D escription of C om plex System s in term s of Self-O rganization P rocesses of P rim e Integer R elations

It is shown that complex systems can be described in terms of self-organization processes of prime integer relations. The prime integer relations are indivisible elements obtained according to a single principle by using the integers as the basic constituents. Prime integer relations characterize correlation structures of complex systems and can be represented as two-dimensional geometric patterns with fractal properties. Controlled by arithmetic only, the self-organization processes of prime integer relations describe complex systems by information not requiring further explanations. This gives the possibility to develop an irreducible theory of complex systems.

C om plex system s profoundly change hum an activities of the day. In order to understand and control the developm ents, it is becom ing increasingly in portant to have con dence in the theory of com plex system s. Ultim ately, this requires clear explanations why the foundations of the theory are valid in the st place. The ideal situation would be to have an irreducible theory of com plex system s as not requiring a deeper explanatory base in principle. But the question arises: where such an irreducible theory m ay com e from at the tim e when even the concept of space-tim e is questioned [1] as a fundam ental entity?

As an answer to the question, it is suggested that the concept of integers could take responsibility in the search for an irreducible theory of complex systems [2]. The aim of the paper is to present a description of complex systems in terms of self-organization processes of prime integer relations. A prime integer relation is an indivisible element in the sense that none of its components can be considered separately to result in an integer relation. Starting with the integers and controlled by arithm etic only, the self-organization processes characterize complex systems by information not requiring further explanations. This gives the possibility to develop an irreducible theory of complex systems.

II. IN VAR IANT QUANT IT IES OF A COM PLEX SYSTEM AND THE UNDERLY ING CORRELATIONS

W e approach com plex system s from a general perspective. In particular, we consider the dynam ics of a com - plex system in order to understand the correlations between the parts. For this purpose we describe a com – plex system by its certain quantities and are interested to know how many of them remain invariant as the system evolves from one state to another [2], [3].

Let I be an integer alphabet and

be the set of sequences of length N 2. We consider a complex system of N elementary parts with the state of part P_i speci ed by a space variable x 2 I; i= 1; ...;N and the state of the complex system itself by a sequence $x = x_1 :::x_N \ 2 \ I_N$.

We use piecewise constant functions for a geometric representation of the sequences. Let "> 0 and > 0 be length scales of a two-dimensional lattice. Let $_{m}$ ":x! f be a mapping that realizes the geometric representation of a sequence x = $x_1 ::: x_N \ 2 \ I_N$ by associating it with a function f 2 W " [t_m ; t_{m+N}], denoted f = $_m$ "(x), such that

and whose integrals f^[k] satisfy f^[k](t_m) = 0; k = 1;2; ..., where m is an integer. The sequence $x = x_1 :::x_N$ is called a code of the function f and denoted c(f).

We use the geometric representation to characterize a state $x = x_1 ::: x_N \ 2 \ I_N$ of a complex system in terms of the de nite integrals

of a function $f = m \cdot (x) 2 W \cdot [t_m ; t_{m+N}] [2]$. The de nite integrals specify certain quantities of the complex system .

The integer code series [4] expresses the quantities (1) of a complex system in terms of the state $x = x_1 ::: x_N \ 2$

moves from one state $x = x_1 ::: x_N \ 2 \ I_N$ to another $x^0 = x_1^0 ::: x_N^0 \ 2 \ I_N$, i the space-time changes $x_i = x_i^0 \ x_i; i = 1; :::; N$ of the elementary parts are correlated to satisfy a system of C (x; x⁰) linear equations [2]

with Vanderm onde determ inant, when the num ber of the equations is N. This fact is important in order to prove that the num ber of the conserved quantities of a complex system actually satis as the condition C (x; x^{0}) < N [2]. The character of the system of linear equations (5)

suggests m any possible associations. For example:

- It is shown that the system of equations (5) may be connected with a smooth projective curve over a nite eld and the number C(x;x) of the conserved quantities with the genus of the curve [2].

The system of equations (5) can be written for $s = 0; 1; ...; C(x;x^0) + 1$ and m = 0 as

We are concerned how many quantities (1) remain invariant as a complex system moves from one state $x = x_1 ::: x_N \ 2 \ I_N$ to another $x^0 = x_1^0 ::: x_N^0 \ 2 \ I_N \ [2]$

where $f = m (x); g = m (x^{0})$ (Figure 1).

We consider the conservation of the quantities (3) as a consequence of the correlations between the parts of the com plex system. In particular, although the com plex system moves from one state to another, however the changes of the parts may be correlated to preserve the quantities. It is viewed that the more of the quantities are conserved the stronger the correlations between the changes of the parts.

III. THE CONSERVING CORRELATIONS AS SPECIFIC LINEAR EQUATIONS

It is proved by using (2) that $C(x;x^0)$ 1 of the quantities of a complex system remain invariant, as it

The analysis of linear equations (5) and inequality (6) can reveal that a complex system is actually described in term sofhierarchical structures of prime integer relations. A proper interpretation of such hierarchical structures identices self-organization processes of prime integer relations [2], [3]. In particular, a consistent picture of the hierarchical structures emerges when it is realized that the self-organization processes, starting with the integers as the elementary building blocks and following a single principle, make the prime integer relations from one level to the next.

W e illustrate the results by considering two states of a com plex system




FIG. 2: One of the hierarchical structures associated with the integer relations (7) and inequality (8). The structure may be interpreted as a result of a self-organization process of prime integer relations. It starts with integers 16;13;11;10;7;6;4;1 generated in the positive state and integers 15;14;12;9;8;5;3;2 generated in the negative state on the zero level. The self-organization process makes the prime integer relations from the rst level to the fourth guided by a single principle. A rithm etic forbids the process from reaching level 5, as the left side of (8) cannot be zero.

noting that calculations in (7) and (8) and their results are completely determined by arithmetic.

There is a number of hierarchical structures of prime integer relations associated with the system of integer relations (7) and integer inequality (8). One of the hierarchical structures is shown in Figure 2. In the structure the relationships between the elements of neighboring levels may be interpreted as a consequence of a selforganization process of prime integer relations. The process starts with integers 16; ...; 1 and proceeds level by level follow ing the same organizing principle:

on each level the powers of the integers in the prime integer relations are increased by 1, so that through emerging interdependencies the prime integer relations could self-organize to form prime integer relations of the next level.

We can see that the formation of prime integer relations is more than their simple sum .

It is useful to give another hierarchical structure to indicate where the variety of the hierarchical structures of prime integer relations connected with (7) and (8) comes from .

The rst level of the structure includes the prime integer relations:

The third level of the structure - the prime integer relations

Let us brie y explain the notion of prime integer relation. A prime integer relation of the rst level is the sum of integers from the zero level (Figure 2). Following the organizing principle a prime integer relation of one level is made from prime integer relations of the previous level. Notably, a prime integer relation is an indivisible element in the sense that none of its components can be considered separately to result in an integer relation. For example, integer relation

is a prime integer relation, because none of its components can separately make a prime integer relation. At the same time integer relation

is not prime, because it consists of two prime integer relations + 7^0 $6^0 = 0$; $5^0 + 3^0 = 0$.

The space-time dynamics x_i of elementary part $P_i; i = 1; ...; N$ has the following interpretation. The absolute value of x_i is the number of integers (m + N i + 1) involved in a self-organization process associated with the linear equations (5) and inequality (6), while sign (x_i) determines the state, i.e., positive or negative, of the integers, provided that $x_i \in 0; i = 1; ...; N$.

The self-organization processes describe complex system s by hierarchical structures of prime integer relations. The prime integer relations are true statements that cannot be further reduced. In particular, there exist no




FIG. 3: A correlation structure of the complex system is built in accordance with the hierarchical structure of prime integer relations (Figure 2). The elementary parts P_{16} ; ...; P_1 are depicted as integers 16; ...; 1 to show the correspondence between the composite parts of the complex system and the prime integer relations. The horizontal edge denotes that the parts of the complex system are correlated through a prime integer relation.

deeper principles to explain why the hierarchical structures exist the way they do and not otherwise. For example, it is not possible to explain further a structure, where prime integer relations

It is shown that the correlation structures underlying the conservation of the quantities (3) and (4) are built in accordance with the hierarchical structures of prime integer relations associated with the linear equations (5)and inequality (6) [2], [5], [6].

For example, the prime integer relation $+4^{0}$ $3^{0} = 0$ (Figure 2) corresponds to

which shows that space-time changes x_4 ; x_3 of the elementary parts P_4 and P_3 are correlated as

and thus the parts m ake a composite part (P_4 \$ P_3).

The correlation through the prime integer relation does not seem to involve a physical signal between the parts P_4 and P_3 . But, if the dynamics x_4 of the elementary part P_4 is specified, then the dynamics x_5 of the elementary part P_3 is instantaneously determined and vice versa. The correlation is nonlocal, because the prime integer relation does not have any reference to the distance between the parts.

Similarly, the prime integer relation $2^0 + 1^0 = 0$ speci es the correlation

In general, the self-organization process of prime integer relations can be associated with the formation of a correlation structure of the complex system (Figures 2 and 3). The formation process starts with the elementary parts P_{16} ; ...; P_1 and combine them into composite parts in order to make larger composite parts and so on until the whole correlation structure is built (Figure 3).

By using the self-organization processes of prime integer relations a concept of complexity is introduced [2] and its applications may be found in [7].

V. GEOMETRIZATION OF THE SELF-ORGANIZATION PROCESSES OF PRIME INTEGER RELATIONS AND THEIR FRACTAL PROPERTIES

In the above considerations it was convenient to think about prime integer relations as objects of formation rather than as objects of calculation. However, integers and integer relations are abstract entities in the stplace and do not give pictures we usually have when physical objects form into each other. Moreover, integer relations are not even familiar as geometric objects suitable for




FIG. 4: A hierarchical structure of prime integer relations and an isom orphic hierarchical structure of geom etric patterns. Under the integration of the function, the geom etric patterns one level form the geom etric patterns of the next level. Due to the isom orphism the self-organization process of prime integer relations can be described geom etrically and quantitatively. For example, we can see that geom etric patterns on di erent levels are self-sim ilar. A prime integer relation can be measured by the area of a corresponding geom etric pattern.

observation and m easurem ent. Therefore, the prime integer relations would be better recognized as objects of form ation, if they could be observed and m easured as geom etric patterns.

Remarkably, by using the integer code series β , it is shown that the prime integer relations can be geom etrized as two-dimensional patterns and the selforganization processes can be described in terms of their transformations [2]. These characterize the selforganization processes of prime integer relations geom etrically and quantitatively. As a result self-organization processes of prime integer relations can be visualized and their properties investigated accordingly.

As an illustration a hierarchical structure of prime integer relations and an isom orphic hierarchical structure of geom etric patterns are presented in Figure 4. In this case we have

n = 8 and m = 3. The isom orphism allows us to see that the self-organization process of prime integer relations has a fractal character and investigate its scaling properties. Im portantly, a prime integer relation can be measured by the area of a corresponding geom etric pattern.

In general, the geom etric patterns of prime integer relations exhibit a variety of numbers with important properties. In particular, the PTM sequence is connected with a self-organization process of prime integer relations progressing well through the hierarchical levels and demonstrating critical point [8], [9] features [2] (Figure 4). This resonates properly with the fact that the PTM sequence gives a symbolic description of chaos resulting from period-doubling [10] in physical system s [11].

A lthough the PTM geom etric patterns at levels N > 1 are bounded by intricate curves, they have, nevertheless, a concise and universal description. For example, the area of a PTM geom etric pattern at level N 1 can be simply speci ed as S = LH = 2, where L and H are the length and height of the geom etric pattern (Figure 4). As a result the PTM geom etric patterns have scale invariant properties dividing the hierarchical levels into sim ilar groups of 3 successive levels.

N am ely, the lengths and heights of the PTM geom etric patterns at levels N = 1;2;3 and N = 4;5;6 are given in term s of " and as

the lengths and heights at levels N = 4;5;6 can be expressed in terms of \mathbf{n}^0 and \mathbf{n}^0 in the same way

as the lengths and heights at levels N = 1;2;3 are given in terms of " and . The situation repeats for levels N = 7;8;9 and so on.

VI. CONCLUSIONS

W e have shown that com plex system s can be described in terms of self-organization processes of prime integer relations. The processes have the integers as the basic building blocks and controlled by arithmetic only make the prime integer relations from one level to the next. In the description of com plex systems prime integer relations demonstrate important properties:

-M ay self-organize into another prime integer relations according to a single principle. A prime integer relation m ay participate in various self-organization processes and as a result be a component of di erent prime integer relations at higher levels;

-D o not stand alone, but through the self-organization processes are all interconnected and inseparable in one hierarchical network. It seems that not a m inor change can be m ade to any element of the network;

-Appear to provide nonlocal and instantaneous correlations between the parts of a complex system ;

-C an be described as two-dimensional geometric patterns and may be quantied in renormalizable numbers;

- Provide a complexity order. The self-organization processes start with di erent integers and as a result progress to di erent levels producing the complexity order. It seems like a self-organization process aims to progress as higher as possible in the direction of the order.

F inally, we have presented self-organization processes of prime integer relations as a new way to describe com – plex systems. The processes characterize com plex systems by information not requiring further explanations. This gives the possibility to develop an irreducible theory of com plex system s.
