Two-State M igration of DNA in a Structured M icrochannel

DNA m igration in topologically structured m icrochannels with periodic cavities is investigated experim entally and with B rownian dynam ics simulations of a simple bead-spring m odel. The results are in very good agreement with one another. In particular, the experimentally observed m igration order of - and T2-DNA m olecules is reproduced by the simulations. The simulation data indicate that the mobility may depend on the chain length in a nonmonotonic way at high electric elds. This is found to be the signature of a nonequilibrium phase transition between two di erent m igration states, a slow one and a fast one, which can also be observed experimentally under appropriate conditions.

I. IN TRODUCTION

DNA electrophoresis is one of the main techniques to separate DNA molecules by size [1]. Since the mobility of DNA molecules does not depend on the chain length in free solution, electrophoresis is usually performed in gels. G iven the progress of m icrotechnology, much e ort has been spent on the integration of DNA electrophoresis into m icro uidic devices (as lab-on-a-chip device) 2] and separation strategies which rely on well-de ned microscopic structures have been explored. Various such gel-free devices exploiting both DC [3, 4, 5, 6, 7, 8] and AC [9, 10] elds have been proposed. The mobility of the DNA in these microstructures is determined by a subtle interplay of the characteristic dimensions of the m icrostructure and the m olecular size. M icrostructured system s allow for fast separation of kbp sized DNA fragments in time scales less than one minute [9, 10, 11].

In the present work, we focus on a geometry which has been investigated by H an and C raighead et al. [6, 12, 13] and later by us (Duong et al. [8]). The DNA is pulled through a periodic sequence of cavities and constrictions (Fig. 1) with an electrical DC eld. The separation experim ents of H an and C raighead m otivated several com puter simulation studies [14, 15, 16], which reproduced the results and lead to an improved understanding of the DNA separation mechanisms in these channels. O riginally [9, 12], the width of the constriction was chosen of the order of 0:1 m (corresponding to a few persistence lengths of DNA molecules), and entropic trapping at the entrances of the constrictions was proposed to be the main mechanism leading to size dependent migration of DNA in these channels. Recently, an additional e ect that relies on di usion has been revealed in such geom etries [16]. This second mechanism does not premise extrem ely narrow constrictions. Therefore, one should also achieve DNA separation with wider channels.

B ased on that prediction, we have investigated experim entally the size-dependent electrophoresis in structured m icrochannels (Fig. 1) with constriction widths corresponding roughly to the radius of gyration of the tested

DNA molecules [8, 11]. Unexpectedly, however, the relation between mobility and chain length turned out to be inverse to that observed by H an and C raighead: the short -DNA (48 kbp) migrated faster than the longer T2-DNA (164 kbp)!

In the present paper, we explore the reasons for this unforessen behavior by Brownian dynam ics simulations of a simple bead-spring model. Models of this kind have been used successfully in the past to study them igration of DNA in various geometries [16, 17, 18, 19, 20]. Our simulations reveal a surprisingly complex phenomenology. If the model parameters are adjusted to those of the experiment, we reproduce the experimental ndings. W ith other model parameters (sm aller structures, low er electric eld), we recover the originally expected increase of mobility with increasing chain length. As we show in this paper, the reversal of this trend turns out to be the signature of a nonequilibrium rst order phase transition, which emerges at even higher elds or in even larger structures. This prediction in plies the existence of two m igration states, which could indeed be observed in m igration experiments.

The paper is organized as follows: the simulation model and the simulation technique are described in Sec.II, and the experimental setup in Sec.III. In Sec.IV, we brie y discuss the simulations corresponding to the earlier experimental study by D uong et al. [8]. The results on the two coexisting m igration states are presented in Sec.V, and the possible transition mechanisms are discussed in Sec.VI. We summarize and conclude in Sec.VII.

II. THE SIMULATION MODEL

A. De nition of the model

We describe the DNA on a coarse-grained level by a bead-spring model. Several base pairs of DNA are represented by one bead or \m onom er". Neighboring beads are connected by harm onic springs

where r is the distance between the two neighboring monomers. All beads interact with a purely repulsive W eeks-Chandler-Andersen (W CA) potential

r is the distance between two monomers and 1 sets the range of the interaction.

The walls are assumed to be soft and purely repulsive. The potential describing the interaction with the walls is the same as that acting between the monomers (Eq. 2, with r as the the minimum distance between a bead and the wall). In the corners, the forces of the adjacent walls are sum med up. To model the nite depth of the device, we also introduce walls in y-direction.

Each bead carries a charge q and is subject to an electrical force $f_{el} = qE' = qr$, but charges do not interact with one another in our model. The eld is calculated by solving the Laplace equation (= 0) in the channel. We use von Neum ann boundary conditions at the walls (n r = 0, with n the surface norm al) and in pose a constant potential di erence between the inlets of the device. A num erical solution (r) is obtained from the software program M at lab" (M athworks, US), using a nite element solver. The grid values of the derivatives are interpolated bilinearly.

The eld lines are shown in Fig1. Throughout the rest of this paper, the eld denoted by E refers to the total potential di erence divided by the total channel length, and can thus be regarded as the characteristic strength of the electric eld.

The motion of the chain is described by Langevin dynamics, i.e. the solvent surrounding the chain is replaced by a Brownian force \sim_i and an elective friction coel cient

where fr_{ig} and fv_{ig} represent the locations and the velocities of the m onom ers, respectively. The vectors ff_{ig} sum up forces acting on a m onom er (harm onic spring, repulsive m onom er interaction, w all interaction, external electric eld). Here, each bead carries a m ass m, but simulations with vanishing m ass were also carried out for com parison (see Sec.VI). W ith m = 0, the equations of m otion reduce to

The natural units of our simulation are dened in terms of the bead size , the friction coecient , the bead charge jrj, and the temperature T.Based on these quantities, the energy unit is $k_{\rm B}T$, the length unit is , the time unit is $t_0 = {}^2=k_{\rm B}T$, and the electric eld unit is $E_0 = k_{\rm B}T = jrj$.

The dynamical equations (Eq. 5 and Eq. 6) are integrated with a Verlet algorithm using a timestep $_{\rm t}$ = 10 2 t₀. In the case of the relaxational dynamics in Eq. 7, we use an Euler algorithm with the time step $_{\rm t}$ = 10 4 t₀. The stochastic noise $\sim_{\rm i}$ was implemented by picking random numbers at every time step. As shown in R ef. 22, the random numbers do not have to be G aussian distributed, as long as they full ll Eq.3 and Eq. 4. Those used in our simulation were evenly distributed inside the unit sphere. Unless stated otherwise, the run lengths were 4 20 10 t with equilibration times of 2 10 t.

The spring constant in Eq.1 was chosen very high, $k = 100k_{B}T = {}^{2}$. This ensures that no chain crossing occurs [23]. The equilibrium length of each bond is 0.847.

The static properties of free chains of length N correspond to those of self-avoiding random walks [23] with the persistence length $l_{p} = 1.6$ and the radius of gyration R_{q} 0.5 N. Here = 0.588 is the F lory exponent. The dynam ical properties are characterized by the di usion constant D = $k_{s} T = N = N^{1/2} = t_{0}$, the mobility $_{0} = jqj = = E_{0}t_{0}$, which is independent of the

chain length N , and the decay time of the drift velocity $_0 = m = (Eq.6)$. The quantity $_0$ sets the time scale on which inertia e ects are signi cant. In most simulations presented here, it was set to $_0 = t_0$ (i.e. $m = t_0$), based on the assumption that the relevant time scales for the dynam ical processes of interest here are much longer. In some cases, how ever, simulations with vanishing $_0$ (vanishing m ass) were also necessary (see Sec. V I). On time scales larger than $_0$, the chains behave like standard (self-avoiding) R ouse chains [21] with the R ouse relaxation time $_{\rm R}$ 0:045 t_0 N¹⁺².

B. Correspondence between the model and the experiment

In the experiments, the mobility of -DNA (48 kbp) and T2-DNA (164 kbp) in microchannelswith geometries such as sketched in Fig.1 was studied. Details are given in Ref. 8 and Sec. III. We will now discuss how the parameters and units of our model can be related to those of the experiment.

The energy unit is simply given by the tem perature, $k_{\scriptscriptstyle B} T = 300 k_{\scriptscriptstyle B} K$ 0:026eV, at which the experiments were carried out. Next we adjust the value of the length unit. In our earlier work on entropic traps [16], we had m atched the persistence lengths of the m odel chains with that of DNA. In the present case, however, the persistence length is not an experim entally relevant length scale, because all dim ensions of the microchannels are on the order of m agnitude of the radius of gyration. Thus we can determ ine the length unit by com paring the characteristic length H in our model channel (see Fig. 1) to the corresponding experim entalvalue. Note that this in plies that we can relate simulations with one channel geometry to all three experim ental channels by scaling our results accordingly.

M ore speci cally, the simulations were carried out using channels with H = 60 . We illustrate our adaptation with the example of the 5 m m icrochannels. It is carried out in four steps. First, we compare the channel height H = 5 m60 . This gives the length unit 1 83nm . Second, comparing the radii of gyration of our model chains with that of -DNA, we nd that -DNA is represented by chains of N = 140 beads, or 1 bead 340 bp. Third, the time unit is adjusted by matching the di usion constant D for -DNA. Experim entally, Sm ith et.al.have reported D = 0.47 0.03 m²=sec [24]. Com paring this with the theoretical value, $D = {}^{2}= N t_{0}$, we obtain t_0 1:1 10⁴ s. Hence, one second corresponds to 9:5 $10t_0$ (or 10^6 time steps). Finally, the electric eld unit E_0 is adjusted by adjusting the mobility in large unstructured m icrochannels, which is chain length independent and given by $_0 = 1.84 \quad 10^4 \text{ cm}^2 = \text{V s } [8]$. It is the sum of the free ow mobility $_0$ and the electroosm otic mobility $_{eof} = (2:9 \quad 0:6) \quad 10^4 \text{ cm}^2 = \text{Vs in our channels}$ (see below). This leads to to 1V/cm2:3 $10^{3} E_{0}$. These values as well as those obtained for channels with

H = 3 m and H = 1.5 m are summarized in table I. Unless stated otherwise, all adaptations given in this paper refer to the 5 m channels, except in Sec. IV.

We set the depth of the device to 60 . For comparison, we also performed simulations with in nite depth of the device and found no qualitative di erence (data not shown). In our case, the depth has no signi cant in uence on the dynamics.

The model disregards a number of important physical e ects.

F irst, electrostatic interactions are neglected. The D ebye screening length of DNA in typical buer solutions is about 2nm, which is comparable to the diameter of the polymer and much smaller than the persistence length of DNA (roughly 50nm).

Second, PDMS exhibits silanol groups on its surface which dissociate under the experim ental conditions. Thus the experim ents were carried out in m icrochannels with negatively charged surfaces. This implies the generation of cathodic electroosm otic ow, and the resulting m obility of DNA m olecules is a sum of the electroosm otic and electrophoretic m obilities. The DNA m olecules m igrate to the anode, indicating that electrophoresis overcom eselectroosm osis. In the simulation, we do not incorporate any electroosm otic ow, or ow in general. However, recent reports [25, 26] show that for su ciently low R eynolds number, the ow outside the D ebye layer at the walls is rotation free and proportional to the electric

eld with a xed proportionality constant . Let $\psi(\mathbf{r})$ denote the ow eld at a given position \mathbf{r} and $\mathbf{f}_{\circ,i}$ the forces acting on m onom er i, excluding the electric force $\mathbf{f}_{el,i} = \mathbf{q} + \mathbf{r}$ (\mathbf{r}). Using \mathbf{v}_0 (\mathbf{r}) = \mathbf{r} (\mathbf{r}), the equation of m otion (Eq. 6) now becomes

and for the overdam ped dynam ics (Eq. 7) one nds

These equations are formally equivalent to Eq. 6 and Eq. 7 with a rescaled charge q. The Reynolds number for the electroosmotic ow is can be easily found for our

device. U sing the viscosity of water, the electroosm otic m obility given above and a characteristic length of 5 m, the Reynolds number is roughly 10 3 for electric elds of 100 V/cm in our channels. This justi es our adaptation to the overall m obility given above.

Third, hydrodynamic e ects are not taken into account. This approximation must be questioned. On the one hand, DNA is always surrounded by counter ions, which are dragged into the opposite direction of the DNA. Thus the DNA molecule experiences not only hydrodynam ic drag, but also an extra friction from the solvent molecules. In free solution, these two e ects cancel each other [1]. This \hydrodynam ic screening" accounts for the free-draining property of DNA. However, the total cancellation fails if the DNA molecule is blocked by a geometric barrier [27]. In that case, the counter ions will not be imm obilized, since counterions are still free to move. Furthermore, hydrodynam ic interactions a ect the di usion constant D. In our model, it scales the chain length N like a Rouse chain (D / 1=N). Including hydrodynam ic interactions, one would expect Z im m scaling (D / $1=R_q$ / 1=N). In experiments, the diusion constant of DNA is found to scale as D / $1=N^{0.672}$ [28].

Unfortunately, a full simulation which treats hydrodynamic interactions correctly, takes into account the dynamical counter ion distribution, and includes electrostatic interactions, is a form idable task and impossible with standard computer resources. The simpli cations described above will a lect the quantitative results, but presumably neither by orders of magnitude nor qualitatively.

III. EXPERIMENTAL SETUP

The fabrication method used for the structured microchannels is based on soft lithography of poly (dim ethylsiloxane) (PDMS) and is described in detail in Ref. 8. Brie y, a photoresist (SU-8 from Microresist, GER) coated Siwafer (CrysTec, GER) is exposed through a chromium mask (DeltaMask, NL). A fter developing and hard-baking liquid PDMS (Sylgard 184, Dow Coming, USA) is poured onto the master containing the inverted microstructure and baked for 3 h at 75 C. Peeling o the PDMS slab, punching reservoir holes through the PDMS and covering it with a clean m icroscope glass slide results in the m icrochip. Fig. 2b shows a scanning electron micrograph (SEM) image of the topyiew of a microchannel with H = 5 m. In comparison to the simulated geometry, the corners of the cavities are rounded and the lengths a, b, c, and d in Fig. 1 are not exactly equal. The exact values were a= 3:6 m, b= 6:0 m, c= 3:7 m and d= 4:7 m. The depth of the microchannel was 2:8 m. Other channel geom etries m entioned in this work are described in detail. in Ref. 8.

For uorescence in aging, 6pM - or T2-DNA (Fluka, Germany) in the same bu er (10mM Tris at pH 8:3 containing 50mM NaCl, 1mM ethylenediam inetetraacetic acid (EDTA) and 2% (v/v) -M ercaptoethanol) were adjusted to a YOYO-1 (M olecular Probes, USA) in a basepair ratio of 1:75. A sensitive uorescence videom icroscopy setup is used to record DNA m igration, as described in Ref. 8. Brie y, it consists of an inverted m icroscope (Axivert 100, Zeiss, GER) with a lterset for uorescence observation (XF100-3, Om ega, USA), a 100x oil immersion objective (Plan Neo uar NA 13, Zeiss, GER) and a sensitive CCD-cam era (Im ager 3LS, LaV ision, GER). D ata acquisition and autom ated data analysis is performed in DaV is 5.4.4 (LaV ision) using cross-correlation analysis. Electric elds are applied with power supplies from FUG (M CN 14-2000, GER).

The electroosm oticm obility was determ ined according to the current monitoring method [29]. Linear channels of 20 m width and depth were lled with water immediately after assembly, which was exchanged by the 10mM sample bu erwithout DNA before the experiment. The bu er in the anode reservoir was then exchanged by 8mM Tris bu er with otherwise identical composition as the 10mM bu er. A constant electric eld of 400 V/cm was applied and the current was recorded until a stable low er current value was reached. The recorded current decay times eor were used to calculate the electroosm otic mobility according to: $eor = \frac{1}{E} eor$, with 1 the length of the channel, and E the applied electric eld.

IV. LOW ELECTRIC FIELD:STEADY-STATE M IGRATION

We begin by presenting simulations for relatively low electric elds E, which can be compared to the previously published experim ental results of D uong et al. [3]. In this section, we will adjust our model units to the channels with characteristic size H = 3 m (cf. Sec. IIB), where D uong et al. had found particular clear evidence of a size-dependent mobility.

The electric eld was varied from $E = 0.0025E_0$ up to $E = 0.04E_0$, which corresponds to experimental elds in the range of 4:2V/cm up to 67V/cm. The chain lengths range from N = 10 up to N = 2000 m onom ers, m odeling DNA strands from 1.5 kbp up to 290 kbp. Fig. 2 shows typical trajectories obtained at $E = 0.005E_0$. The trajectories are similar to those obtained for the entropic trap geometry [16]. For N = 10, the trajectory is completely dom insted by di usion. Long chains with N = 1000m onom ers are hardly a ected by the constrictions { much less, in fact, than in the case of the entropic traps [16]. This is because the width of the narrow regions is of the order of the radius of gyration; the chain is thus able to cross the constriction without uncoiling. The trapping mechanism suggested by Han et al. [6] should not apply here. The fact that som e trapping nevertheless occurs for short chains underlines the importance of the e ect reported by Streek et al.[16]. Indeed, Fig. 3 shows that the mobility increases as a function of the chain length for

 $E = 0.005E_0$. In the experimental channel, $E = 0.005E_0$ corresponds to a real eld of E = 8.4V/cm. In such low elds, Duong et al. §] were unable to distinguish between dierent mobilities for dierent DNA sizes; the statistical error is large because di usive motion becomes signi cant. We note that in simulations, we can track the DNA migration over many more cavities than in the experiments, therefore the relative error is smaller.

At higher elds, Duong et al. [3] reported the inverse e ect { the mobility of T2-DNA is smaller than that of -DNA. If we increase the electric eld in the simulations accordingly, we nd indeed that, at $E = 0.04E_0$ the mobility reaches a maximum at N = 200 beads (29 kbp) and decreases for longer chains (Fig. 3). In the param eter region corresponding to -DNA and T2-DNA, smaller chains migrate faster than longer ones, but the di erence in the mobility is not as pronounced as in experiment. Thus our simulations reproduce the behavior observed by Duong et al. [3] qualitatively.

This result is gratifying, but it does not yet explain why the chain length dependence of the mobility is suddenly reversed. In order to explore this question, we proceeded to investigate the migration in our structures under more extrem e conditions. In the simulations, we can increase the eld strength E. In the experiments, this can only be realized up to a eld of approximately 100V /cm, where the cross correlation analysis [8] fails. However, table I shows that we can alternatively work

with larger structures. Therefore, we have fabricated and studied m icrostructures with H = 5 m, and the results will be presented in the next section.

V. HIGH ELECTRIC FIELD: TW O M IGRATION STATES

We begin by discussing the simulation results. We started with studying the extrem e case $E = E_0$. This corresponds to 430 V/cm in a 5 m structure and is thus not accessible in experiments. Two sample trajectories for a chain of length N = 10 (3.4 kbp) and N = 400 (140) kbp) m onom ers are given in Fig. 4. As can be seen from the insets in the N = 10 case, the chains retain some m em ory of their state in the previous cavity. If a chain passes a constriction without being trapped, it will avoid trapping at the next barrier as well. A similar e ect had already been observed in the entropic traps [16]. As in the simulations discussed in the previous section, chains m ay still get trapped in the corners of cavities, but at a low er rate due to the reduced di usion time inside a single cavity. For N = 400, the m igration is periodically fast and slow, indicating that the polym erpenetrates the low

eld regions in the cavities. O ver long simulation times, both the trajectories for N = 10 and N = 400 are quite regular.

The situation is qualitatively di erent for N = 200 (70 kbp). The trajectory is smooth on short time scales, but occasionally, the speed of migration changes abruptly (Fig. 5). One observes two states of migration, one of which is fast and the other is slow. The lower panel of Fig. 5 shows that the two states are associated with two distinctly di erent z-positions of the center of mass:

the polymerm igrates faster when it stays in the hom ogeneous eld in the upper part of the channel. From Fig.5, both states are long-lived during the simulation. Their life time can be made arbitrary long by using large channels (cf. Table I). We conclude that our microchannel system exhibits a nonequilibrium rst order phase transition between two di erent migration states. We nd

coexistence regions of the two states (Fig.5 and 8). The nonmonotonic chain length dependence of the mobility at E = $0.04E_0$ is a consequence of that transition.

The experimental studies of -DNA and T2-DNA migrating in large structures support our sinulation results. In structures characterized by H 5 m, at electric elds ranging up to 100 V/cm, both - and T2-DNA exhibit two distinct states of migration, which are illustrated in Fig. 6a. In one state, the chain remains coiled all the time in the upper (hom ogeneous) part of the eld, and travels at high speed. In the other, it penetrates deep into each cavity, form s a coil inside, and gets stretched again when moving into the narrow region.

Fig. 7 shows monomer density histograms obtained from experiment and simulation. In both the experiments and in the simulations with chains of length N = 120 250 beads, we observe a low-density depletion zone between the upper and the low erpart of the channel. Furtherm ore, Fig. 7a shows that short chains are more likely to migrate in the fast state and long chains arem ore likely to migrate in the slow state. For N = 120 250, the polymer migrates alternatingly in the slow and fast

state, as has already been seen from the trajectory of N = 200 in Fig.5.

Density histogram s such as those shown in Fig. 7a allow to determ ine the population density of the two states. We choose the z-position of the center of mass as an indicator of a polymer's state (cf. also Fig. 5). Since the transition does not take place instantaneously (Fig. 9), we de ne two thresholds separated by a gap: a chain is taken to be in the slow state or in the fast state, if z 8 or z 20 over at least 5 10 time steps. A fler having assigned a state to large portions of the trajectory, we can determ ine the mobility in the slow and the fast state separately.

Fig. 8a shows the results for $E = E_0$ and compares it with the overall mobility. The assignment of states works well for intermediate and long chains. For N = 100 (34 kbp), the polymer migrates almost completely in the fast state and for polymers with N 320 (110 kbp), the polymer occupies the slow state only. Short chains di use very strongly in the z direction, no depletion zone occurs, and they often cross from the lower to the upper part of the channel. Therefore, the assignment criterion often fails, and only a few short fragments of the trajectory contribute to the calculation of the mobility in the fast state. This explains why the result does not coincide with the totalm obility at low N.

The transition was not only observed at $E = E_0$, but also observed at smaller elds E. Fig.8b and Fig.8c gives the mobilities and the population densities for $E = 0.25 E_0$ (110V/cm) and $E = 0.04 E_0$ (17V/cm), as determined by the above criterium. At $E = 0.25 E_0$, the transition is not as pronounced as for $E = E_0$, but still present. At $E = 0.04 E_0$, the transition has alm ost disappeared, and only a slight decrease in the overall mobility remains. This con rm s our earlier assertion that the nonmonotonic chain length dependence of the mobility at $E = 0.04 E_0$ is a signature of the phase transition. It also clari esw hy long chains (T 2-D NA) m igrate slower than shorter chains (-D NA) in our channels. They tend to penetrate deeper into the low eld regions, which slow s them down signi cantly.

The quantitative com parison between simulations and experiments raises a question. According to the simulations, coexistence of two states should be observed at chain lengths below N = 250 beads, which corresponds to 64 kbp in 5 m m icrochannels. Thus we would expect twomobilities for -DNA, but only one for T2-DNA.Experim entally, we nd that T 2-D NA exhibits two states of m igration as well. This is in contrast to the prediction of our simulation. However, a closer inspection reveals that even chains of N = 500 beads (170 kbp, roughly T2-DNA) remain in a fast state for a long time (up to 10 time steps, data not shown), if they are prepared 8 accordingly. These initial fast states turned out to be so stable, that we were unable to analyze their life time in detail. The experim ental situation hardly corresponds to an \equilibrated" late-time lim it. It is conceivable that after being introduced into the micro uidic channel, a sizable fraction of m olecules happens to be prepared in a state that is very weakly populated in the long-time average.

VI. M IG RATION STATE TRANSITION M ECHAN ISM S

To understand the transition and identify the factors which stabilize the twom igration states, we have investigated the transition processes between the two states in more detail.

A. Transition from the fast to the slow state

We begin with discussing the transition from the fast to the slow state. A series of snapshots of a chain with N = 500 beads in the process of crossing from the fast to the slow state is shown in Fig. 9. The chain travels through roughly 35 cavities during the transition process, which we can divide into ve stages:

- 1. At the beginning, the polymer is in a coiled conformation in the homogeneous eld region. The radius of gyration of a chain of N = 500 beads in free solution is R_g 18. The size of the hom ogeneous eld region is limited, thus larger polymers are deformed (Fig. 9a).
- 2. At some stage, one polymer loop or end happens to penetrate into a region with a lower eld. As that

polym er part experiences a low er pulling force, it slows down, while the force acting on the rest of the polym er is unchanged. This leads to uncoiling and stretching of the polym er.

- 3. M ore and m ore m onom ers are slowed down. Since the eld in the hom ogeneous part pulls horizontally in x-direction, and the delayed m onom ers are located in the cavities at low z values, the total force acting on the chain has a net down ward com ponent (Fig. 9 b). A fler a while, the polym er is com pletely stretched (Fig. 9 c).
- 4. For the highly stretched chain, (Fig. 9 c), the probability that the forem ost m onom er gets trapped in a cavity is very high. Im m ediately afterwards, the polym er collapses in that cavity. (Fig. 9 d).
- 5. At the end, the polymerm igrates in the slow state. For long polymers, the probability to leave the slow state is very low (Fig. 9 d).
- B. Transition from the slow to the fast state

Unfortunately, the conguration snapshots of the transition from the slow to the fast state cannot be interpreted as easily as those in Fig. 9, and we have not yet been able to distil the mechanisms which stabilize the fast state in a satisfactory way.

One e ect which presum ably favors the transtion is the inertia of the molecule at the corners of the constriction. M onom ers m igrating up at high speed against the wall continue to drift upwards slightly as they enter the constriction (data not shown). This e ect involves dynamical processes on time scales smaller than o, the characteristic decay time for the drift velocity of the polymer. In our model, $_0$ is given by $_0 = m = ,$ which corresponds to approximately 10 4 s for beads of massm = to.ForDNA in free solution, the drift velocity decay time is $[30]_0$ 10⁹ :::10¹² s, which is much smaller. Thus this particular drift e ect is an artifact of the simulation model. To verify that this mechanism is not responsible for the transition observed in the simulations, we modi ed the model by changing its dynam ics to that of an overdam ped system [31] (Eq. (7)). We could only simulate short chains, and were unable to perform a thorough analysis due to the reduced time step (Eq.7). The transition still occurs in both directions (data not shown). This proves that the fast state is stabilized by anotherm echanism. In fact, the only noticeable e ect of inertia was to suppress the transition for short chains.

A nother conceivablem echanism which m ight favor and stabilize the fast phase is based on di usion. W hile the polymerm igrates along the wall in the narrow region and around the corners, it can only di use upwards. This effect is enhanced by the tendency of the polymer, which has been forced into a stretched conformation in the inhom ogeneous parts of the eld, to contract back to a coil.

The characteristic time scale for contraction is presum – ably related to the Rouse time and scales like N $^{1+2}$ [21], which would explain why the slow state dominates at large chain length. We have not yet been able to support this explanation quantitatively.

The understanding of the fast phase remains an open problem. Systematic studies are di cult, because the opposite transition is triggered by di usion as well.

C. Critical chain length

Fig. 9 suggests that the transition can only take place if the electric eld exceeds a critical value; the inhom ogeneous eld has to uncoil the chain and thus work against the entropic spring force of the polym ers. The m ean elongation hri of stretched self-avoiding polym ers subject to a force f, which pulls on the end m onom ers, is [32]

for weakly stretched chains, where a 0:5 is the proportionality constant in $R_g = aN$. In our case, the force of course acts on all m onom ers. Nevertheless, we shall use Eq.10 and Eq.11 to roughly estimate the maximale ect of the inhom ogeneous eld on a chain, with f / E.

The question is: how much does the eld have to stretch a chain in order to stabilize a distinct slow state? Let us consider the critical chain length N_C at which both states are equally populated. A ssum ing that it is su - cient to stretch the chains by an am ount proportional to their own size, one would expect N E ⁵⁼³ to be a constant at N = N_o (according to both Eq. 10 and Eq. 11). A I-ternatively, it m ight be necessary to stretch the chain to a xed length, which is determined by the size of the device, in particular the constriction length H (see Fig. 1b). In that case, according to Eq. 10, N E ²⁼³ should be constant. This is tested in table II. The quantity N_o $E^{5=3}$ is obviously not constant for di erent electric elds E. However, N_o $E^{2=3}$ is alm ost constant for E 0:50E₀.

For larger values of E this rule breaks dow n. This might be related to the inertia e ects discussed in Sec.VIB. Simulations with overdam ped dynamics at $E = E_0$ indeed suggest that, as m ! 0, chains as small as N = 50 already exhibit two distinct m igration speeds (data not shown). This would yield N_cE²⁼³ = $50E_0^{2=3}$, which is consistent with results at lower elds. Unfortunately, the statistical quality of our data is not su cient to determ ine N_c rigorously in the overdam ped case.

N evertheless, the sum of our ndings suggests that the critical length is determined by the geometry of the device rather than by the size of the chain. This could explain why the transition disappears at small elds: for $E = 0.04E_0$, the predicted critical length is N_c 500, but free chains of that length have an end-to-end distance of 46, which is comparable to the channel height H. Hence a fast state, in which the chain is essentially unperturbed, cannot exist.

This result suggests strategies for the design of microstructures which do or do not exhibit the two-state behavior; we expect it can be suppressed by choosing the construction length d in Fig. 2b sm all, and it can be prom oted by making d larger.

VII. CONCLUSION

We have presented Brownian dynamics simulations and experimental studies of DNA migration in structured microchannels. Our simulations reproduce earlier experimental results presented by D uong et al. [8] and, in particular, explain the experimentally observed migration order of and T2-DNA in migration studies and separation experiments [8]: in channels with geometries as shown in Fig. 1, and for moderate eld values, the shorter -DNA molecules migrate faster than longer T2-DNA molecules.

This behavior, which is opposite to that expected at weaker elds, is a signature of a high-eld nonequilibrium phase transition. At very high elds (or in much larger structures), we found that chains can migrate with two distinctly di erent speeds, assuming different states of migration. This was observed both experimentally and in simulations. We have discussed the factors which stabilize the two states and can thus propose strategies for the design of channels which do or do not exhibit the transition, and which could be suitable for separation experiments.

The comparison of simulations and experiments demonstrates that our simple DNA model, which disregards electrostatic interactions, hydrodynamic interactions, and irrotational uid ow, nevertheless captures the essential physics of DNA m igration in our m icrochannels. However, the interplay of DNA motion and bu er ow is non-trivial and may be neglected for irrotational EOF outside D ebye layers only. A smentioned in Sec. IIB, the experimental electroosmotic mobility in straight channels is of the same order of magnitude as the DNA mobility. In structured m icrochannels, where DNA molecules migrate at either high elds or along the D ebye layer, electroosmosis should give rise to interesting nontrivial ow patterns which certainly in uence the DNA m igration. M oreover, the electrostatic and the hydrodynam ic interactions are not entirely screened in m icrochannels, which leads to additional e ects 27]. In order to investigate such phenom ena, system atic experi-

m ental studies are necessary, and e cient new simulation m ethods need to be developed. These shall be explored in the future.

From a practical point of view, our results have two im portant im plications:

On the one hand, they demonstrate that the physics of DNA electrophoresis in m icrochannels is surprisingly complex. W hen designing new m icro uidic devices, one m ust be aware of the possibility of nonm onotonic or even bistable behavior, and a thorough theoretical analysis is advisable.

On the other hand, the observed two-state behavior can presum ably be exploited. Our notings indicate that the migration velocities of the DNA fragments dierby a large factor (almost 2 in Fig. 8) for $N > N_{\circ}$ and $N < N_{\circ}$. Since the chain length corresponding to N_{\circ} depends on the channel geometry (cf. Table I), a device with a gradient in the constriction size could in principle sequentially separate molecules very e ciently. How ever, as the switching time between the two states is very long, methods need to be developed to accelerate the transition. We are currently exploring corresponding strategies experimentally as well as theoretically.
