On simple modules for the restricted Lie superalgebra gl(m|n)

Abstract

In this paper, we study the simple modules for the restricted Lie superalgebra gl(m|n). A condition for the simplicity of the induced modules is given, and an analogue of Kac-Weisfeiler theorem is proved.

1 Introduction

The notion Lie superalgebras was defined by Kac in [6]. It is a generalization of Lie algebras. Let \mathbf{F} be an algebraically closed field with char $\mathbf{F} = p > 0$. Lie superalgebras over \mathbf{F} were studied in [9] and [10]. Also the notion of restricted Lie superalgebras was given.

Let $\mathfrak{g} = \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_{\bar{1}}$ be a restricted Lie superalgebra over **F**. Then the p-characters were introduced for the \mathfrak{g} -modules in [16]. It is simply a linear function on the even part $\mathfrak{g}_{\bar{0}}$. Each simple \mathfrak{g} -module has a p-character $\chi([16])$.

The present paper is addressing the following questions:

1. What is the possible maximal dimension of each simple $u(\mathfrak{g}, \chi)$ -module?

2. How is a simple $u(\mathfrak{g}, \chi)$ -module related to its simple $u(\mathfrak{g}_{\bar{0}}, \chi)$ -submodules?

3. In studying a simple $u(\mathfrak{g}, \chi)$ -module, can its p-character χ , as in the case of classical Lie algebras, be reduced to a nilpotent one?

The paper is organized as follows: Section 2 gives the preliminaries. In Section 3, we work on Question 1 and study the condition for the simple $u(\mathfrak{g}, \chi)$ -module to attain the maximal possible dimension. Section 4 deals with Question 2. We

study the simple modules for gl(m|n) and determine the condition for the graded baby verma module to be simple.

In Section 5 we work on Questions 3. We have proved a version of the Kac-Weisfeiler Theorem for $\mathfrak{g} = gl(m|n)$: Each simple $u(\mathfrak{g}, \chi)$ -module is induced by a simple $u(\mathfrak{l}, \chi) - submodule$, where $\chi_{|\mathfrak{l}}$ is nilpotent. Then we discuss the properties of $Z^{\chi}(\lambda)$ when χ is in the standard Levi form.

After the first submission of the present paper, I received from Weiqiang Wang their independent work on modular representations of Lie superalgebras: *Representations of Lie superalgebras in prime characteristic I.* I would like to thank him for the comments.

2 Preliminaries

2.1 Basic definitions

Let **F** be an algebraically closed field with char $\mathbf{F} = p > 0$. Assume $\mathbf{Z}_2 = \mathbf{Z}/2\mathbf{Z} = \{\overline{0},\overline{1}\}$. Let $V = V_{\overline{0}} \oplus V_{\overline{1}}$ be a \mathbf{Z}_2 -graded vector space over **F**. We denote by $p(a) = \theta$ the parity of a homogeneous element $a \in V_{\theta}, \theta \in \mathbf{Z}_2$. We assume throughout that the symbol p(x) implies that x is \mathbf{Z}_2 -homogeneous.

A superalgebra is a \mathbb{Z}_2 -graded vector space $\mathcal{A} = \mathcal{A}_{\overline{0}} \oplus \mathcal{A}_{\overline{1}}$ endowed with an algebra structure such that $\mathcal{A}_{\theta}\mathcal{A}_{\mu} \subset \mathcal{A}_{\theta+\mu}$ for all $\theta, \mu \in \mathbb{Z}_2$. A superalgebra $\mathfrak{g} = \mathfrak{g}_{\overline{0}} \oplus \mathfrak{g}_{\overline{1}}$ over \mathbf{F} is called a Lie superalgebra provided that

- (i) $[a,b] = -(-1)^{p(a)p(b)}[b,a],$
- (ii) $[a, [b, c]] = [[a, b], c] + (-1)^{p(a)p(b)}[b, [a, c]],$

for $a, b \in \mathfrak{g}_{\overline{0}} \cup \mathfrak{g}_{\overline{1}}, c \in \mathfrak{g}$.

Let $\mathfrak{g} = \mathfrak{g}_{\overline{0}} \oplus \mathfrak{g}_{\overline{1}}$ be a Lie superalgebra. Then the even part $\mathfrak{g}_{\overline{0}}$ is a Lie algebra and the odd part $\mathfrak{g}_{\overline{1}}$ is a $\mathfrak{g}_{\overline{0}}$ -module under the adjoint action. Note that in the case char $\mathbf{F} = 2$, a Lie superalgebra is a \mathbf{Z}_2 -graded Lie algebra. Thus one usually adopts the convention that char $\mathbf{F} = p > 2$ in the modular case.

Let $V = V_{\overline{0}} \oplus V_{\overline{1}}$ be a \mathbb{Z}_2 -graded vector space, dim $V_{\overline{0}} = m$, dim $V_{\overline{1}} = n$. The algebra $\operatorname{End}_{\mathbf{F}}(V)$ becomes an associative superalgebra if one defines

$$\operatorname{End}_{\mathbf{F}}(V)_{\theta} := \{ A \in \operatorname{End}_{\mathbf{F}}(V) \mid A(V_{\mu}) \subset V_{\theta+\mu}, \mu \in \mathbf{Z}_2 \}$$

for $\theta \in \mathbb{Z}_2$. On the vector superspace $\operatorname{End}_{\mathbf{F}}(V) = \operatorname{End}_{\mathbf{F}}(V)_{\overline{0}} \oplus \operatorname{End}_{\mathbf{F}}(V)_{\overline{1}}$, we define a new multiplication [,] by

$$[A, B] := AB - (-1)^{\operatorname{p}(A)\operatorname{p}(B)}BA \quad \text{for} \ A, B \in \operatorname{End}_{\mathbf{F}}(V).$$

This superalgebra endowed with the new multiplication is a Lie superalgebra, denoted by

$$gl(V) = gl_{\overline{0}}(V) \oplus gl_{\overline{1}}(V)$$
or $gl(m|n) = gl_{\overline{0}}(m|n) \oplus gl_{\overline{1}}(m|n)$

For

$$A = \begin{pmatrix} \alpha & \beta \\ \gamma & \delta \end{pmatrix} \in gl(m|n)$$

define the supertrace:

$$\operatorname{str}(A) = \operatorname{tr}(\alpha) - \operatorname{tr}(\delta).$$

Then

$$sl(m|n) := \{A \in gl(m|n) \mid \operatorname{str}(A) = 0\}$$

is an ideal in gl(m|n) of codimension 1. One can find further information on Lie superalgebras in [6, 7, 12].

A Lie superalgebra $\mathfrak{g} = \mathfrak{g}_{\overline{0}} \oplus \mathfrak{g}_{\overline{1}}$ is called restricted if $\mathfrak{g}_{\overline{0}}$ is a restricted Lie algebra and if $\mathfrak{g}_{\overline{1}}$ is a restricted $\mathfrak{g}_{\overline{0}}$ -module (see [9, 10]). Let $\mathfrak{g} = \mathfrak{g}_{\overline{0}} \oplus \mathfrak{g}_{\overline{1}}$ be a restricted Lie superalgebra. The *p*-mapping $[p] : \mathfrak{g}_{\overline{0}} \to \mathfrak{g}_{\overline{0}}$ is also called the *p*-mapping of the Lie superalgebra \mathfrak{g} . Note that gl(m|n) is restricted with the usual *p*-mapping (*p*-th power taken in $\operatorname{End}(V)$).

2.2 General properties

Let $\mathfrak{g} = \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_{\bar{1}}$ be a Lie superalgebra and $V = V_{\bar{0}} \oplus V_{\bar{1}}$ a \mathbb{Z}_2 -graded vector space. If there is an even homomorphism ρ from \mathfrak{g} to gl(V)(by "even" we mean that $\rho(\mathfrak{g}_{\bar{i}}) \subseteq gl(V)_{\bar{i}}, \bar{i} \in \mathbb{Z}_2$), then we call V a \mathfrak{g} -module. A \mathfrak{g} -module is called simple if it does not have any proper \mathbb{Z}_2 -graded submodules.

Lemma 2.1. [16] (1) Let \mathfrak{g} be a restricted Lie superalgebra and M a simple \mathfrak{g} -module. Then there is a unique $\chi \in \mathfrak{g}_{\overline{0}}^*$ such that $(x^p - x^{[p]} - \chi(x)^p \cdot 1)M = 0$ for all $x \in \mathfrak{g}_{\overline{0}}$.

(2) Let I be a finite dimensional \mathbb{Z}_2 -graded ideal of a Lie superalgebra \mathfrak{g} and M a simple \mathfrak{g} -module. If $\rho(x)$ is nilpotent for all $x \in I$, then IM = 0.

Let \mathfrak{g} be a restricted Lie sueralgebra and $U(\mathfrak{g})$ its universal enveloping algebra. For each $\chi \in \mathfrak{g}_{\overline{0}}^*$, define the χ -reduced enveloping algebra of \mathfrak{g} by $u(\mathfrak{g}, \chi) = U(\mathfrak{g})/I_{\chi}$, where I_{χ} is the \mathbb{Z}_2 -graded two sided ideal of $U(\mathfrak{g})$ generated by elements $\{x^p - x^{[p]} - \chi(x)^p 1 | x \in \mathfrak{g}_{\overline{0}}\}$. When $\chi = 0$, $u(\mathfrak{g}, 0)$ is called the restricted universal enveloping algebra of \mathfrak{g} and simply denoted by $u(\mathfrak{g})$.

Let $(\mathfrak{g}, [p])$ be a restricted Lie superalgebra. Suppose that u_1, \ldots, u_m and v_1, \ldots, v_n are ordered bases of $\mathfrak{g}_{\overline{0}}$ and $\mathfrak{g}_{\overline{1}}$ respectively. Applying a similar arguments as that for the modular Lie algebra case, we have that $u(\mathfrak{g}, \chi)$ has the following PBW-basis:

$$\{v_1^{b(1)}\cdots v_n^{b(n)}u_1^{a(1)}\cdots u_m^{a(m)}\mid 0\leq a(i)\leq p-1; b(j)=0 \text{ or } 1\}.$$

A \mathfrak{g} -module M is called having p-character $\chi \in \mathfrak{g}_{\overline{0}}^*$ provided that

$$x^p \cdot m - x^{[p]} \cdot m = \chi(x)^p \ m$$
 for all $x \in \mathfrak{g}_{\overline{0}}, \ m \in M$.

Clearly, $u(\mathfrak{g}, \chi)$ -modules may be identified with \mathfrak{g} -modules having character χ .

Let $\Phi = \Phi^+ \cup \Phi^-$ be the root system of \mathfrak{g} . We also write $\Phi = \Phi_0 \cup \Phi_1$, where Φ_0 and Φ_1 are the set of even and odd roots respectively([6]). We denote

$$\mathfrak{N}^+ = \bigoplus_{\alpha \in \Phi^+} \mathfrak{g}_{\alpha}, \mathfrak{N}^- = \bigoplus_{\alpha \in \Phi^+} \mathfrak{g}_{-\alpha} \quad \text{and} \quad \mathfrak{B} = H + \mathfrak{N}^+.$$

As a subalgebra, \mathfrak{g} inherits a natural *p*-mapping from gl(m|n). We denote

 $\operatorname{Aut}(\mathfrak{g}) = \{\theta | \theta \text{ is an even automorphism of } \mathfrak{g}, \theta(\mathbf{x}^{[\mathbf{p}]}) = \theta(\mathbf{x})^{[\mathbf{p}]} \text{ for any } \mathbf{x} \in \mathfrak{g}_{\bar{0}} \}.$

Let \mathfrak{g} be one of the following classical Lie superalgebras [6, Prop. 2.1.2]:

$$\begin{pmatrix} \mathfrak{g} & gl(m|n) & B(m|n) & C_n \\ \mathfrak{g}_{\bar{0}} & gl(m) \oplus gl(n) & B_m \oplus C_n & C_{n-1} \oplus \mathbf{F} \\ (m,n) & (m,n) \neq (1,1) & n \ge 2 & n \ge 3 \end{pmatrix}$$
$$\begin{pmatrix} \mathfrak{g} & D(m|n) & F(4) & G(3) \\ \mathfrak{g}_{\bar{0}} & D_m \oplus C_n & B_3 \oplus A_1 & G_2 \oplus A_1 \\ (m,n) & m \ge 4, n \ge 2 & --- & -- \end{pmatrix}$$

By [6, Prop. 2.5.5], we have dim $\mathfrak{g}_{\alpha} = 1$ for any $\alpha \in \Phi$. Let

$$\mathfrak{g}_{\bar{0}}' = \begin{cases} C_{n-1}, & \text{if } \mathfrak{g} = C_n \\ \mathfrak{g}_{\bar{0}}, & \text{otherwise.} \end{cases}$$

Let G be the subgroup of $\operatorname{Aut}(\mathfrak{g}_{\bar{0}}')$ such that $Lie(G) = \mathfrak{g}_{\bar{0}}'$. In particular, we take $G = GL(m) \times GL(n)$ for gl(m|n). If $\mathfrak{g} \neq gl(m|n)$, let G be the Chevalley group of $\mathfrak{g}_{\bar{0}}'$. Each element of G can be extended naturally to an even automorphism of \mathfrak{g} . So we identify G with the subgroup of $\operatorname{Aut}(\mathfrak{g})$ consisting of elements extended from those of G. By [5, p.14], our restriction on (m, n) ensures that there is a non-degenerate G-invariant bilinear form on $\mathfrak{g}_{\bar{0}}'$ if we assume p > 3.

Let $\chi \in \mathfrak{g}_{\bar{\mathfrak{o}}}^*$. For the convenience, we sometimes regard χ as a linear function on \mathfrak{g} by letting $\chi(\mathfrak{g}_{\bar{1}}) = 0$.

Lemma 2.2. [5, p.14] With the assumption on p as above, let \mathfrak{g} be one of the Lie superalgebras listed. Each $\chi \in \mathfrak{g}_{\bar{0}}^*$ is conjugate under G to an element $\chi' \in \mathfrak{g}_{\bar{0}}^*$ with $\chi'(\mathfrak{R}^+) = 0$.

Let $\Psi \in G$ such that $\chi^{\Psi}(\mathfrak{N}^+) = 0$. If $M = M_{\bar{0}} \oplus M_{\bar{1}}$ is a \mathfrak{g} -module, we denote by M^{Ψ} the \mathfrak{g} -module having M as its underlying vector space and a new \mathfrak{g} -action given by $xm = \Psi(x)m$ for $x \in \mathfrak{g}$ and $m \in M$, where the action on the right is the given one. Then $M_{\bar{i}}^{\Psi} = M_{\bar{i}}, i = 1, 2$, and M is simple if and only if M^{Ψ} is. So we may assume $\chi(\mathfrak{N}^+) = 0$ in the following. For each $\chi \in \mathfrak{g}_{\overline{0}}^*$, let $\lambda \in H^*$ satisfy $\lambda(h)^p - \lambda(h) = \chi^p(h)$ for every $h \in H$. Define $\mathbf{F}v$ to be the one dimensional $u(\mathfrak{B}, \chi)$ -module as follows:

 $\mathfrak{N}^+ v = 0, \quad hv = \lambda(h)v \quad \text{for every} \quad h \in H.$

Denote $Z^{\chi}(\lambda) =: U(\mathfrak{g}, \chi) \otimes_{U(\mathfrak{B}, \chi)} \mathbf{F}v. \ Z^{\chi}(\lambda)$ is called a baby Verma module with character χ . Let $\mathfrak{N}^- = \bigoplus_{\alpha < 0} \mathfrak{g}_{\alpha} = \mathfrak{N}^-_{\overline{0}} + \mathfrak{N}^-_{\overline{1}}$, where $\mathfrak{N}^-_{\overline{i}} = \bigoplus_{\alpha < 0, a \in \Phi_i} \mathfrak{g}_{\alpha}, \ i = 0, 1$.

Assume $\mathfrak{N}_{\overline{1}}^-$ has a basis f_1, \ldots, f_k . Then the PBW theorem shows that

$$Z^{\chi}(\lambda) = \sum_{1 \le i_1 < \dots < i_s \le k} f_{i_1} \cdots f_{i_s} u(\mathfrak{N}_{\overline{0}}, \chi) v.$$

We denote

$$Z_{\bar{0}} =: \sum_{s \text{ is even}} f_{i_1} \cdots f_{i_s} u(\mathfrak{N}_{\bar{0}}^-, \chi) v, \quad Z_{\bar{1}} =: \sum_{s \text{ is odd}} f_{i_1} \cdots f_{i_s} u(\mathfrak{N}_{\bar{0}}^-, \chi) v.$$

Then clearly $Z^{\chi}(\lambda) = Z_{\bar{0}} \oplus Z_{\bar{1}}$ is a \mathbb{Z}_2 -graded $u(\mathfrak{g}, \chi)$ -module.

Definition 2.3. Let $M = M_{\bar{0}} \oplus M_{\bar{1}}$ be a $u(\mathfrak{g}, \chi)$ -module. Let H be a maximal torus contained in the Borel subalgebra $\mathfrak{B} = H \oplus \mathfrak{N}^+$. For $\lambda \in H^*$, if there is a nonzero $v \in M_{\bar{0}} \cup M_{\bar{1}}$ such that

$$\mathfrak{N}^+ \cdot v = 0, h \cdot v = \lambda(h)v \quad for \ any \quad h \in H,$$

then we say that v is a maximal vector of highest weight λ .

By [16], any simple $u(\mathfrak{g}, \chi)$ -module contains at least one maximal vector.

Lemma 2.4. [16] The following are equivalent:

(1) M is a simple $u(\mathfrak{g}, \chi)$ -module.

(2) Any maximal vector $v \in M$ generates M.

Lemma 2.5. (1)[16] If M is a simple $u(\mathfrak{g}, \chi)$ -module, then M is the quotient of some $Z^{\chi}(\lambda)$.

(2) If χ is semisimple, then $Z^{\chi}(\lambda)$ has a unique \mathbb{Z}_2 -graded maximal submodule.

Proof. (2) Let $V \subseteq Z^{\chi}(\lambda)$ be a proper submodule. Since the maximal vector v generates $Z^{\chi}(\lambda)$, we have $v \notin V$. Suppose there is f in $u(\mathfrak{N}^-, \chi)\mathfrak{N}^- \subseteq u(\mathfrak{g}, \chi)$ such that $v + fv \in V$. Since χ is semisimple, Lemma 2.1 implies that f acts nilpotently. Thus 1 + f is invertible in $gl(Z^{\chi}(\lambda))$. This leads to $v \in V$, a contradiction. So we have $V \subseteq u(\mathfrak{N}^-, \chi)\mathfrak{N}^-v$. It follows that the sum of all the proper \mathbb{Z}_2 -graded submodules is the unique maximal \mathbb{Z}_2 -graded submodule of M.

Applying a similar arguments as that used in [11, Prop.3], we get

Proposition 2.6. If χ is semisimple, the any simple $u(\mathfrak{g}, \chi)$ -module has a unique maximal vector.

3 The simplicity of $Z^{\chi}(\lambda)$

Let \mathfrak{g} be one of the Lie superalgebras listed in last section. Let $\Phi = \Phi_0 \cup \Phi_1$ be the root system of \mathfrak{g} . In this section, we assume χ is semisimple. i.e., $\chi(\mathfrak{g}_{\alpha}) = 0$ for any $\alpha \in \Phi$.

Let $e_{\alpha_i}(\text{resp.}, f_{\alpha_i}), \alpha_i \in \Phi^+$ denote the positive (resp., negative) root vectors. Define a function $\bar{p}: \Phi^+ \longrightarrow \mathbb{Z}$ such that

$$\bar{p}(\alpha_i) = \begin{cases} p, & \text{if } \alpha_i \in \Phi_{\bar{0}} \\ 2, & \text{if } \alpha_i \in \Phi_{\bar{1}}. \end{cases}$$

We write $\bar{p}(\alpha_i)$ simply as \bar{p} . We abuse the notation \mathbf{F}_2 as the subset $\{\bar{0}, \bar{1}\} \subseteq \mathbf{F}_p$.

Assume $|\Phi^+| = n$. Put elements in Φ^+ in the order of ascending heights: $\alpha_1, \alpha_2, \ldots, \alpha_n$. Let (i_1, \ldots, i_n) and $(i_1, \ldots, i_n)^-$, $0 \le i_k \le \bar{p} - 1$ denote the product

$$e_{\alpha_1}^{i_1}e_{\alpha_2}^{i_2}\dots e_{\alpha_n}^{i_n}$$
 and $f_{\alpha_1}^{i_1}f_{\alpha_2}^{i_2}\dots f_{\alpha_n}^{i_n} \in u(\mathfrak{g},\chi)$

respectively. Then using a similar argument as that for [11, Prop.4], we have

Proposition 3.1. Any nonzero submodule of $Z^{\chi}(\lambda)$ contains $(\bar{p} - 1, \dots, \bar{p} - 1)^{-}v$.

Let \mathfrak{g} be a restricted Lie superalgebra. Consider $U(\mathfrak{g})$ as a $\mathfrak{g}_{\bar{0}}$ -module with the adjoint action, then we get

$$U(\mathfrak{g}) = \bigoplus_{\lambda \in H^*} U(\mathfrak{g})_{\lambda}.$$

We have $U(\mathfrak{g})_{\lambda}U(\mathfrak{g})_{\mu} \subseteq U(\mathfrak{g})_{\lambda+\mu}$. Then $U(\mathfrak{g})_0$ is a subalgebra of $U(\mathfrak{g})$.

Lemma 3.2. [2, 7.4.2] Let $L = U(\mathfrak{g})\mathfrak{N}^+ \cap U(\mathfrak{g})_0$. Then

- (1) $L = \mathfrak{N}^{-}U(\mathfrak{g}) \cap U(\mathfrak{g})_{0}$ and L is a two-sided ideal of $U(\mathfrak{g})_{0}$.
- (2) $U(\mathfrak{g})_0 = U(H) \oplus L.$

Let $\pi: U(\mathfrak{g}) \longrightarrow u(\mathfrak{g}, \chi)$ be the canonical epimorphism of associative algebras. Then

$$\pi(L) \subseteq \pi(U(\mathfrak{g})\mathfrak{N}^+) = u(\mathfrak{g}, \chi)\mathfrak{N}^+.$$

Take a basis of \mathfrak{g} :

$$f_{\alpha_1},\ldots,f_{\alpha_n},h_1,\ldots,h_s,e_{\alpha_1},\ldots,e_{\alpha_n},$$

where the positive roots $\alpha_1, \ldots, \alpha_n$ is in the order of descending heights. Then $u(\mathfrak{g}, \chi)$ has a PBW basis

$$f_{\alpha_1}^{i_1} \cdots f_{\alpha_n}^{i_n} h_1^{k_1} \cdots h_s^{k_s} e_{\alpha_1}^{j_1} \cdots e_{\alpha_n}^{j_n}, 0 \le i_l, j_l \le \bar{p} - 1, 0 \le k_i \le p - 1.$$

Since $\chi(\mathfrak{N}^+) = 0$, so that $e_{\alpha_l}^{\bar{p}} = 0$ for $l = 1, \ldots, n$, each nonzero element of $\pi(U(\mathfrak{g})\mathfrak{N}^+)$ is a linear combination of the basis vectors of $u(\mathfrak{g}, \chi)$ with $\sum j_l > 0$. Thus we get

$$\pi(L) \cap \pi(U(H)) = \pi(L) \cap u(H,\chi) = 0.$$

It follows from Lemma 3.2(2) that $\pi(U(\mathfrak{g})_0) = u(H,\chi) \oplus \pi(L)$. We call the projection map from $\pi(U(\mathfrak{g})_0)$ to $u(H,\chi)$ with the kernel $\pi(L)$ the Harish-Chandra homomorphism, denoted by γ .

For the maximal vector v which defines $Z^{\chi}(\lambda)$, we have

$$(\bar{p} - 1, \dots, \bar{p} - 1)(\bar{p} - 1, \dots, \bar{p} - 1)^{-}v$$

= $\gamma(\prod e_{\alpha_{i}}^{\bar{p} - 1} \prod f_{\alpha_{i}}^{\bar{p} - 1})v$
= $f(\lambda)v.$

Note that the definition of $f(\lambda)$ is dependent on the positive root system Φ^+ and the corresponding Borel subalgebra.

Theorem 3.3. $Z^{\chi}(\lambda)$ is simple if and only if $f(\lambda) \neq 0$.

Proof. Suppose $f(\lambda) \neq 0$. By Proposition 3.1, any nonzero submodule $V \subseteq Z^{\chi}(\lambda)$ contains the maximal vector v, hence $V = Z^{\chi}(\lambda)$. So $Z^{\chi}(\lambda)$ is simple.

Conversely, assume $Z^{\chi}(\lambda)$ is simple. We see that $w =: (\bar{p} - 1, \dots, \bar{p} - 1)^{-\nu} v$ is a minimal vector in $Z^{\chi}(\lambda)$. i.e., $f_{\alpha_i}w = 0$ for every $\alpha_i \in \Phi^+$. Let $\mathfrak{g} = \mathfrak{N}^- \oplus$ $H \oplus \mathfrak{N}^+$. Then we get $Z^{\chi}(\lambda) = u(\mathfrak{N}^+)w$. Since $\dim Z^{\chi}(\lambda) = 2^{\dim \mathfrak{N}_1^+} p^{\dim \mathfrak{N}_0^+}$, the set $\{(i_1, i_2, \dots, i_n)w | 0 \leq i_j \leq \bar{p} - 1, j = 1, \dots, n\}$ is a basis of $Z^{\chi}(\lambda)$. Therefore,

$$0 \neq (\bar{p} - 1, \dots, \bar{p} - 1)w = (\bar{p} - 1, \dots, \bar{p} - 1)(\bar{p} - 1, \dots, \bar{p} - 1)^{-}v = f(\lambda)v$$

Hence we get $f(\lambda) \neq 0$.

Fixing a simple root system Δ and the positive root system Φ^+ , let $\mathfrak{N}^+ = \bigoplus_{\alpha \in \Phi^+} \mathfrak{g}_{\alpha}$. For $\alpha \in \Delta_0$, the reflection s_{α} can be extended to an automorphism of \mathfrak{g} , also denoted by s_{α} . We have [4, p.277]

$$s_{\alpha} = \exp ade_{\alpha} \exp ad(-f_{\alpha}) \exp ade_{\alpha}.$$

Assume p > 3. Then s_{α} is well defined in all cases. Each s_{α} can be naturally extended to an automorphism of the tensor algebra $T(\mathfrak{g})$ such that $s_{\alpha}(1) = 1$. Let \mathfrak{I} be the two sided ideal of $T(\mathfrak{g})$ generated by

$$\{x \otimes y - (-1)^{\mathbf{p}(x)\mathbf{p}(y)}y \otimes x - [x,y], z^p - z^{[p]} - \chi(z)^p \cdot 1 | x, y \in \mathfrak{g}_{\bar{0}} \cup \mathfrak{g}_{\bar{1}}, z \in \mathfrak{g}_{\bar{0}}\}.$$

Then it is clear that s_{α} stabilizes \mathfrak{I} . Hence s_{α} induces an automorphism of $u(\mathfrak{g}, \chi) = U(\mathfrak{g})/\mathfrak{I}$, also denoted by s_{α} .

The induced action of s_{α} on H^* is defined as:

$$s_{\alpha} \cdot \lambda(h) = \lambda(s_{\alpha}^{-1}h), \text{ for } \lambda \in H^*, h \in H.$$

We identify H with $(H^*)^*$ by letting $h(\lambda) = \lambda(h)$ for any $\lambda \in H^*$ and $h \in H$. So U(H) can be identified with the polynomial function ring on H^* . If dimH = s, regard H^* as the affine variety \mathbf{F}^s . Then all weights related to χ makes a closed subset X defined by the relation $\lambda^p - \lambda = \chi$ and $u(H, \chi)$ is the coordinate algebra.

Put elements of Δ in a fixed order: $\alpha_1, \alpha_2, \ldots, \alpha_r$. For $\mathfrak{g} \neq gl(m|n)$, we take a basis of H: $h_1 =: h_{\alpha_1}, \ldots, h_r =: h_{\alpha_r}$. For $\mathfrak{g} = gl(m|n)$, fix a h such that $H = \{h_{\alpha} | \alpha \in \Delta\} \oplus \mathbf{F}h$. We take the basis of H: $h_1 =: h_{\alpha_1}, \ldots, h_r =: h_{\alpha_r}, h_{r+1} = h$. Then we have $X = \{(\lambda_1, \ldots, \lambda_s) | \lambda_i^p - \lambda_i = \chi(h_i)^p\} \subseteq F^s$ and $|X| = p^s$. For our purposes, it is sufficient to work on X instead of H^* .

For $f(h) = f(h_{\alpha_1}, \ldots, h_{\alpha_n}) \in u(H, \chi)$, we have

$$s_{\alpha}f(h)(\lambda) = s_{\alpha}f(h_{\alpha_{1}}, \dots, h_{\alpha_{n}})(\lambda)$$
$$= f(s_{\alpha}h_{\alpha_{1}}, \dots, s_{\alpha}h_{\alpha_{n}})(\lambda)$$
$$= f(\lambda(s_{\alpha}h_{\alpha_{1}}), \dots, \lambda(s_{\alpha}h_{\alpha_{n}}))$$
$$= f(h_{\alpha_{1}}, \dots, h_{\alpha_{n}})(s_{\alpha}^{-1}\lambda).$$

Let v' be the maximal vector defined by the Borel subalgebra $s_{\alpha}(\mathfrak{B})$ of weight $\lambda \in H^*$ and character χ . i.e., $\mathbf{F}v'$ is a 1-dimensional $u(s_{\alpha}(\mathfrak{B}), \chi)$ -module. Let $f^{\alpha}(\lambda)$ be the polynomial defined with respect to the new positive root system $s_{\alpha}(\Phi^+)$. Then we have

$$f^{\alpha}(\lambda)v' = s_{\alpha}(e_{\alpha_1})\dots s_{\alpha}(e_{\alpha_n})s_{\alpha}(f_{\alpha_1})\dots s_{\alpha}(f_{\alpha_n})v'$$
$$= s_{\alpha}(e_{\alpha_1}\dots e_{\alpha_n}f_{\alpha_1}\dots f_{\alpha_n})v'.$$

Assume

$$e_{\alpha_1} \dots e_{\alpha_n} f_{\alpha_1} \dots f_{\alpha_n} = t(h) + \sum_i u_i n_i^+ \in \pi(U(\mathfrak{g})_0),$$

where $u_i \in u(\mathfrak{g}, \chi), n_i^+ \in \mathfrak{N}^+$ and $t(h) = \gamma(e_{\alpha_1} \dots e_{\alpha_n} f_{\alpha_1} \dots f_{\alpha_n}) \in u(H, \chi).$

We denote $\mathfrak{N}'^+ = s_{\alpha}(\mathfrak{N}^+)$. Then we get

$$s_{\alpha}(e_{\alpha_1}\dots e_{\alpha_n}f_{\alpha_1}\dots f_{\alpha_n}) = s_{\alpha}(t(h)) + \sum_i u'_i n'^+_i$$

where $u_i' \in u(\mathfrak{g}, \chi), n_i^{'+} \in \mathfrak{N}^{'+}$. Thus, we have

$$f^{\alpha}(\lambda)v' = s_{\alpha}(t(h))v' = \lambda(s_{\alpha}(t(h)))v' = t(h)(s_{\alpha}^{-1}(\lambda))v'.$$

Since $t(h)(\lambda) = f(\lambda)$, we get $f^{\alpha}(\lambda) = f(s_{\alpha}^{-1}(\lambda))$.

Lemma 3.4. For each $\alpha \in \Delta_0$, $f(\lambda)$ and $f(s_{\alpha}^{-1}(\lambda + \alpha))$ have the same set of zeros.

Proof. Let Φ^+ be the fixed positive root system with which $Z^{\chi}(\lambda)$ and $f(\lambda)$ are defined. Let v be the maximal vector that defines $Z^{\chi}(\lambda)$. Assume $Z_1^{\chi}(\lambda)$ is the baby verma module defined with respect to the new positive root system $s_{\alpha}(\Phi^+)$. It is easy to see that $v' =: f_{\alpha}^{p-1}v \in Z^{\chi}(\lambda)$ is a maximal vector with respect to $s_{\alpha}(\mathfrak{B})$ and has weight $\lambda + \alpha$.

Since v' is homogeneous, the inclusion map $\mathbf{F}v' \to Z^{\chi}(\lambda)$ induces a nonzero \mathbf{Z}_2 graded $u(\mathfrak{g}, \chi)$ -homomorphism κ : $Z_1^{\chi}(\lambda) \longrightarrow Z^{\chi}(\lambda)$. So Im κ is a nonzero \mathbf{Z}_2 -graded
submodule of $Z^{\chi}(\lambda)$. Note that dim $Z_1^{\chi}(\lambda) = \dim Z^{\chi}(\lambda)$.

If $f(\lambda) \neq 0$, then the simplicity of $Z^{\chi}(\lambda)$ shows that κ is onto, hence an isomorphism, so that $Z_1^{\chi}(\lambda)$ is simple and hence $f^{\alpha}(\lambda) \neq 0$. On the other hand, if $f^{\alpha}(\lambda) \neq 0$, then $Z_1^{\chi}(\lambda)$ is simple, hence the \mathbb{Z}_2 -graded submodule ker κ must be zero. Therefore κ is an isomorphism. This implies that $f(\lambda) \neq 0$, since $Z^{\chi}(\lambda)$ is simple.

Let $\alpha \in \Delta$ be a simple root. Consider the subalgebra A of \mathfrak{g} with basis e_{α}, f_{α} , h_{α} . If $\alpha \in \Delta_0$, then $A \cong sl_2$. If $\alpha \in \Delta_1$, then A is a restricted Heisenberg algebra of rank 1 (see [13, p. 149]). By the standard results, for each semisimple character $\chi \in A^*$. A simple $u(A, \chi)$ -module of highest weight $a \in \mathbf{F}$ has dimension less than \bar{p} if and only if $a + 1 \in \mathbf{F}_{\bar{p}} \setminus 0$.

For each simple root $\alpha \in \Delta$, we take a parabolic subalgebra of \mathfrak{g} : $\mathfrak{P} = \mathfrak{B} + \mathbf{F} f_{\alpha}$. Let $\mathfrak{N} = \mathfrak{N}_{\bar{0}} \oplus \mathfrak{N}_{\bar{1}}$ be the nilradical of \mathfrak{P} . Let $\chi \in \mathfrak{g}_{\bar{0}}^*$ be semisimple. For each $\lambda \in X$, a simple $u(A, \chi_{|A})$ -module V can be extended to a $u(\mathfrak{P}, \chi)$ -module as follows:

$$e_{\beta}V = 0, \beta \in \Phi^+ \setminus \alpha, hv = \lambda(h)v \text{ for each } h \in H.$$

Then $u(\mathfrak{g},\chi) \otimes_{u(\mathfrak{P},\chi)} V$ has dimension

 $2^{\dim \mathfrak{N}_{\bar{1}}} p^{\dim \mathfrak{N}_{\bar{0}}} \dim V.$

Obviously $u(\mathfrak{g}, \chi) \otimes_{u(\mathfrak{P}, \chi)} V$ is an epimorphic image of $Z^{\chi}(\lambda)$. If $\lambda(h_{\alpha}) + 1 \in \mathbf{F}_{\bar{p}} \setminus 0$, so that $\dim V < \bar{p}$, then we have $\dim u(\mathfrak{g}, \chi) \otimes_{u(\mathfrak{P}, \chi)} V < \dim Z^{\chi}(\lambda)$, so $Z^{\chi}(\lambda)$ is not simple, hence we have $f(\lambda) = 0$.

Recall that $f(\lambda) = t(h)(\lambda)$. Let $\mathcal{V}(g)$ denote the set of zeros in X of $g \in u(H, \chi)$. Then we get $\mathcal{V}(h_{\alpha} + 1 - c) \subseteq \mathcal{V}(t(h))$ for every $c \in \mathbf{F}_{\bar{p}} \setminus 0$.

By the earlier discussion, each element in $u(H, \chi)$ is a polynomial of the variables h_1, \ldots, h_r $(h_1, \ldots, h_{r+1}$ for $\mathfrak{g} = gl(m|n)$). It is no loss of generality to assume $h_\alpha = h_1$. For every $c \in \mathbf{F}_{\bar{p}} \setminus 0$, using the Remainder Theorem, we have

$$t(h) = (h_1 + 1 - c)q(h) + r(h), \quad q(h), r(h) \in u(H, \chi),$$

where the variable h_1 is not appearing in r(h). Taking the value at a point in $\mathcal{V}(h_{\alpha} + 1 - c)$, we get r(h) = 0. Thus $f(\lambda) = t(h)(\lambda)$ is divisible by the polynomial $\lambda(h_{\alpha}) + 1 - c$.

For the basis of H given earlier, we define $\rho \in H^*$ such that $\rho(h_i) = 1$, $i = 1, \ldots, r$, and $\rho(h_{r+1}) = 0$ if $\mathfrak{g} = gl(m|n)$. Note that $\lambda + \rho \in X$ for any $\lambda \in X$.

Corollary 3.5. (1) For each $\alpha \in \Delta_0$, $[(\lambda(h_\alpha) + \rho(h_\alpha))^{p-1} - 1]|f(\lambda)$.

(2) For each $\alpha \in \Delta_1$, $\lambda(h_\alpha)|f(\lambda)$.

Lemma 3.6. Let $\Phi = \Phi_0 \cup \Phi_1$, $\Phi^+ = \Phi_0^+ \cup \Phi_1^+$, $\Delta = \Delta_0 \cup \Delta_1$ be the root, positive root, simple root system of \mathfrak{g} respectively. Let W_0 be the weyl group of $\mathfrak{g}_{\bar{0}}$. Then for each $\beta \in \Phi_1$, there is $\tau \in W_0$ such that $\tau(\beta) \in \Delta_1$.

Proof. Let $\mathfrak{g}_{\overline{0}} = \mathfrak{g}_{\overline{0}}^1 \oplus \mathfrak{g}_{\overline{0}}^2$ as given in Section 2. Then Δ_0 consist of simple roots of $\mathfrak{g}_{\overline{0}}^1$ (denoted in terms of ϵ_i 's in [6, p.51-53]) and those of $\mathfrak{g}_{\overline{0}}^2$ (denoted in terms of δ_i 's in [6, p.51-53]). By definition, it is easy to get $s_\alpha(\lambda) = \lambda - \lambda(h_\alpha)\alpha$ for $\lambda \in H^*$ and $\alpha \in \Delta_0$. Using the root system given in [6, p.51-53], one sees that there is $\tau \in W_0$ such that $\tau(\beta) \in \Delta_1$.

Theorem 3.7.

$$f(\lambda) = \pm \prod_{\alpha \in \Phi_0^+} [(\lambda(h_\alpha) + \rho(h_\alpha))^{p-1} - 1] \prod_{\alpha \in \Phi_1^+} [\lambda(h_\alpha) + \rho(h_\alpha) - 1].$$

Proof. By Corollary 3.5,

$$\Pi_{\alpha \in \Delta_0} [(\lambda(h_\alpha) + \rho(h_\alpha))^{p-1} - 1] \Pi_{\alpha \in \Delta_1} [\lambda(h_\alpha) + \rho(h_\alpha) - 1] | f(\lambda).$$

Then the theorem follows from Lemma 3.6 and a similar argument as that for [11, Prop. 8].

4 The simplicity of the graded baby verma modules for $\mathfrak{g} = gl(m|n)$

Let $\mathfrak{g} = gl(m|n)$. Then $\mathfrak{g} = \mathfrak{g}_{-1} \oplus \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_1$, where

$$\mathfrak{g}_{-1} = \bigoplus_{j > m, i \le m} \mathbf{F} e_{ji}$$
 and $\mathfrak{g}_1 = \bigoplus_{j > m, i \le m} \mathbf{F} e_{ij}$.

The reader may refer to [6] for more detailed description of \mathfrak{g}_{-1} and \mathfrak{g}_1 .

Let $\chi \in \mathfrak{g}_{\bar{0}}^*$ and assume $\chi(\mathfrak{N}_{\bar{0}}^+) = 0$, where $\mathfrak{N}_{\bar{0}}^+ = \bigoplus \sum_{i < j} \mathbf{F} e_{ij} \subseteq \mathfrak{g}_{\bar{0}}$. Denote $\mathfrak{g}^+ = \mathfrak{g}_0 + \mathfrak{g}_1$. Let M be a simple $u(\mathfrak{g}_{\bar{0}}, \chi)$ -module. We regard M as a $u(\mathfrak{g}^+, \chi)$ -module by letting $\mathfrak{g}_1 M = 0$. As in [16], we define the induced module $Z^{\chi}(M) = u(\mathfrak{g}, \chi) \otimes_{u(\mathfrak{g}^+, \chi)} M$. We call it the graded baby verma module.

Lemma 4.1. Any simple $u(\mathfrak{g}, \chi)$ -module $\mathfrak{M} = \mathfrak{M}_{\overline{0}} \oplus \mathfrak{M}_{\overline{1}}$ is a quotient of $Z^{\chi}(M)$ for some simple $u(\mathfrak{g}_{\overline{0}}, \chi)$ -submodule $M \subseteq \mathfrak{M}_{\overline{0}}$ or $M \subseteq \mathfrak{M}_{\overline{1}}$.

Proof. By [16, Lemma 3.12], there is a simple $u(\mathfrak{g}^+, \chi)$ -submodule $M \subseteq \mathfrak{M}_{\bar{0}}$ or $M \subseteq \mathfrak{M}_{\bar{1}}$. Then the inclusion map $M \to \mathfrak{M}$ induces a \mathbb{Z}_2 -graded $u(\mathfrak{g}, \chi)$ -module homomorphism $f: Z^{\chi}(M) \to \mathfrak{M}$. Since \mathfrak{M} is simple f is an epimorphism. \Box

Let $v \in M$ be a maximal vector of weight λ . Let e_1, \ldots, e_l (resp., f_1, \ldots, f_l) denote the following basis of \mathfrak{g}_1 (resp., \mathfrak{g}_{-1}):

$$\{e_{ij} | i \le m, j > m\} (resp., \{e_{ij} | i > m, j < m\}).$$

We put them in the order of ascending heights. For $e_1 \ldots e_l f_1 \ldots f_l \in \pi(U(\mathfrak{g})_0)$, assume $e_1 \ldots e_l f_1 \ldots f_l v = f_1(\lambda) v$. **Proposition 4.2.** (1) If $f_1(\lambda) \neq 0$, then $Z^{\chi}(M)$ is simple.

(2) If $Z^{\chi}(M)$ is simple, then $f_1(\lambda) \neq 0$.

Proof. (1) Let V be any proper submodule of $Z^{\chi}(M)$. Taking

$$0 \neq \sum f_{i_1} \dots f_{i_t} m_{i_1,\dots,i_t} \in V, \quad m_{i_1,\dots,i_t} \in M,$$

let t be the smallest such that $f_{i_1} \dots f_{i_t} m_{i_1,\dots,i_t} \neq 0$. Let

$$\{j_1,\ldots,j_{l-t}\} = \{1,\ldots,l\} - \{i_1,\ldots,i_t\}.$$

By applying $f_{j_1} \dots f_{j_{l-t}}$, we get $0 \neq f_1 \dots f_l m \in V$ for some $0 \neq m \in M$. Hence $e_1 \dots e_l f_1 \dots f_l m \in V$.

Let $\mathfrak{g}_{\bar{0}} = H \oplus \mathfrak{N}_{\bar{0}}^- \oplus \mathfrak{N}_{\bar{0}}^+$. Since *M* is a simple $u(\mathfrak{g}_{\bar{0}}, \chi)$ -module, there is a polynomial

$$f = \sum n_i^- h_i n_i^+ \in u(\mathfrak{g}_{\bar{0}}, \chi) = u(\mathfrak{N}_0^-, \chi) u(H, \chi) u(\mathfrak{N}_0^+, \chi)$$

such that fm is the maximal vector $v \in M$. Note that for $i, j \leq m$ with $i \neq j$,

$$[e_{ij}, e_1 \dots e_l] = [e_{ij}, f_1 \dots f_l] = 0, [h, e_1 \dots e_l f_1 \dots f_l] = 0$$
 for all $h \in H$.

So we get

$$[f, e_1 \dots e_l f_1 \dots f_l] = [\Sigma n_i^- h_i n_i^+, e_1 \dots e_l f_1 \dots f_l] = 0.$$

This shows that $e_1 \ldots e_l f_1 \ldots f_l v \in V$ and hence $v \in V$. So (1) follows immediately.

(2) Let $v_1 = v, v_2, \ldots, v_s$ be a basis of M. Since $\mathfrak{g}_1 M = 0$ and $\dim Z^{\chi}(M) = 2^{\dim \mathfrak{g}_{-1}} \dim M$.

 $\{f_{i_1} \dots f_{i_k} v_i | 0 \le i_1 < \dots < i_k \le l, i = 1, \dots, s\}$

is a basis of $Z^{\chi}(M)$. Let $M' = f_1 \dots f_l M$, then $\dim M' = \dim M = s$.

Since $\mathfrak{g}_{-1}M' = 0$,

$$Z^{\chi}(M) = u(\mathfrak{g}_1)M' = \langle e_{i_1} \dots e_{i_k}f_1 \dots f_l v_i | 0 \le i_1 < \dots < i_k \le l, i = 1, \dots, s \rangle.$$

Therefore, $e_1 \dots e_l f_1 \dots f_l v \ne 0$, so that $f_1(\lambda) \ne 0$.

Denote $f_0(\lambda) = \prod_{\alpha \in \Phi_0^+} [(\lambda(h_\alpha) + \rho(h_\alpha))^{p-1} - 1].$

Lemma 4.3. Let χ be semisimple. Then $f_1(\lambda) = cf(\lambda)/f_0(\lambda), 0 \neq c \in \mathbf{F}$.

Proof. If λ is such that $f_0(\lambda) \neq 0$ but $f(\lambda) = 0$, then by [11, Th. 3], $M(\lambda)$ is simple, where $M(\lambda)$ is the simple $u(\mathfrak{g}_{\bar{0}}, \chi)$ -module with the unique maximal vector v of weight λ . Since $Z^{\chi}(M(\lambda))$ is not simple, we get $f_1(\lambda) = 0$. By Theorem 3.7, $f(\lambda)/f_0(\lambda) \in u(H,\chi)$ is the product of linear factors. So we have $[f(\lambda)/f_0(\lambda)]|f_1(\lambda)$. A direct computation on $e_1 \cdots e_l f_1 \cdots f_l v$ shows that the highest term of $\gamma(e_1 \cdots e_l f_1 \cdots f_l)$ is $h_{\beta_1} \cdots h_{\beta_l}$, where β_1, \ldots, β_l are all the positive odd roots of \mathfrak{g} . So we get $\deg(f_1(\lambda)) = l$. That is

$$\deg(f_1(\lambda)) = \deg(f(\lambda)) - \deg(f_0(\lambda)).$$

Hence we get $f_1(\lambda) = cf(\lambda)/f_0(\lambda)$ for some $c \neq 0$.

By Theorem 3.7, $f_1(\lambda) = \prod_{\alpha \in \Phi_1^+} ((\lambda + \rho)(h_\alpha) - 1)$ (up to a constant multiple). For $\alpha = \epsilon_i - \delta_j \in \Phi_1^+$, it is easy to see that $h_\alpha = e_{ii} + e_{i+j,i+j}$. So we get $\rho(h_\alpha) = m - i + j \in \mathbf{F}_p$. Let χ be semisimple. If $\chi(h_\alpha) \neq 0$, then $\lambda(h_\alpha) \notin \mathbf{F}_p$. So we have

Theorem 4.4. Let $\mathfrak{g} = gl(m|n)$ and let χ be semisimple. If $\chi(h_{\alpha}) \neq 0$ for every $\alpha \in \Phi_1^+$, then $Z^{\chi}(M)$ is simple.

Recall $Z^{\chi}(\lambda) = Z_{\bar{0}} \oplus Z_{\bar{1}}$. Let $v \in Z_0$ be the maximal vector that defines $Z^{\chi}(\lambda)$. Let $V_0 := u(\mathfrak{g}_{\bar{0}}, \chi) v \subseteq Z_{\bar{0}}$. Since $[e_{ij}, \mathfrak{g}_1] \subseteq \mathfrak{g}_1$ and $[e_{ij}, \mathfrak{g}_{-1}] \subseteq \mathfrak{g}_{-1}$ for any $e_{ij} \in \mathfrak{g}_{\bar{0}}$, we have $\mathfrak{g}_1 V_0 = 0$. Let

$$V_0 \supseteq V_1 \supseteq \cdots \supseteq V_s \supseteq 0$$

be a composition series of $u(\mathfrak{g}_{\bar{0}}, \chi)$ -submodules. Then it can also be regarded as a composition series of $u(\mathfrak{g}^+, \chi)$ -modules. This induces a filtration of \mathbb{Z}_2 -graded $u(\mathfrak{g}, \chi)$ -submodules of $Z^{\chi}(\lambda)$:

$$Z^{\chi}(\lambda) = u(\mathfrak{g},\chi) \otimes_{u(\mathfrak{g}^+,\chi)} V_0 \supseteq u(\mathfrak{g},\chi) \otimes_{u(\mathfrak{g}^+,\chi)} V_1 \supseteq \cdots \supseteq u(\mathfrak{g},\chi) \otimes_{u(\mathfrak{g}^+,\chi)} V_s \supseteq 0.$$

We see that each factor module

$$u(\mathfrak{g},\chi)\otimes_{u(\mathfrak{g}^+,\chi)}V_{i-1}/u(\mathfrak{g},\chi)\otimes V_i\cong u(\mathfrak{g},\chi)\otimes_{u(\mathfrak{g}^+,\chi)}V_{i-1}/V_i=Z^{\chi}(V_{i-1}/V_i), i=1,\ldots,s$$

is a graded baby verma module.

Corollary 4.5. Let $\mathfrak{g} = gl(m|n)$. If $f_1(\lambda) \neq 0$, then the baby verma module $Z^{\chi}(\lambda)$ has a composition series induced by that of the $u(\mathfrak{g}_{\bar{0}}, \chi)$ baby verma module $u(\mathfrak{g}_{\bar{0}}, \chi)v$. In addition, the lowy length equals one if and only if $f_0(\lambda) \neq 0$.

5 $\mathfrak{g} = gl(m|n)$

5.1 The Frobenius superalgebra

Definition 5.1. [6] Let $V = V_{\bar{0}} \oplus V_{\bar{1}}$ be a \mathbb{Z}_2 -graded space and f is a bilinear form on V. Then f is called supersymmetric if $f(a, b) = (-1)^{p(a)p(b)} f(b, a)$ for any $a, b \in V_{\bar{0}} \cup V_{\bar{1}}$.

Definition 5.2. An associative \mathbf{F} -superalgebra A is called a Frobenius superalgebra if it has a non-degenerate invariant bilinear form f. A Frobenius superalgebra is said to be supersymmetric if f is supersymmetric.

Let $A = A_{\bar{0}} \oplus A_{\bar{1}}$ be a Frobenius superalgebra. We use the notation A_L (resp., A_R) to denote the left (resp., right) regular A-module A. Let

$$A_{\overline{i}}^* \coloneqq \{ f \in A^* | f(A_{\overline{i+1}}) = 0 \}, \overline{i} \in \mathbf{Z}_2.$$

Then $A^* = A_0^* \oplus A_1^*$. It is easy to check that A_L^* (resp., A_R^*) is a right (resp., left) \mathbb{Z}_2 -graded A-module.

Lemma 5.3. Let A be a finite dimensional superalgebra. Then the following are equivalent:

(1) A is Frobenious.

(2)
$$A_L \cong (A_R)^*, A_R \cong (A_L)^*.$$

The proof is similar to that of [1, Th. 61.3, p.414].

If we take the polynomial ring \mathcal{O} generated by $\{x^p - x^{[p]} | x \in \mathfrak{g}_{\bar{0}}\}$, then \mathcal{O} is in the center of $U(\mathfrak{g})$. By applying a similar argument as that for [3, Prop.1.2], one gets

Proposition 5.4. Let \mathfrak{g} be a finitely dimensional restricted Lie superalgebra. For any $\chi \in \mathfrak{g}_{\bar{\mathfrak{g}}}(considered \ as \ a \ linear \ function \ on \ \mathfrak{g} \ by \ letting \ \chi(\mathfrak{g}_{\bar{\mathfrak{l}}}) = 0), \ u(\mathfrak{g}, \chi) \ is$ a Frobenius superalgebra. Moreover, $u(\mathfrak{g}, \chi)$ is supersymmetric if str(adx) = 0 for any $x \in \mathfrak{g}$.

Definition 5.5. Let \mathfrak{g} be a restricted Lie superalgebra. We call \mathfrak{g} unipotent if for any $x \in \mathfrak{g}_{\bar{0}}$, there is r > 0 such that $x^{[p]^r} = 0$.

By Lemma 2.1(2), we get

Corollary 5.6. If \mathfrak{g} is unipotent, then the trivial \mathfrak{g} -module \mathbf{F} is the only simple $u(\mathfrak{g})$ -module.

Lemma 5.7. If \mathfrak{g} is unipotent, then each $u(\mathfrak{g}, \chi)$ has only one simple module (up to isomorphism).

Proof. Let $M = M_{\bar{0}} \oplus M_{\bar{1}}$ and $M' = M'_{\bar{0}} \oplus M'_{\bar{1}}$ be two simple $u(\mathfrak{g}, \chi)$ -modules. For $\bar{i}, \bar{j} \in \mathbb{Z}_2$, let

$$\operatorname{Hom}_{\mathbf{F}}(M, M')_{\overline{i}} = \{ f \in \operatorname{Hom}_{\mathbf{F}}(M, M') | f(M_{\overline{j}}) \subseteq M'_{\overline{i+i}} \}.$$

Then

$$\operatorname{Hom}_{\mathbf{F}}(M, M') = \operatorname{Hom}_{\mathbf{F}}(M, M')_{\bar{0}} \oplus \operatorname{Hom}_{\mathbf{F}}(M, M')_{\bar{1}}$$

is a $u(\mathfrak{g})$ -module. By Corollary 5.6, $\operatorname{Hom}_{\mathbf{F}}(M, M')_{\overline{0}}$ contains a trivial submodule $\mathbf{F}x$. Suppose $x = x_{\overline{0}} + x_{\overline{1}}, x_{\overline{i}} \in \operatorname{Hom}_{\mathbf{F}}(M, M')_{\overline{i}}, \overline{i} \in \mathbb{Z}_2$. Then both $\mathbf{F}x_{\overline{i}}$ are trivial $u(\mathfrak{g})$ -submodules. So we may assume x is homogeneous. Therefore

$$\operatorname{Hom}_{\mathfrak{g}}(M, M')_{\overline{0}} \cup \operatorname{Hom}_{\mathfrak{g}}(M, M')_{\overline{1}} \neq 0.$$

Take

$$0 \neq x \in \operatorname{Hom}_{\mathfrak{g}}(M, M')_{\bar{0}} \cup \operatorname{Hom}_{\mathfrak{g}}(M, M')_{\bar{1}},$$

then $x(M_{\bar{0}}) \oplus x(M_{\bar{1}})$ is a nonzero \mathbb{Z}_2 -graded submodule of M'. Since M and M' are simple, $M \cong M'$.

Lemma 5.8. Let \mathfrak{g} be a finite dimensional unipotent Lie superalgebra. Then the regular(both left and right) $u(\mathfrak{g})$ -module $u(\mathfrak{g})$ has a unique trivial submodule $\mathbf{F}v$. Therefore, $v \in u(\mathfrak{g})_{\overline{0}} \cup u(\mathfrak{g})_{\overline{1}}$.

Proof. We only give the proof for the left regular $u(\mathfrak{g})$ -module. By Corollary 5.6, there is $v \in u(\mathfrak{g})$ such that $\mathbf{F}v$ is a trivial $u(\mathfrak{g})$ -submodule. Let f be the non-degenerate invariant bilinear form on $u(\mathfrak{g})$. By assumption, f(x,v) = f(1,xv) = 0 for any $x \in \mathfrak{g}$. So v is in the (right) orthogonal complement of $u(\mathfrak{g})\mathfrak{g}$. Since $u(\mathfrak{g})\mathfrak{g}$ has codimension 1 in $u(\mathfrak{g})$, its orthogonal complement is 1-dimensional. This implies that $u(\mathfrak{g})$ has a unique trivial submodule $\mathbf{F}v$. The uniqueness implies that v is homogeneous.

Lemma 5.9. Let \mathfrak{g} be a finite dimensional unipotent Lie superalgebra. If str(adx) = 0 for all $x \in \mathfrak{g}$. Let $\mathbf{F}v_L(resp., \mathbf{F}v_R)$ be the unique trivial $u(\mathfrak{g})$ -submodule of $u(\mathfrak{g})_L(resp., u(\mathfrak{g})_R)$. Then $\mathbf{F}v_L = \mathbf{F}v_R$.

Proof. By assumption, $u(\mathfrak{g})$ is a supersymmetric superalgebra. Let f be the nondegenerate invariant bilinear form on $u(\mathfrak{g})$. The super symmetry of f implies that both v_L and v_R are in the right orthogonal complement of $u(\mathfrak{g})\mathfrak{g}$, which is 1-dimensional, so $v_L = v_R(up$ to a nonzero constant multiple).

Definition 5.10. [6, p.15] A derivation of degree $s \in \mathbb{Z}_2$ of a superalgebra A is an endomorphism $D \in End_sA$ with property

$$D(ab) = D(a)b + (-1)^{sp(a)}aD(b).$$

Let \mathfrak{g} be a Lie superalgebra. By the Jacobi identity, $ada: b \to [a, b]$ is a derivation of \mathfrak{g} .

Assume $\mathfrak{g}_{\bar{1}}$ has a basis u_1, \ldots, u_l . Then $U(\mathfrak{g}) = U(\mathfrak{g})_{\bar{0}} \oplus U(\mathfrak{g})_{\bar{1}}$ is naturally \mathbb{Z}_2 -graded, where

$$U(\mathfrak{g})_{\bar{0}} = \sum_{\substack{i_1 < \cdots < i_s \\ s \text{ is even}}} u_{i_1} \dots u_{i_s} U(\mathfrak{g}_{\bar{0}}), U(\mathfrak{g})_{\bar{1}} = \sum_{\substack{i_1 < \cdots < i_s \\ s \text{ is odd}}} u_{i_1} \dots u_{i_s} U(\mathfrak{g}_{\bar{0}}).$$

Generally, taking $x_1 x_2 \cdots x_k \in U(\mathfrak{g}), x_1, \ldots, x_k \in \mathfrak{g}_{\bar{0}} \cup \mathfrak{g}_{\bar{1}}$, it is easy to see that $p(x_1 \cdots x_k) = \sum_{i=1}^k p(x_i)$.

Let $a \in \mathfrak{g}_{\bar{0}} \cup \mathfrak{g}_{\bar{1}}$. We now extend *ada* to a derivation of $U(\mathfrak{g})$. Let $f \in U(\mathfrak{g})_{\theta}$, $\theta \in \mathbb{Z}_2$. We define

$$ada(f) = af - (-1)^{\mathbf{p}(a)\mathbf{p}(f)}fa.$$

Use induction we can show that

Lemma 5.11. Let $f = x_1 \cdots x_k \in U(\mathfrak{g})_{\theta}$, where $x_i \in \mathfrak{g}_{\bar{0}} \cup \mathfrak{g}_{\bar{1}}$. Then $ada(f) = \sum (-1)^{p(a)p(x_1 \cdots x_{i-1})} x_1 \cdots [a, x_i] x_{i+1} \cdots x_k.$

Recall I_{χ} for $\chi \in \mathfrak{g}^*$ given in Section 2. Let \mathfrak{g} be a restricted Lie superalgebra and let $a \in \mathfrak{g}_{\bar{0}} \cup \mathfrak{g}_{\bar{1}}$. For each generator $x^p - x^{[p]} - \chi(x)^p \cdot 1 \in U(\mathfrak{g})_{\bar{0}}$, it is easy to see that $ada(x^p - x^{[p]} - \chi(x)^p \cdot 1) = 0$. This induces a derivation on $u(\mathfrak{g}, \chi)$. We denote it also by *ada*. Note that I_{χ} is generated by elements in $U(\mathfrak{g})_{\bar{0}}$. Then $u(\mathfrak{g}, \chi)$ inherits the $Z_2 - gradation$ from that of $U(\mathfrak{g})$, and Lemma 5.11 also holds in $u(\mathfrak{g}, \chi)$.

5.2 The Kac-weisfeiler Theorem

The **F**-vector space gl(m+n) has a structure of the Lie superalgebra $\mathfrak{g} = gl(m|n)$, and also a structure of Lie algebra gl(m+n). The two structures share the same cartan subalgebra $H = \langle e_{ii} | i = 1, ..., m+n \rangle$ and the corresponding root space decomposition.

Let $\mathfrak{g} = gl(m|n)$. Then $\mathfrak{g}_{\bar{0}} = gl(m) \oplus gl(n)$ and $\mathfrak{g} = H + \oplus \mathfrak{g}_{\alpha}$, where $\mathfrak{g}_{\alpha} = \mathbf{F}e_{ij}$, $1 \leq i, j \leq m + n$. With respect to H, the root system of \mathfrak{g} is given in [6, p.51].

If we write $\epsilon_{m+1} = \delta_1, \ldots, \epsilon_{m+n} = \delta_n$, where $\epsilon_i(e_{jj}) = \delta_{ij}$, then the root system of gl(m|n) coincides with that of gl(m+n) (denoted by Φ), and each simple root system of gl(m|n) coincides with that of gl(m+n).

For $\alpha \in \Phi^+$, we use $e_{\alpha}(\text{resp.}, f_{\alpha})$ to denote the positive(resp., negative) root vector. i.e., $\mathfrak{g}_{\alpha} = \mathbf{F} e_{\alpha}(\text{resp.}, \mathfrak{g}_{-\alpha} = \mathbf{F} f_{\alpha})$.

If we use $[,]_s$ momentarily to denote the Lie product in gl(m|n), then we see that

$$(*) \qquad [e_{\alpha_i}, e_{\alpha_j}]_s = \pm [e_{\alpha_i}, e_{\alpha_j}], [f_{\alpha_i}, f_{\alpha_j}]_s = \pm [f_{\alpha_i}, f_{\alpha_j}], \\ [e_{\alpha_i}, f_{\alpha_j}]_s = \pm [e_{\alpha_i}, f_{\alpha_j}] \quad \text{for} \quad \alpha_i \neq \alpha_j.$$

For each positive root $\alpha \in \Phi_1^+$, we define $s_{\alpha}(\beta) =: \tau_{\alpha}(\beta), \beta \in \Phi$, where τ_{α} is the reflection defined in the root system of gl(m+n). The definition of s_{α} is justified by the next lemma.

Lemma 5.12. $s_{\alpha}(\Phi^+)$ is a positive root system of gl(m|n) with the simple root system $s_{\alpha}(\Delta)$.

Proof. Since $\tau_{\alpha}(\Phi^+)$ is a positive root system of gl(m+n) with simple roots $\tau_{\alpha}(\Delta)$, $\tau_{\alpha}(\Delta)$ is a minimal subset of $\tau_{\alpha}(\Phi^+)$ satisfying

(1) $\{e_{\gamma}|\gamma \in \tau_{\alpha}(\Delta)\}$ generates $\{e_{\gamma}|\gamma \in \tau_{\alpha}(\Phi^{+})\}, \{f_{\gamma}|\gamma \in \tau_{\alpha}(\Delta)\}$ generates $\{f_{\gamma}|\gamma \in \tau_{\alpha}(\Phi^{+})\}.$

- (2) $\{e_{\gamma}, f_{\gamma} | \gamma \in \tau_{\alpha}(\Delta)\}$ generates gl(m+n).
- (3) $[e_{\gamma}, f_{\beta}] = \delta_{\gamma,\beta} h \in H, \ \gamma, \beta \in \tau_{\alpha}(\Delta).$

Note that

(**)
$$[h, e_{\gamma}]_s = [h, e_{\gamma}] = \gamma(h)e_{\gamma}$$
, for every $h \in H$.

So each e_{γ} above is also a root vector in the Lie superalgebra gl(m|n). Then (*) says that $\{e_{\gamma}|\gamma \in \tau_{\alpha}(\Delta)\}$ is the set of root vectors of a simple root system $\tilde{\Delta}$ of $\mathfrak{g} = gl(m|n)$, and $\{e_{\gamma}|\gamma \in \tau_{\alpha}(\Phi^{+})\}$ is the set of root vectors of the corresponding positive root system $\tilde{\Phi}^{+}$.

By (**), we have $\tilde{\Delta} = \tau_{\alpha}(\Delta)$ and $\tilde{\Phi}^+ = \tau_{\alpha}(\Phi^+)$; that is, $\tau_{\alpha}(\Phi^+)$ is a positive root system of gl(m|n) with the simple root system $\tau_{\alpha}(\Delta)$.

Lemma 5.13. Let $I = I_{\bar{0}} \oplus I_{\bar{1}}$ be a restricted ideal of a subalgebra \mathfrak{g}' of the Lie superalgebra \mathfrak{g} . Assume $\chi(I) = 0$ and $u(I) \subseteq u(\mathfrak{g}', \chi)$ be the reduced enveloping algebra of I. Let $\mathbf{F}v_L$ be the unique 1-dimensional trivial submodule of u(I). Suppose $v_L = x_1^{i_1} \dots x_m^{i_m}$, where $x_k^{i_k} \in I_{i_k}$ for each $i_k \in \mathbb{Z}_2$. Then for every homogeneous $a \in \mathfrak{g}'$, $ada(v_L) = \lambda v_L$ for some $\lambda \in \mathbf{F}$. If ada is nilpotent, then $\lambda = 0$.

Proof. Let $x \in I$ be homogeneous. Then

$$xada(v_L) = x(av_L - (-1)^{p(v_L)}v_La)$$
$$= [x, a]v_L + (-1)^{p(x)p(a)}axv_L - (-1)^{p(v_L)}xv_La = 0.$$

Therefore $ada(v_L) = \lambda v_L$ for some $\lambda \in \mathbf{F}$.

Note that if $\mathfrak{g} = \mathfrak{g}_{\bar{0}}$, the lemma recovers [3, Lemma 8.3].

Let $\chi \in \mathfrak{g}_{\bar{0}}^*$. Without loss of generality we assume χ vanishes on $N^+ = \sum_{\alpha>0} \mathfrak{g}_{\alpha}$. Let $\chi = \chi_s + \chi_n$, where χ_s is the semisimple part and χ_n is the nilpotent part. Let

$$\mathfrak{l}' = C_{\mathfrak{g}}(\chi_s) = \{ x \in \mathfrak{g} | \chi_s([x, -]) = 0 \}.$$

Then we get

$$\mathfrak{l}' = H \oplus \sum_{\chi(h_{\alpha})=0} \mathfrak{g}_{\alpha}.$$

Let $\mathfrak{l} = [\mathfrak{l}', \mathfrak{l}']$ and let $\mathfrak{B} = H + N^+$. $\mathfrak{P} = \mathfrak{B} + \mathfrak{l}$ is a parabolic subalgebra of \mathfrak{g} . First we take the natural root system of \mathfrak{g} with the simple roots

$$\Delta = \{\epsilon_1 - \epsilon_2, \dots, \epsilon_m - \delta_1, \dots, \delta_{n-1} - \delta_n\}.$$

Then $\mathfrak{N} = \sum_{\chi(h_{\alpha})\neq 0, \alpha>0} \mathfrak{g}_{\alpha}$ is the nilradical of \mathfrak{P} . Let $\mathfrak{N} = \mathfrak{N}_{\bar{0}} \oplus \mathfrak{N}_{\bar{1}}$, where

$$\mathfrak{N}_{\overline{i}} = \sum_{\chi(h_{lpha})
eq 0, lpha \in \Phi^+_{\overline{i}}} \mathfrak{g}_{lpha}, \overline{i} \in \mathbf{Z}_2$$

Let $\Phi_{\mathfrak{l}}$ be the root system of \mathfrak{l} . Denote $\Phi' = \{\alpha \in \Phi^+ | \chi(h_\alpha) \neq 0\}$. By [8, p. 140], $\chi(e_\alpha) = 0$ for every $\alpha \in \Phi^+ \cup -\Phi'$.

Lemma 5.14. ([15],[3]) There is an order of the roots in Φ' : $\Phi' = \{\alpha_1, \alpha_2, \ldots, \alpha_s\}$ such that if $\Phi_1^+ = \Phi^+$, $\Delta_1 = \Delta$. $\Phi_{i+1}^+ = s_{\alpha_i}(\Phi_i^+)$ and $\Delta_{i+1} = s_{\alpha_i}(\Delta_i)$. Then

(1) Φ_i^+ is a system of positive roots in Φ with simple roots Δ_i and $\alpha_i \in \Delta_i$.

(2) For each $i \leq s$, $\{-\alpha_1, -\alpha_2, \ldots, -\alpha_i\}$ is a closed subsystem normalized by Φ_1^+ .

Proof. Now that s_{α} is defined for $\alpha \in \Phi_1$, the proof in [15] and [3] also works here. We give here only a χ -related proof to the first part. We treat χ as a linear function of \mathfrak{g} with $\chi(\mathfrak{g}_{\bar{1}}) = 0$. Note that we can assume $\mathfrak{g} = sl(m|n)$ for this lemma.

Suppose $\Delta \cap \Phi' = \phi$. Then we have $\Delta \subseteq \Phi_{\mathfrak{l}}$. Since $\Phi_{\mathfrak{l}}$ is a closed root system and $H \subseteq [\mathfrak{g}, \mathfrak{g}]$, we get $\chi(H) = 0$. Thus, χ is nilpotent and the case being trivial.

Taking $\alpha_1 \in \Delta \cap \Phi'$, we let $\Delta_2 = s_{\alpha_1}(\Delta_1)$ and $\Phi_2^+ = s_{\alpha_1}(\Phi_1^+)$. Note that $s_{\alpha_i}(\Phi') \subseteq \Phi'$. Using a similar argument as above, we can find $\alpha_2 \in \Delta_2 \cap \Phi'$. We continue this process. Suppose there is i < j such that $\alpha_i = \alpha_j$. Then since $-\alpha_i \in \Phi_j^+$ and $\alpha_j \in \Delta_j \in \Phi_j^+$, we get a contradiction. Therefore Φ' can be ordered as required.

Let $\Phi' = \{\alpha_1, \ldots, \alpha_s\}$ be in the order as above. As in [3], we let $F_i = \langle f_{\alpha_1}, \ldots, f_{\alpha_i} \rangle$. Then since $\{\alpha_1, \ldots, \alpha_i\}$ is closed, F_i is a subalgebra of \mathfrak{g} . Since $\chi(F_i) = 0, u(F_i) = u(F_i, \chi) \subseteq u(\mathfrak{g}, \chi)$.

Theorem 5.15. Let $M = M_{\overline{0}} \oplus M_{\overline{1}}$ be a simple $u(\mathfrak{g}, \chi)$ -module and $M' \subseteq M$ a \mathbb{Z}_2 -graded simple $u(\mathfrak{P}, \chi)$ -submodule. Then $M \cong u(\mathfrak{g}, \chi) \otimes_{u(\mathfrak{P}, \chi)} M'$. In particular, we have

$$dim M = p^{dim\mathfrak{N}_{\bar{0}}} 2^{dim\mathfrak{N}_{\bar{1}}} dim M'.$$

Proof. Let \mathfrak{B}_i denote the Borel subalgebra of \mathfrak{g} with respect to Δ_i and $\mathfrak{P}_i = \mathfrak{B}_i + \mathbf{F}_{\alpha_i}$. Denote $\mathfrak{N}_i = \bigoplus_{\alpha \in \Phi_i^+, \alpha \neq \alpha_i} \mathfrak{g}_{\alpha}$. Then \mathfrak{N}_i is the nilradical of \mathfrak{P}_i . Since M is simple, M is the quotient of $W = u(\mathfrak{g}, \chi) \otimes_{u(\mathfrak{P}, \chi)} M'$. Note that $\mathfrak{B}_{i+1} \subset \mathfrak{P}_i$.

We define an increasing filtration of W:

$$W_1 = 1 \otimes M', W_{i+1} = u(\mathfrak{P}_i, \chi) \otimes_{u(\mathfrak{P}_i, \chi)} W_i, i = 1, \dots, s.$$

Clearly we have $W_{s+1} = W$.

Let W' be a simple $u(\mathfrak{g}, \chi)$ -submodule of W and choose i minimal such that $W' \cap W_{i+1} \neq 0$.

Suppose i > 0. We shall derive a contradiction. We first show that

(1)
$$W_{i+1}^{\mathfrak{N}_i} = (u(\mathfrak{P}_i, \chi) \otimes_{u(\mathfrak{B}_i, \chi)} W_i)^{\mathfrak{N}_i} = u(\mathfrak{P}_i, \chi) \otimes_{u(\mathfrak{B}_i, \chi)} W_i^{\mathfrak{N}_i}.$$

For each root α of \mathfrak{N}_i , we have $[e_\alpha, f_{\alpha_i}] \in \mathfrak{N}_i$, since \mathfrak{N}_i is the nilradical of \mathfrak{P}_i . Let

$$x = \sum_{0 \le j \le \bar{p}-1} f_{\alpha_i}^j \otimes x_j \in W_{i+1}^{\mathfrak{N}_i}.$$

Then we obtain $f_{\alpha_i}^k x \in W_{i+1}^{\mathfrak{N}_i}$ for every $0 \le k \le \overline{p} - 1$.

Assume $\alpha_i \in \Phi_0^+$. Since $\chi(f_{\alpha_i}) = 0$, so that $f_{\alpha_i}^p = 0$ in $u(\mathfrak{g}, \chi)$, we have

$$f_{\alpha_j}^k x = \sum_{0 \le j \le p-1-k} f_{\alpha_i}^{j+k} \otimes x_j, 0 \le k \le p-1.$$

Assume $\alpha_i \in \Phi_1^+$. Since $f_{\alpha_i}^2 = 0$ in $u(\mathfrak{g}, \chi)$ (also in $U(\mathfrak{g})$), we have

$$f_{\alpha_j}^k x = \sum_{0 \le j \le 1-k} f_{\alpha_i}^{j+k} \otimes x_j$$

for k = 0, 1.

Hence we have, for any $\alpha_i \in \Phi^+$,

$$f_{\alpha_j}^k x = \sum_{0 \le j \le \bar{p} - 1 - k} f_{\alpha_i}^{j+k} \otimes x_j$$

for $0 \leq k \leq \overline{p} - 1$, and $f_{\alpha_i}^{\overline{p}} x = 0$.

We use induction on k to prove that $x_k \in W_i^{\mathfrak{N}_i}$. For k = 0, take an arbitrary $y \in \mathfrak{N}_i$. Since $[f_{\alpha_i}, y] \in \mathfrak{N}_i \subseteq \mathfrak{B}_i$, we get

$$0 = y f_{\alpha_i}^{\bar{p}-1} x = y f_{\alpha_i}^{\bar{p}-1} \otimes x_0 = f_{\alpha_i}^{\bar{p}-1} \otimes y x_0 + \sum_{l < \bar{p}-1} f_{\alpha_i}^l \otimes w_l', w_l' \in W_i.$$

This gives us $yx_0 = 0$ and hence $x_0 \in W_i^{\mathfrak{N}_i}$.

Assume $x_k \in W_i^{\mathfrak{N}_i}$ for all $k < m \leq \overline{p} - 1$, and consider the case k = m. For any $y \in \mathfrak{N}_i$, we have

$$0 = y f_{\alpha_i}^{\bar{p}-1-m} x = y \sum_{0 \le k \le m} f_{\alpha_i}^{\bar{p}-1-m+k} \otimes x_k.$$

Then we get

$$f_{\alpha_i}^{\bar{p}-1} \otimes yx_m + \sum_{l < \bar{p}-1} f_{\alpha_i}^l \otimes w_l' = 0, w_l' \in W_i.$$

This gives us $yx_m = 0$, so that $x_m \in W_i^{\mathfrak{N}_i}$. Hence $x \in u(\mathfrak{P}_i, \chi) \otimes_{u(\mathfrak{P}_i, \chi)} W_i^{\mathfrak{N}_i}$.

Let $F_i = (F_i)_{\bar{0}} \oplus (F_i)_{\bar{1}}$. Since $(F_i)_{\bar{0}}^{[p]} = 0$ and $\chi(F_i) = 0$, $u(F_i) \subseteq u(\mathfrak{g}, \chi)$ is supersymmetric.

Let $\mathbf{F}v_L$ be the unique 1-dimensional trivial submodule in the left regular module $u(F_{i-1})$. We may assume that $v_L = f_{\alpha_{j_1}}^{\bar{p}-1} \dots f_{\alpha_{j_{i-1}}}^{\bar{p}-1}$, where $\alpha_{j_1}, \dots, \alpha_{j_{i-1}}$ is the set $\alpha_1, \dots, \alpha_{i-1}$ put in the order of ascending heights. By Lemma 5.9, $v_R = v_L$.

By definition, W_i is a free $u(F_{i-1})$ -module. In particular, as a $u(F_{i-1})$ -submodule,

 $W_i \cong u(F_{i-1}) \otimes_{\mathbf{F}} W_1$ (canonically imbedded in $u(\mathfrak{P}, \chi) \otimes_{u(\mathfrak{B}, \chi)} W_1$).

Then the fact $v_L = v_R$ shows that

$$W_i^{F_{i-1}} = v_L \otimes W_1$$

Since $F_{i-1} \subseteq \mathfrak{N}_i, W_i^{\mathfrak{N}_i} \subseteq W_i^{F_{i-1}}$. It follows that $W_i^{\mathfrak{N}_i} \subseteq (v_L \otimes W_1)^{\mathfrak{N}_i}$.

For any $\alpha \in \Phi_{\mathfrak{l}}^+$ and $w_1 \in W_1$, if $e_{\alpha}v_L \otimes w_1 = 0$, then we get $v_L \otimes e_{\alpha}w_1 = 0$ by Lemma 5.11. Hence $e_{\alpha}w_1 = 0$. Since $\mathfrak{N} = \sum_{\alpha \in \Phi'} \mathfrak{g}_{\alpha}$ is the nilradical of \mathfrak{P} and $\chi(\mathfrak{N}) = 0$, Lemma 2.1(2) shows that $\mathfrak{N}W_1 = 0$. Note that $\mathfrak{N}_1 \subseteq \bigoplus_{\alpha \in \Phi_{\mathfrak{l}}^+} \mathfrak{g}_{\alpha} + \mathfrak{N}$. So we get $\mathfrak{N}_1 w_1 = 0$. This gives us

$$W_i^{\mathfrak{N}_i} \subseteq v_L \otimes W_1^{\mathfrak{N}_1}$$

Since \mathfrak{N}_i is an ideal of \mathfrak{B}_i and $e_{\alpha_i} \in \mathfrak{B}_i$, $e_{\alpha_i} W_i^{\mathfrak{N}_i} \subseteq W_i^{\mathfrak{N}_i}$. Thus we get

$$e_{\alpha_i} W_i^{\mathfrak{N}_i} \subseteq W_i^{\mathfrak{N}_i} \cap e_{\alpha_i} v_L \otimes W_1^{\mathfrak{N}_1}$$

It follows that

$$e_{\alpha_{i}}W_{i}^{\mathfrak{N}_{i}} \subseteq v_{L} \otimes W_{1}^{\mathfrak{N}_{1}} \cap e_{\alpha_{i}}v_{L} \otimes W_{1}^{\mathfrak{N}_{1}}$$
$$= v_{L} \otimes W_{1}^{\mathfrak{N}_{1}} \cap (v_{L} \otimes e_{\alpha_{i}}W_{1}^{\mathfrak{N}_{1}} + [e_{\alpha_{i}}, v_{L}] \otimes W_{1}^{\mathfrak{N}_{1}})$$
$$= v_{L} \otimes W_{1}^{\mathfrak{N}_{1}} \cap [e_{\alpha_{i}}, v_{L}] \otimes W_{1}^{\mathfrak{N}_{1}}.$$

By Lemma 5.12(2), $\bar{P}_{i-1} =: \mathfrak{B} + F_{i-1}$ is a parabolic subalgebra of \mathfrak{g} . Clearly e_{α_i} is in the nilradical of \bar{P}_{i-1} : $\bar{N}_{i-1} = \bigoplus_{\alpha \in \Phi_i^+} \mathfrak{g}_{\alpha} + \langle e_{\alpha_i}, \ldots, e_{\alpha_s} \rangle$. Therefore, we have $[e_{\alpha_i}, f_{\alpha_j}] \in \bar{N}_{i-1} \subseteq \mathfrak{B}$ for each j < i. It follows that

$$[e_{\alpha_i}, v_L] \otimes W_1 \subseteq \sum_{l_k < \bar{p} - 1 \text{ for some } k} e_{\alpha_{j_1}}^{l_1} \cdots e_{\alpha_{j_{i-1}}}^{l_{i-1}} \otimes W_1.$$

Then we get $e_{\alpha_i} W_i^{\mathfrak{N}_i} = 0.$

We shall now prove that

(2)
$$(u(\mathfrak{P}_i,\chi)\otimes_{u(\mathfrak{P}_i,\chi)}W_i^{\mathfrak{N}_i})^{e_{\alpha_i}}=1\otimes W_i^{\mathfrak{N}_i}$$

Let

$$x = \sum_{0 \le k \le \bar{p}-1} f_{\alpha_i}^k \otimes w_k \in (u(\mathfrak{P}_i, \chi) \otimes_{u(\mathfrak{P}_i, \chi)} W_i^{\mathfrak{N}_i})^{e_{\alpha_i}}$$

Then we get

$$0 = e_{\alpha_i} \sum_{0 \le k \le \bar{p}-1} f_{\alpha_i}^k \otimes w_k$$
$$= \sum_{1 \le k \le \bar{p}-1} [e_{\alpha_i}, f_{\alpha_i}^k] \otimes w_k$$
$$= -\sum_{1 \le k \le \bar{p}-1} 2k f_{\alpha_i}^{k-1} \otimes (k-1-h_{\alpha_i}) w_k.$$

This gives

 $(k-1-h_{\alpha_i})w_k = 0 \text{ for } 1 \le k \le \bar{p}-1.$

i.e., $h_{\alpha_i}w_k = (k-1)w_k$. It follows that

$$\chi(h_{\alpha_i})^p w_k = (h_{\alpha_i}^p - h_{\alpha_i}) w_k = 0, 0 \le k \le \bar{p} - 1.$$

So we obtain $w_k = 0, 1 \le k \le \overline{p} - 1$ and hence $x = 1 \otimes w_0 \in W_i^{\mathfrak{n}_i}$.

From (1) and (2), we get

$$0 \neq ((W' \cap W_{i+1})^{\mathfrak{N}_i})^{e_{\alpha_i}} \subseteq (u(\mathfrak{P}_i, \chi) \otimes_{u(\mathfrak{B}_i)} W_i^{\mathfrak{N}_i})^{e_{\alpha_i}} = 1 \otimes W_i^{\mathfrak{N}_i}.$$

This implies that $W' \cap W_i \neq 0$, a contradiction.

Then we must have $W' \cap (1 \otimes W_1) \neq 0$, and hence W' = W. Therefore W is a simple $u(\mathfrak{g}, \chi)$ -module, so that $M \cong W$.

Since \mathfrak{N} is the nilradical of \mathfrak{P} with $\chi(\mathfrak{N}) = 0$, Lemma 2.1(2) shows that each simple $u(\mathfrak{P}, \chi)$ -module is a simple $u(\mathfrak{l}', \chi)$ -module and vice versa. So M' is a simple $u(\mathfrak{l}', \chi)$ -module. Let $\mathfrak{l}' = \mathfrak{l} \oplus H'$, where $H' \subseteq H$ and $[H', \mathfrak{l}'] = 0$. Using the fact that $H' \subseteq \mathfrak{g}_{\bar{0}}$, Schur's Lemma ([6, p.18]) shows that H' acts as scalar multiplications on M'. Thus, M' is a simple $u(\mathfrak{l}, \chi)$ -module. Note that $\chi|_{\mathfrak{l}}$ is nilpotent. \Box

5.3 Standard Levi form

The study of the simple $u(\mathfrak{g}, \chi)$ -modules is now reduced to the case where χ is nilpotent. Let \mathfrak{B} be a Borel subalgebra of \mathfrak{g} .

Definition 5.16. We say that χ has standard Levi form if $\chi(\mathfrak{B}) = 0$ and there is a subset $I \subseteq \Delta_0$ such that

$$\chi(f_{\alpha}) \begin{cases} \neq 0 & \text{if } \alpha \in I, \\ = 0 & \text{if } \alpha \in \Phi \setminus I. \end{cases}$$

Proposition 5.17. If χ is in the standard Levi form, then each $Z^{\chi}(\lambda)$ has a unique maximal submodule.

The proof is similar to that of [5, Prop. 10.2].

Each nilpotent p-character is conjugate under G to the standard Levi form. Let χ be in the standard Levi form and let I be the set of simple roots as above. For each $\alpha \in I$, let $\lambda(h_{\alpha}) = a$. Then since $\lambda(h_{\alpha})^p - \lambda(h_{\alpha}) = 0$, we get $a \in \mathbf{F}_p$. Write $0 \leq a \leq p-1$. Then it is easy to see that $f_{\alpha}^{a+1}v$ is another maximal vector in $Z^{\chi}(\lambda)$ with weight $\lambda - (a+1)\alpha$. So we get

$$Z^{\chi}(\lambda - (a+1)\alpha) \cong Z^{\chi}(\lambda).$$

Recall ρ defined earlier. We define the dot action of $w \in W$ on H^* by

$$w \cdot \lambda = w(\lambda + \rho) - \rho.$$

If $\alpha \in \Delta_0$ is simple, then we have

$$s_{\alpha} \cdot \lambda = \lambda - (\lambda(h_{\alpha}) + 1)\alpha.$$

Denote W_I the subgroup of W generated by the reflections of s_{α} with $\alpha \in I$. Let $L^{\chi}(\lambda)$ be the unique simple quotient of $Z^{\chi}(\lambda)$.

Corollary 5.18. Let $w \in W_I$, then

(1) $Z^{\chi}(w \cdot \lambda) \cong Z^{\chi}(\lambda).$ (2) $L^{\chi}(w \cdot \lambda) \cong L^{\chi}(\lambda).$
