CONVEXITY OF HESSIAN INTEGRALS AND POINCARÉ TYPE INEQUALITIES

1. Introduction

Through out this paper, k will be a fixed integer such that $0 \le k \le n$. For $\lambda \in \mathbb{R}^n$, let $S_k(\lambda)$ be the normalized k^{th} elementary symmetric function of λ , i.e.

$$S_k(\lambda_1, \cdots, \lambda_n) = \frac{k!(n-k)!}{n!} \sum_{i_1 < i_2 < \cdots < i_k} \lambda_{i_1} \cdots \lambda_{i_k}.$$

Let $\mathcal{H}(n)$ denote the space of Hermitian matrices of size n. For $A \in \mathcal{H}(n)$, denote $\lambda(A) \in \mathbb{R}^n$ the eigenvalue of A and

$$S_k(A) = S_k(\lambda(A)).$$

Even though we use S_k to denote functions defined on both \mathbb{R}^n and $\mathcal{H}(n)$, its meaning should be clear from the context. In either case, we use \tilde{S}_k to denote the complete polarization of S_k . Let

$$\Gamma_k = \{ \lambda \in \mathbb{R}^n \mid S_j(\lambda) \ge 0, j = 1, \cdots, k \}$$

be the k-positive cone in \mathbb{R}^n

Let Ω be a smooth bounded domain in \mathbb{C}^n . For real valued function $u \in \mathcal{C}^2(\Omega)$, we define the complex k-Hessian of u by

$$H_k[u] = S_k(\operatorname{Hess}_{\mathbb{C}}(u))$$

where $\operatorname{Hess}_{\mathbb{C}}(u)$ is the complex Hessian matrix of u. Let

$$\mathcal{P}_k(\Omega) = \{ u \in \mathcal{C}^2(\bar{\Omega}) \mid \lambda \big(\operatorname{Hess}_{\mathbb{C}}(u) \big) \in \Gamma_k \}$$

be the space of k-plurisubharmonic (k-psh) function, and $\mathcal{P}_k^0(\Omega)$ be the subspace of $\mathcal{P}_k(\Omega)$ containing functions vanishing on $\partial\Omega$. It is well known that for $v_j \in \mathcal{P}_k(\Omega), j = 1, \dots, k$,

$$\tilde{H}_k[v_1, \cdots, v_k] = \tilde{S}_k\Big(\operatorname{Hess}_{\mathbb{C}}(v_1)\Big), \cdots, \lambda\Big(\operatorname{Hess}_{\mathbb{C}}(v_k)\Big) \ge 0,$$

For $u, u_0, \dots, u_k \in C^2(\bar{\Omega})$, denote

$$F_k[u_0, \dots, u_k] = \int_{\Omega} (-u_0) \tilde{H}_k[u_1, \dots, u_k]$$
 and $I_k[u] = F_k[u, \dots, u] = \int_{\Omega} (-u) H_k[u].$

Theorem 1. Notation as above

(a) For any $u_0, \dots, u_k \in \mathcal{P}_k^0(\Omega)$,

$$F_k[u_0, \cdots, u_k] \le \prod_{j=0}^k \left(I_k[u_j] \right)^{\frac{1}{k+1}}.$$
 (1)

(b) For fixed $0 \le m < k$, and fixed $v_1, \dots, v_m \in \mathcal{P}_k(\Omega)$, consider the functional

$$\mathcal{P}_k^0(\Omega) \ni u \mapsto I_{k,v_1,\dots,v_m}[u] = \int_{\Omega} (-u)\tilde{H}_k[u,\dots,u,v_1,\dots,v_m].$$

Then $I_{k,v_1,\cdots,v_m}^{1/(k-m+1)}$ is convex on \mathcal{P}_0^k in the sense that for any $u,v\in\mathcal{P}_k^0(\Omega)$,

$$I_{k,v_1,\cdots,v_m}^{\frac{1}{k-m+1}}[u+v] \leq I_{k,v_1,\cdots,v_m}^{\frac{1}{k-m+1}}[u] + I_{k,v_1,\cdots,v_m}^{\frac{1}{k-m+1}}[v]. \tag{2}$$

A smooth bounded domain Ω is strong k-pseudoconvex, if $\partial\Omega$ is connected, and the $(k-1)^{\text{th}}$ elementary function of the eigenvalues of the Levi form of $\partial\Omega$ is strictly positive on $\partial\Omega$. For strong k-pseudoconvex domain, we have following Poincaré type inequalities.

Theorem 2. Suppose Ω is strong k-pseudoconvex, then for $0 \leq m < k$, there exists constant C such that for any $u \in \mathcal{P}^0_{\nu}(\Omega)$

$$\left(I_m[u]\right)^{\frac{1}{m+1}} \le C\left(I_k[u]\right)^{\frac{1}{k+1}},\tag{3}$$

where the constant C depends on m, k and Ω only.

Some special cases of Theorem 1 were well known. For example Cegrell and Persson proved in [CP97] that if both u and v are psh function on a domain with vanishing boundary data, then for integer j such that $0 \le j \le n$,

$$\int_{\Omega} (-u)(dd^{c}u)^{j}(dd^{c}v)^{n-j} \leq \left(\int_{\Omega} (-u)(dd^{c}u)^{n}\right)^{\frac{j+1}{n+1}} \left(\int_{\Omega} (-v)(dd^{c}v)^{n}\right)^{\frac{n-j}{n+1}},$$

which is just special case of equation (1) with $u_0 = \cdots = u_j = u$ and $u_{j+1} = \cdots = u_k = v$.

Since the proof of Theorem 1 only uses the divergence structure of Hessian operator H_k , so it can also be applied to the study of real Hessian operator and integrals. Let D be a smooth bounded domain in \mathbb{R}^n . For real valued function $u_j \in \mathcal{C}^2(\bar{D}), j = 0, 1, \dots, k$ and $u \in \mathcal{C}^2(\bar{\Omega})$ define

$$G_k[u_0, \cdots, u_k] = \int_D (-u_0) \tilde{S}_k[\operatorname{Hess}(u_1), \cdots, \operatorname{Hess}(u_k)]$$

and

$$J_k[u] = G_k[u, \cdots, u],$$

where Hess(u) is the Hessian matrix of u.

Theorem 3. For any k-convex function u_0, \dots, u_k with $u_0 = \dots = u_k = 0$ on ∂D ,

$$G_k[u_0, \cdots, u_k] \le \prod_{j=0}^n \left(J_k[u_j]\right)^{\frac{1}{k+1}}.$$
 (4)

Theorem 4. Suppose D is smooth bounded domain in \mathbb{R}^n such that $S_{k-1}(II) > 0$ on ∂D , where II is the second fundamental form of ∂D , then for integer m with $0 \le m < k$, there exists constant C depends on m, k and D such that

$$\left(J_m[u]\right)^{\frac{1}{m+1}} \le C\left(J_k[u]\right)^{\frac{1}{k+1}} \tag{5}$$

for any k-convex function u with u = 0 on ∂D .

Theorem 4 was originally proved by Trudinger and Wang in [TW98] using parabolic method. Compared with the proof in [TW98], our proof is quicker and more elementary, and can be adopted to study the complex Hessian integral. However, Trudinger and Wang's proof contains more information, they showed that the best constant C in equation (5) is attained by the solution of the Dirichlet problem: $H_k[u] = H_m[u]$ and u = 0 on ∂D .

Hessian integrals like J_k were first studied by Bakelman [Bak83] and Tso [Tso90] in the setting of real Monge-Ampère-operator. In [Wan94], Wang studied the real Hessian integrals for general k and established some Sobolev type inequalities. For more information on real Hessian integral, see [Wan09] and the references therein.

For simplicity, we always assume that the functions studied in this paper are at least twice differentiable. Using the standard approximation technique, it is possible to extend the result to the case of real and complex Hessian measure for non-smooth functions, see [TW02, Blo05] for more details.

2. Complex Hessian Integrals

Let ω is the Kähler form of the standard Euclidean metric of \mathbb{C}^n , i.e.

$$\omega = \sqrt{-1} \sum_{j=1}^{n} dz^{j} \wedge d\bar{z}^{j}.$$

It is easy to check that for $u, u_0, \dots, u_k \in \mathcal{P}_k(\Omega)$,

$$H_k[u]\omega^n = (\sqrt{-1}\partial\bar{\partial}u)^k \wedge \omega^{n-k}$$

and

$$\tilde{H}_k[u_1,\cdots,u_k]\omega^n = (\sqrt{-1}\partial\bar{\partial}u_1)\wedge\cdots\wedge(\sqrt{-1}\partial\bar{\partial}u_k)\wedge\omega^{n-k}.$$

Hence

$$I_k[u] = \int_{\Omega} (-u)(\sqrt{-1}\partial\bar{\partial}u)^k \wedge \omega^{n-k}$$

and

$$F_k[u_0, \cdots, u_k] = \int_{\Omega} (-u_0)(\sqrt{-1}\partial\bar{\partial}u_1) \wedge \cdots \wedge (\sqrt{-1}\partial\bar{\partial}u_k) \wedge \omega^{n-k}.$$
 (6)

Obviously the F_k in equation 6 is symmetric in u_1, \dots, u_k . If $u_j \in \mathcal{P}_k^0(\Omega), j = 0, \dots, k$, then by integration by part,

$$F_{k}[u_{0}, \cdots, u_{k}] = \int_{\Omega} \sqrt{-1} \partial u_{0} \wedge \bar{\partial} u_{1} \wedge \cdots \wedge (\sqrt{-1} \partial \bar{\partial} u_{k}) \wedge \omega^{n-k}$$

$$= \int_{\Omega} (-u_{1})(\sqrt{-1} \partial \bar{\partial} u_{0}) \wedge \cdots \wedge (\sqrt{-1} \partial \bar{\partial} u_{k}) \wedge \omega^{n-k} = F_{k}[u_{1}, u_{0}, \cdots, u_{k}]$$

Therefore $F_k[u_0, \dots, u_k]$ is symmetric in its arguments if they are in $\mathcal{P}_k^0(\Omega)$.

Lemma 5. For any $u_0, u_1 \in \mathcal{P}_k^0(\Omega)$ and any $v_2, \dots, v_k \in \mathcal{P}_k(\Omega)$,

$$F_k[u_0, u_1, v_2, \cdots, v_k]^2 \le F_k[u_0, u_0, v_2, \cdots, v_k] F_k[u_1, u_1, v_2, \cdots, v_k]. \tag{7}$$

Proof. For $t \in \mathbb{R}$, consider the quadratic function

$$q(t) = F_k[u_0 + tu_1, u_0 + tu_1, v_2, \cdots, v_k]$$

= $F[u_1, u_1, v_2, \cdots, v_k] t^2 + 2F[u_0, u_1, v_2, \cdots, v_k] t + F[u_0, u_0, v_2, \cdots, v_k].$

Since

$$\begin{split} q(t) &= \int_{\Omega} -(u_0 + tu_1)(\sqrt{-1}\partial\bar{\partial}u_0 + tu_1) \wedge (\sqrt{-1}\partial\bar{\partial}v_2) \wedge (\sqrt{-1}ddbv_k) \wedge \omega^{n-k} \\ &= \int_{\Omega} \sqrt{-1}\partial(u_0 + tu_1) \wedge \bar{\partial}(u_0 + tu_1) \wedge (\sqrt{-1}\partial\bar{\partial}v_2) \wedge (\sqrt{-1}ddbv_k) \wedge \omega^{n-k} \\ &> 0. \end{split}$$

So

$$F_k[u_0, u_1, v_2, \cdots, v_k]^2 \le F_k[u_0, u_0, v_2, \cdots, v_k]F_k[u_1, u_1, v_2, \cdots, v_k].$$

With Lemma 5, both statements in Theorem 1 will follow from following well known algebraic lemma.

Lemma 6. Let S be a set and f be a non-negative symmetric function defined on $S^k = S \times \cdots \times S$. Assume that for any $x_1, \dots, x_k \in S$,

$$f(x_1, x_2, x_3, \dots, x_k)^2 \le f(x_1, x_1, x_3, \dots, x_k) f(x_2, x_2, x_3, \dots, x_k).$$

Then it follows

$$f(x_1, x_2, \dots, x_k)^k \le \prod_{j=1}^k f(x_j, \dots, x_j).$$

Moreover if S is a cone in some linear space, and f is linear in each of its argument, then

$$f(x+y,\dots,x+y)^{1/k} \le f(x,\dots,x)^{1/k} + f(y,\dots,y)^{1/k}$$

for any x and y in S.

Proof of this lemma can be found in [Hör94].

To prove Theorem 2, we need another simple algebraic lemma for symmetric functions.

Lemma 7. Let $\mu \in \Gamma_k \subset \mathbb{R}^n$ with $S_k(\mu) > 0$, then there exists C depending on $\operatorname{dist}(\mu, \partial \Gamma_k)$ only such that for positive integer m < k and $\forall \lambda \in \Gamma_k$

$$S_m(\lambda) \le C\tilde{S}_k(\lambda, \cdots, \lambda, \mu, \cdots, \mu),$$

where λ and μ appear m and k-m times in \tilde{S}_k respectively.

Proof. Since $S_k(\mu) > 0$, so μ is in the interior of Γ_k , therefore there exits $\varepsilon > 0$ such that

$$\mu - \varepsilon \mathbf{e} \in \Gamma_k$$
.

where $\mathbf{e} = (1, \dots, 1) \in \mathbb{R}^n$. Hence by the Gårding's Inequality

$$\tilde{S}_{k}^{\frac{1}{k-m}}(\lambda, \dots, \lambda, \mu, \dots, \mu) \ge \tilde{S}_{k}^{\frac{1}{k-m}}(\lambda, \dots, \lambda, \mu - \varepsilon \mathbf{e}, \dots, \mu - \varepsilon \mathbf{e}) + \tilde{S}_{k}^{\frac{1}{k-m}}(\lambda, \dots, \lambda, \varepsilon \mathbf{e}, \dots, \varepsilon \mathbf{e})
> \tilde{S}_{k}^{\frac{1}{k-m}}(\lambda, \dots, \lambda, \varepsilon \mathbf{e}, \dots, \varepsilon \mathbf{e}) = \varepsilon S_{m}^{\frac{1}{k-m}}(\lambda).$$
(8)

Therefore

$$S_m(\lambda) \leq \frac{1}{\varepsilon^{k-m}} \tilde{S}_k(\lambda, \dots, \lambda, \mu, \dots, \mu).$$

Proof of Theorem 2. Since Ω is strong k-pseudoconvex, it is known [Vin88, Li04] that there exists a unique $v \in \mathcal{P}_0^k(\Omega)$ such that $H_k[v] = 1$. Hence there exists $\varepsilon > 0$ depending on v only, such that $\operatorname{Hess}_{\mathbb{C}}(v) - \varepsilon I_n \in \Gamma_k \subset \mathcal{H}(n)$ pointwise in Ω , where I_n is the identity matrix of size n. Similar to the proof of Lemma 7, there exists C such that

$$H_m[u] = S_m[\operatorname{Hess}_{\mathbb{C}}(u)] \le C\tilde{S}_k[\operatorname{Hess}_{\mathbb{C}}(u), \cdots, \operatorname{Hess}_{\mathbb{C}}(u), \operatorname{Hess}_{\mathbb{C}}(v), \cdots, \operatorname{Hess}_{\mathbb{C}}(v)]$$

where $\operatorname{Hess}_{\mathbb{C}}(u)$ and $\operatorname{Hess}_{\mathbb{C}}(v)$ appear m and k-m times in \tilde{S}_k . Therefore

$$I_{m}[u] = \int_{\Omega} (-u)H_{m}[u]$$

$$\leq C \int_{\Omega} (-u)\tilde{S}_{k}[\operatorname{Hess}_{\mathbb{C}}(u), \cdots, \operatorname{Hess}_{\mathbb{C}}(u), \operatorname{Hess}_{\mathbb{C}}(v), \cdots, \operatorname{Hess}_{\mathbb{C}}(v)]$$

$$= CF_{k}[u, \cdots, u, v, \cdots, v]$$

$$\leq C(I_{k}[u])^{\frac{m+1}{k+1}} (I_{k}[v])^{\frac{1}{k+1}}.$$

So

$$\left(I_m[u]\right)^{\frac{1}{m+1}} \le \tilde{C}\left(I_k[u]\right)^{\frac{l+1}{k+1}}.$$

3. Real Hessian Integrals

To prove Theorem 3 and Theorem 4, we only need to show that the functional G_k is symmetric in its arguments when they vanish on the boundary and the analogous Lemma 5 for G_k . They both follow from the divergence structure of polarized real Hessian operator.

Let $A^{(j)}, j = 1, 2, \dots, n$ be symmetric n by n matrices, then the polarized symmetric function \tilde{S}_k is given by

$$\tilde{S}_k(A^{(1)}, \cdots, A^{(k)}) = \frac{1}{k!} \sum_{\substack{i_1, \dots, i_k \\ j_1, \dots, j_k}} \delta_{j_1 \dots j_k}^{i_1 \dots i_k} A_{i_1 j_1}^{(1)} \dots A_{i_k j_k}^{(k)}.$$

where $\delta_{j_1\cdots j_k}^{i_1\cdots i_k}$ is the generalized Kronecker delta symbol. Denote

$$\tilde{S}_{k-1}^{ij}(A^{(1)}, \cdots, A^{(k-1)}) = \frac{\partial}{\partial A_{ij}^{(k)}} \tilde{S}_k(A^{(1)}, \cdots, A^{(k)}),$$

then

$$\tilde{S}_k(A^{(1)}, \cdots, A^{(k)}) = A_{ij}^{(k)} \tilde{S}_{k-1}^{ij}(A^{(1)}, \cdots, A^{(k-1)})$$

and

$$\tilde{S}_{k-1}^{ij}(A^{(1)},\cdots,A^{(k-1)}) = \frac{1}{k!} \sum_{\substack{i_1,\cdots,i_{k-1}\\j_1,\cdots,j_{k-1}}} \delta_{j_1,\cdots,j_{k-1}}^{i_1,\cdots,i_{k-1}i} A_{i_1j_1}^{(1)} \cdots A_{i_{k-1}j_{k-1}}^{(k-1)}.$$

Lemma 8. Let $u_1, \dots u_{k-1} \in \mathcal{C}^2(D)$, then for any index $i \in \{1, \dots, n\}$,

$$\sum_{j=1}^{n} \frac{\partial}{\partial x_{j}} \tilde{S}_{k-1}^{ij} \left(\text{Hess}(u_{1}), \cdots, \text{Hess}(u_{k-1}) \right) = 0$$

Proof. Denote $\operatorname{Hess}(u_m) = A^{(m)}, m = 1, \dots, k-1$, then

$$\sum_{j} \frac{\partial \tilde{S}_{k-1}^{ij}}{\partial x_{j}} = \frac{1}{k!} \sum_{j} \frac{\partial}{\partial x_{j}} \left(\sum_{\substack{i_{1}, \dots, i_{k-1} \\ j_{1}, \dots, j_{k-1} \\ j_{1}, \dots, j_{k-1} \\ j_{1}, \dots, j_{k-1} \\ j_{1}, \dots, j_{k-1}, j}} \delta_{j_{1} \dots j_{k-1} j}^{i_{1} \dots i_{k-1} i} A_{i_{1} j_{1}}^{(1)} \dots A_{i_{k-1} j_{k-1}}^{(k-1)} \right) \\
= \frac{1}{k!} \sum_{\substack{i_{1}, \dots, i_{k-1} \\ j_{1}, \dots, j_{k-1}, j}} \delta_{j_{1} \dots j_{k-1} j}^{i_{1} \dots i_{k-1} j} \sum_{m=1}^{k-1} A_{i_{1} j_{1}}^{(1)} \dots A_{i_{m-1} j_{m-1}}^{(m-1)} A_{i_{m} j_{m}, j}^{(m)} A_{i_{m+1} j_{m+1}}^{(m+1)} \dots A_{i_{k-1} j_{k-1}}^{(k-1)} \right) \tag{9}$$

Noticed that the j_m and j are anti-symmetric in the Kronecker symbol, while symmetric in $A^m_{i_m j_m, j}$, so the sum in equation (9) must be zero.

Once the Lemma 8 is proved, then for any k-convex functions v_2, \dots, v_k , and C^2 functions u_0 and u_1 with $u_0 = u_1$ on ∂D ,

$$G_{k}[u_{0}, u_{1}, v_{2}, \cdots, v_{k}] = \int_{D} -u_{0} \tilde{S}_{k}[(u_{1})_{ij}, (v_{2})_{ij}, \cdots, (v_{k})_{ij}]$$

$$= \int_{D} -u_{0}(u_{1})_{ij} \tilde{S}_{k-1}^{ij}$$

$$= \int_{D} (u_{0})_{i}(u_{1})_{j} \tilde{S}_{k-1}^{ij}$$

So G_k is symmetric in its arguments if they vanish on the boundary, and more over

$$G_k[u, u, v_2, \cdots, v_k] = \int_D u_i u_j \tilde{S}_{k-1}^{ij} \ge 0$$

for any k-convex v_2, \dots, v_k , and \mathcal{C}^2 function u with u = 0 on ∂D . Then same argument in the proof of Lemma 5 can be used to show following lemma which implies Theorem 3 and Theorem 4.

Lemma 9. For any k-convex functions v_2, \dots, v_k , and any C^2 functions u_0 and u_1 . If $u_0 = u_1 = 0$ on ∂D , then

$$G_k[u_0, u_1, v_2, \cdots, v_k]^2 \le G_k[u_0, u_0, v_2, \cdots, v_k]G_k[u_1, u_1, v_2, \cdots, v_k].$$
