## FINITE P-CENTRAL GROUPS OF HEIGHT K

ABSTRACT. A finite group G is called  $p^i$ -central of height k if every element of order  $p^i$  of G is contained in the  $k^{th}$ -term  $\zeta_k(G)$  of the ascending central series of G. If p is odd such a group has to be p-nilpotent (Thm. A). Finite p-central p-groups of height p-2 can be seen as the dual analogue of finite potent p-groups, i.e., for such a finite p-group P the group  $P/\Omega_1(P)$  is also p-central of height p-2 (Thm. B). In such a group P the index of  $P^p$  is less or equal than the order of the subgroup  $\Omega_1(P)$  (Thm. C). If the Sylow p-subgroup P of a finite group G is p-central of height p-1, p odd, and  $N_G(P)$  is p-nilpotent, then G is also p-nilpotent (Thm. D). Moreover, if G is a p-soluble finite group, p odd, and  $P \in \text{Syl}_p(G)$  is p-central of height p-2, then  $N_G(P)$  controls p-fusion in G (Thm. E). It is well-known that the last two properties hold for Swan groups (see [11]).

## 1. INTRODUCTION

Let p be a prime number. Following a suggestion of A. Mann<sup>1</sup> we call a finite group G *p*-central if every element of order p is central in G, i.e., let

(1.1) 
$$\Omega_i(G,p) = \langle g \in G \mid g^{p^*} = 1 \rangle, \qquad i \ge 0;$$

then G is p-central if, and only if,  $\Omega_1(G, p) \leq Z(G)$ . For a finite p-group P we put  $\Omega_i(P) = \Omega_i(P, p)$ . Obviously, subgroups of p-central groups are p-central.

Powerful finite *p*-groups play an important role in the study of compact *p*-adic analytic groups (see [6, §3]). For finite *p*-central *p*-groups the notion of *p*-centrality is the dual analogue of being powerful provided *p* is odd. Although one must say that *p*-centrality plays a less important role in the study of pro-*p* groups, finite *p*-central groups are quite often the most important examples when it comes to explicit computations in cohomology or homotopy of classifying spaces of finite groups (see for example [3], [11, Thm. 1.7], [23]).

In this note we study a more general class of finite groups. For  $i, k \ge 1$  we say that a finite group G is  $p^i$ -central of height k if  $\Omega_i(G,p) \le \zeta_k(G)$ , where  $\zeta_k(G)$ denotes the  $k^{th}$ -term of the ascending central series of G. In particular, if G is a finite  $p^i$ -central group of height k, then  $\Omega_i(G,p)$  is a p-group. If G is a  $p^i$ -central group of height 1 we simply call G  $p^i$ -central. For odd primes p one can restrict the analysis of finite p-central groups to the study of p-central p-groups (see §3.5).

**Theorem A.** Let p be odd, and let G be a finite p-central group of height  $k \ge 1$ . Then G is p-nilpotent, i.e., if  $P \in Syl_p(G)$  is a Sylow p-subgroup of G, then P has a normal complement in G.

For *p*-central finite groups Theorem A was already proved in [23, Thm. 2.4].

**Example 1.1.** For an odd prime number r the finite group  $G = SL_2(r)$  is 2-central. Hence Theorem A does not hold for p = 2.

The first remarkable result for finite p-central p-groups is the fact that for a finite p-central p-group P, p odd,  $P/\Omega_i(P)$  is also p-central, i.e.,  $(\Omega_i(P))_{i\geq 1}$  is an ascending central series of P. In this form one can find this result in a paper by J. Buckley (see [4]). However, in his first book which appeared three years earlier B. Huppert cited an unpublished result of J. G. Thompson (see [12, Hilfssatz 12.2]) reproducing a proof he is giving credit to N. Blackburn which is also implying the just mentioned statement. For this reason we refer to this result as the Blackburn-Buckley-Thompson theorem. For p = 2 it remains true if one requires that  $\Omega_2(P)$  is contained in the center of P (see [15]). In Section 2.2 we will prove the following generalization.

**Theorem B.** Let k and i be positive integers such that  $k \leq p-2$  or k = p-1 and  $i \geq 2$ . Let P be a  $p^i$ -central pro-p group of height k such that the torsion elements of P form a finite p-group. Then, for all  $j \geq 1$ ,  $P/\Omega_j(P)$  is also a  $p^i$ -central pro-p group of height k. Moreover

(1.2) 
$$\Omega_i(P) = \{ x \in P \mid x^{p^j} = 1 \}.$$

Some families of finite *p*-groups - like powerful or regular groups - have a nice power structure. In particular, the index of the agemo subgroup (the subgroup being generated by the *p*-powers or, simply,  $P^p$ ) is equal to the number of elements of order *p* (see [7], [10]). For an arbitrary finite *p*-group *P* the index  $|P : P^p|$ is bounded in terms of *p* and  $|\Omega_1(P)|$ , i.e., there exist a function *f* such that  $|P : P^p| \leq f(p, |\Omega_1(P)|)$  (see [9], [16]). In a finite *p*-central *p*-group *P* of height p-2 the index of the agemo subgroup is bounded just by the cardinality of  $|\Omega_1(P)|$ (see §2.3).

**Theorem C.** Let k, i be positive integers such that  $k \leq p-2$  or k = p-1 and  $i \geq 2$ , and let P be a  $p^i$ -central p-group of height k. Then

$$(1.3) |P:P^p| \le |\Omega_1(P)|.$$

Moreover, if  $P^p = \{x^p \mid x \in P\}$ , then equality holds in (1.3).

In [11], S. Priddy and H-W. Henn showed that a finite *p*-central *p*-group P, p odd<sup>2</sup>, is a *Swan group*, i.e., if G is a finite group containing P as Sylow *p*-subgroup, then the restriction map in cohomology

(1.4) 
$$\operatorname{res}_{N_G(P)}^G \colon H^{\bullet}(G, \mathbb{F}_p) \longrightarrow H^{\bullet}(N_G(P), \mathbb{F}_p)$$

is an isomorphism of  $\mathbb{N}_0$ -graded, connected, anti-commutative  $\mathbb{F}_p$ -algebras. As pointed out by J. Thévenaz in [21] a finite *p*-group *P* is a Swan group if, and only if,  $N_G(P)$  controls *p*-fusion in *G* for all finite groups *G* with  $P \in \operatorname{Syl}_p(G)$ . This property of *p*-central groups seems to be very particular, and one cannot expect that it holds in a much more general context (see Ex. 1.2). Nevertheless, there are two weaker properties which also hold for *p*-central groups of small height.

**Example 1.2.** Let  $p \ge 5$ ,  $n \ge 2$  and put  $G = \mathrm{SL}_2(\mathbb{Z}/p^n.\mathbb{Z})$ . Then  $P \in \mathrm{Syl}_p(G)$  is *p*-central of height 3, but  $N_G(P)$  does not control *p*-fusion in *G*. Hence, by [17], *P* is not a Swan group.

A finite p-group P will be called to determine p-nilpotency locally if the following holds: Let G be a finite group containing P as Sylow p-subgroup such that  $N_G(P)$ is p-nilpotent. Then G is also p-nilpotent. From J. Tate's nilpotency criterion (see [20]) it follows that Swan groups determine p-nilpotency locally. For finite p-central p-groups of small height we will show the following (see §4).

**Theorem D.** Let p be odd, and let P be a finite p-central p-group of height p-1. Then P determines p-nilpotency locally.

Finite *p*-central *p*-groups of small height possess a 'Swan group like' property which concerns their embeddings into *p*-soluble groups. For simplicity we say that a *p*-soluble group *G* is a p'pp'-sandwich group, if  $O_p(G/O_{p'}(G))$  is a Sylow *p*-subgroup of  $G/O_{p'}(G)$ . In Section 5.2 we will show the following.

**Theorem E.** Let p be odd, and let G be a finite p-soluble group containing a p-central Sylow p-subgroup P of height p-2. Then G is a p'pp'-sandwich group. In particular,  $N_G(P)$  controls p-fusion in G.

The mod p cohomology ring  $H^{\bullet}(G) = H^{\bullet}(G, \mathbb{F}_p)$  of a finite p-central group G is much easier to analyze than for an arbitrary finite group. In [3], C. Broto and H-W. Henn showed that  $H^{\bullet}(G)$  is Cohen-Macaulay. Thus by a result of D. J. Benson and J. F. Carlson (see [2]) its Hilbert series

(1.5) 
$$h_G(t) = \sum_{k \in \mathbb{N}_0} \dim_{\mathbb{F}_p} (H^k(G)) t^k$$

satisfies some functional equation. In case that p is odd and G satisfies some additional property - the  $\Omega_1$ -extension property (see Remark 2.5) - one can determine the  $\mathbb{F}_p$ -algebra structure of  $H^{\bullet}(G)$  explicitly modulo some finite-dimensional  $\mathbb{F}_p$ algebra which satisfies Poincaré duality (see [23]).

A finite *p*-central *p*-group *P* of height 2 may have maximal elementary abelian subgroups of different order, and thus, its mod *p*-cohomology ring will not be Cohen-Macaulay (see [2]). In order to know whether one can extend the result of C. Broto and H-W. Henn to *p*-central *p*-groups of height p - 2, it would be interesting to investigate the following question.

**Question F.** Let p be odd, and let P be a finite p-central p-group of height p-2 such that  $\Omega_k(P)/\Omega_{k-1}(P)$  is abelian for all  $k \ge 1$ . Is  $H^{\bullet}(P)$  Cohen-Macaulay?

Notations and basic definitions. We use the standard notations in group theory. Multiple commutators will always supposed to be left normed. We simply write  $[N_{,(k)} M]$  for the commutator  $[N, M, \ldots, M]$  with M appearing k-times. By  $G^{p^{j}}$  we denote the (closed) subgroup of the (topological) group G which is (topologically) generated by the  $p^{j}$ -powers of G;  $\Omega_{i}(G, p)$  will denote the (closed) subgroup generated by the elements of order less or equal to  $p^{i}$ . For a (closed) normal subgroup N of G we denote by  $N^{1/p}$  the (closed) normal subgroup generated by the set  $\{x \in G \mid x^{p} \in N\}$ .

### 2. *p*-Central *p*-groups of height k

Let p be a prime number, and let k be a positive integer satisfying  $k \leq p-1$ . For a pro-p group P and an integer n we put

(2.1) 
$$\lambda_n^{(k)}(P) = \begin{cases} P & \text{if } n \le 1, \\ \operatorname{cl}(\lambda_{n-k}^{(k)}(P)^p.[\lambda_{n-1}^{(k)}(P), P]) & \text{if } n > 1, \end{cases}$$

where  $cl(\_)$  denotes the closure operation. One has the following.

**Proposition 2.1.** Let P be a pro-p group, and let  $k \leq p-1$ . For  $m, n \geq 1$  one has:

- (a)  $[\lambda_n^{(k)}(P), \lambda_m^{(k)}(P)] \le \lambda_{m+n}^{(k)}(P);$ (b)  $\lambda_n^{(k)}(P)^p \le \lambda_{n+k}^{(k)}(P);$
- (c) if  $k \le p-2$ , then for  $x, y \in \lambda_n^{(k)}(P)$ ,  $(xy)^p \lambda_{n+k+1}^{(k)}(P) = x^p y^p \lambda_{n+k+1}^{(k)}(P)$ .

In particular,  $(\lambda_n^{(k)}(P))_{n>1}$  is a descending p-central series. If  $k \leq p-2$  the associated graded object

(2.2) 
$$\operatorname{gr}_{\bullet}^{(k)}(P) = \coprod_{n \ge 1} \lambda_n^{(k)}(P) / \lambda_{n+1}^{(k)}(P)$$

carries naturally the structure of a graded  $\mathbb{F}_p[t_{\bullet}]$ -Lie algebra with  $t_{\bullet}$  being homoge*neous of degree* k*.* 

*Proof.* (a) and (b) follow from a similar argument as in [8, Lemma 4.6]. By [12, 12]Chap. III, Theorem 9.4, one has

(2.3) 
$$(xy)^p \equiv x^p y^p \pmod{\gamma_2(\lambda_n^{(k)}(P))^p \gamma_p(\lambda_n^{(k)}(P))}.$$

By (a) and (b),  $\gamma_2(\lambda_n^{(k)}(P))^p \gamma_p(\lambda_n^{(k)}(P)) \leq \lambda_{n+k+1}^{(k)}(P)$ . This yields the claim. 

Note that for k = 1 the series  $(\lambda_n^{(k)}(P))_{n \ge 1}$  coincides with the descending *p*-central series of *P*. A finite *p*-group *P* is called of *k*-elementary *p*-length  $\ell$  if  $\operatorname{gr}_{\ell}^{(k)}(P) \neq 0$ , but  $\operatorname{gr}_{\ell+1}^{(k)}(P) = 0$ . In particular, a finite *p*-group *P* is of *k*-elementary *p*-length  $\ell, \ell \leq k$ , if, and only if, it is of exponent *p* and nilpotency class  $\ell$ .

2.1. *p*-Central *p*-groups of small height. Let *p* be odd, let  $k \leq p-2$ , and let *P* be a finite *p*-group. Then *P* is *k*-powerful if, and only if,  $t_{\bullet}: \operatorname{gr}_{\bullet+k}^{(k)}(P) \to \operatorname{gr}_{\bullet+k}^{(k)}(P)$  is surjective. A weak form of injectivity of the mapping  $t_{\bullet}$  has the following consequence.

**Proposition 2.2.** Let P be a finite p-group of k-elementary p-length  $\ell$ ,  $k \leq p-2$ , and assume that  $t_s$ :  $\operatorname{gr}_s^{(k)}(P) \to \operatorname{gr}_{s+k}^{(k)}(P)$  is injective for  $s < \ell - k + 1$ . Then P is p-central of height k.

*Proof.* By hypothesis, one has  $\lambda_{\ell-k+1}^{(k)}(P) \leq \zeta_k(P)$ , and every element of order p must be contained in  $\lambda_{\ell-k+1}^{(k)}(P)$ . 

# Example 2.1. Let $k \leq p - 2$ .

(a) Let F be a finitely generated free pro-p group. Then Proposition 2.2 implies that for any  $m \ge 1$  the finite *p*-group  $P_m = F/\lambda_{m+k}^{(k)}(F)$  is *p*-central of height *k*. (b) Let *Q* be a finitely generated torsion-free *k*-powerful pro-*p* group. Then Propo-

sition 2.2 shows that  $Q/\lambda_{m+k}^{(k)}(Q)$  is a finite *p*-central *p*-group of height *k*. In particular, if Q is a finitely generated uniformly powerful pro-p group, then  $Q/Q^{p^{m+1}}$ 

is a finite *p*-central *p*-group. This result can also be obtained from the theory of powerful groups. (see [6].)

(c) Let M be a finite  $\mathbb{Z}_p$ -module. It is straight forward to check that

(2.4) 
$$PL(M) = \{ \operatorname{id}_M + p.\alpha \mid \alpha \in \operatorname{End}_{\mathbb{Z}_p}(M) \}.$$

is a p-central p-group. For p odd it is also powerful.

(d) For  $n \geq 2$  let P be a Sylow pro-p subgroup of  $\operatorname{SL}_n(\mathbb{Z}_p)$ , and for  $m \geq 1$  let  $K_m$  denote the kernel of the canonical homomorphism  $\operatorname{SL}_n(\mathbb{Z}_p) \to \operatorname{SL}_n(\mathbb{Z}_p/p^m.\mathbb{Z}_p)$ , i.e.,  $K_m$  is just the  $m^{th}$ -congruence subgroup.

Suppose that p > n + 1. Then P is torsion-free. Moreover, one has

(2.5) 
$$\gamma_{n+1}(P) \le P^p,$$

i.e., P is n-powerful and thus potent. This fact can be used to show that for  $P_m = P/K_{m+1}$  one has

$$(2.6)\qquad\qquad \Omega_1(P_m) = K_m/K_{m+1}.$$

In particular,  $P_m$  is *p*-central of height 2n - 1.

2.2. Homomorphic images of p-central pro-p groups of height k. The following power-commutator relations are well-known.

**Lemma 2.3.** Let P be a pro-p group, and let N be a closed normal subgroup of P. If  $N = \langle X \rangle$  then

(2.7) 
$$[N_{(r)} P]^p \le [P(N)_{(r)} P][N_{(r+p-1)} P],$$

where  $P(N) = \langle x^p \mid x \in X \rangle^G$ . In particular, for  $i \ge 1$  one has

(2.8) 
$$[\Omega_i(P), (r) P]^p \le [\Omega_{i-1}(P), (r) P] [\Omega_i(P), (r+p-1) P].$$

Proof. See Theorem 2.7 of [8].

Theorem B can be deduced from Lemma 2.3 as follows.

Proof of Theorem B. By induction, it suffices to prove the theorem for j = 1. Let T be the torsion subgroup. By hypothesis, T is closed and nilpotent. Moreover, there exists m > 0 such that  $[T_{,(m)} P] = 1$ .

As the nilpotence class of  $\Omega_1(P)$  is bounded by p-1,  $\Omega_1(P) = \{x \in P \mid x^p = 1\}$ (see [10]). In order to show that  $P/\Omega_1(P)$  is  $p^i$ -central of height k it suffices to show that for all  $r \geq k$ ,  $[\Omega_{i+1}(P), (r) P] \leq \Omega_1(P)$ . As the claim certainly holds for  $r \geq m$ , we proceed by reverse induction on r < m. Suppose that the assumption is true for  $r+1 \leq m$ .

(1) If  $k \leq p - 2$ , then by Lemma 2.3 and induction

(2.9) 
$$[\Omega_{i+1}(P), (r) P]^p \leq [\Omega_i(P), (r) P][\Omega_{i+1}(P), (r+p-1) P] \leq [\Omega_1(P), (p-2) P] = 1.$$

Hence  $[\Omega_{i+1}(P), (r), P] \leq \Omega_1(P).$ 

(2) If k = p - 1 and  $i \ge 2$  the same argument as in (2.9) yields

(2.10) 
$$[\Omega_{i+1}(P), (r) P]^p \le \Omega_1(P) \cap \mathbb{Z}(P)$$

Hence  $[\Omega_{i+1}(P), (r) P] \leq \Omega_2(P)$ , and therefore

(2.11) 
$$[\Omega_{i+1}(P),_{(r)}P]^p \leq [\Omega_i(P),_{(r)}P][\Omega_{i+1}(P),_{(r+p-1)}P] \leq [\Omega_2(P),_{(p-1)}P] = 1.$$
  
Thus  $[\Omega_{i+1}(P),_{(r)}P] \leq \Omega_1(P)$ , and this yields the claim.

The following example shows that the hypothesis in Theorem B on the finiteness of the subgroup generated by torsion elements cannot be removed.

**Example 2.2.** Let p be odd, let  $C_{p^{i+1}}$  be the cyclic group of order  $p^{i+1}$ ,  $i \ge 1$ , and let A denote its canonical homomorphic image of order p. Let  $M = \mathbb{Z}_p[A]/\mathbb{Z}_p.\Delta$ , where  $\Delta = \sum_{a \in A} a$ . The semi-direct product  $P = C_{p^{i+1}} \ltimes M$ , with the canonical action of  $C_{p^{i+1}}$  on M, is a p-adic analytic pro-p group which is  $p^i$ -central. However,  $P/\Omega_i(P)$  is not p-central. If  $c \in C_{p^{i+1}}$  is a generator and  $a \in M$ , then c.a is an element of order  $p^{i+1}$ . Hence the closed subgroup of P generated by all torsion elements is the entire group P.

Theorem B can be applied also to certain families of *p*-central pro-*p* groups.

**Corollary 2.4.** Let P be a  $p^i$ -central p-adic analytic pro-p group of height k such that  $\gamma_{h(p-1)}(P) \leq \gamma_i(P)^{p^j}$  with h(p-1) < j(p-1) + i. Then  $P/\Omega_j(P)$  is also a  $p^i$ -central pro-p group of height k and  $\Omega_j(P) = \{x \in P \mid x^{p^j} = 1\}.$ 

*Proof.* By [8, Thm. 4.8], the torsion elements of P form a finite p-group. Thus Theorem B yields the claim.

**Remark 2.5.** Let p be odd, and let P be a p-central p-group of height  $k, k \leq p-2$ . We say that P has the  $\Omega_1$ -extension property if there exists a finite p-central p-group Q of height k such that  $P \simeq Q/\Omega_1(Q)$ . It can be shown that all p-groups<sup>3</sup> described in Example 2.1 have this property. However, there are examples of p-central groups which do not have this property. For p-central p-groups of height 1 this property has a strong impact on the structure of the  $\mathbb{F}_p$ -cohomology algebra  $H^{\bullet}(P, \mathbb{F}_p)$  (see [23]). It is very likely that this is also the case for p-central p-groups of height larger than 1 but less than p-2.

2.3. Bounding the index of the agemo subgroup. For a finite p-group P we define the following series of characteristic subgroups:

(2.12) 
$$M_n(P) = \begin{cases} [\Omega_1(P),_{(p-n-1)} P] & \text{if } n \le p-1, \\ M_{n-p+1}(P)^{1/p} & \text{otherwise.} \end{cases}$$

It is easy to check that  $M_{n+1}(P) \ge M_n(P)$ . For n < 0 we put  $M_n(P) = 1$ . If P is a p-central p-group of height p - 2 (resp. a  $p^2$ -central group of height p - 1) this series has the following properties.

**Proposition 2.6.** Let p be odd, let P be a finite p-central p-group of height p - 2 (resp. a  $p^2$ -central group of height p-1), and let  $n \ge 0$ . Then one has the following:

- (a)  $P/M_n(P)$  is a p-central group of height p-2 (resp. a  $p^2$ -central group of height p-1).
- (b)  $[M_n(P), P] \le M_{n-1}(P).$
- (c)  $M_n(P)^p \le M_{n-p+1}(P)$ .
- (d) If  $x \in M_n(P)$ ,  $y \in M_m(P)$  and  $n \ge m$ , then

(2.13) 
$$(xy)^p \equiv x^p y^p \pmod{M_{m-p}(P)}$$

*Proof.* (a) We restrict our considerations to the case when P is p-central of height p-2. The case when P is  $p^2$ -central of height p-1 follows by a similar argument (see proof of Theorem B).

By Theorem B, it suffices to prove the statement for  $n \le p-1$ . Hence one has to show that for  $1 \le s \le p-1$  and  $r \ge p-2-s$ ,

(2.14) 
$$[[\Omega_1(P)_{(s)} P]^{1/p}_{(r)} P] \le \Omega_1(P).$$

We proceed by reverse induction on r. For r large, (2.14) is certainly true. Suppose that (2.14) is true for r + 1. Then, by Lemma 2.3,

(2.15) 
$$[[\Omega_1(P)_{(s)} P]^{1/p}_{(r)} P]^p \leq [\Omega_1(P)_{(s+r)} P] [[\Omega_1(P)_{(s)} P]^{1/p}_{(r+p-1)} P] \\ \leq [\Omega_1(P)_{(p-2)} P] = 1.$$

Hence  $[[\Omega_1(P), (s) P]^{1/p}, (r) P] \leq \Omega_1(P)$ , and this yields the claim.

(b) We may assume that  $n \ge p-1$ , and proceed by induction on n. By (a) and induction, one has

(2.16)

$$[M_n(P), P]^p = [M_{n-p+1}(P)^{1/p}, P]^p \le [M_{n-p+1}(P), P][M_{n-p+1}(P)^{1/p}, P]$$
  
$$\le M_{n-p}(P) [M_{n-p+1}, P] = M_{n-p}(P).$$

Hence  $[M_n(P), P] \le M_{n-1}(P)$ .

(c) is obvious.

(d) By the Hall-Petrescu formula (see [12, Theorem 9.4]) one has

(2.17) 
$$(xy)^p \equiv x^p y^p \pmod{[M_m(P), P]^p[M_m(P), (p-1)P]}.$$

Thus if  $m \leq p-1$  there is nothing to prove. Let m > p-1. Then  $M_m(P) = M_{m-p+1}(P)^{1/p}$ , and by (a),

(2.18)

$$[M_m(P)_{(p-1)}P] = [M_{m-p+1}(P)^{1/p}_{(p-1)}P] = [M_{m-p+1}(P), P] = M_{m-p}(P).$$
  
Hence, (b) and (c) yield the claim.

Proof of Theorem C. Let  $m_{\bullet}(P) = \coprod_{n \in \mathbb{N}} M_{n+1}(P)/M_n(P)$ . By Proposition 2.6(d),  $t_{\bullet} \colon m_{\bullet}(P) \to m_{\bullet}(P), t_n(xM_{n-1}(P)) = x^p M_{n-p}(P)$ , is a well-defined,  $\mathbb{F}_p$ -linear mapping of graded  $\mathbb{F}_p$  vector spaces of degree 1-p. Thus  $m_{\bullet}(P)$  is a graded  $\mathbb{F}_p[t_{\bullet}]$  module. Moreover, by construction of the series  $(M_n(P))_{n\geq 0}$ , one has

(2.19) 
$$\operatorname{Ann}(t_{\bullet}) = m_{(p-1)}(P) = \coprod_{0 \le n \le p-2} M_{n+1}(P) / M_n(P).$$

For any subgroup Q of P we put  $m_{\bullet}(Q) = \coprod_{n \in \mathbb{N}} (Q \cap M_{n+1}(P)) M_n(P) / M_n(P)$ . Hence by (2.19),  $\operatorname{Ann}(t_{\bullet}) = m_{\bullet}(\Omega_1(P))$ . On the other hand one has

(2.20) 
$$t_{\bullet}.M(P) = \coprod_{n \in \mathbb{N}} M_{n+p}(P)^p M_n(P) / M_n(P)$$

and

(2.21) 
$$m_{\bullet}(P^p) = \coprod_{n \in \mathbb{N}} (P^p \cap M_{n+1}(P)) M_n(P) / M_n(P).$$

As  $M_{n+p}(P)^p \leq P^p \cap M_{n+1}(P)$ , one has (2.22)  $|P:P^p| = |m_{\bullet}(P): m_{\bullet}(P^p)| \leq |m_{\bullet}(P): t_{\bullet}.m_{\bullet}(P)| = |\operatorname{Ann}(t_{\bullet})| = |\Omega_1(P)|$ . Moreover, if  $P^p = \{x^p \mid x \in P\}$ , then  $P^p \cap M_{n+1}(P) = M_{n+p}(P)^p$ . Hence equality holds in (2.22).

# 3. Fusion of elementary abelian p-subgroups and F-isomorphisms of mod-p cohomology rings

Throughout this section we fix a prime number p.

3.1. The mod p cohomology ring of a finite group. Recall that an  $\mathbb{N}_0$ -graded  $\mathbb{F}_p$ -algebra  $A_{\bullet}$  is called *anti-commutative*, if for  $a \in A_n$ ,  $b \in A_m$ ,  $n, m \ge 0$  one has

$$b \cdot a = (-1)^{n \cdot m} a \cdot b$$

Such an  $\mathbb{F}_p$ -algebra is called *connected*, if  $A_0 = \mathbb{F}_p \cdot 1_A$ . For a finite group G the *cohomology algebra* 

(3.2) 
$$H^{\bullet}(G) = H^{\bullet}(G, \mathbb{F}_p)$$

is a finitely generated, connected, anti-commutative,  $\mathbb{N}_0$ -graded  $\mathbb{F}_p$ -algebra.

Let  $\alpha_{\bullet}: A_{\bullet} \to B_{\bullet}$  be a homomorphism of finitely generated, connected, anticommutative,  $\mathbb{N}_0$ -graded  $\mathbb{F}_p$ -algebras. Then  $\alpha_{\bullet}$  is called an *F*-isomorphism, if  $\ker(\alpha_{\bullet})$  is nilpotent, and for all  $b \in B_n$ , there exists  $k \in \mathbb{N}_0$  such that  $b^{p^k} \in \operatorname{im}(\alpha_{\bullet})$ . If *S* is a subgroup of the finite group *G*, then

(3.3) 
$$\operatorname{res}_{S}^{G} \colon H^{\bullet}(G) \longrightarrow H^{\bullet}(S)$$

is a homomorphism of finitely generated, connected, anti-commutative,  $\mathbb{N}_0\text{-}\mathrm{graded}$   $\mathbb{F}_p\text{-}\mathrm{algebras}.$ 

3.2. Quillen stratification. Let G be a finite group. Let  $C_G$  denote the category the objects of which are elementary p-abelian subgroups of G and morphisms are given by conjugation, i.e., for  $E, E' \in ob(C_G)$  one has

(3.4) 
$$\operatorname{mor}_{G}(E, E') = \{ i_{g} \colon E \to E' \mid g \in G, \ g E g^{-1} \leq E' \},\$$

where  $i_g(e) = g e g^{-1}, e \in E$ . Then

(3.5) 
$$H^{\bullet}(\mathcal{C}_G) = \lim_{\mathcal{C}_G} H^{\bullet}(E)$$

is a finitely generated, connected, anti-commutative,  $\mathbb{N}_0$ -graded  $\mathbb{F}_p$ -algebra. Moreover, the restriction maps  $\operatorname{res}_E^G$  yield a map

(3.6) 
$$q_G = \prod_{E \in ob(\mathcal{C}_G)} \operatorname{res}_E^G \colon H^{\bullet}(G) \longrightarrow H^{\bullet}(\mathcal{C}_G).$$

Although it is quite difficult to determine the explicit structure of the mod p cohomology algebra  $H^{\bullet}(G)$  for a given finite group G, one knows its structure up to F-isomorphism thanks to the following remarkable result of D. Quillen which is also known as Quillen stratification (see [1, Cor. 5.6.4], [19]).

**Theorem 3.1** (D. Quillen). Let G be a finite group. Then  $q_G: H^{\bullet}(G) \to H^{\bullet}(\mathcal{C}_G)$  is an F-isomorphism.

3.3. Quillen stratification and fusion. Let H be a subgroup of the finite group G containing a Sylow p-subgroup of G which controls fusion of elementary abelian p-subgroups. Then the canonical embedding functor

$$(3.7) j_{H,G}: \mathcal{C}_H \longrightarrow \mathcal{C}_G$$

is an equivalence of categories. Thus  $H^{\bullet}(j_{H,G}): H^{\bullet}(\mathcal{C}_G) \to H^{\bullet}(\mathcal{C}_H)$  is an isomorphism of connected, anti-commutative,  $\mathbb{N}_0$ -graded  $\mathbb{F}_p$ -algebras. Thus from Theorem 3.1 one concludes the following property which can be seen as a weak version of G. Mislin's result (see [17]).

**Proposition 3.2.** Let H be a subgroup of the finite group G containing a Sylow p-subgroup of G which controls fusion of elementary abelian p-subgroups. Then  $\operatorname{res}_{S}^{G} \colon H^{\bullet}(G) \to H^{\bullet}(H)$  is an F-isomorphism.

*Proof.* This is a direct consequence of the commutative diagram

(3.8) 
$$\begin{aligned} H^{\bullet}(G) & \xrightarrow{q_G} H^{\bullet}(\mathcal{C}_G) \\ & \underset{H^{\bullet}(H)}{\overset{res_H^G}{\longrightarrow}} H^{\bullet}(\mathcal{C}_H) \end{aligned}$$

and the previously mentioned remark.

3.4. Quillen's *p*-nilpotency criterion. In [18], D. Quillen has shown the following.

**Theorem 3.3** (D. Quillen). Let G be a finite group, let p be odd, and let P be a Sylow p-subgroup of G. Then G is p-nilpotent if, and only if,  $\operatorname{res}_P^G \colon H^{\bullet}(G) \to H^{\bullet}(P)$  is an F-isomorphism.

**Remark 3.4.** (a) Let G be a finite group, and let P be a Sylow p-subgroup. By a result of J. Tate (see [20]), G is p-nilpotent if, and only if,  $\operatorname{res}_P^G \colon H^{\bullet}(G) \to H^{\bullet}(P)$  is an isomorphism. Every isomorphism of finitely generated, connected, anti-commutative,  $\mathbb{N}_0$ -graded  $\mathbb{F}_p$ -algebras is in particular also an F-isomorphism. Hence Theorem 3.3 can be seen as a generalization of J. Tate's nilpotency criterion for p odd.

(b) Let p be odd. Let G be a finite group, and let  $P \in \text{Syl}_p(G)$ . From Proposition 3.2 and Theorem 3.3 one concludes that G is p-nilpotent if, and only if, P controls fusion of elementary abelian p-subgroups.

3.5. Finite *p*-central groups of height k. For finite *p*-central groups of height k one has the following fundamental property.

**Proposition 3.5.** Let G be a finite p-central group of height  $k, k \ge 1$ , and let P be a Sylow p-subgroup of G. Then for any elementary p-abelian subgroup E of G, one has

(3.9) 
$$G = P.\operatorname{Cent}_G(E).$$

*Proof.* The subgroup  $\Omega_1(G, p)$  is nilpotent of class at most k, and therefore a finite p-group. Let  $p^e$  be the exponent of  $\Omega_1(G, p)$ . By the Hall-Petrescu collection formula (see [8, Theorem 2.1]), for any  $y \in \Omega_1(G, p)$  and  $x \in G$  one has

(3.10) 
$$[y, x^{p^{e+k}}] \in \prod_{0 \le i \le e+k} [\Omega_1(G, p), (p^i) G]^{p^{e+k-i}} = \{1\}.$$

In particular,  $G^{p^{e+k}} \leq \operatorname{Cent}_G(\Omega_1(G))$ . Moreover, for any Sylow *p*-subgroup *P* of *G* one has  $G = P.G^{p^{e+k}}$ . Since every elementary *p*-abelian subgroup *E* of *G* is contained in  $\Omega_1(G, p)$ , this yields the claim.

*Proof of Theorem A.* Let G be a finite p-central group of height k, p odd. By Proposition 3.5, P controls fusion of elementary abelian p-subgroups. Then Proposition 3.2 and Theorem 3.3 yield the claim.

#### 4. FINITE *p*-GROUPS WHICH DETERMINE *p*-NILPOTENCY LOCALLY

Let p be an odd prime number. For  $m \geq 1$  we denote by  $\mathbf{C}_{p^m}$  the cyclic group of order  $p^m$ . Let  $Y_p(1) = \mathbf{C}_p \wr \mathbf{C}_p$  denote the regular wreath product, and let  $\beta \colon \mathbf{C}_p \wr \mathbf{C}_p \to \mathbf{C}_p$  denote the canonical homomorphism with elementary abelian kernel. By  $Y_p(m), m \geq 1$ , we denote the finite p-group which is the pull-back of the diagram

(4.1) 
$$\begin{array}{c} \mathbf{C}_{p^m} \longrightarrow \mathbf{C}_p \\ & & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\$$

In [24] it was shown that every finite *p*-group *P* not containing subgroups isomorphic to  $Y_p(m), m \ge 1$ , determines *p*-nilpotency locally. As a consequence we obtain the following result.

**Theorem 4.1.** Let p be odd, and let P be a finite p-central p-group of height p-1. Then P does not contain subgroups isomorphic to  $Y_p(m)$  for some  $m \ge 1$ . In particular, P determines p-nilpotency locally.

*Proof.* Suppose P contains a subgroup isomorphic to  $Y_p(m)$ ,  $m \ge 1$ . This implies that  $Y_p(m)$  is p-central of height p-1, a contradiction.

### 5. Semi-simple modules for finite p-soluble groups

Let p be a prime number, and let  $\mathbb{F}_q$ ,  $q = p^f$ , denote the finite field with q elements. Then there exists a unique unramified extension  $\mathbb{Q}_q/\mathbb{Q}_p$  of the p-adic numbers of degree f. Moreover,  $\mathbb{Z}_q = \operatorname{int}_{\mathbb{Q}_q}(\mathbb{Z}_q)$  is a complete discrete valuation domain with maximal ideal  $p.\mathbb{Z}_q$  and residue field isomorphic to  $\mathbb{F}_q$ .

For a finite group G we will call a finitely generated left  $\mathbb{Z}_q[G]$ -module L a left  $\mathbb{Z}_q[G]$ -lattice, if it is also a free  $\mathbb{Z}_q$ -module.

The purpose of this section is to translate I. M. Isaacs version (see [13], [14]) of the Fong-Swan-Rukolaine theorem (see [5, Thm. 22.1]) in a module theoretic way (see Thm. 5.1). Using results of P. H. Tiep and A. E. Zalesskii one can then describe the size of a Jordan block of an element of order p in a p-soluble group G on any finite semi-simple left  $\mathbb{F}_q[G]$ -module (see Cor. 5.2). This description will allow us to establish a sufficient criterion for the normality of a Sylow p-subgroup in a finite p-soluble group provided p is odd (see Lemma 5.3).

5.1. **The Fong-Swan-Rukolaine theorem.** The following theorem can be seen as a module theoretic version of I. M. Isaacs version of the Fong-Swan-Rukolaine theorem.

**Theorem 5.1.** Let G be a finite p-soluble group, let  $\mathbb{E}$  be a finite field of characteristic p and let M be an absolutely irreducible left  $\mathbb{E}[G]$ -module. Then there exists a finite extension  $\mathbb{F}_q/\mathbb{E}$  of  $\mathbb{E}$  and a left  $\mathbb{Z}_q[G]$ -lattice L with the following properties:

- (i)  $L/p.L \simeq M \otimes_{\mathbb{E}} \mathbb{F}_q$ ;
- (ii)  $L \otimes_{\mathbb{Z}_q} \mathbb{Q}_q$  is an absolutely irreducible left  $\mathbb{Q}_q[G]$ -module.

*Proof.* Let  $\mathbb{E}$  denote an algebraic closure of  $\mathbb{E}$ , let  $\mathbb{Q}_p$  denote an algebraic closure of  $\mathbb{Q}_p$ , and let  $\mathbb{Q}_p^{\text{un}}$  denote the maximal unramified extension of  $\mathbb{Q}_p$  in  $\overline{\mathbb{Q}}_p$ . Let  $\overline{\chi}_M$ denote the Brauer character of  $M \otimes_{\mathbb{E}} \overline{\mathbb{E}}$ . By [13] and [14], there exists an irreducible left  $\mathbb{Q}_p[G]$ -module V such that the restriction of its character to p-regular conjugacy classes of G agrees with  $\overline{\chi}_M$ , and all its character values are contained in  $\mathbb{Q}_p^{\mathrm{un}}$ . Then by [22, Lemma 3.3], there exists a finite unramified extension  $\mathbb{Q}_q/\mathbb{Q}_p$  of  $\mathbb{Q}_p$  and an absolutely irreducible left  $\mathbb{Q}_q[G]$ -module W such that  $V \simeq W \otimes_{\mathbb{Q}_q} \overline{\mathbb{Q}}_p$ . We may assume that  $\mathbb{F}_q$  contains  $\mathbb{E}$ . Let L < W be a full left  $\mathbb{Z}_q[G]$ -lattice contained in W. Then by construction  $L/p.L \simeq M \otimes_{\mathbb{F}_q} \mathbb{E}$ , and  $L \otimes_{\mathbb{Z}_q} \mathbb{Q}_q \simeq W$ . This yields the claim.  $\Box$ 

From [22, Lemma 3.1] one concludes the following corollary.

**Corollary 5.2.** Let G be a finite p-soluble group, let M be a finite semi-simple  $\mathbb{F}_q[G]$ -module, and let  $\phi: G \to \operatorname{End}_{\mathbb{F}_q}(M)$  be the representation associated to M. Then for every element  $g \in G$  of order p the size of a Jordan block of  $\phi(g)$  is either 1, p-1 or p.

Corollary 5.2 can be translated into a group theoretic context as follows:

**Lemma 5.3.** Let G be a finite p-soluble group,  $p \neq 2$ , and let  $P \in \text{Syl}_p(G)$ . Let M be a finitely generated  $\mathbb{F}_p[G]$ -module, and let  $\phi_M \colon G \to \text{GL}_{\mathbb{F}_p}(M)$  denote the associated representation. Assume further that

(i)  $\ker(\phi_M) \leq O_p(G);$ 

(ii) for all  $g \in P$ ,  $(\phi_M(g) - \mathrm{id}_M)^{p-2} = 0$ .

Then  $P = \ker(\phi_M)$ ; in particular, P is normal in G.

Proof. Let  $\pi: M \to M^{ss}$  denote the semi-simplification of the  $\mathbb{F}_p[G]$ -module M, and let  $\phi_{M^{ss}}: G \to \operatorname{GL}_{\mathbb{F}_p}(M^{ss})$  denote the associated  $\mathbb{F}_p$ -linear representation. By (i),  $\operatorname{ker}(\phi_M)$  is a normal p-subgroup. Let  $\tilde{\phi}_M: \mathbb{F}_p[G] \to \operatorname{End}_{\mathbb{F}_p}(M)$  denote the associated homomorphism of  $\mathbb{F}_p$ -algebras. Then

(5.1) 
$$\ker(\phi_{M^{ss}})/\ker(\phi_M) \le \mathrm{id}_M + \mathrm{Jac}(\mathrm{im}(\phi_M)),$$

where Jac(\_) denotes the Jacobson radical. In particular,  $\ker(\phi_{M^{ss}})/\ker(\phi_M)$  is a *p*-group, and thus  $\ker(\phi_{M^{ss}})$  is a normal *p*-subgroup of *G*.

Let  $g \in P^{\circ} = \phi_{M^{ss}}(P)$  be an element satisfying  $g^p = 1$ . Since  $\phi_{M^{ss}}(G)$  is *p*soluble and as  $M^{ss}$  is a semi-simple left  $\mathbb{F}_p[\phi_{M^{ss}}(G)]$ -module, Corollary 5.2 implies that a Jordan block of *g* must have length 1, p-1 or *p*. Hypothesis (ii) yields that  $(g-1)^{p-2} = 0 \in \operatorname{End}_{\mathbb{F}_p}(M^{ss})$ . Thus every Jordan block of *g* must have size 1; i.e., g = 1. Therefore,  $P^{\circ} = \{1\}$ , and this yields the claim.  $\Box$ 

5.2. The sandwich theorem. Let G be a finite group. By  $O_{p',p}(G)$  we denote the normal subgroup of G containing  $O_{p'}(G)$  and satisfying


(5.2) 
$$O_{p',p}(G)/O_{p'}(G) = O_p(G/O_{p'}(G)).$$

Similarly, we denote by  $O_{p',p,p'}(G)$  the normal subgroup of G containing  $O_{p',p}(G)$  such that

(5.3) 
$$O_{p',p,p'}(G)/O_{p',p}(G) = O_{p'}(G/O_{p',p}(G)).$$

The finite group G will be called a p'pp'-sandwich group, if  $G = O_{p',p,p'}(G)$ . Note that a p'pp'-sandwich group is p-soluble. One has the following property.

**Proposition 5.4.** Let G be a finite p'pp'-sandwich group, and let  $P \in Syl_p(G)$ . Then  $N_G(P)$  controls p-fusion in G. *Proof.* Let  $Q = O_{p',p}(G)$  and  $M = O_{p'}(G)$ ; in particular,  $P \leq Q$ . The Frattini argument yields that  $G = Q.N_G(P) = M.N_G(P)$ . Put  $M_{\circ} = M \cap N_G(P)$ . Then one has a commutative diagram of finite groups



and thus also a commutative diagram of homomorphism of  $\mathbb{F}_p$ -algebras

(5.5) 
$$H^{\bullet}(N_{G}(P), \mathbb{F}_{p}) \xleftarrow{H^{\bullet}(\alpha)} H^{\bullet}(\alpha) H^{\bullet}(G, \mathbb{F}_{p})$$
$$H^{\bullet}(N_{G}(P)/M_{\circ}, \mathbb{F}_{p})$$

Since  $H^{\bullet}(\beta)$  and  $H^{\bullet}(\gamma)$  are inflation mappings with respect to normal subgroups of p'-order,  $H^{\bullet}(\beta)$  and  $H^{\bullet}(\gamma)$  are isomorphisms. Hence  $H^{\bullet}(\alpha) = \operatorname{res}_{N_G(P)}^G$  is an isomorphism. Thus by G. Mislin's theorem (see [17]),  $N_G(P)$  controls p-fusion in G.

The following lemma will turn out to be useful for our purpose.

**Lemma 5.5.** Let p be an odd prime, and let G be a finite p-soluble group. Assume further that  $O_{p'}(G) = \{1\}, O_p(G) \neq \{1\}$ , and that  $\Omega_1(O_p(G))$  is of exponent p. Then  $\operatorname{Cent}_G(\Omega_1(O_p(G))) \leq O_p(G)$ .

Proof. Put  $\Omega = \Omega_1(O_p(G))$  and  $C = \operatorname{Cent}_G(\Omega)$ . Then  $O_p(C) \leq O_p(G)$ , and therefore  $\Omega_1(O_p(C)) \leq \Omega$ . Thus  $\Omega_1(O_p(C)) \leq \mathbb{Z}(\Omega)$ , and  $O_p(C)$  is a non-trivial *p*central normal subgroup of *G*. Let *M* be the characteristic subgroup of *C* containing  $O_p(C)$  such that  $M/O_p(C) = O_{p'}(C/O_p(C))$ . Let  $H \leq M$  be a *p'*-Hall subgroup of *M*. Then *H* is acting trivially on  $\Omega_1(O_p(C))$ , and thus on  $O_p(C)$  (see [12, Kap. IV, Satz 5.12]). In particular,  $[H, O_p(C)] = \{1\}$ , and therefore  $H = O_{p'}(M)$ . Hence, as  $O_{p'}(G) = \{1\}, H = \{1\}$ , and  $C = O_p(C)$ . This yields the claim.  $\Box$ 

**Theorem 5.6.** Let p be odd, and let G be a finite p-soluble group containing a Sylow p-subgroup  $P \in Syl_p(G)$  which is p-central of height p-2. Then  $P.O_{p'}(G)$  is normal in G. In particular, G is a p'pp'-sandwich group.

*Proof.* We may assume that  $O_{p'}(G) = \{1\}$  and  $O_p(G) \neq \{1\}$ . Let  $\Omega = \Omega_1(O_p(G))$ . Since P is p-central of height p - 2,  $\Omega$  is of exponent p. Thus by Lemma 5.5, one has  $\operatorname{Cent}_G(\Omega) \leq O_p(G)$ .

Let  $M = \operatorname{gr}_{\bullet}^{(1)}(\Omega)$  denote the graded  $\mathbb{F}_p[G]$ -module associated to the descending *p*-central series of  $\Omega$  (see (2.2)), and let  $\phi_M : G \longrightarrow \operatorname{GL}_{\mathbb{F}_p}(M)$  denote the associated representation for *G*. Let  $g \in \operatorname{ker}(\phi(M))$  be an element of order co-prime to *p*. Then  $g \in \operatorname{Cent}_G(\Omega) \leq O_p(G)$ . Hence g = 1, and  $\operatorname{ker}(\phi_M) \leq O_p(G)$ . As *P* is *p*-central of height p - 2, one has for  $g \in P$  that  $(\phi_M(g) - \operatorname{id}_M)^{p-2} = 0$ . Hence  $\operatorname{ker}(\phi_M) = P$  by Lemma 5.3. This yields the claim.  $\Box$ 

From Theorem 5.6 and Proposition 5.4 one concludes the following consequence which can be seen an analogue of J. Thévenaz's result.

**Corollary 5.7.** Let p be odd, and let G be a finite p-solvable group, for which  $P \in Syl_p(G)$  is p-central of height p-2. Then  $N_G(P)$  controls p-fusion in G.
