

SYMMETRY PROPERTIES OF THE GENERALIZED HIGHER-ORDER EULER POLYNOMIALS

ABSTRACT. The purpose of this paper is to generalize this relation of symmetry between the power sum polynomials and the generalized Euler polynomials to the relation between the power sum polynomials and the generalized higher-order Euler polynomials.

§1. Introduction

Let d be a fixed positive odd integer and let χ be the Dirichlet's character with conductor d . Then the generalized Euler numbers and polynomials attached to χ are defined as

$$(1) \quad \begin{aligned} \frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{at}}{e^{dt} + 1} &= \sum_{n=0}^{\infty} E_{n,\chi} \frac{t^n}{n!}, \\ \frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{at}}{e^{dt} + 1} e^{xt} &= \sum_{n=0}^{\infty} E_{n,\chi}(x) \frac{t^n}{n!}, \text{ for } |t| < \frac{\pi}{d}, \text{ (see [1-14]).} \end{aligned}$$

For a real or complex parameter α , we define the generalized higher-order Euler numbers and polynomials attached to χ as follows:

$$(2) \quad \begin{aligned} \left(\frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{at}}{e^{dt} + 1} \right)^\alpha &= \sum_{n=0}^{\infty} E_{n,\chi}^{(\alpha)} \frac{t^n}{n!}, \text{ and} \\ \left(\frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{at}}{e^{dt} + 1} \right)^\alpha e^{xt} &= \sum_{n=0}^{\infty} E_{n,\chi}^{(\alpha)}(x) \frac{t^n}{n!}, \text{ where } |t| < \frac{\pi}{d}. \end{aligned}$$

From (2), we note that

$$(3) \quad E_{n,\chi}^{(\alpha)}(x) = \sum_{l=0}^n \binom{n}{l} E_{l,\chi}^{(\alpha)} x^{n-l}.$$

By (1), we can also easily see that

$$(4) \quad E_{k,\chi}(nd) + E_{k,\chi} = 2T_{k,\chi}(nd-1), \text{ where } T_{k,\chi}(n) = \sum_{l=0}^n (-1)^l \chi(l) l^k.$$

Recently, Kurt (see [10]) and several authors (see [5-8], [11-13]) have studied the symmetry property for the Bernoulli and Euler polynomials. The main purpose of this paper is to prove an identity of symmetry for the generalized higher-order Euler polynomials by using the method of Kurt. It turn out that the recurrence relation and multiplication theorem for the generalized Euler polynomials attached to χ .

§2. Identities related to the generalized higher-order Euler polynomials

For $w_1, w_2 \in \mathbb{N}$ with $w_1 \equiv 1, w_2 \equiv 1 \pmod{2}$, let us consider the following functional equation:

$$(5) \quad \begin{aligned} I &= \frac{1}{2} \left(\frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{w_1 a t}}{e^{dw_1 t} + 1} \right)^m e^{w_1 w_2 x t} (e^{dw_1 w_2 t} + 1) \\ &\times \left(\frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{w_2 a t}}{e^{dw_2 t} + 1} \right)^m e^{w_1 w_2 y t} \\ &= \left(\frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{w_1 a t}}{e^{dw_1 t} + 1} \right)^m e^{w_1 w_2 x t} \left(\frac{e^{dw_1 w_2 t} + 1}{e^{w_2 dt} + 1} \right) \left(\sum_{b=0}^{d-1} \chi(b) (-1)^b e^{w_2 b t} \right) \\ &\times \left(\frac{2 \sum_{a=0}^{d-1} (-1)^a \chi(a) e^{w_2 a t}}{e^{dw_2 t} + 1} \right)^{m-1} e^{w_1 w_2 y t}. \end{aligned}$$

It is easy to see that

$$(6) \quad \begin{aligned} &\left(\frac{e^{w_1 dt} + 1}{e^{dt} + 1} \right) \left(\sum_{i=0}^{d-1} \chi(i) e^{it} (-1)^i \right) = \left(\sum_{l=0}^{w_1-1} e^{ldt} (-1)^l \right) \left(\sum_{i=0}^{d-1} \chi(i) (-1)^i e^{it} \right) \\ &= \sum_{i=0}^{w_1 d-1} \chi(i) (-1)^i e^{it} = \sum_{k=0}^{\infty} \left(\sum_{i=0}^{w_1 d-1} \chi(i) (-1)^i i^k \right) \frac{t^k}{k!} = \sum_{k=0}^{\infty} T_{k,\chi}(w_1 d-1) \frac{t^k}{k!}. \end{aligned}$$

By (5) and (6), we have

$$(7) \quad \begin{aligned} I &= \left(\sum_{i=0}^{\infty} E_{i,\chi}^{(m)}(w_2 x) \frac{w_1^i t^i}{i!} \right) \left(\sum_{l=0}^{\infty} T_{l,\chi}(w_1 d-1) \frac{w_2^l t^l}{l!} \right) \left(\sum_{k=0}^{\infty} E_{k,\chi}^{(m-1)}(w_1 y) \frac{w_2^k t^k}{k!} \right) \\ &= \sum_{n=0}^{\infty} \left(\sum_{j=0}^n \binom{n}{j} w_2^j w_1^{n-j} E_{n-j,\chi}^{(m)}(w_2 x) \sum_{k=0}^j T_{k,\chi}(w_1 d-1) \binom{j}{k} E_{j-k,\chi}^{(m-1)}(w_1 y) \right) \frac{t^n}{n!}. \end{aligned}$$

By the symmetry of I in w_1 and w_2 , we also see that

$$(8) \quad I = \sum_{n=0}^{\infty} \left(\sum_{j=0}^n \binom{n}{j} w_1^j w_2^{n-j} E_{n-j, \chi}^{(m)}(w_1 x) \sum_{k=0}^j \binom{j}{k} T_{k, \chi}(w_2 d - 1) E_{j-k, \chi}^{(m-1)}(w_2 y) \right) \frac{t^n}{n!}.$$

By comparing the coefficients on the both sides of (7) and (8), we obtain the following theorem.

Theorem 1. *Let χ be the Dirichlet's character with an odd conductor $d \in \mathbb{N}$. For $w_1, w_2, d \in \mathbb{N}$ with $d \equiv 1 \pmod{2}$, $w_1 \equiv 1 \pmod{2}$, $w_2 \equiv 1 \pmod{2}$, we have*

$$(9) \quad \begin{aligned} & \sum_{j=0}^n \binom{n}{j} w_2^j w_1^{n-j} E_{n-j, \chi}^{(m)}(w_2 x) \sum_{k=0}^j \binom{j}{k} T_{k, \chi}(w_1 d - 1) E_{j-k, \chi}^{(m-1)}(w_1 y) \\ &= \sum_{j=0}^n \binom{n}{j} w_1^j w_2^{n-j} E_{n-j, \chi}^{(m)}(w_1 x) \sum_{k=0}^j \binom{j}{k} T_{k, \chi}(w_2 d - 1) E_{j-k, \chi}^{(m-1)}(w_2 y). \end{aligned}$$

Let $y = 0$ and $m = 1$ in (9). Then we have the following corollary.

Corollary 2. *For $n \in \mathbb{Z}_+$, we have*

$$(10) \quad \begin{aligned} & \sum_{j=0}^n \binom{n}{j} w_2^j w_1^{n-j} E_{n-j, \chi}(w_2 x) T_{j, \chi}(w_1 d - 1) \\ &= \sum_{j=0}^n \binom{n}{j} w_1^j w_2^{n-j} E_{n-j, \chi}(w_1 x) T_{j, \chi}(w_2 d - 1). \end{aligned}$$

From (5) and (6), we can also derive the following Eq.(11).

$$(11) \quad \begin{aligned} I &= \left(\frac{2 \sum_{a=0}^{d-1} \chi(a) (-1)^a e^{w_1 a t}}{e^{d w_1 t} + 1} \right)^m e^{w_1 w_2 x t} \left(\sum_{i=0}^{w_1 d - 1} \chi(i) (-1)^i e^{i w_2 t} \right) \\ &\times \left(\frac{2 \sum_{b=0}^{d-1} \chi(b) (-1)^b e^{w_2 b t}}{e^{d w_2 t} + 1} \right)^{m-1} e^{w_1 w_2 y t} \\ &= \left(\sum_{i=0}^{w_1 d - 1} \chi(i) (-1)^i \sum_{k=0}^{\infty} E_{k, \chi}^{(m)} \left(w_2 x + \frac{w_2}{w_1} i \right) \frac{w_1^k t^k}{k!} \right) \left(\sum_{l=0}^{\infty} E_{l, \chi}^{(m-1)}(w_1 y) \frac{w_2^l t^l}{l!} \right) \\ &= \sum_{n=0}^{\infty} \left(\sum_{k=0}^n \binom{n}{k} w_1^k w_2^{n-k} E_{n-k, \chi}^{(m-1)}(w_1 y) \sum_{i=0}^{w_1 d - 1} \chi(i) (-1)^i E_{k, \chi}^{(m)} \left(w_2 x + \frac{w_2}{w_1} i \right) \right) \frac{t^n}{n!}. \end{aligned}$$

By the symmetry of I in w_1, w_2 , we also see that

$$(12) \quad I = \sum_{n=0}^{\infty} \left(\sum_{k=0}^n \binom{n}{k} w_2^k w_1^{n-k} E_{n-k, \chi}^{(m-1)}(w_2 y) \sum_{i=0}^{w_2 d-1} \chi(i) (-1)^i E_{k, \chi}^{(m)}(w_1 x + \frac{w_1}{w_2} i) \right) \frac{t^n}{n!}.$$

By comparing the coefficients on the both sides of (11) and (12), we obtain the following theorem.

Theorem 3. *Let w_1, w_2 be the odd natural numbers. For $n \in \mathbb{Z}_+, m \in \mathbb{N}$, we have*

$$(13) \quad \begin{aligned} & \sum_{k=0}^n \binom{n}{k} w_1^k w_2^{n-k} E_{n-k, \chi}^{(m-1)}(w_1 y) \sum_{i=0}^{w_1 d-1} \chi(i) (-1)^i E_{k, \chi}^{(m)}(w_2 x + \frac{w_2}{w_1} i) \\ &= \sum_{k=0}^n \binom{n}{k} w_2^k w_1^{n-k} E_{n-k, \chi}^{(m-1)}(w_2 y) \sum_{i=0}^{w_2 d-1} \chi(i) (-1)^i E_{k, \chi}^{(m)}(w_1 x + \frac{w_1}{w_2} i) \end{aligned}$$

Let $m = 1$ in (13). Then we have

$$w_1^n \sum_{i=0}^{w_1 d-1} \chi(i) (-1)^i E_{n, \chi}(w_2 x + \frac{w_2}{w_1} i) = w_2^n \sum_{i=0}^{w_2 d-1} \chi(i) (-1)^i E_{n, \chi}(w_1 x + \frac{w_1}{w_2} i)$$
