From Single-thread to Multithreaded: An Efficient Static Analysis Algorithm

Abstra
t

A great variety of stati analyses that ompute safety properties of single-thread programs have now been developed. This paper presents a systematic method to extend a class of such static analyses, so that they handle programs with multiple POSIX-style threads. Starting from a pragmatic operational semantics, we build a denotational semantics that expresses reasoning \dot{a} la assume-guarantee. The final algorithm is then derived by abstra
t interpretation. It analyses ea
h thread in turn, propagating interferen
es between threads, in addition to other semanti information. The ombinatorial explosion, ensued from the explicit consideration of all interleavings, is thus avoided. The worst case complexity is only increased by a factor n compared to the single-thread case, where n is the number of instructions in the program. We have implemented prototype tools, demonstrating the pra
ti
ality of the approa
h.

1 Introduction

Many static analyses have been developed to check safety properties of sequential programs $\vert 1, 2, 3, 4, 5 \vert$ while more and more software applications are multithreaded. Naive approaches to analyze such applications would run by exploring all possible interleavings, whi
h is impra
ti
al. Some previous proposals avoid this ombinatorial explosion (see Related Work). Our ontribution is to show that every stati analysis framework for single-thread programs extends to one that analyzes multithreaded ode with dynami thread creation and with only a modest increase in complexity. We ignore on
urren
y spe
i bugs, e.g., ra
e onditions or deadlo
ks, as do some other authors $[6]$. If any, such bugs can be detected using orthogonal techniques $[7, 8]$.

Outline We describe in Section 2 a toy imperative language. This contains essential features of C with POSIX threads $[9]$ with a thread creation primitive. The main feature of multithreaded ode is that parallel threads may *interfere*, i.e., side-effects of one thread may change the value of variables in other threads. To take interference between threads into account. we model the behavior of a program by an infinite transition system: this is the operational semantics of our language, which we describe in Section 2.3. It is common practice in abstract interpretation to go from the concrete to the abstract semantics through an intermediate so-called collecting semantics [10]. In our case a different but similar concept is needed, which we call G-collecting semantics, and which we introduce in Section 3. This semantics will discover states, accumulate transitions encountered in the current thread and olle
t interferen
es from other threads. The main properties of this semantics—Proposition 2 and Theorem 1—are the technical core of this paper. These properties allow us to overapproximate the Golle
ting semantics by a denotational semantics. Section 4 then derives an abstract semantics from the G-collecting semantics through abstract interpretation. We discuss algorithmic issues, implementation, question of precision, and possible extensions in Se
tion 5, and examine the omplexity of our analysis te
hnique in se
tion 6, and on
lude in Se
tion 7.

Related Work A great variety of static analyses that compute safety properties of single-thread programs have been developed, e.g., intervals $[4]$. points-to-graph $[11, 3]$, non-relational stores $[1, 2]$ or relational stores such as octagons $[5]$.

Our approach is similat to Rugina and Rinard $[12, 13]$, in the sens that we also use an abstract semantics that derives tuples containing information about urrent states, transitions of the urrent thread, and interferen
e from other threads. While their main parallel primitive is par, which runs too threads ans waits for their ompletion before resuming omputation, we are mostly interested in the more challenging thread creation primitive *create*, which spawn a thread that can survive its father. In Section 6.3, we handle

par to show how they an be dealt with our te
hniques.

Some authors present generalizations of specific analyses to multithreaded code, e.g., Venet and Brat $[14]$ and Lammich and Müller-Olm $[6]$, while our framework extends any single-threaded ode analysis.

Our approach also has some similarities with Flanagan and Qadeer [15]. They use a model-checking approach to verify multi-threaded programs. Their algorithm computes a guarantee condition for each thread; one can see our static analysis framework as computing a guarantee, too. Furthermore, both analyses abstra
t away both number and ordering of interferen
es from other threads. Flanagan and Qadeer's approa
h still keeps some on crete information, in the form of triples containing a thread id, and concrete stores before and after transitions. They laim that their algorithm takes polynomial time in the size of the omputed set of triples. However, su
h sets an have exponential size in the number of global variables of the program. When the nesting depth of loops and thread creation statements is bounded, our algorithm works in polynomial time. Moreover, we demonstrate that our analysis is still precise on realistic examples. Finally, while Flanagan and Qadeer assume a given, static, set of threads created at program start-up, we handle dynamic thread creation. The same restriction is required in Malkis $et \ al.$ [16].

The 3VMC tool [17] has a more general scope. This is an extension of TVLA designed to do shape analysis and to detect specific multithreaded bugs. However, even without multithreading, TVLA already runs in doubly exponential time $|18|$.

Other papers focus on bugs that arise because of multithreading primitives. This is orthogonal to our work. See $[19, 20]$ for atomicity properties, Locksimth and Goblint tools [7, 21, 22] for data-races and [8] for deadlock detection using geometric ideas.

2 Syntax and Operational Semanti
s

2.1 Simplified Language.

The syntax of our language is given in Fig. 1. The syntax of the language is decomposed in two parts: commands (cmd) and statements $(stmt)$. A statement cmd, l' is a command with a return label where it should go after completion. E.g., in Fig 2a, a thread at label ℓ_3 will execute ${}^{\ell_3}$ create(${}^{\ell_4}x :=$

 $x + 1$, ℓ_2 . Commands and statements are labeled, and we denote by Labels the set of labels. Labels represent the control flow: the statement ℓ *stmt,* ℓ' begins at label ℓ and terminates at label $\ell',$ e.g., in Fig 2b, a thread at label ℓ_2 will execute the assignment $x := x+1$ and go to label ℓ_3 . It is assumed that in a given ommand or statement ea
h label appears only on
e. Furthermore, to represent the end of the execution, we assume a special label ℓ_{∞} which never appears in a ommand, but may appear as the return label of a statement. Intuitively, this label represents the termination of a thread: a thread in this label will not be able to execute any statement.

Notice that sequences $cmd_1; cmd_2$ are not labeled. Indeed, the label of a sequence is implicitly the label of the first command, e.g., the program of

Fig. 2b is a sequence labeled by ℓ_5 . We write ℓ *cmd* when the label of *cmd* is ℓ and we write $^{\ell}$ *stmt,* ℓ' the statement *stmt* labeled by ℓ and ℓ' . A program is represented by a statement of the form $^\ell cmd, \ell_\infty.$ Other statements represent a partial execution of a program. The statements *create*, while and if are not atomic, there are composed of several basic steps, e.g., to enter in a *while* loop. To model these basic steps, we introduce the statements $^{\ell_1}$ spawn $(\ell_2), \ell_3$ and ℓ_1 guard(cond), ℓ_2 . Then, the semantics of create, while and if will be defined using the semantics of ℓ_1 spawn(ℓ_2), ℓ_3 and ℓ_1 guard(cond), ℓ_2 . Local variables are irrelevant to our work. Then, all variables in our language are global. Nevertheless, lo
al variables have been implemented (See Se
tion 5) as a sta
k.

This is a toy imperative language with dynamic thread creation. It can easily be extended to handle real-world languages like C or Ada, see Se
tions 2.4 and 5.

2.2 Des
ription of the system.

To represent threads, we use a set Ids of *thread identifiers*. During an execution of a program, each thread is represented by a different identifier. We assume a distinguished identifier $\textit{main} \in \textbf{Ids}$, and take it to denote the initial thread.

When a program is executed, threads go from a label to another one independently. A *control point* is a partial function P that maps thread identifiers to labels and that is defined in $main$. A control point associates each thread with its current label. The domain of P is the set of created threads, the other identifiers may be used after in the execution, for new threads. Let $\mathbb P$ be the set of control points. We write $Dom(P)$ the domain of P and let $P[i \mapsto \ell]$ be the partial function defined by $P[i \mapsto \ell](j) \stackrel{\text{def}}{=}$

Furthermore, threads may create other threads at any time. A *genealogy* of threads is a finite sequence of tuples $(i, \ell, j) \in \text{Ids} \times \text{Labels} \times \text{Ids}$ such that (a) each two tuples (i_1, ℓ_1, j_1) and (i_2, ℓ_2, j_2) have distinct third component (i.e., $j_1 \neq j_2$), (b) **main** is never the third component of a tuple. Such a tuple (i, ℓ, j) means that thread i created thread j at label ℓ . We write j has been *created* in g to say that a uple (i, ℓ, j) appears in g. Let **Genealogies**

be the set of genealogies. We write $g \cdot g'$ the *concatenation* of the genealogies g and g' . The hypothesis (a) means that a thread is never created twice, the hypothesis (b) means that the thread \boldsymbol{main} is never created: it already exists at the begining of the execution.

We let **Stores** be the set of *stores*. We leave the precise semantics of stores undefined for now, and only require two primitives $write_{w:=e}(\sigma)$ and $bool(σ, cond)$. Given a store $σ$, write_{lv:=e} returns the store modified by the assignment $lv := e$. The function *bool* evaluates a condition *cond* in a store σ , returning *true* or *false*.

A uple $(i, P, \sigma, q) \in \text{Ids} \times \mathbb{P} \times \text{Stores} \times \text{Geneadogies}$ is a *state* if (a) $i \in$ $Dom(P)$, (b) $Dom(P)$ is the disjoint union between $\{main\}$ and the set of threads created in g . Let **States** be the set of states. A state is a tuple (i, P, σ, g) where i is the currently running thread, P states where we are in the control flow, σ is the current store and g is the genealogy of thread creations. $Dom(P)$ is the set of existing threads. The hypothesis (a) means that the urrent thread exists, the hypothesis (b) means that the only threads that exist are the initial threads and the thread created in the past.

In the single-threaded case, only the store and the control point of the unique thread is needed. In the ase of several threads, the ontrol point of each thread is needed: this is P.

There are two standard ways to model interferen
es between threads:

- Either all threads are active, and at any time any threads can fire a transition,
- \bullet or, in each state there is an "active thread", a.k.a., a "current thread". and some so called schedule transitions can change the active thread.

Our model rests on latter choice: this allows us to keep track of a thread during execution. Thread ids do not carry information as to how threads were created. This is the role of the q component of states.

Given a program ℓ_0 cmd, ℓ_{∞} the set Initial states is the set of tuples $(\textit{main}, P_0, \sigma, \epsilon)$ where $\textit{Dom}(P_0) = \{\textit{main}\}, P_0(\textit{main}) = \ell_0, \sigma$ is an arbitrary store, and ϵ is the empty word.

A transition is a pair of states $\tau = ((i, P, \sigma, g), (i', P', \sigma', g \cdot g'))$ such that $\forall j \in Dom(P) \setminus \{i\}, P(j) = P'(j)$ and if (j, ℓ, j') is a letter of g', then $j = i$ and $P(i) = \ell$.

We denote by **Tr** the set of all transitions and we denote by *Schedule* $\stackrel{\text{def}}{=}$ $\{((i, P, \sigma, g), (j, P, \sigma, g)) \in \mathcal{I}r \mid i \neq j\}$ the set of transitions that may appear

in the conclusion of rule "schedule", respectively. A transition in *Schedule* only changes the identifier of the current thread.

2.3 Evolution.

To model interleavings, we use a small step semanti
s: ea
h statement gives rise to an infinite transition system over states where edges $s_1 \rightarrow s_2$ correspond to elementary computation steps from state s_1 to s_2 . We define the judgment ℓ_1 stmt, $\ell_2 \Vdash s_1 \to s_2$ to state that $s_1 \to s_2$ is one of these global computation steps that arise when cmd is executed, returning to label l' on termination. To simplify semantic rules, we use an auxiliary judgment

 ℓ_1 stmt, $\ell_2 \vdash (\ell, \sigma) \rightarrow (\ell', \sigma')$ to describe evolutions that are local to a given thread.

Judgments are derived using the rules of Fig. 3. The rule "parallel" transforms local transitions into global transitions. "While body" and "sequence" rules are global because while loop and sequences may contain global subcommands, e.g., ^{ℓ_1}while (x) { ℓ_2 *create*(ℓ_3 *x* := 0)}. In "spawn", the expression "j is fresh in (i, P, σ, q) " means that $i \neq j$ and $P(j)$ is not defined and j nevers appears in g, i.e., in g, there is no tuples (i, ℓ, i') with i or i' equal to j. Intuitively, a fresh identifier is an identifier that has never been used (we keep track of used identifiers in q).

We define the set of transitions generated by the statement $^{\ell}$ stmt, ℓ' :

Notice that, unlike Flanagan and Qadeer [15], an arbitrary number of threads may be spawned, e.g., with the program ℓ_1 *example*₁, ℓ_{∞} of Fig. 2a. Therefore, **Ids** is infinite, an so are \mathbb{P} and $\tau_{\ell_{stmt,\ell'}}$. Furthermore, **Stores** may be infinite, e.g., if store maps variables to integers. Therefore, we cannot have a complexity depending of cardinal of $\tau_{\ell_{s,tmt,\ell'}}$.

Example Let us consider stores that are maps from a unique variable to an integer. We write $[x = n]$ the store that maps x to the integer n. The transitions generated by the statements extracted from Fig. 2a are:

2.4 Properties of the language

Let $\textit{Labs}({}^{\ell}\textit{cmd} ,\ell_{\infty})$ be the set of labels of the statement ${}^{\ell}\textit{cmd} ,\ell_{\infty}.$

A statement generates only transitions from its labels and to its labels, this is formalized by the following lemma:

Notice that in Fig. 3 some statements are "atomic". We call these statements *basic statements*. Formally, a basic statement is a statement of the form ${}^{\ell_1}lv := e, \ell_2, \, {}^{\ell_1}$ guard $(cond), \ell_2$ or ${}^{\ell_1}$ spawn $(\ell_3), \ell_2$.

On basic statement, we have a more precise lemma on labels:

each statement a transfer function that will be abstracted (see Section 4) as an abstra

A concrete configuration is a tuple $Q = \langle S, G, A \rangle : 1$. S is the current state of the system during an execution, 2. G, for *guarantee*, represents what the urrent thread and its des
endants an do 3. and A, for assume, represents what the other threads can do.

Formally, S is a set of states, and G and A are sets of transitions containing Schedule. The set of concrete configurations is a complete lattice for the ordering $\langle S_1, G_1, A_1 \rangle \leq \langle S_2, G_2, A_2 \rangle \Leftrightarrow S_1 \subseteq S_2 \wedge G_1 \subseteq G_2 \wedge A_1 \subseteq A_2$. Proposition 4 will establish the link between operational and G-collecting semantics.

Figure 5 illustrates the execution of a whole program. Ea
h verti
al line represents the exe
ution of a thread from top to bottom, and ea
h horizontal line represents the creation of a thread. At the beginning (top of the figure), there is only the thread $\boldsymbol{main} = j_0$.

During execution, each thread may execute transitions. At state s_0 , thread(s_0) denotes the *currently* running thread (or current thread), see Fig. 4. On Fig. 5, the current thread of s_0 is j_0 and the current thread of s is j_2 .

During the program execution given in Fig. 5, j_0 creates j_1 . We say that j_1 is a *child* of j_0 and j_0 is the *parent* of j_1 . Furthermore, j_1 creates j_3 . We then introduce the concept of *descendant*: the thread j_3 is a descendant of j_0 because it has been created by j_1 which has been cre-

ated by j_0 . More precisely, descendants depend on genealogies. Consider the state $s_0 = (j_0, P_0, \sigma_0, g_0)$ with $g_0 = [(j_0, \ell_1, j_1)]$: the set of descendants of j_0 from g_0 (written $desc_{g_0}(\{j_0\})$, see Fig. 4) is just $\{j_0, j_1\}$. The set of descendants of a given thread increases during the execution of the program. In Fig. 5, the genealogy of s is of the form $g_0 \cdot g$ for some g, here $g = [(j_0, \ell_2, j_2), (j_1, \ell_3, j_3), (j_2, \ell_4, j_4)]$. When the execution of the program reaches the state s, the set of descendants of j_0 from $g_0 \cdot g$ is $desc_{g_0 \cdot g}(\lbrace j_0 \rbrace)$ = $\{j_0, j_1, j_2, j_3, j_4\}.$

In a genealogy, there are two important pieces of information. First, there is a tree structure: a thread creates children that may creates children and so on... Second, there is a global time, e.g., in g, the thread j_2 has been created before the thread j_3 .

Lemma 6. Let $g \cdot g'$ a genealogy and i, j which are not created in g' . Therefore, either $desc_{g'}(\{j\}) \subseteq desc_{g \cdot g'}(\{i\})$ or $desc_{g'}(\{j\}) \cap desc_{g \cdot g'}(\{i\}) = \emptyset$.

Proof. We prove this lemma by induction on g'. If $g' = \epsilon$, then $desc_{\epsilon}(\{j\}) =$ $\{j\}.$

Let us consider the case $g' = g'' \cdot (i', \ell, j')$. By induction hypothesis either $desc_{g''}(\{j\}) \subseteq desc_{g\cdot g''}(\{i\})$ or $desc_{g''}(\{j\}) \cap desc_{g\cdot g''}(\{i\}) = \emptyset$.

In the first case, if $i' \in desc_{g''}(\{j\})$, therefore $j' \in desc_{g'' \cdot (i',\ell',j')}(\{j\})$ and $j' \in desc_{g \cdot g'' \cdot (i', \ell', j')}(\{i\}),$ else $j' \notin desc_{g'' \cdot (i', \ell', j')}(\{j\}).$

In the second case, let us consider the subcase $i' \in desc_{g''}(\{j\})$. Therefore $i' \notin des_{g \cdot g''}(\{i\})$. In addition to this, j is not created in $g \cdot g''$ (a thread cannot be created twice in a genealogy), therefore $j \notin desc_{g \cdot g''}(\{i\})$. Hence $j' \in desc_{g'' \cdot (i',\ell',j')}(\{j\}) \text{ and } j' \notin desc_{g \cdot g'' \cdot (i',\ell',j')}(\{i\}).$

The subcase $i' \in desc_{g \cdot g''}(\{i\})$ is similar. Let us consider the subcase $i' \notin desc_{g''}(\{j\}) \cup desc_{g \cdot g''}(\{i\}).$ Therefore $desc_{g \cdot g'' \cdot (i',\ell',j')}(\{i\}) = desc_{g \cdot g''}(\{i\})$ and $desc_{g'' \cdot (i', \ell', j')}(\{j\}) = desc_{g''}(\{j\}).$ \Box

We also need to consider sub-genealogies such as g . In this partial genealogy, j_1 has not been created by j_0 . Hence $desc_q({j_0}) = {j_0, j_2, j_4}$. Notice that $j_3 \notin desc_{g}(\lbrace j_0 \rbrace)$ even though the creation of j_3 is in the genealogy g.

During an execution, after having encountered a state $s_0 = (j_0, P_0, \sigma_0, g_0)$ we distinguish two kinds of descendants of j_0 : (i) those which already exist in state s_0 (except j_0 itself) and their descendants, (ii) j_0 and its other descendants. Each thread of kind (i) has been created by a statement executed by j₀. We call $after(s_0)$ the states from which a thread of kind (ii) can execute a transition. In Fig. 5, the thi
k lines des
ribe all the states en
ountered while executing the program that fall into $after(s_0)$.

The following lemma explicits some properties of *after*:

Lemma 7. Let T a set of transitions. Let $(s_0, s_1) \in T^*$ therefore:

- 1. If thread(s₀) = thread(s₁) then $s_1 \in$ after(s₀)
- 2. If $s_1 \in after(s_0)$ then $after(s_1) \subset after(s_0)$

Proof. Let $(i_0, P_0, \sigma_0, g_0) = s_0$ and $(i_1, P_1, \sigma_1, g_1) = s_1$. By definition of transitions, there exists g'_1 such that $g_1 = g_0 \cdot g'_1$. Because $i_0 \in desc_{\epsilon}(\{i_0\}),$ $i_0 \in \text{desc}_{g'_1}(\{i_0\})$. Therefore, if $\text{thread}(s) = \text{thread}(s')$, i.e., $i_1 = i_0$, then $s_1 \in after(s_0)$ (By definition of after).

Let us assume that $s_1 \in after(s_0)$. Let $s_2 = (i_2, P_2, \sigma_2, g_2) \in after(s_1)$. Therefore, there exists g'_2 such that $g_2 = g_1 \cdot g'_2 = g_0 \cdot g'_1 \cdot g'_2$ and $i_2 \in$ $desc_{g'_2}(\{i_1\})$. Because $s_1 \in after(s_0)$, by definition, $i_1 \in desc_{g'_1}(\{i_0\})$. Therefore $i_1 \in desc_{g'_2}(\{i_1\}) \cap desc_{g'_1 \cdot g'_2}(\{i_0\})$. According to Lemma 6, $desc_{g'_2}(\{i_1\})$ ⊆ $\text{desc}_{g'_1,g'_2}(\{i_0\})$. Hence $i_2 \in \text{desc}_{g'_1,g'_2}(\{i_0\})$ and therefore $s_2 \in \text{after}(s_0)$. \Box

When a schedule transition is executed, the current thread change. The futur des
endants of the past urrent thread and the new urrent thread are diffents. This is formalized by the following lemma:

Lemma 8. If $(s_1, s_2) \in Schedule$ then after $(s_1) \cap after(s_2) = \emptyset$.

Proof. Let $(i_1, P_1, \sigma_1, g_1) = s_1$ and $i_2 = thread(s_2)$. Therefore $(i_2, P_1, \sigma_1, g_1) =$ s₂. Let $s = (i, P, \sigma, g) \in after(s_1) \cap after(s_2)$.

By definition of *after*, there exists g' such that $g = g_1 \cdot g'$, $i \in desc_{g'}(\{i_1\})$ and $i \in desc_{g'}(\{i_2\})$. Furthermore i_1 and i_2 are in $Dom(P_1)$. Therefore i_1 and i_2 are either created in g_1 , or are **main**. Hence, i_1 and i_2 cannot be created in g'. Therefore, $i_2 \notin desc_{g'}(\{i_1\})$ and therefore $desc_{g'}(\{i_2\}) \subseteq desc_{\epsilon \cdot g'}(\{i_1\}).$ Using Lemma 6 we conclude that $desc_{g'}(\{i_1\}) \cap desc_{g'}(\{i_2\}) = \emptyset$. This is a contradiction with $i \in desc_{g'}(\{i_1\})$ and $i \in desc_{g'}(\{i_2\}).$ \Box

During the execution of a set of transition T that do not create threads, the set of des
endants does not in
rease:

Lemma 9. Let T a set of transitions such that: for all $(s, s') = ((i, P, \sigma, g), (i', P', \sigma', g')) \in T, g = g'.$ Let $s_0 = (i_0, P_0, \sigma_0, g_0), s = (i, P, \sigma, g_0 \cdot g)$ and $s = (i', P', \sigma', g_0 \cdot g \cdot g')$. If $(s, s') \in (A_{\overline{after(s_0)}} \cup T)^{\star}$ then $desc_{g \cdot g'}\{i_0\} = desc_{g}\{i_0\}.$

Proof. Let s_1, \ldots, s_n a sequence of states such that $s_1 = s$, for all $k \in$ $\{1, \ldots, n-1\}, (s_k, s_{k+1}) \in \mathbf{A}_{\vert \text{after}(s_0)} \cup T)^{\star}, \text{ and } s_n = s'.$

Let $(i_k, P_k, \sigma_k, g_0 \cdot g \cdot g_k) = s_k$.

If $g_k \neq g_{k+1}$ then, $(s_k, s_{k_1}) \in \mathbb{A}_{\overline{after(s_0)}}$ and then $i_k \notin desc_{g \cdot g_k}{i_0}$ and then $desc_{g \cdot g_k}{i} = desc_{g \cdot g_{k+1}}{i_0}.$

Therefore, in all cases $desc_{g \cdot g_k} \{i\} = desc_{g \cdot g_{k+1}} \{i\}$ and then, by straightforward induction, $desc_{g \cdot g'}\{i\} = desc_g\{i\}.$ \Box

Lemma 10. Let T a set of transitions such that: for all $(s, s') = ((i, P, \sigma, g), (i', P', \sigma', g')) \in T, g = g'.$ Let $s = (i, P, \sigma, g)$ and $s = (i', P', \sigma', g \cdot g')$. If $(s, s') \in (A_{\overline{after(s_0)}} \cup T)^{\star}$ then $desc_{g'}\{i\} = \{i\}.$

Proof. Apply Lemma 9 with $s_0 = s$.

These lemmas has a consequence on *after*:

Lemma 11. Let T a set of transitions such that: for all $(s, s') = ((i, P, \sigma, g), (i', P', \sigma', g')) \in T, g = g'.$ If $(s_0, s_1) \in (A_{\lceil \frac{after(s_0)}{}} \cup T)^*$ and $s_1 \in after(s_0)$ then thread $(s_1) = thread(s_0)$.

Proof. Let $(i_0, P_0, \sigma_0, g_0) = s_0$ and $(i_1, P_1, \sigma, g_0 \cdot g_1) = s_1$. By Lemma 10 $desc_{g_1}{i_0} = {i_0}$ and by definition of after, $i_1 \in desc_{g_1}{i_0}$. Ш

Lemma 12. Let T_1 a set of transitions such that: for all $(s, s') = ((i, P, \sigma, g), (i', P', \sigma', g')) \in T, g = g'.$ Let T_2 a set of transitions.

Let s_0, s_1, s three states such that $(s_0, s_1) \in T_1^*$, thread $(s_0) = \text{thread}(s_1)$ and $(s_1, s) \in T^*$.

If $s \in after(s_0)$ then $s \in after(s_1)$.

Proof. Let $(i_0, P_0, \sigma_0, g_0) = s_0$, $(i_1, P_1, \sigma, g_0 \cdot g_1) = s_1$ and $(i, P, \sigma, g_0 \cdot g_1 \cdot g) = s$. By Lemma 10 $desc_{q_1}{i_0} = {i_0}$ and by definition of after, $i_1 \in desc_{q_1}{i_0}$. Therefore $desc_{g_1 \cdot g}(\{i_0\}) = desc_g(desc_{g_1}(\{i_0\})) = desc_g(\{i_0\}).$

Because $s \in after(s_0), \, \text{idesc}_{g_1 \cdot g}(\{i_0\}), \, \text{therefore} \, \text{idesc}_g(\{i_0\}).$ Hence $s \in$ $after(s_1).$ \Box

3.2 Definition of the G-collecting Semantics

Let us recall some classical definitions. For any binary relation R on states let $R_{|S} = \{(s, s') \in R \mid s \in S\}$ be the restriction of R to S and $R\langle S \rangle =$ $\{s' \mid \exists s \in S : (s, s') \in R\}$ be the application of R on S. $R; R' = \{(s, s'') \mid$ $\exists s' \in \text{States} : (s, s') \in R \land (s', s'') \in R' \}$ is the *composition* of R and R'. Let $R^* = \bigcup_{k \in \mathbb{N}} R^k$ where $R^0 = \{(s, s) \mid s \in \text{States}\}$ and $R^{k+1} = R; R^k$. Finally, for any set of states S, let \overrightarrow{S} = States $\setminus S$ be the *complement* of S.

The definition of the G-collecting semantics $\lbrack \lbrack \ell$ stmt, $\ell' \rbrack$ of a statement ℓ stmt, ℓ' requires some intermediate relations and sets. The formal definition is given by the following definition:

Let us read together, on some special cases shown in Fig. 6. This will explain the rather intimidating of Definition 1 step by step, introducing the necessary complications as they come along.

The statement is executed between states $s_0 = (j_0, P, \sigma, g)$ and $s_1 =$ $(j_0, P', \sigma', g \cdot g')$.

Figure $6(a)$ describes the single-thread case: there is no thread interaction during the execution of $^\ell$ *stmt,* ℓ' *.* The thread j_5 is spawned after the execution of the statement. E.g., in Fig. 2b, $^{\ell_6}y := 0; \ell_7$.

In this simple case, a state s is reachable from s_0 if and only if there exists a path from s_0 to s using only transitions done by the unique thread (these transitions should be in the guarantee G) and that are generated by the statement. S' represents the final states reachable from S. Finally, in this ase:

Figure 6(b) is more complex: j_0 interferes with threads j_1 and j_3 . These interferences are assumed to be in A. Some states can be reached only with such interference transitions. E.g, consider the statement ${}^{\ell_{14}}y := 1; {}^{\ell_{15}}z :=$ y, ℓ_{∞} in Fig. 2d: at the end of this statement, the value of z may be 3, because the statement $\ell_{13} y := 3, \ell_{\infty}$ may be executed when the thread main is at label ℓ_{15} . Therefore, to avoid missing some reachable states, transitions of A are taken into account in the definition of Reach. In Fig. $6(b)$, the statement ℓ stmt, ℓ' is executed by descendants of j_0 of kind (ii) (i.e., after(s₀)), and the interferences come from j_1 and j_3 which are descendants of kind (i) (i.e., in $after(s_0)$). Finally, we find the complete formula of Definition 1:

In Fig. 6(c), when j_0 executes the statement $^\ell$ s t m t , ℓ' it creates subthreads $(j_2 \text{ and } j_4)$ which execute transitions in parallel of the statement. The guarantee G is not supposed to contain only transitions executed by the current thread but also these transitions. These transitions, represented by thi
k lines in Fig. $6(c)$, are collected into the set Par. Consider such a transition, it is executed in parallel of the statement, i.e., from a state of $Schedule \circ \text{Reach}(\{s_0\})$.

Furthermore, this transition ame from the statement, and not from an earlier thread, hence from $after(s₀)$.

The threads created by j_0 when it executes the statement ℓ stmt, ℓ' may survive when this statement returns in s_1 , as shown in Fig. 6(d). Such a thread *i* (here, *i* is j_4 or j_5 or j_6) can execute transitions that are not in Par. Sub collects these transitions. The creation of i results of a create statement executed between s_0 and s_1 . Hence, such a transition (s, s') is executed from a state in $after(s_0) \setminus after(s_1)$. The path from s_1 to s is comprised of transitions in $(G_{|after(s_0)} \cap \mathcal{Tr}_{^{\ell}stmt,\ell'}) \cup A_{|\overline{after(s_0)}}$ (similarly to Reach) and of transitions of j_0 or j_5 under the dotted line, i.e., transitions in $\mathsf{G}_{|after(s_1)}$.

3.3 Properties of the G-collecting Semantics

To prepare for our stati analysis we provide a ompositional analysis of the Golle
ting semanti
s in Theorem 1 below. To this end, we introdu
e a set of helper functions, see Fig. 7. We define, for any extensive¹ function f , $f^{\uparrow \omega}(X) \stackrel{\text{def}}{=} \bigcup_{n \in \mathbb{N}} f^n(X).$

¹A function f of domain D is extensive if and only if for every set $X \subseteq D$, $X \subseteq f(X)$

The function interfere_A(S) returns states that are reachable from S by applying interferen
es in A. Noti
e that these interferen
es do not hange the label of the urrent thread:

Lemma 13. Let $s = (i, P, \sigma, g)$ and $s' = (i', P', \sigma', g')$. If $(s, s') \in (A_{\lceil \frac{after(s)}{after(s)} \rceil})$ Schedule)^{*} then $P(i) = P'(i)$, i.e., label(s) = $P'(thread(s))$. If furthermore thread(s) = thread(s') then $label(s) = label(s')$.

Proof. There exists a sequence of states s_0, \ldots, s_n such that $s_0 = s$ and $s_n = s'$ and for all $k \in \{0, \ldots, n-1\}$, $(s_k, s_{k+1}) \in A_{\lceil \frac{after(s)}{after(s)} \rceil} \cup Schedule$.

Let $(i_k, P_k, \sigma_k, g_k) = s_k$. Let us prove by induction that $P_k(i) = P(i)$. If $(s_k, s_{k+1}) \in Schedule$ and $P_k(i) = P(i)$ then $P_{k+1}(i) = P(i)$. If $(s_k, s_{k+1}) \in$ $\mathbf{A}_{\overline{after(s)}}$ and $P_k(i) = P(i)$ then $s_k \notin after(s_k)$ and then $i_k \neq i$ and then $P_{k+1}(i) = P_k(i) = P(i).$ \Box

The function $post(\ell)$ computes the set of states that may be reached after having created a thread at label ℓ ; schedule-child applies a schedule transition to the last child of the current thread. The function init-child_{ℓ} computes a configuration for the last child created at ℓ , taking into account interferences with its parent using $post(\ell)$; notice that we need here the genealogies to define $post(\ell)$ and then to have Theorem 1. The function exe
ute-thread omputes a part of the guarantee (an under-approximation), given the semantics of a command represented as a function f from configuration to configuration. And guarantee iterates execute-thread to compute the whole guarantee.

During the execution of a statement $^\ell s t m t, \ell',$ some interference transition may be fired at any time. Nevertheless, the labels of the thread(s) executing the statement are still in a label of the statement:

3.4 Basi Statements

Basic statement have common properties, therefore, we will study them at the same time. Proposition 2 explain how to overapproximate the semanti
s of a basic statement. It will be used in the abstract semantics.

An execution path of a basic statement can be decomposed in interferences, then one transition of the basic statement, and then, some other interferen
es. The following lemma show this. This lemma will allow us to prove Proposition 2.

Notice that **spawn** creates a subthread, but does not execute it. The Claim 3 caracterizes the transitions done by the current thread. The Claim 4 gives an overapproximation of S', the set of states reached at the end of the execution of a basic statement.

While points 1 and 3 are as expected, the overapproximation of semantics of ℓ_1 create(ℓ_2 cmd), ℓ_3 (point 4) computes interferences which will arise from executing the child and its descendants with guarantee and then combines this result with the configuration of the current thread. This theorem will be proved later.

The following proposition consider a statement ℓ stmt, ℓ' set of transition T. The only constraint on T is on the use of labels of ℓ stmt, ℓ' .

The proposition consider an execution of the statement from a state s_0 to a state s_1 , and, after, an execution s_2, \ldots, s_n of other commands. The labels of ℓ *stmt,* ℓ' mays only be used :

. This Proposition ensures us that any transition executed by a thread created during the execution of ℓ stmt, ℓ' (i.e., between s_0 and s_1) is a transition generated by the statement ℓ *stmt,* ℓ' *.*

Recall from the theory of abstract interpretation [4] that a *Galois con*nection [23] between a concrete complete lattice X and an abstract complete lattice Y is a pair of monotonic functions $\alpha: X \to Y$ and $\gamma: Y \to X$ such that $\forall x \in X, \forall y \in Y, \alpha(x) \leq y \Leftrightarrow x \leq \gamma(y)$; α is called the *abstraction* function and γ the *concretization* function. Product lattices are ordered by the product ordering and sets of functions from X to a lattice L are ordered by the pointwise ordering $f \leq q \Leftrightarrow \forall x \in X, f(x) \leq q(x)$. A monotonic function f^{\sharp} is an abstraction of a monotonic function f^{\flat} if and only if $\alpha \circ f^{\flat} \circ \gamma \leqslant f^{\sharp}$. It is a classical result [23] that an adjoint uniquely determines the other in a Galois connection; therefore, we sometimes omit the abstraction function (lower adjoint) or the concretization function (upper adjoint).

Our concrete lattices are the powersets $P(\text{States})$ and $P(\text{Tr})$ ordered by in
lusion. Remember, our goal is to adapt any given single-thread analysis in a multithreaded setting. Accordingly, we are given an abstract complete lattice $\mathscr D$ of abstract states and an abstract complete lattice $\mathscr R$ of abstract transitions. These on
rete and abstra
t latti
es are linked by two Galois connections, respectively $\alpha_{\mathscr{D}}, \gamma_{\mathscr{D}}$ and $\alpha_{\mathscr{R}}, \gamma_{\mathscr{R}}$. We assume that abstractions of states and transitions depend only on stores and that all the transitions that leave the store unchanged are in $\gamma_{\mathscr{R}}(\perp)$. This assumption allows us to abstract guard and spawn as the least abstract transition \perp .

tions. We assume $\ell_{\star} \in$ Labels a spe

We define a Galois connection between $P(\text{States})$ and $\mathcal{P}(\mathbf{Labels})$: $\alpha_L(S) = \{ \ell \in$ Labels | S ∩ post $(\ell) \neq \emptyset$ }

Note that we have two distinct ways of abstracting states (i, P, σ, g) , either by using $\alpha_{\mathscr{D}}$, which only depends on the store σ , or by using α_{L} which only depends on the genealogy g and the current thread i . The latter is specific to the multithreaded ase, and is used to infer information about possible interferen
es.

Just as $\alpha_{\mathscr{D}}$ was not enough to abstract states in the multithreaded setting, $\alpha_{\mathscr{R}}$ is not enough, and lose the information that a given transition is or not in a given $post(\ell)$. This information is needed because $G_{|post(\ell)}$ is used in Theorem 1 and Fig. 7. Let us introdu

4.2 Appli
ations: Non-Relational Stores and Gen/Kill Analyses

As an application, we show some concrete and abstract stores that can be used in practice. We define a Galois connection $\alpha_{store}, \gamma_{store}$ between concrete and abstract stores and encode both *abstract states* and *abstract transitions* as abstract stores, i.e., $\mathscr{D} = \mathscr{R}$. Abstract states are concretized by:

Gen/kill analyses In such analyses $[6]$, stores are sets, e.g., sets of initialized variables, sets of edges of a point-to graph. The $\mathit{assign}_{lv:=e}$ function updates $\mathcal K$ by adding the modification of the store to all labels encountered so far (those which are in \mathcal{L}). It does not change $\mathcal L$ because no thread is created. Notice that in the case of a non-relational store, we can simplify function *assign* using the fact that *inter*_{*I*} \circ *write*_{x:=e}(*C*) = $C[x \mapsto val_{\mathcal{C}}(e) \sqcup I(x)].$

The abstract semantics is defined by induction on syntax, see Fig. 9, and. with Prop.5, it is straightforward to check the soundness of this semantics:

4.4 Example

Consider Fig. 10 and the non-relational store of ranges $[4]$. We will apply our algorithm on this example.

Our algorithm computes a first time *execute-thread*, then, the fixpoint is not reached, and then, execute-thread is computed another time.

The abstract semantics is denotational, so we may compute it recursively. This requires to compute fixpoints and may fail to terminate. For this reason, each time we have to compute $f^{\uparrow \omega}(X)$ we compute instead the overapproximation $f^{\uparrow\triangledown}$, where \triangledown is a widening operator, in the following way: 1. Assign $X_1 := X$ 2. Compute $X_2 := f(X_1)$ 3. If $X_2 \leq X_1$ then returns X_2 , otherwise, 4. Assign $X_1 := X_1 \nabla X_2$ and go back to 2. Our final algorithm is to compute recursively $\textit{guarantee}_{\ell\textit{cmd},\ell_\infty}$ applied to the initial configuration $\langle \top, \{\ell_{\star}\}, \lambda \ell, \bot, \bot \rangle$, overapproximating all fixpoint computations.

We have implemented two tools, Parint and MT-Penjili, in O
aml with the front-end C2newspeak, w two different abstract stor The first one maps variables to integer intervals and omputes an overapproximation of the values of the variables. The

second one extends the analysis of Allamigeon et al. $|2|$, which focuses on pointers, integers, C-style strings and structs and detects array overflows. It analyzes programs in full fledged C (except for dynamic memory allocation library routines) that use the Pthreads multithread library. We ignore mutexes and ondition variables in these implementations. This is sound be ause mutexes and ondition variables only restri
t possible transitions. We lose precision if mutexes are used to create atomic blocks, but not if they are used only to prevent data-ra
es.

In Table 2 we show some results on benchmarks of differents sizes. L.o.C. means "Lines of Code". "Message" is a C file, with 3 threads: one thread sends an integer message to another through a shared variable. "Embedded" is extracted from embedded C code with two threads. "Test 12" and "Test 15" are sets of 12 and 15 files respectively, each one focusing on a specific thread intera
tion.

To give an idea of the precision of the analysis, we indicate how many false alarms were raised. Our preliminary experiments show that our algorithm loses pre
ision in two ways: 1. through the (single-thread) abstra
tion on stores 2. by abstra
tion on interferen
es. Indeed, even though our algorithm takes the order of transitions into account for the current thread, it onsiders that interferen
e transitions may be exe
uted in an arbitrary order and arbitrary many times. This does not cause any loss in "Message", since the thread whi
h send the message never put an in
orre
t value in the shared variable. Despite the fact that "Embedded" is a large excerpt of an actual industrial ode, the loss of pre
ision is moderate: 7 false alarms are reported

on a total of 27 100 lines. Furthermore, be
ause of this arbitrary order, our analysis straightforwardly extends to models with "relaxed-consistency" and "temporary" view of thread memory due to the use of cache, e.g., OpenMP.

6 Complexity

The omplexity of our algorithm greatly depends on widening and narrowing operators. Given a program ℓ^0 prog, ℓ_∞ , the slowness of the widening and narrowing in an integer w su
h that: widening-narrowing stops in always at most w steps on each loop and whenever *guarantee* is computed (which also requires doing an abstract fixpoint computation). Let the *nesting depth* of a program be the nesting depth of while and of create which² have a subcommand *create*.

Proposition 6. Let d be the nesting depth, n the number of commands of our program, and, w the slowless of our widening. The time complexity of our analysis is $O(nw^{d+1})$ assuming operations on abstract stores are done in onstant time.

This is comparable to the $O(nw^d)$ complexity of the corresponding singlethread analysis, and ertainly mu
h better that the ombinatorial explosion of interleaving-based analyses. Furthermore, this is beter than polynomial in an exponential number of states [15].

Proof. Let $c({\ell cm}d, {\ell'})$, $n({\ell cm}d, {\ell'})$ and $d({\ell cm}d, {\ell'})$ and $w({\ell cm}d, {\ell'})$ be the complexity of analyzing ℓ cmd, ℓ' , the size of ℓ cmd, ℓ' and the nesting depth of ℓ *cmd,* ℓ' *,* the slowless of the widening and narrowing on ℓ *cmd,* ℓ' *respectively.* Let a and k the complexity of assign and of reading $\mathcal{K}(\ell)$ respectively.

r roposition o is a straightforward consequence of the following lemma :

If ℓ_2 cmd does not contain any subcommand create, then the fixpoint computation terminates in one step: $c({}^{\ell_1}$ create $({}^{\ell_2}cmd), \ell_3) = k + c({}^{\ell_2}cmd)$ Else: $c({}^{\ell_1} \text{create}({}^{\ell_2} \text{cmd}), \ell_3) = k + w({}^{\ell_1} \text{create}({}^{\ell_2} \text{cmd}), \ell_3)) \times c({}^{\ell_2} \text{cmd})$

6.1 Complexity of Operations on $\mathscr{R}^{\text{Labels}}$

Notice that we have assumed that operation on $\mathscr{R}^{\text{Labels}}$ are done in constant time in Proposition 6. This abstract store may be represented in different ways. The main problem is the complexity of the *assign* function, which computes a union for each element in \mathcal{L} . The naive approach is to represent $\mathcal{K} \in \mathscr{R}^{\mathbf{Labels}}$ as a map from $\mathcal{P}(\mathbf{Labels})$ to \mathscr{R} . Assuming that operations on maps are done in onstant time, this approa
h yields a $O(tnw^d)$ complexity where t is the number⁴ of creates in the program. We may also represent $\mathcal{K} \in \mathcal{R}^{\text{Labels}}$ as some map \mathcal{K}_M from $\mathcal{P}(\text{Labels})$ to R such that $\mathcal{K}(\ell) = \bigcup_{\ell \in \mathbb{R}} \mathcal{K}_M(\ell)$ and the function *assign* is done in $\text{constant time : } \text{assign}_{lv:=e} \langle C, L, \mathcal{K}, I \rangle \stackrel{\text{def}}{=} \langle \text{inter}_I \circ \text{write}_{lv:=e}(C), L, \mathcal{K}_M[L] \mapsto$ *K*^M(*L*) \sqcup *write-inter*_{lv:=e}(*C*)], *I* \rangle . Nevertheless, to access to the value *K*(ℓ) may need up to t operations, whi
h in
reases the omplexity of *child* -*spawn* and *combine*. The complexity is then $O(n(w + t)w^{d-1})$.

6.2 Compexity of Widdenning

The slowness of the widening and narrowing operators, w , depends on the abstra
tion. Nevertheless, a widening is supposed to be fast.

Consider the naive widening on intervals : $[x, x']\nabla[y, y'] = [z', z']$ where $z =$ $\int x$ if $y \geqslant x$ −∞ else and $z' =$ $\int x'$ if $y \leqslant x$ $+\infty$ else

This widening never widen more than two times on the same variable. Therefore this naive widening is linear in the worst case.

I his is different to the number of threads since an arbitrary number of threads may be created at the same location.

6.3 Other form of parallelism

Our technique also applies to other forms of concurrency, Fig. 11 displays how Rugina and Rinard's *par* constructor $[12, 13]$ would be computed with our abstra
tion. Corre
tness is a straightforward extension of the te
hniques des
ribed in this paper.

Our model handle programs that use *create* and *par*. Then, it can handle OpenMP programs with "parallel" and "task" constructors.

Conclusion $\overline{7}$

We have described a generic static analysis technique for multithreaded programs parametrized by a single-thread analysis framework and based on a form of rely-guarantee reasoning. To our knowledge, this is the first such modular framework: all previous analysis frameworks concentrated on a particular abstract domain. Such modularity allows us to leverage any static analysis te
hnique to the multithreaded ase. We have illustrated this by applying it to two abstra
t domains: an interval based one, and a ri
her one that also analyzes array overflows, strings, pointers $[2]$. Both have been implemented.

We have shown that our framework only incurred a moderate (low-degree polynomial) amount of added omplexity. In parti
ular, we avoid the ombinatorial explosion of all interleaving based approa
hes.

Our analyses are always correct, and produce reasonably precise information on the programs we tested. Clearly, for some programs, taking locks/mutexes and conditions into account will improve precision. We believe that is an orthogonal concern: the non-trivial part of our technique is already present without syn
hronization primitives, as should be manifest from the correctness proof of our G-collecting semantics. We leave the integration of syn
hronisation primitives with our te
hnique as future work. However, lo
ks whose sole purpose are to prevent data ra
es (e.g. ensuring that two concurrent accesses to the same variable are done in some arbitrary sequential order) have no influence on precision. Taking locks into account may be interesting to isolate atomi blo
ks.
