FIBONACCI NUMBERS AND POSITIVE BRAIDS

ABSTRACT. The paper contains enumerative combinatorics for positive braids, square free braids, and simple braids, emphasizing connections with classical Fibonacci sequence. The simple subgraph of the Cayley graph of the braid group is analyzed in the final part.

1. Introduction

The classical Fibonacci sequence, $(F_n)_{n\geq 0}$: 0, 1, 1, 2, 3, ... appears from time to time in enumerative questions related to Artin braids [2], the geometrical analogue of permutations. The *positive n-braids* can be defined as words in the alphabet $\{x_1, x_2, \ldots, x_{n-1}\}$:

$$x_i \quad \begin{vmatrix} & i-1 & i & i+1 & i+2 & n \\ & \ddots & & & & & & \\ & \ddots & & & & & & \\ \end{matrix}$$

in which we identify two words obtained using finitely many changes of type

$$\begin{array}{ll} \alpha(x_i x_j)\beta &\longleftrightarrow & \alpha(x_j x_i)\beta & (\text{for } |i-j| \ge 2) \\ \alpha(x_i x_{i+1} x_i)\beta &\longleftrightarrow & \alpha(x_{i+1} x_i x_{i+1})\beta & (\text{for } i=1,2,\ldots,n-2): \end{array}$$



A central role is played by *Garside braid* [10]: $\Delta_n = x_1(x_2x_1)\dots(x_{n-1}\dots x_1)$.

We will denote by \mathcal{MB}_n the set of positive braids, by \mathcal{MB}_n^+ the set of positive braids not containing Δ_n as a subword, and by $\text{Div}(\Delta_n)$ the set of positive braids which are subwords of Garside braid:

 $\operatorname{Div}(\Delta_n) = \{ \omega \in \mathcal{MB}_n | \text{ there exist } \alpha, \beta \in \mathcal{MB}_n \text{ such that } \Delta_n = \alpha \omega \beta \}.$

A well known result says that the set of square free positive braids coincides with $\text{Div}(\Delta_n)$. In [4] is defined in many ways the set of simple braids, $\mathcal{SB}_n \subset \text{Div}\Delta_n$. One definition is:

Definition 1.1. A simple braid is a positive braid $\beta \in \mathcal{MB}_n$ which contains a letter x_i at most once.

In our first computations Fibonacci numbers (F_k) appear; b_k and b_k^+ represents the number of braids of length k in \mathcal{MB}_3 and \mathcal{MB}_3^+ respectively.

Theorem 1.2. The generating function of \mathcal{MB}_3 is

$$G_{\mathcal{MB}_3}(t) = \sum_{k \ge 0} b_k t^k = 1 + 2t + 4t^2 + 7t^3 + 12t^4 + 20t^5 + \dots$$

where $b_k = F_{k+3} - 1, \ k \ge 0.$

Theorem 1.3. The generating function of \mathcal{MB}_3^+ is

$$G_{\mathcal{MB}_3^+}(t) = \sum_{k \ge 0} b_k^+ t^k = 1 + 2t + 4t^2 + 6t^3 + 10t^4 + 16t^5 + \dots$$

where $b_k^+ = 2F_{k-1}, \ k \ge 1$.

Theorem 1.4. The number of simple braids in SB_n is F_{2n-1} .

The paper contains some other combinatorial problems related to positive braids. In the next section the proofs of the first two theorems are given.

In the third section the generating polynomial of the square free braids is computed (Proposition 3.1) and the recurrence relation for its coefficients are presented (Proposition 3.2).

A proof of Theorem 1.4, the generating polynomial for simple braids, and some properties of its coefficients (Proposition 4.1) are contained in section 4.

The fifth section contains enumerative problems related to the set of conjugacy classes of simple braids (Proposition 5.1).

In the last section we analyze the subgraph of the Cayley graph of the braid group generated by simple braids (Proposition 6.2 and Proposition 6.3).

Connections between multiple Fibonacci-type recurrence [12] and Jones polynomial and Conway-Alexander polynomial for closed braids are presented in [8] and [3].

2. Positive braids

The generating function for positive braids was computed by P. Deligne [9] using invariants of Coxeter groups. A direct computation for 3-braids was done by P. Xu [14] and an inductive algorithm for $G_{\mathcal{MB}_n}(t)$ and some generalizations are contained in Z. Iqbal [11]. Using any of these references, we have

Corollary 2.1. ([9], [14], [11]) The generating function for positive 3-braids is given by

$$G_{\mathcal{MB}_3}(t) = \frac{1}{(1-t)(1-t-t^2)}$$

Proof of Theorem 1.2 The expansion in simple parts $G_{\mathcal{MB}_3}(t) = \frac{2+t}{1-t-t^2} - \frac{1}{1-t}$ and the equality $(1-t-t^2)^{-1} = \sum_{k>0} F_{k+1}t^k$ gives the result:

 $b_{k} = (2F_{k+1} + F_{k}) - 1 = (F_{k+1} + F_{k+2}) - 1 = F_{k+3} - 1. \qquad \square$ Proof of Theorem 1.3 Every positive braid β can be written in a unique way as a product $\beta = \Delta_{n}^{k}\beta^{+}$ with $\beta^{+} \in \mathcal{MB}_{n}^{+}$ (see [10]), therefore the decomposition $\mathcal{MB}_{3} = \coprod_{k\geq 0} \Delta_{3}^{k} \cdot \mathcal{MB}_{3}^{+}$ implies:

$$G_{\mathcal{MB}_3^+}(t) = (1+t^3+t^6+\ldots)^{-1} \cdot G_{\mathcal{MB}_3}(t) = \frac{1+t+t^2}{1-t-t^2} = \sum_{k>1} b_k^+ t^k.$$

Simple computations shows that $b_0^+ = 1$, $b_1^+ = 2 = 2F_2$, $b_2^+ = 4 = 2F_3$, and, for $k \ge 3$, $b_k^+ - b_{k-1}^+ - b_{k-2}^+ = 0$, hence the result.

For a universal upper bound of the growing type of \mathcal{MB}_n , see [7].

3. Square free braids

To represent an element of $Div(\Delta_n)$, i.e. a positive square free braid, we choose the canonical form given by the smallest elements in the length-lexicographic order (see [6], [1]):

$$\beta_{K,J} = \beta_{k_1,j_1} \beta_{k_2,j_2} \dots \beta_{k_s,j_s}$$

where $\beta_{k,j} = x_k x_{k-1} \dots x_{j+1} x_j$, $0 \leq s \leq n-1$, $1 \leq k_1 < k_2 \dots < k_s \leq n-1$, and $j_h \leq k_h$ for $h = 1, \dots, s$ (the case s = 0 corresponds to the unit $\beta = 1$). For simplicity, we will write Div_n for $Div(\Delta_n)$. Let us denote by $d_{n,i}$ the number of divisors of Δ_n of length *i* and by $G_{Div_n}(t)$ the generating polynomial of the square free *n*-braids. Proposition 3.1. $G_{Div_n}(t) = \sum_{i=0}^{n(n-1)/2} d_{n,i}t^i$ = $(1+t)(1+t+t^2)\dots(1+t+t^2+\dots+t^{n-1}).$

Proof. We start the induction with n = 2: $Div_2 = \{1, x_1\}$ and $G_{Div_2}(t) = 1 + t$. The canonical form of square free braids shows that the map

$$f: Div_{n-1} \times \{1, \beta_{n-1,1}, \beta_{n-1,2}, \dots, \beta_{n-1,n-1}\} \longrightarrow Div_n,$$

defined by $f(\omega, 1) = w$, $f(\omega, \beta_{n,k}) = w \cdot \beta_{n,k}$, is a bijection. The generating polynomial of the set $\{1, \beta_{n-1,k}\}_{k=1,\dots,n-1}$ is $1 + t + \dots + t^{n-1}$, so $G_{Div_n}(t) = G_{Div_{n-1}}(t) \cdot (1 + t + \dots + t^{n-1})$.

Corollary 3.2. The sequence $(d_{n,i})_{i=0,\ldots,\frac{n(n-1)}{2}}$ is symmetric and unimodular and satisfies the following recurrence relation:

a) $d_{1,0} = 1$, $d_{1,i} = 0$ if $i \neq 1$; b) $d_{n+1,i} = d_{n,i} + d_{n,i-1} + \ldots + d_{n,i-n}$.

4. Simple braids

The canonical form of a simple braids in \mathcal{SB}_n is

$$\beta_{K,J} = \beta_{k_1,j_1} \beta_{k_2,j_2} \dots \beta_{k_s,j_s}$$

where $1 \leq k_1 < k_2 < \ldots k_s \leq n-1$, $j_i \leq k_i$ for all $i = 1, 2, \ldots, s$, and also $j_{i+1} > k_i$ for all $i = 1, 2, \ldots, s-1$ (see [4]). Let us denote by \mathcal{SB}_n^i the subset of simple braids of length i in \mathcal{SB}_n and $s_{n,i}$ its cardinality. The generating polynomial of simple n-braids is denoted by $G_{\mathcal{SB}_n}(t) = \sum_{i=0}^{n-1} s_{n,i}t^i$. We are interested to count the number of simple braids $G_{\mathcal{SB}_n}(1)$.

Proposition 4.1. The sequence $(s_{n,i})$ is given by the recurrence: a) $s_{1,1} = 0$ and $s_{1,i} = 0$ for $i \neq 1$; b) $s_{n,i} = s_{n-1,i} + s_{n-1,i-1} + s_{n-2,i-2} + \ldots + s_{n-i,0}$.

Proof. The set \mathcal{SB}_n^i can be decomposed as disjoint union as follows: $\mathcal{SB}_n^i = \mathcal{SB}_{n-1}^i \amalg (\mathcal{SB}_{n-1}^{i-1} \times \{x_{n-1}\}) \amalg (\mathcal{SB}_{n-1}^{i-1} \times \{x_{n-1}x_{n-2}\}) \amalg \dots \amalg \{x_{n-1} \dots x_1\}.$

Corollary 4.2. The sequence $(s_{n,i})$ satisfies also the recurrence :

$$s_{n,i} = 2s_{n-1,i-1} + s_{n-1,i} - s_{n-2,i-1}.$$

Example 4.3. Starting with $s_{n,0} = 1$, $s_{n,1} = n - 1$, and using the recurrence of Proposition 4.1 we get $s_{n,2} = (n-1)(n+2)/2!$, $s_{n,3} = (n-3)(n+4)(n-1)/3!$ and $s_{n,4} = (n-4)(n+1)(n^2+5n-18)/4!$. Using the same recurrence we find that the

last non zero coefficient is $s_{n,n-1} = 2^{n-2}$ (if $n \ge 2$). First values of $s_{n,i}$ (on the *n*-th line) are given in the triangle:

Proposition 4.4. $s_{n,i}$ is a polynomial in n of degree i and leading coefficient is 1/i!.

Proof. The induction by *i* starts with $s_{n,0} = 1$ and $s_{n,1} = n - 1$. Using Proposition 4.1, we have

$$s_{n,i} - s_{n-1,i} = s_{n-1,i-1} + s_{n-2,i-2} + \ldots + s_{n-i,0}$$

where the sum is a polynomial in n of degree i-1 and leading coefficient 1/(i-1)!. This implies that $s_{n,i}$ is a polynomial in n of degree i and leading coefficient is 1/i!.

Proof of Theorem 1.4 By definition $G_{\mathcal{SB}_n}(1) = s_{n,0} + s_{n,1} + s_{n,2} + s_{n,n-2} + \ldots + s_{n,n-1}$. Using the recurrence given in Proposition 4.1, we expand $G_{\mathcal{SB}_n}(1) = \sum_{i=0}^{n-1} s_{n,i}$ and get

$$G_{\mathcal{SB}_n}(1) = 2G_{\mathcal{SB}_{n-1}}(1) + G_{\mathcal{SB}_{n-2}}(1) + G_{\mathcal{SB}_{n-3}}(1) + \ldots + G_{\mathcal{SB}_2}(1) + G_{\mathcal{SB}_1}(1).$$

Starting an induction with $G_{SB_1}(1) = 1 = F_1 = F_2$, $G_{SB_2}(1) = 2 = F_3$, $G_{SB_3}(1) = 5 = F_5$, we obtain

$$G_{\mathcal{SB}_n}(1) = 2F_{2n-3} + F_{2n-5} + \dots + F_5 + F_3 + F_2$$

= $2F_{2n-3} + F_{2n-5} + \dots + F_5 + F_4$
= \dots
= $2F_{2n-3} + F_{2n-5} + F_{2n-6} = 2F_{2n-3} + F_{2n-4}$
= $F_{2n-2} + F_{2n-3} = F_{2n-1}$.

5. Conjugacy classes of simple braids

A simple braid $\beta \in SB_n$ is conjugate to the braid

$$\beta_A = (x_1 x_2 \dots x_{s_1-1})(x_{s_1+1} \dots x_{s_2-1}) \dots (x_{s_{r-1}+1} \dots x_{s_r-1})$$

(i.e. there is a positive braid $\alpha \in \mathcal{MB}_n$ such that $\beta \alpha = \alpha \beta_A$); here $A = (a_1, a_2, \ldots, a_r)$ is a sequence of integers satisfying $a_1 \ge a_2 \ge \ldots \ge a_r \ge 2$ and $s_i = a_1 + a_2 + \ldots + a_i$. Conversely, if β_A and $\beta_{A'}$ are conjugate, then the sequences A and A' coincide (see [4]). The generating polynomial for distinct conjugate *n*-simple braid is denoted by $Cf_n(t) = \sum_{i=0}^{n-1} c_{n,i}t^i$, where $c_{n,i}$ is the number of conjugacy classes of positive simple braids of length *i*. A partition of a positive integer *m* is a representation of *m* in a form $m = m_1 + m_2 + \ldots + m_k$ where the integers m_1, m_2, \ldots, m_k satisfy the inequalities $m_1 \ge m_2 \ge \ldots \ge m_k \ge 1$. The number of partitions of *m* into *k* parts is denoted by P(m,k) (see [13]).

Proposition 5.1. The number of conjugacy classes of simple braids of length i is given by

$$c_{n,i} = P(i + \min(i, n - i), \min(i, n - i)).$$

Proof. Consider $\beta_A = (x_1x_2...x_{s_1-1})(x_{s_1+1}...x_{s_2-1})...(x_{s_{r-1}+1}...x_{s_r-1})$, the canonical representative of a conjugacy class in \mathcal{SB}_n , of length $i = s_r - r$. We associate to the sequence $A = (a_1 \ge a_2 \ge ...a_r)$ (here $a_r \ge 2$) the partition of i, $i = (a_1-1)+(a_2-1)+...(a_r-1)$. The condition $s_r = a_1+a_2+...+a_r \le n$ implies $i+r \le r$, therefore the number of conjugacy classes of simple braids of length i is given by the number of partitions of i into at most n-i parts:

$$c_{n,i} = P(i,1) + P(i,2) + \ldots + P(i,min(i,n-i)).$$

Using the relation $P(n + k, k) = \sum_{i=1}^{k} P(n, k)$ $(k \le n)$ (see [13]), we obtain the result.

6. Simple Graph

We consider the subgraph of the Cayley graph of the group \mathcal{B}_n with vertices the simple braids.

Definition 6.1. The simple graph Γ_{SB_n} is the graph with vertices SB_n and edges between the simple braids $\beta \leftrightarrow \beta x_i$ (i = 1, ..., n - 1). The number of vertices of Γ_{SB_n} is F_{2n-1} .

Proposition 6.2. The number of edges of the graph Γ_{SB_n} is:

$$e(\Gamma_{\mathcal{SB}_n}) = (n-1)s_{n,0} + (n-2)s_{n,1} + \ldots + s_{n,n-2}.$$

Proof. The number of edges between a vertex β of length i and vertices of length i+1, βx_j , is the number of letters x_j which are not in the simple braid β , and this number is n-1-i; this gives $(n-1-i)s_{n,i}$ edges between simple braids of length i and i+1.

Proposition 6.3. a) The graph Γ_{SB_n} is connected and n-partite. b) Γ_{SB_n} is planar if and only if $n \leq 6$. *Proof.* a) Any vertex $\beta = x_{i_1}x_{i_2}\ldots x_{i_k}$ is connected to the empty word 1 by the path $1-x_{i_1}-x_{i_1}x_{i_2}-\ldots-\beta$. The parts are given by simple braids of the same length. More generally, the Cayley graph of Coxeter groups are multipartite because multiplication by generators modifies the length of words with ± 1 .

b) The graph Γ_{SB_n} is canonically embedded in $\Gamma_{SB_{n+1}}$. The graph Γ_{SB_7} contains $K_{3,3}$ as a subgraph and Γ_{SB_6} has a planar imbedding, see the next pictures:







A $K_{3,3}$ subgraph of Γ_{SB_7}

The close relations between simple braids in \mathcal{SB}_n and the corresponding permutations in the symmetric group Σ_n and also the simple part of the permutahedron (the simple graph $\Gamma_{\mathcal{SB}_n}$ is its one dimensional skeleton) are studied in [5].
