ANALYTICITY AND UNIFORM STABILITY IN THE INVERSE SPECTRAL PROBLEM FOR DIRAC OPERATORS

Abstract. We prove that the inverse spectral mapping reconstructing the square integrable potentials on $[0, 1]$ of Dirac operators in the AKNS form from their spectral data (two spectra or one spectrum and the corresponding norming constants) is analytic and uniformly stable in a certain sense.

1. INTRODUCTION

The main goal of this paper is to establish analyticity and uniform continuity of solutions in the inverse spectral problems for a certain class of Dirac operators on the interval [0, 1]. Namely, we consider one-dimensional Dirac operators in the AKNS normal form [\[1\]](#page-16-0) generated by the differential expressions

$$
\ell_Q := \sigma_2 \frac{1}{i} \frac{d}{dx} + Q(x),
$$

with potentials

(1.1)
$$
Q(x) = q_1(x)\sigma_1 + q_3(x)\sigma_3.
$$

Here

$$
\sigma_1 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \quad \sigma_2 = \begin{pmatrix} 0 & -i \\ i & 0 \end{pmatrix}, \quad \sigma_3 = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}
$$

are the Pauli matrices and q_1 and q_2 are real-valued integrable functions that incorporate various physical characteristics of the particle considered (its mass m , the scalar potential, electrostatic potential, and anomalous magnetic moment, see [\[30,](#page-17-0) Ch. 4]). We assume that the potential is of bounded support and thus consider the Dirac operator on a bounded interval (which without loss of generality might be taken [0, 1]).

The Dirac equation has widely been used in various areas of physics and mathematics starting from 1929, when P. Dirac suggested it to model the evolution of spin- $\frac{1}{2}$ particles in the relativistic quantum mechanics [\[30\]](#page-17-0). In 1973 Ablowitz, Kaup, Newell, and Segur [\[1\]](#page-16-0) observed that the Dirac equation is related to a nonlinear wave equation (the "modified Korteweg–de Vries equation", a member of the AKNS–ZS hierarchy, see $[2, 33]$ $[2, 33]$ in the same manner as the Schrödinger equation is related to the KdV equations, and this discovery stimulated the increasing interest in direct and inverse problems for Dirac operators in both physical and mathematical literature. The topic was brought to life somewhat earlier; namely, in 1966, Gasymov and Levitan solved the inverse problems for Dirac operators on \mathbb{R}_+ by the spectral function [\[11\]](#page-17-1) and by the scattering phase [\[10\]](#page-17-2). Their investigations were continued and further developed in many directions. The reference list on the inverse spectral and scattering theory for Dirac operators has become very vast by now, and we only mention papers [\[3,](#page-16-2) [7,](#page-17-3)

[15,](#page-17-4) [25\]](#page-17-5) that contain extended bibliography on the topic. The books by Levitan and Sargsjan [\[24\]](#page-17-6) and by Thaller [\[30\]](#page-17-0) may serve as a good introduction into the (respectively mathematical and physical part of the) theory of Dirac operators.

In what follows, we fix $\theta_0, \theta_1 \in [0, \pi)$ and define the Dirac operator $\mathscr{D}(\theta_0, \theta_1, Q)$ in the Hilbert space $\mathbb{H} := L_2(0,1) \times L_2(0,1)$ as the restriction of ℓ_Q onto the domain

dom
$$
\mathscr{D}(\theta_0, \theta_1, Q) = \{ \mathbf{u} = (u_1, u_2)^{\dagger} \in \mathbb{H} \mid u_1, u_2 \in \text{AC}[0, 1],
$$

 $u_1(j) \cos \theta_j = u_2(j) \sin \theta_j, j = 0, 1 \}.$

It is well known that so defined operator $\mathscr{D}(\theta_0, \theta_1, Q)$ is self-adjoint and has a simple discrete spectrum tending to $\pm \infty$. In general, the spectrum of the operator $\mathscr{D}(\theta_0, \theta_1, Q)$ does not determine the potential Q. Indeed, there are only several analogues of the Ambartsumyan result for the Sturm–Liouville operators on a finite interval [\[4\]](#page-16-3), where the unperturbed Dirac operator (i.e., with $Q = 0$) is the only one having the specific spectrum; see [\[16,](#page-17-7)[23](#page-17-8)[,31\]](#page-17-9). To reconstruct the operator $\mathscr{D}(\theta_0, \theta_1, Q)$ in a generic situation some additional information is needed. For instance, the classical result of the inverse theory for the Dirac operators states that if we also know the spectrum of another operator $\mathscr{D}(\theta_0, \theta'_1, Q)$, with θ'_1 such that $\sin(\theta'_1 - \theta_1) \neq 0$, then two such spectra determine uniquely the potential Q in the AKNS form (1.1) .

For the sake of definiteness (and in order to avoid inessential technicalities), we choose the boundary conditions corresponding to $\theta_0 = \theta_1 = 0$ and $\theta'_1 = \pi/2$ and denote the operators $\mathscr{D}(0, 0, Q)$ and $\mathscr{D}(0, \pi/2, Q)$ by $\mathscr{D}_1(Q)$ and $\mathscr{D}_2(Q)$ respectively. If $Q \in L_2(0,1) \otimes \mathbb{C}^4$, then the eigenvalues $(\lambda_n)_{n \in \mathbb{Z}}$ and $(\mu_n)_{n \in \mathbb{Z}}$ of $\mathscr{D}_1(Q)$ and $\mathscr{D}_2(Q)$ respectively can be enumerated so that they satisfy the interlacing condition

$$
(1.2) \qquad \lambda_n < \mu_n < \lambda_{n+1}, \qquad n \in \mathbb{Z},
$$

and the asymptotics

(1.3)
$$
\lambda_n = \pi n + \lambda'_n,
$$

$$
\mu_n = \pi (n + \frac{1}{2}) + \mu'_n,
$$

where the remainders λ'_n and μ'_n form ℓ_2 -sequences; see [\[5,](#page-16-4) [24\]](#page-17-6). Conversely, it was shown in [\[3\]](#page-16-2) that any two sequence of real numbers that interlace and obey the asymp-totics [\(1.3\)](#page-1-0) are eigenvalues of the operators $\mathcal{D}_1(Q)$ and $\mathcal{D}_2(Q)$, for some real-valued potential Q in the AKNS form with L_2 -entries.

We thus have a well-defined mapping

$$
(1.4) \qquad \qquad ((\lambda_n), (\mu_n)) \mapsto Q
$$

from the spectral data $((\lambda_n),(\mu_n))$ of Dirac operators $\mathscr{D}_1(Q)$ and $\mathscr{D}_2(Q)$ to the corresponding potential Q in the AKNS form. A natural question arises, what properties this inverse spectral mapping has.

Unfortunately, we are not aware of any work where this topic has been explicitly studied. However, there have been many papers discussing the analogous question for Sturm–Liouville operators with integrable potentials; see [\[6,](#page-16-5) [8,](#page-17-10) [27,](#page-17-11) [28\]](#page-17-12) and the references cited in [\[19\]](#page-17-13). (We observe in passing that the case of Sturm–Liouville operators in impedance form considered in [\[6,](#page-16-5)[8,](#page-17-10)[18,](#page-17-14)[27\]](#page-17-11) is in a certain sense equivalent to the class of reduced Dirac operators with $q_3 = 0$; cf. [\[3\]](#page-16-2).) Adapting as necessary the corresponding proofs for the Sturm–Liouville operators, one can show that the inverse spectral problem is locally stable, i.e., that the potential Q depends continuously on the spectral data $((\lambda_n),(\mu_n))$. Here the metric on the set of the spectral data is induced by

that of $\ell_2 \times \ell_2$ on the elements $((\lambda'_n), (\mu'_n))$ with the λ'_n and μ'_n defined by [\(1.3\)](#page-1-0). More exactly (cf. [\[6,](#page-16-5) [27\]](#page-17-11) for the Sturm–Liouville case), this local stability means that, for a fixed $M > 0$, there are positive ε and L such that if $||Q_1||_{\mathbb{H}} \leq M$, $||Q_2||_{\mathbb{H}} \leq M$, and their spectral data $\nu_1 := ((\lambda_{1,n}), (\mu_{1,n}))$ and $\nu_2 := ((\lambda_{2,n}), (\mu_{2,n}))$ satisfy $\|\nu_1 - \nu_2\| \leq \varepsilon$, then

(1.5)
$$
||Q_1 - Q_2||_{\mathbb{H}} \leq L||\mathbf{v}_1 - \mathbf{v}_2||.
$$

Such a result cannot be considered satisfactory e.g. for the purpose of numerical reconstruction, as it refers to the norm of the potential Q to be recovered and thus specifies neither the allowed noise level ε nor the Lipschitz constant L. Therefore it is desirable to have a uniform stability that asserts [\(1.5\)](#page-2-0) whenever the spectral data ν_1 and ν_2 run through a bounded set $\mathcal N$ and with L only depending on $\mathcal N$.

Recently, such a uniform stability in the inverse spectral problem for Sturm–Liouville operators on [0, 1] was established by Shkalikov and Savchuk [\[29\]](#page-17-15). They considered operators with real-valued potentials from the Sobolev spaces $W_2^s(0,1)$ with $s > -1$; for negative s, such potentials are distributions. Their approach was based on a careful study of the nonlinear mapping of [\(1.4\)](#page-1-1) and used extensively the implicit function theorem. In our work [\[19\]](#page-17-13) we established analyticity and global stability of the inverse spectral mapping for $s \in [-1, 0]$ using a different approach that generalizes a classical method due to Gelfand and Levitan [\[12\]](#page-17-16) and Marchenko [\[26\]](#page-17-17) and has been successfully applied to reconstruction of Sturm–Liouville operators with singular potentials [\[20,](#page-17-18)[21\]](#page-17-19). In [\[18\]](#page-17-14), similar results were established for Sturm–Liouville operators in impedance form.

The main aim of this paper (Theorem [2.1\)](#page-4-0) is to prove analyticity and uniform continuity of the inverse spectral mapping $((\lambda_n),(\mu_n)) \mapsto Q$ for the class of the Dirac operators under consideration. In fact, we first establish these properties for the inverse problem of reconstructing Q from the eigenvalues of (λ_n) and the corresponding norming constants (α_n) introduced below (Theorem [2.2\)](#page-4-1), and then show that these norming constants depend analytically an Lipschitz continuously on two spectra, (λ_n) and (μ_n) . We use the approach to the inverse spectral problem for Dirac equation based on the Krein equation [\[3\]](#page-16-2) and further develop the methods of [\[19\]](#page-17-13).

We mention that the methods of [\[3\]](#page-16-2) could be used to treat the Dirac operators in AKNS form with real-valued potentials belonging to $L_p(0,1) \otimes \mathbb{C}^4$ with $p \in [1,\infty)$. However, apart from some technicalities caused by more complicated properties of the Fourier transform in $L_p(0,1)$ for $p \neq 2$ the approach would remain the same and we decided to sacrifice the generality to simplicity of presentation.

The paper is organised as follows. In the next section we introduce all the related objects, formulate the main results, and recall the approach to solution of the inverse spectral problem for Dirac operators in AKNS form based on the Gelfand–Levitan– Marchenko and Krein equations. In Section [3,](#page-6-0) we prove Theorem [2.2](#page-4-1) and in Section [4](#page-10-0) study dependence of the spectrum (μ_n) of the operator $\mathscr{D}_2(Q)$ on (λ_n) and (α_n) and then derive Theorem [2.1.](#page-4-0) Finally, three appendices discuss properties of special analytic mappings between Banach spaces and recall some facts on the special Banach algebra that are essentially used in the paper.

Notations. Throughout the paper, we shall denote by $\mathbb{L}_2(0,1)$ the set of all 2×2 potentials in the AKNS normal form; clearly, this space is unitarily equivalent to $L_2(0,1) \times L_2(0,1)$. Bold letters will usually denote vectors and functions with values in H, and $||f||$ and $||f||$ will stand for the $L_2(0, 1)$ -norm of a scalar function f and H-norm of the vector-valued function f, respectively.

2. Preliminaries and main results

In this section we state the main results and recall the method of solution of the inverse spectral problem based on the Gelfand–Levitan–Marchenko [\[24\]](#page-17-6) and Krein [\[3\]](#page-16-2) equations.

2.1. Spectral data. We denote by λ_n and μ_n , $n \in \mathbb{Z}$, the eigenvalues of the operators $\mathscr{D}_1(Q)$ and $\mathscr{D}_2(Q)$ respectively and recall that these eigenvalues interlace, i.e., λ_n < $\mu_n < \lambda_{n+1}$ for all $n \in \mathbb{Z}$, and satisfy the relations

$$
\lambda_n = \pi n + \rho_{2n},
$$
\n $\mu_n = \pi (n + \frac{1}{2}) + \rho_{2n+1}$

with some ℓ_2 -sequence (ρ_n) .

The equation $\ell_{Q} \mathbf{u} = \lambda \mathbf{u}, \mathbf{u} = (u_1, u_2)^t$, subject to the initial conditions $u_1(0) = 0$, $u_2(0) = 1$ has the solution

(2.1)
$$
\mathbf{s}(x,\lambda) = \mathbf{s}_0(x,\lambda) + \int_0^x K(x,t)\mathbf{s}_0(t,\lambda) ds,
$$

where $\mathbf{s}(x,\lambda) := (s_1(x,\lambda), s_2(x,\lambda))^{\dagger}, \ \mathbf{s}_0(x,\lambda) := (\sin \lambda x, \cos \lambda x)^{\dagger} \text{ and } K =: (k_{jl})_{j,l=1}^2$ is the kernel of the transformation operator. Further, $s(\cdot, \lambda_n)$ is an eigenfunction corresponding to the eigenvalue λ_n of the operator $\mathscr{D}_1(Q)$, and we call the number $\alpha_n := ||\mathbf{s}(\cdot, \lambda_n)||^{-2}$ the *norming constant* for this eigenvalue. It is known that

$$
\alpha_n = 1 + \alpha'_n,
$$

where the sequence $(\alpha'_n)_{n\in\mathbb{Z}}$ belongs to $\ell_2 := \ell_2(\mathbb{Z})$. Moreover, the norming constants α_n can be determined from the spectra of the operators $\mathcal{D}_1(Q)$ and $\mathcal{D}_2(Q)$ as follows.

We set $S(\lambda) := s_1(1, \lambda)$ and $C(\lambda) := s_2(1, \lambda)$; due to [\(2.1\)](#page-3-0) these are entire functions of exponential type 1 with zeros λ_n and μ_n respectively. The Hadamard canonical products of S and C are

(2.2)
$$
S(z) = (z - \lambda_0) \text{V.p.} \prod_{n = -\infty}^{\infty} \frac{\lambda_n - z}{\pi n}, \qquad C(z) = \text{V.p.} \prod_{n = -\infty}^{\infty} \frac{\mu_n - z}{\pi (n + \frac{1}{2})}
$$

(the prime denoting that the factor corresponding to $n = 0$ is omitted), so that S and C are uniquely determined by their zeros. Then we have [\[3\]](#page-16-2)

(2.3)
$$
\alpha_n = \frac{1}{\dot{S}(\lambda_n)C(\lambda_n)},
$$

where the dot denotes the derivative in z.

2.2. Main results. We introduce the set $\mathscr N$ of data $((\lambda_n)_{n\in\mathbb Z}, (\mu_n)_{n\in\mathbb Z})$ with the following properties:

- • the sequences (λ_n) and (μ_n) strictly interlace, i.e., $\lambda_n < \mu_n < \lambda_{n+1}$ for all $n \in \mathbb{Z}$;
- the sequence $(\rho_k)_{k\in\mathbb{Z}}$, with $\rho_{2n} := \lambda_n \pi n$ and $\rho_{2n+1} := \mu_n \pi (n + \frac{1}{2})$ $(\frac{1}{2})$, belongs to ℓ_2 .

In this way every element $\boldsymbol{\nu} := ((\lambda_n), (\mu_n))$ of $\mathscr N$ is identified with a sequence (ρ_n) in ℓ_2 thus inducing a metric on $\mathscr N$.

According to [\[3\]](#page-16-2), every element of $\mathcal N$ gives the eigenvalue sequences of the operators $\mathcal{D}_1(Q)$ and $\mathcal{D}_2(Q)$ corresponding to a unique real-valued AKNS potential $Q \in \mathbb{L}_2(0,1)$ and, conversely, for every real-valued $Q \in \mathbb{L}_2(0,1)$ of the form (1.1) the spectra of the corresponding Dirac operators form an element of $\mathcal N$. When the AKNS potential Q varies over a bounded subset of $\mathbb{L}_2(0, 1)$, then the corresponding spectral data

 $((\lambda_n),(\mu_n))$ remain in a bounded subset of N. Moreover, the Prüfer angle technique yields then a positive h such that all the corresponding spectral data $((\lambda_n),(\mu_n))$ are h-separated, i.e., that $\mu_{n+1} - \lambda_n \geq h$ and $\lambda_n - \mu_n \geq h$ for every $n \in \mathbb{N}$. Summarizing, we conclude that the uniform stability of the inverse spectral problem we would like to establish is only possible on the convex closed sets $\mathcal{N}(h,r)$ of spectral data consisting of all elements of N that are h-separated and satisfy $\|(\rho_n)\|_{\ell_2} \leq r$.

In these notations, the first main results of the paper reads as follows.

Theorem 2.1. *For every* $h \in (0, \pi/2)$ *and* $r > 0$ *, the inverse spectral mapping*

$$
\mathcal{N}(h,r) \ni \nu \mapsto Q \in \mathbb{L}_2(0,1)
$$

is analytic and Lipschitz continuous.

In fact, as in [\[19\]](#page-17-13), we prove first the analyticity and Lipschitz continuity of the inverse spectral problem of reconstructing Q from the Dirichlet spectrum (λ_n) and the norming constants (α_n) (see Theorem [2.2](#page-4-1) below), and then derive Theorem [2.1](#page-4-0) by showing that the norming constants depend analytically and Lipschitz continuously on the two spectra.

More exactly, we denote by $\mathscr L$ the family of strictly increasing sequences $\lambda := (\lambda_n)$ such that $\rho_{2n} := \lambda_n - \pi n$ forms an element of ℓ_2 and pull back the topology on $\mathscr L$ from that of ℓ_2 by identifying such λ with $(\rho_{2n}) \in \ell_2$. For $h \in (0, \pi)$ and $r > 0$, we denote by $\mathscr{L}(h,r)$ the closed convex subset of \mathscr{L} consisting of sequences $(\lambda_n)_{n\in\mathbb{Z}}$ with $\lambda_{n+1} - \lambda_n \geq h$, and such that $\|(\rho_{2n})\|_{\ell_2} \leq r$. Next, we write $\mathscr A$ for the set of sequences $\alpha := (\alpha_n)_{n \in \mathbb{N}}$ of positive numbers (α_n) such that the sequence (β_n) with $\beta_n := \alpha_n - 1$ belongs to ℓ_2 . This induces the topology of ℓ_2 on $\mathscr A$; we further consider closed subsets $\mathscr{A}(h,r)$ of $\mathscr A$ consisting of all (α_n) such that $\alpha_n \geq h$ for all $n \in \mathbb N$ and $\|(\beta_n)\|_{\ell_2} \leq r$.

It is known that, given an element $(\lambda, \alpha) \in \mathscr{L} \times \mathscr{A}$, there is a unique $Q \in \mathbb{L}_2(0, 1)$ in the AKNS normal form such that λ is the sequence of eigenvalues and α the sequence of norming constants for the Dirac operator $\mathcal{D}_1(Q)$. Some further properties of the induced mapping are described in the following theorem.

Theorem 2.2. For every $h \in (0, \pi)$ and every positive h' , r , and r' , the inverse spectral *mapping*

$$
\mathscr{L}(h,r)\times\mathscr{A}(h',r')\ni(\pmb{\lambda},\pmb{\alpha})\mapsto Q\in\mathbb{L}_2(0,1)
$$

is analytic and Lipschitz continuous.

2.3. Solution of the inverse spectral problem via the GLM and Krein equations. The Gelfand–Levitan–Marchenko equation relates the spectral data for the operator $\mathcal{D}_1(Q)$ (i.e., its eigenvalues and norming constants) with the transformation operator $\mathscr{I} + \mathscr{K}$. To derive it, we start with the resolution of identity for $\mathscr{D}_1(Q)$,

$$
\mathscr{I} = \operatorname*{slim}_{N \to \infty} \sum_{n=-N}^{N} \alpha_n(\cdot, \mathbf{s}_n)_{\mathbb{H}} \mathbf{s}_n,
$$

where s-lim stands for the limit in the strong operator topology and $\mathbf{s}_n(x) := \mathbf{s}(x, \lambda_n)$. Recalling that $\mathbf{s}_n = (\mathscr{I} + \mathscr{K}) \mathbf{s}_{0,n}$ with $\mathbf{s}_{0,n}(x) = \mathbf{s}_0(x, \lambda_n)$, we get

(2.4)
$$
\mathscr{I} = (\mathscr{I} + \mathscr{K}) \Big[\lim_{N \to \infty} \sum_{n=1}^{N} \alpha_n(\cdot, \mathbf{s}_{0,n}) \mathbb{H} \mathbf{s}_{0,n} \Big] (\mathscr{I} + \mathscr{K}^*).
$$

The operator in the square brackets has the form $\mathscr{I} + \mathscr{F}$, where \mathscr{F} is an integral operator of Hilbert–Schmidt class with kernel

(2.5)
$$
F(x,t) := \frac{1}{2} \left[H(\frac{x-t}{2}) - H(\frac{x+t}{2}) \sigma_3 \right],
$$

and

(2.6)
$$
H(s) := \text{V.p.} \sum_{n=-\infty}^{\infty} \left(\alpha_n e^{2\lambda_n i s \sigma_2} - e^{2\pi n i s \sigma_2} \right).
$$

Applying $({\mathscr I} + {\mathscr K}^*)^{-1}$ to both sides of [\(2.4\)](#page-4-2) and rewriting the resulting relation in terms of the kernels K and F, we get the Gelfand–Levitan–Marchenko (GLM) equation

(2.7)
$$
K(x,t) + F(x,t) + \int_0^x K(x,s)F(s,t) ds = 0, \qquad x \ge y.
$$

If the potential Q is continuous, then the algorithm for reconstructing Q from the spectral data $((\lambda_n),(\mu_n))$ proceeds as follows, cf. [\[24\]](#page-17-6). We first calculate numbers α_n via (2.3) , then construct a matrix-function H of (2.6) , form the kernel F of (2.5) , solve the GLM equation [\(2.7\)](#page-5-2), and finally set

(2.8)
$$
Q(x) = K(x, x)\frac{1}{i}\sigma_2 - \frac{1}{i}\sigma_2 K(x, x).
$$

If the potential Q is only assumed to be in $\mathbb{L}_2(0,1)$, then the kernel K has the property that $K(x, \cdot)$ and $K(\cdot, x)$ are square-integrable matrix-functions depending continuously in $L_2(0,1) \otimes \mathbb{C}^4$ on $x \in [0,1]$. In particular, K may not have well defined restriction $K(x, x)$ on the diagonal and thus the above-described method cannot be used.

To overcome this obstacle, we consider, along with the GLM equation, the Krein equation

(2.9)
$$
R(x,t) + H(x-t) + \int_0^x R(x,s)H(s-t) ds = 0, \qquad 0 \le t \le x \le 1.
$$

It is easily seen that if R is a solution to this equation, then

$$
K(x,t) := \frac{1}{2} \big[R(x, \frac{x+t}{2}) - R(x, \frac{x-t}{2}) \sigma_3 \big]
$$

solves the GLM equation, and in this sense the Krein equation is more general. The kernel R generates another transformation operator in the sense that

(2.10)
$$
\mathbf{s}(x,\lambda) = \mathbf{s}_0(x,\lambda) + \int_0^x R(x,x-t)\mathbf{s}_0(x-2t,\lambda) ds.
$$

Moreover, as soon as the related convolution operator

(2.11)
$$
\mathscr{H}\mathbf{u}(x) := \int_0^1 H(x-t)\mathbf{u}(t) dt
$$

satisfies the inequality $\mathscr{I} + \mathscr{H} > 0$ in $L_2(0,1) \times \mathbb{C}^4$, the Krein equation can be shown to possess a unique solution R and this solution has the property that $R(\cdot, t)$ belongs to $L_2(0,1) \otimes \mathbb{C}^4$ and depends continuously therein on $t \in [0,1]$. Now, rewriting the relation (2.8) in terms of R, we find that

(2.12)
$$
Q(x) = -R(x,0)\sigma_1.
$$

This formula defines Q as an $L_2(0, 1) \otimes \mathbb{C}^4$ -valued function and will be the basis of our reconstruction algorithm.

3. Stability of the inverse spectral problem: norming constants

In this section, we prove Theorem [2.2](#page-4-1) on uniform stability of the inverse spectral problem of reconstructing the potential Q of a Dirac operator $\mathcal{D}_1(Q)$ from its spectrum and norming constants.

We shall study the correspondence between the data $(\lambda, \alpha) \in \mathscr{L}(h, r) \times \mathscr{A}(h', r')$ and the potentials Q in the AKNS form of the Dirac operator $\mathcal{D}_1(Q)$ through the chain

$$
(\lambda, \alpha) \mapsto H \mapsto R \mapsto Q,
$$

in which H is the matrix-valued function of (2.6) , R is the matrix-function solving the Krein equation (2.9) , and, finally, Q is given by (2.12) .

Lemma 3.1. *The mapping*

$$
\mathscr{L}(h,r)\times\mathscr{A}(h',r')\ni(\boldsymbol{\lambda},\boldsymbol{\alpha})\mapsto H\in L_2(-1,1)\otimes\mathbb{C}^4
$$

is analytic and Lipschitz continuous.

Proof. Since the matrix B has simple eigenvalues $\pm i$, it is unitarily equivalent to the matrix diag $\{i, -i\}$, and thus H is unitarily equivalent to the matrix-function $diag\{h(s), h(-s)\}\$, where

(3.1)
$$
h(s) := V.p. \sum_{n=-\infty}^{\infty} (\alpha_n e^{2\lambda_n is} - e^{2\pi n is}).
$$

We thus need to prove that the mappings

$$
\mathscr{L}(h,r) \times \mathscr{A}(h',r') \ni (\lambda, \alpha) \mapsto h(\pm s) \in L_2(-1,1)
$$

are analytic and Lipschitz continuous. It clearly suffices to consider only the case of $h(s)$; also, since the α_n and λ_n are real, we get $h(-s) = \overline{h(s)}$, and only the restriction of h onto $(0, 1)$ need to be studied.

We have $h = h_{\lambda} + h_{\lambda,\alpha}$, where

$$
h_{\lambda}(s) := \mathcal{V} \cdot \mathcal{p} \cdot \sum_{n=-\infty}^{\infty} [e^{2\rho_{2n}is} - 1] e^{2\pi nis}, \qquad h_{\lambda,\alpha}(s) := \mathcal{V} \cdot \mathcal{p} \cdot \sum_{n=-\infty}^{\infty} \beta_n e^{2\lambda_n is}.
$$

We recall that the numbers $\beta_n := \alpha_n - 1$ and $\rho_{2n} = \lambda_n - \pi n$ form sequences in ℓ_2 that induce the topology of $\mathscr L$ and $\mathscr A$. The series

V.p.
$$
\sum_{n \in \mathbb{Z}} \rho_{2n} e^{2\pi n i s}
$$
 and V.p. $\sum_{n \in \mathbb{Z}} \beta_n e^{2\pi n i s}$

converge in $L_2(0, 1)$, and we denote by f_{λ} and g_{α} respectively the corresponding sums. Since the sequence of functions $(e^{2\pi n i s})_{n\in\mathbb{Z}}$ forms an orthonormal basis of $L_2(0, 1)$, the mappings $(\rho_{2n}) \mapsto f_{\lambda}$ and $(\beta_n) \mapsto g_{\alpha}$ are unitary isomorphisms between $\ell_2(\mathbb{Z})$ and $L_2(0, 1)$ given by the inverse Fourier transform. Therefore we have $h_{\lambda} = g(f_{\lambda})$ and $h_{\lambda,\alpha} = \Phi(f_{\lambda}, g_{\alpha})$ with the mappings $g(f)$ and $\Phi(f,g)$ introduced in Appendix [B.](#page-14-0) The claim now follows from the properties of $g(f)$ and $\Phi(f, g)$ established in Lemmata [B.1](#page-14-1) and [B.2](#page-15-0) respectively.

Solubility of the Krein equation crucially relies on the following property of the convolution operator \mathscr{H} .

Lemma 3.2. For every $h \in (0, \pi)$, $h' \in (0, 1)$, and positive r and r', there exists $\varepsilon > 0$ *with the following property: if* (λ, α) *is an arbitrary element of* $\mathscr{L}(h,r) \times \mathscr{A}(h_1,r_1)$ and H is the function of (2.6) , then for the corresponding convolution operator $\mathcal H$ we *have* $\mathscr{I} + \mathscr{H} \geq \varepsilon \mathscr{I}$.

Proof. Denote by \mathscr{H}_{\pm} the convolution operators in $L_2(0,1)$ constructed as in [\(2.11\)](#page-5-6) but for the scalar functions $h(\pm s)$ of [\(3.1\)](#page-6-1). Transforming H to the diagonal form as in the proof of the previous lemma, we see that it suffices to prove that there is $\varepsilon > 0$ independent of (λ, α) such that $I + \mathcal{H}_+ \geq \varepsilon I$. We shall only treat the case of the operator $I + \mathcal{H}_+$, as the other case is completely analogous.

Since the system $(e^{2\pi n i s})_{n\in\mathbb{Z}}$ is an orthonormal basis of $L_2(0,1)$, we find that

$$
((I + \mathcal{H}_{+})f, f) = (f, f) + \lim_{k \to \infty} \sum_{n=-k}^{k} [\alpha_{n} | (f, e^{2\lambda_{n}is})|^{2} - |(f, e^{2\pi nis})|^{2}]
$$

$$
= \text{V.p.} \sum_{n=-\infty}^{\infty} \alpha_{n} | (f, e^{2\lambda_{n}is})|^{2}.
$$

The inclusion $\alpha \in \mathscr{A}(h', r')$ implies that $\alpha_n \geq h'$ for all $n \in \mathbb{Z}$. It follows from the results of [\[13,](#page-17-20) Ch. VI], [\[32,](#page-18-1) Ch. 4] that the system $\mathscr{E}_{\lambda} := (e^{2\lambda_n is})_{n \in \mathbb{Z}}$ is a Riesz basis of $L_2(0, 1)$; moreover, there exists $m = m(h, r) > 0$ that gives a lower bound of \mathscr{E}_{λ} for every $\lambda \in \mathscr{L}(h,r)$ [\[17\]](#page-17-21). Therefore,

$$
((I + \mathcal{H}_+)f, f) = \mathcal{V} \cdot \mathcal{V} \cdot \sum_{n = -\infty}^{\infty} \alpha_n |(f, e^{2\lambda_n i s})|^2 \ge h' \mathcal{V} \cdot \mathcal{V} \cdot \sum_{n = -\infty}^{\infty} |(f, e^{2\lambda_n i s})|^2 \ge h'm \|f\|^2.
$$

The proof is complete.

To study solvability of the Krein equation [\(2.9\)](#page-5-4), we shall regard it as a relation between the corresponding integral operators. To this end we recall several notions that will be used. By definition, the ideal $\mathfrak{S}_2 = \mathfrak{S}_2(\mathbb{H})$ of Hilbert–Schmidt operators consists of integral operators $\mathscr T$ in $\mathbb H$ whose kernels T satisfy the inequality

$$
\int_0^1 \int_0^1 \operatorname{tr}\bigl(T(x,y)T^*(y,x)\bigr) dx dy < \infty;
$$

here tr stands for the trace of a matrix or a trace-class operator. Notice that if $T =$ $(T_{ij})_{i,j=1}^2$, then

$$
\operatorname{tr} TT^* = \sum_{i,j=1}^2 |T_{ij}|^2,
$$

i.e., the operators in \mathfrak{S}_2 have kernels whose entries are square integrable in $\Omega = (0,1) \times$ $(0, 1)$. The linear set \mathfrak{S}_2 becomes a Hilbert space under the scalar product

$$
\langle \mathcal{X}, \mathcal{Y} \rangle_2 := \text{tr}(\mathcal{X} \mathcal{Y}^*) = \int_0^1 \int_0^1 \text{tr}\big(X(x, y)Y^*(y, x)\big) dx dy
$$

As noticed above, the matrix-valued function H satisfies the relation $H^*(s) = H(-s)$ and $H(s)$ is unitarily equivalent to the diagonal matrix diag $\{h(s), h(-s)\}\$. Therefore,

$$
\int_0^1 \operatorname{tr} H(x - y) H^*(x - y) dx = \int_0^1 |h(x - y)|^2 dx + \int_0^1 |h(y - x)|^2 dx
$$

$$
\leq 2 \int_{-1}^1 |h(s)|^2 ds,
$$

so that the convolution operator \mathscr{H} belongs to \mathfrak{S}_2 and its norm satisfies $\|\mathscr{H}\|_{\mathfrak{S}_2}^2 =$ $\langle \mathcal{H}, \mathcal{H} \rangle_2 \leq 4 ||h||^2_{L_2(0,2)}.$

Denote by \mathfrak{S}_2^+ the subspace of \mathfrak{S}_2 consisting of all Hilbert–Schmidt operators with lower-triangular kernels. In other words, $\mathscr{T} \in \mathfrak{S}_2$ belongs to \mathfrak{S}_2^+ if the kernel T of \mathscr{T} satisfies $T(x, y) = 0$ for $0 \le x < y \le 1$. For an arbitrary $\mathscr{T} \in \mathfrak{S}_2$ with kernel T the cut-off T^+ of T given by

$$
T^+(x,y) = \begin{cases} T(x,y) & \text{for } x \ge y \\ 0 & \text{for } x < y \end{cases}
$$

generates an operator $\mathscr{T}^+ \in \mathfrak{S}_2^+$, and the corresponding mapping $\mathfrak{P}^+ : \mathscr{T} \mapsto \mathscr{T}^+$ turns out to be an orthoprojector in \mathfrak{S}_2 onto \mathfrak{S}_2^+ , i.e. $(\mathfrak{P}^+)^2 = \mathfrak{P}^+$ and $\langle \mathfrak{P}^+ \mathscr{X}, \mathscr{Y} \rangle_2 =$ $\langle \mathcal{X}, \mathfrak{P}^{\dagger} \mathcal{Y} \rangle_2$ for any $\mathcal{X}, \mathcal{Y} \in \mathfrak{S}_2$; see details in [\[14,](#page-17-22) Ch. I.10].

With these notations, the Krein equation (2.9) for the kernels R and H can be recast as the relation between the corresponding Hilbert–Schmidt integral operators

(3.2)
$$
\mathscr{R} + \mathfrak{P}^+ \mathscr{H} + \mathfrak{P}^+ (\mathscr{R} \mathscr{H}) = 0
$$

or

$$
(\mathfrak{I}+\mathfrak{P}^+_{\mathscr{H}})\mathscr{R}=-\mathfrak{P}^+\mathscr{H},
$$

where \mathfrak{P}_x^+ is the linear operator in \mathfrak{S}_2 defined by $\mathfrak{P}_x^+\mathscr{Y}=\mathfrak{P}^+(\mathscr{Y}\mathscr{X})$ and \mathfrak{I} is the identity operator in \mathfrak{S}_2 . Therefore solvability of the Krein equation and continuity of its solutions on $\mathscr H$ is strongly connected with the properties of the operator $\mathfrak P^+_{\mathscr H}$.

Lemma 3.3. For every $\mathscr{X} \in \mathscr{B}(\mathcal{H})$, the operator $\mathfrak{P}^+_{\mathscr{X}}$ is bounded in \mathfrak{S}_2 . Moreover, *for every* $\mathscr H$ *from the set*

$$
\mathfrak{H} := \{ \mathscr{H} = \mathscr{H}(\lambda, \alpha) \mid (\lambda, \alpha) \in \mathscr{L}(h, r) \times \mathscr{A}(h', r') \} \subset \mathfrak{S}_2
$$

the operator $\mathfrak{I} + \mathfrak{P}_{\mathscr{H}}^{+}$ *is invertible in* $\mathscr{B}(\mathfrak{S}_{2}^{+})$ *and the inverse* $(\mathfrak{I} + \mathfrak{P}_{\mathscr{H}}^{+})$ *depends analytically and Lipschitz continuously on* $\mathcal{H} \in \mathfrak{H}$ *in the topology of* \mathfrak{S}_2 *.*

Proof. Boundedness of $\mathfrak{P}_{\mathcal{X}}^{+}$ is a straightforward consequence of the inequality

$$
\|\mathfrak{P}^+_{\mathscr{X}}\mathscr{Y}\|_{\mathfrak{S}_2}\leq \|\mathscr{Y}\mathscr{X}\|_{\mathfrak{S}_2}\leq \|\mathscr{X}\|_{\mathscr{B}(\mathbb{H})}\|\mathscr{Y}\|_{\mathfrak{S}_2}
$$

,

cf. [\[13,](#page-17-20) Ch. 3]. Assume next that $\mathscr{I} + \mathscr{X} \geq \varepsilon \mathscr{I}$ in \mathbb{H} ; then for $\mathscr{Y} \in \mathfrak{S}_2^+$ we find that

$$
\langle (\mathfrak{I} + \mathfrak{P}_{\mathcal{X}}^+) \mathscr{Y}, \mathscr{Y} \rangle_2 = \langle \mathscr{Y}, \mathscr{Y} \rangle_2 + \langle \mathscr{Y} \mathscr{X}, \mathscr{Y} \rangle_2 = \text{tr}(\mathscr{Y}(\mathscr{I} + \mathscr{X}) \mathscr{Y}^*).
$$

Since $\mathscr{Y}(\mathscr{I} + \mathscr{X})\mathscr{Y}^* \geq \varepsilon \mathscr{Y} \mathscr{Y}^*$ and the trace is a monotone functional, we get

$$
\langle (\mathfrak{I} + \mathfrak{P}_{\mathscr{X}}^+) \mathscr{Y}, \mathscr{Y} \rangle_2 \geq \varepsilon \langle \mathscr{Y}, \mathscr{Y} \rangle_2,
$$

i.e., $\mathfrak{I} + \mathfrak{P}_{\mathscr{X}}^+ \geq \varepsilon \mathfrak{I}$ in \mathfrak{S}_2^+ .

Applying now Lemma [3.2,](#page-7-0) we conclude that for every $\mathscr{H} \in \mathfrak{H}$ it holds $\mathfrak{I} + \mathfrak{P}_{\mathscr{H}}^+ \geq \varepsilon \mathfrak{I}$ with ε of that lemma depending only on h, h', r, and r'; therefore, $\mathfrak{I}+\mathfrak{P}_{\mathscr{H}}^{+}$ is boundedly invertible in $\mathscr{B}(\mathfrak{S}_2^+)$ and

$$
\left\|(\mathfrak{I}+\mathfrak{P}_{\mathscr{H}}^+)^{-1}\right\| \leq \varepsilon^{-1}.
$$

Since $\mathfrak{P}^+_{\mathscr{H}}$ depends linearly on \mathscr{H} , it follows that the mapping $\mathscr{H} \mapsto (\mathfrak{I} + \mathfrak{P}^+_{\mathscr{H}})^{-1}$ from \mathfrak{S}_2 into $\mathscr{B}(\mathfrak{S}_2^+)$ is analytic and Lipschitz continuous on the set \mathfrak{H} . The proof is \Box complete. \Box

Corollary 3.4. For every $\mathcal{H} \in \mathfrak{H}$, the Krein equation [\(2.9\)](#page-5-4) has a unique solution

$$
\mathscr{R} := -(\mathfrak{I} + \mathfrak{P}_{\mathscr{H}}^+)^{-1} \mathfrak{P}^+ \mathscr{H} \in \mathfrak{S}_2^+;
$$

moreover, \mathcal{R} depends analytically and Lipschitz continuously in \mathfrak{S}_2^+ on $\mathcal{H} \in \mathfrak{H} \subset \mathfrak{S}_2$.

It follows that the kernel $R(x, t)$ of $\mathscr R$ is square integrable in the domain Ω and depends analytically and Lipschitz continuously in $L_2(\Omega) \otimes \mathbb{C}^4$ on \mathscr{H} . However, we need to know that $R(x, 0)$ is well defined and belongs to $L_2(0, 1) \otimes \mathbb{C}^4$.

To this end we use the Krein equation to show that

$$
R(x,t) = -H(x-t) - \int_0^1 R(x,s)H(s-t) \, ds
$$

as a function of x depends continuously in $L_2(\Omega) \times \mathbb{C}^4$ on $t \in [0,1]$. Since the shift $f(\cdot) \mapsto f(\cdot-t)$ is a continuous operation in $L_2(\mathbb{R})$, $H(\cdot-t)$ enjoys the required property. Denote by R_{ij} and H_{ij} , $i, j = 1, 2$, the entries of the matrix-valued functions R and H respectively. They belong to $L_2(\Omega)$ since the corresponding integral operators $\mathscr R$ and \mathscr{H} are in \mathfrak{S}_2 ; therefore,

(3.3)

$$
\int_0^1 \left| \int_0^1 R_{ij}(x,s) H_{jk}(s-t) ds \right|^2 dx
$$

$$
\leq \int_0^1 dx \int_0^1 |R_{ij}(x,s)|^2 ds \int_0^1 |H_{jk}(s-t)|^2 ds
$$

$$
\leq \int_{-1}^1 |H_{jk}(s)|^2 ds \int_0^1 \int_0^1 |R_{ij}(x,s)| ds dx < \infty.
$$

Thus the function

(3.4)
$$
\int_0^1 R_{ij}(x,s)H_{jk}(s-t) \, ds
$$

of the variable $x \in [0, 1]$ belongs to $L_2(0, 1)$; moreover, continuity of the shifts $H_{jk}(-t)$ and estimate [\(3.3\)](#page-9-0) show that function [\(3.4\)](#page-9-1) depends continuously in $L_2(0,1)$ on $t \in$ [0, 1]. Since the entries of the matrix $\int_0^1 R(x,s)H(s-t) ds$ are sums of functions [\(3.4\)](#page-9-1) for corresponding indices i, j and k, we conclude that $R(\cdot, t)$ indeed depends continuously in $L_2(0,1) \otimes \mathbb{C}^4$ on $t \in [0,1]$. In particular, $R(\cdot,0)$ is a well-defined function in $L_2(0,1)\otimes\mathbb{C}^4.$

Proof of Theorem [2.2.](#page-4-1) The above arguments show that it is legitimate to take $t = 0$ in the Krein equation; thus we get that

$$
R(x, 0) = -H(x) - \int_0^1 R(x, s)H(s) ds.
$$

The right-hand side is a bilinear expression in H and R . In view of the analytic dependence of $\mathscr R$ onto $\mathscr H$ stated in Corollary [3.4](#page-9-2) and estimates [\(3.3\)](#page-9-0), this yields analyticity and Lipschitz continuity of $R(x, 0)$ on $H \in L_2(-1, 1) \otimes \mathbb{C}^4$. By [\(2.12\)](#page-5-5) the function Q enjoys the same properties, and the proof is complete.

4. Reconstruction from two spectra

We recall that the norming constants α_n for the Dirac operator $\mathscr{D}_1(Q)$ can be determined from the spectra (λ_n) and (μ_n) of $\mathscr{D}_1(Q)$ and $\mathscr{D}_2(Q)$ by the formula

$$
\alpha_n = \frac{1}{\dot{S}(\lambda_n)C(\lambda_n)},
$$

where the entire functions S and C are given by the canonical products [\(2.2\)](#page-3-2) over λ_n $((\lambda_n),(\mu_n))\in\mathcal{N}$ into the norming constants $\alpha:=(\alpha_n)\in\mathcal{A}$. In this section, we shall and μ_n respectively. This induces a mapping $\nu \mapsto \alpha$ from the spectral data $\nu :=$ establish Theorem [2.1](#page-4-0) by proving the following result.

Theorem 4.1. For every $h \in (0, \pi/2)$ and $r > 0$, the mapping

(4.1)
$$
\mathcal{N}(h,r) \ni \nu \mapsto \alpha \in \mathscr{A}
$$

is analytic and Lipschitz continuous; moreover, there exist positive constants h' and r' such that the range of this mapping belongs to $\mathscr{A}(h', r')$.

By definition, $\mathscr A$ consists of elements of the commutative unital Banach algebra A introduced in Appendix [C.](#page-16-6) We observe that the metrics on $\mathscr A$ agrees with the norm of A, and thus the results of Appendix [C](#page-16-6) yield the following statement.

Proposition 4.2. For every positive h and r, the set $\mathscr{A}(h,r)$ consists of invertible *elements of A. Moreover, the mapping* $\alpha \mapsto \alpha^{-1}$ *is analytic and Lipschitz continuous in A on* $\mathscr{A}(h,r)$ *, and its range lies in* $\mathscr{A}((1+r)^{-1}, rh^{-1})$ *.*

In view of Proposition [4.2,](#page-10-1) it suffices to prove Theorem [4.1](#page-10-2) with α replaced by α^{-1} . The elements of the sequence α^{-1} are $\alpha_n^{-1} = \dot{S}(\lambda_n)C(\lambda_n)$. We shall show that the sequences

$$
\boldsymbol{\gamma}:=\big((-1)^n\dot{S}(\lambda_n)\big)_{n\in\mathbb{Z}},\qquad \boldsymbol{\delta}:=\big((-1)^nC(\lambda_n)\big)_{n\in\mathbb{Z}}
$$

form elements of $\mathscr A$. Thus Theorem [4.1](#page-10-2) will be proved if we show that the mappings

(4.2)
$$
\mathcal{N}(h,r) \ni \nu \mapsto \gamma \in \mathscr{A}, \qquad \mathcal{N}(h,r) \ni \nu \mapsto \delta \in \mathscr{A}
$$

enjoy the properties required for the mapping [\(4.1\)](#page-10-3).

To begin with, integral representation [\(2.10\)](#page-5-7) of the solution $s(\cdot, \lambda)$ yields the formulae

(4.3)
$$
S(\lambda) = \sin \lambda + \int_0^1 r_1(s) e^{i\lambda(1-2s)} ds,
$$

(4.4)
$$
C(\lambda) = \cos \lambda + \int_0^1 r_2(s) e^{i\lambda(1-2s)} ds
$$

for the functions S and C . Here r_1 and r_2 are some (uniquely defined) functions in $L_2(0, 1)$ formed from the entries of the matrix-valued function $R(1, 1-x)$. Therefore both S and C can be recast in the form

$$
\cos \lambda + \int_0^1 g(s)e^{i\lambda(1-2s)} ds
$$

with $g(s) = i(1-2s)r_1(s)$ for S and $g(s) = r_2(s)$ for C. The sequences γ and δ have therefore similar structures; namely, their n -th element equals

(4.5)
$$
\cos \rho_{2n} + (-1)^n \int_0^1 g(s) e^{i\lambda_n (1-2s)} ds
$$

for respective g; here, as usual, $\rho_{2n} := \lambda_n - \pi n$.

Clearly, the mapping $(\rho_{2n}) \mapsto (\cos \rho_{2n} - 1)$ is analytic in ℓ_2 . Its Lipschitz continuity follows from the inequality $|\cos x - \cos y| \leq |x-y|$; also, the inequality $1-\cos x \leq x^2/2$ yields the estimate $\|(\cos \rho_{2n} - 1)\| \le \|(\rho_{2n})\|^2/2$.

Let f_{λ} denote the function in $L_2(0, 1)$ such that $\hat{f}_{\lambda}(n) = \rho_{2n}$ and set

(4.6)
$$
h_n := (-1)^n \int_0^1 g(s) e^{i\lambda_n (1-2s)} ds.
$$

Then the function h given by the Fourier series $\sum_{n\in\mathbb{Z}}h_n e^{2\pi i n s}$ coincides with the function $\Psi(f_{\lambda}, g)$ of Lemma [B.3.](#page-15-1) It follows from that lemma that the sequence $(h_n)_{n\in\mathbb{Z}}$ depends analytically and boundedly Lipschitz continuously in ℓ_2 on f_λ and g. We prove in the lemma below that the function g depends in the same manner on $\nu =$ $(\lambda, \mu) \in \mathcal{N}(h,r).$

Lemma 4.3. *The mappings*

$$
\mathcal{N}(h,r) \ni (\lambda, \mu) \mapsto r_j \in L_2(0,1), \qquad j=1,2,
$$

are analytic and Lipschitz continuous.

Proof. Since both mappings can be treated similarly, we only discuss the first one. By definition, we have $S(\lambda_n) = 0$, and thus the numbers $\lambda_n = \pi n + \rho_{2n}$, $n \in \mathbb{Z}$, are zeros of the entire function S of [\(4.3\)](#page-10-4). The required properties of the mapping $\nu \mapsto r_1$ follow now from the results of Appendix A. now from the results of Appendix [A.](#page-13-0)

The above reasoning justifies the inclusion $\alpha^{-1} \in \mathscr{A}$ as well as analyticity and Lipschitz continuity of the mappings of (4.2) . It remains to prove that there exist positive h' and r' such that, for every $v \in \mathcal{N}(h,r)$, the corresponding elements γ and δ belong to $\mathscr{A}(h', r')$.

Existence of such an r' follows from the uniform estimates of the ℓ_2 -norms of the sequences (cos ρ_{2n} – 1) and (h_n); see [\(4.5\)](#page-10-6) and [\(4.6\)](#page-11-0). Indeed, in view of Lemma [B.3](#page-15-1) the function $h = \sum_{n \in \mathbb{Z}} h_n e^{2\pi i n s}$ remains in the bounded subset of $L_2(0, 1)$ when f_{λ} and g vary over bounded subsets of $L_2(0,1)$, and the latter is the case when ν runs over $\mathcal{N}(h,r)$ by the definition of the functions f_{λ} and g and Lemma [4.3.](#page-11-1)

Next, in view of formula [\(2.2\)](#page-3-2) and the interlacing property of λ_n and μ_n , the numbers $\gamma_n = (-1)^n \dot{S}(\lambda_n)$ and $\delta_n = (-1)^n C(\lambda_n)$ are all of the same sign and thus are all positive in view of the asymptotic relation [\(4.5\)](#page-10-6). The uniform positivity of γ_n and δ_n (and thus existence of a positive h' such that $1/\alpha_n = \gamma_n \delta_n \ge h'$, immediately follows from the lemma below. A similar statement is established in [\[17\]](#page-17-21); we give a complete proof below for the sake of completeness.

Lemma 4.4. *For every* $h \in (0, \pi/2)$ *and* $r > 0$ *we have*

$$
\sup_{(\lambda,\mu)}\sup_{n\in\mathbb{N}}\log|\dot{S}(\lambda_n)|<\infty,\qquad \sup_{(\lambda,\mu)}\sup_{n\in\mathbb{N}}\log|C(\lambda_n)|<\infty,
$$

where S and C are constructed via [\(2.2\)](#page-3-2) from sequences λ and μ , and the suprema are *taken over* $(\lambda, \mu) \in \mathcal{N}(h,r)$.

Proof. We assume first that $n \neq 0$. By [\(2.2\)](#page-3-2), we have

$$
\dot{S}(\lambda_n) = \frac{\lambda_0 - \lambda_n}{\pi n} \prod_{k \in \mathbb{Z}, \ k \neq 0, n} \frac{\lambda_k - \lambda_n}{\pi k}.
$$

¹In what follows, all summations and multiplications over the index set $\mathbb Z$ will be taken in the principal value sense and the symbol V.p. will be omitted.

Dividing both sides by

$$
\cos \pi n = \frac{d \sin z}{dz}\Big|_{z=\pi n} = -\prod_{k \in \mathbb{Z}, \ k \neq 0,n} \frac{\pi k - \pi n}{\pi k},
$$

we conclude that

$$
|\dot{S}(\lambda_n)| = \prod_{k \in \mathbb{Z}, \ k \neq n} \frac{\lambda_k - \lambda_n}{\pi(k - n)}
$$

and observe that this formula also holds for $n = 0$. Set (recall that $\rho_{2k} := \lambda_k - \pi k$)

$$
a_{k,n} := \frac{\lambda_k - \lambda_n}{\pi(k-n)} - 1 = \frac{\rho_{2k} - \rho_{2n}}{\pi(k-n)}
$$

if $k \neq n$ and $a_{n,n} := 0$; then $|S(\lambda_n)| = \prod_{k \in \mathbb{Z}} (1 + a_{k,n})$. Since the sequence (λ_n) is 2h-separated for every $(\lambda, \mu) \in \mathcal{N}(h, r)$, we have $1 + a_{k,n} \geq 2h/\pi$ for all integer k and n. Therefore, with

$$
K := \max_{x \ge -1 + 2h/\pi} \left| \frac{\log(1+x) - x}{x^2} \right| < \infty,
$$

we get the estimate

(4.7)
$$
\left|\log \prod_{k \in \mathbb{Z}} (1 + a_{k,n})\right| \le \left|\sum_{k \in \mathbb{Z}} a_{k,n}\right| + K \sum_{k \in \mathbb{Z}} a_{k,n}^2,
$$

provided the two series converge.

Clearly,

$$
\sum_{k \neq n} \frac{1}{k - n} = 0,
$$

and thus

$$
\left|\sum_{k\in\mathbb{Z}} a_{k,n}\right| = \left|\frac{1}{\pi}\sum_{k\neq n} \frac{\rho_{2k}}{k-n}\right| \leq \frac{r}{\sqrt{3}}
$$

by the Cauchy–Bunyakovski–Schwarz inequality (recall that $\sum_{k\in\mathbb{Z}}\rho_{2k}^2 \leq r^2$ by the definition of the set $\mathcal{N}(h,r)$ and $\sum_{k\neq n}(k-n)^{-2}=\pi^2/3$. Next, the inequality

$$
a_{k,n}^2 \le \frac{2\rho_{2k}^2}{(k-n)^2} + \frac{2\rho_{2n}^2}{(k-n)^2}
$$

for $k \neq n$ yields

$$
\sum_{k \in \mathbb{Z}} a_{k,n}^2 \le 4r^2 \sum_{k \ne n} \frac{1}{(n-k)^2} = \frac{4\pi^2 r^2}{3}.
$$

It follows from [\(4.7\)](#page-12-0) that

$$
\left|\log\prod_{k\in\mathbb{Z}}(1+a_{k,n})\right| \leq (\sqrt{3}r + 4K\pi^2r^2)/3,
$$

where the constant K only depends on h .

Similarly, we find that

$$
|C(\lambda_n)| = \left| \prod_{k=1}^{\infty} \frac{\mu_k - \lambda_n}{\pi (k + \frac{1}{2})} \right| = \prod_{k \in \mathbb{Z}} \frac{\mu_k - \lambda_n}{\pi (k + \frac{1}{2}) - \pi n}
$$

and then mimic the above reasoning to establish the other uniform bound. The lemma is proved. \square

Combination of the above results constitutes a complete proof of Theorem [4.1](#page-10-2) and together with Theorem [2.2](#page-4-1) establishes Theorem [2.1.](#page-4-0)

Appendix A. Analyticity of some related mappings

Here we give a brief account on the results of [\[22\]](#page-17-23) as well as some extensions that are used to prove Lemma [4.3.](#page-11-1) It was shown in [\[22\]](#page-17-23) that for every $f \in L_2(0,1)$ there exists a unique function $g \in L_2(0, 1)$ such that all zeros (counting multiplicities) of the entire function

(A.1)
$$
G_g(z) := \sin z + \int_0^1 g(t)e^{iz(1-2t)} dt
$$

are given by the numbers $\pi n + \hat{f}(n)$, $n \in \mathbb{Z}$. Such pairs of f and g in fact satisfy the relation

(A.2)
$$
H(f,g) := s(f) + g + \sum_{k=1}^{\infty} \frac{(M^k g) * f^{}}{k!} = 0;
$$

here

$$
s(f) := \sum_{k=0}^{\infty} \frac{(-1)^k f^{<2k+1>}}{(2k+1)!},
$$

 $f^{>}$ is the k-fold convolution of f with itself, and M is the operator of multiplication by i(1 − 2x). The function H is analytic from $L_2(0,1) \times L_2(0,1)$ into $L_2(0,1)$, and its partial derivatives $\partial_f H(f, g)$ and $\partial_q H(f, g)$ are given by

(A.3)
$$
\partial_f H(f,g)(h_1) = \left(c(f) + \sum_{k=1}^{\infty} \frac{(M^k g) * f^{}}{(k-1)!}\right) * h_1,
$$

(A.4)
$$
\partial_g H(f,g)(h_2) = h_2 + \sum_{k=1}^{\infty} \frac{(M^k h_2) * f^{}}{k!}
$$

with

$$
c(f) := \sum_{k=0}^{\infty} \frac{(-1)^k f^{<2k>}}{(2k)!}.
$$

Using the implicit function theorem, it was shown that the induced mapping $f \mapsto q$ is analytic. In order to establish its Lipschitz continuity, we shall study the above partial derivatives in more detail.

Namely, we assume that $f \in L_2(0,1)$ is such that the corresponding sequence $\lambda =$ $(\lambda_n)_{n\in\mathbb{N}}$ with $\lambda_n := \pi n + \hat{f}(n)$ belongs to $\mathscr{L}(h,r)$. Set S_λ to be the canonical product of [\(2.2\)](#page-3-2); then S_{λ} can also be represented as [\(A.1\)](#page-13-1). Direct calculations show that the n-th Fourier coefficient of the function of $(A.3)$ is equal to

$$
(-1)^n \hat{h}_1(n) \left[\cos \lambda_n + \int_0^1 \mathrm{i} (1 - 2t) g(t) e^{i \lambda_n (1 - 2t)} dt \right] = (-1)^n \hat{h}_1(n) \dot{S}_{\lambda}(\lambda_n).
$$

By Lemma [4.4](#page-11-3) there are positive numbers K_1 and K_2 such that

$$
K_1 \leq |\dot{S}_{\lambda}(\lambda_n)| \leq K_2
$$

for all $\lambda \in \mathcal{L}(h,r)$ and all $n \in \mathbb{Z}$. Therefore the partial derivative $\partial_f H(f,g)$ is a bounded and boundedly invertible operator in $L_2(0, 1)$; moreover, for every fixed $h > 0$ and $r > 0$, the norms of $\partial_f H(f, g)$ and their inverses are uniformly bounded for $f \in L_2(0,1)$ generating the sequences λ in the set $\mathscr{L}(h,r)$.

Similarly, the *n*-th Fourier coefficient of the function of $(A.4)$ is equal to

$$
(-1)^n \int_0^1 h_2(t) e^{i\lambda_n(1-2t)} dt.
$$

By the results of [\[17\]](#page-17-21), there exist positive M and m such that, for all $\lambda \in \mathcal{L}(h,r)$, the sequences $(e^{i\lambda_n(1-2x)})_{n\in\mathbb{Z}}$ form Riesz bases of $L_2(0,1)$ of upper bound M and lower bound m. Therefore the operator $H_g := \partial_g H(f, g)$,

$$
H_g: h_2 \mapsto \sum_{n \in \mathbb{Z}} (-1)^n (h_2, e^{i\lambda_n(1-2x)}) e^{2\pi n i x},
$$

is bounded and boundedly invertible in $L_2(0,1)$, with $||H_g|| \leq M^{1/2}$ and $||H_g^{-1}|| \leq$ $m^{-1/2}$.

We now use the implicit mapping theorem to conclude that the mapping $f \mapsto g$ is analytic in $L_2(0,1)$. The uniform bounds on the inverses of the partial derivatives $\partial_f H(f,g)$ and $\partial_q H(f,g)$ established above imply that, for every $h > 0$ and $r > 0$, this mapping is Lipschitz continuous on the set of functions $f \in L_2(0,1)$ generating the sequences $\lambda \in \mathscr{L}(h,r)$.

Appendix B. Some auxiliary results

We recall that the convolution $f * g$ of two functions in $L_2(0,1)$ is a function in $L_2(0,1)$ given by

$$
(f * g)(x) := \int_0^1 f(x - t)g(t) dt,
$$

where f is extended to $(-1,0)$ as a periodic function with period 1. The (discrete) Fourier transform \hat{f} of $f \in L_2(0,1)$ is a function over $\mathbb Z$ given by

$$
\hat{f}(n) := \int_0^1 f(t) e^{-2\pi n i t} dt.
$$

It is well known that the Fourier transform is a unitary mapping from $L_2(0,1)$ to $\ell_2(\mathbb{Z})$ and that $\widehat{f * g}(n) = \widehat{f}(n)\widehat{g}(n)$; as a result, we have the inequality

$$
||f * g|| \le ||f|| ||g||
$$

for all $f, g \in L_2(0,1)$.

Lemma B.1. For a function $f \in L_2(0,1)$, set

$$
g(f)(x) := V.p. \sum_{n=-\infty}^{\infty} [e^{2\hat{f}(n)x} - 1]e^{2\pi n x}.
$$

Then the series determines a function in $L_2(0,1)$ *, and the mapping*

$$
L_2(0,1) \ni f \mapsto g_f \in L_2(0,1)
$$

is analytic and locally Lipschitz continuous on bounded subsets.

Proof. We start with observing that the series $\sum_{n\in\mathbb{Z}} \hat{f}^k(n) e^{2\pi n i s}$ is the Fourier series for the function $f^{(k)}$, the k-fold convolution of f with itself, and that $||f^{(k)}|| \leq ||f||^k$. Developing $e^{\hat{f}(n)$ ^{is} into the Taylor series, we find that

$$
g(f) = \text{V.p.} \sum_{n=-\infty}^{\infty} \left[\sum_{k=1}^{\infty} \frac{\hat{f}^k(n)(2is)^k}{k!} \right] e^{2\pi n is}
$$

=
$$
\sum_{k=1}^{\infty} \frac{(2is)^k}{k!} \text{V.p.} \sum_{n=-\infty}^{\infty} \hat{f}^k(n) e^{2\pi n is}
$$

=
$$
\sum_{k=1}^{\infty} \frac{(2is)^k}{k!} f^{(k)}.
$$

The change of the summation order in the second equality above is justified by the fact that, for $k > 1$, the summands in the double series are dominated by $C^k \hat{f}^2(n)/k!$ with $C := 2 \max_{n \in \mathbb{Z}} \{ |\hat{f}(n)| \} + 1$. Therefore the double series over the index set $\{(n, k) \mid n \in \mathbb{Z}\}$ $\mathbb{Z}, k > 1$ converges absolutely and the Fubini theorem applies. This formula represents $g(f)$ as an absolutely convergent series (which is a Taylor series expansion of $g(f)$ in the variable f) and thus proves the analyticity in $L_2(0, 1)$ of the mapping $f \mapsto g(f)$.

Lipschitz continuity of that mapping on bounded sets follows from the estimate

$$
||g(f_1) - g(f_2)|| = \Big\|\sum_{k=1}^{\infty} \frac{(2is)^k}{k!} [f_1^{(k)} - f_2^{(k)}]\Big\|
$$

$$
\leq \sum_{k=1}^{\infty} \frac{2^k}{(k-1)!} ||f_1 - f_2|| \big(||f_1|| + ||f_2||\big)^{k-1} \leq \exp\{4r\} ||f_1 - f_2||,
$$

which is valid as soon as the L_2 -norms of f_1 and f_2 are not greater than r. The proof is complete. \Box

Lemma B.2. For f and g in $L_2(0,1)$, set

$$
\Phi(f,g) := \text{V.p.} \sum_{n=-\infty}^{\infty} \hat{g}(n) \exp\{2[\pi n + \hat{f}(n)]\text{is}\}.
$$

Then the function $\Phi(f, g)$ *belongs to* $L_2(0, 1)$ *and the mapping*

$$
\Phi: L_2(0,1) \times L_2(0,1) \to L_2(0,1)
$$

is analytic and Lipschitz continuous on bounded subsets.

Proof. Transformations similar to those used in the proof of the above lemma show that

$$
\Phi(f,g) = \sum_{k=1}^{\infty} \frac{(2is)^k}{k!} [f^{(k)} * g].
$$

The mapping Φ is linear (and thus analytic) in q, and its analyticity in f as well as Lipschitz continuity on bounded subsets is established in the same manner as for the mapping $g(f)$ of Lemma [B.1.](#page-14-1)

Lemma B.3. For f and g in $L_2(0,1)$, set

$$
\Psi(f,g) := \text{V.p.} \sum_{n \in \mathbb{Z}} (-1)^n \int_0^1 g(t) \exp\{[\pi n + \hat{f}(n)] i(1 - 2t)\} dt e^{2\pi i n x};
$$

Then the function $\Psi(f, g)$ *belongs to* $L_2(0, 1)$ *and the mapping*

$$
\Psi: L_2(0,1) \times L_2(0,1) \to L_2(0,1)
$$

is analytic and Lipschitz continuous on bounded subsets.

Proof. The coefficient of $e^{2\pi i n x}$ in the above series for Ψ can be written as

(B.1)
$$
\int_0^1 g(t) \exp\{i(1-2t)\hat{f}(n)\} e^{-2\pi int} dt
$$

and gives the *n*-th Fourier coefficient of the function $h := \sum_{k=0}^{\infty} h_k/k!$, with $h_0 := g$, $h_k := f^{} * M^k g$ for $k \geq 1$, and M being the operator of multiplication by the function i(1 − 2t). In other words, we have $\Psi(f,g) = h$. Since $||f * g|| \le ||f|| ||g||$ for every f and g in $L_2(0,1)$, the functions h_k belong to $L_2(0,1)$ and their norms there obey the estimate

$$
||h_k|| \leq ||f||^k ||M||^k ||g||,
$$

with $\|M\|$ denoting the norm of the operator M. Thus the series for h converges absolutely and, since every h_k is a multi-linear function of f and g, the mapping Ψ is analytic. Its Lipschitz continuity on bounded subsets is established in the usual manner, and the proof is complete.

Appendix C. Banach algebras

The space $\ell_2 = \ell_2(\mathbb{Z})$ is a commutative Banach algebra under the pointwise multiplication $(x_n) \cdot (y_n) = (x_n \cdot y_n)$. Its unital extension A consists of elements of ℓ_{∞} of the form $a\mathbf{1} + \mathbf{x}$ with $a \in \mathbb{C}$, the unity $\mathbf{1} \in \ell_{\infty}$ having all its elements equal to 1, and $\mathbf{x} = (x_n) \in \ell_2$. The norm in A is given by

$$
||a\mathbf{1} + \mathbf{x}||_A = |a| + ||\mathbf{x}||,
$$

and $a\mathbf{1} + \mathbf{x}$ is invertible in A if and only if $a \neq 0$ and $a + x_n \neq 0$ for all $n \in \mathbb{Z}$; in this case the inverse is equal to $a^{-1}\mathbf{1} + \mathbf{y}$, where $\mathbf{y} = (y_n)$ with $y_n := -x_n/a(a + x_n)$. Since under the above assumptions we have $\inf_n |a + x_n| > 0$, we see that y indeed belongs to ℓ_2 ; moreover,

$$
||(a\mathbf{1}+\mathbf{x})^{-1}||_A \leq |a|^{-1} (1+||\mathbf{x}||/\inf_n |a+x_n|).
$$

The mapping $\hat{\mathbf{x}} \mapsto \hat{\mathbf{x}}^{-1}$ is analytic on the open set of all invertible elements of A; in addition, it is Lipschitz continuous on the sets

$$
\mathscr{S}_{\varepsilon} := \big\{ a\mathbf{1} + \mathbf{x} \mid |a| \ge \varepsilon, \ \inf_{n} |a + x_n| \ge \varepsilon \big\}.
$$
