

ALGORITHMIC RANDOMNESS, REVERSE MATHEMATICS, AND THE DOMINATED CONVERGENCE THEOREM

ABSTRACT. We analyze the pointwise convergence of a sequence of computable elements of $L^1(2^\omega)$ in terms of algorithmic randomness. We consider two ways of expressing the dominated convergence theorem and show that, over the base theory RCA_0 , each is equivalent to the assertion that every G_δ subset of Cantor space with positive measure has an element. This last statement is, in turn, equivalent to weak König's lemma relativized to the Turing jump of any set. These principles imply the existence of a 2-random relative to any given set, and are equivalent to that assertion in the presence of Σ_2^0 induction.

1. INTRODUCTION

Fix a measure space $\mathcal{X} = (X, \mathcal{B}, \mu)$. The dominated convergence theorem states that if (f_n) is any sequence of integrable functions dominated by an integrable function g , and (f_n) converges pointwise almost everywhere to a function f , then f is an integrable function as well, and $(\int f_n)$ converges to $\int f$.

In the context of both computable measure theory and reverse mathematics, in the case where X is a compact separable metric space and \mathcal{B} is the collection of Borel subsets of \mathcal{X} , the space $L^1(\mathcal{X})$ of integrable functions modulo a.e. equivalence can be represented as the completion of a countable set of test functions under the L^1 norm. There are then two ways that the dominated convergence theorem can then be expressed in the language of second-order arithmetic, depending on whether the pointwise limit is assumed or asserted to exist as an element of $L^1(\mathcal{X})$. One option is to say that given a sequence (f_n) of elements of $L^1(\mathcal{X})$ and an element g of $L^1(\mathcal{X})$, if (f_n) is dominated by g and is pointwise convergent a.e., then there is an element f of $L^1(\mathcal{X})$ such that (f_n) converges to f pointwise a.e. and $(\int f_n)$ converges to $\int f$. The second option is to assume the existence of the limit, f , in advance, and say that given f , g , and a sequence (f_n) of elements of $L^1(\mathcal{X})$, if (f_n) is dominated by g and converges pointwise a.e. to f , then $(\int f_n)$ converges to $\int f$. Let us call the first version (DCT) and the second version (DCT').

Yu [17] has shown that, over RCA_0 , (DCT) is equivalent to the arithmetic comprehension principle, (ACA). The implication from (DCT) to (ACA) is not difficult: if we take \mathcal{X} to be the unit interval $[0, 1]$ under Lebesgue measure and take each f_n to be a constant function, (DCT) implies, for example, that every monotone bounded sequence of rationals has a limit, a fact that easily implies (ACA) [13].

The status of (DCT') remained open, however. Yu [17] showed that the corresponding formulation of the monotone convergence theorem is equivalent to a principle, weak König's lemma (WWKL), introduced by Yu and Simpson [18]. Simpson [13] conjectured that (DCT') is also equivalent to (WWKL). Our main

result here is that, over RCA_0 , (DCT') is equivalent to a principle, (2-POS) , which is strictly stronger than (WWKL) , strictly weaker than (ACA) , and incomparable with (WKL) . (2-POS) asserts that any G_δ subset of Cantor space with positive measure has an element, and is equivalent to the relativization of (WWKL) to the Turing jump of any set. (2-POS) also implies the statement (2-RAN) that there exists a 2-random relative to any given set, and is equivalent to (2-RAN) in the presence of Σ_2^0 induction.

In fact, there is a more natural way of formulating the dominated convergence theorem without having to assert the existence of a pointwise limit. Namely, one says that given a sequence (f_n) dominated by g , if $(f_n(x))$ is a Cauchy sequence for almost every x , then $(\int f_n)$ is Cauchy as well. Call this version (DCT^*) . It is not hard to show that (DCT^*) implies (DCT') over RCA_0 , since whenever $(f_n(x))$ converges to $f(x)$ the sequence $f_0(x), f(x), f_1(x), f(x), f_2(x), \dots$ is Cauchy. We show that, in fact, over RCA_0 the principle (DCT^*) is also equivalent to (2-POS) .

Below, we assume familiarity with some of the basic notions of algorithmic randomness [4, 11] and computable measure theory [5, 8, 15]. We also assume familiarity with reverse mathematics, and, in particular, the formalization of measure-theoretic notions in subsystems of second-order arithmetic [13, 18, 16, 17].

The outline of this paper is as follows. In Sections 2, 3, and 4, we focus on Cantor space, 2^ω , as the natural setting for the study of algorithmic randomness. Section 2 considers measure-theoretic convergence statements in those terms. Section 3 begins to develop a framework for treating algorithmic randomness formally, in the context of subsystems of second-order arithmetic. These two strands come together in Section 4, which provides a formal analysis of the dominated convergence theorem in terms of 2-randomness. In Section 5 we observe that the framework of Section 3 can be extended straightforwardly to deal with n -randomness, for every n .

The theory of 2-random subsets of 2^ω has recently been brought to bear on reverse mathematics in an interesting way by Csima and Mileti [3], who use it to build a model of the “rainbow Ramsey theorem” for pairs, (RRT_2^2) , which is not a model of Ramsey’s theorem for pairs. More recently, Theodore Slaman and Chris Conidis have announced that the argument of Csima and Mileti can be used to derive (RRT_2^2) from the axiom (2-RAN) we consider here. They have also shown that (2-RAN) is conservative over $\text{RCA}_0 + (\text{B}\Sigma_2)$ for Π_1^1 -sentences, and have studied its first-order consequences.

Kjos-Hanssen, Solomon, and Miller [9] have considered a related principle, (POS) , which asserts that every G_δ set of positive measure contains a closed set of positive measure. (The similarity of the name (2-POS) is coincidental.) Over RCA_0 , $(\text{POS}) + (\text{WWKL})$ clearly implies (2-POS) , while Cholak, Greenberg, and Miller [2] have shown that (POS) does not imply (WWKL) and $(\text{WWKL}) + (\text{POS})$ does not imply (WKL) . We are grateful to Joseph Miller for calling our attention to this.

2. CONVERGENCE AND ALGORITHMIC RANDOMNESS

An element α of Cantor space, 2^ω , can be viewed as a one-way infinite binary sequence, but can also be identified with the set X of natural numbers with characteristic function α . A basis for the standard topology is given by the collection of sets of the form $[\sigma]$, where σ is a finite binary sequence and $[\sigma]$ is the set of elements of 2^ω that extend it. A *name* (or *code*) for an open subset of 2^ω is a sequence

$(B_i)_{i \in \omega}$, intended to denote $\bigcup_i B_i$, where each B_i denotes a basic open set $[\sigma]$ or \emptyset . A subset A of 2^ω is *computably open*, or Σ_1^0 , if it has a computable name. The definition relativizes to any set X , so that open subsets of 2^ω are exactly the ones that are $\Sigma_1^{0,X}$ for some X .

A Π_1^0 set is the complement of a Σ_1^0 set. These notions extend to the full arithmetic hierarchy; for example, a Π_2^0 set is of the form $\bigcap_i \bigcup_j B_{i,j}$, where $B_{i,j}$ is a uniformly computable sequence of basic open sets. Equivalently, one can view a Π_2^0 set as given by a computable sequence (G_i) of (indices of) Σ_1^0 sets, or as given by a Π_2^0 formula in the language of arithmetic with free set variable X . It is not hard to pass back and forth between these representations [4, Section 2.19].

Now consider the usual coin-flipping measure μ on 2^ω given by $\mu([\sigma]) = 2^{-\text{length}(\sigma)}$. A *Martin-Löf test*, or a *Martin-Löf null set*, is a Π_2^0 set $\bigcap_i G_i$ which moreover has the property that $\mu(G_i) < 2^{-i}$; in other words, it is an effective sequence of Σ_1^0 sets whose measures converge to 0 with an explicit rate of convergence. It is well known that an effective countable union of Martin-Löf tests is contained in a Martin-Löf test; in fact, there is a maximal one, called the *universal* Martin-Löf test. An element of 2^ω is *Martin-Löf random*, or *1-random*, if it is not an element of any Martin-Löf test, which is equivalent to saying that it is not an element of the universal Martin-Löf test. More generally, a Σ_n^0 -test is an effective sequence of Σ_n^0 sets whose measures converge to 0 with the rate of convergence above, and an element of 2^ω is *n-random* if it is not in the universal Σ_n^0 -test.

Let us turn to $L^1(2^\omega)$. A *simple function* on 2^ω is a function $f : 2^\omega \rightarrow \mathbb{R}$ of the form $\sum_{i < n} a_i 1_{[\sigma_i]}$ where each $a_i \in \mathbb{Q}$ and $1_{[\sigma_i]}$ denotes the characteristic function of $[\sigma_i]$. A *name* of an element of $L^1(2^\omega)$ is a Cauchy sequence (f_i) of (names of) simple functions such that for every $j \geq i$, $\|f_i - f_j\|_1 < 2^{-i}$. As before, an element f of $L^1(2^\omega)$ is *computable* if it has a computable name. One can show that if (f_i) is a name of an element of $L^1(2^\omega)$, then $(f_i(x))$ converges for all x outside a Martin-Löf null set, and that two computable names for the same element of $L^1(2^\omega)$ take the same value on Martin-Löf random points. (See [12, Lemma 3.2] and [7, Section 4.2], as well as [17, Lemma 2.1], which carries out the argument formally in RCA_0 .)

It will be convenient to blur the distinction between computable elements of $L^1(2^\omega)$ and their names. When we say that (f_i) is a computable sequence of elements of $L^1(2^\omega)$, we mean that each f_i is a computable element of $L^1(2^\omega)$ given by a sequence of names that are computable uniformly in i . When we say that $(f_i(x))$ converges we mean to imply that, moreover, $(f_i(x))$ is defined for every i .

Theorem 2.1. *Let (f_i) be a computable sequence of elements of $L^1(2^\omega)$. Then up to a Martin-Löf null set, the set of points x such that the sequence $(f_i(x))$ converges is a Π_3^0 set. Similarly, if f is a computable element of $L^1(2^\omega)$, then the set of points x such that the sequence $(f_i(x))$ converges to $f(x)$ is a Π_3^0 set.*

Proof. Notice that in the last claim we can assume without loss of generality that $f = 0$, by considering the sequence $(f_i - f)_{i \in \omega}$.

Suppose f_i is given by the name $(f_{i,j})_{j \in \omega}$. Let us show that we can replace each f_i with the simple function $f'_i = f_{i,i}$ without changing the limiting behavior of $f_i(x)$ on more than a Martin-Löf null set. If, for some x , one of the sequences $(f_i(x))$, $(f'_i(x))$ converges while the other does not, or if the two sequences converge to different values, then there is some $\varepsilon > 0$ such that $|f_i(x) - f'_i(x)| > \varepsilon$ infinitely often. By Chebyshev's theorem, for each j the set $\{x \mid |f_j(x) - f'_j(x)| > \varepsilon\}$ has

measure at most $2^{-j}/\varepsilon$. So if $G_i = \{x \mid \exists j > i \ (|f_j(x) - f'_j(x)| > \varepsilon)\}$, then $\mu(G_i) \leq 2^{-i}/\varepsilon$. But the set of x such that $|f_j(x) - f'_j(x)| > \varepsilon$ for arbitrarily large j is contained in $\bigcap_i G_i$, and hence contained in a Martin-Löf null set. Since this set is also effective in ε , the union over rational $\varepsilon > 0$ is Martin-Löf null.

So, up to a Martin-Löf null set, the set of points x for which $(f_i(x))$ converges is equal to $\{x \mid \forall \varepsilon > 0 \ \exists m \ \forall n > m \ |f'_n(x) - f'_m(x)| > \varepsilon\}$, clearly a Π_3^0 set. Similarly, the set of points x for which $(f_i(x))$ converges to $f(x)$ is equal to $\{x \mid \forall \varepsilon > 0 \ \exists m \ \forall n > m \ |f'_n(x) - f(x)| > \varepsilon\}$. \square

In the statement of the next corollary, x is *weakly 2-random*, by definition, if it is not in any null Π_2^0 set. (So every 2-random element of 2^ω is weakly 2-random, and every weakly 2-random element is 1-random.)

Corollary 2.2. *If (f_i) is a computable sequence of elements of $L^1(2^\omega)$ that is pointwise a.e. convergent to 0, then $(f_i(x))$ converges to 0 for every weak 2-random x .*

Proof. By Theorem 2.1, the set of points x for which $(f_i(x))$ doesn't converge is contained in a null Σ_3^0 set, and hence a countable union of null Π_2^0 sets. \square

Corollary 2.3. *If (f_i) is any computable sequence of elements of $L^1(2^\omega)$ that is not pointwise a.e. convergent to 0, then there is a Π_2^0 set A with positive measure such that $(f_i(x))$ does not converge to 0 for any x in A .*

Proof. Considering the Σ_3^0 set promised by Theorem 2.1 minus the Martin-Löf null set of exceptions, we see that the hypothesis implies that the set of x such that $(f_i(x))$ doesn't converge contains a Σ_3^0 set with positive measure. But this is a countable union of Π_2^0 sets, one of which has to have positive measure. \square

The relativization of a theorem due to Kučera [10, 4] says that if A is any Π_2^0 subset of 2^ω with positive measure, then every 2-random x has a tail in A . (See also [1] for a number of interesting variants.) We will exploit this fact, together with Corollary 2.3, in Section 4, to show that over a suitable base theory the existence of 2-random elements of 2^ω (relative to any set) implies the dominated convergence theorem. Roughly speaking, assuming that the conclusion of the dominated convergence theorem fails, we will produce an explicit Π_2^0 set with positive measure, any element of which provides a counterexample to the hypothesis.

In the other direction, to show that the dominated convergence theorem implies the existence of 2-randoms, it suffices to show that the dominated convergence theorem implies that every Π_2^0 set with positive measure has an element (since the complement of the universal Σ_2^0 test is the union of such sets). This will involve formalizing the following theorem.

Theorem 2.4. *Let A be a Π_2^0 set with measure greater than δ , for some $\delta > 0$. Then there is a sequence of simple characteristic functions f_i such that $\int f_i > \delta$ for each i , but $(f_i(x))$ converges to 0 for every x outside of A .*

Proof. Let $A = \bigcap_i G_i$, where each $G_i = \bigcup_j B_{i,j}$ is open with measure greater than δ and $G_0 \supseteq G_1 \supseteq \dots$. Let $G'_i = \bigcup_{j \leq k} B_{i,j}$ for the least k integer making the measure of this set greater than δ . Let $f_i = 1_{G'_i}$. Then for each i , $\int f_i > \delta$. On the other hand, if $x \notin A$, then $x \notin G_i$ for some i , in which case $f_{i'}(x) = 0$ for every $i' \geq i$. \square

All of the theorems and corollaries in this section relativize to an arbitrary set. In the next section, we will make these relativizations explicit. Section 4 deals with the same measure-theoretic notions in the context of a more general set of finite measure spaces. All the results described here hold in that more general setting, and the proofs can be adapted straightforwardly.

3. FORMALIZING 2-RANDOMNESS AND RELATED NOTIONS

We now begin to provide a framework for the study of algorithmic randomness in the context of reverse mathematics. This involves importing the definitions in the last section to the language of second-order arithmetic. Specifically, we say (a code for) a $\Sigma_1^{0,X}$ subset A of 2^ω is (an index of) a sequence $(B_i)_{i \in \omega}$ of basic open sets, computable from X . With respect to the usual development of topological notions in reverse mathematics, an open subset of Cantor space is just a $\Sigma_1^{0,X}$ set for some X . We can then view a $\Pi_1^{0,X}$ set as the complement of a $\Sigma_1^{0,X}$ set. Similarly, a $\Pi_2^{0,X}$ subset of 2^ω is a doubly-indexed sequence $B_{i,j}$ of basic open sets, viewed as $\bigcap_i \bigcup_j B_{i,j}$. These correspond to the G_δ subsets of Cantor space that are computable from X .

In the language of second-order arithmetic we can take $Y \in \bigcup_i [\sigma_i]$ to mean $\exists i (\sigma_i \subset Y)$, where the notation $\sigma_i \subset Y$ means that σ_i is an initial segment of the characteristic function of Y . More generally, membership of Y in a $\Sigma_n^{0,X}$ (resp. $\Pi_n^{0,X}$) set can be expressed by a $\Sigma_n^{0,X}$ (resp. $\Pi_n^{0,X}$) formula with the additional parameter Y . But it is important to keep in mind that such a set is an *intensional object*: it is a *description* of a set of subsets of ω , rather than the set itself. In particular, different “sets” A can represent the same subset of 2^ω .

As usual, the measure of an open set $\bigcup B_i$ is $\lim_n \mu(\bigcup_{i < n} B_i)$. When it comes to weak theories of reverse mathematics, however, one has to be careful, for at least three reasons. First, a weak theory cannot prove that the measure of an open set always exists; indeed, Yu [16] shows that this is equivalent, over the base theory RCA_0 , to the principle (ACA) of arithmetic comprehension. Second, a weak theory cannot prove that extensionally equivalent descriptions of an open set have the same measure. For example, Yu and Simpson [18] show that the statement “if $\bigcup B_i = 2^\omega$ then $\mu(\bigcup_i B_i) = 1$ is equivalent to the principle (WWKL) discussed below, which is not provable in RCA_0 . Finally, different characterizations of the measure of a set need not coincide; for example, if one defines the measure of a closed set in terms of its complement, in weak theories one cannot show that the measure of a closed set is the infimum of the measures of open sets covering it. Yu [16] shows that ACA_0 proves the existence and regularity of measures of sets at any finite level of the Borel hierarchy, eliminating all three problems in that axiomatic context. But in the context of the theories discussed here, the reader should keep in mind that all the definitions below are “intensional” and don’t generally presuppose the existence of measures.

The principle (WWKL) introduced by Yu and Simpson [18] is as follows:

$\forall T$ (if T is an infinite binary tree and

$$\lim_{n \rightarrow \infty} \frac{|\{\sigma \in T, \text{length}(\sigma) = n\}|}{2^n} > 0, \text{ there is a path through } T).$$

If A is a $\Sigma_1^{0,X}$ set $\bigcup_i B_i$ and $\delta \in \mathbb{Q}$, then $\mu(A) > \delta$ is defined to be the assertion $\exists m (\mu(\bigcup_{i < m} B_i) > \delta)$. Notice that this is a Σ_1^0 formula in X , A , and δ . Similarly, $\mu(A) \leq \delta$ is the Π_1^0 assertion $\forall m (\mu(\bigcup_{i < m} B_i) \leq \delta)$. If A is a $\Pi_1^{0,X}$ set, we can also express “ $\mu(A) < \delta$ ” and “ $\mu(A) \geq \delta$,” respectively, as Σ_1^0 and Π_1^0 formulas in X , A , and δ . Let (1-POS) be the statement

$$\forall X, A \in \Pi_1^{0,X}, \delta > 0 (\mu(A) \geq \delta \rightarrow \exists Y (Y \in A)).$$

This expresses the statement that every closed set with positive measure has an element. Finally, define a *Martin-Löf test relative to X* to be a uniformly computable sequence $(G_i)_{i \in \mathbb{N}}$ of $\Sigma_1^{0,X}$ sets such that for each i , $\mu(G_i) \leq 2^{-i}$. A set Y is *1-random relative to X* if for every Martin-Löf test (A_i) relative to X , $Y \notin \bigcap_i A_i$, that is, $\exists i (Y \notin A_i)$. Let (1-RAN) be the following principle:

$$\forall X \exists Y (Y \text{ is 1-random relative to } X).$$

The fact that for any X there is a universal Martin-Löf test (U_i) relative to X can be proved straightforwardly in RCA_0 . So, if (U_i) is any such test, Y is 1-random relative to X if and only if Y is not in U_i for some i .

Theorem 3.1. *Over RCA_0 , the following are equivalent:*

- (1) (WWKL)
- (2) (1-POS)
- (3) (1-RAN)

Proof. The equivalence of (WWKL) and (1-POS) is proved by Yu and Simpson [18]. (In fact, Yu and Simpson prove that the conclusion holds for a wider classes of measure spaces; we will return to this in the next section.) The equivalence of (1-POS) and (1-RAN) is stated in [14], and amounts to little more than the formalization of Kučera’s theorem [10] (see also [4, Section 6.10]). Here we summarize the proof in a way that makes it clear that the proof goes through in RCA_0 .

First, suppose (1-POS). Given X , let (U_i) be the universal Martin-Löf test relative to X . Then the complement of U_1 is a $\Pi_1^{0,X}$ set with positive measure, and any element of this set is 1-random relative to X .

Conversely, assume (1-RAN). Let C be a $\Pi_1^{0,X}$ set with positive measure, and let $\bar{C} = \bigcup_i [\sigma_i]$ be its complement. Without loss of generality, we can assume the sets $[\sigma_i]$ are disjoint. Suppose $\mu(\bar{C}) \leq r < 1$. For each i , let $D_i = \bigcup_{j_1, \dots, j_i} [\sigma_{j_1} \sigma_{j_2} \dots \sigma_{j_i}]$, where $\sigma_{j_1} \sigma_{j_2} \dots \sigma_{j_i}$ denotes the concatenation of $\sigma_{j_1}, \sigma_{j_2}, \dots, \sigma_{j_i}$. We claim that for every i , $\mu(D_i) \leq r^i$. To see this, consider any finite subunion $\hat{D} \subset D_i$ and let E be a finite subunion of \bar{C} such that for every σ occurring in a sequence $\sigma_{j_1} \sigma_{j_2} \dots \sigma_{j_i}$ corresponding to a component of \hat{D} , $[\sigma]$ is included in E . Then $\mu(\hat{D}) \leq \mu(E)^i \leq r^i$, as required.

Now thin (D_i) to a Martin-Löf test. Applying (1-RAN), we obtain a Y such that Y is not in D_i for some i . Then $Y \notin [\sigma_{j_1} \sigma_{j_2} \dots \sigma_{j_i}]$ for any j_1, \dots, j_i . This implies that some tail of Y is not in \bar{C} ; otherwise, by Σ_1 induction, we would have that for every i' there are $j_1, \dots, j_{i'}$ such that $Y \in [\sigma_{j_1} \sigma_{j_2} \dots \sigma_{j_{i'}}]$. By recursive comprehension, this tail of Y is again a set, and an element of C . \square

Note the use of Σ_1 induction in the proof that (1-RAN) implies (1-POS).

Our goal here is to carry out a similar analysis of 2-randomness, as well as the assertion that there is an element of any $\Pi_2^{0,X}$ set with positive measure and an analogue of (WWKL) which involves trees computable from X' . But there are two

fine points that need to be addressed: first, how to say that a $\Pi_2^{0,X}$ set has positive measure, in light of the warnings above; and second, how to refer to X' when the existence of Turing jumps is not provable in the weak theories we are considering here.

The second concern is easily met: simply use an appropriate $\Sigma_1^{0,X}$ formula to describe the Turing jump of X . We can express the fact that Turing machine e with oracle X halts on input x and returns y , denoted $\varphi_e^X(x) \downarrow = y$, by the formula $\exists \sigma \subset X \varphi_e^\sigma(x) \downarrow = y$. Here $\varphi_e^\sigma(x) \downarrow$ expresses the assertion that Turing machine e halts on input x in less than $\text{length}(\sigma)$ steps, querying only the bits of σ . We can then define $e \in X'$ to mean $\exists \sigma \subseteq X \varphi_e^\sigma(0) \downarrow$.

In the context of formal theories of arithmetic, recall the collection principles $(B\Sigma_n)$:

$$\forall x < u \exists y \varphi(x, y) \rightarrow \exists v \forall x < u \exists y < v \varphi(x, y),$$

where φ is any Σ_n formula, possibly with number and set parameters other than x and y (see [6, 13]). Let $(I\Sigma_n)$ denote Σ_n induction. Over a weak theory, $(I\Sigma_n)$ implies $(B\Sigma_n)$, and $(B\Sigma_{n+1})$ implies $(I\Sigma_n)$. In particular, RCA_0 proves $(B\Sigma_1)$, which suffices to show that the set of Σ_1 formulas is closed under bounded quantification. We now define $\varphi_e^{X'}(x) \downarrow = y$ to mean $\exists \sigma \subset X' \varphi_e^\sigma(x) \downarrow = y$. Using $(B\Sigma_1)$, the assertion $\sigma \subseteq X'$ is $\Delta_2^{0,X}$, as is the assertion $\varphi_e^{X'}(x) = y$, assuming $\varphi_e^{X'}$ is total. We can then take (2-WWKL) to be the principle:

$\forall X, T$ (if T is an infinite binary tree computable from X' and

$$\lim_{n \rightarrow \infty} \frac{|\{\sigma \in T, \text{length}(\sigma) = n\}|}{2^n} > 0, \text{ there is a path through } T).$$

We can express the conclusion by saying that for some $\delta > 0$, for every n , there exists a finite set of σ 's of length n in the tree making the sum greater than δ .

The first concern is also easily met by first considering $\Pi_2^{0,X}$ sets in a particularly nice form. Say that a $\Pi_2^{0,X}$ set $\bigcap_i \bigcup_j B_{i,j}$ is “strict” if the sets $\bigcup_j B_{i,j}$ are decreasing, in the sense that whenever $i' \geq i$, for every j' there is a j such that $B_{i',j'} \subseteq B_{i,j}$. Just as $(B\Sigma_1)$ can be used to show that Σ_1^0 formulas are closed under bounded quantification, it can be used to show that $\Sigma_1^{0,X}$ sets are closed under finite intersections: in the identity

$$\bigcap_{i' \leq i} \bigcup_j B_{i',j} = \bigcup_{(j_0, \dots, j_i)} (B_{0,j_0} \cap \dots \cap B_{i,j_i}),$$

$(B\Sigma_1)$ proves the left-to-right inclusion. Thus RCA_0 proves that every $\Pi_2^{0,X}$ set $\bigcap_i G_i$ is extensionally equivalent to a strict $\Pi_2^{0,X}$ set $\bigcap_i (\bigcap_{i' \leq i} G_{i'})$, and we can interpret references to the measure of $\bigcap_i G_i$ in terms of the measure of its strict equivalent. If $A = \bigcap_i \bigcup_j B_{i,j}$ is a strict $\Pi_2^{0,X}$ subset of 2^ω , we can express $\mu(A) \geq r$ as $\forall i, \varepsilon > 0 \mu(\bigcup_j B_{i,j}) > r - \varepsilon$. In particular, the assertion that A has positive measure is equivalent to $\exists \delta > 0 \forall i (\mu(\bigcup_j B_{i,j}) > \delta)$. This gives (2-POS) :

$$\forall X, A \in \Pi_2^{0,X} (\mu(A) > 0 \rightarrow \exists Y (Y \in A)).$$

Our first goal is to show that, over RCA_0 , the principles (2-WWKL) and (2-POS) are equivalent. This requires checking that RCA_0 can prove some fundamental facts about algorithmic randomness.

In the absence of $(B\Sigma_2)$, reasoning about computability relative to the Turing jump X' of a set X is delicate. For example, $(B\Sigma_2)$ is needed to show that if $f(n)$ is computable relative to X' then so are the course-of-values function $g(n) = (f(0), \dots, f(n-1))$ and the function $h(n) = \max_{i < n} f(i)$. Fortunately, in the presence of (2-WWKL) , we have $(B\Sigma_2)$ as well.

Proposition 3.2. *Over RCA_0 , (2-WWKL) implies $(B\Sigma_2)$.*

Proof. Arguing in $\text{RCA}_0 + (2\text{-WWKL})$, suppose $\forall x < a \exists y \varphi(x, y)$ where φ is a Π_1^0 formula, possibly with parameters other than the one shown. Via pairing, we can assume there is only one set parameter, X . Pick k such that $2^k \geq a$ and let $\sigma_0, \dots, \sigma_{a-1}$ be the first a binary sequences of length k . The idea is to build a tree computable from X' that includes all children of each σ_x until they reach a length greater than some y satisfying $\varphi(x, y)$. More precisely, let T be the tree defined by putting a sequence τ in T if and only if τ is an initial segment of σ_x , for some $x < a$, or τ properly extends σ_x and $\forall y < \text{length}(\tau) \neg \varphi(x, y)$. The hypothesis implies there is no path through the tree, so, by (2-WWKL) , there is some level b such that the density of nodes of length b in T is less than 2^{-k} . For any $x < a$, this implies that there is a $y < b$ satisfying $\varphi(x, y)$; otherwise, all extensions of σ_x of length b would be in T , and these have density 2^{-k} . \square

Joseph Miller has pointed out to us that this proof also establishes that the principle (POS) of [9], mentioned in the introduction, also implies $(B\Sigma_2)$.

Our next task is to prove that, over RCA_0 , (2-WWKL) and (2-POS) are equivalent. Essentially, this involves showing that conventional computability-theoretic constructions can be carried out in RCA_0 , and that claims regarding measure can be verified in the restricted axiomatic setting.

Proposition 3.3. *RCA_0 proves the following. Let T be a tree computable from X' satisfying the hypothesis of (2-WWKL) . Then the set of paths through T is a $\Pi_2^{0,X}$ set with positive measure.*

Proof. Argue in RCA_0 . Let T be as above. By the Shoenfield limit lemma [4, Theorem 2.6.1] there is a 0, 1-valued function $f(n, m)$ computable from X such that for every n , $\lim_m f(n, m)$ exists, and for every σ , $\sigma \in T$ if and only if $\lim_m f(\sigma, m) = 1$. (The proof of the limit lemma can be carried out using $(B\Sigma_1)$.)

Define a sequence of trees (T_m) where $\sigma \in T_m$ if $f(\tau, m) = 1$ for all $\tau \subseteq \sigma$. By $(B\Sigma_1)$, we have $\sigma \in T$ if and only if for every k there is an $m > k$ such that $\sigma \in T_m$. For each n , let $G_n = \bigcup \{[\sigma] \mid \text{length}(\sigma) = n \wedge \exists k > n \sigma \in T_k\}$. Clearly the sequence (G_n) is decreasing. By $(B\Sigma_1)$, each G_n contains $\bigcup \{[\sigma] \mid \text{length}(\sigma) = n \wedge \sigma \in T\}$, so $\mu(G_n) \geq \delta$ for each n .

Hence $\bigcap_n G_n$ is a strict $\Pi_2^{0,X}$ set with positive measure, and it suffices to show that for any Y , $Y \in \bigcap_n G_n$ if and only if Y is a path through T . Suppose Y is a path through T . Then for every n , $Y \upharpoonright n$ is in T , and hence in $Y \in G_n$. Conversely, suppose Y is not a path through T . Then for some n , $Y \upharpoonright n$ is not in T . Hence, for some $m \geq n$, $Y \upharpoonright n$ is not in T_k for any $k \geq m$. Then $Y \upharpoonright m$ is not in T_k for any $k \geq m$, and so Y is not in G_m . \square

The next proposition is an effective version of regularity for G_δ sets.

Proposition 3.4. $\text{RCA}_0 + (\text{B}\Sigma_2)$ proves the following. Suppose A is a $\Pi_2^{0,X}$ set such that $\mu(A) \geq r$, and $\delta > 0$. Then there is a $\Pi_1^{0,X'}$ set $C \subseteq A$ such that $\mu(C) \geq r - \delta$.

Proof. Let $A = \bigcap_i \bigcup_j B_{i,j}$ be a strict $\Pi_2^{0,X}$ set, where each $B_{i,j}$ is a basic open set. Notice that for every i , there is a K_i such that for every $J > K_i$, $\mu(\bigcup_{j \leq J} B_{i,j} \setminus \bigcup_{j \leq K_i} B_{i,j}) < \delta/2^{i+2}$; otherwise, Σ_1 induction implies that for every n there is a J such that $\mu(\bigcup_{j \leq J} B_{i,j}) > n\delta/2^{i+2}$, which contradicts the fact that the measure is bounded by 1. Let $f(i)$ be a function, computable from X' , which returns such an i .

Since every finite union of basic open sets is clopen, $C = \bigcap_i \bigcup_{j \leq f(i)} B_{i,j}$ is a closed set, and can be expressed explicitly as a $\Pi_1^{0,X'}$ set $\bigcap_i C_i$. (In more detail, write each $\bigcup_{j \leq f(i)} B_{i,j}$ as an intersection $\bigcap_{j \leq g(i)} \bar{D}_{i,j}$ for a $g(i)$ computable from X' , write $C = \bigcap_i \bigcap_{j \leq g(i)} \bar{D}_{i,j}$, and use $(\text{B}\Sigma_2)$ to combine the two intersections.) To show $\mu(C) \geq r - \delta$, we need to show that for every i' , $\mu(\bigcup_{i \leq i'} C_i) \geq r - \delta$. By $(\text{B}\Sigma_1)$, it suffices to show that for every i' , $\mu(\bigcap_{i \leq i'} \bigcup_{j \leq f(i)} B_{i,j}) > r - \delta$, because every intersection $\bigcap_{i \leq i'} C_i$ is a superset of a larger intersection of the form $\bigcap_{i \leq i'} \bigcup_{j \leq f(i)} B_{i,j}$.

Fix i' . The hypothesis that $\mu(A) \geq r$ implies that for some J_1 large enough, $\mu(\bigcup_{j \leq J_1} B_{i',j}) > \delta/2$. The strictness of A implies that $\bigcup_{j \leq J_1} B_{i',j}$ is included in $\bigcup_j B_{i,j}$ for each $i \leq i'$, and $(\text{B}\Sigma_1)$ then implies there is a J such that it is included in $\bigcup_{j \leq J} B_{i,j}$ for each $i \leq i'$. Hence $\mu(\bigcap_{i \leq i'} \bigcup_{j \leq J} B_{i,j}) > r - \delta/2$.

But now we are reduced to manipulations with finite unions and intersections. We have

$$\bigcap_{i \leq i'} \bigcup_{j \leq J} B_{i,j} \setminus \bigcap_{i \leq i'} \bigcup_{j \leq f(i)} B_{i,j} \subseteq \bigcup_{i \leq i'} (\bigcup_{j \leq J} B_{i,j} \setminus \bigcup_{j \leq f(i)} B_{i,j})$$

and the measure of this last set is less than $\sum_{i \leq i'} \delta/2^{i+2} < \delta/2$. Hence we have $\mu(\bigcap_{i \leq i'} \bigcup_{j \leq f(i)} B_{i,j}) > r - \delta$, as required. \square

Proposition 3.5. Over RCA_0 , (2-WWKL) and (2-POS) are equivalent.

Proof. First, assume (2-POS), and let T be any tree computable from X' that satisfies the hypothesis of (2-WWKL). By Proposition 3.3 the set of paths through T is a $\Pi_2^{0,X}$ set with positive measure, and so, by (2-POS), has an element.

In the other direction, assume (2-WWKL), and let $A = \bigcup_i G_i$ be any strict $\Pi_2^{0,X}$ set such that $\mu(A) \geq \delta > 0$. Using Propositions 3.2 and 3.4, there is a $\Pi_1^{0,X'}$ set $C \subseteq A$ such that $\mu(C) \geq \delta/2$. By the usual reduction of closed sets to trees [18] we get a tree T satisfying the hypotheses of (2-WWKL), such that any path through T is an element of C and hence A . \square

We now turn to formalized notions of 2-randomness. Within the language of second-order arithmetic, define a $\Sigma_2^{0,X}$ test to be a uniformly computable sequence $(A_i)_{i \in \mathbb{N}}$ of $\Sigma_2^{0,X}$ sets such that for each i , $\mu(A_i) \leq 2^{-i}$. A set Y is *2-random relative to X* if for every $\Sigma_2^{0,X}$ test (A_i) relative to X , $Y \notin \bigcap_i A_i$, that is, $\exists i (Y \notin A_i)$. Let (2-RAN) be the following principle:

$$\forall X \exists Y (Y \text{ is 2-random relative to } X).$$

Once again, the fact that for every X there is a universal $\Sigma_2^{0,X}$ test (U_i) can be proved straightforwardly in RCA_0 .

Proposition 3.6.

- (1) *Over RCA_0 , (2-WWKL) implies (2-RAN).*
- (2) *Over $\text{RCA}_0 + (\text{I}\Sigma_2)$, (2-RAN) implies (2-WWKL).*

Proof. By Proposition 3.5 we can use (2-POS) in place of (2-WWKL). For the first claim, fix X , and let $(U_i)_{i \in \omega}$ be a universal $\Sigma_2^{0,X}$ test. Then the complement of U_1 is a $\Pi_2^{0,X}$ test with positive measure, so by (2-POS), there is an element Y in the complement of U_1 , which is hence 2-random.

For the second claim, let us show that $\text{RCA}_0 + (\text{I}\Sigma_2) + (2\text{-RAN})$ proves (2-POS). Fix a $\Pi_2^{0,X}$ set A with positive measure. By Proposition 3.4, there is a subset B of A which is a $\Pi_1^{0,X'}$ set of positive measure. Let Y be 2-random relative to X . As in the proof of Theorem 3.1, Σ_2 induction implies that some tail of Y is in B and hence A , and so, using recursive comprehension, there is an element of A . \square

The main conclusions of this section are summarized as follows:

Theorem 3.7.

- (1) *Over RCA_0 , (2-WWKL) and (2-POS) are equivalent, and imply both $(\text{B}\Sigma_2)$ and (2-RAN).*
- (2) *Over $\text{RCA}_0 + (\text{I}\Sigma_2)$, (2-WWKL), (2-POS), and (2-RAN) are equivalent.*

Recall that (WKL) is the axiom that asserts that every infinite tree on $\{0, 1\}$ has a path.

Theorem 3.8. *Over RCA_0 , each of (2-WWKL) and (WKL) implies (WWKL), but both implications are strict. In fact, (2-WWKL) doesn't imply (WKL), and (WKL) doesn't imply (2-WWKL).*

Proof. To see that (WKL) doesn't imply (2-WWKL), notice that the low basis theorem implies that there is an ω -model of (WKL) in which every set is low, and so, in particular, Δ_2^0 [6, 13]. On the other hand, no Δ_2^0 set is 2-random. Finally, the model \mathcal{M} constructed by Yu and Simpson [18, Section 2] satisfies $\text{RCA}_0 + (2\text{-WWKL})$, but not (WKL). (In fact, that model satisfies more; see Section 5.) \square

Slaman and Conidis have posed the question as to whether (2-RAN) implies $(\text{B}\Sigma_2)$. Similarly, we do not know whether (2-RAN) implies (2-WWKL) over RCA_0 . The results of Slaman and Conidis mentioned at the end of the introduction suggest that (2-WWKL) should be conservative over $\text{RCA}_0 + (\text{B}\Sigma_2)$ for Π_1^1 sentences, but we do not know that this is the case.

4. CONVERGENCE THEOREMS AND REVERSE MATHEMATICS

We now turn to the formalization of convergence theorems in reverse mathematics. We need to consider measures on an arbitrary compact separable metric space, along the lines of [13, 16, 17, 18]. (The development there is closely related to the treatment of these notions in computable analysis, along the lines of [8, 15].) In particular, a compact separable metric space (X, d) is assumed to be represented by a countable dense set of ideal points, and elements of the space are named by Cauchy sequences with an explicit rate of convergence. Open and closed sets, and more generally $\Sigma_n^{0,X}$ and $\Pi_n^{0,X}$ sets for any X and n , are defined as in Section 2,

where now the basic open sets B_i are balls $B(a, \delta)$, where a is an ideal point and δ is rational. The space $C(X, \mathbb{R})$ of continuous functions on X can be represented as the closure of a set of particularly simple “test functions” (called “polynomials” in [13, 16, 17, 18]) under the uniform norm.

A finite measure μ on (X, d) is given in terms of the values of the integral $\int f d\mu$ on test functions; the space $L^1(\mu)$ is then defined as in Section 2, replacing the simple functions there with test functions. Without loss of generality, we will assume $\mu(X) = 1$. Operations like pointwise addition and integration are defined straightforwardly and their basic properties can be established in RCA_0 . Also, if (f_n) is the name of an element f of $L^1(\mu)$ and k is any rational number, $(\min(f_n, k))$ and $(\max(f_n, k))$ are names for $\min(f, k)$ and $\max(f, k)$. Below we will rely on the fact that in RCA_0 these operations have the expected properties, such as $\min(f, k) + \max(f, k) = f + k$.

The measure of an open set A is now defined as the supremum of the measure of test functions that are bounded by 1 and vanish outside of A . In contrast to the case with 2^ω , the measure of a basic open set need not be computable from μ . But, as in Section 2, if A is $\Sigma_1^{0,X}$, the predicate $\mu(A) > \delta$ is $\Sigma_1^{0,X}$ definable. Randomness notions from Section 2 are easily adapted to this more general setting; see [8, 13, 16, 17, 18] for details.

Let $(G_\delta\text{-POS})$ be the axiom that says that for every compact separable metric space (X, d) and measure μ , every $\Pi_2^{0,X}$ set with positive measure has an element. To link this up with axioms discussed in Section 3, we only need the following two propositions. The first generalizes Proposition 3.4.

Proposition 4.1. $\text{RCA}_0 + (\text{B}\Sigma_2)$ proves the following. Fix a measure μ on a compact separable metric space (X, d) . Suppose A is a $\Pi_2^{0,X}$ set such that $\mu(A) \geq r$, and $\delta > 0$. Then there is a $\Pi_1^{0,X'}$ set $C \subseteq A$ such that $\mu(C) \geq r - \delta$.

Proof. The proof is similar to that of Proposition 3.4, but slightly complicated by the fact that now basic open sets are no longer clopen. The construction we describe below is essentially that used by Yu [16, Lemma 4.1] to show that ACA_0 proves the regularity of measures for G_δ sets; we only need to confirm that the construction is computable in the Turing jump of the original set, and that the correctness can be verified in $\text{RCA}_0 + (\text{B}\Sigma_2)$.

Suppose $A = \bigcup_i G_i$ where G_i is a decreasing sequence of open sets and for each i , $\mu(G_i) \geq r$. Yu [16, Lemma 2.3] notes that to each G_i we can associate an increasing sequence of test functions $(g_{i,k})_{k \in \omega}$ that all vanish outside of G_i , with the property that whenever $\mu(G_i) > s$ then $\int g_{i,k} > s$ for sufficiently large k .

As in the proof of Proposition 3.4, we can define a function $f(i)$ computable in X' such that for every $j \geq f(i)$, $\int g_{i,j} - \int g_{i,f(i)} < \delta/2^{i+2}$. For each i' , using $(\text{B}\Sigma_2)$ let

$$C_{i'} = \{x \mid \min_{i \leq i'} g_{i,f(i)}(x) \geq \delta/4\},$$

and let $C = \bigcap_{i'} C_{i'}$. If $x \in C_{i'}$ then $x \in \bigcap_{i \leq i'} G_i$, so $C \subseteq A$. Hence it suffices to show that for every i' , $\mu(C_{i'}) \geq r - \delta$.

For each i' , we have $\mu(C_{i'}) \geq \int \min_{i \leq i'} g_{i,f(i)} - \delta/4$. As in the proof of Proposition 3.4 we can find a J large enough so that $\int \min_{i \leq i'} g_{i,J} > r - \delta/4$. But we also

have

$$\int \min_{i \leq i'} g_{i,J} - \int \min_{i \leq i'} g_{i,f(i)} \leq \sum_{i \leq i'} \left(\int g_{i,J} - \int g_{i,f(i)} \right) \leq \sum_{i \leq i'} \delta/2^{i+1} < \delta/2,$$

so $\mu(C_{i'}) \geq r - \delta/4 - \delta/2 - \delta/4 = r - \delta$, as required. \square

Proposition 4.2. *Over (RCA_0) , $(\text{G}_\delta\text{-POS})$ is equivalent to (2-WWKL) .*

Proof. Given the usual representation of Cantor space as a metric space [13], (2-POS) is an instance of $(\text{G}_\delta\text{-POS})$. Thus by Theorem 3.7 $(\text{G}_\delta\text{-POS})$ implies (2-WWKL) , and we only have to prove the converse. Fortunately, Yu and Simpson [18] have done most of the hard work: Theorem 2 of [18] relativizes to show (2-WWKL) proves that every $\Pi_1^{0,X'}$ set with positive measure contains an element. By the previous proposition, every $\Pi_2^{0,X}$ set with positive measure contains a $\Pi_1^{0,X'}$ set with positive measure, so we are done. \square

We can express the fact that a sequence (f_n) converges to f pointwise almost everywhere by saying that there is a null G_δ set C such that for any point $x \notin C$, $f_n(x)$ converges to $f(x)$. Recall that in ordinary mathematics, a sequence (f_n) converges to f *almost uniformly* if for every $\lambda > 0$ and $\varepsilon > 0$ there is an n such that $\mu(\{x \mid \exists m \geq n \mid f_m(x) - f(x) > \varepsilon\}) < \lambda$. In the case where each f_n is a test function and $f(x) = 0$, the set in question is an open set, so when (f_n) is a sequence of test functions we can straightforwardly express the fact that (f_n) approaches 0 almost uniformly in the language of second-order arithmetic.

Theorem 4.3. *Over RCA_0 , the following are equivalent:*

- (1) (2-WWKL)
- (2) “If (f_n) is a sequence of test functions that converges to 0 pointwise a.e., then (f_n) converges to 0 almost uniformly.”
- (3) (DCT') , that is, “If f and g are elements of $L^1(\mathcal{X})$, (f_n) is a sequence of elements of $L^1(\mathcal{X})$ dominated by g , and (f_n) converges pointwise a.e. to f , then $(\int f_n)$ converges to $\int f$.”
- (4) “If (f_n) is a sequence of nonnegative test functions that is dominated by 1 and converges to 0 everywhere, then $(\int f_n)$ converges to 0.”

Notice that statement (2) is Egorov’s theorem restricted to test functions. Statement (4) is the dominated convergence theorem with additional restrictions: the functions in the sequence are test functions, they are nonnegative and uniformly dominated by 1, and they converge everywhere (rather than just a.e.).

To prove that (1) implies (2), suppose (f_n) is a sequence of test functions that converges to 0 pointwise a.e., but does not converge to 0 almost uniformly. Then for some $\varepsilon > 0$ and $\lambda > 0$ and any n , if we set $A_n = \{x \mid \exists m \geq n \mid f_m(x) > \varepsilon\}$, we have $\mu(A_n) > \lambda$. Since we are assuming f_n converges a.e., there is an open set B such that $\mu(B) < \lambda/2$ and (f_n) converges to 0 off of B . Then $\bigcap_n A_n - B$ is a $\Pi_2^{0,(f_n)}$ set with measure greater than λ , and so, by (2-POS) , has an element x . But then $x \notin B$ implies that $(f_n(x))$ converges to 0 and $x \in \bigcap_n A_n$ implies that for every n and there is $m \geq n$ such that $|f_m(x)| > \varepsilon$, a contradiction.

To prove that (2) implies (3), without loss of generality we will assume that $f = 0$ in the statement of (DCT') and each f_n and g are nonnegative. First let us prove that $\int f_n$ converges to 0 in the special case where g is the constant function

1. As in the proof of Theorem 2.1, we can assume that each f_n is a test function. By (2), we have that (f_n) converges to 0 almost uniformly, so, in particular, for any $\varepsilon > 0$ there is an n such that for every $m \geq n$, $\mu(\{x \mid |f_m(x)| > \varepsilon/2\}) < \varepsilon/2$. Write

$$\int f_m = \int \min(f_m, \varepsilon/2) + \int (\max(f_m, \varepsilon/2) - \varepsilon/2).$$

The first term is less than or equal to $\varepsilon/2$. The function $\max(f_m, \varepsilon/2) - \varepsilon/2 = \max(f_m - \varepsilon/2, 0)$ is bounded by 1 and vanishes outside $\{x \mid |f_m(x)| > \varepsilon/2\}$, so its integral is less than $\varepsilon/2$. Hence $\int f_m < \varepsilon$, as required.

Scaling, we have that (2) implies (3) in the special case where g is any constant function. To handle the more general case, we need a lemma. For any constant K and nonnegative $f \in L^1(2^\omega)$, write f^K for $\min(f, K)$. The next lemma shows that as K approaches infinity, f^K approaches f in the L_1 norm, provably in RCA_0 .

Lemma 4.4. *RCA_0 proves that if g is any nonnegative element of $L^1(2^\omega)$ and $\varepsilon > 0$, there is an integer K such that $\int (g - g^K) < \varepsilon$.*

Proof. Given g , choose a test function g_n such that $\|g - g_n\| < \varepsilon$. Choose K big enough so that g_n is bounded by K . Then $\|g - g^K\| \leq \|g - g_n\| < \varepsilon$.

(Intuitively, this last formula holds because $g(x) - g^K(x) = 0$ when $g(x) \leq K$, and $g(x) - g^K(x) < g(x) - g_n(x)$ when $g(x) > K$. Formally, one can show $\|g - g^K\| = \|\max(g, K) - K\| = \|\max(g - K, 0)\| \leq \|\max(g - g_n, 0)\| \leq \|g - g_n\|$.) \square

To complete the proof that (2) implies (3), now suppose (f_n) approaches 0 pointwise a.e. and is dominated by g . We need to show that for every $\varepsilon > 0$, there is an m such that $\int f_n < \varepsilon$ for all $n \geq m$. Choose K as in Lemma 4.4 with $\varepsilon/2$ in place of ε . Then (f_n^K) still converges to 0 pointwise a.e., so by the version of the dominated convergence theorem we have already proved, there is an m such that for every $n \geq m$, $\int f_n^K < \varepsilon/2$. But for every n , $\int (f_n - f_n^K) < \int (g - g_n^K) < \varepsilon/2$, so for every $n \geq m$ we have $\int f_n < \varepsilon$, as required.

Clearly (3) implies (4). To show that (4) implies (1), consider any Π_2^0 set $A = \bigcap_n G_n$ with measure greater than or equal to $\delta > 0$. As in the proof of Theorem 2.4, for each n we can find a test function f_n with the property $\int f_n > \delta$ but f_n vanishes outside of G_n . In particular, (f_n) converges to 0 outside of A . By (4), there is an x such that $(f_n(x))$ does not converge to 0. This element, x , must be in A .

This completes the proof of Theorem 4.3. We also have an analogous version for the principle (DCT^*) described in the introduction. Say that a sequence (f_n) is “almost uniformly Cauchy” if for every $\lambda > 0$ and $\varepsilon > 0$ there is an n such that $\mu(\{x \mid \exists m, m' \geq n \mid |f_m(x) - f_{m'}(x)| > \varepsilon\}) < \lambda$. In ordinary mathematics, this is clearly equivalent to being almost uniformly convergent, but it has the advantage that it does not require any mention of limits.

Theorem 4.5. *Over RCA_0 , the following are equivalent:*

- (1) (2-WWKL)
- (2) “If (f_n) is a sequence of test functions such that $f_n(x)$ is Cauchy for almost every x , then (f_n) is almost uniformly Cauchy.”
- (3) (DCT^*) , this is, “If g is an element of $L^1(\mathcal{X})$, (f_n) is a sequence of elements of $L^1(\mathcal{X})$ dominated by g , and the sequence $(f_n(x))$ is Cauchy for almost every x , then $(\int f_n)$ is Cauchy.”
- (4) “If (f_n) is a sequence of nonnegative test functions that is dominated by 1 and the sequence $(f_n(x))$ is Cauchy for every x , then $(\int f_n)$ is Cauchy.”

Proof. We need only slight modifications to the proof of Theorem 4.3. To show that (1) implies (2), replace the sets A_n in the previous proof by $\{x \mid \exists m, m' \geq n \mid f_m(x) - f_{m'}(x) > \varepsilon\}$. To show that (2) implies (3) in the special case where $g = 1$, note that since (f_n) is almost uniformly Cauchy, for any $\varepsilon > 0$ there is an n such that for every m, m' greater than or equal to n , $\mu(\{x \mid |f_m(x) - f_{m'}(x)| > \varepsilon/2\}) < \varepsilon/2$. Then argue as before that for such m and m' ,

$$\left| \int f_m - \int f_{m'} \right| \leq \int |f_m(x) - f_{m'}(x)| < \varepsilon.$$

The generalization to arbitrary g is as before. That (3) implies (4) is immediate. To show that (4) implies (1), let (f_n) be as in the previous proof, and define the sequence (f'_n) by $f'_{2n} = f_n$, $f'_{2n+1} = f_n/2$. Then $(\int f'_n)$ is not Cauchy, since consecutive elements differ by at least $\lambda/2$. By (4), there is a point x such that $(f'_n(x))$ is not Cauchy; but since (f_n) converges to 0 outside of A , this point has to be in A . \square

Corollary 4.6. *Over RCA_0 , (DCT') and (DCT^*) are equivalent to each other, and are strictly stronger than (WWKL) , strictly weaker than (ACA) , and not comparable with (WKL) .*

5. FORMALIZING n -RANDOMNESS

In this section we observe that notions related to 2-randomness treated in Section 3 can be generalized to the corresponding notions for n -randomness, yielding a hierarchy of theories below (ACA_0) . This involves adapting the proofs in Section 3 to formalize a number of basic properties of n -randomness (see [4, Section 6.10]). As was the case for $n = 2$ in Section 3, $(\text{B}\Sigma_n)$ is needed to show that $\Sigma_n^{0,X}$ sets are closed under bounded intersection, and also to develop a reasonable theory of computability relative to the n th Turing jump $X^{(n)}$ of a set X . Here we only sketch the details in the hopes that they will prove useful.

For each n , say that a *strict* $\Pi_{n+1}^{0,X}$ (resp. $\Sigma_{n+1}^{0,X}$) set is given by a decreasing (resp. increasing) sequence $A_0 \supseteq A_1 \supseteq A_2 \supseteq \dots$ where each A_n in turn is a strict $\Sigma_n^{0,X}$ (resp. $\Pi_n^{0,X}$) set. It is not hard to show that $\text{RCA}_0 + (\text{B}\Sigma_n)$ proves that every $\Pi_{n+1}^{0,X}$ set is extensionally equal to a strict one.

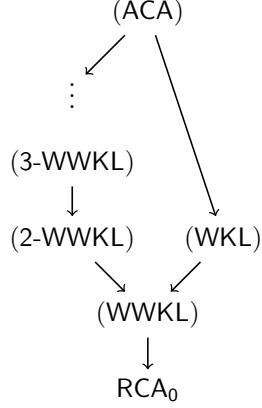
If $\bigcup_n A_n$ is a strict $\Sigma_n^{0,X}$ set, then $\mu(\bigcup_n A_n) > \delta$ is defined by the $\Sigma_n^{0,X}$ formula $\exists n (\mu(A_n) > \delta)$. Similarly, if B is a strict $\Pi_n^{0,X}$ set, $\mu(A) \geq \delta$ is defined by a $\Pi_n^{0,X}$ formula. By the results of Yu [16], over ACA_0 this agrees with the definition of the measure of a set in terms of the infimum of the measures of the open sets covering it. The principles $(n\text{-WWKL})$, $(n\text{-POS})$, and $(n\text{-RAN})$ are then defined as in Section 3. The results of Section 2 carry over, yielding:

Theorem 5.1. *Let $n \geq 1$.*

- (1) *Over RCA_0 , $(n\text{-WWKL})$ and $(n\text{-POS})$ are equivalent, and imply both $(\text{B}\Sigma_n)$ and $(n\text{-RAN})$.*
- (2) *Over $\text{RCA}_0 + (\text{I}\Sigma_n)$, $(n\text{-WWKL})$, $(n\text{-POS})$, and $(n\text{-RAN})$ are equivalent.*

Moreover, the proof of Proposition 4.2 generalizes to show that $(n\text{-POS})$ is equivalent to the corresponding principle for arbitrary measures on compact measure spaces.

This gives rise to the following picture, in which the only implications that hold are the ones indicated. Note that the model \mathcal{M} of Yu and Simpson [18], mentioned in the proof of Proposition 3.8, satisfies all the principles (n -WWKL) but not (WKL).



We do not know whether (n -RAN) implies (m -WWKL) for any $m \leq n$, in the absence of $\text{I}\Sigma_m$; in particular whether (3-RAN) implies (2-WWKL) over RCA_0 , or whether (2-RAN) implies (WWKL) over RCA_0^* (see [13]). We also do not know whether $\text{RCA}_0 + (n\text{-WWKL})$ is Π_1^1 -conservative over $\text{RCA}_0 + (\text{B}\Sigma_n)$.
