NONLINEAR STOCHASTIC HOMOGENIZATION IN ORLICZ SPACES AND APPLICATIONS

1. INTRODUCTION

In this work, we are interested in the stochastic homogenization of integral functionals defined in Orlicz-Sobolev spaces. We present a general version of nonlinear stochastic homogenization in these spaces and apply the general versions to homogenization problems in random media. In particular, we introduce a notion of Γ -convergence in Orlicz-Sobolev spaces and we show the compactness of a class \mathcal{F} of integral functionals with respect to this convergence. To guarantee that the Γ -limit is a measure, one has to give a criterion called fundamental estimate which the class of functionals must satisfy. For classical L^p -spaces, such estimate was introduced by DeGiorgi and further developed by Dal Maso, Modica, Braides. A distance function is also defined as a metric so that the family of minimizers of these functionals is continuous with respect to this metric. Using results of ergodic theory, we prove a stochastic theorem concerning the limit of minimizers, which is an extension of [10]. Finally, we apply the theorem to homogenization over a class of partial differential equations defined in Orlicz spaces. A technique of such homogenization problems has been developed in [18]. We improve these methods using continuum percolation models. We also mention the possible improvement of existing results on homogenization of p-Laplace type equations [3].

The paper is organized as follows.

- II Integral functionals in Orlicz spaces, lower semicontinuity and existence of minimizers.

2. Preliminaries

A function Φ is called a Young function if it admits the presentation

$$\Phi(u) = \int_0^u \phi(t) dt$$

where $\phi(t), t > 0$ satisfies

- (1) $\phi(0) = 0$
- (2) $\phi(t) > 0$ for all $t \ge 0$
- (3) ϕ is nondecreasing, right continuous
- (4) $\lim_{t \to \infty} \phi(t) = \infty$
- (5) $u\phi(u) < a\Phi(u)$ for a > 1 and for all $u \ge 0$

The function Φ is called an N- function. We say that Φ satisfies the Δ_2- condition (or has the doubling property) if there exists k > 0, and $l \ge 0$ such that

$$\Phi(2u) \le k\Phi(u)$$

for all u > l.

Then Φ is nonnegative, continuous, strictly increasing, convex function on $[0, \infty)$. The complementary function Ψ to Φ is defined by the formula

$$\Psi(v) = \max_{u \ge 0} [uv - \Phi(u)]$$

The following Young's inequality holds:

$$uv \le \Phi(u) + \Psi(v)$$

Let Ω be an open subset of \mathbb{R}^n . We define the Orlicz class $\tilde{L}_{\Phi}(\Omega)$ as the set of all measurable functions u such that

$$\rho(u,\Phi,\Omega) = \int_{\Omega} \Phi(|u(x)|) dx < \infty$$

 $\mathbf{2}$

By Young's inequality, the norm

$$||u|||_{\Phi,\Omega} = \sup_{\rho(v,\Phi,\Omega) \le 1} \left| \int_{\Omega} u(x)v(x)dx \right|$$

is well defined in $\tilde{L}_{\Phi}(\Omega)$. If both Φ , Ψ satisfy the Δ_2 -condition, then the class $\tilde{L}_{\Phi}(\Omega)$ equipped with either the previous norm or the Luxenburg norm

$$\|u\|_{\Phi,\Omega} = \inf\left\{\lambda > 0 : \int_{\Omega} \Phi\left(\frac{|u(x)|}{\lambda}\right) dx \le 1\right\}$$

is a reflexive Banach space that we will denote by $L_{\Phi}(\Omega)$. For $u \in L_{\Phi}(\Omega)$, $v \in L_{\Psi}(\Omega)$, the following Holder inequality holds:

$$\int_{\Omega} uv dx \le \|u\|_{\Phi,\Omega} \|v\|_{\Psi,\Omega}$$

Also,

(2.1) $||u||_{\Phi,\Omega} \le \rho(u,\Phi,\Omega) + 1$

and if $||u||_{\Phi,\Omega} \leq 1$,

(2.2)
$$\rho(u, \Phi, \Omega) \le ||u||_{\Phi, \Omega}$$

We say that the sequence $u_n \in L_{\Phi}$ converges in the mean to u provided

$$\rho(u_n - u, \Phi, \Omega) \to 0$$

as $n \to \infty$. If the Δ_2 condition holds, the convergence in the mean is equivalent to the convergence in norm.

2.1. Orlicz-Sobolev spaces. Consider the space of smooth functions $C^{1}(\Omega)$ endowed with the norm

$$\|u\|_{\Phi,\Omega}^1 = \max_{|\alpha| \le 1} \{\|D^{\alpha}u\|_{\Phi,\Omega}\}$$

The Orlicz-Sobolev space $W^1_{\Phi}(\Omega)$ is defined as the closure of $C^1(\overline{\Omega})$ with respect to this norm. The closure of $C_0^{\infty}(\Omega)$ to this norm is denoted by $W^1_{0,\Phi}(\Omega)$ and is a subspace of $W^1_{\Phi}(\Omega)$. The following embedding theorem holds [12]: if Ω is a bounded domain in \mathbb{R}^n with smooth boundary, the embedding of $W^1_{\Phi}(\Omega)$ into $L_{\Phi}(\Omega)$ is compact and

$$||u||_{\Phi,\Omega} \le C ||Du||_{\Phi,\Omega}$$

for all $u \in W^1_{0,\Phi}(\Omega)$.

Notation. For two Young functions Q, P, we will use the symbol $P \prec \prec Q$ when Q grows more rapidly than P near infinity, i.e. for all $\delta > 0$,

$$\lim_{t \to \infty} \frac{P(t)}{Q(\delta t)} = 0$$

Lemma 1 ([15], [5]). Let Ω be an open subset of \mathbb{R}^n of finite measure and let Φ, P be Young functions satisfying the Δ_2 condition. Suppose that $g: \Omega \times \mathbb{R} \to \mathbb{R}$ is a Caratheodory function such that

$$P(|g(x,s)|) \le k_1 \Phi(|s|)$$

for some constant k_1 . Then the Nemytskii operator $T_g(u)(x) = g(x, u(x))$ is strongly continuous from $L_{\Phi}(\Omega)$ to $L_P(\Omega)$.

For the proof we need the following theorem.

Theorem 1. Suppose $\Phi \in \Delta_2$ and $\Omega \subset \mathbb{R}^n$. If $u_n \to u$ in $L_{\Phi}(\Omega)$ there exists a subsequence u_{n_k} and $h \in L_{\Phi}(\Omega)$ such that

$$u_{n_k} \to u \ a.e. \ in\Omega$$

and

$$|u_{n_k}| \leq h \ a.e. \ in\Omega$$

The proof of theorem 1 is a modification of theorem 2.3 in [4].

Proof of Lemma 1. The map $u \to g(\cdot, u)$ is well defined from $L_{\Phi}(\Omega)$ to $L_{P}(\Omega)$. From theorem 1 and the continuity of g in u, for a sequence $u_{n} \to u$ in $L_{\Phi}(\Omega)$ we have

$$g(\cdot, u_n) \to g(\cdot, u)$$
 a.e. in Ω

and

$$|u_n| \leq h$$
 a.e. in Ω

for all $n \in \mathbb{N}$ and $h \in L_{\Phi}(\Omega)$. The continuity of P gives

$$P(|g(\cdot, u_n)|) \to P(|g(\cdot, u)|)$$
 a.e. Ω

Then

$$P(|g(\cdot, u_n)|) \le k_1 \Phi(|u_n|) \le k_1 \Phi(|h|)$$

with $\Phi(|h|) \in L^1(\Omega)$. Thus, the Dominated convergence theorem says that

$$\int_{\Omega} P(|g(\cdot, u_n)|) \to \int_{\Omega} P(|g(\cdot, u)|)$$

which implies that $g(\cdot, u_n) \to g(\cdot, u)$ for any $u_n \to u$.

Lemma 2 ([1],8.23). Suppose P, Q are Young functions with $P \prec \prec Q$. Then, any bounded subset of $L_Q(\Omega)$ which is precompact in $L^1(\Omega)$ is also precompact in $L_P(\Omega)$.

Theorem 2 ([1],8.32). Suppose $\Omega \subset \mathbb{R}^n$ has the cone property and $\int_0^1 \frac{\Phi^{-1}(t)}{t^{n(n+1)}} dt < \infty$ and $\int_1^\infty \frac{\Phi^{-1}(t)}{t^{n(n+1)}} dt = \infty$. Consider the Young function defined by

$$\Phi_*^{-1}(|t|) = \int_1^{|t|} \frac{\Phi^{-1}(s)}{s^{n(n+1)}} \, ds$$

Then for any $B \prec \prec \Phi_*$, the embedding $W^1_{\Phi}(\Omega) \to L_B(\Omega)$ is compact.

3. INTEGRAL FUNCTIONALS IN ORLICZ SPACES

Let $f: \Omega \times \mathbb{R}^n \to \overline{\mathbb{R}}$ be a function such that

• $f(x, \cdot)$ is continuous a.e. $x \in \Omega$

• $f(\cdot, p)$ is measurable for every $p \in \mathbb{R}^n$

We assume that

(3.1) f is convex in
$$p$$
;

and that there are constants $c_f^1,c_f^2>0$ so that

(3.2)
$$c_f^1 \Phi(|p|) \le f(x,p) \le c_f^2 (1 + \Phi(|p|)) \text{ for all } (x,p) \in \mathbb{R}^n \times \mathbb{R}^n$$

Let also $g: \Omega \times \mathbb{R} \to \overline{\mathbb{R}}$ be a function that is lower semicontinuous in the second variable and assume that for some constant $c_g > 0$ and some $b_g(x) \in L^1(\Omega)$,

(3.3)
$$g(x,u) \ge c_g B(|u|) - b_g(x)$$

where $B \prec \prec \Phi_*$. We denote by $\mathcal{F} = \mathcal{F}(c_f^1, c_f^2, \Phi)$ the class of functionals $F: L_{\Phi}(\mathbb{R}^n) \times \Omega \to \overline{\mathbb{R}}$ such that

(3.4)
$$F(u,\Omega) = \int_{\Omega} f(x,Du(x)) \, dx \text{ for all } u \in W^{1}_{\Phi}(\Omega)$$

where f is previously defined.

Let

$$G(u,\Omega) = F(u,\Omega) + \int_{\Omega} g(x,u(x))dx$$

Proposition 1. The functional $F(u, \Omega)$ is lower semicontinuous in the weak topology of $W^1_{\Phi}(\Omega)$, that is, if $u_n \to u$ weakly in $W^1_{\Phi}(\Omega)$, then

$$F(u,\Omega) \le \liminf_{n \to \infty} F(u_n,\Omega)$$

Proof. Let v_n be a sequence converging to v in $L_{\Phi}(\Omega)$ so that $\lim_{n\to\infty} F(v_n, \Omega)$ exists. From the definition of the norm in L_{Φ} and Fatou's lemma,

$$\int_{\Omega} \Phi(\frac{u}{\|u\|}) dx \le 1$$

Hence,

$$\int_{\Omega} \liminf_{n \to \infty} \Phi(\frac{v_n - v}{\|v_n - v\|}) dx \le 1$$

The continuity of Φ implies that

$$\Phi\left[\liminf_{n\to\infty}\left(\frac{v_n-v}{\|v_n-v\|}\right)\right] \le \liminf_{n\to\infty}\Phi\left(\frac{v_n-v}{\|v_n-v\|}\right) \le \infty \text{ a.e.}$$

so that

$$\liminf_{n \to \infty} \left(\frac{v_n - v}{\|v_n - v\|} \right) \le \infty \text{ a.e.}$$

Then, there exists a subsequence, still denoted by v_n , such that $v_n \to v$ a.e. Assume that $||v_n - v|| < 1/2$. The convexity of Φ shows that

$$\Phi(v_n) = \Phi\left(\|v_n - v\|\frac{v_n - v}{\|v_n - v\|} + (1 - \|v_n - v\|)\frac{v}{1 - \|v_n - v\|}\right)$$

$$\leq \|v_n - v\|\Phi\left(\frac{v_n - v}{\|v_n - v\|}\right) + (1 - \|v_n - v\|)\Phi\left(\frac{v}{1 - \|v_n - v\|}\right)$$

Then,

(3.5)
$$\int_{\Omega} \Phi(v_n) dx \le \|v_n - v\| + (1 - \|v_n - v\|) \int_{\Omega} \Phi(\frac{v}{1 - \|v_n - v\|}) dx$$

If in addition we choose m such that $||v|| \leq 2^m$, the Δ_2 - condition reads

$$\Phi(\frac{v}{1 - \|v_n - v\|}) \le \Phi(2v) \le k\Phi(v)$$

and

$$\begin{split} \int_{\Omega} \Phi(v) dx &= \int_{\Omega} \Phi(\|v\| \frac{v}{\|v\|}) dx \\ &\leq \int_{\Omega} \Phi(2^m \frac{v}{\|v\|}) dx \leq k^m \int_{\Omega} \Phi(\frac{v}{\|v\|}) dx \leq k^m < \infty \end{split}$$

From the Dominated convergence theorem,

$$\lim_{n \to \infty} \int_{\Omega} \Phi(\frac{v}{1 - \|v_n - v\|}) dx = \int_{\Omega} \Phi(v) dx$$

so that (3.4) gives

$$\limsup_{n \to \infty} \int_{\Omega} \Phi(v_n) dx \le \int_{\Omega} \Phi(v) dx$$

Using again Fatou's lemma,

$$\int_{\Omega} \Phi(v_n) dx \le \liminf_{n \to \infty} \int_{\Omega} \Phi(v_n) dx$$

so that

$$\int_{\Omega} \Phi(v_n) dx \to \int_{\Omega} \Phi(v) dx$$

Since $f(x, \cdot)$ and Φ are continuous,

$$\lim_{n \to \infty} (f(x, v_n) - c_f^1 \Phi(v_n)) = f(x, v) - c_f^1 \Phi(v)$$

and

$$\int_{\Omega} f(x, v) dx \le \lim_{n \to \infty} f(x, v_n) dx$$

Thus, the functional $\int_{\Omega} f(x, v) dx$ is lower semicontinuous in $L_{\Phi}(\Omega)$ which implies that $F(u, \Omega)$ is lower semicontinuous in $W^{1}_{\Phi}(\Omega)$, since if $v_{n} \to v$ in $W^{1}_{\Phi}(\Omega)$, then $Dv_{n} \to Dv$ in $L_{\Phi}(\Omega)$.

Proposition 2. The functional $\int_{\Omega} g(x, u) dx$ is sequentially lower semicontinuous in $W^{1}_{\Phi}(\Omega)$.

Proof. Suppose $u_n \to u$ weak $W^1_{\Phi}(\Omega)$. Then $\{u_n\}$ is bounded and up to a subsequence it converges strongly to u in $L_B(\Omega)$, due to theorem 2. Using proposition 1 with g instead of f, we obtain that $\int_{\Omega} g(x, u) dx$ is lower semicontinuous on $L_{\Phi}(\Omega)$. This implies the needed result. \Box

Theorem 3. Suppose X is a nonempty, weakly closed subset of $W_{\Phi}^{1}(\Omega)$. Then the functional

$$G(u, \Omega) = F(u, \Omega) + \int_{\Omega} g(x, u) \, dx$$

has a minimum over all $u \in X$.

Proof. Let χ_X be the indicator function of X, which is weakly lower semicontinuous in $W^1_{\Phi}(\Omega)$. Then the minimization problem can be written in the equivalent form

$$\min_{u \in W^1_{\Phi}(\Omega)} (F(u, \Omega) + \int_{\Omega} g(x, u) \, dx + \chi_X(u))$$

Then,

$$F(u,\Omega) + \int_{\Omega} g(x,u) \, dx + \chi_X \ge cZ(u) - b$$

holds for some positive constants c, b with $Z(u) = \int_{\Omega} \Phi(u) dx$ which is sequentially coercive in $W_{\Phi}^{1}(\Omega)$. The reason is that if $||u|| \leq 1$ then $Z(u) \leq$ ||u|| and if $||u|| \geq 1$ then $Z(u) \geq ||u||$. Thus, the set $\{u : Z(u) \leq t\}$ is bounded in $W_{\Phi}^{1}(\Omega)$ and sequentially compact since the space is reflexive. The direct method of variational problems implies the existence of the minimizer. If Xis convex, one can show that the minimum is unique. \Box

3.1. Yosida transforms and distance in \mathcal{F} . For $F \in \mathcal{F}$ the ε -Yosida transform is the functional $T_{\varepsilon}F(u,\Omega): L_{\Phi}(\Omega) \times \Omega \to \mathbb{R}$ defined by

$$T_{\varepsilon}F(u,\Omega) = \inf_{v \in W_{\Phi}^{1}(\Omega)} \{F(v,\Omega) + \varepsilon^{-1} \|u - v\|_{L_{\Phi}(\Omega)}\}$$

Proposition 3. For every $F \in \mathcal{F}$ and $u \in L_{\Phi}(\Omega)$,

$$\lim_{\varepsilon \to 0^+} T_{\varepsilon} F(u, \Omega) = \sup_{\varepsilon > 0} T_{\varepsilon} F(u, \Omega) = F(u, \Omega)$$

Proof. See [10], proposition 1.11

The ε -Yosida transform can be used to define a metric in \mathcal{F} so that the metric space (\mathcal{F}, d) is compact and the map $F \to \min_{u \in X} F(u)$ is continuous with respect to the metric. For this purpose, we pick a countable dense subset $W = \{w_j\}$ of $W^1_{\Phi}(\Omega)$ and a family $\mathcal{B} = \{B_k\}$ of open bounded subsets of \mathbb{R}^n .

Let $F, G \in \mathcal{F}$ and $h : \mathbb{R} \to \mathbb{R}$, we define

(3.6)
$$d(F,G) = \sum_{i,j,k=1}^{\infty} \frac{1}{2^{i+j+k}} |h(T_{1/i}(F(w_j, B_k))) - h(T_{1/i}(G(w_j, B_k)))|$$

To show that d is a distance in \mathcal{F} , it suffices to show that if d(F,G) = 0, then F = G.

4. Γ -convergence in Orlicz Spaces

The next step is to show that (\mathcal{F}, d) is compact, thus separable and complete. The notion of Γ -convergence will be introduced for this purpose.

Definition 1. Let X be a metric space and $F_n : X \to \overline{\mathbb{R}}$ a sequence of functionals on X. We say that $F_n \Gamma(X)$ -converges to the $\Gamma(X)$ -limit $F: X \to \overline{\mathbb{R}}$ if the following two conditions hold:

- $F(x) \leq \liminf_{n \to \infty} F_n(x_n)$, for every sequence x_n converging to x as $n \to \infty$
- for every $x \in X$, there is a sequence x_n converging to x as $n \to \infty$ such that $F(x) \ge \limsup F_n(x_n)$

such that $F(x) \ge \limsup_{n \to \infty} F_n(x_n)$ In this case we write $F(x) = \Gamma(X) \lim_{n \to \infty} F_n(x)$.

We adopt the definition of Γ -convergence for functionals in \mathcal{F} and $u \in L_{\Phi}(\Omega)$ and we denote the limit by

$$\Gamma(L_{\Phi}) \lim_{n \to \infty} F_n(u) = F(u)$$

Proposition 4 (Main Γ -Convergence result). The class \mathcal{F} is compact for the $\Gamma(L_{\Phi})$ convergence, i.e. every sequence $\{F_n\}$ in \mathcal{F} contains a subsequence that $\Gamma(L_{\Phi})$ -converges to a functional $F \in \mathcal{F}$.

The proof of proposition 4 will be a consequence of the following results:

Proposition 5. Let (X, d) be a separable metric space, and for all $j \in \mathbb{N}$ let $f_j : X \to \overline{\mathbb{R}}$ be a function. Then there is an increasing sequence of integers (j_k) such that the $\Gamma(d) - \lim_k f_{j_k}$ exists for all $x \in X$.

Proof. See [8], chap. 8.

Note that if the Δ_2 -condition is satisfied the Orlicz space is separable [16]. In the following definition, $\mathcal{A}(A)$ is the family of all open subsets of $A \subset \mathbb{R}^n$.

Definition 2. A function $\alpha : \mathcal{A}(\Omega) \to [0,\infty]$ is called an increasing set function if $\alpha(\emptyset) = 0$ and $\alpha(A) \leq \alpha(B)$ if $A \subset B$. An increasing set function is subadditive if $\alpha(A \cup B) \leq \alpha(A) + \alpha(B)$ for all $A, B \subset \mathcal{A}(\Omega)$. Finally, α is called inner regular if

$$\alpha(A) = \sup\{\alpha(B) | B \in A, B \subset \subset A\}$$

4.1. An Integral representation for Γ -limits. We recall that a function $u \in L^1(\Omega)$ is piecewise affine in Ω if there is a family of disjoint open subsets of Ω and a set $N \subset \Omega$ with |N| = 0 such that $\Omega = (\bigcup_{i \in I} \Omega_i) \bigcup N$ and $u_{|\Omega_i|}$ is affine in Ω_i . We have the following density result.

Proposition 6. For every $u \in W^1_{\Phi}(\Omega)$ there exists a sequence $u_j \in W^1_{\Phi}(\Omega)$ of piecewise affine functions such that $u_j \to u$ in $W^1_{\Phi}(\Omega)$.

Proof. Applying theorem 2.1 of [12], we can find a sequence $\{u_j\} \in C_0^{\infty}(\Omega)$ converging to u in $W_{\Phi}^1(\Omega)$. Furthermore, by proposition 2.1, chap. X of [13], for $u \in C_0^{\infty}(\Omega)$ there is a sequence $\{u_j\}$ of piecewise affine functions so that $u_j \to u$ and $Du_j \to Du$ uniformly in Ω . Then, since $u_j \in W_{\Phi}^1(\Omega)$ and the uniform convergence implies that

$$\int_{\Omega} \Phi(|u_j - u|) + \Phi(|Du_j - Du|) \, dx \to 0$$

a diagonal process gives the desired sequence.

We are in position to state and show an integral representation result for a class of functionals in the Orlicz space.

Theorem 4. Suppose that $F : L_{\Phi}(\Omega) \times \mathcal{A} \to [0, \infty)$ be an increasing functional satisfying the following assumptions:

- (1) F is local, i.e. F(u, A) = F(v, A) for all $A \in A$ and u, v such that u = v a.e. in A;
- (2) F is lower semicontinuous;
- (3) F(u+c, A) = F(u, A) for every $u \in L_{\Phi}(\Omega), c \in \mathbb{R}^n$
- (4) there is constant $\beta > 0$ and a function $a(x) \in L^1(\Omega)$ such that

$$0 \le F(u, A) \le \beta \int_A a(x) + \Phi(|Du|) \, dx$$

for all $u \in W^1_{\Phi}(\Omega)$, $A \in \mathcal{A}(\Omega)$

Then there exist a Caratheodory function $f: \Omega \times \mathbb{R}^n \to [0, \infty]$ such that (i) for every $u \in L_{\Phi}(\Omega)$,

$$F(u, A) = \int_{A} f(x, Du(x)) \, dx$$

(ii) $f(x, \cdot)$ is convex for every $x \in \Omega$ and it satisfies

$$0 \le f(x, p) \le a(x) + \Phi(|p|)$$

Proof. The proof, in general, follows the steps with the proof in the case of Sobolev spaces [8] with a few differences.

Step 1 We define the linear function $u_p(x) = p \cdot x$ and use assumption (4) of the theorem to claim that $F(u_p, \cdot)$ is continuous with respect to the Lebesgue measure. Thus there is a density function

$$f(x,p) = \lim_{\rho \to 0^+} \frac{F(u_p, B_\rho(x))}{|B_\rho(x)|}$$

in $L^1_{\text{loc}}(\Omega)$ such that

$$F(u_p, A) = \int_A f(x, p) \, dx$$

for $A \in \mathcal{A}$. One can show that the representation (i) holds for every piecewise affine function.

Step 2 It can be shown that $f(x, \cdot)$ is convex on \mathbb{R}^n :

$$f(x,p) \le tf(x,p_1) + (1-t)f(x,p_2)$$

for all $t \in [0, 1]$, $p_1 \neq p_2$ with $p = tp_1 + (1 - t)p_2$.

Step 3 The map

$$u \to \int_A f(x, Du(x)) \ dx$$

is continuous with respect to the $W^1_{\Phi}(\Omega)$ convergence. Let $u \in W^1_{\Phi}(\Omega)$ and $A \in \mathcal{A}$. Applying proposition 6, for $A' \subset A$ there exists a sequence u_j of piecewise affine functions such that $u_j \to u$ in $W^1_{\Phi}(\Omega)$. By the lower semicontinuity of F we have that

$$F(u,A') \le \liminf_{j \to \infty} F(u_j,A') = \lim_{j \to \infty} \int_{A'} f(x,Du_j) \, dx = \int_{A'} f(x,Du) \, dx$$

Taking the limit $A' \nearrow A$, we obtain $F(u, A) \leq \int_A f(x, Du) dx$ for all $u \in W^1_{\Phi}(\Omega)$ and $A \in \mathcal{A}$.

Step 4 Fix $v \in W^1_{\Phi}(\Omega)$ and define the functional

$$W(u,A) = F(u+v,A)$$

It is straighforward to see that G satisfies assumptions (1) - (3) and

(4) can ve verified with the computation

$$\begin{split} 0 &\leq W(u,A) = F(u+v,A) \leq \int_A a(x) + \Phi(|Du+Dv|) \ dx \\ &\leq 2^{\beta-1} \int_A \frac{a(x)}{2^{\beta-1}} + \Phi(|Du|) + \Phi(Dv|) \ dx \\ &= \int_A b(x) + \Phi(|Du|) \ dx \end{split}$$

where $b(x) = a(x) + 2^{\beta-1} \Phi(Dv|) \in L^1(\Omega), \ \beta = \log_2 k$. Thus, from step 1, we can find a measurable function $g: \Omega \times \mathbb{R}^n$ such that

$$W(u,A) \le \int_A g(x,Du) \ dx$$

for all piecewise affine functions $u \in W^1_{\Phi}(\Omega)$ and $A \in \mathcal{A}$. It follows that the map $u \to \int_A g(x, Du) dx$ is continuous in $W^1_{\Phi}(\Omega)$. For $A' \subset$ A there is a sequence of piecewise affine functions (v_n) converging to u in $W^1_{\Phi}(\Omega)$ so that step 1 together with the last inequality give us

$$\int_{A'} g(x,0) \, dx = W(0,A') = F(v,A')$$

$$\leq \int_{A'} f(x,Dv) \, dx = \lim_{n \to \infty} \int_{A'} f(x,Dv_n) \, dx = \lim_{n \to \infty} F(v_n,A')$$

$$\lim_{n \to \infty} W(v_n - v,A') \leq \lim_{n \to \infty} \int_{A'} g(x,Dv_n - Dv) \, dx = \int_{A'} g(x,0) \, dx$$
so as $A' \nearrow A$ we get $F(v,A) = \int_A f(x,Dv) \, dx$.

4.2. Uniform Estimate. To proceed to the compactness for integral functionals, we need to prove some properties of the Γ -limit as a set function. We do that by elaborating a method of joining sequences of functions so that, from the knowledge of the minimizing sequences for F(u, A) and F(u, B), we can obtain an estimate for $F(u, A \cup B)$. We need the following lemma.

Lemma 3. Suppose $U, U', V \in \mathcal{A}(A)$ with $U' \subset U$ and let $u \in W^1_{\Phi}(U)$, $v \in W^1_{\Phi}(V)$. Then for every cutoff function $\phi \in C^{\infty}_0(\Omega)$ between U' and U (i.e. spt $\phi \subset U$, $0 \le \phi \le 1$, $\phi = 1$ in U') we have $\phi u + (1 - \phi)v \in W^1_{\Phi}(U' \cup V)$.

Definition 3. Let $F: L_{\Phi} \times \Omega \to \mathbb{R}$ be a functional. We say that F satisfies the fundamental L_{Φ} -estimate if for every $U, U', V \in \mathcal{A}(A)$ with $U' \subset \subset U$ and $\sigma > 0$ there is $M_{\sigma} > 0$ such that for all $u, v \in L_{\Phi}(\Omega)$ there exists a cut-off function ϕ between U' and U such that

(4.1)
$$F(\phi u + (1 - \phi)v, U' \cup V)$$
$$\leq (1 + \sigma)(F(u, U) + F(v, V)) + M_{\sigma} \int_{(U \cap V) \setminus U')} \Phi(|u - v|) dx + \sigma$$

The same definition holds for a family $\{F_n\}_{n>0}$ if in addition there is n_0 such that for all $n \leq n_0$ the last estimate is valid uniformly.

This definition corresponds to the definition of L^p -fundamental estimate for functionals defined in L^p spaces.

Proposition 7 (Uniform estimate). The family $\mathcal{F}(c_f^1, c_f^2, \Phi)$ satisfies the fundamental L_{Φ} -estimate uniformly.

Proof. Pick $F \in \mathcal{F}(c_f^1, c_f^2, \Phi)$ and let $U, U', V \in \mathcal{A}(A)$ with $U' \subset \subset U$. Let $\delta = d(U', \partial U)$ and take parameters $0 < \eta < \delta, 0 < r < \delta - \eta$. Choose a cutoff function ϕ between the sets $\{x \in U : d(x, U') < r\}$ and $\{x \in U : d(x, U') < r\}$ with $|D\phi| \le 2/\eta$. Define $V_r^{\eta} = \{x \in V : r < d(x, U') < r + \eta\}$.

Let $u, v \in L_{\Phi}(\Omega)$. Then

$$\begin{split} F(u\phi + (1 - \phi)v, U' \cup V) \\ &= \int_{U' \cup V} f(x, \phi Du + (1 - \phi)Dv + (u - v)D\phi) \, dx \\ &= \int_{\{x \in V: d(x, U') \geq r + \eta\}} f(x, Dv) \, dx + \int_{\{x \in V \cup U': d(x, U') \leq r\}} f(x, Du) \, dx \\ &+ \int_{V_r^n} f(x, \phi Du + (1 - \phi)Dv + (u - v)D\phi) \, dx \\ &\leq F(v, V) + F(u, U) + c_f^2 \int_{V_r^n} 1 + \Phi(|\phi Du + (1 - \phi)Dv + (u - v)D\phi|) \, dx \\ &= F(v, V) + F(u, U) + c_f^2 \int_{V_r^n} 1 + \Phi\left(\frac{|\phi Du + (1 - \phi)Dv + (u - v)D\phi|}{3}\right) \, dx \\ &\leq F(v, V) + F(u, U) \\ &+ k3^\beta c_f^2 \int_{V_r^n} 1 + \Phi\left(\frac{|\phi Du + (1 - \phi)Dv + (u - v)D\phi|}{3}\right) \, dx \\ &\leq F(v, V) + F(u, U) \\ &+ k3^{\beta - 1}c_f^2 \int_{V_r^n} 1 + \Phi(|\phi Du|) + \Phi(|(1 - \phi)||Dv|) + \Phi(|(u - v)||D\phi|) \, dx \\ &\leq F(v, V) + F(u, U) \\ &+ k3^{\beta - 1}c_f^2 \int_{V_r^n} 1 + \Phi(|Du|) + \Phi(|Dv|) \, dx + k3^{\beta - 1}c_f^2(\frac{2}{\eta})^\beta \int_{(U \cap V) \setminus U'} \Phi(|(u - v)|) \, dx \end{split}$$

where $\beta = \log_2 k$. To obtain the above inequalities we use assumption (3.2), the properties of ϕ , Jensen's inequality and the fact that the Δ_2 -condition implies that $\Phi(\lambda u) \leq k \lambda^{\beta} \Phi(u)$, for $\lambda \geq 1$. Note that from (3.2),

$$c_f^2 \int_{U \cap V} 1 + \Phi(|Du|) + \Phi(|Dv|) \ dx \le c_f^2 |U \cap V| + \frac{c_f^2}{c_f^1} (F(u, U) + F(v, V))$$

Then, for all N = 1, 2, ... there is $\mu \in \{1, ..., N\}$ such that

$$\begin{split} c_f^2 k 3^{\beta-1} \int_{\{x \in V: \frac{\delta(\mu-1)}{N} < d(x,U') < \frac{\delta\mu}{N}\}} 1 + \Phi(|Du|) + \Phi(|Dv|) \ dx \\ &\leq c_f^2 k 3^{\beta-1} \frac{1}{N} |U \cap V| + c_f^2 k 3^{\beta-1} \frac{1}{N} \frac{c_f^2}{c_f^1} (F(u,U) + F(v,V)) \end{split}$$

Fix σ and choose $N \ge \max\left\{\frac{c_f^2 k 3^{\beta-1}}{\sigma}, \frac{1}{\sigma} k 3^{\beta-1} \frac{c_f^2}{c_f^1}\right\}, \eta = \frac{\delta}{N}$ and $r = (\mu - 1)\delta$

 $\frac{(\mu-1)\delta}{N}$ so that the constant M_{σ} depends only on U, U', V, c_f^1, c_f^2 . This implies that the estimate holds uniformly in $\mathcal{F}(c_f^1, c_f^2, \Phi)$.

Using the uniform estimate, one can include boundary conditions to the study of Γ -limits of local functionals.

Proposition 8. Suppose that $\{F_n\}$ is a family of functionals defined on $L_{\Phi}(\Omega) \times \mathcal{A}(A)$ that satisfy the fundamental L_{Φ} estimate as $n \to 0$ and let (n_j) be a sequence of positive numbers converging to zero. If $F'(u,U) = \Gamma(L_{\Phi}) - \liminf_j F_{n_j}(u,U)$ and $F''(u,U) = \Gamma(L_{\Phi}) - \limsup_j F_{n_j}(u,U)$ then

$$F'(u, U' \cup V) \le F'(u, U') + F''(u, V)$$

and

$$F''(u, U' \cup V) \le F''(u, U) + F''(u, V)$$

for all $u \in L_{\Phi}(\Omega)$ and $U, U', V \in \mathcal{A}(A)$.

Proof. We start by noticing that we can find two sequences $\{u_j\}$ and $\{v_j\}$ converging to u in L_{Φ} such that

$$F'(u,V) = \liminf_{j} F_{n_j}(u_j,V)$$

and

$$F''(u,V) = \limsup_{j} F_{n_j}(v_j,V)$$

Applying the fundamental estimate to $\{u_j\}$ and $\{v_j\}$ for fixed $\sigma > 0$, we can find $M_{\sigma}, n_{\sigma} > 0$ so that for $n_j < n_{\sigma}$ there is a sequence $w_j = \phi_j u_j + (1 - \phi_j) v_j$ $(\phi_j \text{ are cutoff functions})$ between U', U such that

$$F_{n_j}(w_j, U' \cup V) \le (1 + \sigma)(F_{n_j}(u_j, U) + F_{n_j}(v_j, V)) + M_\sigma \int_{(U \cap V)} \Phi(|u_j - v_j|) \, dx + \sigma$$

Since
$$\int_{U \cap V} \Phi(|u_j - v_j|) dx \to 0$$
, we have
 $F'(u, U \cup V) \leq \liminf_j F_{n_j}(w_j, U' \cup V)$
 $\leq (1 + \sigma)(\liminf_j F_{n_j}(u_j, U) + \limsup_j F_{n_j}(v_j, V)) + \sigma$
 $= (1 + \sigma)(F'(u, U) + F''(u, V)) + \sigma$

for any $\sigma > 0$. The proof of the second inequality follows the same steps. \Box

Then one can show that $F'(u, \cdot), F''(u, \cdot)$ are increasing set functions. We return to the proof of proposition 4:

Proof of proposition 4. Taking into account the compactness result 10.3 in [6] and the above propositions, there exists a subsequence $F_{h(n)}$ and a nonnegative, convex function $f_{\gamma} : \mathbb{R}^n \times \mathbb{R}^n \to \mathbb{R}$ such that

$$\int_{\Omega} f_{\gamma}(x, Du) \, dx = \Gamma(L_{\Phi}) \lim_{h \to \infty} (F_{h(n)})$$

for each $\Omega \in \mathcal{A}(A)$, $u \in L_{\phi}(\Omega)$. The growth conditions of f_{γ} remain the same (because of the lower semicontinuity) so that $f_{\gamma} \in \mathcal{F}(c_f^1, c_f^2, \Phi)$. \Box

Proposition 9. Let $\Omega \in \mathcal{A}$ and F_n be a sequence in \mathcal{F} . Suppose that X is a weakly closed subset in $W^1_{\Phi}(\Omega)$. Suppose $\{F_n(u,\Omega)\} \Gamma(L_{\Phi})$ - converges to a functional $\tilde{F} \in \mathcal{F}$. Let X be a weakly closed subspace of $W^1_{0,\Phi}(\Omega)$ and

$$c_1(x) + P^{-1}c_g^1 B(|u|) \le g(x,u) \le c_2(x) + P^{-1}c_g^2 B(|u|)$$

where $c_i(x) \in L^1(\Omega)$ and $\Phi \prec \prec P$. Then,

$$\lim_{n \to \infty} \min_{u \in X} G_n(u) = \min_{u \in X} \tilde{G}(u)$$

where $\tilde{G}(u) = \tilde{F}(u, \Omega) + \int_{\Omega} g(x, u(x)) dx$. Furthermore, any sequence $u_n \in X$ with $G_n(u_n) = \min_{u \in X} G_n(u)$ contains a subsequence that converges strongly in $L_{\Phi}(\Omega)$, weakly in $W_{\Phi}^1(\Omega)$ and a.e. in Ω to a function $\tilde{u} \in X$ such that

$$\tilde{G}(\tilde{u}) = \min_{u \in X} \tilde{G}(u)$$

Proof. From theorem 3, the functionals G_n, \tilde{G} attain their minimum in X. For any sequence such that $G_n(u_n) = \min_{u \in X} G_n(u)$, we have that u_n is bounded in $W^1_{\Phi}(\Omega)$ so, up to a subsequence u_{n_k} , it converges in $L_{\Phi}(\Omega)$ and pointwise a.e. to a function $\tilde{u} \in W^1_{\Phi}(\Omega)$ and

(4.2)
$$\liminf_{n \to \infty} \left(\min_{u \in X} G_n(u) \right) = \liminf_{n \to \infty} \left(\min_{u \in X} G_{n_k}(u) \right)$$

Take a fixed subset $B \subset \subset \Omega$; if the sequence u_{n_k} converges to \tilde{u} , the sequence $F_{n_k} \Gamma(L_{\Phi})$ -converges to \tilde{F}_{n_k} in B and hence

$$\tilde{F}(\tilde{u}, B) \leq \liminf_{n \to \infty} F_{n_k}(u_{n_k}, B) \leq \liminf_{n \to \infty} F_{n_k}(u_{n_k}, \Omega)$$

Fatou's lemma gives

$$\liminf_{n \to \infty} \int_{\Omega} g(x, u_{n_k}) \, dx \ge \int_{\Omega} g(x, \tilde{u}) \, dx$$

Combining, we obtain

$$\tilde{F}(\tilde{u}, B) + \int_{\Omega} g(x, \tilde{u}) dx$$

$$\leq \liminf_{n \to \infty} \left[F_{n_k}(u_{n_k}, B) + \int_{\Omega} g(x, u_{n_k}) dx \right] = \liminf_{n \to \infty} G_{n_k}(u_{n_k})$$

and hence taking $B \uparrow \Omega$ yields

$$\tilde{G}(\tilde{u}) \le \liminf_{n \to \infty} G_{n_k}(u_{n_k})$$

Consider now the second term $K(u) = \int_{\Omega} g(x, u) \, dx$ and note that Lemma 1 implies the continuity of K in X.

We will show that for all $\varepsilon > 0$ there is a sequence (v_n) in X converging to \tilde{v} so that

$$\limsup_{n \to \infty} F_n(v_n, \Omega) \le (1 + \varepsilon)\tilde{F}(\tilde{v}, \Omega) + c\varepsilon$$

with $c = c(\tilde{v})$. Fix $\varepsilon \in [0, 1]$. Our assumption says that there is a sequence (w_n) converging to \tilde{v} in $L_{\Phi}(\Omega)$ such that

$$\tilde{F}(\tilde{v},\Omega) \ge \limsup_{n \to \infty} F_n(w_n,\Omega)$$

To have that $v_n \in X$, we modify w_n by taking a compact subset B of Ω with

$$\int_{\Omega \setminus B} (1 + \Phi(|D\tilde{v}|)) \, dx < \varepsilon$$

and sets Ω_1, Ω_2 with $B \subset \Omega_1 \subset \Omega_2 \subset \Omega$. Applying proposition 6, one can find M > 0 and cutoff functions $\phi_1, \phi_2, ..., \phi_k$ of $C_0^{\infty}(\Omega_2)$ between the sets Ω_1, Ω_2 so that

$$\begin{split} \min_{1 \le i \le k} F_n(\phi_i w_n + (1 - \phi_i)\tilde{v}, \Omega) \\ &\le (1 + \varepsilon)[F_n(w_n, \Omega) + F_n(\tilde{v}, \Omega \setminus B)] \\ &+ \varepsilon \left[\int_{\Omega} \Phi(w_n) \ dx + \int_{\Omega \setminus B} \Phi(\tilde{v}) \ dx + 1 \right] + M \int_{\Omega \setminus B} \Phi(w_n - \tilde{v}) \ dx \end{split}$$

for $n \in \mathbb{N}$. If we denote by i_n the index at which the minimum is attained and define $v_n = \phi_{i_n} w_n + (1 - \phi_{i_n}) \tilde{v} \in X$ then v_n converges to \tilde{v} in X. Finally,

$$\begin{split} \limsup_{n \to \infty} F_n(v_n, \Omega) \\ &\leq (1 + \varepsilon) \left[\limsup_{n \to \infty} F_n(w_n, \Omega) + C \int_{\Omega \setminus B} (1 + \Phi(|D\tilde{v}|)) \, dx \right] \\ &+ \varepsilon \left[2 \int_{\Omega} \Phi(\tilde{v}) \, dx + 1 \right] \\ &\leq (1 + \varepsilon) \tilde{F}(\tilde{v}, \Omega) + c\varepsilon \end{split}$$

which completes the proof.

In our previous discussion, the function f may be taken in the form f(x, z, p) instead of f(x, p).

The following theorem shows the connection between the distance d and the Γ -convergence. Together with proposition 4, it shows that (\mathcal{F}, d) is complete.

Theorem 5. Suppose that $\{F_n\}_{n>0}$ is a sequence in \mathcal{F} and $F_{\gamma} \in \mathcal{F}$. The following conditions are equivalent:

(1) $\lim_{n \to \infty} d(F_n, F_{\gamma}) = 0$ (2) $\Gamma(L_{\Phi}) \lim_{n \to \infty} (F_n) = F_{\gamma}$ (3) $\lim_{n \to \infty} (T_{\varepsilon}F_n)(u, \Omega) = (T_{\varepsilon}F_{\gamma})(u, \Omega) \ \forall \varepsilon > 0, \ u \in L_{\Phi}, \ \Omega \in \mathcal{A}(A)$

Corollary 1. The map $m_{\Omega,X,g}(F) = \min_{u \in X} J(u,\Omega)$ is continuous on (\mathcal{F},d) for $\Omega \in \mathcal{A}(A), X \subseteq W^1_{\Phi}(\Omega)$.

5. RANDOM FUNCTIONALS AND THE ERGODIC THEOREM

We denote by (S, Σ, P) a fixed probability space where Σ is the σ -algebra on S and P is the probability measure. A random functional is a measurable function $F: S \to \mathcal{F}$ when \mathcal{F} is endowed with the field Σ_S generated by the distance d. The image $P(F^{-1}(S)), S \in \Sigma_S$ is the distribution law of F. If F and G have the same distribution law, we write $F \sim G$.

For $z \in \mathbb{Z}^n$ we define the translation operator τ_z by

(5.1)
$$(\tau_z F)(u,\Omega) = \int_{\Omega} f(x+z,Du) \ dx$$

and for $\varepsilon > 0$ the homothety operator ρ_{ε} by

(5.2)
$$(\rho_{\varepsilon}F)(u,\Omega) = \int_{\Omega} f(\frac{x}{\varepsilon}, Du) \ dx$$

Note that, since the integrand is independent of u,

$$(\tau_z F)(u,\Omega) = F(\tau_z u, \tau_z \Omega)$$

where $\tau_z u(x) = (x - z), \ \tau_z \Omega = \{x \in \mathbb{R}^n : x - z \in \Omega\}$ and

$$\rho_{\varepsilon}F(u,\Omega) = \varepsilon^n F(\rho_{\varepsilon}u,\rho_{\varepsilon}\Omega)$$

where $\rho_{\varepsilon}u = \frac{1}{\varepsilon}u(\varepsilon x)$, $\rho_{\varepsilon}\Omega = \{x \in \mathbb{R}^n : \varepsilon x \in \Omega\}$. If *F* is a random functional then both the translated and the homothetic functionals are also random functionals.

A stochastic homogenization process is a family of random variables $(F_{\varepsilon})_{\varepsilon>0}$ that has the same distribution law with the random functionals $\rho_{\varepsilon}F$.

For $F \in \mathcal{F}$, $u \in L_{\Phi}(\Omega)$, we consider the Dirichlet problem

(5.3)
$$m(F, u_0, \Omega) = \min_{u} \{ F(u, \Omega) : u - u_0 \in W^1_{0, \Phi}(\Omega) \}$$

Let $Q_{1/\varepsilon}$ be the cube

$$Q_{1/\varepsilon} = \{ x \in \mathbb{R}^n : |x_i| < 1/\varepsilon, i = 1, ..., n \}$$

with volume $(2/\varepsilon)^n$. We denote by $l_p = p \cdot x$ the linear function with gradient p. The main theorem of this section is the following:

Theorem 6. Let F be a random integral functional and define $F_{\varepsilon} = \rho_{\varepsilon}F$. Suppose that $\tau_z F = F(\tau_z u, \tau_z A)$ and F have the same distribution law. Then the family F_{ε} converges P-almost everywhere as $\varepsilon \to 0^+$ to a random integral functional F_0 . In addition, there is a set $S' \subset S$ of full measure such that the limit

$$f_0(\omega, p) = \lim_{\varepsilon \to 0^+} \frac{m(u, l_p, Q_{1/\varepsilon})}{|Q_{1/\varepsilon}|}$$

exists for all $\omega \in \mathcal{S}'$ and

$$F_0(u,\Omega) = \int_{\Omega} f_0(\omega,p) \, dx$$

Moreover, if F is ergodic, the integrand f_0 is independent of ω and

$$f_0(p) = \lim_{\varepsilon \to 0^+} \int_{\Omega} \frac{m(u, l_p, Q_{1/\varepsilon})}{|Q_{1/\varepsilon}|}$$

for all $p \in \mathbb{R}^n$, $\varepsilon > 0$.

We give a sketch of the proof which can be found in [11]. We need the following results.

In [9], the question of determining an integral functional by the knowledge of their minima was studied. In particular, suppose the numbers

$$m(u, l_p, \Omega)$$

are given and that we have a family of subsets $\{A_{\rho}\}_{\rho>0}$ of \mathbb{R}^n which shrinks nicely to x as $\rho \to 0^+$. This means that the following density-type inequalities are satisfied:

$$A_{\rho} \subseteq B(x,\rho) \qquad |A_{\rho}| \ge c|B(x,\rho)|$$

where $B(x, \rho)$ is the ball centered at x of radius ρ . The following theorem holds

Theorem 7. Suppose $f: \Omega \times \mathbb{R}^n \to \mathbb{R}$ satisfies the assumptions of section 3, (3.1) and

$$\phi_1(p) \le f(x,p) \le \phi_2(p)$$

for all $(x,p) \in (\Omega \times \mathbb{R}^n)$ where ϕ_1, ϕ_2 are convex in p and

$$\lim_{|p| \to \infty} \frac{\phi_1(p)}{|p|} = \infty$$

Then there is a measurable subset $N \subseteq \mathbb{R}^n$ with |N| = 0 such that

$$f(x,p) = \lim_{\rho \to 0^+} \frac{m(u, l_p, A_\rho)}{|A_\rho|}$$

for all $p \in \mathbb{R}^n$, $x \in \mathbb{R} \setminus N$ and every family $\{A_\rho\}_{\rho>0}$ shrinking nicely to x as $\rho \to 0^+$.

A function $\mu : A \to \mathbb{R}$ is called subadditive if for every finite and disjoint family $(A_i)_{i \in I}$ with $|A \setminus \bigcup_{i \in I} A_i| = 0$,

$$\mu(A) \le \sum_{i} \mu(A_i)$$

We say that μ is dominated if $0 \leq \mu(A) \leq C|A|$ for all sets A. Consider now the family of dominated, subadditive functions and the group of translations $(\tau_z \mu)(A = \mu(\tau_z A))$, where $\tau_z A = \{x \in \mathbb{R}^n : x - z \in A\}$.

Theorem 8. (Ergodic)(see [2], [10]): Let $\mu : S \to \mathbb{R}^n$ be a subadditive process, periodic in law, in the sense that $\mu(\cdot)$ and $\tau_z \mu(\cdot)$ have the same distribution for every $z \in \mathbb{Z}^n$. Then, there exists measurable function ϕ : $S \to R$ and a subset $\Omega' \subset \Omega$ of full measure such that

$$\lim_{t \to \infty} \frac{\mu(\omega)(tQ)}{|tQ|} = \phi(\omega)$$

exists a.e. $\omega \in S'$ and for every cube $Q \subset \mathbb{R}^n$. Furthermore, if μ is ergodic then ϕ is constant.

We return to the proof of theorem 6.

Proof. For fixed $p \in \mathbb{R}^n$ and for $\omega \in S$ we define

$$\mu_p(\omega)(\Omega) = m(F(\omega), l_p, \Omega)$$

which is a measurable map, since $m(\cdot, l_p, \Omega)$ is continuous in \mathcal{F} . For $z \in \mathbb{Z}^n$,

$$(\tau_z \mu_p)(\omega)(\Omega) = m_p(\omega)(\tau_z \Omega)$$

= $\min_u \{ (\tau_z F)(\omega)(\tau_{-z}u, \Omega) : \tau_{-z}u - \tau_{-z}l_p \in W^1_{0,\Phi}(\Omega) \}$
= $\min_u \{ (\tau_z F)(\omega)(v + l_p(z), \Omega) : v - l_p \in W^1_{0,\Phi}(\Omega) \}$

and

$$(\tau_z F)(\omega)(v+l_p(z),\Omega) = (\tau_z F)(\omega)(v,\Omega)$$

since the integrand is independent of u. Thus,

$$(\tau_z \mu_p)(\omega)(\Omega) = m((\tau_z F), l_p, \Omega)$$

which shows that μ_p is periodic in law. Applying theorem 4, there exists measurable function $\phi : \Omega \to R$ and a subset $\Omega' \subset \Omega$ of full measure such that

$$\lim_{t \to \infty} \frac{\mu_p(\omega)(tQ)}{|tQ|} = \phi_p(\omega)$$

exists a.e. $\omega \in \Omega'$ and for every cube $Q \subset \mathbb{R}^n$. Let

$$f_0(\omega, p) = \limsup_{t \to \infty} \frac{\mu_p(\omega)(Q_t)}{|Q_t|}$$

We observe that the convexity of F in u says that the functions

$$p \to \frac{\mu_p(\omega)(\Omega)}{|\Omega|}$$

are convex and equibounded. Hence, f_0 is convex in p and

$$f_0(\omega, p) = \lim_{t \to \infty} \frac{\mu_p(\omega)(tQ)}{|tQ|}$$

Furthermore,

$$\mu_p(\omega)(tQ) = t^n m((\rho_{1/t}F)(\omega), l_p, Q)$$

so that, since $\rho_{\varepsilon}F = F_{\varepsilon}$,

$$\lim_{\varepsilon \to 0^+} \frac{m(F(\omega), l_p, Q)}{|Q|} = f_0(\omega, p)$$

for each cube $Q, p \in \mathbb{R}^n, \omega \in \mathcal{S}'$. Fix $\omega \in \mathcal{S}'$. Corollary 1 and proposition 4 tell that there is an integral functional $F_0(\omega) \in \mathcal{F}$ such that $F_{\varepsilon}(\omega) \Gamma$ converges to $F_0(\omega)$. Then we are in position to compute the integrand of $F_0(\omega)$ since, from theorem 7 there is a subset N with |N| = 0 such that

$$g_{0}(\omega, x, p) = \lim_{\rho \to 0^{+}} \frac{m(F_{0}(\omega), l_{p}, Q_{\rho})}{|Q_{\rho}|}$$
$$= \lim_{\rho \to 0^{+}} \lim_{\varepsilon \to 0^{+}} \frac{m(F_{\varepsilon}(\omega), l_{p}, Q_{\rho})}{|Q_{\rho}|}$$
$$= \lim_{\rho \to 0^{+}} \lim_{\varepsilon \to 0^{+}} \frac{\mu_{p}(\omega) \left(\frac{1}{\varepsilon}Q_{\rho}\right)}{\left|\frac{1}{\varepsilon}Q_{\rho}\right|} = f_{0}(\omega, p)$$

for all $x \in \mathbb{R}^n \setminus N$, $p \in \mathbb{R}^n$ so that

$$F_0(u,\Omega) = \int_{\Omega} f_0(\omega,Du) \, dx$$

Note that if F is ergodic, μ_p is constant.

Remark 1. The last proof is derived in [10] under the assumption that the integrand is independent of u. If the integrand depends on u, i.e. $f = f(\omega, x, u, Du)$, we can consider the function

$$f_u(\omega, x, Du) = f(\omega, x, u, Du)$$

and apply the last proof to see that

$$f_{0,u}(\omega, p) = \lim_{\varepsilon \to 0^+} \frac{m(F_u(\omega), l_p, Q_{1/\varepsilon})}{|Q_{1/\varepsilon}|}$$

for all $\omega \in \mathcal{S}'$, $p \in \mathbb{R}^n$. Hence,

$$F_{0,u}(u,\Omega) = \int_{\Omega} f_0(\omega, u, Du) \, dx$$

and from the last limit,

$$f_0(\omega, u, p) = f_{0,u}(\omega, p)$$

The abstract form of this theorem can be applied to obtain homogenization results over random structures for partial differential equations defined in Orlicz-Sobolev spaces.

5.1. Examples of random functionals. An application of theorem 3 is the case of random two-phase domains. Such domains can be obtained for instance from the realization of Poisson processes. Construction of random domains has been studied in [14], using the connectivity function of continuum percolation theory [19]. In particular, we take a Poisson process X with density $\lambda > 0$ and we consider the realization $X(\omega)$ of the process in a given domain $\Omega \subset \mathbb{R}^n$, for some $\omega \in S$. A connection function $g : \mathbb{R}^+ \to [0, 1]$ connects two points $x_1, x_2 \in X$ with probability $g(|x_1 - x_2|)$, where $|\cdot|$ denotes the Euclidean distance. Suppose that ω is a given realization for X which is locally finite, i.e. a finite number of points hits every compact set $K \subset \mathbb{R}^n$ almost surely:

 $P(\omega \in \Omega : \psi(K) < \infty \text{ for all compact } K \subset \mathbb{R}^n) = 1$

where $\psi(\cdot)$ is a counting measure. Let $x_i \in X$ be a given point of this realization.

Consider the annulus $A = \{x \in \mathbb{R}^n : c_1 \leq |x - x_i| \leq c_2\}$, where c_1, c_2 are positive constants with $c_1 \leq c_2$.

We connect the point x_i with all the points in A that are given from X. For this purpose we choose the connection function

$$g(|x - x_i|) = \begin{cases} 1 & \text{if } c_1 \le |x - x_i| \le c_2 \\ 0 & \text{otherwise} \end{cases}$$

For a point $x_i \in A$, we denote by $l_{ij}(\omega) = l(x_i, x_j)$ the line segment with endpoints x_i, x_j and let $T_{c_1/2}(l_{ij})(\omega)$ the tube of radius $c_1/2$ surrounding l_{ij} . Let now $T(x_i)(\omega) = \bigcup_j T_{c_1/2}(l_{ij})(\omega)$ and $G(\omega, c_1/2) = \bigcup_i T(x_i)(\omega)$ for all points x_i of the process.

Thus, the set $G(\omega, c_1/2)$ is the union of random tubes obtained from the given realization of the point process. Let $\Omega(\omega, c_1/2) = \mathbb{R}^n \setminus G(\omega, c_1/2)$.

We define the indicator function

$$a(\omega, x) = 1 - \min\{X_{F(\omega, c_1/2)}, 1\}$$

which is zero in the union of tubes and one elsewhere.

Let Ω be an open, bounded domain of \mathbb{R}^n and consider the random functional $F(\omega)(u,\Omega) = \int_{\Omega} a(\omega,x) f(\omega,Du) dx = \int_{G(\omega)\cap\Omega} f(\omega,Du) dx$ for $u \in W^1_{\Phi}(\Omega)$. This functional is periodic in law and independent at large distances, thus ergodic. Furthermore let $(\rho_{\varepsilon}F)(u,A) = \varepsilon^n F(\rho_{\varepsilon}u,\rho_{\varepsilon}A)$ where $(\rho_{\varepsilon}u)(x) = \frac{1}{\varepsilon}u(\varepsilon x), \ (\rho_{\varepsilon}A) = \{x \in \mathbb{R}^n : \varepsilon x \in A\}$

Then the family

$$F^{\varepsilon}(u,\Omega) = \rho_{\varepsilon}F(u,\Omega)$$

satisfies the assumptions of theorem 3. Note that the ρ_{ε} – homothetic functional is the functional obtained if we scale by ε the distance between the connected points of the set $F(\omega, c_1/2)$ that corresponds to the union of tubes $\varepsilon F = F(\varepsilon \omega, \varepsilon c_1/2)$, where $\varepsilon \omega$ maps to the point measure whose support is $\{\varepsilon x_i\}$ and $\{x_i\}$ is the support of $X(\omega)$. Also, the scaling properties of this model are the same (in terms of distribution) with the model that we have if we choose

$$g_{\varepsilon}(|x - x_i|) = \begin{cases} 1 & \text{if } c_1 \varepsilon \le |x - x_i| \le c_2 \varepsilon \\ 0 & \text{otherwise} \end{cases}$$

with density function λ/ε . Let us define $G^{\varepsilon}(\omega) = \varepsilon G = G(\varepsilon \omega, \varepsilon c_1/2)$ and $\Omega^{\varepsilon}(\omega) = \varepsilon \Omega(\omega) = \mathbb{R}^n \setminus G^{\varepsilon}(\omega).$

We may also model a domain perforated with balls at random positions but nonintersecting. Instead of constructing tubes, we let every point be the center of a ball with radius $\rho(\omega) \leq \min d(x_i, x_j)(\omega)$, where the minimum is taken over all the pairs of points x of $X(\omega)$. Note that, without any affect to our proofs, we may assume that $\rho(\omega)$ is identically distributed random variable taking maximum value $\min d(x_i, x_j)(\omega)/4$. We consider for simplicity the first case. According to this construction, we obtain a domain randomly perforated with balls of radius and with minimal distance between them. Finally, we define

 $G^{\varepsilon}(\omega) = \bigcup_{i \ge 1} B(\varepsilon \rho(\omega), \varepsilon x_i) \cap \Omega$ and $\Omega^{\varepsilon}(\omega) \cap \Omega = \Omega \setminus G^{\varepsilon}(\omega)$. Note that meas $G^{\varepsilon}(\omega)$ tends to zero as $\varepsilon \to 0$.

6. Application to homogenization problems

6.1. Homogenization of pde's with generalized growth conditions. We study the homogenization of the Dirichlet problem

$$\operatorname{div} A(x, u^{\varepsilon}, Du^{\varepsilon}) + B(x, u^{\varepsilon}, Du^{\varepsilon}) = f(x) \text{ in } \Omega^{\varepsilon}, u^{\varepsilon} - u_0 \in W^1_{0, G}(\Omega^{\varepsilon})$$

where $\Omega^{\varepsilon} = \Omega^{\varepsilon}(\omega)$ is a randomly perforated domain (as in section 4.1 for instance), $\Omega^{\varepsilon} = \Omega \setminus G^{\varepsilon}$, G to be precisely defined below. We assume that the following structure conditions hold:

(6.2)
$$p \cdot A \ge |p|g(|p|) - a_1g\left(\frac{|z|}{R}\right)\frac{|z|}{R} - a_2$$

(6.3)
$$|A| \le a_3 g(|p|) + a_4 g\left(\frac{|z|}{R}\right) + a_5$$

where a_1, a_2, a_3, a_4, a_5 are nonnegative constants and g is a C^1 function satisfying

(6.4)
$$\delta \le \frac{tg'(t)}{g(t)} \le g_0 \text{ if } t > 0$$

for some $\delta > 0$.

We define $G(t) = \int_0^t g(s) \, ds$. It can be shown [17] that G is twice differentiable, convex function and it satisfies

(6.5)
$$\frac{tg(t)}{1+g_0} \le G(t) \le tg(t) \text{ if } t \ge 0,$$

(6.6)
$$\frac{G(a)}{G(b)} \le \frac{a}{b} \text{ if } b \ge a > 0,$$

(6.7)
$$g(t) \le g(2t) \le 2^{g_0} g(t) \text{ if } t \ge 0,$$

(6.8)
$$ag(b) \le ag(a) + bg(b) \text{ if } a, b \ge 0$$

The smoothness of solutions for the equation (5.1) under the above structure conditions have been derived in [17].

If in addition $tg(t) \leq C$ for $t \geq 0$, (5.5) implies that G satisfies the Δ_2 -condition. To see this, note that from (5.5),

$$\frac{C}{t} \ge \frac{g(t)}{G(t)} = \frac{G'(t)}{G(t)} = (\log G(t))'$$

and consequently

$$\log \frac{G(2t)}{G(t)} = \int_t^{2t} \frac{g(s)}{G(s)} \, ds \le C \log 2$$

i.e.

$$G(2t) \le 2^C G(t)$$

Thus, $G \in \Delta_2$ with $k = 2^c$. The additional assumption $tg(t) \leq C$ is also included in [17][Lemma 2.1] to derive L^{∞} estimates for the solutions.

We denote by $W_G^1(\Omega)$ the Orlicz-Solobev space as defined in section 2.1. We seek the asymptotic behavior of the family u^{ε} as $\varepsilon \to 0$ in the general variational form

(6.9)
$$\inf\left\{\int_{\Omega^{\varepsilon}} f(x, u^{\varepsilon}, Du^{\varepsilon}) \ dx : u^{\varepsilon} - u_0 \in W^1_{0,G}(\Omega^{\varepsilon})\right\}$$

where $u_0 \in C^1(\overline{\Omega})$, f(x, u, p) is a measurable function defined in $\Omega \times \mathbb{R} \times \mathbb{R}^n$, continuously differentiable with respect to u, p and satisfies

(6.10)
$$C_1G(|p|) - C_2G(u) \le f(x, u, p) \le C_3(1 + G(u) + G(|p|)),$$

(6.11)

$$|f(x, u, p) - f(x, v, q)| \le C_4(1 + g(u) + g(v) + g(|p|) + g(|q|))(|u - v| + |p - q|),$$

(6.12)
$$f(x, u, p) - f(x, u, q) - \sum_{i=1}^{n} f_{q_i}(x, u, q)(p_i - q_i) \ge 0$$

with $f_{p_i} = A_i, f_u = B$.

Theorem 9 ([17]). Suppose that g satisfies (5.4)

(6.13)
$$p \cdot A \ge |p|g(|p|) - a_1g(|p|)|p| - a_2$$

$$(6.14) |A| \le a_3 g(|p|) + a_5,$$

(6.15)
$$|B| \le b_0 g(|p|)|p| + b_1$$

for $x \in \Omega^{\varepsilon}$, $|z| \leq M$. If $u^{\varepsilon} \in L^{\infty} \cap W^{1}_{G}$ solves $Lu^{\varepsilon} = 0$ where

$$Lz = \operatorname{div} A(x, z, p) + B(x, z, p)$$

with $|u^{\varepsilon}| \leq M$ in Ω^{ε} . Then u^{ε} is locally Holder continuous with

$$\operatorname{osc}_{B_{\rho}} u^{\varepsilon} \leq C \left(\frac{\rho}{R}\right)^{\alpha} \left(\operatorname{osc}_{B_{R}} u^{\varepsilon} + \chi R\right)$$

for $\alpha > 0$, $C = C(a_3, b_0 M, g_0, n, \delta)$ and concentric balls B_{ρ} , B_R in Ω^{ε} , $0 < \rho \leq R \leq 1$.

6.2. **Passing the limit.** In this section, we improve the homogenization method of [18]. For the convinience of the reader we present it explicitly. Taking $u_0 \in C^1(\Omega)$ and using the smoothness of the solution from the last section, we can extend u^{ε} to Ω by taking $u^{\varepsilon} = u_0$ in $\Omega \setminus \Omega^{\varepsilon}$. We keep the notation u^{ε} for the extended function. Then,

$$\|u^{\varepsilon}\|_{W^1_G(\Omega)} \le c \|f\|_{W^1_G(\Omega)}$$

and hence, the family u^{ε} is compact in $C^{\alpha}(\Omega)$ and weakly compact in $W^{1}_{G}(\Omega)$. Thus, we can extract a subsequence, still denoted by u^{ε} that converges weakly to a function $u \in C^{\alpha}(\Omega) \cap W^{1}_{G}(\Omega)$. We denote by $Q_h^x = Q(x,h)$ the cube centered at x of size h > 0 and we define the function

(6.16)
$$R(x, v^{\varepsilon}, \nabla v^{\varepsilon}) = f(x, 0, \nabla v^{\varepsilon}) + h^{-1-\gamma} G(v^{\varepsilon} - b)$$

where γ is a positive parameter. We also define the capacity-type functionals

(6.17)
$$\operatorname{cap}_{f}(\omega, x, \varepsilon, h, b) = \inf_{v^{\varepsilon}} \int_{Q_{x}^{h} \cap \Omega^{\varepsilon}} f(x, 0, \nabla v^{\varepsilon}) \, dx$$

and

(6.18)
$$\operatorname{cap}(\omega, x, \varepsilon, h, b) = \inf_{v^{\varepsilon}} \int_{Q_x^h \cap \Omega^{\varepsilon}} R(x, v^{\varepsilon}, \nabla v^{\varepsilon}) \, dx$$

where the infimum is taken over the set $\{v^{\varepsilon} \in W^{1}_{G}(\Omega) : v^{\varepsilon} = 0 \text{ in } \Omega \setminus \Omega^{\varepsilon}\}$. Note that theorem 3 shows that the limit

$$\lim_{h \to 0} \lim_{\varepsilon \to 0} \frac{\operatorname{cap}_f(\omega, x, \varepsilon, h, b)}{h^n} = c(x)$$

exists for every point $x \in \Omega$. In addition, since our functionals are independent at large distances, the ergodicity implies that the limit $c(x) = c_0$ is constant. The continuity of v^{ε} shows that the integral $\int_{Q_x^h \cap \Omega^{\varepsilon}} G(v^{\varepsilon} - b) dx$ can estimated in terms of $\int_{Q_x^h \cap \Omega^{\varepsilon}} G(|\nabla v^{\varepsilon}|) dx$ (see also [20] for Poincare type inequalities) times a factor $h^{1+\gamma}$.

Let us also consider the limit

$$\lim_{h \to 0} \lim_{\varepsilon \to 0} \frac{\operatorname{cap}(\omega, x, \varepsilon, h, b)}{h^n} = c_0(b)$$

Furthermore, we assume that for every $x \in \Omega$,

$$\limsup_{\varepsilon \to 0} \frac{\operatorname{cap}(\omega, x, \varepsilon, h, b)}{h^n} \le C(1 + g(|b|))|b|$$

Theorem 10. The (extended) family of minimizers of (5.9) converges weakly to the minimizer $u \in C^{\alpha}(\Omega) \cap W^{1}_{G}(\Omega)$ of

(6.19)
$$\inf\left\{\int_{\Omega} f(x, u, Du) + c_0(u - u_0) \ dx : u - u_0 \in W^1_{0,G}(\Omega)\right\}$$

Proof. We consider a partition of Ω with cubes $Q^{\alpha} = Q(x^{\alpha}, h)$ centered at x^{α} of size h, so that $\cup_{\alpha}Q(x^{\alpha}, h)$ is a cover of Ω and the points x^{α} form a periodic lattice of period h - r, r to be chosen. Consider a partition of unity $\{\phi_{\alpha}\}$ of C^{2} functions such that

(1) $0 \le \phi_{\alpha} \le 1$ (2) $\phi_{\alpha} = 0$ if $x \notin Q^{\alpha}, \phi_{\alpha} = 1$ if $x \in Q^{\alpha} \setminus \bigcup_{\beta \ne \alpha} Q^{\beta}$ (3) $\sum_{\alpha} \phi_{\alpha}(x) = 1$, if $x \in D$ (4) $|\nabla \phi_{\alpha}| \le C/r$

Let us denote by $v_{\alpha} = v_{\alpha}^{\varepsilon}$ the minimizer of (6.9) in the cube centered at x^{α} with $b = b_{\alpha}$.

From the last assumption and (6.10),

$$\int_{Q^{\alpha}} G(|\nabla v_{\alpha}|) \, dx = O(h^n)$$

and

$$\int_{Q^{\alpha}} G(|v_{\alpha} - b_{\alpha}|) \ dx = O(h^{n+1+\gamma})$$

We denote by $\hat{Q}_h^{\alpha} = Q_h^{\alpha} \setminus \bigcup_{\beta \neq \alpha} Q_h^{\beta}$ the concentric cube centered at x^{α} of size $\hat{h} = h - 2r$. Then,

$$\begin{split} &\int_{Q_{h}^{\alpha} \setminus \hat{Q}_{h}^{\alpha}} R(x, v_{\alpha}, \nabla v_{\alpha}) \, dx \\ &= \int_{Q_{h}^{\alpha}} R(x, v_{\alpha}, \nabla v_{\alpha}) \, dx - \int_{\hat{Q}_{h}^{\alpha}} R(x, v_{\alpha}, \nabla v_{\alpha}) \, dx + O(rh^{n-1}) \\ &\leq \operatorname{cap}(\omega, x, h, \varepsilon, b) - \operatorname{cap}(\omega, x, \hat{h}, \varepsilon, b) + O(rh^{n-1}) \end{split}$$

So,

$$\int_{(Q_h^{\alpha} \setminus \hat{Q}_h^{\alpha}) \cap \Omega^{\varepsilon}} R(x, v_{\alpha}, \nabla v_{\alpha}) \, dx = o(h^n)$$

which implies that

(6.20)
$$\int_{(Q_{h}^{\alpha} \setminus \hat{Q}_{h}^{\alpha}) \cap \Omega^{\varepsilon}} G(|\nabla v_{\alpha}|) \ dx = o(h^{n})$$

(6.21)
$$\int_{(Q_h^{\alpha} \setminus \hat{Q}_h^{\alpha}) \cap \Omega^{\varepsilon}} G(v_{\alpha} - b_{\alpha}) \ dx = o(h^n) h^{1+\gamma}$$

Note that these relations imply that the local limit

$$\lim_{h \to 0} \lim_{\varepsilon \to 0} \frac{\operatorname{cap}(\omega, x, \varepsilon, h, b)}{h^n} = c(x, b) = c_0(b)$$

exists.

Consider a function $w \in C^1(\Omega)$ such that $w = u_0$ on $\partial\Omega$ and denote by \mathcal{K}_{θ} the set of the cubes Q_h^{α} that cover Ω such that $|w(x) - f(x)| > \theta$ for $\theta > 0$.

We set $b_{\alpha} = w(x^{\alpha}) - f(x^{\alpha})$ for each $Q_h^{\alpha} \in \mathcal{K}_{\theta}$ and $b_{\alpha} = 1$ for $Q_h^{\alpha} \notin \mathcal{K}_{\theta}$. For each cube Q_h^{α} , we define the set

(6.22)
$$\mathcal{B}^{\alpha}(\delta,\varepsilon,h) = \{x \in Q_h^{\alpha} : \operatorname{sgn} b_{\alpha} \le |b_{\alpha}| - \delta\}$$

and the function

$$V_{\alpha}^{\varepsilon}(x) = \begin{cases} v_{\alpha}^{\varepsilon} & \text{if } x \in \mathcal{B}^{\alpha}(\delta, \varepsilon, h) \\ b_{\alpha}^{\delta} = (|b_{\alpha}| - \delta) \operatorname{sgn} b_{\alpha} & \text{if } x \in Q_{h}^{\alpha} \setminus \mathcal{B}^{\alpha}(\delta, \varepsilon, h) \end{cases}$$

with $0 < \delta \leq \theta/2 \ll 1$. To estimate the measure of $\mathcal{B}^{\alpha}(\delta, \varepsilon, h)$, observe that from our assumption and (5.26), for ε sufficiently small,

$$G(\delta) \operatorname{meas} \mathcal{B}^{\alpha}(\delta, \varepsilon, h) \leq \int_{\mathcal{B}^{\alpha}(\delta, \varepsilon, h) \cap \Omega^{\varepsilon}} G(v_{\alpha} - b_{\alpha}) \, dx$$
$$\leq \int_{Q_{h}^{\alpha} \cap \Omega^{\varepsilon}} G(v_{\alpha} - b_{\alpha}) \, dx \leq Ch^{n+1+\gamma}$$

We set $\delta = G^{-1}((h^{-1-\gamma})^{-1+\delta_1})$ for $\delta_1 \in (0,1)$. Then

(6.23)
$$\operatorname{meas} \mathcal{B}^{\alpha}(\delta, \varepsilon, h) = O(h^n) h^{(1+\gamma)\delta_1} = o(h^n)$$

as $h \to 0$. For $w \in C^2(\Omega)$ supported in Ω , consider the function

$$w_h^{\varepsilon}(x) = w(x) + \sum_{\alpha} \frac{(w(x) - u_0(x))}{b_{\alpha}^{\delta}} (V_{\alpha}^{\varepsilon}(x) - b_{\alpha}^{\delta}) \phi_{\alpha}(x)$$

so that $w_h^{\varepsilon} - u_0 \in W^1_{0,G}(\Omega^{\varepsilon})$. Let us denote by

$$J^{\varepsilon}[v^{\varepsilon}] = \int_{\Omega^{\varepsilon}} f(x, v^{\varepsilon}, Dv^{\varepsilon}) \, dx$$

and note that since u^{ε} minimizes $J^{\varepsilon}[\cdot]$,

$$J^{\varepsilon}[u^{\varepsilon}] \le J^{\varepsilon}[w_h^{\varepsilon}]$$

To estimate the last inequality, observe that

$$J^{\varepsilon}[w_{h}^{\varepsilon}] \leq \sum_{\alpha} \int_{\hat{Q}_{h}^{\alpha} \cap \Omega^{\varepsilon}} f(x, w_{h}^{\varepsilon}, Dw_{h}^{\varepsilon}) \ dx + \sum_{\alpha, \beta} \int_{(\hat{Q}_{h}^{\alpha} \cap \hat{Q}_{h}^{\beta}) \cap \Omega^{\varepsilon}} |f(x, w_{h}^{\varepsilon}, Dw_{h}^{\varepsilon})| \ dx$$

Taking into account the properties of $V^{\varepsilon}_{\alpha}, \phi_{\alpha}, w$ and the convexity of $G(\cdot)$ one derives

(6.24)
$$\lim_{h \to 0} \limsup_{\varepsilon \to 0} \sum_{\alpha, \beta} \int_{(\hat{Q}_h^{\alpha} \cap \hat{Q}_h^{\beta}) \cap \Omega^{\varepsilon}} |f(x, w_h^{\varepsilon}, Dw_h^{\varepsilon})| \, dx = 0$$

Introduce the sets $\mathcal{B}_1^{\alpha}(\varepsilon,h) = \mathcal{B}^{\alpha}(\delta,\varepsilon,h) \cap (\hat{Q}_h^{\alpha} \cap \Omega^{\varepsilon})$ and $\mathcal{B}_2^{\alpha}(\varepsilon,h) = (\hat{Q}_h^{\alpha} \cap \Omega^{\varepsilon}) \setminus \mathcal{B}_1^{\alpha}(\varepsilon,h)$. Then,

(6.25)
$$\int_{\mathcal{B}_{2}^{\alpha}(\varepsilon,h)} f(x, w_{h}^{\varepsilon}, Dw_{h}^{\varepsilon}) \ dx \leq \int_{\hat{Q}_{h}^{\alpha}} f(x, w, Dw) \ dx + o(h^{n})$$

Furthermore, for $Q_h^{\alpha} \in \mathcal{K}_{\theta}$, we have

$$\begin{split} \int_{\mathcal{B}_{1}^{\alpha}(\varepsilon,h)} & f(x, w_{h}^{\varepsilon}, Dw_{h}^{\varepsilon}) \, dx \\ &= \int_{\mathcal{B}_{1}^{\alpha}(\varepsilon,h)} f(x, 0, Dv_{\alpha}^{\varepsilon}) \, dx + \int_{\mathcal{B}_{1}^{\alpha}(\varepsilon,h)} f(x, w_{h}^{\varepsilon}, Dw_{h}^{\varepsilon}) - f(x, 0, Dv_{\alpha}^{\varepsilon}) \, dx \\ &\leq \int_{\mathcal{B}_{1}^{\alpha}(\varepsilon,h)} f(x, 0, Dv_{\alpha}^{\varepsilon}) \, dx + c_{1} \int_{\mathcal{B}_{1}^{\alpha}(\varepsilon,h)} g(c_{2} + c_{3}|\nabla v_{\alpha}^{\varepsilon}|) \, dx \\ &+ O(h) \int_{\mathcal{B}_{1}^{\alpha}(\varepsilon,h)} G(|\nabla v_{\alpha}^{\varepsilon}|) \, dx \end{split}$$

for constants independent of ε, h, δ . Note that the second term on the right hand side is of order $O(h^{n+1})$. To estimate the first term consider the subsets of $\mathcal{B}_1^{\alpha}(\varepsilon, h)$,

(6.26)
$$\mathcal{B}_{11}^{\alpha}(\varepsilon,h) = \{ x \in \mathcal{B}_{1}^{\alpha}(\varepsilon,h) : c_{2} + c_{3} | \nabla v_{\alpha}^{\varepsilon} | \le m(h) \}$$

(6.27)
$$\mathcal{B}_{12}^{\alpha}(\varepsilon,h) = \{ x \in \mathcal{B}_{1}^{\alpha}(\varepsilon,h) : c_{2} + c_{3} | \nabla v_{\alpha}^{\varepsilon} | > m(h) \}$$

where $m(h) = (h^{-1-\gamma})^{\delta_1/2}$. From condition 5 in section 2,

$$m(h)g(c_2 + c_3|\nabla v_{\alpha}^{\varepsilon}|) < (c_2 + c_3|\nabla v_{\alpha}^{\varepsilon}|)g(c_2 + c_3|\nabla v_{\alpha}^{\varepsilon}|)$$
$$\leq CG(c_2 + c_3|\nabla v_{\alpha}^{\varepsilon}|)$$

in $\mathcal{B}^{\alpha}_{12}(\varepsilon, h)$. The convexity of G and (6.27) give us

(6.28)
$$\int_{\mathcal{B}_{12}^{\alpha}(\varepsilon,h)} g(c_2 + c_3 |\nabla v_{\alpha}^{\varepsilon}|) \, dx = o(h^n)$$

so that

$$\int_{Q_h^{\alpha} \cap \Omega^{\varepsilon}} f(x, w_h^{\varepsilon}, Dw_h^{\varepsilon}) \, dx \leq \int_{Q_h^{\alpha} \cap \Omega} f(x, w_h^{\varepsilon}, Dw_h^{\varepsilon}) \, dx + \operatorname{cap}(\omega, x^{\alpha}, \varepsilon, h, b_{\alpha}) + o(h^n)$$

for cubes $Q_h^{\alpha} \in \mathcal{K}_{\theta}$. Similarly we can obtain this inequality for $Q_h^{\alpha} \notin \mathcal{K}_{\theta}$. Letting $\varepsilon \to 0$, $h \to 0$ and finally $\theta \to 0$, we obtain

(6.30)
$$\lim_{h \to 0} \limsup_{\varepsilon \to 0} J^{\varepsilon}[w_h^{\varepsilon}] \le J_{c_0}(w)$$

and hence

(6.31)
$$\lim_{\varepsilon \to 0} J^{\varepsilon}[u^{\varepsilon}] \le J_{c_0}(w)$$

for all $w \in C^1(\Omega)$ and hence for all $w \in W^1_G(\Omega)$, with $J_{c_0}(u)$ being the functional in (5.23), which is continuous in $W^1_G(\Omega)$.

To prove the lower bound, we will use the following lemma [18]:

Lemma 4. Suppose $w \in W_G^1(\Omega)$ with $||w||_{G,\Omega}^1 < 1$. Under the assumption of theorem 8, there exists a sequence $W^{\varepsilon} \in W_G^1(\Omega)$ with $W^{\varepsilon} = 0$ in $\Omega \setminus \Omega^{\varepsilon}$ converging weakly in $W_G^1(\Omega)$ to w and, for sufficiently small ε , satisfies

$$\|W^{\varepsilon}\|_{G,\Omega}^{1} \leq \Lambda \left(\|w\|_{G,\Omega}^{1}\right)$$

for some continuous nonnegative function Λ with $\lim_{t\to 0} \Lambda(t) = 0$.

Now let $u \in W^1_G(\Omega)$ be a weak limit of a sequence u^{ε} of solutions of (5.9) extended by u_0 in $\Omega \setminus \Omega^{\varepsilon}$. Given $\delta > 0$ we pick a function $u_{\delta} \in C^1(\Omega)$ such that

$$(6.32) \|u_{\delta} - u\|_{G,\Omega}^1 < \delta$$

From lemma 4, it follows that there exists a sequence $\{W_{\delta}^{\varepsilon}\}$ converging weakly to $u_{\delta} - u$. We define $u_{\delta}^{\varepsilon} = u^{\varepsilon} + W_{\delta}^{\varepsilon}$ so that, as $\varepsilon \to 0$, $u_{\delta}^{\varepsilon} \rightharpoonup u_{\delta}$ and $u_{\delta}^{\varepsilon} = u_0$ in $\Omega \setminus \Omega^{\varepsilon}$. Then,

$$\lim_{\delta \to 0} \limsup_{\varepsilon \to 0} \|u_{\delta}^{\varepsilon} - u^{\varepsilon}\|_{G,\Omega}^{1} = 0$$

that leads to

$$\lim_{\delta \to 0} \limsup_{\varepsilon \to 0} |J^{\varepsilon}[u^{\varepsilon}_{\delta}] - J^{\varepsilon}[u^{\varepsilon}]| = 0$$

The continuity of J_{c_0} implies that it suffices to show

(6.33)
$$\lim_{\varepsilon \to 0} J_{c_0}[u^{\varepsilon}] \ge J_{c_0}[u]$$

To prove (6.37), we introduce the sets

$$\Omega_{\theta} = \Omega_{\theta}^{+} \cup \Omega_{\theta}^{-} \qquad \qquad \tilde{\Omega}_{\theta} = \tilde{\Omega}_{\theta}^{+} \cup \tilde{\Omega}_{\theta}^{-} \qquad \qquad \Xi_{\theta} = \Omega \setminus \Omega_{\theta}$$
$$\Omega_{\theta}^{\varepsilon} = \Omega_{\theta} \cup \Omega^{\varepsilon} \qquad \qquad \tilde{\Omega}_{\theta}^{\varepsilon} = \tilde{\Omega}_{\theta} \cup \tilde{\Omega}^{\varepsilon} \qquad \qquad \Xi_{\theta}^{\varepsilon} = \Xi_{\theta} \cap \Omega_{\varepsilon}$$

where

$$\Omega_{\theta}^{\pm} = \{ c \in \Omega : \pm (u_{\delta} - u_0) > \theta \} \qquad \qquad \tilde{\Omega}_{\theta}^{\pm} = \{ \cup_{\alpha} Q_h^{\alpha} : Q_h^{\alpha} \subset \Omega_{\theta}^{\pm} \}$$

Since u_{δ} is smooth,

$$\lim_{h\to 0} \operatorname{meas}[\Omega^\varepsilon_\theta \setminus \tilde\Omega^\varepsilon_\theta] = 0$$

The limit of the capacity functional implies that

$$\operatorname{meas}[G^{\varepsilon} \cap Q_h^{\alpha}] = O(h^n)h^{1+\gamma}$$

for sufficiently small $\varepsilon>0$ so that

$$\operatorname{meas}[G^{\varepsilon}] = o(1)$$

We write $J^{\varepsilon}[u^{\varepsilon}_{\delta}]$ in the following way:

$$\begin{split} J^{\varepsilon}[u^{\varepsilon}_{\delta}] &= \int_{\tilde{\Omega}^{\varepsilon}_{\theta}} f(x, u^{\varepsilon}_{\delta}, \nabla u^{\varepsilon}_{\delta}) \ dx \\ &+ \int_{\Omega^{\varepsilon} \setminus \tilde{\Omega}^{\varepsilon}_{\theta}} f(x, u^{\varepsilon}_{\delta}, \nabla u^{\varepsilon}_{\delta}) \ dx + \int_{\Xi^{\varepsilon}_{\theta}} f(x, u^{\varepsilon}_{\delta}, \nabla u^{\varepsilon}_{\delta}) \ dx \end{split}$$

From (6.11) and (6.12) we have

$$f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \ge f(x, u_{\delta}, \nabla u_{\delta})$$

+
$$\sum_{i=1}^{n} \frac{\partial f}{\partial u_{x_{i}}}(x, u_{\delta}, \nabla u_{\delta}) \left(\frac{\partial u_{\delta}^{\varepsilon}}{\partial x_{i}} - \frac{\partial u_{\delta}}{\partial x_{i}}\right)$$

-
$$(g(u_{\delta}^{\varepsilon}) + 2g(|\nabla u_{\delta}^{\varepsilon}|) + 1)(|u_{\delta}^{\varepsilon} - u_{\delta}|)$$

The convergence of u^{ε}_{δ} to u_{δ} and the last estimation implies that

$$\lim_{h \to 0} \liminf_{\varepsilon \to 0} \int_{\Omega^{\varepsilon} \setminus \tilde{\Omega}_{\theta}^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \ dx \ge 0$$

Furthermore,

$$\int_{\Xi_{\theta}^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx = \int_{\Xi_{\theta}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx - \int_{\Xi_{\theta} \cap G^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx$$

and

$$\liminf_{\varepsilon \to 0} \int_{\Xi_{\theta}^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \ dx \ge \int_{\Xi_{\theta}} f(x, u_{\delta}, \nabla u_{\delta}) \ dx$$

Let Q_h^{α} be a cube in $\tilde{\Omega}_{\theta}^+$ and set

$$b_{\alpha}^{\min} = \min_{Q_{h}^{\alpha}} u_{\delta} - h_{1}$$
 $b_{\alpha}^{\max} = \max_{Q_{h}^{\alpha}} u_{0} + h_{1}$ $b_{\alpha} = b_{\alpha}^{\min} - b_{\alpha}^{\max}$

$$\begin{split} \Omega_{1\alpha}^{\varepsilon} &= \{ x \in Q_h^{\alpha} \cap \Omega^{\varepsilon} : u_{\delta}^{\varepsilon} < b_{\alpha}^{\max} \} \\ \Omega_{2\alpha}^{\varepsilon} &= \big\{ x \in Q_h^{\alpha} \cap \Omega^{\varepsilon} : b_{\alpha}^{\max} \le u_{\delta}^{\varepsilon} \le b_{\alpha}^{\min} \big\} \\ \Omega_{3\alpha}^{\varepsilon} &= \big\{ x \in Q_h^{\alpha} \cap \Omega^{\varepsilon} : u_{\delta}^{\varepsilon} > b_{\alpha}^{\min} \big\} \end{split}$$

Since $u_{\delta}^{\varepsilon} \to u_{\delta}$ in the $L_G(\Omega)$, for $\varepsilon > 0$ small enough

$$\int_{Q_h^{\alpha}} G(u_{\delta}^{\varepsilon} - u_{\delta}) = O(h^{n+2+2\gamma})$$

and hence

$$G(h_1) \operatorname{meas}[\Omega_{1\alpha}^{\varepsilon} \cup \Omega_{2\alpha}^{\varepsilon}] \le \int_{\Omega_{1\alpha}^{\varepsilon} \cup \Omega_{2\alpha}^{\varepsilon}} G(u_{\delta}^{\varepsilon} - u_{\delta}) = O(h^{n+2+2\gamma})$$

Choosing $h_1 = G^{-1}(h^{1+\gamma})$, we get meas $[\Omega_{1\alpha}^{\varepsilon} \cup \Omega_{2\alpha}^{\varepsilon}] = O(h^{n+1+\gamma})$ We follow the steps that we did to show (6.33), to get

(6.34)
$$\liminf_{\varepsilon \to 0} \int_{\Omega_{1\alpha}^{\varepsilon} \cup \Omega_{3\alpha}^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx \ge \int_{Q_{h}^{\alpha}} f(x, u_{\delta}, \nabla u_{\delta}) \, dx + o(h^{n})$$

The estimate over $\Omega_{2\alpha}^{\varepsilon}$ follows by introducing the function

$$v_{\alpha}^{\varepsilon} = \begin{cases} 0, & \text{in } \Omega_{3\alpha}^{\varepsilon} \cup (G^{\varepsilon} \cup Q_{h}^{\alpha}) \\ u_{\delta}^{\varepsilon} - b_{\alpha}^{\max}, & \text{in } \Omega_{2\alpha}^{\varepsilon} \\ b_{\alpha}, & \text{in } \Omega_{3\alpha}^{\varepsilon} \end{cases}$$

Since u_{δ}^{ε} are bounded in $\Omega_{2\alpha}^{\varepsilon}$,

$$\int_{\Omega_{2\alpha}^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx = \int_{Q_{h}^{\alpha}} f(x, 0, \nabla v_{\alpha}^{\varepsilon}) \, dx$$
$$+ h^{-1-\gamma} \int_{Q_{h}^{\alpha}} G(v_{\alpha}^{\varepsilon} - b_{\alpha}) \, dx + o(h^{n})$$

so that

$$\int_{\Omega_{2\alpha}^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx \ge \operatorname{cap}(\omega, x^{\alpha}, \varepsilon, h, b_{\alpha}) + o(h^{n})$$

It follows that

$$\liminf_{\varepsilon \to 0} \int_{Q_h^{\alpha} \cap \Omega^{\varepsilon}} f(x, u_{\delta}^{\varepsilon}, \nabla u_{\delta}^{\varepsilon}) \, dx \ge \int_{Q_h^{\alpha}} f(x, u_{\delta}, \nabla u_{\delta}) \, dx \\ + \liminf_{\varepsilon \to 0} \operatorname{cap}(\omega, x^{\alpha}, \varepsilon, h, b_{\alpha}) + o(h^n)$$

The same inequality can be obtained for $Q_h^{\alpha} \subset \Omega_{\theta}^-$ so that

$$J_{c_0}[u] \le J_{c_0}[w]$$

for all $w \in W^1_{0,G}(\Omega)$. This completes the proof.

6.3. p(x)-Laplace type equations. Homogenization results for the p(x)-Laplacian have been studied in [3]. The problem under consideration is

(6.35)
$$-\operatorname{div}(|\nabla u^{\varepsilon}|^{p_{\varepsilon}(x)-2}\nabla u^{\varepsilon}) + |u^{\varepsilon}|^{p_{\varepsilon}(x)-2}u^{\varepsilon} = f(x) \text{ in } \Omega^{\varepsilon}$$

(6.36)
$$u^{\varepsilon} = 0 \text{ on } \partial \Omega^{\varepsilon}$$

where $p_{\varepsilon}(x)$ is continuous, oscillating function satisfying a modulus of continuity $|p_{\varepsilon}(x) - p_{\varepsilon}(y)| \leq \xi_{\varepsilon}(|x - y|)$ with $\limsup_{\tau \to 0} \xi_{\varepsilon}(\tau) \ln(1/\tau) = 0$. Such equations are defined in Sobolev spaces with variable exponents. Assuming certain convergence properties on $p_{\varepsilon}(\cdot)$, it is shown that the sequence u_{ε} converges in $W^{1,p_0(x)}(\Omega)$, $\lim_{\varepsilon \to 0} ||p_{\varepsilon} - p_0||_{C^0(\Omega)} = 0$, to the minimizer u of the energy functional

$$\int_{\Omega} \frac{1}{p_0(x)} |\nabla u|^{p_0(x)} + \frac{1}{p_0(x)} |u|^{p_0(x)} + c(x, u) - fu \, dx$$

where

$$c(x,b) = \lim_{h \to 0} \lim_{\varepsilon \to 0} \frac{c(\varepsilon, h, z, b)}{h^n}$$

and

$$c(\varepsilon,h,z,b) = \inf_{v^{\varepsilon}} \int_{Q_h^z} \frac{1}{p_{\varepsilon}(x)} |\nabla u|^{p_{\varepsilon}(x)} + h^{-1-\gamma} (|v^{\varepsilon} - b|^{p_{\varepsilon}(x)} + |v^{\varepsilon} - b|^{p_0(x)}) dx$$

Proceeding as in the proof of theorem 9, one can show the existence of the capacity limits, assuming appropriately modelled perforated domains in which the ergodic theorem is valid. A setup of Γ -convergence in Sobolev spaces with variable exponent and the integral representation of variational functionals (see [7]) would produce similar homogenization results as long as theorem 4 is proved.
