# SOME EXAMPLES OF SELF-SIMILAR SOLUTIONS AND TRANSLATING SOLITONS FOR LAGRANGIAN MEAN CURVATURE FLOW

#### Abstract

We construct new examples of self-similar solutions and translating solitons for Lagrangian mean curvature flow by extending the method of Joyce, Lee and Tsui [\[3\]](#page-14-0). Those examples include examples in which the Lagrangian angle is arbitrarily small as the examples of Joyce, Lee and Tsui [\[3\]](#page-14-0).

#### 1 Introduction

In recent years the Lagrangian mean curvature flow has been extensively studied, as it is a key ingredient in the Strominger-Yau-Zaslow Conjecture and Thomas-Yau Conjecture. Strominger-Yau-Zaslow Conjecture explains Mirror Symmetry of Calabi-Yau 3-folds. In Joyce, Lee and Tsui [\[3\]](#page-14-0), many examples of self-similar solutions and translating solitons for Lagrangian mean curvature flow are constructed. Those Lagrangian submanifold L are the total space of a 1-parameter family of quadrics  $Q_s$ ,  $s \in I$ , where I is an open interval in  $\mathbb R$ . In this paper, we construct new examples of those Lagrangian submanifolds that link up with the examples of Lagrangian submanifolds given in  $[1]$ ,  $[2]$ ,  $[3]$ ,  $[4]$  and so on. To do so we improve theorems in [\[3\]](#page-14-0) by describing Lagrangian submanifolds of the forms of Ansatz 3.1 and Ansatz 3.3 in [\[3\]](#page-14-0).

Let L be a Lagrangian submanifold in  $\mathbb{C}^n$ . Define a function  $c: L \to \mathbb{C}$ by the relation that

$$
dz_1 \wedge \cdots \wedge dz_n|_L \equiv c \cdot vol_L
$$

where vol<sub>L</sub> is the volume form of L. Then  $|c| \equiv 1$  holds. So we can define Lagrangian angle  $\theta : L \to \mathbb{R}$  or  $\theta : L \to \mathbb{R}/2\pi\mathbb{Z}$  by the relation that

$$
dz_1 \wedge \cdots \wedge dz_n|_L \equiv e^{i\theta} \text{vol}_L.
$$

On a Lagrangian submanifold L in  $\mathbb{C}^n$ , the mean curvature vector H is given by

$$
H = J\nabla\theta,\tag{1}
$$

where  $\nabla$  is the gradient on L and J is the standard complex structure in  $\mathbb{C}^n$ . The proof of [\(1\)](#page-1-0) is given in [\[5\]](#page-14-4).

**Definition 1.1.** Let  $L \subset \mathbb{R}^N$  be a submanifold in  $\mathbb{R}^N$ . L is called a selfsimilar solution if  $H \equiv \alpha F^{\perp}$  on L for some constant  $\alpha \in \mathbb{R}$ , where  $F^{\perp}$  is the orthogonal projection of the position vector  $F$  in  $\mathbb{R}^N$  to the normal bundle of L, and H is the mean curvature vector of L in  $\mathbb{R}^N$ . It is called a selfshrinker if  $\alpha < 0$  and a self-expander if  $c > 0$ . On the other hand  $L \subset \mathbb{R}^N$ is called a *translating soliton* if there exists a constant vector T in  $\mathbb{R}^N$  such that  $H \equiv T^{\perp}$ , where  $T^{\perp}$  is the orthogonal projection of the constant vector T in  $\mathbb{R}^N$  to the normal bundle of L and H is the mean curvature vector of L in  $\mathbb{R}^N$ . We call T a translating vector.

It is well-known that if F is a self-similar solution then  $F_t = \sqrt{2\alpha t}F$  is moved by the mean curvature flow, and if  $F$  is a translating soliton then  $F_t = F + tT$  is also moved by the mean curvature flow.

First we consider self-similar solutions.

<span id="page-1-1"></span>**Theorem 1.2.** Let  $B, C, \lambda_1, \dots, \lambda_n \in \mathbb{R} - \{0\}, E > 1, a_1, \dots, a_n >$ 0, and  $\alpha, \psi_1, \dots, \psi_n \in \mathbb{R}$  be constants. Let  $I \subset \mathbb{R}$  be a connected open neighborhood of  $0 \in \mathbb{R}$  such that  $E\{\prod_{k=1}^{n}(1 + 2a_kB\lambda_ks)\}e^{2B\alpha s} - 1$  and  $1/a_i + 2\lambda_i Bs$  are positive for any  $j \in \{1, \dots, n\}$  and any  $s \in I$ . Define  $r_1, \cdots, r_n : I \to \mathbb{R}$  by

$$
r_j = \sqrt{\frac{1}{a_j} + 2\lambda_j Bs}.
$$

Define  $\phi_1, \cdots, \phi_n : I \to \mathbb{R}$  by

$$
\phi_j = \psi_j + \int_0^s \frac{\lambda_j |B|}{(\frac{1}{a_j} + 2\lambda_j Bt)\sqrt{E\{\prod_{k=1}^n (1 + 2a_k B\lambda_k t)\}e^{2B\alpha t} - 1}} \mathrm{d}t.
$$

Then the submanifold  $L$  in  $\mathbb{C}^n$  given by

$$
L = \{(x_1r_1(s)e^{i\phi_1(s)}, \cdots, x_nr_n(s)e^{i\phi_n(s)})|\sum_{j=1}^n \lambda_j x_j^2 = C, x_j \in \mathbb{R}, s \in I\}
$$

is an immersed Lagrangian submanifold, and its position vector F and mean curvature vector H satisfy  $CH \equiv \alpha F^{\perp}$ .

*Remark* 1.2.1. In the situation of Theorem [1.2,](#page-1-1) let  $I' \subset I$  be a subinterval such that  $r_j$  has positive lower and upper bounds. Put  $\alpha \neq 0, n \geq 2, \lambda_j > 0$ for  $1 \leq j \leq k < n$  and  $\lambda_j < 0$  for  $k < j \leq n$  where k is a positive integer less than *n*. Let  $t \in \mathbb{R}$  be a constant. Define

$$
L_t = \{ (x_1 r_1(s)e^{i\phi_1(s)}, \cdots, x_n r_n(s)e^{i\phi_n(s)}) \mid \sum_{j=1}^n \lambda_j x_j^2 = 2\alpha t, x_j \in \mathbb{R}, s \in I' \}.
$$

The fact that the varifold  $\cup_t L_t$ ,  $-\infty < t < \infty$ , forms an eternal solution for Brakke flow without mass loss is proved similarly to Lee and Wang [\[4\]](#page-14-3). So see Lee and Wang [\[4\]](#page-14-3). By Theorem [1.2,](#page-1-1)  $L_t$  is a Lagrangian self-shrinker if  $t < 0$ , a Lagrangian self-expander if  $t > 0$ , and a Lagrangian cone if  $t = 0$ .

<span id="page-2-1"></span>**Theorem 1.3.** Let  $a_j > 0$ ,  $\psi_j \in \mathbb{R}, \mathbb{Q}E > 1$ , and  $\alpha \geq 0$  be constants.  $Define \ r_j(s) : \mathbb{R} \to \mathbb{R} \ by \ r_j(s) = \sqrt{\frac{1}{a_j} + s^2}. \ Define \ \phi_j(s) : \mathbb{R} \to \mathbb{R} \ by$ 

<span id="page-2-0"></span>
$$
\phi_j(s) = \psi_j + \int_0^s \frac{|t|}{(\frac{1}{a_j} + t^2)\sqrt{E\{\prod_{k=1}^n (1 + a_k t^2)\} e^{\alpha t^2} - 1}} \mathrm{d}t. \tag{2}
$$

Then the submanifold  $L$  in  $\mathbb{C}^n$  given by

$$
L = \{(x_1r_1(s)e^{i\phi_1(s)}, \cdots, x_nr_n(s)e^{i\phi_n(s)})|\sum_{j=1}^n x_j^2 = 1, x_j \in \mathbb{R}, s \in \mathbb{R}, s \neq 0\}
$$

is an immersed Lagrangian diffeomorphic to  $(\mathbb{R} - \{0\}) \times S^{n-1}$ , and its position vector F and mean curvature vector H satisfy  $H \equiv \alpha F^{\perp}$ .

*Remark* 1.3.1. The manifold obtained as  $\lim_{E\to 1+0} L$  is the same as Theorem C in [\[3\]](#page-14-0). So the condition  $s \neq 0$  on the definition of L is not necessary if  $E = 1$ . If we put  $E = 1$  then changing  $0 \mapsto -\infty$  in the integral of [\(2\)](#page-2-0) gives the example of [\[2\]](#page-14-2).

<span id="page-2-3"></span>*Remark* 1.3.2. Define  $\bar{\phi}_1, \cdots, \bar{\phi}_n > 0$  by

$$
\bar{\phi}_j = \int_0^\infty \frac{|t|}{(\frac{1}{a_j} + t^2)\sqrt{E\{\prod_{k=1}^n (1 + a_k t^2)\}e^{\alpha t^2} - 1}} \mathrm{d}t.
$$

We put  $\alpha > 0$ . From the proof of Theorem [1.3](#page-2-1) and [\(6\)](#page-5-0) in § [2](#page-5-1) the Lagrangian angle  $\theta$  satisfies

$$
\theta = \sum_{j} \phi_{j} + \arg(s + i \frac{|s|}{\sqrt{E\{\prod_{k=1}^{n} (1 + a_{k}s^{2})\}e^{\alpha s^{2}} - 1}}}) \text{ and}
$$
\n
$$
\dot{\theta} = \frac{-\alpha|s|}{\sqrt{E\{\prod_{k=1}^{n} (1 + a_{k}s^{2})\}e^{\alpha s^{2}} - 1}}.
$$
\n(3)

It follows that  $\theta$  is strictly decreasing. We define the submanifold  $L_1 \subset L$ by restricting  $s > 0$  and  $L_2 \subset L$  by restricting  $s < 0$ . Therefore we have  $L = L_1 \cup L_2$ . We rewrite  $\theta_1, \theta_2$  as the Lagrangian angle of  $L_1, L_2$  respectively. Then  $\lim_{s\to\infty} \theta_1(s) < \theta_1(s) < \lim_{s\to 0+0} \theta_1(s)$  and  $\lim_{s\to 0-0} \theta_2(s) <$  $\theta_2(s) < \lim_{s \to -\infty} \theta_2(s)$ . So from the first equation of [\(3\)](#page-2-2) we have

$$
\sum_{j} \psi_j + \sum_{j} \bar{\phi}_j < \theta_1 < \sum_{j} \psi_j + \tan^{-1} \frac{1}{\sqrt{E - 1}}
$$

and

$$
\sum_{j} \psi_j + \pi - \tan^{-1} \frac{1}{\sqrt{E - 1}} < \theta_2 < \sum_{j} \psi_j + \pi - \sum_{j} \bar{\phi}_j.
$$

Therefore by choosing  $\tan^{-1}(1/\sqrt{E-1})$  close to 0, that is, choosing E close to  $\infty$ , the oscillation of the Lagrangian angle of  $L_1, L_2$  can be made arbitrarily small. Furthermore  $\Phi : (a_1, \dots, a_n) \mapsto (\bar{\phi}_1, \dots, \bar{\phi}_n)$  gives a diffeomorphism

$$
\Phi: (0, \infty)^n \to \{(\bar{\phi}_1, \cdots, \bar{\phi}_n) \in (0, \tan^{-1} \frac{1}{\sqrt{E-1}})^n | 0 < \sum_j \bar{\phi}_j < \tan^{-1} \frac{1}{\sqrt{E-1}} \}.
$$

We can prove that  $\Phi$  is a diffeomorphism similarly to the proof of Theorem D in [\[3\]](#page-14-0). So we omit the proof. Therefore by choosing  $\sum_j \bar{\phi}_j$  close to  $\tan^{-1}(1/\sqrt{E-1})$ , the oscillation of the Lagrangian angle of  $L_1, L_2$  can also be made arbitrarily small.

*Remark* 1.3.3. If we put  $B = 1/2$ ,  $C = \lambda_1 = \cdots = \lambda_n = 1$ ,  $\alpha \geq 0$  in the situation of Theorem [1.2](#page-1-1) then  $L$  is the same as  $L$  in Theorem [1.3](#page-2-1) where  $s > 0$ .

Next we turn to translating solitons.

<span id="page-3-0"></span>Theorem 1.4. Let  $B, \lambda_1, \dots, \lambda_{n-1} \in \mathbb{R} - \{0\}, E > 1, a_1, \dots, a_{n-1} > 0,$ and  $\alpha, \psi_1, \dots, \psi_{n-1} \in \mathbb{R}, K \in \mathbb{C}$  be constants. Let  $I \subset \mathbb{R}$  be a connected open neighborhood of  $0 \in \mathbb{R}$  such that  $E\{\prod_{k=1}^{n-1}(1+2a_kB\lambda_ks)\}e^{2B\alpha s}-1$  and  $1/a_j + 2\lambda_j Bs$  are positive for any  $j \in \{1, \dots, n-1\}$  and any  $s \in I$ . Define  $r_1, \cdots, r_{n-1} : I \to \mathbb{R}$  by

$$
r_j = \sqrt{\frac{1}{a_j} + 2\lambda_j Bs}.
$$

Define  $\phi_1, \cdots, \phi_{n-1} : I \to \mathbb{R}$  by

$$
\phi_j = \psi_j + \int_0^s \frac{\lambda_j |B|}{\left(\frac{1}{a_j} + 2\lambda_j B t\right) \sqrt{E\{\prod_{k=1}^{n-1} (1 + 2a_k B \lambda_k t)\} e^{2B\alpha t} - 1}} \mathrm{d}t.
$$

Then the submanifold  $L$  in  $\mathbb{C}^n$  given by

$$
L = \{(x_1r_1(s)e^{i\phi_1(s)}, \cdots, x_{n-1}r_{n-1}(s)e^{i\phi_{n-1}(s)}, -\frac{1}{2}\sum_{j=1}^{n-1}\lambda_jx_j^2 + Bs +
$$
  

$$
|B| \int^s \frac{dt}{\sqrt{1+t}} \frac{dt}{\sqrt{1+t}} + K|x_1 + x_{n-1} \in \mathbb{R} \text{ s.t.}
$$

$$
i|B|\int_0^{\infty} \frac{dt}{\sqrt{E\{\prod_{k=1}^{n-1}(1+2a_kB\lambda_kt)\}e^{2B\alpha t}-1}}+K)|x_1,\cdots,x_{n-1}\in\mathbb{R},s\in I\}
$$

is an immersed Lagrangian submanifold, and its mean curvature vector H satisfy  $H \equiv T^{\perp}$  where  $T = (0, \dots, 0, \alpha) \in \mathbb{C}^n$ .

<span id="page-4-0"></span>**Theorem 1.5.** Let  $a_1, \dots, a_{n-1} > 0$ ,  $\psi_1, \dots, \psi_{n-1} \in \mathbb{R}, \mathbb{Q}E > 1$ , and  $\alpha \geq 0$  be constants. Define  $r_j(s) : \mathbb{R} \to \mathbb{R}$  by  $r_j(s) = \sqrt{\frac{1}{a_j} + s^2}$ . Define  $\phi_i(s) : \mathbb{R} \to \mathbb{R}$  by

$$
\phi_j(s) = \psi_j + \int_0^s \frac{|t|}{\left(\frac{1}{a_j} + t^2\right) \sqrt{E\{\prod_{k=1}^{n-1} (1 + a_k t^2)\} e^{\alpha t^2} - 1}} \mathrm{d}t.
$$

Then the submanifold  $L$  in  $\mathbb{C}^n$  given by

$$
L = \{(x_1r_1(s)e^{i\phi_1(s)}, \cdots, x_{n-1}r_{n-1}(s)e^{i\phi_{n-1}(s)}, -\frac{1}{2}\sum_{j=1}^{n-1}x_j^2 + \frac{1}{2}s^2 + i\int_0^s \frac{|t|dt}{\sqrt{E\{\prod_{k=1}^{n-1}(1+a_kt^2)\}e^{\alpha t^2}-1}}|x_1\cdots, x_{n-1}\in\mathbb{R}, s\in\mathbb{R}, s\neq 0\}
$$

is an immersed Lagrangian diffeomorphic to  $(\mathbb{R} - \{0\}) \times \mathbb{R}^{n-1}$ , and its mean curvature vector  $H$  satisfy  $H \equiv T^{\perp}$  where  $T = (0, \dots, 0, \alpha) \in \mathbb{C}^n$ .

Remark 1.5.1. If we put  $\psi_1 = \cdots = \psi_{n-1} = 0$  then the manifold obtained as  $\lim_{E\to 1+0} L$  is the same as Theorem G in [\[3\]](#page-14-0). So the condition  $s\neq 0$  on the definition of L is not necessary if  $E = 1$ .

Remark 1.5.2. We define the submanifold  $L_1 \subset L$  by restricting  $s > 0$  and  $L_2 \subset L$  by restricting  $s < 0$ . Similarly to Remark [1.3.2](#page-2-3) if we fix  $\alpha > 0$  then by choosing the parameters  $a_1, \dots, a_n > 0$  or  $E > 1$ , the oscillation of the Lagrangian angle of  $L_1, L_2$  can be made arbitrarily small.

*Remark* 1.5.3. If we put  $B = 1/2$ ,  $\lambda_1 = \cdots = \lambda_{n-1} = 1$ ,  $K = 0$ ,  $\alpha \ge 0$  in the situation of Theorem [1.4](#page-3-0) then  $L$  is the same as  $L$  in Theorem [1.5](#page-4-0) where  $s > 0$ .

## <span id="page-5-1"></span>2 Proofs for self-similar solutions

In order to prove Theorem [1.2](#page-1-1) and Theorem [1.3](#page-2-1) we use the following Theorem [2.1](#page-5-2) and Theorem [2.3](#page-6-0) that are a slight generalization of Theorem A and Theorem B in [\[3\]](#page-14-0). The following Theorem [2.1](#page-5-2) sets up the ordinary differential equations for immersed Lagrangian submanifolds diffeorphic to  $S^1 \times S^{m-1} \times \mathbb{R}^{n-m}$  or  $\mathbb{R} \times S^{m-1} \times \mathbb{R}^{n-m}$  where  $1 \leq m \leq n$ .

<span id="page-5-2"></span>**Theorem 2.1.** Let  $I \subset \mathbb{R}$  be an open interval. Let  $\lambda_1, \dots, \lambda_n, C \in \mathbb{R} - \{0\}$ be constants, and  $\omega_1, \dots, \omega_n : I \to \mathbb{C} - \{0\}$  and  $f : I \to \mathbb{C} - \{0\}$  be smooth functions. Suppose that

$$
\frac{\mathrm{d}\omega_j}{\mathrm{d}s} = \frac{\lambda_j f}{\overline{\omega}_j}, \quad j = 1, \cdots, n \tag{4}
$$

hold in I. Then the submanifold L in  $\mathbb{C}^n$  given by

<span id="page-5-4"></span>
$$
L = \{(x_1\omega_1(s), \cdots, x_n\omega_n(s))|\sum_{j=1}^n \lambda_j x_j^2 = C, x_j \in \mathbb{R}, s \in I\}
$$
 (5)

is a Lagrangian submanifold in  $\mathbb{C}^n$ , with Lagrangian angle

<span id="page-5-0"></span>
$$
\theta(s) = \arg(\omega_1 \cdots \omega_n f) \tag{6}
$$

 $at (x_1\omega_1(s), \dots, x_n\omega_n(s)) \in L$ , so  $\theta$  is a function depending only on s, not on  $x_1, \dots, x_n$ . Further we have

$$
H = \frac{\dot{\theta}}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right)
$$

and

$$
F^{\perp} = -\frac{C \operatorname{Im}(f)}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right).
$$

Remark 2.1.1. A direct calculation shows that

$$
\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle = \sum_{j=1}^n \frac{\lambda_j^2 x_j^2 |f|^2}{|\omega_j|^2}.
$$

*Remark* 2.1.2. Let  $\tilde{\theta}: I \to \mathbb{R}$  be a function satisfying

$$
\frac{\mathrm{d}\tilde{\theta}}{\mathrm{d}s} = -\alpha \operatorname{Im}(e^{i\tilde{\theta}} \overline{\omega_1 \cdots \omega_n}).
$$

Put

$$
f = e^{i\tilde{\theta}} \overline{\omega_1 \cdots \omega_n}.
$$

Then it is proved in  $[3]$  that L is a Lagrangian submanifold and L is a self-similar solution. This is Theorem A in [\[3\]](#page-14-0).

**Corollary 2.2.** Let  $I \subset \mathbb{R}$  be an open interval. Let  $\lambda_1, \dots, \lambda_n, C \in \mathbb{R} - \{0\}$ be constants, and  $\omega_1, \dots, \omega_n : I \to \mathbb{C} - \{0\}$  and  $f : I \to \mathbb{C} - \{0\}$  be smooth functions. Suppose that

$$
\frac{\mathrm{d}\omega_j}{\mathrm{d}s} = \frac{\lambda_j f}{\overline{\omega_j}}, \quad j = 1, \cdots, n
$$

and

$$
\frac{\mathrm{d}}{\mathrm{d}s}\arg(\omega_1\cdots\omega_nf)=-\alpha\mathrm{Im}(f)
$$

hold in I. Then the submanifold  $L_C$  in  $\mathbb{C}^n$  given by

$$
L_C = \{(x_1\omega_1(s), \dots, x_n\omega_n(s))|\sum_{j=1}^n \lambda_j x_j^2 = C, x_j \in \mathbb{R}, s \in I\}
$$

is a Lagrangian submanifold in  $\mathbb{C}^n$ , and its position vector F and mean curvature vector H satisfy  $CH \equiv \alpha F^{\perp}$ . Moreover, If  $|\omega_i|$  has positive lower and upper bounds and  $\alpha \in \mathbb{R} - \{0\}, n \geq 2, \lambda_j > 0$  for  $1 \leq j \leq k < n$  and  $\lambda_j$  < 0 for  $k < j \leq n$  where k is a positive integer less than n then the varifold  $\cup_t L_{2\alpha t}$ ,  $-\infty < t < \infty$ , forms an eternal solution for Brakke flow without mass loss. The fact is proved similarly to Lee and Wang  $\vert 4 \vert$ . Then  $L_{2\alpha t}$  is a Lagrangian self-shrinker if  $t < 0$ , a Lagrangian self-expander if  $t > 0$ , and a Lagrangian cone if  $t = 0$ .

The following Theorem [2.3](#page-6-0) gives the solution to ordinary deferential equations in Theorem [2.1.](#page-5-2)

<span id="page-6-0"></span>**Theorem 2.3.** In the situation of Theorem [2.1](#page-5-2) write  $\omega_j := r_j e^{i\phi_j}$ , for functions  $r_1, \dots, r_n : I \to (0, \infty), \phi_1, \dots, \phi_n : I \to \mathbb{R}$ . Fix  $s_0 \in I$ . Define  $u: I \to \mathbb{R}$  by

$$
u(s) := 2 \int_{s_0}^s \text{Re}(f(t)) \, \mathrm{d}t.
$$

Then we have

$$
r_j^2 = \alpha_j + \lambda_j u, \quad \phi_j = \psi_j + \int_{s_0}^s \frac{\lambda_j \operatorname{Im}(f(t))}{\alpha_j + \lambda_j u(t)} dt,
$$

with  $\alpha_j = r_j^2(s_0)$ ,  $\psi_j = \phi_j(s_0)$ .

Remark 2.3.1. Thus if  $f$  is explicitly given, the ordinary differential equation [\(4\)](#page-5-3) is solved by Theorem [2.3.](#page-6-0)

Proof of Theorem [2.1.](#page-5-2) If we set

$$
x_n = \sqrt{\frac{1}{\lambda_n}(C - \lambda_1 x_1^2 - \dots - \lambda_{n-1} x_{n-1}^2)},
$$

then  $(x_1, \dots, x_{n-1}, s)$  is a coordinate of L. With this coordinate we have

$$
\begin{split}\n(\mathrm{d}z_{1} \wedge \mathrm{d}\overline{z}_{1} + \cdots + \mathrm{d}z_{n} \wedge \mathrm{d}\overline{z}_{n})|_{L} \\
= & (\omega_{1} \mathrm{d}x_{1} + x_{1} \dot{\omega}_{1} \mathrm{d}s) \wedge (\overline{\omega_{1}} \mathrm{d}x_{1} + x_{1} \overline{\dot{\omega}_{1}} \mathrm{d}s) + \cdots + \\
& (\omega_{n-1} \mathrm{d}x_{n-1} + x_{n-1} \dot{\omega}_{n-1} \mathrm{d}s) \wedge (\overline{\omega_{n-1}} \mathrm{d}x_{n-1} + x_{n-1} \overline{\dot{\omega}_{n-1}} \mathrm{d}s) + \\
& (-\frac{\lambda_{1}x_{1}}{\lambda_{n}x_{n}} \omega_{n} \mathrm{d}x_{1} - \cdots - \frac{\lambda_{n-1}x_{n-1}}{\lambda_{n}x_{n}} \omega_{n} \mathrm{d}x_{n-1} + x_{n} \dot{\omega}_{n} \mathrm{d}s) \wedge \\
& (-\frac{\lambda_{1}x_{1}}{\lambda_{n}x_{n}} \overline{\omega_{n}} \mathrm{d}x_{1} - \cdots - \frac{\lambda_{n-1}x_{n-1}}{\lambda_{n}x_{n}} \overline{\omega_{n}} \mathrm{d}x_{n-1} + x_{n} \overline{\dot{\omega}_{n}} \mathrm{d}s) \\

\vdots & \ddots & 0 & \vdots \\
0 & \omega_{n-1} & x_{n-1} \dot{\omega}_{n-1} \\
-\frac{\lambda_1 x_1}{\lambda_n x_n} \omega_n & \cdots & -\frac{\lambda_{n-1} x_{n-1}}{\lambda_n x_n} \omega_n & x_n \dot{\omega}_n\n\end{vmatrix} dx_1 \wedge \cdots \wedge dx_{n-1} \wedge ds
$$
  
\n=
$$
\frac{\omega_1 \cdots \omega_n}{\lambda_n x_n} \Big( \sum_{j=1}^n \frac{\lambda_j x_j^2 \dot{\omega}_j}{\omega_j} \Big) dx_1 \wedge \cdots \wedge dx_{n-1} \wedge ds
$$
  
\n=
$$
\frac{\omega_1 \cdots \omega_n f}{\lambda_n x_n} \sum_j \frac{\lambda_j^2 x_j^2}{|\omega_j|^2} dx_1 \wedge \cdots \wedge dx_{n-1} \wedge ds.
$$

It follows that  $L$  is a nonsingular immersed Lagrangian, with Lagrangian angle

$$
\theta(s) = \arg(\omega_1 \cdots \omega_n f)
$$

at  $(x_1\omega_1(s), \dots, x_n\omega_n(s))$ . Since

d\theta = \dot{\theta} ds,
$$

and

$$
\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial x_j} \rangle = \langle (x_1 \dot{\omega}_1(s), \cdots, x_n \dot{\omega}_n(s)), (0, \cdots, 0, \omega_j, 0, \cdots, 0, -\frac{\lambda_j x_j}{\lambda_n x_n} \omega_n) \rangle
$$
  
= Re $(x_j \dot{\omega}_j \overline{\omega}_j - \frac{\lambda_j}{\lambda_n} x_j \dot{\omega}_n \overline{\omega}_n)$   
=  $x_j \lambda_j \text{Re}(f - f)$   
= 0

for any  $1 \leq j \leq n-1$ , it follows that

$$
\nabla \theta = \frac{\dot{\theta}}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} \left( \frac{\partial}{\partial s} \right).
$$

Therefore we obtain

$$
H = \frac{\dot{\theta}}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right).
$$

The normal projection of the position vector  $F$  is computed by

= 0,

and

$$
\langle F, J\frac{\partial}{\partial s}\rangle = \langle (x_1\omega_1, \cdots, x_n\omega_n), i(x_1\dot{\omega}_1(s), \cdots, x_n\dot{\omega}_n(s))\rangle
$$
  
= Re( $\sum x_j^2 \overline{\omega}_j \cdot i\dot{\omega}_j$ )  
= -C Im(*f*).

It follows that

$$
F^{\perp} = -\frac{C \operatorname{Im}(f)}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right).
$$

This completes the proof of Theorem [2.1.](#page-5-2)

Proof of Theorem [2.3.](#page-6-0) Since we have

$$
\frac{\mathrm{d}r_j^2}{\mathrm{d}s} = \frac{\mathrm{d}}{\mathrm{d}s}(\omega_j \overline{\omega_j}) = \lambda_j f + \lambda_j \overline{f} = 2\lambda_j \operatorname{Re}(f),
$$

we obtain

$$
r_j^2 = \alpha_j + \lambda_j u.
$$

So we have

$$
\dot{r}_j = \frac{\lambda_j \operatorname{Re} f}{r_j}.
$$

By our assumption we have

$$
\dot{\omega}_j = \frac{\lambda_j f}{\overline{\omega_j}}.
$$

This is equivalent to

\dot{r}_j e^{i\phi_j} + r_j i \dot{\phi}_j e^{i\phi_j} = \frac{\lambda_j f}{r_j e^{-i\phi_j}}.

Then

\dot{\phi}_j = \frac{\lambda_j \operatorname{Im}(f)}{\alpha_j + \lambda_j u}.
$$

Therefore

$$
\phi_j = \psi_j + \int_{s_0}^s \frac{\lambda_j \operatorname{Im}(f(t))}{\alpha_j + \lambda_j u(t)} dt.
$$

This completes the proof of Theorem [2.3.](#page-6-0)

 $\Box$ 

From Theorem [2.1](#page-5-2) if  $\dot{\theta} = -\alpha \operatorname{Im}(f)$  then L is a self-similar solution. From Theorem [2.3](#page-6-0) and [\(6\)](#page-5-0),  $\dot{\theta} = -\alpha \operatorname{Im}(f)$  is equivalent to

$$
\sum_{j} \frac{\lambda_j \operatorname{Im}(f)}{\alpha_j + 2\lambda_j \int_{s_0}^s \operatorname{Re}(f) \mathrm{d}t} + \frac{\mathrm{d}}{\mathrm{d}s} \operatorname{arg}(f) = -\alpha \operatorname{Im}(f). \tag{7}
$$

Therefore if  $(7)$  holds then L is a self-similar solution. So we can get self-similar solutions by getting solutions of [\(7\)](#page-9-0). For example if we put  $f \equiv i$  then f is a solution of [\(7\)](#page-9-0). In this case if we put  $\alpha_1 = \cdots = \alpha_n = 0, \lambda_1, \cdots, \lambda_n \in$  $\mathbb{Z} - \{0\}$  then the construction reduces to that of Lee and Wang [\[4\]](#page-14-3).

*Proof of Theorem [1.2.](#page-1-1)* Define  $\omega_j : I \to \mathbb{C} - \{0\}$  by  $\omega_j = r_j e^{i\phi_j}$ . Define  $f: I \to \mathbb{C} - \{0\}$  by

$$
f = \frac{\overline{\omega_j} \dot{\omega}_j}{\lambda_j}.
$$

A direct calculation shows that

$$
f = B + i \frac{|B|}{\sqrt{E\{\prod_{k=1}^{n} (1 + 2a_k B\lambda_k s)\} e^{2B\alpha s} - 1}}.
$$

Then  $f \neq 0$  in I. Apply Theorem 2.1 to the data  $\omega_i, f$  above. Then we get a Lagrangian submanifold  $L$  defined by  $(5)$ . A direct calculation shows that  $f$  satisfies  $(7)$ . So this completes the proof.  $\Box$ 

*Proof of Theorem [1.3.](#page-2-1)* Put  $I = \mathbb{R}_{>0}$  or  $I = \mathbb{R}_{<0}$ . Define  $\omega_j : I \to \mathbb{C} - \{0\}$ by  $\omega_j = r_j e^{i\phi_j}$ . Define  $f: I \to \mathbb{C} - \{0\}$  by

$$
f = \overline{\omega_j} \, \dot{\omega}_j.
$$

A direct calculation shows that

$$
f = s + i \frac{|s|}{\sqrt{E\{\prod_{k=1}^{n} (1 + a_k s^2)\} e^{\alpha s^2} - 1}}.
$$

Then  $f \neq 0$  in I. Apply Theorem 2.1 to the data  $\omega_j, f$  above and  $\lambda_1 = \cdots =$  $\lambda_n = C = 1$ . Then we get a Lagrangian submanifold L defined by [\(5\)](#page-5-4). A direct calculation shows that f satisfies [\(7\)](#page-9-0). So this completes the proof.  $\Box$ 

#### 3 Proofs for translating solitons

In order to prove Theorem [1.4](#page-3-0) and Theorem [1.5](#page-4-0) we use the following Theorem [3.1](#page-10-0) and Corollary [3.2](#page-11-0) that are a slight generalization of Theorem A and Theorem B in [\[3\]](#page-14-0). The following Theorem [3.1](#page-10-0) sets up the ordinary differential equations for immersed Lagrangian submanifolds diffeorphic to  $\mathbb{R}^n$ .

<span id="page-10-0"></span>**Theorem 3.1.** Fix  $n \geq 2$ . Let  $\lambda_1, \dots, \lambda_{n-1} \in \mathbb{R} \setminus \{0\}$  and  $\alpha \in \mathbb{R}$  be constants, I be an open interval in R, and  $\omega_1, \dots, \omega_{n-1} : I \to \mathbb{C} \backslash \{0\}$  and  $\beta: I \to \mathbb{C}$  be smooth functions. Suppose that

<span id="page-10-1"></span>
$$
\frac{\mathrm{d}\omega_j}{\mathrm{d}s} = \frac{\lambda_j}{\overline{\omega}_j} \cdot \frac{\mathrm{d}\beta}{\mathrm{d}s} \tag{8}
$$

and

$$
\frac{\mathrm{d}\beta}{\mathrm{d}s}\neq 0
$$

hold in I. Then the submanifold L in  $\mathbb{C}^n$  given by

$$
L = \{ (x_1 \omega_1(s), \cdots, x_{n-1} \omega_{n-1}(s), -\frac{1}{2} \sum_{j=1}^{n-1} \lambda_j x_j^2 + \beta(s)) |
$$
  

$$
x_1, \cdots, x_{n-1} \in \mathbb{R}, s \in I \}
$$

$$
(9)
$$

<span id="page-10-3"></span>is an immersed Lagrangian submanifolds diffeomorphic to  $\mathbb{R}^n$ , with Lagrangian angle

<span id="page-10-2"></span>
$$
\theta(s) = \arg(\omega_1 \cdots \omega_{n-1} \dot{\beta}).\tag{10}
$$

Further we have

$$
H = \frac{\dot{\theta}}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right)
$$

and

$$
T^{\perp} = \frac{-\alpha \operatorname{Im}(\dot{\beta})}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right),
$$

where  $T = (0, \dots, 0, \alpha) \in \mathbb{C}^n$  is a constant vector.

Remark 3.1.1. A direct calculation shows that

$$
\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle = \sum_{j=1}^{n-1} \frac{\lambda_j^2 x_j^2 |\dot{\beta}|^2}{|\omega_j|^2} + \big| - \frac{1}{2} \sum_{j=1}^{n-1} \lambda_j x_j^2 + \beta \big|^2.
$$

*Remark* 3.1.2. Let  $\tilde{\theta}: I \to \mathbb{R}$  be a function satisfying

$$
\frac{\mathrm{d}\tilde{\theta}}{\mathrm{d}s} = -\alpha \operatorname{Im}(e^{i\tilde{\theta}} \overline{\omega_1 \cdots \omega_{n-1}}).
$$

Suppose that

$$
\frac{\mathrm{d}\beta}{\mathrm{d}s} = e^{i\tilde{\theta}} \overline{\omega_1 \cdots \omega_{n-1}}.
$$

hold in  $I$ . Then it is proved in  $[3]$  that  $L$  is a Lagrangian submanifold and L is a translating soliton with translating vector  $(0, \dots, 0, \alpha) \in \mathbb{C}^n$ . This is Theorem G in [\[3\]](#page-14-0).

The following Corollary [3.2](#page-11-0) gives the solution to ordinary deferential equations in Theorem [3.1.](#page-10-0)

<span id="page-11-0"></span>**Corollary 3.2.** In the situation of Theorem [3.1,](#page-10-0) write  $\omega_j := r_j e^{i\phi_j}$ , for functions  $r_1, \dots, r_{n-1} : I \to (0, \infty), \phi_1, \dots, \phi_{n-1} : I \to \mathbb{R}$ . Define  $u : I \to \mathbb{R}$ by

$$
u(s) := 2 \int_{s_0}^s \text{Re}(\dot{\beta}(t)) \, \mathrm{d}t.
$$

Then we have

$$
r_j^2 = \alpha_j + \lambda_j u, \quad \phi_j = \psi_j + \int_{s_0}^s \frac{\lambda_j \operatorname{Im}(\dot{\beta}(t))}{\alpha_j + \lambda_j u(t)} dt
$$

with  $\alpha_j = r_j^2(s_0)$ ,  $\psi_j = \phi_j(s_0)$ .

Remark 3.2.1. Thus if  $\beta$  is explicitly given, the ordinary differential equation [\(8\)](#page-10-1) is solved by Theorem [3.2.](#page-11-0)

Proof of Theorem [3.1.](#page-10-0) We consider the map

$$
\iota: \mathbb{R}^{n-1} \times I \to \mathbb{C}^n
$$

given by

$$
\iota((x_1,\dots,x_{n-1}),s)=(x_1\omega_1(s),\dots,x_{n-1}\omega_{n-1}(s),\frac{1}{2}\sum_{j=1}^{n-1}\lambda_jx_j^2+\beta(s)).
$$

Then we have  $L = \iota(\mathbb{R}^{n-1} \times I)$ . So  $(x_1, \dots, x_{n-1}, s)$  is a coordinate of L. With this coordinate we have

$$
(dz_1 \wedge d\overline{z}_1 + \cdots + dz_n \wedge d\overline{z}_n)|_L
$$
  
=  $(\omega_1 dx_1 + x_1 \dot{\omega}_1 ds) \wedge (\overline{\omega_1} dx_1 + x_1 \dot{\overline{\omega}_1} ds) + \cdots +$   
 $(\omega_{n-1} dx_{n-1} + \dot{\omega}_{n-1} ds) \wedge (\overline{\omega_{n-1}} dx_{n-1} + x_{n-1} \dot{\overline{\omega}_{n-1}} ds)$   
+  $(-\lambda_1 x_1 dx_1 - \cdots - \lambda_{n-1} x_{n-1} dx_{n-1} + \dot{\beta}(s) ds)$   
 $\wedge (-\lambda_1 x_1 dx_1 - \cdots - \lambda_{n-1} x_{n-1} dx_{n-1} + \dot{\overline{\beta}}(s) ds)$   
=  $2i \text{Im}(x_1 \omega_1 \overline{\omega_1}) dx_1 \wedge ds + \cdots + 2i \text{Im}(x_{n-1} \omega_{n-1} \overline{\omega_{n-1}}) dx_{n-1} \wedge ds$   
-  $2i \text{Im}(\lambda_1 x_1 \overline{\beta}) dx_1 \wedge ds - \cdots - 2i \text{Im}(\lambda_{n-1} x_{n-1} \overline{\beta}) dx_{n-1} \wedge ds$   
= 0

and

$$
dz_1 \wedge \cdots \wedge dz_n |_{L}
$$
  
=  $(\omega_1 dx_1 + x_1 \dot{\omega}_1 ds) \wedge \cdots \wedge (\omega_{n-1} dx_{n-1} + x_{n-1} \dot{\omega}_{n-1} ds) \wedge$   
 $(-\lambda_1 x_1 dx_1 - \cdots - \lambda_{n-1} x_{n-1} dx_{n-1} + \dot{\beta} ds)$   
=  $\omega_1 \cdots \omega_{n-1} \dot{\beta} \left(1 + \sum_{j=1}^{n-1} \frac{\lambda_j^2 x_j^2}{|\omega_j|^2} \right) dx_1 \wedge \cdots \wedge dx_{n-1} \wedge ds.$ 

It follows that  $L$  is a nonsingular immersed Lagrangian, with Lagrangian angle

$$
\theta = \arg(\omega_1 \cdots \omega_{n-1} \dot{\beta}).
$$

Since

$$
\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial x_j} \rangle
$$
  
= $\langle (x_1 \dot{\omega}_1(s), \dots, x_{n-1} \dot{\omega}_{n-1}(s), \dot{\beta}), (0, \dots, 0, \omega_j, 0, \dots, 0, -\lambda_j x_j) \rangle$   
= $\text{Re}(\overline{\omega_j} x_j \dot{\omega}_j - \lambda_j x_j \dot{\beta})$   
=0,

and  $\mathrm{d}\theta=\dot{\theta}\mathrm{d}s,$  it follows that

$$
\nabla \theta = \frac{\dot{\theta}}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} \left( \frac{\partial}{\partial s} \right).
$$

Therefore we obtain

$$
H = \frac{\dot{\theta}}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right).
$$

The normal projection of the position vector  $F$  is computed by

$$
\langle T, J\frac{\partial}{\partial x_j} \rangle
$$
  
= $\langle (0, \dots, 0, \alpha), i(0, \dots, 0, \omega_j, 0, \dots, 0, -\lambda_j x_j) \rangle$   
=0

and

$$
\langle T, J\frac{\partial}{\partial s}\rangle = \langle (0, \cdots, 0, \alpha), i(x_1\dot{\omega}_1(s), \cdots, x_{n-1}\dot{\omega}_{n-1}(s), \dot{\beta})\rangle
$$
  
= Re( $\alpha i\dot{\beta}$ )  
= -  $\alpha$  Im( $\dot{\beta}$ ).

It follows that

$$
T^{\perp} = -\frac{\alpha \operatorname{Im}(\dot{\beta})}{\langle \frac{\partial}{\partial s}, \frac{\partial}{\partial s} \rangle} J\left(\frac{\partial}{\partial s}\right).
$$

This completes the proof of Theorem [3.1.](#page-10-0)

As the proof of Theorem G in [\[3\]](#page-14-0) there is an another proof of Theorem [3.1](#page-10-0) which obtains Theorem [3.1](#page-10-0) from Theorem [2.1](#page-5-2) by a limiting procedure. See Joyce, Lee and tsui [\[3\]](#page-14-0).

*Proof of Corollary [3.2.](#page-11-0)* Changing f to  $\dot{\beta}$  in the proof of Theorem [2.3](#page-6-0) gives the proof of Corollary [3.2.](#page-11-0)  $\Box$ 

From Theorem [3.1](#page-10-0) if  $\dot{\theta} = -\alpha \operatorname{Im}(\dot{\beta})$  then L is a translating soliton with translating vector  $T = (0, \dots, 0, \alpha) \in \mathbb{C}^n$ . From Theorem [3.2](#page-11-0) and [\(10\)](#page-10-2),  $\dot{\theta} = -\alpha \operatorname{Im}(\dot{\beta})$  is equivalent to

<span id="page-13-0"></span>
$$
\sum_{j=1}^{n-1} \frac{\lambda_j \operatorname{Im}(\dot{\beta})}{\alpha_j + 2\lambda_j \int_{s_0}^s \operatorname{Re}(\dot{\beta}) dt} + \frac{d}{ds} \operatorname{arg}(\dot{\beta}) = -\alpha \operatorname{Im}(\dot{\beta}). \tag{11}
$$

Therefore if  $(11)$  holds then L is a translating soliton with translating vector  $T = (0, \dots, 0, \alpha) \in \mathbb{C}^n$ .

*Proof of Theorem [1.4.](#page-3-0)* Define  $\omega_j : I \to \mathbb{C} - \{0\}$  by  $\omega_j = r_j e^{i\phi_j}$ . Define  $\beta: I \to \mathbb{C} - \{0\}$  by

$$
\dot{\beta} = \frac{\overline{\omega_j} \dot{\omega}_j}{\lambda_j}
$$
 and  $\beta(0) = -K$ .

A direct calculation shows that

$$
\beta(s) = \int_0^s (B + i \frac{|B|}{\sqrt{E\{\prod_{k=1}^{n-1} (1 + 2a_k B\lambda_k s)\} e^{2B\alpha s} - 1}}) ds + K.
$$

Then  $\dot{\beta} \neq 0$  in *I*. Apply Theorem [3.1](#page-10-0) to the data  $\omega_i$ ,  $\beta$  above. Then we get a Lagrangian submanifold  $L$  defined by  $(9)$ . A direct calculation shows that  $\beta$  satisfies [\(11\)](#page-13-0). So this completes the proof.  $\Box$ 

*Proof of Theorem [1.5.](#page-4-0)* Put  $I = \mathbb{R}_{>0}$  or  $I = \mathbb{R}_{<0}$ . Define  $\omega_j : I \to \mathbb{C} - \{0\}$ by  $\omega_j = r_j e^{i\phi_j}$ . Define  $\beta : I \to \mathbb{C} - \{0\}$  by

$$
\dot{\beta} = \overline{\omega_j} \dot{\omega}_j
$$
 and  $\beta(0) = 0$ .

A direct calculation shows that

$$
\beta(s) = \int_0^s (s + i \frac{|s|}{\sqrt{E\{\prod_{k=1}^{n-1} (1 + a_k s^2)\} e^{\alpha s^2} - 1}}) ds.
$$

Then  $\dot{\beta} \neq 0$  in *I*. Apply Theorem [3.1](#page-10-0) to the data  $\omega_j$ ,  $\beta$  above and  $\lambda_1 = \cdots =$  $\lambda_{n-1} = 1$ . Then we get a Lagrangian submanifold L defined by [\(9\)](#page-10-3). A direct calculation shows that  $\beta$  satisfies [\(11\)](#page-13-0). So this completes the proof.  $\Box$
