

**MEROMORPHIC CONTINUATIONS OF FINITE GAP
HERGLOTZ FUNCTIONS AND PERIODIC JACOBI MATRICES**

ROSTYSLAV KOZHAN

ABSTRACT. We find a necessary and sufficient condition for a Herglotz function m to be the Borel transform of the spectral measure of an exponentially decaying perturbation of a periodic Jacobi matrix. The condition is in terms of meromorphic continuation of m to a natural Riemann surface and the structure of its zeros and poles.

The analogous result is also established for the Borel transform of the spectral measure of eventually periodic Jacobi matrices.

This paper generalizes the corresponding result from [17] for exponentially decaying perturbations of the free Jacobi matrix.

1. INTRODUCTION

Let μ be a probability measure on the real line \mathbb{R} with compact support. Denote by

$$m(z) = \int \frac{d\mu(x)}{x-z}, \quad z \notin \text{ess supp } \mu \quad (1.1)$$

the Borel transform (also sometimes referred as the Stieltjes transform) of μ . It is a Herglotz function: if $\text{Im } z > 0$ then $\text{Im } m(z) > 0$.

Assuming μ is a non-trivial measure, i.e., not supported on finitely many points, we can apply the Gram-Schmidt algorithm to orthonormalize the sequence of polynomials $\{x^n\}_{n=0}^\infty$. Let the resulting sequence of orthonormal polynomials be $\{p_n(x)\}_{n=0}^\infty$. They satisfy the Szegő recurrence

$$xp_n(x) = p_{n+1}(x)a_{n+1} + p_n(x)b_{n+1} + p_{n-1}(x)a_n, \quad n = 1, 2, \dots, \quad (1.2)$$

for some sequences of real numbers $a_n > 0$ and $b_n \in \mathbb{R}$, called the Jacobi coefficients. In fact, if we put $p_{-1}(x) \equiv 0$, then (1.2) holds for $n = 0$ too. Now one can see that the operator of multiplication by x in $L^2(\mu)$ in the basis $\{p_n(x)\}_{n=0}^\infty$ has the form

$$\mathcal{J} = \begin{pmatrix} b_1 & a_1 & 0 & & \\ a_1 & b_2 & a_2 & \ddots & \\ 0 & a_2 & b_3 & \ddots & \\ & \ddots & \ddots & \ddots & \ddots \end{pmatrix}. \quad (1.3)$$

This three-diagonal matrix is called the Jacobi matrix associated with the measure μ . One can recover μ from \mathcal{J} by finding the spectral measure of \mathcal{J} corresponding to the vector $\delta_1 = (1, 0, 0, \dots)^T$. Thus from the operator viewpoint, function (1.1)

is just the $(1, 1)$ -entry of the resolvent of \mathcal{J} , also sometimes referred to as a Green's function in spectral theory.

The theme of this paper is that certain analytic properties of m determine (in an if and only if fashion) how close \mathcal{J} is to being periodic. The prototype for this is the following result from [17].

The simplest Jacobi matrix is the one with constant Jacobi coefficients. After translating and scaling we may consider $a_n = 1$, $b_n = 0$, $n \geq 1$. We will refer to this matrix as the free Jacobi matrix. The Borel transform of μ corresponding to the free Jacobi matrix is

$$m(z) = \frac{-z + \sqrt{z^2 - 4}}{2}, \quad (1.4)$$

with the principal branch for the square root.

Note that the function (1.4) has a meromorphic continuation to the hyperelliptic Riemann surface associated with the polynomial $z^2 - 4$. Informally one may think of this surface as two sheets of $\mathbb{C} \cup \{\infty\} \setminus [-2, 2]$ glued together along the slit (see Section 2.1 for more details). It was shown in [17, Thm 3.8], that if a Jacobi matrix is “exponentially close” to being free (in the sense of (1.6)), then its Borel transform m has a meromorphic continuation through $[-2, 2]$ to an explicit region on the second sheet. Instead of continuations of m through $[-2, 2]$, we can equivalently consider continuations of

$$M(z) = m(z + z^{-1}), \quad z \in \mathbb{D} = \{z : |z| < 1\} \quad (1.5)$$

through $\partial\mathbb{D} = \{z : |z| = 1\}$. The result of [17, Thm 3.8] then says that

$$\limsup_{n \rightarrow \infty} (|b_n| + |1 - a_n^2|)^{1/2n} \leq R^{-1} \quad (1.6)$$

if and only if (1.5) satisfies

- (a) M has a meromorphic continuation to $\{z : |z| < R\}$;
- (b) M has no poles on $\partial\mathbb{D}$, except possibly at ± 1 , where they are at most simple;
- (c) $M(z) - M^\sharp(z)$ has no zeros in $\{z : R^{-1} < |z| < R\}$, except possibly at ± 1 , where they are at most simple;
- (d) if M has a pole $z \in \mathbb{D}$ with $R^{-1} < |z| < 1$, then \bar{z}^{-1} is not a pole of M .

Here $M^\sharp(z) = \overline{M(\bar{z}^{-1})}$. In fact, [17] also covers the case of matrix-valued measures. See Lemmas A.1 and A.2 below for the exact statement of the results.

The purpose of the current paper is to establish the analogue of the above equivalence for perturbations of the periodic Jacobi matrices. Another way to put it, instead of considering $\text{ess sup} \mu = [-2, 2]$ in this equivalence, we are extending it to the case $\text{ess sup} \mu = \cup_{j=1}^p [\alpha_j, \beta_j]$, a finite gap set.

One may put this result on its head and say that we obtain a criterion for a finite gap Herglotz function to have a meromorphic continuation without degeneracies of types (b), (c), (d).

The main results of this paper are stated in Theorem 3.1 and 3.2 in Section 3 below. One has to be careful in the periodic setting, since there is a whole multidimensional set of periodic Jacobi matrices that have the same spectrum. Theorem 3.1 corresponds to exponentially decaying perturbations of periodic Jacobi matrices, and Theorem 3.2 is the refinement for the eventually periodic Jacobi matrices.

The idea of the proof is to use the “Magic Formula” of Damanik–Killip–Simon (see Lemma B.2 in Appendix) which establishes a connection to the matrix-valued problem, and then apply the author's matrix-valued result (Lemmas A.1, A.2).

The present paper covers only the case when all the intervals $[\alpha_j, \beta_j]$ have equal equilibrium measure (the so-called “all gaps open” case). Even though this is a generic situation for the periodic Jacobi matrices, it would still be interesting to prove Theorems 3.1 and 3.2 in the cases when measures of $[\alpha_j, \beta_j]$ are rational but unequal (“some gaps closed” periodic setting), as well as when measures of $[\alpha_j, \beta_j]$ are not all rational (almost periodic setting). There is little doubt that similar theorems should still hold in these situations. However one would have to come up with a different approach to prove them, without the reliance on the Damanik–Killip–Simon formula.

For the background discussion of Jacobi matrices and orthogonal polynomials, see, e.g., [19]. A textbook exposition of the theory of *periodic* Jacobi matrices can be found there as well (in Chapter 5), along with an extensive historical discussion. Papers related to exponentially decaying perturbations of Jacobi matrices include (but are likely not limited to) [6, 7, 8, 17, 18].

The results of the present paper were completed and presented in 2010 (see the author’s PhD thesis [15]). Later there appeared an independent series of papers by Iantchenko–Korotyaev [11, 12, 13], who study eventually periodic Jacobi matrices, but from another perspective and using an entirely different approach. Their results are related to our Theorem 3.2. It should be noted however that the models and the results are different: Iantchenko–Korotyaev fix a periodic Jacobi matrix, which is assumed to be known, and then consider compact perturbations of it. In our approach, we fix the support of the spectrum and consider compact perturbations of any Jacobi matrix from the isospectral torus, without any other knowledge about it.

The organization of the paper is as follows. Section 2 contains the necessary definitions and preliminary information. Section 3 contains the two main theorems. Section 4 contains the proofs. Appendix contains all the necessary results from the theory of scalar and matrix-valued orthogonal polynomials (Appendix A), periodic Jacobi matrices and the connection between periodic and matrix-valued settings (Appendix B), general facts about matrix-valued functions (Appendix C) and Herglotz functions (Appendix D). A reader not familiar with the theory of orthogonal polynomials should familiarize (him/her)self with Appendices A and B prior to reading the proofs in Section 4. Otherwise, appendices can be used when referred to.

2. PRELIMINARIES

2.1. Finite Gap Sets and Surface $\mathcal{S}_\mathfrak{e}$. In this subsection let us assume that μ is a probability measure, and its essential support is a finite union of closed intervals (“finite gap set”)

$$\text{ess supp } \mu = \mathfrak{e} = \bigcup_{j=1}^{g+1} [\alpha_j, \beta_j], \quad \alpha_j < \beta_j < \alpha_{j+1}. \quad (2.1)$$

We will be referring to the collections of intervals $[\alpha_j, \beta_j]$ ($1 \leq j \leq g+1$) as “bands”, and $[\beta_j, \alpha_{j+1}]$ ($1 \leq j \leq g$) as “gaps”. As we will see soon, the spectral measures of periodic Jacobi matrices have exactly this form.

Then m , defined by (1.1), is a meromorphic function on $\mathbb{C} \setminus \mathfrak{e}$, and it is natural to ask if m has a meromorphic continuation through \mathfrak{e} . Indeed, this is the analogue

of the meromorphic continuation for the $\epsilon = [-2, 2]$ case that we discussed in the Introduction. Let us introduce the natural Riemann surface that arises here.

Definition 2.1. *Assume ϵ is a finite gap set (2.1). Define \mathcal{S}_ϵ to be the hyperelliptic Riemann surface corresponding to the polynomial $\prod_{j=1}^{g+1} (z - \alpha_j)(z - \beta_j)$.*

We will not give the formal definition, which can be found in many textbooks (see, e.g., [19, Sect 5.12]). Informally \mathcal{S}_ϵ can be described as follows.

Let $\mathbb{C}_+ = \{z : \text{Im } z > 0\}$, $\mathbb{C}_- = \{z : \text{Im } z < 0\}$. Denote \mathcal{S}_+ and \mathcal{S}_- to be two copies of $\mathbb{C} \cup \{\infty\}$ with a slit along ϵ (include ϵ as a top edge and exclude it from the lower), and let \mathcal{S}_ϵ be \mathcal{S}_+ and \mathcal{S}_- glued together along ϵ in the following way: passing from $\mathbb{C}_+ \cap \mathcal{S}_+$ through ϵ takes us to $\mathbb{C}_- \cap \mathcal{S}_-$, and from $\mathbb{C}_- \cap \mathcal{S}_+$ to $\mathbb{C}_+ \cap \mathcal{S}_-$. It is clear that topologically \mathcal{S}_ϵ is an orientable manifold of genus g .

Let $\pi : \mathcal{S}_\epsilon \rightarrow \mathbb{C} \cup \{\infty\}$ be the ‘‘projection map’’ which extends the natural inclusions $\mathcal{S}_+ \hookrightarrow \mathbb{C} \cup \{\infty\}$, $\mathcal{S}_- \hookrightarrow \mathbb{C} \cup \{\infty\}$.

The following notation will be used frequently throughout the paper.

Definition 2.2.

- For $z \in \mathbb{C} \cup \{\infty\}$, denote by z_+ and z_- the two preimages $\pi^{-1}(z)$ in \mathcal{S}_+ and \mathcal{S}_- respectively (for $z \in \cup_{j=1}^{g+1} \{\alpha_j, \beta_j\}$, z_+ and z_- coincide).
- Let $z^\#$ be $\left(\overline{\pi(z)}\right)_-$ if $z \in \mathcal{S}_+ \setminus \pi^{-1}(\epsilon)$, and $\left(\overline{\pi(z)}\right)_+$ if $z \in \mathcal{S}_- \setminus \pi^{-1}(\epsilon)$. In order to make this continuous, we make the convention $z^\# = z$ for $z \in \pi^{-1}(\epsilon)$.
- Let $m^\#(z) = m(z^\#)^*$.

Here bar means complex conjugation, and $*$ means Hermitian conjugation (later on we will allow m to be a matrix-valued function).

2.2. Periodic Orthogonal Polynomials on the Real Line. For all the proofs of the facts in this subsection, we refer the reader to [19] and references therein. Some of the basics of the theory of orthogonal polynomials, along with the necessary lemmas, are also listed below in Appendices A and B.

A Jacobi matrix \mathcal{J} , see (1.3), is called periodic if there exists an integer $p \geq 1$ such that

$$a_{n+p} = a_n, \quad b_{n+p} = b_n \quad \text{for all } n. \quad (2.2)$$

One can also talk about two-sided Jacobi matrices, which are operators on $\ell^2(\mathbb{Z})$ of the same tridiagonal form as (1.3), where sequences $\{a_n, b_n\}_{n \in \mathbb{Z}}$ are now extended to the whole \mathbb{Z} . The same definition of periodicity (2.2) applies to a two-sided Jacobi matrix as well. We will commonly use $(a_n, b_n)_{n=1}^\infty$, $(a_n, b_n)_{n \in \mathbb{Z}}$ as a notation for one-sided and two-sided Jacobi matrices, respectively.

For a one- or two-sided p -periodic Jacobi matrix one can associate the polynomial of degree p with real coefficients

$$\Delta(z) = \text{Tr} \left(\prod_{j=p}^1 \frac{1}{a_j} \begin{pmatrix} z - b_j & -1 \\ a_j^2 & 0 \end{pmatrix} \right), \quad (2.3)$$

which is called the *discriminant* of \mathcal{J} .

The polynomial Δ has numerous useful properties, some of which we list in Lemma B.1. The most important for us here is that it determines the spectrum of \mathcal{J} .

It turns out that the spectrum of a two-sided periodic Jacobi matrix is purely absolutely continuous of multiplicity two, and

$$\sigma((a_n, b_n)_{n \in \mathbb{Z}}) = \Delta^{-1}([-2, 2]).$$

Essential spectrum of a one-sided periodic Jacobi matrix is purely absolutely continuous of multiplicity one and we still have

$$\sigma_{ess}((a_n, b_n)_{n=1}^\infty) = \Delta^{-1}([-2, 2]).$$

In fact, $\Delta^{-1}([-2, 2])$ is a finite gap set

$$\Delta^{-1}([-2, 2]) = \bigcup_{j=1}^p [\alpha_j, \beta_j] \equiv \mathfrak{e}, \quad \alpha_j < \beta_j \leq \alpha_{j+1}, \quad (2.4)$$

where these intervals are allowed to touch. If some two intervals do touch $\beta_j = \alpha_{j+1}$, then this gap $[\beta_j, \alpha_{j+1}]$ is said to be *closed*, and otherwise it is *open*. Let g be the number of open gaps (in other words, \mathfrak{e} consists precisely of $g + 1$ disjoint closed intervals), which is consistent with the notation in the previous section.

Unlike the two-sided Jacobi matrices, the one-sided ones may have some point spectrum: $\sigma((a_n, b_n)_{n=1}^\infty) \setminus \Delta^{-1}([-2, 2])$ may consist of up to g eigenvalues, at most one per each open gap.

It turns out that if there exists at least one periodic Jacobi matrix \mathcal{J} with $\sigma_{ess}(\mathcal{J}) = \mathfrak{e}$, then there exists a whole set of periodic Jacobi matrices satisfying the same property. In fact, this set is homeomorphic to $(S^1)^g$, a g -dimensional torus. This motivates the following definition.

Definition 2.3. *The isospectral torus $\mathcal{T}_\mathfrak{e}$ of \mathfrak{e} is the set of periodic Jacobi matrices \mathcal{J} with $\sigma_{ess}(\mathcal{J}) = \mathfrak{e}$.*

We will view $\mathcal{T}_\mathfrak{e}$ as a set of one-sided $(a_n, b_n)_{n=1}^\infty$ or two-sided $(a_n, b_n)_{n \in \mathbb{Z}}$ matrices, depending on the context.

Denote $\rho_\mathfrak{e}$ to be the equilibrium (harmonic) measure of \mathfrak{e} .

There is an easy criterion for determining when a finite gap set \mathfrak{e} is the (essential) spectrum of some periodic Jacobi matrix.

Lemma 2.4. *Let \mathfrak{e} be a finite gap set (2.4).*

- (a) \mathfrak{e} is the essential spectrum of some periodic Jacobi matrix if and only if the equilibrium measure of each of the $g + 1$ disjoint intervals of \mathfrak{e} is rational.
- (b) \mathfrak{e} is the essential spectrum of some p -periodic Jacobi matrix with all gaps open if and only if the equilibrium measures of each of the $p = g + 1$ disjoint intervals of \mathfrak{e} are equal (and so equal to $1/p$).

Note that (a) in the above lemma should be thought of as p intervals of equal equilibrium measure, some of which may touch. So in a sense (which can be made rigorous), (b) in the generic subcase of (a).

As a side remark, if at least one of the $g + 1$ disjoint intervals of \mathfrak{e} has irrational equilibrium measure, then one can construct an *almost periodic* Jacobi matrix with essential spectrum \mathfrak{e} . We will not be discussing them in this paper (see [19, Chapt 9] for more information).

Now let μ be the spectral measure of a periodic one-sided Jacobi matrix $\mathcal{J} = (a_n, b_n)_{n=1}^\infty$ with respect to the vector δ_1 , and let m be its Borel transform (1.1).

Using the recursion-type relation (A.6) and the periodicity of \mathcal{J} , one can easily obtain that m satisfies a certain quadratic equation. In fact (see Lemma B.1(ii)),

$$m(z) = \frac{r(z) \pm \sqrt{\Delta^2(z) - 4}}{t(z)}.$$

Here $r(z), t(z)$ are some polynomials in z . Comparing this with (2.4), one now sees that m has a meromorphic continuation to the full surface \mathcal{S}_ϵ , the genus g hyperelliptic surface constructed in Definition 2.1.

Our aim is to show that spectral measures of exponentially decaying perturbations of periodic Jacobi matrices have Borel transforms m that can be meromorphically continued from \mathcal{S}_+ to a portion of \mathcal{S}_- . In fact, up to some poles/zeros constraints, these are the only measures that have this property.

3. RESULTS

Let $\epsilon = \cup_{j=1}^p [\alpha_j, \beta_j]$, $\alpha_j < \beta_j < \alpha_{j+1}$, be such that each $[\alpha_j, \beta_j]$ has equal equilibrium measure (“open gaps case”).

Assume $\text{ess supp } \mu = \epsilon$, and let $m(z) = \int_{\mathbb{R}} \frac{d\mu(x)}{x-z}$.

Denote Δ to be the unique polynomial of degree p such that $\epsilon = \Delta^{-1}[-2, 2]$ (its existence follows from the discussion in Section 2.2). Let $x(z) = z + z^{-1}$. For each $R > 1$, let

$$\mathcal{S}_R = \mathcal{S}_+ \cup \pi^{-1}(E_R),$$

where E_R is the union of the interiors of the bounded components of the set $\Delta^{-1}(x(R\partial\mathbb{D}))$.

Theorem 3.1. *Let $R > 1$. The following are equivalent:*

(i) *The Jacobi matrix $(a_n, b_n)_{n=1}^\infty$ associated with μ satisfies*

$$\limsup_{n \rightarrow \infty} \left(|a_n - a_n^{(0)}| + |b_n - b_n^{(0)}| \right)^{1/2n} \leq R^{-1},$$

where $(a_n^{(0)}, b_n^{(0)})_{n=1}^\infty$ is a periodic Jacobi matrix from \mathcal{T}_ϵ .

- (ii) (a) *m has a meromorphic continuation to \mathcal{S}_R ;*
 (b) *m has no poles on $\pi^{-1}(\epsilon)$, except at $\pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$, where they are at most simple;*
 (c) *$m(z) - m^\sharp(z)$ has no zeros in $\pi^{-1}(E_R)$, except at $\pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$, where they are at most simple;*
 (d) *If m has a pole at z for $z \in \pi^{-1}(E_R \setminus \epsilon)$ then z^\sharp is not a pole of m .*

Theorem 3.2. *The following are equivalent:*

(i) *The Jacobi matrix $(a_n, b_n)_{n=1}^\infty$ associated with μ is eventually periodic, i.e., satisfies*

$$(a_n, b_n)_{n=N}^\infty \in \mathcal{T}_\epsilon \quad \text{for large } N.$$

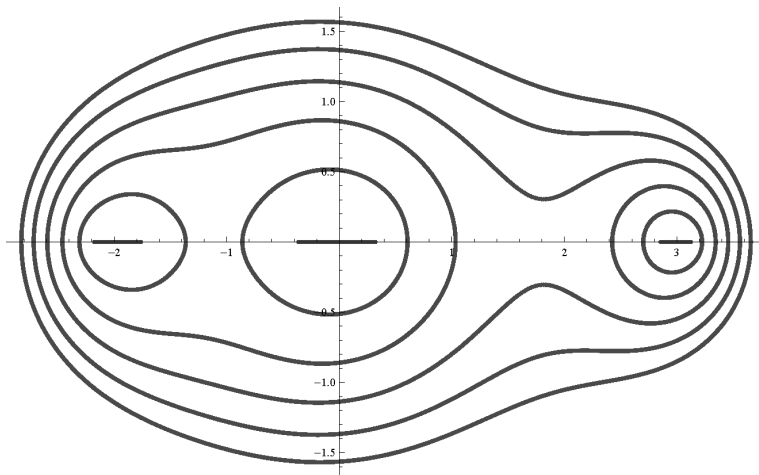
- (ii) (a) *m has a meromorphic continuation to \mathcal{S}_ϵ ;*
 (b) *m has no poles on $\pi^{-1}(\epsilon)$, except at $\pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$, where they are at most simple;*
 (c) *$m(z) - m^\sharp(z)$ has no zeros in $\mathcal{S}_\epsilon \setminus \{\pm\infty\}$, except at $\pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$, where they are at most simple;*
 (d) *If m has a pole at z for $z \in \pi^{-1}(\mathbb{C} \setminus \epsilon)$ then z^\sharp is not a pole of m .*

Remarks. 1. Theorems 3.1, 3.2 for $p = 1$ and [17, Thm 3.8, 3.9] (see Lemmas A.1, A.2) for $l = 1$ are identical.

2. $R = \infty$ in Theorem 3.1 is, in fact, allowed, and this case is *not* the same as Theorem 3.2.

3. Let us try to understand conditions (a) through (d) in terms of the properties of the measure μ . Condition (b) just says that μ has no pure points on ϵ (see Lemma D.2). By the discussion after Lemma D.3, the conditions (a) and (c) imply that μ has no singular continuous part; the absolutely-continuous density $f(x) = \frac{d\mu}{dx}$ has a meromorphic continuation to $\pi^{-1}(E_R)$, where it is non-vanishing except possibly the first order zeros at the band edges (recall that local coordinates of \mathcal{S}_ϵ at the edges of ϵ are given in terms of $\sqrt{z - z_0}$, not $z - z_0$). However it is not so simple to express the condition (d) in terms of the properties of μ alone, since it is influenced by both the absolutely continuous and pure point parts of μ .

4. Below is an example how E_R evolves as R grows (the picture was generated using Wolfram Mathematica 7.0). Using the results of [19, Chapt 5], it is easy to see that E_R are precisely the interiors of the level sets of the logarithmic potential of the equilibrium measure for ϵ .



4. PROOFS

4.1. Notation. Let $\epsilon, \mu, m, \Delta, E_R$ be as in Section 3. Let \mathcal{J} be the Jacobi matrix associated with μ . As explained in Appendix B, $\Delta(\mathcal{J})$ can be viewed as a block Jacobi matrix with $p \times p$ matrix entries.

Let $p_n(x), q_n(x)$ be the orthonormal polynomials of the first and the second kind for \mathcal{J} (see Appendix A), and $\mathbf{p}_n(x), \mathbf{q}_n(x)$ be the right matrix-valued orthonormal polynomials of the first and the second kind for $\Delta(\mathcal{J})$.

Denote by $\mathcal{S} = \mathcal{S}_\epsilon$ the (genus $p - 1$) Riemann surface corresponding to ϵ , and by $\mathcal{R} = \mathcal{S}_{[-2,2]}$ the (genus 0) Riemann surface corresponding to $[-2, 2]$ (i.e., the hyperelliptic surface corresponding to the polynomial $z^2 - 4$). We will denote both projections $\mathcal{S} \rightarrow \mathbb{C} \cup \{\infty\}$ and $\mathcal{R} \rightarrow \mathbb{C} \cup \{\infty\}$ by the same symbol π , in hopes that it should be unambiguous from the context.

Recall that $\mathcal{S}_R = \mathcal{S}_+ \cup \pi^{-1}(E_R)$, where E_R is the union of the interiors of the bounded components of $\Delta^{-1}(x(R\partial\mathbb{D}))$, where $x(z) = z + z^{-1}$. Denote $\mathcal{R}_R =$

$\mathcal{R}_+ \cup \pi^{-1}(F_R)$, where F_R is the interior of the bounded component of $x(R\partial\mathbb{D})$ (ellipse).

Let μ be the spectral measures for \mathcal{J} with respect to $\delta_1 = (1, 0, 0, \dots)^T$. Let μ_Δ be the $p \times p$ spectral measures of $\Delta(\mathcal{J})$ with respect to $(\mathbf{1}, \mathbf{0}, \mathbf{0}, \dots)^T$. Here $\mathbf{1}, \mathbf{0}$ are the $p \times p$ identity matrix and the $p \times p$ zero matrix, respectively.

Let m be the Borel transform of μ . It is a meromorphic function on $\mathbb{C} \cup \{\infty\} \setminus \mathfrak{e}$. However we will view it as a meromorphic function on \mathcal{S}_+ under the natural identification. Similarly let \mathbf{m}_Δ be the $p \times p$ matrix-valued Borel transform of μ_Δ . It is meromorphic on $\mathbb{C} \cup \{\infty\} \setminus [-2, 2]$ by the spectral theorem. Indeed, $\Delta(\mathfrak{e}) = [-2, 2]$. Again, we will view it as a meromorphic function on \mathcal{R}_+ .

As in Definition 2.2, let z^\sharp be $\left(\overline{\pi(z)}\right)_-$ if $z \in \mathcal{S}_+$ and $\left(\overline{\pi(z)}\right)_+$ if $z \in \mathcal{S}_-$, with the convention $z^\sharp = z$ for $z \in \pi^{-1}(\mathfrak{e})$. Similarly, let λ^\sharp be $\left(\overline{\pi(\lambda)}\right)_-$ if $\lambda \in \mathcal{R}_+$ and $\left(\overline{\pi(\lambda)}\right)_+$ if $\lambda \in \mathcal{R}_-$, with the convention $\lambda^\sharp = \lambda$ for $\lambda \in \pi^{-1}([-2, 2])$. Let $m^\sharp(z) = \overline{m(z^\sharp)}$ and $\mathbf{m}_\Delta^\sharp(\lambda) = \mathbf{m}_\Delta(\lambda^\sharp)^*$.

Let $\{\gamma_j\}_{j=1}^{p-1}$ be the $p-1$ real solutions of $\Delta'(z) = 0$ (they are indeed all real by Lemma B.1). Denote by $\{\xi_j\}_{j=1}^N$ all of the preimages $\Delta^{-1}(\Delta(\gamma_j))$ (so the set $\{\xi_j\}_{j=1}^N$ contains all γ_j 's and finitely many of other points).

Denote the p inverse functions of Δ by f_j :

$$\Delta(z) = \lambda \Rightarrow z = f_j(\lambda).$$

Initially we can define f_j on $\mathbb{C}_+ \cup \mathbb{C}_- \cup [-2, 2]$ (the critical points of Δ are all in $(-\infty, -2) \cup (2, \infty)$), and then extend it to $(-\infty, -2) \cup (2, \infty)$ by demanding it to be continuous “from above”, i.e., for $\lambda_0 \in (-\infty, -2) \cup (2, \infty)$,

$$f_j(\lambda_0) = \lim_{\mathbb{C}_+ \ni \lambda \rightarrow \lambda_0} f_j(\lambda).$$

With this convention, we have that f_j are functions defined everywhere on \mathbb{C} with possible discontinuity only along $(-\infty, -2) \cup (2, \infty)$. Also note that for any $\lambda \in \mathbb{C}$ (including $(-\infty, -2) \cup (2, \infty)$), the set $\{f_j(\lambda) : 1 \leq j \leq p\}$ is equal to $\{z : \Delta(z) = \lambda\}$. In fact, if $\lambda \in \mathbb{C} \setminus \{\Delta(\gamma_1), \dots, \Delta(\gamma_{p-1})\}$, then $f_j(\lambda)$ are all distinct for $j = 1, \dots, p$.

Counting zeros one can see that

$$\Delta(z) - \lambda = c_0 \prod_{j=1}^p (z - f_j(\lambda)) \quad (4.1)$$

for some constant $c_0 \in \mathbb{R} \setminus \{0\}$. In fact, $c_0 = \text{Cap}(\mathfrak{e})^{-p}$ (see [19, Chapt 5]), where $\text{Cap}(\mathfrak{e})$ stands for the logarithmic capacity of the set \mathfrak{e} .

Now let us “lift” the maps f_j . Define \tilde{f}_j to be the unique map $\mathcal{R} \rightarrow \mathcal{S}$ satisfying the conditions

$$\begin{aligned} \pi \circ \tilde{f}_j &= f_j, \\ \tilde{f}_j(\lambda) &\in \mathcal{S}_+ \quad \text{if } \lambda \in \mathcal{R}_+, \\ \tilde{f}_j(\lambda) &\in \mathcal{S}_- \quad \text{if } \lambda \in \mathcal{R}_-. \end{aligned}$$

Note that each \tilde{f}_j is continuous everywhere except on $\pi^{-1}((-\infty, -2) \cup (2, \infty))$.

Define $\tilde{\Delta} : \mathcal{S} \rightarrow \mathcal{R}$ in the analogous way:

$$\begin{aligned}\pi \circ \tilde{\Delta} &= \Delta, \\ \tilde{\Delta}(z) &\in \mathcal{R}_+ \quad \text{if } z \in \mathcal{S}_+, \\ \tilde{\Delta}(z) &\in \mathcal{R}_- \quad \text{if } z \in \mathcal{S}_-.\end{aligned}$$

Whenever we have any function g of complex variable, and $z \in \mathcal{S}$, $\lambda \in \mathcal{R}$, then we will occasionally write $g(z)$, $g(\lambda)$ instead of $g(\pi(z))$, $g(\pi(\lambda))$.

Throughout the paper, by a simple pole of a matrix-valued meromorphic function $\mathbf{m}(\lambda)$, we mean a point λ_0 where $\lim_{\lambda \rightarrow \lambda_0} (\lambda - \lambda_0) \mathbf{m}(\lambda)$ exists and is a non-zero matrix. By a regular point of a function \mathbf{m} , we mean a point λ_0 where $\lim_{\lambda \rightarrow \lambda_0} \mathbf{m}(\lambda)$ exists.

4.2. Lemmas.

Lemma 4.1. *For $\lambda \in \mathcal{R}_+ \setminus \pi^{-1}([-2, 2])$,*

$$m(\tilde{f}_l(\lambda)) = \left(c_0(\Delta(\mathcal{J}) - \lambda)^{-1} \prod_{j \neq l} (\mathcal{J} - f_j(\lambda)) \delta_1, \delta_1 \right). \quad (4.2)$$

Proof. Since $(x - f_l(\lambda))^{-1} = c_0(\Delta(x) - \lambda)^{-1} \prod_{j \neq l} (x - f_j(\lambda))$, we obtain

$$(\mathcal{J} - f_l(\lambda))^{-1} = c_0(\Delta(\mathcal{J}) - \lambda)^{-1} \prod_{j \neq l} (\mathcal{J} - f_j(\lambda)) \quad \text{for } \lambda \in \mathcal{R}_+ \quad (4.3)$$

(note also that $\prod_{j \neq l} (\mathcal{J} - f_j(\lambda))$ is a finite-banded matrix, so the multiplication on the right-hand side is well-defined). Now using (A.9), we obtain the result of the lemma. \square \square

Note that (4.2) allows one to continue m using the continuation of \mathbf{m}_Δ , but not vice versa since we cannot invert the operator $\prod_{j \neq l} (\mathcal{J} - f_j(\lambda))$. There is a trick that will help us, though.

Lemma 4.2. *For $\lambda \in \mathcal{R}_+$,*

$$\begin{aligned} \sum_{j=1}^p \left(\begin{array}{cccc} q_0 + p_0 m & q_1 + p_1 m & \cdots & q_{p-1} + p_{p-1} m \\ q_1 + p_1 m & q_1 p_1 + p_1^2 m & \cdots & q_{p-1} p_1 + p_{p-1} p_1 m \\ \vdots & \vdots & \ddots & \vdots \\ q_{p-1} + p_{p-1} m & q_{p-1} p_1 + p_{p-1} p_1 m & \cdots & q_{p-1} p_{p-1} + p_{p-1}^2 m \end{array} \right) (\tilde{f}_j(\lambda)) \\ = \mathbf{m}_\Delta(\lambda) (S_{11} + \mathbf{p}_1^R(\lambda) S_{21}) + A_1^{-1*} S_{21}, \end{aligned} \quad (4.4)$$

where S_{ij} is the (i, j) -th $p \times p$ block entry of $\Delta'(\mathcal{J})$, and p_j, q_j are the first and second kind polynomials for \mathcal{J} .

Proof. Sum the equalities (4.3) from $l = 1$ to p :

$$\begin{aligned} \sum_{l=1}^p (\mathcal{J} - \tilde{f}_l(\lambda))^{-1} &= c_0(\Delta(\mathcal{J}) - \lambda)^{-1} \sum_{l=1}^p \prod_{j \neq l} (\mathcal{J} - f_j(\lambda)) \\ &= (\Delta(\mathcal{J}) - \lambda)^{-1} \Delta'(\mathcal{J}). \end{aligned} \quad (4.5)$$

The last equality comes from

$$c_0 \sum_{l=1}^p \prod_{j \neq l} (x - f_j(\lambda)) = \Delta'(x) \quad (4.6)$$

(to see this, just differentiate (4.1)).

Now using (A.9), and taking the top-left $p \times p$ block of both sides of (4.5), we obtain

$$\text{LHS of (4.4)} = \mathbf{m}_\Delta(\lambda)S_{11} + (\mathbf{q}_1^R(\lambda) + \mathbf{m}_\Delta(\lambda)\mathbf{p}_1^R(\lambda))S_{21}.$$

Since $\mathbf{q}_1^R(\lambda) = A_1^{*-1}$ (see (A.8)), we obtain the result of the lemma. \square \square

The above lemma allows us to continue \mathbf{m}_Δ using the continuation of m . We will now establish some results that will allow us to study zeros and poles of m , \mathbf{m}_Δ , $m - m^\sharp$, and $\mathbf{m}_\Delta - \mathbf{m}_\Delta^\sharp$.

Lemma 4.3. *If m and \mathbf{m}_Δ have meromorphic continuations to \mathcal{S}_R and \mathcal{R}_R , respectively, then for $\lambda \in \pi^{-1}(F_R)$,*

$$\begin{aligned} \left[\mathbf{m}_\Delta(\lambda) - \mathbf{m}_\Delta^\sharp(\lambda) \right] (S_{11} + \mathbf{p}_1(\lambda)S_{21}) &= \sum_{j=1}^p \left[m(\tilde{f}_j(\lambda)) - m^\sharp(\tilde{f}_j(\lambda)) \right] \times \\ &\times \begin{pmatrix} 1 & p_1 & \cdots & p_{p-1} \\ p_1 & p_1^2 & \cdots & p_1 p_{p-1} \\ \vdots & \vdots & \ddots & \vdots \\ p_{p-1} & p_1 p_{p-1} & \cdots & p_{p-1}^2 \end{pmatrix} (f_j(\lambda)). \end{aligned} \quad (4.7)$$

Proof. Immediate from the previous lemma. \square \square

In order to use equality (4.7), we will need to understand the detailed behavior of $S_{11} + \mathbf{p}_1(\lambda)S_{21}$. This is done in Lemma 4.5. To prove it, we will need the following perturbation theory result. For the terminology and basics of perturbation theory, we refer the reader to [14, Section 2.1] or [3, Section 3.2].

Lemma 4.4. *Let $\mathfrak{U}(z)$ be an analytic $p \times p$ matrix-valued function in a small neighborhood of $z = z_0$ and λ_0 be an eigenvalue of $\mathfrak{U}(z_0)$. Suppose that*

(E1) *The λ_0 -group of perturbed eigenvalues of $\mathfrak{U}(z)$ is $\{\lambda_1(z), \lambda_2(z), \dots, \lambda_{2N}(z)\}$, each of multiplicity 1. Suppose that this λ_0 -group of eigenvalues consists of N cycles $\{\lambda_{2s}(z), \lambda_{2s+1}(z)\}$ of period 2 ($s = 1, 2, \dots, N$).*

(E2) *The eigenvectors $\vec{g}_j(z)$ of $\mathfrak{U}(z)$ corresponding to the eigenvalue $\lambda_j(z)$ can be chosen so that they satisfy*

$$\vec{g}_{2s}(z) = \vec{h}_s + (z - z_0)^{1/2} \vec{k}_{2s} + O(z - z_0), \quad (4.8)$$

$$\vec{g}_{2s+1}(z) = \vec{h}_s + (z - z_0)^{1/2} \vec{k}_{2s+1} + O(z - z_0), \quad (4.9)$$

where $\vec{h}_1, \dots, \vec{h}_N \in \mathbb{C}^p$ are linearly independent constant vectors.

Then the Jordan blocks corresponding to λ_0 in the Jordan form of $\mathfrak{U}(z_0)$ are each of size 2×2 , and there are N of them.

Remarks. 1. Note that given the condition (E1), there always exist eigenvectors having expansions (4.8)–(4.9), with non-zero \vec{h}_s (see Theorem 2 from [3, Section 6.1.7]). What is a non-trivial requirement here is that the vectors $\vec{h}_1, \dots, \vec{h}_N$ are linearly independent.

2. Condition (E1) easily gives us that the algebraic multiplicity of λ_0 is $2N$. The condition (E2) says that the geometric multiplicity is *at least* N . There doesn't seem to be a general theory that would determine the Jordan form from this.

Proof. Using the perturbation theory on the eigenprojections, we immediately know that the algebraic multiplicity of λ_0 as an eigenvalue of $\mathfrak{U}(z_0)$ is $2N$. We will now find N linearly independent eigenvectors (which are going to be $\vec{h}_1, \dots, \vec{h}_N$, of course), and show that each one of them has an associated generalized eigenvector. This determines the Jordan structure we are looking for.

Condition (E1) and the standard perturbation theory tell us that the perturbed eigenvalue functions have the Puiseux expansions

$$\lambda_{2s}(z) = \lambda_0 + c_s(z - z_0)^{1/2} + O(z - z_0), \quad (4.10)$$

$$\lambda_{2s+1}(z) = \lambda_0 - c_s(z - z_0)^{1/2} + O(z - z_0), \quad (4.11)$$

for any $s = 1, \dots, N$.

Note that $c_s \neq 0$, for otherwise $\{\lambda_{2s}(z), \lambda_{2s+1}(z)\}$ would not constitute a period 2 cycle.

Now taking $z \rightarrow z_0$ in $\mathfrak{U}(z)\vec{g}_{2s}(z) = \lambda_{2s}(z)\vec{g}_{2s}(z)$ gives

$$\mathfrak{U}(z_0)\vec{h}_s = \lambda_0\vec{h}_s.$$

Similarly, plugging expansions (4.8), (4.9), (4.10), (4.11) into

$$\mathfrak{U}(z) \left(\frac{\vec{g}_{2s}(z) - \vec{g}_{2s+1}(z)}{2c_s(z - z_0)^{1/2}} \right) = \frac{1}{2c_s(z - z_0)^{1/2}} (\lambda_{2s}(z)\vec{g}_{2s}(z) - \lambda_{2s+1}(z)\vec{g}_{2s+1}(z)),$$

and then taking $z \rightarrow z_0$, gives

$$\mathfrak{U}(z_0) \left(\frac{\vec{k}_{2s} - \vec{k}_{2s+1}}{2c_s} \right) = \vec{h}_s + \lambda_0 \frac{\vec{k}_{2s} - \vec{k}_{2s+1}}{2c_s}.$$

This shows that $\frac{\vec{k}_{2s} - \vec{k}_{2s+1}}{2c_s}$ is a non-zero vector, and, in fact, is the generalized eigenvector associated with λ_0 and \vec{h}_s . Thus we obtain N Jordan blocks of size at least 2. Since the algebraic multiplicity is $2N$, we obtain the statement of our lemma. \square \square

We can now prove the following lemma. Recall that $\{\gamma_j\}_{j=1}^{p-1}$ are the zeros of the polynomial $\Delta'(z)$. Denote

$$\mathfrak{U}(\lambda) = S_{11} + \mathfrak{p}_1(\lambda)S_{21}. \quad (4.12)$$

Lemma 4.5. *The following holds:*

$$\det \mathfrak{U}(\lambda) = p^p \prod_{j=1}^{p-1} (\lambda - \Delta(\gamma_j)), \quad (4.13)$$

$$\ker \mathfrak{U}(\lambda) = \text{span}\{\vec{v}_1(\lambda), \dots, \vec{v}_p(\lambda)\}^\perp, \quad (4.14)$$

where $\vec{v}_j(\lambda) = (1, p_1(f_j(\lambda)), \dots, p_{p-1}(f_j(\lambda)))^*$.

In particular, $\mathfrak{U}(\lambda)$ is singular if and only if $\lambda = \Delta(\gamma_j)$, $j = 1, \dots, p-1$, and $\mathfrak{U}(\lambda)^{-1}$ has simple poles at these points.

Proof. Note that by (A.7),

$$\mathfrak{U}(\lambda) = S_{11} + (\lambda \mathbf{1} - B_1)A_1^{*-1}S_{21} = S_{11} + (\lambda \mathbf{1} - T_{11})T_{21}^{-1}S_{21},$$

where S_{ij} and T_{ij} are the $p \times p$ blocks of $\Delta'(\mathcal{J})$ and $\Delta(\mathcal{J})$, respectively.

Take any $\mu \in \mathbb{C}$, and let

$$\begin{aligned}\widehat{u}(\mu) &= (1, p_1(\mu), \dots, p_j(\mu), \dots)^*, \\ \vec{u}_1(\mu) &= (1, p_1(\mu), \dots, p_{p-1}(\mu))^*, \\ \vec{u}_2(\mu) &= (p_p(\mu), p_{p+1}(\mu), \dots, p_{2p-1}(\mu))^*.\end{aligned}$$

Then $\widehat{u}^* \mathcal{J} = \mu \widehat{u}^*$ in the formal sense (note that $\widehat{u} \notin \ell^2$ in general). This gives $\widehat{u}^* \Delta(\mathcal{J}) = \Delta(\mu) \widehat{u}^*$ and $\widehat{u}^* \Delta'(\mathcal{J}) = \Delta'(\mu) \widehat{u}^*$ in the formal sense. However $\Delta(\mathcal{J})$ and $\Delta'(\mathcal{J})$ are banded matrices, so we can conclude that

$$\begin{aligned}\vec{u}_1^* T_{11} + \vec{u}_2^* T_{21} &= \Delta(\mu) \vec{u}_1^*, \\ \vec{u}_1^* S_{11} + \vec{u}_2^* S_{21} &= \Delta'(\mu) \vec{u}_1^*.\end{aligned}$$

The first equality implies $\vec{u}_1^* T_{11} T_{21}^{-1} + \vec{u}_2^* = \Delta(\mu) \vec{u}_1^* T_{21}^{-1}$, and therefore

$$\vec{u}_1^* [S_{11} + (\lambda - T_{11}) T_{21}^{-1} S_{21}] = \vec{u}_1^* [\Delta'(\mu) + (\lambda - \Delta(\mu)) T_{21}^{-1} S_{21}].$$

This shows that if $\lambda = \Delta(\mu)$, then $\mathfrak{U}(\lambda)^* \vec{u}_1(\mu) = \Delta'(\bar{\mu}) \vec{u}_1(\mu)$, or equivalently,

$$\mathfrak{U}(\bar{\lambda})^* \vec{u}_1(\bar{\mu}) = \Delta'(\mu) \vec{u}_1(\bar{\mu}). \quad (4.15)$$

Since $\mathfrak{U}(\bar{\lambda})^*$ is a $p \times p$ matrix, we now know its spectrum:

$$\sigma(\mathfrak{U}(\bar{\lambda})^*) = \{\Delta'(\Delta^{-1}(\lambda))\} = \{\Delta'(f_1(\lambda)), \dots, \Delta'(f_p(\lambda))\}. \quad (4.16)$$

Indeed, by perturbation theory this equality is true even if some of the points $\{\Delta'(f_1(\lambda)), \dots, \Delta'(f_p(\lambda))\}$ coincide. Note that this happens if and only if $\lambda = \Delta(\gamma_j)$ for some j .

Thus the characteristic polynomial of $\mathfrak{U}(\bar{\lambda})^*$ is

$$\det(\mathfrak{U}(\bar{\lambda})^* - t \mathbf{1}) = \prod_{k=1}^p (\Delta'(f_k(\lambda)) - t).$$

At $t = 0$, using (4.1):

$$\begin{aligned}\det \mathfrak{U}(\lambda) &= \det \mathfrak{U}(\bar{\lambda})^* = \prod_{k=1}^p \Delta'(f_k(\lambda)) = \prod_{k=1}^p p c_0 \prod_{j=1}^{p-1} (f_k(\lambda) - \gamma_j) \\ &= p^p \prod_{j=1}^{p-1} (\lambda - \Delta(\gamma_j)).\end{aligned} \quad (4.17)$$

This establishes (4.13) (alternatively one can directly see that (4.16) contains zero if and only if $\lambda = \Delta(\gamma_j)$ for some j , and then count the degree of the polynomials).

Note that the system of vectors $\{(1, p_1(z_j), \dots, p_{p-1}(z_j))\}_{j=1}^k$ is linearly independent if and only if all the points z_j are distinct: easy use of Vandermonde determinant and the fact that p_n is of degree n . Therefore if $\lambda \notin \{\Delta(\gamma_j)\}_{j=1}^{p-1}$, then vectors $\vec{v}_j(\lambda) = (1, p_1(f_j(\lambda)), \dots, p_{p-1}(f_j(\lambda)))^*$ form a basis of \mathbb{C}^p , and (4.14) is trivial.

Suppose $\lambda_0 = \Delta(\gamma_k)$ for some k . We showed in (4.15) that each $\vec{v}_j(\bar{\lambda}_0)$, $1 \leq j \leq p$, is an eigenvector of $\mathfrak{U}(\bar{\lambda}_0)^*$ with eigenvalue $\Delta'(f_j(\lambda_0))$. Now let us apply Lemma 4.4 to $\mathfrak{U}(\bar{\lambda})^*$ around the point λ_0 . Note that in place of the Lemma's $\mathfrak{U}(z)$, z_0 , λ_0 , we

feed $\mathfrak{U}(\bar{\lambda})^*$, λ_0 , 0, respectively, hoping it will not cause confusion. Note that if $\Delta'(f_j(\lambda_0)) = 0$ for some j , then $f_j(\lambda)$ is one of the two branches of a multivalued analytic function with branching degree 2 around λ_0 . This is because each γ_j is a *simple* zero of Δ' (follows from Lemma B.1(i)). Thus (E1) of Lemma 4.4 is satisfied. The linear independence in (E2) of Lemma 4.4 follows from the above-mentioned fact that the system $\{(1, p_1(z_j), \dots, p_{p-1}(z_j))\}_{j=1}^k$ is linearly independent if and only if all the points z_j are distinct.

Therefore we can conclude that the Jordan form of $\mathfrak{U}(\bar{\lambda}_0)^*$ consists of 1×1 blocks corresponding to non-zero eigenvalues and 2×2 blocks corresponding to zero eigenvalues. It is clear that for such matrices the range is precisely equal to the span of all eigenvectors. Thus,

$$\text{Ran } \mathfrak{U}(\bar{\lambda}_0)^* = \text{span}\{\vec{v}_1(\bar{\lambda}_0), \dots, \vec{v}_p(\bar{\lambda}_0)\}$$

holds. This implies (4.14), since $\ker \mathfrak{U}(\bar{\lambda}_0) = (\text{Ran } \mathfrak{U}(\bar{\lambda}_0)^*)^\perp$ and $\lambda_0 = \bar{\lambda}_0$.

Finally, the poles of $\mathfrak{U}(\lambda)^{-1}$ at $\lambda = \Delta(\gamma_j)$ are simple by (4.13), (4.14), and Lemma C.2. \square \square

We now know everything we need about $S_{11} + \mathfrak{p}_1(\lambda)S_{21}$. We also need to analyze the right-hand side of (4.7). Let us assign it a name:

$$\mathfrak{L}(\lambda) = \sum_{j=1}^p \left[m(\tilde{f}_j(\lambda)) - m^\sharp(\tilde{f}_j(\lambda)) \right] \begin{pmatrix} 1 & p_1 & \cdots & p_{p-1} \\ p_1 & p_1^2 & \cdots & p_1 p_{p-1} \\ \vdots & \vdots & \ddots & \vdots \\ p_{p-1} & p_1 p_{p-1} & \cdots & p_{p-1}^2 \end{pmatrix} (f_j(\lambda)). \quad (4.18)$$

Lemma 4.6. *The following holds:*

$$\det \mathfrak{L}(\lambda) = \left(\frac{p^p}{c_0^p} \prod_{j=1}^{p-1} a_j^{-2(p-j)} \right) \prod_{j=1}^p \left(m(\tilde{f}_j(\lambda)) - m^\sharp(\tilde{f}_j(\lambda)) \right) \prod_{j=1}^{p-1} (\lambda - \Delta(\gamma_j)).$$

If $\lambda = \tilde{\Delta}(\gamma_k)$ and all $m(\tilde{f}_j(\lambda)) - m^\sharp(\tilde{f}_j(\lambda))$ are regular and non-zero, then

$$\ker \mathfrak{L}(\lambda) = \text{span}\{\vec{v}_1(\lambda), \dots, \vec{v}_p(\lambda)\}^\perp, \quad (4.19)$$

where $\vec{v}_j(\lambda) = (1, p_1(f_j(\lambda)), \dots, p_{p-1}(f_j(\lambda)))^*$, and $\mathfrak{L}(\lambda)^{-1}$ has simple poles at these points.

Proof. Let $\eta_j = m(\tilde{f}_j(\lambda)) - m^\sharp(\tilde{f}_j(\lambda))$. Then

$$\begin{aligned} \det \mathfrak{L}(\lambda) &= \det \sum_{j=1}^p \eta_j [p_{k-1}(f_j(\lambda))p_{s-1}(f_j(\lambda))]_{k,s=1}^p \\ &= \det \left[\sum_{j=1}^p \eta_j p_{k-1}(f_j(\lambda))p_{s-1}(f_j(\lambda)) \right]_{k,s=1}^p \\ &= \det \left([\eta_j p_{k-1}(f_j(\lambda))]_{k,j=1}^p [p_{s-1}(f_j(\lambda))]_{j,s=1}^p \right) \\ &= \left(\det [p_{s-1}(f_j(\lambda))]_{j,s=1}^p \right)^2 \prod_{j=1}^p \eta_j. \end{aligned}$$

Since p_j is of degree j , by performing elementary row operations we can reduce $\det [p_{s-1}(f_j(\lambda))]_{j,s=1}^p$ to the Vandermonde determinant times the product of the leading coefficients of $1, p_1, \dots, p_{p-1}$. Using (A.3), we get

$$\begin{aligned} \det \mathfrak{L}(\lambda) &= \prod_{j=1}^p \eta_j \prod_{j=1}^{p-1} (a_1 \dots a_j)^{-2} \prod_{j < s} (f_j(\lambda) - f_s(\lambda))^2 \\ &= \prod_{j=1}^p \eta_j \prod_{j=1}^{p-1} a_j^{-2(p-j)} \prod_{j=1}^p \prod_{\substack{s=1 \\ s \neq j}}^p (f_j(\lambda) - f_s(\lambda)). \end{aligned}$$

Now observe that

$$\prod_{\substack{s=1 \\ s \neq j}}^p (f_j(\lambda) - f_s(\lambda)) = \frac{1}{c_0} \Delta'(f_j(\lambda))$$

by (4.6), and so the determinant is equal to

$$\frac{1}{c_0^p} \prod_{j=1}^p \eta_j \prod_{j=1}^{p-1} a_j^{-2(p-j)} \prod_{j=1}^p \Delta'(f_j(\lambda)) = \frac{p^p}{c_0^p} \prod_{j=1}^{p-1} a_j^{-2(p-j)} \prod_{j=1}^p \eta_j \prod_{s=1}^{p-1} (\lambda - \Delta(\gamma_s)),$$

where in the last step we reused the computations from (4.17). This proves the first statement of the lemma.

Suppose that $\lambda = \Delta(\gamma_k)$. That any vector orthogonal to $\{\vec{v}_1(\lambda), \dots, \vec{v}_p(\lambda)\}$ must be in the kernel is clear, since the j -th row of the matrix in (4.7) is obtained from its first row by multiplication by p_{j-1} . Therefore

$$\ker \mathfrak{L}(\lambda) \supseteq \text{span}\{\vec{v}_1(\lambda), \dots, \vec{v}_p(\lambda)\}^\perp. \quad (4.20)$$

Note that $\dim \ker \mathfrak{L}(\lambda)$ is less than or equal to the order of λ as the root of $\det \mathfrak{L}(\lambda)$ (it could be strictly less if one of the κ 's is ≥ 2 in Lemma C.1). But this order is precisely equal to p minus the cardinality of $\{f_1(\lambda), \dots, f_p(\lambda)\}$. This implies that

$$\dim \ker \mathfrak{L}(\lambda) \leq \dim \text{span}\{\vec{v}_1(\lambda), \dots, \vec{v}_p(\lambda)\}^\perp. \quad (4.21)$$

But then (4.20) and (4.21) imply that $\ker \mathfrak{L}(\lambda) = \text{span}\{\vec{v}_1(\lambda), \dots, \vec{v}_p(\lambda)\}^\perp$.

Finally, each zero of $\mathfrak{L}(\lambda)$ is simple by Lemma C.2. \square \square

Lemma 4.7. *If m and \mathfrak{m}_Δ have meromorphic continuations to \mathcal{S}_R and \mathcal{R}_R , respectively, then for $\lambda \in \pi^{-1}(F_R)$,*

$$\det \left(\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\#(\lambda) \right) = \left(\frac{1}{c_0^p} \prod_{j=1}^p a_j^{-2(p-j)} \right) \prod_{j=1}^p \left(m(\tilde{f}_j(\lambda)) - m^\#(\tilde{f}_j(\lambda)) \right).$$

Remark. Note that if we take $\lambda \in \pi^{-1}(\mathfrak{e})$ in the lemma, then we can recover the formula from Damanik–Killip–Simon relating the determinant of the density $\frac{d\mu_\Delta}{dx}$ of μ_Δ and the density $\frac{d\mu}{dx}$ of μ (see [4, Prop 11.1]). In our notation it looks as follows:

$$\det \left[\frac{d\mu_\Delta(\lambda)}{d\lambda} \right] = \frac{1}{c_0^p} \prod_{j=1}^{p-1} a_j^{-2(p-j)} \prod_{j=1}^p \frac{d\mu}{dx}(f_j(\lambda)).$$

Proof. Immediate from Lemmas 4.3, 4.5, and 4.6. \square \square

The next lemma will allow us to assume that m satisfies conditions (P1) and (P2) stated below, which will considerably simplify the proof of the main results.

Recall that $\{\xi_j\}_{j=1}^N$ are all of the preimages $\Delta^{-1}(\Delta(\gamma_j))$, where γ_j are the critical points of Δ' .

Lemma 4.8. *Let $a_0 > 0, b_0 \in \mathbb{R}$, and let $\mathcal{J}^{(-1)} = (a_n, b_n)_{n=0}^\infty$ be the Jacobi matrix obtained from $\mathcal{J} = (a_n, b_n)_{n=1}^\infty$ by adding one column and one row with the coefficients a_0, b_0 . Let m and $m^{(-1)}$ be the Borel transforms of the spectral measure of \mathcal{J} and $\mathcal{J}^{(-1)}$, respectively. If m satisfies (ii) of Theorem 3.1/3.2, then so does $m^{(-1)}$.*

Moreover, for any $\varepsilon > 0$, there exist a_0, b_0, a_{-1}, b_{-1} such that the Jacobi matrix $\mathcal{J}^{(-2)} = (a_n, b_n)_{n=-1}^\infty$ (with two rows and columns added) satisfies

(P1) $m^{(-2)}$ does not have poles at any $(\xi_j)_\pm$ and band edges;

(P2) for any two poles ζ_1, ζ_2 of $m^{(-2)}$ in $\mathcal{S}_{R-\varepsilon}$, $\tilde{\Delta}(\zeta_1) \neq \tilde{\Delta}(\zeta_2)$, $\tilde{\Delta}(\zeta_1^\sharp) \neq \tilde{\Delta}(\zeta_2)$.

Proof. Suppose that m satisfies (ii) of Theorem 3.1. By the recursion

$$a_0^2 m(z) = -z + b_0 - m^{(-1)}(z)^{-1} \quad (4.22)$$

we can extend $m^{(-1)}$ to the same domain as m . So $m^{(-1)}$ satisfies (ii)(a) of Theorem 3.1. Moreover,

$$m(z) - m^\sharp(z) = \frac{m^{(-1)}(z) - m^{(-1)\sharp}(z)}{a_0^2 m^{(-1)}(z) m^{(-1)\sharp}(z)} \quad \text{for } z \in \pi^{-1}(E_R). \quad (4.23)$$

Assume $m^{(-1)}(z)$ has a pole at a point in $\pi^{-1}(\mathbf{e} \setminus \cup_{j=1}^p \{\alpha_j, \beta_j\})$. Then (4.22) implies that m is real at this point, which violates (ii)(c). Assume $m^{(-1)}(z)$ has a pole of order $k \geq 2$ at a band edge $z \in \pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$. Then $m^{(-1)\sharp}(z)$ has the same order pole at this point, and therefore $m^{(-1)}(z) - m^{(-1)\sharp}(z)$ has a pole of order at most k . Now (4.23) implies that $m - m^\sharp$ has a zero of order at least $2k - k \geq 2$, contradicting (ii)(c) for m . Thus $m^{(-1)}$ satisfies (ii)(b).

Assume $m^{(-1)}(z)$ and $m^{(-1)\sharp}(z)$ are both regular and $m^{(-1)}(z) - m^{(-1)\sharp}(z) = 0$, for some z not at a band edge. Then (4.23) implies that m violates (ii)(c) or (ii)(d) of Theorem 3.1, a contradiction. Thus $m^{(-1)}$ satisfies (ii)(c) for z not at a band edge.

Let us verify (ii)(c) for $m^{(-1)}$ at a band edge.

Assume $m^{(-1)}$ is finite and non-zero at a band edge. Then so is $m^{(-1)\sharp}$, and then $m^{(-1)} - m^{(-1)\sharp} = a_0^2(m - m^\sharp)m^{(-1)}m^{(-1)\sharp}$ has at most first order pole there.

Now let $m^{(-1)}$ have a zero of order $k \geq 1$ at $z_0 \in \pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$. Then (4.22) shows that necessarily $k = 1$. This means that locally around z_0 ,

$$m^{(-1)}(z) = s_1 \sqrt{z - z_0} + s_2(z - z_0) + O(z - z_0)^{3/2}$$

for a non-zero constant s_1 . But then $m^{(-1)\sharp}(z) = -s_1 \sqrt{z - z_0} + s_2(z - z_0) - O(z - z_0)^{3/2}$, and so $m^{(-1)}(z) - m^{(-1)\sharp}(z) = 2s_1 \sqrt{z - z_0} + O(z - z_0)^{3/2}$ has first order zero too.

Lastly, assume $m^{(-1)}$ has a pole at a band edge. We showed that then this pole is simple. Again, $m^{(-1)\sharp}$ has a first order pole with the coefficient near $\frac{1}{\sqrt{z - z_0}}$ being negative to that of $m^{(-1)}$. Therefore $m^{(-1)} - m^{(-1)\sharp}$ still has a first order pole. Thus it does not vanish, and so $m^{(-1)}$ satisfies (ii)(c).

Finally, let us check (ii)(d) for $m^{(-1)}$. Assume $m^{(-1)}(z)$ and $m^{(-1)\sharp}(z)$ both have a pole at $z_0 \in \pi^{-1}(E_R \setminus \mathfrak{e})$. Then by (4.22) $m(z_0) = m^\sharp(z_0) = \frac{b_0 - \pi(z_0)}{a_0^2}$, which means that m violates (ii)(c). Contradiction.

Let us prove the “moreover” part of the lemma now. Note that all the poles of $m^{(-1)}$ occur at the points where $a_0^2 m(z) = b_0 - z$. Denote the finite number of distinct poles of m in $\mathcal{S}_{R-\varepsilon}$ by $\{z_j\}_{j=1}^K$. Let $M_1 = \max_j |\pi(z_j)|$. Choose small $\delta > 0$ such that the δ -neighborhoods $U_\delta(z_j) = \{z : |z - z_j| < \delta\}$ of these points are disjoint and lie inside $\mathcal{S}_{R-\varepsilon}$. Let

$$M_2 = \sup_{z \in \mathcal{S}_{R-\varepsilon} \setminus \bigcup_{j=1}^K U_\delta(z_j)} |m(z)|.$$

Let $b_0(t) = M_1 + M_2 + t$ for $t \gg 0$, and choose any a_0 satisfying $0 < a_0 < \sqrt{\delta/M_2}$. For each such $a_0, b_0(t)$ let $m^{(-1)}(a_0, b_0(t))$ be the m -function of $\mathcal{J}^{(-1)} = (a_n, b_n)_{n=0}^\infty$. Note that if z is not in one of $U_\delta(z_j)$ or $U_\delta(b_0(t)_+)$, then z cannot be a pole of $m^{(-1)}(a_0, b_0(t))$. Indeed, for such z , $|a_0^2 m(z)| \leq \delta < |b_0 - z|$. Note that for large t , $b_0(t)_-$ is not in $\mathcal{S}_{R-\varepsilon}$, and we can ignore $U_\delta(b_0(t)_-)$.

Let $a_0^2 m(z) + z$ around each z_j be locally k_j -to-1 (where $k_j \geq 1$ is the order of the pole of m at z_j). Therefore assuming t is large enough, we will have precisely k_j distinct solutions to $a_0^2 m(z) + z = b_0(t)$ in each $U_\delta(z_j)$, i.e., there are precisely k_j distinct first order poles of $m^{(-1)}(a_0, b_0(t))$ in each $U_\delta(z_j)$.

For large enough t there will be exactly one solution to $a_0^2 m(z) = b_0(t) - z$ in $U_\delta(b_0(t)_+)$. Indeed, m is monotonically increasing to zero as $\mathbb{R} \ni z \rightarrow +\infty$ (see (1.1)). Therefore for large t , $a_0^2 m(z) = b_0(t) - z$ will have exactly one real solution in $U_\delta(b_0(t)_+)$. Since any pole of $m^{(-1)}$ on \mathcal{S}_+ must be real, there must be a unique pole of $m^{(-1)}$ in $U_\delta(b_0(t)_+)$.

Thus there are precisely $1 + \sum_{j=1}^K k_j$ first order poles of $m^{(-1)}(a_0, b_0(t))$ in $\mathcal{S}_{R-\varepsilon}$, which are distinct for any t large enough. Denote the locations of these poles by $\zeta_j(t)$ (note that each $\zeta_j(t)$ is a continuous function).

The restriction (P1) requires only $b_0(t) \neq a_0^2 m((\xi_j)_\pm) + \xi_j$, and $b_0(t) \neq a_0^2 m(\alpha_j) + \alpha_j$, $b_0(t) \neq a_0^2 m(\beta_j) + \beta_j$, which excludes only a finite number of allowable $b_0(t)$ for each a_0 .

Thus choosing t large enough will always ensure that $m^{(-1)}(a_0, b_0(t))$ satisfies (P1) and has only first order poles in $\mathcal{S}_{R-\varepsilon}$. Performing this procedure and renaming $m^{(-1)}$ to m , we may now assume that m already satisfies (P1) and has only first order poles in $\mathcal{S}_{R-\varepsilon}$.

In particular, since each pole of m is assumed to be simple, $k_j = 1$. Therefore there are precisely $K + 1$ poles of $m^{(-1)}$ in $\mathcal{S}_{R-\varepsilon}$: one pole $\zeta_j(t)$ in each $U_\delta(z_j)$, $1 \leq j \leq K$, and one pole $\zeta_{K+1}(t)$ in $U_\delta(b_0(t)_+)$.

Choose any pair of indices $1 \leq j, n \leq K + 1$. We will be checking which a_0 and t would make $m^{(-1)}(a_0, b_0(t))$ satisfy (P2) for the pair of poles $\zeta_j(t), \zeta_n(t)$.

First observe that $\zeta_{K+1}(t) \rightarrow \infty_+$ when $t \rightarrow \infty$, while $\zeta_j(t) \in U_\delta(z_j)$, so if t is large enough then $\zeta_{K+1}(t)$ cannot cause any trouble with respect to (P2).

Now note that if δ is small enough, then

$$\begin{aligned} \tilde{\Delta}(z_j) \neq \tilde{\Delta}(z_n) &\Rightarrow \tilde{\Delta}(U_\delta(z_j)) \cap \tilde{\Delta}(U_\delta(z_n)) = \emptyset, \\ \tilde{\Delta}(z_j^\sharp) \neq \tilde{\Delta}(z_n) &\Rightarrow \tilde{\Delta}(U_\delta(z_j)^\sharp) \cap \tilde{\Delta}(U_\delta(z_n)) = \emptyset. \end{aligned}$$

So if m satisfies (P2) some z_j, z_n , then $m^{(-1)}$ satisfies (P2) for the corresponding poles $\zeta_j(t), \zeta_n(t)$.

Assume that m does not satisfy (P2), say for the poles z_1 and z_2 . Without loss of generality we may assume $\tilde{\Delta}(z_1) = \tilde{\Delta}(z_2) \equiv \lambda_0$ (the case $\tilde{\Delta}(z_1^\#) = \tilde{\Delta}(z_2)$ can be treated in the same way).

Fix any a_0 ($0 < a_0 < \sqrt{\delta/M_2}$). Suppose that $m^{(-1)}(a_0, b_0(t))$ fails the condition (P2) for uncountably many t at $\zeta_1(t)$ and $\zeta_2(t)$. Recall that $\zeta_1(t), \zeta_2(t)$ are the unique solutions of $a_0^2 m(z) = b_0(t) - z$ in $U_\delta(z_1), U_\delta(z_2)$, respectively. This implies $\tilde{\Delta}(\zeta_1(t)) = \tilde{\Delta}(\zeta_2(t)) =: \lambda(t)$. This means that we can choose *different* branches \tilde{f}_1, \tilde{f}_2 of $\tilde{\Delta}^{-1}$ around λ_0 (note that $\pi(\lambda_0)$ is not critical point of Δ since (P1) holds for m), such that $\zeta_1(t) = \tilde{f}_1(\lambda(t)), \zeta_2(t) = \tilde{f}_2(\lambda(t))$. This implies

$$a_0^2(m(\tilde{f}_1(\lambda(t))) - m(\tilde{f}_2(\lambda(t)))) = f_2(\lambda(t)) - f_1(\lambda(t)).$$

for uncountably many t . But then by analytic continuation we obtain

$$a_0^2(m(\tilde{f}_1(\lambda)) - m(\tilde{f}_2(\lambda))) = f_2(\lambda) - f_1(\lambda).$$

for all λ in a neighborhood of λ_0 . This may, in fact, happen. However then any a_0 different from the chosen one would violate this condition. This means that there may be only one a_0 for which $\tilde{\Delta}(\zeta_1(t)) = \tilde{\Delta}(\zeta_2(t))$ holds for uncountably many t . Every other a_0 will have at most countably many exceptions. Note, in particular, that this allows us to take t as large as we need (which is important in regards to $\zeta_{K+1}(t)$, as well as to make sure that $m^{(-1)}$ still satisfies (P1)).

Since there are finitely many pairs of indices $1 \leq j, n \leq K+1$, we can conclude that there exists a choice of a_0 and t which works for all of them, i.e., $m^{(-1)}$ satisfies (P2). Moreover, t can be chosen large enough, so that $m^{(-1)}$ still satisfies (P1). \square \square

Finally, we will need the following result, which is the analogue of Lemma A.3.

Lemma 4.9. *Assume that $\mathcal{J} = (a_n, b_n)_{n=1}^\infty$ satisfies*

$$\limsup_{n \rightarrow \infty} \left(|a_n - a_n^{(0)}| + |b_n - b_n^{(0)}| \right)^{1/2n} \leq R^{-1},$$

where $\mathcal{J}^0 = (a_n^{(0)}, b_n^{(0)})_{n=1}^\infty$ is a p -periodic Jacobi matrix in \mathcal{T}_c . Let $m, m^{(n)}$, and m^0 be the Borel transform of the spectral measure of $\mathcal{J}, \mathcal{J}^{(n)}$, and \mathcal{J}^0 , respectively. Suppose that m has a meromorphic continuation to \mathcal{S}_R . Then $m^{(np)}(z) \rightarrow m^0(z)$ as $n \rightarrow \infty$ for any $z \in \mathcal{S}_R$.

Remark. In fact, if we view m as a function $\mathcal{S}_R \rightarrow \mathbb{C} \cup \{\infty\}$, then the convergence is uniform on compacts with respect to the spherical distance on the Riemann sphere $\mathbb{C} \cup \{\infty\}$.

Proof. Since $(\mathcal{J}^0)^{(np)} = \mathcal{J}^0$, we have $\mathcal{J}^{(np)} \rightarrow \mathcal{J}^0$ in norm. This also gives us $\Delta(\mathcal{J}^{(np)}) \rightarrow \Delta(\mathcal{J}^0)$. Note that convergence in norm implies convergence of the resolvents, which gives us $m^{(np)}(z) \rightarrow m^0(z)$, *but only for $z \in \mathcal{S}_+$* .

Fix any point $z \in \mathcal{S}_R$. For this lemma only, let us employ the following convention. For any *scalar* Jacobi matrix \mathcal{I} , let us write $m(\mathcal{I})$ to mean the m -function (i.e., the Borel transform of the spectral measure) of \mathcal{I} evaluated at $z \in \mathcal{S}_R$, the dependence on which we will omit for convenience. For any *block* Jacobi matrix

\mathcal{I} , let us write $\mathbf{m}_\Delta(\mathcal{I})$ to mean the (matrix-valued) m -function of \mathcal{I} evaluated at $\tilde{\Delta}(z) \in \mathcal{R}_R$.

Let also m^0 be the m -function of \mathcal{J}^0 , evaluated at z , and \mathbf{m}_Δ^0 be the m -function of the free block Jacobi matrix $(\frac{-\lambda \pm \sqrt{\lambda^2 - 4}}{2} \mathbf{1})$, evaluated at $\tilde{\Delta}(z)$.

Let us write (4.2) as $m(\mathcal{J}) = g(\mathbf{m}_\Delta(\Delta(\mathcal{J})), \{a_j\}_{j=1}^N, \{b_j\}_{j=1}^N)$, where g is a continuous function that takes one $p \times p$ matrix-valued parameter and $2N$ real parameters. Indeed, the right-hand side of (4.2) depends on $\mathbf{m}_\Delta(\Delta(\mathcal{J}))$, the first orthogonal polynomial \mathfrak{p}_1 of $\Delta(\mathcal{J})$, and the first column of the product $\prod_{j \neq i} (\mathcal{J} - f_j(\Delta(z)))$. The latter two objects are smooth functions (in fact, polynomials) of first N Jacobi parameters $\{a_j\}_{j=1}^N, \{b_j\}_{j=1}^N$ of \mathcal{J} , for N sufficiently large but finite. This proves that if $\mathcal{J}_k \rightarrow \mathcal{J}$ and $\mathbf{m}_\Delta(\Delta(\mathcal{J}_k)) \rightarrow \mathbf{m}_\Delta(\Delta(\mathcal{J}))$ then $m(\mathcal{J}_k) \rightarrow m(\mathcal{J})$.

By Lemma A.3 we have that $\mathbf{m}_\Delta(\Delta(\mathcal{J}^{(np)})) \rightarrow \mathbf{m}_\Delta^0$. Note that $\Delta(\mathcal{J}^{(np)}) \neq \Delta(\mathcal{J}^{(n)})$. However, $\Delta(\mathcal{J}^{(np)})$ and $\Delta(\mathcal{J}^{(n)})$ differ only in the first block entry, which implies $\Delta(\mathcal{J}^{(np)})^{(1)} = \Delta(\mathcal{J}^{(n+1)})$. Thus

$$\mathbf{m}_\Delta(\Delta(\mathcal{J}^{(np)})^{(1)}) = \mathbf{m}_\Delta(\Delta(\mathcal{J}^{(n+1)})) \rightarrow \mathbf{m}_\Delta^0.$$

Note that $\Delta(\mathcal{J}^0)^{(1)}$ is free, so $\mathbf{m}_\Delta(\Delta(\mathcal{J}^0)^{(1)}) = \mathbf{m}_\Delta^0$. Therefore

$$\mathbf{m}_\Delta(\Delta(\mathcal{J}^{(np)})^{(1)}) \rightarrow \mathbf{m}_\Delta(\Delta(\mathcal{J}^0)^{(1)}).$$

Now use (4.22): the first Jacobi parameters of $\Delta(\mathcal{J}^{(np)})$ converge to the first Jacobi parameters of $\Delta(\mathcal{J}^0)$, which implies that $\mathbf{m}_\Delta(\Delta(\mathcal{J}^{(np)})) \rightarrow \mathbf{m}_\Delta(\Delta(\mathcal{J}^0))$ if $\tilde{\Delta}(z)$ is a regular point of $\mathbf{m}_\Delta(\Delta(\mathcal{J}^0))$. This gives us $m(\mathcal{J}^{(np)}) \rightarrow m(\mathcal{J}^0)$ by continuity of g , for all z such that $\tilde{\Delta}(z)$ is regular for $\mathbf{m}_\Delta(\Delta(\mathcal{J}^0))$.

In fact, note that the convergence $\mathbf{m}_\Delta(\Delta(\mathcal{J}^{(np)})^{(1)}) \rightarrow \mathbf{m}_\Delta(\Delta(\mathcal{J}^0)^{(1)})$ is given by Lemma A.3 to be uniform on compacts (\mathbf{m}_Δ^0 has no poles except at ∞_-). Therefore

$$m(\mathcal{J}^{(np)}) = g \left(\left[B_0^{(np)} - \Delta(z) - A_0^{(np)} \mathbf{m}_\Delta(\Delta(\mathcal{J}^{(np)})^{(1)}) A_0^{(np)*} \right]^{-1}, \right. \\ \left. \{a_j\}_{j=1+np}^{N+np}, \{b_j\}_{j=1+np}^{N+np} \right)$$

is just some rational function of finitely many uniformly convergent analytic functions. This implies that $m(\mathcal{J}^{(np)})$ is a sequence of meromorphic functions that converges to $m(\mathcal{J}^0)$ uniformly on compacts with respect to the spherical distance. In particular, if $m(\mathcal{J}^0)$ has a pole at z , then $m(\mathcal{J}^{(np)}) \rightarrow \infty$. \square \square

4.3. Proof of Theorems 3.1 and 3.2.

Proof of Theorem 3.1.

(ii) \Rightarrow (i) Passing from m to $m^{(-2)}$ in Lemma 4.8, we may assume that m itself satisfies (P1) and (P2).

We want to apply Lemma A.1 to $\Delta(\mathcal{J})$.

(II)(A) holds by (ii)(a) and Lemma 4.2, and analytic continuation. Indeed, for any $\lambda \in \mathcal{R}_R$, $\tilde{f}_j(\lambda) \in \mathcal{S}_R$, so all we need to check is continuity along $\pi^{-1}((-\infty, -2) \cup (2, \infty)) \cap \mathcal{R}_-$. We want to show that for any $\eta \in (-\infty, -2) \cup (2, \infty)$,

$$\lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_+) \ni \lambda \rightarrow \eta_-} \mathbf{m}_\Delta(\lambda) = \lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_-) \ni \lambda \rightarrow \eta_-} \mathbf{m}_\Delta(\lambda). \quad (4.24)$$

Even though in general $\lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_+) \lambda \rightarrow \eta_-} \tilde{f}_j(\lambda) \neq \lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_-) \ni \lambda \rightarrow \eta_-} \tilde{f}_j(\lambda)$, we however still have

$$\left\{ \lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_+) \lambda \rightarrow \eta_-} \tilde{f}_j(\lambda) \right\}_{1 \leq j \leq p} = \left\{ \lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_-) \ni \lambda \rightarrow \eta_-} \tilde{f}_j(\lambda) \right\}_{1 \leq j \leq p}$$

as sets (these points just get permuted). Then (4.4) shows that (4.24) is true.

(ii)(b), Lemma 4.2, and Lemma 4.5 imply (II)(B).

Recall the functions $\mathfrak{U}(\lambda)$ and $\mathfrak{L}(\lambda)$, which we introduced in (4.12) and (4.18). Equation (4.7) can be rewritten as

$$\left[\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda) \right]^{-1} = \mathfrak{U}(\lambda) \mathfrak{L}(\lambda)^{-1}, \quad (4.25)$$

and so the poles of (4.25) may come only from the poles of $\mathfrak{L}(\lambda)^{-1}$.

Let us show that (II)(C) holds. Assume that it does not, and there is a pole of (4.25) at $\lambda_0 \in \pi^{-1}(F_R \setminus \{\pm 2\})$. By symmetry, we can assume $\lambda_0 \in \mathcal{R}_+$.

Suppose first that $\{f_j(\lambda_0)\}_{j=1}^p$ are all regular points for m and m^\sharp . Then $\mathfrak{L}(\lambda)$ is regular at λ_0 . So the fact that $\mathfrak{L}(\lambda)^{-1}$ has a pole means that $\det \mathfrak{L}(\lambda)$ is zero. By Lemma 4.6 and (ii)(b), $\lambda_0 = \Delta(\gamma_j)_+$ for some j .

By Lemma 4.5, $\mathfrak{L}(\lambda)^{-1}$ has a simple pole at λ_0 , so

$$\operatorname{Res}_{\lambda=\lambda_0} \left[\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda) \right]^{-1} = \mathfrak{U}(\lambda_0) \operatorname{Res}_{\lambda=\lambda_0} \mathfrak{L}(\lambda)^{-1}.$$

But using Lemmas C.2, 4.6, and 4.5, we get

$$\operatorname{Ran} \operatorname{Res}_{\lambda=\lambda_0} \mathfrak{L}(\lambda)^{-1} = \ker \mathfrak{L}(\lambda_0) = \ker \mathfrak{U}(\lambda_0),$$

which implies $\operatorname{Res}_{\lambda=\lambda_0} (\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda))^{-1} = \mathbf{0}$, i.e., $(\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda))^{-1}$ is regular at λ_0 .

Now assume that $z_0 = \tilde{f}_n(\lambda_0)$ is a pole for m or m^\sharp for some $1 \leq n \leq p$. Note that (4.19) does not apply here, so we need some additional arguments.

By (ii)(d), z_0 cannot be a pole for both m and m^\sharp . Without loss of generality, let it be a pole for m^\sharp . By the property (P2), $m(\tilde{f}_j(\lambda_0))$ and $m^\sharp(\tilde{f}_j(\lambda_0))$ are regular for $j \neq n$. By the property (P1), $\pi(\lambda_0) \neq \Delta(\gamma_j)$ for every j . Therefore $\mathfrak{U}(\lambda_0)$ is invertible. Let $k \geq 1$ be the order of the pole of m^\sharp at z_0 . By Lemma 4.3, $\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda)$ has a pole of order k at λ_0 . Let its Smith–McMillan form (see Lemma C.1) be

$$\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda) = E(\lambda) \operatorname{diag}((\lambda - \lambda_0)^{\kappa_1}, \dots, (\lambda - \lambda_0)^{\kappa_p}) F(\lambda)$$

with $\kappa_1 \geq \kappa_2 \geq \dots \geq \kappa_p = -k$. By Lemma 4.7 (and (ii)(c)), $\det(\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda))$ has also a pole of order k . Therefore $\kappa_1 + \dots + \kappa_{p-1} = 0$. In order to get that $(\mathfrak{m}_\Delta - \mathfrak{m}_\Delta^\sharp)^{-1}$ is regular at λ_0 , we need to show that $\kappa_j \leq 0$ for all j .

Using (4.7), we can see that

$$\lim_{\lambda \rightarrow \lambda_0} (\lambda - \lambda_0)^k [\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda)]$$

has rank 1, since each matrix $[p_{j-1}(f_j(\lambda)) p_{s-1}(f_j(\lambda))]_{j,s=1}^p$ is of rank 1 and $\mathfrak{U}(\lambda_0)$ is invertible. Therefore $\kappa_{p-1} > -k$.

Assume $0 > \kappa_{p-1} > -k$. Then by Lemma C.4, there exists an analytic \mathbb{C}^p -valued function ϕ_{p-1} such that $\phi_{p-1}(\lambda_0) \neq 0$ and

$$(\lambda - \lambda_0)^{-\kappa_{p-1}} \phi_{p-1}(\lambda)^T (\mathfrak{m}_\Delta(\lambda) - \mathfrak{m}_\Delta^\sharp(\lambda)) = \psi_{p-1}(\lambda)$$

is analytic at λ_0 with $\psi_{p-1}(\lambda_0) \neq 0$. Now plug $\mathbf{m}_\Delta - \mathbf{m}_\Delta^\sharp$ from (4.7) into the last expression. We claim that, in fact,

$$\lim_{\lambda \rightarrow \lambda_0} (\lambda - \lambda_0)^{-\kappa_{p-1}} \phi_{p-1}(\lambda)^T (\mathbf{m}_\Delta(\lambda) - \mathbf{m}_\Delta^\sharp(\lambda)) = 0.$$

The reason is that $m(\tilde{f}_N(\lambda_0)) - m^\sharp(\tilde{f}_N(\lambda_0))$ has a pole of order $k > -\kappa_{p-1}$, which forces $\phi_{p-1}(\lambda_0)^T$ to be in the kernel of $[p_{j-1}(f_N(\lambda_0))p_{s-1}(f_N(\lambda_0))]_{j,s=1}^p$. But any other $m(\tilde{f}_j(\lambda_0)) - m^\sharp(\tilde{f}_j(\lambda_0))$ ($j \neq n$) is regular, so each of those terms in the sum vanishes too. Therefore we conclude $\psi_{p-1}(\lambda_0) = 0$, a contradiction.

We showed that $\kappa_{p-1} \geq 0$. Since $\kappa_1 + \dots + \kappa_{p-1} = 0$ and $\kappa_1 \geq \kappa_2 \geq \dots \geq \kappa_{p-1} \geq 0$, we obtain $\kappa_1 = \kappa_2 = \dots = \kappa_{p-1} = 0$, which implies that $(\mathbf{m}_\Delta(\lambda_0) - \mathbf{m}_\Delta^\sharp(\lambda_0))^{-1}$ is regular.

Finally we need to show that there are at most simple poles of $(\mathbf{m}_\Delta - \mathbf{m}_\Delta^\sharp)^{-1}$ at $\lambda_0 = \pi^{-1}(\pm 2)$. By (ii)(c), $m(\tilde{f}_j(\lambda_0)) - m^\sharp(\tilde{f}_j(\lambda_0))$ are zeros of order at most 1. Let k be the number of such simple zeros, and let the corresponding indices be j_1, \dots, j_k . There are no poles of m or m^\sharp at $\tilde{f}_j(\lambda_0)$ by (P1), so $m - m^\sharp$ is analytic there. Repeating the arguments of Lemma 4.6, one sees that

$$\ker \mathfrak{L}(\lambda_0) = \text{span} [\{\vec{v}_1, \dots, \vec{v}_p\} \setminus \{\vec{v}_{j_1}, \dots, \vec{v}_{j_k}\}]^\perp,$$

where $\vec{v}_j = (1, p_1(f_j(\lambda_0)), \dots, p_{p-1}(f_j(\lambda_0)))^*$. Since \vec{v}_j are linearly independent, we see that the dimension of this kernel is precisely k . Since $\det \mathfrak{L}$ has a zero of order k at λ_0 by Lemma 4.6, we conclude that its inverse has a simple pole (Lemma C.2). This establishes that \mathbf{m}_Δ satisfies (II)(C).

Finally, let us check (II)(D). Assume \mathbf{m}_Δ has a pole at $(\lambda_0)_+$ and $(\lambda_0)_-$ for some $\lambda \in \mathbb{C} \setminus [-2, 2]$. By (P1), $\lambda_0 \neq \Delta(\gamma_j)$ for any j . This implies that $\det \mathfrak{U}(\lambda_0)$ is invertible, and so the pole of $\mathbf{m}_\Delta((\lambda_0)_+)$ must have come from a pole of $m(f_j((\lambda_0)_+))$ or $m^\sharp(f_j((\lambda_0)_+))$ for some j . Similarly, the pole of $\mathbf{m}_\Delta((\lambda_0)_-)$ comes from a pole of $m(f_k((\lambda_0)_-))$ or $m^\sharp(f_k((\lambda_0)_-))$ for some k . But this violates the condition (P2).

Thus (II)(A)–(D) hold, and we are in position to apply Lemma A.1. Therefore $\Delta(\mathcal{J})$ satisfies (I), which implies (i) by Lemma B.3.

(i) \Rightarrow (ii) The condition (i) implies that (I) holds for $\Delta(\mathcal{J})$ by Lemma B.3, which in turn implies that (II)(A)–(D) hold by Lemma A.1.

(ii)(a) holds by Lemma 4.1 and analytic continuation. Indeed, for each $l, 1 \leq l \leq p$, it allows us to meromorphically extend m to the region $\tilde{f}_l(F_R) \cap \mathcal{S}_-$. Their union is of course $\pi^{-1}(E_R) \cap \mathcal{S}_-$, so the only thing we need to check is that our continuation is continuous on the boundaries of these regions, i.e., on $\pi^{-1}(\Delta^{-1}((-\infty, 2) \cup (2, \infty))) \cap \mathcal{S}_-$. Choose any z_0 there, and let $\lambda_0 = \tilde{\Delta}(z_0)$. Let us assume that z_0 lies on the boundaries of $\tilde{f}_1(F_R)$ and of $\tilde{f}_2(F_R)$. Then either

$$\lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_+) \ni \lambda \rightarrow \lambda_0} \tilde{f}_1(\lambda) = \lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_-) \ni \lambda \rightarrow \lambda_0} \tilde{f}_2(\lambda) \quad (4.26)$$

or

$$\lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_-) \ni \lambda \rightarrow \lambda_0} \tilde{f}_1(\lambda) = \lim_{\mathcal{R}_- \cap \pi^{-1}(\mathbb{C}_+) \ni \lambda \rightarrow \lambda_0} \tilde{f}_2(\lambda).$$

Without loss, let us assume it's (4.26). We need to show

$$\lim_{\mathcal{S}_- \cap \tilde{f}_1(F_R) \ni z \rightarrow z_0} m(z) = \lim_{\mathcal{S}_- \cap \tilde{f}_2(F_R) \ni z \rightarrow z_0} m(z). \quad (4.27)$$

But (4.26) implies

$$\left\{ \lim_{\mathcal{R} \cap \pi^{-1}(\mathbb{C}_+) \ni \lambda \rightarrow \lambda_0} \tilde{f}_j(\lambda) \right\}_{1 \leq j \leq p, j \neq 1} = \left\{ \lim_{\mathcal{R} \cap \pi^{-1}(\mathbb{C}_-) \ni \lambda \rightarrow \eta_-} \tilde{f}_j(\lambda) \right\}_{1 \leq j \leq p, j \neq 2}$$

Then (4.2) and the fact that $\mathcal{J} - x_j$ commute for different j 's prove (4.27). Thus we established (ii)(a).

(4.2) and (II)(B) imply (ii)(b).

Now let us show (ii)(c) and (ii)(d).

First of all, let m^0 be the Borel transform of the spectral measure of the periodic Jacobi matrix $(a_n^{(0)}, b_n^{(0)})_{n=1}^\infty$ from (i). Note that m^0 is of the form (B.1), and it is straightforward to check that it satisfies (ii)(c) and (ii)(d) on all \mathcal{S} ((d) follows from the fact that $p_{p-1}(z)$ has simple zeros).

Note also that if $m(z) = m^\sharp(z)$ (this includes the possibility of $\infty = \infty$), then we would have $m^{(n)}(z) = m^{(n)\sharp}(z)$ for every n by (A.6). But by Lemma 4.9 this would produce

$$m^0(z) = \lim_{n \rightarrow \infty} m^{(n)}(z) = \lim_{n \rightarrow \infty} m^{(n)\sharp}(z) = m^{0\sharp}(z),$$

which, as we just checked, is possible only if $z \in \pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$.

Thus m satisfies (ii)(c) and (ii)(d) with a possible exceptions of the band edges. So let us assume that $m(z) - m^\sharp(z)$ has a pole of order $k \geq 2$ at some band edge $z_0 \in \pi^{-1}(\cup_{j=1}^p \{\alpha_j, \beta_j\})$. Without loss of generality, we may assume $\tilde{\Delta}(z_0) = 2$ and $\tilde{f}_1(2) = z_0$.

For λ in a small neighborhood of 2, let us define the \mathbb{C}^p -valued function $\phi(\lambda)$ to be the unique vector of norm 1 in $\text{span}\{\tilde{v}_2(\lambda), \tilde{v}_3(\lambda), \dots, \tilde{v}_p(\lambda)\}^\perp$, where, just as in Lemma 4.6, $\tilde{v}_j(\lambda) = (1, p_1(f_j(\lambda)), \dots, p_{p-1}(f_j(\lambda)))^*$. Indeed, for λ close to 2, this is a 1-dimensional space. Moreover, $\phi(\lambda)$ is analytic at $\lambda = 2$ (as a function on \mathcal{S}), and $\phi(2) \neq 0$.

Now consider the function $\phi(\lambda)^T \mathfrak{L}(\lambda)$ (see (4.18)). By construction, each term in the sum except $j = 1$ is identically zero for any λ . The $j = 1$ term has zero at $\lambda = 2$ of order at least $k \geq 2$ because of the factor $m(\tilde{f}_1(\lambda)) - m^\sharp(\tilde{f}_1(\lambda))$. This means that $\phi(\lambda)$ is a left null function (see Definition C.3) at $\lambda = 2$ for $\mathfrak{L}(\lambda)$ of order at least 2. But that means that one of the κ 's in the Smith–McMillan form of $\mathfrak{L}(\lambda)$ is ≥ 2 . This implies that $\mathfrak{L}(\lambda)^{-1}$ has pole at $\lambda = 2$ of order at least 2. Then Lemma 4.3 implies that $(\mathfrak{m}_\Delta - \mathfrak{m}_\Delta^\sharp)^{-1}$ has a pole at $\lambda = 2$ of order at least 2, which contradicts (II)(C). \square

Proof of Theorem 3.2.

(i) \Rightarrow (ii) If $\mathcal{J} = (a_n, b_n)_{n=1}^\infty$ is eventually periodic, then $\Delta(\mathcal{J})$ is eventually free by the Magic Formula (Lemma B.2). Then Lemma A.2 implies that \mathfrak{m}_Δ has a meromorphic continuation to the whole surface \mathcal{R} . Lemma 4.1 allows us to extend m to the whole \mathcal{S} as well. Parts (ii)(b), (ii)(c), and (ii)(d) are already proven in the previous theorem.

(ii) \Rightarrow (i) The result is obtained by following the proof of the previous theorem, but applying Lemma A.2 instead of Lemma A.1 (note that \mathfrak{m}_Δ has meromorphic continuation to the whole surface \mathcal{R} by (ii)(a) and Lemma 4.2). \square

APPENDIX A. ORTHOGONAL POLYNOMIALS ON THE REAL LINE

We will introduce some basics of orthogonal polynomials on the real line here. We immediately start with the matrix-valued theory to avoid repetition. The scalar theory is of course a special case $p = 1$. We will mention the differences between the scalar and matrix-valued cases as we proceed.

The proofs of most of the results listed here, along with more details, can be found in the paper by Damanik–Pushnitski–Simon [5] (see also [19]).

Let μ be a $p \times p$ matrix-valued Hermitian positive semi-definite finite measure on \mathbb{R} of compact support, normalized by $\mu(\mathbb{R}) = \mathbf{1}$, where $\mathbf{1}$ is the $p \times p$ identity matrix. For any $p \times p$ dimensional matrix functions f, g , define

$$\langle\langle f, g \rangle\rangle_{L^2(\mu)} = \int f(x)^* d\mu(x) g(x);$$

where $*$ is the Hermitian conjugation (just complex conjugation if $p = 1$).

What we have defined here is the right product of f and g , as opposed to the left product $\int f(x) d\mu(x) g(x)^*$, whose properties are completely analogous.

Measure μ is called non-trivial if $\|\langle\langle f, f \rangle\rangle_{L^2(\mu)}\| > 0$ for all non-zero matrix-valued polynomials f . From now on assume μ is non-trivial. Then there exist unique (right) monic polynomials \mathbf{P}_n^R of degree n satisfying

$$\langle\langle \mathbf{P}_n^R, f \rangle\rangle_{L^2(\mu)} = 0 \quad \text{for any polynomial } f \text{ with } \deg f < n.$$

For any choice of unitary $l \times l$ matrices τ_n (we demand $\tau_0 = \mathbf{1}$), the polynomials

$$\mathbf{p}_n^R = \mathbf{P}_n^R \langle\langle \mathbf{P}_n^R, \mathbf{P}_n^R \rangle\rangle_{L^2(\mu)}^{-1/2} \tau_n \tag{A.1}$$

are orthonormal:

$$\langle\langle \mathbf{p}_n^R, \mathbf{p}_m^R \rangle\rangle_{L^2(\mu)} = \delta_{n,m} \mathbf{1},$$

where $\delta_{n,m}$ is the Kronecker δ . Using orthogonality one can show that they satisfy the (Jacobi) recurrence relation

$$x \mathbf{p}_n^R(x) = \mathbf{p}_{n+1}^R(x) A_{n+1}^* + \mathbf{p}_n^R(x) B_{n+1} + \mathbf{p}_{n-1}^R(x) A_n, \quad n = 1, 2, \dots, \tag{A.2}$$

where matrices $A_n = \langle\langle \mathbf{p}_{n-1}^R, x \mathbf{p}_n^R \rangle\rangle_{L^2(\mu)}$, $B_n = \langle\langle \mathbf{p}_{n-1}^R, x \mathbf{p}_{n-1}^R \rangle\rangle_{L^2(\mu)}$ are called the Jacobi parameters (with $\mathbf{p}_{-1}^R = \mathbf{0}$, $A_0 = \mathbf{1}$, the relation holds for $n = 0$ too).

From the above recursion, it is easily seen that the leading coefficient of $\mathbf{p}_n^R(x)$ is

$$(A_1^*)^{-1} \dots (A_n^*)^{-1}. \tag{A.3}$$

In the exact same fashion, just using the left product instead of right, one can define the left monic orthogonal polynomials \mathbf{P}_n^L and left orthonormal polynomials \mathbf{p}_n^L . It is not hard to see that $\mathbf{P}_n^L(z) = \mathbf{P}_n^R(\bar{z})^*$ and $\mathbf{p}_n^L(z) = \mathbf{p}_n^R(\bar{z})^*$.

We will be using the notation \mathbf{P}_n , \mathbf{p}_n for matrix-valued polynomials, while in the case $p = 1$ we will downgrade them to P_n , p_n . Whenever we write \mathbf{p}_n without the sup-index R or L , we will mean the right orthonormal polynomial \mathbf{p}_n^R .

Note that if $p = 1$ it is natural to choose $\tau_n = \mathbf{1}$ in (A.1). In particular this gives $p_n^R = p_n^L$, the Jacobi parameters become real, and A_n 's positive. This choice of τ_n 's is not necessarily the best if $p > 1$. Thus one has to talk about the equivalence classes of Jacobi matrices (see [5, 16]).

We can arrange sequences $\{A_n\}_{n=1}^\infty, \{B_n\}_{n=1}^\infty$ (called Jacobi parameters) into an infinite matrix

$$\mathcal{J} = \begin{pmatrix} B_1 & A_1 & \mathbf{0} & & \\ A_1^* & B_2 & A_2 & \ddots & \\ \mathbf{0} & A_2^* & B_3 & \ddots & \\ & \ddots & \ddots & \ddots & \end{pmatrix}. \quad (\text{A.4})$$

This is called a block Jacobi matrix if $p > 1$. If $p = 1$ then we lose the word ‘‘block’’ and denote the Jacobi coefficients by a_n, b_n instead of A_n, B_n .

If $A_n \equiv \mathbf{1}, B_n \equiv \mathbf{0}$ the corresponding (block) Jacobi matrix is called *free*.

Conversely, any block Jacobi matrix (A.4) with invertible $\{A_n\}_{n=1}^\infty$ gives rise to a $p \times p$ matrix-valued Hermitian measure μ via the spectral theorem. If $p = 1$ this establishes a one-to-one correspondence between all non-trivial compactly supported measures and bounded Jacobi matrices. If $p > 1$ the same holds, except now the correspondence is with the set of equivalence classes of bounded block Jacobi matrices. This has the name of Favard’s Theorem (see [5] for a proof in the matrix-valued case).

Define the Borel transform (also called the Weyl-Titchmarsh m -function) of the measure μ :

$$\mathbf{m}(z) = \int \frac{d\mu(x)}{x - z}, \quad (\text{A.5})$$

which is a matrix-valued meromorphic function in $\mathbb{C} \setminus \text{ess supp } \mu$. Again, we will use the letter m instead of \mathbf{m} if $p = 1$.

Define $\mathcal{J}^{(1)}$ to be the ‘‘once-stripped’’ Jacobi matrix with Jacobi parameters $(A_n, B_n)_{n=2}^\infty$, i.e., the Jacobi matrix of the form (A.4) with the first row and column removed. Then the following holds (the matrix-valued version is due to [1]):

$$A_1 \mathbf{m}(z; \mathcal{J}^{(1)}) A_1^* = B_1 - z - \mathbf{m}(z; \mathcal{J})^{-1}. \quad (\text{A.6})$$

As was explained in the Introduction, [17] established a connection between the rate of exponential convergence of Jacobi coefficients and meromorphic continuations of \mathbf{m} .

Denote by $\mathcal{R} = \mathcal{S}_{[-2,2]}$ the Riemann surface corresponding to $[-2, 2]$ (i.e., the hyperelliptic surface corresponding to the polynomial $z^2 - 4$). Recall Definitions 2.1 and 2.2.

Let $x(z) = z + z^{-1}$, and for any $R > 1$ let $\mathcal{R}_R = \mathcal{R}_+ \cup \pi^{-1}(F_R)$, where F_R is the interior of the bounded component of $x(R\partial\mathbb{D})$ (ellipse).

The next three lemmas are taken from the author’s [17].

Lemma A.1. *Let $\text{ess supp } \mu = [-2, 2]$ and $R > 1$. Define \mathbf{m} as in (A.5). The following are equivalent:*

(I) *The Jacobi matrix $(A_n, B_n)_{n=1}^\infty$ associated with μ satisfies*

$$\limsup_{n \rightarrow \infty} (\|B_n\| + \|\mathbf{1} - A_n A_n^*\|)^{1/2n} \leq R^{-1}.$$

(II) *All of the following holds:*

- (A) \mathbf{m} has a meromorphic continuation to \mathcal{R}_R ;
- (B) \mathbf{m} has no poles in $\pi^{-1}(-2, 2)$, and at most simple poles at $\pi^{-1}(\pm 2)$;
- (C) $(\mathbf{m} - \mathbf{m}^\sharp)^{-1}$ has no poles in $\pi^{-1}(F_R)$, except at $\pi^{-1}(\pm 2)$, where they are at most simple;

(D) If \mathbf{m} has a pole at $\lambda_0 \in \pi^{-1}(F_R) \cup \mathcal{R}_+$ and at λ_0^\sharp , then

$$\text{Ran } \text{Res}_{\lambda=\lambda_0} \mathbf{m}(\lambda) \subset \ker(\mathbf{m}(\lambda_0^\sharp) - \mathbf{m}^\sharp(\lambda_0^\sharp))^{-1},$$

$$\text{Ran } \text{Res}_{\lambda=\lambda_0} \mathbf{m}(\lambda) \subset \left(\text{Ran } (\mathbf{m}(\lambda_0^\sharp) - \mathbf{m}^\sharp(\lambda_0^\sharp))^{-1} \mathbf{m}(\lambda_0^\sharp) \right)^\perp.$$

Lemma A.2. Let $\text{ess supp } \mu = [-2, 2]$. Define \mathbf{m} as in (A.5). The following are equivalent:

(I) The Jacobi matrix $(A_n, B_n)_{n=1}^\infty$ associated with μ satisfies

$$\|B_n\| + \|\mathbf{1} - A_n A_n^*\| = \mathbf{0} \quad \text{for all large } n.$$

(II) All of the following holds:

(A) \mathbf{m} is a rational matrix function;

(B) \mathbf{m} has no poles in $\pi^{-1}(-2, 2)$, and at most simple poles at $\pi^{-1}(\pm 2)$;

(C) $(\mathbf{m} - \mathbf{m}^\sharp)^{-1}$ has no poles in \mathcal{R}_R , except at $\pi^{-1}(\pm 2)$, where they are at most simple;

(D) If \mathbf{m} has a pole at $\lambda_0 \in \mathcal{R}_+$, and at λ_0^\sharp , then

$$\text{Ran } \text{Res}_{\lambda=\lambda_0} \mathbf{m}(\lambda) \subset \ker(\mathbf{m}(\lambda_0^\sharp) - \mathbf{m}^\sharp(\lambda_0^\sharp))^{-1},$$

$$\text{Ran } \text{Res}_{\lambda=\lambda_0} \mathbf{m}(\lambda) \subset \left(\text{Ran } (\mathbf{m}(\lambda_0^\sharp) - \mathbf{m}^\sharp(\lambda_0^\sharp))^{-1} \mathbf{m}(\lambda_0^\sharp) \right)^\perp.$$

Remarks. 1. We stated these lemmas in terms of \mathbf{m} , rather than of M (see (1.5)) as it was in [17]. Note also that z_0^{-1} in [17, Thm 3.8(D)/3.9(D)] should be better thought of as \bar{z}_0^{-1} . Since the only poles of \mathbf{m} on \mathcal{R}_+ are the pure points of the spectral measure, they must be real, and so $z_0^{-1} = \bar{z}_0^{-1}$.

2. Conditions (D) of Lemmas A.1/A.2 do not look pleasant. Note however that they are trivially satisfied if no λ and λ^\sharp are both poles of \mathbf{m} . This will be enough for our purposes. One can also show that for $p = 1$, (D) is equivalent to \mathbf{m} not having simultaneous poles at λ and λ^\sharp (see [17]).

Lemma A.3. Under the conditions of one of the previous two lemmas,

$$\mathbf{m}^{(n)}(\lambda) \rightarrow \mathbf{m}^0(\lambda) \quad \text{uniformly on compacts of } \mathcal{R}_R,$$

where $\mathbf{m}^{(n)}$ is the Borel transform of the spectral measure for the n times stripped operator $\mathcal{J}^{(n)}$, and \mathbf{m}^0 is the Borel transform of the spectral measure for the free block Jacobi matrix.

Remarks. 1. In fact, $\mathbf{m}^0(\lambda) = \frac{-\lambda \pm \sqrt{\lambda^2 - 4}}{2} \mathbf{1}$.

2. Convergence on compacts of \mathcal{R}_+ (but not \mathcal{R}_R) is obvious from the convergence of the resolvents.

Let us define the second kind polynomials by

$$\mathbf{q}_n^R(z) = \int_{\mathbb{R}} d\mu(x) \frac{\mathbf{p}_n^R(z) - \mathbf{p}_n^R(x)}{z - x}, \quad n = 0, 1, \dots$$

It can be shown that \mathbf{q}_n^R are polynomials of degree $n - 1$, and that they satisfy the same recurrence relations (A.2). For future reference,

$$\mathbf{p}_0^R(z) = \mathbf{1}, \quad \mathbf{p}_1^R(z) = (z - B_1)A_1^{*-1}, \quad (\text{A.7})$$

$$\mathbf{q}_0^R(z) = \mathbf{0}, \quad \mathbf{q}_1^R(z) = A_1^{*-1}. \quad (\text{A.8})$$

Define also $\mathfrak{q}_n^L = \mathfrak{q}_n^R(\bar{z})^*$.

The resolvent of \mathcal{J} has the following block form (see [5, Thm 2.29])

$$(\mathcal{J} - z)^{-1} = \begin{pmatrix} \mathfrak{m} & \mathfrak{q}_1^R + \mathfrak{m}\mathfrak{p}_1^R & \mathfrak{q}_2^R + \mathfrak{m}\mathfrak{p}_2^R & \cdots \\ \mathfrak{q}_1^L + \mathfrak{p}_1^L\mathfrak{m} & \mathfrak{q}_1^L\mathfrak{p}_1^R + \mathfrak{p}_1^L\mathfrak{m}\mathfrak{p}_1^R & \mathfrak{p}_1^L\mathfrak{q}_2^R + \mathfrak{p}_1^L\mathfrak{m}\mathfrak{p}_2^R & \cdots \\ \mathfrak{q}_2^L + \mathfrak{p}_2^L\mathfrak{m} & \mathfrak{q}_2^L\mathfrak{p}_1^R + \mathfrak{p}_2^L\mathfrak{m}\mathfrak{p}_1^R & \mathfrak{q}_2^L\mathfrak{p}_2^R + \mathfrak{p}_2^L\mathfrak{m}\mathfrak{p}_2^R & \cdots \\ \vdots & \vdots & \vdots & \ddots \end{pmatrix} (z), \quad (\text{A.9})$$

i.e., its (i, j) -th block entry is $\mathfrak{q}_{i-1}^L\mathfrak{p}_{j-1}^R + \mathfrak{p}_{i-1}^L\mathfrak{m}\mathfrak{p}_{j-1}^R$ if $i \geq j$, and $\mathfrak{p}_{i-1}^L\mathfrak{q}_{j-1}^R + \mathfrak{p}_{i-1}^L\mathfrak{m}\mathfrak{p}_{j-1}^R$ otherwise.

APPENDIX B. PERIODIC JACOBI MATRICES

By periodic Jacobi matrices we mean the (scalar) Jacobi matrices satisfying (2.2) for some p . We already mentioned some properties of them in Section 2.2. In particular we introduced the notion of discriminant Δ of a periodic Jacobi matrix. As we already mentioned, Δ determines the essential spectrum of \mathcal{J} . Next lemma contains some further properties of \mathcal{J} and Δ .

Lemma B.1. *Let \mathcal{J} be a (one-sided) p -periodic Jacobi matrix, m the Borel transform of the spectral measure, and Δ its discriminant (2.3). Then*

- (i)
 - $\Delta^{-1}([-2, 2]) \subset \mathbb{R}$.
 - Let $x_1^\pm \leq x_2^\pm \leq \dots \leq x_p^\pm$ be the zeros (counting multiplicity) of $\Delta(\lambda) \mp 2$. Then

$$x_p^+ > x_p^- \geq x_{p-1}^- > x_{p-1}^+ \geq x_{p-2}^- > x_{p-2}^+ \geq \dots$$

- $\Delta(\lambda)$ is strictly increasing on each interval (x_{p-2j}^-, x_{p-2j}^+) and strictly decreasing on each interval $(x_{p-2j-1}^+, x_{p-2j-2}^-)$, $j = 0, 1, \dots$. In particular the $p-1$ solutions of $\Delta'(\lambda) = 0$ are all real and lie one per each gap. If a gap is open, then the corresponding solution lies in the gap's interior.

- (ii) m has a meromorphic continuation to \mathcal{S}_ϵ and its two branches are given by

$$m(z) = \frac{-\beta(z) \pm \sqrt{\beta(z)^2 - 4\alpha(z)\gamma(z)}}{2\alpha(z)}, \quad (\text{B.1})$$

where $\alpha(z) = a_p p_{p-1}(z)$, $\beta(z) = p_p(z) + a_p q_{p-1}(z)$, $\gamma(z) = q_p(z)$. Moreover,

$$\beta(z)^2 - 4\alpha(z)\gamma(z) = \Delta(z)^2 - 4.$$

There is a nice connection between the theory of periodic orthogonal polynomials and matrix-valued orthogonal polynomials. Note that applying a polynomial of degree p to the tridiagonal matrix \mathcal{J} gives us $(2p+1)$ -diagonal matrix, which can be viewed as a block Jacobi matrix with $p \times p$ matrix-valued Jacobi parameters A_n, B_n (note that A_n are lower triangular).

Let S be the right shift operator on $\ell^2(\mathbb{Z})$. Note that $S^p + S^{-p}$ is the free block Jacobi matrix with $p \times p$ block entries.

Lemma B.2 (“Magic Formula”, Damanik–Killip–Simon [4]). *Let \mathcal{J}_0 be a p -periodic Jacobi matrix with discriminant $\Delta_{\mathcal{J}_0}$ and isospectral torus \mathcal{T}_ϵ . Let \mathcal{J} be any two-sided Jacobi matrix. Then*

$$\Delta_{\mathcal{J}_0}(\mathcal{J}) = S^p + S^{-p} \iff \mathcal{J} \in \mathcal{T}_\epsilon.$$

Moreover we can “perturb” this result if all gaps are open.

Lemma B.3. *Let \mathcal{J}_0 be a p -periodic Jacobi matrix with discriminant $\Delta_{\mathcal{J}_0}$ and isospectral torus \mathcal{T}_ϵ , such that all gaps of \mathcal{J}_0 are open (every interval of ϵ has equal equilibrium measure). Let \mathcal{J} be any two-sided Jacobi matrix, and let $(A_n, B_n)_{n \in \mathbb{Z}}$ be the $p \times p$ Jacobi parameters of $\Delta_{\mathcal{J}_0}(\mathcal{J})$. Then the following are equivalent:*

- (i) $\limsup_{n \rightarrow \infty} \left(|a_n - a_n^{(0)}| + |b_n - b_n^{(0)}| \right)^{1/2n} \leq R^{-1}$, where $(a_n^{(0)}, b_n^{(0)})_{n=1}^\infty$ is a periodic Jacobi matrix from \mathcal{T}_ϵ .
- (I) $\limsup_{n \rightarrow \infty} (\|\mathbf{1} - A_n A_n^* + \|B_n\|)^{1/2n} \leq R^{-1}$.

Remark. Since both conditions depend on the behavior of the coefficients at $+\infty$, this result can also be applied to one-sided Jacobi matrices \mathcal{J} .

Proof. The proof of this lemma requires some slight modifications of the arguments of Damanik–Killip–Simon [4].

First of all, notice that there exist positive constants c_1, c_2 such that for all A in a neighborhood of $\mathbf{1}$,

$$c_1 \|\mathbf{1} - |A|\| \leq \|\mathbf{1} - AA^*\| \leq c_2 \|\mathbf{1} - |A|\|.$$

Moreover, for the lower-triangular matrices A in a neighborhood of $\mathbf{1}$, we can find positive constants \tilde{c}_1, \tilde{c}_2 so that

$$\tilde{c}_1 \|\mathbf{1} - A\| \leq \|\mathbf{1} - AA^*\| \leq \tilde{c}_2 \|\mathbf{1} - A\| \quad (\text{B.2})$$

(see [4, Prop 11.12]).

(i) \Rightarrow (I) As was shown in [4, Section 11], each $\mathbf{1} - A_n$ and B_n is a smooth function of p consecutive pairs (a_n, b_n) . Moreover, each one of them vanish on \mathcal{T}_ϵ . Therefore (i), Lipschitz property of smooth functions, and (B.2) imply (I).

(I) \Rightarrow (i) Note that $\lim_{n \rightarrow \infty} A_n A_n^* = \mathbf{1}$ implies $\lim_{n \rightarrow \infty} A_n = \mathbf{1}$ because of the fact that A_n 's are lower triangular (see [5, Thm 2.9], as well as [16]). Therefore A_n 's are in a neighborhood of $\mathbf{1}$, and so they eventually all satisfy (B.2). Therefore we may assume that

$$\limsup_{n \rightarrow \infty} \|\mathbf{1} - A_n\|_{HS}^{1/2n} \leq R^{-1}, \quad \limsup_{n \rightarrow \infty} \|B_n\|_{HS}^{1/2n} \leq R^{-1},$$

where $\|\cdot\|_{HS}$ is the Hilbert–Schmidt norm. Then following the same arguments as [4, Lemma 11.11] and then [4, Theorem 11.13(i) \Rightarrow (vi)], we obtain that

$$\limsup_{n \rightarrow \infty} d_n(\mathcal{J}, \mathcal{T}_\epsilon)^{1/2n} \leq R^{-1}, \quad (\text{B.3})$$

where $d_n(\mathcal{J}, \mathcal{T}_\epsilon) = \inf\{d_n(\mathcal{J}, \mathcal{J}_0) : \mathcal{J}_0 \in \mathcal{T}_\epsilon\}$, where

$$d_n((a_j, b_j), (a'_j, b'_j)) = \sum_{j=0}^{\infty} e^{-j} (|a_{n+j} - a'_{n+j}| + |b_{n+j} - b'_{n+j}|).$$

But this implies that there exists some $\mathcal{J}_0 \in \mathcal{T}_\epsilon$ so that (i) holds. Indeed, denote $(a_j^{(n)}, b_j^{(n)})_{j=1}^p$ to be the periodic Jacobi matrix from \mathcal{T}_ϵ that minimizes $d_n(\mathcal{J}, \mathcal{T}_\epsilon)$. Then (B.3) implies

$$\sup_{1 \leq j \leq p} |a_j^{(n)} - a_j^{(n+1)}| + \sup_{1 \leq j \leq p} |b_j^{(n)} - b_j^{(n+1)}| \leq CR^{-2n}.$$

This means that for each $j = 1, \dots, p$, the sequences $a_j^{(n)}$ and $b_j^{(n)}$ are Cauchy with respect to $n \rightarrow \infty$, and therefore have limits $a_j^{(0)}$ and $b_j^{(0)}$ respectively, to which

they converge exponentially fast. If we let $\mathcal{J}_0 = (a_j^{(0)}, b_j^{(0)})_{j=1}^p$, then (B.3) gives $\limsup_{n \rightarrow \infty} d_n(\mathcal{J}, \mathcal{J}_0)^{1/2n} \leq R^{-1}$, which implies (i). \square \square

APPENDIX C. MATRIX-VALUED FUNCTIONS

Throughout the paper, all meromorphic/analytic matrix functions are assumed to have not identically vanishing determinant.

The order of a pole of a $p \times p$ matrix-valued meromorphic function f is defined to be the minimal $k > 0$ such that $\lim_{z \rightarrow z_0} (z - z_0)^k f(z)$ is a finite non-zero matrix.

By a zero of a matrix-valued meromorphic function f we call a point at which f^{-1} has a pole.

Denote by $\delta_j \in \mathbb{C}^p$, $1 \leq j \leq p$, the column vector having 1 on the j -th position, and 0 everywhere else.

We will make use of the so-called (local) Smith–McMillan form (see, e.g., [2, Thm 3.1.1]).

Lemma C.1. *Let $f(z)$ be a $p \times p$ matrix-valued function meromorphic at z_0 with determinant not identically zero. Then $f(z)$ admits the representation*

$$f(z) = E(z) \operatorname{diag}((z - z_0)^{\kappa_1}, \dots, (z - z_0)^{\kappa_p}) F(z), \quad (\text{C.1})$$

where $E(z)$ and $F(z)$ are $p \times p$ matrix-valued functions which are analytic and invertible in a neighborhood of z_0 , and $\kappa_1 \geq \kappa_2 \geq \dots \geq \kappa_p$ are integers (positive, negative, or zero).

This immediately gives us the following corollary.

Lemma C.2. *Let u be an analytic function at z_0 such that z_0 is a zero of $\det u$ of order $k > 0$. Then $\dim \ker u(z_0) = k$ if and only if z_0 is a pole of $u(z)^{-1}$ of order 1.*

If this is the case, then

$$\ker \operatorname{Res}_{z=z_0} u(z)^{-1} = \operatorname{Ran} u(z_0),$$

$$\operatorname{Ran} \operatorname{Res}_{z=z_0} u(z)^{-1} = \ker u(z_0).$$

Proof. Both of the conditions in the if-and-only-if statement are equivalent to saying that $\kappa_1 = \dots = \kappa_k = 1$, $\kappa_{k+1} = \dots = \kappa_p = 0$ in the Smith–McMillan form of $u(z)$ at z_0 . Then note that both $\ker \operatorname{Res}_{z=z_0} u(z)^{-1}$ and $\operatorname{Ran} u(z_0)$ are equal to $E(z_0) \operatorname{span}\{\delta_{k+1}, \dots, \delta_p\}$. Similarly, both $\operatorname{Ran} \operatorname{Res}_{z=z_0} u(z)^{-1}$ and $\ker u(z_0)$ are equal to $F(z_0)^{-1} \operatorname{span}\{\delta_1, \dots, \delta_k\}$. \square \square

Definition C.3.

- (i) *An analytic \mathbb{C}^p -valued function $\phi(z)$ with $\phi(z_0) \neq 0$ is called a left null function at z_0 of order $k > 0$ for a meromorphic matrix-valued function f , if $\phi(z)^T f(z)$ is analytic at z_0 with a zero of order k at z_0 .*
- (ii) *An analytic \mathbb{C}^p -valued function $\psi(z)$ with $\psi(z_0) \neq 0$ is called a left pole function at z_0 of order $k > 0$ for a meromorphic matrix-valued function f , if there exists an analytic \mathbb{C}^p -valued function $\phi(z)$ with $\phi(z_0) \neq 0$ such that $\phi(z)^T f(z) = (z - z_0)^{-k} \psi(z)$.*

Note that ψ is a left pole function for f if and only if ψ is a left null function for f^{-1} .

The following is immediate from the definition and will prove to be useful for us.

Lemma C.4. *Let f has a local Smith–McMillan form (C.1) with $\kappa_1 \geq \dots \geq \kappa_j > 0$, $0 > \kappa_r \geq \dots \geq \kappa_p$. Then*

- (i) *Functions $(E(z)^{-1})^T \delta_1, \dots, (E(z)^{-1})^T \delta_j$ are left null functions for $f(z)$ at z_0 of orders $\kappa_1, \dots, \kappa_j$, respectively.*
- (ii) *Functions $\delta_r^T F(z), \dots, \delta_p^T F(z)$ are left pole functions for $f(z)$ at z_0 of orders $-\kappa_r, \dots, -\kappa_p$, respectively.*

APPENDIX D. HERGLOTZ FUNCTIONS

Definition D.1. *An analytic in \mathbb{C}_+ $l \times l$ matrix-valued function \mathbf{m} is called Herglotz if $\text{Im } \mathbf{m}(z) \geq \mathbf{0}$ for all $z \in \mathbb{C}_+$.*

Here $\text{Im } T \equiv \frac{T - T^*}{2i}$.

We can also define \mathbf{m} on the lower half plane \mathbb{C}_- by reflection $\mathbf{m}(z) = \mathbf{m}(\bar{z})^*$, so that $\text{Im } \mathbf{m}(z) \leq \mathbf{0}$ for all z with $\text{Im } z < 0$. In particular the function \mathbf{m} defined in (A.5) is Herglotz.

We will assume from now on that $\det \text{Im } \mathbf{m}(z)$ is not identically zero, in which case the inequality in $\text{Im } \mathbf{m}(z) \geq \mathbf{0}$ is everywhere strict (see [9, Lemma 5.3]).

The following result is well-known (see, e.g., [9, Thm 5.4]).

Lemma D.2. *Let \mathbf{m} be an $l \times l$ matrix-valued Herglotz function. Then there exist an $l \times l$ matrix-valued measure μ on \mathbb{R} satisfying $\int_{\mathbb{R}} \frac{1}{1+x^2} d\mu(x) < \infty$, and constant matrices $C = C^*, D \geq \mathbf{0}$ such that*

$$\mathbf{m}(z) = C + Dz + \int_{\mathbb{R}} \left(\frac{1}{x-z} - \frac{x}{1+x^2} \right) d\mu(x), \quad z \in \mathbb{C}_+. \quad (\text{D.1})$$

The absolutely continuous part of μ can be recovered from this representation by

$$f(x) \equiv \frac{d\mu}{dx} = \pi^{-1} \lim_{\varepsilon \downarrow 0} \text{Im } \mathbf{m}(x + i\varepsilon),$$

and the pure point part by

$$\mu(\{\lambda\}) = \lim_{\varepsilon \downarrow 0} \varepsilon \text{Im } \mathbf{m}(\lambda + i\varepsilon) = \lim_{\varepsilon \downarrow 0} \varepsilon \mathbf{m}(\lambda + i\varepsilon).$$

Let \mathbf{m} be a Herglotz function. Assume that the corresponding measure μ has $\text{ess supp } \mu = \mathfrak{e}$, a finite gap set. Denote the associated Riemann surface by \mathcal{S} . Then \mathbf{m} is meromorphic on $(\mathbb{C} \cup \{\infty\}) \setminus \mathfrak{e}$, which we identify with \mathcal{S}_+ . We are interested in conditions under which it has a continuation through the bands of \mathfrak{e} to some region of \mathcal{S}_- . The lemma below clarifies when this happens. The scalar result is due to Greenstein [10], while the matrix-valued can be found in [9].

Lemma D.3. *Let \mathbf{m} be a matrix-valued Herglotz function with representation (D.1). Then \mathbf{m} can be analytically continued from $\mathcal{S}_+ \cap \pi^{-1}(\mathbb{C}_+)$ through an interval $I \subset \mathbb{R}$ if and only if the associated measure μ is purely absolutely continuous on I , and the density $f(x) = \frac{d\mu}{dx}$ is real-analytic on I . In this case, the analytic continuation of \mathbf{m} into some domain \mathcal{D}_- of $\mathcal{S}_- \cap \pi^{-1}(\mathbb{C}_-)$ is given by*

$$\mathbf{m}(z_-) = \mathbf{m}(\bar{z}_+)^* + 2\pi i f(z), \quad z \in \pi(\mathcal{D}_-),$$

where $f(z)$ is the complex-analytic continuation of f to some $\pi(\mathcal{D}_-)$.

Thus one can view any result on the continuation of \mathbf{m} as the corresponding result on the continuation of the absolutely continuous part f of μ .
