## The derivation algebra and automorphism group of the (generalized) twisted N=2 superconformal algebra

Abstract. In this paper, we determine the derivation algebra and automorphism group of the twisted N = 2 superconformal algebra. Then we generalize the relative results to the generalized twisted N = 2 superconformal algebra in the final section.

**Key words:** the twisted N=2 superconformal algebra, derivation algebras, automorphism groups

### 1 Introduction

It is well known that the superconformal algebras are closely related the conformal field theory and the string theory and play important roles in both mathematics and physics, which were constructed in [8] and [1] independently. As for the N=2 superconformal algebras, there are four sectors: the Neveu-Schwarz sector, the Ramond sector, the topological sector and the twisted sector, all of which are closely related to the well-known Virasoro algebra and the super-Virasoro algebra. A series of results have been gained on these algebras (e.g., [2, 3, 4, 5, 6, 8, 7, 9] and the correspondingly cited references).

The twisted N=2 superconformal algebra  $\widetilde{\mathcal{L}}$  is an infinite-dimensional Lie superalgebra over the complex field  $\mathbb{C}$  with the basis  $\{L_n, T_r, G_p, \mathfrak{c} \mid n \in \mathbb{Z}, r \in \frac{1}{2} + \mathbb{Z}, p \in \frac{1}{2}\mathbb{Z}\}$ , admitting the following non-vanishing super brackets:

$$\begin{split} [L_m, L_n] &= (m-n)L_{n+m} + \frac{m^3 - m}{12} \delta_{m+n,0} \mathfrak{c}, \\ [L_m, T_r] &= -rT_{r+m}, \qquad [T_r, T_s] = \frac{r}{3} \delta_{r+s,0} \mathfrak{c}, \\ [L_m, G_p] &= \left(\frac{m}{2} - p\right) G_{p+m}, \qquad [T_r, G_p] = G_{p+r}, \\ [G_p, G_q] &= \begin{cases} (-1)^{2p} \left(2L_{p+q} + \frac{1}{3}(p^2 - \frac{1}{4})\delta_{p+q,0}\mathfrak{c}\right) & \text{if } p+q \in \mathbb{Z}, \\ (-1)^{2p+1}(p-q)T_{p+q} & \text{if } p+q \in \frac{1}{2} + \mathbb{Z}. \end{cases} \end{split}$$

Obviously,  $\widetilde{\mathcal{L}}$  is  $\mathbb{Z}_2$ -graded:  $\widetilde{\mathcal{L}} = \widetilde{\mathcal{L}}_{\overline{0}} \oplus \widetilde{\mathcal{L}}_{\overline{1}}$ , with

$$\widetilde{\mathcal{L}}_{\overline{0}} = \operatorname{span}_{\mathbb{C}} \{ L_m, \, T_r, \, \mathfrak{c} \, | \, m \in \mathbb{Z}, \, r \in \frac{1}{2} + \mathbb{Z} \}, \quad \widetilde{\mathcal{L}}_{\overline{1}} = \operatorname{span}_{\mathbb{C}} \{ G_p \, | \, p \in \frac{1}{2} \mathbb{Z} \},$$

and the Cartan subalgebra  $\mathcal{H} = \mathbb{C}L_0 + \mathbb{C}\mathfrak{c}$ . One can easily see that  $\widetilde{\mathcal{L}}$  contains the wellknown Virasoro algebra  $\mathcal{V}ir = \operatorname{span}_{\mathbb{C}}\{L_n, \mathfrak{c} \mid n \in \mathbb{Z}\}$ , the super-Virasoro algebras  $\mathcal{NS}$  (the N = 1 Neveu-Schwarz algebra) spanned by  $\{L_n, G_r, \mathfrak{c} \mid n \in \mathbb{Z}, r \in \frac{1}{2} + \mathbb{Z}\}$ , and  $\mathcal{R}$  (the N = 1Ramond algebra) spanned by  $\{L_n, G_n, \mathfrak{c} \mid n \in \mathbb{Z}\}$ .

First we recall some definitions and notations. Let  $\mathfrak{g} = \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_{\bar{1}}$  be a Lie superalgebra over  $\mathbb{C}$ . All elements below are assumed to be  $\mathbb{Z}_2$ -homogeneous, where  $\mathbb{Z}_2 = \{\bar{0}, \bar{1}\}$ . For  $x \in \mathfrak{g}$ , we always denote  $[x] \in \mathbb{Z}_2$  to be its *parity*, i.e.,  $x \in \mathfrak{g}_{[x]}$ . A  $\mathbb{Z}_2$ -homogenous linear map  $\mathfrak{d} : \mathfrak{g} \to \mathfrak{g}$  such that there exists  $[\mathfrak{d}] \in \mathbb{Z}_2$ ,  $\mathfrak{d}(\mathfrak{g}_{\bar{i}}) \subset \mathfrak{g}_{[\bar{i}+[\mathfrak{d}]]}$  for all  $\bar{i} \in \mathbb{Z}_2$  satisfying

$$\mathfrak{d}([x,y]) = [\mathfrak{d}(x), y] + (-1)^{[\mathfrak{d}][x]}[x, \mathfrak{d}(y)] \quad \text{for } x, y \in \mathfrak{g},$$
(1.2)

is called a Lie superalgebra homogenous derivations of parity  $[\mathfrak{d}]$ . The derivation  $\mathfrak{d}$  is called even if  $[\mathfrak{d}] = \overline{\mathfrak{0}}$ , odd if  $[\mathfrak{d}] = \overline{\mathfrak{1}}$ . Denote by  $\operatorname{Der}_{\overline{i}}(\mathfrak{g})$  the set of homogenous derivations of parity  $\overline{i}$ . Then  $\operatorname{Der}(\mathfrak{g}) = \operatorname{Der}_{\overline{\mathfrak{0}}}(\mathfrak{g}) \oplus \operatorname{Der}_{\overline{\mathfrak{1}}}(\mathfrak{g})$  is the derivation algebra of  $\mathfrak{g}$ . Denote by  $\operatorname{ad}(\mathfrak{g})$  the inner derivation algebra.

It is easy to see that  $\widetilde{\mathcal{L}}$  is a  $\frac{1}{2}\mathbb{Z}$ -graded algebra:  $\widetilde{\mathcal{L}} = \bigoplus_{p \in \frac{1}{2}\mathbb{Z}} \widetilde{\mathcal{L}}_p$  where  $\widetilde{\mathcal{L}}_p = \{x \in \widetilde{\mathcal{L}} \mid [L_0, x] = -p x\}$ . Der $(\widetilde{\mathcal{L}})$  is also  $\frac{1}{2}\mathbb{Z}$ -graded: Der $(\widetilde{\mathcal{L}}) = \bigoplus_{p \in \frac{1}{2}\mathbb{Z}} \text{Der}_p(\widetilde{\mathcal{L}})$  where Der $_p(\widetilde{\mathcal{L}}) = \{d \in \text{Der}(\widetilde{\mathcal{L}}) \mid d(\widetilde{\mathcal{L}}_\alpha) \subseteq \widetilde{\mathcal{L}}_{\alpha+p}, \ \alpha \in \frac{1}{2}\mathbb{Z}\}.$ 

The result on the derivation algebra  $Der(\widetilde{\mathcal{L}})$  of the twisted N=2 superconformal algebra  $\widetilde{\mathcal{L}}$  can be formulated as the following theorem.

Theorem 1.1  $\operatorname{Der}(\widetilde{\mathcal{L}}) = \operatorname{ad}(\widetilde{\mathcal{L}}).$ 

In order to introduce the related corollary, we first present some relative notations. Firstly, let us recall some related definitions based on a Lie superalgebra  $\mathfrak{g}$ . Denote by  $\tau$  the super-twist map of  $\mathfrak{g} \otimes \mathfrak{g}$ :  $\tau(x \otimes y) = (-1)^{[x][y]} y \otimes x$  for any  $x, y \in \mathfrak{g}$  and  $\xi$  the super-cyclic map cyclically permuting the coordinates of  $\mathfrak{g}^{\otimes 3}$ :  $\xi = (\mathbf{1} \otimes \tau) \cdot (\tau \otimes \mathbf{1})$ :  $x_1 \otimes x_2 \otimes x_3 \mapsto (-1)^{[x_1]([x_2]+[x_3])} x_2 \otimes x_3 \otimes x_1$  for any  $x_i \in \mathfrak{g}$ , i = 1, 2, 3, where  $\mathbf{1}$  is the identity map of  $\mathfrak{g}$ . A Lie superalgebra is a pair  $(\mathfrak{g}, \varphi)$  consisting of a vector space  $\mathfrak{g} = \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_{\bar{1}}$  and a bilinear map  $\varphi : \mathfrak{g} \otimes \mathfrak{g} \to \mathfrak{g}$  satisfying:

 $\varphi(\mathfrak{g}_{\overline{i}},\mathfrak{g}_{\overline{j}}) \subset \mathfrak{g}_{\overline{i}+\overline{j}}, \quad \operatorname{Ker}(\mathbf{1}\otimes\mathbf{1}-\tau) \subset \operatorname{Ker}\varphi, \quad \varphi \cdot (\mathbf{1}\otimes\varphi) \cdot (\mathbf{1}\otimes\mathbf{1}\otimes\mathbf{1}+\xi+\xi^2) = 0.$ 

A Lie super-coalgebra is a pair  $(\mathfrak{g}, \Delta)$  consisting of a vector space  $\mathfrak{g} = \mathfrak{g}_{\bar{0}} \oplus \mathfrak{g}_{\bar{1}}$  and a linear map  $\Delta : \mathfrak{g} \to \mathfrak{g} \otimes \mathfrak{g}$  satisfying:

$$\Delta(\mathfrak{g}_{\bar{i}}) \subset \sum_{\bar{j} \in \mathbb{Z}_2} \mathfrak{g}_{\bar{j}} \otimes \mathfrak{g}_{\bar{i}-\bar{j}}, \quad \mathrm{Im}\,\Delta \subset \mathrm{Im}(\mathbf{1} \otimes \mathbf{1}-\tau), \quad (\mathbf{1} \otimes \mathbf{1} \otimes \mathbf{1}+\xi+\xi^2) \cdot (\mathbf{1} \otimes \Delta) \cdot \Delta = 0.$$

Now one can give the definition of a Lie super-bialgebra, which is a triple  $(\mathfrak{g}, \varphi, \Delta)$  satisfying: (i)  $(\mathfrak{g}, \varphi)$  is a Lie superalgebra, (ii)  $(\mathfrak{g}, \Delta)$  is a Lie super-coalgebra, (iii)  $\Delta \varphi(x \otimes y) = x * \Delta y - (-1)^{[x][y]}y * \Delta x$ , for any  $x, y \in \mathfrak{g}$ , where the symbol "\*" means the *adjoint diagonal action*:  $x*(\sum_{i} a_i \otimes b_i) = \sum_{i} ([x, a_i] \otimes b_i + (-1)^{[x][a_i]}a_i \otimes [x, b_i]), \forall x, a_i, b_i \in \mathfrak{g}$ , and in general  $[x, y] = \varphi(x \otimes y)$  for  $x, y \in \mathfrak{g}$ .

Denote by  $\mathfrak{U}(\mathfrak{g})$  the universal enveloping algebra of  $\mathfrak{g}$ . If  $r = \sum_{i} a_{i} \otimes b_{i} \in \mathfrak{g} \otimes \mathfrak{g}$ , then the following elements are in  $\mathfrak{U}(\mathfrak{g}) \otimes \mathfrak{U}(\mathfrak{g}) \otimes \mathfrak{U}(\mathfrak{g})$ :  $r^{12} = \sum_{i} a_{i} \otimes b_{i} \otimes \mathbf{1} = r \otimes \mathbf{1}, r^{23} =$  $\sum_{i} \mathbf{1} \otimes a_{i} \otimes b_{i} = \mathbf{1} \otimes r, r^{13} = \sum_{i} a_{i} \otimes \mathbf{1} \otimes b_{i} = (\mathbf{1} \otimes \tau)(r \otimes \mathbf{1}) = (\tau \otimes \mathbf{1})(\mathbf{1} \otimes r)$ , while the following elements are in  $\mathfrak{g} \otimes \mathfrak{g} \otimes \mathfrak{g}$ :  $[r^{12}, r^{23}] = \sum_{i,j} a_{i} \otimes [b_{i}, a_{j}] \otimes b_{j}, [r^{12}, r^{13}] = \sum_{i,j} (-1)^{[a_{j}][b_{i}]}[a_{i}, a_{j}] \otimes b_{i} \otimes b_{j},$  $[r^{13}, r^{23}] = \sum_{i,j} (-1)^{[a_{j}][b_{i}]} a_{i} \otimes a_{j} \otimes [b_{i}, b_{j}].$ 

A coboundary super-bialgebra is a quadruple  $(\mathfrak{g}, \varphi, \Delta, r)$ , where  $(\mathfrak{g}, \varphi, \Delta)$  is a Lie superbialgebra and  $r \in \operatorname{Im}(\mathbf{1} \otimes \mathbf{1} - \tau) \subset \mathfrak{g} \otimes \mathfrak{g}$  such that  $\Delta = \Delta_r$  is a coboundary of r, where  $\Delta_r(x) = (-1)^{[r][x]}x * r$  for any  $x \in \mathfrak{g}$ . Furthermore, a coboundary Lie super-bialgebra  $(\mathfrak{g}, \varphi, \Delta, r)$  is called *triangular* if it satisfies the following *classical Yang-Baxter Equation*  $c(r) := [r^{12}, r^{13}] + [r^{12}, r^{23}] + [r^{13}, r^{23}] = 0.$ 

For any  $\mathfrak{g}$ -module V, denote  $V^{\mathfrak{g}} = \{v \in V \mid \mathfrak{g}. v = 0\}$ .

The following lemma can be found in [10], which is generalized from the Lie algebra case given in [11].

**Lemma 1.2** Let  $\mathfrak{g}$  be a Lie superalgebra such that  $\mathfrak{g}^{\mathfrak{g}}$ ,  $(\mathfrak{g} \otimes \mathfrak{g})^{\mathfrak{g}}$  and  $H^{1}(\mathfrak{g}, \mathfrak{g})$  are all equal to zero. Then for any one dimensional central extension  $\widetilde{\mathfrak{g}}$  of  $\mathfrak{g}$ , there is a linear embedding from  $H^{1}(\mathfrak{g}, \mathfrak{g} \otimes \mathfrak{g})$  into  $H^{1}(\widetilde{\mathfrak{g}}, \widetilde{\mathfrak{g}} \otimes \widetilde{\mathfrak{g}})$ . In particular, if  $H^{1}(\mathfrak{g}, \mathfrak{g} \otimes \mathfrak{g}) = 0$ , then  $H^{1}(\widetilde{\mathfrak{g}}, \widetilde{\mathfrak{g}} \otimes \widetilde{\mathfrak{g}}) = 0$ .

Denote  $\widetilde{\mathcal{L}}$  with  $\mathfrak{c} = 0$  by  $\mathcal{L}$ . The following theorem is the main result of [5].

**Theorem 1.3**  $H^1(\mathcal{L}, \mathcal{L} \otimes \mathcal{L})$  and every Lie super-bialgebra structure on  $\mathcal{L}$  is coboundary triangular.

Theorem 1.1 implies  $H^1(\widetilde{\mathcal{L}}, \widetilde{\mathcal{L}}) = 0$  and  $H^1(\mathcal{L}, \mathcal{L}) = 0$ . It is not difficult to see that  $\mathcal{L}^{\mathcal{L}} = 0$  and  $(\mathcal{L} \otimes \mathcal{L})^{\mathcal{L}} = 0$ . Combining Lemma 1.2 and Theorem 1.3, we can deduce the following corollary.

**Corollary 1.4**  $H^1(\widetilde{\mathcal{L}}, \widetilde{\mathcal{L}} \otimes \widetilde{\mathcal{L}})$  and every Lie super-bialgebra structure on  $\widetilde{\mathcal{L}}$  is coboundary triangular.

Denote by  $\operatorname{Aut}(\widetilde{\mathcal{L}})$  and  $\operatorname{Inn}(\widetilde{\mathcal{L}})$  the automorphism group and inner automorphism group of  $\widetilde{\mathcal{L}}$ . For any  $\varphi \in \operatorname{Aut}(\widetilde{\mathcal{L}})$  and  $x, y \in \widetilde{\mathcal{L}}$ , we have

$$\varphi(\widetilde{\mathcal{L}}_{\bar{0}}) = \widetilde{\mathcal{L}}_{\bar{0}}, \quad \varphi(\widetilde{\mathcal{L}}_{\bar{1}}) = \widetilde{\mathcal{L}}_{\bar{1}}, \quad \varphi([x,y]) = [\varphi(x),\varphi(y)]. \tag{1.3}$$

It is easy to see that  $\operatorname{Inn}(\widetilde{\mathcal{L}})$  is generated by

 $\exp(l_0 \operatorname{ad} L_0)$  for some  $l_0 \in \mathbb{C}^*$ .

Then  $\operatorname{Inn}(\widetilde{\mathcal{L}}) \cong \mathbb{C}^*$ . For any  $n \in \mathbb{Z}_+$ , denote  $\mathbb{Z}/n\mathbb{Z}$  by  $\mathbb{Z}_n$ .

Theorem 1.5  $\operatorname{Aut}(\widetilde{\mathcal{L}}) = \operatorname{Inn}(\widetilde{\mathcal{L}}) \rtimes \mathbb{Z}_4.$ 

The following corollary follows immediately from Theorem 1.5 and  $\operatorname{Inn}(\widetilde{\mathcal{L}}) \cong \mathbb{C}^*$ .

Corollary 1.6  $\operatorname{Aut}(\widetilde{\mathcal{L}}) = \mathbb{C}^* \rtimes \mathbb{Z}_4.$ 

### 2 Proof of Theorem 1.1

Proof of Theorem 1.1 It will follow from a series of lemmas.

Lemma 2.1 
$$\operatorname{Der}_{\overline{1}}(\widetilde{\mathcal{L}}) = \operatorname{ad}_{\overline{1}}(\widetilde{\mathcal{L}}).$$

*Proof* For any  $\mathfrak{d}_p \in \operatorname{Der}_{\overline{1}}(\widetilde{\mathcal{L}}) \cap \operatorname{Der}_p(\widetilde{\mathcal{L}})$  with  $p \in \frac{1}{2}\mathbb{Z}$ , we always have  $\mathfrak{d}_p(\mathfrak{c}) = 0$ .

If  $p \in \mathbb{Z}$ , we can assume

$$\mathfrak{d}_p(L_i) = a_{p,i}G_{p+i}, \quad \mathfrak{d}_p(T_r) = b_{p,r}G_{p+r}, \\
\mathfrak{d}_p(G_q) = \begin{cases} c_{p,q}L_{p+q} + e_q\delta_{p+q,0}\mathfrak{c} & \text{if } q \in \mathbb{Z}, \\ d_{p,q}T_{p+q} & \text{if } q \in \frac{1}{2} + \mathbb{Z}, \end{cases}$$
(2.1)

where  $a_{p,i}, b_{p,r}, c_{p,q}, d_{p,q}, e_q \in \mathbb{C}$ .

According to the assumption that  $\mathfrak{d}_p$  is a derivation, we have the following identity:

$$\mathfrak{d}_p([T_r, T_s]) = [\mathfrak{d}_p(T_r), T_s] + [T_r, \mathfrak{d}_p(T_s)], \quad \forall \ r, \ s \in \frac{1}{2} + \mathbb{Z},$$

which gives

$$b_{p,r}G_{p+r+s} = b_{p,s}G_{p+r+s}.$$

Then  $b_{p,r} = b_{p,s}$  for any  $r, s \in \frac{1}{2} + \mathbb{Z}$ , which implies that  $b_{p,r}$  is a constant. For convenience, we denote

$$b_{p,r} = b_p, \quad \forall \ p \in \mathbb{Z}, \ r \in \frac{1}{2} + \mathbb{Z}.$$
 (2.2)

According to the identity  $\mathfrak{d}_p([L_i, T_r]) = [\mathfrak{d}_p(L_i), T_r] + [L_i, \mathfrak{d}_p(T_r)]$ , we obtain

$$rb_{p,r+i}G_{p+r+i} = a_{p,i}G_{p+r+i} + (p+r-\frac{i}{2})b_{p,r}G_{p+r+i}$$

Comparing the coefficients of  $G_{p+r+i}$ , one has

$$rb_{p,r+i} = a_{p,i} + (p+r-\frac{i}{2})b_{p,r+i}$$

which together with (2.2), gives

$$a_{p,i} = \left(\frac{i}{2} - p\right)b_p, \quad \forall \ p, \ i \in \mathbb{Z}.$$
(2.3)

For any  $r, q \in \frac{1}{2} + \mathbb{Z}$ , we have  $\mathfrak{d}_p([T_r, G_q]) = [\mathfrak{d}_p(T_r), G_q] + [T_r, \mathfrak{d}_p(G_q)]$ , which gives

$$c_{p,q+r}L_{p+q+r} + e_{q+r}\delta_{p+q+r,0}\mathfrak{c} - d_{p,q}\frac{r}{3}\delta_{p+q+r,0}\mathfrak{c}$$
  
=  $(-1)^{2(p+r)}b_{p,r}\left(2L_{p+q+r} + \frac{4(p+r)^2 - 1}{12}\delta_{p+q+r,0}\mathfrak{c}\right)$ 

Comparing the coefficients of  $L_{p+q+r}$  and  $\mathfrak{c}$ , one has

$$\begin{split} c_{p,q+r} &= -2b_{p,r}, \\ e_{-p} &= \frac{r}{3}d_{p,-p-r} - \frac{4(p+r)^2 - 1}{12}b_{p,r} \end{split}$$

which together with (2.2), give

$$c_{p,n} = -2b_p,\tag{2.4}$$

$$e_{-p} = \frac{r}{3}d_{p,-p-r} - \frac{4(p+r)^2 - 1}{12}b_p,$$
(2.5)

for any  $p, n \in \mathbb{Z}$  and  $r \in \frac{1}{2} + \mathbb{Z}$ .

For any  $r \in \frac{1}{2} + \mathbb{Z}$  and  $q \in \mathbb{Z}$ , the identity  $\mathfrak{d}_p([T_r, G_q]) = [\mathfrak{d}_p(T_r), G_q] + [T_r, \mathfrak{d}_p(G_q)]$  gives

$$d_{p,q+r}T_{p+q+r} = (-1)^{2(p+r)+1}(p+r-q)b_{p,r}T_{p+q+r} + rc_{p,q}T_{p+q+r}.$$

Comparing the coefficients of  $T_{p+q+r}$  and using (2.2) with (2.4), we obtain

$$d_{p,q+r} = (p - q - r)b_p,$$

which implies

$$d_{p,q} = (p-q)b_p, \quad \forall \ p \in \mathbb{Z}, \ q \in \frac{1}{2} + \mathbb{Z}.$$
(2.6)

Using (2.5) and (2.6), one can deduce

$$e_{-p} = -\frac{1}{3}(p^2 - \frac{1}{4})b_p, \quad \forall \ p \in \mathbb{Z}.$$
 (2.7)

Combing the identities given in (2.2), (2.3), (2.4), (2.6) and (2.7),  $\mathfrak{d}_p(L_i)$ ,  $\mathfrak{d}_p(T_r)$  and  $\mathfrak{d}_p(G_q)$  referred in (2.1) can be respectively rewritten as follows:

$$\mathfrak{d}_{p}(L_{i}) = (\frac{i}{2} - p)b_{p}G_{p+i}, \quad \mathfrak{d}_{p}(T_{r}) = b_{p}G_{p+r}, \quad \mathfrak{d}_{p}(\mathfrak{c}) = 0, \\
\mathfrak{d}_{p}(G_{q}) = \begin{cases}
-2b_{p}L_{p+q} - \frac{1}{3}(p^{2} - \frac{1}{4})b_{p}\delta_{p+q,0}\mathfrak{c} & \text{if } q \in \mathbb{Z}, \\
(p-q)b_{p}T_{p+q} & \text{if } q \in \frac{1}{2} + \mathbb{Z},
\end{cases}$$
(2.8)

for any  $p, i \in \mathbb{Z}, r \in \frac{1}{2} + \mathbb{Z}$  and  $q \in \frac{1}{2}\mathbb{Z}$ . Noticing

$$ad(-b_p G_p)(L_i) = (\frac{i}{2} - p)b_p G_{p+i}, \quad ad(-b_p G_p)(T_r) = b_p G_{p+r}, \quad ad(-b_p G_p)(\mathfrak{c}) = 0,$$
  
$$ad(-b_p G_p)(G_q) = \begin{cases} -2b_p L_{p+q} - \frac{1}{3}(p^2 - \frac{1}{4})b_p \delta_{p+q,0}\mathfrak{c} & \text{if } q \in \mathbb{Z}, \\ (p-q)b_p T_{p+q} & \text{if } q \in \frac{1}{2} + \mathbb{Z}, \end{cases}$$

for any  $p, i \in \mathbb{Z}, r \in \frac{1}{2} + \mathbb{Z}$  and  $q \in \frac{1}{2}\mathbb{Z}$ , we claim that

$$\mathfrak{d}_p = \mathrm{ad}(-b_p G_p), \quad \forall \ p \in \mathbb{Z}.$$

If  $p \in \frac{1}{2} + \mathbb{Z}$ , we can assume (for convenience, we still use the same notations)

where  $a_{p,i}, b_{p,r}, c_{p,q}, d_{p,q}, e_q \in \mathbb{C}$ .

Using the following two identities:

$$\begin{aligned} \boldsymbol{\mathfrak{d}}_p([L_i, T_r]) &= [\boldsymbol{\mathfrak{d}}_p(L_i), T_r] + [L_i, \boldsymbol{\mathfrak{d}}_p(T_r)], \quad \forall \ i \in \mathbb{Z}, \ r \in \frac{1}{2} + \mathbb{Z}, \\ \boldsymbol{\mathfrak{d}}_p([T_r, T_s]) &= [\boldsymbol{\mathfrak{d}}_p(T_r), T_s] + [T_r, \boldsymbol{\mathfrak{d}}_p(T_s)], \quad \forall \ r, \ s \in \frac{1}{2} + \mathbb{Z}, \end{aligned}$$

we can deduce (for convenience, we denote  $b_{p,\frac{1}{2}}$  by  $b_p$  for any  $p \in \frac{1}{2} + \mathbb{Z}$ )

$$a_{p,i} = (\frac{i}{2} - p)b_p, \quad b_{p,r} = b_p, \quad \forall \ i \in \mathbb{Z}, \ p, \ r \in \frac{1}{2} + \mathbb{Z}.$$
 (2.11)

For any  $p, q \in \frac{1}{2} + \mathbb{Z}$ , we have  $\mathfrak{d}_p([L_0, G_q]) = [\mathfrak{d}_p(L_0), G_q] + [L_0, \mathfrak{d}_p(G_q)]$ , which gives

$$(p+q)c_{p,q}L_{p+q} - q(c_{p,q}L_{p+q} + e_q\delta_{p+q,0}\mathfrak{c})$$
  
=  $a_{p,0}(-1)^{2p} \left(2L_{p+q} + \frac{1}{3}(p^2 - \frac{1}{4})\delta_{p+q,0}\mathfrak{c}\right).$ 

Comparing the coefficients of  $L_{p+q}$  and  $\mathfrak{c}$ , we have

$$qc_{p,q} = (p+q)c_{p,q} - 2pb_p,$$
  
$$pe_{-p} = \frac{1}{3}(\frac{1}{4} - p^2)a_{p,0},$$

which imply

$$c_{p,q} = 2b_p, \quad e_{-p} = \frac{1}{3}(p^2 - \frac{1}{4})b_p, \quad \forall \ p, \ q \in \frac{1}{2} + \mathbb{Z}.$$

$$ia_{p,i} = (p+i)a_{p,i} + (i-p)a_{p,0},$$
  
 $pm_{-p} = a_{p,0}\frac{p^3 - p}{12},$

which gives

$$a_{p,i} = \frac{p-i}{p}a_p, \quad m_{-p} = \frac{p^2 - 1}{12}a_p,$$
(2.16)

for any  $i \in \mathbb{Z}$  and  $p \in \mathbb{Z}^*$ , where  $a_{p,0}$  is denoted by  $a_p$  for any  $p \in \mathbb{Z}^*$ .

According to the fact that  $\mathfrak{D}_p([L_0, T_r]) = [\mathfrak{D}_p(L_0), T_r] + [L_0, \mathfrak{D}_p(T_r)]$ , we obtain

$$rb_{p,r}T_{p+r} = ra_pT_{p+r} + (p+r)b_{p,r}T_{p+r},$$

By now we have completed the proof of Theorem 1.1.

#### 3 Proof of Theorem 1.5

Proof of Theorem 1.5 For any  $i \in \mathbb{Z}^*$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$  and  $\sigma \in \operatorname{Aut}(\widetilde{\mathcal{L}})$ , we can suppose

$$\sigma(L_0) = a_0 L_0 + c_0 \mathfrak{c}, \quad \sigma(\mathfrak{c}) = m_0 \mathfrak{c},$$
  

$$\sigma(L_i) = \sum_{j \in \mathbb{Z}} a_{i,j} L_j + \sum_{s \in \frac{1}{2} + \mathbb{Z}} b_{i,s} T_s + c_i \mathfrak{c},$$
  

$$\sigma(T_r) = \sum_{j \in \mathbb{Z}} d_{r,j} L_j + \sum_{s \in \frac{1}{2} + \mathbb{Z}} e_{r,s} T_s + f_r \mathfrak{c},$$
  

$$\sigma(G_q) = \sum_{p \in \frac{1}{2} \mathbb{Z}} n_{q,p} G_p,$$
  
(3.1)

where  $a_0, m_0, a_{i,j}, b_{i,s}, c_i, d_{r,j}, e_{r,s}, f_r, n_{q,p} \in \mathbb{C}$ .

We first claim that  $a_0 \neq 0$ . Otherwise, if  $a_0 = 0$ , for any  $x \in \widetilde{\mathcal{L}}_p$  with  $p \neq 0$ , we have

$$-p\sigma(x) = [\sigma(L_0), \sigma(x)] = [c_0 \mathfrak{c}, \sigma(x)] = 0,$$

which is impossible. Thus  $a_0 \neq 0$ .

For any  $i \in \mathbb{Z}^*$ , applying  $\sigma$  on  $[L_0, L_i] = -iL_i$ , we have

$$a_0\left(\sum_{j\in\mathbb{Z}}ja_{i,j}L_j+\sum_{s\in\frac{1}{2}+\mathbb{Z}}sb_{i,s}T_s\right)=i\left(\sum_{j\in\mathbb{Z}}a_{i,j}L_j+\sum_{s\in\frac{1}{2}+\mathbb{Z}}b_{i,s}T_s+c_i\mathfrak{c}\right).$$

Comparing the coefficients of  $L_j$ ,  $T_s$  and  $\mathfrak{c}$ , we obtain

$$(a_0j - i)a_{i,j} = 0, \quad (a_0s - i)b_{i,s} = 0, \quad ic_i = 0,$$

which imply

$$a_{i,j} = b_{i,s} = c_i = 0, \quad \forall \ i \in \mathbb{Z}^*, \ j \neq \frac{i}{a_0}, \ s \neq \frac{i}{a_0}.$$
 (3.2)

Furthermore, we claim that  $a_0 \in \{\pm 1, \pm 2\}$ . Otherwise,  $\sigma(L_i)$  referred in (3.1) can be rewritten as  $\sigma(L_i) = 0$  for some  $i \in \mathbb{Z}^*$ , which is impossible. Thus  $a_0 \in \{\pm 1, \pm 2\}$ .

For any  $r \in \frac{1}{2} + \mathbb{Z}$ , applying  $\sigma$  on  $[L_0, T_r] = -rT_r$ , we have

$$a_0\left(\sum_{j\in\mathbb{Z}}jd_{r,j}L_j+\sum_{s\in\frac{1}{2}+\mathbb{Z}}se_{r,s}T_s\right)=r\left(\sum_{j\in\mathbb{Z}}d_{r,j}L_j+\sum_{s\in\frac{1}{2}+\mathbb{Z}}e_{r,s}T_s+f_r\mathfrak{c}\right).$$

Comparing the coefficients of  $L_j$ ,  $T_s$  and  $\mathfrak{c}$ , we obtain

$$(a_0j - r)d_{r,j} = 0, \quad (a_0s - r)e_{r,s} = 0, \quad rf_r = 0,$$

which imply

$$d_{r,j} = e_{r,s} = f_r = 0, \quad \forall \ r \in \frac{1}{2} + \mathbb{Z}, \ j \neq \frac{r}{a_0}, \ s \neq \frac{r}{a_0}.$$
 (3.3)

We claim that  $a_0 \notin \{\pm 2\}$ . Otherwise,  $\sigma(T_r)$  referred in (3.1) can be rewritten as  $\sigma(T_r) = 0$ for any  $r \in \frac{1}{2} + \mathbb{Z}$ , which is impossible. Thus  $a_0 \in \{\pm 1\}$ .

For any  $q \in \frac{1}{2}\mathbb{Z}$ , applying  $\sigma$  on  $[L_0, G_q] = -qG_q$ , we have

$$a_0 \sum_{p \in \frac{1}{2}\mathbb{Z}} pn_{q,p} G_p = q \sum_{p \in \frac{1}{2}\mathbb{Z}} n_{q,p} G_p.$$

Comparing the coefficients of  $G_p$ , we obtain

$$(a_0p-q)n_{q,p}=0,$$

which together with  $a_0 \in \{\pm 1\}$ , implies

$$n_{q,p} = 0, \quad \forall \ p \neq \frac{q}{a_0}. \tag{3.4}$$

Combining the identities given in (3.2), (3.3) and (3.4), we can rewrite  $\sigma(L_i)$ ,  $\sigma(T_r)$  and  $\sigma(G_q)$  referred in (3.1) as follows:

$$\sigma(L_i) = a_{i,\frac{i}{a_0}} L_{\frac{i}{a_0}}, \quad \sigma(T_r) = e_{r,\frac{r}{a_0}} T_{\frac{r}{a_0}}, \quad \sigma(G_q) = n_{q,\frac{q}{a_0}} G_{\frac{q}{a_0}}, \tag{3.5}$$

for any  $i \in \mathbb{Z}^*$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$  with  $a_0 \in \{\pm 1\}$ .

For the case  $a_0 = 1$ , using (3.5), we can write

$$\sigma(\mathbf{c}) = m_0 \mathbf{c}, \quad \sigma(L_i) = a_i L_i + c_0 \delta_{i,0} \mathbf{c},$$
  

$$\sigma(T_r) = e_r T_r, \quad \sigma(G_q) = n_q G_q,$$
(3.6)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$  and the coefficients are all in  $\mathbb{C}$ .

For any  $i, j \in \mathbb{Z}$ , applying  $\sigma$  to  $[L_i, L_j] = (i - j)L_{i+j} + \frac{i^3 - i}{12}\delta_{i+j,0}\mathfrak{c}$ , we have

$$a_{i}a_{j}(i-j)L_{i+j} + \frac{i^{3}-i}{12}\delta_{i+j,0}a_{i}a_{j}\mathfrak{c}$$
  
=  $(i-j)a_{i+j}L_{i+j} + (i-j)\delta_{i+j,0}c_{0}\mathfrak{c} + \frac{i^{3}-i}{12}\delta_{i+j,0}m_{0}\mathfrak{c}$ 

Comparing the coefficients of  $L_{i+j}$  and  $\mathfrak{c}$ , we obtain

$$(i-j)(a_{i+j}-a_ia_j) = 0,$$
  
$$\frac{i^3-i}{12}a_ia_{-i} = 2ic_0 + \frac{i^3-i}{12}m_0,$$

for any  $i, j \in \mathbb{Z}$ , from which we can deduce

$$c_0 = 0, \quad m_0 = 1, \quad a_i = a_1^i, \quad \forall \ i \in \mathbb{Z}.$$
 (3.7)

From the identity  $\sigma([T_r, T_s]) = \frac{r}{3} \delta_{r+s,0} \sigma(\mathfrak{c})$ , we can deduce

$$e_r e_{-r} = 1, \quad \forall \ r \in \frac{1}{2} + \mathbb{Z}.$$

$$(3.8)$$

Using  $\sigma([L_i, T_r]) = -r\sigma(T_{r+i})$  and recalling (3.7), we can deduce

$$e_{r+i} = e_r a_1^i, \quad \forall \ i \in \mathbb{Z}, \ r \in \frac{1}{2} + \mathbb{Z}, \tag{3.9}$$

which together with (3.8), gives

$$a_i = \beta^{2i}, \quad e_r = \beta^{2r}, \quad \forall \ i \in \mathbb{Z}, \ r \in \frac{1}{2} + \mathbb{Z},$$

$$(3.10)$$

where  $e_{\frac{1}{2}}$  is denoted by  $\beta$  for convenience and also  $\beta \neq 0$ .

By  $\sigma([G_p, G_q]) = n_p n_q [G_p, G_q]$ , we have

$$\begin{cases} n_p n_q = a_{p+q} & \text{if } p+q \in \mathbb{Z}, \\ n_p n_q = e_{p+q} & \text{if } p+q \in \frac{1}{2} + \mathbb{Z}, \end{cases}$$

which together with (3.10), give

$$n_p n_q = \beta^{2p+2q}, \quad \forall \ p, \ q \in \frac{1}{2}\mathbb{Z}.$$

Then we can deduce

$$n_q = \varepsilon \beta^{2q}, \quad \forall \ q \in \frac{1}{2}\mathbb{Z},$$

$$(3.11)$$

where  $\varepsilon^2 = 1$ . Combining (3.7), (3.9) and (3.11), we can rewrite (3.6) as follows:

$$\sigma(\mathbf{c}) = \mathbf{c}, \quad \sigma(L_i) = \beta^{2i} L_i,$$
  

$$\sigma(T_r) = \beta^{2r} T_r, \quad \sigma(G_q) = \varepsilon \beta^{2q} G_q,$$
(3.12)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$  and some  $\beta \in \mathbb{C}^*$ ,  $\varepsilon^2 = 1$ . The following identities hold:

$$\exp\left(-(\log\beta^2)\mathrm{ad}L_0\right)(\mathfrak{c}) = \mathfrak{c}, \quad \exp\left(-(\log\beta^2)\mathrm{ad}L_0\right)(L_i) = \beta^{2i}L_i,$$
  
$$\exp\left(-(\log\beta^2)\mathrm{ad}L_0\right)(T_r) = \beta^{2r}T_r, \quad \exp\left(-(\log\beta^2)\mathrm{ad}L_0\right)(G_q) = \beta^{2q}G_q,$$
(3.13)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$ .

For convenience, we introduce the following isomorphism:

$$\epsilon(\mathbf{c}) = \mathbf{c}, \quad \epsilon(L_i) = L_i,$$
  

$$\epsilon(T_r) = T_r, \quad \epsilon(G_q) = -G_q,$$
(3.14)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$ . It is easy to check that  $\epsilon^k \in \operatorname{Aut}(\widetilde{\mathcal{L}})/\operatorname{Inn}(\widetilde{\mathcal{L}})$  for any  $k \in \mathbb{Z}_2$ .

The  $\sigma$  referred in (3.12) can be rewritten as:

$$\sigma = \epsilon^k \exp\left(-(\log\beta^2) \operatorname{ad} L_0\right),\tag{3.15}$$

for some  $\beta \in \mathbb{C}^*$ ,  $k \in \mathbb{Z}_2$  and  $\epsilon$  is determined by (3.14).

For the case  $a_0 = -1$ , using (3.5), we can write

$$\sigma(\mathbf{c}) = m_0 \mathbf{c}, \quad \sigma(L_i) = a_i L_{-i} + c_0 \delta_{i,0} \mathbf{c},$$
  

$$\sigma(T_r) = e_r T_{-r}, \quad \sigma(G_q) = n_q G_{-q},$$
(3.16)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$  and the coefficients are all in  $\mathbb{C}$ . We still denote  $e_{\frac{1}{2}}$  as  $\beta$ . Repeating the corresponding process, (3.16) can be simplified as follows:

$$\sigma(\mathbf{c}) = -\mathbf{c}, \quad \sigma(L_i) = -\beta^{2i} L_{-i},$$
  

$$\sigma(T_r) = \beta^{2r} T_{-r}, \quad \sigma(G_q) = \omega \beta^{2q} G_{-q},$$
(3.17)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$  and some  $\beta \in \mathbb{C}^*$ ,  $\omega^2 = -1$ .

For convenience, we introduce the following two isomorphisms:

$$\varpi(\mathbf{c}) = -\mathbf{c}, \quad \varpi(L_i) = -L_{-i}, 
\varpi(T_r) = T_{-r}, \quad \varpi(G_q) = \sqrt{-1}G_{-q},$$
(3.18)

for any  $i \in \mathbb{Z}$ ,  $r \in \frac{1}{2} + \mathbb{Z}$ ,  $q \in \frac{1}{2}\mathbb{Z}$ . It is easy to check that  $\varpi^k \in \operatorname{Aut}(\widetilde{\mathcal{L}})/\operatorname{Inn}(\widetilde{\mathcal{L}})$  for any  $k \in \{4k+1 \mid \forall k \in \mathbb{Z}\} \cup \{4k+3 \mid \forall k \in \mathbb{Z}\}.$ 

The  $\sigma$  referred in (3.16) can be rewritten as:

$$\sigma = \varpi^k \exp\left(-(\log\beta^2) \operatorname{ad} L_0\right),\tag{3.19}$$

for some  $\beta \in \mathbb{C}^*$ ,  $k \in \{4k+1 \mid \forall k \in \mathbb{Z}\} \cup \{4k+3 \mid \forall k \in \mathbb{Z}\}$  and  $\varpi$  is determined by (3.18).

Combining (3.12), (3.15), (3.17) and (3.19), we finally arrive at the following conclusion:

$$\sigma = \varpi^k \exp\left(-(\log\beta^2) \operatorname{ad} L_0\right), \tag{3.20}$$

for some  $\beta \in \mathbb{C}^*$ ,  $k \in \mathbb{Z}_4$  and  $\varpi$  is determined by (3.18). Then this theorem follows.

#### 4 The generalized case

Let  $\mathbb{F}$  be a field of characteristic zero with the unit identity element 1,  $\Gamma$  an additive subgroup of  $\mathbb{F}$ , 0 the identity element of  $\Gamma$ , and  $s \in \mathbb{F}$  satisfying  $s \notin \Gamma$  while  $2s \in \Gamma$ . Denote  $\Gamma^* = \Gamma / \{0\}, \Gamma_s = s + \Gamma$  and  $s\Gamma = \Gamma \cup \Gamma_s$ .

The generalized twisted N = 2 superconformal algebra, denoted by  $\widetilde{\mathcal{L}}[s\Gamma]$ , is an infinitedimensional Lie superalgebra over  $\mathbb{F}$  with the basis  $\{L_{\gamma}, T_{\mu}, G_{u}, \mathfrak{c} \mid \gamma \in \Gamma, \mu \in \Gamma_{s}, u \in s\Gamma\}$ admitting the following non-vanishing super brackets:

$$\begin{split} [L_{\gamma_{1}}, L_{\gamma_{2}}] &= (\gamma_{1} - \gamma_{2})L_{\gamma_{2} + \gamma_{1}} + \frac{\gamma_{1}^{3} - \gamma_{1}}{12}\delta_{\gamma_{2} + \gamma_{1},0}\mathbf{c}, \\ [L_{\gamma}, T_{\mu}] &= -\mu T_{\mu + \gamma}, \qquad [T_{\mu_{1}}, T_{\mu_{2}}] = \frac{\mu_{1}}{3}\delta_{\mu_{2} + \mu_{1},0}\mathbf{c}, \\ [L_{\gamma}, G_{u}] &= (\frac{\gamma}{2} - u)G_{u + \gamma}, \qquad [T_{\mu}, G_{u}] = G_{u + \mu}, \\ [G_{u}, G_{v}] &= \begin{cases} 2L_{u + v} + \frac{1}{3}(u^{2} - \frac{1}{4})\delta_{u + v,0}\mathbf{c} & \text{if } u, v \in \Gamma, \\ -2L_{u + v} - \frac{1}{3}(u^{2} - \frac{1}{4})\delta_{u + v,0}\mathbf{c} & \text{if } u, v \in \Gamma_{s}, \\ (v - u)T_{u + v} & \text{if } u \in \Gamma, v \in \Gamma_{s}, \\ (u - v)T_{u + v} & \text{if } v \in \Gamma, u \in \Gamma_{s}. \end{cases} \end{split}$$

It is easy to see that  $\widetilde{\mathcal{L}}[s\Gamma]$  is  $\mathbb{Z}_2$ -graded with  $\widetilde{\mathcal{L}}[s\Gamma] = \widetilde{\mathcal{L}}[s\Gamma]_{\bar{0}} \oplus \widetilde{\mathcal{L}}[s\Gamma]_{\bar{1}}$ , where

$$\widetilde{\mathcal{L}}[s\Gamma]_{\bar{0}} = \operatorname{Span}_{\mathbb{F}}\{L_{\gamma}, T_{\mu}, \mathfrak{c} \mid \gamma \in \Gamma, \ \mu \in \Gamma_{s}\},\\ \widetilde{\mathcal{L}}[s\Gamma]_{\bar{1}} = \operatorname{Span}_{\mathbb{F}}\{G_{u} \mid u \in s\Gamma\}.$$

A  $\mathbb{Z}_2$ -homogenous linear map  $\mathfrak{D} : \widetilde{\mathcal{L}}[s\Gamma] \to \widetilde{\mathcal{L}}[s\Gamma]$  such that there exists  $[\mathfrak{D}] \in \mathbb{Z}_2$ ,  $\mathfrak{D}(\widetilde{\mathcal{L}}[s\Gamma]_{\overline{i}}) \subset \widetilde{\mathcal{L}}[s\Gamma]_{[\overline{i}+[\mathfrak{D}]]}$  for all  $\overline{i} \in \mathbb{Z}_2$  satisfying

$$\mathfrak{D}([x,y]) = [\mathfrak{D}(x), y] + (-1)^{[\mathfrak{D}][x]}[x, \mathfrak{D}(y)] \quad \text{ for } x, y \in \widetilde{\mathcal{L}}[s\Gamma],$$

is called a Lie superalgebra homogenous derivations of parity  $[\mathfrak{D}]$ . The derivation  $\mathfrak{D}$  is called even if  $[\mathfrak{D}] = \overline{0}$ , odd if  $[\mathfrak{D}] = \overline{1}$ . Denote by  $\operatorname{Der}_{\overline{i}}(\widetilde{\mathcal{L}}[s\Gamma])$  the set of homogenous derivations of parity  $\overline{i}$ . Then  $\operatorname{Der}(\widetilde{\mathcal{L}}[s\Gamma]) = \operatorname{Der}_{\overline{0}}(\widetilde{\mathcal{L}}[s\Gamma]) \oplus \operatorname{Der}_{\overline{1}}(\widetilde{\mathcal{L}}[s\Gamma])$  is the derivation algebra of  $\widetilde{\mathcal{L}}[s\Gamma]$ . Denote by  $\operatorname{ad}(\widetilde{\mathcal{L}}[s\Gamma])$  the inner derivation algebra.

It is easy to see that  $\widetilde{\mathcal{L}}[s\Gamma]$  is a  $s\Gamma$ -graded algebra:  $\widetilde{\mathcal{L}}[s\Gamma] = \bigoplus_{u \in s\Gamma} \widetilde{\mathcal{L}}[s\Gamma]_u$  where  $\widetilde{\mathcal{L}}[s\Gamma]_u = \{x \in \widetilde{\mathcal{L}}[s\Gamma] \mid [L_0, x] = -u x\}$ . Der $(\widetilde{\mathcal{L}}[s\Gamma])$  is also  $s\Gamma$ -graded: Der $(\widetilde{\mathcal{L}}[s\Gamma]) = \bigoplus_{u \in s\Gamma} \text{Der}_u(\widetilde{\mathcal{L}}[s\Gamma])$  where

$$\operatorname{Der}_{u}(\widetilde{\mathcal{L}}[s\Gamma]) = \{ d \in \operatorname{Der}(\widetilde{\mathcal{L}}[s\Gamma]) \mid d(\widetilde{\mathcal{L}}[s\Gamma]_{v}) \subseteq \widetilde{\mathcal{L}}[s\Gamma]_{v+u}, v \in s\Gamma \}.$$

The result on the derivation algebra  $\operatorname{Der}(\widetilde{\mathcal{L}}[s\Gamma])$  of the generalized twisted N=2 superconformal algebra  $\widetilde{\mathcal{L}}[s\Gamma]$  can be formulated as the following theorem, which is not difficult to be generalized from Theorem 1.1.

**Theorem 4.1**  $\operatorname{Der}(\widetilde{\mathcal{L}}[s\Gamma]) = \operatorname{ad}(\widetilde{\mathcal{L}}[s\Gamma]) \oplus \operatorname{Hom}_{\mathbb{Z}}(\Gamma, \mathbb{F}).$ 

*Proof* The following results can be obtained from Lemmas 2.1 and 2.2 without essential difference:

$$\operatorname{Der}_{\overline{1}}(\widetilde{\mathcal{L}}[s\Gamma]) = \operatorname{ad}_{\overline{1}}(\widetilde{\mathcal{L}}[s\Gamma]) \quad \text{and} \quad \mathfrak{D}_p \in \operatorname{ad}(\widetilde{\mathcal{L}}[s\Gamma]),$$

for any  $\mathfrak{D}_p \in \operatorname{Der}_{\bar{0}}(\widetilde{\mathcal{L}}[s\Gamma]) \cap \operatorname{Der}_p(\widetilde{\mathcal{L}}[s\Gamma])$  with  $0 \neq p \in s\Gamma$ .

For any  $\gamma \in \Gamma$ ,  $\mu \in \Gamma_s$  and  $u \in s\Gamma$ , we can write

$$\mathfrak{D}_0(\mathfrak{c}) = \alpha_0 \mathfrak{c}, \quad \mathfrak{D}_0(L_\gamma) = a_\gamma L_\gamma + m_\gamma \delta_{\gamma,0} \mathfrak{c}, \quad \mathfrak{D}_0(T_\mu) = b_\mu T_\mu, \quad \mathfrak{D}_0(G_u) = c_u G_u, \ (4.2)$$

where  $a_{\gamma}, b_{\mu}, c_{u}, m_{\gamma}, \alpha_{0} \in \mathbb{F}$ .

Nearly repeating the proving process of Lemma 2.3, we can obtain the following results:

$$m_{0} = \alpha_{0} = 0, \quad a_{\gamma_{1}+\gamma_{2}} = a_{\gamma_{1}} + a_{\gamma_{2}},$$
  
$$b_{-\mu} = -b_{\mu}, \quad b_{\gamma+\mu} = a_{\gamma} + b_{\mu},$$
  
$$\begin{cases} c_{u} + c_{v} = a_{u+v} & \text{if } u + v \in \Gamma, \\ c_{u} + c_{v} = b_{u+v} & \text{if } u + v \in \Gamma_{s}, \end{cases}$$

for all  $\gamma, \gamma_1, \gamma_2 \in \Gamma, \mu \in \Gamma_s$  and  $u, v \in s\Gamma$ . Furthermore, we can deduce

$$c_{\gamma} = a_{\gamma}, \quad b_{\mu} = c_{\mu} = \frac{a_{2\mu}}{2},$$

for all  $\gamma, \in \Gamma, \mu \in \Gamma_s$  and  $a_{\gamma_1+\gamma_2} = a_{\gamma_1} + a_{\gamma_2}$  for any  $\gamma_1, \gamma_2 \in \Gamma$ .

Then the identities referred in (4.2) can be rewritten as

$$\mathfrak{D}_0(L_\gamma) = a_\gamma L_\gamma, \quad \mathfrak{D}_0(T_\mu) = \frac{1}{2} a_{2\mu} T_\mu,$$
$$\mathfrak{D}_0(G_\gamma) = a_\gamma G_\gamma, \quad \mathfrak{D}_0(G_\mu) = \frac{1}{2} a_{2\mu} G_\mu, \quad \mathfrak{D}_0(\mathfrak{c}) = 0,$$

for any  $\gamma \in \Gamma$ ,  $\mu \in \Gamma_s$  and  $u \in s\Gamma$ .

For any  $\varphi \in \operatorname{Hom}_{\mathbb{Z}}(\Gamma, \mathbb{F})$ , one can define the following derivation  $\delta_{\varphi}$ :

$$\delta_{\varphi}(L_{\gamma}) = \varphi(\gamma)L_{\gamma}, \quad \delta_{\varphi}(T_{\mu}) = \frac{1}{2}\varphi(2\mu)T_{\mu},$$
  
$$\delta_{\varphi}(G_{\gamma}) = \varphi(\gamma)G_{\gamma}, \quad \delta_{\varphi}(G_{\mu}) = \frac{1}{2}\varphi(2\mu)G_{\mu}, \quad \delta_{\varphi}(\mathfrak{c}) = 0,$$

for any  $\gamma \in \Gamma$  and  $\mu \in \Gamma_s$ .

By now we have completed the proof of Theorem 4.1.

Denote by  $\operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma])$  and  $\operatorname{Inn}(\widetilde{\mathcal{L}}[s\Gamma])$  the automorphism group and inner automorphism group of  $\widetilde{\mathcal{L}}[s\Gamma]$ . For any  $\varphi \in \operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma])$  and  $x, y \in \widetilde{\mathcal{L}}[s\Gamma]$ , we have

$$\varphi(\widetilde{\mathcal{L}}[s\Gamma]_{\bar{0}}) = \widetilde{\mathcal{L}}[s\Gamma]_{\bar{0}}, \quad \varphi(\widetilde{\mathcal{L}}[s\Gamma]_{\bar{1}}) = \widetilde{\mathcal{L}}[s\Gamma]_{\bar{1}}, \quad \varphi([x,y]) = [\varphi(x),\varphi(y)].$$
(4.3)

It is easy to see that  $\operatorname{Inn}(\widetilde{\mathcal{L}}[s\Gamma])$  is generated by

 $\exp(l_0 \operatorname{ad} L_0)$  for some  $l_0 \in \mathbb{F}^*$ .

Then  $\operatorname{Inn}(\widetilde{\mathcal{L}}[s\Gamma]) \cong \mathbb{F}^*$ .

Denote by  $\mathfrak{G}$  the subgroup of  $\operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma])$ , which is generated by the automorphisms determined by (4.7) and (4.8). Then the result on the automorphism group  $\operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma])$ of the generalized twisted N = 2 superconformal algebra  $\widetilde{\mathcal{L}}[s\Gamma]$  can be formulated as the following theorem.

**Theorem 4.2** Aut $(\widetilde{\mathcal{L}}[s\Gamma]) = \operatorname{Inn}(\widetilde{\mathcal{L}}[s\Gamma]) \rtimes \mathfrak{G}.$ 

*Proof* For any  $\gamma \in \Gamma^*$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  and  $\sigma \in \operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma])$ , we can suppose

$$\sigma(L_0) = a_0 L_0 + c_0 \mathfrak{c}, \quad \sigma(\mathfrak{c}) = m_0 \mathfrak{c},$$
  

$$\sigma(L_\gamma) = \sum_{\alpha \in \Gamma} a_{\gamma,\alpha} L_\alpha + \sum_{\nu \in \Gamma_s} b_{\gamma,\nu} T_\nu + c_\gamma \mathfrak{c},$$
  

$$\sigma(T_\mu) = \sum_{\alpha \in \Gamma} d_{\mu,\alpha} L_\alpha + \sum_{\nu \in \Gamma_s} e_{\mu,\nu} T_\nu + f_\mu \mathfrak{c},$$
  

$$\sigma(G_u) = \sum_{v \in s\Gamma} n_{u,v} G_v,$$
  
(4.4)

where  $a_0, m_0, a_{\gamma,\alpha}, b_{\gamma,\nu}, c_{\gamma}, d_{\mu,\alpha}, e_{\mu,\nu}, f_{\mu}, n_{u,v} \in \mathbb{F}$ . Nearly repeating the proving process of Theorem 1.5, we can deduce

$$\begin{aligned} a_0 &\neq 0, \quad (a_0 v - u) n_{u,v} = 0, \\ (a_0 \alpha - \gamma) a_{\gamma,\alpha} &= 0, \quad (a_0 \nu - \gamma) b_{\gamma,\nu} = 0, \quad \gamma c_\gamma = 0, \\ (a_0 \alpha - \mu) d_{\mu,\alpha} &= 0, \quad (a_0 \nu - \mu) e_{\mu,\nu} = 0, \quad \mu f_\mu = 0, \end{aligned}$$

which imply

$$a_{\gamma,\alpha} = b_{\gamma,\nu} = c_{\gamma} = d_{\mu,\beta} = e_{\mu,\nu'} = f_{\mu} = n_{u,\nu} = 0$$

for any  $\gamma \in \Gamma^*$ ,  $\beta \in \Gamma$ ,  $\alpha \neq \varepsilon \gamma$ ,  $\mu, \nu \in \Gamma_s, \nu' \neq \varepsilon \mu$ ,  $\nu \neq \varepsilon u$  and  $\varepsilon \in \{\pm 1\}$ . Then we can rewrite the identities referred in (4.4) as follows:

$$\sigma(L_{\gamma}) = a_{\gamma}L_{\varepsilon\gamma}, \quad \sigma(T_{\mu}) = e_{\mu}T_{\varepsilon\mu}, \quad \sigma(G_{u}) = n_{u}G_{\varepsilon u}, \tag{4.5}$$

for any  $\gamma \in \Gamma^*$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  with  $\varepsilon \in \{\pm 1\}$ .

For the case  $\varepsilon = 1$ , using (4.5), we can write

$$\sigma(\mathbf{c}) = m_0 \mathbf{c}, \quad \sigma(L_\gamma) = a_\gamma L_\gamma + c_0 \delta_{\gamma,0} \mathbf{c},$$
  
$$\sigma(T_\mu) = e_\mu T_\mu, \quad \sigma(G_u) = n_u G_u,$$
  
(4.6)

for any  $\gamma \in \Gamma$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  and the coefficients are all in  $\mathbb{F}$ .

Nearly repeating the corresponding proving process given in Theorem 1.5, we can deduce

$$e_{\mu}e_{-\mu} = 1, \quad e_{\mu+\gamma} = e_{\mu}a_{\gamma},$$
  

$$(\gamma - \alpha)(a_{\gamma+\alpha} - a_{\gamma}a_{\alpha}) = 0,$$
  

$$\frac{\gamma^{3} - \gamma}{12}a_{\gamma}a_{-\gamma} = 2\gamma c_{0} + \frac{\gamma^{3} - \gamma}{12}m_{0},$$
  

$$\begin{cases} n_{u}n_{v} = a_{u+v} & \text{if } u+v \in \Gamma, \\ n_{u}n_{v} = e_{u+v} & \text{if } u+v \in \Gamma_{s}, \end{cases}$$

which imply

$$c_{0} = 0, \quad m_{0} = 1, \quad a_{\gamma+\alpha} = a_{\gamma}a_{\alpha},$$
$$e_{\mu}^{2} = a_{2\mu}, \quad e_{\mu+\gamma} = e_{\mu}a_{\gamma}, \quad n_{u} = \begin{cases} \varepsilon a_{u} & \text{if } u \in \Gamma, \\ \varepsilon e_{u} & \text{if } u \in \Gamma_{s}, \end{cases}$$

for all  $\alpha, \gamma \in \Gamma, \mu \in \Gamma_s$  and  $u \in s\Gamma$ . Then the identities given in (4.6) can be rewritten as follows:

$$\begin{split} \sigma(\mathbf{c}) &= \mathbf{c}, \ \ \sigma(L_{\gamma}) = a_{\gamma}L_{\gamma}, \ \ \sigma(T_{\mu}) = e_{\mu}T_{\mu}, \\ \sigma(G_u) &= \begin{cases} \varepsilon a_u G_u & \text{if} \ \ u \in \Gamma, \\ \varepsilon e_u G_u & \text{if} \ \ u \in \Gamma_s, \end{cases} \end{split}$$

for any  $\gamma \in \Gamma$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  and  $\varepsilon^2 = 1$ ,  $a_{\gamma+\alpha} = a_{\gamma}a_{\alpha}$ ,  $e_{\mu}^2 = a_{2\mu}$ ,  $e_{\mu+\gamma} = e_{\mu}a_{\gamma}$ .

For the case  $\varepsilon = -1$ , the identities given in (4.4) and (4.6) can be rewritten as follows:

$$\sigma(\mathbf{c}) = -\mathbf{c}, \ \sigma(L_{\gamma}) = a_{\gamma}L_{-\gamma}, \ \sigma(T_{\mu}) = e_{\mu}T_{-\mu},$$
$$\sigma(G_u) = \begin{cases} -\omega a_u G_{-u} & \text{if } u \in \Gamma, \\ \omega e_u G_{-u} & \text{if } u \in \Gamma_s, \end{cases}$$

for any  $\gamma \in \Gamma$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  and  $\omega^2 = -1$ ,  $a_{\gamma+\alpha} = -a_{\gamma}a_{\alpha}$ ,  $e_{\mu}^2 = -a_{2\mu}$ ,  $e_{\mu+\gamma} = -e_{\mu}a_{\gamma}$ .

For convenience, we introduce the following notation:

$$\omega_{\varepsilon}^{u} = \begin{cases} \varepsilon & \text{if } \varepsilon = 1, \ u \in s\Gamma, \\ -\omega & \text{if } \varepsilon = -1, \ u \in \Gamma, \\ \omega & \text{if } \varepsilon = -1, \ u \in \Gamma_{s}, \end{cases}$$

where  $\varepsilon^2 = 1$  and  $\omega^2 = -1$ .

Then for any  $\gamma \in \Gamma^*$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  and  $\sigma \in \operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma])$ , the identities given in (4.4) can be rewritten as follows:

$$\sigma(\mathbf{c}) = \varepsilon \mathbf{c}, \quad \sigma(L_{\gamma}) = a_{\gamma} L_{\varepsilon \gamma}, \quad \sigma(T_{\mu}) = e_{\mu} T_{\varepsilon \mu},$$
  
$$\sigma(G_{u}) = \begin{cases} \omega_{\varepsilon}^{u} a_{u} G_{\varepsilon u} & \text{if } u \in \Gamma, \\ \omega_{\varepsilon}^{u} e_{u} G_{\varepsilon u} & \text{if } u \in \Gamma_{s}, \end{cases}$$
(4.7)

for any  $\gamma \in \Gamma$ ,  $\mu \in \Gamma_s$ ,  $u \in s\Gamma$  and

$$a_{\gamma+\alpha} = \varepsilon a_{\gamma} a_{\alpha}, \quad e_{\mu}^2 = \varepsilon a_{2\mu}, \quad e_{\mu+\gamma} = \varepsilon e_{\mu} a_{\gamma}.$$
 (4.8)

Then this theorem follows.

The following corollary follows immediately from Theorem 4.2 and  $\operatorname{Inn}(\widetilde{\mathcal{L}}[s\Gamma]) \cong \mathbb{F}^*$ .

Corollary 4.3  $\operatorname{Aut}(\widetilde{\mathcal{L}}[s\Gamma]) = \mathbb{F}^* \rtimes \mathfrak{G}.$
