# ON THE RELATIVE COHEN-MACAULAY MODULES

ABSTRACT. Let R be a commutative Noetherian local ring and let  $\mathfrak{a}$  be a proper ideal of R. In this paper, as a main result, it is shown that if M is a Gorenstein R-module with  $c = \operatorname{ht}_{M}\mathfrak{a}$ , then  $\operatorname{H}^{i}_{\mathfrak{a}}(M) = 0$  for all  $i \neq c$  is completely encoded in homological properties of  $\operatorname{H}^{c}_{\mathfrak{a}}(M)$ , in particular in its Bass numbers. Notice that, this result provides a generalization of a result of Hellus and Schenzel which has been proved before, as a main result, in the case where M = R.

#### 1. Introduction

Throughout this paper, R is a commutative Noetherian ring,  $\mathfrak a$  is a proper ideal of R and M is an R-module. For a prime ideal  $\mathfrak p$  of R, the residue class field  $R_{\mathfrak p}/\mathfrak p R_{\mathfrak p}$  is denoted by  $k(\mathfrak p)$ . For each non-negative integer i, let  $\mathrm{H}^i_{\mathfrak a}(M)$  denotes the i-th local cohomology module of M with respect to  $\mathfrak a$ ; see [1] for its definition and basic results. A Gorenstein module over a local ring R is a maximal Cohen-Macaulay module of finite injective dimension. This concept was introduced by Sharp in [7] and studied extensively by him and other authors. In the present paper, we will use the concept of relative Cohen-Macaulay modules which is a generalization of the concept of Cohen-Macaulay modules. This kind of modules has been studied in [3] under the title of cohomologically complete intersections and continued in [5]. In [3] Hellus and Schenzel, as a main result, showed that if  $(R, \mathfrak m, k)$  is a Gorenstein local ring and  $\mathfrak a$  is an ideal of R with ht  $R\mathfrak a = c$  and  $\dim R/\mathfrak a = d$  such that R is relative Cohen-Macaulay in  $V(\mathfrak a) \setminus \{\mathfrak m\}$ , then the following statements are equivalent.

- (i)  $H^i_{\mathfrak{a}}(R) = 0$  for all  $i \neq c$ , i.e R is relative Cohen-Macaulay with respect to  $\mathfrak{a}$ .
- (ii)  $\mathrm{H}^d_\mathfrak{m}(\mathrm{H}^c_\mathfrak{a}(R)) \cong \mathrm{E}_R(k)$  and  $\mathrm{H}^i_\mathfrak{m}(\mathrm{H}^c_\mathfrak{a}(R)) = 0$  for all  $i \neq d$ .
- (iii)  $\operatorname{Ext}_{R}^{d}(k, \operatorname{H}_{\mathfrak{g}}^{c}(R)) \cong k$  and  $\operatorname{Ext}_{R}^{i}(k, \operatorname{H}_{\mathfrak{g}}^{c}(R)) = 0$  for all  $i \neq d$ .
- (iv)  $\mu^i(\mathfrak{m}, H^c_{\mathfrak{g}}(R)) = \delta_{di}$ .

Moreover, if  $\mathfrak{a}$  satisfies the above conditions, it follows that  $\hat{R}^{\mathfrak{a}} \cong \mathsf{Hom}_{R}(\mathsf{H}^{c}_{\mathfrak{a}}(R), \mathsf{H}^{c}_{\mathfrak{a}}(R))$  and  $\mathsf{Ext}^{i}_{R}(\mathsf{H}^{c}_{\mathfrak{a}}(R), \mathsf{H}^{c}_{\mathfrak{a}}(R)) = 0$  for all  $i \neq 0$ , where  $\hat{R}^{\mathfrak{a}}$  denotes the  $\mathfrak{a}$ -adic completion of R.

As a main result, in Theorem 2.9, we generalize the above result for a Gorenstein R-module M. Indeed, it is shown that if M is a Gorenstein R-module with  $c = \operatorname{ht}_M \mathfrak{a}$  and  $d = \dim M/\mathfrak{a}M$  such that M is relative Cohen-Macaulay in  $\operatorname{Supp}_R(M/\mathfrak{a}M) \setminus \{\mathfrak{m}\}$ , then the following statements are equivalent.

- (i)  $H^i_{\mathfrak{a}}(M) = 0$  for all  $i \neq c$ , i.e M is relative Cohen-Macaulay with respect to  $\mathfrak{a}$ .
- (ii)  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)) \cong \mathrm{E}_R(k)^{r(M)}$  and  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)) = 0$  for all  $i \neq d$ .
- (iii)  $\operatorname{Ext}_R^d(k, \operatorname{H}_{\mathfrak{a}}^c(M)) \cong k^{r(M)}$  and  $\operatorname{Ext}_R^i(k, \operatorname{H}_{\mathfrak{a}}^c(M)) = 0$  for all  $i \neq d$ .
- (iv)  $\mu^i(\mathfrak{m}, H^c_{\mathfrak{g}}(M)) = r(M)\delta_{di}$ .

Moreover, if  $\mathfrak{a}$  satisfies the above conditions, it follows that  $\operatorname{\mathsf{Hom}}_R(M,M)\otimes_R \hat{R}^{\mathfrak{a}}\cong \operatorname{\mathsf{Hom}}_R(\operatorname{\mathsf{H}}^c_{\mathfrak{a}}(M),\operatorname{\mathsf{H}}^c_{\mathfrak{a}}(M))$  and  $\operatorname{\mathsf{Ext}}^i_R(\operatorname{\mathsf{H}}^c_{\mathfrak{a}}(M),\operatorname{\mathsf{H}}^c_{\mathfrak{a}}(M))=0$  for all  $i\neq 0$ , where r(M) denotes the type of M.

### 2. Main results

**Definition 2.1.** We say that a finitely generated R-module M is relative Cohen Macaulay with respect to  $\mathfrak{a}$  if there is precisely one non-vanishing local cohomology module of M with respect to  $\mathfrak{a}$ . Clearly this is the case if and only if grade  $(\mathfrak{a}, M) = \operatorname{cd}(\mathfrak{a}, M)$ , where  $\operatorname{cd}(\mathfrak{a}, M)$  denotes the cohomological dimension of M with respect to  $\mathfrak{a}$ , which is the largest integer i for which  $\operatorname{H}^i_{\mathfrak{a}}(M) \neq 0$ . Observe that the notion of relative Cohen-Macaulay module is connected with the notion of cohomologically complete intersection ideal which has been studied in [3].

**Remark 2.2.** Let M be a relative Cohen-Macaulay module with respect to  $\mathfrak a$  and let  $\mathsf{cd}(\mathfrak a, M) = n$ . Then, in view of [1, Theorems 6.1.4, 4.2.1, 4.3.2], it is easy to see that  $\mathrm{Supp}\, H^n_{\mathfrak a}(M) = \mathrm{Supp}(M/\mathfrak a M)$  and  $\mathrm{ht}_M \mathfrak a = \mathrm{grade}\,(\mathfrak a, M)$ , where  $\mathrm{ht}_M \mathfrak a = \inf\{\, \dim_{R_\mathfrak p} M_{\mathfrak p} | \, \mathfrak p \in \mathrm{Supp}(M/\mathfrak a M) \,\}$ .

**Definition 2.3.** ( See [7, Theorem 3.11].) A non-zero finitely generated module M over a local ring  $(R, \mathfrak{m})$  is said to be a Gorenstein R-module if the following equalities hold true

$$\operatorname{depth} M = \operatorname{dim} M = \operatorname{id}_R M = \operatorname{dim} R.$$

**Definition 2.4.** For any prime ideal  $\mathfrak{p}$  of R, the i-th Bass number of M with respect to  $\mathfrak{p}$  is defined by  $\mu^i(\mathfrak{p}, M) := \operatorname{vdim}_{k(\mathfrak{p})} \operatorname{Ext}_{R_{\mathfrak{p}}}^i(k(\mathfrak{p}), M_{\mathfrak{p}})$ . If  $(R, \mathfrak{m})$  is local and M is finitely generated of depth t, then the number  $\mu^t(\mathfrak{m}, M)$  is called type of M and is denoted by r(M).

Let M be a non-zero finitely generated module over a local ring  $(R, \mathfrak{m})$  and let  $\mathfrak{a}$  be an ideal of R. Let  $E_R(M)$  be a minimal injective resolution for M. It is a well-known fact that  $E_R(M)^i = \bigoplus_{\mathfrak{p} \in \operatorname{Spec}(R)} \mu^i(\mathfrak{p}, M) E_R(R/\mathfrak{p})$ , where  $E_R(R/\mathfrak{p})$  denotes the injective hull of  $R/\mathfrak{p}$ . Now, let  $c = \operatorname{grade}(\mathfrak{a}, M)$ . Then,  $\Gamma_{\mathfrak{a}}(E_R(M)^i) = 0$  for all

i < c. Therefore  $\mathrm{H}^c_{\mathfrak{a}}(M) = \ker(\Gamma_{\mathfrak{a}}(\mathrm{E}_R^i(M))^c \longrightarrow \Gamma_{\mathfrak{a}}(\mathrm{E}_R^i(M))^{c+1})$ . This observation provides an embedding  $0 \longrightarrow \mathrm{H}^c_{\mathfrak{a}}(M)[-c] \longrightarrow \Gamma_{\mathfrak{a}}(\mathrm{E}_R^i(M))$  of complexes of R-modules where  $\mathrm{H}^c_{\mathfrak{a}}(M)[-c]$  is considered as a complex concentrated in homological degree zero.

**Definition 2.5.** (See [4, Definition 4.1].) The cokernel of the embedding

$$0 \longrightarrow \mathrm{H}^{c}_{\mathfrak{a}}(M)[-c] \longrightarrow \Gamma_{\mathfrak{a}}(\mathrm{E}_{R}(M))$$

is denoted by  $C_M(\mathfrak{a})$  and is called the truncation complex. Therefore, there is a short exact sequence

$$0 \longrightarrow \mathrm{H}^{c}_{\mathfrak{a}}(M)[-c] \longrightarrow \Gamma_{\mathfrak{a}}(\mathrm{E}_{R}(M)) \longrightarrow C_{M}(\mathfrak{a}) \longrightarrow 0$$

of complexes of R-modules. We observe that  $\mathrm{H}^i(C_M(\mathfrak{a})) \cong \mathrm{H}^i_{\mathfrak{a}}(M)$  for all i > c while  $\mathrm{H}^i(C_M(\mathfrak{a})) = 0$  for all  $i \leq c$ .

The following proposition is of assistance in the proof of the main result.

**Proposition 2.6.** Assume that M is a Gorenstein module over a local ring R. Then, with the previous notation the following statements are true.

(i) There is an exact sequence

$$0 \to \operatorname{Ext}_R^0(C_M^{\textstyle{\boldsymbol{\cdot}}}(\mathfrak{a}), M) \to \operatorname{Hom}_R(M, M) \otimes_R \hat{R}^{\mathfrak{a}} \to \operatorname{Ext}_R^c(\operatorname{H}^c_{\mathfrak{a}}(M), M) \to \operatorname{Ext}_R^1(C_M^{\textstyle{\boldsymbol{\cdot}}}(\mathfrak{a}), M) \to 0.$$

- (ii) There are isomorphisms  $\operatorname{Ext}_R^{i+c}(\operatorname{H}^c_{\mathfrak a}(M),M)\cong \operatorname{Ext}_R^{i+1}(C_M(\mathfrak a),M)$  for all i>0.
- (iii) Suppose that M is relative Cohen-Macaulay with respect to  $\mathfrak{a}$ . Then  $\operatorname{Ext}_R^c(\operatorname{H}^c_{\mathfrak{a}}(M),M)\cong\operatorname{Hom}_R(M,M)\otimes_R\hat{R}^{\mathfrak{a}}$  and  $\operatorname{Ext}_R^{i+c}(\operatorname{H}^c_{\mathfrak{a}}(M),M)=0$  for all  $i\neq 0$ .

Proof. We first notice that, since M is Gorenstein, R is Cohen-Macaulay and  $\hat{M}$  is a Gorenstein  $\hat{R}$ -module. Now, let  $\omega_{\hat{R}}$  be a canonical module of the ring  $\hat{R}$ . Then, in view of [2, Exercise 3.3.28],  $\hat{M}$  is isomorphic to a direct sum of finitely many copies of  $\omega_{\hat{R}}$ . Hence, one can use [2, Theorem 3.3.10(c)], [2, Theorem 3.3.4(d)] and the fact that  $\operatorname{Ext}_{\hat{R}}^i(\hat{M},\hat{M}) \cong \operatorname{Ext}_R^i(M,M) \otimes_R \hat{R}$  for all i, to see that  $\operatorname{Ext}_R^i(M,M) = 0$  for all i > 0 and that  $\operatorname{Hom}_R(M,M)$  is a flat R-module.

(i): Let  $E^{\cdot}$  be a minimal injective resolution for M. Then, since  $E^{\cdot}$  is a bounded complex of injective R-modules, by applying the functor  $\mathsf{Hom}_R(-,E^{\cdot})$  on the exact sequence of R-complexes in 2.5 we obtain the following short exact sequence of complexes

$$0 \longrightarrow \operatorname{Hom}_{R}(C_{M}(\mathfrak{a}), E^{\cdot}) \longrightarrow \operatorname{Hom}_{R}(\Gamma_{\mathfrak{a}}(E^{\cdot}), E^{\cdot}) \longrightarrow \operatorname{Hom}_{R}(\operatorname{H}^{c}_{\mathfrak{a}}(M), E^{\cdot})[c] \longrightarrow 0.$$

Now, let  $\underline{\mathbf{x}} = x_1, \ldots, x_n$  be a generating set of the ideal  $\mathfrak{a}$ , and let  $\check{C}_{\underline{\mathbf{x}}}(R)$  be the  $\check{C}$ ech complex of R with respect to  $\underline{\mathbf{x}}$ . Then, in view of [6, Theorem 1.1], there exists an isomorphism  $\mathbf{R}\Gamma_{\mathfrak{a}}(M) \simeq \check{C}_{\underline{\mathbf{x}}}(R) \otimes_{R}^{\mathbf{L}} M$  in the derived category. Now, since  $\mathrm{Ext}_{R}^{i}(M,M) = 0$  for all i > 0, we see that  $\mathrm{Hom}_{R}(M,M) \simeq \mathbf{R} \, \mathrm{Hom}_{R}(M,M)$ . Thus, we get the following isomorphisms

$$\begin{split} \mathbf{R} \operatorname{Hom}_R(\mathbf{R}\Gamma_{\mathfrak{a}}(M), M) &\simeq \mathbf{R} \operatorname{Hom}_R((\check{C}_{\underline{\mathbf{X}}}(R) \otimes_R^{\mathbf{L}} M), M) \\ &\simeq \mathbf{R} \operatorname{Hom}_R(\check{C}_{\underline{\mathbf{X}}}(R), \mathbf{R} \operatorname{Hom}_R(M, M)) \\ &\simeq \mathbf{R} \operatorname{Hom}_R(\check{C}_{\mathbf{X}}(R), \operatorname{Hom}_R(M, M)), \end{split}$$

in the derived category. Now, since  $\operatorname{\mathsf{Hom}}_R(M,M)$  is flat, one can use [6, Theorem 1.1] and the above isomorphisms to deduce that  $\operatorname{H}^i(\mathbf{R}\operatorname{\mathsf{Hom}}_R(\mathbf{R}\Gamma_{\mathfrak{a}}(M),M)=0$  for all  $i\neq 0$  and that  $\operatorname{H}^0(\operatorname{\mathsf{Hom}}_R(\Gamma_{\mathfrak{a}}(E^{\cdot}),E^{\cdot}))\cong \operatorname{\mathsf{Hom}}_R(M,M)\otimes_R\hat{R}^{\mathfrak{a}}$ . On the other hand, since  $\Gamma_{\mathfrak{a}}((E^{\cdot})^i)=0$  for all  $i< c=\operatorname{\mathsf{grade}}(\mathfrak{a},M)$  and  $\operatorname{\mathsf{Hom}}_R(N,X)=\operatorname{\mathsf{Hom}}_R(N,\Gamma_{\mathfrak{a}}(X))$  for any  $\mathfrak{a}$ -torsion R-module N and for all R-modules X, one can deduce that  $\operatorname{\mathsf{Ext}}^i_R(\operatorname{\mathsf{H}}^c_{\mathfrak{a}}(M),M)=0$  for all i< c. Therefore, with the aid of the above considerations, the induced long exact cohomology sequence of the above exact sequence of complexes provides the statements (i) and (ii) of the claim.

(iii): Assume that M is relative Cohen-Macaulay with respect to  $\mathfrak{a}$ . Then, one can easily check that the complex  $C_M^i(\mathfrak{a})$  is exact; and so the complex  $\operatorname{Hom}_R(C_M^i(\mathfrak{a}), E^i)$  is also exact. Therefore,  $\operatorname{Ext}_R^i(C_M^i(\mathfrak{a}), M) = \operatorname{H}^i(\operatorname{Hom}_R(C_M^i(\mathfrak{a}), E^i)) = 0$  for all i. Hence, the assertion follows from (i) and (ii).

The following lemma and definition are needed in the proof of the next result.

**Lemma 2.7.** (See [3, Proposition 4.1].) Let n be a non-negative integer and let M be an arbitrarily R-module over a local ring  $(R, \mathfrak{m})$ . Then the following conditions are equivalent.

- (i)  $H_{\mathfrak{m}}^{i}(M) = 0$  for all i < n.
- (ii)  $\operatorname{Ext}_R^i(R/\mathfrak{m}, M) = 0$  for all i < n.

**Definition 2.8.** Let  $(R, \mathfrak{m})$  be a local ring and let  $\mathfrak{a}$  be a proper ideal of R. Then, we say that a non-zero R-module M is relative Cohen-Macaulay in  $\operatorname{Supp}_R(M/\mathfrak{a}M)\setminus\{\mathfrak{m}\}$ , whenever  $M_{\mathfrak{p}}$  is relative Cohen-Macaulay with respect to  $\mathfrak{a}R_{\mathfrak{p}}$  and  $\operatorname{cd}(\mathfrak{a}R_{\mathfrak{p}}, M_{\mathfrak{p}}) = c$  for all  $\mathfrak{p} \in \operatorname{Supp}_R(M/\mathfrak{a}M)\setminus\{\mathfrak{m}\}$ , where  $c=\operatorname{ht}_M\mathfrak{a}$ .

The following theorem extends the main result [3, Theorem 0.1].

**Theorem 2.9.** Let  $\mathfrak{a}$  be an ideal of a local ring  $(R, \mathfrak{m}, k)$  and M a Gorenstein R-module. Suppose that M is relative Cohen-Macaulay in  $\operatorname{Supp}_R(M/\mathfrak{a}M) \setminus \{\mathfrak{m}\}$ . Set  $c := \operatorname{ht}_M \mathfrak{a}$  and  $d := \dim M/\mathfrak{a}M$ . Then the following statements are equivalent.

(i)  $H^i_{\mathfrak{a}}(M) = 0$  for all  $i \neq c$ , i.e M is relative Cohen-Macaulay with respect to  $\mathfrak{a}$ .

- (ii)  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{q}}(M)) \cong \mathrm{E}_R(k)^{r(M)}$  and  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{q}}(M)) = 0$  for all  $i \neq d$ .
- (iii)  $\operatorname{Ext}_{R}^{d}(k, \operatorname{H}_{\mathfrak{g}}^{c}(M)) \cong k^{r(M)}$  and  $\operatorname{Ext}_{R}^{i}(k, \operatorname{H}_{\mathfrak{g}}^{c}(M)) = 0$  for all  $i \neq d$ .
- (iv)  $\mu^i(\mathfrak{m}, H^c_{\mathfrak{q}}(M)) = r(M)\delta_{di}$ .

Moreover, if one of the above statements holds, then  $\operatorname{Ext}_R^i(\operatorname{H}^c_{\mathfrak{a}}(M), \operatorname{H}^c_{\mathfrak{a}}(M)) = 0$  for all  $i \neq 0$  and  $\operatorname{Hom}_R(\operatorname{H}^c_{\mathfrak{a}}(M), \operatorname{H}^c_{\mathfrak{a}}(M)) \cong \operatorname{Hom}_R(M, M) \otimes_R \hat{R}^{\mathfrak{a}}$ , where  $\hat{R}^{\mathfrak{a}}$  denotes the  $\mathfrak{a}$ -adic completion of R.

*Proof.* (i) $\Rightarrow$ (ii): First, we can use [5, Proposition 2.8] and the assumption to see that  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)) \cong \mathrm{H}^{i+c}_{\mathfrak{m}}(M)$  for all  $i \geq 0$ . Now, since M is Cohen-Macaulay of dimension n,  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)) \cong \mathrm{H}^n_{\mathfrak{m}}(M)$  and  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)) = 0$  for all  $i \neq d$ . On the other hand, in view of [5, Theorem 2.5] and the assumption,  $\mathrm{H}^n_{\mathfrak{m}}(M)$  is an injective R-module. Therefore, one can use [5, Corollay 2.2] to achieve the isomorphism  $\mathrm{H}^n_{\mathfrak{m}}(M) \cong \mathrm{E}_R(k)^{r(M)}$ .

(ii) $\Rightarrow$ (iii): It follows from Lemma 2.7 that  $\operatorname{Ext}_R^i(k,\operatorname{H}^c_{\mathfrak{a}}(M))=0$  for all i< d. On the other hand, since  $\operatorname{H}^d_{\mathfrak{m}}(\operatorname{H}^c_{\mathfrak{a}}(M))$  is injective, one can use [5, Proposition 2.1] to see that  $\operatorname{Ext}_R^i(k,\operatorname{H}^c_{\mathfrak{a}}(M))=0$  for all d< i and that  $\operatorname{Ext}_R^d(k,\operatorname{H}^c_{\mathfrak{a}}(M))\cong \operatorname{Hom}_R(k,\operatorname{H}^d_{\mathfrak{a}}(H))\cong k^{r(M)}$ , and hence the assertion is done. The implications (iii) $\Leftrightarrow$ (iv) is clear.

(iii) $\Rightarrow$ (ii): First, in view of Lemma 2.7,  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M))=0$  for all i< d. Now, since  $\dim_R \mathrm{H}^c_{\mathfrak{a}}(M) \leq \dim_R M/\mathfrak{a}M = d$ , one can use the vanishing theorem to see that  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M))=0$  for all d< i. Therefore, [5, Proposition 2.1] implies that  $\mathrm{Hom}_R(R/\mathfrak{m},\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)))\cong k^{r(M)}$ , and so it is an Artinian R-module. Hence, by [1, Theorem 7.1.2],  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M))$  is Artinian. Thus, one can use [5, Corollary 2.2] to see that  $\mu^1(\mathfrak{m},\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)))=\mu^{d+1}(\mathfrak{m},\mathrm{H}^c_{\mathfrak{a}}(M))=0$  and  $\mu^0(\mathfrak{m},\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M)))=r(M)$ . Hence  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M))$  is an injective R-module, and so we obtain the isomorphism  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(M))\cong \mathrm{E}_R(k)^{r(M)}$ .

(ii) $\Rightarrow$ (i): Since M is relative Cohen-Macaulay in  $\operatorname{Supp}_R(M/\mathfrak{a}M)\setminus\{\mathfrak{m}\}$ , one can use [5, Proposition 2.8] to deduce that  $\operatorname{H}^i_{\mathfrak{p}R_{\mathfrak{p}}}(\operatorname{H}^c_{\mathfrak{a}R_{\mathfrak{p}}}(M_{\mathfrak{p}}))\cong \operatorname{H}^{i+c}_{\mathfrak{p}R_{\mathfrak{p}}}(M_{\mathfrak{p}})$  for all prime ideals  $\mathfrak{p}$  in  $\operatorname{Supp}_R(M/\mathfrak{a}M)\setminus\{\mathfrak{m}\}$  and for all  $i\in\mathbb{Z}$ . On the other hand, since M is Gorenstein, one can use [5, Theorem 2.5] and [5, Corollay 2.2] to see that  $\operatorname{H}^n_{\mathfrak{m}}(M)\cong \operatorname{E}_R(k)^{r(M)}$ . Therefore, the assertion follows from [4, Theorem 4.4]. Next, one can use Proposition 2.6(iii) and [5, Proposition 2.1] to establish the final assertion.

Next, we provide an example to show that even if, for all  $\mathfrak{p} \in \operatorname{Supp}_R(M/\mathfrak{a}M) \setminus \{\mathfrak{m}\}$ ,  $M_{\mathfrak{p}}$  is relative Cohen-Macaulay with respect to  $\mathfrak{a}R_{\mathfrak{p}}$ , but with different cohomological dimensions, then Theorem 2.9 is no longer true.

**Example 2.10.** Let k be a filed and R = k[[x, y, z]]. Set  $\mathfrak{a} := (xy, xz)$ . Then, we have grade  $(\mathfrak{a}, R) = \operatorname{ht} \mathfrak{a} = 1$ . Also, one can use Mayer-Vietoris sequence to see that

 $\operatorname{cd}(\mathfrak{a},R)=2$  and  $\operatorname{H}^1_{\mathfrak{a}}(R)\cong\operatorname{H}^1_{(x)}(R)$ . On the other hand, it is easy to see that, for all prime ideals  $\mathfrak{p}$  in  $\operatorname{V}(\mathfrak{a})\setminus\{\mathfrak{m}\}$ ,  $\mathfrak{a}R_{\mathfrak{p}}=(x)R_{\mathfrak{p}}$  or  $\mathfrak{a}R_{\mathfrak{p}}=(y,z)R_{\mathfrak{p}}$ ; and hence  $R_{\mathfrak{p}}$  is relative Cohen-Macaulay with respect to  $\mathfrak{a}R_{\mathfrak{p}}$  for all prime ideals  $\mathfrak{p}$  in  $\operatorname{V}(\mathfrak{a})\setminus\{\mathfrak{m}\}$  with  $\operatorname{cd}(\mathfrak{a}R_{\mathfrak{p}},R_{\mathfrak{p}})\in\{1,2\}$ . Next, since  $\operatorname{H}^i_{(x)}(R)=0$  for all  $i\neq 1$ , one can see that  $\operatorname{H}^i_{\mathfrak{m}}(\operatorname{H}^1_{(x)}(R))\cong\operatorname{H}^{i+1}_{\mathfrak{m}}(R)$  for all i. Hence, by using the fact that R is Gorenstein, we have  $\operatorname{H}^d_{\mathfrak{m}}(\operatorname{H}^1_{\mathfrak{a}}(R))\cong\operatorname{E}_R(k)$  and  $\operatorname{H}^i_{\mathfrak{m}}(\operatorname{H}^1_{\mathfrak{a}}(R))=0$  for all  $i\neq d$ , where  $d=\dim R/\mathfrak{a}$ .

Next, we single out a certain case of the above theorem for  $M = \omega_R$ , where  $\omega_R$  denotes a canonical module of a Cohen-Macaulay ring R.

Corollary 2.11. Let  $(R, \mathfrak{m}, k)$  be a local Cohen-Macaulay ring which admits a canonical R-module  $\omega_R$  and let  $\mathfrak{a}$  be an ideal of R with  $\operatorname{ht}_R \mathfrak{a} = c$  and  $\dim R/\mathfrak{a} = d$ . Suppose that  $\omega_R$  is relative Cohen-Macaulay in  $V(\mathfrak{a}) \setminus \{\mathfrak{m}\}$ . Then the following statements are equivalent.

- (i)  $H_{\mathfrak{g}}^{i}(\omega_{R}) = 0$  for all  $i \neq c$ .
- (ii)  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(\omega_R)) \cong \mathrm{E}_R(k)$  and  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{a}}(\omega_R)) = 0$  for all  $i \neq d$ .
- (iii)  $\operatorname{Ext}_{R}^{d}(k, \operatorname{H}_{\mathfrak{g}}^{c}(\omega_{R})) \cong k$  and  $\operatorname{Ext}_{R}^{i}(k, \operatorname{H}_{\mathfrak{g}}^{c}(\omega_{R})) = 0$  for all  $i \neq d$ .
- (iv)  $\mu^i(\mathfrak{m}, \mathcal{H}^c_{\mathfrak{a}}(\omega_R)) = \delta_{di}$ .

Moreover, if  $\mathfrak{a}$  satisfies the above conditions, then  $\operatorname{Ext}_R^i(\operatorname{H}^c_{\mathfrak{a}}(\omega_R), \operatorname{H}^c_{\mathfrak{a}}(\omega_R)) = 0$  for all  $i \neq 0$  and  $\hat{R}^{\mathfrak{a}} \cong \operatorname{Hom}_R(\operatorname{H}^c_{\mathfrak{a}}(\omega_R), \operatorname{H}^c_{\mathfrak{a}}(\omega_R))$ , where  $\hat{R}^{\mathfrak{a}}$  denotes the  $\mathfrak{a}$ -adic completion of R.

Proof. We first notice that  $\operatorname{Supp}(\omega_R/\mathfrak{a}\omega_R) = \operatorname{Supp}(\omega_R) \cap \operatorname{V}(\mathfrak{a}) = \operatorname{V}(\mathfrak{a})$ . Therefore,  $\dim(\omega_R/\mathfrak{a}\omega_R) = \dim(R/\mathfrak{a})$  and  $\operatorname{ht}_R\mathfrak{a} = \operatorname{ht}_{\omega_R}\mathfrak{a}$ . On the other hand, one can use [2, Proposition 3.3.11] to see that  $\omega_R$  is a Gorenstein R-module of type 1 and that  $\operatorname{Hom}_R(\omega_R,\omega_R) \cong R$ . Hence, the assertion follows from Theorem 2.9.

The following corollary, which is an immediate consequence of Corollary 2.11, has been proved in [3, Theorem 0.1] as a main result.

**Corollary 2.12.** Let  $(R, \mathfrak{m}, k)$  be a local Gorenstein ring and let  $\mathfrak{a}$  be an ideal of R. Set  $\operatorname{ht}_R \mathfrak{a} = c$  and  $\dim R/\mathfrak{a} = d$ . Suppose that R is relative Cohen-Macaulay in  $V(\mathfrak{a}) \setminus \{\mathfrak{m}\}$ . Then the following statements are equivalent.

- (i)  $H^i_{\mathfrak{a}}(R) = 0$  for all  $i \neq c$ , i.e R is relative Cohen-Macaulay with respect to  $\mathfrak{a}$ .
- (ii)  $\mathrm{H}^d_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{q}}(R)) \cong \mathrm{E}_R(k)$  and  $\mathrm{H}^i_{\mathfrak{m}}(\mathrm{H}^c_{\mathfrak{q}}(R)) = 0$  for  $i \neq d$ .
- (iii)  $\operatorname{\mathsf{Ext}}^d_R(k,\operatorname{H}^c_{\mathfrak a}(R))\cong k$  and  $\operatorname{\mathsf{Ext}}^i_R(k,\operatorname{H}^c_{\mathfrak a}(R))=0$  for all  $i\neq d.$
- (iv)  $\mu^i(\mathfrak{m}, H^c_{\mathfrak{g}}(R)) = \delta_{di}$ .

Moreover, if one of the above conditions is satisfied, then  $\hat{R}^{\mathfrak{a}} \cong \mathsf{Hom}_{R}(\mathrm{H}^{c}_{\mathfrak{a}}(R), \mathrm{H}^{c}_{\mathfrak{a}}(R))$  and  $\mathsf{Ext}^{i}_{R}(\mathrm{H}^{c}_{\mathfrak{a}}(R), \mathrm{H}^{c}_{\mathfrak{a}}(R)) = 0$  for all  $i \neq 0$ .
