A NOTE ON DIASTATIC ENTROPY AND BALANCED METRICS

ABSTRACT. We give un upper bound $\operatorname{Ent}_{d}(\Omega, g) < \lambda$ of the diastatic entropy $\operatorname{Ent}_{d}(\Omega, g)$ (defined by the author in [18]) of a complex bounded domain (Ω, g) in terms of the balanced condition (in Donaldson terminology) of the Kähler metric λg . When (Ω, g) is a homogeneous bounded domain we show that the converse holds true, namely if $\operatorname{Ent}_{d}(\Omega, g) < 1$ then g is balanced. Moreover, we explicitly compute $\operatorname{Ent}_{d}(\Omega, g)$ in terms of Piatetski-Shapiro constants.

1. INTRODUCTION AND STATEMENTS OF THE MAIN RESULTS

Let (M, g) be a real analytic Kähler manifold with associated Kähler form ω . Fix a local coordinate system $z = (z_1, \ldots, z_n)$ on a neighbourhood U of a point $p \in M$ and let $\phi : U \to \mathbb{R}$ be a real analytic Kähler potential (i.e $\omega_{|U} = \frac{i}{2} \partial \overline{\partial} \phi$). By shrinking U, we can assume that the potential $\phi(z)$ can be analytically continued to $U \times U$. Denote this extension by $\phi(z, \overline{w})$. The Calabi's diastasis function $\mathcal{D} : U \times U \to \mathbb{R}$ (E. Calabi [4]) is defined by

$$\mathcal{D}(z, w) = \mathcal{D}_{w}(z) = \phi(z, \overline{z}) + \phi(w, \overline{w}) - \phi(z, \overline{w}) - \phi(w, \overline{z})$$

Assume that ω has global diastasis function $\mathcal{D}_p : M \to \mathbb{R}$ centered at p. The *diastatic entropy* at p is defined as

$$\operatorname{Ent}_{d}(M, g)(p) = \min\left\{c > 0 \mid \int_{M} e^{-c \mathcal{D}_{p}} \frac{\omega^{n}}{n!} < \infty\right\}.$$
 (1)

This definition does not depend on the point p fixed, provided that for every $p \in \Omega$ the diastasis \mathcal{D}_p is globally defined (see [18, Proposition 2.2]). The concept of diastatic entropy was defined by the author in [18] (following the ideas developed in [15]), where he obtained upper and lower bound for the first eigenvalue of a real analytic Kähler manifold.

In this paper we study the link between the diastatic entropy $\operatorname{Ent}_{d}(\Omega, g)$ and the balanced condition of the metric g. S. Donaldson in [8], in order to obtain a link between the constant scalar curvature condition on a Kähler metric g and the Chow stability of a polarization L, gave the definition of a balanced metric on a compact manifold. Later, this definition has been generalized, by C. Arezzo and A. Loi in [3] (see also [2]), to the noncompact case. R. MOSSA

In this paper we are interested in complex domains $\Omega \subset \mathbb{C}^n$ (connected open subset of \mathbb{C}^n) endowed with a real analytic Kähler metric g. Let ω be the Kähler form associated to g. Assume that ω admits a global Kähler potential $\phi : \Omega \to \mathbb{R}$. We can define the weighted Hilbert space \mathcal{H}_{ϕ} of square integrable holomorphic functions on Ω with weight $e^{-\phi}$

$$\mathcal{H}_{\phi} = \left\{ s \in \operatorname{Hol}(\Omega) : \int_{\Omega} e^{-\phi} \left| s \right|^2 \frac{\omega^n}{n!} < \infty \right\}.$$
 (2)

If $\mathcal{H}_{\phi} \neq \{0\}$ we can pick an orthonormal basis $\{s_j\}_{j=1,\dots,N \leq \infty}$,

$$\int_{\Omega} e^{-\phi} \, s_j \, \overline{s}_k \, \frac{\omega^n}{n!} = \delta_{jk}$$

and define its reproducing kernel by

$$K_{\phi}(z,\overline{w}) = \sum_{j=0}^{N} s_j(z) \ \overline{s_j(w)}.$$
(3)

The so called ε -function is defined by

$$\varepsilon_g(z) = e^{-\phi(z)} K_\phi(z, \bar{z}), \qquad (4)$$

as suggested by the notation ε_g depends only on the metric g and not on the choice of the Kähler potential ϕ (see, for example, [14, Lemma 1] for a proof).

Definition 1. The metric g is *balanced* if and only if the function ε_g is a positive constant.

In the literature the constancy of ε_g was studied first by J. H. Rawnsley in [22] under the name of η -function, later renamed as ε -function in [5]. It also appears under the name of distortion function for the study of Abelian varieties by J. R. Kempf [13] and S. Ji [12], and for complex projective varieties by S. Zhang [24]. (See also [16] and references therein).

The following theorem represents the first result of this paper.

Theorem 1. Let $\Omega \subset \mathbb{C}^n$ be a complex domain and g a Kähler metric such that λg is balanced for some $\lambda > 0$. Then the diastatic entropy $\text{Ent}_d(\Omega, g)$ is constant and

$$\operatorname{Ent}_{d}(\Omega, g) < \lambda.$$

In particular (see Lemma 4 below) the diastatic entropy of a homogeneous bounded domain is constant.

It is natural to ask when the converse of the previous theorem holds true. In the next theorem we show that this is the case when (Ω, g) is assumed to be homogeneous. **Theorem 2.** Let (Ω, g) be a homogeneous bounded domain, then g is balanced if and only if

$$\operatorname{Ent}_{d}(\Omega, g) < 1.$$

We also compute the diastatic entropy of a homogeneous bounded domain in terms of the constants p_k , b_k , q_k and γ_k defined by the Piatetski-Shapiro's root structure (see (10) and (11) in Appendix below):

Corollary 2. Let (Ω, g) be a homogeneous bounded domain. Then the diastatic entropy of (Ω, g) is the positive constant given by

$$\operatorname{Ent}_{d}(\Omega, g)(z) = \max_{1 \le k \le r} \frac{1 + p_{k} + b_{k} + q_{k}/2}{\gamma_{k}}, \qquad \forall z \in \Omega.$$

Example 3. If g is the Bergman metric on Ω , then $\gamma_k = 2 + p_k + q_k + b_k$, $k = 1, \ldots, r$ (see [10, Theorem 5.1] or [20, (2.19)]), so by Theorem 2,

$$\operatorname{Ent}_{d}(\Omega, g)(z) = \max_{1 \le k \le r} \frac{1 + p_{k} + b_{k} + q_{k}/2}{2 + p_{k} + q_{k} + b_{k}}, \quad \forall z \in \Omega.$$
(5)

In particular, when (Ω, g) is a bounded symmetric domain (i.e. is a homogeneous bounded domain and a symmetric space as Riemannian manifold), there exist integers a and b such that

$$p_k = (k-1)a, \quad q_k = (r-k)a, \quad b_k = b, \quad \gamma_k = (r-1)a + b + 2.$$

where r is the rank of (Ω, g) . Therefore, denoted by γ the genus of Ω , by (5) we obtain

$$\operatorname{Ent}_{d}(\Omega, g)(z) = \max_{1 \le k \le r} \frac{1 + (k-1)a + b + (r-k)a/2}{\gamma}$$
$$= \frac{1 + (r-1)a + b}{\gamma} = \frac{\gamma - 1}{\gamma}, \quad \forall z \in \Omega.$$

See also [19] for a similar formula relating the volume entropy with the invariants a, b, and r. The table below summarizes the numerical invariants and the dimension of irreducible bounded symmetric domains according to their type (for a more detailed description of these invariants, see e.g. [1], [24]).

2. Proofs of Theorem 1, 2 and Corollary 2

2.1. **Proof of Theorem 1.** Assume that λg is balanced, namely that the ε -function is constant. Consider the Kähler potential $\lambda \phi(z)$ of λg , let $\lambda \phi(z, \overline{w})$ be its analytic continuation and let $K_{\lambda \phi}(z, \overline{w})$ be the reproducing kernel for the weighted Hilbert space $\mathcal{H}_{\lambda \phi}$. We have

$$\varepsilon_{\lambda q}(z, \overline{w}) = e^{-\lambda \phi(z, \overline{w})} K_{\lambda \phi}(z, \overline{w}) = C > 0, \tag{6}$$

so $K_{\lambda\phi}(z, \overline{w})$ never vanish. Hence, fixed a point z_0 , the function

$$\psi\left(z,\,\overline{w}\right) = \frac{K_{\lambda\phi}\left(z,\,\overline{w}\right)K_{\lambda\phi}\left(z_0,\,\overline{z}_0\right)}{K_{\lambda\phi}\left(z,\,\overline{z}_0\right)K_{\lambda\phi}\left(z_0,\,\overline{w}\right)}.\tag{7}$$

is well defined. Note that $\psi(z_0, \overline{w}) = \psi(z, \overline{z}_0) = 1$ and that

$$\mathcal{D}_{z_0}\left(z\right) = \frac{1}{\lambda}\log\psi\left(z,\,\overline{z}\right) \tag{8}$$

is the diastasis centered in z_0 associated to g. So the diastasis \mathcal{D}_{z_0} is globally defined and $\lambda \mathcal{D}_{z_0}$ is a global Kähler potential for λg . Consider the Hilbert space $\mathcal{H}_{\lambda \mathcal{D}_{z_0}}$ given by:

$$\mathcal{H}_{\lambda \mathcal{D}_{z_0}} = \left\{ f \in \operatorname{Hol}\left(\Omega\right) : \int_{\Omega} e^{-\lambda \mathcal{D}_{z_0}} \left|f\right|^2 \frac{\omega^n}{n!} < \infty \right\}.$$

Let $K_{\lambda \mathcal{D}_{z_0}}(z, \overline{w})$ be its reproducing kernel, since the ε -function does not depend on the Kähler potential, by (6) we have

$$\varepsilon_{\lambda g}(z, \overline{w}) = e^{-\lambda \mathcal{D}_{z_0}(z, \overline{w})} K_{\lambda \mathcal{D}_{z_0}}(z, \overline{w}) = C$$
(9)

where $\mathcal{D}_{z_0}(z, \overline{w})$ denote the analytic continuation of $\mathcal{D}_{z_0}(z) = \mathcal{D}_{z_0}(z, \overline{z})$. In particular

$$C = e^{-\lambda \mathcal{D}_{z_0}(z, \overline{z}_0)} K_{\lambda \mathcal{D}_{z_0}}(z, \overline{z}_0) = K_{\lambda \mathcal{D}_{z_0}}(z, \overline{z}_0) \in \mathcal{H}_{\lambda \mathcal{D}_{z_0}},$$

indeed by (7) and (8) we have $\mathcal{D}_{z_0}(z, \overline{z}_0) = \frac{1}{\lambda} \log \psi(z, \overline{z}_0) = 0$. It would be worth to say that $K_{\lambda \mathcal{D}_{z_0}} \in \mathcal{H}_{\lambda \mathcal{D}_{z_0}}$ by its very definition (indeed $K_{\lambda \mathcal{D}_{z_0}}(z, \overline{z}_0) =$ $\sum_{j=0}^{N} s_j(z) \overline{s_j(z_0)}$ where $\{s_j\}$ is a basis for $\mathcal{H}_{\lambda \mathcal{D}_{z_0}}$). Thus $\mathcal{H}_{\lambda \mathcal{D}_{z_0}}$ contains the constant functions and

$$\int_{\Omega} e^{-\lambda \mathcal{D}_{z_0}} \frac{\omega^n}{n!} < \infty$$

We conclude, by the very definition of the diastatic entropy, that $\operatorname{Ent}_{d}(\Omega, g)(z_{0}) < \lambda$. Moreover, by (8), the diastasis $\mathcal{D}_{z_{0}}$ is globally defined for any fixed $z_{0} \in \Omega$ and [18, Proposition 2.2] says us that $\operatorname{Ent}_{d}(\Omega, g)$ is constant. As wished.

2.2. **Proof of Theorem 2.** Recall that a homogeneous bounded domain (Ω, g) is a bounded domain of \mathbb{C}^n with a Kähler metric g such that the group G = $\operatorname{Aut}(\Omega) \cap \operatorname{Isom}(\Omega, g)$ acts transitively on it, where $\operatorname{Aut}(\Omega)$ denotes the group of biholomorphisms of Ω and $\operatorname{Isom}(\Omega, g)$ the group of isometries of (Ω, g) . It is wellknown that such a domain Ω is contractible and that $\omega = \frac{i}{2}\partial\bar{\partial}\phi$ for a globally defined Kähler potential ϕ . Indeed Ω is pseudoconvex being biholomorphically equivalent to a Siegel domain (see, e.g. [11] for a proof) and so the existence of a global potential follows by a classical result of Hormander (see [6]) asserting that the equation $\bar{\partial}u = f$ with $f \bar{\partial}$ -closed form has a global solution on pseudoconvex domains (see also [17, 19] and the proof of Theorem 4 in [7], for an explicit construction of the potential ϕ following the ideas developed in [9]).

We have to prove that if $1 > \text{Ent}_{d}(\Omega, g)(z)$ then g is balanced (the converse follows by Theorem 1). Assume that $1 > \text{Ent}_{d}(\Omega, g)(z)$ i.e.

$$\int_{\Omega} e^{-\mathcal{D}_z} \, \frac{\omega^n}{n!} < \infty$$

then the Hilbert space $\mathcal{H}_{\mathcal{D}_z}$ contains the constant functions and the associated ε function is strictly positive. By the homogeneity of (Ω, g) we conclude that ε_g has to be a positive constant (see the proof of [14, Lemma 1]), that is g is balanced. This concludes the proof of Theorem 2.

2.3. **Proof of Corollary 2.** In order to prove Corollary 2 we need of the following result:

Lemma 4. ([14, Theorem 2] and [14, (12)]). Let $(\Omega, \lambda g)$ be a homogeneous bounded domain and let p_k , b_k , q_k and γ_k be the constants defined by (10) and (11) in Appendix. Then the metric λg is balanced if and only if

$$\lambda > \frac{1 + p_k + b_k + q_k/2}{\gamma_k}, \qquad 1 \le k \le r.$$

By the very definition of diastatic entropy, we have that

$$\operatorname{Ent}_{\mathrm{d}}\left(\Omega,\,\lambda\,g\right) = \frac{\operatorname{Ent}_{\mathrm{d}}\left(\Omega,\,g\right)}{\lambda},$$

combining this with Theorem 2 we obtain that $\operatorname{Ent}_{d}(\Omega, g) < \lambda$ if and only if the metric λg is balanced. Therefore

$$\operatorname{Ent}_{d}(\Omega, g) = \min \left\{ \lambda > 0 \mid \lambda g \text{ is balanced} \right\}, \qquad \forall z \in \Omega.$$

Together with Lemma 4, this concludes the proof of Corollary 2.

3. Appendix

In this section we give the definition of the constants p_k , b_k , q_k and γ_k associated to the Piatetski-Shapiro's root structure (see [21] for details).

Let $(\Omega \subset \mathbb{C}^n, g)$ be an homogenous bounded domain, and set $G = \operatorname{Aut}(\Omega) \cap$ Isom (Ω, g) , where Aut (Ω) (resp. Isom (Ω, g)) denotes the group of invertible holomorphic maps (resp. g-isometries) of Ω . By [9, Theorem 2 (c)], there exists a connected split solvable Lie subgroup $S \subset G$ acting simply transitively on the domain Ω . Fix a point $p_0 \in \Omega$, we have a diffeomorphism $\iota : S \to \Omega$ with $\iota(h) = h \cdot p_0$. By differentiation, we get a linear isomorphism between the Lie algebra \mathfrak{s} of S and the tangent space $T_{p_0}M$, given by $X \stackrel{\sim}{\mapsto} X \cdot p_0$. Then the evaluation of the Kähler form ω on \mathfrak{s} is given by

$$\omega \left(X \cdot p_0, Y \cdot p_0 \right) = \beta \left([X, Y] \right) \qquad X, Y \in \mathfrak{s}$$

with a certain linear form $\beta \in \mathfrak{s}^*$. Let $j : \mathfrak{s} \to \mathfrak{s}$ be the linear map defined in such a way that

$$(jX) \cdot p_0 = \sqrt{-1} (X \cdot p_0)$$
 for $X \in \mathfrak{s}$.

We have $g(X \cdot p_0, Y \cdot p_0) = \beta([jX, Y])$ for $X, Y \in \mathfrak{s}$, so the right-hand side defines a positive inner product on \mathfrak{s} . Let \mathfrak{a} be the orthogonal complement of $[\mathfrak{s}, \mathfrak{s}]$ in \mathfrak{s} with respect to this inner product. Then \mathfrak{a} is a commutative Cartan subalgebra of \mathfrak{s} . Given a linear form α on the Cartan algebra \mathfrak{a} , we denote by \mathfrak{s}_{α} the subspace

$$\mathfrak{s}_{\alpha} = \{ X \in \mathfrak{s} : [C, X] = \alpha(C) X, \ \forall C \in \mathfrak{a} \}$$

of \mathfrak{s} . We say that α is a *root* if $\mathfrak{s}_{\alpha} \neq \{0\}$ and $\alpha \neq 0$. Thanks to [21, Chapter 2, Section 3] or [23, Theorem 4.3], there exists a basis $\{\alpha_1, \ldots, \alpha_r\}, (r := \dim \mathfrak{a})$ of \mathfrak{a}^* such that every root is one of the following:

$$\alpha_k, \ \alpha_k/2, \ (k = 1, \dots, r), \qquad (\alpha_l \pm \alpha_k)/2, \qquad 1 \le k < l \le r.$$

For k = 1, ..., r we define (see [23, Definition 4.7] and [20, (2.7)])

$$p_k := \sum_{i < k} \dim \mathfrak{s}_{(\alpha_k - \alpha_i)/2}, \quad q_k := \sum_{l > k} \dim \mathfrak{s}_{(\alpha_l - \alpha_k)/2}, \quad b_k := \frac{1}{2} \dim \mathfrak{s}_{\alpha_k/2}, \quad (10)$$

$$\gamma_k := 4 \beta \left(\left[j A_k, A_k \right] \right), \tag{11}$$

where $\{A_1, \ldots, A_r\}$ is the basis of \mathfrak{a} dual to $\{\alpha_1, \ldots, \alpha_r\}$.
