# The Pólya-Chebotarev Problem and Inverse Polynomial Images<sup>\*</sup>

#### Abstract

Consider the problem, usually called the Pólya-Chebotarev problem, of finding a continuum in the complex plane including some given points such that the logarithmic capacity of this continuum is minimal. We prove that each connected inverse image  $\mathcal{T}_n^{-1}([-1,1])$  of a polynomial  $\mathcal{T}_n$  is always the solution of a certain Pólya-Chebotarev problem. By solving a nonlinear system of equations for the zeros of  $\mathcal{T}_n^2 - 1$ , we are able to construct polynomials  $\mathcal{T}_n$  with a connected inverse image.

### 1 The Pólya-Chebotarev Problem

Let us introduce an extremal problem concerning the logarithmic capacity usually called the "Pólya-Chebotarev problem" or the "Chebotarev problem", since Chebotarev mentioned the problem in a letter to Pólya [11].

Pólya-Chebotarev problem: Given  $\nu$  distinct points  $c_1, c_2, \ldots, c_{\nu} \in \mathbb{C}$  in the complex plane, find a *continuum* S, i.e. S is *connected*, with the property that  $c_1, \ldots, c_{\nu} \in S$ , such that the logarithmic capacity cap S is minimal.

Existence and uniqueness of such a set S is proved in [4]. We will call the minimal set S the *Pólya-Chebotarev continuum* for  $\{c_1, c_2, \ldots, c_{\nu}\}$ .

The case of  $\nu = 2$  points  $c_1, c_2$  is trivial: in this situation the Pólya-Chebotarev continuum is just the segment  $[c_1, c_2]$ .

In [7], the authors gave a short history of the Pólya-Chebotarev problem and a description of the solution which can be implemented numerically. Fedorov [1] gave a complete solution of the Pólya-Chebotarev problem for  $\nu = 3$  and  $\nu = 4$  points (only a symmetric case) with the help of the Jacobian elliptic functions, see also [14].

In the following, let us recall the well-known representation of the Pólya-Chebotarev continuum with the help of a hyperelliptic integral, see, e.g., [3] or [2].

**Theorem 1.** Let  $c_1, c_2, \ldots, c_{\nu} \in \mathbb{C}$  be  $\nu \geq 3$  given pairwise distinct complex points. If there exists  $\nu - 2$  points  $d_1, \ldots, d_{\nu-2} \in \mathbb{C}$  with

$$Re\{\Phi(c_j)\} = 0, \qquad j = 1, 2, \dots, \nu, Re\{\Phi(d_j)\} = 0, \qquad j = 1, 2, \dots, \nu - 2,$$
(1)

where  $\Phi(z)$  is the hyperelliptic integral

$$\Phi(z) = \int_{c_1}^{z} \frac{\sqrt{\prod_{j=1}^{\nu-2} (w - d_j)}}{\sqrt{\prod_{j=1}^{\nu} (w - c_j)}} \, \mathrm{d}w,$$
(2)

then the set S defined by

$$S := \left\{ z \in \mathbb{C} : \operatorname{Re} \{ \Phi(z) \} = 0 \right\},$$
(3)

is the Pólya-Chebotarev continuum for  $\{c_1, c_2, \ldots, c_{\nu}\}$ .

- **Remark.** (i) Let us mention that the function  $\operatorname{Re}\{\Phi(z)\}$  is harmonic and single valued in  $\overline{\mathbb{C}} \setminus S$  and is the unique Green function with pole at  $\infty$  for  $\mathbb{C} \setminus S$ , see [6]. For the definition and many properties of the Green function and the logarithmic capacity of a set S in the complex plane, we refer to [12] and [13].
  - (ii) We will call the complex points d<sub>1</sub>,..., d<sub>ν-2</sub>, which appear in formula (2), the bifurcation points of the Pólya-Chebotarev continuum S. If a point d\* ∈ C is a zero of multiplicity k of the polynomial ∏<sup>ν-2</sup><sub>j=1</sub>(w d<sub>j</sub>) then d\* is called a bifurcation point of multiplicity k. For a typical Pólya-Chebotarev continuum for ν = 5 points, see Fig. 1.



Figure 1: Illustration of a Pólya-Chebotarev continuum ( $\nu = 5$ )

The paper is organized as follows. In Section 2, after two preliminary lemmata, the main result is stated in Theorem 2. We prove that each inverse image  $\mathcal{T}_n^{-1}([-1,1])$  of a polynomial  $\mathcal{T}_n$ , which is connected, solves a certain Pólya-Chebotarev problem. Further, we give some simple examples of polynomials with a connected inverse image. In Section 3, we show how to construct polynomials  $\mathcal{T}_n$  with a connected inverse image by solving a certain nonlinear system of equations for the zeros of  $\mathcal{T}_n^2 - 1$ . Some examples and a conjecture concerning a denseness statement conclude the paper.

# 2 The Connection between the Pólya-Chebotarev Problem and Inverse Polynomial Images

Let us start with a lemma which is very important for what follows. The first part, see [16, Lemma 2], is just an immediate consequence of the fundamental theorem of algebra, the second part is due to Peherstorfer [9, Corollary 2]. As usual, let  $\mathbb{P}_n$  denote the set of all polynomials of degree n with complex coefficients.

**Lemma 1.** For any polynomial  $\mathcal{T}_n(z) = \tau z^n + \ldots \in \mathbb{P}_n$ ,  $\tau \in \mathbb{C} \setminus \{0\}$ , there exists a unique  $\ell \in \{1, 2, \ldots, n\}$ , a unique monic polynomial

$$\mathcal{H}_{2\ell}(z) = \prod_{j=1}^{2\ell} (z - a_j) = z^{2\ell} + \ldots \in \mathbb{P}_{2\ell}$$
(4)

with pairwise distinct zeros  $a_1, a_2, \ldots, a_{2\ell}$ , and a unique polynomial  $\mathcal{U}_{n-\ell}(z) = \tau z^{n-\ell} + \ldots \in \mathbb{P}_{n-\ell}$  such that the polynomial equation

$$\mathcal{T}_n^2(z) - 1 = \mathcal{H}_{2\ell}(z)\mathcal{U}_{n-\ell}^2(z)$$
(5)

holds.

Further, there exists a monic polynomial  $\mathcal{R}_{\ell-1}(z) = z^{\ell-1} + \ldots \in \mathbb{P}_{\ell-1}$  such that

$$\mathcal{T}'_{n}(z) = n \,\mathcal{R}_{\ell-1}(z) \,\mathcal{U}_{n-\ell}(z) \tag{6}$$

and, for  $z \in \mathbb{C}$  with  $\mathcal{T}_n(z) \notin [-1, 1]$ ,

$$\mathcal{T}_n(z) = \pm \cosh\left(n \int_{a_j}^z \frac{\mathcal{R}_{\ell-1}(w)}{\sqrt{\mathcal{H}_{2\ell}(w)}} \,\mathrm{d}w\right),\tag{7}$$

where  $a_i$  is any zero of  $\mathcal{H}_{2\ell}$ .

Note that the points  $a_1, a_2, \ldots, a_{2\ell}$  are exactly those zeros of  $\mathcal{T}_n^2(z) - 1$  which have odd multiplicity.

Next, let us introduce the notion of the inverse image of a polynomial. For a polynomial  $\mathcal{T}_n \in \mathbb{P}_n$ , let  $\mathcal{T}_n^{-1}([-1,1])$  denote the inverse image of [-1,1] with respect to  $\mathcal{T}_n$ , i.e.

$$\mathcal{T}_n^{-1}([-1,1]) := \{ z \in \mathbb{C} : \mathcal{T}_n(z) \in [-1,1] \}.$$
(8)

In general, the inverse image  $\mathcal{T}_n^{-1}([-1,1])$  consists of n Jordan arcs [16]. One reason why we are interested in the factorization of  $\mathcal{T}_n^2(z) - 1$  in the form (5) is that the number  $\ell$  signifies the minimum number of Jordan arcs the inverse image  $\mathcal{T}_n^{-1}([-1,1])$  consists of, see [16, Theorem 2].

Concerning the connectivity of the inverse image  $\mathcal{T}_n^{-1}([-1,1])$ , the following is known.

**Lemma 2.** Let  $\mathcal{T}_n \in \mathbb{P}_n$ , and let  $\mathcal{R}_{\ell-1}$  as in Lemma 1. The following statements are equivalent:

- (i) The inverse image  $\mathcal{T}_n^{-1}([-1,1])$  is connected.
- (ii) All zeros of the derivative  $\mathcal{T}'_n$  are located in  $\mathcal{T}^{-1}_n([-1,1])$ .
- (iii) All zeros of  $\mathcal{R}_{\ell-1}$  are located in  $\mathcal{T}_n^{-1}([-1,1])$ .

*Proof.* The equivalence of (i) and (ii) is proved in [16, Theorem 4]. The equivalence of (ii) and (iii) follows immediately from (6), since, by (5), all zeros of  $\mathcal{U}_{n-\ell}$  are located in  $\mathcal{T}_n^{-1}([-1,1])$ .

Next, we state and prove the first main result. It says that each polynomial  $\mathcal{T}_n \in \mathbb{P}_n$  with a connected inverse image  $\mathcal{T}_n^{-1}([-1,1])$  solves a certain Pólya-Chebotarev problem.

**Theorem 2.** Let  $\mathcal{T}_n(z) = \tau z^n + \ldots \in \mathbb{P}_n$  with  $\tau \in \mathbb{C} \setminus \{0\}$  and suppose that all zeros of the derivative  $\mathcal{T}'_n$  are located in the inverse image  $\mathcal{T}_n^{-1}([-1,1])$ , i.e.  $\mathcal{T}_n^{-1}([-1,1])$  is connected. Suppose that  $c_1, c_2, \ldots, c_{\nu}$  (pairwise distinct) are exactly the simple zeros of  $\mathcal{T}_n^2(z) - 1$ . Then  $S = \mathcal{T}_n^{-1}([-1,1])$  is the Pólya-Chebotarev continuum for  $\{c_1, c_2, \ldots, c_{\nu}\}$  with corresponding minimal logarithmic capacity

$$\operatorname{cap} S = \frac{1}{\sqrt[n]{2|\tau|}}.$$
(9)

Proof. For  $\mathcal{T}_n \in \mathbb{P}_n$ , let  $\mathcal{H}_{2\ell}(z)$ ,  $\mathcal{U}_{n-\ell}(z)$ , and  $\mathcal{R}_{\ell-1}(z)$  as in Lemma 1. By assumption and Lemma 1,  $c_1, \ldots, c_{\nu} \in \{a_1, \ldots, a_{2\ell}\}$  are those zeros of  $\mathcal{H}_{2\ell}(z)$ , which are not zeros of  $\mathcal{U}_{n-\ell}(z)$ . Let  $b_1, \ldots, b_{2\ell-\nu} \in \{a_1, \ldots, a_{2\ell}\}$  be those zeros of  $\mathcal{H}_{2\ell}(z)$ , which are also zeros of  $\mathcal{U}_{n-\ell}(z)$ . Then, by (5), each  $b_j$  is a zero of  $\mathcal{T}_n^2(z) - 1$  with an odd multiplicity greater than two. Thus, by (5) and (6), each  $b_j$  is a zero of  $\mathcal{R}_{\ell-1}(z)$ . Hence

$$\frac{\mathcal{R}_{\ell-1}(z)}{\sqrt{\mathcal{H}_{2\ell}(z)}} = \frac{\sqrt{\mathcal{R}_{\ell-1}^2(z)}}{\sqrt{\prod_{j=1}^{\nu}(z-c_j)\cdot\prod_{j=1}^{2\ell-\nu}(z-b_j)}} = \frac{\sqrt{\prod_{j=1}^{\nu-2}(z-d_j)}}{\sqrt{\prod_{j=1}^{\nu}(z-c_j)}},$$

where

$$\prod_{j=1}^{\nu-2} (z - d_j) := \frac{\mathcal{R}_{\ell-1}^2(z)}{\prod_{j=1}^{2\ell-\nu} (z - b_j)}.$$
(10)

Define

$$\Phi(z) := \int_{c_1}^{z} \frac{\mathcal{R}_{\ell-1}(w)}{\sqrt{\mathcal{H}_{2\ell}(w)}} \,\mathrm{d}w$$

then, by Lemma 1,

$$\{ z \in \mathbb{C} : \operatorname{Re} \Phi(z) = 0 \} = \{ z \in \mathbb{C} : \operatorname{cosh}(n\Phi(z)) \in [-1,1] \}$$
$$= \{ z \in \mathbb{C} : \mathcal{T}_n(z) \in [-1,1] \} = \mathcal{T}_n^{-1}([-1,1]).$$

By construction,  $c_1, \ldots, c_{\nu} \in \mathcal{T}_n^{-1}([-1,1])$ , thus  $\operatorname{Re} \Phi(c_j) = 0$ ,  $j = 1, \ldots, \nu$ . By (10),  $d_1, \ldots, d_{\nu-2}$  are zeros of  $\mathcal{R}_{\ell-1}$ , thus, by Lemma 2,  $d_1, \ldots, d_{\nu-2} \in \mathcal{T}_n^{-1}([-1,1])$  and again  $\operatorname{Re} \Phi(d_j) = 0$ ,  $j = 1, \ldots, \nu - 2$ . Now the assertion apart from formula (9) follows by Theorem 1 and it remains to prove (9).

For any polynomial  $\mathcal{T}_n(z) = \tau z^n + \ldots \in \mathbb{P}_n, \tau \in \mathbb{C} \setminus \{0\}$ , it is known, see [9], [5] or [8], that the monic polynomial  $\hat{\mathcal{T}}_n(z) := \mathcal{T}_n(z)/\tau = z^n + \ldots \in \mathbb{P}_n$  is the Chebyshev polynomial on its inverse image  $S := \mathcal{T}_n^{-1}([-1,1])$  with minimum deviation  $L_n(S) = 1/|\tau|$ . Thus, from the identity  $L_n(S) = 2(\operatorname{cap} S)^n$ , see [15, Theorem 1], we get (9).

**Remark.** (i) Let  $\mathcal{T}_n \in \mathbb{P}_n$  and  $S := \mathcal{T}_n^{-1}([-1,1])$ . Then [9]

$$g_S(z) = \frac{1}{n} \log \left| \mathcal{T}_n(z) + \sqrt{\mathcal{T}_n^2(z) - 1} \right|$$
(11)

is the Green function of  $\overline{\mathbb{C}} \setminus S$  with pole at infinity. For the complex Green function

$$G_S(z) = \exp\left(-g_S(z) + ih_S(z)\right),\tag{12}$$

where  $h_S(z)$  is the harmonic conjugate of  $g_S(z)$ , we have [9]

$$G_S(z) = \exp\left(-\int_{c_1}^z \frac{\mathcal{R}_{\ell-1}(w)}{\sqrt{\mathcal{H}_{2\ell}(w)}} \,\mathrm{d}w\right),\tag{13}$$

where  $\mathcal{R}_{\ell-1}$  and  $\mathcal{H}_{2\ell}$  are as in Lemma 1.

(ii) In [14], the author characterizes the Pólya-Chebotarev continuum with the help of Jacobian elliptic and theta functions (using Zolotarev's conformal mapping) for the case of three and four points (i.e.  $\nu = 3$  and  $\nu = 4$ ). With this characterization, one can construct sets  $\{c_1, c_2, c_3, c_4\}$  such that the corresponding Pólya-Chebotarev continuum is *not* an inverse polynomial image.

Let us give some examples of polynomials with a connected inverse image.

**Example.** (i) Let  $\mathcal{T}_n(z) := z^n$ . The inverse image of  $\mathcal{T}_n$  is

$$S := \mathcal{T}_n^{-1}([-1,1]) = \left\{ z = r \mathrm{e}^{\mathrm{i}\varphi} : r \in [0,1], \varphi \in \{0, \frac{\pi}{n}, \frac{2\pi}{n}, \dots, \frac{(2n-1)\pi}{n} \} \right\},$$
(14)

see Fig. 2, where n = 5. By Theorem 2, the set S in (14) is the Pólya-Chebotarev continuum for the  $\nu = 2n$  points  $\{c_0, c_1, \ldots, c_{2n-1}\}$ , where  $c_k := e^{ik\pi/n}$ ,  $k = 0, 1, \ldots, 2n - 1$ , with (the only) bifurcation point  $d_1 = 0$  (of multiplicity 2n - 2). With the notations of Lemma 1, we have  $\ell = n$ ,

$$\mathcal{H}_{2\ell}(z) = \prod_{k=0}^{2n-1} (z - e^{ik\pi/n}) = z^{2n} - 1, \quad \mathcal{U}_{n-\ell}(z) = 1 \quad \text{and} \quad \mathcal{R}_{\ell-1}(z) = z^{n-1}.$$

Although very simple, this example seems to be new since we could not find it in the literature.

(ii) Let n = 2 and  $\mathcal{T}_n(z) := \frac{2}{1+\alpha^2}(z^2-1) + 1$  with  $0 \le \alpha < \infty$ . The inverse image of  $\mathcal{T}_n$  is the cross

$$S := \mathcal{T}_n^{-1}([-1,1]) = [-1,1] \cup [-i\alpha, i\alpha].$$
(15)

By Theorem 2, the set S in (15) is the Pólya-Chebotarev continuum for the  $\nu = 4$  points  $\{c_1, c_2, c_3, c_4\} = \{-1, 1, -i\alpha, i\alpha\}$  with (the only) bifurcation point  $d_1 = 0$  (of multiplicity two), see Fig. 3. With the notations of Lemma 1, we have  $\ell = 2$ ,

$$\mathcal{H}_{2\ell}(z) = (z^2 - 1)(z^2 + \alpha^2), \quad \mathcal{U}_{n-\ell}(z) = \frac{2}{1 + \alpha^2} \text{ and } \mathcal{R}_{\ell-1}(z) = z$$

(iii) Let  $n = 3, 0 \le \alpha < \infty$ , and define

$$\mathcal{T}_n(z) := -1 - \frac{(z-1)(2z+1-\alpha^2)^2}{(1+\alpha^2)^2}.$$
(16)

The zeros of  $\mathcal{T}_n^2(z) - 1$  are  $\pm 1$ ,  $\frac{1}{2}(1 + \alpha^2) \pm i\alpha$  (multiplicity one) and  $\frac{1}{2}(\alpha^2 - 1)$ (multiplicity two). The zeros of  $\mathcal{T}'_n(z)$  are  $\frac{1}{2}(\alpha^2 - 1)$  and  $\frac{1}{6}(3 + \alpha^2)$ . For  $\alpha \in [0, \sqrt{3}]$ ,

the inverse image  $\mathcal{T}_n^{-1}([-1,1])$  is connected and consists of the interval [-1,1] and a hyperbola moving from  $\frac{1}{2}(1+\alpha^2) + i\alpha$  to  $\frac{1}{2}(1+\alpha^2) - i\alpha$  crossing the interval [-1,1] at  $\frac{1}{6}(3+\alpha^2)$ . By Theorem 2, the set  $S = \mathcal{T}_n^{-1}([-1,1])$  is the Pólya-Chebotarev continuum for the  $\nu = 4$  points

$$\{c_1, c_2, c_3, c_4\} = \{-1, 1, \frac{1}{2}(1+\alpha^2) - i\alpha, \frac{1}{2}(1+\alpha^2) + i\alpha\}$$

with the bifurcation point  $d_1 = \frac{1}{6}(3 + \alpha^2)$  (of multiplicity two). In Fig. 4, we have plotted the inverse image  $\mathcal{T}_n^{-1}([-1,1])$  of the polynomial  $\mathcal{T}_n(z)$  defined in (16) for  $\alpha = \frac{1}{2}$ . For  $\alpha = 0$ , we get  $\mathcal{T}_n(z) = 3z - 4z^3$ , i.e. the Chebyshev polynomial of the first kind of degree three, for  $\alpha = \sqrt{3}$ , we get  $\mathcal{T}_n(z) = -1 - \frac{1}{4}(z-1)^3$ .

(iv) Let  $n = 4, 0 \le \alpha < \infty$ , and define

$$\mathcal{T}_n(z) := \frac{8z^4 - 8z^2 + 1 + 4\alpha^2}{1 + 4\alpha^2}.$$
(17)

The zeros of  $\mathcal{T}_n^2(z) - 1$  are  $\pm 1$ ,  $\pm \frac{1}{2}\beta \pm i\alpha/\beta$  (multiplicity one) and 0 (multiplicity two), where  $\beta := \sqrt{1 + \sqrt{1 + 4\alpha^2}}$ . The zeros of  $\mathcal{T}'_n(z)$  are 0 and  $\pm 1/\sqrt{2}$ . The inverse

image  $\mathcal{T}_n^{-1}([-1,1])$  is connected and consists of the interval [-1,1] and two analytic Jordan arcs moving from  $\frac{1}{2}\beta + i\alpha/\beta$  and  $-\frac{1}{2}\beta + i\alpha/\beta$  to  $\frac{1}{2}\beta - i\alpha/\beta$  and  $-\frac{1}{2}\beta - i\alpha/\beta$  crossing the interval [-1,1] at  $1/\sqrt{2}$  and  $-1/\sqrt{2}$ , respectively. By Theorem 2, the set  $S = \mathcal{T}_n^{-1}([-1,1])$  is the Pólya-Chebotarev continuum for the  $\nu = 6$  points

$$\{c_1, c_2, c_3, c_4, c_5, c_6\} = \{\pm 1, \pm \frac{1}{2}\beta \pm i\alpha/\beta\}$$

with the bifurcation points  $d_{1,2} = \pm 1/\sqrt{2}$ . In Fig. 5, we have plotted the inverse image  $\mathcal{T}_n^{-1}([-1,1])$  of the polynomial  $\mathcal{T}_n(z)$  defined in (17) for  $\alpha = 2$ . For  $\alpha = 0$ , we get  $\mathcal{T}_n(z) = 8z^4 - 8z^2 + 1$ , i.e. the Chebyshev polynomial of the first kind of degree four.

# 3 Construction of Polynomials with Connected Inverse Image

Let us begin with a statement on a polynomial system of equations, which is valid for the zeros of  $\mathcal{T}_n^2 - 1$ , where  $\mathcal{T}_n \in \mathbb{P}_n$ . For the proof, see [10, Lemma 2.1].

**Lemma 3** ([10]). (i) Let  $\mathcal{T}_n(z) = \tau z^n + \ldots \in \mathbb{P}_n$  and let  $z_1^+, \ldots, z_n^+$  and  $z_1^-, \ldots, z_n^-$  be the zeros of  $\mathcal{T}_n(z) - 1$  and  $\mathcal{T}_n(z) + 1$ , respectively. Then the following polynomial system of equations hold:

$$\sum_{j=1}^{n} (z_j^+)^k - \sum_{j=1}^{n} (z_j^-)^k = 0, \qquad k = 1, 2, \dots, n-1.$$
(18)

(ii) Suppose that  $z_1^+, \ldots, z_n^+, z_1^-, \ldots, z_n^- \in \mathbb{C}$  with  $z_i^+ \neq z_j^-$ ,  $i, j \in \{1, \ldots, n\}$ , satisfy the polynomial system (18). Then there exists a polynomial  $\mathcal{T}_n(z) = \tau z^n + \ldots \in \mathbb{P}_n$  such that

$$\mathcal{T}_n(z) - 1 = \tau \prod_{j=1}^n (z - z_j^+) \quad and \quad \mathcal{T}_n(z) + 1 = \tau \prod_{j=1}^n (z - z_j^-)$$
(19)

holds.

In both cases, the leading coefficient  $\tau$  of  $\mathcal{T}_n$  is given by

$$\tau = -2\prod_{j=1}^{n} (z_1^- - z_j^+)^{-1}.$$
(20)

Next, let us give some further properties of the inverse image  $\mathcal{T}_n^{-1}([-1,1])$  of a polynomial  $\mathcal{T}_n$ , see [16, Lemma 1].

Lemma 4 ([16]). Let  $\mathcal{T}_n \in \mathbb{P}_n$ .

- (i) The inverse image T<sub>n</sub><sup>-1</sup>([-1,1]) consists of n analytic Jordan arcs, denoted by C<sub>1</sub>, C<sub>2</sub>,...,C<sub>n</sub>, where the 2n zeros of T<sub>n</sub><sup>2</sup> 1 are the endpoints of the n arcs. If z<sub>0</sub> ∈ C is a zero of T<sub>n</sub><sup>2</sup> 1 of multiplicity κ then exactly κ analytic Jordan arcs C<sub>i1</sub>, C<sub>i2</sub>,...,C<sub>iκ</sub> of T<sub>n</sub><sup>-1</sup>([-1,1]), 1 ≤ i<sub>1</sub> < i<sub>2</sub> < ... < i<sub>κ</sub> ≤ n, have z<sub>0</sub> as common endpoint. These κ Jordan arcs are cutting each other at successive angles of 2π/κ. If z<sub>0</sub> ∈ C is a double zero of T<sub>n</sub><sup>2</sup> 1 then the two analytic Jordan arcs with the same endpoint z<sub>0</sub> can be conjoined into one analytic Jordan arc.
- (ii) The complement  $\mathbb{C} \setminus \mathcal{T}_n^{-1}([-1,1])$  is connected.

With the help of Lemma 3, we will construct polynomials  $\mathcal{T}_n \in \mathbb{P}_n$  with the property

$$\mathcal{T}'_n(z_0) = 0 \quad \Rightarrow \quad \mathcal{T}_n(z_0) \in \{-1, 1\}.$$

$$\tag{21}$$

Note that if  $\mathcal{T}_n$  satisfies (21) then, by Lemma 2,  $\mathcal{T}_n^{-1}([-1,1])$  is connected.

**Theorem 3.** Suppose that the  $2\nu - 2$  pairwise distinct points  $c_1, \ldots, c_{\nu} \in \mathbb{C}$  and  $d_1, \ldots, d_{\nu-2} \in \mathbb{C}$  satisfy the system

$$\sum_{j=1}^{\nu} \alpha_j c_j^k + 3 \sum_{j=1}^{\nu-2} \gamma_j d_j^k + 2 \sum_{j=1}^{n-2\nu+3} \beta_j z_j^k = 0, \qquad k = 1, 2, \dots, n-1,$$
(22)

where  $z_1, \ldots, z_{n-2\nu+3} \in \mathbb{C}$  pairwise distinct, with  $\alpha_j, \beta_j, \gamma_j \in \{-1, 1\}$  and

$$\sum_{j=1}^{\nu} \alpha_j + 3 \sum_{j=1}^{\nu-2} \gamma_j + 2 \sum_{j=1}^{n-2\nu+3} \beta_j = 0.$$
(23)

Then  $S = \mathcal{T}_n^{-1}([-1,1])$  is the Pólya-Chebotarev continuum for  $\{c_1, \ldots, c_{\nu}\}$  with bifurcation points  $d_1, \ldots, d_{\nu-2}$ , where  $\mathcal{T}_n$  is given by

$$\mathcal{T}_n(z) = 1 + \tau \prod_{\substack{j=1\\\alpha_j=1}}^{\nu} (z - c_j) \cdot \prod_{\substack{j=1\\\gamma_j=1}}^{\nu-2} (z - d_j)^3 \cdot \prod_{\substack{j=1\\\beta_j=1}}^{n-2\nu+3} (z - z_j)^2$$
(24)

and

$$\tau = -2 \Big(\prod_{\substack{j=1\\\alpha_j=1}}^{\nu} (z^- - c_j) \cdot \prod_{\substack{j=1\\\gamma_j=1}}^{\nu-2} (z^- - d_j)^3 \cdot \prod_{\substack{j=1\\\beta_j=1}}^{n-2\nu+3} (z^- - z_j)^2 \Big)^{-1},$$
(25)

where  $z^-$  is either a point  $c_j$  for which  $\alpha_j = -1$  or a point  $d_j$  for which  $\gamma_j = -1$  or a point  $z_j$  for which  $\beta_j = -1$ .

Moreover, the Pólya-Chebotarev continuum  $S = \mathcal{T}_n^{-1}([-1,1])$  consists of  $2\nu - 3$  analytic Jordan arcs, where

- each point  $c_j$ ,  $j = 1, ..., \nu$ , is an endpoint of one analytic Jordan arc;
- each point  $d_j$ ,  $j = 1, ..., \nu 2$ , is an endpoint of three analytic Jordan arcs with an angle of  $2\pi/3$  between two arcs.

*Proof.* Suppose that (22) with (23) holds. By Lemma 3, there exists a polynomial  $\mathcal{T}_n \in \mathbb{P}_n$  such that

$$\mathcal{T}_n^2(z) - 1 = \tau^2 \prod_{j=1}^{\nu} (z - c_j) \cdot \prod_{j=1}^{\nu-2} (z - d_j)^3 \cdot \prod_{j=1}^{n-2\nu+3} (z - z_j)^2.$$
(26)

Since each zero of  $\mathcal{T}_n^2(z) - 1$  of multiplicity  $\kappa$  is a zero of  $2\mathcal{T}_n(z)\mathcal{T}_n'(z)$  of multiplicity  $\kappa - 1$  thus a zero of  $\mathcal{T}_n'(z)$  of multiplicity  $\kappa - 1$ , we get

$$\mathcal{T}'_{n}(z) = n\tau \prod_{j=1}^{\nu-2} (z - d_{j})^{2} \cdot \prod_{j=1}^{n-2\nu+3} (z - z_{j}).$$
(27)

Thus all zeros of  $\mathcal{T}'_n(z)$  are zeros of  $\mathcal{T}^2_n(z) - 1$ , i.e. lie in  $\mathcal{T}^{-1}_n([-1,1])$ , hence, by Lemma 2,  $\mathcal{T}^{-1}_n([-1,1])$  is connected.

The representation (24) with (25) of the polynomial  $\mathcal{T}_n$  follows from (19) with (20).

By (26),  $\mathcal{T}_n^2(z) - 1$  has a factorization of the form (5) with (note that  $c_1, \ldots, c_{\nu}$  and  $d_1, \ldots, d_{\nu-2}$  are pairwise distinct by assumption)

$$\mathcal{H}_{2\ell}(z) := \prod_{j=1}^{\nu} (z - c_j) \cdot \prod_{j=1}^{\nu-2} (z - d_j),$$
(28)

i.e.  $\ell = \nu - 1$ , and

$$\mathcal{U}_{n-\ell}(z) := \tau \prod_{j=1}^{\nu-2} (z - d_j) \cdot \prod_{j=1}^{n-2\nu+3} (z - z_j).$$
(29)

By (6), (27) and (29), the polynomial  $\mathcal{R}_{\ell-1}(z)$  in Lemma 1 is

$$\mathcal{R}_{\ell-1}(z) = \prod_{j=1}^{\nu-2} (z - d_j),$$

thus, by (28),

$$\frac{\mathcal{R}_{\ell-1}(z)}{\sqrt{\mathcal{H}_{2\ell}(z)}} = \frac{\sqrt{\prod_{j=1}^{\nu-2}(z-d_j)}}{\sqrt{\prod_{j=1}^{\nu}(z-c_j)}},$$

and we continue as in the proof of Theorem 2.

The last statement follows immediately by Lemma 4 and the fact that the points  $c_1, \ldots, c_{\nu}$  are simple zeros, the points  $d_1, \ldots, d_{\nu-2}$  are triple zeros and the points  $z_1, \ldots, z_{n-2\nu+3}$  are double zeros of  $\mathcal{T}_n^2(z) - 1$ , respectively.

**Remark.** Consider the simplest case  $\nu = 3$ . In view of (22) and (23), there are 8 possible systems of equations (each with k = 1, ..., n - 1):

$$\begin{split} c_1^k + c_2^k + c_3^k + 3d_1^k + 2\sum_{j=1}^{(n-6)/2} (z_j^+)^k - 2\sum_{j=1}^{n/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k + 3d_1^k + 2\sum_{j=1}^{(n-4)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-2)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k + c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-2)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-4)/2} (z_j^-)^k &= 0\\ c_1^k + c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-2)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-4)/2} (z_j^-)^k &= 0\\ c_1^k + c_2^k + c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-3)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-4)/2} (z_j^-)^k &= 0\\ c_1^k + c_2^k - c_3^k + 3d_1^k + 2\sum_{j=1}^{(n-3)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-3)/2} (z_j^-)^k &= 0\\ c_1^k + c_2^k - c_3^k + 3d_1^k + 2\sum_{j=1}^{(n-5)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k + c_3^k + 3d_1^k + 2\sum_{j=1}^{(n-5)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum_{j=1}^{(n-1)/2} (z_j^-)^k &= 0\\ c_1^k - c_2^k - c_3^k - 3d_1^k + 2\sum_{j=1}^{(n-1)/2} (z_j^+)^k - 2\sum$$

Note that the first and second 4 systems are possible only for n even and n odd, respectively. In [14], the case  $\nu = 3$  is completely solved with the help of Jacobian elliptic and theta functions.

**Remark.** If the assumptions of Theorem 3 are satisfied and  $\mathcal{T}_n$  is given by (24) with (25), by Theorem 3 one can identify  $\mathcal{T}_n^{-1}([-1,1])$  as a *simple ordinary graph* G with no cycles, i.e. a *tree*, with the  $\nu$  vertices  $c_1, \ldots, c_{\nu}$  of degree one, with the  $\nu - 2$  vertices  $d_1, \ldots, d_{\nu-2}$ of degree 3, and  $2\nu - 3$  edges (analytic Jordan arcs). The Pólya-Chebotarev continuum in general can be interpreted as a simple ordinary graph (tree) with no vertices of degree 2, see [7, Definition 1]. **Example.** Consider the special case of  $\nu = 4$  points

$$c_{1,2} = \alpha \pm i\beta, \qquad c_{3,4} = -\alpha \pm i\beta, \qquad \alpha, \beta > 0,$$

which are the vertices of a rectangle. If  $\beta < \alpha$ , it is known [3] that the corresponding Pólya-Chebotarev continuum is symmetric with respect to the real and imaginary axis and the corresponding bifurcation points  $d_1, d_2$  lie on the real axis with  $0 < d_1 < \alpha$  and  $d_2 = -d_1$ , compare Fig. 6. Without loss of generality, let us fix  $\alpha = 1$ . For  $n \in \{5, 6, 7, 8, 9\}$ , below one can find the corresponding system of equations from (22) (note that  $k = 1, \ldots, n-1$ ) and the corresponding solution. For n = 9, note that there are two possible systems. For both cases, we have plotted the corresponding inverse polynomial image in Fig. 6.

c_1^k + c_2^k - c_3^k - c_4^k - 3d_1^k + 3d_2^k = 0 \\
\beta = \frac{\sqrt{5}}{3\sqrt{3}}, \quad d_{1,2} = \pm \frac{2}{3}
\end{cases}$$
•  $n = 6$ :  

$$\begin{cases}
c_1^k + c_2^k + c_3^k + c_4^k - 3d_1^k - 3d_2^k + 2z_1^k = 0 \\
\beta = 2 - \sqrt{3}, \quad d_{1,2} = \pm 2\sqrt{2 - \sqrt{3}}, \quad z_1 = 0
\end{cases}$$
•  $n = 7$ :  

$$\begin{cases}
c_1^k + c_2^k - c_3^k - c_4^k - 3d_1^k + 3d_2^k + 2z_1^k - 2z_2^k = 0 \\
\beta \approx 0.186748, \quad d_{1,2} \approx \pm 0.848275, \quad z_{1,2} \approx \pm 0.272412
\end{cases}$$

• 
$$n = 8$$
:  

$$\begin{cases}
c_1^k + c_2^k + c_3^k + c_4^k - 3d_1^k - 3d_2^k + 2z_1^k - 2z_2^k + 2z_3^k = 0 \\
\beta \approx 0.138701, \quad d_{1,2} \approx \pm 0.885782, \quad z_{1,3} \approx \pm 0.442891, \quad z_2 = 0
\end{cases}$$
•  $n = 9$ :  

$$\begin{cases}
c_1^k + c_2^k - c_3^k - c_4^k - 3d_1^k + 3d_2^k + 2z_1^k - 2z_2^k - 2z_3^k + 2z_4^k = 0 \\
\beta \approx 0.10749, \quad d_{1,2} \approx \pm 0.910657, \quad z_{1,2} \approx \pm 0.558978, \quad z_{3,4} \approx \pm 0.192993
\end{cases}$$

$$\begin{cases}
c_1^k + c_2^k - c_3^k - c_4^k + 3d_1^k - 3d_2^k - 2z_1^k - 2z_2^k + 2z_3^k + 2z_4^k = 0 \\
\beta \approx 0.594803, \quad d_{1,2} \approx \pm 0.541874, \quad z_{1,2} \approx 0.906406 \pm 0.49118 \, i, \\
z_{3,4} \approx -0.906406 \pm 0.49118 \, i
\end{cases}$$

Finally, let us state a conjecture on a certain density result:

**Conjecture 1.** Let  $c_1, \ldots, c_{\nu} \in \mathbb{C}$  be  $\nu$  distinct points. For each  $\varepsilon > 0$  there exists a polynomial  $\mathcal{T}_n \in \mathbb{P}_n$  such that  $S = \mathcal{T}_n^{-1}([-1,1])$  is the Pólya-Chebotarev continuum for  $\{\tilde{c}_1, \ldots, \tilde{c}_{\nu}\}$  with  $|c_j - \tilde{c}_j| < \varepsilon, j = 1, \ldots, \nu$ .
