# Construction of class fields over imaginary biquadratic fields

#### Abstract

Let K be an imaginary biquadratic field and  $K_1$ ,  $K_2$  be its imaginary quadratic subfields. For integers N > 0,  $\mu \ge 0$  and an odd prime p with gcd(N,p) = 1, let  $K_{(Np^{\mu})}$  and  $(K_i)_{(Np^{\mu})}$  for i = 1, 2 be the ray class fields of K and  $K_i$ , respectively, modulo  $Np^{\mu}$ . We first present certain class fields  $\widetilde{K_{N,p,\mu}^{1,2}}$  of K, in the sense of Hilbert, which are generated by Siegel-Ramachandra invariants of  $(K_i)_{(Np^{\mu+1})}$  for i = 1, 2over  $K_{(Np^{\mu})}$  and show that  $K_{(Np^{\mu+1})} = \widetilde{K_{N,p,\mu}^{1,2}}$  for almost all  $\mu$ .

#### 1 Introduction

In 1900 Hilbert asked at the Paris ICM, as his 12-th problem, that what kind of analytic functions and algebraic numbers are necessary to construct all abelian extensions of given number fields. For any number field K and a modulus  $\mathfrak{m}$  of K, it is well known that there is a unique maximal abelian extension of K unramified outside  $\mathfrak{m}$  with certain ramification condition ([27] or [6, Theorem 8.6]), which we call the *ray class field* of K modulo  $\mathfrak{m}$ . Since any abelian extension of K is contained in some ray class field modulo  $\mathfrak{m}$  by class field theory, in order to approach the problem we are first in need of constructing ray class fields of given number fields as Ramachandra did in [19] over imaginary quadratic fields.

Historically, over imaginary quadratic fields, after Hasse ([8]) one can now construct it by using the theory of complex multiplication of elliptic curves together with the singular values of modular functions and elliptic functions ([15, Chapter 10] or [23]). However, for any other number fields we know relatively little until now. For example, over cyclotomic

field see [12], [13], [20] (also [18]), [21], and over biquadratic fields we refer to [1], [2], [3], [4], [26] and [28].

In this paper we will concentrate on the case of imaginary biquadratic fields K. There are two imaginary quadratic subfields  $K_1$ ,  $K_2$  in K. For integers N > 0,  $\mu \ge 0$  and an odd prime p with gcd(N,p) = 1, we denote by  $K_{(Np^{\mu})}$  and  $(K_i)_{(Np^{\mu})}$  for i = 1, 2 the ray class fields of K and  $K_i$  modulo  $Np^{\mu}$ , respectively. In Section 2, we apply Shimura's reciprocity law to the field K and put emphasis on the necessity of using modular units to construct class fields over K as Hilbert proposed. On the other hand, Jung-Koo-Shin ([10, Theorem 3.5]) constructed relatively simple ray class invariants over imaginary quadratic fields by means of the singular values of certain Siegel functions, namely, Siegel-Ramachandra invariants. Using this idea we define in Section 4 and 5 certain class field  $\widetilde{K_{N,p,\mu}^{1,2}}$  of K which is generated by Siegel-Ramachandra invariants of  $(K_i)_{(Np^{\mu+1})}$  for i = 1, 2 over  $K_{(Np^{\mu})}$ , and provide a necessary and sufficient condition for the field  $\widetilde{K_{N,p,\mu}^{1,2}}$  to become  $K_{(Np^{\mu+1})}$  (Theorem 4.7 and 5.4).

NOTATION 1.1. For  $z \in \mathbb{C}$ , we denote by  $\overline{z}$  the complex conjugate of z and put  $e(z) = e^{2\pi i z}$ . If R is a ring with identity and  $r, s \in \mathbb{Z}_{>0}$ ,  $M_{r \times s}(R)$  indicates the ring of all  $r \times s$  matrices with entries in R. In particular, we set  $M_r(R) = M_{r \times r}(R)$ . The identity matrix of  $M_r(R)$  is written by  $1_r$  and the transpose of a matrix  $\alpha$  is written as  ${}^t\alpha$ . And,  $R^{\times}$  means the group of all invertible elements of R. If G is a group and  $g_1, g_2, \ldots, g_r$  are elements of G, let  $\langle g_1, g_2, \ldots, g_r \rangle$  be the subgroup of G generated by  $g_1, g_2, \ldots, g_r$ . For a number field K, let  $\mathcal{O}_K$  be the ring of integers of K. If  $a \in \mathcal{O}_K$  we denote by (a) the principal ideal of K generated by a. When  $\mathfrak{f}$  is an integral ideal of K, we mean by  $\mathcal{N}(\mathfrak{f})$  the absolute norm of an ideal  $\mathfrak{f}$ . For a finite extension L of K, let [L:K] be the extension degree of L over K. When L/K is abelian, we mean by  $\left(\frac{L/K}{\cdot}\right)$  the Artin map of L/K. Further, we let  $\zeta_N = e^{2\pi i/N}$  be a primitive N-th root of unity for a positive integer N.

## 2 Shimura's reciprocity law on imaginary biquadratic fields

In this section we shall briefly recall Siegel modular forms and apply Shimura's reciprocity law to an imaginary biquadratic field.

Let n be a positive integer and

$$J = J_n = \begin{bmatrix} 0 & -1_n \\ 1_n & 0 \end{bmatrix}.$$

For a commutative ring R with unity, we let

$$GSp_{2n}(R) = \left\{ \alpha \in GL_{2n}(R) \mid {}^{t}\alpha J\alpha = \nu(\alpha)J \text{ with } \nu(\alpha) \in R^{\times} \right\}$$
$$Sp_{2n}(R) = \left\{ \alpha \in GSp_{2n}(R) \mid \nu(\alpha) = 1 \right\}.$$

We set  $G_{\mathbb{Q}} = \mathrm{GSp}_{2n}(\mathbb{Q})$  and  $G_{\mathbb{Q}+} = \{ \alpha \in G_{\mathbb{Q}} \mid \nu(\alpha) > 0 \}$ . Let

$$\mathbb{H}_n = \{ Z \in M_n(\mathbb{C}) \mid {}^t Z = Z, \ \operatorname{Im}(Z) > 0 \}$$

be the Siegel upper half-space of degree n. Here, for a hermitian matrix  $\xi$  we write  $\xi > 0$ when  $\xi$  is positive definite. An element  $\alpha = \begin{bmatrix} A & B \\ C & D \end{bmatrix}$  of  $G_{\mathbb{Q}+}$  acts on  $\mathbb{H}_n$  by

$$\alpha(Z) = (AZ + B)(CZ + D)^{-1},$$

where  $A, B, C, D \in M_n(\mathbb{Q})$ .

For every positive integer N, let

$$\Gamma(N) = \left\{ \gamma \in \operatorname{Sp}_{2n}(\mathbb{Z}) \mid \gamma \equiv 1_{2n} \pmod{N \cdot M_{2n}(\mathbb{Z})} \right\}.$$

For an integer k a holomorphic function  $f : \mathbb{H}_n \to \mathbb{C}$  is called a *(classical) Siegel modular* form of degree n, weight k and level N if

$$f(\gamma(Z)) = \det(CZ + D)^k f(Z)$$

for all  $\gamma = \begin{bmatrix} A & B \\ C & D \end{bmatrix} \in \Gamma(N)$  and  $Z \in \mathbb{H}_n$ , plus the requirement that f is holomorphic at every cusp when n = 1. A Siegel modular form f of degree n and level N has a Fourier expansion of the form

$$f(Z) = \sum_{\xi} A(\xi) e(\operatorname{tr}(\xi Z)/N)$$

with  $A(\xi) \in \mathbb{C}$ , where  $\xi$  runs over all positive semi-definite half-integral symmetric matrices of degree n [11, §4 Theorem 1]. Here, a symmetric matrix  $\xi \in \mathrm{GL}_n(\mathbb{Q})$  is called *half-integral* if  $2\xi$  is an integral matrix and its diagonal entries are even.

For a subfield D of  $\mathbb{C}$ , let

 $\mathcal{M}_k^n(\Gamma(N), D) =$  the space of Siegel modular forms of weight k and level N with Fourier coefficients in D,

$$\mathcal{M}_k^n(D) = \bigcup_{N=1}^\infty \mathcal{M}_k^n(\Gamma(N), D),$$

$$\mathcal{A}_{0}^{n}(\Gamma(N), D) = \text{ the field of functions of the form } g/h$$
  
with  $g \in \mathcal{M}_{k}^{n}(D)$  and  $h \in \mathcal{M}_{k}^{n}(D) \setminus \{0\}$  for the same weight  $k$ ,  
which are invariant under  $\Gamma(N)$ .

In particular, we set

$$\mathcal{F}_N^n = \mathcal{A}_0^n \big( \Gamma(N), \mathbb{Q}(\zeta_N) \big),$$
  
$$\mathcal{F}^n = \bigcup_{N=1}^{\infty} \mathcal{F}_N^n.$$

Let  $G_{\mathbb{A}}$  be the adelization of the group  $G_{\mathbb{Q}}$ ,  $G_0$  be the non-archimedean part of  $G_{\mathbb{A}}$  and  $G_{\infty}$  be the archimedean part of  $G_{\mathbb{A}}$ . Then  $\nu$  in (2.1) defines a homomorphism  $G_{\mathbb{A}} \to \mathbb{Q}_{\mathbb{A}}^{\times}$ . We put  $G_{\infty+} = \{x \in G_{\infty} \mid \nu(x) > 0\}$  and  $G_{\mathbb{A}+} = G_0 G_{\infty+}$ . For every algebraic number field F, let  $F_{ab}$  be the maximal abelian extension of F and  $F_{\mathbb{A}}^{\times}$  be the idele group of F. By class field theory, every element x of  $F_{\mathbb{A}}^{\times}$  acts on the field  $F_{ab}$  as an automorphism. We then write this automorphism as [x, F]. On the other hand, any element of  $G_{\mathbb{A}+}$  acts on the space  $\mathcal{A}_0^n(\mathbb{Q}_{ab})$  as an automorphism ([22, p.680]). If  $x \in G_{\mathbb{A}+}$  and  $f \in \mathcal{A}_0^n(\mathbb{Q}_{ab})$ , by  $f^x$  we mean the image of f under x.

For each index i = 1, 2, let  $K_i = \mathbb{Q}(\sqrt{-d_i})$  be an imaginary quadratic field with square-free positive integer  $d_i$  and set

$$\rho_i = \begin{cases} -\frac{1}{\sqrt{-d_i}} & \text{if } -d_i \equiv 1 \pmod{4} \\ -\frac{1}{2\sqrt{-d_i}} & \text{if } -d_i \equiv 2, 3 \pmod{4} \end{cases}$$

Note that  $\rho_i$  is the number in  $K_i$  for which  $-\rho_i^2$  is totally positive,  $\operatorname{Im}(\rho_i) > 0$  and  $\operatorname{Tr}_{K_i/\mathbb{Q}}(\rho_i x) \in \mathbb{Z}$  for all  $x \in \mathcal{O}_{K_i}$ . Let  $L_i = \mathcal{O}_{K_i}$  be a lattice in  $\mathbb{C}$ . Then, for  $z_i, w_i \in \mathbb{C}$  we define an  $\mathbb{R}$ -bilinear form  $E_i(z_i, w_i)$  on  $\mathbb{C}$  by

$$E_i(z_i, w_i) = \rho_i(z_i \overline{w_i} - \overline{z_i} w_i).$$

And,  $E_i$  becomes a non-degenerate Riemann form on the complex torus  $\mathbb{C}/L_i$  satisfying

$$E_i(\alpha_i, \beta_i) = \operatorname{Tr}_{K_i/\mathbb{Q}}(\rho_i \alpha_i \overline{\beta_i}) \text{ for } \alpha_i, \beta_i \in K_i,$$

which makes it an elliptic curve as a polarized abelian variety ([24, p.43–44]). Let

$$\theta_i = \begin{cases} (-1 + \sqrt{-d_i})/2 & \text{if } -d_i \equiv 1 \pmod{4} \\ \sqrt{-d_i} & \text{if } -d_i \equiv 2, 3 \pmod{4} \end{cases}$$

and let  $\Omega_i = \begin{bmatrix} \theta_i & 1 \end{bmatrix} \in M_{1 \times 2}(\mathbb{C})$ . Then  $\mathcal{O}_{K_i} = \mathbb{Z}[\theta_i]$  and  $\Omega_i$  satisfies

$$L_{i} = \left\{ \Omega_{i} \begin{bmatrix} a \\ b \end{bmatrix} \mid a, b \in \mathbb{Z} \right\},$$
$$E_{i}(\Omega_{i}\mathbf{x}, \Omega_{i}\mathbf{y}) = {}^{t}\mathbf{x}J_{1}\mathbf{y} \text{ for } \mathbf{x}, \mathbf{y} \in \mathbb{R}^{2}.$$

On the other hand, we define a ring monomorphism  $h_i: K_i \to M_2(\mathbb{Q})$  by

$$\begin{bmatrix} \alpha_i \theta_i \\ \alpha_i \end{bmatrix} = h_i(\alpha_i) \begin{bmatrix} \theta_i \\ 1 \end{bmatrix} \text{ for } \alpha_i \in K_i,$$

in other words,  $h_i(\alpha_i)$  is the regular representation of  $\alpha_i$  with respect to  $\{\theta_i, 1\}$ . Then  $\theta_i$  becomes the CM-point of  $\mathbb{H}_1$  induced from  $h_i$  which corresponds to the elliptic curve  $(\mathbb{C}/L_i, E_i)$  ([22, p.684-685] or [24, §24.10]).

Now, let  $Y = K_1 \oplus K_2$  be a CM-algebra so that  $[Y : \mathbb{Q}] = 4$ ,  $\mathcal{O}_Y = \mathcal{O}_{K_1} \oplus \mathcal{O}_{K_2}$  and  $\rho = (\rho_1, \rho_2) \in Y$ . We denote by

$$v(\alpha) = \begin{bmatrix} \alpha_1 \\ \alpha_2 \end{bmatrix}$$
 for  $\alpha = (\alpha_1, \alpha_2) \in Y$ .

Let  $L = \{v(\alpha) \mid \alpha \in \mathcal{O}_Y\}$  be a lattice in  $\mathbb{C}^2$ . For  $\mathbf{z} = {}^t \begin{bmatrix} z_1 & z_2 \end{bmatrix}$  and  $\mathbf{w} = {}^t \begin{bmatrix} w_1 & w_2 \end{bmatrix}$  in  $\mathbb{C}^2$ , we define an  $\mathbb{R}$ -bilinear form  $E(\mathbf{z}, \mathbf{w})$  on  $\mathbb{C}^2$  by

$$E(\mathbf{z}, \mathbf{w}) = \sum_{i=1}^{2} E_i(z_i, w_i).$$

Then E becomes a non-degenerate Riemann form on the complex torus  $\mathbb{C}^2/L$  satisfying

$$E(v(\alpha), v(\beta)) = \operatorname{Tr}_{Y/\mathbb{Q}}(\rho \alpha \overline{\beta}) = \sum_{i=1}^{2} \operatorname{Tr}_{K_{i}/\mathbb{Q}}(\rho_{i} \alpha_{i} \overline{\beta_{i}}) \quad \text{for } \alpha = (\alpha_{i}), \beta = (\beta_{i}) \in Y,$$

which also makes it a polarized abelian variety ([24, p.43–44, 129–130]). Let

$$\Omega = \begin{bmatrix} \theta_1 & 0 & 1 & 0 \\ 0 & \theta_2 & 0 & 1 \end{bmatrix} \in M_{2 \times 4}(\mathbb{C}).$$

Then  $\Omega$  satisfies

$$L = \left\{ \Omega \begin{bmatrix} \mathbf{a} \\ \mathbf{b} \end{bmatrix} \mid \mathbf{a}, \mathbf{b} \in \mathbb{Z}^2 \right\},$$
$$E(\Omega \mathbf{x}, \Omega \mathbf{y}) = {}^t \mathbf{x} J_2 \mathbf{y} \text{ for } \mathbf{x}, \mathbf{y} \in \mathbb{R}^4.$$

Here, we write  $\Omega = \begin{bmatrix} \Omega_1 & \Omega_2 \end{bmatrix} = \begin{bmatrix} v(e_1) & v(e_2) & v(e_3) \end{bmatrix}$  with  $\Omega_1, \Omega_2 \in M_2(\mathbb{C})$  and  $e_1, e_2, e_3, e_4 \in Y$ . Then  $\{e_1, e_2, e_3, e_4\}$  is a free  $\mathbb{Q}$ -basis of Y, so we can define a ring monomorphism  $h: Y \to M_4(\mathbb{Q})$  by

$$\begin{bmatrix} \alpha e_1 \\ \vdots \\ \alpha e_4 \end{bmatrix} = h(\alpha) \begin{bmatrix} e_1 \\ \vdots \\ e_4 \end{bmatrix} \quad \text{for } \alpha \in Y,$$

that is,  $h(\alpha)$  is the regular representation of  $\alpha$  with respect to  $\{e_1, e_2, e_3, e_4\}$ . One can then readily show that  $Z_0 = \Omega_2^{-1}\Omega_1 = \begin{bmatrix} \theta_1 & 0 \\ 0 & \theta_2 \end{bmatrix}$  is the CM-point of  $\mathbb{H}_2$  induced from h which corresponds to the polarized abelian variety  $(\mathbb{C}^2/L, E)$  ([22, p.684-685] or [24, §24.10]).

Let  $K = \mathbb{Q}(\sqrt{-d_1}, \sqrt{-d_2})$  be an imaginary biquadratic field which is the composite field of  $K_1$  and  $K_2$ . Let  $Y_{\mathbb{A}} = \prod_{i=1}^2 (K_i)_{\mathbb{A}}$  and  $Y_{\mathbb{A}}^{\times} = \prod_{i=1}^2 (K_i)_{\mathbb{A}}^{\times}$ . We define a map  $\varphi: K_{\mathbb{A}}^{\times} \to Y_{\mathbb{A}}^{\times}$  by

$$\varphi(x) = \left(N_{K/K_i}(x)\right)_{1 \le i \le 2} \text{ for } x \in K^{\times}_{\mathbb{A}}.$$

Then the map h can be naturally extended to a homomorphism  $Y_{\mathbb{A}} \to M_4(\mathbb{Q}_{\mathbb{A}})$ , which we also denote by h. Hence, for every  $b \in K_{\mathbb{A}}^{\times}$  we get  $\nu(h(\varphi(b))) = N_{K/\mathbb{Q}}(b)$  and  $h(\varphi(b)^{-1}) \in G_{\mathbb{A}+}$  ([24, p.172]).

PROPOSITION 2.1 (Shimura's reciprocity law). Let Y, h,  $Z_0$  and K be as above. Then for every  $f \in \mathcal{A}^2_0(\mathbb{Q}_{ab})$  which is finite at  $Z_0$ , the value  $f(Z_0)$  belongs to  $K_{ab}$ . Moreover, if  $b \in K^{\times}_{\mathbb{A}}$ , then  $f^{h(\varphi(b)^{-1})}$  is finite at  $Z_0$  and

$$f(Z_0)^{[b,K]} = f^{h(\varphi(b)^{-1})}(Z_0).$$

PROOF. [24, Theorem 26.8].

REMARK 2.2. For any  $f \in \mathcal{A}_0^2(\mathbb{Q}_{ab})$  that is finite at  $Z_0$ , the value  $f(Z_0)$  indeed belongs to the class field  $\widetilde{K_{ab}}$  of K corresponding to the kernel of  $\varphi$ .

Now, we define a subset  $\mathbb{H}_2^{\text{diag}}$  of the Siegel upper half-space  $\mathbb{H}_2$  by

$$\mathbb{H}_2^{\text{diag}} = \left\{ \begin{bmatrix} z_1 & 0\\ 0 & z_2 \end{bmatrix} \mid z_1, z_2 \in \mathbb{H}_1 \right\}.$$

Clearly, the CM-point  $Z_0$  belongs to  $\mathbb{H}_2^{\text{diag}}$ . A function f in  $\mathcal{F}_N^1$  is called a *modular unit* of level N if it has no zeros and poles on  $\mathbb{H}_1$  [14, p.36].

PROPOSITION 2.3. Let  $N \geq 2$  be an integer and  $f \in \mathcal{F}_N^2$ . Then f has no zeros and poles on  $\mathbb{H}_2^{\text{diag}}$  if and only if there exist modular units  $f_1, f_2$  of level N such that

$$f\left(\begin{bmatrix} z_1 & 0\\ 0 & z_2 \end{bmatrix}\right) = f_1(z_1)f_2(z_2).$$

PROOF. See [7, Theorem 4.2].

Thus, we see from Proposition 2.3 that it is natural to investigate the class field of K generated by the singular values  $f(\theta_i)$  of modular units f.

#### 3 Siegel-Ramachandra invariants

In this section we shall introduce the well-known modular units, Siegel functions, and review some necessary facts about the Siegel-Ramachandra invariants as singular values of Siegel functions.

For a rational vector  $\mathbf{r} = \begin{bmatrix} r_1 \\ r_2 \end{bmatrix} \in (1/N)\mathbb{Z}^2 \setminus \mathbb{Z}^2$  with an integer  $N \ge 2$ , we define the Siegel function  $g_{\mathbf{r}}(\tau)$  on  $\tau \in \mathbb{H}_1$  by the following infinite product

$$g_{\mathbf{r}}(\tau) = -q^{\frac{1}{2}\mathbf{B}_{2}(r_{1})}e^{\pi i r_{2}(r_{1}-1)}(1-q^{r_{1}}e^{2\pi i r_{2}})\prod_{n=1}^{\infty}(1-q^{n+r_{1}}e^{2\pi i r_{2}})(1-q^{n-r_{1}}e^{-2\pi i r_{2}}),$$

where  $\mathbf{B}_2(X) = X^2 - X + 1/6$  is the second Bernoulli polynomial and  $q = e^{2\pi i \tau}$ . Then a Siegel function is a modular unit, namely, it is a modular function which has no zeros and poles on  $\mathbb{H}_1$  ([25] or [14, p.36]). Furthermore, the function  $g_{\mathbf{r}}(\tau)^{12N}$  belongs to  $\mathcal{F}_N^1$ .

Let F be a number field and  $\mathfrak{m}$  be a modulus of F. A modulus  $\mathfrak{m}$  may be written as  $\mathfrak{m}_0\mathfrak{m}_\infty$ , where  $\mathfrak{m}_0$  is an integral ideal of F and  $\mathfrak{m}_\infty$  is a product of distinct real infinite primes of F. Let  $I_F(\mathfrak{m})$  be the group of all fractional ideals of F which are relatively prime to  $\mathfrak{m}$  and  $P_{F,1}(\mathfrak{m})$  be the subgroup of  $I_F(\mathfrak{m})$  generated by the principal ideals  $\alpha \mathcal{O}_F$ , where  $\alpha \in \mathcal{O}_F$  satisfies

- (i)  $\alpha \equiv 1 \pmod{\mathfrak{m}_0}$
- (ii)  $\tau(\alpha) > 0$  for every real infinite prime  $\tau$  dividing  $\mathfrak{m}_{\infty}$ .

Further, we let  $\operatorname{Cl}_F(\mathfrak{m}) = I_F(\mathfrak{m})/P_{F,1}(\mathfrak{m})$  be the ray class group of F modulo  $\mathfrak{m}$ . Then there exists a unique abelian extension  $F_{\mathfrak{m}}$  of F whose Galois group is isomorphic to  $\operatorname{Cl}_F(\mathfrak{m})$  via the Artin map ([6, Theorem 8.6]). Here, the field  $F_{\mathfrak{m}}$  is called the *ray class* field of F modulo  $\mathfrak{m}$ . And, it is well-known ([6, Theorem 8.2]) that any finite abelian extension of F is contained in some ray class field  $F_{\mathfrak{m}}$ .

From now on, let  $F = \mathbb{Q}(\sqrt{-d})$  be an imaginary quadratic field with square-free positive integer d and let

$$\theta = \begin{cases} (-1 + \sqrt{-d})/2 & \text{if } -d \equiv 1 \pmod{4} \\ \sqrt{-d} & \text{if } -d \equiv 2, 3 \pmod{4} \end{cases}$$

so that  $\mathcal{O}_F = \mathbb{Z}[\theta]$ . Let  $\mathfrak{f}$  be a nontrivial proper integral ideal of F and N be the smallest positive integer in  $\mathfrak{f}$ . For  $C \in \operatorname{Cl}_F(\mathfrak{f})$ , we take any integral ideal  $\mathfrak{c}$  in C and choose a basis  $[\omega_1, \omega_2]$  of  $\mathfrak{f}\mathfrak{c}^{-1}$  such that  $\omega_1/\omega_2 \in \mathbb{H}_1$ . Then we can write

$$N = r_1 \omega_1 + r_2 \omega_2$$

for some  $r_1, r_2 \in \mathbb{Z}$ . We define the Siegel-Ramachandra invariant of conductor  $\mathfrak{f}$  at C by

$$g_{\mathfrak{f}}(C) = g_{\left[ {r_1/N \atop r_2/N} \right]} (\omega_1/\omega_2)^{12N}$$

This value depends only on the class C and  $\mathfrak{f}$ , not on the choice of  $\mathfrak{c}$ .

PROPOSITION 3.1. Let  $\mathfrak{f} = N\mathcal{O}_F$  with an integer  $N \geq 2$  and  $C_0$  be the unit class in  $\operatorname{Cl}_F(\mathfrak{f})$ . Assume that  $F \neq \mathbb{Q}(\sqrt{-1}), \mathbb{Q}(\sqrt{-3})$ . Then the value

$$g_{\mathfrak{f}}(C_0) = g_{\left[\begin{smallmatrix} 0\\1/N \end{smallmatrix}\right]}(\theta)^{12N}.$$

is a real algebraic integer. Moreover, for any positive integer n, we get

$$F_{(N)} = F(g_{\mathfrak{f}}(C_0)^n).$$

PROOF. [10, Theorem 3.5 and Remark 3.6]

#### 4 Class fields over imaginary biquadratic fields (I)

We shall consider an imaginary biquadratic field  $K = \mathbb{Q}(\sqrt{-d_1}, \sqrt{-d_2})$  where  $d_1$ ,  $d_2$  are square-free positive integer such that  $-d_1 \equiv 1 \pmod{4}$ ,  $-d_2 \equiv 2, 3 \pmod{4}$  and  $\gcd(d_1, d_2) = 1$ . Then we have two imaginary quadratic subfields  $K_1 = \mathbb{Q}(\sqrt{-d_1})$ ,  $K_2 = \mathbb{Q}(\sqrt{-d_2})$  and one real quadratic subfield  $K_3 = \mathbb{Q}(\sqrt{d_1d_2})$  in K.

LEMMA 4.1. The ring of integers  $\mathcal{O}_K$  of K is  $\mathbb{Z}\left[(-1+\sqrt{-d_1})/2, \sqrt{-d_2}\right]$ . Consequently,

$$\mathcal{O}_{K} = \left\{ \frac{1}{2} \left[ a + b\sqrt{-d_{1}} + c\sqrt{-d_{2}} + d\sqrt{d_{1}d_{2}} \right] \ \left| \ a, b, c, d \in \mathbb{Z}, \ a \equiv b \pmod{2}, \ c \equiv d \pmod{2} \right\} \right\}$$

PROOF. By [9, Chapter I, Theorem 9.5] we have  $\mathcal{O}_K = \mathcal{O}_{K_1}\mathcal{O}_{K_2} = \mathbb{Z}\left[\frac{-1+\sqrt{-d_1}}{2}, \sqrt{-d_2}\right]$ . Hence we deduce

$$\mathcal{O}_{K} = \left\{ A + B\left(\frac{-1 + \sqrt{-d_{1}}}{2}\right) + C\sqrt{-d_{2}} + D\left(\frac{-\sqrt{-d_{2}} - \sqrt{d_{1}d_{2}}}{2}\right) \mid A, B, C, D \in \mathbb{Z} \right\}$$
  
$$= \left\{ \frac{1}{2} \left[ (2A - B) + B\sqrt{-d_{1}} + (2C - D)\sqrt{-d_{2}} - D\sqrt{d_{1}d_{2}} \right] \mid A, B, C, D \in \mathbb{Z} \right\}$$
  
$$= \left\{ \frac{1}{2} \left[ a + b\sqrt{-d_{1}} + c\sqrt{-d_{2}} + d\sqrt{d_{1}d_{2}} \right] \mid a, b, c, d \in \mathbb{Z}, \ a \equiv b \pmod{2}, \ c \equiv d \pmod{2} \right\}.$$

Let N be a positive integer and p be an odd prime not dividing N. For a non-negative integer  $\mu$ , we set

$$S_{N,p,\mu} = \{a \in K^{\times} \mid a \equiv 1 \pmod{Np^{\mu}\mathcal{O}_K}, a \text{ is prime to } p\mathcal{O}_K\},$$
  

$$S_{N,p,\mu}^{(i)} = \{a \in K_i^{\times} \mid a \equiv 1 \pmod{Np^{\mu}\mathcal{O}_{K_i}}, a \text{ is prime to } p\mathcal{O}_{K_i}\} \text{ for } i = 1, 2.$$

Further, we let

$$\begin{aligned} H_{N,p,\mu} &= S_{N,p,\mu+1}(S_{N,p,\mu} \cap \mathcal{O}_K^{\times}), \\ H_{N,p,\mu}^{(i)} &= S_{N,p,\mu+1}^{(i)}(S_{N,p,\mu}^{(i)} \cap \mathcal{O}_{K_i}^{\times}) \quad \text{for } i = 1, 2. \end{aligned}$$

Then we achieve the isomorphisms

(4.1) 
$$\begin{aligned} \operatorname{Gal}(K_{(Np^{\mu+1})}/K_{(Np^{\mu})}) &\cong S_{N,p,\mu}\mathcal{O}_{K}^{\times}/S_{N,p,\mu+1}\mathcal{O}_{K}^{\times} &\cong S_{N,p,\mu}/H_{N,p,\mu} \\ \operatorname{Gal}((K_{i})_{(Np^{\mu+1})}/(K_{i})_{(Np^{\mu})}) &\cong S_{N,p,\mu}^{(i)}\mathcal{O}_{K_{i}}^{\times}/S_{N,p,\mu+1}^{(i)}\mathcal{O}_{K_{i}}^{\times} &\cong S_{N,p,\mu}^{(i)}/H_{N,p,\mu}^{(i)} \end{aligned}$$

by class field theory ([9, Chapter V §6]). Since  $N_{K/K_i}(H_{N,p,\mu}) \subset H_{N,p,\mu}^{(i)}$  for i = 1, 2, we can define a homomorphism

$$\widetilde{\varphi_{N,p,\mu}^{1,2}}: S_{N,p,\mu}/H_{N,p,\mu} \to S_{N,p,\mu}^{(1)}/H_{N,p,\mu}^{(1)} \times S_{N,p,\mu}^{(2)}/H_{N,p,\mu}^{(2)}$$

by

$$\widetilde{\varphi_{N,p,\mu}^{1,2}}(aH_{N,p,\mu}) = \left(N_{K/K_1}(a)H_{N,p,\mu}^{(1)}, N_{K/K_2}(a)H_{N,p,\mu}^{(2)}\right)$$

Let  $\widetilde{K_{N,p,\mu}^{1,2}}$  be the class field of K corresponding to  $\ker(\widetilde{\varphi_{N,p,\mu}^{1,2}})$ . Note that

$$\widetilde{K_{N,p,\mu}^{1,2}} = K_{(Np^{\mu})}(K_{(Np^{\mu+1})} \cap \widetilde{K_{\mathrm{ab}}}),$$

where  $\widetilde{K_{ab}}$  is the class field of K described in Remark 2.2.

LEMMA 4.2. With the notations as above, for a non-negative integer  $\mu$  we obtain

$$\widetilde{K_{N,p,\mu}^{1,2}} = K_{(Np^{\mu})}(K_1)_{(Np^{\mu+1})}(K_2)_{(Np^{\mu+1})}.$$

PROOF. For each index i = 1, 2, let  $\gamma_i$  be a primitive generator of  $(K_i)_{(Np^{\mu+1})}$  over  $(K_i)_{(Np^{\mu})}$ . Since  $(K_i)_{(Np^{\mu})} \subset K_{(Np^{\mu})}$  for i = 1, 2, we attain

$$K_{(Np^{\mu})}(K_1)_{(Np^{\mu+1})}(K_2)_{(Np^{\mu+1})} = K_{(Np^{\mu})}(\gamma_1, \gamma_2).$$

If  $aH_{N,p,\mu} \in \ker(\widetilde{\varphi_{N,p,\mu}^{1,2}})$ , then  $N_{K/K_i}(a) \in H_{N,p,\mu}^{(i)}$  for i = 1, 2. Since  $\gamma_i \in (K_i)_{(Np^{\mu+1})}$ , we have

$$\gamma_i^{\left(\frac{K_{(Np^{\mu+1})}/K}{(a)}\right)} = \gamma_i^{\left(\frac{(K_i)_{(Np^{\mu+1})}/K_i}{N_{K/K_i}((a))}\right)} = \gamma_i \quad \text{for } i = 1, 2$$

([9, Chapter III §3]). Hence  $\widetilde{K_{N,p,\mu}^{1,2}} \supset K_{(Np^{\mu})}(\gamma_1, \gamma_2)$ . Conversely, let  $bH_{N,p,\mu} \in S_{N,p,\mu}/H_{N,p,\mu}$  such that

$$\gamma_i^{\left(\frac{K_{(Np^{\mu+1})}/K}{(b)}\right)} = \gamma_i \quad \text{for } i = 1, 2.$$

Since  $\gamma_i$  is the primitive generator of  $(K_i)_{(Np^{\mu+1})}/(K_i)_{(Np^{\mu})}$ , we obtain  $N_{K/K_i}(b) \in H_{N,p,\mu}^{(i)}$ for i = 1, 2 by (4.1). Thus  $bH_{N,p,\mu} \in \ker(\varphi_{N,p,\mu}^{1,2})$ , and so  $K_{N,p,\mu}^{1,2} \subset K_{(Np^{\mu})}(\gamma_1, \gamma_2)$ . This completes the proof.

For a non-negative integer  $\mu$  and i = 1, 2, we let  $\mathfrak{f}_{\mu,i} = N p^{\mu} \mathcal{O}_{K_i}$  and  $C_{\mu,i}$  be the unit class in  $\operatorname{Cl}_{K_i}(\mathfrak{f}_{\mu,i})$ .

COROLLARY 4.3. Assume that  $K_1, K_2 \neq \mathbb{Q}(\sqrt{-1}), \mathbb{Q}(\sqrt{-3})$ . For any positive integers  $n_1, n_2$ , the value

$$\prod_{i=1}^{2} g_{\mathfrak{f}_{\mu+1,i}} (C_{\mu+1,i})^n$$

generates  $\widetilde{K_{N,p,\mu}^{1,2}}$  over  $K_{(Np^{\mu})}$ .

**PROOF.** It follows from Proposition 3.1 and Lemma 4.2 that

$$\widetilde{K_{N,p,\mu}^{1,2}} = K_{(Np^{\mu})} \Big( g_{\mathfrak{f}_{\mu+1,1}} (C_{\mu+1,1})^{n_1}, \ g_{\mathfrak{f}_{\mu+1,2}} (C_{\mu+1,2})^{n_2} \Big).$$

Note that

$$\left| (g_{\mathfrak{f}_{\mu+1,i}} (C_{\mu+1,i})^{n_i})^{\tau} \right| > \left| g_{\mathfrak{f}_{\mu+1,i}} (C_{\mu+1,i})^{n_i} \right|$$

for i = 1, 2 and  $\tau \in \text{Gal}((K_i)_{(Np^{\mu+1})}/K_i) \setminus \{\text{Id}\}$  ([10, Theorem 3.5 and Remark 3.6]). Hence

$$\left(\prod_{i=1}^{2} g_{\mathfrak{f}_{\mu+1,i}}(C_{\mu+1,i})^{n_i}\right)' \neq \prod_{i=1}^{2} g_{\mathfrak{f}_{\mu+1,i}}(C_{\mu+1,i})^{n_i}$$

for  $\tau \in \operatorname{Gal}(\widetilde{K_{N,p,\mu}^{1,2}}/K_{(Np^{\mu})}) \setminus {\mathrm{Id}}$ . This proves the corollary.

In this section we shall consider only the case  $\mu = 0$ . As for the other cases, see Section 5.

LEMMA 4.4. With the notation as above, we get

$$|S_{N,p,0}/S_{N,p,1}| = (p-1)\prod_{j=1}^{3} m_{p,j},$$

where  $m_{p,i} = p - \left(\frac{-d_i}{p}\right)$  for i = 1, 2 and  $m_{p,3} = p - \left(\frac{d_1 d_2}{p}\right)$ .

PROOF. Note that for any coset  $aS_{N,p,1}$  in  $S_{N,p,0}/S_{N,p,1}$ , there is an element  $a' \in S_{N,p,0} \cap \mathcal{O}_K$  such that  $aS_{N,p,1} = a'S_{N,p,1}$ . Here we claim that the map

(4.2) 
$$\begin{aligned} \psi : S_{N,p,0}/S_{N,p,1} &\longrightarrow (\mathcal{O}_K/p\mathcal{O}_K)^{\times} \\ \omega S_{N,p,1} &\longmapsto \omega + p\mathcal{O}_K \quad \text{for } \omega \in S_{N,p,0} \cap \mathcal{O}_K \end{aligned}$$

is an isomorphism. Indeed, if  $\omega, \omega' \in S_{N,p,0} \cap \mathcal{O}_K$  such that  $\omega S_{N,p,1} = \omega' S_{N,p,1}$ , then  $\omega' = \omega \alpha$  for some  $\alpha \in S_{N,p,1}$ . We can then write  $\alpha = a/b$  with  $a, b \in \mathcal{O}_K$  such that a, b are prime to  $Np\mathcal{O}_K$  and  $a \equiv b \pmod{Np\mathcal{O}_K}$ . So  $\omega'b = \omega a \equiv \omega b \pmod{p\mathcal{O}_K}$ , from which we have  $\omega' \equiv \omega \pmod{p\mathcal{O}_K}$ . Thus  $\psi$  is a well-defined homomorphism. If  $\omega S_{N,p,1} \in \ker(\psi)$  then  $\omega \equiv 1 \pmod{p\mathcal{O}_K}$ . Since  $\gcd(N,p) = 1$ , we obtain  $\omega \equiv 1 \pmod{Np\mathcal{O}_K}$ , and so  $\psi$  is injective. For given  $\omega + p\mathcal{O}_K \in (\mathcal{O}_K/p\mathcal{O}_K)^{\times}$ , we can find  $a \in \mathcal{O}_K$  such that  $\omega + pa \equiv 1 \pmod{N\mathcal{O}_K}$ . Therefore  $\psi$  is surjective, and hence the claim is proved. By [5, Proposition 4.2.12] we derive

$$|(\mathcal{O}_K/p\mathcal{O}_K)^{\times}| = \mathcal{N}(p\mathcal{O}_K) \cdot \prod_{\substack{\mathfrak{p} \mid p\mathcal{O}_K\\\mathfrak{p} \text{ prime}}} \left(1 - \frac{1}{\mathcal{N}(\mathfrak{p})}\right)$$

By considering all possible prime ideal factorization of  $p\mathcal{O}_K$ , we get the conclusion ([17, p.74 and p.116]).

From now on, we assume that  $N \neq 2$  and  $K_1, K_2 \neq \mathbb{Q}(\sqrt{-1}), \mathbb{Q}(\sqrt{-3})$ . Let  $\varepsilon_0$  be the fundamental unit of the real quadratic field  $K_3$ . Since  $d_1 \equiv 3 \pmod{4}$ , the norm of  $\varepsilon_0$  is 1. We let  $m_0$  be the smallest positive integer such that  $\varepsilon_0^{m_0} \equiv \pm 1 \pmod{N\mathcal{O}_K}$ , and set

$$\varepsilon_0' = \begin{cases} \varepsilon_0^{m_0} & \text{if } N \neq 1 \text{ and } \varepsilon_0^{m_0} \equiv +1 \pmod{N\mathcal{O}_K} \\ -\varepsilon_0^{m_0} & \text{if } N \neq 1 \text{ and } \varepsilon_0^{m_0} \equiv -1 \pmod{N\mathcal{O}_K} \\ \varepsilon_0 & \text{if } N = 1. \end{cases}$$

Further, we let  $n_0$  be the smallest positive integer for which  $(\varepsilon'_0)^{n_0} \equiv 1 \pmod{Np\mathcal{O}_K}$ .

LEMMA 4.5. With the assumptions as above, we deduce

$$|H_{N,p,0}/S_{N,p,1}| = \begin{cases} n_0 & \text{if } N \neq 1\\ n_0 \cdot Q(K) & \text{if } N = 1 \text{ and } n_0 \text{ is even}\\ 2n_0 \cdot Q(K) & \text{if } N = 1 \text{ and } n_0 \text{ is odd,} \end{cases}$$

where  $Q(K) = \left[\mathcal{O}_{K}^{\times} : \mathcal{O}_{K_{1}}^{\times}\mathcal{O}_{K_{2}}^{\times}\mathcal{O}_{K_{3}}^{\times}\right].$ 

PROOF. By the assumption,  $\mathcal{O}_{K_1}^{\times} = \mathcal{O}_{K_2}^{\times} = \{\pm 1\}$  so that  $\mathcal{O}_{K_1}^{\times} \mathcal{O}_{K_2}^{\times} \mathcal{O}_{K_3}^{\times} = \mathcal{O}_{K_3}^{\times}$ . Observe that

$$|H_{N,p,0}/S_{N,p,1}| = |H_{N,p,0}/S_{N,p,1}(S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times})| \cdot |S_{N,p,1}(S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times})/S_{N,p,1}|.$$

First, we consider the group  $H_{N,p,0}/S_{N,p,1}(S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times})$ . Suppose  $N \neq 1$ . Then we claim that  $S_{N,p,0} \cap \mathcal{O}_K^{\times} \subset \mathbb{R}$ , namely,  $H_{N,p,0} = S_{N,p,1}(S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times})$ . Indeed, let  $\varepsilon \in S_{N,p,0} \cap \mathcal{O}_K^{\times}$ . By Lemma 4.1 we can write

$$\varepsilon = \frac{1}{2} \left[ a + b\sqrt{-d_1} + c\sqrt{-d_2} + d\sqrt{d_1d_2} \right]$$

with  $a, b, c, d \in \mathbb{Z}$  such that  $a \equiv b \pmod{2}$ ,  $c \equiv d \pmod{2}$ . Since  $\varepsilon \equiv 1 \pmod{N\mathcal{O}_K}$ , we have  $a \equiv 2 \pmod{N}$  and so  $a \neq 0$ . Here we note that

$$\varepsilon^{2} = \frac{1}{4} \Big[ a^{2} - b^{2}d_{1} - c^{2}d_{2} + d^{2}d_{1}d_{2} + 2 \Big\{ (ab + cdd_{2})\sqrt{-d_{1}} + (ac + bdd_{1})\sqrt{-d_{2}} + (ad - bc)\sqrt{d_{1}d_{2}} \Big\} \Big]$$
  

$$\in \mathcal{O}_{K_{1}}^{\times}\mathcal{O}_{K_{2}}^{\times}\mathcal{O}_{K_{3}}^{\times} \subset \mathbb{R}$$

because Q(K) = 1 or 2. And, we obtain

$$(4.3) \qquad \qquad ab + cdd_2 = 0 ac + bdd_1 = 0,$$

hence  $d(b^2d_1 - c^2d_2) = 0$ . If d = 0, then ab = ac = 0 which enables us to get b = c = 0. Thus  $\varepsilon = a/2 \in \mathbb{R}$  in this case. Now, suppose that  $d \neq 0$  and  $b^2d_1 - c^2d_2 = 0$ . Then it follows from (4.3) that  $-(a^2b)/(dd_2) = ac = -bdd_1$ , and we have  $b(a^2 - d^2d_1d_2) = 0$ . If b = 0 then c = 0, and hence  $\varepsilon = (a + d\sqrt{d_1d_2})/2 \in \mathbb{R}$ . If  $a^2 - d^2d_1d_2 = 0$ , then we achieve

$$N_{K/K_1}(\varepsilon) = \frac{1}{4} \left[ a^2 - b^2 d_1 + c^2 d_2 - d^2 d_1 d_2 + 2(ab - cdd_2)\sqrt{-d_1} \right]$$
  
=  $\frac{1}{2} (ab - cdd_2)\sqrt{-d_1}$   
\neq \pm 1.

This contradicts the assumption  $\mathcal{O}_{K_1} = \{\pm 1\}$ , and the claim is justified.

If N = 1, then  $S_{1,p,0} \cap \mathcal{O}_K^{\times} = \mathcal{O}_K^{\times}$  and  $S_{1,p,0} \cap \mathcal{O}_{K_3}^{\times} = \mathcal{O}_{K_3}^{\times}$ . Hence one can show  $S_{1,p,1} \cap \mathcal{O}_K^{\times} \subset \mathbb{R}$  in a similar fashion as in the above claim. And, we establish

$$\begin{aligned} H_{1,p,0}/S_{1,p,1}(S_{1,p,0} \cap \mathcal{O}_{K_3}^{\times}) &= S_{1,p,1}\mathcal{O}_K^{\times}/S_{1,p,1}\mathcal{O}_{K_3}^{\times} \\ &\cong \mathcal{O}_K^{\times}/\mathcal{O}_{K_3}^{\times}(S_{1,p,1} \cap \mathcal{O}_K^{\times}) \\ &\cong \mathcal{O}_K^{\times}/\mathcal{O}_{K_3}^{\times}. \end{aligned}$$

Therefore we attain

(4.4) 
$$\left| H_{N,p,0} / S_{N,p,1} (S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times}) \right| = \begin{cases} 1 & \text{if } N \neq 1 \\ Q(K) & \text{if } N = 1. \end{cases}$$

Next, we consider the group  $S_{N,p,1}(S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times})/S_{N,p,1}$ . If  $N \neq 1$ , then  $S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times} = \{(\varepsilon'_0)^n \mid n \in \mathbb{Z}\}$ , and hence we have

$$\left|S_{N,p,1}(S_{N,p,0}\cap\mathcal{O}_{K_3}^{\times})/S_{N,p,1}\right| = \left|\langle\varepsilon_0'S_{N,p,1}\rangle\right| = n_0.$$

Now, suppose N = 1. If  $n_0$  is even, then  $(\varepsilon'_0)^{n_0/2}$  is the root of the equation  $X^2 \equiv 1 \pmod{p\mathcal{O}_{K_3}}$ . Write  $(\varepsilon'_0)^{n_0/2} = \alpha + \beta \sqrt{d_1 d_2}$  with  $\alpha, \beta \in \mathbb{Z}$ . Then we get

$$\alpha^2 + d_1 d_2 \beta^2 \equiv 1 \pmod{p}$$
$$2\alpha\beta \equiv 0 \pmod{p}.$$

If p divides  $\alpha$ , then  $d_1d_2\beta^2 \equiv 1 \pmod{p}$ . Since  $N_{K_3/\mathbb{Q}}((\varepsilon'_0)^{n_0/2}) = \alpha^2 - d_1d_2\beta^2 = 1$ , it is a contradiction. Thus p divides  $\beta$ , and we achieve  $(\varepsilon'_0)^{n_0/2} \equiv -1 \pmod{p\mathcal{O}_K}$  by the minimality of  $n_0$ . If  $n_0$  is odd, then  $(\varepsilon'_0)^n \not\equiv -1 \pmod{p\mathcal{O}_K}$  for all  $n \in \mathbb{Z}_{>0}$ . Indeed, if  $(\varepsilon'_0)^n \equiv -1 \pmod{p\mathcal{O}_K}$  for some  $n \in \mathbb{Z}_{>0}$ , then  $(\varepsilon'_0)^{2n} \equiv 1 \pmod{p\mathcal{O}_K}$ . By definition of  $n_0$  we see that  $n_0$  divides 2n. Since  $n_0$  is odd,  $n_0$  divides n. But  $(\varepsilon'_0)^n \not\equiv 1 \pmod{p\mathcal{O}_K}$ , so it gives a contradiction. Since  $\mathcal{O}_{K_3}^{\times} = \{\pm (\varepsilon'_0)^n \mid n \in \mathbb{Z}\}$ , we derive that

$$S_{1,p,1}(S_{1,p,0} \cap \mathcal{O}_{K_3}^{\times})/S_{1,p,1} = S_{1,p,1}\mathcal{O}_{K_3}^{\times}/S_{1,p,1} \cong \begin{cases} \mathbb{Z}/n_0\mathbb{Z} & \text{if } n_0 \text{ is even} \\ \mathbb{Z}/2\mathbb{Z} \times \mathbb{Z}/n_0\mathbb{Z} & \text{if } n_0 \text{ is odd} \end{cases}$$

And, we deduce

(4.5) 
$$|S_{N,p,1}(S_{N,p,0} \cap \mathcal{O}_{K_3}^{\times})/S_{N,p,1}| = \begin{cases} n_0 & \text{if } N \neq 1 \text{ or } n_0 \text{ is even} \\ 2n_0 & \text{if } N = 1 \text{ and } n_0 \text{ is odd.} \end{cases}$$

Therefore, the lemma follows from (4.4) and (4.5).

LEMMA 4.6. Let  $F = \mathbb{Q}(\sqrt{d})$  be a quadratic field with square-free integer d and p be an odd prime such that  $p \nmid d$ . Then we attain

$$\{\omega + p\mathcal{O}_F \in (\mathcal{O}_F/p\mathcal{O}_F)^{\times} \mid N_{F/\mathbb{Q}}(\omega) \equiv 1 \pmod{p}\} \cong \mathbb{Z}/m\mathbb{Z},$$

with  $m = p - \left(\frac{d}{p}\right)$ .

**PROOF.** First, consider an affine curve

$$\mathcal{C}: x^2 - dy^2 = 1$$

defined over a finite field  $\mathbb{F}_p$ . Then  $\mathcal{C}$  is smooth since  $p \nmid d$ . We define a group law on  $\mathcal{C}$  by

$$(r,s) \oplus (t,u) = (rt + dsu, ru + st)$$

for points (r, s), (t, u) on  $\mathcal{C}$ . Then the group  $\mathcal{C}(\mathbb{F}_p)$  is isomorphic to  $\mathbb{Z}/m\mathbb{Z}$  ([16]).

On the other hand, since gcd(2, p) = 1, we obtain

$$\mathcal{O}_F/p\mathcal{O}_F = \{x + y\sqrt{d} + p\mathcal{O}_F \mid x, y \in \mathbb{F}_p\}.$$

And, the map

$$\{ \omega + p\mathcal{O}_F \in (\mathcal{O}_F/p\mathcal{O}_F)^{\times} \mid N_{F/\mathbb{Q}}(\omega) \equiv 1 \pmod{p} \} \longrightarrow \mathcal{C}(\mathbb{F}_p)$$
  
 
$$x + y\sqrt{d} + p\mathcal{O}_F \longmapsto (x,y)$$

is an isomorphism, which completes the proof.

Now, we further assume that  $p \nmid d_1 d_2$ . Then we derive

$$p\mathcal{O}_K = \begin{cases} \mathfrak{p}_1 \mathfrak{p}_2 \mathfrak{p}_3 \mathfrak{p}_4 & \text{if } \left(\frac{-d_1}{p}\right) = \left(\frac{-d_2}{p}\right) = 1\\ \mathfrak{p}_1 \mathfrak{p}_2 & \text{otherwise} \end{cases}$$

where the  $\mathfrak{p}_i$  are distinct prime ideals of K ([17, p.116]). By making use of (4.1), Lemma 4.4 and 4.5, one can find the extension degree of  $K_{(Np)}$  over  $K_{(N)}$ . Here we note that

$$\varepsilon_0' + p\mathcal{O}_{K_3} \in \{\omega + p\mathcal{O}_{K_3} \in (\mathcal{O}_{K_3}/p\mathcal{O}_{K_3})^{\times} \mid N_{K_3/\mathbb{Q}}(\omega) \equiv 1 \pmod{p}\}$$

and so  $n_0$  divides  $m_{p,3}$  by Lemma 4.6.

For i = 1, 2, let

$$W_{N,p,0}^{i} = \begin{cases} \left\{ \omega \in S_{N,p,0} \mid N_{K/K_{i}}(\omega) \equiv 1 \pmod{Np\mathcal{O}_{K_{i}}} \right\} & \text{if } N \neq 1 \\ \left\{ \omega \in S_{1,p,0} \mid N_{K/K_{i}}(\omega) \equiv \pm 1 \pmod{p\mathcal{O}_{K_{i}}} \right\} & \text{if } N = 1, \end{cases}$$

and let

$$W_{N,p,0}^{1,2} = W_{N,p,0}^1 \cap W_{N,p,0}^2,$$

so that  $\ker(\widetilde{\varphi_{N,p,0}^{1,2}}) = W_{N,p,0}^{1,2}/H_{N,p,0}$ . Here, we mean by  $\widetilde{W_{N,p,0}^{1,2}}$  the image of  $W_{N,p,0}^{1,2}/S_{N,p,1}$  in  $(\mathcal{O}_K/p\mathcal{O}_K)^{\times}$  via the isomorphism (4.2).

THEOREM 4.7. Let  $N \neq 2$  be a positive integer and p be an odd prime not dividing  $Nd_1d_2$ . Assume that  $K_1, K_2 \neq \mathbb{Q}(\sqrt{-1}), \mathbb{Q}(\sqrt{-3})$ . Then we deduce

$$\begin{bmatrix} K_{(Np)} : \widetilde{K_{N,p,0}^{1,2}} \end{bmatrix} = \begin{cases} \frac{m_{p,3}}{n_0} & \text{if } N \neq 1 \\ \frac{4m_{p,3}}{n_0 \cdot Q(K)} & \text{if } N = 1 \text{ and } n_0 \text{ is even} \\ \frac{2m_{p,3}}{n_0 \cdot Q(K)} & \text{if } N = 1 \text{ and } n_0 \text{ is odd,} \end{cases}$$

Hence, we get

$$K_{(Np)} = \widetilde{K_{N,p,0}^{1,2}} \quad if and only if \quad N \neq 1 and n_0 = m_{p,3}.$$

PROOF. Let

$$\widetilde{W_{N,p,0}^{1,2}}' = \{\omega + p\mathcal{O}_K \in (\mathcal{O}_K/p\mathcal{O}_K)^{\times} \mid N_{K/K_i}(\omega) \equiv 1 \pmod{p\mathcal{O}_{K_i}} \text{ for } i = 1, 2\},$$

and let  $d_i^{-1}$  be the inverse of  $d_i$  in  $(\mathbb{Z}/p\mathbb{Z})^{\times}$  for i = 1, 2. For  $\omega + p\mathcal{O}_K \in \mathcal{O}_K/p\mathcal{O}_K$  we can write  $\omega = a + b\sqrt{-d_1} + c\sqrt{-d_2} + d\sqrt{d_1d_2}$  with  $a, b, c, d \in \mathbb{Z}$  due to the fact gcd(2, p) = 1.

First, we consider the group  $\widetilde{W_{N,p,0}^{1,2}}$ . If  $\omega + p\mathcal{O}_K \in \widetilde{W_{N,p,0}^{1,2}}'$ , then we attain

(4.6) 
$$a^{2} - b^{2}d_{1} + c^{2}d_{2} - d^{2}d_{1}d_{2} \equiv 1 \pmod{p}$$
$$ab - cdd_{2} \equiv 0 \pmod{p}$$

and

(4.7) 
$$a^{2} + b^{2}d_{1} - c^{2}d_{2} - d^{2}d_{1}d_{2} \equiv 1 \pmod{p}$$
$$ac - bdd_{1} \equiv 0 \pmod{p}.$$

Since  $c^2 dd_2 \equiv abc \equiv b^2 dd_1 \pmod{p}$ , we obtain  $d(b^2 d_1 - c^2 d_2) \equiv 0 \pmod{p}$ . If  $b^2 d_1 - c^2 d_2 \equiv 0 \pmod{p}$ , then p must divide b, c and hence we get  $a^2 - d^2 d_1 d_2 \equiv 1 \pmod{p}$ . Indeed, if  $\left(\frac{d_1 d_2}{p}\right) = -1$ , it is clear. On the contrary, suppose that  $\left(\frac{d_1 d_2}{p}\right) = 1$  and  $b, c \not\equiv 0 \pmod{p}$ . Then  $d_1^{-1} d_2 \equiv D^2 \pmod{p}$  for some  $D \in \mathbb{Z}$ , which yields  $b \equiv \pm cD \pmod{p}$  and  $a \equiv \pm dDd_1 \pmod{p}$ . Thus we deduce that

$$a^{2} - b^{2}d_{1} + c^{2}d_{2} - d^{2}d_{1}d_{2} \equiv d^{2}d_{1}d_{2} - c^{2}d_{2} + c^{2}d_{2} - d^{2}d_{1}d_{2} \equiv 0 \pmod{p},$$

which contradicts (4.6). If  $b^2d_1 - c^2d_2 \not\equiv 0 \pmod{p}$  and  $d \equiv 0 \pmod{p}$ , then  $ab \equiv ac \equiv 0 \pmod{p}$  and so  $a \equiv 0 \pmod{p}$ . But it follows from (4.6), (4.7) that  $b^2d_1 - c^2d_2 \equiv -1 \equiv 1 \pmod{p}$ , which is a contradiction. Therefore we derive

$$\widetilde{W_{N,p,0}^{1,2}}' = \left\{ a + d\sqrt{d_1 d_2} + p\mathcal{O}_K \in (\mathcal{O}_K/p\mathcal{O}_K)^{\times} \mid a^2 - d^2 d_1 d_2 \equiv 1 \pmod{p} \right\}$$
$$\cong \left\{ \omega + p\mathcal{O}_{K_3} \in (\mathcal{O}_{K_3}/p\mathcal{O}_{K_3})^{\times} \mid N_{K_3/\mathbb{Q}}(\omega) \equiv 1 \pmod{p} \right\}$$
$$\cong \mathbb{Z}/m_{p,3}\mathbb{Z} \quad \text{(by Lemma 4.6).}$$

If  $N \neq 1$ , then  $\widetilde{W_{N,p,0}^{1,2}} = \widetilde{W_{N,p,0}^{1,2}}'$  and by Lemma 4.5 we attain

$$\left[K_{(Np)}:\widetilde{K_{N,p,0}^{1,2}}\right] = |W_{N,p,0}^{1,2}/H_{N,p,0}| = \frac{|W_{N,p,0}^{1,2}|}{|H_{N,p,0}/S_{N,p,1}|} = \frac{m_{p,3}}{n_0}$$

For i = 1, 2, we let

$$\begin{aligned} A_i &= \left\{ b\sqrt{-d_1} + c\sqrt{-d_2} + p\mathcal{O}_K \in (\mathcal{O}_K/p\mathcal{O}_K)^{\times} \mid b^2 d_1 - c^2 d_2 \equiv (-1)^i \; (\text{mod } p) \right\} \\ &= \left\{ b\sqrt{-d_1} + c\sqrt{-d_2} + p\mathcal{O}_K \in (\mathcal{O}_K/p\mathcal{O}_K)^{\times} \mid b^2 - c^2 d_1^{-1} d_2 \equiv (-1)^i d_1^{-1} \; (\text{mod } p) \right\} \\ &\neq \phi \quad (\text{by Lemma 4.6}). \end{aligned}$$

If N = 1, we choose  $a_1, a_2 \in \mathcal{O}_K$  so that  $a_i + p\mathcal{O}_K \in A_i$  for i = 1, 2. Then it satisfies

$$N_{K/K_1}(a_1) \equiv -1 \pmod{p}, \quad N_{K/K_2}(a_1) \equiv 1 \pmod{p},$$
  
$$N_{K/K_1}(a_2) \equiv 1 \pmod{p}, \quad N_{K/K_2}(a_2) \equiv -1 \pmod{p}.$$

Hence we achieve

$$\widetilde{W_{1,p,0}^{1,2}} = \bigsqcup_{0 \le i,j < 2} a_1^i a_2^j \cdot \widetilde{W_{1,p,0}^{1,2}}'.$$

Thus  $|\widetilde{W_{1,p,0}^{1,2}}| = 4m_{p,3}$ , and so by Lemma 4.5 we derive

$$\left[K_{(p)}:\widetilde{K_{1,p,0}^{1,2}}\right] = \left|W_{1,p,0}^{1,2}/H_{1,p,0}\right| = \frac{\left|\widetilde{W_{1,p,0}^{1,2}}\right|}{\left|H_{1,p,0}/S_{1,p,1}\right|} = \begin{cases} \frac{4m_{p,3}}{n_0 \cdot Q(K)} & \text{if } n_0 \text{ is even} \\ \frac{2m_{p,3}}{n_0 \cdot Q(K)} & \text{if } n_0 \text{ is odd.} \end{cases}$$

This proves the theorem.

EXAMPLE 4.8. Let  $K = \mathbb{Q}(\sqrt{-15}, \sqrt{-26})$ . Then  $K_1 = \mathbb{Q}(\sqrt{-15})$ ,  $K_2 = \mathbb{Q}(\sqrt{-26})$ ,  $K_3 = \mathbb{Q}(\sqrt{390})$  and  $\varepsilon_0 = 79 + 4\sqrt{390}$ . We set N = 5 and p = 37 so that  $m_0 = 5$ ,  $\varepsilon'_0 = -\varepsilon_0^{m_0}$  and  $n_0 = 38 = m_{p,3}$ . Thus by Corollary 4.3 and Theorem 4.7, for any positive integers  $n_1, n_2$ ,

(4.8) 
$$K_{(185)} = \widetilde{K_{5,37,0}^{1,2}} = K_{(5)} \left( g_{\left[ \begin{array}{c} 0\\1/185 \end{array}\right]}(\theta_1)^{2220n_1} g_{\left[ \begin{array}{c} 0\\1/185 \end{array}\right]}(\theta_2)^{2220n_2} \right)$$

where  $\theta_1 = (-1 + \sqrt{-15})/2$  and  $\theta_2 = \sqrt{-26}$ .

#### 5 Class fields over imaginary biquadratic fields (II)

Following the previous section we shall consider the more general case  $\mu > 0$ .

Let N be a positive integer and p be an odd prime not dividing N. We use the same notations as in Section 4.

LEMMA 5.1. For a positive integer  $\mu$ , we have

$$|S_{N,p,\mu}/S_{N,p,\mu+1}| = p^4.$$

**PROOF.** Now that  $S_{N,p,\mu}/S_{N,p,\mu+1}$  is isomorphic to  $\mathcal{O}_K/p\mathcal{O}_K$  by a mapping

$$S_{N,p,\mu}/S_{N,p,\mu+1} \longrightarrow \mathcal{O}_K/p\mathcal{O}_K$$
$$(1+Np^{\mu}\omega)S_{N,p,\mu+1} \longmapsto \omega + p\mathcal{O}_K \quad \text{for } \omega \in \mathcal{O}_K,$$

we obtain  $S_{\mu}/S_{\mu+1} \cong (\mathbb{Z}/p\mathbb{Z})^4$ .

Let  $\varepsilon_0$  be the fundamental unit of the real quadratic field  $K_3$ ,  $\ell_0$  be the smallest positive integer such that  $\varepsilon_0^{\ell_0} \equiv 1 \pmod{Np\mathcal{O}_K}$  and  $\mu_0$  be the maximal positive integer satisfying  $\varepsilon_0^{\ell_0} \equiv 1 \pmod{Np^{\mu_0}\mathcal{O}_K}$ . Write

$$\varepsilon_0^{\ell_0} = 1 + N p^{\mu_0} (\alpha_0 + \beta_0 \sqrt{d_1 d_2})$$

with  $\alpha_0, \beta_0 \in \mathbb{Z}$ . By the maximality of  $\mu_0$  we have  $\alpha_0 + \beta_0 \sqrt{d_1 d_2} \notin p\mathcal{O}_{K_3}$ . Since

$$1 = N_{K_3/\mathbb{Q}}(\varepsilon_0^{\ell_0}) \equiv 1 + 2Np^{\mu_0}\alpha_0 \pmod{Np^{\mu_0+1}},$$

we get  $p \mid \alpha_0$  and  $p \nmid \beta_0$ .

LEMMA 5.2. Assume that  $K_1, K_2 \neq \mathbb{Q}(\sqrt{-1}), \mathbb{Q}(\sqrt{-3})$ . Then for a positive integer  $\mu$ we get

$$|H_{N,p,\mu}/S_{N,p,\mu+1}| = \begin{cases} 1 & \text{if } \mu < \mu_0 \\ p & \text{if } \mu \ge \mu_0. \end{cases}$$

PROOF. In a similar way as in the proof of Lemma 4.5, one can verify that if  $\ell_0$  is odd, then  $\varepsilon_0^n \not\equiv -1 \pmod{Np\mathcal{O}_K}$  for all  $n \in \mathbb{Z}_{>0}$ . And, if  $\ell_0$  is even, then we have either  $\varepsilon_0^{\ell_0/2} \equiv -1 \pmod{Np\mathcal{O}_K}$  or  $\varepsilon_0^n \not\equiv -1 \pmod{Np\mathcal{O}_K}$  for all  $n \in \mathbb{Z}_{>0}$ . Indeed, suppose  $\varepsilon_0^{\ell_0/2} \not\equiv -1 \pmod{Np\mathcal{O}_K}$ . If  $\varepsilon_0^n \equiv -1 \pmod{Np\mathcal{O}_K}$  for some  $n \in \mathbb{Z}_{>0}$ , then  $\ell_0 \mid 2n$  and so  $(\ell_0/2) \mid n$ . It contradicts the fact  $(\varepsilon_0^{\ell_0/2})^m \not\equiv -1 \pmod{Np\mathcal{O}_K}$  for all  $m \in \mathbb{Z}_{>0}$ .

Next, we claim that if  $\ell_0$  is even and  $\varepsilon_0^{\ell_0/2} \equiv -1 \pmod{Np\mathcal{O}_K}$ , then  $\mu_0$  is the maximal positive integer such that  $\varepsilon_0^{\ell_0/2} \equiv -1 \pmod{Np^{\mu_0}\mathcal{O}_K}$ . For, write  $\varepsilon_0^{\ell_0/2} = -1 + Np\omega$  for some  $\omega \in \mathcal{O}_{K_3}$ . Then

$$\varepsilon_0^{\ell_0} = 1 + Np\omega(-2 + Np\omega) \equiv 1 \pmod{Np^{\mu_0}\mathcal{O}_{K_3}}.$$

Since  $-2 + Np\omega \notin \mathfrak{p}$  for any prime ideal  $\mathfrak{p}$  dividing  $p\mathcal{O}_{K_3}$ ,  $\omega$  belongs to  $p^{\mu_0-1}\mathcal{O}_{K_3}$  and  $\varepsilon_0^{\ell_0/2} \equiv -1 \pmod{Np^{\mu_0}\mathcal{O}_K}$ . If  $\varepsilon_0^{\ell_0/2} \equiv -1 \pmod{Np^{\mu}\mathcal{O}_K}$  for some  $\mu > \mu_0$ , then  $\varepsilon_0^{\ell_0} \equiv 1 \pmod{Np^{\mu}\mathcal{O}_K}$ , which contradicts the maximality of  $\mu_0$ .

On the other hand, one can show by utilizing the idea in the proof of Lemma 4.5 that  $S_{N,p,\mu} \cap \mathcal{O}_{K}^{\times} \subset \mathcal{O}_{K_{3}}^{\times} = \{\pm \varepsilon_{0}^{n} \mid n \in \mathbb{Z}\}$  for all  $\mu \in \mathbb{Z}_{>0}$ . Here we observe that we don't need the assumptions  $N \neq 2$ . Since  $H_{N,p,\mu}/S_{N,p,\mu+1} \subseteq S_{N,p,\mu}/S_{N,p,\mu+1} \cong (\mathbb{Z}/p\mathbb{Z})^{4}$ , we attain

$$\dim_{\mathbb{Z}/p\mathbb{Z}} \left( H_{N,p,\mu}/S_{N,p,\mu+1} \right) = 0 \text{ or } 1.$$

It then follows from the above claim that  $H_{N,p,\mu}/S_{N,p,\mu+1} = 0$  if  $\mu < \mu_0$ . Now, assume  $\mu \ge \mu_0$ . Observe that  $H_{N,p,\mu_0}/S_{N,p,\mu_0+1} = \langle \varepsilon_0^{\ell_0} S_{N,p,\mu_0+1} \rangle \cong \mathbb{Z}/p\mathbb{Z}$  because gcd(2,p) = 1. For a positive integer m,

$$(\varepsilon_0^{\ell_0})^m = 1 + mNp^{\mu_0}(\alpha_0 + \beta_0\sqrt{d_1d_2}) + \sum_{i=2}^m \binom{m}{i} \left\{ Np^{\mu_0}(\alpha_0 + \beta_0\sqrt{d_1d_2}) \right\}^i.$$

Since  $\alpha_0 + \beta_0 \sqrt{d_1 d_2} \notin p\mathcal{O}_{K_3}$  and

$$\sum_{i=2}^{p} {p \choose i} \left\{ N p^{\mu_0} (\alpha_0 + \beta_0 \sqrt{d_1 d_2}) \right\}^i \in N p^{\mu_0 + 2} \mathcal{O}_{K_3}$$

m = p is the smallest positive integer satisfying  $(\varepsilon_0^{\ell_0})^m \in H_{N,p,\mu_0+1} \setminus S_{N,p,\mu_0+2}$ . In a similar fashion, one can prove by using the induction that  $m = p^{\mu-\mu_0}$  is the smallest positive integer such that  $(\varepsilon_0^{\ell_0})^m \in H_{N,p,\mu} \setminus S_{N,p,\mu+1}$ . Therefore, we conclude

$$H_{N,p,\mu}/S_{N,p,\mu+1} = \langle \varepsilon_0^{\ell_0 p^{\mu-\mu_0}} S_{N,p,\mu+1} \rangle \cong \mathbb{Z}/p\mathbb{Z}.$$

COROLLARY 5.3. With the assumption as in Lemma 5.2, for a positive integer  $\mu$ 

$$\left[K_{(Np^{\mu+1})}:K_{(Np^{\mu})}\right] = \begin{cases} p^4 & \text{if } \mu < \mu_0\\ p^3 & \text{if } \mu \ge \mu_0, \end{cases}$$

**PROOF.** It is immediate from (4.1), Lemma 5.1 and 5.2.

For a positive integer  $\mu$  and i = 1, 2, let

$$W_{N,p,\mu}^{1,2} = \{ \omega \in S_{N,p,\mu} \mid N_{K/K_i}(\omega) \equiv 1 \pmod{Np^{\mu+1}\mathcal{O}_{K_i}} \text{ for } i = 1, 2 \}$$

so as to get  $\ker(\widetilde{\varphi_{N,p,\mu}^{1,2}}) = W_{N,p,\mu}^{1,2}/H_{N,p,\mu}$ .

THEOREM 5.4. Let N be a positive integer and p be an odd prime not dividing N. Assume that  $K_1, K_2 \neq \mathbb{Q}(\sqrt{-1}), \mathbb{Q}(\sqrt{-3})$ . Then for a positive integer  $\mu$ , we derive

$$\left[K_{(Np^{\mu+1})} : \widetilde{K_{N,p,\mu}^{1,2}}\right] = \begin{cases} p & \text{if } \mu < \mu_0\\ 1 & \text{if } \mu \ge \mu_0, \end{cases}$$

PROOF. For any coset  $\alpha S_{N,p,\mu+1}$  in  $S_{N,p,\mu}/S_{N,p,\mu+1}$  we can choose  $\omega \in \mathcal{O}_K \cap S_{N,p,\mu}$  such that  $\alpha S_{N,p,\mu+1} = \omega S_{N,p,\mu+1}$ . And, we write  $\omega = 1 + (Np^{\mu}/2)(a+b\sqrt{-d_1}+c\sqrt{-d_2}+d\sqrt{d_1d_2})$  with  $a, b, c, d \in \mathbb{Z}$  satisfying  $a \equiv b \pmod{2}$ ,  $c \equiv d \pmod{2}$ .

First, we consider the group  $W_{N,p,\mu}^{1,2}/S_{N,p,\mu+1}$ . If  $\omega \in \mathcal{O}_K \cap W_{N,p,\mu}^{1,2}$ , then we have

$$N_{K/K_1}(\omega) \equiv 1 + Np^{\mu}(a + b\sqrt{-d_1}) \equiv 1 \pmod{Np^{\mu+1}\mathcal{O}_{K_1}},$$
  
$$N_{K/K_2}(\omega) \equiv 1 + Np^{\mu}(a + c\sqrt{-d_2}) \equiv 1 \pmod{Np^{\mu+1}\mathcal{O}_{K_2}}.$$

Since  $a + b\sqrt{-d_1} = a + b + 2b\left(\frac{-1+\sqrt{-d_1}}{2}\right) \in p\mathcal{O}_{K_1}$  and  $a + c\sqrt{-d_2} \in p\mathcal{O}_{K_2}$ , p divides a, b, c. Thus we claim that

$$W_{N,p,\mu}^{1,2}/S_{N,p,\mu+1} = \left\langle (1 + Np^{\mu}\sqrt{d_1d_2})S_{N,p,\mu+1} \right\rangle \cong \mathbb{Z}/p\mathbb{Z}$$

and by Lemma 5.2 we get

$$\left[K_{(Np^{\mu+1})}:\widetilde{K_{N,p,\mu}^{1,2}}\right] = \frac{\left|W_{N,p,\mu}^{1,2}/S_{N,p,\mu+1}\right|}{\left|H_{N,p,\mu}/S_{N,p,\mu+1}\right|} = \begin{cases} p & \text{if } \mu < \mu_0\\ 1 & \text{if } \mu \ge \mu_0. \end{cases}$$

On the other hand, let  $f_{\mu,i}$  and  $C_{\mu,i}$  be as in Section 4.

COROLLARY 5.5. With the notations and assumptions as above, if  $\mu \ge \mu_0$ , then for any positive integers  $n_1$ ,  $n_2$ , the value

$$\prod_{i=1}^{2} g_{\mathfrak{f}_{\mu+1,i}} (C_{\mu+1,i})^{n_i}$$

generates  $K_{(Np^{\mu+1})}$  over  $K_{(Np^{\mu_0})}$ .

**PROOF.** By Proposition 3.1, Lemma 4.2 and Theorem 5.4 we obtain

$$K_{(Np^{\mu+1})} = K_{(Np^{\mu})}(K_1)_{(Np^{\mu+1})}(K_2)_{(Np^{\mu+1})} = K_{(Np^{\mu_0})}(K_1)_{(Np^{\mu+1})}(K_2)_{(Np^{\mu+1})} = K_{(Np^{\mu_0})}(\gamma_1, \gamma_2),$$

where  $\gamma_i = g_{\mathfrak{f}_{\mu+1,i}}(C_{\mu+1,i})^{n_i}$  for i = 1, 2. Since the only element of  $\operatorname{Gal}(K_{(Np^{\mu+1})}/K_{(Np^{\mu_0})})$  fixing the value  $\gamma_1\gamma_2$  is the identity, we get the conclusion ([10, Theorem 3.5 and Remark 3.6]).

EXAMPLE 5.6. Let  $K = \mathbb{Q}(\sqrt{-15}, \sqrt{-26})$ , N = 5 and p = 37 as in Example 4.8 (ii). Then  $\varepsilon_0 = 79 + 4\sqrt{390}$ ,  $\ell_0 = 190$  and  $\mu_0 = 1$ . Hence by Corollary 5.5 and (4.8) we get that for any positive integers  $n_1$ ,  $n_2$  and  $\mu$ ,

$$K_{(5\cdot37^{\mu})} = K_{(5)} \left( g_{\left[ \begin{array}{c} 0\\ 1/(5\cdot37^{\mu}) \end{array} \right]} (\theta_1)^{60\cdot37^{\mu}n_1} g_{\left[ \begin{array}{c} 0\\ 1/(5\cdot37^{\mu}) \end{array} \right]} (\theta_2)^{60\cdot37^{\mu}n_2} \right)$$

where  $\theta_1 = (-1 + \sqrt{-15})/2$  and  $\theta_2 = \sqrt{-26}$ .
