

# Vector Polynomials and a Matrix Weight Associated to Dihedral Groups

**Abstract.** The space of polynomials in two real variables with values in a 2-dimensional irreducible module of a dihedral group is studied as a standard module for Dunkl operators. The one-parameter case is considered (omitting the two-parameter case for even dihedral groups). The matrix weight function for the Gaussian form is found explicitly by solving a boundary value problem, and then computing the normalizing constant. An orthogonal basis for the homogeneous harmonic polynomials is constructed. The coefficients of these polynomials are found to be balanced terminating  ${}_4F_3$ -series.

## 1 Introduction

For each irreducible two-dimensional representation of a dihedral reflection group there is a module of the algebra of operators on polynomials generated by multiplication and the Dunkl operators. This algebra is called the rational Cherednik algebra of the group. The space of vector-valued polynomials is equipped with a bilinear form which depends on one parameter and is invariant under the group action. For a certain interval of parameter values the form can be represented as an integral with respect to a positive-definite matrix weight function times the Gaussian measure. In a previous paper this structure was analyzed for the group of type  $B_2$  where there are two free parameters. This paper concerns the Coxeter group of type  $I_2(m)$ , the full symmetry group of the regular  $m$ -gon, of order  $2m$ . Even values for  $m$  would allow two parameters but only the one parameter case is considered here.

The orthogonality properties of the Gaussian form are best analyzed by means of harmonic homogeneous polynomials. These are studied in Section 2. An inductive approach is used to produce the definitions. Closed forms are obtained for these polynomials in the complex coordinate system. The formulae are explicit but do require double sums, that is, the coefficients are given as terminating balanced  ${}_4F_3$ -series. Section 3 contains the construction of an orthogonal basis of harmonic polynomials and the structure constants with respect to the Gaussian form. The results in Sections 2 and 3 are of algebraic flavor and hold for any value of  $\kappa$ . The sequel is of analytic nature and the results hold for restricted values of  $\kappa$ . Section 4 sets up the differential system for the weight function and then constructs the solution up to a normalizing constant. Section 5 deals with the mechanics of integrating harmonic polynomials with respect to the Gaussian weight. In Section 6 the normalizing constant is found by direct integration. The survey [3] covering general information about Dunkl operators and related topics is accessible online.

Fix  $m \geq 3$  and set  $\omega := \exp \frac{2\pi i}{m}$ . The group  $I_2(m)$  (henceforth denoted by  $W$ ) contains  $m$  reflections and  $m - 1$  rotations. Although the group is real it is often useful to employ complex coordinates for  $x = (x_1, x_2) \in \mathbb{R}^2$ , that is,  $z = x_1 + ix_2$ ,  $\bar{z} = x_1 - ix_2$ . Then the reflections are expressed as  $z\sigma_j := \bar{z}\omega^j$  ( $0 \leq j < m$ ) and the rotations are  $z\rho_j := z\omega^j$  ( $1 \leq j < m$ ). The (pairwise nonequivalent) 2-dimensional irreducible representations are given by

$$\tau_\ell(\sigma_j) = \begin{bmatrix} 0 & \omega^{-j\ell} \\ \omega^{j\ell} & 0 \end{bmatrix}, \quad 1 \leq \ell \leq \left\lfloor \frac{m-1}{2} \right\rfloor, \quad 0 \leq j < m.$$

Henceforth fix  $\ell$ . We consider the vector space  $\mathcal{P}_{m,\ell}$  consisting of polynomials

$$f(z, \bar{z}, t, \bar{t}) = f_1(z, \bar{z})t + f_2(z, \bar{z})\bar{t}$$

with the group action

$$\sigma_j f(z, \bar{z}, t, \bar{t}) = f_2(\bar{z}\omega^j, z\omega^{-j})\omega^{-\ell j}t + f_1(\bar{z}\omega^j, z\omega^{-j})\omega^{\ell j}\bar{t}. \quad (1)$$

Fix a parameter  $\kappa$ ; the Dunkl operators are defined by

$$\begin{aligned} \mathcal{D}f(z, \bar{z}, t, \bar{t}) &= \frac{\partial}{\partial z} f(z, \bar{z}, t, \bar{t}) + \kappa \sum_{j=0}^{m-1} \frac{f(z, \bar{z}, \omega^{\ell j} \bar{t}, \omega^{-\ell j} t) - f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j} \bar{t}, \omega^{-\ell j} t)}{z - \bar{z}\omega^j}, \quad (2) \\ \bar{\mathcal{D}}f(z, \bar{z}, t, \bar{t}) &= \frac{\partial}{\partial \bar{z}} f(z, \bar{z}, t, \bar{t}) - \kappa \sum_{j=0}^{m-1} \frac{f(z, \bar{z}, \omega^{\ell j} \bar{t}, \omega^{-\ell j} t) - f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j} \bar{t}, \omega^{-\ell j} t)}{z - \bar{z}\omega^j} \omega^j. \end{aligned}$$

In these coordinates the Laplacian  $\Delta_\kappa = 4\mathcal{D}\bar{\mathcal{D}}$ . The group covariant property  $\bar{\mathcal{D}} = \sigma_0 \mathcal{D} \sigma_0$  is convenient for simplifying some proofs.

The *rational Cherednik algebra* associated with the data  $(I_2(m), \kappa)$  is the abstract algebra formed from the product  $\mathbb{C}[z, \bar{z}] \otimes \mathbb{C}[\mathcal{D}, \bar{\mathcal{D}}] \otimes \mathbb{C}I_2(m)$  (polynomials in the two sets of variables and the group algebra of  $I_2(m)$ ) with relations like  $\bar{\mathcal{D}} = \sigma_0 \mathcal{D} \sigma_0$  and  $\bar{z} = \sigma_0 z \sigma_0$ , and commutations described in Proposition 1. The algebra acts on  $\mathcal{P}_{m,\ell}$  by multiplication, and equations (2), (1) for the respective three components. Thus there is a representation of the algebra as operators on  $\mathcal{P}_{m,\ell}$ , and so  $\mathcal{P}_{m,\ell}$  is called the *standard module* with lowest degree component of isotype  $\tau_\ell$  (that is, the representation  $\tau_\ell$  of  $I_2(m)$ ).

The bilinear form on  $\mathcal{P}_{m,\ell}$  is defined in the real coordinate system ( $t = s_1 + is_2$ ,  $\mathcal{D}_1 = \mathcal{D} + \bar{\mathcal{D}}$ ,  $\mathcal{D}_2 = i(\mathcal{D} - \bar{\mathcal{D}})$ ) by

$$\langle s_j, s_k \rangle = \delta_{jk}, \quad \langle x_j p(x, s), q(x, s) \rangle = \langle p(x, s), \mathcal{D}_j q(x, s) \rangle, \quad \langle s_j, q(x, s) \rangle = \langle s_j, q(0, s) \rangle.$$

This definition is equivalent to

$$\langle p_1(x)s_1 + p_2(x)s_2, q(x, s) \rangle = \langle s_1, (p_1(\mathcal{D}_1, \mathcal{D}_2)q)(0, s) \rangle + \langle s_2, (p_2(\mathcal{D}_1, \mathcal{D}_2)q)(0, s) \rangle.$$

The form is real-bilinear and symmetric (see [2]). To transform the definition to the complex coordinate system we impose the conditions

$$\langle cp, q \rangle = \bar{c} \langle p, q \rangle, \quad \langle p, cq \rangle = c \langle p, q \rangle, \quad c \in \mathbb{C},$$

thus  $\langle t, t \rangle = \langle s_1 + is_2, s_1 + is_2 \rangle = 2$ ,  $\langle t, \bar{t} \rangle = 0$ ,  $\langle \bar{t}, \bar{t} \rangle = 2$ . Now suppose  $p$  is given in complex form  $p(z, \bar{z}) = \sum_{j,k} a_{jk} z^j \bar{z}^k$  then set  $p^*(z, \bar{z}) = \sum_{j,k} \bar{a}_{jk} z^k \bar{z}^j$  and replace  $x_j$  by  $\mathcal{D}_j$  and conjugate.

This leads to  $p^*(\mathcal{D}_1 + i\mathcal{D}_2, \mathcal{D}_1 - i\mathcal{D}_2) = p^*(2\bar{\mathcal{D}}, 2\mathcal{D})$  (in more detail, if  $p = \sum_{j,k} a_{jk} z^j \bar{z}^k$  then

$$p^*(2\bar{\mathcal{D}}, 2\mathcal{D}) = \sum_{j,k} \bar{a}_{jk} 2^{j+k} \mathcal{D}^j \bar{\mathcal{D}}^k).$$

Then the form is given by

$$\langle p_1(z, \bar{z})t + p_2(z, \bar{z})\bar{t}, q(z, \bar{z}, t, \bar{t}) \rangle = \langle t, p_1^*(2\bar{\mathcal{D}}, 2\mathcal{D})q \rangle|_{z=0} + \langle \bar{t}, p_2^*(2\bar{\mathcal{D}}, 2\mathcal{D})q \rangle|_{z=0}. \quad (3)$$

The form is defined for all  $\kappa$ . It is positive-definite provided that  $-\frac{\ell}{m} < \kappa < \frac{\ell}{m}$ , as will be shown. This is related to the results of Etingof and Stoica [4, Proposition 4.3] on unitary representations. The (abstract) Gaussian form is defined for  $f, g \in \mathcal{P}_{m,\ell}$  by

$$\langle f, g \rangle_G = \langle e^{\Delta_\kappa/2} f, e^{\Delta_\kappa/2} g \rangle = \langle e^{2\mathcal{D}\bar{\mathcal{D}}} f, e^{2\mathcal{D}\bar{\mathcal{D}}} g \rangle.$$

This has the important property that  $\langle pf, g \rangle_G = \langle f, p^*g \rangle_G$  for any scalar polynomial  $p(z, \bar{z})$ . This motivates the attempt to express the pairing in integral form, specifically

$$\langle f, g \rangle_G = \int_{\mathbb{C}} gKf^* e^{-|z|^2/2} dm_2(z), \quad (4)$$

where  $f, g \in \mathcal{P}_{m,\ell}$  are interpreted as vectors  $f_1(z, \bar{z})t + f_2(z, \bar{z})\bar{t} \mapsto (f_1, f_2)$  and  $K$  is an integrable Hermitian  $2 \times 2$  matrix function. We preview the formula for  $K$  on the fundamental chamber  $\{z = re^{i\theta} : r > 0, 0 < \theta < \frac{\pi}{m}\}$ , in the real coordinate system, in terms of auxiliary parameters and functions:

$$\text{Set } v := \sin^2 \frac{m\theta}{2}, \quad \delta := \frac{1}{2} - \frac{\ell}{m},$$

$$\begin{aligned} f_1(\kappa, \delta; v) &:= v^{\kappa/2} (1-v)^{-\kappa/2} {}_2F_1 \left( \begin{matrix} \delta, -\delta \\ \frac{1}{2} + \kappa \end{matrix}; v \right), \\ f_2(\kappa, \delta; v) &:= \frac{\delta}{\frac{1}{2} + \kappa} v^{(\kappa+1)/2} (1-v)^{(1-\kappa)/2} {}_2F_1 \left( \begin{matrix} 1 + \delta, 1 - \delta \\ \frac{3}{2} + \kappa \end{matrix}; v \right), \\ H(\kappa, \delta) &:= \frac{\Gamma(\frac{1}{2} + \kappa)^2}{\Gamma(\frac{1}{2} + \kappa + \delta) \Gamma(\frac{1}{2} + \kappa - \delta)}, \end{aligned}$$

and

$$L(\theta) = \begin{bmatrix} f_1(\kappa, \delta; v) & f_2(\kappa, \delta; v) \\ -f_2(-\kappa, \delta; v) & f_1(-\kappa, \delta; v) \end{bmatrix} \begin{bmatrix} \cos \delta m\theta & -\sin \delta m\theta \\ \sin \delta m\theta & \cos \delta m\theta \end{bmatrix},$$

then

$$K(r, \theta) = \frac{\cos \pi\kappa}{2\pi \cos \pi\delta} L(\theta)^T \begin{bmatrix} H(-\kappa, \delta) & 0 \\ 0 & H(\kappa, \delta) \end{bmatrix} L(\theta).$$

The equation  $K(zw) = \tau_\ell(w)^{-1} K(z) \tau_\ell(w)$  defines  $K$  on the other chambers  $\{z = re^{i\theta} : r > 0, (j-1)\frac{\pi}{m} < \theta < j\frac{\pi}{m}\}$ ,  $2 \leq j \leq 2m$ .

Usually we will write  $\partial_u := \frac{\partial}{\partial u}$  for a variable  $u$ .

## 2 Harmonic polynomials

In this section we construct a basis for the (vector-valued) harmonic ( $\Delta_\kappa f = 0$ ) homogeneous polynomials. These are important here because for generic  $\kappa$  any polynomial in  $\mathcal{P}_{m,\ell}$  has a unique expansion as a sum of terms like  $(z\bar{z})^n f(z, \bar{z}, t, \bar{t})$  where  $f$  is homogeneous and  $\Delta_\kappa f = 0$  (see [2, (5), p. 4]); furthermore  $\langle f, g \rangle_G = \langle f, g \rangle$  for any harmonic polynomials  $f, g$ . Complex coordinates are best suited for this study. To each monomial in  $z, \bar{z}, t$  or  $\bar{t}$  associate the degree and the  $m$ -parity: (with  $a, b \in \mathbb{N}_0$ )

- 1) the degree is given by  $\deg(z^a \bar{z}^b t) = \deg(z^a \bar{z}^b \bar{t}) = a + b$ ,
- 2) the  $m$ -parities of  $z^a \bar{z}^b t, z^a \bar{z}^b \bar{t}$  are  $a - b + \ell \bmod m, a - b - \ell \bmod m$ , respectively.

If each monomial in a polynomial  $p$  has the same degree and  $m$ -parity then say that  $p$  has this degree and  $m$ -parity (this implies  $p$  is homogeneous in  $z, \bar{z}$ ). The following is a product rule.

**Proposition 1.** For  $f \in \mathcal{P}_{m,\ell}$

$$\begin{aligned} \mathcal{D}_z f(z, \bar{z}, t, \bar{t}) &= (z\mathcal{D} + 1)f(z, \bar{z}, t, \bar{t}) + \kappa \sum_{j=0}^{m-1} f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j}\bar{t}, \omega^{-\ell j}t), \\ \bar{\mathcal{D}}_z f(z, \bar{z}, t, \bar{t}) &= z\bar{\mathcal{D}}f(z, \bar{z}, t, \bar{t}) - \kappa \sum_{j=0}^{m-1} f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j}\bar{t}, \omega^{-\ell j}t)\omega^j. \end{aligned}$$

**Proof.** Abbreviate  $g_j = f(z, \bar{z}, \omega^{\ell j}\bar{t}, \omega^{-\ell j}t)$  and  $h_j = f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j}\bar{t}, \omega^{-\ell j}t)$ . Then

$$\begin{aligned} \mathcal{D}_z f(z, \bar{z}, t, \bar{t}) &= \left( z \frac{\partial}{\partial z} + 1 \right) f(z, \bar{z}, t, \bar{t}) + \kappa \sum_{j=0}^{m-1} \frac{zg_j - \bar{z}\omega^j h_j}{z - \bar{z}\omega^j} \\ &= \left( z \frac{\partial}{\partial z} + 1 \right) f(z, \bar{z}, t, \bar{t}) + \kappa \sum_{j=0}^{m-1} \left\{ \frac{zg_j - zh_j}{z - \bar{z}\omega^j} + \frac{zh_j - \bar{z}\omega^j h_j}{z - \bar{z}\omega^j} \right\} \\ &= (z\mathcal{D} + 1)f(z, \bar{z}, t, \bar{t}) + \kappa \sum_{j=0}^{m-1} h_j. \end{aligned}$$

The second formula is proved similarly. ■

With the aim of using Proposition 1 define

$$\begin{aligned} T_z f(z, \bar{z}, t, \bar{t}) &:= \sum_{j=0}^{m-1} f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j}\bar{t}, \omega^{-\ell j}t), \\ T_{\bar{z}} f(z, \bar{z}, t, \bar{t}) &:= \sum_{j=0}^{m-1} f(\bar{z}\omega^j, z\omega^{-j}, \omega^{\ell j}\bar{t}, \omega^{-\ell j}t)\omega^j. \end{aligned}$$

**Lemma 1.** Suppose that  $p \in \mathcal{P}_{m,\ell}$  has  $m$ -parity  $r$  then  $T_z p = 0$  for  $r \not\equiv 0 \pmod{m}$ ,  $T_z p = m\sigma_0 p$  for  $r \equiv 0 \pmod{m}$ ,  $T_{\bar{z}} p = 0$  for  $r \not\equiv m-1 \pmod{m}$  and  $T_{\bar{z}} p = m\sigma_0 p$  if  $r \equiv m-1 \pmod{m}$ .

**Proof.** Consider  $T_z z^a \bar{z}^b t = z^b \bar{z}^a \bar{t} \sum_{j=0}^{m-1} \omega^{(a-b+\ell)j}$ ; the sum is zero if  $a-b+\ell \not\equiv 0 \pmod{m}$ , otherwise  $T_z z^a \bar{z}^b t = m\sigma_0(z^a \bar{z}^b t)$ . The same argument applies to  $T_z z^a \bar{z}^b \bar{t}$  whose  $m$ -parity is  $a-b-\ell$ . Similarly  $T_{\bar{z}} z^a \bar{z}^b t = z^b \bar{z}^a \bar{t} \sum_{j=0}^{m-1} \omega^{(a-b+\ell+1)j}$ . ■

A polynomial  $p$  is called harmonic if  $\mathcal{D}\bar{\mathcal{D}}p = 0$ . By using an inductive construction we do not need to explicitly determine the action of  $\mathcal{D}$ ,  $\bar{\mathcal{D}}$  on general monomials.

**Proposition 2.** Suppose that  $p \in \mathcal{P}_{m,\ell}$  has  $m$ -parity  $r$  with  $r \not\equiv 0 \pmod{m}$ , and  $\bar{\mathcal{D}}p = 0$  then  $\mathcal{D}zp = (z\mathcal{D} + 1)p$  and  $\bar{\mathcal{D}}zp = -\kappa m\sigma_0 p$  if  $r \equiv m-1 \pmod{m}$ , otherwise  $\bar{\mathcal{D}}zp = 0$ .

**Proof.** By Proposition 1  $\mathcal{D}zp = (z\mathcal{D} + 1)p + \kappa T_z p$  and  $T_z p = 0$  by the lemma. Also  $\bar{\mathcal{D}}zp = z\bar{\mathcal{D}}p - \kappa T_{\bar{z}} p$ . ■

Notice that  $p = t$  or  $p = \bar{t}$  with degree 0 and  $m$ -parities  $\ell$  and  $m-\ell$  respectively, satisfy the hypotheses of the following.

**Theorem 1.** Suppose that  $p \in \mathcal{P}_{m,\ell}$  has  $m$ -parity  $r$  with  $1 \leq r \leq m-1$ ,  $\deg p = n$ ,  $z\mathcal{D}p = np$  and  $\overline{\mathcal{D}}p = 0$  then  $\mathcal{D}z^s p = (n+s)z^{s-1}p$  for  $0 \leq s \leq m-r$ ,  $\overline{\mathcal{D}}z^s p = 0$  for  $0 \leq s \leq m-1-r$  and  $\overline{\mathcal{D}}z^{m-r} p = -m\kappa\overline{z}^{m-1-r}\sigma_0 p$ . Furthermore  $q := z^{m-r}p + \frac{m\kappa}{m-r+n}\overline{z}^{m-r}\sigma_0 p$  has  $m$ -parity 0 and satisfies

$$\begin{aligned} \mathcal{D}q &= (m-r+n) \left\{ 1 - \left( \frac{m\kappa}{m-r+n} \right)^2 \right\} z^{m-r-1}p, & \overline{\mathcal{D}}q &= 0, \\ \mathcal{D}zq &= (m+n-r+1)q, & \overline{\mathcal{D}}zq &= 0. \end{aligned}$$

**Proof.** By Lemma 1  $T_z z^s p = 0$  for  $0 \leq s < m-r$ . Arguing by induction suppose  $\mathcal{D}z^s p = (n+s)z^{s-1}p$  for some  $s$  satisfying  $1 \leq s < m-r$  then by Proposition 2  $\mathcal{D}z^{s+1}p = (z\mathcal{D}+1)z^s p = ((n+s)+1)z^s p$ . Similarly  $T_{\overline{z}} z^s p = 0$  for  $0 \leq s \leq m-2-r$  and  $\overline{\mathcal{D}}z^s p = 0$  for  $1 \leq s \leq m-1-r$ . Also  $\overline{\mathcal{D}}z^{m-r} p = -m\kappa\sigma_0(z^{m-r-1}p)$ . Thus

$$\overline{\mathcal{D}}q = \overline{\mathcal{D}}z^{m-r} p + \frac{m\kappa}{m-r+n}\overline{\mathcal{D}}\sigma_0(z^{m-r}p) = -m\kappa\sigma_0(z^{m-r-1}p) + \frac{m\kappa}{m-r+n}\sigma_0\mathcal{D}z^{m-r}p = 0,$$

and

$$\begin{aligned} \mathcal{D}q &= \mathcal{D}z^{m-r}p + \frac{m\kappa}{m-r+n}\mathcal{D}\sigma_0(z^{m-r}p) \\ &= (m-r+n)z^{m-r-1}p + \frac{m\kappa}{m-r+n}\sigma_0\overline{\mathcal{D}}z^{m-r}p \\ &= (m-r+n)z^{m-r-1}p + \frac{m\kappa}{m-r+n}\sigma_0(-m\kappa\sigma_0z^{m-r-1}p) \\ &= (m-r+n) \left\{ 1 - \left( \frac{m\kappa}{m-r+n} \right)^2 \right\} z^{m-r-1}p. \end{aligned}$$

The  $m$ -parity of  $q$  is zero and  $\overline{\mathcal{D}}q = 0$  thus  $\overline{\mathcal{D}}zq = 0$ . By Proposition 1

$$\begin{aligned} \mathcal{D}zq &= z\mathcal{D}q + q + m\kappa\sigma_0q = (m-r+n) \left\{ 1 - \left( \frac{m\kappa}{m-r+n} \right)^2 \right\} z^{m-r}p \\ &\quad + z^{m-r}p + \frac{m\kappa}{m-r+n}\overline{z}^{m-r}\sigma_0 p + m\kappa \left\{ \overline{z}^{m-r}\sigma_0 p + \frac{m\kappa}{m-r+n}z^{m-r}p \right\} \\ &= (m-r+n+1) \left\{ z^{m-r}p + \frac{m\kappa}{m-r+n}\overline{z}^{m-r}\sigma_0 p \right\}. \end{aligned}$$

This completes the proof. ■

**Corollary 1.** With the same hypotheses  $z^s p$ ,  $\overline{z}^s \sigma_0 p$  for  $0 \leq s \leq m-r$ , and  $zq$ ,  $\sigma_0(zq)$  are harmonic.

**Proof.** Each of these polynomials  $f$  satisfy  $\mathcal{D}f = 0$  or  $\overline{\mathcal{D}}f = 0$  (recall  $\mathcal{D}\sigma_0 = \sigma_0\overline{\mathcal{D}}$ ) with the exception of  $z^{m-r}p$  and  $\sigma_0(z^{m-r}p)$ . But  $\overline{\mathcal{D}}\mathcal{D}z^{m-r}p = (m-r+n)\overline{\mathcal{D}}z^{m-r-1}p = 0$ . ■

Observe that  $\mathcal{D}$ ,  $\overline{\mathcal{D}}$  change the  $m$ -parity by  $-1, +1$  respectively. The leading term of a homogeneous polynomial  $\sum_{j=0}^n a_j z^{n-j} \overline{z}^j t + \sum_{j=0}^n b_j z^{n-j} \overline{z}^j \overline{t}$  is defined to be  $(a_0 z^n + a_n \overline{z}^n)t + (b_0 z^n + b_n \overline{z}^n)\overline{t}$ .

There are 4 linearly independent harmonic polynomials of each degree  $\geq 1$ . Recall  $\sigma_0 p(z, \overline{z}, t, \overline{t}) = p(\overline{z}, z, \overline{t}, t)$ . By use of Theorem 1 we find there are two sequences of harmonic homogeneous polynomials  $\{p_n^{(1)}, \sigma_0 p_n^{(1)} : n \geq 1\}$  and  $\{p_n^{(2)}, \sigma_0 p_n^{(2)} : n \geq 1\}$  with the properties:

- 1) the leading terms of  $p_n^{(1)}, \sigma_0 p_n^{(1)}, p_n^{(2)}, \sigma_0 p_n^{(2)}$  are  $z^n t, \overline{z}^n \overline{t}, z^n \overline{t}, \overline{z}^n t$  respectively,

- 2)  $p_1^{(1)} = zt$ ,  $\sigma_0 p_1^{(1)} = \bar{z}\bar{t}$ ,
- 3) if  $n + \ell \neq 0 \pmod m$  then  $p_{n+1}^{(1)} = zp_n^{(1)}$ ,
- 4) if  $n + \ell = 0 \pmod m$  then  $p_{n+1}^{(1)} = z(p_n^{(1)} + \frac{m\kappa}{n}\sigma_0 p_n^{(1)})$ ;
- 5)  $p_1^{(2)} = z\bar{t}$ ,  $\sigma_0 p_1^{(2)} = \bar{z}t$ ,
- 6) if  $n - \ell \neq 0 \pmod m$  then  $p_{n+1}^{(2)} = zp_n^{(2)}$ ,
- 7) if  $n - \ell = 0 \pmod m$  then  $p_{n+1}^{(2)} = z(p_n^{(2)} + \frac{m\kappa}{n}\sigma_0 p_n^{(2)})$ .

The consequence of these relations is that there exist polynomials  $P_n^{(1)}$  and  $P_n^{(2)}$  of degrees  $m(n+1) - \ell + 1$  and  $nm + \ell + 1$  respectively ( $n \geq 0$ ) such that

- 1)  $p_r^{(1)} = z^r t$  for  $1 \leq r \leq m - \ell$  and  $p_s^{(1)} = z^r P_n^{(1)}$  for  $s = m(n+1) - \ell + 1 + r$  and  $0 \leq r < m$ ;
- 2)  $p_r^{(2)} = z^r \bar{t}$  for  $1 \leq r \leq \ell$  and  $p_s^{(2)} = z^r P_n^{(2)}$  for  $s = nm + \ell + 1 + r$  and  $0 \leq r < m$ .

The formulae imply recurrences:

- 1)  $P_0^{(1)} = z^{m-\ell+1}t + \frac{m\kappa}{m-\ell}z\bar{z}^{m-\ell}\bar{t}$  and  $P_{n+1}^{(1)} = z^m P_n^{(1)} + \frac{m\kappa}{(n+1)m+(m-\ell)}z\bar{z}^{m-1}\sigma_0 P_n^{(1)}$ ;
- 2)  $P_0^{(2)} = z^{\ell+1}\bar{t} + \frac{m\kappa}{\ell}z\bar{z}^\ell t$  and  $P_{n+1}^{(2)} = z^m P_n^{(2)} + \frac{m\kappa}{(n+1)m+\ell}z\bar{z}^{m-1}\sigma_0 P_n^{(2)}$ .

There is a common thread in these recurrences. Let  $\lambda$  be a parameter with  $\lambda > 0$  and define polynomials  $Q_n^{(1)}(\kappa, \lambda; w, \bar{w})$ ,  $Q_n^{(2)}(\kappa, \lambda; w, \bar{w})$  by

$$\begin{aligned} Q_0^{(1)}(\kappa, \lambda; w, \bar{w}) &= 1, & Q_0^{(2)}(\kappa, \lambda; w, \bar{w}) &= \frac{\kappa}{\lambda}, \\ Q_{n+1}^{(1)}(\kappa, \lambda; w, \bar{w}) &= wQ_n^{(1)}(\kappa, \lambda; w, \bar{w}) + \frac{\kappa}{\lambda + n + 1}\bar{w}Q_n^{(2)}(\kappa, \lambda; \bar{w}, w), \\ Q_{n+1}^{(2)}(\kappa, \lambda; w, \bar{w}) &= \frac{\kappa}{\lambda + n + 1}\bar{w}Q_n^{(1)}(\kappa, \lambda; \bar{w}, w) + wQ_n^{(2)}(\kappa, \lambda; w, \bar{w}). \end{aligned}$$

There is a closed form point evaluation:

**Proposition 3.** For  $\lambda > 0$  and  $n \geq 0$

$$\begin{aligned} Q_n^{(1)}(\kappa, \lambda; 1, 1) &= \frac{(\lambda + \kappa)_{n+1} + (\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}}, \\ Q_n^{(2)}(\kappa, \lambda; 1, 1) &= \frac{(\lambda + \kappa)_{n+1} - (\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}}. \end{aligned}$$

**Proof.** The statement is obviously true for  $n = 0$ . Arguing by induction suppose the statement is valid for some  $n$  then

$$\begin{aligned} Q_{n+1}^{(1)}(\kappa, \lambda; 1, 1) &= \frac{(\lambda + \kappa)_{n+1} + (\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}} + \frac{\kappa}{\lambda + n + 1} \left\{ \frac{(\lambda + \kappa)_{n+1} - (\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}} \right\} \\ &= \frac{(\lambda + \kappa)_{n+1}}{2(\lambda)_{n+1}} \left\{ 1 + \frac{\kappa}{\lambda + n + 1} \right\} + \frac{(\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}} \left\{ 1 - \frac{\kappa}{\lambda + n + 1} \right\} \\ &= \frac{(\lambda + \kappa)_{n+2}}{2(\lambda)_{n+2}} + \frac{(\lambda - \kappa)_{n+2}}{2(\lambda)_{n+2}}, \end{aligned}$$

and

$$\begin{aligned} Q_{n+1}^{(2)}(\kappa, \lambda; 1, 1) &= \frac{\kappa}{\lambda + n + 1} \left\{ \frac{(\lambda + \kappa)_{n+1} + (\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}} \right\} + \frac{(\lambda + \kappa)_{n+1} - (\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}} \\ &= \frac{(\lambda + \kappa)_{n+1}}{2(\lambda)_{n+1}} \left\{ 1 + \frac{\kappa}{\lambda + n + 1} \right\} - \frac{(\lambda - \kappa)_{n+1}}{2(\lambda)_{n+1}} \left\{ 1 - \frac{\kappa}{\lambda + n + 1} \right\}. \end{aligned}$$

This completes the proof. ■

**Proposition 4.** For  $n \geq 0$

$$\begin{aligned} P_n^{(1)} &= z^{m-\ell+1} Q_n^{(1)} \left( \kappa, \frac{m-\ell}{m}; z^m, \bar{z}^m \right) t + z \bar{z}^{m-\ell} Q_n^{(2)} \left( \kappa, \frac{m-\ell}{m}; z^m, \bar{z}^m \right) \bar{t}, \\ P_n^{(2)} &= z^{\ell+1} Q_n^{(1)} \left( \kappa, \frac{\ell}{m}; z^m, \bar{z}^m \right) \bar{t} + z \bar{z}^\ell Q_n^{(2)} \left( \kappa, \frac{\ell}{m}; z^m, \bar{z}^m \right) t. \end{aligned}$$

**Proof.** The statement is true for  $n = 0$ . Suppose that the first one holds for some  $n$ , then set  $\lambda = \frac{m-\ell}{m}$  and

$$\begin{aligned} P_{n+1}^{(1)} &= z^m P_n^{(1)} + \frac{m\kappa}{(n+1)m + (m-\ell)} z \bar{z}^{m-1} \sigma_0 P_n^{(1)} \\ &= z^m \left( z^{m-\ell+1} Q_n^{(1)}(\kappa, \lambda; z^m, \bar{z}^m) t + z \bar{z}^{m-\ell} Q_n^{(2)}(\kappa, \kappa; z^m, \bar{z}^m) \bar{t} \right) \\ &\quad + \frac{\kappa}{n+1+\lambda} z \bar{z}^{m-1} \left( \bar{z}^{m-\ell+1} Q_n^{(1)}(\kappa, \lambda; \bar{z}^m, z^m) \bar{t} + z^{m-\ell} \bar{z} Q_n^{(2)}(\kappa, \lambda; \bar{z}^m, z^m) t \right) \\ &= z^{m-\ell+1} t \left( z^m Q_n^{(1)}(\kappa, \lambda; z^m, \bar{z}^m) + \frac{\kappa}{n+1+\lambda} \bar{z}^m Q_n^{(2)}(\kappa, \lambda; \bar{z}^m, z^m) \right) \\ &\quad + z \bar{z}^{m-\ell} \bar{t} \left( z^m Q_n^{(2)}(\kappa, \kappa; z^m, \bar{z}^m) + \frac{\kappa}{n+1+\lambda} \bar{z}^m Q_n^{(1)}(\kappa, \lambda; \bar{z}^m, z^m) \right) \\ &= z^{m-\ell+1} Q_{n+1}^{(1)}(\kappa, \lambda; z^m, \bar{z}^m) t + z \bar{z}^{m-\ell} Q_{n+1}^{(2)}(\kappa, \kappa; z^m, \bar{z}^m) \bar{t}; \end{aligned}$$

this proves the first part by induction. The same argument applies with  $\ell$  replaced by  $m - \ell$  and  $t, \bar{t}$  interchanged.  $\blacksquare$

**Proposition 5.** For  $n \geq 0$

$$\begin{aligned} Q_n^{(1)}(\kappa, \lambda; w, \bar{w}) &= w^n + \sum_{j=1}^n \frac{\kappa^2(n-j+1)}{\lambda(\lambda+n)} {}_4F_3 \left( \begin{matrix} 1-j, j-n, 1-\kappa, 1+\kappa \\ 2, \lambda+1, -\lambda-n+1 \end{matrix}; 1 \right) w^{n-j} \bar{w}^j, \\ Q_n^{(2)}(\kappa, \lambda; w, \bar{w}) &= \sum_{j=0}^n \frac{\kappa}{\lambda+j} {}_4F_3 \left( \begin{matrix} -j, j-n, -\kappa, +\kappa \\ 1, \lambda, -\lambda-n \end{matrix}; 1 \right) w^{n-j} \bar{w}^j. \end{aligned}$$

**Proof.** Set  $Q_n^{(1)}(\kappa, \lambda; w, \bar{w}) = \sum_{j=0}^n a_{n,j} w^{n-j} \bar{w}^j$  and  $Q_n^{(2)}(\kappa, \lambda; w, \bar{w}) = \sum_{j=0}^n b_{n,j} w^{n-j} \bar{w}^j$ , then the recurrence is equivalent to  $a_{0,0} = 1, b_{0,0} = \frac{\kappa}{\lambda}$  and

$$a_{n+1,j} = a_{n,j} + \frac{\kappa}{\lambda+n+1} b_{n,n+1-j}, \quad b_{n+1,j} = b_{n,j} + \frac{\kappa}{\lambda+n+1} a_{n,n+1-j},$$

for  $0 \leq j \leq n+1$  (with  $a_{n,n+1} = 0 = b_{n,n+1}$ ). It is clear that  $a_{n+1,0} = a_{n,0} = 1$  and  $b_{n+1,0} = b_{n,0} = \frac{\kappa}{\lambda}$ . Now let  $1 \leq j \leq n+1$ . In the following sums the upper limit can be taken as  $n+1$ . Proceeding by induction we verify that  $a_{n+1,j} - a_{n,j} = \frac{\kappa}{\lambda+n+1} b_{n,n+1-j}$  using the formulae. The left-hand side is

$$\begin{aligned} &\frac{\kappa^2(n-j+2)}{\lambda(\lambda+n+1)} {}_4F_3 \left( \begin{matrix} 1-j, j-n-1, 1-\kappa, 1+\kappa \\ 2, \lambda+1, -\lambda-n \end{matrix}; 1 \right) \\ &\quad - \frac{\kappa^2(n-j+1)}{\lambda(\lambda+n)} {}_4F_3 \left( \begin{matrix} 1-j, j-n, 1-\kappa, 1+\kappa \\ 2, \lambda+1, -\lambda-n+1 \end{matrix}; 1 \right) \\ &= \frac{\kappa^2}{\lambda} \sum_{i=0}^{n+1} \frac{(1-j)_i (1-\kappa)_i (1+\kappa)_i}{(2)_i (\lambda+1)_i i!} \left\{ \frac{(n-j+2)(j-n-1)_i}{(\lambda+n+1)(-\lambda-n)_i} - \frac{(n-j+1)(j-n)_i}{(\lambda+n)(-\lambda-n+1)_i} \right\} \end{aligned}$$

$$\begin{aligned}
&= \frac{\kappa^2}{\lambda} \sum_{i=0}^{n+1} \frac{(1-j)_i (1-\kappa)_i (1+\kappa)_i}{(i+1)! (\lambda+1)_i i!} \left\{ \frac{(j-n-2)_{i+1}}{(-\lambda-n-1)_{i+1}} - \frac{(j-n-1)_{i+1}}{(-\lambda-n)_{i+1}} \right\} \\
&= \frac{\kappa^2}{\lambda} \sum_{i=0}^{n+1} \frac{(1-j)_i (1-\kappa)_i (1+\kappa)_i (j-n-1)_i (i+1)(\lambda+j-1)}{(i+1)! (\lambda+1)_i i! (-\lambda-n-1)_{i+2}} \\
&= \frac{\kappa^2 (\lambda+j-1)}{\lambda (\lambda+n+1) (\lambda+n)} {}_4F_3 \left( \begin{matrix} 1-j, j-n-1, 1-\kappa, 1+\kappa \\ 1, \lambda+1, -\lambda-n+1 \end{matrix}; 1 \right).
\end{aligned}$$

The  ${}_4F_3$  is balanced and we can apply the transformation (see [5, (16.4.14)]) to show

$$\begin{aligned}
&{}_4F_3 \left( \begin{matrix} 1-j, j-n-1, 1-\kappa, 1+\kappa \\ 1, \lambda+1, -\lambda-n+1 \end{matrix}; 1 \right) \\
&= \frac{(\lambda+2-j+n)_{j-1} (-\lambda+2-j)_{j-1}}{(\lambda+1)_{j-1} (-\lambda-n+1)_{j-1}} {}_4F_3 \left( \begin{matrix} 1-j, j-n-1, -\kappa, \kappa \\ 1, \lambda, -\lambda-n \end{matrix}; 1 \right) \\
&= \frac{\lambda(\lambda+n)}{(\lambda+j-1)(\lambda+n+1-j)} \frac{\lambda+n+1-j}{\kappa} b_{n,n-j+1},
\end{aligned}$$

and this proves the first recurrence relation.

Next verify  $b_{n+1,j} - b_{n,j} = \frac{\kappa}{\lambda+n+1} a_{n,n+1-j}$ . The left-hand side equals

$$\begin{aligned}
&\frac{\kappa}{\lambda+j} \sum_{i=0}^{n+1} \frac{(-j)_i (-\kappa)_i (\kappa)_i}{i! i! (\lambda)_i} \left\{ \frac{(j-n-1)_i}{(-\lambda-n-1)_i} - \frac{(j-n)_i}{(-\lambda-n)_i} \right\} \\
&= \frac{\kappa}{\lambda+j} \sum_{i=1}^{n+1} \frac{(-j)_i (-\kappa)_i (\kappa)_i (j-n)_{i-1}}{i! i! (\lambda)_i (-\lambda-n)_{i-1}} \left\{ \frac{j-n-1}{-\lambda-n-1} - \frac{j-n+i-1}{-\lambda-n+i-1} \right\} \\
&= \frac{\kappa}{\lambda+j} \sum_{i=1}^{n+1} \frac{(-j)_i (-\kappa)_i (\kappa)_i (j-n)_{i-1} (\lambda+j)_i}{i! i! (\lambda)_i (-\lambda-n-1)_{i+1}} \\
&= \left( \frac{\kappa}{\lambda+n+1} \right) \frac{\kappa^2 j}{\lambda(\lambda+n)} \sum_{s=0}^{n+1} \frac{(1-j)_s (j-n)_s (1-\kappa)_s (1+\kappa)_s}{s! (2)_s (\lambda+1)_{s+1} (-\lambda-n+1)_s} \\
&= \left( \frac{\kappa}{\lambda+n+1} \right) a_{n,n+1-j},
\end{aligned}$$

where the index of summation is changed  $s = i - 1$ . ■

We consider the differentiation formulae. Set  $\lambda_1 := \frac{m-\ell}{m}$ ,  $\lambda_2 := \frac{\ell}{m}$ . In the previous section we used  $\delta := \frac{1}{2} - \frac{\ell}{m}$ ; thus  $\delta = \frac{1}{2} - \lambda_2 = \lambda_1 - \frac{1}{2}$ . For  $n \geq 0$  we have  $\deg P_n^{(1)} = m(n+1) - \ell + 1 = m(n + \lambda_1) + 1$  and  $\deg P_n^{(2)} = mn + \ell + 1 = m(n + \lambda_2) + 1$ , then (using  $P_{-1}^{(1)} = z^{1-\ell} t$  and  $P_{-1}^{(2)} = z^{1+\ell-m} \bar{t}$ ) for  $j = 1, 2$

$$\begin{aligned}
\mathcal{D}z^r P_n^{(j)} &= (m(n + \lambda_j) + r + 1) z^{r-1} P_n^{(j)}, \quad 1 \leq r \leq m-1, \\
\mathcal{D}P_n^{(j)} &= (m(n + \lambda_j) + 1) \left( z^{m-1} P_{n-1}^{(j)} + \frac{\kappa}{n + \lambda_j} \bar{z}^{m-1} \sigma_0 P_{n-1}^{(j)} \right), \\
\mathcal{D}^2 P_n^{(j)} &= (m(n + \lambda_j) + 1) m(n + \lambda_j) \left\{ 1 - \left( \frac{\kappa}{n + \lambda_j} \right)^2 \right\} z^{m-2} P_{n-1}^{(j)}, \\
\overline{\mathcal{D}}z^r P_n^{(j)} &= 0, \quad 0 \leq r \leq m-2, \\
\overline{\mathcal{D}}z^{m-1} P_n^{(j)} &= -m\kappa \bar{z}^{m-2} \sigma_0 P_n^{(j)}.
\end{aligned}$$

The other differentiations follow from  $\overline{\mathcal{D}} = \sigma_0 \mathcal{D} \sigma_0$ .



Notice we have an evaluation formula for  $p_n^{(j)}(1)$  ( $j = 1, 2$ ): suppose  $n = m(k + \lambda_j) + r$  with  $1 \leq r \leq m$  then

$$\begin{aligned} p_n^{(1)}(1) &= \frac{1}{2} \frac{(\lambda_1 + \kappa)_{k+1}}{(\lambda_1)_{k+1}} (t + \bar{t}) + \frac{1}{2} \frac{(\lambda_1 - \kappa)_{k+1}}{(\lambda_1)_{k+1}} (t - \bar{t}), \\ p_n^{(2)}(1) &= \frac{1}{2} \frac{(\lambda_2 + \kappa)_{k+1}}{(\lambda_2)_{k+1}} (t + \bar{t}) - \frac{1}{2} \frac{(\lambda_2 - \kappa)_{k+1}}{(\lambda_2)_{k+1}} (t - \bar{t}). \end{aligned}$$

### 3 The bilinear form on harmonic polynomials

Recall (formula (3)) that the form is given by

$$\langle p_1(z, \bar{z})t + p_2(z, \bar{z})\bar{t}, q(z, \bar{z}, t, \bar{t}) \rangle = \langle t, p_1^*(2\bar{\mathcal{D}}, 2\mathcal{D})q \rangle|_{z=0} + \langle \bar{t}, p_2^*(2\bar{\mathcal{D}}, 2\mathcal{D})q \rangle|_{z=0}.$$

We will compute values for the harmonic polynomials. Suppose  $q$  is harmonic of degree  $n$  and  $p = \sum_{j=0}^n a_j z^{n-j} \bar{z}^j t + \sum_{j=0}^n b_j z^{n-j} \bar{z}^j \bar{t}$  with arbitrary coefficients  $\{a_j\}$ ,  $\{b_j\}$ , then

$$\begin{aligned} 2^{-n} \langle p, q \rangle &= \left\langle t, \sum_{j=0}^n \bar{a}_j \mathcal{D}^{n-j} \bar{\mathcal{D}}^j q \right\rangle + \left\langle \bar{t}, \sum_{j=0}^n \bar{b}_j \mathcal{D}^{n-j} \bar{\mathcal{D}}^j q \right\rangle \\ &= \langle t, (\bar{a}_0 \mathcal{D}^n + \bar{a}_n \bar{\mathcal{D}}^n) q \rangle + \langle \bar{t}, (\bar{b}_0 \mathcal{D}^n + \bar{b}_n \bar{\mathcal{D}}^n) q \rangle, \end{aligned} \quad (5)$$

because  $\mathcal{D}^{n-j} \bar{\mathcal{D}}^j q = 0$  for  $1 \leq j \leq n-1$ . Thus  $\langle p_n^{(1)}, q \rangle = 2^n \langle t, \mathcal{D}^n q \rangle$  and  $\langle p_n^{(2)}, q \rangle = 2^n \langle \bar{t}, \mathcal{D}^n q \rangle$ ; this follows from the leading terms of  $p_n^{(1)}, p_n^{(2)}$ .

Define  $\alpha_n$  by  $\mathcal{D}^n p_n^{(1)} = \alpha_n t$  (we will show that there is no  $\bar{t}$  component). If  $1 \leq n \leq m - \ell$  then  $p_n^{(1)} = z^n t$  and  $\mathcal{D}^n z^n t = n! t$  so  $\alpha_n = n!$ . Suppose  $n = m(k + \lambda_j) + r + 1$  for some  $k \geq 0$  and  $1 \leq r \leq m - 1$ , then  $p_n^{(1)} = z^r P_k^{(1)}$  and  $\mathcal{D} p_n^{(1)} = (m(n + \lambda_j) + r + 1) z^{r-1} P_k^{(1)} = n z^{r-1} P_k^{(1)}$ . Repeat this procedure to show  $\mathcal{D}^r p_n^{(1)} = n(n-1) \cdots (n-r+1) P_k^{(1)}$ , that is,  $\alpha_n = (-1)^r (-n)_r \alpha_{n-r}$ . Now suppose  $n = m(k + \lambda_j) + 1$  so that  $p_n^{(1)} = P_k^{(1)}$  and

$$\begin{aligned} \mathcal{D}^2 P_k^{(1)} &= (m(k + \lambda_j) + 1) m(k + \lambda_j) \left\{ 1 - \left( \frac{\kappa}{k + \lambda_1} \right)^2 \right\} z^{m-2} P_{k-1}^{(1)} \\ &= n(n-1) \left\{ 1 - \left( \frac{\kappa}{k + \lambda_1} \right)^2 \right\} z^{m-2} P_{k-1}^{(1)}, \\ \mathcal{D}^m P_k^{(1)} &= n(n-1) \left\{ 1 - \left( \frac{\kappa}{k + \lambda_1} \right)^2 \right\} \mathcal{D}^{m-2} z^{m-2} P_{k-1}^{(1)} \\ &= n(n-1) \left\{ 1 - \left( \frac{\kappa}{k + \lambda_1} \right)^2 \right\} (n-2) \cdots (n-m+1) P_{k-1}^{(1)} \\ &= \frac{n!}{(n-m)!} \frac{(\lambda_1 - \kappa + k)(\lambda_1 + \kappa + k)}{(\lambda_1 + k)^2} P_{k-1}^{(1)}. \end{aligned} \quad (6)$$

Induction on these results is used in the following

**Proposition 6.** For  $k = 0, 1, 2, \dots$  and  $n = m(k + \lambda_1) + 1 = m(k + 1) - \ell + 1$

$$\begin{aligned} \mathcal{D}^n P_k^{(1)} &= n! \frac{(\lambda_1 - \kappa)_{k+1} (\lambda_1 + \kappa)_{k+1}}{(\lambda_1)_{k+1}^2} t, \\ \langle P_k^{(1)}, P_k^{(1)} \rangle &= 2^{n+1} n! \frac{(\lambda_1 - \kappa)_{k+1} (\lambda_1 + \kappa)_{k+1}}{(\lambda_1)_{k+1}^2}. \end{aligned}$$

**Proof.** Suppose  $k = 0$  then

$$\mathcal{D}^2 P_0^{(1)} = (m - \ell + 1)(m - \ell) \frac{(\lambda_1 - \kappa)(\lambda_1 + \kappa)}{\lambda_1^2} z^{m-\ell-1} t$$

and  $\mathcal{D}^{m-\ell-1} z^{m-\ell-1} t = (m - \ell - 1)! t$ , so the formula is valid for  $k = 0$ . Suppose the formula is valid for some  $k \geq 0$  with  $n = m(k + 1) - \ell + 1$  then by (6)

$$\begin{aligned} \mathcal{D}^m P_{k+1}^{(1)} &= \frac{(n + m)!}{n!} \frac{(\lambda_1 - \kappa + k + 1)(\lambda_1 + \kappa + k + 1)}{(\lambda_1 + k + 1)^2} P_k^{(1)}, \\ \mathcal{D}^{n+m} P_{k+1}^{(1)} &= (n + m)! \frac{(\lambda_1 - \kappa)_{k+2} (\lambda_1 + \kappa)_{k+2} t}{(\lambda_1)_{k+2}^2}. \end{aligned}$$

This completes the induction. By Proposition 4 the coefficients of  $z^n$  and  $\bar{z}^n$  in  $P_k^{(1)}$  are  $t$  and  $0$  respectively. By equation (5)  $\langle P_k^{(1)}, P_k^{(1)} \rangle = 2^n \langle t, \mathcal{D}^n P_k^{(1)} \rangle$ . The fact that  $\langle t, t \rangle = 2$  finishes the proof. ■

**Proposition 7.** For  $k = 0, 1, 2, \dots$  and  $n = m(k + \lambda_2) + 1 = mk + \ell + 1$

$$\begin{aligned} \mathcal{D}^n P_k^{(2)} &= n! \frac{(\lambda_2 - \kappa)_{k+1} (\lambda_2 + \kappa)_{k+1} \bar{t}}{(\lambda_2)_{k+1}^2}, \\ \langle P_k^{(2)}, P_k^{(2)} \rangle &= 2^{n+1} n! \frac{(\lambda_2 - \kappa)_{k+1} (\lambda_2 + \kappa)_{k+1}}{(\lambda_2)_{k+1}^2}. \end{aligned}$$

**Proof.** The same argument used in the previous propositions works here. ■

The other basis polynomials can be handled as a consequence.

**Proposition 8.** Suppose  $j = 1, 2$ ,  $k = 0, 1, 2, \dots$ ,  $1 \leq r \leq m - 1$  and  $n = m(k + \lambda_j) + r + 1$  then  $p_n^{(j)} = z^r P_k^{(j)}$  and

$$\langle p_n^{(j)}, p_n^{(j)} \rangle = 2^{n+1} n! \frac{(\lambda_j - \kappa)_{k+1} (\lambda_j + \kappa)_{k+1}}{(\lambda_j)_{k+1}^2}.$$

**Proof.** By Theorem 1  $\mathcal{D}^r p_n^{(j)} = \frac{n!}{(n-r)!} P_k^{(j)}$  and  $\deg P_k^{(j)} = n - r = m(k + \lambda_j) + 1$ . The preceding formulae for  $\langle P_k^{(j)}, P_k^{(j)} \rangle$  imply the result. ■

The trivial cases come from  $\{p_n^{(1)} : 0 \leq n \leq m - \ell\}$  and  $\{p_n^{(2)} : 0 \leq n \leq \ell\}$ . By Theorem 1  $\mathcal{D}^n p_n^{(1)} = \mathcal{D}^n z^n t = n! t$  and  $\langle p_n^{(1)}, p_n^{(1)} \rangle = 2^{n+1} n!$  for  $0 \leq n \leq m - \ell$ . Similarly  $\mathcal{D}^n p_n^{(2)} = \mathcal{D}^n z^n \bar{t} = n! \bar{t}$  and  $\langle p_n^{(2)}, p_n^{(2)} \rangle = 2^{n+1} n!$  for  $0 \leq n \leq \ell$ .

### 3.1 Orthogonal basis for the harmonics

At each degree  $\geq 1$  we have the basis  $\{p_n^{(1)}, \sigma_0 p_n^{(1)}, p_n^{(2)}, \sigma_0 p_n^{(2)} : n \geq 1\}$ . These polynomials are pairwise orthogonal with certain exceptions. The leading terms and relevant properties are (the constants  $c_n$  are not specified, and may vary from line to line):

- 1)  $p_n^{(1)} : z^n t, \mathcal{D}^n p_n^{(1)} = c_n t, \bar{\mathcal{D}} p_n^{(1)} = 0$  if  $n + \ell \neq 0 \pmod{m}$ ;
- 2)  $\sigma_0 p_n^{(1)} : \bar{z}^n \bar{t}, \bar{\mathcal{D}}^n \sigma_0 p_n^{(1)} = c_n \bar{t}, \mathcal{D} \sigma_0 p_n^{(1)} = 0$  if  $n + \ell \neq 0 \pmod{m}$ ;
- 3)  $p_n^{(2)} : z^n \bar{t}, \mathcal{D}^n p_n^{(2)} = c_n \bar{t}, \bar{\mathcal{D}} p_n^{(2)} = 0$  if  $n - \ell \neq 0 \pmod{m}$ ;
- 4)  $\sigma_0 p_n^{(2)} : \bar{z}^n t, \bar{\mathcal{D}}^n \sigma_0 p_n^{(2)} = c_n t, \mathcal{D} \sigma_0 p_n^{(2)} = 0$  if  $n - \ell \neq 0 \pmod{m}$ .

If  $n \geq 1$  then  $\text{span}\{p_n^{(1)}, \sigma_0 p_n^{(1)}\} \perp \text{span}\{p_n^{(2)}, \sigma_0 p_n^{(2)}\}$ . This is clear from the above properties when  $n \pm \ell \neq 0 \pmod{m}$  (note  $\langle p_n^{(1)}, p_n^{(2)} \rangle = 0$  because  $\langle t, \bar{t} \rangle = 0$ ). One example suffices to

demonstrate the other cases: suppose  $n + \ell = 0 \pmod m$  then  $n - \ell \neq 0 \pmod m$  and  $\langle p_n^{(1)}, \sigma_0 p_n^{(2)} \rangle = 2^n \langle t, \mathcal{D}^n \sigma_0 p_n^{(2)} \rangle = 0$ .

Consider the special cases  $n \pm \ell = 0 \pmod m$ . Recall

$$\overline{\mathcal{D}} z^{m-1} P_k^{(j)} = -m\kappa \sigma_0 z^{m-2} P_k^{(j)}.$$

Using the leading term of  $\sigma_0 z^{m-1} P_k^{(j)}$  we find that

$$\langle \sigma_0 z^{m-1} P_k^{(j)}, z^{m-1} P_k^{(j)} \rangle = -2m\kappa \langle z^{m-2} P_k^{(j)}, z^{m-2} P_k^{(j)} \rangle \neq 0.$$

In this case there are two different natural orthogonal bases. One is  $\{p_n^{(j)} + \sigma_0 p_n^{(j)}, p_n^{(j)} - \sigma_0 p_n^{(j)}\}$ . First suppose  $j = 1$  and  $n = m(k + 2) - \ell$  with  $k \geq 0$ , then  $p_n^{(1)} = z^{m-1} P_k^{(1)}$  and

$$\begin{aligned} \langle p_n^{(1)}, p_n^{(1)} \rangle &= \langle \sigma_0 p_n^{(1)}, \sigma_0 p_n^{(1)} \rangle = 2^{n+1} n! \frac{(\lambda_1 - \kappa)_{k+1} (\lambda_1 + \kappa)_{k+1}}{(\lambda_1)_{k+1}^2}, \\ \langle \sigma_0 p_n^{(1)}, p_n^{(1)} \rangle &= 2^n \langle \bar{t}, \overline{\mathcal{D}}^n p_n^{(1)} \rangle = -2^n m\kappa \langle \bar{t}, \overline{\mathcal{D}}^{n-1} \sigma_0 z^{m-2} P_k^{(1)} \rangle \\ &= -2^n m\kappa (n-1)! \frac{(\lambda_1 - \kappa)_{k+1} (\lambda_1 + \kappa)_{k+1}}{(\lambda_1)_{k+1}^2} \langle \bar{t}, \bar{t} \rangle. \end{aligned}$$

These imply

$$\begin{aligned} \langle p_n^{(1)} + \sigma_0 p_n^{(1)}, p_n^{(1)} - \sigma_0 p_n^{(1)} \rangle &= \langle p_n^{(1)}, p_n^{(1)} \rangle - \langle \sigma_0 p_n^{(1)}, \sigma_0 p_n^{(1)} \rangle = 0, \\ \langle p_n^{(1)} + \sigma_0 p_n^{(1)}, p_n^{(1)} + \sigma_0 p_n^{(1)} \rangle &= 2 \langle p_n^{(1)}, p_n^{(1)} \rangle + 2 \langle \sigma_0 p_n^{(1)}, \sigma_0 p_n^{(1)} \rangle \\ &= 2^{n+2} n! \frac{(\lambda_1 - \kappa)_{k+2} (\lambda_1 + \kappa)_{k+1}}{(\lambda_1)_{k+2} (\lambda_1)_{k+1}}, \\ \langle p_n^{(1)} - \sigma_0 p_n^{(1)}, p_n^{(1)} - \sigma_0 p_n^{(1)} \rangle &= 2 \langle p_n^{(1)}, p_n^{(1)} \rangle - 2 \langle \sigma_0 p_n^{(1)}, \sigma_0 p_n^{(1)} \rangle \\ &= 2^{n+2} n! \frac{(\lambda_1 - \kappa)_{k+1} (\lambda_1 + \kappa)_{k+2}}{(\lambda_1)_{k+1} (\lambda_1)_{k+2}}. \end{aligned}$$

In these calculations we used

$$n! - m\kappa(n-1)! = n! \left( \frac{n - m\kappa}{n} \right) = n! \left( \frac{m(k+1 - \kappa) + m - \ell}{m(k+1) + m - \ell} \right) = n! \frac{\lambda_1 - \kappa + k + 1}{\lambda_1 + k + 1}$$

and

$$n! + m\kappa(n-1)! = n! \frac{\lambda_1 + \kappa + k + 1}{\lambda_1 + k + 1}.$$

The result also applies when  $k = -1$ , that is,  $n = m - \ell$  and  $p_n^{(1)} = z^{m-\ell} t$ .

Now suppose  $j = 2$  and  $n = m(k + 1) + \ell$  with  $k \geq 0$ , then  $p_n^{(2)} = z^{m-1} P_k^{(2)}$  and by a similar argument

$$\begin{aligned} \langle p_n^{(2)} + \sigma_0 p_n^{(2)}, p_n^{(2)} + \sigma_0 p_n^{(2)} \rangle &= 2^{n+2} n! \frac{(\lambda_2 - \kappa)_{k+2} (\lambda_2 + \kappa)_{k+1}}{(\lambda_2)_{k+2} (\lambda_2)_{k+1}}, \\ \langle p_n^{(2)} - \sigma_0 p_n^{(2)}, p_n^{(2)} - \sigma_0 p_n^{(2)} \rangle &= 2^{n+2} n! \frac{(\lambda_2 - \kappa)_{k+1} (\lambda_2 + \kappa)_{k+2}}{(\lambda_2)_{k+1} (\lambda_2)_{k+2}}. \end{aligned}$$

Note  $n = m(k + 1 + \lambda_2)$  and  $n \pm m\kappa = m(\lambda_2 \pm \kappa + k + 1)$ . The formula also applies to  $n = \ell$  with  $k = -1$  and  $p_n^{(2)} = z^\ell \bar{t}$ .

The other natural basis is  $\{p_n^{(j)} + \frac{m\kappa}{n}\sigma_0 p_n^{(j)}, \sigma_0 p_n^{(j)}\}$  (with  $p_n^{(j)} = z^{m-1}P_k^{(j)}$ ); the idea is to form a linear combination  $f_n^{(j)} = p_n^{(j)} + c\sigma_0 p_n^{(j)}$  so that  $\overline{\mathcal{D}}f = 0$ , which implies  $\langle \sigma_0 p_n^{(j)}, f_n^{(j)} \rangle = 0$ . Indeed

$$\overline{\mathcal{D}}f_n^{(j)} = -m\kappa\sigma_0 z^{m-2}P_k^{(j)} + cn\sigma_0 z^{m-2}P_k^{(j)}.$$

Another expression for  $f_n^{(j)}$  is  $\frac{1}{z}P_{k+1}^{(j)}$ , that is,

$$\begin{aligned} f_n^{(1)} &= z^{m-\ell}Q_k^{(1)}(\kappa, \lambda_1; z^m, \bar{z}^m)t + \bar{z}^{m-\ell}Q_k^{(2)}(\kappa, \lambda_1; z^m, \bar{z}^m)\bar{t}, & n = m(k+1) - \ell, \\ f_n^{(2)} &= z^\ell Q_n^{(1)}(\kappa, \lambda_2; z^m, \bar{z}^m)\bar{t} + \bar{z}^\ell Q_n^{(2)}(\kappa, \lambda_2; z^m, \bar{z}^m)t, & n = mk + \ell. \end{aligned}$$

To compute  $\langle f_n^{(j)}, f_n^{(j)} \rangle$  (by use of  $\mathcal{D}\sigma_0 = \sigma_0\overline{\mathcal{D}}$ )

$$\begin{aligned} \mathcal{D}^{m-1}f_n^{(j)} &= \mathcal{D}^{m-2}\left(nz^{m-1}P_k^{(j)} - m\kappa\frac{m\kappa}{n}z^{m-2}P_k^{(j)}\right) \\ &= n\left(1 - \left(\frac{m\kappa}{n}\right)^2\right)\mathcal{D}^{m-2}z^{m-1}P_k^{(j)} = \frac{n!}{(n-m+1)!}\left(1 - \left(\frac{m\kappa}{n}\right)^2\right)P_k^{(j)}. \end{aligned}$$

If  $j = 1$  then  $n = m(k+2) - \ell$  and

$$1 - \left(\frac{m\kappa}{n}\right)^2 = \frac{(k+1 + \lambda_1 - \kappa)(k+1 + \lambda_1 + \kappa)}{(k+1 + \lambda_1)^2},$$

and by the previous results (also valid for  $k = -1$ )

$$\langle f_n^{(1)}, f_n^{(1)} \rangle = 2^{n+1}n! \frac{(\lambda_1 - \kappa)_{k+2}(\lambda_1 + \kappa)_{k+2}}{(\lambda_1)_{k+2}^2}.$$

Similarly if  $j = 2$  then  $n = m(k+1) + \ell$  and

$$\langle f_n^{(2)}, f_n^{(2)} \rangle = 2^{n+1}n! \frac{(\lambda_2 - \kappa)_{k+2}(\lambda_2 + \kappa)_{k+2}}{(\lambda_2)_{k+2}^2}.$$

Observe that  $-\frac{\ell}{m} < \kappa < \frac{\ell}{m} = \lambda_2$  implies all the pairings  $\langle p, p \rangle > 0$  (by definition  $\lambda_2 < \lambda_1$ ).

## 4 The Gaussian kernel

In the previous sections we showed that the forms  $\langle \cdot, \cdot \rangle$  and  $\langle \cdot, \cdot \rangle_G$  are positive-definite on the harmonic polynomials exactly when  $-\frac{\ell}{m} < \kappa < \frac{\ell}{m}$ . By use of general formulae ([2, (4), p. 4]) with  $\gamma(\kappa; \tau) = 0$  for  $\Delta_\kappa^k((z\bar{z})^n f(z, \bar{z}, t, \bar{t}))$ , where  $\Delta_\kappa f = 0$  it follows that the forms are positive-definite on  $\mathcal{P}_{m,\ell}$  for the same values of  $\kappa$ . This together with the property  $\langle pf, g \rangle_G = \langle f, p^*g \rangle_G$  for any scalar polynomial  $p(z, \bar{z})$  suggests there should be an integral formulation of  $\langle \cdot, \cdot \rangle_G$ . The construction begins with suitable generalizations of the integral for the scalar case and the group  $I_2(m)$ , namely  $|z^m - \bar{z}^m|^{2\kappa} \exp\left(-\frac{z\bar{z}}{2}\right)$ .

In [2, Section 5] we derived conditions, holding for any finite reflection group, on the matrix function  $K$  associated with the Gaussian inner product. The formula for  $W$  is stated in (4), and the general conditions specialize to:

- 1)  $K(zw) = \tau_\ell(w)^{-1}K(z)\tau_\ell(w)$ ,  $w \in W$ ;
- 2)  $K$  satisfies a boundary condition at the walls of the fundamental chamber  $\mathcal{C} := \{z = re^{i\theta} : 0 < \theta < \frac{\pi}{m}, r > 0\}$ ; see equation (9) below;

- 3)  $K = L^*ML$  where  $M$  is a constant positive-definite matrix and  $L$  satisfies a differential system.

The differential system (for a  $2 \times 2$  matrix function  $L$ ) is

$$\begin{aligned}\partial_z L(z, \bar{z}) &= \kappa L(z, \bar{z}) \sum_{j=0}^{m-1} \frac{1}{z - \bar{z}\omega^j} \tau_\ell(\sigma_j), \\ \partial_{\bar{z}} L(z, \bar{z}) &= \kappa L(z, \bar{z}) \sum_{j=0}^{m-1} \frac{-\omega^j}{z - \bar{z}\omega^j} \tau_\ell(\sigma_j).\end{aligned}$$

(As motivation for this formulation note that the analogous scalar weight function  $|z^m - \bar{z}^m|^{2\kappa} = \bar{h}h$  where  $h$  satisfies  $\partial_z h = \kappa h \sum_{j=0}^{m-1} \frac{1}{z - \bar{z}\omega^j}$  and  $\partial_{\bar{z}} h = \kappa h \sum_{j=0}^{m-1} \frac{-\omega^j}{z - \bar{z}\omega^j}$ .) It follows that

$$(z\partial_z + \bar{z}\partial_{\bar{z}})L = 0,$$

thus  $L$  is positively homogeneous of degree 0 and depends only on  $e^{i\theta}$  for  $z = re^{i\theta}$  ( $r > 0$ ,  $-\pi < \theta \leq \pi$ ). Further  $\partial_\theta = i(z\partial_z - \bar{z}\partial_{\bar{z}})$  and thus

$$\partial_\theta L = i\kappa L \sum_{j=0}^{m-1} \frac{z + \bar{z}\omega^j}{z - \bar{z}\omega^j} \tau_\ell(\sigma_j).$$

We use the following to compute the sums involving  $z - \bar{z}\omega^j$ .

**Lemma 2.** For  $n \in \mathbb{Z}$  let  $r = n - 1 \pmod{m}$  and  $0 \leq r < m$  then (indeterminate  $w$ )

$$\sum_{j=0}^{m-1} \frac{\omega^{jn}}{w - \omega^j} = \frac{mw^r}{w^m - 1}, \quad \sum_{j=0}^{m-1} \frac{\omega^{jn}}{z - \bar{z}\omega^j} = \frac{mz^r \bar{z}^{m-1-r}}{z^m - \bar{z}^m}.$$

**Proof.** Assume  $|w| < 1$  then

$$\sum_{j=0}^{m-1} \frac{\omega^{jn}}{w - \omega^j} = - \sum_{j=0}^{m-1} \frac{\omega^{j(n-1)}}{1 - w\omega^{-j}} = - \sum_{s=0}^{\infty} w^s \sum_{j=0}^{m-1} \omega^{j(n-1-s)}.$$

The inner sum equals  $m$  if  $n - 1 = s \pmod{m}$ , that is  $s = r + km$  for  $k \geq 0$ , otherwise the sum vanishes; thus

$$\sum_{j=0}^{m-1} \frac{\omega^{jn}}{w - \omega^j} = -m \sum_{k=0}^{\infty} w^{r+km} = \frac{-mw^r}{1 - w^m}.$$

The identity is valid for all  $w \notin \{\omega^j\}$ . Next

$$\sum_{j=0}^{m-1} \frac{\omega^{jn}}{z - \bar{z}\omega^j} = \frac{1}{\bar{z}} \sum_{j=0}^{m-1} \frac{\omega^{jn}}{\frac{z}{\bar{z}} - \omega^j} = \frac{m}{\bar{z}} \frac{z^r \bar{z}^{-r}}{z^m \bar{z}^{-m} - 1} = \frac{mz^r \bar{z}^{m-1-r}}{z^m - \bar{z}^m}. \quad \blacksquare$$

**Corollary 2.** For  $1 \leq \ell \leq m - 1$

$$\sum_{j=0}^{m-1} \frac{z + \bar{z}\omega^j}{z - \bar{z}\omega^j} \omega^{j\ell} = 2m \frac{z^\ell \bar{z}^{m-\ell}}{z^m - \bar{z}^m}, \quad \sum_{j=0}^{m-1} \frac{z + \bar{z}\omega^j}{z - \bar{z}\omega^j} \omega^{-j\ell} = 2m \frac{z^{m-\ell} \bar{z}^\ell}{z^m - \bar{z}^m}.$$

Write  $L = L_1 t + L_2 \bar{t}$ , then

$$\partial_\theta L_1(\theta) = \frac{m\kappa}{\sin m\theta} e^{i\theta(m-2\ell)} L_2(\theta), \quad \partial_\theta L_2(\theta) = \frac{m\kappa}{\sin m\theta} e^{-i\theta(m-2\ell)} L_1(\theta).$$

As in [1, Theorem 4.3] let  $\delta = \frac{1}{2} - \frac{\ell}{m}$ ,  $\tilde{L}_1 = e^{-im\delta\theta} L_1$ ,  $\tilde{L}_2 = e^{im\delta\theta} L_2$ , then

$$\partial_\theta \tilde{L}_1(\theta) = -im\delta \tilde{L}_1(\theta) + \frac{m\kappa}{\sin m\theta} \tilde{L}_2(\theta), \quad \partial_\theta \tilde{L}_2(\theta) = \frac{m\kappa}{\sin m\theta} \tilde{L}_1(\theta) + im\delta \tilde{L}_2(\theta).$$

Now changing  $\{t, \bar{t}\}$  to real coordinates  $t = s_1 + is_2$  we write  $\tilde{L}_1 t + \tilde{L}_2 \bar{t} = (\tilde{L}_1 + \tilde{L}_2)s_1 + i(\tilde{L}_1 - \tilde{L}_2)s_2$ . Let  $g_1 = \tilde{L}_1 + \tilde{L}_2$ ,  $g_2 = i(\tilde{L}_1 - \tilde{L}_2)$  and  $\phi = m\theta$ . The system is transformed to

$$\partial_\phi g_1 = \frac{\kappa}{\sin \phi} g_1 - \delta g_2, \quad \partial_\phi g_2 = \delta g_1 - \frac{\kappa}{\sin \phi} g_2.$$

Introduce the variable  $v = \sin^2 \frac{\phi}{2}$  and let

$$g_1 = \left( \frac{v}{1-v} \right)^{\kappa/2} h_1(v), \quad g_2 = \left( \frac{v}{1-v} \right)^{(\kappa+1)/2} h_2(v).$$

Here we restrict  $\theta$  to the fundamental chamber  $\{\theta : 0 < \theta < \frac{\pi}{m}\}$  so that  $0 < v < 1$  and  $\sin \phi = 2(v(1-v))^{1/2}$  and  $\frac{\partial}{\partial \phi} v = (v(1-v))^{1/2}$ . Then

$$\partial_v h_1 = -\frac{\delta}{1-v} h_2, \quad \partial_v h_2 = \frac{\delta}{v} h_1 - \frac{\kappa + \frac{1}{2}}{v(1-v)} h_2,$$

from which follows

$$v(1-v)\partial_v^2 h_1 + \left( \kappa + \frac{1}{2} - v \right) \partial_v h_1 + \delta^2 h_1 = 0.$$

This is the hypergeometric equation with solutions

$$h_1^{(1)} = {}_2F_1 \left( \begin{matrix} \delta, -\delta \\ \frac{1}{2} + \kappa \end{matrix}; v \right),$$

$$h_1^{(2)} = v^{\frac{1}{2}-\kappa} {}_2F_1 \left( \begin{matrix} \frac{1}{2} - \kappa - \delta, \frac{1}{2} - \kappa + \delta \\ \frac{3}{2} - \kappa \end{matrix}; v \right) = v^{\frac{1}{2}-\kappa} (1-v)^{\frac{1}{2}+\kappa} {}_2F_1 \left( \begin{matrix} 1 + \delta, 1 - \delta \\ \frac{3}{2} - \kappa \end{matrix}; v \right).$$

By use of the differentiations

$$\partial_v {}_2F_1 \left( \begin{matrix} a, b \\ c \end{matrix}; v \right) = \frac{ab}{c} {}_2F_1 \left( \begin{matrix} a+1, b+1 \\ c+1 \end{matrix}; v \right),$$

$$\partial_v v^c {}_2F_1 \left( \begin{matrix} a, b \\ c+1 \end{matrix}; v \right) = cv^{c-1} {}_2F_1 \left( \begin{matrix} a, b \\ c \end{matrix}; v \right),$$

we find

$$h_2^{(1)} = \frac{\delta}{\frac{1}{2} + \kappa} (1-v) {}_2F_1 \left( \begin{matrix} 1 + \delta, 1 - \delta \\ \frac{3}{2} + \kappa \end{matrix}; v \right),$$

$$h_2^{(2)} = -\frac{\frac{1}{2} - \kappa}{\delta} (1-v) v^{-\frac{1}{2}-\kappa} {}_2F_1 \left( \begin{matrix} \frac{1}{2} - \kappa - \delta, \frac{1}{2} - \kappa + \delta \\ \frac{1}{2} - \kappa \end{matrix}; v \right)$$

$$= -\frac{\frac{1}{2} - \kappa}{\delta} (1-v)^{\kappa+\frac{1}{2}} v^{-\frac{1}{2}-\kappa} {}_2F_1 \left( \begin{matrix} \delta, -\delta \\ \frac{1}{2} - \kappa \end{matrix}; v \right).$$

All these solutions can be expressed in terms of the following

$$\begin{aligned} f_1(\kappa, \delta; v) &:= v^{\kappa/2}(1-v)^{-\kappa/2} {}_2F_1\left(\begin{matrix} \delta, -\delta \\ \frac{1}{2} + \kappa \end{matrix}; v\right), \\ f_2(\kappa, \delta; v) &:= \frac{\delta}{\frac{1}{2} + \kappa} v^{(\kappa+1)/2}(1-v)^{(1-\kappa)/2} {}_2F_1\left(\begin{matrix} 1 + \delta, 1 - \delta \\ \frac{3}{2} + \kappa \end{matrix}; v\right). \end{aligned} \quad (7)$$

Then (by replacing  $h_j^{(2)}$  by  $\frac{-\delta}{\frac{1}{2}-\kappa}h_j^{(2)}$  for  $j = 1, 2$ )

$$\begin{aligned} g_1^{(1)} &= \left(\frac{v}{1-v}\right)^{\kappa/2} h_1^{(1)} = f_1(\kappa, \delta; v), & g_2^{(1)} &= \left(\frac{v}{1-v}\right)^{(\kappa+1)/2} h_2^{(1)} = f_2(\kappa, \delta; v), \\ g_1^{(2)} &= \left(\frac{v}{1-v}\right)^{\kappa/2} h_1^{(2)} = -f_2(-\kappa, \delta; v), & g_2^{(2)} &= \left(\frac{v}{1-v}\right)^{(\kappa+1)/2} h_2^{(2)} = f_1(-\kappa, \delta; v). \end{aligned}$$

The Wronskian of the system is  $f_1(\kappa, \delta; v)f_1(-\kappa, \delta; v) + f_2(\kappa, \delta; v)f_2(-\kappa, \delta; v) = 1$ . Returning to  $L_1, L_2$  we find (for  $j = 1, 2$ )

$$L_1^{(j)} = e^{im\delta\theta} \tilde{L}_1^{(j)} = \frac{1}{2} e^{im\delta\theta} (g_1^{(j)} - ig_2^{(j)}), \quad L_2^{(j)} = e^{-im\delta\theta} \tilde{L}_2^{(j)} = \frac{1}{2} e^{-im\delta\theta} (g_1^{(j)} + ig_2^{(j)}),$$

and in the real coordinate system  $t = s_1 + is_2$

$$\begin{aligned} L_{j1} &:= L_1^{(j)} + L_2^{(j)} = \cos m\delta\theta g_1^{(j)} + \sin m\delta\theta g_2^{(j)}, \\ L_{j2} &:= i(L_1^{(j)} - L_2^{(j)}) = -\sin m\delta\theta g_1^{(j)} + \cos m\delta\theta g_2^{(j)}. \end{aligned}$$

So a fundamental solution in the real coordinates (for  $0 < \phi = m\theta < \pi$ , recall  $v = \sin^2 \frac{\phi}{2}$ ) is

$$\begin{aligned} L(\phi) &= M_f(v)M_\delta(\phi), \\ M_f(v) &= \begin{bmatrix} f_1(\kappa, \delta; v) & f_2(\kappa, \delta; v) \\ -f_2(-\kappa, \delta; v) & f_1(-\kappa, \delta; v) \end{bmatrix}, & M_\delta(\phi) &= \begin{bmatrix} \cos \delta\phi & -\sin \delta\phi \\ \sin \delta\phi & \cos \delta\phi \end{bmatrix}. \end{aligned} \quad (8)$$

(In the trivial case  $\kappa = 0$  it follows from standard hypergeometric series formulae that  $f_1(0, \delta; v) = \cos \delta\phi$  and  $f_2(0, \delta; v) = \sin \delta\phi$ , see Lemma 3.) As described in [2] the kernel for the Gaussian inner product in the fundamental chamber  $\mathcal{C}$  is given by  $K(\phi)e^{-(x_1^2+x_2^2)/2}$  where

$$K(\phi) = L(\phi)^T M L(\phi)$$

and  $M$  is a constant positive-definite matrix determined by boundary conditions at the walls,  $\theta = 0$  and  $\theta = \frac{\pi}{m}$  in this case. Suppose  $\sigma$  corresponds to one of the walls (that is, the hyperplane fixed by  $\sigma$ ) and  $x_0 \neq 0$  is a boundary point of  $\mathcal{C}$  with  $x_0\sigma = x_0$  then the condition is: for any vectors  $\xi, \eta$  in the module for  $\tau_\ell$  (the underlying representation) if  $\xi\tau_\ell(\sigma) = \xi$  and  $\eta\tau_\ell(\sigma) = -\eta$  then

$$\lim_{x \rightarrow x_0, x \in \mathcal{C}} \xi K(x) \eta^T = 0,$$

equivalently

$$\lim_{x \rightarrow x_0, x \in \mathcal{C}} (K(x) - \tau_\ell(\sigma)K(x)\tau_\ell(\sigma)) = 0. \quad (9)$$

By the invariance property of  $K$  the condition is equivalent to

$$\lim_{x \rightarrow 0, x_0+x \in \mathcal{C}} (K(x_0+x) - K(x_0+x\sigma)) = 0,$$

a weak type of continuity. Near  $\phi = 0$  consider  $\tau_\ell(\sigma_0) = \begin{bmatrix} 1 & 0 \\ 0 & -1 \end{bmatrix}$  and the boundary condition becomes

$$\lim_{\phi \rightarrow 0^+} K(\phi)_{12} = 0.$$

Let  $M_0 = \begin{bmatrix} a_1 & a_2 \\ a_2 & a_3 \end{bmatrix}$  and replace  $M_f(v)$  by (with nonzero constants  $c_1, c_2$  depending on  $\delta$  and  $\kappa$ , see (7))

$$L'(\phi) := \begin{bmatrix} 2^{-\kappa} \phi^\kappa & c_1 \phi^{\kappa+1} \\ c_2 \phi^{1-\kappa} & 2^\kappa \phi^{-\kappa} \end{bmatrix},$$

then  $\lim_{\phi \rightarrow 0} M_\delta(\phi) = I$  and

$$(L'(\phi)^T M_0 L'(\phi))_{12} = 2^{-\kappa} c_2 a_1 \phi^{1+2\kappa} - 2^\kappa c_1 a_3 \phi^{1-2\kappa} + a_2 (1 - c_1 c_2 \phi^2).$$

The boundary condition immediately implies  $a_2 = 0$ , then the positive-definite condition implies  $a_1 a_3 \neq 0$  and thus  $1 \pm 2\kappa > 0$ . This bound ( $-\frac{1}{2} < \kappa < \frac{1}{2}$ ) also implies the integrability of  $K$  on the circle (and with respect to  $e^{-|x|^2/2} dm_2(x)$ ).

Next we consider the behavior of  $L(\phi)$  near  $\phi = \pi$ , that is,  $v$  near 1. We use (see [5, (15.8.4)])

$$\begin{aligned} {}_2F_1 \left( \begin{matrix} a, b \\ c \end{matrix}; v \right) &= \frac{\Gamma(c)\Gamma(c-a-b)}{\Gamma(c-a)\Gamma(c-b)} {}_2F_1 \left( \begin{matrix} a, b \\ 1+a+b-c \end{matrix}; 1-v \right) \\ &\quad + (1-v)^{c-a-b} \frac{\Gamma(c)\Gamma(a+b-c)}{\Gamma(a)\Gamma(b)} {}_2F_1 \left( \begin{matrix} c-a, c-b \\ 1-a-b+c \end{matrix}; 1-v \right). \end{aligned}$$

Define

$$H(\kappa, \delta) := \frac{\Gamma(\frac{1}{2} + \kappa)^2}{\Gamma(\frac{1}{2} + \kappa + \delta) \Gamma(\frac{1}{2} + \kappa - \delta)}.$$

The formula  $\Gamma(u)\Gamma(1-u) = \frac{\pi}{\sin \pi u}$  implies

$$\frac{\Gamma(\frac{1}{2} + \kappa) \Gamma(-\frac{1}{2} - \kappa)}{\Gamma(\delta)\Gamma(-\delta)} = \left( \frac{\delta}{\frac{1}{2} + \kappa} \right) \frac{\sin \pi \delta}{\cos \pi \kappa}.$$

Then

$$\begin{aligned} f_1(\kappa, \delta; v) &= H(\kappa, \delta) f_1(-\kappa, \delta; 1-v) + \frac{\sin \pi \delta}{\cos \pi \kappa} f_2(\kappa, \delta; 1-v), \\ f_2(\kappa, \delta; v) &= \frac{\sin \pi \delta}{\cos \pi \kappa} f_1(\kappa, \delta; 1-v) - H(\kappa, \delta) f_2(-\kappa, \delta; 1-v). \end{aligned} \tag{10}$$

Note  $H(\kappa, \delta)H(-\kappa, \delta) + \left(\frac{\sin \pi \delta}{\cos \pi \kappa}\right)^2 = 1$ . Summarize the transformation rules as

$$\begin{bmatrix} f_1(\kappa, \delta; v) & f_2(\kappa, \delta; v) \\ -f_2(-\kappa, \delta; v) & f_1(-\kappa, \delta; v) \end{bmatrix} = \begin{bmatrix} H(\kappa, \delta) & \frac{\sin \pi \delta}{\cos \pi \kappa} \\ -\frac{\sin \pi \delta}{\cos \pi \kappa} & H(-\kappa, \delta) \end{bmatrix} \begin{bmatrix} f_1(-\kappa, \delta; 1-v) & -f_2(-\kappa, \delta; 1-v) \\ f_2(\kappa, \delta; 1-v) & f_1(\kappa, \delta; 1-v) \end{bmatrix},$$

or set

$$M_H = \begin{bmatrix} H(\kappa, \delta) & \frac{\sin \pi \delta}{\cos \pi \kappa} \\ -\frac{\sin \pi \delta}{\cos \pi \kappa} & H(-\kappa, \delta) \end{bmatrix}, \quad M_\sigma = \begin{bmatrix} 0 & 1 \\ 1 & 0 \end{bmatrix},$$



then

$$M_f(v) = M_H M_\sigma M_f(1-v) M_\sigma,$$

the same relation holds with  $v$  and  $1-v$  interchanged (indeed  $(M_H M_\sigma)^2 = I$ ). The reflection corresponding to the wall  $\theta = \frac{\pi}{m}$  is  $\sigma_1$  ( $z\sigma_1 = \bar{z}\omega$  so  $e^{i\pi/m}\sigma_1 = e^{i\pi/m}$ ). Thus the boundary condition is

$$\lim_{\phi \rightarrow \pi_-} (K(\phi) - \tau_\ell(\sigma_1)K(\phi)\tau_\ell(\sigma_1)) = 0,$$

and (in the real coordinates)

$$\tau_\ell(\sigma_1) = \begin{bmatrix} \cos \frac{2\pi\ell}{m} & \sin \frac{2\pi\ell}{m} \\ \sin \frac{2\pi\ell}{m} & -\cos \frac{2\pi\ell}{m} \end{bmatrix}.$$

Then

$$K(\phi) - \tau_\ell(\sigma_1)K(\phi)\tau_\ell(\sigma_1) = q(\phi) \begin{bmatrix} \sin \frac{2\pi\ell}{m} & -\cos \frac{2\pi\ell}{m} \\ -\cos \frac{2\pi\ell}{m} & -\sin \frac{2\pi\ell}{m} \end{bmatrix},$$

$$q(\phi) = \{K(\phi)_{11} - K(\phi)_{22}\} \sin \frac{2\pi\ell}{m} - 2K(\phi)_{12} \cos \frac{2\pi\ell}{m}.$$

We want to determine  $M_0$  so that  $\lim_{\phi \rightarrow \pi_-} q(\phi) = 0$ . We have

$$K(\phi) = M_\delta(\phi)^T M_f(v)^T M_0 M_f(v) M_\delta(\phi).$$

Let  $\psi = \pi - \phi$  then the first-order approximations (as  $\psi \rightarrow 0_+$ ) are

$$1-v \sim \frac{1}{4}\psi^2,$$

$$f_1(\kappa, \delta; 1-v) \sim \left(\frac{\psi}{2}\right)^{-\kappa}, \quad f_2(\kappa, \delta; 1-v) \sim \frac{\delta}{\frac{1}{2} + \kappa} \left(\frac{\psi}{2}\right)^{1-\kappa},$$

$$f_1(-\kappa, \delta; 1-v) \sim \left(\frac{\psi}{2}\right)^\kappa, \quad f_2(-\kappa, \delta; 1-v) \sim \frac{\delta}{\frac{1}{2} - \kappa} \left(\frac{\psi}{2}\right)^{1+\kappa},$$

and

$$M_f(v) \sim M_H \begin{bmatrix} \left(\frac{\psi}{2}\right)^\kappa & -\frac{\delta}{\frac{1}{2} - \kappa} \left(\frac{\psi}{2}\right)^{1+\kappa} \\ \frac{\delta}{\frac{1}{2} + \kappa} \left(\frac{\psi}{2}\right)^{1-\kappa} & \left(\frac{\psi}{2}\right)^{-\kappa} \end{bmatrix}.$$

We also find

$$M_\delta(\pi - \psi) \sim M_1 + \psi\delta M_2,$$

$$M_1 = \begin{bmatrix} \sin \frac{\pi\ell}{m} & -\cos \frac{\pi\ell}{m} \\ \cos \frac{\pi\ell}{m} & \sin \frac{\pi\ell}{m} \end{bmatrix}, \quad M_2 = \begin{bmatrix} \cos \frac{\pi\ell}{m} & \sin \frac{\pi\ell}{m} \\ -\sin \frac{\pi\ell}{m} & \cos \frac{\pi\ell}{m} \end{bmatrix}.$$

There is one more simplification: for an arbitrary  $M_0 = \begin{bmatrix} a_1 & a_2 \\ a_2 & a_3 \end{bmatrix}$  if  $J = M_1^T M_0 M_1$  then

$(J_{11} - J_{22}) \sin \frac{2\pi\ell}{m} - 2J_{12} \cos \frac{2\pi\ell}{m} = 2a_2$ . So

$$M_f(v) M_\delta(\pi - \psi) \sim M_H \begin{bmatrix} \left(\frac{\psi}{2}\right)^\kappa & -\frac{\delta}{\frac{1}{2} - \kappa} \left(\frac{\psi}{2}\right)^{1+\kappa} \\ \frac{\delta}{\frac{1}{2} + \kappa} \left(\frac{\psi}{2}\right)^{1-\kappa} & \left(\frac{\psi}{2}\right)^{-\kappa} \end{bmatrix} (M_1 + \psi\delta M_2);$$

and discarding quantities tending to zero (as  $\psi \rightarrow 0_+$ ) we need to consider the (1, 2)-entry of

$$\begin{bmatrix} 2^{-\kappa}\psi^\kappa & 0 \\ 0 & 2^\kappa\psi^{-\kappa} \end{bmatrix} M_H^T \begin{bmatrix} a_1 & 0 \\ 0 & a_3 \end{bmatrix} M_H \begin{bmatrix} 2^{-\kappa}\psi^\kappa & 0 \\ 0 & 2^\kappa\psi^{-\kappa} \end{bmatrix},$$

which equals  $(a_1 H(\kappa, \delta) - a_3 H(-\kappa, \delta)) \frac{\sin \pi \delta}{\cos \pi \kappa}$ . Thus with the normalization constant  $c(\kappa, \delta)$

$$K(\phi) = c(\kappa, \delta) L(\phi)^T \begin{bmatrix} H(-\kappa, \delta) & 0 \\ 0 & H(\kappa, \delta) \end{bmatrix} L(\phi), \quad (11)$$

for  $0 < \phi = m\theta < \pi$ . The condition that the kernel be positive definite is  $H(\kappa, \delta)H(-\kappa, \delta) > 0$ , and

$$H(\kappa, \delta)H(-\kappa, \delta) = \frac{\cos \pi(\kappa + \delta) \cos \pi(\kappa - \delta)}{\cos^2 \pi \kappa} = \frac{\sin \pi \left(\frac{\ell}{m} + \kappa\right) \sin \pi \left(\frac{\ell}{m} - \kappa\right)}{\cos^2 \pi \kappa},$$

thus  $-\frac{\ell}{m} < \kappa < \frac{\ell}{m}$ . In Section 6 we show that

$$c(\kappa, \delta) = \frac{\cos \pi \kappa}{2\pi \cos \pi \delta}.$$

## 5 Integrals of harmonic polynomials

As in [2] define the circle-type pairing by

$$\langle f, g \rangle_S = \frac{1}{2^n n!} \langle f, g \rangle_G = \frac{1}{2^n n!} \langle e^{\Delta \kappa/2} f, e^{\Delta \kappa/2} g \rangle$$

when  $\deg f + \deg g = 2n$  ( $n = 0, 1, \dots$ ); the term ‘‘circle’’ refers to the polar coordinate system. If  $f, g$  are harmonic then  $\langle f, g \rangle_G = \langle f, g \rangle$ . In the coordinate system  $\{t, \bar{t}\}$  the matrix function (denoted by  $K^{\mathbb{C}}$  for this basis) satisfies  $K^{\mathbb{C}}(z)^* = K^{\mathbb{C}}(z)$  and  $K^{\mathbb{C}}(zw) = \tau_\ell(w)^* K^{\mathbb{C}}(z) \tau_\ell(w)$  for  $w \in W$  (recall  $\tau_\ell$  is unitary), and  $K^{\mathbb{C}}$  is positively homogeneous of degree 0. The Gaussian pairing is

$$\langle f, g \rangle_G = \int_{\mathbb{C}} g(z) K^{\mathbb{C}}(z) f(z)^* e^{-|z|^2/2} dm_2(z),$$

where  $dm_2(z) = dx_1 dx_2$  (for  $z = x_1 + ix_2$ ) and  $g(z)$  denotes  $(g_1(z), g_2(z))$  with  $g = g_1 t + g_2 \bar{t}$ , similarly for  $f$ . In polar coordinates  $z = re^{i\theta}$  the fundamental chamber is  $\{(r, \theta) : r > 0, 0 < \theta < \frac{\pi}{m}\}$ . Then

$$\begin{aligned} \langle f, g \rangle_G &= \sum_{w \in W} \int_0^\infty e^{-r^2/2} r dr \int_0^{\frac{\pi}{m}} g(re^{i\theta} w) K^{\mathbb{C}}(e^{i\theta} w) f(re^{i\theta} w)^* d\theta \\ &= \sum_{w \in W} \int_0^\infty e^{-r^2/2} r dr \int_0^{\frac{\pi}{m}} g(re^{i\theta} w) \tau_\ell(w)^* K^{\mathbb{C}}(e^{i\theta}) \tau_\ell(w) f(re^{i\theta} w)^* d\theta. \end{aligned}$$

In particular, if  $f, g$  are homogeneous with  $\deg f + \deg g = 2n$  then

$$\langle f, g \rangle_S = \frac{1}{2^n n!} \langle f, g \rangle_G = \sum_{w \in W} \int_0^{\frac{\pi}{m}} g(e^{i\theta} w) \tau_\ell(w)^* K^{\mathbb{C}}(e^{i\theta}) \tau_\ell(w) f(e^{i\theta} w)^* d\theta. \quad (12)$$

Now suppose  $f, g$  have  $m$ -parities  $r_1, r_2$ . That is,  $0 \leq r_1, r_2 < m$ ,  $f$  is a sum of monomials  $\{z^a \bar{z}^b t : a - b + \ell = r_1 \pmod{m}\}$  and  $\{z^a \bar{z}^b \bar{t} : a - b - \ell = r_1 \pmod{m}\}$  and  $g$  has the same property with  $r_1$  replaced by  $r_2$ . The generic rotation in  $W$  is

$$\varrho_j : f(z, \bar{z}, t, \bar{t}) \mapsto f(z\omega^j, \bar{z}\omega^{-j}, t\omega^{\ell j}, \bar{t}\omega^{-\ell j});$$

this maps the monomial  $z^a \bar{z}^b t$  to  $\omega^{j(a-b+\ell)} z^a \bar{z}^b t$  and  $z^a \bar{z}^b \bar{t}$  to  $\omega^{j(a-b-\ell)} z^a \bar{z}^b \bar{t}$ . By hypothesis  $f(e^{i\theta} \rho_j) \tau_\ell(\rho_j)^* = \omega^{r_1 j} f(e^{i\theta})$ . The reflection

$$\sigma_j : f(z, \bar{z}, t, \bar{t}) \mapsto f(\bar{z}\omega^j, z\omega^{-j}, \bar{t}\omega^{\ell j}, t\omega^{-\ell j})$$

maps the monomial  $z^a \bar{z}^b t$  to  $\omega^{j(a-b+\ell)} z^b \bar{z}^a \bar{t}$  and  $z^a \bar{z}^b \bar{t}$  to  $\omega^{j(a-b-\ell)} z^b \bar{z}^a t$ . For a polynomial  $p(z, \bar{z})$  let  $p^\vee = p(\bar{z}, z)$ . So if  $f = f_1 t + f_2 \bar{t}$  has  $m$ -parity  $r_1$  then  $\sigma_j f = \omega^{r_1 j} (f_1^\vee \bar{t} + f_2^\vee t)$ . Break up the sum in formula (12) into two parts, one for rotations (including the identity  $\rho_0$ ) and one for the reflections we obtain

$$\begin{aligned} \langle f, g \rangle_S &= \sum_{j=0}^{m-1} \omega^{r_2 j} \omega^{-r_1 j} \int_0^{\frac{\pi}{m}} g(e^{i\theta}) K^{\mathbb{C}}(e^{i\theta}) f(e^{i\theta})^* d\theta \\ &\quad + \sum_{j=0}^{m-1} \omega^{r_2 j} \omega^{-r_1 j} \int_0^{\frac{\pi}{m}} g^\wedge(e^{i\theta}) K^{\mathbb{C}}(e^{i\theta}) f^\wedge(e^{i\theta})^* d\theta, \end{aligned}$$

where  $g^\wedge = (g_2^\vee, g_1^\vee)$  and  $f^\wedge = (f_2^\vee, f_1^\vee)$ . The sums vanish unless  $r_1 = r_2$  in which case both equal  $m$ .

Next we convert the matrix in (11) to the complex coordinate system. Recall

$$K(\phi) = M_\delta(\phi)^T M_f(v)^T M_0 M_f(v) M_\delta(\phi),$$

in the real coordinates, where

$$M_f(v) = \begin{bmatrix} f_1(\kappa, \delta; v) & f_2(\kappa, \delta; v) \\ -f_2(-\kappa, \delta; v) & f_1(-\kappa, \delta; v) \end{bmatrix}, \quad M_\delta(\phi) = \begin{bmatrix} \cos \delta\phi & -\sin \delta\phi \\ \sin \delta\phi & \cos \delta\phi \end{bmatrix}.$$

To find the change-of-basis matrix observe  $g_1 t + g_2 \bar{t} \mapsto g_1(s_1 + is_2) + g_2(s_1 - is_2) = (g_1 + g_2)s_1 + i(g_1 - g_2)s_2$ . Let

$$B = \begin{bmatrix} 1 & i \\ 1 & -i \end{bmatrix},$$

then in the complex coordinates

$$K^{\mathbb{C}} = B M_\delta(\phi)^T M_f(v)^T M_0 M_f(v) M_\delta(\phi) B^*.$$

We find

$$B M_\delta(\phi)^T = \begin{bmatrix} e^{-i\delta\phi} & 0 \\ 0 & e^{i\delta\phi} \end{bmatrix} B,$$

and  $\delta\phi = (\frac{1}{2} - \frac{\ell}{m}) m\theta$ . So

$$K^{\mathbb{C}} = \begin{bmatrix} e^{-i\delta\phi} & 0 \\ 0 & e^{i\delta\phi} \end{bmatrix} B M_f(v)^T M_0 M_f(v) B^* \begin{bmatrix} e^{i\delta\phi} & 0 \\ 0 & e^{-i\delta\phi} \end{bmatrix}.$$

Then using (8)

$$\begin{aligned} K_{11}^{\mathbb{C}} &= K_{22}^{\mathbb{C}} = c(\kappa, \delta) G_1(\kappa, \delta, v), \\ G_1(\kappa, \delta, v) &:= (f_1(\kappa, \delta; v)^2 + f_2(\kappa, \delta; v)^2) H(-\kappa, \delta) + (f_1(-\kappa, \delta; v)^2 + f_2(-\kappa, \delta; v)^2) H(\kappa, \delta), \\ K_{12}^{\mathbb{C}} &= \overline{K_{21}^{\mathbb{C}}} = e^{-2i\delta m\theta} c(\kappa, \delta) G_2(\kappa, \delta; v), \\ G_2(\kappa, \delta; v) &:= (f_1(\kappa, \delta; v) + i f_2(\kappa, \delta; v))^2 H(-\kappa, \delta) - (f_1(-\kappa, \delta; v) + i f_2(-\kappa, \delta; v))^2 H(\kappa, \delta). \end{aligned} \tag{13}$$

Recall  $v = \sin^2 \frac{\phi}{2} = \frac{1}{2}(1 - \cos m\theta)$  and  $e^{-2i\delta\phi} = e^{-i\theta(m-2\ell)}$  ( $= \bar{z}^m z^{2\ell}$  on the circle).

In the special case  $f = g = t$  we obtain

$$2 = \langle t, t \rangle_S = m \int_0^{\frac{\pi}{m}} (K_{11}^{\mathbb{C}} + K_{22}^{\mathbb{C}}) d\theta = 2m \int_0^{\frac{\pi}{m}} K_{11}^{\mathbb{C}} d\theta. \quad (14)$$

In the “trivial” case  $\kappa = 0$  the term  $f_1(0, \delta; v)^2 + f_2(0, \delta; v)^2 = 1$  (see Lemma 3) and  $H(0, \delta) = \cos \pi \delta$  thus  $c(0, \delta) = \frac{1}{2\pi \cos \pi \delta}$ . Consider the evaluation of  $\langle f, f \rangle_S$  where  $f = p_n^{(1)}$  and  $n = m(k+1) - \ell + r$  with  $k \geq 0$  and  $1 \leq r \leq m$ ; thus

$$f = z^{m-\ell+r} Q_k^{(1)} \left( \kappa, \frac{m-\ell}{m}; z^m, \bar{z}^m \right) t + z^r \bar{z}^{m-\ell} Q_k^{(2)} \left( \kappa, \frac{m-\ell}{m}; z^m, \bar{z}^m \right) \bar{t}.$$

Because  $Q_k^{(1)}$  and  $Q_k^{(2)}$  have real coefficients we find  $f_1^\vee = \bar{f}_1$  and  $f_2^\vee = \bar{f}_2$ . The integrand is (suppressing the arguments  $\kappa, \frac{m-\ell}{m}$  in  $Q_k^{(j)}$  and omitting the factor  $c(\kappa, \delta)$ )

$$\begin{aligned} & 2(f_1 \bar{f}_1 + f_2 \bar{f}_2) G_1 + 2e^{-2i\delta m \theta} f_1 \bar{f}_2 G_2 + 2e^{2i\delta m \theta} f_2 \bar{f}_1 G_2, \\ & f_1 \bar{f}_1 + f_2 \bar{f}_2 = Q_k^{(1)}(z^m, \bar{z}^m) Q_k^{(1)}(\bar{z}^m, z^m) + Q_k^{(2)}(z^m, \bar{z}^m) Q_k^{(2)}(\bar{z}^m, z^m), \\ & e^{-2i\delta m \theta} f_1 \bar{f}_2 = \bar{z}^m z^{2\ell} z^{m-\ell+r} \bar{z}^r z^{m-\ell} Q_k^{(1)}(z^m, \bar{z}^m) Q_k^{(2)}(\bar{z}^m, z^m) \\ & \quad = z^m Q_k^{(1)}(z^m, \bar{z}^m) Q_k^{(2)}(\bar{z}^m, z^m), \\ & e^{2i\delta m \theta} \bar{f}_1 f_2 = \bar{z}^m Q_k^{(1)}(\bar{z}^m, z^m) Q_k^{(2)}(z^m, \bar{z}^m). \end{aligned}$$

(Note  $z\bar{z} = 1$  on the circle.) The integrand is now expressed as a function of  $z^m$ , that is,  $e^{i\phi}$ . Similarly suppose  $f = p_n^{(2)}$  with  $n = mk + \ell + r$  so that

$$\begin{aligned} p_n^{(2)} &= z^r \bar{z}^\ell Q_k^{(2)} \left( \kappa, \frac{\ell}{m}; z^m, \bar{z}^m \right) t + z^{\ell+r} Q_k^{(1)} \left( \kappa, \frac{\ell}{m}; z^m, \bar{z}^m \right) \bar{t}, \\ e^{-2i\delta m \theta} f_1 \bar{f}_2 &= \bar{z}^m z^{2\ell} z^r \bar{z}^\ell \bar{z}^{\ell+r} Q_k^{(2)}(z^m, \bar{z}^m) Q_k^{(1)}(\bar{z}^m, z^m) = \bar{z}^m Q_k^{(2)}(z^m, \bar{z}^m) Q_k^{(1)}(\bar{z}^m, z^m), \\ e^{2i\delta m \theta} \bar{f}_1 f_2 &= z^m Q_k^{(2)}(\bar{z}^m, z^m) Q_k^{(1)}(z^m, \bar{z}^m). \end{aligned}$$

## 6 The normalizing constant

In this section we find the normalizing constant for  $K$  by computing the integral in (14) and using a method that separates the parameters  $\delta$  and  $\kappa$ . To start we examine the special cases  $f_1(0, \delta; v)$  and  $f_2(0, \delta; v)$ .

**Lemma 3.** For  $-\pi < \phi < \pi$  and any  $\delta$

$$f_1 \left( 0, \delta; \sin^2 \frac{\phi}{2} \right) = \cos \delta \phi, \quad f_2 \left( 0, \delta; \sin^2 \frac{\phi}{2} \right) = \sin \delta \phi.$$

**Proof.** The first part is a standard formula (see [5, (15.4.12)]). Briefly, consider  $g(v) = {}_2F_1 \left( \begin{smallmatrix} \delta, -\delta \\ 1/2 \end{smallmatrix}; v \right)$ ; it can be shown directly that  $\partial_\phi^2 g(v) = -\delta^2 g(v)$ ,  $g(0) = 1$  and  $g(1) = \cos \pi \delta$ ; note  $\partial_\phi = \sqrt{v(1-v)} \partial_v$ . Apply  $\partial_\phi$  to both sides of the first formula to obtain

$$\frac{\delta(-\delta)}{1/2} \sqrt{v(1-v)} {}_2F_1 \left( \begin{smallmatrix} 1+\delta, 1-\delta \\ 3/2 \end{smallmatrix}; v \right) = -\delta \sin \delta \phi;$$

the left hand side equals  $-\delta f_2(0, \delta; v)$ . ■

Next we derive another expression for  $K_{11}^{\mathbb{C}} + K_{22}^{\mathbb{C}}$ . Recall  $G_1(\kappa, \delta; v)$  from (13).

**Lemma 4.** For  $-\frac{1}{2} < \kappa < \frac{1}{2}$  and  $\delta > 0$

$$G_1(\kappa, \delta; v) = f_1(\kappa, \delta; v)f_1(-\kappa, \delta; 1-v) + f_1(-\kappa, \delta; v)f_1(\kappa, \delta; 1-v) \\ - f_2(\kappa, \delta; v)f_2(-\kappa, \delta; 1-v) - f_2(-\kappa, \delta; v)f_2(\kappa, \delta; 1-v).$$

**Proof.** From equation (10) we have (replacing  $\kappa$  by  $-\kappa$  and  $v$  by  $1-v$ )

$$H(-\kappa, \delta)f_1(\kappa, \delta; v) = f_1(-\kappa, \delta; 1-v) - \frac{\sin \pi \delta}{\cos \pi \kappa} f_2(-\kappa, \delta; v), \\ H(-\kappa, \delta)f_1(\kappa, \delta; v)^2 = f_1(\kappa, \delta; v)f_1(-\kappa, \delta; 1-v) - \frac{\sin \pi \delta}{\cos \pi \kappa} f_1(\kappa, \delta; v)f_2(-\kappa, \delta; v), \\ H(\kappa, \delta)f_1(-\kappa, \delta; v)^2 = f_1(-\kappa, \delta; v)f_1(\kappa, \delta; 1-v) - \frac{\sin \pi \delta}{\cos \pi \kappa} f_1(-\kappa, \delta; v)f_2(\kappa, \delta; v),$$

and

$$H(-\kappa, \delta)f_2(\kappa, \delta; v) = \frac{\sin \pi \delta}{\cos \pi \kappa} f_1(-\kappa, \delta; v) - f_2(-\kappa, \delta; 1-v), \\ H(-\kappa, \delta)f_2(\kappa, \delta; v)^2 = \frac{\sin \pi \delta}{\cos \pi \kappa} f_1(-\kappa, \delta; v)f_2(\kappa, \delta; v) - f_2(\kappa, \delta; v)f_2(-\kappa, \delta; 1-v), \\ H(\kappa, \delta)f_2(-\kappa, \delta; v)^2 = \frac{\sin \pi \delta}{\cos \pi \kappa} f_1(\kappa, \delta; v)f_2(-\kappa, \delta; v) - f_2(-\kappa, \delta; v)f_2(\kappa, \delta; 1-v).$$

Adding up the appropriate equations (the second two in each group) we get the desired result. Note the cancellations of the terms  $f_1(\kappa, \delta; v)f_2(-\kappa, \delta; v)$  and  $f_1(-\kappa, \delta; v)f_2(\kappa, \delta; v)$ .  $\blacksquare$

**Proposition 9.** Suppose  $-\frac{1}{2} < \kappa < \frac{1}{2}$  and  $0 \leq \delta < \frac{1}{2}$  then

$$\int_0^1 G_1(\kappa, \delta; v)(v(1-v))^{-1/2} dv = \frac{1}{\cos \pi \kappa} \int_0^1 G_1(0, \delta; v)(v(1-v))^{-1/2} dv.$$

**Proof.** By the symmetry  $v \rightarrow 1-v$  it suffices to integrate  $f_1(\kappa, \delta; v)f_1(-\kappa, \delta; 1-v)$  and  $f_2(\kappa, \delta; v)f_2(-\kappa, \delta; 1-v)$ . By definition

$$f_1(\kappa, \delta; v)f_1(-\kappa, \delta; 1-v) = v^\kappa(1-v)^{-\kappa} \sum_{i,j=0}^{\infty} \frac{(\delta)_i(-\delta)_i(\delta)_j(-\delta)_j}{i!j! \left(\frac{1}{2} + \kappa\right)_i \left(\frac{1}{2} - \kappa\right)_j} v^i(1-v)^j.$$

Multiply by  $(v(1-v))^{-1/2}$  and integrate over  $0 < v < 1$  to obtain

$$\sum_{i,j=0}^{\infty} \frac{(\delta)_i(-\delta)_i(\delta)_j(-\delta)_j}{i!j! \left(\frac{1}{2} + \kappa\right)_i \left(\frac{1}{2} - \kappa\right)_j} B\left(i + \frac{1}{2} + \kappa, j + \frac{1}{2} - \kappa\right) \\ = \Gamma\left(\frac{1}{2} + \kappa\right) \Gamma\left(\frac{1}{2} - \kappa\right) \sum_{i,j=0}^{\infty} \frac{(\delta)_i(-\delta)_i(\delta)_j(-\delta)_j}{i!j!(i+j)!},$$

because

$$B\left(i + \frac{1}{2} + \kappa, j + \frac{1}{2} - \kappa\right) = \frac{1}{\Gamma(i+j+1)} \Gamma\left(\frac{1}{2} + \kappa\right) \Gamma\left(\frac{1}{2} - \kappa\right) \left(\frac{1}{2} + \kappa\right)_i \left(\frac{1}{2} - \kappa\right)_j.$$

The ratio to the same integral with  $\kappa$  replaced by 0 is

$$\frac{\Gamma\left(\frac{1}{2} + \kappa\right) \Gamma\left(\frac{1}{2} - \kappa\right)}{\Gamma\left(\frac{1}{2}\right)^2} = \frac{1}{\cos \pi \kappa}.$$

Similarly

$$f_2(\kappa, \delta; v) f_2(-\kappa, \delta; 1-v) = \frac{\delta^2}{\left(\frac{1}{2} + \kappa\right) \left(\frac{1}{2} - \kappa\right)} v^{1+\kappa} (1-v)^{1-\kappa} \\ \times \sum_{i,j=0}^{\infty} \frac{(1+\delta)_i (1-\delta)_i (1+\delta)_j (1-\delta)_j}{i! j! \left(\frac{3}{2} + \kappa\right)_i \left(\frac{3}{2} - \kappa\right)_j} v^i (1-v)^j.$$

Multiply by  $(v(1-v))^{-1/2}$  and integrate over  $0 < v < 1$  to obtain

$$\frac{\delta^2}{\left(\frac{1}{2} + \kappa\right) \left(\frac{1}{2} - \kappa\right)} \sum_{i,j=0}^{\infty} \frac{(1+\delta)_i (1-\delta)_i (1+\delta)_j (1-\delta)_j}{i! j! \left(\frac{3}{2} + \kappa\right)_i \left(\frac{3}{2} - \kappa\right)_j} B\left(i + \frac{3}{2} + \kappa, j + \frac{3}{2} - \kappa\right) \\ = \Gamma\left(\frac{1}{2} + \kappa\right) \Gamma\left(\frac{1}{2} - \kappa\right) \delta^2 \sum_{i,j=0}^{\infty} \frac{(1+\delta)_i (1-\delta)_i (1+\delta)_j (1-\delta)_j}{i! j! (i+j+2)!},$$

because

$$\frac{B\left(i + \frac{3}{2} + \kappa, j + \frac{3}{2} - \kappa\right)}{\left(\frac{1}{2} + \kappa\right) \left(\frac{1}{2} - \kappa\right)} = \frac{\Gamma\left(\frac{3}{2} + \kappa\right) \Gamma\left(\frac{3}{2} - \kappa\right) \left(\frac{3}{2} + \kappa\right)_i \left(\frac{3}{2} - \kappa\right)_j}{\left(\frac{1}{2} + \kappa\right) \left(\frac{1}{2} - \kappa\right) \Gamma(i+j+3)} \\ = \Gamma\left(\frac{1}{2} + \kappa\right) \Gamma\left(\frac{1}{2} - \kappa\right) \frac{\left(\frac{3}{2} + \kappa\right)_i \left(\frac{3}{2} - \kappa\right)_j}{(i+j+2)!}.$$

The double series converges by Stirling's formula and the comparison test. By the same argument as for the first integral the proof is finished.  $\blacksquare$

**Lemma 5.** Suppose  $0 < \delta < \frac{1}{2}$  then

$$\int_0^1 f_1(0, \delta; v) f_1(0, \delta; 1-v) \frac{dv}{\sqrt{v(1-v)}} = \frac{\pi}{2} \cos \delta\pi + \frac{1}{2\delta} \sin \pi\delta, \\ \int_0^1 f_2(0, \delta; v) f_2(0, \delta; 1-v) \frac{dv}{\sqrt{v(1-v)}} = -\frac{\pi}{2} \cos \delta\pi + \frac{1}{2\delta} \sin \pi\delta.$$

**Proof.** For  $v = \sin^2 \frac{\phi}{2}$  one has  $dv = \sqrt{v(1-v)} d\phi$ . Also  $1-v = \cos^2 \frac{\phi}{2} = \sin^2 \frac{\pi-\phi}{2}$ , thus by Lemma 3 the two integrals equal

$$\int_0^\pi \cos \delta\phi \cos \delta(\pi - \phi) d\phi = \frac{\pi}{2} \cos \delta\pi + \frac{1}{2\delta} \sin \delta\pi, \\ \int_0^\pi \sin \delta\phi \sin \delta(\pi - \phi) d\phi = -\frac{\pi}{2} \cos \delta\pi + \frac{1}{2\delta} \sin \delta\pi,$$

respectively.  $\blacksquare$

Combining the lemma and the proposition we prove:

**Proposition 10.** Suppose  $-\frac{1}{2} < \kappa < \frac{1}{2}$  and  $0 \leq \delta < \frac{1}{2}$  then

$$\int_0^1 G_1(\kappa, \delta; v) (v(1-v))^{-1/2} dv = 2\pi \frac{\cos \delta\pi}{\cos \kappa\pi}.$$

To determine the normalizing constant: recall the requirement from (14)

$$\begin{aligned} 2 &= \langle t, t \rangle_S = 2m \int_0^{\frac{\pi}{m}} K_{11}^{\mathbb{C}} d\theta = 2 \int_0^{\pi} K_{11}^{\mathbb{C}} d\phi \\ &= 2c(\kappa, \delta) \int_0^1 G_1(\kappa, \delta; v)(v(1-v))^{-1/2} dv = 4\pi c(\kappa, \delta) \frac{\cos \delta\pi}{\cos \kappa\pi}, \\ c(\kappa, \delta) &= \frac{1}{2\pi} \frac{\cos \kappa\pi}{\cos \delta\pi}. \end{aligned}$$

This implies

$$\det K = \frac{\sin \pi \left(\frac{\ell}{m} + \kappa\right) \sin \pi \left(\frac{\ell}{m} - \kappa\right)}{4\pi^2 \sin^2 \frac{\pi\ell}{m}} = \frac{1}{4\pi^2} \left( 1 - \left( \frac{\sin \pi\kappa}{\sin \frac{\pi\ell}{m}} \right)^2 \right)$$

(and  $\det K^{\mathbb{C}} = |\det B|^2 \det K = 4 \det K$ ). The weight function  $K$  is actually integrable for  $-\frac{1}{2} < \kappa < \frac{1}{2}$  but does not give a positive form when  $\frac{\ell}{m} \leq |\kappa| < \frac{1}{2}$ .
