# Well-posedness of the Cauchy problem for a space-dependent anyon Boltzmann equation.

Abstract. A fully non-linear kinetic equation for anyons and large initial data is studied in a periodic 1d setting. Strong  $L^1$  solutions are obtained for the Cauchy problem. The main results concern global existence, uniqueness and  $L^1$ -convergence to equilibrium.

## 1 Anyons and the Boltzmann equation.

Let us first recall the definition of anyon. Consider the wave function  $\psi(R, \theta, r, \varphi)$  for two identical particles with center of mass coordinates  $(R, \theta)$  and relative coordinates  $(r, \varphi)$ . Exchanging them,  $\varphi \to \varphi + \pi$ , gives a phase factor  $e^{2\pi i}$  for bosons and  $e^{\pi i}$  for fermions. In three or more dimensions those are all possibilities. Leinaas and Myrheim proved 1977 [10], that in one and two dimensions any phase factor is possible in the particle exchange. This became an important topic after the first experimental confirmations in the early 1980-ies, and Frank Wilczek in analogy with the terms bos(e)-ons and fermi-ons coined the name any-ons for the new quasi-particles with any phase. Anyon quasi-particles with e.g. fractional electric charge, have since been observed in various types of experiments.

By moving to a definition in terms of a generalized Pauli exclusion principle, Haldane [9] extended this to a fractional exclusion statistics valid for any dimension, and coinciding with the anyon definition in the one and two dimensional cases. Haldane statistics has also been realized for neutral fermionic atoms at ultra-low temperatures in three dimensions [3]. Wu later derived [19] occupation-number distributions for ideal gases under Haldane statistics by counting states under the new fractional exclusion principle. From the number of quantum states of N identical particles occupying G states being

 and  $\frac{G!}{N!(G-N)!}$ 

in the boson resp. fermion cases, he derived the interpolated number of quantum states for the fractional exclusions to be

$$\frac{(G + (N-1)(1-\alpha))!}{N!(G - \alpha N - (1-\alpha))!}, \qquad 0 < \alpha < 1.$$

He then obtained for ideal gases the equilibrium statistical distribution

$$\frac{1}{w(e^{(\epsilon-\mu)/T})+\alpha},$$
(1.2)

where  $\epsilon$  is particle energy,  $\mu$  chemical potential, T temperature, and the function  $w(\zeta)$  satisfies

$$w(\zeta)^{\alpha}(1+w(\zeta))^{1-\alpha} = \zeta \equiv e^{(\epsilon-\mu)/T}$$

In particular  $w(\zeta) = \zeta - 1$  for  $\alpha = 0$  (bosons) and  $w(\zeta) = \zeta$  for  $\alpha = 1$  (fermions).

In elastic pair collisions, the velocities  $(v, v_*)$  before and  $(v', v'_*)$  after a collision are related by  $v' = v - n[(v - v_*) \cdot n], v'_* = v_* + n[(v - v_*) \cdot n], n \in S^{d-1}$ . This preserves mass, linear momentum, and energy in Boltzmann type collision operators. We shall write  $f = f(v), \quad f_* = f(v_*), \quad f' = f(v'), \quad f'_* = f(v'_*)$ . An important question for gases with fractional exclusion statistics, is how to calculate their transport properties, in particular how the Boltzmann equation

$$\partial_t f + v \bigtriangledown_x f = Q(f)$$

gets modified. An answer was given by Bhaduri, Bhalerao, and Murthy [2] by generalizing to anyons the filling factors F(f) from the fermion and boson cases,  $F(f) = (1 + \eta f)$ ,  $\eta = \pm 1$ . The filling factors appear because quantum transitions also depend on the occupancy of the final state. With a filling factor F(f) in the collision operator Q, the entropy production term becomes

$$\int Q(f) \log \frac{f}{F(f)} \,,$$

which for equilibrium implies

$$\frac{f'}{F(f')}\frac{f'_*}{F(f'_*)} = \frac{f}{F(f)}\frac{f_*}{F(f_*)}$$

Using the conservation laws, we may conclude as usual, that in equilibrium

$$\frac{f}{F(f)}$$

is a Maxwellian. Inserting Wu's equilibrium (1.2) for f and Maxwellian, this gives

$$f = \frac{1}{w(e^{(\epsilon-\mu)/T}) + \alpha}$$
,  $F(f) = f e^{(\epsilon-\mu)/T} = \frac{e^{(\epsilon-\mu)/T}}{w(e^{(\epsilon-\mu)/T}) + \alpha}$ .

In particular in the fermion and boson cases,

$$f = \frac{1}{e^{(\epsilon - \mu)/T} - \eta}, \qquad F(f) = \frac{e^{\epsilon - \mu)/T}}{e^{(\epsilon - \mu)/T} - \eta}, \ \eta = \mp 1.$$

This is consistent with taking an interpolation between the fermion and boson factors as general filling factor,  $F(f) = (1 - \alpha f)^{\alpha} (1 + (1 - \alpha)f)^{1-\alpha}$ ,  $0 < \alpha < 1$ . It gives as collision operator Q under Haldane statistics ([2]),

$$Q(f)(v) = Q^{+}(f) - Q^{-}(f) = \int_{\mathbb{R}^{d} \times S^{d-1}} B(v - v_{*}, \omega) \times [f'f'_{*}F(f)F(f_{*}) - ff_{*}F(f')F(f'_{*})]dv_{*}d\omega.$$
(1.3)

Here  $d\omega$  corresponds to the Lebesgue probability measure on the (d-1)-sphere. The collision kernel  $B(z,\omega)$  in the variables  $(z,\omega) \in \mathbb{R}^d \times \mathbb{S}^{d-1}$  is positive, locally integrable, and only depends on |z| and  $|(z,\omega)|$ . See [2] for further discussion of the kernel B. The Boltzmann equation for  $0 < \alpha < 1$  retains important properties from the Fermi-Dirac case, but it has so far not been validated from basic quantum theory.

In the filling factor  $F(f) = (1 - \alpha f)^{\alpha}(1 + (1 - \alpha)f)^{1-\alpha}$ ,  $0 < \alpha < 1$ , the real factor  $(1 - \alpha f)^{\alpha}$  requires the value of f to be between 0 and  $\frac{1}{\alpha}$ . This is formally preserved by the equation, since the gain term vanishes for  $f = \frac{1}{\alpha}$ , making the Q-term (1.3) and the derivative left hand side of the Boltzmann equation negative there. And the derivative equals the positive gain term for f = 0, where the loss term vanishes. F is concave with maximum value one at f = 0 for  $\alpha \geq \frac{1}{2}$ , and maximum value  $(\frac{1}{\alpha} - 1)^{1-2\alpha} > 1$  at  $f = \frac{1-2\alpha}{\alpha(1-\alpha)}$  for  $\alpha < \frac{1}{2}$ . The collision operator vanishes identically for the equilibrium distribution functions obtained by Wu, but for no other functions.

The derivation and basic properties of the Boltzmann equation for the limiting cases, representing boson statistics ( $\alpha = 0$ ) and fermion statistics ( $\alpha = 1$ ), was obtained by Nordheim [16] and Uehling, Uhlenbeck [18]. Here the quartic terms in the collision integral cancel, which is used in the analysis. General existence results for the space-homogeneous isotropic boson large data case were obtained in [12], followed by a number of other papers, e.g. [8], [13], [14], [15], and for the space-dependent case near equilibrium in [17]. In the space-dependent fermion case general existence results were obtained in [7] and [11].

For  $0 < \alpha < 1$  there are no cancellations in the collision term. Moreover, the Lipschitz continuity of the collision term is replaced by a weaker Hölder continuity near  $f = \frac{1}{\alpha}$ . The space-homogeneous initial value problem for the Boltzmann equation with Haldane statistics is

$$\frac{df}{dt} = Q(f), \quad f(0,v) = f_0(v).$$
 (1.4)

Because of the filling factor F, the range for the initial value  $f_0$  should belong to  $[0, \frac{1}{\alpha}]$ , which is also formally preserved by the equation. A good control of  $\int f(t, x, v) dv$ , which in the spacehomogeneous case is given by the mass conservation, can be used to also keep f uniformly away from  $\frac{1}{\alpha}$ , and F(f) Lipschitz continuous. That was a basic observation behind the existence result for the space-homogeneous anyon Boltzmann equation.

**Proposition 1.1** [1] Consider the space-homogeneous equation (1.4) with velocities in  $\mathbb{R}^d$ ,  $d \geq 2$  and for hard force kernels with

$$0 < B(z,\omega) \le C|z|^{\beta} |\sin\theta\cos\theta|^{d-1},\tag{1.5}$$

where  $0 < \beta \leq 1$ , d > 2, and  $0 < \beta < 1$ , d = 2. Let the initial value  $f_0$  have finite mass and energy. If  $0 < f_0 \leq \frac{1}{\alpha}$  and ess  $\sup(1+|v|^s)f_0 < \infty$  for  $s = d-1+\beta$ , then the initial value problem for (1.4) has a strong solution in the space of functions continuous from  $t \geq 0$  into  $L^1 \cap L^\infty$ , which conserves mass and energy, and for  $t_0 > 0$  given, has ess  $\sup_{v,t \leq t_0} |v|^{s'} f(t,v)$  bounded, where  $s' = \min(s, \frac{2\beta(d+1)+2}{d})$ .

In this proposition, stronger limitations on B would allow for weaker conditions on the initial value  $f_0$ . The proof implies stability; given a sequence of positive initial values  $(f_{0n})_{n \in \mathbb{N}}$  with

$$\sup_{n} \operatorname{ess\,sup} f_{0n}(v) < \frac{1}{\alpha},$$

and converging in  $L^1$  to  $f_0$ , there is a subsequence of the solutions converging in  $L^1$  to a solution with initial value  $f_0$ .

## 2 The main results.

The present paper considers the space-dependent anyon Boltzmann equation in a slab. Anyons only exist in one and two dimensions, and their velocities are restricted to  $v \in \mathbb{R}^2$ . The kernel  $B(n \cdot \frac{v-v_*}{|v-v_*|}, |v-v_*|)$  is assumed measurable with

$$0 \le B \le B_0,\tag{2.1}$$

for some  $B_0 > 0$ . It is also assumed for some  $\gamma, \gamma' > 0$ , that

$$B(n \cdot \frac{v - v_*}{|v - v_*|}, |v - v_*|) = 0 \text{ for } |n \cdot \frac{v - v_*}{|v - v_*|}| < \gamma', \quad \text{for } ||n \cdot \frac{v - v_*}{|v - v_*|}| - 1| < \gamma', \quad \text{and for } |v - v_*| < \gamma,$$
(2.2)

and that

$$\int B(\omega, |v - v_*|)) d\omega \ge c_B > 0 \quad \text{for } |v - v_*| \ge \gamma.$$
(2.3)

The initial datum  $f_0(x, v)$ , periodic in x, is assumed to be a measurable function with values in  $[0, \frac{1}{\alpha}]$ , and such that

$$(1+|v|^2)f_0(x,v) \in L^1([0,1] \times \mathbb{R}^2), \ \int \sup_{x \in [0,1]} f_0(x,v)dv = c_0 < \infty, \ \inf_{x \in [0,1]} f_0(x,v) > 0, \ \text{a.a.} v \in \mathbb{R}^2.$$
(2.4)

With  $v_1$  denoting the component of v in the x-direction, consider for functions periodic in x, the initial value problem

$$\partial_t f(t, x, v) + v_1 \partial_x f(t, x, v) = Q(f)(t, x, v), \quad f(0, x, v) = f_0(x, v), \tag{2.5}$$

in one space-dimension. The main result of the present paper is the following theorem.

#### Theorem 2.1

There exists a strong solution  $f \in \mathcal{C}([0,\infty[;L^1([0,1] \times \mathbb{R}^2)))$  of (2.5) with  $0 < f(t,.) < \frac{1}{\alpha}$  for t > 0. There is  $t_m > 0$  such that for any  $T > t_m$ , there is  $\eta_T > 0$  so that  $f \leq \frac{1}{\alpha} - \eta_T$  for  $t_m \leq t \leq T$ . The solution is unique and is stable in the  $L^1$ -norm on each interval  $0 \leq t \leq T$ . It conserves mass, first moment and energy.

#### Remarks.

The above results seem to be new also in the fermion case where  $\alpha = 1$ . The approach in the paper can also be used to obtain regularity results. Contrary to the space-homogeneous case, here the control of  $\int f(t, x, v) dv$  is non-trivial.

An entropy connected to (2.5) is

$$\int \left( f \log f + (\frac{1}{\alpha} - f) \log(1 - \alpha f)^{\alpha} - (\frac{1}{1 - \alpha} + f) \log(1 + (1 - \alpha)f)^{1 - \alpha} \right) dx dp.$$

It is used to prove Proposition 4.3, stating that the solution converges strongly in  $L^1$  to a spacehomogeneous equilibrium solution of type (1.2) with the same mass, first velocity moments, and energy as the initial value.

An open problem is the behaviour of (2.5) beyond the anyon frame, i.e. for higher v-dimensions

under Haldane statistics. It seems likely that a close to equilibrium approach as in the classical case, could work with fairly general kernels B for close to equilibrium initial values  $f_0$  with some regularity and strong decay conditions for large velocities. Any progress on the large data case in several space-dimensions under Haldane statistics would be quite interesting.

The proof in this paper uses the control of the Bony functional, only known for one space dimension. Due to the filling factor F(f), the study is restricted to the anyon case, i.e. with  $v \in \mathbb{R}^2$ . The lack of Lipschitz continuity of F(f) when f is in a neighborhood of  $\frac{1}{\alpha}$  requires some care. Since the gain term vanishes when  $f = \frac{1}{\alpha}$  and the derivative becomes negative there, f should start decreasing before reaching this value. The proof that this takes place uniformly over phase-space and approximations, is based on a good control of  $\int f(t, x, v) dv$  in the integration of the gain and loss parts of Q. That is a main topic in Section 3 together with the study of a family of approximating equations with large velocity cut-off. Based on those results and using the Lipschitz continuity of F(.) away from  $\frac{1}{\alpha}$ , in Section 4 contraction mapping techniques prove the well-posedness of the problem, when the initial value  $f_0$  stays uniformly away from  $\frac{1}{\alpha}$ . That restriction is removed by a local initial value analysis, which only assumes Hölder continuity of F(.). Finally, the time-asymptotic behaviour is studied, using entropy and entropy dissipation control.

# **3** Approximations and control of mass density.

For any  $j \in \mathbb{N}^*$ , denote by  $\psi_i$ , the cut-off function with

$$\psi_j(r) = 0$$
 if  $r > j$  and  $\psi_j(r) = 1$  if  $r \le j$ ,

and set

$$\chi_j(v, v_*, v', v'_*) = \psi_j(|v|)\psi_j(|v_*|)\psi_j(|v'|)\psi_j(|v'_*|)$$

Let  $F_j$  be defined on  $[0, \frac{1}{\alpha}]$  by

$$F_j(y) = \frac{1 - \alpha y}{(\frac{1}{j} + 1 - \alpha y)^{1 - \alpha}} (1 + (1 - \alpha)y)^{1 - \alpha}.$$

Denote by  $Q_j$  the operator

$$Q_j(f)(v) := \int B(v, v_*, \omega) \chi_j(v, v_*, v', v'_*) \Big( f' f'_* F_j(f) F_j(f_*) - f f_* F_j(f') F_j(f'_*) \Big) dv_* d\omega,$$

and set  $f_{0,j} = \min\{f_0, \frac{1}{\alpha} - \frac{1}{j}\}$ . The following lemma concerns a corresponding approximation of (2.5).

**Lemma 3.1** There is a unique solution  $f_j \in C([0, +\infty[; L^1([0, 1] \times \{v; |v| \le j\})))$  to

$$\partial_t f_j + v_1 \partial_x f_j = Q_j(f_j), \quad f_j(0, \cdot, \cdot) = f_{0,j}, \tag{3.1}$$

with values in  $[0, \frac{1}{\alpha} - \eta_j]$ , for some  $\eta_j > 0$ . It conserves mass, first moment and energy.

## Proof of Lemma 3.1.

Let us prove that for any T > 0, there is a unique solution  $f_j \in C([0,T]; L^1([0,1] \times \{v; |v| \le j\}))$  to (3.1). Let T > 0 be given. For  $\epsilon \in ]0, 1[$ , let a mollifier  $\varphi_{\epsilon}$  be defined by  $\varphi_{\epsilon}(x, v) = \frac{1}{\epsilon^3} \varphi(\frac{x}{\epsilon}, \frac{v}{\epsilon})$ , where

$$\varphi \in C_0^{\infty}(\mathbb{R}^3), \quad support(\varphi) \subset [0,1] \times \{ v \in \mathbb{R}^2; |v| \le 1 \}, \quad \varphi \ge 0, \quad \int \varphi(x,v) dx dv = 1.$$

Let  $f_{0,j,\epsilon}$  be the restriction to  $[0,1] \times \{|v| \leq j\}$  of  $\left(\min\{f_0, \frac{1}{\alpha} - \frac{1}{j}\}\right) * \varphi_{\epsilon}$ . Let  $\tilde{F}_{\epsilon,j}$  be defined on  $[0, \frac{1}{\alpha}]$  by

$$\tilde{F}_{\epsilon,j}(y) = \frac{\epsilon + 1 - \alpha y}{(\frac{1}{j} + 1 - \alpha y)^{1-\alpha}} (1 + (1 - \alpha)y)^{1-\alpha}.$$

For a real number y, set

$$\bar{y} = 0$$
 if  $y < 0$ ,  $\bar{y} = y$  if  $y \in [0, \frac{1}{\alpha}]$ ,  $\bar{y} = \frac{1}{\alpha}$  if  $y > \frac{1}{\alpha}$ .

Let the operators  $Q_{\epsilon,j}$  and  $\bar{Q}_{\epsilon,j}$  be defined by

$$Q_{\epsilon,j}(f)(v) = \int B(v, v_*, \omega) \chi_j \Big( f' f'_* F_j(f) F_j(f_*) - f f_* \tilde{F}_{\epsilon,j}(f') \tilde{F}_{\epsilon,j}(f'_*) \Big) dv_* d\omega,$$
  
$$\bar{Q}_{\epsilon,j}(f)(v) = \int B(v, v_*, \omega) \chi_j \Big( \bar{f}' \bar{f}'_* F_j(f) F_j(\bar{f}_*) - f \bar{f}_* \tilde{F}_{\epsilon,j}(\bar{f}') \tilde{F}_{\epsilon,j}(\bar{f}'_*) \Big) dv_* d\omega.$$

We shall first prove by contraction that for  $t_0 > 0$  and small enough, there is a unique solution  $f_{\epsilon,j} \in C([0, t_0] \times [0, 1] \times \{v; |v| \le j\})$  to the initial value problem

$$\partial_t f_{\epsilon,j} + v_1 \partial_x f_{\epsilon,j} + f_{\epsilon,j} \int B\chi_j \bar{f}_{\epsilon,j*} \tilde{F}_{\epsilon,j}(\bar{f}'_{\epsilon,j}) \tilde{F}_{\epsilon,j}(\bar{f}'_{\epsilon,j*}) dv_* d\omega = F_j(f_{\epsilon,j}) \int B\chi_j \bar{f}'_{\epsilon,j} \bar{f}'_{\epsilon,j*} F_j(\bar{f}_{\epsilon,j*}) dv_* d\omega,$$
$$f_{\epsilon,j}(0,\cdot,\cdot) = f_{0,j,\epsilon}. \tag{3.2}$$

Extending the approximation approach from [7] in the fermion case, let the map C be defined on  $C([0,T] \times [0,1] \times \{v; |v| \le j\})$  by C(f) = g, where

$$\partial_t g + v_1 \partial_x g = \bar{Q}_{\epsilon,j}(f), \quad g(0,\cdot,\cdot) = f_{0,j,\epsilon}.$$

C is a contraction in the sup-norm on  $[0, T_1]$ , for  $T_1 > 0$  small enough, since the partial derivatives of the map

$$(x_1, x_2, x_3, x_4) \to \bar{x}_3 \bar{x}_4 F_j(x_1) F_j(\bar{x}_2) - x_1 \bar{x}_2 \tilde{F}_{\epsilon,j}(\bar{x}_3) \tilde{F}_{\epsilon,j}(\bar{x}_4)$$

are bounded. The initial value is  $f_{0,j,\epsilon} > 0$ , and the right hand side of the first equation of (3.2) is initially positive. It follows by continuity for some  $T_1 \ge t_0 > 0$ , that  $1 - \frac{1}{\alpha} f_{\epsilon,j} > 0$  for  $t \le t_0$  uniformly in x, v. Hence

$$\begin{aligned} f_{\epsilon,j}^{\sharp}(t,x,v) &:= f_{\epsilon,j}(t,x+tv_1,v) \ge f_{0,j,\epsilon}(x,v)e^{-\int_0^t \int B\chi_j(\bar{f}_*\bar{F}_{\epsilon,j}(\bar{f}')\bar{F}_{\epsilon,j}(\bar{f}'_*))^{\sharp}(s)dv_*d\omega ds} \\ &\ge f_{0,j,\epsilon}(x,v)e^{-cj^2t} > 0, \quad t \in [0,t_0], \ x \in [0,1], \ |v| \le j. \end{aligned}$$

An analogous result holds for  $1 - \frac{1}{\alpha} f_{\epsilon,j}$ . Thus  $f_{\epsilon,j}$  locally maps into  $]0, \frac{1}{\alpha}[$ , and in (3.2) the bar can be removed from  $f_{\epsilon,j}$ , giving a local solution in  $C([0, t_0] \times [0, 1] \times \{v; |v| \le j\})$  to

$$\partial_t f_{\epsilon,j} + v_1 \partial_x f_{\epsilon,j} = Q_{\epsilon,j}(f_{\epsilon,j}), \quad f_{\epsilon,j}(0,\cdot,\cdot) = f_{0,\epsilon,j}.$$

$$(3.3)$$

The argument can be repeated and the solution can be continued up to t = T. Consequently, for some  $\eta_j > 0$ , there is a solution  $f_{\epsilon,j} \in C([0,T] \times [0,1] \times \{v; |v| \le j\})$  to (3.3) with values in  $[0, \frac{1}{\alpha} - \eta_j]$ . The family  $(f_{\epsilon,j})_{\epsilon \in [0,1]}$  is Cauchy. Indeed, for any  $(\epsilon, \epsilon') \in [0,1]^2$ ,

for some constants  $c_1$  and  $c_2$  depending on j and independent on  $(\epsilon, \epsilon')$ . Using a Gronwall argument and taking into account that  $\int |f_{0,j,\epsilon} - f_{0,j,\epsilon'}|(x,v)dxdv \to 0$  when  $\epsilon$  and  $\epsilon'$  tend to zero, it follows that  $(f_{\epsilon,j})_{\epsilon \in [0,1]}$  is Cauchy in  $L^1([0,T] \times [0,1] \times \{v; |v| \le j\})$ . Denote by  $f_j$  its limit when  $\epsilon \to 0$ . It is a solution to (3.1) and belongs to  $C([0,T]; L^1([0,1] \times \{v; |v| \le j\})$  since  $Q_j(f_j)$  is bounded.

If there were another nonnegative local solution  $\tilde{f}_j$  to (3.1), defined on [0, T'] for some  $T \ge T' > 0$ , then by the exponential form it would stay strictly below  $\frac{1}{\alpha}$ . The difference  $f_j - \tilde{f}_j$  would for some constant  $c_{T'}$  satisfy

$$\int |(f_j - \tilde{f}_j)^{\sharp}(t, x, v)| dx dv \le c_{T'} \int_0^t |(f_j - \tilde{f}_j)^{\sharp}(s, x, v)| ds dx dv, \ t \in [0, T'], \quad (f_j - \tilde{f}_j)^{\sharp}(0, x, v) = 0,$$

implying that the difference is identically zero on [0, T']. Thus  $f_j$  is the unique solution on [0, T] to (3.1), and has its range contained in  $[0, \frac{1}{\alpha} - \eta_j]$ .

The remaining part of this section is devoted to obtaining a uniform control with respect to  $j \in \mathbb{N}^*$  of

$$\int \sup_{t>0, x\in[0,1]} f_j^{\sharp}(t,x,v) dv.$$

It relies on the following four lemmas, where the first is an estimate of the Bony functionals,

$$\bar{B}_{j}(t) := \int_{0}^{1} \int |v - v_{*}|^{2} B\chi_{j} f_{j} f_{j*} F_{j}(f_{j}') F_{j}(f_{j*}') dv dv_{*} d\omega dx, \quad t \ge 0.$$

#### Lemma 3.2

It holds that

$$\int_0^{+\infty} \bar{B}_j(t) dt \le c'_0, \quad j \in \mathbb{N}^*,$$

with  $c'_0$  only depending on  $\int (1+|v|^2) f_0(x,v) dx dv$ .

### Proof of Lemma 3.2.

Denote  $f_j$  by f for simplicity. The lemma follows by an extension of the classical proof (cf [4], [6]), as follows. It holds

$$\int_0^t \int_0^1 \int (v_1 - u_1)^2 B\chi_j f f_* F_j(f') F_j(f'_*)(s, x, v, v_*, \omega) dv dv_* d\omega dx ds$$
  
$$\leq c \int_0^t \int_0^1 \int (v_1 - u_1)^2 f f_*(s, x, v, v_*) dv dv_* dx ds, \quad t > 0,$$

with  $u_1 = \frac{\int v_1 f dv}{\int f dv}$ . The right hand side can also be written

$$\frac{c}{2} \int_0^t \int_0^1 \int (v_1 - v_{*1})^2 ff_*(s, x, v, v_*) dv dv_* dx ds$$

which is bounded by a constant depending only on  $\int (1+v^2)f_0(x,v)dxdv$  (see [5] with a proof for smooth solutions but, adding a convolution argument, also holding for strong solutions).

Multiply equation (3.1) for f by  $v_1^2$ , integrate and use that  $\int v_1^2 Q_j(f) dv = \int (v_1 - u_1)^2 Q_j(f) dv$ . It results

<  $c_{0}$ ,

where  $c_0$  is a constant only depending on  $\int (1+v^2) f_0(x,v) dx dv$ .

After a collision transform the left hand side can be written

$$\int_{0}^{t} \int (v_{1}' - u_{1})^{2} B\chi_{j} f f_{*} F_{j}(f') F_{j}(f_{*}') dv dv_{*} d\omega dx ds$$
  
= 
$$\int_{0}^{t} \int (c_{1} - n_{1}[(v - v_{*}) \cdot n])^{2} B\chi_{j} f f_{*} F_{j}(f') F_{j}(f_{*}') dx dv dv_{*} d\omega ds,$$

where  $c_1 = v_1 - u_1$ . Expand  $(c_1 - n_1[(v - v_*) \cdot n])^2$ , and remove the positive term containing  $c_1^2$ .

The term containing  $n_1^2[(v - v_*) \cdot n]^2$  is estimated from below. When v' and  $v'_*$  are shifted, n is replaced by an orthogonal unit vector  $n_{\perp}$ , and the product  $ff_*F_j(f')F_j(f'_*)$  is unchanged. In  $\mathbb{R}^2$  the ratio between the sum of the integrand factors  $n_1^2[(v - v_*) \cdot n]^2 + n_{\perp 1}^2[(v - v_*) \cdot n_{\perp}]^2$  and  $|v - v_*|^2$ , is, outside of the angular cut-off, uniformly bounded from below by some constant r > 0. Indeed, if  $\alpha$  denotes the angle between  $\frac{v - v_*}{|v - v_*|}$  and n,

$$\begin{split} n_1^2 [\frac{v - v_*}{|v - v_*|} \cdot n]^2 + n_{\perp 1}^2 [\frac{v - v_*}{|v - v_*|} \cdot n_{\perp}]^2 &= \cos^2\theta \cos^2\alpha + \sin^2\theta \sin^2\alpha \\ &\geq \gamma'^2 \cos^2\alpha + \gamma'(2 - \gamma') \sin^2\alpha \\ &\geq \gamma'^2, \quad \gamma' < |\cos\theta| < 1 - \gamma', \quad \alpha \in [0, 2\pi]. \end{split}$$

This is where the condition  $v \in \mathbb{R}^2$  is used.

That leads to the lower bound

$$\int_0^t \int n_1^2 [(v-v_*) \cdot n]^2 B\chi_j f f_* F_j(f') F_j(f'_*) dv dv_* d\omega dx ds$$
  

$$\geq r \int_0^t \int |v-v_*|^2 B\chi_j f f_* F_j(f') F_j(f'_*) dv dv_* d\omega dx ds.$$

And so,

$$r \int_{0}^{t} \int |v - v_{*}|^{2} B\chi_{j} f f_{*} F_{j}(f') F_{j}(f'_{*}) dv dv_{*} d\omega dx ds$$
  

$$\leq c_{0} + 2 \int_{0}^{t} \int (v_{1} - u_{1}) n_{1} [(v - v_{*}) \cdot n] B\chi_{j} f f_{*} F_{j}(f') F_{j}(f'_{*}) dv dv_{*} d\omega dx ds$$
  

$$\leq 2c_{0} + 2 \int_{0}^{t} \int \left( v_{1}(v_{2} - v_{*2}) n_{1} n_{2} \right) B\chi_{j} f f_{*} F_{j}(f') F_{j}(f'_{*}) dv dv_{*} d\omega dx ds,$$

since

$$\int u_1(v_1 - v_{*1})n_1^2 B\chi_j f f_* F_j(f') F_j(f'_*) dv dv_* d\omega dx$$
  
=  $\int u_1(v_2 - v_{*2})n_1 n_2 \chi_j Bf f_* F(if') F_j(f'_*) dv dv_* d\omega dx = 0,$ 

by an exchange of the variables v and  $v_*$ . Moreover, exchanging first the variables v and  $v_*$ ,

$$2\int_{0}^{t} \int v_{1}(v_{2} - v_{*2})n_{1}n_{2}B\chi_{j}ff_{*}F_{j}(f')F_{j}(f'_{*})dvdv_{*}d\omega dxds$$
  

$$=\int_{0}^{t} \int (v_{1} - v_{*1})(v_{2} - v_{*2})n_{1}n_{2}B\chi_{j}ff_{*}F_{j}(f')F_{j}(f'_{*})dvdv_{*}d\omega dxds$$
  

$$\leq \frac{1}{r}\int_{0}^{t} \int (v_{1} - v_{*1})^{2}n_{1}^{2}B\chi_{j}ff_{*}F_{j}(f')F_{j}(f'_{*})dvdv_{*}d\omega dxds$$
  

$$+\frac{r}{4}\int_{0}^{t} \int (v_{2} - v_{*2})^{2}n_{2}^{2}B\chi_{j}ff_{*}F_{j}(f')F_{j}(f'_{*})dvdv_{*}d\omega dxds$$
  

$$\leq \frac{c_{0}}{r} + \frac{r}{4}\int_{0}^{t} \int (v_{2} - v_{*2})^{2}n_{2}^{2}B\chi_{j}ff_{*}F_{j}(f')F_{j}(f'_{*})dvdv_{*}d\omega dxds.$$

It follows that

$$\int_0^t \int |v - v_*|^2 B\chi_j f f_* F_j(f') F_j(f'_*) dv dv_* d\omega dx ds \le c'_0,$$

with  $c'_0$  only depending on  $\int (1+v^2) f_0(x,v) dx dv$ . That completes the proof of the lemma.

#### Lemma 3.3

There exists a constant  $c_1'$  only depending on  $\int (1+|v|^2)f_0(x,v)dxdv,$  so that

$$\int \sup_{t \ge 0} f_j^{\sharp}(t, x, v) dx dv < c_1', \quad j \in \mathbb{N}^*.$$

<u>Proof of Lemma 3.3.</u> Denote  $f_j$  by f for simplicity. Since

$$f^{\sharp}(t, x, v) = f_0(x, v) + \int_0^t Q_j(f)(s, x + sv_1, v)ds,$$

it holds that

$$\sup_{t \ge 0} f^{\sharp}(t, x, v) \le f_0(x, v) + \int_0^{+\infty} Q_j^+(f)(t, x + tv_1, v) dt.$$
(3.4)

Integrating (3.5) with respect to (x, v) and using Lemma 3.2, gives

$$\int \sup_{t\geq 0} f^{\sharp}(t,x,v) dx dv \leq \int f_0(x,v) dx dv + \int_0^{+\infty} \int B\chi_j$$

$$f(t,x+tv_1,v') f(t,x+tv_1,v'_*) F_j(f)(t,x+tv_1,v) F_j(f)(t,x+tv_1,v_*) dv dv_* d\omega dx dt$$

$$\leq \int f_0(x,v) dx dv + \frac{1}{\gamma^2} \int_0^{+\infty} \int B\chi_j |v-v_*|^2$$

$$f(t,x,v') f(t,x,v'_*) F_j(f)(t,x,v) F_j(f)(t,x,v_*) dv dv_* d\omega dx dt$$

$$\leq \int f_0(x,v) dx dv + \frac{c'_0}{\gamma^2}.$$

## Lemma 3.4

Given  $\delta_1 > 0$ , there exists  $\delta_2 > 0$  and  $t_0 > 0$ , only depending on  $\int (1 + |v|^2) f_0(x, v) dx dv$ , so that

$$\sup_{x_0 \in [0,1]} \int_{|x-x_0| < \delta_2} \sup_{t \le t_0} f_j^{\sharp}(t,x,v) dx dv < \delta_1, \quad j \in \mathbb{N}^*.$$

 $\frac{\text{Proof of Lemma 3.4.}}{\text{Denote } f_j \text{ by } f \text{ for simplicity. It holds,}}$ 

$$f^{\sharp}(t, x, v) = f_0(x, v) + \int_0^t Q_j(f)(s, x + sv_1, v)ds$$
  
$$\leq f_0(x, v) + \int_0^t Q_j^+(f)(s, x + sv_1, v)ds.$$

Hence,

$$\sup_{t \le t_0} f^{\sharp}(t, x, v) \le f_0(x, v) + \int_0^{t_0} Q_j^+(f)(s, x + sv_1, v) ds.$$

Integrating with respect to (x, v) and using Lemmas 3.2-3, gives

$$\begin{split} &\int_{|x-x_0|<\delta_2} \sup_{t\leq t_0} f^{\sharp}(t,x,v) dx dv \\ &\leq \int_{|x-x_0|<\delta_2} f_0(x,v) dx dv \\ &+ \int_0^{t_0} \int B\chi_j f(s,x+sv_1,v') f(s,x+sv_1,v'_*) F_j(f)(s,x+sv_1,v) F_j(f)(s,x+sv_1,v_*) dv dv_* d\omega dx ds \\ &\leq \int_{|x-x_0|<\delta_2} f_0(x,v) dx dv \\ &+ \frac{1}{\lambda^2} \int_0^{t_0} \int_{|v-v_*|\geq\lambda} B\chi_j |v-v_*|^2 f(s,x,v') f(s,x,v'_*) F_j(f)(s,x,v) F_j(f)(s,x,v_*) dv dv_* d\omega dx ds \\ &+ \int_0^{t_0} \int_{|v-v_*|<\lambda} B\chi_j f(s,x,v) f(s,x,v_*) dv dv_* d\omega dx ds \\ &\leq \int_{|x-x_0|<\delta_2} f_0(x,v) dx dv + \frac{c'_0}{\lambda^2} + t_0 cc'_1 \lambda^2. \end{split}$$

Suitably choosing  $\delta_2$ ,  $\lambda$ , and  $t_0$  in that order and depending on  $\delta_1$ , the lemma follows.

The previous lemmas imply an exponential growth for the v-integral of  $f_j^{\#}$  with the growth coefficients only depending on  $\int (1+|v|^2) f_0(x,v) dx dv$ , as will now be proved.

#### Lemma 3.5

The solution  $f_j$  of (3.1) satisfies

$$\int \sup_{(t,x)\in[0,T]\times[0,1]} f_j^{\sharp}(t,x,v) dv \le c_1 e^{c_2 T}, \quad j \in \mathbb{N}^*, \quad T > 0,$$

where  $c_1$  and  $c_2$  only depend on  $\int (1+|v|^2) f_0(x,v) dx dv$ .

Proof of Lemma 3.5.

As in the proof of Lemma 3.4,

$$\sup_{s \le t} f^{\sharp}(s, x, v) \le f_0(x, v) + \int_0^t Q_j^+(f)(s, x + sv_1, v) ds = f_0(x, v) + \int_0^t \int B\chi_j f(s, x + sv_1, v') f(s, x + sv_1, v'_*) F_j(f)(s, x + sv_1, v) F_j(f)(s, x + sv_1, v_*) dv_* d\omega ds \le f_0(x, v) + cA,$$
(3.5)

where

$$A = \int_0^t \int B\chi_j \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_1 - v_1'), v') \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_1 - v_{*1}'), v_*') dv_* d\omega ds.$$

For  $\omega$  outside of the angular cutoff, let n be the unit vector in the direction v - v', and  $n_{\perp}$  the orthogonal unit vector in the direction  $v - v'_*$ . With  $e_1$  a unit vector in the x-direction,

$$\max(|n \cdot e_1|, |n_\perp \cdot e_1|) \geq \frac{1}{\sqrt{2}}.$$

For  $\delta_2 > 0$  that will be fixed later, split A into  $A_1 + A_2 + A_3 + A_4$ , where

$$A_{1} = \int_{0}^{t} \int_{|n \cdot e_{1}| \ge \frac{1}{\sqrt{2}}, t |v_{1} - v_{1}'| > \delta_{2}} B\chi_{j} \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1} - v_{1}'), v') \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1} - v_{1}'), v_{*}') dv_{*} d\omega ds,$$

$$A_{2} = \int_{0}^{t} \int_{|n \cdot e_{1}| \ge \frac{1}{\sqrt{2}}, t |v_{1} - v_{1}'| < \delta_{2}} B\chi_{j} \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1} - v_{1}'), v') \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1} - v_{1}'), v_{*}') dv_{*} d\omega ds,$$

$$A_{3} = \int_{0}^{t} \int_{|n_{\perp} \cdot e_{1}| \ge \frac{1}{\sqrt{2}}, t |v_{1} - v_{1}'| > \delta_{2}} B\chi_{j} \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1} - v_{1}'), v') \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1} - v_{*1}'), v_{*}') dv_{*} d\omega ds,$$

$$f^{t} = f$$

$$A_4 = \int_0^{\circ} \int_{|n_{\perp} \cdot e_1| \ge \frac{1}{\sqrt{2}}, t|v_1 - v_1'| < \delta_2} B\chi_j \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_1 - v_1'), v') \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_1 - v_{*1}'), v_*') dv_* d\omega ds.$$

In  $A_1$  and  $A_2$ , bound the factor  $\sup_{\tau \in [0,t]} f^{\sharp}(\tau, x + s(v_1 - v'_{*1}), v'_*)$  by its supremum over  $x \in [0,1]$ , and make the change of variables

 $s \to y = x + s(v_1 - v_1').$ 

For any  $(a, b) \in \mathbb{R}^2$ , denote by I(a, b) the interval with end points a and b. It holds that

$$A_{1} \leq \int_{t|v_{1}-v_{1}'|>\delta_{2}} \frac{B\chi_{j}}{|v_{1}-v_{1}'|} \Big(\int_{y\in I(x,x+t(v_{1}-v_{1}'))} \sup_{\tau\in[0,t]} f^{\#}(\tau,y,v')dy\Big) \sup_{(\tau,X)\in[0,t]\times[0,1]} f^{\#}(\tau,X,v_{*}')dv_{*}d\omega,$$

and

$$A_{2} \leq \frac{\sqrt{2}}{\gamma'} \int_{|n \cdot e_{1}| \geq \frac{1}{\sqrt{2}}, t|v_{1} - v_{1}'| < \delta_{2}} B\chi_{j} \left( \int_{|y - x| < \delta_{2}} \sup_{\tau \in [0, t]} f^{\#}(\tau, y, v') dy \right) \sup_{(\tau, X) \in [0, t] \times [0, 1]} f^{\#}(\tau, X, v_{*}') dv_{*} d\omega.$$

Then, performing the change of variables  $(v, v_*, \omega) \rightarrow (v', v'_*, -\omega)$ ,

$$\int \sup_{x \in [0,1]} A_1 dv \leq \int_{t|v_1 - v_1'| > \delta_2} \frac{B\chi_j}{|v_1 - v_1'|} \sup_{x \in [0,1]} \left( \int_{y \in I(x, x + t(v_1' - v_1)} \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v) dy \right) \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_*) dv dv_* d\omega,$$

so that

$$\begin{split} &\int \sup_{x \in [0,1]} A_1 dv \\ &\leq \int_{t \mid v_1 - v_1' \mid > \delta_2} \frac{B\chi_j}{\mid v_1 - v_1' \mid} \sup_{x \in [0,1]} \left( \int_{y \in I(x, x + E(t(v_1' - v_1) + 1)} \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v) dy \right) \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_*) dv dv_* d\omega \\ &= \int_{t \mid v_1 - v_1' \mid > \delta_2} \frac{B\chi_j}{\mid v_1 - v_1' \mid} \Big( E(t(v_1' - v_1) + 1)) \Big( \int_0^1 \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v) dy \Big) \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_*) dv dv_* d\omega \\ &\leq t(1 + \frac{1}{\delta_2}) \int B\chi_j \Big( \int_0^1 \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v) dy \Big) \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_*) dv dv_* d\omega \\ &\leq c \frac{t}{\delta_2} \int \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v) dy dv \int \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_*) dv_*. \end{split}$$

Here E(x) is the integer part of  $x \in \mathbb{R}$ ,  $E(x) \le x < E(x) + 1$ . Apply Lemma 3.3, so that

$$\int \sup_{x \in [0,1]} A_1 dv \le \frac{cc_1' t}{\delta_2} \int \sup_{(\tau,X) \in [0,t] \times [0,1]} f^{\#}(\tau,X,v_*) dv_*.$$
(3.6)

Moreover, performing the change of variables  $(v, v_*, \omega) \rightarrow (v'_*, v', -\omega)$ ,

$$\int \sup_{x \in [0,1]} A_2 dv \le c \sup_{x \in [0,1]} \left( \int_{|y-x| < \delta_2} \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v_*) dy dv_* \right) \int \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v) dv.$$

Given  $\delta_1$ , apply Lemma 3.4 with the corresponding  $\delta_2$  and  $t_0$  and consider  $t \leq t_0$ , so that for some constant c,

$$\int \sup_{x \in [0,1]} A_2 dv \le c\delta_1 \int \sup_{(\tau,X) \in [0,t_0] \times [0,1]} f^{\#}(\tau,X,v) dv.$$
(3.7)

The terms  $A_3$  and  $A_4$  are treated similarly, with the change of variables  $s \to y = x + s(v_1 - v'_{*1})$ . Using (3.6)-(3.7) and similar bounds obtained for  $A_3$  and  $A_4$  in (3.6) leads to

$$\int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v)dv \leq \int \sup_{x\in[0,1]} f_0(x,v)dv + \frac{tcc_1'}{\delta_2} \int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v)dv + c_9\delta_1 \int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v)dv,$$

for some constant  $c_9$ . The choice of  $\delta_2$  and  $t_0$  are now made as given by Lemma 3.4 for  $\delta_1 = \frac{1}{2c_9}$ . And so,

$$\int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v)dv \le c \int \sup_{x} f_0(x,v)dv + \frac{tcc_1'}{\delta_2} \int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v)dv$$

for  $t \leq t_0$ . Since  $c'_1$  and  $t_0$  only depend on  $\int (1+|v|^2) f_0(x,v) dx dv$ , it follows that  $\int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v) dv$  is at most exponentially increasing,

$$\int \sup_{(s,x)\in[0,t]\times[0,1]} f^{\#}(s,x,v)dv \le c_1 e^{c_2 t},$$

where  $c_1$  and  $c_2$  only depend on  $\int (1+|v|^2)f_0(x,v)dxdv$ .

4 Proof of the main theorem and the asymptotic behavior.

The following two preliminary lemmas are needed for the control of large velocities.

Lemma 4.1

Given t > 0, there is a constant  $c_t > 0$  such that the solutions of (3.1) satisfy

$$\sup_{j\in\mathbb{N}^*}\int_0^1\int_{|v|>\lambda}|v|\sup_{s\leq t}f_j^\sharp(s,x,v)dvdx\leq \frac{c_t}{\lambda}.$$

Proof of Lemma 4.1.

For convenience j is dropped from the notation  $f_j$ . As in Section 3,

$$\sup_{s \le t} f^{\sharp}(s, x, v) \le f_0(x, v) + \int_0^t Q_j^+(f)(s, x + sv_1, v) ds.$$

Integration with respect to (x, v) for  $|v| > \lambda$ , gives

$$\int_{0}^{1} \int_{|v|>\lambda} |v| \sup_{s \le t} f^{\sharp}(s, x, v) dv dx \le \int \int_{|v|>\lambda} |v| f_{0}(x, v) dv dx + \int_{0}^{t} \int_{|v|>\lambda} B\chi_{j} |v| f(s, x + sv_{1}, v') f(s, x + sv_{1}, v'_{*}) F(f)(s, x + sv_{1}, v) F(f)(s, x + sv_{1}, v_{*}) dv dv_{*} d\omega dx ds.$$

Here in the last integral, either |v'| or  $|v'_*|$  is the largest and larger than  $\frac{\lambda}{\sqrt{2}}$ . The two cases are symmetric, and we discuss the case  $|v'| \ge |v'_*|$ . After a translation in x, estimate the integrand by  $c|v'|f^{\#}(s,x,v') \sup_{x\in[0,1],s\leq t} f^{\#}(s,x,v'_*)$ . The change of variables  $(v,v_*,\omega) \to (v',v'_*,-\omega)$ , the integration over  $(s,x,v,v_*,\omega) \in [0,t] \times [0,1] \times \{v \in \mathbb{R}^2; |v| > \frac{\lambda}{\sqrt{2}}\} \times \mathbb{R}^2 \times S^1$  and Lemma 3.5 give the bound

$$\frac{c}{\lambda} \Big( \int_0^t \int |v|^2 f^{\#}(s, x, v) dx dv ds \Big) \Big( \int \sup_{s \le t, x \in [0, 1]} f^{\#}(s, x, v_*) dv_* \Big) \le \frac{ct e^{c_2 t}}{\lambda} \int |v|^2 f_0(x, v) dx dv.$$

The lemma follows.

### Lemma 4.2

Given t > 0, there is a constant  $c'_t > 0$ , such that the solutions  $f_j$  of (3.1) satisfy

$$\sup_{j \in \mathbb{N}^*} \int_{|v| > \lambda} \sup_{(s,x) \in [0,t] \times [0,1]} f_j^{\sharp}(s,x,v) dv \le \frac{c'_t}{\sqrt{\lambda}}$$

<u>Proof of Lemma 4.2.</u> Take  $\lambda > 2$ . As previously,

$$\int_{|v|>\lambda} \sup_{(s,x)\in[0,t]\times[0,1]} f^{\sharp}(s,x,v)dv \le \int_{|v|>\lambda} \sup_{x\in[0,1]} f_0(x,v)dv + C,$$
(4.1)

where

$$C = c \int_{|v| > \lambda} \sup_{x \in [0,1]} \int_0^t \int B\chi_j f^{\#}(s, x + s(v_1 - v_1'), v') f^{\#}(s, x + s(v_1 - v_{*1}'), v_*') dv dv_* d\omega ds.$$

For  $v', v'_*$  outside of the angular cutoff, let n be the unit vector in the direction v - v', and  $n_{\perp}$  the orthogonal unit vector in the direction  $v - v'_*$ . Let  $e_1$  be a unit vector in the x-direction. Split C as  $C = \sum_{1 \le i \le 6} C_i$ , where  $C_1$  (resp.  $C_2, C_3$ ) refers to integrating on

$$\{(v_*,\omega); \quad n \cdot e_1 \ge \frac{1}{\sqrt{2}}, \quad |v'| \ge |v'_*|\},\$$

(resp. 
$$\{(v_*,\omega); n \cdot e_1 \ge \sqrt{1-\frac{1}{\lambda}}, |v'| \le |v'_*|\}, \{(v_*,\omega); n \cdot e_1 \in [\frac{1}{\sqrt{2}}, \sqrt{1-\frac{1}{\lambda}}], |v'| \le |v'_*|\}),$$

and similar definitions for  $C_i$ ,  $4 \le i \le 6$ , with *n* replaced by  $n_{\perp}$ . By symmetry,  $C_i$ ,  $4 \le i \le 6$  can be treated as  $C_i$ ,  $1 \le i \le 3$ , so we only discuss the control of  $C_i$ ,  $1 \le i \le 3$ . By the change of variables  $(v, v_*, \omega) \to (v', v'_*, -\omega)$  and noticing that  $|v'| \ge \frac{\lambda}{\sqrt{2}}$  in the domain of integration of  $C_1$ , it holds that

$$C_{1} \leq \int_{|v| > \frac{\lambda}{\sqrt{2}}} \sup_{x \in [0,1]} \int_{0}^{t} \int_{n \cdot e_{1} \geq \frac{1}{\sqrt{2}}} B\chi_{j} f^{\#}(s, x + s(v_{1}' - v_{1}), v) f^{\#}(s, x + s(v_{1}' - v_{*1}), v_{*}) dv_{*} d\omega ds dv$$
$$\leq \int_{|v| > \frac{\lambda}{\sqrt{2}}} \sup_{x \in [0,1]} \int_{0}^{t} \int_{n \cdot e_{1} \geq \frac{1}{\sqrt{2}}} B\chi_{j} \sup_{\tau \in [0,t]} f^{\#}(\tau, x + s(v_{1}' - v_{1}), v) \sup_{(\tau, X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_{*}) dv_{*} d\omega ds dv.$$

With the change of variables  $s \to y = x + s(v'_1 - v_1)$ ,

$$\begin{split} C_{1} &\leq \int_{|v| > \frac{\lambda}{\sqrt{2}}} \sup_{x \in [0,1]} \int_{n \cdot e_{1} \geq \frac{1}{\sqrt{2}}} \int_{y \in I(x,x+t(v_{1}'-v_{1}))} \frac{B\chi_{j}}{|v_{1}'-v_{1}|} \sup_{\tau \in [0,t]} f^{\#}(\tau,y,v) \sup_{(\tau,X) \in [0,t] \times [0,1]} f^{\#}(\tau,X,v_{*}) dy dv_{*} d\omega dv \\ &\leq \int_{|v| > \frac{\lambda}{\sqrt{2}}} \int_{n \cdot e_{1} \geq \frac{1}{\sqrt{2}}} \frac{E(t(v_{1}'-v_{1}))+1}{|v_{1}'-v_{1}|} \int_{0}^{1} B\chi_{j} \sup_{\tau \in [0,t]} f^{\#}(\tau,y,v) \sup_{(\tau,X) \in [0,t] \times [0,1]} f^{\#}(\tau,X,v_{*}) dy dv_{*} d\omega dv \\ &\leq c(t+1) \int_{0}^{1} \int_{|v| > \frac{\lambda}{\sqrt{2}}} \sup_{\tau \in [0,t]} f^{\#}(\tau,y,v) dy dv \int \sup_{(\tau,X) \in [0,t] \times [0,1]} f^{\#}(\tau,X,v_{*}) dv_{*} \\ &\leq \frac{c(t+1)}{\lambda} \int_{0}^{1} \int_{|v| > \frac{\lambda}{\sqrt{2}}} |v| \sup_{\tau \in [0,t]} f^{\#}(\tau,y,v) dy dv \int \sup_{(\tau,X) \in [0,t] \times [0,1]} f^{\#}(\tau,X,v_{*}) dv_{*}. \end{split}$$

By Lemma 3.5 and Lemma 4.1,

$$C_1 \le o(\frac{1}{\lambda})(t+1)c_1 e^{c_2 t}.$$

Moreover,

$$C_{2} \leq \int_{|v'|>\lambda, |v_{*}|>|v|, n \cdot e_{1} \geq \sqrt{1-\frac{1}{\lambda}}} \frac{\chi_{j}B}{|v'_{1}-v_{1}|} \sup_{x \in [0,1]} \int_{y \in I(x,x+t(v'_{1}-v_{1}))} \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v)$$

$$\sup_{\substack{(\tau,X) \in [0,t] \times [0,1]}} f^{\#}(\tau, X, v_{*}) dy dv dv_{*} d\omega$$

$$\leq c(t+1) \int_{n \cdot e_{1} \geq \sqrt{1-\frac{1}{\lambda}}} d\omega \int \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v) dy dv \int \sup_{(\tau,X) \in [0,t] \times [0,1]} f^{\#}(\tau, X, v_{*}) dv_{*} \leq \frac{c(t+1)}{\sqrt{\lambda}},$$

by Lemma 3.3 and Lemma 3.5. Finally,

$$C_{3} \leq \int_{|v_{*}| > \frac{\lambda}{\sqrt{2}}, \frac{1}{\sqrt{\lambda}} \leq n_{\perp} \cdot e_{1} \leq \frac{1}{\sqrt{2}}} \sup_{(\tau, X) \in [0, t] \times [0, 1]} f^{\#}(\tau, X, v) \frac{\chi_{j}B}{|v_{1}' - v_{*1}|}$$

$$\sup_{x \in [0, 1]} \left( \int_{y \in I(x, x + t(v_{1}' - v_{*1}))} \sup_{\tau \in [0, t]} f^{\#}(\tau, y, v_{*}) dy \right) dv dv_{*} d\omega$$

$$\leq c(t+1) \sqrt{\lambda} \left( \int \sup_{(\tau, X) \in [0, t] \times [0, 1]} f^{\#}(\tau, X, v) dv \right) \left( \int_{|v_{*}| > \frac{\lambda}{\sqrt{2}}} \sup_{\tau \in [0, t]} f^{\#}(\tau, y, v_{*}) dy dv_{*} \right).$$

By Lemma 3.5,

$$C_3 \le c(t+1)\sqrt{\lambda} \int_{|v_*| > \frac{\lambda}{\sqrt{2}}} \sup_{\tau \in [0,t]} f^{\#}(\tau, y, v_*) dy dv_*,$$

and so by Lemma 4.1,

$$C_3 \le c(t+1)\sqrt{\lambda}\frac{c_T}{\lambda}$$

The lemma follows.

Using the previous lemmas, the results in Section 3, and an initial layer analysis, the main result of the paper follows.

#### Proof of Theorem 2.1

For any T > 0, we shall prove the convergence in  $C([0,T]; L^1([0,T] \times \mathbb{R}^2))$  of the sequence  $(f_j)$  to a solution f of (2.5). Denote by

$$\tilde{\nu}_j(f) := \int B\chi_j f' f'_* F_j(f_*) dv_* d\omega, \quad \nu_j(f) := \int B\chi_j f_* F_j(f') F_j(f'_*) dv_* d\omega,$$

so that

$$Q_j(f) = F_j(f)\tilde{\nu}_j(f) - f\nu_j(f).$$

Consider

$$\nu_j(f_j)^{\sharp}(t,x,v) = \int B\chi_j f(t,x+tv_1,v_*) F_j(f(t,x+tv_1,v')) F_j(f(t,x+tv_1,v'_*)) dv_* d\omega.$$

It follows from Lemma 3.5 that for  $\omega$  outside the integration cut-off, the measure of the set

$$Z_{(j,t,x,v,\omega)} := \{v_*; f(t,x+tv_1,v') > \frac{1}{2} \quad \text{or} \quad f(t,x+tv_1,v'_*) > \frac{1}{2}\}$$
(4.2)

is uniformly bounded with respect to  $(x, v, \omega), t \leq T$ , and  $j \in \mathbb{N}^*$ . Take  $j_T$  so large that  $\pi j_T^2$  is at least eight times this uniform bound. Notice that here  $j_T$  only depends on T and  $\int (1+v^2)f_0(x,v)dxdv$ . Using the exponential form for the solution, one gets using Lemma 3.5 that

$$f_j^{\sharp}(t, x, v_*) \ge c'_T f_0(x, v_*) > 0, \quad j \ge j_T, \quad t \le T,$$

with  $c'_T$  independent of  $j \ge j_T$ . It follows that

$$\nu_j(f_j)^{\sharp}(t, x, v) > c_{2T} > 0, \quad (t, x, v) \in [0, T] \times [0, 1] \times \{v \in \mathbb{R}^2; |v| \le j\},$$
(4.3)

uniformly with respect to  $j \ge j_T$ , and with  $c_{2T}$  only depending on T and  $f_0$ .

Moreover, using the  $v_* \to v'$  change of variables on half the unit circle and  $v_* \to v'_*$  on the other half unit circle, together with Lemma 3.5, one obtains that for some constant  $\tilde{c}_T > 0$ ,

$$\tilde{\nu}_j^{\sharp}(f_j)(t, x, v) \le \tilde{c}_T, \quad j \ge j_T, \quad (t, x, v) \in [0, T] \times [0, 1] \times \{v \in \mathbb{R}^2; |v| \le j\}.$$

The functions defined on  $]0, \frac{1}{\alpha}]$  by  $x \to \frac{F_j(x)}{x}$  are uniformly bounded with respect to j by  $x \to \alpha^{\alpha-1}\frac{(1-\alpha x)^{\alpha}}{x}$ , that is continuous and decreasing to zero at  $x = \frac{1}{\alpha}$ . Hence there is  $\mu \in ]0, \frac{1}{\alpha}[$  such that

$$x \in \left[\frac{1}{\alpha} - \mu, \frac{1}{\alpha}\right]$$
 implies  $\frac{F_j(x)}{x} < \frac{c_{2T}}{2\tilde{c}_T}, \quad j \ge j_T$ 

Consequently, for  $j \geq j_T$ ,

$$\begin{aligned} f_{j}^{\sharp}(t,x,v) \in &]\frac{1}{\alpha} - \mu, \frac{1}{\alpha}] \quad \Rightarrow \quad D_{t}f_{j}^{\sharp}(t,x,v) = \left(F_{j}(f_{j}^{\sharp})\tilde{\nu}_{j}^{\sharp} - \frac{1}{2}f_{j}^{\sharp}\nu_{j}^{\sharp}(t,x,v) - \frac{1}{2}f_{j}^{\sharp}\nu_{j}^{\sharp}(t,x,v) \\ &< -\frac{1}{2}f_{j}^{\sharp}\nu_{j}^{\sharp}(t,x,v) \\ &< -\frac{1}{2}(\frac{1}{\alpha} - \gamma)c_{2T} := -b_{1}. \end{aligned}$$

This gives a maximum time  $t_1 = \frac{\gamma}{b_1}$  for  $f_j^{\#}$  to reach  $\frac{1}{\alpha} - \mu$  from an initial value  $f_0(x, v) \in ]\frac{1}{\alpha} - \mu, \frac{1}{\alpha}]$ . On this time interval  $D_t f_j^{\sharp} \leq -b_1$ . If  $t_1 \geq T$ , then at t = T the value of  $f_j^{\#}$  is bounded from above by  $\frac{1}{\alpha} - b_1 T := \frac{1}{\alpha} - \mu'$  with  $0 < \mu' \leq \mu$ . Take  $t_m = \min(t_1, T)$ , and from now on  $\mu = t_m b_1$ . For any (x, v), if  $f_j(0, x, v) < \frac{1}{\alpha} - \mu$  were to reach  $\frac{1}{\alpha} - \mu$  at (t, x, v) with  $t \leq t_m$ , then  $D_t f_j^{\#}(t, x, v) \leq -b_1$ , which excludes such a possibility. It follows that  $f_j \leq \frac{1}{\alpha} - \mu$  everywhere for  $t \in [t_m, T]$ . The previous estimates leading to the definition of  $t_m$  are independent of  $j \geq j_T$ .

Let us prove that  $(f_j)$  converges when  $j \to \infty$ . We shall prove that given  $\beta > 0$ , there exists  $a \ge max\{1, j_T\}$ , so that

$$\sup_{[0,T]} \int |g_j(t,x,p)| dx dv < \beta, \quad j > a,$$

$$\tag{4.4}$$

where  $g_j = f_j - f_a$ . The function  $g_j$  satisfies the equation

$$\partial_{t}g_{j} + p_{1}\partial_{x}g_{j} = \int (\chi_{j} - \chi_{a})B\left(f_{j}'f_{j*}'F_{j}(f_{j})F_{j}(f_{j*}) - f_{j}f_{j*}F_{j}(f_{j}')F_{j}(f_{j*})\right)dv_{*}d\omega + \int \chi_{a}B(f_{j}'f_{j*}' - f_{a}'f_{a*}')F_{j}(f_{j})F_{j}(f_{j*})dv_{*}d\omega - \int \chi_{a}B(f_{j}f_{j*} - f_{a}f_{a*})F_{j}(f_{j}')F_{j}(f_{j*}')dv_{*}d\omega + \int \chi_{a}Bf_{a}'f_{a*}'\left(F_{j}(f_{j*})\left(F_{j}(f_{j}) - F_{j}(f_{a})\right) + F_{a}(f_{a})\left(F_{j}(f_{j*}) - F_{j}(f_{a*})\right)\right)dv_{*}d\omega + \int \chi_{a}Bf_{a}'f_{a*}'\left(F_{j}(f_{j*})\left(F_{j}(f_{a}) - F_{a}(f_{a})\right) + F_{a}(f_{a})\left(F_{j}(f_{a*}) - F_{a}(f_{a*})\right)\right)dv_{*}d\omega - \int \chi_{a}Bf_{a}f_{a*}\left(F_{j}(f_{j*}')\left(F_{j}(f_{j}') - F_{j}(f_{a}')\right) + F_{a}(f_{a}')\left(F_{j}(f_{j*}') - F_{j}(f_{a*}')\right)\right)dv_{*}d\omega - \int \chi_{a}Bf_{a}f_{a*}\left(F_{j}(f_{j*}')\left(F_{j}(f_{a}') - F_{a}(f_{a}')\right) + F_{a}(f_{a}')\left(F_{j}(f_{a*}') - F_{a}(f_{a*}')\right)\right)dv_{*}d\omega.$$
(4.5)

Moreover,

$$\int (\chi_j - \chi_a) B\Big(f'_j f'_{j*} F_j(f_j) F_j(f_{j*}) + f_j f_{j*} F_j(f'_j) F_j(f'_{j*})\Big) dx dv dv_* d\omega \leq c \int_{|v| > \frac{a}{\sqrt{2}}} f_j(t, x, v) dx dv dv_* d\omega$$
$$\leq \frac{c}{a^2} \text{ by the conservation of energy of } f_j,$$

$$\int \chi_a B |f_j f_{j*} - f_a f_{a*}| F_j(f'_j) F_j(f'_{j*}) dx dv dv_* d\omega \leq c \Big( \int \sup_{(t,x) \in [0,T] \times [0,1]} f_j^{\sharp}(t,x,v) dv + \int \sup_{(t,x) \in [0,T] \times [0,1]} f_a^{\sharp}(t,x,v) dv \Big) \int |(f_j^{\sharp} - f_a^{\sharp})(t,x,v)| dx dv \leq c \int |(f_j^{\sharp} - f_a^{\sharp})(t,x,v)| dx dv \quad \text{by Lemma 3.5.}$$

Next

$$\int \chi_a B\Big(f'_a f'_{a*} F_j(f_{j*}) |F_j(f_a) - F_a(f_a)|\Big)^{\sharp} dx dv dv_* d\omega = \int \chi_a B\Big(f'_a f'_{a*} F_j(f_{j*})(1 - \alpha f_a) |(\frac{1}{j} + 1 - \alpha f_a)^{\alpha - 1} - (\frac{1}{a} + 1 - \alpha f_a)^{\alpha - 1} |(1 + (1 - \alpha) f_a)^{1 - \alpha} dx dv dv_* d\omega |f_a|^{\alpha - 1} + 1 - \alpha f_a)^{\alpha - 1} |(1 + (1 - \alpha) f_a)^{1 - \alpha} dx dv dv_* d\omega |f_a|^{\alpha - 1} + 1 - \alpha f_a)^{\alpha - 1} |(1 + (1 - \alpha) f_a)^{1 - \alpha} dx dv dv_* d\omega |f_a|^{\alpha - 1} + 1 - \alpha f_a)^{\alpha - 1} |(1 + (1 - \alpha) f_a)^{\alpha - 1} |(1 + (1 - \alpha) f_a)^{\alpha - 1} |f_a|^{\alpha - 1} + 1 - \alpha f_a)^{\alpha - 1} |f_a|^{\alpha - 1} + 1 - \alpha f_a)^{\alpha - 1} |f_a|^{\alpha - 1} |f_a|^{\alpha$$

By Lemma 3.3 and Lemma 3.5, this integral restricted to the set where  $1 - \alpha f_a(t, x, v) \leq \frac{2}{a}$ , is bounded by  $C\frac{1}{a^{\alpha}}$ . For the remaining domain of integration where  $1 - \alpha f_a(t, x, v) \geq \frac{2}{a}$ , it holds  $|F_j(f_a) - F_a(f_a)| \leq C(1 - \alpha f_a)^{\alpha} |(\frac{1}{j(1 - \alpha f_a)} + 1)^{\alpha - 1} - (\frac{1}{a(1 - \alpha f_a)} + 1)^{\alpha - 1}| \leq \frac{C}{a^{\alpha}}$ . And so the integral restricted to this set is also bounded by  $C\frac{1}{a^{\alpha}}$ . Finally

$$\int \chi_a B\Big(f'_a f'_{a*} F_j(f_{j*}) |F_j(f_j) - F_j(f_a)|\Big)^{\sharp}(t, x, v) dx dv dv_* d\omega \le c \int |F_j(f_j) - F_j(f_a)|^{\sharp}(t, x, v) dx dv.$$

Split the (x, v)-domain of integration of the latest integral into

$$A_{1} := \{(x,v); (f_{j}^{\sharp}(t,x,v), f_{a}^{\sharp}(t,x,v)) \in [0, \frac{1}{\alpha} - \mu]^{2} \},$$

$$A_{2} := \{(x,v); (f_{j}^{\sharp}(t,x,v), f_{a}^{\sharp}(t,x,v)) \in [\frac{1}{\alpha} - \mu, \frac{1}{\alpha}]^{2} \},$$

$$A_{3} := \{(x,v); f_{j}^{\sharp}(t,x,v) \in [\frac{1}{\alpha} - \mu, \frac{1}{\alpha}], f_{a}^{\sharp}(t,x,v)) \in [0, \frac{1}{\alpha} - \mu] \},$$

$$A_{3}' := \{(x,v); f_{a}^{\sharp}(t,x,v) \in [\frac{1}{\alpha} - \mu, \frac{1}{\alpha}], f_{j}^{\sharp}(t,x,v)) \in [0, \frac{1}{\alpha} - \mu] \}.$$

It holds that

$$\begin{split} &\int_{A_1} |F_j(f_j) - F_j(f_a)|^{\sharp}(t, x, v) dx dv \le c(\alpha \mu)^{\alpha - 1} \int_{A_1} |g_j^{\sharp}(t, x, v)| dx dv, \\ &\int_{A_2} |F_j(f_j) - F_j(f_a)|^{\sharp}(t, x, v) dx dv \le ct^{\alpha - 1} \int_{A_2} |g_j^{\sharp}(t, x, v)| dx dv, \\ &\int_{A_3} |F_j(f_j) - F_j(f_a)|^{\sharp}(t, x, v) dx dv \le c \left((\alpha \mu)^{\alpha - 1} + t^{\alpha - 1}\right) \int_{A_3} |g_j^{\sharp}(t, x, v)| dx dv \end{split}$$

The remaining terms in (4.5) are of the same types as the ones just estimated. Consequently,

$$\frac{d}{dt}\int |g_j^{\sharp}(t,x,v)|dxdv \leq \frac{c}{a^{\frac{\alpha}{2}}} + c(1+t^{\alpha-1})\Big(\int |g_j^{\sharp}(t,x,v)|dxdv\Big).$$

And so,

$$\int |g_j^{\sharp}(t,x,v)| dx dv \leq \Big(\int_{|v|>a} f_0(x,v) dx dv + \frac{cT}{a^{\frac{\alpha}{2}}}\Big) e^{c(T+\frac{T^{\alpha}}{\alpha})},$$

which tends to zero when  $a \to +\infty$ , uniformly w.r.t.  $j \ge a$ . This ends the proof of the existence of a solution f to (2.5).

One can similarly prove that the solution is unique and stable. The energy is non-increasing. The conservation of mass and first momentum of f follow from the boundedness of the total energy.

Energy conservation will follow if the energy is non-decreasing. Taking  $\psi_{\epsilon} = \frac{|v^2|}{1+\epsilon|v|^2}$  as approximation for  $|v|^2$ , it is enough to bound

$$\int Q(f, f(t, x, v)\psi_{\epsilon} dx dv = \int B\psi_{\epsilon} \Big( f'f'_*F(f)F(f_*) - ff_*F(f')F(f'_*) \Big) dx dv dv_* d\omega$$

from below by zero in the limit  $\epsilon \to 0$ . Now [13]

$$\int Q(f,f)\psi_{\epsilon}dxdv = \frac{1}{2}\int Bff_{*}F(f')F(f'_{*}\Big(\psi_{\epsilon}(v') + \psi_{\epsilon}(v'_{*}) - \psi_{\epsilon}(v) - \psi_{\epsilon}(v_{*})\Big)dxdvdv_{*}d\omega$$
$$\geq -\int Bff_{*}F(f')F(f'_{*})\frac{\epsilon|v|^{2}|v_{*}|^{2}}{(1+\epsilon|v|^{2})(1+\epsilon|v_{*}|^{2})}dxdvdv_{*}d\omega.$$

The previous line, with the integral taken over a bounded set in  $(v, v_*)$ , converges to zero when  $\epsilon \to 0$ . In integrating over  $|v|^2 + |v_*|^2 \ge 2\lambda^2$ , there is symmetry between the subset of the domain with  $|v|^2 > \lambda^2$  and the one with  $|v_*|^2 > \lambda^2$ . We discuss the first sub-domain, for which the integral in the last line is bounded from below by

It follows from Lemma 4.2 that the right hand side tends to zero when  $\lambda \to \infty$ . This implies that the energy is non-decreasing, and bounded from below by its initial value. That completes the proof of the theorem.

An entropy connected to (1.3) is  $\int s(f) dx dv$ , where

$$s(f) := f \log f + (\frac{1}{\alpha} - f) \log(1 - \alpha f)^{\alpha} - (\frac{1}{1 - \alpha} + f) \log(1 + (1 - \alpha)f)^{1 - \alpha}.$$

**Proposition 4.3** The solution f to (2.5) has a long-time equilibrium limit  $\lim_{t\to\infty} f(t, x, v) = f_{\infty}(v)$  in  $L^1([0,1] \times \mathbb{R}^2)$  that is an anyon equilibrium distribution of type (1.2) with the same mass, first v-moments, and energy as  $f_0$ .

 $\frac{\text{Proof of Propostion 4.3.}}{\text{Writing the equation (2.4) in mild form gives}}$ 

$$\int |f^{\#}(t+h) - f^{\#}(t)| dx dv = \int |\int_{t}^{t+h} Q(f)^{\#} ds| dx dv \leq 2 \int_{t}^{t+h} ds \int_{0}^{1} dx \int dv dv_{*} d\omega Bf f_{*}F(f')F(f'_{*}) \\ \leq c \int \int_{t}^{t+h} ds \int_{0}^{1} dx \int dv dv_{*} d\omega |v-v_{*}|^{2} Bf f_{*}F(f')F(f'_{*}) \to 0, \qquad t \to \infty,$$

where Lemma 3.2 was used in the last step. This proves the convergence of f(t) when  $t \to \infty$  to a limit  $f_{\infty}$  with the same mass and first *v*-moments as  $f_0$ . Energy is conserved by the earlier argument. Also  $f_{\infty}$  is a solution to (2.5) with collision operator zero, hence dose not depend on *x*.

The solution f of Theorems 2.1 has its range in  $]0, \frac{1}{\alpha}]$  and conserve mass and energy. This implies that  $f \log f(t, ., .) \in L^1([0, 1] \times \mathbb{R}^2)$  with  $\int f(t, x, v) \log f(t, x, v) dx dv$  uniformly bounded in time. A simple computation shows that

$$f\log f + f\log\alpha \le f\log f + (\frac{1}{\alpha} - f)\log(1 - \alpha f)^{\alpha}$$
$$-(\frac{1}{1 - \alpha} + f)\log(1 + (1 - \alpha)f)^{1 - \alpha} \le f\log f.$$

And so the entropy  $\int s(f)(t, x, v) dx dv$  of f is uniformly bounded in time. The entropy-entropy dissipation equation holds,

$$\int s(f)(t) = \int s(f_0) - \frac{1}{4} \int ds \int BF(f)F(f_*)F(f')F(f'_*)(\frac{f'f'_*}{F(f')F('_*)}) \\ -\frac{ff_*}{F(f)F(f_*)})(\log \frac{f'f'_*}{F(f')F('_*)} \log \frac{ff_*}{F(f)F(*)})$$

with the entropy dissipation integral convergent on  $[0, \infty[\times[0,1] \times \mathbb{R}^2]$ . This implies for the limit  $f_{\infty}$  that  $\frac{f_{\infty}}{F(f_{\infty})} = e^{-\frac{(v-v_o)^2 - \mu}{T}}$ , which can be written  $f_{\infty} = (w(e^{\frac{(v-v_o)^2 - \mu}{T}}) + \alpha)^{-1}$  with  $w(\zeta)^{\alpha}(1 + w(\zeta))^{1-\alpha} = \zeta \equiv e^{\frac{(v-v_o)^2 - \mu}{T}}$ . That is the equilibrium equation for anyons [19]. And so  $f_{\infty}$  is an equilibrium solution for anyons.
