ON SOME METABELIAN 2-GROUP WHOSE ABELIANIZATION IS OF TYPE (2,2,2) AND APPLICATIONS

ABSTRACT. Let G be some metabelian 2-group satisfying the condition $G/G' \simeq \mathbb{Z}/2\mathbb{Z} \times \mathbb{Z}/2\mathbb{Z} \times \mathbb{Z}/2\mathbb{Z}$. In this paper, we construct all the subgroups of G of index 2 or 4, we give the abelianization types of these subgroups and we compute the kernel of the transfer map. Then we apply these results to study the capitulation problem of the 2-ideal classes of some fields **k** satisfying the condition $Gal(\mathbf{k}_2^{(2)}/\mathbf{k}) \simeq G$, where $\mathbf{k}_2^{(2)}$ is the second Hilbert 2-class field of **k**.

1. INTRODUCTION

Let G be a group and let G' = [G, G] be its *derived group*, that is the subgroup of G generated by the commutators $[x, y] = x^{-1}y^{-1}xy$, where x and y are in G. Let $\gamma_i(G)$ be the i-th term of the lower central series of G defined inductively by $\gamma_1(G) = G$ and $\gamma_{i+1}(G) = [\gamma_i(G), G]$. The group G is said to be *nilpotent* if there exists a positive integer c such that $\gamma_{c+1}(G) = 1$; the smallest integer c satisfying this equality is called the *nilpotency class* of G; if the order of G is p^h , where p is a prime, then the number cc(G) = h - cis called the coclass of G. It is well known that a p-group G is nilpotent. Recall that a group G is said to be *metabelian* if its derived group G' is abelian. Finally, a subgroup H of a group G, not reduced to an element, is called maximal if it is the unique subgroup of G distinct from G containing H.

Consider the group family defined, for any integer $n \ge 1$, as follows

$$G_n = \langle \sigma, \tau, \rho : \rho^4 = \sigma^8 = \tau^{2^{n+2}} = 1, \sigma^4 = \tau^{2^{n+1}}, \rho^2 = \tau^{2^n} \sigma^2,$$

[\tau, \sigma] = 1, [\rho, \sigma] = \sigma^{-2}, [\rho, \tau] = \tau^2 \rangle. (1)

In this paper, we construct all the subgroups of G_n of index 2 or 4, we give the abelianization types of these subgroups and we compute the kernel of the transfer map $V_{G\to H} : G_n/G'_n \to H/H'$, for any subgroup H of

 G_n , defined by the Artin map. Then we apply these results to study the capitulation problem of the 2-ideal classes of some fields **k** satisfying the condition $\operatorname{Gal}(\mathbf{k}_2^{(2)}/\mathbf{k}) \simeq G_n$, where $\mathbf{k}_2^{(2)}$ is the second Hilbert 2-class field of **k**. Finally, we illustrate our results by an example about an imaginary bicyclic biquadratic field.

2. Results

Recall first that if x, y and z are elements of some group G, then we easily show that:

$$[xy, z] = [x, z]^{y}[y, z]$$
 and
 $[x, yz] = [x, z][x, y]^{z},$
where $x^{y} = y^{-1}xy.$

Let G_n be the group family defined by the Equality (1). Since $[\tau, \sigma] = 1$, $[\rho, \sigma] = \sigma^{-2}$ and $[\rho, \tau] = \tau^2$, so $G'_n = \langle \sigma^2, \tau^2 \rangle$, which is abelian. Then G_n is metabelian and $G_n/G'_n \simeq (2, 2, 2)$, since $\rho^2 = \tau^{2^n} \sigma^2$. Hence G_n admits seven subgroups of index 2, denote them by $H_{i,2}$, and seven subgroups of index 4, denote them by $H_{i,4}$, where $1 \leq i \leq 7$. These subgroups, their derived groups and their abelianizations are given in the Tables 1 and 2.

To check the Tables entries we need the following lemma.

Lemma 1. Let $G_n = \langle \sigma, \tau, \rho \rangle$ denote the group defined above, then

- 1. $\rho^{-1}\sigma\rho = \sigma^{3}$. 2. $\rho^{-1}\tau\rho = \tau^{-1}$. 3. ρ^{2} commutes with σ and τ . 4. $(\tau\rho)^{2} = \rho^{2}$. 5. $(\sigma\tau\rho)^{2} = (\sigma\rho)^{2} = \rho^{2}\sigma^{4}$. 6. For all $\pi \in \mathbb{N}$, $[\sigma - 2^{r}] = -2^{r+1}$ and
 - 6. For all $r \in \mathbb{N}$, $[\rho, \tau^{2^r}] = \tau^{2^{r+1}}$ and $[\rho, \sigma^{2^r}] = \sigma^{-2^{r+1}}$.

Proof. 1. and 2. are obvious, since $[\rho, \sigma] = \sigma^{-2}$ and $[\rho, \tau] = \tau^2$. 3. As $\rho^2 = \tau^{2^n} \sigma^2$, so $\rho^2 \in \langle \tau, \sigma \rangle$, which is an abelian group, because $[\tau, \sigma] = 1$. Hence the result.

4. $(\tau \rho)^2 = \tau \rho \tau \rho = \tau \rho^2 \rho^{-1} \tau \rho = \tau \rho^2 \tau^{-1} = \rho^2.$

5. We proceed as in 4. to prove these results.

6. Since $[\rho, \tau] = \tau^2$, so $[\rho, \tau^2] = \tau^4$. By induction, we show that for all $r \in \mathbb{N}^*$, $[\rho, \tau^{2^r}] = \tau^{2^{r+1}}$. Similarly, we prove that $[\rho, \sigma^{2^r}] = \sigma^{2^{r+1}}$.

Let us now prove some entries of the Tables 1 and 2, using the Lemma 1. • For $H_{1,2} = \langle \sigma, \tau, G'_n \rangle = \langle \sigma, \tau \rangle$, we have $H'_{1,2} = \langle 1 \rangle$, since $[\sigma,\tau] = 1$. As $\sigma^8 = \tau^{2^{n+2}} = 1$ and $\sigma^4 = \tau^{2^{n+1}}$, so $H_{1,2}/H'_{1,2} \simeq \left(2^{\min(2,n+1)}, 2^{\max(3,n+2)}\right) = (2^2, 2^{n+2}).$

• For $H_{2,2} = \langle \sigma, \rho, G'_n \rangle = \langle \sigma, \rho, \tau^2, \sigma^2 \rangle = \langle \sigma, \rho, \tau^2 \rangle$. If n = 1, then $\rho^2 = \tau^2 \sigma^2$, hence $H_{2,2} = \langle \sigma, \rho \rangle$. Therefore $H'_{2,2} = \langle \sigma^2 \rangle$ and $H_{2,2}/H'_{2,2} \simeq (2,4)$. If $n \ge 2$, then $H_{2,2} = \langle \sigma, \rho, \tau^2 \rangle$. Therefore $H'_{2,2} = \langle \sigma^2, \tau^4 \rangle$ and $H_{2,2}/H'_{2,2} \simeq (2,2,2)$. • For $H_{1,4} = \langle \sigma, G'_n \rangle = \langle \sigma, \sigma^2, \tau^2 \rangle = \langle \sigma, \tau^2 \rangle$, we have $H'_{1,4} = \langle 1 \rangle$, since $[\sigma, \tau] =$ 1. As $\sigma^8 = \tau^{2^{n+2}} = 1$ and $\sigma^4 = \tau^{2^{n+1}}$, so $H_{1,4}/H'_{1,4} \simeq (2^{\min(2,n)}, 2^{\max(3,n+1)})$. • For $H_{2,4} = \langle \tau, G'_n \rangle = \langle \tau, \tau^2, \sigma^2 \rangle = \langle \tau, \sigma^2 \rangle$, we have $H'_{2,4} = \langle 1 \rangle$, hence $H_{2,4}/H'_{2,4} \simeq \left(2^{\min(1,n+1)}, 2^{\max(2n+2)}\right) = (2, 2^{n+2}).$ The other entries are checked similarly.

Proposition 2. Let G_n be the group family defined by the Equality (1), then

- 1. The order of G_n is 2^{n+5} and that of G'_n is 2^{n+2} .
- 2. The coclass of G_n is 3 and its nilpotency class is n+2.

Proof. 1. Since $\sigma^8 = \tau^{2^{n+2}} = 1$ and $\sigma^4 = \tau^{2^{n+1}}$, then

$$\langle \sigma, \tau \rangle \simeq \left(2^{\min(2,n+1)}, 2^{\max(3,n+2)} \right) = \left(2^2, 2^{n+2} \right).$$

Moreover, as $\rho^2 = \tau^{2^n} \sigma^2$ and $\rho^4 = \sigma^8 = \tau^{2^{n+2}} = 1$, so

$$\langle \sigma, \tau, \rho \rangle \simeq \left(2^2, 2^{n+2}, 2\right)$$

Thus $|G_n| = 2^{n+5}$. Similarly, we prove that $|G'_n| = 2^{n+2}$, since $G'_n = \langle \sigma^2, \tau^2 \rangle$.

2. The lower central series of G_n is defined inductively by $\gamma_1(G_n) = G_n$ and $\gamma_{i+1}(G_n) = [\gamma_i(G_n), G_n]$, that is the subgroup of G_n generated by the set $\{[a, b] = a^{-1}b^{-1}ab/a \in \gamma_i(G_n), b \in G_n\}$, so the coclass of G_n is defined to be $cc(G_n) = h - c$, where $|G_n| = 2^h$ and $c = c(G_n)$ is the nilpotency class of G_n . We easily get

 $\begin{aligned} \gamma_1(G) &= G.\\ \gamma_2(G) &= G' = \langle \sigma^2, \tau^2 \rangle.\\ \gamma_3(G) &= [G', G] = \langle \sigma^4, \tau^4 \rangle. \end{aligned}$

Then Lemma 1(6) yields that $\gamma_{j+1}(G) = [\gamma_j(G), G] = \langle \sigma^{2^j}, \tau^{2^j} \rangle$. Hence, if we put $v = \max(n+1, 2) = n+1$, then we get $\gamma_{j+1}(G) = \langle \sigma^{2^{j+1}}, \tau^{2^{j+1}} \rangle = \langle 1 \rangle$

put $v = \max(n+1,2) = n+1$, then we get $\gamma_{v+2}(G) = \langle \sigma^{2^{v+1}}, \tau^{2^{v+1}} \rangle = \langle 1 \rangle$ and $\gamma_{v+1}(G) = \langle \sigma^{2^v}, \tau^{2^v} \rangle \neq \langle 1 \rangle$. As $|G| = 2^{n+5}$, so

$$c(G) = n + 2$$
 and $cc(G) = n + 5 - (n + 2) = 3$.

We contenue with the following results.

Proposition 3 ([8]). Let H be a normal subgroup of G_n . For $g \in G_n$, put $f = [\langle g \rangle . H : H]$ and let $\{x_1, x_2, \ldots, x_t\}$ be a set of representatives of $G/\langle g \rangle H$. The transfer map $V_{G \to H} : G/G' \to H/H'$ is given by the following formula

$$V_{G \to H}(gG') = \prod_{i=1}^{t} x_i^{-1} g^f x_i . H'.$$
(2)

Easily, we prove the following corollaries.

Corollary 4. Let H be a subgroup of G_n of index 2. If $G_n/H = \{1, zH\}$, then $V_{G \to H}(gG'_n) = \begin{cases} gz^{-1}gz.H' = g^2[g, z].H' & \text{if } g \in H, \\ g^2.H' & \text{if } g \notin H. \end{cases}$

Corollary 5. Let H be a normal subgroup of G_n of index 4. If $G_n/H = \{1, zH, z^2H, z^3H\}$, then

$$V_{G \to H}(gG'_n) = \begin{cases} gz^{-1}gz^{-1}gz^{-1}gz^3.H' & \text{if } g \in H, \\ g^4.H' & \text{if } gH = zH, \\ g^2z^{-1}g^2z.H' & \text{if } g \notin H \text{ and } gH \neq zH. \end{cases}$$

Corollary 6. Let H be a normal subgroup of G_n of index 4. If $G_n/H = \{1, z_1H, z_2H, z_3H\}$ with $z_3 = z_1z_2$, then

$$\mathcal{V}_{G \to H}(gG'_n) = \begin{cases} gz_1^{-1}gz_1z_2^{-1}gz_1^{-1}gz_1z_2.H' & \text{if } g \in H, \\ g^2z_i^{-1}g^2z_i.H' & \text{if } gH = z_jH \text{ with } i \neq j. \end{cases}$$

Theorem 7. Keep the previous notations. Then we have:

1. $\ker V_{G_n \to H_{1,2}} = \langle \tau G'_n \rangle.$ 2. $\ker V_{G_n \to H_{2,2}} = \begin{cases} \langle \sigma G'_n, \rho G'_n \rangle & \text{if } n = 1. \\ \langle \sigma G'_n, \tau \rho G'_n \rangle & \text{if } n \ge 2. \end{cases}$ 3. $\ker V_{G_n \to H_{3,2}} = \langle \tau G'_n, \rho G'_n \rangle.$ 4. $\ker V_{G_n \to H_{4,2}} = \begin{cases} \langle \tau \rho G'_n, \sigma \rho G'_n \rangle & \text{if } n = 1. \\ \langle \sigma \tau G'_n, \rho G'_n \rangle & \text{if } n \ge 2. \end{cases}$ 5. $\ker V_{G_n \to H_{5,2}} = \langle \tau G'_n, \sigma \rho G'_n \rangle.$ 6. $\ker V_{G_n \to H_{6,2}} = \begin{cases} \langle \sigma G'_n, \tau \rho G'_n \rangle & \text{if } n = 1. \\ \langle \rho G'_n, \sigma G'_n \rangle & \text{if } n \ge 2. \end{cases}$ 7. $\ker V_{G_n \to H_{7,2}} = \begin{cases} \langle \sigma \tau G'_n, \rho G'_n \rangle & \text{if } n = 1. \\ \langle \sigma \tau G'_n, \tau \rho G'_n \rangle & \text{if } n \ge 2. \end{cases}$ 8. For all $1 \le i \le 7$, $\ker V_{G_n \to H_{i,4}} = G_n/G'_n.$

Proof. We prove only some assertions of the theorem. 1. We know, from the Table 1, that $H_{1,2} = \langle \sigma, \tau \rangle$, then $G_n/H_{1,2} = \{1, \rho H_{1,2}\}$ and $H'_{1,2} = \langle 1 \rangle$. Hence, by Corollary 4 and Lemma 1, we get

Therefore ker $V_{G_n \to H_{1,2}} = \langle \tau G'_n \rangle$.

8. We know, from the Table 2, that $H_{1,4} = \langle \sigma, \tau^2 \rangle$, then $G_n/H_{1,4} = \{1, \tau H_{1,4}, \rho H_{1,4}, \tau \rho H_{1,4}\}$ and $H'_{1,4} = \langle 1 \rangle$. Hence Corollary 6 and Lemma 1 yield that

*
$$V_{G_n \to H_{1,4}}(\sigma G'_n) = \sigma^8 H'_{1,4} = H'_{1,4}.$$

* $V_{G_n \to H_{1,4}}(\tau G'_n) = \tau^2 \rho^{-1} \tau^2 \rho H'_{1,4} = H'_{1,4}.$
* $V_{G_n \to H_{1,4}}(\rho G'_n) = \rho^4 H'_{1,4} = H'_{1,4}.$

Therefore ker $V_{G_n \to H_{1,4}} = \langle \sigma G'_n, \tau G'_n, \rho G'_n \rangle$. The other assertions are proved similarly.

3. Applications

Let \mathbf{k} be a number field and $C_{\mathbf{k},2}$ be its 2-class group, that is the 2-Sylow subgroup of the ideal class group $C_{\mathbf{k}}$ of \mathbf{k} , in the wide sens. Let $\mathbf{k}_{2}^{(1)}$ be the Hilbert 2-class field of \mathbf{k} in the wide sens. Then the Hilbert 2-class field tower of \mathbf{k} is defined inductively by: $\mathbf{k}_{2}^{(0)} = \mathbf{k}$ and $\mathbf{k}_{2}^{(n+1)} = (\mathbf{k}_{2}^{(n)})^{(1)}$, where n is a positive integer. Let \mathbb{M} be an unramified extension of \mathbf{k} and $C_{\mathbb{M}}$ be the subgroup of $C_{\mathbf{k}}$ associated to \mathbb{M} by the class field theory. Denote by $j_{\mathbf{k} \to \mathbb{M}} : C_{\mathbf{k}} \longrightarrow C_{\mathbb{M}}$ the homomorphism that associate to the class of an ideal \mathcal{A} of \mathbf{k} the class of the ideal generated by \mathcal{A} in \mathbb{M} , and by $\mathcal{N}_{\mathbb{M}/\mathbf{k}}$ the norm of the extension \mathbb{M}/\mathbf{k} .

Throughout all this section, assume that $\operatorname{Gal}(\mathbf{k}_{2}^{(2)}/\mathbf{k}) \simeq G_{n}$. Hence, according to the class field theory, $\operatorname{C}_{\mathbf{k},2} \simeq G_{n}/G'_{n} \simeq (2,2,2)$, thus $\operatorname{C}_{\mathbf{k},2} = \langle \mathfrak{a}, \mathfrak{b}, \mathfrak{c} \rangle \simeq \langle \sigma G'_{n}, \tau G'_{n}, \rho G'_{n} \rangle$, where $(\mathfrak{a}, \mathbf{k}_{2}^{(2)}/\mathbf{k}) = \sigma G'_{n}, (\mathfrak{b}, \mathbf{k}_{2}^{(2)}/\mathbf{k}) = \tau G'_{n}$ and $(\mathfrak{c}, \mathbf{k}_{2}^{(2)}/\mathbf{k}) = \rho G'_{n}$, with $(., \mathbf{k}_{2}^{(2)}/\mathbf{k})$ denotes the Artin symbol in $\mathbf{k}_{2}^{(2)}/\mathbf{k}$.

It is well known that each subgroup $H_{i,j}$, where $1 \le i \le 7$ and j = 2 or 4, of $C_{\mathbf{k},2}$ is associated, by class field theory, to a unique unramified extension $\mathbf{K}_{i,j}$ of $\mathbf{k}_2^{(1)}$ such that $H_{i,j}/H'_{i,j} \simeq C_{\mathbf{K}_{i,j},2}$.

Our goal is to study the capitulation problem of the 2-ideal classes of \mathbf{k} in its unramified quadratic and biquadratic extensions $\mathbf{K}_{i,2}$ and $\mathbf{K}_{i,4}$. By the class field theory, the kernel of $j_{\mathbf{k}\to\mathbb{M}}$, ker $j_{\mathbf{k}\to\mathbb{M}}$, is determined by the kernel of the transfer map $V_{G\to H} : G/G' \to H/H'$, where $G = \operatorname{Gal}(\mathbf{k}_2^{(2)}/\mathbf{k})$ and $H = \operatorname{Gal}(\mathbb{M}_2^{(2)}/\mathbb{M})$.

Theorem 8. Keep the previous notations. Then we have:

1. ker $j_{\mathbf{k}\to\mathbf{K}_{1,2}} = \langle \mathfrak{b} \rangle$. 2. ker $j_{\mathbf{k}\to\mathbf{K}_{2,2}} = \begin{cases} \langle \mathfrak{a}, \mathfrak{c} \rangle & \text{if } n = 1. \\ \langle \mathfrak{a}, \mathfrak{b} \mathfrak{c} \rangle & \text{if } n \ge 2. \end{cases}$ 3. ker $j_{\mathbf{k}\to\mathbf{K}_{3,2}} = \langle \mathfrak{b}, \mathfrak{c} \rangle$. 4. ker $j_{\mathbf{k}\to\mathbf{K}_{4,2}} = \begin{cases} \langle \mathfrak{a}\mathfrak{c}, \mathfrak{b}\mathfrak{c} \rangle & \text{if } n = 1. \\ \langle \mathfrak{a}\mathfrak{b}, \mathfrak{c} \rangle & \text{if } n \ge 2. \end{cases}$ 5. ker $j_{\mathbf{k}\to\mathbf{K}_{5,2}} = \langle \mathfrak{b}, \mathfrak{a}\mathfrak{c} \rangle$. 6. ker $j_{\mathbf{k}\to\mathbf{K}_{6,2}} = \begin{cases} \langle \mathfrak{a}, \mathfrak{b}\mathfrak{c} \rangle & \text{if } n = 1. \\ \langle \mathfrak{a}, \mathfrak{b}\mathfrak{c} \rangle & \text{if } n \ge 2. \end{cases}$

7. ker $j_{\mathbf{k}\to\mathbf{K}_{7,2}} = \begin{cases} \langle \mathfrak{ab}, \mathfrak{c} \rangle & \text{if } n = 1. \\ \langle \mathfrak{ab}, \mathfrak{bc} \rangle & \text{if } n \geq 2. \end{cases}$ 8. For all $1 \leq i \leq 7$, ker $j_{\mathbf{k}\to\mathbf{K}_{i,4}} = C_{\mathbf{k},2}$. 9. The 2-class group of $\mathbf{k}_2^{(1)}$ is of type $(2, 2^{n+1})$. 10. The Hilbert 2-class field tower of \mathbf{k} stops at $\mathbf{k}_2^{(2)}$. Proof. According to the Theorem 7, we have (1) Since ker $V_{G_n\to H_{1,2}} = \langle \tau G'_n \rangle$, so ker $j_{\mathbf{k}\to\mathbf{K}_{1,2}} = \langle \mathfrak{b} \rangle$. (2) Similarly, as ker $V_{G_n\to H_{2,2}} = \begin{cases} \langle \sigma G'_n, \rho G'_n \rangle & \text{if } n = 1, \\ \langle \sigma G'_n, \tau \rho G'_n \rangle & \text{if } n \geq 2, \end{cases}$ then ker $j_{\mathbf{k}\to\mathbf{K}_{2,2}} = \begin{cases} \langle \mathfrak{a}, \mathfrak{c} \rangle & \text{if } n = 1. \\ \langle \mathfrak{a}, \mathfrak{bc} \rangle & \text{if } n \geq 2. \end{cases}$ The other assertions are proved similarly.

(9) It is well known that $C_{\mathbf{k}_{2}^{(1)},2} \simeq G'_{n}$, where $C_{\mathbf{k}_{2}^{(1)},2}$ is the 2-class group of $\mathbf{k}_{2}^{(1)}$. As $G'_{n} \simeq \langle \sigma^{2}, \tau^{2} \rangle \simeq (2^{\min(1,n)}, 2^{\max(2,n+1)}) \simeq (2, 2^{n+1})$, since $\sigma^{4} = \tau^{2^{n+1}}$; so the result derived.

(10) $H_{1,4}$, $H_{2,4}$ and $H_{4,4}$ are the three subgroups of index 2 of the group $H_{1,2}$, then $\mathbf{K}_{1,4}$, $\mathbf{K}_{2,4}$ and $\mathbf{K}_{4,4}$ are the three unramified quadratic extensions of $\mathbf{K}_{1,2}$. On the other hand, the 2-class groups of these fields are of rank 2, since, by the class field theory, $C_{\mathbf{K}_{i,j},2} \simeq H_{i,j}/H'_{i,j}$ with i = 1, 2 or 4 and j = 2 or 4. Thus the Tables 1 and 2 imply that $C_{\mathbf{K}_{1,2},2} \simeq (2^2, 2^{n+2})$ and $C_{\mathbf{K}_{2,4,2}} \simeq (2, 2^{n+2})$. Hence $h_2(\mathbf{K}_{2,4}) = \frac{h_2(\mathbf{K}_{1,2})}{2}$, where $h_2(\mathbf{K})$ denotes the 2-class number of the field K. Therefore we can apply Proposition 7 of [5], which says that $\mathbf{K}_{1,2}$ has an abelian 2-class field tower if and only if it has a quadratic unramified extension $\mathbf{K}_{2,4}/\mathbf{K}_{1,2}$ such that $h_2(\mathbf{K}_{2,4}) = \frac{h_2(\mathbf{K}_{1,2})}{2}$. Thus $\mathbf{K}_{1,2}$ has abelian 2-class field tower which terminates at the first stage; this implies that the 2-class field tower of \mathbf{k} terminates at $\mathbf{k}_2^{(2)}$, since $\mathbf{k} \subset \mathbf{K}_{1,2}$. Moreover, we know, from Proposition 2, that $|G_n| = 2^{n+5}$ and $|G'_n| = 2^{n+2}$, hence $\mathbf{k}_2^{(1)} \neq \mathbf{k}_2^{(2)}$.

4. EXAMPLE

Let $p_1 \equiv p_2 \equiv 5 \pmod{8}$ be different primes. Denote by **k** the imaginary bicyclic biquadratic field $\mathbb{Q}(\sqrt{d},i)$, where $d = 2p_1p_2$. Let $\mathbf{k}_2^{(1)}$ be the Hilbert 2-class field of \mathbf{k} , $\mathbf{k}_2^{(2)}$ its second Hilbert 2-class field and G be the Galois group of $\mathbf{k}_2^{(2)}/\mathbf{k}$. According to [4], **k** has an elementary abelian 2class group $\mathbf{C}_{\mathbf{k},2}$ of rank 3, that is of type (2,2,2). Put $\mathbf{K} = \mathbf{k}(\sqrt{2}) = \mathbb{Q}(\sqrt{2},\sqrt{p_1p_2},\sqrt{-1})$, and let q denote the unit index of $\mathbf{K}^+ = \mathbb{Q}(\sqrt{2},\sqrt{p_1p_2})$. Denote by $h_2(-p_1p_2)$ (resp. $h_2(p_1p_2)$) the 2-class number of $\mathbb{Q}(\sqrt{-p_1p_2})$ (resp. $\mathbb{Q}(\sqrt{p_1p_2})$), then, from [10], $h_2(-p_1p_2) = 2^{m+1}$ with $m \geq 2$, and $h_2(p_1p_2) = 2^n$ with $n \geq 1$. Assume that q = 2, then, by [3, Lemma 6], m = 2 and $n \geq 1$, and by [3, Theorem 2], $G \simeq G_n$. The following result is proved in [3], and we give it here to illustrate the results shown above. For more details, the reader can see [3].

Theorem 9. Let $p_1 \equiv p_2 \equiv 5 \pmod{8}$ be two different primes. Put $\mathbf{k} = \mathbb{Q}(\sqrt{2p_1p_2}, i)$, \mathbf{k} has fourteen unramified extensions within his first Hilbert 2-class field, $\mathbf{k}_2^{(1)}$ (see [1]). Denote by $\mathbf{C}_{\mathbf{k},2}$ the 2-class group of \mathbf{k} . Then the following assertions hold.

- 1. Exactly four elements of $C_{k,2}$ capitulate in each unramified quadratic extension of k, except one where there are only two.
- 2. All the 2-classes of \mathbf{k} capitulate in each unramified biquadratic extension of \mathbf{k} .
- 3. The Hilbert 2-class field tower of \mathbf{k} stops at $\mathbf{k}_2^{(2)}$ (see [2]).
- 4. $\mathbf{C}_{\mathbf{k}_{2}^{(1)},2} \simeq (2, 2^{n+1}).$
- 5. The coclass of G is 3 and its nilpotency class is n + 2.
- The 2-class groups of the unramified quadratic extensions of k are of type (2, 4), (2, 2, 2) or (4, 2ⁿ⁺²).
- 7. The types of the 2-class groups of the unramified biquadratic extensions of \mathbf{k} are exactly those given by the Table 2.
