PERIODIC MEASURES ARE DENSE IN INVARIANT MEASURES FOR RESIDUALLY FINITE AMENABLE GROUP ACTIONS WITH SPECIFICATION

Abstract We prove that for actions of a discrete countable residually finite amenable group on a compact metric space with specification property, periodic measures are dense in the set of invariant measures. We also prove that some certain expansive actions of a countable discrete group by automorphisms of compact abelian groups have specification property.

1. INTRODUCTION

Let G be a discrete countable residually finite amenable group acting on a compact metric space X. Denote by $\mathcal{M}(X,G)$ the set of G-invariant measures and $\mathcal{M}_e(X,G)$ the set of ergodic G-invariant measures. For a point $x \in X$, we call x a periodic point if $|orb(x)| < \infty$. Denote the periodic measure μ_x as a probability measure with mass $|orb(x)|^{-1}$ at each point of orb(x) and we denote $\mathcal{M}_P(X)$ the set of all such periodic measures by $\mathcal{M}_P(X)$.

For $G = \mathbb{Z}$ the theory of such dynamical system is well studied. For example in [14], Sigmund proved the periodic measures are dense in invariant measures for Axiom A-diffeomorphisms. In [7], Hirayama proved that the measures supported by hyperbolic periodic points are dense in invariant measures for mixing $C^{1+\alpha}$ diffeomorphisms. In [9], Liang, Liu and Sun proved that each invariant measure in a non-uniformly hyperbolic system can be approximated by atomic measures on hyperbolic periodic orbits.

Throughout this paper, G will be a infinite discrete countable residually finite amenable group acting on a compact metric space X with metric ρ . We will recall some definitions and terminology in the next section.

Our main results are as follows.

Theorem 1.1. Let G be a discrete countable residually finite amenable group acting on a compact metric space X with specification property. Then $\mathcal{M}_P(X,G)$ is dense in $\mathcal{M}(X,G)$ in the weak^{*} topology. Moreover $\mathcal{M}_e(X,G)$ is residual in $\mathcal{M}(X,G)$.

Theorem 1.2. Let Γ be a countable discrete group and f an element of $\mathbb{Z}\Gamma$ invert-

ible in $l^1(\Gamma, \mathbb{R})$. Then the action of Γ on X_f has specification property.

2. Preliminary

In this section we will set up some notions and basic facts about amenable group and residually finite group. Also we will give the definition of specification.

2.1. Amenable group. A countable group G is amenable if there exists a sequence of finite subsets $\{F_n\}_{n \in \mathbb{N}}$ satisfying

$$\lim_{n \to \infty} \frac{|F_n \triangle KF_n|}{|F_n|} = 0, \forall K \in \mathcal{F}(G),$$

where $\mathcal{F}(G)$ is the collection of all finite subsets of G. Such sequences are said Følner sequences.

The quasi tiling theory is a useful tool for amenable group actions which is set up by Ornstein and Weiss in [12]. Subsets $A_1, A_2, \dots, A_k \in \mathcal{F}(G)$ are ε -disjoint if there exists $\{B_1, B_2, \dots, B_k\} \subset \mathcal{F}(G)$ such that $(1)B_i \subset A_i$ $i = 1, 2, \dots, k$

 $\begin{array}{ll} (1)B_i \subset A_i & i = 1, 2, \cdots, k, \\ (2)\frac{|B_i|}{|A_i|} > 1 - \varepsilon & i = 1, 2, \cdots, k. \\ \text{For } \alpha \in (0, 1], \text{ we say } \{A_1, A_2, \cdots, A_k\} \ \alpha\text{-covers } A \in \mathcal{F}(G) \text{ if } \end{array}$

$$\frac{A \cap \left(\bigcup_{i=1}^{k} A_i\right)}{|A|} \ge \alpha$$

We say that $\{A_1, A_2, \dots, A_k\} \subset \mathcal{F}(G)$ ε -quasi-tile $A \in \mathcal{F}(G)$ if there exists $\{C_1, C_2, \dots, C_k\} \subset \mathcal{F}(G)$ satisfying

 $(1)A_iC_i \subset A \text{ and } \{A_ic|c \in C_i\} \text{ forms an } \varepsilon - \text{disjoint family for } i = 1, 2, \cdots, k, \\ (2)A_iC_i \cap A_jC_j \neq \emptyset \quad 1 \le i \ne j \le k,$

(3){ $A_iC_i : i = 1, 2, \dots k$ } forms a $(1 - \varepsilon)$ -cover of A. The subsets C_1, C_2, \dots, C_k are called the tiling centers.

The following proposition is [15, Theorem 2.6].

Proposition 2.1. Let $\{F_n\}_{n\in\mathbb{N}}$ with $\{e_G\} \in F_1 \subset F_2 \subset and \{F'_n\}_{n\in\mathbb{N}}$ be two Følner sequences of G. Then for any $\varepsilon \in (0, \frac{1}{4})$ and $N \in \mathbb{N}$ there exists integers n_1, n_2, \dots, n_k with $n_k > n_{k-1} > \dots > n_1 > N$ such that $F_{n_1}, F_{n_2}, \dots, F_{n_k}$ ε -quasi-tile F'_m when m is large enough.

We will change Proposition 2.1 a little bit for our use. This is a light reformulation of [8, Proposition 2.3]. We describe these changes briefly, using the same notation and terminology in [8]. Fix $\varepsilon \in (0, \frac{1}{4}), N \in \mathbb{N}$ and k, δ are as in [8, Proposition 2.3]. Choose n_1, n_2, \dots, n_k such that $F_{n_{i+1}}$ is $(F_{n_i}F_{n_i}^{-1}, \delta)$ -invariant and $\frac{|F_{n_i}|}{|F_{n_{i+1}}|} < \delta$, $i = 1, 2, \dots, k - 1$. Then there is some $g_i \in G$, satisfying $F_{n_i}g_i \subset F_{n_{i+1}}$. Denote by $h_i = g_ig_{i+1}\dots g_{k-1}$, for $i = 1, 2\dots, k-1$ and $h_k = e_G$, then $F_{n_1}h_1 \subset F_{n_2}h_2 \subset \dots \subset F_{n_k}$. Pich $g \in G$ such that $e_G \in F_{n_1}h_1g$. Denote by $\widetilde{F}_{n_i} = F_{n_i}h_ig$. Then $e_G \in \widetilde{F}_{n_1} \subset \widetilde{F}_{n_2} \subset \dots \widetilde{F}_{n_k}$. From proposition 2.3 in [8], we know F'_m can be ε -quasi tiled by $\widetilde{F}_{n_1}, \widetilde{F}_{n_2}, \dots \widetilde{F}_{n_k}$ when m is sufficiently large. Since \widetilde{F}_{n_i} is just a translation of F_{n_i} for $i = 1, 2, \dots, k$, so F'_m can be ε -quasi-tiled by $F_{n_1}, F_{n_2}, \dots, F_{n_k}$. Hence we get the next proposition. **Proposition 2.2.** Let $\{F_n\}_{n\in\mathbb{N}}$ and $\{F'_n\}_{n\in\mathbb{N}}$ be two Følner sequences of G. Then for any $\varepsilon \in (0, \frac{1}{4})$ and $N \in \mathbb{N}$ there exists integers n_1, n_2, \cdots, n_k with $n_k > n_{k-1} > \cdots > n_1 > N$ such that $F_{n_1}, F_{n_2}, \cdots, F_{n_k} \varepsilon$ -quasi-tile F'_m when m is large enough.

For our proof, we also need the Mean Ergodic Theorem for amenable group actions . Readers may refer [10, Theorem 1.1].

Lemma 2.3 (Mean Ergodic Theorem). Let G be an amenable group acting on a measure space (X, \mathcal{B}, μ) by measure preserving transformation, and let $\{F_n\}_{n \in \mathbb{N}}$ be a Følner sequence. Then for any $f \in L^1(\mu)$, there is a G-invariant $\overline{f} \in L^1(\mu)$ such that

$$\lim_{n \to \infty} \frac{1}{|F_n|} \sum_{g \in F_n} f(gx) = \overline{f}(x) \quad in \quad L^1$$

Moreover $\int f(x)d\mu = \int \overline{f}(x)d\mu$. In particular, if the G-action is ergodic,

$$\lim_{n \to \infty} \frac{1}{|F_n|} \sum_{g \in F_n} f(gx) = \int f(x) \mathrm{d}\mu(x) \quad in \quad L^1.$$

For more information about ergodic theorem, readers may refer [11] or [6, Chapter 8].

2.2. **Residually finite group.** A group is residually finite if the intersection of all its normal subgroups of finite index is trivial. Examples of groups that are residually finite are finite groups, free groups, finitely generated nilpotent groups, polycyclicby-finite groups, finitely generated linear groups, and fundamental groups of 3manifolds. For more information about residually finite groups readers can refer [3, Chapter 2].

Let $(G_n, n \ge 1)$ be a sequence of finite index normal subgroups in G. We say

$$\lim_{n \to \infty} G_n = \{e_G\}$$

if we can find, for any $K \in \mathcal{F}(G)$, an N > 1 with $G_n \cap (K^{-1}K) = \{e_G\}$ for every $n \geq N$. Clearly such sequence exists if G is countable and residually finite.

If $G' \subset G$ is a subgroup with finite index, and $Q \subset G$ is a fundamental domain of the right coset space G/G', i.e. a finite subset such that $\{sQ \mid s \in G'\}$ is a partition of G.

The following proposition is [5, Corollary 5.6] and we will use it to control the periodic orbits we get.

Proposition 2.4. Let G be a countable discrete residually finite amenable group and let $(G_n, n \ge 1)$ be a sequence of finite index normal subgroup with $\lim_{n\to\infty} G_n =$ $\{e_G\}$. Then there exists a Følner sequence $(Q_n, n \ge 1)$ such that Q_n is a fundamental domain of G/G_n for every $n \ge 1$.

2.3. Specification. Specification is an orbit tracing property which is very useful in finding periodic orbits. In [1], Bowen was the first to state this notion and Ruelle investigated the extension of this notion to \mathbb{Z}^d -action in [13]. Chung and Li again generalized the property to general group actions in [4].

Let α be a continuous G-action on a compact metric space X with metric ρ . The action has specification property if there exist, for every $\varepsilon > 0$, a nonempty finite subset $F = F(\varepsilon)$ of G with the following property :

for any finite collection of finite subsets F_1, F_2, \cdots, F_m of G satisfying

$$FF_i \cap F_j = \emptyset \qquad 1 \le i \ne j \le m$$

and for any subgroup G' of G with

$$FF_i \cap F_j(G' \setminus \{e_G\}) = \emptyset \quad for \quad 1 \le i, j \le m.$$

Then for any collection of points $x^1, x^2, \ldots, x^m \in X$ there is a point $y \in X$ satisfying

$$\rho(sx^i, sy) \le \varepsilon \quad for \ all \quad s \in F_i, \ 1 \le i \le m \tag{3}$$

and sy = y for all $s \in G'$.

3. Proof of Theorem

Let $(G_n, n \ge 1)$ be a sequence of finite index normal subgroup with $\lim_{n\to\infty} G_n = \{e_G\}$ and a Følner sequence $(Q_n, n \ge 1)$ such that Q_n is a fundamental domain of G/G_n as described in Proposition 2.4.

Let $\nu \in \mathcal{M}(X,G), \varepsilon > 0$ and W a finite subset of C(X). Uniformly continuity of the elements of W implies that there is $\delta \in (0, \varepsilon)$ such that $|\xi(x) - \xi(y)| < \frac{\varepsilon}{8}$ for all $x, y \in X$ with $d(x, y) < \delta$ for all $\xi \in W$. Define

$$Q(G) = \{ x \in X : \lim_{n \to \infty} \frac{1}{|Q_n|} \sum_{g \in Q_n} \xi(gx) \quad \text{exists for all} \quad \xi \in C(X) \}$$

We call Q(G) the basin of ν . By Birkhorff Ergodic theorem, $\nu(Q(G)) = 1$. Denote by $\xi^*(x)$ the limit for each $x \in Q(G)$.

Moreover,

$$\int_{Q(G)} \xi^*(x) d\nu = \int_{Q(G)} \xi(x) d\nu.$$

Next we will construct a finite partition as following:

Set
$$D = \max_{\xi \in W} ||\xi||_{\infty}$$

For $j = 1, 2, \cdots, [\frac{16D}{\varepsilon}] + 1$ define

$$Q_j(\xi) = \{ x \in Q(G) | -D + \frac{j-1}{8} \varepsilon \le \xi^*(x) < -D + \frac{j}{8} \varepsilon \}.$$

Since W is finite

$$\eta := \bigvee_{\xi \in W} \{Q_1(\xi), \cdots, Q_{\left[\frac{BD}{\varepsilon}\right]+1}(\xi)\}$$

is a finite partition of Q(G), where $\alpha \lor \beta = \{A_i \cap B_j | A_i \in \alpha, B_j \in \beta\}$ for partitions $\alpha = \{A_i\}$ and $\beta = \{B_j\}$

Next we will construct F_1, F_2, \dots, F_t and G_m satisfying (1) and (2) in specification property. The idea is from [16] but some little modifications. Suppose $\eta = \{A_1, A_2, \dots, A_l\}$. Let $a_i = \nu(A_i)$ for $i = 1, 2, \dots, l$ and $a = \min\{a_i : i = 1, 2, \dots, l\}$. By Egorov's Theorem, there exist a Borel subset $X' \subset X$ with $\nu(X') > 1 - \frac{1}{4}a$ and $\frac{1}{|Q_n|} \sum_{g \in Q_n} \xi(gx)$ converges to $\xi^*(x)$ uniformly on X'.

Take $0 < \gamma < \min\left\{\frac{\delta}{16l}, \frac{\delta}{8D|F|}, \frac{1}{2}, \frac{\delta}{16Dl}\right\}$ and $F = F(\gamma)$ as in the specification property. Take $N_1 \in \mathbb{N}$ such that for $\forall x \in X', \left|\frac{1}{|Q_n|}\sum_{g \in Q_n} \xi(gx) - \xi^*(x)\right| < \frac{1}{8}\varepsilon$, for all $n \ge N_1$. Take $N_2 > N_1$ large enough s.t. $\frac{|gQ_n \bigtriangleup Q_n|}{|Q_n|} < \frac{\gamma}{4|F|^2l}$ for all $g \in F$, $n \ge N_2$. By Proposition 2.2 there exist $n_k > n_{k-1} > \cdots > n_1 > N_2$ and $N_3 \in \mathbb{N}$ s.t. Q_m can be $\frac{\gamma}{4|F|^2l}$ -quasi-tile by $Q_{n_1}, Q_{n_2}, \cdots, Q_{n_k}$ when $m > N_3$. Also N_3 will be large REN

enough such that the family of all the translations

$$\mathcal{F} = \{Q_{n_j}c_j : 1 \le i \le k, c_j \in C_j\}$$

can be partitioned into l subfamilies \mathcal{F}_{i} , $1 \leq i \leq l$ satisfying

$$\left|\frac{|\mathcal{F}_i|}{|Q_m|} - a_i\right| < \frac{\gamma}{l}$$

where $\bigcup \mathcal{F}_i = \bigcup_{Q_{n_j}c_j \in \mathcal{F}_i} \{F_{n_j}c_j\}$. Moreover the elements in \mathcal{F} are pairwise $\frac{\gamma}{4|F|^2l}$ -disjoint. We can choose $\{\widetilde{T_{n_j}}(c_j)c_j \subset Q_{n_j}c_j \in \mathcal{F}\}$ are pairwise disjoint and $\frac{|\widetilde{T_{n_j}}(c_j)|}{|F_{n_j}|} > 1 - \frac{\gamma}{4|F|^2l}$. Denote

$$T_{n_j}(c_j) = \{ s \in \widetilde{T}_{n_j}(c_j) | Fs \subset Q_{n_j} \}$$

and

$$S_{n_j}(c_j) = T_{n_j}(c_j) \cap FT_{n_j}(c_j)$$

By the definition, we know $\frac{|Q_{n_j} \setminus T_{n_j}(c_j)|}{|Q_{n_j}|} < \frac{\gamma}{2|F|}$ and $\frac{|Q_{n_j} \setminus S_{n_j}(c_j)|}{|Q_{n_j}|} < \gamma$. Denote $\widetilde{\mathcal{F}} = \{S_{n_j}(c_j)c_j|S_{n_j}(c_j)c_j \subset Q_{n_j}c_j \in \widetilde{F}\}$ and $\widetilde{\mathcal{F}}_i = \{S_{n_j}(c_j)c_j|Q_{n_j}c_j \in \mathcal{F}_i\}$ Claim: $\{S_{n_j}(c_j)c_j|S_{n_j}(c_j)c_j \in \widetilde{\mathcal{F}}\}$ and G_m satisfy the conditions in specification

property.

For different $S_{n_{j_1}}(c_{j_1})c_{j_1}$ and $S_{n_{j_2}}(c_{j_2})c_{j_2}$ we have

$$(S_{n_{j_1}}(c_{j_1})c_{j_1}\cap FS_{n_{j_2}}(c_{j_2})c_{j_2}) \subset (S_{n_{j_1}}(c_{j_1})c_{j_1}\cap T_{n_{j_2}}(c_{j_2})c_{j_2}) \subset (\widetilde{T}_{n_{j_1}}(c_{j_1})c_{j_1}\cap \widetilde{T}_{n_{j_2}}(c_{j_2})c_{j_2}) = \emptyset$$

By Proposition 2.4, we know

$$G = \bigsqcup_{g \in Q_n} gG_n \tag{4}$$

$$= \bigsqcup_{g \in Q_n} (g \bigsqcup g(G_n \setminus \{e_G\}))$$

For different $S_{n_{j_1}}(c_{j_1})c_{j_1}$ and $S_{n_{j_2}}(c_{j_2})c_{j_2}$, since $FS_{n_{j_1}}(c_{j_1})c_{j_1} \cap S_{n_{j_2}}(c_{j_2})c_{j_2} = \emptyset$, by (4), $FS_{n_{j_1}}(c_{j_1})c_{j_1} \cap S_{n_{j_2}}(c_{j_2})c_{j_2}G_m = \emptyset$; for the same $S_{n_{j_1}}(c_{j_1})c_{j_1}$ and $S_{n_{j_2}}(c_{j_2})c_{j_2}$, by (5), we get $FS_{n_{j_1}}(c_{j_1})c_{j_1} \cap S_{n_{j_2}}(c_{j_2})c_{j_2}(G_m \setminus \{e_G\}) = \emptyset$. We get that $\{S_{n_j}(c_j)c_j\}$ and G_m satisfy the conditions (1) and (2) in the specification property. Next we will construct the periodic measure.

For $S_{n_j}(c_j)c_j \in \widetilde{\mathcal{F}}_i$, pick some x related to $S_{n_j}(c_j)c_j$ denoted by $x_j(c_j)$ satisfying $x_j(c_j) \in c_j^{-1}A_j \cap X'$. Using the specification property, there is some y such that $\rho(gx_j(c_j), gy) < \gamma < \delta, \forall g \in S_{n_j}(c_j)c_j$. Denote

$$\mu_y = \frac{1}{|\widetilde{\mathcal{F}}|} \left(\sum_{i=1}^l \sum_{S_{n_j}(c_j)c_j \in \cup \widetilde{\mathcal{F}}_i} \sum_{g \in S_{n_j}(c_j)c_j} \delta_{gy}\right)$$

where δ_y is the Dirac measure on y.

Claim: $|\int \xi d\nu - \int \xi d\mu_y| < \varepsilon$, for all $\xi \in W$

$$\begin{split} |\int \xi d\nu - \int \xi d\mu_{y}| &= |\int \xi^{*}(x)d\nu - \int \xi(x)d\mu_{y}| \\ &= |\int \xi^{*}(x)d\nu - \frac{1}{|\cup\widetilde{\mathcal{F}}|} \sum_{i=1}^{l} \sum_{S_{n_{j}}(c_{j})c_{j}\in\widetilde{\mathcal{F}}_{i}} \sum_{g\in S_{n_{j}}(c_{j})c_{j}} \xi(gy)| \\ &\leq |\int \xi^{*}(x)d\nu - \frac{1}{|\cup\widetilde{\mathcal{F}}|} \sum_{i=1}^{l} \sum_{S_{n_{j}}(c_{j})c_{j}\in\widetilde{\mathcal{F}}_{i}} \sum_{g\in S_{n_{j}}(c_{j})c_{j}} \xi(gx_{n_{j}}(c_{j}))| + \frac{\varepsilon}{8} \\ &\leq |\int \xi^{*}(x)d\nu - \sum_{i=1}^{l} \sum_{S_{n_{j}}(c_{j})c_{j}\in\widetilde{\mathcal{F}}_{i}} \frac{|S_{n_{j}}(c_{j})|}{|\cup\widetilde{\mathcal{F}}|} \frac{1}{|S_{n_{j}}(c_{j})|} \sum_{g\in S_{n_{j}}(c_{j})c_{j}} \xi(gx_{j}(c_{j}))| + \frac{\varepsilon}{8} \end{split}$$

Pick $x_i \in A_i \cap X^*$, then $|\xi^*(x) - \xi^*(x_i)| < \frac{\varepsilon}{8}$ for all $x \in A_i$ by the construction of η . Then

$$\left|\frac{1}{|Q_{n_j}|}\sum_{g\in Q_{n_j}}\xi(gc_jx_j(c_j)) - \frac{1}{|Q_{n_j}|}\sum_{g\in Q_{n_j}}\xi(gx_i)\right| \le |\xi^*(c_jx_j(c_j)) - \xi^*(x_i)| + \frac{\varepsilon}{4} \le \frac{3}{8}\varepsilon$$

Also

$$\begin{aligned} \left| \frac{1}{|S_{n_{j}}(c_{j})|} \sum_{g \in S_{n_{j}}} \xi(gc_{j}x_{j}(c_{j})) - \frac{1}{|Q_{n_{j}}|} \sum_{g \in Q_{n_{j}}} \xi(gc_{j}x_{j}(c_{j}))\right| \\ &\leq \left| \frac{1}{|S_{n_{j}}(c_{j})|} \sum_{g \in S_{n_{j}}(c_{j})} \xi(gc_{j}x_{j}(c_{j})) - \frac{1}{|S_{n_{j}}(c_{j})|} \sum_{g \in Q_{n_{j}}} \xi(gc_{j}x_{j}(c_{j}))\right| \\ &+ \left| \frac{1}{|S_{n_{j}}(c_{j})|} \sum_{g \in Q_{n_{j}}} \xi(gc_{j}x_{j}(c_{j})) - \frac{1}{|Q_{n_{j}}|} \sum_{g \in Q_{n_{j}}} \xi(gc_{j}x_{j}(c_{j}))\right| \\ &\leq \frac{1}{|S_{n_{j}}(c_{j})|} D|Q_{n_{j}} \setminus S_{n_{j}}(c_{j})| + \frac{|Q_{n_{j}}|D}{|S_{n_{j}}(c_{j})||Q_{n_{j}}|} (|Q_{n_{j}}| - |S_{n_{j}}(c_{j})|) \\ &\leq \frac{2D\gamma}{1-\gamma} \\ &\leq \frac{1}{4}\varepsilon \end{aligned} \tag{8}$$

Taking (7) and (8) into (6), we have,

$$\begin{split} |\int \xi d\nu - \int \xi d\mu_y| &\leq |\int \xi^* d\nu - \sum_{i=1}^l \sum_{S_{n_j} c_j \in \widetilde{\mathcal{F}}_i} \frac{|S_{n_j}(c_j)|}{|\cup \widetilde{\mathcal{F}}|} \frac{1}{|Q_{n_j}|} \sum_{g \in Q_{n_j}} \xi(gc_j x_j(c_j))| + \frac{3}{8}\varepsilon \\ &\leq |\int \xi^*(x) d\nu - \sum_{i=1}^l \sum_{S_{n_j}(c_j) c_j \in \widetilde{\mathcal{F}}_i} \frac{|S_{n_j}(c_j)|}{|\cup \widetilde{\widetilde{\mathcal{F}}}|} \xi^*(c_j x_j(c_j))| + \frac{1}{2}\varepsilon \\ &\leq |\int \xi^*(x) d\nu - \sum_{i=1}^l a_i \xi^*(x_i)| + \frac{3}{4}\varepsilon \\ &\leq |\sum_{i=1}^l \int_{A_i} \xi^*(x) - \xi^*(x_i) d\nu| + \frac{7}{8}\varepsilon \\ &\leq \varepsilon \end{split}$$

For the moreover part, we just need the following claim.

Claim: Suppose (K, ρ) is a convex compact metric set and denote the set of extreme points of K by ext(K). Then ext(K) is a G_{δ} subset of K.

Let

$$K_n = \{x \in K : \text{ there exist } y, z \in K \text{ such that } x = \frac{1}{2}(y+z) \text{ and } d(y,z) \ge \frac{1}{n}\}.$$

Obviously, K_n is closed. Let $K_0 = \bigcup_{n \ge 1} K_n$ and K_0 is a F_{σ} subset. It is easy to check

check

$$x \notin ext(K) \Leftrightarrow x \in K_0.$$

As a result, $ext(K) = K \setminus K_0$ is a G_{δ} subset of K. We know that $\mathcal{M}_e(X,G)$ is the set of extreme points of $\mathcal{M}(X,G)$. So by the claim, $\mathcal{M}_e(X,G)$ is a G_{δ} set. Combined with periodic measure is ergodic, we get the moreover part.

So we prove the Theorem 1.1.

4. Proof of Theorem 1.2

For a countable group Γ and an element $f = \sum f_s s$ in the integral group ring $\mathbb{Z}\Gamma$, consider the quotient $\mathbb{Z}\Gamma/\mathbb{Z}\Gamma f$ of $\mathbb{Z}\Gamma$ by the left ideal $\mathbb{Z}\Gamma f$ generated by f. It is a discrete abelian group with a left Γ -action by multiplication. The Pontryagin dual

$$X_f = \mathbb{Z}\widehat{\Gamma}/\mathbb{Z}\widehat{\Gamma}f$$

is a compact abelian group with a left action of Γ by continuous group antomorphisms and we denote by ρ the compliable metric on X_f . Denote $X = (\mathbb{R}/\mathbb{Z})^{\Gamma}$. The left and right actions l and r on X are defined by

$$(l^{s}x)_{t} = x_{s^{-1}t}$$
 and $(r^{s}x)_{t} = x_{ts}$

for every $s, t \in \Gamma$ and $x \in X$. We can extend those actions of Γ to commuting actions l and r of $\mathbb{Z}\Gamma$ on X by setting

$$l_f x = \sum_{s \in \Gamma} f_s l^s x$$
 and $r_f x = \sum_{s \in \Gamma} f_s r^s x$.

It is easy to check $X_f = \{x \in X \mid r_f x = xr^* = 0\}$, where $f^* = \sum f_s s^{-1}$. Denote by

$$\alpha_f = l|_{X_f},$$

the restriction to X_f of the Γ -action l on X.

From in[5, Theorem 3.2], the action α_f is expansive if and only if f is invertible in $l^1(\Gamma)$. Denote by P the canonical map $l^{\infty}(\Gamma, \mathbb{R}) \to X$. Let $\xi = P \circ r_{f^{-1}} : L^{\infty}(\Gamma, \mathbb{Z}) \to X_f$. By in [5, Proposition 4.2], ξ is a surjective group homomorphism.

The following lemma is in [5, Lemma 4.5]

Lemma 4.1. For every $x \in X_f$ there exists an element $v \in l^{\infty}(\Gamma, \mathbb{Z})$ with $\xi(v) = x$ and $||v||_{\infty} \leq \frac{||f||_1}{2}$.

Proof. The proof is really easy. We choose $w \in P^{-1}(X_f) \subset l^{\infty}(\Gamma, \mathbb{R})$ with P(w) = xand $-\frac{1}{2} \leq w_s < \frac{1}{2}$ for every $s \in \Gamma$. Then $v = r_f(v)$ is what we need. Denote by $W = \{e_{\Gamma}\} \cup support(f^*) = (\{e_{\Gamma}\} \cup support(f))^{-1}$. Let $\varepsilon > 0$. Then we can fine a nonempty finite subset W_1 of Γ and $\varepsilon_1 \in (0, ||f||_1^{-1})$ such that $x, y \in X_f$ satisfy $\max_{s \in W_1} |x_s - y_s| \leq 2\varepsilon_1$, then $\rho(x, y) \leq \varepsilon$. Take a finite subset W_2 of Γ containing e_{Γ} satisfying $\sum_{s \in \Gamma \setminus W_2^{-1}} ||(f^*)^{-1}||_1 < \frac{\varepsilon_1}{2||f||_1}$. Denote by $\tilde{F} = W_1 W_2(W_1 W_2)^{-1}$.

For any finite collection of finite subsets F_1, F_2, \dots, F_m of Γ satisfying $\tilde{F}F_i \cap F_j = \emptyset, 1 \leq i \neq j \leq m$ and any collection of points x^1, x^2, \dots, x^m . By Lemma 4.1, pick $v^1, v^2, \dots, v^m \in l^{\infty}(\Gamma, \mathbb{Z})$ with $\|v^i\|_{\infty} \leq \frac{\|f\|_1}{2}$ and $\xi(v^i) = x^i$ for $i = 1, 2, \dots, m$. Let $v \in l^{\infty}(\Gamma, \mathbb{Z})$ be a point with $\|v\|_{\infty} \leq \frac{\|f\|_1}{2}$ and $v_s = v_s^i$ for $s \in F_i^{-1}W_1W_2$. v is well defined since $F_i^{-1}W_1W_2 \cap F_j^{-1}W_1W_2 = \emptyset$ for $1 \leq i \neq j \leq m$.

Let

$$\tilde{w}_s = \begin{cases} (f^{-1})_s & s \in W_2 \\ 0 & otherwise \end{cases}$$

 $\begin{array}{l} \textbf{Claim1:} \ y = \xi(v) \ \text{satisfies} \ \rho(sx^i,sy) < \varepsilon \ \forall s \in F_i, \ i = 1,2,\ldots,m. \\ \text{By the choice of} \ W_1, \ \text{we just need to show} \ |(sx^i)_t - (sy)_t| < 2\varepsilon_1 \ \forall s \in F_i \ \text{and} \ t \in W_1 \\ \text{i.e.} \ |x_s^i - y_s| < 2\varepsilon_1 \ \text{for all} \ s \in F_i^{-1}W_1. \\ \text{For any} \ s \in F_i^{-1}W_1, \end{array}$

$$\begin{aligned} |x_{s}^{i} - y_{s}| &= |P \circ r_{f^{-1}}(v^{i})_{s} - P \circ r_{f^{-1}}(v)_{s}| \\ &= |P \circ r_{f^{-1}}(v^{i})_{s} - P \circ r_{\tilde{w}}(v^{i})_{s} + P \circ r_{\tilde{w}}(v^{i})_{s} - P \circ r_{\tilde{w}}(v)_{s} \\ &+ P \circ r_{\tilde{w}}(v)_{s} - P \circ r_{f^{-1}}(v^{i})_{s}|. \end{aligned}$$

For $s \in F_i^{-1} W_1$, we get the following calculations,

$$|r_{f^{-1}}(v^{i})_{s} - r_{\tilde{w}}(v^{i})_{s}| = |\sum_{t \in \Gamma} f_{t}^{-1} v_{st}^{i} - \tilde{w}_{t} v_{st}^{i}|$$

$$\leq |\sum_{t \in W_{2}} f_{t}^{-1} v_{st}^{i} - \tilde{w}_{t} v_{st}^{i}| + |\sum_{t \in \Gamma \setminus W_{2}} f_{t} v_{st}^{i} - \tilde{w}_{t} v_{st}^{i}|$$

$$\leq \frac{\varepsilon_{1}}{2 \|f\|_{1}} \cdot \frac{\|f\|_{1}}{2} = \frac{\varepsilon_{1}}{4}$$
(10)

and

$$|r_{\tilde{w}}(v^{i})_{s} - r_{\tilde{w}}(v)_{s}| = |\sum_{t \in \Gamma} \tilde{w}_{t}(v^{i})_{st} - \tilde{w}_{t}v_{st}|$$
$$= |\sum_{t \in W_{2}} \tilde{w}_{t}(v^{i})_{st} - \tilde{w}_{t}v_{st}| = 0$$
(11)

and

$$|r_{\tilde{w}}(v)_{s} - r_{f^{-1}}(v)_{s}| = |\sum_{t \in \Gamma} \tilde{w}_{t} v_{st} - f_{t}^{-1} v_{st}|$$

$$\leq |\sum_{t \in W_{2}} \tilde{w}_{t} v_{st} - f_{t}^{-1} v_{st}| + |\sum_{t \in \Gamma \setminus W_{2}} \tilde{w}_{t} v_{st} - f_{t}^{-1} v_{st}|$$

$$\leq |\sum_{t \in \Gamma \setminus W_{2}} f_{t}^{-1} v_{st}|$$

$$\leq \frac{\varepsilon_{1}}{4}$$
(12)

By (10)-(12), we get

$$\rho(sx^i, sy) < \varepsilon$$
 for all $s \in F_i, i = 1, 2, \dots, m$.

The following lemma is a version [2, Lemma 1], also appeared in the proof of Lemma 6.2 in [4].

Lemma 4.2. Let α be an expansive continuous action of Γ on a compact metric space (X, ρ) . Let d > 0 such that if $x, y \in X$ satisfy $\sup_{s \in \Gamma} \rho(sx, sy) \leq d$, then x = y. Let x, y satisfy $\rho(sx, sy) \leq d$ for all but finite many $s \in \Gamma$. Then $\rho(sx, sy) \to 0$ as $\Gamma \ni s \to \infty.$

Denote $\Delta(X_f) = \{x \in X_f | \rho(sx, se_{X_f}) \to 0 \text{ as } \Gamma \ni s \to \infty\}.$ **Claim2:** Let d be the expansive coefficient of (X_f, α_f) i.e. for $x, y \in X_f$ with $\rho(sx, sy) \leq d$ for all $s \in \Gamma$ implies x = y. For any $\varepsilon \in (0, d)$ and $\tilde{F}(\varepsilon) = \tilde{F}$ as in Claim 1. Then for any finite subset F_1 of Γ and $x \in X_f$, there exists $y \in \Delta(X_f)$ s.t. $\max_{s \in F_1} \rho(sx, sy) \leq \varepsilon \text{ and } \sup_{s \in \Gamma \setminus \tilde{F}_{F_1}} \rho(e_{X_f}, sy) \leq \varepsilon.$

To prove the above claim, we may assume $\tilde{F} = \tilde{F}^{-1}$ otherwise we can replace F by $F \cup F^{-1}$. Let F_1 be a finite subset of Γ and $x \in X_f$. For each finite set $F_2 \subset \Gamma \setminus FF_1$. From claim1, we can find $y_{F_2} \in X_f$ such that $\rho(sx, sy_{F_2}) \leq \varepsilon$ for all $s \in F_1$ and $\rho(se_{X_f}, sy_{F_2}) \leq \varepsilon$ for all $s \in F_2$. Note that the collection of the finite subsets of $\Gamma \setminus \tilde{F}F_1$ has a partial order. Take a limit point $y \in X_f$ of $\{y_{F_2}\}_{F_2}$. Then $\rho(sx, sy) \leq \varepsilon$ for all $s \in F_1$ and $\rho(se_{X_f}, sy) \leq \varepsilon$ for all $\Gamma \setminus FF_1$. By Lemma 4.2, we know $y \in \Delta(X_f)$.

Take some $\delta > 0$ satisfying $\rho(x, y) < \delta$ implies $|x_{e_{\Gamma}} - y_{e_{\Gamma}}| < \varepsilon_1$, for all $x, y \in X_f$. Take $W_3 = W_3(\delta)$ as described in Claim2, such that for any finite subsets F_1 of Γ and $x \in X_f$ there exists $y \in \Delta(X_f)$ with $\rho(sx, sy) < \delta$ for all $s \in F_1$ and $\rho(sy, e_{X_f}) < \delta$ for all $s \in \Gamma \setminus W_3F_1$ which implies $|x_s - y_s| < \varepsilon_1$ for all $s \in F_1^{-1}$ and
$$\begin{split} |y_s| &< \varepsilon_1 \text{ for all } s \in \Gamma \setminus (W_3 F_1)^{-1} \text{ by the choice of } \delta. \\ \text{Take } F &= W_1 W_2 W_3^{-1} W (W_1 W_2 W_3^{-1} W)^{-1}. \end{split}$$

For any finite collection of finite subsets F_1, F_2, \ldots, F_m of Γ , and subgroup Γ' satisfy Condition 4 and 5. By the form of F, we will rewrite the conditions as

$$F_i^{-1} W_1 W_2 W_3^{-1} W \cap F_i^{-1} W_1 W_2 W_3^{-1} W = \emptyset \ 1 \le i \ne j \le m, \tag{13}$$

and

$$F_i W_1 W_2 W_3^{-1} W \cap (\Gamma'\{e_{\Gamma}\}) F_j^{-1} W_1 W_2 W_3^{-1} W = \emptyset \ 1 \le i, j \le m.$$
(14)

For any collection of points x^1, x^2, \ldots, x^m in X_f , we can pick $y^1, y^2, \ldots, y^m \in \Delta(X_f)$ with

$$\max_{s \in (W_1 W_2)^{-1} F_i} \rho(sx^i, sy^i) \le \delta \text{ and } \sup_{s \in \Gamma \setminus (W_3 (W_1 W_2)^{-1} F_i)} \rho(sy^i, e_{X_f}) \le \delta$$

which implies

$$\max_{s\in F_i^{-1}W_1W_2} |x_s^i - y_s^i| \le \varepsilon_1 \text{ and } \sup_{s\in \Gamma\setminus (F_i^{-1}W_1W_2W_3^{-1})} |y_s^i| \le \varepsilon_1$$
(15)

for i = 1, 2, ..., m. Take $\tilde{y}^i \in [-\frac{1}{2}, \frac{1}{2}]^{\Gamma}$ and $\tilde{x}^i \in [-1, 1]^{\Gamma}$ with $P(\tilde{y}^i) = y^i$ and $P(\tilde{x}^i) = x^i$ respectively such that

$$|\tilde{x}_s^i - \tilde{y}_s^i| \le \varepsilon_1 \,\, \forall s \in F_i^{-1} W_1 W_2 \text{ and } |\tilde{y}_s^i| \le \varepsilon_1 \quad \forall s \in \Gamma \setminus (F_i^{-1} W_1 W_2 W_3^{-1}).$$

For any $s \in \Gamma \setminus (F_i^{-1} W_1 W_2 W_3^{-1} W)$, one has

$$|(r_f \tilde{y}^i)_s| = |\sum_{t \in \Gamma} f_t \tilde{y}_{st}| = |\sum_{t \in W^{-1}} f_t \tilde{y}_{st}| \le ||f||_1 \sup_{s \in \Gamma \setminus (W_1 W_2 W_3^{-1})} |\tilde{y}^i| < ||f||_1 \cdot \varepsilon_1 < 1.$$

We note that $r_f \tilde{y}^i \in l^{\infty}(\Gamma, \mathbb{Z})$, thus $support(r_f \tilde{y}^i) \subset F_i^{-1} W_1 W_2 W_3^{-1} W$. By (13) and (14), we get the elements $sr_f \tilde{y}^i$ in $l^{\infty}(\Gamma, \mathbb{Z})$ for $s \in \Gamma'$ and $1 \leq i \leq m$ have pairwise disjoint supports. Denote by $\tilde{z} = \sum_{s \in \Gamma'} \sum_{i=1}^m sr_f \tilde{y}^i$. By the definition, one gets $\tilde{z} \in l^{\infty}(\Gamma, \mathbb{Z})$ and

$$\|\tilde{z}\|_{\infty} = \max_{1 \le i \le m} \|r_f \tilde{y}^i\| \le \|f\|_1 \max_{1 \le i \le m} \|\tilde{y}^i\|_{\infty} \le \frac{\|f\|_1}{2}$$

Set $\tilde{y} = r_{f^{-1}}(\tilde{z})$ and $y = P(\tilde{y}) = \xi(\tilde{z})$.

Claim3: y satisfies the conditions in specification property.

By the property of ξ , one gets $y \in X_f$. For each $s \in \Gamma'$, we have $s\tilde{z} = z$ and hence sy = y. For $x', y' \in l^{\infty}(\Gamma, \mathbb{R})$ satisfying $||x'||_{\infty}, ||y'||_{\infty} \leq ||f||_1$ and x', y' are equal on sW_2 for some $s \in \Gamma$ then

$$|(r_{f^{-1}}x')_{s} - (r_{f^{-1}}y')_{s}| = |\sum_{t \in \Gamma} (f_{t}^{-1}x'_{st} - f_{t}^{-1}y'_{st})| = |\sum_{t \in \Gamma \setminus W_{2}} (f_{t}^{-1}x'_{st} - f_{t}^{-1}y'_{st})|$$

$$\leq \frac{\varepsilon_{1}}{2\|f\|_{1}} \cdot 2\|f\|_{1} = \varepsilon_{1}$$
(16)

For any $t \in W_1$ and $s \in F_i$,

$$|(sx^{i})_{t} - (sy)_{t}| = |x^{i}_{s^{-1}t} - y^{i}_{s^{-1}t} + y^{i}_{s^{-1}t} - y_{s^{-1}t}|$$

$$\leq |x^{i}_{s^{-1}t} - y^{i}_{s^{-1}t}| + |y^{i}_{s^{-1}t} - y_{s^{-1}t}|$$

$$\leq 2\varepsilon_{1}, \qquad (17)$$

for i = 1, 2, ..., m and the last inequality is getting from (15) and (16). By the choice of W_1 , we finish the proof.

Combined by Theorem 1.1 and Theorem 1.2, we can easily get the following corollary.

Corollary 4.3. Let Γ be a countable discrete residually finite amenable group and $f \in \mathbb{Z}\Gamma$ invertible in $l^{\infty}(\Gamma, \mathbb{R})$. Then for the system (X_f, α_f) , $\mathcal{M}_P(X_f)$ is dense in $\mathcal{M}(X_f, \alpha_f)$.
