Self-Consistent Sources for Integrable Equations via Deformations of Binary Darboux Transformations

Abstract

We reveal the origin and structure of self-consistent source extensions of integrable equations from the perspective of binary Darboux transformations. They arise via a deformation of the potential that is central in this method. As examples, we obtain in particular matrix versions of self-consistent source extensions of the KdV, Boussinesq, sine-Gordon, nonlinear Schrödinger, KP, Davey-Stewartson, two-dimensional Toda lattice and discrete KP equation. We also recover a (2+1)-dimensional version of the Yajima-Oikawa system from a deformation of the pKP hierarchy. By construction, these systems are accompanied by a hetero binary Darboux transformation, which generates solutions of such a system from a solution of the source-free system and additionally solutions of an associated linear system and its adjoint. The essence of all this is encoded in universal equations in the framework of bidifferential calculus.

1 Introduction

The study of soliton equations with self-consistent sources has been pursued in particular in the work of Mel'nikov [1–6]. Mathematically, such systems of equations arise via a multiscaling limit of familiar integrable systems (see, e.g., [5,7]), or via a symmetry constraint imposed on a higher than two-dimensional integrable system (see [8,9], and also, e.g., [10–13] for related work). Several of these systems appeared, independently from those more mathematical explorations, in various physical contexts. For example, the nonlinear Schrödinger (NLS) equation with self-consistent sources describes the nonlinear interaction of an electrostatic high-frequency wave with the ion acoustic wave in a plasma (cold ions, warm electrons) in a small amplitude limit [14, 15]. In nonlinear optics it describes the interaction of self-induced transparency and NLS solitons [16, 17]. By now quite a number of publications have been devoted to such equations.

In this work, we show that self-consistent source extensions arise via a simple deformation of the "potential" that appears in the binary Darboux transformation method (see, e.g., [18]). Moreover, the present work provides a more universal approach to such extensions, generalizations to matrix versions of such equations, and a corresponding solution generating method. This is achieved in the framework of bidifferential calculus [19–21].

In Section 2 we consider the example of the potential KP (pKP) equation with self-consistent sources. The underlying structure is then abstracted to bidifferential calculus in Section 3. The resulting system allows to generate self-consistent source extensions of other integrable equations and supplies them with a solution-generating method. Examples are treated in the further sections. In Appendix A, we apply the aforementioned deformation to the matrix pKP hierarchy. The first non-trivial member then turns out to be a (2+1)-dimensional version [1] of the Yajima-Oikawa system [22]. Finally, Section 11 contains some concluding remarks.

2 Via binary Darboux transformation to self-consistent source extensions of the pKP equation

Let ϕ_0 solve the matrix potential KP (pKP) equation, i.e.,

$$\left(4\phi_{0,t} - \phi_{0,xxx} - 6(\phi_{0,x})^2\right)_x - 3\phi_{0,yy} + 6[\phi_{0,x},\phi_{0,y}] = 0, \qquad (2.1)$$

where a subscript x, y or t indicates a partial derivative with respect to this variable. A comma is used to separate them from subscripts of a different kind. Let θ, η solve the associated linear system and its adjoint, i.e.,

$$\theta_y = \theta_{xx} + 2 \phi_{0,x} \theta, \qquad \theta_t = \theta_{xxx} + 3 \phi_{0,x} \theta_x + \frac{3}{2} (\phi_{0,y} + \phi_{0,xx}) \theta$$
(2.2)

and

$$\eta_y = -\eta_{xx} - 2\eta \phi_{0,x}, \qquad \eta_t = \eta_{xxx} + 3\eta_x \phi_{0,x} - \frac{3}{2}\eta \left(\phi_{0,y} - \phi_{0,xx}\right). \tag{2.3}$$

Both pairs of equations have the above pKP equation as consistency condition. As a consequence of these equations, the compatibility conditions of the system

$$\Omega_x = -\eta \,\theta \,, \qquad \Omega_y = -\eta \,\theta_x + \eta_x \,\theta \,, \qquad \Omega_t = -\eta \,\theta_{xx} + \eta_x \,\theta_x - \eta_{xx} \,\theta - 3 \,\eta \,\phi_{0,x} \,\theta \,,$$

are satisfied, which guarantees the existence of a "potential" Ω . Then it follows that

$$\phi = \phi_0 - \theta \,\Omega^{-1} \,\eta \tag{2.4}$$

is a new solution of (2.1), and

$$q = \theta \,\Omega^{-1} \,, \qquad r = \Omega^{-1} \,\eta \,, \tag{2.5}$$

solve (2.2) and (2.3), respectively, with ϕ instead of ϕ_0 . This is an essential step of the binary Darboux transformation method for the pKP equation.

Remark 2.1. An attempt to iterate this procedure by using ϕ , q and r instead of ϕ_0 , θ and η , leads back to the ϕ_0 we started with to generate ϕ . Iteration of the binary Darboux transformation method involves the construction of still other solutions of the linear systems. But we will not need these further steps here, since we consider a *vectorial* binary Darboux transformation, so that there is no need for iteration.

Let us now deform the potential Ω as follows,

$$\Omega_x = -\eta \,\theta + c_1 ,$$

$$\Omega_y = -\eta \,\theta_x + \eta_x \,\theta + c_2 ,$$

$$\Omega_t = -\eta \,\theta_{xx} + \eta_x \,\theta_x - \eta_{xx} \,\theta - 3 \,\eta \,\phi_{0,x} \,\theta + c_3 ,$$
(2.6)

with (matrix) functions c_i , i = 1, 2, 3. Consistency requires that

$$c_1 = \omega_x , \qquad c_2 = \omega_y , \qquad c_3 = \omega_t ,$$

with a potential ω . Hence the above deformation actually amounts to the substitution $\Omega \mapsto \Omega - \omega$ in the previous equations. Then ϕ, q, r no longer satisfy (2.1), (2.2) and (2.3). Instead we find

$$q_{y} - q_{xx} = 2 \phi_{x} q + (-q \omega_{y} + q \omega_{xx} + 2 q_{x} \omega_{x}) \Omega^{-1},$$

$$q_{t} - q_{xxx} = 3 \phi_{x} q_{x} + \frac{3}{2} (\phi_{y} + \phi_{xx}) q + \frac{3}{2} (-q \omega_{y} + q \omega_{xx} + 2 q_{x} \omega_{x}) r q$$

$$+ (-q \omega_{t} + q \omega_{xxx} + 3 (q_{x} \omega_{x})_{x} + 3 \phi_{x} q \omega_{x}) \Omega^{-1},$$

$$r_{y} + r_{xx} = -2 r \phi_{x} - \Omega^{-1} (\omega_{y} r + \omega_{xx} r + 2 \omega_{x} r_{x}),$$

$$r_{t} - r_{xxx} = 3 r_{x} \phi_{x} - \frac{3}{2} r (\phi_{y} - \phi_{xx}) + \frac{3}{2} r q (\omega_{y} r + \omega_{xx} r + 2 \omega_{x} r_{x})$$

$$+ \Omega^{-1} (-\omega_{t} r + \omega_{xxx} r + 3 (\omega_{x} r_{x})_{x} + 3 \omega_{x} r \phi_{x}),$$
(2.8)

and the extended pKP equation

$$(4 \phi_t - \phi_{xxx} - 6 (\phi_x)^2)_x - 3 \phi_{yy} + 6 [\phi_x, \phi_y] = (4 q \omega_t r - 6 q \omega_x r_y - 6 q \omega_x r_{xx} + 6 q \omega_y r_x - 18 q \omega_{xx} r_x - 6 q \omega_{xy} r - 10 q \omega_{xxx} r)_x + (6 q \omega_x r_x - 3 q \omega_y r + 9 q \omega_{xx} r)_y + (6 q \omega_x r_x - 3 q \omega_y r + 9 q \omega_{xx} r)_{xx} .$$
(2.9)

If ϕ is an $m \times m$ matrix, then θ, q have matrix size $m \times n$, and η, r have size $n \times m$. Ω and ω are then $n \times n$ matrices.

Remark 2.2. Using (2.5), and introducing $\hat{\Omega} := -\Omega^{-1}$, we turn (2.6) into the Riccati system

$$\hat{\Omega}_x = -r q + \hat{\Omega} \, \omega_x \, \hat{\Omega} \,, \qquad \hat{\Omega}_y = -r \, q_x + r_x \, q + \hat{\Omega} \, \omega_y \, \hat{\Omega} \,, \\ \hat{\Omega}_t = -r \, q_{xx} + r_x \, q_x - r_{xx} \, q - 3 \, r \, \phi_x \, q + \hat{\Omega} \, \omega_t \, \hat{\Omega} \,.$$

This completes the system consisting of (2.7), (2.8) (where Ω^{-1} should be replaced by $-\hat{\Omega}$) and (2.9). The above hetero binary Darboux transformation can now be inverted to map solutions of (2.7), (2.8) and (2.9) to solutions of the source-free pKP equation and solutions of its linear system:

$$\phi_0 = \phi - q \,\hat{\Omega}^{-1} r \,, \quad \theta = -q \,\hat{\Omega}^{-1} \,, \quad \eta = -\hat{\Omega}^{-1} \, r \,.$$

The equations for q, r and $\hat{\Omega}$ are *non*linear, however, and thus more difficult to solve.

Next we look for choices of ω , such that Ω can be eliminated in half of the equations (2.7) and (2.8). This requires $\omega_x = 0$ and leaves us with the choices $\omega_y = 0$ or $\omega_t = 0$. In the first case, we only keep the equations for q_y and r_y . In the second case, we only keep those for q_t and r_t . This results in the two versions of pKP with self-consistent sources that appeared in the literature.

In terms of

$$\tilde{q} = q \mathcal{Q}, \qquad \tilde{r} = \mathcal{R} r, \qquad (2.11)$$

with a suitable choice of Q(t) and $\mathcal{R}(t)$, this system can be written as

$$(4\phi_t - \phi_{xxx} - 6(\phi_x)^2)_x - 3\phi_{yy} + 6[\phi_x, \phi_y] = (\tilde{q}\,\tilde{r})_x, \tilde{q}_y - \tilde{q}_{xx} = 2\phi_x\,\tilde{q}\,, \qquad \tilde{r}_y + \tilde{r}_{xx} = -2\,\tilde{r}\,\phi_x\,,$$
 (2.12)

where ω_t has been absorbed. The latter is rather what we should call a system with selfconsistent sources. Its scalar version has been studied in [1, 4, 7, 23–27]. The "noncommutative" generalization (2.12) already appeared in [28]. In our framework, the modification (2.10) is important. By actually solving (2.10), we obtain solutions of the self-consistent source system (2.12), which depend on arbitrary functions of t. The appearance of arbitrary functions of a single variable in solutions is a generic feature of systems with self-consistent sources.

2. $\omega = \omega(y)$.

$$(4\phi_t - \phi_{xxx} - 6(\phi_x)^2)_x - 3\phi_{yy} + 6[\phi_x, \phi_y] = 3(q\omega_y r_x - q_x\omega_y r)_x - 3(q\omega_y r)_y,$$

$$q_t - q_{xxx} = 3\phi_x q_x + \frac{3}{2}(\phi_y + \phi_{xx})q - \frac{3}{2}q\omega_y rq,$$

$$r_t - r_{xxx} = 3r_x\phi_x - \frac{3}{2}r(\phi_y - \phi_{xx}) + \frac{3}{2}rq\omega_y r.$$

$$(2.13)$$

Again, introducing new variables as in (2.11), now with a suitable Q(y) and $\mathcal{R}(y)$, ω_y can be absorbed. The scalar version of this system has been studied in [1,26].

Remark 2.3. In the scalar case (m = 1), if ω does not depend on x, the expression (2.4) can be rewritten as $\phi = \phi_0 + \operatorname{tr}(-\theta \Omega^{-1} \eta) = \phi_0 + \operatorname{tr}(\Omega_x \Omega^{-1}) = \phi_0 + (\ln(\det \Omega))_x$. Together with (2.5), this provides us with solutions of the scalar versions of (2.7) and (2.8). If ω depends only on t or y, we obtain solutions of (2.10) and (2.13), respectively.

Remark 2.4. As formulated above, the number of sources appears to be n. However, this is only so if ω_t , respectively ω_y , has maximal rank. If the rank is N < n, then only N sources appear on the right hand side of (2.9).

The above procedure provides us with a hetero binary Darboux transformation from the pKP equation and its associated linear system to any of the pKP systems with self-consistent sources (modified by ω).¹ In the framework of bidifferential calculus, we can abstract the underlying structure from the specific example (here pKP) and then obtain corresponding self-consistent source extensions of quite a number of other integrable equations.

Remark 2.2 shows that there is also a transformation that maps a class of solutions of any of the self-consistent source extensions of the pKP equation to solutions of the source-free pKP equation and its linear system. We expect that this is a general feature of integrable systems with self-consistent sources.

Exact solutions in case of constant seed. Let ϕ_0 be constant. Special solutions of (2.2) and (2.3) are given by

$$\theta = a \, e^{\vartheta(P)} \, A \,, \qquad \eta = B \, e^{-\vartheta(Q)} \, b \,, \qquad \vartheta(P) := P \, x + P^2 \, y + P^3 \, t \,,$$

with constant matrices a, b, A, B, P and Q of appropriate size. Then (2.6) is solved by

$$\Omega = \omega - B e^{-\vartheta(Q)} X e^{\vartheta(P)} A,$$

with a constant matrix X that satisfies the Sylvester equation

$$XP - QX = ba$$

¹In the scalar case, hetero binary Darboux transformations from a KP equation with self-consistent sources to the KP equation with additional sources have been elaborated in [25].

(2.4) and (2.5) now provide us with explicit solutions of the above matrix pKP equations with self-consistent sources, (2.10) and (2.13). The basic solution solutions are obtained if P and Q are diagonal with distinct eigenvalues, and if they have disjoint spectra, in which case the Sylvester equation has a unique solution. Also see [29] for the source-free case.

Example 2.5. In the scalar case (m = 1), choosing n = 1, a = A = B = b = 1 and $\omega = e^{\alpha}/(Q-P)$, where α is either a function only of y or of t, we obtain

$$\begin{split} \phi &= \phi_0 + \frac{(P-Q) \, e^{\vartheta(P) - \vartheta(Q)}}{e^\alpha + e^{\vartheta(P) - \vartheta(Q)}} = \phi_0 + \frac{1}{2} (P-Q) + (\ln(\cosh\Theta))_x \ , \\ q &= \frac{(Q-P) \, e^{\vartheta(P)}}{e^\alpha + e^{\vartheta(P) - \vartheta(Q)}} = \frac{1}{2} (Q-P) \, e^{\tilde{\Theta}} \operatorname{sech}(\Theta) \ , \ r = \frac{(Q-P) \, e^{-\vartheta(Q)}}{e^\alpha + e^{\vartheta(P) - \vartheta(Q)}} = \frac{1}{2} (Q-P) \, e^{-\tilde{\Theta} - \alpha} \operatorname{sech}(\Theta) \ , \end{split}$$

where $\Theta = \frac{1}{2} (\vartheta(P) - \vartheta(Q) - \alpha)$ and $\tilde{\Theta} = \frac{1}{2} (\vartheta(P) + \vartheta(Q) - \alpha)$. Then $u = \phi_x$, together with q and r, or rather the transformed \tilde{q} and \tilde{r} , is a soliton solution of the scalar KP equation with self-consistent sources. Also see [24, 25, 30, 31].

3 A framework for generating self-consistent source extensions of integrable equations

Let us recall some basics of bidifferential calculus. A graded associative algebra is an associative algebra $\Omega = \bigoplus_{r \geq 0} \Omega^r$ over \mathbb{C} , where $\mathcal{A} := \Omega^0$ is an associative algebra over \mathbb{C} and Ω^r , $r \geq 1$, are \mathcal{A} -bimodules such that $\Omega^r \Omega^s \subseteq \Omega^{r+s}$. A bidifferential calculus is a unital graded associative algebra Ω , supplied with two (\mathbb{C} -linear) graded derivations d, $\overline{d} : \Omega \to \Omega$ of degree one (hence $d\Omega^r \subseteq \Omega^{r+1}$, $\overline{d}\Omega^r \subseteq \Omega^{r+1}$), and such that

$$d^{2} = \bar{d}^{2} = d\bar{d} + \bar{d}d = 0.$$
(3.1)

In this framework, many integrable equations can be expressed either as

$$d d \phi_0 + d \phi_0 d \phi_0 = 0, \qquad (3.2)$$

with $\phi_0 \in Mat(m, m, \mathcal{A})$ (the algebra of $m \times m$ matrices over \mathcal{A}), and possibly with some reduction condition, or as

$$d\left[(\bar{d}g_0)\,g_0^{-1}\right] = 0\,,\tag{3.3}$$

with an invertible $g_0 \in Mat(m, m, \mathcal{A})$. The two equations are related by the *Miura equation*

$$\bar{\mathrm{d}}g_0 = (\mathrm{d}\phi_0) \, g_0,\tag{3.4}$$

which has both, (3.2) and (3.3), as integrability conditions. (3.2) and (3.3) are generalizations or analogs of well-known potential forms of the self-dual Yang-Mills equation (cf. [20]).

A linear system and an adjoint linear system for (3.2) is given by

$$\bar{\mathrm{d}}\theta = (\mathrm{d}\phi_0)\,\theta + (\mathrm{d}\theta)\,\Delta + \theta\,\lambda\,,\tag{3.5}$$

respectively

$$\bar{\mathrm{d}}\eta = -\eta \,\mathrm{d}\phi_0 + \Gamma \,\mathrm{d}\eta + \kappa \,\eta\,,\tag{3.6}$$

where $\theta \in Mat(m, n, \mathcal{A}), \eta \in Mat(n, m, \mathcal{A}), \Delta, \Gamma \in Mat(n, n, \mathcal{A}), \text{ and } \lambda, \kappa \text{ are } n \times n \text{ matrices of } elements of <math>\Omega^1$. They have to satisfy²

$$\bar{\mathrm{d}}\Delta + [\lambda, \Delta] = (\mathrm{d}\Delta)\,\Delta\,, \qquad \bar{\mathrm{d}}\lambda + \lambda^2 = (\mathrm{d}\lambda)\,\Delta\,, \bar{\mathrm{d}}\Gamma - [\kappa, \Gamma] = \Gamma\,\mathrm{d}\Gamma\,, \qquad \bar{\mathrm{d}}\kappa - \kappa^2 = \Gamma\,\mathrm{d}\kappa\,,$$
(3.7)

as a consequence of (3.1) and the graded derivation property of d and d.

Binary Darboux transformation. Let Ω be a solution of

$$\Gamma \Omega - \Omega \Delta = \eta \,\theta \,, \tag{3.8}$$

$$\bar{\mathrm{d}}\Omega = (\mathrm{d}\Omega)\,\Delta - (\mathrm{d}\Gamma)\,\Omega + \kappa\,\Omega + \Omega\,\lambda + (\mathrm{d}\eta)\,\theta\,. \tag{3.9}$$

The equation obtained by acting with \bar{d} on (3.8) is identically satisfied as a consequence of (3.5), (3.6), (3.8), and the equation that results from (3.8) by acting with d on it. Correspondingly, also the equation that results from acting with \bar{d} on (3.9) is identically satisfied as a consequence of the preceding equations. It follows [20] that

$$\phi = \phi_0 - \theta \,\Omega^{-1} \,\eta$$

is a new solution of (3.2), and

$$q = \theta \, \Omega^{-1} \,, \qquad r = \Omega^{-1} \, \eta \,,$$

satisfy

$$\bar{\mathrm{d}}q = (\mathrm{d}\phi)\,q + \mathrm{d}(q\,\Gamma) - q\,\kappa\,, \qquad \bar{\mathrm{d}}r = -r\,(\mathrm{d}\phi) + \mathrm{d}(\Delta\,r) - \lambda\,r\,.$$

Deformation of the potential. Guided by the pKP example in the preceding section, we replace Ω by $\Omega - \omega$ in the above equations, i.e.,

$$\Gamma (\Omega - \omega) - (\Omega - \omega) \Delta = \eta \theta, \bar{d}(\Omega - \omega) = d(\Omega - \omega) \Delta - (d\Gamma) (\Omega - \omega) + \kappa (\Omega - \omega) + (\Omega - \omega) \lambda + (d\eta) \theta.$$

Hence

$$\Gamma \Omega - \Omega \Delta = \eta \theta + c, \bar{d}\Omega = (d\Omega) \Delta - (d\Gamma) \Omega + \kappa \Omega + \Omega \lambda + (d\eta) \theta + \gamma,$$
(3.10)

where

$$c := \Gamma \,\omega - \omega \,\Delta \,, \qquad \gamma := \bar{\mathrm{d}}\omega - (\mathrm{d}\omega) \,\Delta + (\mathrm{d}\Gamma) \,\omega - \kappa \,\omega - \omega \,\lambda \,. \tag{3.11}$$

We note that they satisfy

$$\bar{d}\gamma = (d\gamma)\Delta - (d\Gamma)\gamma + \kappa\gamma - \gamma\lambda - (d\kappa)c, \bar{d}c = (dc)\Delta + \kappa c + c\lambda + \Gamma\gamma - \gamma\Delta.$$
(3.12)

By straightforward computations, one proves the following.

²For $\kappa = \lambda = 0$, these are "Riemann equations in bidifferential calculus" [32].

Theorem 3.1. Let ϕ_0 be a solution of (3.2) and let θ , η , Ω satisfy the linear equations (3.5), (3.6) and (3.10), respectively.³ Then

$$\phi = \phi_0 - \theta \,\Omega^{-1} \,\eta \,, \qquad q = \theta \,\Omega^{-1} \,, \qquad r = \Omega^{-1} \,\eta \,, \tag{3.13}$$

are solutions of

$$d\bar{d}\phi + d\phi d\phi = d(q\gamma r - qd(cr))$$
(3.14)

and

$$\bar{\mathrm{d}}q = (\mathrm{d}\phi) q + \mathrm{d}(q\,\Gamma) - q\,\kappa - q\,\gamma\,\Omega^{-1} - (\mathrm{d}q)\,c\,\Omega^{-1}, \bar{\mathrm{d}}r = -r\,\mathrm{d}\phi + \mathrm{d}(\Delta\,r) - \lambda\,r - \Omega^{-1}\,\gamma\,r + \Omega^{-1}\,\mathrm{d}(c\,r).$$

$$(3.15)$$

From (3.14) and (3.15) we can recover the self-consistent source extensions of the pKP equation, revisited in the preceding section, see below. But now we can choose different bidifferential calculi and obtain self-consistent source extensions also of other integrable equations. A number of examples will be presented in the following sections. In all these examples, we have c = 0, i.e.,

$$\Gamma \,\omega = \omega \,\Delta \,. \tag{3.16}$$

Remark 3.2. The above equations form a consistent system in the sense that any equation derived from it by acting with \bar{d} on any of its members yields an equation that is satisfied as a consequence of the system.

Remark 3.3. Using the last two equations in (3.13), we eliminate θ and η in (3.10) to obtain

$$\begin{split} &\Delta \,\Omega - \Omega \,\Gamma = r \,q + \Omega \,c \,\Omega \,, \\ &\bar{\mathrm{d}}\hat{\Omega} = \mathrm{d}(\hat{\Omega}\Gamma) - \hat{\Omega} \,\kappa - \lambda \,\hat{\Omega} + (\mathrm{d}r) \,q + \left((\mathrm{d}\hat{\Omega}) \,c + \hat{\Omega} \,\gamma\right) \,\hat{\Omega} \,, \end{split}$$

where $\hat{\Omega} = -\Omega^{-1}$. (3.15) then reads

$$\begin{split} \bar{\mathrm{d}}q &= (\mathrm{d}\phi) \, q + \mathrm{d}(q\,\Gamma) - q\,\kappa + q\,\gamma\,\hat{\Omega} + (\mathrm{d}q)\,c\,\hat{\Omega} \,, \\ \bar{\mathrm{d}}r &= -r\,\mathrm{d}\phi + \mathrm{d}(\Delta\,r) - \lambda\,r + \hat{\Omega}\,\gamma\,r - \hat{\Omega}\,\mathrm{d}(c\,r) \,. \end{split}$$

Together with (3.14), this constitutes a system of equations for ϕ , q, r and $\hat{\Omega}$, for which we now have a solution-generating technique at hand. Also see Remark 2.2.

Generating solutions of the equations for g. If ϕ_0 and g_0 satisfy the Miura equation (3.4), then ϕ, q, r together with

$$g = (I - \theta \,\Omega^{-1} \,\Gamma^{-1} \eta) \,g_0 \,,$$

where I is the identity matrix, satisfy

$$\bar{\mathrm{d}}g - (\mathrm{d}\phi) g = (q \gamma + (\mathrm{d}q) c) \Omega^{-1} \Gamma^{-1} \Omega r g_0 .$$

If (3.16) holds, i.e., c = 0, then we have

$$g^{-1} = g_0^{-1} \left(I + \theta \, \Delta^{-1} \, \Omega^{-1} \, \eta \right),$$

³Here we also assume, of course, that $\Delta, \Gamma, \kappa, \lambda$ satisfy (3.7).

and g satisfies the extended Miura equation

$$\bar{\mathrm{d}}g - (\mathrm{d}\phi) g = (q \gamma \Delta^{-1} r) g, \qquad (3.17)$$

which implies the following extension of (3.3),

$$d[(\bar{d}g) g^{-1}] = d(q \gamma \Delta^{-1} r).$$
(3.18)

Via the extended Miura equation (3.17), we can eliminate ϕ in (3.15) in favor of g. The resulting equations, together with (3.18), constitute the (Miura-) dual of (3.14) and (3.15). It is another generating system for further self-consistent source extensions of integrable equations.

Transformations. The equations for Δ and λ in (3.7) and the linear equation (3.5) are invariant under a transformation

$$\theta \mapsto \theta L \,, \quad \Delta \mapsto L^{-1} \Delta L \,, \quad \lambda \mapsto L^{-1} \lambda L + L^{-1} \overline{\mathrm{d}} L + (\mathrm{d} L^{-1}) \Delta L \,,$$

with an invertible L. Correspondingly, the equations for Γ and κ in (3.7) and the linear equation (3.6) are invariant under

$$\eta \mapsto M \eta, \quad \Gamma \mapsto M \Gamma M^{-1}, \quad \kappa \mapsto M \kappa M^{-1} + (\bar{\mathrm{d}}M) M^{-1} + M \Gamma \mathrm{d}M^{-1}$$

with an invertible M. (3.10) is invariant if we supplement these transformations by $\Omega \mapsto M \Omega L$ and $\omega \mapsto M \omega L$. Now (3.12) implies $c \mapsto M c L$ and $\gamma \mapsto M \gamma L$. The formula for ϕ in (3.13) is invariant, and those for q and r imply $q \mapsto q M^{-1}$ and $r \mapsto L^{-1} r$. It follows that (3.14), (3.15), (3.16), (3.17) and (3.18) are invariant. This suggests that, via such a transformation, κ and λ can typically be eliminated. However, Sections 4-7 show that this may not necessarily be so and that special choices of κ and λ can achieve a drastic simplification of the equations.

Choice of the graded algebra. In this work, we specify the graded algebra Ω to be of the form

$$\mathbf{\Omega} = \mathcal{A} \otimes \mathbf{\Lambda}, \qquad \mathbf{\Lambda} = \bigoplus_{i=0}^{2} \mathbf{\Lambda}^{i}$$
(3.19)

where Λ is the exterior (Grassmann) algebra of the vector space \mathbb{C}^2 . It is then sufficient to define d and \overline{d} on \mathcal{A} , since they extend to Ω in a straightforward way, treating the elements of Λ as constants. Moreover, d and \overline{d} extend to matrices over Ω . We choose a basis ξ_1, ξ_2 of Λ^1 .

Recovering the pKP case. Let \mathcal{A}_0 be the space of smooth complex functions on \mathbb{R}^3 . We extend it to $\mathcal{A} = \mathcal{A}_0[\partial]$, where $\partial := \partial_x$ is the partial differentiation operator with respect to x. On \mathcal{A} we define (cf. [20])

$$df = [\partial, f] \xi_1 + \frac{1}{2} [\partial_y + \partial^2, f] \xi_2, \qquad \bar{d}f = \frac{1}{2} [\partial_y - \partial^2, f] \xi_1 + \frac{1}{3} [\partial_t - \partial^3, f] \xi_2.$$

The maps d and \overline{d} extend to linear maps on $\Omega = \mathcal{A} \otimes \Lambda$, and moreover to matrices over Ω . Choosing

$$\Delta = \Gamma = -I_n \partial \,, \qquad \kappa = \lambda = 0 \,,$$

where I_n is the $n \times n$ identity matrix, (3.7) is satisfied, and c = 0, i.e., (3.16), becomes $\omega_x = 0$. The second equation in (3.11) leads to

$$\gamma = \frac{1}{2}\omega_y \,\xi_1 + \left(\frac{1}{3}\omega_t + \frac{1}{2}\omega_y \,\partial\right) \,\xi_2 \,.$$

(3.10) becomes (2.6) with $c_1 = 0$, $c_2 = \omega_y$, $c_3 = \omega_t$. Taking $\omega_x = 0$ into account, we recover all equations in Section 2. For example, (3.15) yields (2.7) and (2.8), and (3.14) becomes (2.9). A corresponding extension of the whole pKP hierarchy is presented in Appendix A.

4 Matrix KdV equation with self-consistent sources

Let \mathcal{A}_0 be the space of smooth complex functions on \mathbb{R}^2 . We extend it to $\mathcal{A} = \mathcal{A}_0[\partial]$, where $\partial := \partial_x$ is the partial differentiation operator with respect to the coordinate x. On \mathcal{A} we define (cf. [20])

$$df = [\partial, f] \xi_1 + \frac{1}{2} [\partial^2, f] \xi_2, \qquad \bar{d}f = -\frac{1}{2} [\partial^2, f] \xi_1 + \frac{1}{3} [\partial_t - \partial^3, f] \xi_2.$$

The maps d and \overline{d} extend to linear maps on $\Omega = \mathcal{A} \otimes \Lambda$, and moreover to matrices over Ω . Choosing

$$\Delta = \Gamma = -I_n \partial, \quad \kappa = \frac{1}{2} Q^2 \left(\xi_1 + \partial \xi_2\right), \quad \lambda = -\frac{1}{2} P^2 \left(\xi_1 + \partial \xi_2\right)$$

with constant matrices P, Q, (3.7) is satisfied, and (3.16) becomes $\omega_x = 0$. The choices for κ and λ considerably simplify the subsequent equations.⁴ The second equation in (3.11) yields

$$\gamma = \gamma_1 \xi_1 + (\gamma_2 + \gamma_1 \partial) \xi_2, \qquad \gamma_1 = -\frac{1}{2} (Q^2 \omega - \omega P^2), \quad \gamma_2 = \frac{1}{3} \omega_t.$$

The linear equations (3.5) and (3.6) read

$$\begin{split} \theta_{xx} &= \theta \, P^2 - 2 \, \phi_{0,x} \, \theta \,, \quad \theta_t = \theta_x \, P^2 + \phi_{0,x} \, \theta_x - \frac{1}{2} \phi_{0,xx} \, \theta \,, \\ \eta_{xx} &= Q^2 \eta - 2 \eta \, \phi_{0,x} \,, \quad \eta_t = Q^2 \eta_x + \eta_x \, \phi_{0,x} - \frac{1}{2} \eta \, \phi_{0,xx} \,, \end{split}$$

and (3.10) takes the form

$$Q^{2} \Omega - \Omega P^{2} = \eta \theta_{x} - \eta_{x} \theta + Q^{2} \omega - \omega P^{2},$$

$$\Omega_{x} = -\eta \theta, \quad \Omega_{t} = -Q^{2} \eta \theta - \eta \theta P^{2} + \eta_{x} \theta_{x} + \eta \phi_{0,x} \theta + \omega_{t}.$$
(4.1)

According to Section 3, it follows that ϕ , q and r, given by (3.13), satisfy

$$4 u_{t} - u_{xxx} - 3 (u^{2})_{x} = 8 (q \omega_{t} r)_{x} + 6 (q_{x} (Q^{2} \omega - \omega P^{2}) r - q (Q^{2} \omega - \omega P^{2}) r_{x})_{x},$$

$$q_{xx} = q Q^{2} - u q - q (Q^{2} \omega - \omega P^{2}) \Omega^{-1},$$

$$q_{t} = q_{x} Q^{2} + \frac{1}{2} q (Q^{2} \omega - \omega P^{2}) r q + \frac{1}{2} u q_{x} - \frac{1}{4} u_{x} q - q_{x} (Q^{2} \omega - \omega P^{2}) \Omega^{-1} - q \omega_{t} \Omega^{-1}$$

$$= q_{xxx} + \frac{3}{2} u q_{x} + \frac{3}{4} u_{x} q + \frac{3}{2} q (Q^{2} \omega - \omega P^{2}) r q - q \omega_{t} \Omega^{-1},$$

$$r_{xx} = P^{2} r - r u + \Omega^{-1} (Q^{2} \omega - \omega P^{2}),$$

$$r_{t} = P^{2} r_{x} - \frac{1}{2} r q (Q^{2} \omega - \omega P^{2}) r + \frac{1}{2} r_{x} u - \frac{1}{4} r u_{x} + \Omega^{-1} (Q^{2} \omega - \omega P^{2}) r_{x} - \Omega^{-1} \omega_{t} r$$

$$= r_{xxx} + \frac{3}{2} r_{x} u + \frac{3}{4} r u_{x} - \frac{3}{2} r q (Q^{2} \omega - \omega P^{2}) r - \Omega^{-1} \omega_{t} r,$$
(4.2)

where we introduced $u = 2 \phi_x$. From this we obtain the following two versions of a matrix KdV equation with self-consistent sources.

1. Setting $\gamma_1 = 0$, i.e.,

$$Q^2\omega = \omega P^2, \qquad (4.3)$$

and disregarding the equations for q_t and r_t , (4.2) reduces to

$$4 u_t - u_{xxx} - 3 (u^2)_x = 8 (q \omega_t r)_x, \quad q_{xx} = q Q^2 - u q, \quad r_{xx} = P^2 r - r u.$$
(4.4)

Here ω_t can be absorbed by a redefinition of either q or r, which exchanges P and Q in the corresponding linear equation due to a necessary application of (4.3). The scalar version appeared in [3], also see [33–36].

 $^{{}^{4}\}kappa = \lambda = 0$ is not the best choice here.

Here we chose $\beta(t) = \sin(3t)$, $p_1 = 1$, $p_2 = -1/2$, $a_1 = b_1^{\mathsf{T}} = (1,0)$ and $a_2 = (0,1) = b_2^{\mathsf{T}}$ in (4.6). The plots for r_1 and r_2 look like those for q_1 and q_2 .

2. $\gamma_2 = 0$, i.e., constant ω . In this case (4.2) yields

$$4 u_t - u_{xxx} - 3 (u^2)_x = (\tilde{q}_x r - \tilde{q} r_x)_x ,$$

$$\tilde{q}_t = \tilde{q}_{xxx} + \frac{3}{2} u \tilde{q}_x + \frac{3}{4} u_x \tilde{q} + \frac{3}{2} \tilde{q} r \tilde{q} , \quad r_t = r_{xxx} + \frac{3}{2} r_x u + \frac{3}{4} r u_x - \frac{3}{2} r \tilde{q} r , \qquad (4.5)$$

where we introduced $\tilde{q} = 6 q (Q^2 \omega - \omega P^2)$. This system is also obtained from (2.13) by assuming that ϕ, q, r do not depend on y, whereas ω_y is non-zero, but constant. We note that (4.5) is a system of evolution equations for all dependent variables. In this respect it is very different from all other examples of systems with self-consistent sources presented in this work, with the exception of (5.1).

Exact solutions for vanishing seed. Let ϕ_0 be constant, i.e., $u_0 = 0$. Then we have the following solutions of the linear equations,

$$\theta = a_1 e^{\vartheta(P)} + a_2 e^{-\vartheta(P)}, \quad \eta = e^{\vartheta(Q)} b_1 + e^{-\vartheta(Q)} b_2, \quad \vartheta(P) = P x + P^3 t, \quad (4.6)$$

with constant matrices a_i, b_i . A corresponding solution of (4.1) is

$$\Omega = e^{\vartheta(Q)} A_{11} e^{\vartheta(P)} + e^{-\vartheta(Q)} A_{22} e^{-\vartheta(P)} + e^{-\vartheta(Q)} A_{21} e^{\vartheta(P)} + e^{\vartheta(Q)} A_{12} e^{-\vartheta(P)} + \omega \,,$$

with constant matrices A_{ij} that satisfy the Sylvester equations

 $QA_{11} + A_{11}P = -b_1a_1$, $QA_{22} + A_{22}P = b_2a_2$, $QA_{21} - A_{21}P = b_2a_1$, $QA_{12} - A_{12}P = -b_1a_2$. Then (3.13) yields exact solutions of (4.4), respectively (4.5), under the corresponding condition for ω .

Example 4.1. In case of the first version of a KdV equation with self-consistent sources, for the sake of definiteness we choose $\omega(t) = \beta(t) I_n$. Then (4.3) leads to $Q = \pm P$. The two cases turn out to be equivalent, hence we choose Q = P. Now (3.13) determines a class of exact solutions of (4.4). Fig. 1 shows an example of a modulated 2-soliton solution. Introducing $\tilde{r} = \beta r$, this becomes a solution of (4.4) without the presence of ω_t .

Example 4.2. In case of the second KdV equation with self-consistent sources, let n = 1. Then we obtain the following 2-soliton solution of (4.5),

$$\begin{split} \phi &= \frac{2\left(P^2 - Q^2\right)}{D}\cosh(\vartheta_1)\sinh(\vartheta_2), \quad \tilde{q} = \frac{e^{-\nu_1 - \nu_2}\left(P + Q\right)\left(Q^2\omega - \omega P^2\right)}{D}\cosh(\vartheta_1), \\ r &= \frac{e^{-\mu_1 - \mu_2}\left(P - Q\right)}{D}\sinh(\vartheta_2), \quad D := \omega + (Q - P)\cosh(\vartheta_1 + \vartheta_2) + (Q + P)\cosh(\vartheta_1 - \vartheta_2), \end{split}$$

with constants μ_i, ν_i and $\vartheta_1 = \vartheta(P) + \mu_1 - \mu_2, \, \vartheta_2 = \vartheta(Q) + \nu_1 - \nu_2.$

5 Matrix Boussinesq equation with self-consistent sources

Let \mathcal{A}_0 be the space of smooth complex functions on \mathbb{R}^2 , with coordinates x and t, and $\mathcal{A} = \mathcal{A}_0[\partial]$, where $\partial := \partial_x$ is the partial differentiation operator with respect to x. On \mathcal{A} we define a bidifferential calculus via

$$df = [\partial, f] \xi_1 + \frac{1}{2} [\partial_t + \partial^2, f] \xi_2, \qquad \bar{d}f = \frac{1}{2} [\partial_t - \partial^2, f] \xi_1 - \frac{1}{3} [\partial^3, f] \xi_2.$$

Setting

$$\Delta = \Gamma = -I_n \partial \,, \quad \kappa = -\frac{1}{3} \, Q^3 \, \xi_2 \,, \quad \lambda = -\frac{1}{3} \, P^3 \, \xi_2 \,,$$

with constant matrices P, Q, (3.7) is satisfied, and (3.16) becomes $\omega_x = 0$. The second equation in (3.11) yields

$$\gamma = \gamma_1 \xi_1 + (\gamma_2 + \gamma_1 \partial) \xi_2, \qquad \gamma_1 = \frac{1}{2} \omega_t, \quad \gamma_2 = \frac{1}{3} (Q^3 \omega + \omega P^3).$$

The linear equations (3.5) and (3.6) read

$$\begin{aligned} \theta_{xxx} &= \theta P^3 - 3 \phi_{0,x} \theta_x - \frac{3}{2} (\phi_{0,t} + \phi_{0,xx}) \theta , \qquad \theta_t = \theta_{xx} + 2 \phi_{0,x} \theta , \\ \eta_{xxx} &= Q^3 \eta - 3 \eta_x \phi_{0,x} + \frac{3}{2} \eta \left(\phi_{0,t} - \phi_{0,xx} \right) , \qquad \eta_t = -\eta_{xx} - 2 \eta \phi_{0,x} , \end{aligned}$$

and (3.10) takes the form

$$Q^{3}(\Omega - \omega) + (\Omega - \omega) P^{3} = -\eta \theta_{xx} + \eta_{x} \theta_{x} - \eta_{xx} \theta - 3 \eta \phi_{0,x} \theta,$$

$$\Omega_{x} = -\eta \theta, \qquad (\Omega - \omega)_{t} = -\eta \theta_{x} + \eta_{x} \theta.$$

Our general results in Section 3 imply that ϕ , q and r, given by (3.13), satisfy⁵

$$\begin{split} 3\,\phi_{tt} + \phi_{xxxx} + 6\,(\phi_x{}^2)_x - 6\,[\phi_x,\phi_t] &= -\left(4\,q\,(Q^3\omega + \omega\,P^3)\,r + 3\,q\,\omega_t\,r_x - 3\,q_x\omega_t\,r\right)_x + 3\,(q\,\omega_t\,r)_t\,,\\ q_{xxx} &= -q\,Q^3 - 3\,\phi_x q_x - \frac{3}{2}(\phi_t + \phi_{xx})\,q + \frac{3}{2}q\,\omega_t r\,q + q\,(Q^3\omega + \omega\,P^3)\,\Omega^{-1}\,,\\ q_t &= q_{xx} + 2\,\phi_x q - q\,\omega_t\,\Omega^{-1}\,,\\ r_{xxx} &= -P^3\,r - 3\,r_x\,\phi_x + \frac{3}{2}r\,(\phi_t - \phi_{xx}) - \frac{3}{2}r\,q\,\omega_t\,r + \Omega^{-1}\,(Q^3\omega + \omega\,P^3)\,r\,,\\ r_t &= -r_{xx} - 2\,r\,\phi_x - \Omega^{-1}\,\omega_t\,r\,. \end{split}$$

From this we obtain the following two versions of a matrix Boussinesq equation with self-consistent sources. Here we set $u := 2\phi_x$.

$$1. \ Q^3\omega + \omega P^3 = 0.$$

$$\begin{aligned} 3 \, u_{tt} + u_{xxxx} + 3 \, (u^2)_{xx} - 3 \, [u, \partial^{-1} u_t]_x &= -6 \, (q \, \omega_t \, r_x - q_x \omega_t \, r)_{xx} + 6 \, (q \, \omega_t \, r)_{xt} \\ q_{xxx} &= -q \, Q^3 - \frac{3}{2} \, u \, q_x - \frac{3}{4} (\partial^{-1} u_t + u_x) \, q + \frac{3}{2} q \, \omega_t r \, q \, , \\ r_{xxx} &= -P^3 \, r - \frac{3}{2} \, r_x \, u + \frac{3}{4} r \, (\partial^{-1} u_t - u_x) - \frac{3}{2} r \, q \, \omega_t r \, . \end{aligned}$$

The scalar version appeared in [37].

⁵Up to the term involving Q and P, the first equation is obtained as a reduction of (2.9), exchanging y and t.

2. $\omega_t = 0$, i.e., constant ω .

$$3 u_{tt} + u_{xxxx} + 3 (u^2)_{xx} - 3 [u, \partial^{-1} u_t]_x = (\tilde{q} r)_{xx} ,$$

$$\tilde{q}_t = \tilde{q}_{xx} + u \tilde{q} , \qquad r_t = -r_{xx} - r u .$$
(5.1)

where we introduced $\tilde{q} = -8 q (Q^3 \omega + \omega P^3)$. In contrast to most systems with self-consistent sources obtained in this work, here we have evolution equations for *all* dependent variables. Also see (4.5).

Solutions with vanishing seed. If $u_0 = \phi_{0,x}/2 = 0$, solutions of the linear equations are given by

$$\theta = a_0 e^{\vartheta(P)} + a_1 e^{\vartheta(\zeta P)} + a_2 e^{\vartheta(\zeta^2 P)}, \qquad \eta = e^{-\vartheta(-Q)} b_0 + e^{-\vartheta(-\zeta Q)} b_1 + e^{-\vartheta(\zeta^2 Q)} b_2,$$

where a_i, b_i are constant and

$$\zeta := e^{2\pi \mathrm{i}/3} \,, \qquad \vartheta(P) := P \, x + P^2 \, t \,.$$

A corresponding solution of the equations for Ω is then given by

$$\Omega = \sum_{j,k=0}^{2} e^{-\vartheta(-\zeta^k Q)} A_{kj} e^{\vartheta(\zeta^j P)} + \omega ,$$

where A_{kj} are constant matrices subject to

$$\zeta^k Q A_{kj} + \zeta^j A_{kj} P = -b_k a_j \qquad j, k = 0, 1, 2.$$

Now (3.13) yields exact solutions of the above Boussinesq systems with self-consistent sources. In case of the first version, we still have to take the constraint $Q^3\omega = -\omega P^3$ into account.

6 Matrix sine-Gordon equation with self-consistent sources

Let \mathcal{A}_0 be an associative algebra, where the elements depend on variables x and y. Let $\mathcal{A} = \mathcal{A}_0[J]$, where J is an idempotent operator that determines an involution * via $Jf =: f^*J$, for $f \in \mathcal{A}_0$, i.e., $f^* = JfJ$. A bidifferential calculus is then determined on \mathcal{A} by setting

$$df = [\partial_x, f] \xi_1 + \frac{1}{2} [J, f] \xi_2, \qquad \bar{d}f = \frac{1}{2} [J, f] \xi_1 + [\partial_y, f] \xi_2.$$

In order to eliminate explicit appearances of the operator J in the equations resulting from the linear equations (3.5) and (3.6), we write⁶

$$\begin{split} \phi &= \varphi J \,, \quad \Delta = P J \,, \quad \Gamma = J Q \,, \\ \kappa &= J \left(\kappa_1 + \frac{1}{2} I \right) \xi_1 + \left(\kappa_2 - \frac{1}{2} Q^* \right) \xi_2 \,, \quad \lambda = \left(\lambda_1 - \frac{1}{2} I \right) J \,\xi_1 + \left(\lambda_2 + \frac{1}{2} P^* \right) \xi_2 \,, \end{split}$$

where $\varphi, P, Q, \kappa_i, \lambda_i$ can now be taken to be matrices over \mathcal{A}_0 . We will assume that P and Q are invertible. Then we obtain

$$\theta_x = \left(\frac{1}{2}I - \varphi_{0,x}\right)\theta^* P^{-1} - \theta \lambda_1 P^{-1}, \quad \theta_y = \frac{1}{2}\theta^* P^* - \frac{1}{2}(\varphi_0 - \varphi_0^*)\theta + \theta \lambda_2, \eta_x = Q^{-1}\eta^* \left(\varphi_{0,x}^* - \frac{1}{2}I\right) - Q^{-1}\kappa_1 \eta, \quad \eta_y = -\frac{1}{2}Q^*\eta^* + \frac{1}{2}\eta \left(\varphi_0 - \varphi_0^*\right) + \kappa_2 \eta,$$
(6.1)

⁶Only in this section we carry the full freedom in κ and λ along with us, in particular in order to demonstrate that there are special non-zero choices, here given by $\kappa_i = \lambda_i = 0$, which considerably simplify the equations.

where θ and η can now be restricted to be matrices over \mathcal{A}_0 . The equations (3.7) impose the following conditions,

$$P_{x} = (\lambda_{1}P^{*} - P \lambda_{1}^{*}) (P^{*})^{-1}, \qquad P_{y} = P \lambda_{2}^{*} - \lambda_{2} P,$$

$$Q_{x} = (Q^{*})^{-1} (Q^{*} \kappa_{1} - \kappa_{1}^{*} Q), \qquad Q_{y} = \kappa_{2}^{*} Q - Q \kappa_{2},$$

$$\kappa_{1,y} + Q \kappa_{2,x} = \kappa_{2}^{*} \kappa_{1} - \kappa_{1} \kappa_{2}, \qquad \lambda_{1,y} + \lambda_{2,x} P = \lambda_{1} \lambda_{2}^{*} - \lambda_{2} \lambda_{1}$$

Next we set

$$\Omega = \tilde{\Omega} J \,, \quad \omega = \tilde{\omega} J \,, \quad q = \tilde{q} J \,, \quad r = J \, \tilde{r}$$

Then (3.16) becomes

$$Q\,\tilde{\omega} = \tilde{\omega}^* P\,,\tag{6.2}$$

.

and the involution property implies $Q^*Q\,\tilde{\omega} = \tilde{\omega}\,P^*P$. The second equation in (3.11) reads

....

$$\gamma = \gamma_1 \,\xi_1 + \gamma_2 \,J \,\xi_2 \quad \text{where} \quad \gamma_1 = -(\tilde{\omega}_x + Q^{-1}\kappa_1 \,\tilde{\omega}) \,P^* - \tilde{\omega} \,\lambda_1^*, \quad \gamma_2 = \tilde{\omega}_y - \tilde{\omega} \,\lambda_2^* - \kappa_2 \,\tilde{\omega} \,.$$

From (3.10) we obtain the Sylvester equation

$$Q^* \tilde{\Omega}^* - \tilde{\Omega} P^* = \eta \theta, \qquad (6.3)$$

and

$$\tilde{\Omega}_{x} = Q^{-1} \eta^{*} \left(\frac{1}{2}I - \varphi_{0,x}^{*}\right) \theta\left(P^{*}\right)^{-1} - \gamma_{1} \left(P^{*}\right)^{-1} - \tilde{\Omega} \lambda_{1}^{*} (P^{*})^{-1} - Q^{-1} \kappa_{1} \tilde{\Omega},$$

$$\tilde{\Omega}_{y} = -\frac{1}{2} \eta \theta^{*} + \gamma_{2} + \tilde{\Omega} \lambda_{2}^{*} + \kappa_{2} \tilde{\Omega}.$$
(6.4)

Given solutions θ and η of the linear equations, and a solution Ω of the latter consistent system, it follows from our general results in Section 3 that

$$\varphi = \varphi_0 - \theta \,(\tilde{\Omega}^*)^{-1} \,\eta^* \,, \qquad \tilde{q} = \theta \,(\tilde{\Omega}^*)^{-1} \,, \qquad \tilde{r} = \tilde{\Omega}^{-1} \,\eta \tag{6.5}$$

solve

$$\varphi_{xy} - \frac{1}{2}(\varphi - \varphi^*) + \frac{1}{2} \{\varphi - \varphi^*, \varphi_x\} = \frac{1}{2} (\tilde{q} \,\gamma_1^* \,\tilde{r} - \tilde{q}^* \,\gamma_1 \,\tilde{r}^*) + (\tilde{q} \,\gamma_2^* \,\tilde{r}^*)_x \,,$$

which is obtained from (3.14), and the system

$$\begin{split} \tilde{q}_x &= \left(\frac{1}{2}I - \varphi_x\right) \tilde{q}^* Q^{-1} + \tilde{q} \, \gamma_1^* \, \tilde{\Omega}^{-1} Q^{-1} + \tilde{q} \, (Q^*)^{-1} \kappa_1^* \,, \\ \tilde{q}_y &= \frac{1}{2} \tilde{q}^* \, Q^* - \frac{1}{2} (\varphi - \varphi^*) \, \tilde{q} - \tilde{q} \, \gamma_2^* \, (\tilde{\Omega}^*)^{-1} - \tilde{q} \, \kappa_2^* \,, \\ \tilde{r}_x &= P^{-1} \, \tilde{r}^* \, (\varphi_x^* - \frac{1}{2}I) + P^{-1} (\tilde{\Omega}^*)^{-1} \, \gamma_1^* \, \tilde{r} + \lambda_1^* (P^*)^{-1} \tilde{r} \,, \\ \tilde{r}_y &= -\frac{1}{2} P^* \, \tilde{r}^* + \frac{1}{2} \tilde{r} \, (\varphi - \varphi^*) - \tilde{\Omega}^{-1} \, \gamma_2 \, \tilde{r} - \lambda_2^* \, \tilde{r} \,, \end{split}$$

which results from (3.15). { , } denotes the anti-commutator.

The extended Miura equation

$$\varphi_x = \frac{1}{2} (I - g (g^*)^{-1}) + \tilde{q} \gamma_1^* P^{-1} \tilde{r}^*, \qquad \frac{1}{2} (\varphi - \varphi^*) = -g_y g^{-1} + \tilde{q} \gamma_2^* (P^*)^{-1} \tilde{r},$$

obtained from (3.17), turns the last system into

$$\begin{split} \tilde{q}_x &= \frac{1}{2}g\left(g^*\right)^{-1}\tilde{q}^*Q^{-1} - \tilde{q}\gamma_1^*\left(P^{-1}\tilde{r}^*\tilde{q}^* - \tilde{\Omega}^{-1}\right)Q^{-1} + \tilde{q}\left(Q^*\right)^{-1}\kappa_1^*, \\ \tilde{q}_y &= g_y \,g^{-1}\tilde{q} + \frac{1}{2}\tilde{q}^*Q^* - \tilde{q}\,\gamma_2^*\left((P^*)^{-1}\tilde{r}\,\tilde{q} + (\tilde{\Omega}^*)^{-1}\right) - \tilde{q}\,\kappa_2^*, \\ \tilde{r}_x &= -\frac{1}{2}P^{-1}\tilde{r}^*g^*g^{-1} + P^{-1}\left(\tilde{r}^*\tilde{q}^*\gamma_1\left(P^*\right)^{-1} + (\tilde{\Omega}^*)^{-1}\gamma_1^*\right)\tilde{r} + \lambda_1^*(P^*)^{-1}\tilde{r}, \\ \tilde{r}_y &= -\tilde{r}\,g_y\,g^{-1} - \frac{1}{2}P^*\,\tilde{r}^* + \left(\tilde{r}\,\tilde{q}\,\gamma_2^*(P^*)^{-1} - \tilde{\Omega}^{-1}\gamma_2\right)\tilde{r} - \lambda_2^*\tilde{r}\,, \end{split}$$

and (3.18) has the form

$$(g_y g^{-1})_x - \frac{1}{4} \left(g \left(g^* \right)^{-1} - g^* g^{-1} \right) = \frac{1}{2} \left(\tilde{q} \gamma_1^* P^{-1} \tilde{r}^* - \tilde{q}^* \gamma_1 \left(P^* \right)^{-1} \tilde{r} \right) + \left(\tilde{q} \gamma_2^* \left(P^* \right)^{-1} \tilde{r} \right)_x.$$
(6.6)

The latter system is solved by

$$g = I - \theta \,(\tilde{\Omega}^*)^{-1} (Q^*)^{-1} \eta \,g_0 \,, \qquad \tilde{q} = \theta \,(\tilde{\Omega}^*)^{-1} \,, \qquad \tilde{r} = \tilde{\Omega}^{-1} \,\eta \,, \tag{6.7}$$

if g_0 is a solution of the source-free version of (6.6). Equations with self-consistent sources are now obtained as follows.

1. $\gamma_2 = 0$. In this case we have

$$\begin{aligned} \varphi_{xy} &- \frac{1}{2}(\varphi - \varphi^*) + \frac{1}{2} \left\{ \varphi - \varphi^* \,,\, \varphi_x \right\} = \frac{1}{2} (\tilde{q} \,\gamma_1^* \,\tilde{r} - \tilde{q}^* \,\gamma_1 \,\tilde{r}^*) \,, \\ \tilde{q}_y &= \frac{1}{2} \tilde{q}^* \,Q^* - \frac{1}{2} (\varphi - \varphi^*) \,\tilde{q} - \tilde{q} \,\kappa_2^* \,, \quad \tilde{r}_y = -\frac{1}{2} P^* \,\tilde{r}^* + \frac{1}{2} \tilde{r} \,(\varphi - \varphi^*) - \lambda_2^* \,\tilde{r} \,, \end{aligned}$$

and

$$(g_y g^{-1})_x - \frac{1}{4} \left(g \left(g^* \right)^{-1} - g^* g^{-1} \right) = \frac{1}{2} \left(\tilde{q} \gamma_1^* P^{-1} \tilde{r}^* - \tilde{q}^* \gamma_1 \left(P^* \right)^{-1} \tilde{r} \right) ,$$

$$\tilde{q}_y = g_y g^{-1} \tilde{q} + \frac{1}{2} \tilde{q}^* Q^* - \tilde{q} \kappa_2^* , \quad \tilde{r}_y = -\tilde{r} g_y g^{-1} - \frac{1}{2} P^* \tilde{r}^* - \lambda_2^* \tilde{r} .$$
(6.8)

2. $\gamma_1 = 0$. Then we have

$$\varphi_{xy} - \frac{1}{2}(\varphi - \varphi^*) + \frac{1}{2} \{\varphi - \varphi^*, \varphi_x\} = (\tilde{q} \gamma_2^* \tilde{r}^*)_x,$$

$$\tilde{q}_x = (\frac{1}{2}I - \varphi_x) \tilde{q}^* Q^{-1} + \tilde{q} (Q^*)^{-1} \kappa_1^*, \quad \tilde{r}_x = P^{-1} \tilde{r}^* (\varphi_x^* - \frac{1}{2}I) + \lambda_1^* (P^*)^{-1} \tilde{r},$$

and

$$(g_y g^{-1})_x - \frac{1}{4} \left(g \left(g^* \right)^{-1} - g^* g^{-1} \right) = \left(\tilde{q} \gamma_2^* (P^*)^{-1} \tilde{r} \right)_x,$$

$$\tilde{q}_x = \frac{1}{2} g \left(g^* \right)^{-1} \tilde{q}^* Q^{-1} + \tilde{q} \left(Q^* \right)^{-1} \kappa_1^*, \quad \tilde{r}_x = -\frac{1}{2} P^{-1} \tilde{r}^* g^* g^{-1} + \lambda_1^* (P^*)^{-1} \tilde{r}.$$
(6.9)

To turn this into a concrete system of PDEs, we have to specify \mathcal{A}_0 and the operator J. We note that for a *non-zero* choice of κ and λ , corresponding to $\kappa_i = \lambda_i = 0$, i = 1, 2, the above equations attain a particularly simple form.

Scalar sine-Gordon equations with self-consistent sources. Let $C^{\infty}(\mathbb{R}^2)$ be the algebra of smooth complex functions of real variables x and y. Let σ_j , j = 1, 2, 3, be the Pauli matrices, and $\mathcal{A}_0 = \{a I_2 + b \sigma_2 \mid a, b \in C^{\infty}(\mathbb{R}^2)\}$, which is a commutative algebra. We choose $J = \sigma_3$. Note that, for $f \in \mathcal{A}_0$, also $f^* \in \mathcal{A}_0$. Let

$$q = e^{\mathrm{i}\,\sigma_2\,u/2}\,,$$

with a complex function u. Then we have $g^* = e^{-i\sigma_2 u/2}$ and, for vanishing sources, (6.6) becomes the complex sine-Gordon equation $u_{xy} = \sin u$. Any $v \in \mathcal{A}_0$ has a unique decomposition $v = [v]_0 I_2 + [v]_1 i \sigma_2$, and we have $v^* = [v]_0 I_2 - [v]_1 i \sigma_2$.

1. $\gamma_2 = 0$. Setting $\kappa_2 = \lambda_2 = 0$, from (6.8) we obtain

$$u_{xy} - \sin u = -2 \, [\tilde{q} \, \tilde{\omega}_x^* \, \tilde{r}^*]_1 ,$$

$$\tilde{q}_y = \frac{i}{2} \, u_y \, \sigma_2 \, \tilde{q} + \frac{1}{2} \tilde{q}^* \, Q^* , \quad \tilde{r}_y = -\frac{i}{2} u_y \, \tilde{r} \, \sigma_2 - \frac{1}{2} P^* \, \tilde{r}^* .$$

Then $P_y = Q_y = 0$, so that P and Q are only allowed to depend on x. With the decomposition $\tilde{q} = f_1 \otimes I_2 + f_2 \otimes i \sigma_2$, $\tilde{r} = h_2 \otimes I_2 + h_1 \otimes i \sigma_2$, with row vectors f_i and column vectors h_i , and assuming $Q^* = Q$ and $P^* = P$, so that $Q = \tilde{Q} \otimes I_2$ and $P = \tilde{P} \otimes I_2$, the linear equations for \tilde{q} and \tilde{r} can be written as

$$\begin{pmatrix} \partial_y & u_y/2 \\ u_y/2 & -\partial_y \end{pmatrix} \begin{pmatrix} f_1 \\ f_2 \end{pmatrix} = \frac{1}{2} \begin{pmatrix} f_1 \tilde{Q} \\ f_2 \tilde{Q} \end{pmatrix}, \quad \begin{pmatrix} \partial_y & u_y/2 \\ u_y/2 & -\partial_y \end{pmatrix} \begin{pmatrix} h_1 \\ h_2 \end{pmatrix} = \frac{1}{2} \begin{pmatrix} \tilde{P} f_1 \\ \tilde{P} f_2 \end{pmatrix}.$$

Of course, the constraint (6.2) has to be taken into account. Due to the latter, $\tilde{\omega}_x$ can be absorbed by a redefinition of either \tilde{q} or \tilde{r} , while only exchanging P and Q in the respective linear equation. Then we obtain

$$u_{xy} - \sin u = f_1 h_1 - f_2 h_2 \,,$$

which establishes contact with the sine-Gordon equation with self-consistent sources considered, e.g., in [38].

2. $\gamma_1 = 0$. Setting $\kappa_1 = \lambda_1 = 0$, (6.9) becomes

$$u_{xy} - \sin u = 2 \left[\left(\tilde{q} \, \tilde{\omega}_y^* (P^*)^{-1} \, \tilde{r} \right)_x \right]_1,$$

$$\tilde{q}_x = \frac{1}{2} e^{\mathbf{i} \, \sigma_2 \, u} \, \tilde{q}^* \, Q^{-1}, \quad \tilde{r}_x = -\frac{1}{2} P^{-1} \tilde{r}^* \, e^{-\mathbf{i} \, \sigma_2 \, u}$$

In terms of the new variables $\hat{q} = \tilde{q} e^{-i\sigma_2 u/2}$ and $\hat{r} = e^{i\sigma_2 u/2} \tilde{r}$, this becomes

$$u_{xy} - \sin u = 2 \left[(\hat{q} \, \tilde{\omega}_y^* (P^*)^{-1} \hat{r})_x \right]_1,$$

$$\hat{q}_x = \frac{1}{2} \, \hat{q}^* \, Q^{-1} - \frac{i}{2} \, u_x \, \sigma_2 \, \hat{q}, \quad \hat{r}_x = -\frac{1}{2} P^{-1} \hat{r}^* + \frac{i}{2} \, u_x \, \sigma_2 \, \hat{r}$$

Then P and Q can only depend on y. We can absorb $\tilde{\omega}_y P^{-1}$ by a redefinition of \hat{q} , but in the linear equation for \hat{q} we have to replace Q by P^* (via an application of (6.2)). Then, writing $\hat{q} = f_1 \otimes I_2 + f_2 \otimes i \sigma_2$, $\hat{r} = f_2^{\mathsf{T}} \otimes I_2 + f_1^{\mathsf{T}} \otimes i \sigma_2$ (where T denotes the transpose), and setting $P = (P^*)^{\mathsf{T}}$, we obtain

$$u_{xy} - \sin u = 2 \left(f_1 f_1^{\mathsf{T}} + f_2 f_2^{\mathsf{T}} \right)_x,$$

and thus the sine-Gordon equation with self-consistent sources considered in [39, 40]. Of course, we still have to respect the constraint (6.2).

With the above choice for \mathcal{A}_0 and J, the systems (6.8) and (6.9) can thus be regarded as matrix generalizations of the above sine-Gordon equations with self-consistent sources. The corresponding systems involving φ instead of g are Miura-duals of them.

Remark 6.1. A simpler choice for \mathcal{A}_0 and the involution * is the algebra of smooth complex functions on \mathbb{R}^2 together with complex conjugation. In the scalar case (m = 1), we then set $g = e^{i u/2}$, with real u. This leads to similar results, but there is a restriction to self-consistent source extensions of the *real* sine-Gordon equation. The slightly more complicated setting we chose above is more flexible.

Exact solutions in case of trivial seed. We set $\kappa_1 = \kappa_2 = \lambda_1 = \lambda_2 = 0$, and $P = I_2 \otimes \tilde{P}$, $Q = \tilde{Q} \otimes I_2$, with constant complex matrices \tilde{P} and \tilde{Q} . Then we have $P = P^*$ and $Q = Q^*$, and special solutions of the linear equations (6.1) with $\varphi_0 = 0$ are given by

$$\begin{aligned} \theta &= a_0 \, e^{\vartheta(P)/2} \otimes I_2 + a_1 \, e^{-\vartheta(P)/2} \otimes \operatorname{i} \sigma_2 \,, \qquad \eta &= e^{-\vartheta(Q)/2} \, b_0 \otimes I_2 + e^{\vartheta(Q)/2} \, b_1 \otimes \operatorname{i} \sigma_2 \,, \\ \vartheta(K) &:= x \, K^{-1} + y \, K \,, \end{aligned}$$

with constant complex $1 \times n$ matrices a_i and $n \times 1$ matrices b_i . The equations (6.3) and (6.4) are solved by $\tilde{\Omega} = [\tilde{\Omega}]_0 \otimes I_2 + [\tilde{\Omega}]_1 \otimes i \sigma_2$ with

$$\begin{split} & [\tilde{\Omega}]_0 = e^{-\vartheta(\tilde{Q})/2} A_0 \, e^{\vartheta(\tilde{P})/2} + e^{\vartheta(\tilde{Q})/2} B_0 \, e^{-\vartheta(\tilde{P})/2} + [\tilde{\omega}]_0 \,, \\ & [\tilde{\Omega}]_1 = e^{-\vartheta(\tilde{Q})/2} A_1 \, e^{-\vartheta(\tilde{P})/2} + e^{\vartheta(\tilde{Q})/2} B_1 \, e^{\vartheta(\tilde{P})/2} + [\tilde{\omega}]_1 \,, \end{split}$$

where the constant complex matrices A_0, A_1, B_0, B_1 are subject to the Sylvester equations

$$\tilde{Q}A_0 - A_0\tilde{P} = b_0 a_0$$
, $\tilde{Q}B_0 - B_0\tilde{P} = b_1 a_1$, $\tilde{Q}A_1 + A_1\tilde{P} = -b_0 a_1$, $\tilde{Q}B_1 + B_1\tilde{P} = -a_0 b_1$,

and ω has to satisfy (6.2). Now (6.7), with constant g_0 , leads to a class of exact solutions of the above scalar sine-Gordon equations with self-consistent sources.

7 Matrix Nonlinear Schrödinger equation with self-consistent sources

Let \mathcal{A} be the algebra of $M \times M$ matrices of smooth functions of coordinates x and t on \mathbb{R}^2 . We define a bidifferential calculus on \mathcal{A} via

$$df = -\frac{1}{2} [J, f] \xi_1 + [\partial, f] \xi_2, \qquad \bar{d}f = [\partial, f] \xi_1 - [i \partial_t, f] \xi_2,$$

where $J \neq I$ is a constant $M \times M$ matrix, i.e., $J_x = J_t = 0$, satisfying $J^2 = I$ (also see [41]). d and \bar{d} extend to matrices over A and to the corresponding graded algebra. We set m = 1 and

$$\Delta = P, \quad \Gamma = Q, \quad \kappa = (\kappa_1 - \frac{1}{2}QJ)\xi_1 + (\kappa_2 - Q\kappa_1)\xi_2, \quad \lambda = (\lambda_1 + \frac{1}{2}JP)\xi_1 + (\lambda_2 - \lambda_1 P)\xi_2,$$

where $P, Q, \kappa_i, \lambda_i$ are matrices over \mathcal{A}_0 . Then the equations (3.7) lead to

$$\begin{split} P_x &= \left[P, \lambda_1\right], \qquad \mathrm{i}\, P_t = -\left[P, \lambda_2\right], \qquad \mathrm{i}\, \lambda_{1,t} + \lambda_{2,x} = -\left[\lambda_1, \lambda_2\right], \\ Q_x &= -\left[Q, \kappa_1\right], \qquad \mathrm{i}\, Q_t = \left[Q, \kappa_2\right], \qquad \mathrm{i}\, \kappa_{1,t} + \kappa_{2,x} = \left[\lambda_1, \lambda_2\right], \end{split}$$

(3.16) becomes

$$Q\,\omega = \omega P\,,\tag{7.1}$$

and the second equation in (3.11) reads

$$\gamma = \gamma_1 \xi_1 + (\gamma_2 - \gamma_1 P) \xi_2, \quad \gamma_1 = \omega_x - \kappa_1 \omega - \omega \lambda_1, \quad \gamma_2 = -\mathbf{i} \omega_t - \kappa_2 \omega - \omega \lambda_2.$$

The linear equations (3.5) and (3.6) take the form

$$\theta_{x} = \frac{1}{2}J\theta P + \theta\lambda_{1} + \frac{1}{2}[J,\phi_{0}]\theta, \quad i\theta_{t} = -\frac{1}{2}J\theta P^{2} - \theta\lambda_{2} - \frac{1}{2}[J,\phi_{0}]\theta P - \phi_{0,x}\theta,$$

$$\eta_{x} = -\frac{1}{2}Q\eta J + \kappa_{1}\eta - \frac{1}{2}\eta[J,\phi_{0}], \quad i\eta_{t} = \frac{1}{2}Q^{2}\eta J - \kappa_{2}\eta + \frac{1}{2}Q\eta[J,\phi_{0}] + \eta\phi_{0,x}, \quad (7.2)$$

and (3.10) results in

$$Q\Omega - \Omega P = \eta \,\theta \,, \qquad \Omega_x = -\frac{1}{2}\eta \,J \,\theta + \kappa_1 \omega + \Omega \lambda_1 + \gamma_1 \,,$$

$$i \,\Omega_t = \frac{1}{2} (Q\eta \,J \,\theta + \eta J \theta P) - \kappa_2 \,\Omega - \Omega \lambda_2 + \frac{1}{2}\eta \,[J, \phi_0] \,\theta - \gamma_2 \,. \tag{7.3}$$

Now ϕ, q, r given by (3.13) solve

$$\frac{i}{2}[J,\phi_t] + \phi_{xx} - \frac{1}{2}[[J,\phi],\phi_x] = (q\gamma_1 r)_x - \frac{1}{2}[J,q(\gamma_2 - \gamma_1 P)r]$$

and

$$\begin{split} q_x &= \frac{1}{2} Jq \, Q - q \, \kappa_1 + \frac{1}{2} [J, \phi] \, q - q \, \gamma_1 \, \Omega^{-1} \,, \\ \mathrm{i} \, q_t &= -\frac{1}{2} Jq \, Q^2 + q \, \kappa_2 - \phi_x \, q - \frac{1}{2} [J, \phi] \, q \, Q + q \, \gamma_1 \, r \, q + q \gamma_2 \, \Omega^{-1} \,, \\ r_x &= -\frac{1}{2} Pr J - \lambda_1 r - \frac{1}{2} r \, [J, \phi] - \Omega^{-1} \gamma_1 \, r \,, \\ \mathrm{i} \, r_t &= \frac{1}{2} P^2 r J + \lambda_2 \, r + r \, \phi_x + \frac{1}{2} Pr \, [J, \phi] - r \, q \, \gamma_1 \, r + \Omega^{-1} \gamma_2 \, r \,. \end{split}$$

Next we choose $J = \text{block-diag}(I_{M_1}, -I_{M_2})$, where $M_1 + M_2 = M$, and use the block decompositions

$$\phi = J \begin{pmatrix} u & \mathfrak{q} \\ \mathfrak{r} & v \end{pmatrix} = \begin{pmatrix} u & \mathfrak{q} \\ -\mathfrak{r} & -v \end{pmatrix}, \quad q = \begin{pmatrix} q_1 \\ q_2 \end{pmatrix}, \quad r = \begin{pmatrix} r_1 & r_2 \end{pmatrix}, \quad (7.4)$$

where u, v, q, r are, respectively, $M_1 \times M_1$, $M_2 \times M_2$, $M_1 \times M_2$ and $M_2 \times M_1$ matrices. q_1 and q_2 have size $M_1 \times (M \cdot n)$ and $M_2 \times (M \cdot n)$, respectively. Then we obtain the following AKNS equations with self-consistent sources. Here and in the following we set $\kappa_i = \lambda_i = 0$, in which case P and Q have to be constant.

1.
$$\gamma_1 = \omega_x = 0.$$

In both cases, Q, P and ω still have to satisfy (7.1). Via a Hermitian conjugation reduction, see below, these systems become matrix versions of two kinds of (scalar) Nonlinear Schrödinger (NLS) equations with self-consistent sources. The second system seems to be new, even in the scalar case.

Hermitian conjugation reductions. Imposing the conditions

We can set $\epsilon_1 = 1$, since it can be absorbed into ω . Though ω_x can be absorbed (e.g., by redefinitions of r_1 and r_2 , before the reduction), we cannot simultaneously absorb Q on the right hand side of the first equation. The last system is therefore of a different nature than the familiar integrable equations with self-consistent sources. In contrast to (7.8), the equations for q_1 and q_2 are *non*linear in the system (7.9).

In both cases, Q and ω also have to satisfy $Q \omega + \omega Q^{\dagger} = 0$, as a consequence of (7.1). This severely restricts Q if $\omega \neq 0$. If $\omega = \beta I_{nM}$, with a scalar β , then $Q^{\dagger} = -Q$. For diagonal Q, this

restricts its eigenvalues to be imaginary, a restriction that also appears in [43], in the focusing NLS case $\varepsilon = -1$. $\varepsilon = 1$ is the defocusing case.

The above reduction conditions (7.7) for q, r, u, v, q_i, r_i can be expressed as follows,

If Q and $-Q^{\dagger}$ have no eigenvalue in common, the solutions A and B are unique and Hermitian. But $Q\omega + \omega Q^{\dagger} = 0$ then implies $\omega = 0$. Thus, in order to obtain solutions of (7.8) or (7.9) with $\omega \neq 0$, the spectrum condition for Q needs to be violated. Requiring $A^{\dagger} = A$ and $B^{\dagger} = B$, then Ω is Hermitian, since $\vartheta(Q)^{\dagger} = -\vartheta(-Q^{\dagger})$, and ϕ satisfies the reduction condition. If ω and Q satisfy $Q\omega + \omega Q^{\dagger} = 0$, and if $\omega_x = 0$ or $\omega_t = 0$, then

provides us with exact solutions of the above matrix NLS equations with self-consistent sources. In the defocusing NLS case, it is more interesting to start with a constant density seed solution (see, e.g., [43]).

8 Matrix Davey-Stewartson equation with self-consistent sources

Let \mathcal{A}_0 be the algebra of $M \times M$ matrices of smooth complex functions on \mathbb{R}^3 , and $\mathcal{A} = \mathcal{A}_0[\partial]$, where ∂ is again the partial differentiation operator with respect to x. We define a bidifferential calculus on \mathcal{A} via

Hermitian conjugation reductions. (8.5) and (8.6), and its special cases (8.7) and (8.8), are compatible with the reduction conditions (7.10). In order that the solution generating procedure respects the reduction conditions, we also have to require

Remark 8.1. In the scalar case, i.e., $M_1 = M_2 = 1$, the inhomogeneous linear equations for u and v in (8.9) integrate to $u_y - u_x = -\varepsilon |\mathbf{q}|^2 = v_y + v_x$, dropping "constants" of integration. This is solved by $u = w_y + w_x$ and $v = w_y - w_x$, with a function w, and we obtain $w_{xx} - w_{yy} = \varepsilon |\mathbf{q}|^2$. The first of equations (8.9) then takes the form $\mathbf{i} \mathbf{q}_t + \mathbf{q}_{xx} + \mathbf{q}_{yy} + 2(w_{xx} + w_{yy}) \mathbf{q} = -\mathbf{i} \varepsilon q_1 \omega_t q_2^{\dagger}$. Passing over to "light cone variables", we recover the DS equation with self-consistent sources treated in [44] (also see [45]).

Remark 8.2. We consider again the scalar case $M_1 = M_2 = 1$. Introducing the new variable $s = u + v + \int^y (u_x - v_x - 2\varepsilon |\mathbf{q}|^2) dy$, from (8.9) we obtain

Here h(x) is an arbitrary function of x, which can be eliminated by a redefinition of s. In this way we recover the system of Example 3 in [46].

Remark 8.3. Assuming that all objects do not depend on the variable x, (8.9) reduces to the NLS equation in Section 7 up to changes in notation $(J \mapsto -J)$, and y has finally to be renamed to x). We note that the second of equations (8.4) becomes a constraint: $\eta J \theta = 0$. As formulated above, our solution generating method does not work for this NLS reduction. This can be corrected by extending the first equations in (8.2) to $\Delta = -2I_n \partial + P$ and $\Gamma = -2I_n \partial + Q$, with constant $n \times n$ matrices P, Q, and generalizing the subsequent equations accordingly. In particular, we need non-vanishing κ and λ , cf. Section 7. The matrices P and Q are redundant on the level of DS.

Dropping in (8.1) the partial derivatives with respect to x, we recover the bidifferential calculus for the NLS system in Section 7, up to the stated changes in notation. Dropping instead the partial derivatives with respect to y, we obtain a bidifferential calculus for the NLS system different from that used in Section 7.

Exact solutions in case of vanishing seed. Let $\phi_0 = 0$. The linear equations (8.3) are solved by

$$\Omega = \begin{pmatrix} \omega_{11} - \frac{1}{4\operatorname{Re}(\lambda_1)} e^{\alpha_1} & \omega_{12} \\ \omega_{12}^* & \omega_{22} - \frac{1}{4\operatorname{Re}(\lambda_2)} e^{\alpha_2} \end{pmatrix},$$

where

$$\alpha_1 = 2\operatorname{Re}(\lambda_1)(x+y) - 8\operatorname{Re}(\lambda_1)\operatorname{Im}(\lambda_1)t, \quad \alpha_2 = 2\operatorname{Re}(\lambda_2)(y-x) + 8\operatorname{Re}(\lambda_2)\operatorname{Im}(\lambda_2)t.$$

Hence

$$\det(\Omega) = \omega_{11}\,\omega_{22} - |\omega_{12}|^2 - \frac{\omega_{22}}{4\,\mathrm{Re}(\lambda_1)}\,e^{\alpha_1} - \frac{\omega_{11}}{4\,\mathrm{Re}(\lambda_2)}\,e^{\alpha_2} + \frac{1}{4\,\mathrm{Re}(\lambda_1)\,\mathrm{Re}(\lambda_2)}\,e^{\alpha_1 + \alpha_2}\,.$$

Evaluation of $\phi = -\theta \, \Omega^{-1} \theta^{\dagger} \Lambda$ and its decomposition now leads to

$$\begin{aligned} \mathbf{q} &= -\frac{\varepsilon \,\omega_{12}}{\det(\Omega)} \,e^{(\lambda_1 - \lambda_2^*) \,x + (\lambda_1 + \lambda_2^*) \,y + 2\mathbf{i} \,(\lambda_1^2 + (\lambda_2^*)^2) \,t} \,, \\ u &= -\frac{1}{\det(\Omega)} \,e^{\alpha_1} \left(\omega_{22} - \frac{1}{4\operatorname{Re}(\lambda_2)} \,e^{\alpha_2}\right), \quad v = -\frac{\varepsilon}{\det(\Omega)} \,e^{\alpha_2} \left(\omega_{11} - \frac{1}{4\operatorname{Re}(\lambda_1)} \,e^{\alpha_1}\right) \end{aligned}$$

From $q = \theta \Omega^{-1}$ we obtain

$$q_1 = \frac{1}{\det(\Omega)} e^{\vartheta_1(\lambda_1)} \left(\omega_{22} - \frac{1}{4\operatorname{Re}(\lambda_2)} e^{\alpha_2}, -\omega_{12}\right),$$
$$q_2 = \frac{1}{\det(\Omega)} e^{\vartheta_1(\lambda_2)} \left(-\omega_{12}^*, \omega_{11} - \frac{1}{4\operatorname{Re}(\lambda_1)} e^{\alpha_1}\right).$$

If det(Ω) nowhere vanishes, this solution is regular. If ω is constant, it describes a single dromion solution of the DS equation [47–50], or its degeneration to a solitoff [51] or a soliton. A solution of a DS equation with self-consistent sources, with non-constant ω , can change its type. In particular, we find the following.

- 1. In a region where $det(\omega) < 0$, $\omega_{11} \operatorname{Re}(\lambda_2) > 0$, $\omega_{22} \operatorname{Re}(\lambda_1) > 0$, $\operatorname{Re}(\lambda_1) \operatorname{Re}(\lambda_2) < 0$, the above solution describes a single dromion [49].
- 2. If det(ω) = 0, $\omega_{11} \operatorname{Re}(\lambda_2) > 0$, $\omega_{22} \operatorname{Re}(\lambda_1) > 0$, $\operatorname{Re}(\lambda_1) \operatorname{Re}(\lambda_2) < 0$, we have a single solitoff solution [51].
- 3. If $\omega_{11} = \omega_{22} = 0$, $\operatorname{Re}(\lambda_1) \operatorname{Re}(\lambda_2) < 0$, the solution represents a single soliton.

A nonlinear superposition of n of such elementary solutions is obtained by taking a_{\pm} to be a row of $n \ 2 \times 2$ matrices of the above form, and $P_i = \text{block-diagonal}(\lambda_{i1} I_2, \ldots, \lambda_{in} I_2)$.

9 Matrix two-dimensional Toda lattice equation with self-consistent sources

Let \mathcal{A}_0 be the space of complex functions on $\mathbb{R}^2 \times \mathbb{Z}$, smooth in the first two variables. We extend it to $\mathcal{A} = \mathcal{A}_0[\mathbb{S}, \mathbb{S}^{-1}]$, where \mathbb{S} is the shift operator in the discrete variable $k \in \mathbb{Z}$. A bidifferential calculus is determined by setting

$$df = [\mathbb{S}, f] \xi_1 + [\partial_y, f] \xi_2, \qquad \bar{d}f = [\partial_x, f] \xi_1 - [\mathbb{S}^{-1}, f] \xi_2$$

on \mathcal{A} [20]. For $f \in \mathcal{A}$, we write $f^{\pm}(x, y, k) := f(x, y, k \pm 1)$. We set

$$\phi = \varphi \, \mathbb{S}^{-1} \,, \quad q = \tilde{q} \, \mathbb{S}^{-1} \,, \quad r = \mathbb{S}^{-1} \, \tilde{r} \,, \quad \Delta = \Gamma = \mathbb{S}^{-1} \,, \quad \kappa = \lambda = 0 \,, \quad \Omega = \tilde{\Omega} \, \mathbb{S} \,, \quad \omega = \tilde{\omega} \, \mathbb{S} \,.$$

Then (3.7) is satisfied, (3.16) becomes $\tilde{\omega}^+ = \tilde{\omega}$, and the second equation in (3.11) leads to

$$\gamma = \tilde{\omega}_x \, \mathbb{S} \, \xi_1 - \tilde{\omega}_y \, \xi_2 \, .$$

Now (3.14) becomes⁷

$$\varphi_{xy} - (\varphi^+ - \varphi) (\varphi_y + I) + (\varphi_y + I) (\varphi - \varphi^-) = (\tilde{q} \,\tilde{\omega}_x \,\tilde{r}^-)_y + [\tilde{q}^+ \,\tilde{\omega}_y \,\tilde{r}^- - (\tilde{q}^+ \,\tilde{\omega}_y \,\tilde{r}^-)^-] \,. \tag{9.1}$$

⁷For vanishing right hand side, this equation already appeared in [20].

Remark 9.1. In the scalar case, in terms of $V := \varphi_y$, (9.1) without sources becomes $(\ln(1 + V))_x = \varphi^+ - \varphi + \varphi^-$. Differentiating with respect to y, this becomes the *two-dimensional Toda* lattice equation $(\ln(1 + V))_{xy} = V^+ - 2V + V^-$ [52–54]. A self-consistent source extension, and corresponding exact solutions, has been obtained in [55] (also see [56]), using the framework of Hirota's bilinear difference operators [54]. (9.1) leads to a matrix version.

Let φ_0 be a solution of (9.1) with vanishing sources. The linear equations (3.5) and (3.6) read

$$\theta_x = \theta^+ - \theta + (\varphi_0^+ - \varphi_0) \theta, \qquad \theta_y = \theta - \theta^- - \varphi_{0,y} \theta^-, \eta_x = \eta - \eta^- - \eta (\varphi_0^+ - \varphi_0), \qquad \eta_y = \eta^+ - \eta + \eta^+ \varphi_{0,y}^+,$$
(9.2)

and from (3.10) we obtain

$$\tilde{\Omega} - \tilde{\Omega}^{-} = -\eta \,\theta \,, \qquad \tilde{\Omega}_{x} = -\eta \,\theta^{+} + \tilde{\omega}_{x} \,, \qquad \tilde{\Omega}_{y} = -\eta^{+} \left(\varphi_{0,y}^{+} + I\right) \theta + \tilde{\omega}_{y} \,. \tag{9.3}$$

If θ, η and $\tilde{\Omega}$ solve the preceding equations, then

$$\varphi = \varphi_0 - \theta \,(\tilde{\Omega}^-)^{-1} \,\eta^-, \qquad \tilde{q} = \theta \,(\tilde{\Omega}^-)^{-1} \,, \qquad \tilde{r} = \tilde{\Omega}^{-1} \,\eta \tag{9.4}$$

satisfy (9.1) and the system

$$\tilde{q}_{x} = \tilde{q}^{+} - \tilde{q} + (\varphi^{+} - \varphi) \tilde{q} - \tilde{q} \tilde{\omega}_{x} (\tilde{\Omega}^{-})^{-1},
\tilde{q}_{y} = \tilde{q} - \tilde{q}^{-} - \varphi_{y} \tilde{q}^{-} - \tilde{q} \tilde{\omega}_{y} (\tilde{\Omega}^{--})^{-1},
\tilde{r}_{x} = \tilde{r} - \tilde{r}^{-} - \tilde{r} (\varphi^{+} - \varphi) - \tilde{\Omega}^{-1} \tilde{\omega}_{x} \tilde{r},
\tilde{r}_{y} = \tilde{r}^{+} - \tilde{r} + \tilde{r}^{+} \varphi_{y}^{+} - (\tilde{\Omega}^{+})^{-1} \tilde{\omega}_{y} \tilde{r},$$
(9.5)

which results from (3.15).

Using the extended Miura transformation,

$$\varphi^+ - \varphi = g_x g^{-1} - \tilde{q} \,\tilde{\omega}_x \,\tilde{r} \,, \qquad \varphi_y + I = (g^+ g^{-1} + \tilde{q}^+ \,\tilde{\omega}_y \,\tilde{r})^- \,,$$

the system (9.5) becomes

$$\begin{aligned}
\tilde{q}_{x} &= \tilde{q}^{+} - \tilde{q} + (g_{x} g^{-1} - \tilde{q} \tilde{\omega}_{x} \tilde{r}) \tilde{q} - \tilde{q} \tilde{\omega}_{x} (\tilde{\Omega}^{-})^{-1}, \\
\tilde{q}_{y} &= \tilde{q} - (g^{+} g^{-1} + \tilde{q}^{+} \tilde{\omega}_{y} \tilde{r})^{-} \tilde{q}^{-} - \tilde{q} \tilde{\omega}_{y} (\tilde{\Omega}^{--})^{-1}, \\
\tilde{r}_{x} &= \tilde{r} - \tilde{r}^{-} - \tilde{r} (g_{x} g^{-1} - \tilde{q} \tilde{\omega}_{x} \tilde{r}) - \tilde{\Omega}^{-1} \tilde{\omega}_{x} \tilde{r}, \\
\tilde{r}_{y} &= -\tilde{r} + \tilde{r}^{+} (g^{+} g^{-1} + \tilde{q}^{+} \tilde{\omega}_{y} \tilde{r}) - (\tilde{\Omega}^{+})^{-1} \tilde{\omega}_{y} \tilde{r},
\end{aligned} \tag{9.6}$$

and (3.18) reads⁸

$$(g_x g^{-1})_y - [g^+ g^{-1} - (g^+ g^{-1})^-] = + (\tilde{q} \,\tilde{\omega}_x \,\tilde{r})_y + [\tilde{q}^+ \,\tilde{\omega}_y \,\tilde{r} - (\tilde{q}^+ \,\tilde{\omega}_y \,\tilde{r})^-].$$
(9.7)

This system is solved by

$$g = I - \theta \,(\tilde{\Omega}^{-})^{-1} \,\eta \,, \tag{9.8}$$

together with \tilde{q} and \tilde{r} given by (9.4).

Equations (9.1) and (9.5), respectively (9.6) and (9.7), lead to versions of a two-dimensional matrix Toda lattice equation with self-consistent sources in the following cases.

⁸In the scalar case, writing $g = e^{u}$, the left hand side of (9.7) becomes $u_{xy} - e^{u^{+}-u} + e^{u-u^{-}}$.

1. $\tilde{\omega}_x = 0.$ (9.1) reduces to

$$\varphi_{xy} - (\varphi^+ - \varphi) (\varphi_y + I) + (\varphi_y + I) (\varphi - \varphi^-) = \tilde{q}^+ \tilde{\omega}_y \tilde{r}^- - (\tilde{q}^+ \tilde{\omega}_y \tilde{r}^-)^-.$$
(9.9)

Those of the equations (9.5) that do not involve $\tilde{\Omega}$ are

$$\tilde{q}_x = \tilde{q}^+ - \tilde{q} + (\varphi^+ - \varphi) \,\tilde{q} \,, \qquad \tilde{r}_x = \tilde{r} - \tilde{r}^- - \tilde{r} \left(\varphi^+ - \varphi\right) \,. \tag{9.10}$$

(9.9) and (9.10) constitute the first type of the two-dimensional matrix Toda lattice equation with self-consistent sources.

Correspondingly, (9.7) and (9.6) reduce to

$$(g_x g^{-1})_y - [g^+ g^{-1} - (g^+ g^{-1})^-] = \tilde{q}^+ \tilde{\omega}_y \,\tilde{r} - (\tilde{q}^+ \tilde{\omega}_y \,\tilde{r})^-, \tilde{q}_x = \tilde{q}^+ - \tilde{q} + g_x \, g^{-1} \,\tilde{q}, \qquad \tilde{r}_x = \tilde{r} - \tilde{r}^- - \tilde{r} \, g_x \, g^{-1}.$$
(9.11)

These equations constitute the Miura-dual of the first type of the two-dimensional matrix Toda lattice equation with self-consistent sources. In the scalar case, in terms of $u = \ln g$ this takes the form

$$u_{xy} - e^{u^+ - u} + e^{u - u^-} = \tilde{q}^+ \tilde{\omega}_y \,\tilde{r} - (\tilde{q}^+ \tilde{\omega}_y \,\tilde{r})^-,$$

$$\tilde{q}_x = \tilde{q}^+ - \tilde{q} + u_x \,\tilde{q}, \qquad \tilde{r}_x = \tilde{r} - \tilde{r}^- - u_x \,\tilde{r}.$$

2. $\tilde{\omega}_y = 0.$ (9.1) becomes

$$\varphi_{xy} - (\varphi^+ - \varphi) (\varphi_y + I) + (\varphi_y + I) (\varphi - \varphi^-) = (\tilde{q} \,\tilde{\omega}_x \,\tilde{r}^-)_y \,. \tag{9.12}$$

Those of equations (9.5) that do not depend on $\tilde{\Omega}$ are

$$\tilde{q}_y = \tilde{q} - \tilde{q}^- - \varphi_y \,\tilde{q}^-, \qquad \tilde{r}_y = \tilde{r}^+ - \tilde{r} + \tilde{r}^+ \,\varphi_y^+.$$
(9.13)

(9.12) and (9.13) constitute the second type of the two-dimensional matrix Toda lattice equation with self-consistent sources.

From (9.7) and (9.6) we obtain the corresponding Miura-dual,

$$(g_x g^{-1})_y - [g^+ g^{-1} - (g^+ g^{-1})^-] = (\tilde{q} \,\tilde{\omega}_x \,\tilde{r})_y, \tilde{q}_y = \tilde{q} - g \,(g^{-1} \,\tilde{q})^-, \qquad \tilde{r}_y = -\tilde{r} + \tilde{r}^+ g^+ g^{-1}.$$
(9.14)

In the scalar case (m = 1), in terms of $u = \ln g$, $a = e^{-y} g^{-1} \tilde{q} \tilde{\omega}_x$ and $b = e^y g \tilde{r}$, (9.14) can be expressed as follows,

$$u_{xy} - e^{u^+ - u} + e^{u - u^-} = (a b)_y, \quad a_y + u_y a + a^- = 0, \quad b_y - b u_y - b^+ = 0.$$

Such a system appeared in [57].

The above matrix versions of the two-dimensional Toda lattice equations with self-consistent sources are new according to our knowledge.

Explicit solutions for trivial seed. Let $\varphi_0 = 0$ and $g_0 = I$. Then (9.2) becomes

$$\theta_x = \theta^+ - \theta$$
, $\theta_y = \theta - \theta^-$, $\eta_x = \eta - \eta^-$, $\eta_y = \eta^+ - \eta$.

Special solutions are given by

$$\theta = a \, e^{\vartheta(P)} \, P^k \, A \,, \quad \eta = B \, e^{-\vartheta(Q)} \, Q^{-k} \, b , \quad \vartheta(P) := (P - I) \, x + (I - P^{-1}) \, y \,,$$

with arbitrary constant matrices a, b, A, B, P, Q of appropriate size. (9.3) leads to

$$\tilde{\Omega} = \tilde{\omega} - B \, e^{-\vartheta(Q)} \, Q^{-k} \, X \, e^{\vartheta(P)} \, P^{k+1} \, A \,,$$

where the constant matrix X has to satisfy the Sylvester equation

$$XP - QX = ba.$$

Then (9.4) and (9.8) provide us with explicit solutions of the above matrix two-dimensional Toda lattice equations with self-consistent sources.

10 A generalized discrete KP equation with self-consistent sources

Let \mathcal{A}_0 be the space of complex functions of discrete variables $k_0, k_1, k_2 \in \mathbb{Z}$, and $\mathbb{S}_0, \mathbb{S}_1, \mathbb{S}_2$ corresponding shift operators. We extend \mathcal{A}_0 to $\mathcal{A} = \mathcal{A}_0[\mathbb{S}_0^{\pm 1}, \mathbb{S}_1^{\pm 1}, \mathbb{S}_2^{\pm 1}]$ and define d and \overline{d} on \mathcal{A} via

$$df = \sum_{i=1}^{2} c_{i}^{-1} \left[\mathbb{S}_{i}^{-1}, f \right] \xi_{i}, \qquad \bar{d}f = \sum_{i=1}^{2} \left[\mathbb{S}_{i}^{-1} \mathbb{S}_{0}, f \right] \xi_{i}, \qquad (10.1)$$

where c_i are constants. Then d and \bar{d} extend to $\Omega = \mathcal{A} \otimes \Lambda$ and to matrices over Ω . In the following we will use the notation

$$f_{,0} := \mathbb{S}_0 f \mathbb{S}_0^{-1}, \quad f_{,-0} := \mathbb{S}_0^{-1} f \mathbb{S}_0, \quad f_{,i} := \mathbb{S}_i f \mathbb{S}_i^{-1}, \quad f_{,-i} := \mathbb{S}_i^{-1} f \mathbb{S}_i \qquad i = 1, 2.$$

We set

$$\Delta = \Gamma = \mathbb{S}_0, \quad \kappa = \lambda = 0, \quad \Omega = \tilde{\Omega} \, \mathbb{S}_0^{-1}, \quad \omega = \tilde{\omega} \, \mathbb{S}_0^{-1}, \quad \phi = \varphi \, \mathbb{S}_0, \quad q = \tilde{q} \, \mathbb{S}_0, \quad r = \mathbb{S}_0 \, \tilde{r} \, .$$

Then (3.7) is satisfied, (3.16) becomes $\tilde{\omega}_{,0} = \tilde{\omega}$, and the second equation in (3.11) leads to

$$\gamma = \sum_{i=1}^{2} \mathbb{S}_{i}^{-1} \gamma_{i} \xi_{i}, \qquad \gamma_{i} := (c_{i}^{-1} - 1)(\tilde{\omega}_{,i} - \tilde{\omega}).$$

The linear equations (3.5) and (3.6) read

$$\theta_{,i} = (c_i - 1)^{-1} \left[(c_i + \varphi_{0,i} - \varphi_0) \theta_{,0} - \theta \right], \eta_{,-i} = (c_i - 1)^{-1} \left[\eta_{,-0} (c_i + \varphi_0 - \varphi_{0,-i})_{,-0} - \eta \right],$$

and from (3.10) we obtain

$$\tilde{\Omega}_{,0} - \tilde{\Omega} = \eta \,\theta \,, \qquad \tilde{\Omega} - \tilde{\Omega}_{,-i} = (c_i - 1)^{-1} \,\eta_{,-0} \,\left(c_i + \varphi_0 - \varphi_{0,-i}\right)_{,-0} \,\theta_{,-i} - \tilde{\omega} + \tilde{\omega}_{,-i} \,.$$

Given solutions θ, η and $\tilde{\Omega}$, according to Section 3,

$$\varphi = \varphi_0 - \theta \,\tilde{\Omega}_{,0}^{-1} \,\eta_{,0} \,, \qquad \tilde{q} = \theta \,\tilde{\Omega}_{,0}^{-1} \,, \qquad \tilde{r} = \tilde{\Omega}^{-1} \,\eta \tag{10.2}$$

solve the equations

$$\begin{aligned} (c_j + \varphi_{,j} - \varphi)_{,i} & (c_i + \varphi_{,i} - \varphi)_{,0} - (c_i + \varphi_{,i} - \varphi)_{,j} (c_j + \varphi_{,j} - \varphi)_{,0} \\ &= (c_i - 1) \left[(\tilde{q}_{,i} \left(\tilde{\omega}_{,i} - \tilde{\omega} \right) \tilde{r}_{,0,0})_{,j} - \tilde{q}_{,i} \left(\tilde{\omega}_{,i} - \tilde{\omega} \right) \tilde{r}_{,0,0} \right] \\ &- (c_j - 1) \left[(\tilde{q}_{,j} \left(\tilde{\omega}_{,j} - \tilde{\omega} \right) \tilde{r}_{,0,0})_{,i} - \tilde{q}_{,j} \left(\tilde{\omega}_{,j} - \tilde{\omega} \right) \tilde{r}_{,0,0} \right] \end{aligned} \qquad i, j = 1, 2 \end{aligned}$$

and

$$\tilde{q}_{,i} = (c_i - 1)^{-1} [(c_i + \varphi_{,i} - \varphi) \,\tilde{q}_{,0} - \tilde{q}] - \tilde{q}_{,i} \,(\tilde{\omega}_{,i} - \tilde{\omega}) \,\tilde{\Omega}_{,0,0}^{-1} , \tilde{r}_{,-i} = (c_i - 1)^{-1} [\tilde{r}_{,-0} \,(c_i + \varphi - \varphi_{,-i})_{,-0} - \tilde{r}] + \tilde{\Omega}_{,0}^{-1} \,(\tilde{\omega} - \tilde{\omega}_{,-i}) \,\tilde{r}_{,-i} , \qquad i = 1, 2 .$$

They result, respectively, from (3.14) and (3.15). The extended Miura equation (3.17) takes the form

$$\varphi_{,i} - \varphi + c_i = c_i g_{,i} g_{,0}^{-1} - (c_i - 1) \tilde{q}_{,i} (\tilde{\omega}_{,i} - \tilde{\omega}) \tilde{r}_{,0} \qquad i = 1, 2.$$

Correspondingly, (3.18) becomes

$$c_{i}\left((g_{,i}\,g_{,0}^{-1})_{,j}-g_{,i}\,g_{,0}^{-1}\right)-c_{j}\left((g_{,j}\,g_{,0}^{-1})_{,i}-g_{,j}\,g_{,0}^{-1}\right)$$

= $(c_{i}-1)\left[(\tilde{q}_{,i}\,(\tilde{\omega}_{,i}-\tilde{\omega})\,\tilde{r}_{,0})_{,j}-\tilde{q}_{,i}\,(\tilde{\omega}_{,i}-\tilde{\omega})\,\tilde{r}_{,0}\right]-(c_{j}-1)\left[(\tilde{q}_{,j}\,(\tilde{\omega}_{,j}-\tilde{\omega})\,\tilde{r}_{,0})_{,i}-\tilde{q}_{,j}\,(\tilde{\omega}_{,j}-\tilde{\omega})\,\tilde{r}_{,0}\right],$

and the above equations for \tilde{q} and \tilde{r} transform to

$$\tilde{q}_{,i} = (c_i - 1)^{-1} [c_i g_{,i} g_{,0}^{-1} \tilde{q}_{,0} - q] - [\tilde{q}_{,i} (\tilde{\omega}_{,i} - \tilde{\omega}) \tilde{r}_{,0}] \tilde{q}_{,0} - \tilde{q}_{,i} (\tilde{\omega}_{,i} - \tilde{\omega}) \tilde{\Omega}_{,0,0}^{-1}, \tilde{r}_{,-i} = (c_i - 1)^{-1} [c_i \tilde{r}_{,-0} g_{,-0} g_{,-i}^{-1} - \tilde{r}] - \tilde{r}_{,-0} [\tilde{q}_{,-0} (\tilde{\omega} - \tilde{\omega}_{,-i})_{,-0} \tilde{r}_{,-i}] + \tilde{\Omega}_{,0}^{-1} (\tilde{\omega} - \tilde{\omega}_{,-i}) \tilde{r}_{,-i}.$$

Setting $\tilde{\omega}_{,1} = \tilde{\omega}$, and retaining only those equations for \tilde{q} and \tilde{r} that do not contain $\tilde{\Omega}$, we obtain the following equations with self-consistent sources,

$$\begin{aligned} &(c_1 + \varphi_{,1} - \varphi)_{,2} \left(c_2 + \varphi_{,2} - \varphi \right)_{,0} - (c_2 + \varphi_{,2} - \varphi)_{,1} \left(c_1 + \varphi_{,1} - \varphi \right)_{,0} \\ &= (c_2 - 1) \left[\left(\tilde{q}_{,2} \left(\tilde{\omega}_{,2} - \tilde{\omega} \right) \tilde{r}_{,0,0} \right)_{,1} - \tilde{q}_{,2} \left(\tilde{\omega}_{,2} - \tilde{\omega} \right) \tilde{r}_{,0,0} \right], \\ &\tilde{q}_{,1} = (c_1 - 1)^{-1} \left[\left(c_1 + \varphi_{,1} - \varphi \right) \tilde{q}_{,0} - q \right], \\ &\tilde{r}_{,-1} = (c_1 - 1)^{-1} \left[\tilde{r}_{,-0} \left(c_1 + \varphi - \varphi_{,-1} \right)_{,-0} - r \right], \end{aligned}$$

respectively,

$$c_{2}\left((g_{,2} g_{,0}^{-1})_{,1} - g_{,2} g_{,0}^{-1}\right) - c_{1}\left((g_{,1} g_{,0}^{-1})_{,2} - g_{,1} g_{,0}^{-1}\right)$$

$$= (c_{2} - 1) \left[(\tilde{q}_{,2} (\tilde{\omega}_{,2} - \tilde{\omega}) \tilde{r}_{,0})_{,1} - \tilde{q}_{,2} (\tilde{\omega}_{,2} - \tilde{\omega}) \tilde{r}_{,0}\right],$$

$$\tilde{q}_{,1} = (c_{1} - 1)^{-1} \left[c_{1} g_{,1} g_{,0}^{-1} \tilde{q}_{,0} - \tilde{q}\right],$$

$$\tilde{r}_{,-1} = (c_{1} - 1)^{-1} \left[c_{1} \tilde{r}_{,-0} g_{,-0} g_{,-1}^{-1} - \tilde{r}\right].$$
(10.3)

Scalar discrete KP equation with self-consistent sources. We consider the scalar case m = 1 with $\tilde{\omega}_{,1} = \tilde{\omega}$. Writing

$$g = rac{ au_{,-0}}{ au}\,, \qquad ilde{q} = rac{
ho_{,-0}}{ au}\,, \qquad ilde{r} = rac{\sigma}{ au_{,-0}}\,,$$

the equations for \tilde{q} and \tilde{r} in (10.3) read

$$(c_1 - 1)\tau_{,0}\rho_{,1} + \tau_{,0,1}\rho - c_1\tau_{,1}\rho_{,0} = 0, \qquad (c_1 - 1)\tau_{,1}\sigma_{,0} + \tau\sigma_{,0,1} - c_1\tau_{,0}\sigma_{,1} = 0.$$
(10.4)

By using these equations, and choosing $\tilde{\omega}_{,2} - \tilde{\omega} =: K(c_1 - 1)/[c_1(c_2 - 1)]$ to be constant, the first of equations (10.3) can be cast into the form

$$\frac{1}{\tau_{,0} \tau_{,1,2}} \Big(c_2 \tau_{,0,1} \tau_{,2} - c_1 \tau_{,0,2} \tau_{,1} - K \rho_{,2} \sigma_{,0,1} \Big) \\
= \Big[\frac{1}{\tau_{,0} \tau_{,1,2}} \Big(c_2 \tau_{,0,1} \tau_{,2} - c_1 \tau_{,0,2} \tau_{,1} - K \rho_{,2} \sigma_{,0,1} \Big) \Big]_{,-0},$$

which implies

$$c_2 \tau_{,0,1} \tau_{,2} - c_1 \tau_{,0,2} \tau_{,1} - c_{12} \tau_{,0} \tau_{,1,2} = K \rho_{,2} \sigma_{,0,1} , \qquad (10.5)$$

with an arbitrary scalar c_{12} that does not depend on the discrete variable k_0 . Up to differences in notation, the system (10.4) and (10.5) coincides with the discrete KP equation (Hirota bilinear difference or Hirota-Miwa equation) with self-consistent sources considered in [58] (also see [56]). (10.3) thus constitutes a "non-commutative" generalization of the latter.

Some explicit solutions for vanishing seed. We set $\varphi_0 = 0$ and $g_0 = I$. Then the linear equations for θ and η are satisfied by

$$\begin{split} \theta &= (1-c_1^{-1})^{-k_1} \, (1-c_2^{-1})^{-k_2} \, a \, P^{k_0} \, P_1^{k_1} \, P_2^{k_2} \, A \,, \qquad P_i := P - c_i^{-1} \, I \,, \quad i = 1, 2, \\ \eta &= (1-c_1^{-1})^{k_1} \, (1-c_2^{-1})^{k_2} \, B \, Q^{-k_0} \, Q_1^{-k_1} \, Q_2^{-k_2} \, b \,, \qquad Q_i := Q - c_i^{-1} \, I \,, \quad i = 1, 2, \end{split}$$

with constant matrices a, b, A, B, P and Q. A corresponding solution of the equations for $\tilde{\Omega}$ is

$$\tilde{\Omega} = \tilde{\omega} + B \, Q^{-k_0} \, Q_1^{-k_1} \, Q_2^{-k_2} \, X \, P^{k_0} \, P_1^{k_1} \, P_2^{k_2} \, A \,,$$

with a constant matrix X that satisfies the Sylvester equation

$$Q^{-1}XP - X = ba.$$

(10.2) together with $g = I - \theta \,(\tilde{\Omega}^+)^{-1} \eta$ now provides us with explicit solutions of the above matrix discrete KP equations with self-consistent sources.

11 Conclusions

The present work clarifies the origin of self-consistent source extensions of integrable equations from the binary Darboux transformation perspective. The essential point is a deformation of the potential Ω that is central in this solution generating method. We presented an abstraction of the underlying structure in the framework of bidifferential calculus. Choosing realizations of the bidifferential calculus then leads to self-consistent source extensions of various integrable equations, and in this work we provided a number of examples, recovering known examples and obtaining generalizations to matrix versions. All this is not at last a demonstration of the power of bidifferential calculus. Generalizing an integrability feature of an integrable system to this framework opens the door toward a large set of integrable systems sharing this feature. It therefore establishes such a feature as a common property of a wide class of integrable systems and provides a universal proof.

Our approach also demonstrated that self-consistent source extensions of integrable equations typically⁹ admit classes of solutions that depend on arbitrary functions of a single independent variable (which, of course, may be a combination of the independent variables used). We note that

⁹Exceptions are given by (4.5) and (5.1), since here ω is constant.

the "source-generation method" in [56] essentially consists of promoting constant parameters in soliton solutions of an integrable equation to arbitrary functions of a single variable.

In Appendix A, we also showed that the (2+1)-dimensional generalization of the Yajima-Oikawa equation (A.7) belongs to the class of systems addressed in this work. As a consequence, its soliton solutions involve arbitrary functions of a combination of independent variables.

Appendix A: The extended matrix pKP hierarchy

On the algebra \mathcal{A}_0 of smooth functions of variables x and $\mathbf{t} = (t_1, t_2, \ldots)$ we define

$$df = [\mathcal{E}_{\mu_1}, f] \xi_1 + [\mathcal{E}_{\mu_2}, f] \xi_2, \quad \bar{d}f = [(\mu_1^{-1} - \partial)\mathcal{E}_{\mu_1}, f] \xi_1 + [(\mu_2^{-1} - \partial)\mathcal{E}_{\mu_2}, f] \xi_2, \quad (A.1)$$

where ∂ is the partial derivative operator with respect to x, μ_1 and μ_2 are indeterminates, and \mathcal{E}_{μ} is the Miwa shift operator, hence $\mathcal{E}_{\mu}f = f_{[\mu]}\mathcal{E}_{\mu}$, where $[\mu] := (\mu, \mu^2/2, \mu^3/3, ...)$ and $f_{[\mu]}(x, t) = f(x, t + [\mu])$ (see, e.g., [59] and references cited there). We will also use the notation $f_{-[\mu]}(x, t) := f(x, t - [\mu])$. Let \mathcal{A} be the algebra \mathcal{A}_0 extended by ∂ , the Miwa shift operators, and their inverses. The maps d and \bar{d} extend to \mathcal{A} and matrices over $\Omega = \mathcal{A} \otimes \Lambda$. In the following we choose

$$\Delta = \Gamma = -I_n \partial \,, \qquad \kappa = \lambda = 0$$

(3.7) is then satisfied. The second equation in (3.11) leads to

$$\gamma = \left(\mu_1^{-1}(\omega_{[\mu_1]} - \omega) - \omega_{[\mu_1],x}\right) \mathcal{E}_{\mu_1} \xi_1 + \left(\mu_2^{-1}(\omega_{[\mu_2]} - \omega) - \omega_{[\mu_2],x}\right) \mathcal{E}_{\mu_2} \xi_2$$

We require again (3.16), which means

$$\omega_x = 0.$$

The system collected in Remark 3.3 now consists of

$$(\mu_{2}^{-1} - \phi + \phi_{-[\mu_{2}]})_{-[\mu_{1}]} (\mu_{1}^{-1} - \phi + \phi_{-[\mu_{1}]}) - (\mu_{1}^{-1} - \phi + \phi_{-[\mu_{1}]})_{-[\mu_{2}]} (\mu_{2}^{-1} - \phi + \phi_{-[\mu_{2}]}) - (\phi_{-[\mu_{1}]} - \phi_{-[\mu_{2}]})_{x} = \mu_{1}^{-1} q_{-[\mu_{1}]} (\omega - \omega_{-[\mu_{1}]}) r - \mu_{1}^{-1} q_{-[\mu_{1}] - [\mu_{2}]} (\omega - \omega_{-[\mu_{1}]})_{-[\mu_{2}]} r_{-[\mu_{2}]} - \mu_{2}^{-1} q_{-[\mu_{2}]} (\omega - \omega_{-[\mu_{2}]}) r + \mu_{2}^{-1} q_{-[\mu_{2}] - [\mu_{1}]} (\omega - \omega_{-[\mu_{2}]})_{-[\mu_{1}]} r_{-[\mu_{1}]} ,$$
(A.2)

$$\mu_1^{-1}(q - q_{-[\mu_1]}) - q_x = (\phi - \phi_{-[\mu_1]}) q + \mu_1^{-1} q_{-[\mu_1]} (\omega - \omega_{-[\mu_1]}) \hat{\Omega},$$

$$\mu_1^{-1}(r_{[\mu_1]} - r) - r_x = -r (\phi_{[\mu_1]} - \phi) + \mu_1^{-1} \hat{\Omega} (\omega_{[\mu_1]} - \omega) r_{[\mu_1]},$$
(A.3)

and

$$\hat{\Omega}_x = -r \, q \,, \qquad \mu_1^{-1} (\hat{\Omega}_{[\mu_1]} - \hat{\Omega}) = -r \, q_{[\mu_1]} + \mu_1^{-1} \hat{\Omega} \left(\omega_{[\mu_1]} - \omega \right) \hat{\Omega} \,. \tag{A.4}$$

Expansion of these equations in powers of the indeterminates μ_1 and μ_2 generates the deformed hierarchy equations. Taking $\mu_2 \rightarrow 0$ in (A.2) leads to

$$(\phi_{t_1} - \phi_x - q \,\omega_{t_1} r)_{[\mu_1]} - (\phi_{t_1} - \phi_x - q \,\omega_{t_1} r) = 0,$$

which implies

$$(\phi_{t_1} - \phi_x - q\,\omega_{t_1}r)_{t_i} = 0 \qquad i = 1, 2, \dots$$
(A.5)

Without the deformation, i.e., if $\omega = 0$, we are forced to identify t_1 with x. (A.2) then generates the pKP hierarchy, and (A.3) generates corresponding linear and adjoint linear systems. Now we observe that a non-vanishing ω_{t_1} requires t_1 and x to be independent. Besides (A.5), the first non-trivial equation obtained from (A.2) appears at order $\mu_1^2 \mu_2$ (or, equivalently, $\mu_1 \mu_2^2$). It is an extension of the pKP equation. Expansion of (A.3) yields to lowest orders

$$\begin{split} \mu_1^0 : & q_{t_1} = q_x + q \, \omega_{t_1} \hat{\Omega} \,, \quad r_{t_1} = r_x + \hat{\Omega} \, \omega_{t_1} r \,, \\ \mu_1^1 : & q_{t_2} = q_{t_1 t_1} + 2 \, \phi_{t_1} q + (q \, \omega_{t_1 t_1} - q \, \omega_{t_2} - 2 \, q_{t_1} \omega_{t_1}) \, \hat{\Omega} \\ & = q_{xx} + 2 \, (\phi_{t_1} - q \, \omega_{t_1} r) \, q + q \, \omega_{t_2} \, \hat{\Omega} \,, \\ r_{t_2} = -r_{t_1 t_1} - 2r \, \phi_{t_1} + \hat{\Omega} \, (\omega_{t_1 t_1} r + \omega_{t_2} r + 2 \, \omega_{t_1} r_{t_1}) \\ & = -r_{xx} - 2r \, (\phi_{t_1} - q \, \omega_{t_1} r) + \hat{\Omega} \, \omega_{t_2} r \,, \\ \mu_1^2 : & q_{t_3} = q_{xxx} + \frac{3}{2} \, (\phi_{t_2} + \phi_{t_1 t_1}) \, q + 3 \, \phi_{t_1} q_x - \frac{3}{2} \, q \, (\omega_{t_2} + \omega_{t_1 t_1}) \, r \, q - 3 \, (q \, \omega_{t_1} r \, q)_x \\ & - 3 \, q \, \omega_{t_1} \hat{\Omega} \, \omega_{t_1} r \, q + q \, \omega_{t_3} \, \hat{\Omega} \,, \\ r_{t_3} = r_{xxx} - \frac{3}{2} \, r \, (\phi_{t_2} - \phi_{t_1 t_1}) + 3 \, r_x \phi_{t_1} + \frac{3}{2} \, r \, q \, (\omega_{t_2} - \omega_{t_1 t_1}) \, r \\ & - 3 \, (r \, q \, \omega_{t_1} r)_x - 3 \, r \, q \, \omega_{t_1} \hat{\Omega} \, \omega_{t_1} r + \hat{\Omega} \, \omega_{t_3} r \,, \end{split}$$

where we used from (A.4) the first equation and $\hat{\Omega}_{t_1} = -r q + \hat{\Omega} \omega_{t_1} \hat{\Omega}$.

Remark A.1. Via expansion of (A.1) in the indeterminates μ_1 and μ_2 , one obtains in particular the bidifferential calculus given by

$$df = [\partial_{t_1}, f] \xi_2, \qquad \bar{d}f = [\partial_{t_1} - \partial, f] \xi_1 + [\frac{1}{2}(\partial_{t_2} + \partial_{t_1}^2) - \partial_{t_1}\partial, f] \xi_2,$$

which underlies the above evolution equations with variables t_1 and t_2 . They will be considered in the next example.

Example A.2. Setting $\omega_{t_2} = 0$, the equations for q_{t_2} and r_{t_2} do not involve $\hat{\Omega}$. Disregarding the equations for q_{t_1} and r_{t_1} , in terms of $u := -2 (\phi_{t_1} - q \omega_{t_1} r)$, we obtain the system¹¹

$$u_{t_1} - u_x = -2 (q \,\omega_{t_1} r)_x, \qquad q_{t_2} = q_{xx} - u \, q, \qquad r_{t_2} = -r_{xx} + r \, u, \tag{A.6}$$

where the first equation results from (A.5) for i = 1. Via $t_2 \mapsto -i t_2$, and with the reduction $r = q^{\dagger}$ and u, ω_{t_1} Hermitian, the system becomes [60]

$$u_{t_1} - u_x = -2 (q \,\omega_{t_1} q^{\dagger})_x, \qquad i \, q_{t_2} = q_{xx} - u \, q$$

The change of variables $x = x' - t'_1 + t'_2$, $t_1 = t'_1 - t'_2$, $t_2 = t'_2$, turns this into

$$u_{t_1'} = -2 \left(q \,\omega_{t_1'} q^{\dagger} \right)_{x'}, \qquad \mathbf{i} \left(q_{t_1'} + q_{t_2'} \right) = q_{x'x'} - u \, q \,, \tag{A.7}$$

which is a (2+1)-dimensional generalization [1, 12, 61-66] of the Yajima-Oikawa system [22]. We note that $\omega_{t'_1}$ can be absorbed by a redefinition of q. Our derivation of this system via the above deformation of the pKP hierarchy is new, according to our knowledge.¹²

¹⁰As a consequence of (A.5), we have $u = -2\phi_x + a$, where a is an arbitrary $m \times m$ matrix only allowed to depend on x.

¹¹Introducing the new independent variable $x' = x + t_1$, this simplifies to $u_{t_1} = -2(q \omega_{t_1} r)_{x'}, q_{t_2} = q_{x'x'} - uq$,

 $r_{t_2} = -r_{x'x'} + r u$. ¹²It is well-known that the (1+1)-dimensional Yajima-Oikawa system arises from the KP hierarchy via a symmetry constraint [8,67,68]. It still has to be clarified how this is related to the above deformation of the pKP hierarchy.

Addressing our solution generating method, the linear equations (3.5) and (3.6) read

$$\mu_1^{-1} \left(\theta - \theta_{-[\mu_1]} \right) - \theta_x = \left(\phi_0 - \phi_{0,-[\mu_1]} \right) \theta, \qquad \mu_1^{-1} \left(\eta_{[\mu_1]} - \eta \right) - \eta_x = -\eta \left(\phi_{0,[\mu_1]} - \phi_0 \right), \quad (A.8)$$

and (3.10) yields

$$\Omega_x = -\eta \,\theta \,, \qquad \mu_1^{-1}(\Omega_{[\mu_1]} - \Omega) = -\eta \,\theta_{[\mu_1]} + \mu_1^{-1}(\omega_{[\mu_1]} - \omega) \,. \tag{A.9}$$

Recall that $\hat{\Omega} = -\Omega^{-1}$. Solutions of the system (A.2), (A.3) and (A.4) are then obtained via (3.13).

Example A.3. Solutions of the linear equations $\theta_{t_1} = \theta_x$, $\theta_{t_2} = \theta_{xx}$, $\eta_{t_1} = \eta_x$, $\eta_{t_2} = -\eta_{xx}$, obtained from (A.8) with constant seed ϕ_0 , are given by

$$\theta = a e^{\vartheta(P)} A$$
, $\eta = B e^{-\vartheta(Q)} b$, $\vartheta(P) = P (x + t_1) + P^2 t_2$,

with constant matrices a, b, A, B, P, Q of appropriate size. The corresponding solution of (3.10) is

$$\Omega = B e^{-\vartheta(Q)} X e^{\vartheta(P)} A + \omega(t_1), \qquad Q X - X P = b a$$

Solutions of the above system (A.6) are then given by

$$u = 2 \left(\theta \, \Omega^{-1} \eta\right)_x, \quad q = \theta \, \Omega^{-1}, \quad r = \Omega^{-1} \eta.$$

We would rather like to obtain solutions of (A.6) with ω_{t_1} replaced by $-I_n$, since in this case (A.7) becomes the system studied, e.g., in [62]. Since this can be achieved by a transformation of q and r, this means that, for any matrix function $\omega(t_1)$, we obtain a class of solutions.

In the simplest case, where m = n = 1, let us set a = b = A = B = 1 and $Q = -P^{\dagger}$. We write $p = \operatorname{Re}(P)$, $s = \operatorname{Im}(P)$, and $\omega = -e^{2\alpha}/(2p)$, with a real function $\alpha(t_1)$. Then we obtain

$$q = -p e^{-\alpha + i \delta} \operatorname{sech}(\beta), \qquad u = -2 p^2 \operatorname{sech}^2(\beta)$$

with $\beta = p(x+t_1) - \alpha(t_1) + 2spt_2$ and $\delta = s(x+t_1) - (p^2 - s^2)t_2 + \delta_0$, where δ_0 is an arbitrary real constant. Then $\tilde{q} = \sqrt{-\omega_{t_1}}q = -\sqrt{p\alpha_{t_1}}e^{i\delta}\operatorname{sech}(\beta)$, where $p\alpha_{t_1} > 0$, and the above u solve the system

$$u_{t_1} - u_x - 2 \left(|\tilde{q}|^2 \right)_x = 0, \qquad \mathrm{i} \, \tilde{q}_{t_2} = \tilde{q}_{xx} - u \, \tilde{q},$$

which translates into the (2+1)-dimensional Yajima-Oikawa system (A.7) via the transformation of variables stated in Example A.2. The above solution then becomes the 1-soliton solution, obtained previously in [62], if we choose $\alpha = k_1 t_1 + k_0$, with real constants k_0, k_1 . We learned, however, that α is allowed to be an *arbitrary* function of t_1 . More generally, we obtain multi-soliton solutions depending on several arbitrary functions of t_1 .

Reduction $t_1 = x$. This requires $\omega_{t_1} = 0$. The first of equations (A.9) is then redundant. With this reduction, we recover (2.9), (2.7) and (2.8) by expansion of (A.2) and (A.3). The next equations in the deformed hierarchy are

$$\begin{aligned} 3 \,\phi_{xt_4} &- 2 \,\phi_{yt} - \phi_{xxxy} - 3 \,(\phi_x^{\ 2})_y - 3 \,\{\phi_y, \phi_{xx}\} + [\phi_x, 4 \,\phi_t - \phi_{xxx}] \\ &= 3 \,(q \,\omega_{t_4} r)_x + 2 \,(q \,\omega_t r_x - q_x \omega_t r)_x - 2 \,(q \,\omega_y r)_t + \frac{3}{2} (q \,\omega_y r_y - q_y \omega_y r)_x \\ &- 3 \,(q_x \omega_y r_x)_x + \frac{1}{2} (q \,\omega_y r)_{xxx} \,, \end{aligned}$$

where $y = t_2$ and $t = t_3$, and

$$\begin{aligned} q_{t_4} &= q_{xxxx} + 4 \phi_x q_{xx} + 2 \left(\phi_y + 2 \phi_{xx} \right) q_x + \left(\frac{4}{3} \phi_t + \phi_{xy} + \frac{5}{3} \phi_{xxx} + 2 \phi_x^2 \right) q \\ &- 2 \left(q \, \omega_y r \right) q_x - (q \, \omega_y r)_x q - \frac{4}{3} \left(q \, \omega_t r \right) q - q \, \omega_{t_4} \Omega^{-1} , \\ r_{t_4} &= -r_{xxxx} - 4 \, r_{xx} \phi_x + 2 \, r_x (\phi_y - 2 \phi_{xx}) - r \left(\frac{4}{3} \phi_t - \phi_{xy} + \frac{5}{3} \phi_{xxx} + 2 \, \phi_x^2 \right) \\ &- 2 \, r_x (q \, \omega_y r) - r \left(q \, \omega_y r \right)_x + \frac{4}{3} r \left(q \, \omega_t r \right) - \Omega^{-1} \omega_{t_4} r . \end{aligned}$$

The corresponding additional equation for Ω , obtained from (A.9), is

$$\Omega_{t_4} = -\eta \,\theta_{xxx} + \eta_x \theta_{xx} - \eta_{xx} \theta_x + \eta_{xxx} \theta - 4 \,\eta \,\phi_{0,x} \theta_x + 4 \,\eta_x \phi_{0,x} \theta - 2 \,\eta \,\phi_{0,y} \theta + \omega_{t_4} \,.$$
