

Confidence interval for correlation estimator between latent processes

Abstract

Kimura and Yoshida [26] treated a model in which the finite variation part of a two-dimensional semimartingale is expressed by time-integration of latent processes. They proposed a correlation estimator between the latent processes and proved its consistency and asymptotic mixed normality. In this paper, we discuss the confidence interval of the correlation estimator to detect the correlation. We propose two types of estimators for asymptotic variance of the correlation estimator and prove their consistency in a high frequency setting. Our model includes doubly stochastic Poisson processes whose intensity processes are correlated Itô processes. We compare our estimators based on the simulation of the doubly stochastic Poisson processes.

1 Introduction

Integrated correlation is an important index in high frequency financial data analysis. Epps [16] pointed out that the sample correlation between the returns of two different stocks decreases as the sampling frequency of data increases. It is considered that non-synchronicity and market microstructure of trading cause this phenomenon.

Non-synchronous covariance estimation schemes have been developed: Fourier analytic approach (Malliavin and Mancino [32], Malliavin et al. [33]) and the cumulative covariance estimator (Hayashi and Yoshida [23, 21, 22], Mykland [40]).

The market microstructure is modeled as the noise added to the latent price process. This modeling was successful and denoising techniques have also been developed: sub-sampling (Zhang et al. [48], Zhang [49]), pre-averaging (Podolskij and Vetter [43], Jacod et al. [25]), and others (Zhou [50]). There are many studies that treat both non-synchronicity and market microstructure noise: Malliavin and Mancino [34], Mancino and Sanfelici [35], Park and Linton [42], Voev and Lunde [47], Griffin and Oomen [19], Christensen et al. [12, 13], Koike [27, 29, 28], Aït-Sahalia et al. [4], Barndorff-Nielsen et al. [6], Bibinger [8, 9].

The followings are proposed as the cause of market microstructure: bid-ask spread (Roll [44]), discretization error (Gottlieb and Kalay [18]), and asymmetric information (Glosten and Milgrom [17]). On the other hand, the relationship

between the additive noise modeling and the market microstructure is not so clearly explained.

In ultra high frequency sampling, recently, the market microstructure is modeled as dynamics of the limit order book (LOB) rather than the noise. Many studies adopt approaches modeling LOB with Poisson processes (Cont et al. [15], Abergel and Jedidi [2], Muni Toke [46, 37], Smith et al. [45], Muni Toke and Yoshida [39]), Hawkes processes (Hewlett [24], Large [31], Bowsher [10], Bacry et al. [5], Abergel and Jedidi [3], Muni Toke and Pomponio [38], Muni Toke [36], Climet and Yoshida [14], Ogihara and Yoshida [41]), and doubly stochastic Poisson processes (Abergel et al. [1], Guillaud and Pham [20], Chertok et al. [11], Korolev et al. [30]). These approaches can also treat the non-synchronicity of trading.

In this stream, Kimura and Yoshida [26] focused on the integrated correlation between intensity processes of doubly stochastic Poisson processes. They introduced the following model to treat it in a generalized form. This paper is also based on the model.

Now, we consider a stochastic basis $\mathcal{B} = (\Omega, \mathcal{F}, \mathbb{F}, P)$, $\mathbb{F} = (\mathcal{F}_t)_{t \in [0, T]}$. On \mathcal{B} , let $\mathbb{X} = (X^1, X^2)$ be an \mathbb{R}^2 -valued Itô process given by

$$\mathbb{X}_t = \mathbb{X}_0 + \int_0^t \mathbb{X}_s^0 \, ds + \int_0^t \mathbb{X}_s^1 \, dw_s \quad (t \in [0, T]), \quad (1.1)$$

where w is an r -dimensional \mathcal{F} -Wiener process, \mathbb{X}_0 is an \mathbb{F}_0 -measurable random variable, \mathbb{X}^0 is a two-dimensional \mathbb{F} -adapted process, and \mathbb{X}^1 is an $\mathbb{R}^2 \otimes \mathbb{R}^r$ -valued \mathbb{F} -adapted process satisfies condition [A] mentioned later. Let a_n be a positive number depending on n . On \mathcal{B} , consider a two-dimensional measurable process $\mathbb{Y}^n = (Y^{n,1}, Y^{n,2})$ having a decomposition

$$\mathbb{Y}_t^n = \mathbb{Y}_0^n + \int_0^t a_n \mathbb{X}_s \, ds + \mathbb{M}_t^n \quad (t \in [0, T]),$$

where \mathbb{M}^n is a two-dimensional measurable process with $\mathbb{M}_0^n = 0$ satisfies condition [B], [B'], or $[B^{\sharp}]$ mentioned later.

In this model, \mathbb{Y} can be a counting process with intensity process $a_n \mathbb{X}$ where \mathbb{X} is \mathbb{R}_+^2 -valued, i.e. \mathbb{Y} is a two-dimensional doubly stochastic Poisson process. This counting process models the high frequency counting data of the orders or transactions in the active market, for example.

Let $I_j = [t_{j-1}, t_j)$ for a sampling design $\Pi = (t_j)_{j=0, \dots, b_n}$ with $0 = t_0 < t_1 < \dots < t_{b_n} = T$ and $h_j = t_j - t_{j-1}$.

Kimura and Yoshida [26] introduced the estimator of the covariance $\langle X^1, X^2 \rangle$ from the sampled data of \mathbb{Y} as follows. For $\alpha, \beta = 1, 2$,

$$S_n^{\alpha\beta} = \sum_{k=2}^{b_n} \left(\frac{Y_{t_k}^{n,\alpha} - Y_{t_{k-1}}^{n,\alpha}}{a_n h_k} - \frac{Y_{t_{k-1}}^{n,\alpha} - Y_{t_{k-2}}^{n,\alpha}}{a_n h_{k-1}} \right) \left(\frac{Y_{t_k}^{n,\beta} - Y_{t_{k-1}}^{n,\beta}}{a_n h_k} - \frac{Y_{t_{k-1}}^{n,\beta} - Y_{t_{k-2}}^{n,\beta}}{a_n h_{k-1}} \right),$$

Here, $S_n = (S_n^{12}, S_n^{11}, S_n^{22})^*$ is the (co)variance estimator. S_n depends on the scaling parameter a_n which is not derived from the data of \mathbb{Y} . Therefore, treat the correlation estimator $C_n^{12} = S_n^{12} / \sqrt{S_n^{11} S_n^{22}}$ which does not depend on the scaling parameter a_n .

Let

$$U^{\alpha\beta} = \frac{2}{3}\langle X^{\alpha,c}, X^{\beta,c}\rangle_T = \frac{2}{3} \int_0^T X_t^{\alpha 1} \cdot X_t^{\beta 1} dt \quad (\alpha, \beta = 1, 2)$$

and $U = (U^{12}, U^{11}, U^{22})^*$, where $X^{\alpha,c}$ is the continuous part of X^α and $X_t^{\alpha 1}$ is the α -th row of \mathbb{X}_t^1 . Let

$$\begin{aligned} \gamma^{(\alpha_1, \beta_1), (\alpha_2, \beta_2)} &= \int_0^T \sum_{i,j=1}^r \frac{X_{i,s}^{\alpha_1 1} X_{j,s}^{\beta_1 1} + X_{j,s}^{\alpha_1 1} X_{i,s}^{\beta_1 1}}{2} \frac{X_{i,s}^{\alpha_2 1} X_{j,s}^{\beta_2 1} + X_{j,s}^{\alpha_2 1} X_{i,s}^{\beta_2 1}}{2} ds \\ &= \int_0^T (\mathbb{X}_s^1)^{\tilde{\otimes}(\alpha_1, \beta_1)} \cdot (\mathbb{X}_s^1)^{\tilde{\otimes}(\alpha_2, \beta_2)} ds. \end{aligned}$$

and $\Gamma = (\gamma^{pq})_{p,q=(1,2),(1,1),(2,2)}$, where $X_{i,s}^{\alpha 1}$ is the (α, i) -element of \mathbb{X}_s^1 .

Under [A] and any one of [B], [B'], and [B''], Kimura and Yoshida [26] proved the asymptotic mixed normality of the covariance estimator and the correlation estimator.

$$\left(\frac{T}{b_n}\right)^{-1/2} (S_n - U) \xrightarrow{d_s} \Gamma^{1/2} \zeta$$

as $n \rightarrow \infty$, where ζ is an \mathbb{R}^3 -valued standard normal variable independent of \mathcal{F} . and d_s means \mathcal{F} -stable convergence. Let $R = U^{12}/\sqrt{U^{11}U^{22}}$ and suppose that $U^{11}U^{22} \neq 0$ a.s.

$$\left(\frac{T}{b_n}\right)^{-1/2} (C_n^{12} - R) \xrightarrow{d_s} \Xi^{1/2} \zeta$$

as $n \rightarrow \infty$, where

$$\Xi^{1/2} := \left(\frac{1}{\sqrt{U^{11}U^{22}}}, \frac{-U^{12}}{2\sqrt{(U^{11})^3U^{22}}}, \frac{-U^{12}}{2\sqrt{U^{11}(U^{22})^3}} \right) \Gamma^{1/2}.$$

$\Xi = (\Xi^{1/2})(\Xi^{1/2})^*$ is the asymptotic variance of the correlation estimator.

In this paper, we introduce two types of estimators for Γ and prove their consistency in order to obtain the consistent estimator for Ξ . Therefore, we can detect the correlation between latent processes based on hypothesis testing.

This paper is organized as follows. In Section 2, we list the assumptions. In Section 3, we introduce the estimators for Γ and Ξ , and state the main result: their consistency. In Section 4, the results in Section 3 are proved. In Section 5, an example and simulation studies are given.

2 Assumptions

For simplicity, we assume $t_j = j(T/b_n)$, $h_j = T/b_n =: \delta_n$. We write $\Delta_j V = V_{t_j} - V_{t_{j-1}}$ for a process V . Consider the following conditions.

- [A] Process \mathbb{X} admits the representation (1.1) for an \mathbb{R}^2 -valued \mathcal{F}_0 -measurable random variable \mathbb{X}_0 and coefficients \mathbb{X}^κ ($\kappa = 0, 1$) such that \mathbb{X}^0 is a càdlàg \mathbb{F} -adapted process and that \mathbb{X}^1 has a representation

$$\mathbb{X}_t^1 = \mathbb{X}_0^1 + \int_0^t \mathbb{X}_s^{10} ds + \int_0^t \sum_{\kappa'=1}^{r'} \mathbb{X}_s^{1\kappa'} d\tilde{w}_s^{\kappa'} \quad (t \in [0, T]),$$

where \mathbb{X}_0^1 is an $\mathbb{R}^2 \otimes \mathbb{R}^r$ -valued \mathcal{F}_0 -measurable random variable, $\tilde{w} = (\tilde{w}^1, \dots, \tilde{w}^{r'})$ is an r' -dimensional \mathbb{F} -Wiener process (not necessarily independent of w), and $\mathbb{X}_s^{1\kappa'} (\kappa' = 0, 1, \dots, r')$ are $\mathbb{R}^2 \otimes \mathbb{R}^r$ -valued càdlàg \mathbb{F} -adapted processes.

- [B] $\mathbb{M}^n = (M^{n,\alpha})_{\alpha=1,2}$ is a two-dimensional \mathbb{F} -local martingale with $\mathbb{M}_0^n = 0$ and such that
 - (i) $\lim_{n \rightarrow \infty} b_n^{5/2}/a_n = 0$.
 - (ii) $E[\sum_{j=1}^{b_n} |\Delta_j \mathbb{M}^n|^2] = O_p(a_n)$ as $n \rightarrow \infty$, $\sup_{t \in [0,1]} |\Delta \mathbb{M}^n| \leq c a_n^{1/2}$ for a constant c independent of n .
 - (iii) The absolutely continuous (w.r.t. the Lebesgue measure a.s.) mapping $[0, T] \ni t \mapsto \langle \mathbb{M}^n, w \rangle_t \in \mathbb{R}^2 \otimes \mathbb{R}^r$ satisfies $\sup_{t \in [0,T]} |d\langle \mathbb{M}^n, w \rangle_t/dt| = O_p(b_n)$ as $n \rightarrow \infty$.

Here, $\langle \mathbb{M}^n, w \rangle_t$ is the $2 \times r$ matrix of angle brackets $\langle M^{n,\alpha}, w^k \rangle_t$ for $\mathbb{M}^n = (M^{n,\alpha})_{\alpha=1,2}$ and $w = (w^k)_{k=1,\dots,r}$.

- [B'] \mathbb{M}^n is a two-dimensional \mathbb{F} -local martingale with $\mathbb{M}_0^n = 0$, satisfies [B] (i), (iii), and

$$(ii') E[\sum_{j=1}^{b_n} |\Delta_j \mathbb{M}^n|^2] = O(a_n) \text{ as } n \rightarrow \infty.$$

- [B $^\sharp$] \mathbb{M}^n is a two-dimensional \mathbb{F} -local martingale with $\mathbb{M}_0^n = 0$, satisfies [B] (ii), (iii), and

$$(i $^\sharp$) $\lim_{n \rightarrow \infty} b_n^3/a_n = 0$.$$

- [C] $E[\sum_{j=1}^{b_n} |\Delta_j \mathbb{M}^n|^4] = O(a_n^2 b_n^{-1})$ as $n \rightarrow \infty$

Remark 2.1. [A], [B], and [B'] are the same condition in [26]. [B $^\sharp$] is a bit stronger condition than [B $^\sharp$] in [26].

Remark 2.2. The doubly stochastic Poisson process model satisfies [C].

3 Results

We need the estimator of Γ to obtain the asymptotic variance estimator. Here, we give two types of the gamma estimator.

Before that, we introduce some notations to simplify the description. Let $A^{\otimes(i,j)}$ is an (i, j) -element of A^\otimes , $A^\otimes = A \otimes A = AA^*$, and $*$ denotes transpose. Let $x \tilde{\otimes} y = ((x_i y_j + x_j y_i)/2) \in \mathbb{R}^r \otimes \mathbb{R}^r$ for $x = (x_i) \in \mathbb{R}^r$, $y = (y_i) \in \mathbb{R}^r$, and let $x \tilde{\otimes} (\alpha, \beta) = x^\alpha \tilde{\otimes} x^\beta$ for $x = (x_i^\alpha) \in \mathbb{R}^2 \otimes \mathbb{R}^r$. We write $x \cdot y = \sum_{i=1}^r x_i y_i$ for $x = (x_i)$, $y = (y_i) \in \mathbb{R}^r$, and $x \cdot y = \sum_{i,j=1}^r x_{i,j} y_{i,j}$ for $x = (x_{i,j})$, $y = (y_{i,j}) \in \mathbb{R}^r \otimes \mathbb{R}^r$. Write

$$\tilde{V}_k := \frac{\Delta_k V}{a_n h_k} = \frac{\Delta_k V}{a_n \delta_n}.$$

for a stochastic process V . For example, we can write

$$S_n^{\alpha\beta} = \sum_{j=2}^{b_n} (\tilde{Y}_j^n - \tilde{Y}_{j-1}^n)^{\otimes(\alpha,\beta)}, \quad \gamma^{pq} = \int_0^1 (\mathbb{X}_s^1)^{\tilde{\otimes} p} \cdot (\mathbb{X}_s^1)^{\tilde{\otimes} q} \, ds.$$

3.1 Γ estimator

In the similar way in Barndorff-Nielsen and Shephard [7], we define

$$\begin{aligned}\hat{\gamma}_{n,1}^{pq} = & \frac{9}{8} \left\{ \sum_{k=2}^{b_n} (\tilde{Y}_k^n - \tilde{Y}_{k-1}^n)^{\otimes p} (\tilde{Y}_k^n - \tilde{Y}_{k-1}^n)^{\otimes q} \right. \\ & - \frac{1}{2} \sum_{k=2}^{b_n-2} \left((\tilde{Y}_k^n - \tilde{Y}_{k-1}^n)^{\otimes p} (\tilde{Y}_{k+2}^n - \tilde{Y}_{k+1}^n)^{\otimes q} \right. \\ & \left. \left. + (\tilde{Y}_{k+2}^n - \tilde{Y}_{k+1}^n)^{\otimes p} (\tilde{Y}_k^n - \tilde{Y}_{k-1}^n)^{\otimes q} \right) \right\} \left(\frac{T}{b_n} \right)^{-1}\end{aligned}$$

By the similar idea, we define

$$\begin{aligned}\hat{\gamma}_{n,2}^{pq} = & \frac{9}{8} \sum_{k=2}^{b_n-2} \frac{1}{2} \left\{ (\tilde{Y}_{k+2}^n - \tilde{Y}_{k+1}^n)^{\otimes p} - (\tilde{Y}_k^n - \tilde{Y}_{k-1}^n)^{\otimes p} \right\} \\ & \times \left\{ (\tilde{Y}_{k+2}^n - \tilde{Y}_{k+1}^n)^{\otimes q} - (\tilde{Y}_k^n - \tilde{Y}_{k-1}^n)^{\otimes q} \right\} \left(\frac{T}{b_n} \right)^{-1}.\end{aligned}$$

3.2 Kernel based Γ estimator

In the similar way in Hayashi and Yoshida [22], we define the kernel based estimator.

$$\partial_h \{X^\alpha, X^\beta\}_k := \sum_{l=(k-n(h)+1)\vee 2}^k (\Delta_l X^\alpha \Delta_l X^\beta) h^{-1}.$$

where $h = h_n$ is a parameter satisfying $h_n \rightarrow 0$ and $h_n^{-1} b_n^{-1} \rightarrow 0$, and $n(h) := \max_m \{t_m \leq h\}$.

$$\begin{aligned}\hat{\gamma}_{n,h}^{pq} = & \frac{9}{8} \sum_{k=2}^{b_n} \left\{ \partial_h \{\tilde{Y}^{n,\alpha_1}, \tilde{Y}^{n,\alpha_2}\}_k \partial_h \{\tilde{Y}^{n,\beta_1}, \tilde{Y}^{n,\beta_2}\}_k \right. \\ & \left. + \partial_h \{\tilde{Y}^{n,\alpha_1}, \tilde{Y}^{n,\beta_2}\}_k \partial_h \{\tilde{Y}^{n,\beta_1}, \tilde{Y}^{n,\alpha_2}\}_k \right\} \left(\frac{T}{b_n} \right).\end{aligned}$$

3.3 Ξ estimator

Here, we define

$$\hat{\Xi}_{n,*}^{1/2} = \left(\frac{1}{\sqrt{S_n^{11} S_n^{22}}}, \frac{-S_n^{12}}{2\sqrt{(S_n^{11})^3 S_n^{22}}}, \frac{-S_n^{12}}{2\sqrt{S_n^{11} (S_n^{22})^3}} \right) \hat{\Gamma}_{n,*}^{1/2}$$

and $\hat{\Xi}_{n,*} = (\hat{\Xi}_{n,*}^{1/2})^\otimes$, for $* = 1, 2, h$.

3.4 consistency of the estimators

Theorem 3.1. (a) $\hat{\gamma}_{n,i}^{pq} = \gamma^{pq} + o_p(1)$ under [A] and any one of [B], [B'] and $[B^{\sharp}]$, ($i = 1, 2$).

(b) $\hat{\gamma}_{n,i}^{pq} = \gamma^{pq} + O_p(b_n^{-1/2})$ under [A] and $[B^{\sharp}]$, ($i = 1, 2$).

(c) $\hat{\gamma}_{n,i}^{pq} = \gamma^{pq} + O_p(b_n^{-1/2})$ under [A], [B] or [B'], and [C] ($i=1,2$).

Theorem 3.2. (a) $\hat{\gamma}_{n,h}^{pq} = \gamma^{pq} + o_p(1)$ under [A] and any one of [B], [B'] and $[B^{\sharp\sharp}]$.

$$(b) \hat{\gamma}_{n,h}^{pq} = \gamma^{pq} + O_p(b_n^{-1/2}) + O_p(h_n) \text{ under [A] and } [B^{\sharp\sharp}].$$

$$(c) \hat{\gamma}_{n,h}^{pq} = \gamma^{pq} + O_p(b_n^{-1/2}) + O_p(h_n) \text{ under [A], [B] or [B'], and [C].}$$

Corollary 3.3. (a) $\hat{\Xi}_{n,i} = \Xi + o_p(1)$ under [A] and any one of [B], [B'] and $[B^{\sharp\sharp}]$, ($i = 1, 2$).

$$(b) \hat{\Xi}_{n,i} = \Xi + O_p(b_n^{-1/2}) \text{ under [A] and } [B^{\sharp\sharp}], (i = 1, 2).$$

$$(c) \hat{\Xi}_{n,i} = \Xi + O_p(b_n^{-1/2}) \text{ under [A], [B] or [B'], and [C]} (i=1,2).$$

Corollary 3.4. (a) $\hat{\Xi}_{n,h} = \Xi + o_p(1)$ under [A] and any one of [B], [B'] and $[B^{\sharp\sharp}]$.

$$(b) \hat{\Xi}_{n,h} = \Xi + O_p(b_n^{-1/2}) + O_p(h_n) \text{ under [A] and } [B^{\sharp\sharp}].$$

$$(c) \hat{\Xi}_{n,h} = \Xi + O_p(b_n^{-1/2}) + O_p(h_n) \text{ under [A], [B] or [B'], and [C].}$$

4 Proof

Proof of Theorem 3.1

First, we approximate $\hat{\gamma}_{n,i}^{pq} (i = 1, 2)$ by the following quantities. Let

$$\begin{aligned} G_{n,1}^{pq} &= \frac{9}{8} \left\{ \sum_{k=2}^{b_n} (\tilde{\chi}_k^n - \tilde{\chi}_{k-1}^n)^{\otimes p} (\tilde{\chi}_k^n - \tilde{\chi}_{k-1}^n)^{\otimes q} \right. \\ &\quad - \frac{1}{2} \sum_{k=2}^{b_n-2} \left((\tilde{\chi}_k^n - \tilde{\chi}_{k-1}^n)^{\otimes p} (\tilde{\chi}_{k+2}^n - \tilde{\chi}_{k+1}^n)^{\otimes q} \right. \\ &\quad \left. \left. + (\tilde{\chi}_{k+2}^n - \tilde{\chi}_{k+1}^n)^{\otimes p} (\tilde{\chi}_k^n - \tilde{\chi}_{k-1}^n)^{\otimes q} \right) \right\} \left(\frac{T}{b_n} \right)^{-1} \end{aligned}$$

and

$$\begin{aligned} G_{n,2}^{pq} &= \frac{9}{8} \sum_{k=2}^{b_n-2} \frac{1}{2} \left\{ (\tilde{\chi}_{k+2}^n - \tilde{\chi}_{k+1}^n)^{\otimes p} - (\tilde{\chi}_k^n - \tilde{\chi}_{k-1}^n)^{\otimes p} \right\} \\ &\quad \times \left\{ (\tilde{\chi}_{k+2}^n - \tilde{\chi}_{k+1}^n)^{\otimes q} - (\tilde{\chi}_k^n - \tilde{\chi}_{k-1}^n)^{\otimes q} \right\} \left(\frac{T}{b_n} \right)^{-1}. \end{aligned}$$

where $\chi^n = (\chi^{n,1}, \chi^{n,2})$ and $\chi_t^{n,\alpha} = \int_0^t a_n X_s^\alpha \, ds$.

Lemma 4.1. (a) $\hat{\gamma}_{n,i}^{pq} = G_{n,i}^{pq} + o_p(1)$ under any one of [B], [B'] and $[B^{\sharp\sharp}]$, ($i=1,2$).

$$(b) \hat{\gamma}_{n,i}^{pq} = G_{n,i}^{pq} + o_p(b_n^{-1/2}) \text{ under } [B^{\sharp\sharp}], (i=1,2).$$

Proof. Write $(V^1 \otimes V^2 \otimes \cdots \otimes V^n)_{i_1, i_2, \dots, i_n} = V_{i_1}^1 V_{i_2}^2 \cdots V_{i_n}^n$ for vectors V^1, V^2, \dots, V^n and confirm $|V^1 \otimes V^2 \otimes \cdots \otimes V^n| = |V^1||V^2| \cdots |V^n|$. \mathcal{R}_{n,2}^{1,pq} &= \frac{9}{16} \left\{ \frac{4}{9} \sum_{k=2}^{b_n-2} (X_{t_k}^{\alpha_1 1} \cdot X_{t_k}^{\beta_1 1}) (X_{t_k}^{\alpha_2 1} \cdot X_{t_k}^{\beta_2 1}) \left(\frac{T}{b_n} \right) \right. \\
&\quad + \frac{4}{9} \sum_{k=2}^{b_n-2} \left\{ (X_{t_{k-2}}^{\alpha_1 1} \cdot X_{t_{k-2}}^{\alpha_2 1}) (X_{t_{k-2}}^{\beta_1 1} \cdot X_{t_{k-2}}^{\beta_2 1}) \right. \\
&\quad \left. \left. + (X_{t_{k-2}}^{\alpha_1 1} \cdot X_{t_{k-2}}^{\beta_2 1}) (X_{t_{k-2}}^{\beta_1 1} \cdot X_{t_{k-2}}^{\alpha_2 1}) \right\} \left(\frac{T}{b_n} \right) \right\} \\
&\quad - \frac{4}{9} \sum_{k=2}^{b_n-2} (X_{t_k}^{\alpha_1 1} \cdot X_{t_k}^{\beta_1 1}) (X_{t_{k-2}}^{\alpha_2 1} \cdot X_{t_{k-2}}^{\beta_2 1}) \left(\frac{T}{b_n} \right) \\
&\quad - \frac{4}{9} \sum_{k=2}^{b_n-2} (X_{t_{k-2}}^{\alpha_1 1} \cdot X_{t_{k-2}}^{\beta_1 1}) (X_{t_k}^{\alpha_2 1} \cdot X_{t_k}^{\beta_2 1}) \left(\frac{T}{b_n} \right) \\
&\quad + \frac{4}{9} \sum_{k=2}^{b_n-2} (X_{t_{k-2}}^{\alpha_1 1} \cdot X_{t_{k-2}}^{\beta_1 1}) (X_{t_{k-2}}^{\alpha_2 1} \cdot X_{t_{k-2}}^{\beta_2 1}) \left(\frac{T}{b_n} \right) \\
&\quad + \frac{4}{9} \sum_{k=2}^{b_n-2} \left\{ (X_{t_{k-2}}^{\alpha_1 1} \cdot X_{t_{k-2}}^{\alpha_2 1}) (X_{t_{k-2}}^{\beta_1 1} \cdot X_{t_{k-2}}^{\beta_2 1}) \right. \\
&\quad \left. \left. + (X_{t_{k-2}}^{\alpha_1 1} \cdot X_{t_{k-2}}^{\beta_2 1}) (X_{t_{k-2}}^{\beta_1 1} \cdot X_{t_{k-2}}^{\alpha_2 1}) \right\} \left(\frac{T}{b_n} \right) \right\} \\
&\quad + O_p(b_n^{-1/2}). \\
&= \gamma^{pq} + o_p(b_n^{-1/2}) + O_p(b_n^{-1/2}).
\end{aligned}$$

The last $o_p(b_n^{-1/2})$ s are derived from the proof of Lemma 3 in [26] and simple calculus. \square

Proof of Theorem 3.2

In the similar way to the proof of Therem 3.1, let

$$G_{n,h}^{pq} = \frac{9}{8} \sum_{k=2}^{b_n} \left\{ \partial_h \{\tilde{\chi}^{n,\alpha_1}, \tilde{\chi}^{n,\alpha_2}\}_k \partial_h \{\tilde{\chi}^{n,\beta_1}, \tilde{\chi}^{n,\beta_2}\}_k \right. \\ \left. + \partial_h \{\tilde{\chi}^{n,\alpha_1}, \tilde{\chi}^{n,\beta_2}\}_k \partial_h \{\tilde{\chi}^{n,\beta_1}, \tilde{\chi}^{n,\alpha_2}\}_k \right\} \left(\frac{T}{b_n} \right).$$

Lemma 4.3. (a) $\hat{\gamma}_{n,h}^{pq} = G_{n,h}^{pq} + o_p(1)$ under any one of $[B]$, $[B']$ and $[B^{\sharp}]$.
(b) $\hat{\gamma}_{n,h}^{pq} = G_{n,h}^{pq} + o_p(b_n^{-1/2})$ under $[B^{\sharp}]$.

Proof. We write

$$b_n^\rho \left(\frac{9}{8} \right)^{-1} |\hat{\gamma}_{n,h} - G_{n,h}| \\ = b_n^\rho 2 \left| \sum_{k=2}^{b_n} (\check{s}_{k,h} \otimes \check{s}_{k,h} - \check{t}_{k,h} \otimes \check{t}_{k,h}) \right| \left(\frac{T}{b_n} \right) \\ = b_n^\rho 2 \left| \sum_{k=2}^{b_n} (\check{s}_{k,h} - \check{t}_{k,h}) \otimes (\check{s}_{k,h} - \check{t}_{k,h}) \right. \\ \left. + (\check{s}_{k,h} - \check{t}_{k,h}) \otimes \check{t}_{k,h} + \check{t}_{k,h} \otimes (\check{s}_{k,h} - \check{t}_{k,h}) \right| \left(\frac{T}{b_n} \right) \\ \leq b_n^\rho 2 \sum_{k=2}^{b_n} \left\{ \left| (\check{s}_{k,h} - \check{t}_{k,h}) \otimes (\check{s}_{k,h} - \check{t}_{k,h}) \right| \right. \\ \left. + \left| (\check{s}_{k,h} - \check{t}_{k,h}) \otimes \check{t}_{k,h} \right| + \left| \check{t}_{k,h} \otimes (\check{s}_{k,h} - \check{t}_{k,h}) \right| \right\} \left(\frac{T}{b_n} \right) \\ = b_n^\rho 2 \sum_{k=2}^{b_n} |\check{s}_{k,h} - \check{t}_{k,h}|^2 \left(\frac{T}{b_n} \right) + b_n^\rho 4 \sum_{k=2}^{b_n} |\check{t}_{k,h}| |\check{s}_{k,h} - \check{t}_{k,h}| \left(\frac{T}{b_n} \right) \\ \leq 2 \left\{ b_n^{\rho/2} \left(\frac{T}{b_n} \right)^{-1/2} \sum_{k=2}^{b_n} |\check{s}_{k,h} - \check{t}_{k,h}| \left(\frac{T}{b_n} \right) \right\}^2 \\ + 4 \left\{ \max_k |\check{t}_{k,h}| \right\} \left\{ b_n^\rho \sum_{k=2}^{b_n} |\check{s}_{k,h} - \check{t}_{k,h}| \left(\frac{T}{b_n} \right) \right\}.$$

We obtain the conclusion from the inequalities

Proposition 4.4. $\hat{\gamma}_{n,h}^{pq} = G_{n,h}^{pq} + o_p(b_n^{-1/2})$ under [B] or [B'], and [C].

Proof. The conclusion is derived from the proof of Lemma 4.3, that of Proposition 4.2, and the inequality

Lemma 4.5. $b_n^\rho \sum_{l=(k-n(h)+1)\vee 2}^k F_l G_l h^{-1} \rightarrow^p 0$ for all pairs of $(F_l, G_l) \in \{A_k^\alpha, B_k^\alpha, C_k^\alpha, D_k^\alpha; \alpha = 1, 2\}^2 \setminus \{(A_l^\alpha, A_l^\beta); \alpha, \beta = 1, 2\}$.

The proof of this lemma is very similar to proof of Lemma 2 in [26].

Proof. Let $\mathcal{Q}_{n,h} = b_n^\rho \sum_{l=(k-n(h)+1)\vee 2}^k F_l G_l h^{-1}$. For $F_l = A_l^\alpha$ and $G_l = C_l^\beta$, $E[(|\mathcal{Q}_{n,h}|)^2] = O(b_n^{2\rho} n(h) h^{-2} b_n^{-3}) = O(h^{-1} b_n^{2\rho-2}) = o(1)$. For $F_l = A_l^\alpha$ and $G_l = D_l^\beta$, $E[(|\mathcal{Q}_{n,h}|)] = O(b_n^\rho n(h) h^{-1} b_n^{-3/2}) o(1) = o(b_n^{\rho-1/2}) = o(1)$. For $F_l = A_l^\alpha$ and $G_l = B_l^\beta$, $E[(|\mathcal{Q}_{n,h}|)^2] = O(b_n^{2\rho} n(h) h^{-2} b_n^{-3}) = O(h^{-1} b_n^{2\rho-2}) = o(1)$. \square

Now, let

$$Q_{k,h}^{1,\alpha\beta} = \sum_{l=(k-n(h)+1)\vee 2}^k A_l^\alpha A_l^\beta h^{-1}.$$

By Lemma 4.5 and (4) (esp. $Q_{k,h}^{1,\alpha\beta} = O_p(1)$), it holds that

$$\begin{aligned} G_{n,h}^{pq} &= \frac{9}{8} \sum_{k=2}^{b_n} (Q_{k,h}^{1,\alpha_1\alpha_2} Q_{k,h}^{1,\beta_1\beta_2} + Q_{k,h}^{1,\alpha_1\beta_2} Q_{k,h}^{1,\beta_1\alpha_2}) \left(\frac{T}{b_n} \right) + o_p(b_n^{-1/2}) \\ &=: \mathcal{R}_{n,h}^{1,pq} + o_p(b_n^{-1/2}). \end{aligned}$$

By recombination of the multiple summation,

\mathcal{R}_{n,h}^{1,pq} &= \frac{9}{8} \sum_{l=2}^{b_n-n(h)} \left\{ n(h)(q_l^{1,\alpha_1\alpha_2} q_l^{1,\beta_1\beta_2} + q_l^{1,\alpha_1\beta_2} q_l^{1,\beta_1\alpha_2}) \right. \\
&\quad + (n(h)-1)(q_l^{1,\alpha_1\alpha_2} q_{l+1}^{1,\beta_1\beta_2} + q_l^{1,\alpha_1\beta_2} q_{l+1}^{1,\beta_1\alpha_2} \\
&\quad \quad + q_{l+1}^{1,\alpha_1\alpha_2} q_l^{1,\beta_1\beta_2} + q_{l+1}^{1,\alpha_1\beta_2} q_l^{1,\beta_1\alpha_2}) \\
&\quad + \sum_{k=2}^{n(h)-1} (n(h)-k)(q_l^{1,\alpha_1\alpha_2} q_{l+k}^{1,\beta_1\beta_2} + q_l^{1,\alpha_1\beta_2} q_{l+k}^{1,\beta_1\alpha_2} \\
&\quad \quad + q_{l+k}^{1,\alpha_1\alpha_2} q_l^{1,\beta_1\beta_2} + q_{l+k}^{1,\alpha_1\beta_2} q_l^{1,\beta_1\alpha_2}) \Big\} h_n^{-2}\left(\frac{T}{b_n}\right) \\
&\quad + \frac{9}{8} \sum_{m=b_n-n(h)+1}^{b_n} \left\{ \left(\sum_{l=b_n-n(h)+1}^m q_l^{1,\alpha_1\alpha_2} \right) \left(\sum_{l=b_n-n(h)+1}^m q_l^{1,\beta_1\beta_2} \right) \right. \\
&\quad \quad \left. + \left(\sum_{l=b_n-n(h)+1}^m q_l^{1,\alpha_1\beta_2} \right) \left(\sum_{l=b_n-n(h)+1}^m q_l^{1,\beta_1\alpha_2} \right) \right\} h_n^{-2}\left(\frac{T}{b_n}\right) \\
&=: \mathcal{B}_{n,h}^{1,pq} + \mathcal{T}_{n,h}^{1,pq},
\end{aligned}$$

where $q_l^{1,\alpha\beta} = A_l^\alpha A_l^\beta = q_l^{2,\alpha\beta} + q_l^{3,\alpha\beta}$.

By (4.2), (4.3), (4.4) and similar evaluation, we have $\mathcal{B}_{n,h}^{1,pq} = \mathcal{B}_{n,h}^{2,pq} + O_p(b_n^{-1/2})$, where $\mathcal{B}_{n,h}^{2,pq}$ is defined in the same way of $\mathcal{B}_{n,h}^{1,pq}$ with $q_l^{2,\alpha\beta}$ instead of $q_l^{1,\alpha\beta}$. It is easy to see that $\mathcal{T}_{n,h}^{1,pq} = O_p(h_n)$.

By simple calculus, we have

\mathcal{B}_{n,h}^{2,pq} &= \frac{9}{8} \sum_{l=2}^{b_n-n(h)} \sum_{k=1}^{n(h)-1} (n(h)-k) \\
&\quad \times \left\{ (q_l^{2,\alpha_1\alpha_2}(q_{l+k}^{2,\beta_1\beta_2} - q_l^{2,\beta_1\beta_2}) + q_l^{2,\alpha_1\beta_2}(q_{l+k}^{2,\beta_1\alpha_2} - q_l^{2,\beta_1\alpha_2})) \right. \\
&\quad \quad \left. + (q_{l+k}^{2,\alpha_1\alpha_2} - q_l^{2,\alpha_1\alpha_2})q_l^{2,\beta_1\beta_2} + (q_{l+k}^{2,\alpha_1\beta_2} - q_l^{2,\alpha_1\beta_2})q_l^{2,\beta_1\alpha_2}) \right\} h_n^{-2}\left(\frac{T}{b_n}\right) \\
&\quad + \frac{9}{8} \sum_{l=2}^{b_n} n(h)^2 (q_l^{2,\alpha_1\alpha_2} q_l^{2,\beta_1\beta_2} + q_l^{2,\alpha_1\beta_2} q_l^{2,\beta_1\alpha_2}) h_n^{-2}\left(\frac{T}{b_n}\right) \\
&\quad - \frac{9}{8} \sum_{l=b_n-n(h)+1}^{b_n} n(h)^2 (q_l^{2,\alpha_1\alpha_2} q_l^{2,\beta_1\beta_2} + q_l^{2,\alpha_1\beta_2} q_l^{2,\beta_1\alpha_2}) h_n^{-2}\left(\frac{T}{b_n}\right) \\
&=: \mathcal{P}_{n,h}^{2,pq} + \mathcal{C}_{n,h}^{2,pq} - \mathcal{T}_{n,h}^{2,pq}.
\end{aligned}$$

From the proof of Lemma 3 in [26] and simple calculus, it is derived that $\mathcal{C}_{n,h}^{2,pq} = \gamma^{pq} + o_p(b_n^{-1/2})$. It is easy to see that $\mathcal{T}_{n,h}^{2,pq} = o_p(h_n)$.

Furthermore, we have

&\quad \left. + \sum_{m=1}^k (q_{l+m}^{2,\alpha_1\alpha_2} - q_{l+m-1}^{2,\alpha_1\alpha_2}) q_l^{2,\beta_1\beta_2} + \sum_{m=1}^k (q_{l+m}^{2,\alpha_1\beta_2} - q_{l+m-1}^{2,\alpha_1\beta_2}) q_l^{2,\beta_1\alpha_2}) \right\} h_n^{-2} \left(\frac{T}{b_n} \right) \\
&= \frac{9}{8} \sum_{l=2}^{b_n-n(h)} \sum_{k=1}^{n(h)-1} \frac{(n(h) - k)(n(h) - k + 1)}{2} \\
&\quad \times \left\{ (q_l^{2,\alpha_1\alpha_2} (q_{l+k}^{2,\beta_1\beta_2} - q_{l+k-1}^{2,\beta_1\beta_2}) + q_l^{2,\alpha_1\beta_2} (q_{l+k}^{2,\beta_1\alpha_2} - q_{l+k-1}^{2,\beta_1\alpha_2}) \right. \\

&= \frac{9}{8} \sum_{l=2}^{n(h)} \sum_{k=1}^{n(h)-l} \frac{(n(h) - k)(n(h) - k + 1)}{2} \\
&\quad \times \left\{ (q_l^{2,\alpha_1\alpha_2} (q_{l+k}^{2,\beta_1\beta_2} - q_{l+k-1}^{2,\beta_1\beta_2}) + q_l^{2,\alpha_1\beta_2} (q_{l+k}^{2,\beta_1\alpha_2} - q_{l+k-1}^{2,\beta_1\alpha_2}) \right. \\
&\quad \left. + (q_{l+k}^{2,\alpha_1\alpha_2} - q_{l+k-1}^{2,\alpha_1\alpha_2}) q_l^{2,\beta_1\beta_2} + (q_{l+k}^{2,\alpha_1\beta_2} - q_{l+k-1}^{2,\alpha_1\beta_2}) q_l^{2,\beta_1\alpha_2}) \right\} h_n^{-2} \left(\frac{T}{b_n} \right) \\
&\quad + \frac{9}{8} \sum_{l'=n(h)+1}^{b_n} \sum_{k=1}^{n(h)-1} \frac{(n(h) - k)(n(h) - k + 1)}{2} \\
&\quad \times \left\{ (q_{l'-k}^{2,\alpha_1\alpha_2} (q_{l'}^{2,\beta_1\beta_2} - q_{l'-1}^{2,\beta_1\beta_2}) + q_{l'-k}^{2,\alpha_1\beta_2} (q_{l'}^{2,\beta_1\alpha_2} - q_{l'-1}^{2,\beta_1\alpha_2}) \right. \\
&\quad \left. + (q_{l'}^{2,\alpha_1\alpha_2} - q_{l'-1}^{2,\alpha_1\alpha_2}) q_{l'-k}^{2,\beta_1\beta_2} + (q_{l'}^{2,\alpha_1\beta_2} - q_{l'-1}^{2,\alpha_1\beta_2}) q_{l'-k}^{2,\beta_1\alpha_2}) \right\} h_n^{-2} \left(\frac{T}{b_n} \right) \\
&\quad - \frac{9}{8} \sum_{l=b_n-n(h)+1}^{b_n-1} \sum_{k=1}^{b_n-l} \frac{(n(h) - k)(n(h) - k + 1)}{2} \\
&\quad \times \left\{ (q_l^{2,\alpha_1\alpha_2} (q_{l+k}^{2,\beta_1\beta_2} - q_{l+k-1}^{2,\beta_1\beta_2}) + q_l^{2,\alpha_1\beta_2} (q_{l+k}^{2,\beta_1\alpha_2} - q_{l+k-1}^{2,\beta_1\alpha_2}) \right. \\
&\quad \left. + (q_{l+k}^{2,\alpha_1\alpha_2} - q_{l+k-1}^{2,\alpha_1\alpha_2}) q_l^{2,\beta_1\beta_2} + (q_{l+k}^{2,\alpha_1\beta_2} - q_{l+k-1}^{2,\alpha_1\beta_2}) q_l^{2,\beta_1\alpha_2}) \right\} h_n^{-2} \left(\frac{T}{b_n} \right) \\
&=: \mathcal{H}_{n,h}^{3,pq} + \mathcal{P}_{n,h}^{3,pq} - \mathcal{T}_{n,h}^{3,pq}.
\end{aligned}$$

$\mathcal{H}_{n,h}^{3,pq} = O_p(h_n)$ and $\mathcal{T}_{n,h}^{3,pq} = O_p(h_n)$ are derived from the following calculus.

$$\begin{aligned}
&\frac{(n(h) - k)(n(h) - k + 1)}{2} (q_{l+k}^{2,\beta_1\beta_2} - q_{l+k-1}^{2,\beta_1\beta_2}) \\
&= \frac{(n(h) - k)(n(h) - (k - 1))}{2} q_{l+k}^{2,\beta_1\beta_2} - \frac{(n(h) - (k - 1))(n(h) - (k - 2))}{2} q_{l+(k-1)}^{2,\beta_1\beta_2} \\
&\quad + (n(h) - (k - 1)) q_{l+(k-1)}^{2,\beta_1\beta_2}.
\end{aligned}$$

Here, we set

$$\mathcal{P}_{n,h}^{3,pq} = \sum_{l'=n(h)+1}^{b_n} p_{n,h,l'}^{3,pq}.$$

and we have

$$\begin{aligned} \sum_{l'=n(h)+1}^{b_n} E\left[p_{n,h,l'}^{3,pq} \mid \mathcal{F}_{l'-3}^n\right] &= O_p(h_n), \\ \sum_{l'=n(h)+1}^{b_n} E\left[\left|p_{n,h,l'}^{3,pq}\right|^2 \mid \mathcal{F}_{l'-3}^n\right] &= O_p(h_n^2) \end{aligned}$$

and $\{p_{n,h,l'}^{3,pq}\}_{l'=2}^{b_n}$ is $\{\mathcal{F}_{l'-2}^n\}_{l'=2}^{b_n}$ -adapted. Therefore, by Lenglart's inequality and its application, it holds that $\mathcal{P}_{n,h}^{3,pq} = O_p(h_n)$.

Here, we proved that $G_{n,h}^{pq} = \gamma^{pq} + o_p(b_n^{-1/2}) + O_p(b_n^{-1/2}) + O_p(h_n)$. We reached the conclusion. \square

5 Simulation

We consider the following example. \mathbb{X} is an \mathbb{R}_+^2 -valued Itô process satisfying

$$\begin{aligned} X_t^1 &= X_0^1 + \int_0^t X_s^1 \mu_1 \, ds + \int_0^t X_s^1 \sigma_1 \, dw_s^1 \\ X_t^2 &= X_0^2 + \int_0^t X_s^2 \mu_2 \, ds + \int_0^t X_s^2 \rho \sigma_2 \, dw_s^1 + \int_0^t X_s^2 \sqrt{1-\rho^2} \sigma_2 \, dw_s^2, \end{aligned}$$

where w^1 and w^2 are independent Wiener processes, and $t \in [0, T]$. \mathbb{Y} is a counting process with intensity process $a_n \mathbb{X}$. In this setting, [C] is satisfied.

In various a_n, b_n settings, We examine the asymptotic variance estimators $\hat{\Xi}_{n,*}$, for $* = 1, 2, w, m, n$, where $\hat{\Xi}_{n,w} = \hat{\Xi}_{n,h}$, $h = h_n = Tb_n^{-0.25}$; $\hat{\Xi}_{n,m} = \hat{\Xi}_{n,h}$, $h = h_n = Tb_n^{-0.5}$; $\hat{\Xi}_{n,n} = \hat{\Xi}_{n,h}$, $h = h_n = Tb_n^{-0.75}$. To reflect the condition that $\lim_{n \rightarrow \infty} b_n^r/a_n = 0$ ($r = 2, 2.5, 3$), we see the case that $a_n = b_n^r$ ($r = 2, 2.5, 3, 3.5$). We calculate these with 1000 paths and compare these by mean squared error (MSE).

Now, we fix the parameters $\mu_1 = 0.2, \mu_2 = 0.3, \sigma_1 = 0.2, \sigma_2 = 0.3, \rho = 0.7, X_0^1 = 1, X_0^2 = 2, T = 1$.

Table 1, 2, 3 and 4 display the MSE of the asymptotic variance estimators in the case that $a_n = b_n^r$ ($r = 2, 2.5, 3, 3.5$), respectively. Table 1 and 2 show

that the MSE of the estimators do not converge to 0. Table 3 and 4 show that they converge to 0. These support Corollary 3.3 (a) and Corollary 3.4 (a).

Table 5, 6, 7 and 8 display b_n times the MSE of the asymptotic variance estimators in the case that $a_n = b_n^r$ ($r = 2, 2.5, 3, 3.5$), respectively. Table 5 and 6 show that b_n times the MSE of the estimators do not converge to 0. Table 7 and 8 show that b_n times the MSE of $\hat{\Xi}_{n,*}$ ($* = 1, 2, m, n$) converge to 0, and b_n times the MSE of $\hat{\Xi}_{n,w}$ does not. These support Corollary 3.3 (c) and Corollary 3.4 (c).
