# A LIOUVILLE THEOREM ON THE PDE $det(f_{i\bar{j}}) = 1$

ABSTRACT. Let f be a smooth plurisubharmonic function which solves

$$\det(f_{i\bar{j}}) = 1 \quad \text{ in } \Omega \subset \mathbb{C}^n.$$

Suppose that the metric  $\omega_f = \sqrt{-1}f_{i\bar{j}}dz_i \wedge d\bar{z}_j$  is complete and f satisfies the growth condition

 $C^{-1}(1+|z|^2) \le f \le C(1+|z|^2), \quad as \quad |z| \to \infty.$ 

for some C > 0, then f is quadratic.

#### 1. Introduction

Let  $\Omega \subset \mathbb{C}^n$ , denote

 $\mathcal{R}^{\infty}(\Omega) := \{ f \in C^{\infty}(\Omega) \mid f \text{ is a real function and } (f_{i\bar{j}}) > 0 \},\$ 

where  $(f_{i\bar{j}}) = \left(\frac{\partial^2 f}{\partial z_i \partial \bar{z}_j}\right)$ . For  $f \in \mathcal{R}^{\infty}(\Omega)$ ,  $(\Omega, \omega_f)$  is a Kähler manifold. In this paper we study the PDE

 $\det(f_{i\bar{j}}) = 1.$ 

The quadratical polynomial

(1.2) 
$$f = z_1 \bar{z}_1 + \dots + z_n \bar{z}_n$$

is a solution of (1.1). If we take a linear transformation

$$\dot{z}_i = \sum a_i^j z_j, \quad \det(a_i^j) = 1,$$

the above f is transformed into another solution of (1.1). All these solutions are called affine equivalent.

When  $\omega_f$  is complete,  $\omega_f$  is a complete Calabi-Yau metric. Tian proved that every Calabi-Yau metric of Euclidean volume growth on  $\mathbb{C}^2$  must be Euclidean metric, and conjectured that the same should hold true on  $\mathbb{C}^n$  for all  $n \geq 3$  ([9]). Recently, a counterexample to this conjecture was found by Li, Conlon-Rochon, Szekelyhidi independently (see [3, 5, 8]).

To obtain the Liouville theorem of (1.1) people need to strengthen the assumption near  $\infty$ . At the AIM workshop "Nonlinear PDEs in real and complex geometry" Szekelyhidi asked the following question ([1])

**Question 1.1.** Let f be plurisubharmonic solution to  $det(f_{i\bar{j}}) = 1$  on  $\mathbb{C}^n$  satisfying

$$C^{-1}(|z|^2 + 1) \le f \le C(|z|^2 + 1)$$

then f is quadratic.

In [10] Wang prove the Liouville theorem under the assumption  $f = |z|^2 + o(|z|^2)$ , as  $|z| \to \infty$ .

In this paper we consider the solution of (1.1) with complete Kähler metrics. We prove the following two Liouville properties on (1.1).

**Theorem 1.2.** Let  $f \in \mathcal{R}^{\infty}(\Omega)$  satisfying (1.1). Suppose that

- (1) There is a constant  $\varepsilon > 0$  such that  $f \ge \varepsilon (\sum_{i=1}^{n} z_i \bar{z}_i)$  as  $|z| \to \infty$ .
- (2)  $\omega_f$  is complete.

Then the second derivatives of f of mixed type are constants.

We have following corollary.

**Corollary 1.3.** Let  $f \in \mathcal{R}^{\infty}(\Omega)$  satisfying (1.1). Suppose that

(1) There is a constant C > 0 such that

$$C^{-1}(\sum_{i=1}^{n} z_i \bar{z}_i) \le f \le C(\sum_{i=1}^{n} z_i \bar{z}_i), \quad as \ |z| \to \infty$$

(2)  $\omega_f$  is complete.

Then f must be affine equivalent to a quadratical polynomial.

To state our second theorem we define a invariant

$$D := \sum f^{i\bar{k}} f^{j\bar{l}} f_{,ij} f_{,\bar{b}\bar{l}},$$

where "," denote the covariant derivative with respect to the metric  $\omega_f$ .

**Theorem 1.4.** Let  $f \in \mathcal{R}^{\infty}(\Omega)$  satisfying (1.1). Suppose that

(1) There is a constant C > 0 such that

$$C^{-1}(\sum_{i=1}^{n} z_i \bar{z}_i) \le f \le C(\sum_{i=1}^{n} z_i \bar{z}_i), \quad as \ |z| \to \infty$$

(2) f defined on whole  $\mathbb{C}^n$ .

(3) There is a constant C > 0 such that  $D \le C(1 + f)^2$ . Then f must be affine equivalent to a quadratical polynomial.

By the assumption  $f \ge \varepsilon(\sum_{i=1}^n z_i \bar{z}_i)$  we have f attain its minimal at some point  $p^{\bullet}$ . Consider the coordinate transformation  $\tilde{z} = z - z(p^{\bullet})$ . By adding a constant f attains its minimum min f = 0 at  $\tilde{z}(p^{\bullet}) = 0$ . Then there exists  $R_1 > R_0$  such that  $f \ge \frac{\varepsilon}{2}(\sum_{i=1}^n \tilde{z}_i \bar{\tilde{z}}_i)$  when  $|\tilde{z}| \ge R_1$ . Without loss of generality we assume that f attains its minimum min f at 0, and f(0) = 0.

## 2. Proof of Theorem 1.2

2.1. Estimate of T. Denote  $T = \sum_{i=1}^{n} f^{i\bar{j}} g_{i\bar{j}}$ , where  $g_{i\bar{j}}$  is the Euclidean metric on  $\mathbb{C}^{n}$ . Denote by  $R_{i\bar{j}}(\omega_f)$  and  $R_{i\bar{j}}(\omega_g)$  the Ricci curvature of the metric  $\omega_f$  and  $\omega_g$  respectively. Let C > 0 be an arbitrary large number. Consider the geodesic ball  $B_f(0, 2C)$  centered at 0 with redius r = 2C. We take a linear transformation

(2.1) 
$$\dot{f} = \frac{f}{C^2}, \quad \dot{g} = \frac{g}{C^2}, \quad , \quad \dot{z} = \frac{z}{C}.$$

Note that

(2.2) 
$$\frac{\partial^2 f}{\partial z_i \partial \bar{z}_j} = \frac{\partial^2 f}{\partial \dot{z}_i \partial \bar{z}_j}, \quad \dot{T} := \sum \dot{f}^{i\bar{j}} \dot{g}_{i\bar{j}} = T.$$

Denote  $\dot{f}_{i\bar{j}} = \frac{\partial^2 \dot{f}}{\partial \dot{z}_i \partial \dot{z}_j}$ . Obviously,

$$\det(f_{i\bar{j}}) = 1.$$

Denote  $\|\cdot\|_f$ ,  $\|\cdot\|_g$  and  $\|\cdot\|_f$ , the norm with respect to the metric  $\omega_f$ ,  $\omega_g$  and  $\omega_f$  respectively. Denote by  $\dot{B}_f(0,2)$  the geodesic ball centered at 0 with radius 2 with respect to the metric  $\omega_f$ . We estimate  $\|\nabla f\|_f^2$ . In [2] Chen, Li and Sheng proved

**Lemma 2.1.** Let  $\dot{f} \in \mathcal{R}^{\infty}(\Omega)$  with  $\dot{f}(0) = \inf_{\Omega} \dot{f} = 0$ . Suppose that

(2.3) 
$$||R_{i\bar{j}}(\omega_{j})||_{j} \leq \mathsf{N}_{1}, \ in \ B_{j}(0,2),$$

where  $R_{i\bar{i}}(\omega_{f})$  is the Ricci curvature of the metric  $\omega_{f}$ . Then in  $B_{f}(0,1)$ 

(2.4) 
$$\frac{\|\nabla f\|_{\dot{f}}^2}{(1+\dot{f})^2} \le \mathsf{C}_{f}$$

where  $C_1 > 0$  is a constant depending only on n and  $N_0$ . Then, for any  $q \in B_{\hat{f}}(0,1)$ ,

(2.5) 
$$\dot{f}(q) - \dot{f}(0) \le \exp\left(\sqrt{\mathsf{C}}_1 d(0, p)\right) - 1,$$

where d(0,p) denotes the geodesic distance from 0 to p with respect to the metric  $\omega_{i}$ .

By the condition (1) of Theorem 1.2 and the linear transformation (2.1) we have,

$$\dot{f} \ge \varepsilon (\sum_{i=1}^{n} \dot{z}_i \bar{z}_i).$$

By Lemma 2.1, in  $B_{\dot{f}}(0,1)$ , we conclude that

(2.6) 
$$\sum |\dot{z}_i|^2 \le \frac{1}{\varepsilon} \exp(\sqrt{\mathsf{C}_1}).$$

To estimate  $\dot{T}$ , we need

**Lemma 2.2.** Let  $\dot{f} \in \mathcal{R}^{\infty}(\Omega)$  and  $B_{\dot{f}}(0,1) \subset \Omega$ . Suppose

$$det(\dot{f}_{i\bar{j}}) \leq \mathsf{N}_1, \quad \|R_{i\bar{j}}(\omega_{\dot{f}})\|_{\dot{f}} \leq \mathsf{N}_1, \quad |\dot{z}| \leq \mathsf{N}_1.$$

in  $B_{\hat{f}}(0,1)$ , for some constant  $N_1 > 0$ . Then there exists a constant  $C_2 > 1$  such that

$$\mathsf{C}_2^{-1} \le \lambda_1 \le \dots \le \lambda_n \le \mathsf{C}_2, \ \forall \ q \in B_{\dot{f}}(0, 1/2).$$

where  $\lambda_1, \dots, \lambda_n$  are eigenvalues of the matrix  $(\dot{f}_{i\bar{j}}), C_2$  is a positive constant depending on n and  $N_1$ .

The Lemma 2.2 has been proved in [2]. By Lemma 2.2 and  $\dot{g}_{i\bar{j}} = \delta_{i\bar{j}}$ ,  $\dot{T}$  is bounded by a constant in  $B_f(0, 1/2)$ . By (2.2) we have T is bounded by a constant in  $B_f(0, C/2)$ . Since C is arbitrary,  $\sum f^{i\bar{i}} = \sum_i 1/\lambda_i$  and  $\sum f_{i\bar{i}} = \sum_i \lambda_i$  we have

(2.7) 
$$\mathsf{C}_2^{-1}\omega_g \leq \sum \omega_f \leq \mathsf{C}_2\omega_g.$$

on whole Kähler manifold  $(\Omega, \omega_f)$ .

Set  $\varphi = f - g$ . Denote

$$S_f := \sum f^{i\bar{j}} f^{k\bar{l}} f^{m\bar{n}} \varphi_{;i\bar{l}m} \varphi_{;\bar{j}k\bar{n}}.$$

where ";" denote the covariant derivative with respect to the metric  $\omega_g$ . If no danger of confusion we denote  $S_f$  by S. It was proved that (see [11, 6])

$$(2.8) \qquad \qquad \Delta'S \ge -\mathsf{C}_3S - \mathsf{C}_4$$

for some constants  $C_3, C_4 > 0$ , where  $\Delta'$  is the Laplacian operator with respect to the metric  $\omega_f$ .

The following lemma can be found in [2].

Lemma 2.3.

(2.9) 
$$\Delta'T \geq \sum f^{i\bar{j}} f^{n\bar{l}} f^{k\bar{h}} f^{m\bar{p}} g_{k\bar{l}} \phi_{;n\bar{p}\bar{j}} \phi_{;m\bar{h}i} + \sum f^{m\bar{l}} f^{k\bar{h}} g_{k\bar{l}} R_{m\bar{h}}(\omega_f) - \|R_{i\bar{j}k\bar{l}}(\omega_g)\|_g T^2,$$

(2.10)  $\Delta' \log T \geq - \|R_{i\bar{j}}(\omega_f)\|_f - \|R_{i\bar{j}k\bar{l}}(\omega_g)\|_g T.$ 

where  $R_{i\bar{j}k\bar{l}}(\omega_g)$  denotes the holomorphic bisectional curvature of the metric  $\omega_g$ .

Since  $g_{i\bar{j}}=\delta_{ij}$  and  $R_{i\bar{j}}(\omega_f)=0,$  by (2.9) and (2.10) we have

(2.11) 
$$\Delta' T \ge \frac{1}{\lambda_i \lambda_m \lambda_k^2} |\phi_{;k\bar{m}i}|^2 \ge \mathsf{C}_1^{-1} S, \qquad \Delta' \log \ T \ge 0$$

2.2. Estimate of S. By (2.8) and (2.11) we have

**Lemma 2.4.** There are constants A > 0,  $C_5$ ,  $C_6 > 0$  such that

$$\Delta'(S + AT) \ge \mathsf{C}_5 S - \mathsf{C}_6.$$

Now we prove

**Lemma 2.5.** Suppose that  $T \leq C_2$  in  $B_f(0, a)$ , where  $a \geq 1$ . Then, in  $B_f(0, a/2)$ , we have

$$S \le \mathsf{C}_7\left(1 + \frac{1}{a^2}\right).$$

where  $C_7$  is a constant depending only on  $C_1$ .

**Proof.** Consider the function

$$\mathbf{F} = (a^2 - r^2)^2 e^{\alpha T} (S + AT)$$

defined on  $B_f(0, a)$ , where  $\alpha < 1$  is a constant to be determined later. F attains its supremum at some interior point  $p^*$ . Then, at  $p^*$ ,

(2.12) 
$$\left(-\frac{2(r^2)_{,i}}{a^2 - r^2} + \alpha T_{,i}\right) + \frac{(S + AT)_{,i}}{(S + AT)} = 0,$$

$$(2.13) \quad \left(-\frac{2\Delta'(r^2)}{a^2 - r^2} - \frac{2\|\nabla(r^2)\|_f^2}{(a^2 - r^2)^2} + \alpha\Delta'T\right) + \frac{\Delta'(S + AT)}{(S + AT)} - \frac{\|\nabla(S + AT)\|_f^2}{(S + AT)^2} \le 0.$$

Using the Schwarz inequality and (2.12) we obtain

(2.14) 
$$\frac{\|\nabla(S+AT)\|_{f}^{2}}{(S+AT)^{2}} \le (1+\frac{1}{\delta})\frac{4\|\nabla r^{2}\|^{2}}{(a^{2}-r^{2})^{2}} + \alpha^{2}(1+\delta)\|\nabla T\|_{f}^{2}$$

On the other hand, it is easy to check that

$$\|\nabla T\|_f^2 \le n\mathsf{C}_1^2S.$$

In fact, we choose local coordinates such that

$$f_{i\bar{j}} = \lambda_i \delta_{ij}, \quad g_{i\bar{j}} = \delta_{ij}.$$

Then

$$\|\nabla T\|_{f}^{2} = \sum_{k} \frac{1}{\lambda_{k}} \left| \sum_{i} \frac{1}{\lambda_{i}^{2}} \varphi_{;i\bar{i}k} \right|^{2} \leq \mathsf{C}_{1}^{2} \sum_{k} \frac{1}{\lambda_{k}} \left| \sum_{i} \frac{1}{\lambda_{i}} \varphi_{;i\bar{i}k} \right|^{2} \leq n\mathsf{C}_{1}^{2}S.$$

Note that  $|\nabla r| = 1$ . Using the Laplacian comparison theorem we have

(2.16) 
$$\frac{2\Delta'(r^2)}{a^2 - r^2} + \frac{2\|\nabla(r^2)\|^2}{(a^2 - r^2)^2} \le \frac{4a^2}{(a^2 - r^2)^2} + \frac{C(n)}{a^2 - r^2}.$$

Then we obtain that

(2.17) 
$$(1 - n\mathsf{C}_1^3(1+\delta)\alpha)\mathsf{C}_1^{-1}\alpha S \le C\left(1 + \frac{a^2}{(a^2 - r^2)^2}\right)$$

Choose  $\delta = 1$  and  $\alpha$  small such that  $nC_1^3(1+\delta)\alpha \leq \frac{1}{2}$ . By  $T < nC_1$  we have

$$(a^2 - r^2)^2 e^{\alpha T} (S + AT) \le C (a^4 + a^2).$$

Then Lemma 2.5 is proved.

2.3. **Proof of Theorem 1.2.** Let  $p = (z_o, f(z_o))$  be an arbitrary point in  $(\Omega, \omega_f)$ , we prove  $S_f(p) = 0$ . Suppose that  $S_f(p) \neq 0$ , we take a sequence  $C_k$  and a sequence of geodesic ball  $B_f(0, 2C_k)$  with  $C_k \to \infty$ . We take a sequence of linear transformations:

(2.18) 
$$\dot{f}_k = \frac{f}{C_k^2}, \ \dot{z}_k = \frac{z}{C_k}.$$

We get a sequence of geodesic ball  $B_{f_k}(0,2)$ . Obviously,  $p \in B_{f_k}(0,1/2)$  as k large enough. Since T is invariant under these coordinate transformations, we have

$$S_{f_k}(p) = C_k^2 S_f(p) \to \infty \quad if \ S_f(p) \neq 0$$

On the other hand, by  $p \in B_{f_k}(0, 1/2)$  and Lemma 2.5,  $S_{f_k}(p)$  are uniformly bounded above by a constant independent of k, we get a contradiction. So  $S_f \equiv 0$  on whole Kähler manifold  $(\Omega, \omega_f)$ . Theorem 1.2 is proved.

**Remark 2.6.** By (2.7), and the theorem of Riebesehl and Schulz (cf. Theorem 2 in [7]) we can immediately obtain Theorem 1.2. Here we give a different proof, which has independent interest for us.

**Proof of Corollary 1.3.** By Theorem 1.2 we conclude that  $f_{i\bar{j}}, 1 \leq i, j \leq n$  are constants. Set  $v = \sum_{i,j} z_i f_{i\bar{j}}(0) \bar{z}_j$ . Then f - v satisfying

$$\frac{\partial^2}{\partial z_i \partial \bar{z}_j} (f - v) = 0, \quad \forall 1 \le i, j \le n,$$

$$|f - v| \le C(1 + |z|^2).$$

In particular, f - v is a harmonic function. By the estimates of harmonic function (cf. Theorem 1.13 in [4]) we have, for any R > 1 and any multi-index v with |v| = 2,

$$|\nabla^{\nu}(f-v)(p)| \le \frac{C(n)}{R^2} \max_{D(p,R)} |f-v| \le \frac{C(n)}{R^2} \max_{D(0,R+d_E(0,p))} |f-v|,$$

where  $d_E(0, p)$  denotes the Euclidean distance from 0 to p, D(p, R) denotes Euclidean ball centered at p with radius R. Choose R big enough, we have  $|\nabla^{\nu}(f - v)(p)| \leq C$ . Then by Liouville Theorem we have f - v is quadratic.

## 3. Proof of Theorem 1.4

Denote  $S_f(0,b) := \{z | f(z) \leq b\}$ . Consider the function defined on the section  $S_f(0,b)$ 

$$\mathbf{F} := \exp\left\{-\frac{b}{b-f}\right\} \frac{\|\nabla f\|_f^2}{(1+f)^2}$$

**F** attains its supremum at some interior point  $p^*$ . We may assume  $\|\nabla f\|_f(p^*) > 0$ . Then, at  $p^*$ ,

(3.1) 
$$-\left[\frac{2f_{,i}}{1+f} + \frac{bf_{,i}}{(b-f)^2}\right] \sum f^{i\bar{j}} f_i f_{\bar{j}} + \sum f^{i\bar{j}} f_{,ik} f_{\bar{j}} + f_k = 0.$$

Choose a complex coordinate system such that, at  $p^*$ ,

$$f_{i\bar{j}} = \delta_{ij}, \ f_{,1} = f_{,\bar{1}}, \ f_{,i} = f_{,\bar{i}} = 0 \ \forall \ i > 1.$$

Then from (3.1) we have

(3.2) 
$$-\left[\frac{2f_{,1}}{1+f} + \frac{bf_{,1}}{(b-f)^2}\right]f_{,1}f_{,\bar{1}} + f_{,11}f_{\bar{1}} + f_1 = 0.$$

From (3.2) and the condition (3) of Theorem 1.4 it follows that

$$\frac{2\|\nabla f\|_f^4}{(1+f)^2} \le C(1+f)^2 + 1.$$

Then

(3.3) 
$$\exp\left\{-\frac{b}{b-f}\right\}\frac{\|\nabla f\|_{f}^{2}}{(1+f)^{2}} \leq \frac{\sqrt{C+1}}{\sqrt{2}}.$$

Since F attains its supremum at  $p^*$ , (3.3) holds everywhere on  $S_f(0, b)$ . Letting  $b \to \infty$ , we have

(3.4) 
$$\frac{\|\nabla f\|^2}{(1+f)^2} \le e \frac{\sqrt{C+1}}{\sqrt{2}} := \mathsf{C}_9.$$

Take a point  $p_1 \in \partial S_f(0, b)$  such that  $d(0, p_1) = d(0, \partial S_f(0, b))$ . Let l be the shortest geodesic from 0 to  $p_1$ . Following from (3.4) we have

$$\sqrt{\mathsf{C}_9} \ge \|\nabla \log(1+f)\| \ge \left|\frac{d\log(1+f)}{ds}\right|,$$

where s denotes the arc-length parameter with respect to the metric  $f_{i\bar{j}}$ . Applying this and a direct integration we obtain

$$d(0, p_1) = \int_l ds \ge \mathsf{C}_9^{-\frac{1}{2}} \log(1+f)|_{p_1} = \mathsf{C}_9^{-\frac{1}{2}} \log\left(1+b\right).$$

As  $b \to \infty$ , we obtain  $d(0, \partial S_f(0, b)) \to +\infty$ . Hence  $\omega_f$  is complete. Then we use Corollary 1.3 to complete the proof of Theorem 1.4.
