

On certain rational recursive sequences of order four

Abstract

We obtain solutions to the recursive sequences of the form

$$x_{n+1} = \frac{x_{n-3}x_n}{x_{n-2}(a_n + b_nx_{n-3}x_n)}$$

where a_n and b_n are arbitrary sequences of real numbers, and the initial values are given as; x_{-3}, x_{-2}, x_{-1} and x_0 . Our methodology is to employ a group theoretic method which lowers the order of the equations, and then solve the resulting lower order recurrence relations that arise therefrom.

1 Introduction

Due to the work of Sophus Lie on differential equations [14], there has been great interest in the invariance properties of differential equations under groups of point transformations. Lie discovered that most of the known theories for solving differential equations are closely related to the idea of infinitesimal transformations. One of the applications of symmetry analysis (Lie's method) in differential equations is the obtention of solutions. A lot of work has been published that reflects the application of the method to difference equations [6–9, 11, 13, 17]. Symmetry analysis on difference equations started with Shigeru Maeda [15, 16] who studied the continuous point symmetries of difference equations. Nalini Joshi [11] came up with a concrete method for finding symmetries of first order difference equations and gave the local analytic diffeomorphism that makes first order discrete dynamical systems linear. In the recent past, Hydon [8, 9] came up with algorithms for finding symmetries and first integrals of difference equations independent of their order. It must be stated that, applying these methods involves a lot of cumbersome and tedious calculations.

In this paper, we perform a symmetry analysis and derive closed form formulas for solutions of difference equations of the form

$$x_{n+1} = \frac{x_{n-3}x_n}{x_{n-2}(a_n + b_n x_{n-3}x_n)}, \quad (1)$$

where a_n and b_n are sequences of real numbers. For related work on this, see [2, 4, 5, 7, 12, 17].

1.1 Preliminaries

We start by recalling some terminology in Lie analysis of differential and difference equations mostly taken from [1, 8].

Definition 1.1 [1] *Let $x = (x_1; x_2; \dots; x_n)$ lie in a region $D \subset \mathcal{R}^n$. The set of transformations*

$$\tilde{x} = X(x; \varepsilon), \quad (2)$$

defined for each x in D and parameter ε in a set \mathcal{S} , a subset of \mathcal{R} , with $\phi(\varepsilon, \delta)$ defining a law of composition of parameters ε and δ in \mathcal{S} , constitutes a one-parameter group of transformations on D if the following hold:

- *For each ε in \mathcal{S} , the transformation is one-to-one and onto. (Hence, \tilde{x} lies in D).*
- *\mathcal{S} with the law of composition ϕ forms a group G .*
- *For each x in D , $\tilde{x} = x$, when $\varepsilon = \varepsilon_0$ corresponds to the identity e , that is,*

$$X(x; \varepsilon_0) = x. \quad (3)$$

- *If $\tilde{x} = X(x; \varepsilon)$, $\tilde{\tilde{x}} = X(\tilde{x}; \delta)$, it follows that*

$$\tilde{\tilde{x}} = X(x; \phi(\varepsilon, \delta)). \quad (4)$$

The above definition together with the following:

- ε is a continuous parameter, that is, \mathcal{S} is an interval in \mathcal{R} . Without a loss of generality, $\varepsilon = 0$ corresponds to the identity element e :
- X is infinitely differentiable with respect to x in D and is an analytic function of ε in \mathcal{S} .
- $\phi(\varepsilon, \delta)$ is an analytic function of ε and δ ; $\varepsilon \in \mathcal{S}$; $\delta \in \mathcal{S}$,

define a one-parameter group of transformations.

Definition 1.2 [1] *The infinitesimal generator of the one-parameter Lie group of transformations (2) is the operator*

$$X = X(x) = \xi(x) \times \Delta = \sum_{s=1}^n \xi_s(x) \frac{\partial}{\partial x_s}, \quad (5)$$

where Δ is the gradient operator

$$\Delta = \left(\frac{\partial}{\partial x_1}, \frac{\partial}{\partial x_2}, \dots, \frac{\partial}{\partial x_n} \right). \quad (6)$$

Definition 1.3 [1] *An infinitely differentiable function $F(x)$ is an invariant function of the Lie group of transformations (2) if and only if, for any group transformations,*

$$F(\tilde{x}) = F(x). \quad (7)$$

Theorem 1.1 [1] *$F(x)$ is invariant under the Lie group of transformations (2) if and only if,*

$$XF(x) = 0. \quad (8)$$

Considering the r th-order difference equation

$$u_{n+r+1} = \varphi(n, u_n, u_{n+1}, \dots, u_{n+r}). \quad (9)$$

We employ the infinitesimal group of point transformations

$$(n, u_{n+s}) \mapsto (\tilde{n} = n, \tilde{u}_{n+s} = u_{n+s} + \varepsilon \xi(n+s, u_{n+s})) \quad (10)$$

and let

$$\mathcal{X} = \xi(n, u_n) \frac{\partial}{\partial u_n} \quad (11)$$

be the generator of the group transformations with prolonged form

$$X = \mathcal{X}^{[r]} = \xi(n, u_n) \frac{\partial}{\partial u_n} + \xi(n+1, u_{n+1}) \frac{\partial}{\partial u_n} + \dots + \xi(n+r, u_{n+r}) \frac{\partial}{\partial u_{n+r}}. \quad (12)$$

A symmetry is a group of transformations that maps solutions onto other solutions. Here, the criterion of invariance is given by

$$\tilde{u}_{n+r+1} = \varphi(\tilde{n}, \tilde{u}_n, \tilde{u}_{n+1}, \dots, \tilde{u}_{n+r}), \quad (13)$$

whenever (9) holds. As a result, the linearized symmetry condition becomes

$$S^{r+1}\xi(n, u_n) - X\varphi = 0. \quad (14)$$

2 Main results

We consider ordinary difference equations;

$$u_{n+4} = \varphi = \frac{u_n u_{n+3}}{u_{n+1}(A_n + B_n u_n u_{n+3})}, \quad (15)$$

where A_n and B_n are random real sequences, equivalent to (1).

By the criterion of invariance (14),

$$\begin{aligned} \xi(n+4, \varphi) - \frac{A_n u_n \xi(n+3, u_{n+3})}{u_{n+1}(A_n + B_n u_n u_{n+3})^2} + \frac{u_n u_{n+3} \xi(n+1, u_{n+1})}{u_{n+1}^2 (A_n + B_n u_n u_{n+3})} \\ - \frac{A_n u_{n+3} \xi(n, u_n)}{u_{n+1}(A_n + B_n u_n u_{n+3})^2} = 0. \end{aligned} \quad (16)$$

To solve for ξ , we differentiate implicitly, the functional equation (16) with respect to u_n by viewing u_{n+1} as a function of u_n , u_{n+3} and φ . That is, to operate

$$L = \frac{\partial}{\partial u_n} + \frac{\partial u_{n+1}}{\partial u_n} \frac{\partial}{\partial u_{n+1}} = \frac{\partial}{\partial u_n} - \frac{\frac{\partial \varphi}{\partial u_n}}{\frac{\partial \varphi}{\partial u_{n+1}}} \frac{\partial}{\partial u_{n+1}}$$

on (16). This leads to

$$\begin{aligned} B_n u_n^2 u_{n+1} \xi(n+3, u_{n+3}) + (A_n u_n + B_n u_n^2 u_{n+3}) u_{n+1} \xi'(n+1, u_{n+1}) - (A_n u_n \\ + B_n u_n^2 u_{n+3}) \xi(n+1, u_{n+1}) - (A_n u_n + B_n u_n^2 u_{n+3}) u_{n+1} \xi'(n, u_n) + (2B_n u_n u_{n+3} \\ + A_n) u_{n+1} \xi(n, u_n) = 0 \end{aligned} \quad (17)$$

after clearing fractions. By thrice differentiating (17) with respect to u_n , keeping u_{n+1} fixed, we obtain

$$-u_n u_{n+1} (A_n + B_n u_n u_{n+3}) \xi^{(4)}(n, u_n) - 2u_{n+1} (A_n + 2B_n u_n u_{n+3}) \xi^{(3)}(n, u_n) = 0. \quad (18)$$

We separate (18) based on the fact that the function ξ depends on the continuous variable u_n only. We get

$$u_{n+1} u_{n+3} \quad \text{terms : } u_n \xi^{(4)}(n, u_n) + 4\xi^{(3)}(n, u_n) = 0 \quad (19)$$

$$u_{n+1} \quad \text{terms : } u_n \xi^{(4)}(n, u_n) + 2\xi^{(3)}(n, u_n) = 0. \quad (20)$$

Equivalently,

$$\xi(n, u_n) = \beta_n u_n^2 + \gamma_n u_n + \lambda_n \quad (21)$$

for some functions β_n , γ_n and λ_n of n .

Here, we perform a substitution of (21) into (16) and separate the resulting equation by setting the coefficients of products of shifts of u_n to zero (since the functions β_n , γ_n and λ_n depend on n only). This leads to the following system:

$$u_n^2 u_{n+1}^2 u_{n+3}^2 \text{ terms : } B_n^2 \lambda_{n+4} + B_n \beta_{n+1} = 0 \quad (22a)$$

$$u_n u_{n+1}^2 u_{n+3} \text{ terms : } 2A_n B_n \lambda_{n+1} + A_n \beta_{n+1} = 0 \quad (22b)$$

$$u_n^2 u_{n+1} u_{n+3}^2 \text{ terms : } B_n \gamma_{n+1} + B_n \gamma_{n+4} = 0 \quad (22c)$$

$$u_n^2 u_{n+1} u_{n+3} \text{ terms : } -A_n \beta_n = 0 \quad (22d)$$

$$u_n^2 u_{n+3}^2 \text{ terms : } B_n \lambda_{n+1} + \beta_{n+4} = 0 \quad (22e)$$

$$u_n u_{n+1} u_{n+3}^2 \text{ terms : } -A_n \beta_{n+3} = 0 \quad (22f)$$

$$u_{n+1}^2 \text{ terms : } A_n^2 \lambda_{n+4} = 0 \quad (22g)$$

$$u_n u_{n+1} u_{n+3} \text{ terms : } -A_n \gamma_n + A_n \gamma_{n+1} - A_n \gamma_{n+3} + A_n \gamma_{n+4} = 0 \quad (22h)$$

$$u_n u_{n+1} \text{ terms : } -A_n \lambda_{n+3} = 0 \quad (22i)$$

$$u_n u_{n+3} \text{ terms : } A_n \lambda_{n+1} = 0 \quad (22j)$$

$$u_{n+1} u_{n+3} \text{ terms : } -A_n \lambda_n = 0. \quad (22k)$$

Solving (22) leads to the following ‘final constraint’:

$$\beta_n = 0 \quad (23)$$

$$\lambda_n = 0 \quad (24)$$

$$\gamma_n + \gamma_{n+3} = 0. \quad (25)$$

It is not difficult to see that $(-1)^n$, $\exp(i\pi n/3)$ and $\exp(-i\pi n/3)$ are the solutions of (25). Set $\gamma = \exp(i\pi/3)$. Thanks to (21), the three characteristics are thus given as

$$\xi_1 = (-1)^n u_n, \quad \xi_2 = \gamma^n u_n \quad \text{and} \quad \xi_3 = \bar{\gamma}^n u_n. \quad (26a)$$

Hence, the ‘prolongation’ of the spanning vectors of the Lie algebra of (15) are as follows:

$$X_1 = (-1)^n u_n \frac{\partial}{\partial u_n} + (-1)^{n+1} u_{n+1} \frac{\partial}{\partial u_{n+1}} + (-1)^{n+2} u_{n+2} \frac{\partial}{\partial u_{n+2}} + (-1)^{n+3} u_{n+3} \frac{\partial}{\partial u_{n+3}}, \quad (27a)$$

$$X_2 = \gamma^n u_n \frac{\partial}{\partial u_n} + \gamma^{n+1} u_{n+1} \frac{\partial}{\partial u_{n+1}} + \gamma^{n+2} u_{n+2} \frac{\partial}{\partial u_{n+2}} + \gamma^{n+3} u_{n+3} \frac{\partial}{\partial u_{n+3}}, \quad (27b)$$

$$X_3 = \bar{\gamma}^n u_n \frac{\partial}{\partial u_n} + \bar{\gamma}^{n+1} u_{n+1} \frac{\partial}{\partial u_{n+1}} + \bar{\gamma}^{n+2} u_{n+2} \frac{\partial}{\partial u_{n+2}} + \bar{\gamma}^{n+3} u_{n+3} \frac{\partial}{\partial u_{n+3}}. \quad (27c)$$

Using ξ_2 , the canonical coordinate [11] that linearizes (15) is

$$S_n = \int \frac{du_n}{\xi_2(n, u_n)} = \frac{1}{\gamma^n} \ln |u_n|. \quad (28)$$

Now, inspired by the form of the ‘final constraint’(25), we define the invariant function

$$\tilde{V}_n = \gamma^n S_n + \gamma^{n+3} S_{n+3} \quad (29)$$

since

$$X_1 \tilde{V}_n = X_2 \tilde{V}_n = X_3 \tilde{V}_n = 0. \quad (30)$$

For the sake of simplicity, we will be making use of the function V_n defined as:

$$|V_n| = \exp\{-\tilde{V}_n\}, \quad (31)$$

that is to say, $V_n = \pm 1/(u_n u_{n+3})$ but we shall utilize the plus sign:

$$V_n = \frac{1}{u_n u_{n+3}}. \quad (32)$$

Substituting (31) into equation (15), we obtain a first-order linear difference equation:

$$V_{n+1} = A_n V_n + B_n \quad (33)$$

whose solution in closed form is

$$V_n = V_0 \left(\prod_{k_1=0}^{n-1} A_{k_1} \right) + \sum_{l=0}^{n-1} \left(B_l \prod_{k_2=l+1}^{n-1} A_{k_2} \right). \quad (34)$$

From (28), (29) and (31), we get

$$\begin{aligned} |u_n| &= \exp \left((-1)^n c_1 + \bar{\gamma}^n c_2 + \gamma^n c_3 + (-1)^n \sum_{k_1=0}^{n-1} \frac{1}{3} (-1)^{-k_1} \ln |V_{k_1}| + \bar{\gamma}^n \sum_{k_2=0}^{n-1} \frac{1}{3} \gamma^{k_2} \ln |V_{k_2}| \right. \\ &\quad \left. + \gamma^n \sum_{k_3=1}^{n-1} \frac{1}{3} \bar{\gamma}^{k_3} \ln |V_{k_3}| \right) \\ &= \exp \left\{ H_n + \frac{1}{3} \sum_{k=0}^{n-1} [(-1)^{n-k} + 2\text{Re}(\mathbb{H}(n, k))] \ln |V_k| \right\} \end{aligned} \quad (35)$$

where $\text{Re}(z)$ is the real part of z ,

$$H_n = (-1)^n c_1 + \bar{\gamma}^n c_2 + \gamma^n c_3, \quad (36a)$$

$$\mathbb{H}(n, k) = \gamma^n \bar{\gamma}^k. \quad (36b)$$

Recall that $\gamma = \exp i\pi/3$. It is easy to verify that

$$\exp(H_{6n+j}) = \exp(H_j) = |u_j|, \quad 0 \leq j \leq 2, \quad (37a)$$

$$\exp(H_{6n+j}) = \exp(H_j) = |V_{j-3}| |u_j|, \quad 3 \leq j \leq 5, \quad (37b)$$

$$\mathbb{H}(6n+j, k) = \mathbb{H}(j, 6n+k) = \mathbb{H}(j, k), \quad (37c)$$

$$\mathbb{H}(n+3, k) = \mathbb{H}(n, k+3) = -\mathbb{H}(n, k). \quad (37d)$$

Using (31), together with properties (37), in (35), we get

$$|u_{6n+j}| = \exp \left\{ H_j + \frac{1}{3} \sum_{k=0}^{6n+j-1} [(-1)^{6n+j-k} + 2\text{Re}(\mathbb{H}(j, k))] \ln |V_k| \right\} \quad (38)$$

$$= |u_j| \prod_{s=0}^{n-1} \left| \frac{V_{6n+j}}{V_{6n+j+3}} \right|. \quad (39)$$

Using (32), it can be shown that there is not need of the absolute values, thus

$$\begin{aligned} u_{6n+j} &= u_j \prod_{s=0}^{n-1} \frac{V_{6n+j}}{V_{6n+j+3}} \\ &= u_j \prod_{s=0}^{n-1} \frac{V_0 \left(\prod_{k_1=0}^{6n+j-1} A_{k_1} \right) + \sum_{l=0}^{6n+j-1} \left(B_l \prod_{k_2=l+1}^{6n+j-1} A_{k_2} \right)}{V_0 \left(\prod_{k_1=0}^{6n+j+2} A_{k_1} \right) + \sum_{l=0}^{6n+j+2} \left(B_l \prod_{k_2=l+1}^{6n+j+2} A_{k_2} \right)} \\ &= u_j \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+j-1} A_{k_1} \right) + \frac{1}{V_0} \sum_{l=0}^{6n+j-1} \left(B_l \prod_{k_2=l+1}^{6n+j-1} A_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+j+2} A_{k_1} \right) + \frac{1}{V_0} \sum_{l=0}^{6n+j+2} \left(B_l \prod_{k_2=l+1}^{6n+j+2} A_{k_2} \right)} \\ &= u_j \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+j-1} A_{k_1} \right) + u_0 u_3 \sum_{l=0}^{6n+j-1} \left(B_l \prod_{k_2=l+1}^{6n+j-1} A_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+j+2} A_{k_1} \right) + u_0 u_3 \sum_{l=0}^{6n+j+2} \left(B_l \prod_{k_2=l+1}^{6n+j+2} A_{k_2} \right)} \end{aligned}$$

so that, for $j = 0, 1, 2, 3, 4, 5$, we have

$$x_{6n+j-3} = x_{j-3} \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+j-1} a_{k_1} \right) + x_{-3} x_0 \sum_{l=0}^{6n+j-1} \left(b_l \prod_{k_2=l+1}^{6n+j-1} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+j+2} a_{k_1} \right) + x_{-3} x_0 \sum_{l=0}^{6n+j+2} \left(b_l \prod_{k_2=l+1}^{6n+j+2} a_{k_2} \right)}. \quad (40)$$

Hence, the solution $\{x_n\}_{n=1}^{\infty}$ expressed in terms of the initial values $x_{-3}, x_{-2}, x_{-1}, x_0$ is given by;

$$x_{6n-3} = x_{-3} \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n-1} a_{k_1} \right) + x_{-3} x_0 \sum_{l=0}^{6n-1} \left(b_l \prod_{k_2=l+1}^{6n-1} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+2} a_{k_1} \right) + x_{-3} x_0 \sum_{l=0}^{6n+2} \left(b_l \prod_{k_2=l+1}^{6n+2} a_{k_2} \right)}, \quad (41)$$

$$x_{6n-2} = x_{-2} \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n} \left(b_l \prod_{k_2=l+1}^{6n} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+3} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+3} \left(b_l \prod_{k_2=l+1}^{6n+3} a_{k_2} \right)}, \quad (42)$$

$$x_{6n-1} = x_{-1} \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+1} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+1} \left(b_l \prod_{k_2=l+1}^{6n+1} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+4} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+4} \left(b_l \prod_{k_2=l+1}^{6n+4} a_{k_2} \right)}, \quad (43)$$

$$x_{6n} = x_0 \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+2} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+2} \left(b_l \prod_{k_2=l+1}^{6n+2} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+5} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+5} \left(b_l \prod_{k_2=l+1}^{6n+5} a_{k_2} \right)}, \quad (44)$$

$$x_{6n+1} = \frac{x_{-3}x_0}{x_{-2}(a_0 + b_0x_{-3}x_0)} \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+3} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+3} \left(b_l \prod_{k_2=l+1}^{6n+3} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+6} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+6} \left(b_l \prod_{k_2=l+1}^{6n+6} a_{k_2} \right)}, \quad (45)$$

$$x_{6n+2} = \frac{x_{-3}x_0}{x_{-1}(a_0a_1 + (a_1b_0 + b_1)x_{-3}x_0)} \prod_{s=0}^{n-1} \frac{\left(\prod_{k_1=0}^{6n+4} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+4} \left(b_l \prod_{k_2=l+1}^{6n+4} a_{k_2} \right)}{\left(\prod_{k_1=0}^{6n+7} a_{k_1} \right) + x_{-3}x_0 \sum_{l=0}^{6n+7} \left(b_l \prod_{k_2=l+1}^{6n+7} a_{k_2} \right)}. \quad (46)$$

In the following section we look at a special case when the sequences a_n and b_n are 1-periodic.

2.1 The case a_n and b_n are 1-periodic

In this case, set $a_n = a$ and $b_n = b$ where $a, b \in \mathbb{R}$. Then by direct substitution in the solution above, we have

$$x_{6n-3} = x_{-3} \prod_{s=0}^{n-1} \frac{a^{6n} + bx_{-3}x_0 \sum_{l=0}^{6n-1} a^l}{a^{6n+3} + bx_{-3}x_0 \sum_{l=0}^{6n+2} a^l}, \quad x_{6n-2} = x_{-2} \prod_{s=0}^{n-1} \frac{a^{6n+1} + bx_{-3}x_0 \sum_{l=0}^{6n} a^l}{a^{6n+4} + bx_{-3}x_0 \sum_{l=0}^{6n+3} a^l},$$

$$x_{6n-1} = x_{-1} \prod_{s=0}^{n-1} \frac{a^{6n+2} + bx_{-3}x_0 \sum_{l=0}^{6n+1} a^l}{a^{6n+5} + bx_{-3}x_0 \sum_{l=0}^{6n+4} a^l}, \quad x_{6n} = x_0 \prod_{s=0}^{n-1} \frac{a^{6n+3} + bx_{-3}x_0 \sum_{l=0}^{6n+2} a^l}{a^{6n+6} + bx_{-3}x_0 \sum_{l=0}^{6n+5} a^l},$$

$$x_{6n+1} = c \prod_{s=0}^{n-1} \frac{a^{6n+4} + bx_{-3}x_0 \sum_{l=0}^{6n+3} a^l}{a^{6n+7} + bx_{-3}x_0 \sum_{l=0}^{6n+6} a^l}, \quad x_{6n+2} = d \prod_{s=0}^{n-1} \frac{a^{6n+5} + bx_{-3}x_0 \sum_{l=0}^{6n+4} a^l}{a^{6n+8} + bx_{-3}x_0 \sum_{l=0}^{6n+7} a^l},$$

where $c = \frac{x_{-3}x_0}{x_{-2}(a+bx_{-3}x_0)}$ and $d = \frac{x_{-3}x_0}{x_{-1}(a^2+(ab+b)x_{-3}x_0)}$.

2.1.1 The case $a = 1$

$$x_{6n-3} = x_{-3} \prod_{s=0}^{n-1} \frac{1 + (6n)bx_{-3}x_0}{1 + (6n+3)bx_{-3}x_0}, \quad x_{6n-2} = x_{-2} \prod_{s=0}^{n-1} \frac{1 + (6n+1)bx_{-3}x_0}{1 + (6n+4)bx_{-3}x_0},$$

$$x_{6n-1} = x_{-1} \prod_{s=0}^{n-1} \frac{1 + (6n+2)bx_{-3}x_0}{1 + (6n+5)bx_{-3}x_0}, \quad x_{6n} = x_0 \prod_{s=0}^{n-1} \frac{1 + (6n+3)bx_{-3}x_0}{1 + (6n+6)bx_{-3}x_0},$$

$$x_{6n+1} = c \prod_{s=0}^{n-1} \frac{1 + (6n+4)bx_{-3}x_0}{1 + (6n+7)bx_{-3}x_0}, \quad x_{6n+2} = d \prod_{s=0}^{n-1} \frac{1 + (6n+5)bx_{-3}x_0}{1 + (6n+8)bx_{-3}x_0}.$$

where $c = \frac{x_{-3}x_0}{x_{-2}(1+bx_{-3}x_0)}$ and $d = \frac{x_{-3}x_0}{x_{-1}(1+2bx_{-3}x_0)}$.

2.1.2 The case $a \neq 1$

For this case, we obtain

$$x_{6n-3} = x_{-3} \prod_{s=0}^{n-1} \frac{a^{6n} + bx_{-3}x_0 \left(\frac{1-a^{6n}}{1-a} \right)}{a^{6n+3} + bx_{-3}x_0 \left(\frac{1-a^{6n+3}}{1-a} \right)}, \quad x_{6n-2} = x_{-2} \prod_{s=0}^{n-1} \frac{a^{6n+1} + bx_{-3}x_0 \left(\frac{1-a^{6n+1}}{1-a} \right)}{a^{6n+4} + bx_{-3}x_0 \left(\frac{1-a^{6n+4}}{1-a} \right)},$$

$$x_{6n-1} = x_{-1} \prod_{s=0}^{n-1} \frac{a^{6n+2} + bx_{-3}x_0 \left(\frac{1-a^{6n+2}}{1-a} \right)}{a^{6n+5} + bx_{-3}x_0 \left(\frac{1-a^{6n+5}}{1-a} \right)}, \quad x_{6n} = x_0 \prod_{s=0}^{n-1} \frac{a^{6n+3} + bx_{-3}x_0 \left(\frac{1-a^{6n+3}}{1-a} \right)}{a^{6n+6} + bx_{-3}x_0 \left(\frac{1-a^{6n+6}}{1-a} \right)},$$

$$x_{6n+1} = c \prod_{s=0}^{n-1} \frac{a^{6n+4} + bx_{-3}x_0 \left(\frac{1-a^{6n+4}}{1-a} \right)}{a^{6n+7} + bx_{-3}x_0 \left(\frac{1-a^{6n+7}}{1-a} \right)}, \quad x_{6n+2} = d \prod_{s=0}^{n-1} \frac{a^{6n+5} + bx_{-3}x_0 \left(\frac{1-a^{6n+5}}{1-a} \right)}{a^{6n+8} + bx_{-3}x_0 \left(\frac{1-a^{6n+8}}{1-a} \right)},$$

where $c = \frac{x_{-3}x_0}{x_{-2}(a+bx_{-3}x_0)}$ and $d = \frac{x_{-3}x_0}{x_{-1}(a^2+(ab+b)x_{-3}x_0)}$.

The case $a = -1$:

For this case, we obtain the following solution:

$$x_{6n+j-3} = \begin{cases} x_{j-3}(-1 + bx_{-3}x_0)^n, & \text{if } j \text{ is odd;} \\ x_{j-3}(-1 + bx_{-3}x_0)^{-n}, & \text{if } j \text{ is even;} \end{cases}$$

where $j \in \{0, 1, 2, 3, 4, 5\}$, $x_1 = \frac{x_{-3}x_0}{x_{-2}(-1+bx_{-3}x_0)}$ and $x_2 = \frac{x_{-3}x_0}{x_{-1}}$.

3 Conclusion

In this paper, we obtained three non-trivial symmetry generators and formulas for the solutions of difference equations (1). Our approach involved Lie symmetry analysis and solving certain recurrences relations.
