# CHARACTERIZATION OF MULTILINEAR MULTIPLIERS IN TERMS OF SOBOLEV SPACE REGULARITY

ABSTRACT. We provide necessary and sufficient conditions for multilinear multiplier operators with symbols in  $L^r$ -based product-type Sobolev spaces uniformly over all annuli to be bounded from products of Hardy spaces to a Lebesgue space. We consider the case  $1 < r \le 2$  and we characterize boundedness in terms of inequalities relating the Lebesgue indices (or Hardy indices), the dimension, and the regularity and integrability indices of the Sobolev space. The case r > 2 cannot be handled by known techniques and remains open. Our result not only extends but also establishes the sharpness of previous results of Miyachi, Nguyen, Tomita, and the first author [13, 14, 15, 23], who only considered the case r = 2.

## 1. Introduction

Given a bounded function  $\sigma$  on  $\mathbb{R}^n$ , the linear Fourier multiplier operator  $T_{\sigma}$  acting on a Schwartz function f is given by

$$T_{\sigma}f(x) := \int_{\mathbb{R}^n} \sigma(\xi) \widehat{f}(\xi) e^{2\pi i \langle x, \xi \rangle} d\xi,$$

where  $\widehat{f}(\xi) := \int_{\mathbb{R}^n} f(x) e^{-2\pi i \langle x, \xi \rangle} dx$  is the Fourier transform of f. The classical Mikhlin multiplier theorem [22] states that  $T_{\sigma}$  admits an  $L^p$ -bounded extension for 1 whenever

$$\left|\partial_{\xi}^{\alpha}\sigma(\xi)\right| \lesssim_{\alpha} |\xi|^{-|\alpha|}, \quad \xi \neq 0$$

for all multi-indices  $\alpha$  with  $|\alpha| \leq [n/2]+1$ . Hörmander [19] refined this result by introducing the weaker condition

(1.1) 
$$\sup_{j \in \mathbb{Z}} \| \sigma(2^j \cdot) \widehat{\psi} \|_{L^2_s(\mathbb{R}^n)} < \infty$$

for s > n/2, where  $L_s^2(\mathbb{R}^n)$  denotes the standard fractional Sobolev space of order s on  $\mathbb{R}^n$  and  $\psi$  is a Schwartz function on  $\mathbb{R}^n$  whose Fourier transform is supported in the annulus  $1/2 < |\xi| < 2$  and satisfies  $\sum_{j \in \mathbb{Z}} \widehat{\psi}(\xi/2^j) = 1$  for  $\xi \neq 0$ . Calderón and Torchinsky [2] proved that if (1.1) holds for s > n/p - n/2, then  $T_{\sigma}$  is bounded on  $H^p(\mathbb{R}^n)$  for  $0 . They also showed that <math>L_s^2$  in (1.1) can be replaced by  $L_s^r$  for the  $L^p$ -boundedness, using a complex interpolation method, and their assumptions were weakened by Grafakos, He, Honzík, and Nguyen [10].

The multilinear counterparts of the Fourier multiplier theory have analogous formulations but substantially more complicated proofs. Let m be a positive integer greater than 1; this

index will serve as the degree of the multilinearity of a Fourier multiplier. For a bounded function  $\sigma$  on  $(\mathbb{R}^n)^m$  we define the corresponding m-linear multiplier operator  $T_{\sigma}$  by

$$T_{\sigma}(f_1,\ldots,f_m)(x) := \int_{(\mathbb{R}^n)^m} \sigma(\vec{\boldsymbol{\xi}}) \Big( \prod_{j=1}^m \widehat{f_j}(\xi_j) \Big) e^{2\pi i \langle x, \sum_{j=1}^n \xi_j \rangle} d\vec{\boldsymbol{\xi}}$$

for Schwartz functions  $f_j$  on  $\mathbb{R}^n$ , where  $\vec{\boldsymbol{\xi}} := (\xi_1, \dots, \xi_m)$  and  $d\vec{\boldsymbol{\xi}} := d\xi_1 \cdots d\xi_m$ . As a multilinear extension of Mikhlin's result, Coifman and Meyer [3] proved that if L is sufficiently large and  $\sigma$  satisfies

$$\left| \partial_{\xi_1}^{\alpha_1} \cdots \partial_{\xi_m}^{\alpha_m} \sigma(\xi_1, \dots, \xi_m) \right| \lesssim_{\alpha_1, \dots, \alpha_m} \left( |\xi_1| + \dots + |\xi_m| \right)^{-(|\alpha_1| + \dots + |\alpha_m|)}$$

for multi-indices  $\alpha_1, \ldots, \alpha_m$  satisfying  $|\alpha_1| + \cdots + |\alpha_m| \leq L$ , then  $T_\sigma$  is bounded from  $L^{p_1} \times \cdots \times L^{p_m}$  to  $L^p$  for all  $1 < p_1, \ldots, p_m \leq \infty$  and  $1 with <math>1/p_1 + \cdots + 1/p_m = 1/p$ . This result was extended to  $p \leq 1$  by Kenig and Stein [21] and Grafakos and Torres [18].

Let  $\Psi^{(m)}$  be the *m*-linear counterpart of  $\psi$ . That is,  $\Psi^{(m)}$  is a Schwartz function on  $(\mathbb{R}^n)^m$  having the properties:

$$\operatorname{Supp}(\widehat{\Psi^{(m)}}) \subset \big\{\vec{\pmb{\xi}} \in (\mathbb{R}^n)^m : 1/2 \leq |\vec{\pmb{\xi}}| \leq 2\big\}, \qquad \sum_{j \in \mathbb{Z}} \widehat{\Psi^{(m)}}(\vec{\pmb{\xi}}/2^j) = 1, \quad \vec{\pmb{\xi}} \neq \vec{\pmb{0}}.$$

Let  $(\vec{I} - \vec{\Delta})^{s/2}F = \left( (1 + 4\pi^2(|\cdot_1|^2 + \dots + |\cdot_m|^2))^{s/2}\widehat{F} \right)^{\vee}$  for a nice function on  $(\mathbb{R}^n)^m$ , where  $F^{\vee}(\vec{\xi}) := \widehat{F}(-\vec{\xi})$  is the inverse Fourier transform of F. For  $s \geq 0$  and  $0 < r < \infty$  we define the Sobolev space  $L_s^r((\mathbb{R}^n)^m)$  in terms of the finiteness of the norm:

(1.2) 
$$||F||_{L_s^r((\mathbb{R}^n)^m)} := ||(\vec{I} - \vec{\Delta})^{s/2} F||_{L^r((\mathbb{R}^n)^m)}.$$

Tomita [27] was the first to obtain an  $L^{p_1} \times \cdots \times L^{p_m}$  to  $L^p$  boundedness for  $T_{\sigma}$  in the range  $1 < p_1, \ldots, p_m, p < \infty$ , under a condition analogous to (1.1) for the Sobolev space  $L_s^r((\mathbb{R}^n)^m)$ . Grafakos and Si [17] extended this result to  $p \leq 1$  using  $L^r$ -based Sobolev norms of  $\sigma$  for  $1 < r \leq 2$ :

**Theorem A.** ([17]) Let  $1 < r \le 2, r \le p_1, \dots, p_m < \infty, 0 < p < \infty, \text{ and } 1/p_1 + \dots + 1/p_m = 1/p$ . Suppose that

$$s > mn/r$$
.

If  $\sigma$  satisfies

(1.3) 
$$\sup_{j \in \mathbb{Z}} \| \sigma(2^j \cdot_1, \dots, 2^j \cdot_m) \widehat{\Psi^{(m)}} \|_{L^r_s((\mathbb{R}^n)^m)} < \infty,$$

then we have

$$||T_{\sigma}(f_1,\ldots,f_m)||_{L^p(\mathbb{R}^n)} \lesssim \sup_{j\in\mathbb{Z}} ||\sigma(2^j\cdot_1,\ldots,2^j\cdot_m)\widehat{\Psi^{(m)}}||_{L^r_s((\mathbb{R}^n)^m)} \prod_{i=1}^m ||f_i||_{L^{p_i}(\mathbb{R}^n)}$$

for functions  $f_1, \ldots, f_m \in \mathcal{S}(\mathbb{R}^n)$ .

In the preceding theorem and in the rest of this paper,  $S(\mathbb{R}^n)$  denotes the space of all Schwartz functions on  $\mathbb{R}^n$ .

The standard Sobolev space in (1.3) in many recent multiplier results is replaced by a product type Sobolev space where the different powers of the Laplacian fall on different variables  $\xi_i \in \mathbb{R}^n$ . For  $s_1, \ldots, s_m \geq 0$  and a function F on  $(\mathbb{R}^n)^m$  let

$$(I - \Delta_1)^{s_1/2} \cdots (I - \Delta_m)^{s_m/2} F := ((1 + 4\pi^2 |\cdot_1|^2)^{s_1/2} \cdots (1 + 4\pi^2 |\cdot_m|^2)^{s_m/2} \widehat{F})^{\vee}$$

and for  $0 < r < \infty$  and  $\vec{s} := (s_1, \ldots, s_m)$ , define

$$||F||_{L^r_{\overline{s}}((\mathbb{R}^n)^m)} := ||(I - \Delta_1)^{s_1/2} \cdots (I - \Delta_m)^{s_m/2} F||_{L^r((\mathbb{R}^n)^m)}.$$

Here  $\Delta_i$  is the Laplacian acting in the *i*th variable and  $s_i \geq 0$ . Note that for  $1 < r < \infty$  and  $s \geq s_1 + \cdots + s_m$ , we have

(1.4) 
$$||F||_{L^{r}_{(s_{1},...,s_{m})}((\mathbb{R}^{n})^{m})} \lesssim ||F||_{L^{r}_{s}((\mathbb{R}^{n})^{m})}.$$

When r=2, this is an immediate consequence of the pointwise estimate

$$(1 + 4\pi^2 |\xi_1|^2)^{s_1/2} \cdots (1 + 4\pi^2 |\xi_m|^2)^{s_m/2} \le (1 + 4\pi^2 (|\xi_1|^2 + \cdots + |\xi_m|^2))^{s/2}$$

for  $s \geq s_1 + \cdots + s_m$ . In general, it follows from the fact that for  $s \geq s_1 + \cdots + s_m$ 

$$\mathcal{N}(\xi_1, \dots, \xi_m) := \frac{(1 + 4\pi^2 |\xi_1|^2)^{s_1/2} \cdots (1 + 4\pi^2 |\xi_m|^2)^{s_m/2}}{(1 + 4\pi^2 (|\xi_1|^2 + \dots + |\xi_m|^2))^{s/2}}$$

is an  $L^r((\mathbb{R}^n)^m)$ -multiplier for  $1 < r < \infty$  due to the Marcinkiewicz multiplier theorem, which proves the inequality below

$$||F||_{L^{r}_{(s_{1},...,s_{m})}((\mathbb{R}^{n})^{m})} = ||(I_{1} - \Delta_{1})^{s_{1}/2} \cdots (I_{m} - \Delta_{m})^{s_{m}/2} F||_{L^{r}((\mathbb{R}^{n})^{m})}$$

$$= ||T_{\mathcal{N}}(\vec{I} - \vec{\Delta})^{s/2} F||_{L^{r}((\mathbb{R}^{n})^{m})}$$

$$\lesssim ||(\vec{I} - \vec{\Delta})^{s/2} F||_{L^{r}((\mathbb{R}^{n})^{m})} = ||F||_{F^{r}_{s}((\mathbb{R}^{n})^{m})},$$

where  $T_{\mathcal{N}}$  is the multiplier operator associated with  $\mathcal{N}$ .

For a function  $\sigma$  on  $(\mathbb{R}^n)^m$ , throughout this work we will use the notation:

$$\mathcal{L}^{r,\Psi^{(m)}}_{\vec{\boldsymbol{s}}}[\sigma] := \sup_{j \in \mathbb{Z}} \| \sigma(2^j \cdot_1, \dots, 2^j \cdot_m) \widehat{\Psi^{(m)}} \|_{L^r_{\vec{\boldsymbol{s}}}((\mathbb{R}^n)^m)}.$$

Research work has also focused on boundedness properties of  $T_{\sigma}$  under the assumption  $\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] < \infty$  for given  $\vec{s}$ . Under this assumption with r=2, Fujita and Tomita [7] provided weighted estimates for  $T_{\sigma}$ . Miyachi and Tomita [23] obtained boundedness for bilinear multipliers (i.e., m=2) in the full range of indices  $0 < p, p_1, p_2 \le \infty$  extending a result of Calderón and Torchinsky [2] to the bilinear setting; here Lebesgue spaces in the domain are replaced by Hardy spaces when  $p_i \le 1$ . Multilinear extensions were later provided by Grafakos, Miyachi, and Tomita [13], Grafakos and Nguyen [15], Grafakos, Miyachi, Nguyen, and Tomita [14], but all these results were proved only in the case r=2. We review most of these results in one formulation:

**Theorem B.** ([13, 14, 15, 23]) Let  $0 < p_1, \ldots, p_m \le \infty, 0 < p < \infty, \text{ and } 1/p_1 + \cdots + 1/p_m = 1/p$ . Suppose that

(1.5) 
$$s_1, \dots, s_m > n/2, \qquad \sum_{k \in J} (s_k/n - 1/p_k) > -1/2$$

for every nonempty subset J of  $\{1,\ldots,m\}$ . If  $\sigma$  satisfies  $\mathcal{L}^{2,\Psi^{(m)}}_{\vec{s}}[\sigma]<\infty$ , then we have

(1.6) 
$$||T_{\sigma}(f_1,\ldots,f_m)||_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^{2,\Psi^{(m)}}[\sigma] \prod_{i=1}^m ||f_i||_{H^{p_i}(\mathbb{R}^n)}$$

for Schwartz functions  $f_1, \ldots, f_m \in \mathcal{S}(\mathbb{R}^n)$ .

Here and in the sequel,  $H^p(\mathbb{R}^n)$  denotes the classical real Hardy space of Fefferman and Stein [5]. This space is defined for  $0 and coincides with <math>L^p(\mathbb{R}^n)$  for 1 .

The optimality of (1.5) was also studied in [15, 14, 23] and indeed, if (1.6) holds, then we must necessarily have

$$s_1, \dots, s_m \ge n/2, \qquad \sum_{k \in J} (s_k/n - 1/p_k) \ge -1/2$$

for every nonempty subset J of  $\{1, \ldots, m\}$ . However, this does not guarantee the validity of (1.6) in the critical case

(1.7) 
$$\min(s_1, \dots, s_m) = n/2$$
 or  $\sum_{k \in J} (s_k/n - 1/p_k) = -1/2$  for some  $J \subset \{1, \dots, m\}$ 

and recently, it was proved in Park [25] that (1.6) fails in the case (1.7) as well.

**Theorem C.** ([25]) Let  $0 < p_1, \ldots, p_m \le \infty$  and  $0 with <math>1/p_1 + \cdots + 1/p_m = 1/p_m$ . If  $\vec{s} = (s_1, \ldots, s_m)$  satisfies

$$\min(s_1,\ldots,s_m) \le n/2$$
 or  $\sum_{k \in J} (s_k/n - 1/p_k) \le -1/2$  for some  $J \subset \{1,\ldots,m\}$ ,

then there exists a function  $\sigma$  on  $(\mathbb{R}^n)^m$  such that  $\mathcal{L}^{2,\Psi^{(m)}}_{\vec{s}}[\sigma] < \infty$ , but (1.6) does not hold

Therefore (1.5) is a necessary and sufficient condition for (1.6) to hold.

In this paper, we focus on the case  $1 < r \le 2$  and we prove necessary and sufficient conditions for bounded functions  $\sigma$  on  $(\mathbb{R}^n)^m$  that satisfy the Hörmander condition  $\mathcal{L}^{r,\Psi^{(m)}}_{\vec{s}}[\sigma] < \infty$  to be bounded multilinear multipliers. The case r < 2 was also considered in [11] but the results obtained there were non optimal. The characterization we provide is given in terms of explicit inequalities relating different relevant indices and provides generalizations for Theorems B and C, and an extension of Theorem A in view of (1.4). The main result of this article is the following:

**Theorem 1.1.** Let  $1 < r \le 2$ ,  $s_1, ..., s_m \ge 0$ ,  $0 < p_1, ..., p_m \le \infty$ ,  $0 , and <math>1/p_1 + \cdots + 1/p_m = 1/p$ . Then the conditions

(1.8) 
$$s_1, \dots, s_m > n/r$$
 and  $\sum_{k \in J} (s_k/n - 1/p_k) > -1/r'$ 

hold for every nonempty subset J of  $\{1, 2, ..., m\}$  if and only if every  $T_{\sigma}$  with  $\mathcal{L}_{\vec{s}}^{r, \Psi^{(m)}}[\sigma] < \infty$  satisfies

(1.9) 
$$||T_{\sigma}(f_1,\ldots,f_m)||_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^m ||f_i||_{H^{p_i}(\mathbb{R}^n)}$$

for  $f_1, \ldots, f_m \in \mathcal{S}(\mathbb{R}^n)$ .

The implicit constant in (1.9) depends only on the dimension n, the degree of multilinearity m, and the indices  $p_j$ ,  $s_j$ , and r. Here r' = r/(r-1). We remark that, when r = 2, Theorem 1.1 coincides with Theorem B and C. Moreover, since

$$s_1, \ldots, s_m > n/r$$
 implies  $\sum_{k \in J} (s_k/n - 1/p_k) > -1/r'$  for all  $J$  when  $r \le p_1, \ldots, p_m$ ,

and

$$\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \leq \sup_{j \in \mathbb{Z}} \|\sigma(2^j \cdot 1, \dots, 2^j \cdot m) \widehat{\Psi^{(m)}}\|_{L_s^r((\mathbb{R}^n)^m)} \quad \text{for } s \geq s_1 + \dots + s_m,$$

Theorem 1.1 also covers Theorem A and extends its range of indices to  $0 < p_1, \ldots, p_m \le \infty$ .

1.1. **Necessary condition.** In order to prove the direction  $(1.9) \Rightarrow (1.8)$  in Theorem 1.1, two different multipliers will be constructed based on an idea contained in [25]. However, the methods in [25] essentially rely on Plancherel's theorem to obtain the upper bound of

$$\mathcal{L}_{\vec{s}}^{2,\Psi^{(m)}}[\sigma] = \sup_{j \in \mathbb{Z}} \left\| \left( \prod_{k=1}^{m} (1 + 4\pi^2 |\cdot_k|^2)^{s_k/2} \right) \left( \sigma(2^j \cdot_1, \dots, 2^j \cdot_m) \widehat{\Psi^{(m)}} \right)^{\vee} \right\|_{L^2((\mathbb{R}^n)^m)}$$

and this cannot be applied in the case 1 < r < 2 anymore.

To overcome this difficulty, we benefit from a recent calculation of Grafakos and Park [16] concerning a variant of the Bessel potentials that involves a logarithmic term. For any  $0 < t, \gamma < \infty$  we define

(1.10) 
$$\mathcal{H}_{(t,\gamma)}(x) := \frac{1}{(1+4\pi^2|x|^2)^{t/2}} \frac{1}{(1+\ln(1+4\pi^2|x|^2))^{\gamma/2}}.$$

We first observe that for any  $t, \gamma > 0$ 

(1.11) 
$$\mathcal{H}_{(t,\gamma)}(x-y) \ge \mathcal{H}_{(t,\gamma)}(x)\mathcal{H}_{(t,\gamma)}(y)$$

and

(1.12) 
$$\|\mathcal{H}_{(t,\gamma)}\|_{L^p(\mathbb{R}^n)} < \infty \quad \text{if and only if} \quad t > n/p \quad \text{or} \quad t = n/p, \gamma > 2/p.$$

Moreover, it was shown in [16] that

$$\left|\widehat{\mathcal{H}_{(t,\gamma)}}(\xi)\right| \lesssim_{t,\gamma,n} e^{-|\xi|/2} \quad \text{for } |\xi| > 1$$

and when 0 < t < n,

$$|\widehat{\mathcal{H}_{(t,\gamma)}}(\xi)| \approx_{t,\gamma,n} |\xi|^{-(n-t)} (1 + 2\ln|\xi|^{-1})^{-\gamma/2} \text{ for } |\xi| \le 1.$$

The estimates imply that

(1.13) 
$$\|\widehat{\mathcal{H}}_{(t,\gamma)}\|_{L^p(\mathbb{R}^n)} < \infty$$
 if and only if  $t > n - n/p$  or  $t = n - n/p, \gamma > 2/p$ .

These properties provide us with tools that allow us to prove the following two propositions:

**Proposition 1.2.** Let  $1 < r < \infty$ ,  $0 < p_1, \ldots, p_m \le \infty$ ,  $0 , and <math>1/p_1 + \cdots + 1/p_m = 1/p$ . Suppose that

$$s_1 \le s_2, \dots, s_m$$
 and  $s_1 \le n/r$ .

Then there exists a function  $\sigma$  on  $(\mathbb{R}^n)^m$  such that  $\mathcal{L}^{r,\Psi^{(m)}}_{\vec{\sigma}}[\sigma] < \infty$ , but

$$||T_{\sigma}||_{H^{p_1} \times \cdots \times H^{p_m} \to L^p} = \infty.$$

**Proposition 1.3.** Let  $1 < r < \infty$ ,  $0 < p_1, \ldots, p_m \le \infty$ ,  $0 , and <math>1/p_1 + \cdots + 1/p_m = 1/p$ . Let  $1 \le l \le m$ . Suppose that  $s_1, \ldots, s_m > n/r$  and

$$\sum_{k=1}^{l} \left( s_k/n - 1/p_k \right) \le -1/r'.$$

Then there exists a function  $\sigma$  on  $(\mathbb{R}^n)^m$  such that  $\mathcal{L}^{r,\Psi^{(m)}}_{\vec{s}}[\sigma] < \infty$ , but

$$||T_{\sigma}||_{H^{p_1}\times\cdots\times H^{p_m}\to L^p}=\infty.$$

The necessity part of Theorem 1.1 is a consequence of the preceding two propositions along with a rearrangement argument.

1.2. **Sufficiency condition.** The sufficiency condition part in Theorem 1.1 is a consequence of the following four propositions combined with a rearrangement argument.

**Proposition 1.4.** Let  $1 < r \le 2$ ,  $r \le p_1, \ldots, p_m \le \infty$ , and  $1/p = 1/p_1 + \cdots + 1/p_m$ . Suppose that

$$(1.14) s_1, \dots, s_m > n/r.$$

If  $\sigma$  satisfies  $\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] < \infty$ , then (1.9) holds.

**Proposition 1.5.** Let  $1 < r \le 2$ ,  $1 \le l \le m$ ,  $0 < p_1, ..., p_l \le 1$ ,  $p_{l+1}, ..., p_m = \infty$ , and  $1/p = 1/p_1 + \cdots + 1/p_l$ . Suppose that

(1.15) 
$$s_{l+1}, \dots, s_m > n/r, \qquad \sum_{k \in J} (s_k/n - 1/p_k) > -1/r'$$

for every nonempty subset  $J \subset \{1, \ldots, l\}$ . If  $\sigma$  satisfies  $\mathcal{L}^{r, \Psi^{(m)}}_{\vec{s}}[\sigma] < \infty$ , then (1.9) holds.

**Proposition 1.6.** Let  $1 < r \le 2$ ,  $1 \le l < \rho \le m$ ,  $0 < p_1, \ldots, p_l \le 1$ ,  $r \le p_{l+1}, \ldots, p_{\rho} < \infty$ ,  $p_{\rho+1}, \ldots, p_m = \infty$ , and  $1/p = 1/p_1 + \cdots + 1/p_{\rho}$ . Suppose that (1.15) holds for every nonempty subset  $J \subset \{1, \ldots, l\}$ . If  $\sigma$  satisfies  $\mathcal{L}_{\vec{s}}^{r, \Psi^{(m)}}[\sigma] < \infty$ , then (1.9) holds.

**Proposition 1.7.** Let  $1 < r \le 2$  and  $1 \le l \le m$ . Suppose that  $\mathfrak{L}$  is a subset of  $\{1, \ldots, m\}$  with  $|\mathfrak{L}| = l$ , and

$$1 < p_i < r$$
 for  $i \in \mathfrak{L}$ 

and

$$0 < p_i \le 1$$
 or  $r \le p_i \le \infty$  for  $i \in \{1, \dots, m\} \setminus \mathfrak{L}$ .

Suppose that (1.8) holds for every nonempty subset J of  $\{1,\ldots,m\}$ . If the function  $\sigma$  satisfies  $\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] < \infty$ , then (1.9) holds.

The statements in the above propositions can be thought of as extensions of Theorems A and B from r=2 to  $1 < r \le 2$ . However, the ingredients of their proofs are significantly more involved than in the case r=2, in view of the lack of Plancherel's identity. The proofs we employ depend on the Littlewood-Paley theory for the Hardy space  $H^p$ , but this certainly does not work for  $H^\infty = L^\infty$  or BMO, and this is the reason the case  $p_i = \infty$  was excluded in Theorem A. It was addressed in the proof of Theorem B by applying a modified version of the Carleson measure estimate related to BMO functions, which is contained in [13]. We provide a new method to deal with this issue, using a generalization of Peetre's maximal function, saying  $\mathfrak{M}^t_{\sigma,2^j}f$ , introduced by Park [24]. As we have an  $L^\infty(\ell^2)$  characterization of BMO with this maximal function, stated in Lemma 2.2, we may still utilize the Littlewood-Paley theory to obtain  $H^{p_i}$  bounds for all  $0 < p_i \le \infty$ .

The proof of Proposition 1.4 is based on that of Theorem A for which the pointwise estimate in Lemma 2.4 below is essential. In Propositions 1.5 and 1.6 at least one index  $p_i$  satisfies  $0 < p_i \le 1$  and the  $H^{p_i}$  atomic decomposition is very useful. In this case we need

to employ an approximation argument for  $\sigma$  as we don't know that we can interchange infinite sums of atoms and the action of the operator as in

$$T_{\sigma}(f_1,\ldots,f_m) = \sum_{k_1=1}^{\infty} \cdots \sum_{k_m=1}^{\infty} \lambda_{1,k_1}, \cdots \lambda_{l,k_l} T_{\sigma}(a_{1,k_l},\ldots,a_{l,k_l},f_{l+1},\ldots,f_m)$$

for functions  $f_i \in H^{p_i}(\mathbb{R}^n)$  with atomic representation  $f_i = \sum_{k_i=1}^{\infty} \lambda_{i,k_i} a_{i,k_i}$ ,  $1 \leq i \leq l$ . This regularization of the multiplier was also used in [15] but here it is stated in Lemma 2.7. Afterwards, we apply the method of Grafakos and Kalton [12] and a pointwise estimate of the form

$$(1.16) \left| T_{\sigma} \left( a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m \right) (x) \right| \lesssim \mathcal{L}_{\mathbf{S}}^{r,\Psi^{(m)}} [\sigma] b_1(x) \cdots b_l(x) F_{l+1}(x) \cdots F_m(x)$$

where  $||b_i||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1$  and  $||F_i||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}$ . Since the above estimate separates the left-hand side to m functions of x, we may now apply Hölder's inequality with exponents  $1/p = 1/p_1 + \cdots + 1/p_m$ . The main idea in the proof of Proposition 1.7 is a multilinear extension of the complex interpolation method of Calderón [1] and Calderón and Torchinsky [2]. Specifically, we apply the interpolation to Propositions 1.4, 1.5, and 1.6 to obtain (1.9) in the entire range  $0 < p_1, \ldots, p_m \leq \infty$ .

**Remark.** The direction  $(1.9) \Rightarrow (1.8)$  is valid even for  $2 < r < \infty$ , in view of Propositions 1.2 and 1.3. Thus, under the assumption  $\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] < \infty$  conditions (1.8) are necessary for the boundedness of  $T_{\sigma}$  for all r in the range  $1 < r < \infty$ . However the sufficiency of (1.8) for the boundedness of  $T_{\sigma}$ , i.e., the direction (1.8)  $\Rightarrow$  (1.9) is missing in the case r > 2. It seems that our techniques are not applicable in this case. We hope to address this problem in the future but we welcome interested researchers to investigate this topic as well.

**Organization.** Section 2 contains some preliminary facts that are crucial in the proofs of the preceding propositions. The proofs of Propositions 1.2 - 1.7 are given in Sections 3 - 8. Some key lemmas that appear in the proofs of the propositions are contained in the last section.

**Notation.** We denote by  $\mathbb{N}$  and  $\mathbb{Z}$  the sets of natural numbers and integers, respectively. We use the symbol  $A \lesssim B$  to indicate that  $A \leq CB$  for some constant C > 0 independent of the variable quantities A and B, and  $A \approx B$  if  $A \lesssim B$  and  $B \lesssim A$  hold simultaneously. The set of all dyadic cubes in  $\mathbb{R}^n$  is denoted by  $\mathcal{D}$ , and for each  $j \in \mathbb{Z}$  we designate  $\mathcal{D}_j$  to be the subset of  $\mathcal{D}$  consisting of dyadic cubes with side length  $2^{-j}$ . For each  $Q \in \mathcal{D}$ ,  $\chi_Q$  denotes the characteristic function of Q. We also use the notation  $\vec{f} := (f_1, \ldots, f_m)$ ,  $\vec{v} := (v_1, \ldots, v_m)$ , and  $\langle x \rangle := (1 + 4\pi^2 |x|^2)^{1/2}$ .

## 2. Preliminaries

Let  $\phi$  be a Schwartz function on  $\mathbb{R}^n$  with  $\widehat{\phi}(0) = 1$ . For  $0 the Hardy space <math>H^p(\mathbb{R}^n)$  contains all tempered distributions f on  $\mathbb{R}^n$  which satisfy

$$||f||_{H^p(\mathbb{R}^n)} := \left| \left| \sup_{j \in \mathbb{Z}} |\phi_j * f| \right| \right|_{L^p(\mathbb{R}^n)} < \infty$$

where  $\phi_j := 2^{jn}\phi(2^j \cdot)$ . According to [6, 28], different choices of Schwartz function  $\phi$  with  $\widehat{\phi}(0) = 1$  provide equivalent Hardy space norms. In this paper we fix a Schwartz function

 $\psi$  on  $\mathbb{R}^n$  whose Fourier transform is supported in the annulus  $1/2 < |\xi| < 2$  and satisfies  $\sum_{j \in \mathbb{Z}} \widehat{\psi}(\xi/2^j) = 1$  for  $\xi \neq 0$ . Set  $\widehat{\psi}(\cdot/2^j) = \widehat{\psi}_j$ . Then we define a function  $\phi \in \mathcal{S}(\mathbb{R}^n)$  by

(2.1) 
$$\widehat{\phi}(\xi) := \begin{cases} \sum_{j \le 0} \widehat{\psi_j}(\xi), & \xi \ne 0 \\ 1, & \xi = 0, \end{cases}$$

and let  $\phi_j := 2^{jn}\phi(2^j \cdot)$  so that  $\widehat{\phi}_j = \widehat{\phi}(\cdot/2^j)$ . Note that  $H^p(\mathbb{R}^n) = L^p(\mathbb{R}^n)$  for all  $1 . A nice feature of the Hardy spaces <math>H^p$  for 0 is their atomic decomposition. More precisely, when <math>N is a positive integer greater or equal to [n/p-n]+1, every f in  $H^p(\mathbb{R}^n)$ ,  $0 , can be written as <math>\sum_{k=1}^{\infty} \lambda_k a_k$ , where  $\lambda_k$  are coefficients satisfying  $\left(\sum_{k=1}^{\infty} |\lambda_k|^p\right)^{1/p} \lesssim \|f\|_{H^p(\mathbb{R}^n)}$  and  $a_k$  are  $L^\infty$ -atoms for  $H^p$ ; this means that there exist cubes  $Q_k$  such that  $\operatorname{Supp}(a_k) \subset Q_k$ ,  $\|a_k\|_{L^\infty(\mathbb{R}^n)} \le |Q_k|^{-1/p}$ , and  $\int_{Q_k} x^{\alpha} a_k(x) dx = 0$  for all multi-indices  $\alpha$  with  $|\alpha| \le N$ .

The Hardy space  $H^p$  can be characterized in terms of Littlewood-Paley theory. For 0 we have

(2.2) 
$$||f||_{H^{p}(\mathbb{R}^{n})} \approx \left\| \left( \sum_{j \in \mathbb{Z}} \left| \psi_{j} * f \right|^{2} \right)^{1/2} \right\|_{L^{p}(\mathbb{R}^{n})}$$

where  $\psi_j$  is a Littlewood-Paley function defined as above. This property is also independent of the choice of functions  $\psi_j$  because of the Calderón reproducing formula and the Fefferman-Stein vector-valued maximal inequality [4] which states that

(2.3) 
$$\|\{\mathcal{M}_t f_j\}_{j \in \mathbb{Z}}\|_{L^p(\ell^q)} \lesssim \|\{f_j\}_{j \in \mathbb{Z}}\|_{L^p(\ell^q)}$$
 for  $t < p, q < \infty$ 

where  $\mathcal{M}f(x) := \sup_{Q:x \in Q} |Q|^{-1} \int_{Q} |f(y)| dy$  is the Hardy-Littlwood maximal functions and  $\mathcal{M}_t f(x) := \left(\mathcal{M}(|f|^t)\right)^{1/t}$  for  $0 < t < \infty$ . Note that (2.3) also holds for  $0 , <math>q = \infty$  or for  $p = q = \infty$ .

For  $j \in \mathbb{Z}$ , s > 0, and  $0 < t \le \infty$  we now define

$$\mathfrak{M}_{s,2^{j}}^{t}f(x) := 2^{jn/t} \left\| \frac{f(x-\cdot)}{(1+2^{j}|\cdot|)^{s}} \right\|_{L^{t}(\mathbb{R}^{n})},$$

which is a generalization of the Peetre's maximal function  $\mathfrak{M}_{s,2^j}f(x) := \mathfrak{M}_{s,2^j}^{\infty}f(x)$ . It is easy to verify that if  $0 < t < \infty$  and s > n/t, then

(2.4) 
$$\mathfrak{M}_{s,2^j}^t f(x) \lesssim \mathcal{M}_t f(x)$$
, uniformly in  $j \in \mathbb{Z}$ .

Moreover, for s > 0,  $0 < t \le r \le \infty$ , and  $j \in \mathbb{Z}$ , we have

$$\mathfrak{M}_{s,2^{j}}^{r}\mathfrak{M}_{s,2^{j}}^{t}f(x) \lesssim \mathfrak{M}_{s,2^{j}}^{t}f(x).$$

See [24] for more details.

Elementary considerations reveal that for s > 0 and  $Q \in \mathcal{D}_j$ 

$$\sup_{y \in Q} |f(y)| \lesssim \inf_{y \in Q} \mathfrak{M}_{s,2^j} f(y)$$

and then it follows from (2.5) that for  $0 < t < \infty$ 

(2.6) 
$$\sup_{y \in Q} \mathfrak{M}_{s,2^j}^t f(y) \lesssim \inf_{y \in Q} \mathfrak{M}_{s,2^j} \mathfrak{M}_{s,2^j}^t f(y) \lesssim \inf_{y \in Q} \mathfrak{M}_{s,2^j}^t f(y).$$

In addition, the following maximal inequality holds.

**Lemma 2.1** ([24]). Let  $0 < p, q, t \le \infty$  and  $s > n/\min(p, q, t)$ . Suppose that the Fourier transform of  $f_i$  is supported in a ball of radius  $A2^j$  for some A > 0.

(1) For  $0 and <math>0 < q \le \infty$  or for  $p = q = \infty$ , we have

$$\|\{\mathfrak{M}_{s,2^{j}}^{t}f_{j}\}_{j\in\mathbb{Z}}\|_{L^{p}(\ell^{q})} \lesssim \|\{f_{j}\}_{j\in\mathbb{Z}}\|_{L^{p}(\ell^{q})}.$$

(2) For  $p = \infty$ ,  $0 < q < \infty$ , and  $\mu \in \mathbb{Z}$ , we have

$$\sup_{P \in \mathcal{D}_{\mu}} \left( \frac{1}{|P|} \int_{P} \sum_{i=\mu}^{\infty} \left( \mathfrak{M}_{s,2^{j}}^{t} f_{j}(x) \right)^{q} dx \right)^{1/q} \lesssim \sup_{P \in \mathcal{D}_{\mu}} \left( \frac{1}{|P|} \int_{P} \sum_{i=\mu}^{\infty} |f_{j}(x)|^{q} dx \right)^{1/q}$$

where the constant in the inequality is independent of  $\mu$ .

Using Lemma 2.1 we can prove the following result.

**Lemma 2.2** ([24]). Let  $0 , <math>0 < t \le \infty$ ,  $0 < \gamma < 1$ , and  $s > n/\min(p, 2, t)$ . Then for any dyadic cubes  $Q \in \mathcal{D}$ , there exists a proper measurable subset  $S_Q$  of Q, depending on  $\gamma, s, t, f$ , such that  $|S_Q| > \gamma |Q|$  and

$$||f||_{X^p} \approx \left\| \left\{ \sum_{Q \in \mathcal{D}_i} \left( \inf_{y \in Q} \mathfrak{M}_{s,2^j}^t (\psi_j * f)(y) \right) \chi_{S_Q} \right\}_{j \in \mathbb{Z}} \right\|_{L^p(\ell^2)}$$

where  $X^p = H^p$  for  $0 and <math>X^{\infty} = BMO$ .

We observe that if  $S_Q$  is a measurable subset of  $Q \in \mathcal{D}$  with  $|S_Q| > \gamma |Q|$  for some  $0 < \gamma < 1$ , then we have

(2.7) 
$$\chi_Q(x) \lesssim_{\tau,\gamma} \mathcal{M}_{\tau}(\chi_{S_Q})(x),$$

which is due to the fact that for  $x \in Q$ 

$$(2.8) 1 < \frac{1}{\gamma^{1/\tau}} \frac{|S_Q|^{1/\tau}}{|Q|^{1/\tau}} = \frac{1}{\gamma^{1/\tau}} \left( \frac{1}{|Q|} \int_O \chi_{S_Q}(y) dy \right)^{1/\tau} \le \gamma^{-1/\tau} \mathcal{M}_\tau(\chi_{S_Q})(x).$$

Based on the  $L^{\infty}(\ell^2)$  characterization of BMO from Lemma 2.2, we have the following lemma, which will be essential in obtaining  $L^{\infty}$  bounds in the proof of our main theorem.

**Lemma 2.3.** Let  $0 < p, t < \infty, N \ge 3$ , and

$$s_1 > n/\min(p, t),$$
  $s_i > n/\min(2, t)$   $2 < i < N.$ 

Let  $\varphi_j, \vartheta_j \in \mathcal{S}(\mathbb{R}^n)$ ,  $j \in \mathbb{Z}$ , satisfy  $\operatorname{Supp}(\widehat{\varphi_j}) \subset \{\xi \in \mathbb{R}^n : |\xi| \leq C2^j\}$  and  $\operatorname{Supp}(\widehat{\vartheta_j}) \subset \{\xi \in \mathbb{R}^n : D^{-1}2^j \leq |\xi| \leq D2^j\}$  for some C, D > 1. Suppose that  $T^1$  and  $T^2$  are the bilinear operators and  $T^3$  is the N-linear operator, defined by

$$T^{1}(f_{1}, f_{2})(x) := \left[ \sum_{j \in \mathbb{Z}} \left( \mathfrak{M}_{s_{1}, 2^{j}}^{t} (\varphi_{j} * f_{1})(x) \right)^{2} \left( \mathfrak{M}_{s_{2}, 2^{j}}^{t} (\vartheta_{j} * f_{2})(x) \right)^{2} \right]^{1/2},$$

$$T^{2}(f_{1}, f_{2})(x) := \sum_{j \in \mathbb{Z}} \mathfrak{M}_{s_{1}, 2^{j}}^{t} (\vartheta_{j} * f_{1})(x) \mathfrak{M}_{s_{2}, 2^{j}}^{t} (\vartheta_{j} * f_{2})(x),$$

$$T^{3}(f_{1}, \dots, f_{N})(x) := \sum_{j \in \mathbb{Z}} \mathfrak{M}_{s_{1}, 2^{j}}^{t} (\varphi_{j} * f_{1})(x) \prod_{j=1}^{N} \mathfrak{M}_{s_{i}, 2^{j}}^{t} (\vartheta_{j} * f_{i})(x)$$

for  $f_1, \ldots, f_N \in S(\mathbb{R}^n)$  and  $x \in \mathbb{R}^n$ . Then we have

(2.9) 
$$||T^{1}(f_{1}, f_{2})||_{L^{p}(\mathbb{R}^{n})} \lesssim ||f_{1}||_{H^{p}(\mathbb{R}^{n})} ||f_{2}||_{BMO(\mathbb{R}^{n})}$$

(2.10) 
$$||T^{2}(f_{1}, f_{2})||_{L^{p}(\mathbb{R}^{n})} \lesssim ||f_{1}||_{H^{p}(\mathbb{R}^{n})} ||f_{2}||_{BMO(\mathbb{R}^{n})}$$

(2.11) 
$$||T^{3}(f_{1},...,f_{N})||_{L^{p}(\mathbb{R}^{n})} \lesssim ||f_{1}||_{H^{p}(\mathbb{R}^{n})} \prod_{i=2}^{N} ||f_{i}||_{BMO(\mathbb{R}^{n})}.$$

*Proof.* We will only be concerned with (2.9) and (2.11) as the proof of (2.10) is very similar to that of (2.11) with N=3.

Since dyadic cubes with the same side length are pairwise disjoint, the left-hand side of (2.9) can be written as

$$\left\| \left( \sum_{j \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_j} \left( \mathfrak{M}^t_{s_1, 2^j} (\varphi_j * f_1) \right)^2 \left( \mathfrak{M}^t_{s_2, 2^j} (\vartheta_j * f_2) \right)^2 \chi_Q \right)^{1/2} \right\|_{L^p(\mathbb{R}^n)}$$

and the estimate (2.6) implies that the preceding expression is dominated by a constant multiple of

$$(2.12) \quad \left\| \left( \sum_{j \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_j} \left( \inf_{y \in Q} \mathfrak{M}^t_{s_1, 2^j} (\varphi_j * f_1)(y) \right)^2 \left( \inf_{y \in Q} \mathfrak{M}^t_{s_2, 2^j} (\vartheta_j * f_2)(y) \right)^2 \chi_Q \right)^{1/2} \right\|_{L^p(\mathbb{R}^n)}.$$

According to Lemma 2.2, for each  $Q \in \mathcal{D}$  we can choose a proper measurable subset  $S_Q$  of Q such that  $|S_Q| > \frac{1}{2}|Q|$  and

Here, we may use  $\vartheta_j$ , instead of  $\psi_j$ , because of the Calderón reproducing formula and (2.5). Now, using (2.7) with  $\tau < \min(p, 2)$  and the vector-valued maximal inequality (2.3) of  $\mathcal{M}_{\tau}$  with the index set  $\{Q\}_{Q \in \mathcal{D}}$ ,  $\chi_Q$  can be replaced by  $\chi_{S_Q}$  in (2.12) and then Hölder's inequality yields that (2.12) is less than a constant times

$$\left\| \sup_{j \in \mathbb{Z}} \mathfrak{M}_{s_1, 2^j}^t (\varphi_j * f_1) \right\|_{L^p(\mathbb{R}^n)} \left\| \left\{ \sum_{Q \in \mathcal{D}_j} \left( \inf_{y \in Q} \mathfrak{M}_{s_2, 2^j}^t (\vartheta_j * f_2)(y) \right) \chi_{S_Q} \right\}_{j \in \mathbb{Z}} \right\|_{L^{\infty}(\ell^2)}.$$

The second term is definitely comparable to  $||f_2||_{BMO}$  due to (2.13) and the first one can be estimated by

$$\left\| \sup_{j \in \mathbb{Z}} \left| \varphi_j * f_1 \right| \right\|_{L^p(\mathbb{R}^n)} \approx \|f_1\|_{H^p(\mathbb{R}^n)}$$

in view of Lemma 2.1. This proves (2.9).

Similarly, for each  $Q \in \mathcal{D}$  we choose proper measurable subsets  $S_Q^2$  and  $S_Q^3$  of Q such that  $|S_Q^2|, |S_Q^3| > \frac{3}{4}|Q|$  and

$$||f_k||_{BMO} \approx \left\| \left\{ \sum_{Q \in \mathcal{D}_j} \left( \inf_{y \in Q} \mathfrak{M}^t_{s_k, 2^j} (\vartheta_j * f_k)(y) \right) \chi_{S_Q^k} \right\}_{j \in \mathbb{Z}} \right\|_{L^{\infty}(\ell^2)}, \quad k = 2, 3.$$

We note that  $|S_Q^2 \cap S_Q^3| > \frac{1}{2}|Q|$  and thus (2.7) implies

$$\chi_Q(x) \lesssim_{\tau} \mathcal{M}_{\tau}(\chi_{S_Q^2 \cap S_Q^3})(x), \quad \text{for all } 0 < \tau < \infty.$$

Choose  $\tau < \min(1, p)$ . Then we can prove that the left-hand side of (2.11) is smaller than a constant times

$$\begin{split} \left\| \sum_{j \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_{j}} \left( \inf_{y \in Q} \mathfrak{M}_{s_{1},2^{j}}^{t} (\varphi_{j} * f_{1})(y) \right) \prod_{k=2}^{N} \left( \inf_{y \in Q} \mathfrak{M}_{s_{k},2^{j}}^{t} (\vartheta_{j} * f_{k})(y) \right) \chi_{S_{Q}^{2}} \chi_{S_{Q}^{3}} \right\|_{L^{p}(\mathbb{R}^{n})} \\ \leq \left\| \sup_{j \in \mathbb{Z}} \mathfrak{M}_{s_{1},2^{j}}^{t} (\varphi_{j} * f_{1}) \right\|_{L^{p}(\mathbb{R}^{n})} \prod_{k=2}^{3} \left\| \left\{ \sum_{Q \in \mathcal{D}_{j}} \left( \inf_{y \in Q} \mathfrak{M}_{s_{k},2^{j}}^{t} (\vartheta_{j} * f_{k})(y) \right) \chi_{S_{Q}^{k}} \right\}_{j \in \mathbb{Z}} \right\|_{L^{\infty}(\ell^{2})} \\ \times \prod_{k=4}^{N} \left\| \left\{ \mathfrak{M}_{s_{k},2^{j}}^{t} (\vartheta_{j} * f_{k}) \right\}_{j \in \mathbb{Z}} \right\|_{L^{\infty}(\ell^{\infty})} \\ \lesssim \|f_{1}\|_{H^{p_{1}}(\mathbb{R}^{n})} \prod_{k=2}^{N} \|f_{k}\|_{BMO} \end{split}$$

as desired. Here, we used the fact that for  $4 \le k \le N$ ,

$$\left\|\left\{\mathfrak{M}^t_{s_k,2^j}\big(\vartheta_j*f_k\big)\right\}_{j\in\mathbb{Z}}\right\|_{L^\infty(\ell^\infty)}\lesssim \left\|\left\{\vartheta_j*f_k\right\}_{j\in\mathbb{Z}}\right\|_{L^\infty(\ell^\infty)}\approx \|f_k\|_{\dot{F}^{0,2}_\infty}\lesssim \|f_k\|_{\dot{F}^{0,2}_\infty}\approx \|f_k\|_{BMO}$$

where  $\dot{F}_p^{0,q}$  is the homogeneous Triebel-Lizorkin space, and Lemma 2.1, the embedding  $\dot{F}_{\infty}^{0,2} \hookrightarrow \dot{F}_{\infty}^{0,\infty}$ , and the characterization  $BMO = \dot{F}_{\infty}^{0,2}$  are applied. We refer to [24] for more details.

The following lemma is the main tool used to derive pointwise estimates like (1.16). In fact, similar results can be found in [13, 14, 15, 17, 23] with the maximal function  $\mathcal{M}_t$ , but here we replace  $\mathcal{M}_t$  by  $\mathfrak{M}^t_{s_t,2^j}$  in order to apply the arguments in Lemmas 2.2 and 2.3.

**Lemma 2.4.** Let  $1 < t \le 2$  and  $s_1, \ldots, s_m > n/t$ . Suppose that  $\sigma$  is a bounded function with a compact support in  $(\mathbb{R}^n)^m$ . Then we have

$$\left|T_{\sigma}\vec{\boldsymbol{f}}(x)\right| \lesssim \left\|\sigma(2^{j}\cdot)\right\|_{L_{\vec{\boldsymbol{s}}}^{t}((\mathbb{R}^{n})^{m})} \prod_{k=1}^{m} \mathfrak{M}_{s_{k},2^{j}}^{t} f_{k}(x), \quad uniformly \ in \ j \in \mathbb{Z}.$$

*Proof.* Using the Hölder inequality, we obtain

$$\begin{aligned} \left| T_{\sigma} \vec{f}(x) \right| &= \left| \int_{(\mathbb{R}^n)^m} \sigma^{\vee}(\vec{v}) \prod_{k=1}^m f_k(x - v_k) d\vec{v} \right| \\ &\leq 2^{-jmn/t} \left[ \int_{(\mathbb{R}^n)^m} \left( \prod_{k=1}^m \langle 2^j v_k \rangle^{s_k t'} \right) |\sigma^{\vee}(\vec{v})|^{t'} d\vec{v} \right]^{1/t'} \prod_{k=1}^m \mathfrak{M}_{s_k, 2^j}^t f_k(x) \end{aligned}$$

where we applied the simple inequality that

$$||f(x-\cdot)\langle 2^j\cdot\rangle^{-s_k}||_{L^t(\mathbb{R}^n)} \lesssim 2^{-jn/t}\mathfrak{M}^t_{s_k,2^j}f(x)$$

Then the Hausdorff Young inequality with  $1 < t \le 2$  yields that

$$\left[\int_{(\mathbb{R}^n)^m} \left(\prod_{k=1}^m \langle 2^j v_k \rangle^{s_k t'}\right) |\sigma^{\vee}(\vec{v})|^{t'} d\vec{v}\right]^{1/t'} \lesssim 2^{jmn/t} \left\|\sigma(2^j \cdot)\right\|_{L^t_{\vec{s}}((\mathbb{R}^n)^m)}$$

and this completes the proof.

The next lemma is a multi-parameter inequality of Kato-Ponce type.

**Lemma 2.5.** Let  $1 < t < \infty$  and  $s_1, \ldots, s_m \ge 0$ . Suppose that g is a function in  $L^t_{\vec{s}}((\mathbb{R}^n)^m)$  and  $\Xi \in \mathcal{S}((\mathbb{R}^n)^m)$ . Then we have

The above lemma is clear when  $s_1,\ldots,s_m$  are even integers as the derivatives of  $\Xi$  are bounded functions, using the embedding  $L^t_{\vec{s}^{(1)}}\hookrightarrow L^t_{\vec{s}^{(2)}}$  for  $\vec{s}^{(2)}:=(s_1^{(2)},\ldots,s_m^{(2)})\leq \vec{s}^{(1)}:=(s_1^{(1)},\ldots,s_m^{(1)})$ , which means  $s_k^{(2)}\leq s_k^{(1)}$  for each  $1\leq k\leq m$ . To be specific,

$$\|\Xi \cdot g\|_{L^{t}_{\overline{s}}((\mathbb{R}^{n})^{m})} \lesssim \Big(\max_{1 \leq j \leq m} \max_{1 \leq l_{j} \leq s_{j}/2} \|(I - \Delta_{1})^{l_{1}} \cdots (I - \Delta_{m})^{l_{m}} \Xi\|_{L^{\infty}((\mathbb{R}^{n})^{m})} \Big) \|g\|_{L^{t}_{\overline{s}}((\mathbb{R}^{n})^{m})}$$

for even integers  $s_1, \ldots, s_m$ . Now suppose, by induction, that (2.14) holds for all even integers  $s_1, \ldots, s_l$  and all nonnegative numbers  $s_{l+1}, \ldots, s_m$ . Let  $r_1, \ldots, r_{l-1}$  be even integers and  $r_l, \ldots, r_m$  be nonnegative numbers. Choose an integer  $N_l$  with  $2N_l \leq r_l < 2(N_l + 1)$ . Then we obtain

$$\left\|\Xi \cdot g\right\|_{L^t_{(r_1,\ldots,r_m)}((\mathbb{R}^n)^m)} \lesssim_{\Xi} \|g\|_{L^t_{(r_1,\ldots,r_m)}((\mathbb{R}^n)^m)}$$

by interpolating the two estimates (2.14) with

$$(s_1,\ldots,s_m)=(r_1,\ldots,r_{l-1},2N_l,r_{l+1},\ldots,r_m)$$

and

$$(s_1,\ldots,s_m)=(r_1,\ldots,r_{l-1},2(N_l+1),r_{l+1},\ldots,r_m),$$

which follow from the induction hypothesis. By repeating this process (m-1) times, we obtain (2.14) for any  $s_1, \ldots, s_m \geq 0$ . We refer to [9, Section 5] for a similar interpolation technique.

We now discuss a regularization of multipliers.

**Lemma 2.6.** Let  $1 < r \le 2$  and  $\sigma$  satisfy  $\mathcal{L}_{\overline{s}}^{r,\Psi^{(m)}}[\sigma] < \infty$  for  $s_k > n/r$ ,  $1 \le k \le m$ . Then there exists a family of Schwartz functions  $\{\sigma^{\epsilon}\}_{0 < \epsilon < 1/2}$  such that  $\widehat{\sigma^{\epsilon}}$  has a compact support in  $(\mathbb{R}^n)^m$ ,

(2.15) 
$$\sup_{0 < \epsilon < 1/2} \mathcal{L}_{\vec{s}}^{r, \Psi^{(m)}}[\sigma^{\epsilon}] \lesssim \mathcal{L}_{\vec{s}}^{r, \Psi^{(m)}}[\sigma],$$

and

(2.16) 
$$\lim_{\epsilon \to 0} \|T_{\sigma} \vec{f} - T_{\sigma^{\epsilon}} \vec{f}\|_{L^{2}(\mathbb{R}^{n})} = 0$$

for Schwartz functions  $f_1, \ldots, f_m$  on  $\mathbb{R}^n$ .

The above lemma can be verified with a very similar argument as described in [15, Theorem 3.1], by using Lemma 2.5 and just replacing  $L^2_{\vec{s}}$  by  $L^r_{\vec{s}}$ . Therefore, the proof will not be pursued here. As shown in [15], the  $L^2$  convergence in (2.16) implies the existence of a sequence of positive numbers  $\{\epsilon_j\}_{j\in\mathbb{N}}$ , converging to 0 as  $j\to\infty$ , such that

$$\lim_{j \to \infty} T_{\sigma^{\epsilon_j}} \vec{f}(x) = T_{\sigma} \vec{f}(x) \quad \text{a.e. } x \in \mathbb{R}^n.$$

Then Fatou's lemma and (2.15) yield that

$$\begin{aligned} \|T_{\sigma}\vec{f}\|_{L^{p}(\mathbb{R}^{n})} &\leq \liminf_{j \to \infty} \|T_{\sigma^{\epsilon_{j}}}\vec{f}\|_{L^{p}(\mathbb{R}^{n})} \lesssim \sup_{0 < \epsilon < 1/2} \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma^{\epsilon}] \prod_{i=1}^{m} \|f_{i}\|_{H^{p_{i}}(\mathbb{R}^{n})} \\ &\lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^{m} \|f_{i}\|_{H^{p_{i}}(\mathbb{R}^{n})}. \end{aligned}$$

In view of this reduction, in the proof of the main theorem we may actually assume that  $\sigma$  is a Schwartz function such that  $\widehat{\sigma}$  has a compact support. Our estimates will depend only on  $\mathcal{L}^{r,\Psi^{(m)}}_{\overline{s}}[\sigma]$  and not on other quantities related to  $\sigma$ .

With the regularization in Lemma 2.6, we may apply the following lemma in the case that for at least one i with  $1 \le i \le m$  we have  $p_i \le 1$ , so that the  $H^{p_i}$ -atomic decomposition is applied.

**Lemma 2.7** ([14]). Let  $1 \leq l \leq m$ ,  $0 < p_1, \ldots, p_l \leq 1$ , and  $1 < p_{l+1}, \ldots, p_m \leq \infty$ . Let  $\sigma$  be a Schwartz function on  $(\mathbb{R}^n)^m$  whose Fourier transform has compact support (as  $\sigma^{\epsilon}$  does in Lemma 2.6). Suppose that  $f_i \in H^{p_i}(\mathbb{R}^n)$ ,  $1 \leq i \leq l$ , have atomic representations  $f_i = \sum_{k_i=1}^{\infty} \lambda_{i,k_i} a_{i,k_i}$ , where  $a_{i,k_i}$  are  $L^{\infty}$ -atoms for  $H^{p_i}$  and  $\left(\sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i}\right)^{1/p_i} \leq \|f_i\|_{H^{p_i}(\mathbb{R}^n)}$ . Suppose  $f_i \in \mathcal{S}(\mathbb{R}^n)$  for  $l+1 \leq i \leq m$ . Then

$$T_{\sigma}\vec{\boldsymbol{f}}(x) = \sum_{k_1=1}^{\infty} \cdots \sum_{k_l=1}^{\infty} \lambda_{1,k_1} \cdots \lambda_{l,k_l} T_{\sigma}(a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m)(x)$$

for almost all  $x \in \mathbb{R}^n$ .

In order to establish an inequality such as (1.16), the vanishing moment condition of  $a_{i,k_i}$  will be exploited in the following way.

**Lemma 2.8.** Suppose that  $a \in L_0^{\infty}(\mathbb{R}^n)$  is a bounded function with a compact support and has vanishing moments in the sense that there is a  $M \in \mathbb{N} \cup \{0\}$  such that

(2.17) 
$$\int_{\mathbb{R}^n} x^{\alpha} a(x) dx = 0, \quad |\alpha| \le M.$$

Then for any  $K \in S(\mathbb{R}^n)$  and  $c_0 \in \mathbb{R}^n$ , we have

$$(2.18) \qquad |K*a(x)| \lesssim \int_0^1 \int_{\mathbb{R}^n} |y - c_0|^{M+1} \sum_{|\alpha| = M+1} |\partial^{\alpha} K(x - c_0 - t(y - c_0))| |a(y)| dy dt.$$

*Proof.* We recall Taylor's formula saying that for any  $x, y \in \mathbb{R}^n$  and  $M \in \mathbb{N} \cup \{0\}$  we have

$$f(x+y) = \sum_{|\alpha| \le M} \frac{\partial^{\alpha} f(x)}{\alpha!} y^{\alpha} + (M+1) \sum_{|\alpha| = M+1} \frac{1}{\alpha!} \Big( \int_0^1 (1-t)^M \partial^{\alpha} f(x+ty) dt \Big) y^{\alpha}.$$

Then (2.17) yields that the left-hand side of (2.18) is dominated by a constant times

$$\sum_{|\alpha|=M+1} \frac{1}{\alpha!} \int_0^1 (1-t)^M \int_{\mathbb{R}^n} |\partial^{\alpha} K(x-c_0-t(y-c_0))| |y-c_0|^{M+1} |a(y)| dy dt$$

and this is clearly less than the right-hand side of (2.18).

The argument in Lemma 2.8 will help us estimate the  $L^{r'}$  norm of the product of  $\langle x_1 \rangle^{s_1} \cdots \langle x_m \rangle^{s_m}$  and derivatives of  $(\sigma(2^j)\widehat{\Psi^{(m)}})^{\vee}$  to obtain the quantity  $\mathcal{L}^{r,\Psi^{(m)}}_{\vec{s}}[\sigma]$ , as the Hausdorff-Young inequality  $\|F^{\vee}\|_{L^{r'}((\mathbb{R}^n)^m)} \lesssim \|F\|_{L^r((\mathbb{R}^n)^m)}$  is applicable for  $1 < r \le 2$ . The following lemma will play a significant role in this.

**Lemma 2.9** ([14, 23]). Let  $1 \le p \le q \le \infty$ , and  $s_k \ge 0$  for  $1 \le k \le m$ . Let  $\sigma$  be a function defined on  $(\mathbb{R}^n)^m$  and  $K = \sigma^{\vee}$  be the inverse Fourier transform of  $\sigma$ . Suppose that  $\sigma$  is supported in a ball of a constant radius. Then for  $1 \le l \le m$  and any multi-index  $\vec{\alpha}$  in  $(\mathbb{Z}^n)^l$  there exists a constant  $C_{\vec{\alpha}}$  such that

$$\begin{aligned} & \|\langle \cdot_1 \rangle^{s_1} \cdots \langle \cdot_l \rangle^{s_l} \partial^{\vec{\alpha}} K(\cdot_1, \dots, \cdot_l, y_{l+1}, \dots, y_m) \|_{L^q((\mathbb{R}^n)^l)} \\ & \leq C_{\vec{\alpha}} \|\langle \cdot_1 \rangle^{s_1} \cdots \langle \cdot_l \rangle^{s_l} K(\cdot_1, \dots, \cdot_l, y_{l+1}, \dots, y_m) \|_{L^p((\mathbb{R}^n)^l)} \end{aligned}$$

where  $\partial^{\vec{\alpha}}$  denotes  $\vec{\alpha}$  derivatives in the first l variables.

We end this section by reviewing the technique of Grafakos and Kalton [12], which will be very useful in estimating the  $L^p$  norm of the sum of functions having a compact support for 0 .

**Lemma 2.10.** [12, Lemma 2.1] Let  $0 and <math>\{f_Q\}_{Q \in \mathcal{J}}$  be a family of nonnegative integrable functions with  $\operatorname{Supp}(f_Q) \subset Q$  for all  $Q \in \mathcal{J}$ , where  $\mathcal{J}$  is a finite or countable family of cubes in  $\mathbb{R}^n$ . Then we have

$$\left\| \sum_{Q \in \mathcal{J}} f_Q \right\|_{L^p(\mathbb{R}^n)} \lesssim \left\| \sum_{Q \in \mathcal{J}} \left( \frac{1}{|Q|} \int_Q f_Q(y) dy \right) \chi_Q \right\|_{L^p(\mathbb{R}^n)},$$

where the constant in the inequality depends only on p.

## 3. Proof of Proposition 1.2

Let  $\theta$  and  $\widetilde{\theta}$  denote Schwartz functions on  $\mathbb{R}^n$  having the properties

$$\operatorname{Supp}(\widehat{\theta}) \subset \left\{ \xi \in \mathbb{R}^n : \frac{1}{2000\sqrt{m}} \le |\xi| \le \frac{1}{1000\sqrt{m}} \right\}$$
$$\operatorname{Supp}(\widehat{\widetilde{\theta}}) \subset \left\{ \xi \in \mathbb{R}^n : |\xi| \le \frac{1}{100\sqrt{m}} \right\}$$

and  $\widehat{\widetilde{\theta}}(\xi) = 1$  for  $|\xi| \leq \frac{1}{1000\sqrt{m}}$ . Then it is clear that

(3.1) 
$$(\theta(\epsilon \cdot)) * \widetilde{\theta}(x) = \theta(\epsilon x) for any 0 < \epsilon \le 1.$$

Let  $e_1 := (1,0,\ldots,0) \in \mathbb{Z}^n$ . Choose  $2/r < \delta \le 2$  and let N > 0 be a sufficiently large number to be chosen later. Recall that our fixed Schwartz function  $\phi_j$  satisfies  $\operatorname{Supp}(\widehat{\phi_j}) \subset \{\xi \in \mathbb{R}^n : |\xi| \le 2^{j+1}\}$  and  $\widehat{\phi_j}(\xi) = 1$  for  $|\xi| \le 2^j$ . Let  $\Phi$  be a Schwartz function on  $\mathbb{R}^n$  whose Fourier transform is equal to 1 on the ball  $\{\xi \in \mathbb{R}^n : |\xi| \le 1\}$  and is supported in a larger ball. Let N be a sufficiently large positive integer and  $\Phi_N := N^n \Phi(N \cdot)$ .

We define

$$\mathcal{H}_{(n,\delta)}^{(N)}(x) := \mathcal{H}_{(n,\delta)}(x)\widehat{\Phi_N}(x), \qquad x \in \mathbb{R}^n$$

and

$$\sigma^{(N)}(\vec{\boldsymbol{\xi}}) := \widehat{\mathcal{H}_{(n,\delta)}^{(N)}}(\xi_1 - e_1)\widehat{\widetilde{\theta}}(\xi_1 - e_1)\widehat{\widetilde{\theta}}(\xi_2) \cdots \widehat{\widetilde{\theta}}(\xi_m), \qquad \vec{\boldsymbol{\xi}} \in (\mathbb{R}^n)^m,$$

where  $\mathcal{H}_{(n,\delta)}$  is defined in (1.10).

It follows from the support of  $\widehat{\widetilde{\theta}}$  that  $\sigma^{(N)}$  is supported in  $\{\vec{\xi} \in (\mathbb{R}^n)^m : \frac{99}{100} \leq |\vec{\xi}| \leq \frac{101}{100}\}$ , which implies that  $\sigma^{(N)}(2^l\vec{\xi})\widehat{\Psi^{(m)}}(\vec{\xi})$  vanishes unless  $-1 \leq l \leq 1$ . Moreover, in view of Lemma 2.5 we have

$$\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma^{(N)}] \lesssim \max_{-1 \leq l \leq 1} \|\sigma^{(N)}(2^{l} \cdot_{1}, \dots, 2^{l} \cdot_{m})\|_{L_{\vec{s}}^{r}((\mathbb{R}^{n})^{m})},$$

which can be estimated, via scaling, by a constant times

where we used Lemma 2.5 in the last inequality. We observe that

$$(I-\Delta)^{s_1/2}\widehat{\mathcal{H}_{(n,\delta)}^{(N)}}(\xi)=\widehat{\mathcal{H}_{(n-s_1,\delta)}^{(N)}}(\xi)=\Phi_N*\widehat{\mathcal{H}_{(n-s_1,\delta)}}(\xi)$$

and  $\widehat{\mathcal{H}_{(n-s_1),\delta}} \in L^r(\mathbb{R}^n)$ , using (1.13) with  $\delta > 2/r$  and  $s_1 = n/r$ . Since  $\{\Phi_N\}_{N \in \mathbb{N}}$  is an approximate identity, we have

$$\lim_{N \to \infty} \left\| \Phi_N * \widehat{\mathcal{H}_{(n-s_1,\delta)}} - \widehat{\mathcal{H}_{(n-s_1,\delta)}} \right\|_{L^r(\mathbb{R}^n)} = 0,$$

which proves

$$(3.3) \qquad \limsup_{N \to \infty} \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma^{(N)}] \lesssim \lim_{N \to \infty} \left\| \Phi_N * \widehat{\mathcal{H}_{(n-s_1,\delta)}} \right\|_{L^r(\mathbb{R}^n)} \leq \left\| \widehat{\mathcal{H}_{(n-s_1,\delta)}} \right\|_{L^r(\mathbb{R}^n)} < \infty.$$

On the other hand, for  $0 < \epsilon < 1/100$ , let

$$f_1^{(\epsilon)}(x) := \epsilon^{n/p_1} \theta(\epsilon x) e^{2\pi i \langle x, e_1 \rangle}, \qquad f_j^{(\epsilon)}(x) := \epsilon^{n/p_j} \theta(\epsilon x), \ 2 \le j \le m.$$

Then it is clear, from the Littlewood-Paley theory for Hardy spaces and scaling arguments that for each  $1 \le j \le m$ 

Moreover, we observe that

$$\left| T_{\sigma^{(N)}} \left( f_1^{(\epsilon)}, \dots, f_m^{(\epsilon)} \right) (x) \right| = \epsilon^{n/p} \left| \mathcal{H}_{(n,\delta)}^{(N)} * \left( \theta(\epsilon \cdot) \right) (x) \right| \left| \theta(\epsilon x) \right|^{m-1}$$

and this, together with scaling, yields that

$$\left\| T_{\sigma^{(N)}}\left(f_1^{(\epsilon)}, \dots, f_m^{(\epsilon)}\right) \right\|_{L^p(\mathbb{R}^n)} = \left\| \left| \theta \right|^{m-1} \left( \mathcal{H}_{(n,\delta)}^{(N)} * \left( \theta(\epsilon \cdot) \right) \right) (\cdot / \epsilon) \right\|_{L^p(\mathbb{R}^n)}.$$

Applying (3.4) and Fatou's lemma, we obtain that

$$||T_{\sigma^{(N)}}||_{H^{p_1} \times \dots \times H^{p_m} \to L^p} \gtrsim \liminf_{\epsilon \to 0} ||T_{\sigma^{(N)}}(f_1^{(\epsilon)}, \dots, f_m^{(\epsilon)})||_{L^p(\mathbb{R}^n)}$$

$$\geq |||\theta|^{m-1}| \liminf_{\epsilon \to 0} \int_{\mathbb{R}^n} \theta(x - \epsilon y) \mathcal{H}_{(n,\delta)}^{(N)}(y) dy |||_{L^p(\mathbb{R}^n)}.$$

Since

$$\left|\theta(x-\epsilon y)\mathcal{H}^{(N)}_{(n,\delta)}(y)\right| \lesssim \mathcal{H}^{(N)}_{(n,\delta)}(y)$$
 uniformly in  $\epsilon > 0, x \in \mathbb{R}^n$ 

and

$$\|\mathcal{H}_{(n,\delta)}^{(N)}\|_{L^1(\mathbb{R}^n)} \le \|\widehat{\Phi_N}\|_{L^1(\mathbb{R}^n)} \lesssim N^n < \infty,$$

the Lebesgue dominated convergence theorem yields

$$(3.5) = \left\| |\theta|^m \right\|_{L^p(\mathbb{R}^n)} \int_{\mathbb{R}^n} \mathcal{H}_{(n,\delta)}^{(N)}(y) dy \approx \int_{\mathbb{R}^n} \mathcal{H}_{(n,\delta)}(y) \widehat{\Phi_N}(y) dy.$$

Taking  $\liminf_{N\to\infty}$ , we finally obtain that

$$\liminf_{N \to \infty} \|T_{\sigma^{(N)}}\|_{H^{p_1} \times \dots \times H^{p_m} \to L^p} \gtrsim \|\mathcal{H}_{(n,\delta)}\|_{L^1(\mathbb{R}^n)} = \infty$$

where we applied the monotone convergence theorem and the fact that  $\mathcal{H}_{(n,\delta)} \notin L^1(\mathbb{R}^n)$  for  $\delta \leq 2$  because of (1.12).

This fact combined with (3.3) completes the proof.

## 4. Proof of Proposition 1.3

We first consider the case  $1 \leq l < m$ . Let  $\mu_1 := (m^{-1/2}, 0, \dots, 0) \in \mathbb{R}^n$ . The condition

$$\sum_{k=1}^{l} \left( s_k/n - 1/p_k \right) \le -1/r'$$

is equivalent to

$$(4.1) s_1 + \dots + s_l + n/r' \le n/p_1 + \dots + n/p_l = n/p - (n/p_{l+1} + \dots + n/p_m).$$

On the other hand, it follows from the condition  $s_i > n/r$ ,  $1 \le j \le m$ , that

$$s_1 + \dots + s_l + n/r' > ln/r + n/r',$$

which further implies, combined with (4.1), that

$$2l/r + 2/r' < 2/p - (2/p_{l+1} + \dots + 2/p_m).$$

Now we choose  $\tau, \tau_{l+1}, \dots, \tau_m > 0$  such that

$$\tau_{l+1} > 2/p_{l+1}, \dots, \tau_m > 2/p_m$$

and

$$(4.2) 2/r < \tau < 2l/r + 2/r' < 2/p - (\tau_{l+1} + \dots + \tau_m) < 2/p - (2/p_{l+1} + \dots + 2/p_m).$$

Let  $\varphi, \widetilde{\varphi} \in S(\mathbb{R}^n)$  be radial functions having the properties that  $\varphi \geq 0$ ,  $\varphi(0) \neq 0$ ,  $\operatorname{Supp}(\widehat{\varphi}) \subset \{\xi \in \mathbb{R}^n : |\xi| \leq \frac{1}{200lm}\}$ ,  $\operatorname{Supp}(\widehat{\widetilde{\varphi}}) \subset \{\xi \in \mathbb{R}^n : |\xi| \leq \frac{1}{100m}\}$ , and  $\widehat{\widetilde{\varphi}}(\xi) = 1$  for  $|\xi| \leq \frac{1}{200m}$ . In what follows, we denote  $\mathcal{H}_{(s_1 + \dots + s_l + n/r', \tau)}$  by  $\mathcal{H}$  for notational convenience. We define

$$K^{(l)}(x) := \mathcal{H} * \varphi(x), \quad x \in \mathbb{R}^n,$$

and

$$M^{(l)}(\xi_1, \dots, \xi_l) := (K^{(l)})^{\vee} \left(\frac{1}{l} \sum_{k=1}^{l} (\xi_k - \mu_1)\right) \prod_{j=2}^{l} \varphi^{\vee} \left(\frac{1}{l} \sum_{k=1}^{l} (\xi_k - \xi_j)\right)$$

where  $M^{(l)}$  is defined on  $(\mathbb{R}^n)^l$ . Then the multiplier  $\sigma$  on  $(\mathbb{R}^n)^m$  is defined by

$$\sigma(\xi_1,\ldots,\xi_m):=M^{(l)}(\xi_1,\ldots,\xi_l)\widetilde{\varphi}^{\vee}(\xi_{l+1}-\mu_1)\cdots\widetilde{\varphi}^{\vee}(\xi_m-\mu_1).$$

To investigate the support of  $\sigma$  we first look at the support of  $M^{(l)}$ . From the support of  $\varphi^{\vee}$ , we have

$$\left|\xi_1+\cdots+\xi_l-l\mu_1\right|\leq \frac{1}{200m},$$

and for each  $2 \le j \le l$ 

$$|\xi_1 + \dots + \xi_l - l\xi_j| \le \frac{1}{200m}.$$

By adding up all of them, we obtain

$$|\xi_1 - \mu_1| \le \frac{1}{200m}$$

and the sum of (4.3) and (4.4) yields that for each  $2 \le j \le l$ 

$$\left| \mu_1 + \xi_2 + \dots + \xi_l - l\xi_j \right| \le \frac{1}{100m}.$$

Let us call the above estimate  $\mathcal{E}(j)$ . Then for  $2 \leq j \leq l$ , it follows from

$$\mathcal{E}(j) + \sum_{k=2}^{l} \mathcal{E}(k)$$

that

$$\left|\xi_j - \mu_1\right| \le \frac{1}{100m},$$

which proves, together with (4.4), that

(4.5) 
$$\operatorname{Supp}(M^{(l)}) \subset \left\{ (\xi_1, \dots, \xi_l) \in (\mathbb{R}^n)^l : |\xi_j - \mu_1| \le \frac{1}{100m}, \ 1 \le j \le l \right\}.$$

Since  $\widehat{\widetilde{\varphi}}$  is also supported in  $\{\xi \in \mathbb{R}^n : |\xi| \leq \frac{1}{100m}\}$ , it is clear that

Supp
$$(\sigma)$$
  $\subset \left\{ (\xi_1, \dots, \xi_m) \in (\mathbb{R}^n)^m : |\xi_j - \mu_1| \le \frac{1}{100m}, \ 1 \le j \le m \right\}$   
 $\subset \left\{ \vec{\xi} := (\xi_1, \dots, \xi_m) \in (\mathbb{R}^n)^m : \frac{99}{100} \le |\vec{\xi}| \le \frac{101}{100} \right\},$ 

which shows that  $\sigma(2^l\vec{\xi})\widehat{\Psi^{(m)}}(\vec{\xi})$  vanishes unless  $-1 \le l \le 1$ . Furthermore, using Lemma 2.5 and the scaling argument in the derivation of (3.2), we have

$$\mathcal{L}^{r,\Psi^{(m)}}_{\vec{\boldsymbol{s}}}[\sigma] \lesssim \sup_{-1 < l < 1} \left\| \sigma(2^l \cdot) \widehat{\Psi^{(m)}} \right\|_{L^r_{\vec{\boldsymbol{s}}}((\mathbb{R}^n)^m)} \lesssim \|\sigma\|_{L^r_{\vec{\boldsymbol{s}}}((\mathbb{R}^n)^m)}$$

and this is clearly less than a constant times

$$||M^{(l)}||_{L^{r}_{(s_{1},\ldots,s_{l})}((\mathbb{R}^{n})^{l})} \prod_{j=l+1}^{m} ||\widetilde{\varphi}^{\vee}||_{L^{r}_{s_{j}}(\mathbb{R}^{n})} \lesssim ||(I-\Delta_{1})^{s_{1}/2}\cdots(I-\Delta_{l})^{s_{l}/2}M^{(l)}||_{L^{r}((\mathbb{R}^{n})^{l})}.$$

We observe that

$$\widehat{M^{(l)}}(x_1,\ldots,x_l)$$

$$= \int_{(\mathbb{R}^n)^l} (K^{(l)})^{\vee} \left( \frac{1}{l} \sum_{k=1}^l (\xi_k - \mu_1) \right) \left[ \prod_{j=2}^l \varphi^{\vee} \left( \frac{1}{l} \sum_{k=1}^l (\xi_k - \xi_j) \right) \right] \left( \prod_{j=1}^l e^{-2\pi i \langle x_j, \xi_j \rangle} \right) d\xi_1 \cdots d\xi_l.$$

Using a change of variables with

$$\zeta_1 := \frac{1}{l} \sum_{k=1}^{l} (\xi_k - \mu_1), \quad \text{and} \quad \zeta_j := \frac{1}{l} \sum_{k=1}^{l} (\xi_k - \xi_j), \quad 2 \le j \le l$$

so that

(4.6) 
$$\xi_1 = \zeta_1 + \dots + \zeta_l + \mu_1$$
, and  $\xi_j = \zeta_1 - \zeta_j + \mu_1$ ,  $2 \le j \le l$ ,

we see that

$$\widehat{M^{(l)}}(x_1, \dots, x_l) = le^{-2\pi i \langle \sum_{k=1}^l x_k, \mu_1 \rangle} \int_{(\mathbb{R}^n)^l} (K^{(l)})^{\vee} (\zeta_1) \Big( \prod_{j=2}^l \varphi^{\vee}(\zeta_j) \Big) e^{-2\pi i \langle \sum_{k=1}^l x_k, \zeta_1 \rangle}$$

$$\times \Big( \prod_{j=2}^l e^{-2\pi i \langle x_1 - x_j, \zeta_j \rangle} \Big) d\zeta_1 \cdots d\zeta_l$$

$$= lK^{(l)}(x_1 + \dots + x_l) \varphi(x_1 - x_2) \cdots \varphi(x_1 - x_l) e^{-2\pi i \langle x_1 + \dots + x_l, \mu_1 \rangle}$$

$$(4.7)$$

since the Jacobian of the system (4.6) is l. Consequently,

$$(I - \Delta_1)^{s_1/2} \cdots (I - \Delta_l)^{s_l/2} M^{(l)}(\xi_1, \dots, \xi_l)$$

$$= l \int_{(\mathbb{R}^n)^l} \left( \prod_{j=1}^l \langle x_j \rangle^{s_j} \right) K^{(l)}(x_1 + \dots + x_l) \varphi(x_1 - x_2) \cdots \varphi(x_1 - x_l)$$

$$e^{-2\pi i \langle x_1 + \dots + x_l, \mu_1 \rangle} e^{2\pi i \langle x_1, \xi_1 \rangle} \cdots e^{2\pi i \langle x_l, \xi_l \rangle} dx_1 \cdots dx_l$$

and we perform another change of variables with

$$y_1 := x_1 + \dots + x_l$$
, and  $y_j := x_1 - x_j$ ,  $2 \le j \le l$ ,

which is equivalent to

$$x_1 = \frac{1}{l} \sum_{k=1}^{l} y_k$$
, and  $x_j = \frac{1}{l} \sum_{k=1}^{l} (y_k - y_j)$ ,  $2 \le j \le l$ ,

to obtain that the last expression is controlled by a constant times

$$\int_{(\mathbb{R}^n)^l} \left\langle \frac{1}{l} \sum_{k=1}^l y_k \right\rangle^{s_1} \left( \prod_{j=2}^l \left\langle \frac{1}{l} \sum_{k=1}^l (y_k - y_j) \right\rangle^{s_j} \right) K^{(l)}(y_1) \left( \prod_{j=2}^l \varphi(y_j) \right) \\
\times e^{2\pi i \langle y_1, \frac{1}{l} (\xi_1 + \dots + \xi_l) - \mu_1 \rangle} \left( \prod_{j=2}^l e^{2\pi i \langle y_j, \frac{1}{l} (\xi_1 + \dots + \xi_l) - \xi_j \rangle} \right) dy_1 \dots dy_l.$$

In conclusion, using a change of variables, we have

$$(4.8) \quad \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \lesssim \left\| \int_{(\mathbb{R}^n)^l} \left\langle \frac{1}{l} \sum_{k=1}^l y_k \right\rangle^{s_1} \left( \prod_{j=2}^l \left\langle \frac{1}{l} \sum_{k=1}^l (y_k - y_j) \right\rangle^{s_j} \right) \times K^{(l)}(y_1) \left( \prod_{j=2}^l \varphi(y_j) \right) \left( \prod_{j=1}^l e^{2\pi i \langle y_j, \xi_j \rangle} \right) dy_1 \cdots dy_l \right\|_{L^r(\xi_1, \dots, \xi_m)}.$$

For sufficiently large M > 0, let

$$\mathcal{N}_{(M)}(y_1,\ldots,y_l) := \frac{\left\langle \frac{1}{l} \sum_{k=1}^l y_k \right\rangle^{s_1} \prod_{j=2}^l \left\langle \frac{1}{l} \sum_{k=1}^l (y_k - y_j) \right\rangle^{s_j}}{\langle y_1 \rangle^{s_1 + \cdots + s_l} \prod_{j=2}^l \langle y_j \rangle^M}.$$

Then the right-hand side of (4.8) can be written as

where

$$K^{(l)}_{(s_1+\cdots+s_l)}(y_1) := \langle y_1 \rangle^{s_1+\cdots+s_l} K^{(l)}(y_1), \qquad \varphi^{(M)}(y) := \langle y \rangle^M \varphi(y).$$

Now we need the following lemma whose proof will be provided in Section 9.

**Lemma 4.1.** Let  $M > s_1 + \cdots + s_l + n + 2$ . Then  $\mathcal{N}_{(M)}$  is an  $L^r$  multiplier on  $(\mathbb{R}^n)^l$ .

By choosing  $M > s_1 + \cdots + s_l + n + 2$  and using Lemma 4.1 and 2.5, we obtain

$$(4.9) \lesssim \| (K_{(s_1 + \dots + s_l)}^{(l)})^{\vee} \otimes (\varphi^{(M)})^{\vee} \otimes \dots \otimes (\varphi^{(M)})^{\vee} \|_{L^r((\mathbb{R}^n)^l)}$$

$$\lesssim \| (I - \Delta)^{(s_1 + \dots + s_l)/2} (K^{(l)})^{\vee} \|_{L^r(\mathbb{R}^n)} = \| (I - \Delta)^{(s_1 + \dots + s_l)/2} (\mathcal{H}^{\vee} \varphi^{\vee}) \|_{L^r(\mathbb{R}^n)}$$

$$\lesssim \| (I - \Delta)^{(s_1 + \dots + s_l)/2} \mathcal{H}_{(s_1 + \dots + s_l + n/r', \tau)}^{\vee} \|_{L^r(\mathbb{R}^n)} = \| \widehat{\mathcal{H}_{(n/r', \tau)}} \|_{L^r(\mathbb{R}^n)}$$

and this is finite because of (1.13) with  $\tau > 2/r$ , which concludes that

$$\mathcal{L}^{r,\Psi^{(m)}}_{\vec{s}}[\sigma] < \infty.$$

To achieve

$$(4.10) ||T_{\sigma}||_{H^{p_1} \times \cdots \times H^{p_m} \to L^p} = \infty,$$

let

$$f_1(x) = \dots = f_l(x) := 2^n \widetilde{\varphi}(2x) e^{2\pi i \langle x, \mu_1 \rangle},$$

$$f_j(x) := \mathcal{H}_{(n/p_j, \tau_j)} * \varphi(x) e^{2\pi i \langle x, \mu_1 \rangle}, \quad l+1 \le j \le m.$$

Clearly,  $||f_j||_{H^{p_j}(\mathbb{R}^n)} \lesssim 1$  for  $1 \leq j \leq l$  and

$$||f_j||_{H^{p_j}(\mathbb{R}^n)} \approx ||f_j||_{L^{p_j}(\mathbb{R}^n)} \lesssim ||\mathcal{H}_{(n/p_j,\tau_j)}||_{L^{p_j}(\mathbb{R}^n)} \lesssim 1, \quad l+1 \leq j \leq m$$

due to (1.12) with  $\tau_j > 2/p_j$ , where the pointwise estimate  $\mathcal{H}_{(n/p_j,\tau_j)} * \varphi(x) \lesssim \mathcal{H}_{(n/p_j,\tau_j)}(x)$  is applied. On the other hand, using (4.5) and the facts that  $\varphi * \widetilde{\varphi} = \varphi$  and

$$\hat{f}_j(\xi) = 1$$
 for  $|\xi - \mu_1| \le \frac{1}{100m}$  and  $1 \le j \le l$ ,

we see that

$$\sigma(\xi_1,\ldots,\xi_m)\widehat{f_1}(\xi_1)\cdots\widehat{f_m}(\xi_m)=M^{(l)}(\xi_1,\ldots,\xi_l)\widehat{f_{l+1}}(\xi_{l+1})\cdots\widehat{f_m}(\xi_m),$$

which implies that

$$|T_{\sigma}\vec{f}(x)| = |(M^{(l)})^{\vee}(x, \dots, x)| |f_{l+1}(x)| \cdots |f_{m}(x)|$$
$$= l|K^{(l)}(lx)| |\varphi(0)|^{l-1} \prod_{j=l+1}^{m} |\mathcal{H}_{(n/p_{j}, \tau_{j})} * \varphi(x)|$$

where we applied (4.7) and the fact that  $K^{(l)}$  is a radial function. Now, since

$$\mathcal{H}_{(s,\gamma)} * \varphi(x) \gtrsim \mathcal{H}_{(s,\gamma)}(x)$$
 for any  $s, \gamma > 0$ ,

which follows from the fact that  $\varphi, \mathcal{H}_{(s,\gamma)} \geq 0$  and (1.11), we obtain that

$$\begin{aligned} \|T_{\sigma}\vec{f}(x)\|_{L^{p}(\mathbb{R}^{n})} &\gtrsim \|\mathcal{H}(l) \prod_{j=l+1}^{m} \mathcal{H}_{(n/p_{j},\tau_{j})} \|_{L^{p}(\mathbb{R}^{n})} \\ &\approx \|\mathcal{H}_{(s_{1}+\dots+s_{l}+n/r',\tau)} \prod_{j=l+1}^{m} \mathcal{H}_{(n/p_{j},\tau_{j})} \|_{L^{p}(\mathbb{R}^{n})} \\ &= \|\mathcal{H}_{(s_{1}+\dots+s_{l}+n/p_{l+1}+\dots+n/p_{m}+n/r',\tau+\tau_{l+1}+\dots+\tau_{m})} \|_{L^{p}(\mathbb{R}^{n})}. \end{aligned}$$

Since  $s_1 + \cdots + s_l + n/p_{l+1} + \cdots + n/p_m + n/r' \le n/p$  due to (4.1), the last expression is greater than

$$\left\|\mathcal{H}_{(n/p,\tau+\tau_{l+1}+\cdots+\tau_m)}\right\|_{L^p(\mathbb{R}^n)} = \infty$$

because of (1.12) with  $\tau + \tau_{l+1} + \cdots + \tau_m < p/2$ , which follows from (4.2). This completes the proof of (4.10).

When l=m, exactly the same argument is applicable with  $2/r < \tau < 2m/r + 2/r' < 2/p$ ,  $\sigma := M^{(m)}$ , and  $f_j(x) := 2^d \widetilde{\varphi}(2x) e^{2\pi i \langle x, \mu_1 \rangle}$  for  $1 \leq j \leq m$ . Since the proof is just a repetition, we omit the details.

## 5. Proof of Proposition 1.4

Let  $\Theta^{(m)}$  be a Schwartz function on  $(\mathbb{R}^n)^m$  such that  $0 \leq \widehat{\Theta^{(m)}} \leq 1$ ,  $\widehat{\Theta^{(m)}}(\vec{\xi}) = 1$  for  $2^{-2}m^{-1/2} \leq |\vec{\xi}| \leq 2^2m^{1/2}$ , and  $\operatorname{Supp}(\widehat{\Theta^{(m)}}) \subset \{\vec{\xi} \in (\mathbb{R}^n)^m : 2^{-3}m^{-1/2} \leq |\vec{\xi}| \leq 2^3m^{1/2}\}$ . Then using the Littlewood-Paley partition of unity  $\{2^{jmn}\Psi^{(m)}(2^j\cdot)\}_{j\in\mathbb{Z}}$ , the triangle inequality, and Lemma 2.5, we first see that  $\mathcal{L}^{r,\Theta^{(m)}}_{\vec{s}}[\sigma] \lesssim \mathcal{L}^{r,\Psi^{(m)}}_{\vec{s}}[\sigma]$ . Thus it suffices to prove the estimate

$$\|T_{\sigma}\vec{f}\|_{L^{p}(\mathbb{R}^{n})} \lesssim \mathcal{L}_{\vec{s}}^{r,\Theta^{(m)}}[\sigma] \prod_{i=1}^{m} \|f_{i}\|_{L^{p_{i}}(\mathbb{R}^{n})}$$

as  $L^{p_i} = H^{p_i}$  for  $1 < p_i \le \infty$ . We adopt the notation  $\mathcal{L}^r_{\vec{s}}[\sigma] := \mathcal{L}^{r,\Theta^{(m)}}_{\vec{s}}[\sigma]$  for simplicity. It follows from (1.14) that there exists 1 < t < r such that

$$s_1, \ldots, s_m > n/t > n/r.$$

Since  $\sigma(2^j \vec{\cdot}) \widehat{\Theta^{(m)}}$  has a compact support in an annulus of a constant size, independent of j, we have

(5.1) 
$$\mathcal{L}_{\vec{s}}^t[\sigma] \lesssim \mathcal{L}_{\vec{s}}^r[\sigma]$$

as 1 < t < r. See [9, Section 5] for more details.

Using the Littlewood-Paley partition of unity  $\{\psi_j\}_{j\in\mathbb{Z}}$ , we decompose  $\sigma(\vec{\xi})$  as

$$(5.2) \quad \sigma(\vec{\xi}) = \sum_{j_1, \dots, j_m \in \mathbb{Z}} \sigma(\vec{\xi}) \widehat{\psi_{j_1}}(\xi_1) \cdots \widehat{\psi_{j_m}}(\xi_m)$$

$$= \left(\sum_{j_1 \in \mathbb{Z}} \sum_{j_2, \dots, j_m \le j_1} \cdots\right) + \left(\sum_{j_2 \in \mathbb{Z}} \sum_{\substack{j_1 < j_2 \\ j_3, \dots, j_m \le j_2}} \cdots\right) + \cdots + \left(\sum_{j_m \in \mathbb{Z}} \sum_{j_1, \dots, j_{m-1} < j_m} \cdots\right)$$

$$=: \sigma^{(1)}(\vec{\xi}) + \sigma^{(2)}(\vec{\xi}) + \cdots + \sigma^{(m)}(\vec{\xi}).$$

We are only concerned with  $\sigma^{(1)}$  appealing to symmetry for the other cases. Thus, our goal is to show that

$$||T_{\sigma^{(1)}}\vec{f}||_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}^r_{\vec{s}}[\sigma] \prod_{i=1}^m ||f_i||_{L^{p_i}(\mathbb{R}^n)}.$$

We write

$$\sigma^{(1)}(\vec{\xi}) = \sum_{j \in \mathbb{Z}} \sum_{j_2, \dots, j_m \le j} \sigma(\vec{\xi}) \widehat{\psi_j}(\xi_1) \widehat{\psi_{j_2}}(\xi_2) \cdots \widehat{\psi_{j_m}}(\xi_m)$$

$$= \sum_{j \in \mathbb{Z}} \sigma(\vec{\xi}) \widehat{\Theta^{(m)}}(\vec{\xi}/2^j) \widehat{\psi_j}(\xi_1) \sum_{j_2, \dots, j_m \le j} \widehat{\psi_{j_2}}(\xi_2) \cdots \widehat{\psi_{j_m}}(\xi_m),$$

since 
$$\widehat{\Theta^{(m)}}(\vec{\xi}/2^j) = 1$$
 for  $2^{j-1} \le |\xi_1| \le 2^{j+1}$  and  $|\xi_i| \le 2^{j+1}$  for  $2 \le i \le m$ . Let  $\sigma_i(\vec{\xi}) := \sigma(\vec{\xi})\widehat{\Theta^{(m)}}(\vec{\xi}/2^j)$ .

Then we note that

(5.4) 
$$\|\sigma_j(2^j \cdot)\|_{L^t_{\underline{\sigma}}((\mathbb{R}^n)^m)} \le \mathcal{L}^t_{\vec{s}}[\sigma]$$

and

$$\sigma^{(1)}(\vec{\xi}) = \sum_{j \in \mathbb{Z}} \sigma_j(\vec{\xi}) \widehat{\psi_j}(\xi_1) \sum_{j_2, \dots, j_m \leq j} \widehat{\psi_{j_2}}(\xi_2) \cdots \widehat{\psi_{j_m}}(\xi_m).$$

We further decompose  $\sigma^{(1)}$  as

$$\sigma^{(1)}(\vec{\xi}) = \sigma^{(1)}_{low}(\vec{\xi}) + \sigma^{(1)}_{high}(\vec{\xi})$$

where

$$\sigma_{low}^{(1)}(\vec{\boldsymbol{\xi}}) := \sum_{j \in \mathbb{Z}} \sigma_j(\vec{\boldsymbol{\xi}}) \widehat{\psi_j}(\xi_1) \sum_{\substack{j_2, \dots, j_m \leq j \\ \max_{2 \leq i \leq m} (j_i) \geq j - 3 - \lfloor \log_2 m \rfloor}} \widehat{\psi_{j_2}}(\xi_2) \cdots \widehat{\psi_{j_m}}(\xi_m),$$

(5.5) 
$$\sigma_{high}^{(1)}(\vec{\boldsymbol{\xi}}) := \sum_{j \in \mathbb{Z}} \sigma_j(\vec{\boldsymbol{\xi}}) \widehat{\psi_j}(\xi_1) \sum_{j_2, \dots, j_m \le j-4-\lfloor \log_2 m \rfloor} \widehat{\psi_{j_2}}(\xi_2) \cdots \widehat{\psi_{j_m}}(\xi_m).$$

We refer to  $T_{\sigma^{(1)}_{low}}$  as the low frequency part and  $T_{\sigma^{(1)}_{high}}$  as the high frequency part of  $T_{\sigma^{(1)}}$  (due to the Fourier supports of the summands in  $T_{\sigma^{(1)}_{low}}\vec{f}$  and  $T_{\sigma^{(1)}_{high}}\vec{f}$ ).

5.1. Low frequency part. To establish the estimate for the operator  $T_{\sigma_{low}^{(1)}}$ , we first observe that

$$T_{\sigma_{low}^{(1)}} \vec{f}(x) = \sum_{j \in \mathbb{Z}} \sum_{\substack{j_2, \dots, j_m \le j \\ \max_{2 \le i \le m} (j_i) \ge j - 3 - \lfloor \log_2 m \rfloor}} T_{\sigma_j} ((f_1)_j, (f_2)_{j_2}, \dots, (f_m)_{j_m})(x)$$

where  $(g)_l := \psi_l * g$  for  $g \in \mathcal{S}(\mathbb{R}^n)$  and  $l \in \mathbb{Z}$ . It suffices to treat only the sum over  $j_3, \ldots, j_m \leq j_2$  and  $j - 3 - \lfloor \log_2 m \rfloor \leq j_2 \leq j$ , and we will actually prove that

$$(5.6) \quad \left\| \sum_{j \in \mathbb{Z}} \sum_{\substack{j-3-\lfloor \log_2 m \rfloor \leq j_2 \leq j \\ j_3, \dots, j_m \leq j_2}} T_{\sigma_j} \left( (f_1)_j, (f_2)_{j_2}, \dots, (f_m)_{j_m} \right) \right\|_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \prod_{i=1}^m \|f_i\|_{L^{p_i}(\mathbb{R}^n)}.$$

Let  $\phi$  be the Schwartz function defined in (2.1) and  $\phi_j := 2^{jn}\phi(2^j)$  for  $j \in \mathbb{Z}$ . Let  $(g)^l := \phi_l * g$  for  $g \in \mathcal{S}(\mathbb{R}^n)$ . Then we can write

$$\sum_{j_3,\dots,j_n\leq j_2} T_{\sigma_j} \big( (f_1)_j, (f_2)_{j_2}, \dots, (f_m)_{j_m} \big) (x) = T_{\sigma_j} \big( (f_1)_j, (f_2)_{j_2}, (f_3)^{j_2}, \dots, (f_m)^{j_2} \big) (x).$$

Since the sum over  $j_2$  in the left-hand side of (5.6) is a finite sum over  $j_2$  near j, we may consider only the case  $j_2 = j$  and thus our claim is

(5.7) 
$$\left\| \sum_{j \in \mathbb{Z}} T_{\sigma_j} ((f_1)_j, (f_2)_j, (f_3)^j, \dots, (f_m)^j) \right\|_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}^r_{\vec{s}}[\sigma] \prod_{i=1}^m \|f_i\|_{L^{p_i}(\mathbb{R}^n)}.$$

Using Lemma 2.4, (5.4), and (5.1), we obtain the pointwise estimate

(5.8)

$$|T_{\sigma_j}((f_1)_j, (f_2)_j, (f_3)^j, \dots, (f_m)^j)(x)| \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \Big(\prod_{i=1}^2 \mathfrak{M}_{s_i, 2^j}^t(f_i)_j(x)\Big) \Big(\prod_{i=3}^m \mathfrak{M}_{s_i, 2^j}^t(f_i)^j(x)\Big).$$

Since  $s_1, s_2 > n/t = n/\min(p_1, 2, t) = n/\min(p_2, 2, t)$ , it follows from Lemma 2.2 that for any dyadic cube  $Q \in \mathcal{D}$  there exists measurable proper subsets  $S_Q^1$  and  $S_Q^2$  of Q such that  $|S_Q^1|, |S_Q^2| > \frac{3}{4}|Q|$  and

(5.9) 
$$||f_i||_{X^{p_i}} \approx \left\| \left\{ \sum_{Q \in \mathcal{D}_j} \left( \inf_{y \in Q} \mathfrak{M}^t_{s_i, 2^j}(f_i)_j(y) \right) \chi_{S_Q^i} \right\}_{j \in \mathbb{Z}} \right\|_{L^{p_i}(\ell^2)}, \quad i = 1, 2.$$

Note that  $|S_Q^1\cap S_Q^2|\geq \frac{1}{2}|Q|$  and thus, for any  $\tau>0$ 

(5.10) 
$$\chi_Q(x) \lesssim_{\tau} \mathcal{M}_{\tau} \left( \chi_{S_Q^{(1)} \cap S_Q^{(2)}} \right) (x) \chi_Q(x),$$

using the argument in (2.8). Clearly, the constant in the inequality is independent of Q. Now we choose  $\tau < \min(1, p)$ , and apply (5.8), (5.10), and (2.3), as in the proof of Lemma 2.3, to obtain

$$\begin{split} & \left\| \sum_{j \in \mathbb{Z}} T_{\sigma_{j}} \left( (f_{1})_{j}, (f_{2})_{j}, (f_{3})^{j}, \dots, (f_{m})^{j} \right) \right\|_{L^{p}(\mathbb{R}^{n})} \\ & \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \sum_{j \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_{j}} \left( \prod_{i=1}^{2} \mathfrak{M}_{s_{i},2^{j}}^{t}(f_{i})_{j} \right) \left( \prod_{i=3}^{m} \mathfrak{M}_{s_{i},2^{j}}^{t}(f_{i})^{j} \right) \chi_{Q} \right\|_{L^{p}(\mathbb{R}^{n})} \\ & \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \sum_{j \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_{j}} \left( \prod_{i=1}^{2} \Omega_{s_{i},t}^{Q,1} f_{i} \right) \left( \prod_{i=3}^{m} \Omega_{s_{i},t}^{Q,2} f_{i} \right) \mathcal{M}_{\tau} (\chi_{S_{Q}^{1} \cap S_{Q}^{2}}) \right\|_{L^{p}(\mathbb{R}^{n})} \\ & \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \sum_{j \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_{j}} \left( \prod_{i=1}^{2} \Omega_{s_{i},t}^{Q,1} f_{i} \right) \left( \prod_{i=3}^{m} \Omega_{s_{i},t}^{Q,2} f_{i} \right) \chi_{S_{Q}^{1}} \chi_{S_{Q}^{2}} \right\|_{L^{p}(\mathbb{R}^{n})}, \end{split}$$

where  $\Omega_{s,t}^{Q,1}g:=\inf_{y\in Q}\mathfrak{M}^t_{s,2^j}(g)_j(y)$  and  $\Omega_{s,t}^{Q,2}g:=\inf_{y\in Q}\mathfrak{M}^t_{s,2^j}(g)^j(y)$  for all  $Q\in \mathcal{D}_j$ .

Using Hölder's inequality and the fact that  $\Omega_{s_i,t}^{Q,2}f_i \leq \mathfrak{M}_{s_i,t}^t(f_i)^j(x)$  for all  $x \in Q \in \mathcal{D}_j$ , the  $L^p$  norm in the last displayed expression is bounded by a constant times

$$\left(\prod_{i=1}^{2} \left\| \left\{ \sum_{Q \in \mathcal{D}_{j}} \Omega_{s_{i},t}^{Q,1} f_{i} \cdot \chi_{S_{Q}^{i}} \right\}_{j \in \mathbb{Z}} \right\|_{L^{p_{i}}(\ell^{2})} \right) \left(\prod_{i=3}^{m} \left\| \left\{ \mathfrak{M}_{s_{i},2^{j}}^{t} (f_{i})^{j} \right\}_{j \in \mathbb{Z}} \right\|_{L^{p_{i}}(\ell^{\infty})} \right) 
\lesssim \|f_{1}\|_{X^{p_{1}}(\mathbb{R}^{n})} \|f_{2}\|_{X^{p_{2}}(\mathbb{R}^{n})} \prod_{i=3}^{m} \|f_{i}\|_{H^{p_{i}}(\mathbb{R}^{n})},$$

where the inequality follows from Lemmas 2.1, 2.2, and the definition of Hardy space  $H^{p_i}$ . Since  $H^{p_i} = L^{p_i} \subset X^{p_i}$  when  $1 < p_i \le \infty$ , we finally obtain (5.7).

5.2. **High frequency part.** The proof for the high frequency part relies on the fact that if  $\widehat{g_j}$  is supported on  $\{\xi \in \mathbb{R}^n : C^{-1}2^j \leq |\xi| \leq C2^j\}$  for some C > 1, then

(5.11) 
$$\left\| \left\{ \psi_j * \left( \sum_{l=i-h}^{j+h} g_l \right) \right\}_{j \in \mathbb{Z}} \right\|_{L^p(\ell^q)} \lesssim_{h,C} \left\| \left\{ g_j \right\}_{j \in \mathbb{Z}} \right\|_{L^p(\ell^q)}, \quad 0$$

for  $h \in \mathbb{N}$ . The proof of (5.11) is elementary and standard, so it is omitted here. Just use the estimate  $|\psi_j * g_l(x)| \lesssim_{\sigma} \mathfrak{M}_{\sigma,2^l} g_l(x)$  for  $0 < \sigma < p,q$  and  $j-h \leq l \leq j+h$ , and apply Lemma 2.1.

We note that

$$T_{\sigma_{high}^{(1)}} \vec{f}(x) = \sum_{j \in \mathbb{Z}} T_{\sigma_j} ((f_1)_j, (f_2)^{j,m}, \dots, (f_m)^{j,m})(x)$$

where  $\phi_l$  is defined as in the previous subsection and  $(f_i)^{j,m} := \phi_{j-4-\lfloor \log_2 m \rfloor} * f_i$  for  $2 \le i \le m$ . Observe that the Fourier transform of  $T_{\sigma_j}((f_1)_j, (f_2)^{j,m}, \dots, (f_m)^{j,m})$  is supported in  $\{\xi \in \mathbb{R}^n : 2^{j-3} \le |\xi| \le 2^{j+3}\}$  and thus (5.11) yields that

(5.12) 
$$||T_{\sigma_{high}^{(1)}}\vec{f}||_{L^{p}(\mathbb{R}^{n})} \lesssim ||\{T_{\sigma_{j}}((f_{1})_{j},(f_{2})^{j,m},\ldots,(f_{m})^{j,m})\}_{j\in\mathbb{Z}}||_{L^{p}(\ell^{2})}.$$

Moreover, it follows from Lemma 2.4, (5.4), and (5.1), that

$$|T_{\sigma_j}((f_1)_j, (f_2)^{j,m}, \dots, (f_m)^{j,m})(x)| \lesssim \mathcal{L}^r_{\vec{s}}[\sigma]\mathfrak{M}^t_{s_1,2^j}(f_1)_j(x) \prod_{i=2}^m \mathfrak{M}^t_{s_i,2^j}(f_i)^{j,m}(x).$$

For  $Q \in \mathcal{D}$  let  $S_Q^1$  be a measurable proper subset of Q such that  $|S_Q^1| > \frac{3}{4}|Q|$  and (5.9) holds for i = 1 as before, and by an analogous argument we obtain

$$\begin{split} & \left\| T_{\sigma_{high}^{(1)}} \vec{f} \right\|_{L^{p}(\mathbb{R}^{n})} \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \left\{ \mathfrak{M}_{s_{1},2^{j}}^{t}(f_{1})_{j} \prod_{i=2}^{m} \mathfrak{M}_{s_{i},2^{j}}^{t}(f_{i})^{j,m} \right\}_{j \in \mathbb{Z}} \right\|_{L^{p}(\ell^{2})} \\ & \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \left\{ \sum_{Q \in \mathcal{D}_{j}} \left( \inf_{y \in Q} \mathfrak{M}_{s_{1},2^{j}}^{t}(f_{1})_{j}(y) \right) \left[ \prod_{i=2}^{m} \left( \inf_{y \in Q} \mathfrak{M}_{s_{i},2^{j}}^{t}(f_{i})^{j,m}(y) \right) \right] \chi_{S_{Q}^{1}} \right\}_{j \in \mathbb{Z}} \right\|_{L^{p}(\ell^{2})} \\ & \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \left\{ \sum_{Q \in \mathcal{D}_{j}} \left( \inf_{y \in Q} \mathfrak{M}_{s_{1},2^{j}}^{t}(f_{1})(y) \right) \chi_{S_{Q}^{1}} \right\}_{j \in \mathbb{Z}} \right\|_{L^{p_{1}}(\ell^{2})} \prod_{i=2}^{m} \left\| \sup_{j \in \mathbb{Z}} \left| \phi_{j} * f_{i} \right| \right\|_{L^{p_{i}}(\mathbb{R}^{n})} \\ & \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \| f_{1} \|_{X^{p_{1}}(\mathbb{R}^{n})} \prod_{i=2}^{m} \| f_{i} \|_{H^{p_{i}}(\mathbb{R}^{n})} \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \prod_{i=1}^{m} \| f_{i} \|_{L^{p_{i}}(\mathbb{R}^{n})}. \end{split}$$

## 6. Proof of Proposition 1.5

We consider only the case l < m as a similar and simpler procedure is applicable to the case l = m. Let  $1 \le l < m$ ,  $0 < p_1, \ldots, p_l \le 1$ ,  $p_{l+1} = \cdots = p_m = \infty$ , and  $1/p = 1/p_1 + \cdots + 1/p_l$ . For simplicity we assume that  $||f_{l+1}||_{L^{\infty}(\mathbb{R}^n)} = \cdots = ||f_m||_{L^{\infty}(\mathbb{R}^n)} = 1$ . Then the aim is to show that

(6.1) 
$$||T_{\sigma}\vec{f}||_{L^{p}(\mathbb{R}^{n})} \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^{l} ||f_{i}||_{H^{p_{i}}(\mathbb{R}^{n})}.$$

Let  $f_i \in H^{p_i}(\mathbb{R}^n)$  for  $1 \leq i \leq l$ . Using atomic representations, we write

$$f_i = \sum_{k_i=1}^{\infty} \lambda_{i,k_i} a_{i,k_i}, \quad 1 \le i \le l,$$

where  $a_{i,k_i}$  are  $L^{\infty}$ -atoms for  $H^{p_i}$  satisfying

(6.2) 
$$\operatorname{Supp}(a_{i,k_i}) \subset Q_{i,k_i}, \quad \|a_{i,k_i}\|_{L^{\infty}(\mathbb{R}^n)} \le |Q_{i,k_i}|^{-1/p_i}, \quad \int_{Q_{i,k_i}} x^{\alpha} a_{i,k_i}(x) dx = 0$$

for  $|\alpha| < N_i$  with  $N_i$  large enough, and

(6.3) 
$$\left(\sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i}\right)^{1/p_i} \lesssim ||f_i||_{H^{p_i}(\mathbb{R}^n)}.$$

By the regularization in Lemma 2.6, we can assume that  $\sigma$  is a Schwartz function whose Fourier transform has a compact support in  $(\mathbb{R}^n)^m$ . Then Lemma 2.7 yields that

(6.4) 
$$T_{\sigma} \vec{f}(x) = \sum_{k_1=1}^{\infty} \cdots \sum_{k_l=1}^{\infty} \lambda_{1,k_1} \dots \lambda_{l,k_l} T_{\sigma} (a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m)(x)$$

for a.e.  $x \in \mathbb{R}^n$ .

For a cube Q we denote by  $Q^*$  its concentric dilate by a factor  $10\sqrt{n}$ . Now we can split  $T_{\sigma}\vec{f}$  into two parts and estimate

$$\left|T_{\sigma}\vec{\boldsymbol{f}}(x)\right| \leq G_1(x) + G_2(x),$$

where

$$G_{1} := \sum_{k_{1}=1}^{\infty} \cdots \sum_{k_{l}=1}^{\infty} |\lambda_{1,k_{1}}| \cdots |\lambda_{l,k_{l}}| |T_{\sigma}(a_{1,k_{1}}, \dots, a_{l,k_{l}}, f_{l+1}, \dots, f_{m})| \chi_{Q_{1,k_{1}}^{*} \cap \dots \cap Q_{l,k_{l}}^{*}},$$

$$G_2 := \sum_{k_1=1}^{\infty} \cdots \sum_{k_l=1}^{\infty} |\lambda_{1,k_1}| \cdots |\lambda_{l,k_l}| |T_{\sigma}(a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m)| \chi_{(Q_{1,k_1}^* \cap \dots \cap Q_{l,k_l}^*)^c}.$$

The first part  $G_1$  can be dealt with via Lemma 2.10. Suppose that  $Q_{1,k_1}^* \cap \cdots \cap Q_{l,k_l}^* \neq \emptyset$ , as if this intersection is empty we are done. From these cubes, choose a cube that has the minimum side length, and denote it by  $R_{k_1,\ldots,k_l}$ . Then

$$Q_{1,k_1}^* \cap \dots \cap Q_{l,k_l}^* \subset R_{k_1,\dots,k_l} \subset Q_{1,k_1}^{**} \cap \dots \cap Q_{l,k_l}^{**},$$

where  $Q_{i,k_i}^{**}:=(Q_{i,k_i}^*)^*$  denotes a dilation of  $Q_{i,k_i}^*$  . We shall prove (6.5)

$$\frac{1}{|R_{k_1,\dots,k_l}|} \int_{R_{k_1,\dots,k_l}} |T_{\sigma}(a_{1,k_1},\dots,a_{l,k_l},f_{l+1},\dots,f_m)(y)| dy \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^{l} |Q_{i,k_i}|^{-1/p_i}.$$

To verify this, we may assume, without loss of generality,  $R_{k_1,...,k_l} = Q_{1,k_1}^*$ . Using the Cauchy-Schwarz inequality, the left-hand side of (6.5) is majored by

$$\frac{1}{|Q_{1,k_1}^*|^{1/2}} \left\| T_{\sigma} \left( a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m \right) \right\|_{L^2(\mathbb{R}^n)}$$

and this is less than a constant multiple of

$$\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \frac{1}{|Q_{1,k_1}^*|^{1/2}} \|a_{1,k_1}\|_{L^2(\mathbb{R}^n)} \prod_{i=2}^l \|a_{i,k_i}\|_{L^{\infty}(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^l |Q_{i,k_i}|^{-1/p_i}$$

in view of Proposition 1.4. This proves (6.5).

We now apply Lemma 2.10, the estimate (6.5), and the Hölder inequality to obtain

$$||G_{1}||_{L^{p}(\mathbb{R}^{n})} \lesssim \left\| \sum_{k_{1}=1}^{\infty} \cdots \sum_{k_{l}=1}^{\infty} \left( \prod_{i=1}^{l} |\lambda_{i,k_{i}}| \right) \chi_{R_{k_{1},\dots,k_{l}}} \frac{1}{|R_{k_{1},\dots,k_{l}}|}$$

$$\times \int_{R_{k_{1},\dots,k_{l}}} |T_{\sigma}(a_{1,k_{1}},\dots,a_{l,k_{l}},f_{l+1},\dots,f_{m})(y)| dy \right\|_{L^{p}(\mathbb{R}^{n})}$$

$$\lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \left\| \sum_{k_{1}=1}^{\infty} \cdots \sum_{k_{l}=1}^{\infty} \left( \prod_{i=1}^{l} |\lambda_{i,k_{i}}| |Q_{i,k_{i}}|^{-1/p_{i}} \chi_{Q_{i,k_{i}}^{**}} \right) \right\|_{L^{p}(\mathbb{R}^{n})}$$

$$\leq \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^{l} \left\| \sum_{k_{i}=1}^{\infty} |\lambda_{i,k_{i}}| |Q_{i,k_{i}}|^{-1/p_{i}} \chi_{Q_{i,k_{i}}^{**}} \right\|_{L^{p_{i}}(\mathbb{R}^{n})},$$

and this clearly implies that

(6.6) 
$$||G_1||_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}^{r,\Psi^{(m)}}_{\vec{s}}[\sigma] \prod_{i=1}^l ||f_i||_{H^{p_i}(\mathbb{R}^n)}$$

as

$$\left\| \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}| |Q_{i,k_i}|^{-1/p_i} \chi_{Q_{i,k_i}^{**}} \right\|_{L^{p_i}(\mathbb{R}^n)} \le \left( \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i} \right)^{1/p_i} \lesssim \|f_i\|_{H^{p_i}(\mathbb{R}^n)}.$$

To obtain the estimate for  $G_2$ , we need the following lemma whose proof will be given in Section 9.

**Lemma 6.1.** Let  $1 \le l < m$  and  $0 < p_1, \ldots, p_l \le 1$ . Let  $a_i, 1 \le i \le l$ , be atoms supported in the cube  $Q_i$  such that

(6.7) 
$$||a_i||_{L^{\infty}(\mathbb{R}^n)} \le |Q_i|^{-1/p_i}, \qquad \int_{Q_i} x^{\alpha} a_i(x) dx = 0$$

for all  $|\alpha| < N_i$  with  $N_i$  sufficiently large. Let  $||f_{l+1}||_{L^{\infty}(\mathbb{R}^n)} = \cdots = ||f_m||_{L^{\infty}(\mathbb{R}^n)} = 1$ . Suppose that (1.15) holds for all  $J \subset \{1, \ldots, l\}$  and  $\sigma$  satisfies  $\mathcal{L}^{r, \Psi^{(m)}}_{\vec{s}}[\sigma] < \infty$ . Then for any nonempty subset  $J_0$  of  $\{1, \ldots, l\}$ , there exist nonnegative functions  $b_1^{J_0}, \ldots, b_l^{J_0}$  such that

$$\|b_i^{J_0}\|_{L^{p_i}(\mathbb{R}^n)} \lesssim 1 \quad \text{for } 1 \leq i \leq l,$$

and

$$\left| T_{\sigma}(a_1, \dots, a_l, f_{l+1}, \dots, f_m)(x) \right| \lesssim \mathcal{L}_{\vec{s}}^{r, \Psi^{(m)}}[\sigma] b_1^{J_0}(x) \cdots b_l^{J_0}(x)$$
 for all  $x \in \left( \bigcap_{i \notin J_0} Q_i^* \right) \setminus \left( \bigcup_{i \in J_0} Q_i^* \right)$ .

Let  $J_0$  be a nonempty subset of  $\{1,\ldots,l\}$ . Then Lemma 6.1 ensures the existence of nonnegative functions  $b_{1,k_1}^{J_0},\ldots,b_{l,k_l}^{J_0}$  such that

$$\left| T_{\sigma} \left( a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m \right) (x) \right| \lesssim \mathcal{L}_{\vec{s}}^{r, \Psi^{(m)}} [\sigma] b_{1,k_1}^{J_0} (x) \cdots b_{l,k_l}^{J_0} (x)$$

for all  $x \in \left(\bigcap_{i \notin J_0} Q_{i,k_i}^*\right) \setminus \left(\bigcup_{i \in J_0} Q_{i,k_i}^*\right)$  and  $\|b_{i,k_i}^{J_0}\|_{L^{p_i}(\mathbb{R}^n)} \lesssim 1$ . Now set

$$b_{i,k_i} := \sum_{\emptyset \neq J_0 \subset \{1,2,\dots,l\}} b_{i,k_i}^{J_0}.$$

Since it is a finite sum, we first note that  $||b_{i,k_i}||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1$ . In addition, we have the pointwise estimate

$$|T_{\sigma}(a_{1,k_1},\ldots,a_{l,k_l},f_{l+1},\ldots,f_m)(x)|\chi_{(Q_{1,k_1}^*\cap\ldots\cap Q_{l,k_l}^*)^c}(x) \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma]b_{1,k_1}(x)\cdots b_{l,k_l}(x),$$

which yields that

$$G_2(x) \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^{l} \Big( \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}| b_{i,k_i}(x) \Big).$$

Then we apply Hölder's inequality to deduce that

$$(6.8) \|G_2\|_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^l \left\| \sum_{k_i=1}^\infty |\lambda_{i,k_i}| b_{i,k_i} \right\|_{L^{p_i}(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \prod_{i=1}^l \|f_i\|_{H^{p_i}(\mathbb{R}^n)}$$

because

$$\left\| \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}| b_{i,k_i} \right\|_{L^{p_i}(\mathbb{R}^n)} \leq \left( \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i} \|b_{i,k_i}\|_{L^{p_i}(\mathbb{R}^n)}^{p_i} \right)^{1/p_i} \lesssim \left( \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i} \right)^{1/p_i} \lesssim \|f_i\|_{H^{p_i}(\mathbb{R}^n)}.$$

Combining (6.6) and (6.8), we finally obtain (6.1) as desired. This completes the proof.

## 7. Proof of Proposition 1.6

Let  $1 < r \le 2$ ,  $1 \le l < \rho \le m$ , and

(7.1) 
$$I := \{1, \dots, l\}, \quad II := \{l+1, \dots, \rho\}, \quad III := \{\rho+1, \dots, m\}, \quad \Lambda := I \cup II \cup III.$$

Assume that  $0 < p_i \le 1$  for  $i \in I$ ,  $r \le p_i < \infty$  for  $i \in II$ , and  $1/p_1 + \cdots + 1/p_\rho = 1/p$ . Let  $||f_i||_{L^{\infty}(\mathbb{R}^n)} = 1$  for  $i \in III$ . As in (5.2), we write

$$\sigma(\vec{\boldsymbol{\xi}}) = \sum_{j_1, \dots, j_m \in \mathbb{Z}} \sigma(\vec{\boldsymbol{\xi}}) \widehat{\psi_{j_1}}(\xi_1) \cdots \widehat{\psi_{j_m}}(\xi_m).$$

If  $\max(j_1,\ldots,j_m)=j_k$ , then there are two cases

(Case1) 
$$j_k - 3 - \lfloor \log_2 m \rfloor \le \max_{j_i \neq j_k} (j_i) \le j_k,$$

(Case2) 
$$\max_{j_i \neq j_k} (j_i) \leq j_k - 4 - \lfloor \log_2 m \rfloor.$$

For (Case1), we utilize the argument in Section 5.1. That is, we need to prove that for  $1 \le \kappa_1 < \kappa_2 \le m$ 

(7.2) 
$$\left\| \sum_{j \in \mathbb{Z}} \left| T_{\sigma_{j}} \left( (f_{1})^{j}, \dots, (f_{\kappa_{1}-1})^{j}, (f_{\kappa_{1}})_{j}, (f_{\kappa_{1}+1})^{j}, \dots \right. \right. \right. \\ \left. \left. \left. \left( f_{\kappa_{2}-1} \right)^{j}, (f_{\kappa_{2}})_{j}, (f_{\kappa_{2}+1})^{j}, \dots, (f_{m})^{j} \right) \right| \right\|_{L^{p}(\mathbb{R}^{n})} \\ \lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \prod_{i \in I \cup II} \|f_{i}\|_{H^{p_{i}}(\mathbb{R}^{n})},$$

where  $(g)_j := \psi_j * g$  and  $(g)^j := \phi_j * g$  as before.

We remark that (Case2) is a high frequency part for which  $T_{\sigma_{high}^{(\kappa)}}(f_1,\ldots,f_m)$  is written as the sum, over  $j_{\kappa} \in \mathbb{Z}$ , of terms whose Fourier transform is supported in an annulus of size  $2^{j_{\kappa}}$  where  $\sigma^{(\kappa)}$  is defined as in (5.3) and  $\sigma_{high}^{(\kappa)}$  is similar to (5.5). Thus, the square function characterization of  $H^p$  will be applied to deal with this case as in (5.12). We will actually prove that for each  $1 \leq \kappa \leq m$ 

$$\left\| \left( \sum_{j \in \mathbb{Z}} \left| T_{\sigma_j} \left( (f_1)^{j,m}, \dots, (f_{\kappa-1})^{j,m}, (f_{\kappa})_j, (f_{\kappa+1})^{j,m}, \dots, (f_m)^{j,m} \right) \right|^2 \right)^{1/2} \right\|_{L^p(\mathbb{R}^n)}$$

$$(7.3) \qquad \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \prod_{i \in I \cup II} \|f_i\|_{H^{p_i}(\mathbb{R}^n)}$$

where  $(g)^{j,m} := \phi_{j-4-|\log_2 m|} * g$ .

7.1. **Proof of (7.2) for**  $1 \le \kappa_1 < \kappa_2 \le m$ . Let  $\widetilde{\psi_j} := \psi_{j-1} + \psi_j + \psi_{j+1}$  so that  $\widetilde{\psi_j} * \psi_j = \psi_j$  and for each  $1 \le \kappa_1 < \kappa_2 \le m$  we define

$$\sigma_{j,1}^{\kappa_1,\kappa_2} := \left(\underbrace{\phi_j \otimes \cdots \otimes \phi_j}_{(\kappa_1 - 1) \text{ times}} \otimes \psi_j \otimes \underbrace{\phi_j \otimes \cdots \otimes \phi_j}_{(\kappa_2 - \kappa_1 - 1) \text{ times}} \otimes \psi_j \otimes \underbrace{\phi_j \otimes \cdots \otimes \phi_j}_{(m - \kappa_2) \text{ times}}\right)^{\wedge} \cdot \sigma_j,$$

$$\sigma_{j,1}^{\kappa_1,\kappa_2} := \left(\underbrace{\phi_j \otimes \cdots \otimes \phi_j \otimes \widetilde{\psi_j} \otimes$$

$$\sigma_{j,2}^{\kappa_1,\kappa_2} := \big(\underbrace{\phi_j \otimes \cdots \otimes \phi_j}_{(\kappa_1-1) \text{ times}} \otimes \widetilde{\psi_j} \otimes \underbrace{\phi_j \otimes \cdots \otimes \phi_j}_{(\kappa_2-\kappa_1-1) \text{ times}} \otimes \widetilde{\psi_j} \otimes \underbrace{\phi_j \otimes \cdots \otimes \phi_j}_{(m-\kappa_2) \text{ times}} \big)^{\wedge} \cdot \sigma_j.$$

Then both  $\sigma_{j,1}^{\kappa_1,\kappa_2}$  and  $\sigma_{j,1}^{\kappa_1,\kappa_2}$  can be expressed in the form

$$\Xi(\cdot/2^j)) \cdot \sigma_j$$

for some  $\Xi \in \mathcal{S}((\mathbb{R}^n)^m)$  whose support is in a ball of a constant radius in  $(\mathbb{R}^n)^m$ . We observe that, thanks to Lemma 2.5, for any  $1 < t < \infty$ 

(7.4) 
$$\|\Xi \cdot \sigma_j(2^j \cdot)\|_{L^t_{\vec{s}}((\mathbb{R}^n)^m)} \lesssim \|\sigma_j(2^j \cdot)\|_{L^t_{\vec{s}}((\mathbb{R}^n)^m)} \lesssim \mathcal{L}^t_{\vec{s}}[\sigma],$$

and

$$T_{\sigma_{i,1}^{\kappa_1,\kappa_2}} \vec{\boldsymbol{f}}$$

$$(7.5) = T_{\sigma_j}((f_1)^j, \dots, (f_{\kappa_1-1})^j, (f_{\kappa_1})_j, (f_{\kappa_1+1})^j, \dots (f_{\kappa_2-1})^j, (f_{\kappa_2})_j, (f_{\kappa_2+1})^j, \dots, (f_m)^j)$$

$$(7.6) = T_{\sigma_{i,2}^{\kappa_1,\kappa_2}}(f_1,\ldots,f_{\kappa_1-1},(f_{\kappa_1})_j,f_{\kappa_1+1},\ldots,f_{\kappa_2-1},(f_{\kappa_2})_j,f_{\kappa_2+1},\ldots,f_m).$$

Furthermore, if  $1 \le \kappa_1 < l + 1 < \kappa_2 \le m$ ,  $T_{\sigma_{i,1}^{\kappa_1,\kappa_2}} \vec{f}$  can be also written as

(7.7) 
$$T_{\sigma_{j,1}^{\kappa_1,\kappa_2}} \vec{f} = T_{\sigma_{j,2}^{\kappa_1,\kappa_2}} (f_1, \dots, f_{\kappa_1-1}, (f_{\kappa_1})_j, f_{\kappa_1+1}, \dots, f_{\kappa_2-1}, (f_{\kappa_2})_j, f_{\kappa_2+1}, \dots, f_m)$$

since  $\phi_{i+1} * \phi_i = \phi_i$ . Similarly, for  $l+1 < \kappa_1 < \kappa_2 \le m$ , we have

(7.8) 
$$T_{\sigma_{j,1}^{\kappa_1,\kappa_2}} \vec{f} = T_{\sigma_{j,2}^{\kappa_1,\kappa_2}} (f_1, \dots, f_l, (f_{l+1})^{j+1}, f_{l+2}, \dots, f_{l+2}, \dots,$$

Now we write, as in (6.4),

$$(7.9) T_{\sigma_{j,1}^{\kappa_1,\kappa_2}} \vec{f}(x) = \sum_{k_1=1}^{\infty} \cdots \sum_{k_l=1}^{\infty} \lambda_{1,k_1}, \dots, \lambda_{l,k_l} T_{\sigma_{j,1}^{\kappa_1,\kappa_2}} (a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m)(x)$$

where  $a_{i,k_i}$  are  $L^{\infty}$ -atoms for  $H^{p_i}$  satisfying (6.2) and (6.3). Then we apply the following lemma that will be proved in Section 9.

**Lemma 7.1.** Let  $1 < r \le 2$ ,  $1 \le l < \rho \le m$ , and let I, II, III, and  $\Lambda$  be defined as in (7.1). Suppose that  $0 < p_i \le 1$  for  $i \in I$ ,  $r \le p_i < \infty$  for  $i \in II$ , and  $1/p = 1/p_1 + \cdots + 1/p_\rho$ . Let  $a_i, i \in I$ , be atoms supported in the cube  $Q_i$  such that (6.7) holds for all  $|\alpha| < N_i$  with  $N_i$  sufficiently large. Suppose that (1.15) holds for all  $J \subset I$ . Let  $f_i \in L^{p_i}(\mathbb{R}^n)$  for  $i \in II$  and  $||f_i||_{L^{\infty}(\mathbb{R}^n)} = 1$  for  $i \in III$ . Then there exist nonnegative functions  $b_i, i \in I$ , and  $F_i, i \in II$ , on  $\mathbb{R}^n$  such that

(7.10) 
$$\sum_{j \in \mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa_1,\kappa_2}}(a_1,\ldots,a_l,f_{l+1},\ldots,f_m)(x) \right| \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \left( \prod_{i \in \mathbf{I}} b_i(x) \right) \left( \prod_{i \in \mathbf{II}} F_i(x) \right),$$

$$\|b_i\|_{L^{p_i}(\mathbb{R}^n)} \lesssim 1, \qquad \|F_i\|_{L^{p_i}(\mathbb{R}^n)} \lesssim \|f_i\|_{L^{p_i}(\mathbb{R}^n)}.$$

Lemma 7.1 proves the existence of functions  $b_{i,k_i}$  for  $i \in I$ ,  $k_i \in \mathbb{Z}$ , and  $F_i$  for  $i \in II$ , having the properties that

$$(7.11) \left| T_{\sigma_{j,1}^{\kappa_1,\kappa_2}} \left( a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m \right) (x) \right| \lesssim \mathcal{L}_{\vec{s}}^r [\sigma] \left( \prod_{i \in \mathbb{I}} b_{i,k_i}(x) \right) \left( \prod_{i \in \mathbb{I}} F_i(x) \right),$$

$$(7.12) ||b_{i,k_i}||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1, ||F_i||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}.$$

By using (7.5) and (7.9), the left-hand side of (7.2) is less than

$$\left\| \sum_{k_1=1}^{\infty} \cdots \sum_{k_l=1}^{\infty} |\lambda_{1,k_1}| \cdots |\lambda_{l,k_l}| \sum_{j \in \mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa_1,\kappa_2}}(a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m) \right| \right\|_{L^p(\mathbb{R}^n)}.$$

Then (7.11) and Hölder's inequality yield that the preceding expression is dominated by a constant times

$$\mathcal{L}^{r}_{\vec{s}}[\sigma] \Big( \prod_{i \in \mathbf{I}} \Big\| \sum_{k_{i}=1}^{\infty} |\lambda_{i,k_{i}}| b_{i,k_{i}} \Big\|_{L^{p_{i}}(\mathbb{R}^{n})} \Big) \Big( \prod_{i \in \mathbf{II}} \|F_{i}\|_{L^{p_{i}}(\mathbb{R}^{n})} \Big).$$

It is obvious that  $||F_i||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}$ , and we also have

$$\left\| \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}| b_{i,k_i} \right\|_{L^{p_i}(\mathbb{R}^n)} \leq \left( \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i} \|b_{i,k_i}\|_{L^{p_i}(\mathbb{R}^n)}^{p_i} \right)^{1/p_i} \lesssim \left( \sum_{k_i=1}^{\infty} |\lambda_{i,k_i}|^{p_i} \right)^{1/p_i} \lesssim \|f_i\|_{H^{p_i}(\mathbb{R}^n)}$$

having used (7.12). This proves (7.2).

7.2. **Proof of (7.3) for**  $1 \le \kappa \le m$ . Let  $\widetilde{\psi_j} := \psi_{j-1} + \psi_j + \psi_{j+1}$  as above, and for each  $1 \le \kappa \le m$  we define

$$\sigma_{j,1}^{\kappa} := \left(\underbrace{\phi_{j-4-\lfloor \log_2 m \rfloor} \otimes \cdots \otimes \phi_{j-4-\lfloor \log_2 m \rfloor}}_{(\kappa-1) \text{ times}} \otimes \psi_j \otimes \underbrace{\phi_{j-4-\lfloor \log_2 m \rfloor} \otimes \cdots \otimes \phi_{j-4-\lfloor \log_2 m \rfloor}}_{(m-\kappa) \text{ times}}\right)^{\wedge} \cdot \sigma_j.$$

$$\sigma_{j,2}^{\kappa} := \Big(\underbrace{\phi_{j-4-\lfloor \log_2 m \rfloor} \otimes \cdots \otimes \phi_{j-4-\lfloor \log_2 m \rfloor}}_{(\kappa-1) \text{ times}} \otimes \widetilde{\psi_j} \otimes \underbrace{\phi_{j-4-\lfloor \log_2 m \rfloor} \otimes \cdots \otimes \phi_{j-4-\lfloor \log_2 m \rfloor}}_{(m-\kappa) \text{ times}} \Big)^{\wedge} \cdot \sigma_j.$$

Then the argument in (7.4) yields that for any  $1 < t < \infty$ 

(7.13) 
$$\|\sigma_{j,1}^{\kappa}(2^{j}\cdot)\|_{L_{\vec{s}}^{t}((\mathbb{R}^{n})^{m})}, \|\sigma_{j,2}^{\kappa}(2^{j}\cdot)\|_{L_{\vec{s}}^{t}((\mathbb{R}^{n})^{m})} \lesssim \mathcal{L}_{\vec{s}}^{t}[\sigma].$$

Moreover, we note that

$$(7.14) T_{\sigma_{j,1}^{\kappa}} \vec{f} = T_{\sigma_j} ((f_1)^{j,m}, \dots, (f_{\kappa-1})^{j,m}, (f_{\kappa})_j, (f_{\kappa+1})^{j,m}, \dots, (f_m)^{j,m})$$

$$= T_{\sigma_{j,2}^{\kappa}} (f_1, \dots, f_{\kappa-1}, (f_{\kappa})_j, f_{\kappa+1}, \dots, f_m)$$

and if  $l+1 < \kappa \le m$ , it can be also written as

$$(7.15) T_{\sigma_{i_1}^{\kappa}} \vec{f} = T_{\sigma_{i_2}^{\kappa}} (f_1, \dots, f_l, (f_{l+1})^{j+1, m}, f_{l+2}, \dots, f_{\kappa-1}, (f_{\kappa})_j, f_{\kappa+1}, \dots, f_m)$$

since  $\phi_{j-3-|\log_2 m|} * \phi_{j-4-|\log_2 m|} = \phi_{j-4-|\log_2 m|}$ . Therefore, (7.3) is reduced to

(7.16) 
$$\left\| \left( \sum_{j \in \mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa}} \vec{f} \right|^2 \right)^{1/2} \right\|_{L^p(\mathbb{R}^n)} \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \prod_{i \in \mathbb{I} \cup \mathbb{I} \mathbf{I}} \|f_i\|_{H^{p_i}(\mathbb{R}^n)}.$$

Now we write, as in (6.4),

$$(7.17) T_{\sigma_{j,1}^{\kappa}} \vec{f}(x) = \sum_{k_1=1}^{\infty} \cdots \sum_{k_{l-1}=1}^{\infty} \lambda_{1,k_1}, \dots, \lambda_{l,k_l} T_{\sigma_{j,1}^{\kappa}} (a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m)(x)$$

where  $a_{i,k_i}$  are  $L^{\infty}$ -atoms for  $H^{p_i}$  satisfying (6.2) and (6.3). Then we need the following lemma whose proof will be given in Section 9.

**Lemma 7.2.** Let  $1 < r \le 2$ ,  $1 \le l < \rho \le m$ , and let I, II, III, and  $\Lambda$  be defined as in (7.1). Suppose that  $0 < p_i \le 1$  for  $i \in I$ ,  $r \le p_i < \infty$  for  $i \in II$ , and  $1/p = 1/p_1 + \cdots + 1/p_\rho$ . Let  $a_i$ ,  $i \in I$ , be atoms supported in the cube  $Q_i$  such that (6.7) holds for all  $|\alpha| < N_i$  with  $N_i$  sufficiently large. Suppose that (1.15) holds for all  $J \subset I$ . Let  $f_i \in L^{p_i}(\mathbb{R}^n)$  for  $i \in II$  and  $||f_i||_{L^{\infty}(\mathbb{R}^n)} = 1$  for  $i \in III$ . Then there exist nonnegative functions  $b_i$ ,  $i \in I$ , and  $F_i$ ,  $i \in II$ , on  $\mathbb{R}^n$  such that

$$(7.18) \qquad \Big(\sum_{j\in\mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa}} \left( a_1, \dots, a_l, f_{l+1}, \dots, f_m \right) (x) \right|^2 \Big)^{1/2} \lesssim \mathcal{L}_{\vec{s}}^r [\sigma] \Big( \prod_{i\in\mathcal{I}} b_i(x) \Big) \Big( \prod_{i\in\mathcal{I}} F_i(x) \Big),$$

$$\|b_i\|_{L^{p_i}(\mathbb{R}^n)} \lesssim 1, \qquad \|F_i\|_{L^{p_i}(\mathbb{R}^n)} \lesssim \|f_i\|_{L^{p_i}(\mathbb{R}^n)}.$$

According to the above lemma, we can choose nonnegative functions  $b_{i,k_i}$ ,  $i \in I$ , and  $F_i$ ,  $i \in II$ , such that

 $\left(\sum_{i \in \mathbb{Z}} \left| T_{\sigma_{j,1}^k} \left( a_{1,k_1}, \dots, a_{l,k_l}, f_{l+1}, \dots, f_m \right)(x) \right|^2 \right)^{1/2} \lesssim \mathcal{L}_{\vec{s}}^r [\sigma] \left( \prod_{i \in \mathbb{I}} b_{i,k_i}(x) \right) \left( \prod_{i \in \mathbb{I}} F_i(x) \right),$ 

$$(7.20) ||b_{i,k_i}||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1, ||F_i||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}.$$

Using (7.17), a triangle inequality in  $\ell^2$ , (7.19), and the Hölder inequality, the left-hand side of (7.16) is less than

$$\left\| \sum_{k_{1}=1}^{\infty} \cdots \sum_{k_{l}=1}^{\infty} |\lambda_{1,k_{1}}| \cdots |\lambda_{l,k_{l}}| \left( \sum_{j \in \mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa}} \left( a_{1,k_{1}}, \dots, a_{l,k_{l}}, f_{l+1}, \dots, f_{m} \right) \right|^{2} \right)^{1/2} \right\|_{L^{p}(\mathbb{R}^{n})}$$

$$\lesssim \mathcal{L}_{\vec{s}}^{r}[\sigma] \left\| \sum_{k_{1}=1}^{\infty} \cdots \sum_{k_{l}=1}^{\infty} |\lambda_{1,k_{1}}| \cdots |\lambda_{l,k_{l}}| \left( \prod_{i \in \mathbf{I}} b_{i,k_{i}} \right) \left( \prod_{i \in \mathbf{I}} F_{i} \right) \right\|_{L^{p}(\mathbb{R}^{n})}$$

$$\leq \mathcal{L}_{\vec{s}}^{r}[\sigma] \left( \prod_{i \in \mathbf{I}} \left\| \sum_{k_{i}=1}^{\infty} |\lambda_{i,k_{i}}| b_{i,k_{i}} \right\|_{L^{p_{i}}(\mathbb{R}^{n})} \right) \left( \prod_{i \in \mathbf{I}} \|F_{i}\|_{L^{p_{i}}(\mathbb{R}^{n})} \right).$$

This is clearly majored by the right-hand side of (7.16) and in view of (7.20) and the proof is concluded.

## 8. Proof of Proposition 1.7

The proof will be based on the following interpolation method for multilinear multipliers.

**Lemma 8.1.** Let 
$$1 < r \le 2$$
,  $0 < p_1^0, \ldots, p_m^0 \le \infty$ ,  $0 < p_1^1, \ldots, p_m^1 \le \infty$ ,  $1/p^0 = 1/p_1^0 + \cdots + 1/p_m^0$ , and  $1/p^1 = 1/p_1^1 + \cdots + 1/p_m^1$ . Let  $s_1^0, \ldots, s_m^0 \ge 0$  and  $s_1^1, \ldots, s_m^1 \ge 0$ . Suppose that

(8.1) 
$$||T_{\sigma}||_{H^{p_1^l} \times \cdots \times H^{p_m^l} \to L^{p^l}} \lesssim \mathcal{L}_{(s_1^l, \dots, s_m^l)}^{r, \Psi^{(m)}}[\sigma], \quad l = 0, 1.$$

Then for any  $0 < \theta < 1, 0 < p, p_1, \dots, p_m \le \infty$ , and  $s_1, \dots, s_m \ge 0$  satisfying

$$1/p = (1 - \theta)/p^0 + \theta/p^1$$
,  $1/p_k = (1 - \theta)/p_k^0 + \theta/p_k^1$  for  $1 \le k \le m$ ,  
 $s_k = (1 - \theta)s_k^0 + \theta s_k^1$  for  $1 \le k \le m$ ,

we have

(8.2) 
$$||T_{\sigma}||_{H^{p_1} \times \cdots \times H^{p_m} \to L^p} \lesssim \mathcal{L}_{(s_1, \dots, s_m)}^{r, \Psi^{(m)}}[\sigma].$$

*Proof.* Since the proof is more or less standard, we only provide a sketch of it.

Let  $\widetilde{\Psi^{(m)}} := 2^{-mn}\Psi(\vec{\cdot}/2) + \Psi^{(m)} + 2^{mn}\Psi^{(m)}(2\vec{\cdot})$  so that  $\widetilde{\Psi^{(m)}} * \Psi^{(m)} = \Psi^{(m)}$ . We construct a family of multilinear Fourier multipliers  $\sigma^z$  as

$$\sigma^{z}(\vec{\xi}) := \frac{(1+\theta)^{mn+1}}{(1+z)^{mn+1}} \sum_{j \in \mathbb{Z}} (I-\Delta_{1})^{-(s_{1}^{0}(1-z)+s_{1}^{1}z)/2} \cdots (I-\Delta_{m})^{-(s_{m}^{0}(1-z)+s_{m}^{1}z)/2}$$

$$\left( (I-\Delta_{1})^{s_{1}/2} \cdots (I-\Delta_{m})^{s_{m}/2} \left( \sigma(2^{j} \vec{\cdot}) \widehat{\Psi^{(m)}} \right) \right) (\vec{\xi}/2^{j}) \widehat{\widehat{\Psi^{(m)}}} (\vec{\xi}/2^{j}).$$

Note that  $\sigma^{\theta} = \sigma$  and it follows from the interpolation theorem for analytic families of operators that

$$||T_{\sigma}||_{H^{p_1} \times \dots \times H^{p_m} \to L^p} \le \left( \sup_{t \in \mathbb{R}} \mathcal{L}^{r, \Psi^{(m)}}_{(s_1^0, \dots, s_m^0)} [\sigma^{it}] \right)^{1-\theta} \left( \sup_{t \in \mathbb{R}} \mathcal{L}^{r, \Psi^{(m)}}_{(s_1^1, \dots, s_m^1)} [\sigma^{1+it}] \right)^{\theta}$$

by applying (8.1). We refer to [1, 2, 5, 20, 26] for more details.

We now observe that for each l = 0, 1, due to compact support conditions and Lemma 2.5,

$$\begin{split} \mathcal{L}_{(s_{1}^{l},\ldots,s_{m}^{l})}^{r,\Psi^{(m)}}[\sigma^{l+it}] &= \sup_{j \in \mathbb{Z}} \left\| \sigma^{l+it}(2^{j} \cdot) \widehat{\Psi^{(m)}} \right\|_{L_{(s_{1}^{l},\ldots,s_{m}^{l})}^{r}((\mathbb{R}^{n})^{m})} \\ &\lesssim \frac{1}{(1+|t|)^{mn+1}} \sup_{j \in \mathbb{Z}} \left\| (I-\Delta_{1})^{-it(s_{1}^{0}-s_{1}^{1})/2} \cdots (I-\Delta_{m})^{-it(s_{m}^{0}-s_{m}^{1})/2} \right. \\ & \qquad \\ & \left. (I-\Delta_{1})^{s_{1}/2} \cdots (I-\Delta_{m})^{s_{m}/2} \left( \sigma(2^{j} \cdot) \widehat{\Psi^{(m)}} \right) \right\|_{L^{r}((\mathbb{R}^{n})^{m})} \\ &\lesssim \mathcal{L}_{(s_{1},\ldots,s_{m})}^{r,\Psi^{(m)}}[\sigma] \end{split}$$

where we applied the Marcinkiewicz multiplier theorem in the last inequality. This proves (8.2).

We now state the following delicate interpolation result whose proof is based on that of [14, Lemma 3.7].

**Lemma 8.2.** Let 
$$1 < r \le 2$$
,  $m \in \mathbb{N}$  and  $0 < p_1, \dots, p_m \le \infty$ . For  $\vec{p} := (p_1, \dots, p_m)$  let  $\Gamma_m(\vec{p}) := \left\{ \vec{s} : \sum_{k \in I} (s_k/n - 1/p_k) \ge -1/r' \text{ for any } J \subset \{1, \dots, m\} \right\}$ 

and for each  $1 \le u \le m$  define

$$\Lambda_m^u(\vec{p}) := \{ \vec{s} : s_u \ge n/p_u - n/r', \quad s_i \ge n/p_i \text{ for all } i \ne u \}.$$

Then  $\Gamma_m(\vec{p})$  is the convex hull of  $\Lambda_m^u(\vec{p})$  for  $1 \le u \le m$ .

*Proof.* Let  $H_m(\vec{p})$  be the convex hull of  $\Lambda_m^u(\vec{p})$  for  $1 \leq u \leq m$  and then we need to show that  $H_m(\vec{p}) = \Gamma_m(\vec{p})$ .

We first note that  $\Gamma_m(\vec{p})$  is convex as it is the intersection of  $2^m - 1$  convex sets. Since  $\Gamma_m(\vec{p})$  contains  $\Lambda_m^u(\vec{p})$  for all  $1 \leq u \leq m$ , it is clear that  $H_m(\vec{p}) \subset \Gamma_m(\vec{p})$ .

We now verify  $\Gamma_m(\vec{p}) \subset H_m(\vec{p})$ . For this one we restrict the size of  $s_i$ ,  $1 \leq i \leq m$ . Let M be a sufficiently large number such that  $M > mn(1/p_1 + \cdots + 1/p_m)$  and let

$$\Gamma_m^M(\vec{p}) := \Gamma_m(\vec{p}) \cap \left\{ \vec{s} : s_i \leq M \ 1 \leq i \leq m \right\},$$
  
$$\Lambda_m^{u,M}(\vec{p}) := \Lambda_m^u(\vec{p}) \cap \left\{ \vec{s} : s_i \leq M \ 1 \leq i \leq m \right\},$$
  
$$H_m^M(\vec{p}) := H_m(\vec{p}) \cap \left\{ \vec{s} : s_i \leq M \ 1 \leq i \leq m \right\},$$

and we actually prove that

(8.3) 
$$\Gamma_m^M(\vec{p}) \subset H_m^M(\vec{p}) \quad \text{for all } 0 < p_1, \dots, p_m \le \infty,$$

from which we obtain the desired result by taking  $M \to \infty$ . We use an induction argument beginning with the case m = 2.

When m=2, it is trivial because  $\Gamma_2^M(\vec{p})$  is the convex hull of the five points (M,M),  $(n/p_1-n/r',M)$ ,  $(n/p_1-n/r',n/p_2)$ ,  $(n/p_1,n/p_2-n/r')$ , and  $(M,n/p_2-n/r')$ .

Now we fix m > 2 and assume that (8.3) holds with m replaced by m - 1. We denote

$$\Gamma_m^{0,M}(\vec{p}) := \left\{ \vec{s} \in \Gamma_m^M(\vec{p}) : n/p_l - n/r' \le s_l \le n/p_l \text{ for all } 1 \le l \le m \right\},$$
$$\Gamma_m^{l,M}(\vec{p}) := \left\{ \vec{s} \in \Gamma_m^M(\vec{p}) : n/p_l \le s_l \le M \right\}, \qquad 1 \le l \le m.$$

It is easy to see that  $\Gamma_m^M(\vec{p}) = \bigcup_{l=0}^m \Gamma_m^{l,M}(\vec{p})$  and thus it is enough to show that

(8.4) 
$$\Gamma_m^{0,M}(\vec{p}) \subset H_m^M(\vec{p}),$$

(8.5) 
$$\Gamma_m^{l,M}(\vec{p}) \subset H_m^M(\vec{p}) \quad \text{for all } 1 \le l \le m.$$

We note that  $\Gamma_m^{0,M}(\vec{p})$  is the intersection of the two sets

$$\{\vec{s}: n/p_l - n/r' \le s_l \le n/p_l \text{ for all } 1 \le l \le m\}$$

and

$$\{\vec{s}: s_1 + \dots + s_m \ge n/p_1 + \dots + n/p_m - n/r'\},\$$

which would be a standard m-simplex with the m+1 vertices

$$(n/p_1,\ldots,n/p_m), (n/p_1-n/r',n/p_2,\ldots,n/p_m), \ldots, (n/p_1,\ldots,n/p_{m-1},n/p_m-n/r').$$

Since the vertices of the simplex are contained in the convex set  $H_m^M(\vec{p})$ , (8.4) holds.

To achieve (8.5) we consider only the case l=m as the other cases will follow from a rearrangement. We additionally define

$$\Gamma_{m,1}^{m,M}(\vec{\boldsymbol{p}}) := \left\{ \vec{\boldsymbol{s}} \in \Gamma_m^M(\vec{\boldsymbol{p}}) : s_m = n/p_m \right\}, \quad \Gamma_{m,2}^{m,M}(\vec{\boldsymbol{p}}) := \left\{ \vec{\boldsymbol{s}} \in \Gamma_m^M(\vec{\boldsymbol{p}}) : s_m = M \right\}$$

and then (8.5) with l = m follows once we prove

(8.6) 
$$\Gamma_{m,1}^{m,M}(\vec{p}), \Gamma_{m,2}^{m,M}(\vec{p}) \subset H_m^M(\vec{p})$$

as  $H_m^M(\vec{p})$  is a convex set. Therefore, let us prove (8.6). For simplicity, we denote  $\vec{p}^{*m} := (p_1, \ldots, p_{m-1})$  and  $\vec{s}^{*m} := (s_1, \ldots, s_{m-1})$  so that  $\vec{p} = (\vec{p}^{*m}, p_m)$  and  $\vec{s} = (\vec{s}^{*m}, s_m)$ . We observe that

$$\Gamma_{m,1}^{m,M}(\vec{p}) = \{ \vec{s} : \vec{s}^{*m} \in \Gamma_{m-1}^{M}(\vec{p}^{*m}), \ s_m = n/p_m \}.$$

By using the induction hypothesis on m-1, we obtain

$$\Gamma_{m,1}^{m,M}(\vec{p}) \subset \left\{ \vec{s} : \vec{s}^{*m} \in H_{m-1}^{M}(\vec{p}^{*m}), \ s_m = n/p_m \right\}$$

where the right-hand side is the convex hull of the sets

$$\left\{\vec{\boldsymbol{s}}: \vec{\boldsymbol{s}}^{*m} \in \Lambda_{m-1}^{u}(\vec{\boldsymbol{p}}^{*m}), \ s_m = n/p_m\right\} \subset \Lambda_m^{u}(\vec{\boldsymbol{p}}), \quad 1 \leq u \leq m-1.$$

From the definition of  $H_m^M(\vec{p})$ , it follows that  $\Gamma_{m,1}^{m,M}(\vec{p}) \subset H_m^M(\vec{p})$ . Similarly, we have

$$\Gamma_{m,2}^{m,M}(\vec{\boldsymbol{p}}) \subset \left\{ \vec{\boldsymbol{s}} : \vec{\boldsymbol{s}}^{*m} \in H_{m-1}^{M}(\vec{\boldsymbol{p}}^{*m}), \ s_m = M \right\} \subset H_m^{M}(\vec{\boldsymbol{p}})$$

because  $M > n/p_m$  is sufficiently large. This proves (8.6).

Now we prove Proposition 1.7 by induction.

Assume l = 1 and treat only the case

$$1 < p_1 < r, \quad 0 < p_2, \dots, p_{\rho} \le 1, \quad r \le p_{\rho+1}, \dots, p_m \le \infty.$$

In this case, condition (1.8) is equivalent to

$$s_1, s_{\rho+1}, \dots, s_m > n/r$$
, and  $\sum_{k \in J} (s_k/n - 1/p_k) > -1/r'$ 

for all nonempty subsets  $J \subset \{1, \dots, \rho\}$ . Then Lemma 8.2 yields that  $\vec{s}$  satisfying the above conditions belongs to one of the following sets

$$\mathfrak{S}_{u} := \{ \vec{s} : s_{u} > n/p_{u} - n/r', \quad s_{i} > n/p_{i} \text{ for } i \neq u, \ 1 \leq i \leq \rho \}$$

$$\cap \{ \vec{s} : s_{1}, s_{\rho+1}, \dots, s_{m} > n/r \}, \quad 1 \leq u \leq \rho,$$

$$\mathfrak{S}_{0} := \{ \vec{s} = \theta_{1} \vec{s}_{1} + \dots + \theta_{\rho} \vec{s}_{\rho} : \theta_{1} + \dots + \theta_{\rho} = 1, \ 0 < \theta_{i} < 1, \ \vec{s}_{i} \in \mathfrak{S}_{i}, \ 1 \leq i \leq \rho \}.$$

It suffices to show that for  $1 \le u \le \rho$ ,  $\vec{s} \in \mathfrak{S}_u$  implies (1.9) because the case when  $\vec{s} \in \mathfrak{S}_0$  can be proved by using Lemma 8.1 at most  $\rho - 1$  times. If  $\vec{s} \in \mathfrak{S}_1$ , then the assumptions in Lemma 8.1 hold with

$$(p_1^0, \dots, p_m^0) = (1, p_2, \dots, p_m), \quad (s_1^0, \dots, s_m^0) = (s_1, \dots, s_m)$$

and

$$(p_1^1, \dots, p_m^1) = (r, p_2, \dots, p_m), \quad (s_1^0, \dots, s_m^0) = (s_1, \dots, s_m),$$

due to Proposition 1.4, 1.5, and 1.6, and now (1.9) follows from Lemma 8.1. Note that  $s_1 > n/r = n - n/r'$ .

If  $\vec{s} \in \mathfrak{S}_u$  for  $2 \le u \le \rho$ , then we choose  $0 < \theta < 1$  such that

$$s_1 > n/p_1 = (1 - \theta)n + \theta n/r.$$

We also select  $t^0 > n$  and  $t^1 > n/r$  satisfying  $s_1 = (1 - \theta)t^0 + \theta t^1$ . Then we interpolate between the two cases

$$(p_1^0, \dots, p_m^0) = (1, p_2, \dots, p_m), \quad (s_1^0, \dots, s_m^0) = (t^0, s_2, \dots, s_m)$$

and

$$(p_1^1, \dots, p_m^1) = (r, p_2, \dots, p_m), \quad (s_1^1, \dots, s_m^1) = (t^1, s_2, \dots, s_m)$$

using Lemma 8.1. Here, the assumptions in Lemma 8.1 with the above two cases follow from Proposition 1.4, 1.5, and 1.6. This finally yields (1.9).

We now consider the cases  $l \geq 2$  and suppose, by induction, that the claimed assertion holds for  $|\mathfrak{L}| = l - 1$ . Without loss of generality, we may assume that  $1 < p_1, \ldots, p_l < r$ ,  $0 < p_{l+1}, \ldots, p_{\rho} \leq 1$ , and  $r \leq p_{\rho+1}, \ldots, p_m \leq \infty$ , and accordingly, we have

$$s_1, \dots, s_l, s_{\rho+1}, \dots, s_m > n/r,$$
 and  $\sum_{k \in J} (s_k/n - 1/bp_k) > -1/r'$ 

for any nonempty subset  $J \subset \{1, \dots, \rho\}$ . Similarly as in the case l = 1, we need to handle only the case that for  $1 \le u \le \rho$ 

$$s_1, \ldots, s_l, s_{\rho+1}, \ldots, s_m > n/r,$$
  $s_u > n/p_u - n/r', \ s_i > n/p_i \ \text{for} \ i \neq u, \ 1 \leq i \leq \rho.$ 

Since  $l \geq 2$ , we may choose  $1 \leq v \leq l$  such that  $v \neq u$ . Clearly,

$$(8.7) s_v > n/p_v (> n/r)$$

since  $1 < p_v < r$ , and  $s_u > \max(n/p_u - n/r', n/r)$ . Let  $0 < \theta < 1$  be the number satisfying  $1/p_v = (1 - \theta) + \theta/r$  and then there exist  $t^0 > n$  and  $t^1 > n/r$  so that  $s_v = (1 - \theta)t^0 + \theta t^1$  because of (8.7). We apply the induction hypothesis to obtain the boundedness with

$$(p_1^0, \dots, p_m^0) = (p_1, \dots, p_{v-1}, 1, p_{v+1}, \dots, p_m), (s_1^0, \dots, s_m^0) = (s_1, \dots, s_{v-1}, t^0, s_{v+1}, \dots, s_m)$$

and another one with

$$(p_1^1, \dots, p_m^1) = (p_1, \dots, p_{v-1}, r, p_{v+1}, \dots, p_m), (s_1^0, \dots, s_m^0) = (s_1, \dots, s_{v-1}, t^1, s_{v+1}, \dots, s_m).$$

Since these are the assumptions in Lemma 8.1, (1.9) holds as a result of the lemma. This completes the proof of Proposition 1.7.

#### 9. Proofs of the key Lemmas

9.1. **Proof of Lemma 4.1.** Let  $1 \le l \le m$ . The sufficiently large number M > 0 shall be chosen later. We utilize an argument of the Marcinkiewicz multiplier theorem. Indeed, we will actually show that for any multi-indices  $\alpha_{(1)}, \ldots, \alpha_{(l)}$  in  $\mathbb{Z}^n$  with  $|\alpha_{(j)}| \le n/2 + 1$  for  $1 \le j \le l$ ,

$$(9.1) |\partial_1^{\alpha_{(1)}} \cdots \partial_l^{\alpha_{(l)}} \mathcal{N}_{(M)}(y_1, \dots, y_l)| \lesssim_{\alpha_{(1)}, \dots, \alpha_{(l)}} |y_1|^{-|\alpha_{(1)}|} \cdots |y_l|^{-|\alpha_{(l)}|}$$

We first observe that

$$(9.2) \quad \left| \partial_{1}^{\alpha_{(1)}} \cdots \partial_{l}^{\alpha_{(l)}} \mathcal{N}_{(M)}(y_{1}, \dots, y_{l}) \right| \lesssim \sum_{u=1}^{l} \sum_{\alpha_{(u)}^{1} + \dots + \alpha_{(u)}^{l+1} = \alpha_{(u)}} \left| \partial_{1}^{\alpha_{(1)}^{1}} \cdots \partial_{l}^{\alpha_{(l)}^{l}} \left\langle \frac{1}{l} \sum_{k=1}^{l} y_{k} \right\rangle^{s_{1}} \right|$$

$$\times \left( \prod_{j=2}^{l} \left| \partial_{1}^{\alpha_{(1)}^{j}} \cdots \partial_{l}^{\alpha_{(l)}^{j}} \left\langle \frac{1}{l} \sum_{k=1}^{l} (y_{k} - y_{j}) \right\rangle^{s_{j}} \right| \right)$$

$$\times \left| \partial_{1}^{\alpha_{(1)}^{l+1}} \langle y_{1} \rangle^{-(s_{1} + \dots + s_{l})} \right| \left( \prod_{j=2}^{l} \left| \partial_{j}^{\alpha_{(j)}^{l+1}} \langle y_{j} \rangle^{-M} \right| \right).$$

Using the argument in [8, p450], we obtain that

$$\left| \partial_{1}^{\alpha_{(1)}^{1}} \cdots \partial_{l}^{\alpha_{(l)}^{l}} \left\langle \frac{1}{l} \sum_{k=1}^{l} y_{k} \right\rangle^{s_{1}} \right| \lesssim \left\langle \frac{1}{l} \sum_{k=1}^{l} y_{k} \right\rangle^{s_{1} - (|\alpha_{(1)}^{1}| + \dots + |\alpha_{(l)}^{1}|)},$$

$$\left| \partial_{1}^{\alpha_{(1)}^{j}} \cdots \partial_{l}^{\alpha_{(l)}^{j}} \left\langle \frac{1}{l} \sum_{k=1}^{l} (y_{k} - y_{j}) \right\rangle^{s_{j}} \right| \lesssim \left\langle \frac{1}{l} \sum_{k=1}^{l} (y_{k} - y_{j}) \right\rangle^{s_{j} - (|\alpha_{(1)}^{j}| + \dots + |\alpha_{(l)}^{j}|)},$$

$$\left| \partial_{1}^{\alpha_{(1)}^{l+1}} \left\langle y_{1} \right\rangle^{-(s_{1} + \dots + s_{l})} \right| \lesssim \left\langle y_{1} \right\rangle^{-(s_{1} + \dots + s_{l} + |\alpha_{(1)}^{l+1}|)},$$

$$\left| \partial_{j}^{\alpha_{(j)}^{l+1}} \left\langle y_{j} \right\rangle^{-M} \right| \lesssim \left\langle y_{j} \right\rangle^{-(M + |\alpha_{(j)}^{l+1}|)}.$$

We choose a positive number N such that  $M > N + n + 2 > s_1 + \cdots + s_l + n + 2$ . Since

$$\frac{\left\langle \frac{1}{l} \sum_{k=1}^{l} y_k \right\rangle^{s_1} \prod_{j=2}^{l} \left\langle \frac{1}{l} \sum_{k=1}^{l} (y_k - y_j) \right\rangle^{s_j}}{\langle y_1 \rangle^{s_1 + \dots + s_l} \prod_{j=2}^{l} \langle y_j \rangle^N} \lesssim 1,$$

we finally obtain that the right-hand side of (9.2) is dominated by a constant times the product of

$$I_{1} := \left\langle \frac{1}{l} \sum_{k=1}^{l} y_{k} \right\rangle^{-(|\alpha_{(1)}^{1}| + \dots + |\alpha_{(l)}^{1}|)}, \qquad I_{2} := \prod_{j=2}^{l} \left\langle \frac{1}{l} \sum_{k=1}^{l} (y_{k} - y_{j}) \right\rangle^{-(|\alpha_{(1)}^{j}| + \dots + |\alpha_{(l)}^{j}|)},$$

$$I_{3} := \left\langle y_{1} \right\rangle^{-|\alpha_{(1)}^{l+1}|}, \qquad I_{4} := \prod_{j=2}^{l} \left\langle y_{j} \right\rangle^{-(M-N+|\alpha_{(j)}^{l+1}|)}.$$

If  $|y_1| > 2l|y_j|$  for all  $2 \le j \le l$ , then

$$I_1 \lesssim \langle y_1 \rangle^{-|\alpha_{(1)}^1|}$$
 and  $I_2 \lesssim \prod_{j=2}^l \langle y_1 \rangle^{-|\alpha_{(1)}^j|}$ ,

which implies that

$$I_1 \times I_2 \times I_3 \times I_4 \lesssim \langle y_1 \rangle^{-|\alpha_{(1)}|} \prod_{j=2}^{l} \langle y_j \rangle^{-(M-N)} \lesssim |y_1|^{-|\alpha_{(1)}|} \cdots |y_l|^{-|\alpha_{(l)}|}$$

for M - N > n + 2 > n/2 + 1.

Now assume that  $|y_1| \leq 2l \max(|y_2|, \ldots, |y_l|)$  and actually, only the case  $|y_1| \leq 2l|y_2|$  will be considered. In that case, we see that

$$I_1 \times I_2 \times I_3 \times I_4 \le I_4 \lesssim \langle y_1 \rangle^{-|\alpha_{(1)}|} \langle y_2 \rangle^{-(M-N-|\alpha_{(1)}|)} \prod_{j=3}^l \langle y_j \rangle^{-(M-N)}$$
$$\lesssim |y_1|^{-|\alpha_{(1)}|} \cdots |y_l|^{-|\alpha_{(l)}|}$$

for  $M-N \ge M-N - |\alpha_{(1)}| > n+2-|\alpha_{(1)}| \ge |\alpha_{(j)}|$  for  $2 \le j \le l$ . This proves (9.1).

9.2. **Proof of Lemma 6.1.** Without loss of generality, we assume that  $J_0 = \{1, \ldots, v\}$  for some  $1 \le v \le l$ , and  $||f_i||_{L^{\infty}(\mathbb{R}^n)} = 1$  for all  $l + 1 \le i \le m$ . Fix

$$x \in \Big(\bigcap_{i=v+1}^{l} Q_i^*\Big) \setminus \Big(\bigcup_{i=1}^{v} Q_i^*\Big).$$

(When v = l, just fix  $x \in \mathbb{R}^n \setminus (\bigcup_{i=1}^l Q_i^*)$ .) Now we write

$$T_{\sigma}(a_1,\ldots,a_l,f_{l+1},\ldots,f_m)(x) = \sum_{j\in\mathbb{Z}} g_j(x),$$

where

$$(9.3) g_j(x) := \int_{(\mathbb{R}^n)^m} 2^{jmn} K_j(2^j(x-y_1), \dots, 2^j(x-y_m)) \Big( \prod_{i=1}^l a_i(y_i) \Big) \Big( \prod_{i=l+1}^m f_i(y_i) \Big) d\vec{\boldsymbol{y}}$$

with  $K_j := (\sigma(2^j \cdot) \widehat{\Psi^{(m)}})^{\vee}$ . Let  $c_i$  be the center of the cube  $Q_i$   $(1 \le i \le l)$ . For  $1 \le i \le v$ , since  $x \notin Q_i^*$ , we have  $|x - c_i| \approx |x - y_i|$  for all  $y_i \in Q_i$ . Fix  $1 \le k \le v$  and for  $1 \le u \le w \le m$  denote

$$K_j^{(u,w)}(x,\vec{y}) := K_j(y_1,\ldots,y_{u-1},2^j(x-y_u),\ldots,2^j(x-y_w),y_{w+1},\ldots,y_m)$$

for convenience of notation. We see that

$$\left(\prod_{i=1}^{v} \langle 2^{j}(x-c_{i})\rangle^{s_{i}}\right) |g_{j}(x)|$$

$$\lesssim 2^{jmn} \left(\prod_{i=1}^{l} ||a_{i}||_{L^{\infty}(\mathbb{R}^{n})}\right) \int_{Q_{1}\times\cdots\times Q_{l}\times(\mathbb{R}^{n})^{m-l}} \left(\prod_{i=1}^{v} \langle 2^{j}(x-y_{i})\rangle^{s_{i}}\right) |K_{j}^{(1,m)}(x,\vec{\boldsymbol{y}})| d\vec{\boldsymbol{y}}$$

and the integral in the preceding expression is less than

$$\int_{Q_{1}\times\cdots\times Q_{v}\times(\mathbb{R}^{n})^{m-v}} \left( \prod_{i=1}^{v} \langle 2^{j}(x-y_{i})\rangle^{s_{i}} \right) |K_{j}^{(1,m)}(x,\vec{\boldsymbol{y}})| d\vec{\boldsymbol{y}}$$

$$= 2^{-jn(m-v)} \int_{Q_{1}\times\cdots\times Q_{v}\times(\mathbb{R}^{n})^{m-v}} \left( \prod_{i=1}^{v} \langle 2^{j}(x-y_{i})\rangle^{s_{i}} \right) |K_{j}^{(1,v)}(x,\vec{\boldsymbol{y}})| d\vec{\boldsymbol{y}}$$

$$\leq 2^{-jn(m-v)} \left( \prod_{i=1}^{v} |Q_{i}| \right) \int_{(\mathbb{R}^{n})^{m-v}} \left[ \int_{y_{k}\in Q_{k}} |Q_{k}|^{-1} \langle 2^{j}(x-y_{k})\rangle^{s_{k}}$$

$$\times \left\| \left( \prod_{\substack{i=1\\i\neq k}}^{v} \langle y_{i}\rangle^{s_{i}} \right) K_{j}^{(k,k)}(x,\vec{\boldsymbol{y}}) \right\|_{L^{\infty}(y_{1},\ldots,y_{k-1},y_{k+1},\ldots,y_{v})} dy_{k} \right] dy_{v+1} \cdots dy_{m}.$$

Using Lemma 2.9, the integral in the last expression is majored by a constant multiple of

$$2^{-jn(m-v)} \left( \prod_{i=1}^{v} |Q_i| \right) \int_{y_k \in Q_k} |Q_k|^{-1} \langle 2^j (x - y_k) \rangle^{s_k}$$

$$\times \left[ \int_{(\mathbb{R}^n)^{m-v}} \left\| \left( \prod_{\substack{i=1 \ j \neq k}}^{v} \langle y_i \rangle^{s_i} \right) K_j^{(k,k)} (x, \vec{\boldsymbol{y}}) \right\|_{L^{r'}(y_1, \dots, y_{k-1}, y_{k+1}, \dots, y_v)} dy_{v+1} \cdots dy_m \right] dy_k$$

and this is further estimated by

$$2^{-jn(m-v)} \left( \prod_{i=1}^{v} |Q_i| \right) \int_{y_k \in Q_k} |Q_k|^{-1} \langle 2^j (x - y_k) \rangle^{s_k}$$

$$\times \left\| \left( \prod_{\substack{i=1\\i \neq k}}^m \langle y_i \rangle^{s_i} \right) K_j^{(k,k)} (x, \vec{\boldsymbol{y}}) \right\|_{L^{r'}(y_1, \dots, y_{k-1}, y_{k+1}, \dots, y_m)} dy_k,$$

by applying Hölder's inequality, as  $s_i > n/r$  for  $v + 1 \le i \le m$ . We finally obtain

$$(9.4) \qquad \left(\prod_{i=1}^{v} \langle 2^{j}(x-c_{i})\rangle^{s_{i}}\right) |g_{j}(x)| \leq 2^{jvn} \left(\prod_{i=1}^{v} |Q_{i}|^{1-1/p_{i}}\right) \left(\prod_{i=v+1}^{l} b_{i}(x)\right) h_{j}^{(k,0)}(x),$$

where  $b_i(x) := |Q_i|^{-1/p_i} \chi_{Q_i^*}(x)$  for  $v + 1 \le i \le l$  and

$$h_j^{(k,0)}(x) := \frac{1}{|Q_k|} \int_{Q_k} \langle 2^j (x - y_k) \rangle^{s_k} \left\| \left( \prod_{\substack{i=1\\i \neq k}}^m \langle y_i \rangle^{s_i} \right) K_j^{(k,k)} (x, \vec{\boldsymbol{y}}) \right\|_{L^{r'}(y_1, \dots, y_{k-1}, y_{k+1}, \dots, y_m)} dy_k.$$

The functions  $b_i$ ,  $v+1 \leq i \leq l$ , obviously satisfy the estimate  $||b_i||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1$ , and the Minkowski inequality with  $1 < r' < \infty$  gives

$$\|h_{j}^{(k,0)}\|_{L^{r'}(\mathbb{R}^{n})} \leq \frac{1}{|Q_{k}|} \int_{Q_{k}} \left( \int_{\mathbb{R}^{n}} \langle 2^{j}(x-y_{k}) \rangle^{r's_{k}} \| \cdots \|_{L^{r'}((\mathbb{R}^{n})^{m-1})}^{r'} dx \right)^{1/r'} dy_{k}$$

$$\lesssim 2^{-jn/r'} \| \left( \prod_{i=1}^{m} \langle \cdot_{i} \rangle^{s_{i}} \right) K_{j} \|_{L^{r'}((\mathbb{R}^{n})^{m})} \lesssim 2^{-jn/r'} \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma]$$

where we made use of a change of variables and applied the Hausdorff-Young inequality in the preceding inequalities. On the other hand, using the vanishing moment condition of  $a_k$  and Lemma 2.8, we write

$$|g_{j}(x)| \lesssim 2^{jmn} \sum_{|\alpha|=N_{k}+1} \int_{0}^{1} \int_{(\mathbb{R}^{n})^{m}} (2^{j} |y_{k} - c_{k}|)^{N_{k}+1} \Big( \prod_{i=1}^{l} |a_{i}(y_{i})| \Big)$$

$$\times \left| \partial_{k}^{\alpha} K_{j} (2^{j} (x - y_{1}), \dots, 2^{j} (x - y_{k-1}), 2^{j} x_{c_{k}, y_{k}}^{t}, 2^{j} (x - y_{k+1}), \dots, 2^{j} (x - y_{m})) \right| d\vec{\boldsymbol{y}} dt$$

where  $x_{c_k,y_k}^t := x - c_k - t(y_k - c_k)$  and  $\partial_k^{\alpha} K_j(z_1,\ldots,z_m) := \partial_{z_k}^{\alpha} K_j(z_1,\ldots,z_m)$ . Notice that  $|x_{c_k,y_k}^t| \approx |x - c_k|$  for  $x \notin Q_k^*$ ,  $y_k \in Q_k$ , and 0 < t < 1. Repeating the preceding argument that is used to establish (9.4), we also obtain

$$(9.6) \qquad \Big(\prod_{i=1}^{v} \langle 2^{j}(x-c_{i}) \rangle^{s_{i}} \Big) |g_{j}(x)| \lesssim 2^{jvn} \Big(\prod_{i=1}^{v} |Q_{i}|^{1-1/p_{i}} \Big) \Big(\prod_{i=v+1}^{l} b_{i}(x) \Big) h_{j}^{(k,1)}(x),$$

where  $b_i(x) := |Q_i|^{-1/p_i} \chi_{Q_i^*}(x)$  as before, and

$$h_{j}^{(k,1)}(x) := (2^{j}l(Q_{k}))^{N_{k}+1} \sum_{|\alpha|=N_{k}+1} \frac{1}{|Q_{k}|} \int_{0}^{1} \int_{Q_{k}} \langle 2^{j} x_{c_{k},y_{k}}^{t} \rangle^{s_{k}}$$

$$\times \left\| \left( \prod_{\substack{i=1\\ i \neq k}}^{m} \langle \cdot_{i} \rangle^{s_{i}} \right) \partial_{k}^{\alpha} K_{j}(\cdot_{1}, \dots, \cdot_{k-1}, 2^{j} x_{c_{k},y_{k}}^{t}, \cdot_{k+1}, \dots, \cdot_{m}) \right\|_{L^{r'}((\mathbb{R}^{n})^{m-1})} dy_{k} dt.$$

Now Minkowski's inequality and Lemma 2.9 yield that

(9.7) 
$$||h_j^{(k,1)}||_{L^{r'}(\mathbb{R}^n)} \lesssim 2^{-\frac{jn}{r'}} (2^j l(Q_k))^{N_k + 1} \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma].$$

which is the counterpart of (9.5) for  $h_j^{(k,1)}$ .

Combining (9.4) and (9.6), we obtain

$$(9.8) |g_j(x)| \lesssim 2^{jvn} \Big( \prod_{i=1}^v |Q_i|^{1-1/p_i} \langle 2^j(x-c_i) \rangle^{-s_i} \Big) \Big( \prod_{i=v+1}^l b_i(x) \Big) \min \Big( h_j^{(k,0)}(x), h_j^{(k,1)}(x) \Big)$$

for all  $x \in \left(\bigcap_{i=v+1}^l Q_i^*\right) \setminus \left(\bigcup_{i=1}^v Q_i^*\right)$  and all  $1 \le k \le v$ . Now we will construct nonnegative functions  $u_{i,j}$  for  $1 \le i \le v$  such that

$$|g_j(x)| \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \Big(\prod_{i=1}^v u_{i,j}(x)\Big) \Big(\prod_{i=v+1}^l b_i(x)\Big)$$

for all  $x \in \left(\bigcap_{i=v+1}^l Q_i^*\right) \setminus \left(\bigcup_{i=1}^v Q_i^*\right)$  and

(9.9) 
$$\left\| \sum_{j \in \mathbb{Z}} u_{i,j} \right\|_{L^{p_i}(\mathbb{R}^n)} \lesssim 1.$$

Then the lemma follows by taking

$$(9.10) b_i := \sum_{j \in \mathbb{Z}} u_{i,j} \quad 1 \le i \le v.$$

For this, we choose  $\lambda_i$ ,  $1 \le i \le v$ , such that

$$0 \le \lambda_i < 1/r', \quad s_i/n > 1/p_i - 1/r' + \lambda_i, \quad \sum_{i=1}^v \lambda_i = (v-1)/r'.$$

This is possible since the second condition in (1.15), with  $J \subset \{1, \dots, v\}$ , yields

$$\sum_{i=1}^{v} \min (0, s_i/n - 1/p_i) > -1/r',$$

which further implies

$$\sum_{i=1}^{v} \min (1/r', s_i/n - 1/p_i + 1/r') > (v-1)/r'.$$

We set

(9.11) 
$$\alpha_i := 1/p_i - 1/r' + \lambda_i \quad \text{and} \quad \beta_i := 1 - r'\lambda_i.$$

Then we have  $\alpha_i > 0$ ,  $\beta_i > 0$ , and  $\sum_{i=1}^{v} \beta_i = 1$ . Letting

$$u_{i,j}(x) := \left(\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma]\right)^{-\beta_i} 2^{jn} |Q_i|^{1-1/p_i} \langle 2^j(x-c_i) \rangle^{-s_i} \chi_{(Q_i^*)^c}(x) \min\left(h_j^{(i,0)}(x), h_j^{(i,1)}(x)\right)^{\beta_i}$$

for  $1 \le i \le v$ , it is easy to see, from (9.8), that

$$(9.12) |g_j(x)| \lesssim \mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma] \Big( \prod_{i=1}^v u_{i,j}(x) \Big) \Big( \prod_{i=v+1}^l b_i(x) \Big)$$

for all  $x \in (\bigcap_{i=v+1}^l Q_i^*) \setminus (\bigcup_{i=1}^v Q_i^*)$ .

It remains to verify (9.9). Since  $1/p_i = \alpha_i + \beta_i/r'$ , Hölder's inequality yields

$$||u_{i,j}||_{L^{p_i}(\mathbb{R}^n)} \le \left(\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma]\right)^{-\beta_i} 2^{jn} |Q_i|^{1-1/p_i} ||\langle 2^j(\cdot - c_i)\rangle^{-s_i} \chi_{(Q_i^*)^c}||_{L^{1/\alpha_i}(\mathbb{R}^n)} \times \min\left(||h_j^{(i,0)}||_{L^{r'}(\mathbb{R}^n)}^{\beta_i}, ||h_j^{i,1}||_{L^{r'}(\mathbb{R}^n)}^{\beta_i}\right).$$

We observe that

$$\left\| \langle 2^j (\cdot - c_i) \rangle^{-s_i} \chi_{(Q_i^*)^c} \right\|_{L^{1/\alpha_i}(\mathbb{R}^n)} \approx 2^{-jn\alpha_i} \min\left(1, \left(2^j l(Q_i)\right)^{-(s_i - \alpha_i n)}\right)$$

since  $s_i/\alpha_i > n$ . In addition, it follows from (9.5) and (9.7) that

$$\min\left(\|h_{j}^{(i,0)}\|_{L^{r'}(\mathbb{R}^{n})}^{\beta_{i}}, \|h_{j}^{(i,1)}\|_{L^{r'}(\mathbb{R}^{n})}^{\beta_{i}}\right) \lesssim 2^{-jn\beta_{i}/r'} \left(\mathcal{L}_{\vec{s}}^{r,\Psi^{(m)}}[\sigma]\right)^{\beta_{i}} \min\left(1, \left(2^{j}l(Q_{i})\right)^{\beta_{i}(N_{i}+1)}\right).$$

In conclusion, we have

We choose  $N_i$  sufficiently large so that  $-(n/p_i - n) + \beta_i(N_i + 1) > 0$ , and then (9.9) follows immediately.

The proof of Lemma 6.1 is done.

9.3. **Proof of Lemma 7.1.** It follows from (1.15) that there exists 1 < t < r such that

$$(9.14) s_1, \dots, s_m > n/t > n/r, \sum_{k \in I} (s_k/n - 1/p_k) > -1/t' > -1/r'$$

for every nonempty subset  $J \subset \{1, \ldots, l\}$ . Then (5.1) holds.

For each  $J_0 \subset I$ , let

$$E_{J_0} := \left(\bigcap_{i \in I \setminus J_0} Q_i^*\right) \setminus \left(\bigcup_{i \in J_0} Q_i^*\right)$$

where  $E_{\emptyset} = \bigcap_{i \in I} Q_i^*$  for  $J_0 = \emptyset$ , and  $E_I = (\bigcup_{i \in I} Q_i^*)^c$  for  $J_0 = I$ . Then we see that the left-hand side of (7.10) can be decomposed as

$$\sum_{J_0 \subset \mathbf{I}} \Big( \sum_{j \in \mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa_1, \kappa_2}} \big( a_1, \dots, a_l, f_{l+1}, \dots, f_m \big)(x) \right| \Big) \chi_{E_{J_0}}(x).$$

Since it is a finite sum over  $J_0$ , it suffices to show that for each  $J_0 \subset I$ , there exist functions  $b_i^{J_0}$ ,  $1 \le i \le l$ , and  $F_i^{J_0}$ ,  $l+1 \le i \le \rho$  having the properties that for  $x \in E_{J_0}$ 

$$(9.15) \qquad \sum_{i \in \mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa_1,\kappa_2}}(a_1,\ldots,a_l,f_{l+1},\ldots,f_m)(x) \right| \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \Big( \prod_{i \in \mathcal{I}} b_i^{J_0}(x) \Big) \Big( \prod_{i \in \mathcal{I}} F_i^{J_0}(x) \Big),$$

(9.16) 
$$||b_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1$$
, for  $i \in I$ ,

(9.17) 
$$||F_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}, \quad \text{for } i \in \mathbf{II}.$$

We first consider the case  $J_0 = \emptyset$  and divide the proof into six cases based on the location of  $\kappa_1$  and  $\kappa_2$ . Let  $x \in E_{J_0}$ .

Case1:  $\kappa_1, \kappa_2 \in I$ . By applying (7.6), Lemma 2.4, (7.4), (5.1), and (2.4), we have

$$|T_{\sigma_{j,2}^{\kappa_1,\kappa_2}}(a_1,\ldots,a_l,f_{l+1},\ldots,f_m)(x)|$$

$$\lesssim \mathcal{L}_{\vec{s}}^r[\sigma]\mathcal{M}_t(a_{\kappa_1})_j(x)\mathcal{M}_t(a_{\kappa_2})_j(x)\Big(\prod_{i\in\mathcal{I}\setminus\{\kappa_1,\kappa_2\}}\mathcal{M}_ta_i(x)\Big)\Big(\prod_{i\in\mathcal{I}}\mathcal{M}_tf_i(x)\Big),$$

since  $\mathcal{M}_t f_i(x) \leq ||f_i||_{L^{\infty}(\mathbb{R}^n)} = 1$  for  $i \in \text{III}$ . Now we take the sum over  $j \in \mathbb{Z}$  to both sides and apply the Cauchy-Schwarz inequality. Then (9.15) follows from taking

$$b_{i}^{J_{0}}(x) := \left(\sum_{j \in \mathbb{Z}} \left(\mathcal{M}_{t}(a_{i})_{j}(x)\right)^{2}\right)^{1/2} \chi_{Q_{i}^{*}(x)}, \qquad i \in \{\kappa_{1}, \kappa_{2}\}$$

$$b_{i}^{J_{0}}(x) := \mathcal{M}_{t}a_{i}(x)\chi_{Q_{i}^{*}}(x), \qquad i \in I \setminus \{\kappa_{1}, \kappa_{2}\},$$

$$F_{i}^{J_{0}}(x) := \mathcal{M}_{t}f_{i}(x), \qquad i \in II.$$

Moreover, using Hölder's inequality, (2.3) with t < 2, and (2.2), we obtain

$$||b_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \le |Q_i^*|^{1/p_i - 1/2} ||\{\mathcal{M}_t(a_i)_j\}_{j \in \mathbb{Z}}||_{L^2(\ell^2)} \lesssim |Q_i|^{1/p_1 - 1/2} ||a_i||_{L^2(\mathbb{R}^n)} \lesssim 1, \ i \in \{\kappa_1, \kappa_2\},$$

$$||b_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \le |Q_i^*|^{1/p_i - 1/2} ||\mathcal{M}_t a_i||_{L^2(\mathbb{R}^n)} \lesssim |Q_i|^{1/p_i - 1/2} ||a_i||_{L^2(\mathbb{R}^n)} \lesssim 1, \quad i \in I \setminus \{\kappa_1, \kappa_2\},$$

$$||F_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}, \quad i \in II,$$

which completes the proof of (9.16) and (9.17).

Case2:  $\kappa_1, \kappa_2 \in II$ . Similarly, (9.15) holds with

$$b_i^{J_0}(x) := \mathcal{M}_t a_i(x) \chi_{Q_i^*}(x), \qquad i \in \mathcal{I},$$

$$F_i^{J_0}(x) := \left(\sum_{j \in \mathbb{Z}} \left(\mathcal{M}_t(f_i)_j(x)\right)^2\right)^{1/2}, \qquad i \in \{\kappa_1, \kappa_2\},$$

$$F_i^{J_0}(x) := \mathcal{M}_t f_i(x), \qquad i \in \mathcal{I} \setminus \{\kappa_1, \kappa_2\}.$$

Obviously, (9.16) and (9.17) are clear as (2.2) is applied when  $i \in \{\kappa_1, \kappa_2\}$ .

**Case3**:  $\kappa_1, \kappa_2 \in \text{III}$ . In this case, we cannot use the classical Littlewood-Paley theory as  $L^{\infty}$  norm is not characterized by  $L^{\infty}$  norm of a square function. Instead, we can benefit

from Lemma 2.3, using  $\mathfrak{M}_{\sigma,2^{j}}^{t}$ , not  $\mathcal{M}_{t}$ . By applying (7.8), Lemma 2.4, (7.4), (5.1), and (2.4), we obtain

$$\left|T_{\sigma_{j,1}^{\kappa_1,\kappa_2}}(a_1,\ldots,a_l,f_{l+1},\ldots,f_m)(x)\right| \lesssim \mathcal{L}_{\overline{s}}^r[\sigma] \left(\prod_{i\in I} \mathcal{M}_t a_i(x)\right) \mathfrak{M}_{s_{l+1},2^j}^t(f_{l+1})^{j+1}(x)$$

$$\times \left(\prod_{i\in II\setminus\{l+1\}} \mathcal{M}_t f_i(x)\right) \mathfrak{M}_{s_{\kappa_1},2^j}^t(f_{\kappa_1})_j(x) \mathfrak{M}_{s_{\kappa_2},2^j}^t(f_{\kappa_2})_j(x).$$

Now we take

$$b_i^{J_0}(x) := \mathcal{M}_t a_i(x) \chi_{Q_i^*}(x), \qquad i \in \mathcal{I},$$

$$F_{l+1}^{J_0}(x) := \sum_{j \in \mathbb{Z}} \mathfrak{M}_{s_{l+1}, 2^j}^t (f_{l+1})^{j+1}(x) \mathfrak{M}_{s_{\kappa_1}, 2^j}^t (f_{\kappa_1})_j(x) \mathfrak{M}_{s_{\kappa_2}, 2^j}^t (f_{\kappa_2})_j(x),$$

$$F_i^{J_0}(x) := \mathcal{M}_t f_i(x), \qquad i \in \mathcal{I} \setminus \{l+1\}.$$

Then (9.15), (9.16), and (9.17) are immediate for  $i \neq l+1$ , and the case i = l+1 follows from Lemma 2.3.

**Case4**:  $\kappa_1 \in I$ ,  $\kappa_2 \in II$ . Using the arguments in **Case1** and **Case2**, we are done with the choices

$$b_{\kappa_{1}}^{J_{0}}(x) := \left(\sum_{j \in \mathbb{Z}} \left(\mathcal{M}_{t}(a_{\kappa_{1}})_{j}(x)\right)^{2}\right)^{1/2} \chi_{Q_{\kappa_{1}}^{*}}(x),$$

$$b_{i}^{J_{0}}(x) := \mathcal{M}_{t}a_{i}(x)\chi_{Q_{i}^{*}}(x), \qquad i \in I \setminus \{\kappa_{1}\},$$

$$F_{\kappa_{2}}^{J_{0}}(x) := \left(\sum_{j \in \mathbb{Z}} \left(\mathcal{M}_{t}(f_{\kappa_{2}})_{j}(x)\right)^{2}\right)^{1/2},$$

$$F_{i}^{J_{0}}(x) := \mathcal{M}_{t}f_{i}(x), \qquad i \in II \setminus \{\kappa_{2}\}.$$

Case5:  $\kappa_1 \in I$ ,  $\kappa_2 \in III$ . It follows from (7.7), Lemma 2.4, (7.4), (5.1), and (2.4) that (9.15) holds with

$$b_{\kappa_{1}}^{J_{0}}(x) := \left(\sum_{j \in \mathbb{Z}} \left(\mathcal{M}_{t}(a_{\kappa_{1}})_{j}(x)\right)^{2}\right)^{1/2} \chi_{Q_{\kappa_{1}}^{*}}(x),$$

$$b_{i}^{J_{0}}(x) := \mathcal{M}_{t}a_{i}(x)\chi_{Q_{i}^{*}}(x), \qquad i \in I \setminus \{\kappa_{1}\},$$

$$F_{l+1}^{J_{0}}(x) := \left(\sum_{j \in \mathbb{Z}} \left(\mathfrak{M}_{s_{l+1},2^{j}}^{t}(f_{l+1})^{j+1}(x)\right)^{2} \left(\mathfrak{M}_{s_{\kappa_{2}},2^{j}}^{t}(f_{\kappa_{2}})_{j}(x)\right)^{2}\right)^{1/2},$$

$$F_{i}^{J_{0}}(x) := \mathcal{M}_{t}f_{i}(x), \qquad i \in II \setminus \{l+1\},$$

and it is clear that (9.15), (9.16), and (9.17) hold. Especially, (9.17) for i = l + 1 is due to Lemma 2.3.

Case6:  $\kappa_1 \in \Pi$ ,  $\kappa_2 \in \Pi$ . The similar arguments can be applied with

$$b_i^{J_0}(x) := \mathcal{M}_t a_i(x) \chi_{Q_i^*}(x), \qquad i \in \mathcal{I},$$

$$F_{\kappa_1}^{J_0}(x) := \sum_{j \in \mathbb{Z}} \mathfrak{M}_{s_{\kappa_1}, 2^j}^t(f_{\kappa_1})_j(x) \mathfrak{M}_{s_{\kappa_2}, 2^j}^t(f_{\kappa_2})_j(x),$$

$$F_i^{J_0}(x) := \mathcal{M}_t f_i(x), \quad i \in \mathcal{I} \setminus \{\kappa_1\}.$$

Note that Lemma 2.3 implies

$$||F_{\kappa_1}^{J_0}||_{L^{p_{\kappa_1}}(\mathbb{R}^n)} \lesssim ||f_{\kappa_1}||_{L^{p_{\kappa_1}}(\mathbb{R}^n)} ||f_{\kappa_2}||_{BMO} \lesssim ||f_{\kappa_1}||_{L^{p_{\kappa_1}}(\mathbb{R}^n)}.$$

Next we consider the case  $J_0 \neq \emptyset$ . In this case the proof is based on the idea in the proof of Lemma 6.1. For notational convenience, let

(9.18) 
$$\mathcal{G}_j := T_{\sigma_{j_1}^{\kappa_1,\kappa_2}} \left( a_1, \dots, a_l, f_{l+1}, \dots, f_m \right).$$

Here, the notation  $\mathcal{G}_j$  does not contain two parameters  $\kappa_1$  and  $\kappa_2$  as the arguments below are universal for any  $1 \leq \kappa_1 < \kappa_2 \leq m$ . We note that  $\mathcal{G}_j$  plays a similar role as  $g_j$  in (9.3).

We shall prove that there exist nonnegative functions  $u_{i,j}^{J_0}$ ,  $i \in J_0$ , such that for  $x \in E_{J_0}$  and  $j \in \mathbb{Z}$ ,

$$(9.19) |\mathcal{G}_j(x)| \lesssim \mathcal{L}^r_{\vec{s}}[\sigma] \Big( \prod_{i \in J_0} u_{i,j}^{J_0}(x) \Big) \Big( \prod_{i \in I \setminus J_0} |Q_i|^{-1/p_i} \chi_{Q_i^*}(x) \Big) \Big( \prod_{i \in II} \mathcal{M}_t(f_i)(x) \Big),$$

and

for some  $\gamma_i, \delta_i > 0$ , which are the counterparts of (9.12) and (9.13), respectively.

If we have such functions  $u_{i,j}^{J_0}$ , then (9.15) holds with the functions

$$(9.21) b_i^{J_0} := \sum_{i \in \mathbb{Z}} u_{i,j}^{J_0} \text{for } i \in J_0, b_i^{J_0} = |Q_i|^{-1/p_i} \chi_{Q_i^*} \text{for } i \in I \setminus J_0,$$

(9.22) 
$$F_i^{J_0} := \mathcal{M}_t(f_i) \quad \text{for} \quad i \in \mathbf{II}.$$

The estimate (9.16) for  $i \in I \setminus J_0$  is obvious and when  $i \in J_0$  it follows from (9.20). In addition, (9.17) holds via the  $L^{p_i}$ -boundedness of  $\mathcal{M}_t$ .

From now on, let us construct  $u_{i,j}^{J_0}$  having the properties (9.19) and (9.20). Fix  $x \in E_{J_0}$  and write

$$\mathcal{G}_j(x) = \int_{(\mathbb{R}^n)^m} 2^{jmn} K_j(2^j(x-y_1), \dots, 2^j(x-y_m)) \Big( \prod_{i \in \mathbb{I}} a_i(y_i) \Big) \Big( \prod_{i \in \mathbb{I} \cup \mathbb{I} \cup \mathbb{I}} f_i(y_i) \Big) d\vec{\boldsymbol{y}}$$

where  $K_j := (\sigma_{j,1}^{\kappa_1,\kappa_2}(2^j \cdot))^{\vee}$ . Let  $c_i$  denote the center of the cube  $Q_i$  and use the notation

$$K_j^{(u,w)}(x,\vec{y}) := K_j(y_1,\ldots,y_{u-1},2^j(x-y_u),\ldots,2^j(x-y_w),y_{w+1},\ldots,y_m)$$

for simplicity, as before.

Since  $|x - c_i| \approx |x - y_i|$  for  $x \notin Q_i^*$  and  $y_i \in Q_i$ , we see that

$$\left(\prod_{i \in J_0} \langle 2^j (x - c_i) \rangle^{s_i} \right) |\mathcal{G}_j(x)| 
\lesssim 2^{jmn} \int_{(\mathbb{R}^n)^m} \left(\prod_{i \in J_0} \langle 2^j (x - y_i) \rangle^{s_i} \right) |K_j^{(1,m)}(x, \vec{\boldsymbol{y}})| \left(\prod_{i \in I} |a_i(y_i)| \right) \left(\prod_{i \in II \cup III} |f_i(y_i)| \right) d\vec{\boldsymbol{y}} 
\leq 2^{jmn} \int_{(\mathbb{R}^n)^m} \left(\prod_{i \in J_0} \langle 2^j (x - y_i) \rangle^{s_i} \right) |K_j^{(1,m)}(x, \vec{\boldsymbol{y}})| \left(\prod_{i \in I} |Q_i|^{-1/p_i} \chi_{Q_i}(y_i) \right) \left(\prod_{i \in II} |f_i(y_i)| \right) d\vec{\boldsymbol{y}}.$$

We now fix  $k \in J_0$  and estimate the last integral by

$$\begin{split} \int_{y_k \in \mathbb{R}^n} \left\| \left( \prod_{i \in J_0 \cup \Pi} \langle 2^j (x - y_i) \rangle^{s_i} \right) K_j^{(1,m)} (x, \vec{\boldsymbol{y}}) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{J_0 \setminus \{k\}}) L^1(\vec{\boldsymbol{y}}_{\Pi \setminus J_0}) L^{t'}(\vec{\boldsymbol{y}}_{\Pi}) L^1(\vec{\boldsymbol{y}}_{\Pi \Pi})} \\ & \times \left\| \prod_{i \in J_0} |Q_i|^{-1/p_i} \chi_{Q_i}(y_i) \right\|_{L^1(\vec{\boldsymbol{y}}_{J_0 \setminus \{k\}})} \left\| \prod_{i \in \Pi \setminus J_0} |Q_i|^{-1/p_i} \chi_{Q_i}(y_i) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{\Pi \setminus J_0})} \\ & \times \left\| \prod_{i \in \Pi} \langle 2^j (x - y_i) \rangle^{-s_i} f_i(y_i) \right\|_{L^t(\vec{\boldsymbol{y}}_{\Pi})} dy_k, \end{split}$$

where we used the notations  $\vec{\boldsymbol{y}}_J := \bigotimes_{i \in J} y_i$  for all J (for example,  $\vec{\boldsymbol{y}}_{\rm I} = (y_1, \dots, y_l)$ ,  $\vec{\boldsymbol{y}}_{\rm II} = (y_{l+1}, \dots, y_{\rho})$ , and so on), and

$$||F(z_1,z_2)||_{L^p(z_1)L^q(z_2)} := |||F(z_1,z_2)||_{L^p(z_1)}||_{L^q(z_2)}$$

Using a change of variables we write

$$\begin{split} & \left\| \left( \prod_{i \in J_0 \cup \text{II}} \langle 2^j (x - y_i) \rangle^{s_i} \right) K_j^{(1,m)} (x, \vec{\boldsymbol{y}}) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{J_0 \setminus \{k\}}) L^1(\vec{\boldsymbol{y}}_{\text{I} \setminus J_0}) L^{t'}(\vec{\boldsymbol{y}}_{\text{II}}) L^1(\vec{\boldsymbol{y}}_{\text{III}})} \\ &= 2^{-jn \text{Card}(\text{I} \setminus J_0)} 2^{-(jn/t') \text{Card}(\text{II})} 2^{-jn \text{Card}(\text{III})} \\ & \times \left\| \langle 2^j (x - y_k) \rangle^{s_k} \left( \prod_{i \in J_0 \cup \text{II} \setminus \{k\}} \langle y_i \rangle^{s_i} \right) K_j^{(k,k)} (x, \vec{\boldsymbol{y}}) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{J_0 \setminus \{k\}}) L^1(\vec{\boldsymbol{y}}_{\text{I} \setminus J_0}) L^{t'}(\vec{\boldsymbol{y}}_{\text{II}}) L^1(\vec{\boldsymbol{y}}_{\text{III}})}. \end{split}$$

Now Hölder's inequality with  $s_i > n/t$  and Lemma 2.9 yield

$$\begin{aligned} & \left\| \langle 2^{j}(x - y_{k}) \rangle^{s_{k}} \left( \prod_{i \in J_{0} \cup \Pi \setminus \{k\}} \langle y_{i} \rangle^{s_{i}} \right) K_{j}^{(k,k)}(x, \vec{\boldsymbol{y}}) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{J_{0} \setminus \{k\}}) L^{1}(\vec{\boldsymbol{y}}_{I \setminus J_{0}}) L^{t'}(\vec{\boldsymbol{y}}_{\Pi I}) L^{1}(\vec{\boldsymbol{y}}_{\Pi I})} \\ & \lesssim \left\| \langle 2^{j}(x - y_{k}) \rangle^{s_{k}} \left( \prod_{i \in \Lambda \setminus \{k\}} \langle y_{i} \rangle^{s_{i}} \right) K_{j}^{(k,k)}(x, \vec{\boldsymbol{y}}) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{J_{0} \setminus \{k\}}) L^{t'}(\vec{\boldsymbol{y}}_{\Lambda \setminus J_{0}})} \\ & \lesssim \left\| \langle 2^{j}(x - y_{k}) \rangle^{s_{k}} \left( \prod_{i \in \Lambda \setminus \{k\}} \langle y_{i} \rangle^{s_{i}} \right) K_{j}^{(k,k)}(x, \vec{\boldsymbol{y}}) \right\|_{L^{t'}(\vec{\boldsymbol{y}}_{\Lambda \setminus \{k\}})}. \end{aligned}$$

Morover, we have

$$\begin{split} \left\| \prod_{i \in J_0} |Q_i|^{-1/p_i} \chi_{Q_i}(y_i) \right\|_{L^1(\vec{\boldsymbol{y}}_{J_0 \setminus \{k\}})} &\lesssim \left( \prod_{i \in J_0} |Q_i|^{1-1/p_i} \right) \chi_{Q_k}(y_k) |Q_k|^{-1}, \\ \left\| \prod_{i \in \mathcal{I} \setminus J_0} |Q_i|^{-1/p_i} \chi_{Q_i}(y_i) \right\|_{L^{\infty}(\vec{\boldsymbol{y}}_{\mathcal{I} \setminus J_0})} &\leq \prod_{i \in \mathcal{I} \setminus J_0} |Q_i|^{-1/p_i}, \\ \left\| \prod_{i \in \mathcal{I}} \langle 2^j(x - y_i) \rangle^{-s_i} f_i(y_i) \right\|_{L^t(y_{\mathcal{I}\mathcal{I}})} &\lesssim 2^{-(jn/t)\operatorname{Card}(\mathcal{I}\mathcal{I})} \prod_{i \in \mathcal{I}\mathcal{I}} \mathfrak{M}_{s_i, 2^j} f_i(x) \\ &\lesssim 2^{-(jn/t)\operatorname{Card}(\mathcal{I}\mathcal{I})} \prod_{i \in \mathcal{I}\mathcal{I}} \mathcal{M}_t(f_i)(x), \end{split}$$

where the last inequality follows from (2.4) with  $s_i > n/t$ .

Combining the above inequalities, we obtain that for  $x \in E_{I_0}$ ,

$$\left(\prod_{i \in J_0} \langle 2^j (x - c_i) \rangle^{s_i} \right) |\mathcal{G}_j(x)| \lesssim 2^{jn \operatorname{Card}(J_0)} H_j^{(k,0)}(x) \left(\prod_{i \in J_0} |Q_i|^{1 - 1/p_i} \right) \\
\times \left(\prod_{i \in I \setminus J_0} |Q_i|^{-1/p_i} \right) \left(\prod_{i \in \Pi} \mathcal{M}_t(f_i)(x) \right)$$

where  $H_i^{(k,0)}$  is defined as

$$H_j^{(k,0)}(x) := \frac{1}{|Q_k|} \int_{Q_k} \langle 2^j (x - y_k) \rangle^{s_k} \left\| \left( \prod_{i \in \Lambda \setminus \{k\}} \langle y_i \rangle^{s_i} \right) K_j^{(k,k)}(x, \vec{\boldsymbol{y}}) \right\|_{L^{t'}(\vec{\boldsymbol{y}}_{\Lambda \setminus \{k\}})} dy_k,$$

which is the counterpart of  $h_j^{(k,0)}$  in the proof of Lemma 6.1. Then the argument that led to (9.5), with (5.1), proves that

(9.23) 
$$||H_j^{(k,0)}||_{L^{t'}(\mathbb{R}^n)} \lesssim 2^{-jn/t'} \mathcal{L}_{\vec{s}}^r[\sigma].$$

On the other hand, applying the vanishing moment condition of  $a_k$  and Lemma 2.8, we write

$$\begin{split} \left| \mathcal{G}_{j}(x) \right| &\lesssim 2^{jmn} \sum_{|\alpha| = N_{k} + 1} \int_{0}^{1} \int_{(\mathbb{R}^{n})^{m}} \left( 2^{j} |y_{k} - c_{k}| \right)^{N_{k} + 1} \left( \prod_{i \in I} |Q_{i}|^{-1/p_{i}} \chi_{Q_{i}}(y_{i}) \right) \\ &\times \left| \partial_{k}^{\alpha} K_{j} \left( 2^{j} (x - y_{1}), \dots, 2^{j} (x - y_{k-1}), 2^{j} x_{c_{k}, y_{k}}^{t}, 2^{j} (x - y_{k+1}), \dots, 2^{j} (x - y_{m}) \right) \right| \\ &\times \left( \prod_{i \in I^{1}} |f_{i}(y_{i})| \right) d\vec{\boldsymbol{y}} dt \end{split}$$

where  $x_{c_k,y_k}^t := x - c_k - t(y_k - c_k)$ . Since  $|x_{c_k,y_k}^t| \approx |x - c_k|$  for  $x \notin Q_k^*$ ,  $y_k \in Q_k$ , and 0 < t < 1, arguing as in (9.6), we obtain that for  $x \in E_{J_0}$ ,

where

$$H_{j}^{(k,1)}(x) := \left(2^{j} l(Q_{k})\right)^{N_{k}+1} \sum_{|\alpha|=N_{k}+1} \frac{1}{|Q_{k}|} \int_{0}^{1} \int_{Q_{k}} \langle 2^{j} x_{c_{k},y_{k}}^{t} \rangle^{s_{k}}$$

$$\times \left\| \prod_{i \in \Lambda \setminus \{k\}} \langle \cdot_{i} \rangle^{s_{i}} \partial_{k}^{\alpha} K_{j}\left(\cdot_{1}, \dots, \cdot_{k-1}, 2^{j} x_{c_{k},y_{k}}^{t}, \cdot_{k+1}, \dots, \cdot_{m}\right) \right\|_{L^{t'}((\mathbb{R}^{n})^{m-1})} dy_{k} dt.$$

Using Minkowski's inequality, Lemma 2.9 and (5.1), we deduce

(9.24) 
$$||H_j^{(k,1)}||_{L^{t'}(\mathbb{R}^n)} \lesssim 2^{-jn/t'} \left(2^j l(Q_k)\right)^{N_k+1} \mathcal{L}_{\vec{s}}^r[\sigma].$$

So far, we have proved that for  $x \in E_{J_0}$  and  $k \in J_0$ ,

$$(9.25) \quad |\mathcal{G}_{j}(x)| \lesssim 2^{jn\operatorname{Card}(J_{0})} \Big( \prod_{i \in J_{0}} \langle 2^{j}(x - c_{i}) \rangle^{-s_{i}} |Q_{i}|^{1 - 1/p_{i}} \chi_{(Q_{i}^{*})^{c}}(x) \Big)$$

$$\times \Big( \prod_{i \in \operatorname{I} \backslash J_{0}} |Q_{i}|^{-1/p_{i}} \chi_{Q_{i}^{*}}(x) \Big) \Big( \prod_{i \in \operatorname{II}} \mathcal{M}_{t}(f_{i})(x) \Big) \min \Big( H_{j}^{(k,0)}(x), H_{j}^{(k,1)}(x) \Big).$$

We choose  $\{\alpha_i\}_{i\in I_0}$  and  $\{\beta_i\}_{i\in I_0}$  as in (9.11) by replacing  $\{1,\ldots,v\}$  and r' by  $J_0$  and t', respectively, which is possible since

$$\sum_{i \in J_0} \min (0, s_i/n - 1/p_i) > -1/t'$$

by virtue of condition (9.14). Then we have

$$\alpha_i, \beta_i > 0, \quad s_i/n > 1/p_i - \beta_k/t' = \alpha_i, \quad \sum_{i \in J_0} \beta_i = 1.$$

Now if we set

$$u_{i,j}^{J_0}(x) := \left(\mathcal{L}_{\vec{s}}^r[\sigma]\right)^{-\beta_i} 2^{jn} |Q_i|^{1-1/p_i} \langle 2^j(x-c_i) \rangle^{-s_i} \chi_{(Q_i^*)^c}(x) \left(\min\left(H_j^{(i,0)}(x), H_j^{(i,1)}(x)\right)\right)^{\beta_i},$$

(9.19) is immediate from (9.25) since  $\sum_{i \in J_0} \beta_i = 1$ .

It remains to verify (9.20). Hölder's inequality with  $1/p_i = \beta_i/r' + \alpha_i$  yields that

$$||u_{i,j}^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \leq \left(\mathcal{L}_{\vec{s}}^r[\sigma]\right)^{-\beta_i} 2^{jn} l(Q_i)^{n(1-1/p_i)} ||\langle 2^j(\cdot - c_i)\rangle^{-s_i} \chi_{(Q_i^*)^c}||_{L^{1/\alpha_i}(\mathbb{R}^n)} \times \min\left(||H_j^{(i,0)}||_{L^{t'}(\mathbb{R}^n)}^{\beta_i}, ||H_j^{(i,1)}||_{L^{t'}(\mathbb{R}^n)}^{\beta_i}\right).$$

Since  $s_i > \alpha_i n$ , we have

$$\left\| \langle 2^j(\cdot - c_i) \rangle^{-s_i} \chi_{(Q_i^*)^c} \right\|_{L^{1/\alpha_i}(\mathbb{R}^n)} \lesssim 2^{-jn\alpha_i} \min \left( 1, \left( 2^j l(Q_i) \right)^{-(s_i - \alpha_i n)} \right),$$

and the estimates (9.23) and (9.24) prove

$$\min\left(\|H_{j}^{(i,0)}\|_{L^{t'}(\mathbb{R}^{n})}^{\beta_{i}}, \|H_{j}^{(i,1)}\|_{L^{t'}(\mathbb{R}^{n})}^{\beta_{i}}\right) \lesssim 2^{-jn\beta_{i}/t'} \left(\mathcal{L}_{\vec{s}}^{r}[\sigma]\right)^{\beta_{i}} \min\left(1, \left(2^{j}l(Q_{i})\right)^{\beta_{i}(N_{i}+1)}\right).$$

Thus,

$$||u_{i,j}^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \lesssim \begin{cases} \left(2^j l(Q_i)\right)^{-(n/p_i-n)+\beta_i(N_i+1)}, & \text{if } 2^j l(Q_i) \leq 1\\ \left(2^j l(Q_i)\right)^{-(n/p_i-n)-(s_i-\alpha_i n)}, & \text{if } 2^j (Q_i) > 1 \end{cases}$$

since  $1 - \alpha_i - \beta_i/t' = 1 - 1/p_i$ . This implies (9.20) with  $\gamma_j = -(n/p_i - n) + \beta_i(N_i + 1)$  and  $\delta_i = n/p_i - n + s_i - \alpha_i n$ . We have  $\gamma_k, \delta_k > 0$  as  $N_k$  is sufficiently large and  $s_i > \alpha_i n$ .

This completes the proof of Lemma 7.1.

9.4. **Proof of Lemma 7.2.** The proof is similar to that of Lemma 7.1. As in the proof of Lemma 7.1, we choose 1 < t < r such that

$$s_1, \dots, s_m > d/t > d/r, \qquad \sum_{k \in I} (s_k/n - 1/p_k) > -1/t' > -1/r'$$

for every nonempty subset  $J \subset I$ , and observe that (5.1) holds.

For each  $J_0 \subset I$ , let

$$E_{J_0} := \left(\bigcap_{i \in I \setminus J_0} Q_i^*\right) \setminus \left(\bigcup_{i \in J_0} Q_i^*\right)$$

and we decompose the left-hand side of (7.18) as

$$\sum_{J_0 \subset I} \left( \sum_{i \in \mathbb{Z}} \left| T_{\sigma_{1,j}^{\kappa}} (a_1, \dots, a_l, f_{l+1}, \dots, f_m)(x) \right|^2 \right)^{1/2} \chi_{E_{J_0}}(x).$$

Since it is a finite sum over  $J_0$ , we need to prove that for each  $J_0 \subset I$ , there exist nonnegative functions  $b_i^{J_0}$ ,  $i \in I$ , and  $F_i^{J_0}$ ,  $i \in II$  satisfying that for all  $x \in E_{J_0}$ 

$$(9.26) \qquad \Big(\sum_{j\in\mathbb{Z}} \left| T_{\sigma_{j,1}^{\kappa}} \left( a_1, \dots, a_l, f_{l+1}, \dots, f_m \right)(x) \right|^2 \Big)^{1/2} \lesssim \mathcal{L}_{\overline{s}}^r [\sigma] \Big( \prod_{i\in\mathbb{I}} b_i^{J_0}(x) \Big) \Big( \prod_{i\in\mathbb{I}} F_i^{J_0}(x) \Big),$$

(9.27) 
$$||b_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \lesssim 1$$
, for  $i \in I$ ,

(9.28) 
$$||F_i^{J_0}||_{L^{p_i}(\mathbb{R}^n)} \lesssim ||f_i||_{L^{p_i}(\mathbb{R}^n)}, \quad \text{for } i \in \text{II.}$$

Let us first assume  $J_0 = \emptyset$ . In this case, the proof consists of three cases.

Case1:  $\kappa \in I$ . Using (7.14), Lemma 2.4, (2.4), (7.13), and (5.1), we obtain

$$\left| T_{\sigma_{j,1}^{\kappa}} (a_1, \dots, a_l, f_{l+1}, \dots, f_m)(x) \right| \lesssim \mathcal{L}_{\vec{s}}^r [\sigma] \mathcal{M}_t(a_{\kappa})_j(x) \Big( \prod_{i \in \Pi} \mathcal{M}_t a_i(x) \Big) \Big( \prod_{i \in \Pi} \mathcal{M}_t f_i(x) \Big),$$

where we applied  $\mathcal{M}_t f_i(x) \leq ||f_i||_{L^{\infty}(\mathbb{R}^n)} = 1$  for  $i \in III$ . We now take

$$b_{\kappa}^{J_0}(x) := \left(\sum_{j \in \mathbb{Z}} \left( \mathcal{M}_t(a_{\kappa})_j(x) \right)^2 \right)^{1/2} \chi_{Q_{\kappa}^*}(x),$$
  
$$b_i^{J_0}(x) := \mathcal{M}_t a_i(x) \chi_{Q_i^*}(x), \qquad i \in I \setminus \{\kappa\},$$
  
$$F_i^{J_0}(x) := \mathcal{M}_t f_i(x), \qquad i \in II$$

and then (9.26) holds. Furthermore, (9.27) and (9.28) follow from Hölder's inequality, (2.3) with t < 2, and (2.2). To be specific, the estimates for  $i \in I \setminus \{\kappa\}$  or for  $i \in II$  are clear, and

$$||b_{\kappa}^{J_0}||_{L^{p_{\kappa}}(\mathbb{R}^n)} \leq |Q_{\kappa}^*|^{1/p_{\kappa}-1/2} || \{ \mathcal{M}_t(a_{\kappa})_j \}_{j \in \mathbb{Z}} ||_{L^2(\ell^2)} \lesssim |Q_{\kappa}|^{1/p_{\kappa}-1/2} ||a_{\kappa}||_{L^2(\mathbb{R}^n)} \lesssim 1.$$

Case2:  $\kappa \in II$ . It can be proved in a similar way. Indeed, (9.26) holds with

$$b_i^{J_0}(x) := \mathcal{M}_t a_i(x) \chi_{Q_i}(x), \qquad i \in \mathcal{I},$$

$$F_{\kappa}^{J_0}(x) := \left( \sum_{j \in \mathbb{Z}} \left( \mathcal{M}_t(f_{\kappa})_j(x) \right)^2 \right)^{1/2},$$

$$F_i^{J_0}(x) := \mathcal{M}_t f_i(x), \qquad i \in \mathcal{I} \setminus \{\kappa\}.$$

It is also obvious that (9.27) and (9.28) hold as (2.2) is applied in the case  $i = \kappa$ .

Case3:  $\kappa \in III$ . We utilize Lemma 2.3 as we did in Case3 that appeared in the proof of Lemma 7.1. Using (7.15), Lemma 2.4, (2.4), (7.13), and (5.1), we obtain that

$$\begin{aligned} & \left| T_{\sigma_{j,1}^{\sigma+1}} (a_1, \dots, a_l, f_{l+1}, \dots, f_m)(x) \right| \\ & \lesssim \mathcal{L}_{\vec{s}}^r [\sigma] \Big( \prod_{i \in \mathbf{I}} \mathcal{M}_t a_i(x) \Big) \mathfrak{M}_{s_{l+1}, 2^j}^t (f_{l+1})^{j+1, m}(x) \Big( \prod_{i \in \mathbf{II} \setminus \{l+1\}} \mathcal{M}_t f_i(x) \Big) \mathfrak{M}_{s_{\kappa}, 2^j}^t (f_{\kappa})_j(x). \end{aligned}$$

Now we take

$$b_i^{J_0}(x) := \mathcal{M}_t a_i(x) \chi_{Q_i}(x), \qquad i \in \mathcal{I},$$

$$F_{l+1}^{J_0}(x) := \Big( \sum_{j \in \mathbb{Z}} \Big( \mathfrak{M}_{s_{l+1}, 2^j}^t(f_{l+1})^{j+1, m}(x) \Big)^2 \Big( \mathfrak{M}_{s_{\kappa}, 2^j}^t(f_{\kappa})_j(x) \Big)^2 \Big)^{1/2},$$

$$F_i^{J_0}(x) := \mathcal{M}_t f_i(x), \quad i \in \mathcal{I} \setminus \{l+1\}.$$

Then (9.26), (9.27), and (9.28) are all true for  $i \neq l + 1$ , and (9.28) for i = l + 1 follows from Lemma 2.3.

Now we consider the case  $J_0 \neq \emptyset$ . The proof is immediate from the argument in the proof of Lemma 7.1. We define, like (9.18),

$$\mathcal{G}_j := T_{\sigma_{i,1}^{\kappa}}(a_1, \dots, a_l, f_{l+1}, \dots, f_m).$$

Then (9.19) still holds in the present case with (9.20). Let  $b_i^{J_0}$ ,  $i \in I$ , and  $F_i^{J_0}$ ,  $i \in II$ , be defined as in (9.21) and (9.22), and apply the embedding  $\ell^1 \hookrightarrow \ell^2$  to obtain that the left-hand side of (9.26) is bounded by

$$\sum_{j \in \mathbb{Z}} \left| \mathcal{G}_j(x) \right| \lesssim \mathcal{L}_{\vec{s}}^r[\sigma] \left( \prod_{i=1}^l b_i^{J_0}(x) \right) \left( \prod_{i=l+1}^{\rho} F_i^{J_0}(x) \right),$$

which proves (9.26). In addition, (9.27) and (9.28) are obvious from (9.16) and (9.17), respectively.

This completes the proof.
