# On the discretization of Darboux Integrable Systems admitting the second-order integrals.

**Abstract** We study discretization of Darboux integrable systems. The discretization is done by using x- or y-integrals of the considered systems. New examples of semi-discrete Darboux integrable systems are obtained.

Keywords: semi-discrete system, Darboux integrability, x-integral, n-integral, discretization.

### 1 Introduction

In the present paper we study the problem of discretization of integrable equations so that the property of integrability is preserved. In particular, we consider hyperbolic type systems

$$p_{xy}^{i} = f^{i}(x, y, p, p_{x}, p_{y}) \qquad i = 1, \dots, m,$$
(1)

where  $p = (p^1, ..., p^m), p_x = (p_x^1, ..., p_x^m)$  and  $p_y = (p_y^1, ..., p_y^m)$ .

For such hyperbolic systems it is convenient to use Darboux integrability [1]. The above system is said to be integrable if it admits m functionally independent non-trivial x-integrals and m functionally independent non-trivial y-integrals. A function  $I(x, y, p, p_y, p_{yy}, ...)$  is called an x- integral of the system (1) if

$$D_x I(x, y, p, p_y, p_{yy}, ...) = 0 \qquad \text{on all solutions of (1)}, \tag{2}$$

where  $D_x$  is the total derivative with respect to x. One can define y- integrals in a similar way. The Darboux integrable systems are extensively studied, see [2]-[11] and a review paper [12].

The extension of the notion of Darboux integrability to discrete and semi-discrete Darboux integrable systems was developed by Habibullin and Pekcan [13], see also [14]. In recent years there is an interest in studying such systems, see [15]-[25]. A semi-discrete system

$$q_{nx}^{i} = f^{i}(x, n, q, q_{x}, q_{1}) \qquad i = 1, \dots, m,$$
(3)

where  $q = (q^1, \ldots, q^m)$ ,  $q_x = (q_x^1, \ldots, q_x^m)$  and  $q_1 = (q^1(x, n+1), \ldots, q^m(x, n+1))$ , is called Darboux integrable if it admits m functionally independent non-trivial x-integrals and m functionally independent non-trivial n-integrals. A function  $J(x, n, q, q_x, q_{xx}, \ldots)$  is called an n- integral of the system (3) if

$$DJ(x, y, q, q_x, q_{xx}, \ldots) = J(x, n, q, q_x, q_{xx}, \ldots) \qquad \text{on all solutions of (3)}, \tag{4}$$

where D is the shift operator, that is  $Dq = q_1$ . Note that  $Dq_k = q_{k+1}$ , k = 1, 2, 3, ... The *x*-integrals  $I(x, n, q, q_1, q_2, ...)$  for the system (3) are defined in the same way as for continuous system.

A hypothesis states that any continuous Darboux integrable system can be discretized with respect to one of the independent variables such that the resulting semi-discrete system is Darboux integrable and admits the set of x- or y- integrals of the original system as n-integrals [25]. The results of our work support the above hypothesis. We complete the discretization of continuous Darboux integrable equations derived by Zhiber and Kostrigina in [8]. In their paper Zhiber and Kostrigina considered the classification problem for continuous Darboux integrable systems admitting x- and y-integrals of the first and second orders. They found all such systems together with their x- and y-integrals. Following [8] we have two types of systems. The first system is

$$\begin{cases} u_{xy} = \frac{u_x u_y}{u+v} + \left(\frac{1}{u+v} + \frac{\alpha}{u+\alpha^2 v}\right) u_x v_y, \\ v_{xy} = \frac{\alpha^2 v_x v_y}{u+\alpha^2 v} + \left(\frac{1}{\alpha(u+v)} + \frac{\alpha}{u+\alpha^2 v}\right) u_x v_y. \end{cases}$$
(5)

For  $\alpha = 1$  it has *y*-integrals

$$I = 2v - \frac{u + v + c}{u_x} + 2c \ln \frac{u_x}{u + v + c},$$
(6)

$$J = \frac{u_{xx}}{u_x} - \frac{2u_x + v_x}{(u + v + c)}$$
(7)

and the x-integrals have the same form in  $u, u_y, u_{yy}$  and  $v, v_y, v_{yy}$  variables. For  $\alpha \neq 1$  it has y-integrals

$$I_1 = \left(1 + \frac{1}{\alpha}\right) v \left(\frac{u_x}{u+v}\right)^{1-\alpha} - v_x \left(\frac{u_x}{u+v}\right)^{-\alpha},\tag{8}$$

$$J_1 = \frac{u_{xx}}{u_x} - \frac{(\alpha+1)u_x + \alpha v_x}{\alpha(u+v)}$$
(9)

and the x-integrals have the same form in  $u, u_y, u_{yy}$  and  $v, v_y, v_{yy}$  variables. The second system is

$$\begin{cases}
 u_{xy} = \frac{vu_x u_y}{uv + d} + \left(\frac{1}{uv + d} + \frac{1}{\alpha(uv + c)}\right) uu_x v_y, \\
 v_{xy} = \frac{uv_x v_y}{uv + c} + \left(\frac{\alpha}{uv + d} + \frac{1}{uv + c}\right) vu_x v_y.
\end{cases}$$
(10)

For  $\alpha = 1$  it has *y*-integrals

$$I_2 = \frac{(d-c)v^2 u_x^2}{2(uv+d)^2} - \frac{c u_x v_x}{uv+d}$$
(11)

and

$$J_2 = \frac{u_{xx}}{u_x} + \frac{(d-c)vu_x - cuv_x}{c(uv+d)},$$
(12)

where c and d are non-zero constants and the x-integrals have the same form in  $u, u_y, u_{yy}$  and  $v, v_y, v_{yy}$  variables.

For  $\alpha \neq 1$  it has *y*-integrals

$$I_3 = \frac{u_x^\beta v_x}{(uv+d)^\beta} + \frac{\beta v^2 u_x^{\beta+1}}{(uv+d)^{\beta+1}}$$
(13)

and

$$J_3 = -\frac{u_{xx}}{u_x} + \frac{2vu_x + uv_x}{uv + d},$$
(14)

where d and  $\beta \neq 1$  are non-zero constants, and the x-integrals have the same form in  $u, u_y, u_{yy}$ and  $v, v_y, v_{yy}$  variables.

To discretize the systems (5) and (10) we employ a method introduced by Habibullin et. all [21], (see also [24]-[26]). In this approach one takes x- or y-integrals of a system and looks for a semi-discrete system admitting such integrals as n-integrals. In general one gets a set of semi-discrete systems admitting these n-integrals. For all sets of y- integrals of systems (5) and (10) we obtained corresponding semi-discrete systems. In all cases we were able to choose a semi-discrete system that gives the original system in the continuum limit. Also in examples where we can write a semi-discrete system explicitly we have shown that the system is Darboux integrable.

The following theorems are formulated for a hyperbolic type semi-discrete system

$$\begin{cases} u_{xn} = f(x, n, u, v, u_x, v_x, u_n, v_n), \\ v_{xn} = g(x, n, u, v, u_x, v_x, u_n, v_n), \end{cases}$$
(15)

where variables u, v depend on a continuous variable  $x \in \mathbb{R}$  and a discrete variable  $n \in \mathbb{N}$ . Note that the system (5) in the case  $\alpha = 1$  was discretized in [25].

**Theorem 1** Let  $\alpha \neq 1$ . A system (15) admits n-integrals (8) and (9) if and only if it has the form

$$u_{1x} = \frac{u_1 + v_1}{u + v} \mathcal{D}_1^{\alpha^{-1}} u_x,$$
  

$$v_{1x} = \frac{\alpha + 1}{\alpha} \frac{v_1 \mathcal{D}_1^{\alpha^{-1}} - v \mathcal{D}_1}{u + v} u_x + \mathcal{D}_1 v_x.$$
(16)

The function  $\mathcal{D}_1$  is equal to 1 or given implicitly by  $H(K_1, L_1) = 0$ , where H is any smooth function and

$$K_1 = \frac{\alpha v_1 \mathcal{D}_1^{\alpha^{-1}} - \alpha v \mathcal{D}_1^{1+\alpha^{-1}} + (1 - \mathcal{D}_1^{\alpha^{-1}}) u_1}{(\mathcal{D}_1^{\alpha^{-1}} - 1)^{\alpha + 1}},$$
(17)

$$L_{1} = \frac{(u_{1} - \mathcal{D}_{1}^{1+\alpha^{-1}}u)e^{\mathcal{D}_{1}^{\alpha^{-1}}}}{\mathcal{D}_{1}(\mathcal{D}_{1}^{\alpha^{-1}} - 1)^{a}} + \frac{(-1)^{\alpha}e^{\mathcal{D}_{1}^{\alpha^{-1}}}(\alpha v_{1}\mathcal{D}_{1}^{\alpha^{-1}} - \alpha v\mathcal{D}_{1}^{1+\alpha^{-1}} + (1 - \mathcal{D}_{1}^{\alpha^{-1}})u_{1})}{(\mathcal{D}_{1}^{\alpha^{-1}} - 1)^{\alpha+1}}.$$
 (18)

Let us construct some examples.

**Example 1** In the case  $\mathcal{D}_1 = 1$  the system (16) becomes

$$u_{1x} = \frac{u_1 + v_1}{u + v} u_x,$$

$$v_{1x} = \left(1 + \frac{1}{\alpha}\right) \frac{v_1 - v}{u + v} u_x + v_x.$$
(19)

This system is Darboux integrable. Indeed, it has two independent non-trivial n- integrals (8), (9) and two independent non-trivial x-integrals

$$\mathcal{F}_1 = \frac{v - v_1}{v_1 - v_2} \qquad and \qquad \mathcal{F}_2 = \frac{u_1 - u}{(v_1 - v)^{\frac{\alpha}{1 + \alpha}}} - \alpha(v_1 - v)^{\frac{1}{1 + \alpha}}.$$
 (20)

The x-integrals can be found by considering the x-algebra corresponding to the system.

**Example 2** Considering  $K_1 = 0$  and  $\alpha = -1$  we get  $\mathcal{D}_1 = \frac{u_1 + v_1}{u_1 + v}$ . Using (16) we get the system

$$u_{1x} = \frac{u_1 + v}{u + v} u_x,$$

$$v_{1x} = \frac{u_1 + v_1}{u_1 + v} v_x.$$
(21)

This system is Darboux integrable. Indeed, it has two independent non-trivial n- integrals (8), (9) and two independent non-trivial x-integrals

$$\mathcal{F}_1 = \frac{(u_2 + v_1)(v - v_1)}{(u_1 + v_1)(v_1 - v_2)} \quad and \quad \mathcal{F}_2 = \frac{(u - u_1)(u_1 + v_1)}{(-u_1 + u_2)(u_1 + v)}.$$
(22)

Example 3 Considering  $K_1 = 0$  and  $\alpha = \frac{-1}{2}$  we get  $\mathcal{D}_1 = \frac{4u_1 + 2v_1}{v + \sqrt{v^2 + 16u_1^2 + 8u_1v_1}}$ . Using (16)

$$u_{1x} = \frac{u_1 + v_1}{u + v} \left( \frac{v + \sqrt{v^2 + 16u_1^2 + 8u_1v_1}}{4u_1 + 2v_1} \right)^2 u_x,$$
  

$$v_{1x} = -\left( \frac{v_1}{u + v} \left( \frac{v + \sqrt{v^2 + 16u_1^2 + 8u_1v_1}}{4u_1 + 2v_1} \right)^2 - \frac{v(4u_1 + 2v_1)}{(u + v)(v + \sqrt{v^2 + 16u_1^2 + 8u_1v_1})} \right) u_x \quad (23)$$
  

$$+ \frac{4u_1 + 2v_1}{v + \sqrt{v^2 + 16u_1^2 + 8u_1v_1}} v_x$$

This system has two independent non-trivial n- integrals (8) and (9).

**Example 4** Considering  $L_1 = 0$  and  $\alpha = \frac{-1}{2}$  we get  $\mathcal{D}_1 = \frac{v_1 + \sqrt{v_1^2 + 16u^2 + 8uv}}{2v + 4u}$ . Using (16) we get the system

$$u_{1x} = \frac{u_1 + v_1}{u + v} \left( \frac{2v + 4u}{v_1 + \sqrt{v_1^2 + 16u^2 + 8uv}} \right)^2 u_x,$$
  

$$v_{1x} = -\left( \frac{v_1}{u + v} \left( \frac{2v + 4u}{v_1 + \sqrt{v_1^2 + 16u^2 + 8uv}} \right)^2 - \frac{v(v_1 + \sqrt{v_1^2 + 16u^2 + 8uv})}{(u + v)(2v + 4u)} \right) u_x$$
(24)  

$$+ \frac{v_1 + \sqrt{v_1^2 + 16u^2 + 8uv}}{2v + 4u} v_x$$

This system has two independent non-trivial n- integrals (8) and (9).

**Remark 1** In both previous examples let us consider the corresponding x-rings. Denote by  $X = D_x$ ,  $Y_1 = \frac{\partial}{\partial u_x}$ ,  $Y_2 = \frac{\partial}{\partial v_x}$ ,  $E_1 = [Y_1, X]$ ,  $E_2 = [Y_2, X]$ ,  $E_3 = [E_1, E_2]$ . Note that  $X = u_x E_1 + v_x E_2 + Y_1 + Y_2$ . The following multiplication table

$[E_i, E_j]$	$E_1$	$E_2$	$E_3$
$E_1$	0	$E_3$	$-2(u+v)^{-1}E_3$
$E_2$	$-E_3$	0	$-2(u+v)^{-1}E_3$
$E_3$	$2(u+v)^{-1}E_3$	$2(u+v)^{-1}E_3$	0

shows that x-rings are finite-dimensional. Therefore systems (23) and (24) are Darboux integrable.

**Remark 2** Expansion of the function  $D_1^{\alpha^{-1}}$  given implicitly by  $H(K_1, L_1) = L_1 = 0$ , that is by

$$\alpha v_1 D_1^{\alpha^{-1}} - \alpha v D_1^{1+\alpha^{-1}} + (1 - D_1^{\alpha^{-1}})u_1 = 0,$$

into a series of the form  $D_1^{\alpha^{-1}}(u_1, v, v_1) = \sum_{n=0}^{\infty} a_n (v_1 - v)^n$ , where coefficients  $a_n$  depend on variables  $u_1$  and v only, yields

$$D_1^{\alpha^{-1}}(u_1, v, v_1) = 1 + \frac{\alpha}{u_1 + \alpha^2 v}(v_1 - v) + \sum_{n=2}^{\infty} a_n (v_1 - v)^n$$

and

$$D_1(u_1, v, v_1) = 1 + \frac{\alpha^2}{u_1 + \alpha^2 v} (v_1 - v) + \sum_{n=2}^{\infty} a_n (v_1 - v)^n.$$

By letting  $u_1 = u + \varepsilon u_y$ ,  $v_1 = v + \varepsilon v_y$  and taking  $\varepsilon \to 0$  one can see that the system (16) becomes (5).

**Theorem 2** A system (15) admits n-integrals (11) and (12) if and only if it has the form

$$u_{1x} = \frac{v(u_1v_1 + d)\mathcal{D}_2}{v_1(uv + d)}u_x,$$

$$v_{1x} = \frac{(d - c)vv_1(\mathcal{D}_2^2 - 1)}{2c(uv + d)\mathcal{D}_2}u_x + \frac{v_1}{v\mathcal{D}_2}v_x.$$
(25)

The function  $\mathcal{D}_2$  is given implicitly by  $H(K_2, L_2) = 0$ , where H is any smooth function and

$$K_{2} = \frac{v_{1}(\mathcal{D}_{2}-1)M^{-\frac{2d}{c+d}}}{v\mathcal{D}_{2}} \left(-2cdu_{1}v_{1}+uv\mathcal{D}_{2}M\right), \qquad L_{2} = \frac{v\mathcal{D}_{2}M^{\frac{2d}{c+d}}}{v_{1}}, \tag{26}$$

where

$$M = 2cd + \frac{(c+d)(\mathcal{D}_2 - 1)u_1v_1}{\mathcal{D}_2}.$$

Example 5 Considering  $K_2 = 0$  we can get  $\mathcal{D}_2 = \frac{(2cd + (c+d)uv)u_1v_1}{(2cd + (c+d)u_1v_1)uv}$ . Using (25) we get the

system

$$u_{1x} = \frac{u_1(u_1v_1 + d)(2cd + (c+d)uv)}{u(uv+d)(2cd + (c+d)u_1v_1)}u_x,$$

$$v_{1x} = \frac{(d-c)}{2c(uv+d)} \left\{ \frac{u_1 v_1^2 (2cd+(c+d)uv)}{u(2cd+(c+d)u_1v_1)} - \frac{uv^2 (2cd+(c+d)u_1v_1)}{u_1 (2cd+(c+d)uv)} \right\} u_x$$
(27)

$$+\frac{u(2cd+(c+d)u_{1}v_{1})}{u_{1}(2cd+(c+d)uv)}v_{x}.$$

This system has two independent non-trivial n- integrals (11) and (12). One can check that this system also has the following two n-integrals

$$I_2^* = \frac{(2cd + (c+d)uv)u_x}{u(uv+d)},$$
$$J_2^* = \frac{(c-d)uv^2u_x}{2c(uv+d)(2cd + (c+d)uv)} + \frac{uv_x}{2cd + (c+d)uv}$$

Considering the corresponding x-algebra we can also find x-integrals given by

$$\mathcal{F}_1 = \frac{u_1}{u} \left( \frac{2cd + (c+d)uv}{2cd + (c+d)u_1v_1} \right)^{\frac{c-a}{c+d}}, \qquad \mathcal{F}_2 = \frac{u_1v_1 - uv}{u_2v_2 - uv}.$$
(28)

**Example 6** Considering  $K_2 = 0$  we can also get  $\mathcal{D}_2 = \frac{(c+d)u_1v_1}{2cd + (c+d)u_1v_1}$ . Using (25) we get the system

$$u_{1x} = \frac{(c+d)u_1v(u_1v_1+d)}{(uv+d)(2cd+(c+d)u_1v_1)}u_x,$$

$$v_{1x} = \frac{(d-c)v}{2c(uv+d)} \left\{ \frac{(c+d)u_1v_1^2}{2cd+(c+d)u_1v_1} - \frac{2cd+(c+d)u_1v_1}{(c+d)u_1} \right\} u_x + \frac{2cd+(c+d)u_1v_1}{(c+d)u_1v}v_x.$$
(29)

This system has two independent non-trivial n- integrals (11) and (12) and two independent xintegrals

$$\mathcal{F}_1 = \frac{1}{c+d} \left( \frac{2cd + (c+d)u_1v_1}{vu_1} \right)^{\frac{c+d}{2d}} + \frac{u}{u_1} \left( \frac{2cd + (c+d)u_1v_1}{vu_1} \right)^{\frac{c-d}{2d}}$$

and

$$\mathcal{F}_2 = \frac{v_1 u_1^{\frac{d-c}{2d}} (2cd + (c+d)u_1v_1)^{\frac{c+d}{2d}}}{v^{\frac{c+d}{2d}} (2cd + (c+d)(u_1v_1 + u_2v_2))}.$$

**Remark 3** The expansion of the function  $D_2$  given implicitly by  $H(K_2, L_2) = L_2 - (2cd)^{2d/(c+d)} = 0$ into a series of the form  $D_2(u_1, v, v_1) = \sum_{n=0}^{\infty} a_n (v_1 - v)^n$ , where coefficients  $a_n$  depend on vari-

ables  $u_1$  and v only, yields  $D_2(u_1, v, v_1) = 1 + \frac{c}{v(uv+c)}(v_1 - v) + \sum_{n=2}^{\infty} a_n(v_1 - v)^n$ . By letting  $u_1 = u + \varepsilon u_y$ ,  $v_1 = v + \varepsilon v_y$  and taking  $\varepsilon \to 0$  one can see that the system (25) becomes (10) with  $\alpha = -1$ .

**Theorem 3** A system (15) admits n-integrals (13) and (14) if and only if it has form

$$u_{1x} = \frac{u_1 v_1 + d_1}{\mathcal{D}_3(uv + d)} u_x,$$

$$v_{1x} = \left(\frac{-\beta v_1^2}{\mathcal{D}_3(uv + d)} + \frac{\beta v^2 \mathcal{D}_3^\beta}{uv + d}\right) u_x + \mathcal{D}_3^\beta v_x.$$
(30)

The function  $\mathcal{D}_3$  is given implicitly by  $H(K_3, L_3) = 0$ , where H is any smooth function and

$$K_3 = \frac{(v_1 - v\mathcal{D}_3^\beta)^{\beta^{-1}}(d_1u - du_1\mathcal{D}_3)}{\mathcal{D}_3},\tag{31}$$

$$L_3 = (v_1 - v\mathcal{D}_3^\beta)^{(1-\beta)\beta^{-1}} (d_1\mathcal{D}_3^{\beta-1} - d_1 + (\beta - 1)u_1(v_1 - v\mathcal{D}_3^\beta)).$$
(32)

**Example 7** Considering  $K_3 = 0$  we can get  $\mathcal{D}_3 = \frac{v_1^{1/\beta}}{v^{1/\beta}}$ . Using (30) we get the system

$$u_{1x} = \frac{(u_1v_1 + d_1)v^{1/\beta}}{(uv+d)v_1^{1/\beta}}u_x,$$
(33)
$$\left(\begin{array}{ccc} \beta v_1^2 v^{1/\beta} & \beta v^2 v_1 \end{array}\right) = v_1$$

$$v_{1x} = \left\{ -\frac{\beta v_1^2 v^{1/\beta}}{v_1^{1/\beta} (uv+d)} + \frac{\beta v^2 v_1}{v(uv+d)} \right\} u_x + \frac{v_1}{v} v_x.$$

This system has two independent non-trivial n- integrals (13) and (14) and two independent xintegrals

$$\mathcal{F}_1 = \left(1 - \left(\frac{v_1}{v}\right)^{\frac{1-\beta}{\beta}}\right) \left(-d_1 u + du_1 \left(\frac{v_1}{v}\right)^{\frac{1}{\beta}}\right)^{\beta-1}$$

and

$$\mathcal{F}_2 = \frac{v^{\frac{1-\beta}{\beta}} - v_2^{\frac{1-\beta}{\beta}}}{v^{\frac{1-\beta}{\beta}} - v_1^{\frac{1-\beta}{\beta}}}.$$

One can check that this system also has the following two n-integrals

$$I_3^* = \frac{v^{1/\beta}u_x}{uv+d}, \qquad J_3^* = \frac{v_x}{v} + \frac{\beta v u_x}{uv+d}$$

**Example 8** Considering  $K_3 = 0$  we can also get  $\mathcal{D}_3 = \frac{d_1 u}{du_1}$ . Using (30) we get the system

$$u_{1x} = \frac{(u_1v_1 + d_1)du_1}{(uv + d)d_1u}u_x,$$

$$v_{1x} = \left\{-\frac{\beta dv_1^2 u_1}{d_1u(uv + d)} + \frac{\beta d_1^\beta v^2 u^\beta}{d^\beta u_1^\beta(uv + d)}\right\}u_x + \frac{d_1^\beta u^\beta}{d^\beta u_1^\beta}v_x.$$
(34)

This system has two independent non-trivial n- integrals (13) and (14) and two independent xintegrals

$$\mathcal{F}_{1} = \frac{d_{1}^{\beta} u^{\beta} v - d^{\beta} u_{1}^{\beta} v_{1}}{d_{2}^{\beta} u_{1}^{\beta} v_{1} - d_{1}^{\beta} u_{2}^{\beta} v_{2}}$$

and

$$\mathcal{F}_{2} = \frac{(d_{1}^{\beta}u^{\beta}v - d^{\beta}u_{1}^{\beta}v_{1})(dd_{1}^{\beta}u^{\beta}u - d_{1}d^{\beta}u_{1}^{\beta}u + (1-\beta)uu_{1})}{dd_{1}uu_{1}}.$$

One can check that this system also has the following two n-integrals

$$I_3^{**} = \frac{du_x}{u(uv+d)}, \qquad J_3^{**} = \frac{u^\beta v_x}{d^\beta} + \frac{\beta v^2 u^\beta u_x}{d^\beta (uv+d)},$$

**Example 9** Considering  $L_3 = 0$  with  $\beta = 2$  we get  $\mathcal{D}_3 = \frac{d_1 + R}{2u_1 v}$ , where

$$R = \sqrt{d_1^2 + 4u_1v(u_1v_1 - d_1)}.$$

Using (30) we get the system

$$u_{1x} = \frac{(u_1v_1 + d_1)(d_1 - R)}{2(uv + d)(d_1 - u_1v_1)}u_x,$$

$$v_{1x} = \left\{ \frac{v_1^2(R-d_1)}{d_1 - u_1 v_1} + \frac{d_1^2 + 2u_1 v(u_1 v_1 - d_1) + d_1 R}{u_1^2} \right\} \frac{u_x}{uv + d} + \frac{d_1^2 + 2u_1 v(u_1 v_1 - d_1) + d_1 R}{2u_1^2 v^2} v_x.$$
(35)

This system has two independent non-trivial n- integrals (13) and (14).

**Example 10** Considering  $L_3 = 0$  with  $\beta = 1/2$  we get  $\mathcal{D}_3^{1/2} = \frac{2d_1 + u_1v_1 + R}{2u_1v}$ , where

$$R = \sqrt{(2d_1 + u_1v_1)^2 - 8d_1u_1v_1}$$

Using (30) we get the system

$$u_{1x} = \frac{(u_1v_1 + d_1)(2d_1 + u_1v_1 - R)^2}{16d_1^2(uv + d)}u_x,$$

$$v_{1x} = \left\{\frac{-v_1^2(2d_1 + u_1v_1 - R)^2}{32d_1^2} + \frac{v(2d_1 + u_1v_1 + R)}{4u_1}\right\}\frac{u_x}{uv + d} + \frac{2d_1 + u_1v_1 + R}{2u_1v}v_x.$$
(36)

This system has two independent non-trivial n- integrals (13) and (14).

**Remark 4** In both previous examples the corresponding x-rings have the following multiplication table

$$\begin{array}{c|c|c} [E_i, E_j] & E_1 & E_2 & E_3 \\ \hline E_1 & 0 & E_3 & \frac{-2v}{d+uv}E_3 \\ \hline E_2 & -E_3 & 0 & \frac{-2u}{d+uv}E_3 \\ \hline E_3 & \frac{2v}{d+uv}E_3 & \frac{2u}{d+uv}E_3 & 0 \end{array}$$

where fields X,  $Y_1$ ,  $Y_2$ ,  $E_1$ ,  $E_2$  and  $E_3$  are introduced in the same way as in Remark 1. It shows that the x-rings are finite-dimensional and the corresponding systems are Darboux integrable.

**Remark 5** The expansion of the function  $D_3$  given implicitly by  $H(K_3, L_3) = L_3 = 0$  into a series of the form  $D_3(u_1, v, v_1) = \sum_{n=0}^{\infty} a_n (v_1 - v)^n$ , where coefficients  $a_n$  depend on variables  $u_1$  and v only, yields

$$D_3(u_1, v, v_1) = 1 + \frac{u_1}{\beta u_1 v - d_1}(v_1 - v) + \sum_{n=2}^{\infty} a_n (v_1 - v)^n.$$

By letting  $u_1 = u + \varepsilon u_y$ ,  $v_1 = v + \varepsilon v_y$  and taking  $\varepsilon \to 0$  one can see that the system (30) becomes (10). Note that  $\beta = -\alpha$ .

## 2 Proof of Theorem 1

It follows from the equality  $DJ_1 = J_1$  that

$$\frac{u_{1xx}}{u_{1x}} - \left(1 + \frac{1}{\alpha}\right)\frac{u_{1x}}{u_1 + v_1} - \frac{v_{1x}}{u_1 + v_1} = \frac{u_{xx}}{u_x} - \frac{(\alpha + 1)u_x + \alpha v_x}{\alpha(u + v)},\tag{37}$$

that is

$$\frac{f_x + f_u u_x + f_v v_x + f_{u_1} f + f_{v_1} g + f_{u_x} u_{xx} + f_{v_x} v_{xx}}{f} - \left(1 + \frac{1}{\alpha}\right) \frac{f}{u_1 + v_1} - \frac{g}{u_1 + v_1} = \frac{u_{xx}}{u_x} - \frac{(\alpha + 1)u_x + \alpha v_x}{\alpha(u + v)}.$$
(38)

By comparing the coefficients by  $v_{xx}$  and  $u_{xx}$ , we get  $f_{v_x} = 0$  and  $\frac{f_{u_x}}{f} = \frac{1}{u_x}$ . Hence

$$f(x, n, u, v, u_1, v_1, u_x, v_x) = A(x, n, u, v, u_1, v_1)u_x.$$
(39)

It follows from  $DI_1 = I_1$  that

$$\left(1+\frac{1}{\alpha}\right)v_1\left(\frac{Au_x}{u_1+v_1}\right)^{1-\alpha} - g\left(\frac{Au_x}{u_1+v_1}\right)^{-\alpha} = \left(1+\frac{1}{\alpha}\right)v\left(\frac{u_x}{u+v}\right)^{1-\alpha} - v_x\left(\frac{u_x}{u+v}\right)^{-\alpha}, \quad (40)$$

that is

$$g = \left(1 + \frac{1}{\alpha}\right) \left(\frac{Av_1}{u_1 + v_1} - \frac{vA^{\alpha}}{u + v} \left(\frac{u + v}{u_1 + v_1}\right)^{\alpha}\right) u_x + \left(A\frac{u + v}{u_1 + v_1}\right)^{\alpha} v_x.$$
(41)

By substituting the expressions for f and g into (38) and comparing the coefficients by  $v_x$ ,  $u_x$  and the free term we get

$$\frac{A_x}{A} = 0,$$

$$\frac{A_u}{A} + A_{u_1} + \left(1 + \frac{1}{\alpha}\right) \left[A_{v_1} \frac{v_1}{u_1 + v_1} - \frac{vA^{\alpha}A_{v_1}}{A(u + v)} \left(\frac{u + v}{u_1 + v_1}\right)^{\alpha} - \frac{A}{u_1 + v_1}\right]$$

$$\frac{Av_1}{Av_1} + \frac{vA^{\alpha}}{vA^{\alpha}} \left(u + v\right)^{\alpha} + \frac{1}{u_1} = 0$$
(42)

$$-\frac{Av_1}{(u_1+v_1)^2} + \frac{vA^{\alpha}}{(u+v)(u_1+v_1)} \left(\frac{u+v}{u_1+v_1}\right) + \frac{1}{u+v} = 0, \tag{43}$$

$$\frac{A_v}{A} + \frac{A_{v_1}A^{\alpha}}{A} \left(\frac{u+v}{u_1+v_1}\right)^{\alpha} - \frac{A^{\alpha}}{u_1+v_1} \left(\frac{u+v}{u_1+v_1}\right)^{\alpha} + \frac{1}{u+v} = 0.$$
(44)

Let

$$\mathcal{D}_1 = \left(\frac{u+v}{u_1+v_1}\right)^{\alpha} A^{\alpha}.$$
(45)

In terms of the function  $\mathcal{D}_1$  the equations (43) and (44) become

$$(u+v)\mathcal{D}_{1u} + (u_1+v_1)\mathcal{D}_1^{\alpha^{-1}}\mathcal{D}_{1u_1} + \frac{\alpha+1}{\alpha}(v_1\mathcal{D}_1^{\alpha^{-1}} - v\mathcal{D}_1)\mathcal{D}_{1v_1} - \mathcal{D}_1(\mathcal{D}_1^{\alpha^{-1}} - 1) = 0, \quad (46)$$

$$\frac{\mathcal{D}_{1v}}{\alpha} + \mathcal{D}_{1v} = 0 \quad (47)$$

$$\frac{\mathcal{I}_{1v}}{\mathcal{D}_{1}} + \mathcal{D}_{1v_{1}} = 0.$$
(47)

The set of solutions of the above system is not empty. For example,  $\mathcal{D}_1 = 1$  is one singular solution that leads to the Darboux integrable system (19). Let  $\mathcal{D}_1 \neq 1$ . For function  $W = W(u, v, u_1, v_1, \mathcal{D}_1)$  equations (46) and (47) become

$$(u+v)W_{u} + (u_{1}+v_{1})\mathcal{D}_{1}^{\alpha^{-1}}W_{u_{1}} + \frac{\alpha+1}{\alpha}(v_{1}\mathcal{D}_{1}^{\alpha^{-1}} - v\mathcal{D}_{1})W_{v_{1}} + \mathcal{D}_{1}(\mathcal{D}_{1}^{\alpha^{-1}} - 1)W_{\mathcal{D}_{1}} = 0, \quad (48)$$
$$\frac{W_{v}}{\mathcal{D}_{1}} + W_{v_{1}} = 0. \quad (49)$$

After the change of variables  $\tilde{v} = v$ ,  $\tilde{v}_1 = v_1 - v\mathcal{D}_1$ ,  $\tilde{u} = u$ ,  $\tilde{u}_1 = u_1$ ,  $\tilde{\mathcal{D}}_1 = \mathcal{D}_1$  equations above become

$$\begin{split} &(\tilde{u}+\tilde{v})W_{\tilde{u}}+(\tilde{u}_{1}+\tilde{v}_{1}+\tilde{v}\tilde{\mathcal{D}}_{1})\tilde{\mathcal{D}}_{1}^{\alpha^{-1}}W_{\tilde{u}_{1}}+((1+\frac{1}{\alpha})\tilde{v}_{1}\tilde{\mathcal{D}}_{1}^{\alpha^{-1}}+\frac{1}{\alpha}\tilde{v}(\tilde{\mathcal{D}}_{1}^{1+\alpha^{-1}}-\tilde{\mathcal{D}}_{1}))W_{\tilde{v}_{1}}\\ &+(\tilde{\mathcal{D}}_{1}^{1+\alpha^{-1}}-\tilde{\mathcal{D}}_{1})W_{\tilde{\mathcal{D}}_{1}}=0,\\ &W_{\tilde{v}}=0. \end{split}$$

We differentiate the first equation with respect to  $\tilde{v}$ , use  $W_{\tilde{v}} = 0$ , and get two new equations

$$W_{\tilde{u}} + \tilde{\mathcal{D}}_{1}^{1+\alpha^{-1}} W_{\tilde{u}_{1}} + \frac{1}{\alpha} (\tilde{\mathcal{D}}_{1}^{1+\alpha^{-1}} - \tilde{\mathcal{D}}_{1}) W_{\tilde{v}_{1}} = 0,$$
 (50)

$$\tilde{u}W_{\tilde{u}} + (\tilde{u}_1 + \tilde{v}_1)\tilde{\mathcal{D}}_1^{\alpha^{-1}}W_{\tilde{u}_1} + \frac{\alpha + 1}{\alpha}\tilde{v}_1\tilde{\mathcal{D}}_1^{\alpha^{-1}}W_{\tilde{v}_1} + (\tilde{\mathcal{D}}_1^{1+\alpha^{-1}} - \tilde{\mathcal{D}}_1)W_{\tilde{\mathcal{D}}_1} = 0.$$
(51)

After the change of variables  $u_1^* = \tilde{u}_1 - \tilde{\mathcal{D}}_1^{1+\alpha^{-1}}\tilde{u}, v_1^* = \alpha \tilde{\mathcal{D}}_1^{\alpha^{-1}}\tilde{v}_1 + (1 - \tilde{\mathcal{D}}_1^{\alpha^{-1}})\tilde{u}_1, u^* = \tilde{u}, v^* = \tilde{v}$ and  $\mathcal{D}_1^* = \tilde{\mathcal{D}}_1$  the last system becomes

$$W_{u^*} = 0,$$
  

$$\left( (\mathcal{D}_1^{*\alpha^{-1}} + \alpha^{-1}(1 - \mathcal{D}_1^{*-\alpha^{-1}}))u_1^* + \alpha^{-1}v_1^*\mathcal{D}_1^{*-\alpha^{-1}} \right) W_{u_1^*} + \frac{\alpha + 1}{\alpha}v_1^*\mathcal{D}_1^{*\alpha^{-1}}W_{v^*} + \mathcal{D}_1^*(\mathcal{D}_1^{*\alpha^{-1}} - 1)W_{\mathcal{D}_1^*} = 0.$$

The last equation has a general solution  $H(K_1, L_1) = 0$ , where  $K_1$ ,  $L_1$  (rewritten in old variables) are given by (17), (18) and H is any smooth function. Now, using the equalities (45), (39) and (41) we obtain the system (16).  $\Box$ 

# 3 Proof of Theorem 2

The equality  $DJ_2 = J_2$  implies

$$\frac{f_x + f_u u_x + f_v v_x + f_{u_1} f + f_{v_1} g + f_{u_x} u_{xx} + f_{v_x} v_{xx}}{f} + \frac{(d_1 - c_1)v_1 f - c_1 u_1 g}{c_1(u_1 v_1 + d_1)} = \frac{u_{xx}}{u_x} + \frac{(d - c)v u_x - c u v_x}{c(uv + d)}.$$
 (52)

By comparing the coefficients by  $u_{xx}$  and  $v_{xx}$  in the above equality we get  $f_{v_x} = 0$  and  $\frac{f_{u_x}}{f} = \frac{1}{u_x}$ . Hence

$$f = A(x, n, u, v, u_1, v_1)u_x.$$
(53)

Equality  $DI_2 = I_2$  implies

$$\frac{(d_1 - c_1)v_1^2 A^2 u_x}{2(u_1 v_1 + d_1)^2} - \frac{cAg}{u_1 v_1 + d_1} = \frac{(d - c)v^2 u_x}{2(uv + d)^2} - \frac{cv_x}{uv + d}.$$
(54)

It follows from (54) that

$$g = \left(\frac{(d_1 - c_1)v_1^2 A}{2c_1(u_1v_1 + d_1)} - \frac{(d - c)v_1^2(u_1v_1 + d_1)}{2c_1A(uv + d)^2}\right)u_x + \frac{c(u_1v_1 + d_1)}{c_1A(uv + d)}v_x.$$
(55)

By substituting the expressions for f and g into (52) and comparing the coefficients by  $u_x$ ,  $v_x$  and free term we get

$$\frac{A_{u}}{A} + A_{u_{1}} + \left(\frac{A_{v_{1}}}{A} - \frac{u_{1}}{u_{1}v_{1} + d_{1}}\right) \left(\frac{(d_{1} - c_{1})v_{1}^{2}A}{2c_{1}(u_{1}v_{1} + d_{1})} - \frac{(d - c)v^{2}(u_{1}v_{1} + d_{1})}{2c_{1}A(uv + d)^{2}}\right) \\
+ \frac{(d_{1} - c_{1})v_{1}A}{c_{1}(u_{1}v_{1} + d_{1})} - \frac{(d - c)v}{c(uv + d)} = 0,$$

$$\frac{A_{v}}{A} + \frac{c(u_{1}v_{1} + d_{1})}{c_{1}A(uv + d)} \left(\frac{A_{v_{1}}}{A} - \frac{u_{1}}{u_{1}v_{1} + d_{1}}\right) + \frac{u}{uv + d} = 0.$$
(56)

One can check that  $A = \frac{v(u_1v_1 + d)}{v_1(uv + d)}$  is a particular solution provided  $d_1 = d$  and  $c_1 = c$ . Now assuming that  $A \neq \frac{v(u_1v_1 + d)}{v_1(uv + d)}$  we introduce new function

$$\mathcal{D}_2 = \frac{v_1(uv+d)}{v(u_1v_1+d_1)}A.$$
(57)

In terms of  $\mathcal{D}_2$  the system (56) becomes

$$\mathcal{D}_{2x} = 0,$$
  

$$(uv+d)\mathcal{D}_{2u} + \frac{v(u_1v_1+d_1)\mathcal{D}_2}{v_1}\mathcal{D}_{2u_1} + \frac{vv_1}{2c_1}\left((d_1-c_1)\mathcal{D}_2 - (d-c)\mathcal{D}_2^{-1}\right)\mathcal{D}_{2v_1}$$
  

$$-\frac{dv}{c}\mathcal{D}_2 + \frac{(d_1+c_1)v}{2c_1}\mathcal{D}_2^2 + \frac{v(d-c)}{2c_1} = 0,$$
  

$$c_1v\mathcal{D}_2\mathcal{D}_{2v} + cv_1\mathcal{D}_{2v_1} + (-c\mathcal{D}_2 + c_1\mathcal{D}_2^2) = 0.$$

For function  $W = W(u, v, u_1, v_1, \mathcal{D}_2)$  the last two equations become

$$(uv+d)W_{u} + \frac{v(u_{1}v_{1}+d_{1})}{v_{1}}\mathcal{D}_{2}W_{u_{1}} + \frac{vv_{1}}{2c_{1}}\left((d_{1}-c_{1})\mathcal{D}_{2}-(d-c)\mathcal{D}_{2}^{-1}\right)W_{v_{1}} + \left(\frac{dv}{c}\mathcal{D}_{2} - \frac{(d_{1}+c_{1})v}{2c_{1}}\mathcal{D}_{2}^{2} - \frac{v(d-c)}{2c_{1}}\right)W_{\mathcal{D}_{2}} = 0,$$
  
$$c_{1}v\mathcal{D}_{2}W_{v} + cv_{1}W_{v_{1}} + (c\mathcal{D}_{2}-c_{1}\mathcal{D}_{2}^{2})W_{\mathcal{D}_{2}} = 0.$$

In new variables  $\tilde{u} = u$ ,  $\tilde{u_1} = u_1$ ,  $\tilde{v} = v(c_1\mathcal{D}_2 - c)$ ,  $\tilde{v_1} = v_1(c_1\mathcal{D}_2 - c)\mathcal{D}_2^{-1}$ ,  $\tilde{\mathcal{D}}_2 = \mathcal{D}_2$  the last system can be rewritten as

$$\left((c_{1}\tilde{\mathcal{D}}_{2}-c)\tilde{u}\tilde{v}+d(c_{1}\tilde{\mathcal{D}}_{2}-c)^{2}\right)W_{\tilde{u}}+\frac{\tilde{v}}{\tilde{v}_{1}}\left(\tilde{u}_{1}\tilde{v}_{1}\tilde{\mathcal{D}}_{2}(c_{1}\tilde{\mathcal{D}}_{2}-c)+d_{1}(c_{1}\tilde{\mathcal{D}}_{2}-c)^{2}\right)W_{\tilde{u}_{1}}$$
$$+\tilde{v}^{2}\left(\frac{c_{1}d\tilde{\mathcal{D}}_{2}}{c}-\frac{(d_{1}+c_{1})\tilde{\mathcal{D}}_{2}^{2}}{2}+\frac{c-d}{2}\right)W_{\tilde{v}}+\tilde{v}\tilde{v}_{1}\left(\frac{(d_{1}-c_{1})\tilde{\mathcal{D}}_{2}^{2}}{2}-\frac{cd_{1}\tilde{\mathcal{D}}_{2}}{c_{1}}+\frac{c+d}{2}\right)W_{\tilde{v}_{1}}=0,\ (58)$$
$$W_{\tilde{\mathcal{D}}_{2}}=0.$$

Special solutions of (58) may occur only when  $\tilde{\mathcal{D}}_2 = c_1/c$ . We differentiate equation (58) with respect to  $\tilde{\mathcal{D}}_2$  three times and get the following system of three equations

$$(dc^{2} - c\tilde{u}\tilde{v})W_{\tilde{u}} + c^{2}d_{1}\frac{\tilde{v}}{\tilde{v_{1}}}W_{\tilde{u_{1}}} + \frac{(c-d)\tilde{v}^{2}}{2}W_{\tilde{v}} + \frac{(c+d)\tilde{v}\tilde{v_{1}}}{2}W_{\tilde{v_{1}}} = 0,$$
(59)

$$(c_1\tilde{u}\tilde{v} - 2dc_1c)W_{\tilde{u}} - (2d_1c_1c\frac{\tilde{v}}{\tilde{v_1}} + c\tilde{u_1}\tilde{v})W_{\tilde{u_1}} + \frac{c_1d\tilde{v}^2}{c}W_{\tilde{v}} - \frac{cd_1\tilde{v}\tilde{v_1}}{c_1}W_{\tilde{v_1}} = 0,$$
(60)

$$dc_1^2 W_{\tilde{u}} + \left(\frac{d_1 c_1^2 \tilde{v}}{\tilde{v}_1} + c_1 \tilde{u}_1 \tilde{v}\right) W_{\tilde{u}_1} - \frac{(d_1 + c_1) \tilde{v}^2}{2} W_{\tilde{v}} + \frac{(d_1 - c_1) \tilde{v} \tilde{v}_1}{2} W_{\tilde{v}_1} = 0, \tag{61}$$

that has no solutions if  $c_1 \neq c$  or  $d_1 \neq d$ . In case of  $c_1 = c$  and  $d_1 = d$  the system becomes

$$W_{\tilde{u}} - \frac{\tilde{v}^2 (2c^2d + (c - d)\tilde{u}_1 \tilde{v}_1)}{2c(\tilde{u}\tilde{u}_1 \tilde{v}\tilde{v}_1 + cd(\tilde{u}\tilde{v} - \tilde{u}_1 \tilde{v}_1))} W_{\tilde{v}} - \frac{\tilde{v}\tilde{v}_1 (2c^2d + (c + d)\tilde{u}_1 \tilde{v}_1)}{2c(\tilde{u}\tilde{u}_1 \tilde{v}\tilde{v}_1 + cd(\tilde{u}\tilde{v} - \tilde{u}_1 \tilde{v}_1))} W_{\tilde{v}_1} = 0,$$
(62)

$$W_{\tilde{u}_{1}} - \frac{\tilde{v}\tilde{v}_{1}(-2c^{2}d + (c+d)\tilde{u}\tilde{v})}{2c(\tilde{u}\tilde{u}_{1}\tilde{v}\tilde{v}_{1} + cd(\tilde{u}\tilde{v} - \tilde{u}_{1}\tilde{v}_{1}))}W_{\tilde{v}} + \frac{\tilde{v}_{1}^{2}(2c^{2}d + (-c+d)\tilde{u}\tilde{v})}{2c(\tilde{u}\tilde{u}_{1}\tilde{v}\tilde{v}_{1} + cd(\tilde{u}\tilde{v} - \tilde{u}_{1}\tilde{v}_{1}))}W_{\tilde{v}_{1}} = 0.$$
(63)

After the change of variables  $u_1^* = \tilde{u}_1$ ,  $v_1^* = \tilde{v}_1$ ,  $v^* = \frac{\tilde{v}}{\tilde{v}_1} (2c^2d + (c+d)\tilde{u}_1\tilde{v}_1)^{\frac{2d}{c+d}}$ ,  $u^* = \tilde{u}\tilde{v}_1 (2c^2d + (c+d)\tilde{u}_1\tilde{v}_1)^{\frac{c-d}{c+d}} - 2c^2d\tilde{u}_1\tilde{v}_1^2\tilde{v}^{-1} (2c^2d + (c+d)\tilde{u}_1\tilde{v}_1)^{-\frac{2d}{c+d}}$  equations (62) and (63) become  $W_{v_1^*} = 0$  and  $W_{u_1^*} = 0$  respectively. We rewrite these first integrals in old variables and get that the general solution is given implicitly by  $H(K_2, L_2) = 0$ , where H is any smooth function and  $K_2$ ,  $L_2$  are given by (26). The form of system (25) follows from (53), (55) and (57).  $\Box$ 

### 4 Proof of Theorem 3

**Proof.** Equality  $DJ_3 = J_3$  implies

$$-\frac{f_x + f_u u_x + f_v v_x + f_{u_1} f + f_{v_1} g + f_{u_x} u_{xx} + f_{v_x} v_{xx}}{f} + \frac{2v_1 f + u_1 g}{u_1 v_1 + d_1} = -\frac{u_{xx}}{u_x} + \frac{2v u_x + u v_x}{uv + d}.$$
 (64)

By comparing the coefficients by  $u_{xx}$  and  $v_{xx}$  in the above equality we get  $f_{v_x} = 0$  and  $\frac{f_{u_x}}{f} = \frac{1}{u_x}$ . Hence

$$f = A(x, n, u, v, u_1, v_1)u_x.$$
(65)

Equality  $DI_3 = I_3$  implies

$$\frac{f^{\beta}g}{(u_1v_1+d_1)^{\beta}} + \frac{\beta v_1^2 f^{\beta+1}}{(u_1v_1+d_1)^{\beta+1}} = \frac{u_x^{\beta}v_x}{(uv+d)^{\beta}} + \frac{\beta v^2 u_x^{\beta+1}}{(uv+d)^{\beta+1}}.$$
(66)

Let

$$\mathcal{D}_3 = \frac{u_1 v_1 + d_1}{A(uv+d)}.$$
(67)

Then from (66) we get

$$g = \left(-\frac{\beta v_1^2}{\mathcal{D}_3(uv+d)} + \frac{\beta v^2 \mathcal{D}_3^\beta}{(uv+d)}\right) u_x + \mathcal{D}_3^\beta v_x.$$
(68)

The equality (64) in terms of  $\mathcal{D}_3$  takes the form

$$\frac{\mathcal{D}_{3x}}{\mathcal{D}_{3}} + \left(\frac{\mathcal{D}_{3u}}{\mathcal{D}_{3}} + \frac{u_{1}v_{1} + d_{1}}{\mathcal{D}_{3}^{2}(uv+d)}\mathcal{D}_{3u_{1}} + \frac{\beta(v^{2}\mathcal{D}_{3}^{\beta} - v_{1}^{2}\mathcal{D}_{3}^{-1})}{\mathcal{D}_{3}(uv+d)}\mathcal{D}_{3v_{1}} + \frac{v_{1}}{\mathcal{D}_{3}(uv+d)} - \frac{v}{(uv+d)}\right)u_{x} + \left(\frac{\mathcal{D}_{3v}}{\mathcal{D}_{3}} + \mathcal{D}_{3}^{\beta-1}\mathcal{D}_{3v_{1}}\right)v_{x} = 0. \quad (69)$$

By comparing the coefficients by  $u_x$ ,  $v_x$  and free term we get

$$\mathcal{D}_{3x} = 0, \tag{70}$$

$$\frac{uv+d}{\mathcal{D}_3}\mathcal{D}_{3u} + \frac{u_1v_1+d_1}{\mathcal{D}_3^2}\mathcal{D}_{3u_1} + \frac{\beta v^2 \mathcal{D}_3^\beta - \beta v_1^2 \mathcal{D}_3^{-1}}{\mathcal{D}_3}\mathcal{D}_{3v_1} + \frac{v_1}{\mathcal{D}_3} - v = 0,$$
(71)

$$\mathcal{D}_{3v} + \mathcal{D}_3{}^\beta \mathcal{D}_{3v_1} = 0. \tag{72}$$

In new variables  $\tilde{v}_1 = v_1 - v\mathcal{D}_3^\beta$ ,  $\tilde{v} = v$ ,  $\tilde{u} = u$ ,  $\tilde{u}_1 = u_1$ ,  $\tilde{\mathcal{D}}_3 = \mathcal{D}_3$  equations (72) and (71) can be rewritten for function  $W = W(\tilde{u}, \tilde{v}, \tilde{u}_1, \tilde{v}_1, \tilde{\mathcal{D}}_3)$  as follows

$$W_{\tilde{v}} = 0,$$
  
$$\tilde{\mathcal{D}}_{3}(\tilde{u}\tilde{v} + d)W_{\tilde{u}} + (\tilde{u}_{1}(\tilde{v}_{1} + \tilde{v}\tilde{\mathcal{D}}_{3}^{\ \beta}) + d_{1})W_{\tilde{u}_{1}} + \tilde{\mathcal{D}}_{3}(\tilde{v}(\tilde{\mathcal{D}}_{3} - \tilde{\mathcal{D}}_{3}^{\ \beta}) - \tilde{v}_{1})W_{\tilde{\mathcal{D}}_{3}} - \beta\tilde{v}_{1}(\tilde{v}_{1} + \tilde{v}\tilde{\mathcal{D}}_{3}^{\ \beta})W_{\tilde{v}_{1}} = 0$$

We differentiate the last equation with respect to  $\tilde{v}$ , use the fact that  $W_{\tilde{v}} = 0$  and get the new system of equations

$$\begin{split} \tilde{u}\tilde{\mathcal{D}}_{3}W_{\tilde{u}} + \tilde{u_{1}}\tilde{\mathcal{D}}_{3}^{\ \beta}W_{\tilde{u_{1}}} + (\tilde{\mathcal{D}}_{3}^{\ 2} - \tilde{\mathcal{D}}_{3}^{\ \beta+1})W_{\tilde{\mathcal{D}}_{3}} - \beta\tilde{v_{1}}\tilde{\mathcal{D}}_{3}^{\ \beta}W_{\tilde{v_{1}}} = 0, \\ d\tilde{\mathcal{D}}_{3}W_{\tilde{u}} + (\tilde{u_{1}}\tilde{v_{1}} + d_{1})W_{\tilde{u_{1}}} - \tilde{\mathcal{D}}_{3}\tilde{v_{1}}W_{\tilde{\mathcal{D}}_{3}} - \beta\tilde{v_{1}}^{2}W_{\tilde{v_{1}}} = 0, \end{split}$$

that can be rewritten as

$$W_{\tilde{u}} + \frac{d_{1}\tilde{\mathcal{D}}_{3} - d_{1}\tilde{\mathcal{D}}_{3}^{\ \beta} + \tilde{\mathcal{D}}_{3}\tilde{u}_{1}\tilde{v}_{1}}{d_{1}\tilde{u} - d\tilde{\mathcal{D}}_{3}^{\ \beta}\tilde{u}_{1} + \tilde{u}\tilde{u}_{1}\tilde{v}_{1}}W_{\tilde{\mathcal{D}}_{3}} - \frac{\beta d_{1}\tilde{v}_{1}\tilde{\mathcal{D}}_{3}^{\ \beta-1}}{d_{1}\tilde{u} - d\tilde{\mathcal{D}}_{3}^{\ \beta}\tilde{u}_{1} + \tilde{u}\tilde{u}_{1}\tilde{v}_{1}}W_{\tilde{v}_{1}} = 0,$$
$$W_{\tilde{u}_{1}} - \frac{\tilde{\mathcal{D}}_{3}(d\tilde{\mathcal{D}}_{3} - d\tilde{\mathcal{D}}_{3}^{\ \beta} + \tilde{u}\tilde{v}_{1})}{d_{1}\tilde{u} - d\tilde{\mathcal{D}}_{3}^{\ \beta}\tilde{u}_{1} + \tilde{u}\tilde{u}_{1}\tilde{v}_{1}}W_{\tilde{\mathcal{D}}_{3}} + \frac{\beta\tilde{v}_{1}(d\tilde{\mathcal{D}}_{3}^{\ \beta} - \tilde{u}\tilde{v}_{1})}{d_{1}\tilde{u} - d\tilde{\mathcal{D}}_{3}^{\ \beta}\tilde{u}_{1} + \tilde{u}\tilde{u}_{1}\tilde{v}_{1}}W_{\tilde{v}_{1}} = 0.$$

After the change of variables  $u^* = \tilde{u}\tilde{v_1}^{1/\beta}d_1^{1/(1-\beta)}\tilde{\mathcal{D}_3}^{-1} - dd_1^{\beta/(1-\beta)}\tilde{u_1}\tilde{v_1}^{1/\beta}$ ,  $\mathcal{D}_3^* = \tilde{v_1}^{(1-\beta)/\beta}\tilde{\mathcal{D}_3}^{\beta-1} - \tilde{v_1}^{(1-\beta)/\beta} + (\beta-1)d_1^{-1}\tilde{u_1}\tilde{v_1}^{1/\beta}$ ,  $u_1^* = \tilde{u_1}$ ,  $v^* = \tilde{v}$ ,  $v_1^* = \tilde{v_1}$  the last two equations become respectively  $W_{v_1^*} = 0$  and  $W_{u_1^*} = 0$ . We rewrite these first integrals in old variables and get that general solution is given implicitly by  $H(K_3, L_3) = 0$ , where H is any smooth function and  $K_3$ ,  $L_3$  are given by (31), (32). The form of system (30) follows from (65), (68) and (67).  $\Box$
