

COSECTION LOCALIZATION AND VANISHING FOR VIRTUAL FUNDAMENTAL CLASSES OF D-MANIFOLDS

ABSTRACT. We establish cosection localization and vanishing results for virtual fundamental classes of derived manifolds, combining the theory of derived differential geometry by Joyce with the theory of cosection localization by Kiem-Li. As an application, we show that the stable pair invariants of hyperkähler fourfolds, defined by Cao-Maulik-Toda, are zero.

1. INTRODUCTION

The study of coherent sheaves and vector bundles on Calabi-Yau manifolds has been a long-standing subject of interest in mathematics and theoretical physics.

From the point of view of enumerative geometry, the virtual counts of coherent sheaves on Calabi-Yau threefolds are known as Donaldson-Thomas invariants and were first introduced by Thomas [Tho00]. He showed that moduli spaces of stable sheaves admit a perfect obstruction theory [BF97] and thus a virtual fundamental cycle [BF97, LT98]. These moduli spaces enjoy many rich structures and the invariants and their generalizations and refinements have been extensively studied (for a far from exhaustive list of references, cf. [Beh09, JS12, KS10, BBJ19, BBD⁺15, Oko19, KLS17, Sav20, KS21]).

Suppose now that W is a smooth, projective complex Calabi-Yau fourfold (meaning that its canonical bundle is trivial, $K_W \cong \mathcal{O}_W$) and X a proper moduli scheme parameterizing stable sheaves on W with fixed determinant. In this case, the deformations and (higher) obstructions for a sheaf E on W

are controlled by the groups

$$\mathrm{Ext}^1(E, E)_0, \mathrm{Ext}^2(E, E)_0, \mathrm{Ext}^3(E, E)_0$$

and thus the natural candidate complex for a perfect obstruction theory has three terms, making the results of [Beh09, LT98] and the theory of virtual fundamental cycles not directly applicable.

In order to define Donaldson-Thomas invariants, Cao-Leung [CC14] first suggested a gauge-theoretic approach, which produces invariants in certain cases. Later, in their seminal paper [BJ17], Borisov-Joyce generalized this approach to define invariants in great generality, making crucial use of the fact that X is the truncation of a (-2) -shifted symplectic derived scheme [PTVV13] and using the theory of derived differential geometry [Joy]. The virtual fundamental classes they define are thus of differential and not algebraic nature and depend on a choice of orientation, which exists by [CGJ20]. In [OT20, OT], Oh-Thomas develop a definition strictly within the realm of algebraic geometry and prove that their virtual fundamental cycle coincides with the class of Borisov-Joyce.

Computing Donaldson-Thomas invariants and invariants of Donaldson-Thomas type for Calabi-Yau fourfolds has attracted significant interest recently, cf. [CK18, CK20, CKM19, CKM20, CT19, CT21, Cao20, CMT22, CMT18].

One of the most important methods in handling such invariants in algebraic geometry has been the localization of virtual fundamental cycles by cosections introduced by Kiem-Li [KL13].

The purpose of this paper is to establish cosection localization and vanishing results for the virtual fundamental class appearing in the context of Borisov-Joyce, which will aid in working with these invariants, and at the same time enhance our understanding of virtual classes in the context of derived differential geometry. To do so, we combine the theory of derived manifolds by Joyce [Joy] with the analytic and topological versions of cosection localization by Kiem-Li [KL07, KL13, KL20]. The corresponding algebraic theory for the virtual fundamental cycle constructed by Oh-Thomas has recently been developed by Kiem-Park in [KP20]. We expect that our localized virtual fundamental class coincides with the one constructed by Kiem-Park under the appropriate comparison result proved in [OT].

Statement of results. Here we give brief statements of our main results. These fall into three categories depending on the assumptions made: vanishing of the virtual fundamental class in the presence of a surjective weak real cosection, localization by a real cosection, and localization by complex cosections which “come from geometry”.

We have the following vanishing result.

Theorem (Theorem 4.3). *Let \mathcal{X} be a compact, oriented d -manifold with a continuous family of surjective \mathbb{R} -linear maps $\sigma_x: h^1(\mathbb{T}_{\mathcal{X}|_x}) \rightarrow \mathbb{R}$ and underlying topological space X . Then its virtual fundamental class is zero, i.e. $[\mathcal{X}]^{\mathrm{vir}} = 0 \in H_{\mathrm{vir.dim.}}(X)$.*

This statement is essentially already embedded in the literature, following from the definition of the virtual fundamental class of \mathcal{X} given in [Joy].

More generally, when a d-manifold admits a real cosection, we may localize the virtual fundamental class to its degeneracy locus.

Theorem (Theorem 5.3). *Let \mathcal{X} be a compact, oriented d-manifold with underlying topological space X , equipped with a real cosection $\sigma: h^1(\mathbb{T}_{\mathcal{X}}|_X) \rightarrow \mathbb{R}_X$ (cf. Definition 4.1). Let $X(\sigma)$ be the locus where σ is not surjective and $i: X(\sigma) \rightarrow X$ be the inclusion map. Then the virtual fundamental class localizes to $X(\sigma)$, i.e. there exists a cosection localized virtual fundamental class $[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} \in H_{\text{vir.dim.}}(X(\sigma))$ satisfying*

$$i_*[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} = [\mathcal{X}]^{\text{vir}} \in H_{\text{vir.dim.}}(X).$$

In [BJ17], the virtual fundamental class of a (-2) -shifted symplectic derived scheme $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ is obtained by truncating $\underline{\mathcal{X}}$ in a suitable way to produce an associated d-manifold \mathcal{X}_{dm} and then taking its virtual fundamental class. In this setting, using the above theorems gives the following vanishing and localization results for cosections on $\underline{\mathcal{X}}$ that are non-degenerate with respect to the symplectic form, since we can show that such cosections induce cosections on \mathcal{X}_{dm} which are surjective on their non-degeneracy locus.

Theorem (Theorem 4.6, Theorem 5.3). *Let $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ be a proper, oriented (-2) -shifted symplectic derived scheme with a cosection $\sigma: \mathbb{T}_{\underline{\mathcal{X}}}|_X[1] \rightarrow \mathcal{O}_X$ (cf. Definition 4.4).*

If σ is non-degenerate on $\underline{\mathcal{X}}$, then the virtual fundamental class vanishes, i.e. $[\mathcal{X}_{dm}]^{\text{vir}} = 0 \in H_{\text{vir.dim.}}(X)$.

More generally, the virtual fundamental class localizes to the degeneracy locus $X(\sigma)$ of σ , so that there exists a cosection localized class $[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} \in H_{\text{vir.dim.}}(X(\sigma))$ satisfying

$$i_*[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} = [\mathcal{X}]^{\text{vir}} \in H_{\text{vir.dim.}}(X),$$

where $i: X(\sigma) \rightarrow X$ denotes the inclusion.

As a corollary, we obtain the vanishing of stable pair invariants of hyperkähler fourfolds.

Corollary (Theorem 7.2, [CMT22, Claim 2.19]). *Let $P_n(W, \beta)$ be the moduli space parameterizing stable pairs $I = [\mathcal{O}_W \xrightarrow{s} F]$ on a hyperkähler fourfold W satisfying $[F] = \beta \in H_2(W)$, $\chi(F) = n$. If $\beta \neq 0$ or $n \neq 0$, then the virtual fundamental class is zero, i.e. $[P_n(W, \beta)]^{\text{vir}} = 0$.*

Finally, when a derived manifold \mathcal{X} and a cosection σ satisfy conditions bringing them closer to being complex analytic or obtained from analytic or algebraic data, we show that can localize the virtual fundamental class by the cosection in a more explicit way of algebraic flavor (Theorem-Definition 6.7).

Layout of the paper. In §2, we provide necessary background on d-manifolds, (-2) -shifted symplectic schemes and their relationship. §3 contains material on the topological definition of normal cones and the virtual fundamental class of a d-manifold. In §4 we establish vanishing results for surjective real cosections and in §5 we treat the general case of real cosections making use of the results of §4, especially for their application in derived symplectic algebraic geometry. In §6 we study complex cosections

coming from geometry in more detail. Finally, in §7 we obtain the vanishing of stable pair invariants of hyperkähler fourfolds.

Notation and conventions. For topological purposes, we work with Borel-Moore homology and singular (co)homology with integer coefficients. These are equal for compact spaces and afford us the necessary flexibility to work with fundamental classes of (non)compact spaces. We refer the reader to [Bre97, Ive86] for a comprehensive treatment.

We work with the theory of \mathcal{C}^∞ -schemes and derived manifolds developed by Joyce [Joy]. In analogy to usual smooth manifolds, our \mathcal{C}^∞ -schemes will be separated, second countable and locally fair, meaning that their underlying topological space is Hausdorff, second countable and they are locally modelled by the spectrum of a finitely generated \mathcal{C}^∞ -ring. By definition, such \mathcal{C}^∞ -schemes can be the underlying scheme of a d-manifold. Unless otherwise stated, the underlying topological spaces of \mathcal{C}^∞ -schemes and d-manifolds are assumed to be Euclidean Neighbourhood Retracts (ENR) for simplicity. This is automatically the case for the complex analytic spaces or algebraic schemes appearing throughout the paper.

All algebraic and derived schemes are defined over the field of complex numbers \mathbb{C} . Classical and derived algebraic schemes and complex analytic spaces are separated and of finite type. The reader can consult [Toë14] for more general background on derived algebraic geometry and shifted symplectic structures or [BJ17] for the necessary material for our applications.

$\underline{\mathcal{X}}$ will typically denote a derived scheme and $\omega_{\underline{\mathcal{X}}}$ a (-2) -shifted symplectic form on $\underline{\mathcal{X}}$. \mathcal{X} will typically denote a d-manifold and $X_{\mathcal{C}^\infty}$ its underlying \mathcal{C}^∞ -scheme. X will always denote the underlying topological space of $\underline{\mathcal{X}}$ or \mathcal{X} and sometimes, by abuse of notation, the classical truncation of $\underline{\mathcal{X}}$ as well. In that case, X^{an} denotes the complex analytic space associated to classical truncation X of $\underline{\mathcal{X}}$. These distinctions will be explicitly stated or should be clear from context throughout the paper. In general, we typically use the notation $X_{\mathcal{C}^\infty}$ when we need to use the existence of quasicoherent sheaves on a \mathcal{C}^∞ -scheme, whereas we only consider homology groups of the underlying topological spaces.

2. BACKGROUND ON D-MANIFOLDS AND (-2) -SHIFTED SYMPLECTIC DERIVED SCHEMES

In this section, we collect some requisite background and introduce terminology that will be used in the rest of the paper.

2.1. \mathcal{C}^∞ -schemes and d-manifolds. The main references for the theory of \mathcal{C}^∞ -schemes and d-manifolds are the books [Joy19] and [Joy] by Joyce. Here we give a brief informal account of their structure.

Roughly speaking, under the conventions of this paper, a \mathcal{C}^∞ -scheme is a locally ringed space that is locally isomorphic to the (real) spectrum of the \mathcal{C}^∞ -ring $\mathcal{C}^\infty(\mathbb{R}^n)/I$, where I is an ideal of smooth functions on \mathbb{R}^n . There

is a theory of (quasi)coherent sheaves and vector bundles on \mathcal{C}^∞ -schemes, which resembles that of sheaves on algebraic schemes.

D-manifolds form a theory of derived differential geometry being analogous to quasi-smooth derived or dg-schemes. Their local structure is given as follows.

Definition 2.1. [Joy, Example 1.4.4] *A principal d-manifold $\mathcal{X} = \mathcal{S}_{Y,E,s}$ is determined by the data of a smooth manifold Y , a smooth vector bundle $E \rightarrow Y$ and $s \in \mathcal{C}^\infty(E)$ as follows: Its underlying \mathcal{C}^∞ -scheme $X_{\mathcal{C}^\infty}$ is the affine scheme obtained as the spectrum of the \mathcal{C}^∞ -ring $\mathcal{C}^\infty(Y)/I$, where $I = (s)$ is the ideal generated by the section s . The higher data are given by the morphism $E^\vee|_{X_{\mathcal{C}^\infty}} \xrightarrow{s^\vee} I/I^2$ of $\mathcal{O}_{X_{\mathcal{C}^\infty}}$ -modules, so that the underlying topological space X is the zero locus of the section s . The tangent complex (or virtual tangent bundle) of \mathcal{X} is the two-term complex*

$$\mathbb{T}_{\mathcal{X}} = [T_Y|_{X_{\mathcal{C}^\infty}} \xrightarrow{ds} E|_{X_{\mathcal{C}^\infty}}]$$

where for any choice of connection ∇ on E^\vee , ds is the restriction to $X_{\mathcal{C}^\infty}$ of $\nabla s: T_Y \rightarrow E$.

In general, every d-manifold \mathcal{X} is locally equivalent to a principal d-manifold. When \mathcal{X} is compact (i.e. its underlying topological space is compact), Joyce proves a Whitney embedding theorem, which in particular implies that this is true globally. Since we will be fundamentally interested in compact d-manifolds in this paper, this allows us in practice to consider the case of principal d-manifolds, which are a considerable simplification.

Theorem-Definition 2.2. [Joy, Theorems 4.29, 4.34] *Let \mathcal{X} be a compact d-manifold. Then $\mathcal{X} \simeq \mathcal{S}_{Y,E,s}$ where Y is an open subset of some Euclidean space \mathbb{R}^N . We refer to this equivalence as a presentation of \mathcal{X} as a principal d-manifold. The virtual dimension of \mathcal{X} is then equal to $N - \text{rk } E$.*

In analogy with the case of quasi-smooth derived schemes or schemes with a perfect obstruction theory [BF97], we give the following definition.

Definition 2.3. *The obstruction sheaf of \mathcal{X} is the coherent sheaf $\text{Ob}_{\mathcal{X}} := h^1(\mathbb{T}_{\mathcal{X}}) \in \text{Coh}(X_{\mathcal{C}^\infty})$, where $\mathbb{T}_{\mathcal{X}}$ is the tangent complex of \mathcal{X} .*

Finally we mention that there is a notion of orientation for a d-manifold \mathcal{X} , which in the case of a principal d-manifold $\mathcal{S}_{Y,E,s}$ roughly amounts to an orientation of the determinant line bundle $\det \mathbb{T}_{\mathcal{X}}$. As in the case of manifolds, compact, oriented d-manifolds admit a virtual fundamental class.

Theorem 2.4. [Joy, Section 13] *Let \mathcal{X} be a compact, oriented d-manifold with underlying topological space X . Then there exists a virtual fundamental class $[\mathcal{X}]^{\text{vir}} \in H_{\text{vir.dim.}}(X)$. Moreover, $[\mathcal{X}]^{\text{vir}}$ only depends on the bordism class of \mathcal{X} .*

2.2. (−2)-shifted symplectic derived schemes. In this subsection, we establish some terminology and describe local structure results that will be used in the rest of the paper. For an introduction to derived algebraic geometry, we refer the reader to [Toë14]. Shifted symplectic structures were introduced in the seminal paper [PTVV13].

In a nutshell, a derived scheme $\underline{\mathcal{X}}$ is locally modelled by the (derived) spectrum $\mathbf{Spec} A$ where A is a commutative differential (negatively) graded \mathbb{C} -algebra. A (-2) -shifted symplectic structure on $\underline{\mathcal{X}}$ is given by a 2-form

$$\omega_{\underline{\mathcal{X}}}: \mathbb{T}_{\underline{\mathcal{X}}} \wedge \mathbb{T}_{\underline{\mathcal{X}}} \longrightarrow \mathcal{O}_{\underline{\mathcal{X}}}[-2]$$

which is non-degenerate and is equipped with extra data that make it closed.

A (-2) -shifted symplectic scheme is a pair $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ consisting of a derived scheme $\underline{\mathcal{X}}$ and a symplectic structure on it. There is also an appropriate notion of orientation on a (-2) -shifted symplectic scheme (cf. [BJ17]). Given the above, we introduce the following terminology.

Definition 2.5. *The obstruction sheaf of $\underline{\mathcal{X}}$ is the sheaf $\mathcal{O}b_{\underline{\mathcal{X}}} = h^1(\mathbb{T}_{\underline{\mathcal{X}}}|_X)$. The obstruction space of $\underline{\mathcal{X}}$ at a point $x \in \underline{\mathcal{X}}$ is the vector space $\mathcal{O}b(\underline{\mathcal{X}}, x) = h^1(\mathbb{T}_{\underline{\mathcal{X}}}|_x)$.*

In particular, the symplectic form $\omega_{\underline{\mathcal{X}}}$ induces a family of non-degenerate quadratic forms $q_x: \mathcal{O}b(\underline{\mathcal{X}}, x) \rightarrow \mathbb{C}$.

We conclude this subsection with a local description of (-2) -shifted symplectic schemes that will be essential later on. In [BBJ19], the local structure of $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ around every point $x \in X$ is described by charts in Darboux form as follows.

Theorem-Definition 2.6. [BBJ19, Example 5.16] *Let $x \in \underline{\mathcal{X}}$ be a point of a (-2) -shifted symplectic derived scheme $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$. Then there exists a Zariski open neighbourhood $\underline{U} = \mathbf{Spec} A \rightarrow \underline{\mathcal{X}}$ around x such that:*

- (1) (A, δ) is a commutative differential graded algebra, whose degree zero part A^0 is a smooth \mathbb{C} -algebra of dimension m , with a set of étale coordinates $\{x_i\}_{i=1}^m$.
- (2) A is freely generated over A^0 by variables $\{y_j\}_{j=1}^n$ and $\{z_i\}_{i=1}^m$ in degrees -1 and -2 respectively.
- (3) Let ω_A be the pullback of $\omega_{\underline{\mathcal{X}}}$ to $\mathbf{Spec} A$. There exist invertible elements $q_1, \dots, q_n \in A^0$ such that

$$\omega_A = \sum_{i=1}^m dz_i dx_i + \sum_{j=1}^n d(q_j y_j) dy_j.$$

- (4) The differential δ is determined by the equations

$$\delta x_i = 0, \quad \delta y_j = s_j, \quad \delta z_i = \sum_{j=1}^n y_j \left(2q_j \frac{\partial s_j}{\partial x_i} + s_j \frac{\partial q_j}{\partial x_i} \right)$$

where the elements $s_j \in A^0$ satisfy

$$q_1 s_1^2 + \dots + q_n s_n^2 = 0.$$

We let $V = \mathbf{Spec} A^0$, E the trivial vector bundle of rank n whose dual has basis given by the variables y_j and F the trivial vector bundle whose dual has basis given by the variables z_i . We refer to all of the above data as a derived algebraic Darboux chart for $\underline{\mathcal{X}}$ at x .

At the classical level, the truncation $U = h^0(\underline{U}) \subset X$ is equipped with the following data:

- (1) A smooth affine scheme V of dimension m .

- (2) A trivial vector bundle E on V of rank n with a non-degenerate quadratic form q which is given by

$$q_u(y_1, \dots, y_n) = q_1(u)y_1^2 + \dots + q_n(u)y_n^2$$

on each fiber of E over $u \in U$.

- (3) A q -isotropic section $s \in \Gamma(E)$ whose scheme-theoretic zero locus is $U \subset V$.
- (4) A three-term perfect complex of amplitude $[0, 2]$

$$G := \mathbb{T}_U|_U = [T_V|_U \xrightarrow{ds} E|_U \xrightarrow{t} F|_U].$$

such that q_u gives a non-degenerate quadratic form on each obstruction space $h^1(G|_u) = \mathcal{O}b(\underline{\mathcal{X}}, u)$.

We refer to the data (V, E, G, q, s) as an algebraic Darboux chart for X at x .

By working in the complex analytic category, since the functions q_j are non-zero at x , by possibly shrinking V around x , they admit square roots $q_j = r_j^2$ and after re-parametrizing $y_j \mapsto \frac{y_j}{r_j}$ we may assume that $q_j(u) = 1$. We then refer to the data (V, E, G, q, s) as an analytic Darboux chart for X at x .

Different Darboux charts glue and thus are compatible through appropriate data of homotopical nature. These compatibilities are important, however we will not need them explicitly. Knowing that they exist and that local constructions play well with them (which is ensured by the results we quote) will be sufficient for our purposes.

2.3. From (-2) -shifted symplectic schemes to d-manifolds. Consider a (-2) -shifted symplectic derived scheme $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$. Let $X = h^0(\underline{\mathcal{X}})$ be its classical truncation and, by abuse of notation, we write X for the underlying topological space as well.

In this subsection, we briefly recall the main results of [BJ17], where the authors produce a (non-uniquely determined) d-manifold \mathcal{X}_{dm} associated to $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ and thus a virtual fundamental class $[\mathcal{X}_{dm}]^{\text{vir}} \in H_*(X)$.

In order to construct a d-manifold starting with a (-2) -shifted symplectic derived scheme, it is necessary to take appropriate (real smooth) truncations of Darboux charts.

Definition 2.7. [BJ17, Definition 3.6] *Let (V, E, G, q, s) be data of an analytic Darboux chart for X at the point x . We say that a real subbundle $E^- \subset E$ is q -adapted if for all $u \in U$ the following conditions are met:*

- (1) $\text{im}(ds|_u) \cap E^-|_u = \{0\} \subset E|_u$.
- (2) $t|_u(E^-|_u) = t|_u(E|_u) \subset F|_u$.
- (3) *The image of the linear map*

$$\Pi_u: \ker(t|_u) \cap E^-|_u \longrightarrow \ker(t|_u) \longrightarrow h^1(G|_u) = \mathcal{O}b(\underline{\mathcal{X}}, u)$$

is a real maximal negative definite vector subspace of $\mathcal{O}b(\underline{\mathcal{X}}, u)$ with respect to the quadratic form $\text{Re } q_u$.

Here is a (very) brief outline of the steps involved in the construction of the d-manifold \mathcal{X}_{dm} .

Construction 2.8.

- (1) $(\mathcal{X}, \omega_{\mathcal{X}})$ admits a cover by derived algebraic Darboux charts, which are compatible in a suitable homotopy-theoretic sense.
- (2) The classical truncation of these charts gives a cover of X by analytic Darboux charts.
- (3) For each such chart (V, E, G, q, s) at a point $x \in X$, up to possible shrinking of V around x , there exists a q -adapted $E^- \subset E$. Fix any such choice and let $E^+ = E/E^-$ and $s^+ = s \bmod E^-$.
- (4) Using the compatibility data between the derived algebraic Darboux charts, the principal d -manifolds $\mathcal{S}_{V, E^+, s^+}$ glue to a d -manifold \mathcal{X}_{dm} with underlying topological space X^{an} .

Moreover, orientations of $(\mathcal{X}, \omega_{\mathcal{X}})$ are in bijection with orientations of \mathcal{X}_{dm} . Thus a proper, oriented $(\mathcal{X}, \omega_{\mathcal{X}})$ gives rise to a compact, oriented d -manifold \mathcal{X}_{dm} and a virtual fundamental class $[\mathcal{X}_{dm}]^{\text{vir}} \in H_*(X)$.

A priori, depending on the choices of q -adapted subbundles $E^- \subset E$, there are many possibilities for the d -manifold \mathcal{X}_{dm} produced by this process. However, it is shown in [BJ17] that all such d -manifolds have the same bordism class and therefore must have the same virtual fundamental class. We record this in the following proposition.

Proposition 2.9. [BJ17, Corollary 3.19] *The virtual fundamental class $[\mathcal{X}_{dm}]^{\text{vir}} \in H_*(X)$ associated to a proper, oriented (-2) -shifted symplectic derived scheme $(\mathcal{X}, \omega_{\mathcal{X}})$ is independent of any choices involved in the construction of the d -manifold \mathcal{X}_{dm} and thus canonical.*

3. NORMAL CONES AND VIRTUAL FUNDAMENTAL CLASSES

In this short section, we first briefly recall a topological version of the algebraic intrinsic normal cone [BF97] and its basic properties, following [Sie99, Section 3]. We then use the normal cone to give an alternative definition of the virtual fundamental class of a compact, oriented d -manifold \mathcal{X} , which is equivalent to the one given in [Joy].

3.1. Topological and homological normal cone. Let Y be an oriented, topological manifold of dimension N and E a topological vector bundle on Y with projection map $q: E \rightarrow Y$. Let furthermore s be a continuous section of E with zero locus $X = Z(s) \subset Y$.

For any $\ell > 0$, let $p_{\ell}: Y \times \mathbb{R}^{\ell} \rightarrow Y$ be the projection and define a section $s_{\ell} \in \Gamma(Y \times (\mathbb{R}^{\ell} \setminus \{0\}), p_{\ell}^*E)$ by the formula

$$s_{\ell}(y, v) = |v|^{-1} \cdot s(y).$$

Let $\bar{\Gamma}_{s_{\ell}} \subset p_{\ell}^*E$ denote the closure of the graph of s_{ℓ} in p_{ℓ}^*E .

Theorem-Definition 3.1. [Sie99, Definition 3.1, Proposition 3.2] *The topological normal cone $C(s) \subset E$ associated to s is defined as*

$$(3.1) \quad C(s) = \bar{\Gamma}_{s_{\ell}} \cap (E \times \{0\}).$$

This is independent of ℓ and satisfies:

- (1) $C(s) = \lim_{t \rightarrow \infty} \Gamma_{t, s}$, where $C(s)$ and $\Gamma_{t, s}$ are considered as closed subsets of E .

(2) $C(s)$ lies over X and $q(C(s)) = X$.

The long exact sequence in homology gives

$$H_{N+\ell}(C(s)) \longrightarrow H_{N+\ell}(\overline{\Gamma}_{s_\ell}) \longrightarrow H_{N+\ell}(\Gamma_{s_\ell}) \longrightarrow H_{N+\ell-1}(C(s))$$

and therefore for large enough ℓ the two outer homology groups vanish and the homology class

$$(s_\ell)_*[Y \times (\mathbb{R}^\ell \setminus \{0\})] \in H_{N+\ell}(\Gamma_{s_\ell})$$

gives rise to a fundamental class

$$(3.2) \quad [\overline{\Gamma}_{s_\ell}] \in H_{N+\ell}(\overline{\Gamma}_{s_\ell}).$$

Here we have chosen an orientation of \mathbb{R}^ℓ . This choice will not affect the homological normal cone, defined below.

Let $\delta_0 \in H_{\{0\}}^\ell(\mathbb{R}^\ell)$ be Poincaré dual to $\{0\} \subset \mathbb{R}^\ell$ and $q_\ell: p_\ell^*E \rightarrow \mathbb{R}^\ell$ be the projection.

Theorem-Definition 3.2. [Sie99, Definition 3.3, Proposition 3.4] *The homological normal cone associated to s is defined as*

$$(3.3) \quad [C(s)] = [\overline{\Gamma}_{s_\ell}] \cap q_\ell^* \delta_0 \in H_N(C(s)).$$

It is independent of ℓ and satisfies $[C(s)] = [\Gamma_{t \cdot s}] \in H_N(E)$ for any $t \neq 0$.

Remark 3.3. *The homological normal cone should be regarded as the fundamental class of $C(s)$. This is motivated by the fact that formula (3.1) can obviously be equivalently written as $C(s) = \overline{\Gamma}_{s_\ell} \cap q_\ell^{-1}(0)$.*

Finally, we remark that the topological normal cone is compatible with the intrinsic normal cone used in complex algebraic geometry. Suppose that Y is a complex manifold, E is a holomorphic vector bundle and s a holomorphic section. Let I be the ideal sheaf of X in Y . The normal cone of X associated to s is then defined as

$$C_{X/Y} = \text{Spec}_{\mathcal{O}_X} \left(\bigoplus_{n \geq 0} I^n / I^{n+1} \right)$$

and is a closed subcone of the vector bundle E . Here Spec is used to stand for MaxSpec , so that as a topological space the points of $C_{X/Y}$ correspond to maximal ideals.

Proposition 3.4. [Sie99, Proposition 3.5] $C_{X/Y} = C(s) \subset E$ and $[C_{X/Y}] = [C(s)] \in H_N(E)$.

3.2. Virtual fundamental class. Let now \mathcal{X} be a compact, oriented d-manifold with underlying topological space X and virtual dimension n .

By Theorem-Definition 2.2, \mathcal{X} is equivalent to a principal d-manifold, meaning that there exists an open subset $Y \subset \mathbb{R}^N$, a smooth vector bundle E on Y of rank r and a smooth section s of E whose zero locus is X .

Moreover, we may assume that Y retracts onto X and

$$f_*: H_n(X) \rightarrow H_n(Y)$$

is an isomorphism, where $f: X \rightarrow Y$ is the inclusion map and $n = N - r$.

The line bundle $L = \Lambda^r E \otimes \Lambda^N T^*Y$ is oriented. Since $\Lambda^N T^*Y$ admits an orientation by the definition of Y , this is equivalent to a choice of orientation

of the bundle E . We may therefore further assume that E is oriented. This choice of orientation does not affect the virtual fundamental class below.

By a small perturbation of the section s of E , we get a section s' of E intersecting the zero section Y transversely. Thus its zero locus X' is a compact, oriented smooth manifold. Write $f': X' \rightarrow Y$ for the inclusion.

Definition 3.5. [Joy] *The J-virtual fundamental class of \mathcal{X} is defined as*

$$(3.4) \quad [\mathcal{X}]_J^{\text{vir}} = (f_*)^{-1} \circ f'_*[X'] \in H_n(X).$$

It is shown in [Joy] that the J-virtual fundamental class is independent of all choices involved and only depends on the bordism class of \mathcal{X} .

Remark 3.6. *The assumption that Y retracts onto X and the pushforward f_* induces an isomorphism on homology uses the fact that X is assumed to be a Euclidean Neighbourhood Retract (ENR). This is however not strictly necessary in order to define $[\mathcal{X}]_J^{\text{vir}}$, as is explained for example in [BJ17, Subsection 2.6.5].*

Using the homological normal cone, we can also define a virtual fundamental class as follows.

Definition 3.7. *The BF-virtual fundamental class of \mathcal{X} is defined as*

$$(3.5) \quad [\mathcal{X}]_{BF}^{\text{vir}} = 0_{E|X}^! [C(s)] \in H_n(X).$$

The next proposition shows that the two definitions are equivalent. In particular, the BF-virtual fundamental class is well defined and independent of any choices made above.

Proposition 3.8. $[\mathcal{X}]_J^{\text{vir}} = [\mathcal{X}]_{BF}^{\text{vir}}$.

Proof. By (3.4) and (3.5), we need to show

$$(3.6) \quad f'_*[X'] = f_*0_{E|X}^! [C(s)] \in H_n(Y).$$

By the Cartesian diagram

$$\begin{array}{ccc} E|_X & \xrightarrow{g} & E \\ \downarrow & & \downarrow \\ X & \xrightarrow{f} & Y \end{array}$$

we have (cf. for example [KL20, Equation (2.23)])

$$(3.7) \quad f_* \circ 0_{E|X}^! = 0_E^! \circ g_*.$$

By Theorem-Definition 3.2, $g_*[C(s)] = [\Gamma_s] \in H_N(E)$ and for a small perturbation s' of s we have $[\Gamma_s] = [\Gamma_{s'}] \in H_N(E)$. Therefore

$$(3.8) \quad 0_E^! g_*[C(s)] = 0_E^! [\Gamma_{s'}] = f'_*[X'] \in H_n(Y)$$

since s' is taken to be transverse to the zero section of E .

Combining (3.6), (3.7) and (3.8) completes the proof. \square

From now on, we write $[\mathcal{X}]^{\text{vir}}$ for the virtual fundamental class of the d-manifold \mathcal{X} .

Remark 3.9. *The construction of $[\mathcal{X}]^{\text{vir}}$ does not strictly require that \mathcal{X} is compact, but rather the existence of a presentation $\mathcal{X} \simeq \mathcal{S}_{Y,E,s}$ or more generally of a closed embedding of \mathcal{X} as a d -manifold into a smooth manifold. The compactness of \mathcal{X} implies both of these conditions and simplifies our arguments, so we have opted to assume it here and subsequently in the paper to facilitate the exposition.*

Remark 3.10. *Suppose that Y is a complex manifold and E and s are holomorphic. Since the homological normal cone $[C(s)]$ coincides with the normal cone $[C_{X/Y}]$ by Proposition 3.4, it is clear by Definition 3.7 that the virtual fundamental class $[\mathcal{X}]^{\text{vir}}$ coincides with the definition of the virtual fundamental cycle in [BF97].*

4. VANISHING FOR SURJECTIVE REAL COSECTIONS

Let \mathcal{X} be a d -manifold whose truncation is the \mathcal{C}^∞ -scheme $X_{\mathcal{C}^\infty}$. We typically denote the underlying topological space by X .

To simplify notation, we will write \mathbb{R}_X to denote both the trivial line bundle on $X_{\mathcal{C}^\infty}$ as an $\mathcal{O}_{X_{\mathcal{C}^\infty}}$ -module and the trivial real line bundle on the topological space X .

In this section, we introduce the appropriate notions of cosections that will be considered throughout the paper and prove vanishing theorems for the virtual fundamental classes of d -manifolds and (-2) -shifted symplectic schemes in the presence of a surjective or non-degenerate cosection respectively, which constitutes the simplest possible scenario.

Besides setting up notation, we treat the case of surjective cosections separately from the general case, which is the subject of Section 5, for two reasons. The first is technical and has to do with the fact that to prove vanishing we don't need to work with normal cones nor employ homological considerations for intersections or the topology of the vanishing locus of a cosection. This simplifies the arguments and also allows us to prove a vanishing result for not just surjective real cosections of d -manifolds, but for the relaxed version of surjective weak real cosections. The second reason is that for the purposes of applying the theory to (-2) -shifted symplectic derived schemes, the surjective case (Theorem 4.6) plays an important role as the first step in the proof of the general case (Theorem 5.8). We therefore elect to treat it separately in order to clarify the argument for the convenience of the reader.

4.1. Localization by surjective real cosections of d -manifolds. Let \mathcal{X} be a d -manifold with underlying \mathcal{C}^∞ -scheme $X_{\mathcal{C}^\infty}$. We give the following definition.

Definition 4.1. *A real cosection is a morphism $\sigma: \mathcal{O}_{\mathcal{X}} \rightarrow \mathbb{R}_X$ of coherent sheaves on $X_{\mathcal{C}^\infty}$.*

A weak real cosection is a collection of linear maps $\sigma_x: \mathcal{O}_{\mathcal{X}}|_x \rightarrow \mathbb{R}$ for $x \in X$ that vary continuously, i.e. for any open subset $U \subset X$ and \mathcal{C}^∞ -vector bundle E_U on U with a surjection $p_U: E_U \rightarrow \mathcal{O}_{\mathcal{X}}|_U$ of sheaves on $U_{\mathcal{C}^\infty}$ the linear maps $\sigma_x \circ p_U|_x: E_U|_x \rightarrow \mathbb{R}$ define a continuous map of vector bundles $E_U \rightarrow \mathbb{R}_U$.

A (weak) real cosection is surjective if the corresponding morphism(s) in its definition is (are) surjective.

Remark 4.2. Clearly a real cosection induces data of a weak real cosection.

We then have the following vanishing theorem.

Theorem 4.3. Let \mathcal{X} be a compact, oriented d -manifold of virtual dimension n with a surjective weak real cosection. Then

$$[\mathcal{X}]^{\text{vir}} = 0 \in H_n(X),$$

i.e. the virtual fundamental class of \mathcal{X} is zero.

Proof. By Theorem-Definition 2.2, \mathcal{X} is equivalent to a principal d -manifold. Therefore, we have an open subset $Y \subset \mathbb{R}^N$, a smooth, oriented vector bundle E on Y of rank r and a smooth section s of E with X being its zero locus, which define an embedding of \mathcal{C}^∞ -schemes $X_{\mathcal{C}^\infty} \rightarrow Y$.

The tangent complex of \mathcal{X} is given by

$$\mathbb{T}_{\mathcal{X}} = [T_Y|_{X_{\mathcal{C}^\infty}} \xrightarrow{\text{ds}} E|_{X_{\mathcal{C}^\infty}}]$$

and hence we have a surjection $p: E|_{X_{\mathcal{C}^\infty}} \rightarrow \mathcal{O}b_{\mathcal{X}}$. By the definition of weak cosection, the maps $\sigma_x \circ p|_x: E|_x \rightarrow \mathbb{R}$ for $x \in X$ vary continuously and thus induce a continuous surjection of vector bundles

$$(4.1) \quad \sigma \circ p: E|_X \rightarrow \mathbb{R}_X.$$

Keeping the same notation around (3.4), with $f: X \rightarrow Y$ denoting the inclusion of X inside Y , we have by definition that

$$f_*[\mathcal{X}]^{\text{vir}} = e(E) \cap [Y] \in H_n(Y)$$

where $e(E)$ denotes the Euler class of E .

After possibly shrinking Y around X , since X is compact, we may assume that the surjection (4.1) extends to a continuous surjection $E \rightarrow \mathbb{R}_Y$. Since E has a trivial quotient, $e(E) = 0 \in H^r(Y)$ and we obtain

$$[\mathcal{X}]^{\text{vir}} = (f_*)^{-1}(e(E) \cap [Y]) = 0 \in H_n(X).$$

□

4.2. Vanishing for (-2) -shifted symplectic derived schemes. We can give the following general definition of a cosection for any derived scheme $\underline{\mathcal{X}}$.

Definition 4.4. A cosection is a morphism $\sigma: \mathbb{T}_{\underline{\mathcal{X}}}|_X[1] \rightarrow \mathcal{O}_X$ in $D^b(\text{Coh } X)$. We say that σ is surjective if the morphism $h^0(\sigma): \mathcal{O}b_{\underline{\mathcal{X}}} \rightarrow \mathcal{O}_X$ is surjective, or equivalently if the collection of \mathbb{C} -linear maps $\sigma_x: \mathcal{O}b(\underline{\mathcal{X}}, x) \rightarrow \mathbb{C}$ for every $x \in X$ are surjective.

Now suppose that $\omega_{\underline{\mathcal{X}}}$ is a (-2) -shifted symplectic form on $\underline{\mathcal{X}}$. We say that σ is non-degenerate if the induced quadratic form q_x^\vee on $\mathcal{O}b(\underline{\mathcal{X}}, x)^\vee$ is non-degenerate on the image of σ_x^\vee for all $x \in X$. In particular, σ must be surjective.

Remark 4.5. When $\underline{\mathcal{X}}$ is quasi-smooth so that $\mathbb{T}_{\underline{\mathcal{X}}|X}$ is a perfect complex of amplitude $[0, 1]$, the above definition of a cosection coincides with the standard definition for schemes with perfect obstruction theory, as $h^1(\mathbb{T}_{\underline{\mathcal{X}}|X})$ is the obstruction sheaf of the perfect obstruction theory $\mathbb{L}_{\underline{\mathcal{X}}|X} \rightarrow \mathbb{L}_X$ on X , in the sense of Behrend-Fantechi [BF97].

According to our discussion in Subsection 2.3, a (-2) -shifted symplectic derived scheme $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ gives rise to an associated d-manifold \mathcal{X}_{dm} . When $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ is moreover proper and oriented, there is a well defined virtual fundamental class $[\mathcal{X}_{dm}]^{\text{vir}} \in H_*(X)$ in the homology of the underlying topological space X .

We then have the following theorem, saying that cosection localization applies to the setting of non-degenerate cosections, implying the vanishing of the virtual fundamental class.

Theorem 4.6. *Suppose that a proper, oriented (-2) -shifted symplectic scheme $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ admits a non-degenerate cosection σ . These data give rise to a d-manifold \mathcal{X}_{dm} with an induced surjective real cosection and hence a vanishing virtual fundamental class, i.e. $[\mathcal{X}_{dm}]^{\text{vir}} = 0 \in H_{\text{vir.dim.}}(X)$.*

Proof. We use the terminology introduced in Subsection 2.3.

By Proposition 2.9, we are free to make any choice of q -adapted $E^- \subset E$ for an analytic Darboux chart (V, E, G, q, s) around a point $x \in X$ in Construction 2.8.

Since $\mathbb{T}_{\underline{\mathcal{X}}|U}$ is isomorphic to the complex G , σ is determined by a morphism $E \rightarrow \mathcal{O}_U$ and for every $u \in U$ we have the factorization

$$\sigma_u: \text{Ob}(\underline{\mathcal{X}}, u) \subset E|_u / \text{im}(ds|_u) \longrightarrow \mathcal{O}_X|_u$$

and hence the projection

$$E|_u \longrightarrow E|_u / \text{im}(ds|_u) \longrightarrow \mathcal{O}_X|_u$$

is surjective. Therefore we get a surjective morphism $E|_U \rightarrow \mathcal{O}_U$, which up to possible shrinking of V around x , extends to a surjective morphism $\sigma_E: E \rightarrow \mathcal{O}_V$.

The dual $\sigma_E^\vee: \mathcal{O}_V \rightarrow E^\vee$ restricts to σ_x^\vee at x , as the differentials of the complex G vanish at x by construction. Thus, since σ is non-degenerate, we may assume, up to further shrinking of V around x , that the image of σ_E^\vee is non-degenerate with respect to the quadratic form q^\vee on E^\vee .

Taking the orthogonal complement of the image and dualizing, we get a q -orthogonal splitting $E = \mathcal{O}_V \oplus \ker(\sigma_E)$, such that q is non-degenerate on each summand. After re-parametrizing analytically, q is equal to

$$q_v(z) = y_1^2 + y_2^2 + \dots + y_n^2$$

on each fiber over $v \in V$, where y_1 is the coordinate on the fiber of the first trivial summand \mathcal{O}_V and y_2, \dots, y_n are the fiber coordinates of the summand $\ker(\sigma_E)$.

We now take E^- to be the direct sum of the imaginary parts of each individual summand. E^- is easily seen to be q -adapted around $x \in X$ (it is obviously q -adapted at x and being q -adapted is an open condition by [BJ17]).

Then, for $u \in X$ close to x , the subspace $\text{im } \Pi_u \subset \mathcal{O}b(\underline{\mathcal{X}}, u)$ must project onto \mathbb{C} through σ_u non-trivially since it is maximal negative definite with respect to $\text{Re } q_u$ as E^- is q -adapted (see Definition 2.7). But, by the choice of E^- , $\text{im } \Pi_u$ consists only of imaginary vectors and therefore its projection to \mathbb{C} is contained in $i\mathbb{R} \subset \mathbb{C}$, so we must have $\sigma_u(\text{im } \Pi_u) = i\mathbb{R}$. This implies that σ_u induces a surjection

$$\sigma_u^+ : \mathcal{O}b(\underline{\mathcal{X}}, u) / \text{im } \Pi_u \longrightarrow \mathbb{R}.$$

For every such $u \in X$, the conditions in Definition 2.7 imply the existence of an exact sequence

$$T_V|_u \xrightarrow{ds^+} E^+|_u \longrightarrow \mathcal{O}b(\underline{\mathcal{X}}, u) / \text{im } \Pi_u \longrightarrow 0.$$

Since \mathcal{X}_{dm} is locally equivalent to the principal d-manifold $\mathcal{S}_{V, E^+, s^+}$, the maps $\sigma_u^+ : \mathcal{O}b_{\mathcal{X}_{dm}}|_u \rightarrow \mathbb{R}$ vary smoothly and, in particular, give a surjective real cosection for \mathcal{X}_{dm} . Thus, by Theorem 4.3, we get the desired vanishing $[\mathcal{X}_{dm}]^{\text{vir}} = 0 \in H_*(X)$. \square

5. LOCALIZATION BY REAL COSECTIONS

Keeping the notation of the previous section, let \mathcal{X} be a d-manifold whose truncation is the \mathcal{C}^∞ -scheme $X_{\mathcal{C}^\infty}$ and whose underlying topological space is X . Let $\sigma : \mathcal{O}b_{\mathcal{X}} \rightarrow \mathbb{R}_X$ be a real cosection on \mathcal{X} (cf. Definition 4.1).

In this section, we use the intersection pairing in Borel-Moore homology in order to localize the virtual fundamental class $[\mathcal{X}]^{\text{vir}}$ to a class $[\mathcal{X}]_{\text{loc}, \sigma}^{\text{vir}} \in H_*(X(\sigma))$, where $X(\sigma)$ is the degeneracy locus of σ , i.e. the locus of points $x \in X$ for which $\sigma|_x$ is equal to zero (or more generally possibly undefined). To do this, we first establish the appropriate necessary cone reduction criterion and then adapt the construction first introduced in [KL07] and [KL13, Appendix]. We finally obtain a corresponding cosection localization formalism for (-2) -shifted symplectic derived schemes, combining the results of this section with the proof of Theorem 4.6.

5.1. Cone reduction by real cosections. In this subsection, we verify that the arguments of [KL13, Section 4] go through in our context.

Let Y be a smooth manifold of dimension N , E a smooth vector bundle on Y and s a smooth section of E with zero locus $X = Z(s) \subset Y$. Locally, let $s_1, \dots, s_r \in \mathcal{C}^\infty(Y)$ be the components of the section s and y_1, \dots, y_N coordinates on Y .

Now consider the principal d-manifold $\mathcal{X} = \mathcal{S}_{Y, E, s}$ determined by the above data. Write $p : E|_{X_{\mathcal{C}^\infty}} \rightarrow \mathcal{O}b_{\mathcal{X}}$ for the projection morphism. We have the following cone reduction statement (cf. [KL13, Corollary 4.5]).

Proposition 5.1. *Let $\bar{\sigma} : \mathcal{O}b_{\mathcal{X}} \rightarrow \mathbb{R}_X$ be a morphism of coherent sheaves on $X_{\mathcal{C}^\infty}$. Let $X(\sigma)$ be the locus where $\bar{\sigma} \circ p$ is zero and $U(\sigma) = X - X(\sigma)$ its complement, where $\bar{\sigma} \circ p$ is surjective. Then $C(s)$ is contained entirely in the kernel bundle $E(\sigma) = \ker(\bar{\sigma} \circ p) = E|_{X(\sigma)} \cup \ker(\bar{\sigma} \circ p)|_{U(\sigma)}$.*

Proof. Let $c = (x, e) \in C(s)$. We need to show that if $x \notin X(\sigma)$, then $c \in \ker(\bar{\sigma} \circ p)|_{U(\sigma)}$. As $X(\sigma)$ is closed in X , by shrinking around x we may assume that $\sigma := \bar{\sigma} \circ p : E|_{X_{\mathcal{C}^\infty}} \rightarrow \mathbb{R}_X$ is surjective and extends to a smooth

surjective map $E \rightarrow \mathbb{R}_Y$ on Y and that we have fixed a connection ∇ giving the tangent complex of \mathcal{X} , $ds: T_Y|_{X_{C^\infty}} \rightarrow E|_{X_{C^\infty}}$.

We have by definition $\sigma|_{X_{C^\infty}} \circ ds|_{X_{C^\infty}} = 0$. This implies that for every variable y_j of Y

$$(5.1) \quad \sum_{i=1}^r \sigma_i \frac{\partial s_i}{\partial y_j} = O(s)$$

where $O(s)$ stands for a linear combination of the functions s_1, \dots, s_r with coefficients smooth functions, and σ_i are the components of σ .

Fix $\ell = 1$ and $c_1 = (x, 0, e) \in C(s) \subset p_1^*E$. By the definition of $C(s)$, we have a sequence $(y_k, v_k) \in Y \times \mathbb{R}$ such that, as $k \rightarrow \infty$, $y_k \rightarrow x, v_k \rightarrow 0$ and for $i = 1, \dots, r$

$$(5.2) \quad \lim_{k \rightarrow \infty} \frac{s_i(y_k)}{|v_k|} = e_i.$$

Take any continuous path $f(t) = (\gamma(t), \zeta(t)): [0, \epsilon) \rightarrow Y \times \mathbb{R}$ such that $f(0) = (x, 0)$, f is differentiable on $(0, \epsilon)$, $\zeta(t)$ is positive and strictly increasing on $(0, \epsilon)$ and there exists a sequence $t_k \rightarrow 0$ in $(0, \epsilon)$ such that $f(t_k) = (y_k, v_k)$.

By re-parametrizing we may assume that $\zeta(t) = t$ and $t_k = v_k = |v_k|$.

(5.1) gives then for $t \neq 0$

$$\sum_{i=1}^r \sigma_i(\gamma(t)) \frac{\partial s_i}{\partial y_j}(\gamma(t)) \gamma_j'(t) = O(s(\gamma(t)))$$

and hence by summing over $j = 1, \dots, N$

$$\sum_{i=1}^r \sigma_i(\gamma(t)) \frac{d}{dt} s_i(\gamma(t)) = O(s(\gamma(t))).$$

It is immediate that

$$\frac{d}{dt} \sum_{i=1}^r \sigma_i(\gamma(t)) s_i(\gamma(t)) = \sum_{i=1}^r a_i(t) s_i(\gamma(t))$$

for some continuous functions $a_i(t)$, smooth on $(0, \epsilon)$. We integrate to get

$$\sum_{i=1}^r \sigma_i(\gamma(t)) s_i(\gamma(t)) = \int_0^t \sum_{i=1}^r a_i(\lambda) s_i(\gamma(\lambda)) d\lambda.$$

Evaluating at t_k and dividing by t_k gives

$$\sum_{i=1}^r \sigma_i(y_k) \frac{s_i(y_k)}{t_k} = \frac{1}{t_k} \int_0^{t_k} \sum_{i=1}^r a_i(\lambda) s_i(\gamma(\lambda)) d\lambda$$

so letting $k \rightarrow \infty$ it follows by (5.2) that

$$\sigma(e) = \sum_{i=1}^r \sigma_i(x) e_i = \sum_{i=1}^r a_i(0) s_i(x) = 0$$

which is what we want. \square

5.2. Cosection localization for d-manifolds. Let us first recall very briefly the intersection pairing in Borel-Moore homology. For more details, we refer the reader to [Ive86] or [Bre97].

Let W be a smooth oriented manifold of dimension d . Then, for any two closed subsets Z_1, Z_2 , there exists a (bilinear) intersection pairing

$$(5.3) \quad \cap: H_i(Z_1) \times H_j(Z_2) \longrightarrow H_{i+j-d}(Z_1 \cap Z_2).$$

It has a concrete geometric interpretation when W is real analytic and Z_1, Z_2 are closed real analytic subsets of W , given for example in [Gin98, Section 1] (cf. also [IP19, Appendix A.9] for a short treatment of the pairing).

Let now \mathcal{X} be a compact, oriented d-manifold of virtual dimension n . By Theorem-Definition 2.2, \mathcal{X} is equivalent to a principal d-manifold $\mathcal{S}_{Y,E,s}$. We fix a choice of such presentation

$$(5.4) \quad \mathcal{X} \simeq \mathcal{S}_{Y,E,s}.$$

Thus we have an embedding $X_{C^\infty} \rightarrow Y$, given by the data of an open $Y \subset \mathbb{R}^N$, a smooth, oriented vector bundle E on Y of rank r , a smooth section s of E with X being its zero locus and a surjection $p: E|_{X_{C^\infty}} \rightarrow \mathcal{O}b_{\mathcal{X}}$. We have $n = N - r$.

Write σ' for the composition $\sigma \circ p: E|_{X_{C^\infty}} \rightarrow \mathbb{R}_X$ and $U(\sigma) = X - X(\sigma)$, the locus where σ' is surjective.

Up to possible shrinking of Y , we may take $\sigma'_Y: E \rightarrow \mathbb{R}_Y$ to be a smooth extension of σ' to the ambient space Y with degeneracy locus $Y(\sigma'_Y)$ and complement $U(\sigma'_Y) = Y - Y(\sigma'_Y)$.

We now assume that the degeneracy locus $X(\sigma)$ is a Euclidean Neighbourhood Retract (ENR). In particular, this implies that since $X(\sigma)$ is a closed subset of X , there is an open neighbourhood V of $X(\sigma)$ in X that retracts onto $X(\sigma)$ and such that the natural map

$$(5.5) \quad H_*(X(\sigma)) \longrightarrow H_*(V)$$

induced by the inclusion morphism is an isomorphism.

$\sigma'|_{X-V}$ is then surjective on the closed subset $X - V$ of Y and extends smoothly to the open neighbourhood $U(\sigma'_Y)$. Following [KL07], after choosing a metric on E , we can pick a smooth section $\check{\sigma}_Y \in C^\infty(E)$ that is a small perturbation of the zero section of E and moreover satisfies that the composition

$$(5.6) \quad \sigma'|_{X-V} \circ \check{\sigma}_Y|_{X-V}$$

is nonzero everywhere on $X - V$. We denote the image of $\check{\sigma}_Y$ inside E by ξ .

We now have homology classes

$$[C(s)] \in H_N(C(s)) \text{ and } [\xi] \in H_N(\xi).$$

The latter exists due to the fact that ξ is diffeomorphic to Y , which is an oriented manifold. Clearly, being a section of a vector bundle, ξ is a closed subset of the smooth manifold E .

By Proposition 5.1, $C(s)$ is contained in $E(\sigma) = E|_{X(\sigma)} \cup \ker(\sigma')|_{U(\sigma)}$, so by the definition of the section ξ , we deduce that $C(s) \cap \xi$ maps diffeomorphically under the bundle projection $q: E \rightarrow Y$ to a closed subspace of V .

With these in place, we may apply the homological intersection pairing (5.3) to the closed subsets $C(s)$ and ξ of the smooth, oriented manifold E of dimension $N + r$ and the homology classes $[C(s)], [\xi]$ respectively to obtain a class

$$(5.7) \quad [C(s)] \cap [\xi] \in H_{N-r}(C(s) \cap \xi) = H_n(C(s) \cap \xi).$$

Hence, pushing forward via q , the class (5.7) gives rise to a homology class in $H_n(V)$ and hence, applying the isomorphism (5.5), to a class

$$(5.8) \quad [\mathcal{X}]_{\text{loc}, \sigma}^{\text{vir}} := [C(s)] \cap [\xi] \in H_n(X(\sigma)).$$

By standard homological arguments, one may easily verify that $[\mathcal{X}]_{\text{loc}, \sigma}^{\text{vir}}$ is independent from the choice of extension σ'_Y and section $\check{\sigma}_Y$. By [KL07], it satisfies that

$$i_*[\mathcal{X}]_{\text{loc}, \sigma}^{\text{vir}} = [\mathcal{X}]^{\text{vir}} \in H_n(X)$$

where $i: X(\sigma) \rightarrow X$ is the natural inclusion map.

We moreover have the following proposition.

Proposition 5.2. *$[\mathcal{X}]_{\text{loc}, \sigma}^{\text{vir}}$ is independent from the choice of presentation $\mathcal{X} \simeq \mathcal{S}_{Y, E, s}$ and thus well defined.*

Proof. Suppose that $\mathcal{X} \simeq \mathcal{S}_{Y_1, E_1, s_1} \simeq \mathcal{S}_{Y_2, E_2, s_2}$. By [Joy, Theorems 1.4.8, 4.9, 4.34], up to possibly shrinking Y_1 around X , we may reduce to the case of an equivalence in the following standard form: we have a submersion $f: Y_1 \rightarrow Y_2$ and a morphism of vector bundles $\hat{f}: E_1 \rightarrow f^*E_2$ such that $\hat{f} \circ s_1 = f^*s_2$. The morphism of tangent complexes

$$(5.9) \quad \begin{array}{ccc} T_{Y_1}|_X & \xrightarrow{ds_1} & E_1|_X \\ df \downarrow & & \downarrow \hat{f} \\ f^*T_{Y_2}|_X & \xrightarrow{d(f^*s_2)} & f^*E_2|_X \end{array}$$

is a quasi-isomorphism on fibers over $x \in X$ and thus we must have that $E_1|_X \xrightarrow{\hat{f}} f^*E_2|_X$ is surjective, so after further possible shrinking of Y_1 , we may assume that \hat{f} is surjective.

This situation can be locally described as follows: Let $N_1 = \dim Y_1$, $N_2 = \dim Y_2 = N_1 - p$, y_1, \dots, y_{N_1} be local coordinates for Y_1 , y_1, \dots, y_{N_2} local coordinates for Y_2 and $E_1 = f^*E_2 \oplus \mathbb{R}_{Y_1}^p$ be a splitting for \hat{f} . Then, with respect to this splitting, we have $s_1(y_1, \dots, y_{N_1}) = (s_2(y_1, \dots, y_{N_2}), y_{N_2+1}, \dots, y_{N_1})$.

Let $i_1: X \rightarrow Y_1$, $i_2: X \rightarrow Y_2$ be the inclusion maps. They satisfy $i_2 = f \circ i_1$ and fit into a commutative diagram

$$\begin{array}{ccc} X & \xrightarrow{i_1} & Y_1 \\ & \searrow i_2 & \downarrow f \\ & & Y_2. \end{array}$$

It follows that the projection

$$\hat{f}: E_1 \longrightarrow f^*E_2,$$

restricted to X via pullback by the inclusion i_1 , induces a projection map $\widehat{f}|_X: C(s_1) \rightarrow C(s_2)$ which makes $C(s_1)$ into a vector bundle over $C(s_2)$.

By restricting to X and using the inclusion $C(s_2) \subset E_2|_X$ (cf. Theorem-Definition 3.1), we also have a commutative diagram

$$\begin{array}{ccc} & & f^*E_2 \\ & \nearrow j_1 & \downarrow \\ C(s_2) & \xrightarrow{j_2} & E_2. \end{array}$$

Now, let $\sigma'_{Y_2}: E_2 \rightarrow \mathbb{R}_{Y_2}$ be a smooth extension of the composition $\sigma \circ p_2: E_2|_{X_{C^\infty}} \rightarrow \mathbb{R}_X$. Then, by (5.9), $\sigma'_{Y_1} := f^*\sigma_{Y_2} \circ \widehat{f}$ is a smooth extension of the corresponding composition $\sigma \circ p_1: E_1|_{X_{C^\infty}} \rightarrow \mathbb{R}_X$.

Pick a splitting $\check{f}: f^*E_2 \rightarrow E_1$ of \widehat{f} . Moreover, let $\check{\sigma}_{Y_2}$ be a smooth section of E_2 as in (5.6). Then, up to rescaling \check{f} , the composition $\check{\sigma}_{Y_1} := \check{f} \circ f^*\sigma_{Y_2}$ also satisfies the same properties in regards to the cosection σ'_{Y_1} .

Using the splitting, write $E_1 = f^*E_2 \oplus E_3$ so that \widehat{f} is the projection onto the first factor and \check{f} is the inclusion of the first factor.

We then have by definition

$$C(s_1) = C(s_2) \oplus E_3|_X$$

where $C(s_2)$ is a closed subspace of f^*E_2 via the embedding j_1 and

$$\check{\sigma}_{Y_1} = f^*\check{\sigma}_{Y_2} \oplus 0.$$

The intersections $C(s_1) \cap \xi_1, C(s_2) \cap \xi_2$ are closed subspaces of V , using Lemma 5.1 and the construction of ξ_1 and ξ_2 , and we see that they must be equal.

Under this identification it is routine to verify that the properties of the intersection pairing imply that

$$[C(s_1)] \cap [\xi_1] = [C(s_2)] \cap [\xi_2] \in H_n(X(\sigma))$$

where we have suppressed the pushforward to V and the isomorphism (5.5) on homology. \square

If $X(\sigma)$ is not an ENR or more generally does not admit a neighbourhood V in X satisfying the above properties, we may still perform the construction with the following modifications, following [BJ17, Subsection 2.6.5]: Instead of V , we consider a sequence of open neighbourhoods

$$V_1 \supset V_2 \supset V_3 \supset \dots$$

of $X(\sigma)$ in X satisfying

$$(5.10) \quad \bigcap_{i=1}^{\infty} V_i = X(\sigma).$$

The above construction gives a sequence of homology classes for $i = 1, 2, \dots$

$$[\mathcal{X}]_{\text{loc}, \sigma, i}^{\text{vir}} \in H_n(V_i)$$

compatible under restriction from V_i to V_{i+1} and hence an element

$$(5.11) \quad [\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} \in \varprojlim_{i \geq 1} H_n(V_i).$$

Borel-Moore homology satisfies Milnor's continuity axiom (cf. for example [IP19, Appendix A]) and hence

$$(5.12) \quad \varprojlim_{i \geq 1} H_n(V_i) = H_n(\cap_{i=1}^{\infty} V_i).$$

Combining (5.10), (5.11) and (5.12), we again obtain a localized homology class

$$(5.13) \quad [\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} \in H_n(X(\sigma)).$$

Summarizing our discussion, we may now give the following definition.

Theorem-Definition 5.3. *Let \mathcal{X} be a compact, oriented d -manifold of virtual dimension n and $\sigma: \mathcal{O}b_{\mathcal{X}} \rightarrow \mathbb{R}_{\mathcal{X}}$ a real cosection. Then the cosection localized virtual fundamental class $[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}}$ of \mathcal{X} is defined by (5.8) (and more generally by (5.13) when $X(\sigma)$ is not a Euclidean Neighbourhood Retract) and satisfies*

$$i_*[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} = [\mathcal{X}]^{\text{vir}} \in H_n(X)$$

where $i: X(\sigma) \rightarrow X$ denotes the inclusion.

Remark 5.4. *In order to define the cosection localized virtual fundamental class, we do not need a globally defined cosection σ on \mathcal{X} , but only a surjective cosection $\sigma_{\mathcal{U}(\sigma)}: \mathcal{O}b_{\mathcal{U}(\sigma)} \rightarrow \mathbb{R}_{\mathcal{U}(\sigma)}$ defined on the open sub- d -manifold $\mathcal{U}(\sigma)$ of \mathcal{X} whose underlying topological space is an open subset $U(\sigma)$ inside X . We will use this observation in Subsection 5.3.*

Remark 5.5. *The above definition generalizes the statement of Theorem 4.3 when one only considers cosections of d -manifolds (and not weak cosections).*

Example 5.6. *Let $Y \subset \mathbb{R}^N$ be the open unit disk, E an oriented, rank N vector bundle on Y , s the zero section of E and $X \simeq \mathcal{S}_{Y,E,s}$ so that the underlying topological space is $X = Y$. Consider a cosection $\sigma: E \rightarrow \mathbb{R}_Y$ whose zero locus $Y(\sigma)$ is the origin, viewed as a smooth manifold.*

Clearly $C(s) = Y \subset E$ is the zero section. Let V be a disk of sufficiently small radius ϵ centered at the origin 0 . By trivializing $E \cong \mathbb{R}^N \times \mathbb{R}^N$ around 0 , we write $y = (y_1, \dots, y_N)$ for the coordinates of Y and $e = (e_1, \dots, e_N)$ for the fiber coordinates of E . Then we may assume that σ is the map

$$\sigma(y, e) = y_1 e_1 + \dots + y_N e_N.$$

We can split σ away from 0 using the section $\check{\sigma}: \mathbb{R}_V \rightarrow E|_V$ defined by

$$\check{\sigma}(y) = \begin{cases} (y, \frac{y}{|y|}) & \text{if } \frac{\epsilon}{2} < |y| < \epsilon \\ (y, \frac{2}{\epsilon}y) & \text{if } |y| \leq \frac{\epsilon}{2} \end{cases}$$

After smoothing and extending $\check{\sigma}$ to Y (and possibly rescaling), we have a splitting and obtain a section ξ of E as the graph of $\check{\sigma}$.

It is then immediate that $[C(s)] \cap [\xi] = \pm[0] \in H_0(Y(\sigma))$, where the sign is determined by the orientation of E and hence

$$[Y]_{\text{loc},\sigma}^{\text{vir}} = \pm[0] \in H_0(Y(\sigma)).$$

5.3. Cosection localization for (-2) -shifted symplectic derived schemes.

The methods developed in this section together with the strategy employed in the proof of Theorem 4.6 allow us to significantly generalize its statement. Before we proceed, we introduce a bit of terminology.

Definition 5.7. A meromorphic cosection on a derived scheme $\underline{\mathcal{X}}$ is a cosection σ defined on an open derived subscheme $\underline{\mathcal{U}}(\sigma)$ of $\underline{\mathcal{X}}$.

When $\underline{\mathcal{X}}$ is (-2) -shifted symplectic with symplectic form $\omega_{\underline{\mathcal{X}}}$, we say that σ is non-degenerate if it is a non-degenerate cosection of the (-2) -shifted symplectic derived scheme $(\underline{\mathcal{U}}(\sigma), \omega_{\underline{\mathcal{U}}(\sigma)})$, where $\omega_{\underline{\mathcal{U}}(\sigma)} := \omega_{\underline{\mathcal{X}}}|_{\underline{\mathcal{U}}(\sigma)}$. If $U(\sigma)$ is the underlying topological space of $\underline{\mathcal{U}}(\sigma)$, we use the notation $X(\sigma) = X - U(\sigma)$ for the locus where σ is not defined or degenerate.

We are now in position to generalize Theorem 4.6.

Theorem 5.8. Let $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ be a proper, oriented (-2) -shifted symplectic derived scheme of virtual dimension n with a meromorphic non-degenerate cosection σ . Then there exists a cosection localized virtual fundamental class $[\mathcal{X}_{dm}]_{\text{loc},\sigma}^{\text{vir}} \in H_n(X(\sigma))$ satisfying

$$i_*[\mathcal{X}_{dm}]_{\text{loc},\sigma}^{\text{vir}} = [\mathcal{X}_{dm}]^{\text{vir}} \in H_n(X)$$

where $i: X(\sigma) \rightarrow X$ is the inclusion map.

Proof. Since $X(\sigma)$ is a Zariski closed subset of X , it is an ENR and therefore there exists an open neighbourhood V of $X(\sigma)$ that retracts onto $X(\sigma)$ such that the natural map

$$H_*(X(\sigma)) \longrightarrow H_*(V)$$

induced by inclusion is an isomorphism.

We may now follow the same strategy as in the proof of Theorem 4.6 to associate to $(\underline{\mathcal{X}}, \omega_{\underline{\mathcal{X}}})$ a d-manifold \mathcal{X}_{dm} together with the data of an open sub-d-manifold \mathcal{W} whose underlying topological space W is contained in $U(\sigma)$ and is an open neighbourhood of $X - V$ inside $U(\sigma)$ and a surjective real cosection $\sigma_{\mathcal{W}}$ on \mathcal{W} .

Theorem-Definition 5.3 and Remark 5.4 then imply the existence of a localized virtual fundamental class $[\mathcal{X}_{dm}]_{\text{loc},\sigma}^{\text{vir}}$ in $H_n(X - W)$ and hence in $H_n(V) \cong H_*(X(\sigma))$, which is independent of all choices involved and thus well defined and satisfies the required properties. \square

6. LOCALIZATION BY COMPLEX COSECTIONS

As usual, let \mathcal{X} be a compact, oriented d-manifold, $X_{\mathcal{C}^\infty}$ the associated \mathcal{C}^∞ -scheme and X the underlying topological space. In this section, we study a certain kind of complex cosection that has similar properties to a cosection for an algebraic scheme with perfect obstruction theory. This allows us to localize in a more robust and systematic way of algebraic flavor compared to the previous section.

Similarly to the case of real cosections, we write \mathbb{C}_X to denote both the trivial complex line bundle on $X_{\mathcal{C}^\infty}$ and the trivial complex line bundle on X .

Definition 6.1. *A complex cosection is a morphism $\sigma: \text{Ob}_{\mathcal{X}} \rightarrow \mathbb{C}_X$ of sheaves on $X_{\mathcal{C}^\infty}$.*

The motivation behind the results of this section is the following observation: Suppose that X is a complex projective scheme equipped with a perfect obstruction theory with cosection σ . Then, writing as usual $i: X(\sigma) \rightarrow X$ for the inclusion, there is a cosection localized virtual fundamental cycle $[X]_{\text{loc},\sigma}^{\text{vir}} \in H_*(X(\sigma))$ satisfying $i_*[X]_{\text{loc},\sigma}^{\text{vir}} = [X]^{\text{vir}} \in H_*(X)$, defined by an explicit formula in [KL13] which utilizes the blowup of X along $X(\sigma)$.

In [Joy, Section 14.5], Joyce defines a truncation functor from schemes with perfect obstruction theory to d-manifolds, which acts functorially on their virtual fundamental classes. Applying this functor to X , one gets a d-manifold \mathcal{X} with an induced complex cosection σ and a virtual fundamental class, which is thus automatically naturally localized by the cosection σ by an explicit formula (see equation (6.9) and Theorem-Definition 6.7 below for the formula in our context).

One can then ask how close a d-manifold \mathcal{X} with a complex cosection σ can be to a truncation of an algebraic (or complex analytic) scheme with a perfect obstruction theory with cosection to admit this more robustly described cosection localized virtual fundamental class.

As we will see, a sufficient set of holomorphicity assumptions regarding the topology of \mathcal{X} and the cosection σ is given by the following setup. From now on in this section, we proceed to make these assumptions.

Setup 6.2. *We say that \mathcal{X} and σ come from geometry if:*

- (1) *X admits the structure of a complex analytic space X^{an} inducing a structure of a \mathcal{C}^∞ -scheme on X , denoted by $X_{\mathcal{C}^\infty}^{\text{an}}$.*
- (2) *There exists a closed embedding $X^{\text{an}} \hookrightarrow W$, where W is a complex manifold.*
- (3) *There exists a closed embedding of \mathcal{C}^∞ -schemes $X_{\mathcal{C}^\infty}^{\text{an}} \hookrightarrow X_{\mathcal{C}^\infty}$.*
- (4) *The locus $X(\sigma)$, where σ is not surjective, is a complex analytic closed subset of X^{an} .*
- (5) *The image of $\sigma|_{X_{\mathcal{C}^\infty}^{\text{an}}}$ is an $\mathcal{O}_{X_{\mathcal{C}^\infty}^{\text{an}}}$ -submodule of \mathbb{C}_X generated by an ideal $I \subset \mathcal{O}_{X^{\text{an}}}$ whose zero locus is $X(\sigma)$.*

We briefly clarify the above conditions.

In (1), if X^{an} is analytically locally described as the vanishing locus of holomorphic functions f_1, \dots, f_r defined on a polydisc D in \mathbb{C}^N , $X_{\mathcal{C}^\infty}^{\text{an}}$ is locally described by the spectrum of the \mathcal{C}^∞ -ring $\mathcal{C}^\infty(D)/(\text{Re}f_1, \text{Im}f_1, \dots, \text{Re}f_r, \text{Im}f_r)$. Clearly holomorphic transition functions between such charts induce smooth transition functions so that we obtain a \mathcal{C}^∞ -scheme.

In (5), if I is locally generated by a set of holomorphic functions f_1, \dots, f_r on X^{an} whose common zero set is $X(\sigma)$, we consider the $\mathcal{O}_{X_{\mathcal{C}^\infty}^{\text{an}}}$ -submodule of $\mathbb{C}_X = \mathbb{R}_X \oplus \mathbb{R}_X$ generated by the pairs

$$(\text{Re}f_1, \text{Im}f_1), (-\text{Im}f_1, \text{Re}f_1), \dots, (\text{Re}f_r, \text{Im}f_r), (-\text{Im}f_r, \text{Re}f_r)$$

of functions on $X_{\mathcal{C}^\infty}^{an}$. (5) requires the image of $\sigma|_{X_{\mathcal{C}^\infty}^{an}}$ to be locally of this form for some choice of generators of I .

Therefore, Setup 6.2 essentially says that \mathcal{X} and the cosection σ are determined by complex analytic data up to possible thickening of the underlying \mathcal{C}^∞ -scheme.

Remark 6.3. *By design, if X^{an} is a complex analytic space with an embedding $X^{an} \rightarrow W$ into a complex manifold and a perfect obstruction theory with holomorphic cosection σ^{an} , then the d -manifold \mathcal{X} obtained by applying the truncation functor in [Joy, Section 14.5], and its induced complex cosection σ satisfy the conditions of Setup 6.2. The same holds for a complex scheme X endowed with the same data.*

By Theorem-Definition 2.2, \mathcal{X} is equivalent to a principal d -manifold $\mathcal{S}_{Y,E,s}$. We fix a choice of such presentation

$$(6.1) \quad \mathcal{X} \simeq \mathcal{S}_{Y,E,s}.$$

Thus we have an embedding $X_{\mathcal{C}^\infty} \rightarrow Y$, given by the data of an open $Y \subset \mathbb{R}^N$, a smooth, oriented vector bundle E on Y of rank r , a smooth section s of E with X being its zero locus and a surjection $p: E|_{X_{\mathcal{C}^\infty}} \rightarrow \mathcal{O}_b\mathcal{X}$.

Write σ' for the composition $\sigma \circ p: E|_{X_{\mathcal{C}^\infty}} \rightarrow \mathbb{C}_X$ and $U(\sigma) = X - X(\sigma)$, the locus where σ' is surjective. Let

$$E(\sigma) = E|_{X(\sigma)} \cup \ker(\sigma'|_{U(\sigma)}).$$

Write $j: E|_{X(\sigma)} \rightarrow E(\sigma)$ for the inclusion.

In order to localize $[\mathcal{X}]^{\text{vir}}$, we need to use an appropriate notion of resolution of the cosection, as in [KL13] and [KL20].

Definition 6.4. *We say that a proper map $\rho: \tilde{X} \rightarrow X$ of topological spaces is a σ -regularizing map with respect to the presentation (6.1) if:*

- (1) $\rho|_{\rho^{-1}(U(\sigma))}: \rho^{-1}(U(\sigma)) \rightarrow U(\sigma)$ is a homeomorphism. Write D for the complement of $U(\sigma)$ in \tilde{X} .
- (2) The pullback $\rho^*\sigma': \rho^*E|_X \rightarrow \mathbb{C}_{\tilde{X}}$ factors through a surjection

$$(6.2) \quad \rho^*E|_X \rightarrow L$$

where L is a complex line bundle on \tilde{X} together with a continuous section $t \in \Gamma(\tilde{X}, L^\vee)$ whose zero locus is D .

We write $\rho(\sigma): D \rightarrow X(\sigma)$ for the induced map. Moreover let E' be the kernel bundle of the surjection (6.2). We get an induced commutative diagram of topological spaces

$$(6.3) \quad \begin{array}{ccc} E' & \longrightarrow & \rho^*E|_X \\ \rho' \downarrow & & \downarrow \\ E(\sigma) & \longrightarrow & E|_X. \end{array}$$

We say that a σ -regularizing map satisfies homological lifting if any homology class $\gamma \in H_i(E(\sigma))$ can be written as

$$(6.4) \quad \gamma = j_*\alpha + \rho'_*\beta$$

for homology classes $\alpha \in H_i(E|_{X(\sigma)})$ and $\beta \in H_i(E')$.

The next proposition shows that when \mathcal{X} and σ come from geometry, there exists an induced σ -regularizing map that satisfies homological lifting.

Proposition 6.5. *Suppose that the conditions in Setup 6.2 hold and we have fixed a presentation (6.1). Then there exists an induced σ -regularizing map $\rho: \tilde{X} \rightarrow X$ that satisfies homological lifting.*

Proof. By parts (1) and (2) of Setup 6.2, we have a closed embedding $X^{an} \rightarrow W$. In particular, at the level of \mathcal{C}^∞ -schemes we get an embedding

$$(6.5) \quad X_{\mathcal{C}^\infty}^{an} \longrightarrow W_{\mathcal{C}^\infty}.$$

By definition, pulling back E from Y via the embedding $X_{\mathcal{C}^\infty} \rightarrow Y$ gives a vector bundle $E|_{X_{\mathcal{C}^\infty}}$ on $X_{\mathcal{C}^\infty}$.

By part (3) of Setup 6.2, we can further pull it back to a vector bundle $E|_{X_{\mathcal{C}^\infty}^{an}}$ on $X_{\mathcal{C}^\infty}^{an}$. Pulling back σ' gives a cosection

$$(6.6) \quad E|_{X_{\mathcal{C}^\infty}^{an}} \longrightarrow \mathbb{C}_{X_{\mathcal{C}^\infty}^{an}}.$$

At the topological level, both vector bundles $E|_{X_{\mathcal{C}^\infty}}$ and $E|_{X_{\mathcal{C}^\infty}^{an}}$ give the vector bundle $E|_X$ on the underlying topological space X .

The existence of the embedding (6.5) and the bundle $E|_{X_{\mathcal{C}^\infty}^{an}}$ implies (for example, by the argument in the proof of [Joy, Theorem 4.34]) that there exists an open neighbourhood V of X in W such that $E|_X$ extends to a smooth vector bundle E_V on V . Moreover, using parts (4) and (5) of Setup 6.2 and the cosection (6.6), up to shrinking V , we may extend the cosection $\sigma': E|_X \rightarrow \mathbb{C}_X$ to a smooth morphism of vector bundles

$$\sigma_V: E_V \longrightarrow \mathbb{C}_V.$$

Let $\tau: \tilde{V} \rightarrow V$ be the blowup of V along $X(\sigma)$ with exceptional divisor D_V and set $\tilde{X} = \tilde{V} \times_V X$ with induced proper morphism $\rho: \tilde{X} \rightarrow X$.

For two such choices V_1, V_2 and blowup maps $\tau_1: \tilde{V}_1 \rightarrow V_1$ and $\tau_2: \tilde{V}_2 \rightarrow V_2$, let their intersection inside W be $V_{12} = V_1 \cap V_2$ and $\tau_{12}: \tilde{V}_{12} \rightarrow V_{12}$ be the blowup of V_{12} along $X(\sigma)$. For $i = 1, 2$, since $X(\sigma) \subset V_{12}$ is a closed embedding and V_{12} is open in both V_1 and V_2 , we have diagrams with Cartesian squares

$$\begin{array}{ccccc} \tilde{X} & \longrightarrow & \tilde{V}_{12} & \longrightarrow & \tilde{V}_i \\ \downarrow \rho & & \downarrow \tau_{12} & & \downarrow \tau_i \\ X & \longrightarrow & V_{12} & \longrightarrow & V_i \end{array}$$

and therefore ρ is independent from the choice of neighbourhood V .

We now have a complex line bundle $L = \mathcal{O}_{\tilde{V}}(-D_V)|_{\tilde{X}}$ and a morphism

$$\tau^* \sigma_V: \tau^* E_V \rightarrow \mathcal{O}_{\tilde{V}}(-D_V)$$

whose restriction to \tilde{X} gives a surjection

$$\rho^* \sigma': \rho^* E|_X \longrightarrow L.$$

We thus see that $\rho: \tilde{X} \rightarrow X$ is σ -regularizing.

By construction, the diagram (6.3) gives rise to a commutative diagram

$$(6.7) \quad \begin{array}{ccc} E' & \longrightarrow & \tau^* E_V \\ \rho' \downarrow & & \downarrow \\ E(\sigma) & \longrightarrow & E_V. \end{array}$$

Then the proof of [KL20, Lemma 2.3] applies verbatim to this setting and implies that ρ satisfies homological lifting. \square

Remark 6.6. *If we have two closed embeddings $X^{an} \rightarrow W_1$ and $X^{an} \rightarrow W_2$ of X^{an} into complex manifolds W_1 and W_2 , a standard argument using the diagonal embedding $X^{an} \rightarrow W_1 \times W_2$ and the projections $W_1 \times W_2 \rightarrow W_i$ for $i = 1, 2$ shows that the map ρ is independent from the particular choice of closed embedding $X^{an} \rightarrow W$ and thus determined canonically by the rest of the data of Setup 6.2.*

What is essential is that such an embedding exists. This is true automatically for example when X^{an} is quasi-projective.

Given a σ -regularizing map $\rho: \tilde{X} \rightarrow X$ satisfying homological lifting, by [KL20] we have a localized Gysin map

$$(6.8) \quad 0_{E|X,\sigma}^!: H_*(E(\sigma)) \longrightarrow H_{*-r}(X(\sigma))$$

given by the formula

$$(6.9) \quad 0_{E|X,\sigma}^! \gamma = 0_{E|X(\sigma)}^! \alpha - \rho(\sigma)_* \left(e(L^\vee, t) \cap 0_{E'}^! \beta \right)$$

where $\gamma \in H_i(E(\sigma))$ and we have written $\gamma = j_* \alpha + \rho'_* \beta$ for some $\alpha \in H_i(E|X(\sigma))$ and $\beta \in H_i(E')$.

By the proof of [KL20, Theorem 3.2], the Gysin map $0_{E|X,\sigma}^!$ is independent from the particular choice of α and β .

If $i: X(\sigma) \rightarrow X$ denotes the inclusion, it is shown in [KL13, Corollary 2.9] that it satisfies

$$0_{E|X}^! \circ j_* = i_* \circ 0_{E|X(\sigma)}^!: H_*(E|X) \rightarrow H_{*-r}(X).$$

Now, by Proposition 5.1, $C(s)$ is contained in $E(\sigma)$ and therefore by the definition (3.3) it follows that we obtain a class

$$[C(s)] \in H_N(E(\sigma)).$$

We are now in position to explicitly define the cosection localized virtual fundamental class of \mathcal{X} .

Theorem-Definition 6.7. *Let \mathcal{X} be a compact, oriented d -manifold of virtual dimension n and $\sigma: \mathcal{O}b_{\mathcal{X}} \rightarrow \mathbb{C}_X$ a complex cosection, satisfying the conditions of Setup 6.2. Then the cosection localized virtual fundamental class of \mathcal{X} is defined by the formula*

$$[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} := 0_{E|X,\sigma}^! [C(s)] \in H_n(X(\sigma)).$$

It satisfies

$$i_* [\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}} = [\mathcal{X}]^{\text{vir}} \in H_n(X).$$

Finally, we have not addressed the potential dependence of $[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}}$ on the presentation (6.1) of \mathcal{X} as a principal d-manifold, i.e. on the data Y, E, s .

Proposition 6.8. $[\mathcal{X}]_{\text{loc},\sigma}^{\text{vir}}$ is independent from the choice of presentation $\mathcal{X} \simeq \mathcal{S}_{Y,E,s}$ and thus well defined.

Proof. Firstly, the σ -regularizing map $\rho: \widetilde{X} \rightarrow X$ by construction can only a priori depend on the choice of closed embedding $X \hookrightarrow W$ and of an open neighbourhood V of X inside W . By the proof of Proposition 6.5 and Remark 6.6, it is independent of these choices and thus independent from the particular choice of presentation.

Suppose now that $\mathcal{X} \simeq \mathcal{S}_{Y_1,E_1,s_1} \simeq \mathcal{S}_{Y_2,E_2,s_2}$. As in the proof of Proposition 5.2, up to possibly shrinking Y_1 around X , we can write this equivalence in the following standard form: we have a submersion $f: Y_1 \rightarrow Y_2$ and a morphism of vector bundles $\widehat{f}: E_1 \rightarrow f^*E_2$ such that $\widehat{f} \circ s_1 = f^*s_2$. The morphism of tangent complexes

$$\begin{array}{ccc} T_{Y_1}|_X & \xrightarrow{ds_1} & E_1|_X \\ df \downarrow & & \downarrow \widehat{f} \\ f^*T_{Y_2}|_X & \xrightarrow{d(f^*s_2)} & f^*E_2|_X \end{array}$$

is a quasi-isomorphism on fibers over $x \in X$ and thus we must have that $E_1|_X \xrightarrow{\widehat{f}} f^*E_2|_X$ is surjective, so after further possible shrinking of Y_1 , we may assume that \widehat{f} is surjective.

Using the notation of diagram (6.3), we have an induced diagram with Cartesian squares

$$\begin{array}{ccccc} E'_1 & \xrightarrow{\widehat{f}'} & (f^*E_2)' & \xrightarrow{f'} & E'_2 \\ \rho'_1 \downarrow & & \downarrow & & \downarrow \rho'_2 \\ E_1(\sigma) & \xrightarrow{\widehat{f}(\sigma)} & (f^*E_2)(\sigma) & \xrightarrow{f(\sigma)} & E_2(\sigma) \\ i_1 \uparrow & & \uparrow & & \uparrow i_2 \\ E_1|_{X(\sigma)} & \xrightarrow{\widehat{f}|_{X(\sigma)}} & (f^*E_2)|_{X(\sigma)} & \xrightarrow{f|_{X(\sigma)}} & E_2|_{X(\sigma)} \end{array}$$

where the horizontal arrows are smooth and the vertical arrows proper.

Write $\widehat{g}' = f' \circ \widehat{f}'$, $g(\sigma) = f(\sigma) \circ \widehat{f}(\sigma)$ and $g|_{X(\sigma)} = f|_{X(\sigma)} \circ \widehat{f}|_{X(\sigma)}$ for the (submersive) compositions of the horizontal arrows.

Using base change for Cartesian squares with vertical arrows that are submersions and proper horizontal arrows (cf. for example [KL20, Equations (2.12), (2.23)]), the local description of the equivalence $\mathcal{S}_{Y_1,E_1,s_1} \simeq \mathcal{S}_{Y_2,E_2,s_2}$ given in the proof of Proposition 5.2 implies that in the notation of (3.2) we have

$$(s_{1,\ell})_*[Y_1 \times (\mathbb{R}^\ell \setminus \{0\})] = \widehat{g}^*(s_{2,\ell})_*[Y_2 \times (\mathbb{R}^\ell \setminus \{0\})]$$

where \widehat{g} is the composition $E_1 \xrightarrow{\widehat{f}} f^*E_2 \rightarrow E_2$.

It thus follows from the definition of the cones $[C(s_1)]$ and $[C(s_2)]$ and Proposition 5.1 that

$$[C(s_1)] = \widehat{f}(\sigma)^*[C(f^*s_2)] = \widehat{f}(\sigma)^*f(\sigma)^*[C(s_2)] = g(\sigma)^*[C(s_2)]$$

and therefore if

$$[C(s_2)] = (i_2)_*\alpha_2 + (\rho'_2)_*\beta_2$$

in the notation of (6.4), we will have

$$[C(s_1)] = (i_1)_*\alpha_1 + (\rho'_1)_*\beta_1$$

where

$$\alpha_1 = (g|_{X(\sigma)})^*\alpha_2, \quad \beta_1 = (\widehat{g}')^*\beta_2.$$

By the usual functoriality properties of Gysin maps (cf. for example [KL20, Section 2.4]), we obtain

$$0^!_{E_1|_{X(\sigma)}}\alpha_1 = 0^!_{E_2|_{X(\sigma)}}\alpha_2, \quad 0^!_{E'_1}\beta_1 = 0^!_{E'_2}\beta_2$$

so the formula of the localized Gysin map (6.9) immediately implies that

$$0^!_{E_1|_{X,\sigma}}[C(s_1)] = 0^!_{E_2|_{X,\sigma}}[C(s_2)]$$

as we want. \square

Remark 6.9. *In general, given a cosection σ on \mathcal{X} , it is not clear if it is possible to endow the locus $X(\sigma)$ with a natural choice of structure of a d -manifold.*

This is intuitive from the point of view of complex analytic spaces with perfect obstruction theory, as a cosection does not necessarily induce a perfect obstruction theory on its vanishing locus.

7. APPLICATION: VANISHING OF STABLE PAIR INVARIANTS OF HYPERKÄHLER FOURFOLDS

Let W be a smooth, projective Calabi-Yau fourfold. In [CMT22], the authors study the stable pair invariants of W and claim that they vanish when W is hyperkähler, anticipating the existence of a cosection localization theory for d -manifolds. In this section, we prove their claim using the theory developed in the previous parts of the paper.

A stable pair on W is the data of

$$(F, s), \quad F \in \text{Coh } W, \quad s: \mathcal{O}_W \longrightarrow F$$

where F is a pure one-dimensional sheaf on W and s is surjective in dimension one.

Fix $\beta \in H_2(W, \mathbb{Z})$ and $n \in \mathbb{Z}$. Then the moduli space $P_n(W, \beta)$ is a projective scheme which parameterizes stable pairs viewed as two-term complexes

$$I = [\mathcal{O}_W \xrightarrow{s} F] \in D^b(\text{Coh } W)$$

satisfying $[F] = \beta$ and $\chi(F) = n$.

By [CMT22, Lemma 1.3], $X = P_n(W, \beta)$ is the truncation of a (-2) -shifted symplectic derived scheme \mathcal{X} , which admits a choice of orientation. Writing $\mathbb{I} = [\mathcal{O}_{W \times X} \rightarrow \mathbb{F}]$ for the universal stable pair and $\pi_X: X \times W \rightarrow X$, $\pi_W: X \times W \rightarrow W$ for the projection maps, we have

$$\mathbb{T}_{\mathcal{X}|_X} = \mathbf{R}\mathcal{H}om_{\pi_X}(\mathbb{I}, \mathbb{I})_0[1]$$

so that at a point $x = [I] \in X$ we have $\mathcal{O}b(\underline{\mathcal{X}}, x) = \text{Ext}^2(I, I)_0$ and the quadratic form $q_x = q_I$ induced by the symplectic form coincides with the Serre duality pairing.

Suppose now that W is hyperkähler with holomorphic symplectic form η . Then, using the Atiyah class of \mathbb{I} and the symplectic form, it is shown in [CMT22] that $\underline{\mathcal{X}}$ admits a strong cosection, whose associated weak cosection is non-degenerate.

We briefly recall the construction for the convenience of the reader.

Let

$$\text{At}(\mathbb{I}) \in \text{Ext}^1(\mathbb{I}, \mathbb{I} \otimes \pi_W^* \Omega_W)$$

be the relative Atiyah class of \mathbb{I} . We then get morphisms

$$\begin{aligned} \wedge \frac{\text{At}(\mathbb{I})^2}{2}: \mathbb{T}_{\underline{\mathcal{X}}|_X}[1] &= \mathbf{R}\mathcal{H}om_{\pi_X}(\mathbb{I}, \mathbb{I})_0[2] \longrightarrow \mathbf{R}\mathcal{H}om_{\pi_X}(\mathbb{I}, \mathbb{I} \otimes \pi_W \Omega_W^2[2])[2] \\ \lrcorner \eta: \mathbf{R}\mathcal{H}om_{\pi_X}(\mathbb{I}, \mathbb{I} \otimes \pi_W \Omega_W^2[2])[2] &\longrightarrow \mathbf{R}\mathcal{H}om_{\pi_X}(\mathbb{I}, \mathbb{I}[2])[2] \\ \text{tr}: \mathbf{R}\mathcal{H}om_{\pi_X}(\mathbb{I}, \mathbb{I}[2])[2] &\longrightarrow \mathbf{R}\mathcal{H}om_{\pi_X}(\mathcal{O}_{X \times W}, \mathcal{O}_{X \times W}[2])[2] = \mathcal{O}_X \oplus \mathcal{O}_X[-4] \end{aligned}$$

Projecting onto \mathcal{O}_X , their composition gives a cosection

$$\sigma: \mathbb{T}_{\underline{\mathcal{X}}|_X}[1] \longrightarrow \mathcal{O}_X$$

which at the point $x = [I] \in X$ corresponds to a morphism

$$(7.1) \quad \sigma_x = \sigma_I: \mathcal{O}b(\underline{\mathcal{X}}, x) = \text{Ext}^2(I, I)_0 \longrightarrow H^4(W, \mathcal{O}_W).$$

We have the following proposition.

Proposition 7.1. [CMT18, Proposition 2.9] [CMT22, Proposition 2.18] *Let W be a smooth, projective hyperkähler fourfold and X a connected scheme. Let \mathbb{I} be any perfect complex on $X \times W$ and write $\mathbb{I}|_x = I$ for $x \in X$. Then if $\text{ch}_3(I) \neq 0$ or $\text{ch}_4(I) \neq 0$, σ_I is surjective and:*

- (1) *If $\text{ch}_4(I) \neq 0$, σ_I admits a q_I -orthogonal splitting and q_I is non-degenerate on $H^4(W, \mathcal{O}_W)$.*
- (2) *If $\text{ch}_4(I) = 0$ and $\text{ch}_3(I) \neq 0$, let $\kappa_W \in H^1(W, T_W)$ be the Kodaira-Spencer class dual to $\text{ch}_3(I)$. Similarly to the above, we obtain a second strong cosection*

$$\tau: \pi_W^* \kappa_W \circ (\wedge \text{At}(\mathbb{I})) : \mathbb{T}_{\underline{\mathcal{X}}|_X}[1] \longrightarrow \mathcal{O}_X.$$

The map $\sigma_I \oplus \tau_I$ is surjective and admits a q_I -orthogonal splitting such that q_I is non-degenerate on $H^4(W, \mathcal{O}_W) \oplus H^4(W, \mathcal{O}_W)$ with matrix $\begin{pmatrix} 0 & 2 \\ 2 & 0 \end{pmatrix}$. In particular,

$$(7.2) \quad \sigma_I + \tau_I: \text{Ext}^2(I, I)_0 \longrightarrow H^4(W, \mathcal{O}_W)$$

admits a q_I -orthogonal splitting and q_I is non-degenerate on $H^4(W, \mathcal{O}_W)$.

Using the proposition, it is immediate by Definition 4.4 that if $n \neq 0$, the cosection σ for $P_n(W, \beta)$ is non-degenerate, and if $\beta \neq 0$, the cosection $\sigma + \tau$ given pointwise by (7.2) is non-degenerate.

Therefore by Theorem 4.6 we immediately get the following vanishing result for stable pair invariants on hyperkähler fourfolds, which is precisely [CMT22, Claim 2.19].

Theorem 7.2. *Let W be a smooth, projective hyperkähler fourfold and $P_n(W, \beta)$ the moduli space of stable pairs with $n \neq 0$ or $\beta \neq 0$. Then $[P_n(W, \beta)]^{\text{vir}} = 0$.*
