Counterfactual Concealed Telecomputation

Distributed computing is a fastest growing field—enabling virtual computing, parallel computing, and distributed storage. By exploiting the counterfactual techniques, we devise a distributed blind quantum computation protocol to perform a universal two-qubit controlled unitary operation for any input state without using preshared entanglement and without exchanging physical particles between remote parties. This distributed protocol allows Bob to counterfactully apply an arbitrary unitary operator to Alice's qubit in probabilistic fashion, without revealing the operator to her, using a control qubit—called the counterfactual concealed telecomputation (CCT). It is shown that the protocol is valid for general input states and that single-qubit unitary teleportation is a special case of CCT. The quantum circuit for CCT can be implemented using the (chained) quantum Zeno gates and the protocol becomes determistic with simplified circuit implementation if the initial composite state of Alice and Bob is a Bell-type state.

A nonlocal controlled unitary operation (CUO) is one of the fundamental building blocks in distributed quantum computing [1–3] and quantum communications [4– 6]. Recently, it has been shown that any bipartite nonlocal unitary operation on a $d_{\rm A} \times d_{\rm B}$ dimensional quantum system can be implemented using at most $4d_{\rm A} - 5$ nonlocal controlled unitary operators, regardless of $d_{\rm B}$, where $d_{\rm A}$ and $d_{\rm B}$ denote the dimensions of quantum systems possessed by the remote parties Alice and Bob, respectively [7]. In particular, a two-qubit nonlocal controlled unitary operator plays an important role in distributed quantum computing as any n-qubit nonlocal unitary operation can be decomposed into a product of two-qubit nonlocal CUOs and single-qubit operations [7, 8]. Two-qubit nonlocal CUOs have been implemented using entanglement-assisted local operations and classical communication (LOCC) [9, 10].

In general, a two-qubit CUO can be represented as $U_{\rm c} = I \otimes |0\rangle \langle 0| + U \otimes |1\rangle \langle 1|$, where I is the singlequbit identity operator and U is an arbitrary single-qubit unitary operator. To devise a two-qubit nonlocal CUO, $U_{\rm c}$ can be further decomposed to [10, 11]

$$\boldsymbol{U}_{c} = (\boldsymbol{A}_{1} \otimes \boldsymbol{B}_{1}) \left(\sum_{kl} e^{\iota kl\theta} |kl\rangle \langle kl| \right) (\boldsymbol{A}_{2} \otimes \boldsymbol{B}_{2}), \quad (1)$$

where $\iota = \sqrt{-1}$; $|k\rangle$ and $|l\rangle$ denote the computational basis of target and control qubits; and A_1, A_2, B_1 and B_2 are the single-qubit local unitary operators that depend on U. To date, nonlocal CUOs have been implemented using LOCC when the following two conditions are met: i) a sufficient amount of preshared entanglement is available and ii) U is known to *both* Alice and Bob [10].

Blind quantum computation using entanglementassisted LOCC [12–14] is a unique capability enabled by quantum mechanics, which allows one party to use quantum computational resources of a remote party without revealing the input, computation, and output. This quantum task enables a client to perform computation remotely and privately under the unconditional security, which relies on the law of quantum mechanics such as quantum entanglement, quantum nonlocality and quantum nocloning theorem. Counterfactual quantum communication [15, 16] is an other unique capability enabled by quantum mechanics, which allows remote parties to communicate information without exchanging physical particles. The counterfactuality was first introduced based on the bomb detection experiment to determine the presence of a bomb in an interferometer without intreacting with it—namely, the *interaction-free measurement* by using the Mach-Zehnder interferometer [17] and the quantum Zeno (QZ) effect [18]. The direct counterfactual quantum communication protocol is based on the nested version of the Mach-Zehnder interferometer with M outer and N inner cycles—namely, the chained QZ (CQZ) ef*fect*—where a classical bit is encoded in the presence or absence of the absorptive object (e.g., shutter) in the interferometer. To ensure the counterfactuality of the protocol for both classical bits 0 and 1, if any physical particle is found in the quantum channel, the absorptive object absorbs the particle and declares the erasure of the classical information. In contrast, the quantum absorptive object (e.g., electron, trapped ions), which can take superposition of the absence and presence, is required to transfer quantum information in counterfactual way [19]. In addition to quantum communication, the counterfactuality has been successfully used in quantum computation [20, 21] and quantum cryptography [22, 23].

This letter put forth a new type of blind quantum computation without using preshared entanglement and without exchanging physical particles between remote parties. A fudamental building block of blind quantum computation is a protocol that enables Bob to counterfactually apply an arbitrary unitary operator U to Alice's qubit in probabilistic fashion, without revealing U

Alice and Bob counterfactually apply the operation \boldsymbol{Q}_3 on their composite state and transform the composite state as $|\psi_{6m}\rangle_{\rm AB} = \gamma \left(\boldsymbol{I} |\psi\rangle_{\rm A}\right) \otimes |0\rangle_{\rm B} + \delta \left(\boldsymbol{U}_m |\psi\rangle_{\rm A}\right) \otimes |1\rangle_{\rm B}$ where $\boldsymbol{U}_m = \boldsymbol{R}_z(\phi) \boldsymbol{R}_y((-1)^m \theta) \boldsymbol{R}_z(\varphi)$. Here \boldsymbol{I} denotes the single-qubit identity matrix and \boldsymbol{X} is the Pauli x operator.

to Alice, using a control qubit. This is accomplished by decomposing the two-qubit CUO corresponding to Uinto global controlled flipping operations and local operations at the remote parties. The key features of this protocol are that i) the global controlled flipping operations are implemented in counterfactual way, and ii) both the global operations and Alice's local operations are implemented in a way that U is concealed from Alice. This protocol is called counterfactual concealed telecomputation (CCT). The counterfactual implementation of global controlled flipping operations using the QZ [24] and CQZ gates [19, 25, 26] is given in the supplementary material where Alice's qubit acts as a quantum absorptive object to ensure the counterfactuality of the protocol [27]. The protocol is shown to be valid for general input states, and single-qubit unitary teleportation [28, 29] can be seen as a special case of CCT. If the composite state of Alice and Bob is a Bell-type state, the protocol becomes deterministic and the quantum circuit for CCT can be simplified significantly.

The protocol.— In general, a single-qubit unitary operator \boldsymbol{U} can be represented as $\boldsymbol{U} = \boldsymbol{R}_{z}(\phi) \boldsymbol{R}_{y}(\theta) \boldsymbol{R}_{z}(\varphi)$ where ϕ , θ , and φ are the Euler angles, and the rotation matrices are given by

$$\boldsymbol{R}_{y}(\theta) = \begin{bmatrix} \cos\left(\theta/2\right) & -\sin\left(\theta/2\right) \\ \sin\left(\theta/2\right) & \cos\left(\theta/2\right) \end{bmatrix}, \quad (2)$$

$$\boldsymbol{R}_{\mathbf{z}}(\varphi) = \begin{bmatrix} e^{-\iota\varphi/2} & 0\\ 0 & e^{\iota\varphi/2} \end{bmatrix}.$$
 (3)

The proposed CCT protocol will counterfactually implement controlled- U_m on Alice's qubit, without revealing U_m to Alice as shown in Fig. 1, where

$$\boldsymbol{U}_{\mathsf{m}} = \boldsymbol{R}_{\mathsf{z}}(\phi) \, \boldsymbol{R}_{\mathsf{y}}((-1)^{\mathsf{m}} \, \theta) \, \boldsymbol{R}_{\mathsf{z}}(\varphi) \,, \qquad (4)$$

with

$$\mathbb{P}\{\mathsf{m} = m\} = \begin{cases} \frac{1}{2}, & \text{for } m = 0, \\ \frac{1}{2}, & \text{for } m = 1. \end{cases}$$
(5)

To demonstrate the implementation of CCT (see Fig. 1), consider the arbitrary pure input states of Alice's target qubit $|\psi\rangle_{\rm A}$ and Bob's control qubit $|\psi\rangle_{\rm B}$ as follows:

$$\left|\psi\right\rangle_{\mathcal{A}} = \alpha \left|0\right\rangle_{\mathcal{A}} + \beta \left|1\right\rangle_{\mathcal{A}},\tag{6}$$

$$\left|\psi\right\rangle_{\rm B} = \gamma \left|0\right\rangle_{\rm B} + \delta \left|1\right\rangle_{\rm B},\tag{7}$$

with the complex coefficients α , β , γ , and δ satisfying $|\alpha|^2 + |\beta|^2 = 1$ and $|\gamma|^2 + |\delta|^2 = 1$. Bob starts the protocol by performing the local CNOT operation to entangle his qubit with the ancillary qutrit $|0\rangle_{\rm C}$. Alice and Bob conterfactually apply Toffoli gate T by using the CQZ gate (see Fig. S8 in the supplementary material), with Alice's qubit and ancillary qutrit as control and Bob's qubit as a target. To ensure the conterfactuality of the protocol, if any physical particle is transmitted over the quantum channel, Alice's quantum absorptive object absorbs the particle and both parties (Alice and Bob) discard the protocol. Unless the protocol is discarded, Bob applies the following local operation $V_1(U)$ on his qubit and ancillary qutrit:

where

$$V_{11} = \boldsymbol{I} \otimes |0\rangle_{\rm C} \langle 0| + (\boldsymbol{R}_{\rm z}(\varphi) \, \boldsymbol{X}) \otimes |1\rangle_{\rm C} \langle 1| + \boldsymbol{I} \otimes |2\rangle_{\rm C} \langle 2|$$
(9)

(8)

 $V_1(U) = V_{14}V_{13}V_{12}V_{11},$

$$V_{12} = |0\rangle_{\rm B} \langle 0| \otimes \boldsymbol{I} + |10\rangle_{\rm BC} \langle 10| + |12\rangle_{\rm BC} \langle 11| + |11\rangle_{\rm BC} \langle 12|, \qquad (10)$$

$$V_{13} = \boldsymbol{I} \otimes |0\rangle_{\mathrm{C}} \langle 0| + (\boldsymbol{R}_{\mathrm{z}}(\phi) \ \boldsymbol{R}_{\mathrm{y}}(\theta)) \otimes |1\rangle_{\mathrm{C}} \langle 1| + (\boldsymbol{R}_{\mathrm{c}}(\phi) \ \boldsymbol{R}_{\mathrm{y}}(\theta)) \otimes |2\rangle_{\mathrm{C}} \langle 2|, \qquad (11)$$

$$V_{14} = \boldsymbol{I} \otimes (|0\rangle_{\rm C} \langle 0| + |1\rangle_{\rm C} \langle 1|) + \boldsymbol{X} \otimes |2\rangle_{\rm C} \langle 2|, \qquad (12)$$

and X denotes the Pauli x operator. Note that the dependence of V_1 on U is through V_{11} and V_{13} . Now, Alice and Bob counterfactually apply the following two consecutive controlled flipping operations Q_1 and Q_2 by using the QZ and CQZ gates, respectively (see Fig. S8 in the supplementary material) where

$$Q_{1} = \boldsymbol{I} \otimes \left(|00\rangle_{\mathrm{BC}} \langle 00| + |01\rangle_{\mathrm{BC}} \langle 01| \\ + |10\rangle_{\mathrm{BC}} \langle 10| + |02\rangle_{\mathrm{BC}} \langle 02| \right)$$
(13)
$$+ \boldsymbol{X} \otimes \left(|11\rangle_{\mathrm{BC}} \langle 11| + |12\rangle_{\mathrm{BC}} \langle 12| \right),$$
$$Q_{2} = \left(|0\rangle_{\mathrm{A}} \langle 0| + |1\rangle_{\mathrm{A}} \langle 1| \right) \otimes \boldsymbol{I} \otimes |0\rangle_{\mathrm{C}} \langle 0| \\ + |1\rangle_{\mathrm{A}} \langle 1| \otimes \boldsymbol{I} \otimes |1\rangle_{\mathrm{C}} \langle 1| \\ + |0\rangle_{\mathrm{A}} \langle 0| \otimes \boldsymbol{I} \otimes |2\rangle_{\mathrm{C}} \langle 2|$$
(14)
$$+ |0\rangle_{\mathrm{A}} \langle 0| \otimes \boldsymbol{X} \otimes |1\rangle_{\mathrm{C}} \langle 1| \\ + |1\rangle_{\mathrm{A}} \langle 1| \otimes \boldsymbol{X} \otimes |2\rangle_{\mathrm{C}} \langle 2|.$$

Bob applies the local operation V_2 on his qubit and ancillary qutrit:

$$V_{2} = |0\rangle_{B} \langle 0| \otimes I + |1\rangle_{B} \langle 1| \otimes (|0\rangle_{C} \langle 1| + |1\rangle_{C} \langle 2| + |2\rangle_{C} \langle 0|), \qquad (15)$$

followed by the Hadamard gate H on the ancillary qutrit to disentangle the ancillary qutrit from Alice's and Bob's qubits. At the end of the protocol, Bob performs the measurement on the ancillary qutrit in the computational basis where $m \in \{0, 1\}$ is a measurement outcome with equal probability. Bob announces the measurement result with classical communication and applies the unitary operation Q_3 in counterfactual way where

$$\boldsymbol{Q}_{3} = \begin{cases} \boldsymbol{I}, & \text{for } m = 0, \\ (\boldsymbol{Z} \otimes \boldsymbol{X}) \, \boldsymbol{Z}_{c} \left(\boldsymbol{I} \otimes \boldsymbol{X} \right), & \text{for } m = 1, \end{cases}$$
(16)

and Z_c is the controlled-Z operation and Z denotes the Pauli z operator. To implement the set of global flipping operations T, Q_1, Q_2 and Q_3 counterfactually, there is the nonzero probability—called the *abortion rate* [30] that the physical particle is found in the quantum channel and the protocol fails in counterfactuality. This abortion rate vanishes asymptotically as the cycle numbers of QZ and CQZ gates increase. In case any physical particle is traveled over the quantum channel, Alice and Bob discard the protocol to ensure the full counterfactuality of CCT. Unless the protocol is discarded, the CCT protocol transforms the initial state $|\psi_0\rangle_{AB} = |\psi\rangle_A |\psi\rangle_B$ for the measurement outcome m as follows:

$$\left|\psi_{6m}\right\rangle_{AB} = \gamma \left(\boldsymbol{I} \left|\psi\right\rangle_{A}\right) \otimes \left|0\right\rangle_{B} + \delta \left(\boldsymbol{U}_{m} \left|\psi\right\rangle_{A}\right) \otimes \left|1\right\rangle_{B}.$$
(17)

The equation (17) shows that Bob has successfully performed the CCT on Alice's qubit. Note that the detailed state transformations $|\psi_1\rangle_{ABC}$ to $|\psi_{6m}\rangle_{AB}$ can be found in the supplementary material.

For the unitary teleportation as a special case of the CCT protocol, Bob sets the initial state of his qubit to $|\psi\rangle_{\rm B} = |1\rangle_{\rm B}$, then

$$\left|\psi_{6m}\right\rangle_{AB} = \left(\boldsymbol{U}_{m}\left|\psi\right\rangle_{A}\right) \otimes \left|1\right\rangle_{B}.$$
 (18)

Equation (18) shows that at the end of the protocol, the qubits of Alice and Bob are in a separable state, resulting in the unitary transformation of the arbitrary input state $|\psi\rangle_{\rm A}$ of Alice—also known as the quantum remote control.

Bell-type states.— Consider that initial states of Alice and Bob are Bell-type states (see Fig. 2). In general, the Bell-type states are given as

$$\psi_{0}\rangle_{AB} : \begin{cases} |\psi_{00}^{\pm}\rangle_{AB} = \alpha |00\rangle_{AB} \pm \beta |11\rangle_{AB}, \\ |\psi_{01}^{\pm}\rangle_{AB} = \gamma |01\rangle_{AB} \pm \delta |10\rangle_{AB}, \end{cases}$$
(19)

where $|\psi_{0\ell}^{\pm}\rangle_{AB}$, $\ell = 0, 1$, are called the ℓ -class states. Assume that Bob knows either the input is an 0-class or 1-class state. Similar to the general scheme, Bob starts

the protocol by entangling his qubit with the ancillary qubit. Bob directly applies

$$\tilde{\boldsymbol{V}}_{1}(\boldsymbol{U}) = \boldsymbol{I} \otimes |0\rangle_{\mathrm{C}} \langle 0| + \left(\boldsymbol{X}^{1-\ell} \boldsymbol{U} \boldsymbol{X}^{\ell}\right) \otimes |1\rangle_{\mathrm{C}} \langle 1|, \quad (20)$$

for the $\ell\text{-class}$ states. Now Alice and Bob counterfactually apply

$$\hat{\boldsymbol{Q}}_{1} = \boldsymbol{I} \otimes \left(|00\rangle_{\mathrm{BC}} \langle 00| + |01\rangle_{\mathrm{BC}} \langle 01| + |10\rangle_{\mathrm{BC}} \langle 10| \right) + \boldsymbol{X} \otimes \left(|11\rangle_{\mathrm{BC}} \langle 11| \right),$$
(21)

followed by

$$\tilde{\boldsymbol{Q}}_{2} = \left(\left| 0 \right\rangle_{A} \langle 0 \right| + \left| 1 \right\rangle_{A} \langle 1 \right| \right) \otimes \boldsymbol{I} \otimes \left| 0 \right\rangle_{C} \langle 0 \right| \\ + \left| 1 \right\rangle_{A} \langle 1 \right| \otimes \boldsymbol{X}^{1-\ell} \otimes \left| 1 \right\rangle_{C} \langle 1 \right| \\ + \left| 0 \right\rangle_{A} \langle 0 \right| \otimes \boldsymbol{X}^{\ell} \otimes \left| 1 \right\rangle_{C} \langle 1 \right|,$$
(22)

for the ℓ -class states. At the end of the protocol, Bob applies the local CNOT operation at his qubits to disentangle the ancillary qubit. Again, there exists the abortion rate [31] that the physical particle is transmitted over the quantum channel and the protocol fails to implement the set of global flipping operations \tilde{Q}_1 and \tilde{Q}_2 counterfactually—which tends to zero under the asymptotic limits. In case any physical particle is traveled over the quantum channel, the protocol aborts to ensure the full counterfactuality. Unless the protocol is discarded, the CCT protocol for Bell-type states transforms $|\psi_0\rangle_{AB}$ as follows:

$$|\psi\rangle_{\rm ABC} = |\psi_1\rangle_{\rm AB} \otimes |0\rangle_{\rm C}\,,\tag{23}$$

where

$$|\psi_1\rangle_{AB} = \left(\boldsymbol{I} \otimes |0\rangle_B \langle 0| + \boldsymbol{U} \otimes |1\rangle_B \langle 1| \right) |\psi_0\rangle_{AB}.$$
 (24)

As the ancillary qubit is already in a separable state with qubits $|\psi_1\rangle_{AB}$, Bob does not need to perform measurement on his ancillary qubit.

In summary, we devise a new protocol for distributed quantum computing that allows Alice and Bob to apply a two-qubit CUO on any input state in probabilistic fashion without using preshared entanglement, without revealing the unitary operator to Alice, and without exchanging physical particles between remote parties.

• As any *n*-qubit unitary operator can be decomposed into the product of two-qubit unitary operators and single qubit operators, the CCT protocol enables Bob to apply an arbitrary unitary operation on Alice's arbitrary number of qubits remotely in concealed way without transmitting any physical particle over the quantum channel and without using preshared entanglement. As nonlocal controlled flipping operators Q_1 and Q_2 (or \tilde{Q}_1 and \tilde{Q}_2) are independent of states, the protocol is oblivious to the input states of Alice and Bob, leading to universal concealed telecomputation on arbitrary input states.

• As the unitary teleportation is a special case of the CCT protocol, Bob is able to appeal quantum remote control at a distinct party (Alice) without using transmitting any physical particle over the quantum channel and without using preshared entanelement. As unitary operator U is unknown to Alice, the CCT protocol can play an important role for the cryptography tasks such as quantum secure direct communication, quantum secret sharing and distributed quantum secure computation. While we do not discuss the security of the protocol, future work may consider suitable variations of the current protocol for the cryptography tasks.

The abortion rate of CCT decreases with the cycle numbers M and N, whereas the stability of the nested Mach-Zehender interferometer improves with decreasing these cycle numbers. This problem may limit the success probability of the CCT protocol and needs to be overcome in future work towards effective CCT.

Supplementary Material: Counterfactual Concealed Telecomputation

Abstract

We demonstrate the state transformations of the CCT protocol followed by the counterfactual implementation of global operations without using preshared entanglement and without transmitting any physical particle over the quantum channel. We put forth i) the fundamental gates required for the counterfactual implementation of the global operations, ii) the CCT protocol for general input states, and iii) the CCT protocol for Bell-type input states. We also obtain the probability that the protocol fails in counterfactuality—called the abortion rate of CCT—which vanishes asymptotically.

PRELIMINARIES

The counterfactual quantum communication [S15, S16] is based on the single-particle nonlocality and quantum measurement theory. A quantum state usually collapses back to its initial state if the time between repeated measurements is short enough [S24]. This quantum Zeno (QZ) effect has been demonstrated to achieve the interaction-free measurement (IFM) where the the state of a photon acts as an unstable quantum state corresponding to the presence of the absorptive object [S18]. We begin with detailed state transformations of the CCT protocol for general input states and then briefly review the overall actions of the QZ and chained QZ (CQZ) gates [S25, S26] that are invoked to devise CCT.

\mathbf{CCT}

Alice and Bob start the protocol with the initial composite state $|\psi_0\rangle_{AB} = |\psi\rangle_A |\psi\rangle_B$ where $|\psi\rangle_A$ and $|\psi\rangle_B$ are given in (6) and (7) of the main text, respectively. Bob applies the CNOT operation locally where Bob's qubit acts as a control and the ancillary qutrit is a target (see Fig. 1 in the main text). It transforms $|\psi_0\rangle_{AB}$ to

which can be written as (17) in the main text. Note that the probability ζ_m that the CCT protocol fails in counterfactuality—called the *abortion rate*—is given in (S44) when the global operations T, Q_1, Q_2 and Q_3 are counterfactually implemented using the QZ and CQZ gates.

QZ Gates

Fig. S1 shows the Michelson version of the QZ gate [S26] to perform IFM. The QZ gate is to ascertain the classical behavior of an absorptive object, i.e., to infer the absence state $|0\rangle_{AO}$ or the presence state $|1\rangle_{AO}$ of AO without interacting with it. The H(V)-QZ_N gate takes an H (V) polarized photon as input. The switchable mirror SM_N is initially turned off to allow passing the photon and is turned on for N cycles once the photon is passed. After N cycles, SM_N is turned off again allowing the photon out. The polarization rotator PR_N^{H(V)} gives rotation to the input photon by an angle $\theta_N = \pi/(2N)$ as follows:

The photon state $|\phi\rangle$ after $PR_N^{H(V)}$ in the first cycle of the H(V)- QZ_N gate is given by

Then, the polarizing beam splitter PBS separates the H and V components of the photon into two different optical paths: $SM \rightarrow MR_1$ and $SM \rightarrow MR_2$. The H (V) component goes towards MR_1 and the V (H) component goes towards MR_2 . The photon component in the second optical path only interacts with AO (control terminal).

• AO = $|0\rangle_{AO}$: In the absence of the absorptive object, the V (H) component of the photon is reflected by MR₂ and is returned back to PBS. Hence, the photon state remains unchanged. After n (< N) cycles, the photon state is given by

$$\left|\phi\right\rangle = \cos\left(n\theta_{N}\right)\left|\mathrm{H}\left(\mathrm{V}\right)\right\rangle_{\mathrm{p}} + \sin\left(n\theta_{N}\right)\left|\mathrm{V}\left(\mathrm{H}\right)\right\rangle_{\mathrm{p}}.$$

The photon will end up in the state $|V(H)\rangle_p$ with certainty by $\pi/2$ rotation after N cycles.

• AO = $|1\rangle_{AO}$: In the presence of the absorptive object, the V (H) component is absorbed by AO if it is found in the control terminal. In each cycle, the probability of this absorption event is equal to $\sin^2 \theta_N$. Unless the photon is absorbed, the photon state collapses to the initial state $|H(V)\rangle_p$. After N cycles, the photon is not absorbed and ends up in the state $|H(V)\rangle_p$ with probability $\cos^{2N} \theta_N$ tending to one as $N \to \infty$.

Table I shows the overall action of the QZ gate. Note that the H(V)- QZ_N gate has the output $|H(V)\rangle_p$ in the presence state $|1\rangle_{AO}$ if the photon has not traveled over the control terminal (quantum channel). Hence, the QZ gate is counterfactual only for this measurement outcome.



FIG. S3. A quantum absorptive object (electron) for (a) the QZ gate (type I) and (b) the CQZ gate (type II). The electron takes the superposition of two paths $|\uparrow\rangle_e$ and $|\downarrow\rangle_e$. In type I, the electron states $|\uparrow\rangle_e$ and $|\downarrow\rangle_e$ act as the presence (absence) state $|1(0)\rangle_{AO}$ and the absence (presence) state $|0(1)\rangle_{AO}$ of the absorptive object for the H(V)-QZ gate, respectively. In type II, the electron states simply act as $|\uparrow\rangle_e = |0\rangle_{AO}$ and $|\downarrow\rangle_e = |1\rangle_{AO}$ for the CQZ gate. If the photon is absorbed by the electron, the electron state is in an erasure state orthogonal to $|\uparrow\rangle_e$ and $|\downarrow\rangle_e$.

CQZ Gates

Fig. S2 shows the nested version of QZ gates with M outer and N inner cycles [S25]. The CQZ gate enables to ascertain the absence or presence of the absorptive object counterfactually for both the outcomes. The H(V)-CQZ_{M,N} gate also takes an H (V) polarized photon as input. In each outer cycle, the V (H) component of the photon enters the inner V(H)-QZ_N gate.

• AO = $|0\rangle_{AO}$: In the absence of the absorptive object, the inner V(H)-QZ_N gate transforms the photon state $|V(H)\rangle_p$ into $|H(V)\rangle_p$ after N cycles. This component ends up at the detector D after PBS. Hence, the inner QZ gate acts as an absorptive object for the outer QZ gate in the absence state $|0\rangle_{AO}$, where D serves to detect the event that the photon is found in the control terminal. In each outer cycle, unless the photon is discarded, the photon state collapses back to the initial state $|H(V)\rangle_p$ with probability $\cos^2 \theta_M$. After M outer cycles, the photon is not discarded at the detector D and ends up in the initial state $|H(V)\rangle_p$ with probability

$$\lambda_0 = \cos^{2M} \theta_M. \tag{S10}$$

tending to one as $M \to \infty$.

• AO = $|1\rangle_{AO}$: In case the absorptive object is present, the V (H) component of the photon recombines with the H (V) component and the photon state remains unchanged for the next outer cycle, unless the photon is absorbed by AO. Hence, the inner QZ gate acts as a mirror for the outer QZ gate in the presence state $|1\rangle_{AO}$. After i (< M) outer cycles, unless the photon is absorbed, the photon state is given by (S9), which is again not absorbed by AO for the next outer cycle with probability

$$\left[1 - \sin^2\left(i\theta_M\right)\sin^2\theta_N\right]^N.$$

Hence, unless the photon is absorbed by AO, the H(V)-CQZ_{*M*,*N*} gate transforms the input state $|H(V)\rangle_{p}$ into $|V(H)\rangle_{p}$ with probability

tending to one as $M, N \to \infty$.

Note that the CQZ gate is counterfactual for both the outcomes and infers the absence or presence of the absorptive object (with probability λ_0 or λ_1) but no physical particle (photon) is found in the control terminal (see Table I).

CCT IMPLEMENTATION USING QZ AND CQZ GATES

As shown in Fig. S3, an electron as a quantum absorptive object takes superposition of two paths $|\uparrow\rangle_{\rm e}$ and $|\downarrow\rangle_{\rm e}$ where the subscript e denotes the electron. In type I (Fig. S3(a)), the electron state $|\uparrow (\downarrow)\rangle_{\rm e}$ or $|\downarrow (\uparrow)\rangle_{\rm e}$ acts as the presence state $|1\rangle_{\rm AO}$ or the absence state $|0\rangle_{\rm AO}$ of the absorptive object for the H(V)-QZ_N gate. For the counterfactuality of the protocol, we setup four gates:

- 1) counterfactual electron-photon intereaction (CEPI) gates using the H(V)- QZ_N gate;
- 2) dual CEPI (D-CEPI) gates using the dual QZ (DQZ) gate;
- 3) distributed controlled flipping operation (DCFO) gates using the CEPI gates;

If the photon is found in the quantum channel, the pair of photon and electron is discarded in transforming $|\eta_1\rangle_{ep}$ to $|\eta_2\rangle_{ep}$ where the photon that has traveled over the channel is diverted again to the quantum absorptive object and absorbed by the electron. This electron-photon interaction is designed to output the photon and electron by using the presence state (blocking event) only. Hence, the protocol is fully counterfactual.

4) dual DCFO (D-DCFO) gates using the D-CEPI gates.

From the above list of gates, the second (first) and forth (third) gates are used to devise the CCT for general (Bell-type) input states.

CEPI Gates

Fig. S4 shows the H(V)-CEPI_N gate where the quantum absorptive object is in the superposition state

where $\nabla_0 = |\alpha|^2 (|\beta|^2)$ is the probability that the electron is in the presence state for the H(V)-QZ_N gate.

The second (first) term of $|\eta_1\rangle_{ep}$ is the outcome corresponding to the electron in the absence state for the

H(V)- QZ_N gate. Since this outcome is not counterfactual, it is discarded (absorbed) by the electron using the $PBS^{H(V)}$ and the X operator. To discard the factual (non-counterfactual) outcome $|V(H)\rangle_p$ of the H(V)- QZ_N gate, $PBS^{H(V)}$ redirects this photon component to the quantum absorptive object (followed by the X operator) to be absorbed by the electron. Hence, whenever the photon is found in the quantum channel, the electron absorbs it and becomes in an erasure state, leading the H(V)-CEPI_N gate to output no photon and electron (e.g., particles in the erasure state). This enables the protocol to abort nonlocally by discarding both the photon and the electron whenever its counterfactuality is broken.

D-CEPI Gates

Fig. S5 shows the dual form of the H(V)-CEPI_N gate in Fig. S4. For counterfacuality, this D-CEPI_N gate works similarly to the H(V)-CEPI_N gate. The only difference is that the superposition polarization state

where $\nabla_1 = |\alpha \gamma|^2 + |\beta \delta|^2$ is the probability that the electron is in the presence state for QZ gates in both paths.

DCFO Gates

To devise the DCFO gate, $K \operatorname{H}(V)$ -CEPI_N gates are concatenated serially where Alice has the quantum absorptive object (electron) and Bob equips the QZ gates (see Fig. S6). To explain the operation of the DCFO_{K,N} gate, consider the Bell-type state of electron-photon pair

$$|\eta_0\rangle_{\rm ep} : \begin{cases} |\eta_{00}^{\pm}\rangle_{\rm ep} = \alpha |\uparrow \mathrm{H}\rangle_{\rm ep} \pm \beta |\downarrow \mathrm{V}\rangle_{\rm ep} ,\\ |\eta_{01}^{\pm}\rangle_{\rm ep} = \gamma |\uparrow \mathrm{V}\rangle_{\rm ep} \pm \delta |\downarrow \mathrm{H}\rangle_{\rm ep} , \end{cases}$$
(S24)

where $|\eta_{00}^{\pm}\rangle_{\rm ep}$ and $|\eta_{01}^{\pm}\rangle_{\rm ep}$ are 0- and 1-class states, respectively. The H(V)-DCFO_{K,N} protocol for Bell-type states of 1(0)-class takes the following steps.

- 1. Bob starts the H(V)-DCFO_{K,N} protocol by throwing his photon towards PBS^V, which allows the V component to pass and detour the H component to be recombined after K successive H(V)-CEPI_N operations. Bob performs the \mathcal{B} operator on the V photon component where $\mathcal{B} = X^{\ell}$ for ℓ -class states.
- 2. Alice performs $\mathbf{R}_{y}(2\theta_{K})$ on her qubit (electron) where $\theta_{K} = \pi/(2K)$. The rotation gate $\mathbf{R}_{y}(2\theta_{K})$ transforms $|\uparrow\rangle_{e}$ and $|\downarrow\rangle_{e}$ as follows:

$$\left|\uparrow\right\rangle_{\rm e} \to \cos\theta_K \left|\uparrow\right\rangle_{\rm e} + \sin\theta_K \left|\downarrow\right\rangle_{\rm e},\qquad(S25)$$

$$\left|\downarrow\right\rangle_{\rm e} \to \cos\theta_K \left|\downarrow\right\rangle_{\rm e} - \sin\theta_K \left|\uparrow\right\rangle_{\rm e}.$$
 (S26)

3. Bob inputs the H (V) component to the H(V)-CEPI_N gate. Unless the photon is absorbed by the electron, the first H(V)-CEPI_N gate transforms the $|\eta_0\rangle_{ep}$ as follows:

$$\left|\eta_{1}\right\rangle_{\text{epa}}:\begin{cases}\left|\eta_{10}^{\pm}\right\rangle_{\text{epa}} = \alpha\left(\cos\theta_{K}\left|\uparrow \text{H0}\right\rangle_{\text{epa}} + \sin\theta_{K}\left|\downarrow \text{H0}\right\rangle_{\text{epa}}\right) \pm \beta\left|\downarrow \text{V1}\right\rangle_{\text{epa}},\\\left|\eta_{11}^{\pm}\right\rangle_{\text{epa}} = \gamma\left|\uparrow \text{H1}\right\rangle_{\text{epa}} \pm \delta\left(\cos\theta_{K}\left|\downarrow \text{H0}\right\rangle_{\text{epa}} - \sin\theta_{K}\left|\uparrow \text{H0}\right\rangle_{\text{epa}}\right)\end{cases}$$
(S27)

with probability

$$\nabla_2 = \left(1 - \nabla \cos^2 \theta_K \sin^2 \theta_N\right)^N \left(1 - \nabla \sin^2 \theta_K\right),$$
(S28)

where $\nabla = |\gamma|^2 (|\beta|^2)$. Whenever the photon is found in the transmission channel between Alice and Bob, the electron absorbs it and the protocol declares an erasure.

4. Alice and Bob repeat the second and third steps for subsequent H(V)-CEPI_N gates. After K H(V)-CEPI_N gates, unless the photon is absorbed by the electron, Bob performs the \mathcal{B} operator again on the output photon to recombine the H and V components of the photon and the composite state of electron-photon pair transforms to:

$$|\eta_2\rangle_{\rm ep} : \begin{cases} |\eta_{20}^{\pm}\rangle_{\rm ep} = \alpha |\downarrow \mathbf{H}\rangle_{\rm ep} \pm \beta |\downarrow \mathbf{V}\rangle_{\rm ep}, \\ |\eta_{21}^{\pm}\rangle_{\rm ep} = \gamma |\uparrow \mathbf{V}\rangle_{\rm ep} \mp \delta |\uparrow \mathbf{H}\rangle_{\rm ep} \end{cases}$$
(S29)

with probability

$$\nabla_3 = \nabla_2^K. \tag{S30}$$

D-DCFO Gates

Similar to the H(V)-DCFO_{K,N} gate, K D-CEPI_N gates are concatenated serially to devise the D-DCFO gate where Alice has quantum absorptive object (electron) and Bob equips QZ_N gates, as shown in Fig. S7. To explain the operation of the D-DCFO_{K,N} gate, consider the initial state of electron-photon pair

$$\begin{aligned} \left|\eta_{0}\right\rangle_{\rm epa} &= \frac{1}{\sqrt{2}} \left(\alpha \left|\downarrow \mathbf{H}\right\rangle_{\rm ep} + \beta \left|\uparrow \mathbf{V}\right\rangle_{\rm ep}\right) \left|0\right\rangle_{\rm a} \\ &\frac{1}{\sqrt{2}} \left(\gamma \left|\uparrow \mathbf{H}\right\rangle_{\rm ep} + \delta \left|\downarrow \mathbf{V}\right\rangle_{\rm ep}\right) \left|1\right\rangle_{\rm a} \,. \end{aligned} \tag{S31}$$

The D-DCFO_{K,N} gate takes the following steps.

1. Bob starts the D-DCFO by applying PBS^V in each path of the photon and recombines the respective components of the photon after K successive D-CEPI_N operations. Bob applies the \boldsymbol{X} operator on the photon component in path state $|0\rangle_a$.

2. Now, Alice performs $\mathbf{R}_{y}(2\theta_{K})$ on her qubit and Bob inputs the photon components in path states $|0\rangle_{a}$ and $|1\rangle_{a}$ to the D-CEPI_N gate. Unless the photon is absorbed by the electron, the first D-CEPI_N gate transforms the $|\eta_{0}\rangle_{epa}$ as

$$\eta_{1}\rangle_{\rm epa} = \frac{1}{\sqrt{2}} \left(\beta \mid \uparrow H0 \rangle_{\rm epa} + \delta \mid \downarrow V1 \rangle_{\rm epa} + \alpha \cos \theta_{K} \mid \downarrow H2 \rangle_{\rm epa} - \alpha \sin \theta_{K} \mid \uparrow H2 \rangle_{\rm epa} + \gamma \cos \theta_{K} \mid \uparrow H3 \rangle_{\rm epa} + \gamma \sin \theta_{K} \mid \downarrow H3 \rangle_{\rm epa} \right)$$
(S32)

with probability

$$\nabla_5 = \left(1 - \nabla_4 \cos^2 \theta_K \sin^2 \theta_N\right)^N \\ \left(1 - \nabla_4 \sin^2 \theta_K\right),$$
(S33)

where $\nabla_4 = |\beta|^2 + |\delta|^2$.

3. Alice and Bob repeat the second step for subsequent D-CEPI_N gates. After K D-CEPI_N gates, unless the photon is absorbed by the electron, Bob performs the \boldsymbol{X} operator on the photon component in path state $|0\rangle_{\rm a}$ and recombines the respective photon components. Then, the composite state of electron-photon pair transforms to

$$\begin{aligned} \left| \eta_2 \right\rangle_{\rm epa} &= \frac{1}{\sqrt{2}} \left(-\alpha \left| \uparrow \mathbf{H} \right\rangle_{\rm ep} + \beta \left| \uparrow \mathbf{V} \right\rangle_{\rm ep} \right) \left| 0 \right\rangle_{\rm a} \\ &\frac{1}{\sqrt{2}} \left(\gamma \left| \downarrow \mathbf{H} \right\rangle_{\rm ep} + \delta \left| \downarrow \mathbf{V} \right\rangle_{\rm ep} \right) \left| 1 \right\rangle_{\rm a} \end{aligned}$$
 (S34)

with probability

$$\nabla_6 = \nabla_5^K. \tag{S35}$$

CCT for General Input States

For the CCT with general input states, Alice and Bob prepare the target and control qubits in electron and photon: $|\psi\rangle_{\rm A} = |{\rm electron}\rangle_{\rm e}$ and $|\psi\rangle_{\rm B} = |{\rm photon}\rangle_{\rm p}$ where

$$\begin{split} &|0\rangle_{\mathrm{A}} = |\uparrow\rangle_{\mathrm{e}} \,, \\ &|1\rangle_{\mathrm{A}} = |\downarrow\rangle_{\mathrm{e}} \,, \\ &|0\rangle_{\mathrm{B}} = |\mathrm{H}\rangle_{\mathrm{p}} \,, \\ &|1\rangle_{\mathrm{B}} = |\mathrm{V}\rangle_{\mathrm{p}} \,. \end{split} \tag{S36}$$

To devise the CCT, Alice and Bob takes the following steps (see Fig. S8).

- 1. Bob starts the protocol by throwing his photon towards PBS^H to entangle the polarization (control qubit) state $|\psi\rangle_{\rm B}$ with path state $|0\rangle_{\rm C}$. Then Alice and Bob have the composite state $|\psi_1\rangle_{\rm ABC}$ in (S1).
- 2. Bob detours the H component of the photon to recombine it at the end of the protocol and inputs the V component of the photon to the V-CQZ_{*M*,*N*} gate. Unless the photon is absorbed by the electron or discarded at the detector in V-CQZ_{*M*,*N*} gate, it transforms $|\psi_1\rangle_{ABC}$ to $|\psi_2\rangle_{ABC}$ in (S2) with probability

$$\lambda_2 = \left(1 - |\alpha\delta|^2 \sin^2 \theta_M\right)^M$$
$$\prod_{i=1}^M \left[1 - |\beta\delta|^2 \sin^2 (i\theta_M) \sin^2 \theta_N\right]^N$$
(S37)

tending to one as $M, N \to \infty$.

3. Bob applies the $\mathcal{B}_1 = \mathbf{R}_z(\varphi) \mathbf{X}$ operation followed by PBS^H on the component of the photon in path state $|1\rangle_{\rm C}$.

- 4. Bob applies $\mathcal{B}_2 = \mathbf{R}_z(\phi) \mathbf{R}_y(\theta)$ and $X\mathcal{B}_2$ operators on the photon components in the path states $|1\rangle_C$ and $|2\rangle_C$, respectively. Then, the composite state of Alice and Bob transforms to $|\psi_3\rangle_{ABC}$ in (S3).
- 5. Bob inputs the photon components in path states $|1\rangle_{\rm C}$ and $|2\rangle_{\rm C}$ to the D-DCFO_{K,N} gate. From (S31)–(S34), unless the photon is absorbed by the electron in the D-DCFO_{K,N} gate, it transforms $|\psi_3\rangle_{\rm ABC}$ as follows:

$$\begin{split} \psi_{3}^{\prime}\rangle_{\mathrm{ABC}} &= \gamma \left|\psi\right\rangle_{\mathrm{A}}\left|00\right\rangle_{\mathrm{BC}} \\ &+ \delta \alpha e^{-\iota(\varphi+\phi)/2} \cos\left(\theta/2\right)\left|101\right\rangle_{\mathrm{ABC}} \\ &+ \delta \alpha e^{-\iota(\varphi-\phi)/2} \sin\left(\theta/2\right)\left|011\right\rangle_{\mathrm{ABC}} \\ &- \delta \beta e^{\iota(\varphi+\phi)/2} \cos\left(\theta/2\right)\left|002\right\rangle_{\mathrm{ABC}} \\ &- \delta \beta e^{\iota(\varphi-\phi)/2} \sin\left(\theta/2\right)\left|112\right\rangle_{\mathrm{ABC}} \end{split}$$
(S38)

with probability

$$\lambda_3 = \left(1 - |\delta|^2 \sin^2\left(\theta/2\right) \cos^2\theta_K \sin^2\theta_N\right)^{KN} \left(1 - |\delta|^2 \sin^2\left(\theta/2\right) \sin^2\theta_K\right)^K.$$
(S39)

- 6. Alice applies the X followed by the Z on her qubit and Bob performs XZX operation on the path state $|2\rangle_{\rm C}$, respectively.
- 7. Bob inputs the component of the photon in path state $|1\rangle_{\rm C}$ to the H-CQZ_{*M*,*N*} gate and $|2\rangle_{\rm C}$ to the V-CQZ_{*M*,*N*} gate, respectively. Unless the photon is discarded in the CQZ_{*M*,*N*} gates, Bob applies X operator on the component of photon in path state $|1\rangle_{\rm C}$ and the composite of Alice and Bob transforms

to $|\psi_4\rangle_{ABC}$ in (S4) [S7] with probability

$$\lambda_4 = \left(1 - \nabla_7 \sin^2 \theta_M\right)^M \\ \prod_{i=1}^M \left[1 - \nabla_8 \sin^2 \left(i\theta_M\right) \sin^2 \theta_N\right]^N,$$
(S40)

where ∇_7 and ∇_8 are defined as:

$$\nabla_7 = |\delta\alpha|^2 \cos^2\left(\theta/2\right) + |\delta\beta|^2 \sin^2\left(\theta/2\right), \qquad (S41)$$

$$\nabla_8 = |\delta\beta|^2 \cos^2\left(\theta/2\right) + |\delta\alpha|^2 \sin^2\left(\theta/2\right).$$
 (S42)

- 8. To disentangle the ancillary qutrit, Bob applies the local operation V_2 followed by the Hadamard gate H on the ancilla and performs the measurement on the ancilla in the computational basis. It collapses the composite state $|\psi_4\rangle_{ABC}$ to $|\psi_{5m}\rangle_{AB}$ in (S5).
- 9. Alice and Bob apply the global unitary operation Q_3 depending on Bob's announcement of the measurement result m with classical communication. For m = 0, $Q_3 = I$. For m = 1, Alice applies the Z operator on her qubit and Bob applies X. Bob throws his photon towards PBS^H again and inputs the V components of the photon to the V-CQZ_{2M,N} gate with 2M outer cycles to apply the controlled-Z operator counterfactually as shown in Fig. S9. Unless the photon is discarded in the CQZ gate, Bob recombines the H and V components of

the photon with probability

$$\lambda_5 = \left(1 - |\alpha\gamma|^2 \sin^2 \theta_M\right)^{2M} \\ \prod_{i=1}^{2M} \left[1 - |\beta\gamma|^2 \sin^2 (i\theta_M) \sin^2 \theta_N\right]^N,$$
(S43)

followed by applying the X operator on his qubit. Unless the photon is discarded, the composite state $|\psi_{5m}\rangle_{AB}$ transforms to $|\psi_{6m}\rangle_{AB}$ in (S6) with probability λ_5^m .

In the CCT protocol for general input states, there exists the nonzero probability (abortion rate) ζ_m that the photon is traveled over the quantum channel and the protocol fails in counterfactuality where

$$\zeta_m = 1 - \lambda_2 \lambda_3 \lambda_4 \lambda_5^m, \tag{S44}$$

which tends to zero as $M, N, K \to \infty$.

CCT for Bell-Type Input States

To demonstrate the implementation of CCT for Belltype states, consider that the composite input state of Alice and Bob is $|\psi_0\rangle_{AB} = |\psi_{0\ell}^{\pm}\rangle_{AB}$, $\ell = 0, 1$, in (19) of the main text. Similar to the general setup, Bob starts the protocol by entangling his qubit with the ancillary qubit $|0\rangle_{C}$ by throwing his photon towards PBS^H as shown in Fig. S10. The CCT protocol for Bell-type states of 1(0)class takes the following steps.

- 1. Bob applies C_1 on the component of the photon in path state $|1\rangle_{\rm C}$ where $C_1 = X^{1-\ell} U X^{\ell}$ for ℓ -class states.
- 2. Bob inputs the photon component in path state $|1\rangle_{\rm C}$ to the ${\rm H(V)}$ -DCFO_{K,N} gate. From (S24)–(S29), unless the photon is absorbed by the electron, the ${\rm H(V)}$ -DCFO_{K,N} gate transforms the composite of Alice and Bob as follows:

$$|\psi_0'\rangle_{\rm ABC} : \begin{cases} |\psi_{00}'\rangle_{\rm ABC} = \alpha |100\rangle_{\rm ABC} \pm \beta \left(-e^{\iota(\varphi+\phi)/2}\cos\left(\theta/2\right)|001\rangle_{\rm ABC} - e^{\iota(\varphi-\phi)/2}\sin\left(\theta/2\right)|111\rangle_{\rm ABC}\right), \\ |\psi_{01}'\rangle_{\rm ABC} = \gamma \left(e^{\iota(\varphi+\phi)/2}\cos\left(\theta/2\right)|101\rangle_{\rm ABC} + e^{\iota(\varphi-\phi)/2}\sin\left(\theta/2\right)|011\rangle_{\rm ABC}\right) \mp \delta |000\rangle_{\rm ABC} \end{cases}$$
(S45)

with probability

$$\lambda_{6} = \left(1 - \nabla \sin^{2}\left(\theta/2\right) \cos^{2}\theta_{K} \sin^{2}\theta_{N}\right)^{KN} \left(1 - \nabla \sin^{2}\left(\theta/2\right) \sin^{2}\theta_{K}\right)^{K}.$$
(S46)

3. Alice applies the X followed by the Z on her qubit

and Bob performs $C_2 = XZ^{1-\ell}X^{1-\ell}$ for ℓ -class states on the photon component in path state $|1\rangle_{\rm C}$, respectively.

4. Bob inputs the photon component in path state $|1\rangle_{\rm C}$ to the V-CQZ_{*M*,*N*} gate and recombines the

photon component in path state $|0\rangle_{\rm C}$ and $|1\rangle_{\rm C}$ after the V-CQZ_{*M*,*N*} gate. At the end of the protocol, unless the photon is discarded in the V-CQZ_{*M*,*N*} gate, Bob recombines the H and V components of the photon and the composite state $|\psi'_0\rangle_{\rm ABC}$ transforms to $|\psi\rangle_{\rm ABC}$ in (23) of the main text with probability

$$\lambda_7 = \left(1 - \nabla_{9(10)} \sin^2 \theta_M\right)^M$$
$$\prod_{i=1}^M \left[1 - \nabla_{10(9)} \sin^2 (i\theta_M) \sin^2 \theta_N\right]^N$$
(S47)

for 1(0)-class states where

$$\nabla_9 = \nabla \cos^2\left(\theta/2\right),\tag{S48}$$

$$\nabla_{10} = \nabla \sin^2 \left(\theta/2 \right). \tag{S49}$$

For the CCT protocol with Bell-type states, the probability (abortion rate) that the protocol fails to ensure the counterfactuality is given by

$$\zeta = 1 - \lambda_6 \lambda_7 \tag{S50}$$

tending again to zero as $M, N, K \to \infty$.
