Global well-posedness of one-dimensional compressible Navier-Stokes-Vlasov system

Abstract

A fluid-particle model is investigated in the present paper, which consists of the compressible Navier-Stokes equations coupled with the Vlasov equation though a nonlinear drag force. We consider the initial value problem for the one-dimensional compressible Navier-Stokes-Vlasov system and establish the global existence and uniqueness of the weak solution for general initial data in either spatial periodic domain or spatial real line, which is shown to be a strong solution for regular initial data. Moreover, it is showed that for spatial periodic domain, both the fluid velocity and the macroscopic velocity of the particles converge to the same speed exponentially in time, and the compact support of distribution function associated with velocity variable converges to a point set exponentially in time.

Key words: Fluid-particle model; Nonlinear drag force; Global well-posedness, Large time behavior

1 Introduction

The fluid-particle interaction models are introduced to simulate the motion of particles dispersed in a fluid [6, 7, 15, 20, 21, 32, 35, 40, 47], and are used widely in many applied scientific areas such as diesel engines, rocket propulsors, aerosols and sprays, pollution settling processes, chemical engineering, wastewater treatment or biomedical flows [1, 4, 8, 9, 11, 40, 46, 47], etc.

In this paper, we consider the initial value problem (IVP) of the following one-dimensional compress-

ible Navier-Stokes-Vlasov system for fluid-particle motion:

$$\begin{cases} \rho_t + (\rho u)_x = 0, \\ (\rho u)_t + (\rho u^2)_x + (P(\rho))_x = (\mu(\rho)u_x)_x - \int_{\mathbb{R}} F_d f dv, \\ f_t + v f_x + (F_d f)_v = 0, \quad (x, v) \in \Omega \times \mathbb{R}, \ t > 0, \end{cases}$$
(1.1)

with the initial data

$$(\rho(x,0), u(x,0), f(x,v,0)) = (\rho_0(x), u_0(x), f_0(x,v)), \quad (x,v) \in \Omega \times \mathbb{R},$$
(1.2)

where $\rho = \rho(x,t)$ and u = u(x,t) denote the density and velocity associated with the dense phase (fluid) respectively, governed by the compressible Navier-Stokes equations $(1.1)_1$ - $(1.1)_2$, and f = f(x,v,t) is the distribution function associated with the dispersed phase (particles), governed by the Vlasov equation $(1.1)_3$. The spatial domain Ω is either the periodic domain $\mathbb{T} = \mathbb{R}/\mathbb{Z}$ or the real line \mathbb{R} . The pressure $P(\rho)$ and the viscosity coefficient $\mu(\rho)$ satisfy

$$P(\rho) = A\rho^{\gamma}, \quad \mu(\rho) = \mu_0 + \mu_1 \rho^{\beta}, \tag{1.3}$$

and the drag force F_d takes the form

$$F_d = \kappa \rho(u - v),\tag{1.4}$$

where $A, \mu_0, \mu_1, \kappa, \gamma$ and β are constants satisfying

$$A > 0$$
, $\mu_0 > 0$, $\mu_1 > 0$, $\kappa > 0$, $\gamma > 1$, $\beta > 0$.

Without loss of generality, we take $A = \mu_0 = \mu_1 = \kappa = 1$ in the present paper.

There are many important progress made recently on the analysis of existence and dynamical behaviors of solutions for fluid-particle models [3,5,10,17–19,23–26,28,29,33,45]. Among them, concerning with multi-dimensional incompressible Navier-Stokes-Vlasov equations, the global existence of weak solutions in spatial periodic domain was established in [10], and the asymptotic stability of stationary states in a pipe with partially absorbing boundary conditions was investigated in [24]. The global well-posedness and large time behavior of weak solutions for three-dimensional incompressible Navier-Stokes-Vlasov system were showed for small initial data in both spatial periodic domain [28] and spatial whole space [29] respectively. And the global existence of weak solutions for three-dimensional inhomogeneous Navier-Stokes-Vlasov equations was studied in [45]. For compressible Navier-Stokes-Vlasov system, the exponential time stability of global solutions in spatial periodic domain was obtained in [3,18,34] provided that the global solutions existed and satisfied some uniform estimates, and the finite time blow-up phenomena of classical solutions in the presence of vacuum was proved in [19] for any space dimension.

However, there are no any results about the global well-posedness problem for compressible Navier-Stokes-Vlasov equations as we know so far. The purpose of this paper is to deal with the existence, uniqueness and regularity of global weak solution to the IVP (1.1)-(1.4) for general initial data.

Before stating the main results, we present some notations below.

Notations. Throughout this paper, C > 0 and c > 0 denote some constants independent of time, and $C_T > 0$ is a constant which may depend on time T. For $p \in [1, \infty]$ and integer $k \geq 0$, the simplified Lebesgue, Sobolev and Hölder norms are given as follows:

Let n and w denote the average local density and velocity of distribution function f to the Vlasov equation $(1.1)_3$ respectively as

First, we have the following result for the spatial periodic domain:

Theorem 1.1. Let $\Omega = \mathbb{T}$. Assume that the initial data (ρ_0, u_0, f_0) satisfies

where $R_0>0$ is a constant. Then the IVP (1.1)-(1.4) admits a unique global weak solution (ρ,u,f) satisfying for any T > 0 that

where $\rho_{-} > 0, \rho_{+} > 0, C_{0} > 0$ and $R_{1} > 0$ are constants independent of time $T > 0$.

In addition to (1.6), if it further holds

$$\rho_0 \in H^2(\mathbb{T}), \quad u_0 \in H^2(\mathbb{T}), \quad f_0 \in C^1(\mathbb{T} \times \mathbb{R}), \tag{1.9}$$

then (ρ, u, f) is indeed a global strong solution satisfying for any T > 0 that

Next, it is shown that as time evolves, the global solution (ρ, u, f) given by Theorem 1.1 converges to its equilibrium state exponentially.

Theorem 1.2. Let the assumptions of Theorem 1.1 hold, and (ρ, u, f) be the global solution to the IVP (1.1)-(1.4) given by Theorem 1.1. Then it holds

where $W_1(f,g)$ is the Wasserstein distance given by Definition 1.1, $C_1 > 0$ and $\lambda > 0$ are two constants independent of time, and $\overline{\rho_0}$ and u_s are given by

Then, we have the following result for the spatial real line:

Theorem 1.3. Let $\Omega = \mathbb{R}$. Assume that the initial data (ρ_0, u_0, f_0) satisfies

where $\tilde{\rho} > 0$ and $\tilde{R}_0 > 0$ are two constants. Then the IVP (1.1)-(1.4) admits a unique global weak solution (ρ, u, f) satisfying for any T > 0 that

where $\rho_T > 0$ and $\widetilde{R}_T > 0$ are constants dependent of time T > 0.

In addition to (1.13), if it further holds

then the global weak solution (ρ, u, f) is indeed a strong solution satisfying for any T > 0 that

We explain the main ideas to prove Theorem 1.1, which can be applied to the proof of Theorem 1.3 with some modifications. Indeed, for any initial data satisfying (1.6) and (1.9), we can show the local well-posedness of strong solution to the IVP (1.1)-(1.4). Thus, to extend the solution globally in time, we need to overcome the difficulties caused by the drag force term $\rho n(w-u)$ on the right-hand side of the equation (1.1)₂ and establish the uniformly a-priori estimates of the solution. To this end, we introduce a new effective velocity

$$u + \mathcal{I}(n)$$
,

where the operator $\mathcal{I}: L^1(\mathbb{T}) \to L^\infty(\mathbb{T})$ is defined by

$$\mathcal{I}(g)(x) =: \int_0^x g(y)dy - \int_0^1 \int_0^y g(z)dzdy, \quad \forall g \in L^1(\mathbb{T}),$$

so that the momentum equation $(1.1)_2$ can be re-written as

$$\left(\rho(u+\mathcal{I}(n))\right)_t + \left(\rho u(u+\mathcal{I}(n))\right)_x + (\rho^{\gamma})_x = (\mu(\rho)u_x)_x + \rho \int_0^1 nw(y,t)dy. \tag{1.18}$$

Making use of basic energy estimates and the equation (1.18) instead of (1.1)₂, we are able to obtain the upper bound of the fluid density ρ uniformly in time. In addition, we show that the L^1 -norm of the pressure $P(\rho)$ is strictly positive for large time, which is crucial to establish the lower bound of ρ uniformly with respect to time.

Then, we define the second effective velocity

$$U =: u + \mathcal{I}(n) + \rho^{-2}\mu(\rho)\rho_x.$$

By $(1.1)_1$ and (1.18), we can verify that U satisfies the following equation:

$$\rho(U_t + uU_x) + \gamma \rho^{\gamma + 1} \mu(\rho)^{-1} U = \gamma \rho^{\gamma + 1} \mu(\rho)^{-1} (u + \mathcal{I}(n)) + \rho \int_0^1 nw(y, t) dy.$$

After having proved that the density ρ has strictly positive upper and lower bounds, which implies that the term $\gamma \rho^{\gamma+1} \mu(\rho)^{-1} U$ acts a damping in (1.19), we are able to establish the L^2 -estimate of ρ_x uniformly

in time. The higher order regularities of the solution can be showed by standard arguments after some modifications.

The rest of the paper is organized as follows. Section 2 is devoted to the a-priori estimates and global existence of solutions to the IVP (1.1)-(1.4) in both spatial periodic domain and spatial real line. The uniqueness of the weak solution satisfying either (1.7)-(1.8) or (1.14)-(1.15) is proved in Section 3. The local well-posedness of the IVP (1.1)-(1.4) is shown in Appendix A, and the exponential time-decay rate of the global weak solution is obtained in Appendix B.

2 The a-priori estimates and global existence

2.1 Spatial periodic domain

In this subsection, we establish the a-priori estimates for any regular solution to the IVP (1.1)-(1.4) in spatial periodic domain. Indeed, we can construct a approximate sequence of global regular solutions, show their convergence to a global weak solution of the IVP (1.1)-(1.4) based on the corresponding uniform estimates, and then justify the expected properties in Theorem 1.1 for the solution.

We start with

Lemma 2.1. Let T > 0, and (ρ, u, f) be any regular solution to the IVP (1.1)-(1.4) for $t \in (0, T]$. Then, under the assumptions of Theorem 1.1, it holds

+ \int_0^T \int_{\mathbb{T}} (\mu(\rho) |u_x|^2) (x,t) dx dt + \int_0^T \int_{\mathbb{T} \times \mathbb{R}} (\rho |u - v|^2 f) (x,v,t) dv dx dt \leq E_0,
\end{cases}$$

where the initial energy E_0 is given by

$$E_0 =: \int_{\mathbb{T}} \left(\frac{1}{2} \rho_0 |u_0|^2 + \frac{\rho_0^{\gamma}}{\gamma - 1} \right) (x) dx + \int_{\mathbb{T} \times \mathbb{R}} \frac{1}{2} |v|^2 f_0(x, v) dv dx. \tag{2.2}$$

Proof. Due to the maximum principle for transport equations, $(2.1)_1$ holds. In addition, $(2.1)_2$ - $(2.1)_3$ can be derived after a direct computation. To show $(2.1)_4$, multiplying $(1.1)_1$ and $(1.1)_2$ by $\frac{\gamma}{\gamma-1}\rho^{\gamma-1}$ and u respectively, and integrating the resulted equations by parts over \mathbb{T} , one gets after adding them

together that

$$\frac{d}{dt} \int_{\mathbb{T}} \left(\frac{1}{2}\rho|u|^2 + \frac{\rho^{\gamma}}{\gamma - 1}\right)(x, t)dx + \int_{\mathbb{T}} (\mu(\rho)|u_x|^2)(x, t)dx$$

$$= -\int_{\mathbb{T}\times\mathbb{R}} \rho(x, t)(u(x, t) - v)u(x, t)f(x, v, t)dvdx.$$
(2.3)

Multiplying $(1.1)_3$ by $\frac{1}{2}|v|^2$, and integrating the resulted equation by parts over $\mathbb{T} \times \mathbb{R}$, we obtain

$$\frac{d}{dt} \int_{\mathbb{T} \times \mathbb{R}} \frac{1}{2} |v|^2 f(x, v, t) dv dx = \int_{\mathbb{T} \times \mathbb{R}} \rho(x, t) (u(x, t) - v) v f(x, v, t) dv dx. \tag{2.4}$$

The combination of (2.3)-(2.4) gives rise to $(2.1)_4$. The proof of Lemma 2.1 is completed.

By Lemma 2.1, we can establish the lower and upper bounds of the density ρ below:

Lemma 2.2. Let T > 0, and (ρ, u, f) be any regular solution to the IVP (1.1)-(1.4) for $t \in (0, T]$. Then, under the assumptions of Theorem 1.1, it holds

where $\rho_+ > 0$ is a constant independent of time T > 0, and $C_T > 0$ is a constant dependent of time T > 0.

Proof. We introduce a new effective velocity

$$u + \mathcal{I}(n)$$

where the operator $\mathcal{I}: L^1(\mathbb{T}) \to L^\infty(\mathbb{T})$ is defined by

$$\mathcal{I}(g)(x) =: \int_0^x g(y)dy - \int_0^1 \int_0^y g(z)dzdy, \quad \forall g \in L^1(\mathbb{T}). \tag{2.6}$$

It can be verified verify for $g \in L^1(\mathbb{T})$ that

and for $g \in W^{1,1}(\mathbb{T})$ that

Integrating the equation $(1.1)_3$ over \mathbb{R} with respect to velocity variable v, we have

$$n_t + (nw)_x = 0, (2.9)$$

where n and w are defined by (1.5). Applying the operator \mathcal{I} to the equation (2.9), we deduce by (2.8) that

which together with $(1.1)_1$, (1.5) and (2.7) leads to

Thus, by virtue of (2.10), we can re-write the momentum equation $(1.1)_2$ as

It follows from (2.6)-(2.8) and (2.11) that

<u>Proof of global existence in spatial real line:</u> Let T > 0 be any given time. With the help of Lemmas 2.8-2.11 and Lemma 4.2 below, we can obtain a sequence of strong solutions $(\rho^{\varepsilon}, u^{\varepsilon}, f^{\varepsilon})$ for $\varepsilon \in (0,1)$ on $\mathbb{R} \times \mathbb{R} \times [0,T]$.

Then, one can show under the assumptions (1.13) of Theorem 1.3 that $(\rho^{\varepsilon}, u^{\varepsilon}, f^{\varepsilon})$ satisfies the estimates established in Lemmas 2.8-2.10 uniformly with respect to $\varepsilon \in (0,1)$. Since the locally compact embedding $H^2(\mathbb{R}) \hookrightarrow \hookrightarrow L^2_{loc}(\mathbb{R})$ holds, by virtue of the Aubin-Lions's lemma and cantor's diagonal argument, up to a subsequence (still denoted by $(\rho^{\varepsilon}, u^{\varepsilon}, f^{\varepsilon})$), we have the strong convergence

3 Uniqueness

In this section, we prove the uniqueness of the weak solution to the IVP (1.1)-(1.4) satisfying (1.7)-(1.8) in spatial periodic domain, and similar arguments can be applied to the case of spatial real line.

Proposition 3.1. Let $\Omega = \mathbb{T}$ and T > 0. Assume that the initial data (ρ_0, u_0, f_0) satisfies (1.6). If (ρ_1, u_1, f_1) and (ρ_2, u_2, f_2) are two solutions to the IVP (1.1)-(1.4) satisfying (1.7)-(1.8) on $\mathbb{T} \times \mathbb{R} \times [0, T]$ with the same initial data (ρ_0, u_0, f_0) , then it holds $(\rho_1, u_1, f_1) = (\rho_2, u_2, f_2)$ a.e. in $\mathbb{T} \times \mathbb{R} \times (0, T)$.

and similarly,

$$\int_{\mathbb{T}\times\mathbb{R}} \left(\sup_{r \in (0,1)} \frac{1}{2r} \int_{X_2(t)-r}^{X_2(t)+r} |(u_1 - u_2)_z(z,t)| dz \right)^2 f_0(x,v) dv dx
\leq C_T \|(u_1 - u_2)_x(t)\|_{L^2}^2.$$
(3.20)

The combination of (3.18)-(3.20) leads to

$$I_4^3 \le C_T Q^{\frac{1}{2}}(t) \|(u_1 - u_2)_x(t)\|_{L^2} \le C_T Q(t) + \frac{1}{100} \|(u_1 - u_2)_x(t)\|_{L^2}^2.$$

Proposition 3.2. Let $\Omega = \mathbb{R}$ and T > 0. Assume that the initial data (ρ_0, u_0, f_0) satisfies (1.13). If (ρ_1, u_1, f_1) and (ρ_2, u_2, f_2) are two solutions to the IVP (1.1)-(1.4) satisfying (1.14)-(1.15) on $\mathbb{R} \times \mathbb{R} \times [0, T]$ with the same initial data (ρ_0, u_0, f_0) , then it holds $(\rho_1, u_1, f_1) = (\rho_2, u_2, f_2)$ a.e. in $\mathbb{R} \times \mathbb{R} \times (0, T)$.

4 Appendix A: Local well-posedness

In this Appendix, we prove the local well-posednes of strong solution to the IVP (1.1)-(1.4) for spatial periodic domain, and similar arguments can be applied to the case of spatial real line.

\leq \frac{1}{4\rho_{0+}} \| (u^{n+1})_{xxx}(t) \|_{L^{2}}^{2} + NE_{0} \| u^{n+1}(t) \|_{H^{2}}^{2} + N(1 + E_{0}) E_{0},$$

which together with (4.13) gives rise to

Then by the previous estimates (4.8)-(4.9), (4.12), (4.15) and (4.18)-(4.19), we conclude that for each $n \ge 0$, the strong solution $(\rho^{n+1}, u^{n+1}, f^{n+1})$ to the IVP (4.3)-(4.4) belongs to $\mathcal{W}(T_0)$ as long as (ρ^n, u^n, f^n) satisfies (4.5). By repeating the procedure used above, we can obtain an approximate sequence (ρ^n, u^n, f^n) satisfying the uniform estimates in $\mathcal{W}(T_0)$.

where $N_* > 0$ is a constant depending only on ρ_{0+}, ρ_{0-} and R_0 . Choosing

Due to the estimates of (ρ^n, u^n, f^n) uniformly in $n \ge 0$, as $n \to \infty$, it holds up to a subsequence (still denoted by (ρ^n, u^n, f^n)) that

Thus, we can pass to the limit $n \to \infty$ for the equations (4.3) in the sense of distributions and prove that (ρ, u, f) is indeed a strong solution to the IVP (1.1)-(4.4) on $\mathbb{T} \times \mathbb{R} \times [0, T_*]$.

In addition, applying the theory of renormalized solutions in [22], we have $\rho \in C([0,T_*];H^1(\mathbb{T}))$. where $\tilde{\rho} > 0$ and $\tilde{R}_0 > 0$ are two constants. Then there is a time $T_{**} > 0$ such that the IVP (1.1)-(1.4) admits a unique strong solution satisfying

5 Appendix B: exponential time-decay rate

In this Section, we establish the a-priori estimates of ρ uniformly in time and dynamical behaviors of the spatial periodic solution (ρ, u, f) to the IVP (1.1)-(1.4) to the corresponding equilibrium state $(\overline{\rho_0}, u_s, n\delta(v-u_s))$ in the terms of the relative entropy, where the constants $\overline{\rho_0}$ and u_s are given by (1.12). First, we recall the definition of Wasserstein distance [44] as follows:

$$u_s = e^{-\int_0^t \rho(X^{x,v,t}(\omega),\omega)d\omega} u_s + \int_0^t e^{-\int_\tau^t \rho(X^{x,v,t}(\omega),\omega)d\omega} \rho(X^{x,v,t}(\tau),\tau) u_s d\tau,$$

which together with (2.29) leads to

$$v - u_{s} = e^{-\int_{0}^{t} \rho(X^{x,v,t}(\tau),\tau)d\tau} (V^{x,v,t}(0) - u_{s})$$

$$+ \int_{0}^{t} e^{-\int_{\tau}^{t} \rho(X^{x,v,t}(\omega),\omega)d\omega} (\rho(u - u_{s}))(X^{x,v,t}(\tau),\tau)d\tau,$$
(5.31)

where the bi-characteristic curves $(X^{x,v,t}(s), V^{x,v,t}(s))$ are given by (2.26). By (5.26)-(5.27) and the Gagliardo-Nirenberg's inequality, one can show

$$\begin{aligned} \|(u-u_s)(t)\|_{L^{\infty}} &\leq \|(u-\overline{u})(t)\|_{L^{\infty}} + |(\overline{u}-u_s)(t)| \\ &\leq C\|(u-\overline{u})(t)\|_{L^{2}}^{\frac{1}{2}}\|u_{x}(t)\|_{L^{2}}^{\frac{1}{2}} + |\int_{\mathbb{T}} (u-u_s)(x,t)dx| \\ &\leq C(\|(u-m_1)(t)\|_{L^{2}} + |(m_1-\overline{u})(t)|)^{\frac{1}{2}}\|u_{x}(t)\|_{L^{2}}^{\frac{1}{2}} + \|(u-u_s)(t)\|_{L^{2}} \\ &\leq Ce^{-\frac{\lambda_{1}}{4}t}\|u_{x}(t)\|_{L^{2}}^{\frac{1}{2}} + Ce^{-\frac{\lambda_{1}}{2}t}. \end{aligned}$$

It derives from $(2.1)_4$, (2.28), (5.27), (5.31), (5.32) and the Hölder inequality for any $(x,t) \in \mathbb{T} \times [0,\infty)$ that

$$\sup_{v \in \Sigma(x,t)} |v - u_{s}|
\leq e^{-\rho - t} (|u_{s}| + R_{0}) + C \int_{0}^{t} e^{-\rho - (t - \tau)} ||(u - u_{s})(\tau)||_{L^{\infty}} d\tau
\leq e^{-\rho - t} (|u_{s}| + R_{0}) + C \int_{0}^{t} e^{-\rho - (t - \tau)} (e^{-\frac{\lambda_{1}}{4}\tau} ||u_{x}(\tau)||_{L^{2}}^{\frac{1}{2}} + e^{-\frac{\lambda_{1}}{2}\tau}) d\tau
\leq C e^{-\rho - t} + C ||u_{x}||_{L^{2}(0,t;L^{2})}^{\frac{1}{2}} (\int_{0}^{t} e^{-\frac{4\rho - (t - \tau)}{3}t} e^{-\frac{\lambda_{1}}{3}t} d\tau)^{\frac{3}{4}} + C \int_{0}^{t} e^{-\rho - (t - \tau)} e^{-\frac{\lambda_{1}}{2}\tau} d\tau
\leq C (e^{-\frac{\rho - t}{2}t} + e^{-\frac{\lambda_{1}}{8}t}),$$
(5.33)

where $\Sigma(x,t)$ is given by (2.31) and one has used the fact for some constants $a_1 > 0$ and $a_2 > 0$ that

$$\int_{0}^{t} e^{-a_{1}(t-\tau)} e^{-a_{2}\tau} d\tau \le \int_{0}^{\frac{t}{2}} e^{-a_{1}(t-\tau)} e^{-a_{2}\tau} d\tau + \int_{\frac{t}{2}}^{t} e^{-a_{1}(t-\tau)} e^{-a_{2}\tau} d\tau$$

$$\le \frac{1}{a_{2}} e^{-\frac{a_{1}}{2}t} + \frac{1}{a_{1}} e^{-\frac{a_{2}}{2}t}.$$

The combination of (5.24), (5.27), (5.28)-(5.30) and (5.33) leads to $(1.11)_3$. The proof of Theorem 1.2 is completed.
