

Proof of the volume conjecture for twist knots

We prove the volume conjecture for every twist knots by using an equivalence relation, complex analysis, analytic continuation, and the method of steepest descent on the basis of colored Jones polynomials.

1 Introduction

H.Murakami-J.Murakami [6] reformulated Kashaev's conjecture as the volume conjecture. In this paper, we study the volume conjecture of every oriented twist knots. The volume conjectures has so far proven to be true only for the following four sorts of knot: the figure-eight knot by Ekholm (see [5]), 5_2 by Kashaev-Yokota [4] and Ohtsuki [7], torus knots by Kashaev-Tirkkonen[3] and the whitehead doubles of non-trivial torus knots by Zheng [10]. These volume conjectures were solved by calculating colored Jones polynomial. We solve the volume conjecture for every twist knots by using some equivalence relations, complex analysis, analytic continuations, and the method of steepest descent on the basis of colored Jones polynomials. The following is the volume conjecture:

Conjecture 1.1 *Let K be an oriented hyperbolic knot, $J_N(K, q)$ be the colored Jones polynomial of K and $\text{Vol}(K)$ be the hyperbolic volume of $S^3 \setminus K$. Then we obtain the following equality holds:*

$$(1) \quad \lim_{N \rightarrow \infty} \frac{2\pi \log |J_N(K, \exp(2\pi\sqrt{-1}/N))|}{N} = \text{Vol}(K).$$

The purpose of this paper is to prove that the volume conjecture is true for every oriented twist knots. Namely, we prove the following theorem.

Theorem 1.2 *Let K be a twist knot, $J_N(K, q)$ be the colored Jones polynomial of K , $\text{Vol}(K)$ be the hyperbolic volume of $S^3 \setminus K$. Then the above equality (1) holds.*

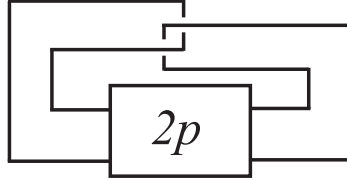


Figure 1: Here $2p$ ($p \in \mathbb{Z} \setminus \{0, 1\}$) denote the numbers of half twists in each box.

Let K be a twist knot as in Figure 1. Note that positive numbers correspond to left-handed twists and negative numbers correspond to right-handed twists respectively.

2 Lemmas necessary for Proof of Volume Conjecture for twist knots

Let N be a positive integer, n_i be positive integers or equal to 0, and q be $\exp(2\pi\sqrt{-1}/N)$. We know the following theorem.

Theorem 2.1 ([8]) *Let p be a positive integer, $K_{p>0}$ be the usual p -th twist knot, $J_N(K; q)$ be the colored Jones polynomial of K , and K^* be the mirror image of the knot K . We know that K_{-p} is the mirror image of $K_{p>0}$.*

$$J_N(K_{p>0}^*; q) = q^{1-N} \sum_{N-1 \geq n_{2p-1} \geq \dots \geq n_1 \geq 0} (q^{1-N})_{n_{2p-1}} q^{-Nn_{2p-1}} \\ \times \prod_{i=1}^{2p-2} (-1)^{n_i} q^{(-1)^i Nn_i + \binom{n_i}{2} - n_i n_{i+1}} \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix},$$

where we have used the usual q -binomial coefficient

$$\begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} = \frac{(q)_{n_{i+1}}}{(q)_{n_{i+1}-n_i} (q)_{n_i}}$$

with the standard q -hyper geometric notation

$$(q)_n = \prod_{k=0}^{n-1} (1 - q^{k+1}) = (1 - q)^n \Gamma_q(n + 1).$$

Definition 2.2 We say that $f(N)$ and $g(N)$ are *equivalent* if the difference $|f(N) - g(N)|$ tends to zero when $N \rightarrow \infty$. Namely, we denote $\lim_{N \rightarrow \infty} |f(N) - g(N)| = 0$ by $f(N) \stackrel{N}{\sim} g(N)$.

This relation $\overset{N}{\sim}$ is an equivalence relation. Hence, reflexive relation, symmetric relation, and transitive relation hold.

Lemma 2.3 *If $i(N) \overset{N}{\sim} g(N)$, $h(N) \overset{N}{\sim} i(N)$, and $g(N) \leq f(N) \leq h(N)$, then we have that*

$$f(N) \overset{N}{\sim} i(N).$$

Moreover, if $i(N)$ is a constant function, then

$$\lim_{N \rightarrow \infty} f(N) = i(N)$$

holds.

Proof Because of the assumptions, we have that

$$g(N) - i(N) \leq f(N) - i(N) \leq h(N) - i(N),$$

and

$$\lim_{N \rightarrow \infty} |g(N) - i(N)| = \lim_{N \rightarrow \infty} |h(N) - i(N)| = 0.$$

Hence,

$$\lim_{N \rightarrow \infty} |f(N) - i(N)| = 0,$$

and

$$f(N) \overset{N}{\sim} i(N).$$

□

We define the following dilogarithm function:

$$\text{Li}_2(z) := \sum_{n=1}^{\infty} \frac{z^n}{n^2} \quad (|z| < 1).$$

We know that the following equality:

$$-\log(1 - z) = \sum_{n=1}^{\infty} \frac{z^n}{n} \quad (|z| < 1).$$

Hence, the analytic continuation of the dilogarithm function is given by

$$\text{Li}_2(z) = - \int_0^z \frac{\log(1 - t)}{t} dt \quad (z \in \mathbb{C} \setminus [1, \infty)).$$

Here, $\log(1 - t) := \log|1 - t| + \sqrt{-1}\text{Arg}(1 - t)$ ($0 \leq \text{Arg}(1 - t) < 2\pi$) is a regular analytic function on $\mathbb{C} \setminus [1, \infty)$. Hence, $\text{Li}_2(z)$ is a regular analytic function on $\mathbb{C} \setminus [1, \infty)$.

Definition 2.4 We define the following functions:

$$f(z_1, \dots, z_{2p-1}) := -\text{Li}_2\left(\frac{1}{z_1}\right) + \sum_{i=1}^{2p-2} \left(\text{Li}_2(z_i) - \text{Li}_2\left(\frac{z_i}{z_{i+1}}\right) + \text{Li}_2\left(\frac{1}{z_{i+1}}\right) \right) + \text{Li}_2(z_{2p-1}),$$

$$f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) := \sum_{i=1}^{2p-2} \left(\text{Li}_2(z_i^{(i)}) - \text{Li}_2\left(\frac{z_i^{(i)}}{z_{i+1}^{(i)}}\right) + \text{Li}_2\left(\frac{1}{z_{i+1}^{(i)}}\right) \right) - \text{Li}_2(z_{2p-1}^{(2p-1)}) + \frac{\pi^2}{6},$$

$$\begin{aligned} \tilde{f}(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) &:= \sum_{i=1}^{2p-2} \left(-\sqrt{-1}\text{Li}_2(z_i^{(i)}) + \frac{\pi^2\sqrt{-1}}{6} + \sqrt{-1}\text{Li}_2\left(\frac{z_i^{(i)}}{z_{i+1}^{(i)}}\right) - \frac{\pi^2\sqrt{-1}}{6} \right. \\ &\quad \left. - \sqrt{-1}\text{Li}_2\left(\frac{1}{z_{i+1}^{(i)}}\right) + \frac{\pi^2\sqrt{-1}}{6} \right) + \sqrt{-1}\text{Li}_2(z_{2p-1}^{(2p-1)}) - \frac{\pi^2\sqrt{-1}}{6}, \end{aligned}$$

and

$$g(n, N) := \frac{\pi^2\sqrt{-1}n^2}{N^2} - \frac{2\pi n \log(1 - \exp(2\pi\sqrt{-1}n/N))}{N} + \frac{\pi n \log 4}{N} + \frac{\pi n \sin^2(\frac{\pi n}{N})}{N},$$

where $z_i^{(i)} := \exp(2\pi\sqrt{-1}n_i/N)$, $1/z_{i+1}^{(i)} := \exp(2\pi\sqrt{-1}(n_{i+1} - n_i)/N)$.

Hence,

$$\tilde{f}(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) = -\sqrt{-1}f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) + \frac{\pi^2\sqrt{-1}(2p-2)}{6}.$$

2.1 First reduction

Firstly, we prove that

$$\begin{aligned} f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) &\stackrel{N}{\sim} f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)), \\ f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) + \text{Li}_2(z_{2p-1}^{(2p-1)}) - \frac{\pi^2}{6} &\stackrel{N}{\sim} f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)), \\ \frac{2\pi \log |(q)_n|}{N} &\stackrel{N}{\sim} \sqrt{-1}\text{Li}_2(\exp(2\pi\sqrt{-1}n/N)) - \frac{\pi^2\sqrt{-1}}{6} \stackrel{N}{\sim} \text{Im}[-\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))], \end{aligned}$$

and the following limit value converges:

$$\lim_{N \rightarrow \infty} \text{Li}_2(\exp(2\pi\sqrt{-1}n/N)).$$

Hence, the following limit value converges:

$$\lim_{N \rightarrow \infty} f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)).$$

Moreover, we obtain the following formulas:

$$\begin{aligned}
& \frac{2\pi}{N} \log \left(|(q)_{n_{2p-1}}| \prod_{i=1}^{2p-2} \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) = \frac{2\pi}{N} \left(\log |(q)_{n_{2p-1}}| + \sum_{i=1}^{2p-2} \log \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) \\
& \sim \sum_{i=1}^{2p-2} \operatorname{Im} [\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_i/N)) - \operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_{i+1}/N))] \\
& \quad + \operatorname{Li}_2(\exp(2\pi\sqrt{-1}(n_{i+1} - n_i)/N)) + \operatorname{Im} [-\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_{2p-1}/N))] \\
& = \operatorname{Im} [f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)})] \\
& \sim \operatorname{Im} [f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N))],
\end{aligned}$$

and

$$\begin{aligned}
& \frac{2\pi}{N} \log \left(|(q)_{n_{2p-1}}| \prod_{i=1}^{2p-2} \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) = \frac{2\pi}{N} \left(\log |(q)_{n_{2p-1}}| + \sum_{i=1}^{2p-2} \log \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) \\
& \sim \tilde{f}(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) \\
& = -\sqrt{-1}f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) + \frac{\pi^2\sqrt{-1}(2p-2)}{6} \\
& \sim -\sqrt{-1}f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)) + \frac{\pi^2\sqrt{-1}(2p-2)}{6}.
\end{aligned}$$

To show the above formulas, we first prove the property of dilogarithm function $\operatorname{Li}_2(z)$ of Lemma 2.5, Lemma 2.6 and Lemma 2.7.

Lemma 2.5 *If $z \in \mathbb{C} \setminus (-\infty, 0]$, then we obtain the following functional equality:*

$$\operatorname{Li}_2(1-z) = -\frac{1}{2} \log^2 z - \operatorname{Li}_2\left(1 - \frac{1}{z}\right).$$

Proof We obtain the following equalities:

$$\begin{aligned}
\operatorname{Li}_2(1-z) + \operatorname{Li}_2\left(1 - \frac{1}{z}\right) &= \operatorname{Li}_2(1-z) - \int_0^{1-1/z} \frac{1-t}{t} dt \\
&= \operatorname{Li}_2(1-z) - \int_1^z \frac{\log(\frac{1}{t})}{1-\frac{1}{t}} \cdot \frac{dt}{t^2} \\
&= \operatorname{Li}_2(1-z) - \int_1^z \frac{\log t}{t} dt - \int_1^z \frac{\log t}{t-1} dt \\
&= \operatorname{Li}_2(1-z) - \left[\frac{1}{2} \log^2 t \right]_1^z + \int_0^{1-z} \frac{1-t}{t} dt
\end{aligned}$$

$$= \text{Li}_2(1-z) - \frac{1}{2} \log^2 z - \text{Li}_2(1-z) = -\frac{1}{2} \log^2 z.$$

□

Lemma 2.6 *If $z \in \mathbb{C} \setminus [0, \infty)$, then we obtain the following functional equality:*

$$-\text{Li}_2\left(\frac{1}{z}\right) = \text{Li}_2(z) + \frac{\pi^2}{6} + \frac{1}{2} \log^2(-z).$$

Proof We obtain the following equalities:

$$\begin{aligned} \text{Li}_2(z) + \text{Li}_2\left(\frac{1}{z}\right) &= \int_z^0 \frac{\log(1-t)}{t} dt + \int_{1/z}^0 \frac{\log(1-t)}{t} dt \\ &= \int_z^{-1} \frac{\log(1-t)}{t} dt + \int_{1/z}^{-1} \frac{\log(1-t)}{t} dt + 2 \int_{-1}^0 \frac{\log(1-t)}{t} dt \\ &= 2\text{Li}_2(-1) + \int_z^{-1} \frac{\log(1-t)}{t} dt + \int_z^{-1} t \log\left(\frac{t-1}{t}\right) \frac{-dt}{t^2} \\ &= -\frac{\pi^2}{6} + \int_z^{-1} \frac{\log(1-t)}{t} dt - \frac{\log(1-t)}{t} + \frac{\log(-t)}{t} dt \\ &= -\frac{\pi^2}{6} - \frac{1}{2} \log^2(-z). \end{aligned}$$

□

Lemma 2.7 *If the domain of definition of $\text{Li}_2(z)$ is $z \in \mathbb{C} \setminus [1, \infty)$ and that of $\text{Li}_2(-z)$ is $z \in \mathbb{C} \setminus (-\infty, -1]$, then we obtain the following functional equality:*

$$\text{Li}_2(z) + \text{Li}_2(-z) = \frac{1}{2} \text{Li}_2(z^2).$$

Proof We obtain the following equalities:

$$\begin{aligned} \text{Li}_2(z) + \text{Li}_2(-z) &= \sum_{n=1}^{\infty} \left(\frac{z^n}{n^2} + \frac{(-z)^n}{n^2} \right) \\ &= \sum_{m=1}^{\infty} \left(\frac{z^{2m-1}}{(2m-1)^2} - \frac{z^{2m-1}}{(2m-1)^2} \right) + \sum_{k=1}^{\infty} \left(\frac{z^{2k}}{(2k)^2} + \frac{z^{2k}}{(2k)^2} \right) \\ &= \frac{1}{2} \text{Li}_2(z^2). \end{aligned}$$

□

Lemma 2.8 *The following limit value uniformly converges: for every $n \in \mathbb{C}$,*

$$\lim_{N \rightarrow \infty} \text{Li}_2(\exp(2\pi\sqrt{-1}n/N)).$$

Proof For sufficiently large N and N' such that $N > N'$, we obtain the following inequalities:

$$\begin{aligned}
& |\text{Li}_2(\exp(2\pi\sqrt{-1}n/N)) - \text{Li}_2(\exp(2\pi\sqrt{-1}n/N'))| \\
&= \left| \int_{\exp(2\pi\sqrt{-1}n/N')}^{\exp(2\pi\sqrt{-1}n/N)} \frac{\log(1-t)}{t} dt \right| \\
&\leq \int_{\frac{2\pi n}{N'}}^{\frac{2\pi n}{N}} \left| \frac{\log(1 - \exp(\sqrt{-1}\theta))}{\exp(\sqrt{-1}\theta)} \right| |\sqrt{-1}\exp(\sqrt{-1}\theta)| d\theta \\
&= \int_{\frac{2\pi n}{N'}}^{\frac{2\pi n}{N}} |\log(1 - \exp(\sqrt{-1}\theta))| d\theta \\
&\leq \int_{\frac{2\pi n}{N'}}^{\frac{2\pi n}{N}} (1 - \log|\theta|) d\theta = \left[2\theta - \theta \log|\theta| \right]_{\frac{2\pi n}{N'}}^{\frac{2\pi n}{N}} \\
&= \frac{2\pi n}{N'} \left(2 - \log\left| \frac{2\pi n}{N'} \right| \right) - \frac{2\pi n}{N} \left(2 - \log\left| \frac{2\pi n}{N} \right| \right) \rightarrow 0 \quad (N > N' \rightarrow \infty).
\end{aligned}$$

Lemma 2.9 With the same notation as in Theorem 2.1 we have that

$$\begin{aligned}
\frac{2\pi \log |(q)_n|}{N} &= \sqrt{-1} \text{Li}_2(\exp(2\pi\sqrt{-1}n/N)) - \frac{\pi^2\sqrt{-1}}{6} + g(n, N) \\
&\stackrel{N}{\sim} \text{Im}[-\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))].
\end{aligned}$$

Proof Because of Lemma 2.5 and Lemma 2.6, we obtain the following equalities:

$$\begin{aligned}
& \sqrt{-1} \text{Li}_2(\exp(2\pi\sqrt{-1}n/N)) - \frac{\pi^2\sqrt{-1}}{6} - \text{Im}[-\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))] \\
&= \sqrt{-1} (\text{Re}[\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))] + \sqrt{-1} \text{Im}[\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))]) \\
&\quad - \frac{\pi^2\sqrt{-1}}{6} + \text{Im}[\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))] \\
&= \sqrt{-1} (\text{Re}[\text{Li}_2(\exp(2\pi\sqrt{-1}n/N))] - \frac{\pi^2}{6}) \\
&= \sqrt{-1} (\text{Re}[-\frac{1}{2} \log^2(1 - \exp(2\pi\sqrt{-1}n/N)) \\
&\quad - \text{Li}_2\left(1 - \frac{1}{1 - \exp(2\pi\sqrt{-1}n/N)}\right)] - \frac{\pi^2}{6}) \\
&= \sqrt{-1} (\text{Re}[-\frac{1}{2} \log^2(1 - \exp(2\pi\sqrt{-1}n/N))
\end{aligned}$$

$$\begin{aligned}
& - \operatorname{Li}_2\left(\frac{\exp(2\pi\sqrt{-1}n/N)}{\exp(2\pi\sqrt{-1}n/N) - 1}\right) \Big| - \frac{\pi^2}{6} \\
&= \sqrt{-1}(\operatorname{Re}[-\frac{1}{2}\log^2(1 - \exp(2\pi\sqrt{-1}n/N)) + \operatorname{Li}_2\left(\frac{\exp(2\pi\sqrt{-1}n/N) - 1}{\exp(2\pi\sqrt{-1}n/N)}\right)]) \\
&+ \frac{\pi^2}{6} + \frac{1}{2}\log^2\left(-\frac{\exp(2\pi\sqrt{-1}n/N)}{\exp(2\pi\sqrt{-1}n/N) - 1}\right) \Big| - \frac{\pi^2}{6} \\
&= \sqrt{-1}(\operatorname{Re}[\operatorname{Li}_2\left(\frac{\exp(2\pi\sqrt{-1}n/N) - 1}{\exp(2\pi\sqrt{-1}n/N)}\right)]) \\
&- \log(\exp(2\pi\sqrt{-1}n/N))\log(1 - \exp(2\pi\sqrt{-1}n/N)) \\
&+ \frac{1}{2}\log^2(\exp(2\pi\sqrt{-1}n/N))] \rightarrow 0 \quad (N \rightarrow \infty).
\end{aligned}$$

Hence,

$$\begin{aligned}
\frac{2\pi \log |(q)_n|}{N} &= \frac{2\pi \log |\prod_{k=0}^{n-1}(1 - q^{k+1})|}{N} = \frac{2\pi \sum_{k=1}^n \log |1 - q^k|}{N} \\
&\stackrel{N}{\sim} 2\pi \int_0^{n/N} \log |1 - \exp(2\pi\sqrt{-1}x)| dx \\
&= \sqrt{-1}\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n/N)) + \frac{\pi^2\sqrt{-1}n^2}{N^2} \\
&- \frac{2\pi n \log(1 - \exp(2\pi\sqrt{-1}n/N))}{N} \\
&+ \frac{\pi n \log 4}{N} + \frac{\pi n \log \sin^2(\frac{\pi n}{N})}{N} - \frac{\pi^2\sqrt{-1}}{6} \\
&= \sqrt{-1}\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n/N)) - \frac{\pi^2\sqrt{-1}}{6} + g(n, N) \\
&\stackrel{N}{\sim} \operatorname{Im}[-\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n/N))].
\end{aligned}$$

Corollary 2.10 *With the same notation as in Theorem 2.1 we have that*

$$\begin{aligned}
\frac{2\pi \log \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right|}{N} &\stackrel{N}{\sim} -\sqrt{-1}\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_i/N)) + \frac{\pi^2\sqrt{-1}}{6} - g(n_i, N) \\
&+ \sqrt{-1}\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_{i+1}/N)) - \frac{\pi^2\sqrt{-1}}{6} + g(n_{i+1}, N) \\
&- \sqrt{-1}\operatorname{Li}_2(\exp(2\pi\sqrt{-1}(n_{i+1} - n_i)/N)) + \frac{\pi^2\sqrt{-1}}{6}
\end{aligned}$$

$$\begin{aligned}
 & -g(n_{i+1} - n_i, N) \\
 & \stackrel{N}{\sim} \operatorname{Im}[\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_i/N)) - \operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_{i+1}/N)) \\
 & \quad + \operatorname{Li}_2(\exp(2\pi\sqrt{-1}(n_{i+1} - n_i)/N))].
 \end{aligned}$$

Lemma 2.11 $f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)})$ and $f(z_1, \dots, z_{2p-1})$ in Definition 2.4 above. We obtain the following equivalence relations:

$$f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) \stackrel{N}{\sim} f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)),$$

and

$$f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)}) + \operatorname{Li}_2(z_{2p-1}^{(2p-1)}) - \frac{\pi^2}{6} \stackrel{N}{\sim} f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)).$$

Proof Firstly, for a sufficiently large N ,

$$\begin{aligned}

2.2 Second reduction

Let $(a_1, \dots, a_{2p-1}) \in (\mathbb{C} \setminus [0, \infty))^{2p-1}$ be a solution of $\partial f / \partial z_1 = \dots = \partial f / \partial z_{2p-1} = 0$. The solution of these equations which induces the complete hyperbolic structure of the knot complement exists uniquely by virtue of the Lemma 2.3 of [9]. Secondly, we prove the following equality by using the method of steepest descent:

As for symbol ξ_j , see the Lemma 2.12. We know the following equality:

$\operatorname{Im}[f(a_1, \dots, a_{2p-1})]$ is the hyperbolic volume of a twist knot [1].

We prove the following Lemma in this section:

&\quad \times \prod_{j=1}^{2p-1} \left(-\xi_j\right)^{-\frac{1}{2}} \cdot \exp\left(\frac{\sqrt{-1}N}{2\pi}(\text{Re}[f(a_1, \dots, a_{2p-1})] - \frac{\pi^2(2p-2)}{6})\right),
\end{aligned}$$

where ξ_j are eigenvalues of the Hessian matrix of $f(z_1, \dots, z_{2p-1})$ evaluated at (a_1, \dots, a_{2p-1}) and $(-\xi_j)^{-\frac{1}{2}}$ are defined with arguments:

We deform $|z_i| = 1$ into C_i so that a_i will be a maximal value $\text{Im}[f(a_1, \dots, a_{2p-1})]$. Because of the method of steepest descent, we obtain the following formulas:

&= \left(\frac{N}{2\pi\sqrt{-1}}\right)^{2p-1} \left(\frac{4\pi^2}{\sqrt{-1}N}\right)^{\frac{2p-1}{2}} \exp\left(\frac{\sqrt{-1}N}{2\pi}(f(a_1, \dots, a_{2p-1}) - \frac{\pi^2(2p-2)}{6})\right)

& \times \left(\frac{1}{a_1} \cdots \frac{1}{a_{2p-1}} + O(N^{-1}) \right) \prod_{j=1}^{2p-1} (-\xi_j)^{-\frac{1}{2}} \\
& = \exp\left(-\frac{3\pi\sqrt{-1}(2p-1)}{4}\right) \cdot N^{\frac{2p-1}{2}} \cdot \exp\left(-\frac{N}{2\pi} \operatorname{Im}[f(a_1, \dots, a_{2p-1})]\right) \\
& \times \left(\frac{1}{a_1} \cdots \frac{1}{a_{2p-1}} + O(N^{-1}) \right) \\

3 Proof of the volume conjecture for twist knots

In this section, we prove Volume Conjecture for twist knots by using Lemmas of the previous Section.

Lemma 3.1 *With the same notation as in Theorem 2.1. If*

$$\begin{aligned} & \stackrel{N}{\sim} -\sqrt{-1}f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)) + \frac{\pi^2\sqrt{-1}(2p-2)}{6} \\ & + \sum_{i=1}^{2p-2} (-g(n_i, N) + g(n_{i+1}, N) - g(n_{i+1} - n_i, N)). \end{aligned}$$

Proof We obtain the following formulas:

Here, Equivalent relation (4) is shown by using Lemma 2.9 and Corollary 2.10. Equivalent relation (5) is shown by using Lemma 2.11. \square

Therefore, there exist the following positive real sequence $n_i \in \mathbb{N}$ ($1 \leq i \leq 2p - 1$):

$$\begin{aligned} J_N(K_{p>0}^*; q) &= q^{1-N} \sum_{N-1 \geq m_{2p-1} \geq \dots \geq m_1 \geq 0} (q^{1-N})_{m_{2p-1}} q^{-Nm_{2p-1}} \\ & \times \prod_{i=1}^{2p-2} (-1)^{m_i} q^{(-1)^i Nm_i + \binom{m_i}{2} - m_i m_{i+1}} \begin{bmatrix} m_{i+1} \\ m_i \end{bmatrix} \\ & + q^{1-N} \sum_{N-1 > m_1 > \dots > m_{2p-1} > 0} (q^{1-N})_{m_{2p-1}} q^{-Nm_{2p-1}} \\ & \times \prod_{i=1}^{2p-2} (-1)^{m_i} q^{(-1)^i Nm_i + \binom{m_i}{2} - m_i m_{i+1}} \begin{bmatrix} m_{i+1} \\ m_i \end{bmatrix} \\ & = q^{1-N} \sum_{m_{2p-1}, \dots, m_1 = 0}^{N-1} (q^{1-N})_{m_{2p-1}} q^{-Nm_{2p-1}} \\ & \times \prod_{i=1}^{2p-2} (-1)^{m_i} q^{(-1)^i Nm_i + \binom{m_i}{2} - m_i m_{i+1}} \begin{bmatrix} m_{i+1} \\ m_i \end{bmatrix}. \end{aligned}$$

We define the following sequence:

$$\begin{aligned} j(m_{2p-1}, \dots, m_1) &:= (q^{1-N})_{m_{2p-1}} q^{-Nm_{2p-1}} \\ & \times \prod_{i=1}^{2p-2} (-1)^{m_i} q^{(-1)^i Nm_i + \binom{m_i}{2} - m_i m_{i+1}} \begin{bmatrix} m_{i+1} \\ m_i \end{bmatrix}. \end{aligned}$$

Since for every $m_i, m_{i+1} \in \mathbb{N}$,

$$\begin{bmatrix} m_{i+1} \\ m_i \end{bmatrix} = 0 \quad (m_{i+1} < m_i)$$

holds, we obtain the following equality: for every $1 \leq i \leq 2p-2$,

$$j(m_{2p-1}, \dots, m_{i+1}, m_i, \dots, m_1) = 0 \quad (m_{i+1} < m_i).$$

Hence,

$$\begin{aligned}
& \left| \sum_{m_{2p-1}, \dots, m_1=0}^{N-1} j(m_{2p-1}, \dots, m_1) \right| \\
& \geq 2 \left| \left| \sum_{m_{2p-2}, \dots, m_1=0}^{N-1} j(n_{2p-1}, m_{2p-2}, \dots, m_1) \right| - \left| \sum_{m_{2p-2}, \dots, m_1=0}^{N-1} j(0, m_{2p-2}, \dots, m_1) \right| \right| \\
& \geq 2 \left(\left| \sum_{m_{2p-2}, \dots, m_1=0}^{N-1} j(n_{2p-1}, m_{2p-2}, \dots, m_1) \right| - \sum_{m_{2p-2}, \dots, m_1=0}^{N-1} \right) \\
& = 2 \left(\left| \sum_{m_{2p-2}, \dots, m_1=0}^{N-1} j(n_{2p-1}, m_{2p-2}, \dots, m_1) \right| - N^{2p-2} \right) \\
& \geq 2 \left(2 \left| \sum_{m_{2p-3}, \dots, m_1=0}^{N-1} j(n_{2p-1}, n_{2p-2}, m_{2p-3}, \dots, m_1) \right| \right. \\
& \quad \left. - \left| \sum_{m_{2p-3}, \dots, m_1=0}^{N-1} j(n_{2p-1}, n_{2p-1} + 1, m_{2p-3}, \dots, m_1) \right| - N^{2p-2} \right) \\
& = 2 \left(2 \left| \sum_{m_{2p-3}, \dots, m_1=0}^{N-1} j(n_{2p-1}, n_{2p-2}, m_{2p-3}, \dots, m_1) \right| - N^{2p-2} \right) \\
& = 4 \left| \sum_{m_{2p-3}, \dots, m_1=0}^{N-1} j(n_{2p-1}, n_{2p-2}, m_{2p-3}, \dots, m_1) \right| - 2N^{2p-2}.
\end{aligned}$$

We repeat the above calculation $2p-3$ times. Then, we obtain the following inequality:

$$\begin{aligned}
& \left| \sum_{m_{2p-1}, m_{2p-2}, \dots, m_1=0}^{N-1} j(m_{2p-1}, m_{2p-2}, \dots, m_1) \right| \\
& \geq 2^{2p-1} |j(n_{2p-1}, n_{2p-2}, n_{2p-3}, \dots, n_1)| - 2N^{2p-2}.
\end{aligned}$$

Hence,

$$|J_N(K_{p>0}^*; q)| \geq 2^{2p-1} |(q)_0| \prod_{i=1}^{2p-2} \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| - 2N^{2p-2}.$$

□

Lemma 3.5 *With the same notation as in Theorem 2.1 we have that*

$$\text{Im}[f(a_1, \dots, a_{2p-1})] \leq \lim_{N \rightarrow \infty} \frac{2\pi \log |J_N(K_{p>0}^*; q)|}{N}.$$

Proof Because of Lemma 3.4, for a sufficiently large N , we obtain the following formula:

$$2^{2p-1}|(q)_0| \prod_{i=1}^{2p-2} \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \leq |J_N(K_{p>0}^*; q)| + 2N^{2p-2}.$$

Hence,

$$\begin{aligned} (7) \quad & \frac{2\pi \log(|J_N(K_{p>0}^*; q)| + 2N^{2p-2})}{N} \geq \frac{2\pi}{N} \log \left(2^{2p-1}|(q)_0| \prod_{i=1}^{2p-2} \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) \\ & = \frac{2\pi}{N} \left(\log 2^{2p-1} + \log |(q)_0| + \sum_{i=1}^{2p-2} \log \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) \\ & \geq \frac{2\pi}{N} \left(\log 2^{2p-1} + \log |(q)_0| + \log |(q)_{2p-1}| + \sum_{i=1}^{2p-2} \log \left| \begin{bmatrix} n_{i+1} \\ n_i \end{bmatrix} \right| \right) \\ & \sim \sum_{i=1}^{2p-2} \operatorname{Im}[\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_i/N)) - \operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_{i+1}/N))] \\ & \quad + \operatorname{Li}_2(\exp(2\pi\sqrt{-1}(n_{i+1} - n_i)/N))] + \operatorname{Im}[\operatorname{Li}_2(\exp(2\pi\sqrt{-1}n_{2p-1}/N))] \\ & = \operatorname{Im}[f(z_1^{(1)}, \dots, z_{2p-1}^{(2p-1)})] \\ (8) \quad & \sim \operatorname{Im}[f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N))]. \end{aligned}$$

Here, Inequality (7) is shown by using Lemma 3.4. Equivalent relation (8) is shown by using Lemma 2.11. Hence,

$$(9) \quad \begin{aligned} & |J_N(K_{p>0}^*; q)| + 2N^{2p-2} \\ & \geq \exp\left(\frac{N}{2\pi} \operatorname{Im}[f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N))]\right). \end{aligned}$$

Hence,

$$\begin{aligned} & \int_0^N \cdots \int_0^N (|J_N(K_{p>0}^*; q)| + 2N^{2p-2}) |dn_1 \cdots dn_{2p-1}| \\ & \geq \int_0^N \cdots \int_0^N \left| \exp\left(\frac{N}{2\pi} \operatorname{Im}[f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N))]\right) \right| \\ & \quad \times \left| \exp\left(\frac{-\sqrt{-1}N}{2\pi}\right) \right. \\ & \quad \times \operatorname{Re}[f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N))] \left. \right| |dn_1 \cdots dn_{2p-1}| \\ & \geq \int_0^N \cdots \int_0^N \left| \exp\left(\frac{-\sqrt{-1}N}{2\pi}\right) \right| \end{aligned}$$

$$\begin{aligned}
& \times f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)) \Big| dn_1 \cdots dn_{2p-1} \\
& \geq \left| \int_0^N \cdots \int_0^N \exp\left(\frac{-\sqrt{-1}N}{2\pi}\right) \right. \\
& \quad \left. \times f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)) \right| dn_1 \cdots dn_{2p-1}.
\end{aligned}$$

Because of Corollary 2.13, we obtain the following formulas:

$$\begin{aligned}
& N^{2p-1} (|J_N(K_{p>0}^*; q)| + 2N^{2p-2}) \\
& \geq \left| \int_0^N \cdots \int_0^N \exp\left(\frac{-\sqrt{-1}N}{2\pi}\right) \right. \\
& \quad \left. \times f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N)) \right| dn_1 \cdots dn_{2p-1} \\
& = \left| \exp\left(-\frac{\sqrt{-1}\pi(2p-1)}{4}\right) \cdot N^{\frac{2p-1}{2}} \cdot \exp\left(\frac{N}{2\pi} \operatorname{Im}[f(a_1, \dots, a_{2p-1})]\right) \right. \\
& \quad \times \left(\frac{1}{a_1} \cdots \frac{1}{a_{2p-1}} + O(N^{-1})\right) \\
& \quad \left. \times \prod_{j=1}^{2p-1} (-\xi_j)^{-\frac{1}{2}} \exp\left(\frac{-\sqrt{-1}N}{2\pi} \operatorname{Re}[f(a_1, \dots, a_{2p-1})]\right) \right| \\
& = N^{\frac{2p-1}{2}} \exp\left(\frac{N}{2\pi} \operatorname{Im}[f(a_1, \dots, a_{2p-1})]\right) \cdot U(N).
\end{aligned}$$

Here,

$$U(N) := \left| \left(\frac{1}{a_1} \cdots \frac{1}{a_{2p-1}} + O(N^{-1})\right) \prod_{j=1}^{2p-1} (-\xi_j)^{-\frac{1}{2}} \right|.$$

Hence,

$$\frac{2\pi}{N} \left(\log \frac{1}{U(N)} + \log N^{\frac{2p-2}{2}} + \log \left| |J_N(K_{p>0}^*; q)| + 2N^{2p-2} \right| \right) \geq \operatorname{Im}[f(a_1, \dots, a_{2p-1})].$$

Because of Inequality (9), we have that

$$\begin{aligned}
\frac{2N^{2p-2}}{|J_N(K_{p>0}^*; q)|} & \leq \frac{2N^{2p-2}}{\exp\left(\frac{N}{2\pi} \operatorname{Im}[f(\exp(2\pi\sqrt{-1}n_1/N), \dots, \exp(2\pi\sqrt{-1}n_{2p-1}/N))]\right)} \\
& \rightarrow 0 \quad (N \rightarrow \infty).
\end{aligned}$$

Since

$$\frac{2\pi \log \left| |J_N(K_{p>0}^*; q)| + 2N^{2p-2} \right|}{N} \underset{N}{\sim} \frac{2\pi \log |J_N(K_{p>0}^*; q)|}{N},$$

and

$$\lim_{N \rightarrow \infty} \frac{2\pi}{N} \log N = \lim_{N \rightarrow \infty} \frac{2\pi}{N} \log \frac{1}{U(N)} = 0$$

hold, we obtain the following formula:

$$\operatorname{Im}[f(a_1, \dots, a_{2p-1})] \leq \lim_{N \rightarrow \infty} \frac{2\pi \log |J_N(K_{p>0}^*; q)|}{N}.$$

□

Theorem 3.6 *Theorem 1.2 is true.*

Proof Because of Lemma 2.3, Lemma 3.2, and Lemma 3.5, we obtain Theorem 1.2. □
