Pitchfork bifurcation at line solitons for nonlinear Schrödinger equations on the product space $\mathbb{R} \times \mathbb{T}$

Abstract

In this paper, we study the bifurcation problem from a line soliton for a stationary nonlinear Schrödinger equation on the product space $\mathbb{R} \times \mathbb{T}$. We extend earlier results to a larger class of the nonlinearity in the equation. The salient point of our analysis relies on a lower bound of solution to the "auxiliary equation" and then on the application of the Crandall-Rabinowitz argument.

1 Introduction

In this paper, we study the bifurcation problem from line solitons for the following stationary nonlinear Schrödinger equation posed on the product space $\mathbb{R} \times \mathbb{T}$:

$$-\partial_x^2 u - \partial_y^2 u + \omega u - |u|^{p-1} u = 0, \quad (x, y) \in \mathbb{R} \times \mathbb{T},$$
(1.1)

where $\mathbb{T} := \mathbb{R}/2\pi\mathbb{Z}$ is the one dimensional torus, $\omega > 0$, p > 1 and u is the unknown realvalued function on $\mathbb{R} \times \mathbb{T}$. Introducing the function $\mathcal{F} : (0, \infty) \times H^2(\mathbb{R} \times \mathbb{T}) \to L^2(\mathbb{R} \times \mathbb{T})$ defined by

$$\mathcal{F}(\omega, u) := -\partial_x^2 u - \partial_y^2 u + \omega u - |u|^{p-1} u, \qquad (1.2)$$

equation (1.1) can now be written as $\mathcal{F}(\omega, u) = 0$. We will use $\partial_u \mathcal{F}$ to denote the derivative of $\mathcal{F} = \mathcal{F}(\omega, u)$ with respect to the second variable u.

For each $\omega > 0$, equation (1.1) admits a positive solution in $H^1(\mathbb{R} \times \mathbb{T})$ which is independent of the variable $y \in \mathbb{T}$. Such a solution is called a line soliton to (1.1). In other words, a line soliton to (1.1) is defined as a positive H^1 -solution to the following ordinary differential equation:

$$-\frac{d^2R}{dx^2} + \omega R - R^p = 0, \qquad x \in \mathbb{R}.$$
(1.3)

It is known that for any $\omega > 0$ and p > 1, a unique positive H^1 -solution to (1.3) exists; We use R_{ω} to denote the line soliton to (1.1). The line soliton R_{ω} is explicitly given as

$$R_{\omega}(x,y) = R_{\omega}(x) := \omega^{\frac{1}{p-1}} \left(\frac{p+1}{2}\right)^{\frac{1}{p-1}} \operatorname{sech}^{\frac{2}{p-1}} \left(\frac{p-1}{2}\sqrt{\omega}x\right).$$
(1.4)

Note that the function $\omega \in (0, \infty) \mapsto R_{\omega} \in H^2(\mathbb{R})$ is C^{∞} . Furthermore, let $L_{\omega,+,0}$ be the linearized operator around R_{ω} for the ODE (1.3), namely,

$$L_{\omega,+,0} := -\frac{d^2}{dx^2} + \omega - pR_{\omega}^{p-1}.$$
 (1.5)

Then, the following are known (see, e.g., Section 3 of [2]):

1.

$$\sigma(L_{\omega,+,0}) = \left\{-\frac{\omega}{\omega_p}\right\} \cup \{0\} \cup [0,\infty) \quad \text{with} \quad \omega_p := \frac{4}{(p-1)(p+3)}. \tag{1.6}$$

2. All eigenvalues of $L_{\omega,+,0}$ are simple, and

$$L_{\omega,+,0}R_{\omega}^{\frac{p+1}{2}} = -\frac{\omega}{\omega_p}R_{\omega}^{\frac{p+1}{2}}, \qquad L_{\omega,+,0}\frac{dR_{\omega}}{dx} = 0.$$
(1.7)

Note that $R_{\omega}^{\frac{p+1}{2}}$ is even and $\frac{dR_{\omega}}{dx}$ is odd.

By the Fourier series expansion with respect to the second variable y, we see that for any $\omega > 0$ and $f \in H^2(\mathbb{R} \times \mathbb{T})$,

$$\partial_u \mathcal{F}(\omega, R_\omega) f = \sum_{n \in \mathbb{Z}} \left(L_{\omega, +, 0} + n^2 \right) f_n(x) e^{iny} \quad \text{with} \quad f_n(x) := \frac{1}{2\pi} \int_0^{2\pi} e^{-iny} f(x, y) \, dy.$$
(1.8)

Thus, we find from (1.6) and (1.8) that

$$\sigma(\partial_u \mathcal{F}(\omega, R_\omega)) = \bigcup_{n \in \mathbb{Z}} \sigma(L_{\omega, +, 0} + n^2).$$
(1.9)

The aim of this paper is to show that for any p > 1, a "pitchfork bifurcation" occurs at the line soliton R_{ω_p} (see Theorem 1.1). Let us recall that the pair (ω_p, R_{ω_p}) is called a bifurcation point for the equation $\mathcal{F} = 0$ with respect to the curve $\omega \mapsto (\omega, R_{\omega})$ if every neighborhood of (ω_p, R_{ω_p}) contains zeros of \mathcal{F} not lying on the curve (see [3]). The implicit function theorem shows that if (ω_p, R_{ω_p}) is the bifurcation point, then zero is an eigenvalue of $\partial_u \mathcal{F}(\omega_p, R_{\omega_p})$. Since $\partial_u \mathcal{F}(\omega_p, R_{\omega_p})$ is just the linearized operator around R_{ω_p} for (1.1), we can say that a necessary condition for (ω_p, R_{ω_p}) to be the bifurcation point is that R_{ω_p} is degenerate. In addition, by (1.6), (1.7) and (1.9), we see that if $\omega = \omega_p$, then the kernel of $\partial_u \mathcal{F}(\omega_p, R_{\omega_p})$ contains the real-valued functions $\partial_x R_{\omega_p}, R_{\omega_p}^{\frac{p+1}{2}} \cos y$ and $R_{\omega_p}^{\frac{p+1}{2}} \sin y$. We introduce the spaces L_{sym}^2 and H_{sym}^2 as

$$\begin{split} L^2_{\mathrm{sym}} &:= \left\{ \ u \in L^2(\mathbb{R} \times \mathbb{T}) \colon u(x,y) = u(-x,y) = u(x,-y) \ \right\} \\ H^2_{\mathrm{sym}} &:= H^2(\mathbb{R} \times \mathbb{T}) \cap L^2_{\mathrm{sym}}. \end{split}$$

Note that $R_{\omega_p}^{\frac{p+1}{2}} \cos y \in H_{\text{sym}}^2$, whereas $\partial_x R_{\omega_p}$ and $R_{\omega_p}^{\frac{p+1}{2}} \sin y$ fail to lie in H_{sym}^2 . Thus, (ω_p, R_{ω_p}) is still a candidate for the the bifurcation point in the setting H_{sym}^2 . Here, we remark that the information about branches bifurcating from (ω_p, R_{ω_p}) is useful in the study of the stability of the degenerate line soliton R_{ω_p} (see [6, 4]).

Now, we sate the main result of this paper.

Theorem 1.1. For any p > 1, the pair (ω_p, R_{ω_p}) is a pitchfork bifurcation point for $\mathcal{F} = 0$ in $(0, \infty) \times H^2_{\text{sym}}$ with respect to the curve $\omega \mapsto (\omega, R_{\omega})$; Precisely, there exist $a_* > 0$, $\delta_* > 0$ and a C^2 -curve $a \in (-a_*, a_*) \mapsto (\omega(a), Q(a)) \in (\omega_p - \delta_*, \omega_p + \delta_*) \times H^2_{\text{sym}}$ with the following properties:

1. The set of zeros of \mathcal{F} in $(\omega_p - \delta_*, \omega_p + \delta_*) \times H^2_{\text{sym}}$ consists of two curves $\omega \in (0, \infty) \mapsto (\omega, R_\omega)$ and $a \in (-a_*, a_*) \mapsto (\omega(a), Q(a))$.

2. The following hold for all $a \in (-a_*, a_*)$:

$$\omega(0) = \omega_p, \qquad \frac{d\omega}{da}(0) = 0, \qquad (1.10)$$

$$\frac{d^{2}\omega}{da^{2}}(0) = \omega_{p} \{p(p-1)\}^{2} \langle \mathbf{T}(\omega_{p}, 0)^{-1} \left(R_{\omega_{p}}^{p-2} \{\psi_{\omega_{p}} \cos y\}^{2} \right), R_{\omega_{p}}^{p-2} \{\psi_{\omega_{p}} \cos y\}^{2} \rangle
+ \frac{p(p-1)(p-2)\omega_{p}}{3} \langle R_{\omega_{p}}^{p-3}, \{\psi_{\omega_{p}} \cos y\}^{4} \rangle,$$
(1.11)

where $\mathbf{T}(\omega_p, 0) := P_{\perp} \partial_u \mathcal{F}(\omega_p, R_{\omega_p})|_{X_2}$; Note that $\mathbf{T}(\omega_p, 0) \colon X_2 \to Y_2$ is a bijection.

3. For any $a \in (-a_*, a_*)$, Q(a) is positive and written as

$$Q(a) = R_{\omega_p} + aC_p R_{\omega_p}^{\frac{p+1}{2}} \cos y + O(a^2) \qquad in \ H^2(\mathbb{R} \times \mathbb{T}), \tag{1.12}$$

where $C_p > 0$ is a normalizing constant chosen such that

$$\|C_p R_{\omega_p}^{\frac{p+1}{2}} \cos y\|_{L^2(\mathbb{R}\times\mathbb{T})}^2 = 1.$$
(1.13)

In particular, $Q(0) = R_{\omega_p}$. Furthermore, the mass of Q(a) is written as

$$\|Q(a)\|_{L^{2}(\mathbb{R}\times\mathbb{T})}^{2} = \pi \|R_{\omega_{p}}\|_{L^{2}(\mathbb{R})}^{2} + \frac{a^{2}}{\omega_{p}} \left\{ \frac{d^{2}\omega}{da^{2}}(0) \frac{5-p}{4(p-1)} \|R_{\omega_{p}}\|_{L^{2}(\mathbb{R})}^{2} - 1 \right\} + o(a^{2}).$$

$$(1.14)$$

Remark 1.1. When $p \ge 2$, the same result as in Theorem 1.1 had been obtained in [6]. The salient point of our result is that we can treat all p > 1; When $1 , the twice differentiability of the curve <math>(\omega(a), Q(a))$ is not obvious because the nonlinearity is not twice differentiable.

We give a proof of Theorem 1.1 in Section 5. In order to prove the theorem, we derive a lower bound of the solution to the "auxiliary equation" (see (2.20)) first, and then apply the Crandall-Rabinowitz argument [3]. Such an approach enables us to treat the case 1 .

At the end of this section, we give a basic properties of line solitons to (1.1). It follows from the definition of the line solitons (see (1.4)) that

$$R_{\omega}(x) = \omega^{\frac{1}{p-1}} R_1(\sqrt{\omega}x), \qquad (1.15)$$

$$\partial_{\omega}R_{\omega} = \frac{1}{p-1}\omega^{-1}R_{\omega} + \frac{1}{2}\omega^{-1}x\frac{dR_{\omega}}{dx},$$
(1.16)

$$\omega^{\frac{1}{p-1}} e^{-\sqrt{\omega}|x|} \le R_{\omega}(x) \le \{2(p+1)\omega\}^{\frac{1}{p-1}} e^{-\sqrt{\omega}|x|}.$$
(1.17)

Differentiating both sides of $\mathcal{F}(\omega, R_{\omega}) = 0$ with respect to ω , we see that

$$\partial_u \mathcal{F}(\omega, R_\omega) \partial_\omega R_\omega = -R_\omega. \tag{1.18}$$

Furthermore, by (1.16) and the integration by parts, we can verify that

$$\int_{\mathbb{R}} R^q_{\omega} \partial_{\omega} R_{\omega} = \frac{2q - p + 3}{2(p - 1)(q + 1)} \omega^{-1} \int_{\mathbb{R}} R^{q+1}_{\omega} \quad \text{for all } q \ge 1.$$
(1.19)

We can also derive the following equation (see Lemma 2.2 of [6]):

$$\int_{\mathbb{R}} R_{\omega}^{p+r} = \frac{(p+1)(r+1)}{2r+p+1} \omega \int_{\mathbb{R}} R_{\omega}^{r+1} \quad \text{for all } r > 1.$$
(1.20)

The rest of this paper is organized as follows. In Section 2, we apply the Lyapunov-Schmidt method and introduce the auxiliary and bifurcation equations (see (2.20) and (2.21)). In Section 3, we derive a lower bound and decay estimates for solutions to the auxiliary equation. In Section 4, we show the three times differentiability of solutions to the auxiliary equation with respect to certain parameters. In Section 5, we give a proof of Theorem 1.1.

2 Lyapunov-Schmidt method

In order to construct a bifurcation branch of $\mathcal{F} = 0$ from (ω_p, R_{ω_p}) in $(0, \infty) \times H^2_{\text{sym}}(\mathbb{R} \times \mathbb{T})$, we employ the Lyapunov-Schmidt method. Let us begin by introducing a few symbols:

Notation 2.1. *1.* For $\omega > 0$, define ψ_{ω} as

$$\psi_{\omega} := \frac{R_{\omega}^{\frac{p+1}{2}}}{\|R_{\omega}^{\frac{p+1}{2}}\cos y\|_{L^{2}(\mathbb{R}\times\mathbb{T})}} = \frac{R_{\omega}^{\frac{p+1}{2}}}{\sqrt{\pi}\|R_{\omega}^{\frac{p+1}{2}}\|_{L^{2}(\mathbb{R})}}.$$
(2.1)

Observe from (1.17) that

$$|\psi_{\omega_p}(x)| \lesssim e^{-\frac{p+1}{2}\sqrt{\omega}|x|} \qquad \text{for all } x \in \mathbb{R},$$
(2.2)

where the implicit constant depends only on p.

2. For p > 1 and $\omega > 0$, let $\lambda(\omega)$ denote the second eigenvalue of the operator $\partial_u \mathcal{F}(\omega, R_\omega)$ restricted to H^2_{sym} . Note that $\partial_u \mathcal{F}(\omega, R_\omega)|_{H^2_{\text{sym}}}$ is a seff-adjoint operator on $L^2(\mathbb{R} \times \mathbb{T})$ with the values in L^2_{sym} . By (1.9), (1.6), (1.7) and (2.1), we see that

$$\lambda(\omega) = 1 - \frac{\omega}{\omega_p}, \quad \partial_u \mathcal{F}(\omega, R_\omega)|_{H^2_{\text{sym}}} \psi_\omega \cos y = \lambda(\omega) \psi_\omega \cos y \qquad \text{for all } \omega > 0. \tag{2.3}$$

Furthermore, we see that

$$\operatorname{Ker} \partial_u \mathcal{F}(\omega_p, R_{\omega_p})|_{H^2_{\operatorname{sym}}} = \operatorname{span} \{\psi_{\omega_p} \cos y\},$$
(2.4)

$$\frac{d\lambda}{d\omega}(\omega) = -\frac{1}{\omega_p} \qquad \text{for all } \omega > 0. \tag{2.5}$$

3. We use $L^2_{real}(\mathbb{R} \times \mathbb{T})$ to denote the real Hilbert space of square integral functions on $\mathbb{R} \times \mathbb{T}$ equipped with the inner product

$$\langle u, v \rangle := \int_{\mathbb{R}^d \times [0, 2\pi]} u(x, y) v(x, y) \, dx dy.$$

4. We define the spaces X_2 and Y_2 as

$$X_2 := \{ u \in H^2_{\text{sym}}(\mathbb{R} \times \mathbb{T}) \colon \langle u, \psi_{\omega_p} \cos y \rangle = 0 \},$$
$$Y_2 := \{ u \in L^2_{\text{sym}}(\mathbb{R} \times \mathbb{T}) \colon \langle u, \psi_{\omega_p} \cos y \rangle = 0 \}.$$

Note that $X_2 \subset Y_2$. Since the line solitons are independent of y, it is easy to verify that

$$R_{\omega}, \partial_{\omega} R_{\omega} \in X_2 \qquad \text{for all } p > 1 \text{ and } \omega > 0.$$

$$(2.6)$$

We look for solutions to the equation $\mathcal{F} = 0$ of the form $(\omega, u) = (\omega_p + \delta, R_{\omega_p} + a\psi_{\omega_p} \cos y + h)$ with $\delta > 0$, $a \in \mathbb{R}$ and $h \in H^2_{\text{sym}}$. To this end, we consider the orthogonal projection P_{\perp} from $L^2(\mathbb{R} \times \mathbb{T})$ onto Y_2 :

$$P_{\perp}u := u - \langle u, \psi_{\omega_p} \cos y \rangle \psi_{\omega_p} \cos y, \qquad (2.7)$$

Then, we define the function $\mathcal{F}_{\perp} : (0, \infty) \times (-1, 1) \times H^2_{\text{sym}} \to Y_2$ as

$$\mathcal{F}_{\perp}(\omega, a, h) := P_{\perp} \mathcal{F}(\omega, R_{\omega_p} + a\psi_{\omega_p} \cos y + h).$$
(2.8)

Note that

$$\mathcal{F}_{\perp}(\omega, 0, R_{\omega} - R_{\omega_p}) = P_{\perp}\mathcal{F}(\omega, R_{\omega}) = 0.$$
(2.9)

Note that (2.4) shows that

$$\operatorname{Ker} \partial_u \mathcal{F}(\omega_p, R_{\omega_p})|_{X_2} = \{0\}.$$
(2.10)

Furthermore, by the decay of R_{ω} (see (1.17)), (2.10) and the Fredholm alternative theorem, we see that

$$\operatorname{Ran} \partial_u \mathcal{F}(\omega_p, R_{\omega_p})|_{X_2} = Y_2.$$
(2.11)

By (2.10) and (2.11), we see that $\partial_u \mathcal{F}(\omega_p, R_{\omega_p}) \colon X_2 \to Y_2$ is bijective.

Using the implicit function theorem, we can find solutions to $\mathcal{F}_{\perp}(\omega, a, h) = 0$:

Lemma 2.1. Assume p > 1. Then, there exist $a_0 > 0$, $\delta_0 > 0$, $r_0 > 0$ and a C^1 -function $\eta: (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0) \to X_2$ such that the following hold for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$:

- 1. Let $h \in X_2$. Then, $\mathcal{F}_{\perp}(\omega, a, h) = 0$ if and only if $h = \eta(\omega, a)$.
- 2. $\|\eta(\omega, a)\|_{H^2(\mathbb{R}\times\mathbb{T})} < r_0.$
- 3. Define $\varphi(\omega, a)$ as

$$\varphi(\omega, a) := R_{\omega_p} + a\psi_{\omega_p} \cos y + \eta(\omega, a). \tag{2.12}$$

Then, the following hold:

$$\partial_{\omega}\eta(\omega,a) = -\left(P_{\perp}\partial_{u}\mathcal{F}(\omega,\varphi(\omega,a))|_{X_{2}}\right)^{-1}P_{\perp}\varphi(\omega,a),\tag{2.13}$$

$$\partial_a \eta(\omega, a) = -\left(P_\perp \partial_u \mathcal{F}(\omega, \varphi(\omega, a))|_{X_2}\right)^{-1} P_\perp \partial_u \mathcal{F}(\omega, \varphi(\omega, a)) \psi_{\omega_p} \cos y.$$
(2.14)

Remark 2.1. 1. Lemma 2.1 only states that the function η is C^1 since the assumption includes the case $1 . When <math>p \ge 2$, we can prove that η is C^2 .

2. Since η is C^1 with respect to (ω, a) in $H^2(\mathbb{R} \times \mathbb{T})$, replacing δ_0 by $\frac{\delta_0}{2}$ and a_0 with $\frac{a_0}{2}$ if necessary, we may assume that

$$\sup_{\omega \in (\omega_p - \delta_0, \omega_p + \delta_0)} \sup_{a \in (-a_0, a_0)} \left\{ \|\partial_\omega \eta(\omega, a)\|_{H^2(\mathbb{R} \times \mathbb{T})} + \|\partial_a \eta(\omega, a)\|_{H^2(\mathbb{R} \times \mathbb{T})} \right\} \lesssim 1, \quad (2.15)$$

where the implicit constant depends only on p.

Let $a_0 > 0$, $\delta_0 > 0$, $r_0 > 0$, η and φ be the same as in Lemma 2.1. By (2.6), (2.9), Lemma 2.1, we see that

$$\eta(\omega, 0) = R_{\omega} - R_{\omega_p} \quad \text{for all } \omega \in (\omega_p - \delta_0, \ \omega_p + \delta_0).$$
(2.16)

In particular, we see that

$$\eta(\omega_p, 0) = 0, \qquad \varphi(\omega, 0) = R_\omega, \qquad \partial_\omega \eta(\omega, 0) = \partial_\omega \varphi(\omega, 0) = \partial_\omega R_\omega.$$
 (2.17)

We can also verify that

$$\partial_a \eta(\omega_p, 0) = 0, \qquad \partial_a \phi(\omega_p, 0) = \psi_{\omega_p} \cos y.$$
 (2.18)

Now, we introduce the function \mathcal{F}_{\parallel} : $(\omega_p - \delta_0, \ \omega_p + \delta_0) \times (-a_0, a_0) \to \mathbb{R}$ as

$$\mathcal{F}_{\parallel}(\omega, a) := \langle \mathcal{F}(\omega, \varphi(\omega, a)), \ \psi_{\omega_p} \cos y \rangle.$$
(2.19)

Then, we may write the equation $\mathcal{F}(\omega, R_{\omega_p} + a\psi_{\omega_p}\cos y + h) = 0$ as follows:

$$\int \mathcal{F}_{\perp}(\omega, a, h) = 0, \qquad (2.20)$$

$$\int \mathcal{F}_{\parallel}(\omega, a) = 0. \tag{2.21}$$

The first equation (2.20) is called the auxiliary equation and the second one (2.21) the bifurcation equation. Lemma 2.1 shows that $(\omega, a, \eta(\omega, a))$ is a solution to the auxiliary equation (2.20) for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$. Observe from (2.17), (2.19) and $\mathcal{F}(\omega, R_{\omega}) = 0$ that

$$\mathcal{F}_{\parallel}(\omega, 0) = 0. \tag{2.22}$$

3 Lower bound and decay of solution to the auxiliary equation

Throughout this section, for a given p > 1, we use a_0 , δ_0 and $\eta: (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0) \to X_2$ provided by Lemma 2.1. Furthermore, let $\varphi(\omega, a)$ be the function defined by (2.12), namely, $\varphi(\omega, a) = R_{\omega_p} + a\psi_{\omega_p} \cos y + \eta(\omega, a)$.

Our aim in this section is to show the following propositions:

Proposition 3.1. Assume p > 1. Then, there exists $\varepsilon_1 > 0$ depending only on p with the following property: for any $0 < \varepsilon < \varepsilon_1$, there exist $0 < a_{\varepsilon} < a_0$ and $C_1(\varepsilon) > 1$ depending only on p and ε such that for any $(\omega, a, x, y) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon}) \times \mathbb{R} \times \mathbb{T}$,

$$\frac{1}{C_1(\varepsilon)}e^{-(\sqrt{\omega}+\varepsilon)|x|} \le \varphi(\omega, a, x, y) \le C_1(\varepsilon)e^{-(\sqrt{\omega}-\varepsilon)|x|}.$$
(3.1)

In particular, $\varphi(\omega, a)$ is positive.

Proposition 3.2. Assume p > 1. Let $\varepsilon_1 > 0$ be the constant given in Proposition 3.1. Then, for any $0 < \varepsilon < \varepsilon_1$, there exist $0 < a_{\varepsilon} < a_0$, $C_2(\varepsilon) > 0$ and $C_3(\varepsilon) > 0$ depending only on p and ε such that for any $(\omega, a, x, y) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon}) \times \mathbb{R} \times \mathbb{T}$,

$$\left|\partial_{\omega}\varphi(\omega, a, x, y)\right| \le C_2(\varepsilon)e^{-(\sqrt{\omega}-2\varepsilon)|x|},\tag{3.2}$$

$$\left|\partial_a \varphi(\omega, a, x, y)\right| \le C_3(\varepsilon) e^{-(\sqrt{\omega} - \varepsilon)|x|}.$$
(3.3)

We use these propositions to show the differentiability of $\varphi(\omega, a)$ with respect to ω and a (see Section 4 below in details).

We will introduce symbols used in the rest of this paper:

Notation 3.1. Let p > 1 and $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$.

1. Define the operators $\mathbf{L}_{-}(\omega, a)$ and $\mathbf{L}_{+}(\omega, a)$ on $L^{2}_{real}(\mathbb{R} \times \mathbb{T})$ with the domain $H^{2}(\mathbb{R} \times \mathbb{T})$ as

$$\mathbf{L}_{-}(\omega, a) := -\partial_x^2 - \partial_y^2 + \omega - \varphi(\omega, a)^{p-1}, \qquad (3.4)$$

$$\mathbf{L}_{+}(\omega, a) := \partial_{u} \mathcal{F}(\omega, \varphi(\omega, a)) = -\partial_{x}^{2} - \partial_{y}^{2} + \omega - p\varphi(\omega, a)^{p-1}.$$
(3.5)

Note that both $\mathbf{L}_{-}(\omega, a)$ and $\mathbf{L}_{+}(\omega, a)$ are self-adjoint operators on $L^{2}(\mathbb{R} \times \mathbb{T})$ with domain $H^{2}(\mathbb{R} \times \mathbb{T})$. Observe from (2.17) that

$$\mathbf{L}_{+}(\omega,0) = \partial_{u}\mathcal{F}(\omega,R_{\omega}). \tag{3.6}$$

Furthermore, by (3.6), (2.17) and (1.18), we see that

$$\mathbf{L}_{+}(\omega,0)\partial_{\omega}\varphi(\omega,0) = \partial_{u}\mathcal{F}(\omega,R_{\omega})\partial_{\omega}R_{\omega} = -R_{\omega}.$$
(3.7)

2. Define

$$E(\omega, a) := \mathcal{F}_{\parallel}(\omega, a)\psi_{\omega_p}\cos y. \tag{3.8}$$

Lemma 2.1 together with (2.12) shows that

$$\mathbf{L}_{-}(\omega, a)\varphi(\omega, a) = \mathcal{F}_{\perp}(\omega, a, \eta(\omega, a)) + \mathcal{F}_{\parallel}(\omega, a)\psi_{\omega_{p}}\cos y = E(\omega, a).$$
(3.9)

3.1 **Proof of Proposition 3.1**

Following the argument of Berestycki and Nirenberg [1], we shall prove Proposition 3.1. The maximal principle plays an important role in the proof. We first show a uniform decay of $\varphi(\omega, a)$.

Lemma 3.3. Assume p > 1. Then, for any $\omega \in (\omega_p - \delta_0, \omega_p + \delta_0)$, the following holds:

$$\lim_{|x|\to\infty} \sup_{a\in[-\frac{a_0}{2},\frac{a_0}{2}]} \sup_{y\in\mathbb{T}} \varphi(\omega,a,x,y) = 0.$$
(3.10)

Proof. If the claim were false, then there existed $\omega_* \in (\omega_p - \delta_0, \omega_p + \delta_0)$, $C_* > 0$ and a sequence $\{x_n\}$ with $\lim_{n\to\infty} |x_n| = \infty$ such that

$$\sup_{a \in \left[-\frac{a_0}{2}, \frac{a_0}{2}\right]} \sup_{y \in \mathbb{T}} |\varphi(\omega_*, a, x_n, y)| \ge C_* \quad \text{for all } n \in \mathbb{N}.$$

Furthermore, for each $n \in \mathbb{N}$, there exist $a_n \in \left[-\frac{a_0}{2}, \frac{a_0}{2}\right]$ and $y_n \in \mathbb{T}$ such that

$$|\varphi(\omega_*, a_n, x_n, y_n)| \ge \frac{C_*}{2}.$$
(3.11)

Since $\left[-\frac{a_0}{2}, \frac{a_0}{2}\right]$ is compact, we may assume that there exists $a_{\infty} \in \left[-\frac{a_0}{2}, \frac{a_0}{2}\right]$ such that $\lim_{n\to\infty} a_n = a_{\infty}$. Note that $\partial_a \varphi(\omega_*, a)$ is continuous with respect to a in $H^2(\mathbb{R} \times \mathbb{T})$. Then, by the Sobolev inequality and the mean-value theorem, we see that

$$\begin{aligned} |\varphi(\omega_*, a_n, x_n, y_n) - \varphi(\omega_*, a_\infty, x_n, y_n)| &\lesssim \|\varphi(\omega_*, a_n) - \varphi(\omega_*, a_\infty)\|_{H^2(\mathbb{R} \times \mathbb{T})} \\ &\lesssim |a_n - a_\infty| \sup_{0 \le \theta \le 1} \left\| \partial_a \varphi(\omega_*, a_\infty + \theta(a_n - a_\infty)) \right\|_{H^2(\mathbb{R} \times \mathbb{T})} \lesssim |a_n - a_\infty|, \end{aligned}$$
(3.12)

where the implicit constant is independent of n. We find from (3.12) that there exists a number $n_* \geq 1$ such that

$$|\varphi(\omega_*, a_n, x_n, y_n) - \varphi(\omega_*, a_\infty, x_n, y_n)| \le \frac{C_*}{4} \quad \text{for all } n \ge n_*.$$
(3.13)

Furthermore, it follows from (3.11) and (3.13) that

$$|\varphi(\omega_*, a_\infty, x_n, y_n)| \ge \frac{C_*}{8}$$
 for all $n \ge n_*$,

which is absurd because $\varphi(\omega_*, a_\infty) \in H^2(\mathbb{R} \times \mathbb{T})$ implies that

$$\lim_{|x|\to\infty}\sup_{y\in\mathbb{T}}\varphi(\omega_*,a_\infty,x,y)=0.$$

Thus, the claim of the lemma must be true.

Now, we give a proof of Proposition 3.1:

Proof of Proposition 3.1. Let $\omega \in (\omega_p - \delta_0, \omega_p + \delta_0)$ and $\varepsilon > 0$ be a small constant to be specified later (see (3.19)), and define

$$W_1(x,y) = W_1(x) := e^{-(\sqrt{\omega}-\varepsilon)|x|}, \qquad W_2(x,y) = W_2(x) := e^{-(\sqrt{\omega}+\varepsilon)|x|}.$$

Furthermore, let $a \in \left[-\frac{a_0}{2}, \frac{a_0}{2}\right]$ be a constant to be specified later. It is easy to verify that

$$\mathbf{L}_{-}(\omega, a)W_{1} = \left(2\sqrt{\omega\varepsilon} - \varepsilon^{2} - |\varphi(\omega, a)|^{p-1}\right)W_{1}, \qquad (3.14)$$

$$\mathbf{L}_{-}(\omega, a)W_{2} = \left(-2\sqrt{\omega\varepsilon} - \varepsilon^{2} - |\varphi(\omega, a)|^{p-1}\right)W_{2}.$$
(3.15)

Furthermore, we define

$$v_{1,a} := W_1 - \varphi(\omega, a), \qquad v_{2,a} := \varphi(\omega, a) - W_2.$$

Then, by (3.14), (3.15) and (3.9), we see that

$$\mathbf{L}_{-}(\omega, a)v_{1,a} = \left(2\sqrt{\omega}\varepsilon - \varepsilon^{2} - |\varphi(\omega, a)|^{p-1}\right)W_{1} - E(\omega, a), \qquad (3.16)$$

$$\mathbf{L}_{-}(\omega, a)v_{2,a} = \left(2\sqrt{\omega}\varepsilon + \varepsilon^{2} + |\varphi(\omega, a)|^{p-1}\right)W_{2} + E(\omega, a).$$
(3.17)

Define

$$B_{r_0} := \{ u \in X_2 \colon \| u \|_{H^2(\mathbb{R} \times \mathbb{T})} < r_0 \}.$$

Then, by Lemma 2.1, there exists a constants $C_* > 0$ depending only on p such that for any $x \in \mathbb{R}$,

$$\sup_{y \in \mathbb{T}} |E(\omega, a, x, y)| \leq \|\mathcal{F}(\omega, \varphi(\omega, a))\|_{L^2(\mathbb{R} \times \mathbb{T})} \|\psi_{\omega_p} \cos y\|_{L^2(\mathbb{R} \times \mathbb{T})} |\psi_{\omega_p}(x)|$$

$$\leq C_* e^{-\frac{p+1}{2}\sqrt{\omega}|x|}.$$
(3.18)

Now, we impose the smallness condition on ε by

$$0 < \varepsilon < \frac{\min\{p-1, 1\}}{4} \sqrt{\omega_p - \delta_0}.$$
 (3.19)

Let $\rho(\varepsilon) > 0$ be a number such that

$$C_* e^{-\varepsilon \rho(\varepsilon)} \le \varepsilon^2. \tag{3.20}$$

Then, by (3.18), we see that if $|x| \ge \rho(\varepsilon)$, then

$$\sup_{y\in\mathbb{T}} |E(\omega, a, x, y)| \le C_* e^{-\frac{p-1}{4}\sqrt{\omega_p - \delta_0}|x|} W_2 \le C_* e^{-\varepsilon\rho(\varepsilon)} W_2 \le \varepsilon^2 W_2 \le \varepsilon^2 W_1.$$
(3.21)

Furthermore, by Lemma 3.3, we may assume that $\rho(\varepsilon) > 0$ is so large that

$$\sup_{a \in \left[-\frac{a_0}{2}, \frac{a_0}{2}\right]} \sup_{y \in \mathbb{T}} \left|\varphi(\omega, a, x, y)\right|^{p-1} \le \varepsilon^2 \quad \text{for all } |x| \ge \rho(\varepsilon).$$

Then, it follows from (3.16), (3.17), (3.21) and (3.19) that

$$\mathbf{L}_{-}(\omega, a)v_{1,a} \ge 0, \qquad \mathbf{L}_{-}(\omega, a)v_{2,a} \ge 0 \qquad \text{for all } |x| \ge \rho(\varepsilon) \text{ and } y \in \mathbb{T}.$$
 (3.22)

On the other hand, Since $\lim_{a\to 0} \|\varphi(\omega, a) - \varphi(\omega, 0)\|_{L^{\infty}(\mathbb{R}\times\mathbb{T})} = 0$ and $\varphi(\omega, 0) = R_{\omega} \geq \omega^{\frac{1}{p-1}} e^{-\sqrt{\omega_p + \delta_0}|x|}$ (see (2.17) and (1.17)), we can take $0 < a_{\varepsilon} \leq \frac{a_0}{2}$ depending only on p and ε such that if $a \in (-a_{\varepsilon}, a_{\varepsilon})$, then

$$\frac{1}{2}R_{\omega}(x) \le \varphi(\omega, a, x, y) \le 2R_{\omega}(x) \quad \text{for all } |x| \le 2\rho(\varepsilon) \text{ and } y \in \mathbb{T}.$$
(3.23)

Furthermore, by (3.20), (3.23) and (1.17), we see that for any $y \in \mathbb{T}$,

$$v_{1,a}(\rho(\varepsilon), y) \ge \varepsilon^{-2} C_* e^{-\sqrt{\omega}\rho(\varepsilon)} - 2\{2(p+1)\sqrt{\omega_p + \delta_0}\}^{\frac{1}{p-1}} e^{-\sqrt{\omega}\rho(\varepsilon)}.$$
(3.24)

Similarly, we see that for any $y \in \mathbb{T}$,

$$v_{2,a}(\rho(\varepsilon), y) \ge \frac{1}{2} (\omega_p - \delta_0)^{\frac{1}{p-1}} e^{-\sqrt{\omega}\rho(\varepsilon)} - C_*^{-1} \varepsilon^2 e^{-\sqrt{\omega}\rho(\varepsilon)}.$$
(3.25)

Thus, we find from (3.24) and (3.25) that if ε is sufficiently small dependently only on p, then

 $v_{1,a}(\rho(\varepsilon), y) \ge 0, \qquad v_{2,a}(\rho(\varepsilon), y) \ge 0 \qquad \text{for all } y \in \mathbb{T}.$ (3.26)

Define

$$S_{\varepsilon} := \{ (x, y) \in \mathbb{R} \times \mathbb{T} \colon |x| > \rho(\varepsilon) \}$$

We claim that

$$v_{1,a}, v_{2,a} \ge 0$$
 for all $(x, y) \in S_{\varepsilon}$. (3.27)

Note that (3.27) together with (3.23) proves Proposition 3.1. We prove (3.27) by contradiction. Suppose that (3.27) fails. Then, we see that there exists $(x_{\min}, y_{\min}) \in \mathbb{R} \times [-\pi, \pi]$ such that $v_{1,a}(x_{\min}, y_{\min}) = \min_{(x,y)\in S_{\varepsilon}} v_{1,\alpha}(x,y) < 0$. By (3.22), (3.26) and $\omega - |\varphi(\omega, a)|^{p-1} \geq 0$ on S_{ε} , we can apply the maximum principle and find that $y_{\min} \notin (-\pi, \pi)$, that is, $y_{\min} = \pi$ or $-\pi$. However, by the Hopf lemma and $\partial_y v_{1,a}(\pi) = \partial_y v_{1,a}(-\pi) = 0$, we can also find that $y_{\min} \neq \pm \pi$, which is absurd. Therefore, $v_{1,a} \geq 0$ for all $(x, y) \in S_{\varepsilon}$. Similarly, we can prove that $v_{2,a} \geq 0$ on S_{ε} . Thus, we have completed the proof.

3.2 Exponential decay of the derivatives of $\varphi(\omega, a)$

In this subsection, we give a proof of Proposition 3.2. To this end, for $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$ and a given function G on $\mathbb{R} \times \mathbb{T}$, we consider the following equation:

$$\mathbf{L}_{+}(\omega, a)v = G \qquad \text{in } \mathbb{R} \times \mathbb{T}.$$
(3.28)

By a standard Fourier analysis (see also Theorem 6.23 of [5]), we may write (3.28) as

$$v(x,y) = C \int_{\mathbb{R}_z} \sum_{m \in \mathbb{Z}} e^{imy} \int_{\mathbb{R}} \frac{e^{i\xi(x-z)}}{\xi^2 + m^2 + \omega} \int_{\mathbb{T}_w} e^{-imw} \left\{ p |\varphi(\omega, a, z, w)|^{p-1} v(z, w) + G(z, w) \right\} dz d\xi dw$$

$$(3.29)$$

where C is some constant. A key in proving Proposition 3.2 is the following:

Proposition 3.4. Assume p > 1. Let $\varepsilon_1 > 0$ be the constant given in Proposition 3.1, $0 < \varepsilon < \varepsilon_1$, and let a_{ε} denote the same constant as in Proposition 3.1. Furthermore, let $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$, v be a solution to (3.28), A > 0, B > 0 and $0 < \alpha < \sqrt{\omega}$. Assume that the function G on the right-hand side of (3.28) obeys that

$$|G(x,y)| \le Ae^{-\alpha|x|} \quad for \ all \ (x,y) \in \mathbb{R} \times \mathbb{T}.$$
(3.30)

Furthermore, assume that

$$\|v\|_{L^{\infty}(\mathbb{R}\times\mathbb{T})} \le B. \tag{3.31}$$

Then, the following holds:

$$|v(x,y)| \le C_{\varepsilon} e^{-(\alpha-\varepsilon)|x|} \qquad for \ all \ (x,y) \in \mathbb{R} \times \mathbb{T},$$
(3.32)

where the implicit constant depends only on p, A, B, α and ε .

Proof of Proposition 3.4. By (3.29), we see that

$$|v(x,y)| \sim \Big| \int_{\mathbb{R}_z} \sum_{m \in \mathbb{Z}} e^{imy} \frac{e^{-\sqrt{m^2 + \omega} |x-z|}}{\sqrt{m^2 + \omega}} \int_{\mathbb{T}_w} e^{-imw} \Big\{ p |\varphi(\omega, a, z, w)|^{p-1} v(z, w) + G(z, w) \Big\} \Big|.$$

$$(3.33)$$

Put

$$\nu_m := \sqrt{m^2 + \omega}.\tag{3.34}$$

Then, by (3.33), (3.1) and the assumptions (3.30) and (3.31), we see that

$$|v(x,y)| \lesssim B \int_{\mathbb{R}} \sum_{m \in \mathbb{Z}} \frac{e^{-\nu_m |x-z|}}{\nu_m} e^{-(p-1)(\sqrt{\omega}-\varepsilon)|z|} dz + A \int_{\mathbb{R}} \sum_{m \in \mathbb{Z}} \frac{e^{-\nu_m |x-z|}}{\nu_m} e^{-\alpha |z|} dz, \quad (3.35)$$

where the implicit constant depends only on p.

Consider the second term on the right-hand side of (3.35). Let $x \in \mathbb{R}$. Then, for any $m \in \mathbb{Z} \setminus \{0\}$, a direct computation together with $0 < \alpha < \sqrt{\omega} \leq \nu_m$ and $\omega < \omega_p$ shows that

$$\int_{\mathbb{R}} e^{-\nu_m |x-z|} e^{-\alpha |z|} dz \le \int_{\mathbb{R}} e^{-(\nu_m - \alpha)|x-z|} e^{-\alpha (|x-z|+|x|)} dz \le \frac{2e^{-\alpha |x|}}{\nu_m - \alpha} \le \frac{e^{-\alpha |x|}}{m}.$$
 (3.36)

where the implicit constant depends only on p. Thus, by (3.36) and $\omega > \omega_p - \delta_0$, we see that

$$\int_{\mathbb{R}} \sum_{m \in \mathbb{Z}} \frac{e^{-\nu_m |x-z|}}{\nu_m} e^{-\alpha |z|} dz \lesssim \sum_{m \in \mathbb{Z} \setminus \{0\}} \frac{1}{m^2} e^{-\alpha |x|} + \frac{1}{\sqrt{\omega}(\sqrt{\omega} - \alpha)} e^{-\alpha |x|} \lesssim e^{-\alpha |x|}, \quad (3.37)$$

where the implicit constants depend only on p and α .

Consider the first term on the right-hand side of (3.35). Then, a computation similar to (3.36) together with $\omega \geq \omega_p - \delta_0$ shows that

$$\int_{\mathbb{R}} \sum_{m \in \mathbb{Z}} \frac{e^{-\nu_m |x-z|}}{\nu_m} e^{-(p-1)(\sqrt{\omega}-\varepsilon)|z|} dz$$

$$\lesssim \sum_{m \in \mathbb{Z} \setminus \{0\}} \frac{1}{m^2} e^{-\min\{1, (p-1)\}(\sqrt{\omega}-\varepsilon)|x|} + e^{-\min\{1, (p-1)\}(\sqrt{\omega}-\varepsilon)|x|}$$

$$\lesssim e^{-\min\{1, (p-1)\}(\sqrt{\omega}-\varepsilon)|x|},$$
(3.38)

where the implicit constants depend only on p and ε . Putting (3.35), (3.37) and (3.38) together, we find that

$$|v(x,y)| \lesssim Be^{-\min\{1, (p-1)\}(\sqrt{\omega}-\varepsilon)|x|} + Ae^{-(\alpha-\varepsilon)|x|}, \qquad (3.39)$$

where the implicit constant depends only on p, α and ε .

When min{1, (p-1)}($\sqrt{\omega}-\varepsilon$) $\leq \alpha-\varepsilon$, (3.39) implies the desired estimate (3.32). On the other hand, when min{1, (p-1)}($\sqrt{\omega}-\varepsilon$) $> \alpha-\varepsilon$, using (3.39) in the computation (3.33)–(3.35) instead of the assumption (3.31), we can verify that

$$|v(x,y)| \lesssim \max\left\{ e^{-\min\{1, 2(p-1)\}(\sqrt{\omega}-\varepsilon)|x|}, e^{-(\alpha-\varepsilon)|x|} \right\},$$
(3.40)

where the implicit constant depends only on p, A, B, α and ε . Updating the bound of |v| in (3.33)–(3.35) one after another, we see that for any integer $k \ge 1$,

$$|v(x,y)| \lesssim \max\left\{ e^{-\min\{1, k(p-1)\}(\sqrt{\omega}-\varepsilon)|x|}, e^{-(\alpha-\varepsilon)|x|} \right\},$$
(3.41)

where the implicit constant depends only on $p, A, B, \alpha, \varepsilon$ and k. This implies (3.32).

Now, we are in a position to prove Proposition 3.2.

Proof of Proposition 3.2. Note that $\partial_{\omega}\varphi(\omega, a)$ and $\partial_{a}\varphi(\omega, a)$ satisfy

$$\mathbf{L}_{+}(\omega, a)\partial_{\omega}\varphi(\omega, a) = -\varphi(\omega, a) + \widehat{E}(\omega, a), \qquad \mathbf{L}_{+}(\omega, a)\partial_{a}\varphi(\omega, a) = \widetilde{E}(\omega, a),$$

where

$$\widehat{E}(\omega, a) := \langle \mathbf{L}_{+}(\omega, a) \partial_{\omega} \varphi(\omega, a) + \varphi(\omega, a), \ \psi_{\omega_{p}} \cos y \rangle \psi_{\omega_{p}} \cos y,$$
$$\widetilde{E}(\omega, a) := \langle \mathbf{L}_{+}(\omega, a) \partial_{a} \varphi(\omega, a), \psi_{\omega_{p}} \cos y \rangle \psi_{\omega_{p}} \cos y.$$

Then, by Proposition 3.1, (2.2), Lemma 2.1 and (2.15), we see that $\varphi(\omega, a)$, $\widehat{E}(\omega, a)$ and $\widetilde{E}(\omega, a)$ have exponential decay with respect to x:

$$|\varphi(\omega,a)| \lesssim e^{-(\sqrt{\omega}-\varepsilon)|x|}, \quad |\widehat{E}(\omega,a)| + |\widetilde{E}(\omega,a)| \lesssim e^{-\frac{p+1}{2}\sqrt{\omega}|x|} \lesssim e^{-(\sqrt{\omega}-\varepsilon)|x|}, \quad (3.42)$$

where the implicit constants depend only on p and ε . Applying Proposition 3.4 as $G = -\varphi(\omega, a) + \widehat{E}(\omega, a)$ and $G = \widetilde{E}(\omega, a)$, we find that Proposition 3.2 is true.

4 Computation of derivatives

The aim of this section is to compute the second and third derivatives of $\varphi(\omega, a)$ and $\mathcal{F}_{\parallel}(\omega, a)$ with respect to a and ω , which are used in the application of the Crandall-Rabinowitz argument [3] (see Section 5). Note that when 1 , even twice differentiability is not obvious, as the nonlinearity of (1.1) is not twice differentiable.

Throughout this section, let $a_0 > 0$ and $\delta_0 > 0$ be the constants given in Lemma 2.1, and let $\varepsilon_1 > 0$ be the constant given in Proposition 3.1. Furthermore, for $0 < \varepsilon < \varepsilon_1$, we use a_{ε} to denote the same constant as in Proposition 3.1. We will assume that δ_0 and ε_1 are sufficiently small dependently only on p without any notice.

Recall from Proposition 3.2 that if p > 1 and $0 < \varepsilon < \varepsilon_1$, then the following holds for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$ and $(x, y) \in \mathbb{R} \times \mathbb{T}$:

$$\left|\partial_a \varphi(\omega, a, x, y)\right| + \left|\partial_\omega \varphi(\omega, a, x, y)\right| \lesssim e^{-\sqrt{\omega}|x| + 2\varepsilon|x|},\tag{4.1}$$

where the implicit constant depends only on p and ε .

We introduce symbols which are used in this and the next sections:

Notation.

1. For p > 1, $k \ge 1$ and $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$, we define $V_k(\omega, a)$ as

$$V_k(\omega, a) := \frac{d^k x^p}{dx^k} \Big|_{x=\varphi(\omega, a)} = p(p-1)\cdots(p-k+1)\varphi(\omega, a)^{p-k}.$$
 (4.2)

Note that

$$\mathbf{L}_{+}(\omega, a) = -\partial_{x}^{2} - \partial_{y}^{2} + \omega - V_{1}(\omega, a).$$
(4.3)

Since $\varphi(\omega, a)$ is positive (see Proposition 3.1) and of class C^1 on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$ in the $H^2(\mathbb{R} \times \mathbb{T})$ -topology (see Lemma 2.1 and (2.12)), the following holds:

$$\partial V_k(\omega, a) = V_{k+1}(\omega, a) \partial \varphi(\omega, a)$$
 everywhere in $\mathbb{R} \times \mathbb{T}$, (4.4)

where ∂ denotes either ∂_a or ∂_ω . Furthermore, Proposition 3.1 shows that if $0 < \varepsilon < \varepsilon_1$ and $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$, then

where the implicit constants depend only on p, ε and k.

We have to pay attention to the difference between $\mathbf{T}(\omega, a)$ and $P_{\perp}\mathbf{L}_{+}(\omega, a)$; In particular, $\mathbf{T}(\omega, a)$ has the inverse, but $P_{\perp}\mathbf{L}_{+}(\omega, a)$ does not.

4.1 Basic results

It is easy to verify that for any $(\omega_1, a_1), (\omega_2, a_2) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0),$

Furthermore, it is known that for any p > 1 and $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$,

$$\|\mathbf{T}(\omega, a)^{-1}\|_{L^2(\mathbb{R}\times\mathbb{T})\to H^2(\mathbb{R}\times\mathbb{T})} \lesssim 1,$$
(4.9)

where the implicit constant depends only on p, which together with the linearity implies the continuity, namely if $\lim_{n\to\infty} f_n = f$ in $L^2(\mathbb{R} \times \mathbb{T})$, then

$$\lim_{n \to \infty} \mathbf{T}(\omega, a)^{-1} f_n = \mathbf{T}(\omega, a)^{-1} f \quad \text{in } H^2(\mathbb{R} \times \mathbb{T}).$$

By the boundedness of P_{\perp} in $L^2(\mathbb{R} \times \mathbb{T})$, the continuity of $\varphi(\omega, a)$ with respect to (ω, a) (see Lemma 2.1 and (2.12)), and (4.7) through (4.9), we can obtain the following lemma:

$$\lim_{(\gamma_1,\gamma_2)\to(0,0)} \|\mathbf{T}(\omega+\gamma_1,a+\gamma_2)^{-1} - \mathbf{T}(\omega,a)^{-1}\|_{L^2_{x,y}(\mathbb{R}\times\mathbb{T})\to H^2(\mathbb{R}\times\mathbb{T})} = 0.$$

It is easy to verify that the following lemma holds:

Lemma 4.2. If $f: (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0) \to L^2(\mathbb{R} \times \mathbb{T})$ has the partial derivatives in $L^2(\mathbb{R} \times \mathbb{T})$ $(\partial_a f(\omega, a), \partial_\omega f(\omega, a) \in L^2(\mathbb{R} \times \mathbb{T}))$, then,

$$\partial_a \langle f(\omega, a), \psi_{\omega_p} \cos y \rangle = \langle \partial_a f(\omega, a), \psi_{\omega_p} \cos y \rangle,$$
$$\partial_\omega \langle f(\omega, a), \psi_{\omega_p} \cos y \rangle = \langle \partial_\omega f(\omega, a), \psi_{\omega_p} \cos y \rangle.$$

In particular, the following holds in $L^2(\mathbb{R} \times \mathbb{T})$:

$$\begin{split} \partial_a \{ P_\perp f(\omega, a) \} &= P_\perp \partial_a f(\omega, a), \\ \partial_\omega \{ P_\perp f(\omega, a) \} &= P_\perp \partial_\omega f(\omega, a). \end{split}$$

Since $-\partial_x^2 - \partial_y^2 \colon H^2(\mathbb{R} \times \mathbb{T}) \to L^2(\mathbb{R} \times \mathbb{T})$ is bounded (hence continuous), it is easy to verify that the following lemma holds:

Lemma 4.3. Let $f: (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0) \to H^2(\mathbb{R} \times \mathbb{T})$ has the partial derivatives in $H^2(\mathbb{R} \times \mathbb{T})$ $(\partial_a f(\omega, a), \partial_\omega f(\omega, a) \in H^2(\mathbb{R} \times \mathbb{T}))$, then, the following hold in $L^2(\mathbb{R} \times \mathbb{T})$ for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0)$:

It remains to consider the second term on the right-hand side of (4.21). By the continuity of $\mathbf{T}(\omega, a)^{-1} \colon L^2(\mathbb{R} \times \mathbb{T}) \to H^2(\mathbb{R} \times \mathbb{T})$ (see (4.10)) and the differentiability of $f(\omega, a)$, we see that

4.2 Second derivatives of $\varphi(\omega, a)$

In this section, we compute the second derivatives of $\varphi(\omega, a)$ with respect to ω and a. We emphasize that when $1 , the twice differentiability of <math>\varphi(\omega, a)$ is not obvious, as the nonlinearity of the equation (1.1) is not C^2 .

Recall that $\eta: (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0) \to X_2$ is C^1 and $P_\perp \mathcal{F}(\omega, \varphi(\omega, a)) = 0$ (see Lemma 2.1). Observe from a direct computation that the following holds in $L^2(\mathbb{R} \times \mathbb{T})$:

$$\partial_a \{ V_0(\omega, a) \} = p\varphi(\omega, a)^{p-1} \partial_a \varphi(\omega, a) = V_1(\omega, a) \{ \psi_{\omega_p} \cos y + \partial_a h(\omega, a) \},$$
(4.28)

$$\partial_{\omega}\{V_0(\omega,a)\} = p\varphi(\omega,a)^{p-1}\partial_{\omega}\varphi(\omega,a) = V_1(\omega,a)\partial_{\omega}h(\omega,a).$$
(4.29)

Note that Lemma 2.1 shows that

$$\partial_{\omega}\varphi(\omega,a) = -\mathbf{T}(\omega,a)^{-1} \{R_{\omega_p} + \eta(\omega,a)\},\tag{4.30}$$

$$\partial_a \varphi(\omega, a) = \psi_{\omega_p} \cos y - \mathbf{T}(\omega, a)^{-1} P_\perp \mathbf{L}_+(\omega, a) \psi_{\omega_p} \cos y.$$
(4.31)

In order to prove the continuity of the second and higher derivatives of $\varphi(\omega, a)$ in $H^2(\mathbb{R} \times \mathbb{T})$, we prepare the following lemma:

Lemma 4.8. Assume p > 1 and let k, j be integers satisfying k > p and $j \ge 1$. Then, there exists $0 < \varepsilon(k, j) < \varepsilon_1$ depending only on p, k, and j with the following property: Let $0 < \varepsilon < \varepsilon(k, j)$, and let g be a function in $C((\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon}), L^2(\mathbb{R} \times \mathbb{T}))$. Assume that for any $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$ and $(x, y) \in \mathbb{R} \times \mathbb{T}$:

$$|g(\omega, a, x, y)| \lesssim e^{-k\sqrt{\omega}|x| + j\varepsilon|x|},\tag{4.32}$$

where the implicit constant depends only on p, k, j and ε . Furthermore, assume that

$$\lim_{(\gamma_1,\gamma_2)\to(0,0)} \|e^{(k-1)\sqrt{\omega}|x|+k\varepsilon|x|} \{g(\omega+\gamma_1,a+\gamma_2) - g(\omega,a)\}\|_{L^2(\mathbb{R}\times\mathbb{T})} = 0.$$
(4.33)

Then, $\mathbf{T}(\omega, a)^{-1} P_{\perp} \{ V_k(\omega, a) g(\omega, a) \}$ is continuous with respect to (ω, a) on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$ in the $H^2(\mathbb{R} \times \mathbb{T})$ -topology.

Proof of Lemma 4.8. Let $0 < \varepsilon < \varepsilon_1$, $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_\varepsilon, a_\varepsilon)$, and let $(\gamma_1, \gamma_2) \in \mathbb{R}^2$. We will assume $\sqrt{\omega} > \frac{1}{2}\sqrt{\omega_p}$ and ε being sufficiently small dependently only on p, k, and j, without any notice. Furthermore, we will take $(\gamma_1, \gamma_2) \to (0, 0)$, so that we may assume that

$$(\omega + \gamma_1, a + \gamma_2) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_\varepsilon, a_\varepsilon), \tag{4.34}$$

$$\sqrt{\omega} - \varepsilon \le \sqrt{\omega - |\gamma_1|} \le \sqrt{\omega} + |\gamma_1| \le \sqrt{\omega} + \varepsilon.$$
(4.35)

First, we shall show that

$$\lim_{(\gamma_1,\gamma_2)\to(0,0)} \left\| V_k(\omega+\gamma_1,a+\gamma_2)g(\omega+\gamma_1,a+\gamma_2) - V_k(\omega,a)g(\omega,a) \right\|_{L^2(\mathbb{R}\times\mathbb{T})} = 0.$$
(4.36)

Observe that

$$\begin{aligned} \left\| V_k(\omega + \gamma_1, a + \gamma_2) g(\omega + \gamma_1, a + \gamma_2) - V_k(\omega, a) g(\omega, a) \right\|_{L^2(\mathbb{R} \times \mathbb{T})} \\ &\leq \left\| \left\{ V_k(\omega + \gamma_1, a + \gamma_2) - V_k(\omega, a) \right\} g(\omega + \gamma_1, a + \gamma_2) \right\|_{L^2(\mathbb{R} \times \mathbb{T})} \\ &+ \left\| V_k(\omega, a) \left\{ g(\omega + \gamma_1, a + \gamma_2) - g(\omega, a) \right\} \right\|_{L^2(\mathbb{R} \times \mathbb{T})}. \end{aligned}$$

$$(4.37)$$

Consider the first term on the right-hand side of (4.37). By the fundamental theorem of calculus, (4.4), (4.32), (4.5), (4.1), (4.35) and p > 1, the following holds everywhere in $\mathbb{R} \times \mathbb{T}$:

$$\begin{split} \left| \left\{ V_{k}(\omega + \gamma_{1}, a + \gamma_{2}) - V_{k}(\omega, a) \right\} g(\omega + \gamma_{1}, a + \gamma_{2}) \right| \\ \lesssim \left| V_{k}(\omega + \gamma_{1}, a + \gamma_{2}) - V_{k}(\omega, a + \gamma_{2}) \right| e^{-k\sqrt{\omega - |\gamma_{1}||x| + j\varepsilon|x|}} \\ + \left| V_{k}(\omega, a + \gamma_{2}) - V_{k}(\omega, a) \right| e^{-k\sqrt{\omega - |\gamma_{1}||x| + j\varepsilon|x|}} \\ \lesssim \left| \gamma_{1} \right| \int_{0}^{1} \left| V_{k+1}(\omega + \theta\gamma_{1}, a + \gamma_{2}) \right| \left| \partial_{\omega}\varphi(\omega + \theta\gamma_{1}, a + \gamma_{2}) \right| d\theta e^{-k\sqrt{\omega - |\gamma_{1}||x| + j\varepsilon|x|}} \\ + \left| \gamma_{2} \right| \int_{0}^{1} \left| V_{k+1}(\omega, a + \theta\gamma_{2}) \right| \left| \partial_{a}\varphi(\omega, a + \theta\gamma_{2}) \right| d\theta e^{-k\sqrt{\omega - |\gamma_{1}||x| + j\varepsilon|x|}} \\ \lesssim \left(|\gamma_{1}| + |\gamma_{2}|) e^{-\frac{p}{2}\sqrt{\omega_{p}}|x| + (3k+j+5-2p)\varepsilon|x|} \lesssim \left(|\gamma_{1}| + |\gamma_{2}|) e^{-\frac{p}{4}\sqrt{\omega_{p}}|x|}, \end{split}$$

$$(4.38)$$

where the implicit constants depend only on p, k, j and ε . Thus, we find that

$$\lim_{(\gamma_1,\gamma_2)\to(0,0)} \|\{V_k(\omega+\gamma_1,a+\gamma_2)-V_k(\omega,a)\}g(\omega+\gamma_1,a+\gamma_2)\|_{L^2(\mathbb{R}\times\mathbb{T})} = 0.$$
(4.39)

Move on to the second term on the right-hand side of (4.37). By (4.5) and p > 1, we see that

$$\left| V_k(\omega, a) e^{-(k-1)\sqrt{\omega}|x| - k\varepsilon|x|} \right| \lesssim e^{\frac{-(p-1)}{2}\sqrt{\omega_p}|x|}, \tag{4.40}$$

where the implicit constant depends only on p, k, j and ε . Then, by (4.40) and (4.33), we see that

$$\lim_{(\gamma_1,\gamma_2)\to(0,0)} \|V_k(\omega,a)\{g(\omega+\gamma_1,a+\gamma_2)-g(\omega,a)\}\|_{L^2(\mathbb{R}\times\mathbb{T})} = 0.$$
(4.41)

Putting (4.37), (4.39) and (4.41) together, we find that (4.36) holds.

We shall finish the proof of the lemma.

Observe from (4.5), (4.32), p > 1 and (4.35) that

$$\|V_{k}(\omega+\gamma_{1},a+\gamma_{2})g(\omega+\gamma_{1},a+\gamma_{2})\|_{L^{2}(\mathbb{R}\times\mathbb{T})}$$

$$\lesssim \|e^{\frac{-p}{2}\sqrt{\omega_{p}}|x|+(3k-2p)\varepsilon|x|}\|_{L^{2}(\mathbb{R}\times\mathbb{T})} \le \|e^{\frac{-p}{4}\sqrt{\omega_{p}}|x|}\|_{L^{2}(\mathbb{R}\times\mathbb{T})} \lesssim 1,$$
(4.42)

where the implicit constants depend only on p, k, j and ε . Then, by (4.42), Lemma 4.1, (4.9) and (4.36), we can prove the continuity of $\mathbf{T}(\omega, a)^{-1}P_{\perp}\{V_k(\omega, a)g(\omega, a)\}$ on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$ in the $H^2(\mathbb{R} \times \mathbb{T})$ -topology.

Next, we give the second derivatives of $\varphi(\omega, a)$:

Proposition 4.9. Assume p > 1. Then, there exists $0 < \varepsilon_2 < \varepsilon_1$ depending only on p such that if $0 < \varepsilon < \varepsilon_2$, then φ is C^2 on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$ in the $H^2(\mathbb{R} \times \mathbb{T})$ -topology; and the following hold for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$:

$$\partial_a^2 \varphi(\omega, a) = \mathbf{T}(\omega, a)^{-1} P_{\perp} \big(V_2(\omega, a) \{ \partial_a \varphi(\omega, a) \}^2 \big), \tag{4.43}$$

$$\partial_{\omega}^{2}\varphi(\omega,a) = \mathbf{T}(\omega,a)^{-1}P_{\perp}\big(V_{2}(\omega,a)\{\partial_{\omega}\varphi(\omega,a)\}^{2} - \partial_{\omega}\varphi(\omega,a)\big), \qquad (4.44)$$

$$\partial_{\omega}\partial_{a}\varphi(\omega,a) = \partial_{a}\partial_{\omega}\varphi(\omega,a) \tag{4.45}$$

$$= \mathbf{T}(\omega, a)^{-1} P_{\perp} \big(V_2(\omega, a) \partial_{\omega} \varphi(\omega, a) \partial_a \varphi(\omega, a) - \partial_a \varphi(\omega, a) \big).$$

Remark 4.2. Since $\mathbf{T}(\omega, a)^{-1}$ maps Y_2 to X_2 , Proposition 4.9 shows that

$$\partial_a^2 \varphi(\omega, a), \ \partial_\omega \partial_a \varphi(\omega, a), \ \partial_a \partial_\omega \varphi(\omega, a), \ \partial_\omega^2 \varphi(\omega, a) \in X_2.$$

Proof of Proposition 4.9. We shall prove (4.43) . By Lemmas 4.2 and 4.6, the following holds in $L^2(\mathbb{R} \times \mathbb{T})$:

$$\partial_a \big(P_\perp \mathbf{L}_+(\omega, a) \{ \psi_{\omega_p} \cos y \} \big) = -P_\perp \Big(V_2(\omega, a) \partial_a \varphi(\omega, a) \psi_{\omega_p} \cos y \Big), \tag{4.46}$$

$$\partial_{\omega} \left(P_{\perp} \mathbf{L}_{+}(\omega, a) \{ \psi_{\omega_{p}} \cos y \} \right) = P_{\perp} \{ \psi_{\omega_{p}} \cos y \} - P_{\perp} \left(V_{2}(\omega, a) \partial_{\omega} \varphi(\omega, a) \psi_{\omega_{p}} \cos y \right).$$
(4.47)

Furthermore, by (4.31), Lemma 4.7 and (4.46), the following holds in $H^2(\mathbb{R} \times \mathbb{T})$:

$$\partial_a^2 \varphi(\omega, a) = -\partial_a \Big(\mathbf{T}(\omega, a)^{-1} P_\perp \mathbf{L}_+(\omega, a) \{ \psi_{\omega_p} \cos y \} \Big)$$

= $-\mathbf{T}(\omega, a)^{-1} \partial_a \Big(P_\perp \mathbf{L}_+(\omega, a) \{ \psi_{\omega_p} \cos y \} \Big)$
 $- \mathbf{T}(\omega, a)^{-1} P_\perp \Big(V_2(\omega, a) \partial_a \varphi(\omega, a) \mathbf{T}(\omega, a)^{-1} P_\perp \mathbf{L}_+(\omega, a) \{ \psi_{\omega_p} \cos y \} \Big)$
= $\mathbf{T}(\omega, a)^{-1} P_\perp \Big(V_2(\omega, a) \partial_a \varphi(\omega, a) \Big\{ \psi_{\omega_p} \cos y - \mathbf{T}(\omega, a)^{-1} P_\perp \mathbf{L}_+(\omega, a) \{ \psi_{\omega_p} \cos y \} \Big\} \Big).$
(4.48)

Plugging (4.31) into the right-hand side of (4.48), we obtain (4.43). Similarly, we can prove (4.45) and (4.44).

It remains to prove the continuity of the second derivatives. When $2 \leq p$, we see from the implicit function theorem that $\varphi(\omega, a)$ is C^2 with respect to a and ω . Hence, we may assume that 2 > p. Observe from (4.1) that

$$\left| \{ \partial_a \varphi(\omega, a, x, y) \}^2 \right| \lesssim e^{-2\sqrt{\omega}|x| + 4\varepsilon |x|}, \tag{4.49}$$

where the implicit constant depends only on p and ε . Furthermore, by (4.1), the embedding $H^2(\mathbb{R} \times \mathbb{T}) \hookrightarrow L^{\infty}(\mathbb{R} \times \mathbb{T})$, and the continuity of $\partial_a \varphi(\omega, a)$ in $H^2(\mathbb{R} \times \mathbb{T})$, we see that

$$\begin{aligned} \|e^{\sqrt{\omega}|x|+2\varepsilon|x|} \Big\{ (\partial_a \varphi(\omega+\gamma_1,a+\gamma_2))^2 - (\partial_a \varphi(\omega,a,x,y))^2 \Big\} \|_{L^2(\mathbb{R}\times\mathbb{T})} \\ &\leq \|e^{\sqrt{\omega}|x|+2\varepsilon|x|} e^{-\frac{3}{2}(\sqrt{\omega-|\gamma_1|}+2\varepsilon)|x|} \|_{L^2(\mathbb{R}\times\mathbb{T})} \|\varphi(\omega+\gamma_1,a+\gamma_2) - \partial_a \varphi(\omega,a,x,y)\|_{L^\infty(\mathbb{R}\times\mathbb{T})}^{\frac{1}{2}} \\ &\to 0 \quad \text{as } (\gamma_1,\gamma_2) \to (0,0). \end{aligned}$$

$$(4.50)$$

Then, by (4.43), (4.49) and (4.50), we find that Lemma 4.8 can apply to $\partial_a^2 \varphi(\omega, a)$ as $k = 2, j = 4, g(\omega, a) = \{\partial_a \varphi(\omega, a)\}^2$. Thus, we see that $\partial_a^2 \varphi(\omega, a)$ is continuous with respect to (ω, a) in the $H^2(\mathbb{R} \times \mathbb{T})$ -topology. Similarly, we can prove the continuity of the other partial derivatives.

We state decay properties of the derivatives of $\varphi(\omega, a)$:

Lemma 4.10. Let p > 1. Then, there exists $\tilde{\varepsilon}_2 > 0$ depending only on p such that for any $0 < \varepsilon < \tilde{\varepsilon}_2$ and $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$, the following holds:

$$\left|\partial_a^2\varphi(\omega,a,x,y)\right| + \left|\partial_\omega\partial_a\varphi(\omega,a,x,y)\right| + \left|\partial_\omega^2\varphi(\omega,a,x,y)\right| \lesssim e^{-\{\sqrt{\omega}-3\varepsilon\}|x|},\tag{4.51}$$

where the implicit constants depend only on p and ε .

Proof. We may write (4.43) through (4.44) in Proposition 4.9 as follows:

$$\mathbf{L}_{+}(\omega, a)\partial_{a}^{2}\varphi(\omega, a) = V_{2}(\omega, a)\{\partial_{a}\varphi(\omega, a)\}^{2}, \qquad (4.52)$$

$$\mathbf{L}_{+}(\omega, a)\partial_{\omega}\partial_{a}\varphi(\omega, a) = V_{2}(\omega, a)\partial_{\omega}\varphi(\omega, a)\partial_{a}\varphi(\omega, a) - \partial_{a}\varphi(\omega, a), \qquad (4.53)$$

$$\mathbf{L}_{+}(\omega, a)\partial_{\omega}^{2}\varphi(\omega, a) = V_{2}(\omega, a)\{\partial_{\omega}\varphi(\omega, a)\}^{2} - \partial_{\omega}\varphi(\omega, a).$$
(4.54)

Observe from (4.5) and (4.1) that if ε is sufficiently small depending only on p, then

$$|V_{2}(\omega, a)\{\partial_{a}\varphi(\omega, a)\}^{2}| \lesssim e^{-\{\sqrt{\omega}-2\varepsilon\}|x|},$$
$$|V_{2}(\omega, a)\partial_{\omega}\varphi(\omega, a)\partial_{a}\varphi(\omega, a)| + |\partial_{a}\varphi(\omega, a)| \lesssim e^{-\{\sqrt{\omega}-2\varepsilon\}|x|},$$
$$|V_{2}(\omega, a)\{\partial_{\omega}\varphi(\omega, a)\}^{2}| + |\partial_{\omega}\varphi(\omega, a)| \lesssim e^{-\{\sqrt{\omega}-2\varepsilon\}|x|},$$

where the implicit constants depend only on p and ε . Then, applying Proposition 3.4 to (4.52) through (4.54) as $\alpha = \sqrt{\omega} - 2\varepsilon$, we obtain (4.51).

4.3 Third derivatives of $\varphi(\omega, a)$

In this section, we find the third derivatives of $\varphi(\omega, a)$ with respect to ω and a.

Let us begin with a generalization of Lemma 4.4:

Lemma 4.11. Assume p > 1, and let k, j be integers satisfying k > p and $j \ge 1$. Then, there exists $\varepsilon(k, j) > 0$ depending only on p, k, and j with the following property: Let $0 < \varepsilon < \varepsilon(k, j)$, and let $g \in C^1((\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_\varepsilon, a_\varepsilon), L^\infty(\mathbb{R} \times \mathbb{T}))$. Furthermore, assume that the following hold for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_\varepsilon, a_\varepsilon)$ and $(x, y) \in \mathbb{R} \times \mathbb{T}$:

$$|g(\omega, a, x, y)| \lesssim e^{-k\sqrt{\omega}|x| + j\varepsilon|x|},\tag{4.55}$$

$$\left|\partial_{\omega}g(\omega, a, x, y)\right| + \left|\partial_{a}g(\omega, a, x, y)\right| \lesssim e^{-k\sqrt{\omega}|x| + (j+2)\varepsilon|x|},\tag{4.56}$$

where the implicit constant depends only on p, j and ε . Then, the following holds in the $L^2(\mathbb{R} \times \mathbb{T})$ -topology for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$:

$$\partial \{V_k(\omega, a)g(\omega, a)\} = V_{k+1}(\omega, a)\partial\varphi(\omega, a)g(\omega, a) + V_k(\omega, a)\partial g(\omega, a),$$

where ∂ denotes either ∂_a or ∂_{ω} .

We omit the proof of Lemma 4.11 as the lemma can be proven in a way similar to Lemma 4.4.

Now, we give the third derivatives of $\varphi(\omega, a)$:

Proposition 4.12. Assume p > 1 and let ε_2 be the constant give in Proposition 4.9. Then, there exists $0 < \varepsilon_3 < \varepsilon_2$ depending only on p such that if $0 < \varepsilon < \varepsilon_3$, then φ is of class C^3 on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$ in the $H^2(\mathbb{R} \times \mathbb{T})$ -topology; and the following hold for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$:

$$\partial_{a}^{3}\varphi(\omega,a) = \mathbf{T}(\omega,a)^{-1}P_{\perp}\left(V_{3}(\omega,a)\{\partial_{a}\varphi(\omega,a)\}^{3}\right)$$

$$+ 3\mathbf{T}(\omega,a)^{-1}P_{\perp}\left(V_{2}(\omega,a)\partial_{a}\varphi(\omega,a)\partial_{a}^{2}\varphi(\omega,a)\right),$$

$$\partial_{a}^{2}\partial_{\omega}\varphi(\omega,a) = \partial_{a}\partial_{\omega}\partial_{a}\varphi = \partial_{\omega}\partial_{a}^{2}\varphi$$

$$= \mathbf{T}(\omega,a)^{-1}P_{\perp}\left(V_{3}(\omega,a)\partial_{\omega}\varphi(\omega,a)\{\partial_{a}\varphi(\omega,a)\}^{2}\right)$$

$$+ 2\mathbf{T}(\omega,a)^{-1}P_{\perp}\left(V_{2}(\omega,a)\partial_{a}\varphi(\omega,a)\partial_{a}\partial_{\omega}\varphi(\omega,a)\right)$$

$$+ \mathbf{T}(\omega,a)^{-1}P_{\perp}\left(V_{2}(\omega,a)\partial_{a}^{2}\varphi(\omega,a)\partial_{\omega}\varphi(\omega,a)\right)$$

$$- \mathbf{T}(\omega,a)^{-1}P_{\perp}\partial_{a}^{2}\varphi(\omega,a),$$

$$(4.57)$$

$$\partial_{a}\partial_{\omega}^{2}\varphi(\omega,a) = \partial_{\omega}\partial_{a}\partial_{\omega}\varphi = \partial_{\omega}^{2}\partial_{a}\varphi$$

$$= \mathbf{T}(\omega,a)^{-1}P_{\perp} \Big(V_{3}(\omega,a)\partial_{\omega}\varphi(\omega,a)\{\partial_{a}\varphi(\omega,a)\}^{2} \Big)$$

$$+ 2\mathbf{T}(\omega,a)^{-1}P_{\perp} \Big(V_{2}(\omega,a)\partial_{a}\varphi(\omega,a)\partial_{a}\partial_{\omega}\varphi(\omega,a) \Big)$$

$$+ \mathbf{T}(\omega,a)^{-1}P_{\perp} \Big(V_{2}(\omega,a)\partial_{a}^{2}\varphi(\omega,a)\partial_{\omega}\varphi(\omega,a) \Big)$$

$$- \mathbf{T}(\omega,a)^{-1}P_{\perp}\partial_{a}^{2}\varphi(\omega,a), \qquad (4.59)$$

$$\partial_{\omega}^{3}\varphi(\omega,a) = \mathbf{T}(\omega,a)^{-1}P_{\perp} \Big(V_{3}(\omega,a) \{\partial_{\omega}\varphi(\omega,a)\}^{3} \Big) + 3\mathbf{T}(\omega,a)^{-1}P_{\perp} \Big(V_{2}(\omega,a)\partial_{\omega}^{2}\varphi(\omega,a)\partial_{\omega}\varphi(\omega,a) \Big) - w\mathbf{T}(\omega,a)^{-1}P_{\perp}\partial_{\omega}^{2}\varphi(\omega,a).$$

$$(4.60)$$

Remark 4.3. Since $\mathbf{T}(\omega, a)^{-1}$ maps Y_2 to X_2 , Proposition 4.12 shows that

$$\partial_a^3 \varphi(\omega, a), \ \partial_a^2 \partial_\omega \varphi(\omega, a), \ \partial_a \partial_\omega^2 \varphi(\omega, a), \ \partial_\omega^3 \varphi(\omega, a) \in X_2.$$

Proof of Proposition 4.12. We shall prove (4.57). By (4.43) in Proposition 4.9, Lemma 4.7 with $f = P_{\perp}(V_2(\omega, a)\{\partial_a \varphi(\omega, a)\}^2)$, Lemma 4.2 and Lemma 4.11 with k = 2, j = 4,

 $g = \{\partial_a \varphi\}^2$, we see that the following holds in $H^2(\mathbb{R} \times \mathbb{T})$:

$$\begin{split} \partial_a^3 \varphi(\omega, a) &= \partial_a \partial_a^2 \varphi(\omega, a) = \partial_a \left\{ \mathbf{T}(\omega, a)^{-1} P_{\perp} \left\{ V_2(\omega, a) \{ \partial_a \varphi(\omega, a) \}^2 \right) \right\} \\ &= \mathbf{T}(\omega, a)^{-1} P_{\perp} \partial_a \left(V_2(\omega, a) \{ \partial_a \varphi(\omega, a) \}^2 \right) \\ &+ \mathbf{T}(\omega, a)^{-1} P_{\perp} \left\{ V_2(\omega, a) \partial_a \varphi(\omega, a) \partial_a^2 \varphi(\omega, a) \right\} \\ &= \mathbf{T}(\omega, a)^{-1} P_{\perp} \left\{ V_3(\omega, a) \{ \partial_a \varphi(\omega, a) \}^3 + 2 V_2(\omega, a) \partial_a \varphi(\omega, a) \partial_a^2 \varphi(\omega, a) \right) \\ &+ \mathbf{T}(\omega, a)^{-1} P_{\perp} \left\{ V_2(\omega, a) \partial_a \varphi(\omega, a) \partial_a^2 \varphi(\omega, a) \right\}. \end{split}$$

Thus, we have proved (4.57). Similarly, we can prove (4.58) through (4.60).

It remains to prove the continuity of the third derivatives of φ . When $3 \leq p$, we see from the implicit function theorem that $\varphi(\omega, a)$ is C^3 with respect to a and ω . Hence, we may assume that p < 3. Then, we shall prove the continuity of $\partial_a^3 \varphi$. Observe from the continuity of $\partial_a \varphi$ and (4.1) that Lemma 4.8 can apply to the first term on the righthand side of (4.57) as k = 3, j = 6, $g(\omega, a) = \{\partial_a \varphi(\omega, a)\}^3$. Moreover, observe from the continuity of $\partial_a \varphi$ and $\partial_a^2 \varphi$, (4.1) and Lemma 4.10 that we can apply Lemma 4.8 to the second term on the right-hand side of (4.57) as k = 2, j = 5, $g = \partial_a \varphi(\omega, a) \partial_a^2 \varphi(\omega, a)$. Thus, we find that $\partial^3 \varphi(\omega, a)$ is continuous with respect to (ω, a) in the $H^2(\mathbb{R} \times \mathbb{T})$ topology. Similarly, we can prove the continuity of the other third order derivatives. \Box

4.4 Derivatives of $\mathcal{F}_{\parallel}(\omega, a)$

In this section, we compute the derivatives of $\mathcal{F}_{\parallel}(\omega, a)$ up to the third order.

$$\partial_{\omega} \mathcal{F}_{\parallel}(\omega, a) = \langle \mathbf{L}_{+}(\omega, a) \partial_{\omega} \varphi(\omega, a), \psi_{\omega_{p}} \cos y \rangle + a.$$
(4.63)

The following result follows from Proposition 4.13, Lemma 4.2, Lemma 4.6 and Proposition 4.9:

Proposition 4.14. Assume p > 1. Let ε_2 be the constant given in Proposition 4.9 and $0 < \varepsilon < \varepsilon_2$. Then, \mathcal{F}_{\parallel} is C^2 on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$, and the following hold for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$:

$$\partial_a^2 \mathcal{F}_{\parallel}(\omega, a) = \langle \mathbf{L}_+(\omega, a) \partial_a^2 \varphi(\omega, a) - V_2(\omega, a) \{ \partial_a \varphi(\omega, a) \}^2, \psi_{\omega_p} \cos y \rangle, \tag{4.64}$$

$$\partial_a \partial_\omega \mathcal{F}_{\parallel}(\omega, a) = \partial_\omega \partial_a \mathcal{F}_{\parallel}(\omega, a) \tag{4.65}$$

$$= 1 + \langle \mathbf{L}_{+}(\omega, a)\partial_{\omega}\partial_{a}\varphi(\omega, a) - V_{2}(\omega, a)\partial_{a}\varphi(\omega, a)\partial_{\omega}\varphi(\omega, a), \psi_{\omega_{p}}\cos y \rangle,$$

$$\partial_{\omega}^{2}\mathcal{F}_{\parallel}(\omega, a) = \langle \mathbf{L}_{+}(\omega, a)\partial_{\omega}^{2}\varphi(\omega, a) - V_{2}(\omega, a)\{\partial_{\omega}\varphi(\omega, a)\}^{2}, \psi_{\omega_{p}}\cos y \rangle.$$
(4.66)

The following result follows from Propositions 4.12 and 4.14, Lemmas 4.2, 4.6 and 4.11:

Proposition 4.15. Assume p > 1. Let ε_3 be the same constant given in Proposition main-lem-3 and $0 < \varepsilon < \varepsilon_3$. Then, \mathcal{F}_{\parallel} is C^3 on $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$, and the following hold for all $(\omega, a) \in (\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_{\varepsilon}, a_{\varepsilon})$:

$$\begin{aligned} \partial_a^3 \mathcal{F}_{\parallel}(\omega, a) & (4.67) \\ &= \langle \mathbf{L}_{+}(\omega, a) \partial_a^3 \varphi(\omega, a) - 3V_2(\omega, a) \partial_a \varphi(\omega, a) \partial_a^2 \varphi(\omega, a) - V_3(\omega, a) \{\partial_a \varphi(\omega, a)\}^3, \psi_{\omega_p} \cos y \rangle, \\ \partial_a^2 \partial_\omega \mathcal{F}_{\parallel}(\omega, a) &= \partial_a \partial_\omega \partial_a \mathcal{F}_{\parallel}(\omega, a) &= \partial_\omega \partial_a^2 \mathcal{F}_{\parallel}(\omega, a) & (4.68) \\ &= \langle \mathbf{L}_{+}(\omega, a) \partial_\omega \partial_a^2 \varphi(\omega, a) - V_2(\omega, a) \partial_\omega \varphi(\omega, a) \partial_a^2 \varphi(\omega, a) \\ &- 2V_2(\omega, a) \partial_a \varphi(\omega, a) \partial_\omega \partial_a \varphi(\omega, a) - V_3(\omega, a) \{\partial_a \varphi(\omega, a)\}^2 \partial_\omega \varphi(\omega, a), \psi_{\omega_p} \cos y \rangle \\ \partial_a \partial_\omega^2 \mathcal{F}_{\parallel}(\omega, a) &= \partial_\omega \partial_a \partial_\omega \mathcal{F}_{\parallel}(\omega, a) &= \partial_\omega^2 \partial_a \mathcal{F}_{\parallel}(\omega, a) & (4.69) \\ &= \langle \mathbf{L}_{+}(\omega, a) \partial_\omega^2 \partial_a \varphi(\omega, a) - V_2(\omega, a) \partial_a \varphi(\omega, a) \partial_\omega^2 \varphi(\omega, a) \\ &- 2V_2(\omega, a) \partial_\omega \varphi(\omega, a) \partial_\omega \partial_a \varphi(\omega, a) - V_3(\omega, a) \{\partial_\omega \varphi(\omega, a)\}^2 \partial_a \varphi(\omega, a), \psi_{\omega_p} \cos y \rangle \\ \partial_\omega^3 \mathcal{F}_{\parallel}(\omega, a) & (4.70) \\ &= \langle \mathbf{L}_{+}(\omega, a) \partial_\omega^3 \varphi(\omega, a) - 3V_2(\omega, a) \partial_\omega \varphi(\omega, a) \partial_\omega^2 \varphi(\omega, a) - V_3(\omega, a) \{\partial_\omega \varphi(\omega, a)\}^3, \psi_{\omega_p} \cos y \rangle. \end{aligned}$$

5 Proof of Theorem 1.1

This section is devoted to the proof of Theorem 1.1. Throughout this section, for a given p > 1, let a_0 , δ_0 and η : $(\omega_p - \delta_0, \omega_p + \delta_0) \times (-a_0, a_0) \to X_2$ be the same as in Lemma 2.1, $\varphi(\omega, a)$ be the function defined by (2.12), and ε_3 be the constant given in Proposition 4.12. Furthermore, for $0 < \varepsilon < \varepsilon_3$, we use a_{ε} to denote the same constant given in Proposition 3.1.

We will emply the argument developed by Crandall and Rabinowitz [3] (see also the proof of Theorem 4 (ii) in [4]). Let $0 < \varepsilon < \varepsilon_3$, and define

Furthermore, we introduce the function $g: D_{\varepsilon} \to \mathbb{R}$ as

Lemma 5.1. Assume p > 1 and let $0 < \varepsilon < \varepsilon_3$. Then, g is twice differentiable on D_{ε} .

Furthermore, the following hold:

$$\partial_{\omega}g(\omega,0) = \partial_{\omega}\partial_{a}\mathcal{F}_{\parallel}(\omega,0) = \partial_{a}\partial_{\omega}\mathcal{F}_{\parallel}(\omega,0), \qquad (5.3)$$

$$\partial_{\omega}^2 g(\omega, 0) = \partial_{\omega}^2 \partial_a \mathcal{F}_{\parallel}(\omega, 0), \tag{5.4}$$

$$\partial_a g(\omega, 0) = \frac{1}{2} \partial_a^2 \mathcal{F}_{\parallel}(\omega, 0), \qquad (5.5)$$

$$\partial_{\omega}\partial_{a}g(\omega,0) = \partial_{a}\partial_{\omega}g(\omega,0) = \frac{1}{2}\partial_{\omega}\partial_{a}^{2}\mathcal{F}_{\parallel}(\omega,0), \qquad (5.6)$$

$$\partial_a^2 g(\omega, 0) = \frac{1}{3} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0).$$
(5.7)

Proof of Lemma 5.1. Since \mathcal{F}_{\parallel} is C^3 on D_{ε} (see Proposition 4.15), it is obvious that g is twice differentiable at $(\omega, a) \in D_{\varepsilon}$ with $a \neq 0$. Furthermore, we can easily verify (5.3) and (5.4).

It remains to prove the twice differentiablity of g at $(\omega, 0)$ and (5.5) through (5.7). The Taylor expansion together with $\mathcal{F}_{\parallel}(\omega, 0) = 0$ (see (2.22)) shows that

Hence, the Taylor expansion together with (5.9) shows that

$$\partial_{\omega}\mathcal{F}_{\parallel}(\omega,a) = \partial_{a}\partial_{\omega}\mathcal{F}_{\parallel}(\omega,0)a + \frac{1}{2}\partial_{a}^{2}\partial_{\omega}\mathcal{F}_{\parallel}(\omega,0)a^{2} + o(a^{2}).$$
(5.10)

Moreover, we will use the Taylor example of $\partial_a \mathcal{F}_{\parallel}(\omega, a)$:

The claim (5.5) follows from (5.8):

$$\partial_a g(\omega, 0) = \lim_{a \to 0} \frac{g(\omega, a) - g(\omega, 0)}{a} = \lim_{a \to 0} \frac{\mathcal{F}_{\parallel}(\omega, a) - a\partial_a \mathcal{F}_{\parallel}(\omega, 0)}{a^2} = \frac{1}{2} \partial_a^2 \mathcal{F}_{\parallel}(\omega, 0). \quad (5.12)$$

Furthermore, (5.12) shows that

$$\partial_{\omega}\partial_{a}g(\omega,0) = \lim_{\delta \to 0} \frac{\partial_{a}g(\omega+\delta,0) - \partial_{a}g(\omega,0)}{\delta} = \frac{1}{2}\partial_{\omega}\partial_{a}^{2}\mathcal{F}_{\parallel}(\omega,0).$$
(5.13)

By (5.3) and (5.10), we see that

$$\partial_a \partial_\omega g(\omega, 0) = \lim_{a \to 0} \frac{\partial_\omega \mathcal{F}_{\parallel}(\omega, a) - a \partial_a \partial_\omega \mathcal{F}_{\parallel}(\omega, 0)}{a^2} = \frac{1}{2} \partial_a^2 \partial_\omega \mathcal{F}_{\parallel}(\omega, 0).$$

Then, (5.6) follows from (5.13), (5.14) and (4.68) in Proposition 4.15.

It remains to prove (5.7). Let $(\omega, a) \in D_{\varepsilon}$ with $a \neq 0$. Then, by the differentiation of quotient and (5.8), we see that

$$= \int_{0}^{1}\partial_{a}^{2}\mathcal{F}_{\parallel}(\omega,\theta a) \, d\theta - \frac{1}{2}\partial_{a}^{2}\mathcal{F}_{\parallel}(\omega,0) - \frac{1}{3!}\partial_{a}^{3}\mathcal{F}_{\parallel}(\omega,0)a + o(a).$$

Furthermore, by (5.15) and (5.12), we see that

$$\partial_a^2 g(\omega, 0) = \lim_{a \to 0} \frac{\partial_a g(\omega, a) - \partial_a g(\omega, 0)}{a}$$

$$= \lim_{a \to 0} \frac{1}{a} \left\{ \int_0^1 \partial_a^2 \mathcal{F}_{\parallel}(\omega, \theta a) \, d\theta - \partial_a^2 \mathcal{F}_{\parallel}(\omega, 0) - \frac{1}{3!} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0) a + o(a) \right\}$$

$$= \lim_{a \to 0} \int_0^1 \int_0^1 \partial_a^3 \mathcal{F}_{\parallel}(\omega, \theta \kappa a) \, d\kappa d\theta - \frac{1}{3!} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0)$$

$$= \int_0^1 \int_0^1 \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0) \, d\kappa d\theta - \frac{1}{6} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0) = \frac{1}{3} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0).$$
(5.16)

Thus, we have completed the proof.

Lemma 5.2. Assume p > 1, and let $0 < \varepsilon < \varepsilon_3$. Then, the function g is C^2 on D_{ε} . Furthermore, the following hold:

Proof of Lemma 5.2. We shall show that g is C^2 on D_{ε} . Since \mathcal{F}_{\parallel} is C^3 on D_{ε} (see Proposition 4.15), it is obvious that g is twice continuously differentiable at $(\omega, a) \in D_{\varepsilon}$ with $a \neq 0$. Furthermore, by Lemma 5.1, it suffices to prove the continuity of the second derivatives $\partial_{\omega}^2 g$, $\partial_{\omega} \partial_a g$ and $\partial_a^2 g$ at $(\omega, 0)$. By (2.17), (3.6) and φ being C^2 on D_{ε} (see Proposition 4.9), we see that both

By (2.17), (3.6) and φ being C^2 on D_{ε} (see Proposition 4.9), we see that both $\mathbf{L}_{+}(\omega, 0)\partial_{\omega}^2\varphi(\omega, 0)$ and $V_2(\omega, 0)\{\partial_{\omega}\varphi(\omega, 0)\}^2$ are independent of y. Hence, (4.66) in Proposition 4.14 together with the integral of $\cos y$ over $[-\pi, \pi]$ being zero shows that

$$\partial_{\omega}^{2} \mathcal{F}_{\parallel}(\omega, 0) = \langle \mathbf{L}_{+}(\omega, 0) \partial_{\omega}^{2} \varphi(\omega, 0) - V_{2}(\omega, 0) \{ \partial_{\omega} \varphi(\omega, 0) \}^{2}, \psi_{\omega_{p}} \cos y \rangle = 0.$$
(5.18)

Then, by the definition of g, (5.18) and (5.4) in Lemma 5.1, we see that

$$\lim_{a \to 0} \partial_{\omega}^2 g(\omega, a) = \lim_{a \to 0} \frac{\partial_{\omega}^2 \mathcal{F}_{\parallel}(\omega, a)}{a} = \partial_a \partial_{\omega}^2 \mathcal{F}_{\parallel}(\omega, 0) = \partial_{\omega}^2 g(\omega, 0).$$
(5.19)

Next, we consider $\partial_{\omega}\partial_a g$. By the differentiation of quotient, the Taylor expansion of

 $\partial_{\omega}\mathcal{F}_{\parallel}$ (see (5.10)), and (5.6) in Lemma 5.1, we see that

$$\lim_{a \to 0} \partial_{\omega} \partial_{a} g(\omega, a) = \lim_{a \to 0} \partial_{\omega} \left\{ \frac{a \partial_{a} \mathcal{F}_{\parallel}(\omega, a) - \mathcal{F}_{\parallel}(\omega, a)}{a^{2}} \right\}$$

$$= \lim_{a \to 0} \left\{ \frac{a \partial_{a} \partial_{\omega} \mathcal{F}_{\parallel}(\omega, a) - a \partial_{a} \partial_{\omega} \mathcal{F}_{\parallel}(\omega, 0)}{a^{2}} - \frac{1}{2} \partial_{a}^{2} \partial_{\omega} \mathcal{F}_{\parallel}(\omega, 0) + o_{a}(1) \right\}$$

$$= \frac{1}{2} \partial_{a}^{2} \partial_{\omega} \mathcal{F}_{\parallel}(\omega, 0) = \partial_{\omega} \partial_{a} g(\omega, 0).$$
(5.20)

Finally, we consider $\partial_a^2 g$. By the definition of g, (5.8) and (5.11), we can verify that for any $(\omega, a) \in D_{\varepsilon}$ with $a \neq 0$,

$$\partial_a^2 g(\omega, a) = \frac{a^2 \partial_a^2 \mathcal{F}_{\parallel}(\omega, a) - 2a \partial_a \mathcal{F}_{\parallel}(\omega, a) + 2\mathcal{F}_{\parallel}(\omega, a)}{a^3}$$

$$= \frac{a^2 \partial_a^2 \mathcal{F}_{\parallel}(\omega, a) - 2a \partial_a \mathcal{F}_{\parallel}(\omega, a) + 2a \partial_a \mathcal{F}_{\parallel}(\omega, 0) + a^2 \partial_a^2 \mathcal{F}_{\parallel}(\omega, 0)}{a^3}$$

$$+ \frac{1}{3} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0) + o_a(1) \qquad (5.21)$$

$$= a^{-1} \partial_a^2 \mathcal{F}_{\parallel}(\omega, a) - a^{-1} \partial_a^2 \mathcal{F}_{\parallel}(\omega, 0) - \frac{2}{3} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0) + o_a(1)$$

$$= \int_0^1 \partial_a^3 \mathcal{F}_{\parallel}(\omega, \theta a) \, d\theta - \frac{2}{3} \partial_a^3 \mathcal{F}_{\parallel}(\omega, 0) + o_a(1).$$

Then, the continuity of $\partial_a^2 g$ at $(\omega, 0)$ follows from (5.21) and (5.7) in Lemma 5.1:

Thus, we have proved that g is C^2 on D_{ε} .

We shall prove (5.17). Note that the following follows from the self-adjointness of $\mathbf{L}_{+}(\omega, a)$ on $L^{2}(\mathbb{R} \times \mathbb{T})$, (3.6) and (2.4):

$$\langle \mathbf{L}_{+}(\omega_{p},0)u, \psi_{\omega_{p}}\cos y \rangle = 0 \quad \text{for all } u \in H^{2}(\mathbb{R} \times \mathbb{T}).$$
 (5.23)

Then, by (4.62) in Proposition 4.13, and (5.23), we see that

$$g(\omega_p, 0) = \langle \mathbf{L}_+(\omega_p, 0) \partial_a \varphi(\omega_p, 0), \ \psi_{\omega_p} \cos y \rangle = 0.$$
(5.24)

By (5.5), (4.64) in Proposition 4.14, $V_2(\omega_p, 0) = p(p-1)R_{\omega_p}^{p-2}$ (see (4.2) and (2.17)), $\partial_a \varphi(\omega_p, 0) = \psi_{\omega_p} \cos y$ (see (2.18)), (5.23) and the integral of $(\cos y)^3$ over $[-\pi, \pi]$ being zero, we see that

$$\partial_{a}g(\omega_{p},0) = \frac{1}{2} \langle \mathbf{L}_{+}(\omega_{p},0)\partial_{a}^{2}\varphi(\omega_{p},0) - p(p-1)R_{\omega_{p}}^{p-2} \{\psi_{\omega_{p}}\cos y\}^{2}, \ \psi_{\omega_{p}}\cos y \rangle$$

$$= -\frac{p(p-1)}{2} \int_{\mathbb{R}} R_{\omega_{p}}^{p-2} \psi_{\omega_{p}}^{3} dx \int_{\mathbb{T}} (\cos y)^{3} dy = 0.$$
 (5.25)

By (5.3), (4.65) in Proposition 4.14, (5.23), (2.17), (2.18), the definition of ψ_{ω_p} (see (2.1)), (1.19) and (1.20), we see that

$$\begin{aligned} \partial_{\omega}g(\omega_{p},0) &= \partial_{\omega}\partial_{a}\mathcal{F}_{\parallel}(\omega_{p},0) \\ &= 1 + \langle \mathbf{L}_{+}(\omega_{p},0)\partial_{\omega}\partial_{a}\varphi(\omega_{p},0) - V_{2}(\omega_{p},0)\partial_{a}\varphi(\omega_{p},0)\partial_{\omega}\varphi(\omega_{p},0), \ \psi_{\omega_{p}}\cos y \rangle \\ &= 1 - p(p-1)\langle R_{\omega_{p}}^{p-2}(\psi_{\omega_{p}}\cos y)\partial_{\omega}R_{\omega}|_{\omega=\omega_{p}}, \ \psi_{\omega_{p}}\cos y \rangle \\ &= 1 - \frac{p(p-1)}{\|R_{\omega_{p}}\|_{L^{p+1}(\mathbb{R})}^{p+1}} \int_{\mathbb{R}} R_{\omega_{p}}^{2p-1}\partial_{\omega}R_{\omega}|_{\omega=\omega_{p}} dx \end{aligned}$$
(5.26)
$$&= 1 - \frac{p(p-1)}{\|R_{\omega_{p}}\|_{L^{p+1}(\mathbb{R})}^{p+1}} \frac{3p+1}{4p(p-1)}\omega_{p}^{-1} \int_{\mathbb{R}} R_{\omega_{p}}^{2p} dx \\ &= 1 - \frac{1}{\|R_{\omega_{p}}\|_{L^{p+1}(\mathbb{R})}^{p+1}} \frac{(p+1)^{2}}{4} \int_{\mathbb{R}} R_{\omega_{p}}^{p+1} = -\frac{(p-1)(p+3)}{4} = -\frac{1}{\omega_{p}}. \end{aligned}$$

Thus, we have completed the proof of the lemma.

Now, we are in a position to prove Theorem 1.1.

Proof of Theorem 1.1. The first step to prove Theorem 1.1 is to find a curve $\omega(a)$ parametrized by a such that $(\omega(a), a)$ satisfies the bifurcation equation (2.21):

$$\mathcal{F}_{\parallel}(\omega(a), a) = \langle \mathcal{F}(\omega, \varphi(\omega(a), a)), \ \psi_{\omega_p} \cos y \rangle = 0.$$
(5.27)

The implicit function theorem together with Lemma 5.2 shows that there exist $a_* > 0$, $\delta_* > 0$ and a C^2 -curve $\omega(\cdot): a \in (-a_*, a_*) \mapsto \omega(a) \in (\omega_p - \delta_*, \omega_p + \delta_*)$ with the following properties:

1.

$$g(\omega(a), a) = 0, \qquad \omega(0) = \omega_p, \qquad \frac{d\omega}{da}(a) = -\frac{\partial_a g(\omega(a), a)}{\partial_\omega g(\omega(a), a)}.$$
 (5.28)

2. Let Z_p be the set of zeros of g = 0 in $(\omega_p - \delta_*, \omega_p + \delta_*) \times (-a_*, a_*)$. Then,

$$Z_p = \{ (\omega(a), a) \colon a \in (-a_*, a_*) \}.$$
(5.29)

Next, we define the function $Q: (-a_*, a_*) \to H^2(\mathbb{R} \times \mathbb{T})$ by

$$Q(a) := \varphi(\omega(a), a) = R_{\omega_p} + a\psi_{\omega_p}\cos y + \eta(\omega(a), a).$$
(5.30)

Note that Q is C^2 on $(-a_*, a_*)$ in $H^2(\mathbb{R} \times \mathbb{T})$.

Since $g(\omega, a) = 0$ with $a \neq 0$ implies that $\mathcal{F}_{\parallel}(\omega, a) = 0$, the first claim of Theorem 1.1 follows from (5.29) and Lemma 2.1. Furthermore, the claim (1.10) follows immediately from (5.28) and (5.17).

We shall prove (1.11), (1.12) and (1.14).

First, note that the integral of $(\cos y)^3$ over $[-\pi,\pi]$ being zero shows that

$$R_{\omega_p}^{p-2} \{\psi_{\omega_p} \cos y\}^2 \in X_2.$$
(5.31)

Furthermore, by (4.43) in Proposition 4.9, (4.6), $V_2(\omega_p, 0) = p(p-1)R_{\omega_p}^{p-2}$ (see (4.2) and (2.17)), (2.18) and (5.31), we see that

$$\partial_a^2 \varphi(\omega_p, 0) = p(p-1) \{ P_\perp \partial_u \mathcal{F}(\omega_p, R_{\omega_p}) |_{X_2} \}^{-1} (R_{\omega_p}^{p-2} \{ \psi_{\omega_p} \cos y \}^2).$$
(5.32)

Differentiating both sides of the last equation in (5.28), and using (1.10), (5.17) and (5.7) in Lemma 5.1, we see that

$$\frac{d^2\omega}{da^2}(0) = -\frac{\omega_p}{3}\partial_a^3 \mathcal{F}_{\parallel}(\omega_p, a).$$
(5.33)

By (4.67) in Proposition 4.15, (5.23), $V_2(\omega_p, 0) = p(p-1)R_{\omega_p}^{p-2}$ and $V_3(\omega_p, 0) = p(p-1)(p-2)R_{\omega_p}^{p-3}$ (see (4.2) and (2.17)), $\partial_a \varphi(\omega_p, 0) = \psi_{\omega_p} \cos y$ (see (2.18)), (5.32) and (5.31), we see that

$$\begin{aligned} \partial_{a}^{3} \mathcal{F}_{\parallel}(\omega_{p}, 0) \\ &= \langle -3V_{2}(\omega_{p}, 0)\partial_{a}\varphi(\omega_{p}, 0)\partial_{a}^{2}\varphi(\omega_{p}, 0) - V_{3}(\omega_{p}, 0)\{\partial_{a}\varphi(\omega_{p}, 0)\}^{3}, \ \psi_{\omega_{p}}\cos y\rangle \\ &= -3\{p(p-1)\}^{2}\langle R_{\omega_{p}}^{p-2}\psi_{\omega_{p}}\cos y \mathbf{T}(\omega_{p}, 0)^{-1}(R_{\omega_{p}}^{p-2}\{\psi_{\omega_{p}}\cos y\}^{2}), \ \psi_{\omega_{p}}\cos y\rangle \\ &- p(p-1)(p-2)\langle R_{\omega_{p}}^{p-3}\{\psi_{\omega_{p}}\cos y\}^{3}, \ \psi_{\omega_{p}}\cos y\rangle \\ &= -3\{p(p-1)\}^{2}\langle \mathbf{T}(\omega_{p}, 0)^{-1}(R_{\omega_{p}}^{p-2}\{\psi_{\omega_{p}}\cos y\}^{2}), \ R_{\omega_{p}}^{p-2}\{\psi_{\omega_{p}}\cos y\}^{2}\rangle \\ &- p(p-1)(p-2)\langle R_{\omega_{p}}^{p-3}\{\psi_{\omega_{p}}\cos y\}^{3}, \ \psi_{\omega_{p}}\cos y\rangle. \end{aligned}$$
(5.34)

Plugging (5.34) into (5.33), we obtain (1.11).

Observe that

0

$$\frac{dQ}{da}(a) = \partial_{\omega}\varphi(\omega(a), a)\frac{d\omega}{da}(a) + \partial_{a}\varphi(\omega(a), a).$$
(5.35)

Then, by (5.35), (1.10) and (2.18), we see that

$$\frac{dQ}{da}(0) = \partial_a \varphi(\omega_p, 0) = \psi_{\omega_p} \cos y.$$
(5.36)

Furthermore, differentiating both sides of (5.35), and using (1.10) and (2.17), we see that

$$\frac{d^2 Q}{da^2}(0) = \partial_{\omega}^2 \varphi(\omega(0), 0) \left(\frac{d\omega}{da}(0)\right)^2 + \partial_{\omega} \varphi(\omega(0), 0) \frac{d^2 \omega}{da^2}(0)
+ \partial_{\omega} \partial_a \varphi(\omega(0), 0) \frac{d\omega}{da}(0) + \partial_a^2 \varphi(\omega(0), 0)
= \partial_{\omega} R_{\omega}|_{\omega = \omega_p} \frac{d^2 \omega}{da^2}(0) + \partial_a^2 \varphi(\omega_p, 0).$$
(5.37)

Then, the Taylor expansion together with $Q(0) = \varphi(\omega(0), 0) = R_{\omega_p}$ (see (2.17)), (5.36) and (5.37) shows that the following holds in $H^2(\mathbb{R} \times \mathbb{T})$:

$$Q(a) = R_{\omega_p} + a\psi_{\omega_p}\cos y + \frac{1}{2}a^2 \left\{ \partial_\omega R_\omega |_{\omega=\omega_p} \frac{d^2\omega}{da^2}(0) + \partial_a^2 \varphi(\omega_p, 0) \right\} + o(a^2).$$
(5.38)

Clearly, this shows that (1.12) holds.

It remains to prove the last claim (1.14). By (5.38), $\|\psi_{\omega_p} \cos y\|_{L^2(\mathbb{R}\times\mathbb{T})} = 1$ and the integral of $\cos y$ over $[-\pi, \pi]$ being zero, we see that

$$|Q(a)||^{2}_{L^{2}(\mathbb{R}\times\mathbb{T})} = ||R_{\omega_{p}}||^{2}_{L^{2}(\mathbb{R}\times\mathbb{T})} + a^{2} + a^{2} \frac{d^{2}\omega}{da^{2}}(0) \langle R_{\omega_{p}}, \ \partial_{\omega}R_{\omega}|_{\omega=\omega_{p}} \rangle + a^{2} \langle R_{\omega_{p}}, \ \partial^{2}_{a}\varphi(\omega_{p}, 0) \rangle + o(a^{2})$$

$$(5.39)$$

Recall that $R_{\omega}, \partial_{\omega}R_{\omega} \in X_2$ (see (2.6)) and $\partial_u \mathcal{F}(\omega_p, R_{\omega_p}): X_2 \to Y_2$ is bijective (see (2.10) and (2.11)). Then, by (5.32), (3.7) and the same computation as (5.26), we see that

$$\langle R_{\omega_p}, \ \partial_a^2 \varphi(\omega_p, 0) \rangle$$

$$= p(p-1) \langle \left\{ P_\perp \partial_u \mathcal{F}(\omega_p, R_{\omega_p}) |_{X_2} \right\}^{-1} R_{\omega_p}, \ R_{\omega_p}^{p-2} \{ \psi_{\omega_p} \cos y \}^2 \rangle$$

$$= -p(p-1) \langle \partial_\omega R_\omega |_{\omega=\omega_p}, \ R_{\omega_p}^{p-2} \{ \psi_{\omega_p} \cos y \}^2 \rangle = -1 - \frac{1}{\omega_p}.$$

$$(5.40)$$

Plugging (5.40) into (5.39), and using (1.19), we obtain (1.14). Thus, we have completed the proof of the theorem. \Box
