CONFORMAL TORI WITH ALMOST NON-NEGATIVE SCALAR CURVATURE

Abstract. In this work, we consider sequence of metrics with almost nonnegative scalar curvature on torus. We show that if the sequence is uniformly conformal to another sequence of metrics with better controlled geometry, then it converges to a flat metric in the volume preserving intrinsic flat sense, L^p sense and the measured Gromov-Hausdorff sense.

1. Introduction

In the study of Riemnnian geometry, the notion of curvature plays an significant role. As the average of sectional curvature, the scalar curvature is one of the simplest curvature invariants on a Riemannian manifold. In general, the scalar curvature can be regarded as a kind of weak measure of the local geometry. It is tempting to ask which manifolds can admit metric of positive scalar curvature. When the underlying manifold is torus \mathbb{T}^n , the Geroch Conjecture predicted that metrics with non-negative scalar curvature must be flat. The problem was solved by Schoen-Yau [\[24,](#page-20-0) [25\]](#page-20-1) for $n \leq 7$ using minimal surface method and Gromov-Lawson [\[15\]](#page-19-0) for general n using Atiyah-Singer index theorem for a twisted spinor bundle on a spin manifold.

In [\[14\]](#page-19-1), Gromov conjectured a stability for the torus rigidity. Namely, a sequence of Riemannian manifolds with almost non-negative scalar curvature, which are diffeomorphic to tori, combined with appropriate compactness conditions should converge to a flat torus in some weak sense. In [\[29\]](#page-20-2), Sormani had formulated the conjecture more concretely using the notion of intrinsic flat distance which is a distance between integral current spaces and was introduced by Sormani-Wenger [\[30\]](#page-20-3). This is believed to be the suitable notion for taking limits of manifolds with lower scalar curvature bounds, see also the recent work of the second named author, Naber and Neumayer in [\[21\]](#page-20-4) which suggested that the geodesic distance should be replaced by the L^p version of distance function d_p at least when $n > 3$. For general dimension, it is unclear what conditions should serve as the non-collapsing assumption. While in $n = 3$, Sormani [\[29\]](#page-20-2) gave a precise prediction of the non-collapsing conditions called the MinA condition in order to avoid bubbling occurring.

The first result in this direction is given by Gromov in [\[14\]](#page-19-1) where if one assumes that a sequence of tori with almost non-negative scalar curvature converges in the C^0 sense to a C^2 metric, then one can show that the C^2 limit is a flat Riemannian metric. In [\[6\]](#page-19-2), Bamler gave an alternative proof using the Ricci flow to perform regularization. It was recently generalized by Burkhardt-Guim [\[8\]](#page-19-3) to the case when the limiting metrics g_{∞} are only C^0 metric and it was shown that g_{∞} is isometric to the flat torus as a metric space. Further progresses toward the conjecture formulated by Sormani [\[29\]](#page-20-2) has been made in various cases. In [\[2\]](#page-19-4), Allen, Hernandez-Vazquez, Parise, Payne, and Wang studied the warped product case. In [\[9\]](#page-19-5), Cabrera Pacheco, Ketterer, and Perales studied the case of graphical tori. In [\[1\]](#page-19-6), Allen studied the case when the sequence is conformal to the flat tori. In [\[21\]](#page-20-4), the second named author with Naber and Neumayer considered the case when the entropy is small and proved the stability in the sense of d_p convergence.

Motivated by the work of Allen in [\[1\]](#page-19-6), we study the case when the metrics are uniformly conformal to some metrics with better controlled geometry. We show that under the natural non-collapsing assumption, if in addition the conformal factor is bounded in L^{p_0} for some sufficiently large p_0 , then the sequence will converge to a flat metric in the volume preserving intrinsic flat sense.

Theorem 1.1. Let (M_i, g_i) be a sequence of n-dimensional Riemannian manifolds $(n > 2)$. Suppose M_i is diffeomorphic to \mathbb{T}^n and $g_i = u_i^{\frac{4}{n-2}} h_i$ for some metric h_i such that

- (i) $|\text{Ric}(h_i)|_{h_i} + (\text{inj}(M_i, h_i))^{-1} + \text{diam}(M_i, h_i) \leq \Lambda;$
- (ii) diam $(M_i, g_i) + ||u_i||_{L^{p_0}(M_i, h_i)} \leq \Lambda;$
- (iii) $\text{Vol}(M_i, g_i) \geq \Lambda^{-1};$
- (iv) $R(q_i) > -\delta_i$

for some $\Lambda > 0$, $p_0 > \frac{n}{2} + \frac{2n(n+4)}{(n-2)(n+2)}$ and $\delta_i \to 0$. Then after passing to a subsequence, (M_i, g_i) converges to a flat torus in the volume preserving intrinsic flat sense.

Remark 1.1. By the Hölder inequality, condition (ii) and (iii) will imply a lower bound of $Vol(M_i, h_i)$. In this case, the lower bound of injectivity radius of h_i will follow from the work of Cheeger-Gromov-Taylor [\[11\]](#page-19-7) if we strengthen the curvature bound of h_i from $\text{Ric}(h_i)$ to $\text{Rm}(h_i)$.

In Theorem [1.1,](#page-1-0) h_i serves as a sequence of well-behaved reference metrics within the conformal classes. In certain sense, we show that if the metric within the conformal has almost non-negative scalar curvature, then it is almost the solution to the Yamabe problem. The volume condition (iii) is necessary in order to prevent collapsing. Condition (ii) is stronger than volume non-expanding which plays the role to rule out bubbling. If we strengthen

condition (ii) from L^{p_0} to L^{∞} , better convergence can be obtained. Note that in this case, the upper bound of $\text{diam}(M_i, g_i)$ follows from condition (i).

Theorem 1.2. Let (M_i, g_i) be a sequence of n-dimensional Riemannian manifolds $(n > 2)$. Suppose M_i is diffeomorphic to \mathbb{T}^n and $g_i = u_i^{\frac{4}{n-2}} h_i$ for some metric h_i such that

- (i) $|\text{Ric}(h_i)|_{h_i} + (\text{inj}(M_i, h_i))^{-1} + \text{diam}(M_i, h_i) \leq \Lambda;$
- (ii) $\sup_{M_i} u_i \leq \Lambda$;
- (iii) $\text{Vol}(M_i, g_i) \geq \Lambda^{-1};$
- (iv) $R(q_i) \geq -\delta_i$

for some $\Lambda > 0$ and $\delta_i \to 0$. Then after passing to a subsequence, (M_i, g_i) converges to a flat torus in L^p for all $p > 0$ modulo diffeomorphism. Moreover, (M_i, g_i) converges to a flat torus in the measured Gromov-Hausdorff sense.

Remark 1.2. It will be clear from the proof that the torus structure doesn't play any important role. Indeed, the same stability will be true if \mathbb{T}^n is replaced by any closed manifolds $Mⁿ$ with non-positive Yamabe invariant. We refer readers to Section [3](#page-14-0) for the detailed statement.

The main technique is motivated by that of [\[6,](#page-19-2) [8,](#page-19-3) [27\]](#page-20-5) which used the Ricci flow to regularize the metrics using the estimates from [\[20,](#page-20-6) [28\]](#page-20-7). In our case, we do not a-priori assume any convergence of g_i or C^0 closeness of metrics and therefore Ricci flow's method do not apply directly. Instead, we make use of the Yamabe flow which is a geometric heat flow evolving inside the conformal class to (partially) regularize the metric g_i . Unlike the Ricci flow, its regularization ability is relatively limited and highly depends on the uniform geometry of h_i . In our case, although the corresponding Yamabe flow $g_i(t)$ is not uniformly regular in C^{∞} , we are able to show that it converges to a fixed flat metric away from $t = 0$ weakly modulo diffeomorphism. This reduces the problem to establishing uniform weak convergence of $g_i(t)$ as $t \to 0$. This will be done in Section [3.](#page-14-0)

2. A-priori estimates along the Yamabe flow

In the following, we will consider a Riemannian manifold (M, h) which satisfies

\begin{aligned} \mathbf{(A)}: \quad \begin{cases} \ |\text{Ric}(h)|_h \leq \Lambda; \\ \text{diam}(M, h) \leq \Lambda; \\ \text{inj}(M, h) \geq \Lambda^{-1} \end{cases} \end{aligned}
$$

for some $\Lambda > 0$. For later use, here we recall the Sobolev inequality and the Poincaré inequality: for $f \in W^{1,2}(M)$,

(2.1)
$$
\left(\int_M |f|^{\frac{2n}{n-2}} d\mu_h\right)^{\frac{n-2}{n}} \leq C_S \int_M |\nabla^h f|_h^2 d\mu_h + C_S \int_M f^2 d\mu_h,
$$

and

$$
(2.2) \qquad \int_M |f - \underline{f}|^2 d\mu_h \leq C_P \int_M |\nabla^h f|_h^2 d\mu_h, \quad \underline{f} = \frac{1}{\text{Vol}(M, h)} \int_M f d\mu_h.
$$

Note that the lower bound of injective radius implies the lower bound of volume (see [\[7\]](#page-19-8)), and then constants C_S (see [\[18\]](#page-20-8)) and C_P (see [\[22\]](#page-20-9)) depend only on n and $Λ$.

Let $g_0 = u_0^{\frac{4}{n-2}} h$ be a metric inside the conformal class of h. Suppose that

\begin{aligned} \mathbf{(B)}: \quad \begin{cases} \Vert u_0 \Vert_{L^{p_0}(M,h)} \leq \Lambda; \\ \text{Vol}(M,g_0) \geq \Lambda^{-1}; \\ R(g_0) \geq -\delta \geq -1 \end{cases} \end{aligned}
$$

for some $p_0, \Lambda, \delta > 0$. In this section, we will use the Yamabe flow to regularize g_0 slightly. This is the family of metric $g(t)$ which solves

(2.3)
$$
\begin{cases} \frac{\partial g}{\partial t} = -R(g)g, \\ g(0) = g_0. \end{cases}
$$

Equivalently, if we write $g(t) = u(t)^{\frac{4}{n-2}}h$, then the function $u(t)$ solves

(2.4)
$$
\begin{cases} \frac{\partial u^N}{\partial t} = \frac{n+2}{4} \left(\frac{4(n-1)}{n-2} \Delta_h u - R_h u \right), \\ u(0) = u_0, \end{cases}
$$

where $N = \frac{n+2}{n-2}$ $\frac{n+2}{n-2}$ and R_h denotes the scalar curvature of h. We will establish a-priori estimates of $q(t)$ or equivalently $u(t)$ along the Yamabe flow.

2.1. Lower bound of the Yamabe flow. We first show that if p_0 is sufficiently large, then assumption (B) implies the positive lower bound of u_0 . We begin with the following lemma, which is a global version of [\[17,](#page-19-9) (4.8)].

Lemma 2.1. If $p_0 > \frac{2n}{n-1}$ $\frac{2n}{n-2}$, then there is a constant $\varepsilon_0(n, \Lambda, p_0) > 0$ such that

(2.5)

\left(\int_M u_0^{\varepsilon_0} d\mu_h\right) \left(\int_M u_0^{-\varepsilon_0} d\mu_h\right) \leq 4e^2.
$$

Proof. The proof is similar to that of the local version [\[17,](#page-19-9) (4.8)]. For the sake of completeness, we include the proof here. Since $g_0 = u_0^{\frac{4}{n-2}} h$, then the scalar curvature of g_0 is

(2.6)

R_{g_0} = u_0^{-\frac{n+2}{n-2}} \left(R_h u_0 - \frac{4(n-1)}{n-2} \Delta_h u_0 \right),
$$

Define

(2.7)
$$
w = \log u_0 - \frac{1}{\text{Vol}(M, h)} \int_M (\log u_0) d\mu_h.
$$

Direct calculation shows

(2.8)

$$
R_{g_0} = u_0^{-\frac{4}{n-2}} \left(R_h - \frac{4(n-1)}{n-2} \frac{\Delta_h u_0}{u_0} \right)
$$

$$
= u_0^{-\frac{4}{n-2}} \left(R_h - \frac{4(n-1)}{n-2} \left(\Delta_h w + |\nabla^h w|_h^2 \right) \right).
$$

Recalling $R_{g_0} \geq -1$,

$$
(2.9) \quad |\nabla^h w|_h^2 = -\Delta_h w + \frac{n-2}{4(n-1)} \left(R_h - R_{g_0} u_0^{\frac{4}{n-2}} \right) \le -\Delta_h w + C u_0^{\frac{4}{n-2}} + C
$$

for some $C(n, \Lambda)$. Since $p_0 > \frac{2n}{n-2} > \frac{4}{n-2}$ $\frac{4}{n-2}$, we obtain

$$
(2.10)\quad \int_M |\nabla^h w|_h^2 d\mu_h \le \int_M (Cu_0^{\frac{4}{n-2}} + C) d\mu_h \le C \|u_0\|_{p_0}^{p_0} + C \le C(n, \Lambda_0, p_0).
$$

Combining this with the Sobolev inequality and the Poincaré inequality,

$$
(2.11) \qquad \left(\int_M |w|^{\frac{2n}{n-2}} d\mu_h\right)^{\frac{n-2}{n}} \leq C_S \int_M |\nabla^h w|_h^2 d\mu_h + C_S \int_M |w|^2 d\mu_h
$$

$$
\leq C_S (1 + C_P) \int_M |\nabla^h w|_h^2 d\mu_h \leq C(n, \Lambda, p_0).
$$

Define two constants β and β^* by

(2.12)
$$
\frac{4\beta}{n-2} = p_0, \quad \frac{1}{\beta} + \frac{1}{\beta^*} = 1.
$$

Then $p_0 > \frac{2n}{n-2}$ $\frac{2n}{n-2}$ implies $\beta > \frac{n}{2}$ and $\beta^* < \frac{n}{n-2}$ $\frac{n}{n-2}$. Using [\(2.9\)](#page-4-0), [\(2.10\)](#page-4-1) and the Hölder inequality, for $p > 1$, we compute

\int_{M} |w|^{p} |\nabla^{h} w|_{h}^{2} d\mu_{h}
$$
\n
$$
\leq p \int_{M} |w|^{p-1} |\nabla^{h} w|_{h}^{2} d\mu_{h} + C \int_{M} |w|^{p} u_{0}^{\frac{4}{n-2}} d\mu_{h} + C \int_{M} |w|^{p} d\mu_{h}
$$
\n
$$
(2.13) \quad \leq \frac{1}{2} \int_{M} |w|^{p} |\nabla^{h} w|_{h}^{2} d\mu_{h} + (Cp)^{p} \int_{M} |\nabla^{h} w|_{h}^{2} d\mu_{h}
$$
\n
$$
+ C \left(\int_{M} u_{0}^{p_{0}} d\mu_{h} \right)^{\frac{1}{\beta}} \left(\int_{M} |w|^{p\beta^{*}} d\mu_{h} \right)^{\frac{1}{\beta^{*}}} + C \left(\int_{M} |w|^{p\beta^{*}} d\mu_{h} \right)^{\frac{1}{\beta^{*}}}
$$
\n
$$
\leq \frac{1}{2} \int_{M} |w|^{p} |\nabla^{h} w|_{h}^{2} d\mu_{h} + (Cp)^{p} + C \left(\int_{M} |w|^{p\beta^{*}} d\mu_{h} \right)^{\frac{1}{\beta^{*}}},
$$

which implies

$$
(2.14)\quad \int_M |\nabla (|w|^{\frac{p+2}{2}})|_h^2 d\mu_h \le C(p+2)^2 \left(\int_M |w|^{p\beta^*} d\mu_h\right)^{\frac{1}{\beta^*}} + (C(p+2))^{p+2},
$$

Combining this with the Sobolev inequality and the Hölder inequality,

$$
\left(\int_M |w|^{\frac{n(p+2)}{n-2}} d\mu_h\right)^{\frac{n-2}{n}}
$$
\n
$$
\leq C(p+2)^2 \left(\int_M |w|^{p\beta^*} d\mu_h\right)^{\frac{1}{\beta^*}} + C \int_M |w|^{p+2} d\mu_h + (C(p+2))^{p+2}
$$
\n
$$
\leq C(p+2)^2 \left(\int_M |w|^{(p+2)\beta^*} d\mu_h\right)^{\frac{1}{\beta^*}} + (C(p+2))^{p+2}.
$$

It then follows that

$$
(2.16) \qquad \|w\|_{L^{\frac{n(p+2)}{n-2}}} \le (C(p+2))^{\frac{2}{p+2}} \|w\|_{L^{(p+2)\beta^*}} + C(p+2), \quad \text{for } p > 1.
$$

Replacing $(p+2)\beta^*$ by p, and writing $\gamma = \frac{n}{\beta^*(n-2)}$, we obtain

(2.17)

||w||_{L^{\gamma p}} \le (Cp)^{\frac{C}{p}} ||w||_{L^p} + Cp, \text{ for } p > 3\beta^*.
$$

Recalling $\beta^* < \frac{n}{n-1}$ $\frac{n}{n-2}$, we have $\gamma > 1$. Using [\(2.17\)](#page-5-0) repeatedly,

(2.18)

||w||_{L^{6\beta^*}} \leq C||w||_{L^{4\beta^*}} + C.
$$

By [\(2.11\)](#page-4-2), we have $||w||_{L^{2\beta^*}} \leq C$. Using the Cauchy-Schwarz inequality,

(2.19)\quad \|w\|_{L^{4\beta^*}} = \left(\int_M |w|^{\beta^*}|w|^{3\beta^*} d\mu_h\right)^{\frac{1}{4\beta^*}} \leq \|w\|_{L^{2\beta^*}}^{\frac{1}{4}} \|w\|_{L^{6\beta^*}}^{\frac{3}{4}} \leq C \|w\|_{L^{6\beta^*}}^{\frac{3}{4}}.
$$

Then [\(2.18\)](#page-5-1) and [\(2.19\)](#page-5-2) show $||w||_{L^{6\beta^*}} \leq C$. Combining this with [\(2.17\)](#page-5-0), we obtain

(2.20)

||w||_{L^{\gamma^k}} \le (C\gamma^{k-1})^{\frac{C}{\gamma^{k-1}}} ||w||_{L^{\gamma^{k-1}}} + C\gamma^{k-1}, \text{ for } k \in \mathbb{N},
$$

and so

||w||_{L^{\gamma^k}} \leq C(n, \Lambda, p_0)\gamma^k, \text{ for } k \in \mathbb{N}.
$$

This shows

(2.22)
$$
||w||_{L^p} \le C_0(n, \Lambda, p_0)p, \text{ for } p \ge 1.
$$

Choosing $\varepsilon_0(n, \Lambda, p_0)$ such that $C_0 \varepsilon_0 \leq \frac{1}{2}$ $\frac{1}{2}$, then (2.23)

\int_M e^{\varepsilon_0|w|} d\mu_h = \sum_{k=0}^{\infty} \int_M \frac{\varepsilon_0^k |w|^k}{k!} d\mu_h \le \sum_{k=0}^{\infty} \frac{(C_0 \varepsilon_0)^k k^k}{k!} \le e \sum_{k=0}^{\infty} (C_0 \varepsilon_0)^k \le 2e.
$$

Recalling the definition of $w(2.7)$ $w(2.7)$, we obtain

\left(\int_M u_0^{\varepsilon_0} d\mu_h\right) \left(\int_M u_0^{-\varepsilon_0} d\mu_h\right) = \left(\int_M e^{\varepsilon_0 w} d\mu_h\right) \left(\int_M e^{-\varepsilon_0 w} d\mu_h\right) \leq 4e^2.
$$

Lemma 2.2. If $p_0 > \frac{2n}{n-1}$ $\frac{2n}{n-2}$, then there is a constant $c(n, \Lambda, p_0) > 0$ such that (2.25) $\inf_M u_0(x) \ge c(n, \Lambda, p_0).$

Proof. By (2.6) , we have

(2.26)
$$
\frac{4(n-1)}{n-2} \Delta_h u_0 = R_h u_0 - R_{g_0} u_0^{\frac{n+2}{n-2}}.
$$

Using $R_{g_0} \ge -1$, the function $v = u_0^{-1}$ satisfies

\Delta_h v = -v^2 \Delta_h u_0 + 2v^3 |\nabla^h u|_h^2
$$

$$
> -\frac{(n-2)v}{2} \left(B_h - B_h u \right)
$$

(2.27)

$$
\geq -\frac{(n-2)v}{4(n-1)} \left(R_h - R_{g_0} u_0^{\frac{4}{n-2}} \right)
$$

$$
\geq -C(n)\Lambda v - C(n)u_0^{\frac{4}{n-2}}.
$$

Define two constants β and β^* by

(2.28)
$$
\frac{4\beta}{n-2} = p_0, \quad \frac{1}{\beta} + \frac{1}{\beta^*} = 1.
$$

Then $p_0 > \frac{2n}{n-1}$ $\frac{2n}{n-2}$ implies $\beta > \frac{n}{2}$ and $\beta^* < \frac{n}{n-2}$ $\frac{n}{n-2}$. For $p > 1$, multiplying $-v^{p-1}$ on both sides of (2.27) and integrating on (M, h) , we have

\frac{4(p-1)}{p^2} \int_M |\nabla^h v^{\frac{p}{2}}|^2_h d\mu_h = -\int_M (v^{p-1} \Delta_h v) d\mu_h
$$
\n
$$
\leq C \int_M v^p d\mu_h + C \int_M (u_0^{\frac{4}{n-2}} v^p) d\mu_h
$$
\n
$$
\leq C \int_M v^p d\mu_h + C \left(\int_M u_0^{p_0} d\mu_h \right)^{\frac{1}{\beta}} \left(\int_M v^{p\beta^*} d\mu_h \right)^{\frac{1}{\beta^*}}
$$

for some $C(n, \Lambda)$. Combining this with $||u_0||_{L^{p_0}} \leq \Lambda$, the Sobolev inequality and the Hölder inequality, for $p > 1$,

$$
(2.30) \t\t \t\t \frac{p-1}{p^2} \left(\int_M v^{\frac{pn}{n-2}} d\mu_h \right)^{\frac{n-2}{n}} \leq C(n, \Lambda, p_0) \left(\int_M v^{p\beta^*} d\mu_h \right)^{1/\beta^*}.
$$

Recalling $\beta^* < \frac{n}{n-1}$ $\frac{n}{n-2}$, we may apply the iteration method to conclude that (2.31) $||v||_{L^{\infty}} \leq C(n, \Lambda, p_0) ||v||_{L^{\varepsilon_0}},$

where ε_0 is the constant in Lemma [2.1.](#page-3-1)

It remains to control L^{ε_0} bound of $v = u_0^{-1}$. Thanks to Lemma [2.1,](#page-3-1) it suffices to establish the positive lower bound of $||u_0||_{L^{\varepsilon_0}}$. We may assume $\varepsilon_0 = \frac{2n\sigma}{n-2}$ $\frac{2n\sigma}{n-2}$ for some $\sigma < 1$. Otherwise, the required estimate follows from $Vol(M, g_0) \geq \Lambda^{-1}$ and the Hölder inequality. For any $\gamma \in (0, \sigma)$,

\Lambda^{-1} \leq \text{Vol}(M, g_0) = \int_M u_0^{\frac{2n}{n-2}} d\mu_h = \int_M u_0^{\frac{\epsilon_0 \gamma}{\sigma} + \frac{2n(1-\gamma)}{n-2}} d\mu_h
$$
\n
$$
\leq \left(\int_M u_0^{\epsilon_0} d\mu_h \right)^{\frac{\gamma}{\sigma}} \left(\int_M u_0^{\frac{2n\sigma(1-\gamma)}{(n-2)(\sigma-\gamma)}} d\mu_h \right)^{\frac{\sigma-\gamma}{\sigma}}.
$$

Since $p_0 > \frac{2n}{n-1}$ $\frac{2n}{n-2}$, we may choose $\gamma < \sigma$ such that

\frac{2n\sigma(1-\gamma)}{(n-2)(\sigma-\gamma)} = p_0.
$$

Using $||u_0||_{L^{p_0}} \leq \Lambda$, we obtain

\int_M u_0^{\varepsilon_0} d\mu_h \ge c(n, \Lambda, p_0) > 0,

which completes the proof. \Box

Using Lemma [2.2,](#page-6-1) we establish the lower bound of the Yamabe flow:

Proposition 2.1. Let $g(t) = u(t)^{\frac{4}{n-2}}h$ be a solution of the Yamabe flow [\(2.3\)](#page-3-2). Suppose that $g(t)$ exists on $M \times [0,T]$. If $p_0 > \frac{2n}{n-1}$ $\frac{2n}{n-2}$, then there are constants \hat{T} and c depending only on (n, Λ, p_0) such that

2.2. Upper bound of the Yamabe flow. Next, we will show that if p_0 is sufficiently large, then along the Yamabe flow, $u(t)$ will be bounded from above instantaneously.

Proposition 2.2. Let $g(t) = u(t)^{\frac{4}{n-2}}h$ be a solution of the Yamabe flow [\(2.3\)](#page-3-2). Suppose that $g(t)$ exists on $M \times [0,T]$ for some $T \leq 1$. If $\frac{n}{2} + \frac{2n(n+4)}{(n-2)(n+2)}$ $p_0 < \infty$, then for any $\left(\frac{2p_0}{n} - \frac{4(n+4)}{(n-2)(n+2)}\right)^{-1} < \alpha < 1$, there is a constant $C(\alpha, n, \Lambda, p_0)$ such that

for some $C(\alpha, n, \Lambda)$, where

Proposition 2.3. Let $g(t) = u(t)^{\frac{4}{n-2}}h$ be a solution of the Yamabe flow [\(2.3\)](#page-3-2). If $p_0 > \frac{n}{2} + \frac{2n(n+4)}{(n-2)(n+2)}$, then there is a constant $T_0(n, \Lambda, p_0)$ such that $g(t)$ exists on $[0, T_0]$. Moreover, for all $[a, T_0] \subset (0, T_0]$, there is a constant $\lambda(a, n, \Lambda, p_0)$ 1 such that

\begin{cases} \lambda^{-1}h \le g(t) \le \lambda h; \\ |\nabla^h g(t)|_h \le \lambda; \\ -\delta \le R_{g(t)} \le \lambda \end{cases}

on $M \times [a, T_0]$.

Proof. In the following, all norms are with respect to metric h . Denote the maximal existence time of the Yamabe flow (2.3) by T_{max} . First, we establish the lower bound of T_{max} . By [\[5,](#page-19-10) Lemma 2.2], for any $\beta \in (0,1)$, the $C^{1,\beta}$ harmonic radius of h is bounded from below by $r(\beta, n, \Lambda)$. Next, we establish the required estimates. The estimate $\lambda^{-1}h \leq g(t) \leq \lambda h$ follows from [\(2.60\)](#page-11-1). \int_{M} |g(t) - g(0)|_{h} d\mu_{h} = \int_{M} \left| \int_{0}^{t} \frac{\partial g}{\partial s} ds \right|_{h} d\mu_{h}
$$
\n
$$
\leq C \int_{0}^{t} \int_{M} |R_{g(s)}| d\mu_{h} ds
$$
\n
$$
\leq C(n, \Lambda)t.
$$

For $p \in (0, 1)$, the Holder inequality shows

(2.78)
$$
\int_M |g(t) - g(0)|_h^p d\mu_h \le C \left(\int_M |g(t) - g(0)|_h d\mu_h \right)^p = C(p, n, \Lambda) t^p.
$$

For $p > 1$, using (2.75).

$$
(2.79) \qquad \int_M |g(t) - g(0)|_h^p d\mu_h \le C \int_M |g(t) - g(0)|_h d\mu_h \le C(p, n, \Lambda)t.
$$

3. Stability on torus

In this section, we will give the proof of Theorem [1.1](#page-1-0) and [1.2.](#page-2-0) Indeed, we will consider a slightly more general case where M is a closed manifold with non-positive Yamabe invariant. Recall that

(3.1) $\sigma(M) = \sup \{ \mathcal{Y}(M, [g]) : [g] \text{ is a conformal class of metrics on } M \},$ where

(3.2)
$$
\mathcal{Y}(M,[g_0]) = \inf \left\{ \int_M R(g) \, d\mu_g : g \in [g_0], \text{ Vol}(M,g) = 1 \right\}.
$$

It is well known that if a smooth metric on a compact manifold attains the Yamabe invariant and if the invariant is nonpositive, then the metric is Einstein [\[23\]](#page-20-11). In particular, if g is a smooth metric with $R_g \geq 0$ on M, then $\text{Ric}(g) \equiv 0.$

Remark 3.1. For $n \geq 3$, it is in general difficult to compute the Yamabe invariant. One can usually show that $\sigma(M) = 0$ by proving the non-existence of metrics with positive scalar curvature. For example, Schoen-Yau [\[24,](#page-20-0) [25\]](#page-20-1)

and Gromov-Lawson [\[15\]](#page-19-0) showed that torus cannot admit metric with positive scalar curvature and hence $\sigma(\mathbb{T}^n) = 0$.

In the following, we will consider a sequence of $g_{i,0} = u_i^{\frac{4}{n-2}} h_i$ on M^n with $\sigma(M) \leq 0$ where h_i and $g_{i,0}$ satisfy assumptions (A) and (B) with $\delta = i^{-1} \to 0$ and p_0 sufficiently large. Our goal is to show that $g_{i,0}$ will converge to a Ricciflat metric on M in a weak sense. Let $g_i(t)$ be the Yamabe flow with initial metric $g_{i,0}$.

Theorem 3.1. Let M^n be a closed manifold with $\sigma(M) \leq 0$. Suppose $g_{i,0}$ is a sequence of metrics on M such that

(a)
$$
g_{i,0} = u_i^{\frac{4}{n-2}} h_i
$$
 for some metric h_i on M_i satisfying assumption (A);

(b) $g_{i,0}$ satisfies assumption (B) for $\delta = i^{-1} \rightarrow 0$ and $p_0 > \frac{n}{2} + \frac{2n(n+4)}{(n-2)(n+2)}$.

Then the Yamabe flow $g_i(t)$ with initial metric $g_{i,0}$ exists on $M \times [0, T_0]$, where $T_0(n, \Lambda, p_0)$ is the constant in Proposition [2.3.](#page-11-2) Moreover, there is a sequence of diffeomorphisms Φ_i of M and a Ricci-flat metric g_{∞} on M such that after passing to subsequence, $\Phi_i^* g_i(t)$ converges to g_{∞} on M in $C^0_{loc}(M \times (0,T_0])$.

Proof. In the proof, for notational convenience all convergent sequence means convergent subsequence. By [\[5\]](#page-19-10), we can find a sequence of diffeomorphism Φ_i such that $\Phi_i^* h_i$ converges to some $C^{1,\beta}$ metric h_{∞} on M in $C^{1,\gamma}$ for all $\gamma < \beta < 1$ after passing to subsequence. For notational convenience, we will pull-back all $g_{i,0}$ by Φ_i and omit Φ_i^* .

Applying Proposition [2.3](#page-11-2) to each $g_i(t)$, we obtain a sequence of Yamabe flows $g_i(t)$ on $M^n \times [0, T_0]$ which is uniform bounded in C^1 on any $[a, T_0] \subset (0, T_0]$. Our goal is to show that $g_i(t)$ converges to a Ricci-flat metric on M weakly. In case h_i is uniformly regular in C^{∞} , it is not difficult to see that $g_i(t)$ converges to a limiting solution of the Yamabe flow $g_{\infty}(t)$ for $t > 0$ after passing to subsequence. Since h_i is only mildly regular, it is not clear to us whether $g_{\infty}(t)$ exists smoothly although the flow is expected to be static. Instead, we will regularize it further using the Ricci flow.

Claim 3.1. There is a Ricci-flat metric g_{∞} on M such that $g_i(T_0) \to g_{\infty}$ in $C^{0}(M)$ as $i \to \infty$ after passing to subsequence and pulling back by a sequence of diffeomorphism.

Proof of Claim [3.1.](#page-15-0) Since $g_i(T_0)$ is uniformly bounded in C^1 with respect to $h_i, g_i(T_0)$ is uniformly equivalent to h_i and $h_i \to h_\infty$ in $C^{1,\gamma}$. By passing to subsequence, we may assume $g_i(T_0) \to g_\infty(T_0)$ in C^γ for all $\gamma \in (0,1)$. In particular, for $\varepsilon > 0$ sufficiently small, there is $N \in \mathbb{N}$ such that for all $i > N$,

(3.3)
$$
(1 - \varepsilon)\overline{h} \le g_i(T_0) \le (1 + \varepsilon)\overline{h}, \quad |\nabla^{\overline{h}}g_i(T_0)|_{\overline{h}} \le C(\overline{h}, n, \Lambda, p_0),
$$

where $\bar{h} = g_N(T_0)$. Note that the constant C depends on \bar{h} , but is independent of i. In the following, all constants may possibly depend on \bar{h} , but are independent of i.

Let $\tilde{g}_i(s)$ be Ricci flow starting from $g_i(T_0)$. By [\[27,](#page-20-5) Lemma 4.3] with $\delta = 0$ (see also [\[28\]](#page-20-7)), there is a constant $S_0(h, n, \Lambda, p_0) > 0$ such that $\tilde{g}_i(s)$ exists on $M^n \times [0, S_0]$ and satisfies

(3.4)
$$
|\text{Rm}(\tilde{g}_i(s))| \le C(\bar{h}, n, \Lambda, p_0) s^{-1/2}
$$

provided that ε is sufficiently small depending only on n. In particular, $\tilde{q}_i(s)$ is uniformly equivalent to $\tilde{g}_i(0)$ and hence h_i for all $s \in [0, S_0]$ by integration on time. Here we have used the estimate of the Ricci-Deturck flow with reference metric h from [\[27,](#page-20-5) Lemma 4.3] and the fact that the Ricci-Deturck flow is diffeomorphic to the Ricci flow with the same initial data.

Since inj (h_i) is bounded from below, we have a uniform lower bound on $\text{inj}(\tilde{q}_i(s))$ thanks to the uniform equivalence of metrics. Together with Shi's estimates [\[26\]](#page-20-12) (see also [\[28,](#page-20-7) Theorem 4.3]) and Hamilton's compactness [\[16\]](#page-19-13), we can pass $\tilde{g}_i(s) \to \tilde{g}_{\infty}(s)$ in C^{∞} Cheeger-Gromov sense on $M \times (0, S_0]$ after passing to subsequence. More precisely, there is a sequence of diffeomorphism Ψ_i of M such that $\Psi_i^*\tilde{g}_i(s)$ converges to $g_\infty(s)$ in $C^{\infty}_{loc}(M\times (0, S])$. As usual, we will pull-back each metrics by Ψ_i and therefore will omit Ψ_i^* . We note that in this way, $\{\Psi_i^* h_i\}_{i=1}^{\infty}$ are not necessarily compact in $C^{1,\gamma}$ topology anymore due to the additional pull-back of diffeomorphism but it will remain uniformly equivalent to the Ricci flow $\tilde{q}_i(s)$ thanks to the curvature estimates in [\(3.4\)](#page-16-0).

It is well-known that Ricci flow preserved the lower bound of the scalar curvature, we have

(3.5)
$$
R_{\tilde{g}_i(s)} \ge R_{\tilde{g}_i(0)} = R_{g_i(T_0)} \ge -i^{-1},
$$

where we used [\(2.58\)](#page-11-3) in the last inequality. Letting $i \to \infty$, we obtain $R_{\tilde{g}_{\infty}(s)} \ge$ 0 for $s \in (0, S_0]$. By the assumption of $\sigma(M) \leq 0$ and uniqueness of the Ricci flow, $\tilde{g}_{\infty}(s) \equiv g_{\infty}$ on M for $s \in (0, S_0]$ for some Ricci-flat metric g_{∞} . Combining [\(3.4\)](#page-16-0) and the equation of Ricci-flow

(3.6)
$$
\frac{\partial \tilde{g}_{kl}}{\partial s} = -2 \text{Ric}(\tilde{g})_{kl}
$$

we obtain

$$
(3.7) \t\t |\tilde{g}_i(s) - g_i(T_0)|_{\tilde{g}_i(S_0)} = |\tilde{g}_i(s) - \tilde{g}_i(0)|_{\tilde{g}_i(S_0)} \leq C(\bar{h}, n, \Lambda, p_0) s^{\frac{1}{2}}.
$$

Combining this with $\tilde{g}_i(s) \to g_\infty$ in C_{loc}^{∞} on $(0, S_0]$, we conclude $g_i(T_0) =$ $\tilde{g}_i(0) \to g_\infty$ in $C^0(M)$ as $i \to \infty$.

Next, we claim that $g_i(t)$ converges to the same Ricci-flat metric g_{∞} .

Claim 3.2. For all $t \in (0, T_0]$, $g_i(t) \to g_{\infty}$ in C^0 as $i \to \infty$, where g_{∞} is the Ricci-flat metric obtain from Claim [3.1.](#page-15-0)

Proof. By Proposition [2.3,](#page-11-2) for $a \in (0, T_0]$, $g_i(t)$ is uniformly equivalent to $g_i(T_0)$ on $[a, T_0]$ and $-i^{-1} \le R_{g_i(t)} \le \lambda$. Using [\(2.63\)](#page-12-2), we compute

(3.8)
$$
\frac{\partial}{\partial t} \left(\int_M R_{g_i(t)} d\mu_{g_i(t)} \right) = \left(1 - \frac{n}{2} \right) \int_M R_{g_i(t)}^2 d\mu_{g_i(t)}
$$

$$
\geq -C(a, n, \Lambda, p_0) \left(\int_M R_{g_i(t)} d\mu_{g_i(t)} + i^{-1} \right).
$$

Hence, for all $t \in [a, T_0]$,

(3.9)
$$
\int_{M} R_{g_i(t)} d\mu_{g_i(t)} \leq C(a, n, \Lambda, p_0) \left(\int_{M} R_{g_i(T_0)} d\mu_{g_i(T_0)} + i^{-1} \right).
$$

We now estimate the integral of scalar curvature on the right hand side. We will make use of the smooth convergence of the Ricci-flow. The scalar curvature $R_{\tilde{g}_i(s)}$ satisfies (see e.g., [\[31,](#page-20-13) (2.5.5)])

.

(3.10)
$$
\left(\frac{\partial}{\partial s} - \Delta_{\tilde{g}_i(s)}\right) R_{\tilde{g}_i(s)} = 2 |\text{Ric}(\tilde{g}_i(s))|_{\tilde{g}_i(s)}^2
$$

By [\(3.4\)](#page-16-0) and [\(3.5\)](#page-16-1),

(3.11)
$$
-i^{-1} \leq R_{\tilde{g}_i(s)} \leq C(\bar{h}, n, \Lambda, p_0) s^{-\frac{1}{2}}.
$$

Then along the Ricci flow, we have

(3.12)
\n
$$
\frac{\partial}{\partial s} \left(\int_M R_{\tilde{g}_i(s)} d\mu_{\tilde{g}_i(s)} \right) = \int_M \left(2 \left| \text{Ric}(\tilde{g}_i(s)) \right|^2_{\tilde{g}_i(s)} - \left| R_{\tilde{g}_i(s)} \right|^2 \right) d\mu_{\tilde{g}_i(s)}
$$
\n
$$
\geq - C(a, \bar{h}, n, \Lambda, p_0) s^{-\frac{1}{2}} \left(\int_M R_{\tilde{g}_i(s)} d\mu_{\tilde{g}_i(s)} + i^{-1} \right).
$$

This shows

$$
(3.13) \qquad \int_M R_{g_i(T_0)} d\mu_{g_i(T_0)} = \int_M R_{\tilde{g}_i(0)} d\mu_{\tilde{g}_i(0)}
$$

$$
\leq C(a, \bar{h}, n, \Lambda, p_0) \left(\int_M R_{\tilde{g}_i(S_0)} d\mu_{\tilde{g}_i(S_0)} + i^{-1} \right).
$$

Using [\(3.9\)](#page-17-0), for all $t \in [a, T_0]$,

(3.14)
$$
\int_M R_{g_i(t)} d\mu_{g_i(t)} \leq C(a, \bar{h}, n, \Lambda, p_0) \left(\int_M R_{\tilde{g}_i(S_0)} d\mu_{\tilde{g}_i(S_0)} + i^{-1} \right).
$$

Combining this with $R_{g(t)} \geq -i^{-1}$ (see [\(2.58\)](#page-11-3)), we have

$$
(3.15) \qquad \int_M |R_{g_i(t)}| d\mu_{g_i(t)} \leq C(a, \bar{h}, n, \Lambda, p_0) \left(\int_M R_{\tilde{g}_i(S_0)} d\mu_{\tilde{g}_i(S_0)} + i^{-1} \right).
$$

By the similar computation of (2.77) and the fact that $g_i(t)$ is uniformly equivalent to h_i and hence $\tilde{g}_i(S_0)$, we have

(3.16)
\n
$$
\int_{M} |g_{i}(t) - g_{i}(T_{0})|_{g_{i}(T_{0})} d\mu_{g_{i}(T_{0})} \leq C \int_{a}^{T_{0}} \int_{M} |R_{g_{i}(s)}| d\mu_{g_{i}(T_{0})} ds
$$
\n
$$
\leq C(a, \bar{h}, n, \Lambda, p_{0}) \left(\int_{M} R_{\tilde{g}_{i}(S_{0})} d\mu_{\tilde{g}_{i}(S_{0})} + i^{-1} \right).
$$

Using Claim [3.1,](#page-15-0) the smooth convergence of $\tilde{g}_i(S_0)$ to g_∞ and the fact that $\text{Ric}(g_{\infty}) = 0$, we see that $g_i(t) \to g_{\infty}$ in $L^1(M, g_{\infty})$ as $i \to \infty$ for all $t \in$ [a, T_0]. By the uniform C^1 estimates from Proposition [2.3,](#page-11-2) we can improve the convergence to C^0 . This completes the proof since $a \in (0, T_0]$ is arbitrary. \Box

 \Box

We now prove the stability Theorem for manifolds with $\sigma(M) \leq 0$. This will imply Theorem [1.1](#page-1-0) and [1.2](#page-2-0) when $M = \mathbb{T}^n$ by Remark [3.1](#page-14-2) as Ricci-flat metric on torus is flat from the splitting Theorem of Cheeger-Gromov [\[10\]](#page-19-14).

Corollary 3.1. Under the assumption in Theorem [3.1,](#page-15-1) if $\text{diam}(M, g_{i,0})$ are uniformly bounded from above, then after passing to subsequence, $g_{i,0}$ converges to a Ricci-flat metric g_{∞} in the volume preserving intrinsic flat sense.

Proof. By (2.58) , the Yamabe flow $g_i(t)$ in Theorem [3.1](#page-15-1) satisfies

(3.17)
$$
\frac{\partial g_i}{\partial t} = -R_{g_i} g_i \leq i^{-1} g_i,
$$

which implies

(3.18)
$$
g_i(t) \le e^{-i^{-1}t} g_i(0) = e^{-i^{-1}t} g_{i,0}.
$$

In particular,

(3.19)
$$
g_i(T_0) \le e^{-i^{-1}T_0}g_{i,0}.
$$

By Theorem [3.1,](#page-15-1) $F_i^* g_i(T_0)$ converges to a Ricci-flat metric g_{∞} in $C^0(M)$ where $F_i = \Phi_i \circ \Psi_i$. By relabelling the index, we may assume without loss of generality that

$$
(3.20) \qquad \qquad \left(1 - \frac{1}{i}\right) g_{\infty} \le F_i^* g_{i,0}.
$$

The intrinsic flat convergence follows from [\(3.20\)](#page-18-0), volume convergence in Propo-sition [2.4](#page-12-3) and [\[3,](#page-19-15) Theorem 2.1].

Corollary 3.2 (Theorem [1.2\)](#page-2-0). Under the assumption in Theorem [3.1,](#page-15-1) if u_i are uniformly bounded from above, then there is a sequence of diffeomorphisms F_i of M such that after passing to subsequence, $F_i^*g_{i,0}$ converges to a Ricci-flat metric g_{∞} in $L^p(M, g_{\infty})$ for all $p > 0$. Moreover, $g_{i,0}$ converges to g_{∞} in the measured Gromov-Hausdorff sense.

Proof. The L^p convergence follows from Proposition [2.4](#page-12-3) and Theorem [3.1.](#page-15-1) As shown in proof of Theorem [3.1,](#page-15-1) $F_i^* h_i \leq C(n,\Lambda) \cdot F_i^* g_i(T_0)$ and $F_i^* g_i(T_0)$ converges to g_{∞} in $C^{0}(M)$. Combining this with [\(3.20\)](#page-18-0), we have

(3.21)
$$
\left(1-\frac{1}{i}\right)g_{\infty} \leq F_i^*g_{i,0} \leq C(n,\Lambda)g_{\infty}.
$$

for i sufficiently large. The measured Gromov-Hausdorff convergence follows from [\(3.21\)](#page-19-16), the L^p convergence and [\[4,](#page-19-17) Theorem 1.2].
