Bicomplex Mittag-Leffler Function and Properties

Abstract

With the increasing importance of the Mittag-Leffler function in the physical applications, these days many researchers are studying various generalizations and extensions of the Mittag-Leffler function. In this paper efforts are made to define bicomplex extension of the Mittag-Leffler function and also its analyticity and region of convergence are discussed. Various properties of the bicomplex Mittag-Leffler function including integral representation, recurrence relations, duplication formula and differential relations are established.

1 Introduction

Bicomplex numbers are being studied for quite a long time and a lot of work has been done in this area. Cockle [9, 10] introduced *Tessarines* between 1848 and 1850 following which Segre [35] introduced bicomplex numbers.

Many properties of the bicomplex numbers have been discovered. During the last few years developments have aimed to achieve different algebraic and geometric properties of bicomplex numbers and its applications (see, e.g. [6, 25, 30, 31, 33, 34]). In the recent developments, efforts have been done to extend the integral transforms [1, 2], holomorphic and meromorphic functions [6, 7, 8] a number of functions like Polygamma function [14], Hurwitz Zeta function [15], Gamma and Beta functions [16], Riemann Zeta function [30], bicomplex analysis and Hilbert space [18, 19, 20, 21, 22, 23] in the bicomplex variable from their complex counterparts.

Recently many researchers have worked on various generalizations and the extensions of the Mittag- Leffler function [4, 5, 12, 13, 17].

1.1 Bicomplex Numbers

Segre [35] defined the set of bicomplex numbers as:

Definition 1.1 (Bicomplex Number). In terms of real components, the set of bicomplex numbers is defined as

$$\mathbb{T} = \{ \xi : \xi = x_0 + i_1 x_1 + i_2 x_2 + j x_3 \mid x_0, x_1, x_2, x_3 \in \mathbb{R} \}, \tag{1}$$

and in terms of complex numbers it can be written as

$$\mathbb{T} = \{ \xi : \xi = z_1 + i_2 z_2 \mid z_1, \ z_2 \in \mathbb{C} \}. \tag{2}$$

We shall use the notations, $x_0 = \text{Re}(\xi)$, $x_1 = \text{Im}_{i_1}(\xi)$, $x_2 = \text{Im}_{i_2}(\xi)$, $x_3 = \text{Im}_{j}(\xi)$.

Segre discussed the presence of zero divisors which he called *Nullifics*. He noticed that the zero divisors in bicomplex numbers constitute two ideals which he called infinite set of nullifics. The set of all zero divisors is called null cone [32] defined as follows:

$$\mathbb{NC} = \mathbb{O}_2 = \{ z_1 + z_2 i_2 \mid z_1^2 + z_2^2 = 0 \}.$$
 (3)

Two non trivial idempotent zero divisors in \mathbb{T} , denoted by e_1 and e_2 and defined as follows [27]:

$$e_1 + e_2 = 1$$
, $e_1 \cdot e_2 = 0$, $e_1 = \frac{1 + i_1 i_2}{2} = \frac{1 + j}{2}$, $e_2 = \frac{1 - i_1 i_2}{2} = \frac{1 - j}{2}$, and $e_1^2 = e_1$, $e_2^2 = e_2$.

Definition 1.2 (Idempotent Representation). Every element $\xi \in \mathbb{T}$ has unique idempotent representation defined by

$$\xi = z_1 + i_2 z_2 = (z_1 - i_1 z_2)e_1 + (z_1 + i_1 z_2)e_2 = \xi_1 e_1 + \xi_2 e_2 \tag{4}$$

where $\xi_1 = (z_1 - i_1 z_2)$ and $\xi_2 = (z_1 + i_1 z_2)$.

Projection mappings $P_1: \mathbb{T} \to T_1 \subseteq \mathbb{C}$, $P_2: \mathbb{T} \to T_2 \subseteq \mathbb{C}$ for a bicomplex number $\xi = z_1 + i_2 z_2$ are defined as (see, e.g. [31]):

$$P_1(\xi) = P_1(z_1 + i_2 z_2) = P_1[(z_1 - i_1 z_2)e_1 + (z_1 + i_1 z_2)e_2] = (z_1 - i_1 z_2) \in T_1$$
 (5)

$$P_2(\xi) = P_2(z_1 + i_2 z_2) = P_2[(z_1 - i_1 z_2)e_1 + (z_1 + i_1 z_2)e_2] = (z_1 + i_1 z_2) \in T_2,$$
 (6) where

$$T_1 = \{ \xi_1 = z_1 - i_1 z_2 \mid z_1, z_2 \in \mathbb{C} \} \text{ and } T_2 = \{ \xi_2 = z_1 + i_1 z_2 \mid z_1, z_2 \in \mathbb{C} \}.$$
 (7)

Remark 1.3. The bicomplex space \mathbb{T} can be written as the product

$$\mathbb{T} = T_1 \times_e T_2 = \{ \xi_1 e_1 + \xi_2 e_2, \ \xi_1 \in T_1, \ \xi_2 \in T_2 \}. \tag{8}$$

Definition 1.4 (Modulus). Let $\xi = z_1 + i_2 z_2 \in \mathbb{T}$ (see, e.g. [31]). The real modulus of ξ is defined as

$$|\xi| = \sqrt{|z_1|^2 + |z_2|^2}. (9)$$

The i_1 -modulus of ξ is defined as

$$|\xi|_{i_1} = \sqrt{z_1^2 + z_2^2}. (10)$$

The i_2 -modulus of ξ is defined as

$$|\xi|_{i_2} = \sqrt{(|z_1|^2 - |z_2|^2) + 2\operatorname{Re}(z_1\bar{z_1})i_2}.$$
 (11)

The j-modulus of ξ is defined as

$$|\xi|_{j} = |z_{1} - i_{1}z_{2}|e_{1} + |z_{1} + i_{1}z_{2}|e_{2}.$$

$$(12)$$

Definition 1.5 (Norm). Let $\xi = z_1 + i_2 z_2 = \xi_1 e_1 + \xi_2 e_2 = x_0 + x_1 i_1 + x_2 i_2 + x_3 j \in \mathbb{T}$ (see, e.g. [3, 28]) then the norm of ξ is given by

$$\|\xi\| = \sqrt{|z_1|^2 + |z_2|^2} = \frac{1}{\sqrt{2}} \sqrt{|\xi_1|^2 + |\xi_2|^2} = \sqrt{x_0^2 + x_1^2 + x_2^2 + x_3^2}.$$
 (13)

Definition 1.6. Let $\xi = z_1 + i_2 z_2 = \xi_1 e_1 + \xi_2 e_2 = x_0 + x_1 i_1 + x_2 i_2 + x_3 j \in \mathbb{T}$ (see, e.g. [28]) then absolute value of ξ is denoted by $|\xi|_{abs}$, and is defined as

$$|\xi|_{abs} = \sqrt{|z_1^2 + z_2^2|} = \sqrt{|(z_1 - i_1 z_2)(z_1 + i_1 z_2)|} = \sqrt{|\xi_1 \xi_2|} = \sqrt{|\xi_1||\xi_2|}.$$
 (14)

Definition 1.7 (Argument). Let $\xi = z_1 + i_2 z_2 = \xi_1 e_1 + \xi_2 e_2 = x_0 + x_1 i_1 + x_2 i_2 + x_3 j \in \mathbb{T}$ then hyperbolic argument (see, e.g. [24]) of ξ is given by:

$$\arg_j(\xi) = \arg(\xi_1)e_1 + \arg(\xi_1)e_2.$$
 (15)

Let U be an open set, and $g: U \subseteq \mathbb{T} \to \mathbb{T}$ (see, e.g. [30, 34]). Also $g(z_1 + i_2 z_2) = g_1(z_1, z_2) + i_2 g_2(z_1, z_2)$, then g is \mathbb{T} -holomorphic iff g_1 and g_2 are holomorphic in U and

$$\frac{\partial g_1}{\partial z_1} = \frac{\partial g_2}{\partial z_2}$$
 and $\frac{\partial g_2}{\partial z_1} = -\frac{\partial g_1}{\partial z_2}$ on U . (16)

These equations are called the bicomplex Cauchy-Riemann equations (abbr. bicomplex CR-equations).

$$g' = \frac{\partial g_1}{\partial z_1} + i_2 \frac{\partial g_2}{\partial z_1}. (17)$$

In the following theorem, Riley [28] studied the convergence of bicomplex power series.

Theorem 1.8. Let

$$N(\xi) = \sqrt{\|\xi\|^2 + \sqrt{\|\xi\|^4 - |\xi|_{abs}^4}} = \max(|\xi_1|, |\xi_2|)$$
 (18)

then $N(\xi)$ is a norm and if $\sum_{n=0}^{\infty} a_n \xi^n$ is a power series with component series $\sum_{n=0}^{\infty} b_n \xi_1^n$ and $\sum_{n=0}^{\infty} c_n \xi_2^n$, $a_n = b_n e_1 + c_n e_2$ both have same radius of convergence R > 0 then $\sum_{n=0}^{\infty} a_n \xi^n$ converges for $N(\xi) < R$ and diverges for $N(\xi) > R$, where $\|\xi\| = \frac{1}{\sqrt{2}} \sqrt{|\xi_1|^2 + |\xi_2|^2}$ and $|\xi|_{abs} = \sqrt{|\xi_1| |\xi_2|}$.

In the following theorem, Ringleb [29] (see, e.g. [28]) discussed the analyticity of a bicomplex function w.r.t. its idempotent complex component functions. This theorem plays a vital role while discussing the convergence of the bicomplex functions.

Theorem 1.9 (Decomposition theorem of Ringleb [29]). Let f(z) be analytic in a region \mathbb{T} , and let T_1 and T_2 be the component regions of \mathbb{T} , in the ξ_1 and ξ_2 planes, respectively. Then there exists a unique pair of complex-valued analytic functions, $f_1(\xi_1)$ and $f_2(\xi_2)$, defined in T_1 and T_2 , respectively, such that

$$f(z) = f_1(\xi_1)e_1 + f_2(\xi_2)e_2 \tag{19}$$

for all ξ in \mathbb{T} . Conversely, if $f_1(\xi_1)$ is any complex-valued analytic function in a region T_1 and $f_2(\xi_2)$ any complex-valued analytic function in a region T_2 then the bicomplex-valued function f(z) defined by the equation (19) is an analytic function of the bicomplex variable ξ in the product-region $\mathbb{T} = T_1 \times_e T_2$ (equation (8)).

In the Theorem 1.10, Price [27] studied the integration in bicomplex domain w.r.t. its idempotent representation. This theorem plays a basic role in the study of integrals of the bicomplex function.

Theorem 1.10. Let $X \subseteq \mathbb{T}$. Let C_1 , C_2 be two curves defined as

$$C_1: z_1 - i_2 z_2 = z_1(t) - i_1 z_2(t) = \xi_1 = \xi_1(t), \ a \le t \le b.$$
 (20)

$$C_2: z_1 + i_2 z_2 = z_1(t) + i_1 z_2(t) = \xi_2 = \xi_2(t), a \le t \le b.$$
 (21)

which have continuous derivatives and whose traces are in $X_1 \subseteq T_1$, $X_2 \subseteq T_2$ respectively and let C be the curve with trace in X which is defined as

$$C: \xi(t) = \xi_1(t)e_1 + \xi_2(t)e_2, \ a \le t \le b$$
(22)

Then the integrals of f, f_1 , f_2 on the curves C, C_1 and C_2 exists and

$$\int_{C} f(\xi)d\xi = \int_{C_1} f_1(z_1 - i_1 z_2)d(z_1 - i_1 z_2)e_1 + \int_{C_2} f_1(z_1 + i_1 z_2)d(z_1 + i_1 z_2)e_2 \quad (23)$$

or

$$\int_{C} f(\xi)d\xi = \int_{C_1} f_1(\xi_1)d(\xi_1)e_1 + \int_{C_2} f_2(\xi_2)d(\xi_2)e_2.$$
 (24)

We would require the definition of the bicomplex gamma function defined by Goyal et al. [16], in the Euler product form as follows:

$$\frac{1}{\Gamma \xi} = \xi e^{\gamma \xi} \prod_{n=1}^{\infty} \left(\left(1 + \frac{\xi}{n} \right) exp\left(-\frac{\xi}{n} \right) \right), \ \xi \in \mathbb{T}$$
 (25)

provided that $z_1 \neq \frac{-(m+l)}{2}$, and $z_2 \neq i_1(\frac{l-m}{2})$ where $m, l \in \mathbb{N} \cup \{0\}$. The Euler constant $\gamma(0 \leq \gamma \leq 1)$ is given by

$$\gamma = \lim_{n \to \infty} (H_n - \log n), \ H_n = \sum_{k=1}^n \frac{1}{k}.$$
 (26)

Also, in idempotent form

$$\Gamma \xi = \Gamma \xi_1 e_1 + \Gamma \xi_2 e_2, \ \xi \in \mathbb{T}, \tag{27}$$

and in the integral form (see, e.g.[16]), for $p = p_1e_1 + p_2e_2$, $p_1, p_2 \in \mathbb{R}^+$.

$$\Gamma \xi = \int_{H} e^{-p} p^{\xi - 1} dp = \left(\int_{0}^{\infty} e^{-p_{1}} p_{1}^{\xi_{1} - 1} dp_{1} \right) e_{1} + \left(\int_{0}^{\infty} e^{-p_{2}} p_{2}^{\xi_{2} - 1} dp_{2} \right) e_{2}$$
 (28)

where $H = (\gamma_1, \gamma_2)$ and $\gamma_1 : 0$ to ∞ , $\gamma_2 : 0$ to ∞ .

Mittag-Leffler Function and its Properties

The Mittag-Leffler function (M-L function) comes intrinsically in the study of the fractional calculus. The importance of the M-L function in science and engineering is continuously increasing. It is very useful in the area of fractional modeling.

The one parameter M-L function defined by Mittag-Leffler [26] is given by

$$\mathbb{E}_{\alpha}(z) = \sum_{k=0}^{\infty} \frac{z^k}{\Gamma(\alpha k + 1)}, \quad \text{Re}(\alpha) > 0, \quad z \in \mathbb{C}.$$
 (29)

It comes from the Cauchy inequality for the Taylor coefficients and properties of the Gamma function (see, e.g.[13, p.18]) that \exists a number $k \geq 0$ and a positive number r(k) such that

$$M_{\mathbb{E}_{\alpha}(r)} = \max_{|z|=r} |\mathbb{E}_{\alpha}(z)| < e^{r^k}, \ \forall r > r(k).$$
(30)

hence $\mathbb{E}_{\alpha}(z)$ is an entire function of finite order.

For each $Re(\alpha) > 0$ the order ρ and type σ of M-L function (29) is given by

$$\rho = \lim \sup_{k \to \infty} \frac{k \log k}{\log \frac{1}{|a_k|}} = \frac{1}{\operatorname{Re}(\alpha)}$$
(31)

and

$$\sigma = \frac{1}{e\rho} \lim \sup_{k \to \infty} (k|a_k|^{\frac{\rho}{k}}) = 1.$$
 (32)

2 Bicomplex one-parameter Mittag-Leffler function

Here, we introduce the bicomplex one parameter Mittag-Leffler function defined by

$$\mathbb{E}_{\alpha}(\xi) = \sum_{k=0}^{\infty} \frac{\xi^k}{\Gamma(\alpha k + 1)},\tag{33}$$

where $\xi, \alpha \in \mathbb{T}$, $\xi = z_1 + i_2 z_2$ and $|\operatorname{Im}_{j}(\alpha)| < \operatorname{Re}(\alpha)$.

The definition of bicomplex M-L function is well justified by the following theorem.

Theorem 2.1. Let $\xi, \alpha \in \mathbb{T}$ where $\xi = z_1 + i_2 z_2 = \xi_1 e_1 + \xi_2 e_2$, $\alpha = \alpha_1 e_1 + \alpha_2 e_2 = a_0 + i_1 a_1 + i_2 a_2 + i_1 i_2 a_3$, with $|\operatorname{Im}_{\mathbf{j}}(\alpha)| < \operatorname{Re}(\alpha)$. Then

$$\mathbb{E}_{\alpha}(\xi) = \sum_{k=0}^{\infty} \frac{\xi^k}{\Gamma(\alpha k + 1)}.$$
 (34)

Proof. Consider the function

$$\mathbb{E}_{\alpha}(\xi) = \sum_{k=0}^{\infty} \frac{\xi^k}{\Gamma(\alpha k + 1)}.$$
 (35)

By using the idempotent representation

$$\mathbb{E}_{\alpha}(\xi) = \sum_{k=0}^{\infty} \frac{\xi_1^k}{\Gamma(\alpha_1 k + 1)} e_1 + \sum_{k=0}^{\infty} \frac{\xi_2^k}{\Gamma(\alpha_2 k + 1)} e_2$$

$$= \mathbb{E}_{\alpha_1}(\xi_1) e_1 + \mathbb{E}_{\alpha_2}(\xi_2) e_2,$$
(36)

where $\xi = \xi_1 e_1 + \xi_2 e_2$ and $\alpha = \alpha_1 e_1 + \alpha_2 e_2$. Now,

$$\mathbb{E}_{\alpha_1}(\xi_1) = \sum_{k=0}^{\infty} \frac{\xi_1^k}{\Gamma(\alpha_1 k + 1)},\tag{37}$$

is the complex M-L function convergent for $\text{Re}(\alpha_1) > 0$, $\xi_1 \in \mathbb{C}$. Similarly,

$$\mathbb{E}_{\alpha_2}(\xi_2) = \sum_{k=0}^{\infty} \frac{\xi_2^k}{\Gamma(\alpha_2 k + 1)},\tag{38}$$

is also complex M-L function convergent for $\operatorname{Re}(\alpha_2) > 0$, $\xi_2 \in \mathbb{C}$. Since $\mathbb{E}_{\alpha_1}(\xi_1)$ and $\mathbb{E}_{\alpha_2}(\xi_2)$ are convergent in T_1 , T_2 respectively, by Ringleb decomposition theorem (35) is also convergent in \mathbb{T} . Further, Let

$$\alpha = a_0 + i_1 a_1 + i_2 a_2 + i_1 i_2 a_3 = \alpha_1 e_1 + \alpha_2 e_2,$$
(39)

where $\alpha_1 = (a_0 + a_3) + i_1(a_1 - a_2)$ and $\alpha_2 = (a_0 - a_3) + i_1(a_1 + a_2)$.

Since $Re(\alpha_1) > 0$ and $Re(\alpha_2) > 0$

$$\Rightarrow a_0 + a_3 > 0 \text{ and } a_0 - a_3 > 0.$$
 (40)

$$\Rightarrow |a_3| < a_0.$$
 (41)

$$\Rightarrow |\operatorname{Im}_{j}(\alpha)| < \operatorname{Re}(\alpha).$$
 (42)

This completes the proof.

By substituting the value of the bicomplex gamma function defined by equation (25) in the equation (36) we get the following representation for Mittag-Leffler function:

Theorem 2.2. Let $\xi, \alpha \in \mathbb{T}$ where $\xi = z_1 + i_2 z_2 = \xi_1 e_1 + \xi_2 e_2$, $\alpha = a_0 + i_1 a_1 + i_2 a_2 + i_1 i_2 a_3 = \alpha_1 e_1 + \alpha_2 e_2$, with $|\operatorname{Im}_{\mathbf{i}}(\alpha)| < \operatorname{Re}(\alpha)$. then

$$\mathbb{E}_{\alpha}(\xi) = \sum_{k=0}^{\infty} \xi^{k} (\alpha k + 1) e^{\gamma(\alpha k + 1)} \prod_{n=1}^{\infty} \left(\left(1 + \frac{(\alpha k + 1)}{n} \right) exp\left(-\frac{(\alpha k + 1)}{n} \right) \right). \tag{43}$$

Remark 2.3. Also, in integral form, bicomplex M-L function can be represented as

$$\mathbb{E}_{\alpha}(\xi) = \sum_{k=0}^{\infty} \frac{\xi^k}{\int_{H} e^{-p} p^{\alpha k} dp}.$$
(44)

where $H = (\gamma_1, \gamma_2)$ as defined in (25).

For different values of the α we obtain various bicomplex functions as special cases. To mention, a few are:

- 1. For $\alpha = 0$ we get bicomplex binomial function $\mathbb{E}_0(\xi) = \frac{1}{1-\xi}$, $\|\xi\| < 1$.
- 2. For $\alpha = 1$ we get bicomplex exponential function $\mathbb{E}_1(\pm \xi) = e^{\pm \xi}$.
- 3. For $\alpha = 2$ we get bicomplex cosine function $\mathbb{E}_2(-\xi^2) = \cos \xi$.
- 4. For $\alpha = 2$ we get bicomplex hyperbolic cosine function $\mathbb{E}_2(\xi^2) = \cosh \xi$.
- 5. For $\alpha = 3$ we get following function $\mathbb{E}_3(\xi) = \frac{1}{2} \left(e^{\xi^{1/3}} + 2e^{-(1/2)\xi^{1/3}} \cos\left(\frac{\sqrt{3}}{2}\xi^{1/3}\right) \right)$.
- 6. For $\alpha = 4$ we get following bicomplex relation $\mathbb{E}_4(\xi) = \frac{1}{2} \left(\cos(\xi^{1/4}) + \cosh(\xi^{1/4}) \right)$.

Theorem 2.4. The bicomplex Mittag-Leffler function defined in equation (34) satisfies bicomplex Cauchy - Riemann equations.

Proof. By the result (36) we have,

$$\mathbb{E}_{\alpha}(\xi) = \mathbb{E}_{\alpha_{1}}(\xi_{1})e_{1} + \mathbb{E}_{\alpha_{2}}(\xi_{2})e_{2}
= \mathbb{E}_{\alpha_{1}}(z_{1} - i_{1}z_{2})e_{1} + \mathbb{E}_{\alpha_{2}}(z_{1} + i_{1}z_{2})e_{2}
= \mathbb{E}_{\alpha_{1}}(z_{1} - i_{1}z_{2})\left(\frac{1 + i_{1}i_{2}}{2}\right) + \mathbb{E}_{\alpha_{2}}(z_{1} + i_{1}z_{2})\left(\frac{1 - i_{1}i_{2}}{2}\right)
= \left(\frac{1}{2}\left(\mathbb{E}_{\alpha_{1}}(z_{1} - i_{1}z_{2}) + \mathbb{E}_{\alpha_{2}}(z_{1} + i_{1}z_{2})\right)\right)
+ i_{2}\left(\frac{i_{1}}{2}\left(\mathbb{E}_{\alpha_{1}}(z_{1} - i_{1}z_{2}) - \mathbb{E}_{\alpha_{2}}(z_{1} + i_{1}z_{2})\right)\right)
= f_{1}(z_{1}, z_{2}) + i_{2}f_{2}(z_{1}, z_{2}).$$
(45)

where $f_1(z_1, z_2) = \frac{1}{2} \left(\mathbb{E}_{\alpha_1}(z_1 - i_1 z_2) + \mathbb{E}_{\alpha_2}(z_1 + i_1 z_2) \right)$, and $f_2(z_1, z_2) = \frac{i_1}{2} \left(\mathbb{E}_{\alpha_1}(z_1 - i_1 z_2) - \mathbb{E}_{\alpha_2}(z_1 + i_1 z_2) \right)$. $\mathbb{E}_{\alpha_i}(i = 1, 2)$ are complex M-L functions. Now,

$$\frac{\partial f_1}{\partial z_1} = \frac{1}{2} \left(\mathbb{E}'_{\alpha_1}(z_1 - i_1 z_2) + \mathbb{E}'_{\alpha_2}(z_1 + i_1 z_2) \right),
\frac{\partial f_1}{\partial z_2} = \frac{-i_1}{2} \left(\mathbb{E}'_{\alpha_1}(z_1 - i_1 z_2) - \mathbb{E}'_{\alpha_2}(z_1 + i_1 z_2) \right),
\frac{\partial f_2}{\partial z_1} = \frac{i_1}{2} \left(\mathbb{E}'_{\alpha_1}(z_1 - i_1 z_2) - \mathbb{E}'_{\alpha_2}(z_1 + i_1 z_2) \right),
\frac{\partial f_2}{\partial z_2} = \frac{1}{2} \left(\mathbb{E}'_{\alpha_1}(z_1 - i_1 z_2) + \mathbb{E}'_{\alpha_2}(z_1 + i_1 z_2) \right).$$

from the above equations it can be observed that

Hence, bicomplex Cauchy-Riemann equations are satisfied by the bicomplex M-L function.

Theorem 2.5. The bicomplex M-L function $\mathbb{E}_{\alpha}(\xi)$, $|\operatorname{Im}_{j}(\alpha)| < \operatorname{Re}(\alpha)$ is an entire function in the bicomplex domain.

Proof. Let $\sum_{n=0}^{\infty} a_n \xi^n$ represents a bicomplex power series where a_n , ξ , $\in \mathbb{T}$, $a_n = b_n e_1 + c_n e_2$, $\xi = \xi_1 e_1 + \xi_2 e_2$. Then by Ringleb decomposition theorem 1.9, the series

Hence from Theorem 1.8, $\mathbb{E}_{\alpha}(\xi)$ converges in the bicomplex domain and has infinite radius of convergence [28]. Since complex M-L function is entire function in \mathbb{C} the bicomplex M-L function is an entire function in \mathbb{T} (Riley [28, p.141]).

Theorem 2.6 (Order and Type). The bicomplex Mittag-Leffler function $\mathbb{E}_{\alpha}(\xi)$, ξ , $\alpha \in \mathbb{T}$ is an entire function of finite order $\rho = \frac{a_0 - a_3 j}{(a_0^2 - a_3^2)}$ and type $\sigma = 1$.

$$\leq e^{r^{k}} e_{1} + e^{r^{k}} e_{2}, \quad \forall r > r(k)$$

$$= e^{r^{k}}.$$
(56)

Hence $\mathbb{E}_{\alpha}(z)$ is an entire function of finite order.

For the bicomplex M-L function ξ , $\alpha \in \mathbb{T}$, $|\operatorname{Im}_{j}(\alpha)| < \operatorname{Re}(\alpha)$. (from equation (41)) the order ρ is given by

Remark 2.7. There are different moduli such as real, i_1 , i_2 and j modulus are defined for a bicomlex number (see, e.g. [31]). In this paper, j modulus has been used for the calculation, since it provides expression in terms of idempotent components of the complex modulus.

2.1 Properties of Bicomplex Mittag-Leffler Function

$$\Rightarrow \operatorname{Re} \xi = 1, \ \operatorname{Im}_{j} \xi = 0.$$

$$\Rightarrow \operatorname{Re} \xi^{1/\alpha} = 1, \ \operatorname{Im}_{j} \xi = 0.$$

The complex Mittag-Leffler function has following integral representation (see, e.g. [11])

$$\mathbb{E}_{\alpha}(z) = \frac{1}{2\pi i} \int_{\Omega} \frac{t^{\alpha - 1} e^t}{t^{\alpha} - z} dt, \ \alpha > 0, \ z \in \mathbb{C}$$

where the path of integration Ω is a loop starting and ending at $-\infty$ and encircling the circular disk $|t| \leq |z|^{1/\alpha}$ in the positive sense, $|\arg t| < \pi$ on Ω .

Theorem 2.9. Let ξ , $\omega \in \mathbb{T}$ where $\xi = z_1 + i_2 z_2 = \xi_1 e_1 + \xi_2 e_2$, $\omega = \omega_1 e_1 + \omega_2 e_2$ then bicomplex Mittag-Leffler function has following integral representation

where the path of integration $H = (\Omega_1, \Omega_2)$ and Ω_1, Ω_2 are loops starting and ending at $-\infty$ and encircling the circular disks $|\omega_1| \leq |\xi_1|^{1/\alpha}$, $|\omega_2| \leq |\xi_2|^{1/\alpha}$, respectively, in the positive sense, $|\arg \omega_1| < \pi$ on Ω_1 and $|\arg \omega_1| < \pi$ on Ω_1 , Ω_2 .

$$\frac{d^p}{d\xi^p} \mathbb{E}_{p/q}(\xi^{p/q}) = \sum_{k=1}^{q-1} \frac{\xi^{-kp/q}}{\Gamma(1 - kp/q)} + \mathbb{E}_{p/q}(\xi^{p/q}).$$
(80)

Theorem 2.13. The function $\mathbb{E}_n(\xi^n)$ (n = 1, 2, 3, ...) satisfies the nth order ordinary differential equation

$$\frac{d^n}{d\xi^n} \left(\mathbb{E}_n(\xi^n) \right) = \mathbb{E}_n(\xi^n), \tag{81}$$

where $\xi \in \mathbb{T}$.

Proof. For $\alpha > 0$, By replacing ξ by ξ^{α} in the equation (34), we get

$$\mathbb{E}_{\alpha}(\xi^{\alpha}) = \sum_{k=0}^{\infty} \frac{\xi^{\alpha k}}{\Gamma(\alpha k + 1)}$$

$$= 1 + \frac{\xi^{\alpha}}{\Gamma(\alpha + 1)} + \frac{\xi^{2\alpha}}{\Gamma(2\alpha + 1)} + \frac{\xi^{3\alpha}}{\Gamma(3\alpha + 1)} + \dots$$
(82)

By taking derivative of order α on both sides of the equation (82), we get

$$D^{\alpha}\left(\mathbb{E}_{\alpha}(\xi^{\alpha})\right) = D^{\alpha}\left(1 + \frac{\xi^{\alpha}}{\Gamma(\alpha+1)} + \frac{\xi^{2\alpha}}{\Gamma(2\alpha+1)} + \frac{\xi^{3\alpha}}{\Gamma(3\alpha+1)} + \ldots\right)$$

$$= \frac{\Gamma(1)}{\Gamma(1-\alpha)}\xi^{-\alpha} + \frac{\Gamma(\alpha+1)}{\Gamma(1)}\frac{1}{\Gamma(\alpha+1)} + \frac{\Gamma(2\alpha+1)}{\Gamma(\alpha+1)}\frac{\xi^{\alpha}}{\Gamma(2\alpha+1)}$$

$$+ \frac{\Gamma(3\alpha+1)}{\Gamma(2\alpha+1)}\frac{\xi^{2\alpha}}{\Gamma(3\alpha+1)} + \ldots$$

$$= \frac{\Gamma(1)}{\Gamma(1-\alpha)}\xi^{-\alpha} + 1 + \frac{\xi^{\alpha}}{\Gamma(\alpha+1)} + \frac{\xi^{2\alpha}}{\Gamma(2\alpha+1)} + \ldots$$
(83)

Since $\frac{1}{\Gamma(1-\alpha)} = 0$ for $\alpha = n \in \mathbb{N}$, we get from equation (83),

$$D^{n}\left(\mathbb{E}_{n}(\xi^{n})\right) = 1 + \frac{\xi^{n}}{\Gamma(n+1)} + \frac{\xi^{2n}}{\Gamma(2n+1)} + \dots$$

$$= \sum_{k=0}^{\infty} \frac{\xi^{nk}}{\Gamma(nk+1)}$$

$$= \mathbb{E}_{n}(\xi^{n}).$$
(84)

3 Conclusion

In this paper, one parameter M-L function and its properties in bicomplex space has been defined from its complex counterpart. Various properties and the special cases along with recurrence relations, duplication formula, integral representation, differential relation are also derived. We intend to extend the concepts of the fractional calculus in bicomplex space using M-L function. Since bicomplex space provides a more generalized approach towards the large class of functions appearing in signal theory, electromagnetism and quantum theory.
