# Well-posedness of a time-harmonic elasticity problem in a half-strip

#### Abstract

In this paper we establish that the time-harmonic elasticity problem in a half-strip with non-homogeneous Dirichlet conditions on its boundary section and traction-free conditions on its upper and lower boundaries, has a unique weak solution when this solution is searched under the form of the sum of a linear combination of outgoing waves and an exponentialy decreasing function (in the sense of weighted Sobolev spaces).

## 1 Introduction.

The diffraction of elastic waves by a defect in a plate (for example in the context of non-destructive testing) can be modelled using Lamb modes. Lamb modes are obtained by searching solutions to the time-harmonic elasticity equations in a plate assuming an invariance with respect to the direction in the plate orthogonal to the direction of wave propagation, and then the problem in the plate is reduced to a problem in a strip. But a fundamental issue (among others) is to reduce the problem of diffraction by a defect which is posed in an unbounded strip to a problem posed in a bounded strip. For that one must find a framework where the time-harmonic elasticity problem in a half-strip with non-homogeneous Dirichlet conditions on its boundary section is well-posed. If there exists such a framework, then it is possible to define a Dirichlet-to-Neumann operator on a boundary section of a bounded strip containing the defect (by continuity of the displacement and the traction on this section), in order to prescribe appropriate boundary conditions on it, and thus to reduce the problem to a problem posed in a bounded strip. It is the purpose of the present paper to find such a framework and to prove a result of well-posedness.

More precisely we consider the time-harmonic elasticity problem in a half-strip with non-homogeneous

[^0]Dirichlet conditions on its boundary section, traction-free conditions on its upper and lower boundaries and appropriate radiation conditions. The radiation conditions consist in searching the solution under the form of the sum of a linear combination of outgoing waves and an exponentialy decreasing function (in the sense of weighted Sobolev spaces). The main theorem of this paper is Theorem 9.2 which establishes the existence and uniqueness of a weak solution (namely in the variational sense) to the equations of time-harmonic elasticity in a half-strip satisfying the aforementioned boundary conditions and radiation conditions. The author was unable to find a complete proof of the well-posedness of this problem in the literature, despite the simplicity of its statement. The uniqueness of a solution to it has been proved for example in [16, Theorem 1 or in [2], Theorem 2.1. The present paper proves the existence of a solution to this problem. The proofs of the present paper are based on the methods of the books [18], [10] and of the paper [3]. However, the framework in the present paper which is the variational framework is not the same as that of references [18], [10] and we give here detailed proofs with precise references to justify the assertions. Note that in [17], Theorem 5.1, a result linked with Theorem 9.2 is stated and for the proof the reader is referred to the book [18]. But in [18] it is impossible to find the precise result [17], Theorem 5.1. In [18] the theorem which is closer to Theorem 5.1 of [17] is Theorem 3.5, p. 160 and it is not obvious at all that this theorem implies Theorem 5.1 of 17 .

Essential tools of the proofs in this paper are the use of weighted Sobolev spaces in order to take into account the exponential growth or decay of the solutions at infinity, the fundamental Proposition 5.1 which gives an asymptotic expansion of the solution to the time-harmonic elasticity problem in a strip with respect to the eigenvectors and generalized eigenvectors of the corresponding spectral problem (Lamb modes and associated modes are a part of these eigenvectors), the complex symplectic form (8.6) which provides a way to distinguish outgoing and incoming waves and the Fredholm property of some operators. The paper is basically self-contained and is the opportunity to give complete, and in some instances, new or simpler proofs of rather classical results.

The paper is organized as follows. In section 2 the systems of equations of the time-harmonic elasticity problems in a strip and in a half-strip are written in a formal form. The weighted Sobolev spaces for a strip are introduced in section 3. In section 4 we give a sufficient condition in order to establish the wellposedness of the time-harmonic elasticity problem in a strip (Theorem 4.1). This kind of result is fairly classical (see [10, Chapter 5, 18, Chapter 3). But in this paper we consider weak solutions and the given proof is rather an adaptation of the proof of Theorem 5.1 of 3]. In section 5 we establish an asymptotics of the solution to the previous problem (Proposition 5.1). There to this kind of result is quite classical (see [10], Chapter 5, 18], Chapter 3) but here we consider weak solutions and the proofs must be adapted. Moreover it should be noted that the proof of the corresponding result in [10], Chapter 5 is not correct as it is and that the calculus of the coefficients of the asymptotics (formula (5.15)) is more straightforward in the present proof than in the aforementioned references (see Remark 5.1). Section 6 is devoted to the Fredholm property of the operator (Eq. (6.2)) associated to the variational formulation of the half-strip
problem (Proposition 6.2). For that purpose an essential tool is Proposition 6.1. The method of proof of this proposition is similar to that of Theorem 5.3 of [3]. However the boundary conditions are not the same on the upper and lower parts of the strip (Neumann in the present paper versus Dirichlet in [3]), and the proof of Proposition 6.1 relies on a precise form of Korn inequality (Theorem6.2), which itself is an application of Theorem 3.1 of [7] (Theorem 6.1). In section 7 we establish an asymptotics of a solution to the half-strip problem (Proposition 7.1). In section 8 we introduce the sesquilinear antihermitian form $q_{\Omega_{+}}$(Eq. (8.6) ). In Proposition 8.1 we show that this form is nondegenerate so that it is symplectic. This form makes it possible to distinguish outgoing and incoming waves according to the Mandelstam radiation principle. In section 9 we show that the half-strip problem is well-posed (Theorem 9.2) under Assumption 8.1. In appendix $A$ we recall classical results on operator pencils, in appendix $B$ we establish lemmas showing the linear independence of some families of functions and in appendix $\mathbb{C}$ we give a new proof of an important result but in the variational framework.

## 2 Set-up of the problem.

In the sequel we shall use the following notations. The set of natural numbers will be denoted by $\mathbb{N}$ (containing 0 ) and the set of positive natural numbers by $\mathbb{N}^{*}(=\mathbb{N} \backslash\{0\})$. If $E$ is a Banach space, denote by $E^{*}$ its topological dual, $\langle.,$.$\rangle the duality bracket between E^{*}$ and $E$ (the context will determine the involved Banach space) and if $f \in E^{*}$ its norm is defined by $\|f\|_{E^{*}}=\sup _{u \in E,\|u\| \leq 1}|\langle f, u\rangle|$. If $n, m \in \mathbb{N}^{*}$ and $\Omega$ is an open set of $\mathbb{R}^{n}$, the set of $\mathcal{C}^{\infty}$ functions from $\Omega$ (resp. $\bar{\Omega}$ ) with values in $\mathbb{R}^{m}$ will be denoted by $\mathcal{C}^{\infty}\left(\Omega, \mathbb{R}^{m}\right)$ (resp. $\mathcal{C}^{\infty}\left(\bar{\Omega}, \mathbb{R}^{m}\right)$ ), with similar notations for functions with values in $\mathbb{C}^{m}$ and for functions with compact support in $\Omega$ (resp. $\bar{\Omega}$ ), where $\mathcal{C}^{\infty}$ is replaced by $\mathcal{C}_{0}^{\infty}$. If $k \in \mathbb{N}$, the set of functions from $\Omega$ with values in $\mathbb{R}^{m}$ whose components are in the Sobolev space $H^{k}(\Omega)$ will be denoted by $H^{k}\left(\Omega, \mathbb{R}^{m}\right)$, with similar notations for functions with values in $\mathbb{C}^{m}$ (if $k=0, H^{0}$ is replaced by $L^{2}$ ). The inner product in $H^{k}\left(\Omega, \mathbb{R}^{m}\right)$ or $H^{k}\left(\Omega, \mathbb{C}^{m}\right)$ will be denoted by $(., .)_{k, \Omega}$, the associated norm by $\|.\|_{k, \Omega}$, the associated semi-norm by $|\cdot|_{k, \Omega}$ and the norm in the topological dual $\left(H^{k}\left(\Omega, \mathbb{R}^{m}\right)\right)^{*}$ or $\left(H^{k}\left(\Omega, \mathbb{C}^{m}\right)\right)^{*}$ by $\|\cdot\|_{k, \Omega, *}$. Recall that the word "iff" means "if and only if". We shall use the Einstein summation convention of repeated indices.

Let us consider a linearly elastic plate of thickness $2 h(h>0)$ occupying the open set $\Omega_{1}$ of $\mathbb{R}^{3}$ :

where $\omega_{h}=(-h, h)$. The plate is assumed to be homogeneous and isotropic (with Lamé coefficients $\lambda$ and $\mu$ satisfying the conditions $3 \lambda+2 \mu>0$ and $\mu>0$, see [19], p.341), with mass density $\rho$ and traction-free on the upper and lower boundary. Denote by $u=\left(u_{i}\right), \varepsilon_{i j}(u), \sigma_{i j}(u)$ the displacement field (with values in $\mathbb{C}^{3}$ ), the components of the strain tensor and the components of the stress tensor associated to $u$. We assume that the displacement field $u$ is independent of $x_{2}$ (the physical properties are independent of the
$x_{2}$ direction). Let us define the strip $\Omega$ by:

The time-harmonic elastodynamics equations and boundary conditions for the plate are reduced to a problem in the strip $\Omega$ and are written as follows (the derivative with respect to $x_{i}$ being denoted by $\partial_{i}$ ):

where $\omega>0$ is fixed and $f_{i}$ are the components of the body force density (independent of $x_{2}$ ). The displacement field $u$ (with values in $\mathbb{C}^{3}$ ) formally satisfies the following variational problem: for all displacement field $v \in \mathcal{C}_{0}^{\infty}\left(\bar{\Omega}, \mathbb{C}^{3}\right)$,

Now we are interested in the time-harmonic elastodynamics equations but in the half-strip $x_{3}>0$, with no body force and with a prescribed displacement field $g$ on the boundary $\left\{x_{3}=0\right\}$. Let us set:

The displacement field $u$ (with values in $\mathbb{C}^{3}$ ) formally satisfies the following variational problem: $u$ satisfies (2.15) and for all displacement field $v \in \mathcal{C}_{0}^{\infty}\left(\bar{\Omega}_{+}, \mathbb{C}^{3}\right)$ satisfying (2.15) with $g=0$,

## 3 Weighted Sobolev spaces.

In this section we introduce the weighted Sobolev spaces and the partial Fourier-Laplace transform for a strip. For $\beta \in \mathbb{R}, k \in \mathbb{N}$ and $m \in \mathbb{N}^{*}$, define $W_{\beta}^{k}\left(\Omega, \mathbb{R}^{m}\right)$ as the completion of $\mathcal{C}_{0}^{\infty}\left(\bar{\Omega}, \mathbb{R}^{m}\right)$ for the norm $\|u\|_{\beta, k, \Omega}=\left\|e^{\beta x_{3}} u\right\|_{k, \Omega}$ with similar definitions for $W_{\beta}^{k}\left(\Omega, \mathbb{C}^{m}\right)$. The norm on the topological dual $\left(W_{\beta}^{k}\left(\Omega, \mathbb{R}^{m}\right)\right)^{*}\left(\operatorname{resp} .\left(W_{\beta}^{k}\left(\Omega, \mathbb{C}^{m}\right)\right)^{*}\right)$ of $W_{\beta}^{k}\left(\Omega, \mathbb{R}^{m}\right)\left(\operatorname{resp} . W_{\beta}^{k}\left(\Omega, \mathbb{C}^{m}\right)\right)$ will be denoted by $\|.\|_{\beta, k, \Omega, *}$.

Define the partial Fourier-Laplace transform with respect to $x_{3}$ on $\mathcal{C}_{0}^{\infty}\left(\bar{\Omega}, \mathbb{C}^{m}\right)$ by

## 4 Well-posedness of the problem in the strip $\Omega$.

In this section we shall study the mathematical formulation of the variational problem (2.7), (2.8), (2.9). Let $\beta \in \mathbb{R}$. The sesquilinear form $b_{\Omega}$ defined in (2.8) makes sense for $u \in W_{\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ and $v \in W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ and there exists $C>0$ satisfying:

In view of Lemmas 4.2 and 4.3 except for a set of $\beta \in \mathbb{R}$ at most denumerable, $\mathscr{L}(\nu)$ has no eigenvalue on the line $R e \nu=-\beta$. From the previous lemmas we get

The definition (A.7) of the adjoint $A^{*}$ reads as follows in this case:

## 5 Asymptotics in the strip $\Omega$.

This section is devoted to the asymptotics of the solution to Eq. (4.32) (Proposition 5.1). Let $\beta \in \mathbb{R}$. Define the sesquilinear forms $b_{1}$ and $b_{2}$ on $H^{1}\left(\omega_{h}, \mathbb{C}^{3}\right)$ by

In order to obtain formula (5.9) below, we will apply the method of [18], p.52. Let $\zeta \in \mathcal{C}^{\infty}(\mathbb{R}, \mathbb{R})$ be nonnegative and such that $\int_{\mathbb{R}} \zeta=1, \eta \in \mathcal{C}_{0}^{\infty}(\mathbb{R}, \mathbb{R})$ be such that $\eta=1$ in a neighborhood of 0 . Let $\nu \in \mathbb{C}$, $\varphi \in H^{2}\left(\omega_{h}, \mathbb{C}^{3}\right), \psi \in H^{1}\left(\omega_{h}, \mathbb{C}^{3}\right)$ and for $\varepsilon>0, x \in \mathbb{R}$, set $u^{\varepsilon}(., x)=\varphi e^{\nu x} \zeta(x / \varepsilon) / \varepsilon, v^{\varepsilon}(., x)=\psi e^{-\nu x} \eta(x)$. It is well-known that $\int_{-\infty}^{+\infty}(\zeta(x / \varepsilon) / \varepsilon) \eta(x) d x \rightarrow \eta(0)=1$ when $\varepsilon \rightarrow 0$. On the other hand by an integration by parts, for $n \in \mathbb{N}^{*}, \int_{-\infty}^{+\infty} \partial_{x}^{n}(\zeta(x / \varepsilon) / \varepsilon) \eta(x) d x=(-1)^{n} \int_{-\infty}^{+\infty}(\zeta(x / \varepsilon) / \varepsilon) \partial_{x}^{n} \eta(x) d x \rightarrow(-1)^{n}\left(\partial_{x}^{n} \eta\right)(0)=0$ when $\varepsilon \rightarrow 0$. Considering $b_{\Omega}\left(u^{\varepsilon}, \overline{v^{\varepsilon}}\right)$ given by formulas (5.6) and (5.7) and taking the limit when $\varepsilon \rightarrow 0$ we get the formula: for all $\varphi \in H^{2}\left(\omega_{h}, \mathbb{C}^{3}\right), \psi \in H^{1}\left(\omega_{h}, \mathbb{C}^{3}\right), \nu \in \mathbb{C}$,

This formula shows that the polynomial operator pencil $\mathscr{L}(\nu)$ restricted to $H^{2}\left(\omega_{h}, \mathbb{C}^{3}\right)$ has the same characteristics (eigenvalues, eigenvectors, Jordan chains ...) than the polynomial operator pencil $\left(\mathcal{A}\left(\partial_{x_{1}}, \nu\right)\right.$, $\left.\mathcal{B}\left(\partial_{x_{1}}, \nu\right)\right)$ from $H^{2}\left(\omega_{h}, \mathbb{C}^{3}\right)$ into $L^{2}\left(\omega_{h}, \mathbb{C}^{3}\right) \times \mathbb{R}^{2}$. Moreover if $\nu_{0}$ is an eigenvalue of the polynomial operator pencil $\mathscr{L}(\nu)$ and $\varphi \in H^{1}\left(\omega_{h}, \mathbb{C}^{3}\right)$ is an eigenvector of $\mathscr{L}(\nu)$ corresponding to $\nu_{0}$, it can be inferred that $\varphi \in H^{2}\left(\omega_{h}, \mathbb{C}^{3}\right)$ (and even $\varphi \in \mathcal{C}^{\infty}\left(\overline{\omega_{h}}, \mathbb{C}^{3}\right)$ ), with the same properties for the corresponding generalized eigenvectors.

The following proposition is fundamental and gives an asymptotics of the solution to (4.32).

Proposition 5.1 (a) Let $\beta<\gamma \in \mathbb{R}$. Let $\nu_{1}, \ldots, \nu_{N}$ be the eigenvalues of the pencil $\mathscr{L}(\nu)$ in the strip $-\gamma<$ Re $\nu<-\beta$. For $i=1, \ldots, N$, let $J_{i}, \kappa_{i, j}, j=1, \ldots, J_{i},\left\{\varphi_{j, s}^{i}\right\}_{j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1}$ be the geometric multiplicity of $\nu_{i}$, the partial multiplicities of $\nu_{i}$ and a canonical system of Jordan chains of $\mathscr{L}(\nu)$ corresponding to $\nu_{i}$. For $i=1, \ldots, N$, let $\left\{\psi_{j, s}^{i}\right\}_{j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1}$ be the unique canonical system of Jordan chains of $\mathscr{L}^{*}(\nu)=\mathscr{L}(-\nu)$ corresponding to $\overline{\nu_{i}}$ given by Theorem A.1. For $i=1, \ldots, N$, the set of "power-exponential" functions

and let $\varphi_{\beta}, \varphi_{\gamma} \in \mathcal{C}^{\infty}(\bar{\Omega}, \mathbb{R})$ satisfy the conditions: supp $\varphi_{\beta} \subset \Omega_{\beta}$, supp $\varphi_{\gamma} \subset \Omega_{\gamma}$ and $\varphi_{\beta}+\varphi_{\gamma} \equiv 1$. Then for $i=1, \ldots, N, j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1, \varphi_{\beta} v_{j, s}^{i} \in W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ and $\varphi_{\gamma} v_{j, s}^{i} \in W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$.
(b) Assume moreover that $\mathscr{L}(\nu)$ has no eigenvalue on the lines $\operatorname{Re\nu }=-\beta$ and Re $=-\gamma$. Let $f_{\beta} \in\left(W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ and $f_{\gamma} \in\left(W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ be such that $f_{\beta}=f_{\gamma}$ on $W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right) \cap W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ and set $u_{\beta}=B_{\Omega, \beta}^{-1} f_{\beta}, u_{\gamma}=B_{\Omega, \gamma}^{-1} f_{\gamma}$ (Theorem 4.1). Remark 5.1 There is a proof of a similar result in [10], Theorem 5.4.1, which uses Lemma 5.4.1 of the same reference. But the author of the present paper does not understand the argument p. 170 in the proof of this lemma: "Consequently, the norm of $v_{\rho}$ in $L_{2}(\Omega \times(-N, N))$ is square integrable with respect to $\rho$ over the interval $\left(c_{1},+\infty\right)$. Thus this norm tends to zero as $\rho \rightarrow \infty$." It is well-known that if a function $f: \mathbb{R} \rightarrow \mathbb{R}$ is integrable on $\mathbb{R}, f(x)$ does not necessarily tend to zero when $x \rightarrow \pm \infty$. Perhaps it lacks an argument in this proof. There is another proof of a similar result in [18], pp.47-48 which uses an argument of density. We apply the same argument of density in the proof of Proposition 5.1 where the situation is distinct from that of [18], pp.47-48 because of the second members which are in a dual space. Moreover the calculus of the coefficients $c_{j, s}^{i}$ is simpler in the present proof than in the proofs of [10], p.176, [18],pp.50-51 or [13].

Proof: (a) The basis properties are stated at the end of appendix A Since for $i=1, \ldots, N, \beta<$ $\operatorname{Re}\left(-\overline{\nu_{i}}\right)<\gamma$, it results that for $i=1, \ldots, N, j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1, \varphi_{\beta} v_{j, s}^{i} \in W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ and $\varphi_{\gamma} v_{j, s}^{i} \in W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$.
(b) Given that the embedding from $W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ into $W_{-\beta}^{0}\left(\Omega, \mathbb{C}^{3}\right)$ is continuous and dense, the embedding from $\left(W_{-\beta}^{0}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ into $\left(W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ is also continuous and dense (see [20], p.265) and thanks to the Riesz representation Theorem and the density of $\mathcal{C}_{0}^{\infty}\left(\bar{\Omega}, \mathbb{C}^{3}\right)$ in $\left(W_{-\beta}^{0}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*} \cong W_{\beta}^{0}\left(\Omega, \mathbb{C}^{3}\right)$ it follows that if $f_{\beta} \in\left(W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ and $\varepsilon>0$, there exists $h_{\beta} \in \mathcal{C}_{0}^{\infty}\left(\bar{\Omega}, \mathbb{C}^{3}\right)$ satisfying

The partial Fourier-Laplace transform of $f$ in the sense of (3.15) is holomorphic with respect to $\nu \in \mathbb{C}$ and satisfies:

Owing to (5.21) and (5.22), $\left.f^{n}\right|_{W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)}$ $\rightarrow f_{\beta}$ in $\left(W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ and $\left.f^{n}\right|_{W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)} \rightarrow f_{\gamma}$ in $\left(W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ when $n \rightarrow+\infty$. From (5.24) applied to $f=f^{n}$, Theorem 4.1 the continuity of $c_{j, s}^{i}$ given by (5.15) with respect to $f_{\beta}$ and $f_{\gamma}$, by extracting a subsequence of $\left\{h_{\beta}^{n}\right\}_{n \in \mathbb{N}}$ and $\left\{h_{\gamma}^{n}\right\}_{n \in \mathbb{N}}$, we obtain (15.14) (a.e in $\Omega$ ). Let $\varphi_{\beta}^{\prime}, \varphi_{\gamma}^{\prime} \in \mathcal{C}^{\infty}(\bar{\Omega}, \mathbb{R})$ fulfilling the conditions: $\operatorname{supp} \varphi_{\beta}^{\prime} \subset \Omega_{\beta}$, $\operatorname{supp} \varphi_{\gamma}^{\prime} \subset \Omega_{\gamma}$ and $\varphi_{\beta}^{\prime}+\varphi_{\gamma}^{\prime} \equiv 1$. Let $c_{j, s}^{\prime i}$ be defined by (5.15) where $\varphi_{\beta}$ and $\varphi_{\gamma}$ are replaced by $\varphi_{\beta}^{\prime}$ and $\varphi_{\gamma}^{\prime}$. Since $\varphi_{\beta}-\varphi_{\beta}^{\prime}$ and $\varphi_{\gamma}-\varphi_{\gamma}^{\prime}$ have compact supports, since $f_{\beta}=f_{\gamma}$ on $W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right) \cap W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ and since $\varphi_{\beta}-\varphi_{\beta}^{\prime}+\varphi_{\gamma}-\varphi_{\gamma}^{\prime} \equiv 0$, it results that $c_{j, s}^{i}=c_{j, s}^{i}$.

## 6 Fredholm property in the half-strip $\Omega_{+}$.

In this section we shall examine the Fredholm properties of the operator associated to the variational formulation in the half-strip. For $\beta \in \mathbb{R}, k \in \mathbb{N}$ and $m \in \mathbb{N}^{*}$, define $W_{\beta}^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right)$ as the completion of $\mathcal{C}_{0}^{\infty}\left(\overline{\Omega_{+}}, \mathbb{C}^{m}\right)$ for the norm $\|u\|_{\beta, k, \Omega_{+}}=\left\|e^{\beta x_{3}} u\right\|_{k, \Omega_{+}}, H_{\Sigma}^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right)=\left\{u \in H^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right), u=0\right.$ on $\left.\Sigma\right\}$ and $W_{\beta, \Sigma}^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right)=\left\{u \in W_{\beta}^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right), u=0\right.$ on $\left.\Sigma\right\}$. The norm on the topological dual $\left(W_{\beta, \Sigma}^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right)\right)^{*}$ of $W_{\beta, \Sigma}^{k}\left(\Omega_{+}, \mathbb{C}^{m}\right)$ will be denoted by $\|.\|_{\beta, \Sigma, k, \Omega_{+}, *}$. The sesquilinear form $b_{\Omega_{+}}$defined in (2.17) makes sense for $u \in W_{\beta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and $v \in W_{-\beta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ then also for $u \in W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and $v \in W_{-\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and there exists $C>0$ such that for all $u \in W_{\beta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\left(\right.$ resp. $\left.u \in W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ and $v \in W_{-\beta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ (resp. $v \in W_{-\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ ),

On the other hand we know that for all $\beta \in \mathbb{R},\left(B_{\Omega_{+}, \beta}\right)^{*}=B_{\Omega_{+},-\beta}$ so that if $\beta \in \mathbb{R}$ is such that $\mathscr{L}(\nu)$ has no eigenvalue on the lines $\operatorname{Re\nu }=-\beta$ and $\operatorname{Re\nu }=\beta$, moreover the kernel of $B_{\Omega_{+},-\beta}=\left(B_{\Omega_{+}, \beta}\right)^{*}$ is finite-dimensional and consequently the range of $B_{\Omega_{+}, \beta}$ (which is closed) has a finite codimension (see [8, Lemma 1.40, p.141). Since in the previous reasoning $\beta$ can be replaced by $-\beta$ we have shown

Proposition 6.2 If $\beta \in \mathbb{R}$ is such that $\mathscr{L}(\nu)$ has no eigenvalue on the lines $R e \nu=-\beta$ and $R e \nu=\beta$, the operators $B_{\Omega_{+}, \beta}$ and $B_{\Omega_{+},-\beta}$ are Fredholm.

## 7 Asymptotics in the half-strip $\Omega_{+}$.

This section is devoted to the asymptotics of solutions to the variational formulation in the half-strip (Proposition 7.1). Hereafter in this paper, $\chi$ is a function such that $\chi \in \mathcal{C}^{\infty}(\mathbb{R}, \mathbb{R})$ and $\chi(x)=0$ for $x \leq 1, \chi(x)=1$ for $x \geq 2$.

In this section $\beta$ and $\gamma$ are real numbers such that $\beta<\gamma$ and we shall use the notations of Proposition 5.1, (a). The eigenvalues $\nu_{i}$ of $\mathscr{L}(\nu)$ in Proposition 5.1, (a) fulfill the condition $-\gamma<R e \nu_{i}<-\beta$ therefore with the notation (5.10) of this proposition, for $m \in \mathbb{N}, e^{\beta x_{3}} \chi\left(x_{3}\right) u_{j, s}^{i} \in H^{m}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ (recall that for $\left.m \in \mathbb{N}, u_{j, s}^{i} \in H^{m}\left(\omega_{h}, \mathbb{C}^{3}\right)\right)$, consequently $\chi\left(x_{3}\right) u_{j, s}^{i} \in W_{\beta, \Sigma}^{m}\left(\Omega_{+}, \mathbb{C}^{3}\right)$. Let $\kappa$ be the sum of the algebraic multiplicities of the eigenvalues of $\mathscr{L}(\nu)$ (strictly) between the lines $R e \nu=-\beta$ and $R e \nu=-\gamma$. With the notation (5.10) of Proposition 5.1. (a), denote by $\left\{W_{k}\right\}_{k=1, \ldots, \kappa}$ the family $\left\{\chi\left(x_{3}\right) u_{j, s}^{i}\right\}_{i=1, \ldots, N, j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1}$ (these functions will be named "waves"). Let $\mathcal{D}_{W}$ be the vector space spanned by these $\kappa$ functions. Lemma B.2 implies that the functions $W_{k}, k=1, \ldots, \kappa$ are linearly independent modulo $W_{\gamma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and linearly independent, then the sum $\mathcal{D}_{W}+W_{\gamma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ is direct and $\mathcal{D}_{W}$ is $\kappa$-dimensional. Consider the space $\mathcal{D}=\mathcal{D}_{W} \oplus W_{\gamma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\left(W_{\gamma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right) \subset \mathcal{D} \subset W_{\beta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$. The space $\mathcal{D}$ equipped with the norm: for $u=u_{W}+u_{\gamma} \in \mathcal{D}$ with $u_{W}=\sum_{k=1}^{\kappa} a_{k} W_{k}, a_{1}, \ldots, a_{\kappa} \in \mathbb{C}$ and $u_{\gamma} \in W_{\gamma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$,

In the same way the sum $\mathcal{D}_{W}+$ $W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ is direct and the space $\mathcal{D}_{\Sigma}=\mathcal{D}_{W} \oplus W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\left(W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right) \subset \mathcal{D}_{\Sigma} \subset W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ is a closed subspace of $\mathcal{D}$.

$$ $W_{-\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ is dense in $W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$, the adjoint of the inclusion map between these two spaces,

which is the restriction map

Proposition 7.1 Assume that $\mathscr{L}(\nu)$ has no eigenvalue on the lines $\operatorname{Re\nu }=-\beta$ and $\operatorname{Re\nu }=-\gamma$ and let $f \in\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$. Assume that $u_{\beta} \in W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ satisfies $B_{\Omega_{+}, \beta} u_{\beta}=i_{\beta, \gamma} f=\left.f\right|_{W_{-\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)}$. In that case there exists a family of complex numbers $\left\{c_{k}\right\}_{k=1, \ldots, \kappa}$ satisfying

Moreover it is continuous with respect to $v \in W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ consequently if $v \in W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$ it can be written under the form $\left\langle f_{\gamma}, v\right\rangle$ where $f_{\gamma} \in\left(W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)\right)^{*}$ and $f_{\beta}=f_{\gamma}$ on $W_{-\beta}^{1}\left(\Omega, \mathbb{C}^{3}\right) \cap W_{-\gamma}^{1}\left(\Omega, \mathbb{C}^{3}\right)$. Eq. (7.6) means $B_{\Omega, \beta}\left(\chi\left(x_{3}\right) u_{\beta}\right)=f_{\beta}$. By writing $u_{\beta}$ under the form $u_{\beta}=\chi\left(x_{3}\right)\left(\chi\left(x_{3}\right) u_{\beta}\right)+\left(1-\chi^{2}\left(x_{3}\right)\right) u_{\beta}$ and applying Proposition 5.1, (b) we get (7.3).

The next simple lemma will be used several times in the sequel to extend some variational formulations to a larger space.

Consequently for $u=\chi\left(x_{3}\right) u_{j, s}^{i} \in$ $W_{\beta, \Sigma}^{2}\left(\Omega_{+}, \mathbb{C}^{3}\right)$, if $\theta \in \mathbb{R}$ and $v \in W_{\theta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$, the second member of (7.10) makes sense and we shall define $b_{\Omega_{+}}^{1}\left(\chi\left(x_{3}\right) u_{j, s}^{i}, v\right)$ by formula (7.10). We obtain (7.12) and we can extend $b_{\Omega_{+}}^{1}$ on $\mathcal{D}_{W} \times W_{\theta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ by linearity.

## 8 Radiation conditions in the half-strip $\Omega_{+}$.

In this section we introduce the complex symplectic form $q_{\Omega_{+}}$(Eq. (8.6)). Thanks to this form it is possible to define incoming and outgoing "waves" according to the Mandelstam radiation principle. In the sequel we shall make the following assumption

Assumption $8.1 \delta>0$ is chosen such that in the strip $-\delta<R e \nu<\delta$, the eigenvalues of the operator pencil $\mathscr{L}(\nu)$ are only on the imaginary axis Re $\nu=0$ and $\mathscr{L}(\nu)$ has no eigenvalue on the lines Re $\nu=-\delta$ and Re $=\delta$.

Let $\nu_{1}=i \omega_{1}, \ldots, \nu_{N}=i \omega_{N}$ be these eigenvalues where $\omega_{j} \in \mathbb{R}, j=1, \ldots, N$. Given that $B_{\Omega_{+}, \delta}$ and $B_{\Omega_{+},-\delta}$ are Fredholm operators (Proposition 6.2), $\operatorname{Ker} B_{\Omega_{+},-\delta}$ and $\operatorname{Ker} B_{\Omega_{+}, \delta} \subset \operatorname{Ker} B_{\Omega_{+},-\delta}$ are finitedimensional. Let $T$ be the codimension of $\operatorname{Ker} B_{\Omega_{+}, \delta}$ in $\operatorname{Ker} B_{\Omega_{+},-\delta}$. Let $\kappa$ be the sum of the algebraic multiplicities of the imaginary eigenvalues $i \omega_{j}, j=1, \ldots, N$ of the operator pencil $\mathscr{L}(\nu)$.

Owing to Proposition C. 1

Given that $B_{\Omega_{+}, \delta}^{*}=B_{\Omega_{+},-\delta}$ and $B_{\Omega_{+},-\delta}^{*}=B_{\Omega_{+}, \delta}$ it follows that $\kappa=2 T$. The results of section 7 can be applied with $\beta=-\delta, \gamma=\delta$ and $\kappa=2 T$.

In that case $\mathcal{D}_{W}$ is the vector space spanned by the $2 T$ functions $W_{1}, \ldots, W_{2 T}$. The functions $W_{k}, k=$ $1, \ldots, 2 T$ are linearly independent modulo $W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and linearly independent, the sum $W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ $+\mathcal{D}_{W}$ is direct and $\mathcal{D}_{W}$ is $2 T$-dimensional. The space $\mathcal{D}=W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right) \oplus \mathcal{D}_{W}\left(W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right) \subset \mathcal{D} \subset\right.$ $\left.W_{-\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ is equipped with the norm (7.1) where $\kappa=2 T$ and $\gamma=\delta$. From Lemma 7.2 it is possible to extend the form $b_{\Omega_{+}}^{1}\left(\right.$ still denoted $\left.b_{\Omega_{+}}^{1}\right)$ on the space $\mathcal{D}_{W} \times W_{-\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and thus to extend the form $b_{\Omega_{+}}$ (denoted $\tilde{b}_{\Omega_{+}}$) on the space $\mathcal{D} \times W_{-\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ (in particular on the space $\mathcal{D} \times \mathcal{D}$ ) by: for $u=u_{W}+u_{\delta} \in \mathcal{D}$, with $u_{W} \in \mathcal{D}_{W}, u_{\delta} \in W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$, for $v \in W_{-\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$

The next lemma will be used several times in the sequel to extend some variational formulations to a larger space. It is to be compared with Lemma 7.1

Lemma 8.1 Assume that $f \in\left(W_{-\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ and $u \in \mathcal{D}_{\Sigma}$ satisfy $B_{\Omega_{+},-\delta} u=\left.f\right|_{W_{\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)}$, that is

The following proposition shows that the form $q_{\Omega_{+}}$is nondegenerate. Its proof uses the same method as the proof of Theorem 2.1, p. 50 of [18] (roughly speaking a Taylor formula for $\mathscr{L}\left(\partial_{x}\right)$ around an eigenvalue).

Proposition 8.1 Let $\nu_{1}=i \omega_{1}, \ldots, \nu_{N}=i \omega_{N}$ be the eigenvalues of $\mathscr{L}(\nu)$ on the imaginary axis. With the notations (5.10) and (5.12) of Proposition 5.1, we have

This result is finer than Proposition 8.1, but Proposition 8.1 is sufficient for our purpose. There is another proof of [18], Theorem 2.1, pp.148-156 in [15], Theorem 3.1.

The form $q_{\Omega_{+}}$is sesquilinear and if $u, v \in \mathcal{D}, q_{\Omega_{+}}(v, u)=-\overline{q_{\Omega_{+}}(u, v)}$ consequently $i q_{\Omega_{+}}$is Hermitian. Moreover $q_{\Omega_{+}}$is nondegenerate, thus it is symplectic (that is to say by definition sesquilinear, antihermitian and nondegenerate, see [5], Definition 1) and consequently there exists a basis $V_{1}, \ldots, V_{2 T}$ of $\mathcal{D}_{W}$ with the property that $i q_{\Omega_{+}}\left(V_{j}, V_{k}\right)= \pm \delta_{j, k}$.

This sign is the same as that of $i q_{\Omega_{+}}(u, u)$ (see [17], Eq. (3.4)). According to the Mandelstam radiation principle, $u \in \mathcal{D}_{W}$ is said to be outgoing (resp. incoming) if this sign is $>0$, i.e. $i q_{\Omega_{+}}(u, u)>0\left(\right.$ resp. $<0$, i.e. $\left.i q_{\Omega_{+}}(u, u)<0\right)$.

The following lemma corresponds to Theorem 3.2, p. 157 and Proposition 3.3, p. 158 of 18 in the present context. Its proof is very similar to the proofs of the aforementioned results and is given here for the sake of completeness.

## 9 Well-posedness of the problem in the half-strip $\Omega_{+}$.

In this section we establish the well-posedness of the time-harmonic elasticity problem in a half-strip when the solution is searched in the space $\mathcal{D}^{\text {out }}$ (Theorem 9.2). In order to solve the problem in a halfstrip with a non-homogeneous Dirichlet condition, the method consists in taking a trace lifting of this
inhomogeneous Dirichlet condition and to reduce the problem to a problem with a homogeneous Dirichlet condition and a second member. The solution to this intermediate problem is given by the next theorem.

Theorem 9.1 Under Assumption 8.1, the operator $B_{\Omega_{+}, \delta}^{\text {out }}: \mathcal{D}_{\Sigma}^{\text {out }} \rightarrow\left(W_{-\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ is an isomorphism.

Proof: (a) According to [16], Theorem 1 or [2], Theorem 2.1, we know that $\operatorname{Ker} B_{\Omega_{+}, 0}=\{0\}$, consequently $\operatorname{Ker} B_{\Omega_{+}, \delta}=\{0\}$. Let us examine $\operatorname{Ker} B_{\Omega_{+}, \delta}^{\text {out }}$. Assume that $u=\sum_{k=1}^{T} a_{k} U_{k}+u_{\delta} \in \mathcal{D}_{\Sigma}^{\text {out }}$ satisfies the condition $B_{\Omega_{+}, \delta}^{o u t} u=0$. Consequently $\tilde{b}_{\Omega_{+}}(u, u)=0$ and $q_{\Omega_{+}}(u, u)=0$. But $q_{\Omega_{+}}(u, u)=$ $-i\left(\sum_{k=1}^{T}\left|a_{k}\right|^{2}\right)$ therefore $a_{k}=0(k=1, \ldots, T), u=u_{\delta} \in W_{\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and $u \in \operatorname{Ker} B_{\Omega_{+}, \delta}=\{0\}$. We have shown that $\operatorname{Ker} B_{\Omega_{+}, \delta}^{\text {out }}=\{0\}$.
(b) $B_{\Omega+,-\delta}$ is a Fredholm operator, accordingly its range $\mathcal{R}\left(B_{\Omega+,-\delta}\right)$ is closed and since $\left(B_{\Omega+, \delta}\right)^{*}=$ $B_{\Omega+,-\delta}$, from [8], Theorem 5.13, p.234, we get

\text { Find } u \in \mathcal{D}_{g}^{\text {out }} \text { such that for all } v \in W_{-\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right), \tilde{b}_{\Omega_{+}}(u, v)=0 \tag{9.4}
\end{equation*}
$$

Remark first that a solution to (9.4) is necessarily unique because of part (a) in the proof of Theorem 9.1. Now let us give $g \in H^{1 / 2}\left(\Sigma, \mathbb{C}^{3}\right)$. It is possible to find $u_{0} \in H^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ with compact support (so that $\left.u_{0} \in W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ in such a way that $\left.u_{0}\right|_{\Sigma}=g$. Let us search a solution $u$ to (9.4) under the form $u=u_{0}+w$ where $w \in \mathcal{D}_{\Sigma}^{o u t}$. The variational formulation (9.4) boils down to the following one: find $w \in \mathcal{D}_{\Sigma}^{\text {out }}$ such that for all $v \in W_{-\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$,

The linear form $f: v \in W_{-\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right) \mapsto-b_{\Omega_{+}}\left(u_{0}, \bar{v}\right)$ belongs to $\left(W_{-\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ and (9.5) reads as follows:

Theorem 9.1 shows that problem (9.6) is well-posed. Now we state the main theorem of the paper.

Theorem 9.2 Let $g \in H^{1 / 2}\left(\Sigma, \mathbb{C}^{3}\right)$. Under Assumption [8.1, problem (9.4) has a unique solution $u$ $\in \mathcal{D}_{g}^{\text {out }}$ which is a weak solution to (2.11), ..,(2.15). Moreover $u$ is written under the form $u=u_{0}+w$ where $u_{0} \in W_{\delta}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ satisfies $\left.u_{0}\right|_{\Sigma}=g$ and $w \in \mathcal{D}_{\Sigma}^{\text {out }}$ is written under the form

$$
\begin{equation*}
w=\sum_{k=1}^{T} a_{k} U_{k}+w_{\delta} \tag{9.7}
\end{equation*}
$$

where $a_{k}=-i b_{\Omega_{+}}\left(u_{0}, \zeta_{k}\right), k=1, \ldots, T$ and $w_{\delta} \in W_{\delta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$.

Proof: $w$ is written under the form (9.7), therefore Eq. (9.5) yields $\tilde{b}_{\Omega_{+}}\left(w, \zeta_{k}\right)=-b_{\Omega_{+}}\left(u_{0}, \zeta_{k}\right)(k=$ $1, \ldots, T)$. But with notation (8.20), for $k=1, \ldots, T, \zeta_{k} \in \mathcal{D}_{\Sigma} \cap \operatorname{Ker} B_{\Omega+,-\delta}$, and due to Lemma 8.1 $\tilde{b}_{\Omega_{+}}\left(\zeta_{k}, w\right)=0$ thus $q_{\Omega_{+}}\left(w, \zeta_{k}\right)=-b_{\Omega_{+}}\left(u_{0}, \zeta_{k}\right)$. On the other hand taking into account (9.7), (8.18), (8.19) and (8.20), we obtain $q_{\Omega_{+}}\left(w, \zeta_{k}\right)=-i a_{k}$.

## A Operator pencils

In this section we recall some definitions and results about operator pencils (see [11, Chapter 1, 9, appendix A, [12], section 11, [10], section 5.1, [6], Chapter V, section 9). Let $\mathcal{X}, \mathcal{Y}$ be Hilbert spaces with respectively the inner products $(., .)_{\mathcal{X}},(., .)_{\mathcal{Y}}$ and the norms $\|.\|_{\mathcal{X}},\|.\|_{\mathcal{Y}}$. We denote by $L(\mathcal{X}, \mathcal{Y})$ the set of linear and bounded operators from $\mathcal{X}$ into $\mathcal{Y}$. If $A \in L(\mathcal{X}, \mathcal{Y})$, we denote the kernel and the range of the operator $A$ by $\operatorname{ker} A$ and $\mathcal{R}(A)$. The operator $A$ is said to be Fredholm if $\mathcal{R}(A)$ is closed and the dimension of $\operatorname{ker} A(=\operatorname{dimker} A)$ and the codimension of $\mathcal{R}(A)(=\operatorname{codim} \mathcal{R}(A))$ are finite. In that case the index of $A$ is by definition $\operatorname{Ind} A=\operatorname{dimker} A-\operatorname{codim} \mathcal{R}(A)$.

The operator polynomial

\end{equation*}

where $A_{k} \in L(\mathcal{X}, \mathcal{Y})$ is called a polynomial operator pencil. The point $\nu_{0} \in \mathbb{C}$ is said to be regular if the operator $\mathscr{U}\left(\nu_{0}\right)$ is invertible. The set of all nonregular points is called the spectrum of the polynomial operator pencil $\mathcal{U}(\nu)$.

The number $\nu_{0} \in \mathbb{C}$ is called an eigenvalue of the operator pencil $\mathcal{U}(\nu)$ if there exists $\varphi_{0} \in \mathcal{X}, \varphi_{0} \neq 0$, such that $\mathcal{U}\left(\nu_{0}\right) \varphi_{0}=0$. Such a vector $\varphi_{0}$ is called an eigenvector of $\mathcal{U}(\nu)$ corresponding to $\nu_{0}$. The dimension of $\operatorname{ker} \mathcal{U}\left(\nu_{0}\right)$ is called the geometric multiplicity of the eigenvalue $\nu_{0}$.

Let $\nu_{0}$ be an eigenvalue of the polynomial operator pencil $\mathcal{U}(\nu)$ and let $\varphi_{0}$ be an eigenvector of $\mathcal{U}(\nu)$ corresponding to $\nu_{0}$. If the elements $\varphi_{1}, \ldots, \varphi_{s-1} \in \mathcal{X}$ satisfy the equations

where $\mathcal{U}^{(k)}=d^{k} \mathcal{U} / d \nu^{k}$, the ordered collection $\varphi_{0}, \ldots, \varphi_{s-1} \in \mathcal{X}$ is said to be a Jordan chain of $\mathcal{U}$ corresponding to the eigenvalue $\nu_{0}$. The number $s$ is called the length of this Jordan chain. The vectors $\varphi_{1}, \ldots, \varphi_{s-1}$ are said to be generalized eigenvectors corresponding to $\varphi_{0}$. The maximal length of all Jordan chains formed by the eigenvector $\varphi_{0}$ and corresponding generalized eigenvectors will be denoted by $m\left(\varphi_{0}\right)$ and is called the rank of $\varphi_{0}$. An eigenvalue $\nu_{0}$ of $\mathcal{U}(\nu)$ is said to be of finite algebraic multiplicity if the kernel of $\mathcal{U}\left(\nu_{0}\right)$ is finite dimensional and the ranks of the eigenvectors corresponding to $\nu_{0}$ have a common bound. Assume that the eigenvalue $\nu_{0}$ of $\mathcal{U}(\nu)$ is of finite algebraic multiplicity and denote by $J$ its (finite) geometric multiplicity. In that case

A set of Jordan chains $\varphi_{j, 0}, \ldots, \varphi_{j, \kappa_{j}-1}, j=1, \ldots, J$ is called a canonical system of Jordan chains if
(a) the eigenvectors $\left\{\varphi_{j, 0}\right\}_{j=1, \ldots, J}$ form a basis in $\operatorname{ker} \mathcal{U}\left(\nu_{0}\right)$,
(b) for $j=1, \ldots, J$, let $\mathcal{M}_{j}$ be the space spanned by the vectors $\varphi_{1,0}, \ldots, \varphi_{j-1,0}$. Then

The numbers $\kappa_{j}=m\left(\varphi_{j, 0}\right)$ are called the partial multiplicities of the eigenvalue $\nu_{0}$. The sum $\kappa_{1}+\ldots+\kappa_{J}$ is called the algebraic multiplicity of the eigenvalue $\nu_{0}$.

The polynomial operator pencil $\mathcal{U}(\nu)$ is called Fredholm iff for $\nu \in \mathbb{C}$ the operator $\mathcal{U}(\nu)$ is Fredholm and there exists at least one regular point for $\mathcal{U}(\nu)$ (see [9, Definition A.8.1). The spectrum of a Fredholm polynomial operator pencil consists of isolated eigenvalues of finite algebraic multiplicity (see [9, Proposition A.8.4). In particular if there exists at least one regular point $\nu_{0}$ for $\mathcal{U}(\nu)$ and the operators $A_{k}, k=1, \ldots, l$ are compact, for $\nu \in \mathbb{C}, \mathcal{U}(\nu)$ is a compact perturbation of $\mathcal{U}\left(\nu_{0}\right)$ which is Fredholm with zero index, and [14], Theorem 2.26 shows that for $\nu \in \mathbb{C}, \mathcal{U}(\nu)$ is Fredholm with zero index, accordingly the polynomial operator pencil $\mathcal{U}(\nu)$ is Fredholm and thus its spectrum consists of isolated eigenvalues of finite algebraic multiplicity.

Let $\mathcal{X}^{*}$ be the topological dual of the Hilbert space $\mathcal{X}$. Assume there is a duality between $\mathcal{X}$ and $\mathcal{X}^{*}$, i.e. a sesquilinear form $\langle., .\rangle_{1}$ from $\mathcal{X} \times \mathcal{X}^{*}$ into $\mathbb{C}$ satisfying (see [9], p.404)

and such that if $h \in \mathcal{X}^{*}$, there exists a unique $\varphi^{*} \in \mathcal{X}^{*}$ satisfying

The same condition is assumed for the Hilbert space $\mathcal{Y}$, the corresponding sesquilinear form being denoted $\langle., .\rangle_{2}$. If $A \in L(\mathcal{X}, \mathcal{Y})$, the adjoint operator $A^{*} \in L\left(\mathcal{Y}^{*}, \mathcal{X}^{*}\right)$ satisfies the equality:

\end{equation*}

$\mathcal{U}(\nu)$ is a Fredholm polynomial operator pencil iff $\mathcal{U}^{*}(\nu)$ is a Fredholm polynomial operator pencil (see [9], p.422). $\nu_{0}$ is an eigenvalue of $\mathcal{U}(\nu)$ iff $\bar{\nu}_{0}$ is an eigenvalue of $\mathcal{U}^{*}(\nu)$ and the geometric, partial and algebraic multiplicities of $\nu_{0}$ and $\bar{\nu}_{0}$ coincide (see [9], Proposition A.9.2). The following theorem is fundamental (see [9], Theorem A.10.2):

Theorem A. 1 Assume that $\mathcal{U}(\nu)$ defined in (A.1) is a Fredholm polynomial operator pencil and $\nu_{0}$ is an eigenvalue of $\mathcal{U}(\nu)$ with geometric multiplicity $J$ and partial multiplicities $\kappa_{1}, \ldots, \kappa_{J}$. Assume that $\left\{\varphi_{j, s}\right\}_{j=1, \ldots, J, s=0, \ldots, \kappa_{j}-1}$ is a canonical system of Jordan chains corresponding to $\nu_{0}$. We have
(a) There exists a unique canonical system $\left\{\psi_{j, s}\right\}_{j=1, \ldots, J, s=0, \ldots, \kappa_{j}-1}$ of Jordan chains of $\mathcal{U}^{*}(\nu)$ corresponding to $\bar{\nu}_{0}$ such that $(\mathcal{U}(\nu))^{-1}$ has the following representation

in a neighborhood of $\nu_{0}$, where $P_{j, s} \in L(\mathcal{Y}, \mathcal{X})$ are defined by

and $\Gamma$ is a holomorphic operator function in a neighborhood of $\nu_{0}$ with values in $L(\mathcal{Y}, \mathcal{X})$.
(b) The canonical system $\left\{\psi_{j, s}\right\}_{j=1, \ldots, J, s=0, \ldots, \kappa_{j}-1}$ of the first assertion satisfies the biorthogonality conditions

Here $\varphi_{j, h}=0$ for $h \geq \kappa_{j}, \psi_{k, s}=0$ for $s \geq \kappa_{k}$.
Let $\mathcal{U}(\nu)$ be a Fredholm polynomial operator pencil of the form (A.1). For $\nu \in \mathbb{C}$ let $\mathcal{N}\left(\mathcal{U}\left(\partial_{x}\right), \nu\right)$ be the set of solutions to the differential equation:

In that case the function (A.14) is a solution to Eq.(A.13) iff $\nu$ is an eigenvalue of $\mathcal{U}(\nu)$ and $\varphi_{0}, \ldots, \varphi_{s}$ is a Jordan chain corresponding to this eigenvalue (see [10, Lemma 5.1.3). Let $\nu$ be an eigenvalue of $\mathcal{U}(\nu), J$ its geometric multiplicity, $\kappa_{1}, \ldots, \kappa_{J}$ its partial multiplicities, $\left\{\varphi_{j, s}\right\}_{j=1, \ldots, J, s=0, \ldots, \kappa_{j}-1}$ a canonical system of Jordan chains of $\mathcal{U}$ corresponding to $\nu$. It can be inferred that the "power-exponential" functions $e^{\nu x} \sum_{\sigma=0}^{s} \frac{x^{\sigma}}{\sigma!} \varphi_{j, s-\sigma}, j=1, \ldots, J, s=0, \ldots, \kappa_{j}-1$ form a basis of $\mathcal{N}\left(\mathcal{U}\left(\partial_{x}\right), \nu\right)$. In particular the dimension of $\mathcal{N}\left(\mathcal{U}\left(\partial_{x}\right), \nu\right)$ is equal to the algebraic multiplicity $\kappa_{1}+\ldots+\kappa_{J}$ of the eigenvalue $\nu$ (see [10, Lemma 5.1.4).

## B Some linear independence results

In this section we establish results on the linear independence of some families of functions. The present lemma is a preliminary result before Lemma B. 2

Lemma B. 1 (a) Let $\omega_{1}, \ldots, \omega_{N} \in \mathbb{R}$ be pairwise distinct, $P_{1}, \ldots, P_{N}$ be $N$ polynomial functions with values in a Hilbert space $\mathcal{H}, c \in \mathbb{R}$ and $f$ be the function defined on $[c,+\infty)$ by

In that case $f \in L^{2}([c,+\infty), \mathcal{H}) \Rightarrow P_{j} \equiv 0(j=1, \ldots, N) \Rightarrow f \equiv 0$.
(b) More generally let $\omega_{1}, \ldots, \omega_{N} \in \mathbb{R}, \beta_{1}, \ldots, \beta_{N} \in \mathbb{R}_{+}, P_{1}, \ldots, P_{N}$ be $N$ polynomial functions with values in a Hilbert space $\mathcal{H}, c \in \mathbb{R}$ and $f$ be the function defined on $[c,+\infty)$ by

Then $f \in L^{2}([c,+\infty), \mathcal{H}) \Rightarrow P_{j} \equiv 0(j=1, \ldots, N) \Rightarrow f \equiv 0$.

Proof: We shall give a proof of this lemma when the Hilbert space $\mathcal{H}$ is the set of complex numbers $\mathbb{C}$, the proof in the general case being similar.

& \int_{a}^{a+b}\left|Q_{M}(t)\right|^{2} d t=b \sum_{k \in I_{M}}\left|a_{M, k}\right|^{2}+\sum_{k, l \in I_{M}, k \neq l} a_{M, k} \overline{a_{M, l}} \int_{a}^{a+b} e^{i\left(\omega_{k}-\omega_{l}\right) t} d t=  \tag{B.6}\\
& b \sum_{k \in I_{M}}\left|a_{M, k}\right|^{2}+\sum_{k, l \in I_{M}, k \neq l} a_{M, k} \overline{a_{M, l}} e^{i\left(\omega_{k}-\omega_{l}\right)(a+b / 2)}\left(\frac{\sin b\left(\omega_{k}-\omega_{l}\right) / 2}{\left(\omega_{k}-\omega_{l}\right) / 2}\right) .

$I_{p, k} \subset\{1, \ldots, N\}\left(p=1, \ldots, P, k=0, \ldots, M_{p}\right), \omega_{l}, l \in I_{p, k}$ being pairwise distinct, and $Q_{P, M_{P}} \not \equiv 0$. By an inequality similar to (B.5) where $Q_{M}$ in (B.5) is replaced by $Q_{P, M_{P}}$, there exist $C_{1}>0$ and $C_{2}>0$ satisfying

\begin{array}{ll}
b & \sum_{l \in I_{P, M_{P}}}\left|a_{P, M_{P}, l}\right|^{2} \leq \\
2 & a^{-2 M_{P}} e^{-2 a \beta_{P}}\left(\int_{a}^{a+b}|f(t)|^{2} d t+C_{1} b c(a, b)\right)+C_{2}, a>0, b>0 \tag{B.11}
\end{array}
$$

where

$$
\begin{equation*}
c(a, b)=\sup \left((a+b)^{2\left(M_{P}-1\right)} e^{2(a+b) \beta_{P}},(a+b)^{2 M_{P}} e^{2(a+b) \beta_{P-1}}\right) \tag{B.12}
\end{equation*}
$$

The rest of the proof is as in part (a).
The next lemma shows the linear independence of some families of functions and enables to determine the dimension of the space $\mathcal{D}_{W}$ in section 7 .

Lemma B. 2 Let $\beta<\gamma \in \mathbb{R}$ be such that $\mathscr{L}(\nu)$ has no eigenvalue on the lines $\operatorname{Re\nu }=-\beta$ and Re $\nu=-\gamma$. Let $\kappa$ be the sum of the algebraic multiplicities of the eigenvalues of $\mathscr{L}(\nu)$ (strictly) between the lines Rev $=-\beta$ and Rev $=-\gamma$. Let $\chi \in \mathcal{C}^{\infty}(\mathbb{R}, \mathbb{R})$ be such that $\chi(x)=0$ for $x \leq 1$, $\chi(x)=1$ for $x \geq 2$. With the notations of Proposition 5.1, (a), denote by $\left\{W_{k}\right\}_{k=1, \ldots, \kappa}$ the family $\left\{\chi\left(x_{3}\right) u_{j, s}^{i}\right\}_{i=1, \ldots, N, j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1}$. The functions $W_{k}, k=1, \ldots, \kappa$ are linearly independent modulo $W_{\gamma}^{0}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ (i.e., if $\alpha_{1}, \ldots, \alpha_{\kappa} \in \mathbb{C}$ are such that $\sum_{k=1}^{\kappa} \alpha_{k} W_{k} \in W_{\gamma}^{0}\left(\Omega_{+}, \mathbb{C}^{3}\right)$, then $\alpha_{1}=\cdots=\alpha_{\kappa}=0$ ). In particular they are linearly independent.

Proof: The lemma is a consequence of Lemma B. 1 and the fact that if $\nu_{i}$ is an eigenvalue of $\mathscr{L}(\nu)$, the "power-exponential" functions $e^{\nu_{i} x} \sum_{\sigma=0}^{s} \frac{x^{\sigma}}{\sigma!} \varphi_{j, s-\sigma}^{i}, j=1, \ldots, J_{i}, s=0, \ldots, \kappa_{i, j}-1$ form a basis of $\mathcal{N}\left(\mathscr{L}\left(\partial_{x}\right), \nu_{i}\right)($ see appendix A $)$.

## C Result on the algebraic multiplicities

The following result is similar to that of [18], p. 111 or [1], Theorem 2.2.4, but in the present context and with a distinct proof which is a little more "constructive".

Proposition C. 1 Let $\beta<\gamma \in \mathbb{R}$ be such that $\mathscr{L}(\nu)$ has no eigenvalue on the lines Re $\nu=-\beta$, Re $\nu=-\gamma$, Re $\nu=\beta$ and Re $\nu=\gamma$, consequently $B_{\Omega_{+}, \beta}, B_{\Omega_{+}, \gamma}, B_{\Omega_{+}, \beta}^{*}$ and $B_{\Omega_{+}, \gamma}^{*}$ are Fredholm operators (Proposition 6.2). Let $\kappa$ be the sum of the algebraic multiplicities of the eigenvalues of $\mathscr{L}(\nu)$ (strictly) between the lines $\operatorname{Re} \nu=-\beta$ and $\operatorname{Re} \nu=-\gamma$. Then $\operatorname{Ker} B_{\Omega_{+}, \gamma} \subset \operatorname{Ker} B_{\Omega_{+}, \beta}, \operatorname{Ker} B_{\Omega_{+}, \beta}^{*} \subset \operatorname{Ker} B_{\Omega_{+}, \gamma}^{*}$ and

$$
\begin{equation*}
\operatorname{dim}\left(\operatorname{Ker} B_{\Omega_{+}, \beta} / \operatorname{Ker} B_{\Omega_{+}, \gamma}\right)+\operatorname{dim}\left(\operatorname{Ker} B_{\Omega_{+}, \gamma}^{*} / \operatorname{Ker} B_{\Omega_{+}, \beta}^{*}\right)=\kappa \tag{C.1}
\end{equation*}
$$

Proof: The inclusions in the proposition are trivial. Set $d=\operatorname{dim}\left(\operatorname{Ker} B_{\Omega_{+}, \beta} / \operatorname{Ker} B_{\Omega_{+}, \gamma}\right)$ and let $Z_{1}, \ldots, Z_{d}$ be a basis of a complement of $\operatorname{Ker} B_{\Omega_{+}, \gamma}$ in $\operatorname{Ker} B_{\Omega_{+}, \beta}$. Proposition 7.1 applied with $f=0$ implies that there exists a matrix $C=\left(C_{i j}\right)_{i=1, \ldots, d ; j=1, \ldots, \kappa}$ of complex numbers satisfying the condition $Z_{i}-C_{i j} W_{j} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right), i=1, \ldots, d$. Assume that $X \in \mathbb{C}^{d}$ satisfies $C^{t} X=0$ (where $C^{t}$ is the transpose matrix of $C$ ). Consequently $X_{i} Z_{i}=X_{i} Z_{i}-X_{i} C_{i j} W_{j} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$. But Lemma 7.1. (b) shows that if $u \in \operatorname{Ker} B_{\Omega_{+}, \beta}$ and $u \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ then $u \in \operatorname{Ker} B_{\Omega_{+}, \gamma}$, thus $X_{i} Z_{i} \in \operatorname{Ker} B_{\Omega_{+}, \gamma}$ and $X=0$. This shows that the rank of the matrix $C$ is $d$. It follows that $\kappa \geq d$ and by changing the basis $Z_{1}, \ldots, Z_{d}$ and the order of $W_{1}, \ldots, W_{\kappa}$ if necessary, we may assume

$$
\begin{equation*}
Z_{i}-W_{i}-\sum_{j=d+1}^{\kappa} C_{i j} W_{j} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right), i=1, \ldots, d \tag{C.2}
\end{equation*}
$$

Consider the space $E=B_{\Omega_{+}, \beta}\left(W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right) \cap i_{\beta, \gamma}\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}\left(\right.$ where $i_{\beta, \gamma}$ is defined in (7.2) $)$. If $f \in E$, there exists $u_{\beta} \in W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ with the property that $f=B_{\Omega_{+}, \beta} u_{\beta} \in\left(W_{-\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ and
$f \in i_{\beta, \gamma}\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$. Proposition 7.1 can be applied to $f$ and $u_{\beta}$. Applying the operator $B_{\Omega_{+}, \beta}$ to Eq. (7.3) of this proposition and using (C.2) we obtain

$$
\begin{equation*}
f=B_{\Omega_{+}, \beta} u_{\gamma}^{\prime}+\sum_{i=d+1}^{\kappa} e_{i}\left(B_{\Omega_{+}, \beta} W_{i}\right) \tag{C.3}
\end{equation*}
$$

where $u_{\gamma}^{\prime} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and $e_{d+1}, \ldots, e_{\kappa} \in \mathbb{C}$. Let $F$ be the vector space $F=B_{\Omega_{+}, \beta}\left(W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ and $G$ be the vector space spanned by the functions $B_{\Omega_{+}, \beta} W_{i}, i=d+1, \ldots, \kappa$. We have shown $E \subset F+G$. Assume that $f \in E \cap G$. Consequently $f$ is written under the form $f=B_{\Omega_{+}, \beta} v_{\gamma}=\sum_{i=d+1}^{\kappa} f_{i}\left(B_{\Omega_{+}, \beta} W_{i}\right)$ where $v_{\gamma} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and $f_{d+1}, \ldots, f_{\kappa} \in \mathbb{C}$. Thus $\sum_{i=d+1}^{\kappa} f_{i} W_{i}-v_{\gamma} \in \operatorname{Ker} B_{\Omega_{+}, \beta}$, therefore we obtain a relation $\sum_{i=d+1}^{\kappa} f_{i} W_{i}-v_{\gamma}^{\prime}=\sum_{i=1}^{d} f_{i} Z_{i}$ where $f_{1}, \ldots, f_{d} \in \mathbb{C}$ and $v_{\gamma}^{\prime} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$. From (C.2) it follows that $\sum_{i=1}^{d} f_{i} W_{i}+\sum_{i=d+1}^{\kappa}\left(\sum_{j=1}^{d} C_{j i} f_{j}-f_{i}\right) W_{i} \in W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$. Lemma B.2 implies that $f_{1}=\ldots f_{\kappa}=0$ thus $f=0$. We have shown that the sum $F+G$ is direct and also that the vectors $B_{\Omega_{+}, \beta} W_{i}, i=d+1, \ldots, \kappa$ are linearly independent so that $G$ is $\kappa-d$ dimensional. On the other hand thanks to Lemma 7.1, (a), $F \subset E$ and from Lemma 7.2 and (7.9), $G \subset E$. Accordingly $E=F \oplus G$.

We shall need an intermediate result. Assume more generally that $\mathcal{H}$ is a Hilbert space, that $\mathcal{E}, \mathcal{F}, \mathcal{G}$ are subspaces of $\mathcal{H}^{*}$ (the topological dual of $\mathcal{H}$ ) such that $\mathcal{E}=\mathcal{F} \oplus \mathcal{G}$, that $\mathcal{G}$ is finite-dimensional and $\mathcal{F}$ is closed in $\mathcal{H}^{*}$ (so that $\mathcal{E}$ is closed in $\left.\mathcal{H}^{*}\right)$. Let $\left\{\varphi_{i}\right\}_{i=1, \ldots, q}\left(q \in \mathbb{N}^{*}\right)$ be a basis of $\mathcal{G}$ and $\left\{\psi_{i}\right\}_{i=1, \ldots, q}$ be a family of vectors of $\mathcal{H}$ with the properties that $\left\langle\varphi_{i}, \psi_{j}\right\rangle=\delta_{i, j}, i, j=1, \ldots, q$ and $\psi_{i} \in \mathcal{F}^{\perp}, i=1, \ldots, q$ (here $\langle.,$.$\rangle is the duality bracket between \mathcal{H}^{*}$ and $\mathcal{H}$ and if $A$ is a subset of $\mathcal{H}$ (resp. $\mathcal{H}^{*}$ ), $A^{\perp}$ is the orthogonal of $A$ in $\mathcal{H}^{*}$ (resp. $\mathcal{H}$ ) with respect to this duality bracket). Let $\mathcal{G}_{1} \subset \mathcal{H}$ be the space spanned by the family of vectors $\left\{\psi_{i}\right\}_{i=1, \ldots, q}$ (of dimension $q$ ). Let us show that $\mathcal{F}^{\perp}=\mathcal{E}^{\perp} \oplus \mathcal{G}_{1}$. First $\mathcal{E}^{\perp} \subset \mathcal{F}^{\perp}$ and $\mathcal{G}_{1} \subset \mathcal{F}^{\perp}$. On the other hand $\mathcal{E}^{\perp} \cap \mathcal{G}_{1} \subset \mathcal{G}^{\perp} \cap \mathcal{G}_{1}=\{0\}$. Finally if $x \in \mathcal{F}^{\perp}$, write $x=x_{1}+x_{2}$ where $x_{1}=x-\sum_{i=1}^{q}\left\langle\varphi_{i}, x\right\rangle \psi_{i}$. Therefore $x_{1} \in \mathcal{F}^{\perp} \cap \mathcal{G}^{\perp}=\mathcal{E}^{\perp}$ and $x_{2}=x-x_{1}=\sum_{i=1}^{q}\left\langle\varphi_{i}, x\right\rangle \psi_{i} \in \mathcal{G}_{1}$. The result is proved.

Apply this result to the Hilbert space $\mathcal{H}=W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ and to the spaces $\mathcal{E}=i_{\beta, \gamma}^{-1} E, \mathcal{F}=i_{\beta, \gamma}^{-1} F=$ $i_{\beta, \gamma}^{-1} B_{\Omega_{+}, \beta}\left(W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ and $\mathcal{G}=i_{\beta, \gamma}^{-1} G$. Since $i_{\beta, \gamma}$ is injective and $E \subset i_{\beta, \gamma}\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$, it follows that $\mathcal{E}=\mathcal{F} \oplus \mathcal{G}$. Let $\mathcal{G}_{1} \subset \mathcal{H}$ be the corresponding space of the previous construction of the intermediate result (of dimension $\kappa-d$ ). According to Lemma 7.1. (b), $\mathcal{F}$ is exactly $B_{\Omega_{+}, \gamma}\left(W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right.$ ) hence closed in $\mathcal{H}^{*}$ (because $B_{\Omega_{+}, \gamma}$ is Fredholm). Moreover $\mathcal{G}$ is finite dimensional of dimension $\kappa-d$, thereby closed in $\mathcal{H}^{*}$. Remark that $B_{\Omega_{+}, \beta}\left(W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ is the orthogonal of $\operatorname{Ker} B_{\Omega_{+}, \beta}^{*}$ in $\left(W_{-\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ so that $E=$ $B_{\Omega_{+}, \beta}\left(W_{\beta, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right) \cap i_{\beta, \gamma}\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ is the orthogonal of $\operatorname{Ker} B_{\Omega_{+}, \beta}^{*}$ in $i_{\beta, \gamma}\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ consequently $\mathcal{E}=i_{\beta, \gamma}^{-1} E$ is the orthogonal of $\operatorname{Ker} B_{\Omega_{+}, \beta}^{*}\left(\subset W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ in $\left(W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)^{*}$ and $\mathcal{E}^{\perp}$ (the orthogonal of $\mathcal{E}$ in $W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$ ) is exactly $\operatorname{Ker} B_{\Omega_{+}, \beta}^{*}$ (because $\operatorname{Ker} B_{\Omega_{+}, \beta}^{*}$ is finite-dimensional thus closed in $\left.W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$. Finally $\mathcal{F}^{\perp}\left(\right.$ the orthogonal of $\mathcal{F}$ in $\left.W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ is the orthogonal of $B_{\Omega_{+}, \gamma}\left(W_{\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)\right)$ in $W_{-\gamma, \Sigma}^{1}\left(\Omega_{+}, \mathbb{C}^{3}\right)$, that is $\operatorname{Ker} B_{\Omega_{+}, \gamma}^{*}$. We have shown

$$
\begin{equation*}
\operatorname{Ker} B_{\Omega_{+}, \gamma}^{*}=\operatorname{Ker} B_{\Omega_{+}, \beta}^{*} \oplus \mathcal{G}_{1} \tag{C.4}
\end{equation*}
$$

The proposition follows.
