# INVISCID DAMPING OF MONOTONE SHEAR FLOWS FOR 2D INHOMOGENEOUS EULER EQUATION WITH NON-CONSTANT DENSITY IN A FINITE CHANNEL

### WEIREN ZHAO

ABSTRACT. We prove the nonlinear inviscid damping for a class of monotone shear flows with nonconstant background density for the two-dimensional ideal inhomogeneous fluids in  $\mathbb{T} \times [0, 1]$  when the initial perturbation is in Gevrey- $\frac{1}{s}$  ( $\frac{1}{2} < s < 1$ ) class with compact support.

### 1. INTRODUCTION

We consider the two-dimensional inhomogeneous incompressible Euler system in a finite channel  $\mathbb{T} \times [0,1]$ :

(1.1) 
$$\begin{cases} \partial_t \rho + \mathbf{v} \cdot \nabla \rho = 0, \\ \rho(\partial_t \mathbf{v} + \mathbf{v} \cdot \nabla \mathbf{v}) + \nabla \mathbf{P} = 0, \\ \operatorname{div} \mathbf{v} = 0 \end{cases}$$

where  $\rho > 0$  is the density, **v** is the velocity and **P** is the pressure. By introducing  $m = \rho^{-1}$ , we have

(1.2) 
$$\begin{cases} \partial_t m + \mathbf{v} \cdot \nabla m = 0, \\ \partial_t \mathbf{v} + \mathbf{v} \cdot \nabla \mathbf{v} + m \nabla \mathbf{P} = 0, \\ \operatorname{div} \mathbf{v} = 0. \end{cases}$$

The system has a nontrivial steady state:

 $\mathbf{v}_s = (u(y), 0)$   $m_s = \theta(y)$   $\mathbf{P}_s = \text{cons.}.$ 

In this paper, we study the global stability of this steady state. It is natural to introduce the perturbation:  $\mathbf{v} = (u(y), 0) + U, \ m = \theta(y) + d(t, x, y)$  and  $\mathbf{P} = \cos x + P$ . We also introduce the perturbed vorticity  $\omega = \nabla \times U$  and the associated stream function  $\psi$ . Then we obtain the equations of perturbation  $(U, d, \omega, \psi, P)$ :

(1.3a) 
$$\begin{cases} \partial_t U^x + u(y)\partial_x U^x + u'(y)\partial_x \psi + U \cdot \nabla U^x + \theta \partial_x P + d\partial_x P = 0\\ \partial_t U^y + u(y)\partial_x U^y + U \cdot \nabla U^y + \theta \partial_y P + d\partial_y P = 0, \end{cases}$$

and

(1.3b) 
$$\begin{cases} \partial_t \omega + u(y)\partial_x \omega - u''(y)\partial_x \psi - \theta'(y)\partial_x P + \partial_y P \partial_x d - \partial_x P \partial_y d + U \cdot \nabla \omega = 0, \\ \partial_t d + u(y)\partial_x d + \theta'(y)\partial_x \psi + U \cdot \nabla d = 0, \end{cases}$$

where

(1.3c) 
$$\begin{cases} U = \nabla^{\perp}\psi, \quad \Delta\psi = \omega, \quad \operatorname{div}\left((\theta + d)\nabla P\right) = -\operatorname{div}(u \cdot \nabla u) - 2u'(y)\partial_{xx}\psi, \\ \psi(t, x, 0) = \psi(t, x, 1) = 0, \quad \partial_y P(t, x, 0) = \partial_y P(t, x, 1) = 0, \\ \omega|_{t=0} = \omega_{in}(x, y), \quad d|_{t=0} = d_{in}(x, y). \end{cases}$$

In the homogeneous density case  $\theta = 1, d = 0, (1.3)$  is the Euler equation around a shear flow (u(y), 0). In [30], Orr observed that for the Couette flow case u(y) = y, the velocity will tend to a shear flow as  $t \to \infty$ . This phenomenon is called inviscid damping. Bedrossian and Masmoudi [5] proved nonlinear inviscid damping around the Couette flow in Gevrey-m class  $(1 \le m < 2)$ . Deng and Masmoudi [14] proved some instability for initial perturbations in the Gevrey-*m* class (m > 2). We refer to [18, 19] and references therein for other related interesting results. For the monotone shear flow setting, Case [9] predicted the  $t^{-1}$  decay for the velocity. It is later proved by Wei, Zhang, and Zhao [33]. We also refer to [38, 21, 20]. The nonlinear inviscid damping for stable monotone shear flow was proved by Ionescu-Jia [16], and Masmoudi-Zhao [28]. For non-monotone flows such as the Poiseuille flow and the Kolmogorov flow, another dynamic phenomenon should be taken into consideration, which is the so-called vorticity depletion, predicted by Bouchet and Morita [8] and later proved in [34, 35, 17]. See also [1, 26, 19] for similar depletion in various systems. For the inhomogeneous Euler equation, very recently, Chen, Wei, Zhang, and Zhang [11] proved the nonlinear inviscid damping for the Couette flow with the density near a constant, namely,  $\theta = 1$ .

Our main result is

**Theorem 1.1.** Suppose  $u(y), \theta(y)$  are smooth functions defined on [0,1] which satisfy:

- (1) (Monotone) There exists  $c_0 > 0$  such that  $u' \ge c_0 > 0$ .
- (2) (Positive density) There exists  $c_0 > 0$  such that  $\theta \ge c_0 > 0$ .
- (3) (Compact support) There exists  $\kappa_0 \in (0, \frac{1}{10}]$  such that  $\sup u'' \subset [4\kappa_0, 1-4\kappa_0]$  and  $\sup \theta' \subset [4\kappa_0, 1-4\kappa_0]$  $[4\kappa_0, 1 - 4\kappa_0].$
- (4) (Linear stability) The distorted Rayleigh operator  $u \operatorname{Id} \left(\frac{u'}{\theta}\right)' \tilde{\Delta}^{-1}$  has no eigenvalue and no embedded eigenvalue.

(5) (Regularity) There exist K > 1 and  $s_0 \in (0, 1)$  such that for all integers  $m \ge 0$ ,

$$\sup_{y \in \mathbb{R}} \left| \frac{d^m(\theta'(y))}{dy^m} \right| + \sup_{y \in \mathbb{R}} \left| \frac{d^m(u''(y))}{dy^m} \right| \le K^m (m!)^{\frac{1}{s_0}} (m+1)^{-2}.$$

For all  $1 > s_0 \ge s > 1/2$  and  $\lambda_{in} > 0$ , there exist  $\lambda_{in} > \lambda_{\infty} = \lambda_{\infty}(\lambda_{in}, K, \kappa_0, s) > 0$  and  $0 < \epsilon_0 = \epsilon_0(\lambda_{in}, \lambda_{\infty}, \kappa_0, s) \le \frac{1}{2}$  such that for all  $\epsilon \le \epsilon_0$  if  $\omega_{in}$ ,  $d_{in}$  have compact support in  $\mathbb{T} \times [3\kappa_0, 1 - 3\kappa_0]$  and satisfy

$$\|\omega_{in}\|_{\mathcal{G}^{s,\lambda_{in}}}^2 = \sum_k \int |\widehat{\omega}_{in}(k,\eta)|^2 e^{2\lambda_{in}\langle k,\eta\rangle^s} d\eta \le \epsilon^2, \quad \int_{\mathbb{T}\times[0,1]} \omega_{in}(x,y) dx dy = 0$$

and

$$\|d_{in}\|_{\mathcal{G}^{s,\lambda_{in}}}^2 = \sum_k \int \left|\widehat{d}_{in}(k,\eta)\right|^2 e^{2\lambda_{in}\langle k,\eta\rangle^s} d\eta \le \epsilon^2, \quad \int_{\mathbb{T}\times[0,1]} d_{in}(x,y) dx dy = 0$$

then the smooth solution  $\omega(t)$  and d(t) to (1.3) satisfy:

- 1. (Compact support) For all  $t \ge 0$ , supp  $\omega(t) \subset \mathbb{T} \times [2\kappa_0, 1-2\kappa_0]$  and supp  $d(t) \subset \mathbb{T} \times [2\kappa_0, 1-2\kappa_0]$ .
- 2. (Scattering) There exist  $f_{\infty}, d_{\infty} \in \mathcal{G}^{s,\lambda_{\infty}}$  with  $\operatorname{supp} f_{\infty} \subset \mathbb{T} \times [2\kappa_0, 1 2\kappa_0]$  and  $\operatorname{supp} d_{\infty} \subset \mathbb{T} \times [2\kappa_0, 1 2\kappa_0]$  such that for all  $t \geq 0$ ,

(1.4) 
$$\|\omega(t, x + tu(y) + \Phi(t, y), y) - f_{\infty}(x, y)\|_{\mathcal{G}^{s, \lambda_{\infty}}} \lesssim \frac{\epsilon}{\langle t \rangle},$$

and

(1.5) 
$$\|d(t, x + tu(y) + \Phi(t, y), y) - d_{\infty}(x, y)\|_{\mathcal{G}^{s,\lambda_{\infty}}} \lesssim \frac{\epsilon}{\langle t \rangle},$$

where  $\Phi(t, y)$  is given explicitly by

(1.6) 
$$\Phi(t,y) = \frac{1}{2\pi} \int_0^t \int_{\mathbb{T}} U^x(\tau,x,y) dx d\tau = u_\infty(y)t + O(\epsilon^2),$$

with  $u_{\infty}(y) = -\frac{1}{2\pi} \partial_y \int_{\mathbb{T}} \Delta^{-1} f_{\infty}(x, y) dx$ . 3. (Inviscid damping) The velocity field U satisfies

(1.7) 
$$\left\|\frac{1}{2\pi}\int U^{x}(t,x,\cdot)dx - u_{\infty}\right\|_{\mathcal{G}^{s,\lambda_{\infty}}} \lesssim \frac{\epsilon^{2}}{\langle t\rangle^{2}},$$

(1.8) 
$$\left\| U^x(t) - \frac{1}{2\pi} \int U^x(t, x, \cdot) dx \right\|_{L^2} \lesssim \frac{\epsilon}{\langle t \rangle}$$

(1.9) 
$$\|U^y(t)\|_{L^2} \lesssim \frac{\epsilon}{\langle t \rangle^2}.$$

We list some remarks here.

- (1) By modifying the Fourier multiplier, one can prove the asymptotic stability in the Gevrey-2 class.
- (2) The compact support assumptions on u'',  $\theta'$  and  $\omega_{in}$ ,  $d_{in}$  seem necessary, which ensures the Fourier analysis works in the estimate.
- (3) In the proof, we construct a wave operator to absorb the nonlocal term. Such kind of operators appears in the study of dispersive equations with potential, (also called distorted Fourier transform, see [13, 15, 25, 31, 32, 36] for more details. Let us also mention that recently, the wave operator was successfully used to solve important problems in fluid mechanics. In [24], the authors use the wave operator method to solve Gallay's conjecture on

pseudospectral and spectral bounds of the Oseen vortices operator. In [35], the wave operator method was used to solve Beck and Wayne's conjecture. In [28], the authors use the wave operator method to prove the nonlinear inviscid damping for stable monotone shear flows.

- (4) In [11], the authors introduce a well-constructed weight A\* which captures the important difference of regularities between the vorticity and density. There are other choices. The weight introduced in [11] is constructed in a clever way. We use the same weight in this paper. It helps us to simplify the proof and reduce more than 20 pages of this paper.
- (5) It is quite interesting to study the stability threshold problem for the 2D inhomogeneous incompressible Navier-Stokes equations at a high Reynolds number. For the Navier-Stokes equations, we refer to [2, 3, 4, 6, 7, 10, 12, 22, 23, 27, 29] for the recent progress.

1.1. Main idea. The paper contains mainly two parts. The first part, from section 2 to section 5, is the more important part, where we do the reduction. In this part, we introduce a good unknown, pressure decomposition, nonlinear change of coordinates, and the wave operator to deduce a good working PDE system. The following map (1) shows the main idea of reaching a good working system. In each step, we ensure that the system is better for nonlinear energy estimates. In the second part, we close the energy estimate by using time-dependent Fourier multipliers which capture the growth of the solution at each frequency and each time.

We first introduce a good unknown to get rid of the linear pressure term  $\theta'(y)\partial_x P$ , see section 2 for more details. This offers us a better equation (see equation (2.21)), at least at the linear level. One can easily compare the linearized equation (2.21) of the good unknown with the classical linearized Euler equation and obtain linear (in)stability results parallelly. Due to the new good unknown, we have to study a distorted elliptic equation to recover the stream function, even at (t, x, y) coordinate. Moreover, the equation for the pressure is also distorted by the background density. In Appendix C, we study the Sturm-Liouville equation and obtain the decay estimate of the Fourier transform of the corresponding Green function, see Proposition 8.3 and Proposition 10.1, which will be used in the elliptic estimates for the stream function and pressure. This part is new. Roughly speaking, after being distorted by the density and nonlinear change of coordinates, the main part of the elliptic operator still behaves as  $\partial_z^2 + (\partial_v - t\partial_z)^2$ , namely, the Fourier transform of the Green function  $\mathcal{G}$  satisfies

$$|\mathcal{G}(t,k,\xi,\eta)| \le C \min\left\{\frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\xi-kt)^2}, \frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2}\right\}.$$

Note that the denominator  $k^2 + (\xi - kt)^2$  is the Fourier transform of  $-\partial_z^2 - (\partial_v - t\partial_z)^2$ .

The pressure term is one of the main difficulties: 1, the right-hand side of the pressure equation (2.2) is not compactly supported; 2, the pressure equation is an elliptic equation with Neumann boundary conditions, which is not friendly to the zero mode, namely, the compatibility condition should be kept in the decomposition. The second step is pressure decomposition, which is mainly because of the finite channel setting. Instead of solving the elliptic equation, we obtain the zero mode of the pressure from the vertical velocity equation. See (5.7i) for the equation and section 9 for detailed estimates. For the nonzero modes, we first divide the pressure into the linear part  $P_l$  and the nonlinear part  $P_n$ . We divide the pressure into 6 terms,

$$P = P_{l,1} + P_{l,2} + P_{l,b} + P_{n,1} + P_{n,2} + P_{n,b}$$

Now we introduce the main idea of decomposition. For the nonlinear part  $P_n$ , we consider the steady case, namely

$$-(\theta+d)\partial_x P_n = U^x \partial_x U^x + U^y \partial_y U^x = \frac{1}{2}\partial_x (U^x)^2 + \partial_x \psi(\Omega + \partial_x \partial_x \psi).$$





Noticing that near the boundary  $d + \theta$  is constant,  $\Omega = 0$ , we then have

$$P_n = -\frac{\left(\left(\partial_x \psi\right)^2 + \left(\partial_y \psi\right)^2\right) + C}{2(\theta + d)}$$

near the boundary. We use this idea to construct two boundary correction terms  $P_{l,b}$  and  $P_{n,b}$  to get rid of the boundary value on the right-hand side of the pressure equation and make them compactly supported. The same idea also works for the decomposition of the linear part, see section 2 for more details. There is a derivative loss after the decomposition, which does not appear in the whole space  $\mathbb{T} \times \mathbb{R}$  setting, discussed in [11]. For example, for the linear part, before the decomposition, one can formally regard  $\Delta P_l \approx -\partial_{xx}\psi$ . After the decomposition, there is  $\chi_2'' \partial_y \psi$  on the right-hand

side of the equation of  $P_{l,2}$ , see (2.5). Note that the derivative loss in y is bad because it will lead to growth. Luckily,  $\chi_2''$  vanishes on the support of  $\theta', d, \chi_1$ . So we first study  $\Delta P_{l,2} \approx \chi_2'' \partial_y \psi$ and control  $\langle \partial_x, \partial_y \rangle P_{l,2}$  by  $\psi$ . Then we study  $\Delta(P_{l,2}\chi_1) \approx 2\chi_1' \partial_y P_{l,2}$  and control  $\langle \partial_x, \partial_y \rangle^2 P_{l,2}\chi_1$  by  $\langle \partial_x, \partial_y \rangle P_{l,2}$ , which can be formally regarded as the estimate of the commutator

$$[\Delta^{-1}, \chi_1](\chi_2'' \partial_y \psi).$$

The same problem appears in the pressure decomposition of the nonlinear part. Roughly speaking, the additional growth of  $\Pi_{l,2}$  and  $\Pi_{n,2}$  happens only near the boundary, which does not affect the vorticity equation due to the compact support of a and  $\theta'$ . We use the same strategy to treat  $\Pi_{l,2}$  and  $\Pi_{n,2}$ , see section 10 for more details.

The third step is the nonlinear change of coordinates, which helps us to get rid of the nondecaying zero mode in the transport term. The step will also distort the elliptic equation for the stream function and pressure. But after separating the linear equation with the time-independent coefficients, the time-dependent (solution-dependent) part is small, see (8.2) and (10.4) for the decompositions, also see Proposition 8.3, Lemma 10.2, Lemma 10.3, Lemma 10.4, and Lemma 10.5 for the estimates of the solution-dependent part.

The original nonlocal term  $-u''\partial_x\psi - \theta'\partial_xP$ , which does not appear in the Couette flow with a constant background density case, is hard to deal with. After introducing the good unknown  $\tilde{\omega}$  (see 2.1) and doing the nonlinear change of coordinates, we have a slightly better new nonlocal term  $\varphi_1 \partial_z P_{\neq} \Psi$ . The new nonlocal term may lead to instability. However, under the linear stability assumption (4) in Theorem 1.1, we can construct a wave operator to eliminate it. Similar to [28], we have the following observations: 1, the operator can be constructed for each frequency in z separately; 2, the nonlocal term is small for high frequencies in the z variable, which also corresponds to the linear stability of the distorted Rayleigh operator in large wave numbers. So the wave operator is not needed for higher frequencies; 3, the nonlocal term  $(\varphi_1 \circ u^{-1})(v)\partial_z P_{\neq} \mathring{\mathcal{T}}_{1,D}^{-1}[\Omega]$ with time-independent coefficient  $(\varphi_1 \circ u^{-1})(v)$  is responsible for the linear instability. Thus, we only construct a wave operator for lower frequencies in z to eliminate the time-independent part. Due to the change of coordinates, even the linearized nonlocal term  $\tilde{\mathcal{T}}_{1,D}^{-1}[\Omega]$  is time-dependent. We then introduce the inverse linear change of coordinates to make the nonlocal term time-independent. We arrive at (2.21), which is the same as the linearized equation in the original variables but has a different meaning. The construction of the wave operator is highly non-trivial. In section 3, we study (2.21). This part is new. We obtain the representation formula of the solution, which gives the linear inviscid damping. The representation formula leads us to the formula of the wave operator. In section 4, we study the basic properties of the wave operator. The nice estimates of its Fourier kernel, make the wave operator well-adapted to nonlinear interactions. More precisely, the Fourier kernel  $\mathcal{D}(t, k, \xi_1, \xi_2)$  of the wave operator satisfies

$$|\mathcal{D}(t,k,\xi_1,\xi_2)| \lesssim e^{-\lambda_{\mathcal{D}}|\xi_1-\xi_2|^{s_0}}$$

In terms of regularity, one can simply regard the effect of the wave operator acting on the function f as multiplying f by a smooth function, whose Fourier transform is  $e^{-\lambda_{\mathcal{D}}|\xi|^{s_0}}$ . This is one reason why the wave operator is well-adapted to the nonlinear system. The second reason is related to the famous Orr mechanism [30]. In physical terms, because the mode of the vorticity in question is initially well-mixed, and then proceeds to un-mix under the shear flow evolution, a transient growth happens near the Orr critical time. In the breakthrough paper [5], the authors estimate this transient growth mathematically rigorously by introducing a multiplier  $A(t, \nabla)$ . In terms of frequency, the wave operator has two effects: 1, it changes the amplitude of the function at each frequency; 2, it essentially mixes the information near each frequency, due to the fast decay of its Fourier kernel. It ensures that the critical time does not move too much. These good properties of

the wave operator allow us to use the same multiplier A of [5] and use the same strategy as in [28] to study the effect of the wave operator on the nonlinear terms.

With all the preparations done, we arrive at a good working system (5.7). In the second part, we study the nonlinear problem and close the energy estimates. The main idea is to introduce time-dependent Fourier multipliers which capture the different growths of different frequencies at different times. We use the classical multiplier  $A(t, \nabla)$  (see Appendix D for details) of [5] to capture the nonlinear growth from the nonlinear interactions of the transport term  $U \cdot \nabla \Omega$ . We use an additional multiplier  $B(t, \nabla)$  introduced in [11] to gain the derivative for the density *a* for short times. It is useful in the estimate of the nonlinear interactions between *a* and the pressure II when *a* is in higher frequencies. We also use the multipliers  $\mathcal{M}_3, \mathcal{M}_4$ , and  $\mathcal{M}_5$  by using the ideas from [11] to control the pressure. We refer to [11] for some explanations about the new multipliers. Some ideas related to the energy estimates and applying the weight are given in section 6 after we introduce the working system and the Fourier multipliers, which are more technical.

The proof of the main theorem is based on a standard bootstrap argument. In section 6, we introduce the bootstrap Proposition 6.7. In section 7, we give the key propositions which will be used to prove Proposition 6.7 and finish the proof of Theorem 1.1 by admitting those propositions. The rest of the paper is to prove propositions in section 7. Some estimates are done in the previous papers [5, 28]. The key estimate is to control the pressure term, which is in section 9 and section 10.

1.2. Notations. For f(z, v) smooth with compact support in  $\mathbb{T} \times (u(0), u(1))$ , we define the Fourier transform in the first variable  $\mathcal{F}_1 f(k, v)$ , the Fourier transform in the second variable  $\mathcal{F}_2 f(z, \eta)$  and the Fourier transform in both variables  $\hat{f}_k(\eta)$  where  $(k, \eta) \in \mathbb{Z} \times \mathbb{R}$ ,

$$\mathcal{F}_1 f(k,v) = \frac{1}{2\pi} \int_{\mathbb{T}} f(z,v) e^{-izk} dz,$$
  
$$\mathcal{F}_2 f(z,\eta) = \int_{\mathbb{R}} f(z,v) e^{-iv\eta} dv,$$
  
$$\hat{f}_k(\eta) = \hat{f}(k,\eta) = \frac{1}{2\pi} \int_{\mathbb{T}\times\mathbb{R}} f(z,v) e^{-izk-iv\eta} dz dv.$$

We use a convention is to denote M, N as dyadic integers  $M, N \in \mathbb{D}$  where

$$\mathbb{D} = \left\{\frac{1}{2}, 1, 2, \dots, 2^j, \dots\right\} = 2^{\mathbb{N}} \cup \frac{1}{2}.$$

This will be useful when defining Littlewood-Paley projections and paraproduct decompositions. We will use the same A for  $A(t, \nabla)f = (A(\eta)\hat{f}(\eta))^{\vee}$  or  $A\hat{f} = A(\eta)\hat{f}(\eta)$ , where  $A(t, \nabla)$  is a Fourier multiplier. For function  $A(t, k, \xi)$ , we denote the time derivative of A by  $\dot{A}(t, k, \xi) = \partial_t A(t, k, \xi)$ . We also denote the time derivative on the Fourier multiplier  $A(t, \nabla)$  by

$$\dot{\mathbf{A}}(t,\nabla)f = (\dot{\mathbf{A}}(t,k,\eta)\hat{f}(t,k,\eta))^{\vee}.$$

We use the notation  $f \leq g$  when there exists a constant C > 0 independent of the parameters of interest such that  $f \leq Cg$  (we define  $g \gtrsim f$  analogously). Similarly, we use the notation  $f \approx g$ when there exists C > 0 such that  $C^{-1}g \leq f \leq Cg$ . We use the notation c to denote a constant such that  $0 \leq c < 1$  which may be different from line to line.

We will denote the  $l^1$  vector norm  $|k, \eta| = |k| + |\eta|$ , which by convention is the norm taken in our work. Similarly, given a scalar or vector in  $\mathbb{R}^n$  we denote

$$\langle v \rangle = (1 + |v|^2)^{\frac{1}{2}}.$$

We denote the projection to the kth mode of f(x, y) by

$$P_k f(x,y) = f_k(x,y) = \frac{1}{2\pi} \left( \int_{\mathbb{T}} f(x',y) e^{-ikx'} dx' \right) e^{ikx},$$

and denote the projection to the non-zero mode by

$$P_{\neq}f(x,y) = f_{\neq} = \sum_{k \in \mathbb{Z} \setminus \{0\}} f_k(x,y)$$

and the projection to zero mode by

$$(P_0f)(y) = \frac{1}{2\pi} \left( \int_{\mathbb{T}} f(x', y) dx' \right).$$

We also use  $\hat{f}_k(\xi)$  to denote  $\hat{f}(k,\xi)$  to emphasize it is the Fourier transform of the k mode.

In some proofs, we use the Littlewood-Paley dyadic decomposition. Let  $\rho_0$  be a smooth function such that  $\rho_0 = 1$  for  $|\xi| \leq \frac{1}{2}$  and  $\rho(\xi) = 0$  for  $|\xi| \geq \frac{3}{4}$ . We define  $\rho = \rho_0(\xi/2) - \rho_0(\xi)$  and  $\rho_M(\xi) = \rho(M^{-1}\xi)$  with dyadic numbers M = 1, 2, 4, ...

$$f_{\mathrm{M}} = \varrho_{\mathrm{M}}(|\nabla|)f, \quad \widehat{f}_{k}(\xi)_{\mathrm{M}} = \widehat{f}_{k}(\xi)\rho_{\mathrm{M}}(k,\xi)$$
$$f_{<\mathrm{M}} = \varrho_{0}(|\nabla|)f + \sum_{\mathrm{K}\in 2^{\mathbb{N}}:\mathrm{K}<\mathrm{M}}f_{\mathrm{K}}.$$

We denote the standard  $L^2$  norms by  $\|\cdot\|_2$ . We make common use of the Gevrey- $\frac{1}{s}$  norm with Sobolev correction defined by

$$\|f\|_{\mathcal{G}^{s,\lambda,\sigma}}^2 = \sum_k \int \left|\hat{f}_k(\eta)\right|^2 e^{2\lambda|k,\eta|^s} \langle k,\eta \rangle^{2\sigma} d\eta.$$

In the proof, we sometimes use  $\mathcal{G}^{s,\sigma}$  instead where we omit  $\lambda = \lambda(t)$  for simplification and keep the important index  $\sigma$  which represents the Sobolev corrections. We refer to this norm as the  $\mathcal{G}^{s,\lambda,\sigma}$  norm and occasionally refer to the space of functions

$$\mathcal{G}^{s,\lambda,\sigma} = \left\{ f \in L^2 : \|f\|_{\mathcal{G}^{s,\lambda,\sigma}} < \infty \right\}.$$

We refer to section A.2 in [5] for a discussion of the basic properties of this norm and some related useful inequalities. For  $\eta \geq 0$ , we define  $E(\eta) \in \mathbb{Z}$  to be the integer part. We define for  $\eta \in \mathbb{R}$  and  $1 \leq |k| \leq E(\sqrt{|\eta|})$  with  $\eta k \geq 0$ ,  $t_{k,\eta} = \left|\frac{\eta}{k}\right| - \frac{|\eta|}{2|k|(|k|+1)}$  and  $t_{0,\eta} = 2|\eta|$  and the critical intervals

$$\mathbf{I}_{k,\eta} = \begin{cases} [t_{|k|,\eta}, t_{|k|-1,\eta}] & \text{if } \eta k \ge 0 \text{ and } 1 \le |k| \le \mathbf{E}(\sqrt{|\eta|}), \\ \emptyset & \text{otherwise.} \end{cases}$$

For minor technical reasons, we define a slightly restricted subset as the resonant intervals

$$\mathbf{I}_{k,\eta} = \begin{cases} \mathbf{I}_{k,\eta} & \sqrt{|\eta|} \le t_{k,\eta}, \\ \emptyset & \text{otherwise.} \end{cases}$$

We use  $\mathbf{1}_A$  be the characteristic function which means  $\mathbf{1}_A(x) = \begin{cases} 1 & x \in A \\ 0 & x \notin A \end{cases}$ . We also use the smooth cut-off functions  $\chi_1$  and  $\chi_2$  in Gevrey- $\frac{2}{s_0+1}$  class which satisfies

$$\operatorname{supp} \chi_1 \subset [\kappa_0, 1 - \kappa_0], \quad \chi_1(y) \equiv 1 \text{ for } y \in [1 - 2\kappa_0, 2\kappa_0],$$
$$\operatorname{supp} \chi_2 \subset \left[\frac{\kappa_0}{2}, 1 - \frac{\kappa_0}{2}\right], \quad \chi_2(y) \equiv 1 \text{ for } y \in [\kappa_0, 1 - \kappa_0],$$

and there exist  $K_1 > 1$  such that for all integers  $m \ge 0$ 

(1.10) 
$$\sup_{y \in \mathbb{R}} \left| \frac{d^m \chi_i(y)}{dy^m} \right| \le K_1^m (m!)^{\frac{2}{s_0 + 1}} (m+1)^{-2}, \quad i = 1, 2.$$

# 2. Good unknown and coordinate system

There are two linear nonlocal terms  $-u''\partial_x\psi$  and  $-\theta'\partial_xP$  in the vorticity equation of (1.3). The first nonlocal term also appears in the Euler case [28], where the authors introduce the wave operator to eliminate it. The second nonlocal term is new, which does not exist in the constant background density case  $\theta = 1$ . The idea of eliminating this term is to use the horizontal velocity equation, which also contains  $\partial_x P$  in the equation. We introduce the good unknown

(2.1) 
$$\tilde{\omega} = \frac{\omega}{\theta} - \frac{\theta'}{\theta^2} \partial_y \psi = \partial_y \left(\frac{1}{\theta} \partial_y \psi\right) + \frac{1}{\theta} \partial_{xx} \psi \stackrel{\text{def}}{=} \tilde{\Delta} \psi.$$

# 2.1. New system in good unknown. A direct calculation gives

$$(2.2) \begin{cases} \partial_t \tilde{\omega} + u(y)\partial_x \tilde{\omega} - \left(\frac{u'}{\theta}\right)' U^y + U \cdot \nabla \tilde{\omega} + \frac{\theta'}{\theta} \partial_x \psi \tilde{\omega} + \left(\frac{\theta''}{\theta^2} - \frac{(\theta')^2}{\theta^3}\right) \partial_x \psi \partial_y \psi \\ + \frac{\partial_x d\partial_y P - \partial_y d\partial_x P}{\theta} + \frac{\theta' d\partial_x P}{\theta^2} = 0, \\ \tilde{\Delta} \psi \stackrel{\text{def}}{=} \partial_y \left(\frac{1}{\theta} \partial_y \psi\right) + \frac{1}{\theta} \partial_{xx} \psi = \tilde{\omega}, \quad U = (U^x, U^y) = \nabla^\perp \psi, \\ \psi(t, x, 0) = \psi(t, x, 1) = 0 \\ \partial_t d + u(y) \partial_x d + \theta'(y) \partial_x \psi + U \cdot \nabla d = 0, \\ \operatorname{div} \left((\theta + d) \nabla P\right) = -\operatorname{div}(U \cdot \nabla U) - 2u'(y) \partial_{xx} \psi, \end{cases}$$

Let us mention some observations of the new system here.

- The new linear nonlocal term (<sup>u'</sup>/<sub>θ</sub>)' U<sup>y</sup> has compact support.
  If d = 0, θ = 1, we are back to the Euler equation around shear flows.

2.2. Pressure decomposition. The pressure equation is not good for applying the Fourier transform, because the right-hand side  $-\operatorname{div}(U \cdot \nabla U) - 2u'(y)\partial_{xx}\psi$  is not compactly supported. We divide P into six terms: two linear terms  $P_{l,1}$  and  $P_{l,2}$ , two nonlinear terms  $P_{n,1}$  and  $P_{n,2}$ , and two boundary corrections  $P_{l,b}$   $P_{n,b}$ , namely,

$$P = P_{l,1} + P_{l,2} + P_{l,b} + P_{n,1} + P_{n,2} + P_{n,b}.$$

We define  $P_{l,b} = \frac{u\partial_y \psi_{\neq} - u'\psi_{\neq}}{\theta + d} (1 - \chi_2)$ , where  $\psi_{\neq} = \psi - \frac{1}{2\pi} \int_{\mathbb{T}} \psi(t, x, y) dx$  is the projection of  $\psi$  onto the non-zero mode. Then by using the facts

$$(1 - \chi_2)\omega = 0, \ u''(1 - \chi_2) = 0, \ (1 - \chi_2)\nabla(\frac{1}{\theta + d}) = 0,$$

we have

$$\partial_y P_{l,b} = \frac{u(P_{\neq}[\omega] - \partial_{xx}\psi_{\neq})}{\theta + d} (1 - \chi_2) - \frac{u\partial_y\psi_{\neq} - u'\psi_{\neq}}{\theta + d}\chi'_2$$
  
div  $((\theta + d)\nabla P_{l,b}) = \Delta((u\partial_y\psi - u'\psi)(1 - \chi_2))$   
 $= (1 - \chi_2)(u\partial_{yxx}\psi_{\neq} - u'\partial_{xx}\psi_{\neq}) - \chi''_2(u\partial_y\psi_{\neq} - u'\psi_{\neq})$   
 $- 2\chi'_2(u\partial_{yy}\psi_{\neq} - u'\partial_y\psi_{\neq}) - 2\chi'_2(u'\partial_y\psi_{\neq} - u''\psi_{\neq})$ 

$$+ (1 - \chi_2)(u\partial_{yyy}\psi_{\neq} + 2u'\partial_{yy}\psi_{\neq} - u'\partial_{yy}\psi_{\neq} - u''\partial_y\psi_{\neq} - u'''\psi_{\neq})$$
$$= -2(1 - \chi_2)u'\partial_{xx}\psi_{\neq} + 2\chi_2'(u\partial_{xx}\psi_{\neq}) - \chi_2''(u\partial_y\psi_{\neq} - u'\psi_{\neq})$$

which gives  $\partial_y P_{l,b}(t, x, 0) = \partial_y P_{l,b}(t, x, 1) = 0$  and

(2.3) 
$$\frac{\partial_x d\partial_y P_{l,b} - \partial_y d\partial_x P_{l,b}}{\theta} + \frac{\theta' d\partial_x P_{l,b}}{\theta^2} \equiv 0, \quad \text{and} \quad d\partial_x P_{l,b} \equiv 0$$

This means that the linear boundary correction does not affect the equation of  $\tilde{\omega}$ . Then we define  $P_l$  by solving the following equation:

(2.4) 
$$\begin{cases} \operatorname{div} \left( (\theta + d) \nabla P_{l,1} \right) = -2(\chi_2 u')(y) \partial_{xx} \psi - 2(u\chi'_2)(y) \partial_{xx} \psi - (u'\chi''_2)(y) \psi_{\neq}, \\ \partial_y P_{l,1}(t,x,0) = \partial_y P_{l,1}(t,x,1) = 0, \end{cases}$$

and

(2.5) 
$$\begin{cases} \operatorname{div}\left((\theta+d)\nabla P_{l,2}\right) = (\chi_2''u)(y)\partial_y\psi_{\neq x}\\ \partial_y P_{l,2}(t,x,0) = \partial_y P_{l,2}(t,x,1) = 0. \end{cases}$$

It is easy to check that  $P_{l,1} + P_{l,2} + P_{l,b}$  solves

(2.6) 
$$\begin{cases} \operatorname{div}\left((\theta+d)\nabla(P_{l,1}+P_{l,2}+P_{l,b})\right) = -2u'(y)\partial_{xx}\psi,\\ \partial_y(P_{l,1}+P_{l,2}+P_{l,b})(t,x,0) = \partial_y(P_{l,1}+P_{l,2}+P_{l,b})(t,x,1) = 0. \end{cases}$$

We then define the nonlinear boundary correction:

(2.7) 
$$P_{n,b}(t,x,y) = -\frac{1}{2} \frac{1}{\theta+d} \Big[ (\partial_x \psi)^2 + (\partial_y \psi)^2 \Big] (1-\chi_2).$$

Notice that  $\partial_y P_{n,b}(t,x,0) = \partial_y P_{n,b}(t,x,1) = 0$  and

$$\frac{\partial_x d\partial_y P_{n,b} - \partial_y d\partial_x P_{n,b}}{\theta} + \frac{\theta' d\partial_x P_{n,b}}{\theta^2} \equiv 0, \quad \text{and} \quad d\partial_x P_{n,b} \equiv 0$$

which means that the nonlinear boundary correction does not affect the equation of  $\tilde{\omega}$ .

Now let us deduce the equation for  $P_n$ . A direct calculation gives

$$\operatorname{div}\left((\theta+d)\nabla P_n\right) = -\operatorname{div}(U\cdot\nabla U) + \frac{1}{2}\operatorname{div}\left((\theta+d)\nabla\left(\frac{1}{\theta+d}\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right](1-\chi_2)\right)\right)$$
$$= -2(\partial_{xy}\psi)^2 - 2(\partial_{xx}\psi)^2 + 2\omega\partial_{xx}\psi$$
$$+ \frac{1}{2}\operatorname{div}\left(\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right](1-\chi_2)(\theta+d)\nabla\left(\frac{1}{\theta+d}\right)\right)$$
$$+ \frac{1}{2}\operatorname{div}\left((1-\chi_2)\nabla\left(\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right]\right)\right)$$
$$- \frac{1}{2}\partial_y\left(\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right]\chi_2'\right).$$

Noticing that  $(1 - \chi_2) = 0$  on the compact support of  $\nabla\left(\frac{1}{\theta+d}\right)$ , we obtain that

$$\operatorname{div}\left((\theta+d)\nabla P_n\right) = -\operatorname{div}(U\cdot\nabla U) + \operatorname{div}\left((\theta+d)\nabla\left(\frac{1}{\theta+d}\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right](1-\chi_2)\right)\right)$$
$$= -2(\partial_{xy}\psi)^2 - 2(\partial_{xx}\psi)^2 + 2\omega\partial_{xx}\psi$$
$$+ \frac{1}{2}(1-\chi_2)\operatorname{div}\left(\nabla\left(\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right]\right)\right)$$
$$- \chi_2'\partial_y\left(\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right]\right) - \frac{1}{2}\chi_2''\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right]$$

$$= -2\chi_2(\partial_{xy}\psi)^2 - 2\chi_2(\partial_{xx}\psi)^2 + 2\omega\partial_{xx}\psi + (1-\chi_2)\partial_x\omega\partial_x\psi + (1-\chi_2)\partial_y\omega\partial_y\psi - \chi_2'\Big(\Big[2(\partial_x\psi)\partial_{xy}\psi + 2(\partial_y\psi)\partial_{xx}\psi\Big]\Big) - \frac{1}{2}\chi_2''\Big[(\partial_x\psi)^2 + (\partial_y\psi)^2\Big].$$

Noticing that  $(1 - \chi_2) = 0$  on the compact support of  $\nabla \omega$ , we obtain the equation of  $P_n$ 

(2.8) 
$$\begin{cases} \operatorname{div}\left((\theta+d)\nabla P_n\right) = -2\chi_2(\partial_{xy}\psi)^2 - 2\chi_2(\partial_{xx}\psi)^2 + 2\omega\partial_{xx}\psi \\ -\chi_2'\left(\left[2(\partial_x\psi)\partial_{xy}\psi + 2(\partial_y\psi)\partial_{xx}\psi\right]\right) - \frac{1}{2}\chi_2''\left[(\partial_x\psi)^2 + (\partial_y\psi)^2\right]. \\ \partial_y P_n(t,x,0) = \partial_y P_n(t,x,1) = 0. \end{cases}$$

Note that the last term  $(\partial_y \psi)^2$  in (2.8) requires an additional decomposition for  $P_n = P_{n,1} + P_{n,2}$ with

(2.9) 
$$\begin{cases} \operatorname{div}\left((\theta+d)\nabla P_{n,1}\right) = -2\chi_2(\partial_{xy}\psi)^2 - 2\chi_2(\partial_{xx}\psi)^2 + 2\omega\partial_{xx}\psi \\ -\chi_2'\left(\left[2(\partial_x\psi)\partial_{xy}\psi + 2(\partial_y\psi)\partial_{xx}\psi\right]\right) - \frac{1}{2}\chi_2''\left[(\partial_x\psi)^2 + (\partial_yP_{\neq}\psi)^2\right]. \\ \partial_yP_{n,1}(t,x,0) = \partial_yP_{n,1}(t,x,1) = 0. \end{cases}$$

and

(2.10) 
$$\begin{cases} \operatorname{div} \left( (\theta + d) \nabla P_{n,2} \right) = -\chi_2'' (\partial_y P_{\neq} \psi) (\partial_y P_0 \psi) - \frac{1}{2} \chi_2'' (\partial_y P_0 \psi)^2. \\ \partial_y P_{n,2}(t, x, 0) = \partial_y P_{n,2}(t, x, 1) = 0. \end{cases}$$

By this decomposition, the functions of the right-hand side of equations (2.4), (2.5), (2.8), and (2.10) have compact support. Let us give a formal discussion about the behavior of each pressure. By dropping the lower order terms, coefficients, and the distorting effect in the elliptic equations, in terms of regularity, one can formally regard that these equations are

$$\Delta P_{l,1} \approx \chi_2 \partial_{xx} \psi, \quad \Delta P_{l,2} \approx \chi_2'' \partial_y \psi_{\neq}, \quad \Delta P_{n,1} \approx \omega \partial_{xx} \psi, \quad \Delta P_{n,2} \approx \chi_2'' (\partial_y \psi_{\neq}).$$

# 2.3. Zero mode of the pressure. For the zero mode of the pressure, we use the equation

$$\partial_t U^y + u(y)\partial_x U^y + U \cdot \nabla U^y + \theta \partial_y P + d\partial_y P = 0$$

to estimate the zero mode of the pressure. We have

$$(\theta + P_0(d))\partial_y P_0(P) + P_0[P_{\neq}(d)\partial_y P_{\neq}(P)] = P_0(U^x \partial_x U^y - U^y \partial_x U^x) = P_0(-\partial_y \psi \partial_{xx} \psi + \partial_x \psi \partial_{xy} \psi).$$

2.4. Nonlinear coordinate transform. Let us now introduce the change of variables  $(t, x, y) \rightarrow (t, z, v)$  to eliminate the non-decaying zero mode:

(2.11) 
$$v(t,y) = u(y) - \frac{\chi_1(y)}{t} \int_0^t \frac{1}{2\pi} \int_{\mathbb{T}} \partial_y \psi(t',x,y) dx dt',$$
$$z(t,x,y) = x - tv(t,y).$$

Thus  $\operatorname{Ran} u = \operatorname{Ran} v = [u(0), u(1)]$ . Let us also define  $\underline{\partial_t v}(t, v)$  and  $\underline{\partial_y v}(t, v)$  so that

$$\underline{\partial_t v}(t, v(t, y)) = \partial_t v(t, y), \quad \partial_y v(t, v(t, y)) = \partial_y v(t, y).$$

In order to simplify the notations, we introduce

(2.12) 
$$\varphi_{1}(y) = \left(\frac{u'}{\theta}\right)'(y), \quad \varphi_{2}(y) = \frac{\theta'(y)}{\theta(y)}, \quad \varphi_{3}(y) = \left(\frac{\theta''}{\theta^{2}} - \frac{(\theta')^{2}}{\theta^{3}}\right), \\ \varphi_{4}(y) = \frac{1}{\theta(y)}, \quad \varphi_{5}(y) = \varphi_{2}(y)\varphi_{4}(y), \quad \varphi_{6}(y) = -2(\chi_{2}u')(y) - 2(u\chi'_{2})(y), \\ \varphi_{7}(y) = -(u'\chi''_{2})(y), \quad \varphi_{8}(y) = (\chi''_{2}u)(y), \quad \varphi_{9}(y) = u'(y), \quad \varphi_{10}(y) = \theta'(y), \\ \varphi_{11}(y) = \theta(y).$$

Here and below, for any function  $\varphi(y)$ , we denote

$$\varphi(t, v(t, y)) = \varphi(y)$$
 and  $\widetilde{\varphi}(u(y)) = \varphi(y)$ .

We write two functions  $\underline{\varphi}(t, v)$  and  $\widetilde{\varphi}(v)$  both in (t, v) variable and regard  $\widetilde{\varphi}(v)$  as the linear part of  $\underline{\varphi}(t, v)$ . So we can expect

(2.13) 
$$\varphi^{\delta}(t,v) \stackrel{\text{def}}{=} \underline{\varphi}(t,v) - \widetilde{\varphi}(v)$$

is small.

**Remark 2.1.** Recall the notations  $\underline{\varphi}(t, v(t, y)) = \varphi(y)$  and  $\widetilde{\varphi}(u(y)) = \varphi(y)$ , then  $\underline{\varphi}(t, v)$  satisfies the following transport equation

$$\partial_t \underline{\varphi}(t, v) + \underline{\partial_t v}(t, v) \partial_v \underline{\varphi}(t, v) = 0,$$

and  $\varphi^{\delta}(t,v) = \underline{\varphi}(t,v) - \widetilde{\varphi}(v)$  satisfies

$$\partial_t \varphi^{\delta} + \underline{\partial_t v}(t, v) \partial_v \varphi^{\delta} = -\underline{\partial_t v}(t, v) \partial_v \widetilde{\varphi}(v).$$

Also note that  $\varphi_4(t,v)$ ,  $\varphi_9(t,v)$ , and  $\varphi_{11}(t,v)$  do not have compact support, but  $\varphi_j^{\delta}(t,v)$  has compact support for j = 1, 2, ..., 11

$$\begin{array}{l} \text{Define } \Omega(t,z,v), \ a(t,z,v), \ \Pi(t,z,v) \ \text{and } \Psi(t,z,v) \ \text{so that} \\ (2.14) \\ \end{array} \\ (2.14) \\ \begin{array}{l} \Omega(t,z(t,x,y),v(t,y)) = \tilde{\omega}(t,x,y), \quad a(t,z(t,x,y),v(t,y)) = d(t,x,y), \\ \Pi_{l,1}(t,z(t,x,y),v(t,y)) = P_{l,1}(t,x,y), \quad \Pi_{l,2}(t,z(t,x,y),v(t,y)) = P_{l,2}(t,x,y), \\ \Pi_{n,1}(t,z(t,x,y),v(t,y)) = P_{n,1}(t,x,y), \quad \Pi_{n,2}(t,z(t,x,y),v(t,y)) = P_{n,2}(t,x,y), \\ \Psi(t,z(t,x,y),v(t,y)) = \psi(t,x,y), \quad \underline{\omega}(t,z(t,x,y),v(t,y)) = \omega(t,x,y) \end{array}$$

hence the original 2D inhomogeneous Euler system (1.3) is expressed in the (t, z, v) variables as

$$(2.15) \qquad \begin{cases} \partial_t P_0(\underline{\omega}) + \underline{\partial}_y v P_0(\partial_z \Psi \partial_v \underline{\omega} - \partial_v \Psi \partial_z \underline{\omega}) - \underline{\partial}_y v P_0(\partial_z \Pi_l \partial_v a - \partial_v \Pi_l \partial_z a) \\ - \underline{\partial}_y v P_0(\partial_z \Pi_n \partial_v a - \partial_v \Pi_n \partial_z a) = 0, \\ \partial_t \Omega - \underline{\varphi_1} \partial_z P_{\neq} \Psi + U \cdot \nabla_{z,v} \Omega + \mathcal{N}_{\Omega}[\Psi] + \mathcal{N}_a[\Pi] = 0, \\ \partial_t a + \underline{\theta'} \partial_z \Psi + U \cdot \nabla_{z,v} a = 0, \\ \underline{\varphi_4} \partial_{zz} \Psi + \underline{\partial}_y v (\partial_v - t \partial_z) \left( \underline{\varphi_4} \underline{\partial}_y v (\partial_v - t \partial_z) \Psi \right) = \Omega, \\ \Psi(t, z, u(0)) = \Psi(t, z, u(1)) = 0, \\ U = (0, \underline{\partial_t v}) + \underline{\partial_y v} \nabla_{v,z}^{\perp} P_{\neq}(\Psi), \end{cases}$$

where  $\mathcal{N}$  represents the nonlinear terms:

$$\mathcal{N}_{\Omega}[\Psi] = \underline{\varphi_2} \partial_z \Psi \Omega + \underline{\varphi_3} \partial_z \Psi \underline{\partial_y v} (\partial_v - t \partial_z) \Psi$$

and 
$$\mathcal{N}_{a}[\Pi] = \mathcal{N}_{a}[\Pi_{l}] + \mathcal{N}_{a}[\Pi_{n}]$$
 with  $\Pi_{l} = \Upsilon_{2}\Pi_{l,1} + \Upsilon_{1}\Pi_{l,2}, \Pi_{n} = \Upsilon_{2}\Pi_{n,1} + \Upsilon_{1}\Pi_{n,2}$ , and  
(2.17)  
 $\mathcal{N}_{a}[\Pi_{l}] = \underline{\varphi_{4}}\partial_{y}v(\partial_{v}\Pi_{l}\partial_{z}a - \partial_{z}\Pi_{l}\partial_{v}a) + \underline{\varphi_{5}}a\partial_{z}\Pi_{l},$   
 $\mathcal{N}_{a}[\Pi_{n}] = \underline{\varphi_{4}}\partial_{y}v(\partial_{v}\Pi_{n}\partial_{z}a - \partial_{z}\Pi_{n}\partial_{v}a) + \underline{\varphi_{5}}a\partial_{z}\Pi_{n}.$ 

Here  $(P_{l,1}, P_{l,2}, P_{n,1}, P_{n,2})$  solve the following equations.

$$\begin{cases} \partial_z \Big( (a + \underline{\theta}) \partial_z \Pi_{l,1} \Big) + \underline{\partial_y v} (\partial_v - t \partial_z) \Big( (a + \underline{\theta}) \underline{\partial_y v} (\partial_v - t \partial_z) \Pi_{l,1} \Big) \\ = \underline{\varphi_6} \partial_{zz} \Psi + \underline{\varphi_7} P_{\neq}(\Psi), \\ (\partial_v - t \partial_z) \Pi_{l,1}(t, z, u(0)) = (\partial_v - t \partial_z) \Pi_{l,1}(t, z, u(1)) = 0, \end{cases}$$

and

(2.18b) 
$$\begin{cases} \partial_z \Big( (a + \underline{\theta}) \partial_z \Pi_{l,2} \Big) + \underline{\partial_y v} (\partial_v - t \partial_z) \Big( (a + \underline{\theta}) \underline{\partial_y v} (\partial_v - t \partial_z) \Pi_{l,2} \Big) \\ = \underline{\varphi_8} \underline{\partial_y v} (\partial_v - t \partial_z) P_{\neq}(\Psi), \\ (\partial_v - t \partial_z) \Pi_{l,2}(t, z, u(0)) = (\partial_v - t \partial_z) \Pi_{l,2}(t, z, u(1)) = 0, \end{cases}$$

and

$$(2.18c) \begin{cases} \partial_{z} \left( (a + \underline{\theta}) \partial_{z} \Pi_{n,1} \right) + \underline{\partial_{y} v} (\partial_{v} - t \partial_{z}) \left( (a + \underline{\theta}) \underline{\partial_{y} v} (\partial_{v} - t \partial_{z}) \Pi_{n,1} \right) \\ = -2 \underline{\chi_{2}} (\underline{\partial_{y} v} (\partial_{v} - t \partial_{z}) \partial_{z} \Psi)^{2} - 2 \partial_{zz} \Psi \left( \Omega - \underline{\chi_{2}} \partial_{zz} \Psi \right), \\ - 2 \underline{\chi_{2}'} \underline{\partial_{y} v} \left[ (\partial_{z} \Psi) (\partial_{v} - t \partial_{z}) \partial_{z} \Psi + (\partial_{v} - t \partial_{z}) \Psi \partial_{zz} \Psi \right] \\ - \frac{1}{2} \underline{\chi_{2}''} \left[ (\partial_{z} \Psi)^{2} + (\underline{\partial_{y} v})^{2} ((\partial_{v} - t \partial_{z}) P_{\neq} \Psi)^{2} \right], \\ (\partial_{v} - t \partial_{z}) \Pi_{n,1}(t, z, u(0)) = (\partial_{v} - t \partial_{z}) \Pi_{n,1}(t, z, u(1)) = 0, \end{cases}$$

(2.18d) 
$$\begin{cases} \partial_z \Big( (a+\underline{\theta})\partial_z \Pi_{n,2} \Big) + \underline{\partial_y v} (\partial_v - t\partial_z) \Big( (a+\underline{\theta})\underline{\partial_y v} (\partial_v - t\partial_z)\Pi_{n,2} \Big) \\ = -\frac{1}{2} \underline{\chi_2''} \Big[ 2(\underline{\partial_y v})^2 ((\partial_v - t\partial_z)P_{\neq}\Psi)\partial_v P_0\Psi + (\underline{\partial_y v})^2 (\partial_v P_0\Psi)\partial_v P_0\Psi \Big] \\ (\partial_v - t\partial_z)\Pi_{n,2}(t,z,u(0)) = (\partial_v - t\partial_z)\Pi_{n,2}(t,z,u(1)) = 0. \end{cases}$$

We also have that the zero mode of the pressure solves

$$(\underline{\theta} + P_0(a))\partial_v P_0(\Pi) + P_0 \big[ P_{\neq}(a)P_{\neq}(\partial_v - t\partial_z)P_{\neq}(\Pi) \big] = P_0 \Big( \partial_z \Psi \partial_z (\partial_v - t\partial_z)\Psi - \partial_{zz} \Psi \partial_v \Psi \Big).$$

Note that (2.15) is not our final working system. The main part of the nonlocal quasi-linear term  $-\varphi_1 \partial_z P_{\neq}(\Psi)$  will be eliminated by applying the wave operator.

2.5. Linearization and the inverse linear change of coordinate. Let us also introduce the linearization of (2.15) in (t, z, v) coordinates

(2.19) 
$$\begin{cases} \partial_t \Omega - \widetilde{\varphi_1} \partial_z P_{\neq} \Psi = 0, \\ \tilde{\Delta}_t^l \Psi \stackrel{\text{def}}{=} \widetilde{\varphi_4} \partial_{zz} \Psi + \widetilde{u'} (\partial_v - t \partial_z) \Big( \widetilde{\varphi_4} \widetilde{u'} (\partial_v - t \partial_z) \Psi \Big) = \Omega, \end{cases}$$

Here we recall that  $\widetilde{\varphi_1}(v) = \left(\left(\frac{u'}{\theta}\right)' \circ u^{-1}\right)(v), \ \widetilde{\varphi_4}(v) = \frac{1}{(\theta \circ u^{-1})(v)} \text{ and } \widetilde{u'}(v) = (u' \circ u^{-1})(v).$  Let us now introduce the inverse linear change of coordinate, namely,  $(t, z, v) \to (t, x, y)$ :

(2.20) 
$$y = u^{-1}(v), \quad x = z + tu(y)$$

Define  $\tilde{\omega}(t, x, y) = \Omega(t, x - tu(y), u(y))$  and  $\psi(t, x, y) = \Psi(t, x - tu(y), u(y))$ . Then we arrive at

(2.21) 
$$\partial_t \tilde{\omega} + \partial_x \mathcal{R} \tilde{\omega} = 0, \quad \psi = \Delta^{-1} \tilde{\omega}$$

where  $\mathcal{R} = u \mathrm{Id} - \left(\frac{u'}{\theta}\right)' \tilde{\Delta}^{-1}$  is the distorted Rayleigh operator. Note that here we use the same notation (t, x, y),  $\tilde{\omega}$ , and  $\psi$ . They are different from the functions in (2.2) written in original (t, x, y) coordinates.

### 3. Linear inviscid damping

In this section, we study the linearized equation (2.21). The main purpose is to introduce the wave operator associated with the distorted Rayleigh operator  $\mathcal{R}$ .

The wave operator related to a self-adjoint operator is well-known [13, 31, 15, 25, 32, 36]. Let A, B be two self-adjoint operators in the Hilbert space H, then the wave operator  $\mathbb{D}$  related to A and B satisfies

$$A\mathbb{D} = \mathbb{D}B$$

It can be defined by

$$\mathbb{D} = \lim_{t \to \infty} e^{-itA} e^{itB}.$$

However, the wave operator related to non-self-adjoint operators is usually not easy to construct and estimate. Let us explain the intuition of the construction on the operator  $i\partial_x$  associated with the Fourier transform. More precisely, we know that  $\lambda$  and  $e^{-i\lambda x}$  are the generalized eigenvalue and eigenfunction. For any function  $f \in L^1 \cap L^2$  we have the representation formula

(3.1) 
$$f(x) = \int_{\mathbb{R}} \langle f, e^{-i\lambda x} \rangle e^{-i\lambda x} d\lambda.$$

Let us define  $T(f)(\lambda) = \langle f, e^{-i\lambda x} \rangle = \int_{\mathbb{R}} f(x)e^{ix\lambda}dx$ , then  $T \circ (i\partial_x) = \lambda T$ , and we can regard T as a wave operator conjugating  $i\partial_x$  to the multiplication by  $\lambda$ .

# 3.1. The distorted Rayleigh equation. By taking the Fourier transform in x, we have

$$\partial_t \tilde{\Delta}_k \hat{\psi} + iku(y)\tilde{\Delta}_k \hat{\psi} - ik(\frac{u'}{\theta})'\hat{\psi} = 0.$$

Let  $\tilde{\mathcal{L}}_k \hat{\psi} = \tilde{\Delta}_k^{-1} \left( u(y) \tilde{\Delta}_k \hat{\psi} - \left(\frac{u'}{\theta}\right)' \hat{\psi} \right)$ . We then have

(3.2) 
$$\hat{\psi}(t,k,y) = \frac{1}{2\pi i} \oint_{\partial \mathcal{S}} e^{-ickt} (c - \tilde{\mathcal{L}}_k)^{-1} \hat{\psi}_{in} dc$$

where  $\mathcal{S}$  contains the spectrum of  $\tilde{\mathcal{L}}_k$ . Next, we study the resolvent  $\Psi^I = (c - \tilde{\mathcal{L}}_k)^{-1} \hat{\psi}_{in}$ . Then  $\Psi^I$  solves the distorted inhomogeneous Rayleigh equation

(3.3) 
$$(u-c)\partial_y \left(\frac{1}{\theta}\partial_y \Psi^I\right) - (u-c)\frac{k^2}{\theta}\Psi^I - \left(\frac{u'}{\theta}\right)'\Psi^I = -\tilde{\Delta}_k \hat{\psi}_{in} = -\hat{\tilde{\omega}}_{in}$$

with boundary condition  $\Psi^{I}(0) = \Psi^{I}(1) = 0$ . We also introduce the homogeneous distorted Rayleigh equation

(3.4) 
$$(u-c)\partial_y\left(\frac{1}{\theta}\partial_y\Psi^H\right) - (u-c)\frac{k^2}{\theta}\Psi^H - \left(\frac{u'}{\theta}\right)'\Psi^H = 0.$$

**Remark 3.1.** Let  $u \in C^4$ ,  $u' \neq 0$  and  $\theta > 0$ . Then we have the following facts:

• Ran  $u \subset \sigma(\tilde{\mathcal{L}}_k)$  is the continuous spectrum.

- If  $c \notin \operatorname{Ran} u$  is an eigenvalue of  $\tilde{\mathcal{L}}_k$ , then (3.4) has a non-trivial solution in  $H^2(0,1) \cap H^1_0(0,1)$ .
- If  $c = u(y_c) \in \operatorname{Ran} u$  is an embedded eigenvalue, then  $\left(\frac{u'}{\theta}\right)'(y_c) = 0$ . The boundary value u(0), u(1) are not the embedded eigenvalue.
- If  $\left(\frac{u'}{A}\right)'$  does not change sign in [0,1], then  $\tilde{\mathcal{L}}_k$  has no eigenvalue or embedded eigenvalue.

3.2. Homogeneous equation. In this section, we show the existence of a smooth solution to the homogeneous equation (3.4).

**Proposition 3.2.** Let  $y, y' \in [0, 1]$ , and let  $\phi_1$  solve

(3.5) 
$$\phi_1(y,y',k) = 1 + \int_{y'}^y \frac{k^2 \theta(z')}{(u(z') - u(y'))^2} \int_{y'}^{z'} \frac{(u(z'') - u(y'))^2}{\theta(z'')} \phi_1(z'',y',k) dz'' dz'$$

or in the differential equation form

(3.6) 
$$\begin{cases} \partial_y \left( \frac{(u(y) - u(y'))^2}{\theta(y)} \partial_y \phi_1(y, y', k) \right) = k^2 \frac{(u(y) - u(y'))^2}{\theta(y)} \phi_1(y, y', k), \\ \phi_1(y', y', k) = 1 \quad \partial_y \phi_1(y', y', k) = 0. \end{cases}$$

Then  $\phi(y, y', k) = (u(y) - u(y'))\phi_1(y, y', k)$  solves (3.4) with  $c = u(y') \in \operatorname{Ran} u$ . Let  $\epsilon_0 > 0$  and for  $|\epsilon| < \epsilon_0$ , let  $\phi_1(y, y', \epsilon, k)$  solve

(3.7) 
$$\phi_1(y,y',\epsilon,k) = 1 + \int_{y'}^y \int_{y'}^{z'} \frac{k^2 \theta(z') (u(z'') - u(y') - i\epsilon)^2}{\theta(z'') (u(z') - u(y') - i\epsilon)^2} \phi_1(z'',y',\epsilon,k) dz'' dz'$$

or in the differential equation form

(3.8) 
$$\begin{cases} \partial_y \left( \frac{(u(y) - u(y') - i\epsilon)^2}{\theta(y)} \partial_y \phi_1(y, y', \epsilon, k) \right) = k^2 \frac{(u(y) - u(y') - i\epsilon)^2}{\theta(y)} \phi_1(y, y', \epsilon, k), \\ \phi_1(y', y', \epsilon, k) = 1 \quad \partial_y \phi_1(y', y', \epsilon, k) = 0. \end{cases}$$

Then  $\phi(y, y', \epsilon, k) = (u(y) - u(y') - i\epsilon)\phi_1(y, y', \epsilon, k)$  solves (3.4) with  $c = u(y') + i\epsilon$ . Moreover, the following estimates hold for  $y, y' \in [0, 1]$ ,  $k \in \mathbb{Z} \setminus \{0\}$ , and  $|\epsilon| < \epsilon_0$ .

(3.9) 
$$\phi_1(y, y', k) \ge 1, \quad (y - y')\partial_y \phi_1(y, y', k) \ge 0$$

(3.10) 
$$C^{-1}e^{C^{-1}|k|(|y-y'|)} \le \phi_1(y,y',k) \le Ce^{C|k||y-y'|},$$

(3.11) 
$$C^{-1}|k|\min\{|k|(y-y'),1\} \le \frac{|\partial_y \phi_1(y,y',k)|}{\phi_1(y,y',k)} \le C|k|\min\{|k|(y-y'),1\}$$

(3.12) 
$$|\partial_{yy}\phi_1(y,y',k)| \le Ck^2\phi_1(y,y',k),$$

(3.13) 
$$0 \le \phi_1(y, y', k) - 1 \le C \min\{1, |k|^2 | y - y'|^2\} \phi_1(y, y', k),$$

and  $\phi_1(y, y', \epsilon, k) \rightarrow \phi_1(y, y', k)$  as  $\epsilon \rightarrow 0$ , and for  $\epsilon_0$  small enough (may depend on k)

(3.14) 
$$\frac{1}{2} \le |\phi_1(y, y', \epsilon, k)| \le C e^{C|k||y-y'|}$$

Here C is a constant independent of k.

*Proof.* Existence part. We first show the existence of  $\phi_1(y, y', \epsilon, k)$  for any fixed  $k \in \mathbb{Z} \setminus \{0\}$  and  $(y, y', \epsilon) \in [0, 1]^2 \times [-\epsilon_0, \epsilon_0]$ . We introduce the weighted norm

$$||f||_{X_0} \stackrel{\text{def}}{=} \sup_{(y,y') \in [0,1]^2} \left| \frac{f(y,y')}{\cosh A(y-y')} \right|,$$

$$\|f\|_X \stackrel{\text{def}}{=} \sup_{(y,y',\epsilon) \in [0,1]^2 \times [-\epsilon_0,\epsilon_0]} \left| \frac{f(y,y',\epsilon)}{\cosh A(y-y')} \right|,$$

and

$$\|f\|_{Y_0} \stackrel{\text{def}}{=} \sum_{k=0}^2 \sum_{|\beta|=k} A^{-k} \|\nabla_{y,y'}^{\beta} f\|_{X_0},$$
  
$$\|f\|_Y \stackrel{\text{def}}{=} \|f\|_X + \frac{1}{A} (\|\partial_y f\|_X + \|\partial_{y'} f\|_X + \|\partial_\epsilon f\|_X).$$

Consider the linear operator for  $0 \leq \epsilon \leq |\epsilon_0|$ 

$$T_{\epsilon}[\phi_1] = \int_{y'}^{y} \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} \phi_1(z'', y', \epsilon, k) dz'' dz',$$

it is easy to check that

$$||T_0[\phi_1]||_{X_0} \le \frac{C}{A^2} ||\phi_1||_{X_0}, \quad ||T_\epsilon[\phi_1]||_X \le \frac{C}{A^2} ||\phi_1||_X.$$

A direct calculation gives

$$\partial_y T_{\epsilon}[\phi_1] = \int_{y'}^y \frac{\theta(y)(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(y) - u(y') - i\epsilon)^2} \phi_1(z'', y', \epsilon, k) dz'',$$

which gives

$$\|\partial_y T_0[\phi_1]\|_{X_0} \le \frac{C}{A} \|\phi_1\|_{X_0}, \quad \|\partial_y T_\epsilon[\phi_1]\|_X \le \frac{C}{A} \|\phi_1\|_X.$$

We also have

$$\partial_{yy}T_{\epsilon}[\phi_{1}] = \phi_{1} + \int_{y'}^{y} \frac{\theta'(y)(u(z'') - u(y') - i\epsilon)^{2}}{\theta(z'')(u(y) - u(y') - i\epsilon)^{2}} \phi_{1}(z'', y', \epsilon, k)dz'' - 2\int_{y'}^{y} \frac{\theta(y)u'(y)(u(z'') - u(y') - i\epsilon)^{2}}{\theta(z'')(u(y) - u(y') - i\epsilon)^{3}} \phi_{1}(z'', y', \epsilon, k)dz'',$$

which gives

$$\|\partial_{yy}T_0[\phi_1]\|_{X_0} \le C \|\phi_1\|_{X_0}, \quad \|\partial_{yy}T_{\epsilon}[\phi_1]\|_X \le C \|\phi_1\|_X.$$

A direct calculation gives for  $-\epsilon_0 \leq \epsilon \leq \epsilon_0$ 

$$\begin{aligned} (\partial_y + \partial_{y'})T_{\epsilon}[\phi_1] &= \int_{y'}^y \int_{y'}^{z'} (\partial_{y'} + \partial_{z'} + \partial_{z''}) \left( \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} \phi_1(z'', y', \epsilon, k) \right) dz'' dz' \\ &= \int_{y'}^y \int_{y'}^{z'} (\partial_{y'} + \partial_{z'} + \partial_{z''}) \left( \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} \right) \phi_1(z'', y', \epsilon, k) dz'' dz' \\ &+ \int_{y'}^y \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} (\partial_{y'} + \partial_{z''}) \phi_1(z'', y', \epsilon, k) dz'' dz' \end{aligned}$$

and

$$\begin{aligned} (\partial_y + \partial_{y'})^2 T_{\epsilon}[\phi_1] \\ &= \int_{y'}^y \int_{y'}^{z'} (\partial_{y'} + \partial_{z'} + \partial_{z''})^2 \left( \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} \right) \phi_1(z'', y', \epsilon, k) dz'' dz' \end{aligned}$$

$$+ \int_{y'}^{y} \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} (\partial_{y'} + \partial_{z''})^2 \phi_1(z'', y', \epsilon, k) dz'' dz' + \int_{y'}^{y} \int_{y'}^{z'} (\partial_{y'} + \partial_{z'} + \partial_{z''}) \left( \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} \right) (\partial_{y'} + \partial_{z''}) \phi_1(z'', y', \epsilon, k) dz'' dz',$$

which together with the fact that for  $0 \leq y' \leq z'' \leq z' \leq 1$  or  $0 \leq z' \leq z'' \leq y' \leq 1$ 

$$\left| (\partial_{y'} + \partial_{z'} + \partial_{z''})^j \left( \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^2}{\theta(z'')(u(z') - u(y') - i\epsilon)^2} \right) \right| \le C, \quad \text{for} \quad j = 0, 1, 2,$$

gives that

$$\begin{split} \|(\partial_{y} + \partial_{y'})T_{0}[\phi_{1}]\|_{X_{0}} &\leq \frac{C}{A^{2}} \left(\|(\partial_{y} + \partial_{y'})\phi_{1}\|_{X_{0}} + \|\phi_{1}\|_{X_{0}}\right), \\ \|(\partial_{y} + \partial_{y'})T_{\epsilon}[\phi_{1}]\|_{X} &\leq \frac{C}{A^{2}} \left(\|(\partial_{y} + \partial_{y'})\phi_{1}\|_{X} + \|\phi_{1}\|_{X}\right), \\ \|(\partial_{y} + \partial_{y'})^{2}T_{0}[\phi_{1}]\|_{X_{0}} &\leq \frac{C}{A^{2}} \left(\|(\partial_{y} + \partial_{y'})^{2}\phi_{1}\|_{X_{0}} + \|(\partial_{y} + \partial_{y'})\phi_{1}\|_{X_{0}} + \|\phi_{1}\|_{X_{0}}\right), \\ \|(\partial_{y} + \partial_{y'})^{2}T_{\epsilon}[\phi_{1}]\|_{X} &\leq \frac{C}{A^{2}} \left(\|(\partial_{y} + \partial_{y'})^{2}\phi_{1}\|_{X} + \|(\partial_{y} + \partial_{y'})\phi_{1}\|_{X} + \|\phi_{1}\|_{X}\right). \end{split}$$

We also have

$$\begin{aligned} \partial_{\epsilon} T_{\epsilon}[\phi_{1}] &= -2i \int_{y'}^{y} \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y') - i\epsilon)}{\theta(z'')(u(z') - u(y') - i\epsilon)^{2}} \phi_{1}(z'', y', \epsilon, k) dz'' dz' \\ &+ 2i \int_{y'}^{y} \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^{2}}{\theta(z'')(u(z') - u(y') - i\epsilon)^{3}} \phi_{1}(z'', y', \epsilon, k) dz'' dz' \\ &+ \int_{y'}^{y} \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y') - i\epsilon)^{2}}{\theta(z'')(u(z') - u(y') - i\epsilon)^{2}} \partial_{\epsilon} \phi_{1}(z'', y', \epsilon, k) dz'' dz', \end{aligned}$$

which gives

$$\|\partial_{\epsilon}T_{\epsilon}[\phi_1]\|_X \le \frac{C}{A}\|\phi_1\|_X + \frac{C}{A^2}\|\partial_{\epsilon}\phi_1\|_X$$

By combining all the estimates, we arrive at

$$||T_0[\phi_1]||_{Y_0} \le \frac{C}{A^2} ||\phi_1||_{Y_0}, \quad ||T_\epsilon[\phi_1]||_Y \le \frac{C}{A^2} ||\phi_1||_Y.$$

By using the equations

$$\phi_1(y, y', \epsilon, k) = 1 + k^2 T_{\epsilon}[\phi_1](y, y', \epsilon, k)$$
 and  $\phi_1(y, y', k) = 1 + k^2 T_{\epsilon}[\phi_1](y, y', k)$ 

and taking A large enough, we show that  $T_{\epsilon}$  is the contraction map yields the existence of  $\phi_1(y, y', \epsilon, k)$ and  $\phi_1(y, y', k)$ .

**Estimate part.** The estimate (3.9) follows directly from the fact that  $T_0$  is a positive operator. We also get that for  $0 \le y' \le z'' \le y \le 1$  or  $0 \le y \le z'' \le y' \le 1$ ,

$$1 \le \phi_1(z'', y', k) \le \phi_1(y, y', k).$$

Thus

$$\begin{split} \phi_1(y,y',k) - 1 &= k^2 \int_{y'}^y \int_{y'}^{z'} \frac{\theta(z')(u(z'') - u(y'))^2}{\theta(z'')(u(z') - u(y'))^2} \phi_1(z'',y',k) dz'' dz' \\ &\leq Ck^2 |y - y'|^2 \phi_1(y,y',k), \end{split}$$

$$\begin{aligned} |\partial_y \phi_1(y, y', k)| &= k^2 \left| \int_{y'}^y \frac{\theta(y)(u(z'') - u(y'))^2}{\theta(z'')(u(y) - u(y'))^2} \phi_1(z'', y', k) dz'' \right| \\ &\leq k^2 |y - y'| \phi_1(y, y', k), \end{aligned}$$

which gives (3.13) and part of (3.11). We introduce  $f(y, y', k) = \frac{\partial_y \phi_1(y, y', k)}{\theta(y) \phi_1(y, y', k)}$  then  $f(y, y', k) \ge 0$  for  $y \ge y'$  and  $f(y, y', k) \le 0$  for  $y \le y'$ . We also have

$$f' + \frac{2u'}{u(y) - u(y')}f + f^2\theta = \frac{k^2}{\theta},$$

and  $f'(y', y', k) = \frac{k^2}{3\theta(y')} > 0$ . By the continuity of f and the fact that  $\frac{2u'}{u(y)-u(y')}f \ge 0$ , using a classical contradiction argument, we have  $|f(y, y', k)| \le \frac{|k|}{\theta(y)}$ , which gives (3.11). We also get that

(3.15) 
$$|f'(y, y', k)| \le Ck^2$$

and

$$\frac{\phi_1(z'', y', k)}{\phi_1(y, y', k)} = \exp\left(\int_y^{z''} \theta(z') f(z', y', k) dz'\right) \ge e^{-|k||y-z''|}$$

Thus we have for  $|y - y'| \le \frac{1}{|k|}, \ 1 \le \phi_1(z'', y, k) \le \phi_1(y, y', k) \le C$ 

$$\left| \frac{\partial_y \phi_1(y, y', k)}{\phi_1(y, y', k)} \right| = k^2 \left| \int_{y'}^y \frac{\theta(y)(u(z'') - u(y'))^2}{\theta(z'')(u(y) - u(y'))^2} \frac{\phi_1(z'', y', k)}{\phi_1(y, y', k)} dz'' \right|$$
  
$$\geq C^{-1} k^2 |y - y'|$$

and for  $|y - y'| \ge \frac{1}{|k|}$  and if y > y'

$$\begin{split} \left| \frac{\partial_y \phi_1(y, y', k)}{\phi_1(y, y', k)} \right| &= k^2 \int_{y'}^y \frac{\theta(y)(u(z'') - u(y'))^2}{\theta(z'')(u(y) - u(y'))^2} \frac{\phi_1(z'', y', k)}{\phi_1(y, y', k)} dz'' \\ &\geq C^{-1} k^2 \int_{y'}^y \frac{(u(z'') - u(y'))^2}{(u(y) - u(y'))^2} e^{-|k||y - z''|} dz'' \\ &\geq C^{-1} k^2 \int_{y - \frac{1}{2|k|}}^y \frac{(u(z'') - u(y'))^2}{(u(y) - u(y'))^2} e^{-|k||y - z''|} dz'' \geq C^{-1} |k| \end{split}$$

and if y < y',

$$\left|\frac{\partial_y \phi_1(y, y', k)}{\phi_1(y, y', k)}\right| \ge C^{-1} k^2 \int_y^{y + \frac{1}{2|k|}} \frac{(u(z'') - u(y'))^2}{(u(y) - u(y'))^2} e^{-|k||y - z''|} dz'' \ge C^{-1} |k|.$$

We now use

$$\phi_1(y, y', k) = \exp\left(\int_{y'}^y \frac{\partial_y \phi_1(z', y', k)}{\phi_1(z', y', k)} dz'\right) \ge e^{C^{-1}|k||y-y'|},$$

which give (3.10). The estimate (3.12) follows directly from (3.15) and (3.12). The estimate (3.14)follows from the fact that  $\phi_1(y, y', \epsilon, k)$  is continuous in  $\epsilon$  and (3.10). Thus we proved the proposition. 

3.3. Inhomogeneous solution. In this section, we give the representation formula of the inhomogeneous solution to (3.3) and study the limit as  $\epsilon \to 0$ . Let us first introduce

$$\rho(y') = (u(y') - u(0))(u(1) - u(y')),$$

and

$$J_{1}(y',k) \stackrel{\text{def}}{=} -(u(1) - u(y'))\frac{\theta(0)}{u'(0)} - (u(y') - u(0))\frac{\theta(1)}{u'(1)} + \rho(y') \int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y'))^{2}} \left(\frac{1}{\phi_{1}(z',y',k)^{2}} - 1\right) dz' - \rho(y') \mathcal{H}\left[\left((\theta \circ u^{-1})(u^{-1})'\right)' \chi_{\left[u(0),u(1)\right]}\right](u(y')) = -(u(1) - u(y'))\frac{\theta(0)}{u'(0)} - (u(y') - u(0))\frac{\theta(1)}{u'(1)} + \rho(y') \int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y'))^{2}} \left(\frac{1}{\phi_{1}(z',y',k)^{2}} - 1\right) dz' + \rho(y') P.V. \int_{0}^{1} \frac{1}{u(z) - u(y')} \left(\frac{\theta(z)}{u'(z)}\right)' dz,$$

and

(3.16b) 
$$J_2(y') = \rho(y') \left( (\theta \circ u^{-1})(u^{-1}) \right)' (u(y')) = -\rho(y') \frac{\theta(y')^2}{u'(y')^3} \left( \frac{u'}{\theta} \right)' (y').$$

We then have the following lemma.

**Lemma 3.3.** Let  $y' \in [0,1]$  and  $k \in \mathbb{Z} \setminus \{0\}$ . Then  $u(y') \in \operatorname{Ran} u$  is an embedded eigenvalue of  $\tilde{\mathcal{L}}_k$ , if and only if

$$J_1(y',k)^2 + J_2(y')^2 = 0$$

Proof. Suppose  $J_1(y',k)^2 + J_2(y')^2 = 0$ , then  $\left(\frac{u'}{\theta}\right)'(y') = 0$  and  $y' \neq 0, 1$ . We have for  $0 \le y < y'$ ,

$$\varphi_1(y,y') = \phi(0,y',k)\phi(y,y',k) \int_0^y \frac{\theta(z)}{\phi(z,y',k)^2} dz$$

solves the homogeneous equation (3.4) with boundary condition  $\varphi_1(0, y') = 0$  and  $\partial_y \varphi_1(0, y') = 1$ . Next, we show that  $\varphi_1$  can naturally  $C^2$  extend to  $y' \leq y \leq 1$  under the assumption  $\left(\frac{u'}{\theta}\right)'(y') = 0$ . A direct calculation gives for  $0 \leq y < y'$ ,

$$\begin{split} \varphi_1(y,y') =& \phi(0,y',k)\phi(y,y',k) \int_0^y \frac{\theta(z)}{(u(z)-u(y'))^2} dz \\ &+ \phi(0,y',k)\phi(y,y',k) \int_0^y \frac{\theta(z)}{(u(z)-u(y'))^2} \Big(\frac{1}{\phi_1(z,y',k)^2} - 1\Big) dz \\ =& \phi(0,y',k)\phi(y,y',k) \int_{u(0)}^{u(y)} \frac{(\theta \circ u^{-1})(\tilde{u})(u^{-1})'(\tilde{u})}{(\tilde{u}-u(y'))^2} d\tilde{u} \\ &+ \phi(0,y',k)\phi(y,y',k) \int_0^y \frac{\theta(z)}{(u(z)-u(y'))^2} \Big(\frac{1}{\phi_1(z,y',k)^2} - 1\Big) dz \\ =& \phi(0,y',k)\phi(y,y',k) \int_{u(0)}^{u(y)} \frac{(\theta \circ u^{-1})(\tilde{u})(u^{-1})'(\tilde{u}) - (\theta \circ u^{-1})(u(y'))(u^{-1})'(u(y'))}{(\tilde{u}-u(y'))^2} d\tilde{u} \end{split}$$

$$-\frac{\phi(0,y',k)\phi(y,y',k)(\theta\circ u^{-1})(u(y'))(u^{-1})'(u(y'))}{\tilde{u}-u(y')}\Big|_{u(0)}^{u(y)} +\phi(0,y',k)\phi(y,y',k)\int_{0}^{y}\frac{\theta(z)}{(u(z)-u(y'))^{2}}\Big(\frac{1}{\phi_{1}(z,y',k)^{2}}-1\Big)dz = I_{1}(y)+I_{2}(y)+I_{3}(y).$$

Note that the assumption  $\left(\frac{u'}{\theta}\right)'(y') = 0$  gives  $\left((\theta \circ u^{-1})(u^{-1})'\right)'(u(y')) = 0$ , which gives that the integral in  $I_1$ 

$$\begin{split} &\int_{u(0)}^{u(y)} \frac{[(\theta \circ u^{-1})(u^{-1})'](\tilde{u}) - [(\theta \circ u^{-1})(u^{-1})'](u(y'))}{(\tilde{u} - u(y'))^2} d\tilde{u} \\ &= \int_{u(0)}^{u(y)} \frac{[(\theta \circ u^{-1})(u^{-1})'](\tilde{u}) - [(\theta \circ u^{-1})(u^{-1})'](u(y')) - ((\theta \circ u^{-1})(u^{-1})')'(u(y'))(\tilde{u} - u(y'))}{(\tilde{u} - u(y'))^2} d\tilde{u} \end{split}$$

is well defined for all  $y \in [0, 1]$  and  $I_j(y) \in C^2$ , for j = 1, 2, 3. It is easy to check that  $I_1 + I_2 + I_3$  is also well defined for all  $y \in [0, 1]$  which also solves homogeneous equation (3.4) with c = u(y'). We also use  $\varphi_1(y, y')$  to represent its extension. A direct calculation gives

$$\varphi_1(1, y') = I_1(1) + I_2(1) + I_3(1) = -\phi_1(0, y', k)\phi_1(1, y', k)J_1(y', k) = 0.$$

Thus  $\varphi_1(y, y')$  is an eigenfunction associated with the embedded eigenvalue u(y').

Suppose u(y') is an embedded eigenvalue and  $\Phi^H \in H^2$  is the corresponding eigenfunction. Then  $\partial_y \left(\frac{1}{\theta}\partial_y \Phi^H\right) = \frac{k^2}{\theta} \Phi^H + \frac{\left(\frac{u'}{\theta}\right)' \Phi^H(y)}{u(y) - u(y')} \in L^2$ . Thus either  $\Phi^H(y') = 0$  or  $\left(\frac{u'}{\theta}\right)'(y') = 0$ . If  $\Phi^H(y') = 0$ , we have

$$\begin{split} 0 &= \int_0^1 \frac{1}{\theta} (|\partial_y \Phi^H|^2 + k^2 |\Phi^H|^2) dy + \int_0^1 \frac{(\frac{u'}{\theta})' |\Phi^H(y)|^2}{u(y) - u(y')} dy \\ &= \int_0^1 \frac{1}{\theta} (|\partial_y \Phi^H|^2 + k^2 |\Phi^H|^2) dy - 2\operatorname{Re} \int_0^1 \frac{(\frac{u'}{\theta}) \partial_y \Phi^H(y) \overline{\Phi^H(y)}}{u(y) - u(y')} dy + \int_0^1 \frac{(\frac{u'}{\theta}) u' |\Phi^H(y)|^2}{(u(y) - u(y'))^2} dy \\ &= \int_0^1 \frac{1}{\theta} \left| \partial_y \Phi^H - \frac{u' \Phi^H(y)}{u(y) - u(y')} \right|^2 + \frac{k^2}{\theta} |\Phi^H|^2 dy, \end{split}$$

which gives  $\Phi^H \equiv 0$ . Thus  $\left(\frac{u'}{\theta}\right)'(y') = 0$  which means  $J_2(y') = 0$ . Then by the argument in the first part,  $\varphi_1(y, y')$  is a  $C^2$  solution that solves the homogeneous equation (3.4) with c = u(y'). Then  $\varphi_1(y, y')$  is an eigenfunction if and only if  $\varphi_1(1, y') = 0$ , which gives  $J_1(y', k) = 0$ . Thus we proved the lemma.

By following a similar idea, we have the following lemma.

**Lemma 3.4.** Let  $k \in \mathbb{Z} \setminus \{0\}$  and  $c = u(y') + i\epsilon$  with  $0 < |\epsilon| \le \epsilon_0$ . Then c is an eigenvalue of  $\hat{\mathcal{L}}_k$  if and only if

$$\int_0^1 \frac{\theta(z')}{\phi(z',y',\epsilon,k)^2} dz' = 0$$

*Proof.* The function

$$\varphi(y,y',\epsilon,k) = \phi(0,y',\epsilon,k)\phi(y,y',\epsilon,k)\int_0^y \frac{\theta(z')}{\phi(z',y',\epsilon,k)^2} dz' \in H^2$$

is a solution to the homogeneous equation (3.4) with  $c = u(y') + i\epsilon$  with boundary value  $\varphi(0, y', \epsilon, k) = 0$  and  $\partial_y \varphi(0, y', \epsilon, k) = 1$ . The integral is well-defined for all  $y \in [0, 1]$  by taking  $\epsilon_0$  small enough.

Thus  $\varphi(y, y', \epsilon, k)$  is an eigenfunction associated with  $c = u(y') + i\epsilon$  if and only if  $\varphi(1, y', \epsilon, k) = 0$ . The lemma follows directly from the fact that  $\phi(0, y', \epsilon, k)\phi(1, y', \epsilon, k) \neq 0$  for  $\epsilon \neq 0$ .

**Lemma 3.5.** Under the assumption that  $\tilde{\mathcal{L}}_k$  has no embedded eigenvalue, we have

$$C^{-1}(1+k^2\rho(y')^2) \le J_1(y',k)^2 + \pi^2 J_2(y')^2 \le C(1+k^2\rho(y')^2).$$

*Proof.* For  $|k| \leq M_0$ , Lemma 3.3 implies

$$J_1(y',k)^2 + \pi^2 J_2(y')^2 \approx_{M_0} 1.$$

Let us now consider the case  $|k| > M_0$  with  $M_0$  large enough. By Proposition 3.2, we have

$$\begin{split} &\int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y'))^{2}} \Big( \frac{1}{\phi_{1}(z', y', k)^{2}} - 1 \Big) dz' \\ &\leq -C^{-1} \int_{|z'-y'| \leq \frac{1}{|k|}} \frac{1}{(z'-y')^{2}} \left| \int_{z'}^{y'} \partial_{y} \phi_{1}(z'', y', k) dz'' \right| dz' \\ &\leq -C^{-1} \int_{|z'-y'| \leq \frac{1}{|k|}} k^{2} dz' \leq -C^{-1} |k|. \end{split}$$

It is easy to check that

$$\begin{aligned} & \left| \int_0^1 \frac{\theta(z')}{(u(z') - u(y'))^2} \Big( \frac{1}{\phi_1(z', y', k)^2} - 1 \Big) dz' \right| \\ & \leq C \int_0^1 \frac{1}{(z' - y')^2} \min\{k^2 | z' - y' |^2, 1\} dz' \leq C |k|, \end{aligned}$$

and

$$\left|\mathcal{H}\left[\left((\theta \circ u^{-1})(u^{-1})'\right)'\chi_{[u(0),u(1)]}\right](u(y'))\right| \le C \|\left((\theta \circ u^{-1})(u^{-1})'\right)'\|_{H^1}.$$

Thus we have

$$J_{1}(y',k)^{2} \geq \left(-(u(1)-u(y'))\frac{\theta(0)}{u'(0)} - (u(y')-u(0))\frac{\theta(1)}{u'(1)}\right)^{2} \\ + \rho(y')^{2} \left| \int_{0}^{1} \frac{\theta(z')}{(u(z')-u(y'))^{2}} \left(\frac{1}{\phi_{1}(z',y',k)^{2}} - 1\right) dz' \right|^{2} \\ - \left(\rho(y')\mathcal{H}\left[ \left((\theta \circ u^{-1})(u^{-1})'\right)'\chi_{[u(0),u(1)]}\right](u(y')) \right)^{2} \\ \geq C^{-1}(1+k^{2}\rho(y')^{2})$$

and

$$\begin{aligned} J_1(y',k)^2 &\leq \Big( -(u(1)-u(y'))\frac{\theta(0)}{u'(0)} - (u(y')-u(0))\frac{\theta(1)}{u'(1)} \Big)^2 \\ &+ \rho(y')^2 \left| \int_0^1 \frac{\theta(z')}{(u(z')-u(y'))^2} \Big( \frac{1}{\phi_1(z',y',k)^2} - 1 \Big) dz' \right|^2 \\ &+ \Big( \rho(y')\mathcal{H} \big[ \big( (\theta \circ u^{-1})(u^{-1})' \big)' \chi_{[u(0),u(1)]} \big] (u(y')) \Big)^2 \\ &\leq C(1+k^2\rho(y')^2). \end{aligned}$$

Thus we prove the lemma.

Now let us study the inhomogeneous equation (3.3). By using the homogeneous solution, we rewrite it as

$$\partial_y \left( \frac{\phi^2}{\theta} \partial_y \left( \frac{\Psi^I}{\phi} \right) \right) = -\hat{\tilde{\omega}}_{in} \phi_1.$$

Thus, for  $c = u(y') + i\epsilon$  with  $y' \in [0,1]$  and  $0 < |\epsilon| \le \epsilon_0$ , it holds that

$$\begin{split} \Psi^{I}(y,y',\epsilon,k) &= -\phi(y,y',\epsilon,k) \int_{0}^{y} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k) \phi_{1}(z'',y',\epsilon,k) dz''}{(u(z') - u(y') - i\epsilon)^{2} \phi_{1}(z',y',\epsilon,k)^{2}} dz' \\ &+ \frac{\int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k) \phi_{1}(z'',y',\epsilon,k) dz''}{\int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y') - i\epsilon)^{2} \phi_{1}(z',y',\epsilon,k)^{2}} dz'} \phi(y,y',\epsilon,k) \int_{0}^{y} \frac{\theta(z')}{\phi(z',y',\epsilon,k)^{2}} dz' \\ &= -\phi(y,y',\epsilon,k) \int_{1}^{y} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k) \phi_{1}(z'',y',\epsilon,k) dz''}{(u(z') - u(y') - i\epsilon)^{2} \phi_{1}(z',y',\epsilon,k)^{2}} dz'} dz' \\ &+ \frac{\int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k) \phi_{1}(z'',y',\epsilon,k) dz''}{\int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k) \phi_{1}(z'',y',\epsilon,k)^{2}} dz'} \phi(y,y',\epsilon,k) \int_{1}^{y} \frac{\theta(z')}{\phi(z',y',\epsilon,k)^{2}} dz'. \end{split}$$

Note that Lemma 3.4 ensures that the above representation formula is well-defined by taking  $\epsilon_0$  small enough. By the continuity of  $\phi(y, y', \epsilon, k)$  in  $\epsilon$ , it holds that

$$\begin{split} &\lim_{\epsilon \to 0} \phi(y, y', \epsilon, k) \int_{1}^{y} \frac{\theta(z')}{\phi(z', y', \epsilon, k)^{2}} dz' = \phi(y, y', k) \int_{1}^{y} \frac{\theta(z')}{\phi(z', y', k)^{2}} dz' \quad \text{for} \quad y' < y \leq 1\\ &\lim_{\epsilon \to 0} \phi(y, y', \epsilon, k) \int_{0}^{y} \frac{\theta(z')}{\phi(z', y', \epsilon, k)^{2}} dz' = \phi(y, y', k) \int_{0}^{y} \frac{\theta(z')}{\phi(z', y', k)^{2}} dz' \quad \text{for} \quad 0 \leq y < y'\\ &\lim_{\epsilon \to 0} \phi(y, y', \epsilon, k) \int_{j}^{y} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'', k) \phi_{1}(z'', y', \epsilon, k) dz''}{(u(z') - u(y') - i\epsilon)^{2} \phi_{1}(z', y', \epsilon, k)^{2}} dz' \quad \text{for} \quad 0 \leq y < y'\\ &= \phi(y, y', k) \int_{j}^{y} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'', k) \phi_{1}(z'', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \quad \text{for} \quad j = 0, 1, \ y \in [0, 1]. \end{split}$$

We have for  $y' \in (0,1)$ 

$$\begin{split} &\int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y') - i\epsilon)^{2} \phi_{1}(z', y', \epsilon, k)^{2}} dz' \\ &= \int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y') - i\epsilon)^{2}} dz' + \int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y') - i\epsilon)^{2}} \Big(\frac{1}{\phi_{1}(z', y', \epsilon, k)^{2}} - 1\Big) dz' \\ &= \int_{u(0)}^{u(1)} \frac{(\theta \circ u^{-1})(u)(u^{-1})'(u)}{(u - u(y') - i\epsilon)^{2}} du + \int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y') - i\epsilon)^{2}} \Big(\frac{1}{\phi_{1}(z', y', \epsilon, k)^{2}} - 1\Big) dz' \\ &= \frac{-(\theta \circ u^{-1})(u)(u^{-1})'(u)}{(u - u(y') - i\epsilon)} \Big|_{u(0)}^{u(1)} + \int_{u(0)}^{u(1)} \frac{((\theta \circ u^{-1})(u^{-1}))'(u)}{u - u(y') - i\epsilon} du \\ &+ \int_{0}^{1} \frac{\theta(z')}{(u(z') - u(y') - i\epsilon)^{2}} \Big(\frac{1}{\phi_{1}(z', y', \epsilon, k)^{2}} - 1\Big) dz' \\ &\to \frac{\theta(0)(u^{-1})'(u(0))}{(u(0) - u(y'))} - \frac{\theta(1)(u^{-1})'(u(1))}{(u(1) - u(y'))} \end{split}$$

$$-\mathcal{H}\left[\left((\theta \circ u^{-1})(u^{-1})'\right)'\chi_{[u(0),u(1)]}\right](u(y')) \pm i\pi\left((\theta \circ u^{-1})(u^{-1})\right)'(u(y')) \\ +\int_{0}^{1} \frac{\theta(z')}{(u(z')-u(y'))^{2}} \left(\frac{1}{\phi_{1}(z',y',k)^{2}}-1\right)dz' \quad \text{as} \quad \epsilon \to 0^{\pm},$$

where  $\mathcal{H}[f](u) = P.V. \int \frac{f(u')}{u-u'} du'$  is the Hilbert transform and  $\chi_{[u(0),u(1)]}(u) = \begin{cases} 1, & u \in [u(0), u(1)] \\ 0, & \text{else}, \end{cases}$  is the characteristic function. We also have for  $y' \in (0, 1)$ ,

Lemma 3.6. It holds that

$$\|\Pi_1[\hat{\tilde{\omega}}_{in}]\|_{L^2} \le C \|\hat{\tilde{\omega}}_{in}\|_{L^2},$$

where C > 0 is a constant independent of k.

*Proof.* By the  $L^2$  estimate of the Hilbert transform and the maximum function, we have

$$\left\| -\mathcal{H}\left[ (\theta \circ u^{-1}) \hat{\tilde{\omega}}_{in}(u^{-1}(\cdot), k) \left( (u^{-1})' \right)^2 \chi_{[u(0), u(1)]} \right] (u(y')) \right\|_{L^2} \leq C \|\hat{\tilde{\omega}}_{in}\|_{L^2},$$
$$\left\| -\frac{(\theta \circ u^{-1})(\tilde{u}) \int_{u(y')}^{\tilde{u}} \hat{\tilde{\omega}}_{in}(u^{-1}(\tilde{\tilde{u}}), k)(u^{-1})'(\tilde{\tilde{u}}) d\tilde{\tilde{u}}}{(\tilde{u} - u(y'))} (u^{-1})'(\tilde{\tilde{u}}) d\tilde{\tilde{u}}} (u^{-1})'(\tilde{u}) \right\|_{u(0)}^{u(1)} \right\|_{L^2} \leq C \|\hat{\tilde{\omega}}_{in}\|_{L^2},$$

and

$$\left\| \int_{u(0)}^{u(1)} \frac{\int_{u(y')}^{\tilde{u}} \hat{\omega}_{in}(u^{-1}(\tilde{\tilde{u}}),k)(u^{-1})'(\tilde{\tilde{u}})d\tilde{\tilde{u}}}{(\tilde{u}-u(y'))} \Big( (\theta \circ u^{-1})(\tilde{u})(u^{-1})' \Big)'(\tilde{u})d\tilde{u} \right\|_{L^{2}} \le C \|\hat{\tilde{\omega}}_{in}\|_{L^{2}}.$$

We write

$$\begin{split} &\int_{0}^{1} \int_{y'}^{z'} \frac{\theta(z')\hat{\tilde{\omega}}_{in}(z'',k)}{(u(z')-u(y'))^{2}} \Big(\frac{\phi_{1}(z'',y',k)}{\phi_{1}(z',y',k)^{2}} - 1\Big) dz''dz' \\ &= \int_{|u(z')-u(y')| \leq \frac{2}{|k|}} \int_{y'}^{z'} \frac{\theta(z')\hat{\tilde{\omega}}_{in}(z'',k)}{(u(z')-u(y'))^{2}} \Big(\frac{\phi_{1}(z'',y',k)}{\phi_{1}(z',y',k)^{2}} - 1)\Big) dz''dz' \\ &- \int_{|u(z')-u(y')| \geq \frac{2}{|k|}} \frac{\theta(z')\int_{y'}^{z'}\hat{\tilde{\omega}}_{in}(z'',k)dz''}{(u(z')-u(y'))^{2}} dz' \\ &+ \int_{|u(z')-u(y')| \geq \frac{2}{|k|}} \int_{y'}^{z'} \frac{\theta(z')\hat{\tilde{\omega}}_{in}(z'',k)}{(u(z')-u(y'))^{2}} \phi_{1}(z'',y',k)} dz''dz' \\ &= I_{1} + I_{2} + I_{3}. \end{split}$$

By Proposition 3.2, we have

$$\begin{aligned} \|I_1\|_{L^2} &\leq C \left\| \int_{|u(z') - u(y')| \leq \frac{2}{|k|}} \frac{|k|}{|y' - z'|} \int_{y'}^{z'} |\hat{\omega}_{in}(z'', k)| dz'' dz' \right\|_{L^2} \leq C \|\hat{\omega}_{in}\|_{L^2}, \\ \|I_3\|_{L^2} &\leq C \left\| \int_{|u(z') - u(y')| \geq \frac{2}{|k|}} \frac{|k|}{|y' - z'|} \int_{y'}^{z'} |\hat{\omega}_{in}(z'', k)| dz'' e^{-C^{-1}|k||y' - z'|} dz' \right\|_{L^2} \leq C \|\hat{\omega}_{in}\|_{L^2}. \end{aligned}$$

We have

$$\begin{split} I_{2} &= -\chi_{\{|u(y')-u(0)| \geq \frac{2}{|k|}\}}(u(y')) \int_{u(0)}^{u(y')-\frac{2}{|k|}} \frac{(\theta \circ u^{-1})(u)(u^{-1})'(u) \int_{u(y')}^{u} \hat{\omega}_{in}(u^{-1}(\tilde{u}),k)(u^{-1})'d\tilde{u}}{(u-u(y'))^{2}} du \\ &-\chi_{\{|u(y')-u(1)| \geq \frac{2}{|k|}\}}(u(y')) \int_{u(y')+\frac{2}{|k|}}^{u(1)} \frac{(\theta \circ u^{-1})(u)(u^{-1})'(u) \int_{u(y')}^{u} \hat{\omega}_{in}(u^{-1}(\tilde{u}),k)(u^{-1})'d\tilde{u}}{(u-u(y'))^{2}} du \\ &=\chi_{\{|u(y')-u(0)| \geq \frac{2}{|k|}\}}(u(y')) \frac{(\theta \circ u^{-1})(u)(u^{-1})'(u) \int_{u(y')}^{u} \hat{\omega}_{in}(u^{-1}(\tilde{u}),k)(u^{-1})'d\tilde{u}}{(u-u(y'))} \bigg|_{u(0)}^{u(y')-\frac{2}{|k|}} du \end{split}$$

$$\begin{split} &+ \chi_{\{|u(y')-u(1)| \geq \frac{2}{|k|}\}}(u(y')) \frac{(\theta \circ u^{-1})(u)(u^{-1})'(u) \int_{u(y')}^{u} \hat{\omega}_{in}(u^{-1}(\tilde{u}),k)(u^{-1})'d\tilde{u}}{(u-u(y'))} \Big|_{u(y')+\frac{2}{|k|}}^{u(1)} \\ &- \int_{|u-u(z')| \geq \frac{2}{|k|}} \frac{\left((\theta \circ u^{-1})(u)(u^{-1})'(u)\right)' \int_{u(y')}^{u} \hat{\omega}_{in}(u^{-1}(\tilde{u}),k)(u^{-1})'d\tilde{u}}{u-u(y')} du}{u-u(y')} du \\ &- \int_{|u-u(z')| \geq \frac{2}{|k|}} \frac{(\theta \circ u^{-1})(u)((u^{-1})'(u))^2 \hat{\omega}_{in}(u^{-1}(u),k)}{u-u(y')} du. \end{split}$$

By the  $L^2$  estimate of the maximal Hilbert transform, and the maximum function, we have

 $||I_2||_{L^2(0,1)} \le C ||\hat{\tilde{\omega}}_{in}||_{L^2}.$ 

Combining the above estimates, we prove the lemma.

We conclude the above calculations by the following proposition.

**Proposition 3.7.** It holds that  $\lim_{\epsilon \to 0^{\pm}} \Psi^{I}(y, y', \epsilon, k) = \Psi^{I}_{\pm}(y, y', k)$ . where

$$\Psi_{\pm}^{I}(y,y',k) = \begin{cases} -\phi(y,y',k) \int_{0}^{y} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k)\phi_{1}(z'',y',k)dz''}{(u(z')-u(y'))^{2}\phi_{1}(z',y',k)^{2}} dz' \\ + \frac{\rho(y')(\Pi_{1}[\hat{\omega}_{in}] \pm i\pi\Pi_{2}[\hat{\omega}_{in}])}{J_{1}(y',k) \pm i\pi J_{2}(y')} \phi(y,y',k) \int_{0}^{y} \frac{\theta(z')}{\phi(z',y',k)^{2}} dz', \quad for \quad y < y' \\ -\phi(y,y',k) \int_{1}^{y} \frac{\theta(z') \int_{y'}^{z'} \hat{\omega}_{in}(z'',k)\phi_{1}(z'',y',k)dz''}{(u(z')-u(y'))^{2}\phi_{1}(z',y',k)^{2}} dz' \\ + \frac{\rho(y')(\Pi_{1}[\hat{\omega}_{in}] \pm i\pi\Pi_{2}[\hat{\omega}_{in}])}{J_{1}(y',k) \pm i\pi J_{2}(y')} \phi(y,y',k) \int_{1}^{y} \frac{\theta(z')}{\phi(z',y',k)^{2}} dz' \quad for \quad y' < y. \end{cases}$$

We have the following uniform estimate.

**Proposition 3.8.** For any fixed  $k \in \mathbb{Z} \setminus \{0\}$ , suppose that  $\tilde{\mathcal{L}}_k$  has no eigenvalue or embedded eigenvalue. Then for all  $c \notin \operatorname{Ran} u$ , let  $\Psi^I$  solve (3.3) with boundary condition  $\Psi^I(0) = \Psi^I(1) = 0$ . Then it holds that

(3.18) 
$$\|\Psi^I\|_{H^1} \le C \|\hat{\tilde{\omega}}_{in}\|_{H^1},$$

where C is a constant independent of c.

*Proof.* It is easy to check that for  $c \in \{c : dist(c, Ran u) > M\}$  with M large enough, it holds that

$$\|\Psi^{I}\|_{H^{1}} \le C \|\hat{\tilde{\omega}}_{in}\|_{L^{2}}.$$

So we only focus on the case  $c \in \{c : \operatorname{dist}(c, \operatorname{Ran} u) \leq M\}$ . We prove the estimate (3.18) by a contradiction argument. Suppose (3.18) does not hold, namely, there is  $(c_n, \Psi_n^I, \hat{\omega}_{in,n})$  such that  $\{c_n\}_{n\geq 1} \subset \{c : 0 < \operatorname{dist}(c, \operatorname{Ran} u) \leq M\}$  and as  $n \to \infty$ ,  $\|\Psi_n^I\|_{H^1} = 1$ ,  $\|\hat{\omega}_n\|_{H^1} \to 0$  and

$$(u-c_n)\partial_y\left(\frac{1}{\theta}\partial_y\Psi_n^I\right) - (u-c_n)\frac{k^2}{\theta}\Psi_n^I - \left(\frac{u'}{\theta}\right)'\Psi_n^I = -\hat{\tilde{\omega}}_{in,n}.$$

Then there exists a subsequence also denoted by  $(c_n, \Psi_n^I, \hat{\tilde{\omega}}_{in,n})$ , so that

$$c_n \to c_\infty, \quad \Psi_n^I \rightharpoonup \Psi_\infty^I \quad \hat{\tilde{\omega}}_{in,n} \to 0 \quad \text{in} \quad H^1.$$

If  $c_{\infty} \notin \operatorname{Ran} u$ , then  $\|\Psi_n^l\|_{H^3} \leq C(\|\hat{\tilde{\omega}}_{in,n}\|_{H^1} + \|\Psi_n^l\|_{H^1})$ , thus  $\Psi_n^I \to \Psi_{\infty}^I$  and

$$(u - c_{\infty})\partial_y \left(\frac{1}{\theta}\partial_y \Psi_{\infty}^I\right) - (u - c_{\infty})\frac{\kappa^2}{\theta}\Psi_{\infty}^I - \left(\frac{u}{\theta}\right)'\Psi_{\infty}^I = 0$$

It implies that  $c_{\infty}$  is an eigenvalue that leads to a contradiction. If  $c_{\infty} = u(y_{\infty}) \in \operatorname{Ran} u$  (without loss of generality, we assume that  $\operatorname{Im} c_n > 0$ ), then we have

$$\partial_y \left(\frac{1}{\theta} \partial_y \Psi_n^I\right) = \frac{k^2}{\theta} \Psi_n^I + \frac{\left(\frac{u'}{\theta}\right)' \Psi_n^I - \hat{\tilde{\omega}}_{in,n}}{u - c_n} \\ = \frac{k^2}{\theta} \Psi_n^I + \partial_y \left(\frac{\left(\frac{u'}{\theta}\right)' \Psi_n^I - \hat{\tilde{\omega}}_{in,n}}{u'} \ln(u - c_n)\right) - \partial_y \left(\frac{\left(\frac{u'}{\theta}\right)' \Psi_n^I - \hat{\tilde{\omega}}_{in,n}}{u'}\right) \ln(u - c_n)$$

which gives that for 1

(3.19) 
$$\left\| \frac{1}{\theta} \partial_y \Psi_n^I - \frac{\left(\frac{u'}{\theta}\right)' \Psi_n^I - \hat{\tilde{\omega}}_{in,n}}{u'} \ln(u - c_n) \right\|_{L^2 \cap \dot{W}^{1,p}} \le C.$$

Therefore, we have for any  $\delta_0 > 0$ 

$$\|\partial_{y}\Psi_{n}^{I}\|_{L^{2}((y_{\infty}-\delta_{0},y_{\infty}+\delta_{0})\cap(0,1))} \leq C\delta_{0}^{\frac{1}{3}}$$

Here the constant C is independent of n. We also have

$$\Psi_n^I \to \Psi_\infty^I$$
 in  $H^1(0,1) \setminus (y_\infty - \delta_0, y_\infty + \delta_0).$ 

Thus we have

$$\Psi_n^I \to \Psi_\infty^I$$
 in  $H^1(0,1)$ .

For any  $\varphi \in H_0^1$ , we also have

$$\begin{split} 0 &= -\int_{0}^{1} \frac{\partial_{y} \Phi_{n}^{I}(y) \partial_{y} \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \frac{\Phi_{n}^{I}(y) \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \left(\frac{u'}{\theta}\right)'(y) \frac{\Phi_{n}^{I} \varphi}{u - c_{n}} dy + \int_{0}^{1} \frac{\hat{\omega}_{in,n} \varphi}{u - c_{n}} dy \\ &= -\int_{0}^{1} \frac{\partial_{y} \Phi_{n}^{I}(y) \partial_{y} \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \frac{\Phi_{n}^{I}(y) \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \left(\frac{u'}{\theta}\right)'(y) \frac{\Phi_{n}^{I} \varphi}{u'} \partial_{y} (\ln(u - c_{n})) dy \\ &+ \int_{0}^{1} \frac{\hat{\omega}_{in,n} \varphi}{u'} \partial_{y} (\ln(u - c_{n})) dy \\ &= -\int_{0}^{1} \frac{\partial_{y} \Phi_{n}^{I}(y) \partial_{y} \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \frac{\Phi_{n}^{I}(y) \varphi(y)}{\theta(y)} dy + \int_{0}^{1} \partial_{y} \left( \left(\frac{u'}{\theta}\right)'(y) \frac{\Phi_{n}^{I} \varphi}{u'} \right) \ln(u - c_{n}) dy \\ &- \left(\frac{u'}{\theta}\right)'(y) \frac{\Phi_{n}^{I} \varphi}{u'} \ln(u(y) - c_{n}) \Big|_{0}^{1} + \frac{\hat{\omega}_{in,n} \varphi}{u'} \ln(u(y) - c_{n}) \Big|_{0}^{1} \\ &- \int_{0}^{1} \frac{\partial_{y} \Phi_{n}^{I}(y) \partial_{y} \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \frac{\Phi_{n}^{I}(y) \varphi(y)}{\theta(y)} dy + \int_{0}^{1} \partial_{y} \left( \left(\frac{u'}{\theta}\right)'(y) \frac{\Phi_{n}^{I} \varphi}{u'} \right) \ln(u - c_{n}) dy \\ &- \int_{0}^{1} \frac{\partial_{y} \Phi_{n}^{I}(y) \partial_{y} \varphi(y)}{\theta(y)} dy - \int_{0}^{1} \frac{\Phi_{n}^{I}(y) \varphi(y)}{\theta(y)} dy + \int_{0}^{1} \partial_{y} \left( \left(\frac{u'}{\theta}\right)'(y) \frac{\Phi_{n}^{I} \varphi}{u'} \right) \ln(u - c_{n}) dy \\ &- i\pi \left(\frac{u'}{\theta}\right)'(y_{\infty}) \frac{\Phi_{n}^{I}(y_{\infty}) \varphi(y_{\infty})}{u'(y_{\infty})}. \end{split}$$

By taking  $\varphi(y) = \overline{\Phi_{\infty}^{I}(y)}$ , we have  $\left(\frac{u'}{\theta}\right)'(y_{\infty})|\Phi_{\infty}^{I}(y_{\infty})|^{2} = 0$ . Thus we have  $\Phi_{\infty}^{I} \in H^{2} \cap H_{0}^{1}$  and  $c_{\infty}$  is an embedded eigenvalue, which leads to a contradiction.

3.4. Linear damping, representation formula, and the wave operator. In this section, we prove the weak linear inviscid damping and introduce the representation formula and the wave operator which will be used in the nonlinear problem.

**Lemma 3.9.** Let  $\psi$  be the velocity solving the linearized equation (2.21). Then it holds that

$$\|(\partial_y \hat{\psi}, \hat{\psi})\|_{H^1_t L^2_y} \le C \|\hat{\omega}_{in}\|_{H^1_y},$$

which implies  $\lim_{t\to\infty} \|(\partial_y \hat{\psi}, \hat{\psi})\|_{L^2_y} = 0.$ 

*Proof.* We have by (3.2), Proposition 3.8 , and Proposition 3.7 that

$$\hat{\psi}(t,k,y) = \frac{1}{2\pi i} \int_0^1 e^{-iu(y')kt} (\Psi_-^I(y,y',k) - \Psi_+^I(y,y',k))u'(y')dy'$$
$$\partial_t \hat{\psi}(t,k,y) = \frac{1}{2\pi i} \int_0^1 (-iu(y')k)e^{-iu(y')kt} (\Psi_-^I(y,y',k) - \Psi_+^I(y,y',k))u'(y')dy'$$

and

$$\|\Psi^{I}_{\pm}(y,y',k)\|_{L^{\infty}_{y'}H^{1}_{y}} \leq C \|\hat{\tilde{\omega}}_{in}\|_{H^{1}_{x,y}}.$$

Therefore by Plancherel's formula, we infer that

$$\begin{split} \|(\partial_{y}\hat{\psi},\hat{\psi})\|_{H^{1}_{t}L^{2}_{y}}^{2} &= \int_{\mathbb{R}} \left( \|(\partial_{y}\hat{\psi},\hat{\psi})\|_{L^{2}_{y}}^{2} + \|\partial_{t}(\partial_{y}\hat{\psi},\hat{\psi})\|_{L^{2}_{y}}^{2} \right) dt \\ &\lesssim \int_{0}^{1} \int_{\mathbb{R}} \left( |\hat{\psi}(t,k,y)|^{2} + |\partial_{y}\hat{\psi}(t,k,\cdot)|^{2} + k^{2}|\partial_{t}\hat{\psi}(t,k,y)|^{2} + |\partial_{t}\partial_{y}\hat{\psi}(t,k,y)|^{2} \right) dt dy \\ &\lesssim \int_{0}^{1} \int_{\operatorname{Ran} u} \left( k^{2} |\Psi_{\pm}^{I}(y,y',k)|^{2} + |\partial_{y}\Psi_{\pm}^{I}(y,y',k)|^{2} \right) dc dy \\ &\leq C \int_{\operatorname{Ran} u} \|\hat{\omega}_{in}(k,\cdot)\|_{H^{1}_{y}}^{2} dc \lesssim C \|\hat{\omega}_{in}(k,\cdot)\|_{H^{1}_{y}}^{2}. \end{split}$$

The lemma follows directly from the Sobolev embedding.

In order to obtain the point-wise linear inviscid damping, one may need to study the regularity of  $\Psi^{I}_{\pm}(y, y', k)$  in y'. We may not discuss it here.

We now introduce the representation formula.

**Proposition 3.10.** Let  $\psi$  be the velocity solving the linearized equation (2.21). Then it holds that

$$\hat{\psi}(t,k,y) = -\int_0^1 e^{-iu(y')kt} \frac{J_1(y',k)\Pi_2[\hat{\tilde{\omega}}_{in}](y') - J_2(y')\Pi_1[\hat{\tilde{\omega}}_{in}](y',k)}{J_1(y',k)^2 + \pi^2 J_2(y')^2} \rho(y')u'(y')e(y,y',k)dy'$$

where

(3.20) 
$$e(y,y',k) = \begin{cases} \phi(y,y',k) \int_0^y \frac{\theta(z)}{\phi(z,y',k)^2} dz & 0 \le y < y', \\ \phi(y,y',k) \int_1^y \frac{\theta(z)}{\phi(z,y',k)^2} dz & y' < y \le 1. \end{cases}$$

*Proof.* The proposition follows directly from (3.2), Proposition 3.8, and Proposition 3.7 with a simple calculation.  $\Box$ 

The representation formula in Proposition 3.10 leads to the wave operator. By taking t = 0, we have the following representation formula:

(3.21) 
$$\hat{\psi}_{in}(k,y) = -\int_0^1 \mathbb{D}_{u,k} \left[ \tilde{\Delta}_k \hat{\psi}_{in} \right] (y',k) \frac{\frac{\theta(y')}{u'(y')} \rho(y') e(y,y',k)}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} dy',$$

where

(3.22)  
$$\mathbb{D}_{u,k}\left[\tilde{\omega}\right](y',k) \stackrel{\text{def}}{=} \frac{u'(y')}{\theta(y')} \frac{u'(y')J_1(y',k)\Pi_2[\tilde{\omega}](y') - u'(y')J_2(y')\Pi_1[\tilde{\omega}](y',k)}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} \\= \frac{J_1(y',k)\tilde{\omega}(y') + \rho(y')\frac{\theta(y')}{u(y')}\left(\frac{u'}{\theta}\right)'(y')\Pi_1[\tilde{\omega}](y',k)}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}}.$$

### 4. WAVE OPERATOR

In this section, we give the basic properties of the wave operator and study its Fourier kernel.

**Proposition 4.1.** For  $k \neq 0$ , let  $\mathcal{R}_{u,k} = u \operatorname{Id} - \left(\frac{u'}{\theta}\right)' \tilde{\Delta}_k^{-1}$ . Suppose that for all  $k \neq 0$ ,  $\mathcal{R}_{u,k}$  has no eigenvalue and no embedded eigenvalue. Let  $\mathbb{D}_{u,k}$  be defined in (3.22). Then there exists  $\mathbb{D}_{u,k}^1$  such that

$$(4.1) \qquad \qquad \mathbb{D}_{u,k}\mathcal{R}_{u,k} = u\mathbb{D}_{u,k},$$

and for  $\omega, g \in L^2(0,1)$ 

(4.2) 
$$\int_0^1 \mathbb{D}_{u,k}(\omega)(y)\mathbb{D}_{u,k}^1(g)(y)dy = \int_0^1 \omega(y)g(y)dy.$$

Moreover, there exists C > 1 independent of k such that

(4.3) 
$$C^{-1} \le \|\mathbb{D}_{u,k}\|_{L^2 \to L^2} \le C, \quad C^{-1} \le \|\mathbb{D}^1_{u,k}\|_{L^2 \to L^2} \le C.$$

Note that (4.3) implies that the wave operator  $\mathbb{D}_{u,k}$  is invertible and

(4.4) 
$$\mathbb{D}^1_{u,k} = (\mathbb{D}^{-1}_{u,k})^*.$$

We give the representation formula of  $\mathbb{D}_{u,k}^{-1}$  in (4.12).

Proof. **Proof of** (4.1). Let  $\psi = \tilde{\Delta}_k^{-1} \omega$ , namely  $\partial_y \left(\frac{1}{\theta} \partial_y \psi\right) - \frac{k^2}{\theta} \psi = \omega$  and  $\psi(0) = \psi(1) = 0$ . Then  $\mathcal{R}_{u,k}[\omega](y') = u(y')\omega(y') - \left(\frac{u'}{\theta}\right)' \psi(y')$ . A direct calculation gives

$$\begin{split} \mathbb{D}_{u,k} \left[ \mathcal{R}_{u,k}[\omega] \right] (y',k) \\ &= \frac{u'(y')}{\theta(y')} \frac{u'(y')J_1(y',k)\Pi_2[\mathcal{R}_{u,k}[\omega]](y') - u'(y')J_2(y')\Pi_1[\mathcal{R}_{u,k}[\omega]](y',k)}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} \\ &= u(y') \frac{u'(y')J_1(y',k)\Pi_2[\omega]}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} \frac{u'(y')}{\theta(y')} - \frac{J_1(y',k)\frac{\theta(y')}{u'(y')} \left(\frac{u'}{\theta}\right)'\psi(y')}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} \frac{u'(y')}{\theta(y')} \\ &- \frac{u'(y')}{\theta(y')} \frac{u'(y')J_2(y')P.V. \int_0^1 \frac{\theta(z')\int_{y'}^{z'} \left(u(z'')\omega(z'') - \left(\frac{u'}{\theta}\right)'\psi(z'')\right)\phi_1(z'',y',k)dz''}{(u(z') - u(y'))^2\phi_1(z',y',k)^2} dz'} \\ \end{split}$$

Let us now simplify the second term. Recall that  $\phi(y, y', k) = (u(y) - u(y'))\phi_1(y, y', k)$  solves

$$\partial_y \left(\frac{1}{\theta} \partial_y \phi\right) - \frac{k^2}{\theta} \phi = \left(\frac{u'}{\theta}\right)' \phi_1.$$

Then by using the integration by part, we have

$$\begin{split} P.V. & \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \left( u(z'')\omega(z'') - \left(\frac{u'}{\theta}\right)' \psi(z'') \right) \phi_{1}(z'', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &= P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} u(z'')\omega(z'')\phi_{1}(z', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &- P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \psi(z'') \left(\frac{\partial y}{|\theta|} \left(\frac{1}{\theta} \partial y \phi(z'', y', k)\right) - \frac{k^{2}}{\theta} \phi(z'', y', k)\right) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &= P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} u(z'')\omega(z'')\phi_{1}(z', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' + P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \phi(z'', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &+ P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \partial_{y} \psi(z'') \left(\frac{1}{\theta} \partial_{y} \phi(z'', y', k)\right) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &- P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} u(z'')\omega(z'') \phi_{1}(z', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &= P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} u(z'')\omega(z'') \phi_{1}(z', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &- P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} u(z'')\omega(z'') \phi_{1}(z', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' - P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \omega(z'') \phi(z'', y, k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' \\ &+ P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} u(z'') (\psi(z'') \phi_{1}(z', y', k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' - P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \omega(z'') \phi(z'', y, k) dz''}{(u(z') - u(y'))^{2} \phi_{1}(z', y', k)^{2}} dz' - P.V. \int_{0}^{1} \frac{\theta(z') \int_{y'}^{z'} \omega(z'') \phi(z'', y, k)^{2}}{(u(z') - u(y')) \phi_{1}(z', y', k)} dz' - \int_{0}^{1} \frac{\psi(z') \partial_{y} \phi_{1}(z', y', k)}{(u(z') - u(y')) \phi_{1}(z', y', k)^{2}} dz' \\ &- P.V. \int_{0}^{1} \frac{\theta(z') \psi(z') \phi_{1}(z', y', k) - \theta(z') \psi(y') (\frac{\psi(y')}{\theta(y')}}{(u(z') - u(y')) \phi_{1}(z', y', k)^{2}} dz' \\ &= u(y') \Pi_{1}[\omega] + I_{1}[\psi] + I_{2}[\psi] + I_{3}[\psi]. \end{split}$$

We write

$$\begin{split} I_1 &= \int_0^1 \frac{\partial_y \psi(z')}{(u(z') - u(y'))} \Big( \frac{1}{\phi_1(z', y', k)} - 1 \Big) dz' + P.V. \int_0^1 \frac{\partial_y \psi(z')}{(u(z') - u(y'))} dz' \\ I_2 &= \int_0^1 \frac{\psi(z')}{(u(z') - u(y'))} \partial_y \Big( \frac{1}{\phi_1(z', y', k)} - 1 \Big) dz' \\ I_3 &= \int_0^1 \psi(z') \partial_y \Big( \frac{1}{(u(z') - u(y'))} \Big) \Big( \frac{1}{\phi_1(z', y', k)} - 1 \Big) dz' \\ &- P.V. \int_0^1 \frac{u'(z')\psi(z') - \theta(z')\psi(y') \left( \frac{u'(y')}{\theta(y')} \right)}{(u(z') - u(y'))^2} dz' \\ &+ \psi(y') \frac{u'(y')}{\theta(y')} \int_0^1 \frac{\theta(z')}{(u(z') - u(y'))^2} \Big( \frac{1}{\phi_1(z', y', k)^2} - 1 \Big) dz'. \end{split}$$

Therefore, we obtain that

$$(4.5) I_1 + I_2 + I_3 = P.V. \int_0^1 \frac{\partial_y \psi(z')}{(u(z') - u(y'))} dz' + P.V. \int_0^1 \partial_y \Big( \frac{1}{u(z') - u(y')} \Big) \Big( \psi(z') - \frac{\theta(z')}{u'(z')} \psi(y') \left( \frac{u'(y')}{\theta(y')} \right) \Big) dz' + \psi(y') \frac{u'(y')}{\theta(y')} \int_0^1 \frac{\theta(z')}{(u(z') - u(y'))^2} \Big( \frac{1}{\phi_1(z', y', k)^2} - 1 \Big) dz' = \psi(y') \frac{u'(y')}{\theta(y')} P.V. \int_0^1 \frac{1}{u(z') - u(y')} \Big( \frac{\theta(z')}{u'(z)} \Big)' dz' - \frac{\frac{\theta(1)}{u'(1)} \psi(y') \left( \frac{u'(y')}{\theta(y')} \right)}{u(1) - u(y')} + \frac{\frac{\theta(0)}{u'(0)} \psi(y') \left( \frac{u'(y')}{\theta(y')} \right)}{u(0) - u(y')} + \psi(y') \frac{u'(y')}{\theta(y')} \int_0^1 \frac{\theta(z')}{(u(z') - u(y'))^2} \Big( \frac{1}{\phi_1(z', y', k)^2} - 1 \Big) dz' = \psi(y') \frac{u'(y')}{\theta(y')\rho(y')} J_1(y', k),$$

which gives that

$$P.V. \int_0^1 \frac{\theta(z') \int_{y'}^{z'} \left( u(z'')\omega(z'') - \left(\frac{u'}{\theta}\right)' \psi(z'') \right) \phi_1(z'', y', k) dz''}{(u(z') - u(y'))^2 \phi_1(z', y', k)^2} dz'$$
  
=  $u(y') \Pi_1[\omega] + \psi(y') \frac{u'(y')}{\theta(y')\rho(y')} J_1(y', k).$ 

Then we can conclude that

$$\mathbb{D}_{u,k} \left[ \mathcal{R}_{u,k}[\omega] \right](y',k) \\ = u(y') \frac{u'(y')}{\theta(y')} \frac{u'(y')J_1(y',k)\Pi_2[\omega]}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} - u(y') \frac{u'(y')}{\theta(y')} \frac{u'(y')J_2(y')\Pi_1[\omega]}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}} = u(y')\mathbb{D}_{u,k}[\omega].$$

**Proof of** (4.2). Let  $g \in H^2(0,1) \cap H^1_0(0,1)$  and  $\psi = \tilde{\Delta}_k^{-1}\omega$ , namely  $\partial_y \left(\frac{1}{\theta}\partial_y\psi\right) - \frac{k^2}{\theta}\psi = \omega$  and  $\psi(0) = \psi(1) = 0$ . Then

$$\int_0^1 \omega(y)g(y)dy = \int_0^1 \psi(y)\tilde{\Delta}_k g(y)dy.$$

By the representation formula (3.21), we have

$$\begin{split} \int_{0}^{1} \psi(y) \tilde{\Delta}_{k}[g] dy &= -\int_{0}^{1} \int_{0}^{1} \mathbb{D}_{u,k}\left[\omega\right](y',k) \frac{\frac{\theta(y')}{u'(y')} \rho(y') e(y,y',k)}{\sqrt{J_{1}(y',k)^{2} + \pi^{2}J_{2}(y')^{2}}} dy' \tilde{\Delta}_{k}g(y) dy \\ &= -\int_{0}^{1} \int_{0}^{y} \mathbb{D}_{u,k}\left[\omega\right](y',k) \frac{\theta(y')}{u'(y')} \frac{\rho(y')\phi(y,y',k) \int_{1}^{y} \frac{\theta(z)}{\phi(z,y',k)^{2}} dz}{\sqrt{J_{1}(y',k)^{2} + \pi^{2}J_{2}(y')^{2}}} dy' \tilde{\Delta}_{k}g(y) dy \\ &- \int_{0}^{1} \int_{y}^{1} \mathbb{D}_{u,k}\left[\omega\right](y',k) \frac{\theta(y')}{u'(y')} \frac{\rho(y')\phi(y,y',k) \int_{0}^{y} \frac{\theta(z)}{\phi(z,y',k)^{2}} dz}{\sqrt{J_{1}(y',k)^{2} + \pi^{2}J_{2}(y')^{2}}} dy' \tilde{\Delta}_{k}g(y) dy \end{split}$$

$$= \int_{0}^{1} \frac{\mathbb{D}_{u,k}\left[\omega\right](y',k)\rho(y')}{\sqrt{J_{1}(y',k)^{2} + \pi^{2}J_{2}(y')^{2}}} \frac{\theta(y')}{u'(y')} \int_{y'}^{1} \frac{\theta(z)\int_{y'}^{z}\phi(y,y',k)\Delta_{k}g(y)dy}{\phi(z,y',k)^{2}} dzdy'$$
  
$$- \int_{0}^{1} \frac{\mathbb{D}_{u,k}\left[\omega\right](y',k)\rho(y')}{\sqrt{J_{1}(y',k)^{2} + \pi^{2}J_{2}(y')^{2}}} \frac{\theta(y')}{u'(y')} \int_{0}^{y'} \frac{\theta(z)\int_{z'}^{y'}\phi(y,y',k)\tilde{\Delta}_{k}g(y)dy}{\phi(z,y',k)^{2}} dzdy'$$
  
$$= \int_{0}^{1} \frac{\mathbb{D}_{u,k}\left[\omega\right](y',k)\rho(y')}{\sqrt{J_{1}(y',k)^{2} + \pi^{2}J_{2}(y')^{2}}} \frac{\theta(y')}{u'(y')} \int_{0}^{1} \frac{\theta(z)\int_{y'}^{z}\phi(y,y',k)\tilde{\Delta}_{k}g(y)dy}{\phi(z,y',k)^{2}} dzdy'.$$

We now simplify the integral by using integration by parts

$$\begin{split} &\int_{0}^{1} \frac{\theta(z) \int_{y'}^{z} \phi(z'',y',k) \Delta_{k}g(z'')dy}{\phi(z,y',k)^{2}} dz \\ &= \int_{0}^{1} \frac{\theta(z) \int_{y'}^{z} \tilde{\Delta}_{k} \phi(z'',y',k)g(z'')dy}{\phi(z,y',k)^{2}} dz + P.V. \int_{0}^{1} \frac{\partial_{y}g(z)}{(u(z)-u(y'))\phi_{1}(z,y',k)} dz \\ &- \int_{0}^{1} \frac{\partial_{y}\phi_{1}(z,y',k)g(z)}{(u(z)-u(y'))\phi_{1}(z,y',k)^{2}} dz - \int_{0}^{1} \frac{u'(z)\phi_{1}(z,y',k)g(z) - \theta(z)\frac{1}{\theta(y')}u'(y')g(y')}{\phi(z,y',k)^{2}} dz \\ &= P.V. \int_{0}^{1} \frac{\theta(z) \int_{y'}^{z} \left(\frac{u'}{\theta}\right)' \phi_{1}(z'',y',k)g(z'')dy}{\phi(z,y',k)^{2}} dz + I_{1}[g] + I_{2}[g] + I_{3}[g], \end{split}$$

where  $I_1, I_2, I_3$  are defined in the previous step. Thus by (4.5), we get

$$\int_{0}^{1} \frac{\theta(z) \int_{y'}^{z} \phi(z'', y', k) \tilde{\Delta}_{k} g(z'') dy}{\phi(z, y', k)^{2}} dz = \Pi_{1} \left[ \left( \frac{u'}{\theta} \right)' g \right] + \frac{u'(y')}{\theta(y') \rho(y')} J_{1}(y', k) g(y').$$

We define

(4.6) 
$$\mathbb{D}_{u,k}^{1}[g] = \frac{\frac{\theta(y')}{u'(y')}\rho(y')\Pi_1\left[\left(\frac{u'}{\theta}\right)'g\right] + J_1(y',k)g(y')}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}},$$

and then we obtain (4.2) for  $g \in H^2(0,1) \cap H^1_0(0,1)$ . By Lemma 3.5 and Lemma 3.6, it is easy to obtain for any  $\omega \in L^2(0,1)$  and  $k \neq 0$ ,

(4.7) 
$$\|\mathbb{D}_{u,k}[\omega]\|_{L^2} + \|\mathbb{D}_{u,k}^1[\omega]\|_{L^2} \le C \|\omega\|_{L^2}.$$

Here C > 0 is a constant independent of k.

Due to the fact that  $H^2 \cap H^1_0$  is dense in  $L^2$ , for any  $g \in L^2$ , there is a sequence  $\{g_n\}_{n \ge 1}$  such that  $H^2 \cap H^1_0 \ni g_n \to g$  in  $L^2$  and

$$\int_0^1 \mathbb{D}_{u,k}(\omega)(y')\mathbb{D}_{u,k}^1(g_n)(y')dy' = \int_0^1 \omega(y)g_n(y)dy.$$

Then

$$\begin{split} & \left| \int_{0}^{1} \mathbb{D}_{u,k}(\omega)(y_{c}) \mathbb{D}_{u,k}^{1}(g)(y') dy' - \int_{0}^{1} \omega(k,y) g(k,y) dy \right| \\ & = \left| \int_{0}^{1} \mathbb{D}_{u,k}(\omega)(y') \mathbb{D}_{u,k}^{1}(g_{n})(y') dy' - \int_{0}^{1} \omega(k,y) (g(y) - g_{n}(y)) dy \right| \\ & \leq C \|\mathbb{D}_{u,k}(\omega)\|_{L^{2}} \|\mathbb{D}_{u,k}^{1}(g - g_{n})\|_{L^{2}} + \|\omega\|_{L^{2}} \|g - g_{n}\|_{L^{2}} \to 0. \end{split}$$

~

Thus we proved (4.2). The lower bound of  $\mathbb{D}_{u,k}$  and  $\mathbb{D}_{u,k}^1$  in (4.3) follow directly from a duality argument, and the upper bound (4.7). Thus we proved the proposition. 

**Remark 4.2.** For any bounded function  $C^{-1} < p(y') < C$ , the operators  $p(y')\mathbb{D}_{u,k}$  and  $\frac{1}{p(y')}\mathbb{D}_{u,k}^{1}$ also satisfy the same properties in Proposition (4.1). The wave operator  $\mathbb{D}_{u,k}$  is normalized so that if  $\left(\frac{u'}{\theta}\right)' = 0$ , then  $\mathbb{D}_{u,k} = \mathbb{D}_{u,k}^{1} = \mathrm{Id}$ . Moreover, it is easy to check that

which is a commutator.

4.1. Wave operator in (t, z, v) coordinates. Recall that we construct the wave operator in  $(t, \tilde{x}, \tilde{y})$  coordinates (we drop tildes and still use (t, x, y) in the above calculations for convenience), which is from the nonlinear change of coordinates and then the linear inverse change of coordinates. We show the relationship between different coordinate systems in the following map.

$$\underbrace{(t, x, y)}_{\text{original system}} \xrightarrow{\text{nonlinear change of coordinates}} \underbrace{(t, z, v)}_{\text{working object}} \xrightarrow{\text{inverse linear change of coordinates}}_{\text{linear change of coordinates}} \underbrace{(t, \tilde{x}, \tilde{y})}_{\text{wave operator}}.$$

In this section, we give the representation formula of the wave operator in (t, z, v) coordinates. Let us first rewrite  $\mathbb{D}_{u,k}$  and  $\mathbb{D}_{u,k}^1$  in different forms. We first define

$$b_1(y',k) = \frac{J_1(y',k)}{\sqrt{J_1(y',k)^2 + \pi^2 J_2(y')^2}}$$

Recall that  $\varphi_1(y) = \left(\frac{u'}{\theta}\right)'(y)$  defined in (2.12) and e(z, y', k) defined in (3.20). A direct calculation gives that

Let us now introduce the following operators associated with  $\mathbb{D}_{u,k}$ ,  $\mathbb{D}_{u,k}^{-1}$ , and  $\mathbb{D}_{u,k}^{1}$ . For any Schwartz function f(t, z, v) defined on  $\mathbb{R} \times \mathbb{T} \times \operatorname{Ran} u$ , we define

$$\mathbf{D}_{u,k} (\mathcal{F}_1 f(t, k, \cdot))(t, k, v) \stackrel{\text{def}}{=} B_1(v, k) \mathcal{F}_1 f(t, k, v) + \widetilde{\varphi_1}(v) B_2(v, k) \int_{u(0)}^{u(1)} E(k, v_1, v) \frac{\mathcal{F}_1 f(t, k, v_1) e^{-i(v_1 - v)tk}}{v_1 - v} (u^{-1})'(v_1) dv_1, (4.15) \qquad \mathbf{D}_{u,k}^{-1} (\mathcal{F}_1 f(t, k, \cdot))(t, k, v)$$

$$\stackrel{\text{def}}{=} B_1(v,k)\mathcal{F}_1f(t,k,v) + \widetilde{\varphi_1}(v) \int_{u(0)}^{u(1)} E(k,v,v_1)B_2(k,v_1) \frac{\mathcal{F}_1f(t,k,v_1)e^{i(v_1-v)tk}}{v-v_1} (u^{-1})'(v_1)dv_1$$

and

(4.16) 
$$\mathbf{D}_{u,k}^{1} \left( \mathcal{F}_{1}f(t,k,\cdot) \right)(t,k,v) \\ \stackrel{\text{def}}{=} B_{1}(v,k)\mathcal{F}_{1}f(t,k,v) \\ + B_{2}(v,k) \int_{u(0)}^{u(1)} E(k,v_{1},v) \frac{\widetilde{\varphi_{1}}(v_{1})\mathcal{F}_{1}f(t,k,v_{1})e^{-i(v_{1}-v)tk}}{v_{1}-v} (u^{-1})'(v)dv_{1}.$$

With these definitions, we have the following proposition.

**Proposition 4.3.** For  $k \neq 0$ , let  $\tilde{\Delta}_{t,k}^{l} = -k^{2}\widetilde{\varphi_{4}} + \widetilde{u'}(\partial_{v} - itk) \left(\widetilde{\varphi_{4}}\widetilde{u'}(\partial_{v} - itk)\right)$  and  $\mathbf{R}_{u,k} = v \mathrm{Id} - \widetilde{\varphi_{1}}(v) \left(\tilde{\Delta}_{t,k}^{l}\right)^{-1}$ 

be a modified Rayleigh operator. Then it holds for any f(t, z, v) and g(t, z, v) that

$$[\partial_t, \mathbf{D}_{u,k}] \big( \mathcal{F}_1 f(t,k,\cdot) \big)(t,k,v) = [ikv, \mathbf{D}_{u,k}] \big( \mathcal{F}_1 f(t,k,\cdot) \big)(t,k,v)$$

(4.20) 
$$\int \mathbf{D}_{u,k} (\mathcal{F}_1 f(t,k,\cdot))(t,k,v) \overline{\mathbf{D}_{u,k}^1 (\mathcal{F}_1 g(t,k,\cdot))(t,k,v)} dv = \int \mathcal{F}_1 f(k,u) \overline{\mathcal{F}_1 g(k,v)} dv,$$
  
(4.21) 
$$C^{-1} \le \|\mathbf{D}_{u,k}\|_{L^2 \to L^2} \le C, \quad C^{-1} \le \|\mathbf{D}_{u,k}^1\|_{L^2 \to L^2} \le C, \quad C^{-1} \le \|\mathbf{D}_{u,k}^{-1}\|_{L^2 \to L^2} \le C.$$

Let 
$$\Omega(t, z, v)$$
 be defined in (2.14). Then applying the inverse linear change of coordinate (2.20), we get that

$$\begin{aligned} \mathbf{D}_{u,k} \big( \mathcal{F}_1 \Omega(t,k,\cdot) \big)(t,k,v) e^{ikz} \bigg|_{z=x-u(y)t, \ v=u(y)} &= \mathbf{D}_{u,k} \big( \mathcal{F}_1 \Omega(t,k,\cdot) \big)(t,k,u(y)) e^{ik(x-tu(y))} \\ &= \mathbb{D}_{u,k} \big( \mathcal{F}_1 w(t,k,\cdot) \big)(t,k,y) e^{ikx}, \end{aligned}$$

where  $w(t, x, y) = \Omega(t, x - u(y)t, u(y))$  is different from  $\tilde{\omega}(t, x, y)$  in the original coordinate system. **Remark 4.4.** We have changed  $\mathbb{D}^1_{u,k}$  in the (z, v) coordinate slightly to ensure that (4.20) holds.

**Remark 4.4.** We have changed  $\mathbb{D}_{u,k}^{*}$  in the (z, v) coordinate slightly to ensure that (4.20) holds Let  $\Omega(t, z, v)$  be defined in (2.14). It holds that

where  $w(t, x, y) = \Omega(t, x - u(y)t, u(y))$ .

The proposition follows directly from Proposition 4.1 and the representation formulas (4.11) and (4.12) by a simple change of coordinates.

**Remark 4.5.** By the compact support property of  $b_2$ . It is easy to check  $\mathbf{D}_{u,k}(\mathcal{F}_1\Omega)$  has the same compact support as  $\Omega$ .

4.2. Gevrey regularity of the homogeneous solution. To obtain the Fourier kernels of  $\mathbf{D}_{u,k}$ ,  $\mathbf{D}_{u,k}^{-1}$ , and  $\mathbf{D}_{u,k}^{1}$ , we need to study the regularity of the coefficients  $B_1(v,k)$ ,  $B_2(v,k)$  and the kernel E(v, v', k). Indeed, all these functions are related to the homogeneous solution  $\phi_1(y, y', k)$  obtained in Proposition 3.2.

Let us define  $\Phi(v, v', k)$  and  $\Phi_1(v, v', k)$  to be such that

$$\Phi(u(y), u(y'), k) = \phi(y, y', k), \quad \Phi_1(u(y), u(y'), k) = \phi_1(y, y', k).$$

By Proposition 3.2 and (3.5), we have

$$\Phi(v, v', k) = (v - v')\Phi_1(v, v', k),$$

For any  $k \neq 0$ , let  $M \geq 1$  be a large constant, then we define the following weighted Gevrey spaces:

$$\|f\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s}([a,b]^2)} \stackrel{\text{def}}{=} \sup_{(v,v')\in[a,b]^2,\,m\geq m_1\geq 0} \frac{|\partial_v^{m-m_1}(\partial_{v'}+\partial_v)^{m_1}f(v,v')|}{\Gamma_s(m)M^m|k|^m\cosh M|k|(v-v')},$$

where  $\Gamma_s(m) = (m!)^{\frac{1}{s}}(m+1)^{-2}$ .

Lemma 4.6. It holds that

$$\sup_{(v,v')\in[a,b]^2,\,m\geq m_1\geq 0}\frac{|\partial_v^{m-m_1}\partial_{v'}^{m_1}f(v,v')|}{\Gamma_s(m)2^{m_1}M^m|k|^m\cosh M|k|(v-v')}\leq \|f\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s}([a,b]^2)}.$$

$$\leq \sup_{m_1 \geq 0} 2^{-m_1} \sum_{m_2=0}^{m_1} \frac{m_1!}{m_2!(m_1 - m_2)!} \|f\|_{\mathcal{G}_{ph, \cosh}^{M|k|, s}([a, b]^2)} \leq \|f\|_{\mathcal{G}_{ph, \cosh}^{M|k|, s}([a, b]^2)}.$$

Thus we proved the remark.

Remark 4.7. It holds that

$$\|fg\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s}([a,b]^2)} \le C \|f\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s}([a,b]^2)} \|g\|_{\mathcal{G}_{ph,1}^{M|k|,s}([a,b]^2)}.$$

where the norm  $\|\cdot\|_{\mathcal{G}^{M|k|,s}_{ph,1}([a,b]^2)}$  is defined in (A.7).

**Proposition 4.8.** Suppose  $(u^{-1})'', \tilde{\theta} \in \mathcal{G}_{ph,1}^{K_u,s_0}([u(0), u(1)])$ , then there exists  $M_0 = M_0(K_u) \ge 1$ , such that for any  $M \ge M_0$ , it holds that

$$\|\mathbf{T}_0 \circ \mathbf{T}_{2,2}\|_{\mathcal{G}_{ph, \cosh}^{M|k|, s_0}([u(0), u(1)]^2) \to \mathcal{G}_{ph, \cosh}^{M|k|, s_0}([u(0), u(1)]^2)} \le \frac{C}{M^2 k^2}.$$

$$\begin{split} \left\| \frac{\partial_{v}^{m_{1}}(\partial_{v} + \partial_{v'})^{m-m_{1}} \left( \frac{1}{(v-v')^{j+1}} \int_{v'}^{u} (u'-v')^{j} f(u',v') du' \right)}{\cosh M|k|(v-v')} \right\|_{L^{\infty}[u(0),u(1)]^{2}} \\ &\leq \frac{\int_{0}^{1} t^{j} t^{m_{1}} \cosh t M|k|(v-v') dt}{\cosh M|k|(v-v')} \left\| \frac{\partial_{v}^{m_{1}}(\partial_{v} + \partial_{v'})^{m-m_{1}} f}{\cosh M|k|(v-v')} \right\|_{L^{\infty}[u(0),u(1)]^{2}} \\ &\leq C \left\| \frac{\partial_{v}^{m_{1}}(\partial_{v} + \partial_{v'})^{m-m_{1}} f}{\cosh M|k|(v-v')} \right\|_{L^{\infty}[u(0),u(1)]^{2}}. \end{split}$$

Thus we proved the proposition.

By (4.23), Proposition 4.8 and Lemma 4.6, we have the following corollary:
**Corollary 4.9.** Suppose that  $u, \theta$  are the same as in Proposition 4.8 and  $\Phi_1$  satisfies (4.23), then there exist  $M_0$  and C(k) > 0 such that for any  $|k| \neq 0$ , for all integers  $m \ge m_1 \ge 0$  and  $M \ge M_0$ ,

$$\left|\partial_{v}^{m_{1}}\partial_{v'}^{m-m_{1}}\Phi_{1}(v,v',k)\right| \leq C(k)\Gamma_{s_{0}}(m)(2M)^{m}|k|^{m}.$$

Moreover there exists  $C \geq 1$  such that

$$\left|\partial_{v}^{m_{1}}\partial_{v'}^{m-m_{1}}\left(\frac{\Phi_{1}(v,v',k)-1}{(v-v')^{2}}\right)\right| \leq C(k)\Gamma_{s_{0}}(m)(CM)^{m}|k|^{m}.$$

*Proof.* The second inequality follows directly from the first inequality and the fact that  $\Phi_1(v, v', k)|_{v=v'} = 1$  and  $\partial_{v'} \Phi_1(v, v', k)|_{v=v'} = \partial_v \Phi_1(v, v', k) = 0|_{v=v'}$ . So we only need to prove the first inequality. By taking  $M_0$  large enough, it follows from (4.23) and Proposition 4.8 that

$$\begin{split} \|\Phi_1\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s_0}([u(0),u(1)]^2)} &\leq \|k^2 \mathbf{T}_0 \circ \mathbf{T}_{2,2} \Phi_1\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s_0}([u(0),u(1)]^2)} + C \\ &\leq \frac{C}{M^2} \|\Phi_1\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s_0}([u(0),u(1)]^2)} + C, \end{split}$$

which gives us that

$$\|\Phi_1\|_{\mathcal{G}_{ph,cosh}^{M|k|,s_0}([u(0),u(1)]^2)} \le C.$$

Then the corollary follows from Lemma 4.6.

4.3. Gevrey regularity of the coefficients and Fourier kernels. In order to estimate the Fourier kernels of  $\mathbf{D}_{u,k}$ ,  $\mathbf{D}_{u,k}^{-1}$ , and  $\mathbf{D}_{u,k}^{1}$ , we need write the kernel E(v, v', k) in a good form. Recall that in (y, y') coordinates we have

$$e(y,y',k) = \begin{cases} \phi(y,y',k) \int_0^y \frac{\theta(z)}{\phi(z,y',k)^2} dz & 0 \le y < y', \\ \phi(y,y',k) \int_1^y \frac{\theta(z)}{\phi(z,y',k)^2} dz & y' < y \le 1. \end{cases}$$

A direct calculation gives us that for j = 0, 1

$$\begin{split} \phi(y,y',k) &\int_{j}^{y} \frac{\theta(w)}{\phi(y,w,k)^{2}} dw \\ &= \phi(y,y',k) \int_{j}^{y} \frac{\theta(w)}{(u(w)-u(y'))^{2}} \Big(\frac{1}{\phi_{1}(w,y',k)^{2}} - 1\Big) dy' \\ &+ \phi(y,y',k) \int_{j}^{y} \frac{\theta(w)}{(u(w)-u(y'))^{2}} dw \\ &= \phi(y,y',k) \int_{j}^{y} \frac{\theta(z)}{(u(w)-u(y'))^{2}} \Big(\frac{1}{\phi_{1}(w,y',k)^{2}} - 1\Big) dw \\ &+ \phi(y,y',k) \int_{u(j)}^{u(y)} \frac{\left(\tilde{\theta}(u^{-1})'\right)(u_{1}) - \left(\tilde{\theta}(u^{-1})'\right)(u(y')) - \left(\tilde{\theta}(u^{-1})'\right)'(u(y'))(u_{1}-u(y'))}{(u_{1}-u(y'))^{2}} du_{1} \\ &- \left(\tilde{\theta}(u^{-1})'\right)(u(y')) \frac{\phi(y,y',k)}{u(w)-u(y')}\Big|_{w=j}^{w=y} + \phi(y,y',k) \left(\tilde{\theta}(u^{-1})'\right)'(u(y')) \ln |u(w)-u(y')|\Big|_{w=j}^{w=y}. \end{split}$$

Thus we obtain

(4.27)  
$$\phi(y,y',k) \int_{j}^{y} \frac{\theta(w)}{\phi(y,w,k)^{2}} dw \\ = -\left(\tilde{\theta}(u^{-1})'\right)(u(y')) + \phi(y,y',k) \left(\tilde{\theta}(u^{-1})'\right)'(u(y')) \ln|u(y) - u(y')| + \phi_{j}^{re}(y,y',k),$$

where  $\phi_j^{re}$  is the regular part

$$\begin{split} \phi_{j}^{re}(y,y',k) &= \phi(y,y',k) \int_{j}^{y} \frac{\theta(w)}{(u(w)-u(y'))^{2}} \Big(\frac{1}{\phi_{1}(w,y',k)^{2}} - 1\Big) dw \\ &+ \phi(y,y',k) \int_{u(j)}^{u(y)} \frac{\Big(\tilde{\theta}(u^{-1})'\Big)(u_{1}) - \Big(\tilde{\theta}(u^{-1})'\Big)(u(y')\big) - \Big(\tilde{\theta}(u^{-1})'\Big)'(u(y'))(u_{1} - u(y'))}{(u_{1} - u(y'))^{2}} du_{1} \\ &+ \Big(\tilde{\theta}(u^{-1})'\Big)(u(y'))(1 - \phi_{1}(y,y',k)) + \Big(\tilde{\theta}(u^{-1})'\Big)(u(y'))\frac{u(y) - u(y')}{u(j) - u(y')}\phi_{1}(y,y',k) \\ &- \phi(y,y',k)\Big(\tilde{\theta}(u^{-1})'\Big)'(u(y'))\ln|u(j) - u(y')|. \end{split}$$

Note that the integral  $\phi(y, y', k) \int_{j}^{y} \frac{\theta(w)}{\phi(w, y', k)^{2}} dw$  is well defined for y < y' if j = 0 and for y > y' if j = 1. However, the right-hand side of (4.27) can be defined for  $y \neq y'$ .

Therefore, we have

(4.28) 
$$e(y,y',k) = -\left(\tilde{\theta}(u^{-1})'\right)(u(y')) + \phi(y,y',k)\left(\tilde{\theta}(u^{-1})'\right)'(u(y'))\ln|u(y) - u(y')| + \phi_0^{re}(y,y',k)(1_{\mathbb{R}^-}(y-y')) + \phi_1^{re}(y,y',k)(1_{\mathbb{R}^+}(y-y'))$$

and thus

(4.29) 
$$E(v,v',k) = -\left(\tilde{\theta}(u^{-1})'\right)(v') + \Phi(v,v',k)\left(\tilde{\theta}(u^{-1})'\right)'(v')\ln|v-v'| + \Phi_0^{re}(v,v',k)(1_{\mathbb{R}^-}(v-v')) + \Phi_1^{re}(v,v',k)(1_{\mathbb{R}^+}(v-v'))$$

where for  $j = 0, 1, \Phi_j^{re}(v, v', k)$  satisfies  $\Phi_j^{re}(u(y), u(y'), k) = \phi_j^{re}(y, y', k)$ , namely,

$$\begin{split} \Phi_{j}^{re}(v,v',k) &= \Phi(v,v',k) \int_{u(j)}^{v} \frac{\tilde{\theta}(w)u^{-1}(w)}{(w-v')^{2}} \Big(\frac{1}{\Phi_{1}(w,v',k)^{2}} - 1\Big) dw \\ &+ \Phi(v,v',k) \int_{u(j)}^{v} \frac{\Big(\tilde{\theta}(u^{-1})'\Big)(u_{1}) - \Big(\tilde{\theta}(u^{-1})'\Big)(v') - \Big(\tilde{\theta}(u^{-1})'\Big)'(v')(u_{1}-v')}{(u_{1}-v')^{2}} du_{1} \\ &+ \Big(\tilde{\theta}(u^{-1})'\Big)(v')(1 - \Phi_{1}(v,v',k)) + \Big(\tilde{\theta}(u^{-1})'\Big)(v')\frac{v-v'}{u(j)-v'} \Phi_{1}(v,v',k) \\ &- \Phi(v,v',k) \Big(\tilde{\theta}(u^{-1})'\Big)'(v') \ln |u(j)-v'|. \end{split}$$

We define

$$\begin{aligned}
\Phi_{j,1}^{re}(v,v',k) &= \frac{\Phi_{j}^{re}(v,v',k)}{v-v'} \\
&= \Phi_{1}(v,v',k) \int_{u(j)}^{v} \frac{\tilde{\theta}(w)u^{-1}(w)}{(w-v')^{2}} \Big(\frac{1}{\Phi_{1}(w,v',k)^{2}} - 1\Big) dw \\
\end{aligned}$$
(4.30)
$$+ \Phi_{1}(v,v',k) \int_{u(j)}^{v} \frac{\Big(\tilde{\theta}(u^{-1})'\Big)(u_{1}\big) - \Big(\tilde{\theta}(u^{-1})'\Big)(v'\big) - \Big(\tilde{\theta}(u^{-1})'\Big)'(v')(u_{1}-v')}{(u_{1}-v')^{2}} du_{1} \\
&+ \Big(\tilde{\theta}(u^{-1})'\Big)(v') \frac{\Big(1 - \Phi_{1}(v,v',k)\Big)}{v-v'} + \Big(\tilde{\theta}(u^{-1})'\Big)(v') \frac{1}{u(j)-v'} \Phi_{1}(v,v',k) \\
&- \Phi_{1}(v,v',k) \Big(\tilde{\theta}(u^{-1})'\Big)'(v') \ln |u(j)-v'|.
\end{aligned}$$

We have the following proposition:

### **Proposition 4.10.** It holds that

$$|\partial_{v}^{m_{1}}\partial_{v'}^{m-m_{1}}B_{1}(v,k)| + |\partial_{v}^{m_{1}}\partial_{v'}^{m-m_{1}}B_{2}(v,k)| \le C(k)\Gamma_{s}(m)(M)^{m}$$

Recall that  $\tilde{\chi}_2 = \chi_2 \circ u^{-1}$  is a smooth function with compact support such that  $\operatorname{supp} \chi_2 \subset \left[\frac{\kappa_0}{2}, 1 - \frac{\kappa_0}{2}\right]$ and satisfies (1.10).

$$|\partial_{v}^{m_{1}}\partial_{v'}^{m-m_{1}}\tilde{\chi}_{2}(v)\tilde{\chi}_{2}(v')\Phi_{j}^{re}(v,v'k)| \leq C(k)\Gamma_{s}(m)(M)^{m}, \quad for \quad j=0,1,$$

and

$$|\partial_{v}^{m_{1}}\partial_{v'}^{m-m_{1}}\tilde{\chi}_{2}(v)\tilde{\chi}_{2}(v')\Phi_{j,1}^{re}(v,v'k)| \leq C(k)\Gamma_{s}(m)(M)^{m}, \quad for \quad j=0,1.$$

*Proof.* First, we write the numerator  $J_1(y',k)$  of  $b_1(y',k)$  in v' coordinate

$$\begin{aligned} \mathbf{J}_{1}(v',k) \stackrel{\text{def}}{=} & -(u(1) - v') \frac{\theta(0)}{u'(0)} - (v' - u(0)) \frac{\theta(1)}{u'(1)} \\ & + \tilde{\rho}(v') \int_{0}^{1} \frac{\tilde{\theta}(w)(u^{-1})'(w)}{(w - v')^{2}} \Big( \frac{1}{\Phi_{1}(w,v',k)^{2}} - 1 \Big) dw \\ & - \tilde{\rho}(v') \mathcal{H} \Big[ \Big( (\theta \circ u^{-1})(u^{-1})' \Big)' \chi_{[u(0),u(1)]} \Big] (v') \end{aligned}$$

where  $\tilde{\rho}(v') = (v' - u(0))(u(1) - v')$ . Notice that  $((\theta \circ u^{-1})(u^{-1})')'$  has compact support. Thus by Remark A.2, we have

$$\left|\mathcal{F}_{v\to\xi}[(\theta\circ u^{-1})(u^{-1})'](\xi)\right| \le Ce^{-\lambda_{u,\theta}\langle\xi\rangle^s}$$

which implies

$$\left|\mathcal{F}_{v'\to\xi}\left[\mathcal{H}\left[\left((\theta\circ u^{-1})(u^{-1})'\right)'\chi_{\left[u(0),u(1)\right]}\right](v')\right]\right| \leq Ce^{-\lambda_{u,\theta}\langle\xi\rangle^s}.$$

Thus by Lemma A.1, we have

$$\left|\partial_{v'}^{m} \left[\mathcal{H}\left[\left((\theta \circ u^{-1})(u^{-1})'\right)' \chi_{[u(0),u(1)]}\right](v')\right| \le C\Gamma_{s}(m)(M)^{m}.$$

The estimates of  $B_1, B_2$  follow directly from (3.9), Corollary 4.9, Lemma 3.5, and (A.9).

Now we prove the regularity of  $\Phi_j^{re}$  and  $\Phi_{j,1}^{re}$ . Notice that with the cut-off function, the 'bad' terms  $\tilde{\chi}_2(v)\tilde{\chi}_2(v')\Big(\tilde{\theta}(u^{-1})'\Big)(v')\frac{v-v'}{u(j)-v'}\Phi_1(v,v',k)$  is regular. For the term that contains logarithmic function  $\Phi(v,v',k)\Big(\tilde{\theta}(u^{-1})'\Big)'(v')\ln|u(j)-v'|$ , we notice that  $\Big(\tilde{\theta}(u^{-1})'\Big)'(v')$  has compact support. Thus by using (3.9), Corollary 4.9, Lemma 3.5, and (A.9), we prove the proposition.

Although the wave operator is nonlocal both in physical space and frequency space, the next proposition shows that the wave operator does not move frequencies a lot. Now we introduce the Fourier kernels and the estimates.

**Proposition 4.11.** Recall that  $\tilde{\chi}_2 = \chi_2 \circ u^{-1}$  is a smooth function with compact support such that  $\sup \chi_2 \subset [\frac{\kappa_0}{2}, 1 - \frac{\kappa_0}{2}]$  and satisfies (1.10). Then for any  $0 < |k| \leq k_M$ , there exist  $\mathcal{D}(t, k, \xi_1, \xi_2)$ ,  $\mathcal{D}^1(t, k, \xi_1, \xi_2)$  and  $\mathcal{D}^{-1}(t, k, \xi_1, \xi_2)$  such that

$$\mathcal{F}_2\Big(\mathbf{D}_{u,k}\big(\tilde{\chi}_2\mathcal{F}_1f(t,k,\cdot)\big)\Big)(t,k,\xi_1) = \int \mathcal{D}(t,k,\xi_1,\xi_2)\hat{f}_k(t,\xi_2)d\xi_2,$$

and

$$\mathcal{F}_2\Big(\tilde{\chi}_2\mathbf{D}^1_{u,k}\big(\tilde{\chi}_2\mathcal{F}_1f(t,k,\cdot)\big)\Big)(t,k,\xi_1) = \int \mathcal{D}^1(t,k,\xi_1,\xi_2)\hat{f}_k(t,\xi_2)d\xi_2,$$

and

$$\mathcal{F}_{2}\Big(\mathbf{D}_{u,k}^{-1}\big(\tilde{\chi}_{2}\mathcal{F}_{1}f(t,k,\cdot)\big)\Big)(t,k,\xi_{1}) = \int \mathcal{D}^{-1}(t,k,\xi_{1},\xi_{2})\hat{f}_{k}(t,\xi_{2})d\xi_{2}.$$

Moreover, there exists  $\lambda_{\mathcal{D}} = \lambda_{\mathcal{D}}(\lambda_0, \kappa_0, s_0, s_1, k_M)$  independent of t such that

(4.31) 
$$|\mathcal{D}(t,k,\xi_1,\xi_2)| + |\mathcal{D}^1(t,k,\xi_1,\xi_2)| + |\mathcal{D}^{-1}(t,k,\xi_1,\xi_2)| \lesssim e^{-\lambda_{\mathcal{D}}|\xi_1-\xi_2|^{s_0}}.$$

*Proof.* Note that by (4.14), (4.15) and (4.16), the wave operator  $\mathbf{D}_{u,k}$  is similar to the operator  $\mathbf{D}_{u,k}^1$  and the inverse wave operator  $\mathbf{D}_{u,k}^{-1}$  in structure. We only present the proof for the wave operator  $\mathbf{D}_{u,k}$ . The estimates of  $\mathbf{D}_{u,k}^1$  and  $\mathbf{D}_{u,k}^{-1}$  are similar and we omit them.

We divide the nonlocal part of the wave operator into four different types of integral operators whose kernels have different singularities:

(4.32) 
$$\mathbf{D}_{u,k} \big( \mathcal{F}_1 \tilde{f}(t,k,\cdot) \big)(t,k,v') = B_1(v,k) \mathcal{F}_1 \tilde{f}(t,k,v) + \sum_{j=1}^4 \Pi_j(\tilde{f}),$$

where

$$\begin{split} \Pi_{1}(\tilde{f}) &= \widetilde{\varphi_{1}}(v')B_{2}(v',k) \int_{u(0)}^{u(1)} \mathcal{F}_{1}\tilde{f}(u_{1})e^{-i(u_{1}-v')tk}(u^{-1})'(u_{1})\Phi_{1,1}^{re}(u_{1},v',k)du_{1}, \\ \Pi_{2}(\tilde{f}) &= \widetilde{\varphi_{1}}(v')B_{2}(v',k) \int_{u(0)}^{u(1)} \mathcal{F}_{1}\tilde{f}(u_{1})e^{-i(u_{1}-v')tk}(u^{-1})'(u_{1})\Phi_{0,1}^{re}(u_{1},v',k)(1_{\mathbb{R}^{-}}(u_{1}-v'))du_{1} \\ &\quad - \widetilde{\varphi_{1}}(v')B_{2}(v',k) \int_{u(0)}^{u(1)} \mathcal{F}_{1}\tilde{f}(u_{1})e^{-i(u_{1}-v')tk}(u^{-1})'(u_{1})\Phi_{1,1}^{re}(u_{1},v',k)1_{\mathbb{R}^{-}}(u_{1}-v')du_{1}, \\ \Pi_{3}(\tilde{f}) &= \widetilde{\varphi_{1}}(v')B_{2}(v',k) \int_{u(0)}^{u(1)} \mathcal{F}_{1}\tilde{f}(u_{1})e^{-i(u_{1}-v')tk}(u^{-1})'(u_{1}) \\ &\quad \times \left(\tilde{\theta}(u^{-1})'\right)'(v')\Phi_{1}(u_{1},v',k)\ln|u_{1}-v'|du_{1}, \\ \Pi_{4}(\tilde{f}) &= -\left(\tilde{\theta}(u^{-1})'\right)(v')\widetilde{\varphi_{1}}(v')B_{2}(v',k) \int_{u(0)}^{u(1)} \frac{\mathcal{F}_{1}\tilde{f}(u_{1})e^{-i(u_{1}-v')tk}}{u_{1}-v'}(u^{-1})'(u_{1})du_{1}. \end{split}$$

By Lemma B.1, we get that there exists  $\mathcal{D}(t, k, \xi_1, \xi_2)$  such that

$$\mathcal{F}_2\Big(\mathbf{D}_{u,k}\big(\tilde{\chi}_2\mathcal{F}_1f(t,k,\cdot)\big)\Big)(t,k,\xi_1) = \int \mathcal{D}(t,k,\xi_1,\xi_2)\hat{f}_k(t,\xi_2)d\xi_2.$$

The behavior of  $\mathcal{D}(t, k, \xi_1, \xi_2)$  depends only on the regularity of  $D_1$ ,  $D_2$  and E. Therefore by Lemma B.1, Remark A.2, Corollary 4.9, Proposition 4.10, and Lemma B.2, we obtain Proposition 4.11.  $\Box$ 

4.4. Commutator. In this section, let us study the difference between  $\mathbf{D}_{u,k}^1$  and  $\mathbf{D}_{u,k}$  and prove the following proposition.

**Proposition 4.12.** There exists  $\mathcal{D}^{com}(t, k, \xi, \xi_1)$  such that

$$\mathcal{F}_2\Big(\tilde{\chi}_2\mathbf{D}_{u,k}(\tilde{\chi}_2\mathcal{F}_1f) - \tilde{\chi}_2\mathbf{D}_{u,k}^1(\tilde{\chi}_2\mathcal{F}_1f)\Big)(\xi) = \int \mathcal{D}^{com}(t,k,\xi,\xi_1)\hat{f}_k(t,\xi_1)d\xi_1.$$

Moreover, there exists  $\lambda_{\mathcal{D}} = \lambda_{\mathcal{D}}(\lambda_0, \theta_0, s_0, s_1, k_M)$  independent of t such that

$$\left|\mathcal{D}^{com}(t,k,\xi,\xi_1)\right| \lesssim \min\left(\frac{e^{-\lambda_{\mathcal{D}}|\xi-\xi_1|^{s_0}}}{1+|\xi-kt|^2}, \frac{e^{-\lambda_{\mathcal{D}}|\xi-\xi_1|^{s_0}}}{1+|\xi_1-kt|^2}\right).$$

*Proof.* We have by (4.29) that

$$\begin{split} \tilde{\chi}_{2} \mathbf{D}_{u,k}(\mathcal{F}_{1}f) &= \tilde{\chi}_{2} \mathbf{D}_{u,k}^{u}(\mathcal{F}_{1}f) \\ &= \tilde{\chi}_{2} B_{2}(v,k) \int_{u(0)}^{u(1)} E(k,v_{1},v) \frac{\mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk}}{v_{1}-v} \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ &= -\tilde{\chi}_{2} B_{2}(k,v) \int_{u(0)}^{u(1)} \left( \tilde{\theta}(u^{-1})' \right)(v) \frac{\mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk}}{v_{1}-v} \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ &+ \tilde{\chi}_{2} B_{2}(k,v) \int_{u(0)}^{u(1)} \Phi_{1}(v_{1},v,k) \Big( \tilde{\theta}(u^{-1})' \Big)'(v) \ln |v_{1}-v| \mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk} \\ &\times \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ &+ \tilde{\chi}_{2} B_{2}(v,k) \int_{u(0)}^{u(1)} \Phi_{0,1}^{re}(v_{1},v,k) (1_{\mathbb{R}^{-}}(v_{1}-v)) \mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk} \\ &\times \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ &+ \tilde{\chi}_{2} B_{2}(v,k) \int_{u(0)}^{u(1)} \Phi_{1,1}^{re}(v_{1},v,k) (1_{\mathbb{R}^{+}}(v_{1}-v)) \mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk} \\ &\times \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} . \end{split}$$

Let  $\mathcal{D}^{com}(t, k, \xi, \xi_1)$  be the Fourier kernel of the operator  $\tilde{\chi}_2 \mathbf{D}_{u,k}(\tilde{\chi}_2 \mathcal{F}_1 f) - \tilde{\chi}_2 \mathbf{D}_{u,k}^1(\tilde{\chi}_2 \mathcal{F}_1 f)$ , which means that

$$\mathcal{F}_2\Big(\tilde{\chi}_2\mathbf{D}_{u,k}(\tilde{\chi}_2\mathcal{F}_1f) - \tilde{\chi}_2\mathbf{D}_{u,k}^1(\tilde{\chi}_2\mathcal{F}_1f)\Big)(\xi) = \int \mathcal{D}^{com}(t,k,\xi,\xi_1)\hat{f}_k(t,\xi_1)d\xi_1.$$

Then by the same argument as in the proof of Proposition 4.11, we get that there exists  $\lambda_{\mathcal{D}}$  such that

 $\left|\mathcal{D}^{com}(t,k,\xi,\xi_1)\right| \lesssim e^{-\lambda_{\mathcal{D}}|\xi-\xi_1|^{s_0}}.$ 

Let us also study the derivate  $(\partial_v - itk)$  acting on  $\tilde{\chi}_2 \mathbf{D}_{u,k}(\mathcal{F}_1 f) - \tilde{\chi}_2 \mathbf{D}_{u,k}^1(\mathcal{F}_1 f)$ :

$$\begin{aligned} &(\partial_v - itk) \Big( \tilde{\chi}_2 \mathbf{D}_{u,k}(\mathcal{F}_1 f) - \tilde{\chi}_2 \mathbf{D}_{u,k}^1(\mathcal{F}_1 f) \Big) \\ &= \tilde{\chi}_2 B_2(v,k) \int_{u(0)}^{u(1)} \Phi_1(v_1,v,k) \Big( \tilde{\theta}(u^{-1})' \Big)'(v) \ln |v_1 - v| \mathcal{F}_1 f(v_1) e^{-i(v_1 - v)tk} \Big) \end{aligned}$$

$$\times \partial_{v} \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ + \widetilde{\chi}_{2}B_{2}(v,k) \int_{u(0)}^{u(1)} \Phi_{0,1}^{re}(v_{1},v,k)(1_{\mathbb{R}^{-}}(v_{1}-v))\mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk} \\ \times \partial_{v} \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ + \widetilde{\chi}_{2}B_{2}(v,k) \int_{u(0)}^{u(1)} \Phi_{1,1}^{re}(v_{1},v,k)(1_{\mathbb{R}^{+}}(v_{1}-v))\mathcal{F}_{1}f(v_{1})e^{-i(v_{1}-v)tk} \\ \times \partial_{v} \Big[ \widetilde{\varphi_{1}}(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})'(v) \Big] dv_{1} \\ \end{array}$$

+ good terms.

Here note that the derivative  $\partial_v$  acting on  $\ln |v_1 - v|$  gives a good term:

$$\frac{\widetilde{\varphi_1}(v)(u^{-1})'(v_1) - \widetilde{\varphi_1}(v_1)(u^{-1})'(v)}{v_1 - v} \in \mathcal{G}_{ph,1}^{K_u,s}([u(0), u(1)]^2),$$

for some  $K_u > 0$ . Therefore, there exists  $\mathcal{D}^{com,1}(t,k,\xi,\xi_1)$  such that

$$(i\xi - ikt)\mathcal{F}_2\Big(\tilde{\chi}_2\mathbf{D}_{u,k}(\tilde{\chi}_2\mathcal{F}_1f) - \tilde{\chi}_2\mathbf{D}_{u,k}^1(\tilde{\chi}_2\mathcal{F}_1f)\Big)(\xi) = \int \mathcal{D}^{com,1}(t,k,\xi,\xi_1)\hat{f}_k(t,\xi_1)d\xi_1.$$

Moreover, Lemma B.2 gives us that there exists  $\lambda_{\mathcal{D}}'$  such that

$$|\mathcal{D}^{com,1}(t,k,\xi,\xi_1)| \lesssim e^{-\lambda_{\mathcal{D}}'|\xi-\xi_1|^{s_0}},$$

which together with the fact that

$$i(\xi - kt)\mathcal{D}^{com}(t, k, \xi, \xi_1) = \mathcal{D}^{com, 1}(t, k, \xi, \xi_1),$$

gives us that

$$\left|\mathcal{D}^{com}(t,k,\xi,\xi_1)\right| \lesssim \frac{e^{-\lambda_{\mathcal{D}}'|\xi-\xi_1|^{s_0}}}{1+|\xi-kt|}.$$

We can repeat the above argument once more and get that

$$\begin{aligned} (\partial_{v} - itk)^{2} \Big( \tilde{\chi}_{2} \mathbf{D}_{u,k}(\mathcal{F}_{1}f) - \tilde{\chi}_{2} \mathbf{D}_{u,k}^{1}(\mathcal{F}_{1}f) \Big) \\ &= \tilde{\chi}_{2} B_{2}(v,k) \int_{u(0)}^{u(1)} \Phi_{1}(v_{1},v,k) \Big( \tilde{\theta}(u^{-1})' \Big)'(v) \frac{\mathcal{F}_{1}f(v_{1})}{v_{1} - v} e^{-i(v_{1} - v)tk} \\ &\times \Big[ \widetilde{\varphi_{1}}'(v)(u^{-1})'(v_{1}) - \widetilde{\varphi_{1}}(v_{1})(u^{-1})''(v) \Big] dv_{1} \\ &+ \tilde{\chi}_{2} B_{2}(v,k) \Phi_{0,1}^{re}(v,v,k) \mathcal{F}_{1}f(v) \Big[ \widetilde{\varphi_{1}}'(v)(u^{-1})'(v) - \widetilde{\varphi_{1}}(v)(u^{-1})''(v) \Big] \\ &+ \tilde{\chi}_{2} B_{2}(v,k) \Phi_{1,1}^{re}(v,v,k) \mathcal{F}_{1}f(v) \Big[ \widetilde{\varphi_{1}}'(v)(u^{-1})'(v) - \widetilde{\varphi_{1}}(v)(u^{-1})''(v) \Big] \\ &+ \operatorname{good terms.} \end{aligned}$$

Therefore, there exists  $\mathcal{D}^{com,2}(t,k,\xi,\xi_1)$  such that

$$(i\xi - ikt)^2 \mathcal{F}_2\Big(\tilde{\chi}_2 \mathbf{D}_{u,k}(\tilde{\chi}_2 \mathcal{F}_1 f) - \tilde{\chi}_2 \mathbf{D}_{u,k}^1(\tilde{\chi}_2 \mathcal{F}_1 f)\Big)(\xi) = \int \mathcal{D}^{com,2}(t,k,\xi,\xi_1) \hat{f}_k(t,\xi_1) d\xi_1.$$

Moreover, there exists  $\lambda_{\mathcal{D}}'$  such that

$$|\mathcal{D}^{com,2}(t,k,\xi,\xi_1)| \lesssim e^{-\lambda'_{\mathcal{D}}|\xi-\xi_1|^{s_0}},$$

which together with the fact that

$$-(\xi - kt)^2 \mathcal{D}^{com}(t,k,\xi,\xi_1) = \mathcal{D}^{com,2}(t,k,\xi,\xi_1),$$

gives us that

$$\left|\mathcal{D}^{com}(t,k,\xi,\xi_1)\right| \lesssim \frac{e^{-\lambda_{\mathcal{D}}'|\xi-\xi_1|^{s_0}}}{1+|\xi-kt|^2}.$$

By using the fact that

$$\frac{1+|\xi_1-kt|^2}{1+|\xi-kt|^2} \lesssim \frac{1+|\xi-kt|^2+|\xi-\xi_1|^2}{1+|\xi-kt|^2} \lesssim \langle \xi-\xi_1 \rangle^2,$$

we obtain Proposition 4.12 for some  $\lambda_{\mathcal{D}} < \lambda'_{\mathcal{D}}$ .

# 5. The good system

Now we apply the wave operator on  $\Omega$  in (2.15). Let us first introduce the new good unknown

(5.1) 
$$f(t,z,v) \stackrel{\text{def}}{=} P_0(\Omega)(t,v) + P_{|k| \ge k_M} \Omega(t,z,v) + \sum_{0 < |k| < k_M} \mathbf{D}_{u,k}(\mathcal{F}_1 \Omega(t,k,\cdot))(t,k,v) e^{izk},$$

where

$$P_{|k| \ge k_M} \Omega(t, z, v) = \sum_{|k| \ge k_M} \mathcal{F}_1 \Omega(t, k, v) e^{ikz}.$$

Let us give the following remark and determine  $k_M$ .

**Remark 5.1** (Determination of  $k_M$ ). To make the choice of  $k_M$  more precise, let us first introduce three constants:

- (1) The constant  $C_{ell} \geq 1$  only depends on the background flow. It is the constant appearing in the linear elliptic estimate.
- (2) The constant  $C_{\varphi_1''} = 1 + \|\widetilde{\varphi_1}\|_{\mathcal{G}^{s,\sigma+2}}$  only depends on the Gevrey norm of  $\widetilde{\varphi_1}$ .
- (3) The constant  $C_0 \ge 1$  is a universal constant that depends on s and  $\sigma$ .

We choose  $k_M$  such that

$$(5.2) k_M \ge 100C_0C_{u''}C_{ell}$$

Since  $C_{u''}$  and  $C_{ell}$  only depend on the background flow, the constant  $k_M$  is fixed once the background flow is given.

By Remark 4.5, f has the same compact support as  $\Omega$ .

 $\circ$ 

Let us now deduce the equation of the new good unknown f. An easy calculation shows that

$$\begin{split} \partial_t f &= \partial_t P_0(\Omega) + \partial_t P_{k \ge k_M} \Omega \\ &+ \partial_t \sum_{0 < |k| < k_M} \mathbf{D}_{u,k}(\mathcal{F}_1 \Omega(t,k,\cdot))(t,k,v) e^{izk} \\ &= -P_0 \left( \mathbf{U} \cdot \nabla_{z,v} \Omega \right) - P_0 \left( \mathcal{N}_\Omega[\Psi] \right) - P_0 \left( \mathcal{N}_a[\Pi] \right) + \underline{\varphi_1} \partial_z P_{k \ge k_M} \Psi \\ &- P_{k \ge k_M} \left( \mathbf{U} \cdot \nabla_{z,v} \Omega \right) - P_{k \ge k_M} \left( \mathcal{N}_\Omega[\Psi] \right) - P_{k \ge k_M} \left( \mathcal{N}_a[\Pi] \right) \\ &+ \sum_{0 < |k| < k_M} \left[ \partial_t, \mathbf{D}_{u,k} \right] \left( \mathcal{F}_1 \Omega(t,k,\cdot) \right) (t,k,v) e^{izk} \end{split}$$

$$+ \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \underline{\varphi_1} \partial_z (\Psi) \right) \right) (t,k,v) e^{izk} \\ - \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \mathbf{U} \cdot \nabla_{z,v} \Omega \right) \right) (t,k,v) e^{izk} \\ - \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \mathcal{N}_\Omega[\Psi] \right) \right) (t,k,v) e^{izk} - \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \mathcal{N}_a[\Pi] \right) \right) (t,k,v) e^{izk}.$$

By the fact that,

$$\begin{split} \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \left( \underline{\varphi_{1}} \partial_{z} \Psi \right) \right) (t,k,v) \\ &= \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \left( \widetilde{\varphi_{1}} \partial_{z} \left( \left( \tilde{\Delta}_{t}^{l} \right)^{-1} \Omega \right) \right) \right) (t,k,v) + \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \left( \underline{\varphi_{1}} \partial_{z} \Psi - \widetilde{\varphi_{1}} \partial_{z} \left( \left( \tilde{\Delta}_{t}^{l} \right)^{-1} \Omega \right) \right) \right) (t,k,v) \\ &= \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \left( \widetilde{\varphi_{1}} \partial_{z} \left( \left( \tilde{\Delta}_{t}^{l} \right)^{-1} \Omega \right) \right) \right) (t,k,v) + \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \left( \varphi_{1}^{\delta} \partial_{z} \Psi - \widetilde{\varphi_{1}} \partial_{z} \left( \left( \tilde{\Delta}_{t}^{l} \right)^{-1} \Omega - \Psi \right) \right) \right) (t,k,v) \\ &= -ikv \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \Omega(t,k,\cdot) \right) (t,k,v) + \mathbf{D}_{u,k} \left( ik \mathcal{F}_{1} v \Omega(t,k,\cdot) \right) (t,k,v) \\ &+ \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \left( \varphi^{\delta} \partial_{z} \Psi - \widetilde{\varphi_{1}} \partial_{z} \left( \left( \tilde{\Delta}_{t}^{l} \right)^{-1} \Omega - \Psi \right) \right) \right) (t,k,v), \end{split}$$

we obtain by (4.19) that

$$(5.3) \qquad \partial_t f = -P_0 \left( \mathbf{U} \cdot \nabla_{z,v} \Omega \right) - P_0 \left( \mathcal{N}_\Omega[\Psi] \right) - P_0 \left( \mathcal{N}_a[\Pi] \right) + \underline{\varphi_1} \partial_z P_{|k| \ge k_M} \Psi - P_{|k| \ge k_M} \left( \mathbf{U} \cdot \nabla_{z,v} \Omega \right) - P_{k \ge k_M} \left( \mathcal{N}_\Omega[\Psi] \right) - P_{k \ge k_M} \left( \mathcal{N}_a[\Pi] \right) + \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \varphi_1^{\delta} \partial_z \Psi - \widetilde{\varphi_1} \partial_z \left( \left( \widetilde{\Delta}_t^l \right)^{-1} \Omega - \Psi \right) \right) \right) (t, k, v) e^{izk} - \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \mathbf{U} \cdot \nabla_{z,v} \Omega \right) \right) (t, k, v) e^{izk} - \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \mathcal{N}_\Omega[\Psi] \right) \right) (t, k, v) e^{izk} - \sum_{0 < |k| < k_M} \mathbf{D}_{u,k} \left( \mathcal{F}_1 \left( \mathcal{N}_\Omega[\Psi] \right) \right) (t, k, v) e^{izk}.$$

Here we recall the notations used in the previous calculations

$$\tilde{\Delta}_t^l = \widetilde{\varphi_4}\partial_{zz} + \widetilde{u'}(\partial_v - t\partial_z) \Big(\widetilde{\varphi_4}\widetilde{u'}(\partial_v - t\partial_z)\Big).$$

We also have

$$\partial_t v(t,y) = -\frac{\chi_1(y)}{t^2} \int_0^t P_0(U^x)(t',y)dt' + \frac{\chi_1(y)}{t} P_0(U^x)(t,y),$$

and

$$\partial_{tt}v(t,y) = \partial_t \left( \underline{\partial_t v}(t,v(t,y)) \right) = \partial_t \left( \underline{\partial_t v} \right)(t,v(t,y)) + \partial_t v(t,y) \partial_v \left( \underline{\partial_t v} \right)(t,v(t,y))$$

which gives that

$$\partial_{tt}v(t,y) = \frac{2\chi_1(y)}{t^3} \int_0^t P_0(U^x)(t',y)dt' - \frac{2\chi_1(y)}{t^2} P_0(U^x)(t,y) + \frac{\chi_1(y)}{t} P_0(\partial_t U^x)(t,y)$$

$$= -\frac{2}{t}\partial_t v(t,y) + \frac{\chi_1(y)}{t}P_0(\partial_t U^x)(t,y).$$

By using the fact that

$$\partial_t U^x + u(y)\partial_x U^x + u'(y)U^y + \theta(y)\partial_x P + d\partial_x P + U^x \partial_x U^x + U^y \partial_y U^x = 0,$$

we obtain that

(5.4) 
$$\partial_t(\underline{\partial_t v}) + \underline{\partial_t v} \partial_v(\underline{\partial_t v}) + \frac{2}{t}(\underline{\partial_t v}) = -\frac{\underline{\chi_1}}{t} \underline{\partial_y v} P_0\left(\nabla_{z,v}^{\perp} P_{\neq}(\Psi) \cdot \nabla_{z,v} \underline{U^x}\right) \\ -\frac{\underline{\chi_1}}{t} P_0\left(P_{\neq}(a)\partial_z P_{\neq}(\Pi_l + \Pi_n)\right),$$

where  $\underline{U^x}(t, z(t, x, y), v(t, y)) = U^x(t, x, y)$ . We also have

$$\partial_y v(t,y) = u'(y) - \frac{1}{t} \int_0^t P_0(\omega)(t',y) dt',$$

then it holds that

$$\partial_t \Big( t \big( \partial_y v(t, y) - u'(y) \big) \Big) = -P_0(\omega)(t, y).$$

Let  $h(t, v(t, y)) = \partial_y v(t, y) - u'(y)$ , then h(t, v) satisfies

(5.5) 
$$\partial_t h + \underline{\partial_t v} \partial_v h = \frac{1}{t} \left( -P_0(\underline{\omega}) - h \right) \stackrel{\text{def}}{=} \bar{h} = \underline{\partial_y v} \partial_v \underline{\partial_t v}.$$

We then get

(5.6)  
$$\partial_t \bar{h} = -\frac{\bar{h}}{t} - \frac{1}{t} (\partial_t P_0(\underline{\omega}) + \partial_t h)$$
$$= -\frac{2\bar{h}}{t} - \underline{\partial_t v} \partial_v \bar{h} + \frac{\partial_y v}{t} \Big( P_0(\partial_z \Psi \partial_v \underline{\omega} - \partial_v \Psi \partial_z \underline{\omega}) - P_0(\partial_z \Pi_l \partial_v a - \partial_v \Pi_l \partial_z a) - P_0(\partial_z \Pi_n \partial_v a - \partial_v \Pi_n \partial_z a) \Big).$$

We now introduce the cut-off function  $\Upsilon_1(v), \Upsilon_2(v) \in \mathcal{G}_{ph,1}^{M(\kappa_0),\frac{s+1}{2}}$  which satisfies

supp 
$$\Upsilon_1(v) \subset [u(\kappa_0), u(1-\kappa_0)]$$
  
supp  $\Upsilon_2(v) \subset \left[u(\frac{\kappa_0}{2}), u(1-\frac{\kappa_0}{2})\right]$ 

and  $\Upsilon(v) \equiv 1$ , for  $v \in [u(\kappa_0), u(1-\kappa_0)]$ .

## 6. Energy functional and bootstrap proposition

We will use the same multiplier  $A(t, \nabla)$  introduced in [5].

$$\mathbf{A}_{k}(t,\eta) = e^{\lambda(t)\langle k,\eta\rangle^{s}} \langle k,\eta\rangle^{\sigma} \mathbf{J}_{k}(t,\eta).$$

The index  $\lambda(t)$  is the bulk Gevrey- $\frac{1}{s}$  regularity and will be chosen to satisfy

$$\lambda(t) = \frac{3}{4}\lambda_0 + \frac{1}{4}\lambda', \quad t \le 1$$
$$\dot{\lambda}(t) = -\frac{\delta_\lambda}{\langle t \rangle^{2\bar{q}}}(1 + \lambda(t)), \quad t \in (1, \infty)$$

where  $\lambda_0, \lambda'$  are parameters that depend on the regularity of the background flow u(y), density  $\theta(y)$ and chosen by the proof,  $\delta_{\lambda} \approx \lambda_0 - \lambda'$  is a small parameter that ensures  $\lambda(t) \geq \frac{\lambda_0}{2} + \frac{\lambda'}{2}$  for  $t \geq 0$ and  $\frac{1}{2} < \tilde{q} \leq \frac{s}{8} + \frac{7}{16}$  is a parameter chosen by the proof. The main multiplier for dealing with the Orr mechanism and the associated nonlinear growth is

Here  $(w_{\rm R}(t,\eta), w_{\rm NR}(t,\eta))$  is defined in the following way:

Let  $w_{\rm NR}$  be a non-decreasing function of time with  $w_{\rm NR}(t,\eta) = 1$  for  $t \ge 2\eta$ . For definiteness, we remark here that for  $|\eta| \leq 1$ ,  $w_{\rm NR}(t,\eta) = 1$ , which will be a consequence of the definition. For  $k = 1, 2, 3, \dots, \mathrm{E}(\sqrt{\eta})$ , we define

One may refer to [5] and Appendix D for more basic properties of the multiplier  $A(t, \nabla)$ . We also introduce the Fourier multiplier  $A^*(t, \nabla) = \mathcal{F}^{-1}(A_k^*(t, \eta)\hat{f}_k(t, \eta))$  from [11],

$$A_k^*(t,\eta) = A_k(t,\eta)B_k(t,\eta), \quad B_k(t,\eta) = \left(1 + \frac{k^2 + |\eta|}{\langle t \rangle^2}\right)^{\frac{1}{2}}.$$

The weight is well-constructed to capture the important regularity difference between the vorticity f and the density a.

## Remark 6.1. It holds that

$$\frac{\partial_t \mathcal{A}_k^*(t,\eta)}{\mathcal{A}_k^*(t,\eta)} = \frac{\partial_t \mathcal{A}_k(t,\eta)}{\mathcal{A}_k(t,\eta)} - \frac{t(k^2 + |\eta|)}{\langle t \rangle^4 + (k^2 + |\eta|) \langle t \rangle^2} \approx \frac{\partial_t \mathcal{A}_k(t,\eta)}{\mathcal{A}_k(t,\eta)}.$$

*Proof.* The remark follows directly from the fact that

$$\frac{t(k^2+|\eta|)}{\langle t\rangle^4+(k^2+|\eta|)\langle t\rangle^2} \lesssim \frac{\langle k\rangle^{\frac{1}{2}}}{\langle t\rangle^{\frac{3}{2}}} + \frac{\langle \eta\rangle^{\frac{1}{2}}}{\langle t\rangle^2} \lesssim \frac{\langle k,\eta\rangle^s}{\langle t\rangle^{2\bar{q}}}.$$

Let us mention some ideas for choosing the multiplier B. It is used to solve the problem from the nonlinear interactions between the pressure and the density, which can be formally written as  $\partial_z \Pi \partial_v a$  and  $\partial_v \Pi \partial_z a$ . On one hand, if the pressure is in higher frequencies, namely,  $\partial_z \Pi_{high} \partial_v a_{low}$ and  $\partial_v \Pi_{high} \partial_z a_{low}$ , both terms behavior as the Reaction terms  $\partial_z \Psi_{high} \partial_v \Omega_{low}$  and  $\partial_v \Psi_{high} \partial_z \Omega_{low}$ . They can be controlled easily. We only need to control

$$\left\|\left\langle\frac{\partial_v}{t\partial_z}\right\rangle^{-1} \left(\partial_z^2 + (\partial_v - t\partial_z)^2\right) \left(\frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^s} \mathbf{A} + \sqrt{\frac{\partial_t w}{w}} \tilde{\mathbf{A}}\right) P_{\neq}(\Pi\Upsilon_2)\right\|_2^2$$

by the  $\mathcal{CK}$  terms. However, it is not enough to close the elliptic estimate for the pressure  $\Pi$ . Indeed, unlike the elliptic equation of the stream function, the elliptic error terms in the pressure equations are not just zero mode, see  $S_a[\Pi]$  and its estimates in Lemma 10.3. Notice that  $\Pi$  behaves better than the stream function  $\Psi$ , which allows us to replace  $\left\langle \frac{\partial_v}{\partial z} \right\rangle^{-1} A(t, \nabla)$  by a stronger weight  $\mathcal{M}_3$ , see Propositions 7.8, 7.9, and 7.10, and section 9 and section 10 for more details. On the other hand, when the density a is in higher frequencies, namely,  $\partial_z \Pi_{low} \partial_v a_{high}$  and  $\partial_v \Pi_{low} \partial_z a_{high}$ , we have derivative loss. Note that in similar terms that involve the stream function and vorticity, we use the commutator to gain a 1/2 derivative. Here we put half more derivative in the multiplier of

a for short time, which allows us to control these terms. Then we should be careful in estimating the linear term  $-\underline{\theta'}\partial_z(\Upsilon_2\Psi)$  in the equation of a, because the added weight B will act on  $\Psi$ , see Proposition 7.14 and section 13 for more details. The other place where we take advantage of the operator B is the estimate of elliptic error term  $S_a(\Pi)$ , see the proof of Lemma 10.3 for more details.

Let us now remark here that by the nice Fourier kernel estimates, the operator A commutates well with the wave operator. The following two remarks can be found in [28].

**Remark 6.2.** There exists  $C = C(k_M) \ge 1$  independent of t such that for any  $\lambda < \lambda_D$ ,

$$C^{-1} \|\Omega\|_{\mathcal{G}^{s,\lambda,\sigma}(\mathbb{T}\times[u(0),u(1)])} \le \|f\|_{\mathcal{G}^{s,\lambda,\sigma}(\mathbb{T}\times[u(0),u(1)])} \le C \|\Omega\|_{\mathcal{G}^{s,\lambda,\sigma}(\mathbb{T}\times[u(0),u(1)])},$$

and that there exists  $C = C(k_M) \ge 1$  independent of t such that for any  $\lambda(t) < \lambda_D$ ,

$$C^{-1} \|\mathbf{A}\Omega\|_2^2 \le \|\mathbf{A}f\|_2^2 \le C \|\mathbf{A}\Omega\|_2^2.$$

**Remark 6.3.** Proposition 4.11 gives us that for  $\lambda_0$  and  $\lambda'$  sufficiently small,

$$-\dot{\lambda}(t) \left\| |\nabla|^{s/2} \mathrm{A}\Omega \right\|_{2}^{2} + \left\| \sqrt{\frac{\partial_{t} w}{w}} \tilde{\mathrm{A}}\Omega \right\|_{2}^{2} \lesssim \mathcal{C}\mathcal{K}_{f},$$

where

$$\mathcal{CK}_f = \sum_{k \in \mathbb{Z}} \int_{\mathbb{R}} |\dot{\mathbf{A}}_k(t,\eta)| \mathbf{A}_k(t,\eta) |\hat{f}_k(t,\eta)|^2 d\eta.$$

**Remark 6.4.** The following fact will be frequently used: for any function  $\underline{\varphi}$  of zero mode, we write  $\underline{\varphi} = \widetilde{\varphi} + \varphi^{\delta}$ 

$$\left\| \sqrt{\frac{\partial_t w}{w}} \tilde{\mathbf{A}}(\underline{\varphi} P_{\neq} f) \right\|_{L^2} \lesssim \|\widetilde{\varphi}\|_{\mathcal{G}^{s,\sigma+2}} \mathcal{C} \mathcal{K}_f + \|\varphi^{\delta}\|_{\mathcal{G}^{s,\sigma-6}} \mathcal{C} \mathcal{K}_f + \left\| \sqrt{\frac{\partial_t w}{w}} \mathbf{A}^{\mathbf{R}} \varphi^{\delta} \right\|_2 \|f\|_{\mathcal{G}^{s,\sigma-6}} \lesssim \mathcal{C} \mathcal{K}_f + \epsilon \mathcal{C} \mathcal{K}_{\varphi^{\delta}},$$

where

We give the following remark, related to the operator A.

**Remark 6.5.** Let  $\ell = k - l$  and  $\zeta = \xi - \eta$ , then (1) if  $\ell \neq 0$ ,  $k \neq 0$ , and  $l \neq 0$ , then

$$\begin{split} \mathbf{A}_{k}(\xi) \lesssim &\mathbf{A}_{l}(\eta) e^{c\lambda|\ell,\zeta|^{s}} \Big( 1 + \frac{|\xi|}{k^{2} + (\xi - kt)^{2}} \mathbf{1}_{t \in \mathbf{I}_{k,\xi} \cap \mathbf{I}_{k,\eta}} \mathbf{1}_{c|\xi| \leq |\eta| \leq \frac{1}{c} |\xi|} \Big) \mathbf{1}_{\mathrm{LH}} \\ &+ \mathbf{A}_{\ell}(\zeta) e^{c\lambda|l,\eta|^{s}} \Big( 1 + \frac{|\xi|}{k^{2} + (\xi - kt)^{2}} \mathbf{1}_{t \in \mathbf{I}_{k,\xi} \cap \mathbf{I}_{k,\zeta}} \mathbf{1}_{c|\xi| \leq |\zeta| \leq \frac{1}{c} |\xi|} \Big) \mathbf{1}_{\mathrm{HL}} \\ &+ e^{c\lambda|l,\eta|^{s}} e^{c\lambda|\ell,\xi|^{s}} \langle l,\eta \rangle^{\sigma/2+1} \langle \ell,\xi \rangle^{\sigma/2+1} \mathbf{1}_{\mathrm{HH}}, \end{split}$$

(2) if  $\ell = 0$  and  $k \neq 0$ , then

$$\begin{aligned} \mathbf{A}_{k}(\xi) \lesssim &\mathbf{A}_{k}(\eta) e^{c\lambda|\zeta|^{s}} \mathbf{1}_{\mathrm{LH}} + \mathbf{A}^{\mathrm{R}}(\zeta) e^{c\lambda|k,\eta|^{s}} \mathbf{1}_{\mathrm{HL}} \\ &+ e^{c\lambda|k,\eta|^{s}} e^{c\lambda|\xi|^{s}} \langle k,\eta \rangle^{\sigma/2+1} \langle \xi \rangle^{\sigma/2+1} \mathbf{1}_{\mathrm{HH}} \end{aligned}$$

 $\textit{where } \operatorname{LH} = \{4|\ell, \zeta| \leq |l,\eta|\}, \ \operatorname{HL} = \{|\ell,\zeta| \geq 4|l,\eta|\}, \ \textit{and } \operatorname{HH} = \{\frac{1}{4}|\ell,\zeta| \leq |l,\eta| \leq 4|\ell,\zeta|\}.$ 

6.1. Energy functionals. Now we define the energy functionals:

$$\begin{split} \mathcal{E}_{f} &= \sum_{k \in \mathbb{Z}} \int_{\mathbb{R}} |\mathbf{A}_{k}(t,\eta) \widehat{f}_{k}(t,\eta)|^{2} d\eta, \quad \mathcal{C}\mathcal{K}_{f} = \sum_{k \in \mathbb{Z}} \int_{\mathbb{R}} |\dot{\mathbf{A}}_{k}(t,\eta)| \mathbf{A}_{k}(t,\eta)| \widehat{f}_{k}(t,\eta)|^{2} d\eta, \\ \mathcal{E}_{a} &= \sum_{k \in \mathbb{Z}} \int_{\mathbb{R}} |\mathbf{A}_{k}^{*}(t,\eta) \widehat{f}_{k}(t,\eta)|^{2} d\eta, \quad \mathcal{C}\mathcal{K}_{a} = \sum_{k \in \mathbb{Z}} \int_{\mathbb{R}} |\dot{\mathbf{A}}_{k}^{*}(t,\eta)| \mathbf{A}_{k}^{*}(t,\eta)| \widehat{f}_{k}(t,\eta)|^{2} d\eta, \\ \mathcal{E}_{h} &= \int_{\mathbb{R}} |\mathbf{A}^{\mathrm{R}}(t,\eta) \widehat{h}(t,\eta)|^{2} d\eta, \quad \mathcal{C}\mathcal{K}_{h} = \int_{\mathbb{R}} |\dot{\mathbf{A}}^{\mathrm{R}}(t,\eta)| \mathbf{A}^{\mathrm{R}}(t,\eta)| \widehat{h}(t,\eta)|^{2} d\eta \\ \mathcal{E}_{\bar{h}} &= \int_{\mathbb{R}} \frac{\langle t \rangle^{2+2s}}{\langle \eta \rangle^{2s}} |\mathbf{A}_{0}(t,\eta)| (\underline{\partial_{y} v \partial_{v} \underline{\partial_{t} v}})(t,\eta)|^{2} d\eta, \\ \mathcal{C}\mathcal{K}_{\bar{h}} &= \int_{\mathbb{R}} \frac{\langle t \rangle^{2+2s}}{\langle \eta \rangle^{2s}} |\dot{\mathbf{A}}_{0}(t,\eta)| \mathbf{A}_{0}(t,\eta)| (\underline{\partial_{y} v \partial_{v} \underline{\partial_{t} v}})(t,\eta)|^{2} d\eta, \\ \mathcal{E}_{\varphi_{j}^{\delta}} &= \int_{\mathbb{R}} |\mathbf{A}^{\mathrm{R}}(t,\eta) \widehat{\varphi_{j}^{\delta}}(t,\eta)|^{2} d\eta, \quad \mathcal{C}\mathcal{K}_{\varphi_{j}^{\delta}} &= \int_{\mathbb{R}} \dot{\mathbf{A}}^{\mathrm{R}}(t,\eta) \mathbf{A}^{\mathrm{R}}(t,\eta) |\widehat{\varphi_{j}^{\delta}}(t,\eta)|^{2} d\eta, \quad j = 1, 2, ..., 11. \end{split}$$

We also introduce an assistant functional:

$$\mathcal{E}_{\underline{\partial}t\underline{v}} = \int_{\mathbb{R}} \langle t \rangle^{4-\mathrm{K}_{\mathrm{D}}\epsilon} e^{2\lambda(t)\langle\eta\rangle^{s}} \langle\eta\rangle^{2\sigma-12} |\underline{\widehat{\partial}_{t}\underline{v}}(t,\eta)|^{2} d\eta.$$

We define the total energy functional

$$\mathcal{E}(t) = \mathcal{E}_f + \frac{1}{\mathrm{K}_a} \mathcal{E}_a + \mathcal{E}_{\bar{h}} + \mathcal{E}_{\underline{\partial}_t v} + \frac{1}{\mathrm{K}_v} \Big( \sum_{j=1}^{11} \mathcal{E}_{\varphi_j^{\delta}} \Big)$$

where  $K_D \geq 1$ ,  $K_a \geq 1$  and  $K_v \geq 1$  are large constants determined in the proof. Indeed,  $K_D$  depends on  $s, \lambda, \lambda'$ ,  $K_a$  is mainly determined by the constant  $C_{\varepsilon_0}$  in Proposition 7.14 and  $K_v$  is mainly determined by the Gevrey norms of  $\widetilde{\varphi_j}$  and  $\widetilde{\theta}$ .

6.2. Determine  $k_M$ . In this section, we explain why the constant  $k_M$  is determined as it is in Remark 5.1. We define

(6.10) 
$$I_{f,5}^{L} \stackrel{\text{def}}{=} \frac{1}{2\pi} \sum_{|k| \ge k_{M}} \int_{\mathbb{R}} \mathcal{A}_{k}(t,\eta)^{2} \left( \widehat{\varphi_{1}} \partial_{z} \mathring{\mathcal{T}}_{1,D}^{-1}(\Omega) \right)_{k}(t,\eta) \overline{\widehat{\Omega}_{k}(t,\eta)} d\eta.$$

This is the linear part of  $I_{f,5}$  which is defined in (7.1). We have the following Lemma.

**Lemma 6.6.** It holds for all  $k_M \ge 1$  that

(6.11) 
$$|I_{f,5}^L| \leq \frac{C_{\varphi_1}}{\langle t \rangle^2} ||\mathbf{A}P_{|k| \geq k_M} f||_{L^2}^2 + \frac{C_0 C_{ell} C_{\varphi_1}}{k_M} \mathcal{C}\mathcal{K}_f$$

Here both  $C_{ell} > 1$  and  $C_{\varphi_1} > 1$  are constants only depending on the background flow and density. More precisely, the constant  $C_{ell}$  is from Proposition C.9, and the constant  $C_{\varphi_1}$  is given by the Gevrey norm of  $\tilde{\varphi_1}$ .

*Proof.* We have

$$\begin{split} I_{f,5}^{L} &= \frac{1}{2\pi} \sum_{|k| \ge k_{M}} \int_{|\eta - \xi| \ge 8|k,\xi|} \mathcal{A}_{k}(t,\eta)^{2} \Big(\widehat{\widetilde{\varphi_{1}}}(\eta - \xi)ik\widehat{\mathcal{T}_{1,D}^{-1}(\Omega)}_{k}(t,\xi)\Big) \overline{\widehat{\Omega}_{k}(t,\eta)} d\xi d\eta \\ &+ \frac{1}{2\pi} \sum_{|k| \ge k_{M}} \int_{|\eta - \xi| \le \frac{1}{8}|k,\xi|} \mathcal{A}_{k}(t,\eta)^{2} \Big(\widehat{\widetilde{\varphi_{1}}}(\eta - \xi)ik\widehat{\mathcal{T}_{1,D}^{-1}(\Omega)}_{k}(t,\xi)\Big) \overline{\widehat{\Omega}_{k}(t,\eta)} d\xi d\eta \end{split}$$

$$+ \frac{1}{2\pi} \sum_{|k| \ge k_M} \int_{\frac{1}{8}|k,\xi| \le |\eta-\xi| \le 8|k,\xi|} \mathcal{A}_k(t,\eta)^2 \Big(\widehat{\widetilde{\varphi_1}}(\eta-\xi)ik\widehat{\mathcal{T}_{1,D}^{-1}(\Omega)}_k(t,\xi)\Big) \widehat{\Omega}_k(t,\eta) d\xi d\eta$$

$$= I_{f,5}^{L,HL} + I_{f,5}^{L,LH} + I_{f,5}^{L,HH}.$$

On the support of the integrand of  $I_{f,5}^{L,HL}$ , we have

$$A_k(t,\eta) \le A^R(t,\eta-\xi)e^{c\lambda\langle k,\xi\rangle^s},$$

which implies that

$$\begin{split} |I_{f,5}^{L,HL}| &\leq C \|\mathbf{A}^{\mathbf{R}}\widetilde{\varphi_{1}}\|_{L^{2}} \|P_{|k|\geq k_{M}} \mathring{\mathcal{T}}_{1,D}^{-1}(\Omega)\|_{\mathcal{G}^{s,\lambda,4}} \|\mathbf{A}P_{|k|\geq k_{M}}\Omega\|_{L^{2}} \\ &\leq C_{ell} \langle t \rangle^{2} \|\mathbf{A}^{\mathbf{R}}\widetilde{\varphi_{1}}\|_{L^{2}} \|P_{|k|\geq k_{M}}f\|_{\mathcal{G}^{s,\lambda,6}} \|\mathbf{A}P_{|k|\geq k_{M}}f\|_{L^{2}}. \end{split}$$

Here we use Proposition C.9

$$\begin{split} &\sum_{|k|\geq k_M} \|\langle k,\xi\rangle^4 e^{c\lambda\langle k,\xi\rangle^s} \widehat{\mathcal{T}_{1,D}(\Omega)}_k(t,\xi)\|_{L^2}^2 \\ &= \sum_{|k|\geq k_M} \left\|\langle k,\xi\rangle^4 e^{c\lambda\langle k,\xi\rangle^s} \int \mathcal{G}_{D,1}(t,k,\xi,\eta)\widehat{\Omega}_k(t,\eta)d\eta\right\|_{L^2}^2 \\ &\leq \sum_{|k|\geq k_M} \left\|\int \frac{e^{\lambda\langle k,\xi-\eta\rangle^s} e^{-\lambda_\Delta\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2} \langle k,\eta\rangle^4 e^{c\lambda\langle k,\eta\rangle^s} \widehat{\Omega}_k(t,\eta)d\eta\right\|_{L^2}^2 \\ &\leq \sum_{|k|\geq k_M} \left\|\int \frac{e^{-\frac{1}{2}\lambda_\Delta\langle\xi-\eta\rangle^s}}{\langle t\rangle^2} \langle k,\eta\rangle^6 e^{c\lambda\langle k,\eta\rangle^s} \widehat{\Omega}_k(t,\eta)d\eta\right\|_{L^2}^2 \leq \langle t\rangle^{-4} C_{ell} \|P_{|k|\geq k_M} f\|_{\mathcal{G}^{s,\lambda,6}}^2. \end{split}$$

A similar argument gives that

$$|I_{f,5}^{L,HH}| \leq C_{ell} \langle t \rangle^2 \| \mathbf{A}^{\mathbf{R}} \widetilde{\varphi_1} \|_{L^2} \| \mathbf{A} P_{|k| \geq k_M} f \|_{L^2}^2.$$

To estimate  $|I_{f,5}^{L,LH}|$ , we have by Proposition C.9 that,

$$\begin{split} |I_{f,5}^{L,LH}| &= \left| \frac{1}{2\pi} \sum_{|k| \ge k_M} \int_{|\eta - \xi| \le \frac{1}{8} |k,\xi|} \mathcal{A}_k(t,\eta)^2 \Big( \widehat{\widetilde{\varphi_1}}(\eta - \xi) ik \mathcal{G}_{D,1}(t,\xi,\zeta) \widehat{\Omega}_k(\zeta) \Big) \overline{\widehat{\Omega}_k(t,\eta)} d\zeta d\xi d\eta \right| \\ &\leq C_{ell} \sum_{|k| \ge k_M} \left| \int_{|\eta - \xi| \le \frac{1}{8} |k,\xi|} \mathcal{A}_k(t,\eta)^2 \Big( e^{-\lambda_{u,\theta} \langle \eta - \xi \rangle^s} \frac{|k| e^{-\lambda_\Delta \langle \zeta - \xi \rangle^s}}{k^2 + (\zeta - kt)^2} \widehat{\Omega}_k(\zeta) \Big) \overline{\widehat{\Omega}_k(t,\eta)} d\zeta d\xi d\eta \right| \\ &\leq C_{ell} C_{\varphi_1} \sum_{|k| \ge k_M} \left| \int_{|\eta - \xi| \le \frac{1}{8} |k,\xi|} \Big( e^{-\frac{3}{4} \lambda_{u,\theta} \langle \eta - \xi \rangle^s} \frac{|k| e^{-\frac{3}{4} \lambda_\Delta \langle \zeta - \xi \rangle^s}}{k^2 + (\zeta - kt)^2} \widehat{\Omega}_k(\zeta) \Big) \overline{\widehat{\Omega}_k(t,\eta)} d\zeta d\xi d\eta \right| \end{split}$$

It is easy to check that for  $k \ge k_M$ 

$$\frac{1}{k^2 + (\zeta - kt)^2} \lesssim \frac{1}{k_M} \sqrt{\frac{\dot{\mathbf{A}}_k(t,\eta)}{\mathbf{A}_k(t,\eta)}} \sqrt{\frac{\dot{\mathbf{A}}_k(t,\zeta)}{\mathbf{A}_k(t,\zeta)}} \langle \zeta - \xi, \eta - \xi \rangle^3$$

which implies that there is a universal constant  $C_0$  such that

$$|I_{f,5}^{L,LH}| \le \frac{C_0 C_{ell} C_{\varphi_1}}{k_M} \mathcal{C}\mathcal{K}_f.$$

Thus we obtain (6.11) and finish the proof.

One can regard  $k_M$  as the threshold after which we no longer need to apply the wave operator.

6.3. The bootstrap argument. The local wellposedness of the inhomogeneous incompressible Euler equation in the Gevrey class is classical. In this way, we may safely ignore the time interval [0, 1] by further restricting the size of the initial data.

The goal is next to prove by a continuity argument that this energy  $\mathcal{E}(t)$  (together with some related quantities) is uniformly bounded for all time if  $\epsilon$  is sufficiently small.

We define the following controls referred to in the sequel as the bootstrap hypotheses for  $t \ge 1$ and some constant  $C(k_M)$ ,

(B1) 
$$\mathcal{E}(t) < 10C(k_M)\epsilon^2$$
;

(B2) Compact support of  $\Omega$  and a:

$$\operatorname{supp} \Omega \subset \left[ 2.5\kappa_0 - 10C(k_M)\epsilon, 1 - 2.5\kappa_0 + 10C(k_M)\epsilon \right],$$
$$\operatorname{supp} a \subset \left[ 2.5\kappa_0 - 10C(k_M)\epsilon, 1 - 2.5\kappa_0 + 10C(k_M)\epsilon \right];$$

(B3) 'CK' integral estimates

$$\int_{1}^{t} \left[ \mathcal{C}\mathcal{K}_{f} + \frac{1}{\mathbf{K}_{a}} \mathcal{C}\mathcal{K}_{a} + \mathcal{C}\mathcal{K}_{\bar{h}} + \mathcal{C}\mathcal{K}_{\underline{\partial}_{t}v} + \frac{1}{\mathbf{K}_{v}} \Big( \sum_{j=1}^{11} \mathcal{C}\mathcal{K}_{\varphi_{j}^{\delta}} \Big) \right] d\tau \leq 20C(k_{M})\epsilon^{2},$$

**Proposition 6.7** (Bootstrap). Let  $k_M$  satisfy (5.2). There exists an  $\epsilon_0 \in (0, \frac{1}{2})$  depending only on  $k_M$ ,  $\lambda_0$ ,  $\lambda'$ , s and  $\sigma$  such that if  $\epsilon < \epsilon_0$  and on  $[1, T^*]$  the bootstrap hypotheses (B1)-(B3) hold, then for  $\forall t \in [1, T^*]$ ,

- 1.  $\mathcal{E}(t) \leq 8C(k_M)\epsilon^2$ ,
- 2. Compact support of  $\Omega$  and a:

$$\operatorname{supp} \Omega \subset \left[ 2.5\kappa_0 - 8C(k_M)\epsilon, 1 - 2.5\kappa_0 + 8C(k_M)\epsilon \right],$$
$$\operatorname{supp} a \subset \left[ 2.5\kappa_0 - 8C(k_M)\epsilon, 1 - 2.5\kappa_0 + 8C(k_M)\epsilon \right];$$

3. and the CK controls satisfy:

$$\int_{1}^{t} \left[ \mathcal{C}\mathcal{K}_{f} + \frac{1}{\mathbf{K}_{a}} \mathcal{C}\mathcal{K}_{a} + \mathcal{C}\mathcal{K}_{\bar{h}} + \mathcal{C}\mathcal{K}_{\underline{\partial}_{\underline{t}}\underline{v}} + \frac{1}{\mathbf{K}_{v}} \Big( \sum_{j=1}^{11} \mathcal{C}\mathcal{K}_{\varphi_{j}^{\delta}} \Big) \right] d\tau \leq 18C(k_{M})\epsilon^{2},$$

from which it follows that  $T^* = +\infty$ .

The remainder of this paper is devoted to the proof of Proposition 6.7.

## 7. Energy estimate

7.1. Energy estimate for  $\mathcal{E}_f$ . A direct calculation gives

$$\begin{split} &\frac{1}{2}\frac{d}{dt}\mathcal{E}_{f} + \mathcal{C}\mathcal{K}_{f} \\ &= -\frac{1}{2\pi}\sum_{k=0, \, |k| \ge k_{M}} \int_{\mathbb{R}} \mathcal{A}_{k}(t,\eta)^{2} (\widehat{\Upsilon_{2}U \cdot \nabla_{z,v}\Omega})_{k}(t,\eta) \overline{\widehat{\Omega}_{k}(t,\eta)} d\eta \\ &\quad -\frac{1}{2\pi}\sum_{0<|k|< k_{M}} \int_{\mathbb{R}} \mathcal{A}_{k}(t,\eta)^{2} \mathcal{F}_{2} \Big( \mathbf{D}_{u,k} \left( \mathcal{F}_{1} \Big( \mathbf{U} \cdot \nabla_{z,v}\Omega \Big) \right) \Big)_{k}(t,\eta) \overline{\widehat{f}_{k}(t,\eta)} d\eta \end{split}$$

$$-\frac{1}{2\pi} \sum_{k=0, |k| \ge k_M} \int_{\mathbb{R}} A_k(t,\eta)^2 (\widehat{\mathcal{N}_{\Omega}[\Upsilon_2\Psi]})_k(t,\eta) \overline{\widehat{\Omega}_k(t,\eta)} d\eta -\frac{1}{2\pi} \sum_{k=0, |k| \ge k_M} \int_{\mathbb{R}} A_k(t,\eta)^2 (\widehat{\mathcal{N}_a[\Pi]})_k(t,\eta) \overline{\widehat{\Omega}_k(t,\eta)} d\eta +\frac{1}{2\pi} \sum_{|k| \ge k_M} \int_{\mathbb{R}} A_k(t,\eta)^2 (\underline{\varphi_1} \widehat{\partial_z(\Upsilon_2\Psi)})_k(t,\eta) \overline{\widehat{\Omega}_k(t,\eta)} d\eta +\frac{1}{2\pi} \sum_{0 < |k| < k_M} \int_{\mathbb{R}} A_k(t,\eta)^2 \mathcal{F}_2 \Big( \mathbf{D}_{u,k} \left( \mathcal{F}_1 \Big( \varphi_1^{\delta} \partial_z(\Upsilon_2\Psi) - \widetilde{\varphi_1} \partial_z \big(\mathring{\mathcal{T}}_{1,D}^{-1}[\Omega] - \Upsilon_2\Psi \big) \Big) \Big) \Big)_k(t,\eta) \overline{\widehat{f}_k(t,\eta)} d\eta -\frac{1}{2\pi} \sum_{0 < |k| < k_M} \int_{\mathbb{R}} A_k(t,\eta)^2 \mathcal{F}_2 \Big( \mathbf{D}_{u,k} \left( \mathcal{F}_1 \Big( \mathcal{N}_\Omega[\Psi] \Big) \Big) \Big)_k(t,\eta) \overline{\widehat{f}_k(t,\eta)} d\eta$$

$$(7.1) -\frac{1}{2\pi} \sum_{0 < |k| < k_M} \int_{\mathbb{R}} A_k(t,\eta)^2 \Big( \mathbf{D} \widehat{(\mathcal{N}_a[\Pi])} \big)_k(t,\eta) \overline{\widehat{f}_k(t,\eta)} d\eta = \sum_{j=1}^8 I_{f,j}.$$

We first treat  $I_{f,2}$ . The main idea is to recover the transport structure together with  $I_{f,1}$ . A usual way to recover the transport structure  $U \cdot \nabla_{z,v} D\Omega$  is to study the commutator

$$[D, \mathbf{U} \cdot \nabla_{z,v}]\Omega.$$

However, it is not good here, because the commutator will mix the information of different frequencies in z. The new idea is to use an important identity (4.20), which formally is that

(7.2) 
$$\int D(f)D^{1}(g)dzdv = \int fgdzdv,$$

where  $D^1 = (D^{-1})^*$  (see (4.4) for more details). More precisely, we need to control the following term

$$\int \mathbf{A} D(\mathbf{U} \cdot \nabla_{z,v} \Omega) \mathbf{A} D(\Omega) dz dv.$$

The idea is to remove the wave operator D using (7.2) and recover the transport structure:

$$\begin{split} &\int \mathcal{A}D(\mathcal{U}\cdot\nabla_{z,v}\Omega)\mathcal{A}D(\Omega)dzdv\\ &=\int \mathcal{A}(\mathcal{U}\cdot\nabla_{z,v}\Omega)\mathcal{A}(\Omega)dzdv + \int [\mathcal{A},D^{1}](\mathcal{U}\cdot\nabla_{z,v}\Omega)D\mathcal{A}(\Omega)dzdv\\ &+\int \mathcal{A}D^{1}(\mathcal{U}\cdot\nabla_{z,v}\Omega)[\mathcal{A},D](\Omega)dzdv + \int \mathcal{A}(D-D^{1})(\mathcal{U}\cdot\nabla_{z,v}\Omega)\mathcal{A}D(\Omega)dzdv. \end{split}$$

With the previous brief idea in mind, now we present a precise calculation.

For  $0 < |k| < k_M$ , let

The proposition is proved in section 11.

Note that although the wave operator in this paper is new, we still have the same estimates of the Fourier kernels of  $\mathbf{D}_{u,k}$ ,  $\mathbf{D}_{u,k}^1$ , and  $\tilde{\chi}_2 \mathbf{D}_{u,k} - \tilde{\chi}_2 \mathbf{D}_{u,k}^1$  as that in [28], see Proposition 4.11 and Proposition 4.12. Thus, the commutator term  $I_{f,2}^{com}$  which involves the wave operator can be treated in the same way as [28].

We refer to the estimate of  $\Pi^{com}$  term in [28] for the proof and more details.

The last term in the previous two propositions will be controlled by the elliptic estimate.

The constant  $C_{ell}$  is the same constant in Lemma 6.6. Generally, it holds that

The basic idea of proving this proposition is to control the elliptic error terms, which is similar to previous papers [5, 28]. However, a new Fourier analysis of the Green function is required, which is given in Appendix C. The proof of this proposition is given in section 8.

The term  $I_{f,3}$  and  $I_{f,7}$  are arose from introducing the good unknown  $\tilde{\omega}$ . They are lower-order terms since there is no derivative loss. They are also different from the nonlocal error term  $I_{f,6}^1$  or nonlocal small term  $I_{f,7}$  that will be discussed later. In  $I_{f,3}$  and  $I_{f,7}$ , the function  $\partial_z(\Upsilon_2\Psi)$  interacts with the nonzero modes.

The term  $I_{f,6}$  contains two terms

The first term  $I_{f,6}^1$  can be treated as the reaction term, which is similar to  $\Pi^{u'',\epsilon_1}$  term in [28]. The second term  $I_{f,6}^2$  is relate to the elliptic error term  $\mathcal{T}_{1,D}^{-1}[\mathcal{S}_1[\Psi]]$  (see (8.5)), which is similar to  $\Pi^{u'',\epsilon_2}$  term in [28].

Proposition 7.5. Under the bootstrap hypotheses,

The terms  $I_{f,5}$  have the same structure and can be treated in the same way. Indeed,  $I_{f,5}$  is similar to the term  $\Pi^{u''}$  in [28]. The key observation for this term is as follows:

- 1. we can treat it as the reaction term;
- 2. we can get an extra smallness if  $|k| \ge k_M$  with  $k_M$  sufficiently large.

$$|I_{f,\mathrm{LH}}^{5;\mathrm{R,R}}| \leq \frac{C_0/10}{k_M} \|\underline{\varphi}_1\|_{\mathcal{G}^{s,\lambda,\sigma-6}} \left\| \sqrt{\frac{\partial_t w}{w}} \tilde{\mathrm{A}}f \right\|_2^2 + \frac{C_0/10}{k_M} \|\underline{\varphi}_1\|_{\mathcal{G}^{s,\lambda,\sigma-6}} \left\| \sqrt{\frac{\partial_t w}{w}} \Delta_L \tilde{\mathrm{A}}P_{|k|\geq k_M} 1_{\mathrm{R}}(\Psi\Upsilon) \right\|_2^2.$$

Here  $C_0 > 1$  is a universal constant. By combining all the above estimates and using the bootstrap assumptions, we obtain the proposition. One may refer to the proof of  $\Pi^{u''}$  in [28] for more details. Indeed, the linear part of  $I_{f,5}$  is treated

in Lemma 6.6, which is used to determine the  $k_M$  before the bootstrap argument. 

Now we control the pressure. We first estimate the zero mode.

Proposition 7.8. Under the bootstrap hypotheses,

$$\left\| t(t^2 + |\partial_v|^2)(2 - \partial_v^2)^{-1} \mathbf{A}_0 P_0(\partial_v(\Pi \Upsilon_1)) \right\|_2 \lesssim \epsilon$$

and

$$\left\| t(t^{2} + |\partial_{v}|^{2})(2 - \partial_{v}^{2})^{-1} \left( \sqrt{\frac{\partial_{t}w}{w}} + \frac{\langle \partial_{v} \rangle^{\frac{s}{2}}}{\langle t \rangle^{s}} \right) \mathbf{A}_{0} P_{0} \left( \partial_{v} (\Pi \Upsilon_{1}) \right) \right\|_{2}^{2}$$

$$\lesssim \frac{\epsilon^{4}}{\langle t \rangle^{2s}} + \epsilon^{2} \mathcal{C} \mathcal{K}_{a} + \epsilon^{2} \mathcal{C} \mathcal{K}_{\varphi_{4}^{\delta}}$$

$$+ \epsilon^{2} \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{\neq} (\Psi \Upsilon) \right\|_{2}^{2}$$

Proposition 7.8 is proved in section 9.

The estimates of the non-zero modes of pressure are highly non-trivial.

**Proposition 7.9.** Under the bootstrap hypotheses,

$$\left\| \langle \partial_z \rangle t(t + \langle \nabla \rangle) (1 - \Delta)^{-1} \left( (\partial_v - t \partial_z)^2 + \partial_z^2 \right) \mathrm{A} P_{\neq} \Pi_\star \right\|_2 \lesssim \epsilon$$

and

$$\begin{split} & \left\| \langle \partial_z \rangle t(t + \langle \nabla \rangle) (1 - \Delta)^{-1} \left( (\partial_v - t \partial_z)^2 + \partial_z^2 \right) \left( \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \mathbf{A} + \sqrt{\frac{\partial_t w}{w}} \tilde{\mathbf{A}} \right) P_{\neq} \Pi_{\star} \right\|_2 \\ & \lesssim \epsilon^2 \Big( \frac{1}{\langle t \rangle^s} + \mathcal{C} \mathcal{K}_{\varphi_6^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_8^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_9^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{a}^{\frac{1}{2}} \Big) \\ & + \epsilon \left\| \left\langle \frac{\partial_v}{t \partial_z} \right\rangle^{-1} (\partial_z^2 + (\partial_v - t \partial_z)^2) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^s} \mathbf{A} + \sqrt{\frac{\partial_t w}{w}} \tilde{\mathbf{A}} \right) P_{\neq} (\Psi \Upsilon_2) \right\|_2 \\ & + \epsilon \left\| t (t^2 + |\partial_v|^2) (2 - \partial_v^2)^{-1} \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \partial_v \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) \mathbf{A}_0 P_0 \big( \partial_v (\Pi \Upsilon_1) \big) \right\|_2^2, \end{split}$$

where  $\Pi_{\star} \in {\Upsilon_2 \Pi_{l,1}, \Upsilon_1 \Pi_{l,2}}.$ 

Proposition 7.10. Under the bootstrap hypotheses,

$$\left| \langle \partial_z \rangle t(t + \langle \nabla \rangle) (1 - \Delta)^{-1} \left( (\partial_v - t \partial_z)^2 + \partial_z^2 \right) \mathcal{A} P_{\neq} \Pi_{\star} \right\|_2 \lesssim \epsilon^2$$

and

$$\begin{split} \left\| \langle \partial_{z} \rangle t(t + \langle \nabla \rangle) (1 - \Delta)^{-1} \left( (\partial_{v} - t \partial_{z})^{2} + \partial_{z}^{2} \right) \left( \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t} w}{w}} \tilde{\mathbf{A}} \right) P_{\neq} \Pi_{\star} \right\|_{2} \\ \lesssim \epsilon \mathcal{C} \mathcal{K}_{f}^{\frac{1}{2}} + \epsilon^{2} \left( \frac{1}{\langle t \rangle^{s}} + \mathcal{C} \mathcal{K}_{\varphi_{4}^{\frac{1}{4}}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{6}^{\frac{1}{5}}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{6}^{\frac{1}{5}}}^{\frac{1}{5}} + \mathcal{C} \mathcal{K}_{\varphi_{6}^$$

where  $\Pi_{\star} \in {\Upsilon_2 \Pi_{n,1}, \Upsilon_1 \Pi_{n,2}}.$ 

There are four key ideas in estimates: 1, the pressure decomposition in section 2 ensures the Fourier analysis works in the problem; 2, the new Fourier analysis of the Green function associated with the linearized equation is given in Appendix C; 3, the well-designed weights B,  $\mathcal{M}_3$ ,  $\mathcal{M}_4$ , and

.

 $\mathcal{M}_5$  from [11] help control the elliptic error terms easily; 4, the iteration method helps us gain back the derivative loss in the equation of  $\Pi_{l,2}$  and  $\Pi_{n,2}$ , see section 10 for more details. These two propositions are proved in section 10.

As a direct corollary, we have the point-wise decay estimate for the pressure.

Corollary 7.11. Under the bootstrap hypotheses,

$$\|\partial_v P_0(\Upsilon_2\Pi)\|_{\mathcal{G}^{s,\sigma-6}} \lesssim \frac{\epsilon}{\langle t \rangle^3}$$

and

$$\|P_{\neq}(\Pi_{\star})\|_{\mathcal{G}^{s,\sigma-6}} \lesssim rac{\epsilon}{\langle t \rangle^4},$$

where  $\Pi_{\star} \in {\Upsilon_2 \Pi_{l,1}, \Upsilon_2 \Pi_{n,1}, \Upsilon_1 \Pi_{l,2}, \Upsilon_1 \Pi_{n,2}}.$ 

The terms  $I_{f,4}$  and  $I_{f,8}$  are new, which are the interactions between the density a and the pressure  $\Pi$ . If the pressure is in higher frequencies, these terms behave as the Reaction term in [5]. If the density a is in higher frequencies, there is a derivative loss. So we need the multiplier B to gain half derivative. We have the following proposition for the estimates.

Proposition 7.12. Under the bootstrap hypotheses,

$$\begin{split} |I_{f,4}| + |I_{f,8}| \lesssim &\frac{\epsilon^3}{\langle t \rangle^3} + \epsilon \mathcal{C}\mathcal{K}_f + \epsilon \mathcal{C}\mathcal{K}_a \\ &+ \epsilon \left\| t(t^2 + |\partial_v|^2)(2 - \partial_v^2)^{-1} \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \partial_v \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) \mathcal{A}_0 P_0 \big( \partial_v (\Pi \Upsilon_1) \big) \right\|_2^2 \\ &+ \epsilon \left\| \langle \partial_z \rangle t(t + \langle \nabla \rangle)(1 - \Delta)^{-1} \big( (\partial_v - t \partial_z)^2 + \partial_z^2 \big) \left( \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \mathcal{A} + \sqrt{\frac{\partial_t w}{w}} \tilde{\mathcal{A}} \right) P_{\neq} \Pi_{\star} \right\|_2^2. \end{split}$$

where  $\Pi_{\star} = \Upsilon_2 \Pi_{l,1} + \Upsilon_2 \Pi_{n,1} + \Upsilon_1 \Pi_{l,2} + \Upsilon_1 \Pi_{n,2}$ .

The proposition is proved in section 14.

7.2. Energy estimate of  $\mathcal{E}_a$ . A direct calculation gives

$$\frac{1}{2}\frac{d}{dt}\mathcal{E}_{a} + \mathcal{C}\mathcal{K}_{a} = -\int \mathbf{A}^{*}a\mathbf{A}^{*}\left(\Upsilon_{2}\mathbf{U}\cdot\nabla_{z,v}a\right)dzdv - \int \mathbf{A}^{*}a\mathbf{A}^{*}\left(\underline{\theta'}\partial_{z}(\Upsilon_{2}\Psi)\right)dzdv$$
$$\stackrel{\text{def}}{=}I_{a}^{tr} + I_{a}^{l}.$$

We have the following proposition for the estimate of  $I_a^{tr}$ .

**Proposition 7.13.** Under the bootstrap hypotheses,

(7.8) 
$$|I_a^{tr}| \lesssim \epsilon \mathcal{C} \mathcal{K}_a + \epsilon^2 \mathcal{C} \mathcal{K}_h + \epsilon^2 \mathcal{C} \mathcal{K}_{\varphi_9^\delta} + \frac{\epsilon^3}{\langle t \rangle^{2-\mathrm{K}_{\mathrm{D}}\epsilon/2}} + \epsilon \left\| \left\langle \frac{\partial_v}{t\partial_z} \right\rangle^{-1} (\partial_z^2 + (\partial_v - t\partial_z)^2) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^s} \mathrm{A} + \sqrt{\frac{\partial_t w}{w}} \tilde{\mathrm{A}} \right) P_{\neq}(\Psi \Upsilon_2) \right\|_2.$$

The proposition is proved in section 11.

The linear term force  $I_a^l$  is new because of the non-constant background density  $\theta$ . However, it is  $U^y \partial_y \theta$  which can be regarded as the Reaction term  $\mathbf{R}^a_{\mathbf{N}}$  but without smallness.

**Proposition 7.14.** Under the bootstrap hypotheses,

$$\begin{split} |I_a^l| &\leq \frac{C\epsilon^2}{\langle t \rangle^2} + C\epsilon \mathcal{C}\mathcal{K}_{\varphi_{10}^{\tilde{\delta}}} + \varepsilon_0 \mathcal{C}\mathcal{K}_a \\ &+ C_{\varepsilon_0} \left\| \left\langle \frac{\partial_v}{t\partial_z} \right\rangle^{-1} (\partial_z^2 + (\partial_v - t\partial_z)^2) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^s} \mathbf{A} + \sqrt{\frac{\partial_t w}{w}} \tilde{\mathbf{A}} \right) P_{\neq}(\Psi \Upsilon_2) \right\|_2^2. \end{split}$$

The proposition is proved in section 13.

7.3. Energy estimates of the coordinate system and coefficients. The coordinate system is easy to control, which is similar to *Proposition 2.5* in [5].

**Proposition 7.15** (Coordinate system controls). Under the bootstrap hypotheses, for  $\epsilon$  sufficiently small and  $K_v$  sufficiently large there is a K > 0 such that

(7.9) 
$$\mathcal{E}_h + \frac{1}{4} \int_1^t \mathcal{C} \mathcal{K}_h(\tau) d\tau \le \frac{1}{2} \mathrm{K}_v \epsilon^2,$$

(7.10) 
$$\mathcal{E}_{\bar{h}} + \int_{1}^{\tau} \mathcal{C}\mathcal{K}_{\bar{h}}(\tau) + d\tau \leq C(k_{M})\epsilon^{2} + \mathbf{K}\epsilon^{3},$$

(7.11) 
$$\langle t \rangle^{4-\mathrm{K}_{\mathrm{D}}\epsilon} \|\underline{\partial}_{t}v\|_{\mathcal{G}^{s,\lambda(t),\sigma-6}}^{2} \leq C(k_{M})\epsilon^{2} + \mathrm{K}\epsilon^{3}$$

*Proof.* We use to the estimate of  $\underline{\omega}$  in Corollary 8.4 to control the term  $P_0(\partial_z(\Upsilon_2\Psi)\partial_v\underline{\omega}-\partial_v(\Upsilon_2\Psi)\partial_z\underline{\omega})$ . The term which involves  $P_0(\partial_z\Pi_l\partial_v a - \partial_v\Pi_l\partial_z a)$  and  $P_0(\partial_z\Pi_n\partial_v a - \partial_v\Pi_n\partial_z a)$  can be controlled by using the same idea of the proof of Proposition 7.12 in section 14.

**Proposition 7.16.** Under the bootstrap hypotheses, for  $\epsilon$  sufficiently small and  $K_v$  sufficiently large there is a K > 0 such that for j = 1, 2, ..., 11,

(7.12) 
$$\mathcal{E}_{\varphi_j^{\delta}} + \frac{1}{4} \int_1^t \mathcal{C} \mathcal{K}_{\varphi_j^{\delta}}(\tau) d\tau \leq \frac{1}{2} \mathrm{K}_v \epsilon^2.$$

The energy estimates for the coefficients  $\varphi_j^{\delta}$  (j=1,...,11) is easier than h. They have the same transport structure as the equation of h:

(7.13) 
$$(\partial_t + \underline{\partial_t v} \partial_v) \mathcal{U} = \mathcal{F},$$

where  $\mathcal{F}$  represents one of the forcing terms  $\underline{\partial_t v} \partial_v \widetilde{\varphi_j}$ . Due to the fact that  $\widetilde{\varphi_j}$  are smoother given functions compared to the solutions,  $\mathcal{F}$  has the same behavior as  $\underline{\partial_t v}$  which is better than the force term  $\overline{h} = \underline{\partial_y v} \partial_v \underline{\partial_t v}$  in the equation of h (5.5). By following the estimate of h in section 8.2 of [5], one can obtain the estimate of  $\mathcal{E}_{\varphi_i^{\delta}}(t)$  easily.

7.4. **Proof of the main theorem.** Now, we prove the compact support result in Proposition 6.7 and conclude the proof. Under the bootstrap assumption, we have

$$\Delta \psi(t, x, y) = \omega(t, x, y) = \underline{\omega}(t, x - tv(t, y), v(t, y)), \quad \psi(x, 0) = \psi(x, 1) = 0.$$

Taking the Fourier transform in x, we get

(7.14) 
$$\mathcal{F}_1\psi(t,k,y) = \int_0^1 G_k(y,z)\underline{\omega}(t,k,v(t,z))e^{-iktv(t,z)}dz$$

and

(7.15) 
$$\partial_y \mathcal{F}_1 \psi(t,k,y) = \int_0^1 \partial_y G_k(y,z) \underline{\omega}(t,k,v(t,z)) e^{-iktv(t,z)} dz,$$

where

$$G_k(y_1, y_2) = \frac{1}{k \sinh k} \times \begin{cases} \sinh(k(1-y_2)) \sinh ky_1, & y_1 \le y_2, \\ \sinh(ky_2) \sinh(k(1-y_1)), & y_1 \ge y_2, \end{cases}$$

and

$$G_0(y_1, y_2) = \begin{cases} (1 - y_2)y_1, & y_1 \le y_2, \\ y_2(1 - y_1), & y_1 \ge y_2, \end{cases}$$

Integrating by parts in z in the identities (7.14) (twice) and (7.15) (once), we get that

(7.16) 
$$|U^y(t,x,y)| \lesssim \frac{\epsilon}{\langle t \rangle^2}, \quad |U^x - \langle U^x \rangle| \lesssim \frac{\epsilon}{\langle t \rangle}.$$

Then let us define

$$\begin{cases} \frac{d(X^1, X^2)}{dt}(t, x, y) = (u(y) + U^x(t, X^1, X^2), U^y(t, X^1, X^2)), \\ (X^1, X^2)\big|_{t=0} = (x, y). \end{cases}$$

Then  $\frac{d}{dt}\omega(t, X^1, X^2) = (u''\partial_x\psi)(t, X_1, X_2)$  and  $|X^2(t, x, y) - y| \le C\epsilon$ , thus the for  $y \notin [4\kappa_0 - C\epsilon, 1 - 4\kappa_0 + C\epsilon]$ ,  $\frac{d}{dt}\omega(t, X^1, X^2) = 0$ . Note that we only need that u'' to be equal to 0 close to the boundary. Thus the support of  $\omega(t)$  will always be away from the boundary. 

This ends the proof of the bootstrap Proposition 6.7.

Let us now go back to the original coordinate system and prove Theorem 1.1. Applying the same method in section 2.4 of [5], we get for  $\omega_1(t, z, y) = \underline{\omega}(t, z, v) = \omega(t, x, y), P_1(t, z, y) = P(t, x, y) = P(t, x, y)$  $\Pi(t, z, v), d_1(t, z, y) = d(t, x, y) = a(t, z, v) \text{ and } \psi_1(t, z, y) = \Psi(t, z, v) = \psi(t, x, y),$ 

$$\partial_t \omega_1 + \nabla_{z,y}^{\perp} P_{\neq} \psi_1 \cdot \nabla_{z,y} \omega_1 - u'' \partial_z \psi_1 - \theta'(y) \partial_z P_1 + \partial_y P_1 \partial_z d_1 - \partial_z P_1 \partial_y a = 0,$$

and

$$\partial_t d_1 + \theta' \partial_z \psi_1 + \nabla_{z,y}^{\perp} P_{\neq} \psi_1 \cdot \nabla_{z,y} d_1 = 0$$

Then we can define

$$f_{\infty} = \omega_1(1) - \int_1^{\infty} \nabla_{z,y}^{\perp} P_{\neq} \psi_1(s) \cdot \nabla_{z,y} \omega_1(s) ds + \int_1^{\infty} u'' \partial_z \psi_1(s) ds + \int_1^{\infty} \theta'(y) \partial_z P_1(s) ds - \int_1^{\infty} \partial_y P_1 \partial_z d_1(s) ds + \int_1^{\infty} \partial_z P_1 \partial_y a(s) ds,$$

and

$$d_{\infty} = d_1(1) - \int_1^{\infty} \theta' \partial_z \psi_1(s) ds - \int_1^{\infty} \nabla_{z,y}^{\perp} P_{\neq} \psi_1 \cdot \nabla_{z,y} d_1(s) ds.$$

Therefore there exists  $f_{\infty}, d_{\infty}$  such that,

$$\begin{aligned} \|\omega(t, x + tu(y) + \Phi(t, y)\chi_1(y), y) - f_{\infty}(x, y)\|_{\mathcal{G}^{s,\lambda_{\infty}}} &\lesssim \frac{\epsilon}{\langle t \rangle} \\ \|d(t, x + tu(y) + \Phi(t, y)\chi_1(y), y) - d_{\infty}(x, y)\|_{\mathcal{G}^{s,\lambda_{\infty}}} &\lesssim \frac{\epsilon}{\langle t \rangle} \end{aligned}$$

Note that  $\omega(t, x, y) = 0$  for  $y \notin [2\kappa_0, 1 - 2\kappa_0]$  so is  $f_{\infty}$ , thus we can replace  $\Phi(t, y)\chi_1(y)$  by  $\Phi(t, y)$ which gives (1.4) and (1.5).

Now, we prove (1.7). We have

$$-\partial_y P_0(U^x) = P_0(\omega), \quad \partial_t P_0(U^x) + P_0(U^y \omega) = 0,$$

which implies that  $P_0(U^x)(t,y) = C_U$  for any  $t \ge 1$  and  $y \in [0, 2\kappa_0] \cup [1 - 2\kappa_0, 1]$ . Let  $\tilde{U}^x(t,z,y) = U^x(t,x,y)$ , then  $\left(P_0(\tilde{U}^x)(t,y) - C_U\right)$  has the same compact support as  $\omega_1$  and satisfies

$$\begin{aligned} \partial_t \Big( P_0(\tilde{U}^x)(t,y) - C_U \Big) &= -P_0(\nabla_{z,y}^{\perp} P_{\neq} \psi_1 \cdot \nabla_{z,y} \tilde{U}^x) \chi_1(y) \\ &= -P_0(-\partial_y P_{\neq}(\Upsilon_2 \psi_1) \partial_z (\partial_y - t \partial_y v \partial_z) (\Upsilon_2 \psi_1) + \partial_z P_{\neq}(\Upsilon_2 \psi_1) \partial_y \partial_z (\Upsilon_2 \psi_1)). \end{aligned}$$

Then (1.7) follows from the fact that

(7.17) 
$$\|\Upsilon_2\psi_1\|_{\mathcal{G}^{s,\lambda'_{\infty},2}} \lesssim \frac{\epsilon}{\langle t\rangle^2}.$$

This ends the proof of Theorem 1.1.

# 8. Elliptic estimate for steam function

In this section, we study the following elliptic equation

(8.1) 
$$\begin{cases} \underline{\varphi_4}\partial_{zz}\Psi + \underline{\partial_y v}(\partial_v - t\partial_z)\Big(\underline{\varphi_4}\underline{\partial_y v}(\partial_v - t\partial_z)\Psi\Big) = \Omega, \\ \Psi(t, z, u(0)) = \Psi(t, z, u(1)) = 0, \end{cases}$$

We rewrite the equation by separating its linear part and the nonlinear part.

$$\Omega = \underline{\varphi_4} \partial_{zz} \Psi + \underline{\partial_y v} (\partial_v - t\partial_z) \left( \underline{\varphi_4} \underline{\partial_y v} (\partial_v - t\partial_z) \Psi \right)$$

$$(8.2) \qquad = \mathcal{T}_1[\Psi] + \varphi_4^{\delta} \partial_{zz} \Psi + \underline{\partial_y v} (\partial_v - t\partial_z) \left( \underline{\varphi_4} (\underline{\partial_y v} - \widetilde{u'}) (\partial_v - t\partial_z) \Psi \right)$$

$$+ \underline{\partial_y v} (\partial_v - t\partial_z) \left( \varphi_4^{\delta} \widetilde{u'} (\partial_v - t\partial_z) \Psi \right) + (\underline{\partial_y v} - \widetilde{u'}) (\partial_v - t\partial_z) \left( \widetilde{\varphi_4} \widetilde{u'} (\partial_v - t\partial_z) \Psi \right)$$

where

(8.3) 
$$\mathcal{T}_1[\Psi] = \widetilde{\varphi_2} \partial_{zz} \Psi + \widetilde{u'} (\partial_v - t \partial_z) \Big( \widetilde{\varphi_2} \widetilde{u'} (\partial_v - t \partial_z) \Psi \Big).$$

It is easy to see that  $\mathcal{T}_1$  is an elliptic second-order differential operator. We define  $\mathcal{T}_{1,D}^{-1}$  to be the inverse operator with Dirichlet boundary conditions, namely for any function f(t, z, v),  $\mathcal{T}_1[\mathcal{T}_{1,D}^{-1}[f]] = f$  with

$$\mathcal{T}_{1,D}^{-1}[f](t,z,0) = \mathcal{T}_{1,D}^{-1}[f](t,z,1)$$

We also define

(8.4) 
$$\mathring{\mathcal{T}}_{1,D}^{-1} = \Upsilon_2 \mathcal{T}_{1,D}^{-1}$$

**Proposition 8.1.** Let  $\Omega$  be compactly supported. Then there is  $\mathcal{G}_{D,1}(t,k,\xi,\eta)$  such that

$$(\widehat{\mathcal{T}_{1,D}^{-1}[\Omega]})(t,k,\xi) = \int_{\mathbb{R}} \mathcal{G}_{D,1}(t,k,\xi,\eta)\widehat{\Omega}(t,k,\eta)d\eta,$$

with estimate

$$\left|\mathcal{G}_{D,1}(t,k,\xi,\eta)\right| \le C \min\left\{\frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\xi-kt)^2}, \frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2}\right\}.$$

The proposition is proved in Appendix C.1.

By applying  $\mathcal{T}_{1,D}^{-1}$  on equation (8.2) and multiplying the cut-off function  $\Upsilon_2$ , we get that

$$\mathring{\mathcal{T}}_{1,D}^{-1}[\Omega] - \Upsilon_2 \Psi = \mathring{\mathcal{T}}_{1,D}^{-1}[\mathcal{S}_1[\Psi]]$$

where

$$S_{1}[\Psi] = \varphi_{4}^{\delta} \partial_{zz} \Psi + \underline{\partial_{y} v} (\partial_{v} - t \partial_{z}) \left( \underline{\varphi_{4}} (\underline{\partial_{y} v} - \widetilde{u'}) (\partial_{v} - t \partial_{z}) \Psi \right) + \underline{\partial_{y} v} (\partial_{v} - t \partial_{z}) \left( \varphi_{4}^{\delta} \widetilde{u'} (\partial_{v} - t \partial_{z}) \Psi \right) + (\underline{\partial_{y} v} - \widetilde{u'}) (\partial_{v} - t \partial_{z}) \left( \widetilde{\varphi_{4}} \widetilde{u'} (\partial_{v} - t \partial_{z}) \Psi \right) = \varphi_{4}^{\delta} \partial_{zz} \Psi + h_{1} (\partial_{v} - t \partial_{z})^{2} (\Upsilon_{2} \Psi) + h_{2} (\partial_{v} - t \partial_{z}) (\Upsilon_{2} \Psi)$$

has compact support with  $\operatorname{supp} \mathcal{S}_1[\Psi] \subset [\kappa_0, 1 - \kappa_0]$  with

$$h_{1} = \underline{\partial_{y} v} \underline{\varphi_{4}} (\underline{\partial_{y} v} - \widetilde{u'}) + \underline{\partial_{y} v} \underline{\varphi_{4}^{\delta}} \widetilde{u'} + (\underline{\partial_{y} v} - \widetilde{u'}) \widetilde{\varphi_{4}} \widetilde{u'}$$

$$h_{2} = \underline{\partial_{y} v} \partial_{v} (\underline{\varphi_{4}} (\underline{\partial_{y} v} - \widetilde{u'})) + \underline{\partial_{y} v} \partial_{v} (\underline{\varphi_{4}^{\delta}} \widetilde{u'}) + (\underline{\partial_{y} v} - \widetilde{u'}) \partial_{v} (\widetilde{\varphi_{4}} \widetilde{u'}).$$

8.1. Lossy estimate. We have the following lemmas.

**Lemma 8.2.** It holds for all  $0 \le s_1 \le \sigma - 1$  that

(8.7) 
$$\|\partial_z^2 \Upsilon_2 P_{\neq} \Psi\|_{\mathcal{G}^{s,\lambda(t),s_1-2}} \lesssim \frac{\|\Omega\|_{\mathcal{G}^{s,\lambda(t),s_1}}}{\langle t \rangle^2}.$$

With the estimate of the Fourier kernel of  $\mathring{\mathcal{T}}_{1,D}^{-1}$ , the lossy estimate is simple. We refer to the proof of Lemma 3.4 in [28].

8.2. Precision elliptic control. The precision elliptic control is slightly more complicated than that in [28]. We have more terms here. The idea is to show that  $S_1[\Psi]$  is small. We have the following proposition.

**Proposition 8.3.** Under the bootstrap hypotheses,

$$(8.8) \qquad \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{\star} \left( \mathring{\mathcal{T}}_{1,D}^{-1} [\mathcal{S}_{1}[\Psi]] \right) \right\|_{2}^{2} \\ \lesssim \epsilon \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{\star} (\Psi \Upsilon_{2}) \right\|_{2}^{2} \\ + \epsilon \mathcal{C} \mathcal{K}_{h} + \epsilon \mathcal{C} \mathcal{K}_{\varphi_{9}^{\delta}} + \epsilon \mathcal{C} \mathcal{K}_{\varphi_{4}^{\delta}},$$

and

(8.9)  
$$\left\|\left\langle\frac{\partial_{v}}{t\partial_{z}}\right\rangle^{-1}\left(\partial_{z}^{2}+\left(\partial_{v}-t\partial_{z}\right)^{2}\right)P_{\star}\left(\mathring{\mathcal{T}}_{1,D}^{-1}[\mathcal{S}_{1}[\Psi]]\right)\right\|_{2}^{2}$$
$$\lesssim \epsilon \left\|\left\langle\frac{\partial_{v}}{t\partial_{z}}\right\rangle^{-1}\left(\partial_{z}^{2}+\left(\partial_{v}-t\partial_{z}\right)^{2}\right)P_{\star}(\Psi\Upsilon_{2})\right\|_{2}^{2}+\epsilon^{2},$$

where  $P_{\star} \in \{P_{0 < |k| < k_M}, P_{|k| \ge k_M}\}$  is the projection.

*Proof.* By applying Proposition 8.1, we have

$$\left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} (\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{\star} \left( \mathring{\mathcal{T}}_{1,D}^{-1} [\mathcal{S}_{1}[\Psi]] \right) \right\|_{2}$$
$$\lesssim \left\| \mathcal{M}_{1} \left( [\mathcal{S}_{1}[\Psi]] \right) \right\|_{2} + \left\| \mathcal{M}_{2} \left( [\mathcal{S}_{1}[\Psi]] \right) \right\|_{2}$$

and

$$\left\|\left\langle\frac{\partial_{v}}{t\partial_{z}}\right\rangle^{-1}(\partial_{z}^{2}+(\partial_{v}-t\partial_{z})^{2})P_{\star}\left(\mathring{\mathcal{T}}_{1,D}^{-1}[\mathcal{S}_{1}[\Psi]]\right)\right\|_{2} \lesssim \left\|\mathcal{M}_{0}\left([\mathcal{S}_{1}[\Psi]]\right)\right\|_{2}$$

where

$$\mathcal{M}_0(t, \nabla) = \left\langle \frac{\partial_v}{t\partial_z} \right\rangle^{-1} \mathbf{A} P_\star,$$
$$\mathcal{M}_1(t, \nabla) = \left\langle \frac{\partial_v}{t\partial_z} \right\rangle^{-1} \frac{|\nabla|^{s/2}}{\langle t \rangle^s} \mathbf{A} P_\star,$$
$$\mathcal{M}_2(t, \nabla) = \left\langle \frac{\partial_v}{t\partial_z} \right\rangle^{-1} \sqrt{\frac{\partial_t w}{w}} \tilde{\mathbf{A}} P_\star.$$

Let

(8.10) 
$$T^1 = h_1(\partial_v - t\partial_z)^2(\Psi\Upsilon_2), \quad T^2 = h_2(\partial_v - t\partial_z)(\Psi\Upsilon_2), \quad T^3 = \varphi_4^\delta \partial_{zz}(\Upsilon_2\Psi).$$

Divide each via a paraproduct decomposition in the v variable only

$$(8.11) T^{1} = \sum_{M \ge 8} (h_{1})_{M} (\partial_{v} - t\partial_{z})^{2} (\Psi\Upsilon)_{$$

Note that  $T^1 = h_1(\partial_v - t\partial_z)^2(\Psi\Upsilon)$  has a similar form as the term  $T^1 = (1 - (v')^2)(\partial_v - t\partial_z)^2\phi$  in [5]. The support of the functions is away from the boundary, which guarantees that the Fourier analysis works well. Similarly, the term  $T^2$  has the same structure. The new term  $T^3$  here is even better than  $T^1$ . The key point in *proof of Proposition 2.4, section 4.2.1 — 4.2.3* in [5] is that the Fourier multipliers  $\mathcal{M}_0$ ,  $\mathcal{M}_1$  and  $\mathcal{M}_2$  have some algebraic type properties. It is the same here. Thus we have

$$\begin{split} &\sum_{j=1}^{3} \left\| \mathcal{M}_{0} \mathbf{T}_{\mathrm{LH}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{0} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} \\ &\sum_{j=1}^{3} \left\| \mathcal{M}_{1} \mathbf{T}_{\mathrm{LH}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{1} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} \end{split}$$

$$\sum_{j=1}^{3} \left\| \mathcal{M}_{2} \mathrm{T}_{\mathrm{LH}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{1} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} + \epsilon^{2} \left\| \mathcal{M}_{2} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2},$$

and

$$\begin{split} &\sum_{j=1}^{3} \left\| \mathcal{M}_{0} \mathbf{T}_{\mathrm{HL}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{0} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} + \epsilon^{4}, \\ &\sum_{j=1}^{3} \left\| \mathcal{M}_{1} \mathbf{T}_{\mathrm{HL}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{1} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} + \epsilon^{2} \mathrm{CK}_{h}^{2} + \epsilon^{2} \mathrm{CK}_{\varphi_{4}^{\delta}}^{2} + \epsilon^{2} \mathrm{CK}_{\varphi_{9}^{\delta}}^{2}, \\ &\sum_{j=1}^{3} \left\| \mathcal{M}_{2} \mathbf{T}_{\mathrm{HL}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{2} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} + \epsilon^{2} \left\| \mathcal{M}_{1} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} \\ &+ \epsilon^{2} \mathrm{CK}_{h}^{1} + \epsilon^{2} \mathrm{CK}_{\varphi_{4}^{\delta}}^{1} + \epsilon^{2} \mathrm{CK}_{\varphi_{9}^{\delta}}^{2}, \end{split}$$

and

$$\begin{split} &\sum_{j=1}^{3} \left\| \mathcal{M}_{0} \mathrm{T}_{\mathcal{R}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{0} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2}, \\ &\sum_{j=1}^{3} \left\| \mathcal{M}_{1} \mathrm{T}_{\mathcal{R}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{1} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2}, \\ &\sum_{j=1}^{3} \left\| \mathcal{M}_{2} \mathrm{T}_{\mathcal{R}}^{j} \right\|_{2}^{2} \lesssim \epsilon^{2} \left\| \mathcal{M}_{1} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2} + \epsilon^{2} \left\| \mathcal{M}_{2} \Delta_{L} P_{\star}(\Psi \Upsilon) \right\|_{2}^{2}, \end{split}$$

where  $\Delta_L = \partial_z^2 + (\partial_v - t\partial_z)^2$ . Thus we prove the proposition.

Now we prove Proposition 7.3.

*Proof.* We consider the case  $|k| \ge k_M$  first. In this case,  $P_k f = P_k \Omega$ . By using (8.5), and Proposition 8.3, we have

$$\begin{split} & \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{|k| \ge k_{M}} (\Psi \Upsilon_{2}) \right\|_{2}^{2} \\ & \leq C_{ell} \mathcal{C} \mathcal{K}_{f} + \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{|k| \ge k_{M}} \left( \mathring{\mathcal{T}}_{1,D}^{-1} [\mathcal{S}_{1}[\Psi]] \right) \right\|_{2}^{2} \\ & \leq C_{ell} \mathcal{C} \mathcal{K}_{f} + \epsilon \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{|k| \ge k_{M}} (\Psi \Upsilon_{2}) \right\|_{2}^{2} \\ & + \epsilon \mathcal{C} \mathcal{K}_{h} + \epsilon \mathcal{C} \mathcal{K}_{\varphi_{9}^{\delta}} + \epsilon \mathcal{C} \mathcal{K}_{\varphi_{4}^{\delta}} \end{split}$$

which gives (7.5).

For the case  $0 < |k| < k_M$ , we have  $P_k f(t, z, v) = \mathbf{D}_{u,k}[\mathcal{F}_1\Omega(t, k, \cdot)](t, k, v)e^{izk}$  and thus

$$P_k\Omega(t,z,v) = \mathbf{D}_{u,k}^{-1}[\mathcal{F}_1 f(t,k,\cdot)](t,k,v)e^{izk}.$$

By following the same argument, we have

$$\left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2} \right) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{|k| \ge k_{M}} (\Psi \Upsilon_{2}) \right\|_{2}^{2}$$

$$\leq \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{|k| \le k_{M}} (\Omega) \right\|_{2}^{2} + \epsilon \mathcal{C} \mathcal{K}_{h} + \epsilon \mathcal{C} \mathcal{K}_{\varphi_{9}^{\delta}} + \epsilon \mathcal{C} \mathcal{K}_{\varphi_{4}^{\delta}}.$$

To control the first term by  $\mathcal{CK}_f$ , we use Remark 6.3. Thus we prove the proposition.

We conclude this section by introducing the following corollary, which will be used in the estimates of pressure terms.

Corollary 8.4. Under the bootstrap hypotheses,

$$\left\|\left\langle\frac{\partial_v}{t\partial_z}\right\rangle^{-1}(\partial_z^2 + (\partial_v - t\partial_z)^2)\mathbf{A}P_{\neq}(\Psi\Upsilon_2)\right\|_2 \lesssim \epsilon,$$

and

$$\|\langle \partial_{v} \rangle \mathcal{A}_{0} P_{0}(\Upsilon_{2} \Psi)\|_{2} \lesssim \epsilon,$$

$$\left\| \left( \sqrt{\frac{\partial_{t} w}{w}} + \frac{\langle \partial_{v} \rangle^{\frac{s}{2}}}{\langle t \rangle^{s}} \right) \langle \partial_{v} \rangle \mathcal{A}_{0} P_{0}(\Upsilon_{2} \Psi) \right\|_{2} \lesssim \mathcal{C} \mathcal{K}_{f}^{\frac{1}{2}} + \epsilon \left( \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{4}^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{9}^{\delta}}^{\frac{1}{2}} \right).$$

Moreover, we have estimate for  $\underline{\omega}(t, z, v) = \underline{\theta}\Omega + \underline{\varphi}_2 \partial_y v (\partial_v - t \partial_z) \Psi$ . It holds that

$$\|\mathbf{A}\underline{\omega}\|_{L^2} \lesssim \epsilon_1$$

and

$$\left\| \left( \sqrt{\frac{\partial_t w}{w}} \mathbf{A} + \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \tilde{\mathbf{A}} \right) \underline{\omega} \right\|_2 \lesssim \mathcal{C} \mathcal{K}_f^{\frac{1}{2}} + \epsilon \left( \mathcal{C} \mathcal{K}_h^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_2^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_4^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_9^{\delta}}^{\frac{1}{2}} \right).$$

*Proof.* The estimates for nonzero modes and the estimates for  $\underline{\omega}$  in the corollary follow directly from (8.5), (8.9) and Remark 6.2 and the estimate of zero mode of  $\Upsilon_2\Psi$ .

For the zero mode, similarly, we have the decomposition

(8.14) 
$$P_0(\Omega) = P_0(\mathcal{T}_1[\Psi]) + h_1 \partial_{vv} P_0(\Upsilon_2 \Psi) + h_2 \partial_v P_0(\Upsilon_2 \Psi),$$

where

(8.15) 
$$P_0(\mathcal{T}_1[\Psi]) = \widetilde{u'} \partial_v \left( \widetilde{\varphi_2} \widetilde{u'} \partial_v P_0(\Psi) \right).$$

We then have

$$\langle \partial_v \rangle \mathcal{A}_0 P_0(\Upsilon_2 \Psi) = \langle \partial_v \rangle \mathring{\mathcal{T}}_{1,D}^{-1} \Big[ P_0(\Omega) - h_1 \partial_{vv} P_0(\Upsilon_2 \Psi) - h_2 \partial_v P_0(\Upsilon_2 \Psi) \Big].$$

Notice that Proposition 8.1 holds also for k = 0. Note that for  $|\eta| \ge 2|\xi - \eta|$ 

$$\frac{\mathcal{A}_0(\xi)}{\mathcal{A}^{\mathcal{R}}(\eta)} \lesssim e^{c\lambda \langle \xi - \eta \rangle^s}, \quad \text{for some} \quad 0 < c < 1.$$

Thus we conclude that

$$\begin{aligned} \|\langle \partial_v \rangle \mathcal{A}_0 P_0(\Upsilon_2 \Psi)\|_2 &\lesssim \left\| \langle \partial_v \rangle^{-1} \mathcal{A}_0 P_0 \Omega \right\|_2 + \left\| \langle \partial_v \rangle^{-1} \mathcal{A}_0(h_1 \partial_{vv} P_0(\Upsilon_2 \Psi)) \right\|_2 \\ &+ \left\| \langle \partial_v \rangle^{-1} \mathcal{A}_0(h_2 \partial_v P_0(\Upsilon_2 \Psi)) \right\|_{L^2} \\ &\lesssim \|\mathcal{A}_0 P_0 \Omega\|_2 + \epsilon \| \langle \partial_v \rangle \mathcal{A}_0 P_0(\Upsilon_2 \Psi) \|_2 \end{aligned}$$

+ 
$$\left( \|\mathbf{A}^{\mathbf{R}}h_1\|_{L^2} + \|\mathbf{A}^{\mathbf{R}}\langle\partial_v\rangle^{-1}h_2\|_{L^2} \right) \|P_0(\Upsilon_2\Psi)\|_{\mathcal{G}^{s,\sigma-6}}.$$

Similarly, we have

$$\begin{split} & \left\| \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \partial_v \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) \langle \partial_v \rangle \mathcal{A}_0 P_0(\Upsilon_2 \Psi) \right\|_2 \\ & \lesssim \mathcal{C} \mathcal{K}_f^{\frac{1}{2}} + \left\| \langle \partial_v \rangle^{-1} \mathcal{A}_0 \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \partial_v \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) (h_1 \partial_{vv} P_0(\Upsilon_2 \Psi)) \right\|_2 \\ & + \left\| \langle \partial_v \rangle^{-1} \mathcal{A}_0 \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \partial_v \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) (h_2 \partial_v P_0(\Upsilon_2 \Psi)) \right\|_{L^2} \\ & \lesssim \mathcal{C} \mathcal{K}_f^{\frac{1}{2}} + \epsilon \left\| \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \partial_v \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) \langle \partial_v \rangle \mathcal{A}_0 P_0(\Upsilon_2 \Psi) \right\|_2 \\ & + \left( \mathcal{C} \mathcal{K}_h^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_4^{\frac{1}{4}}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_9^{\frac{1}{5}}}^{\frac{1}{2}} \right) \| P_0(\Upsilon_2 \Psi) \|_{\mathcal{G}^{s,\sigma-6}}, \end{split}$$

which gives the corollary.

The Corollary 8.4 gives the estimates of  $\underline{\omega}(t, z, v)$  which is the same as  $\Omega$ . The estimates of the zero mode of the stream function  $P_0(\Upsilon_2 \Psi)$  are used in the estimate of  $A_4 = \underline{\chi'_2 \partial_y v} \partial_v P_0(\Upsilon_2 \Psi) \partial_{zz}(\Upsilon_2 \Psi)$  in the estimates of the pressure, see Lemma 10.7.

# 9. ZERO MODE OF THE PRESSURE

In this section, we estimate the zero mode of the pressure. Unlike the whole space case, we will not use the elliptic equation to study the zero mode of the pressure. Instead, we use (5.7i). Let us define

$$\mathcal{M}_{0j}\partial_{v}P_{0}(\Pi\Upsilon_{1}) = -\mathcal{M}_{0j}\Big((\underline{\varphi_{4}}\Upsilon_{2})P_{0}(a)\partial_{v}P_{0}(\Pi\Upsilon_{1})\Big) - \mathcal{M}_{0j}\Big((\underline{\varphi_{4}}\Upsilon_{2})P_{0}\big[P_{\neq}(a)P_{\neq}(\partial_{v}-t\partial_{z})P_{\neq}(\Pi\Upsilon_{1})\big]\Big) \\ + \mathcal{M}_{0j}\Big[(\underline{\varphi_{4}}\Upsilon_{2})P_{0}\Big(\partial_{z}(\Psi\Upsilon_{2})\partial_{z}(\partial_{v}-t\partial_{z})(\Psi\Upsilon_{2}) - \partial_{zz}(\Psi\Upsilon_{2})(\partial_{v}-t\partial_{z})(\Psi\Upsilon_{2})\Big)\Big)\Big].$$

We first show that the first two terms in (9.1) are small.

**Proposition 9.1.** Under the bootstrap hypotheses,

$$\lesssim \frac{\epsilon^2}{\langle t \rangle^s} + \epsilon \left( \mathcal{C} \mathcal{K}_a^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_4^{\frac{1}{2}}}^{\frac{1}{2}} \right)$$

$$+ \epsilon \left\| \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) \langle \partial_z \rangle t (1 + \langle \partial_z \rangle + |\partial_v|) (1 - \Delta)^{-1} \left( (\partial_v - t \partial_z)^2 + \partial_z^2 \right) \mathrm{A} P_{\neq} (\Pi \Upsilon_1) \right\|_{L^2}.$$

*Proof.* It is easy to check that

$$+ \epsilon \left( \frac{1}{\langle t \rangle^s} + \mathcal{C} \mathcal{K}_{\varphi_4^{\delta}}^{\frac{1}{2}} \right) \langle t \rangle^4 \| P_{\neq}(\Pi \Upsilon_1) \|_{\mathcal{G}^{s,\sigma-6}}$$

$$\lesssim \frac{\epsilon^2}{\langle t \rangle^s} + \epsilon \left( \mathcal{C} \mathcal{K}_a^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_4^{\delta}}^{\frac{1}{2}} \right)$$

$$+ \epsilon \left\| \left( \sqrt{\frac{\partial_t w}{w}} + \frac{\langle \nabla \rangle^{\frac{s}{2}}}{\langle t \rangle^s} \right) \langle \partial_z \rangle t (1 + \langle \partial_z \rangle + |\partial_v|) (1 - \Delta)^{-1} \left( (\partial_v - t \partial_z)^2 + \partial_z^2 \right) \mathcal{A} P_{\neq}(\Pi \Upsilon_1) \right\|_{L^2}.$$

$$\text{e, we prove the proposition.} \qquad \Box$$

Thus, we prove the proposition.

We now prove Proposition 7.8.

*Proof.* By Proposition 9.1, we only need to control the last term in (9.1). Indeed, we only need to consider

where  $\Pi \in {\{\Pi_{l,1}, \Pi_{l,2}, \Pi_{n,1}, \Pi_{n,2}\}}$  and  $\Xi$  represents the right-hand side of equations (2.18) respectively.

We rewrite the equation by separating its linear part and the nonlinear part.

Similar to  $\mathcal{T}_1$ , we define  $\mathcal{T}_N^{-1}$  to be the inverse operator of  $\mathcal{T}_2$  with Neumann boundary conditions, namely for any function f(t, z, v),  $\mathcal{T}_2[\mathcal{T}_N^{-1}[f]] = f$  with

$$\partial_v \mathcal{T}_N^{-1}[f](t,z,0) = \partial_v \mathcal{T}_N^{-1}[f](t,z,1)$$

We also define

(10.3) 
$$\mathring{\mathcal{T}}_{j,N}^{-1} = \Upsilon_j \mathcal{T}_N^{-1}, \quad j = 1, 2.$$

**Proposition 10.1.** Let  $\Xi$  be compactly supported. Then for  $k \neq 0$  there is  $\mathcal{G}_{N,j}(t,k,\xi,\eta)$  such that for j = 1, 2,

$$|\mathcal{G}_{N,j}(t,k,\xi,\eta)| \le C \min\left\{\frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\xi-kt)^2}, \frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2}\right\}.$$

The proposition is proved in Appendix C.3.

Next, we rewrite the pressure equation by separating interactions with zero-mode and interactions with a.

$$g_{1} = (\underline{\partial_{y}v} - \widetilde{u'})\underline{\theta}\underline{\partial_{y}v} + \widetilde{u'}\theta^{\delta}\underline{\partial_{y}v} + \widetilde{u'}\tilde{\theta}(\underline{\partial_{y}v} - \widetilde{u'})$$

$$g_{2} = (\underline{\partial_{y}v} - \widetilde{u'})\partial_{v}(\underline{\theta}\underline{\partial_{y}v}) + \widetilde{u'}\partial_{v}(\theta^{\delta}\underline{\partial_{y}v}) + \widetilde{u'}\partial_{v}(\tilde{\theta}(\underline{\partial_{y}v} - \widetilde{u'}))$$

$$g_{3} = (\underline{\partial_{y}v} - \widetilde{u'})\underline{\partial_{y}v} + \widetilde{u'}\underline{\partial_{y}v} + \widetilde{u'}(\underline{\partial_{y}v} - \widetilde{u'})$$

$$g_4 = (\underline{\partial_y v} - \widetilde{u'})\partial_v(\underline{\partial_y v}) + \widetilde{u'}\partial_v(\underline{\partial_y v}) + \widetilde{u'}\partial_v((\underline{\partial_y v} - \widetilde{u'})).$$

$$\tilde{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi] - \Upsilon_{j}P_{\neq}\Pi = \tilde{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\mathcal{S}_{2}[\Pi] + P_{\neq}\mathcal{S}_{a}[\Pi]].$$

We introduce three multipliers, which are constructed in [11]: for  $k \in \mathbb{Z} \setminus \{0\}, \xi \in \mathbb{R}$ , let

$$\mathcal{M}_{3}(t,k,\xi) = \frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^{2}+\xi^{2}} \mathbf{A}_{k}(\xi),$$
$$\mathcal{M}_{4}(t,k,\xi) = \frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^{2}+\xi^{2}} \frac{|k,\xi|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A}_{k}(\xi),$$
$$\mathcal{M}_{5}(t,k,\xi) = \frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^{2}+\xi^{2}} \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}}_{k}(\xi).$$

It is easy to check that

$$(10.6) \quad \frac{\langle k \rangle t(t + \langle k \rangle + |\xi|)}{1 + k^2 + \xi^2} = \frac{|kt|}{|\xi| + |kt|} \frac{(|\xi| + |kt|)(t + \langle k \rangle + |\xi|)}{k^2 + \xi^2 + 1} \ge \frac{|kt|}{|\xi| + |kt|} \approx \left\langle \frac{\xi}{kt} \right\rangle^{-1},$$

which implies  $\mathcal{M}_4(t,k,\xi) \geq \mathcal{M}_1(t,k,\xi)$  and  $\mathcal{M}_5(t,k,\xi) \geq \mathcal{M}_2(t,k,\xi)$ . We first control the two error terms  $\mathring{\mathcal{T}}_{j,N}^{-1} [P_{\neq} \mathcal{S}_2[\Pi]]$  and  $\mathring{\mathcal{T}}_{j,N}^{-1} [P_{\neq} \mathcal{S}_a[\Pi]]$ 

Lemma 10.2. Under the bootstrap hypotheses,

$$\begin{split} \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{2}[\Pi] \right] \right\|_{2} &\lesssim \epsilon \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{2}\Pi) \right\|_{2} \\ \left\| (\mathcal{M}_{4} + \mathcal{M}_{5})(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{2}[\Pi] \right] \right\|_{2} &\lesssim \epsilon \left( \mathcal{C}\mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{\varphi^{\delta}}^{\frac{1}{2}} \right) \\ &+ \epsilon \| (\mathcal{M}_{4} + \mathcal{M}_{5})(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{2}\Pi) \|_{2}. \end{split}$$

Lemma 10.3. Under the bootstrap hypotheses,

$$\begin{split} \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{a}[\Pi] \right] \right\|_{2} &\lesssim \epsilon \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{2}\Pi) \right\|_{2} + \epsilon^{2}, \\ \left\| (\mathcal{M}_{4} + \mathcal{M}_{5})(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{a}[\Pi] \right] \right\|_{2} &\lesssim \epsilon \left( \mathcal{C}\mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{a}^{\frac{1}{2}} + \frac{\epsilon}{\langle t \rangle^{s}} \right) \\ &+ \epsilon \| (\mathcal{M}_{4} + \mathcal{M}_{5})(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{2}\Pi) \|_{2} \\ &+ \epsilon \| \mathcal{M}_{01} \partial_{v} P_{0}(\Upsilon_{2}\Pi) \|_{L^{2}}. \end{split}$$

By applying Proposition 10.1, we have

$$\begin{split} & \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \big[ \mathcal{S}_{2}[\Pi] + \mathcal{S}_{a}[\Pi] \big] \right\|_{2} \\ & \lesssim \| \mathcal{M}_{3} P_{\neq} \mathcal{S}_{2}[\Pi] \|_{2} + \| \mathcal{M}_{3} P_{\neq} \mathcal{S}_{a}[\Pi] \|_{2}, \\ & \left\| (\mathcal{M}_{4} + \mathcal{M}_{5})(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \big[ \mathcal{S}_{2}[\Pi] + \mathcal{S}_{a}[\Pi] \big] \right\|_{2} \\ & \lesssim \| (\mathcal{M}_{4} + \mathcal{M}_{5}) P_{\neq} \mathcal{S}_{2}[\Pi] \|_{2} + \| (\mathcal{M}_{4} + \mathcal{M}_{5}) P_{\neq} \mathcal{S}_{a}[\Pi] \|_{2}. \end{split}$$

The idea of the proof of these two lemmas is the same as the proofs of Lemma 3.2, Lemma 3.3, and Lemma 3.4 of [11].

*Proof.* Estimate for  $S_2[\Pi]$ : By fact that

and Remark 6.5, we get

$$\mathcal{M}_{3}(t,k,\xi) \lesssim \mathcal{A}^{\mathcal{R}}(\xi-\eta) \frac{\langle k \rangle t(t+\langle k \rangle+|\eta|)}{1+k^{2}+\eta^{2}} e^{c\lambda|k,\eta|^{s}} + e^{c\lambda|\xi-\eta|^{s}} \mathcal{M}_{3}(t,k,\eta)$$
$$\mathcal{M}_{4}(t,k,\xi) \lesssim \frac{|\eta-\xi|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathcal{A}^{\mathcal{R}}(\xi-\eta) \frac{\langle k \rangle t(t+\langle k \rangle+|\eta|)}{1+k^{2}+\eta^{2}} e^{c\lambda|k,\eta|^{s}} + e^{c\lambda|\xi-\eta|^{s}} \mathcal{M}_{4}(t,k,\eta).$$

By Lemma D.2, we have

$$\mathcal{M}_{5}(t,k,\xi) \lesssim \left(\frac{|\eta-\xi|^{\frac{s}{2}}}{\langle t \rangle^{s}} + \sqrt{\frac{\partial_{t}w}{w}}\right) \mathbf{A}^{\mathbf{R}}(\xi-\eta) \mathcal{M}_{3}(t,k,\eta) e^{c\lambda|k,\eta|^{\frac{s}{2}}} + e^{c\lambda|\xi-\eta|^{s}} \left(\mathcal{M}_{4}(t,k,\eta) + \mathcal{M}_{5}(t,k,\eta)\right).$$

Thus we have

$$\begin{split} \left\| \mathcal{M}_{3} P_{\neq} [\theta^{\delta} \partial_{zz} (\Upsilon_{2} \Pi) + g_{1} (\partial_{v} - t \partial_{z})^{2} (\Upsilon_{2} \Pi)] \right\|_{L^{2}} &\lesssim \epsilon \left\| \mathcal{M}_{3} (\partial_{z}^{2} + (\partial_{v} - t \partial_{z})^{2}) P_{\neq} (\Upsilon_{2} \Pi) \right\|_{2}, \\ \left\| \left( \mathcal{M}_{4} + \mathcal{M}_{5} \right) P_{\neq} [\theta^{\delta} \partial_{zz} (\Upsilon_{2} \Pi) + g_{1} (\partial_{v} - t \partial_{z})^{2} (\Upsilon_{2} \Pi)] \right\|_{L^{2}} \\ &\lesssim \left( \mathcal{C} \mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi^{\delta}_{9}}^{\frac{1}{2}} \right) \left\| \mathcal{M}_{3} (\partial_{z}^{2} + (\partial_{v} - t \partial_{z})^{2}) P_{\neq} (\Upsilon_{2} \Pi) \right\|_{2} \\ &+ \epsilon \| (\mathcal{M}_{4} + \mathcal{M}_{5}) (\partial_{z}^{2} + (\partial_{v} - t \partial_{z})^{2}) P_{\neq} (\Upsilon_{2} \Pi) \|_{2}. \end{split}$$

For the  $g_2(\partial_v - t\partial_z)\Pi$  term, since there is one derivative loss in  $g_2$ , we need to use the decay of  $\Pi$  and the multiplier  $\frac{|k|t(t+|k,\eta|)}{k^2+\eta^2}$  to gain the regularity, which plays a similar role to the multiplier  $\left\langle \frac{\eta}{kt} \right\rangle^{-1}$  in  $\mathcal{M}_1$  and  $\mathcal{M}_2$ . We have for  $|\xi - \eta| \geq 2|k, \eta|$  (the case  $g_2$  is in higher frequencies)

(10.7) 
$$\frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^2+\xi^2} \frac{1+k^2+\eta^2}{\langle k \rangle t(t+\langle k \rangle+|\eta|)} \lesssim \frac{\langle k,\eta \rangle^2}{1+k^2+\xi^2} \Big(1+\frac{|\eta-\xi|}{(t+\langle k \rangle+|\eta|)}\Big) \lesssim \frac{\langle k,\eta \rangle^2}{\langle \eta-\xi \rangle},$$

and for  $|\xi - \eta| \le 2|k, \eta|$ 

$$\frac{\langle k\rangle t(t+\langle k\rangle+|\xi|)}{1+k^2+\xi^2} \frac{1+k^2+\eta^2}{\langle k\rangle t(t+\langle k\rangle+|\eta|)} \lesssim \left(1+\frac{|\xi-\eta||\xi+\eta|}{1+k^2+\xi^2}\right) \left(1+\frac{|\xi-\eta|}{t+\langle k\rangle+|\eta|}\right) \lesssim \langle \xi-\eta\rangle^3.$$

Then we have by Remark 6.5 and Lemma D.2,

$$\begin{split} &\|\mathcal{M}_{3}[g_{2}(\partial_{v}-t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi)]\|_{L^{2}} \lesssim \epsilon \left\|\mathcal{M}_{3}(\partial_{z}^{2}+(\partial_{v}-t\partial_{z})^{2})P_{\neq}(\Upsilon_{2}\Pi)\right\|_{2},\\ &\left\|\left(\mathcal{M}_{4}+\mathcal{M}_{5}\right)P_{\neq}[g_{2}(\partial_{v}-t\partial_{z})(\Upsilon_{2}\Pi)]\right\|_{L^{2}}\\ &\lesssim \left(\mathcal{C}\mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}}+\mathcal{C}\mathcal{K}_{h}^{\frac{1}{2}}+\mathcal{C}\mathcal{K}_{\varphi^{\delta}_{9}}^{\frac{1}{2}}\right)\left\|\mathcal{M}_{3}(\partial_{z}^{2}+(\partial_{v}-t\partial_{z})^{2})P_{\neq}(\Upsilon_{2}\Pi)\right\|_{2}\\ &+\epsilon\|(\mathcal{M}_{4}+\mathcal{M}_{5})(\partial_{z}^{2}+(\partial_{v}-t\partial_{z})^{2})P_{\neq}(\Upsilon_{2}\Pi)\|_{2}. \end{split}$$

This gives the lemma.

*Proof.* Estimate for  $S_a[\Pi]$ : For the estimate of  $S_a[\Pi]$ , we take advantage of the divergence form. Note that switching from  $A_k(\xi)$  to  $A_l(\eta)$ , we will lose  $\frac{\xi}{k^2 + (\xi - kt)^2}$  in the case  $t \in I_{k,\xi} \cap I_{k,\eta}, k \neq l$ . By taking out one derivative  $(\partial_z, \partial_v - t\partial_z)$ , in the worst case  $t \in I_{k,\xi} \cap I_{k,\eta}, k \neq l$ , we multiply a small fact  $\frac{\xi - kt}{\eta - lt}$ .

We first consider the first two terms in  $S_a[\Pi]$  when  $\Pi$  is non-zero modes, namely,  $\partial_z(a\partial_z P_{\neq}(\Upsilon_2\Pi))$ and  $g_3(\partial_v - t\partial_z)(a(\partial_v - t\partial_z)P_{\neq}(\Upsilon_2\Pi))$ . Since  $g_3$  is the zero-mode, using the idea of the proof of  $S_2[\Pi]$ , we have

$$\begin{split} & \left\| \mathcal{M}_{3}P_{\neq} \left[ g_{3}(\partial_{v} - t\partial_{z})(a(\partial_{v} - t\partial_{z})(\Upsilon_{2}\Pi)) \right] \right\|_{L^{2}} \lesssim \left\| \mathcal{M}_{3}P_{\neq} \left[ (\partial_{v} - t\partial_{z})(a(\partial_{v} - t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi)) \right] \right\|_{L^{2}} \\ & \left\| \left( \mathcal{M}_{4} + \mathcal{M}_{5} \right) P_{\neq} \left[ g_{3}(\partial_{v} - t\partial_{z})(a(\partial_{v} - t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi)) \right] \right\|_{L^{2}} \\ & \lesssim \left\| \left( \mathcal{M}_{4} + \mathcal{M}_{5} \right) P_{\neq} \left[ (\partial_{v} - t\partial_{z})(a(\partial_{v} - t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi)) \right] \right\|_{L^{2}} \\ & + \left( \frac{1}{\langle t \rangle^{s}} + \mathcal{C}\mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{\varphi_{9}^{\frac{1}{2}}}^{\frac{1}{2}} \right) \left\| \mathcal{M}_{3}P_{\neq} \left[ (\partial_{v} - t\partial_{z})(a(\partial_{v} - t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi)) \right] \right\|_{L^{2}} \end{split}$$

Then we treat the last term in  $S_a[\Pi]$ , namely,  $g_4a(\partial_v - t\partial_z)(\Upsilon_2\Pi)$ . If  $g_4$  is in lower frequencies, the treatment is easier than  $g_3(\partial_v - t\partial_z)(a(\partial_v - t\partial_z)(\Upsilon_2\Pi))$ . The difficulty happens when  $g_4$  is in higher frequencies. In such a case, we follow the idea of the treatment of  $g_2(\partial_v - t\partial_z)P_{\neq}(\Upsilon_2\Pi)$  term, then by (10.7) we have

$$\begin{split} \left\| \mathcal{M}_{3} \Big[ g_{4} P_{\neq} \Big( a(\partial_{v} - t\partial_{z})(\Upsilon_{2}\Pi) \Big) \Big] \right\|_{L^{2}} \\ \lesssim \left\| \mathcal{M}_{3}(|\partial_{z}| + |\partial_{v} - t\partial_{z}|) P_{\neq} \Big( a(\partial_{v} - t\partial_{z}) P_{\neq}(\Upsilon_{2}\Pi) \Big) \Big] \right\|_{L^{2}} \\ + \left\| \mathcal{M}_{3}(|\partial_{z}| + |\partial_{v} - t\partial_{z}|) P_{\neq} \Big( a\partial_{v} P_{0}(\Upsilon_{2}\Pi) \Big) \Big] \right\|_{L^{2}} \\ \left\| (\mathcal{M}_{4} + \mathcal{M}_{5}) P_{\neq} \Big[ g_{4} \Big( a(\partial_{v} - t\partial_{z})(\Upsilon_{2}\Pi) \Big) \Big] \right\|_{L^{2}} \\ \lesssim \Big( \frac{1}{\langle t \rangle^{s}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{9}^{\frac{1}{2}}}^{\frac{1}{2}} \Big) \left\| \mathcal{M}_{3}(|\partial_{z}| + |\partial_{v} - t\partial_{z}|) P_{\neq} \Big( a(\partial_{v} - t\partial_{z}) P_{\neq}(\Upsilon_{2}\Pi) \Big) \Big] \right\|_{L^{2}} \\ + \Big( \frac{1}{\langle t \rangle^{s}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{9}^{\frac{1}{2}}}^{\frac{1}{2}} \Big) \left\| \mathcal{M}_{3}(|\partial_{z}| + |\partial_{v} - t\partial_{z}|) P_{\neq} \Big( a\partial_{v} P_{0}(\Upsilon_{2}\Pi) \Big) \Big] \right\|_{L^{2}} \\ + \epsilon \| (\mathcal{M}_{4} + \mathcal{M}_{5})(|\partial_{z}| + |\partial_{v} - t\partial_{z}|) P_{\neq}(a(\partial_{v} - t\partial_{z})(\Upsilon_{2}\Pi)) \|_{2}. \end{split}$$

We have by Lemma D.4 and Remark 6.5 that for  $|k - l, \eta - \xi| \le |l, \eta|, k \ne 0, l \ne 0$ 

$$\begin{split} |k|\mathcal{M}_{3}(t,k,\xi)\left\langle t-\frac{\xi}{k}\right\rangle \\ \lesssim \mathcal{M}_{3}(t,l,\eta)(|l|+|\eta-lt|)\frac{|k|+|\xi-kt|}{|l|+|\eta-lt|}\frac{\langle k\rangle(t+\langle k\rangle+|\xi|)}{\langle l\rangle(t+\langle l\rangle+|\eta|)}\frac{1+l^{2}+\eta^{2}}{1+k^{2}+\xi^{2}}e^{c\lambda|k-l,\eta-\xi|^{s}} \\ + A_{l}(\eta)\frac{\langle k\rangle t(t+\langle k\rangle+|\xi|)}{1+k^{2}+\xi^{2}}\frac{|\xi|(|k|+|\xi-kt|)}{k^{2}+(\xi-kt)^{2}}\mathbf{1}_{t\in\mathbf{I}_{k,\xi}\cap\mathbf{I}_{k,\eta},k\neq l} \\ \lesssim \mathcal{M}_{3}(t,l,\eta)(|l|+|\eta-lt|)e^{c\lambda|k-l,\eta-\xi|}\langle k-l,\eta-\xi\rangle^{5} + A_{l}(\eta)\frac{\xi/k}{\eta/l}|l|\left\langle t-\frac{\eta}{l}\right\rangle e^{c\lambda|k-l,\eta-\xi|} \\ \lesssim e^{c\lambda|k-l,\eta-\xi|}\mathcal{M}_{3}(t,l,\eta)(|l|+|\eta-lt|) \end{split}$$

For  $|k - l, \eta - \xi| \ge |l, \eta|, k \ne 0, l \ne 0, k \ne l$ , we have by Remark 6.5

$$\begin{aligned} |k|\mathcal{M}_{3}(t,k,\xi)\left\langle t-\frac{\xi}{k}\right\rangle \\ \lesssim \frac{\langle k\rangle t(t+\langle k\rangle+|\xi|)}{1+k^{2}+\xi^{2}}(|k|+|\xi-kt|)\mathbf{A}_{k-l}(\xi-\eta)e^{c\lambda|l,\eta|^{s}} \\ + \frac{\langle k\rangle t(t+\langle k\rangle+|\xi|)}{1+k^{2}+\xi^{2}}\mathbf{A}_{k-l}(\xi-\eta)\frac{|\xi|(|k|+|\xi-kt|)}{k^{2}+|\xi-kt|^{2}}e^{c\lambda|l,\eta|^{s}}\mathbf{1}_{t\in\mathbf{I}_{k,\xi}\cap\mathbf{I}_{k,\xi-\eta},k\neq k-l} \end{aligned}$$

$$\lesssim \mathcal{A}_{k-l}^*(\xi-\eta)\langle t\rangle^3 e^{c\lambda|l,\eta|^s}.$$

Similarly, by Lemma D.2, we have

$$\begin{aligned} |k|(\mathcal{M}_4(t,k,\xi) + \mathcal{M}_5(t,k,\xi)) \left\langle t - \frac{\xi}{k} \right\rangle \\ &\lesssim e^{c\lambda|k-l,\eta-\xi|} (\mathcal{M}_4(t,l,\eta) + \mathcal{M}_5(t,l,\eta))(|l| + |\eta - lt|) \\ &+ \left(\sqrt{\frac{\partial_t w}{w}} + \frac{|k-l,\xi-\eta|^{\frac{s}{2}}}{\langle t \rangle^s}\right) \mathbf{A}^*_{k-l}(\xi-\eta) \langle t \rangle^2 e^{c\lambda|l,\eta|^s}. \end{aligned}$$

$$\begin{split} &\|\mathcal{M}_{3}P_{\neq}[(\partial_{v}-t\partial_{z})(a(\partial_{v}-t\partial_{z})P_{\neq}((\Upsilon_{2}\Pi)))]\|_{L^{2}}\\ &\lesssim \epsilon \left\|\mathcal{M}_{3}\big((\partial_{v}-t\partial_{z})^{2}+\partial_{z}^{2}\big)P_{\neq}(\Upsilon_{2}\Pi)\right\|_{2}+\epsilon\langle t\rangle^{4}\|P_{\neq}(\Upsilon_{2}\Pi)\|_{\mathcal{G}^{s,\sigma-6}}\\ &\|(\mathcal{M}_{4}+\mathcal{M}_{5})P_{\neq}[(\partial_{v}-t\partial_{z})(a(\partial_{v}-t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi))]\|_{L^{2}}\\ &\lesssim \epsilon \left\|(\mathcal{M}_{4}+\mathcal{M}_{5})\big((\partial_{v}-t\partial_{z})^{2}+\partial_{z}^{2}\big)P_{\neq}(\Upsilon_{2}\Pi)\big\|_{L^{2}}+\langle t\rangle^{4}\|P_{\neq}(\Upsilon_{2}\Pi)\|_{\mathcal{G}^{s,\sigma-6}}\mathcal{CK}_{a}^{\frac{1}{2}}. \end{split}$$

Next, we consider the second term in  $S_a[\Pi]$  when  $\Pi$  is the zero mode, namely,  $g_3(\partial_v - t\partial_z)(P_{\neq}(a)\partial_v P_0(\Upsilon_2\Pi))$ . Again, we first get rid of  $g_3$ :

$$\begin{split} & \left\| \mathcal{M}_{3} \Big[ g_{3}(\partial_{v} - t\partial_{z}) (P_{\neq} a \partial_{v} P_{0}(\Upsilon_{2}\Pi)) \Big] \right\|_{L^{2}} \lesssim \left\| \mathcal{M}_{3} [(\partial_{v} - t\partial_{z}) (P_{\neq} a \partial_{v} P_{0}(\Upsilon_{2}\Pi))] \right\|_{L^{2}} \\ & \left\| \left( \mathcal{M}_{4} + \mathcal{M}_{5} \right) [g_{3}(\partial_{v} - t\partial_{z}) (P_{\neq} a \partial_{v} P_{0}(\Upsilon_{2}\Pi))] \right\|_{L^{2}} \\ & \lesssim \left\| \left( \mathcal{M}_{4} + \mathcal{M}_{5} \right) P_{\neq} [(\partial_{v} - t\partial_{z}) (a \partial_{v} P_{0}(\Upsilon_{2}\Pi))] \right\|_{L^{2}} \\ & + \left( \frac{1}{\langle t \rangle^{s}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{9}^{\frac{1}{2}}}^{\frac{1}{2}} \right) \| \mathcal{M}_{3} [(\partial_{v} - t\partial_{z}) (P_{\neq} a \partial_{v} P_{0}(\Upsilon_{2}\Pi))] \|_{L^{2}}. \end{split}$$

We have for  $|\xi - \eta| \le 2|k, \eta|$ , (which is associated with the case *a* is in higher frequencies,)

$$\frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^2+\xi^2} \frac{|\xi-kt|}{\mathcal{B}_k(\eta)} \lesssim \frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^2+\xi^2} \frac{t|\xi-kt|}{t+|\xi|^{\frac{1}{2}}+|k|} \langle \xi-\eta \rangle^{\frac{1}{2}}$$
$$\lesssim \langle t \rangle^3 \langle \xi-\eta \rangle^{\frac{1}{2}},$$

and for  $|\xi - \eta| \ge 2|k, \eta|$ ,

$$\frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^2+\xi^2} |\xi-kt| \Big(\frac{t(t^2+(\xi-\eta)^2)}{2+(\xi-\eta)^2}\Big)^{-1} \lesssim \langle k,\eta \rangle^6 \frac{|\xi-kt|}{t+|\xi|}.$$

Thus we obtain by Remark 6.5 that

$$\begin{aligned} \|\mathcal{M}_{3}[(\partial_{v}-t\partial_{z})(P_{\neq}a\partial_{v}P_{0}(\Upsilon_{2}\Pi))]\|_{L^{2}} &\lesssim \|\mathbf{A}^{*}a\|_{L^{2}}\langle t\rangle^{3}\|\partial_{v}P_{0}(\Upsilon_{2}\Pi)\|_{\mathcal{G}^{s,\sigma-6}} \\ &+ \|a\|_{\mathcal{G}^{s,\sigma-6}}\|\mathcal{M}_{00}\partial_{v}P_{0}(\Upsilon_{2}\Pi)\|_{L^{2}} \lesssim \epsilon^{2} \end{aligned}$$

and by Lemma D.2

$$\begin{split} & \left\| \left( \mathcal{M}_4 + \mathcal{M}_5 \right) P_{\neq} \left[ (\partial_v - t \partial_z) (a \partial_v P_0(\Upsilon_2 \Pi)) \right] \right\|_{L^2} \\ & \lesssim \epsilon \mathcal{C} \mathcal{K}_a^{\frac{1}{2}} + \epsilon \| \mathcal{M}_{01} \partial_v P_0(\Upsilon_2 \Pi) \|_{L^2}. \end{split}$$

Thus we proved the lemma.

Now we introduce two lemmas with weaker weight.

Lemma 10.4. Under the bootstrap hypotheses,

$$\begin{split} \left\| \mathcal{M}_{3}(-\partial_{z}^{2} - (\partial_{v} - t\partial_{z})^{2})^{\frac{1}{2}} \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{2}[\Pi] \right] \right\|_{2} \\ \lesssim \epsilon \left\| \mathcal{M}_{3}(-\partial_{z}^{2} - (\partial_{v} - t\partial_{z})^{2})^{\frac{1}{2}} P_{\neq}(\Upsilon_{2}\Pi) \right\|_{2} \\ \left\| (\mathcal{M}_{4} + \mathcal{M}_{5})(-\partial_{z}^{2} - (\partial_{v} - t\partial_{z})^{2})^{\frac{1}{2}} \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{2}[\Pi] \right] \right\|_{2} \\ \lesssim \epsilon \left( \mathcal{C} \mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{9}^{\frac{1}{2}}}^{\frac{1}{2}} \right) + \epsilon \| (\mathcal{M}_{4} + \mathcal{M}_{5})(-\partial_{z}^{2} - (\partial_{v} - t\partial_{z})^{2})^{\frac{1}{2}} P_{\neq}(\Upsilon_{2}\Pi) \|_{2} \end{split}$$

Lemma 10.5. Under the bootstrap hypotheses,

$$\begin{split} & \left\| \mathcal{M}_{3}(-\partial_{z}^{2} - (\partial_{v} - t\partial_{z})^{2})^{\frac{1}{2}} \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{a}[\Pi] \right] \right\|_{2} \\ & \lesssim \epsilon \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{1}\Pi) \right\|_{2} + \epsilon^{2}, \\ & \left\| (\mathcal{M}_{4} + \mathcal{M}_{5})(-\partial_{z}^{2} - (\partial_{v} - t\partial_{z})^{2})^{\frac{1}{2}} \mathring{\mathcal{T}}_{j,N}^{-1} P_{\neq} \left[ \mathcal{S}_{a}[\Pi] \right] \right\|_{2} \\ & \lesssim \epsilon \left( \mathcal{C} \mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi^{\delta}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{a}^{\frac{1}{2}} + \frac{\epsilon}{\langle t \rangle^{s}} \right) \\ & + \epsilon \left\| (\mathcal{M}_{4} + \mathcal{M}_{5})(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{1}\Pi) \right\|_{2} \\ & + \epsilon \| \mathcal{M}_{01} \partial_{v} P_{0}(\Upsilon_{2}\Pi) \|_{L^{2}}. \end{split}$$

Noticing that, by applying Proposition 10.1, we only need to control

$$\left\|\mathcal{M}_{3}(-\partial_{z}^{2}-(\partial_{v}-t\partial_{z})^{2})^{-\frac{1}{2}}P_{\neq}\left(\mathcal{S}_{2}[\Pi]+\mathcal{S}_{a}[\Pi]\right)\right\|_{2}$$

and

$$\left\| (\mathcal{M}_4 + \mathcal{M}_5)(-\partial_z^2 - (\partial_v - t\partial_z)^2)^{-\frac{1}{2}} P_{\neq} \Big( \mathcal{S}_2[\Pi] + \mathcal{S}_a[\Pi] \Big) \right\|_2.$$

Notice that when the gaining  $(k^2 + (\xi - kt)^2)^{-\frac{1}{2}}$  is weak, namely,  $|\xi| \approx |kt|$ , the weight  $\frac{\langle k \rangle t(t + \langle k \rangle + |\xi|)}{1 + k^2 + \xi^2} \approx$ 1. The above two lemmas can be proved by using the same idea in the proof of Lemma 10.2 and Lemma 10.3, and following the proofs step by step.

*Proof.* We have for  $|\xi - \eta| \le 2|k, \eta|$  and  $k \ne 0$  that

$$\frac{\langle k \rangle t(t+\langle k \rangle+|\xi|)}{1+k^2+\xi^2} \frac{\mathbf{A}_k(\xi)}{(k^2+(\xi-kt)^2)^{\frac{1}{2}}} \lesssim \frac{\langle k \rangle t(t+\langle k \rangle+|\eta|)}{1+k^2+\xi^2} \frac{\langle \xi-\eta \rangle^4}{(k^2+(\eta-kt)^2)^{\frac{1}{2}}} \mathbf{A}_k(\eta) e^{c\lambda\langle\xi-\eta \rangle^8}$$

and for  $|\xi - \eta| \ge 2|k,\eta|$  and  $k \ne 0$ , we have (10.7). Then we have by Remark 6.5 and Lemma D.2,

$$\begin{split} \left\| \mathcal{M}_{3}(-\partial_{z}^{2}-(\partial_{v}-t\partial_{z})^{2})^{-\frac{1}{2}} [g_{2}(\partial_{v}-t\partial_{z})P_{\neq}(\Upsilon_{2}\Pi)] \right\|_{L^{2}} \\ \lesssim \epsilon \left\| \mathcal{M}_{3}(-\partial_{z}^{2}-(\partial_{v}-t\partial_{z})^{2})^{\frac{1}{2}}P_{\neq}(\Upsilon_{2}\Pi) \right\|_{2}, \\ \left\| (\mathcal{M}_{4}+\mathcal{M}_{5})(-\partial_{z}^{2}-(\partial_{v}-t\partial_{z})^{2})^{-\frac{1}{2}}P_{\neq} [g_{2}(\partial_{v}-t\partial_{z})(\Upsilon_{2}\Pi)] \right\|_{L^{2}} \\ \lesssim \left( \mathcal{C}\mathcal{K}_{\theta^{\delta}}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{h}^{\frac{1}{2}} + \mathcal{C}\mathcal{K}_{\varphi^{\delta}}^{\frac{1}{2}} \right) \left\| \mathcal{M}_{3}(\partial_{z}^{2}+(\partial_{v}-t\partial_{z})^{2})P_{\neq}(\Upsilon_{2}\Pi) \right\|_{2} \\ + \epsilon \| (\mathcal{M}_{4}+\mathcal{M}_{5})(-\partial_{z}^{2}-(\partial_{v}-t\partial_{z})^{2})^{\frac{1}{2}}P_{\neq}(\Upsilon_{2}\Pi) \|_{2}. \end{split}$$

This gives Lemma 10.4.

Proof. By using the same idea of the proof of Lemma 10.3, we only need to estimate

$$\|\mathcal{M}_3 P_{\neq}[(a(\partial_v - t\partial_z)P_{\neq}(\Upsilon_2\Pi))]\|_{L^2}, \quad \|\mathcal{M}_3 P_{\neq}[(a\partial_z P_{\neq}(\Upsilon_2\Pi))]\|_{L^2}$$

and

$$\left\| \left( \mathcal{M}_4 + \mathcal{M}_5 \right) P_{\neq} \left[ \left( a(\partial_v - t\partial_z) P_{\neq}(\Upsilon_2 \Pi) \right) \right] \right\|_{L^2}.$$

Considering the support of a, we have  $a(\partial_v - t\partial_z)P_{\neq}(\Upsilon_2\Pi) = a(\partial_v - t\partial_z)P_{\neq}(\Upsilon_1\Pi)$ . Thus we use  $\Upsilon_1\Pi$  and estimate

$$\|\mathcal{M}_3 P_{\neq}[(a(\partial_v - t\partial_z) P_{\neq}(\Upsilon_1 \Pi))]\|_{L^2}, \quad \|\mathcal{M}_3 P_{\neq}[(a\partial_z P_{\neq}(\Upsilon_1 \Pi))]\|_{L^2}$$

and

$$\left\| \left( \mathcal{M}_4 + \mathcal{M}_5 \right) P_{\neq} \left[ \left( a(\partial_v - t\partial_z) P_{\neq}(\Upsilon_1 \Pi) \right) \right] \right\|_{L^2}$$

We have by Lemma D.4 and Remark 6.5 that for  $|k - l, \eta - \xi| \le |l, \eta|, k \ne 0, l \ne 0$ 

$$\begin{aligned} \mathcal{M}_{3}(t,k,\xi)(|l|+|\eta-lt|) \\ &\lesssim \mathcal{M}_{3}(t,l,\eta)(|l|+|\eta-lt|)e^{\lambda|k-l,\eta-\xi|^{s}} \\ &+ A_{l}(\eta)\frac{\langle k\rangle t(t+\langle k\rangle+|\xi|)}{1+k^{2}+\xi^{2}}\frac{|\xi|(|l|+|\eta-lt|)}{k^{2}+(\xi-kt)^{2}}\mathbf{1}_{t\in\mathbf{I}_{k,\xi}\cap\mathbf{I}_{k,\eta},k\neq l} \\ &\lesssim \mathcal{M}_{3}(t,l,\eta)e^{c\lambda|k-l,\eta-\xi|}\langle k-l,\eta-\xi\rangle^{5} + A_{l}(\eta)\frac{\xi/k}{\eta/l}|l|^{2}\left\langle t-\frac{\eta}{l}\right\rangle^{2}e^{c\lambda|k-l,\eta-\xi|} \\ &\lesssim e^{c\lambda|k-l,\eta-\xi|}\mathcal{M}_{3}(t,l,\eta)(|l|+|\eta-lt|)^{2}. \end{aligned}$$

The lemma follows from Remark 6.5 and Lemma D.2.

10.1. Estimate of  $\Pi_{l,1}$ . In this section, we obtain the estimate for  $P_{\neq}(\Pi_{l,1})$ . We only need to estimate  $\mathcal{M}_3(\partial_z^2 + (\partial_v - t\partial_z)^2)\mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi_1]$ ,  $\mathcal{M}_4(\partial_z^2 + (\partial_v - t\partial_z)^2)\mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi_1]$ , and  $\mathcal{M}_5(\partial_z^2 + (\partial_v - t\partial_z)^2)\mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi_1]$ , where

$$\Xi_1 = \underline{\varphi_6} \partial_{zz} (\Upsilon_2 \Psi) + \underline{\varphi_7} P_{\neq} (\Upsilon_2 \Psi)$$

By Proposition 10.1, we have

(10.8)  
$$\begin{aligned} \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi_{1}] \right\|_{2} \lesssim \left\| \mathcal{M}_{3}[P_{\neq}\Xi_{1}] \right\|_{2}, \\ \left\| \mathcal{M}_{4}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi_{1}] \right\|_{2} \lesssim \left\| \mathcal{M}_{4}[P_{\neq}\Xi_{1}] \right\|_{2}, \\ \left\| \mathcal{M}_{5}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\Xi_{1}] \right\|_{2} \lesssim \left\| \mathcal{M}_{5}[P_{\neq}\Xi_{1}] \right\|_{2}. \end{aligned}$$

By using

(10.9) 
$$(|t| + |k| + |\xi|)|k| \lesssim \langle k, \xi \rangle (|\xi - kt| + |k|), \text{ for } k \neq 0,$$

and Remark 6.5, we then have for  $2|k,\eta| \ge |\xi - \eta|, k \ne 0$ ,

$$\begin{aligned} |k|^2 \frac{\langle k \rangle t(t + \langle k \rangle + |\xi|)}{1 + k^2 + \xi^2} \mathcal{A}_k(\xi) &\lesssim |k^2| \mathcal{A}_k(\eta) \langle \xi - \eta \rangle^3 \frac{\langle k \rangle t(t + \langle k \rangle + |\eta|)}{1 + k^2 + \eta^2} e^{c\lambda |\xi - \eta|^s} \\ &\lesssim \frac{t|k|^2|k, \eta|(|k| + |tk - \eta|)}{1 + k^2 + \eta^2} \frac{|\eta| + |kt|}{|kt|} \left\langle \frac{\eta}{kt} \right\rangle^{-1} \mathcal{A}_k(\eta) e^{c\lambda |\xi - \eta|^s} \\ &\lesssim (k^2 + (\eta - kt)^2) \left\langle \frac{\eta}{kt} \right\rangle^{-1} \mathcal{A}_k(\eta) e^{c\lambda |\xi - \eta|^s}. \end{aligned}$$

and for  $2|k,\eta| \le |\xi - \eta|, \ k \ne 0$ ,

$$|k|\frac{\langle k\rangle t(t+\langle k\rangle+|\xi|)}{1+k^2+\xi^2}\mathbf{A}_k(\xi) \lesssim \mathbf{A}^{\mathbf{R}}(\xi-\eta)e^{\lambda|k,\eta|^s}\langle t\rangle^2\langle k\rangle^2$$

Thus we get that

(10.10) 
$$\|\mathcal{M}_3[P_{\neq}\Xi_1]\|_2 \lesssim \langle t \rangle^2 \|P_{\neq}(\Upsilon_2\Psi)\|_{\mathcal{G}^{s,\sigma-6}} + \left\|\left\langle \frac{\partial_v}{t\partial_z} \right\rangle^{-1} (\partial_z^2 + (\partial_v - t\partial_z)^2) \mathrm{A}P_{\neq}(\Psi\Upsilon_2)\right\|_2 \lesssim \epsilon.$$

By Lemma D.2, we have

$$\begin{split} \left\| \left( \mathcal{M}_{4} + \mathcal{M}_{5} \right) [P_{\neq} \Xi_{1}] \right\|_{2} &\lesssim \left( \frac{1}{\langle t \rangle^{s}} + \mathcal{C} \mathcal{K}_{\varphi_{6}^{\frac{1}{2}}}^{\frac{1}{2}} + \mathcal{C} \mathcal{K}_{\varphi_{7}^{\frac{1}{2}}}^{\frac{1}{2}} \right) \langle t \rangle^{2} \| P_{\neq}(\Upsilon_{2}\Psi) \|_{\mathcal{G}^{s,\sigma-6}} \\ &+ \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} (\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \left( \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathbf{A} + \sqrt{\frac{\partial_{t}w}{w}} \tilde{\mathbf{A}} \right) P_{\neq}(\Psi\Upsilon_{2}) \right\|_{2}. \end{split}$$

Now we prove Proposition 7.9 for  $\Pi_{\star} = \Upsilon_2 \Pi_{l,1}$ .

*Proof.* By (10.5), Lemma 10.2, Lemma 10.3, (10.8), and (10.10), we get that  $\|AA(2)^2 + (2 - (2))^2 P(2) - P(2) \| = 0$ 

$$\begin{split} \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{2}\Pi_{l,1}) \right\|_{2} \\ \lesssim \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{2,N}^{-1}[P_{\neq}\Xi_{1}] \right\|_{2} + \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{j,N}^{-1}[P_{\neq}\mathcal{S}_{2}[\Pi_{l,1}]] \right\|_{2} \\ + \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \mathring{\mathcal{T}}_{2,N}^{-1}[P_{\neq}\mathcal{S}_{a}[\Pi_{l,1}]] \right\|_{2} \\ \lesssim \epsilon + \epsilon \left\| \mathcal{M}_{3}(\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) P_{\neq}(\Upsilon_{2}\Pi_{l,1}) \right\|_{2} + \epsilon^{2} \end{split}$$

and

10.2. Estimate of  $\Pi_{l,2}$ . The  $\Pi_{l,2}$  term arose from the boundary correction. It seems worse than  $\Pi_{l,1}$ . However, on the support of  $\underline{\varphi}_8$ ,  $\Upsilon_1 = 0$ . Thus to estimate  $\Pi_{l,2}$ , we use two steps. First, we get the estimate of  $\Pi_{l,2}$  using equation (5.7f). Second, we obtain an improved estimate for  $\Upsilon_1 \Pi_{l,2}$ , namely, we study the following equation:

where

$$\Xi_{4} = -2\underline{\chi_{2}}(\underline{\partial_{y}v}(\partial_{v} - t\partial_{z})\partial_{z}(\Upsilon_{2}\Psi))^{2} - 2\partial_{zz}(\Upsilon_{2}\Psi)\left(\Omega - \underline{\chi_{2}}\partial_{zz}(\Upsilon_{2}\Psi)\right), - 2\underline{\chi_{2}'}\partial_{y}v\Big[(\partial_{z}(\Upsilon_{2}\Psi))(\partial_{v} - t\partial_{z})\partial_{z}(\Upsilon_{2}\Psi) + (\partial_{v} - t\partial_{z})(\Upsilon_{2}\Psi)\partial_{zz}(\Upsilon_{2}\Psi)\Big] - \frac{1}{2}\underline{\chi_{2}''}\Big[(\partial_{z}(\Upsilon_{2}\Psi))^{2} + (\underline{\partial_{y}v})^{2}((\partial_{v} - t\partial_{z})P_{\neq}(\Upsilon_{2}\Psi))^{2}\Big].$$

We have  $k, l \neq 0$  and  $k \neq l$ ,

which gives that for  $f \in A_3$ ,  $\|\mathcal{M}_3 f\|_2 \lesssim \epsilon^2$ . By Lemma D.2, it holds that

By Remark 6.5 and (10.9), we have for

Thus we prove the lemma.

10.4. Estimate of  $\Pi_{n,2}$ . The strategy of estimating  $\Pi_{n,2}$  is similar to the estimate of  $\Pi_{l,2}$ . We first get estimate for  $P_{\neq}(\Upsilon_2 \Pi_{n,2})$ , where we use Corollary 8.4. Then we study the elliptic equation for  $P_{\neq}(\Upsilon_1\Pi_{n,2})$ :

The proof is similar. We omit the details.

#### 11. TRANSPORT TERMS

The transport structure in the equation of a and f are similar. Here we only present the proof for a. We rewrite  $I_a^{tr}$  as

where T, R, and  $\mathcal{R}$  are given by using the paraproduct decomposition:

Similarly, we have the decomposition for  $I_f^{tr}$  as in (11.1) by replacing A<sup>\*</sup> by A and replacing a by f. We denote them by  $T_N^f$ ,  $R_N^f$ , and  $\mathcal{R}^f$  respectively, also see (2.26) of [5]. By Sobolev embedding,  $\sigma > 5$  and the bootstrap hypotheses, we have

For  $\mathcal{T}_{N}^{f}$  term, we have an even simpler decomposition and there are no  $\mathcal{T}_{N,1}^{f}$  and  $\mathcal{T}_{N,2}^{f}$ . By fact that  $|l,\xi| \approx |k,\eta|, |k\xi - l\eta| \leq |k - l, \eta - \xi||l,\xi|$ , and

$$e^{\lambda|k,\eta|^s} \le e^{\lambda|l,\xi|^s + c\lambda|k-l,\eta-\xi|^s} \le e^{c\lambda|l,\zeta|^s + c\lambda|\xi-\zeta|^s + c\lambda|k-l,\eta-\xi|^s}$$

and

$$\mathbf{J}_{k}(\eta) \lesssim e^{2\mu|k,\eta|^{\frac{1}{2}}} \leq e^{2\mu|l,\zeta|^{\frac{1}{2}} + 2\mu|\xi-\zeta|^{\frac{1}{2}} + 2\mu|k-l,\eta-\xi|^{\frac{1}{2}}}$$

and

$$\frac{\mathbf{B}_k(t,\eta)}{\mathbf{B}_{k-l}(t,\eta-\xi)} \lesssim \langle k,\eta \rangle \lesssim 1 + |l,\zeta| + |\xi-\zeta| + |k-l,\eta-\xi|$$

Thus we have

$$\begin{split} I_{f,9} &= -\frac{1}{2\pi} \sum_{0 < |k| < k_M} \int_{\mathbb{R}} \mathcal{A}_k(t,\eta)^2 \mathcal{F}_2 \Big( \mathbf{D}_{u,k} \left( \mathcal{F}_1 \Big( \underline{\varphi_2} \partial_z \Psi \Omega \Big) \right) \Big)_k(t,\eta) \overline{\widehat{f}_k(t,\eta)} d\eta \\ &- \frac{1}{2\pi} \sum_{0 < |k| < k_M} \int_{\mathbb{R}} \mathcal{A}_k(t,\eta)^2 \mathcal{F}_2 \Big( \mathbf{D}_{u,k} \left( \mathcal{F}_1 \Big( \underline{\varphi_3} \partial_z \Psi \underline{\partial_y v} (\partial_v - t \partial_z) \Psi \Big) \right) \Big)_k(t,\eta) \overline{\widehat{f}_k(t,\eta)} d\eta \\ &= I_{f,9}^1 + I_{f,9}^2. \end{split}$$

The estimates are similar to each other. Here we present the treatment of the most technical term  $I_{f,9}^1$  which involves the wave operator. By Proposition 4.11, we have

12.1. The low-high interactions. For the low-high interaction, the estimate is easy. We have by Lemma D.4

The treatment of  $I_{f,9,\text{HL,HH}}^1$  is similar to that of  $\mathbf{R}^a_{\mathbf{N},4}$ . We have

$$I_{f,9,\mathrm{HL,HH}}^{1} \lesssim \frac{\epsilon^{3}}{\langle t \rangle^{2}} + \epsilon \mathcal{C}\mathcal{K}_{f} + \epsilon \left\| \left\langle \frac{\partial_{v}}{t\partial_{z}} \right\rangle^{-1} (\partial_{z}^{2} + (\partial_{v} - t\partial_{z})^{2}) \frac{|\nabla|^{\frac{s}{2}}}{\langle t \rangle^{s}} \mathrm{A}P_{\neq}(\Psi\Upsilon_{2}) \right\|_{2}^{2}$$

12.3. The high-high interactions. The treatment of  $I_{f,9,\text{HH}}^1$  is even simpler than that of  $\mathcal{R}^a$ . We have

## 13. Linear force term in $I_a$

$$\lesssim e^{c\lambda|\eta-\xi|^{s}}\left((\xi-kt)^{2}+k^{2}\right)\left\langle\frac{\xi}{kt}\right\rangle^{-1}\frac{|\xi|^{\frac{s}{2}}|k,\eta|^{\frac{s}{2}}}{\langle t\rangle^{2}}.$$

3. if  $2|\xi| > t \ge 2\sqrt{|\xi|}$ , then  $t \in \mathcal{I}_{l,\xi} \cap \mathcal{I}_{j,\eta}$  for some l, j, and

### APPENDIX A. GEVREY SPACES

The physical space characterization of Gevrey functions is also used in this paper. We start with a characterization of the Gevrey spaces on the physical side. See *Lemma A.1* in [18] for the elementary proof.

**Lemma A.1** ([18]). Suppose that d = 1, 2, 0 < s < 1, K > 1 and  $g \in C^{\infty}(\mathbb{R}^d)$  with supp  $g \subset [a, b]^d$  satisfies the bounds

By Stirling's formula  $N! \sim \sqrt{2\pi N} (N/e)^N$ , it is easy to check that there exist  $K_1 < K_2$  such that

$$K_1^m (m+1)^{m/s} \lesssim \Gamma_s(m) \lesssim K_2^m (m+1)^{m/s}$$

which implies

(A.9) 
$$\mathcal{G}_{ph}^{K_1M,s}([a,b]^d) \subset \mathcal{G}_{ph,1}^{M,s}([a,b]^d) \subset \mathcal{G}_{ph}^{K_2M,s}([a,b]^d).$$

We also have

(A.10) 
$$\sum_{j=0}^{k} \frac{k!}{j!(k-j)!} \Gamma_s(j) \Gamma_s(k-j) < \Gamma_s(k),$$

which implies

(A.11) 
$$\|fg\|_{\mathcal{G}_{ph,1}^{M,s}([a,b]^d)} \le \|f\|_{\mathcal{G}_{ph,1}^{M,s}([a,b]^d)} \|g\|_{\mathcal{G}_{ph,1}^{M,s}([a,b]^d)}.$$

**Remark A.2.** Suppose  $g \in \mathcal{G}_{ph,1}^{M,s}(\mathbb{R}^d)$  with  $\operatorname{supp} g \subset [a,b]^d$ , then for all integers  $m \geq 0$  and multiindices  $\alpha$  with  $|\alpha| = m$ . Then

(A.12) 
$$|\hat{g}(\xi)| \lesssim_{K,s} Le^{-\mu|\xi|^s},$$

for all  $\xi \in \mathbb{R}^d$  and some  $\mu = \mu(K, s) > 0$ .

We also introduce the composition lemma in [37].

**Lemma A.3** ([37]). Let I, J be real open intervals and let  $f: J \to \mathbb{R}$  be a  $C^{\infty}$ -function such that  $f' \in \mathcal{G}_{ph,1}^{L,s}(J)$  and  $g: I \to J$  be a  $C^{\infty}$ -function such that  $g' \in \mathcal{G}_{ph,1}^{M,s}(I)$ . Let N be a real constant such that

$$N \ge \max(M, L \|g'\|_{\mathcal{G}^{M,s}_{ph,1}(I)}).$$

Then the derivative  $(f \circ g)'$  of the composite function  $f \circ g$  belongs to  $\mathcal{G}_{ph,1}^{N,s}(I)$  and satisfies

$$\|(f \circ g)'\|_{\mathcal{G}^{N,s}_{ph,1}(I)} \le \frac{N}{L} \|f'\|_{\mathcal{G}^{L,s}_{ph,1}(J)}.$$

We also introduce the estimate of the inverse function in the Gevrey class.

**Lemma A.4** ([37]). Let I and J be real open intervals. Let  $f: I \to J$  be a  $C^{\infty}$ -surjection such that

$$|f'(x)| \ge \frac{1}{A}, \quad x \in I$$

for some A > 0 and such that  $f'' \in \mathcal{G}_{ph,1}^{L,s}(I)$ . Then f has a  $C^{\infty}$ -inverse  $f^{-1} : J \to I$  such that  $(f^{-1})' \in \mathcal{G}_{ph,1}^{M,s}(J)$  for some M > 0.

### APPENDIX B. THE FOURIER TRANSFORM OF THE INTEGRAL OPERATOR

In this section, we make some preparations to study the Gevrey regularity of the nonlocal part of the wave operator. Indeed, we will write the nonlocal part into the following four types of integral operators:

$$\Pi_m(F)(v') = \int_{\mathbb{R}} K(v, v') \mu_m(v - v') e^{-ikt(v - v')} F(v) dv, \quad m = 1, 2, 3, 4,$$
  
$$\Pi_m^*(F)(v) = \int_{\mathbb{R}} K(v, v') \mu_m(v - v') e^{-ikt(v - v')} F(v') dv', \quad m = 1, 2, 3, 4,$$

where K(v, v') represents a smooth kernel with compact support which may vary from one line to the other, and  $\mu_1 \in C^{\infty}(\mathbb{R})$  with compact support such that

$$\mu_1(u) = \begin{cases} 1, |u| \le u(1) - u(0), \\ 0, |u| \ge 2(u(1) - u(0)). \end{cases}$$

 $\mu_2(u) = \mu_1(u) \mathbf{1}_{\mathbb{R}^-}(u) \text{ and } \mu_3(u) = \mu_1(u) \ln |u|, \ \mu_4(u) = p.v.\frac{1}{u}. \text{ Thus it holds that}$ (B.1)  $|\widehat{\mu_1}(\xi)| + |\widehat{\mu_2}(\xi)| + |\widehat{\mu_3}(\xi)| + |\widehat{\mu_4}(\xi)| \lesssim 1$ 

It is easy to check that  $\Pi_m^*$ , m = 1, 2, 3, 4 are the dual operators of  $\Pi_m$ , m = 1, 2, 3, 4.

For a smooth kernel with compact support defined on  $\mathbb{R}^2$ , let  $\widehat{K}$  be the Fourier transform in the first variable and  $\widehat{\widehat{K}}$  be the Fourier transform in both variables.

**Lemma B.1.** Suppose  $K(v, v') \in C^{\infty}(\mathbb{R}^2)$  with compact support, then it holds for m = 1, 2, 3, 4 that

$$\widehat{\Pi_m(F)}(\eta) = \frac{1}{2\pi} \int_{\mathbb{R}^2} \hat{F}(\xi) \widehat{\hat{K}}(-\xi - \xi', \eta + \xi') \widehat{\mu_m}(\xi' + kt) d\xi' d\xi,$$

and

$$\widehat{\Pi_m^*(F)}(\xi) = \frac{1}{2\pi} \int_{\mathbb{R}^2} \hat{F}(\eta) \widehat{\hat{K}}(-\xi - \xi', \eta + \xi') \widehat{\mu_m}(\xi' + kt) d\xi' d\eta.$$

*Proof.* Let  $K_L(v - v', v') = K(v, v')$ , then we have that

$$\Pi_{m}(F)(v') = \int_{\mathbb{R}} K_{L}(v - v', v')\mu_{m}(v - v')e^{-ikt(v - v')}F(u)dv$$
  

$$= \frac{1}{2\pi} \int_{\mathbb{R}} K_{L}(v - v', v')\mu_{m}(v - v')e^{-ikt(v - v')} \int_{\mathbb{R}} \hat{F}(\xi)e^{i\xi v}d\xi dv$$
  

$$= \frac{1}{2\pi} \int_{\mathbb{R}} \hat{F}(\xi)e^{iv'\xi} \int_{\mathbb{R}} K_{L}(v - v', v')\mu_{m}(v - v')e^{-ikt(v - v')}e^{i\xi(v - v')}dvd\xi$$
  

$$= \frac{1}{2\pi} \int_{\mathbb{R}} \hat{F}(\xi)e^{iv'\xi}\mathcal{F}_{1}(K_{L}(\cdot, v')\mu_{m})(-\xi + kt)d\xi$$
  

$$= \frac{1}{2\pi} \int_{\mathbb{R}} \int_{\mathbb{R}} \hat{F}(\xi)e^{iv'\xi}\widehat{K_{L}}(-\xi - \xi', v')\widehat{\mu_{m}}(\xi' + kt)d\xi'd\xi.$$

Thus we get that

$$\widehat{\Pi_m(F)}(\eta) = \frac{1}{2\pi} \int_{\mathbb{R}^2} \widehat{F}(\xi) \widehat{\widehat{K_L}}(-\xi - \xi', \eta - \xi) \widehat{\mu_m}(\xi' + kt) d\xi' d\xi.$$

We also have

$$\widehat{\widehat{K}_L}(\xi,\eta) = \int_{\mathbb{R}^2} K_L(w,v') e^{-iw\xi - ic\eta} dw dv'$$
  
= 
$$\int_{\mathbb{R}^2} K_L(v-v',v') e^{-i(v-v')\xi - iv'\eta} dv dv'$$
  
= 
$$\int_{\mathbb{R}^2} K(v,v') e^{-i(v-v')\xi - iv'\eta} dv dv' = \widehat{\widehat{K}}(\xi,\eta-\xi),$$

which gives the first identity and the second identity can be obtained by the same argument.  $\Box$ 

**Lemma B.2.** Suppose  $K(v, v') \in \mathcal{G}_{ph,1}^{M,s_0}(\mathbb{R}^2)$  with compact support in  $[u(0), u(1)]^2$ , then there exists  $\lambda = \lambda(M, s_0)$ , such that for m = 1, 2, 3, 4,

(B.2) 
$$\left| \int \widehat{\widehat{K}}(-\xi - \xi', \eta + \xi')\widehat{\mu_m}(\xi' + kt)d\xi' \right| \lesssim e^{-\lambda|\eta - \xi|^{s_0}}.$$

*Proof.* This lemma follows directly from (B.1), Remark A.2 and the fact that

$$\int_{\mathbb{R}} e^{-\lambda' (|\xi+\xi'|^2 + |\eta+\xi'|^2)^{\frac{s_0}{2}}} d\xi' \lesssim \int_{\mathbb{R}} \frac{e^{-\lambda|\xi-\eta|^{s_0}}}{1 + |\xi+\xi'|^2 + |\eta+\xi'|^2} d\xi' \lesssim e^{-\lambda|\xi-\eta|^{s_0}},$$
  
$$0 < \lambda < \lambda'.$$

holds for  $0 < \lambda < \lambda'$ .

**Remark B.3.** We also point out that if the regularity assumption on K(v, v') is replaced by

(B.3) 
$$\sup_{m \ge 0} \frac{\|(\partial_v + \partial_{v'})^m (1 - \partial_{vv} - \partial_{v'v'}) K(v, v')\|_{L^1}}{\Gamma_s(m) M^m} \le C,$$

then (B.2) also holds. Indeed, the weaker regularity assumption (B.3) implies that there is  $\lambda$  such that

(B.4) 
$$|\widehat{\widehat{K}}(\xi,\eta)| \lesssim \frac{e^{-\lambda|\xi+\eta|^s}}{1+|\xi|^2+|\eta|^2}.$$

Then (B.2) follows directly from (B.1).

### APPENDIX C. STURM-LIOUVILLE EQUATION

In this section, we consider two elliptic equations:

$$\begin{cases} \widetilde{\varphi_2}\partial_{zz}\Psi + \widetilde{u'}(\partial_v - t\partial_z)\Big(\widetilde{\varphi_2}\widetilde{u'}(\partial_v - t\partial_z)\Psi\Big) = \Omega, \\ \Psi(t, z, u(0)) = \Psi(t, z, u(1)) = 0, \end{cases}$$

and

(C.2) 
$$\begin{cases} \widetilde{\theta}\partial_{zz}\Pi + \widetilde{u'}(\partial_v - t\partial_z)\left(\widetilde{\theta}\widetilde{u'}(\partial_v - t\partial_z)\Pi\right) = \Xi\Upsilon,\\ (\partial_v - t\partial_z)\Pi(t, z, u(0)) = (\partial_v - t\partial_z)\Pi(t, z, u(1)) = 0 \end{cases}$$

For the first equation (C.1), if we let

(C.3) 
$$\mathfrak{Q} = \mathcal{F}_1[\Psi](t,k,v)e^{-itkv}$$

then  $\mathfrak Q$  solves

$$\begin{cases} \partial_v (h_1(v)\partial_v \mathfrak{Q}) - k^2 h_2(v) \mathfrak{Q} = \mathfrak{F}(v,k) \\ \mathfrak{Q}(\alpha,k) = \mathfrak{Q}(\beta,k) = 0 \end{cases}$$

where

(C.4) 
$$\begin{aligned} \alpha &= u(0), \ \beta = u(1), \ \mathfrak{F}(v,k) = \widetilde{u'}(v)^{-1} \mathcal{F}_1[\Omega] e^{-iktv}, \\ h_1(v) &= \widetilde{\varphi_2} \widetilde{u'}(v), \ h_2(v) = \widetilde{\varphi_2}(v) \widetilde{u'}(v)^{-1}. \end{aligned}$$

For the second equation (C.2), if we let

(C.5) 
$$\mathfrak{R} = \mathcal{F}_1[\Pi](t,k,v)e^{-itkv}$$

then  $\Re$  solves

$$\begin{cases} \partial_v (h_1(v)\partial_v \mathfrak{R}) - k^2 h_2(v) \mathfrak{R} = \mathfrak{G}(v,k) \\ \partial_v \mathfrak{R}(\alpha,k) = \partial_v \mathfrak{R}(\beta,k) = 0 \end{cases}$$

where

(C.6) 
$$\begin{aligned} \alpha &= u(0), \ \beta = u(1), \ \mathfrak{G}(v,k) = \widetilde{u'}(v)^{-1} \mathcal{F}_1[\Xi] e^{-iktv}, \\ h_1(v) &= \widetilde{\theta}\widetilde{u'}(v), \ h_2(v) = \widetilde{\theta}(v)\widetilde{u'}(v)^{-1}. \end{aligned}$$

Both equations are Sturm-Liouville Equations.

C.1. **Dirichlet boundary conditions.** In this section, we study the general Sturm-Liouville Equation

(C.7) 
$$\begin{cases} \partial_v (h_1(v)\partial_v \mathfrak{Q}) - k^2 h_2(v)\mathfrak{Q} = \mathfrak{F}(v,k) \\ \mathfrak{Q}(\alpha,k) = \mathfrak{Q}(\beta,k) = 0 \end{cases}$$

where  $h_1, h_2$  are positive functions and  $\operatorname{supp} h'_j \subset [\alpha_1, \beta_1]$  for j = 1, 2 with  $\alpha < \lambda_1 < \beta_1 < \beta$ . We also assume that  $h'_1, h'_2 \in \mathcal{G}_{ph}^{M,s}([\alpha, \beta])$ . Let us first study the homogeneous equation.

**Lemma C.1.** There exist positive functions  $\mathfrak{q}_{\alpha}(v,k)$ ,  $\mathfrak{q}_{\beta}(v,k) \geq 1$  such that  $\mathfrak{q}_{\alpha}(\alpha,k) = \mathfrak{q}_{\beta}(\beta,k) = 1$ ,  $\mathfrak{q}'_{\alpha}(\alpha,k) = \mathfrak{q}'_{\beta}(\alpha,k) = 0$ , and  $\mathfrak{q}_{\alpha}(v,k)$  solves

$$\mathbf{q}_{\alpha}(v,k) = 1 + k^2 \int_{\alpha}^{v} \frac{1}{h_1(v')} \int_{\alpha}^{v'} h_2(v'') \mathbf{q}_{\alpha}(v'',k) dv'' dv',$$

and  $q_{\beta}(v,k)$  solves

$$\mathfrak{q}_{\beta}(v,k) = 1 + k^2 \int_{\beta}^{v} \frac{1}{h_1(v')} \int_{\beta}^{v'} h_2(v'') \mathfrak{q}_{\beta}(v'',k) dv'' dv'$$

Moreover, it holds for  $v \in [\alpha, \beta]$  that

(C.8)  

$$C^{-1}\min\{|k|^{2}(v-\alpha),|k|\} \leq \frac{\mathfrak{q}_{\alpha}'(v,k)}{\mathfrak{q}_{\alpha}(v,k)} \leq C\min\{|k|^{2}(v-\alpha),|k|\}$$

$$C^{-1}\min\{|k|^{2}(\beta-v),|k|\} \leq -\frac{\mathfrak{q}_{\beta}'(v,k)}{\mathfrak{q}_{\beta}(v,k)} \leq C\min\{|k|^{2}(\beta-v),|k|\}$$

(C.9) 
$$e^{C^{-1}|k||v-\alpha|} \le \mathfrak{q}_{\alpha}(v,k) \le e^{C|k||v-\alpha|}, \quad e^{C^{-1}|k||v-\beta|} \le \mathfrak{q}_{\beta}(v,k) \le e^{C|k||v-\beta|}.$$

The Wronskian is

$$W[\mathfrak{q}_{\alpha},\mathfrak{q}_{\beta}](v) = \frac{\mathfrak{q}_{\beta}'(\alpha)h_1(\alpha)}{h_1(v)} = -\frac{\mathfrak{q}_{\alpha}'(\beta)h_1(\beta)}{h_1(v)} < 0.$$

which also implies

$$-\frac{\mathfrak{q}_{\beta}'(\alpha)}{\mathfrak{q}_{\alpha}'(\beta)} \approx \frac{\mathfrak{q}_{\beta}(\alpha)}{\mathfrak{q}_{\alpha}(\beta)} \approx 1.$$

*Proof.* We only show the proof for  $\mathfrak{q}_{\alpha}$ .

**Existence.** It is easy to show that  $T[\mathfrak{q}_{\alpha}] = \int_{\alpha}^{v} \frac{1}{h_{1}(v')} \int_{\alpha}^{v} h_{2}(v'')\mathfrak{q}_{\alpha}(v'',k)dv''dv'$  is a contraction map in the weighted Gevrey space  $\mathcal{G}_{ph,\cosh}^{M|k|,s}([\alpha,\beta]) \stackrel{\text{def}}{=} \{f \in C^{\infty}([\alpha,\beta]) : \|f\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s}([\alpha,\beta])} < \infty\}$  by taking M large enough, where

$$\|f\|_{\mathcal{G}_{ph,\cosh}^{M|k|,s}([\alpha,\beta])} \stackrel{\text{def}}{=} \sup_{v \in [\alpha,\beta], m \ge 0} \frac{|\partial_v^m f|}{\Gamma_s(m)M^m|k|^m \cosh M|k|(v-\alpha)}$$

and  $\Gamma_s(m) = (m!)^{\frac{1}{s}}(m+1)^{-2}$ . The proof is simpler than the proof of Proposition 4.8. We omit the details. Note that T is a positive operator, then  $\mathfrak{q}_{\alpha}(v,k) \geq 1$  and  $\mathfrak{q}'_{\alpha}(v,k) \geq 0$ . **Estimates.** Let  $\mathfrak{f}_{\alpha} = h_1 \mathfrak{q}'_{\alpha}/\mathfrak{q}_{\alpha}$ , then  $\mathfrak{f}'_{\alpha} + \mathfrak{f}^2_{\alpha}/h_1 = k^2 h_2$  which gives that  $0 \leq \mathfrak{f}_{\alpha} \leq |k| \sqrt{h_2 h_1}$  and thus  $0 \leq \mathfrak{q}'_{\alpha}/\mathfrak{q}_{\alpha} \leq |k| \sqrt{h_2 / h_1} \leq C|k|$ . Therefore, we have for  $v'' \leq v$ 

$$1 \ge \frac{\mathfrak{q}_{\alpha}(v'',k)}{\mathfrak{q}_{\alpha}(v,k)} \ge e^{-C|k||v''-v|}.$$

We have for  $|v - \alpha| \leq \frac{1}{|k|}$ ,

$$\frac{\mathfrak{q}_{\alpha}'(v,k)}{\mathfrak{q}_{\alpha}(v,k)} = \frac{k^2}{h_1(v)} \int_{\alpha}^{v} h_2(v'') \frac{\mathfrak{q}_{\alpha}(v'',k)}{\mathfrak{q}_{\alpha}(v,k)} dv'' \approx k^2(v-\alpha).$$

As for  $|v - \alpha| \ge \frac{1}{|k|}$ , we have

$$\frac{\mathfrak{q}_{\alpha}'(v,k)}{\mathfrak{q}_{\alpha}(v,k)} \ge \frac{k^2}{h_1(v)} \int_{v-\frac{1}{2|k|}}^{v} h_2(v'') \frac{\mathfrak{q}_{\alpha}(v'',k)}{\mathfrak{q}_{\alpha}(v,k)} dv'' \ge C^{-1}|k|.$$

Combining the above estimates, we get (C.8), (C.9) follows directly.

Let us now computer the Wronskian. A direct calculation gives

$$\partial_v \Big( h_1 W[\mathbf{q}_\alpha, \mathbf{q}_\beta] \Big) = 0$$

which gives the formula of the Wronskian.

Let us now construct two linearly independent solutions  $q_l$  and  $q_r$ :

 $\mathbf{q}_l(v,k) = \mathbf{q}_\alpha(v,k) - \mathbf{q}_\beta(v,k)/\mathbf{q}_\beta(\alpha,k)$ (C.10)

(C.11) 
$$q_r(v,k) = q_\beta(v,k) - q_\alpha(v,k)/q_\alpha(\beta,k)$$

With the homogeneous solution  $q_r$  and  $q_l$ , we get that

$$\mathfrak{Q}(v,k) = \frac{1}{h_1(v)} \frac{\mathfrak{q}_r(v,k)}{W[\mathfrak{q}_r,\mathfrak{q}_l]} \int_0^v \mathfrak{q}_l(v',k) \mathfrak{F}(v',k) h_1(v') dv' + \frac{1}{h_1(v)} \frac{\mathfrak{q}_l(v,k)}{W[\mathfrak{q}_r,\mathfrak{q}_l]} \int_v^1 \mathfrak{q}_r(v',k) \mathfrak{F}(v',k) h_1(v') dv',$$
where

where

(

$$W[\mathfrak{q}_r,\mathfrak{q}_l] = \left(1 - \frac{1}{\mathfrak{q}_\alpha(\beta)\mathfrak{q}_\beta(\alpha)}\right)W[\mathfrak{q}_\alpha,\mathfrak{q}_\beta](v) = \left(1 - \frac{1}{\mathfrak{q}_\alpha(\beta)\mathfrak{q}_\beta(\alpha)}\right)\frac{\mathfrak{q}_\beta'(\alpha)h_1(\alpha)}{h_1(v)}$$

We also express  $\mathfrak{Q}(v,k)$  by using  $\mathfrak{q}_{\alpha}$  and  $\mathfrak{q}_{\beta}$ .

$$\mathfrak{Q}(v,k) = \frac{1}{h_1(v)} \frac{1}{W[\mathfrak{q}_r,\mathfrak{q}_l]} \int_{\alpha}^{v} \left(1 + \frac{1}{\mathfrak{q}_{\beta}(\alpha)\mathfrak{q}_{\alpha}(\beta)}\right) \mathfrak{q}_{\beta}(v,k)\mathfrak{q}_{\alpha}(v',k)\mathfrak{F}(v',k)h_1(v')dv' \\
+ \frac{1}{h_1(v)} \frac{1}{W[\mathfrak{q}_r,\mathfrak{q}_l]} \int_{v}^{\beta} \left(1 + \frac{1}{\mathfrak{q}_{\beta}(\alpha)\mathfrak{q}_{\alpha}(\beta)}\right) \mathfrak{q}_{\alpha}(v,k)\mathfrak{q}_{\beta}(v',k)\mathfrak{F}(v',k)h_1(v')dv' \\
- \frac{1}{h_1(v)} \frac{1}{W[\mathfrak{q}_r,\mathfrak{q}_l]} \int_{\alpha}^{\beta} \frac{\mathfrak{q}_{\alpha}(v,k)\mathfrak{q}_{\alpha}(v',k)}{\mathfrak{q}_{\alpha}(\beta)} \mathfrak{F}(v',k)h_1(v')dv' \\
- \frac{1}{h_1(v)} \frac{1}{W[\mathfrak{q}_r,\mathfrak{q}_l]} \int_{\alpha}^{\beta} \frac{\mathfrak{q}_{\beta}(v,k)\mathfrak{q}_{\beta}(v',k)}{\mathfrak{q}_{\beta}(\alpha)} \mathfrak{F}(v',k)h_1(v')dv'$$

We now introduce the Fourier kernel for the Sturm-Liouville type elliptic problem (C.7). For any given fixed k, and positive Gevrey functions  $h_1, h_2 \in \mathcal{G}_{ph}^{M,s}([\alpha,\beta])$  with constant values near the boundary and any Gevrey cut-off function  $\Upsilon$  with compact support supp  $\Upsilon \subset (\alpha,\beta)$ , we define a linear operator  $\triangle_{D,k}^{-1}$  to be such that for a function  $\mathfrak{F}$ ,

where  $\mathfrak{Q}$  solves

$$\begin{cases} \partial_v (h_1(v)\partial_v \mathfrak{Q}) - k^2 h_2(v) \mathfrak{Q} = \mathfrak{F}(v,k)\Upsilon(v) \\ \mathfrak{Q}(\alpha,k) = \mathfrak{Q}(\beta,k) = 0. \end{cases}$$

For the case k = 0, we have

$$\triangle_{D,0}^{-1}\mathfrak{F} = \int_{\alpha}^{\beta} \mathbf{G}_{D}(v,v',0)\Upsilon(v)\Upsilon(v')\mathfrak{F}(v',0)dv'$$

where

C.2. Regularity of the Green's function. In this section, we study the Gevrey regularity of the Green's function. According to the above decompositions, we only need to estimate  $\frac{q_{\alpha}(v',k)q_{\beta}(v,k)}{q_{\beta}(\alpha,k)}$  with  $v' \leq v$ ,  $\frac{q_{\alpha}(v,k)q_{\beta}(v',k)}{q_{\beta}(\alpha,k)}$  with  $v' \geq v$  and  $\frac{q_{\alpha}(v,k)}{q_{\alpha}(\beta,k)}$  with  $v < \beta - \delta$ ,  $\frac{q_{\beta}(v,k)}{q_{\beta}(\alpha,k)}$  with  $v \geq \alpha + \delta$  for some  $\delta > 0$ . By Lemma C.1, it is easy to check all of the four terms are in Gevrey. So we only focus on the uniformity in k of the Gevrey norm. Now we assume  $|k| \geq k_0 > 0$  with  $k_0$  large enough which is determined by  $h_1, h_2$  and  $\delta$ . Without loss of generality, we assume  $k \geq k_0 > 0$ .

Now let us first treat  $\frac{q_{\alpha}(v,k)}{q_{\alpha}(\beta,k)}$  with  $v < \beta - \delta$ ,  $\frac{q_{\beta}(v,k)}{q_{\beta}(\alpha,k)}$  with  $v \ge \alpha + \delta$  for some  $\delta > 0$  and give the following lemma: **Lemma C.2.** It holds for  $\alpha + \delta < v \leq \beta - \delta$

*Proof.* Let us prove the first estimate and the second one can be obtained by the same argument. Notice that  $\mathfrak{q} = {\mathfrak{q}_{\alpha}, \mathfrak{q}_{\beta}}$  solves

We now use mathematical induction to prove the following result: For all  $N\geq 0,$  it holds that

$$+ \sum_{l=0}^{m-2} \sum_{l_1=0}^{m_l-1} \frac{(m-2)!}{l!(m-2-l)!} \Gamma_s(l) \frac{(m_l-1)!}{l_1!((m_l-1)-l_1)!} \Gamma_s(m-l-2-l_1) C^{m-2-l_1}(C|k|)^{l_1+2} e^{-C^{-1}\delta|k|} \\ \leq \sum_{j_1=0}^{m-1} \frac{(m-1)!}{j_1!(m-1-j_1)!} \Gamma_s(m-1-j_1) C^{m-1-j_1}(C|k|)^{j_1} e^{-C^{-1}\delta|k|} \\ + \sum_{l_1=0}^{m-2} \frac{(m-l_1)!}{(l_1+2)!(m-2-l_1)!} \Gamma_s(m-2-l_1) C^{m-2-l_1}(C|k|)^{l_1+2} e^{-C^{-1}\delta|k|},$$

*Proof.* The two estimates can be proved by the same argument. Here we only prove the first inequality. We write

$$\left| (\partial_{v}, \partial_{v'}) \Big( \mathfrak{q}_{\alpha}(v) \mathfrak{q}_{\alpha}(v') \int_{\beta}^{v} \frac{1}{h_{1}(w) \mathfrak{q}_{\alpha}(w)^{2}} dw \Big) \right| \lesssim k^{2} \int_{\beta}^{v} e^{-2C^{-1}k|v-w|} dw e^{-C^{-1}k|v-v'|} \lesssim k e^{-C^{-1}\delta k},$$

$$\left| (\partial_{v}, \partial_{v'})^{2} \Big( \mathfrak{q}_{\alpha}(v) \mathfrak{q}_{\alpha}(v') \int_{\beta}^{v} \frac{1}{h_{1}(w) \mathfrak{q}_{\alpha}(w)^{2}} dw \Big) \right| \lesssim k^{3} \int_{\beta}^{v} e^{-2C^{-1}k|v-w|} dw e^{-C^{-1}k|v-v'|} \lesssim k^{2} e^{-C^{-1}\delta k},$$

We now use mathematical induction to prove the following result: For all  $N = N_1 + N_2$ , it holds that

(C.21) 
$$\left|\partial_v^{N_1}\partial_v^{N_2}\left(\frac{\mathfrak{q}_{\beta}(v,k)\mathfrak{q}_{\alpha}(v',k)}{\mathfrak{q}_{\beta}(\alpha,k)}\right)\right| \leq \left(\sum_{j=0}^N \frac{N!}{j!(N-j)!}\Gamma_s(N-j)C^{N-j}(C|k|)^j e^{-C^{-1}\delta|k|}\right).$$

Suppose that (C.21) holds for  $N_1 + N_2 = 0, 1, 2, ..., m_1 + m_2 + 1$ , we get for  $N_1 = m_1 + m_2 + 2$  Thus we have

$$\begin{split} & \left| \frac{\partial_{v}^{m_{1}+2} \mathbf{q}_{\beta}(v) \partial_{v'}^{m_{2}} \mathbf{q}_{\alpha}(v')}{\mathbf{q}_{\beta}(\alpha,k)} \right| \\ & \leq \sum_{j=0}^{m_{1}} \left| \frac{(m_{1})!}{j!(m_{1}-j)!} \partial_{v}^{j} \left(\frac{-h'_{1}}{h_{1}}\right) \partial_{v}^{m_{1}+1-j} \mathbf{q}_{\beta}(v) \partial_{v'}^{m_{2}} \mathbf{q}_{\alpha}(v') / \mathbf{q}_{\beta}(\alpha,k) \right| \\ & + k^{2} \sum_{l=0}^{m_{1}} \left| \frac{(m_{1})!}{l!(m_{1}-l)!} \partial_{v}^{l} \left(\frac{h_{2}}{h_{1}}\right) \partial_{v}^{m_{1}-l} \mathbf{q}_{\beta}(v) \partial_{v'}^{m_{2}} \mathbf{q}_{\alpha}(v') / \mathbf{q}_{\beta}(\alpha,k) \right| \\ & \leq \sum_{j=0}^{m_{1}} \frac{(m_{1})!}{j!(m_{1}-j)!} C^{j} \Gamma_{s}(j) \left( \sum_{j_{1}=0}^{N_{j}} \frac{N_{j}!}{j_{1}!(N_{j}-j_{1})!} \Gamma_{s}(N_{j}-j_{1}) C^{N_{j}-j_{1}}(C|k|)^{j_{1}} e^{-C^{-1}\delta|k|} \right) \\ & + C^{-2} \sum_{l=0}^{m_{1}} \frac{(m_{1})!}{l!(m_{1}-l)!} C^{l} \Gamma_{s}(l) \left( \sum_{j_{2}=0}^{N_{l}} \frac{N_{l}!}{j_{2}!(N_{l}-j_{2})!} \Gamma_{s}(N_{l}-j_{2}) C^{N_{l}-j_{2}}(C|k|)^{j_{2}+2} e^{-C^{-1}\delta|k|} \right) \\ & = I_{1} + I_{2}, \end{split}$$

where  $N_j = m_1 + m_2 + 1 - j$  and  $N_l = m_1 + m_2 - l$ . For the first term, we have

$$I_{1} = \sum_{j=0}^{m_{1}} \sum_{j_{1}=0}^{N_{j}} \frac{(m_{1})!}{j!(m_{1}-j)!} \Gamma_{s}(j) \frac{N_{j}!}{j_{1}!(N_{j}-j_{1})!} \Gamma_{s}(N_{j}-j_{1})C^{m_{1}+m_{2}+1-j_{1}}(C|k|)^{j_{1}}e^{-C^{-1}\delta|k|}$$

$$= \sum_{j=0}^{m_{1}} \sum_{j_{1}=0}^{N_{j}} \left( \frac{m_{1}!(m_{1}+m_{2}+1-j)!}{(m_{1}-j)!(m_{1}+m_{2}+1-j_{1})!} \right) \frac{(m_{1}+m_{2}+1-j_{1})!}{j_{1}!(m_{1}+m_{2}+1-j_{1})!}$$

$$\times \left( \frac{(N_{j}-j_{1}+j)!}{j!(N_{j}-j_{1})!} \Gamma_{s}(N_{j}-j_{1})\Gamma_{s}(j) \right) C^{m_{1}+m_{2}+1-j_{1}}(C|k|)^{j_{1}}e^{-C^{-1}\delta|k|}$$

$$\leq \sum_{j_{1}=0}^{m_{1}+m_{2}+1} \frac{(m_{1}+m_{2}+1-j_{1})!}{j_{1}!(m_{1}+m_{2}+1-j_{1})!} \Gamma_{s}(m_{1}+m_{2}+1-j_{1})C^{m_{1}+m_{2}+1-j_{1}}(C|k|)^{j_{1}}e^{-C^{-1}\delta|k|}.$$

Similarly, for the second term, we have

$$I_{2} = C^{-2} \sum_{l=0}^{m_{1}} \sum_{j_{2}=0}^{N_{l}} \frac{(m_{1})!}{l!(m_{1}-l)!} \Gamma_{s}(l) \frac{N_{l}!}{j_{2}!(N_{l}-j_{2})!} \Gamma_{s}(N_{l}-j_{2}) C^{m_{1}+m_{2}-j_{2}}(C|k|)^{j_{2}+2} e^{-C^{-1}\delta|k|}$$
$$\leq C^{-2} \sum_{j_2=0}^{m_1+m_2} \frac{(m_1+m_2+2-j_2)!}{(j_2+2)!(m_1+m_2-j_2)!} \Gamma_s(m_1+m_2-j_2) C^{m_1+m_2-j_2}(C|k|)^{j_2+2} e^{-C^{-1}\delta|k|}.$$

Combining the above estimate,

$$\left|\frac{\partial_v^{m_1+2}\mathfrak{q}_{\beta}(v)\partial_{v'}^{m_2}\mathfrak{q}_{\alpha}(v')}{\mathfrak{q}_{\beta}(\alpha,k)}\right| \leq \left(\sum_{j=0}^N \frac{N!}{j!(N-j)!}\Gamma_s(N-j)C^{N-j}(C|k|)^j e^{-C^{-1}\delta|k|}\right)$$

with  $N = m_1 + m_2 + 2$ . Using a similar argument, we can also get for any  $m_1, m_2$ ,

$$\left|\frac{\partial_v^{m_1}\mathfrak{q}_{\beta}(v)\partial_{v'}^{m_2+2}\mathfrak{q}_{\alpha}(v')}{\mathfrak{q}_{\beta}(\alpha,k)}\right| \le \left(\sum_{j=0}^N \frac{N!}{j!(N-j)!}\Gamma_s(N-j)C^{N-j}(C|k|)^j e^{-C^{-1}\delta|k|}\right)$$

holds for  $N = m_1 + m_2 + 2$ . Thus we proved (C.21). The lemma follows directly by applying

$$(C|k|)^j e^{-C^{-1}\delta|k|} \lesssim (C\delta)^{-j} (j^j/e^j) < (C\delta)^{-j} \Gamma_s(j),$$

and (A.10).

By using the fact that  $h_1, h_2$  are constant-valued functions near the boundary, and the boundary condition of  $\mathfrak{q}_{\alpha}(v)$ , we obtain that for  $\alpha \leq v \leq \alpha + \delta$ ,

$$\mathfrak{q}_{\alpha}(v) = \cosh\left(k\int_{\alpha}^{v}\sqrt{\frac{h_{2}}{h_{1}}}(w)dw\right)$$

and

$$k\sqrt{h_1(\alpha)h_2(\alpha)}\mathfrak{q}_{\alpha}(v)\int_{\alpha}^{v}\frac{1}{h_1(w)\mathfrak{q}_{\alpha}(w)^2}dw=\sinh\left(k\int_{\alpha}^{v}\sqrt{\frac{h_2}{h_1}}(w)dw\right).$$

Let

(C.22) 
$$\mathfrak{e}_{\alpha,+}(v) = \mathfrak{q}_{\alpha}(v) + h_1(\alpha)\mathfrak{q}_{\alpha}(v)\int_{\alpha}^{v} \frac{1}{h_1(w)\mathfrak{q}_{\alpha}(w)^2} dw = e^{\int_{\alpha}^{v}\mathfrak{s}_{\alpha,+}(w)/h_1(w)dw},$$

then a direct calculation gives that  $\mathfrak{e}_{\alpha,+}(v)$  solves

$$\partial_v(h_1\partial_v \mathbf{e}_{\alpha,+}(v)) = k^2 h_2 \mathbf{e}_{\alpha,+}(v)$$

and that  $\mathfrak{s}_{\alpha,+}(v) = \frac{h_1(v)\mathfrak{e}'_{\alpha,+}(v)}{\mathfrak{e}_{\alpha,+}(v)}$  solves

$$\mathfrak{s}_{\alpha,+}'(v) + \frac{\mathfrak{s}_{\alpha,+}(v)^2}{h_1(v)} = k^2 h_2(v),$$

with boundary condition  $\mathfrak{s}_{\alpha,+}(\alpha) = k\sqrt{h_1(\alpha)h_2(\alpha)}$ .

Note that the above calculation for  $\mathfrak{s}_{\alpha,+}$  is similar to  $\mathfrak{f}_{\alpha}$ .

**Lemma C.4.** There is  $k_0 > 0$  and there are C and M independent of k, so that for any  $k > k_0$ , it holds that

$$\sup_{m\geq 0} \left| \partial_v^m \big( \mathfrak{s}_{\alpha,+}(v) - k\sqrt{h_1(v)h_2(v)} \big) \right| \leq C\Gamma_s(m) M^m.$$

*Proof.* We use the idea of WKB approximation and rewrite  $\mathfrak{s}_{\alpha,+}(v)$  as

$$\mathfrak{s}_{\alpha,+}(v) = k\sqrt{h_1(v)h_2(v)} - \frac{(\sqrt{h_1(v)h_2(v)})'}{2\sqrt{h_2(v)/h_1(v)}} + r(v),$$

then r solves

$$\begin{aligned} r' + 2k\sqrt{h_2/h_1}r - \frac{(\sqrt{h_1(v)h_2(v)})'}{\sqrt{h_2(v)/h_1(v)}}r + \frac{r^2}{h_1} - \left(\frac{(\sqrt{h_1(v)h_2(v)})'}{2\sqrt{h_2(v)/h_1(v)}}\right)' + \left(\frac{(\sqrt{h_1(v)h_2(v)})'}{2\sqrt{h_2(v)}}\right)^2 &= 0. \end{aligned}$$
  
Let  $R(w) = r(v)$  with  $w(v) = \int_{\alpha}^{v} \sqrt{h_2/h_1}(z)dz$ , then  
 $R' + 2kR + A(w)R + B(w)R^2 + C(w) = 0, \end{aligned}$ 

with initial data R(0) = 0, where

$$A(w) = -\sqrt{h_1/h_2} \frac{(\sqrt{h_1(v)h_2(v)})'}{\sqrt{h_2(v)/h_1(v)}}$$
  

$$B(w) = \sqrt{\frac{1}{h_1(v)h_2(v)}}$$
  

$$C(w) = -\sqrt{h_1/h_2} \left(\frac{(\sqrt{h_1(v)h_2(v)})'}{2\sqrt{h_2(v)/h_1(v)}}\right)' + \sqrt{h_1/h_2} \left(\frac{(\sqrt{h_1(v)h_2(v)})'}{2\sqrt{h_2(v)}}\right)^2$$

By the Gevrey regularity of  $h_1, h_2$  and composition Lemma A.3, it is easy to check that there are C and  $M_1$  such that

$$\sup_{m \ge 0} |\partial_w^m(A, B, C)(w)| \le C\Gamma_s(m)M_1^m.$$

Let  $D^m = \frac{\partial_w^m}{\Gamma_s(m)M^m}$ , then we get that

$$\frac{1}{2}\frac{d}{dw}|D^m R|^2 + 2k|D^m R|^2 \le C(\sup_{0\le m_1\le m}|D^{m_1} R| + 1)^2|D^m R|.$$

By the Gronwall's inequality, we get that for  $k_0 > 0$  large enough and  $k > k_0$ ,

$$\sup_{m} |D^m R(w)|^2 \lesssim \frac{1}{k},$$

which together with Lemma A.3 gives

$$\sup_{m \ge 0} |\partial_v^m r(v)| \le C \frac{\Gamma_s(m) M_1^m}{\sqrt{k}}.$$

Thus we proved the lemma.

Thus we have the following remark:

**Remark C.5.** It holds that for  $v \ge \alpha + \delta$ 

$$\left|\partial_{v}^{m+1}\left(\frac{1}{\mathfrak{e}_{\alpha,+}(v)}\right)\right| \lesssim \Gamma_{s}(m) M^{m} e^{-C^{-1}k|v-\alpha|}$$

*Proof.* We rewrite  $\frac{1}{\mathfrak{e}_{\alpha,+}(v)} = g_{\mathfrak{e}}(v)e^{-\int_{\alpha}^{v}k\sqrt{h_{1}h_{2}(w)}dw}$ . Then Lemma C.4 gives that  $\left|\partial_{v}^{m+1}g_{\mathfrak{e}}(v)\right| \lesssim \Gamma_{s}(m)M^{m}.$ 

We also have for  $v \geq \alpha + \delta$ 

$$\left|\partial_v^{m+1} e^{-\int_\alpha^v k\sqrt{h_1 h_2(w)} dw}\right| \le \Gamma_s(m) M^m e^{-C^{-1}k|v-\alpha|}$$

which gives the remark.

**Lemma C.6.** For any  $\frac{\beta-\alpha}{100} > \delta > 0$ , there are M and C independent of k, such that for  $|v'-v| \le \delta$ 

$$\sup_{m\geq 0} \int_{\alpha+\delta}^{\beta-\delta} \int_{\{0$$

and

$$\left|\frac{(\partial_v + \partial_{v'})^m}{\Gamma_s(m)M^m} \left(\frac{\mathfrak{q}_\alpha(v')}{\mathfrak{q}_\alpha(v)}\right)\right| \le C$$

*Proof.* Let us first use  $\mathfrak{e}_{\alpha,+}$  to represent  $\mathfrak{q}_{\alpha}(v)$ , by matching the boundary condition, we have

$$\mathfrak{q}_{\alpha}(v) = \mathfrak{e}_{\alpha,+}(v) - k\sqrt{h_1(\alpha)h_2(\alpha)}\mathfrak{e}_{\alpha,+}(v)\int_{\alpha}^{v} \frac{1}{h_1(w)\mathfrak{e}_{\alpha,+}(w)^2}dw.$$

Thus we have

(C.23) 
$$\frac{\mathfrak{q}_{\alpha}(v)}{\mathfrak{q}_{\alpha}(w)} = \frac{\mathfrak{e}_{\alpha,+}(v)}{\mathfrak{e}_{\alpha,+}(w)} \left( 1 + \frac{k\sqrt{h_1(\alpha)h_2(\alpha)}\int_w^v \frac{1}{h_1(z)\mathfrak{e}_{\alpha,+}(z)^2}dz}{1 - k\sqrt{h_1(\alpha)h_2(\alpha)}\int_x^v \frac{1}{h_1(w)\mathfrak{e}_{\alpha,+}(w)^2}dw} \right)$$

By the fact that  $q_{\alpha}(v) \geq 1$  and (C.22), it is easy to

$$1 - k\sqrt{h_1(\alpha)h_2(\alpha)} \int_{\alpha}^{v} \frac{1}{h_1(w)\mathbf{e}_{\alpha,+}(w)^2} dw \ge c_0 > 0$$

for some  $c_0$  independent of k. By Remark C.5, we have that for  $m \ge 1$  and  $w \ge \alpha + \delta$ 

$$\left| \partial_v^m \left( 1 - k\sqrt{h_1(\alpha)h_2(\alpha)} \int_{\alpha}^v \frac{1}{h_1(w)\mathbf{e}_{\alpha,+}(w)^2} dw \right) \right| \lesssim k \left| \partial_v^{m-1} \left( \frac{1}{h_1(w)\mathbf{e}_{\alpha,+}(w)^2} \right) \right| \lesssim \Gamma_s(m) M^m$$

and

$$\begin{split} \left| (\partial_v + \partial_w)^m \left( k \sqrt{h_1(\alpha) h_2(\alpha)} \int_w^v \frac{1}{h_1(z) \mathfrak{e}_{\alpha, +}(z)^2} dz \right) \right| \\ \lesssim k \left| \int_w^v \partial_z^m \left( \frac{1}{h_1(z) \mathfrak{e}_{\alpha, +}(z)^2} \right) dz \right| \lesssim \Gamma_s(m) M^m, \\ \left\| (\partial_v + \partial_w)^m (1 - \partial_{vv} - \partial_{ww}) \left( k \sqrt{h_1(\alpha) h_2(\alpha)} \int_w^v \frac{1}{h_1(z) \mathfrak{e}_{\alpha, +}(z)^2} dz \right) \right\|_{L^1_{v,w}(\{0 < v < w - \delta\} \cap [\alpha + \delta, \beta - \delta]^2)} \\ \lesssim \int_{\alpha + \delta}^{\beta - \delta} k \left| \partial_v^{m+1} \left( \frac{1}{h_1(v) \mathfrak{e}_{\alpha, +}(v)^2} \right) \right| dv + \int_{\alpha + \delta}^{\beta - \delta} k \left| \partial_w^{m+1} \left( \frac{1}{h_1(w) \mathfrak{e}_{\alpha, +}(w)^2} \right) \right| dw \\ \lesssim \Gamma_s(m) M^m \end{split}$$

here we use the fact that

$$\mathfrak{e}_{\alpha,+}(w) \ge e^{-C^{-1}k|w-\alpha|}.$$

Note that

$$\frac{\mathfrak{e}_{\alpha,+}(v)}{\mathfrak{e}_{\alpha,+}(w)} = \frac{g_{\mathfrak{e}}(v)}{g_{\mathfrak{e}}(w)} e^{\int_{w}^{v} k \sqrt{h_{1}h_{2}(z)} dz},$$

where  $g_{\mathfrak{e}}(v)$  is defined in Remark C.5. Thus we obtain that for  $0 \leq w - v \leq \delta$ 

$$(\partial_v + \partial_w)^m e^{\int_w^v k \sqrt{h_1 h_2(z)} dz}$$

$$= (\partial_v + \partial_w)^{m-1} e^{\int_w^v k \sqrt{h_1 h_2(z)} dz} k \Big( \int_w^v (\sqrt{h_1 h_2(z)})' dz \Big) + e^{\int_w^v k \sqrt{h_1 h_2(z)} dz} k \Big( \int_w^v \frac{d^m}{dz^m} (\sqrt{h_1 h_2(z)}) dz \Big),$$

which gives that

$$\begin{aligned} |(\partial_v + \partial_w)^m e^{\int_w^v k \sqrt{h_1 h_2(z)} dz}| &\leq e^{-C^{-1}k|v-w|} \sum_{j=0}^m (k|v-w|)^j C^{m-j} \Gamma_s(m-j) \\ &\lesssim \Gamma_s(m) M^m, \end{aligned}$$

and

$$\left| (1 - \partial_{vv} - \partial_{ww}) (\partial_v + \partial_w)^m e^{\int_w^v k \sqrt{h_1 h_2(z)} dz} \right| \lesssim k^2 \Gamma_s(m) M^m e^{-C^{-1}k|w-v|}.$$

Combining all the estimates, together with (C.23), we get the lemma.

**Lemma C.7.** It holds for 
$$|v' - v| \le \delta$$
,  $v, v' \in [\alpha + \delta, \beta - \delta]$  that

$$\sup_{m \ge 0} \int_{\alpha+\delta}^{\beta-\delta} \int_{\{0 < v-v' \le \delta\} \cap [\alpha,\beta]} \left| \frac{(\partial_v + \partial_{v'})^m}{\Gamma_s(m)M^m} |k|^{-1} (1 - \partial_{vv} - \partial_{v'v'}) \left( \frac{\mathfrak{q}_\beta(v,k)\mathfrak{q}_\alpha(v',k)}{\mathfrak{q}_\beta(\alpha,k)} \right) \right| dvdv' \le C.$$
  
and for  $v - \delta < v' < v$ 

$$\left|\frac{(\partial_v + \partial_{v'})^m}{\Gamma_s(m)M^m} \left(\frac{\mathfrak{q}_\beta(v,k)\mathfrak{q}_\alpha(v',k)}{\mathfrak{q}_\beta(\alpha,k)}\right)\right| \le C$$

and

$$\sup_{m\geq 0} \int_{\alpha+\delta}^{\beta-\delta} \int_{\{0

$$\left| \partial_v^{m-m_1} \partial_{v'}^{m_1} \left(\frac{\mathfrak{q}_\beta(v,k)\mathfrak{q}_\alpha(v',k)}{\mathfrak{q}_\beta(\alpha,k)}\right) \right| \leq C\Gamma_s(m)M^m,$$$$

and for  $v' - \delta < v < v'$ 

$$\left|\frac{(\partial_v + \partial_{v'})^m}{\Gamma_s(m)M^m} \Big(\frac{\mathfrak{q}_\alpha(v,k)\mathfrak{q}_\beta(v',k)}{\mathfrak{q}_\beta(\alpha,k)}\Big)\right| \leq C.$$

**Proposition C.8.** Let  $\widehat{\mathbf{G}}_D$  be the Fourier transform of the kernel  $\mathbf{G}_D$  defined in (C.14), namely,

$$\widehat{\mathbf{G}}_D(k,\xi_1,\xi_2) = \frac{1}{2\pi} \int_{\mathbb{R}^2} \widehat{\mathbf{G}}_D(v,v',k) \Upsilon(v) \Upsilon(v') e^{-iv\xi_1 - iv'\xi_2} dv dv'.$$

Then there is  $\lambda_{\Delta}$  such that for all  $k \in \mathbb{Z}$ ,

(C.24) 
$$|\widehat{\mathbf{G}}_D(k,\xi_1,\xi_2)| \le C \min\left\{\frac{e^{-\lambda_\Delta \langle \xi_1 + \xi_2 \rangle^s}}{1 + k^2 + \xi_1^2}, \frac{e^{-\lambda_\Delta \langle \xi_1 + \xi_2 \rangle^s}}{1 + k^2 + \xi_2^2}\right\}.$$

*Proof.* Notice that

(C.25) 
$$\int_{\mathbb{R}^2} \widehat{\mathbf{G}}_D(v, v', k) \Upsilon(v) \Upsilon(v') e^{-iv\xi_1 - iv'\xi_2} dv dv'$$
$$= \int_{\mathbb{R}^2} \widehat{\mathbf{G}}_D(v, v + w, k) \Upsilon(v) \Upsilon(v + w) e^{-iv(\xi_1 + \xi_2) - iv'\xi_2} dv dw$$

The upper bound (C.24) follows from (C.14), (C.16), (C.17) Lemma C.2, Lemma C.3, Lemma C.7, Lemma A.1, Lemma B.1, Lemma B.2 and Remark B.3.  $\hfill \Box$

By using (C.3) and (C.4), it is easy for us to obtain the following proposition which is equivalent to Proposition 8.1.

**Proposition C.9.** Let  $\Psi$  solve (C.1) with  $\Omega$  compactly supported. Then there is  $\mathcal{G}_{D,1}(t,k,\xi,\eta)$  such that for  $k \neq 0$ 

$$\widehat{(\Psi\Upsilon)}(t,k,\xi) = \int_{\mathbb{R}} \mathcal{G}_{D,1}(t,k,\xi,\eta) \widehat{\Omega}(t,k,\eta) d\eta,$$

with estimate

$$|\mathcal{G}_{D,1}(t,k,\xi,\eta)| \le C_{ell} \min\left\{\frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\xi-kt)^2}, \frac{e^{-\lambda_{\Delta}\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2}\right\}.$$

Notice that from  $\Delta \psi = \omega$ , we have

(C.26) 
$$\begin{cases} \partial_{zz}\Psi + \widetilde{u'}(\partial_v - t\partial_z)\Big(\widetilde{u'}(\partial_v - t\partial_z)\Psi\Big) = \underline{\omega}\\ \Psi(t, z, u(0)) = \Psi(t, z, u(1)) = 0. \end{cases}$$

If we set  $\mathfrak{Q} = \mathcal{F}_1(\Psi)(t, k, v)e^{-itkv}$  and  $h_1(v) = \widetilde{u'}(v)$ ,  $h_2(v) = \widetilde{u'}(v)^{-1}$  and  $\mathfrak{F} = \mathcal{F}_1[\underline{\omega}]e^{-itkv}$ , then we also obtain the Sturm-Liouville Equation (C.7). We then have the following corollary:

**Corollary C.10.** Let  $\Psi$  solve (C.26) with  $\underline{\omega}$  compactly supported. Then there is  $\mathcal{G}_2(t, k, \xi, \eta)$  such that

$$\widehat{(\Psi\Upsilon)}(t,k,\xi) = \int_{\mathbb{R}} \mathcal{G}_2(t,k,\xi,\eta) \underline{\widehat{\omega}}(t,k,\eta) d\eta,$$

with estimate

$$|\mathcal{G}_2(t,k,\xi,\eta)| \le C_{ell} \min\left\{\frac{e^{-\lambda_\Delta\langle\xi-\eta\rangle^s}}{1+k^2+(\xi-kt)^2}, \frac{e^{-\lambda_\Delta\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2}\right\}.$$

C.3. Neumann boundary conditions. We also study the general Sturm-Liouville Equation with Neumann boundary conditions

(C.27) 
$$\begin{cases} \partial_v (h_1(v)\partial_v \mathfrak{R}) - k^2 h_2(v) \mathfrak{R} = \mathfrak{G}(v,k) \\ \partial_v \mathfrak{R}(\alpha,k) = \partial_v \mathfrak{R}(\beta,k) = 0 \end{cases}$$

where  $h_1, h_2$  are positive functions and  $\operatorname{supp} h'_j \subset [\alpha_1, \beta_1]$  for j = 1, 2. We also assume that  $h'_1, h'_2 \in \mathcal{G}_{ph}^{M,s}([\alpha, \beta]).$ 

By Lemma C.1, it is easy to get that

(C.28)  
$$\Re(v,k) = \frac{1}{h_1(v)} \frac{\mathfrak{q}_{\beta}(v,k)}{W[\mathfrak{q}_{\beta},\mathfrak{q}_{\alpha}]} \int_0^v \mathfrak{q}_{\alpha}(v',k)\mathfrak{G}(v',k)h_1(v')dv' + \frac{1}{h_1(v)} \frac{\mathfrak{q}_{\alpha}(v,k)}{W[\mathfrak{q}_{\beta},\mathfrak{q}_{\alpha}]} \int_v^1 \mathfrak{q}_{\beta}(v',k)\mathfrak{G}(v',k)h_1(v')dv',$$

with

$$W[\mathbf{q}_{\beta},\mathbf{q}_{\alpha}](v) = -W[\mathbf{q}_{\alpha},\mathbf{q}_{\beta}](v) = -\frac{\mathbf{q}_{\beta}'(\alpha)h_{1}(\alpha)}{h_{1}(v)} = \frac{\mathbf{q}_{\alpha}'(\beta)h_{1}(\beta)}{h_{1}(v)} > 0$$

We now introduce the Fourier kernel for the Sturm-Liouville type elliptic problem (C.27). For any given fixed k, and positive Gevrey functions  $h_1, h_2 \in \mathcal{G}_{ph}^{M,s}([\alpha,\beta])$  with constant values near the

boundary and any Gevrey cut-off function  $\Upsilon$  with compact support supp  $\Upsilon \subset (\alpha, \beta)$ , we define a linear operator  $\triangle_{N,k}^{-1}$  to be such that for a function  $\mathfrak{G}$ ,

where  $\Re$  solves

$$\begin{cases} \partial_v (h_1(v)\partial_v \mathfrak{R}) - k^2 h_2(v) \mathfrak{R} = \mathfrak{G}(v,k) \Upsilon(v) \\ \partial_v \mathfrak{R}(\alpha,k) = \partial_v \mathfrak{R}(\beta,k) = 0. \end{cases}$$

By (C.28), we have for  $k \neq 0$ 

$$\triangle_{N,k}^{-1}\mathfrak{G} = \int_0^1 \mathbf{G}_N(v,v',k)\Upsilon(v)\Upsilon(v')\mathfrak{G}(v',k)dv'$$

with

(C.30)  

$$\mathbf{G}_{N}(v,v',k) = \frac{1}{h_{1}(v)} \frac{\mathbf{q}_{\beta}(v,k)}{W[\mathbf{q}_{\beta},\mathbf{q}_{\alpha}]} \mathbf{q}_{\alpha}(v',k) h_{1}(v') \chi_{\mathbb{R}^{+}}(v-v') + \frac{1}{h_{1}(v)} \frac{\mathbf{q}_{\alpha}(v,k)}{W[\mathbf{q}_{\beta},\mathbf{q}_{\alpha}]} \mathbf{q}_{\beta}(v',k) h_{1}(v') \chi_{\mathbb{R}^{+}}(v'-v)$$

Similarly to Proposition C.9, by using the representation formula of the Green function (C.30) and applying Lemma C.3 and Lemma A.1, we have the following proposition.

**Proposition C.11.** Let  $\Pi$  solve (C.2) with  $\Xi$  compactly supported. Then there is  $\mathcal{G}_N(t, k, \xi, \eta)$  such that

$$\widehat{(\Pi\Upsilon)}(t,k,\xi) = \int_{\mathbb{R}} \mathcal{G}_N(t,k,\xi,\eta) \widehat{\Xi}(t,k,\eta) d\eta,$$

with estimate

$$|\mathcal{G}_N(t,k,\xi,\eta)| \le C \min\left\{\frac{e^{-\lambda_\Delta\langle\xi-\eta\rangle^s}}{1+k^2+(\xi-kt)^2}, \frac{e^{-\lambda_\Delta\langle\xi-\eta\rangle^s}}{1+k^2+(\eta-kt)^2}\right\}$$

APPENDIX D. PROPERTIES OF MULTIPLIER A

In this section, we list some key properties of the multiplier A from [5].

**Lemma D.1** (Lemma 3.3 in [5]). For  $t \in I_{k,\eta}$  and  $t > 2\sqrt{|\eta|}$ , we have the following with  $\tau = t - \frac{\eta}{k}$  $\frac{\partial_t w_{\rm NR}(t,\eta)}{\partial_t w_{\rm NR}(t,\eta)} \sim \frac{1}{1} \sim \frac{\partial_t w_{\rm R}(t,\eta)}{\partial_t w_{\rm R}(t,\eta)}$ 

$$\frac{\partial_t w_{\rm NR}(t,\eta)}{w_{\rm NR}(t,\eta)} \approx \frac{1}{1+|\tau|} \approx \frac{\partial_t w_{\rm R}(t,\eta)}{w_{\rm R}(t,\eta)}$$

Lemma D.2 (Lemma 3.4 in [5]). The following holds.

(1) For  $t \ge 1$ , and  $k, l, \eta, \xi$  such that  $\max\{2\sqrt{|\xi|}, 2\sqrt{|\eta|}\} < t < 2\min\{|\xi|, |\eta|\},$ 

$$\frac{\partial_t w_k(t,\eta)}{w_k(t,\eta)} \frac{w_l(t,\xi)}{\partial_t w_l(t,\xi)} \lesssim \langle \eta - \xi \rangle.$$

(2) For all  $t \ge 1$ , and  $k, l, \eta, \xi$ , such that for some  $\alpha \ge 1$ ,  $\frac{1}{\alpha} |\xi| \le |\eta| \le \alpha |\xi|$ ,

$$\sqrt{\frac{\partial_t w_l(t,\xi)}{w_l(t,\xi)}} \lesssim_{\alpha} \left[ \sqrt{\frac{\partial_t w_k(t,\eta)}{w_k(t,\eta)}} + \frac{|\eta|^{\frac{s}{2}}}{\langle t \rangle^s} \right] \langle \eta - \xi \rangle.$$

**Lemma D.3** (Lemma 3.5 in [5]). For all  $t, \eta, \xi$ , we have

$$\frac{w_{\rm NR}(t,\xi)}{w_{\rm NR}(t,\eta)} \lesssim e^{\mu|\eta-\xi|^{\frac{1}{2}}}$$

**Lemma D.4** (Lemma 3.6 in [5]). We have for  $t \in I_{k,\eta} \cap I_{k,\xi}$  with  $k \neq l$  that

$$\frac{{\rm J}_k(\eta)}{{\rm J}_l(\xi)} \lesssim \frac{|\eta|}{k^2 + (\eta - kt)^2} e^{9\mu |k - l, \eta - \xi|^{\frac{1}{2}}}$$

we also rewrite it as

$$\frac{\mathbf{J}_k(\eta)}{\mathbf{J}_l(\xi)} \lesssim \frac{|\eta|}{k^2} \sqrt{\frac{\partial_t w_k(t,\eta)}{w_k(t,\eta)}} \sqrt{\frac{\partial_t w_l(t,\xi)}{w_l(t,\xi)}} e^{20\mu|k-l,\eta-\xi|^{\frac{1}{2}}}.$$

In other cases, we have improved estimates

$$\frac{\mathbf{J}_k(\eta)}{\mathbf{J}_l(\xi)} \lesssim e^{10\mu|k-l,\eta-\xi|^{\frac{1}{2}}}.$$

Moreover, if  $t \in I_{l,\xi}$ ,  $t \notin I_{k,\eta}$  and  $\frac{1}{\alpha} |\xi| \le |\eta| \le \alpha |\xi|$  for some  $\alpha > 0$ , then

(D.1) 
$$\frac{\mathbf{J}_k(\eta)}{\mathbf{J}_l(\xi)} \lesssim \frac{|l|(l+|\xi-lt|)}{|\xi|} e^{11\mu|k-l,\eta-\xi|^{\frac{1}{2}}}$$

**Lemma D.5** (Lemma 3.7 in [5]). Let  $t \leq \frac{1}{2} \min\{\sqrt{|\eta|}, \sqrt{|\xi|}\}$ . Then

$$\left|\frac{\mathbf{J}_{k}(\eta)}{\mathbf{J}_{l}(\xi)} - 1\right| \lesssim \frac{\langle k - l, \eta - \xi \rangle}{\sqrt{|\xi| + |\eta| + |k| + |l|}} e^{11\mu|k - l, \eta - \xi|^{\frac{1}{2}}}$$
