# Faster Differentially Private Convex Optimization via Second-Order Methods

#### Abstract

Differentially private (stochastic) gradient descent is the workhorse of differentially private machine learning in both the convex and non-convex settings. Without privacy constraints, second-order methods, like Newton's method, converge faster than first-order methods like gradient descent. In this work, we investigate the prospect of using the second-order information of loss function to accelerate differentially private convex optimization. We first develop a private variant of the regularized cubic Newton method of Nesterov and Polyak [NP06] for the class of strongly convex loss functions. We show that our algorithm achieves the optimal excess loss and attains the same (optimal) rate of convergence as its non-private counterparts. We then design a practical second-order DP algorithm for the unconstrained logistic regression problem. We empirically study the performance of our algorithm. We show that our algorithm almost always achieves the best excess loss for a wide range of $\varepsilon \in[0.01,10]$ on many challenging datasets. Furthermore, the run-time of our algorithm is $10 \times-40 \times$ faster than DPGD.


## 1 Introduction

Many machine learning tasks reduce to a convex optimization problem. More precisely, given a dataset $S_{n}=\left(z_{1}, \ldots, z_{n}\right) \in \mathcal{Z}^{n}$, a closed, convex set $\mathcal{W}$, and a loss function $f: \mathcal{W} \times \mathcal{Z} \rightarrow \mathbb{R}$ such that, for every $z \in \mathcal{Z}, f(w, z)$ is a convex function in $w$, our goal is to compute an approximation to $\arg \min _{w \in \mathcal{W}}\left(\ell\left(w, S_{n}\right) \triangleq \frac{1}{n} \sum_{i \in[n]} f\left(w, z_{i}\right)\right)$. In this paper, we are interested in the problem of designing optimization algorithms in the scenario that the dataset $S_{n}$ contains private information. Differential privacy (DP) DMNS06 is a formal standard for privacy-preserving data analysis that provides a framework for ensuring that the output of an analysis on the data does not leak this private information. This problem is known as private convex optimization: We want an algorithm $\mathcal{A}: \mathcal{Z}^{n} \rightarrow \mathcal{W}$ that is both DP and ensures low excess loss $\triangleq \ell\left(\mathcal{A}\left(S_{n}\right), S_{n}\right)-\min _{w \in \mathcal{W}} \ell\left(w, S_{n}\right)$.
The predominant algorithm for private convex optimization is DP (stochastic) gradient descent (DP-GD/DP-SGD). This is a first-order iterative method. I.e., we start with an initial value $w_{0}$ and iteratively update it using the gradient of the loss $\nabla_{w_{t}} \ell\left(w_{t}, S_{n}\right)$ following the update rule $w_{t+1}=w_{t}-\eta \cdot\left(\nabla_{w_{t}} \ell\left(w_{t}, S_{n}\right)+\xi_{t}\right)$, where $\eta>0$ is a constant and $\xi_{t}$ is Gaussian noise to ensure privacy. The number of iterations $T$ also determines the amount of noise at each iteration, i.e., the scale of $\xi_{t}$ is proportional to $\sqrt{T}$ due to the composition of DP. Note that we assume $\left\|\nabla_{w_{t}} \ell\left(w_{t}, S_{n}\right)\right\| \leq 1$.

[^0]One of the major drawbacks of DP-(S)GD is slow convergence. We argue that the main reason for this is the difficulty of choosing the hyperparameters $(\eta, T)$. The choice of $(\eta, T)$ exhibits a tradeoff in terms of the excess loss: if $\eta \cdot T$ is small, the algorithm cannot reach the optimal solution; on the other hand, the magnitude of noise at each iteration is $\eta \cdot \sqrt{T}$, which cannot be too large. Therefore, to maximize $\eta \cdot T$ and minimize $\eta \cdot \sqrt{T}$, implementations of DP-(S)GD err on the side of large $T$ and small $\eta$, which results in a long, slow path to convergence. This slowness is exacerbated by the facts that (1) DP-SGD requires large batch sizes for good performance [PHKX+23] and (2) the hyperparameter tuning of DP-(S)GD, and generally DP algorithms, is a challenging task PS22. Can we design a DP optimization algorithm which accelerates DP-(S)GD by choosing the step size dynamically?
We draw inspiration from the non-private optimization literature: To address the slow convergence of GD and of first-order methods in general, a class of algorithms based on preconditioning the gradient using second-order information has been developed [Nes98, NW99]. This class of algorithms is based on successively minimizing a quadratic approximation of the function, i.e., $w_{t+1}=w_{t}+\Delta_{t}$ where $\Delta_{t}=\arg \min _{\Delta}\left\{\ell\left(w_{t}, S_{n}\right)+\left\langle\nabla \ell\left(w_{t}, S_{n}\right), \Delta\right\rangle+\frac{1}{2}\left\langle H_{t} \cdot \Delta, \Delta\right\rangle\right\}=-\left(H_{t}\right)^{-1} \nabla \ell\left(w_{t}, S_{n}\right)$. Here, $H_{t}$ is a scaling matrix which provides curvature information about the loss $\ell\left(\cdot, S_{n}\right)$ at $w_{t}$. For instance, Newton's method uses the Hessian $H_{t}=\nabla^{2} \ell\left(w_{t}, S_{n}\right)$. Second-order algorithms significantly improve over the convergence speed of GD, and key to their success is that at each step they automatically tune the stepsize along each dimension based on the local curvature.

In this paper, our goal is to accelerate DP convex optimization. In particular, the current paper revolves around the following questions: Can the second-order information accelerate private convex optimization while achieving optimal excess error? What is the best way to privatize second-order information, e.g., the Hessian matrix? How does the achievable privacy-utility-runtime tradeoff compare with first-order methods such as DP-GD? We show that second-order information can accelerate DP optimization while achieving excess loss that matches or improves on DP-GD. Our main contributions are both theoretical and empirical:

### 1.1 Provably Optimal Algorithm for Strongly Convex Functions

Newton's method is a second-order optimization technique that is well-known for its rapid convergence for strongly convex and smooth functions in non-private optimization. Specifically, to achieve an excess loss of $\alpha$, the method only requires $O(\log \log (1 / \alpha))$ iterations, which is provably faster than the convergence rate of any first-order method. One natural question is whether it is possible to design a second-order DP convex optimization algorithm that can achieve the optimal minmax excess error err ${ }^{\text {opt }}$ in $O\left(\log \log \left(1 / \mathrm{err}^{\mathrm{opt}}\right)\right)$ iterations? We provide an affirmative answer to this question in Section 4 by designing a second-order DP algorithm based on the cubic regularized Newton's method of Nesterov and Polyak [NP06]. At each step $t$, we compute a cubic upper bound $\ell\left(w+\Delta, S_{n}\right) \leq \ell\left(w, S_{n}\right)+\left\langle\nabla_{w} \ell\left(w, S_{n}\right), \Delta\right\rangle+\frac{1}{2}\left\langle\nabla_{w}^{2} \ell\left(w, S_{n}\right) \cdot \Delta, \Delta\right\rangle+O\left(\|\Delta\|^{3}\right)$. We can minimize this cubic upper bound using any DP convex optimization subroutine; the minimizer becomes the next iterate $w_{t+1}$. Since the cubic is a universal upper bound, our algorithm converges globally and the second-order information ensures that it does not require any stepsize tuning.

### 1.2 Fast Practical Algorithms for DP Logistic Regression

DP logistic regression is a popular approach for private classification, with DP-GD/DP-SGD being the predominant class of algorithms for this task. As we numerically show, DP-GD/DP-SGD exhibit slow convergence for this task (See Figure 11). In Section 5. we develop a practical algorithm that
injects carefully designed noise into Newton's update rule as follows:

w_{t+1}=w_{t}-\Psi\left(\nabla_{w_{t}}^{2} \ell\left(w_{t}, S_{n}\right)\right)^{-1} \cdot\left(\nabla_{w_{t}} \ell\left(w_{t}, S_{n}\right)+\xi_{t, 1}\right)+\xi_{t, 2} \tag{1}
\end{equation*}

In particular, we inject noise twice: $\xi_{t, 1}$ privatizes the gradient and $\xi_{t, 2}$ privatizes the direction. The function $\Psi$ modifies the Hessian to ensure that the eigenvalues are not too small; this is essential for bounding the sensitivity and, hence, the scale of $\xi_{t, 2}$. We consider two types of modification based on eigenvalue clipping and eigenvalue adding. For eigenvalue clipping, $\Psi\left(\nabla_{w_{t}}^{2} \ell\left(w_{t}, S_{n}\right)\right)$ replaces the eigenvalues $\lambda_{i}$ of $\nabla_{w_{t}}^{2} \ell\left(w_{t}, S_{n}\right)$ with $\max \left\{\lambda_{i}, \lambda_{0}\right\}$, where $\lambda_{0}>0$ is a carefully chosen constant. For eigenvalue adding, $\Psi\left(\nabla_{w_{t}}^{2} \ell\left(w_{t}, S_{n}\right)\right)=\nabla_{w_{t}}^{2} \ell\left(w_{t}, S_{n}\right)+\lambda_{0} I$. Using $\Psi$ we can control the sensitivity and still have fast convergence, since important curvature information is generally contained in the larger eigenvalues/vectors of the Hessian. We prove the local convergence of the update rule (11) in Section 5.3 and perform a thorough empirical evaluation Section 6 .


Figure 1: Excess loss versus runtime of DP-GD \& our algorithms. We demonstrate that our algorithm outperforms existing baselines on a variety of benchmarks.
Ensuring Global Convergence. One limitation of the update rule in Equation (1) is it does not converge globally (even without noise added for DP). That is, if the initial point $w_{0}$ is too far from the optimal solution, then the iterates may diverge. To address this problem, we propose a variant of Newton's update rule where we replace the Hessian with a different form of second-order information which gives a Quadratic Upperbound (QU) on the logistic loss. This is guaranteed to converge globally, like the cubic Newton approach. And we show numerically that this algorithm converges almost as fast as the regular Newton's method in the private setting. Figure 1 shows the convergence speed of our algorithms and DP-GD in terms of real wall time for the task of logistic regression on the Covertype dataset for $\left.(\varepsilon, \delta)=(1, \text { (num. samples })^{-2}\right)$-DP. Despite DP-GD having a lower per-iteration cost, our algorithm is $30 \times$ faster than DP-GD and achieves better excess loss.

Stochastic Minibatch Variant. We also show that our algorithms naturally extend to the minibatch setting where gradient and second-order information are computed on a subset of samples. We numerically compare it with DP-SGD and show that it has faster convergence.

## 2 Related Work

DP optimization is a well-studied topic [e.g., SCS13; MRTZ17; ACGM+16; STU17; WLKC+17; INST+19; STT20; SSTT21; GTU22; GLL22; BFTG19; BST14]. Most similar to our work, AvellaMedina, Bradshaw, and Loh [ABL21] consider second-order methods for DP convex optimization. We provide a detailed comparison between our results and theirs in Remark 4.5 and Section 6 showing that our algorithms relax restrictive assumptions and provide better excess error for logistic regression.

## 3 Preliminaries

We use standard notation for linear algebra (see Appendix $A$ for completeness). Let $\mathcal{Z}$ be the data and let $\mathcal{W} \subseteq \mathbb{R}^{d}$ be the parameter space. Let $f: \mathcal{W} \times \mathcal{Z} \rightarrow \mathbb{R}$ be a loss function. Throughout
the paper, we assume $f$ is doubly continuous, a convex function in $w$, and $\mathcal{W}$ is a closed and convex set. We say (1) $f$ is $\mathrm{L}_{0}$-Lipschitz iff there exists $\mathrm{L}_{0} \in \mathbb{R}$ such that $\forall z \in \mathcal{Z}, \forall w, v \in \mathcal{W}$ : $|f(w, z)-f(v, z)| \leq \mathrm{L}_{0}\|w-v\|$, (2) $f$ is $\mathrm{L}_{1}$-smooth iff there exists $\mathrm{L}_{1} \in \mathbb{R}$ such that $\forall z \in \mathcal{Z}$, $\forall w, v \in \mathcal{W}:\|\nabla f(w, z)-\nabla f(v, z)\| \leq \mathrm{L}_{1}\|w-v\|,(3) f$ has a $\mathrm{L}_{2}$-Lipschitz Hessian iff there exists $\mathrm{L}_{2} \in \mathbb{R}$ such that $\forall z \in \mathcal{Z}, \forall w, v \in \mathcal{W}:\left\|\nabla^{2} f(w, z)-\nabla^{2} f(v, z)\right\| \leq \mathrm{L}_{2}\|w-v\|$, (4) $f$ is $\mu$-strongly convex iff for all $w, v \in \mathcal{W}$ and $z \in \mathcal{Z}$ we have $f(v, z) \geq f(w, z)+\langle\nabla f(w, z), v-w\rangle+\frac{\mu}{2}\|v-w\|^{2}$. For our privacy analysis, we use concentrated differential privacy DR16; BS16, as it provides a simpler composition theorem - the privacy parameter $\rho$ adds up when we compose.

Definition 3.1 ( $\overline{\text { BS16 }}$, Def. 1.1]). A randomized mechanism $\mathcal{A}: \mathcal{Z}^{n} \rightarrow \mathcal{M}_{1}(\mathcal{R})$ is $\rho$-zCDP, iff, for every neighbouring dataset (i.e., addition or removal) $S_{n} \in \mathcal{Z}^{n}$ and $S_{n}^{\prime} \in \mathcal{Z}^{n}$, and for every $\alpha \in(1, \infty)$, it holds $\mathrm{D}_{\alpha}\left(\mathcal{A}\left(S_{n}\right) \| \mathcal{A}\left(S_{n}^{\prime}\right)\right) \leq \rho \alpha$, where $\mathrm{D}_{\alpha}\left(\mathcal{A}_{n}\left(S_{n}\right) \| \mathcal{A}_{n}\left(S_{n}^{\prime}\right)\right)$ is the $\alpha$-Renyi divergence between $\mathcal{A}_{n}\left(S_{n}\right)$ and $\mathcal{A}_{n}\left(S_{n}^{\prime}\right)$.

We should think of $\rho \approx \varepsilon^{2}$ : to attain $(\varepsilon, \delta)$-DP, it suffices to set $\rho=\frac{\varepsilon^{2}}{4 \log (1 / \delta)+4 \varepsilon}$ BS16, Lem. 3.5].

## 4 Optimal Algorithm for the Class of Strongly Convex Functions

In this section, we present a DP variant of the cubic-regularized Newton's method of Nesterov and Polyak [NP06]. To motivate the idea behind our algorithm, we revisit DP gradient descent (DP-GD) for the class of $\mathrm{L}_{0}$-Lipschitz and $\mathrm{L}_{1}$-smooth convex loss functions.
Let $\left\{w_{t}^{\mathrm{GD}}\right\}_{t \in[T]}$ be the iterates of DP-GD. The smoothness of $\ell$ lets us construct a global quadratic upper bound on the function Nes98, Thm. 2.1.5] as follows $\forall w \in \mathcal{W}$ and $S_{n} \in \mathcal{Z}^{n}$ :

$$
\begin{equation*}
\ell\left(w, S_{n}\right) \leq q_{t}(w) \triangleq \ell\left(w_{t}^{\mathrm{GD}}, S_{n}\right)+\left\langle\nabla \ell\left(w_{t}^{\mathrm{GD}}, S_{n}\right), w-w_{t}^{\mathrm{GD}}\right\rangle+\frac{\mathrm{L}_{1}}{2}\left\|w-w_{t}^{\mathrm{GD}}\right\|^{2} \tag{2}
\end{equation*}
$$

Then, DP-GD can be seen as a two-step process:
(Step I) $v_{t+1}=\underset{v}{\arg \min } q_{t}(v)=w_{t}^{\mathrm{GD}}-\mathrm{L}_{1}^{-1} \nabla \ell\left(w_{t}^{\mathrm{GD}}, S_{n}\right), \quad\left(\right.$ Step II) $\quad w_{t+1}^{\mathrm{GD}}=\Pi_{\mathcal{W}}\left(v_{t+1}+\mathrm{L}_{1}^{-1} \xi_{t}\right)$,
where $\xi_{t}=\mathcal{N}\left(0, \sigma^{2} I_{d}\right)$ with $\sigma^{2}=\frac{\mathrm{L}_{0}^{2}}{2 \rho n^{2}}$ so that $w_{t+1}^{\mathrm{GD}}$ satisfies $\rho$-zCDP BS16. Lem. 2.5]. That is, in each iteration of DP-GD, we find a minimum of the quadratic upper bound $q_{t}(w)$ and then project back to $\mathcal{W}$. (In the unconstrained setting where $\mathcal{W}=\mathbb{R}^{d}$ we do not need the second projection step.)

Consider the class of $L_{2}$-Lipschitz Hessian convex loss functions. Nesterov and Polyak [NP06, Lem. 1] show that we can construct a global cubic upper bound exploiting the second-order information (i.e., Hessian) as follows: for all $w$ and $w_{t}, \ell\left(w, S_{n}\right) \leq \phi_{t}(w)$ where

$$
\begin{equation*}
\phi_{t}(w) \triangleq \ell\left(w_{t}, S_{n}\right)+\left\langle\nabla \ell\left(w_{t}, S_{n}\right), w-w_{t}\right\rangle+\frac{1}{2}\left\langle\nabla^{2} \ell\left(w_{t}, S_{n}\right)\left(w-w_{t}\right), w-w_{t}\right\rangle+\frac{\mathrm{L}_{2}}{6}\left\|w-w_{t}\right\|^{3} . \tag{3}
\end{equation*}
$$

Their non-private algorithm is based on the exact minimization of $\phi_{t}(w)$, i.e., the next iterate is $w_{t+1}=\arg \min \phi_{t}(w)$. Note that $\arg \min \phi_{t}(w)$ does not admit a closed form solution, as opposed to the quadratic upper bound (2). Similar to the intuition for DP-GD on smooth loss functions (2), our algorithms in this section are based on privately minimizing $\phi_{t}(w)$ at each iteration. Our algorithm is shown in Algorithm 1. In each iteration the algorithm makes an oracle call to obtain $\left(\ell\left(w_{t}, S_{n}\right), \nabla \ell\left(w_{t}, S_{n}\right), \nabla^{2} \ell\left(w_{t}, S_{n}\right)\right)$. Then, the algorithm calls an efficient DPSolver for privately optimizing the cubic upper bound (3). The privacy analysis of Algorithm 1 is a direct application of the composition property of zCDP [BS16, Lemma 2.3]; the output of DPSolver at each iteration satisfies $\rho / T$-zCDP where $\rho$ is the total privacy budget and $T$ is the total number of iterations.

Remark 4.1. DPSolver in Algorithm 1 does not affect the oracle complexity of Algorithm 1 , as it is applied to the proxy loss $\phi_{t}(w)$, rather than the underlying loss $\ell\left(w, S_{n}\right)$.

Theorem 4.2. Let $f$ be $a \mathrm{~L}_{0}$-Lipschitz, $\mathrm{L}_{1}$-smooth, $\mathrm{L}_{2}$-Lipschitz Hessian, and $\mu$-strongly convex function. Also, assume that $\mathcal{W} \subseteq \mathbb{R}^{d}$ has finite diameter $D$. Let $w^{\star}=\arg \min _{w \in \mathcal{W}} \ell\left(w, S_{n}\right)$. Then, for every $\rho>0, \beta \in(0,1)$, and $S_{n} \in \mathcal{Z}^{n}$ for sufficiently large $n$, by setting the number of iterations in Algorithm 1 to

$$
T=\Theta\left(\frac{\sqrt{\mathrm{L}_{2}}}{\mu^{3 / 4}}\left(\ell\left(w_{0}, S_{n}\right)-\ell\left(w^{\star}, S_{n}\right)\right)^{\frac{1}{4}}+\log \log \left(\frac{n \sqrt{\rho}}{\sqrt{\log (1 / \beta) d}}\right)\right),
$$

and using Algorithm 2 as DPSolver, we have the following: The output of Algorithm 1, i.e., $w_{T}$, satisfies $\rho-z C D P$ and with probability at least $1-\beta$

$$
\ell\left(w_{T}, S_{n}\right)-\ell\left(w^{\star}, S_{n}\right) \leq \tilde{O}\left(\frac{d\left(\mathrm{~L}_{0}+\mathrm{L}_{1} D\right)^{2} \log (1 / \beta)}{\mu \rho n^{2}} \cdot\left(\frac{\mathrm{~L}_{2}^{2} \mathrm{~L}_{0} D}{\mu^{3}}\right)^{\frac{1}{4}}\right)
$$

Remark 4.3. The lower bound on the excess error of any DP algorithm for the class of strongly convex functions [BST14, Thm. 5.5] implies that the achievable excess error in Theorem 4.2 is optimal in terms of the dependence on $d, \rho$, and $n$. Also, the oracle complexity of our algorithm is an exponential improvement over the oracle complexity of first-order methods STU17.
Remark 4.4. The proof of Theorem 4.2 suggests that Algorithm 1 has two phases. First, while $w_{t}$ is far from $w^{\star}$, the convergence rate is $1 / T^{4}$. Second, when $w_{t}$ is close to $w^{\star}$, the algorithm exhibits the convergence rate of $\exp (\exp (-T))$. Notice that Algorithm 1 is agnostic to this transition in the sense that we do not have an explicit switching step in Algorithm 1 and Algorithm 2.
Remark 4.5 (Comparison with ABL21.). In ABL21, §4], the authors propose a DP variant of Newton's method. Their main idea is to add independent noise directly to the Hessian matrix and the gradient vector using the Gaussian mechanism. They also require that the Hessian be a rank-1 matrix. The issue with adding noise directly to a full-rank Hessian matrix is that the noise scales with the dimension $d$, which can lead to a suboptimal excess loss. In contrast, our algorithm has a global convergence without placing restrictions on the rank of the Hessian matrix or the initialization.
Remark 4.6. The cubic Newton method has a non-private convergence rate of $T^{-2}$ for the class of convex (but not strongly convex) functions [NP06, Thm. 4]. We leave it as an open question whether there exists a DPSolver such that Algorithm 1 achieves an optimal excess error and oracle complexity for convex functions. However, this can be achieved by a DP variant of the first-order accelerated Nesterov's method Nes98; NJLS09; GL12; ; see Appendix B.2.

## 5 DP Logistic Regression using Second-Order Information

The main limitation of our cubic Newton's method (Algorithm 1) is that each iteration requires solving a nontrivial subproblem. So, despite low oracle complexity, it is computationally expensive. Moreover, many loss functions, such as logistic loss, are not strongly convex in the unconstrained setting. In this section, we aim to develop a fast second-order algorithm for unconstrained logistic regression avoiding this issue. In many real-world classification tasks, the logistic loss is the loss of choice. The logistic loss is a convex surrogate of the $0-1$ loss, and satisfies many regularity conditions that give rise to various practical optimization algorithms Bac10; Erd15, KSJ18.
First, we recall the logistic loss function. Let $d \in \mathbb{N}$ and $\mathcal{Z}=\mathcal{B}^{d}(1) \times\{-1,1\}$ be the dimension and data space, where $\mathcal{B}^{d}(1)=\left\{x \in \mathbb{R}^{d}:\|x\| \leq 1\right\}$ is the unit ball in $\mathbb{R}^{d}$. Let $f_{\mathrm{LL}}: \mathbb{R}^{d} \times \mathcal{Z} \rightarrow \mathbb{R}$ denote the logistic loss function defined as

$$
\begin{equation*}
f_{\mathrm{LL}}(w,(x, y))=\log (1+\exp (-y \cdot\langle w, x\rangle)) . \tag{4}
\end{equation*}
$$

The gradient and Hessian of $f_{\mathrm{LL}}$ are given by

$$
\begin{equation*}
\nabla_{w} f_{\mathrm{LL}}(w,(x, y))=\frac{-x y}{1+\exp (y\langle w, x\rangle)}, \quad \nabla_{w}^{2} f_{\mathrm{LL}}(w,(x, y))=\frac{x x^{\top}}{\left(\exp \left(-\frac{\langle w, x\rangle}{2}\right)+\exp \left(\frac{\langle w, x\rangle}{2}\right)\right)^{2}} . \tag{5}
\end{equation*}
$$

Newton's method BV04, §9.5] is based on successively minimizing a local second-order Taylor approximation on the function. Newton's method does not guarantee a global convergence [JT16; the reason is that the second-order Taylor approximation of the logistic loss can greatly underestimate the function. Next we show that it is possible to obtain a quadratic global upper bound on the logistic loss function. We will use this to develop an algorithm that converges globally.

Lemma 5.1. For every $v \in \mathbb{R}^{d}, x \in \mathbb{R}^{d}, w \in \mathbb{R}^{d}$, and $y \in\{-1,+1\}$, we have

$$
f_{\mathrm{LL}}(w,(x, y)) \leq f_{\mathrm{LL}}(v,(x, y))+\left\langle\nabla f_{\mathrm{LL}}(v,(x, y)), w-v\right\rangle+\frac{1}{2}\left\langle H_{q u}(v,(x, y))(w-v), w-v\right\rangle
$$

where $H_{q u}(v,(x, y)) \triangleq \frac{\tanh (\langle x, v\rangle / 2)}{2\langle x, v\rangle} x x^{\top} \in \mathbb{R}^{d \times d}$.
Remark 5.2. Since $f_{\mathrm{LL}}$ is $\frac{1}{4}$-smooth, we can construct a simpler global quadratic upper-bound as follows Nes98, Thm. 2.1.5]: $f_{\mathrm{LL}}(w,(x, y)) \leq f_{\mathrm{LL}}(v,(x, y))+\left\langle\nabla f_{\mathrm{LL}}(v,(x, y)), w-v\right\rangle+\frac{1}{8}\|w-v\|^{2}$. Lemma 5.1 is tighter than this, since $H_{\mathrm{qu}}(v,(x, y)) \preccurlyeq \frac{1}{4} I_{d}$; see Appendix C.2.
Remark 5.3. The second-order Taylor approximation and our upper bound in Lemma 5.1 both provide a quadratic approximation of the logistic loss. In the remainder of the paper, we write $H(v,(x, y))$ to refer to both $\nabla^{2} f_{\mathrm{LL}}(v,(x, y))$ and $H_{\mathrm{qu}}(v,(x, y))$. We refer to $H(v,(x, y))$ as the second-order information (SOI) and to $H_{\mathrm{qu}}$ as quadratic upperbound SOI. Finally, notice both $\nabla^{2} f_{\mathrm{LL}}(v,(x, y))$ and $H_{\mathrm{qu}}(v,(x, y))$ are PSD rank-1 matrices, with maximum eigenvalue $\leq \frac{1}{4}\|x\|^{2} \leq \frac{1}{4}$.

### 5.1 Algorithm Description

We are given a dataset $S_{n}=\left(\left(x_{1}, y_{1}\right), \ldots,\left(x_{n}, y_{n}\right)\right) \in\left(\mathcal{B}^{d}(1) \times\{-1,+1\}\right)^{n}$ and we aim to minimize $\ell_{\mathrm{LL}}\left(w, S_{n}\right) \triangleq \frac{1}{n} \sum_{i \in[n]} f_{\mathrm{LL}}\left(w,\left(x_{i}, y_{i}\right)\right)$. Our algorithm iteratively minimizes a quadratic approximation of $\ell_{\mathrm{LL}}\left(w, S_{n}\right)$. Consider

$$
\begin{equation*}
q_{t}(w) \triangleq \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)+\left\langle\nabla \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right), w-w_{t}\right\rangle+\frac{1}{2}\left\langle H\left(w_{t}, S_{n}\right)\left(w-w_{t}\right),\left(w-w_{t}\right)\right\rangle \tag{6}
\end{equation*}
$$

where $H\left(w_{t}, S_{n}\right) \triangleq \frac{1}{n} \sum_{i \in[n]} H\left(w_{t},\left(x_{i}, y_{i}\right)\right)$. In the non-private setting the next iterate is set to $w_{t+1}=\arg \min _{w} q_{t}(w)=w_{t}-H\left(w_{t}, S_{n}\right)^{-1} \nabla \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)$. To develop a private variant of Newton's method, we need to characterize the sensitivity of this update rule. Our key observation is that the directions corresponding to small eigenvalues of $H\left(w_{t}, S_{n}\right)$ are more sensitive than the directions corresponding to large eigenvalues. To overcome this issue, we modify the eigenvalues of $H\left(w_{t}, S_{n}\right)$ to ensure a minimum eigenvalue $\geq \lambda_{0}$, where $\lambda_{0}>0$ is a carefully chosen constant. We show how to adaptively tune $\lambda_{0}$ in Section 5.2. This procedure yields the desired stability with respect to neighbouring datasets. Formally, the modification operator is defined as follows:

Definition 5.4. Let $A \in \mathbb{R}^{d \times d}$ be a positive semi-definite (PSD) matrix and $\lambda_{0} \geq 0$. Define

$$
\Psi_{\lambda_{0}}(A, \text { clip })=\sum_{i=1}^{d} \max \left\{\lambda_{0}, \lambda_{i}\right\} u_{i} u_{i}^{\top}, \quad \Psi_{\lambda_{0}}(A, \text { add })=\sum_{i=1}^{d}\left(\lambda_{i}+\lambda_{0}\right) u_{i} u_{i}^{\top}=A+\lambda_{0} I_{d} .
$$

where $A=\sum_{i=1}^{d} \lambda_{i} u_{i} u_{i}^{\top}$ is the eigendecomposition of $A$ - i.e., $0 \leq \lambda_{1} \leq \cdots \leq \lambda_{d}$ are the eigenvalues and $u_{1}, \ldots, u_{d} \in \mathbb{R}^{d}$ are the eigenvectors, which satisfy $\forall i \neq j\left\|u_{i}\right\|=1 \wedge\left\langle u_{i}, u_{j}\right\rangle=0$.

Algorithm 3 describes our algorithm where its output satisfies $\rho$-zCDP; the privacy analysis can be found in Appendices C. 3 and C. 4 Our DP algorithm differs from the non-private Newton's method in three ways: (1) We first privatize the gradient by adding noise. (2) We modify $H\left(w_{t}, S_{n}\right)$ to ensure its eigenvalues are not too small. And (3) we add a second noise to the update computed using the noised gradient and modified second-order information (SOI).

Notice that Algorithm 3 has four variations based on the SOI and the modification of SOI, namely, Hess-clip, Hess-add, QU-clip, and QU-add which refer to using Hessian and clip, Hessian and add, quadratic upper bound (See Lemma 5.1) and clip, and quadratic upper bound and add, respectively.

Remark 5.5 (Generalization of Algorithm 3). In this section our main focus is on DP logistic regression, and the privacy guarantees hold for the logistic loss. Nevertheless, in Appendix C.6, we present a generalization of Algorithm 3 whose privacy guarantee holds for every convex, doubly differentiable, Lipschitz, and smooth loss function without any constraints on the rank of Hessian. The main technical challenge for sensitivity analysis is proving the approximate Lipschitzness of $\Psi$ in the operator norm (See Lemma C.7). This demonstrates that our algorithm is more general than objective perturbation [CMS11; KST12; INST+19] and the private damped Newton's method ABL21 which both require a low-rank Hessian.

### 5.2 Private and Adaptive Selection of Minimum Eigenvalue

One of the hyperparameters of Algorithm 3 is the minimum eigenvalue $\lambda_{0}$. There exists a tradeoff for choosing $\lambda_{0}$. We ideally want the modification to be as small as possible, so that the SOI is preserved. However, decreasing $\lambda_{0}$ increases $\sigma_{2}$ and we add more noise. To deal
with this problem, we propose a heuristic rule for an adaptive, private, and time-varying selection of the minimum eigenvalue. We wish to find $\lambda_{0, t}$ that minimizes expected loss at the next iteration, for which we have the quadratic approximation (6). More formally, we compute $\lambda_{0, t}$ as $\arg \min _{\lambda} \mathbb{E}\left[q_{t}\left(w_{t}-\Psi_{\lambda}\left(H\left(w_{t}, S_{n}\right)\right.\right.\right.$, SOI modification $\left.\left.) \tilde{g}_{t}+\left\|\tilde{g}_{t}\right\| \sigma_{2}(\lambda) \cdot \xi\right)\right]$ where $q_{t}$ is given in (6) and $\xi \sim \mathcal{N}\left(0, I_{d}\right)$. We show in Appendix C. 5 that an approximate minimizer is $\lambda_{0, t} \propto$ $\left(\frac{\operatorname{trace}\left(H_{t}\left(w_{t}, S_{n}\right)\right)}{n^{2} \times \text { privacy budget for the direction }}\right)^{\frac{1}{3}}$. Note that $\lambda_{0, t}$ depends on the data through trace $\left(H\left(w_{t}, S_{n}\right)\right)$, which has sensitivity $1 / 4 n$, so it can be estimated privately. In Appendix C.5, we provide the algorithmic description of a variant of Algorithm 3 with an adaptive and private minimum eigenvalue. In particular, we divide the privacy budget at each iteration into three parts: (1) privatizing the gradient; (2) estimating the trace of SOI; and (3) privatizing the direction. We use this variant for our numerical experiments in Section 6 .

### 5.3 Convergence Results for Algorithm 3

In this section, we provide data-dependent convergence guarantees for Algorithm 3. We express these guarantees in terms of the conditional expectation $\mathbb{E}_{t}[\cdot]=\mathbb{E}\left[\cdot \mid\left\{w_{i}\right\}_{i \in[t]}\right]$ and they can be easily extended to obtain high probability bounds. Before presenting the results, we introduce a notation. For a dataset $S_{n}=\left(\left(x_{1}, y_{1}\right), \ldots,\left(x_{n}, y_{n}\right)\right) \in\left(\mathbb{R}^{d} \times\{-1,+1\}\right)^{n}$, let $V \in \mathbb{R}^{d \times d}$ denote the orthogonal projection matrix on the linear subspace spanned by $\left\{x_{1}, \ldots, x_{n}\right\}$. For every vector $u \in \mathbb{R}^{d}$, define $\|u\|_{V} \triangleq \sqrt{u^{\top} V u}$. This norm naturally arises since for every $w \in \mathbb{R}^{d}$ we have $\ell_{\mathrm{LL}}\left(w, S_{n}\right)-\ell_{\mathrm{LL}}\left(w^{\star}, S_{n}\right) \leq \frac{1}{8}\left\|w-w^{\star}\right\|_{V}^{2}$ where $w^{\star}=\arg \min \ell_{\mathrm{LL}}\left(w, S_{n}\right)$ (See Appendix C.7).

### 5.3.1 Local Convergence Guarantee of Hess-clip and Hess-add

Theorem 5.6. Let $S_{n}$ denote the dataset and rank denote the dimension of the linar subspace spanned by $\left\{x_{1}, \ldots, x_{n}\right\}$. Let $\lambda_{\text {min }, t}$ be the smallest non-zero eigenvalue of $\nabla^{2} \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)$ and $\rho$ be the privacy budget (in $z C D P$ ) per iteration. Then,

$$
\mathbb{E}_{t}\left[\left\|w_{t+1}-w^{\star}\right\|_{V}^{2}\right] \leq \nu_{1, t}^{2}\left\|w_{t}-w^{\star}\right\|_{V}^{2}+2 \nu_{1, t} \nu_{2, t}\left\|w_{t}-w^{\star}\right\|_{V}^{3}+\nu_{2, t}^{2}\left\|w_{t}-w^{\star}\right\|_{V}^{4}+\Delta
$$

where the coefficients are given by

$$
\begin{equation*}
\nu_{1, t}=1-\frac{\tilde{\lambda}_{\text {min }, t}}{\lambda_{0}}+\frac{\sqrt{\mathrm{rank}}}{\left(4 n \lambda_{0}^{2}-\lambda_{0}\right) \sqrt{2 \rho \theta}}, \quad \nu_{2, t}=\frac{0.05}{\tilde{\lambda}_{\text {min }, t}}, \quad \Delta=O\left(\frac{\mathrm{rank}}{\rho(1-\theta) n^{2}} \frac{1}{\left(\tilde{\lambda}_{\text {min }, t}\right)^{2}}\right) . \tag{7}
\end{equation*}
$$

Here, $\tilde{\lambda}_{\text {min }, t}=\left\{\begin{array}{ll}\min \left\{\lambda_{\text {min,t }}, \lambda_{0}\right\} & \text { for } \text { Hess-clip, } \\ \lambda_{\text {min }, t}+\lambda_{0} & \text { for Hess-add, }\end{array}\right.$, depends on the modification procedure.
This type of convergence is known as composite convergence, as it is a combination of linear and quadratic rates, and has been observed in the convergence analysis of several quasi-Newton's methods EM15 Erd15, RM16; XYRRM16.
Remark 5.7. $\lambda_{\text {min }, t}$ is the smallest non-zero eigenvalue of $\nabla^{2} \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)$. Therefore, for sufficiently large $n$ we have $0<\nu_{1, t}<1$. It shows Algorithm 3 with Hessian as SOI is, in-expectation, a descent algorithm locally given $\left\|w_{t}-w^{\star}\right\|$ is sufficiently larger than $\Delta$. Roughly speaking, Theorem 5.6 guarantees a linear convergence to a ball around the optimum whose radius is given by $\Delta$. We also observe the linear rate in Figure 3. Moreover, the error due to the privacy, i.e., $\Delta$ in Equation (7), is proportional to the rank of the feature vectors which is always smaller than $d$. These interesting properties is due to the convergence analysis with respect to $\|\cdot\|_{V}$.


Figure 2: Privacy-Utility tradeoff on different datasets.

Remark 5.8. The coefficients of the convergence in Equation (7) depend on the iteration step which is an undesirable aspect of the results. In Lemma C.11, we prove that $\left|\lambda_{\text {min,t }}-\lambda_{\text {min }}^{\star}\right| \leq 0.1\left\|w_{t}-w^{\star}\right\|_{V}$ where $\lambda_{\text {min }}^{\star}$ is the smallest non-zero eigenvalue of $\nabla^{2} \ell_{\text {LL }}\left(w^{\star}, S_{n}\right)$. Therefore, the coefficients can be well-approximated by their analogous values evaluated at the optimum.

### 5.3.2 Global Convergence Guarantee of QU-clip and QU-add

We also establish a global convergence guarantee for QU-clip and QU-add. Due to the space the formal statement and proof are deferred to Appendix C.9. Roughly speaking, under the assumption of local strong convexity at the optimum [Bac14], QU-clip and QU-add converge globally: this is intuitive since QU-clip and QU-add are based on minimizing a global upper bound on the function.

## 6 Experimental Results

In this section, we evaluate the performance of our algorithm (Algorithm 3 with the adaptive minimum eigenvalue selection from Section 5.2 for the problem of binary classification using logistic regression. For brevity, many of the details behind our implementation and more experimental results are deferred to Appendix D. The setup of the experiments is as follows:

Baseline1- DP-(S)GD: The update rule is $w_{t+1}=w_{t}-\eta \nabla \ell\left(w_{t}, S_{n}\right)+\xi$ where $\xi$ is a Gaussian noise SCS13 BST14; ACGM+16]. Since the logistic loss is 1-Lipschitz, we do not need gradient clipping. The Lipschitzness parameter controls the variance of the Gaussian random vector. To draw a fair comparison and show the advantage of using second-order information, we chose the stepsize to be equal to the inverse smoothness. This setting for DP-(S)GD is minmax optimal in terms of the privacy-utility tradeoff [GL13]. Baseline2- Approximate Objective Perturbation (AOP):


Figure 3: Comparison with DP-GD Oracle where at each iteration the stepsize tuned non-privately.

AOP is built on objective perturbation CMS11, KST12. Objective perturbation consists of a twostage process: (1) perturbing the objective function by adding a random linear term and (2) outputting the minimum of the perturbed objective. Releasing such a minimum is sufficient for achieving DP guarantees CMS11; KST12, but only if we can find the exact minimum of the perturbed objective. AOP extends objective perturbation to permit using an approximate minimum of the perturbed objective [INST+19 INST+]. Notice AOP is not an iterative optimization algorithm. Baseline3Damped Newton Method [ABL21]: The algorithm in ABL21] is a variant of damped Newton's method with the assumption that the Hessian of loss function is rank-1, which holds for the logistic loss. Their algorithm is based on adding two i.i.d. noises to the Hessian and the gradient: $w_{t+1}=w_{t}-\eta_{t} H_{\text {noisy }, t}\left(w_{t}, S_{n}\right)^{-1} \tilde{g}_{t}$, where $\eta_{t}$ is the stepsize, $H_{\text {noisy }, t}\left(w_{t}, S_{n}\right)=\nabla^{2} \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)+\Xi_{t}$ and $\tilde{g}_{t}=\nabla \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)+\xi_{t}$. Here $\Xi_{t}$ and $\xi_{t}$ are carefully chosen Gaussian noise. With $\eta_{t}=1$, our experiments show that their algorithm is not converging. We use the strategy suggested in ABL21, Page 22] and set $\eta_{t}=\log \left(1+\beta_{t}\right) / \beta_{t}$ where $\beta_{t}=\left\|\nabla^{2} \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)^{-1} \nabla \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)\right\|$. This stepsize selection makes the algorithm non-private, however, it serves as a good baseline. Datasets: We conducted experiments on six publicly available datasets: a1a, Adult, covertype, synthetic, fashion-MNIST, and protein (Appendix D includes fashion-MNIST and protein results). The synthetic dataset is generated as follows: Fix $d \in \mathbb{N}$ and $w^{\star} \in \mathbb{R}^{d}$. Then, (1) the feature vectors $\left\{x_{i} \in \mathbb{R}^{d}: i \in[n]\right\}$ are independent and sampled uniformly at random from the unit sphere in $\mathbb{R}^{d}$, (2) for the $i$-th datapoint the label is +1 with probability $\left(1+\exp \left(-\left\langle x_{i}, w^{\star}\right\rangle\right)\right)^{-1}$ and -1 otherwise. Privacy Notion: The privacy notion for our experiments is $\left(\varepsilon, \delta=(\text { num. of samples })^{-2}\right)$-DP. Next, we present the results.
Privacy-Utility-Run Time Tradeoff: We study the tradeoff for our algorithm and compare it with other baselines for a broad range of $\varepsilon \in\{0.01, \ldots, 10\}$. We non-privately tune the total number

of iterations of the iterative algorithms and report the best achievable excess error in Figure 2 As can be seen our algorithm almost always achieves the best excess loss for a broad range of $\varepsilon$. Also, Figure 2 shows that damped private Newton method of ABL21 achieves a low excess loss only for large $\varepsilon$. Figure 2 indicates that DP-GD and our algorithm are the best in terms of excess loss. In Table 1, we compare the run time of DP-GD and our algorithm, i.e., the computational time in seconds for achieving the excess loss in Figure 2. As can be seen, for many challenging datasets, our algorithm is $10-40 \times$ faster than DP-GD. Our experiments are run on CPU. We also remark that each step of Algorithm 3, i.e., computing gradient and SOI, is heavily parallelizable implying that the run time of Algorithm 3 can be made much smaller by an efficient implementation. Also, the reported numbers in Figure 2 and Table 1 correspond to Hess-clip.
Second Order Information vs Optimal Stepsize: In non-private convex optimization, the key to the success of second-order optimization algorithms is that the second-order information acts as a preconditioner, and the same performance cannot be attained by optimally tuning the stepsize for GD algorithm. To investigate whether the same holds for our algorithms, we consider the following variant of DP-GD. Let $\tilde{g}_{t}$ denote the perturbed gradient obtained by adding a Gaussian random vector to $\nabla \ell_{\mathrm{LL}}\left(w_{t}, S_{n}\right)$. Instead of a constant stepsize, the stepsize at iteration $t$ is chosen based on $\eta_{t}=\arg \min _{\eta \geq 0} \ell_{\mathrm{LL}}\left(w_{t}-\eta \tilde{g}_{t}\right)$. Notice this variant is obviously not $D P$. We refer to this variant as DP-GD-Oracle. The comparison with DP-GD-Oracle lets us answer the following question: Could we have just computed a single number, i.e., stepsize, to achieve the same performance as our second-order optimization algorithms which require computing a $d \times d$ matrix? In Figure 3, we compare the convergence speed of our algorithms with DP-GD-Oracle in low- and high-privacy regimes. Figure 3 shows our algorithms converge faster than DP-GD-Oracle which is not even a DP algorithm. Figure 3 confirms the expectation that as the privacy budget increases the difference between our algorithms and DP-GD-Oracle increases since we can use more curvature information.

### 6.1 Minibatch Variant of Our Algorithm and Comparison with DP-SGD

So far we have considered full-batch algorithms that compute first- and second-order information on the entire dataset. We extend Algorithm 3 to the minibatch setting, where, at each iteration, the gradient and SOI matrix are computed using a subsample of the data points. In Appendix D.1 we provide a formal algorithmic description of the minibatch version of Algorithm 3 along with its privacy proof. Then, we compare the convergence speed and excess loss with DP-SGD.

DP-SGD is faster than DP-GD, but to achieve good privacy and utility, we need large batches PHKX +23 , Fig. 2]. This is in stark contrast with non-private SGD, where larger batch sizes yield diminishing returns $\mathrm{ZLNM}+19$. In particular, to achieve the best excess loss we need to select the batch size as large as possible. We select the batch size of DP-SGD so that the achievable

excess loss will be close to the full batch versions. Specifically, we select $\frac{\text { batch size DP-SGD }}{\text { number of samples }} \approx 0.02$ and tune the number of iterations of DP-SGD to obtain the best result. Figure 4 shows the progress of different algorithm versus run time. Obviously, for a fixed run time DP-SGD performs more iterations compared to our algorithms. Nevertheless, our algorithms achieve the same excess error as DP-GD with $8-10 \times$ faster run time over all the datasets while the batch sizes of our algorithms are larger than that of $D P-S G D$. We observe that the variations of our algorithms based on the adding operator performs better in the minibatch setting. This can be attributed to the smaller $\sigma_{2}$ for the adding operator in Algorithm 3. In summary, the comparison between privacy-utility-wall time tradeoff of the subsampled variant of our algorithm and DP-SGD is similar to their full-batch counterparts.

## 7 Future Directions

We showed that second-order methods can be used in the DP setting both for improving worst-case convergence guarantees and designing faster practical algorithms. We believe our results open up many directions: One important direction is to improve the per-iteration computational cost of our algorithm for the case that $d$ is large. In the non-private setting, a line of research tries to address this limitation by constructing an approximation to SOI such that the update is efficient, yet still provides sufficient SOI EM15; Erd15; XYRRM16; ABH17]. It would be interesting to investigate how the ideas developed in our paper could be incorporated into these methods.

## A Notations

Let $d \in \mathbb{N}$. For a vector $x \in \mathbb{R}^{d},\|x\|$ denotes the $\ell_{2}$ norm of $x$. Let $n, m \in \mathbb{N}$. For a matrix $A \in \mathbb{R}^{n \times m}$, $\|A\|=\sup _{x \in \mathbb{R}^{m}:\|x\| \leq 1}\|A x\|$ denotes the operator norm, and $\|A\|_{F} \triangleq \sqrt{\operatorname{trace}\left(A^{T} \cdot A\right)}$ denotes the Frobenius norm of $A$ where trace denotes the trace operator. $I_{d} \in \mathbb{R}^{d \times d}$ denotes the identity matrix. $\langle\cdot, \cdot\rangle$ denotes the standard inner product in $\mathbb{R}^{d}$. For a convex and closed subset $\mathcal{W} \subseteq \mathbb{R}^{d}$, let $\Pi_{\mathcal{W}}: \mathbb{R}^{d} \rightarrow \mathcal{W}$ be the Euclidean projection operator, given by $\Pi_{\mathcal{W}}(x)=\arg \min _{y \in \mathcal{W}}\|y-x\|_{2}$. For a (measurable) space $\mathcal{R}, \mathcal{M}_{1}(\mathcal{R})$ denotes the set of all probability measures on $\mathcal{R}$. Note that the statements in the paper about random variables hold almost surely. We will skip such declarations to aid readability.

## A. 1 Properties of zCDP

Lemma A. 1 ( $\left[\overline{\mathrm{BS} 16}\right.$, Prop. 1.3]). Assume we have a randomized mechanism $\mathcal{A}: \mathcal{Z} \rightarrow \mathcal{M}_{1}(\mathcal{R})$ that satisfies $\rho-z C D P$, then for every $\delta>0, \mathcal{A}$ is $(\rho+2 \sqrt{\rho \log (1 / \delta)}, \delta)-D P$.

We also repeatedly use the Gaussian mechanism which is formalized in the next lemma.
Lemma A. 2 ([BS16, Lem. 2.5]). Let $q: \mathcal{Z}^{n} \rightarrow \mathbb{R}^{d}$ be a function. Let the $\ell_{2}$-sensitivity of $q$ be $\Delta=\sup _{S_{n}, S_{n}^{\prime}}\left\|q\left(S_{n}\right)-q\left(S_{n}^{\prime}\right)\right\|$ where the supremum is over all the neighbouring datasets $S_{n}, S_{n}^{\prime}$. For every $\rho_{n}>0$, define randomized mechanism $\mathcal{A}_{n}$ such that on input $S_{n} \in \mathcal{Z}^{n}$, it outputs $\mathcal{N}\left(q\left(S_{n}\right), \frac{\Delta^{2}}{2 \rho} I_{d}\right)$. Then, $\mathcal{A}_{n}$ satisfies $\rho-z C D P$.

## B Appendix of Section 4

## B. 1 Proof of Theorem 4.2

Given a training set $S_{n}=\left(z_{1}, \ldots, z_{n}\right) \in \mathcal{Z}^{n}$, our goal is to minimize

$$
\ell\left(w, S_{n}\right)=\frac{1}{n} \sum_{i \in[n]} f\left(w, z_{i}\right) .
$$

Since $f$ is a strongly convex function and $\mathcal{W}$ is a closed and convex set, there exists a unique $w^{\star}=\arg \min _{w \in \mathcal{W}} \ell\left(w, S_{n}\right)$.
Let $M \in \mathbb{R}$. In each step of the algorithm, we construct a cubic function $\phi: \mathcal{W} \times \mathcal{W} \rightarrow \mathbb{R}$ defined as

$$
\begin{equation*}
\phi_{M}(v ; w) \triangleq \ell\left(w, S_{n}\right)+\left\langle\nabla \ell\left(w, S_{n}\right), v-w\right\rangle+\frac{1}{2}\left\langle\nabla^{2} \ell\left(w, S_{n}\right)(v-w), v-w\right\rangle+\frac{M}{6}\|v-w\|^{3} . \tag{8}
\end{equation*}
$$

We provide a lemma on the properties of $\phi_{M}(v ; w)$.
Lemma B.1. Let $f$ be $a \mathrm{~L}_{2}$-Lipschitz hessian function. Then, $\phi_{M}$ in Equation (8) satisfies the following properties:

1. For every $M \geq 0$ and $w, v \in \mathcal{W}$ such that $v \neq w$,

$$
\nabla_{v}^{2} \phi_{M}(v ; w)=\nabla^{2} \ell\left(w, S_{n}\right)+\frac{M}{2}\|v-w\| I_{d}+\frac{M}{2\|v-w\|}(v-w)(v-w)^{T} .
$$

Therefore, $\nabla_{v}^{2} \phi_{M}(v ; w) \succcurlyeq \lambda_{\min }\left(\nabla^{2} \ell\left(w, S_{n}\right)\right) I_{d}+M\|w-v\| I_{d}$ where $\lambda_{\min }\left(\nabla^{2} \ell\left(w, S_{n}\right)\right)$ denotes the minimum eigenvalue of $\nabla^{2} \ell\left(w, S_{n}\right)$.
2. For every $M \geq \mathrm{L}_{2}$ and $v, w \in \mathcal{W}$,

$$
\ell\left(v, S_{n}\right) \leq \phi_{M}(v ; w) .
$$

3. For every $M \in \mathbb{R}_{+}$and $v, w \in \mathcal{W}$,

$$
\phi_{M}(v ; w) \leq \ell\left(v, S_{n}\right)+\frac{M+\mathrm{L}_{2}}{6}\|v-w\|^{3} .
$$

Proof. To show the first claim, consider

$$
\nabla_{v} \phi_{M}(v ; w)=\nabla \ell\left(w, S_{n}\right)+\nabla^{2} \ell\left(w, S_{n}\right)(v-w)+\frac{M}{2}\|v-w\|(v-w)
$$

Then, the hessian of $\phi_{M}(v ; w)$ is given by

$$
\nabla_{v}^{2}\left(\phi_{M}(v ; w)\right)=\nabla^{2} \ell\left(w, S_{n}\right)+M\|w-v\| I_{d}+\frac{M}{\|w-v\|}(w-v)(w-v)^{T} .
$$

Note that $(w-v)(w-v)^{T}$ is a PSD and rank-1 matrix whose non-zero eigenvalue is given by $\|v-w\|^{2}$.
The second and third parts follow from (NP06, Lemma 1] where it is shown for $L_{2}$-Lipschitz hessian functions we have

$$
\begin{aligned}
\mid \ell\left(v, S_{n}\right)-\left(\ell\left(w, S_{n}\right)+\left\langle\nabla \ell\left(w, S_{n}\right), v-w\right\rangle\right. & \left.+\frac{1}{2}\left\langle\nabla^{2} \ell\left(w, S_{n}\right)(v-w),(v-w)\right\rangle\right) \mid \\
& \leq \frac{\mathrm{L}_{2}}{6}\|v-w\|^{3}
\end{aligned}
$$

The claims are straightforward applications of this inequality.
We can rephrase Equation (8) as follows:

$$
\begin{align*}
& \phi_{M}(v ; w)= \\
& \frac{1}{n} \sum_{i \in[n]} f\left(w, z_{i}\right)+\frac{1}{n} \sum_{i \in[n]}\left\langle\nabla f\left(w, z_{i}\right), v-w\right\rangle+\frac{1}{2 n} \sum_{i \in[n]}\left\langle\nabla^{2} f\left(w, z_{i}\right), v-w\right\rangle+\frac{M}{6}\|w-v\|^{3} . \tag{9}
\end{align*}
$$

Notice that $\phi_{M}(v ; w)$ is a convex function as it is sum of a quadratic function and a cubic term, i.e., $\frac{M}{6}\|v-w\|^{3}$. Also, Part 1 of Lemma B. 1 shows that $\phi_{M}(v ; w)$ is a $\mu$-strong convex function since $f$ is a $\mu$-strong convex function. Moreover, the $\ell_{2}$-sensitivity of $\nabla \phi_{M}(v ; w)$ is $n^{-1}\left(\mathrm{~L}_{0}+\mathrm{L}_{1} D\right)$, and $\phi_{M}(v ; w)$ is $\left(\mathrm{L}_{0}+\mathrm{L}_{1} D+\frac{M}{2} D^{2}\right)$-Lipschitz where $D$ denotes the diameter of $\mathcal{W}$.
First we provide the performance guarantee of the solver of the cubic subproblem in Algorithm 2
Lemma B.2. For every $\beta \in(0,1), \rho>0$, and $w \in \mathcal{W}$ the output of the subproblem solver, denoted by $\hat{v}$ satisfies $\rho T^{-1}-z C D P$ and with probability at least $1-\beta$

\phi_{M}(\hat{v} ; w)-\min _{v \in \mathcal{W}} \phi_{M}(v ; w)=O\left(\frac{d\left(\mathrm{~L}_{0}+\mathrm{L}_{1} D\right)^{2} T}{\mu \rho n^{2}} \cdot \log (1 / \beta)\right) .
$$

Proof. The privacy analysis is as follows: let the total privacy budget and the number of iterations of Meta Algorithm, i.e., Algorithm 11 denoted by $\rho$ and $T$, respectively. We require that the output of the subproblem solver at each iteration satisfies $\rho / T-\mathrm{zCDP}$ which implies the output of Algorithm 1 satisfies $\rho$-zCDP since the zCDP constant increases linearly with the number of iterations.
Now we provide a detailed proof of the suboptimality gap. To ease the notations consider the following problem. Lets assume that we want to use DPSolver to minimize the function $h$ which is $\mu$-strongly convex and $L$-Lipschitz function whose $\ell_{2}$-gradient sensitivity is given by $\Delta$. We are interested in analyzing the suboptimality gap of Algorithm 2 under the condition that the output satisfies $\tilde{\rho}$-zCDP.

Lets assume we want to run the algorithm for $N$ iterations where $N$ will be determined later. Therefore, we need to make sure that each noisy gradient computation satisfies $\tilde{\rho} / N-z \mathrm{CDP}$. To do so, the variance of the noise needs to be $\sigma^{2}=\frac{N \Delta^{2}}{2 \tilde{\rho}}$ from Lemma A. 2 .
Let $\xi_{t}$ be the noise added to the gradient at iteration $t$. Then, in each step we consider $\operatorname{grad}_{t}+\xi_{t}$ for noisy gradient. From [JNGKJ19, Lemma 1], we know that $\left\|\xi_{t}\right\|$ is a SubGaussian random variable with variance proxy of $c \sigma \sqrt{ } d$ where $c$ is a universal constant. We are now ready to use HLR19, Thm. C.3]. HLR19, Thm. C.3] shows that for every $\beta \in(0,1]$ the suboptimality gap with probability at least $1-\beta$ is given by

$$
O\left(\frac{(L+\sigma \sqrt{d})^{2}}{\mu} \frac{\log (1 / \beta)}{N}\right)=O\left(\frac{\left(L^{2}+\sigma^{2} d\right)}{\mu} \frac{\log (1 / \beta)}{N}\right)
$$

where we simply use $(a+b)^{2} \leq 2 a^{2}+2 b^{2}$ for every $a, b$. Finally, we need to plug in the value of $\sigma$ to obtain that the suboptimality gap:

O\left(\frac{\left(L^{2}+\sigma^{2} d\right)}{\mu} \frac{\log (1 / \beta)}{N}\right)=O\left(\left(\frac{L^{2}}{\mu N}+\frac{\sigma^{2} d}{\mu N}\right) \log (1 / \beta)\right)=O\left(\left(\frac{L^{2}}{\mu N}+\frac{d \Delta^{2}}{\tilde{\rho}}\right) \log (1 / \beta)\right)
$$

Then, by setting the number of iterations to $N=\frac{2 L^{2} \tilde{\rho}}{\mu d \Delta^{2}}$, we obtain that the suboptimality gap is given by $O\left(\frac{d \Delta^{2}}{\mu \tilde{\rho}} \log (1 / \beta)\right)$.
In the context of our paper, $\Delta=n^{-1}\left(L_{0}+L_{1} D\right), L=\left(L_{0}+L_{1} D+\frac{M}{2} D^{2}\right)$, and $\tilde{\rho}=\rho / T$. Setting these constants proves the lemma.

We drop the $S_{n}$ argument from $\ell\left(w, S_{n}\right)$ to reduce notational clutter. Using Part 2 of Lemma B. 1 we can write

$$
\begin{equation*}
\ell\left(w_{t+1}\right)-\ell\left(w^{\star}\right) \leq \phi_{M}\left(w_{t+1} ; w_{t}\right)-\min _{w \in \mathcal{W}} \phi_{M}\left(w ; w_{t}\right)+\min _{w \in \mathcal{W}} \phi_{M}\left(w ; w_{t}\right)-\ell\left(w^{\star}\right) . \tag{10}
\end{equation*}
$$

Since $\phi_{M}\left(w ; w_{t}\right)$ as a function of $w$ is a strongly convex function and $\mathcal{W}$ is a closed and convex set there exists a unique $w_{t+1}^{\star}=\arg \min _{w \in \mathcal{W}} \phi_{M}\left(w ; w_{t}\right)$.
Fix a $\beta \in(0,1]$ and define the following event

$$
\begin{equation*}
\mathcal{G}=\left\{\forall t \in[T]: \phi_{M}\left(w_{t} ; w_{t-1}\right)-\phi_{M}\left(w_{t}^{\star} ; w_{t-1}\right) \leq O\left(\frac{d\left(\mathrm{~L}_{0}+\mathrm{L}_{1} D\right)^{2} T}{\mu \rho n^{2}} \cdot \log (T / \beta)\right) \triangleq \Delta_{0}\right\} . \tag{11}
\end{equation*}
$$

We claim that $\mathbb{P}(\mathcal{G}) \geq 1-\beta$. In each step of the algorithm, we find an approximate minimizer of $\phi_{M}\left(w ; w_{t}\right)$ using the subproblem solver in Algorithm 2. The performance guarantee of the
subproblem solver is given in Lemma B. 2 which shows that at each step of the algorithm the excess error in minimizing $\phi_{M}\left(w ; w_{t}\right)$ is less than $\Delta_{0}$ with probability greater than $1-\beta / T$. Ergo, a union bound concludes the proof.
Next we provide an upperbound on $\phi_{M}\left(w_{t+1}^{\star} ; w_{t}\right)-\ell\left(w^{\star}\right)$ in Equation (10). By the third part of Lemma B.1 we have

$$
\phi_{M}\left(w_{t+1}^{\star} ; w_{t}\right)-\ell\left(w^{\star}\right) \leq \min _{w \in \mathcal{W}}\left\{\ell(w)+\frac{M+\mathrm{L}_{2}}{6}\left\|w-w_{t}\right\|^{3}-\ell\left(w^{\star}\right)\right\} .
$$

Since $\mathcal{W}$ is a convex set and $w_{t}, w^{\star} \in \mathcal{W}$, for all $\alpha \in[0,1],(1-\alpha) w_{t}+\alpha w^{\star} \in \mathcal{W}$. Therefore,

$$
\begin{aligned}
& \min _{w \in \mathcal{W}}\left\{\ell(w)+\frac{M+\mathrm{L}_{2}}{6}\left\|w-w_{t}\right\|^{3}-\ell\left(w^{\star}\right)\right\} \\
& \left.\leq \min _{\alpha_{t} \in[0,1]}\left\{\ell\left(\left(1-\alpha_{t}\right) w_{t}+\alpha_{t} w^{\star}\right)\right)+\frac{M+\mathrm{L}_{2}}{6} \alpha_{t}^{3}\left\|w_{t}-w^{\star}\right\|^{3}-\ell\left(w^{\star}\right)\right\} .
\end{aligned}
$$

By the convexity of $\ell$ we have $\left.\ell\left(\left(1-\alpha_{t}\right) w_{t}+\alpha_{t} w^{\star}\right)\right)-\ell\left(w^{\star}\right) \leq \ell\left(w_{t}\right)-\ell\left(w^{\star}\right)-\alpha_{t}\left(\ell\left(w_{t}\right)-\ell\left(w^{\star}\right)\right)$. Also, strong convexity implies that $\left(\frac{2}{\mu}\left(\ell\left(w_{t}\right)-\ell\left(w^{\star}\right)\right)\right)^{\frac{3}{2}} \geq\left\|w_{t}-w^{\star}\right\|^{3}$ Nes 98 . Thus,

$$
\begin{align*}
& \phi_{M}\left(w_{t+1}^{\star} ; w_{t}\right)-\ell\left(w^{\star}\right) \\
& \leq \min _{\alpha_{t} \in[0,1]}\left\{\ell\left(w_{t}\right)-\ell\left(w^{\star}\right)-\alpha_{t}\left(\ell\left(w_{t}\right)-\ell\left(w^{\star}\right)\right)+\alpha_{t}^{3} \frac{M+\mathrm{L}_{2}}{6}\left(\frac{2}{\mu}\left(\ell\left(w_{t}\right)-\ell\left(w^{\star}\right)\right)\right)^{\frac{3}{2}}\right\} \tag{12}
\end{align*}
$$

In the rest of the proof, under the event $\mathcal{G}$, we provide a convergence analysis.
Let $\lambda=\left(\frac{3}{M+\mathrm{L}_{2}}\right)^{2}\left(\frac{\mu}{2}\right)^{3}$ and $q_{t}=\lambda^{-1}\left(\ell\left(w_{t}\right)-\ell\left(w^{\star}\right)\right)$. Then, under the event $\mathcal{G}$ and by Equation 122, we can rephrase Equation (10) as

$$
\begin{equation*}
q_{t+1} \leq \lambda^{-1} \Delta_{0}+\min _{\alpha_{t} \in[0,1]}\left\{q_{t}-\alpha_{t} q_{t}+\frac{1}{2} \alpha_{t}^{3} q_{t}^{\frac{3}{2}}\right\} . \tag{13}
\end{equation*}
$$

Let $\alpha_{t}^{\star}=\arg \min _{\alpha_{t} \in[0,1]}\left\{q_{t}-\alpha_{t} q_{t}+\frac{1}{2} \alpha_{t}^{3} q_{t}^{\frac{3}{2}}\right\}=\min \left\{\sqrt{\frac{2}{3 \sqrt{q_{t}}}}, 1\right\}$.
First, consider the case that $q_{t} \geq 4 / 9$ so that $\alpha_{t}^{\star}=\sqrt{\frac{2}{3 \sqrt{q_{t}}}}$. We can rephrase Equation $\sqrt{13}$ as follows

q_{t+1} \leq \lambda^{-1} \Delta_{0}+q_{t}-\left(\frac{2}{3}\right)^{\frac{3}{2}} q_{t}^{\frac{3}{4}} . \quad(\text { Phase I) } \tag{14}
\end{equation*}

In the second case, i.e., $q_{t}<4 / 9$, we have $\alpha_{t}^{\star}=1$ Equation (13) is given by

$$
\begin{equation*}
q_{t+1} \leq \lambda^{-1} \Delta_{0}+\frac{1}{2} q_{t}^{\frac{3}{2}} . \quad \text { (Phase II) } \tag{15}
\end{equation*}
$$

Assume that $q_{0} \geq 4 / 9$. We will show that, under the event $\mathcal{G},\left\{q_{t}\right\}_{t \in[T]}$ is a decreasing sequence, and as a result there exists $T_{1} \in \mathbb{N}$, independent of $n$, such that $q_{t}<4 / 9$ for $t \geq T_{1}^{\star}$, and as a result $\alpha_{t}^{\star}=1$ for $t \geq T_{1}^{\star}$.
To prove the convergence in Phase I (see Equation (14)), we follow the techniques of Nesterov and Polyak NP06. Let $\tilde{q}_{t}=\frac{9 q_{t}}{4}$, and assume $\Delta_{0} \leq \frac{4 \lambda}{27}$. Then, we can rephrase the recursion for Phase I as follows:

\begin{aligned}
\tilde{q}_{t+1} & \leq \frac{9 \Delta_{0}}{4 \lambda}+\tilde{q}_{t}-\frac{2}{3} \tilde{q}_{t}^{\frac{3}{4}} \\
& \leq \tilde{q}_{t}-\frac{1}{3} \tilde{q}_{t}^{\frac{3}{4}}
\end{aligned}
$$

where the last step follows from $\tilde{q}_{t} \geq 1$ and $\frac{9 \Delta_{0}}{4 \lambda} \leq \frac{1}{3} \leq \frac{\tilde{q}_{t}^{\frac{3}{4}}}{3}$. It also shows that provided that $\tilde{q}_{t} \geq 1$, $\tilde{q}_{t+1} \leq \tilde{q}_{t}$.

Using induction, it is straightforward to show that in Phase 1

\frac{9 q_{t}}{4} \leq\left[\left(\frac{9 q_{0}}{4}\right)^{\frac{1}{4}}-\frac{t}{12}\right]^{4} . \quad(\text { Phase I) }
$$

This result implies that after $T_{1}^{\star}$ iterations where

\begin{equation*}
T_{1}^{\star} \leq O\left(\frac{\sqrt{M+\mathrm{L}_{2}}}{\mu^{3 / 4}}\left(\ell\left(w_{0}\right)-\ell\left(w^{\star}\right)\right)^{\frac{1}{4}}\right), \tag{16}
\end{equation*}
$$

we have $q_{T_{1}^{\star}}<\frac{4}{9}$, and we enter Phase II (see Equation (15)).
Next, we analyze Phase II in which the recursion is given by

q_{t+1} \leq \lambda^{-1} \Delta_{0}+\frac{1}{2} q_{t}^{\frac{3}{2}}
$$

Using Lemma B.3. we obtain that after $\Theta\left(\log \left(\log \left(\frac{\lambda}{\Delta_{0}}\right)\right)\right)$ iterations we have $O\left(\lambda^{-1} \Delta_{0}\right)$. Therefore, the number of iterations to achieve the minimum excess error in Phase II

$$
\begin{equation*}
T_{2}^{\star}=\tilde{\Theta}\left(\log \log \left(\frac{n}{\sqrt{\rho \log (1 / \beta) d}}\right)\right) \tag{17}
\end{equation*}
$$

Finally, the excess error is given by

$$
\begin{equation*}
\ell\left(w_{T}\right)-\ell\left(w^{\star}\right)=\tilde{O}\left(\frac{d\left(\mathrm{~L}_{0}+\mathrm{L}_{1} D\right)^{2}}{\mu \rho n^{2}} \cdot \log (1 / \beta) \cdot\left(T_{1}^{\star}+T_{2}^{\star}\right)\right) \tag{18}
\end{equation*}
$$

where $T=T_{1}^{\star}+T_{2}^{\star}$ and $T_{1}^{\star}$ and $T_{2}^{\star}$ are given by Equation (16) and Equation (17), respectively.
Lemma B.3. Let $\beta_{0}>0$ and define the sequence $a_{t+1} \leq \beta_{0}+\frac{1}{2} a_{t}^{3 / 2}$ where $a_{0} \leq \frac{16}{9}$. Then, after $T=\Theta\left(\log \log \left(\frac{1}{\beta_{0}}\right)\right)$ we have $a_{T}=O\left(\beta_{0}\right)$.

Proof. Without loss of generality, assume $a_{t+1}=\beta_{0}+\frac{1}{2} a_{t}^{3 / 2}$. We define another sequence $\left\{b_{t}\right\}_{t \in \mathbb{N}}$ as follows: $b_{0}=a_{0}$ and $b_{t+1}=\frac{3}{4}\left(b_{t}\right)^{\frac{3}{2}}$. By induction one can easily prove that for every $t \in \mathbb{N}$ such that $\beta_{0} \leq \frac{1}{4}\left(b_{t}\right)^{\frac{3}{2}}$, we have $b_{t+1} \geq a_{t+1}$. Then, we can write

b_{t+1}=\frac{3}{4}\left(b_{t}\right)^{\frac{3}{2}} \Leftrightarrow \frac{9}{16} b_{t+1}=\left(\frac{9}{16} b_{t}\right)^{\frac{3}{2}} .
$$

Therefore, we obtain that $\log \left(\frac{9}{16} b_{t}\right)=\left(\frac{3}{2}\right)^{t} \log \left(\frac{9}{16} b_{0}\right)$. We want to find $T$ such that $\beta_{0} \leq \frac{1}{4}\left(b_{T}\right)^{\frac{3}{2}} \leq 2 \beta_{0}$ which is equivalent to $\log \left(\frac{8 \beta_{0}}{3}\right) \leq \log \left(b_{T}\right) \leq \log \left(\frac{16 \beta_{0}}{3}\right)$. Then, by some simple manipulations we can see that $T=\Theta\left(\log \left(\log \left(\frac{1}{\beta_{0}}\right)\right)\right)$. Therefore, we have $b_{T+1}=O\left(\beta_{0}\right)$. Also, by the construction, $a_{T+1} \leq b_{T+1}=O\left(\beta_{0}\right)$.

## B. 2 Private Accelerated Nestrov's Method

In this section, we present a DP variant of the accelerated Nestrov's Method. The proof ideas are based on Nes98; NJLS09; GL12.

Theorem B.4. Let $f$ be a convex, $\mathrm{L}_{0}$-Lipschitz, and $\mathrm{L}_{1}$-smooth. Also, assume that $\mathcal{W} \subseteq \mathbb{R}^{d}$ is a convex set and has finite diameter $D$. Let $w^{\star} \in \arg \min _{w \in \mathcal{W}} \ell\left(w, S_{n}\right)$. Then, for every $n \in \mathbb{N}$, $S_{n} \in \mathcal{Z}^{n}$, and $\rho>0$, the output of Algorithm 4, i.e., $w_{T}^{a g}$, satisfies $\rho-z C D P$ and

$$
\mathbb{E}\left[\ell\left(w_{T}^{a g}, S_{n}\right)-\ell\left(w^{\star}, S_{n}\right)\right]=O\left(\frac{\mathrm{~L}_{0} D \sqrt{d}}{n \sqrt{\rho}}\right) .
$$

Also, the oracle complexity of Algorithm 4 is

$$
T=\Theta\left(\sqrt{\frac{D n \sqrt{\rho}}{\mathrm{~L}_{0}}}\right) .
$$

Proof. First, we start with the privacy proof. The $\ell_{2}$-sensitivity of $\nabla \ell\left(w, S_{n}\right)$ for every $w \in \mathcal{W}$ is given by $\frac{\mathrm{L}_{0}}{n}$. Therefore, by the composition properties of zCDP in [BS16, Lem. 2.3] and the zCDP analysis of the Gaussian mechansim in BS16, Lem. 2.5], it is straightforward to show that $w_{T}^{\mathrm{ag}}$ satisfies $\rho$-zCDP.

Then, we analyze the excess error. For every $v \in \mathcal{W}$, by the smoothness of $\ell$ we can write

$$
\begin{align*}
\ell\left(w_{t}^{\mathrm{ag}}\right) & \leq \ell(v)+\left\langle\nabla \ell(v), w_{t}^{\mathrm{ag}}-v\right\rangle+\frac{\mathrm{L}_{1}}{2}\left\|w_{t}^{\mathrm{ag}}-v\right\|^{2} \\
& =\ell(v)+\alpha_{t}\left\langle\nabla \ell(v), w_{t}-v\right\rangle+\left(1-\alpha_{t}\right)\left\langle\nabla \ell(v), w_{t-1}^{\mathrm{ag}}-v\right\rangle+\frac{\mathrm{L}_{1}}{2}\left\|w_{t}^{\mathrm{ag}}-v\right\|^{2} \\
& \leq \alpha_{t}\left(\ell(v)+\left\langle\nabla \ell(v), w_{t}-v\right\rangle\right)+\left(1-\alpha_{t}\right) \ell\left(w_{t-1}^{\mathrm{ag}}\right)+\frac{\mathrm{L}_{1}}{2}\left\|w_{t}^{\mathrm{ag}}-v\right\|^{2} . \tag{19}
\end{align*}
$$

Here, the second step is by definition of $w_{t}^{\text {ag }}$, and the last step is by convexity of $\ell$ which implies $\ell(v)+\left\langle\nabla \ell(v), w_{t-1}^{\mathrm{ag}}-v\right\rangle \leq \ell\left(w_{t-1}^{\mathrm{ag}}\right)$.
Note that

\begin{aligned}
w_{t}^{\mathrm{ag}}-w_{t}^{\mathrm{md}} & =\alpha_{t} w_{t}+\left(1-\alpha_{t}\right) w_{t-1}^{\mathrm{ag}}-\left(w_{t-1}^{\mathrm{ag}}+\alpha_{t}\left(w_{t-1}-w_{t-1}^{\mathrm{ag}}\right)\right) \\
& =\alpha_{t}\left(w_{t}-w_{t-1}\right) .
\end{aligned}
$$

In the next step, we substitute $v=w_{t}^{\text {md }}$ in Equation to obtain

$$
\begin{align*}
\ell\left(w_{t}^{\mathrm{ag}}\right) \leq & \alpha_{t}\left(\ell\left(w_{t}^{\mathrm{md}}\right)+\left\langle\nabla \ell\left(w_{t}^{\mathrm{md}}\right), w_{t}-w_{t}^{\mathrm{md}}\right\rangle\right)+\left(1-\alpha_{t}\right) \ell\left(w_{t-1}^{\mathrm{ag}}\right)+\frac{\mathrm{L}_{1}}{2}\left\|w_{t}^{\mathrm{ag}}-w_{t}^{\mathrm{md}}\right\|^{2} \\
= & \left(1-\alpha_{t}\right) \ell\left(w_{t-1}^{\mathrm{ag}}\right)+\alpha_{t}\left(\ell\left(w_{t}^{\mathrm{md}}\right)+\left\langle\nabla \ell\left(w_{t}^{\mathrm{md}}\right), w_{t}-w_{t}^{\mathrm{md}}\right\rangle\right)+\frac{\mathrm{L}_{1} \alpha_{t}^{2}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} \\
= & \left(1-\alpha_{t}\right) \ell\left(w_{t-1}^{\mathrm{ag}}\right)+\alpha_{t}\left(\ell\left(w_{t}^{\mathrm{md}}\right)+\left\langle\nabla \ell\left(w_{t}^{\mathrm{md}}\right), w_{t}-w_{t}^{\mathrm{md}}\right\rangle\right)+\frac{\gamma_{t}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} \\
& \quad-\frac{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} . \tag{20}
\end{align*}
$$

Let $\xi_{t}=G_{t}-\nabla \ell\left(w_{t}^{\mathrm{md}}\right)$. Notice that the projection step can be written as $w_{t}=\arg \min _{v \in \mathcal{W}}\left\{\alpha_{t}\left\langle G_{t}, v-w_{t}^{\mathrm{md}}\right\rangle+\right.$ $\left.\frac{\gamma_{t}}{2}\left\|v-w_{t-1}\right\|^{2}\right\}$. The function $g: \mathcal{W} \rightarrow \mathbb{R}, g(v)=\alpha_{t}\left\langle G_{t}, v-w_{t}^{\text {md }}\right\rangle+\frac{\gamma_{t}}{2}\left\|v-w_{t-1}\right\|^{2}$ is a $\gamma_{t}$ strongly convex function. By the optimally condition for strongly convex functions we can write, for every $v \in \mathcal{W}$

\begin{align*}
& \alpha_{t}\left\langle G_{t}, w_{t}-w_{t}^{\mathrm{md}}\right\rangle+\frac{\gamma_{t}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} \\
& \leq \alpha_{t}\left\langle G_{t}, v-w_{t}^{\mathrm{md}}\right\rangle+\frac{\gamma_{t}}{2}\left\|v-w_{t-1}\right\|^{2}-\frac{\gamma_{t}}{2}\left\|v-w_{t}\right\|^{2} \\
& =\alpha_{t}\left\langle\nabla \ell\left(w_{t}^{\mathrm{md}}\right), v-w_{t}^{\mathrm{md}}\right\rangle+\alpha_{t}\left\langle\xi_{t}, v-w_{t}^{\mathrm{md}}\right\rangle+\frac{\gamma_{t}}{2}\left\|v-w_{t-1}\right\|^{2}-\frac{\gamma_{t}}{2}\left\|v-w_{t}\right\|^{2} . \tag{21}
\end{align*}
$$

By replacing $v=w^{\star}$ where $w^{\star} \in \arg \min \ell\left(w, S_{n}\right)$ in Equation (21), we obtain

$$
\begin{align*}
& \alpha_{t}\left(\ell\left(w_{t}^{\mathrm{md}}\right)+\left\langle\nabla \ell\left(w_{t}^{\mathrm{md}}\right), w_{t}-w_{t}^{\mathrm{md}}\right\rangle\right)+\frac{\gamma_{t}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} \\
& =\alpha_{t} \ell\left(w_{t}^{\mathrm{md}}\right)+\alpha_{t}\left\langle G_{t}, w_{t}-w_{t}^{\mathrm{md}}\right\rangle-\alpha_{t}\left\langle\xi_{t}, w_{t}-w_{t}^{\mathrm{md}}\right\rangle+\frac{\gamma_{t}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} \\
& \leq \alpha_{t}\left(\ell\left(w_{t}^{\mathrm{md}}\right)+\left\langle\nabla \ell\left(w_{t}^{\mathrm{md}}\right), w^{\star}-w_{t}^{\mathrm{md}}\right\rangle\right)+\alpha_{t}\left\langle\xi_{t}, w^{\star}-w_{t}\right\rangle+\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t-1}\right\|^{2}-\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t}\right\|^{2} \\
& =\alpha_{t} \ell\left(w^{\star}\right)+\alpha_{t}\left\langle\xi_{t}, w^{\star}-w_{t}\right\rangle+\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t-1}\right\|^{2}-\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t}\right\|^{2} . \tag{22}
\end{align*}
$$

From Equation (21) and Equation (22) we can write

& \ell\left(w_{t}^{\mathrm{ag}}\right)-\ell\left(w^{\star}\right) \leq\left(1-\alpha_{t}\right)\left(\ell\left(w_{t-1}^{\mathrm{ag}}\right)-\ell\left(w^{\star}\right)\right)+\alpha_{t}\left\langle\xi_{t}, w^{\star}-w_{t}\right\rangle \\
& +\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t-1}\right\|^{2}-\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t}\right\|^{2}-\frac{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}}{2}\left\|w_{t}-w_{t-1}\right\|^{2} .
\end{aligned}
$$

Note that $\xi_{t}$ is independent from the history up to time $t-1$, i.e., $\left\{\left(w_{i}^{\mathrm{md}}, w_{i}, w_{i}^{\mathrm{ag}}\right)\right\}_{i=1}^{t-1}$. Therefore, $\mathbb{E}\left[\left\langle\xi_{t}, w_{t-1}\right\rangle\right]=0$ as $\xi_{t} \sim \mathcal{N}\left(0, \sigma^{2} I_{d}\right)$. Using this observation, we can write

& \mathbb{E}\left[\alpha_{t}\left\langle\xi_{t}, w^{\star}-w_{t}\right\rangle-\frac{\gamma_{t}-L \alpha_{t}^{2}}{2}\left\|w_{t}-w_{t-1}\right\|^{2}\right] \\
& =\mathbb{E}\left[\alpha_{t}\left\langle\xi_{t}, w^{\star}-w_{t-1}\right\rangle+\alpha_{t}\left\langle\xi_{t}, w_{t}-w_{t-1}\right\rangle-\frac{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}}{2}\left\|w_{t}-w_{t-1}\right\|^{2}\right] \\
& \leq \mathbb{E}\left[\alpha_{t}\left\|\xi_{t}\right\|\left\|w_{t}-w_{t-1}\right\|-\frac{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}}{2}\left\|w_{t}-w_{t-1}\right\|^{2}\right] \\
& \leq \frac{\alpha_{t}^{2}}{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}} \mathbb{E}\left[\left\|\xi_{t}\right\|^{2}\right] \\
& =\frac{\alpha_{t}^{2}}{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}} \cdot \sigma^{2} I_{d} \tag{23}
\end{align*}
$$

where the second step follows from Cauchy-Schwarz inequality. Therefore, we obtain that

$$
\begin{align*}
& \mathbb{E}\left[\ell\left(w_{t}^{\mathrm{ag}}\right)-\ell\left(w^{\star}\right)\right] \\
& \leq\left(1-\alpha_{t}\right) \mathbb{E}\left[\ell\left(w_{t-1}^{\mathrm{ag}}\right)-\ell\left(w^{\star}\right)\right]+\frac{\alpha_{t}^{2}\left(\sigma^{2} d\right)}{\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}}+\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t-1}\right\|^{2}-\frac{\gamma_{t}}{2}\left\|w^{\star}-w_{t}\right\|^{2} . \tag{24}
\end{align*}
$$

Let $\Gamma_{t}=\left\{\begin{array}{ll}1 & t=1 \\ \left(1-\alpha_{t}\right) \Gamma_{t-1} & t \geq 2\end{array}=\frac{2}{t(t+1)}\right.$. Note that since $\gamma=2 \mathrm{~L}_{1}$, we have $\gamma_{t}-\mathrm{L}_{1} \alpha_{t}^{2}=$ $\frac{4 \gamma}{t(t+1)}-\frac{4 \mathrm{~L}_{1}}{(t+1)^{2}}=\frac{2 \gamma}{(t+1)^{2}}$, and $\frac{\gamma_{t}}{\Gamma_{t}}=2 \gamma$. Consider dividing both side of Equation 24 by $\Gamma_{t}$ and summing up from 1 to $T$ to obtain

$$
\frac{\mathbb{E}\left[\ell\left(w_{T}^{\mathrm{ag}}\right)-\ell\left(w^{\star}\right)\right]}{\Gamma_{T}} \leq \sum_{\tau=1}^{T} \frac{\gamma_{\tau}}{2 \Gamma_{\tau}}\left(\left\|w^{\star}-w_{\tau-1}\right\|^{2}-\left\|w^{\star}-w_{\tau}\right\|^{2}\right)+\sigma^{2} d \cdot \sum_{\tau=1}^{T} \frac{1}{\Gamma_{\tau}} \cdot \frac{\alpha_{\tau}^{2}}{\gamma_{\tau}-\mathrm{L}_{1} \alpha_{\tau}^{2}} .
$$

Note that $\frac{\gamma_{t}}{\Gamma_{t}}=2 \gamma$. Therefore,

\sum_{\tau=1}^{T} \frac{\gamma_{\tau}}{2 \Gamma_{\tau}}\left(\left\|w^{\star}-w_{\tau-1}\right\|^{2}-\left\|w^{\star}-w_{\tau}\right\|^{2}\right)=\gamma\left\|w_{0}-w^{\star}\right\|^{2} \leq \gamma D^{2}
$$

Then, for the last term consider

$$
\sum_{\tau=1}^{T} \frac{1}{\Gamma_{\tau}} \cdot \frac{\alpha_{\tau}^{2}}{\gamma_{\tau}-\mathrm{L}_{1} \alpha_{\tau}^{2}}=\frac{1}{3 \gamma} T(T+1)(T+2) .
$$

By by combining all the previous steps, we get the following bound on the expected excess error

& =\frac{2}{T(T+1)} \gamma D^{2}+d \frac{2 \mathrm{~L}_{0}^{2} T(T+2)}{6 \gamma \rho n^{2}} . \tag{25}
\end{align*}
$$

Finally, optimizing Equation (25) over $T$, we conclude that with at most $T$ oracle calls where

T=\Theta\left(\left(\frac{D^{2} \rho n^{2}}{d \mathrm{~L}_{0}^{2}}\right)^{1 / 4}\right)
$$

the achievable excess error is given by

$$
\mathbb{E}\left[\ell\left(w_{T}^{\mathrm{ag}}\right)-\ell\left(w^{\star}\right)\right]=O\left(\frac{\mathrm{~L}_{0} D \sqrt{d}}{n \sqrt{\rho}}\right)
$$

## C Appendix of Section 5

## C. 1 Proof of Lemma 5.1

We begin the proof by a lemma from AMN20.


Figure 5: Comparison between the approximation of the logistic loss function

Lemma C. 1 (|AMN20, Prop. 4.1]). For all $0<\mu<1$ and $\lambda \in \mathbb{R}$, we have

$$
\frac{2}{\lambda^{2}}(\log (\mu \exp (\lambda)+1-\mu)-\mu \lambda) \leq \frac{1 / 2-\mu}{\log (1 / \mu-1)} .
$$

We will use the following reformulation of Lemma C.1. Let $\alpha \in \mathbb{R}$ and $\beta \in \mathbb{R}$ be two constants. Then, substitute $\mu=\frac{\exp (\alpha)}{1+\exp (\alpha)}$ and $\lambda=\beta-\alpha$ in Lemma C.1. By some simple manipulations we obtain that $\forall \beta, \alpha \in \mathbb{R}$

$$
\log (1+\exp (\beta)) \leq \log (1+\exp (\alpha))+\frac{\beta-\alpha}{1+\exp (-\alpha)}+\left\{\begin{array}{ll}
\frac{\exp (\alpha)-1}{4(\exp (\alpha)+1)}(\beta-\alpha)^{2} & \alpha \neq 0  \tag{26}\\
\frac{(\beta-\alpha)^{2}}{4} & \alpha=0
\end{array} .\right.
$$

Finally, let $w, v, x \in \mathbb{R}^{d}$ and $y \in\{-1,+1\}$, by substituting $\alpha=\langle-y x, v\rangle$ and $\beta=\langle-y x, w\rangle$, we obtain the stated result in Lemma 5.1.

## C. 2 Comparison of the Approximations

Consider $f: \mathbb{R} \rightarrow \mathbb{R}, f(x)=\log (1+\exp (x))$ which can be seen as a logistic loss in one dimension. Figure 5 compares the three approaches for the quadratic approximation: second-order Taylor approximation, our upper bound in Lemma 5.1, and the upper bound based on smoothness. As can be seen the upper bound in Lemma 5.1 provides tighter approximation compared to the upper bound based on smoothness. Also, the second-order Taylor approximation is not an upper bound on the function.

## C. 3 Privacy proof of Algorithm 3 for add

Theorem C.2. Assume in Algorithm 3 we choose add for the SOI modification. Then, for every training set $S_{n} \in\left(\mathbb{R}^{d} \times\{-1,+1\}\right)^{n}, w_{0} \in \mathcal{W}, \lambda_{0}>0, T \in \mathbb{N}, \rho \in \mathbb{R}_{+}$, and $\theta \in(0,1)$, by setting

$w_{T}$ satisfies $\rho-z C D P$.
Proof. For the privacy analysis, we assume a two stage procedure. The loss function is 1-Lipschitz. Therefore, by setting

\sigma_{1}=\frac{\sqrt{T}}{n \sqrt{2 \rho(1-\theta)}},
$$

the mechanism in Line 10 of Algorithm 3 satisfies $(1-\theta) \frac{\rho}{T}$-zCDP by Lemma A.2
Notice that $\Psi_{\lambda_{0}}\left(H\left(w_{t}, S_{n}\right)\right.$, add $)=H\left(w_{t}, S_{n}\right)+\lambda_{0} I_{d}$. We need to bound the $\ell_{2}$ sensitivity of the search direction which is given by

& \sup _{S_{n} \in\left(\mathbb{R}^{d} \times\{-1,1\}\right)^{n}} \sup _{z_{n+1}=\left(x_{n+1}, y_{n+1}\right) \in \mathbb{R}^{d} \times\{-1,1\}:}^{\left\|x_{n+1}\right\| \leq 1} \\
& \left\|\left[H\left(w_{t}, S_{n}\right)+\lambda_{0} I_{d}\right]^{-1} \tilde{g}_{t}-\left[H\left(w_{t}, S_{n}\right)+\frac{1}{n} H\left(w_{t}, z_{n+1}\right)+\lambda_{0} I_{d}\right]^{-1} \tilde{g}_{t}\right\| . \tag{27}
\end{align*}
$$

By the definition of the operator norm, we have

$$
\begin{aligned}
& \left\|\left[H\left(w_{t}, S_{n}\right)+\lambda_{0} I_{d}\right]^{-1} \tilde{g}_{t}-\left[H\left(w_{t}, S_{n}\right)+\frac{1}{n} H\left(w_{t}, z_{n+1}\right)+\lambda_{0} I_{d}\right]^{-1} \tilde{g}_{t}\right\| \\
& \leq\left\|\left[H\left(w_{t}, S_{n}\right)+\lambda_{0} I_{d}\right]^{-1}-\left[H\left(w_{t}, S_{n}\right)+\frac{1}{n} H\left(w_{t}, z_{n+1}\right)+\lambda_{0} I_{d}\right]^{-1}\right\|\left\|\tilde{g}_{t}\right\| .
\end{aligned}
$$

Let $A \triangleq H\left(w_{t}, S_{n}\right)+\lambda_{0} I_{d}$. For both type of the SOI, we have $H\left(w_{t}, S_{n}\right)+\frac{1}{n} H\left(w_{t}, z_{n+1}\right)+\lambda_{0} I_{d}=$ $A+\beta x_{n+1} x_{n+1}^{\top}$, where $\beta$ only depends on $x_{n+1}, w_{t}$ and $\beta \leq \frac{1}{4 n}$ (see Remark 5.3).
We can drop the subscript $n+1$ and rephrase the problem as follows

We begin by applying the Sherman-Morrison formula GV13 to $\left(A+\beta x x^{\top}\right)^{-1}$ to obtain

$$

$A$ is a PSD matrix. Let the eigenvalue decomposition of $A$ be $A=\sum_{i \in[d]} \lambda_{i} u_{i} u_{i}^{\top}=U \Lambda U^{\top}$ where $\Lambda=\operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{d}\right)$. Using this representation, we can write

\begin{aligned}
\sup _{x \in \mathbb{R}^{d}:\|x\| \leq 1}\left\|\left(A+\beta x x^{\top}\right)^{-1}-A^{-1}\right\| & =\sup _{x \in \mathbb{R}^{d}:\|x\| \leq 1} \frac{\left\|\beta A^{-1} x x^{\top} A^{-1}\right\|}{1+\beta x^{\top} A^{-1} x} \\
& =\sup _{x \in \mathbb{R}^{d}:\|x\| \leq 1} \frac{\left\|\beta U \Lambda^{-1} U^{\top} x x^{\top} U \Lambda^{-1} U^{\top}\right\|}{1+\beta x^{\top} U \Lambda^{-1} U^{\top} x} .
\end{aligned}
$$

Then, consider the change of variable to $v=U^{\top} x$ :

$$
\begin{aligned}
\sup _{x \in \mathbb{R}^{d}:\|x\| \leq 1}\left\|\left(A+\beta x x^{\top}\right)^{-1}-A^{-1}\right\| & =\sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \frac{\left\|\beta U \Lambda^{-1} v v^{\top} \Lambda^{-1} U^{\top}\right\|}{1+\beta v^{\top} \Lambda^{-1} v} \\
& =\sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \frac{\beta\left\|U \Lambda^{-1} v v^{\top} \Lambda^{-1} U^{\top}\right\|}{1+\beta v^{\top} \Lambda^{-1} v} .
\end{aligned}
$$

Notice that $U \Lambda^{-1} v v^{\top} \Lambda^{-1} U^{\top}$ is a rank-one matrix. For a rank-1 matrix, the operator norm is given by its non-zero eigenvalue. Thus,

\left\|U \Lambda^{-1} v v^{\top} \Lambda^{-1} U^{\top}\right\| & =\left\|U \Lambda^{-1} v\right\|_{2}^{2} \\
& =\left\|\Lambda^{-1} v\right\|_{2}^{2}

The last step follows from the fact that $U$ is an orthonormal matrix. Therefore, by combining the previous representations we obtain

\sup _{x \in \mathbb{R}^{d}:\|x\| \leq 1}\left\|\left(A+\beta x x^{\top}\right)^{-1}-A^{-1}\right\|=\sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \frac{\beta\left\|\Lambda^{-1} v\right\|_{2}^{2}}{1+\beta v^{\top} \Lambda^{-1} v} .
$$

For every $a>0$, define $h: \mathbb{R} \rightarrow \mathbb{R}, h(x) \triangleq \frac{x}{1+a x}$ and notice that $h$ is increasing for $x>0$. Using this fact and by considering $v^{\top} \Lambda^{-1} v>0$ and $0<\beta \leq \frac{1}{4 n}$, we obtain

\sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \frac{\beta\left\|\Lambda^{-1} v\right\|_{2}^{2}}{1+\beta v^{\top} \Lambda^{-1} v} & \leq \sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \sup _{\beta \in\left[0, \frac{1}{4}\right]} \frac{\beta\left\|\Lambda^{-1} v\right\|_{2}^{2}}{1+\beta v^{\top} \Lambda^{-1} v} \\
& \leq \sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \frac{\frac{1}{4 n}\left\|\Lambda^{-1} v\right\|_{2}^{2}}{1+\frac{1}{4 n} v^{\top} \Lambda^{-1} v} \\
& =\sup _{v \in \mathbb{R}^{d}:\|v\| \leq 1} \frac{\sum_{i=1}^{d} \frac{1}{\lambda_{i}^{2}} v_{i}^{2}}{4 n+\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2}} .
\end{aligned}
$$

Notice that by the definition of $A$, for $i \in[d], \lambda_{0} \leq \lambda_{i}$. Therefore,

\frac{\sum_{i=1}^{d} \frac{1}{\lambda_{i}^{2}} v_{i}^{2}}{4 n+\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2}} \leq \frac{1}{\lambda_{0}} \frac{\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2}}{4 n+\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2}} .
$$

Then, note that for every $v \in \mathbb{R}^{d}$ such that $\|v\| \leq 1$, we have $\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2} \leq \frac{1}{\lambda_{0}}$. Also, $h: \mathbb{R} \rightarrow$ $\mathbb{R}, h(x) \triangleq \frac{x}{4 n+x}$ is increasing for $x>0$. Thus, using these two facts we obtain

\frac{1}{\lambda_{0}} \frac{\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2}}{4 n+\sum_{i=1}^{d} \frac{1}{\lambda_{i}} v_{i}^{2}} \leq \frac{1}{4 n \lambda_{0}^{2}+\lambda_{0}}
$$

Therefore, we showed that

& \leq \frac{\left\|\tilde{g}_{t}\right\|}{4 n \lambda_{0}^{2}+\lambda_{0}} .
\end{aligned}

This shows that by setting

Let $A=\Psi_{\lambda_{0}}\left(H\left(w_{t}, S_{n}\right)\right.$, clip $)$ and $B=\Psi_{\lambda_{0}}\left(H\left(w_{t}, S_{n}\right)+\frac{1}{n} H\left(w_{t} ; z_{n+1}\right)\right.$, clip $)$. We need a lemma for the next step of the proof.
Lemma C.4. Let $A, B \in \mathbb{R}^{d \times d}$ be positive definite matrices. If $\|A-B\| \cdot\left\|A^{-1}\right\|<1$, then

Consider the eigenvalue decomposition of $A$ as $A=\sum_{i=1}^{d} \lambda_{i} u_{i} u_{i}^{\top}=U \Lambda U^{\top}$ where $\Lambda=$ $\operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{d}\right)$ and $U \in \mathbb{R}^{d \times d}$ is matrix with $u_{i}$ on its $i$-th column. We can represent every matrix in the feasible set of the optimization in Equation 31\} as $\hat{A}=\sum_{i=1}^{d} v_{i} v_{i}^{\top} \tilde{\lambda}_{i}=V \tilde{\Lambda} V^{\top}$ where $\left\{v_{i}\right\}_{i \in[d]}$ are a orthonormal basis for $\mathbb{R}^{d}$ and $\min _{i \in[d]} \tilde{\lambda}_{i} \geq \lambda_{0}$. By using simple facts about Frobenius norm and the eigenvalue decomposition, we can write

where the last step follows from $\operatorname{trace}\left(U^{\top} \hat{A}^{2} U\right)=\operatorname{trace}\left(\hat{A}^{2}\right)=\operatorname{trace}\left(V \tilde{\Lambda}^{2} V^{\top}\right)=\operatorname{trace}\left(\tilde{\Lambda}^{2}\right)$.
As the trace operator is invariant under the cyclic permutation, we have $\operatorname{trace}\left(U^{\top} \hat{A} U \Lambda\right)=$ $\operatorname{trace}\left(U \Lambda U^{\top} \hat{A}\right)=\operatorname{trace}(A \hat{A})$. Then, we invoke Von Neumann's trace inequality Mir75 which states that

For the second part, notice that the feasible set in the optimization problem Equation (31) is a convex and closed subset of $\mathbb{R}^{d \times d}$. Also, Frobenius norm is a metric induced by an inner product over the vector space of the real symmetric matrices. Notice that by the definition of the adding and clipping operators in Definition 5.4. $H\left(w_{t}, S_{n}\right)$ and $\tilde{H}_{t}$ share the same eigenvectors.
To approximate Equation (36), we assume $\tilde{g}_{t} \approx \nabla \ell\left(w_{t}, S_{n}\right)$. Then, by the change of variable $b=U^{\top} \tilde{g}$, we can rephrase Equation (36) as follows

\underset{\lambda>0}{\arg \min } \mathbb{E}_{\xi_{t} \sim \mathcal{N}\left(0, I_{d}\right)}\left[\phi\left(v_{\lambda}\right)\right] \approx \underset{\lambda>0}{\arg \min }\left\{-b^{\top} \tilde{\Lambda}^{-1} b+\frac{1}{2} b^{\top} \tilde{\Lambda}^{-1} \Lambda \tilde{\Lambda}^{-1} b+\frac{\sigma_{2}^{2}\|b\|^{2}}{2} \operatorname{trace}\left(H\left(w_{t}, S_{n}\right)\right)\right\} . \tag{37}
\end{equation*}
$$

Consider the eigenvalue modification using add operator. In this case $\tilde{H}_{t}=H\left(w_{t}, S_{n}\right)+\lambda I_{d}$. Let $\Lambda=\operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{d}\right)$ and $\tilde{\Lambda}=\Lambda+\lambda I_{d}$. Also from Theorem C.2, $\sigma_{2}=\frac{1}{\left(4 n \lambda^{2}+\lambda\right) \sqrt{2 \rho_{2}}}$ where $\rho_{2}>0$ is the privacy budget. Setting these parameters in Equation (37), we get

In many practical scenarios, the SOI matrix has zero eigenvalues. This observation motivates us to use the approximation $\frac{\lambda^{\star}}{\left(\lambda_{i}+\lambda^{\star}\right)^{3}} \approx \frac{1}{\left(\lambda^{\star}\right)^{2}}$ for all $i \in[d]$. Let $\beta \in(0,1)$ such that

By definition of $V, V x_{i}=x_{i}$. Therefore,

Since $\left(\frac{1}{n} \sum_{i=1}^{n} x_{i} x_{i}^{\top} \frac{\tanh \left(\left\langle x_{i}, w^{\star}\right\rangle / 2\right)}{2\left\langle x_{i}, w^{\star}\right\rangle}\right) \preccurlyeq \frac{1}{4} I_{d}$ and $V^{2}=V$, we have

& =\frac{1}{8}\left\|w-w^{\star}\right\|_{V}^{2},
\end{aligned}

which was to be shown.

## C. 8 Proof of Theorem 5.6

We start this section by recalling some of the well-known properties of Mahalanobis semi-norm.
Lemma C.9. Let $A \in \mathbb{R}^{d \times d}$ be a positive semi-definite matrix. For every $x, y \in \mathbb{R}^{d}$ define $\langle x, y\rangle_{A} \triangleq x^{\top}$ Ay and $\|x\|_{A} \triangleq \sqrt{\langle x, x\rangle_{A}}$. Then, the following holds:

- For every $x \in \mathbb{R}^{d}$, we have $\|x\|_{A} \geq 0$.
- for every $\alpha \in \mathbb{R}$, we have $\|\alpha x\|_{A}=|\alpha|\|x\|_{A}$.
- For every $x, y \in \mathbb{R}^{d},\|x+y\|_{A} \leq\|x\|_{A}+\|y\|_{A}$.
- For every $x, y \in \mathbb{R}^{d}$, we have $\left|\langle x, y\rangle_{A}\right| \leq\|x\|_{A}\|y\|_{A}$.

Lemma C.10. Let $A \in \mathbb{R}^{d \times d}$ be a positive semi-definite matrix. Then, for every $M \in \mathbb{R}^{d \times d}$ define

The following lemma summarizes some of the properties of the logistic loss that will be used in the proof.

In words, the directions of zero eigenvalue of $\nabla^{2} \ell_{\mathrm{LL}}\left(w, S_{n}\right)$ are orthogonal to the linear subspace spanned by $\left\{x_{1}, \ldots, x_{n}\right\}$.
3. For every $w \in \mathbb{R}^{d}$, the eigenvectors of $\nabla^{2} \ell_{\mathrm{LL}}\left(w, S_{n}\right)$ corresponding to non-zero eigenvalue lie in the linear subspace spanned by $\left\{x_{1}, \ldots, x_{n}\right\}$.
4. Fix $w \in \mathbb{R}^{d}$ and consider the eigenvalue decomposition of $\nabla^{2} \ell_{\mathrm{LL}}\left(w, S_{n}\right)$ as $\sum_{i=1}^{d} \lambda_{i} u_{i} u_{i}^{\top}$ where $\left\{\lambda_{i} \in \mathbb{R}: i \in[d]\right\}$ and $\left\{u_{i} \in \mathbb{R}^{d}: i \in[d]\right\}$ denote the eigenvalues and eigenvectors. Let $\lambda_{\text {min }, w}=\min \left\{\lambda_{i}: \lambda_{i}>0\right\}$. Then,

where $\Psi_{\lambda_{0}}(\cdot, \cdot)$ is defined in Definition 5.4.

& \left.\leq \frac{1}{n} \sum_{i=1}^{n}\left\|x_{i} x_{i}^{\top}\right\|_{V} \max _{i \in[n]} \right\rvert\,\left(g\left(\left\langle w, x_{i}\right\rangle\right)-g\left(\left\langle w^{\prime}, x_{i}\right\rangle\right) \mid\right. \\
& \leq \max _{i \in[n]} \| g\left(\left\langle w, x_{i}\right\rangle\right)-g\left(\left\langle w^{\prime}, x_{i}\right\rangle \|,\right.
\end{aligned}
$$

where the second and third steps follow form Lemma C.10 and $\left\|x_{i} x_{i}^{\top}\right\|_{V}=\left\|x_{i} x_{i}^{\top}\right\|_{2} \leq 1$. It is easy to show there exists $\mathrm{L}_{2}<0.1$ such that $g$ is $\mathrm{L}_{2}$-Lipschitz. Therefore,

## D Appendix of Section 6

In this section, we present the details of the implementation and additional experiment results.

## D. 1 Subsampled variant of Our Algorithm

In this section, we show how to extend Algorithm 3 to the minibatch version.
Let's assume we have $m$ queries, denoted as $q_{i}: \mathcal{Z}^{\star} \rightarrow \mathbb{R}^{d}$, where $i \in[m$, and each query has an $\ell_{2}$ sensitivity of one. We want to sequentially compose these queries using the Sampled Gaussian Mechanism (SGM), which combines subsampling and additive Gaussian noise (MTZ19. To determine the appropriate noise level for achieving the desired privacy, we assume we have an access to function get_noise_multiplier which takes as input the total privacy budget, $m$, and the subsampling probability and outputs the minimum standard deviation of noise for Gaussian Mechanism to achieve the required privacy. Such a function can be found in various publicly available privacy libraries.

Theorem D.1. For every training set $S_{n} \in \mathcal{Z}^{n}, \lambda_{0}>0, \theta \in(0,1)$, privacy budget $(\varepsilon, \delta)$ - $D P$, initialization $w_{0}$, number of iterations $T$, SOI modification $\in\{$ clip, add $\}$, and sampling rates $p_{g}, p_{H} \in$ $(0,1)$ for gradient and SOI, the output of Algorithm 7, i.e., $w_{T}$ satisfies $(\varepsilon, \delta)-D P$.

Proof. In Algorithm 7, we have two types of SGMs, 1) gradient SGM, 2) SOI SGM. The result from Lyu22; VZ22 indicate that we can interleave these mechanisms in a way that we have $T$
composition of only gradient SGM followed by $T$ composition of SOI SGM. Using this observation, the privacy proof is a straightforward extension of the sensitivity analysis in Theorem C. 2 and Theorem C. 3 .
