## DYNAMICS OF INNER FUNCTIONS REVISITED

JON AARONSON AND MAHENDRA NADKARNI

Abstract. We study the circle restrictions of inner functions of the unit disc showing that the local invertibility of a restriction is independent of its singularity set and proving a local characterization of analytic conditional expectations.

We establish central limit properties for some stochastic processes driven by probability preserving restrictions via spectral analysis of their perturbed transfer operators.

#### §1 Introduction

An *inner function* of the *unit disc*  $\mathfrak{D} = \{z \in \mathbb{C} : |z| < 1\}$  is an analytic endomorphism  $\phi : \mathfrak{D} \leftrightarrow$  so that for  $m \coloneqq$  Leb-a.e.  $x \in \mathbb{T} \coloneqq \mathbb{R}/\mathbb{Z} \cong [0,1)$ ,

$$
\phi(r\chi(x)) \xrightarrow[r\to 1-]{} \phi(\chi(x)) \in \partial \mathfrak{D}
$$

where  $\chi : \mathbb{T} \to \partial \mathfrak{D}, \ \chi(x) \coloneqq e^{2\pi i x}$ ..

The measurable map  $\tau = \tau(\phi) : \mathbb{T} \to \mathbb{T}$  mod m defined by  $\chi(\tau x) =$  $\phi(\chi(x))$  is called the *restriction* of  $\phi$  to  $\mathbb T$  and is a nonsingular transformation of  $(\mathbb{T},m)$  by  $\varnothing$  (p[.4\)](#page-3-0).

The singularities of inner functions were studied in [\[Sei34\]](#page-29-0), although the term inner function appears first in [\[Beu48\]](#page-27-0) where it was shown that the closed subspaces of

under the operator  $f \mapsto \chi f$  are of form  $\phi \circ \chi H^2$  where  $\phi$  is inner.

Aleksandrov proved (in [\[Ale86\]](#page-27-1)) that conditional expectation with respect to a sub- $\sigma$ -algebra  $\mathcal{C} \subset \mathcal{B}(\mathbb{T})$  is *analytic* (i.e. commutes with

the orthogonal projection  $L^2 \to H_0^2 := \{f \in H^2 \hat{f}(0) = 0\}$  ) if and only if  $C = \tau^{-1} \mathcal{B}(\mathbb{T})$  where  $\tau = \tau(\phi)$  with  $\phi$  inner,  $\phi(0) = 0$ .

The ergodic theory of restrictions is discussed in [\[AW73,](#page-27-2) [LS78,](#page-28-0) [Aar78,](#page-27-3) [Neu78,](#page-28-1) [Aar81,](#page-27-4) [DM91,](#page-28-2) [Cra91,](#page-28-3) [Cra92\]](#page-28-4). See also [\[Aar97,](#page-27-5) Ch.6].

This paper deals with the structure and properties of inner functions, the spectral theory of their transfer operators and the central limit theory of stochastic processes driven by them.

It follows from results of Aleksandrov-Heins (Proposition 2.6, p[.8\)](#page-6-0) that an inner function restriction is locally invertible iff it is forward nonsingular (p. [3\)](#page-2-0). We begin §2 by showing that this holds for an arbitrary nonsingular transformation of a standard, nonatomic probability space (Proposition 2.2, p[.3\)](#page-2-0). We then consider the structure of restrictions of inner functions, showing i.a. in Proposition 2.7 (p[.9\)](#page-7-0) that a restriction can be locally invertible while each point of the circle is a singularity of the inner function.

In §5 we prove a local version of Aleksandrov's theorem on analytic conditional expectations (Theorem 5.2 on p. [25\)](#page-23-0).

In §§ 3 & 4, we restrict attention to non-Möbius, inner functions  $\phi$ :  $\mathcal{D} \leftrightarrow$  preserving an absolutely continuous probability; showing in §3 that their transfer operators have spectral gaps on suitable Banach spaces of real analytic functions, i.e. are Doeblin-Fortet operators (as on p[.13\)](#page-13-0). This smooth action of the transfer operator (in contrast to that of the restriction) is seen in  $\varnothing$  (on p[.4\)](#page-3-0). In §4 we consider central limit properties of stochastic processes  $(\psi \circ \tau^n : n \ge 1)$   $(\psi : \mathbb{T} \to \mathbb{R}^d)$ driven by such restrictions  $\tau = \tau(\phi)$ . In particular, if  $\phi : \mathfrak{D} \leftrightarrow$  has a singularity on  $\partial \mathfrak{D}$  and  $\psi$  is real analytic and not constant, then  $(\psi \circ \tau^n : n \ge 1)$  satisfies the conditional central limit theorem (con-CLT) on p[.23\)](#page-22-0).

These results rely on smooth perturbations of quasicompact transfer operators (p. [13\)](#page-13-0) considered in §§ 3 & 4.

Central limit properties of inner function restrictions can also be found in [\[NSiG22\]](#page-29-1) and [\[IU23\]](#page-28-5).

## §2 STRUCTURE

A nonsingular transformation (NST)  $(X, m, T)$  is a measurable transformation T of the non-atomic, polish probability space  $(X,m)$  satisfying  $m \circ T^{-1} \sim m$ .

The NST  $(X, m, T)$  is probability preserving (a PPT) if  $m \circ T^{-1} = m$ .

The transfer operator (aka "adjoint" or "predual") of the NST  $(X, m, T)$ is  $\tilde{T}: L^1(m) \leftarrow$  defined by

$$
\int_A \widehat{T} f dm = \int_{T^{-1}A} f dm \quad A \in \mathcal{B}(X).
$$

The following is a standard application of the disintegration theorem  $(|DM78, Ch. III|):$ 

#### Proposition 2.1 (Preimage measures)

Let  $(X, m, T)$  be a NST of the non-atomic, polish probability space, then  $\exists X_0 \in \mathcal{B}(X)$ ,  $m(X_0) = 1$  and  $\nu = \nu^{(T)} : X_0 \to \mathcal{M}(X)$  so that

<span id="page-2-1"></span> $\text{if } \quad \widehat{T}1_A(x) = \nu_x(A) \text{ for } x \in X_0, \ A \in \mathcal{B}(X) \ \& \ \nu_x(X) = \frac{dm \circ T^{-1}}{dm}(x).$ Moreover,  $\nu_x(X \setminus T^{-1}\{x\}) = 0$  &  $\nu_x \perp m$  for  $m$ -a.e.  $x \in X$ .

The function  $x \mapsto \nu_x$  is known as the *transition kernel* of  $\widehat{T}$  and the  $\nu_x$ are known as preimage measures.

#### <span id="page-2-0"></span>Local invertibility and forward nonsingularity.

Let  $(X, m, T)$  be a NST and let  $Y \in \mathcal{B}(X)$ . We'll say that  $(X, m, T)$ is:

•  $\alpha$ -locally invertible on Y (with  $\alpha \in \mathcal{B}(Y)$  an at most countable partition mod m of Y) if  $T : a \rightarrow Ta$  is invertible, non singular  $\forall a \in \alpha$ ;

• *locally invertible* on Y if it is  $\alpha$ -locally invertible for some at most countable partition  $\alpha \in \mathcal{B}(Y);$ <br>• forward nonsingular on Y

forward nonsingular on Y if  $\exists Y_0 \in \mathcal{B}(Y)$ ,  $m(Y \setminus Y_0) = 0$  so that  $A \in \mathcal{B}(Y_0)$ ,  $m(A) = 0 \implies m(T A) = 0$ .

## Proposition 2.2 (Local invertibility of NSTs)

For a NST  $(X, m, T)$  and  $Y \in \mathcal{B}(X)$ , TFAE:

(o)  $\exists Y_0 \in \mathcal{B}(Y)$ ,  $m(Y \setminus Y_0) = 0$  so that  $T^{-1}\lbrace x \rbrace$  is at most countable  $\forall x \in Y_0;$ 

(i)  $\nu_x$  is purely atomic for m-a.e.  $x \in Y$ ;

(ii) T is locally invertible on  $T^{-1}Y$ ;

(iii) T is forward nonsingular on  $T^{-1}Y$ .

**Proof** The equivalence of (o), (i)  $\&$  (ii) is shown in [\[Rok61\]](#page-29-2) (see also [\[Nad81\]](#page-28-7)). The implication (ii)  $\implies$  (iii) is standard.

We'll show that (iii)  $\implies$  (i). We claim first that the function  $y \mapsto \nu_{Ty}(\{y\})$  is measurable.

To see this let d be a polish metric on X and let  $\alpha_n$  be a sequence of partitions of  $X$  so that

 $\alpha_{n+1} > \alpha_n; m(\partial a) = 0 \ \forall \ a \in \alpha_n, \ n \geq 1; \ \sup_{a \in \alpha_n} \text{diam } a \xrightarrow[n \to \infty]{n \to \infty} 0.$ 

Thus the function  $y \mapsto \nu_{Ty}(\{y\}) = \lim_{n\to\infty} \nu_{Ty}(\alpha_n(y))$  (where  $y \in$  $\alpha_n(y) \in \alpha_n$ ) is measurable.

It follows that  $W := \{y \in Y : \nu_{Ty}(\{y\}) = 0\} \in \mathcal{B}(Y)$ . Now suppose that (i) fails, then  $m(W) > 0$ .

Next, TW is analytic, whence universally measurable and since  $T^{-1}TW \supseteq$ W, we have  $m(T^{-1}TW) \ge m(W) > 0$  whence (by nonsingularity of T),

 $m(TW) > 0.$ 

$$
For V \in \mathcal{B}(W),
$$

$$
m(V) = \int_X \nu_x(V) dm(x) = \int_{TW} \nu_x(V) dm(x).
$$

By the analytic section theorem([\[Lus30\]](#page-28-8), see also [\[Jan41\]](#page-28-9), [\[vN49\]](#page-29-3) [\[Sri98,](#page-29-4) Thm 5.5.2], [\[Coh80,](#page-28-10) §8.5]); and Lusin's theorem,

 $\exists A \in TW$  compact,  $m(A) > 0$ , and  $\pi : A \to B := \pi A \subset W$  continuous so that  $T \circ \pi = \text{Id}$ .

It follows that

$$
B \cap T^{-1}\{x\} = \begin{cases} \varnothing & x \notin A; \\ \{\pi(x)\} & x \in A \end{cases}
$$

whence

$$
\nu_x(B) = 1_A(x)\nu_x(\{\pi(x)\}) = 0 \; : \; \pi(x) \in W \; \& \; x = T(\pi(x)).
$$

Thus

$$
m(B) = \int_A \nu_x(\{\pi(x)\}) dm(x) = 0
$$

whereas  $TB = T\pi A = A$ ,  $m(TB) = m(A) > 0$  and (iii) fails.  $\varnothing$ 

### Structure of inner function restrictions.

#### Nonsingularity of restrictions.

The following shows that an inner function restriction is a nonsingular transformation of  $(\mathbb{T},m)$ .

Proposition 2.3 [\[Nor68\]](#page-29-5)

For  $\phi : \mathfrak{D} \leftrightarrow inner$ ,

$$
\text{where } \pi_z \circ \tau^{-1} = \pi_{\phi(z)}, \text{ or, equivalently: } \widehat{\tau} p_z = p_{\phi(z)}.
$$

where  $\pi_z$   $[p_z]$  is the Poisson measure [density] at z defined by

$$
\lim_{z \to \infty} d\pi_z(x) \coloneqq p_z(x) dx, \ p_z(x) \coloneqq \operatorname{Re} \frac{\chi(x) + z}{\chi(x) - z}.
$$

**Remark:**  $\varnothing$  is aka Boole's formula as a version for rational inner functions of the the upper half plane appears in [\[Boo57,](#page-28-11) p. 787] (see also [\[Gla77,](#page-28-12) §8]). For a converse to  $\varnothing$  see [\[Let77\]](#page-28-13).

#### Invariant probabilities for inner function restrictions.

### Denjoy-Wolff Theorem [\[Den26,](#page-28-14) [Wol26\]](#page-29-6)

Suppose that  $\phi : \mathfrak{D} \leftrightarrow$  is analytic, not constant and not Möbius, then there is a (unique) point  $\mathfrak{d} = \mathfrak{d}(\phi) \in \overline{\mathfrak{D}}$  such that

$$
\frac{1-|\phi(z)|^2}{|1-\overline{\mathfrak{d}}\phi(z)|^2} \ge \frac{1-|z|^2}{|1-\overline{\mathfrak{d}}z|^2} \ \forall \ z \in \mathfrak{D},
$$

and

$$
\phi^n(z) \to \mathfrak{d} \text{ as } n \to \infty \quad \forall \ z \in \mathfrak{D}.
$$

The point  $\mathfrak{d}(\phi)$  is called the *Denjoy-Wolff* point of  $\phi$ .

Corollary (see e.g. [\[Aar78,](#page-27-3) [Neu78,](#page-28-1) [DM91\]](#page-28-2))

The restriction  $\tau$  of an inner function  $\phi$  has an absolutely continuous, invariant probability if  $\mathfrak{d}(\phi) \in \mathfrak{D}$  and in this case  $(\mathbb{T}, \pi_{\mathfrak{d}(\phi)}, T)$  is either conjugate to a circle rotation or is an exact PPT.

#### Clark measures.

The preimage measures  $\nu^{(\tau)} : \mathbb{T} \to \mathcal{M}(\mathbb{T})$  of an inner function restriction  $\tau = \tau(\phi)$  correspond to its *Clark measures* (defined by (i) below). See [\[Sak07\]](#page-29-7).:

## Proposition 2.4

For  $\phi : \mathfrak{D} \leftrightarrow inner$ , (i)  $\int_{\mathbb{T}} p_z d\nu_x^{(\tau)} = p_{\phi(z)}(x);$ (ii)  $x \mapsto \nu_x^{(\tau)} (\mathbb{T} \to \mathcal{M}(\mathbb{T}))$  is weak \* continuous; (iii)  $\nu_t^{(\tau)} \perp m \ \forall \ t \in \mathbb{T}$ .

Statement (i) follows from  $\varnothing$  on p. [4.](#page-3-0) The proofs of (ii)  $\&$  (iii) can be found in [\[Sak07,](#page-29-7) §2].

Note that  $\nu_t^{(\tau)} \perp m$  for m-a.e  $t \in \mathbb{T}$  follows from  $\mathbf{r}$  on p. [3.](#page-2-1)

## Blaschke products.

Suppose that  $Z \subset \mathfrak{D}$  is countable and that  $\mathfrak{m} : Z \to \mathbb{N}$  is so that  $\sum_{a\in\mathbb{Z}}$  m $(a)(1-|a|) < \infty$ .

The Blaschke product with zero set  $Z$  and multiplicity function  $\mathfrak m$  is  $B = B_{Z,\mathfrak{m}} : \mathfrak{D} \to \mathbb{C}$  defined by

$$
B(z) \coloneqq \prod_{\alpha \in Z} b_{\alpha}(z)^{\mathfrak{m}(\alpha)} \text{ with } b_{\alpha}(z) \coloneqq c_{\alpha} \frac{z - \alpha}{1 - \overline{\alpha}z}
$$
  
where  $c_{\alpha} = \frac{-\overline{\alpha}}{\alpha} \ (\alpha \neq 0) \ \& \ c_0 = 1.$ 

Te product converges locally uniformly on  $\mathfrak D$  because

$$
|1-b_{\alpha}(z)^{\mathfrak{m}(\alpha)}| \leq \frac{1+|z|}{1-|z|} \cdot \mathfrak{m}(\alpha)(1-|\alpha|).
$$

It can be shown that B is inner, that  ${a \in \mathfrak{D} : B(a) = 0} = Z$  and that for  $a \in Z$ ,  $\frac{B(z)}{b_a(z)^{\mathfrak{m}(a)}} =: H(z)$  is bounded, analytic with  $H(a) \neq 0$ .

### Singular inner functions.

An inner function  $S : \mathfrak{D} \leftrightarrow \mathfrak{is} \ singular$  (i.e. without zeros) iff

$$
\log S(z) = -\int_{\mathbb{T}} \frac{\chi(t)+z}{\chi(t)-z} d\sigma(t)
$$

where  $\sigma \in \mathfrak{M}(\mathbb{T})$ ,  $\sigma \perp m$ .

In this situation, we'll denote  $S = S_{\sigma}$  ( $\&/\text{or } \sigma = \sigma_S$ ).

Factorization Theorem [\[Smi29\]](#page-29-8) (see also [\[Rud74,](#page-29-9) theorem 17.15])

Let  $\phi : \mathfrak{D} \leftrightarrow$  be inner function, let  $\mathcal{Z}(\phi) := \{z \in \mathfrak{D} : \phi(z) = 0\}$  and, for  $a \in \mathcal{Z}(\phi)$ , let

$$
\mathfrak{m}(a) \coloneqq \max\big\{k \geq 0 : \frac{\phi}{b_a^k} \text{ is bounded on } \mathfrak{D}\big\},\
$$

then  $\sum_{\alpha \in \mathcal{Z}(\phi)} \mathfrak{m}(a)(1-|\alpha|) < \infty$  and  $\phi = \lambda B_{\mathcal{Z}(\phi),\mathfrak{m}} \cdot S$  where  $\lambda \in \mathbb{S}^1$  and S is a singular inner function.

#### Regular points and Singularities.

A regularity point of the inner function  $\phi : \mathfrak{D} \leftrightarrow \mathfrak{b}$  a point  $z \in \partial \mathfrak{D}$  so that  $\exists U \subset \mathbb{C}$  open with  $z \in U$ , and an analytic function  $F: U \to \mathbb{C}$  so that  $F|_{U\cap\mathfrak{D}} \equiv \phi|_{U\cap\mathfrak{D}}$ .

A non-regular point in  $\partial \mathfrak{D}$  is called a *singularity*.

The *regularity set* of  $\phi$  is  $\mathfrak{r}_{\phi}$  := {regularity points of  $\phi$ } and the singularity set of  $\phi$  is  $\mathfrak{s}_{\phi} \coloneqq \partial \mathfrak{D} \setminus \mathfrak{r}_{\phi}$ .

Derivative of a restriction at a regular point.

Let  $\phi : \mathfrak{D} \leftrightarrow$  with restriction  $\tau = \tau(\phi)$ , then  $\tau$  is differentiable at each  $\theta \in \chi^{-1} \mathfrak{r}_{\phi}$  with

 $\tau'(\theta) = \partial \phi(\chi(\theta)) = |\phi'(\chi(\theta))|$  with  $\partial \phi(z) = \frac{z\phi'(z)}{\phi(z)}$ **a**  $\tau'(\theta) = \partial \phi(\chi(\theta)) = |\phi'(\chi(\theta))|$  with  $\partial \phi(z) := \frac{z\phi'(z)}{\phi(z)} = z(\log \phi)'(z)$ .

If  $\phi = \lambda B_{\mathcal{Z}(\phi),\mathfrak{m}} S_{\sigma}$ , then

$$
\mathfrak{s}_{\phi} = \mathcal{Z}(\phi)' \cup \mathtt{spt}\, \sigma
$$

and, as in [\[Mar89\]](#page-28-15)

$$
\begin{aligned} \nabla \quad \mathcal{L}(\theta) &= \sum_{\alpha \in \mathcal{Z}(\phi)} \mathfrak{m}(\alpha) p_{\alpha}(\theta) + \frac{1}{2} \int_{\mathbb{T}} \frac{d\sigma(t)}{\sin^2(\pi(\theta - t))} \\ \n&\geq \sum_{\alpha \in \mathcal{Z}(\phi)} \frac{1 - |\alpha|}{1 + |\alpha|} + \frac{\sigma(\mathbb{T})}{2} =: \eta \geq 0 \quad \forall \ \theta \in \mathbb{T} \text{ such that } \chi(\theta) \in \mathfrak{r}_{\phi} \n\end{aligned}
$$

where  $p_{\alpha}(\theta) := \text{Re} \frac{\alpha + \chi(t)}{\alpha - \chi(t)}$  and  $\sum_{\alpha \in \mathcal{Q}} := 0$ . Since either  $\mathcal{Z}(\phi) \neq \emptyset$  or  $\sigma \neq 0$ (or both), we have  $\eta > 0$ .

Interval maps. In case  $m(\mathfrak{s}_{\phi}) = 0$ , we call  $\tau : \mathbb{T} \leftrightarrow$  an *interval map* as there is an at most countable collection of disjoint open intervals  $I_n$  ⊂ **T**,  $\bigcup_{n\in\mathbb{Z}} I_n n \stackrel{m}{=} [0,1)$  so that  $T: I_n \to [0,1]$  is analytic, strictly increasing.

#### Radial limit set.

The *radial limit set* of  $\phi$  is

$$
\Lambda_{\phi} \coloneqq \{ \beta \in \partial \mathfrak{D} : \phi(r\beta) \xrightarrow[r \to 1-]{} \phi(\beta) \in \partial \mathfrak{D} \}.
$$

For example, if  $\phi(z) \coloneqq \exp[-\frac{1+z}{1-z}]$  $\frac{1+z}{1-z}$ , then

$$
\phi(r\xi) \xrightarrow[r \to 1^-]{} \begin{cases} e^{-i\cot(\frac{\theta}{2})} & \xi = \chi(\theta) \neq 1; \\ 0 & \xi = 1 \end{cases}
$$

and  $\Lambda_{\phi} = \partial \mathfrak{D} \setminus \{1\}.$ 

#### <span id="page-6-0"></span>Angular derivatives.

The inner function  $\phi : \mathfrak{D} \to$  has an *angular derivative*  $\beta \in \mathbb{C}$  at  $\xi \in \Lambda_{\phi}$ if

$$
\exists \ \beta \in \mathbb{C} \quad \text{such that} \ \frac{\phi(z) - \phi(\xi)}{z - \xi} \xrightarrow[z \to \xi]{} \beta;
$$

that is

$$
\frac{\phi(z) - \phi(\xi)}{z - \xi} \xrightarrow[z \to \xi, |\xi - z| \le K(1 - |z|)} \beta \quad \forall K > 0.
$$

Denote the angular derivative at  $\xi$  by  $\beta = \phi'_{\langle \xi \rangle}$ .

**Proposition 2.5** [\[Sak07,](#page-29-7) §3] Let  $\phi : \mathfrak{D} \leftrightarrow be$  inner with restriction  $\tau = \tau(\phi)$ . TFAE for  $\xi = \chi(x) \in \partial \mathfrak{D}$ 

- φ has an angular derivative at  $\xi$ ;
- $\bullet$   $\phi'(z) \xrightarrow[z \to \xi]{z}$  $z \rightarrow \xi$  $\beta \in \mathbb{C}$  & in this case  $\beta = \phi'_{\alpha}(\xi)$ ;
- **•**  $\int_{\mathbb{T}} \frac{d\nu_w(t)}{|\xi \chi(t)|^2} < \infty$  for some (hence all)  $w \in \mathbb{T}$ ,  $w \neq x$ .

## Proposition 2.6 (Local invertibility of restrictions)  $1$

Let  $\phi : \mathfrak{D} \leftrightarrow$  be inner and let  $E \in \mathcal{B}(\mathbb{T})$ ,  $m(E) > 0$ , then  $\tau = \tau(\phi)$ is locally invertible on E iff  $\phi$  has an angular derivative at  $\chi(x)$  for  $m-a.e.$   $x \in E$ .

**Proof**  $\Rightarrow$  Local invertibility entails forward nonsingularity whence a.s existence of angular derivatives follows from [\[Hei77\]](#page-28-16).

To see  $\Leftarrow$ , suppose that  $\phi$  has an angular derivative at  $\chi(x)$  for ma.e.  $x \in E$ . By [\[Cra91,](#page-28-3) Lemma 1.5],  $\tau$  is almost uniformly differentiable on  $E$  in the sense that

 $\bullet$  **∃**  $E_k \in \mathcal{B}(\mathbb{T})$ ,  $E_k \uparrow E$  mod *m* such that:  $\forall k, \ \varepsilon > 0 \ \exists \ \delta = \delta(k, \varepsilon) > 0$  so that

$$
\mathfrak{G} \qquad |\tau(x)-\tau(y)-(x-y)g(x)| \leq \varepsilon |x-y| \ \forall \ x, y \in E_k, \ |x-y| < \delta.
$$

where  $g(x) = |\phi'(x(x))|$  with  $\phi'$  the angular derivative of  $\phi$  at  $\chi(x)$ .

To see that  $\tau$  is forward nonsingular on E, we note that by possibly shrinking the  $E_k$  (as in  $\mathbf{\Theta}$  $\mathbf{\Theta}$  $\mathbf{\Theta}$ ), we may assume in addition that  $\exists M_k > 0$  $(k \geq 1)$  so that  $g \leq M_k$  on  $E_k$ .

Suppose that  $k \geq 1$  &  $S \in \mathcal{B}(E_k)$ ,  $m(S) = 0$  and fix  $\varepsilon > 0$ . There are intervals  $\{I_n: n \geq 1\}$  so that

$$
S \subset \bigcup_{n\geq 1} I_n, \ |I_n| \leq \delta(k,1) \ \& \ \sum_{n\geq 1} |I_n| < \frac{\varepsilon}{M_k+1}.
$$

 $\mathrm{By} \, \mathbf{\Theta},$  $\mathrm{By} \, \mathbf{\Theta},$  $\mathrm{By} \, \mathbf{\Theta},$ 

$$
|\tau(x) - \tau(y)| \le (g(x) + 1)|x - y| \le (M_k + 1)|x - y|
$$

and  $m(\tau(E_k \cap I_n)) \leq (M_k + 1)m(I_n)$ . It follows that  $\tau(S) \subset \bigcup_{n>1} \tau(E_k \cap I_n)$  whence

$$
m(\tau(S)) \leq \sum_{n\geq 1} m(\tau(E_k \cap I_n) \leq (M_k + 1) \sum_{n\geq 1} m(I_n) < \varepsilon
$$

and  $m(\tau(S)) = 0$ .

For  $S \in \mathcal{B}(E)$ ,  $m(S) = 0$ ,

$$
m(\tau(S)) \xleftarrow[k \to \infty]{} m(\tau(E_k \cap S)) = 0
$$

and  $\tau$  is forward nonsingular on E whence locally invertible on E by Proposition 2.2..  $\Box$ 

An example of a probability preserving restriction which is "a.e. continuum to one" (a.e. Clark measure is nonatomic) was constructed in [\[Don65\]](#page-28-17) (see also [\[Sak07,](#page-29-7) Ex. 9.7]).

In particular, for inner functions  $\phi$ ,  $\tau(\phi)$  is locally invertible on **T** iff  $\phi$  has an angular derivative at a.e. point on  $\partial \mathfrak{D}$ .

The next result shows that this property is independent of the singularity set.

#### Proposition 2.7

Let  $E \subseteq \mathbb{T}$  be a closed set, then

 $\exists$  an inner function  $\phi : \mathfrak{D} \leftrightarrow$  with locally invertible restriction  $\tau =$  $\tau(\phi)$  so that  $\phi(0) = 0$  &  $\mathfrak{s}_{\phi} = \chi(E)$ .

## Proof for infinite  $E^{-2}$  $E^{-2}$  $E^{-2}$

If  $E = \mathbb{T}$ , let  $\Gamma \subset \mathbb{T}$  be countable so that  $\Gamma' = \mathbb{T}$ .

Otherwise, let  $F \supseteq E \subset \mathbb{T}$  be closed so that  $F' = E$ .

If  $\mathbb{T} \setminus F = \bigcup_{n \in \mathbb{N}} (a_n, b_n)$ , then  $\Gamma' = E$  where  $\Gamma := \{a_n, b_n : n \in \mathbb{N}\}.$ 

We'll construct  $\phi$  via a Clark measure.

First fix  $\varepsilon : \Gamma \to \mathbb{R}_+$  so that  $\sum_{\gamma \in \Gamma} \varepsilon(\gamma) < \infty$  and then fix  $\pi \in \mathcal{P}(\Gamma)$  so that

$$
\sum_{\gamma\in \Gamma}\tfrac{\pi_\gamma}{\varepsilon(\gamma)^2}<\infty.
$$

We claim that

\P 1 \qquad \qquad \int_{\mathbb{T}} \frac{d\pi(t)}{|t-x|^2} < \infty \text{ for } m\text{-a.e. } x \in \mathbb{T}.
$$

## Proof of ¶1

Since

$$
\sum_{\gamma \in \Gamma} m(B(\gamma, \varepsilon(\gamma))) = 2 \sum_{\gamma \in \Gamma} \varepsilon(\gamma) < \infty
$$

with  $B(x, \varepsilon) := (x - \varepsilon, x + \varepsilon)$ , we have by the Borel-Cantelli lemma that  $\exists K \in \mathcal{B}(\mathbb{T}), K \cap \Gamma = \emptyset, m(K) = 1$  so that  $\forall x \in K, \exists \Gamma_0(x) \in \Gamma$ finite, so that

$$
|\mathfrak{V}\rangle \qquad |x-\gamma|\geq \varepsilon(\gamma) \quad \forall \ \gamma \notin \Gamma_0(x).
$$

Let  $x \in K$ , then

$$
\int_{\mathbb{T}} \frac{d\pi(t)}{|t-x|^2} = \sum_{\gamma \in \Gamma} \frac{\pi_{\gamma}}{|x-\gamma|^2} = \Big(\sum_{\gamma \in \Gamma_0(x)} + \sum_{\gamma \notin \Gamma_0(x)}\Big) \frac{\pi_{\gamma}}{|x-\gamma|^2}.
$$

Since  $K \subset \mathbb{T} \setminus \Gamma$ , we have

$$
\sum_{\gamma \in \Gamma_0(x)} \frac{\pi_\gamma}{|x - \gamma|^2} < \infty \ \forall \ x \in K
$$

\sum_{\gamma \notin \Gamma_0(x)} \frac{\pi_\gamma}{|x - \gamma|^2} \le \sum_{\gamma \notin \Gamma_0(x)} \frac{\pi_\gamma}{\varepsilon(\gamma)^2} < \infty. \quad \text{if } \P 1
$$

Next, we define  $F : \mathfrak{D} \to \mathbb{C}$  by

$$
F(z) \coloneqq \int_{\mathbb{T}} \frac{\chi(t)+z}{\chi(t)-z} d\mu(t).
$$

Note that

$$
\operatorname{Re}\left(\frac{\chi(t)+z}{\chi(t)-z}\right) = \frac{1-|z|^2}{|\chi(t)-z|^2} > 0 \quad \forall \quad z \in \mathfrak{D}
$$

so  $F : \mathfrak{D} \to \mathbb{R}_+ \times \mathbb{R}$ . Moreover, since  $\pi(\mathbb{T}) = 1$ ,  $F(0) = 1$ .

**The CONDET** To construct the inner function, define  $\phi \coloneqq \frac{F-1}{F+1}$  $\frac{F-1}{F+1}$ :  $\mathfrak{D} \rightarrow \mathbb{C}$ . Since,  $F(0) = 1$ ,  $\phi(0) = 0$  and since  $\text{Re } F > 0$  on  $\mathfrak{D}$ ,  $\phi : \mathfrak{D} \leftrightarrow \mathfrak{D}$ Since  $\pi \perp m$ , we have that for *m*-a.e.  $x \in \mathbb{T}$ ,

$$
\exists \lim_{r \to 1^-} F(r\chi(x)) =: F(\chi(t)) \in i\mathbb{R}
$$

whence for such  $x \in \mathbb{T}$ 

$$
\phi(r\chi(x)) \xrightarrow[r \to 1^-]{} \frac{F(\chi(x)) - 1}{F(\chi(x)) + 1} \in \partial \mathfrak{D}
$$

and  $\phi : \mathfrak{D} \leftrightarrow \mathfrak{a}$  is inner.

Moreover,  $\nu_0 = \pi$  whence by  $\P$ 1 and Proposition 2.5,  $\phi$  has an angular derivative at  $\chi(t)$  for a.e.  $t \in \mathbb{T}$ . By Proposition 2.6,  $\tau(\phi)$  is locally invertible.

To finish, we note that  $\mathfrak{s}_{\phi} = \texttt{spt} \,\pi' = \Gamma' = E$ .  $\Box$ 

The Baire category situation is different:

## Proposition 2.8

Suppose that the inner function  $\phi : \mathfrak{D} \leftrightarrow$  has an angular derivative at a residual set of points, then  $\mathfrak{s}_{\phi}$  is nowhere dense.

#### Proof

Fix  $w \in \mathbb{T}$  and define  $F : \mathbb{T} \to (0, \infty]$  by

$$
F(x) \coloneqq \int_{\mathbb{T}} \tfrac{d\nu_w(t)}{|\chi(x) - \chi(t)|^2}
$$

and, for  $r \in (0,1)$ , define  $F_r : \mathbb{T} \to \mathbb{R}_+$  by

$$
F_r(x) \coloneqq \int_{\mathbb{T}} \frac{d\nu_w(t)}{|r\chi(x) - \chi(t)|^2},
$$

then for each  $0 < r < 1$ ,  $F_r : \mathbb{T} \to \mathbb{R}_+$  is continuous and  $F_r(x) \longrightarrow F(x) \in (0, \infty]$   $\forall x \in \mathbb{T}$  by dominated convergence in case  $F(x) < \infty$  and by Fatou's lemma in case  $F(x) = \infty$ 

By Baire's simple limit theorem,

$$
C_{\infty} \coloneqq \{x \in \mathbb{T}: \ F: \mathbb{T} \to (0, \infty] \ \text{ is continuous at } x\}
$$

is residual in **T**.

By assumption,  $\Lambda \coloneqq [F \lt \infty]$  is residual, whence so is  $C \coloneqq C_{\infty} \cap \Lambda$ . Thus ∀  $x \in C$ ,  $\exists$  0 <  $a_x < b_x$  and an open interval  $J_x \ni x$  so that

 $a_x < F < b_x$  on  $J_x$ .

By Seidel's theorem [\[Sei34\]](#page-29-0) (see also [\[Zyg02,](#page-29-10) Thm. 7.48]),

$$
\mathfrak{s}_{\phi} \cap \chi(J_x) = \varnothing,
$$

whence  $\mathfrak{r}_{\phi}$  is open and dense and  $\mathfrak{s}_{\phi}$  is nowhere dense.  $\Box$ 

### Proposition 2.9

Let  $\phi : \mathfrak{D} \leftrightarrow$  be inner with  $\#\mathcal{Z}(\phi)$ ,  $\#\mathfrak{s}_\phi < \infty$  and  $\mathfrak{d}(\phi) \in \mathfrak{D}$ , then  $(\mathbb{T},m,\tau(\phi))$  is a piecewise analytic, increasing interval map so that

$$
\begin{aligned} \text{(U)} \qquad & |\tau'(x)| \ge \eta > 0 \ \forall \ x \in \chi^{-1} \mathfrak{r}_{\phi} \ \& \\ \exists \ d \ge 1 \ s.t. \ |\tau^{d'}(x)| \ge \beta > 1 \ \forall \ x \in \bigcap_{j=0}^{d-1} \tau^{-j} \chi^{-1} \mathfrak{r}_{\phi} \end{aligned}
$$

and

<span id="page-10-1"></span>(A) 
$$
\sup_{x \in \chi^{-1} \mathfrak{r}_{\phi}} \Delta \tau(x) < \infty \ \text{with} \ \Delta \tau(x) \coloneqq \frac{|\tau''(x)|}{\tau'(x)^2}.
$$

Interval maps satisfying [U](#page-10-0) & [A](#page-10-1) are known as Adler maps in honour of [\[Adl73\]](#page-27-7).

### Proof

Since  $\#\mathcal{Z}(\phi)$  &  $\mathfrak{s}_{\phi}$  are both finite, by **Q** on p. [7,](#page-6-1)  $\tau(\theta) = \mathfrak{T}(\theta) \mod 1$ with

\mathfrak{T}(\theta) = \mathfrak{b}(\theta) - \frac{1}{2\pi} \sum_{t \in \mathfrak{s}_{\phi}} \sigma(\lbrace t \rbrace) \cot(\pi(\theta - t))

where either  $\mathfrak{b} \equiv 0$  (when  $\mathcal{Z}(\phi) = \emptyset$ ) or  $\mathfrak{b}(\theta) = \sum_{a \in \mathcal{Z}(\phi)} \mathfrak{m}(a) p_a(\theta)$ .

It follows that  $\tau$  is differentiable on  $\chi(\theta) \in \mathfrak{r}_{\phi}$  with  $\tau'(\theta) \geq \eta > 0$ and that  $\tau$  is a piecewise analytic, increasing interval map. See also [\[Mar89\]](#page-28-15).

\Delta \tau(\theta) \leq \|\Delta \mathfrak{b}\|_{\infty} + \pi \frac{\sum_{t \in \mathfrak{s}_{\phi}} \sigma(\lbrace t \rbrace)|\frac{\cos(\pi(\theta - t))|}{\sin^{3}(\pi(\theta - t))}|}{s'(\theta)^{2}} \leq \|\Delta \mathfrak{b}\|_{\infty} + \pi \sum_{t \in \mathfrak{s}_{\phi}} \frac{\frac{\sigma(\lbrace t \rbrace)|\cos(\pi(\theta - t))|}{|\sin^{3}(\pi(\theta - t))|}}{(\frac{\sigma(\lbrace t \rbrace)}{\sin^{2}(\pi(\theta - t))})^{2}}
$$

$$
= \|\Delta \mathfrak{b}\|_{\infty} + \frac{\pi}{2} \sum_{t \in \mathfrak{s}_{\phi}} \frac{|\sin(2\pi(\theta - t))|}{\sigma(\lbrace t \rbrace)} \leq \|\Delta \mathfrak{b}\|_{\infty} + \frac{\pi}{2} \sum_{t \in \mathfrak{s}_{\phi}} \frac{1}{\sigma(\lbrace t \rbrace)} \cdot \|\Delta \mathfrak{A}
$$

**Proof of [U](#page-10-0)** There is a Möbius transformation  $\Psi : \mathfrak{D} \leftrightarrow$  so that  $\mathfrak{d}(g) = 0$  where  $g = \Psi^{-1} \circ \phi \circ \Psi$ . If the restrictions of g &  $\Psi$  are U &  $\psi$ respectively, then  $\tau^n = \psi \circ U^n \circ \psi^{-1} \ \forall \ n \geq 1$ .

## §3 Quasicompactness of transfer operators

Let  $(X, m, T)$  be a NST with transfer operator  $\widehat{T}$  :  $L^1(m) \leftarrow$ . We look for subspaces  $L \subset L^1(m)$  on which  $\widehat{T} : L \leftarrow$  acts quasicompactly (as on [13\)](#page-13-0).

### Doeblin-Fortet operators on an adapted pair.

Let  $\mathcal{L} \subset \mathcal{C} \subset L^1(m)$  be Banach spaces so that

 $(C, \mathcal{L})$  is an *adapted pair* in the sense that

•  $\|\cdot\|_{L^1(m)} \leq \|\cdot\|_{\mathcal{C}} \leq \|\cdot\|_{\mathcal{L}}, \ (\overline{\mathcal{L}})_{L^1(m)} = L^1(m)$ , and  $\mathcal{L}\text{-closed}, \mathcal{L}\text{-bounded}$ sets are C-compact.

We say that an operator  $P \in \text{hom}(\mathcal{L}, \mathcal{L}) \cap \text{hom}(\mathcal{C}, \mathcal{C})$  is *Doeblin-Fortet* (D-F) on  $(\mathcal{C}, \mathcal{L})$  if

- $DF(i)$   $||P^n f||_c \leq H ||f||_c \forall n \in \mathbb{N}, f \in L^1(m)$  &
- <span id="page-12-0"></span> $\mathsf{DF}(\text{ii})$   $\exists \kappa \geq 1 \text{ such that } ||P^{\kappa}f||_{\mathcal{L}} \leq \theta ||f||_{\mathcal{L}} + R||f||_{\mathcal{C}} \ \forall \ f \in \mathcal{L}.$

where  $R, H \in \mathbb{R}_+$  and  $\theta \in (0,1)$ .

## 3.1 Lemma: (rigidity of DF operators) [\[ITM50\]](#page-28-18)

Suppose that P is a DF operator on the adapted pair  $(C, \mathcal{L})$ . If  $f \in \mathcal{C}$ ,  $P f = f$ , then  $f \in \mathcal{L}$ .

## Proof

Suppose  $f \in \mathcal{C}$ ,  $Pf = f$  and choose  $k_n \in \mathcal{L}$ ,  $||k_n - f||_{\mathcal{C}} \longrightarrow 0$ . By [\[ITM50,](#page-28-18) Lemma 4.1], for each  $n \geq 1$ ,  $\exists \overline{k}_n \in \mathcal{L}$  so that  $P\overline{k}_n = \overline{k}_n$  and  $\|\frac{1}{N}\sum_{j=0}^{N-1} P^j k_n - \overline{k}_n\|_{\mathcal{C}} \longrightarrow 0.$  whence using DF(i),

$$
||f - \overline{k}_n||_{\mathcal{C}} \Leftrightarrow \frac{||f - \overline{k}_n||}{\sqrt{N}} \leq \frac{N-1}{2} \sum_{j=0}^{N-1} P^j (f - k_n) ||_{\mathcal{C}} \leq H ||f - k_n||_{\mathcal{C}} \xrightarrow[n \to \infty]{} 0.
$$

For  $f \in \mathcal{L}$  it now suffices that  $\sup_{n\geq 1} \|\overline{k}_n\|_{\mathcal{L}} < \infty$ . This follows from  $DF(ii):$ 

$$
\sup_{n\geq 1} \|\overline{k}_n\|_{\mathcal{L}} \leq \frac{R}{1-\theta} \sup_{n\geq 1} \|\overline{k}_n\|_{\mathcal{C}} \leq \frac{R}{1-\theta} \left(\|f\|_{\mathcal{C}} + \sup_{n\geq 1} \|f - \overline{k}_n\|_{\mathcal{C}}\right) < \infty. \quad \text{and} \
$$

#### Example 3.2

Let  $\phi : \mathfrak{D} \leftrightarrow$  be non-Möbius inner satisfying  $\#(\mathfrak{s}_{\phi} \cup \mathcal{Z}_{\phi})) < \infty$  and  $\mathfrak{d}(\phi) \in \mathfrak{D}$ . By Proposition 2.9,  $(\mathbb{T}, \pi_{\mathfrak{d}(\phi)}, \tau)$  is an Adler map (as on p. [11\)](#page-10-0). Adler maps are Gibbs-Markov whence (see [\[AD01\]](#page-27-8))

•  $\hat{\tau}$  is D-F on the adapted pair  $(L^1(m), Lip(\mathbb{T}))$  where

 $Lip(\mathbb{T}) = \{$ Lipschitz functions on  $\mathbb{T}$ }

with norm

$$
||f||_{\text{Lip}} := ||f||_1 + \sup_{x \neq y} \frac{|f(x) - f(y)|}{|y - x|}.
$$

#### <span id="page-13-0"></span>Quasicompactness.

It is shown in [\[ITM50\]](#page-28-18) that a D-F operator  $P \in \text{hom}(\mathcal{L}, \mathcal{L})$  has spectral radius  $\rho(P) \leq 1$  and that, if  $\rho(P) = 1$ , then P is quasicompact in the sense that  $\exists A = A(P) \in \text{hom}(\mathcal{L}, \mathcal{L})$  of form

$$
A = \sum_{k=1}^{N} \lambda_k E_k
$$

with  $N \geq 1, E_1, \ldots, E_N \in \text{hom}(\mathcal{L}, \mathcal{L})$  finite dimensional projections,  $\lambda_1, \ldots, \lambda_N \in S^1 := \{ z \in \mathbb{C} : |z| = 1 \}$  so that  $\rho(P - A) < 1$ .

In particular, for  $\theta \in (\rho(P-A), 1), \exists M > 0$  so that

<span id="page-13-1"></span>
$$
(\bigstar) \qquad \|P^n f - A^n f\|_{\mathcal{L}} \le M\theta^n \|f\|_{\mathcal{L}} \ \forall \ n \ge 1, \ f \in \mathcal{L}.
$$

Conversely any  $P \in \text{hom}(\mathcal{L}, \mathcal{L})$  satisfying  $\bigstar$  is a D-F operator.

If 
$$
\phi : \mathfrak{D} \leftarrow
$$
 is as in Example 3.2, then  $\tau(\phi)$  is exact,  
\n $Af = \pi_{\mathfrak{d}(\phi)}(f) := \int_{\mathbb{T}} f d\pi_{\mathfrak{d}(\phi)}$  and  $(\bigstar)$  takes the form  
\n( $\mathbb{A}$ )  $\|\tilde{\tau}^n f - \pi_{\mathfrak{d}(\phi)}(f)\|_{\text{Lip}} \leq N\theta^n \|f\|_{\text{Lip}} \ \forall \ f \in \text{Lip}(\mathbb{T})$ .

<span id="page-13-2"></span>The rest of this section is devoted to finding a version of  $\mathcal{A}$  for general probability preserving inner functions. We'll consider the action of  $\hat{\tau}$ on various spaces of real analytic functions on **T**.

**Harmonization.** The harmonization of  $f \in L^p(m)$  ( $1 \leq p \leq \infty$ ) is  $\widetilde{f}: \mathfrak{D} \to \mathbb{C}$  is defined by

$$
\widetilde{f}(z)\coloneqq \int_{\mathbb{T}} p_z f dm
$$

where  $p_z$  is as in  $\mathbb{R}^n$  on p. [4.](#page-3-1)

It is harmonic in  $\mathfrak D$  and satisfies

$$
\sup_{r\in(0,1)}\|\widetilde{f}(r\chi)\|_p=\|f\|_p.
$$

It is classical that

$$
h^{p}(\mathfrak{D}) \coloneqq \{F : \mathfrak{D} \to \mathbb{C} \text{ harmonic}, \sup_{r \in (0,1)} || F(r\chi)||_{p} < \infty \} = \{\widetilde{f} : f \in L^{p}(m)\}.
$$

and that

$$
H^{p}(\mathfrak{D}) \cong \{ f \in L^{p}(\mathbb{T}) : \ \widehat{f}(n) = 0 \ \forall \ n < 0 \} = \{ f \in h^{p} : \ \widetilde{f} \text{ analytic on } \mathfrak{D} \}.
$$
  
Let

$$
\Lambda_{\widetilde{f}} := \big[ \exists \ \lim_{r \to 1-} \widetilde{f}(r\chi) =: \widetilde{f}(\chi) \in \mathbb{C} \big],
$$

then by Fatou's theorem,  $m(\Lambda_{\tilde{f}}) = 1$  &  $\tilde{f}(\chi) = f$  a.e..

3.3 Basic Proposition

Let  $\phi : \mathfrak{D} \leftrightarrow \phi$  inner with restriction  $\tau = \tau(\phi)$ , then (i)  $F \in H^p(\mathfrak{D}) \implies \widehat{\tau} F \in H^p(\mathfrak{D}).$ (ii) if  $\phi(0) = 0$ , then for  $d \geq 1$ ,  $\hat{\tau}(\chi^d)$  is a polynomial of degree at most d.

(iii) if  $\phi^{(k)}(0) = 0 \ \forall \ 0 \leq k \leq \kappa$ , then for  $d \geq 1$ ,  $\widehat{\tau}(\chi^d)$  is a polynomial of degree at most  $\lfloor \frac{d}{\kappa} \rfloor$  $\frac{d}{\kappa}$ .

Proof of (i) and (ii) See [\[Ale87\]](#page-27-6) (also [\[Sak07,](#page-29-7) Theorem 3.1]).

#### Proof of (iii)

## Theorem 4.1 Analyticity of Perturbation

## 4.4 Exponentiation Lemma

Let  $B > 1$  &  $\psi \in k_B$ , then for each  $z \in \mathbb{C}$ ,  $b \in (1, B)$ ,

$$
\|e^{z\psi}\|_{k_b} \le \exp[\sqrt{\frac{B+b}{B-b}}|z|\|\psi\|_{k_B}].
$$

Proof By the Multiplication Lemma,

$$
\|\psi^n\|_{k_b}^2 \leq \tfrac{B+b}{B-b}\|\psi\|_{k_B}^2\|\psi^{n-1}\|_{k_b}^2 \leq \cdots \leq \big(\tfrac{B+b}{B-b}\big)^n\|\psi\|_{k_B}^{2n}
$$

and

$$
\|e^{z\psi}\|_{k_b} \le \sum_{n\ge0} \frac{|z|^n}{n!} \|\psi^n\|_{k_b} \le \sum_{n\ge0} \frac{|z|^n}{n!} \left(\frac{B+b}{B-b}\right)^{\frac{n}{2}} \|\psi\|_{k_B}^n
$$

$$
= \exp\left[\sqrt{\frac{B+b}{B-b}}|z|\|\psi\|_{k_B}\right]. \quad \text{Z}
$$

## Proof of Theorem 4.1

It suffices to show that  $\forall \omega \in \mathbb{C}$ ,  $\exists \varepsilon = \varepsilon_{\omega} > 0$  so that

To this end, fix  $\omega \in \mathbb{C}$  and  $1 < b < b_1 < b_2 < \cdots < B$ . Let  $f \in k_b$ , then for  $k \geq n$ ,

\|P_{\omega}^{(k)}(f)\|_{k_b} = \|\widehat{\tau}(\Phi^k e^{\omega \Phi} f)\|_{k_b} \le M\rho \|\Phi^k e^{\omega \Phi} f\|_{k_b} \text{ by } (\mathbf{\mathcal{S}})

\le M\rho \sqrt{\frac{b_1 + b}{b_1 - b}} \|f\|_{k_b} \|\Phi^k e^{\omega \Phi}\|_{b_1} \text{ by } (\mathbf{\hat{T}}).
$$

To [c](#page-20-1)ontinue, by repeated application of  $(\hat{\mathbf{\tau}})$  and then  $(\hat{\mathbf{\mathbf{A}}})$ 

$$
\begin{split} \|\Phi^k e^{\omega \Phi}\|_{b_1} &\leq \left(\sqrt{\tfrac{b_2+b_1}{b_2-b_1}}\right)^{k+1} \|\Phi\|_{b_2}^k \|e^{\omega \Phi}\|_{b_2} \\ &\leq \left(\sqrt{\tfrac{b_2+b_1}{b_2-b_1}}\right)^{k+1} \|\Phi\|_{b_2}^k \exp\left[\tfrac{1}{2} \left(|\omega|\sqrt{\tfrac{B+b_2}{B-b_2}}\|\Phi\|_{k_B}^2\right]. \end{split}

Thus

\|\Pi_{\omega}^{(k)}\|_{\text{hom}(k_b, k_b)} \ll (\sqrt{\tfrac{b_2 + b_1}{b_2 - b_1}})^k

#### Periodicity.

Let  $\phi : \mathfrak{D} \leftrightarrow$  be non-Möbius inner with  $\phi(0) = 0$  and let  $\psi : \mathbb{T} \to \mathbb{R}$  be measurable.

We'll call  $t \in \mathbb{R}$  a  $\tau$ -period of  $\psi$  if  $\exists$   $t \in \mathbb{R}$ ,  $\lambda \in \mathbb{C}$ ,  $|\lambda| = 1$  &  $g: \mathbb{T} \to \mathbb{C}$ measurable, so that  $e^{it\psi} = \lambda g \circ \tau / g$ .

We denote the collection of  $\tau$ -periods of  $\psi$  by  $\mathcal{Q}(\psi)$  and call  $\psi$ :  $\tau$ aperiodic if  $\mathcal{Q}(\psi) = \{0\}$  and  $\tau$ -periodic otherwise.

<span id="page-21-1"></span>It is standard to show that for  $t \in \mathbb{R}$ ,  $\lambda \in \mathbb{C}$ ,  $|\lambda| = 1$  and  $f \in L^1(m)$  $e^{it\psi} f = \lambda f \circ \tau \iff P_t(f) \coloneqq \widehat{\tau}(e^{it\psi} f) = \lambda f.$ 

## Proposition 4.5

Let  $\phi : \mathfrak{D} \leftrightarrow$  be non-Möbius inner with  $\mathfrak{d}(\phi) \in \mathfrak{D}$  &  $\mathfrak{s}_{\phi} \neq \emptyset$ . (i) If  $\psi : \mathbb{T} \to \mathbb{R}$  is non-constant, real analytic, then  $\mathcal{Q}(\psi)$  is discrete.

(ii) If  $\mathcal{Z}(\phi)$  &  $\mathfrak{s}_{\phi}$  finite, and  $\psi : \mathbb{T} \to \mathbb{R}$  is non-constant, Lipchitz continuous, then  $\mathcal{Q}(\psi) = \{0\}.$ 

## Proof of (i)

Let  $\mathcal{E} > 0$  be as in Corollary 4.2(i). Fix  $1 < b < B$  with  $\psi \in k_B$ . If  $\mathcal{Q}(\psi)$ is not discrete, then  $\exists t \in (0, \mathcal{E}) \cap \mathcal{Q}(\psi)$  and  $f \in L^1(m)$ ,  $\lambda \in \mathbb{C}$ ,  $|\lambda| = 1$ so that  $P_t(f) = \lambda f$ . For  $t \in (0, \mathcal{E}) \cap \mathcal{Q}(\psi)$ ,  $P_t$  is a DF operator on  $(L^2(m), k_b)$ . Write  $Q \coloneqq \lambda P_t$ , then  $Q : k_b \leftrightarrow \text{is a DF operator}, Qf = f$ and by Proposition 3.1,  $f \in k_b$ .

By  $\mathbf{\ddot{x}}$  we have

<span id="page-22-1"></span>
$$
f(\tau x) = \overline{\lambda} f(x) e^{it\psi(x)} \text{ for } m\text{-a.e. } x \in \mathbb{T},
$$

Using harmonization, we see that  $\mathbb{R}$  holds  $\forall x \in \Lambda_{\phi}$ . Now suppose that v is a point of discontinuity of  $\tau$ , then  $\chi(v) \in \mathfrak{s}_{\phi}$ .

BySeidel's theorem ([\[Sei34\]](#page-29-0), also [\[Zyg02,](#page-29-10) theorem 7.48]),  $\forall w \in \mathbb{R}$ **T**,  $\exists z_n = z_n(w) \in \Lambda_\phi$  so that  $z_n \to v$  and so that  $\tau(z_n) = w$ . Thus

$$
f(w) = f(\tau(z_n)) = \overline{\lambda} f(z_n) \Phi(z_n) \xrightarrow[n \to \infty]{} \overline{\lambda} f(v) \Phi(v)
$$

whence f is constant,  $e^{it\psi} \equiv \lambda$ , whence  $\psi$  (being continuous) is constant.  $\varnothing$  (i)

**Proof of (ii)** Suppose otherwise, that for some  $t \neq 0 \exists f \in L^1(m)$  so that  $\mathbf{F}$  holds. Since  $P_t$  is a DF operator on  $(L^1(m), Lip(\mathbb{T}))$  we obtain as in the proof of (i), that  $f \in \text{Lip}(\mathbb{T})$  and that  $\psi$  is constant.  $\varnothing$ 

#### Central and local limit theorems.

Let  $(X, m, T)$  be a probability preserving transformation. A stationary stochatic process driven by  $(X, m, T)$  is a quadruple  $(X, T, m, \Psi)$ where  $\Psi: X \to \mathbb{R}$  is measurable.

We'll say that the stationary stochatic process  $(X, T, m, \Psi)$  satisfies the

• central limit theorem if  $\exists \sigma > 0$  so that

$$
\text{CLT} \qquad \qquad m\left(\left[\frac{\Psi_n - n\mathbb{E}(\Psi)}{\sigma\sqrt{n}} \le t\right]\right) \xrightarrow[n \to \infty]{} \frac{1}{\sqrt{2\pi}} \int_{-\infty}^t e^{-\frac{s^2}{2}} ds;
$$

• conditional central limit theorem if  $\exists \sigma > 0$  so that

$$
\text{con-CLT} \qquad \qquad \widehat{T}^n 1_{\left[\frac{\Psi_n - n\mathbb{E}(\Psi)}{\sigma\sqrt{n}} \le t\right]} \xrightarrow[n \to \infty]{} \frac{1}{\sqrt{2\pi}} \int_{-\infty}^t e^{-\frac{s^2}{2}} ds;
$$

and

• conditional local limit theorem if  $\exists \sigma > 0$  so that for  $I \subset \mathbb{R}$  an interval, and  $k_n \in \mathbb{Z}$ ,  $\frac{k_n}{a_n}$  $\frac{k_n}{\sigma\sqrt{n}} \to \kappa \in \mathbb{R}$ :

$$
\text{con-LLT} \qquad \qquad \sigma \sqrt{n} \widehat{T}^n \big( 1_{\left[\Psi_n \in n \mathbb{E}(\Psi) + k_n + I\right]} \big) \xrightarrow[n \to \infty]{} \frac{|I|}{\sqrt{2\pi}} e^{-\frac{\kappa^2}{2}}.
$$

where |*I*| is the length of  $I$ .

#### 4.6 Limit theorems

Let  $\phi : \mathfrak{D} \leftrightarrow$  be non-Möbius inner with  $\mathfrak{d}(\phi) \in \mathfrak{D}$  &  $\mathfrak{s}_{\phi} \neq \emptyset$ . (i) If  $\psi : \mathbb{T} \to \mathbb{R}$  is real analytic, not constant, then then  $(\mathbb{T}, \pi_{\mathfrak{d}(\phi)}, \tau, \psi)$ satisfies the con-CLT.

(ii) If  $\#(\mathcal{Z}(\phi) \cup \mathfrak{s}_{\phi}) < \infty$  and  $\psi : \mathbb{T} \to \mathbb{R}$  is Lipschitz continuous, not constant, then then  $(\mathbb{T}, \pi_{\mathfrak{d}(\phi)}, \tau, \psi)$  satisfies the con-LLT.

• In both cases,  $\sigma^2 = \lim_{n \to \infty} \mathbb{E}(\frac{\psi_n^2}{n})$ .

#### Idea of proof

In both cases, the transfer operator satisfies  $\&$  on p. [14](#page-13-2) so by [\[RE83,](#page-29-13) Thm. 2 the limit for  $\sigma^2$  exists. By Proposition 4.5  $\sigma > 0$ . The Taylor expansions of  $\lambda : B(0, \varepsilon) \to \mathbb{C}$  in (i) and (ii) ( $\hat{\mathbf{m}}$ , p[.20](#page-20-0) and  $\hat{\mathbf{m}}$ , p.20 respectively) are both established by [\[RE83,](#page-29-13) Lemmas  $2 \& 3$ ]. The limit theorems are established as in [\[RE83,](#page-29-13) §3-4] with adjustments for the conditional case as in [\[AD01\]](#page-27-8).

### §5 A local version of Aleksandrov's theorem

Fix  $A \in \mathcal{B}(\mathbb{T})$ ,  $m(A) > 0$  &  $C \subseteq \mathcal{B}(A)$  be a sub- $\sigma$ -algebra. For  $1 \leq p \leq \infty$  write

$$
H_0^p(A, \mathcal{C}) \coloneqq \{ f \in H_0^p : f|_A \text{ is } C\text{-measurable} \}.
$$

By [\[Rud74,](#page-29-9) Theorem 17.18] if  $f, g \in H_0^2(m)$  and  $f|_A \equiv g|_A$ , then  $f \equiv g$ . Let  $P: H_0^2 \to H_0^2(A, \mathcal{C})$  be the orthogonal projection in the sense that

<span id="page-23-0"></span>
$$
\mathbf{\hat{C}} \qquad (\text{Id} - P)H_0^2 \subset H_0^2(A, \mathcal{C})^{\perp};
$$

& call  $(A, C)$  an *analytic pair* if

$$
\mathbb{E}_{m_A}^{\mathcal{C}}(f) = (Pf)|_A \quad \text{for } f \in H_0^2
$$

where  $m_A(B) \coloneqq m(A \cap B)$  &  $\mathbb{E}_{m_A}^c(f)$  is conditional expectation on the measure space  $(A, m_A)$  with respect to the sub- $\sigma$ -algebra  $\mathcal{C} \subseteq \mathcal{B}(A)$ .

Let  $A \in \mathcal{B}(\mathbb{T})$ ,  $m(A) > 0$ . It is easy to see that  $(A, C)$  is an analytic pair if either  $C \stackrel{m_A}{=} \mathcal{B}(A)$  (in which case  $H_0^2(A, \mathcal{C}) = H_0^2$ ); or  $\mathcal{C} \stackrel{m_A}{=} {\emptyset, A}$ (in which case  $H_0^2(A, C) = \{0\}$ ).

Next, we give an example which turns out to be general.

**Example 5.1** If  $A \in \tau^{-1}B(\mathbb{T})$  &  $C = \tau^{-1}B(\mathbb{T}) \cap A$  where  $\tau = \tau(\phi)$  with  $\phi : \mathcal{D} \leftrightarrow$ ,  $\phi(0) = 0$  inner, then  $(A, \mathcal{C})$  is a analytic pair.

Proof

We have

$$
H_0^2(A, \tau^{-1}\mathcal{B}) \coloneqq \{ f \in H_0^2 : f|_A \text{ is } \tau^{-1}\mathcal{B}\text{-measurable} \}
$$

$$
= \{ f \in H_0^2 : \exists g \in H_0^2, f|_A = g \circ \tau|_A \}
$$

$$
= H_0^2 \circ \tau \quad \text{by [Rud74, Theorem 17.18].}
$$

To continue, note that because  $m \circ \tau^{-1} = m$ ,

$$
E^{\tau^{-1}\mathcal{B}(\mathbb{T})}(f)=\widehat{\tau}(f)\circ \tau.
$$

By the Basic Proposition 3.3,  $\hat{\tau}: H_0^2 \leftrightarrow \text{whence}$ 

$$
P := E_m^{\tau^{-1}\mathcal{B}(\mathbb{T})} = \widehat{\tau}(f) \circ \tau : H_0^2 \to H_0^2 \circ \tau
$$

is orthogonal projection.

Let 
$$
A = \tau^{-1}B
$$
, then  
\n
$$
\mathbb{E}_{m_A}^{\mathcal{C}}(f) = \mathbb{E}_m^{\tau^{-1}B} (1_B \circ \tau f)|_A = (1_B \widehat{\tau} f) \circ \tau)|_A = (Pf)|_A.
$$

**Theorem 5.2** If  $(A, C)$  is a analytic pair, then either  $C = \{ \emptyset, A \}$ , or  $\exists \phi : \mathcal{D} \leftrightarrow \text{inner with } \phi(0) = 0 \text{ so that } A \in \tau^{-1} \mathcal{B} \text{ and } C = A \cap \tau^{-1} \mathcal{B} \text{ where }$  $\tau = \tau(\phi)$ .

The cases with  $C = \mathbb{T}$  are established in [\[Ale86\]](#page-27-1) <sup>[4](#page-24-0)</sup>.

Proof We claim first that

$$
\P1\ P(gf) = gP(f) \ \forall \ f \in H_0^{\infty}, \ g \in H_0^2(A, \mathcal{C}).

(g+\overline{h}+\gamma)=(PG+\overline{PH}+\gamma)=E_{m_A}^{\mathcal{C}}(f)=f.\quad \text{and}\quad
$$

 $\mathbb{T}3$  Let  $A \in \mathcal{B}(\mathbb{T})$  and let  $\mathcal{C}, \mathcal{C}' \subseteq \mathcal{B}(A)$  so that both  $(A, \mathcal{C})$  and  $(A, \mathcal{C}')$ are analytic pairs, then

Fix  $\phi \in H_0^2(A, \mathcal{C}) \cap L^{\perp}$  (inner with  $\phi(0) = 0$ ). **[6**  $H_0^2(A, \mathcal{C}) = H_0^2 \circ \tau = H_0^2(\mathbb{T}, \tau^{-1}\mathcal{B})$  where  $\tau = \tau(\phi)$ . Each  $H \in H_0^2(A, \tau^{-1} \mathcal{B})$  is of form  $H = h \circ \tau$  with  $h \in H_0^2$ . By  $\mathfrak{S}$ ,

$$
\overline{\phi}g \perp \sum_{k\geq 0} \hat{h}(k)\phi^k = h \circ \tau = H
$$

and  $\overline{\phi}g \in M$ .  $\Box$  **i** 

To see that  $M = \{0\}$  suppose otherwise that  $g \in M$ ,  $g \neq 0$ , then by  $\triangle$ (repeatedly)  $\overline{\phi}^j g \in M \ \forall \ j \geq 1$  which is impossible unless  $g \equiv 0$ .  $\Box \ \P6$  $\P7$  A  $\in \tau^{-1}$ B(T), Proof By  $\P6$   $H_0^2(A, \mathcal{C}) = H_0^2 \circ \tau$  and  $Pf = \widehat{\tau}(f) \circ \tau$  and

\widehat{\tau}(1_A) \circ \tau = 1_A + J
$$

where  $J := \widehat{\tau}(1_A) \circ \tau \cdot 1_{A^c} \geq 0$ . Now,

$$
m(A) = \mathbb{E}_m(\widehat{\tau}(1_A) \circ \tau) = m(A) + \mathbb{E}_m(J)
$$

whence  $\mathbb{E}_m(J) = 0$ ,  $J = 0$  a.s.,  $\widehat{\tau}(1_A) \circ \tau = 1_A$  and  $A \in \tau^{-1} \mathcal{B}(\mathbb{T})$ .  $\Box$  ¶7

§6 Questions arising

 $\P$ 1 In Proposition 2.7 (p[.9\)](#page-7-0) with some  $m(E) > 0$ , can the inner function  $\phi : \mathfrak{D} \leftarrow$  be chosen so that  $\phi' \in N(\mathfrak{D})$ ?

If not, then the restriction of an inner function  $\phi : \mathfrak{D} \leftrightarrow$  with  $\phi' \in$  $N(\mathfrak{D})$  (the Nevanlinna class) is an interval map  $(m(\chi^{-1}\mathfrak{s}_{\phi})=0)$ .

Let  $\phi : \mathfrak{D} \leftrightarrow$  be inner, non-Möbius with  $\phi(0) = 0$  and let  $\psi \in k_B$  (some  $B > 1$ ) be non constant.

**[2** Is the measure preserving transformation  $(\mathbb{T} \times \mathbb{R}, m \times m_{\mathbb{R}}, \tau_{\psi})$  (with  $\tau_{\psi}(x, y) = (\tau(x), y + \psi(x)))$  ergodic?

 $\Box$  Is there  $b \in (1, B)$  so that the characteristic function operators  $P_{t,\psi}$  are DF operators on  $(L^1(m), k_b)$  for every  $t \in \mathbb{R}$ ?

If so, then the conditional local limit theorem ([con-LLT](#page-23-1) on p. [23\)](#page-23-1) would hold and strong ergodic properties of  $(\mathbb{T} \times \mathbb{R}, m \times m_{\mathbb{R}}, \tau_{\psi})$  would follow as in [\[AD01,](#page-27-8) §7].
