Probabilistic Operational Correspondence (Technical Report)

Abstract. Encodings are the main way to compare process calculi. By applying quality criteria to encodings we analyse their quality and rule out trivial or meaningless encodings. Thereby, operational correspondence is one of the most common and most important quality criteria. It ensures that processes and their translations have the same abstract behaviour. We analyse probabilistic versions of operational correspondence to enable such a verification for probabilistic systems.

Concretely, we present three versions of probabilistic operational correspondence: weak, middle, and strong. We show the relevance of the weaker version using an encoding from a sublanguage of probabilistic CCS into the probabilistic π -calculus. Moreover, we map this version of probabilistic operational correspondence onto a probabilistic behavioural relation that directly relates source and target terms. Then we can analyse the quality of the criterion by analysing the relation it induces between a source term and its translation. For the second version of probabilistic operational correspondence we proceed in the opposite direction. We start with a standard simulation relation for probabilistic systems and map it onto a probabilistic operational correspondence criterion.

This technical report contains the proofs to the lemmata and theorems of [\[8\]](#page-23-0) as well as some additional material.

1 Process Calculi and Encodings

Definition 1 (Reductions of Distributions). Let $\Delta \longmapsto \Theta$ whenever

(a) $\Delta = \sum_{i \in I} p_i P_i$, where *I* is a finite index set and $\sum_{i \in I} p_i = 1$, (b) for each $i \in I$ there is a distribution Θ_i such that $P_i \mapsto \Theta_i$ or $\Theta_i = P_i$, (c) for some $i \in I$ we have $P_i \mapsto \Theta_i$, and (d) $\Theta = \sum_{i \in I} p_i \cdot \Theta_i$.

Definition 2 (Relations on Distributions, [\[1\]](#page-22-0)).

Let $\mathcal{R} \subseteq \mathcal{P}^2$ and let $\Delta, \Theta \in \mathcal{D}(\mathcal{P})$. Then $(\Delta, \Theta) \in \overline{\mathcal{R}}$ if (a) $\Delta = \sum_{i \in I} p_i P_i$, where *I* is a finite index set and $\sum_{i \in I} p_i = 1$, (b) for each $i \in I$ there is a process Q_i such that $(P_i, Q_i) \in \mathcal{R}$, and (c) $\Theta = \sum_{i \in I} p_i Q_i$.

For our proofs it is important that Definition [2](#page-0-0) translates preorders into preorders. Accordingly, we prove that it preserves reflexivity.

Lemma 1 (Preservation of Reflexivity). If R is reflexive, then so is $\overline{\mathcal{R}}$.

Proof. Assume a reflexive relation $\mathcal R$ and consider a probability distribution Δ with $\Delta = \sum_{i \in I} p_i P_i$ for some finite index set I with $\sum_{i\in I} p_i = 1$. We have to prove that $(\Delta, \Delta) \in \mathcal{R}$, i.e., that for each $i \in I$ there is some Q_i such that $(P_i, Q_i) \in \mathcal{R}$ and $\Delta = \sum_{i \in I} p_i Q_i$. Since \mathcal{R} is reflexive, we have $(P_i, P_i) \in \mathcal{R}$, i.e., it suffices to choose $Q_i = P_i$ to conclude the proof.

The preservation of transitivity was already given in [\[1\]](#page-22-0).

Lemma 2 (Preservation of Transitivity, [\[1\]](#page-22-0)).

If $\mathcal R$ is transitive, then so is $\overline{\mathcal R}$.

We inherit the criteria (expect operational correspondence) from [\[3\]](#page-22-1):

Compositionality: For every operator **op** with arity n of \mathcal{L}_S and for every subset of names N, there exists a context $\mathcal{C}_{\mathbf{op}}^N([\cdot]_1,\ldots,[\cdot]_n)$ such that, for all S_1,\ldots,S_n with $\mathsf{fn}(S_1)\cup\ldots\cup\mathsf{fn}(S_n)=N$, it holds that $\llbracket \mathbf{op}(S_1, \ldots, S_n) \rrbracket = \mathcal{C}^N_{\mathbf{op}}(\llbracket S_1 \rrbracket, \ldots, \llbracket S_n \rrbracket).$

Name Invariance w.r.t. a Relation $\mathcal{R}_{\tau} \subseteq \mathcal{P}_{\tau}^2$: For every $S \in \mathcal{P}_{\tau}$ and every substitution σ , it holds that $\llbracket S\sigma \rrbracket \equiv_{\alpha} \llbracket S \rrbracket \sigma'$ if σ is injective and $(\llbracket S\sigma \rrbracket, \llbracket S \rrbracket \sigma') \in \mathcal{R}_{\tau}$ otherwise, where σ' is such that $\varphi_{\llbracket \cdot \rrbracket}(\sigma(a)) =$ $\sigma'(\varphi_{\llbracket \cdot \rrbracket}(a))$ for all $a \in \mathcal{N}$.

Divergence Reflection: For every S , $\llbracket S \rrbracket \mapsto^{\omega}$ implies $S \mapsto^{\omega}$.

Success Sensitiveness: For every S, $S\Downarrow\downarrow$ iff $\llbracket S\rrbracket\Downarrow\downarrow$.

The formulation of compositionality is rather strict, i.e., it rules out practically relevant translations. Note that the best known encoding from the asynchronous π -calculus into the Join Calculus in [\[2\]](#page-22-2) is not compositional, but consists of an inner, compositional encoding surrounded by a fixed context—the implementation of so-called firewalls—that is parameterised on the free names of the source term. In order to capture this and similar encodings we relax the definition of compositionality.

Weak Compositionality: The encoding is either compositional or consists of an inner, compositional encoding surrounded by a fixed context that can be parameterised on the free names of the source term or information that are not part of the source term.

Definition 3 (Operational Correspondence, Non-Probabilistic).

1.1 Probabilistic CCS

Probabilistic CCS is introduced in [\[1\]](#page-22-0) as a probabilistic extension of CCS [\[4\]](#page-22-3) to study probabilistic barbed congruence. We omit the operator for non-deterministic choice from [\[1\]](#page-22-0); not because it is non-deterministic but because the summands of this choice are not necessarily guarded, whereas our target language has only guarded choice. We will also adapt the semantics of recursion, to ensure the unfolding of recursion requires a step as it is the case in our target language. We denote the resulting calculus as CCSp. Its syntax is given in the following Definition:

Definition 4 (Syntax of CCS_p). The terms \mathcal{P}_C of CCS_p are given by:

where $A \subseteq \mathcal{N}$ and $f : \mathcal{N} \to \mathcal{N}$ is a renaming function.

All names in A are bound in P by $P \setminus A$ and all names in \tilde{x} are bound in P by $C \stackrel{\text{def}}{=} (\tilde{x})P$. Names that are not bound are free. A renaming function can only affect the free names of a term. Let $fn(P)$ be the set of free names in P such that $fn(Q[f]) = \{f(n) | n \in fn(Q)\}\$ for all $Q \in \mathcal{P}_C$.

Following [\[1\]](#page-22-0) we extend some operations on processes to distributions, because these notions help us to define the semantics of the respective languages. Let Δ_1, Δ_2 be distributions on processes. We define the distributions $\Delta_1 \mid \Delta_2$ (for parallel composition), $\Delta_1 \setminus A$ and $(\nu x) \Delta_1$ (for restriction), and $\Delta_1[f]$ (for a renaming function) f) as:

The semantics of CCS_p is given by the rules in Figure [1,](#page-2-0) where we start with the labelled semantics of [\[1\]](#page-22-0), change the Rule $\text{Rec}_{\text{CCS}_p}$ for recursion, and add the Rule $\text{RED}_{\text{CCS}_p}$ to obtain a reduction semantics.

Rule PROBCHOICE_{CCS_p} reduces a probabilistic choice to a probability distribution over its branches after performing action u. Rule $\text{Rec}_{\text{CCS}_p}$ instead to [\[1\]](#page-22-0) makes the unfolding of recursion a separate τ -step. The remaining rules are standard CCS rules adapted to probability distributions, where the symmetric versions of the Rules $\text{PARL}_{\text{CCS}_p}$ and $\text{COML}_{\text{CCS}_p}$ are omitted.

1.2 Probabilistic Pi-Calculus

The probabilistic π -calculus (π_p) is introduced in [\[9\]](#page-23-1), as a probabilistic version of the π I-calculus [\[7\]](#page-23-2), where output is endowed with probabilities.

We assume that names in a vector \tilde{y} are pairwise distinct. The names \tilde{y}_i are bound in P_i by $x\Phi_{i\in I}$ **in**_i $(\tilde{y}_i)P_i$ and $\overline{x} \oplus_{i \in I} p_i$ **in**_i (\tilde{y}_i) , P_i ; x is bound in P by $(\nu x)P$; and the names \tilde{y} are bound in P by $\overline{x}(\tilde{y})$, P. Names that are not bound are free. Let $fn(P)$ denote the set of free names in P.

Structural congruence \equiv is defined, similarly to [\[5\]](#page-23-3), as the smallest congruence containing α -equivalence \equiv_{α} that is closed under the following rules:

We lift structural congruence to distributions, i.e., $\Delta_1 \equiv \Delta_2$ if there is a finite index set I such that $\Delta_1 =$ $\sum_{i\in I} p_i P_i$, $\Delta_2 = \sum_{i\in I} p_i Q_i$, and $P_i \equiv Q_i$ for all $i \in I$. We obtain the same by applying Definition [2](#page-0-0) on \equiv but do not want to use the symbol ≡.

The semantics of π_p is given by the rules in Figure [2,](#page-3-0) where we start with the labelled semantics of [\[9\]](#page-23-1) and add the Rule $\text{RED}_{\pi_{p}}$ to obtain a reduction semantics.

For the labelled part of the semantics we use Labels of the following form: $xin_i\langle\tilde{y}_i\rangle$, $\overline{xin}_i\langle\tilde{y}_i\rangle$, $x\langle\tilde{y}\rangle$, and $\overline{x}\langle\tilde{y}\rangle$. Rule SELECT_{π_{p}} implements the behaviour of a probabilistic selected output, which behaves like one of the processes P_i , after sending the corresponding output with probability p_i . On the contrary, each input within the branching input is performed with probability 1, and the process behaves like P_j after receiving \tilde{y}_j for some $j \in I$ as defined in Rule BRANCH_{π_p}. Rule COM_{π_p} describes the interaction of input and output, where the passed names are bound. Here the partial operation • on labels is formally defined by: $xin_i\langle\tilde{y}_i\rangle \bullet \overline{x}in_i\langle\tilde{y}_i\rangle =$ $x\langle \tilde{y} \rangle \bullet \overline{x}\langle \tilde{y} \rangle = \tau$ and undefined in all other cases. The remaining rules are standard π -calculus rules extended with probabilities, where the symmetric version of $\text{PARL}_{\pi_{p}}$ is omitted.

In [\[9\]](#page-23-1) a type system is introduced to ensure some interesting properties of well-typed terms such as linearity. Here we are only interested in the untyped version of π_{p} and, thus, omit the type system.

In Definition [5](#page-4-1) the encoding $\left(\cdot\right)_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $\tau_{\text{CCS}_{p}}^{\pi_{p}}$ from CCS_p into π_{p} is presented. In the following we prove that this encoding satisfies the criteria given in Section [1](#page-0-1) (except for a classical version of operational correspondence) and the new criterion weak PrOC.

The encoding of a probabilistic choice is split into three cases: the first three cases of Definition [5.](#page-4-1) For input guards a single input on x is used, to enable the communication with a potential corresponding output. In the following such a communication step on a source term name is denoted as α -step. In the continuation of the input on x a probabilistic selecting output on the reserved name z_i composed in parallel with a matching input is used to encode the probabilities. This step on the reserved channel name z_i is denoted as ω -step. The sequence of these two communication steps on x and z_i emulates the behaviour of a single communication step in the source.

By restricting the scope of the reserved name z_i , interactions with other operators communicating on z_i between two translations of inputs are prevented. Further, as the renaming policy ensures that z_i does not appear in $(P_i)_{\text{CC}}^{\pi_p}$ $\mathcal{C}_{\mathsf{CCS}_{p}}^{n_{p}}$, conflicts between the reserved name z_i and source term names are avoided.

Definition 6 (α -step). An α -step is a communication step on a translated source term name.

Definition 7 (ω -step). An ω -step is a communication step on an instance of the reserved name z_i .

The encoding of an output-guarded probabilistic choice is straight forward, as it is translated using the probabilistic selecting output.

For the guard τ , an output-guarded probabilistic choice in parallel to a single input on the reserved name z_{τ} is used. Because of the restriction, interactions with other translations of τ -guarded operators are prevented.

A communication step of this kind is denoted as ζ-step. This step does not only introduce the probabilities of a τ-guarded source term choice in the translation but also allows the translated term to do a step whenever the source term does one and compensates the missing τ in the syntax of the target language.

Definition 8 (ζ -step). An ζ -step is a communication step on an instance of the reserved name z_{τ} .

The application of a renaming function is encoded by a substitution. A call $C\langle \tilde{y} \rangle$ is encoded by an output, where the corresponding process definitions are translated into replicated inputs and placed in parallel by the outer encoding. The remaining translations are homomorphic.

Definition 9 (η -step). An η -step is a communication step that reduces a replicated input.

Example 1 (ζ -Steps). Consider the source term $S = \tau \cdot (\frac{1}{8}P \oplus \frac{7}{8}Q) \mid \tau \cdot (\frac{3}{5}R \oplus \frac{2}{5}S)$ of CCS_p without process definitions. S can do the following sequence of steps:

By Definition [5](#page-4-1) and since S has no process definitions, $\langle S \rangle_{\text{CC}}^{\pi_p}$ $_{\text{CCS}_{\text{p}}}^{\pi_{\text{p}}} = \llbracket S \rrbracket_{\text{CC}}^{\pi_{\text{p}}}$ $_{\text{CCS}_{\text{p}}}^{\pi_{\text{p}}}$ and:

Thereby, the restriction of the reserved name z_{τ} prevents a communication between the left and right subterm of the outermost parallel operator. By Figure [2,](#page-3-0) $(S)_{CC}^{\pi_p}$ ${}^{\pi_{\mathsf{p}}}_{{\mathsf{CCS}}_{\mathsf{p}}}$ can emulate the steps of S by $(S)_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $\begin{aligned} \mathcal{L}_{\mathsf{CCS_p}} \longmapsto \mathcal{\Delta}_{T,1} \longmapsto \mathcal{\Delta}_{T,2}, \end{aligned}$ where:

The distributions $\Delta_{T,1}$ and $\Delta_{T,2}$ are both structural congruent to the encoding of the corresponding source distributions, i.e., $\left(\Delta_{S,1}\right)_{\text{CC}}^{\pi_p}$ $\overline{\mathcal{L}}_{\mathsf{CCS}_{\mathsf{p}}}^{\pi_{\mathsf{p}}} \equiv \Delta_{T,1}$ and $(\Delta_{S,2})_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $\sum_{\substack{CCS_p \text{is a}}}^{\pi_p} \equiv \Delta_{T,2}$. As both steps in $(S)_{CC}^{\pi_p}$ $\begin{array}{c}\n\Gamma_{\mathsf{P}}\n\subset\end{array}\n\quad \longrightarrow \Delta_{T,1} \longmapsto \Delta_{T,2}$ reduce an instance of z_7 —though of course different instances of z_7 are reduced—they are both ζ -steps. \Box

An example of a α -step followed by a ω -step is presented in [\[8\]](#page-23-0). To obtain the probability distribution that results from this sequence of two steps on the target, the probabilities of the ω -step are multiplied with the probabilities of the corresponding α -step. The resulting probabilities match to the probabilities of the emulated source term step. This multiplication stems from the rules of probability theory, where the probability of an event consisting of a sequence of several events has to be calculated by multiplying the probabilities of all the single events contained in that sequence. Accordingly, if a single source term step is emulated by a sequence

of target term steps, we compare the probabilities that result from multiplying the probabilities of the target term steps in the sequence with the probabilities of the source. Fortunately, the multiplication of probabilities is already covered by Definition [1](#page-0-2) in order to define sequences of steps. It remains to ensure that our version of operational correspondence compares the probabilities of the distribution that results from a single source term step with the final distribution in the emulating target term sequence (and not with the probabilities of a distribution in the middle of this sequence).

We already ruled out strong operational correspondence as defined in Definition [3.](#page-1-0) The other two versions differ in whether they allow for intermediate states. Another look at the example in [\[8\]](#page-23-0) tells us, that intermediate states make sense. Δ_T is a finite probability distribution with the probabilities $\frac{3}{4}$ and $\frac{1}{4}$, but neither S nor S ′ have cases with these probabilities. However, since there is exactly one source term step and exactly one sequence of target term steps, Δ_T does not mark a partial commitment, because there was nothing to decide. Indeed the restriction on z_i ensures that each α -step enables exactly one ω -step and communication is the only case that requires two steps to emulate a single source term steps. Hence, also by interleaving with other emulations, we do not obtain partial commitments. Nonetheless Δ_T is an intermediate state; not intermediate in terms of decisions and commitments but intermediate in terms of probabilities. In the second variant of operational correspondence in Definition [3](#page-1-0) without intermediate states, we would need to find a relation \mathcal{R}_T that relates Δ_T either to $[S]_{CC}^{\pi_p}$ $\int_{\text{CCS}_{p}}^{\pi_{p}}$ or Δ'_{T} . Such a relation \mathcal{R}_{T} is difficult or at least not intuitive, since it has to relate states with different probabilities. It is easier to allow for intermediate states. So, we want to build a weak version of operational correspondence (third case of Definition [3\)](#page-1-0) with probabilities. This leads to the version of probabilistic operational correspondence below denoted as weak probabilistic operational correspondence.

Definition 10 (Weak Probabilistic Operational Correspondence). An encoding $\llbracket \cdot \rrbracket$: $\mathcal{P}_S \rightarrow \mathcal{P}_T$ is weakly probabilistic operationally corresponding (weak PrOC) w.r.t. $\mathcal{R}_{\mathsf{T}} \subseteq \mathcal{P}_{\mathsf{T}}^2$ if it is:

Before we analyse the quality of our new version of PrOC in Section [3,](#page-14-0) we want to check whether it indeed exactly captures the way our encoding $\left(\cdot\right)_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $\sum_{\text{CCS}_{p}}^{\pi_{p}}$ treads source term steps into probability distributions, i.e., we prove that our encoding satisfies weak PrOC. The Example [1](#page-5-0) and the example given in [\[8\]](#page-23-0) illustrate that steps on τ -guarded choices and communication steps satisfy weak PrOC w.r.t. \equiv . They cover ζ -steps, α -steps, and ω -steps. The only missing kind of steps, are steps to unfold a recursion in the source and their emulation by η -steps in the target.

Example 2 (η-Step). Consider $S = C(\tilde{y})$ with $C \stackrel{\text{def}}{=} ($. \checkmark in CCS_p . By Figure [1,](#page-2-0) S can perform only one step: $S \longmapsto \Delta_S = \sqrt{1 - 1}$. By Definition [5,](#page-4-1) then:

By Figure [2,](#page-3-0) $(S)_{CC}^{\pi_p}$ $\sum_{\text{CCS}_{p}}^{\pi_{p}}$ can perform exactly one maximal sequence of steps, namely the η -step $(S)_{CC}^{\pi_{p}}$ $\stackrel{\pi_{\mathsf{p}}}{\mathsf{CCS}_{\mathsf{p}}}\longmapsto \varDelta_{T}=$ $\{1(\nu C) (\checkmark | C(\cdot \checkmark))\}$. By Definition [5,](#page-4-1) $\langle \Delta_S \rangle_{CC}^{\pi_p}$ $\mathcal{L}_{\text{CCS}_{p}}^{\text{A}_{p}} = \Delta_{T}$, because even though Δ_{S} does no longer contain any process constants its process definition is not consumed in the step $S \longmapsto \Delta_S$. □

We prove that the encoding in Definition [5](#page-4-1) satisfies the quality criteria of Section [1](#page-0-1) and weak PrOC. We start with weak compositionality.

Lemma 3 (Weak Compositionality, $\left(\cdot\right)_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $\frac{\pi_{\mathsf{p}}}{\mathsf{CCS}_{\mathsf{p}}}/\llbracket \cdot \rrbracket_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $_{\textrm{CCS}_{\textrm{p}}}^{\pi_{\textrm{p}}}$). The encoding $\left(\cdot\right)_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ ${}_{\text{CCS}_{\text{p}}}^{n_{\text{p}}}$ is weakly compositional.

Proof. Our encoding consists of the outer encoding $\left(\cdot\right)_{\text{CC}}^{\pi_p}$ $\sum_{\text{CCS}_{\text{p}}}^{\pi_{\text{p}}}$ and the inner encoding $[\![\cdot]\!]_{\text{CC}}^{\pi_{\text{p}}}$ ${}^{\pi_{\mathsf{P}}}_{\mathsf{CCS}_{\mathsf{P}}}$. The outer encoding $\left\{\cdot\right\}_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ ${}^{\pi_{\mathsf{P}}}_{\mathsf{CCS}_{\mathsf{P}}}$ is a fixed context that is parametrised on the process definitions of the source term, that are not part of the source term itself. The inner encoding $\left[\!\!\left[\cdot \right]\!\!\right]_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ ${}^{\pi_{\rm p}}_{\rm CCS_p}$ is compositional, because the encoding function in Definition [5](#page-4-1) defines a context for each operator of the source language in that the translations of the subterms of the respective source term are used. Hence, $\left(\cdot\right)_{\mathsf{CC}}^{\pi_\mathsf{p}}$ ${}_{\text{CCS}_{p}}^{^{\pi_{p}}}$ is weakly compositional.

Name invariance and the different versions of operational correspondence are defined modulo a relation \mathcal{R}_T on target terms that is success sensitive. For our encoding $\left(\cdot\right)_{\text{C}^{\pi_{\text{p}}}}^{\pi_{\text{p}}}$ $\mathcal{C}_{\mathsf{CCS}_p}^{\pi_p}$ we can choose \mathcal{R}_{T} as the structural congruence \equiv on the target language π_{p} . Structural congruence satisfies a stronger version of success sensitiveness with $\cdot \downarrow \checkmark$ instead of $\cdot \downarrow \checkmark$.

Lemma 4 (\equiv is Success Sensitive). If $T_1 \equiv T_2$ then $T_1 \downarrow \sim \rightarrow T_2 \downarrow \sim$. Moreover, if $\Delta_1 \equiv \Delta_2$ then $\Delta_1 \downarrow \sim \Delta_2 \downarrow \sim$.

Proof. The proof is by induction on the definition of \equiv . All cases are immediate.

 α -**Equivalence** \equiv_{α} : In this case $T_1 \equiv_{\alpha} T_2$. Since \checkmark does not contain any names, we have $T_1 \downarrow_{\checkmark}$ iff $T_2 \downarrow_{\checkmark}$.

- $P | \mathbf{0} \equiv P$: In this case $T_1 = T_2 | \mathbf{0}$. Since **0** does not contain \checkmark , then $T_1 \checkmark \checkmark$ iff $T_2 \checkmark \checkmark$.
- $P \mid Q \equiv Q \mid P$: In this case $T_1 = P \mid Q$ and $T_2 = Q \mid P$. Since T_1 contains \checkmark iff T_2 contains \checkmark , then $T_1 \checkmark \checkmark$ iff $T_2\downarrow\checkmark$.
- $P | (Q | R) \equiv (P | Q) | R$: In this case $T_1 = P | (Q | R)$ and $T_2 = (P | Q) | R$. Since T_1 contains \checkmark iff T_2 contains \checkmark , then $T_1\checkmark$ iff $T_2\checkmark$.
- (νx) **0** \equiv **0:** In this case $T_1 = (\nu x)$ **0** and $T_2 =$ **0**. Since **0** does not contain \checkmark , then $T_1 \checkmark \checkmark$ and $T_2 \checkmark \checkmark$.
- $(\nu xy)P \equiv (\nu yx)P$: Then $T_1 = (\nu xy)P$ and $T_2 = (\nu yx)P$. Since T_1 as well as T_2 contain \checkmark iff P contains \checkmark , then $T_1\downarrow \checkmark$ iff $T_2\downarrow \checkmark$.
- $(\nu x)(P \mid Q) \equiv P \mid (\nu x)Q$: In this case $T_1 = (\nu x)(P \mid Q)$ and $T_2 = P \mid (\nu x)Q$, where $x \notin \text{fn}(P)$. Since T_1 contains \checkmark iff T_2 contains \checkmark , then $T_1\dot{\downarrow}\checkmark$ iff $T_2\dot{\downarrow}\checkmark$.
- $\Delta_1 \equiv \Delta_2$: In this case there is a finite index set I such that $\Delta_1 = \sum_{i \in I} p_i P_i$, $\Delta_2 = \sum_{i \in I} p_i Q_i$, and $P_i \equiv Q_i$ for all $i \in I$. Because of $P_i \equiv Q_i$, we have $P_i \downarrow \checkmark$ iff $Q_i \downarrow \checkmark$ for all $i \in I$. Then $\Delta_1 \downarrow \checkmark$ iff $\Delta_2 \downarrow \checkmark$.

The renaming policy $\varphi_{\{\cdot\}_{\mathsf{CCS}_{\mathsf{p}}}^{\pi_{\mathsf{p}}} }$ of $\{\cdot\}_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $\overline{\text{CC}}_{\mathsf{SCS}_p}$ reserves the names z_i, z_τ and keeps process constants C distinct from source term names, i.e., $|\varphi_{\phi\phi_{\text{CCs}_{\text{p}}}^{\pi_{\text{p}}}(n)| = 1$ and $\varphi_{\phi\phi_{\text{CCs}_{\text{p}}}^{\pi_{\text{p}}}(n) \cap \{(z_i), (z_\tau), (C) \mid C \text{ is a process constant}\} = \emptyset$ for all $n \in \mathcal{N}$.

Name invariance ensures that the encoding function treads all source term names in the same way. Since the encoding function $\left(\cdot\right)_{CC}^{\pi_p}$ $\frac{C_{CS_p}}{C_{CS_p}}$ does not introduce any free names and because of the rigorous use of the renaming policy $\varphi_{\phi\phi_{\text{ccs}_p}}$ (although we omit it for readability in Definition [5\)](#page-4-1), our encoding satisfies a stronger version of name invariance, where α -equivalence can be used regardless of whether σ is injective.

Lemma 5 (Name Invariance, $\left\|\cdot\right\|^{\pi_{\text{p}}}_{\text{CC}}$ $\frac{\pi_{\mathsf{p}}}{\mathsf{CCS}_{\mathsf{p}}}/\llbracket \cdot \rrbracket_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $(\sum_{\mathsf{CCS_p}}^{\pi_{\mathsf{P}}})$. Proof. Without loss of generality we assume that σ' behaves as identity for all names that are not in the range of $\varphi_{\phi,\xi_{\text{ccs}_p}}$. The assumption can be replaced by applying alpha conversion such that the names introduced by the encoding function, i.e., the restricted names that are denoted by z_i , z_{τ} , or C_i in Definition [5,](#page-4-1) are not affected by applying σ' . The proof is by induction on the encoding function.

For soundness, we have to prove that the encoding does not introduce any new behaviour. Therefore, we show that every sequence of steps on the target belongs to a matching sequence of steps on the source.

We have to proof that there are some Δ'_{S} and Δ'_{T} such that $S \implies \Delta'_{S}$, $\Delta_{T} \implies \Delta'_{T}$, and (Δ'_{S}) π_{p} $\mathcal{L}_{\textsf{CCS}_{\textsf{p}}}^{\pi_{\textsf{p}}} \equiv \Delta'_T$, where the sequence $\Delta_T \implies \Delta'_T$ contains only ω -steps. Therefore, we construct $\Delta_S^{**} \implies \Delta'_S$ and the sequence $\Delta_T^{***} \implies \Delta'_T$
containing only ω -steps such that $S \implies \Delta_S^{**} \implies \Delta'_S$, $\Delta_T^* \implies \Delta_T \implies \Delta_T^* \implies \Delta'_T$, and $(\Delta'_S)_{CCS_p}^{T_p} \equiv$ π_{p} $\frac{\pi_{\mathsf{p}}}{\mathsf{CCS}_{\mathsf{p}}} \equiv \Delta'_T.$

We perform a case split on the nature of $T_i^* \mapsto \Delta_{T,i}$ for all $i \in I$ with $\Delta_{T,i} \neq \overline{T_i^*}$ to generate the initially empty sets S and T of source and target term steps. We use S and T to collect the steps that we need for the sequences $\Delta_S^{**} \Longrightarrow \Delta_S'$ and $\Delta_T^{***} \Longrightarrow \Delta_T'$.

- $\Delta_T^* \mapsto \Delta_T$ is an α -step: By Definition [6,](#page-4-2) then $\Delta_T^* \mapsto \Delta_T$ is a communication step on a translated source term name x . To complete the emulation of the corresponding source term communication on x , we need to perform the ω -step that was enabled by this α -step. Accordingly, we add the respective source term step on x to S and the ω -step that was enabled by $\Delta_T^* \longmapsto \Delta_T$ to T.
- $\Delta_T^* \mapsto \Delta_T$ is an ω -step: By Definition [7,](#page-4-3) then $T_i^* \mapsto \Delta_{T,i}$ is a communication step on an instance of the reserved name z_i . By Definition [5](#page-4-1) and Definition [6,](#page-4-2) all in- and outputs on z_i are initially guarded in the encoding and can only be unguarded by an α -step. Accordingly, $\left(\frac{S}{C}\right)_{C}^{\pi_p}$ ${}^{\pi_{\mathsf{p}}}_{\mathsf{CCS}_{\mathsf{p}}} \Longleftrightarrow \Delta_{\mathcal{T}}^*$ contains the corresponding α -step that unguarded the input on z_i reduced in $T_i^* \mapsto \Delta_{T,i}$. Since (Δ_S^{**}) π_{p} α -step that unguarded the input on z_i reduced in $T_i^* \mapsto \Delta_{T,i}$. Since $(\Delta_S^{**})^{\pi_{\mathsf{P}}}_{\mathsf{CCS_p}} \equiv \Delta_T^{**}$, then $S \mapsto \Delta_S^{**}$
already contains the corresponding communication step in the source, i.e., in this case w add any steps to $\mathcal S$ or $\mathcal T$.
- $\Delta_T^* \mapsto \Delta_T$ is a ζ -step: By Definition [8,](#page-5-1) then $T_i^* \mapsto \Delta_{T,i}$ is a communication step on an instance of the reserved name z_{τ} . In this case we add the source term τ -step that is emulated by $T_i^* \mapsto \Delta_{T,i}$ to S and leave $\mathcal T$ unchanged.
- $\Delta_T^* \mapsto \Delta_T$ is a η -step: By Definition [9,](#page-5-2) then $\Delta_T^* \mapsto \Delta_T$ reduce a replicated input to emulate the unfolding of recursion. Again we add the source term step to unfold a recursion that is emulated by $T_i^* \mapsto \Delta_{T,i}$ to S and leave $\mathcal T$ unchanged.
- **Otherwise:** By Definition [5,](#page-4-1) all steps of an encoded source term are α -steps, ω -steps, ζ -steps, or η -steps.

We observe that in all cases, we need at most one step in the source and target. Since $\Delta_T^* \implies \Delta_T^{**}$ contains only ω -steps, it can only complete the emulation of source terms steps and not start new such emulations. Because of $\langle \Delta_S^{**} |$ π_{p} $\mathcal{L}_{\text{CCS}_{p}}^{\pi_{p}} \equiv \Delta_{T}^{**}$ and because the emulations of the source terms steps in S were enabled in Δ_{T}^{*} , the source term steps in S are enabled in Δ_S^{**} . Divergence reflection ensures that the encoding cannot introduce new sources of divergence.

Success sensitiveness ensures that the translation passes a test if and only if the source term passes this test.

3 Weak Probabilistic Operational Correspondence

Definition 11 (Correspondence Simulation, [\[6\]](#page-23-4)). A relation \mathcal{R} is a (weak reduction) correspondence simulation if for each $(P,Q) \in \mathcal{R}$:

Two terms are probabilistic correspondence similar if a probabilistic correspondence simulation relates them.

If R is a preorder and a probabilistic correspondence simulation then so is $\overline{\mathcal{R}}$.

Else, by Definition [1,](#page-0-2) then $\Delta' = \sum_{i \in I} p_i \Delta'_i$ and for some (at least one) $i \in I$ a processes P_i in Δ performed a sequence of at least one step $P_i \mapsto \Delta'_i$. For all other i we have $\Delta'_i = \overline{P_i}$. Since $\mathcal R$ is a probabilistic correspondence simulation, $(P_i, Q_i) \in \mathcal{R}$ and $P_i \mapsto \Delta'_i$ imply $Q_i \mapsto \Theta'_i$ and $(\Delta'_i, \Theta'_i) \in \overline{\mathcal{R}}$. For the $i \in I$ without a step, we choose $\Theta'_i = \overline{Q_i}$ such that $Q_i \implies \Theta'_i$ and $(\Delta'_i, \Theta'_i) \in \overline{\mathcal{R}}$. Then $\Theta \implies \Theta' = \sum_{i \in I} p_i \Theta'_i$ and $(\Delta'_i, \Theta'_i) \in \overline{\mathcal{R}}$.
- Assume $Θ \implies Θ'$. If $Θ' = Θ$ then we can choose $Δ'' = Δ$ and $Θ'' = Θ$ such that $Δ \implies Δ''$, $Θ' \implies Θ''$, and $(\Delta'', \Theta'') \in \overline{\mathcal{R}}$. Else, by Definition [1,](#page-0-2) then $\Theta' = \sum_{i \in I} p_i \Theta'_i$ and for some (at least one) $i \in I$ a processes Q_i in Θ performed a sequence of at least one step $Q_i \mapsto \Theta'_i$. For all other i we have $\Theta'_i = \overline{Q_i}$. Since \mathcal{R} Q_i in \bigcirc performed a sequence of at least one step $Q_i \mapsto Q_i$. For an other i we have $O_i = Q_i$. Since \mathcal{N} is a probabilistic correspondence simulation, $(P_i, Q_i) \in \mathcal{R}$ and $Q_i \mapsto \Theta_i'$ imply $P_i \mapsto \Delta_i''$, $\Theta_i' \map$ and $(\Delta''_i, \Theta''_i) \in \overline{\mathcal{R}}$. For the $i \in I$ without a step, we choose $\Delta''_i = \overline{P_i}$ and $\Theta''_i = \Theta_i$ such that $P_i \Longrightarrow \Delta''_i$,
 $\Theta'_{i,j} \circ \Theta''_{i,j} = \overline{\mathcal{R}}_i$. Then $\Delta_{i,j}$ and $\Delta''_{i,j} = \overline{\mathcal{R}}_i$ and $\Theta''_{i,j} = \overline{\mathcal{R}}$ $\Theta'_{i} \Longrightarrow \Theta''_{i}$ and $(\Delta''_{i}, \Theta''_{i}) \in \overline{\mathcal{R}}$. Then $\Delta \Longrightarrow \Delta'' = \sum_{i \in I} p_{i} \Delta''_{i}, \Theta' \Longrightarrow \Theta'' = \sum_{i \in I} p_{i} \Theta''_{i}$ and $(\Delta''_{i}, \Theta''_{i}) \in \overline{\mathcal{R}}$. We conclude that $\overline{\mathcal{R}}$ is a probabilistic correspondence simulation.

Theorem 2 (Weak PrOC). $\llbracket \cdot \rrbracket$ is weakly probabilistically operationally corresponding w.r.t. a preorder $\mathcal{R}_T \subseteq$ \mathcal{P}^2 that is a probabilistic correspondence simulation iff $\exists \mathcal{R}_{\llbracket \cdot \rrbracket} \cdot (\forall S. (S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}) \wedge \mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\top}} \wedge (\forall S, T. (S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\top}) \wedge \mathcal{R}_{\llbracket \cdot \rrbracket} \text{ is a preorder }$ and a probabilistic correspondence simulation.

One of the condition in Theorem [2](#page-15-1) is that the relation \mathcal{R}_{T} on the target is obtained from the induced relation $\mathcal{R}_{\llbracket \cdot \rrbracket}$ between source and target by reduction on target terms, i.e., $\mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\llbracket \cdot \rrbracket}}$ We prove that this property is preserved by the lift operation in Definition [2.](#page-0-0)

Lemma 11. If $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$ then $\overline{\mathcal{R}_{\mathsf{T}}} = \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}} \restriction_{\mathcal{P}_{\mathsf{T}}}.$

Proof. Assume $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$. By Definition [2,](#page-0-0) $(\Delta, \Theta) \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$ if

- (i) $\Delta = \sum_{i \in I} p_i P_i$, where *I* is a finite index set and $\sum_{i \in I} p_i = 1$,
- (ii) for each $i \in I$ there is a process Q_i such that $(P_i, Q_i) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$, and
- (iii) $\Theta = \sum_{i \in I} p_i Q_i$.

Then $(\Delta, \Theta) \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}} \restriction_{\mathcal{P}_{\top}}$ if

- (i) $\Delta = \sum_{i \in I} p_i P_i$ in the target, where I is a finite index set and $\sum_{i \in I} p_i = 1$,
- (ii) for each $i \in I$ there is a process Q_i such that $(P_i, Q_i) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_T}$, and
- (iii) $\Theta = \sum_{i \in I} p_i Q_i$ in the target.

Since $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$ and by Definition [2,](#page-0-0) then $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$.

The condition $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket}$ is a preorder. Theorem [2](#page-15-1) allows us to prove that \mathcal{R}_{T} is a preorder if $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a preorder.

Lemma 12. If $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a preorder and $\mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\top}}$ then \mathcal{R}_{\top} is a preorder.

Proof. Assume a preorder $\mathcal{R}_{\llbracket \cdot \rrbracket}$ and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$.

- **Reflexivity:** Since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is reflexive, $(T, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ for all target terms T. Because of $\mathcal{R}_{\llbracket \cdot \rrbracket} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\llbracket \cdot \rrbracket}}$ then $(T, T) \in \mathcal{R}_{\mathsf{T}}$.
- **Transitivity:** Assume $(T_1, T_2) \in \mathcal{R}_T$ and $(T_2, T_3) \in \mathcal{R}_T$ for some target terms T_1, T_2 , and T_3 . Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}, \text{ then } (T_1, T_2) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \text{ and } (T_2, T_3) \in \mathcal{R}_{\llbracket \cdot \rrbracket}. \text{ Since } \mathcal{R}_{\llbracket \cdot \rrbracket} \text{ is transitive, then } (T_1, T_3) \in \mathcal{R}_{\llbracket \cdot \rrbracket}.$ Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$, then $(T_1, T_3) \in \mathcal{R}_{\mathsf{T}}$.

We conclude that \mathcal{R}_{T} is a preorder.

The condition $\forall S, T \colon (S, T) \in \mathcal{R}_{\mathbb{F} \cdot \mathbb{I}} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$ is necessary to ensure (with the remaining properties) that the encoding satisfies weak PrOC in the 'only if'-case of Theorem [2.](#page-15-1) Therefore we lift this property to distributions.

Lemma 13. If $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ then for all distributions Δ_S on the source and all distributions Δ_T on the target $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket \Delta_S \rrbracket, \Delta_T) \in \mathcal{R}_T$.

Proof. Assume $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By Definition [2,](#page-0-0) then there is some index set I such that $\Delta_S = \sum_{i \in I} p_i S_i$, $\Delta_T = \sum_{i \in I} p_i T_i$, $\sum_{i \in I} p_i = 1$, and for each $i \in I$ we have $(S_i, T_i) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. With $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\top}$, then $(\llbracket S_i \rrbracket, T_i) \in \mathcal{R}_{\top}$ for each $i \in I$. By Definition [2,](#page-0-0) then $(\llbracket \Delta_S \rrbracket, \Delta_T) \in \overline{\mathcal{R}_T}$.

To prove Theorem [2,](#page-15-1) it is necessary to ensure that \mathcal{R}_{τ} is a probabilistic correspondence simulation if $\mathcal{R}_{\|\cdot\|}$ is.

Lemma 14. If $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic correspondence simulation and $\mathcal{R}_{\llbracket \cdot \rrbracket} \models_{\llbracket \cdot \rrbracket} \models_{\llbracket \cdot \rrbracket} \models_{\llbracket \cdot \rrbracket}$ then $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic correspondence simulation.

Proof. Assume that $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic correspondence simulation and $\mathcal{R}_{\llbracket \cdot \rrbracket}$ $\uparrow_{\mathcal{P}_{\llbracket \cdot \rrbracket}}$ Moreover, assume $(T_1, T_2) \in \mathcal{R}_{\mathsf{T}}$. Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$, then $(T_1, T_2) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$.

Case (i): Assume $T_1 \implies \Delta$. Since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic correspondence simulation, then $T_2 \implies \Theta$ and $(\Delta, \Theta) \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$. With $\mathcal{R}_{\sf T} = \mathcal{R}_{\llbracket \cdot \rrbracket} {\restriction} \mathcal{P}_{\sf T}$ and Lemma [11,](#page-15-2) then $(\Delta, \Theta) \in \overline{\mathcal{R}_{\sf T}}$.

Case (ii): Assume $T_2 \Longrightarrow \Theta$. Since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic correspondence simulation, then $T_1 \Longrightarrow \Delta'$, $\Theta \Longrightarrow$ Θ' , and $(\Delta', \Theta') \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$. With $\mathcal{R}_{\sf T} = \mathcal{R}_{\llbracket \cdot \rrbracket} {\restriction}_{\mathcal{P}_{\sf T}}$ and Lemma [11,](#page-15-2) then $(\Delta', \Theta') \in \overline{\mathcal{R}_{\sf T}}$.

We conclude that \mathcal{R}_{T} is a probabilistic correspondence simulation.

Next we show the main theorem of Section [3.](#page-14-0) Weak probabilistic operational correspondence induces a relation between source and target terms that is a probabilistic correspondence simulation. More precisely, Theorem [2](#page-15-1) states:

 $\llbracket \cdot \rrbracket$ is weakly probabilistically operationally corresponding w.r.t. a preorder $\mathcal{R}_T \subseteq \mathcal{P}_T^2$ that is a probabilistically operationally $\text{corresponding w.r.t. }$ a preorder $\mathcal{R}_T \subseteq \mathcal{P}_T^2$ that is a probabilistic bilistic correspondence simulation iff $\exists \mathcal{R}_{\llbracket \cdot \rrbracket}$. $(\forall S$. $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}) \wedge \mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\top}}$

 $\wedge \ (\forall S, T. (S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ is a preorder and a probabilistic correspondence simulation.

Proof (Proof of Theorem [2\)](#page-15-1). We prove the two directions of the result separately.

- **if** (\rightarrow) : Assume that $\llbracket \cdot \rrbracket$ is weakly probabilistically operationally corresponding w.r.t. a preorder $\mathcal{R}_T \subseteq \mathcal{P}_T^2$ that is a probabilistic correspondence simulation. We construct $\mathcal{R}_{\llbracket \cdot \rrbracket}$ from $\mathcal{R}_{\sf T}$ by adding $(S, \llbracket S \rrbracket)$ for all source terms S and then building the reflexive and transitive closure. Accordingly, $\forall S$. $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ holds by construction. Since we did not add any pairs of only source terms, i.e., no pairs of the form (S_1, S_2) where both S_1 and S_2 are source terms, and since the only such pairs added by the reflexive and transitive closure are of the form (S, S) , we have $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$. Next we prove that $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$.
Therefore for every S and T and connect $(S, T) \in \mathcal{R}$. Therefore, fix some S and T and assume $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and all pairs relating a source and a target term contain a source term and its literal translation or result from such a pair, \mathcal{R}_{T} , and the transitive closure in the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$. Hence, $T = \llbracket S \rrbracket$ or $(\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$. In the former case, $(\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$ follows from the reflexivity of \mathcal{R}_{T} . The latter case directly provides $([\mathcal{S}], T) \in \mathcal{R}_{\mathcal{T}}$. That $\mathcal{R}_{[\cdot]}$ is a preorder directly follows from the construction of $\mathcal{R}_{[\cdot]}$, because we used the reflexive and transitive closure. As last condition we have to show that $\mathcal{R}_{[\![\cdot]\!]}$ is a probabilistic correspondence simulation. By Definition [12,](#page-15-3) for all $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and all $P \implies \Delta$ we have to find $Q \implies \Theta$ such that $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and for all $Q \Longrightarrow \Theta$ we have to find $P \Longrightarrow \Delta'$ and $\Theta \Longrightarrow \Theta'$ such that $(\Delta', \Theta') \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$. By the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, P may be a source or target term, but Q is a target term.
	- Assume $P \implies \Delta$. If P is a source term, then we have $[[P]] \implies \Delta'$ with $(\Delta, \Delta') \in \overline{\mathcal{R}_T}$, because of completeness in weak PrOC in Definition [10.](#page-6-0) Since Q is a target term and by the construction of $\mathcal{R}_{\llbracket\cdot\rrbracket}$, $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. Because of $\mathcal{R}_{\sf T} = \mathcal{R}_{\llbracket \cdot \rrbracket} {\restriction_{\mathcal{P}_{\sf T}}}$, then $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\sf T}$. Then $Q \Longrightarrow \Theta$ and $(\Delta', \Theta) \in \overline{\mathcal{R}_T}$, because \mathcal{R}_T is a probabilistic correspondence simulation. With the transitivity of \mathcal{R}_{T} and thus $\overline{\mathcal{R}_{\mathsf{T}}}, (\Delta, \Delta') \in \overline{\mathcal{R}_{\mathsf{T}}}$ and $(\Delta', \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$ imply $(\Delta, \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$. Finally, $(\Delta, \Theta) \in \overline{\mathcal{R}_{\|\cdot\|}}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

Else, assume that P is a target term. Then $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(P,Q) \in \mathcal{R}_{\top}$, because Q is a target term and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$. Since \mathcal{R}_{T} is a probabilistic correspondence simulation (see Definition [12\)](#page-15-3), then $P \Longrightarrow \Delta$ implies $Q \Longrightarrow \Theta$ with $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\mathbb{F}}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

– Assume $Q \implies$ Θ. If P is a source term, then $([\![P]\!], Q) \in \mathcal{R}_{[[\cdot]]}$, by the construction of $\mathcal{R}_{[[\cdot]]}$. Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$, then $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\mathsf{T}}$. Since \mathcal{R}_{T} is a probabilistic correspondence simulation (see second case of Definition [12\)](#page-15-3), then $Q \mapsto \Theta$ implies $[[P]] \mapsto \Delta'_T$, $\Theta \mapsto \Theta'$, and $(\Delta'_T, \Theta') \in \overline{\mathcal{R}_T}$. From $\llbracket P \rrbracket \Longrightarrow \Delta'_T$ we obtain $P \Longrightarrow \Delta''$ and $\Delta'_T \Longrightarrow \Delta''_T$ with $(\Delta'', \Delta''_T) \in \overline{\mathcal{R}_T}$, because of soundness in weak PrOC in Definition [10.](#page-6-0) By Lemma [10,](#page-15-0) $\overline{\mathcal{R}_{T}}$ is a probabilistic correspondence simulation. By the first case of Definition [13,](#page-15-4) then $(\Delta'_T, \Theta') \in \overline{\mathcal{R}_T}$ and $\Delta'_T \implies \Delta''_T$ imply $\Theta' \implies \Theta''$ and $(\Delta''_T, \Theta'') \in \overline{\mathcal{R}_T}$. By transitivity, we obtain $(\Delta'', \Theta'') \in \overline{\mathcal{R}_{\mathsf{T}}}$ and $\Theta \implies \Theta''$. Finally, $(\Delta'', \Theta'') \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$ follows from $(\Delta'', \Theta'') \in \overline{\mathcal{R}_{T}}$, by the construction of $\mathcal{R}_{\lbrack \lbrack \cdot \rbrack}$.

Else, assume that P is a target term. Then $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(P,Q) \in \mathcal{R}_{\top}$, because Q is a target term and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \gamma_{\mathsf{T}}$. Since \mathcal{R}_{T} is a probabilistic correspondence simulation (see Definition [12\)](#page-15-3),

then $Q \implies \Theta$ implies $P \implies \Delta'$, $\Theta \implies \Theta'$, and $(\Delta', \Theta') \in \overline{\mathcal{R}_{\mathsf{T}}}$. Finally, $(\Delta', \Theta') \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$ follows from $(\Delta', \Theta') \in \overline{\mathcal{R}_{\mathsf{T}}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

- only if (←): We assume that there is a relation $\mathcal{R}_{\llbracket \cdot \rrbracket}$ such that $\forall S$. $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}, \mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} \uparrow_{\mathcal{P}_{\top}}$, $\forall S, T$, $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and a probabilistic correspondence simulation. We start with weak probabilistic operational correspondence.
	- **Completeness:** Assume $S \implies \Delta_S$. Since $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and because $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic correspondence simulation, then $\llbracket S \rrbracket \Longrightarrow \Delta_T$ and $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and Lemma [13,](#page-16-0) then $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket \Delta_S \rrbracket, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$
	- Weak Soundness: Assume $[S] \Longrightarrow \Delta_T$. Since $(S, [S]) \in \mathcal{R}_{[S]}$ and because $\mathcal{R}_{[S]}$ is a probabilistic correspondence simulation, then $S \implies \Delta_S$, $\Delta_T \implies \Delta'_T$, and $(\Delta_S, \Delta'_T) \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$. By $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow$ $(\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$ and Lemma [13,](#page-16-0) $(\Delta_S, \Delta'_T) \in \overline{\mathcal{R}}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket \Delta_S \rrbracket, \Delta'_T) \in \overline{\mathcal{R}}_{\mathsf{T}}$.

By Definition [10,](#page-6-0) then $\llbracket \cdot \rrbracket$ is weakly probabilistically operationally corresponding w.r.t. \mathcal{R}_{T} . Finally, since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a preorder and a probabilistic correspondence simulation and because of the Lemmata [12](#page-16-1) and [14,](#page-16-2) \mathcal{R}_T is a preorder and a probabilistic correspondence simulation. □

4 (Strong) Probabilistic Operational Correspondence

Definition 14 (Probabilistic Bisimulation). A relation $\mathcal R$ is a probabilistic (reduction) bisimulation if for each $(P,Q) \in \mathcal{R}$:

 $-P \Longrightarrow \Delta$ implies $\exists \Theta$. $Q \Longrightarrow \Theta \wedge (\Delta, \Theta) \in \overline{\mathcal{R}}$

 $-Q \Longrightarrow \Theta$ implies $\exists \Delta$. $P \Longrightarrow \Delta \wedge (\Delta, \Theta) \in \overline{\mathcal{R}}$

Two terms are probabilistic bisimilar if a probabilistic bisimulation relates them.

We can reuse several of the auxiliary results derived in Section [3](#page-14-0) for the proof of Theorem [3.](#page-18-0) But we have to adapt Lemma [14](#page-16-2) to probabilistic bisimulation.

Lemma 15. If $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic bisimulation and $\mathcal{R}_{\llbracket \cdot \rrbracket}$ $\uparrow_{\mathcal{P}_{\llbracket \cdot \rrbracket}}$ then $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic bisimulation.

Proof. Assume that $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic bisimulation and $\mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\llbracket \cdot \rrbracket}}$ Moreover, assume $(T_1, T_2) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}, \text{ then } (T_1, T_2) \in \mathcal{R}_{\llbracket \cdot \rrbracket}.$

Case (i): Assume $T_1 \mapsto \Delta$. Since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic bisimulation, then $T_2 \mapsto \Theta$ and $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. With $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$ and Lemma [11,](#page-15-2) then $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$.

Case (ii): Assume $T_2 \implies \Theta$. Since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic bisimulation, then $T_1 \implies \Delta$ and $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. With $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$ and Lemma [11,](#page-15-2) then $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$.

We conclude that $\overline{\mathcal{R}}_T$ is a probabilistic bisimulation.

Definition 15 (Probabilistic Operational Correspondence). An encoding $\llbracket \cdot \rrbracket : \mathcal{P}_S \to \mathcal{P}_T$ is probabilistic operationally corresponding (PrOC) w.r.t. $\mathcal{R}_{\mathsf{T}} \subseteq \mathcal{P}_{\mathsf{T}}^2$ if it is:

Theorem 3 (PrOC). $\llbracket \cdot \rrbracket$ is probabilistically operationally corresponding w.r.t. a preorder $\mathcal{R}_{\mathsf{T}} \subseteq \mathcal{P}_{\mathsf{T}}^2$ that is a number is involving if probabilistic bisimulation iff

 $\exists \mathcal{R}_{\llbracket \cdot \rrbracket} \cdot (\forall S. (S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}) \wedge \mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\top}} \wedge (\forall S, T. (S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\top}) \wedge \mathcal{R}_{\llbracket \cdot \rrbracket} \text{ is a preorder }$ and a probabilistic bisimulation.

Proof (Proof of Theorem [3\)](#page-18-0). We prove the two directions of the result separately.

- **if** (\rightarrow) : Assume that $[\cdot]$ is probabilistically operationally corresponding w.r.t. a preorder $\mathcal{R}_{\mathsf{T}} \subseteq \mathcal{P}_{\mathsf{T}}^2$ that is a probabilistic bisimulation. We construct $\mathcal{R}_{\llbracket \cdot \rrbracket}$ from $\mathcal{R}_{\llbracket \cdot \rrbracket}$ for all source terms S and then building the reflexive and transitive closure. Accordingly, $\forall S$. $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ holds by construction. Since we did not add any pairs of only source terms, i.e., no pairs of the form (S_1, S_2) where both S_1 and S_2 are source terms, and since the only such pairs added by the reflexive and transitive closure are of the form (S, S) , we have $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$. Next we prove that $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$. Therefore, fix some S and T and assume $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and all pairs relating a source and a target term contain a source term and its literal translation or result from such a pair, \mathcal{R}_{T} , and the transitive closure in the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$. Hence, $T = \llbracket S \rrbracket$ or $(\llbracket S \rrbracket, T) \in \mathcal{R}_{\sf T}$. In the former case, $([\mathbb{S}], T) \in \mathcal{R}_{\mathsf{T}}$ follows from the reflexivity of \mathcal{R}_{T} . The latter case directly provides $([\mathbb{S}], T) \in \mathcal{R}_{\mathsf{T}}$. That $\mathcal{R}_{\|\cdot\|}$ is a preorder directly follows from the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, because we used the reflexive and transitive closure. As last condition we have to show that $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a probabilistic bisimulation. By Definition [14,](#page-18-1) for all $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and all $P \Longrightarrow \Delta$ we have to find $Q \Longrightarrow \Theta$ such that $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and for all $Q \Longrightarrow \Theta$ we have to find $P \Longrightarrow \Delta$ such that $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, P may be a source or target term, but Q is a target term.
	- Assume $P \implies \Delta$. If P is a source term, then we have $[[P]] \implies \Delta'$ with $(\Delta, \Delta') \in \overline{\mathcal{R}_T}$, because of completeness in PrOC in Definition [15.](#page-18-2) Since Q is a target term and by the construction of $\mathcal{R}_{\|\cdot\|}$, $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. With the transitivity of \mathcal{R}_T and thus $\overline{\mathcal{R}_T}$, $(\Delta, \Delta') \in \overline{\mathcal{R}_{\mathsf{T}}}$ and $(\Delta', \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$ imply $(\Delta, \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$. Finally, $(\Delta, \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$, follows from $(\Delta, \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

Else, assume that P is a target term. Then $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(P,Q) \in \mathcal{R}_{\top}$, because Q is a target term and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$. Since \mathcal{R}_{T} is a probabilistic bisimulation (see Definition [14\)](#page-18-1), then $P \Longrightarrow \Delta$ implies $Q \mapsto \Theta$ with $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket\cdot\rrbracket}.$

- Assume $Q \implies$ Θ. If P is a source term, then $([\![P]\!], Q) \in \mathcal{R}_{[[\cdot]]}$, by the construction of $\mathcal{R}_{[[\cdot]]}$. Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$, then $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\mathsf{T}}$. Since \mathcal{R}_{T} is a probabilistic bisimulation (see second case of Definition [14\)](#page-18-1), then $Q \implies \Theta$ implies $[P] \implies \Delta_T$ and $(\Delta_T, \Theta) \in \overline{\mathcal{R}_T}$. From $[P] \implies \Delta_T$ we obtain $P \Longrightarrow \Delta$ with $(\Delta, \Delta_T) \in \overline{\mathcal{R}_T}$, because of soundness in PrOC in Definition [15.](#page-18-2) By transitivity, we obtain $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.
- Else, assume that P is a target term. Then $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(P,Q) \in \mathcal{R}_{\top}$, because Q is a target term and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$. Since \mathcal{R}_{T} is a probabilistic bisimulation (see Definition [14\)](#page-18-1), then $Q \implies \Theta$ implies $P \Longrightarrow \Delta$ and $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket\cdot\rrbracket}.$

Two terms are strong probabilistic bisimilar if a strong probabilistic bisimulation relates them.

Definition 17 (Strong Probabilistic Operational Correspondence). An encoding $\llbracket \cdot \rrbracket : \mathcal{P}_S \to \mathcal{P}_T$ is strongly probabilistic operationally corresponding *(strong PrOC)* w.r.t. $\mathcal{R}_{\mathsf{T}} \subseteq \mathcal{P}_{\mathsf{T}}^2$ if it is:

With $\mathcal{R}_{\sf T} = \mathcal{R}_{\llbracket \cdot \rrbracket} {\restriction}_{\mathcal{P}_{\sf T}}$ and Lemma [11,](#page-15-2) then $(\Delta, \Theta) \in \overline{\mathcal{R}_{\sf T}}$.

Case (ii): Assume $T_2 \mapsto \Theta$. Since $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a strong probabilistic bisimulation, then $T_1 \mapsto \Delta$ and $(\Delta, \Theta) \in$ $\mathcal{R}_{\llbracket \cdot \rrbracket}$. With $\mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} {\restriction} \mathcal{P}_{\top}$ and Lemma [11,](#page-15-2) then $(\Delta, \Theta) \in \mathcal{R}_{\top}$.

We conclude that \mathcal{R}_{T} is a probabilistic bisimulation.

Then can show Theorem [4:](#page-20-0)

Proof (Proof of Theorem [4\)](#page-20-0). We prove the two directions of the result separately.

if (\rightarrow) : Assume that $[\cdot]$ is strongly probabilistically operationally corresponding w.r.t. a preorder $\mathcal{R}_{\mathsf{T}} \subseteq \mathcal{P}_{\mathsf{T}}^2$ that is a strong probabilistic bisimulation. We construct $\mathcal{R}_{\llbracket \cdot \rrbracket}$ from \mathcal{R}_{\top} by adding $(S, \llbracket S \rrbracket)$ for all source terms S and then building the reflexive and transitive closure. Accordingly, $\forall S$. $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ holds by construction. Since we did not add any pairs of only source terms, i.e., no pairs of the form (S_1, S_2) where both S_1 and S_2 are source terms, and since the only such pairs added by the reflexive and transitive closure are of the form (S, S) , we have $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$. Next we prove that $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$.
Therefore for every S and T and events $(S, T) \in \mathcal{R}$. Therefore, fix some S and T and assume $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and all pairs relating a source and a target term contain a source term and its literal translation or result from such a pair, \mathcal{R}_T , and the transitive closure in the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$. Hence, $T = \llbracket S \rrbracket$ or $(\llbracket S \rrbracket, T) \in \mathcal{R}_T$. In the former case, $(\llbracket S \rrbracket, T) \in \mathcal{R}_{\mathsf{T}}$ follows from the reflexivity of \mathcal{R}_{T} . The latter case directly provides

 $([\mathcal{S}], T) \in \mathcal{R}_{\mathcal{T}}$. That $\mathcal{R}_{[\![\cdot]\!]}$ is a preorder directly follows from the construction of $\mathcal{R}_{[\![\cdot]\!]}$, because we used the reflexive and transitive closure. As last condition we have to show that $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is strong a probabilistic bisimulation. By Definition [16,](#page-20-1) for all $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and all $P \mapsto \Delta$ we have to find $Q \mapsto \Theta$ such that $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and for all $Q \mapsto \Theta$ we have to find $P \mapsto \Delta$ such that $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, P may be a source or target term, but Q is a target term.

– Assume $P \mapsto \Delta$. If P is a source term, then we have $[\![P]\!] \mapsto \Delta'$ with $(\Delta, \Delta') \in \overline{\mathcal{R}_T}$, because of strong completeness in strong PrOC in Definition [17.](#page-20-2) Since Q is a target term and by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$, $(P, Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. Because of $\mathcal{R}_{\sf T} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\sf T}}$, then $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\sf T}$. Then $Q \mapsto \Theta$ and $(\Delta', \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$, because \mathcal{R}_{T} is a strong probabilistic bisimulation. With the transitivity of \mathcal{R}_{T} and thus $\overline{\mathcal{R}_{\mathsf{T}}}, (\Delta, \Delta') \in \overline{\mathcal{R}_{\mathsf{T}}}$ and $(\Delta', \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$ imply $(\Delta, \Theta) \in \overline{\mathcal{R}_{\mathsf{T}}}$. Finally, $(\Delta, \Theta) \in \overline{\mathcal{R}_{\llbracket \cdot \rrbracket}}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

Else, assume that P is a target term. Then $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(P,Q) \in \mathcal{R}_{\top}$, because Q is a target term and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$. Since \mathcal{R}_{T} is a strong probabilistic bisimulation (see Definition [16\)](#page-20-1), then $P \longmapsto \Delta$ implies $Q \longmapsto \Theta$ with $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\mathbb{T}}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

– Assume $Q \mapsto \Theta$. If P is a source term, then $([\![P]\!], Q) \in \mathcal{R}_{[[\cdot]]}$, by the construction of $\mathcal{R}_{[[\cdot]]}$. Because of $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \upharpoonright_{\mathcal{P}_{\mathsf{T}}}$, then $(\llbracket P \rrbracket, Q) \in \mathcal{R}_{\mathsf{T}}$. Since \mathcal{R}_{T} is a strong probabilistic bisimulation (see second case of Definition [16\)](#page-20-1), then $Q \mapsto \Theta$ implies $\llbracket P \rrbracket \mapsto \Delta_T$ and $(\Delta_T, \Theta) \in \overline{\mathcal{R}_T}$. From $\llbracket P \rrbracket \mapsto \Delta_T$ we obtain $P \mapsto \Delta$ with $(\Delta, \Delta_T) \in \overline{\mathcal{R}_T}$, because of strong soundness in strong PrOC in Definition [17.](#page-20-2) By transitivity, we obtain $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

Else, assume that P is a target term. Then $(P,Q) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(P,Q) \in \mathcal{R}_{\top}$, because Q is a target term and $\mathcal{R}_{\mathsf{T}} = \mathcal{R}_{\llbracket \cdot \rrbracket} \restriction_{\mathcal{P}_{\mathsf{T}}}$. Since \mathcal{R}_{T} is a strong probabilistic bisimulation (see Definition [16\)](#page-20-1), then $Q \longmapsto \Theta$ implies $P \longmapsto \Delta$ and $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$. Finally, $(\Delta, \Theta) \in \mathcal{R}_{\mathbb{T}}$ follows from $(\Delta, \Theta) \in \mathcal{R}_{\mathsf{T}}$, by the construction of $\mathcal{R}_{\llbracket \cdot \rrbracket}$.

- only if (←): We assume that there is a relation $\mathcal{R}_{\llbracket \cdot \rrbracket}$ such that $\forall S$. $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}, \mathcal{R}_{\top} = \mathcal{R}_{\llbracket \cdot \rrbracket} \uparrow_{\mathcal{R}_{\top}}$ $\forall S, T \nvert (S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \rightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ is a preorder and a strong probabilistic bisimulation. We start with strong probabilistic operational correspondence.
	- Strong Completeness: Assume $S \mapsto \Delta_S$. Since $(S, [S]) \in \mathcal{R}_{[S]}$ and because $\mathcal{R}_{[S]}$ is a strong probabilistic bisimulation, then $\llbracket S \rrbracket \mapsto \Delta_T$ and $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and Lemma [13,](#page-16-0) then $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket \Delta_S \rrbracket, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$
	- **Strong Soundness:** Assume $\llbracket S \rrbracket \mapsto \Delta_T$. Since $(S, \llbracket S \rrbracket) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and because $\mathcal{R}_{\llbracket \cdot \rrbracket}$ is a strong probabilistic bisimulation, then $S \mapsto \Delta_S$ and $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$. By $\forall S, T$. $(S, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket} \longrightarrow (\llbracket S \rrbracket, T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ and Lemma [13,](#page-16-0) then $(\Delta_S, \Delta_T) \in \mathcal{R}_{\llbracket \cdot \rrbracket}$ implies $(\llbracket \Delta_S \rrbracket, \Delta_T) \in \mathcal{R}_{\top}$.

By Definition [17,](#page-20-2) then $\llbracket \cdot \rrbracket$ is strongly probabilistically operationally corresponding w.r.t. \mathcal{R}_{T} . Finally, since $\mathcal{R}_{\llbracket\cdot\rrbracket}$ is a preorder and a strong probabilistic bisimulation and because of the Lemmata [12](#page-16-1) and [16,](#page-20-3) \mathcal{R}_{\top} is a preorder and a strong probabilistic bisimulation. ⊓⊔

Similar to Lemma [4,](#page-7-1) we show that \equiv is barb sensitive.

Lemma 17 (\equiv is Barb Sensitive).

If $T_1 \equiv T_2$ then $T_1 \downarrow_n \longleftrightarrow T_2 \downarrow_n$ for all $n \in \mathcal{N} \cup \overline{\mathcal{N}}$. Moreover, if $\Delta_1 \equiv \Delta_2$ then $\Delta_1 \downarrow_n \leftrightarrow \Delta_2 \downarrow_n$ for all $n \in \mathcal{N} \cup \overline{\mathcal{N}}$.

Proof. Fix some $n \in \mathcal{N} \cup \overline{\mathcal{N}}$. The proof is by induction on the definition of \equiv . All cases are immediate.

- α -**Equivalence** \equiv_{α} : In this case $T_1 \equiv_{\alpha} T_2$. Since barbs via labelled steps on unrestricted names, we have $T_1\downarrow_n$ iff $T_2\downarrow_n$.
- $P \mid \mathbf{0} \equiv P$: In this case $T_1 = T_2 \mid \mathbf{0}$. Since $\mathbf{0}$ does not contain any barbs, then $T_1 \downarrow_n$ iff $T_2 \downarrow_n$.
- $P \mid Q \equiv Q \mid P$: In this case $T_1 = P \mid Q$ and $T_2 = Q \mid P$. Then $T_1 \downarrow_{\checkmark}$ iff $(P \downarrow_n \vee Q \downarrow_n)$ iff $T_2 \downarrow_n$.
- $P | (Q | R) \equiv (P | Q) | R$: In this case $T_1 = P | (Q | R)$ as well as $T_2 = (P | Q) | R$. Thereby, $T_1 \downarrow_{\checkmark}$ iff $(P\downarrow_n \vee Q\downarrow_n \vee R\downarrow_n)$ iff $T_2\downarrow_n$.
- $(\nu x)\mathbf{0} \equiv \mathbf{0}$: In this case $T_1 = (\nu x)\mathbf{0}$ and $T_2 = \mathbf{0}$. Since $\mathbf{0}$ does not contain any barbs, then $T_1\mathbf{1}_n$ and $T_2\mathbf{1}_n$.
- $(\nu xy)P \equiv (\nu yx)P$: Then $T_1 = (\nu xy)P$ and $T_2 = (\nu yx)P$. Since only unrestricted actions can be observed, then $T_1\downarrow_n$ iff $P\downarrow_n$ iff $T_2\downarrow_n$.
- $(\nu x)(P \mid Q) \equiv P \mid (\nu x)Q$: In this case $T_1 = (\nu x)(P \mid Q)$ and $T_2 = P \mid (\nu x)Q$, where $x \notin \text{fn}(P)$. Here $x \notin \text{fn}(P)$ ensures that $P\chi_x$ and $P\chi_{\overline{x}}$. Then $T_1\downarrow_n$ iff $((P\downarrow_n \vee Q\downarrow_n) \wedge n \neq x \wedge n \neq \overline{x})$ iff $T_2\downarrow_n$.
- $\Delta_1 \equiv \Delta_2$: In this case there is a finite index set I such that $\Delta_1 = \sum_{i \in I} p_i P_i$, $\Delta_2 = \sum_{i \in I} p_i Q_i$, and $P_i \equiv Q_i$ for all $i \in I$. Because of $P_i \equiv Q_i$, we have $P_i \downarrow_n$ iff $Q_i \downarrow_n$ for all $i \in I$. Then $\Delta_1 \downarrow_n$ iff $\Delta_2 \downarrow_n$.

Then we can show that the encoding $\left\{\cdot\right\}_{\mathsf{CC}}^{\pi_\mathsf{p}}$ ${}_{\text{CCS}_{p}}^{\pi_{p}}$ also respects barbs, i.e.,:

Lemma 18 (Barb Sensitiveness, $\left(\cdot\right)_{\text{CC}}^{\pi_{\text{p}}}$ $\frac{\pi_{\mathsf{p}}}{\mathsf{CCS}_{\mathsf{p}}}/\llbracket \cdot \rrbracket_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ $_{\textrm{CCS}_{\textrm{p}}}^{\pi_{\textrm{p}}}$). For every S and all $n \in \mathcal{N} \cup \overline{\mathcal{N}}$, $S \Downarrow_n$ iff $(\bigcirc_{\mathsf{CC}}^{\pi_p})^{\pi_p}$ $\operatorname{CCS}_{p} \Downarrow_{\varphi_{\{\cdot\}}\underset{\mathsf{CCS}_{p}}{\pi_{p}}(n)}$.

Proof (Proof of Lemma [18\)](#page-22-4). By Definition [5,](#page-4-1) i.e., since the encoding function does not introduce new free names and because of the rigorous use of the renaming policy $\varphi_{\{\cdot\}_{\text{CCSp}}^{\pi_p}}$, $S^*\downarrow_n$ iff $\{S^*\}$ π_{p} $\overline{\text{CCS}}_{\text{p}}\downarrow_{\varphi_{\{\cdot\}}\underset{\text{CCS}_{\text{p}}}{\pi_{\text{p}}}(n)}$ for all S^* .

Then also $\Delta_S^* \downarrow_n$ iff (Δ_S^*) π_{p} $\tau_{\mathsf{CCS}_{\mathsf{p}}}^{\pi_{\mathsf{p}}} \downarrow_{\varphi_{\mathbb{Q} \cdot \mathsf{D}_{\mathsf{CCS}_{\mathsf{p}}}}(n)}$ for all distributions Δ_S^* .

- If $S \Downarrow_n$, then $S \implies \Delta_S$ and $\Delta_S \downarrow_n$. By Lemma [6,](#page-9-0) then $\langle S \rangle_{\text{CC}}^{\pi_p}$ $\alpha_{\text{CCS}_{\text{p}}} \implies \Delta_T$ and $(\Delta_S)_{\text{CC}}^{\pi_{\text{p}}}$ $\frac{\pi_{\mathsf{P}}}{\mathsf{CCS}_{\mathsf{P}}} \equiv \Delta_T$. By Defi-nition [5,](#page-4-1) $\Delta_S \downarrow_n$ implies $(\Delta_S)_{\text{CC}}^{\pi_p}$ ${}^{\pi_{\mathsf{p}}}_{\mathsf{CCS}_{\mathsf{p}}} \downarrow_{\varphi_{\{\cdot\}}_{\mathsf{CCS}_{\mathsf{p}}}(n)}$. By Lemma [17,](#page-21-0) then $(\Delta_S)_{\mathsf{CCS}_{\mathsf{p}}}^{\pi_{\mathsf{p}}}$ ${}^{\pi_{\mathsf{p}}}_{\mathsf{CCS}_{\mathsf{p}}} \equiv \Delta_T \text{ implies } \Delta_T \downarrow_{\varphi_{\{\cdot\}_{\mathsf{CCS}_{\mathsf{p}}}}(n)}$. Finally, $(S)_{\text{CC}}^{\pi_{\text{p}}}$ $\lim_{\text{CCS}_{\text{p}}} \Longrightarrow \Delta_T \text{ and } \Delta_T \downarrow_{\varphi_{\text{0}} \downarrow_{\text{CCS}_{\text{p}}}} \text{ imply } (S)_{\text{CC}}^{\pi_{\text{p}}}$ $\operatorname{CCS}_{p} \Downarrow_{\varphi_{\{\cdot\}}_{\text{CCS}_{p}}^{\pi_{p}}(n)}$.
- If $(S)_{\text{CC}}^{\pi_{\text{p}}}$ $\operatorname*{ccs}_{\mathsf{p}}\Downarrow_{\varphi_{\{\cdot\}}\underset{\mathsf{CCS}_{\mathsf{p}}}{\pi_{\mathsf{p}}}(n)}, \text{ then } \|\mathcal{S}\|_{\mathsf{CC}}^{\pi_{\mathsf{p}}}$ ${}^{\pi_{p}}_{\mathsf{CCS}_{p}} \Longleftrightarrow \Delta_{T} \text{ and } \Delta_{T} \downarrow_{\varphi_{\mathbb{C} \setminus \mathbb{C} \mathsf{CS}_{p}}} (n)$. By Lemma [7,](#page-12-0) then $S \Longleftrightarrow \Delta'_{S}, \Delta_{T} \Longleftrightarrow \Delta'_{T}$, and (Δ_S') π_{p} ${}^{\pi_{\mathsf{p}}}_{\mathsf{CC}\mathsf{S}_{\mathsf{p}}} \equiv \Delta'_T$. Because of $\Delta_T \models \Delta'_T, \, \Delta_T \downarrow_{\varphi_{\mathsf{Q}} \upharpoonright^{\pi_{\mathsf{p}}}_{\mathsf{CC}\mathsf{S}_{\mathsf{p}}}}(n)$ implies $\Delta'_T \downarrow_{\varphi_{\mathsf{Q}} \upharpoonright^{\pi_{\mathsf{p}}}_{\mathsf{CC}\mathsf{S}_{\mathsf{p}}}}(n)$. By Lemma [17,](#page-21-0) $\Delta'_T \downarrow_{\varphi_{\mathsf{Q}} \uphar$ and (Δ'_S) π_{p} $_{\text{CCS}_{\text{p}}}^{\pi_{\text{p}}} \equiv \Delta'_{T} \text{ imply } (\Delta'_{S})$ π_{p} ${}^{\pi_{p}}_{\mathsf{CCS}_{p}}\downarrow_{\varphi_{\mathbb{C} \cdot \mathsf{CS}_{p}}}$ (n). By Definition [5,](#page-4-1) then $\Delta'_{S}\downarrow_{n}$. Finally, $S \Longrightarrow \Delta'_{S}$ and $\Delta'_{S}\downarrow_{n}$ \Box imply $S\Downarrow_n$. □
