# Mainstream News Articles Co-Shared with Fake News Buttress Misinformation Narratives

Most prior and current research examining misinformation spread on social media focuses on reports published by 'fake' news sources. These approaches fail to capture another potential form of misinformation with a much larger audience: factual news from mainstream sources ('real' news) repurposed to promote false or misleading narratives. We operationalize narratives using an existing unsupervised NLP technique and examine the narratives present in misinformation content. We find that certain articles from reliable outlets are shared by a disproportionate number of users who also shared fake news on Twitter. We consider these 'real' news articles to be *co-shared* with fake news. We show that co-shared articles contain existing misinformation narratives at a significantly higher rate than articles from the *same* reliable outlets that are *not* co-shared with fake news. This holds true even when articles are chosen following strict criteria of reliability for the outlets and after accounting for

the alternative explanation of partisan curation of articles. For example, we observe that a recent article published by The Washington Post titled "Vaccinated people now make up a majority of COVID deaths" was disproportionately shared by Twitter users with a history of sharing anti-vaccine false news reports. Our findings suggest a strategic repurposing of mainstream news by conveyors of misinformation as a way to enhance the reach and persuasiveness of misleading narratives. We also conduct a comprehensive case study to help highlight how such repurposing can happen on Twitter as a *consequence* of the inclusion of particular narratives in the framing of mainstream news.

#### Introduction

Much scholarly and media attention has been lavished on the presence of misinformation in the contemporary information ecosystem (1-3). However, studies attempting to measure the scale of the spread of, and exposure to, fake news as part of the information ecosystem have found it to represent a very tiny part of people's media consumption (4-8). For example, "fake news comprises only 0.15% of Americans' daily media diet" (7). Thus, news that is *not* deemed as fake has a much larger audience, and understanding its interaction with fake news and potential role in the world of online misinformation is critical (9).

In this work, we show that one explanation for certain content from legitimate news sources being shared in the same social media circles as fake news is the occurrence of shared narratives. Most research studying fake news relies on lists of particular outlets deemed as 'fake news outlets' (4, 10–12), which can unwittingly obscure the potential role of news from mainstream ("non-fake") outlets in online misinformation. Operating at the level of news producers can also ignore heterogeneity in the quality of news articles published by any particular outlet, and how outlets deemed legitimate in terms of journalistic practices and norms might still publish

individual, factual stories that are quite misleading (or easily used as such).<sup>1</sup>

We extract and analyze the articles published by mainstream political news outlets (popular outlets *not* marked as regularly publishing false information) that are most likely to be shared in the same Twitter circles as fake news in our dataset, i.e., *co-shared articles*. Articles from these mainstream outlets are scored on how likely they are to be co-shared with fake news. We hypothesize that legitimate news stories that are co-shared with fake news stories often contain misinformation narratives, which are entity-action relationships that repeatedly occur in fake news sources or are present in statements known to be false. This is in opposition to legitimate news stories published by the same reliable outlets that are not co-shared with fake news. In short, we expect that mainstream news stories that are disproportionately co-shared with fake news will be significantly more likely to contain misinformation narratives.




Figure 1: Visual illustration summarizing our approach. In part a) (top-left), we show our process of finding reliable articles disproportionately co-shared with fake news: we score pairs of fake and reliable news on the likelihood of co-occurrence of their shares (by the same set of Twitter users) when controlling for the individual popularity of the two articles. Our method uses a graph-based approach with edges between fake and reliable articles (the nodes) weighted by the number of users sharing both incident articles. The Washington Post article (only headline shown here) illustrates our approach: the article was disproportionately shared by antivaccine fake-news conveyors in our Twitter panel. This process helps us create two groups of mainstream news articles: disproportionately co-shared and control. Using a natural language processing method developed in prior work, we automatically extract potential narrative structures from all texts in our data: misinformation content as well as mainstream news articles, and narratives from misinformation content are considered sets of misinformation narrative libraries (part b), right-hand side). Part c) (bottom-left) illustrates how we conduct the comparison at the heart of our significance testing procedure, in order to test our hypothesis: mainstream news stories that are disproportionately co-shared with fake news consist of a significantly higher presence of misinformation narratives.

For example, a recent article published by The Washington Post (WAPO) with the headline "Vaccinated people now make up a majority of covid deaths" was disproportionately shared by Twitter users in our dataset who have a history of sharing anti-vaccine-related articles published by fake-news outlets (Fig. 1a).<sup>2</sup> The headline/story content are strictly true, but one can see how they would be useful for a user who wished to promote the false narrative that the COVID-19 vaccine is ineffective or actively harmful, which is a popular narrative and belief in misinformation content (14). This example illustrates that the presence of misinformation narratives might enable the repurposing of an otherwise factually correct mainstream article by fake-news conveyors on Twitter.

We investigate our hypothesis by deploying a tool for automatically extracting narrative structures from English text that are represented using narrative strings or labels. This provides us with narratives present in fake news articles as well as claims fact-checked to be false

(Fig. 1b). Our experiments across a variety of misinformation narrative collections and types of reliable outlets validate our hypothesis (the testing procedure is visualized in Fig. 1c). The difference in the presence of misinformation narrative strings between co-shared and control articles (from the same set of mainstream news outlets) remains significant when accounting for partisan differences in the Twitter audience of the two groups of articles (Appendix B).

Our method of scoring news stories on how disproportionately their Twitter shares are connected with fake news shares contributes a scalable and generalizable way of fleshing out the online misinformation ecosystem beyond fake news. It lays the foundations for further investigation of interacting mainstream and fake news articles.

Our finding has important implications for responsible journalistic practice: when vetting news stories (including the headlines) and their framing, it is important to consider not just the story itself but also the broader context of existing narratives in misinformation content. We further highlight the possible consequences of framing choices in mainstream news and their possible repurposing to support misinformation through a comprehensive case study, which also offers insight into how our work provides building blocks of an enabling technology for journalism.

For both journalism and scientific research, our work highlights the importance of looking beyond falsehoods in fake news and towards the larger narratives and world views being fleshed out in news articles of all stripes, including legitimate news. These narratives, and not just the propensity to share falsehoods, are critical for understanding connections between fake news and other news articles.

# **Background and Definitions**

While misinformation has existed since before the invention of the printing press (15), scholars have noted how online news consumption in the digital age, combined with social media, can

enhance the speed and magnitude of its spread (16–20). Online misinformation spread has been noted for the multitude of crises it can help create, including the potential threat to the effective functioning of democracy (21–23), the possibility of increased political polarization (24, 25), and negative effects on trust in public institutions as well as on interpersonal relationships (26–28).

However, as we noted above, fake news and online misinformation constitute a very tiny portion of people's media diet and in this work, we aim to highlight the role of articles published by reliable ('real') outlets, with a much larger audience, in the world of online misinformation.

In this section, we define (and provide background for) the terminology used throughout this paper. We use the terms *domains*, *sources*, and *outlets* interchangeably to refer to news outlets in this work.

**Narratives.** These are sets of entity-action relationships or structures that describe how entities act on each other (29, 30). More specifically for us, these relationships are characterized by a base component of the following format: AGENT ENTITY  $\xrightarrow{\text{VERB}}$  PATIENT ENTITY (31). Some examples are shown in Fig. 1b and Table 2; the extraction process is summarized in Fig. 3.

This is a specific instantiation using some of the components that have been found to characterize narratives in text across the broad and varied literature on narratives — a prior review of narrative theory and considered other components important to narratives such as timing, motivations, etc. (32). Entities (agents and patients) and the actions connecting them were also found to be critical components of narratives in that review, and we focus on those following the prior research which we use in this work (31), including their open-sourced tool for narrative extraction.<sup>3</sup>

**Misinformation.** This broadly refers to false information. We refer to content published by fake news outlets (per our particular operationalization described below) as well as claims or statements fact-checked to be false as misinformation in this work. The former is also sometimes referred to more specifically as fake news articles or fake news, and is typically a subset of misinformation.

**Fake news outlets & fake news.** Fake news domains or outlets are the sources that masquerade as legitimately produced news but eschew epistemological practices (including editorial norms and processes for vetting information) (5, 33).<sup>4</sup> In this work, we deem articles from outlets known to regularly publish false content (per annotations from NewsGuard (35)) as fake news, and the outlets themselves as fake news outlets.<sup>5</sup>

We note that prior literature has used NewsGuard annotations in different ways, such as using the provided 'trustworthiness' scores to divide information sources into groups (36, 37). We aim for precision by considering 'regularly publishing false content' as our criterion out of all the factors that determine trustworthiness in NewsGuard ratings. This helps us highlight the drawbacks of conceptualizing problems with the digital information ecosystem as that of 'false information' or fake news content — a framework that often foregoes closer examination of information coming from sources deemed reliable. An example of a fake news article is shown in Fig. 1a (only the headline).




Figure 2: The top articles from The New York Times (NYT) and The Washington Post (WAPO) in the set of articles disproportionately co-shared with fake news, based on the co-sharing likelihood derived from Twitter sharing behavior. As motivation for our hypothesis in this work, consider the third NYT article and the seventh WAPO article shown in the figure about mail-in ballots and absentee voting. These articles are popular in the same Twitter circles sharing stories published by fake news outlets containing narratives (extracted in this work) that include 'mail ballot raise risk fraud', 'lot people cheat mail', 'mail balloting increase incident fraud', 'paper mail balloting mean dramatic increase fraud', and 'republican complain potential mail absentee ballot fraud'. While only headlines are shown here for illustrative purposes, our investigation also used the entire text of the news article. We will provide the texts as well as the exact article URLs for all groups of news articles as part of our codebase.

**Reliable outlets.** These are all the news outlets annotated for their quality as information sources by journalists at NewsGuard and *not* deemed as fake news outlets as per our selected criteria above. Since this is quite broad, we also show our primary results with narrower criteria such as only considering sources marked as 'trustworthy' by the NewsGuard team as well as ideological subsets (the process for liberal versus conservative categorization is described below).

one low-credibility category (41).

**Mainstream media or news (outlets).** Within reliable outlets, we define mainstream outlets as those that *publish predominantly political content*, are *popular*, and are *not ideological outliers*.

We borrow domain-level ratings from prior work (13). These ratings are based on Twitter shares of articles (over the 2010 to 2021 period) published by various outlets using the same panel of users in the overall dataset used in this work (briefly described above in Data and Methods; the annotations we use will be made available as part of our codebase). The three criteria we use to demarcate mainstream outlets are detailed below:

- 1. **Publish predominantly political content.** Each domain published many articles, but only some of them were deemed as 'political' in domain-level ratings based on the type of users sharing them on Twitter. Using the percentages of all articles published by a domain deemed political content as the political score, *predominantly political domains* are ones having a score greater than a *z*-score of 1.0 (greater than the mean plus the standard deviation calculated using all the domain-level political scores).
- 2. **Popular.** Among these domains that predominantly publish political content, we select the *popular* ones as those that are *i*) in the top 10% for the number of Twitter users sharing a domain's content; and *ii*) among the top 500 most-visited domains per the users involved in a YouGov panel survey (2015-16), with site-visiting statistics derived from passive metering data (per the analysis and data-release in prior work (42)). Using this intersection is a more robust way of deciding the domains that should be deemed 'popular' as opposed to, say, only considering popularity based on Twitter shares.
- 3. *Not* ideological outliers. Finally, using the scalar aggregated ideological scores derived using the number of registered Democratic or Republican Twitter users sharing an article published by that domain (13), we remove domains that are either in the top or the bottom

10% of ideological scores to remove ideological outliers.

The remaining outlets are referred to as mainstream political news outlets, mainstream news, or mainstream media.

**Trustworthy outlets.** These outlets are a particular subset of the set of mainstream media outlets defined above — ones that are annotated as 'trustworthy' in NewsGuard ratings. We note again that 'regularly publishing false content' — our criterion for deciding the outlets that are considered as fake news outlets in this study — is one of several criteria that determine trustworthiness scores in NewsGuard ratings.

**Liberal news outlets.** Using the same aggregated ideological scores based on Twitter shares (13) described above for removing domains that are ideological outliers, we consider each mainstream outlet with an ideological score less than the median of all scores across mainstream outlets as a liberal news outlet (the scores follow the traditional *negative-to-positive* as *liberal-to-conservative* axis, which means lower scores represent a more liberal rating).




Figure 3: A brief summary of the process of extracting narratives using the method created in prior work (31). The following example sentence, obtained from a text of a fake news article in our dataset, is used: "Over 100,000 U.S. children are maimed or killed by vaccines each year."

**Misinformation narratives.** These are the entity-action relationships present in false claim statements or recurring (top 1% in terms of frequency of occurrence) in content published by fake news sources (such as "vaccines harm people").<sup>7</sup> The method for extracting such narratives is detailed in the Data and Methods section below (and summarized in Fig. 3), and some

But we define misinformation narratives that either occur repeatedly in fake news content (where each instance, in trying to mirror mainstream news, contains a detailed story spanning multiple sentences), as well all the ones that occur in false claims (where each instance is a fact-checked false claim consisting of a short sentence).

examples are provided in Table 2.8 Misinformation narratives need not be exclusive to either misinformation or fake news, but in fact, as our findings indicate, can show up across both fake and 'real' news, cross-cutting the types of news outlets.

#### **Data and Methods**

Original Twitter Data. Using a dataset of English tweets from a nationally representative panel of U.S. Twitter users (43, 44), we look at all tweets that share news articles (published by English-language information sources or outlets per NewsGuard) from May 2018 to November 2021. This results in an initial dataset containing  $\sim$ 14.6 million unique URLs published by  $\sim$ 4000 domains shared by  $\sim$ 600,000 different users. For each tweet, we have the user ID of the author, and the news URL being shared in the tweet. We keep URLs that were shared by at least 20 different users (to control for sparsity effects), resulting in  $\sim$ 420,000 different URLs published by  $\sim$ 2400 domains shared by  $\sim$ 480,000 different users.

Creating two groups of mainstream news articles: disproportionately co-shared and control. Our process for finding co-shared mainstream articles is visualized in Fig. 1a.

We create a weighted graph where the nodes are individual articles or URLs shared in tweets (boxes in Fig. 1a), and edges are only considered to be between a pair of nodes where one node is an article published by a fake news outlet (nodes shown on the left-hand side of Fig. 1a) and the other node is an article published by one of the other (reliable) outlets (nodes shown on the

right-hand side of Fig. 1a). Our processed dataset contains  $\sim 24k$  fake news stories published by 276 domains. The weight of each edge is the number of Twitter users in our dataset that shared *both* the incident node URLs at least once (in our illustrative example in Fig. 1a, 8 is the edge weight since eight different users in our panel shared both the WAPO and the fake news article displayed).

Each edge then receives a co-sharing score based on the likelihood of both incident node URLs getting shared by the same user, controlling for the individual popularity of each of those URLs in isolation. This is a straightforward application of a graph-pruning algorithm (45) that has been applied in prior work to construct a co-exposure network that identifies news outlets with a shared audience (5, 46). To the best of our knowledge, this method has not been previously applied to study networks formed by individual news articles. We posit that studying these networks of article-sharing is important for identifying mainstream news stories published by reliable outlets that would otherwise not be considered for their potential role in misinformation circulation on social media.  $^{10}$ 

Edges in the top 1% of co-share scores are considered disproportionately co-shared or simply, co-shared (highlighted as the darker edges in Fig. 1a), and any nodes (articles) from reliable outlets that are a part of the two incident nodes forming those edges are considered as co-shared. Some examples of top co-shared articles (based on an aggregated co-sharing likelihood score for each outward edge from a particular article or URL) from two particular news outlets are shown in Fig. 2. In this study, we only analyze articles published by mainstream outlets (as defined in the prior section) that fall in this top 1% set of articles as *the group of*

articles that are co-shared with fake news. Stories published by the same set of mainstream outlets that are not in the top 5% of co-sharing likelihood scores form our control group. Finally, we have  $\sim 91k$  news stories in the co-shared group and  $\sim 51k$  news stories from the same set of news outlets in our control group. Headline and story texts of all URLs are automatically extracted. Stories are automatically extracted.

Extracting and creating misinformation narrative libraries. We operationalize narratives using the methodology and open-source package created in prior work (31).<sup>16</sup> The conceptual definition used is "sets of relationships between entities that act on each other", which, in language, involves looking at "grammatical statements describing actors, actions, and the acted-upon." Fig. 3 briefly visualizes the process of extracting the narrative structure through an illustrative example.

Narrative structures extracted consist of the base form:

AGENT ENTITY 
$$\xrightarrow{\text{VERB}}$$
 PATIENT ENTITY  $\in E \times V \times E$ 

where E is the set of clustered entities and named entities, and V is the set of all verbs. For example,  $vaccine \xrightarrow{cause} shingles$  and  $people \xrightarrow{develop} shingles$  could be extracted as these base structures, and we can also have  $vaccine \xrightarrow{cause} people \xrightarrow{develop} shingles$  (extracted narrative structures need not be limited to triplets). These are then simply represented as strings, or what we call narrative labels or narrative strings ('vaccine cause shingles'; 'vaccine cause people develop shingles').

Since entities are clustered together during the process of narrative extraction (Fig. 3), the pre-specified number of clusters constitutes an important decision. Following the documentation in the publicly available package (31), two settings are used in order to extract narratives at two levels of granularity from the text data. The first is called *low-dimensional narratives*:

when fewer clusters or latent entities are allowed; and the second is called *high-dimensional narratives*: when a higher number of clusters or latent entities are allowed. <sup>19</sup> Low-dimensional narratives are 'broader' and carry the risk of less coherent entities in these structures (since each group or cluster collects a larger number of underlying individual entity instances), whereas high-dimensional narratives are more 'fine-grained' and carry the risk of some clusters being redundant (and representing the same entity). For example, for the (original, non-processed) sentence — "The filing claims that Zostavax caused multiple people to develop shingles." — the method finds the low-dimensional narrative 'vaccine cause shingle', and finds the high-dimensional narrative 'zostavax cause multiple people develop shingle'. In the former case, the terms 'zostavax' and 'vaccine' terms were clustered together as part of the same entity cluster (represented by 'vaccine'), while in the latter case, the terms 'zostavax' and 'multiple people' could now be part of the string representation because a larger number of smaller-sized clusters were allowed. Each instance of our hypothesis testing and corresponding results includes both these levels of granularity, adding another layer of robustness to our findings.

In this work, we combine all the texts we have: fake news articles, false fact-checked claims, and co-shared and control sets of mainstream news articles, and apply the narrative extraction tool to this combined text data (ensuring that the various choices in narrative labels or string representations, such as the chosen entity representation for a cluster, remain consistent across all various texts). We then divide the output according to the different types of data being considered to get the set of narratives for each group of texts.

For misinformation narratives, we consider two sources of data: headline and story texts from the fake news articles ( $\sim$ 24k URLs), and claims fact-checked to be false ( $\sim$ 24k texts or claims). Headlines and story texts are used as separate text instances and processed to remove

information like domain name mentions, which finally results in  $\sim 30k$  texts.<sup>20</sup> Misinformation narratives from fake news content are defined as recurring narratives: the top 1% in terms of frequency of occurrence. We also experiment with all the narratives found in fake news content (Table 1).

For fact-checked false claims, we collect and combine various publicly available datasets, and use the claims that are labeled as false (or an equivalent label such as 'not true'; our code-base will provide all the labels used to create our collection). These claims will be provided along with the rest of our data in our codebase.<sup>21</sup> Since these are statements, usually consisting of a single sentence fact-checked as false, we consider all narratives extracted from this data as misinformation narratives.

We thus create three misinformation narrative libraries, each containing low and highdimensional narratives (Table 1). Examples of misinformation narratives are provided in Table 2.

## **Hypothesis Testing Procedure and Results**

Our co-sharing method described above results in two groups of articles from reliable ("not-fake") mainstream news media outlets: those disproportionately co-shared with at least one of the fake news articles, and those *not* co-shared with any of the fake news articles (the control group). We have also extracted and created different sets or libraries of misinformation narratives (Table 1).

Per our method, we also obtain both high- and low-dimensional narrative strings (or labels) from the headlines and story texts of co-shared and control mainstream articles. These enable us to test our hypothesis: mainstream news stories that are disproportionately co-shared with fake news consist of a significantly higher presence of misinformation narratives. Put another way, we test if misinformation narratives (extracted in various ways) are present in significantly higher proportions in the co-shared set of articles than in the control group of articles published by the same mainstream outlets. If true, this would suggest that misinformation narratives may allow for a strategic repurposing of mainstream news in fake-news sharing circles on Twitter, something our data and method can be used to study as demonstrated by our case study.

Our testing mechanism is visually explained in Fig. 1c. Consider a particular misinformation narrative library and a particular set of high- or low-dimensional narrative labels or strings in that library, and let's denote this particular collection as M, with size |M| and narrative strings  $n_1, \ldots, n_i, \ldots, n_{|M|}$ . For both groups of mainstream articles (co-shared and control), we obtain the corresponding values of each misinformation narrative as its normalized count in

the set of all narratives extracted from that particular group of articles. Specifically, let  $C_s$  be the collection of all narrative strings present in co-shared mainstream articles (with  $|C_s|$  total number of unique narrative strings:  $s_1, \ldots, s_i, \ldots, s_{|C_s|}$ ), and  $C_o$  be the collection of all narrative strings present in control mainstream articles (with  $|C_o|$  total number of unique strings:  $o_1, \ldots, o_i, \ldots, o_{|C_o|}$ ). Then, the two lists of values we compare —  $l_{cs}$  for co-shared, and  $l_{co}$  for control — are created by iterating over all narratives  $(n_i)$  in M as follows:

$$l_{cs} = \left\lceil \frac{\operatorname{count}(n_i \in C_s)}{\sum_{i=1}^{|C_s|} \operatorname{count}(s_i \in C_s)} \forall n_i \in M \right\rceil$$

$$l_{co} = \left\lceil \frac{\operatorname{count}(n_i \in C_o)}{\sum_{i=1}^{|C_o|} \operatorname{count}(o_i \in C_o)} \forall n_i \in M \right\rceil$$

We then test if misinformation narratives have a significantly higher presence in co-shared articles ( $l_{cs} > l_{co}$ ; Fig. 1c) using the one-sided Wilcoxon-signed rank test (non-parametric significance test for comparing paired or dependent data) (51, 52).<sup>22</sup>

This process is repeated for all three of our misinformation narrative libraries (see Table 1), with the test performed separately for high- and low-dimensional narratives. To control for distributional shifts in the number of articles published by reliable domains, we also perform the same test with articles in both groups limited to those published by trustworthy outlets, as well as articles in both groups limited to those published by liberal outlets alone (trustworthy and liberal outlets are defined in the background section).<sup>23</sup> The results across all these settings are shown in Table 3 and clearly validate our hypothesis: articles from mainstream outlets that are co-shared with fake news contain misinformation narratives at a significantly higher rate.

To provide an estimate for the size of this effect, we also conduct a regression experiment, where every instance is a mainstream news article. The dependent variable (y) is a binary indicator for whether the mainstream article belongs to the co-shared or the control set. We combine all recurring narratives in fake news and all narratives in false fact-checked claims as our misinformation narrative set, and then count the number of narratives in the mainstream article that are also present in the misinformation narrative set. This count forms the independent variable  $(X \text{ or } X_{\text{misinfo-narrative}})$ . Results in Table 4 show that there is a significant positive association be-

tween the number of misinformation narratives in an article and its co-sharing likelihood, with the co-shared group having roughly 1.25 times the odds of the control group for containing a higher number of misinformation narratives.

Partisan curation of individual articles (measured using the ratio of registered Democrats and Republicans sharing the article on Twitter (13)) is another viable explanation for the co-sharing of mainstream articles, and indeed, we find it also represents a significant difference between co-shared and control articles. Our additional experiments testing the robustness of misinformation narratives as an explanation for the co-sharing phenomenon in the presence of partisan curation are detailed in Appendix B.<sup>24</sup> We find that partisanship and misinformation narratives are two distinct, significant, and complementary factors when explaining the difference between co-shared and control sets of mainstream articles.

## **Case Study**

Our quantitative results show that narratives constitute a statistically significant explanation or factor in the co-sharing of certain mainstream articles in the *aggregate*. In addition, our data and methods can help flesh out how narratives can use a mix of fake and 'real' news, and why and how particular mainstream articles co-shared with fake news can help support misleading narratives. To this end, we now highlight how our work can contribute to the understanding of specific narratives in the media landscape, and *enable* journalists and scholars to help investigate potential cases of synergistic support of misinformation and misleading narratives in mainstream news articles via a comprehensive case study.

In our manual examination of narrative labels or strings (and narratives) present in co-shared articles published by liberal mainstream outlets, we find multiple labels of the form 'vaccinated people spread variant, disease, or virus'.

In this case study:

- We first detail our manual filtering approach to form a set of such aforementioned narrative labels and present the selected narrative labels along with the sentences containing those labels (in order to facilitate the interpretation of the narratives themselves).
- We then provide and examine all the mainstream articles that are published by liberal news outlets and co-shared with fake news that contain these narratives. We identify and qualitatively divide these mainstream articles into three types of articles (in terms of their propensity to be used for misleading purposes). We discuss the types likely to be co-opted for misleading purposes in detail.
- To understand the world of fake news these co-shared mainstream articles are interacting
  with, we show a sample of the vaccine-related fake news articles the aforementioned
  mainstream articles are co-shared with.

- Crucially, to better understand *how* the aforementioned interactions are occurring, we show a sample of tweets authored by conveyors of vaccine-related fake news that shared the identified co-shared articles from liberal-leaning mainstream outlets. This can provide a window into the way some of the 'real' news may be getting used to support misinformation or misleading agendas.
- Finally, we quantify the potential impact of one particular type of co-shared mainstream news: when the headline is framed in a somewhat clickbait manner, which could allow for relatively straightforward repurposing in order to push anti-vaccination misinformation narratives.

**Selecting narratives using the narrative labels.** To study the narratives that might be attributing the spread of disease or virus to vaccines or vaccinated people, we first obtain all narrative strings or labels in co-shared articles by liberal mainstream outlets that contain the strings 'vaccin' and 'spread'. The full set of labels obtained after this step is provided in Appendix C.

We then manually filter them down to coherent narrative labels fitting the type of narrative we are investigating in this case study. These labels (such as 'vaccinate people spread virus') along with the sentences containing them are provided in Tables 5 to 7 and help understand the type of narrative that forms the subject of this case study.

**Examining and classifying mainstream articles published by liberal outlets containing selected narratives.** All articles published by liberal news outlets that are co-shared with fake news and contain narratives displayed in Tables 5 to 7 are provided in Tables 8 to 10. These nine articles, in terms of their propensity to be used for misleading purposes, can be grouped qualitatively into three types:

• Type 1: Headlines that are somewhat clickbait. We find that three out of the nine main-

stream articles seem to contain at least a mild form of clickbait or misleading headlines, via trivialization or simplification that could provide easy support for anti-vaccination misinformation narratives and beliefs.

Headlines carry particular significance in their much wider reach and readership (47, 54) as well as influence on how the article, if read, is interpreted (55–57). When written for the primary purpose of generating clicks rather than to inform, headlines can eschew contexts in ways that can sensationalize via presenting the news item as "more interesting, extraordinary and relevant than might be the case" (58). Clickbait headlines that implement sensationalism have been studied for their propensity to mislead (59–61).<sup>25</sup> A recent study studies the pragmatic implications of news headlines and the effect news headlines have on readers (63), and introduces the Misinfo Reaction Frames (MRF) corpus along with NLP models trained on that corpus. Their findings suggest that what news headlines imply in terms of their pragmatics influences the readers' reactions, and reasoning about the implications of headlines is important for combating misinformation.

In these types of articles that emerge in our case study, for example, a headline such as "Top health expert says vaccinated people are spreading delta variant" (first row in Table 8) can be used to ascribe a causal or unique role to vaccinated people in the spread of the variant as opposed to unvaccinated people (not implicated via omission). Compare the headline with this piece of writing in the article: "...public health experts are encouraging further vaccinations to help curb transmission. Some experts, *however*, warn that vaccinated individuals *may still* be capable of contracting and transmitting COVID-19." (emphasis is ours). The addition of uncertainty (in direct contrast to the headline) as well as the clarity that rather than a unique or causal role, it is the fact that vaccines may

not put a complete stop to transmissions, becomes apparent when reading the article. In this manner, another form of misleadingness present in these types of articles might be the phenomenon of incongruent headlines (64) where the headlines are not necessarily entailed by the contents of the article.

The repurposing of such content by vaccine misinformation conveyors on Twitter is further examined below by looking at the texts of the tweets sharing these articles.

• Type 2: Older news articles in potentially new contexts. These are articles from before the period of our Twitter dataset tweets reporting on particular vaccine failures of the past. As shown in Table 9, we find two such articles, one from mid-2017 and another from 2015 (whereas our Twitter dataset consists of tweets from May 2018 to November 2021). These articles are reporting on the failures of polio and chicken vaccines. In the time period covered by our dataset, COVID-19 was the most salient focus of vaccination discussion.

Sharing older news articles in potentially a new context can be used to mislead, and can be a disinformation tactic, and news organizations have taken steps to highlight their publication date (65). In 2020, Facebook rolled out a feature to notify users when they are sharing articles more than 90 days old.<sup>26</sup> The tweets by vaccine misinformation conveyors sharing these type-2 liberal co-shared articles are discussed below and help understand this kind of temporal repurposing of legitimate reporting.

• Type 3: Other. These are simply the remaining articles, and they do not seem to be easily usable for misleading purposes.

co-shared with one of the identified liberal news articles in Table 11. This helps illustrate the
vaccine-related fake news content the identified mainstream news articles are interacting with on
Twitter and helps emphasize the importance of studying misinformation-adjacent mainstream
news.

**Examining** *how* **mainstream news articles might be getting used for misleading purposes by considering the tweet texts.** For type 1 (articles with somewhat clickbait-y headlines) and type 2 (older articles potentially shared in new contexts) liberal outlet articles identified above, we look at tweet texts sharing those particular articles by conveyors of vaccine-related fake news. This helps us understand how these articles might be getting used to support misleading narratives.

We first consider all fake news articles in our dataset for which we have automatically extracted headlines. We obtain all fake news articles with the string 'vaccin' in their (lowercased) headline, which results in 429 vaccine-related fake news. We filter our entire Twitter panel data to tweets by users who shared vaccine-related fake news five or more times, resulting in 1074 different Twitter users. For each type 1 and type 2 mainstream article, we obtain all unique tweet texts that share those articles by this subset of vaccine-misinformation-sharing Twitter

A sample of up to five tweet texts is provided alongside the mainstream article in Table 12, and highlights how these various articles can be used to buttress anti-vaccine misinformation narratives. We also present all the unique tweet texts from which the tweets presented in Table 12 are randomly sampled, in Appendix D.

Impact of framing choices in mainstream articles: disproportionate uptake amongst conveyors of misinformation. We take a closer look at the three type-1 mainstream articles (Table 8), where the framing choices in the headlines seem to facilitate repurposing those articles towards the push for certain misleading narratives by conveyors of vaccine misinformation on Twitter (Table 12). A consequence of those framing choices is those articles being co-shared with fake news. We further find that those particular articles by the three mainstream outlets (The Hill, Business Insider, and The Washington Post) are some of their most popular vaccine-related articles among vaccine-misinformation-sharers relative to all the vaccine reporting done by those outlets (per the URLs shared in our Twitter panel between May 2018 and November 2021). For example, out of all the 444 vaccine-related articles published by The Washington Post in our final dataset, the particular co-shared article with the headline 'CDC study shows three-fourths of people infected in Massachusetts coronavirus outbreak were vaccinated but few required hospitalization' was the  $2^{nd}$  highest in terms of shares amongst the subset of Twitter users known to share vaccine-related fake news (identified using the procedure discussed above).  $2^{nd}$ 

We also create a subset of Twitter users in our dataset that a) did not share any fake news article in our entire dataset, and b) shared vaccine-related articles from liberal mainstream outlets at least five times. For all three articles, we compare the popularity (in terms of number of shares) of the article amongst the vaccine fake news sharers and vaccine 'real' news sharers,

relative to all vaccine-related articles published by that corresponding outlet. We find that these articles got significantly higher attention (in terms of Twitter sharing) amongst vaccine-related fake news conveyors, providing a clear measure of the impact of the framing choices made in the mainstream articles and the disproportionate uptake in misinformation circles on Twitter. Details of our procedure and significance testing are provided in Appendix E.

#### **Discussion and Related Work**

Consistent with our hypothesis, we find that a significantly higher presence of misinformation narratives is associated with disproportionate uptake of mainstream news articles by conveyors of fake news on Twitter. This effect — significantly higher misinformation narratives in mainstream news that are co-shared with fake news — is not explained away by partisan curation, *i.e.*, it is not just a case of news of a particular partisan leaning being popular in fake-news-circles on Twitter when it comes to misinformation narratives pulling together different kinds of sources. Our finding suggests that mainstream news is part of how misinformation narratives are pushed on social media and that it might be used to enhance the reach and persuasiveness of misleading narratives.

To the extent that this hypothesis is true, it has important implications for responsible journalistic practice: when vetting news stories and their framing, especially for the headlines, it is important to consider not just the story itself but also the broader context of existing narratives in fake news. Technological methods like the ones we have developed and used here may help go beyond checking a story's factuality and accuracy and contribute to minimizing the risk of a story containing misinformation narratives and being co-opted by conveyors of fake news on social media.

For scientific research on online misinformation, our work highlights the importance of looking at not just falsehoods in fake news, but the larger narratives and world views being

fleshed out — and examining the role of communicative choices (in the form of existing misinformation narratives) made in mainstream news (that would generally not be deemed fake or factually incorrect). Indeed, a recent study posits that focusing on misinformation leads to misunderstanding the presence of misleading information and widespread occurrence of misperceptions despite the fact that fake news itself, as we mentioned earlier, is a very tiny part of people's media consumption (66). Instead, the study (66) suggests that a better framework for understanding the apparent problems with the online information ecosystem is the synthesis of motivated reasoning and the (new) concept of a marketplace of rationalizations. In brief, sometimes, humans are motivated to believe things out of various forms of desirability (due to emotional, social, or material benefit) rather than accuracy, but there is also a constraint to present the belief in a manner that appears objective and rational. Authors and institutions can serve to offer rationalizations for a variety of beliefs and worldviews (constituting a market-place). Fake news can be seen as part of such material that provides rationalizations for some pre-existing beliefs.

Building upon this theory, we consider it plausible that the narratives present in fake news content (such as "vaccines harm people") can signal the world views and beliefs for which that particular piece of content provides rationalizations. Articles by mainstream outlets that are co-shared with fake news (such as the WAPO article highlighted in Fig. 1 originally titled "Vaccinated people now make up a majority of covid deaths") might become a part of the rationalization process for misperceptions and misleading narratives or beliefs. Our case study suggests as much, with tweets such as "Well look what the CDC is saying today .... It's the vaccinated spreading covid." sharing the article https://www.businessinsider.com/cdc-fully-vaccinated-people-can-spread-delta-variant-2021-7 with the headline "CDC says fully vaccinated people spread the Delta variant and should wear masks: "This new science is worrisome'." The same misleading narrative can now be rationalized using a combination of different infor-

mation sources (fake news, mainstream news, cross-partisan outlets). This accords with our finding that the presence of existing misinformation narratives characterizes the particular articles from mainstream outlets co-shared with fake news.

Very few users share articles from known fake news outlets (5, 67). One prior work suggests that one possible reason is the potential harm to online social reputation as a result of sharing content from outlets not granted mainstream legitimacy (67). Sharing mainstream content containing misleading narratives and beliefs present in fake news could provide a way to circumvent those potential reputational harms while still sharing those narratives.

The presence of existing misinformation narratives in the mainstream media landscape also hints at the potential agenda-setting power of fake news. For example, one prior work studied how fake news content both responds to and influences the agenda in more mainstream partisan media (68), and found that especially in 2016, fake news may have driven the agenda for partisan media in the US, while findings in another study (69) suggest that mainstream news outlets are sometimes responsible for disseminating and popularizing particular fake news stories (even more than social media). Another prior work then further studied *how* the interaction between fake news outlets and mainstream media takes place (70). Their findings suggest that fake news outlets might be utilizing the sensationalism *already* present in the mainstream media environment and "add noise" to that, instead of directly setting the agenda for news outlets. This latter study, concordant with our work, once again confirms the responsibility and need for structural action in the mainstream journalism landscape itself rather than confining the problem of misinformation to a certain set of identified 'bad actors' in the form of specific fake news outlets.

Related to our work and findings, recent work has investigated COVID-19 vaccination misinformation narratives on social media (whereas we look at the content of news articles) (14).<sup>29</sup>

The narratives they found in social media communities are similar to ones we extracted from fake news content and fact-checked false claims (which do include claims from social media): narratives questioning vaccine safety and effectiveness. Interestingly, this study noted the "distortion of facts due to misleading rather than outright false narratives" such as exaggeration of side-effects and recontextualization (14). This mirrors our findings in terms of observed extracted narratives, the co-shared fake and mainstream news content, and the indication of strategic repurposing of mainstream news content on social media (which can help support efforts to recontextualize legitimate reporting). The latter indication of repurposing and possibly taking advantage of how headlines and mainstream story content are framed is backed by the findings of our case study.

#### **Limitations and Future Work**

For our quantitative results in this study, we examine the content of articles, but for tweets, we only considered the articles shared and not the text generated by the user. Our findings, the aforementioned concept of rationalizations, and our case study all suggest that future work should also look at the *content of tweets* sharing news articles, robustly identify misinformation sharers, and study *how* mainstream news articles get repurposed to support pre-existing misperceptions via the potential choices made in tweet texts (while maintaining an understanding of the larger media ecosystem that enables such repurposing). Examining tweets can also help verify what our findings indicate: mainstream outlets might be used to grant an air of legitimacy to certain narratives. Such an examination can help analyze the instances where mainstream news content itself misleads *directly* and instances where mainstream news tends to *enable* misleading usage by users on Twitter.

Another subject of future analysis would be examining where and how misinformation narratives occur in mainstream news stories. One possibility is that these narratives do not occur

in the content written by the journalist or news reporter themselves, but in *direct quotations*: content attributed to a different actor or source replicated and used verbatim in a text. Such direct quotations are marked clearly using quotation markers (such as "...") in texts (71). We aggressively removed instances of direct quotations from co-shared and control articles in a preliminary analysis (aiming for recall), and find that our hypothesis holds when working with this modified content. Therefore, the significantly higher presence of these misinformation narratives in co-shared articles does not seem to be driven by the practice of direct quotations in media alone. Overall, our effect holds for these newly processed texts with direct quotations removed in 16/18 significance testing instances corresponding to rows in Table 3. We report our preliminary analysis including the procedure to remove direct quotations and detailed results in Appendix F to help inform future work, and the procedure to remove direct quotations will also be provided as part of our codebase.

In any case, future work should examine if the practice of direct quotations (and the possible presence of misleading narratives in those quotes) necessarily abdicates the responsibility of journalists. Direct quotations still constitute journalistic choice; indeed, one prior work argues that journalistic quotation (direct or indirect), is a 'highly interpretive compositional activity', making it a subjective part of creating a news story (72). Direct quotations can constitute a *shift* in responsibility to the source as well as a shift in the interpretation or attitude towards the quoted content as not a part of the factual reporting of events (73, 74). However, even if this is the case, it is possible that in the context of strategic repurposing of mainstream news, misinformation conveyors, as well as their audience, might be able to ignore this shift.

Future work can also examine the effect of indirect quotation, where quotation markers are not used and instead, quotes are presented using reporting verbs such as 'said' ('they *said* that ... *quoted text* ...'). Such an investigation can help further understand the distribution of where misinformation narratives in mainstream media occur — when citing a source verbatim, or in

original writing by the author of the news article.

Our work uses one particular way to categorize outlets as fake news, aiming for precision (see the Background and Definitions section). Future work can also experiment with a broader set of unreliable content (aiming for recall) and identify cases where content of established reliability and unreliability are used together.

We hope that the future release of our data, code, and modeling outputs will help enable the investigation of other hypotheses of synergy between certain unreliable and reliable content on social media. This interaction, operationalized by our co-sharing method, can be a valuable tool to help answer different kinds of questions in media studies and sociopolitical information sciences.

By scoring individual news articles for their co-sharing likelihood, our work can also help inspire alternatives to the dominant research paradigm that uses domain-level reliability ratings and tends to treat all individual articles published by the same outlet in the same manner. We note that we also treat articles published by *fake* news outlets in that manner, but we consider each different individual story published by *mainstream* outlets to identify cases of misinformation adjacency.

Our codebase will provide automatically extracted narrative labels and the original raw text data they were extracted from. We encourage user studies and human evaluation to further refine the set of misinformation narratives we introduce in this study in order to make a clearer set of misinformation narratives. This can help answer specific research questions, and conduct additional case studies and investigations of specific misinformation narratives in future research. In Appendix G, we provide *all* the high-dimensional narratives automatically extracted from the texts of fact-checked false claims and used in the comparison of their presence in co-shared and control mainstream articles (for the results reported in Table 3).<sup>30</sup>

We note that for comparing the presence of each misinformation narrative label in sets of narrative labels derived from the content of co-shared and control articles, this work uses *exact* matching, which, while being reliably precise, can sometimes miss cases of similar narratives that should also be matched such as 'vaccine injure people' and 'vaccine harm people'. While the narrative extraction method clusters terms and phrases using distributional word embeddings, fuzzier matching on obtained labels as an additional step can help ensure that surface-level stylistic differences in the writing of fake news and mainstream news do not hamper the discovery of existing misinformation narratives and false belief propagation in mainstream media. Another smaller future step to control for cases missed by an exact match would be to first lemmatize the terms in all narrative strings or labels, and then conduct our procedure to test our hypothesis.

Finally, we note that contending with other explanations can help flesh out the relative role of misinformation narratives and also serve as robustness checks for our work. In this work, we already accounted for the effect of partisan curation of news articles (Appendix B). However, other possible distinctions between the co-shared set of articles and our control group can be the relative presence of certain entities, or even interest in specific topics that may dominate the fake news world and co-shared mainstream articles. Conducting our hypothesis tests within subsets of articles based on the topic or theme in the news content, and also subsets defined by the presence of prominent entities, constitute interesting directions for future research enabled by our processed dataset.

## **Potential Broader Impact**

This work helps raise general, scientific, and journalistic awareness of looking beyond false claims and statements in fake news content, and critically examining the narratives and larger narrative labels that did not occur in both co-shared and control groups are removed before significance testing.

world views being presented along with the beliefs those falsehoods may support. This helps shed light on how factually correct information might also get repurposed and used to push certain misleading narratives. We direct the reader again to our illustrative example in Fig. 1, where the WAPO story content itself makes it clear that since the vast majority of the US population is vaccinated, vaccinated people making up a majority of covid deaths is firmly in line with basic mathematical expectation. However, the original headline (that has since been changed) is ripe for misuse by social media users pushing misleading anti-vaccine narratives (even when the headline is still factually accurate); indeed, our analysis confirms the disproportionate uptake of that article by a number of users known to share fake news regarding vaccines.<sup>31</sup> Our case study highlights multiple such examples.

Technology building off of our work can help journalists identify if their content contains existing misinformation narratives and the likelihood their article might get co-opted by conveyors of fake news on social media. Journalists committed to the rigor of their reporting and how their content might get used or misused can adjust their framing accordingly before publishing. This can help reduce the chances of mainstream news articles potentially legitimizing world views based on false or unsubstantiated claims.

We acknowledge that general awareness of our findings could also encourage fake-news conveyors online to more actively seek and share select mainstream articles in support of false claims. However, our study demonstrates that this is already happening and we argue that raising journalistic awareness of this issue in mainstream media is important, as is providing journalists with new tools.

However, there is a potential negative dual-use scenario for the aforementioned new technology — in identifying or scoring mainstream articles for their likelihood of getting co-opted

by sharers of fake news, the users who *want* to popularize misinformation narratives could also more readily identify the mainstream articles they can use for their goals. In order to mitigate this, it is important that mainstream articles that contain misinformation narratives be reduced, *i.e.*, for the benefit of our technology and findings to be realized quickly through usage in mainstream reporting. We aim to directly convey our findings and recommendations to journalists and facilitate quick uptake of our work and its implications for information sources and platforms committed to the legitimacy of their reporting and content.

### **Appendix**

# A Distribution of Article Counts per Outlet in Co-shared & Control Group




Figure 4: We plot the number of articles in co-shared and control groups against the political partisanship score of the outlet (derived from party affiliation of the Twitter audience sharing political content from the outlets by prior work (13)).

When considering all reliable outlets (Fig. 4a) and only trustworthy outlets (Fig. 4b), right-leaning outlets are over-represented in the co-shared group (in terms of the number of articles), even when both groups of articles (co-shared and control) always consist of articles published by the same set of outlets. This ideological skew is not present in our third condition of only considering liberal outlets (Fig. 4c). Political scores for outlets use annotations created in prior work (13), as described in the Background and Definitions section (see criteria number three for mainstream media).

### **B** Partisanship Explanation Analysis: Procedure and Results

Based on article-level ideological or partisanship scores derived from the relative number of Democrats and Republicans sharing the article in the Twitter panel dataset (where voter registration data is linked with the user tweets; details provided in prior work (43, 44)), we find that the co-shared set of mainstream articles is significantly more conservative (or significantly more popular among Republicans) compared with the control group of mainstream articles (independent t-test, p <<< 0.05). Partisan curation thus presents itself as another viable explanation, and we examine the effect of misinformation narratives in the presence of partisan curation as a competing, but potentially complementary, explanation in various ways outlined below.

Repeating our main experiment with a Republicans- or conservatives-only Twitter panel.

We create a subset of our Twitter data to only contain tweets by registered Republicans, and then repeat our entire experiment – creating the URL-to-URL graph, finding co-shared and control

misinformation content in co-shared versus control texts.

The results are presented in Table 13. We find that while the number of cases where there is a significant difference between the two groups of mainstream articles is reduced, it nevertheless remains a significant factor in many cases, especially when considering mainstream articles published by trustworthy outlets.

We, therefore, compare the two explanations in a regression setup to see if misinformation narratives constitute a significant factor in distinguishing co-shared and control groups (for articles shared in our entire Twitter data), as well as what value addition (in terms of modelfit) might misinformation narratives provide over-and-above the partisan curation, *i.e.*, is partisanship alone enough and subsumes the narrative-based explanations, or are the two distinct, complementary factors?

Regression experiment using both partisanship and narrative-based factors. With every instance being a mainstream article, we set up a logistic regression expression where the dependent variable (y) is a binary indicator of being a co-shared or control article. In our main logistic regression setup, one independent variable  $(X_1 \text{ or } X_{\text{partisanship}})$  is the partisanship score of the article (the relative sharing by Republicans and Democrats as mentioned above). We combine all recurring narratives in fake news and all narratives in false fact-checked claims as our misinformation narrative set, and then count the number of narratives in the mainstream article that are also present in the misinformation narrative set. This count forms the second independent variable  $(X_2 \text{ or } X_{\text{misinfo-narrative}})$ .

Partisanship being a significant explanation is something we expect, but our results in Table 14 show that misinformation narratives offer another significant explanation. We also check if these two independent variables are co-linear, by conducting a multicollinearity test based on the variance inflation factor (VIF) test (75, 76). We find that for these two variables, the VIF is 1.013826, which indicates that these two factors are not co-linear or only slightly co-linear (76). The Spearman correlation value is also low (r = 0.1).

All of this suggests that partisanship and misinformation narrative presence in mainstream

articles are two significant and complementary factors for distinguishing between co-shared and control mainstream articles, and partisanship as a factor does not explain away misinformation narratives as an explanatory factor.

Using information theory to quantify the explanation value provided by the misinformation narratives factor. Finally, we investigate whether having misinformation narratives as a factor offers significant additional explanatory value (towards distinguishing co-shared and control mainstream articles) above and beyond what partisanship already offers. Apart from the full regression model ( $y \sim X_{\text{partisanship}} + X_{\text{misinfo.narrative}}$ ), we also run a partisanship-only model ( $y \sim X_{\text{partisanship}}$ ), and compare the model fit in the two cases using the Akaike information criterion or AIC (78–80). Based on our AIC-based model selection results shown in Table 15 and the rule-of-thumb provided in prior work (80), it is clear that considering only partisanship is a significantly weaker model and considering both factors carries the 100% of explanatory or predictive power as compared to considering just the partisanship factor in our logistic regression setup. That is, considering both factors is significantly better every time for modeling

co-sharing versus control than considering just partisanship as a factor.

## E Case Study Details: Measuring the Impact of Type-1 Mainstream Articles in Terms of Uptake amongst Vaccine Misinformation Sharers

By detecting if the string 'vaccin' is present in the (lowercased) headline, we find that in our final dataset of  $\sim 420,000$  news articles, there are 67 vaccine-related articles published by The Hill, 47 vaccine-related articles published by Business Insider, and 444 vaccine-related articles published by The Washington Post. We found the rank of the particular three type-1 articles (one from each of these outlets; Table 8) in terms of shares on Twitter amongst users who shared vaccine-related misinformation, and those who shared vaccine-related 'real' news (but never shared any fake news article; see the last paragraph in the Case Study section).

Using a simple normal test for proportions (proportions z test), we find that for each of the three articles, they are significantly more popular relative to all vaccine-related articles published by the corresponding outlet among the vaccine misinformation sharers (p <<< 0.05).

### F Direct Quotation Analysis: Procedure and Results

Based on prior work (71) and some of the quotation markers present in our own dataset, we use the following markers to filter out sentences:

We note that ':' is included since many headlines report a direct quote as "source name: quoted text."

We use the NLTK library (81) to split the texts into sentences, and the sentences into tokens. In order to test our function for filtering out sentences containing direct quotations, we get two different random samples of 25 news articles. We manually annotate the sentences expected to be removed via our simple marker-based filtering (ground truth). Then we run our function to

automatically filter or remove the sentences, and compare them to the ground truth.

After a couple of iterations on the first random sample as a training set, we test our function on the held-out sample of 25 full article texts. Our function achieves 0.985 recall and 0.564 precision — it misses just one edge case. This is exactly what we optimized for, a very aggressive or recall-oriented function for filtering out sentences containing direct quotes.

We then use this to create filtered versions of co-shared and control group of texts, and reconduct our significance tests and find that our hypothesis holds in 16 out of 18 cases (Table 17)

as opposed to 17 out of 18 cases with original, non-filtered texts (Table 3).

# G Automatically Extracted Narratives from False Fact-checked Claims

In Tables 18 to 38, we show all high-dimensional narratives automatically extracted from false claims texts and used to test our hypothesis (n=318, see Table 3). Recall that we tested if misinformation narratives have a significantly higher presence in co-shared articles using the one-sided Wilcoxon-signed rank test (non-parametric significance test for comparing paired or dependent data) (51,52), and that before this test is performed, any occurrences (using counts of narrative labels in co-shared and control) of ties and zeros were removed (53).
