# Local Recovery of Two-layer Neural Networks at Overparameterization

#### Abstract

Under mild assumptions, we investigate the structure of loss landscape of two-layer neural networks near global minima, determine the set of parameters which recovers the target function, and characterize the gradient flows around it. With novel techniques, our work uncovers some simple aspects of the complicated loss landscape and reveals how model, target function, samples and initialization affect the training dynamics differently. These results concludes that two-layer neural networks can be recovered locally at overparameterization.

## 1 Introduction

Over the past decade, neural networks-a distinct class of nonlinear models-have transformed the landscape of artificial intelligence. However, the mathematical underpinnings that set them apart from other models are not well comprehended. Deciphering these structures poses a daunting but essential challenge for the field of mathematics. Among the various aspects of neural networks, the loss landscape is obviously important in shaping their training dynamics and generalization capabilities $[6,12]$. Of particular interest is the geometry of the global minima, which lies at the heart of a fundamental enigma: how neural networks are able to find well-generalizing solutions via global training from an ostensibly infinite pool of global minima-a majority of which do not generalize well-especially when the network is overparameterized $[14,2]$.

In our research, we propose and address the local recovery problem for two-layer neural networks. To be precise, we uncover an important geometrical structure of global minima for two-layer neural networks that the branches of the perfect global minima, i.e., the sets that recover the target function, can become separated from other global minima at overparameterization. This separation geometry guarantees local recovery capability of the target function and surely reduces the difficulty in finding well-generalizing solutions globally via gradient dynamics. In particular, we explicitly characterize the branching geometry of perfect global minima and show that its branches are successively separated from the imperfect global minima as the training sample size increases. This branching structure and the successive separation are inherent to the family of neural network models. Beyond the geometry, we further establish and quantify the convergence of the gradient flow dynamics near the global minima, particularly in the vicinity of the perfect global minima.

Our work demonstrates the profound impact of the fine geometry of global minima to the generalization of neural networks. In traditional machine learning problems, the global minima usually have trivial geometry, e.g., isolated points, rendering generalization a separate issue from loss landscape analysis [12]. However, for neural networks, in particular at overparameterization, we showcase the importance of analyzing the geometry of the well-generalizing set, e.g., the perfect global minima, amid the global minima of loss landscape for the understanding of generalization. Our view of the global minima that particularly highlights the structure of the perfect global minima as the backbone and its generalization consequence is a significant refinement over the view suggested by Cooper [5] which focuses on the overall geometry of the global minima. We hope our work could convince the audiences in mathematics that the global minima, or more broadly the loss landscape, of neural networks possess rich geometric structures that are amenable to analysis, mathematically interesting, intrinsic to the model architecture, and undoubtedly plays a fundamental role to their exceptional training and generalization performance.

Technically speaking, the study of global minima in the loss landscape presents two fundamental issues. The first issue is the linear independence of neurons (and their derivatives). It determines geometric structures of the loss landscape, such as dimensions of global minima. Previous works address the linear independence of neurons for the analysis of critical points [11, 12]. In our work, to understand when perfect global minima are separated from the imperfect ones, we establish
the linear independence of neurons and their derivatives. The second issue is that neural network architecture yields highly degenerate Hessian of loss at a global minimum. The loss may fail to be Morse functions, or even generalized Morse-Bott functions, thus beyond the reach of traditional methods. We devise methods for addressing gradient flow dynamics in the vicinity of degenerate critical points, which are indispensable to the analysis of neural networks. This outcome broadens the scope of most existing research that primarily focuses on gradient flow dynamics near critical points of Morse and generalized Morse-Bott functions. Furthermore, our investigations into the dynamics around global minima have yielded unprecedented results in terms of convergence rates and directions.

Specifically, we start by presenting the main results of this paper in an illustrative (but informal) way in Section 2. In Section 3, we prove lemmas and propositions which will be used to derive these main results. Importantly, we investigate the linear independence of neurons (and their partial derivatives against parameters) and then define "separating inputs" (Definition 3.1). The next section, Section 4 gives a detailed treatment of the geometry of global minima and the functional properties of loss near the perfect global minima of it. These help us to characterize the gradient flow near the perfect global minima in Section 5, where the convergence, convergence rate, limiting direction and generalization stability (Definition 5.1) of such gradient flows are investigated. Finally, we make conclusion and discussion of our work in Section 6.

The following diagram summarizes and demonstrates the interconnections of theoretical results in the main part of our paper (Section 3, 4, 5).


Figure 1: Overview of theoretical results and their interconnections. The main parts are in dark pink boxes, the basic theories are in green boxes and the other results are in yellow boxes.

## 2 A Glance at this Paper

### 2.1 Notations and Assumptions

In this section, we make clear the notations and assumptions which we shall use throughout the paper, unless we specify it explicitly. Let $\mathbb{N}$ denote the set of natural numbers $\{1,2,3, \ldots\}$. For any two elements $x, y$ of a Hilbert space, we use $x \cdot y$ and $\langle x, y\rangle$ (interchangeably) to indicate the inner product of $x$ and $y$. For any function $f, \nabla f$ is the gradient of $f$ and Hess $f$ the Hessian of $f$
(given that either one exists). Given a subset $E$ of a Hilbert space, we denote its closure (in the Euclidean space) by $\bar{E}$, and we say $E$ has $\lambda_{k}$-measure zero if the $k$-dimension Lebesgue measure of it is well-defined and is zero. We use $B(\theta, r)$ to denote the open ball centered at $\theta$ with radius $r$; when the $B(\theta, r)$ is in a Euclidean space, it is the open ball with respect to the standard norm.

Then we make assumptions on the objects we study, starting from the activations. Indeed, different kinds of activations give different loss landscape geometry. In our paper, we focus on a generic collection of analytic activations, which turns out to give a reasonable linear independence result: given $m \in \mathbb{N}$ and distinct $w_{1}, \ldots, w_{m} \in \mathbb{R}^{d}, \sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{m} \cdot x\right)$ are linearly independent. This will then give the "simplest possible" structure of global minima of loss function. See Section 3.4 .

Assumption 2.1 (generic (analytic) activation). We consider any analytic activation $\sigma: \mathbb{R} \rightarrow \mathbb{R}$ such that

$$
\begin{equation*}
\sigma(x)=\sum_{j=0}^{\infty} c_{j} x^{j}, \quad x \in(-R, R) \subseteq \mathbb{R} \tag{1}
\end{equation*}
$$

where $R$ is the radius of convergence, $c_{0} \neq 0$, and for any $N \in \mathbb{N}$ there are some odd number $j_{\text {odd }}$ and even number $j_{\text {even }}$ both greater than $N$ with $c_{j_{\text {odd }}} \neq 0, c_{j_{\text {even }}} \neq 0$. We call any such $\sigma$ a generic activation.

For example, the exponential activation $\exp (x)$ satisfies these requirements, while some other commonly-seen activation functions, including $\sigma(x)=\frac{1}{1+e^{x}}, \sigma(x)=\tanh (x)=\frac{e^{x}-e^{-x}}{e^{x}+e^{-x}}$ and $\sigma(x)=\log \left(1+e^{-x}\right)$ do not satisfy this assumption. However, almost any horizontal translation of them is a generic activation: given a non-polynomial analytic activation $\sigma$, for almost all $\varepsilon>0$ the function $x \mapsto \sigma(x+\varepsilon)$ satisfies Assumption 2.1.

The motivation of defining such activations is that any set of neurons constructed from generic activations preserves the number of first-layer features, i.e., the weights. Thus, the neurons are "good feature-maps" as they preserve the information from the input-layer. Mathematically, we will show that whenever $w_{1}, \ldots, w_{r} \in \mathbb{R}^{d}$ are distinct, $\sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right)$ are linearly independent, for any $r \in \mathbb{N}$. This will be proved in Proposition 3.1, when $\sigma$ is a generic activation. We shall also see that Assumption 2.1 (i.e., $\sigma$ is a generic activation) is a necessary condition for it.

Having made assumptions on our activation function, we turn to the set-up of the network training - the model, target function, and loss. In this paper, we focus on training a two-layer neural network

$$
g: \mathbb{R}^{(d+1) m} \times \mathbb{R}^{d} \rightarrow \mathbb{R}, \quad g(\theta, x)=\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x\right),
$$

Here $m \in \mathbb{N}$ is fixed, which is often called the width of $g, x \in \mathbb{R}^{d}$ is the input of $g$, and the parameter $\theta$ of $g$ is in $\mathbb{R}^{(d+1) m}$ : for a parameter we have several notations

$$
\begin{aligned}
\mathbb{R}^{(d+1) m} \ni \theta & =\left(a_{1}, w_{1}, \ldots, a_{m}, w_{m}\right)=\left(a_{k}, w_{k}\right)_{k=1}^{m} \in \prod_{k=1}^{m}\left(\mathbb{R} \times \mathbb{R}^{d}\right) ; \\
\theta^{*} & =\left(a_{1}^{*}, w_{1}^{*}, \ldots, a_{m}^{*}, w_{m}^{*}\right)=\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} ; \\
\theta_{i}^{j} & =\left(\left(a_{1}\right)_{i}^{j},\left(w_{1}\right)_{i}^{j}, \ldots,\left(a_{m}\right)_{i}^{j},\left(w_{m}\right)_{i}^{j}\right)=\left(\left(a_{k}\right)_{i}^{j},\left(w_{k}\right)_{i}^{j}\right)_{k=1}^{m} .
\end{aligned}
$$

Throughout this paper, $i$ and $j$ are arbitrary indices to distinguish points in parameter space $\mathbb{R}^{(d+1) m}$.

Next, we make clear about the models and target functions we consider in the paper. Starting from an abstract sense, we define our model as a function $g: X \times \mathbb{R}^{d} \rightarrow \mathbb{R}$. Here $X$ is any topological space which we call the parameter space of $g$, i.e., $\theta \in X$ is called a parameter, and any $x \in \mathbb{R}^{d}$ ( $d \in \mathbb{N}$ given) is an input of $g$. The collection of all such models is defined as $\mathcal{G}:=\left\{g: X \times \mathbb{R}^{d} \rightarrow \mathbb{R}\right\}$. A particularly interesting case is

$$
X=\coprod_{m=1}^{\infty} \mathbb{R}^{(d+1) m}=: \coprod_{m=1}^{\infty}\left\{\left(a_{k}, w_{k}\right)_{k=1}^{m}: a_{k} \in \mathbb{R}, w_{k} \in \mathbb{R}^{d}\right\}
$$

endowed with the Euclidean topologies from each $\mathbb{R}^{(d+1) m}$, and $g(\theta, x)=\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x\right)$ for $\theta \in \mathbb{R}^{(d+1) m}, x \in \mathbb{R}^{d}$. Then our $\mathcal{G}$ is just the collection of all two-layer NNs (of finite width) with activation $\sigma$. Notice that $\mathbb{R}^{(d+1) m}$ embeds naturally into $\mathbb{R}^{(d+1) m^{\prime}}$ for $m \leq m^{\prime}$. So we can further define

$$
\mathcal{G}_{m}:=\left\{g(\theta, x)=\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x\right): \theta \in \mathbb{R}^{(d+1) m}\right\} \quad \forall m \in \mathbb{N},
$$

and write $\mathcal{G}_{m} \subseteq \mathcal{G}_{m^{\prime}}$ for $m \leq m^{\prime}$.
Once given $\mathcal{G}$, we assume that our target function $f$ is simply an element in it. Notice that when $X=\coprod_{m=1}^{\infty} \mathbb{R}^{(d+1) m}$ and $g(\theta, x)$ defined as above, $f$ is just a two-layer neural network with width $m_{0} \in \mathbb{N}$, for some $m_{0} \in \mathbb{N}$. This is a natural setting, as the universal approximation theorem holds (for many commonly seen $\sigma$ ) on any compact subset of $\mathbb{R}^{d}[9,10,11]$. It is also clear that for any $m \geq m_{0}$ we have

$$
f^{*} \in \mathcal{G}_{m} \subseteq \mathcal{G} .
$$

In the theory of neural network, this can be interpreted as: an NN model with no fewer features than the target function can fit it perfectly. This is the setting we consider in this paper.

Assumption 2.2 (finite-feature setting). Given a generic activation $\sigma$ and $m, m_{0} \in \mathbb{N}$ with $m \geq$ $m_{0}$, we consider a target function

$$
f^{*}(x)=\sum_{k=1}^{m_{0}} \bar{a}_{k} \sigma\left(\bar{w}_{k} \cdot x\right),
$$

where each $\bar{a}_{k} \in \mathbb{R} \backslash\{0\}$ and $\bar{w}_{k} \in \mathbb{R}^{d}$ and $\bar{w}_{k} \neq \bar{w}_{j}$ whenever $k \neq j$. The collection of two-layer NN models we consider is $\mathcal{G}_{m} \subseteq \mathcal{G}$.

Now we define our loss function as the usual empirical $L^{2}$ loss:

$$
R: \mathbb{R}^{(d+1) m} \rightarrow \mathbb{R}, R(\theta)=\int_{\mathbb{R}^{d}}\left|g(\theta, x)-f^{*}(x)\right|^{2} d \mu(x),
$$

the measure $\mu$ being a Borel measure on $\mathbb{R}^{d}$. Throughout the paper we are interested in Dirac masses $\mu=\sum_{i=1}^{n} \delta\left(\cdot-x_{i}\right)$ for distinct $x_{i} \in \mathbb{R}^{d}, 1 \leq i \leq n$; the $x_{i}$ 's and $\left(x_{i}, f^{*}\left(x_{i}\right)\right.$ )'s are both called samples, we do not distinguish them. In this case we have

$$
\begin{equation*}
R(\theta)=\sum_{i=1}^{n}\left|g\left(\theta, x_{i}\right)-f^{*}\left(x_{i}\right)\right|^{2}=\sum_{i=1}^{n}\left|\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x_{i}\right)-\sum_{k=1}^{m_{0}} \bar{a}_{k} \sigma\left(\bar{w}_{k} \cdot x_{i}\right)\right|^{2} . \tag{2}
\end{equation*}
$$

Remark 2.1. Some remarks on the loss function $R$.
(a) As we mentioned above, $f^{*} \in \mathcal{G}_{m_{0}}$, whence there is some $\theta \in \mathbb{R}^{(d+1) m}$ such that $g(\theta, \cdot)=f^{*}$. We define the perfect global minima

$$
\begin{equation*}
Q^{*}:=\left\{\theta \in \mathbb{R}^{(d+1) m}: g(\theta, \cdot)=f^{*}\right\} . \tag{3}
\end{equation*}
$$

Clearly $Q^{*} \subseteq R^{-1}\{0\}$. We may also say $R^{-1}\{0\} \backslash Q^{*}$ imperfect global minima.
(b) When $\mu=\sum_{i=1}^{n} \delta\left(\cdot-x_{i}\right)$ with $n \leq(d+1) m$, we say the model (or more generally, the system) is overparametrized, otherwise it is called underparametrized. Similarly, when $\mu=\rho d x$ for some continuous function $\rho: \mathbb{R}^{d} \rightarrow(0,+\infty)$, the model is underparametrized.
Unlike traditional machine learning, in many NN trainings the models are overparametrized; this is one difficulty in the analysis of them.
Finally, given $\theta_{0}=\left(\left(a_{k}\right)_{0},\left(w_{k}\right)_{0}\right)_{k=1}^{m} \in \mathbb{R}^{(d+1) m}$, the gradient flow $\gamma=\left(a_{k}, w_{k}\right)_{k=1}^{m}:[0,+\infty) \rightarrow$ $\mathbb{R}^{(d+1) m}$ with initial value $\theta_{0}$ is defined as

$$
\dot{\gamma}(t)=\left(\dot{a}_{k}(t), \dot{w}_{k}(t)\right)_{k=1}^{m}=-\nabla R(\gamma(t)), \quad \gamma(0)=\theta_{0} .
$$

In particular, when $R$ has the form in equation (2), we have for $k=1, \ldots, m$

$$
\begin{aligned}
& \dot{a}_{k}(t)=-\frac{\partial R}{\partial a_{k}}(\gamma(t))=2 \sum_{i=1}^{n}\left(g\left(\gamma(t), x_{i}\right)-f^{*}\left(x_{i}\right)\right) \sigma\left(w_{k}(t) \cdot x_{i}\right), \\
& \dot{w}_{k}(t)=-\frac{\partial R}{\partial w_{k}}(\gamma(t))=2 a_{k}(t) \sum_{i=1}^{n}\left(g\left(\gamma(t), x_{i}\right)-f^{*}\left(x_{i}\right)\right) \sigma^{\prime}\left(w_{k}(t) \cdot x_{i}\right) x_{i} .
\end{aligned}
$$

### 2.2 Local Recovery Problem

In this paper, we propose the concept of the local recovery problem in the context of neural networks at overparametrization. This problem refers to the challenge of ensuring that a neural network can perfectly recover the target function, i.e., with zero generalization error, in a local region of its parameter space. The local recovery problem arises due to the complex and non-convex nature of the loss landscape in neural networks, where infinitely many global minima exist and form complex patterns.

The key aspects of the local recovery problem include:
(a) Geometrical structure: As we investigate the recovery of our target function, we are particularly interested in the geometry of global minima and the relation between sample size and global minima geometry.
(b) Separation of minima: In overparameterized neural networks, the possibility that perfect global minima, i.e., those that accurately recover the target function, can become separated from other global minima. This ensures our model to recover target function.
(c) Convergent gradient dynamics: The limiting properties of gradient-based optimization methods near these minima is affected by the local recovery problem. Understanding the dynamics in the vicinity of perfect global minima is essential for efficient training.

By proposing the local recovery problem, we aim to highlight how these geometrical and dynamic properties impact the network's ability to find and utilize these perfect-generalizing solutions during training. Addressing this problem involves developing strategies to navigate the complex loss landscape and understand why the network can recover the target function effectively in local regions.

To illustrate the local recovery problem more concretely, we will use a specific example. Consider a two-neuron model with exponential activation function and with one-dimensional input, i.e., $g(\theta, x)=a_{1} e^{w_{1} \cdot x}+a_{2} e^{w_{2} \cdot x}$, where $x \in \mathbb{R}^{2}$ and $\theta=\left(a_{1}, w_{1}, a_{2}, w_{2}\right) \in \mathbb{R}^{6}$. Consider the training data $\left\{\left(x_{i}, y_{i}\right)\right\}_{i=1}^{n}$ and hence the loss

$$
R(\theta)=\sum_{i=1}^{n}\left|g\left(\theta, x_{i}\right)-y_{i}\right|^{2} .
$$

By Cooper's results [5], up to an arbitrarily small perturbation of the $y_{i}$ 's, $R^{-1}\{0\}$ is a submanifold of $\mathbb{R}^{6}$ with dimension $\max \{0,6-n\}$. In our paper, by considering the cases where $y_{i}$ 's are sampled from a target function $f^{*}$ expressible by the given two-layer NN, which allows for perfect generalization, we uncover more detailed structure of the global minima of $R$. For illustration, we consider a simple example with $f^{*}(x)=\bar{a} e^{\bar{w} \cdot x}(\bar{a} \neq 0)$. The loss function writes

$$
R(\theta)=\sum_{i=1}^{n}\left|g\left(\theta, x_{i}\right)-\bar{a} e^{\bar{w} \cdot x_{i}}\right|^{2} .
$$

First, note that $e^{w_{1} \cdot x}$ and $e^{w_{2} \cdot x}$ are linearly independent if and only if $w_{1} \neq w_{2}$. Thus, based on the number of distinct $w_{k}$ 's, we have a partition of the perfect global minima as $Q^{*}=Q_{1} \cup Q_{2} \cup Q_{3}$ independent of the training inputs, where

$$
\begin{aligned}
Q_{1} & =\{(a, \bar{w}, \bar{a}-a, \bar{w}): a \in \mathbb{R}\} \\
Q_{2} & =\left\{(\bar{a}, \bar{w}, 0, w): w \in \mathbb{R}^{2} \backslash\{\bar{w}\}\right\} \\
Q_{3} & =\left\{(0, w, \bar{a}, \bar{w}): w \in \mathbb{R}^{2} \backslash\{\bar{w}\}\right\} .
\end{aligned}
$$

Geometrically, $Q_{1}, Q_{2}$ and $Q_{3}$ look like three "branches" with different dimensions. See also the figure below.


Figure 2: Illustration of $Q^{*}$. The closure of the branches $Q_{1}, Q_{2}, Q_{3}$ are all affine subspaces in the parameter space. Moreover, $Q_{1}, Q_{2}$ intersects at $(\bar{a}, \bar{w}, 0, \bar{w})$ and $Q_{1}, Q_{3}$ intersects at $(0, \bar{w}, \bar{a}, \bar{w})$.

Observe that $\overline{Q_{1}}, \overline{Q_{2}}, \overline{Q_{3}}$ are all affine subspaces in $\mathbb{R}^{6}$ with different dimensions. In general, when sample size $n \geq 6$, we expect no imperfect global minima, thus the NN achieves perfect generalization when it converges to zero loss. However, at overparameterization when $n<6$, imperfect global minimum generally exists, which sparkles the question of whether each branch of perfect global minima are enclosed by the imperfect global minima. If not, the training dynamics clearly has chance to converge to some perfect global minima, thus achieving perfect generalization. Inspired by this example, we notice that in general, to understand the problem of achieving perfect generalization for a two-layer neural network ( $m, m_{0}$ and $n$ are arbitrary), we must investigate the following questions:
(a) Geometrical structure: How can we describe the perfect global minima $Q^{*}$ geometrically? Does it consist of branches as for the example above?
(b) Separation of minima: How is $Q^{*}$ related to $R^{-1}\{0\}$, in particular to the imperfect global minima $R^{-1}\{0\} \backslash Q^{*}$ ? Can it be "separated" from $R^{-1}\{0\} \backslash Q^{*}$ ? How does this depend on samples?
(c) Convergent Gradient dynamics: What are the convergence, convergence rate, convergence direction, etc., of gradient flows near $R^{-1}\{0\}$ ? Moreover, what can we say about the stability of these gradient flows?

In $[11,8]$, Simsek and Fukumizu already have an answer to question (a), i.e., the geometry of $Q^{*}$. In this paper it is shown that $Q^{*}$ is a set with lots of symmetry. Moreover, it is the union of finitely many branches of different dimensions, the closure of each branch being an affine subspace. See also Section 3.4. We will answer the questions (b) and (c) in this paper. In Sections 4 and 5, we provide detailed answers to them. We also summarize the answers to them in the following Section 2.3 , where the informal theorems (2.1 and 2.2) answer questions (a), (b), (c), respectively. Then we apply these theorems to this example.

### 2.3 Main Results

The main results of this paper are theorems resolving the local recovery of two-layer neural networks. Let us summarize and discuss them informally as follows. For the separation of branches of $Q^{*}$ we have the following.

Theorem 2.1 (separation of branches in $\left.Q^{*}\right)$. Let $\left\{Q_{t}\right\}_{t=1}^{N}$ be the branches of $Q^{*}$. Each branch $Q_{t}$ corresponds to a sample size threshold $N_{t} \leq m(d+1)$ (and if $m>m_{0}$, we have $N_{t}<m(d+1)$ ), such that when sample size $n \geq N_{t}, Q_{t}$ is "separated" from the imperfect global minima. Moreover, by rearranging the indices of $Q_{t}$ if necessary, there is a partition

$$
Q^{*}:=\bigcup_{t=1}^{N} Q_{t}=\left(\bigcup_{t=1}^{N^{\prime}} Q_{t}\right) \bigcup\left(\bigcup_{t=N^{\prime}+1}^{N} Q_{t}\right)
$$

such that whenever $t \leq N^{\prime}$ and $n \geq N_{t}, R$ is not Morse-Bott anywhere at $Q_{t}$, while for $t>N^{\prime}$ and $n \geq N_{t}, R$ is Morse-Bott a.e. at $Q_{t}$.

By saying that $Q_{t}$ is separated we mean there is an open $U \subseteq \mathbb{R}^{(d+1) m}$ such that $U \cap R^{-1}\{0\}=$ $U \cap Q_{t}$. For definition of a Morse-Bott function $f$ we mean the Hess $f$ is non-degenerate along the normal bundle of a manifold in $(\nabla f)^{-1}\{0\}$ (Definition 4.1). The details of Theorem 2.1 will be shown in Lemmas 4.2 and 4.3 in Section 4, which relies on the theory of real analytic functions contained in Section 3.2.

Finally, any gradient flow near $R^{-1}\{0\}$ has the following properties.
Theorem 2.2 (gradient flow near global minima). Following the hypotheses and notations in Theorems 2.1, any gradient flow sufficiently close to $R^{-1}\{0\}$ converges. On the other hand, any point in $R^{-1}\{0\}$ is the limit of some gradient flow. The following results hold.
(a) Whenever $t \leq N^{\prime}$ and sample size $n \geq N_{t}$, a generic gradient flow sufficiently close to $Q_{t}$ converges to a point $\theta^{*} \in Q_{t}$. The convergence does not have linear rate and the curve is "biased towards" ker Hess $R\left(\theta^{*}\right)$. Moreover, any small perturbation of it still converges to $Q_{t}$.
(b) Given $t>N^{\prime}$. When sample size $n \geq N_{t}$, any gradient flow sufficiently close to $Q_{t}$ converges to points $Q_{t}$ at linear rate. Similar to (a), any small perturbation of it still converges to $Q_{t}$.

In short, we characterize the convergence (Theorem 5.2), limiting set (Proposition 5.1), limiting direction and convergence rate of gradient flows near global minimum, especially near $Q^{*}$ (Theorem 5.3). Meanwhile we develop a concept called "generalization stability" which discusses how the limiting model (under gradient flow) changes at perturbation of gradient flow (see Definition 5.1 and the remark below).

These three (informal) theorems exhibit comprehensively the structural change of geometry and local dynamics of global minima at the overparameterized regime (i.e., when $n<(d+1) m$ ), with the perfect gloal minima $Q^{*}$ as its backbone. In particular, the branch separation and convergence results guarantees the local recovery capability of two-layer neural networks, i.e., the target function will be recovered when initialized near separated branches. Furthermore, our results suggest the following mechanism of generalization at overparameteration that deserve further study: with proper generic initialization and hyperparameter tuning, the gradient dynamics can be globally guided to a neighbourhood of the separated branches of $Q^{*}$, thus recovering the target function at
convergence. In the following, we illustrate above results in a simple example.
Example (Continued). Using the three theorems above together with some calculation, we now answer the three questions in Section 2.2 for our two-neuron model example.
(a) From $[11,8], Q^{*}$ is a union of several subsets of $\mathbb{R}^{4}$ whose closures are affine subspaces. Specifically, $Q_{1}$ is a one-dimensional affine subspace, while $Q_{2}, Q_{3}$ are both two-dimensional affine subspaces minus a point. This coincides with our observation and Figure 2 above.
(b) By Theorem 2.1, each $Q_{t}, 1 \leq t \leq 3$, corresponds to a sample size $N_{t}$ making it separated. Specifically, by Lemma 4.2 we have $N_{1}=5$ and $N_{2}=N_{3}=4$. Moreover, when sample size $n \geq N_{t}, R$ is not Morse-Bott anywhere at $Q_{t}$ if $t=1$, and $R$ is Morse-Bott a.e. at $Q_{t}$ if $t=2,3$.
(c) By Theorem 2.2, any gradient flow sufficiently near $R^{-1}\{0\}$ converges to it, and any point in $R^{-1}\{0\}$ is the limit of some gradient flow. According to this theorem and (b), a generic gradient flow $\gamma$ does not converge to a point $\theta^{*} \in Q_{1}$ at linear rate and is biased towards ker $\operatorname{Hess} R\left(\theta^{*}\right)$, when sample size $n \geq 5$. However, any gradient flow $\gamma$ converging to a point in $Q_{2} \cup Q_{3}$ has linear rate, when $n \geq 4$.

The following figure illustrates these properties of $Q^{*}$ and gradient flow nearby.


Figure 3: Illustration of the example for two-neuron model fitting a one-neuron network. As shown in part (a) of example, $Q^{*}$ consists of three sets whose closures are one-dimensional affine subspaces. By (b), the loss $R$ is not Morse-Bott near any point in $Q_{1}$, whence by (c) a gradient flow with limit in $Q_{1}$ ( $\theta_{1}^{*}$ in the figure) is in general "biased towards" ker Hess $R\left(\theta_{1}^{*}\right)$. On the other hand, $R$ is Morse-Bott a.e. at $Q_{2}$ and $Q_{3}$, whence a gradient flow with limit in $Q_{2} \cup Q_{3}\left(\theta_{2}^{*}, \theta_{3}^{*}\right.$ in the figure) in general converges at linear rate. Finally, note that $Q_{12}=(\bar{a}, \bar{w}, 0, \bar{w})$ and $Q_{13}=(0, \bar{w}, \bar{a}, \bar{w})$ are the points of intersections $\overline{Q_{1}} \cap \overline{Q_{2}}$ and $\overline{Q_{1}} \cap \overline{Q_{3}}$, respectively.

## 3 Preparing Lemmas and Propositions

To prove the main results we shall do some preparation in this section. We will first show that, as aforementioned, the linear independence of neurons with a generic activation. Then we introduce separating inputs (Definition 3.1) based on how the choice of samples affect the rank of
certain matrices. Then we present some basic results about the zero set of real analytic functions, some of which will be used in Section 3.3.

Let's start with a lemma about power series.
Lemma 3.1 (characterization of $\varepsilon$-polynomial). Let $\sum_{j=0}^{\infty} c_{j} \varepsilon^{j}$ be a power series of real or complex coefficients $\left\{c_{j}\right\}_{j=0}^{\infty}$ such that for any $N \in \mathbb{N}$ there are some odd number $j_{\text {odd }}>N$ and even number $j_{\text {even }}>N$ with $c_{j_{\text {odd }}} \neq 0, c_{j_{\text {even }}} \neq 0$. Then for any $m, l \in \mathbb{N}$ and any distinct $p_{1}, \ldots, p_{r} \in \mathbb{R} \backslash\{0\}$, the power series in $\varepsilon$ :

$$
\sum_{j \geq l} c_{j} \sum_{k=1}^{r}\left[\alpha_{1 k}+j \alpha_{2 k}+\ldots+\frac{j!}{l!} \alpha_{l k}\right] p_{k}^{j-l} \varepsilon^{j-l}
$$

is a polynomial if and only if $\alpha_{t k}=0$ for all $1 \leq t \leq l$ and $1 \leq k \leq r$.
Proof. First note that for any sufficiently small $\varepsilon$ the power series in question converges. Without loss of generality, assume that $\left|p_{1}\right| \geq \ldots \geq\left|p_{r}\right|$; in particular, $p_{1}$ has the largest absolute value among the $\left|p_{k}\right|$ 's. We consider two cases.
(a) $\left|p_{1}\right|>\left|p_{2}\right|$. Assume that $t_{1} \in\{1, \ldots, l\}$ is the largest number with $\alpha_{t_{1} 1} \neq 0$. Then

$$
\sum_{k=1}^{r}\left[\alpha_{1 k}+j \alpha_{2 k}+\ldots+\frac{j!}{l!} \alpha_{l k}\right] p_{k}^{j-l} \sim \prod_{t=0}^{t_{1}-1}(j-t) p_{1}^{j-l}
$$

as $j \rightarrow+\infty$. By hypothesis, there is a subsequence $\left\{c_{j_{s}}\right\}_{s=1}^{\infty} \subseteq \mathbb{R}(\mathbb{C}) \backslash\{0\}$ of $\left\{c_{j}\right\}_{j=1}^{\infty}$. Therefore,

$$
c_{j_{s}} \sum_{k=1}^{r}\left[\alpha_{1 k}+j_{s} \alpha_{2 k}+\ldots+\frac{j_{s}!}{l!} \alpha_{l k}\right] p_{k}^{j_{s}-l} \sim c_{j_{s}} \prod_{t=0}^{t_{1}-1}\left(j_{s}-t\right) p_{1}^{j_{s}-l}
$$

as $s \rightarrow+\infty$, which shows that the power series has infinitely many non-zero coefficients, whence not a polynomial.
(b) $\left|p_{1}\right|=\left|p_{2}\right|$. Because the $p_{k}$ 's are distinct, we must have $p_{1}+p_{2}=0$ and $\left|p_{2}\right|>\left|p_{3}\right|$. Assume that $t_{1} \in\{1, \ldots, l\}$ is the largest number such that $\alpha_{t_{1} 1}$ or $\alpha_{t_{2} 1}$ is non-zero. Then, similar as (a) above, we have

$$
\sum_{k=1}^{r}\left[\alpha_{1 k}+j \alpha_{2 k}+\ldots+\frac{j!}{l!} \alpha_{l k}\right] p_{k}^{j-l} \sim \prod_{t=0}^{t_{1}-1}(j-t)\left[\alpha_{t_{1} 1}+(-1)^{j-l} \alpha_{t_{1} 2}\right] p_{1}^{j-l}
$$

as $j \rightarrow+\infty$. Our assumption implies that there must be some $j^{\prime} \in \mathbb{N}$ with $\alpha_{t_{1} 1}+(-1)^{j^{\prime}-l} \alpha_{t_{2} 1} \neq$ 0 , , but then this holds for any $j$ having the same parity as $j^{\prime}$. By hypothesis, we can find a subsequence $\left\{c_{j_{s}}\right\}_{s=1}^{\infty} \subseteq \mathbb{R}(\mathbb{C}) \backslash\{0\}$ of $\left\{c_{j}\right\}_{j=1}^{\infty}$, such that each $j_{s}$ has the same parity as $j^{\prime}$ and $c_{j_{s}} \neq 0$. It follows that

$$
c_{j_{s}} \sum_{k=1}^{r}\left[\alpha_{1 k}+j_{s} \alpha_{2 k}+\ldots+\frac{j_{s}!}{l!} \alpha_{l k}\right] p_{k}^{j_{s}-1} \sim c_{j_{s}} \prod_{t=0}^{t_{1}-1}\left(j_{s}-1\right) p_{1}^{j_{s}-1}
$$

as $s \rightarrow+\infty$, so the power series has infinitely many non-zero coefficients, whence not a polynomial.

In either case, we have shown that $\alpha_{11}=\ldots=\alpha_{l 1}=0$ must hold if $h$ is a polynomial. By repeating this procedure for $r$ times we can see that $\alpha_{t k}=0$ for all $1 \leq t \leq l$ and $1 \leq k \leq r$.

### 3.1 Linear Independence of Neurons

Corollary 3.1 (linear independence of neurons). Let d be any positive integer. Given a real analytic function $\sigma: \mathbb{R} \rightarrow \mathbb{R}$, the following two statements about $\sigma$ are equivalent.
(a) $\sigma$ is a generic activation, namely, it satisfies Assumption 2.1.
(b) For any $r>0$ and any distinct vectors $w_{1}, \ldots, w_{r} \in \mathbb{R}^{d}$, the functions $\sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right)$ are linearly independent.

Proof. First suppose that (a) holds. Let $1 \leq k<j \leq r$. The set

$$
\begin{equation*}
A_{k, j}=\left\{x \in \mathbb{R}^{d}:\left\langle x, w_{k}-w_{j}\right\rangle=0\right\} \tag{4}
\end{equation*}
$$

is a subspace of dimension $d-1$, whence $\bigcup_{1 \leq k<j \leq r} A_{k, j}$ has $\lambda_{d}$-measure zero. This, together with linearity, implies that we can find some $e \in \partial B(0,1) \subseteq \mathbb{R}^{d}$ with $p_{k}:=\left\langle w_{k}, e\right\rangle \neq\left\langle w_{j}, e\right\rangle=: p_{j}$ whenever $k \neq j$. For any $|\varepsilon|<\left(\max _{j}\left|p_{j}\right|\right)^{-1} R$ and any $k$ we have

$$
\sigma\left(w_{k} \cdot \varepsilon e\right)=\sum_{j=0}^{\infty} c_{j} \sigma\left(w_{k} \cdot \varepsilon e\right)=\sum_{j=0}^{\infty}\left(c_{j} p_{k}^{j}\right) \varepsilon^{j} .
$$

Now let $\alpha_{1}, \ldots, \alpha_{r}$ be constants such that $x \mapsto \sum_{k=1}^{r} \alpha_{k} \sigma\left(w_{k} \cdot x\right)$ is a zero map. It follows that for $|\varepsilon|<\left(\max _{j}\left|p_{j}\right|\right)^{-1} R$,

$$
\begin{align*}
\sum_{k=1}^{r} \alpha_{k} \sigma\left(w_{k} \cdot \varepsilon e\right) & =\sum_{k=1}^{r} \alpha_{k} \sum_{j=0}^{\infty}\left(c_{j} p_{k}^{j}\right) \varepsilon^{j} \\
& =\sum_{j=0}^{\infty} c_{j}\left(\sum_{k=1}^{r} \alpha_{k} p_{k}^{j}\right) \varepsilon^{j}  \tag{5}\\
& =\sum_{j=1}^{\infty} c_{j-1}\left(\sum_{k=1}^{r} \alpha_{k} p_{k}^{j-1}\right) \varepsilon^{j-1}=0 .
\end{align*}
$$

Since $\sigma$ is a generic activation, the sequence $\left\{c_{j-1}\right\}_{j=1}^{\infty}$ satisfies the hypothesis of Lemma 3.1. Since the $p_{k}$ 's are also distinct, by Lemma 3.1 we have $\alpha_{1}=\ldots=\alpha_{r}=0$. Therefore, $\sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right)$ are linearly independent.

Conversely, assume that (a) does not hold. First suppose there is some $N \in \mathbb{N}$ such that for any odd $j>N$ we have $c_{j}=0$. Then $\sigma$ is the sum of a polynomial and an even function. Let $\tilde{\sigma}: \mathbb{R} \rightarrow \mathbb{R}$ be defined by $\tilde{\sigma}(x)=\sigma(x)-\sigma(-x)$, so $\tilde{\sigma}$ is a polynomial of degree at most $N$. Thus, the dimension of $\operatorname{span}\left\{\tilde{\sigma}\left(\tilde{w}_{1} \cdot x\right), \ldots, \tilde{\sigma}\left(\tilde{w}_{r^{\prime}} \cdot x\right)\right\}$ is bounded by $(N+1)^{d}$. This implies that for any $r>2(N+1)^{d}$ the functions

$$
\sigma\left(w_{1} \cdot x\right), \sigma\left(-w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right), \sigma\left(-w_{r} \cdot x\right)
$$

can never be linearly independent. Similarly, if there is some $N \in \mathbb{N}$ such that for any even $j>N$ we have $c_{j}=0$. Then $\sigma$ is the sum of a polynomial and an odd function. Let $\tilde{\sigma}: \mathbb{R} \rightarrow \mathbb{R}$ be defined by $\tilde{\sigma}(x)=\sigma(x)+\sigma(-x)$, so $\tilde{\sigma}$ is a polynomial. Thus, for sufficiently large $r$ the functions

$$
\sigma\left(w_{1} \cdot x\right), \sigma\left(-w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right), \sigma\left(-w_{r} \cdot x\right)
$$

can never be linearly independent.

Remark 3.1. In fact, the proof of Proposition 3.1 shows that if $\sigma$ is analytic and not a polynomial, $\sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right)$ are linearly independent for any $r \in \mathbb{N}$, whenever the distinct $w_{1}, \ldots, w_{r} \in \mathbb{R}^{d}$ satisfy $w_{k}+w_{j} \neq 0$ for all $1 \leq k, j \leq r$. Similarly, Corollary 3.2 hold under this requirement. In particular, these results hold for $\sigma(x)=\frac{1}{1+e^{-x}}, \sigma(x)=\tanh (x)$ or $\sigma(x)=\log \left(1+e^{-x}\right)$. Interestingly, we also observe that current analysis of loss landscapes of neural network focus on polynomial and non-polynomial activations separately. For example, Venturi [13] has shown that for sufficiently wide one-hidden-layer neural network with polynomial activation, the corresponding loss landscape has no spurious valley, while in [11] the analysis of critical points are valid only for neural networks with certain non-polynomial activations.

Corollary 3.1 proves the (linear) neuron independence of analytic neurons, which is the main object we concern in this paper. For completeness, we also present a version of neuron independence result without requiring the neurons to be analytic. Instead, it considers other important properties of an activation function, which we hope could be of its own interest. More precisely, we make the following assumption.

Assumption 3.1. Assume that $\sigma: \mathbb{R} \rightarrow \mathbb{R}$ is an $s$-times continuously differentiable function ( $s \geq 0$ ) with the following properties:
(a) (rapid decreasing) $\frac{\left|\sigma^{(s)}(y)\right|}{\left|\sigma^{(s)}(x)\right|} \rightarrow+\infty$ as $|x|,|y| \rightarrow+\infty$ and $|x|-|y| \rightarrow+\infty$.
(b) (non-asymptotic symmetry) There is some $c>1$ such that either

$$
\lim _{x \rightarrow+\infty} \frac{\left|\sigma^{(s)}(x)\right|}{\left|\sigma^{(s)}(-x)\right|} \geq c
$$

or

$$
\lim _{x \rightarrow-\infty} \frac{\left|\sigma^{(s)}(x)\right|}{\left|\sigma^{(s)}(-x)\right|} \geq c .
$$

Remark 3.2. Notice that the rapid decreasing property of $\sigma^{(s)}$ requires that $\sigma^{(s)}(x) \neq 0$ for $|x|$ sufficiently large. Moreover, this property implies that $\lim _{x \rightarrow+\infty} \sigma^{(s)}(x)=0$. To see this, let $\left\{x_{n}\right\}_{n=1}^{\infty}$ be a sequence with $\lim _{n \rightarrow \infty}\left|x_{n}\right|=+\infty$. By passing to a subsequence of $\left\{x_{n}\right\}_{n=1}^{\infty}$, we can assume that $\lim _{n \rightarrow \infty}\left(\left|x_{n+1}\right|-\left|x_{n}\right|\right)=+\infty$ as well. Given $A>1$, any sufficiently large $N \in \mathbb{N}$ gives

$$
\frac{\left|\sigma^{(s)}\left(x_{N}\right)\right|}{\left|\sigma^{(s)}\left(x_{N+1}\right)\right|} \geq A .
$$

Thus,

$$
\left|\sigma^{(s)}\left(x_{N}\right)\right| \geq A\left|\sigma^{(s)}\left(x_{N+1}\right)\right| \geq \ldots \geq A^{n}\left|\sigma^{(s)}\left(x_{N+n}\right)\right|
$$

Since $A>1, \lim _{n \rightarrow \infty} A^{n}=+\infty$, which shows that $\lim _{n \rightarrow \infty} \sigma^{(s)}\left(x_{n}\right)=\lim _{n \rightarrow \infty} \sigma^{(s)}\left(x_{N+n}\right)=0$.
We shall give some examples to illustrate the two properties in Assumption 3.1. For the rapid decreasing property we have the following examples, which takes the commonly-seen activations into consideration.
(a) $\sigma(x)=\exp \left(-x^{2}\right)$ with $s=0$. Note that for any $x, y \in \mathbb{R}, \sigma(y) / \sigma(x)=\exp \left(x^{2}-y^{2}\right)$, which obviously tends to infinity as $|x|-|y|$ tends to infinity.
(b) $\sigma(x)=\exp (-|x|)$ with $s=0$. For any $x, y \in \mathbb{R}, \sigma(y) / \sigma(x)=\exp (|x|-|y|)$, which obviously tends to infinity as $|x|-|y|$ tends to infinity.
(c) $\sigma(x)=\frac{1}{1+e^{-x}}$ with $s=1$. Recall that $\sigma^{\prime}(x)=\frac{e^{-x}}{\left(1+e^{-x}\right)^{2}}$. Thus, In other words, $\lim _{x \rightarrow \pm \infty} \frac{\sigma^{\prime}(x)}{e^{-|x|}}=$ 1. Then by (b) we see that for any $|x|,|y|$ sufficiently large, $\sigma^{\prime}(y) / \sigma^{\prime}(x) \approx \exp (|x|-|y|)$, which also tends to infinity as $|x|-|y|$ tends to infinity.
(d) $\sigma(x)=\log \left(1+e^{x}\right)$ with $s=2$. This is because $\sigma^{\prime}(x)=\frac{1}{1+e^{-x}}$. Similarly, $\sigma(x)=\tanh (x)$ also decreases rapidly.

It is easy to see that in any case above, $\sigma^{(s)}$ does not satisfy the non-asymptotic symmetry property, because $\sigma^{(s)}$ is an even function. However, in any case a horizontal shift of $\sigma^{(s)}$ by $b \in \mathbb{R}$, $x \mapsto \sigma^{(s)}(x-b)$, which is just the $s$-th derivative of $\sigma(\cdot-b)$, satisfies both the rapid decreasing property and the non-asymptotic symmetry property.

Proposition 3.1. Let $d$ be a positive integer. Let $\sigma$ satisfy Assumption 3.1. For any $r>0$ and any distinct vectors $w_{1}, \ldots, w_{r} \in \mathbb{R}^{d} \backslash\{0\}$, the functions $\sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right)$ are linearly independent.

Proof. We prove in a similar way as that of Proposition 3.1. As we have shown above, there is some $e \in \partial B(0,1) \subseteq \mathbb{R}^{d}$ with $p_{k}:=\left\langle w_{k}, e\right\rangle \neq\left\langle w_{j}, e\right\rangle=: p_{j} \neq 0$ whenever $k, j \in\{1, \ldots, r\}$ are different. By rearranging the indices if necessary, we can assume that $\left|p_{1}\right| \geq\left|p_{2}\right| \geq \ldots \geq\left|p_{r}\right|>0$.

Let $\alpha_{1}, \ldots, \alpha_{r}$ be constants such that $x \mapsto \sum_{k=1}^{r} \alpha_{k} \sigma\left(w_{k} \cdot x\right)$ is a zero map. In particular, this means

$$
g: \mathbb{R} \rightarrow \mathbb{R}, g(\varepsilon)=\sum_{k=1}^{r} \alpha_{k} \sigma\left(\left(w_{k} \cdot e\right) \varepsilon\right)=\sum_{k=1}^{r} \alpha_{k} \sigma\left(p_{k} \varepsilon\right)
$$

is a zero map. Then the $s$-th derivative (when $s=0$, it is just $g$ itself) of $g$ in $\varepsilon$ is given by

$$
g^{(s)}(\varepsilon)=\sum_{k=1}^{r} \alpha_{k} p_{k}^{s} \sigma^{(s)}\left(p_{k} \varepsilon\right)=0
$$

We start by showing that $\alpha_{1}=0$. When $r=1$ this clearly holds. When $r \geq 2$, we consider two cases.
i) $\left|p_{1}\right|>\left|p_{k}\right|$ for all $2 \leq k \leq r$. Then $p_{1}^{s} \neq 0$. For $\sigma\left(p_{1} \varepsilon\right) \neq 0$ (which holds when $|\varepsilon|$ is sufficiently large), we can rewrite $g^{(s)}(\varepsilon)$ as

$$
\alpha_{1}=-\sum_{k=2}^{r} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)} .
$$

For any $2 \leq k \leq r,\left|p_{1}\right|>\left|p_{k}\right|$, so $\left|p_{1} \varepsilon\right|,\left|p_{k} \varepsilon\right|$ and $\left|p_{1} \varepsilon\right|-\left|p_{k} \varepsilon\right|$ all tend to infinity as $\varepsilon \rightarrow \pm \infty$. Therefore, using the rapid decreasing property of $\sigma^{(s)}$ we have

$$
\lim _{\varepsilon \rightarrow \pm \infty} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}
$$

In particular, it follows that as $\varepsilon \rightarrow+\infty$,

$$
\alpha_{1}=\lim _{\varepsilon \rightarrow+\infty} \alpha_{1}=-\sum_{k=2}^{r} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \lim _{\varepsilon \rightarrow+\infty} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}=0 .
$$

ii) $\left|p_{1}\right|=\left|p_{2}\right|$. Then we must have $p_{1}=-p_{2} \neq 0$ and $\left|p_{1}\right|=\left|p_{2}\right|>\left|p_{k}\right|$ for all $k \neq 1,2$. Again, for $\sigma\left(p_{1} \varepsilon\right) \neq 0$, we can rewrite $g^{(s)}(\varepsilon)$ as

$$
\begin{aligned}
\alpha_{1} & =-\alpha_{2}\left(\frac{p_{2}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{2} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}-\sum_{k>2} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)} \\
& =(-1)^{s+1} \alpha_{2} \frac{\sigma^{(s)}\left(-p_{1} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}-\sum_{k>2} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}
\end{aligned}
$$

where we use $p_{1}=-p_{2}$. Same as in i), letting $\varepsilon \rightarrow \pm \infty$, we still have

$$
\lim _{\varepsilon \rightarrow \pm \infty} \sum_{k>2} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}=0
$$

For the other term, we use the non-asymptotic symmetry property of $\sigma^{(s)}$. Without loss of generality, assume that $\underline{\lim }_{x \rightarrow+\infty} \frac{\left|\sigma^{(s)}\left(-p_{1} \varepsilon\right)\right|}{\left|\sigma^{(s)}\left(p_{1} \varepsilon\right)\right|} \geq c$ for some $c>1$. Then $\overline{\lim }_{x \rightarrow-\infty} \frac{\left|\sigma^{(s)}\left(-p_{1} \varepsilon\right)\right|}{\left|\sigma^{(s)}\left(p_{1} \varepsilon\right)\right|} \leq$ $c^{-1}$. These two inequalities yield lower and upper bounds for $\alpha_{1}$ :

$$
\begin{aligned}
\left|\alpha_{1}\right| & =\left|\lim _{x \rightarrow+\infty}(-1)^{s+1} \alpha_{2} \frac{\sigma^{(s)}\left(-p_{1} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}-\lim _{x \rightarrow+\infty} \sum_{k>2} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}\right| \\
& =\left|\alpha_{2}\right| \lim _{x \rightarrow+\infty} \frac{\left|\sigma^{(s)}\left(-p_{1} \varepsilon\right)\right|}{\left|\sigma^{(s)}\left(p_{1} \varepsilon\right)\right|} \\
& \geq c\left|\alpha_{2}\right|
\end{aligned}
$$

and similarly,

$$
\left|\alpha_{1}\right|=\left|\varlimsup_{x \rightarrow-\infty}(-1)^{s+1} \alpha_{2} \frac{\sigma^{(s)}\left(-p_{1} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}-\varlimsup_{x \rightarrow-\infty} \sum_{k>2} \alpha_{k}\left(\frac{p_{k}}{p_{1}}\right)^{s} \frac{\sigma^{(s)}\left(p_{k} \varepsilon\right)}{\sigma^{(s)}\left(p_{1} \varepsilon\right)}\right| \leq c^{-1}\left|\alpha_{2}\right| .
$$

Unless $\alpha_{1}=\alpha_{2}=0$, we would get a contradiction.
In either case, we show that $\alpha_{1}=0$. By repeating this argument (at most) $r$ times, we can show that $\alpha_{1}=\ldots=\alpha_{r}=0$ and thus the linear independence of $\sigma\left(w_{1} \cdot x\right), \ldots, \sigma\left(w_{r} \cdot x\right)$ follows.

Note that the non-asymptotic symmetry property of $\sigma^{(s)}$ is only used to deal with $p_{k}=-p_{j}$ for some $k, j \in\{1, \ldots, r\}$ in the proof, which is unavoidable only when $w_{k}+w_{j}=0$ for some $w_{k}, w_{j} \neq 0$. Thus, if $w_{1}, \ldots, w_{r} \in \mathbb{R}^{d} \backslash\{0\}$ are distinct vectors satisfying $w_{k}+w_{j} \neq 0$ for all $1 \leq k, j \leq r$, any $\sigma \in C^{s}$ which has the rapid decreasing property would give the linear independence result. By our examples above, this holds for lots of commonly seen neurons, including $\sigma(x)=\frac{1}{1+e^{-x}}$, $\sigma(x)=\tanh (x), \sigma(x)=\exp \left(-x^{2}\right), \sigma(x)=\exp (-|x|)$ and $\sigma(x)=\log \left(1+e^{x}\right)$.

Remark 3.3 (proof techniques). In both cases (analytic and non-analytic), we use two important properties of neurons to show their linear independence. The first one is that for $w \in \mathbb{R}^{d}$ the mapping $\mathbb{R}^{d} \ni x \mapsto w \cdot x$ reduces high-dimensional problems to 1-dimensional ones, as it induces a mapping $\mathbb{R} \ni \varepsilon \mapsto w \cdot(\varepsilon x)$. Therefore, many 1-dimensional results of neurons can be applied to higher-dimensional cases. Another technique is to use the fact that distinct weights of neurons, no
matter how small the difference is, could distinguish them with significant different behaviors. In Proposition 3.1, we observe this by taking higher derivative, while in Proposition 3.1, we observe this by comparing their asymptotic behaviors at $\pm \infty$. The treatment of $w_{k}+w_{j}=0$ for some $k, j$ is more technical, and we make different assumptions in dealing with it: indeed, the function

$$
\sigma(x)=e^{-x^{2}}+\frac{d^{2}}{d x^{2}} \frac{1}{1+e^{-x}}
$$

satisfies Assumption 2.1 and is rapidly decreasing, but $\lim _{x \rightarrow \pm \infty} \sigma(x) / \sigma(-x)=-1$.
We then study the rank of some special matrices related to $\sigma$. Recall the loss function $R(\theta)=$ $\sum_{i=1}^{n}\left|\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x_{i}\right)-f\left(x_{i}\right)\right|^{2}$. For each $1 \leq i \leq n$, the second-order partial derivative of $\left|\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x_{i}\right)-f\left(x_{i}\right)\right|^{2}$ is given by the tensor product $v_{i, \sigma}^{\mathrm{T}} v_{i, \sigma}$ where

$$
v_{i, \sigma}:=\left(\sigma\left(w_{1} \cdot x_{i}\right), \ldots, \sigma\left(w_{m} \cdot x_{i}\right), \sigma^{\prime}\left(w_{1} \cdot x_{i}\right) x_{i}^{\mathrm{T}}, \ldots, \sigma^{\prime}\left(w_{m} \cdot x_{i}\right) x_{i}^{\mathrm{T}}\right) .
$$

Since $R$ is a sum of the $\left|\sum_{k=1}^{m} a_{k} \sigma\left(w_{k} \cdot x_{i}\right)-f\left(x_{i}\right)\right|^{2}$ 's, it motivates us to study the matrices whose rows are these vectors $v_{i, \sigma}$ or parts of them.
Corollary 3.2 (separating inputs). Let $\sigma$ be a generic activation. For any $r \in \mathbb{N}$ and any distinct $w_{1}, \ldots, w_{r} \in \mathbb{R}^{d}$, there are $x_{1}, \ldots, x_{(d+1) r}$ such that the matrix

$$
\left(\begin{array}{cccccc}
\sigma\left(w_{1} \cdot x_{1}\right) & \ldots & \sigma\left(w_{r} \cdot x_{1}\right) & \sigma^{\prime}\left(w_{1} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(w_{r} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(w_{1} \cdot x_{(d+1) r}\right) & \ldots & \sigma\left(w_{r} \cdot x_{(d+1) r}\right) & \sigma^{\prime}\left(w_{1} \cdot x_{(d+1) r}\right) x_{(d+1) r}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(w_{r} \cdot x_{(d+1) r}\right) x_{(d+1) r}^{\mathrm{T}}
\end{array}\right)
$$

has full rank.
Proof. For simplicity, denote $v_{l, \sigma}$ as the vector $\left(\sigma\left(w_{1} \cdot x_{l}\right), \ldots, \sigma\left(w_{r} \cdot x_{r}\right), \sigma^{\prime}\left(w_{1} \cdot x_{l}\right) x_{l}^{\mathrm{T}}, \ldots, \sigma^{\prime}\left(w_{r} \cdot x_{l}\right) x_{j}^{\mathrm{T}}\right)$, i.e., it is the $l$-th row of the matrix in question. We shall prove the result by induction.

Since $\sigma(0) \neq 0$, we can select a sufficiently small $x_{1}$ not orthogonal to $w_{1}$ so that $\sigma\left(w_{1} \cdot x_{1}\right) \neq 0$. This proves the desired result for $r=1$. Suppose the result holds for some $r-1$, where $r \geq 2$. Choose $e \in \mathbb{R}^{d}$ such that $p_{j}:=\left\langle w_{j}, e\right\rangle \neq\left\langle w_{i}, e\right\rangle=: p_{i}$, and some other requirements that we will specify later. Let $b=:\left(b_{1}^{0}, \ldots, b_{r}^{0}, b_{1}^{1}, \ldots, b_{r}^{1}\right) \in \mathbb{R}^{r} \times \mathbb{R}^{r d}$ be any non-zero element in the orthogonal complement of $\operatorname{span}\left\{v_{j, \sigma}: 1 \leq j \leq r-1\right\}$. Consider the matrix

$$
\left(\begin{array}{c}
v_{1, \sigma}  \tag{6}\\
\vdots \\
v_{r-1, \sigma} \\
\left(\sigma\left(\varepsilon p_{1}\right), \ldots, \sigma\left(\varepsilon p_{r}\right), \sigma^{\prime}\left(\varepsilon p_{1}\right) \varepsilon e^{\mathrm{T}}, \ldots, \sigma^{\prime}\left(\varepsilon p_{r}\right) \varepsilon e^{\mathrm{T}}\right)
\end{array}\right) .
$$

We shall show that by choosing $e$ carefully we would have $\varepsilon \mapsto \sum_{k=1}^{r} b_{k}^{0} \sigma\left(\varepsilon p_{j}\right)+\sum_{j=1}^{r}\left\langle b_{j}^{1}, e\right\rangle \sigma^{\prime}\left(\varepsilon p_{j}\right) \varepsilon$ is not a zero map. It will follow that $\left\langle v_{j, \sigma}, b\right\rangle \neq 0$ for some choice of $x_{j}=\varepsilon e$ and thus the matrix (6) has rank $k$. Given $e \in \mathbb{R}^{d}$, suppose that this map is zero; equivalently,

$$
\begin{aligned}
& \sum_{k=1}^{r} b_{k}^{0} \sigma\left(\varepsilon p_{k}\right)+\sum_{k=1}^{r}\left\langle b_{k}^{1}, e\right\rangle \sigma^{\prime}\left(\varepsilon p_{k}\right) \varepsilon \\
= & c_{0} \sum_{k=1}^{r} b_{k}^{0}+\sum_{j \geq 1} c_{j} \sum_{k=1}^{r}\left[\alpha_{1 k}+j \alpha_{2 k}\right] p_{k}^{j-1} \varepsilon^{j} \\
= & c_{0} \sum_{k=1}^{r} b_{k}^{0}+\varepsilon\left(\sum_{j \geq 1} c_{j} \sum_{k=1}^{r}\left[\alpha_{1 k}+j \alpha_{2 k}\right] p_{k}^{j-1} \varepsilon^{j-1}\right) \\
= & 0
\end{aligned}
$$

where for each $1 \leq k \leq m$,

$$
\alpha_{1 k}=b_{k}^{0} p_{k}, \quad \alpha_{2 k}=\left\langle b_{k}^{1}, e\right\rangle .
$$

Similar as in the proof of Proposition 3.1, we may apply Lemma 3.1 to see that $\sum_{k=1}^{r} \beta_{k}=0$ and $\alpha_{1 k}=\alpha_{2 k}=0$ for all $1 \leq k \leq m$. But this implies that $b_{k}^{0}=\left\langle b_{k}^{1}, e\right\rangle=0$ for all $k$, as long as $e \in \mathbb{R}^{d}$ satisfies $p_{k} \neq p_{j}$. Unless $b_{1}^{0}=b_{1}^{1}=\ldots=b_{r}^{0}=b_{r}^{1}=0$, we can always perturb $e$ a little bit to guarantee that $p_{k} \neq p_{j}$ still holds for $k \neq j$, but there is some $\left\langle b_{t}^{1}, e\right\rangle \neq 0$. With this (perturbed) $e$, the analytic function

$$
\varepsilon \mapsto \sum_{k=1}^{r} b_{k}^{0} \sigma\left(\varepsilon p_{k}\right)+\sum_{k=1}^{r}\left\langle b_{k}^{1}, e\right\rangle \sigma^{\prime}\left(\varepsilon p_{k}\right) \varepsilon
$$

is not a zero map, completing the proof.

Inspired by the lemma above, we define separating inputs below. As we will see in Section 4, separating inputs allows us to determine the rank of Hessian of $R$ on $R^{-1}\{0\}$, and thus help us study the geometry of $R$ (e.g., separation of branches, see also Definition 3.3 for a description of geometry of branches) near its perfect global minima $Q^{*}$. This in turn guarantees that locally any gradient flow finds a solution with zero generalization error. We will prove this in Section 5.

Definition 3.1 (separating inputs). Let $r \in\{1, \ldots, m\}$. Given $n \leq(d+1) m$ and distinct $w_{1}, \ldots, w_{r} \in$ $\mathbb{R}^{d}$, we call $\left\{x_{i}\right\}_{i=1}^{n}$ separating inputs (for $w_{1}, \ldots, w_{r}$ ) if he matrix

$$
\left(\begin{array}{cccccc}
\sigma\left(w_{1} \cdot x_{1}\right) & \ldots & \sigma\left(w_{r} \cdot x_{1}\right) & \sigma^{\prime}\left(w_{1} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(w_{r} \cdot x_{1}\right) x_{1}^{\mathrm{T}}  \tag{7}\\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(w_{1} \cdot x_{n}\right) & \ldots & \sigma\left(w_{r} \cdot x_{n}\right) & \sigma^{\prime}\left(w_{1} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(w_{r} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right)
$$

has full rank. For any $\theta=\left(a_{k}, w_{k}\right)_{k=1}^{m} \in \mathbb{R}^{(d+1) m}$, we say $\left\{x_{i}\right\}_{i=1}^{n}$ are separating inputs for $\theta$ if they are separating inputs for the distinct elements among $\left\{w_{1}, \ldots, w_{m}\right\}$.

Note that Corollary 3.2 shows the existence of separating inputs for $\theta$. Since $\sigma$ is analytic, this implies that for almost every $\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{d n},\left\{\left(x_{i}, f^{*}\left(x_{i}\right)\right)\right\}_{i=1}^{n}$ are separating inputs for $\theta$, see Lemma 3.4.

### 3.2 Theory of Real Analytic Functions

To prove such corollaries in this subsection, we introduce some properties of real analytic functions. such tools will also be used in the analysis of the geometry of the loss landscape of $R$ near its global-min $R^{-1}\{0\}$.

Lemma 3.2 (analytic implicit function theorem). Let $\mathcal{M}_{1}$ and $\mathcal{M}_{2}$ be smooth manifolds of dimension $s_{1}$ and $s_{2}$, respectively, and each one has a coordinate representation given by an analytic diffeomorphism. Suppose that $\mathcal{F}: \mathcal{M}_{1} \rightarrow \mathcal{M}_{2}$ is a smooth map with constant ranks (rank $D \mathcal{F}(p)=s$ for all $p$ ). For each $p \in \mathcal{M}_{1}$ and any coordinate ball $U$ around $p$, there exist coordinate maps $\varphi: U \rightarrow \mathbb{R}^{s_{1}}, \psi: \mathcal{F}(\varphi(U)) \rightarrow \mathbb{R}^{s_{2}}$, such that

$$
\begin{equation*}
\psi \circ \mathcal{F} \circ \varphi^{-1}\left(\zeta_{1}, \ldots, \zeta_{s_{1}}\right)=\left(\zeta_{1}, \ldots, \zeta_{s}, 0, \ldots, 0\right) \tag{8}
\end{equation*}
$$

for $\left(\zeta_{1}, \ldots, \zeta_{s_{1}}\right) \in \varphi(U)$.
Proof. By [9], the inverse of a (real) analytic diffeomorphism is analytic. Following the proof of the Rank theorem in [10], we can see that all the functions constructed can be made analytic, whence the desired result holds.

Lemma 3.3. Let $\Omega \subseteq \mathbb{R}^{(d+1) m}$ be a connected open set and let $f: \Omega \rightarrow \mathbb{R}$ be a (real) analytic function. The following results hold.
(a) Either $f=0$ on $\Omega$ or $f^{-1}\{0\}$ has $\lambda_{(d+1) m}$-measure zero.
(b) Suppose that $f$ is not a zero map. For any $z_{0} \in f^{-1}\{0\}$ and any compact $K \subseteq \Omega, K \cap f^{-1}\{0\}$ is contained in a finite union of (analytic) smooth manifolds of dimension $(d+1) m-1$, each one having a coordinate representation by an analytic diffeomorphism.
(c) Let $f^{-1}\{0\}$ be locally contained in the union of connected embedded smooth manifolds $\mathcal{M}_{1}, \ldots, \mathcal{M}_{N}$ of the same dimension, with $\mathcal{M}_{1} \subseteq f^{-1}\{0\}$. Then there is an open $U \subseteq \Omega$ such that $U \cap f^{-1}\{0\}=U \cap \mathcal{M}_{1} \neq \emptyset$.

Proof. (a) We will show that given $n \in \mathbb{N}$ and any set $\Omega$ open in $\mathbb{R}^{n}$, the zero set of any nonconstant analytic function $f: \Omega \rightarrow \mathbb{R}$ has $\lambda_{n}$-measure zero. Indeed, when $n=1$ the zeros of $f$ are (possibly empty isolated points), which means $f^{-1}\{0\}$ has measure zero. Suppose that the result holds for $n-1$. Let $E \subseteq \mathbb{R}$ be the projection of $\Omega$ onto $\operatorname{span}\left\{e_{1}\right\}$. For any $z_{1} \in E$, $f\left(z_{1}, \cdot\right)$ is an analytic function in $n-1$ variables, whence by our assumption its zero set has $\lambda_{n-1}$-measure zero. It follows that

$$
\lambda_{n}\left(f^{-1}\{0\}\right)=\int_{\Omega} \chi_{f^{-1}\{0\}}=\int_{E} \lambda_{n-1}\left(f\left(z_{1}, \cdot\right)^{-1}\{0\}\right) d z_{1}=0
$$

where $\chi$ is the characteristic function. This completes our induction and shows that $f^{-1}\{0\}$ has measure zero.
(b) It suffices to show that for any $y \in f^{-1}\{0\}, y$ has a bounded neighborhood $U$ such that $U \cap f^{-1}\{0\}$ is contained in a finite union of (analytic) submanifolds of codimension 1. Since $f$ is not a zero map on $\Omega$, there is some $N \in \mathbb{N}$ such that $D^{t} f(y)=0$ for all multi-index $t$ with $|t| \leq N$ and there are some $j \in\{1, \ldots,(d+1) m\}$, multi-index $\alpha$ with $|\alpha|=N$ and $\partial_{z_{j}} D^{\alpha} f(y) \neq 0$. Thus,

$$
y \in\left\{z \in \mathbb{R}^{(d+1) m}: D^{\alpha} f(z)=0 \text { and } \partial_{z_{j}} D^{\alpha} f(z) \neq 0\right\}
$$

which shows that $y$ is in a smooth manifold of dimension $(d+1) m-1$, and by Lemma 3.2, it has a coordinate representation given by an analytic diffeomorphism. Let $U$ be a bounded neighborhood of $y$ on which $\partial_{z_{j}} D^{\alpha} f \neq 0$. It follows that $U \cap f^{-1}\{0\}$ is contained in

$$
\begin{equation*}
\bigcup_{t, 0 \leq|t| \leq N} \bigcup_{i=1}^{(d+1) m}\left\{z \in \mathbb{R}^{(d+1) m}: D^{t} f(z)=0 \text { and } \partial_{z_{i}} D^{t} f(z) \neq 0\right\} . \tag{9}
\end{equation*}
$$

Just note that the right side is a finite union of (possibly empty) embedded, analytic smooth manifolds, as desired.
(c) By shrinking the domain of $f, \Omega$ if necessary, we may for simplicity assume that $f^{-1}\{0\} \subseteq$ $\bigcup_{j=1}^{N} \mathcal{M}_{i}$. First suppose that $N=2$. Since

$$
\mathcal{M}_{1}=\left(\mathcal{M}_{1} \backslash \mathcal{M}_{2}\right) \cup\left(\mathcal{M}_{1} \cap \mathcal{M}_{2}\right),
$$

one of the sets on the right side of the equation must contain an open submanifold $E$ of $\mathcal{M}_{1}$. Consider first the case in which $E \subseteq \mathcal{M}_{1} \backslash \mathcal{M}_{2}$ and $x \in E$. If for any $\delta>0$ the
$(d+1) m$-dimensional ball $B(x, \delta)$ intersects $\mathcal{M}_{2}$, then $x$ is in the closure of $\mathcal{M}_{2}$, which implies that $x \in \mathcal{M}_{2}$, as $\mathcal{M}_{2}$ is embedded in $\mathbb{R}^{(d+1) m}$, a contradiction. Now suppose that $x \in E \subseteq$ $\mathcal{M}_{1} \cap \mathcal{M}_{2}$. Since $\operatorname{dim} \mathcal{M}_{1}=\operatorname{dim} \mathcal{M}_{2}, E$ is also an open submanifold of $\mathcal{M}_{2}$; furthermore, it is the intersection of an open subset of $\mathbb{R}^{(d+1) m}$ with $\mathcal{M}_{1}\left(\mathcal{M}_{2}\right)$. In either case, there is some open $U \subseteq \mathbb{R}^{(d+1) m}$ with $U \cap f^{-1}\{0\}=U \cap \mathcal{M}_{1}$. When $N \geq 2$, we argue by induction to obtain the same desired result.

Corollary 3.3. Let $\mu=\sum_{i=1}^{n} \delta\left(\cdot-x_{i}\right)$ as in Assumption 2.2. If $\sigma$ is analytic, then $R$ is analytic, in which case all the results in Lemma 3.3 apply to $R$.

Proof. By our hypothesis, $R(\theta)=\sum_{i=1}^{n}\left|g\left(\theta, x_{i}\right)-f^{*}\left(x_{i}\right)\right|^{2}$ for some $x_{1}, \ldots, x_{n} \in \mathbb{R}^{d}$. Because the composition of two analytic functions is again analytic, each $a_{k} \sigma\left(w_{k} \cdot x_{i}\right)$ is analytic (in $\left.a_{k}, w_{k}\right)$; because adding and/or multiplying two analytic functions produces analytic functions, $R$ is analytic.

Corollary 3.4 (common zeros of parametrized analytic functions). Let $f: E \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ be analytic, where $E \subseteq \mathbb{R}^{s}$. Suppose that for any $z \in E, f(z, \cdot)$ is not constant-zero. Given $n>s$, for any prescribed $x_{1}, \ldots, x_{n} \in \mathbb{R}^{d}$ and any $\varepsilon>0$, we can perturb each of them with no more than $\varepsilon$-distance to obtain $x_{1}^{\prime}, \ldots, x_{n}^{\prime}$, so that

$$
\mathcal{A}_{E}:=\left\{z \in E: f\left(z, x_{1}^{\prime}\right)=\ldots=f\left(z, x_{n}^{\prime}\right)=0\right\}
$$

is empty. In particular, $\mathcal{A}_{E}=\emptyset$ for almost all $\left(x_{1}^{\prime}, \ldots, x_{n}^{\prime}\right) \in \mathbb{R}^{n d}$.
Proof. By hypothesis, $f$ is not constant-zero, whence there is some $x_{1}^{\prime} \in \mathbb{R}^{d}$ with $\left|x_{1}^{\prime}-x_{1}\right|<\varepsilon$ such that $\left.f\left(\cdot, x_{1}^{\prime}\right)\right|_{E}$ is not constant-zero. By Lemma 3.3 (b), for each $N \in \mathbb{N}$ and $x \in \mathbb{R}^{d}$ with $f(\cdot, x)$ not constant-zero, $f(\cdot, x)^{-1}\{0\} \cap(\overline{B(0, N)} \cap E)$ is contained in a finite union of codimension1 submanifolds of $\mathbb{R}^{s}$. Thus, $f\left(\cdot, x_{1}^{\prime}\right)^{-1}\{0\}$ is contained in a union of countably many submanifolds of $\mathbb{R}^{s}$, which we denote by $\left\{\mathcal{M}_{1 n}: n \in \mathbb{N}\right\}$.

For the choice of $x_{2}^{\prime}$ we consider two cases. Suppose first that there are (possibly finite) $\mathcal{M}_{1 n_{1}}, \ldots, \mathcal{M}_{1 n_{k}}, \ldots$ such that $f\left(\cdot, x_{2}\right)$ restricted to each of them is a zero map. Select points $\left\{z_{k}^{\prime} \in\right.$ $\left.\mathcal{M}_{1 n_{k}}: k \in \mathbb{N}\right\}$. For each $k$, there is an open, dense $O_{k}^{\prime} \subseteq \mathbb{R}^{d}$ such that $\lambda_{d}\left(\mathbb{R}^{d} \backslash O_{k}^{\prime}\right)=0$ and $f\left(z_{k}^{\prime}, x\right) \neq 0$ for all $x \in O_{k}^{\prime}$. Thus, $\bigcap_{k=1}^{\infty} O_{k}^{\prime}$ is dense and have (Lebesgue measure) zero in $\mathbb{R}^{d}$. Therefore $f\left(z_{k}^{\prime}, x\right) \neq 0$ for all $k \in \mathbb{N}$, whenever $x \in \bigcap_{k=1}^{\infty} O_{k}^{\prime}$. Let $x_{2}^{\prime} \in \bigcap_{k=1}^{\infty} O_{k}^{\prime}$ with $\left|x_{2}^{\prime}-x_{2}\right|<\varepsilon$. Otherwise, $f\left(z, x_{2}^{\prime}\right)$ is not constant-zero on $\bigcup_{k=1}^{\infty} \mathcal{M}_{1 n}$; in this case simply let $x_{2}^{\prime}=x_{2}$. By Lemma 3.3 , the set on which $\left.f\left(\cdot, x_{1}^{\prime}\right)\right|_{E}=\left.f\left(\cdot, x_{2}^{\prime}\right)\right|_{E}=0$ is contained in a countable union of codimension-2 (analytic) submanifolds of $\mathbb{R}^{s}$.

Repeat this procedure to perturb $x_{1}, \ldots, x_{s}$. We see that in general, for $s^{\prime} \leq s$,

$$
\mathcal{A}_{E, s^{\prime}}:=\left\{z \in E: f\left(z, x_{1}^{\prime}\right)=\ldots=f\left(z, x_{s^{\prime}}^{\prime}\right)=0\right\}
$$

is contained in a countable (possibly finite) union of manifolds of codimension $s^{\prime}$. In particular, $\mathcal{A}_{E, s}$ is a countable (possibly finite) set. For simplicity, denote $\mathcal{A}_{E, s}:=\left\{z_{k}: k \in \mathbb{N}\right\}$. For each $k$, there is an open $O_{k} \subseteq \mathbb{R}^{d}$ such that $\lambda_{d}\left(\mathbb{R}^{d} \backslash O_{k}\right)=0$ and $f\left(z_{k}, x\right) \neq 0$ for all $x \in O_{k}$. Let $x_{s+1}^{\prime} \in \bigcap_{k=1}^{\infty} O_{k}$ with $\left|x_{s+1}^{\prime}-x_{s+1}\right|<\varepsilon$. Finally, let $x_{s+2}^{\prime}=x_{s+2}, \ldots, x_{n}^{\prime}=x_{n}$. The parameters $x_{1}^{\prime}, \ldots, x_{s+1}^{\prime}, \ldots, x_{n}^{\prime}$ satisfy our requirements.

Remark 3.4. This technique enables us to control the size of the global minimum of $R$. See also Lemmas 4.2 (b) and 4.3 .

### 3.3 Separating Inputs are Almost Everywhere

Corollary 3.5 (separating inputs works almost everywhere). Suppose that Assumptions 2.1 and 2.2 hold. Given separating inputs $\left\{x_{i}\right\}_{i=1}^{n}$ for some fixed distinct weights $w_{1}^{*}, \ldots, w_{r}^{*} \in \mathbb{R}^{d}$. Given any $1 \leq j \leq r$, there is an open dense subset of $\mathbb{R}^{j d}$ such that for any $\left(w_{1}, \ldots, w_{j}\right)$ in it, $\left\{x_{i}\right\}_{i=1}^{n}$ are separating inputs for $\left(w_{1}, \ldots, w_{j}, w_{j+1}^{*}, \ldots, w_{r}^{*}\right)$.

Proof. Let $A=A\left(\left(w_{k}\right)_{k=1}^{r},\left(x_{i}\right)_{i=1}^{n}\right)$ be the matrix (7) in Definition 3.1. We may assume that $n \leq(d+1) r$, because when $n>(d+1) r$ we can always find distinct $i_{1}, \ldots, i_{(d+1) r} \in\{1, \ldots,(d+1) r\}$ such that $A\left(\left(w_{k}^{*}\right)_{k=1}^{r},\left(x_{i_{j}}\right)_{j=1}^{(d+1) r}\right)$ has full rank.

Since $n \leq(d+1) r$, the number of columns of $A$ is no less than the number of rows of $A$, so the fact that it is full rank means there is some $n \times n$ submatrix of it, denoted by $B\left(\left(w_{k}^{*}\right)_{k=1}^{r},\left(x_{i}\right)_{i=1}^{n}\right)$, such that $\operatorname{det} B=B\left(\left(w_{k}^{*}\right)_{k=1}^{r},\left(x_{i}\right)_{i=1}^{n}\right) \neq 0$. Notice that when $w_{j+1}^{*}, \ldots, w_{r}^{*}$ and $x_{1}, \ldots, x_{n}$ are fixed, we can view $\operatorname{det} B$ as an analytic function in $w_{1}, \ldots, w_{j}$ :

$$
\mathbb{R}^{j d} \ni\left(w_{1}, \ldots, w_{j}\right) \mapsto \operatorname{det} B\left(\left(w_{1}, \ldots, w_{j}, w_{j+1}^{*}, \ldots, w_{r}^{*}\right),\left(x_{i}\right)_{i=1}^{n}\right) .
$$

Therefore, our proof above implies that it is not constant zero on $\mathbb{R}^{j d}$, whence by Lemma 3.3 (a), its zero set, which is clearly closed, has $\lambda_{j d}$-measure zero. Thus, $\operatorname{det} B \neq 0$, and thus $A$ has full rank for $\left(w_{1}, \ldots, w_{j}\right)$ an open dense subset of $\mathbb{R}^{j d}$.

Argue in the same way as above, we can see that separating inputs is almost everywhere:
Lemma 3.4 (separating inputs are almost everywhere). Given $\theta \in \mathbb{R}^{(d+1) m}$. Almost all choices of $\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n d},\left\{x_{i}\right\}_{i=1}^{n}$ are separating inputs for $\theta$.

### 3.4 Geometry of $Q^{*}$

In this part, we investigate the geometry of $Q^{*}$ under the assumption that $\sigma$ is a generic activation (Assumption 2.1). In this case, Refs. [11, 8] have shown that the global minima of the loss function is a union of subsets of $\mathbb{R}^{(d+1) m}$ whose closure are affine subspaces which we call "branches". For completeness of our study for local recovery, we present this result and prove it with our notations (see Proposition 3.2). Based on this, Simsek shows that $Q^{*}$ is connected [11]. We further investigate how different branches intersect with each other. First let's recall partition and refinement.

Definition 3.2 (partition and refinement). A partition of $\{1, \ldots, m\}$ is denoted by $P:=\left(q_{0}, \ldots, q_{r}\right)$ for some $r \in \mathbb{N}$, where $0=q_{0}<q_{1}<\ldots<q_{r}=m$. Given another partition $P^{\prime}=\left(q_{0}^{\prime}, \ldots, q_{r^{\prime}}^{\prime}\right)$, we say $P^{\prime}$ is a refinement of $P$ if $\left\{q_{0}, \ldots, q_{r}\right\} \subseteq\left\{q_{0}^{\prime}, \ldots, q_{r^{\prime}}^{\prime}\right\}$.

We then partition $Q^{*}$ into symmetric subsets based on the number of distinct $w_{k}$ 's.
Definition 3.3 (fragmentation/stratification of $\left.Q^{*}\right)$. Given $m_{0} \leq r \leq m$, a partition $P=\left(q_{0}, \ldots, q_{r}\right)$ and a permutation $\pi$ of $\{1, \ldots, m\}$. We define the following subsets of $Q^{*}$.
(a) $Q^{r}:=\left\{\theta^{*} \in Q^{*}: \operatorname{Card}\left\{w_{k}^{*}: 1 \leq k \leq m\right\}=r\right\}$, namely, it consists of points $\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q^{*}$ which has precisely $r$ distinct $w_{k}^{*}$ 's.
(b) $Q_{P}^{r}$ consists of $\theta^{*}=\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q^{*}$ such that $w_{k}^{*}=w_{q t}^{*}$ for all $q_{t-1}<k \leq q_{t}$ and $1 \leq t \leq r$, and $w_{q_{t}}^{*}=\bar{w}_{t}$ for all $1 \leq t \leq m_{0}$. For example, if $m_{0}=2, r=3, m=6$ and $P=(0,2,4,6)$ then $\theta^{*} \in Q_{P}^{3}$ if and only if it has the form

$$
\theta^{*}=\left(a_{1}^{*}, \bar{w}_{1}, a_{2}^{*}, \bar{w}_{1}, a_{3}^{*}, \bar{w}_{2}, a_{4}^{*}, \bar{w}_{2}, a_{5}^{*}, u, a_{6}^{*}, u\right)
$$

for some $u \in \mathbb{R}^{d}$.
(c) $Q_{P, \pi}^{r}:=\left\{\left(a_{\pi(k)}^{*}, w_{\pi(k)}^{*}\right)_{k=1}^{m}:\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q_{P}^{r}\right\}$. We call each $Q_{P, \pi}^{r}$ a brunch of $Q^{*}$.

The notations $Q_{P}^{r}$ and $Q_{P, \pi}^{r}$ make sense only when $P$ partitions $\{1, \ldots, m\}$ into $r$ subsets. Thus, when we write these notations we implicitly assume that $P$ satisfies this requirement. Then, clearly, $Q_{P, \pi}^{r}$ and $Q_{P}^{r}$ are both subsets of $Q^{r}$. Also, notice that for any $\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q_{P}^{m_{0}}\left(Q_{P, \pi}^{m_{0}}\right)$, $w_{k}^{*} \in\left\{\bar{w}_{j}: 1 \leq j \leq m\right\}$ for each $k$, while for any $\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q_{P}^{m}\left(Q_{P, \pi}^{m}\right), w_{k}^{*} \neq w_{j}^{*}$ whenever $k \neq j$.

An immediate observation is that for any permutation $\pi, Q_{P, \pi}^{r}$ is the image of $Q_{P}^{r}$ under a coordinate transformation, so they have the same geometric properties. To see this, let $\left\{e_{i}: 1 \leq i \leq(d+1) m\right\}$ be the standard basis of $\mathbb{R}^{(d+1) m}$. Clearly, $\pi$ induces a permutation $\tau$ on $\{1, \ldots,(d+1) m\}$ that maps $i$ to $\tau(i)=(d+1)(\pi(i)-1)+k$ if $i=k \bmod (d+1), 1 \leq k \leq d+1$. Let $\rho$ be the linear map on $\mathbb{R}^{(d+1) m}$ such that $\rho\left(e_{i}\right)=e_{\tau(i)}$ for all $1 \leq i \leq(d+1) m$. Then $Q_{P, \pi}^{r}=\rho\left(Q_{P}^{r}\right)$.

Since $Q_{P, \pi}^{r}$ is isometric to $Q_{P}^{r}, Q^{*}$ has a strong symmetry property. In particular, to study the structure of $Q_{P, \pi}^{r}$ we need only study that of $Q_{P}^{r}$. Similarly, given $r^{\prime}$, partition $P^{\prime}$ and permutation $\pi^{\prime}$, to investigate $\overline{Q_{P, \pi}^{r}} \cap \overline{Q_{P^{\prime}, \pi^{\prime}}^{r^{\prime}}}$ it suffices to investigate $\overline{Q_{P}^{r}} \cap \overline{Q_{P^{\prime}, \tau}^{r^{\prime}}}$, where $\tau=\pi^{-1} \circ \pi^{\prime}$. More importantly, to study the behavior of $R$ near $Q_{P, \pi}^{r}$ we need only study its behavior near $Q_{P}^{r}$.
Proposition 3.2 (fragmentation/stratification of $Q^{*}$, Theorem 3.1 in [11]). Suppose that Assumption 2.1 and Assumption 2.2 hold. Fix $m_{0} \leq r<r^{\prime} \leq m$.
(a) $Q^{*}=\bigcup_{r^{\prime \prime}=m_{0}}^{m} Q^{r^{\prime \prime}}$.
(b) $Q^{r} \cap Q^{r^{\prime}}=\emptyset$, and $Q^{r}=\bigcup_{P, \pi} Q_{P, \pi}^{r}$, the union taken over all possible partition $P$ 's and possible permutation $\pi$ 's. Thus, $Q^{*}=\cup_{r^{\prime \prime}=m_{0}}^{m} \cup_{P, \pi} Q^{r^{\prime \prime}}$.
(c) For any partition $P=\left(q_{0}, \ldots, q_{r}\right), \overline{Q_{P}^{r}}$ is an affine subspace of dimension $(m-r)+\left(r-m_{0}\right) d$. Furthermore, for any $\theta^{*} \in Q_{P}^{r}, \theta^{*}$ has a neighborhood $U \subseteq \mathbb{R}^{(d+1) m}$ such that $U \cap Q_{P}^{r}$ equals $U \cap \overline{Q_{P}^{r}}$.

Remark 3.5. By (b) and (c) and our remark above, the Hausdorff dimension of $Q^{r}$ is $(m-r)+$ $\left(r-m_{0}\right) d$.

Proof. (a) If $\theta^{*} \in Q^{*}$, we have

$$
g\left(\theta^{*}, x\right)-f^{*}(x)=\sum_{k=1}^{m} a_{k}^{*} \sigma\left(w_{k}^{*} \cdot x\right)-\sum_{k=1}^{m_{0}} \bar{a}_{k} \sigma\left(\bar{w}_{k} \cdot x\right)
$$

for all $x \in \mathbb{R}^{d}$. Suppose that $\operatorname{Card}\left\{w_{1}^{*}, \ldots, w_{m}^{*}\right\}=r^{\prime \prime}$. By Proposition 3.1, $\left\{w_{1}^{*}, \ldots, w_{m}^{*}\right\} \supseteq$ $\left\{\bar{w}_{1}, \ldots, \bar{w}_{m_{0}}\right\}$ and thus $r^{\prime \prime} \geq m_{0}$. Furthermore, if $w_{k_{1}}^{*}, \ldots, w_{k_{j}}^{*}=\bar{w}_{k}$ for some $k \in\left\{1, . ., m_{0}\right\}$, then we must have $\sum_{t=1}^{j} a_{k_{t}}^{*}=\bar{a}_{k}$; otherwise, we must have $\sum_{t=1}^{j} a_{k_{t}}^{*}=0$. This shows that $\theta^{*} \in Q^{r^{\prime \prime}}$. Since $m_{0} \leq r^{\prime \prime} \leq m$, it follows that $Q^{*}=\bigcup_{r^{\prime \prime}=m_{0}}^{m} Q^{r^{\prime \prime}}$.
(b) By definition, $Q^{r} \cap Q^{r^{\prime}}=\emptyset$. Fix $\theta^{*} \in Q^{r}$. We can find distinct weights $w_{k_{1}}^{*}, \ldots, w_{k_{r}}^{*}$ such that

$$
\left\{w_{k_{1}}^{*}, \ldots, w_{k_{r}}^{*}\right\} \supseteq\left\{\bar{w}_{1}, \ldots, \bar{w}_{m_{0}}\right\} .
$$

By reordering them if necessary, we may further assume that for any $t \in\left\{1, \ldots, m_{0}\right\}, w_{k_{t}}^{*}=\bar{w}_{t}$. For each $t \in\{1, \ldots, r\}$, let $w_{t(1)}^{*}, \ldots, w_{t\left(\delta_{t}\right)}^{*}$ be all the $w_{k}^{*}$ 's that are equal to $w_{k_{t}}^{*}$. Set $q_{t}^{\prime}=\sum_{j=1}^{t} \delta_{j}$; also set $q_{0}^{\prime}=0$. Let $P^{\prime}=\left(q_{0}^{\prime}, q_{1}^{\prime}, \ldots, q_{r}^{\prime}\right)$ and $\pi^{\prime}$ be the permutation satisfying $\pi^{\prime}\left(q_{t-1}+j\right)=t(j)$, $1 \leq j \leq \delta_{t}$, for all $t \in\{1, \ldots, r\}$. But then $\theta^{*} \in Q_{P^{\prime}, \pi^{\prime}}^{r}$, so $Q^{r}$ is the union of $Q_{P, \pi^{\prime}}^{r}$ 's. Since $r$ is arbitrary, we conclude from (a) that $Q^{*}=\cup_{r^{\prime \prime}=m_{0}}^{m} \cup_{P, \pi} Q_{P, \pi}^{r^{\prime \prime}}$.
(c) Clearly, $\theta^{*} \in Q_{P}^{r}$ if and only if it satisfies
i) $\sum_{k=q_{t-1}+1}^{q_{t}} a_{k}^{*}=\bar{a}_{t}$ for $1 \leq t \leq m_{0}$;
ii) $\sum_{k=q_{t-1}+1}^{q_{t}} a_{k}^{*}=0$ for $m_{0}<t \leq r$;
iii) $w_{q_{t-1}+1}^{*}=\ldots=w_{q t}^{*}=\bar{w}_{t}$ for $1 \leq t \leq m_{0}$;
iv) $w_{q_{t-1}+1}^{*}=\ldots=w_{q_{t}}^{*} \notin\left\{w_{q_{1}}^{*}, \ldots, w_{q_{t-1}}^{*}\right\}$ for $m_{0}<t \leq r$,
from which we can see that the closure of $Q_{P}^{r}$ consists of $\theta^{*} \in \mathbb{R}^{(d+1) m}$ with
i) $\sum_{k=q_{t-1}+1}^{q_{t}} a_{k}^{*}=\bar{a}_{t}$ for $1 \leq t \leq m_{0}$;
ii) $\sum_{k=q_{t-1}+1}^{q_{t}} a_{k}^{*}=0$ for $m_{0}<t \leq r$;
iii) $w_{q_{t-1}+1}^{*}=\ldots=w_{q_{t}}^{*}=\bar{w}_{t}$ for $1 \leq t \leq m_{0}$;
vi) $w_{q_{t-1}+1}^{*}=\ldots=w_{q_{t}}^{*} \in \mathbb{R}^{d}$ for $m_{0}<t \leq r$.

Fix $\tilde{\theta}^{*} \in Q_{P}^{r}$. Given $t \in\{1, \ldots, r\}$, let $A_{t}$ be the subspace of $\mathbb{R}^{q_{t}-q_{t-1}}$ such that for any $\left(z_{1}, \ldots, z_{q_{t}-q_{t-1}}\right) \in A_{t}, z_{1}+\ldots+z_{q_{t}-q_{t-1}}=0$, and $W_{t}$ be the subspace of $\prod_{k=1}^{q_{t}-q_{t-1}} \mathbb{R}^{d}=$ $\mathbb{R}^{\left(q_{t}-q_{t-1}\right) d}$, such that for any $\left(z_{1}, \ldots, z_{q_{t}-q_{t-1}}\right) \in W_{t}, z_{1}=z_{2}=\ldots=z_{q_{t}-q_{t-1}} \in \mathbb{R}^{d}$. By making the identification

$$
\begin{aligned}
\mathbb{R}^{(d+1) m} & \simeq \prod_{t=1}^{r} \prod_{k=1}^{q_{t}-q_{t-1}}\left(\mathbb{R} \times \mathbb{R}^{d}\right) \\
& \simeq \prod_{t=1}^{r}\left(\mathbb{R}^{\left(q_{t}-q_{t-1}\right.} \times \mathbb{R}^{\left(q_{t}-q_{t-1}\right) d}\right) \\
& =\prod_{t=1}^{r}\left\{\left(a_{q_{t-1}+1}, \ldots, a_{q_{t}}, w_{q_{t-1}+1}, \ldots, w_{q_{t}}\right) \in \mathbb{R}^{q_{t}-q_{t-1}} \times \mathbb{R}^{\left(q_{t}-q_{t-1}\right) d}\right\},
\end{aligned}
$$

we can see that

$$
\overline{Q_{P}^{r}} \simeq \tilde{\theta}^{*}+\prod_{t=1}^{m_{0}}\left(A_{t} \times\{0\}\right) \times \prod_{t=m_{0}+1}^{r}\left(A_{t} \times W_{t}\right) .
$$

Thus, $\overline{Q_{P}^{r}}$ is an affine subspace of dimension

$$
\sum_{t=1}^{m_{0}}\left(q_{t}-q_{t-1}-1\right)+\sum_{t=m_{0}+1}^{r}\left[\left(q_{t}-q_{t-1}-1\right)+d\right]=(m-r)+\left(r-m_{0}\right) d .
$$

Since $\overline{Q_{P}^{r}} \backslash Q_{P}^{r}$ consists of $\theta^{*} \in \overline{Q_{P}^{r}}$ such that for some $t \in\left\{m_{0}+1, \ldots, r\right\}$ we have $w_{q_{t}}^{*} \in$ $\left\{w_{q_{1}}^{*}, \ldots, w_{q_{t-1}}^{*}\right\}$, it is a close subset of $\mathbb{R}^{(d+1) m}$. Fix $\theta^{*} \in Q_{P}^{r}$. Thus, any neighborhood of $\theta^{*}$ that intersects trivially with $\overline{Q_{P}^{r}} \backslash Q_{P}^{r}$ satisfies $U \cap Q_{P}^{r}=U \cap \overline{Q_{P}^{r}}$.

Lemma 3.5 (branch intersection). Suppose that Assumptions 2.1 and 2.2 hold. Let $m_{0} \leq r \leq m$. Suppose that $P=\left(q_{0}, \ldots, q_{r}\right)$ and $P^{\prime}=\left(q_{0}^{\prime}, \ldots, q_{r^{\prime}}^{\prime}\right)$ are two partitions of $\{1, \ldots, m\}$. Also let $\pi$ be a permutation of $\{1, \ldots, m\}$. If there are indices $\left\{t_{1}, \ldots, t_{m^{\prime}}\right\}$ such that $\left\{\pi(k): q_{t_{i-1}}^{\prime}<k \leq q_{t_{i}}^{\prime}\right\}$ is not contained in $\left(q_{t-1}, q_{t}\right]$ for all $t$, then $\overline{Q_{P}^{r}} \cap \overline{Q_{P^{\prime}, \pi}^{r^{\prime}}} \subseteq \bigcup_{k=m_{0}}^{r-m^{\prime}} Q^{k}$. In particular, if $\theta^{*} \in Q_{P}^{r} \cap \overline{Q^{r^{\prime}}}$, then there is a partition $\tilde{P}=\left(\tilde{q}_{0}, \ldots, \tilde{q}_{r}\right)$ finer than $P$ and a permutation $\tilde{\pi}$ of $\{1, \ldots, m\}$ such that $\theta^{*} \in Q_{P}^{r} \cap \overline{Q_{\tilde{P}, \tilde{\pi}}^{r^{\prime}}}$.

Proof. Suppose that $\theta^{*} \in \overline{Q_{P}^{r}} \cap \overline{Q_{P^{\prime}, \pi}^{r}}$. Then there are sequences $\left\{\theta_{n}\right\}_{n=1}^{\infty}$ in $Q_{P}^{r}$ and $\left\{\theta_{n}^{\prime}\right\}_{n=1}^{\infty}$ in $Q_{P^{\prime}, \pi}^{r^{\prime}}$ that converge to $\theta^{*}$, respectively. Fix $1 \leq i \leq m^{\prime}$. By hypothesis there are distinct $j_{1}, j_{2} \in\{1, \ldots, r\}$ and $k_{1}, k_{2} \in\left\{q_{t_{i-1}+1}^{\prime}, \ldots, q_{t_{i}}^{\prime}\right\}$ such that

$$
q_{j_{1}-1}<\pi(k) \leq q_{j_{1}} ; \quad q_{j_{2}-1}<\pi\left(k_{2}\right) \leq q_{j_{2}} .
$$

It follows that

$$
\lim _{n \rightarrow \infty}\left(w_{q_{j_{1}}}\right)_{n}=\lim _{n \rightarrow \infty}\left(w_{\pi\left(k_{1}\right)}\right)_{n}^{\prime}=\lim _{n \rightarrow \infty}\left(w_{\pi\left(k_{2}\right)}\right)_{n}^{\prime}=\lim _{n \rightarrow \infty}\left(w_{q_{j_{2}}}\right)_{n}
$$

because for each $n$ we have $\left(w_{\pi\left(k_{1}\right)}\right)_{n}^{\prime}=\left(w_{\pi\left(k_{2}\right)}\right)_{n}^{\prime}$. Therefore,

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left(w_{k}\right)_{n}=w_{t}^{*}=\lim _{n \rightarrow \infty}\left(w_{s}\right)_{n} \tag{10}
\end{equation*}
$$

for all $q_{j_{1}-1}<k \leq q_{j_{1}}, q_{j_{2}-1}<s \leq q_{j_{2}}$ and all $t \in\left\{q_{j_{1}-1}+1, \ldots, q_{j_{1}}\right\} \cup\left\{q_{j_{2}-1}+1, \ldots, q_{j_{2}}\right\}$. This means any occurrence of such indices $t_{i}$ "reduces" the number of distinct $w_{t}^{*}$ 's of $\theta^{*}$ by 1 ; since there are $m^{\prime}$ such occurrences, the number of distinct $w_{t}^{*}$ 's of $\theta^{*}$ is at most $r-m^{\prime}$. It is also clear that (the possibly empty set) $\overline{Q_{P}^{r}} \cap \overline{Q_{P^{\prime}, \pi}^{r^{\prime}}} \subseteq Q^{*}$. Therefore, $\overline{Q_{P}^{r}} \cap \overline{Q_{P^{\prime}, \pi}^{r^{\prime}}} \subseteq \bigcup_{k=m_{0}}^{r-m^{\prime}} Q^{k}$.

Now assume that $\theta^{*} \in Q_{P}^{r} \cap \overline{Q^{r^{\prime}}}$, so there is some partition $\tilde{P}$ and permutation $\tilde{\pi}$ with $\theta^{*} \in$ $Q_{P}^{r} \cap \overline{Q_{\tilde{P}, \tilde{\pi}}^{r^{\prime}}}$. Also, since $\theta^{*} \in Q_{P}^{r}, \theta^{*} \in Q^{r}$. Then our proof above implies that for any index $j \in\left\{1, \ldots, r^{\prime}\right\}$, there is some $t \in\{1, \ldots, r\}$ with

$$
\left\{\tilde{\pi}(k): \tilde{q}_{j-1}<k \leq \tilde{q}_{j}\right\} \subseteq\left(q_{t-1}, q_{t}\right] .
$$

This means there is a permutation $\tau$ on $\{1, \ldots, m\}$ with

$$
\left\{\tau \tilde{\pi}(k): \tilde{q}_{j-1}<k \leq \tilde{q}_{j}\right\} \subseteq\left(q_{t-1}, q_{t}\right]
$$

and $\tau \tilde{\pi}\left(\tilde{q}_{j-1}\right)-\tau \tilde{\pi}\left(\tilde{q}_{j}\right)=1$ for all $1 \leq j \leq r^{\prime}$. Note that we always have $\tau \tilde{\pi}\left(\tilde{q}_{0}\right)=0$ and $\tau \tilde{\pi}\left(\tilde{q}_{r^{\prime}}\right)=m$. Replacing $\tilde{P}$ with the partition $\left(\tau \tilde{\pi}\left(\tilde{q}_{0}\right), \ldots, \tau \tilde{\pi}\left(\tilde{q}_{r^{\prime}}\right)\right)$ and replacing $\tilde{\pi}$ with $\tau^{-1}$ concludes the proof.

Example. Consider a three-neuron model fitting a one-neuron target function, i.e., $g(\theta, x)=$ $\sum_{k=1}^{3} a_{k} \sigma\left(w_{k} x\right)$ and $f(x)=\bar{a} \sigma(\bar{w} x)$. Up to permutations of $\{0,1,2,3\}, Q^{*}$ consists of the following branches:
(a) $Q_{\{0,3\}}^{1}$ : points of the form $\left(a_{1}, \bar{w}, a_{2}, \bar{w}, \bar{a}-\left(a_{1}+a_{2}\right), \bar{w}\right)$. This set has Hausdorff dimension 2 .
(b) $Q_{\{0,2,3\}}^{2}$ : points of the form $\left(a_{1}, \bar{w}, \bar{a}-a_{1}, \bar{w}, 0, w_{3}\right)$. This set has Hausdorff dimension $1+d$.
(c) $Q_{\{0,1,3\}}^{2}$ : points of the form $\left(\bar{a}, \bar{w}, a_{2}, w_{2},-a_{2}, w_{2}\right)$. This set has Hausdorff dimension $1+d$.
(d) $Q_{\{0,1,2,3\}}^{3}$ : points of the form $\left(\bar{a}, \bar{w}, 0, w_{2}, 0, w_{3}\right)$. This set has Hausdorff dimension $2 d$.

Clearly, the closure of each such branch is an affine subspace of $\mathbb{R}^{3(d+1)}$. Moreover, we have $\overline{Q_{\{0,2,3\}}^{2}} \cap \overline{Q_{\{0,1,3\}}^{2}} \subseteq Q_{\{0,3\}}^{1}, \overline{Q_{\{0,2,3\}}^{2}} \cap \overline{Q_{\{0,1,2,3\}}^{3}} \subseteq Q_{\{0,2,3\}}^{2}$, and $\overline{Q_{\{0,1,3\}}^{2}} \cap Q_{\{0,1,2,3\}}^{3} \subseteq Q_{\{0,1,3\}}^{2}$. See also the figures below for how different branches are related to one another.


Figure 4: Intersection of different $Q_{P}^{r}$ 's, view from " $w$-space". The left one shows the intersection of $Q_{\{0,1,2,3\}}^{3}$ (green surface), $Q_{\{0,1,3\}}^{2}$ (black line) and $Q_{\{0,3\}}^{1}$ (red dot). The right one shows the intersection of $Q_{P}^{2}$ 's. Clearly $Q^{2}$ consists of three (geometrically) identical branches (green surface) with same $r$ but different permutation. Their intersections are blue lines and the red dot, which are also identical up to permutation.


Figure 5: Intersection of branches $Q_{\{0,1,2,3\}}^{3}$ (green surface), $Q_{\{0,1,3\}}^{2}$ (tilted black line) and $Q_{\{0,3\}}^{1}$ (red dot), view from " $a$-space".

Definition 3.4 (deficient number). Let $P=\left(q_{0}, \ldots, q_{r}\right)$ be a partition of $\{1, \ldots, m\}$. We say that the deficient number of $P$ is $l(l \geq 0)$ if there are precisely $t_{1}, \ldots, t_{l} \in\left\{m_{0}+1, \ldots, r\right\}$ such that $q_{t_{j}}-q_{t_{j}-1}=1$ for all $1 \leq j \leq l$.

Clearly, if $P$ has deficient number $l>0$ and $\theta^{*}=\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{r} \in Q_{P}^{r}$, then there are exactly $l$ distinct $w_{k}^{*}$ 's whose corresponding $a_{k}^{*}=0$. As we shall see in Section 3 and 4 , the deficient number together with separating inputs provides information about the rank of the Hessian of $R$ at $Q_{P}^{r}$.

Lemma 3.6. Let $P=\left(q_{0}, \ldots, q_{r}\right)$ be a partition of $\{1, \ldots, m\}$. If $r \leq \frac{m+m_{0}}{2}$, the smallest possible deficient number of $P$ is $l=0$. If $r>\frac{m+m_{0}}{2}$, the smallest possible deficient number of $P$ is $l=2 r-m-m_{0}$.

Proof. When $r \leq \frac{m+m_{0}}{2}$ we can set $q_{t}=t$ for all $0 \leq t \leq m_{0}$ and $q_{t}-q_{t-1} \geq 2$ otherwise. Then clearly $l=0$.

When $r>\frac{m+m_{0}}{2}$, we must have $l \geq 1$. To get the smallest possible $l$, we need to make $q_{m_{0}}$ as small as possible in order to "leave room for" non-unique $w_{k}^{*}$ 's. Thus, still set $q_{t}=t$ for $0 \leq t \leq m_{0}$. This gives $q_{k}-q_{m_{0}}=m-m_{0}$. By definition of deficient number of $P$, there are $r-m_{0}-l$ distinct $t>m_{0}$ satisfying $q_{t}-q_{t-1} \geq 2$, whence

$$
2\left(k-m_{0}-l\right)+l \leq m-m_{0} .
$$

Solving the inequality, we see that $l \geq 2 k-m-m_{0}$. This completes the proof.

## 4 Loss Landscape Near $Q^{*}$

Lemma 4.1 ( $R$ is analytic). Let $\sigma$ be an analytic activation. Then $R$ defined as equation (2) is analytic.

Recall the definition of Morse-Bott, which are summarized from [7] and [4]. They will be a prototype when we study the local convergence of gradient flow near each branch of $Q^{*}$.

Definition 4.1 (Morse-Bott function, rephrased from [7] and [4]). Let $f: \mathbb{R}^{(d+1) m} \rightarrow \mathbb{R}$ be $a$ smooth function and let $M \subseteq(\nabla f)^{-1}\{0\}$ be a non-empty submanifold of $\mathbb{R}^{(d+1) m}$. Let $N M \rightarrow M$ be the normal bundle of $M$. Given $p \in M$, let $\operatorname{Hess}_{M} f(p): N_{x} M \times N_{x} M \rightarrow \mathbb{R}$ be the restriction of $\operatorname{Hess} f(p)$ to $N_{x} M$. $M$ is called a non-degenerate critical manifold of $f$ if $\operatorname{Hess}_{M} f(p)$ is nondegenerate for each $p \in M$, and such $f$ is called Morse-Bott (at $M$ ) if there is a neighborhood of $M$ restricted to which $(\nabla f)^{-1}\{0\}=M$.

For our notation, we view $\operatorname{Hess}_{M} f(x)$ as a map in Definition 4.1. Since each bilinear map corresponds to a matrix, we may also view $\operatorname{Hess}_{M} f(x)$ as a matrix, as we usually do for $\operatorname{Hess} f(x)$. In this case, $\operatorname{Hess}_{M} f(x)$ is simply the restriction of Hess $f(x)$ to a subspace of $\mathbb{R}^{(d+1) m}$.

Morse-Bott functions are not rare, the most trivial examples being $f(x, y)=x^{n}, n=2,3,4, \ldots$. Another important example is analytic function whose set of critical points are submanifold(s) and whose Hessian are non-degenerate at the normal spaces of it. Below we give more examples of them with the focus on neural network type functions.
(a) The linear regression model with $L^{2}$ loss

$$
R(\theta)=R(w)=\sum_{i=1}^{n}\left|g\left(w, x_{i}\right)-y_{i}\right|^{2}, \quad g\left(w, x_{i}\right)=w \cdot x
$$

is clearly a Morse-Bott function. This is because Hess $R$ is a constant matrix-valued function, which implies that $(\nabla R)^{-1}\{0\}$ is a union of affine spaces which are all orthogonal to $\operatorname{ker}($ Hess $R)$.
(b) Consider $\sigma(x)=e^{x}$ and $m=n=1$, namely,

$$
R(\theta)=(g(\theta, x)-y)^{2}, \quad g(\theta, x)=a e^{w \cdot x}
$$

where $x$ and $y$ are chosen and fixed. Since

$$
\frac{\partial R}{\partial a}=2\left(a e^{w \cdot x}-y\right) e^{w \cdot x}, \quad \frac{\partial R}{\partial w}=2 a\left(a e^{w \cdot x}-y\right) e^{w \cdot x} x
$$

we can see that $\nabla R(\theta)=0$ if and only if $\theta \in R^{-1}\{0\}$, if and only if $a=y e^{-w \cdot x}$. This shows that $M:=(\nabla R)^{-1}\{0\}=R^{-1}\{0\}$ and is a submanifold of codimension 1 in $\mathbb{R}^{d+1}$. Then we can calculate the Hessian of $R$ on it:

$$
\text { Hess } R(\theta)=2\left(\begin{array}{cccc}
e^{2 w \cdot x} & a e^{2 w \cdot x} x_{1} & \ldots & a e^{2 w \cdot x} x_{d} \\
a e^{2 w \cdot x} x_{1} & a^{2} e^{2 w \cdot x} x_{1}^{2} & \ldots & a^{2} e^{2 w \cdot x} x_{1} x_{d} \\
\vdots & \vdots & \ddots & \vdots \\
a e^{2 w \cdot x} x_{d} & a^{2} e^{2 w \cdot x} x_{1} x_{d} & \ldots & a^{2} e^{2 w \cdot x} x_{d}^{2}
\end{array}\right) \text {. }
$$

To simplify, if $v$ denotes the first column of $R(\theta)$, then Hess $R(\theta)=\left(v, a x_{1} v, \ldots, a x_{d} v\right)$, whence it has constant rank 1 on $M$. Since $T_{\theta} M \subseteq \operatorname{ker} \operatorname{Hess} R(\theta)$, we see that $\operatorname{Hess}_{M} R(\theta)$ must be non-degenerate.
(c) In fact, as we shall see in Lemma 4.2, under our finite-feature setting of 2-layer neural networks (see Assumption 2.2), for sufficiently many samples (number depending on $r \in\left\{m_{0}, \ldots, m\right\}$ ), $R$ is Morse-Bott on a dense, relatively open subset of $Q_{P}^{r}$ for $r \geq\left(m+m_{0}\right) / 2$ and many choices of the partition $P$.



Figure 6: Illustration of $f(x, y)=\left(x^{2}-y\right)^{2}$. The left one shows the graph of this function as a submanifold in $\mathbb{R}^{3}$ (blue manifold) and its zero set (red curve). The right one shows $f^{-1}\{0\} \subseteq \mathbb{R}^{2}$, the blue lines are the normal bundles along it, along which Hess $f$ is non-degenerate.

We then investigate how Hess $R$ near $Q^{*}$ depends on the choice of samples and the branches $Q_{P}^{r}$. In fact, we will give sample size thresholds for branches $Q_{P, \pi}^{r}$ at which $R$ becomes, or never becomes Morse-Bott. Meanwhile, we will give sample size thresholds for each branch $Q_{P, \pi}^{r}$ that makes it "separated", i.e., almost all points in $Q_{P, \pi}^{r}$ has a neighborhood $U \subseteq \mathbb{R}^{(d+1) m}$ such that $U \cap R^{-1}\{0\}=$ $U \cap Q_{P, \pi}^{r}$. Therefore, we obtain a hierarchical (with respect to sample size) characterization of $R^{-1}\{0\}$ near $Q^{*}$ when the system is overparametrized.

Lemma 4.2 (separation of $Q^{*}$ - overparametrized case). Suppose that Assumptions 2.1 and 2.2 hold. Let $n \in \mathbb{N}$. Suppose that $\left\{x_{i}\right\}_{i=1}^{(d+1) m}$ are separating inputs for $\left(\bar{w}_{1}, \ldots, \bar{w}_{m}\right)$ for an arbitrary choice of distinct $\bar{w}_{m_{0}}, \ldots, \bar{w}_{m} \in \mathbb{R}^{d} \backslash\left\{\bar{w}_{k}\right\}_{k=1}^{m_{0}}$. Given $m_{0} \leq r \leq m$ and $1 \leq n \leq(d+1) m$, define $R(\theta)=\sum_{i=1}^{n}\left|g\left(\theta, x_{i}\right)-f^{*}\left(x_{i}\right)\right|^{2}$ as before. Then the following results hold.
(a) When $n \leq(d+1) m_{0}$, any $\theta^{*} \in Q^{*}$ has an open neighborhood $U$ such that $R$ is Morse-Bott at $U \cap R^{-1}\{0\}$, namely, if $M:=U \cap R^{-1}\{0\}$ then for any $\tilde{\theta}^{*} \in U \cap R^{-1}\{0\}$, $\operatorname{Hess}_{M} R\left(\tilde{\theta}^{*}\right)$ is non-degenerate.
(b) Let $P=\left(q_{0}, \ldots, q_{r}\right)$ be a partition with deficient number $l$. When $n \leq r+(r-l) d$, there is an open $U \subseteq \mathbb{R}^{(d+1) m}$ such that $R$ is Morse-Bott at $U \cap R^{-1}\{0\}$, with $U \cap Q_{P}^{r} \subseteq U \cap R^{-1}\{0\}$. When $n \geq r+\left(m+m_{0}-r\right) d$, up to an arbitrarily small perturbation of samples, we have an open $U \subseteq \mathbb{R}^{(d+1) m}$ such that $R$ with $U \cap R^{-1}\{0\}=U \cap Q_{P}^{r}$.
(c) Let $P$ be a partition with deficient number $l$. Suppose that $n \geq r+\left(m+m_{0}-r\right) d$, the samples $\left\{x_{i}\right\}_{i=1}^{n}$, and open $U \subseteq \mathbb{R}^{(d+1) m}$ are chosen so that (b) holds. When $r<\left(m+m_{0}\right) / 2, R$ is not Morse-Bott at $U \cap Q_{P}^{r}$. When $r \geq\left(m+m_{0}\right) / 2$, the samples and $U$ can be chosen so that $R$ becomes Morse-Bott at $U \cap Q_{P}^{r}$ if and only if $l=2 r-m-m_{0}$.

Proof.
(a) By Proposition 3.2, $Q^{*}=\bigcup_{r=m_{0}}^{m} \bigcup_{P, \pi} Q_{P, \pi}^{r}$, so there are $k_{1}, \ldots, k_{m_{0}} \in\{1, \ldots, m\}$ such that $a_{k_{t}}^{*} \neq 0$ and $w_{k_{t}}^{*}=\bar{w}_{t}$ for all $1 \leq t \leq m_{0}$. By hypothesis, $\left\{x_{i}\right\}_{i=1}^{(d+1) m}$ are separating inputs for $\bar{w}_{1}, \ldots, \bar{w}_{m}$. Thus, for each $n \leq(d+1) m,\left\{x_{i}\right\}_{i=1}^{n}$ are separating inputs for $\bar{w}_{1}, \ldots, \bar{w}_{m}$; in particular, they are separating inputs for $\bar{w}_{1}, \ldots, \bar{w}_{m_{0}}$ as well. This implies that for any $1 \leq i \leq n$,

$$
\nabla_{\theta}\left(g\left(\theta^{*}, x_{i}\right)-f^{*}\left(x_{i}\right)\right)=: h_{i}\left(\theta^{*}\right) \neq 0
$$

and thus

$$
\operatorname{Hess}\left(g\left(\theta^{*}, x_{i}\right)-f^{*}\left(x_{i}\right)\right)^{2}=h_{i}\left(\theta^{*}\right) h_{i}\left(\theta^{*}\right)^{\mathrm{T}}
$$

has rank 1 , with $h_{i}\left(\theta^{*}\right)$ being an eigenvector for the only non-zero eigenvalue of this Hessian (because $\theta^{*} \in R^{-1}\{0\}$; in fact, this holds for any $\tilde{\theta}^{*} \in R^{-1}\{0\}$ ). Also, it implies that

$$
\begin{aligned}
& \operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(w_{k_{1}}^{*} \cdot x_{1}\right) & \ldots & \sigma\left(w_{k_{m_{0}}}^{*} \cdot x_{1}\right) & \sigma^{\prime}\left(w_{k_{1}}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(w_{k_{m_{0}}}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(w_{k_{1}}^{*} \cdot x_{n}\right) & \ldots & \sigma\left(w_{k_{m_{0}}}^{*} \cdot x_{n}\right) & \sigma^{\prime}\left(w_{k_{1}}^{*} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(w_{k_{m_{0}}}^{*} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&=\operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(\bar{w}_{1} \cdot x_{1}\right) & \ldots & \sigma\left(\bar{w}_{m_{0}} \cdot x_{1}\right) & \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(\bar{w}_{m_{0}} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(\bar{w}_{1} \cdot x_{n}\right) & \ldots & \sigma\left(\bar{w}_{m_{0}} \cdot x_{n}\right) & \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(\bar{w}_{m_{0}} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&= n .
\end{aligned}
$$

Therefore, $\left\{h_{i}\left(\theta^{*}\right)\right\}_{i=1}^{n}$ is a linearly independent set. By continuity of the $h_{i}$ 's, there is an open neighborhood $U$ of $\theta^{*}$ such that $\left\{h_{i}(\theta)\right\}_{i=1}^{n}$ is linearly independent for any $\theta \in U$. This implies that $M:=U \cap R^{-1}\{0\}$ is the transverse intersection of $n$ codimension- 1 submanifolds of $U$ :

$$
\left.\left(g\left(\cdot, x_{i}\right)-f^{*}\left(x_{i}\right)\right)\right|_{U} ^{-1}\{0\}, \quad 1 \leq i \leq n
$$

Therefore, $M$ has codimension $n$. On the other hand, when $\tilde{\theta}^{*} \in U \cap R^{-1}\{0\}$, each $h_{i}\left(\tilde{\theta}^{*}\right)$ is an eigenvector for the only non-zero eigenvalue of $\operatorname{Hess}\left(g\left(\tilde{\theta}^{*}, x_{i}\right)-f^{*}\left(x_{i}\right)\right)^{2}$. Since

$$
\operatorname{Hess} R\left(\tilde{\theta}^{*}\right)=\sum_{i=1}^{n} \operatorname{Hess}\left(g\left(\tilde{\theta}^{*}, x_{i}\right)-f^{*}\left(x_{i}\right)\right)^{2}
$$

the linear independence of $h_{i}\left(\tilde{\theta}^{*}\right)$ 's yields $\operatorname{rank}\left(\operatorname{Hess} R\left(\tilde{\theta}^{*}\right)\right)=n$. It follows that $\operatorname{Hess}_{M} R\left(\tilde{\theta}^{*}\right)$ is non-degenerate for each $\tilde{\theta}^{*} \in M$. Thus, $R$ is Morse-Bott at $M=U \cap R^{-1}\{0\}$.
(b) First assume that $n \leq r+(r-l) d$. Without loss of generality, we may let $q_{t}=t$ for all $m-l \leq t \leq m$; the general case can be reduced to this one by a rearrangement of indices. Since $r \leq m$ and $r-l \leq m$ and since the $\left\{x_{i}\right\}_{i=1}^{n}$ are separating inputs for $\bar{w}_{1}, \ldots, \bar{w}_{m},\left\{x_{i}\right\}_{i=1}^{n}$ are both separating inputs for $\bar{w}_{1}, \ldots, \bar{w}_{r}$ and $\bar{w}_{1}, \ldots, \bar{w}_{r-l}$.

Let $\theta^{*}=\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q_{P}^{r}$ be such that
i) $w_{q_{t}}^{*}=\bar{w}_{q_{t}}$ for all $1 \leq t \leq m$.
ii) For any $1 \leq t \leq m-l$, there is some $k_{t} \in\left\{q_{t-1}+1, \ldots, q_{t}\right\}$ with $a_{k_{t}}^{*} \neq 0$.

For simplicity of our computation below, we may also set $k_{t}=t$ when $m-l \leq t \leq m$. Then $a_{k_{t}}^{*} \neq 0$ if and only if $t \leq m-l$. Thus, by our hypothesis on the separating inputs, we have

\begin{aligned}
& \operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(w_{1}^{*} \cdot x_{1}\right) & \ldots & \sigma\left(w_{m}^{*} \cdot x_{1}\right) & a_{1}^{*} \sigma^{\prime}\left(w_{1}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & a_{m}^{*} \sigma^{\prime}\left(w_{m}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(w_{1}^{*} \cdot x_{n}\right) & \ldots & \sigma\left(w_{m}^{*} \cdot x_{n}\right) & a_{1}^{*} \sigma^{\prime}\left(w_{1}^{*} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & a_{m}^{*} \sigma^{\prime}\left(w_{m}^{*} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&=\operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(\bar{w}_{1} \cdot x_{1}\right) & \ldots & \sigma\left(\bar{w}_{r} \cdot x_{1}\right) & a_{k_{1}}^{*} \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & a_{k_{r}}^{*} \sigma^{\prime}\left(\bar{w}_{r} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(\bar{w}_{1} \cdot x_{n}\right) & \ldots & \sigma\left(\bar{w}_{r} \cdot x_{n}\right) & a_{k_{1}}^{*} \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & a_{k_{r}}^{*} \sigma^{\prime}\left(\bar{w}_{r} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&=\operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(\bar{w}_{1} \cdot x_{1}\right) & \ldots & \sigma\left(\bar{w}_{r} \cdot x_{1}\right) & a_{k_{1}}^{*} \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & a_{k_{r-l}}^{*} \sigma^{\prime}\left(\bar{w}_{r-l} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(\bar{w}_{1} \cdot x_{n}\right) & \ldots & \sigma\left(\bar{w}_{r} \cdot x_{n}\right) & a_{k_{1}}^{*} \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & a_{k_{r-l}^{*}}^{*}\left(\bar{w}_{r-l} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&=\operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(\bar{w}_{1} \cdot x_{1}\right) & \ldots & \sigma\left(\bar{w}_{r} \cdot x_{1}\right) & \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(\bar{w}_{r-l} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(\bar{w}_{1} \cdot x_{n}\right) & \ldots & \sigma\left(\bar{w}_{r} \cdot x_{n}\right) & \sigma^{\prime}\left(\bar{w}_{1} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & \sigma^{\prime}\left(\bar{w}_{r-l} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&= n .
\end{aligned}
$$

Argue in the same way as we do in (a), we show that $\operatorname{rank}\left(\operatorname{Hess} R\left(\theta^{*}\right)\right)=n$. Also, note that this is the largest possible rank of Hess $R\left(\theta^{*}\right)$ for $\theta^{*} \in Q_{P}^{r}$. By continuity, $\theta^{*} \in Q_{P}^{r}$ has an (open) neighborhood $U \subseteq \mathbb{R}^{(d+1) m}$ such that $\operatorname{rank}(\operatorname{Hess} R(\theta)) \geq n$ for all $\theta \in U$. On the other hand, the computation above shows that $M:=U \cap R^{-1}\{0\}$ is the transverse intersection of $n$ submanifolds in $\mathbb{R}^{(d+1) m}$, whence a submanifold having codimension $n$. By the proof in (a), it follows that for any $\tilde{\theta}^{*} \in M, \operatorname{Hess}_{M} R\left(\tilde{\theta}^{*}\right)$ is non-degenerate, namely, $R$ is Morse-Bott at $U \cap R^{-1}\{0\}$.
Now assume that $n \geq r+\left(m+m_{0}-r\right) d$. Following the proof of Corollary 3.4 with $E=Q^{*}$ and $s^{\prime}=r+\left(m+m_{0}-r\right) d$, we can perturb $x_{1}, \ldots, x_{s^{\prime}}$ arbitrarily small so that $\mathcal{A}_{Q^{*}, s^{\prime}}$ is contained in a countable (possibly finite) union of analytic submanifolds $\mathcal{M}_{1}, \mathcal{M}_{2}, \ldots$ of $\mathbb{R}^{(d+1) m}$ with
codimension $s^{\prime}=r+\left(m+m_{0}-r\right) d$. By Proposition 3.2 (c), $\overline{Q_{P}^{r}}$ is an affine subspace of codimension

$$
(d+1) m-\left[(m-r)+\left(r-m_{0}\right) d\right]=r+\left(m+m_{0}-r\right) d,
$$

and each $\theta^{*} \in Q_{P}^{r}$ has an open neighborhood $V$ such that $V \cap Q_{P}^{r}=V \cap \overline{Q_{P}^{r}}$. Thus, for any such $V, V \cap Q_{P}^{r}$ is a submanifold of codimension $r+\left(m+m_{0}-r\right) d$. In other words, the zero set of $\left.R\right|_{V}$, the restriction of $R$ to $V$, is contained in a countable union of submanifolds of codimension $r+\left(m+m_{0}-r\right) d$. Now by Lemma 3.3 (c), we can find an open $U \subseteq V$ such that $U \cap R^{-1}\{0\}=U \cap Q_{P}^{r} \neq \emptyset$.
(c) Because $R$ is constant zero at $U \cap Q_{P}^{r}, R$ is Morse-Bott at $U \cap Q_{P}^{r}$ if and only if $\operatorname{rank}(\operatorname{Hess} R)=$ $\operatorname{codim}\left(U \cap Q_{P}^{r}\right)$, which is also the largest possible rank of Hess $R$. We know that rank $\left(\operatorname{Hess} R\left(\theta^{*}\right)\right) \leq$ $r+(r-l) d$. Thus, if $R$ is Morse-Bott at $U \cap Q_{P}^{r}$, we must have

$$
r+(r-l) d \geq \operatorname{codim}\left(U \cap Q_{P}^{r}\right)=r+\left(m+m_{0}-r\right) d
$$

which yields $l \leq 2 r-m-m_{0}$. Since $l \geq 2 r-m-m_{0}$ (recall Lemma 3.6) and obviously $l \geq 0$, we conclude that $l=2 r-m-m_{0}$ and $r \geq\left(m+m_{0}\right) / 2$. In other words, when $r<\left(m+m_{0}\right) / 2$ or $l>2 r-m-m_{0}$, we can never make $R$ to be Morse-Bott at $U \cap Q_{P}^{r}$, no matter what samples and what $U$ we choose.
To prove the remaining part of (c), let $r \geq\left(m+m_{0}\right) / 2$ and let $l=2 r-m-m_{0}$ and $n \geq r+\left(m+m_{0}-r\right) d=r+(r-l) d$. By (b), there is some $\theta^{*}=\left(a_{k}^{*}, w_{k}^{*}\right)_{k=1}^{m} \in Q_{P}^{r}$ such that the separating inputs $\left\{x_{i}\right\}_{i=1}^{n^{\prime}}, n^{\prime}=r+(r-l) d$, satisfies

$$
\begin{aligned}
& \operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(w_{1}^{*} \cdot x_{1}\right) & \ldots & \sigma\left(w_{m}^{*} \cdot x_{1}\right) & a_{1}^{*} \sigma^{\prime}\left(w_{1}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & a_{m}^{*} \sigma^{\prime}\left(w_{m}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(w_{1}^{*} \cdot x_{n}\right) & \ldots & \sigma\left(w_{m}^{*} \cdot x_{n}\right) & a_{1}^{*} \sigma^{\prime}\left(w_{1}^{*} \cdot x_{n^{\prime}}\right) x_{n^{\prime}}^{\mathrm{T}} & \ldots & a_{m}^{*} \sigma^{\prime}\left(w_{m}^{*} \cdot x_{n^{\prime}}\right) x_{n^{\prime}}^{\mathrm{T}}
\end{array}\right) \\
&=r+\left(m+m_{0}-r\right) d .
\end{aligned}
$$

Since $R^{-1}\{0\}$ is contained in the zero set of the function $\theta \mapsto \sum_{i=1}^{n^{\prime}}\left|g\left(\theta, x_{i}\right)-f\left(x_{i}\right)\right|^{2}$, we must have

$$
\begin{aligned}
& \operatorname{rank}\left(\begin{array}{cccccc}
\sigma\left(w_{1}^{*} \cdot x_{1}\right) & \ldots & \sigma\left(w_{m}^{*} \cdot x_{1}\right) & a_{1}^{*} \sigma^{\prime}\left(w_{1}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} & \ldots & a_{m}^{*} \sigma^{\prime}\left(w_{m}^{*} \cdot x_{1}\right) x_{1}^{\mathrm{T}} \\
\vdots & \ddots & \vdots & \vdots & \ddots & \vdots \\
\sigma\left(w_{1}^{*} \cdot x_{n}\right) & \ldots & \sigma\left(w_{m}^{*} \cdot x_{n}\right) & a_{1}^{*} \sigma^{\prime}\left(w_{1}^{*} \cdot x_{n}\right) x_{n}^{\mathrm{T}} & \ldots & a_{m}^{*} \sigma^{\prime}\left(w_{m}^{*} \cdot x_{n}\right) x_{n}^{\mathrm{T}}
\end{array}\right) \\
&=r+(r-l) d=r+\left(m+m_{0}-r\right) d .
\end{aligned}
$$

Then, as in (b), there is an open neighborhood $U$ of $\theta^{*}$ such that $U \cap R^{-1}\{0\}=U \cap Q_{P}^{r}$ and $R$ is Morse-Bott at $U \cap R^{-1}\{0\}$.

Remark 4.1. All the three parts of lemma 4.2 can be strengthened. First, the results in (a) can be strengthened as: $R$ restricted to some open $U \subseteq \mathbb{R}^{(d+1) m}$ containing $Q^{*}$ is Morse-Bott at $U \cap R^{-1}\{0\}$. This can be proved by simply taking the union of the neighborhoods we construct for points in $Q^{*}$. For (b) and (c), we note that $U \subseteq \mathbb{R}^{(d+1) m}$ can be chosen so that $U \cap Q_{P}^{r}$ is a dense subset of $Q_{P}^{r}$. Indeed, the set of $\theta^{*} \in Q_{P}^{r}$ such that $a_{k_{t}}^{*} \neq 0$ for some $q_{t-1}<k_{t} \leq q_{t}$ whenever $t \leq m_{0}$ or $q_{t}-q_{t-1}>1$ is dense in $Q_{P}^{r}$, and each such point has a neighborhood on which (b) and/or (c) hold (for this we call $Q_{P}^{r}$ separated/Morse-Bott a.e.). Therefore, we
can simply let $U$ be the union of these neighborhoods. Moreover, the results in (b) and (c) also hold on $Q_{P, \pi}^{r}$, for any permutation $\pi$. This is because the geometry of $Q_{P, \pi}^{r}$ is the same as that of $Q_{P}^{r}$.


Figure 7: Separation of branches in overparameterized regime. In the figure, the $r$ and $r^{\prime}$ are given. As illustrated above, there is some open $U \subseteq \mathbb{R}^{(d+1) m}$ with $U \cap R^{-1}\{0\}=U \cap Q_{P^{\prime}}^{r^{\prime}}$, while this does not hold for $Q_{P}^{r}$. Also note that when $n \geq r^{\prime}+\left(m+m_{0}-r^{\prime}\right) d$, $Q_{P^{\prime}}^{r^{\prime}}$ we can only guarantee that it is separated a.e. (e.g., not at points covered by the green disk).

Lemma 4.3 (separation of $Q^{*}$ - underparametrized case). Suppose that Assumptions 2.1 and 2.2 hold.
(a) For any $N \in \mathbb{N}$ and any open $O \supseteq Q^{*}$, there is a finite collection of samples such that $\overline{B(0, N)} \cap R^{-1}\{0\}$ is contained in $O$.
(b) For any collection of inputs $\left\{x_{i}\right\}_{i=1}^{n}$ with $n>(d+1) m$ and any $\varepsilon>0$, we can perturb each $x_{i}$ with no more than $\varepsilon$-distance to obtain a collection of new inputs $\left\{x_{i}^{\prime}\right\}_{i=1}^{n}$, so that $R^{-1}\{0\}=Q^{*}$. In particular, for any $\theta \in \mathbb{R}^{(d+1) m}$ and any $n>(d+1) m$, almost all separating inputs $\left\{x_{i}^{\prime}\right\}_{i=1}^{n}$ for $\theta$ make $R^{-1}\{0\}=Q^{*}$.

Remark 4.2. Obviously, (a) follows from (b), but to demonstrate different techniques we use two ways to prove them.
Proof. (a) Fix $\theta \in \overline{B(0, N)} \backslash O$, which is a compact subset of $\mathbb{R}^{(d+1) m}$. Since $\theta \notin Q^{*}$, the set $\left\{x \in \mathbb{R}^{d}: g(\theta, x)=f(x)\right\}$ has $\lambda_{d}$-measure zero. Thus, we can find some $x_{\theta}$ such that $g\left(\theta, x_{\theta}\right) \neq$ $f\left(x_{\theta}\right)$; it follows by continuity that $g\left(\tilde{\theta}, x_{\theta}\right) \neq f\left(x_{\theta}\right)$ on an open subset $B_{\theta}$ of $\overline{B(0, N)}$. By compactness, we can find $\theta_{1}, \ldots, \theta_{n} \in \overline{B(0, N)} \backslash O$ such that $\overline{B(0, N)} \backslash O \subseteq \bigcup_{i=1}^{n} B_{\theta_{i}}$. Set $R=\sum_{i=1}^{n}\left|g\left(\theta, x_{\theta_{i}}\right)-f\left(x_{\theta_{i}}\right)\right|^{2}$, then $\overline{B(0, N)} \cap R^{-1}\{0\}$ is contained in $O$.
(b) Let $E:=\mathbb{R}^{(d+1) m} \backslash Q^{*}$. The function $(\theta, x) \mapsto g(\theta, x)-f(x)$ satisfies: for any $\theta \in E$, $x \mapsto g(\theta, x)-f(x)$ is not constant-zero. By Corollary 3.4, for almost all inputs $\left\{x_{i}^{\prime}\right\}_{i=1}^{n}$ and $R(\theta)=\sum_{i=1}^{n}\left|g\left(\theta, x_{i}^{\prime}\right)-f^{*}\left(x_{i}^{\prime}\right)\right|^{2}$, we have $E \cap R^{-1}\{0\}=\emptyset$, or $R^{-1}\{0\}=Q^{*}$. Given $w_{1}, \ldots, w_{m} \in \mathbb{R}^{d}$, the set of separating inputs for $w_{1}, \ldots, w_{m}$ is an open dense full-measure subset of $\mathbb{R}^{d m}$, whence its intersection with the inputs making $R^{-1}\{0\}=Q^{*}$ is also a fullmeasure subset of $\mathbb{R}^{d m}$. In particular, this means when $n \geq(d+1) m$, almost all separating inputs $\left\{x_{i}^{\prime}\right\}_{i=1}^{n}$ makes $R^{-1}\{0\}=Q^{*}$.

The discussion above are all based on the assumption that we know exactly what the target function is. In general, given samples $\left\{\left(x_{i}, y_{i}\right)\right\}_{i=1}^{n}$, the target functions $f^{*}$ with $f^{*}\left(x_{i}\right)=\sum_{k=1}^{m_{0}} \bar{a} \sigma(\bar{w}$. $\left.x_{i}\right)=y_{i}$ for all $i$ may not be unique. Luckily, the following proposition shows that for a dense set of separating inputs, the target function $f^{*}$ is uniquely determined. Thus, in general we only need to deal with one fixed target function.

Proposition 4.1 (uniqueness of representation). Suppose that Assumptions 2.1 and 2.2 hold. Given $n>(d+1) m_{0}$, for almost all separating inputs $\left\{x_{i}^{\prime}\right\}_{i=1}^{n}$ for $\bar{w}_{1}, \ldots, \bar{w}_{m_{0}}, \bar{\theta}=\left(\bar{a}_{k}, \bar{w}_{k}\right)_{k=1}^{m_{0}}$ is the unique global minimum of

$$
\mathbb{R}^{(d+1) m_{0}} \ni\left(a_{k}, w_{k}\right)_{k=1}^{m_{0}} \mapsto \sum_{i=1}^{n}\left|\sum_{k=1}^{m_{0}} a_{k} \sigma\left(w_{k} \cdot x_{i}\right)-f^{*}\left(x_{i}\right)\right|^{2} .
$$

Proof. Let $\left\{x_{i}\right\}_{i=1}^{n}$ be separating inputs for $\bar{w}_{1}, \ldots, \bar{w}_{m_{0}}$, using Lemma 4.2. Then use Lemma 4.3 to perturb the inputs $\left\{x_{i}\right\}$ arbitrarily small to obtain $\left\{x_{i}^{\prime}\right\}_{i=1}^{n}$ so that $\bar{\theta}$ becomes the unique global minimum of this function. Arguing in the same way as in Lemma 4.3, almost all separating inputs has this property.

## 5 Dynamics of Gradient Flow Near $Q^{*}$

Based on the geometry of $Q^{*}$ and functional properties of $R$ which we characterized above, we are now able to give the complete characterization of gradient flows near $Q^{*}$. In this section, we apply Lojasiewicz type inequalities to show the convergence of gradient flow near the critical points of a real analytic function $f$. Then we discuss whether each point in $(\nabla f)^{-1}\{0\}$ is the limit of some gradient flow of $f$. By Assumption 2.2 and/or our discussion in Section 4, all of them hold for $R$. Based on these results and Lemma 4.2, we further characterize the convergence rate, limiting direction, and generalization stability (whether $g\left(\lim _{t \rightarrow+\infty} \gamma(t), \cdot\right)$ is stable under perturbation of $\lim _{t \rightarrow+\infty} \gamma(t)$, see also Definition 5.1) of gradient flow near $Q^{*}$. Thus we prove Theorem 2.2, with a detailed understanding of the behavior of training dynamics near $R^{-1}\{0\}$.

### 5.1 Limiting Set of Gradient Flow

The following theorems are summarized from [7] and [1], which show that for an analytic function, any gradient flow near a local minimum converges.

Theorem 5.1 (Theorem 1 of $[7])$. Let $f: \mathbb{R}^{(d+1) m} \rightarrow \mathbb{R}$ be a real analytic function. For any critical point $p$ of $f$, there is a neighborhood $U$ of $p$ and constants $C>0, \mu \in[1 / 2,1)$ such that

$$
\begin{equation*}
|\nabla f(q)| \geq C|f(q)-f(p)|^{\mu} \tag{11}
\end{equation*}
$$

for any $q \in U$.
Theorem 5.2 (rephrased from Theorem 2.2 in [1]). Let $f: \mathbb{R}^{(d+1) m} \rightarrow \mathbb{R}$ be a real analytic function. Suppose that $p$ is a local minimum of $f$. Then $p$ has a neighborhood $U$ such that any non-constant gradient flow with initial value $x_{0} \in U$ converges. Moreover, any such gradient flow converges with some rate $0<\beta<1$ depending only on $p$. Namely, the curve length

$$
\begin{equation*}
l(\gamma[t,+\infty))=O\left(|f(\gamma(t))-f(p)|^{\beta}\right) \tag{12}
\end{equation*}
$$

as $t \rightarrow+\infty$, where $l(\gamma[t,+\infty))$ is the curve length of $\gamma[t,+\infty)$.

Proof. By Theorem 2.2 in [1], there is some open $U \subseteq \mathbb{R}^{(d+1) m}$ around $p$ such that for any gradient flow $\gamma:[0,+\infty) \rightarrow \mathbb{R}^{(d+1) m}$ with any $\gamma(0)=x_{0} \in U, \gamma$ converges and satisfies: there are some $c, \beta>0$ such that for any $0<t_{1}<t_{2}<+\infty$,

$$
\int_{t_{1}}^{t_{2}}|\dot{\gamma}(t)| d t \leq c\left|f\left(\gamma\left(t_{1}\right)\right)-f(p)\right|^{\beta} .
$$

Taking $t_{2} \rightarrow+\infty$, the monotonic convergence theorem gives $l(\gamma[t,+\infty)) \leq c \mid f\left(\gamma\left(t_{1}\right)-\left.f(p)\right|^{\beta}\right.$, as desired.

Thus, if $f$ is non-negative and $f^{-1}\{0\}$ is non-empty, then there is some open $U \subseteq \mathbb{R}^{(d+1) m}$ such that any gradient flow with initial value $x_{0} \in U$ converges. We then show the converse of the previous result, i.e., if $f$ is analytic near $N$, then any point in $N$ is the limit of a gradient flow, i.e., the limiting set of gradientflow contains $N$.

Proposition 5.1 (converse of Theorem 5.2). Let $f: \mathbb{R}^{(d+1) m} \rightarrow[0,+\infty)$ be continuously differentiable. Suppose that each point $x^{*} \in f^{-1}\{0\}$ has a neighborhood $U$ satisfying
(a) For any $p \in U$, the gradient flow starting at $p, \gamma_{p}$, converges to a point in $f^{-1}\{0\}$,
(b) There are some $C, \alpha>0$ such that for any $p \in U$, the curve length of $\gamma_{p}$ is bounded above by $C \operatorname{dist}\left(p, f^{-1}\{0\}\right)^{\alpha}$.

Then for any $x^{*} \in f^{-1}\{0\}$, there is a non-constant gradient flow converging to $x^{*}$ as $t \rightarrow+\infty$. In particular, we result holds when $f$ is analytic.

Proof. By hypothesis, there is a sequence $\left\{x_{j}^{*}\right\}_{j=1}^{\infty}$ and a sequence of non-constant gradient flow $\left\{\gamma_{j}\right\}_{j=1}^{\infty}$ such that $\lim _{t \rightarrow+\infty} \gamma_{j}(t)=x_{j}^{*} \in f^{-1}\{0\}$ and $\lim _{j \rightarrow \infty} x_{j}^{*}=x^{*} \in f^{-1}\{0\}$ (this can be proved in the same way as we do in the remark above). Choose a compact neighborhood $V \subseteq U$ of $x^{*}$ (so $\bar{V} \subseteq U)$. For each $j$, there is a largest $t_{j} \in \mathbb{R}$ such that $p_{j}:=\gamma_{j}\left(t_{j}\right) \in \partial V \cap \gamma_{j}$. Since $\partial V$ is compact, the sequence $\left\{p_{j}\right\}_{j=1}^{\infty}$ has an accumulation point $p$ in $V$. Moreover, hypothesis (b) implies that $p \notin f^{-1}\{0\}$. Since $p \in U$, the gradient flow $\gamma_{p}:[0,+\infty) \rightarrow \mathbb{R}^{(d+1) m}$ converges to a point in $f^{-1}\{0\}$ and its curve length is bounded by $C \operatorname{dist}\left(p, f^{-1}\{0\}\right)^{\alpha}$.

Let $l_{j}$ be the curve length of $\gamma_{j}\left[t_{j},+\infty\right)$ and $l$ be the curve length of $\gamma_{p}$. For each $j \in \mathbb{N}$, define $u_{j}:[0,+\infty) \rightarrow \mathbb{R}^{(d+1) m}$ by

$$
\begin{array}{rlrl}
u_{j}(0) & =p_{j} ; & \\
\dot{u}_{j}(t) & =-\frac{\nabla f\left(u_{j}(t)\right)}{\left|\nabla f\left(u_{j}(t)\right)\right|}, & & 0<t<l_{j} ; \\
u_{j}(t) & =u_{j}\left(l_{j}\right), & & t \geq l_{j} .
\end{array}
$$

Similarly, define $u:[0,+\infty) \rightarrow \mathbb{R}^{(d+1) m}$ by

$$
\begin{array}{ll}
u(0)=p & \\
\dot{u}(t)=-\frac{\nabla f(u(t))}{|\nabla f(u(t))|}, & 0<t<l ; \\
u(t)=u(l), & t \geq l .
\end{array}
$$

Note that the $u_{j}$ 's and $u$ are exactly the trajectories of their corresponding gradient flows.

Fix $\varepsilon>0$. Choose any $k \in \mathbb{N}$ with $\left|p-p_{k}\right|<\varepsilon$. There is some $T>0$ such that for any $t>T$, we have dist $\left(u_{j}(t), f^{-1}\{0\}\right)<\varepsilon^{1 / \alpha}$ an dist $\left(u(t), f^{-1}\{0\}\right)<\varepsilon^{1 / \alpha}$. Then the Grownwall's inequality and hypothesis (b) yield

$$
\begin{aligned}
\left|\lim _{s \rightarrow+\infty} u(s)-\lim _{s \rightarrow+\infty} u_{k}(s)\right| & \leq\left|\lim _{s \rightarrow+\infty} u(s)-u(t)\right|+\left|u(t)-u_{k}(t)\right|+\left|u_{k}(t)-p_{k}\right| \\
& \leq C \operatorname{dist}\left(u(t), f^{-1}\{0\}\right)^{\alpha}+\exp (t) \varepsilon+C \operatorname{dist}\left(u_{k}(t), f^{-1}\{0\}\right)^{\alpha} \\
& \leq(2 C+\exp (t)) \varepsilon .
\end{aligned}
$$

Since $\{p\} \cup\left\{p_{j}\right\}_{j=1}^{\infty}$ is a subset of the bounded $\partial V$, it follows that $\sup \left\{l, l_{1}, l_{2}, \ldots\right\}<+\infty$. In particular, there is some $T^{\prime}>0$ such that the $u_{j}$ 's and $u$ are all constant on $T^{\prime}$. Thus, we actually have

$$
\left|\lim _{s \rightarrow+\infty} u(s)-\lim _{s \rightarrow+\infty} u_{k}(s)\right| \leq\left(2 C+\exp \left(T^{\prime}\right)\right) \varepsilon
$$

Letting $\varepsilon \rightarrow 0$, we see that $\lim _{s \rightarrow+\infty} u(s)=\lim _{k \rightarrow \infty} x_{k}^{*}=x^{*}$, which means $u$, and thus $\gamma_{p}$, converges to $x^{*}$. This shows the first part of the proposition.

Now suppose that $f$ is analytic. Let $x^{*} \in f^{-1}\{0\}$. By Theorem 5.2. there is a bounded neighborhood $U$ of $x^{*}$ and some $\beta>0$ such that for any $p \in U, \gamma_{p}$ converges at rate $\beta$. Since $U$ is bounded and $f$ is smooth, $f$ is Lipschitz on $U$, so there is some $L>0$ with $\left|f\left(z_{1}\right)-f\left(z_{2}\right)\right| \leq L\left|z_{1}-z_{2}\right|$ for any $z_{1}, z_{2} \in U$. It follows that the curve length $l\left(\gamma_{p}\right)$ of any such $\gamma_{p}$ can be estimated by

$$
l\left(\gamma_{p}\right) \leq \tilde{C}|f(p)|^{\beta} \leq \tilde{C}|f(p)-0|^{\beta} \leq \tilde{C} L^{\beta}|p-q|^{\beta}
$$

where $\tilde{C}>0$ is some constant, and $q \in f^{-1}\{0\}$ is any point satisfying $|p-q|=\operatorname{dist}\left(p, f^{-1}\{0\}\right)$ ( $q$ exists because $f^{-1}\{0\}$ closed). This shows $f$ satisfies the hypotheses and the desired result follows.

We now apply the results above to our loss function $R$. By Lemma 4.1, $R$ is analytic whenever $\sigma$ is a generic activation, whence Theorems 5.1, 5.2 and Proposition 5.1 hold for $R$.

### 5.2 Convergence Rate and Limiting Direction of gradient flow

In this part we investigate the convergence rate and limiting direction of a gradient flow near any (fixed) $Q_{P, \pi}^{r}$ for $r \in\left\{m_{0}, \ldots, m\right\}$, given that $Q_{P, \pi}^{r}$ is separated. As we shall see, the behavior of gradient flows depends largely on $r$ and partition $P$.

Let's begin with two general lemmas. Consider a dynamical system of the form

$$
\begin{align*}
& \dot{x}(t)=f(x(t), y(t), z(t)) \\
& \dot{y}(t)=H(z(t)) y(t)+g(x(t), y(t), z(t)) ;  \tag{13}\\
& \dot{z}(t)=m(x(t), y(t), z(t)),
\end{align*}
$$

where $(x, y, z) \in \mathbb{R}^{c} \times \mathbb{R}^{s} \times \mathbb{R}^{p}$ and $f, g, H, m$ are $C^{3}$ functions, and there is an open $U_{p} \subseteq \mathbb{R}^{p}$ such that for any $z \in U_{p}$, we have i) $H(z)$ is negative definite, ii) $f(0,0, z)=g(0,0, z)=m(0,0, z)=0$, and iii) when $x, y \rightarrow 0$ the maps $f, g, m$ can be estimated as

$$
\begin{aligned}
f(x, y, z) & =O\left(|x|^{2}+|y|^{2}\right) ; \\
g(x, y, z) & =O\left(|x|^{2}+|y|^{2}\right) ; \\
m(x, y, z) & =O\left(|x|^{2}+|y|^{2}\right) .
\end{aligned}
$$

Specifically, when $c=0$, we identify the space $\mathbb{R}^{0} \times \mathbb{R}^{s} \times \mathbb{R}^{p}$ with $\mathbb{R}^{s} \times \mathbb{R}^{p}$, so that the system (13) becomes

$$
\begin{aligned}
& \dot{y}(t)=H(z(t)) y(t)+g(y(t), z(t)) \\
& \dot{z}(t)=m(y(t), z(t))
\end{aligned}
$$

Moreover, for each $z \in U_{p}$, We also consider the following simplified system

$$
\begin{align*}
\dot{x}(t) & =f(x(t), y(t), z) \\
\dot{y}(t) & =H(z) y(t)+g(x(t), y(t), z) \tag{14}
\end{align*}
$$

Lemma 5.1. Consider the system (13). Let $\gamma=(x, y, z):[0,+\infty) \rightarrow \mathbb{R}^{c+s+l}$ be a solution curve to (13) that converges to some $\left(0,0, z^{*}\right) \in \mathbb{R}^{c+s+l}$ with $z^{*} \in U_{p}$.
(a) If $c=0$ then $\left|z(t)-z^{*}\right|=O\left(|y(t)|^{2}\right)$ as $t \rightarrow+\infty$.
(b) If $c>0$ and $\underline{\lim }_{t \rightarrow+\infty, x(t) \neq 0} \frac{|y(t)|}{|x(t)|^{2}}<+\infty$, then $|y(t)|=O\left(|x(t)|^{2}\right)$ as $t \rightarrow+\infty$.

Proof. (a) Since $\dot{y}(t)=H(z(t)) y(t)+O\left(|y(t)|^{2}\right)$ when $c=0$, for each $1 \leq j \leq s,\left|y_{j}(t)\right|$ decreases to 0 at exponential rate. Thus, there is some $T>0$ such that for any $\zeta \geq t>T$ and for any $1 \leq j \leq s$, we have $\left|y_{j}(t)\right|<1,\left|\dot{y}_{j}(t)\right| \geq \frac{\left|\lambda_{j}\right|}{2}\left|y_{j}(t)\right|$, and

$$
D_{1}\left|y_{j}(t)\right| e^{-\mu_{1}(\zeta-t)} \leq\left|y_{j}(\zeta)\right| \leq D_{2}\left|y_{j}(t)\right| e^{-\mu_{2}(\zeta-t)}
$$

for some $D_{1}, D_{2} \geq 0, \mu_{1}, \mu_{2}>0$ depending only on $T$. These assumptions imply that $y_{j}$ is decreasing and $y_{j}=0$ or the sign of $y_{j}$ does not change on $(T,+\infty)$. Thus, for any $t>T$,

$$
\begin{aligned}
\int_{t}^{\infty} y_{j}^{2}(\zeta) d \zeta & \leq \sum_{k=\lfloor t\rfloor}^{\infty} y_{j}^{2}(k) \\
& \leq\left(\sum_{k=\lfloor t\rfloor}^{\infty} y_{j}(k)\right)^{2} \\
& \leq \frac{4}{\lambda_{j}^{2}}\left(\int_{\lfloor t\rfloor}^{\infty} \dot{y}_{j}(\zeta) d \zeta\right)^{2}=\frac{4}{\lambda_{j}^{2}} y_{j}^{2}(\lfloor t\rfloor)
\end{aligned}
$$

where $\lfloor t\rfloor$ denotes the largest integer smaller than $t$. But then

$$
\left|y_{j}(t)\right| \geq D_{1}\left|y_{j}(\lfloor t\rfloor)\right| e^{-\mu_{1}(t-\lfloor t\rfloor)} \geq D_{1}\left|y_{j}(\lfloor t\rfloor)\right| e^{-\mu_{1}}
$$

This means there is some $C_{j}>0$ with $y_{j}^{2}(\lfloor t\rfloor) \leq C_{j} y_{j}^{2}(t)$ whenever $t>T$. Since $m(x, y, z)=$ $O\left(|y|^{2}\right)$ for $z \in U_{p}$, there is some $C_{z}>0$ with $|\dot{z}(t)| \leq C_{z}|y(t)|^{2}$ for $t>T$. It follows that when $t>T$,

$$
\begin{aligned}
\left|z(t)-z^{*}\right| \leq \int_{t}^{\infty}|\dot{z}(\zeta)| d \zeta & \leq C_{z} \sum_{j=1}^{s} \int_{t}^{\infty} y_{j}^{2}(\zeta) d \zeta \\
& \leq C_{z} \sum_{j=1}^{s} \frac{4}{\lambda_{j}^{2}} C_{j} y_{j}^{2}(t) \\
& \leq\left(C_{z} \sum_{j=1}^{s} \frac{4}{\lambda_{j}^{2}} C_{j}\right)|y(t)|^{2}
\end{aligned}
$$

which shows that $\left|z(t)-z^{*}\right|=O\left(|y(t)|^{2}\right.$ as $t \rightarrow+\infty$.
(b) Without loss of generality, assume that $H\left(z^{*}\right)$ is diagonal, and its eigenvalues are $\lambda_{1}, \ldots, \lambda_{s}$; denote $\lambda:=\frac{1}{2} \max _{1 \leq j \leq s} \lambda_{j}$. Let $C_{y}>0$ be a constant such that $|g(x, y, z)| \leq C_{y}\left(|x|^{2}+|y|^{2}\right)$. Consider the quotient

$$
Q(t):=\frac{|y(t)|^{2}}{|x(t)|^{4}}
$$

for $t \in[0,+\infty)$ such that $x(t) \neq 0$. Suppose that (b) does not hold, then $\overline{\lim }_{t \rightarrow+\infty, x(t) \neq 0} Q(t)=$ $+\infty$. By hypothesis, $\underline{\lim }_{t \rightarrow+\infty, x(t) \neq 0} Q(t)<+\infty$, so by continuity of $Q$ we can find a $k_{0}>0$ and a sequence $\left\{t_{n}\right\}_{n=1}^{\infty} \rightarrow+\infty$ such that $\left|\lambda k_{0}\right|>2 C_{y}$, and $\left|y\left(t_{n}\right)\right|=k_{0}\left|x\left(t_{n}\right)\right|^{2}, \dot{Q}\left(t_{n}\right) \geq 0$ for each $n \in \mathbb{N}$. We will show that this gives a contradiction. A straightforward computation yields

$$
\dot{Q}(t)=\frac{2 \sum_{j=1}^{s} y_{j}(t) \dot{y}_{j}(t)}{|x(t)|^{4}}-\frac{4|y(t)|^{2} \sum_{j=1}^{c} x_{j}(t) \dot{x}_{j}(t)}{|x(t)|^{6}}
$$

when $x(t) \neq 0$. As $t_{n} \rightarrow+\infty$, both $x\left(t_{n}\right), y\left(t_{n}\right) \rightarrow 0$ by hypothesis, thus for sufficiently large $t_{n}$ we have $\left|y\left(t_{n}\right)\right| \leq\left|x\left(t_{n}\right)\right|$ and $\left|(H(z(t)) y(t))_{j}\right| \geq \frac{\left|\lambda_{j}\right|}{2}\left|y_{j}(t)\right|$ for all $j \in\{1, \ldots, s\}$. Then for such $t_{n}$,

$$
\begin{aligned}
\sum_{j=1}^{s} y_{j}\left(t_{n}\right) \dot{y}_{j}\left(t_{n}\right) & =\left\langle y\left(t_{n}\right), H(z(t)) y\left(t_{n}\right)\right\rangle+\left\langle y\left(t_{n}\right), g\left(x\left(t_{n}\right), y\left(t_{n}\right), z\left(t_{n}\right)\right)\right\rangle \\
& \leq \lambda\left|y\left(t_{n}\right)\right|^{2}+\left|y\left(t_{n}\right)\right| C_{y}\left(\left|x\left(t_{n}\right)\right|^{2}+\left|y\left(t_{n}\right)\right|^{2}\right) \\
& \leq \lambda\left|y\left(t_{n}\right)\right|^{2}+2 C_{y}\left|y\left(t_{n}\right)\right|\left|x\left(t_{n}\right)\right|^{2} \\
& \leq k_{0}\left(\lambda k_{0}+2 C_{y}\right)\left|x\left(t_{n}\right)\right|^{4} .
\end{aligned}
$$

Since $\lambda<0$, by our assumption we have $k_{0}\left(\lambda k_{0}+2 C_{y}\right)<0$. On the other hand, for any $n \in \mathbb{N}$,

$$
\begin{aligned}
\left|y\left(t_{n}\right)\right|^{2}\left|\sum_{j=1}^{s} x_{j}\left(t_{n}\right) \dot{x}_{j}\left(t_{n}\right)\right| & \leq k_{0}^{2}\left|x\left(t_{n}\right)\right|^{4}\left|x\left(t_{n}\right)\right|\left|\dot{x}\left(t_{n}\right)\right| \\
& \leq k_{0}^{2}\left|x\left(t_{n}\right)\right|^{5} m\left(x\left(t_{n}\right), y\left(t_{n}\right), z\left(t_{n}\right)\right) \\
& =O\left(\left|x\left(t_{n}\right)\right|^{7}\right)
\end{aligned}
$$

Therefore,

$$
\dot{Q}\left(t_{n}\right) \leq 2 k_{0}\left(\lambda k_{0}+2 C_{y}\right)-O\left(\left|x\left(t_{n}\right)\right|\right)
$$

from which we can see that if $N \in \mathbb{N}$ is chosen so that for any $n>N, O\left(\left|x\left(t_{n}\right)\right|\right) \leq k_{0}\left(-\lambda k_{0}-\right.$ $\left.2 C_{y}\right)$, we would have $\dot{Q}\left(t_{n}\right) \leq k_{0}\left(\lambda k_{0}+2 C_{y}\right)<0$, contradicting our assumption that $\dot{Q}\left(t_{n}\right)>0$ for each $n$.

Remark 5.1. When $c>0$, we do not know much about the relationship between $\left|z(t)-z^{*}\right|$ and $|x(t)|$. The best estimate we know is, as $t \rightarrow+\infty$,

$$
\begin{aligned}
\left|z(t)-z^{*}\right| \leq \int_{t}^{\infty}|\dot{z}(s)| d s & \leq C \int_{t}^{\infty}\left(|x(s)|^{2}+|y(s)|^{2}\right) d s \\
& \leq C^{\prime} \int_{t}^{\infty}|x(s)|^{2} d s
\end{aligned}
$$

for some $c \geq 0$ depending on $m$, and any $C^{\prime}>C$.

Then we focus on systems with $c>0$. Note that when $c=0,|y(t)|=O\left(e^{-\beta t}\right)$ for some $\beta>0$; this is just similar to the Morse-Bott case.

Lemma 5.2. Consider the systems (13) and (14) with $c>0$. Suppose that for each $z \in U_{p},(0,0, z)$ is an asymptotically stable equilibrium of (14). Let $\gamma=(x, y, z):[0,+\infty) \rightarrow \mathbb{R}^{c+s+p}$ be a solution curve to (13) that converges to some $\left(0,0, z^{*}\right) \in \mathbb{R}^{c+s+p}$ with $z^{*} \in U_{p}$. Then there is some $\beta>0$ such that $|y(t)|=O\left(|x(t)|^{2}+e^{-\beta t}\right)$ as $t \rightarrow+\infty$. Moreover, $\beta$ can be made as close to the largest negative eigenvalue of $H$ as possible.

Proof. Given $z \in U_{p}$, let $h_{z}$ be the center manifold of the equation (14). In this way we obtain a family of center manifolds $\left\{h_{z}: z \in U_{p}\right\}$. Since $\lim _{t \rightarrow+\infty} \gamma(t)=\left(0,0, z^{*}\right)$ and since $z^{*} \in U_{p}$, there is some $T>0$ such that for any $t \geq T, h_{z(t)}(x(t))$ exists. Define a map $\delta:[T,+\infty) \rightarrow \mathbb{R}^{s}$, $\delta(t)=y(t)-h_{z(t)}(x(t))$. Clearly,

$$
\dot{\delta}(t)=H(z(t)) y(t)+g(x(t), y(t), z(t))-D h_{z(t)}(x(t)) f(x(t), y(t), z(t)) .
$$

Since $h_{z(t)}$ is a center manifold for equation (14) with $z=z(t)$, we have

$$
H(z(t)) h_{z(t)}(x(t))+g(x(t), y(t), z(t))=D h_{z(t)}(x(t)) f(x(t), y(t), z(t)) .
$$

Since $y(t), h_{z(t)}(x(t)) \rightarrow 0$ as $t \rightarrow+\infty$; this, together with $f(x, y, z(t))=O\left(|x|^{2}+|y|^{2}\right)$ and $g(x, y, z(t))=O\left(|x|^{2}+|y|^{2}\right)$, yields

$$
\begin{aligned}
& g(x(t), y(t), z(t))-g\left(x(t), h_{z(t)}(x(t)), z(t)\right) \\
- & D h_{z(t)}(x(t))\left[f\left(x(t), h_{z(t)}(x(t)), z(t)\right)-f(x(t), y(t), z(t))\right]=o(|\delta(t)|) .
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
\dot{\delta}(t)= & H(z(t)) \delta(t)+\left[g(x(t), y(t), z(t))-g\left(x(t), h_{z(t)}(x(t)), z(t)\right)\right] \\
& -D h_{z(t)}(x(t))\left[f\left(x(t), h_{z(t)}(x(t)), z(t)\right)-f(x(t), y(t), z(t))\right] \\
= & H(z(t)) \delta(t)+o(|\delta(t)|) .
\end{aligned}
$$

Since each $H(z(t))$ is negative definite and $\lim _{t \rightarrow+\infty} z(t)=z^{*}$, the continuity of $H$ implies that $\delta(t)$ decreases at exponential rate; in particular, there are $C, \beta>0$ such that $|\delta(t)| \leq C_{1} e^{-\beta t}$.

Then we show that $\beta$ can be made as close to the largest negative eigenvalue of $H$ as possible. For each $z \in U_{p}$ the curve $\left(x(t), h_{z}(x(t)), z\right)$ is just the solution to the system

$$
\begin{align*}
\dot{x}(t) & =f(x(t), y(t), z(t)) \\
\dot{y}(t) & =H(z(t)) y(t)+g(x(t), y(t), z(t)) ;  \tag{15}\\
\dot{z}(t) & =0
\end{align*}
$$

with an initial value $\left(x(0), h_{z}(x(0)), z\right)$. Thus, by the smooth dependence of an autonomous system on initial value, we see that $h(x, z):=h_{z}(x)$ is twice continuously differentiable in both $x$ and $z$. Intuitively, this family of center manifolds deform smoothly.

Since $f(x, y, z)=O\left(|x|^{2}+|y|^{2}\right)$ and $g(x, y, z)=O\left(|x|^{2}+|y|^{2}\right)$ for each fixed $z \in U_{p}$, if $\psi_{i}=$ $\sum_{j, k} \alpha_{i j k} x_{j} x_{k}$ and $\psi=\left(\psi_{1}, \ldots, \psi_{s}\right)^{\mathrm{T}}$, we have $\psi(x)=O\left(|x|^{2}\right)$ and $D \psi(x)=O(|x|)$, whence

$$
\begin{aligned}
& D \psi(x) f(x, \psi(x), z)-H \psi(x)-g((x, \psi(x), z) \\
= & O(|x|) O\left(|x|^{2}+O\left(|x|^{4}\right)\right)-O\left(|x|^{2}\right)+O\left(|x|^{2}+O\left(|x|^{4}\right)\right) \\
= & O\left(|x|^{2}\right) .
\end{aligned}
$$

Thus, the approximation theory of center manifold (see e.g., Section 2.5 of [3]) implies that $h_{z}(x)=$ $O\left(|x|^{2}\right)$. In particular, since $h$ is smooth in both $x$ and $z$, there is some $C_{2}>0$ such that for any $x$ close to 0 and $z$ close to $z^{*},\left|h_{z}(x)\right| \leq C_{2}|x|^{2}$. It follows that for $t$ large,

$$
\begin{equation*}
|y(t)| \leq\left|h_{z(t)}(x(t))\right|+C_{1} e^{-\beta t} \leq C_{2}|x(t)|^{2}+C_{1} e^{-\beta t} \tag{16}
\end{equation*}
$$

Let $\lambda$ be the largest eigenvalue of $H\left(z^{*}\right)$. Fix $\varepsilon>0$. In the proof above we have shown that $\dot{\delta}(t)=H(z(t)) \delta(t)+o(|\delta(t)|)$ and $\delta(t) \rightarrow 0, z(t) \rightarrow z^{*}$ as $t \rightarrow+\infty$. Thus, there is some $T>0$ such that for any $t \geq T,\langle H(z(t)) \delta(t), \delta(t)\rangle \geq(-\lambda-\varepsilon)|\delta(t)|$ and the $o(|\delta(t)|) \leq \varepsilon|\delta(t)|$. It follows that

$$
|\dot{\delta}(t)| \geq\|H \delta(t)|-\varepsilon| \delta(t)\| \geq(-\lambda-2 \varepsilon)|\delta(t)|,
$$

and thus $\delta(t)=O\left(e^{(\lambda+2 \varepsilon) t}\right)$ as $t \rightarrow+\infty$.
Remark 5.2. Observe that if $|x(t)| \geq \Omega\left(e^{-\frac{\mu}{2} t}\right)$ for some $\mu>-\lambda$, then $|y(t)|=O\left(|x(t)|^{2}\right)$ as $t \rightarrow+\infty$. In general, we may not expect that the trajectory of $\gamma$ is "biased" towards $h_{z(t)}$ in the sense that $|y(t)|=O\left(|x(t)|^{2}\right)$ as $t \rightarrow+\infty$, but if the tail length

$$
l_{x y}(\gamma)(t):=\int_{t}^{\infty} \sqrt{|\dot{x}(s)|^{2}+|\dot{y}(s)|^{2}} d s=\Omega\left(e^{-\mu t}\right)
$$

for some $\mu<-\lambda$, we have $|y(t)|=O\left(|x(t)|^{2}\right)$. To see this, choose any $\beta>0$ as in Lemma 5.2 with $\beta>\mu$. We have $|\dot{x}(s)|^{2}+|\dot{y}(s)|^{2} \leq C|x(s)|^{4}+C^{\prime} e^{-2 \beta s}$ and thus

$$
\begin{aligned}
D e^{-\mu t} \leq l_{x y}(\gamma)(t) & \leq \int_{t}^{\infty} \sqrt{C}|x(s)|^{2}+\sqrt{C^{\prime}} e^{-\beta s} d s \\
& \leq \sqrt{C} \int_{t}^{\infty}|x(s)|^{2} d s+\frac{\sqrt{C^{\prime}}}{\beta} e^{-\beta t}
\end{aligned}
$$

for some constants $C, C^{\prime}, D>0$. Thus, there is a sequence $\left\{t_{n}\right\}_{n=1}^{\infty}$ diverging to $\infty$ and some $D^{\prime}>0$ such that for any $n \in \mathbb{N},\left|x\left(t_{n}\right)\right| \geq D^{\prime} e^{-\frac{\mu}{2} t_{n}}$. Using $|y(t)|=O\left(|x(t)|^{2}+e^{-\beta t}\right)$, we have $\underline{l i m}_{t \rightarrow+\infty, x(t) \neq 0} \frac{|y(t)|}{|x(t)|^{2}}<+\infty$. By Lemma 5.1, this implies $|y(t)|=O\left(|x(t)|^{2}\right)$, as desired.


Figure 8: Limiting direction of the solution curve (blue curve) of system (13) with $c>0$. Viewed from $x y$-plane, this curve is "biased towards" $y$-direction, which is non-degenerate.

Let $\theta \in \mathbb{R}^{(d+1) m}$, consider Hess $R(\theta)$. Let $V_{s} \subseteq \mathbb{R}^{(d+1) m}$ be the largest subspace such that for any $v \in V_{s} \backslash\{0\},\langle v$, Hess $R(\theta) v\rangle \neq 0$. Let $V_{p} \subseteq\left(V_{s}\right)^{\perp}$ be the largest subspace such that $\left.R\right|_{\theta+V_{p}}$ is locally constant near $\theta$. Let $V_{c}=\left(V_{s}+V_{p}\right)^{\perp}$. Define linear operators on $\mathbb{R}^{(d+1) m}$ :
i) $\pi_{s}$ be the orthogonal projection onto $V_{s}$.
ii) $\pi_{c}$ be the orthogonal projection onto $V_{c}$.
iii) $\pi_{p}$ be the orthogonal projection onto $V_{p}$.

Finally, given the decomposition $\mathbb{R}^{(d+1) m}:=V_{c} \oplus V_{s} \oplus V_{p}$ as above, we write any element $\theta \in \mathbb{R}^{(d+1) m}$ as $\theta:=(x, y, z)$, i.e., $x=\pi_{c}(\theta), y=\pi_{s}(\theta)$ and $z=\pi_{p}(\theta)$.
Example. Suppose that $R(x, y, z)=x^{2}+y^{4}+0 z$. Then

$$
\operatorname{Hess} R(x, y, z)=\left(\begin{array}{ccc}
2 & 0 & 0 \\
0 & 12 y^{2} & 0 \\
0 & 0 & 0
\end{array}\right) \text {. }
$$

Thus, for Hess $R(0,0,0), V_{s}, V_{c}, V_{p}$ are the $x$-axis, $y$-axis and $z$-axis of $\mathbb{R}^{3}$.
We are now ready to apply the lemmas above to the training dynamics of $R$. First we investigate the properties of the gradient flows near $R^{-1}\{0\}$, especially when it is near $Q^{*}$. Recall that $Q^{*}=$ $\bigcup_{r=m_{0}}^{m}\left(\bigcup_{P, \pi} Q_{P, \pi}^{r}\right)$, whence by an appropriate coordinate transformation the gradient flow near some $Q_{P, \pi}^{r}$ becomes system (13). Since $Q_{P, \pi}^{r}$ has the same geometry as $Q_{P}^{r}$, we will only prove the cases for $Q_{P}^{r}$ 's; the results then apply to $Q_{P, \pi}^{r}$ for all permutation $\pi$ 's on $\{1, \ldots, m\}$.

Theorem 5.3 (Local properties of gradient flow). For $\theta^{*} \in R^{-1}\{0\}$, let $\gamma$ denote any gradient flow converging to $\theta^{*}$. Let $\pi_{s}, \pi_{c}, \pi_{p}$ be defined as above. Given $m_{0} \leq r \leq m$ and $n$ separating inputs of $R$. The following results hold.
(a) Suppose that $n \geq m+\left(m+m_{0}-r\right) d$ and $\frac{m_{0}+m}{2} \leq r \leq m$. If $P$ has deficient number $l=2 r-m-m_{0}$, then for almost all $\theta^{*} \in Q_{P}^{r}, \gamma$ converges to $\theta^{*}$ at linear rate and satisfies $\left|\pi_{p}\left(\gamma(t)-\theta^{*}\right)\right|=O\left(\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|\right)$ as $t \rightarrow+\infty$. When $n \leq(d+1) m_{0}$, the same result holds for any $\theta^{*} \in R^{-1}\{0\}$ sufficiently close to $Q^{*}$.
(b) Suppose that $n \geq m+\left(m+m_{0}-r\right) d$. If $m_{0} \leq r<\frac{m+m_{0}}{2}$ or the deficient number $l$ of $P$ satisfies $l<2 r-m-m_{0}$, then for almost all $\theta^{*} \in Q_{P}^{r}$, if

$$
l(\gamma)(t):=\int_{t}^{\infty} \sqrt{\left|\pi_{c}\left(\gamma(\zeta)-\theta^{*}\right)\right|^{2}+\left|\pi_{s}\left(\gamma(\zeta)-\theta^{*}\right)\right|^{2}} d \zeta=\Omega\left(e^{-\mu t}\right)
$$

for some $\mu$ greater than the largest negative eigenvalue of $\operatorname{Hess} R\left(\theta^{*}\right)$, then $\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|=$ $O\left(\left|\pi_{c}\left(\gamma(t)-\theta^{*}\right)\right|^{2}\right)$ as $t \rightarrow+\infty$.
(c) In particular, (a) holds for all $\theta^{*} \in Q_{P}^{m}$ and (b) holds for all $\theta^{*} \in Q_{P}^{m_{0}}$.

Proof. (a) First assume that $n \geq m+\left(m+m_{0}-r\right) d$ and $\frac{m_{0}+m}{2} \leq r \leq m$. For almost all $\theta^{*} \in Q_{P}^{r}$ we have

$$
s=\operatorname{rank}\left(\operatorname{Hess} R\left(\theta^{*}\right)\right)=\operatorname{codim} Q_{P}^{r}
$$

Fix any such $\theta^{*}$. Find some $U \ni \theta^{*}$ open, such that for any $\tilde{\theta}^{*} \in U \cap Q_{P}^{r}$ we have $\operatorname{rank} \operatorname{Hess} R\left(\tilde{\theta}^{*}\right)=\operatorname{rank}\left(\operatorname{Hess} R\left(\theta^{*}\right)\right)$. Let $\tau: U \rightarrow \mathbb{R}^{s} \times \mathbb{R}^{(d+1) m-s}$ be a (smooth) coordinate transformation such that $\tau\left(U \cap Q_{P}^{r}\right) \subseteq\{0\} \times \mathbb{R}^{p}$, where $p=(d+1) m-s$, and let
$\left(0, z^{*}\right):=\tau\left(\theta^{*}\right)$, where $0 \in \mathbb{R}^{s}$ and $z^{*} \in \mathbb{R}^{p}$. In this way we obtain the system (13) with $c=0$ and $U_{p}=\tau(U)$. By Remark 5.1, $\tau(\gamma(t))=(y(t), z(t))$ converges to $\left(0, z^{*}\right)$ at linear rate and by Lemma 5.1 (a), $\left|z(t)-z^{*}\right|=O\left(|y(t)|^{2}\right)$. By transforming back to the original coordinate system, we see that $\gamma(t)$ converges at linear rate and $\left|\pi_{p}\left(\gamma(t)-\theta^{*}\right)\right|=O\left(\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|\right)$.
Now assume that $n \leq(d+1) m_{0}$. By Lemma $4.2($ a $)$, there is some open $U \subseteq \mathbb{R}^{(d+1) m}$ such that $Q^{*} \subseteq U \cap R^{-1}\{0\}$ and $R$ is Morse-Bott at $U \cap R^{-1}\{0\}$. In particular this means by applying a coordinate transformation we obtain the system (13) with $c=0$. Arguing in the same way as above, we can see that $\gamma(t) \rightarrow \theta^{*}$ at linear rate and $\left|\pi_{p}\left(\gamma(t)-\theta^{*}\right)\right|=O\left(\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|\right)$, as $t \rightarrow+\infty$.
(b) Let $s$ be the maximum of $\operatorname{rank}\left(\operatorname{Hess} R\left(\theta^{*}\right)\right)$ for $\theta^{*} \in Q_{P}^{r}$. By Lemma 4.2, for almost all $\theta^{*} \in Q_{P}^{r}$ we have rank $\left(\operatorname{Hess} R\left(\theta^{*}\right)\right)=s$. Fix any such $\theta^{*}$. Find some $U \ni \theta^{*}$ open, such that for any $\tilde{\theta}^{*} \in U \cap Q_{P}^{r}$, rank $\left(\operatorname{Hess} R\left(\tilde{\theta}^{*}\right)\right)=s$. Since $r<\frac{m_{0}+m}{2}$, by Lemma $4.2 s<\operatorname{codim} Q_{P}^{r}$, so $c:=\operatorname{codim} Q_{P}^{r}-s>0$. Also define $p:=\operatorname{dim} Q_{P}^{r}$.
At each $\tilde{\theta}^{*} \in Q_{P}^{r}$ there is a coordinate transformation $\tau_{\tilde{\theta}^{*}}: U \cap\left(\tilde{\theta}^{*}+\left(Q_{P}^{r}\right)^{\perp}\right) \rightarrow \mathbb{R}^{c} \times \mathbb{R}^{s}$, parametrized smoothly by $\tilde{\theta}^{*}$, such that
i) $\tau\left(U \cap\left(\tilde{\theta}^{*}+V_{s}\right)\right)=\tau\left(\tilde{\theta}^{*}\right)+\{0\} \times \mathbb{R}^{s}$, where $V_{s} \subseteq \mathbb{R}^{(d+1) m}$ is the largest subspace such that for any $v \in V_{s} \backslash\{0\},\left\langle v, \operatorname{Hess} R\left(\tilde{\theta}^{*}\right) v\right\rangle \neq 0$.
ii) $\tau\left(U \cap\left(\tilde{\theta}^{*}+V_{c}\right)\right)=\tau\left(\tilde{\theta}^{*}\right)+\mathbb{R}^{c} \times \mathbb{R}^{s}$, where $V_{c}=\left(V_{s}+Q_{P}^{r}\right)^{\perp}$.

Since the eigenvectors of Hess $R(\theta)$ depends smoothly on $\theta$, these $\tau_{\tilde{\theta}}$ 's can be combined into an embedding $\tau: U \rightarrow \mathbb{R}^{c} \times \mathbb{R}^{s} \times \mathbb{R}^{p}$. In this way we obtain system (13) with $U_{P}=\tau(U)$. By Lemma 5.1 (b) and Remark 5.2, we thus have $|y(t)|=O\left(|x(t)|^{2}\right)$. Now apply $\tau^{-1}: \operatorname{ran} \tau \rightarrow U$ to see that $\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|=O\left(\left|\pi_{c}\left(\gamma(t)-\theta^{*}\right)\right|^{2}\right)$.
(c) When $r \in\left\{m_{0}, m\right\}$ and $n \geq r+\left(m+m_{0}-r\right) d$, the rank of Hess $R$ is constant on $Q_{P}^{r}$.

Since $R$ is continuous, $\lim _{t \rightarrow+\infty} R(\gamma(t))$ exists for any gradient flow $\gamma$ sufficiently close to $R^{-1}\{0\}$. We then investigate the convergence rates of $R(\gamma)$. In particular, we show that even if $\gamma$ does not converge at linear rate, $R(\gamma)$ decreases to 0 much more quickly compared to the convergence of $\gamma$.

Corollary 5.1 (local properties of loss). With the notations in Theorem 5.3, given $m_{0} \leq r \leq m$ and $n$ separating inputs of $R$. The following results hold.
(a) Suppose that $n \geq m+\left(m+m_{0}-r\right) d$ and $\frac{m_{0}+m}{2} \leq r \leq m$ and $P$ has deficient number $l=2 r-m-m_{0}$. For almost all $\theta^{*} \in Q_{P}^{r}$, we have $R(\gamma(t)) \rightarrow R\left(\theta^{*}\right)=0$ at linear rate as $t \rightarrow+\infty$. When $n \leq(d+1) m_{0}$, the same result holds for any $\theta^{*} \in R^{-1}\{0\}$ sufficiently close to $Q^{*}$.
(b) Suppose $m_{0} \leq r<\frac{m+m_{0}}{2}$ and the deficient number $l$ of $P$ satisfies $l<2 r-m-m_{0}$. For almost all $\theta^{*} \in Q_{P}^{r}$, there is some $\beta>0$ such that $R(\gamma(t))=O\left(\left|\gamma(t)-\theta^{*}\right|^{4}+e^{-\beta t}\right)$ for all sufficiently large $t$.

Proof.
(a) Since $R$ is analytic, it is in particular locally Lipschitz, so for any bounded open $U \subseteq \mathbb{R}^{(d+1) m}$ containing $\theta^{*}$, there is a constant $c>0$ with

$$
R(\theta)=\left|R(\theta)-R\left(\theta^{*}\right)\right| \leq c\left|\theta-\theta^{*}\right| .
$$

By Theorem 5.3, for almost all $\theta^{*} \in Q_{P}^{r}$ we have $\left|\gamma(t)-\theta^{*}\right| \leq c^{\prime} e^{-\beta t}$ for some $c^{\prime}, \beta>0$. Therefore,

$$
R(\gamma(t)) \leq c\left|\gamma(t)-\theta^{*}\right| \leq c c^{\prime} e^{-\beta t}
$$

In other words, $R(\gamma(t)) \rightarrow 0$ at linear rate as $t \rightarrow+\infty$.
Now assume that $n \leq(d+1) m_{0}$. Then there is some open $U \subseteq \mathbb{R}^{(d+1) m}$ such that $Q^{*} \subseteq$ $U \cap R^{-1}\{0\}$ and $R$ is Morse-Bott at $U \cap R^{-1}\{0\}$. Thus, for any $\theta^{*} \in U \cap R^{-1}\{0\}$ we can apply Theorem 5.3 and argue in the same way as above to deduce that $R(\gamma(t)) \rightarrow 0$ at linear rate as $t \rightarrow+\infty$.
(b) By Theorem 5.3 (b), we actually have for almost all $\theta^{*} \in Q_{P}^{r},\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|=O\left(\mid \pi_{c}(\gamma(t)-\right.$ $\left.\theta^{*}\right)\left.\right|^{2}+e^{-\mu t}$ ) as $t \rightarrow+\infty$. for some $\mu>0$. Using the Talyor expansion of $R$ near $\theta^{*}$, we can write

$$
\begin{aligned}
R(\theta)=R\left(\theta^{*}\right) & +\left\langle\nabla R\left(\theta^{*}\right), \theta-\theta^{*}\right\rangle \\
& +\frac{1}{2}\left\langle\operatorname{Hess} R\left(\theta^{*}\right)\left(\theta-\theta^{*}\right), \theta-\theta^{*}\right\rangle+O\left(\left|\theta-\theta^{*}\right|^{3}\right) .
\end{aligned}
$$

Since $R$ is analytic and $R \geq 0$, we can further write and simplify it as

$$
\begin{aligned}
R(\theta) & =\frac{1}{2}\left\langle\operatorname{Hess} R\left(\theta^{*}\right)\left(\theta-\theta^{*}\right), \theta-\theta^{*}\right\rangle+O\left(\left|\theta-\theta^{*}\right|^{4}\right) \\
& =\frac{1}{2}\left\langle\operatorname{Hess} R\left(\theta^{*}\right) \pi_{s}\left(\theta-\theta^{*}\right), \pi_{s}\left(\theta-\theta^{*}\right)\right\rangle+O\left(\left|\theta-\theta^{*}\right|^{4}\right) \\
& \leq \frac{1}{2}\left\|\operatorname{Hess} R\left(\theta^{*}\right)\right\|\left|\pi_{s}\left(\theta-\theta^{*}\right)\right|^{2}+O\left(\left|\theta-\theta^{*}\right|^{4}\right) .
\end{aligned}
$$

Since $\lim _{t \rightarrow+\infty} \gamma(t)=\theta^{*}$, it follows that for sufficiently large $t$ we have

$$
\begin{aligned}
R(\gamma(t)) & \leq \frac{1}{2}\left\|\operatorname{Hess} R\left(\theta^{*}\right)\right\|\left|\pi_{s}\left(\gamma(t)-\theta^{*}\right)\right|^{2}+O\left(\left|\gamma(t)-\theta^{*}\right|^{4}\right) \\
& =\frac{1}{2}\left\|\operatorname{Hess} R\left(\theta^{*}\right)\right\| O\left(\left(\left|\pi_{c}\left(\gamma(t)-\theta^{*}\right)\right|^{2}+e^{-\mu t}\right)^{2}\right)+O\left(\left|\gamma(t)-\theta^{*}\right|^{4}\right) \\
& =\frac{1}{2}\left\|\operatorname{Hess} R\left(\theta^{*}\right)\right\| O\left(\left(\left|\gamma(t)-\theta^{*}\right|^{2}+e^{-\mu t}\right)^{2}\right)+O\left(\left|\gamma(t)-\theta^{*}\right|^{4}\right) \\
& =O\left(\left|\gamma(t)-\theta^{*}\right|^{4}+e^{-\beta t}\right),
\end{aligned}
$$

where $\beta>0$ is some constant depending on $\mu$. This proves the desired result.

For clarity, we summarize the results of Theorem 5.3 and Corollary 5.1 in the table below.

Table 1: Convergence rates of gradient flows and loss near $Q_{P, \pi}^{r}$, for given $m_{0} \leq r \leq m$, a partition $P$ with deficient number $l$ and a permutation $\pi$. In the table, "GF" refers to gradient flow. The third column focuses on the convergence rate of gradient flow (near $Q_{P, \pi}^{r}$ ) and the last column indicates convergence of loss under gradient flow
, i.e., convergence of $R(\gamma(t))$ for a gradient flow $\gamma$.

### 5.3 Local Recovery by Gradient Flow

We end this section with a discussion about whether the points in $Q^{*}$ are stable under perturbation, i.e., by slightly perturbing a $\theta^{*} \in Q^{*}$ to some $\theta_{0}$, do we have $\lim _{t \rightarrow \infty} \gamma_{\theta_{0}}(t) \in Q^{*}$ ? To study this problem, we first define "recovery stability" below which works for a more general case.

Definition 5.1 (recovery stability). Let $\theta^{*} \in \mathbb{R}^{(d+1) m}$. We say $\theta^{*}$ is recovery stable if there is some $\delta>0$ such that for any $\theta_{0} \in B\left(\theta^{*}, \delta\right)$, the gradient flow $\gamma_{\theta_{0}}:[0,+\infty) \rightarrow \mathbb{R}^{(d+1) m}$ with initial value $\theta_{0}$ converges and satisfies

$$
g\left(\theta^{*}, x\right)=g\left(\lim _{t \rightarrow+\infty} \gamma_{\theta_{0}}(t), x\right)
$$

for all $x \in \mathbb{R}^{d}$. If this is not true, we say $\theta^{*}$ is recovery unstable. Given a subset $E \subseteq \mathbb{R}^{(d+1) m}, E$ is called recovery stable if every $\theta^{*} \in E$ is recovery stable; otherwise, we say $E$ is recovery unstable.

The following result is an immediate corollary of Theorem 5.3, Lemma 4.2 and Lemma 4.3. It fully explains when a point in $Q^{*}$ is recovery (un)stable.

Theorem 5.4 (recovery stability). Given $m_{0} \leq r \leq m$, partition $P$ and permutation $\pi$ and separating inputs $\left\{x_{i}\right\}_{i=1}^{n}$. Then no point in $Q_{P, \pi}^{r}$ is recovery stable when $n \leq r+(r-l) d$ ( $l$ is the deficient number of $P$ ), and almost all points in $Q_{P, \pi}^{r}$ are recovery stable when $n \geq r+\left(m+m_{0}-r\right) d$. Moreover, all points in $Q^{*}$ are recovery stable when $n>(d+1) m$, i.e., $Q^{*}$ is recovery stable.

Proof. The desired result follows from the observation that a point $\theta^{*} \in Q^{*}$ is recovery stable if and only if it has a neighborhood $U \subseteq \mathbb{R}^{(d+1) m}$ with $U \cap R^{-1}\{0\}=U \cap Q^{*}$.

So fix any $\theta^{*} \in Q^{*}$. First assume that this is not true, there is a sequence $\left\{\theta_{n}^{*}\right\}_{n=1}^{\infty}$ in $R^{-1}\{0\} \backslash Q^{*}$ converging to $\theta^{*}$, whence by perturbing $\theta^{*}$ to any $\theta_{n}^{*}$, the gradient flow $\gamma_{\theta_{n}^{*}}$ starting at $\theta_{n}^{*}$ clearly satisfies

$$
\lim _{t \rightarrow \infty} \gamma_{\theta_{n}}(t)=\theta_{n}^{*} \in R^{-1}\{0\} \backslash Q^{*}
$$

Conversely, if such a $U$ exists, we can shrink it if necessary, so that for any $\theta_{0} \in U, \gamma_{\theta_{0}}$ satisfies

$$
\lim _{t \rightarrow \infty} \gamma_{\theta_{0}}(t) \in Q^{*}
$$

Since any two point in $Q^{*}$ represent the same model $f^{*}$, we clearly have

$$
g\left(\theta^{*}, x\right)=f^{*}(x)=g\left(\lim _{t \rightarrow \infty} \gamma_{\theta_{0}}(t), x\right)
$$

for all $x \in \mathbb{R}^{d}$. Therefore, $\theta^{*}$ is recovery stable.

Below we use Theorem 5.4 to illustrate when the points in each branch $Q^{r}$ of $Q^{*}$ become recovery stable as sample size increases.

Table 2: How sample size determines the recovery stability of points in branches of $Q^{*}$. The left-most column lists the important sample size thresholds. As shown in the table, when $n \leq(d+1) m_{0}$, no point in $Q^{*}$ is recovery stable. For any $r \in\left\{m_{0}, \ldots, m\right\}$, when the sample size $n \geq r+\left(m+m_{0}-r\right) d$, in each of the branches $Q^{r}, Q^{r+1}, \ldots, Q^{m}$ almost all points are recovery stable. Moreover, when $n>(d+1) m$, i.e., when we are in underparameterized regime, any point in $Q^{*}$ is recovery stable.

## 6 Conclusion and Discussion

In this paper, we propose the local recovery problem for neural networks, and solve it under the two-layer neural network setting. Specifically, we investigate (a) the structure of loss landscape of two-layer NNs near global minima, (b) determine the relationship between separation of perfect global minima and sample size, and (c) characterize the gradient flows around it. Our work uncovers some mysteries of the generalization property of two-layer neural networks at overparameterization. Meanwhile, we introduce and develop novel tools for analyzing more general neural networks (and other machine learning models) in the future.
