Three-body decays of $\pi_2(1670)$ and $\rho_3(1690)$ via the Sill distribution

Abstract

We present the three-body decays for the resonances $\pi_2(1670)$ and $\rho_3(1690)$. We use an effective model based on the flavor symmetry and have assumed the Sill distribution for describing the lie-shape of intermediate unstable resonances. The vector-pseudoscalar meson decay channel is considered as an intermediate step to explain the decay of three-pseudoscalar meson channels.

1. INTRODUCTION

The light ground state mesons, such as $\pi_2(1670)$ and $\rho_3(1690)$ (with $J^{PC} = 2^{-+}$, 3⁻⁻), according to the Particle Data Group (PDG) [\[1\]](#page-3-0), are well-established. Their total decay widths are $\Gamma_{\pi_2(1670)}^{\text{tot}} = 258^{+8}_{-9}$ MeV and $\Gamma_{\rho_3(1690)}^{\rm tot} = 161 \pm 10$ MeV. Experimental data for the decay processes of these resonances was used in [\[2](#page-3-1)[–5\]](#page-3-2) to test the corresponding spontaneous and anomalous breaking features of QCD symmetries used in the extended Linear Sigma Model (eLSM) [\[6\]](#page-3-3). We list some of the vector-pseudoscalar meson decay data of these resonances in Tab. [1.](#page-1-0)

In this work, we present novel results for three-body decays of these resonances based on the effective model constructed in Refs. $[2, 4]$ $[2, 4]$. To this end, we use the Sill distribution developed in Ref. $[7]$ and successively used in the case of e.g. spin-2 mesons $[8]$ and hybrid mesons in Ref. $[9]$ (for other works that have applied the Sill distribution, see also $[10-13]$.

2. Effective Model

The following effective interaction term describes the decay of the pseudotensor mesons^{[1](#page-1-1)} $\left(P_2=\right)$ $\pi_2(1670)$, $K_2(1770)$, $\{\eta_2(1870),\eta_2(1645)\}\big\}$ into the vector $\left(V=\right\{\rho(770),K^*(892),\omega(782),\phi(1020)\big\}\big)$ and pseudoscalar $\left(P=\right\{\pi,K,\eta(547),\eta(547)\big\}$ $\eta'(958)$ mesons [\[2\]](#page-3-1):

$$
\mathcal{L}_{p_2vp} = g_{p_2vp} \operatorname{tr} \left[P_2^{\mu\nu} \left[V_\mu , (\partial_\nu P) \right]_- \right] , \qquad (2.1)
$$

which leads to the decay rate:

$$
\Gamma_{P_2 \to V+P}(m_{p_2}, m_v, m_p) = \frac{g_{p_2vp}^2 |\vec{k}_{p_2,v,p}|^3}{120 \pi m_{p_2}^2} \left(5 + \frac{2 |\vec{k}_{p_2,v,p}|^2}{m_v^2}\right) \kappa_i \Theta(m_{p_2} - m_v - m_p). \tag{2.2}
$$

Above κ_i is a decay coefficient that takes into account flavor combinatoric and renormalization factors, extracted from the extended version of the lagrangian. The coupling constant is determined to be:

$$
g_{p_2vp}^2 = (11.9 \pm 1.6). \tag{2.3}
$$

A similar Lagrangian describing the decay of spin-3 tensor mesons $\Big(W_3= \Big\{\rho_3(1690), W_3^*(1780), \phi_3(1850), \omega_3(1670) \Big\} \Big)$ has the following form [\[4\]](#page-3-4):

$$
\mathcal{L}_{w_3vp} = g_{w_3vp} \,\varepsilon^{\mu\nu\rho\sigma} \,\text{tr}\Big[W_{3,\mu\alpha\beta} \left\{ (\partial_\nu V_\rho), \, (\partial^\alpha \partial^\beta \partial_\sigma P) \right\}_+ \Big] \,. \tag{2.4}
$$

The tree-level decay rate is:

$$
\Gamma_{W_3 \to V+P}(m_{w_3}, m_v, m_p) = g_{w_3vp}^2 \frac{|\vec{k}_{w_3,v,p}|^7}{105} \kappa_i \Theta(m_{w_3} - m_v - m_p). \tag{2.5}
$$

As a consequence of the parameter determination shown in Ref. [\[4\]](#page-3-4), one has the following value for the coupling:

$$
g_{w_3vp}^2 = (9.2 \pm 1.9) \cdot 10^{-16} \text{ MeV}^{-6}.
$$
 (2.6)

Some decay channels are listed in Tab[.1](#page-1-0) (see Ref. [\[4\]](#page-3-4) for more details).

 ${}^{1}P_{2}$ is a 3 × 3 matrix containing the nonet of listed states, see [\[2\]](#page-3-1). The same is true for the other quoted nonets.

3. Results for three-body decays

The PDG lists the following decay rates [\[1\]](#page-3-0):

$$
\Gamma_{\pi_2(1670)\to\pi^{\pm}\pi^{+}\pi^{-}} = 137 \pm 11 \,\text{MeV}, \qquad \Gamma_{\rho_3(1690)\to K\overline{K}\pi} = 6.1 \pm 2.0 \,\text{MeV}. \tag{3.1}
$$

In order to theoretically describe them, we introduce the "Sill" spectral function $d^{\text{Sill}}(x)$, which is chosen because of the following features: it is normalized even for broad states, it has a vanishing real part contribution to the loop of virtual particles, it takes into account the decay threshold, and is rather simple to use. For further details, see Ref. [\[7,](#page-3-5) [13\]](#page-4-2).

Considering the spectral function for $\rho(770)$, one has:

$$
d_{\rho}^{\text{Sill}}(y) = \frac{2y}{\pi} \frac{\sqrt{y^2 - 4m_{\pi}^2} \tilde{\Gamma}_{\rho}}{(y^2 - m_{\rho}^2)^2 + (\sqrt{y^2 - 4m_{\pi}^2} \tilde{\Gamma}_{\rho})^2} \Theta(y - 2m_{\pi}), \qquad \int_{2m_{\pi}}^{\infty} dy \, d_{\rho}^{\text{Sill}}(y) = 1 , \qquad (3.2)
$$

where the definition of $\tilde{\Gamma}_{\rho}$ is

$$
\tilde{\Gamma}_{\rho} \equiv \frac{\Gamma^{\rm PDG}_{\rho \to 2\pi} m_{\rho}}{\sqrt{m_{\rho}^2 - 4m_{\pi}^2}} \tag{3.3}
$$

with the PDG values $\Gamma_{\rho\to 2\pi}^{\rm PDG} = 149.1 \text{ MeV}$ and $m_\rho = 775.11 \text{ MeV}$. Then, upon integrating over it, we obtain the following result for the three-body decay of π_2 :

$$
\Gamma_{\pi_2 \to \rho \pi \to \pi \pi \pi} \simeq \int_{2m_{\pi}}^{\infty} dy \, d_{\rho}^{\text{Sill}}(y) \, \Gamma_{\pi_2 \to \rho \pi}(m_{\pi_2}, y, m_{\pi}) \simeq (73.9 \pm 9.9) \,\text{MeV} \,.
$$

The Sill distribution for the vector $K^*(892)$ -meson reads:

$$
d_{K^*}^{\text{Sill}}(y) = \frac{2y}{\pi} \frac{\sqrt{y^2 - (m_K + m_\pi)^2} \tilde{\Gamma}_{K^*}}{(y^2 - m_{K^*}^2)^2 + (\sqrt{y^2 - (m_K + m_\pi)^2} \tilde{\Gamma}_{K^*})^2} \Theta(y - m_K - m_\pi),\tag{3.5}
$$

where $\tilde{\Gamma}_{K^*}$ is linked to the PDG values $\Gamma_{K^* \to K\pi}^{\text{PDG}} = 51.4 \text{ MeV}$ and $m_{K^*} = 890 \text{ MeV}$ according to:

$$
\tilde{\Gamma}_{K^*} \equiv \frac{\Gamma_{K^* \to K\pi}^{\text{PDG}} m_{K^*}}{\sqrt{m_{K^*}^2 - (m_K - m_\pi)^2}} \tag{3.6}
$$

The normalization

$$
\int_{m_k+m_{\pi}}^{\infty} dy \, d_{K^{\star}}^{\text{Sill}}(y) = 1, \qquad (3.7)
$$

holds also here.

In this case, the three-body decay of $\rho_3(1690)$ can be calculated as:

$$
\Gamma_{\rho_3(1690)\to\bar{K}^*(892) K \to K\overline{K}\pi} \simeq \int_{m_k + m_\pi}^{\infty} dy \, d_{K^*}^{\text{Sill}}(y) \, \Gamma_{\rho_3 \to \bar{K}^* K}(m_{\rho_3}, y, m_K) \simeq (3.43 \pm 0.70) \, \text{MeV} \,. \tag{3.8}
$$

The decay channel $\Gamma_{\rho_3 \to \eta \pi \pi}$ has also been seen experimentally [\[14\]](#page-4-3); we estimate it as:

$$
\Gamma_{\rho_3(1690)\to\rho(770)\eta\to\eta\pi\pi} \simeq \int_{2m_\pi}^{\infty} dy \, d_\rho^{\text{Sill}}(y) \, \Gamma_{\rho_3\to\rho\eta}(m_{\rho_3}, y, m_\eta) \simeq (3.95 \pm 0.81) \,\text{MeV} \,. \tag{3.9}
$$

By using the decay rates given in Tab[.1,](#page-1-0) we present various three-body decay channels assuming the Sill distribution in Tab. [2.](#page-3-7)

Decay channel	Sill distribution	PDG
$\pi_2(1670) \to \rho(770)\pi \to \pi^{\pm}\pi^+\pi^-$	73.9 ± 9.9	137 ± 11
$\pi_2(1670) \rightarrow \overline{K}^*(892)\pi \rightarrow K\overline{K}\pi$	10.4 ± 1.4	
$\rho_3(1690) \rightarrow \rho(770)\eta \rightarrow \eta\pi\pi$	3.88 ± 0.80	seen
$\rho_3(1690) \rightarrow \overline{K}^*(892)\pi \rightarrow K\overline{K}\pi$	3.43 ± 0.70	6.1 ± 2.0

TABLE 2. Three body decay rates of $\pi_2(1670)$ and $\rho_3(1690)$ mesons (MeV).

4. CONCLUSION

In this paper, we used a hadronic model and the Sill distribution, introduced in the vector meson intermediate decays, to evaluate the three-body decays of $\pi_2(1670)$ and $\rho_3(1690)$. Results are compared to the ones listed in PDG: they agree within the error bars for $\rho_3(1690) \to K\overline{K}\pi$, while it is two times off the experimental result for $\pi_2(1670) \rightarrow 3\pi$. This implies the necessity of the consideration of multi-channel version of the Sill distribution [\[7\]](#page-3-5) in the future.
