# Y-FRIEZE PATTERNS

#### ANTOINE DE ST. GERMAIN

Abstract. Motivated by cluster ensembles, we introduce a new variant of frieze patterns associated to acyclic cluster algebras, which we call  $\mathbf{Y}\text{-}$  frieze patterns. Using the mutation rules for Y-variables, we define a large class of Y-frieze patterns called *unitary* Y-frieze patterns, and show that the ensemble map induces a map from (unitary) frieze patterns to (unitary) Y-frieze patterns. In rank 2, we show that Y-frieze patterns are (associated to) friezes of generalised cluster algebras. In finite type (not necessarily rank 2), we show that Y-frieze patterns share the same symmetries as frieze patterns, and prove that their number is finite.

#### 1. Introduction and main results

## <span id="page-0-2"></span><span id="page-0-0"></span>1.1. **Introduction.** Fix a positive integer  $r$ , and consider an array

consisting of  $r + 2$  staggered infinite rows of positive integers. Recall that such an array is called a Coxeter frieze pattern of width r if every local configuration

satisfies the diamond rule

$$
WE = 1 + NS.
$$

In this article, we introduce a new variant of Coxeter's frieze patterns. We begin by considering an array

consisting of  $r + 2$  staggered infinite rows, where the top and bottom rows consist entirely of 0's and the remaining rows consist of positive integers. We say that such an array is a  $\mathbf{Y}\text{-}frieze$ pattern of width r if every local configuration

$$
\begin{array}{ccc} & N & \\ W & & E \\ S & & \end{array}
$$

satisfies the Y-diamond rule

$$
WE = (1 + N)(1 + S).
$$

Given a Y-frieze pattern as in  $(1.2)$ , we call the first non-trivial row

$$
\cdots \quad y_1 \quad y_2 \quad y_3 \quad y_4 \quad y_5 \quad \cdots
$$

the Y-quiddity cycle. By the Y-diamond rule, a Y-frieze pattern is determined by its Y-quiddity cycle. The following theorem shows that Y-frieze patterns and Coxeter frieze patterns are intimately linked.

**Theorem A.** Each Coxeter frieze pattern of width r as in  $(1.1)$  gives rise to a unique Y-frieze pattern of width r as in [\(1.2\)](#page-1-0) by setting  $y_i = b_i$ , for all  $i \in \mathbb{Z}$ .

Recall that a *glide reflection* is a composition of a reflection and a translation. We denote by  $\mathbf{F}_r$  the unique glide reflection whose square amounts to a horizontal translation by  $r + 3$ . In [\[Cox71\]](#page-22-1), Coxeter showed that every Coxeter frieze pattern of width r is  $\mathbf{F}_r$ -invariant, a property commonly referred to as the *glide symmetry* of Coxeter frieze patterns. Remarkably, Y-frieze patterns satisfy the same symmetry.

### **Theorem B.** Every **Y**-frieze pattern of width r is  $\mathbf{F}_r$ -invariant.

It was recently shown in [\[Mul23\]](#page-22-2) that the entries in a frieze pattern of width  $r$  admit (explicit) upper bounds, which in turn implies there are finitely many friezes of width  $r$ . Whilst this is not clear from the definition, similar statements hold for Y-frieze patterns.

## **Theorem C.** There are finitely many **Y**-frieze patterns of width  $r$ .

In [\[CC73\]](#page-22-3), Coxeter and Conway constructed a beautiful bijection between Coxeter frieze patterns of width r and triangulations of the regular  $(r+3)$ -gon. It is a well-known combinatorial fact that triangulations of the  $(r+3)$ -gon are counted by the Catalan number  $C_{r+1}$ , where

$$
C_r = \frac{1}{r+1} \begin{pmatrix} 2r \\ r \end{pmatrix}.
$$

**Conjecture.** 1) Every **Y**-frieze pattern of width r arises from a Coxeter frieze pattern of width r as in Theorem A.

- 2) When r is even, there are  $C_{r+1}$ -many **Y**-frieze patterns of width r.
- 3) When r is odd, there are at most  $C_{r+1}$ -many **Y**-frieze patterns of width r.

The elementary nature of Coxeter's frieze patterns conceals a rich algebraic and combinatorial theory related to cluster algebras  $A$  (in the sense of Fomin and Zelevinsky) of type  $A_n$ . Unveiling this connection has led to the notion of frieze patterns [\[ARS10,](#page-22-4) [KS11,](#page-22-5) [MG15\]](#page-22-6), and their algebraic counterparts called A-friezes [\[GM22,](#page-22-7) [dSGHL23\]](#page-22-8), associated to any acyclic cluster algebra A. Intuitively, we think of a frieze pattern as the elementary shadow of an A-frieze.

Each (acyclic) cluster algebra A naturally belongs to a so-called (acyclic) *cluster ensemble*  $(\mathcal{A}, \mathcal{X}, p)$ , where X is often called the *Poisson cluster algebra* and p the *ensemble map*. Our motivation for the notion of Y-frieze patterns was a search for (the *elementary shadow* of) the "correct"  $\mathcal{X}$ -analog of  $\mathcal{A}$ -friezes. The aim of this article is to define Y-frieze patterns associated to an arbitrary acyclic cluster ensemble, expose their  $\mathcal{X}$ -nature and study their properties in the context of cluster algebras and cluster ensembles.

1.2. Main results. In §[2.2,](#page-4-1) we define frieze patterns and Y-frieze patterns associated to an arbitrary symmetrisable generalised Cartan matrix  $A$  (Definition [2.3\)](#page-4-2). Since their definitions are subtraction and division-free, we allow frieze patterns and  $\bf{Y}$ -frieze patterns to take values in an arbitrary semi-ring S (whose definition is recalled in  $\S2.1$ ), thus unifying various notions of patterns appearing in the literature (Remark [2.5](#page-5-0) and Remark [2.6\)](#page-6-0).

Using the machinery of cluster algebra mutations, S. Morier-Genoud defined in [\[MG12\]](#page-22-9) a large class of frieze patterns called unitary frieze patterns. After recalling some notions of mutation in §[2.4,](#page-8-0) we define *unitary* Y-frieze patterns in §[2.5.](#page-9-0) The following summarises the main results in §[2.](#page-4-0)

**Theorem.** (Theorem [2.8](#page-7-0) and Theorem [2.15\)](#page-10-0) Fix an arbitrary symmetrisable generalised Cartan matrix A and a semi-ring S. Denote by Frieze $(A, S)$ , resp. by YFrieze $(A, S)$ , the set of S-valued frieze patterns, resp.  $\mathbf{Y}\text{-}$  frieze patterns, associated to A.

1) One has a well-defined map

$$
p_{A,S}
$$
: Frieze $(A, S)$   $\longrightarrow$  YFrieze $(A, S)$ .

2) If  $f \in \text{Frieze}(A, S)$  is unitary, then  $p_{A,S}(f) \in \text{YFrieze}(A, S)$  is unitary.

In §[3,](#page-12-0) we introduce the Y-belt algebra (Definition [3.4\)](#page-13-0), which we use to define the algebraic counterpart of Y-frieze patterns (see Definition [3.6\)](#page-14-0). It follows rather easily from our setup that Y-frieze patterns and their algebraic counterparts are equivalent (Proposition [3.7\)](#page-14-1). This formulation allows us to establish a precise connection between  $p_{A,S}$  and the ensemble map p (Corollary [3.8\)](#page-14-2).

In §[4,](#page-15-0) we study Y-frieze patterns associated to  $2 \times 2$  symmetrisable Cartan matrices. The main observation here is that the Y-belt algebra associated to a given  $A$  is naturally isomorphic to a generalised cluster algebra, and this isomorphism pulls back (the algebraic counterpart of)

Y-frieze patterns to friezes of generalised cluster algebras (Proposition [4.6\)](#page-17-0). Using this, we determine the number of  $\mathbb{Z}_{>0}$ -valued Y-frieze patterns in rank 2 (Theorem [4.8\)](#page-18-1).

In §[5,](#page-18-0) we turn to an investigation of Y-frieze patterns when the associated Cartan matrix  $A$ is of finite type. Under some mild condition on the semi-ring  $S$  (see  $(5.30)$ ), we determine the symmetry of S-valued frieze patterns and S-valued Y-frieze patterns (Theorem [5.2\)](#page-19-1), generalising the well-known glide symmetry of Coxeter frieze patterns. In §[5.2,](#page-19-2) we study the problem of enumerating the set of S-valued Y-frieze patterns when S is the tropical semi-ring (Proposition [5.3\)](#page-20-0) and the semi-ring of positive integers (Theorem [5.5\)](#page-21-0).

In this article, Y-frieze patterns are associated to an arbitrary Cartan matrix A. One deduces Theorems A, B and C in  $\S1.1$  $\S1.1$  from Theorems [2.8,](#page-7-0) [5.2](#page-19-1) and [5.5](#page-21-0) respectively, by taking A of type  $A_n$  with the standard labelling (c.f. §[1.4\)](#page-3-0).

<span id="page-3-0"></span>1.4. **Notation.** For any integer r, we use  $[1, r]$  to denote the set of all integers k from 1 to r. Elements in  $\mathbb{Z}^n$  for any integer  $n \geq 1$  are regarded as column vectors unless otherwise specified. The standard basis vectors in  $\mathbb{Z}^n$  are denoted by  $e_1, e_2, \ldots, e_n$ .

For a real number a, let  $[a]_+ = \max(a, 0)$ . The transpose of M is denoted by  $M^T$ .

Suppose that A is an Abelian group. For  $\mathbf{a} = (a_1, \ldots, a_n) \in A^n$  and  $L = (l_1, \ldots, l_n)^T \in \mathbb{Z}^n$ , we write  $\mathbf{a}^L = a_1^{l_1} \cdots a_n^{l_n} \in A$ , and for L an  $n \times m$  integral matrix with columns  $L_1, \ldots, L_m$ , we write  $\mathbf{a}^L = (\mathbf{a}^{L_1}, \dots, \mathbf{a}^{L_m}) \in A^m$ .

Given  $\mathbf{v} = (v_1, \ldots, v_n), \mathbf{w} = (w_1, \ldots, w_n)$  with  $v_i, w_i \in \mathbb{Z}$ , we write  $\mathbf{v} \leq \mathbf{w}$  to mean  $v_i \leq \mathbf{w}$  $w_i, i \in [1, n].$ 

**Terminology.** By a symmetrisable generalised Cartan matrix  $A = (a_{i,j})$  we mean a symmetrisable integer matrix such that  $a_{i,i} = 2, a_{i,j} \leq 0$  with  $a_{i,j} = 0$  if and only if  $a_{j,i}$  whenever  $i \neq j$ . A Cartan matrix is of *finite type* if all its principal minors are positive, and of *infinite type* otherwise. By a Cartan matrix of finite type with the standard labelling, we mean any Cartan matrix of the form given in [\[Kac83,](#page-22-10) p.43].

A Cartan matrix is *decomposable* if there exists a non-empty proper subset  $I \subset [1, r]$  such that  $a_{i,j} = 0$  whenever  $i \in I$  and  $j \in [1, r] \backslash I$ . A Cartan matrix which is not decomposable is called indecomposable.

### 2. Y-FRIEZE PATTERNS AND THEIR PROPERTIES

<span id="page-4-3"></span><span id="page-4-0"></span>2.1. Semi-rings and semi-fields. Recall ([\[BFZ96,](#page-22-11) §2.1]) that a *semi-ring*  $S = (S, \cdot, +)$  (with 1) and without 0) consists of a set S and two binary operations  $\cdot : S \times S \to S$  (called multiplication) and  $+: S \times S \rightarrow S$  (called addition) such that

1) multiplication is associative and commutative, with identity element 1;

2) addition is associative and commutative, without 0;

3) distributivity:  $(a + b)c = ac + bc$  for all  $a, b, c \in S$ .

<span id="page-4-6"></span>Example 2.1. Our main examples of semi-rings are as follows.

1) The semi-ring  $\mathbb{Z}_{>0} = (\mathbb{Z}_{>0}, \cdot, +)$  of positive integers with the usual addition and multiplication.

2) The tropical semi-ring  $\mathbb{Z}_{\geq 0}^{\max} = (\mathbb{Z}_{\geq 0}, +, \max)$  consisting of the set of non-negative integers with semi-ring multiplication the usual addition of integers and semi-ring addition the binary operation (a, b) 7−→ max(a, b). ⋄

Recall that a semi-ring  $(S, \cdot, +)$  is called a *semi-field* if S forms a group under multiplication.

<span id="page-4-7"></span>Example 2.2. Our main examples of semi-fields are as follows.

1) The semi-field  $\mathbb{Q}_{>0} = (\mathbb{Q}_{>0}, \cdot, +)$  of positive rational numbers equipped with the usual addition and multiplication.

2) The universal semi-field of rank r, denoted  $\mathbb{Q}_{>0}(z_1,\ldots,z_r)$ , which consists of the set of non-zero subtraction-free expressions in algebraically independent variables  $z_1, \ldots, z_r$  equipped with the operations inherited from the field of rational functions  $\mathbb{Q}(z_1, \ldots, z_r)$ .

3) The tropical semi-field  $\mathbb{Z}^{\max} = (\mathbb{Z}, +, \max).$ 

<span id="page-4-1"></span>2.2. Frieze patterns and Y-frieze patterns. We now introduce the main objects of study of this article. Fix a positive integer  $r$ .

<span id="page-4-2"></span>**Definition 2.3.** Let  $A = (a_{i,j})$  be any  $r \times r$  symmetrisable generalised Cartan matrix, and let S be any semi-ring.

1) [\[GM22,](#page-22-7) Definition 6.2] An S-valued frieze pattern associated to A is a map  $f : [1, r] \times \mathbb{Z} \longrightarrow S$ such that

f(i,m) f(i,m+1) = 1 + \prod_{j=i+1}^{r} f(j,m)^{-a_{j,i}} \prod_{j=1}^{i-1} f(j,m+1)^{-a_{j,i}}, \qquad \forall (i,m) \in [1,r] \times \mathbb{Z}. \tag{2.3}
$$

2) An S-valued **Y**-frieze pattern associated to A is a map  $k : [1, r] \times \mathbb{Z} \longrightarrow S$  such that

k(i,m) k(i,m+1) = \prod_{j=i+1}^{r} (1+k(j,m))^{-a_{j,i}} \prod_{j=1}^{i-1} (1+k(j,m+1))^{-a_{j,i}}, \qquad \forall (i,m) \in [1,r] \times \mathbb{Z}. \tag{2.4}
$$

Let Frieze $(A, S)$ , resp. YFrieze $(A, S)$ , be the set of all S-valued frieze patterns, resp. Y-frieze patterns, associated to A. S-valued frieze patterns and S-valued Y-frieze patterns are also said to take values in S.  $\Diamond$

<span id="page-5-2"></span>Notation 2.4. It is convenient to visualise  $[1, r] \times \mathbb{Z}$  as an infinite grid of r-many staggered rows



An S-valued frieze pattern f (resp. an S-valued Y-frieze pattern  $k$ ) is then an assignment of an element  $f(i, m) \in S$  (resp. of an element  $k(i, m) \in S$ ) for each grid point  $(i, m)$  of  $[1, r] \times \mathbb{Z}$ , such that [\(2.3\)](#page-4-4) (resp. [\(2.4\)](#page-4-5)) holds. ⋄

<span id="page-5-0"></span>Remark 2.5. The study of frieze patterns taking values in certain semi-rings has a long history.

- Frieze patterns taking values in  $\mathbb{Z}_{>0}$  are called *arithmetic frieze patterns* in [\[MG12\]](#page-22-9), see also [\[ARS10,](#page-22-4) [GM22,](#page-22-7) [MG15\]](#page-22-6). In particular, when A is of type  $A_n$  with the standard labelling, arithmetic frieze patterns are the so-called Coxeter frieze patterns, introduced by Coxeter [\[Cox71\]](#page-22-1) in the 1970s.
- Frieze patterns taking values in the tropical semi-field  $\mathbb{Z}^{\text{max}}$  are called *tropical friezes* in [\[Guo13\]](#page-22-12). Tropical friezes were recently studied in the context of the Fock-Goncharov duality conjecture in [\[CdSGL23\]](#page-22-13).
- Let S be the universal semi-field of rank r, with generators  $X_1, \ldots, X_r$ . The S-valued frieze pattern  $F$  associated to  $A$  such that

$$
F(i,0) = X_i, \qquad i \in [1,r],
$$

is called the *generic frieze pattern* (*generalised frieze pattern* in  $[KS11]$ ) associated to A.

The notion of S-valued frieze patterns given in 1) of Definition [2.3](#page-4-2) places all the examples above under the same definition.  $\Diamond$  <span id="page-6-0"></span>Remark 2.6. The notion of Y-frieze patterns taking values in an arbitrary semi-ring S appears to be new. Y-frieze patterns taking values in specific semi-rings have appeared in the literature, but have received far less attention than frieze patterns.

- Y-frieze patterns taking values in  $\mathbb{Z}_{>0}$  are called *arithmetic* Y-frieze patterns. Y-frieze patterns of width r as defined in the Introduction are arithmetic  $\mathbf{Y}$ -frieze patterns associated to a Cartan matrix of type  $A_r$  with the standard labelling. Examples of arithmetic Y-frieze patterns are given in Figure [1.](#page-5-1)
- $\bullet$   $\mathbb{Z}^{\max}$ -valued Y-frieze patterns are called *cluster-additive functions*. They were introduced by Ringel in [\[Rin12\]](#page-22-14). See [\[CdSGL23\]](#page-22-13) for more.
- Let S be the universal semi-field of rank r, with generators  $Y_1, \ldots, Y_r$ . The S-valued **Y**-frieze pattern  $G$  associated to  $A$  such that

$$
G(i,0) = Y_i, \qquad i \in [1,r]
$$

is called the *generic* Y-frieze pattern associated to A in [\[CdSGL23,](#page-22-13) §1]. Generic Yfrieze patterns are a generalisation of the Y-systems considered in  $[{\rm FZ07}, \, \text{88}]$  to study Zamolodchikov's periodicity conjecture. An example of a generic Y-frieze pattern is given in Figure [2.](#page-7-1)

⋄

Consider the total order on  $[1, r] \times \mathbb{Z}$  given by

<span id="page-6-1"></span> $(i, m) < (i, n) \iff m < n \text{ or } m = n \text{ and } i < j.$  (2.5)

<span id="page-6-2"></span>**Lemma 2.7.** Let A be any  $r \times r$  symmetrisable generalised Cartan matrix, S any semi-field. One has bijections

$$
Frieze(A, S) \longrightarrow S^r, \qquad f \mapsto (f(1,0), \dots, f(r,0))
$$
  
\n
$$
YFrieze(A, S) \longrightarrow S^r, \qquad k \mapsto (k(1,0), \dots, k(r,0)).
$$

Given  $\mathbf{s} = (s_1, \ldots, s_r) \in S^r$ , the unique  $f \in \text{Frieze}(A, S)$ ,  $k \in \text{Y} \text{Frieze}(A, S)$  such that

$$
(f(1,0),..., f(r,0)) =
$$
**s** and  $(k(1,0),..., k(r,0)) =$ **s**,

are denoted  $f = f_s$  and  $k = k_s$  respectively. The procedure, recursive with respect to the total order [\(2.5\)](#page-6-1), for computing the values of  $f_s$  and  $k_s$  from  $s$  is called the knitting algorithm [\[Kel10\]](#page-22-16).

*Proof.* Since S is a semi-field, each f is uniquely determined by  $(f(1,0),...,f(r,0)) \in S^r$ , by solving [\(2.4\)](#page-4-5) recursively using the total order [\(2.5\)](#page-6-1) on [1,  $r \times \mathbb{Z}$ . It is straightforward to check that two S-valued frieze patterns coincide if and only if their restriction to the points  $(1,0),\ldots,(r,0)$ coincide. The same argument holds for Y-frieze patterns.  $\Box$ 

When  $S$  is a semi-ring which is not a semi-field, the knitting algorithm fails to produce welldefined S-valued maps on  $[1, r] \times \mathbb{Z}$  in general, since solutions to [\(2.3\)](#page-4-4) or [\(2.4\)](#page-4-5) in S may not exist. As we shall see in §[5,](#page-18-0) this leads to interesting enumeration problems which depend both on S and on A.

<span id="page-7-2"></span>2.3. Constructing Y-frieze patterns from frieze patterns. In this subsection, we establish a close connection between frieze patterns and Y-frieze patterns.

<span id="page-7-0"></span>**Theorem 2.8.** Let A be any  $r \times r$  symmetrisable generalised Cartan matrix and S any semi-ring. One has the set-theoretic map

$$
p_{A,S}
$$
: Frieze $(A, S)$   $\longrightarrow$  YFrieze $(A, S)$ ,  $f \longmapsto p_{A,S}(f)$ ,

given by

$$
p_{A,S}(f)(i,m) = \prod_{j=i+1}^{r} f(j,m)^{-a_{j,i}} \prod_{j=1}^{i-1} f(j,m+1)^{-a_{j,i}}.
$$
 (2.6)

*Proof.* We fix  $f \in \text{Frieze}(A, S)$  and  $(i, m) \in [1, r] \times \mathbb{Z}$ . Set

$$
L = p_{A,S}(f)(i,m) p_{A,S}(f)(i,m+1),
$$

and

$$
R = \prod_{j=i+1}^{r} (1 + p_{A,S}(f)(j,m))^{-a_{j,i}} \prod_{j=1}^{i-1} (1 + p_{A,S}(f)(j,m+1))^{-a_{j,i}}.
$$

We need to show that  $p_{A,S}(f)$  satisfies the relation [\(2.4\)](#page-4-5), i.e. that  $L = R$ .

$$
L = \prod_{j=i+1}^{r} f(j,m)^{-a_{j,i}} \prod_{j=1}^{i-1} f(j,m+1)^{-a_{j,i}} \prod_{j=i+1}^{r} f(j,m+1)^{-a_{j,i}} \prod_{j=1}^{i-1} f(j,m+2)^{-a_{j,i}}
$$
  
= 
$$
\prod_{j=i+1}^{r} (f(j,m)f(j,m+1))^{-a_{j,i}} \prod_{j=1}^{i-1} (f(j,m+1)f(j,m+2))^{-a_{j,i}}
$$
  
= 
$$
\prod_{j=i+1}^{r} (1 + p_{A,S}(f)(j,m))^{-a_{j,i}} \prod_{j=1}^{i-1} (1 + p_{A,S}(f)(j,m+1))^{-a_{j,i}} = R,
$$

where in the third equality we used  $(2.3)$ .  $\Box$ 

In general, the map  $p_{A,S}$  is neither injective nor surjective, as the following example shows.

**Example 2.9.** Let A be of type  $A_3$  with the standard labelling, let  $S = \mathbb{Q}_{>0}$  and set  $s =$  $(1, 2, 3), t = (3, 2, 1), v = (1, 1, 1).$  Consider  $f_s, f_t \in \text{Frieze}(A, S)$  and  $k_v \in \text{YFrieze}(A, S)$  (see Lemma [2.7](#page-6-2) for the notation). It is readily checked that  $p_{A,S}(f_s) = p_{A,S}(f_t)$  and that  $k_v \notin$ Image $(p_{A,S})$ .

On the other hand, it is easy to find pairs  $(A, S)$  for which  $p_{A,S}$  is i) bijective (see Corollary [5.4\)](#page-20-1); ii) injective and not surjective (type  $C_2$  with  $S = \mathbb{Z}_{>0}$ ); iii) surjective and not injective (type  $A_3$  with  $S = \mathbb{Z}_{>0}$ ). It would be interesting to study this further.

<span id="page-8-0"></span>2.4. Background on matrix, A and Y-patterns. In this subsection, we recall various patterns which arise in the theory of cluster algebras, following [\[CdSGL23\]](#page-22-13). These will be used in §[2.5](#page-9-0) to define *unitary* Y-frieze patterns and study their relation to (ordinary) unitary frieze patterns.

A mutation matrix of size r is any  $r \times r$  integer skew-symmetrizable matrix. For a given mutation matrix  $B = (b_{i,j})$  of size r and any  $k \in [1, r]$ , the mutation of B in direction k is the integer matrix  $\mu_k(B) = (b'_{i,j})$  where

$$
b'_{i,j} = \begin{cases} -b_{i,j} & \text{if } i = k \text{ or } j = k, \\ b_{i,j} + [b_{i,k}]_+ [b_{k,j}]_+ - [-b_{i,k}]_+ [-b_{k,j}]_+ & \text{otherwise.} \end{cases}
$$
(2.7)

Let  $\mathbb{T}_r$  be an r-regular tree with the r edges from each vertex labeled bijectively by the set [1, r], and we write  $t \stackrel{k}{\longrightarrow} t'$  if the vertices t and t' in  $\mathbb{T}_r$  are joined by an edge labeled by  $k \in [1, r]$ . We also fix  $t_0 \in \mathbb{T}_r$  and call it the root of  $\mathbb{T}_r$ .

**Definition 2.10.** A matrix pattern of rank r is an assignment, denoted  ${B_t}_{t \in \mathbb{T}_r}$ , of a mutation matrix  $B_t$  of size r to every vertex  $t \in \mathbb{T}_r$  such that  $\mu_k(B_t) = B_{t'}$  whenever  $t \stackrel{k}{\longrightarrow} t'$  $\Diamond$ 

Let  $\mathbb F$  be a field isomorphic to the field of rational functions over  $\mathbb Q$  in r independent variables. A seed in  $\mathbb F$  is a pair  $(z, B)$ , where z is an ordered set of free generators of  $\mathbb F$  over  $\mathbb Q$  and  $B$  is a mutation matrix of size r.

Given a seed  $(\mathbf{x}, B)$  in F and  $k \in [1, r]$ , the **A**-mutation of  $(\mathbf{x}, B)$  in direction k is the seed  $(\mathbf{x}' = (x_1, \ldots, x_{k-1}, x'_k, x_{k+1}, \ldots, x_r), \ \mu_k(B))$ , where  $\mu_k(B)$  is given in [\(2.7\)](#page-8-1) and

$$
x'_{k} = \frac{\prod_{j=1}^{r} x_{j}^{[b_{j,k}]_{+}} + \prod_{j=1}^{r} x_{j}^{[-b_{j,k}]_{+}}}{x_{k}}.
$$
\n(2.8)

**Definition 2.11.** 1) An A-pattern in  $\mathbb{F}$  is an assignment  $\{(\mathbf{x}_t, B_t)\}_{t \in \mathbb{T}_r}$  of a seed  $(\mathbf{x}_t, B_t)$  in  $\mathbb{F}$ to each  $t \in \mathbb{T}_r$  such that  $(\mathbf{x}_{t'}, B_{t'})$  is the **A**-mutation of  $(\mathbf{x}_t, B_t)$  in direction k whenever  $t \stackrel{k}{\longrightarrow} t'$ . 2) The positive space associated to an A-pattern  $\{(\mathbf{x}_t, B_t)\}_{t \in \mathbb{T}_r}$  with  $B_{t_0} = B$  is the pair

 $\mathbb{A}_B = (\mathbb{F}(\mathbb{A}_B), \{\mathbf{x}_t\}_{t \in \mathbb{T}_r})$ . We also call  $\mathbb{A}_B$  the positive **A**-space associated to B.

3) We call each  $x_t$  a *cluster* of  $A_B$ , each  $x \in x_t$  a *cluster variable* of  $A_B$ , monomials of cluster variables in a single cluster *cluster monomials of*  $\mathbb{A}_B$ , and  $\{B_t\}_{t\in\mathbb{T}_r}$  the *matrix pattern* of  $\mathbb{A}_B$ . ◇

Given a seed  $(\mathbf{y}, B)$  in  $\mathbb F$  and  $k \in [1, r]$ , the Y-mutation of  $(\mathbf{y}, B)$  in direction k is the seed  $(\mathbf{y}', \mu_k(B))$ , where  $\mu_k(B)$  is given in [\(2.7\)](#page-8-1) and  $\mathbf{y}' = (y'_1, \dots, y'_r)$  is given by

<span id="page-8-2"></span>
$$
y'_{j} = \begin{cases} y_{k}^{-1}, & \text{if } j = k; \\ y_{j}y_{k}^{[b_{k,j}]_{+}}(1+y_{k})^{-b_{k,j}}, & \text{if } j \neq k. \end{cases}
$$
 (2.9)

**Definition 2.12.** 1) A Y-pattern in  $\mathbb{F}$  is an assignment  $\{(\mathbf{y}_t, B_t)\}_{t \in \mathbb{T}_r}$  of a seed  $(\mathbf{y}_t, B_t)$  in  $\mathbb{F}$  to each  $t \in \mathbb{T}_r$  such that  $(\mathbf{y}_{t'}, B_{t'})$  is the Y-mutation of  $(\mathbf{y}_t, B_t)$  in direction k whenever  $t \stackrel{k}{\longrightarrow} t'$ .

2) The positive space associated to a Y-pattern  $\{(\mathbf{y}_t, B_t)\}_{t \in \mathbb{T}_r}$  with  $B_{t_0} = B$  is the pair  $\mathbb{Y}_B =$  $(\mathbb{F}(\mathbb{Y}_B), \{y_t\}_{t\in\mathbb{T}_r})$ . We also call  $\mathbb{Y}_B$  the positive **Y**-space associated to B.

3) We call each  $y_t$  a Y-cluster of  $\mathbb{Y}_B$ , each  $y \in y_t$  a Y-variable of  $\mathbb{Y}_B$ , and  $\{B_t\}_{t \in \mathbb{T}_r}$  the matrix pattern of  $\mathbb{Y}_B$ .

Let B be an  $r \times r$  mutation matrix, and consider the positive spaces

$$
\mathbb{A}_B = (\mathbb{F}(\mathbb{A}_B), \ \{\mathbf{x}_t\}_{t \in \mathbb{T}_r}) \quad \text{ and } \quad \mathbb{Y}_B = (\mathbb{F}(\mathbb{Y}_B), \ \{\mathbf{y}_t\}_{t \in \mathbb{T}_r}),
$$

with  ${B_t}_{t \in \mathbb{T}_r}$  the matrix pattern of both  $A_B$  and  $\mathbb{Y}_B$ . The pair  $(A_B, \mathbb{Y}_B)$  is called a *Fock*-Goncharov ensemble. The sub-algebras

$$
\mathcal{U}(\mathbb{A}_B) = \bigcap_{t \in \mathbb{T}_r} \mathbb{Z}[\mathbf{x}_t^{\pm 1}] \subset \mathbb{F}(\mathbb{A}_B) \quad \text{ and } \quad \mathcal{U}(\mathbb{Y}_B) = \bigcap_{t \in \mathbb{T}_r} \mathbb{Z}[\mathbf{y}_t^{\pm 1}] \subset \mathbb{F}(\mathbb{Y}_B)
$$

are called the *upper cluster algebra* of  $\mathbb{A}_B$  and of  $\mathbb{Y}_B$  respectively. We set

$$
\mathcal{U}^+(\mathbb{A}_B) = \bigcap_{t \in \mathbb{T}_r} \mathbb{Z}_{\geq 0}[\mathbf{x}_t^{\pm 1}] \quad \text{and} \quad \mathcal{U}^+(\mathbb{Y}_B) = \bigcap_{t \in \mathbb{T}_r} \mathbb{Z}_{\geq 0}[\mathbf{y}_t^{\pm 1}].
$$

Finally, set  $\mathbb{F}_{>0}(\mathbb{A}_B) = \mathbb{Q}_{>0}(\mathbf{x}_t)$  for any  $t \in \mathbb{T}_r$  and  $\mathbb{F}_{>0}(\mathbb{Y}_B) = \mathbb{Q}_{>0}(\mathbf{y}_t)$  for any  $t \in \mathbb{T}_r$ . The semi-field homomorphism

<span id="page-9-3"></span>
$$
p_B^* : \mathbb{F}_{>0}(\mathbb{Y}_B) \longrightarrow \mathbb{F}_{>0}(\mathbb{A}_B), \qquad p_B^*(\mathbf{y}_{t_0}) = \mathbf{x}_{t_0}^B \tag{2.10}
$$

is called the *ensemble map* of  $(\mathbb{A}_B, \mathbb{Y}_B)$  in [\[FG09\]](#page-22-17). Note that  $p_B^*(\mathbf{y}_t) = \mathbf{x}_t^{B_t}$  for every  $t \in \mathbb{T}_r$ .

<span id="page-9-0"></span>2.5. Unitary Y-frieze patterns. For any  $r \times r$  symmetrisable generalised Cartan matrix  $A =$  $(a_{i,j})$ , consider the acyclic mutation matrix

<span id="page-9-1"></span>
$$
B_A = \begin{pmatrix} 0 & a_{1,2} & a_{1,3} & \dots & a_{1,r} \\ -a_{2,1} & 0 & a_{2,3} & \dots & a_{2,r} \\ -a_{3,1} & -a_{3,2} & 0 & \dots & a_{3,r} \\ \dots & \dots & \dots & \dots & \dots \\ -a_{r,1} & -a_{r,2} & -a_{r,3} & \dots & 0 \end{pmatrix},
$$
(2.11)

and along with the positive spaces

$$
\mathbb{A}_B = (\mathbb{F}(\mathbb{A}_B), \{\mathbf{x}_t = (x_{t;1}, \dots, x_{t;r})\}_{t \in \mathbb{T}_r}) \text{ and } \mathbb{Y}_B = (\mathbb{F}(\mathbb{Y}_B), \{\mathbf{y}_t = (y_{t;1}, \dots, y_{t;r})\}_{t \in \mathbb{T}_r})
$$

associated to B. Recall from [\[dSGHL23\]](#page-22-8) the 2-regular sub-tree  $\mathbb{T}_r^{\flat}$  of  $\mathbb{T}_r$  given by

$$
\cdots \stackrel{r-1}{\longrightarrow} t(r,-2) \stackrel{r}{\longrightarrow} t(1,-1) \stackrel{1}{\longrightarrow} \cdots \stackrel{r-1}{\longrightarrow} t(r,-1) \stackrel{r}{\longrightarrow} t(1,0) \stackrel{1}{\longrightarrow} \cdots \stackrel{r-1}{\longrightarrow} t(r,0) \stackrel{r}{\longrightarrow} t(1,1), \stackrel{1}{\longrightarrow} \cdots
$$

where  $t(1,0) = t_0$ . One checks directly that, for every  $(i, m) \in [1, r] \times \mathbb{Z}$ , we have  $B_{t(i,m)} = B_{t(i,0)}$ and that

<span id="page-9-2"></span>
$$
B_{t(i,m)}e_i = (-a_{1,i}, \dots, -a_{i-1,i}, 0, -a_{i+1,i}, \dots, -a_{r,i})^T \ge 0.
$$
\n(2.12)

where recall that  $e_i$  denotes the i<sup>th</sup> standard basis (column) vector of  $\mathbb{Z}^r$ .

For each  $(i, m)$ , we write

$$
x(i,m) \stackrel{\text{def}}{=} x_{t(i,m);i} \in \mathfrak{X}(\mathbb{A}_B)
$$
 and  $y(i,m) \stackrel{\text{def}}{=} y_{t(i,m);i} \in \mathfrak{X}(\mathbb{Y}_B).$ 

It is well known that for each  $(i, m), x(i, m) \in \mathcal{U}^+(\mathbb{A}_B)$ .

<span id="page-10-1"></span>**Lemma 2.13.** [\[CdSGL23,](#page-22-13) §5] For each  $(i, m) \in [1, r] \times \mathbb{Z}$ , we have

$$
x(i, m) x(i, m + 1) = 1 + \prod_{j=i+1}^{r} x(j, m)^{-a_{j,i}} \prod_{j=1}^{i-1} x(j, m + 1)^{-a_{j,i}} \tag{2.13}
$$

$$
y(i, m) y(i, m + 1) = \prod_{j=i+1}^{r} (1 + y(j, m))^{-a_{j,i}} \prod_{j=1}^{i-1} (1 + y(j, m + 1))^{-a_{j,i}},
$$
 (2.14)

and moreover  $y(i, m) \in \mathcal{U}^+(\mathbb{Y}_B)$ .

Given a cluster  $\mathbf{x} = (x_1, \ldots, x_r)$  of  $\mathbb{A}_B$ , we denote by  $\psi_{\mathbf{x}}$  the unique ring homomorphism  $\mathbb{Z}[\mathbf{x}^{\pm 1}] \to \mathbb{Z}$  such that  $\psi_{\mathbf{x}}(x_i) = 1$  for all  $i \in [1, r]$ . Similarly, given a **Y**-cluster  $\mathbf{y} = (y_1, \ldots, y_r)$ of  $\mathbb{Y}_B$ , we denote by  $\phi_{\mathbf{y}}$  the unique ring homomorphism  $\mathbb{Z}[\mathbf{y}^{\pm 1}] \to \mathbb{Z}$  such that  $\phi_{\mathbf{y}}(y_i) = 1$  for all  $i \in [1, r]$ .

<span id="page-10-2"></span>**Lemma-Definition 2.14.** Let A be any symmetrisable generalised Cartan matrix and let  $B =$  $B_A$  as in  $(2.11)$ .

1) [\[MG12\]](#page-22-9) Given a cluster  $x$  of  $A_B$ , there exists a unique arithmetic frieze pattern f associated to A such that

$$
f(i,m) = \psi_{\mathbf{x}}(x(i,m)), \quad \forall (i,m) \in [1,r] \times \mathbb{Z}.
$$
 (2.15)

Arithmetic frieze patterns arising in this way are called unitary.

2) Given a Y-cluster y of  $\mathbb{Y}_B$ , there exists a unique arithmetic Y-frieze pattern k associated to A such that

$$
k(i, m) = \phi_{\mathbf{y}}(y(i, m)), \quad \forall (i, m) \in [1, r] \times \mathbb{Z}.
$$
 (2.16)

Arithmetic Y-frieze patterns obtained in this way are called unitary.

*Proof.* This follows directly from Lemma [2.13.](#page-10-1)  $\Box$ 

A subset  $\sigma = {\sigma_1, \ldots, \sigma_r}$  of  $\mathfrak{X}(\mathbb{A}_B)$  (resp. of  $\mathfrak{X}(\mathbb{Y}_B)$ ) is called an unordered cluster of  $\mathbb{A}_B$ (resp. an unordered Y-cluster of  $\mathbb{Y}_B$ ) if i)  $\sigma$  is a generating set of  $\mathbb{F}(\mathbb{A}_B)$  (resp. of  $\mathbb{F}(\mathbb{Y}_B)$ ) over Q; ii) there exists a cluster **x** of  $\mathbb{A}_B$  (resp. a **Y**-cluster **y** of  $\mathbb{Y}_B$ ) such that  $\sigma_i \in \mathbf{x}$  (resp.  $\sigma_i \in \mathbf{y}$ ) for all  $i \in [1, r]$ . By Lemma-Definition [2.14,](#page-10-2) we have well-defined assignments

$$
\{unordered clusters of AB\} \longrightarrow \text{Frieze}(A, \mathbb{Z}_{>0})
$$
\n(2.17)

$$
\{ \text{unordered } \mathbf{Y}\text{-clusters of }\mathbb{Y}_B \} \longrightarrow \text{YFrieze}(A, \mathbb{Z}_{>0}) \tag{2.18}
$$

It is by now well-known (see e.g. [\[GM22,](#page-22-7) Proposition 3.17]) that [\(2.17\)](#page-10-3) is injective, but in general not surjective (e.g. in type  $G_2$ ).

On the other hand, the assignment [\(2.18\)](#page-10-4) is not injective in general. This can be seen already in type  $A_1$ : there are exactly two Y-clusters, both giving rise to the same arithmetic Y-frieze pattern. Furthermore,  $(2.18)$  is in general not surjective either. This is the case in type  $G_2$ , where there are 8 unordered Y-clusters but 21 arithmetic Y-frieze patterns (see Theorem [4.8\)](#page-18-1).

<span id="page-10-0"></span>**Theorem 2.15.** Let A be any symmetrisable generalised Cartan matrix and let  $S = \mathbb{Z}_{>0}$ . If  $f \in \text{Frieze}(A, S)$  is unitary, then  $p_{A,S}(f) \in \text{YFrieze}(A, S)$  is unitary.

*Proof.* Let  $f \in \text{Frieze}(A, \mathbb{Z}_{>0})$ , and suppose that f is unitary. By definition, there exists a cluster  $\mathbf{x}_t = (x_{t,1}, \ldots, x_{t,r}), t \in \mathbb{T}_r$  of  $\mathbb{A}_B$  such that  $f(i,m) = \psi_{\mathbf{x}_t}(x(i,m))$  for each  $(i,m) \in [1, r] \times \mathbb{Z}$ . Following [\[dSGHL23,](#page-22-8) Lemma 5.4], one can show that

<span id="page-11-0"></span>
$$
x_{t(i,m)} = (x(1, m+1), \dots, x(i-1, m+1), x(i, m), x(i+1, m), \dots, x(r, m)).
$$
\n(2.19)

Combining [\(2.19\)](#page-11-0) with [\(2.12\)](#page-9-2), we deduce that

<span id="page-11-2"></span>
$$
p_{A,S}(f)(i,m) = \psi_{\mathbf{x}_t}(\mathbf{x}_{t(i,m)})^{B_{t(i,m)}e_i}.
$$
\n(2.20)

Denote by  $\Psi_t : \mathbb{F}_{>0}(\mathbb{A}_B) \longrightarrow \mathbb{Q}_{>0}$  and  $\Phi_t : \mathbb{F}_{>0}(\mathbb{Y}_B) \longrightarrow \mathbb{Q}_{>0}$  the semi-field homomorphisms determined by  $\Psi_t(x_{t,i}) = 1$  and  $\Phi_t(y_{t,i}) = 1$  respectively, for  $i \in [1, r]$ . Set  $R_t = \mathbb{F}_{>0}(\mathbb{A}_B) \cap \mathbb{Z}[\mathbf{x}_t^{\pm 1}]$ and  $R'_t = \mathbb{F}_{>0}(\mathbb{Y}_B) \cap \mathbb{Z}[\mathbf{y}_t^{\pm 1}]$ . Note that  $R_t, R'_t$  are closed under multiplication,  $x(i,m) \in R_t$  by the Laurent phenomenon [\[FZ07\]](#page-22-15),  $y(i, m) \in R'_t$  by Lemma [2.13](#page-10-1) and

<span id="page-11-1"></span>
$$
\Psi_t|_{R_t} = \psi_{\mathbf{x}_t}|_{R_t}, \qquad \Phi_t|_{R_t'} = \phi_{\mathbf{y}_t}|_{R_t'} \qquad \text{and} \qquad \Psi_t \circ p_B^* = \Phi_t.
$$
 (2.21)

By applying  $(2.21)$  to  $(2.20)$ , we obtain

$$
p_{A,S}(f)(i,m) = \Psi_t(\mathbf{x}_{t(i,m)}^{B_{t(i,m)}e_i}) = \Psi_t \circ p_B^*(y(i,m)) = \Phi_t(y(i,m)) = \phi_{\mathbf{y}_t}(y(i,m)).
$$

We conclude this section with an extended example in type  $A_3$ .

**Example 2.16.** Let A be of type  $A_3$  with the standard labelling, set  $B = B_A$  as in [\(2.11\)](#page-9-1), and consider the positive space

$$
\mathbb{Y}_B = (\mathbb{F}(\mathbb{Y}_B), \{ \mathbf{y}_t = (y_{t;1}, y_{t;2}, y_{t;3}) \}_{t \in \mathbb{T}_3}).
$$

At  $t_0 \in \mathbb{T}_3$ , we write  $\mathbf{y}_{t_0} = (y_1, y_2, y_3)$ . Note that  $y(i, m) \in \mathbb{Z}_{\geq 0}[y_1^{\pm 1}, y_2^{\pm 1}, y_3^{\pm 1}]$  by Lemma [2.13;](#page-10-1) see Figure [3](#page-11-3) for the Laurent expansion of a few  $y(i, m)$ 's (in fact, one can show that Figure 3 contains all the  $y(i, m)$ 's; see §[5.1\)](#page-18-2).

According to [\(2.18\)](#page-10-4), the unordered Y-cluster  $\{y_1, y_2, y_3\}$  gives rise to a well-defined arithmetic Y-frieze pattern which we denote by k. The first few values of k, obtained by setting  $y_1 = y_2 =$  $y_3 = 1$  in the Laurent expansion of each  $y(i, m)$ , are displayed below (c.f. Notation [2.4](#page-5-2) for the layout).

$$
\begin{array}{cccccccc}\n & 1 & 3 & 3 & 1 & 3 & 3 \\
\cdots & 2 & 8 & 2 & 2 & 8 & 2 & \cdots \\
 & & 3 & 3 & 1 & 3 & 3 & 1\n\end{array}
$$

3. The Y-cluster structure of Y-frieze patterns

<span id="page-12-3"></span><span id="page-12-0"></span>3.1. Friezes of positive spaces. Let B be any  $r \times r$  mutation matrix, not necessarily  $B = B_A$ and consider the Fock-Goncharov ensemble

$$
\mathbb{A}_B = (\mathbb{F}(\mathbb{A}_B), \ \{\mathbf{x}_t\}_{t \in \mathbb{T}_r}) \quad \text{ and } \quad \mathbb{Y}_B = (\mathbb{F}(\mathbb{Y}_B), \ \{\mathbf{y}_t\}_{t \in \mathbb{T}_r}),
$$

with common matrix pattern  ${B_t}_{t \in \mathbb{T}_r}$ . Recall from [\[GHKK18,](#page-22-18) [CdSGL23\]](#page-22-13) that an element  $x \in \mathcal{U}(\mathbb{A}_B)$  is called a *global monomial on*  $\mathbb{A}_B$  if there exist  $t \in \mathbb{T}_r$  and  $\mathbf{m} \in \mathbb{Z}^r$  such that  $x = \mathbf{x}_t^{\mathbf{m}}$ . Similarly, an element  $y \in \mathcal{U}(\mathbb{Y}_B)$  is called a global monomial on  $\mathbb{Y}_B$  if there exist  $t \in \mathbb{T}_r$ and  $\mathbf{m} \in \mathbb{Z}^r$  such that  $y = y_t^{\mathbf{m}}$ . It is well-known that the cluster monomials of  $\mathbb{A}_B$  are precisely all global monomials on  $\mathbb{A}_B$ .

**Definition 3.1.** [\[GHKK18,](#page-22-18) Definition 0.1] Let  $V = A_B$  or  $\mathbb{Y}_B$ .

1) The cluster algebra  $\mathcal{A}(V)$  of V is the sub-algebra of  $\mathcal{U}(V)$  generated by global monomials on  $V$ .

2) A *frieze of*  $\mathcal{A}(V)$  is a ring homomorphism

$$
\mathcal{A}(V) \longrightarrow \mathbb{Z}
$$

taking positive integer values at every global monomial on  $V$ .  $\Diamond$ 

When  $V = A_B$ , this definition agrees with [\[dSGHL23,](#page-22-8) Definition 3.1] and [\[GM22,](#page-22-7) Definition 3.2. When  $V = \mathbb{Y}_B$ , this definition appears to be new. Examples of friezes of  $\mathcal{A}(\mathbb{Y}_B)$  when B is of size 2 will be given in §[4.](#page-15-0) For now, let us illustrate how friezes of  $\mathcal{A}(\mathbb{A}_B)$  and friezes of  $\mathcal{A}(\mathbb{Y}_B)$ for the same  $B$  can exhibit very different behaviours.

<span id="page-12-1"></span>Example 3.2. Let  $B =$  $\sqrt{ }$  $\mathcal{L}$ 0 2  $-2$ −2 0 2 2  $-2$  0  $\setminus$ be the mutation matrix associated to the Markov

quiver. On the one hand, there are infinitely many friezes of  $\mathcal{A}(\mathbb{A}_B)$ . On the other hand, there is only one frieze of  $\mathcal{A}(\mathbb{Y}_B)$ . Indeed, one can check that the matrix pattern  $\{B_t\}_{t\in\mathbb{T}_3}$  obtained by setting  $B_{t_0} = B$  contains exactly two matrices, B and  $-B$ . Using [\[CdSGL23,](#page-22-13) Lemma 3.3], we see that  $\mathcal{A}(\mathbb{Y}_B) \cong \mathbb{Z}[T^{\pm 1}]$ . The single frieze of  $\mathcal{A}(\mathbb{Y}_B)$  is then given by

<span id="page-12-2"></span>
$$
\mathbb{Z}[T^{\pm 1}] \longrightarrow \mathbb{Z}, \qquad T \longmapsto 1.
$$

Whilst  $\mathcal{A}(\mathbb{A}_B)$  has been a central object in cluster theory since the theory's inception in the early 2000s, relatively little is known about  $\mathcal{A}(\mathbb{Y}_B)$ . For this reason, we conclude this subsection by defining a sub-algebra of  $\mathcal{A}(V)$  which we believe "approximates"  $\mathcal{A}(V)$  well. Whilst this sub-algebra will not play an important role in this article, we believe it may prove useful in the future.

Denote by  $\mathfrak{X}(\mathbb{A}_B)$  the set of cluster variables of  $\mathbb{A}_B$ , and by  $\mathfrak{X}(\mathbb{Y}_B)$  the set of Y-variables of  $\mathbb{Y}_B$ . Let  $V = \mathbb{A}_B$  or  $\mathbb{Y}_B$ . Recall [\[CdSGL23,](#page-22-13) §3.5] that elements in  $\mathfrak{X}(V) \cap \mathcal{U}(V)$  are called global variables on V. By the Laurent phenomenon, the cluster variables of  $A_B$  are precisely all global variables on  $A_B$ . On the other hand, not every Y-variable of  $\mathbb{Y}_B$  is a global variable on  $\mathbb{Y}_B$ .

**Definition 3.3.** Let  $V = A_B$  or  $\mathbb{Y}_B$ . The variable algebra  $\mathcal{A}^{\text{var}}(V)$  of V is the sub-algebra of  $U(V)$  generated by the global variables on V.

For all mutation matrices, it is clear that  $\mathcal{A}^{var}(\mathbb{A}_B) = \mathcal{A}(\mathbb{A}_B) \subset \mathcal{U}(\mathbb{A}_B)$  and that

$$
\mathcal{A}^{\text{var}}(\mathbb{Y}_B) \subset \mathcal{A}(\mathbb{Y}_B) \subset \mathcal{U}(\mathbb{Y}_B). \tag{3.22}
$$

In the setup of Example [3.2,](#page-12-1) one can show that the variable algebra is  $\mathbb{Z}$ . In other words, there exist mutation matrices  $B$  such that the first inclusion in  $(3.22)$  is strict.

3.2. Friezes and Y-frieze patterns. We now relate the algebraic notions of friezes defined in §[3.1](#page-12-3) to the elementary notions of frieze patterns and Y-frieze patterns of §[2.](#page-4-0) Let us begin once again by fixing a symmetrisable generalised Cartan matrix  $A = (a_{i,j})$  and setting  $B = B_A$  as in [\(2.11\)](#page-9-1). Recall the definition of  $x(i, m)$  and  $y(i, m)$  from §[2.5.](#page-9-0)

<span id="page-13-0"></span>Definition 3.4. We continue with the notation above.

- 1) The belt algebra  $\mathcal{A}^{\flat}(\mathbb{A}_B)$  is the sub-algebra of  $\mathcal{U}(\mathbb{A}_B)$  generated by  $\{x(i,m)\}_{(i,m)\in[1,r]\times\mathbb{Z}}$ .
- 2) The Y-belt algebra  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$  is the sub-algebra of  $\mathcal{U}(\mathbb{Y}_B)$  generated by  $\{y(i,m)\}_{(i,m)\in[1,r]\times\mathbb{Z}}$ .

By definition,  $\mathcal{A}^{\flat}(\mathbb{A}_B)$  is a sub-algebra of  $\mathcal{A}(\mathbb{A}_B)$ . The following proposition shows that the two algebras coincide.

<span id="page-13-1"></span>**Proposition 3.5.** The set  $\{x(i, 0), x(i, 1): i \in [1, r]\}$  generates  $\mathcal{A}(\mathbb{A}_B)$  as a ring. In particular,  $\mathcal{A}^\flat(\mathbb{A}_B)=\mathcal{A}(\mathbb{A}_B).$ 

*Proof.* Let  $R = \mathbb{Z}[z_1,\ldots,z_{2r}]$  be the polynomial ring in 2r variables. The results in [\[dSGHL23,](#page-22-8) §6.3] imply that there exists a surjective ring homomorphism

$$
\psi^{\text{BFZ}}: R \longrightarrow \mathcal{A}(\mathbb{A}_B),
$$

such that  $\psi^{\text{BFZ}}(z_i) = x(i,0)$  and  $\psi^{\text{BFZ}}(z_{r+i}) = x(i,1)$  for all  $i \in [1,r]$ . The claim then follows.  $\Box$ 

Suppose that g is a frieze of  $\mathcal{A}(\mathbb{A}_B)$ . Setting

$$
f(i, m) = g(x(i, m)), \qquad \forall (i, m) \in [1, r] \times \mathbb{Z},
$$

it is easy to see that  $f \in \text{Frieze}(A, \mathbb{Z}_{>0})$  (see [\[dSGHL23,](#page-22-8) §5.3] for more). In this case we say that f is obtained from g by evaluation. Proposition [3.5](#page-13-1) and [\[dSGHL23,](#page-22-8) Proposition 5.11] guarantee that the converse holds: every  $f \in \text{Frieze}(A, \mathbb{Z}_{>0})$  is obtained from a frieze of  $\mathcal{A}(\mathbb{A}_B)$ by evaluation.

Turning now to the Y-spaces, recall that we have the following chain of inclusions:

<span id="page-13-2"></span>
$$
\mathcal{A}^{\flat}(\mathbb{Y}_B) \subset \mathcal{A}^{\text{var}}(\mathbb{Y}_B) \subset \mathcal{A}(\mathbb{Y}_B) \subset \mathcal{U}(\mathbb{Y}_B). \tag{3.23}
$$

When B has size 2, we show in Lemma [4.5,](#page-16-0) Corollary [4.7](#page-17-1) that the inclusions in  $(3.23)$  are all equalities. When B is of finite type, it was shown in [\[CdSGL23,](#page-22-13) Theorem B] the set  $\{y(i, m):$  $(i, m) \in [1, r] \times \mathbb{Z}$  contains all global variables on  $\mathbb{Y}_B$ , and thus  $\mathcal{A}^{\flat}(\mathbb{Y}_B) = \mathcal{A}^{\text{var}}(\mathbb{Y}_B)$  in this case. It would be interesting to investigate the "gaps" between the rings in [\(3.23\)](#page-13-2), if they exist.

<span id="page-14-0"></span>**Definition 3.6.** By a *frieze of*  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$  we mean a ring homomorphism

$$
h:{\mathcal{A}}^{\flat}({\mathbb{Y}}_B)\longrightarrow {\mathbb{Z}}
$$

taking positive integer values on the set  $\{y(i, m) : (i, m) \in [1, r] \times \mathbb{Z}\}.$   $\diamond$ 

Suppose that h is a frieze of  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$ . Setting

$$
k(i, m) = h(y(i, m)), \qquad \forall (i, m) \in [1, r] \times \mathbb{Z}
$$

and applying h to both sides of [\(2.14\)](#page-10-5), we see that  $k \in \text{YFrieze}(A, \mathbb{Z}_{>0})$ . In this case, we say that  $k$  is *obtained from h by evaluation*. The following proposition says that this procedure establishes a bijection between Y-frieze patterns associated to A and friezes of  $\mathcal{A}^{\flat}(\mathbb{Y}_{B})$ .

<span id="page-14-1"></span>**Proposition 3.7.** Every arithmetic **Y**-frieze pattern associated to A is obtained from a (necessarily unique) frieze of  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$  by evaluation.

*Proof.* Uniqueness follows from the fact that the set  $\{y(i, m) : (i, m) \in [1, r] \times \mathbb{Z}\}\$  generates  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$ . It remains to show that every arithmetic Y-frieze pattern associated to A arises in this way. Suppose that  $f \in \text{YFrieze}(A, \mathbb{Z}_{>0})$ . Denote by  $\mathbf{y} = (y_1, \ldots, y_r)$  the Y-cluster of  $\mathbb{Y}_B$  at  $t_0 = t(1, 0)$ . By a direct computation (see e.g. [\[CdSGL23,](#page-22-13) proof of Theorem 5.2]), we know that

$$
y_i = y(i, 0) \prod_{j=1}^{i-1} (1 + y(j, 0))^{a_{j,i}}, \quad i \in [1, r].
$$

Define

$$
h: \mathbb{Z}[y_1^{\pm 1}, \dots, y_r^{\pm 1}] \longrightarrow \mathbb{Q}, \qquad y_i \longmapsto f(i,0) \prod_{j=1}^{i-1} (1 + f(j,0))^{a_{j,i}}.
$$

By Lemma [2.13,](#page-10-1) h restricts to a ring homomorphism, also denoted by h, from  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$  to  $\mathbb Q$ which takes positive values on every  $y(i, m)$ . It is not hard to check that

$$
h(y(i,0)) = f(i,0), \quad i \in [1,r].
$$

By applying  $h$  to both sides of  $(2.14)$  and reasoning inductively with respect to the total order [\(2.5\)](#page-6-1), we see that  $h(y(i, m)) = f(i, m)$  for all  $(i, m)$ . Since f is  $\mathbb{Z}_{>0}$ -valued by assumption,  $h(\mathcal{A}^{\flat}(\mathbb{Y}_B)) \subset \mathbb{Z}$ , i.e. h is a frieze of  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$  and we are done.

We conclude this section by establishing the connection between  $p_{A,S}$  given in §[2.3](#page-7-2) and the (pullback of the) ensemble map  $p_B^*$  defined in §[2.4.](#page-8-0) To do so, note that the semi-field homomorphism  $p_B^* : \mathbb{F}_{>0}(\mathbb{Y}_B) \to \mathbb{F}_{>0}(\mathbb{A}_B)$  defined in [\(2.10\)](#page-9-3) uniquely determines a ring homomorphism  $\mathcal{U}(\mathbb{Y}_B) \to \mathcal{U}(\mathbb{A}_B)$ , which we also denote by  $p_B^*$ . It is straightforward to show that

$$
p_B^*(y(i,m)) = \mathbf{x}_{t(i,m)}^{B_{t(i,m)}e_i} \stackrel{\text{denote}}{=} \hat{y}(i,m), \qquad \forall (i,m) \in [1,r] \times \mathbb{Z}
$$

which by [\(2.12\)](#page-9-2) and [\(2.19\)](#page-11-0) is a monomial in the variables  $\{x(i, m) : (i, m) \in [1, r] \times \mathbb{Z}\}\.$  Thus,  $p_B^*$  restricts to a ring homomorphism

$$
\widetilde{p}_B^* \stackrel{\text{denote}}{=} p_B^*|_{\mathcal{A}^\flat(\mathbb{Y}_B)} : \mathcal{A}^\flat(\mathbb{Y}_B) \longrightarrow \mathcal{A}(\mathbb{A}_B).
$$

<span id="page-14-2"></span>**Corollary 3.8.** Let  $S = \mathbb{Z}_{>0}$  and  $f \in \text{Frieze}(A, S)$ . If f is obtained from the frieze  $g : \mathcal{A}(\mathbb{A}_B) \to$  $\mathbb Z$  by evaluation, then  $p_{A,S}(f)$  is obtained from  $g \circ \widetilde{p}_B^* : \mathcal A^\flat(\mathbb Y_B) \to \mathbb Z$  via evaluation.

#### 4. Y-frieze patterns in rank 2

<span id="page-15-2"></span><span id="page-15-0"></span>4.1. Background on generalised cluster algebras. In this subsection, we recall some facts about generalised cluster algebras of rank 2. For a more detailed discussion, see [\[Rup13\]](#page-22-19).

Fix a, b two positive integers. Let n be a positive integer, t a formal variable and set  $P_n(t)$  $(1+t)^n$ . It is clear that  $P_n$  is monic and that  $t^n P(t^{-1}) = P(t)$ , i.e.  $P_n$  is palindromic. Let  $x_1, x_2$ be two formal commuting variables, and define  ${x_k}_{k\in\mathbb{Z}}$  recursively by the relations

$$
x_k x_{k+2} = \begin{cases} P_c(x_{k+1}), & k \text{ odd}, \\ P_b(x_{k+1}), & k \text{ even}. \end{cases}
$$
 (4.24)

Consider

$$
\mathcal{U}(P_b, P_c) = \bigcap_{k \in \mathbb{Z}} \mathbb{Z}[x_k^{\pm 1}, x_{k+1}^{\pm 1}] \text{ and } \mathcal{U}^+(P_b, P_c) = \bigcap_{k \in \mathbb{Z}} \mathbb{Z}_{\geq 0}[x_k^{\pm 1}, x_{k+1}^{\pm 1}]
$$

and denote by  $\mathcal{A}(P_b, P_c)$  the sub-algebra of  $\mathbb{Q}(x_1, x_2)$  generated by  $\{x_k\}_{k\in\mathbb{Z}}$ . The algebra  $\mathcal{A}(P_b, P_c)$  is a generalised cluster algebra in the sense of [\[Rup13\]](#page-22-19). Each  $x_k$  is called a generalised cluster variable and each pair  $(x_k, x_{k+1})$  a generalised cluster of  $\mathcal{A}(P_b, P_c)$ . Monomials in variables in a generalised cluster are called *generalised cluster monomials* of  $\mathcal{A}(P_b, P_c)$ .

<span id="page-15-3"></span>**Example 4.1.** 1) Let  $b = c = 1$ . Then  $\mathcal{A}(P_b, P_c)$  is the (ordinary) cluster algebra of type  $A_2$ . 2) Let  $b = 2, c = 1$ . Then  $x_k = x_{k+6}$  for all  $k \in \mathbb{Z}$ , and

$$
x_3 = \frac{x_2 + 1}{x_1}, \qquad x_5 = \frac{x_1^2 + 2x_1 + x_2 + 1}{x_1 x_2},
$$

$$
x_4 = \frac{(1 + x_1 + x_2)^2}{x_1^2 x_2}, \quad x_6 = \frac{(1 + x_1)^2}{x_2}.
$$

3) Let  $b = 3$ ,  $c = 1$ . Then  $x_k = x_{k+8}$  for all  $k \in \mathbb{Z}$ , and

$$
x_3 = \frac{1+x_2}{x_1}, \qquad x_5 = \frac{(1+x_1)^3 + 3x_1x_2 + x_2^2 + 2x_2}{x_1^2x_2}, \quad x_7 = \frac{(1+x_1)^3 + x_2}{x_1x_2},
$$
  

$$
x_4 = \frac{(1+x_1+x_2)^3}{x_1^3x_2}, \quad x_6 = \frac{(x_1^2 + 2x_1 + x_2 + 1)^3}{x_1^3x_2^2}, \qquad x_8 = \frac{(1+x_1)^3}{x_2}.
$$

The following is a summary of results we will need.

<span id="page-15-1"></span>Lemma 4.2. [\[Rup13,](#page-22-19) Theorems 1.1, 2.4, 2.5] The following statements hold.

- 1)  $\mathcal{A}(P_b, P_c) = \mathcal{U}(P_b, P_c)$ .
- 2) For each  $k \in \mathbb{Z}$ ,  $\{x_k, x_{k+1}, x_{k+2}, x_{k+3}\}$  is a generating set of  $\mathcal{A}(P_b, P_c)$  as a ring.
- 3) For each  $k \in \mathbb{Z}$ ,  $x_k \in \mathcal{U}^+(P_b, P_c)$ .

We now introduce friezes of  $\mathcal{A}(P_b, P_c)$ .

**Definition 4.3.** A frieze of  $\mathcal{A}(P_b, P_c)$  is a ring homomorphism  $\mathcal{A}(P_b, P_c) \longrightarrow \mathbb{Z}$  which takes positive integer values at all generalised cluster variables of A(Pb, Pc). ⋄

The following lemma will be used in the proof of Theorem [4.8.](#page-18-1)

<span id="page-15-4"></span>**Lemma 4.4.** Given a generalised cluster  $\mathbf{x} = (x_1, x_2)$  of  $\mathcal{A}(P_b, P_c)$ , the ring homomorphism

$$
\psi_{\mathbf{x}} : \mathbb{Z}[\mathbf{x}^{\pm 1}] \longrightarrow \mathbb{Z}, \quad \psi_{\mathbf{x}}(x_i) = 1, \ i = 1, 2,
$$

restricts to a frieze of  $A(P_b, P_c)$ . Moreover, distinct (as unordered sets) generalised clusters give rise to distinct friezes of  $\mathcal{A}(P_b, P_c)$ .

*Proof.* The restriction of  $\psi_{\mathbf{x}}$  to  $\mathcal{A}(P_b, P_c)$  is obviously a frieze of  $\mathcal{A}(P_b, P_c)$ , thanks to 3) in Lemma [4.2.](#page-15-1) Now suppose that  $\mathbf{x} = (x_1, x_2)$  and  $\mathbf{z} = (z_1, z_2)$  are two distinct generalised clusters such that  $\psi_{\mathbf{x}} = \psi_{\mathbf{z}}$ . Without loss of generality, we may assume that  $z_1 \notin \{x_1, x_2\}$ . On the one hand,  $\psi_{\mathbf{x}}(z_1) = 1$ , and on the other  $z_1 \in \mathbb{Z}_{\geq 0}[\mathcal{X}_1^{\pm 1}, \mathcal{X}_2^{\pm 1}]$  by Lemma [4.2.](#page-15-1) This implies that  $z_1$  is a Laurent monomial of  $x_1$  and  $x_2$ , say

$$
z_1 = x_1^{d_1} x_2^{d_2}.
$$

If  $d_1, d_2 \ge 0$ , i.e.  $x_1^{d_1} x_2^{d_2}$  is a generalised cluster monomial, then  $z_1 - x_1^{d_1} x_2^{d_2} = 0$ , which contradicts the linear independence of generalised cluster monomials proved in [\[Rup13,](#page-22-19) Theorem 1.1]. Thus we may assume that  $d_1 < 0$  or  $d_2 < 0$ . Without loss of generality, say  $d_1 < 0$ . Let  $\mathbf{x}'$  denote the unique generalised cluster of  $\mathcal{A}(P_b, P_c)$  containing  $x_2$  but not  $x_1$ . By a straightforward argument, one can show that  $z_1$  is not a Laurent polynomial in the generalised cluster variables of  $\mathbf{x}'$ , contradicting Lemma [4.2.](#page-15-1)  $\Box$ 

4.2. Arithmetic Y-frieze patterns in rank 2. Let b, c be as in §[4.1,](#page-15-2) and consider the  $2 \times 2$ symmetrisable generalised Cartan matrix

<span id="page-16-3"></span>
$$
A = \begin{pmatrix} 2 & -b \\ -c & 2 \end{pmatrix}.
$$
 (4.25)

Note that since  $b, c \neq 0$  by assumption, the matrix A is indecomposable in the sense of §[1.4.](#page-3-0) We set  $B = B_A$  as in [\(2.11\)](#page-9-1), and consider the positive space

$$
\mathbb{Y}_B = (\mathbb{F}(\mathbb{Y}_B), \{ \mathbf{y}_t = (y_{t;1}, y_{t;2}) \}_{t \in \mathbb{T}_2}).
$$

Setting  $t_0 = t(1,0)$  as in §[2.5,](#page-9-0) one sees that every  $t \in \mathbb{T}_2$  is of the form  $t(i,m)$  for a unique pair  $(i, m) \in [1, 2] \times \mathbb{Z}$ .

Recall that we have defined the rings  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$ ,  $\mathcal{A}^{var}(\mathbb{Y}_B)$ ,  $\mathcal{A}(\mathbb{Y}_B)$  and  $\mathcal{U}(\mathbb{Y}_B)$  associated to  $\mathbb{Y}_B$ in §[3.1](#page-12-3) and Definition [3.4.](#page-13-0)

<span id="page-16-0"></span>Lemma 4.5. With the notation as above, we have

$$
\mathcal{A}^{\flat}(\mathbb{Y}_{B})=\mathcal{A}^{\text{var}}(\mathbb{Y}_{B})=\mathcal{A}(\mathbb{Y}_{B}).
$$

*Proof.* It follows easily from [\[CdSGL23,](#page-22-13) Lemma 3.3] that the set of global variables on  $\mathbb{Y}_B$  is precisely  $\{y(i,m) : (i,m) \in [1,r] \times \mathbb{Z}\},\$  and thus  $\mathcal{A}^{\flat}(\mathbb{Y}_B) = \mathcal{A}^{\text{var}}(\mathbb{Y}_B)$ , by definition. Moreover, the set of global monomials on  $\mathbb{Y}_B$  is readily seen to be

<span id="page-16-1"></span>
$$
\{ \mathbf{y}_{t(1,m)}^{\mathbf{a}}, \mathbf{y}_{t(2,m)}^{-\mathbf{a}} : \mathbf{a} = (a_1, -a_2)^T, \ a_1, a_2 \in \mathbb{Z}_{\geq 0} \}. \tag{4.26}
$$

Using [\(2.9\)](#page-8-2) and the definition of  $y(i, m)$  given in §[2.5,](#page-9-0) we have

<span id="page-16-2"></span>
$$
\mathbf{y}_{t(1,m)} = (y(1,m), y(2,m-1)^{-1}) \text{ and } \mathbf{y}_{t(2,m)} = (y(1,m)^{-1}, y(2,m)), \forall m \in \mathbb{Z}. \tag{4.27}
$$

By combining [\(4.26\)](#page-16-1) and [\(4.27\)](#page-16-2), every global monomial on  $\mathbb{Y}_B$  is a monomial in  $\{y(i, m) : (i, m) \in$  $[1, 2] \times \mathbb{Z}$ , and therefore  $\mathcal{A}(\mathbb{Y}_B) \subset \mathcal{A}^{\flat}(\mathbb{Y}_B)$ . The claim then follows from [\(3.22\)](#page-12-2). <span id="page-17-0"></span>Proposition 4.6. The field isomorphism

<span id="page-17-3"></span>
$$
\mathbb{F}(\mathbb{Y}_B) \longrightarrow \mathbb{Q}(x_1, x_2), \quad y(1, 0) \mapsto x_1, \ y(2, 0) \mapsto x_2,\tag{4.28}
$$

restricts to an isomorphism of rings

$$
\phi: \mathcal{A}(\mathbb{Y}_B) \longrightarrow \mathcal{A}(P_b, P_c).
$$

Moreover,  $\phi$  maps global monomials on  $\mathbb{Y}_B$  to generalised cluster monomials of  $\mathcal{A}(P_b, P_c)$ , and global variables on  $\mathbb{Y}_B$  to generalised cluster variables of  $\mathcal{A}(P_b, P_c)$ . In particular, friezes of  $\mathcal{A}^{\flat}(\mathbb{Y}_B)$  are in bijection with friezes of  $\mathcal{A}(P_b, P_c)$  via pull-back by  $\phi$ .

*Proof.* By Lemma [4.5,](#page-16-0) it is enough to determine the image of the  $y(i, m)$ 's. We show by induction on the total order [\(2.5\)](#page-6-1) that

<span id="page-17-2"></span>
$$
\phi(y(i,m)) = x_{2m+i} \tag{4.29}
$$

for all  $m \in \mathbb{Z}$  and  $i = 1, 2$ . By definition,  $\phi(y(i, 0)) = x_i$  for  $i = 1, 2$ . Now fix  $m \ge 0$ , and assume that [\(4.29\)](#page-17-2) holds for  $i = 1, 2$  and  $0 \le k \le m$ . Then,

$$
\phi(y(1,m+1)) = \phi\left(\frac{(1+y(2,m))^c}{y(1,m)}\right) = \frac{(1+x_{2m+2})^c}{x_{2m+1}} = x_{2(m+1)+1}.
$$

Similarly,  $\phi(y(2,m+1)) = x_{2(m+1)+2}$ . Thus [\(4.29\)](#page-17-2) holds for all  $m \geq 0$ . By a similar argument, one can show that [\(4.29\)](#page-17-2) holds for all  $m \in \mathbb{Z}$ . In particular,  $\phi$  maps  $\mathcal{A}(\mathbb{Y}_B)$  bijectively onto  $\mathcal{A}(P_b, P_c)$ . The remaining claims follow by combining [\(4.29\)](#page-17-2) with [\(4.26\)](#page-16-1).

<span id="page-17-1"></span>**Corollary 4.7.** With the notation as above,  $\mathcal{A}(\mathbb{Y}_B) = \mathcal{U}(\mathbb{Y}_B)$ .

Proof. Using [\(4.27\)](#page-16-2), we see that

$$
\mathcal{U}(\mathbb{Y}_B) = \bigcap_{m \in \mathbb{Z}} \left( \mathbb{Z}[y(1,m)^{\pm 1}, y(2,m-1)^{\pm 1}] \cap \mathbb{Z}[y(1,m)^{\pm 1}, y(2,m)^{\pm 1}] \right).
$$

Moreover, [\(4.29\)](#page-17-2) implies that the image of  $\mathcal{U}(\mathbb{Y}_B)$  under [\(4.28\)](#page-17-3) is precisely  $\mathcal{U}(P_b, P_c) = \mathcal{A}(P_b, P_c)$ (this last equality is 1) of Lemma [4.2\)](#page-15-1). The result then follows from Proposition [4.6.](#page-17-0)  $\Box$ 

For convenience, we write  $A = A(P_b, P_c)$ . In analogy with the discussion in [\[GM22,](#page-22-7) §1.2], the superunitary region of A, denoted  $\mathcal{A}(\mathbb{R}_{>1})$ , is the set of all ring homomorphisms

$$
\mathcal{A}\longrightarrow \mathbb{R}
$$

which take values in  $\mathbb{R}_{\geq 1}$  for all generalised cluster variables of A. It is clear that

$$
\mathcal{A}(\mathbb{R}_{\geq 1}) \longrightarrow (\mathbb{R}_{\geq 1})^2, f \longmapsto (f(x_1), f(x_2)),
$$

is an embedding of  $\mathcal{A}(\mathbb{R}_{\geq 1})$  into  $(\mathbb{R}_{\geq 1})^2 \subset (\mathbb{R}_{>0})^2$ . Identifying  $\mathcal{A}(\mathbb{R}_{\geq 1})$  with its image in  $(\mathbb{R}_{>0})^2$ , the superunitary region can described explicitly by a (potentially infinite set) of polynomial inequalities, one for each generalised cluster variable of  $A$  (expressed as a Laurent polynomial in  $x_1$  and  $x_2$ ). Using Example [4.1,](#page-15-3) we graph the superunitary region (embedded in  $\mathbb{R}^2$ ) when  $1 \leq bc \leq 3$  in Figure [4.](#page-18-3)



<span id="page-18-3"></span>FIGURE 4. The superunitary region (embedded in  $\mathbb{R}^2$ ) in types  $A_2, C_2$  and  $G_2$ .

<span id="page-18-1"></span>**Theorem 4.8.** Let A be any  $2 \times 2$  indecomposable generalised symmetrisable Cartan matrix. There are finitely many arithmetic  $\mathbf Y$ -frieze patterns associated to A if and only if A is of finite type. When A is of finite type, the count of arithmetic  $Y$ -frieze patterns is given in the following table.



*Proof.* Suppose that A is indecomposable of finite type, i.e. A is of the form [\(4.25\)](#page-16-3) with  $1 \leq$  $bc \leq 3$ . By computing the generalised cluster variables of  $\mathcal{A} = \mathcal{A}(P_b, P_c)$  explicitly as in Example [4.1,](#page-15-3) one sees that the superunitary region  $\mathcal{A}(\mathbb{R}_{\geq 1})$  of  $\mathcal{A}$ , embedded in  $\mathbb{R}^2$ , is a compact set; see Figure [4.](#page-18-3) This implies that the set of friezes of  $A$ , which is a closed and discrete subset of  $\mathcal{A}(\mathbb{R}_{\geq 1})$ , is finite. By Proposition [4.6](#page-17-0) and Proposition [3.7,](#page-14-1) the set of arithmetic Y-frieze patterns associated to A is finite. The number of arithmetic Y-frieze patterns can then be calculated using a computer program.

Now suppose that A is of infinite type, i.e.  $bc \geq 4$ . It is well-known [\[FZ03,](#page-22-20) [CS14\]](#page-22-21) that  $\mathcal{A}(P_b, P_c)$  has infinitely many generalised clusters, and by Lemma [4.4](#page-15-4) there are infinitely many friezes of  $\mathcal{A}(P_b, P_c)$ . The claim that there are infinitely many Y-frieze patterns assocaited to A then follows from the bijections in Proposition [4.6](#page-17-0) and Proposition [3.7.](#page-14-1)  $\Box$ 

# 5. Y-frieze patterns in finite type

<span id="page-18-2"></span><span id="page-18-0"></span>5.1. **Symmetries of Y-frieze patterns.** Fix  $A = (a_{i,j})$  an  $r \times r$  indecomposable Cartan matrix of finite type, and let h denote the Coxeter number associated to A. We recall some notation introduced in [\[dSGHL23,](#page-22-8) §7.5].

1) When the Cartan matrix A is of type  $A_1, B, C, D_{2n}, n \geq 2, E_7, E_8, F_4$  or  $G_2$ , set

$$
i = i^*
$$
 and  $m_i = \frac{\mathbf{h}}{2}$ ,  $i \in [1, r]$ .

2) When A is of type  $A_n, D_{2n+1}, n \ge 2$ , or  $E_6$ , define the quiver Q whose vertex set is  $[1, r]$  and where, for each pair  $i \neq j$  there is one arrow from i to j if and only if  $i < j$  and  $a_{i,j} = -1$ . The map  $i \mapsto i^*$  is the permutation of the vertex set  $[1, r]$  induced by the unique graph automorphism

of the Dynkin diagram underlying Q. For  $i \in [1, r]$ , let

$$
\pi(i, i^*) : i = i_0 \longrightarrow i_1 \longrightarrow i_2 \longrightarrow \cdots \longrightarrow i_{l-1} \longrightarrow i_l = i^*
$$

be the unique path in the Dynkin diagram connecting i and i<sup>\*</sup>. If  $i = i^*$ , we set  $a_i = b_i = 0$ . If  $i \neq i^*$ , let  $a_i$  be the number of arrows in Q, whose underlying edges lie in  $\pi(i, i^*)$ , that are pointing towards  $i^*$ , and let  $b_i$  be the number of arrows in  $Q$ , whose underlying edges lie in  $\pi(i, i^*)$ , that are pointing towards i. For  $i \in [1, r]$ , set

$$
m_i = \frac{1}{2}(\mathbf{h} + a_i - b_i).
$$

Define the bijection (see [\[dSGHL23,](#page-22-8) §7.5 and Remark 7.25])

$$
\mathbf{F}_A:[1,r]\times\mathbb{Z}\longrightarrow[1,r]\times\mathbb{Z},\qquad \mathbf{F}_A(i,m)=(i^*,m+m_{i^*}+1).
$$

Recall from Remark [2.5](#page-5-0) and Remark [2.6](#page-6-0) the definitions of the generic frieze pattern and the generic Y-frieze pattern associated to A.

<span id="page-19-3"></span>**Lemma 5.1.** [\[CdSGL23,](#page-22-13) Proposition 6.2] The generic frieze pattern and the generic **Y**-frieze pattern associated to A are  $\mathbf{F}_A$ -invariant.

Let  $S$  be a semi-ring, and consider the statement:

<span id="page-19-0"></span> $S$  is the sub-semiring of some semifield.  $(5.30)$ 

All semi-rings and semi-fields encountered in Example [2.1](#page-4-6) and Example [2.2](#page-4-7) satisfy [\(5.30\)](#page-19-0).

<span id="page-19-1"></span>Theorem 5.2. For any semi-ring S satisfying [\(5.30\)](#page-19-0), S-valued frieze patterns and S-valued **Y**-frieze patterns associated to A are  $\mathbf{F}_{A}$ -invariant.

*Proof.* We prove the claim for Y-frieze patterns. To begin, assume that S is a semi-field. Recall from Lemma [2.7](#page-6-2) that any S-valued Y-frieze pattern is of the form  $k_s$  for some  $s = (s_1, \ldots, s_r) \in$  $S^r$ . Let  $\phi_s : \mathbb{Q}_{>0}(Y_1, \ldots, Y_r)$  denote the unique (see [\[BFZ96,](#page-22-11) Lemma 2.1.6]) semi-field homomorphism given by

 $\phi_{\mathbf{s}}(Y_i) = s_i, \qquad i \in [1, r],$ 

and let G denote the generic Y-frieze pattern. For all  $(i, m)$ , we have

$$
k_{\mathbf{s}}(i,m) = \phi_{\mathbf{s}} \circ G(i,m).
$$

The claim then follows from Lemma [5.1.](#page-19-3) Suppose now that  $S$  is a semi-ring satisfying [\(5.30\)](#page-19-0), and let  $\overline{S}$  be a semi-field such that  $S \subset \overline{S}$ , as semi-rings. Since every S-valued Y-frieze pattern is in particular an  $\overline{S}$ -valued Y-frieze pattern, the claim follows.

The claim for S-valued frieze patterns is obtained mutatis mutandis, and we omit it.  $\Box$ 

<span id="page-19-2"></span>5.2. Enumerating Y-frieze patterns. When  $S$  is a semi-field, S-valued Y-frieze patterns associated to A are in bijection with elements in  $S<sup>r</sup>$  (c.f. Lemma [2.7\)](#page-6-2). Note in particular that this is independent of the choice of symmetrisable generalised Cartan matrix.

On the other hand, one does not expect such a parametrisation of  $S$ -valued  $\bf{Y}$ -frieze patterns, when S is a semi-ring which is not a semi-field (as pointed out at the end of  $\S 2.2$ ). In this case, determining the number of S-valued Y-frieze patterns is in general rather delicate. In this section, we study this problem when S is the tropical semi-ring (Proposition [5.3\)](#page-20-0) or the semi-ring of positive integers (Theorem [5.5\)](#page-21-0).

<span id="page-20-0"></span>**Proposition 5.3.** Let A be an indecomposable Cartan matrix of finite type. Then, there are no non-trivial  $\mathbb{Z}_{\geq 0}^{\max}$ -valued **Y**-frieze patterns associated to A.

Before providing a proof, we mention the following interesting consequence.

<span id="page-20-1"></span>Corollary 5.4. Let A be an indecomposable Cartan matrix of finite type, and let  $S = \mathbb{Z}_{\geq 0}^{\max}$ . Then  $p_{A,S}$  is bijective.

The proof of Proposition [5.3](#page-20-0) is equivalent to the well-known statement that there are no nontrivial  $\mathbb{Z}_{\geq 0}$ -valued additive functions (c.f. [\[CdSGL23\]](#page-22-13) and [\[Rin12,](#page-22-14) §1]) associated to A, when A is of finite type. Unfortunately, we were unable to find a proof in the literature which covered the non-simply laced case; we provide a proof for completeness. To do so, we need to introduce some notation coming from Lie theory. First, let G be the connected and simply connected complex simple Lie group with same Cartan-Killing type as  $A$ . Fix a maximal torus  $T$  and a Borel subgroup B containing T, and let P be the character lattice of T. Let  $\{\alpha_1, \ldots, \alpha_r\} \subset \mathcal{P}$ be the set of simple roots determined by the pair  $(B, T)$ , and let  $\Phi_+ \subset \mathcal{P}$  be the corresponding set of positive roots.

Then, the set  $\{\alpha_1^{\vee}, \ldots, \alpha_r^{\vee}\}\$  of co-roots in the co-character lattice of T are such that

<span id="page-20-4"></span>
$$
a_{i,j} = (\alpha_i^{\vee}, \alpha_j), \quad \forall \ i, j \in [1, r]. \tag{5.31}
$$

Since G is simply connected,  $\{\alpha_1^{\vee}, \ldots, \alpha_r^{\vee}\}\$ is a basis of the co-character lattice of T. Let  $\{\omega_1,\ldots,\omega_r\}$  be the basis of  $\mathcal P$  dual to  $\{\alpha_1^{\vee},\ldots,\alpha_r^{\vee}\}\$ , so that  $\underline{\alpha}=\underline{\omega}A$ , where  $\underline{\alpha}=(\alpha_1,\ldots,\alpha_r)$  and  $\underline{\omega} = (\omega_1, \ldots, \omega_r)$ . Let W be the Weyl group generated by the reflections  $s_i = s_{\alpha_i}$  for  $i \in [1, r]$ , and consider the Coxeter element  $c = s_1 s_2 \cdots s_r$ . Introduce  $\beta = (\beta_1, \ldots, \beta_r)$ , where

$$
\beta_i = s_1 s_2 \cdots s_{i-1}(\alpha_i) \in \Phi_+, \quad i \in [1, r].
$$
\n(5.32)

Then  $\{\beta_i : i \in [1, r]\} = \{\beta \in \Phi_+ : c^{-1}\beta \in -\Phi_+\}.$  Write  $C = (-L_A U_A^{-1})^T$ , and

$$
L_A = \begin{pmatrix} 1 & 0 & \cdots & 0 \\ a_{2,1} & 1 & \cdots & 0 \\ \cdots & \cdots & \cdots & \cdots \\ a_{r,1} & a_{r,2} & \cdots & 1 \end{pmatrix} \quad \text{and} \quad U_A = \begin{pmatrix} 1 & a_{1,2} & \cdots & a_{1,r} \\ 0 & 1 & \cdots & a_{2,r} \\ \cdots & \cdots & \cdots & \cdots \\ 0 & 0 & \cdots & 1 \end{pmatrix}.
$$
 (5.33)

It is straightforward to check that [\[YZ08,](#page-22-22) Lemma 2.1]

<span id="page-20-2"></span>
$$
\underline{\alpha} = \underline{\beta} U_A, \quad c \underline{\alpha} = -\underline{\beta} L_A \quad \text{and} \quad \underline{\beta} = (1 - c)\underline{\omega}.
$$
 (5.34)

Let  $\mathcal{Q} = \text{Span}_{\mathbb{Z}}\{\alpha_1,\ldots,\alpha_r\} \subset \mathcal{P}$  be the root lattice. It follows from [\(5.34\)](#page-20-2) that  $\beta$  is a Z-basis of Q and that  $1 - c : \mathcal{P} \to \mathcal{Q}$  is a lattice isomorphism. It also follows from [\(5.34\)](#page-20-2) that

$$
c\underline{\beta} = -\underline{\beta} C^T. \tag{5.35}
$$

Since c has order h and does not have an eigenvalue equal to 1, we deduce that

<span id="page-20-3"></span>
$$
I_r + C + \dots + C^{\mathbf{h}-1} = 0.
$$
\n(5.36)

*Proof of Proposition [5.3.](#page-20-0)* By definition, a  $\mathbb{Z}_{\geq 0}$ -valued Y-frieze pattern associated to A is an assignment  $f : [1, r] \times \mathbb{Z} \to \mathbb{Z}_{\geq 0}$  such that

<span id="page-21-1"></span>
$$
f(i,m) + f(i,m+1) = \sum_{j=i+1}^{r} (-a_{j,i})f(j,m) + \sum_{j=1}^{i-1} (-a_{j,i})f(j,m+1),
$$
 (5.37)

for each  $(i, m) \in [1, r] \times \mathbb{Z}$ . Clearly, the map (called the *trivial map*)

$$
(i, m) \mapsto 0, \quad \forall (i, m) \in [1, r] \times \mathbb{Z}
$$

is a  $\mathbb{Z}_{\geq 0}$ -valued Y-frieze pattern associated to A. Now, suppose that f is a  $\mathbb{Z}_{\geq 0}$ -valued Y-frieze pattern associated to A. Setting  $f_m = (f(1, m), \dots, f(r, m))^T \in (\mathbb{Z}_{\geq 0})^r$  and re-arranging [\(5.37\)](#page-21-1), we have

$$
L_A^T f_m = -U_A^T f_{m+1}.
$$

Taking  $(-U_A^T)^{-1}$  on both sides, we obtain  $f_m = C^m f_0$  for all  $m \in \mathbb{Z}$ . Now, [\(5.36\)](#page-20-3) implies that

$$
0 = (I_r + C + C^2 + \dots + C^{h-1})f_0 = f_0 + f_1 + f_2 + \dots + f_{h-1}.
$$

Since f is  $\mathbb{Z}_{\geq 0}$ -valued, the equality holds if and only if all entries of  $f_0, f_1, \ldots$  are zero, i.e. f is the trivial map.  $\Box$ 

We now turn to arithmetic Y-frieze patterns associated to  $A$ . The proof of the following theorem is a simple adaptation of that in [\[Mul23\]](#page-22-2).

<span id="page-21-0"></span>Theorem 5.5. Let A be an indecomposable Cartan matrix of finite type. The set of arithmetic **Y**-frieze patterns associated to  $A$  is finite.

*Proof.* By Theorem [5.2,](#page-19-1) there exists a positive integer (depending on A) such that, for all  $k \in$ YFrieze( $A, \mathbb{Z}_{>0}$ ) and all  $(i, m) \in [1, r] \times \mathbb{Z}$ , we have

$$
k(i, m) = k(i, m + p). \tag{5.38}
$$

For each  $i \in [1, r]$ , set  $K_i = \prod_{m=1}^p k(i, m)$ . Since k is  $\mathbb{Z}_{>0}$ -valued,  $K_i \geq 1$ . We now show that  $K_i$  is bounded above. To do so, consider

$$
K_i^2 = \prod_{m=1}^p k(i,m)^2 = \prod_{m=1}^p k(i,m)k(i,m+1).
$$

Substituting [\(2.4\)](#page-4-5) in each term in the product on the right-hand side, we obtain

$$
K_i^2 = \prod_{m=1}^p \prod_{j=i+1}^r (1 + k(j, m))^{-a_{j,i}} \prod_{j=1}^{i-1} (1 + k(j, m+1))^{-a_{j,i}}.
$$

Write

$$
M_i = \prod_{m=1}^p \prod_{j=i+1}^r k(j,m)^{-a_{j,i}} \prod_{j=1}^{i-1} k(j,m+1)^{-a_{j,i}} = \prod_{j \neq i} K_j^{-a_{j,i}}.
$$

Set  $b_i = \prod_{j \neq i} 2^{-a_{j,i}}$ . Using the identity  $x < x + 1 \leq 2x$  which holds for all  $x \geq 1$ , we deduce that

<span id="page-21-2"></span>
$$
M_i < K_i^2 \le b_i^p M_i. \tag{5.39}
$$

Set  $\mathbf{K} = (K_1, \ldots, K_i, \ldots, K_r)$ . By dividing out by  $M_i$  in [\(5.39\)](#page-21-2) for each  $i \in [1, r]$ , we obtain (using the notation in §[1.4\)](#page-3-0) that  $\mathbf{K}^A \leq (b_1^p)$  $_1^p, \ldots, b_r^p$ . It is clear from [\(5.31\)](#page-20-4) that A is invertible and the entries of  $A^{-1}$  are all positive rationals (see e.g. [\[OV90,](#page-22-23) Table 2]). In particular, we deduce that

$$
\mathbf{K} \leq (b_1^p, \ldots, b_r^p)^{A^{-1}},
$$

i.e. each  $K_i$  is bounded above. Since k is  $\mathbb{Z}_{>0}$ -valued, this implies that each  $k(i, m)$  is bounded above, which concludes the proof.  $\Box$
