# Bounded quantifier depth spectrum for random uniform hypegraphs

The notion of spectrum for first-order properties introduced by J. Spencer for Erdős-Rényi random graph is considered in relation to random uniform hypergraphs. In this work we study the set of limit points of the spectrum for first-order formulae with bounded quantifier depth and obtain bounds for its maximum value. Moreover, we prove zero-one $k$-laws for the random uniform hypergraph and improve the bounds for the maximum value of the spectrum for first-order formulae with bounded quantifier depth. We obtain that the maximum value of the spectrum belongs to some two-element set.

Keywords: random hypergraphs, first-order properties, zero-one law.

## 1 Introduction

Asymptotic behavior of first-order properties probabilities of the Erdős-Rényi random graph $G(n, p)$ has been widely investigated (see [1]-[10]). In [2] the notion of spectrum of first-order properties was introduced and it was proved that there exists a first-order property with infinite spectrum. In this work we consider spectrum of first-order properties in relation to random uniform hypergraphs. Let us define the random s-uniform hypergraph $G^{s}(n, p)$. Consider the set $\Omega_{n}=\left\{G=\left(V_{n}, E\right)\right\}$ of all $s$-uniform hypergraphs (s-hypergraphs) with the set of vertices $V_{n}=\{1,2, \ldots, n\}$. The random hypergraph $G^{s}(n, p)$ is a random element with probability distribution

$$
\operatorname{Pr}\left[G^{s}(n, p)=G\right]=p^{|E|}(1-p)^{\binom{n}{s}-|E|} .
$$

Note that for $s=2$ in this definition we obtain the Erdős-Rényi random graph $G(n, p)$. Let us denote the event " $G^{s}(n, p)$ has a property $L$ " by $G^{s}(n, p) \models L$. First-order properties of $s$-uniform hypergraphs are defined by first-order formulae (see [10], [11]) which are built of predicate symbols $N$, =, logical connectivities, variables and quantifiers $\forall, \exists$. The $s$-ary

[^0]predicate symbol $N$ expresses the property of $s$ vertices to constitute an edge. Let us recall that the quantifier depth (see [10], [11]) of a first-order formula is the maximum number of nested quantifiers. Let $\mathcal{L}_{k}$ denote the set of all $s$-hypergraph properties which can be expressed by first-order formulae with quantifier depth at most $k$. Moreover, let $\mathcal{L}=\cup_{k \in \mathbb{N}} \mathcal{L}_{k}$ be the set of all first-order $s$-hypergraph properties.

The random hypergraph $G^{s}(n, p)$ is said to obey the zero-one law if for any first-order property $L \in \mathcal{L}$ the probability $\operatorname{Pr}\left[G^{s}(n, p) \models L\right]$ tends either to 0 or to 1 as $n \rightarrow \infty$. We say that the random hypergraph $G^{s}(n, p)$ obeys the zero-one $k$-law if for any first-order property $L \in \mathcal{L}_{k}$ the probability $\operatorname{Pr}\left[G^{s}(n, p) \models L\right]$ tends either to 0 or to 1 as $n \rightarrow \infty$.

Let us define the spectrum $S(L)$ for any first order property $L \in \mathcal{L} . S(L)$ is the set of all $\alpha \in(0, s-1)$ (we take the interval $(0, s-1)$ because the structure of $G^{s}\left(n, n^{-\alpha}\right)$ for $\alpha>s-1$ is considerably simpler than that for $\alpha<s-1$ and the study of $G^{s}(n, p)$ with $p(n) \gg n^{-s+1}$ is a subject of a separate investigation) which do not satisfy the following property: $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}(n, p) \models L\right]$ exists and is either 0 or 1 . Denote the union of $S(L)$ over all $L \in \mathcal{L}_{k}$ by $S_{k}$. In other words, $S_{k}$ is the set of all $\alpha \in(0, s-1)$ for which the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ does not obey the zero-one $k$-law.

Let $\left(S_{k}\right)^{\prime}$ be the set of limit points in $S_{k}$.
In [1 S. Shelah and J. Spencer proved that when $\alpha$ is an irrational number and $p(n)=$ $n^{-\alpha+o(1)}$ then the random graph $G(n, p)$ obeys the zero-one law. If $\alpha \in(0,1) \cap \mathbb{Q}$, where $\mathbb{Q}$ is the set of all rational numbers, then $G\left(n, n^{-\alpha}\right)$ does not obey the zero-one law. If $\alpha>1$, then $G\left(n, n^{-\alpha}\right)$ obeys the zero-one law if and only if $\alpha \notin\left\{1+\frac{1}{k}: k \in \mathbb{N}\right\}$.

In [3]-[6] zero-one $k$-laws for the random graph $G(n, p)$ were investigated. It was proved that if $\alpha$ is close to 0 or close to 1 , then $G\left(n, n^{-\alpha}\right)$ obeys the zero-one $k$-law. The spectrum $S_{k}$ for the random graph $G(n, p)$ was studied and it was shown that $\min S_{k}=\frac{1}{k-2}$ and $\max S_{k}=1-\frac{1}{2^{k-2}}$. Moreover, $\min \left(S_{k}\right)^{\prime} \leq \frac{1}{k-11}$ and $\max \left(S_{k}\right)^{\prime} \geq 1-\frac{1}{2^{k-5}}$.

In [12] the result from [1] was extended to the case of random uniform hypergraph $G^{s}(n, p)$. The random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ obeys the zero-one law if and only if $\alpha \in$ $(0, s-1) \backslash \mathbb{Q}$ or $\alpha \in(s-1, \infty) \backslash\left\{s-1+\frac{1}{k}: k \in \mathbb{N}\right\}$.

In our previous papers we studied the spectrum $S_{k}$ for the random hypergraph $G^{s}(n, p)$ and examined the question for which $k$ the set $S_{k}$ is infinite (see [13]). We also estimated the minimum and maximum values in $S_{k}$ and proved zero-one $k$-laws for the random hypergraph $G^{s}(n, p)$ (see [14], [12, [15]).

We showed that there exists an interval with the left endpoint equals to 0 , such that for all $\alpha$ from this interval the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ obeys the zero-one $k$-law.

Theorem 1. ([14]) Let $s \geq 3, k \geq s+1, \alpha>0$ and

$$
\frac{1}{\alpha}>\binom{k-1}{s-1}-1-\frac{s-1}{k-1}+\frac{2\left(1+\frac{s-1}{k-1}\right)}{\binom{k-1}{s-1}+2}
$$

Then the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ obeys the zero-one $k$-law.

We also proved that near the right endpoint of this interval there is a point $\alpha$ for which $G^{s}\left(n, n^{-\alpha}\right)$ does not obey the zero-one $k$-law.

Theorem 2. (14]) Let $s \geq 3, k \geq s+2$. Then there exists $\alpha>0$ such that

$$
\frac{1}{\alpha}>\binom{k-1}{s-1}-1-\frac{s-1}{k-1}-\frac{2}{\binom{k-1}{s-1}}
$$

and $G^{s}\left(n, n^{-\alpha}\right)$ does not obey the zero-one $k$-law.
These theorems provide a tight bound for the minimal point in $S_{k}$. The question what is the exact value of the minimal point for which the zero-one $k$-law does not hold remains open. Theorems 1 and 2 imply that this value asymptotically equals $1 /\left(\binom{k-1}{s-1}-1-\frac{s-1}{k-1}+O\left(\frac{1}{\binom{k-1}{s-1}}\right)\right)$ as $k \rightarrow \infty$.

Furthermore, we examined the zero-one $k$-law for the left neighborhood of $s-1$.
Theorem 3. ([14]) Let $\alpha \in\left(s-1-\frac{1}{2^{k-s+1}}, s-1\right) \backslash \mathcal{Q}_{k}$, where $\mathcal{Q}_{k}=\{s-1-$ $\left.\left.\frac{1}{2^{k-s+1}+\frac{a}{b}} \right\rvert\, a, b \in \mathbb{N}, a \leq 2^{k-s+1}\right\}$. Then the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ obeys the zeroone $k$-law.

Theorem 4. ([14]) Let $s \geq 3, k \geq s+4, \alpha=s-1-\frac{1}{2^{k-s+1}+a}$, where $a \in \mathbb{N}$, $a \leq 2^{k-s-2}+2^{k-s-3}+1$. Then the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ does not obey the zero-one $k$-law.

From Theorems 3 and 4 we obtain that the maximal point of $S_{k}$ lies between $s-1-$ $\frac{1}{2^{k-s+1}+2^{k-s-2}+2^{k-s-3}+1}$ and $s-1-\frac{1}{2^{k-s+2}}$.

We also estimated the minimum value in $\left(S_{k}\right)^{\prime}$.
Theorem 5. ([15]) There exists a constant $C$ such that for any $k \geq s+C$ we have $\min \left(S_{k}\right)^{\prime} \leq \frac{1}{\binom{k-11}{s-1}}$.

Taking into account the bound from Theorem 1 we deduce that Theorem 5 gives an asymptotically tight bound for $\min \left(S_{k}\right)^{\prime}$.

Corollary 1. We have $\min \left(S_{k}\right)^{\prime} \sim \frac{(s-1)!}{k^{s-1}}$, as $k \rightarrow \infty$.

## 2 New results

We examine the set $\left(S_{k}\right)^{\prime}$ of limit points in $S_{k}$ and estimate the maximum value in $\left(S_{k}\right)^{\prime}$.
Theorem 6. There exists a constant $C$ such that for any $k \geq s+C$ we have $\max \left(S_{k}\right)^{\prime} \geq s-1-\frac{1}{2^{k-s-4}}$.

From Theorems 3, 4 and 6 it follows that $-\log _{2}\left(s-1-\max \left(S_{k}\right)^{\prime}\right)=k-s+O(1)$.
We prove the zero-one $k$-law for the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ where $\alpha$ belongs to some set of rational numbers from $\left(s-1-\frac{1}{2^{k-s+1}}, s-1\right)$.

Theorem 7. Let $s \geq 3, k \geq s+1$ and $\frac{a}{b}$ be an irreducible positive fraction. Denote $\nu=\max \left(1,2^{k-s+1}-b\right)$. Let $a \in\left\{\nu, \nu+1, \ldots, 2^{k-s+1}\right\}, \alpha=s-1-\frac{1}{2^{k-s+1}+\frac{a}{b}}$. Then the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ obeys the zero-one $k$-law.

This theorem extends the class of rational fractions $\alpha$ for which the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ obeys the zero-one $k$-law and improves the bound obtained in Theorem 3. Theorem 7 implies that the maximal point of $S_{k}$ is not greater than $s-1-\frac{1}{2^{k-s+2}-2}$. From Theorem 7 it follows that $S_{k} \cap\left(s-1-\frac{1}{2^{k-s+1}}, s-1\right)$ is finite, so $\max \left(S_{k}\right)^{\prime} \leq s-1-\frac{1}{2^{k-s+1}}$.

We also disprove the zero-one $k$-law for the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ where $\alpha$ belongs to the left neighborhood of $s-1$.

Theorem 8. Let $s \geq 3, k \geq s+1$ and $\alpha=s-1-\frac{1}{2^{k-s+1}+a}$, where $a \in \mathbb{N}$, $a \leq 2^{k-s+1}-3$. Then the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ does not obey the zero-one $k$-law.

Theorem 8 improves the bound for the maximal point of $S_{k}$ which follows from Theorem 4. Theorems 7 and 8 imply that $\max \left(S_{k}\right) \in\left\{s-1-\frac{1}{2^{k-s+2}-3}, s-1-\frac{1}{2^{k-s+2}-2}\right\}$.

## 3 Auxiliary statements

### 3.1 Small subhypergraphs

For an arbitrary s-hypergraph $G=(V, E)$, set $v(G)=|V|, e(G)=|E|, \rho(G)=\frac{e(G)}{v(G)}$, $\rho^{\max }(G)=\max _{H \subseteq G} \rho(H) . G$ is called strictly balanced if the density $\rho(G)$ of this graph is greater than the density of any its proper subhypergraph. Denote the property of containing a copy of $G$ by $L_{G}$.

Theorem 9 ([16]). If $p \ll n^{-1 / \rho^{\max (G)}}$, then $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}(n, p) \models L_{G}\right]=0$. If $p \gg n^{-1 / \rho^{\max }(G)}$, then $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}(n, p) \models L_{G}\right]=1$.

In other words, the function $n^{-1 / \rho^{\max (G)}}$ is a threshold for the property $L_{G}$.
Let $G_{1}, \ldots, G_{m}$ be strictly balanced $s$-hypergraphs, $\rho\left(G_{1}\right)=\ldots=\rho\left(G_{m}\right)=\rho$. Let $a_{i}$ be the number of automorphisms of $G_{i}$. Denote by $N_{G_{i}}$ the number of copies of $G_{i}$ in $G^{s}(n, p)$. The following theorem is a generalization of a classical result of Bollobás (see, for example, [17]) to the case of $s$-uniform hypergraphs.

Theorem 10. If $p=n^{-1 / \rho}$, then

$$
\left(N_{G_{1}}, \ldots, N_{G_{m}}\right) \xrightarrow{d}\left(P_{1}, \ldots, P_{m}\right),
$$

where $P_{i} \sim \operatorname{Pois}\left(\frac{1}{a_{i}}\right)$ are independent Poisson random variables.

### 3.2 Extensions

Consider arbitrary s-hypergraphs $G$ and $H$ such that $H \subset G, V(H)=\left\{x_{1}, \ldots, x_{l}\right\}$, $V(G)=\left\{x_{1}, \ldots, x_{m}\right\}$. Denote $v(G, H)=v(G)-v(H), e(G, H)=e(G)-e(H), \rho(G, H)=$ $\frac{e(G, H)}{v(G, H)}, \rho^{\max }(G, H)=\max _{H \subset K \subseteq G} \rho(K, H)$. The pair $(G, H)$ is called strictly balanced if $\rho(G, H)>\rho(K, H)$ for any graph $K$ such that $H \subset K \subset G$.

Consider $s$-hypergraphs $\tilde{H}, \tilde{G}$, where $V(\tilde{H})=\left\{\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right\}, V(\tilde{G})=\left\{\tilde{x}_{1}, \ldots, \tilde{x}_{m}\right\}, \tilde{H} \subset \tilde{G}$. The hypergraph $\tilde{G}$ is called $\left(G,\left(x_{1}, \ldots, x_{l}\right)\right)$-extension of the tuple ( $\left.\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right)$, if

$$
\left\{x_{i_{1}}, \ldots, x_{i_{s}}\right\} \in E(G) \backslash E(H) \Rightarrow\left\{\tilde{x}_{i_{1}}, \ldots, \tilde{x}_{i_{s}}\right\} \in E(\tilde{G}) \backslash E(\tilde{H}) .
$$

If

$$
\left\{x_{i_{1}}, \ldots, x_{i_{s}}\right\} \in E(G) \backslash E(H) \Leftrightarrow\left\{\tilde{x}_{i_{1}}, \ldots, \tilde{x}_{i_{s}}\right\} \in E(\tilde{G}) \backslash E(\tilde{H})
$$

we call $\tilde{G}$ a $\operatorname{strict}\left(G,\left(x_{1}, \ldots, x_{l}\right)\right)$-extension of $\left(\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right)$.
Let $\alpha>0$. For any pair $(G, H)$, where $H \subset G$, set $f_{\alpha}(G, H)=v(G, H)-\alpha e(G, H)$. The pair $(G, H)$ is called $\alpha$-safe, if $f_{\alpha}(K, H)>0$ for any $K, H \subset K \subseteq G$. If for any $K$ such that $H \subset K \subseteq G$ we have $f_{\alpha}(G, K)<0$, then the pair $(G, H)$ is called $\alpha$-rigid. If for any $K$ such that $H \subset K \subset G$ we have $f_{\alpha}(K, H)>0$ and $f_{\alpha}(G, H)=0$, then the pair $(G, H)$ is called $\alpha$-neutral.

Let $\tilde{H} \subset \tilde{G} \subset \Gamma, T \subset K$ and $|V(T)| \leq|V(\tilde{G})|$. The pair $(\tilde{G}, \tilde{H})$ is called $(K, T)$-maximal in $\Gamma$, if for any subhypergraph $\tilde{T} \subset \tilde{G}$ with $|V(\tilde{T})|=|V(T)|$ and $\tilde{T} \cap \tilde{H} \neq \tilde{T}$ there does not exist a strict $(K, T)$-extension $\tilde{K}$ of $\tilde{T}$ in the hypergraph $\Gamma \backslash(\tilde{G} \backslash \tilde{T})$ such that $E((\tilde{K} \cup \tilde{G}) \backslash$ $\tilde{T}) \backslash(E(\tilde{K} \backslash \tilde{T}) \cup E(\tilde{G} \backslash \tilde{T}))=\varnothing$. The hypergraph $\tilde{G}$ is called $(K, T)$-maximal in $\Gamma$, if for any subhypergraph $\tilde{T} \subset \tilde{G}$ with $|V(\tilde{T})|=|V(T)|$ there does not exist a strict $(K, T)$-extension $\tilde{K}$ of $\tilde{T}$ in the hypergraph $\Gamma \backslash(\tilde{G} \backslash \tilde{T})$ such that $E((\tilde{K} \cup \tilde{G}) \backslash \tilde{T}) \backslash(E(\tilde{K} \backslash \tilde{T}) \cup E(\tilde{G} \backslash \tilde{T}))=\varnothing$.

Let a pair $(G, H)$ be $\alpha$-safe and $\mathcal{K}_{r}$ be the set of all $\alpha$-rigid and $\alpha$-neutral pairs $(K, T)$, where $|V(T)| \leq|V(G)|,|V(K) \backslash V(T)| \leq r$. Let $\tilde{x}_{1}, \ldots, \tilde{x}_{l} \in V_{n}$. Define a random variable $N_{(G, H)}^{r}\left(\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right)$ which assigns to each hypergraph $\mathcal{G} \in \Omega_{n}$ the number of all strict $(G, H)$ extensions $\tilde{G}$ of the hypergraph $\tilde{H}=\left.\mathcal{G}\right|_{\left\{\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right\}}$ such that for any $(K, T) \in \mathcal{K}_{r}$ the pair $(\tilde{G}, \tilde{H})$ is $(K, T)$-maximal in $\mathcal{G}$.

The following theorem is the generalization of Lemma 10.7.6 from [18] and Proposition 1 from [19] to the case of $s$-uniform hypergraphs. The proof of this theorem is analogous to the proof for graphs.

Theorem 11. Let $p(n)=n^{-\alpha}, r \in \mathbb{N}$ and $(G, H)$ be $\alpha$-safe. Then a.a.s. for every vertices $\tilde{x}_{1}, \ldots, \tilde{x}_{l}$ the following relation holds:

$$
N_{(G, H)}^{r}\left(\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right) \sim \mathrm{E}\left[N_{(G, H)}^{r}\left(\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right)\right]=\Theta\left(n^{f_{\alpha}(G, H)}\right)
$$

Denote by $L_{(G, H)}^{r}$ the following property: for any tuple $\left(\tilde{x}_{1}, \ldots, \tilde{x}_{l}\right)$ there exists a strict $\left(G,\left(x_{1}, \ldots, x_{l}\right)\right)$-extension which is $(K, T)$-maximal for all $(K, T) \in \mathcal{K}_{r}$. Theorem 11 implies that if $(G, H)$ is $\alpha$-safe, then the random hypergraph $G^{s}\left(n, n^{-\alpha}\right)$ satisfies $L_{(G, H)}^{r}$ a.a.s.

Denote by $\tilde{L}_{(G, H)}$ the property that there exists a copy of $H$ such that no copy of $G$ contains it. Denote by $\tilde{N}_{(G, H)}$ the number of copies of $H$ in $G^{s}(n, p)$ which are not contained in any copy of $G$.

Proposition 1 ([13]). Let $p(n)=n^{-\alpha}$, $H$ be a strictly balanced s-hypergraph, $(G, H)$ be a strictly balanced pair, $\rho(H)=\rho(G, H)=1 / \alpha$. Let $a_{1}$ be the number of automorphisms of $H$ which are extendable to some automorphism of $G$. Let $a_{2}$ be the number of automorphisms $\sigma: V(G) \rightarrow V(G)$ with $\sigma(x)=x$ for all $x \in V(H)$. Then

$$
\tilde{N}_{(G, H)} \xrightarrow{d} \operatorname{Pois}\left(\frac{1}{a(H)} \exp \left(-\frac{a(H)}{a_{1} a_{2}}\right)\right) .
$$

### 3.3 Cyclic extensions

We say that $(G, H)$ is a cyclic $m$-extension if $\rho^{\max }(G)<\frac{m}{m(s-1)-1}$, and $(G, H)$ fits one of the following patterns.

- $V(G, H)=\left\{y_{1}, \ldots, y_{k(s-1)}, z_{1}, \ldots, z_{l}\right\}$, and there exists a vertex $x_{1} \in H$ such that

$$
\begin{array}{r}
E(G, H)=\left\{\left\{x_{1}, y_{1}, \ldots, y_{s-1}\right\},\left\{y_{s-1}, \ldots, y_{2(s-1)}\right\}, \ldots,\left\{y_{(k-1)(s-1)}, \ldots, y_{k(s-1)}\right\},\right. \\
\left.\left\{y_{k(s-1)}, z_{1}, \ldots, z_{l}, u_{1}, \ldots, u_{s-1-l}\right\}\right\},
\end{array}
$$

where $1 \leq k \leq m-1,0 \leq l<s-1$ and $u_{1}, \ldots, u_{s-1-l} \in\left\{x_{1}, y_{1}, \ldots, y_{k(s-1)-1}\right\}$ are distinct. In such a situation, $(G, H)$ is called the first type extension.

- $V(G, H)=\left\{y_{1}, \ldots, y_{k(s-1)}, z_{1}, \ldots, z_{l}\right\}$, and there exist distinct vertices $x_{1}, x_{2} \in H$ such that

\begin{aligned}
E(G, H)=\left\{\left\{x_{1}, y_{1}, \ldots, y_{s-1}\right\},\left\{y_{s-1}, \ldots, y_{2(s-1)}\right\}, \ldots,\left\{y_{(k-1)(s-1)}, \ldots, y_{k(s-1)}\right\}\right. \\
\left.\left\{x_{2}, y_{k(s-1)}, z_{1}, \ldots, z_{l}, u_{1}, \ldots, u_{s-2-l}\right\}\right\}
\end{aligned}
$$

where $1 \leq k \leq m-1,0 \leq l \leq s-2$ and $u_{1}, \ldots, u_{s-2-l} \in\left\{y_{1}, \ldots, y_{k(s-1)-1}\right\}$ are distinct. If $x_{1} \neq x_{2}$, then $(G, H)$ is called the second type extension.

- $V(G, H)=\left\{y_{1}, \ldots, y_{s-l}\right\}, 2 \leq l \leq s-1$, and there exist distinct vertices $x_{1}, \ldots, x_{l} \in H$, such that

$$
E(G, H)=\left\{x_{1}, \ldots, x_{l}, y_{1}, \ldots, y_{s-l}\right\}
$$

In such a situation, $(G, H)$ is called the second type extension.
For any $m \geq 1$, define a set of $s$-hypergraphs $\mathcal{H}_{m}$. The one-vertex hypergraph $(\{x\}, \varnothing)$ belongs to $\mathcal{H}_{m}$. If $H \in \mathcal{H}_{m}$, then $\mathcal{H}_{m}$ contains all $s$-hypergraphs $G \supset H$, such that $(V(H), G)$ is a cyclic $m$-extension; $\mathcal{H}_{m}$ also contains all $s$-hypergraphs $\tilde{H}$ such that $V(\tilde{H})=V(H)$, $E(\tilde{H}) \supset E(H)$ and $\rho^{\max }(\tilde{H})<\frac{m}{m(s-1)-1}$.

Note that for any $G \in \mathcal{H}_{m}$ there exists a sequence of hypergraphs $G_{0}=(\{x\}, \varnothing) \subsetneq$ $G_{1} \ldots \subsetneq G_{t} \subseteq G$ such that $G_{i+1}$ is a cyclic $m$-extension of $G_{i}$ for all $i \in\{0, \ldots, t-1\}$. Let us call such sequence of hypergraphs $m$-decomposition of $G$.

Let $H \subset G$ be two subhypergraphs in a hypergraph $\Gamma$. The pair $(G, H)$ is cyclically $m$ maximal in $\Gamma$, if there are no cyclic $m$-extensions of $G$ in $\Gamma$ which are not cyclic $m$-extensions of $H$.

## 4 Proofs of theorems

Proof of Theorem 6. Let $m \in \mathbb{N}, \alpha=s-1-\frac{1}{2^{k-s-4}}+\frac{1}{2^{k-s-4} m}$ and $p=n^{-\alpha}$.
Set

The quantifier depths of $D_{i}$ and $D_{i}^{=}$equal $\left\lceil\log _{2} i\right\rceil+s-2$. The formula $D_{i}\left(x_{1}, x_{2}\right)$ expresses the property that the distance between $x_{1}$ and $x_{2}$ is at most $i, D_{i}^{=}\left(x_{1}, x_{2}\right)$ expresses the property that the distance between $x_{1}$ and $x_{2}$ is exactly $i$. Moreover, set $D_{i, j}^{=}(x, y, z)=$ $D_{i}^{=}(x, z) \wedge D_{j}^{=}(z, y)$ and $N_{i}(x, y)=\left\{z: D_{i, i}^{\overline{=}}(x, y, z)\right\}$.

Let $L$ be a first-order property which is expressed by the formula $\exists a \exists b Q(a, b)$ with quantifier depth $k$, where $Q(a, b)=Q_{1}(a, b) \wedge Q_{2}(a, b)$,

The predicate $Q_{1}(a, b)$ expresses the property that the distance between vertices $a$ and $b$ equals $2^{l}$ and there do not exist two edge-intersecting paths with length $2^{l-1}$ which connect the vertex $a$ (or, respectively, the vertex $b$ ) and two distinct vertices from the set $N_{2^{l-1}}(a, b)$.

Let $\tilde{\Omega}_{n}$ be the set of all hypergraphs $\mathcal{G}$ from $\Omega_{n}$ which satisfy the following properties.

1) For any strictly balanced pair $(G, H)$ such that $\rho(G, H)<\frac{1}{\alpha}$ and $v(G) \leq 2^{l+2}$ sm, any $v(H)$-tuple has a strict $(G, H)$-extension in $\mathcal{G}$ which is $(K, T)$-maximal for all $(K, T) \in \mathcal{K}_{2 l_{s}}$.
2) For any hypergraph $G$ with $\rho^{\max }(G)>\frac{1}{\alpha}$ and $v(G) \leq 2^{l+2} s m$, there is no copy of $G$ in $\mathcal{G}$.

Theorems 9 and 11 imply that $\operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \in \tilde{\Omega}_{n}\right] \rightarrow 1, n \rightarrow \infty$.
Denote by $d_{\mathcal{G}}(x, y)$ the distance between vertices $x, y$ in a hypergraph $\mathcal{G}$.
Suppose that a hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $L$. Let $a, b$ be vertices such that $Q(a, b)$ is true. Let $\chi=\left|N_{2^{l-1}}(a, b)\right|$ and $N_{2^{l-1}}(a, b)=\left\{x_{1}, \ldots, x_{\chi}\right\}$. Let $X$ be the union of $\chi$ paths with length $2^{l}$ and middle vertices $x_{1}, \ldots, x_{\chi}$ respectively which connect $a$ and $b$ in $\mathcal{G}$. Let us prove that $\chi \geq 2 m$. Suppose that $\chi<2 m$. By property 1) from the definition of $\tilde{\Omega}_{n}$ in $\mathcal{G}$ there exist distinct vertices $z_{1}, z_{2}$ such that for any $i \in\{1, \ldots,\lfloor\chi / 2\rfloor\}$ the predicate $D_{2^{l}}^{\overline{-}}\left(x_{i}, z_{1}\right)$ is true and for any $i \in\{\lfloor\chi / 2\rfloor+1, \ldots, 2\lfloor\chi / 2\rfloor\}$ the predicate $D_{2^{l}}^{=}\left(x_{i}, z_{2}\right)$ is true, $d_{\mathcal{G}}\left(a, z_{i}\right)>2^{l}$ and $d_{\mathcal{G}}\left(b, z_{i}\right)>2^{l}$ for any $i \in\{1,2\}$, and there exist $\lfloor\chi / 2\rfloor$ paths $P_{1}, \ldots, P_{\lfloor\chi / 2\rfloor}$ connecting $z_{1}$ and $x_{1}, \ldots, x_{\lfloor\chi / 2\rfloor}$ respectively such that for any distinct $i, j \in\{1, \ldots,\lfloor\chi / 2\rfloor\}$ equality $V\left(P_{i}\right) \cap V\left(P_{j}\right)=\left\{z_{1}\right\}$ holds and there exist $\lfloor\chi / 2\rfloor$ paths $Q_{1}, \ldots, Q_{\lfloor\chi / 2\rfloor}$ connecting $z_{2}$ and $x_{\lfloor\chi / 2\rfloor+1}, \ldots, x_{2\lfloor\chi / 2\rfloor}$ respectively such that for any distinct $i, j \in\{1, \ldots,\lfloor\chi / 2\rfloor\}$ equality $V\left(Q_{i}\right) \cap V\left(Q_{j}\right)=\left\{z_{2}\right\}$ holds. Indeed, in this case the pairs $\left(X \cup P_{1} \cup \ldots \cup P_{\lfloor\chi / 2\rfloor}, X\right)$ and $\left(X \cup P_{1} \cup \ldots \cup P_{\lfloor\chi / 2\rfloor} \cup Q_{1} \cup \ldots \cup Q_{\lfloor\chi / 2\rfloor}, X \cup P_{1} \cup \ldots \cup P_{\lfloor\chi / 2\rfloor}\right)$ are strictly balanced and their densities equal

This contradicts the truth of the predicate $Q_{2}(a, b)$. Therefore, $\chi \geq 2 m$. Let us prove that $\chi \leq 2 m$. Suppose that $\chi>2 m$. Let $\tilde{X}$ be the union of $2 m+1$ paths with length $2^{l}$ and
middle vertices $x_{1}, \ldots, x_{2 m+1}$ respectively which connect $a$ and $b$ in $\mathcal{G}$. Then the density of the subhypergraph $\tilde{X}$ is at least

This contradicts property 2 ) from the definition of $\tilde{\Omega}_{n}$. Therefore, $\chi=2 m$.
Let $H$ be the union of $2 m$ non-intersecting paths with length $2^{l}$ (such that consecutive edges of the paths intersect in one vertex) connecting vertices $a, b$. Let $x_{1}, \ldots, x_{2 m}$ be the middle vertices of these paths. Let $G \supset H$ be an $s$-hypergraph obtained from $H$ by adding a vertex $z$ and $m$ non-intersecting paths with length $2^{l}$ connecting $z$ and vertices $x_{1}, \ldots, x_{m}$ respectively. Then $H$ is strictly balanced, the pair $(G, H)$ is strictly balanced and $\rho(H)=$ $\rho(G, H)=\frac{1}{\alpha}$. Let $\tilde{L}$ be the property that in $\mathcal{G}$ there exists a copy of $H$ such that no copy of $G$ contains it.

Let us show that if the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $L$ then it satisfies the property $L_{H}$. Suppose that $\mathcal{G}$ satisfies $L$. Then there exist vertices $a, b$ satisfying $Q(a, b)$. As we have shown, $\left|N_{2^{l-1}}(a, b)\right|=2 m$. The property 2$)$ from the definition of $\tilde{\Omega}_{n}$ implies that the hypergraph $X$ is isomorphic to $H$, so $\mathcal{G}$ contains a copy of $H$.

Let us prove that if the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $\tilde{L}$ then it satisfies $L$. Suppose that $\mathcal{G}$ satisfies $\tilde{L}$. Let $X_{0} \subset \mathcal{G}$ be a copy of $H$ such that no copy of $G$ contains it. Let $a, b$ be the endpoints of the paths of $X_{0}$. Then $\left|N_{2^{l-1}}(a, b)\right|=2 m, Q_{1}(a, b)$ is true and $d_{\mathcal{G}}(x, y)=2^{l}$ for any distinct vertices $x, y \in N_{2^{l-1}}(a, b)$. Indeed, otherwise $\mathcal{G}$ contains a subhypergraph with at most $2^{l+2} s m$ vertices and density greater than $1 / \alpha$ which contradicts the definition of $\tilde{\Omega}_{n}$. Suppose that $Q(a, b)$ is false. Since $Q_{1}(a, b)$ is true, there exist distinct vertices $z_{1}, z_{2}$ such that the predicate $D_{2^{l}}^{\overline{=}}\left(\cdot, z_{1}\right) \vee D_{2^{l}}^{\overline{=}}\left(\cdot, z_{2}\right)$ is true for all vertices from $N_{2^{l-1}}(a, b)$ except at most one and the predicates $D_{2^{l}}\left(a, z_{i}\right)$ and $D_{2^{l}}\left(b, z_{i}\right)$ are false for any $i \in\{1,2\}$. Then without loss of generality we can assume that in $\mathcal{G}$ there exist paths $P_{1}, \ldots, P_{m}$ with length $2^{l}$ which connect vertex $z_{1}$ with vertices $x_{1}, \ldots, x_{m}$ respectively. Suppose that for some $i \in\{1, \ldots, m-1\}$ we have $P_{i+1} \subseteq P_{1} \cup \ldots \cup P_{i} \cup X_{0}$. Let $P_{i+1}: x_{i+1} \in \mathbf{e}_{1} \rightarrow \ldots \rightarrow \mathbf{e}_{\mathbf{2}^{1}} \ni z_{1}$, where $\mathbf{e}_{\mathbf{1}}, \ldots, \mathbf{e}_{\mathbf{2}^{1}}$ are the edges of the path $P_{i+1}$ considered in the order from $x_{i+1}$ to $z_{1}$. Let $t$ be the minimal number such that $\mathbf{e}_{\mathbf{t}} \notin X_{0}$. Then $\mathbf{e}_{\mathbf{t}} \in E\left(P_{j}\right)$ for some $j<i+1$. Since $d_{\mathcal{G}}\left(x_{i+1}, z\right)=d_{\mathcal{G}}\left(x_{j}, z\right)=2^{l}$, the edge $\mathbf{e}_{\mathbf{t}}$ is also the $t$-th edge in the path $P_{j}$ considered in the order from $x_{j}$ to $z_{1}$. Therefore, $d_{\mathcal{G}}\left(x_{i+1}, x_{j}\right) \leq 2 t-1$. Since $d_{\mathcal{G}}\left(x_{i+1}, x_{j}\right)=2^{l}$, we obtain that $t \geq 2^{l-1}+1$. This implies that one of the vertices $a, b$ belongs to the edge $\mathbf{e}_{2^{1-1}}$ and hence $\min \left(d_{\mathcal{G}}\left(a, z_{1}\right), d_{\mathcal{G}}\left(b, z_{1}\right)\right) \leq 2^{l-1}+1$ which contradicts the falsity of the predicates $D_{2^{l}}\left(a, z_{1}\right)$ and $D_{2^{l}}\left(b, z_{1}\right)$. Therefore, $P_{i+1} \nsubseteq P_{1} \cup \ldots \cup P_{i} \cup X_{0}$ for all $i \in\{1, \ldots, m-1\}$. Consider the sequence of hypergraphs $X_{0}, X_{1}=X_{0} \cup P_{1}, X_{2}=X_{0} \cup P_{1} \cup P_{2}, \ldots, X_{m}=X_{0} \cup P_{1} \cup \ldots \cup P_{m}$. For any $i \in\{1, \ldots, m\}$ the hypergraph $X_{i}$ is obtained from the hypergraph $X_{i-1}$ by adding $n_{i}$ vertices and $e_{i}$ edges, where $e_{i} \leq 2^{l}$ for any $i \in\{1, \ldots, m\}$ and $n_{i} \leq e_{i}(s-1)-1$ for any
$i \in\{2, \ldots, m\}, n_{1} \leq e_{1}(s-1)$. Therefore,

Equalities hold if and only if $e_{i}=2^{l}$ for all $i \in\{1, \ldots, m\}$ and $n_{i}=2^{l}(s-1)-1$ for all $i \in\{2, \ldots, m\}, n_{1}=2^{l}(s-1)$. Therefore, by the definition of $\tilde{\Omega}_{n}$ these equalities hold and $X_{m}$ is isomorphic to $G$. This contradicts the property $\tilde{L}$. Therefore, $Q(a, b)$ is true, and hence $\mathcal{G}$ satisfies $L$.

By Proposition 1, there exists $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models \tilde{L}\right]=c_{1} \in(0,1)$. By Theorem 10, there exists $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models L_{H}\right]=c_{2} \in(0,1)$. Since $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \in \tilde{\Omega}_{n}\right]=$ 1, it follows from the above that $\lim \inf _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models L\right] \geq c_{1}, \lim \sup _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models\right.$ $L] \leq c_{2}$. Letting $m \rightarrow \infty$ we obtain that $s-1-\frac{1}{2^{k-s-4}} \in\left(S_{k}\right)^{\prime}$.

## Proof of Theorem 7.

For an $s$-hypergraph $G$, let $d_{G}(x, \tilde{G})=\min _{y \in \tilde{G}} d_{G}(x, y)$ denote the distance between a vertex $x \in V(G)$ and a subhypergraph $\tilde{G} \subset G$. Denote by $d_{G}\left(\tilde{G}_{1}, \tilde{G}_{2}\right)=\min _{x \in V\left(G_{1}\right)} d_{G}\left(x, G_{2}\right)$ the distance between $\tilde{G}_{1}, \tilde{G}_{2} \subset G$.

By Proposition 1 from [12] there exists $\eta(1 / \alpha) \in \mathbb{N}$ such that any hypergraph $H_{1} \in$ $\mathcal{H}_{2^{k-s+1}}$ with $v\left(H_{1}\right) \geq \eta(1 / \alpha)$ contains a subhypergraph $H_{2} \in \mathcal{H}_{2^{k-s+1}}$ with $v\left(H_{2}\right) \leq \eta(1 / \alpha)$ and density $\rho\left(H_{2}\right)>1 / \alpha$. Set $n(\alpha)=\eta(1 / \alpha)+(k-s+1) s 2^{k-s+1}$.

Let $\tilde{\Omega}_{n}$ be the set of all hypergraphs $G$ from $\Omega_{n}$ which satisfy the following properties.

1) Let $H$ be an $s$-hypergraph with at most $n(\alpha)$ vertices. If $\rho^{\max }(H)>1 / \alpha$, then $G$ does not contain a subhypergraph isomorphic to $H$. If $\rho^{\max }(H)<1 / \alpha$, then $G$ contains an induced subhypergraph which is isomorphic to $H$ and ( $K_{2}, K_{1}$ )-maximal in $G$ for all $\left(K_{2}, K_{1}\right) \in \mathcal{K}_{2^{k-s+1} s}$.
2) For any $\alpha$-safe pair $\left(H_{2}, H_{1}\right)$ with $v\left(H_{2}\right) \leq n(\alpha)$ and for any $G_{1} \subset G$ with $v\left(G_{1}\right)=$ $v\left(H_{1}\right)$, there exists a subhypergraph $G_{2} \subset G$ such that $G_{2}$ is a strict ( $H_{2}, H_{1}$ )-extension of $G_{1}$ and $\left(G_{2}, G_{1}\right)$ is $\left(K_{2}, K_{1}\right)$-maximal in $G$ for all $\left(K_{2}, K_{1}\right) \in \mathcal{K}_{2^{k-s+1} s}$.
Theorems 9,11 imply that $\operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \in \tilde{\Omega}_{n}\right] \rightarrow 1$ as $n \rightarrow \infty$. The statement of the theorem follows from the existence of a winning strategy for Duplicator in $\operatorname{EHR}(G, H, k)$ for all pairs $(G, H)$ such that $G, H \in \tilde{\Omega}_{n}$.

Let $G, H \in \tilde{\Omega}_{n}$. Let $X_{r}$ and $Y_{r}$ be the hypergraphs chosen in the $r$-th round by Spoiler and Duplicator respectively. We denote vertices which are chosen in the first $r$ rounds in $X_{r}$ and $Y_{r}$ by $x_{r}^{1}, \ldots, x_{r}^{r}$ and $y_{r}^{1}, \ldots, y_{r}^{r}$. Let us describe Duplicator's strategy by induction.

Let $r$ rounds be finished, where $1 \leq r \leq k-s+2$. Let $l \in\{1, \ldots, r\}$. Let $\tilde{X}_{r}^{1}, \ldots, \tilde{X}_{r}^{l} \subset \tilde{X}_{r}$ and $\tilde{Y}_{r}^{1}, \ldots, \tilde{Y}_{r}^{l} \subset Y_{r}$ be subhypergraphs of $X_{r}$ and $Y_{r}$ respectively. We say that $\tilde{X}_{r}^{1}, \ldots, \tilde{X}_{r}^{l}$ and $\tilde{Y}_{r}^{1}, \ldots, \tilde{Y}_{r}^{l}$ are $(k, r, l)$-regular equivalent in $\left(X_{r}, Y_{r}\right)$, if the following properties hold.
(I) $x_{r}^{1}, \ldots, x_{r}^{r} \in V\left(\tilde{X}_{r}^{1} \cup \ldots \cup \tilde{X}_{r}^{l}\right), y_{r}^{1}, \ldots, y_{r}^{r} \in V\left(\tilde{Y}_{r}^{1} \cup \ldots \cup \tilde{Y}_{r}^{l}\right)$.
(II) For any distinct $j_{1}, j_{2} \in\{1, \ldots, l\}$, the inequalities $d_{X_{r}}\left(\tilde{X}_{r}^{j_{1}}, \tilde{X}_{r}^{j_{2}}\right)>2^{k-r-s+2}, d_{Y_{r}}\left(\tilde{Y}_{r}^{j_{1}}, \tilde{Y}_{r}^{j_{2}}\right)>$ $2^{k-r-s+2}$ hold.
(III) For any $j \in\{1, \ldots, l\}$, there is no cyclic $2^{k-r-s+2}$-extension of $\tilde{X}_{r}^{j}$ in the hypergraph $X_{r}$ and there is no cyclic $2^{k-r-s+2}$-extension of $\tilde{Y}_{r}^{j}$ in the hypergraph $Y_{r}$.
(IV) Cardinalities of the sets $V\left(\tilde{X}_{r}^{1} \cup \ldots \cup \tilde{X}_{r}^{l}\right)$ and $V\left(\tilde{Y}_{i}^{1} \cup \ldots \cup \tilde{Y}_{r}^{l}\right)$ are at most $\eta(\rho)+(r-$ 1) $s 2^{k-s+1}$.
(V) The hypergraphs $\tilde{X}_{r}^{j}$ and $\tilde{Y}_{r}^{j}$ are isomorphic for any $j \in\{1, \ldots, l\}$ and there exists a corresponding isomorphism (one for all these pairs of hypergraphs) which maps the vertices $x_{r}^{i}$ to the vertices $y_{r}^{i}$ for all $i \in\{1, \ldots, r\}$.
Two hypergraphs $\tilde{X}_{r}^{1}$ and $\tilde{Y}_{r}^{1}$ are called $(k, r)$-equivalent in $\left(X_{r}, Y_{r}\right)$ if
a) properties (I), (IV) and (V) hold for $l=1$,
b) there is no cyclic $\left(2^{k-r-s+2}-1\right)$-extension of $\tilde{X}_{r}^{1}\left(\right.$ resp. $\left.\tilde{Y}_{r}^{1}\right)$ in $X_{r}\left(\right.$ resp. $\left.Y_{r}\right)$,
c) there is no second type cyclic $2^{k-r-s+2}$-extension of $\left.X_{r}\right|_{\left\{x_{r}^{1}, \ldots, x_{r}^{r}\right\}}\left(\right.$ resp. $\left.\left.Y_{r}\right|_{\left\{y_{r}^{1}, \ldots, y_{r}^{r}\right\}}\right)$ in $X_{r} \backslash\left(\left.\tilde{X}_{r}^{1} \backslash X_{r}\right|_{\left\{x_{r}^{1}, \ldots, x_{r}^{r}\right\}}\right)\left(\right.$ resp. $\left.Y_{r} \backslash\left(\left.\tilde{Y}_{r}^{1} \backslash Y_{r}\right|_{\left\{y_{r}^{1}, \ldots, y_{r}^{r}\right\}}\right)\right)$,

The main idea of Duplicator's strategy is the following. Duplicator should play in such way that for some $r \in\{1, \ldots, k-s+1\}$ and $l \in\{1, \ldots, r\}$ in the hypergraphs $X_{r}, Y_{r}$ $(k, r, l)$-regular equivalent collections of subhypergraphs are constructed. In the first round, Duplicator must use the strategy $S_{1}$ which is described in the next section. After the $r$-th round, $r \in\{1, \ldots, k-s\}$, if ( $k, r, l$ )-regular equivalent collections are not constructed, then Duplicator can find $(k, r)$-equivalent hypergraphs and in the $(r+1)$-th round he must use the strategy $S_{r+1}$. Strategy SF is described in [12 and is used by Duplicator in the $(r+1)$-th round, $r \geq 1$, if and only if after the $r$-th round for some $l \in\{1, \ldots, r\}(k, r, l)$-regular equivalent collections of hypergraphs in $\left(X_{r}, Y_{r}\right)$ are constructed. In [12] it is proved that Duplicator wins, when he uses the strategy SF.

## Strategy $S_{1}$

Consider the first round and two possibilities to choose the first vertex by Spoiler.
Let in $X_{1}$ there is no cyclic $2^{k-s+1}$-extension of $\left(\left\{x_{1}^{1}\right\}, \varnothing\right)$. Then Duplicator chooses a vertex $y_{1}^{1} \in V\left(Y_{1}\right)$ such that there are no cyclic $2^{k-s+1}$-extensions of ( $\left\{y_{1}^{1}\right\}, \varnothing$ ) in $Y_{1}$ (such a vertex exists because $\left.Y_{1} \in \tilde{\Omega}_{n}\right)$. Set $\tilde{X}_{1}^{1}=\left(\left\{x_{1}^{1}\right\}, \varnothing\right), \tilde{Y}_{1}^{1}=\left(\left\{y_{1}^{1}\right\}, \varnothing\right)$. Then $\tilde{X}_{1}^{1}$ and $\tilde{Y}_{1}^{1}$ are $(k, 1,1)$-regular equivalent in $\left(X_{1}, Y_{1}\right)$. In this case, in the second round Duplicator exploits the strategy SF.

Let in $X_{1}$ there exists at least one cyclic $2^{k-s+1}$-extension of $\left(\left\{x_{1}^{1}\right\}, \varnothing\right)$. Let us prove that there exists a sequence of hypergraphs $G_{1}, G_{2}, \ldots, G_{t}$ such that
a) for any $i \in\{1, \ldots, s-1\}$ the hypergraph $G_{i+1}$ is a cyclic $2^{k-s+1}$-extension of the hypergraph $G_{i}$ in $X_{1}, G_{1}$ is a cyclic $2^{k-s+1}$-extension of ( $\left.\left\{x_{1}^{1}\right\}, \varnothing\right)$,
b) $G_{t}$ is an induced subhypergraph of $X_{1}$,
c) there are no cyclic $2^{k-s+1}$-extensions of $G_{t}$ in $X_{1}$,
d) either $\rho\left(G_{t}\right)<1 / \alpha$ or there exists $i \in\{1, \ldots, t-1\}$ such that the hypergraph $G_{i+1}$ is a cyclic $2^{k-s+1}$-extension of the hypergraph $G_{i}$ and there are no cyclic $\left(2^{k-s+1}-1\right)$ extensions of $G_{i}$ in $X_{1}$.

Let us prove the existence of such a sequence. Obviously, there exists a sequence $G_{0} \subset$ $G_{1} \subset \ldots \subset G_{i}$ with the following properties. First, $\left.G_{0}=\left\{x_{1}^{1}\right\}, \varnothing\right)$ and $G_{j}$ is a cyclic $\left(2^{k-s+1}-1\right)$-extension of the hypergraph $G_{j-1}$ for any $j \in\{1, \ldots, i\}$. Second, $j=i$ is the first number such that $G_{j}$ has no cyclic $\left(2^{k-s+1}-1\right)$-extensions in $X_{1}$. Let us add cyclic $2^{k-s+1}$-extensions to the hypergraph $G_{i}$ (each next hypergraph is a cyclic $2^{k-s+1}$-extension of the previous one) until there are no cyclic $2^{k-s+1}$-extensions of the final hypergraph in $X_{1}$. We get the sequence of hypergraphs $G_{1}, \ldots, G_{t}$, which follows Properties a) and c) (in addition, the inequality $t \leq 2^{k-s+1} b+1$ holds, because the density of $G_{t}$ is greater than $1 / \alpha$, if $t=2^{k-s+1} b+2$, this contradicts Property 1$)$ ).

Let us prove that $G_{t}$ is an induced subhypergraph of $X_{1}$. Set $e_{i}=e\left(G_{i}, G_{i-1}\right), v_{i}=$ $v\left(G_{i}, G_{i-1}\right)$ for all $i \in\{1, \ldots, t\}$. Set $e_{0}=e\left(\left.X_{1}\right|_{V\left(G_{t}\right)}\right)-e\left(G_{t}\right)$. Note that $e_{i} \leq 2^{k-s+1}$, $v_{i} \leq e_{i}(s-1)-1$. Then

$$
\frac{1}{\rho\left(\left.X_{1}\right|_{V\left(G_{t}\right)}\right)} \leq \frac{\left(e_{1}+\ldots+e_{t}\right)(s-1)-t+1}{e_{1}+\ldots+e_{t}+e}=s-1-\frac{(s-1) e+t-1}{e_{1}+\ldots+e_{t}+e}=s-1-\frac{1}{\tau},
$$

where $\tau=\frac{e_{1}+\ldots+e_{t}+e}{(s-1) e+t-1}$. We have

$$
\tau-2^{k-s+1}=\frac{\left(e_{1}-2^{k-s+1}\right)+\ldots+\left(e_{t}-2^{k-s+1}\right)+e-2^{k-s+1}((s-1) e-1)}{(s-1) e+t-1}
$$

which is less than 0 if $e \geq 1$ and $s \geq 3$. Thus $\frac{1}{\rho\left(\left.X_{1}\right|_{V\left(G_{t}\right)}\right)}<\alpha$ if $e \geq 1$. Therefore, $e=0$ and $G_{t}$ is an induced subhypergraph of $X_{1}$.

Let us show that $v_{i}=e_{i}(s-1)-1$ for all $i \in\{1, \ldots, t\}$. Suppose that there exists $i \in\{1, \ldots, t\}$ such that $v_{i} \leq e_{i}(s-1)-2$. Then

$$
\frac{1}{\rho\left(G_{t}\right)} \leq \frac{\left(e_{1}+\ldots+e_{t}\right)(s-1)-t}{e_{1}+\ldots+e_{t}}=s-1-\frac{1}{\left(e_{1}+\ldots+e_{t}\right) / t} \leq s-1-\frac{1}{2^{k-s+1}}<\alpha .
$$

Therefore, $v_{i}=e_{i}(s-1)-1$ for all $i \in\{1, \ldots, t\}$.
Let us prove that the hypergraph $G_{t}$ is strictly balanced. Let $\tilde{G}$ be an arbitrary proper subhypergraph in $G_{t}$. Denote $\tilde{G}_{1}=G_{1} \cap \tilde{G}$. If $\tilde{G}_{1} \neq G_{1}$, then $e\left(\tilde{G} \cup G_{1}, \tilde{G}\right) \leq 2^{k-s+1}$,
$v\left(\tilde{G} \cup G_{1}, \tilde{G}\right) \leq e\left(\tilde{G} \cup G_{1}, \tilde{G}\right)(s-1)-1$. Therefore, the density of the hypergraph $\tilde{G} \cup G_{1}$ is at least

$$
\frac{e(\tilde{G})+e\left(\tilde{G} \cup G_{1}, \tilde{G}\right)}{v(\tilde{G})+e\left(\tilde{G} \cup G_{1}, \tilde{G}\right)(s-1)-1}>\min \left(\frac{e(\tilde{G})}{v(\tilde{G})}, \frac{1}{s-1-\frac{1}{e\left(\tilde{G} \cup G_{1}, \tilde{G}\right)}}\right)=\rho(\tilde{G})
$$

In the same way, it can be proved that $\rho\left(G_{t}\right) \geq \rho\left(\tilde{G} \cup G_{t-1}\right) \geq \ldots \geq \rho\left(\tilde{G} \cup G_{1}\right) \geq \rho(\tilde{G})$, where at least one of the inequalities is strict, because $\tilde{G}$ is a proper subhypergraph in $G_{t}$. Therefore, the hypergraph $G_{t}$ is strictly balanced.

If $\rho\left(G_{t}\right)<\frac{1}{\alpha}$, then set $\tilde{X}_{1}^{1}=G_{t}$. By the definition of the set $\tilde{\Omega}_{n}$ the hypergraph $Y_{1}$ has a subhypergraph $\tilde{Y}_{1}^{1}$ which is isomorphic to $\tilde{X}_{1}^{1}$ and $(K, T)$-maximal for any pair $(K, T)$ such that $v(K) \leq 2^{k-s+1} s$ and $f_{\alpha}(K, T)<0$. Let $\varphi: \tilde{X}_{1}^{1} \rightarrow \tilde{Y}_{1}^{1}$ be an isomorphism. Then Duplicator chooses the vertex $y_{1}^{1}=\varphi\left(x_{1}^{1}\right)$. By the construction of the hypergraphs $\tilde{X}_{1}^{1}$ and $\tilde{Y}_{1}^{1}$, they do not have cyclic $2^{k-s+1}$-extensions in $X_{1}$ and $Y_{1}$ respectively. Therefore, the hypergraphs $\tilde{X}_{1}^{1}$ and $\tilde{Y}_{1}^{1}$ are $(k, 1,1)$-regular equivalent in $\left(X_{1}, Y_{1}\right)$. In the second round Duplicator exploits the strategy SF.

Let $\rho\left(G_{t}\right)=\frac{1}{\alpha}$. Then

$$
1 / \rho\left(G_{t}\right)=s-1-\frac{1}{\left(e_{1}+\ldots+e_{t}\right) /(t-1)}=s-1-\frac{1}{2^{k-s+1}+a / b} .
$$

Since $a / b$ is an irreducible fraction, $t \geq b+1$. Let us show that there exists $i \in\{0, \ldots, t-1\}$ such that $G_{i+1}$ is not a cyclic $\left(2^{k-s+1}-1\right)$-extension of $G_{i}$. Indeed, otherwise

$$
\begin{aligned}
1 / \rho\left(G_{t}\right) \leq s-1-\frac{1}{2^{k-s+1}-1+\frac{2^{k-s+1}-1}{t-1}} \leq s-1- & \frac{1}{2^{k-s+1}-1+\frac{2^{k-s+1}-1}{b}}= \\
& =s-1-\frac{1}{2^{k-s+1}+\frac{2^{k-s+1}-b-1}{b}}<\alpha,
\end{aligned}
$$

since $a \geq 2^{k-s+1}-b$. Since $G_{t}$ is strictly balanced, $\rho^{\max }\left(G_{i}\right)<1 / \alpha$. As $Y_{1} \in \tilde{\Omega}_{n}$, in $Y_{1}$ there exists a subhypergraph $\tilde{Y}_{1}^{1}$ which is isomorphic to $\tilde{X}_{1}^{1}:=G_{i}$ and $(K, T)$-maximal for any pair $(K, T)$ such that $v(K) \leq 2^{k-s+1} s$ and $f_{\alpha}(K, T)<0$. Let $\varphi: \tilde{X}_{1}^{1} \rightarrow \tilde{Y}_{1}^{1}$ be an isomorphism. Then Duplicator chooses the vertex $y_{1}^{1}=\varphi\left(x_{1}^{1}\right)$. By the construction of the hypergraphs $\tilde{X}_{1}^{1}$ and $\tilde{Y}_{1}^{1}$, they are $(k, 1)$-equivalent in $\left(X_{1}, Y_{1}\right)$. Therefore, in the second round Duplicator exploits the strategy $S_{2}$.

## Strategy $S_{r+1}$

Let after the $r$-th round, $r \in\{1, \ldots, k-s+1\}$, there exist hypergraphs $\tilde{X}_{r}^{1}, \tilde{Y}_{r}^{1}$ which are $(k, r)$-equivalent in $\left(X_{r}, Y_{r}\right)$. Let $\varphi: \tilde{X}_{r}^{1} \rightarrow \tilde{Y}_{r}^{1}$ be an isomorphism. In the $(r+1)$-th round, Spoiler chooses a vertex $x_{r+1}^{r+1}$. If $X_{r+1}=X_{r}$, then set $\tilde{X}_{r+1}^{1}=\tilde{X}_{r}^{1}, \tilde{Y}_{r+1}^{1}=\tilde{Y}_{r}^{1}$. Otherwise, set $\tilde{X}_{r+1}^{1}=\tilde{Y}_{r}^{1}, \tilde{Y}_{r+1}^{1}=\tilde{X}_{r}^{1}$.

Let $x_{r+1}^{r+1} \in V\left(\tilde{X}_{r+1}^{1}\right)$. Duplicator chooses the vertex $y_{r+1}^{r+1}=\varphi\left(x_{r+1}^{r+1}\right)$, if $X_{r+1}=X_{r}$, and the vertex $y_{r+1}^{r+1}=\varphi^{-1}\left(x_{r+1}^{r+1}\right)$, if $X_{r+1}=Y_{r}$. As in $X_{r}, Y_{r}$ there are no cyclic $2^{k-r-s+1}-$ extensions of the hypergraphs $\tilde{X}_{r}^{1}, \tilde{Y}_{r}^{1}$ respectively (by the definition of $(k, r)$-equivalence), the hypergraphs $\tilde{X}_{r+1}^{1}, \tilde{Y}_{r+1}^{1}$ are $(k, r+1,1)$-regular equivalent in $\left(X_{r+1}, Y_{r+1}\right)$. Therefore, in the ( $r+2$ )-th round Duplicator exploits the strategy SF.

Let $x_{r+1}^{r+1} \notin V\left(\tilde{X}_{r+1}^{1}\right)$. Consider several cases.
Suppose first that $r<k-s+1$.
Let $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, x_{r+1}^{r+1}\right)>2^{k-r-s+1}$. If in $X_{r+1}$ there are no cyclic $2^{k-r-s+1}$-extensions of the hypergraph $\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)$, then set $\tilde{X}_{r+1}^{2}=\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)$. By Property 2) of the hypergraph $Y_{r+1}$, it has a vertex $y_{r+1}^{r+1}$ such that $d_{Y_{r+1}}\left(\tilde{Y}_{r+1}^{1}, y_{r+1}^{r+1}\right)=2^{k-r-s+1}+1$ and there are no cyclic $2^{k-r-s+1}$-extensions of $\left(\left\{y_{r+1}^{r+1}\right\}, \varnothing\right)$ in $Y_{r+1}$. Set $\tilde{Y}_{r+1}^{2}=\left(\left\{y_{r+1}^{r+1}\right\}, \varnothing\right)$. If there is exactly one cyclic $2^{k-r-s+1}$-extension of $\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)$, then we denote it by $\tilde{X}_{r+1}^{2}$ (the hypergraph $\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)$ has at most one cyclic $2^{k-r-s+1}$-extension in $\left.X_{r+1}\right)$. Let $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, \tilde{X}_{r+1}^{2}\right)>$ $2^{k-r-s+1}$. By Property 2) of the hypergraph $Y_{r+1}$, it has a vertex $y_{r+1}^{r+1}$ and a subhypergraph $\tilde{Y}_{r+1}^{2}$ such that $d_{Y_{r+1}}\left(\tilde{Y}_{r+1}^{1}, \tilde{Y}_{r+1}^{2}\right)=2^{k-r-s+1}+1$, pairs $\left(\tilde{Y}_{r+1}^{2},\left(\left\{y_{r+1}^{r+1}\right\}, \varnothing\right)\right)$ and $\left(\tilde{X}_{r+1}^{2},\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)\right)$ are isomorphic, and there are no cyclic $2^{k-r-s+1}$-extensions of $\tilde{Y}_{r+1}^{2}$ in $Y_{r+1}$. The property of $(k, r)$-equivalence of the hypergraphs $\tilde{X}_{r}^{1}, \tilde{Y}_{r}^{1}$ in $\left(X_{r}, Y_{r}\right)$ implies nonexistence of cyclic $2^{k-r-s+1}$-extensions of $\tilde{X}_{r}^{1}$ and $\tilde{Y}_{r}^{1}$ in $X_{r}$ and $Y_{r}$ respectively. Obviously, in all the considered cases the collections $\tilde{X}_{r+1}^{1}, \tilde{X}_{r+1}^{2}$ and $\tilde{Y}_{r+1}^{1}, \tilde{Y}_{r+1}^{2}$ are ( $k, r+1,2$ )-regular equivalent in $\left(X_{r+1}, Y_{r+1}\right)$. Thus, in the $(r+2)$-th round Duplicator exploits the strategy SF. Let $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, \tilde{X}_{r+1}^{2}\right) \leq 2^{k-r-s+1}$. The property of $(k, r)$-equivalence of the hypergraphs $\tilde{X}_{r}^{1}, \tilde{Y}_{r}^{1}$ in $\left(X_{r}, Y_{r}\right)$ implies $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, \tilde{X}_{r+1}^{2}\right)=2^{k-r-s+1}$ and non-existence of cyclic $\left(2^{k-r-s+1}-1\right)$-extensions of $\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)$ in $X_{r+1}$. By Property 2) of the hypergraph $Y_{r+1}$, it has a vertex $y_{r+1}^{r+1}$ such that $d_{Y_{r+1}}\left(\tilde{Y}_{r+1}^{1}, y_{r+1}^{r+1}\right)=2^{k-r-s+1}+1$ and there are no cyclic $2^{k-r-s+1}$ extensions of $\left(\left\{y_{r+1}^{r+1}\right\}, \varnothing\right)$ in $Y_{r+1}$. Set $\tilde{X}_{r+1}^{1}:=\tilde{X}_{r+1}^{1} \cup\left\{\left\{x_{r+1}^{r+1}\right\}, \varnothing\right\}, \tilde{Y}_{r+1}^{1}:=\tilde{Y}_{r+1}^{1} \cup\left\{\left\{y_{r+1}^{r+1}\right\}, \varnothing\right\}$. The hypergraphs $\tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}$ are ( $k, r+1$ )-equivalent in $\left(X_{r+1}, Y_{r+1}\right)$ and in the next round Duplicator exploits the strategy $S_{r+2}$.

Let $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, x_{r+1}^{r+1}\right) \leq 2^{k-r-s+1}$. Consider a minimal chain $L_{X}$ in $X_{r+1}$ which connects $x_{r+1}^{r+1}$ and $\tilde{X}_{r+1}^{1}$. Moreover, let such chain connect $x_{r+1}^{r+1}$ and one of the vertices $x_{r+1}^{1}, \ldots, x_{r+1}^{r}$ if such a minimal chain exists. By Property 2) of the hypergraph $Y_{r+1}$, there exists a vertex $y_{r+1}^{r+1}$ such that $d_{Y_{r+1}}\left(\tilde{Y}_{r+1}^{1}, y_{r+1}^{r+1}\right)=d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, x_{r+1}^{r+1}\right)$, there exists an isomorphism $L_{X} \cup \tilde{X}_{r+1}^{1} \rightarrow L_{Y} \cup \tilde{Y}_{r+1}^{1}$ which maps the vertices $x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}$ to the vertices $y_{r+1}^{1}, \ldots, y_{r+1}^{r+1}$ respectively, and the pair $\left(L_{Y} \cup \tilde{Y}_{r+1}^{1}, \tilde{Y}_{r+1}^{1}\right)$ is cyclically $2^{k-r-s+1}$-maximal in $Y_{r+1}$, where $L_{Y}$ is a minimal chain which connects $y_{r+1}^{r+1}$ and $\tilde{Y}_{r+1}^{1}$ in $Y_{r+1}$. Obviously, there are no cyclic $2^{k-r-s+1}$-extensions of the hypergraph $\tilde{Y}_{r+1}^{1}$ in $Y_{r+1}$. If there are no cyclic $2^{k-r-s+1}{ }^{-}$ extensions of $L_{X} \cup \tilde{X}_{r+1}^{1}$ in $X_{r+1}$, then set $\tilde{X}_{r+1}^{1}:=L_{X} \cup \tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}:=\tilde{Y}_{r+1}^{1} \cup L_{Y}$. Obviously, the hypergraphs $\tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}$ are ( $k, r+1,1$ )-regular equivalent in $\left(X_{r+1}, Y_{r+1}\right)$. Therefore, in the next round Duplicator exploits the strategy SF. If there is a cyclic $2^{k-r-s+1}{ }^{-}$ extension of $L_{X} \cup \tilde{X}_{r+1}^{1}$ in $X_{r+1}$, then $d_{X_{r+1}}\left(x_{r+1}^{r+1}, \tilde{X}_{r+1}^{1}\right)=2^{k-r-s+1}$ and there are no cyclic
$\left(2^{k-r-s+1}-1\right)$-extensions of $L_{X} \cup \tilde{X}_{r+1}^{1}$ in $X_{r+1}$. The property of $(k, r)$-equivalence of the hypergraphs $\tilde{X}_{r+1}^{1}, \tilde{Y}_{r+1}^{1}$ in $\left(X_{r+1}, Y_{r+1}\right)$ implies that either there are no second type cyclic $2^{k-r-s+1}$-extension of $\left.X_{r+1}\right|_{\left\{x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}\right\}}$ in $X_{r+1} \backslash\left(\left.\tilde{X}_{r+1}^{1} \backslash X_{r+1}\right|_{\left\{x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}\right\}}\right)$ or the chain $L_{X}$ could be chosen from a set of chains $\left\{L_{X}^{j}\right\}$ which connect vertex $x_{r+1}^{r+1}$ with some vertex $x_{r+1}^{i}$, where $i \in\{1, \ldots, r\}$. In the first case the hypergraphs $\tilde{X}_{r+1}^{1}:=L_{X} \cup \tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}:=$ $\tilde{Y}_{r+1}^{1} \cup L_{Y}$ are $(k, r+1)$-equivalent in $\left(X_{r+1}, Y_{r+1}\right)$ and in the next round Duplicator exploits the strategy $S_{r+2}$. Consider the second case. If in the $(r+2)$-th round Spoiler chooses a vertex from the chain $L_{X}^{j}$ for some $j$, then set $\tilde{X}_{r+1}^{1}:=L_{X}^{j} \cup \tilde{X}_{r+1}^{1}$. Otherwise, set $\tilde{X}_{r+1}^{1}:=L_{X}^{1} \cup \tilde{X}_{r+1}^{1}$. Set $\tilde{Y}_{r+1}^{1}:=\tilde{Y}_{r+1}^{1} \cup L_{Y}$. Then the hypergraphs $\tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}$ satisfy properties a), b) from the definition of $(k, r+1)$-equivalence and the vertex $x_{r+2}^{r+2}$ does not belong to any second type cyclic $2^{k-r-s+1}$-extension of $\left.X_{r+1}\right|_{\left\{x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}\right\}}$ in $X_{r+1} \backslash\left(\left.\tilde{X}_{r+1}^{1} \backslash X_{r+1}\right|_{\left\{x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}\right\}}\right)$ which enables Duplicator to exploit the strategy $S_{r+2}$ in the $(r+2)$-th round.

Suppose that $r=k-s+1$. If $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, x_{r+1}^{r+1}\right)>1$, then set $\tilde{X}_{r+1}^{2}=\left(\left\{x_{r+1}^{r+1}\right\}, \varnothing\right)$. By Property 2) of the hypergraph $Y_{r+1}$, it has a vertex $y_{r+1}^{r+1}$ such that $d_{Y_{r+1}}\left(\tilde{Y}_{r+1}^{1}, y_{r+1}^{r+1}\right)=2$. Set $\tilde{Y}_{r+1}^{2}=\left(\left\{y_{r+1}^{r+1}\right\}, \varnothing\right)$. The property of $(k, r)$-equivalence of the hypergraphs $\tilde{X}_{r}^{1}, \tilde{Y}_{r}^{1}$ in $\left(X_{r}, Y_{r}\right)$ implies non-existence of cyclic 1-extensions of $\tilde{X}_{r}^{1}$ and $\tilde{Y}_{r}^{1}$ in $X_{r}$ and $Y_{r}$ respectively. Then the collections $\tilde{X}_{r+1}^{1}, \tilde{X}_{r+1}^{2}$ and $\tilde{Y}_{r+1}^{1}, \tilde{Y}_{r+1}^{2}$ are $(k, r+1,2)$-regular equivalent in $\left(X_{r+1}, Y_{r+1}\right)$. Thus, in the $(r+2)$-th round Duplicator exploits the strategy SF.

If $d_{X_{r+1}}\left(\tilde{X}_{r+1}^{1}, x_{r+1}^{r+1}\right)=1$ then consider an edge $e_{X}$ which connects $x_{r+1}^{r+1}$ and $\tilde{X}_{r+1}^{1}$. Moreover, let such edge connect $x_{r+1}^{r+1}$ and one of the vertices $x_{r+1}^{1}, \ldots, x_{r+1}^{r}$ if such an edge exists. By Property 2) of the hypergraph $Y_{r+1}$, there exists a vertex $y_{r+1}^{r+1}$ such that $d_{Y_{r+1}}\left(\tilde{Y}_{r+1}^{1}, y_{r+1}^{r+1}\right)=1$, there exists an isomorphism $e_{X} \cup \tilde{X}_{r+1}^{1} \rightarrow e_{Y} \cup \tilde{Y}_{r+1}^{1}$ which maps the vertices $x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}$ to the vertices $y_{r+1}^{1}, \ldots, y_{r+1}^{r+1}$ respectively, and the pair $\left(e_{Y} \cup \tilde{Y}_{r+1}^{1}, \tilde{Y}_{r+1}^{1}\right)$ is cyclically 1-maximal in $Y_{r+1}$, where $e_{Y}$ is an edge which connects $y_{r+1}^{r+1}$ and $\tilde{Y}_{r+1}^{1}$ in $Y_{r+1}$. If there are no cyclic 1-extensions of $e_{X} \cup \tilde{X}_{r+1}^{1}$ in $X_{r+1}$, then the hypergraphs $e_{X} \cup \tilde{X}_{r+1}^{1}$ and $e_{Y} \cup \tilde{Y}_{r+1}^{1}$ are $(k, r+1,2)$-regular equivalent in $\left(X_{r+1}, Y_{r+1}\right)$. Thus, in the $(r+2)$-th round Duplicator exploits the strategy SF. If there is an edge $\tilde{e}_{X}$ which forms a cyclic 1-extension of $e_{X} \cup \tilde{X}_{r+1}^{1}$ in $X_{r+1}$ then the property of $(k, r)$-equivalence of the hypergraphs $\tilde{X}_{r+1}^{1}, \tilde{Y}_{r+1}^{1}$ implies that either $\tilde{e}_{X}$ contains at most one vertex from the set $\left\{x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}\right\}$ or there exists a vertex $x_{r+1}^{i}$, where $i \in\{1, \ldots, r\}$, such that $x_{r+1}^{i}, x_{r+1}^{r+1} \in e_{X} \cap \tilde{e}_{X}$. In the first case set $\tilde{X}_{r+1}^{1}:=e_{X} \cup \tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}:=e_{Y} \cup \tilde{Y}_{r+1}^{1}$. Consider the second case. If in the ( $r+2$ )-th round Spoiler chooses a vertex from the edge $\tilde{e}_{X}$, then set $\tilde{X}_{r+1}^{1}:=\tilde{e}_{X} \cup \tilde{X}_{r+1}^{1}$. Otherwise, set $\tilde{X}_{r+1}^{1}:=e_{X} \cup \tilde{X}_{r+1}^{1}$. Set $\tilde{Y}_{r+1}^{1}:=e_{Y} \cup \tilde{Y}_{r+1}^{1}$. Then Duplicator wins using the strategy SF for the hypergraphs $\tilde{X}_{r+1}^{1}$ and $\tilde{Y}_{r+1}^{1}$ in the rounds $k-s+3, \ldots, k$, since there do not exist vertices $u_{1}, \ldots, u_{l} \notin V\left(\tilde{X}_{r+1}^{1}\right)$, where $l \in\{1, \ldots, s-2\}$, and vertices $v_{1}, \ldots, v_{s-l} \in V\left(\tilde{X}_{r+1}^{1}\right)$ such that $\left\{u_{1}, \ldots, u_{l}, v_{1}, \ldots, v_{s-l}\right\} \in E\left(X_{r+1}\right)$ and $\left|\left\{v_{1}, \ldots, v_{s-l}\right\} \cap\left\{x_{r+1}^{1}, \ldots, x_{r+1}^{r+1}\right\}\right| \geq 2$.

The formula $D_{i}^{=}\left(x_{1}, x_{2}\right)$ was defined in the proof of Theorem 6 and expresses the property that the distance between the vertices $x_{1}$ and $x_{2}$ equals $i$. The quantifier depth of the formula $D_{i}^{=}\left(x_{1}, x_{2}\right)$ equals $\left\lceil\log _{2} i\right\rceil+s-2$.

Let $H_{1}$ be a hypergraph with $V\left(H_{1}\right)=\left\{x_{1}^{1}, \ldots, x_{2(s-1)}^{1}\right\}$ and $E\left(H_{1}\right)=\left\{\left\{x_{1}^{1}, \ldots, x_{s}^{1}\right\}\right.$, $\left.\left\{x_{s}^{1}, \ldots, x_{2 s-2}^{1}, x_{1}^{1}\right\}\right\}$. Let $H_{2}$ be a hypergraph with $V\left(H_{2}\right)=\left\{x_{1}^{2}, \ldots, x_{3(s-1)}^{2}\right\}$ and $E\left(H_{2}\right)=$ $\left\{\left\{x_{1}^{2}, \ldots, x_{s}^{2}\right\},\left\{x_{s}^{2}, \ldots, x_{2 s-1}^{2}\right\},\left\{x_{2 s-1}^{2}, \ldots, x_{3 s-3}^{2}, x_{1}^{2}\right\}\right\}$. Let $H$ be a hypergraph obtained from the disjoint union of the hypergraphs $H_{1}$ and $H_{2}$ by adding a vertex $x$ and two nonintersecting paths with lengths $a_{1}+2^{k-s}-4$ and $a_{2}+2^{k-s}-4$ which connect the vertex $x$ and the vertices $x_{1}^{1}$ and $x_{1}^{2}$ respectively.

Let $\tilde{\Omega}_{n}$ be the set of all hypergraphs $\mathcal{G}$ from $\Omega_{n}$ such that for any hypergraph $G$ with $\rho^{\max }(G)>\frac{1}{\alpha}$ and $v(G) \leq 2^{k} s$, there is no copy of $G$ in $\mathcal{G}$.

Let us prove that if the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $L$ then it contains a copy of the hypergraph $H$. Suppose that the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $L$. Then there exist vertices $x_{1}, x_{2}^{1}, x_{2}^{2} \in V(\mathcal{G})$ such that $d_{\mathcal{G}}\left(x_{1}, x_{2}^{1}\right) \leq a_{1}+2^{k-s-1}+\ldots+2^{2}=a_{1}+2^{k-s}-2^{2}, d_{\mathcal{G}}\left(x_{1}, x_{2}^{2}\right) \leq$ $a_{2}+2^{k-s-1}+\ldots+2^{2}=a_{2}+2^{k-s}-2^{2}$ and the predicates $C_{1}\left(x_{1}, x_{2}^{1}\right)$ and $C_{2}\left(x_{1}, x_{2}^{2}\right)$ are true. As $\mathcal{G} \in \tilde{\Omega}_{n}$, the truth of the predicate $C_{1}\left(x_{1}, x_{2}^{1}\right)$ implies that there exists a subhypergraph $\tilde{H}_{1}$ in $\mathcal{G}$ which is isomorphic to the hypergraph $H_{1}$, contains the vertex $x_{2}^{1}$ and does not contain the vertex $x_{1}$. The truth of the predicate $C_{2}\left(x_{1}, x_{2}^{2}\right)$ implies that there exists a subhypergraph $\tilde{H}_{2}$ in $\mathcal{G}$ which is isomorphic to the hypergraph $H_{2}$, contains the vertex $x_{2}^{2}$
and does not contain the vertex $x_{1}$. Moreover, we have $V\left(\tilde{H}_{1}\right) \cap V\left(\tilde{H}_{2}\right)=\varnothing$, since otherwise the density of the hypergraph $\tilde{H}_{1} \cup \tilde{H}_{2}$ is greater than $1 / \alpha$, which contradicts $\mathcal{G} \in \tilde{\Omega}_{n}$. Let $P_{1}$ be the shortest path which connects the vertex $x_{1}$ with some vertex from $\tilde{H}_{1}$ and $P_{2}$ be the shortest path which connects the vertex $x_{1}$ with some vertex from $\tilde{H}_{2}$. Let $X_{0}=\tilde{H}_{1} \cup \tilde{H}_{2}$, $X_{1}=\tilde{H}_{1} \cup \tilde{H}_{2} \cup P_{1}$ and $X_{2}=\tilde{H}_{1} \cup \tilde{H}_{2} \cup P_{1} \cup P_{2}$. Then $e\left(X_{1}, X_{0}\right) \leq a_{1}+2^{k-s}-4$ and $v\left(X_{1}, X_{0}\right) \leq e\left(X_{1}, X_{0}\right)(s-1)$. If $P_{2} \subset \tilde{H}_{1} \cup \tilde{H}_{2} \cup P_{1}$, then $v\left(X_{1}, X_{0}\right) \leq e\left(X_{1}, X_{0}\right)(s-1)-1$. If $P_{2} \not \subset \tilde{H}_{1} \cup \tilde{H}_{2} \cup P_{1}$, then $e\left(X_{2}, X_{1}\right) \leq a_{2}+2^{k-s}-4$ and $v\left(X_{2}, X_{1}\right) \leq e\left(X_{2}, X_{1}\right)(s-1)-1$. Thus $\left|E\left(X_{2}\right)\right|=e\left(X_{1}, X_{0}\right)+e\left(X_{2}, X_{1}\right)+5 \leq 2^{k-s+1}+a$ and $\left|V\left(X_{2}\right)\right|=v\left(X_{1}, X_{0}\right)+v\left(X_{2}, X_{1}\right)+$ $5(s-1) \leq\left|E\left(X_{2}\right)\right|(s-1)-1$. Therefore,

Therefore, by the definition of $\tilde{\Omega}_{n}$ these equalities hold and the hypergraph $X_{2}$ is isomorphic to $H$.

Conversely, if the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ contains a copy of the hypergraph $H$ then $\mathcal{G}$ satisfies $L$. Since $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \in \tilde{\Omega}_{n}\right]=1$, it follows that $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models\right.$ $L]=\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models L_{H}\right] \in(0,1)$. Therefore, $G^{s}\left(n, n^{-\alpha}\right)$ does not obey the zeroone $k$-law.

Let $\tilde{\Omega}_{n}$ be the set of all hypergraphs $\mathcal{G}$ from $\Omega_{n}$ such that for any hypergraph $G$ with $\rho^{\max }(G)>\frac{1}{\alpha}$ and $v(G) \leq 2^{k} s$, there is no copy of $G$ in $\mathcal{G}$.

Let us show that if the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $L$ then it contains a copy of the hypergraph $H$. Suppose that the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ satisfies $L$. Then there exists a vertex $x_{1}$ and there exist subhypergraphs $\tilde{H}_{1}$ and $\tilde{H}_{2}$ in $\mathcal{G}$ which are isomorphic to the hypergraphs $H_{1}$ and $H_{2}$ respectively and $x_{1} \in V\left(\tilde{H}_{1}\right) \cap V\left(\tilde{H}_{2}\right)$. If $V\left(\tilde{H}_{1}\right) \cap V\left(\tilde{H}_{2}\right) \neq\left\{x_{1}\right\}$, then the density of the hypergraph $\tilde{H}_{1} \cup \tilde{H}_{2}$ is greater than $1 / \alpha$, which contradicts $\mathcal{G} \in \tilde{\Omega}_{n}$. Therefore, the hypergraph $\tilde{H}_{1} \cup \tilde{H}_{2}$ is isomorphic to $H$. Obviously, if the hypergraph $\mathcal{G} \in \tilde{\Omega}_{n}$ contains a
copy of the hypergraph $H$, then it satisfies $L$. Since $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \in \tilde{\Omega}_{n}\right]=1$, we obtain that $\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models L\right]=\lim _{n \rightarrow \infty} \operatorname{Pr}\left[G^{s}\left(n, n^{-\alpha}\right) \models L_{H}\right] \in(0,1)$.
