# A Drude-Lorentz dielectric in the presence of a magnetic current density

The dispersive propagation and absorption in the domain of a Drude-Lorentz dielectric modified by a magnetic current are classically investigated, taking as the starting point the Drude electric permittivity, in connection with the chiral magnetic effect. Using standard electromagnetic methods, the dispersion relations and refractive indices are evaluated and discussed, as well as the group and the energy velocities. We consider three configurations for the magnetic conductivity tensor: isotropic, antisymmetric, and symmetric. In all these cases, we carry out the group velocity and the energy velocity, for investigating the properties of signal propagation. We observe that the isotropic magnetic conductivity enhances the signal propagation at low and intermediary frequencies, while the symmetric and antisymmetric conductivity severely constrains the wave propagation in these frequency windows.

### I. INTRODUCTION

The Maxwell's electrodynamics a general framework to describe the electromagnetic interaction in both classical and quantum scales. The classical electrodynamics explains the interaction of charges in motion via solutions of Maxwell's equations [1-3]. The quantum electrodynamics (QED) describes with excellent precision the interaction of the photons with leptons at the MeV-scale [4]. The electrodynamics applied to the material physics is one of the basic tools of Condensed Matter Physics (CMP). In theoretical CMP, many models are developed to study the electronic properties of solids. One of the examples is the Drude model, initially used to explain the properties of the electrons transported through the metals [5, 6], providing a complex and dispersive conductivity and refractive index associated with the absorption of electromagnetic waves in metals [7]. The Drude model is also applied to describe the optical propagation in dielectric media [7–9], in which the electromagnetic waves interact with vibrating atoms, considered as classical dipoles. This kind of approach allows us to obtain optical properties of solids, including dispersion, absorption and optical activity.

In some specific continuous media, there appears a magnetic current density linear in the magnetic field, originated from an asymmetry between the density of the left- and right-handed chiral fermions [10-12]. This

is known as a macroscopical manifestation of the quantum Chiral Magnetic Effect (CME), being investigated in different research areas in physics, as Cosmology, quarkgluon plasm, electroweak interactions and others [13–17]. In CMP, the CME is associated with the Weyl semimetals (WSM) in which massless fermions acquire velocity along the magnetic field whose direction is driven by the chirality of these fermions [18]. In WSM, the magnetic current density may present a general form,  $\mathbf{J} = \alpha (\mathbf{E} \cdot \mathbf{B}) \mathbf{B}$  [19– 21], with  $\alpha$  being a constant, in such a way the magnetic current,

$$\mathbf{J} = \sigma^B \cdot \mathbf{B} \,, \tag{1}$$

is written in terms of an anisotropic magnetic conductivity tensor denoted by  $\sigma_{ij}^B$ , which depends on the material properties. Classical optical properties of a dielectric medium endowed magnetic current were already investigated, supposing the medium is described by usual constitutive relations,  $\mathbf{D} = \epsilon \mathbf{E}$  and  $\mathbf{B} = \mu \mathbf{H}$  [22]. The refractive indices, propagating modes, and optical effects were examined for three configurations of the magnetic conductivity tensor,

$$\sigma_{ij}^B = \Sigma \,\delta_{ij} \,, \quad \sigma_{ij}^B = \epsilon_{ijk} \,b_k \,, \quad \sigma_{ij}^B = \frac{1}{2} \left( a_i \,c_j + a_j \,c_i \right) \,,$$

associated with isotropic, antisymmetric [24] and symmetric currents, given as

$$\mathbf{J} = \Sigma \mathbf{B} , \quad \mathbf{J} = \mathbf{b} \times \mathbf{B} , \quad \mathbf{J} = \frac{1}{2} \left[ (\mathbf{a} \cdot \mathbf{B}) \mathbf{c} + (\mathbf{c} \cdot \mathbf{B}) \mathbf{a} \right] ,$$
(3)

where **a**, **b**, **c** are constant vectors in space.

The electrodynamics of a continuous medium is described by the Lagrangian density,

$$\mathcal{L} = -\frac{1}{4} G_{\mu\nu} F^{\mu\nu} - J_{\mu} A^{\mu} , \qquad (4)$$

where  $F^{\mu\nu} = \partial_{\mu}A_{\nu} - \partial_{\nu}A_{\mu}$  and  $G^{\mu\nu} = \chi^{\mu\nu\rho\lambda}F_{\rho\lambda}/2$  are the field strength electromagnetic tensors in vacuum and matter, and  $J^{\mu} = (\rho, \mathbf{J})$  is the source four-current<sup>1</sup> The constitive tensor  $\chi^{\mu\nu\rho\lambda}$  satisfies the symmetry properties  $\chi^{\mu\nu\rho\lambda} = -\chi^{\nu\mu\rho\lambda}, \ \chi^{\mu\nu\rho\lambda} = -\chi^{\mu\nu\lambda\rho}$  and  $\chi^{\mu\nu\rho\lambda} = \chi^{\rho\lambda\mu\nu}$ . The action principle applied to the Lagrangian (4) yields the field equation

$$\partial_{\mu}G^{\mu\nu} = J^{\nu} , \qquad (5)$$

while the EM strength field tensor satisfies the Bianchi identity,  $\partial_{\mu} \tilde{F}^{\mu\nu} = 0$ , where  $\tilde{F}^{\mu\nu} = \epsilon^{\mu\nu\rho\lambda} F_{\rho\lambda}/2$  is the dual tensor. Explicitly, the motion equations can be written in the standard form

$$\nabla \cdot \mathbf{D} = 0$$
 ,  $\nabla \times \mathbf{E} + \frac{\partial \mathbf{B}}{\partial t} = \mathbf{0}$ , (6a)

$$\nabla \cdot \mathbf{B} = 0$$
 ,  $\nabla \times \mathbf{H} - \frac{\partial \mathbf{D}}{\partial t} = \mathbf{J}$ , (6b)

where **D** and **H** are the fields in the matter represented by the components  $G^{0i} = -D^i$  and  $H^i = \epsilon^{ijk}G^{jk}/2$ . In this paper, we use the constitutive relations,

$$\mathbf{D} = \epsilon(\omega) \mathbf{E} , \quad \mathbf{H} = \frac{1}{\mu} \mathbf{B} , \qquad (7)$$

applied to a Drude-Lorentz dielectric, whose complex permittivity

$$\epsilon(\omega) = \epsilon_0 \left[ 1 + \frac{\omega_p^2}{\omega_0^2 - \omega^2 - i \,\gamma \,\omega} \right] \,, \tag{8}$$

takes into account the electron's damped oscillation. Here,  $\omega_0$  is the free electron frequency,  $\gamma$  is the damping factor and  $\omega_p = \sqrt{nq^2/\epsilon_0 m}$  is the plasma frequency. From the Drude-Lorentz model, q = -e is the electron charge, m is the electron mass, and n is the number density. Equivalently, one can write Eq. (8) as

$$\epsilon(\omega) = \epsilon'(\omega) + i\epsilon''(\omega) , \qquad (9)$$

where

$$\epsilon'(\omega) = \epsilon_0 \left[ 1 + \frac{\omega_p^2 (\omega_0^2 - \omega^2)}{(\omega_0^2 - \omega^2)^2 + \gamma^2 \omega^2} \right] ,$$
 (10a)

$$\epsilon''(\omega) = \epsilon_0 \left[ \frac{\gamma \, \omega_p^2 \, \omega}{(\omega_0^2 - \omega^2)^2 + \gamma^2 \omega^2} \right] \,. \tag{10b}$$

This Drude dielectric, described by the usual constitutive relations (7), will be examined in the presence of the non conventional current constitutive relation,

$$J_i = \sigma^B_{ij} B_j . \tag{11}$$

Substituting the plane wave solutions,  $\mathbf{E}(\mathbf{r}, t) = \mathbf{E} e^{i(\mathbf{k}\cdot\mathbf{r}-\omega t)}$  and  $\mathbf{B}(\mathbf{r}, t) = \mathbf{B} e^{i(\mathbf{k}\cdot\mathbf{r}-\omega t)}$  in the Maxwell relations, and using the current density (11), we obtain the following equation for the electric field  $\mathbf{E}$ :

$$\left[\mathbf{k}^{2} \,\delta_{ij} - k_{i} \,k_{j} - \omega^{2} \,\mu \,\overline{\epsilon}_{ij}(\omega)\right] E^{j} = 0 \,, \qquad (12)$$

with the effective permittivity,

$$\bar{\epsilon}_{ij}(\omega) = \epsilon(\omega) \,\delta_{ij} - \frac{\imath}{\omega^2} \,\sigma^B_{ia} \epsilon_{abj} \,k_b \,, \tag{13}$$

where  $\sigma_{ij}^B$  is the magnetic conductivity tensor, and  $\epsilon(\omega)$  is the dielectric permittivity. Equation (12) can be written in terms of the refractive index components  $n^i = k^i/\omega$ , in which the refractive index of the medium is defined by  $n = +\sqrt{n_i n_i}$ . Thereby, (12) can be cast into the form

$$M_{ij}E^j = 0 (14)$$

in which the tensor  $M_{ij}$  reads

$$M_{ij} = n^2 \,\delta_{ij} - n_i \,n_j - \mu \,\overline{\epsilon}_{ij}(\omega) \,. \tag{15}$$

The nontrivial solutions for  $E^{j}$  in Eq. (14) are obtained by requiring det $[M_{ij}] = 0$ , which provides the dispersion relations of the model and all the useful information to obtain the group and energy velocities. In dispersive media the electromagnetic fields may be complex,  $\mathbf{E} = \mathbf{E}' + i \mathbf{E}'', \mathbf{B} = \mathbf{B}' + i \mathbf{B}''$ . Additionally, in the presence of absorption the wave vector is complex,

$$\mathbf{k} = \mathbf{k}' + i\,\mathbf{k}''\,,\tag{16}$$

with the energy balance being ruled by the Poynting's theorem [1], whose Poynting vector and electromagnetic energy density (stored in the field) are

$$\mathbf{S} = (\mathbf{E} \times \mathbf{H}^*) = \frac{1}{2\mu'} (\mathbf{E} \times \mathbf{B}^*) , \qquad (17a)$$

$$u_{EM} = \frac{1}{2} \frac{\partial [\omega \epsilon']}{\partial \omega} \left( \mathbf{E} \cdot \mathbf{E}^* \right) + \frac{1}{2\mu'} \left( \mathbf{B} \cdot \mathbf{B}^* \right) . \quad (17b)$$

In the absence of sources ( $\rho = 0$ ), the Gauss's law is compatible with the attainment of transversal modes,

$$(\mathbf{k}' \cdot \mathbf{E}') = (\mathbf{k}'' \cdot \mathbf{E}'') = 0 , \qquad (18a)$$

$$\mathbf{k}' \cdot \mathbf{E}'') = (\mathbf{k}'' \cdot \mathbf{E}') = 0, \qquad (18b)$$

for which the time-averaged quantities read

$$\langle \mathbf{S} \rangle = \frac{\mathbf{E}^2}{2\omega\mu'} \, \mathbf{k}' \,, \tag{19a}$$

$$\langle u_{EM} \rangle = \frac{1}{4} \left[ \epsilon' + \omega \, \frac{\partial \epsilon'}{\partial \omega} + \frac{|\mathbf{k}|^2}{\mu \omega^2} \right] \mathbf{E}^2 \,.$$
 (19b)

In lossy media, the ratio of these quantities defines the energy velocity,

$$\mathbf{v}_E = \frac{\langle \mathbf{S} \rangle}{\langle u_{EM} \rangle} , \qquad (20)$$

suitable to describe the energy transport in the presence of absorption.

In a non-absorbing dieletric ( $\epsilon'' = 0$ ), the group velocity

$$\mathbf{v}_g = \frac{d\omega}{dk} \,\hat{\mathbf{k}} \,, \tag{21}$$

is a real quantity suitable for representing the signal propagation. However, in an absorbing medium, the group velocity becomes complex, as  $\mathbf{v}_g = \text{Re}[d\omega/dk] + i \text{Im}[d\omega/dk]$ , no longer describing energy transport, being replaced by the energy velocity [27–32] in this respect.

For the Drude dielectric permittivity, Eq. (19b) is rewritten as

$$\langle u_{EM} \rangle = \frac{\epsilon_0 |\mathbf{E}|^2}{4} \left[ 1 + \frac{\omega_p^2 (\omega_0^2 - \omega^2)}{\Gamma_+(\omega)} + \frac{2\omega^2 \omega_p^2 \Gamma_-}{\Gamma_+^2(\omega)} + \frac{|\mathbf{k}|^2}{\mu \epsilon_0 \omega^2} \right]$$
(22)

with  $\Gamma_{\pm}(\omega) = (\omega_0^2 - \omega^2)^2 \pm \gamma^2 \omega^2$ , in such a way the energy velocity reads

$$\mathbf{v}_E = \frac{\mathbf{k}'}{\mu\epsilon_0\omega} \left[ 1 + \frac{\omega_p^2(\omega_0^2 - \omega^2)}{\Gamma_+(\omega)} + \frac{2\omega^2\omega_p^2\Gamma_-}{\Gamma_+^2(\omega)} + \frac{|\mathbf{k}|^2}{\mu\epsilon_0\omega^2} \right]^{-1},$$
(23)

By definition,  $\mathbf{v}_E$  points along the  $\mathbf{\hat{k}'}$ -direction, also depending on the dispersion relation of  $k(\omega)$ . In general non absorbing dielectrics, energy velocity and group velocity are the same one. But such an equality that is lost in lossy media, where it holds  $\mathbf{v}_E \neq \mathbf{v}_g$ . Such results have been recently verified for dispersive, absorbing and lossless hyperbolic metamaterial (HMM) [33], as far as general bi-anisotropic media [34]. In accordance with the definition (20), the energy velocity depends on the way the energy density and the dissipated energy density in a lossy medium are written [35, 36], which constitute an active line of research actually [37, 38].

An alternative procedure to investigate group and energy velocities in dissipative dynamical systems [39] was used recently to investigate the group and energy propagation in a dielectric medium endowed with magnetic conductivity [40]. Such a study was performed considering  $\epsilon' = cte$  and  $\epsilon'' = 0$  or  $\epsilon' = cte$  and  $\epsilon'' = \sigma \omega^{-1}$ , comparing group velocity and energy velocity for the cases of isotropic, symmetric and antisymmetric magnetic conductivity shown in Eq. (2).

In this paper, we investigate the properties of propagation and absorption in a realistic Drude dielectric (DD) endowed with magnetic conductivity following the procedures of Ref. [40]. Initially, we obtain the solutions of refractive indices, the propagating modes for the scenarios of an isotropic conductivity magnetic, including evaluation of the group and the energy velocities. Posteriorly, it is done for the case of anisotropic conductivity magnetic tensor, antisymmetric and a symmetric tensor. The features of the refractive indices are discussed having as comparison basis the DD ones. The paper is organized as follows. Section II is dedicated to the case the isotropic tensor  $\sigma_{ij}^B$ . In Section III we obtain the results for an antisymmetric magnetic conductivity tensor parametrized by one constant vector. Section IV is devoted to examining the symmetric conductivity tensor configuration parametrized by two constant vectors. All these sections are divided in two subsections in which the optical properties and the group/energy velocities aspects are addressed. For end, in the section V, we present the conclusions and the final remarks.

### II. THE CASE OF THE ISOTROPIC MAGNETIC CONDUCTIVITY TENSOR

The magnetic current density with a diagonal current, the isotropic conductivity magnetic tensor is

$$\sigma_{ij}^B = \Sigma \,\delta_{ij} \,\,, \tag{24}$$

where  $\varSigma$  is a real and positive constant, in which the bar permittivity tensor is

$$\bar{\epsilon}_{ij}(\omega) = \epsilon(\omega)\,\delta_{ij} + \frac{i\,\Sigma}{\omega}\,\epsilon_{ijk}\,n_k\;. \tag{25}$$

The null determinant of the  $M_{ij}$  matrix implies into the *n*-polynomial equation

$$\left[n^{2} - \mu \epsilon(\omega)\right]^{2} - n^{2} \frac{\mu^{2} \Sigma^{2}}{\omega^{2}} = 0.$$
 (26)

The solutions of the equation (26) are given by

$$n_{\pm} = \sqrt{\mu(\epsilon'(\omega) + i\epsilon''(\omega)) + \left(\frac{\mu\Sigma}{2\omega}\right)^2} \pm \frac{\mu\Sigma}{2\omega} .$$
 (27)

Substituting the dielectric permittivity (10), both solutions can be split into their real and imaginary pieces,

$$n_{\pm} = \Re[n_{\pm}] + i \Im[n_{\pm}],$$
 (28)

where

$$\Re[n_{\pm}] = \sqrt{\frac{|h(\omega)|}{2}} I_{\pm} \pm \frac{\mu\Sigma}{2\omega} , \qquad (29a)$$

$$\Im[n_{\pm}] = \sqrt{\frac{|h(\omega)|}{2}} I_{-} , \qquad (29b)$$

with

$$I_{\pm} \equiv \sqrt{\sqrt{1 + \mu^2 \left[\frac{\epsilon''(\omega)}{h(\omega)}\right]^2} \pm \operatorname{sgn}[h(\omega)]}, \qquad (30a)$$

$$h(\omega) = \mu \epsilon'(\omega) + \left(\frac{\mu \Sigma}{2\omega}\right)^2 , \qquad (30b)$$

where sgn represents the signal function of  $h(\omega)$ . Notice that  $\epsilon'(\omega)$  from (10a) can assume negative values for a given range of  $\omega$ -frequency. Consequently, the  $h(\omega)$ function can also be negative.

The general behavior of  $n_{\pm}$  real and imaginary pieces, written in Eqs. (29a) and (29b), is illustrated in Figs. 1 and 2 in terms of the dimensionless variable  $\omega/\omega_0$ . We note that both  $\Re[n_+]$  indicate propagation regime for the range  $\omega < \omega_0$ . Near the origin the real piece of  $n_+$  tends to infinity, an analog behavior of magnetized plasmas [41]. At the resonance frequency,  $\omega = \omega_0$ , there occurs an absorption peak which coincides with the beginning of the window for  $\Im[n_{\pm}] \neq 0$ . Furthermore, immediately after  $\omega = \omega_0$  the values of  $\Re[n_{\pm}]$  rapidly decrease (anomalous dispersion), being followed by a short increasing region for the index  $n_+$ , which in the sequel exhibits another anomalous region (extending to the asymptotic limit); see Fig. 1. As for the index  $n_{-}$ , however, the anomalous dispersion region is followed by a normal dispersion one; see Fig. 2. For both indices, the absorption peak occurs in the region  $\omega_1^i < \omega < \omega_2^i$ , with  $\omega_1^i \approx \omega_0$ , which defines the absorption window. Note that near the origin, the real piece of  $n_{-}$  is null, which is distinct from the conventional DD behavior.

It is worth mentioning that negative refraction occurs for  $n_{-}$  in the zone  $\omega_1^i < \omega < \omega''$ , which also contains the absorption frequency window. This negative refraction is a consequence of the isotropic magnetic conductivity. For  $n_{\pm}$ , the frequency  $\omega_2^i$  defines the absorption zone limit, which is reduced in the presence of the magnetic conductivity. It is also interesting to note that, besides the absorption width reduction, the indices  $n_{\pm}$  also develop a non-null real piece, enabling energy transport in this region, not allowed in the correspondent usual DD one. For  $\omega > \omega_2^i$ , the absorption is null and attenuation-free propagation occurs. For very high-frequencies ( $\omega \gg \omega_0$ ), one obtains  $\Re[n_{\pm}] \to \sqrt{\mu\epsilon_0}$ .

For very low-frequencies ( $\omega \ll \omega_0$ ), the refractive indices behave as

$$n_{\pm} \simeq \sqrt{\mu\epsilon_0 \left(1 + \frac{\omega_p^2}{\omega_0^2}\right) + \left(\frac{\mu\Sigma}{2\omega}\right)^2 \pm \frac{\mu\Sigma}{2\omega}},$$
 (31)

which near the origin yields  $n_{-} = 0$  and  $n_{+} \simeq \mu \Sigma / \omega$ , thus explaining the  $n_{+}$  divergence at  $\omega \to 0$  in Fig. 1. It is worth to point out that such low-frequency behavior,  $\Re[n_{+}] \to \infty$ ,  $\Re[n_{-}] \to 0$ , is already present in the case of a simple dielectric with constant magnetic conductivity  $\epsilon' = cte$ ,  $\epsilon'' = \sigma / \omega$ ,  $\Sigma = cte$ . See Ref. [40]. As a consistency check, one notes that when  $\Sigma \to 0$ , the refractive indices of Eq. (31) yield a finite and non-null value in the origin, recovering the standard scenario. See the black continuous lines in Figs. 1 and 2.

The peak of the imaginary part is located at  $\omega \approx \omega_0$ . Using Eq. (29b) and expressions (10a), (10b), the peak amplitude is

$$\Im(n_{\pm})\Big|_{\omega=\omega_0} = \sqrt{\frac{\mu\epsilon_0}{2} + \left(\frac{\mu\Sigma}{2\sqrt{2}\omega_0}\right)^2} \mathcal{I} , \qquad (32)$$

with

1

$$\mathcal{I} = \sqrt{\sqrt{1 + \left[\frac{4\omega_0\omega_p^2\epsilon_0}{\gamma \left(4\omega_0^2\epsilon_0 + \mu\Sigma^2\right)}\right]^2} - 1} , \qquad (33)$$

revealing that the magnetic conductivity also modifies the absorption peak magnitude. In the next section, we will discuss the consequence of  $\Sigma$  on the imaginary part of  $n_{\pm}$ .

### A. Propagation modes and optical effects

Let us consider propagation along the Z-axis,  $\mathbf{n} = (0, 0, n)$ , such that the tensor  $M_{ij}$  becomes

$$[M_{ij}] = \begin{bmatrix} n^2 - \mu\epsilon(\omega) & +i\mu\frac{\Sigma}{\omega}n & 0\\ -i\mu\frac{\Sigma}{\omega}n & n^2 - \mu\epsilon(\omega) & 0\\ 0 & 0 & -\mu\epsilon(\omega) \end{bmatrix} .$$
(34)

In order to find the propagating modes, we solve the equation  $M_{ij}E^j = 0$ , including in the matrix (34) the solution of Eq. (26), that is,

$$n^2 - \mu \epsilon(\omega) = \pm n \, \frac{\mu \Sigma}{\omega} \,, \tag{35}$$

providing the following electric fields:

$$\mathbf{E}_{\pm} = \frac{1}{\sqrt{2}} \begin{pmatrix} 1\\ \pm i\\ 0 \end{pmatrix} , \qquad (36)$$

which represent left-handed (LCP) and right-handed (RCP) circularly polarized vectors, respectively. The two different real refractive indices associated with the modes (36) imply circular birefringence, ascribed to the isotropic magnetic conductivity,  $\Sigma$ , and expressed in terms of the rotatory power (RP),

$$\delta = -\frac{\omega}{2} \left[ \Re(n_+) - \Re(n_-) \right] , \qquad (37)$$

specialized for the indices (28) as

$$\delta = -\frac{\mu\Sigma}{2} \,. \tag{38}$$

It is a nondispersive RP that depends linearly on the magnetic conductivity, being equal to the one that appears in nondispersive dielectrics ( $\epsilon' = cte$ ) endowed with isotropic magnetic conductivity [22]. It is interesting to mention that the absorption peak amplitude decreases with an increasing magnitude of the magnetic conductivity  $\Sigma$ . This is in agreement with Eq. (32), which provides  $\Im(n_{\pm}) \to 0$  in the limit of very large conductivity ( $\Sigma \to \infty$ ). In this limit, therefore, this Drude-Lorentz-like dielectric exhibits a nearly null absorption. Such an effect is represented by the different peak amplitudes in Fig. 3.

In lossy systems, the dichroism takes place when one propagating mode is more strongly absorbed than the other, which is directly associated to the imaginary piece of the refractive indices. Dichroism represents a tool to distinguish between Dirac and Weyl semimetals [42], being used also for enantiomeric discrimination [43, 44] and for developing graphene-based devices at terahertz frequencies [45]. For circularly polarized modes, the difference of absorption between left and right-handed circularly polarized modes [46] is given by the circular dichroism coefficient,

$$\delta_{\rm d} = -\frac{\omega}{2} [\operatorname{Im}(n_+) - \operatorname{Im}(n_-)]. \qquad (39)$$

Concerning the modes (36) associated with the refractive indices (28), the dichroism coefficient is null,

$$\delta_{\rm d} = 0, \tag{40}$$

since these indices have equal imaginary parts, see Eq. (29b). This is the same result obtained for the case of a simple dielectric with constant magnetic conductivity  $\epsilon' = cte$ ,  $\Sigma = cte$  [40]. In this sense, the Drude permittivity, although being complex and involved, does not modify either the RP or the dichroism coefficient in relation to the optical panorama of a simpler dielectric.

### B. The phase, group, and the energy velocities

Implementing  $n = \sqrt{\mathbf{k}^2}/\omega$  in Eq. (35), we obtain

$$k^2 \mp \mu \Sigma k - \mu \omega^2 \epsilon(\omega) = 0 , \qquad (41)$$

whose the solutions read

$$k_{\pm} = \omega \sqrt{\mu \epsilon'(\omega) + i\mu \epsilon''(\omega) + \frac{\mu^2 \Sigma^2}{4\omega^2}} \pm \frac{\mu \Sigma}{2} , \qquad (42)$$

with  $\epsilon'$  and  $\epsilon''$  of Eqs. (10a) and (10b), respectively. These solutions can also be written as  $k_{\pm} = k'_{\pm} + i k''_{\pm}$ , where

$$k'_{\pm} = \omega \sqrt{\frac{|h(\omega)|}{2}} I_{+} \pm \frac{\mu \Sigma}{2} , \qquad (43a)$$

$$k_{\pm}^{\prime\prime} = \omega \sqrt{\frac{|h(\omega)|}{2}} I_{-} , \qquad (43b)$$

and the functions  $I_{\pm}$  and  $h(\omega)$  are given in Eqs. (30a) and (30b).

For the propagation analysis, we consider the real part Eq. (43a), which represents the two distinct modes,  $k_+$ 

and  $k_{-}$ . The phase velocities are

$$v_{\rm ph}^{(\pm)} = \frac{\omega}{k_{\pm}'} = \frac{1}{\Re[n_{\pm}]},$$
 (44)

yielding the phase velocity difference,  $\varDelta v_{\rm ph} = v_{\rm ph}^{(-)} - v_{\rm ph}^{(+)},$  namely,

$$\Delta v_{\rm ph} = \frac{4\omega\,\mu\,\Sigma}{2\omega^2\,|h(\omega)|\,I_+^2 - \mu^2\,\Sigma^2}\,,\tag{45}$$

indicating that the magnetic conductivity  $\Sigma$  engenders distinct modes propagating with different phase velocities and birefringence. The group velocity is given in this case by

$$v_g^{(\pm)} = \frac{1}{\mu} \frac{k_{\pm}/\omega \mp \mu \Sigma/(2\omega)}{\epsilon(\omega) + (\partial_{\omega}\epsilon)\omega/2} , \qquad (46)$$

with  $\partial_{\omega} \epsilon = \partial \epsilon / \partial \omega$ . Considering the expression (42), the group velocity takes on the form,

$$v_g^{\pm} = \frac{1}{\mu} \frac{\sqrt{\mu \epsilon'(\omega) + i\mu \epsilon''(\omega) + \frac{\mu^2 \Sigma^2}{4\omega^2}}}{\epsilon'(\omega) + i\epsilon''(\omega) + \frac{\omega}{2}(\partial_\omega \epsilon)}, \qquad (47)$$

which can be rewritten by separating its real and imaginary pieces as follows:

$$\Re[v_g^{(\pm)}] = \frac{(\mu\epsilon_0)^{-1}}{C^2 + D^2} \sqrt{\frac{|h(\omega)|}{2}} \left(I_+ C + I_- D\right) , (48a)$$

$$\Im[v_g^{(\pm)}] = \frac{(\mu\epsilon_0)^{-1}}{C^2 + D^2} \sqrt{\frac{|h(\omega)|}{2}} \left(I_- C - I_+ D\right) , (48b)$$

where

$$C = \epsilon'(\omega) + \frac{\omega}{2} \frac{\partial \epsilon'}{\partial \omega}, \qquad (49a)$$

$$D = \epsilon''(\omega) + \frac{\omega}{2} \frac{\partial \epsilon''}{\partial \omega} .$$
 (49b)

For the real part of the group velocity, see Eq. (48a), it goes to infinity for very low-frequencies ( $\omega \to 0$ ), losing physical meaning. Figure 4 illustrates the behavior of  $v_g$ . In the high-frequency regime ( $\omega \to \infty$ ), one finds  $\Re[v_g^{(\pm)}] \to 1/\sqrt{\mu\epsilon_0}$  and  $\Im[v_g^{(\pm)}] \to 0$ . This asymptotic behavior is the same one attained in the limit  $\Sigma \to 0$  and  $\omega_p \to 0$ , which implies  $\epsilon' \to 1$  and  $\epsilon'' \to 0$ , recovering a non-absorbing dielectric.

In scenarios where the group velocity is complex, the sign propagation is better represented by the energy velocity,  $V_E$ , which is here obtained by substituting the solutions (43a) and (43b) in expression (23), yielding

$$V_E^{\pm} = \frac{\sqrt{2|h(\omega)|\omega I_{\pm} \pm \mu\Sigma}}{2\omega U_{\pm}^I} , \qquad (50a)$$

associated with  $k'_+$  and  $k'_-$ , respectively, with

$$U_{\pm}^{I} = \frac{\mu\epsilon'}{2} + \frac{\mu\omega}{2}\frac{\partial\epsilon'}{\partial\omega} + \frac{|h(\omega)|}{4}(I_{\pm}^{2} + I_{-}^{2}) + \frac{\mu^{2}\Sigma^{2}}{8\omega^{2}} + \pm \frac{\mu\Sigma}{2\omega}\sqrt{\frac{|h(\omega)|}{2}}I_{-}.$$
(50b)

Figure 5 illustrates the energy velocities as function of the dimensionless parameter  $\omega/\omega_0$ . The characteristic frequencies  $\omega_{1,2}^i$  are given by the real non-negative solutions of the sixth-order equation in  $\omega$ ,

$$\gamma^{2} \left( \omega^{4} + \frac{\mu \Sigma^{2}}{4\epsilon_{0}} \omega_{0}^{2} \right) + \left( \omega_{0}^{2} - \omega^{2} \right) \times \\ \times \left[ \omega^{2} \left( \omega_{0}^{2} - \omega^{2} + \omega_{p}^{2} \right) + \frac{\mu \Sigma^{2}}{4\epsilon_{0}} \left( \omega_{0}^{2} - \omega^{2} - \gamma^{2} \right) \right] = 0 ,$$

$$(51)$$

and  $\omega_{1,2}^i$  define the limits of the absorption zone for the propagating modes. This absorption effect modifies the behavior of  $V_E^{\pm}$  with the frequency, as one can see. The frequency  $\omega''$  marks the end of the absorption window for a usual DD, where the energy velocity is vanishing. Note, however, that the energy velocity becomes non-null in the absorption zone of the DD modified by the magnetic conductivity since the refractive indices develop a finite

real part. It implies the reduction of the lossy window, favoring the signal propagation.

It is also relevant to note the much more involved energy velocity of Fig. 5 in relation to the correspondent one of Ref. [40], obviously a consequence of the intricate Drude permittivity here considered.

The real non-negative solutions of Eq. (51) yield the characteristic frequencies  $\omega_{1,2}^i$  when  $\Sigma \neq 0$ , and also the frequencies  $\omega'$ ,  $\omega''$  for  $\Sigma = 0$ . In the numerical examples we have considered, one obtains  $\omega' \approx \omega_1^i$ . This is the reason only  $\omega_1^i$  appears in the plots. Furthermore, we observe that:

- For  $0 < \omega < \omega_1^i$ , both modes propagates without attenuation. In this regime, the energy velocity  $V_E^{\pm}$ increases slowly with frequency, starting from zero. It decreases as long as it approaches the resonance frequency,  $\omega \to \omega_0 \approx \omega_1^i$ , where there is absorption peaks indicated by the dotted lines in Figs. 1 and 2. At this frequency, the energy velocities  $V_E^+$  and  $V_E^$ tend to zero. As for  $V_E^-$ , it exactly holds  $V_E^-(\omega_1^i) =$ 0.
- For  $\omega_1^i < \omega < \omega_2^i$ , there occurs propagation and absorption simultaneously (non-null real and imaginary pieces of  $n_{\pm}$ ), since the energy velocities assume non-null values. In fact,  $V_E^+$  is positive in this interval (see the red curve in Fig. 5. On the other hand, the velocity  $V_E^-$  is negative in this zone, indicating negative refraction. This latter feature is in accordance with Fig. 2, where the real piece of  $n_-$  (blue solid curve) is negative in  $\omega_1^i < \omega < \omega''$ . The frequency  $\omega_2^i$  defines the end of the absorption band, whose width is shortened by the presence of magnetic conductivity. At the same time, the real

part of the indices becomes finite (positive or negative), allowing the signal propagation,  $V_E^{\pm} \neq 0$ (forbidden in this interval for a usual Drude dielectric).

- For  $\omega_2^i < \omega < \omega''$ , there is no absorption as one can see in the dotted curves of Figs. 1 and 2. Consequently, the energy velocities  $V_E^{\pm}$  start to increase progressively to their asymptotic values (which coincide with the usual case ones). Furthermore, in this range one still has  $V_E^- < 0$ , which is in agreement with the negative refraction of  $n_-$  that occurs for  $\omega_1^i < \omega < \omega''$ .
- For ω > ω<sub>2</sub><sup>i</sup>: it happens propagation without attenuation for both modes n<sub>±</sub>.

One last comment, yet very subtle, concerns the similarity between the black solid curves in Figs. 4 and 5. These curves represent the real part of the group velocity and the energy velocity, both for  $\Sigma = 0$ , respectively. Equations (50) and (48a) for  $\Sigma = 0$  read

$$V_{E}^{\pm} = \frac{\sqrt{\frac{|h(\omega)|}{2}}I_{+}}{\mu C + \frac{\mu}{2}\sqrt{\epsilon'(\omega)^{2} + \epsilon''(\omega)^{2}} - \mu\epsilon'(\omega)/2} , \quad (52a)$$
$$\Re[v_{g}^{\pm}] = \frac{\sqrt{\frac{|h(\omega)|}{2}}(I_{+}C + I_{-}D)}{\mu\epsilon_{0} (C^{2} + D^{2})} . \quad (52b)$$

These velocities are only equivalent when there is no absorption,  $\gamma = 0$ . Hence, applying this condition, one finds  $\epsilon'' = 0$  and D = 0, such that

$$V_E^{\pm} - \Re[v_g^{\pm}] = -\frac{\sqrt{|\epsilon'(\omega)| + \epsilon'(\omega)}}{C\sqrt{2\mu\epsilon_0}} \frac{|\epsilon'(\omega)| - \epsilon'(\omega)}{2C + |\epsilon'(\omega)| - \epsilon'(\omega)},$$
(53)

where we have used

$$I'_{+} = \sqrt{1 + \operatorname{sgn}[\mu \epsilon'(\omega)]} .$$
 (54)

Obviously, it holds

$$V_E^{\pm} - \Re[v_g^{\pm}] = 0 , \qquad (55)$$

for  $\epsilon'(\omega) > 0$  or  $\epsilon'(\omega) < 0$ . Note that one has: i)  $\epsilon'(\omega) > 0$  for  $\omega < \omega_0$ , or  $\omega > \sqrt{\omega_0^2 + \omega_p^2}$ ; ii)  $\epsilon'(\omega) < 0$ , when  $\omega_0 < \omega < \sqrt{\omega_0^2 + \omega_p^2}$ .

# III. THE CASE OF ANTISYMMETRIC MAGNETIC CONDUCTIVITY TENSOR

In this case, the antisymmetric conductivity tensor is parameterized in terms of a vector  $\mathbf{b}$ ,

$$\sigma_{ij}^B = \epsilon_{ijk} \, b_k \,, \tag{56}$$

implying an antisymmetric magnetic current density,

$$\mathbf{J} = \mathbf{b} \times \mathbf{B} \,, \tag{57}$$

where **b** is a constant vector in space. Such an antisymmetric magnetic current was investigated in the context of Weyl semimetals [24], where  $\hat{\mathbf{b}}$  defines a direction in space. This kind of allowed transverse chiral magnetic photocurrent (orthogonal to the **B** field) is induced by linearly polarized light in WSMs in the presence of parity violation. The effective permittivity tensor is

$$\overline{\epsilon}_{ij}(\omega) = \left[\epsilon(\omega) - \frac{i}{\omega}(\mathbf{b} \cdot \mathbf{n})\right] \delta_{ij} + \frac{i}{\omega} n_i b_j , \qquad (58)$$

which replaced in Eq. (14) yields the *n*-polynomial equation

$$\mathbf{n}^{2} + \frac{i\,\mu}{\omega}\left(\mathbf{b}\cdot\mathbf{n}\right) - \mu\,\epsilon(\omega) = 0\,,\qquad(59)$$

whose solution provides the dispersive refractive index

$$n(\omega) = -\frac{i\,\mu}{2\omega}\,(\hat{\mathbf{k}}\cdot\mathbf{b}) + \sqrt{\mu\epsilon(\omega) - \frac{\mu^2}{4\omega^2}(\hat{\mathbf{k}}\cdot\mathbf{b})^2}\,,\quad(60)$$

where  $\mathbf{k}$  is the direction of propagation.

Substituting the dielectric permittivity (8), the refractive index (60) can be rewritten as

$$n(\omega) = \Re[n(\omega)] + i \Im[n(\omega)], \qquad (61a)$$

where the real and imaginary parts are

$$\Re[n] = \sqrt{\frac{|f(\omega)|}{2}} A_+ , \qquad (61b)$$

$$\Im[n] = \sqrt{\frac{|f(\omega)|}{2}} A_{-} - \frac{\mu}{2\omega} (\hat{\mathbf{k}} \cdot \mathbf{b}) , \qquad (61c)$$

with  $\epsilon'$  and  $\epsilon''$  of Eqs. (10a) and (10b), respectively, and

$$A_{\pm} = \sqrt{\sqrt{1 + \mu^2 \epsilon_0^2 \left[\frac{\epsilon''(\omega)}{f(\omega)}\right]^2}} \pm \operatorname{sgn}[f(\omega)], \quad (61d)$$

where  $f(\omega) = \mu \epsilon'(\omega) - \mu^2 (\mathbf{b} \cdot \hat{\mathbf{k}})^2 / (2\omega)^2$ .

The general behaviors of  $\Re[n]$  and  $\Im[n]$  are represented in Figs. 6 and 7, considering two distinct configurations of the vector **b** relative to the direction of propagation,  $\cos \theta = \pm 1$ , defining propagation parallel and antiparallel to **b**, respectively, with  $\hat{\mathbf{k}} \cdot \mathbf{b} = b \cos \theta$ . The case  $\theta = \pi/2$  is effectively equivalent to the situation of a dielectric stripped of magnetic conductivity (b = 0), which is represented by a black line in Figs. 6 and 7.

Near the origin, the real piece of n goes to infinity for  $\cos \theta = 1$  whereas it goes to zero for the antiparallel propagation ( $\cos \theta = -1$ ), a different behavior in comparison with the conventional DD, as already mentioned. We notice in Figs. 6 and 7 that around  $\omega/\omega_0 = 1$  the real parts of n for parallel and anti-parallel propagation

 $(\cos \theta = \pm 1)$  become equivalent and nearly overlap to the black line. This superposition also occurs in the very high-frequencies regime.

In the very high-frequency regime, the real part goes as  $\Re[n](\omega \gg \omega_0) \rightarrow \sqrt{\mu\epsilon_0}$ . For the very low-frequency limit,  $\omega \rightarrow 0$ , the refractive index becomes purely imaginary,

$$n \simeq \frac{i\mu b}{2\omega} \left( -\cos\theta + |\cos\theta| \right) , \qquad (62)$$

establishing  $\Re[n] = 0$  near the origin. Further, it yields  $\Im[n] = 0$  for  $\cos \theta = 1$  (see dashed line in Fig. 6) and a diverging *n* for  $\cos \theta = -1$  (see dashed line in Fig. 7).

Differently from the standard Drude-Lorentz model,

where the absorption occurs around the resonance frequency  $\omega_0$ , the presence of a non-null magnetic conductivity, given by  $b = |\mathbf{b}|$ , enables absorption even in the small frequency regime,  $\omega \ll \omega_0$ , accordingly to Eq. (62). Therefore, in this antisymmetric scenario for the magnetic conductivity, absorption effects can occur in regions outside the neighborhood of the resonance frequency  $\omega_0$ . On the other hand, such an effect does not happen by means of absorption peak as it occurs in the DD.

The peaks of the real and imaginary parts are given by

$$\Re[n](\omega = \omega_0) = \sqrt{\frac{|f(\omega_0)|}{2}} A_+(\omega_0) ,$$
 (63a)

$$\Im[n](\omega = \omega_0) = \sqrt{\frac{|f(\omega_0)|}{2}} A_-(\omega_0) - \frac{\mu}{2\omega_0} (\hat{\mathbf{k}} \cdot \mathbf{b}) , \quad (63b)$$

where  $f(\omega_0) = \mu \epsilon_0 - \mu^2 (\mathbf{b} \cdot \hat{\mathbf{k}})^2 / (2\omega_0)^2$ . A very subtle difference between the absorption peaks (imaginary part of n) can be observed by comparing Figs. 6 and 7. One notices that  $\Im[n]|_{\theta=0} < \Im[n]|_{\theta=\pi}$ , a direct consequence of the last term in Eq. (63b), which reveals an observable distinction regarding the propagation direction relative to the magnetic conductivity vector  $\mathbf{b}$ .

#### A. Propagation modes

The propagation modes are found for  ${\bf n}$  along the  ${\cal Z}\text{-}$  axis, and the vector  ${\bf b}$  written as

$$\mathbf{n} = (0, 0, n), \quad \mathbf{b} = b(0, \sin \theta, \cos \theta) \equiv (0, b_2, b_3), \quad (64)$$

where  $\theta$  is the angle between **n** and **b**. The matrix  $M_{ij}$  of Eq. (15) is

$$[M_{ij}] = \begin{bmatrix} n^2 - \mu \epsilon + n \frac{i\mu}{\omega} b_3 & 0 & 0\\ 0 & n^2 - \mu \epsilon + n \frac{i\mu}{\omega} b_3 & 0\\ 0 & -n \frac{i\mu}{\omega} b_2 & -\mu \epsilon \end{bmatrix},$$
(65)

with  $\mathbf{n} \cdot \mathbf{b} = n b_3$ . Replacing the index relation (59) in the matrix (65), the condition  $M_{ij}E_j = 0$  provides two mutually orthogonal propagation modes

$$\mathbf{E}_{\pm} = \frac{1}{\sqrt{2(1+|Q|^2)}} \begin{pmatrix} \pm\sqrt{1+|Q|^2} \\ -1 \\ iQe^{i\alpha} \end{pmatrix} , \qquad (66)$$

with  $Q = b_2 N/(\omega \epsilon)$ , endowed however with a longitudinal component. Here, we have rewritten the complex refractive index as  $n = Ne^{i\alpha}$ , with

$$N = \sqrt{\left(\sqrt{\frac{|f(\omega)|}{2}}A_{+}\right)^{2} + \left(\sqrt{\frac{|f(\omega)|}{2}}A_{-} - \frac{\mu b\cos\theta}{2\omega}\right)^{2}},$$
(67)

and

$$\tan \alpha = \frac{A_-}{A_+} - \frac{\mu b \cos \theta}{\omega A_+ \sqrt{2|f(\omega)|}} \,. \tag{68}$$

For the particular case where  $b_2 = 0$ , the solutions in Eq. (66) simplify as

$$\mathbf{E}_{\pm} = \frac{1}{\sqrt{2}} \begin{pmatrix} \pm 1\\ -1\\ 0 \end{pmatrix} , \qquad (69)$$

representing linearly polarized vectors, orthogonal to the propagation direction. As the refractive index of Eq. (61a) has an imaginary piece, there is absorption for both modes given in Eq. (69) (in equal magnitude), measured in terms of the absorption coefficient [1],  $\tilde{\alpha} = 2\omega \operatorname{Im}(n) = \mu b_3$ .

# B. The group and energy velocities of the antisymmetric case

Rewritting Eq. (59) in terms of **k**, one has

$$\mathbf{k}^{2} + i\,\mu\left(\mathbf{b}\cdot\mathbf{k}\right) - \mu\epsilon(\omega)\,\omega^{2} = 0\,\,,\tag{70}$$

whose solution yields the dispersion relation

$$k(\omega) = -\frac{i\mu}{2} (\mathbf{b} \cdot \hat{\mathbf{k}}) + \sqrt{\mu\epsilon(\omega)\,\omega^2 - \frac{\mu^2}{4} (\mathbf{b} \cdot \hat{\mathbf{k}})^2} , \quad (71)$$

with real and imaginary parts given as, respectively,

$$k'(\omega) = \omega \sqrt{\frac{|f(\omega)|}{2}} A_+ , \qquad (72a)$$

$$k''(\omega) = \omega \sqrt{\frac{|f(\omega)|}{2}} A_{-} - \frac{\mu}{2} (\hat{\mathbf{k}} \cdot \mathbf{b}) .$$
 (72b)

Taking the derivative in relation to  $k^i$ -component in (70), the *i*th-component of the group velocity is

$$v_g^i = \frac{k^i + i\,\mu\,b^i/2}{\mu\omega\left[\epsilon(\omega) + f_\epsilon(\omega)\,\omega/2\right]} \,. \tag{73}$$

Using now  $k^i = k^{i\prime} + ik^{i\prime\prime}$ , one finds

$$\mathbf{v}_g = \frac{\mathbf{k}'/(\mu\omega) + i\,\omega\epsilon''\hat{\mathbf{k}}'/(2k')}{C + iD}\,,\tag{74}$$

with C and D defined by Eq. (49). The latter also indicates that the group velocity is defined along the  $\mathbf{k}'$ direction. Substituting the solution (72), the group velocity is written as a function of  $\omega$ :

$$\Re[v_g] = \frac{(\mu\epsilon_0)^{-1}}{C^2 + D^2} \sqrt{\frac{|f(\omega)|}{2}} \left(A_+C + A_-D\right) , \qquad (75a)$$

$$\Im[v_g] = \frac{(\mu\epsilon_0)^{-1}}{C^2 + D^2} \sqrt{\frac{|f(\omega)|}{2}} \left(A_-C - A_+D\right) .$$
(75b)

The group velocity behavior as function of the dimensionless parameter  $\omega/\omega_0$  is shown in Fig. 8. For highfrequencies, it holds  $\Re[v_g] = 1/\sqrt{\mu_0\epsilon_0} = 1$  (for  $\mu = \mu_0$ ), whereas the imaginary part goes to zero,  $\Im[v_g] = 0$ . At the origin, its real piece is well behaved whereas the imaginary part goes to infinity. This latter behavior is also observed in a dielectric with constant magnetic conductivity,  $\epsilon' = cte$ ,  $\epsilon'' = \sigma/\omega$ ,  $\Sigma = cte$ , as seen in Ref. [40].

Assessing now the energy propagation signal, we implement (72a) in (23), in such a way the energy velocity is

$$V_E = \sqrt{\frac{|f(\omega)|}{2}} \frac{A_+}{U^A} , \qquad (76a)$$

with

$$U^{A} = \frac{\mu\epsilon'}{2} + \frac{\mu\omega}{2}\frac{\partial\epsilon'}{\partial\omega} + \frac{|f(\omega)|}{4}(A_{+}^{2} + A_{-}^{2}) + \frac{\mu^{2}b^{2}}{8\omega^{2}}\cos^{2}\theta + \frac{\mu b\cos\theta}{2\omega}A_{-}\sqrt{\frac{|f(\omega)|}{2}}.$$
(76b)

The behavior of the energy velocity is depicted in Fig. 9 in terms of  $\omega/\omega_0$ . The frequencies  $\omega_{1,2}^a$  define a region where occurs an absorption peak followed by a strong reduction of the real part of the refractive index n, as indicated in Figs. 6 and 7. In details, we observe that:

- For  $0 < \omega < \omega_1^a$ : one has a total absorption range, since  $\operatorname{Re}[n] = 0$ , where there is no propagation. Hence, the energy velocity is null in this frequency window.
- For  $\omega_1^a < \omega < \omega'$ : there occurs propagation together with absorption, since  $\operatorname{Re}[n] \neq 0$  and  $\operatorname{Im}[n] \neq 0$ . As a consequence, there is a non-null energy velocity in this small region, as indicated

in Fig. 9. As the frequency approaches  $\omega'$ , there occurs an absorption peak followed by a rapid decreasing of  $\operatorname{Re}[n]$  to zero, which marks the beginning of a second total absorption zone, where  $V_E$  vanishes. This behavior appears in terms of a diminishing  $V_E$  for  $\omega$  approaching  $\omega'$  and  $V_E = 0$  thereafter. See Fig. 9.

- For  $\omega' < \omega < \omega_2^a$ : there is no propagation,  $\operatorname{Re}[n] = 0$ , as pointed in Figs. 6 and 7, in such a way only absorption takes place and  $V_E = 0$ . This interval magnitude represents the enlargement of the absorption zone in the presence of the antisymmetric magnetic conductivity, compared to the usual DD absorption window, which is now incremented by  $\Delta \omega = \omega_2^a \omega''$ .
- For  $\omega > \omega_2^a$ : the absorption starts to diminish while the propagation regime is partially restored. As a consequence, the energy velocity assumes increasing magnitude, tending to its asymptotic value.
- The entire plot of Fig. 9 reveals a scenario where the signal propagation is severely constrained for frequencies below  $\omega_2^a$ , which is in contrast with the signal propagation in the absorption windows of the Drude isotropic conductivity case, represented by the energy velocity of Fig. 5.

The characteristic frequencies can be determined by

solving the sixth-order equation in  $\omega$ ,

$$\gamma^{2} \left( \omega^{4} - \frac{\mu b^{2} \cos^{2} \theta}{4\epsilon_{0}} \omega_{0}^{2} \right) + \left( \omega_{0}^{2} - \omega^{2} \right) \times \\ \times \left[ \omega^{2} \left( \omega_{0}^{2} - \omega^{2} + \omega_{p}^{2} \right) - \frac{\mu b^{2} \cos^{2} \theta}{4\epsilon_{0}} \left( \omega_{0}^{2} - \omega^{2} - \gamma^{2} \right) \right] = 0$$

$$(77)$$

from which the real and positive solutions yield  $\omega_{1,2,3}^a$ when  $b\cos\theta \neq 0$ , and  $\omega''$  when  $b\cos\theta = 0$ . However, as  $\omega_3^a \approx \omega'$ , we have chosen to depict only  $\omega'$  in the plots.

### IV. THE CASE OF THE SYMMETRIC CONDUCTIVITY TENSOR

We write the magnetic conductivity tensor in the symmetric form

$$\sigma_{Bij} = \frac{1}{2} \left( a_i \, c_j + a_j \, c_i \right) \,, \tag{78}$$

where  $a_i$  and  $c_j$  are components of the orthogonal background vectors **a** and **c**, respectively. In this case, the permittivity tensor (13) is

$$\bar{\epsilon}_{ij}(\omega) = \epsilon(\omega)\delta_{ij} + \frac{i}{2\omega} \left[ a_i \left( \mathbf{c} \times \mathbf{n} \right)_j + c_i \left( \mathbf{a} \times \mathbf{n} \right)_j \right].$$
(79)

The null determinant of the matrix  $M_{ij}$  with permittivity (79) provides *n*-polynomial equations,

$$n^{2} - \mu \epsilon(\omega) \pm \frac{i\mu}{2\omega} \mathbf{n} \cdot (\mathbf{a} \times \mathbf{c}) = 0.$$
 (80)

Writing  $\mathbf{n} = n \,\hat{\mathbf{k}}$ , the solutions of (80) are

$$n_{\pm}(\omega) = \mp \frac{i\,\mu}{4\omega}\,\hat{\mathbf{k}}\cdot(\mathbf{a}\times\mathbf{c}) + \sqrt{\mu\epsilon(\omega) - \frac{\mu^2}{16\omega^2}[\hat{\mathbf{k}}\cdot(\mathbf{a}\times\mathbf{c})]^2},$$
(81)

or

$$n_{\pm} = \Re[n_{\pm}] + i \Im[n_{\pm}] , \qquad (82)$$

with

$$\Re[n_{\pm}] = \sqrt{\frac{|g(\omega)|}{2}} S_{\pm} , \qquad (83a)$$

$$\Im[n_{\pm}] = \sqrt{\frac{|g(\omega)|}{2}} S_{-} \mp \frac{\mu}{4\omega} \,\hat{\mathbf{k}} \cdot (\mathbf{a} \times \mathbf{c}) , \qquad (83b)$$

where

$$S_{\pm} = \sqrt{\sqrt{1 + \mu^2 \left[\frac{\epsilon''(\omega)}{g(\omega)}\right]^2}} \pm \operatorname{sgn}[g(\omega)], \quad (84)$$

and

$$g(\omega) = \mu \epsilon'(\omega) - \mu^2 (\hat{\mathbf{k}} \cdot (\mathbf{a} \times \mathbf{c}))^2 / (4\omega)^2.$$
 (85)

Notice that the expressions (83a) and (83b) can be obtained from the results of the antisymmetric case (61b) and (61c) by implementing  $\mathbf{b} \to \pm (\mathbf{a} \times \mathbf{c})/2$ . The behavior of  $n_{\pm}$  as function of  $\omega/\omega_0$  is illustrated in Figs. 10 and 11, where we have used  $\hat{\mathbf{k}} \cdot (\mathbf{a} \times \mathbf{c}) = |\mathbf{a} \times \mathbf{c}| \cos \varphi$ . From Eq. (82), one notices that  $\Re[n_{\pm}] = \Re[n_{\pm}]$  and  $\Im[n_{\pm}]|_{\varphi=0,\pi} = \Im[n_{\pm}]|_{\varphi=\pi,0}$ , which indicates a kind of correspondence symmetry between the absorptive terms of  $n_{\pm}$  relative to the sense (positive or negative) of propagation.

In the very high-frequency limit, the refractive indices become  $n_{\pm} \rightarrow \sqrt{\mu\epsilon_0}$ . On the other hand, in the lowfrequency regime, one obtains

$$n_{\pm} \simeq \frac{i\mu |\mathbf{a} \times \mathbf{c}|}{4\omega} \left(\mp \cos \varphi + |\cos \varphi|\right) . \tag{86}$$

Hence  $n_+|_{\varphi=0} = n_-|_{\varphi=\pi} = 0$  and  $n_+|_{\varphi=\pi} = n_-|_{\varphi=0} \simeq i\mu |\mathbf{a} \times \mathbf{c}|/(2\omega)$ , which explains the divergence in the origin observed in Figs. 10 and 11.

### A. Propagation modes

To evaluate the propagating modes, we choose an appropriate coordinate system where the magnetic conductivity vectors are given by  $\mathbf{a} = (a_1, 0, a_3)$ ,  $\mathbf{c} = (0, c_2, 0)$ , such that

$$\mathbf{a} \times \mathbf{c} = (-a_3 c_2, 0, a_1 c_2) .$$
 (87)

For propagation along the  $\mathcal{Z}$ -axis,  $\mathbf{n} = (0, 0, n)$ , the

matrix  $M_{ij}$  is

$$[M_{ij}] = \begin{bmatrix} n^2 - \mu\epsilon - i\frac{\mu}{2\omega}a_1c_2n & 0 & 0\\ 0 & n^2 - \mu\epsilon + i\frac{\mu}{2\omega}a_1c_2 & 0\\ -i\frac{\mu}{2\omega}a_3c_2n & 0 & -\mu\epsilon \end{bmatrix}$$
(88)

where  $\epsilon = \epsilon(\omega)$  is the complex electric permittivity. Thus, by implementing Eq. (80) in Eq. (88), the relation  $M_{ij}E_j = 0$  provides the following polarization vectors:

$$\mathbf{E}_{+} = \frac{1}{\sqrt{1+|A|^2}} \begin{pmatrix} 1\\0\\-iA \end{pmatrix}, \quad \mathbf{E}_{-} = \begin{pmatrix} 0\\1\\0 \end{pmatrix}, \quad (89)$$

associated with  $n_{\pm}$ , respectively, with  $A = a_3 c_2/(2\omega\epsilon n)$ . We observe that  $\mathbf{E}_{\pm}$  represent linearly polarized vectors, with  $\mathbf{E}_{+}$  endowed with a longitudinal component. Since the the real peace of  $n_{\pm}$  is the same one, there is no birefringence. On the other hand, the imaginary pieces are different, meaning that the propagating modes are absorbed at different degrees, which can be measured by the absorption difference per unit length,

$$\frac{\Delta_d}{l} = \frac{2\pi}{\lambda_0} \left[ \operatorname{Im}(n_+) - \operatorname{Im}(n_-) \right] , \qquad (90)$$

with  $\lambda_0$  being the vacuum wavelength of incident light. Hence, for the indices of Eq. (82) and propagation along the z-axis, the absorption difference is

$$\frac{\Delta_d}{l} = -\frac{\mu a_1 \, c_2}{2} \,. \tag{91}$$

# B. The group and energy velocities of the symmetric case

Backing to Eq. (80) in terms of  ${\bf k}$  and  $\omega,$  we rewrite it as

$$k^{2} \pm \frac{\imath \mu}{2} \mathbf{k} \cdot (\mathbf{a} \times \mathbf{c}) - \mu \omega^{2} \epsilon(\omega) = 0, \qquad (92)$$

whose solutions are

ŀ

$$k_{\pm}(\omega) = k'_{\pm} + ik''_{\pm} , \qquad (93)$$

with

$$s'_{\pm}(\omega) = \omega \sqrt{\frac{|g(\omega)|}{2}} S_{\pm} , \qquad (94a)$$

$$k_{\pm}^{\prime\prime}(\omega) = \omega \sqrt{\frac{|g(\omega)|}{2}} S_{-} \mp \frac{\mu}{4} \hat{\mathbf{k}} \cdot (\mathbf{a} \times \mathbf{c}) , \quad (94b)$$

and  $S_{\pm}$  of Eq. (84). Evaluating the derivative of Eq. (92) relative to  $k^i$ -component, one finds the following group velocities:

$$\mathbf{v}_{g}^{\pm} = \frac{\partial \omega}{\partial \mathbf{k}} = \frac{\frac{\mathbf{k}}{\mu \omega} \pm i \frac{(\mathbf{a} \times \mathbf{c})}{4\omega}}{\left(\epsilon' + \frac{\omega}{2} \frac{\partial \epsilon'}{\partial \omega}\right) + i \left(\epsilon'' + \frac{\omega}{2} \frac{\partial \epsilon''}{\partial \omega}\right)} . \tag{95}$$

Using Eq. (93) the group velocity (95) takes on the form,

$$\mathbf{v}_{g}^{\pm} = \frac{\frac{\mathbf{k}'}{\mu\omega} + i\frac{\omega\epsilon''\,\mathbf{\hat{k}}}{2k'}}{\left(\epsilon' + \frac{\omega}{2}\frac{\partial\epsilon'}{\partial\omega}\right) + i\left(\epsilon'' + \frac{\omega}{2}\frac{\partial\epsilon''}{\partial\omega}\right)}.$$
 (96)

whose real and imaginary pieces are

$$\Re[v_g^{\pm}] = \frac{(\mu\epsilon_0)^{-1}}{C^2 + D^2} \sqrt{\frac{|g(\omega)|}{2}} \left(S_+C + S_-D\right) , \qquad (97a)$$

$$\Im[v_g^{\pm}] = \frac{(\mu\epsilon_0)^{-1}}{C^2 + D^2} \sqrt{\frac{|g(\omega)|}{2}} \left(S_-C - S_+D\right) . \quad (97b)$$

Figure 12 shows the real and imaginary parts of the group velocity given in Eq. (97) in terms of the dimensionless parameter  $\omega/\omega_0$ . We have considered the previous case where  $\mathbf{a} = (a_1, 0, a_3)$  and  $\mathbf{c} = (0, c_2, 0)$ , such that  $\mathbf{a} \times \mathbf{c} = (-a_3c_2, 0, a_1c_2)$ , and  $\hat{\mathbf{k}} = \hat{\mathbf{z}}$ . For high frequencies  $(\omega \gg \omega_0)$ , one has  $\Re[v_g] \to 1/\sqrt{\mu_0\epsilon_0} = 1$  and  $\Im[v_g] = 0$ .

Considering  $a_3 = 0$ , the propagating modes represented by Eq. (89) turn out perpendicular to the direction of propagation, satisfying the conditions (18a) and (18b) for the evaluation of the energy velocity. In this sense, Eqs. (94a) and (94b) yield

$$V_E^{\pm} = \sqrt{\frac{|g(\omega)|}{2}} \frac{S_+}{U_{\pm}^S} ,$$
 (98a)

with

$$\begin{split} U_{\pm}^{S} &= \frac{\mu\epsilon'}{2} + \frac{\mu\omega}{2} \frac{\partial\epsilon'}{\partial\omega} + \frac{|g(\omega)|}{4} (S_{+}^{2} + S_{-}^{2}) + \\ &+ \frac{\mu^{2} |\mathbf{a} \times \mathbf{c}|^{2}}{32\omega^{2}} \cos^{2}\varphi \pm \frac{|\mathbf{a} \times \mathbf{c}|}{4\omega} \cos\varphi \sqrt{\frac{|g(\omega)|}{2}} S_{-} \;. \end{split}$$
(98b)

The behavior of the energy velocity is represented in Fig. 13 in terms of  $\omega/\omega_0$ . As it happened in the antisymmetric case, see Sec. III, the frequencies  $\omega_{1,2}^s$  define the region where occurs an absorption peak followed by an abrupt and strong reduction of the real part of the refractive indices. Also, we observe the existence of two lossy windows where the energy velocity is null. In details:

- For  $0 < \omega < \omega_1^s$ : there does not occur propagation, since  $\operatorname{Re}[n_{\pm}] = 0$  and the energy velocity is null,  $V_E^{\pm} = 0$ .
- For  $\omega_1^s < \omega < \omega'$ : propagation and absorption occur simultaneously and  $V_E^{\pm} \neq 0$ , since the real and imaginary pieces of  $n_{\pm}$  are non-null, see Figs. 10 and 11. Whereupon the resonance frequency  $\omega'$ , the pieces  $\operatorname{Re}[n_{\pm}]$  undergo a rapid deacreasing, implying a null energy velocity.
- For  $\omega' < \omega < \omega_2^s$ : only absorption occurs, since  $\operatorname{Re}[n_{\pm}] = 0$  and  $V_E^{\pm} = 0$  (see Figs. 11 and 13).
- Finally, for  $\omega > \omega_2^s$ : the propagation of both modes  $n_{\pm}$  is restored, while the absorption effect diminishes rapidly to zero. The energy velocity increases monotonically to its asymptotic value.

To obtain the characteristic frequencies, we need to solve the following the sixth-order equation:

$$\gamma^{2} \left(\omega^{4} - s \,\omega_{0}^{2}\right) + \left(\omega_{0}^{2} - \omega^{2}\right) \times \\ \times \left[\omega^{2} \left(\omega_{0}^{2} - \omega^{2} + \omega_{p}^{2}\right) - s \left(\omega_{0}^{2} - \omega^{2} - \gamma^{2}\right)\right] = 0 , \quad (99)$$

with

$$s = \frac{\mu}{16\epsilon_0} |\mathbf{a} \times \mathbf{c}|^2 \cos^2 \varphi , \qquad (100)$$

in the place of the factor  $\mu b^2 \cos^2 \theta / 4\epsilon_0$  in Eq. (77). Eq. (99) provides the roots  $\omega_{1,2,3}^s$ , when  $|\mathbf{a} \times \mathbf{c}| \cos \varphi \neq 0$ , and  $\omega''$  when  $|\mathbf{a} \times \mathbf{c}| \cos \varphi = 0$ . We mention that  $\omega_3^s \approx \omega'$ , then we have depicted only  $\omega'$  in the previous plots.

### V. FINAL REMARKS

In this paper, we have discussed the properties of wave propagation and absorption in a Drude-Lorentz dielectric in the presence of magnetic conductivity. The analysis was performed for three configurations of the magnetic conductivity tensor: isotropic, antisymmetric, and symmetric. For each case, we have obtained the dispersion relation and refractive indices as functions of the frequency and of the Drude-Lorentz parameters, with their properties properly scrutinized for all configurations. The involved refractive indices were examined in the range of low- and high-frequencies, being always compared to Drude's usual dielectric behavior. The group and the energy velocities were evaluated for all cases, being the latter one used as tool to examine signal propagation.

In lossy scenarios, as the group velocity becomes complex and loses physical interpretation, the signal propagation passes to be described by the energy velocity, which is real. In the high-frequency limit, one obtained  $\Re[n] = \sqrt{\mu \epsilon_0}$ , while the energy velocity is reduced to  $V_E = 1/\sqrt{\mu\epsilon_0}$  (for all the cases examined). The absorption goes to zero in this frequency regime,  $\Im[n] \to 0$ . Near the origin and at intermediary frequencies, however, the refractive indices behave in some different ways.

The first case studied was the DD with isotropic magnetic conductivity,  $\Sigma \neq 0$ , examined in Sec. II. The associated refractive indices show distinct features in relation to the conventional DD. Near the origin, it occurs  $\Re[n_+] \to \infty$ , approaching the behavior of a magnetized plasma index, while one has  $\Re[n_-] \to 0$  (for  $\omega \to 0$ ). These latter properties also manifest in a simple dielectric,  $\epsilon' = cte$ ,  $\epsilon'' = \sigma/\omega$ , with  $\Sigma = cte$  [40]. The absorption window now has its length reduced by the magnetic conductivity. Moreover, the lossy interval begins to support signal propagation,  $V_E^{\pm} \neq 0$ , because the refractive indices  $n_{\pm}$  develop non-null real pieces in the range  $\omega_1^i < \omega < \omega''$ , in which the signal propagation is favoured. See Figs. 1, 2 and 5 for cheking details. Thus, the frequency window where  $V_E = 0$  is nearly supressed in the presence of the magnetic conductivity,  $\Sigma \neq 0$ .

For the antisymmetric and symmetric cases of Secs. III and IV, respectively, we observe that the frequency window, where the energy velocity is null, is slightly "enhanced" due to the presence of the magnetic conductivity  $(b\cos\theta \neq 0, \text{ and } |\mathbf{a} \times \mathbf{c}| \cos\varphi \neq 0)$ . Such a feature occurs because the non-null magnetic conductivity enlarges the frequency window where absorption effects can take place, see Figs. 6 and 7 for the antisymmetric case, and Figs. 10 and 11 for the symmetric case. In both configurations, the energy velocity becomes predominantly null for frequencies approximately smaller than  $2\omega_0$ , a window in which the signal propagation is severely constrained. See the plots of Fig. 9 and Fig. 13. Such a behavior states a sharp difference in relation to the DD with isotropic conductivity of Sec. II, which presents enhanced progapation in this window, as already mentioned. The properties of the DD refractive indices and DD with magnetic conductivity are displayed in Table I.

As it is known in the literature, in non-absorbing media the energy velocity and group velocity are equal,  $v_q = v_E$ , equivalence that disappears in lossy media where it holds  $v_q \neq v_E$ . In the present work all the analyzed scenarios are endowed with absorption and  $\epsilon'' = 0$ , which justifies the attainment of  $v_g \neq v_E$  in all sections of the work .
