# On the Landis conjecture in a cylinder

#### Abstract

The equation  $-\Delta u + Vu = 0$  in the cylinder  $\mathbb{R} \times (0, 2\pi)^d$  with periodic boundary conditions is considered. The potential V is assumed to be bounded, and both functions u and V are assumed to be real-valued. It is shown that the fastest rate of decay at infinity of non-trivial solution u is  $O\left(e^{-c|w|}\right)$  for d = 1 or 2, and  $O\left(e^{-c|w|^{4/3}}\right)$  for  $d \ge 3$ . Here w is the axial variable. <sup>1</sup>

## Introduction

### 0.1 Formulation of the result

Consider the equation

$$-\Delta u + Vu = 0, (0.1)$$

where V is a bounded measurable function. Landis has proposed the question about the fastest speed at which a solution u can decrease at infinity if we consider the equation (0.1) in the entire space  $\mathbb{R}^n$  or outside a ball in  $\mathbb{R}^n$ . There are two settings of the question: the real case and the complex case. A complex-valued function u satisfies the equation (0.1) for a certain bounded *complex* potential V if and only if

$$|\Delta u| \leqslant C|u|. \tag{0.2}$$

If the potential V is real, the equation (0.1) is true for the real part Re u and for the imaginary part Im u. It means that the condition that a function u satisfies the equation (0.1) for a certain bounded real potential V is equivalent to the estimate (0.2) with a real-valued function u.

For n=1 it is easy to see that any solution which decreases superexponentially fast

$$u(x) = O(e^{-N|x|}) \quad \forall N,$$

is  $u \equiv 0$ . On the other hand, there exist nontrivial solutions which decrease exponentially. For example, the function  $u(x) = \exp(-\sqrt{x^2 + 1})$  satisfies the estimate (0.2). Therefore, for n = 1 the answer is clear both in the real and in the complex cases.

The question in the multidimensional complex case was solved by Meshkov [7]. He showed that any function u saisfying (0.2) and

$$u(x) = O\left(e^{-N|x|^{4/3}}\right) \quad \forall \ N,$$

is  $u \equiv 0$ . Also for n = 2 he constructed a nontrivial function u satisfying the estimate (0.2) and the estimate

$$u(x) = O\left(e^{-c|x|^{4/3}}\right)$$

for a certain c > 0.

The real multidimensional case remains an open problem. Recently in [6] it has been shown that for n = 2, any real function u satisfying (0.2) and

$$u(x) = O(e^{-N|x|\sqrt{\ln|x|}}), \text{ for } |x| \to \infty, \quad \forall N$$

is  $u \equiv 0$ .

We consider an analogous question in a cylinder

$$\Pi := \mathbb{R} \times \mathbb{T}^d, \qquad \mathbb{T}^d = \mathbb{R}^d / (2\pi \mathbb{Z})^d.$$

Our main result is the following

**Theorem 0.1.** Let  $d \geq 3$ , N > 0. There exists a real-valued function  $F \in C^{\infty}(\mathbb{R} \times \mathbb{T}^d)$ ,  $F \not\equiv 0$ , such that

$$|\Delta F(x)| \leqslant C|F(x)|,\tag{0.3}$$

$$|F(x)| \leqslant Ce^{-N|w|^{4/3}}$$
 (0.4)

for all  $x = (w, y) \in \mathbb{R} \times \mathbb{T}^d$ .

**Remark 0.2.** If one constructs such function  $F(w, y_1, y_2, y_3)$  for d = 3, then the same function works also as an example for d > 3.

Assume that the function  $F_1(w, y)$  satisfies (0.3), (0.4) with N = 1. Consider the function  $\tilde{F}(w, y) = F_1(nw, ny)$  with some natural n. Then  $\tilde{F}$  is also  $(2\pi)$ -periodic in each variable  $y_j$ ,

$$\left| \Delta \tilde{F}(w,y) \right| = n^2 \left| \Delta F_1(nw, ny) \right| \leqslant n^2 C \left| F_1(w,y) \right|,$$
$$\left| \tilde{F}(w,y) \right| \leqslant C e^{-n^{4/3} |w|^{4/3}}.$$

So, if there is a function for N=1 then there is a such function for any N.

Thus, Theorem 0.1 follows from its particular case d=3 and N=1. In the sequel we construct an example just for d=3 and N=1.

Bourgain and Kenig proved the following estimate.

**Theorem 0.3** ([1], Lemma 3.10). Assume that a function u satisfies (0.2) in  $\mathbb{R}^n$ ,  $u \not\equiv 0$ . Then

$$\max_{|x-x_0| \le 1} |u(x)| \ge c' \exp\left(-c'|x_0|^{4/3} \ln|x_0|\right).$$

They also asked [1, end of §3] what can be said about the quantity

$$\mathcal{L} := \limsup_{|x_0| \to \infty} \min_{|x-x_0| \le 1} \frac{\ln|\ln|u(x)||}{\ln|x|} \tag{0.5}$$

for non-trivial solutions to (0.2). Theorem 0.3 shows that  $\mathcal{L} \leq 4/3$  always. Our example shows that for  $n \geq 4$  this estimate is sharp even for real-valued solutions. Indeed, extend the function F from Theorem 0.1 periodically in  $\mathbb{R}^{d+1}$ . It satisfies (0.2) in  $\mathbb{R}^{d+1}$ . Take x = (w, 0). Then

$$|F(x)| \le Ce^{-|w|^{4/3}} = Ce^{-|x|^{4/3}}, \qquad \ln|\ln|F(x)|| \ge \frac{4}{3}\ln|x| - 1$$

for sufficiently large |x|, and therefore  $\mathcal{L} = 4/3$ .

### 0.2 Relation with an abstract question

In 2020 D. Elton proved

**Theorem 0.4** ([2]). Let  $\mathcal{A}$  be a nonnegative self-ajoint operator in the Hilbert space  $\mathcal{H}$ ,  $\mathcal{A} = \mathcal{A}^* \geqslant 0$ . Suppose that the function  $\phi \colon (0, \infty) \to \mathcal{H}$ ,

$$\phi \in L_2((0,\infty); \operatorname{Dom} \mathcal{A}) \cap W_2^1((0,\infty); \operatorname{Dom} \sqrt{\mathcal{A}}) \cap W_2^2((0,\infty); \mathcal{H})$$

$$\tag{0.6}$$

satisfies the inequality

$$\left\| \frac{d^2 \phi(w)}{dw^2} - \mathcal{A}\phi(w) \right\|_{\mathcal{H}} \leqslant C \|\phi(w)\|_{\mathcal{H}}. \tag{0.7}$$

1) If we also have

$$\int_{0}^{\infty} \left\| \phi(w) \right\|_{\mathcal{H}}^{2} e^{2Nw^{4/3}} dw < \infty \quad \forall \ N > 0,$$

then  $\phi \equiv 0$ .

2) If the positive spectrum of A contains arbitrarily large gaps, and

$$\int_{0}^{\infty} \|\phi(w)\|_{\mathcal{H}}^{2} e^{2Nw} dw < \infty \quad \forall N > 0,$$

then  $\phi \equiv 0$ .

This result is sharp. Assume that all gaps in the spectrum of a self-adjoint operator  $\mathcal{A}$  are bounded by some constant. Then there exists a non-trivial function  $\phi:(0,\infty)\to\mathcal{H}$  satisfying (0.6), (0.7) and the estimate  $\|\phi(w)\|_{\mathcal{H}} \leqslant Ae^{-Bw^{4/3}}$ , see [4, Theorem 0.2].

The equation (0.1) in the half-cylinder  $[0, \infty) \times \mathbb{T}^d$  satisfies the condition of the Theorem 0.4, if we take as  $\mathcal{A}$  the Laplace operator over the variables y,  $\mathcal{A} = -\Delta_{\mathbb{T}^d}$  in the Hilbert space  $\mathcal{H} = L_2(\mathbb{T}^d)$ . The spectrum of  $-\Delta_{\mathbb{T}^d}$  is the set of sums of d squares,

$$\sigma(\mathcal{A}) = \{ n_1^2 + \dots + n_d^2; \quad n_1, \dots, n_d \in \mathbb{Z} \}.$$

Its structure is well studied. For d=1 and d=2 there exist arbitrary long segments in the set of positive integers which contain no numbers from this set. If d=3, the set does not contain the numbers of the form  $4^a(8b+7)$  only, and for  $d \ge 4$  it is the whole set of nonnegative integers  $\sigma(\mathcal{A}) = \mathbb{N}_0$ . Therefore, Theorem 0.4 implies the following

**Theorem 0.5.** Suppose that a complex-valued function  $u \in W_2^2((0,\infty) \times \mathbb{T}^d)$  satisfies the estimate

$$|\Delta u(w,y)| \leq C|u(w,y)|$$
 for almost all  $(w,y) \in (0,\infty) \times \mathbb{T}^d$ .

1) If we also have

$$u(w,y) = O\left(e^{-Nw^{4/3}}\right) \quad \forall \ N, \tag{0.8}$$

then  $u \equiv 0$ .

2) For 
$$d = 1$$
 and  $d = 2$  if  $u(w, y) = O(e^{-Nw}) \quad \forall N,$  (0.9)

then  $u \equiv 0$ .

Of course, this Theorem is sharp in the cases d = 1 and d = 2: as an example one may consider the function  $u(w, y) = e^{-w}$ . In our previous work [4] we showed that this Theorem is sharp for  $d \ge 3$  in the complex case. Now, Theorem 0.1 shows that in the real case it is also sharp.

In §1 we construct an explicit function f in the cylinder which satisfies bounds  $f(x) = O\left(e^{-|w|^{4/3}}\right)$  and  $\Delta f(x) = O\left(e^{-|w|^{4/3}}\right)$ . In §2 we describe the domain  $\Omega$  where the values of the function f are very small,  $|f(x)| \leq he^{-|w|^{4/3}}$  with a fixed number  $h \ll 1$ . Section 3 contains some auxiliary facts. In §4 and §5 we study the Dirichlet problem for the Poisson equation in the domain  $\Omega$ . In §6 we construct first the function  $f^*$  that coincides with the function f outside  $\Omega$ , and is its harmonic extension in  $\Omega$ . Finally, we define the function F as the mollification of the function  $f^*$ , and prove Theorem 0.1.

We use the notations  $\nabla f = \left(\frac{\partial f}{\partial w}, \frac{\partial f}{\partial y_1}, \frac{\partial f}{\partial y_2}, \frac{\partial f}{\partial y_3}\right)^t$ ,  $\nabla_y f = \left(\frac{\partial f}{\partial y_1}, \frac{\partial f}{\partial y_2}, \frac{\partial f}{\partial y_3}\right)^t$ . By  $\text{mes}_k A$  we denote the k-dimensional Lebesgue measure of the set A.

# 1 Functions $f_0$ and f

## 1.1 Sequence of integer vectors

**Lemma 1.1.** There is a sequence  $\{a_k\}_{k=1}^{\infty}$ ,  $a_k \in \mathbb{Z}^3$ , such that

$$a_k^2 = 4k + 1, \qquad |a_k \cdot a_{k+1}| \le \frac{1}{\sqrt{3}} |a_k| |a_{k+1}|.$$

*Proof.* We construct this sequence step by step. Assume that the vector  $a_k$  is already chosen. Without loss of generality we can assume that

$$a_{k,1} \geqslant a_{k,2} \geqslant a_{k,3} \geqslant 0.$$

Then

$$a_k^2 \geqslant l a_{k,l}^2 \quad \Rightarrow \quad a_{k,l} \leqslant \frac{|a_k|}{\sqrt{l}}, \quad l = 1, 2, 3.$$

It is well known that any natural number of the form (4m+1) can be represented as a sum of three squares. Therefore, one can find a vector  $b \in \mathbb{Z}^3$  such that  $|b| = \sqrt{4k+5}$ . Moreover we can assume

$$0 \leqslant b_1 \leqslant b_2 \leqslant b_3,$$

and

$$b_l \leqslant \frac{|b|}{\sqrt{4-l}}, \quad l = 1, 2, 3.$$

Thus,

$$a_{k,l}b_l \leqslant \frac{|a_k||b|}{\sqrt{l(4-l)}} \leqslant \frac{|a_k||b|}{\sqrt{3}}, \quad l = 1, 2, 3.$$

Let us consider four sums

$$a_{k,1}b_1 + a_{k,2}b_2 + a_{k,3}b_3 > 0,$$

$$a_{k,1}b_1 + a_{k,2}b_2 - a_{k,3}b_3,$$

$$a_{k,1}b_1 - a_{k,2}b_2 - a_{k,3}b_3,$$

$$-a_{k,1}b_1 - a_{k,2}b_2 - a_{k,3}b_3 < 0.$$

There are two neighbour lines where the sum in the first line is non-negative, and the sum in the second line is non-positive. They differ at most by  $2|a_k||b|/\sqrt{3}$ . Therefore, one of them is at most  $|a_k||b|/\sqrt{3}$  in absolute value. Now, we can take as  $a_{k+1}$  the vector b with suitable signs of its coordinates.

Corollary 1.2. We have  $(\sin \alpha_k)^2 \ge 2/3$  where  $\alpha_k$  is the angle between  $a_k$  and  $a_{k+1}$ .

## **1.2** Function $f_0$

We need some auxiliary numbers and functions. Introduce numbers

$$w_k = \frac{27}{8} k^{3/2}, \quad k \in \mathbb{N}.$$

We have

$$(k+1)^{3/2} - k^{3/2} = \frac{3}{2} \int_{k}^{k+1} \sqrt{t} \, dt,$$

SO

$$\frac{81}{16}\sqrt{k} \leqslant w_{k+1} - w_k \leqslant \frac{81}{16}\sqrt{k+1}.$$

Fix a function  $\zeta \in C^{\infty}(\mathbb{R})$  possessing the following properties:

$$\zeta(w) = 0 \quad \text{if} \quad w \leqslant 0, \qquad \zeta(w) = 1 \quad \text{if} \quad w \geqslant 1, 
0 \leqslant \zeta(w) \leqslant 1 \quad \forall w, \qquad \zeta'(w) > 0 \quad \text{if} \quad 0 < w < 1, 
\zeta'(w) \leqslant 2 \quad \forall w, \qquad |\zeta''(w)| \leqslant 5 \quad \forall w.$$
(1.1)

Fix a number

$$m = 40000$$
.

For  $w \ge 0$  we define the function

$$f_0(x) = \begin{cases} \cos(a_{m+1}y), & 0 \leq w \leq w_{m+1}, \\ \left(1 - \zeta\left(\frac{w - w_k}{w_{k+1} - w_k}\right)\right) \cos(a_k y) + \zeta\left(\frac{w - w_k}{w_{k+1} - w_k}\right) \cos(a_{k+1}y), & w_k \leq w \leq w_{k+1}, k \geqslant m+1, \end{cases}$$
(1.2)

where  $\{a_k\}$  is the sequence of vectors constructed in Lemma 1.1. We extend  $f_0$  as even function for  $w \leq 0$ ,

$$f_0((w,y)) = f_0((-w,y)).$$

**Lemma 1.3.** The function  $f_0$  possesses the following properties:

$$f_0 \in C^{\infty}(\Pi), \qquad |f_0(x)| \leqslant 1 \quad \forall x,$$

$$\frac{\partial f_0(x)}{\partial w} = 0, \quad |\nabla_y f_0(x)| \leqslant |a_{m+1}|, \qquad \text{if} \quad |w| \leqslant w_{m+1},$$

$$|\nabla f_0(x)| \leqslant \sqrt{5k}, \quad \text{if} \quad w_k \leqslant w \leqslant w_{k+1}, \ k \geqslant m+1.$$

*Proof.* First four claims are evident. Prove the last one.

For  $w_k \leq w \leq w_{k+1}$  we have

$$\frac{\partial f_0(x)}{\partial w} = \frac{1}{w_{k+1} - w_k} \zeta' \left( \frac{w - w_k}{w_{k+1} - w_k} \right) \left( \cos(a_{k+1}y) - \cos(a_ky) \right),$$

therefore,

$$\left| \frac{\partial f_0(x)}{\partial w} \right| \leqslant \frac{4}{w_{k+1} - w_k} \leqslant \frac{64}{81\sqrt{k}}.$$

Clearly,

$$|\nabla_y f_0(x)| \le |a_{k+1}| = \sqrt{4k+5}$$

so,

$$|\nabla f_0(x)|^2 \leqslant 4k + 5 + \frac{1}{k}$$
  $\Rightarrow$   $|\nabla f_0(x)| \leqslant \sqrt{5k}$ 

if  $w_k \leqslant w \leqslant w_{k+1}, k \geqslant m+1$ .

## 1.3 Function f

For  $w \ge 0$  define the function

$$\alpha(w) = \begin{cases} w_m, & \text{if } 0 \leqslant w \leqslant w_m, \\ \left(1 - \zeta\left(\frac{w - w_m}{w_{m+1} - w_m}\right)\right) w_m + \zeta\left(\frac{w - w_m}{w_{m+1} - w_m}\right) w, & \text{if } w_m < w < w_{m+1}, \\ w, & \text{if } w \geqslant w_{m+1}, \end{cases}$$

and extend it as an even function for  $w \leq 0$ ,

$$\alpha(w) = \alpha(-w).$$

**Lemma 1.4.** The function  $\alpha$  possesses the following properties:

$$\alpha \in C^{\infty}(\mathbb{R}), \quad \alpha(w) \geqslant w_m \quad \forall \ w, \quad \alpha(w) \leqslant w \quad \text{if } w \geqslant w_m,$$

$$|\alpha'(w)| \leqslant 3, \quad |\alpha''(w)| \leqslant \frac{3}{\alpha(w)^{1/3}} \quad \forall \ w. \tag{1.3}$$

*Proof.* First three claims are evident. Inequalities (1.3) are also evident for  $|w| \leq w_m$  and for  $|w| \geq w_{m+1}$ .

For  $w_m \leqslant w \leqslant w_{m+1}$  we have

$$\alpha'(w) = \frac{w - w_m}{w_{m+1} - w_m} \zeta'\left(\frac{w - w_m}{w_{m+1} - w_m}\right) + \zeta\left(\frac{w - w_m}{w_{m+1} - w_m}\right),\tag{1.4}$$

so  $0 \le \alpha'(w) \le 3$ . Moreover,

$$\alpha''(w) = \frac{w - w_m}{\left(w_{m+1} - w_m\right)^2} \zeta''\left(\frac{w - w_m}{w_{m+1} - w_m}\right) + \frac{2}{w_{m+1} - w_m} \zeta'\left(\frac{w - w_m}{w_{m+1} - w_m}\right),$$

and by virtue of (1.1)

$$|\alpha''(w)| \leqslant \frac{9}{w_{m+1} - w_m} \leqslant \frac{16}{9\sqrt{m}} = \frac{8}{3w_m^{1/3}} \leqslant \frac{3}{w_{m+1}^{1/3}} \leqslant \frac{3}{\alpha(w)^{1/3}}.$$

### Corollary 1.5. We have

$$|\alpha(w)^{4/3} - \alpha(\tilde{w})^{4/3}| \le 4|w - \tilde{w}| \max(\alpha(w), \alpha(\tilde{w}))^{1/3}.$$

Put

$$f(x) = f_0(x) e^{-\alpha(w)^{4/3}}$$
.

**Lemma 1.6.** The function f possesses the following properties:

$$f((w,y)) = f((-w,y)), \qquad f \in C^{\infty}(\Pi), \qquad |f(x)| \le e^{-\alpha(w)^{4/3}} \ \forall \ x \in \Pi,$$

$$|\Delta f(x)| \le 40m|f(x)|$$
 if  $|w| \le w_{m+1}$ ,  $|\Delta f(x)| \le 10e^{-|w|^{4/3}}$ , if  $|w| \ge w_{m+1}$ .

*Proof.* First three claims are evident. If  $|w| \leq w_m$  then

$$f(x) = \cos(a_{m+1}y) e^{-w_m^{4/3}},$$

and

$$\Delta f(x) = -(4m+5)f(x) \qquad \Rightarrow \qquad |\Delta f(x)| \leqslant 40m|f(x)|.$$

Now, let  $w_k \leq w \leq w_{k+1}, k \geq m$ . We have

$$\left(e^{-\alpha(w)^{4/3}}\right)' = -\frac{4}{3}\alpha(w)^{1/3}\alpha'(w)e^{-\alpha(w)^{4/3}}$$

and

$$\left(e^{-\alpha(w)^{4/3}}\right)'' = \left(\frac{16}{9}\alpha^{2/3}(\alpha')^2 - \frac{4}{9}\alpha^{-2/3}(\alpha')^2 - \frac{4}{3}\alpha^{1/3}\alpha''\right)e^{-\alpha(w)^{4/3}}.$$
(1.5)

If k = m and  $w_m \leqslant w \leqslant w_{m+1}$  then

$$f(x) = \cos(a_{m+1}y) e^{-\alpha(w)^{4/3}}.$$

$$\Delta f(x) = -a_{m+1}^2 \cos(a_{m+1}y) e^{-\alpha(w)^{4/3}} + \cos(a_{m+1}y) \left(e^{-\alpha(w)^{4/3}}\right)''$$
$$= \left(\frac{16}{9}\alpha^{2/3}(\alpha')^2 - (4m+5) - \frac{4}{9}\alpha^{-2/3}(\alpha')^2 - \frac{4}{3}\alpha^{1/3}\alpha''\right) f(x).$$

Here

$$w_m \leqslant \alpha(w) \leqslant w_{m+1}, \quad 0 \leqslant \alpha'(w) \leqslant 3, \quad |\alpha''(w)| \leqslant 3\alpha(w)^{-1/3},$$

therefore,

$$|\Delta f(x)| \le 16w_{m+1}^{2/3}|f(x)| = 36(m+1)|f(x)| \le 40m|f(x)|.$$

Finally, if  $w_k \leq w \leq w_{k+1}$ ,  $k \geq m+1$ , then the formula (1.5) transforms into

$$\left(e^{-w^{4/3}}\right)'' = \left(\frac{16}{9}w^{2/3} - \frac{4}{9}w^{-2/3}\right)e^{-w^{4/3}},$$

and

$$\Delta\left(e^{-w^{4/3}}\cos(a_k y)\right) = \left(\frac{16}{9}w^{2/3} - \frac{4}{9}w^{-2/3} - a_k^2\right)e^{-w^{4/3}}\cos(a_k y).$$

Moreover,

$$\frac{16}{9} w^{2/3} \in [4k, 4k+4], \qquad a_k^2 = 4k+1,$$

so

$$\left| \Delta \left( e^{-w^{4/3}} \cos(a_k y) \right) \right| \leqslant 3e^{-w^{4/3}}.$$

In the same manner,

$$\left|\Delta\left(e^{-w^{4/3}}\cos(a_{k+1}y)\right)\right| \leqslant 6e^{-w^{4/3}}.$$

By (1.2)

$$\Delta f(x) = \left(1 - \zeta \left(\frac{w - w_k}{w_{k+1} - w_k}\right)\right) \Delta \left(e^{-w^{4/3}} \cos(a_k y)\right)$$

$$+ \zeta \left(\frac{w - w_k}{w_{k+1} - w_k}\right) \Delta \left(e^{-w^{4/3}} \cos(a_{k+1} y)\right)$$

$$+ \frac{2}{w_{k+1} - w_k} \zeta' \left(\frac{w - w_k}{w_{k+1} - w_k}\right) \left(e^{-w^{4/3}}\right)' \left(\cos(a_{k+1} y) - \cos(a_k y)\right)$$

$$+ \frac{1}{(w_{k+1} - w_k)^2} \zeta'' \left(\frac{w - w_k}{w_{k+1} - w_k}\right) e^{-w^{4/3}} \left(\cos(a_{k+1} y) - \cos(a_k y)\right).$$

Therefore,

$$|\Delta f(x)| \leqslant 6e^{-w^{4/3}} + \frac{8}{w_{k+1} - w_k} \cdot \frac{4}{3} w^{1/3} e^{-w^{4/3}} + \frac{10}{(w_{k+1} - w_k)^2} e^{-w^{4/3}}$$

$$\leqslant \left(6 + \frac{256\sqrt{k+1}}{81\sqrt{k}} + \frac{2560}{6561k}\right) e^{-w^{4/3}} \leqslant 10e^{-w^{4/3}}.$$

Corollary 1.7. For all  $x \in \Pi$ 

$$|\Delta f(x)| \leqslant 40me^{-\alpha(w)^{4/3}}.$$

## **2** Domain $\Omega$

Denote

$$h = 10^{-8} (2.1)$$

and introduce the set

$$\Omega = \{ x \in \Pi : |f_0(x)| < 2h \}.$$

# 2.1 The boundary of $\Omega$

**Lemma 2.1.** If  $|f_0(x)| = 2h$  then  $\nabla f_0(x) \neq 0$ .

*Proof.* It is sufficient to consider  $w \ge 0$  only.

For  $0 \leq w \leq w_{m+1}$  we have

$$f_0(x) = \cos(a_{m+1}y), \qquad \nabla_y f_0(x) = -\sin(a_{m+1}y) a_{m+1},$$

so if  $|\cos(a_{m+1}y)| = 2h$  then  $\nabla_y f_0(x) \neq 0$ .

The same argument works for the case  $x = (w_k, y)$ .

Now, consider the case  $w_k < w < w_{k+1}, k \ge m+1$ . Due to (1.2)

$$\frac{\partial f_0(x)}{\partial w} = \frac{1}{w_{k+1} - w_k} \zeta' \left( \frac{w - w_k}{w_{k+1} - w_k} \right) \left( \cos(a_{k+1}y) - \cos(a_ky) \right),$$

$$\nabla_y f_0(x) = -\left(1 - \zeta \left(\frac{w - w_k}{w_{k+1} - w_k}\right)\right) \sin(a_k y) \, a_k - \zeta \left(\frac{w - w_k}{w_{k+1} - w_k}\right) \sin(a_{k+1} y) \, a_{k+1}.$$

Now, assume that  $\nabla f_0(x) = 0$ . The vectors  $a_k$  and  $a_{k+1}$  are linearly independent, so by virtue of (1.1) we obtain

$$\begin{cases}
\cos(a_{k+1}y) - \cos(a_ky) = 0, \\
\sin(a_ky) = 0, \\
\sin(a_{k+1}y) = 0.
\end{cases}$$

This implies

$$f_0(x) = \cos(a_k y) = \pm 1.$$

Thus,  $|f_0(x)| \neq 2h$ , a contradiction.

Corollary 2.2. The boundary  $\partial \Omega$  is  $C^{\infty}$ -smooth.

## 2.2 "Sparcity" of $\Omega$

**Lemma 2.3.** For  $0 \le \eta \le 1$  and  $\sigma \in \mathbb{R}$  denote

$$A_{\sigma} := \{ \theta \in [0, \pi] : \cos \theta \in [\sigma - \eta, \sigma] \}.$$

Then  $\operatorname{mes}_1 A_{\sigma} \leqslant 2\sqrt{\eta}$ .

*Proof.* Without loss of generality one can assume  $\sigma \leq 1$ . Moreover,

$$A_{\eta-\sigma} = \left\{ \pi - \theta : \theta \in A_{\sigma} \right\},\,$$

therefore  $\operatorname{mes}_1 A_{\eta-\sigma} = \operatorname{mes}_1 A_{\sigma}$ . So, one can assume that  $\sigma \geqslant \eta/2$ . Then we have

$$\operatorname{mes}_1 A_{\sigma} = \arccos(\sigma - \eta) - \arccos\sigma,$$

$$\frac{d(\operatorname{mes}_1 A_{\sigma})}{d\sigma} = \frac{1}{\sqrt{1 - \sigma^2}} - \frac{1}{\sqrt{1 - (\sigma - \eta)^2}} \geqslant 0 \quad \text{for} \quad \frac{\eta}{2} \leqslant \sigma \leqslant 1.$$

Thus,

$$\operatorname{mes}_1 A_{\sigma} \leqslant \operatorname{mes}_1 A_1 = \arccos(1 - \eta) \leqslant 2\sqrt{\eta}$$

because the function

$$\varphi(\eta) := 2\sqrt{\eta} - \arccos(1-\eta)$$

increases on [0,1] and  $\varphi(0)=0$ .

Corollary 2.4. Let  $0 \leq \eta \leq 1$ ,  $\sigma \in \mathbb{R}$ .

a) We have

$$\operatorname{mes}_1 \{ \theta \in [-\pi, \pi] : \cos \theta \in [\sigma - \eta, \sigma] \} \leqslant 4\sqrt{\eta}$$

b) Let  $\alpha \in \mathbb{R}$ . Then

$$\operatorname{mes}_1 \{ \theta \in [\alpha - \pi, \alpha + \pi] : \cos \theta \in [\sigma - \eta, \sigma] \} \leqslant 4\sqrt{\eta}.$$

c) Let  $\mu > 0$ ,  $\alpha \in \mathbb{R}$ . Then

$$\operatorname{mes}_1 \left\{ \tau \in \left[ -\frac{\pi}{\mu}, \frac{\pi}{\mu} \right] : \cos(\alpha + \mu \tau) \in [\sigma - \eta, \sigma] \right\} \leqslant \frac{4\sqrt{\eta}}{\mu}.$$

d) Let  $\mu \geqslant \pi$ , A > 0. Then

$$\operatorname{mes}_1 \left\{ \tau \in [-A, A] : \cos(\alpha + \mu \tau) \in [\sigma - \eta, \sigma] \right\} \leqslant \frac{4(A+1)\sqrt{\eta}}{\pi}.$$

*Proof.* a) Follows from the evenness of cosine.

- b) Follows from the periodicity of cosine.
- c) The change of variables  $\theta = \alpha + \mu \tau$  transforms the set

$$\left\{ \tau \in \left[ -\frac{\pi}{\mu}, \frac{\pi}{\mu} \right] : \cos(\alpha + \mu \tau) \in [\sigma - \eta, \sigma] \right\}$$

into the set

$$\{\theta \in [\alpha - \pi, \alpha + \pi] : \cos \theta \in [\sigma - \eta, \sigma]\}.$$

d) After the same change of variables  $\theta = \alpha + \mu \tau$  we have to consider the set

$$\{\theta \in [\alpha - \mu A, \alpha + \mu A] : \cos \theta \in [\sigma - \eta, \sigma]\}$$
.

We cover the interval  $\left[\alpha - \mu A, \alpha + \mu A\right]$  by  $\left(\left[\frac{\mu A}{\pi}\right] + 1\right)$  intervals of length  $2\pi$ . Then by the claim of the point b)

$$\operatorname{mes}_1 \left\{ \tau \in [-A, A] : \cos(\alpha + \mu \tau) \in [\sigma - \eta, \sigma] \right\} \leqslant \left( \left\lceil \frac{\mu A}{\pi} \right\rceil + 1 \right) \frac{4\sqrt{\eta}}{\mu}.$$

By assumption  $\mu \geqslant \pi$ , so

$$\left\lceil \frac{\mu A}{\pi} \right\rceil + 1 \leqslant \frac{\mu (A+1)}{\pi}.$$

Therefore,

$$\left( \left[ \frac{\mu A}{\pi} \right] + 1 \right) \frac{4\sqrt{\eta}}{\mu} \leqslant \frac{4(A+1)\sqrt{\eta}}{\pi}.$$

**Lemma 2.5.** *a) Let* 

$$y_* \in \mathbb{T}^3$$
,  $0 \leqslant w \leqslant w_{m+1}$  and  $0 < R \leqslant \frac{\pi}{\sqrt{4m+5}}$ .

Then

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : |y - y_{*}| \leqslant R, (w, y) \in \Omega \right\} \leqslant \frac{8\sqrt{h}}{\sqrt{4m + 5}} \pi R^{2}.$$

b) Let

$$y_* \in \mathbb{T}^3$$
,  $w_k \leqslant w \leqslant w_{k+1}$ ,  $k \geqslant m+1$  and  $0 < R \leqslant \frac{\pi}{\sqrt{4k+5}}$ .

Then

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : |y - y_{*}| \leqslant R, (w, y) \in \Omega \right\} \leqslant \frac{8\sqrt{3h}}{\sqrt{4k+1}} \pi R^{2}.$$

*Proof.* a) We consider the set of  $y \in \mathbb{T}^3$  such that  $|y - y_*| \leq R$  and  $|\cos(a_{m+1}y)| \leq 2h$ . Clearly,

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : |y - y_{*}| \leqslant R, |\cos(a_{m+1}y)| \leqslant 2h \right\}$$
  
$$\leqslant \pi R^{2} \operatorname{mes}_{1} \left\{ \tau \in [-R, R] : |\cos(y_{*}a_{m+1} + |a_{m+1}|\tau)| \leqslant 2h \right\} \leqslant \frac{8\sqrt{h}}{\sqrt{4m+5}} \pi R^{2}$$

due to Corollary 2.4 c) with  $\eta = 4h$ ,  $\alpha = y_* a_{m+1}$  and  $\mu = |a_{m+1}|$ .

b) We have either

$$\zeta\left(\frac{w-w_k}{w_{k+1}-w_k}\right) \geqslant \frac{1}{2},\tag{2.2}$$

or

$$1 - \zeta \left( \frac{w - w_k}{w_{k+1} - w_k} \right) \geqslant \frac{1}{2}. \tag{2.3}$$

First, assume (2.3). Denote by  $e_k$  the unit vector that belongs to the plane generated by the vectors  $a_k$  and  $a_{k+1}$ , and such that  $a_{k+1} \cdot e_k = 0$  and  $a_k \cdot e_k \ge 0$ . Then

$$a_k \cdot e_k = |a_k| |\sin \alpha_k| \geqslant \sqrt{\frac{2}{3}} |a_k| \tag{2.4}$$

by virtue of Corollary 1.2. Introduce the set

$$Q_R := \{ y = y_* + z + \tau e_k : z \perp e_k, |z| \leqslant R, |\tau| \leqslant R \}.$$

We have

$$\left\{ y \in \mathbb{T}^3 : |y - y_*| \leqslant R \right\} \subset Q_{R^*}$$

If  $y = y_* + z + \tau e_k$  and  $(w, y) \in \Omega$  then

$$|f_0(w,y)| = \left| \left( 1 - \zeta \left( \frac{w - w_k}{w_{k+1} - w_k} \right) \right) \cos(a_k(y_* + z + \tau e_k)) + \zeta \left( \frac{w - w_k}{w_{k+1} - w_k} \right) \cos(a_{k+1}(y_* + z)) \right| \le 2h.$$

Taking into account (2.3) we obtain

$$\left| \cos \left( a_k (y_* + z) + \tau a_k \cdot e_k \right) \right) + \frac{\zeta \left( \frac{w - w_k}{w_{k+1} - w_k} \right)}{1 - \zeta \left( \frac{w - w_k}{w_{k+1} - w_k} \right)} \cos(a_{k+1} (y_* + z)) \right| \leqslant 4h. \tag{2.5}$$

Now we apply Corollary 2.4 c) with

$$\eta = 8h$$
,  $\alpha = a_k(y_* + z)$ ,  $\mu = a_k \cdot e_k \in \left[\sqrt{\frac{2}{3}} |a_k|, |a_k|\right]$ ,

where the last inclusion is due to (2.4). Taking into account the assumption

$$R \leqslant \frac{\pi}{\sqrt{4k+5}} < \frac{\pi}{\mu},$$

we get that for any fixed vector z

$$\operatorname{mes}_1 \left\{ \tau \in [-R, R] : \text{the estimate (2.5) holds} \right\} \leqslant \frac{4\sqrt{\eta}}{\mu} \leqslant \frac{8\sqrt{3h}}{\sqrt{4k+1}}$$

Therefore,

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : |y - y_{*}| \leqslant R, (w, y) \in \Omega \right\}$$

$$\leqslant \operatorname{mes}_{3} \left\{ y \in Q_{R} : (w, y) \in \Omega \right\} \leqslant \pi R^{2} \frac{8\sqrt{3h}}{\sqrt{4k + 1}}.$$

$$(2.6)$$

In the same way, if (2.2) holds true then the estimate (2.6) is also fulfilled.

Corollary 2.6. Let  $x_* = (w_*, y_*)$ .

a) If 
$$0 \leqslant w_* \leqslant w_{m+1}$$
 and  $0 < R_* \leqslant \frac{\pi}{\sqrt{4m+9}}$  then

$$\operatorname{mes}_4(B_R(x_*) \cap \Omega) \leqslant \frac{16\sqrt{3h}}{\sqrt{4m+5}} \pi R^3.$$

b) If 
$$w_k \leqslant w_* \leqslant w_{k+1}$$
,  $k \geqslant m+1$  and  $0 < R \leqslant \frac{\pi}{\sqrt{4k+9}}$  then

$$\operatorname{mes}_4(B_R(x_*) \cap \Omega) \leqslant \frac{16\sqrt{3h}}{\sqrt{4k-3}} \pi R^3.$$

*Proof.* a) If  $|w - w_*| < R$  then  $|w| \le w_{m+2}$ . For such w we have

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : |y - y_{*}| \leqslant R, (w, y) \in \Omega \right\} \leqslant \frac{8\sqrt{3h}}{\sqrt{4m + 5}} \pi R^{2}.$$

Therefore,

$$\operatorname{mes}_4(B_R(x_*) \cap \Omega) \leqslant \frac{16\sqrt{3h}}{\sqrt{4m+5}} \pi R^3.$$

b) If  $|w - w_*| < R$  then  $w_{k-1} \le w \le w_{k+2}$ ,

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : |y - y_{*}| \leq R, (w, y) \in \Omega \right\} \leq \frac{8\sqrt{3h}}{\sqrt{4k - 3}} \pi R^{2}.$$

Therefore,

$$\operatorname{mes}_4(B_R(x_*) \cap \Omega) \leqslant \frac{16\sqrt{3h}}{\sqrt{4k-3}} \pi R^3.$$

**Corollary 2.7.** Assume that either the conditions of Corollary 2.6 a) are fulfilled and  $R \geqslant \frac{64\sqrt{3h}}{\pi\sqrt{4m+5}}$ , or the conditions of Corollary 2.6 b) are fulfilled and  $R \geqslant \frac{64\sqrt{3h}}{\pi\sqrt{4k-3}}$ . Then

$$\operatorname{mes}_4(B_R(x_*) \cap \Omega) \leqslant \frac{1}{2} \operatorname{mes}_4 B_R.$$

**Lemma 2.8.** For any  $w \in \mathbb{R}$ 

$$\operatorname{mes}_3 \left\{ y \in \mathbb{T}^3 : (w, y) \in \Omega \right\} \leqslant \pi^3.$$

*Proof.* If  $|w| \leq w_{m+1}$  then

$$\{y \in \mathbb{T}^3 : (w, y) \in \Omega\} = \{y \in \mathbb{T}^3 : |\cos(a_{m+1}y)| < 2h\}.$$

We have

$$diam[-\pi, \pi]^3 = 2\pi\sqrt{3},$$

therefore,

$$[-\pi, \pi]^3 \subset \left\{ y = z + \tau \frac{a_{m+1}}{|a_{m+1}|} : z \perp a_{m+1}, |z| \leqslant \pi \sqrt{3}, |\tau| \leqslant \pi \sqrt{3} \right\}.$$

By virtue of Corollary 2.4 d) with

$$A = \pi \sqrt{3}, \quad \alpha = 0, \quad \mu = |a_{m+1}|, \quad \eta = 4h$$

we have

$$\operatorname{mes}_1 \left\{ \tau \in [-\pi\sqrt{3}, \pi\sqrt{3}] : |\cos(\tau | a_{m+1}|)| \leqslant 2h \right\} \leqslant \frac{8(\pi\sqrt{3}+1)\sqrt{h}}{\pi}.$$

Therefore,

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : \left| \cos \left( a_{m+1} y \right) \right| < 2h \right\} \leqslant 24\pi^{2} (\pi \sqrt{3} + 1) \sqrt{h} < \pi^{3}$$

due to (2.1).

Now, let  $w_k \leq w \leq w_{k+1}$ ,  $k \geq m+1$ . First, assume (2.3) to be fulfilled. Fix the vector  $e_k$  as in the proof of Lemma 2.5. Then

$$[-\pi,\pi]^3 \subset \left\{ y = z + \tau e_k : z \perp e_k, |z| \leqslant \pi\sqrt{3}, |\tau| \leqslant \pi\sqrt{3} \right\}.$$

If  $(w, y) \in \Omega$  then  $|f_0(x)| \leq 2h$  and the inequality (2.5) holds true with  $y_* = 0$ . Now we apply Corollary 2.4 d) with

$$A = \pi\sqrt{3}, \quad \eta = 8h, \quad \alpha = a_k \cdot z, \quad \mu = a_k \cdot e_k \in \left[\sqrt{\frac{2}{3}} |a_k|, |a_k|\right].$$

We obtain that for any fixed vector z

$$\operatorname{mes}_1\left\{\tau\in[-\pi\sqrt{3},\pi\sqrt{3}]: \text{ the estimate (2.5) holds}\right\}\leqslant\frac{4\left(\pi\sqrt{3}+1\right)\sqrt{8h}}{\pi}<32\sqrt{h}.$$

The same is true if the inequality (2.2) is fulfilled. Therefore,

$$\operatorname{mes}_{3} \left\{ y \in \mathbb{T}^{3} : (w, y) \in \Omega \right\}$$

$$\leqslant \operatorname{mes}_{3} \left\{ y = z + \tau e_{k} : z \perp e_{k}, |z| \leqslant \pi \sqrt{3}, |\tau| \leqslant \pi \sqrt{3}, (w, y) \in \Omega \right\}$$

$$\leqslant \pi (\pi \sqrt{3})^{2} \cdot 32\sqrt{h} < \pi^{3}$$

by definition (2.1) of the number h.

# 3 Auxiliary facts

**Lemma 3.1.** If  $\mathcal{O}$  is an open subset of  $\mathbb{T}^3$  and  $\operatorname{mes}_3 \mathcal{O} \leqslant \pi^3$  then

$$||u||_{L_2(\mathcal{O})}^2 \leqslant \frac{15}{7} ||\nabla u||_{L_2(\mathcal{O})}^2 \quad \forall \ u \in \mathring{W}_2^1(\mathcal{O}).$$

*Proof.* It is sufficient to prove that

$$||u||_{L_2(\mathbb{T}^3)}^2 \leqslant \frac{15}{7} ||\nabla u||_{L_2(\mathbb{T}^3)}^2$$

for all  $u \in W_2^1(\mathbb{T}^3)$  such that

$$\operatorname{mes}_3 \{ y \in \mathbb{T}^3 : u(y) = 0 \} \geqslant 7\pi^3.$$

Represent a function u as a sum

$$u(y) = u_0 + v(y),$$

where  $u_0$  is a constant, and  $\int_{\mathbb{T}^3} v(y) dy = 0$ . Then

$$||u||_{L_2(\mathbb{T}^3)}^2 = 8\pi^3 |u_0|^2 + ||v||_{L_2(\mathbb{T}^3)}^2, \qquad ||v||_{L_2(\mathbb{T}^3)}^2 \geqslant 7\pi^3 |u_0|^2,$$

and

$$||u||_{L_2(\mathbb{T}^3)}^2 \leqslant \frac{15}{7} ||v||_{L_2(\mathbb{T}^3)}^2. \tag{3.1}$$

Expanding the function v into the Fourier series we see that

$$||v||_{L_2(\mathbb{T}^3)}^2 \leqslant ||\nabla v||_{L_2(\mathbb{T}^3)}^2 = ||\nabla u||_{L_2(\mathbb{T}^3)}^2.$$

The reference to (3.1) completes the proof.

**Lemma 3.2** (Friedrichs' inequality for  $\Omega$ ). We have

$$\int_{\Omega} |u(x)|^2 dx \leqslant \frac{15}{7} \int_{\Omega} |\nabla_y u(x)|^2 dx \qquad \forall \ u \in \mathring{W}_2^1(\Omega).$$

*Proof.* Follows from Lemma 2.8 and Lemma 3.1. ■

**Theorem 3.3** ([3], §5.7.1, Lemma 1). Let  $\mathcal{O} \subset \mathbb{R}^n$  be a domain with smooth boundary,  $\eta \in C_0^1(\mathbb{R}^n, \mathbb{R}^n)$ ,  $x_0 \in \mathcal{O}$ . Then for almost all  $r \in (0, \infty)$ 

$$\int_{\mathcal{O}\cap B_r(x_0)} \operatorname{div} \eta \, dx = \int_{\partial \mathcal{O}\cap B_r(x_0)} \eta \cdot \nu \, dS(x) + \int_{\mathcal{O}\cap \partial B_r(x_0)} \eta \cdot \nu \, dS(x).$$

Here  $\nu(x)$  is the vector of outward unit normal at the point x to  $\partial \mathcal{O}$  in the first integral and to  $\partial B_r(x_0)$  in the second integral in the right hand side.

**Remark 3.4.** The same is true for functions  $\eta \in C^1(\overline{\mathcal{O}}, \mathbb{R}^n)$  because we can extend such functions to the entire space  $\mathbb{R}^n$  via the smooth boundary  $\partial \mathcal{O}$ .

Corollary 3.5 (Green's identities). Let

$$\mathcal{O} \subset \mathbb{R}^n$$
,  $\partial \mathcal{O} \in C^{\infty}$ ,  $x_0 \in \mathcal{O}$ ,  $u, v \in C^2(\overline{\mathcal{O}})$ .

For almost all  $r \in (0, \infty)$  we have

$$\int_{\mathcal{O}\cap B_r(x_0)} \Delta v(x) \, dx = \int_{\partial \mathcal{O}\cap B_r(x_0)} \frac{\partial v}{\partial \nu} \, dS(x) + \int_{\mathcal{O}\cap \partial B_r(x_0)} \frac{\partial v}{\partial \nu} \, dS(x), \tag{3.2}$$

and

$$\int_{\mathcal{O} \cap B_r(x_0)} \left( u \, \Delta v - v \, \Delta u \right) \, dx \qquad (3.3)$$

$$= \int_{\partial \mathcal{O} \cap B_r(x_0)} \left( u \, \frac{\partial v}{\partial \nu} - v \, \frac{\partial u}{\partial \nu} \right) dS(x) + \int_{\mathcal{O} \cap \partial B_r(x_0)} \left( u \, \frac{\partial v}{\partial \nu} - v \, \frac{\partial u}{\partial \nu} \right) dS(x).$$

Recall that in four-dimensional case the Green function for the Laplace operator is

$$\frac{1}{4\pi^2|x-x_0|^2};$$

on the boundary  $\partial B_r(x_0)$  we have

$$\frac{\partial}{\partial \nu} \frac{1}{4\pi^2 |x - x_0|^2} = \frac{-1}{2\pi^2 |x - x_0|^3}.$$

Corollary 3.6. Let

$$n = 4$$
,  $\mathcal{O} \subset \mathbb{R}^4$ ,  $\partial \mathcal{O} \in C^{\infty}$ ,  $x_0 \in \mathcal{O}$ ,  $v \in C^2(\overline{\mathcal{O}})$ .

Then for almost all  $r \in (0, \infty)$ 

$$v(x_0) = -\int_{\mathcal{O}\cap B_r(x_0)} \frac{\Delta v(x) \, dx}{4\pi^2 |x - x_0|^2}$$

$$+ \int_{\partial \mathcal{O}\cap B_r(x_0)} \left( \frac{\partial v(x)}{\partial \nu} \frac{1}{4\pi^2 |x - x_0|^2} - v(x) \frac{\partial}{\partial \nu(x)} \frac{1}{4\pi^2 |x - x_0|^2} \right) dS(x)$$

$$+ \frac{1}{4\pi^2 r^2} \int_{\mathcal{O}\cap \partial B_r(x_0)} \frac{\partial v(x)}{\partial \nu} \, dS(x) + \frac{1}{2\pi^2 r^3} \int_{\mathcal{O}\cap \partial B_r(x_0)} v(x) \, dS(x).$$

# 4 Dirichlet problem in $\Omega$

### 4.1 Functional J

Let  $\varphi \in L_2(\Omega)$ . We consider the functional

$$J[v] = \int_{\Omega} \left( \frac{|\nabla v|^2}{2} - \varphi \, v \right) dx, \qquad v \in \mathring{W}_{2}^{1}(\Omega). \tag{4.1}$$

By Lemma 3.2 we have

$$\left| \int_{\Omega} \varphi \, v \, dx \right| \leqslant \|v\|_{L_2(\Omega)} \|\varphi\|_{L_2(\Omega)} \leqslant \sqrt{\frac{15}{7}} \|\nabla v\|_{L_2(\Omega)} \|\varphi\|_{L_2(\Omega)},$$

and therefore, the functional J is semi-bounded from below,

$$J[v] \geqslant \frac{1}{4} \|\nabla v\|_{L_2(\Omega)}^2 - \frac{15}{7} \|\varphi\|_{L_2(\Omega)}^2.$$

In a standard way we have the following

**Theorem 4.1.** Let the functional J be defined by (4.1) with  $\varphi \in L_2(\Omega)$ .

- a) Functional J attains its minimum on  $\mathring{W}_{2}^{1}(\Omega)$ .
- b) The Dirichlet problem

$$\begin{cases}
-\Delta u(x) = \varphi(x) & \text{in } \Omega, \\
u|_{\partial\Omega} = 0,
\end{cases}$$
(4.2)

has a unique solution  $u \in \mathring{W}_{2}^{1}(\Omega)$ .

c) This function u is a minimizer of the functional J. The minimizer is unique.

#### Remark 4.2. Under the conditions of Theorem 4.1

$$||u||_{W_2^1(\Omega)} \le 3||\varphi||_{L_2(\Omega)}.$$
 (4.3)

Indeed,

$$\|\nabla u\|_{L_2(\Omega)}^2 = \int_{\Omega} u \,\varphi \, dx \leqslant \|u\|_{L_2(\Omega)} \|\varphi\|_{L_2(\Omega)}.$$

By virtue of Lemma 3.2  $||u||_{L_2(\Omega)} \leq \sqrt{\frac{15}{7}} ||\nabla u||_{L_2(\Omega)}$ , therefore,

$$\|\nabla u\|_{L_{2}(\Omega)} \leqslant \sqrt{\frac{15}{7}} \|\varphi\|_{L_{2}(\Omega)},$$

$$\|u\|_{L_{2}(\Omega)} \leqslant \frac{15}{7} \|\varphi\|_{L_{2}(\Omega)},$$
(4.4)

and so

$$\|\nabla u\|_{L_2(\Omega)}^2 + \|u\|_{L_2(\Omega)}^2 \leqslant \left(\frac{15}{7} + \frac{225}{49}\right) \|\varphi\|_{L_2(\Omega)}^2 \leqslant 9\|\varphi\|_{L_2(\Omega)}^2.$$

**Lemma 4.3.** If under the assumptions of Theorem 4.1  $\varphi(x) \ge 0$  a.e. in  $\Omega$ , then  $u(x) \ge 0$  a.e. in  $\Omega$ .

*Proof.* The function u is the minimizer of J. Consider the function

$$u_+(x) = \max(u(x), 0).$$

It is well known that  $u_+ \in \mathring{W}_2^1(\Omega)$  and

$$\nabla u_+(x) = \begin{cases} \nabla u(x), & \text{if } u(x) > 0, \\ 0, & \text{if } u(x) \le 0. \end{cases}$$

Therefore,

$$J[u_+] = \int_{\Omega} \left( \frac{|\nabla u_+|^2}{2} - \varphi \, u_+ \right) dx \leqslant J[u]$$

due to the assumption  $\varphi \geqslant 0$ . Thus, the function  $u_+$  is also a minimizer for the functional J. Therefore,  $u_+ = u$ .

### 4.2 Dirichlet problem in $\Omega$

**Lemma 4.4.** Let u be the solution to the problem (4.2) with  $\varphi \in L_2(\Omega) \cap C^{\gamma}(\overline{\Omega})$ ,  $\gamma > 0$ . Then  $u \in C^{2+\gamma}(\overline{\Omega})$ .

**Lemma 4.5.** Let  $\varphi \in L_2(\Omega) \cap C^{\gamma}(\overline{\Omega})$ ,  $\gamma > 0$ , and  $\varphi(x) \geqslant 0$  for all  $x \in \Omega$ . Let  $u \in \mathring{W}_2^1(\Omega)$  be the solution to the Dirichlet problem (4.2). Let  $x_0 = (w_0, y_0)$ . Then for almost all  $r \in (0, 1]$  we have

$$u(x_0) \leqslant \int_{\Omega \cap B_r(x_0)} \frac{\varphi(x) \, dx}{4\pi^2 |x - x_0|^2} + \frac{1}{2\pi^2 r^3} \int_{\Omega \cap \partial B_r(x_0)} u(x) \, dS(x). \tag{4.5}$$

*Proof.* By Lemma 4.4  $u \in C^2(\overline{\Omega})$ . Now we use the identity (3.2) and Corollary 3.6. For almost all r > 0

$$0 = \int_{\Omega \cap B_r(x_0)} \varphi(x) \, dx + \int_{\partial \Omega \cap B_r(x_0)} \frac{\partial u}{\partial \nu} \, dS(x) + \int_{\Omega \cap \partial B_r(x_0)} \frac{\partial u}{\partial \nu} \, dS(x), \tag{4.6}$$

and

$$u(x_0) = \int_{\Omega \cap B_r(x_0)} \frac{\varphi(x) dx}{4\pi^2 |x - x_0|^2} + \int_{\partial \Omega \cap B_r(x_0)} \frac{\partial u(x)}{\partial \nu} \frac{1}{4\pi^2 |x - x_0|^2} dS(x) + \frac{1}{4\pi^2 r^2} \int_{\Omega \cap \partial B_r(x_0)} \frac{\partial u(x)}{\partial \nu} dS(x) + \frac{1}{2\pi^2 r^3} \int_{\Omega \cap \partial B_r(x_0)} u(x) dS(x),$$
(4.7)

where we used the boundary condition  $u|_{\partial\Omega}=0$ . Multiplying (4.6) by  $\frac{1}{4\pi^2r^2}$  and substracting from (4.7) we obtain

$$u(x_0) = \int_{\Omega \cap B_r(x_0)} \frac{\varphi(x)}{4\pi^2} \left( \frac{1}{|x - x_0|^2} - \frac{1}{r^2} \right) dx$$

$$+ \int_{\partial \Omega \cap B_r(x_0)} \frac{\partial u(x)}{\partial \nu} \frac{1}{4\pi^2} \left( \frac{1}{|x - x_0|^2} - \frac{1}{r^2} \right) dS(x) + \frac{1}{2\pi^2 r^3} \int_{\Omega \cap \partial B_r(x_0)} u(x) dS(x).$$
(4.8)

The first term in the right hand side is not greater than  $\int_{\Omega \cap B_r(x_0)} \frac{\varphi(x) dx}{4\pi^2 |x-x_0|^2}$ . By virtue of Lemma 4.3  $u(x) \geqslant 0$  in  $\Omega$ . Therefore,  $\frac{\partial u}{\partial \nu}|_{\partial \Omega} \leqslant 0$ , and the second term in the right hand side is non-positive, as  $|x-x_0|^2 \leqslant r^2$  for  $x \in B_r(x_0)$ . Now, (4.5) follows from (4.8).

Corollary 4.6. Let  $\varphi \in L_2(\Omega) \cap C^{\gamma}(\overline{\Omega})$ ,  $\gamma > 0$ , and  $\varphi(x) \geqslant 0$  for all  $x \in \Omega$ . Let  $u \in \mathring{W}_2^1(\Omega)$  be the solution to the Dirichlet problem (4.2). Let  $x_0 = (w_0, y_0)$ ,  $0 < R \leqslant 1$ . Then

$$u(x_0) \leqslant \int_{\Omega \cap B_R(x_0)} \frac{\varphi(x) \, dx}{4\pi^2 |x - x_0|^2} + \frac{2}{\pi^2 R^4} \int_{\Omega \cap B_R(x_0)} u(x) \, dx.$$

*Proof.* For almost all  $r \in (0, R)$  we have

$$2\pi^2 r^3 u(x_0) \leqslant 2\pi^2 r^3 \int_{\Omega \cap B_P(x_0)} \frac{\varphi(x) \, dx}{4\pi^2 |x - x_0|^2} + \int_{\Omega \cap \partial B_P(x_0)} u(x) \, dS(x).$$

Integrating this inequality with respect to r from 0 to R we get

$$\frac{\pi^2 R^4}{2} u(x_0) \leqslant \frac{\pi^2 R^4}{2} \int_{\Omega \cap B_R(x_0)} \frac{\varphi(x) \, dx}{4\pi^2 |x - x_0|^2} + \int_{\Omega \cap B_R(x_0)} u(x) \, dx. \qquad \blacksquare$$

### **Lemma 4.7.** *Let*

$$\varphi \in L_2(\Omega) \cap L_\infty(\Omega) \cap C^\gamma(\overline{\Omega}), \quad \gamma > 0, \quad and \quad \varphi(x) \geqslant 0 \quad \forall \ x \in \Omega.$$

Let  $u \in \mathring{W}_{2}^{1}(\Omega)$  be the solution to the Dirichlet problem (4.2). Then  $u \in L_{\infty}(\Omega)$  and

$$||u||_{L_{\infty}(\Omega)} \leqslant \frac{1}{4} ||\varphi||_{L_{\infty}(\Omega)} + ||\varphi||_{L_{2}(\Omega)}.$$

*Proof.* Let  $x_0 = (w_0, y_0) \in \Omega$ . By Corollary 4.6 with R = 1 we have

$$u(x_0) \leqslant \int_{\Omega \cap B_1(x_0)} \frac{\varphi(x) \, dx}{4\pi^2 |x - x_0|^2} + \frac{2}{\pi^2} \int_{\Omega \cap B_1(x_0)} u(x) \, dx. \tag{4.9}$$

The first term in the right hand side of (4.9) is not greater than

$$\int_{\Omega \cap B_1(x_0)} \frac{\varphi(x) \, dx}{4\pi^2 |x - x_0|^2} \leqslant \frac{\|\varphi\|_{L_{\infty}(\Omega)}}{4\pi^2} \int_{B_1(x_0)} \frac{dx}{|x - x_0|^2} = \frac{\|\varphi\|_{L_{\infty}(\Omega)}}{4}.$$

For the second term in the right hand side of (4.9) we have due to (4.4)

$$\frac{2}{\pi^2} \int_{\Omega \cap B_1(x_0)} u(x) \, dx \leqslant \frac{2}{\pi^2} \left( \frac{\pi^2}{2} \right)^{1/2} \|u\|_{L_2(\Omega \cap B_1(x_0))} \leqslant \frac{\sqrt{2}}{\pi} \cdot \frac{15}{7} \|\varphi\|_{L_2(\Omega)} \leqslant \|\varphi\|_{L_2(\Omega)}.$$

Thus,

$$0 \leqslant u(x_0) \leqslant \frac{1}{4} \|\varphi\|_{L_{\infty}(\Omega)} + \|\varphi\|_{L_2(\Omega)}. \quad \blacksquare$$

### Dirichlet problem in $\Omega$ with exponentially decaying 5 RHS

Introduce the following notations

$$R(w) = \begin{cases} 50\sqrt{h} \, w_m^{-1/3}, & \text{if } |w| < w_m, \\ 50\sqrt{h} \, |w|^{-1/3}, & \text{if } |w| \geqslant w_m, \end{cases} \qquad B(x) := B_{R(w)}(x), \quad x = (w, y).$$

**Lemma 5.1.** For all  $w \ge 0$  we have

$$R(w - R(w)) \leqslant \frac{10}{9} R(w)$$

and

$$\alpha(w)^{4/3} - \alpha (w - R(w))^{4/3} \le 200\sqrt{h}.$$
 (5.1)

Proof. If  $0 \le w \le w_m$  then R(w - R(w)) = R(w). If  $w \ge w_m$  then  $w - R(w) \ge \left(\frac{9}{10}\right)^3 w$ , and therefore,

$$R(w - R(w)) \le \frac{50\sqrt{h}}{(w - R(w))^{1/3}} \le \frac{500\sqrt{h}}{9w^{1/3}} = \frac{10}{9}R(w).$$

For the second inequality we have due to Corollary 1.5

$$\alpha(w)^{4/3} - \alpha (w - R(w))^{4/3} \le 4 \alpha(w)^{1/3} R(w) \le 200 \sqrt{h}$$
.

Assume that a given smooth function  $\varphi$  in  $\Omega$  satisfies the inequality

$$0 \leqslant \varphi(x) \leqslant 10 \, e^{-\alpha(w)^{4/3}}.\tag{5.2}$$

**Lemma 5.2.** If a function  $\varphi$  satisfies (5.2) then the function

$$\Phi(x) = \int_{\Omega \cap B(x)} \frac{\varphi(\tilde{x}) d\tilde{x}}{4\pi^2 |x - \tilde{x}|^2}$$
(5.3)

satisfies the estimate

$$\Phi(x) \leqslant 3R(w)^2 e^{-\alpha(w)^{4/3}}$$
.

*Proof.* It is enough to prove the estimate for  $w \ge 0$ . By assumption

$$\Phi(x) \leqslant 10 e^{-\alpha(w - R(w))^{4/3}} \int_{B(x)} \frac{d\tilde{x}}{4\pi^2 |x - \tilde{x}|^2}.$$

We have also

$$\int_{B(x)} \frac{d\tilde{x}}{4\pi^2|x-\tilde{x}|^2} = \frac{R(w)^2}{4}.$$

Finally, by virtue of the preceding Lemma

$$e^{-\alpha(w-R(w))^{4/3}} \le e^{200\sqrt{h}}e^{-\alpha(w)^{4/3}}$$

The claim follows.

Let the function  $\Phi$  be defined by (5.3) with  $\varphi$  satisfying (5.2). In the space  $L_{\infty}(\Omega)$  we consider the map T defined by the formula

$$(T\rho)(x) = \Phi(x) + \frac{2}{\pi^2 R(w)^4} \int_{\Omega \cap B(x)} \rho(\tilde{x}) d\tilde{x}. \tag{5.4}$$

Clearly,

$$|(T\rho_1)(x) - (T\rho_2)(x)| = \left| \frac{2}{\pi^2 R(w)^4} \int_{\Omega \cap B(x)} (\rho_1(\tilde{x}) - \rho_2(\tilde{x})) d\tilde{x} \right|$$

$$\leq \frac{\max_4 (\Omega \cap B(x))}{\max_4 B(x)} \|\rho_1 - \rho_2\|_{L_{\infty}(\Omega)} \leq \frac{1}{2} \|\rho_1 - \rho_2\|_{L_{\infty}(\Omega)}$$

due to Corollary 2.7. Thus, the map T is a contraction, and hence, there exists a unique function  $\rho_* \in L_{\infty}(\Omega)$  such that  $T\rho_* = \rho_*$ .

**Lemma 5.3.** a) If  $u \in L_{\infty}(\Omega)$  satisfies the inequality

$$u(x) \leqslant (Tu)(x)$$
 a.e. in  $\Omega$ ,

then  $u(x) \leq \rho_*(x)$  a.e. in  $\Omega$ .

b) If  $u \in L_{\infty}(\Omega)$  satisfies the inequality

$$u(x) \geqslant (Tu)(x)$$
 a.e. in  $\Omega$ ,

then  $u(x) \geqslant \rho_*(x)$  a.e. in  $\Omega$ .

*Proof.* a) Let us consider a function

$$\rho_0(x) = \text{const} > ||u||_{L_{\infty}(\Omega)}.$$

Put  $\rho_k = T^k \rho_0$ . Clearly,

$$\rho_k \xrightarrow[k \to \infty]{} \rho_* \quad \text{in} \quad L_\infty(\Omega).$$

On the other hand, we have

$$u(x) \leqslant \rho_k(x)$$
 a.e. in  $\Omega$ 

by induction in k. Taking a limit  $k \to \infty$  we get  $u(x) \leq \rho_*(x)$ .

b) Now, take a function

$$\rho_0(x) = \text{const} < -\|u\|_{L_{\infty}(\Omega)},$$

and  $\rho_k = T^k \rho_0$ . In the same way,

$$u(x) \geqslant \rho_k(x)$$
 a.e. in  $\Omega$ ,

and therefore,  $u(x) \ge \rho_*(x)$  a. e. in  $\Omega$ .

#### Lemma 5.4. Put

$$\Psi(x) = 10R(w)^2 e^{-\alpha(w)^{4/3}}.$$

Then

$$\frac{2}{\pi^2 R(w)^4} \int_{\Omega \cap B(x)} \Psi(\tilde{x}) \, d\tilde{x} \leqslant \frac{7}{10} \, \Psi(x).$$

*Proof.* It is enough to consdier the case  $w \ge 0$ . We have

$$\frac{2}{\pi^2 R(w)^4} \int_{\Omega \cap B(x)} \Psi(\tilde{x}) d\tilde{x}$$

$$\leq \frac{2}{\pi^2 R(w)^4} \cdot 10 R(w - R(w))^2 e^{-\alpha (w - R(w))^{4/3}} \cdot \text{mes}_4 (\Omega \cap B(x))$$

$$\leq \frac{1}{2} \cdot 10 \cdot \frac{100}{81} R(w)^2 e^{200\sqrt{h}} e^{-\alpha (w)^{4/3}}$$

due to Corollary 2.7 and Lemma 5.1. ■

#### Theorem 5.5. Let

$$\varphi \in C^{\gamma}(\overline{\Omega}), \quad \gamma > 0, \qquad 0 \leqslant \varphi(x) \leqslant 10 \, e^{-\alpha(w)^{4/3}} \quad \forall \ x \in \Omega.$$

Let u be the solution to the Dirichlet problem

$$\begin{cases} -\Delta u(x) = \varphi(x) & \text{in } \Omega, \\ u|_{\partial\Omega} = 0. \end{cases}$$

Then

$$0 \leqslant u(x) \leqslant 10 R(w)^2 e^{-\alpha(w)^{4/3}} \quad \forall \ x \in \Omega.$$

*Proof.* Let  $\Phi$  be the function defined by (5.3) with the given function  $\varphi$ , and T be the map defined by (5.4). By Corollary 4.6  $u(x) \leq (Tu)(x)$  for all  $x \in \Omega$ . On the other hand, for the function  $\Psi$  defined in the preceding Lemma we have due to Lemma 5.2 and Lemma 5.4

$$(T\Psi)(x) = \Phi(x) + \frac{2}{\pi^2 R(w)^4} \int_{\Omega \cap B(x)} \Psi(\tilde{x}) \, d\tilde{x} \leqslant 3 \, R(w)^2 e^{-\alpha(w)^{4/3}} + \frac{7}{10} \, \Psi(x) = \Psi(x).$$

Now, Lemma 5.3 implies

$$u(x) \leqslant \rho_*(x) \leqslant \Psi(x).$$

Corollary 5.6. Let  $u \in \mathring{W}_{2}^{1}(\Omega)$  be the solution to the Dirichlet problem

$$\begin{cases} -\Delta u(x) = \Delta f(x) & \text{in } \Omega, \\ u|_{\partial\Omega} = 0. \end{cases}$$

with the function f defined in §1. Then

$$|u(x)| \le 10 R(w)^2 e^{-\alpha(w)^{4/3}} \quad \forall \ x \in \Omega.$$

*Proof.* For  $x \in \Omega$  we have the estimate  $|\Delta f(x)| \leq 10e^{-\alpha(w)^{4/3}}$ . Indeed, if  $|w| \geq w_{m+1}$  then it follows directly from Lemma 1.6. If  $|w| \leq w_{m+1}$  then by Lemma 1.6

$$|\Delta f(x)| \le 40m|f(x)| \le 80mhe^{-\alpha(w)^{4/3}} < 10e^{-\alpha(w)^{4/3}}$$

by definition of the numbers m and h.

Now, denote

$$(\Delta f)_+(x) = \max(\Delta f(x), 0), \qquad (\Delta f)_-(x) = \max(0, -\Delta f(x)).$$

Then

$$\Delta f = (\Delta f)_{+} - (\Delta f)_{-}, \qquad (\Delta f)_{\pm}(x) \geqslant 0 \quad \forall \ x.$$

By Lemma 1.6  $\Delta f \in C^{\infty}(\Pi)$ , therefore,  $(\Delta f)_{\pm} \in C^{\gamma}(\Pi)$  for all  $\gamma < 1$ .

Denote by  $u^{(\pm)} \in \mathring{W}_{2}^{1}(\Omega)$  the solutions to the Dirichlet problems for the equations  $-\Delta u^{(\pm)} = (\Delta f)_{\pm}$ . By Theorem 5.5

$$0 \leqslant u^{(\pm)}(x) \leqslant 10 R(w)^2 e^{-\alpha(w)^{4/3}}.$$

The function  $u^{(+)} - u^{(-)}$  is a solution to the Dirichlet problem for the equation  $-\Delta u = \Delta f$ . Due to uniqueness of the solution we have  $u = u^{(+)} - u^{(-)}$ . Therefore,  $|u(x)| \leq 10R(w)^2 e^{-\alpha(w)^{4/3}}$ .

**Remark 5.7.** The function u is even, u((w,y)) = u((-w,y)).

## 6 Function F

### **6.1** Construction of the function F

Define in  $\Omega$  the function

$$g(x) = f(x) + u(x),$$

where the functions f and u are defined in §1 and in Corollary 5.6 respectively. The function g solves the problem

$$\begin{cases} \Delta g(x) = 0 & \text{in } \Omega, \\ g|_{\partial\Omega} = f|_{\partial\Omega}. \end{cases}$$

In the whole cylinder  $\Pi$  we define the function

$$f^*(x) = \begin{cases} f(x), & \text{if } x \notin \Omega, \\ g(x), & \text{if } x \in \Omega. \end{cases}$$

Clearly,  $f^* \in C(\Pi)$  and

$$|f^*(x)| \le 2e^{-\alpha(w)^{4/3}} \quad \forall \ x \in \Pi.$$
 (6.1)

Introduce the radius

$$\rho := \frac{h}{4}$$

where h is defined by (2.1). Fix a function  $\psi \in C_0^{\infty}(B_{\rho})$ ,  $B_{\rho} \subset \mathbb{R}^4$ , such that  $\int_{B_{\rho}} \psi(x) dx = 1$ ,  $\psi(x) \geq 0$  everywhere, and this function is radially symmetric,  $\psi(x) = \hat{\psi}(|x|)$ . Noting that

$$\alpha(w)^{4/3} \int_{\mathbb{R}^4} \psi\left((x - \tilde{x})\alpha(w)^{1/3}\right) d\tilde{x} = 1, \tag{6.2}$$

we define the function

$$F(x) := \alpha(w)^{4/3} \int_{\Pi} \psi\left((x - \tilde{x})\alpha(w)^{1/3}\right) f^*(\tilde{x}) d\tilde{x}.$$

Clearly,  $F \in C^{\infty}(\Pi)$ . It is also clear that the functions  $g, f^*$  and F are even.

Lemma 6.1. We have

$$|F(x)| \le 3 e^{-\alpha(w)^{4/3}}$$
.

*Proof.* It follows from (6.1), (5.1) and (6.2).

**Lemma 6.2.** If  $|x - \tilde{x}| \le \rho \alpha(w)^{-1/3}$  then  $|f_0(x) - f_0(\tilde{x})| \le h/2$ .

*Proof.* Without loss of generality one can assume  $\tilde{w} \ge 0$ . If  $w \le w_m$  then  $\alpha(w) = w_m$ ,  $\tilde{w} \le w_{m+1}$ , and due to Lemma 1.3

$$|f_0(x) - f_0(\tilde{x})| \le \sqrt{4m+5} |y - \tilde{y}| \le \sqrt{4m+5} \rho w_m^{-1/3} = \frac{\sqrt{4m+5} h}{6\sqrt{m}} < \frac{h}{2}.$$

If  $w_k \leq w \leq w_{k+1}$ ,  $k \geq m$ , then  $\alpha(w) \geq w_k$ ,  $\tilde{w} \in [w_{k-1}, w_{k+2}]$  and by virtue of Lemma 1.3

$$|f_0(x) - f_0(\tilde{x})| \le \sqrt{5(k+1)} |x - \tilde{x}| \le \sqrt{5(k+1)} \rho w_k^{-1/3} = \frac{\sqrt{5(k+1)} h}{6\sqrt{k}} < \frac{h}{2}.$$

We consider also the set

$$U := \{x \in \Pi : |f_0(x)| > h\}.$$

Clearly,

$$U \cup \Omega = \Pi$$
.

### **Lemma 6.3.** If $x \in U$ then

$$|F(x)| \geqslant \frac{h}{8} e^{-\alpha(w)^{4/3}}.$$

*Proof.* Once again, it is sufficient to consider  $w \ge 0$ . Assume first that  $f_0(x) > h$ . Consider the points  $\tilde{x} \in B_{\rho\alpha(w)^{-1/3}}(x)$ . By the preceding Lemma

$$f_0(\tilde{x}) > \frac{h}{2}$$
.

If  $\tilde{x} \notin \Omega$  then  $f_0(\tilde{x}) > 2h$ , and  $f^*(\tilde{x}) = f(\tilde{x}) > 2he^{-\alpha(\tilde{w})^{4/3}}$ . If  $\tilde{x} \in \Omega$  then

$$f^*(\tilde{x}) = g(\tilde{x}) \geqslant f(\tilde{x}) - |u(\tilde{x})| \geqslant \left(\frac{h}{2} - 10R(\tilde{w})^2\right) e^{-\alpha(\tilde{w})^{4/3}} \geqslant \frac{h}{6} e^{-\alpha(\tilde{w})^{4/3}}$$

due to Corollary 5.6. In both cases

$$f^*(\tilde{x}) \geqslant \frac{h}{6}e^{-\alpha(\tilde{w})^{4/3}}.$$

Therefore,

$$F(x) \geqslant \frac{h}{6} e^{-\alpha(w+\rho\alpha(w)^{-1/3})^{4/3}} \geqslant \frac{h}{8} e^{-\alpha(w)^{4/3}},$$

because due to Corollary 1.5

$$\alpha \left( w + \rho \alpha(w)^{-1/3} \right)^{4/3} - \alpha(w)^{4/3} \leqslant 4\rho \alpha(w)^{-1/3} \left( \alpha(w) + 3\rho \alpha(w)^{-1/3} \right)^{1/3}$$
$$= 4\rho \left( 1 + 3\rho \alpha(w)^{-4/3} \right)^{1/3} \leqslant 4\rho \left( 1 + 3\rho w_m^{-4/3} \right)^{1/3} < \ln \frac{4}{3}.$$

In the case  $f_0(x) < -h$  a similar argument shows that

$$F(x) \leqslant -\frac{h}{8} e^{-\alpha(w)^{4/3}}.$$

**Lemma 6.4.** If  $x \notin U$  then F(x) = g(x).

*Proof.* Let  $x \notin U$ . By definition  $|f_0(x)| \leq h$ . By Lemma 6.2  $|f_0(\tilde{x})| \leq \frac{3h}{2}$  if  $|\tilde{x} - x| \leq \rho \alpha(w)^{-1/3}$ , thus

$$B_{\rho\alpha(w)^{-1/3}}(x) \subset \Omega.$$

Therefore,

$$F(x) = \alpha(w)^{4/3} \int_{B_{\rho\alpha(w)^{-1/3}}(x)} \psi((x - \tilde{x})\alpha(w)^{1/3}) g(\tilde{x}) d\tilde{x}.$$

In spherical coordinates

$$\tilde{x} - x = (t; \theta), \quad t \in [0, \infty), \ \theta \in S^3,$$

we have

$$F(x) = \alpha(w)^{4/3} \int_0^{\rho\alpha(w)^{-1/3}} \int_{S^3} \hat{\psi} \left( t\alpha(w)^{1/3} \right) g\left( x + (t; \theta) \right) t^3 dt \, dS(\theta).$$

The function g is harmonic in  $\Omega$ , so by the mean value property

$$\int_{S^3} g(x + (t; \theta)) \ dS(\theta) = 2\pi^2 g(x).$$

Moreover,

$$2\pi^2 \int_0^{\rho\alpha(w)^{-1/3}} \hat{\psi}\left(t\alpha(w)^{1/3}\right) t^3 dt = \int_{|z|\leqslant \rho\alpha(w)^{-1/3}} \psi\left(z\alpha(w)^{1/3}\right) dz = \alpha(w)^{-4/3}.$$

Therefore, F(x) = g(x).

Corollary 6.5. If  $x \notin U$  then  $\Delta F(x) = 0$ .

## **6.2** Laplacian of F

Lemma 6.6. We have

$$\left| \Delta_x \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) - \Delta_{\tilde{x}} \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) \right| \leqslant C_1 \alpha(w)^{2/3}$$
 (6.3)

and

$$\left| \Delta_x \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) \right| \leqslant C_1 \alpha(w)^2. \tag{6.4}$$

Here  $C_1$  is a constant that depends on the choice of the function  $\psi$  only.

Proof. Clearly,

$$\Delta_y \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) 
= \alpha(w)^2 (\Delta_y \psi) \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) 
= \Delta_{\tilde{y}} \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right)$$
(6.5)

and

$$\partial_{\tilde{w}}^{2} \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) = \alpha(w)^{2} (\partial_{w}^{2} \psi) \left( (x - \tilde{x}) \alpha(w)^{1/3} \right). \tag{6.6}$$

We have also

$$\partial_{w} \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right)$$

$$= \frac{4}{3} \alpha(w)^{1/3} \alpha'(w) \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right)$$

$$+ \alpha(w)^{4/3} \left( \alpha(w)^{1/3} + \frac{1}{3} (w - \tilde{w}) \alpha(w)^{-2/3} \alpha'(w) \right) (\partial_{w} \psi) \left( (x - \tilde{x}) \alpha(w)^{1/3} \right)$$

$$+ \frac{1}{3} \alpha(w)^{2/3} \alpha'(w) \sum_{j=1}^{3} (y_{j} - \tilde{y}_{j}) (\partial_{y_{j}} \psi) \left( (x - \tilde{x}) \alpha(w)^{1/3} \right)$$

and

$$\partial_w^2 \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right)$$

$$= \left( \alpha(w) + \frac{1}{3} \left( w - \tilde{w} \right) \alpha'(w) \right)^2 \left( \partial_w^2 \psi \right) \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) + O(\alpha(w)^{2/3}), \tag{6.7}$$

where we have taken into account the relations

$$|x - \tilde{x}| \leq \rho \alpha(w)^{-1/3}, \quad \tilde{w} = O(\alpha(w)), \quad \psi, \nabla \psi, \nabla^2 \psi = O(1),$$
  
$$\alpha'(w) = O(1), \quad \alpha''(w) = O\left(\alpha(w)^{-1/3}\right).$$

Further.

$$\left(\alpha(w) + \frac{1}{3}(w - \tilde{w})\alpha'(w)\right)^2 - \alpha(w)^2 = O(\alpha(w)^{2/3}).$$

Now, the result follows from (6.5), (6.6) and (6.7).

Let us consider also the function

$$G(x) := \alpha(w)^{4/3} \int_{\Pi} \psi\left((x - \tilde{x})\alpha(w)^{1/3}\right) f(\tilde{x}) d\tilde{x}.$$

Clearly,  $G \in C^{\infty}(\Pi)$ .

Lemma 6.7. We have

$$|\Delta G(x)| \leqslant C_2 e^{-\alpha(w)^{4/3}}.$$

where the constant  $C_2$  depends on the choice of the function  $\psi$  only.

*Proof.* It is sufficient to consider  $w \ge 0$ . Represent  $\Delta G$  in the form

$$\Delta G(x) = \int \left( \Delta_x \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) - \Delta_{\tilde{x}} \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) \right) f(\tilde{x}) d\tilde{x}$$
$$+ \int \Delta_{\tilde{x}} \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) f(\tilde{x}) d\tilde{x} =: I_1 + I_2.$$

Estimate the first integral using (6.3):

$$|I_1(x)| \leqslant C_1 \alpha(w)^{2/3} \int_{|\tilde{x}-x| \leqslant \rho \alpha(w)^{-1/3}} |f(\tilde{x})| d\tilde{x}$$
  
$$\leqslant C_1 \alpha(w)^{2/3} e^{-\alpha(w-\rho \alpha(w)^{-1/3})^{4/3}} \frac{\pi^2 \rho^4 \alpha(w)^{-4/3}}{2}.$$

By Corollary 1.5

$$\alpha(w)^{4/3} - \alpha(w - \rho\alpha(w)^{-1/3})^{4/3} \leqslant 4\rho = h. \tag{6.8}$$

Therefore,

$$|I_1(x)| \leq \frac{1}{2}C_1\pi^2\rho^4\alpha(w)^{-2/3}e^he^{-\alpha(w)^{4/3}}.$$

Next, integrating by parts we obtain

$$I_2(x) = \int \alpha(w)^{4/3} \psi\left((x - \tilde{x})\alpha(w)^{1/3}\right) \Delta f(\tilde{x}) d\tilde{x}.$$

Therefore, by virtue of Corollary 1.7, (6.2) and (6.8)

$$|I_2(x)| \le 40me^{-\alpha(w-\rho\alpha(w)^{-1/3})^{4/3}} \le 40me^he^{-\alpha(w)^{4/3}}.$$

Lemma 6.8. We have

$$|\Delta F(x)| \leqslant C_3 e^{-\alpha(w)^{4/3}},$$

where the constant  $C_3$  depends on the choice of the function  $\psi$  only.

*Proof.* Once again we consider  $w \ge 0$ . We have

$$\Delta F(x) - \Delta G(x) = \int_{\Pi} \Delta_x \left( \alpha(w)^{4/3} \psi \left( (x - \tilde{x}) \alpha(w)^{1/3} \right) \right) \left( f^*(\tilde{x}) - f(\tilde{x}) \right) d\tilde{x}.$$

If  $\tilde{x} \notin \Omega$  then  $f^*(\tilde{x}) - f(\tilde{x}) = 0$ . If  $\tilde{x} \in \Omega$  then

$$|f^*(\tilde{x}) - f(\tilde{x})| = |u(\tilde{x})| \le 10R(\tilde{w})^2 e^{-\alpha(\tilde{w})^{4/3}}$$

due to Corollary 5.6. Taking into account (6.4) and (6.8) we get

$$|\Delta F(x) - \Delta G(x)| \leq 10C_1 \alpha(w)^2 \int_{|\tilde{x} - x| \leq \rho \alpha(w)^{-1/3}} R(\tilde{w})^2 e^{-\alpha(\tilde{w})^{4/3}} d\tilde{x}$$

$$\leq 10C_1 \alpha(w)^2 R(w - \rho \alpha(w)^{-1/3})^2 e^{-\alpha(w - \rho \alpha(w)^{-1/3})^{4/3}} \frac{\pi^2 \rho^4 \alpha(w)^{-4/3}}{2}$$

$$\leq 5C_1 \alpha(w)^{2/3} R(w - \rho \alpha(w)^{-1/3})^2 \pi^2 \rho^4 e^h e^{-\alpha(w)^{4/3}}.$$
(6.9)

Show that

$$\alpha(w)^{1/3}R(w - \rho\alpha(w)^{-1/3}) \leqslant 1. \tag{6.10}$$

Indeed, if  $w \leq w_m$  then

$$\alpha(w)^{1/3}R(w - \rho\alpha(w)^{-1/3}) = 50\sqrt{h}.$$

If  $w_m \leq w \leq w_{m+1}$ , then

$$\alpha(w)^{1/3}R(w - \rho\alpha(w)^{-1/3}) \le 50\sqrt{h} \, w_m^{-1/3} w_{m+1}^{1/3}$$

If  $w_k \leq w \leq w_{k+1}$ ,  $k \geq m+1$  then

$$\alpha(w)^{1/3}R(w-\rho\alpha(w)^{-1/3}) \leqslant 50\sqrt{h}\,w_{k-1}^{-1/3}w_{k+1}^{1/3}$$

In all cases (6.10) follows. Now, the claim follows from (6.9), (6.10) and Lemma 6.7.

Proof of Theorem 0.1. The existence of such function F follows from Lemma 6.1, Lemma 6.3, Corollary 6.5 and Lemma 6.8.
