Nonasymptotic Regret Analysis of Adaptive Linear Quadratic Control with Model Misspecification

Abstract

The strategy of pre-training a large model on a diverse dataset, then fine-tuning for a particular application has yielded impressive results in computer vision, natural language processing, and robotic control. This strategy has vast potential in adaptive control, where it is necessary to rapidly adapt to changing conditions with limited data. Toward concretely understanding the benefit of pretraining for adaptive control, we study the adaptive linear quadratic control problem in the setting where the learner has prior knowledge of a collection of basis matrices for the dynamics. This basis is misspecified in the sense that it cannot perfectly represent the dynamics of the underlying data generating process. We propose an algorithm that uses this prior knowledge, and prove upper bounds on the expected regret after T interactions with the system. In the regime where T is small, the upper bounds are dominated by a term that scales with either poly(log T) or \sqrt{T} , depending on the prior knowledge available to the learner. When T is large, the regret is dominated by a term that grows with δT , where δ quantifies the level of misspecification. This linear term arises due to the inability to perfectly estimate the underlying dynamics using the misspecified basis, and is therefore unavoidable unless the basis matrices are also adapted online. However, it only dominates for large T, after the sublinear terms arising due to the error in estimating the weights for the basis matrices become negligible. We provide simulations that validate our analysis. Our simulations also show that offline data from a collection of related systems can be used as part of a pre-training stage to estimate a misspecified dynamics basis, which is in turn used by our adaptive controller.

1. Introduction

Transfer learning, whereby a model is pre-trained on a large dataset, and then finetuned for a specific application, has exhibited great success in computer vision (Dosovitskiy et al., 2020) and natural language processing (Devlin et al., 2018). Efforts to apply these methods to control have shown exciting preliminary results, particularly in robotics (Dasari et al., 2019). The principle underpinning the success of transfer learning is to use diverse datasets to extract compressed, broadly useful features, which can be used in conjunction with comparatively simple models for downstream objectives. These simple models can be finetuned with relatively little data from the downstream task. However, errors in the pre-training stage may cause this two-step strategy to underperform learning from scratch when ample task-specific data is available. This tradeoff may be acceptable in settings such as adaptive control, where the learner must rapidly adapt to changes with limited data.

Driven by the potential of pre-training in adaptive control, we study the adaptive linear quadratic regulator (LQR) in a setting where imperfect prior information about the system is available. The

adaptive LQR problem consists of a learner interacting with an unknown linear system

$$x_{t+1} = A^* x_t + B^* u_t + w_t, \tag{1}$$

with state x_t , input u_t , and noise w_t assuming values in \mathbb{R}^{d_X} , \mathbb{R}^{d_U} , and \mathbb{R}^{d_X} , respectively. The learner is evaluated by its ability to minimize its *regret*, which compares the cost incurred by playing the learner for T time steps with the cost attained by the optimal LQR controller. Prior work has studied the adaptive LQR problem in the settings where A^* , B^* , or both A^* and B^* are fully unknown to the learner and with either stochastic or bounded adversarial noise processes (Abbasi-Yadkori and Szepesvári, 2011; Hazan et al., 2020; Cassel et al., 2020). In this work, we analyze a setting where the learner has a set of basis matrices for the system dynamics; however, $\begin{bmatrix} A^* & B^* \end{bmatrix}$ is not in the subspace spanned by this basis, leading to misspecification.

1.1. Related Work

Adaptive Control Originating from autopilot development for high-performance aircraft in the 1950s (Gregory, 1959), adaptive control addressed the need for controllers to adapt to varying altitude, speed, and flight configuration (Stein, 1980). Interest in adaptive control theory grew over the subsequent decades, notably advanced by the landmark paper by Åström and Wittenmark (1973), who studied self tuning regulators. The history of adaptive control is documented in numerous texts (Åström and Wittenmark, 2013; Ioannou and Sun, 1996; Narendra and Annaswamy, 2012).

Nonasymptotic Adaptive LOR The non-asymptotic study of the adaptive LOR problem was pioneered by Abbasi-Yadkori and Szepesvári (2011). Subsequent works (Dean et al., 2018; Cohen et al., 2019; Mania et al., 2019) developed computationally efficient algorithms with upper bounds on the regret scaling with \sqrt{T} . Simchowitz and Foster (2020) provide lower bounds which show that the rate $\sqrt{d_{\rm II}^2 d_{\rm X} T}$ is optimal when the system is entirely unknown. The dependence of the lower bounds on system theoretic constants is refined by Ziemann and Sandberg (2022), enabling Tsiamis et al. (2022) to show the regret may depend exponentially on d_X for specific classes of systems. If either A^* or B^* are known, then the regret bounds may be improved to poly(log T) (Cassel et al., 2020; Jedra and Proutiere, 2022). Alternative formulations of the adaptive LQR problem consider bounded non-stochastic disturbances (Hazan et al., 2020; Simchowitz et al., 2020) and minimax settings (Rantzer, 2021; Cederberg et al., 2022; Renganathan et al., 2023). In contrast to existing work studying the adaptive LQR problem from a nonasymptotic perspective, we consider bounded misspecification between a representation estimate for the dynamics and the data generating process. Multi-task Representation Learning The source of mispecification we consider is inspired by theoretical work studying multi-task representation learning in the linear regression setting (Du et al., 2020; Tripuraneni et al., 2020). These papers have been followed by a collection of work studying the use of multi-task representation learning in the presence of data correlated across time, which arises in system identification (Modi et al., 2021; Zhang et al., 2023b) and imitation learning (Zhang et al., 2023a). All of these works show that by pre-training a shared representation on a set of source tasks, the sample complexity of learning the target task may be reduced.

1.2. Contributions

We introduce a notion of misspecification between an estimate for the basis of the dynamics and the data generating process. We then propose an adaptive control algorithm that uses this misspecified basis, and subsequently analyze the regret of this algorithm. This leads to the following insights:

• Our results generalize the understanding of when logarithmic regret is possible in adaptive LQR beyond the cases of known A^* or B^* studied by Cassel et al. (2020); Jedra and Proutiere (2022).

• When misspecification is present, the regret incurs a term that is linear in T. The coefficient for this term decays gracefully as the level of misspecification diminishes. As a result, small misspecification means the regret is dominated by sublinear terms in the low data regime of interest for adaptive control. These terms are favorable to those possible in the absence of prior knowledge. We validate our theory with numerical experiments, and show the benefit using a dynamics representation determined by pre-training on offline data from related systems for adaptive control.

1.3. Notation

The Euclidean norm of a vector x is denoted $\|x\|$. For a matrix A, the spectral norm is denoted $\|A\|_F$, and the Frobenius norm is denoted $\|A\|_F$. We use \dagger to denote the Moore-Penrose pseudo-inverse. The spectral radius of a square matrix is denoted $\rho(A)$. A symmetric, positive semi-definite (psd) matrix $A = A^{\top}$ is denoted $A \succeq 0$. Similarly $A \succeq B$ denotes that A - B is positive semidefinite. The minimum eigenvalue of a symmetric, positive definite matrix A is denoted $\lambda_{\min}(A)$. For $f, g: D \to \mathbb{R}$, we write $f \lesssim g$ if for some c > 0, $f(x) \leq cg(x) \, \forall x \in D$. We denote the solutions to the discrete Lyapunov equation by $\mathrm{dlyap}(A,Q)$ and the discrete algebraic Riccati equation by $\mathrm{DARE}(A,B,Q,R)$. We use $x \vee y$ to denote the maximum of x and y.

2. Problem Formulation

2.1. System model

We consider the system (1) where the noise w_t has independent identically distributed elements that are mean zero and σ^2 -sub-Gaussian for some $\sigma^2 \in \mathbb{R}$ with $\sigma^2 \geq 1$. We additionally assume that the noise has identity covariance: $\mathbf{E}[w_t w_t^{\mathsf{T}}] = I$. We suppose the dynamics admit the decomposition

$$[A^{\star} \quad B^{\star}] = \mathsf{vec}^{-1}(\Phi^{\star}\theta^{\star}), \tag{2}$$

where $\Phi^* \in \mathbb{R}^{d_X(d_X+d_U)\times d_\theta}$ specifies the model structure, and has orthonormal columns. Meanwhile, $\theta^* \in \mathbb{R}^{d_\theta}$ specifies the parameters. The operator vec^{-1} maps a vector in $\mathbb{R}^{d_X(d_X+d_U)}$ into a matrix in $\mathbb{R}^{d_X\times(d_X+d_U)}$ by stacking length d_X blocks of the the vector into columns of the matrix, working top to bottom and left to right. We can write this as a linear combination of basis matrices:

$$\begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} = \sum_{i=1}^{d_{\theta}} \theta_{i}^{\star} \begin{bmatrix} \Phi_{i}^{A,\star} & \Phi_{i}^{B,\star} \end{bmatrix}, \text{ where } \begin{bmatrix} \Phi_{i}^{A,\star} & \Phi_{i}^{B,\star} \end{bmatrix} = \text{vec}^{-1} \Phi_{i}^{\star},$$

and Φ_i^\star is the i^{th} column of Φ^\star . This decomposition of the data generating process is a natural extension of the low-dimensional linear representations considered in Du et al. (2020) to the setting of multiple related dynamical systems with shared structure determined by Φ^\star . It captures many practically relevant settings, such as when A^\star and B^\star depend on a few physical parameters θ^\star , and Φ^\star describes the structure through which these physical parameters enter the dynamics.

We assume that both Φ^* and θ^* are unknown; however, we have an estimate $\hat{\Phi} \in \mathbb{R}^{d_X(d_X+d_U)\times d_\theta}$, also with orthonormal columns, for Φ^* . Such an estimate may be obtained by performing a pretraining step on offline data from a collection of systems related to (1) by the shared matrix Φ^* in (2). Due to the noise present in the offline data, this estimate will be imperfect, resulting in misspecification.² To quantify the level of misspecification between this estimate and the underlying data generating process, we use the following subspace distance metric.

Definition 1 ((Stewart and Sun, 1990)) Let Φ_{\perp}^{\star} complete the basis of Φ^{\star} such that $\begin{bmatrix} \Phi^{\star} & \Phi_{\perp}^{\star} \end{bmatrix}$ is an orthogonal matrix. Then the subspace distance between Φ^{\star} and $\hat{\Phi}$ is $d(\Phi^{\star}, \hat{\Phi}) \triangleq \|\hat{\Phi}^{\top} \Phi_{\perp}^{\star}\|$.

Note that the above distance is small when the range of the matrices $\hat{\Phi}$ and Φ^* is similar.³

As long as $d(\Phi^*, \hat{\Phi})$ is sufficiently small and the dimension $d_{\theta} < d_{\mathsf{X}}(d_{\mathsf{X}} + d_{\mathsf{U}})$, the estimate $\hat{\Phi}$ allows the learner to fit a model with less data than would be required to estimate $\begin{bmatrix} A^* & B^* \end{bmatrix}$ from scratch. This benefit comes at the cost of a bias in the learner's model that grows with $d(\Phi^*, \hat{\Phi})$.

2.2. Learning objective

The goal of the learner is to interact with system (1) while keeping the cumulative cost small, where the cumulative cost is defined for matrices $Q \succeq I$ and R = I as⁴

$$C_T \triangleq \sum_{t=1}^{T} c_t$$
, where $c_t \triangleq x_t^{\top} Q x_t + u_t^{\top} R u_t$. (3)

To define an algorithm that keeps the cost small, we first introduce the infinite horizon LQR cost:

$$\mathcal{J}(K) \triangleq \limsup_{T \to \infty} \frac{1}{T} \mathbf{E}^K C_T, \tag{4}$$

where the superscript of K on the expectation denotes that the cost is evaluated under the state feedback controller $u_t = Kx_t$. To ensure that there exists a controller such that (4) has finite cost, we assume (A^\star, B^\star) is stabilizable. Under this assumption, (4) is minimized by the LQR controller $K_\infty(A^\star, B^\star)$, where $K_\infty(A, B) \triangleq -(B^\top P_\infty(A, B)B + R)^{-1}B^\top P_\infty(A, B)A$, and $P_\infty(A, B) \triangleq \text{DARE}(A, B, Q, R)$. We define the shorthands $P^\star \triangleq P_\infty(A^\star, B^\star)$ and $K^\star \triangleq K_\infty(A^\star, B^\star)$. To characterize the infinite horizon LQR cost of an arbitrary stabilizing controller K, we additionally define the solution P_K to the lyapunov equation for the closed loop system under an arbitrary K such that $\rho(A^\star + B^\star K) < 1$: $P_K \triangleq \text{dlyap}(A^\star + B^\star K, Q + K^\top RK)$. For a controller K satisfying $\rho(A^\star + B^\star K) < 1$, $\mathcal{J}(K) = \text{tr}(P_K)$. We have that $P_{K^\star} = P^\star$.

The infinite horizon LQR controller provides a baseline level of performance that our learner cannot surpass in the limit as $T \to \infty$. Borrowing the notion of regret from online learning, as in Abbasi-Yadkori and Szepesvári (2011), we quantify the performance of our learning algorithm by comparing the cumulative cost C_T to the scaled infinite horizon cost attained by the LQR controller if the system matrices A^* were known:

$$\mathbf{R}_T \triangleq C_T - T\mathcal{J}(K^*). \tag{5}$$

In light of the above reformulation, the goal of the learner is to interact with the system (1) to maximize the information about the relevant parameters for control while simultaneously regulating the system to minimize \mathbf{R}_T . A reasonable strategy to do so is for the learner to use its history of interaction with the system to construct a model for the dynamics, e.g. by determining estimates \hat{A} and \hat{B} . It may then use these estimates as part of a *certainty equivalent* (CE) design by synthesizing controllers $\hat{K} = K_{\infty}(\hat{A}, \hat{B})$. Prior work has shown that if the model estimate is sufficiently close

to the true dynamics, then the cost of playing the controller \hat{K} exceeds the cost of playing K^* by a quantity that is quadratic in the estimation error (Mania et al., 2019; Simchowitz and Foster, 2020). This fact will be used to characterize the performance of the learner in terms of the error in the estimation of the system matrices.

2.3. Algorithm description

Our proposed algorithm, Algorithm 1, is a CE algorithm akin to that proposed in Cassel et al. (2020). The algorithm takes a stabilizing controller K_0 as an input. Starting from this controller, Algorithm 1 follows a doubling epochs strategy. At the end of each epoch, it uses the data collected during the epoch along with the estimate for $\hat{\Phi}$ to obtain an estimate for $\hat{\theta}$ by solving a least squares problem (as detailed in Algorithm 2). The estimated parameters $\hat{\theta}$ are combined with the estimate $\hat{\Phi}$ to obtain the dynamics estimate \hat{A} . This estimate is used to synthesize a CE controller $\hat{K} = K_{\infty}(\hat{A}, \hat{B})$. In the next epoch, the learner plays the resultant controller with exploratory noise added. Before playing each input, the algorithm checks whether the state or the controller exceed bounds determined by algorithm inputs x_b and K_b . If they do, it aborts the certainty equivalent scheme, and plays the initial stabilizing controller for all time. Doing so enables bounding of the regret during unlikely events where the CE controller fails. The key difference from the CE algorithms proposed in prior work is that the system identification step solves a least squares problem defined in terms of the estimate $\hat{\Phi}$ to estimate the unknown parameters.

3. Regret Bounds

We now present our bounds on the expected⁷ regret incurred by Algorithm 1. Consider running Algorithm 1 for $T = \tau_1 2^{k_{\text{fin}}-1}$ timesteps, where τ_1 is the initial epoch length and k_{fin} is the number of

epochs. To bound the regret incurred by this algorithm, we decompose the regret into that achieved by the algorithm under a high probability success event, and that incurred during a failure event under which the state or controller bound in line 5 of Algorithm 1 are violated. To ensure the failure event occurs with a small probability, we make the following assumption on the state and controller bounds, which uses the shorthand $\Psi_{B^*} \triangleq \max\{1, ||B^*||\}$.

Assumption 1 We assume that
$$x_b \ge 400 \|P_{K_0}\|^2 \Psi_{B^*} \sigma \sqrt{d_X + d_U}$$
 and $K_b \ge \sqrt{2 \|P_{K_0}\|}$.

We make additional assumptions about the remaining arguments supplied as inputs to the algorithm in two cases: one where no additional assumptions about the dynamics are made (Section 3.1), and one where we assume the system structure estimate is such that the initial controller and the optimal controller provide sufficient excitation to identify the unknown parameters (Section 3.2).

3.1. Certainty equivalent control with continual exploration

To ensure an estimate satisfying the condition in Lemma 1 is attainable, the gap between the model structure estimate and the ground truth cannot be too large, leading to the following assumption.

Assumption 2 Let ε be as in Lemma 1 and K_0 be an initial stabilizing controller. Define $\beta_1 \triangleq C_{\mathsf{bias},1}\sigma^4 \|P_{K_0}\|^{12} \Psi_{B^*}^8 \|\theta^*\|^2 (d_{\mathsf{X}} + d_{\mathsf{U}}) \sqrt{\frac{d_\theta}{d_\mathsf{U}}}$ for a sufficiently large universal constant $C_{\mathsf{bias},1}$. We assume our representation error satisfies $d(\hat{\Phi}, \Phi^*) \leq \frac{\varepsilon^2}{4\beta_1^2}$.

The requirement above arises from the way that misspecification enters our bounds on the estimation error $\| \begin{bmatrix} \hat{A} & \hat{B} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \|_F^2$. See the definition of $\mathcal{E}_{\mathsf{est},1}$ in Section 3.3.

In this setting, we run Algorithm 1 with exploratory inputs injected to ensure identifiability of the unknown parameters. Doing so provides the regret guarantees in the following theorem.

Theorem 2 Consider applying Algorithm 1 with initial stabilizing controller K_0 for $T = \tau_1 2^{k_{\text{fin}}-1}$ timesteps for some positive integers k_{fin} , and τ_1 . Suppose that for some $\gamma \geq 1$, the exploration sequence is given by $\sigma_k^2 = \max\left\{\frac{\sqrt{d_0/d_\theta}}{\sqrt{\tau_1 2^{k-1}}}, \gamma d(\hat{\Phi}, \Phi^\star)^{1/2}\right\} \forall k \geq 1.8$ Suppose the state bound x_b and the controller bound K_b satisfy Assumption 1 and that $\hat{\Phi}$ satisfies Assumption 2. Let ε be as in Lemma 1. There exists a universal positive constant $C_{\text{warm up}}$ such that if $\tau_1 = \tau_{\text{warm up}} \log^2 T$ for

$$\tau_{\mathsf{warm}\,\mathsf{up}} \geq C_{\mathsf{warm}\,\mathsf{up}} \sigma^4 \left\| P_{K_0} \right\|^3 \max \biggl\{ \Psi_{B^\star}^2(d_{\mathsf{X}} + d_{\mathsf{U}}), x_b^2, -\log_{\left(1 - \frac{1}{\|P^\star\|}\right)} \left\| P^\star \right\|, \left(\sqrt{d_\theta d_{\mathsf{U}}/\varepsilon}\right)^2 \biggr\},$$

then the expected regret satisfies

$$E[\mathbf{R}_T] \le c_0 \log^2(T) + c_1 \sqrt{d_\theta d_\mathsf{U}} \sqrt{T} \log T + c_2 \sqrt{d(\hat{\Phi}, \Phi^*)} T,$$

where $c_0 = poly(d_{\mathbf{X}}, d_{\mathbf{U}}, \|P_{K_0}\|, \Psi_{B^*}, \tau_{\mathsf{warm up}}, x_b, K_b)$, $c_1 = poly(\|P_{K_0}\|, \Psi_{B^*}, \sigma)$ and $c_2 = poly(d_{\mathbf{U}}, d_{\mathbf{X}}, d_{\theta}, \|P_{K_0}\|, \Psi_{B^*}, \|\theta^*\|, \sigma, \gamma)$.

The constants c_0 and c_2 in the above bound depend on system dimensions, system-theoretic quantities, and algorithm parameters including the state and controller bounds, the initial epoch length, and the initial controller. In contrast, the constant c_1 , does not depend on system dimension. It is presented as such to emphasize that the dimensional dependence of the order \sqrt{T} term is $\sqrt{d_{\theta}d_{\text{U}}}$. This elucidates the dependence on the system and parameter dimensions in the regime where the \sqrt{T} term is dominant. Consider the result in the absence of misspecification: $d(\hat{\Phi}, \Phi^*) = 0$. In this case, the dominant term grows with $\sqrt{d_{\theta}d_{\text{U}}}\sqrt{T}\log T$. As long as $d_{\theta} \leq d_{\text{X}}d_{\text{U}}$, this is smaller than the dependence of $\sqrt{d_{\text{U}}^2d_{\text{X}}}$ which appears in the lower bounds for the regret of learning to control a system with entirely unknown A^* and B^* (Simchowitz and Foster, 2020). If the misspecification is nonzero, then the regret bound incurs an additional term that grows linearly with T. However, as long as $d(\hat{\Phi}, \Phi^*)$ is sufficiently small, there exists a regime of T for which the \sqrt{T} term dominates, and using the misspecified basis provides a benefit over learning from scratch.

One could modify the procedure to simultaneously use the collected data to estimate A^* and B^* from scratch at every epoch, while maintaining confidence sets for these estimates (Abbasi-Yadkori and Szepesvári, 2011). If the high confidence set is smaller than the bound on the level of misspecification, the learner could switch to relying upon the estimates of learning from scratch. It may therefore be possible to eliminate the term in the regret that is linear in T, while maintaining the benefit of the prior knowledge for small T. We leave investigation of such procedures to future work.

3.2. Certainty equivalent control without additional exploration

In this section, we analyze the regret attained under the additional assumption that the process noise fully excites the relevant modes of the system under K^* and K_0 . This may be guaranteed as follows.

Assumption 3 Let $\hat{\Phi}$ be the estimate for dynamics representation, and let α be a number satisfying $\alpha \geq \frac{1}{3\|P^{\star}\|^{3/2}}$. We assume that $\lambda_{\min}\left(\hat{\Phi}^{\top}\left(\begin{bmatrix}I\\K\end{bmatrix}\begin{bmatrix}I\\K\end{bmatrix}^{\top}\otimes I_{d_{\mathsf{X}}}\right)\hat{\Phi}\right) \geq \alpha^{2}$ for $K=K_{0},K^{\star}$.

The above assumption captures a setting where playing either the initial controller K_0 or the optimal controller K^\star provides persistence of excitation without any exploratory input. This can be seen by noting that the matrix $\hat{\Phi}^\top \left(\begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^\top \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}$ is a lower bound (in Loewner order) for the covariance matrix formed by taking the expectation of Λ/t in Algorithm 2 when $u_s = Kx_s$.

Under the above assumption, we may run Algorithm 1 without an additional exploratory input injected. As in Section 3.1, we require that the representation error is small enough to guarantee the closeness condition in Lemma 1 may be satisfied with our estimated model.

Assumption 4 Let ε be as in Lemma 1, K_0 be a stabilizing controller, and α be a positive number such that Assumption 3 holds. We assume our representation error satisfies $d(\hat{\Phi}, \Phi^*) \leq \sqrt{\frac{\varepsilon}{2\beta_2}}$,

where
$$\beta_2 \triangleq C_{\mathsf{bias},2} \frac{\varepsilon \left\| P_{K_0} \right\|^9 \Psi_{B^\star}^8 \|\theta^\star\|^2 (d_{\mathsf{X}} + d_{\mathsf{U}})}{d_\theta \min\{\alpha^2, \alpha^4\}}$$
 and $C_{\mathsf{bias},2}$ is a sufficiently large universal constant.

This requirement again arises from dependence of the estimation error bounds on the misspecification. See the definition of $\mathcal{E}_{\mathsf{est},2}$ in Section 3.3. Under these assumptions, our regret bound may be improved to that in the following theorem.

Theorem 3 Consider applying Algorithm 1 with initial stabilizing controller K_0 for $T = \tau_1 2^{k_{\text{fin}}}$ timeteps for some positive integers k_{fin} , and τ_1 . Additionally suppose the exploration sequence is zero for all time: $\sigma_k^2 = 0$ for $k = 1, \ldots, k_{\text{fin}}$. Suppose the state bound x_b and the controller bound K_b satisfy Assumption 1, and that $\hat{\Phi}$ satisfies Assumption 3 and Assumption 4. Let ε be as in Lemma 1. There exists a positive universal constant $C_{\text{warm up}}$ such that if $\tau_1 = \tau_{\text{warm up}} \log T$, for

$$\tau_{\mathsf{warm}\,\mathsf{up}} \geq C_{\mathsf{warm}\,\mathsf{up}} \sigma^4 \, \|P_{K_0}\|^3 \, \Psi_{B^\star}^2 \, \max \biggl\{ (d_{\mathsf{X}} + d_{\mathsf{U}}), x_b^2, -\log_{\left(1 - \frac{1}{2\|P^\star\|}\right)} \|P^\star\| \, , d_\theta/(2\varepsilon\alpha^2) \biggr\},$$

then the expected regret satisfies

$$\mathbf{E}[\mathbf{R}_T] \le c_1 \log^2(T) + c_2 d(\hat{\Phi}, \Phi^*)^2 T,$$

where
$$c_1 = poly(d_X, d_U, d_\theta, ||P_{K_0}||, \Psi_{B^*}, ||\theta^*||, \sigma, \alpha^{-1}, \tau_{\text{warm up}}, K_b, x_b)$$
 and $c_2 = poly(d_X, d_U, d_\theta, ||P_{K_0}||, \Psi_{B^*}, ||\theta^*||, \alpha^{-1}).$

When the misspecification is zero, the expected regret grows with $\log^2 T$. Prior work (Cassel et al., 2020; Jedra and Proutiere, 2022) has shown that such rates are possible if either A^* or B^* are known to the learner. See Appendix E.1 for details about how to obtain logarithmic regret in these settings using Theorem 3. The above result expands on prior work by generalizing conditions for prior knowledge that are sufficient to achieve logarithmic regret.

With misspecification present, the above theorem has a term growing linearly T. In contrast to Theorem 2, the coefficient for this term is proportional to the level of misspecification squared, which is smaller than the square root dependence in Theorem 2. This result shows that if some coarse system knowledge depending on a few unknown parameters is available in advance and the unknown parameters are easily identifiable in the sense of Assumption 3, then there exists a substantial regime of T for which the regret incurred is much smaller than that attained by learning to control the system from scratch with fully unknown A^* and B^* (where the regret scales as \sqrt{T}).

3.3. Proof sketch

Our main result proceeds by first defining a success events for which the certainty equivalent control scheme never aborts, and generates dynamics estimates $\begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix}$ which are sufficiently close to the true dynamics $\begin{bmatrix} A^* & B^* \end{bmatrix}$ at all times. The success events for Section 3.1 and Section 3.2 are $\mathcal{E}_{\text{success},1} = \mathcal{E}_{\text{bound}} \cap \mathcal{E}_{\text{est},1}$ and $\mathcal{E}_{\text{success},2} = \mathcal{E}_{\text{bound}} \cap \mathcal{E}_{\text{est},2}$ respectively, where

$$\begin{split} \mathcal{E}_{\mathsf{bound}} &= \Big\{ \|x_t\|^2 \leq x_b^2 \log T \quad \forall t = 1, \dots, T \Big\} \cap \Big\{ \Big\| \hat{K}_k \Big\| \leq K_b \,, \forall k = 1, \dots, k_{\mathsf{fin}} \Big\}, \\ \mathcal{E}_{\mathsf{est},1} &= \Big\{ \Big\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \Big\|_F^2 \leq C_{\mathsf{est},1} \frac{\sigma^2 \sqrt{d_\theta d_\mathsf{U}} \, \|P_{K_0}\|}{\sqrt{\tau_k}} \log T + \beta_1 \sqrt{d(\hat{\Phi}, \Phi^\star)} \Big\}, \\ \mathcal{E}_{\mathsf{est},2} &= \Big\{ \Big\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \Big\|_F^2 \leq C_{\mathsf{est},2} \frac{\sigma^2 d_\theta}{\tau_k \alpha^2} \log T + \beta_2 d(\hat{\Phi}, \Phi^\star)^2 \Big\}, \end{split}$$

and $C_{\ensuremath{\mathsf{est}},1}$ and $C_{\ensuremath{\mathsf{est}},2}$ are positive universal constants.

We use the success events to decompose the expected regret as in Cassel et al. (2020): $\mathbf{E}[\mathbf{R}_T] = R_1 + R_2 + R_3 - T\mathcal{J}(K^*)$, where for $\mathcal{E}_{\mathsf{success}} = \mathcal{E}_{\mathsf{success},1}$ or $\mathcal{E}_{\mathsf{success}} = \mathcal{E}_{\mathsf{success},2}$,

$$R_1 = \mathbf{E}\left[\mathbf{1}(\mathcal{E}_{\text{success}})\sum_{k=2}^{k_{\text{fin}}} J_k\right], \quad R_2 = \mathbf{E}\left[\mathbf{1}(\mathcal{E}_{\text{success}}^c)\sum_{t=\tau_1+1}^T c_t\right], \quad \text{ and } \quad R_3 = \mathbf{E}\left[\sum_{t=1}^{\tau_1} c_t\right], \quad (6)$$

are the costs due to success, failure, and the first epoch respectively. Here, J_k are the epoch costs defined as $J_k = \sum_{t=\tau_k}^{\tau_{k+1}} c_t$. In the settings of both Section 3.1 and Section 3.2, R_3 is given by $\tau_1 \operatorname{tr} \left(P_{K_0} (I + \sigma_1^2 B^\star (B^\star)^\top) \right)$, while R_2 is controlled using the upper bounds on the state and controller to obtain a bound on the cost, which is then multiplied by the small probability of the failure event. To control R_1 , we show that under the success event, the closeness condition Lemma 1 is satisfied. As a result, the cost of each epoch J_k is $(\tau_k - \tau_{k-1}) \mathcal{J}(K^\star)$ in addition to a term proportional to $(\tau_k - \tau_{k-1}) \left(\left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \right\|_F^2 + \sigma_k^2 \right)$. Using the estimation error bounds of events $\mathcal{E}_{\text{est},1}$ and $\mathcal{E}_{\text{est},2}$ along with the choices for σ_k^2 in the two settings, we find that the quantity $R_1 - T \mathcal{J}(K^\star)$ is proportional to $\sqrt{T} \log T + \sqrt{d(\hat{\Phi}, \Phi^\star)T}$ in the setting of Section 3.1, and $\log^2 T + d(\hat{\Phi}, \Phi^\star)^2 T$ in the setting of Section 3.2. Combining terms provides the expected regret bounds in Theorems 2 and 3^{10} .

4. Numerical Example

To validate the trends predicted by our bounds, we run Algorithm 1 on the system (1) where A^* and B^* are obtained by linearizing and discretizing the cartpole dynamics defined by the equations $(M+m)\ddot{x}+m\ell(\ddot{\theta}\cos(\theta)-\dot{\theta}^2\sin(\theta))=u$, and $m(\ddot{x}\cos(\theta)+\ell\ddot{\theta}-g\sin(\theta))=0$, for cart mass M=1, pole mass m=1, pole length $\ell=1$, and gravitiy g=1. Discretization uses Euler's approach with stepsize 0.25. The disturbance signal is generated as $w_t \sim \mathcal{N}(0,0.01I)$.

We consider various inputs for the representation estimate $\hat{\Phi}$ and the exploration sequence $\sigma_1^2,\ldots,\sigma_{k_{\rm fin}}^2$. The remaining parameters are discussed in Appendix A. Note that the requirements on the size of the misspecification and on the length of the initial epoch in Theorems 2 and 3 are quite stringent. In the numerical examples, we choose values that do not satisfy these assumptions. However, the predicted trends still hold.




Figure 1: Regret of Algorithm 1 with various choices for $\hat{\Phi}$.

No Misspecification: In Figure 1, we plot the regret of Algorithm 1 in the absence of misspecification, i.e. $d(\hat{\Phi}, \Phi^*) = 0$. We consider several instances for the representation: one for fully unknown A^* and B^* , one which encodes a setting where the A^* matrix is known up to an unknown scaling, and one which captures a lumped parameter model where the discretized and linearized cartpole structure is known up to scale, but the values of the entries which vary with cart mass, pole mass, and pole length are unknown. We additionally

consider extending the lumped parameter representation by adding a basis vector that ensures the condition in Assumption 3 is violated. For the representation capturing fully unknown A^* and B^* , and the extended lumped parameter representation, the condition in Assumption 3 is not satisfied, so we run Algorithm 1 with exploration noise scaling as $\sigma_k^2 \propto \frac{1}{\sqrt{2^k}}$, and incur \sqrt{T} regret, as predicted by Theorem 2. The extended lumped parameter representation incurs regret at a slower rate than the setting when the system is fully unknown. This is predicted by Theorem 2 due to the fact that the extended lumped parameter model has $d_\theta = 6 < 20 = d_X(d_X + d_U)$, so the coefficient on the \sqrt{T}




Figure 2: We plot the regret of Algorithm 1 with $\hat{\Phi}$ describing a lumped parameter model (right), or a lumped parameter model and extended such that the condition Assumption 3 is violated (left). In both settings the representations are perturbed, resulting in a misspecification between the true representation Φ^* and the representation estimate $\hat{\Phi}$. The regret is compared to that incurred by running Algorithm 1 with a fully unknown A^* and B^* .

term is smaller. For the remaining settings, Assumption 3 is satisfied, so we run the algorithm with no additional exploration and incur logarithmic regret, as predicted in Theorem 3.

Artificial Misspecification: In Figure 2, we compare the regret from the fully unknown setting to the regret with a misspecified lumped parameter representation. Figure 2(a) considers the lumped parameter representation that is extended such that Assumption 3 is violated. Therefore the learner must continually inject noise to the system in order to explore. We artificially create misspecification by adding small perturbations to the true representation such that $d(\hat{\Phi}, \Phi^*) > 0$. We see that in the low data regime, the regret incurred is less than that incurred when the model is fully unknown. When the misspecification level is 0.05, the bias in the identification due to the misspecification causes the regret to rapidly overtake the regret from the fully unknown setting. When the misspecification is small, the regret remains less than that from the fully unknown setting for the entire horizon of T values that are plotted. Figure 2(b) considers the lumped parameter setting without the extension, for which Assumption 3 is satisfied. As in Figure 2(a), we add a perturbation to the representation to create misspecification. In this setting, we consider much larger perturbations, such that $d(\hat{\Phi}, \Phi^*)$ is 0.1, 0.15, or 0.20. For all three such situations, the regret begins much smaller than that of the fully unknown model, but overtakes it as T becomes large.




Figure 3: Regret of Alg. 1 with $\hat{\Phi}$ learned offline from related systems.

Learned Representation: In Figure 3, we consider a setting motivated by multi-task learning, in which a representation is learned using offline data from several systems related to the system of interest. In particular, we collect trajectories of length 1200 from five discretized and linearized cartpole systems generated with various values of the parameters (M, m, ℓ) . The resulting data is in turn used to fit a a representation $\hat{\Phi}$. Once the representation is obtained, we run Algorithm 1 in the absence of exploratory input. We see

that the regret incurred is much lower than the setting in which the dynamics are fully unknown

for the small data regime, but overtakes it as T becomes large. This aligns with the results from the artificial misspecification experiment. By computing the distance between the learned and true lumped parameter representations, we find that $d(\hat{\Phi}, \Phi^*) = 0.2041$.

It is worth noting that, although our focus was on the statistical benefit of using a pre-trained representation, there are clear computation benefits as well. In particular, each epoch solves a linear regression problem of dimension d_{θ} as opposed to $d_{\mathsf{X}}(d_{\mathsf{X}}+d_{\mathsf{U}})$ in the setting of learning from scratch. The computational complexity of linear regression is d^3 . Therefore, in our examples where $d_{\theta}=5$ and $d_{\mathsf{X}}(d_{\mathsf{X}}+d_{\mathsf{U}})=20$, our estimation procedure yields a 64 times computational speed up.

5. Conclusion

We studied adaptive LQR in the presence of misspecification between the learner's simple model structure for the dynamics, and the true dynamics. Our proposed algorithm performs well in both experiments and theory as long as this misspecification is sufficiently small. Our analysis shows a phase shift in the problem that depends on whether the learner's prior knowledge enables identification of the unknown parameters without additional exploration, thus allowing regret that is logarithmic in T. There are many interesting avenues for future work, including extending the analysis to settings where a collection of nonlinear basis functions for the dynamics are misspecified, e.g., by modifying the model studied in Kakade et al. (2020). Another direction is to analyze the setting where the learner's simple model is updated online by sharing data from a collection of related systems, as in recent work on federated learning in dynamical systems (Wang et al., 2023).

Appendix A. Additional Experimental Details

The matrices A^* and B^* considered in Section 4 are given as follows:

$$A^{\star} = \begin{bmatrix} 1 & 0.25 & 0 & 0 \\ 0 & 1 & -0.25 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0.5 & 1 \end{bmatrix}, B^{\star} = \begin{bmatrix} 0 \\ 0.25 \\ 0 \\ -0.25 \end{bmatrix}.$$
 (7)

We consider Q = I, and R = I. We keep the values of K_0 , τ_1 , x_b , and K_b fixed across all experiments as $\begin{bmatrix} 0.37 & 1.64 & 4.49 & 3.89 \end{bmatrix}$, 1024, 50, and 15. We replace the condition $\|x_t\|^2 \ge x_b^2 \log T$ from line 5 of Algorithm 1 with $\|x_t\|^2 \ge x_b$. These modifications are made because the guarantees in Section 3 are not anytime, but rather require the number of timesteps T which the algorithm is to be run as an input to the algorithm. For sake of efficiently plotting the regret against time, we remove the dependence of the algorithm on T, and keep these parameters fixed across time. Despite the discrepancy, we observe that the predicted trends still hold.

Learned Representation The parameter values used for the systems which generate the offline data are $(M, m, \ell) = (0.4, 1.0, 1.0)$, (1.6, 1.3, 0.3), (1.3, 0.7, 0.65), (0.2, 0.06, 1.36) and, (0.2, 0.47, 1.83). The data from the is collected with process noise $w_t \sim \mathcal{N}(0, 0.01I)$, and inputs $u_t = K_0 x_t + \eta_t$, where $\eta_t \sim \mathcal{N}(0, I)$. The representation is determined by jointly optimizing Φ along with the system specific parameter values θ to solve the least squares problem

$$\hat{\Phi}, \hat{\theta}^{(1)}, \dots, \hat{\theta}^{(5)} = \operatorname*{argmin}_{\Phi, \theta^{(1)}, \dots, \theta^{(5)}} \sum_{i=1}^{5} \sum_{t=1}^{1199} \left\| x_{t+1}^{(i)} - \mathsf{vec}^{-1} \Big(\Phi \theta^{(i)} \Big) \begin{bmatrix} x_{t}^{(i)} \\ u_{t}^{(i)} \end{bmatrix} \right\|^{2},$$

where the superscript (i) indicates which of the five systems the data is collected from.

Appendix B. Estimation Error Bounds

We begin by considering a general estimation problem in which the system is excited by an arbitrary stabilizing controller K and excitation level defined by σ_u . In particular, we consider the evolution of the following system:

$$x_{t+1} = A^* x_t + B^* u_t + w_t u_t = K x_t + \sigma_u g_t,$$
 (8)

where $g_t \overset{i.i.d.}{\sim} \mathcal{N}(0,I)$, and w_t is a random variable with σ^2 -sub-Gaussian entries satisfying $\mathbf{E}[w_t w_t^{\top}] = I$. We assume that $\sigma_u^2 \leq 1$ and that x_1 is a random variable. We consider generating the estimates $\hat{\theta}, \Lambda = \mathbb{LS}(\hat{\Phi}, x_{1:t+1}, u_{1:t})$. We present a bound on the estimation error $\left\|\hat{\Phi}\hat{\theta} - \Phi^{\star}\theta^{\star}\right\|^2$ in terms of the true system parameters as well as the amount of data, t.

Before presenting our main estimation result, we define the shorthand $A_K \triangleq A^* + B^*K$. We also use the \mathcal{H}_{∞} norm, defined below.

Definition 4 The \mathcal{H}_{∞} norm of a stable matrix A is given by

$$||A||_{\mathcal{H}_{\infty}} = \sup_{z \in \mathbb{C}, |z|=1} ||(zI - A)^{-1}||.$$

Theorem 5 (least squares estimation error) Let $\delta \in (0, 1/2)$. Suppose $t \ge c\tau_{ls}(K, ||x_1||^2, \delta)$ for

$$\tau_{\mathsf{ls}}(K, \bar{x}, \delta) \triangleq \max \left\{ \sigma^4 \left\| P_K \right\|^3 \Psi_{B^\star}^2 \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \right), \bar{x} \times \left\| P_K \right\| + 1 \right\}$$

and a sufficiently large universal constant c > 0. There exists an event \mathcal{E}_{ls} which holds with probability at least $1 - \delta$ under which the estimation error satisfies

$$\begin{split} & \left\| \hat{\Phi} \hat{\theta} - \Phi^{\star} \theta^{\star} \right\|^{2} \lesssim \frac{d_{\theta} \sigma^{2}}{t \lambda_{\min} \left(\bar{\Delta}^{t}(\sigma_{u}, K) \right)} \log \left(\frac{1}{\delta} \right) \\ & + \left(1 + \frac{\sigma^{4} \left\| P_{K} \right\|^{7} \Psi_{B^{\star}}^{6} \left(d_{X} + d_{U} + \log \frac{1}{\delta} \right)}{t \lambda_{\min} (\bar{\Delta}^{t}(\sigma_{u}, K))^{2}} \right) \frac{\left\| P_{K} \right\|^{2} \Psi_{B^{\star}}^{2} d(\hat{\Phi}, \Phi^{\star})^{2} \left\| \theta^{\star} \right\|^{2}}{\lambda_{\min} (\bar{\Delta}^{t}(\sigma_{u}, K))}. \end{split}$$

where

$$\bar{\Delta}^t(\sigma_u, K) \triangleq \hat{\Phi}^\top \left(\frac{1}{t} \sum_{s=0}^{t-2} \sum_{j=0}^s \begin{bmatrix} I \\ K \end{bmatrix} A_K^j (\sigma_u^2 B^\star (B^\star)^\top + I) \left(A_K^j \right)^\top \begin{bmatrix} I \\ K \end{bmatrix}^\top + \begin{bmatrix} 0 & 0 \\ 0 & \sigma_u^2 I_{d_{\mathsf{U}}} \end{bmatrix} \right) \hat{\Phi}.$$

Toward proving the above theorem, we first define a mapping from the noise sequence and the state x_1 to the stacked sequence of states that is be used throughout the section. In particular,

$$\begin{bmatrix} x_1 \\ x_2 \\ \vdots \\ x_t \end{bmatrix} = \begin{bmatrix} F_1^t(K, \sigma_u) \mid F_2^t(K, \sigma_u) \end{bmatrix} \begin{bmatrix} \frac{x_1}{\eta_t} \end{bmatrix}, \tag{9}$$

where $\eta_t \triangleq \begin{bmatrix} \begin{bmatrix} w_1^\top & g_1^\top \end{bmatrix} & \dots & \begin{bmatrix} w_{t-1}^\top & g_{t-1}^\top \end{bmatrix} \end{bmatrix}^\top$ and

$$\left[\begin{array}{c|cccc} F_1^t(K, \sigma_u) & F_2^t(K, \sigma_u) \end{array} \right] \triangleq \left[\begin{array}{c|cccc} I & 0 & 0 & \dots & 0 \\ A_K & \left[I & B^\star \sigma_u \right] & 0 & \dots & 0 \\ \vdots & & \ddots & & \\ A_K^{t-1} & A_K^{t-2} & \left[I & B^\star \sigma_u \right] & \dots & & \left[I & B^\star \sigma_u \right] \end{array} \right].$$

Using the fact that $\begin{bmatrix} x_t \\ u_t \end{bmatrix} = \begin{bmatrix} I \\ K \end{bmatrix} x_t + \begin{bmatrix} 0 \\ \sigma_u g_t \end{bmatrix}$, we may express the stacked states and inputs as

$$\begin{bmatrix}
x_1 \\ u_1 \\ \vdots \\ x_t \\ u_t
\end{bmatrix} = \left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix}\right) F_1^t(K, \sigma_u) x_1 + \left(\left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix}\right) F_2^t(K, \sigma_u) + \left(I_t \otimes \begin{bmatrix} 0 & 0 \\ 0 & \sigma_u I_{d_0} \end{bmatrix}\right)\right) \eta$$

$$\triangleq \Xi_1^t(K, \sigma_u) x_1 + \Xi_2^t(K, \sigma_u) \eta. \tag{10}$$

We additionally define two quantities related to the empirical covariance matrix. In particular, we define the expected value of the empirical covariance matrix conditioned on the state at the start of the sequence, x_1 , along with the centered counterpart:

$$\begin{split} & \Sigma^t(K, \sigma_u, x_1) \triangleq \mathbf{E} \left[\frac{1}{t} \sum_{s=1}^t \begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top | x_1 \right] \text{ and } \\ & \bar{\Sigma}^t(K, \sigma_u, x_1) \triangleq \mathbf{E} \left[\frac{1}{t} \sum_{s=1}^t \left(\begin{bmatrix} x_s \\ u_s \end{bmatrix} - \mathbf{E} \left[\begin{bmatrix} x_s \\ u_s \end{bmatrix} | x_1 \right] \right) \left(\begin{bmatrix} x_s \\ u_s \end{bmatrix} - \mathbf{E} \left[\begin{bmatrix} x_s \\ u_s \end{bmatrix} | x_1 \right] \right)^\top \right]. \end{split}$$

Lemma 2 (Epoch-wise covariance bounds) For $t \ge 2$, we have

Points 1 and 2: These results follow by expressing the states and inputs in terms of the noise sequence and x_1 , then using the fact that the noise terms are independent, with mean zero and identity covariance.

Point 3: The first inequality is immediate from point one by the fact that

$$\succeq \frac{1}{2} \begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} + \begin{bmatrix} 0 & 0 \\ 0 & \sigma_{u}^{2} I_{d_{U}} \end{bmatrix}.$$

By Lemma F.6 of Dean et al. (2018),

To conclude, we pull out $\frac{1}{2}$, and we see that $\min\left\{1, \frac{1}{2\|K\|^2 + \sigma_u^2}\right\} \ge \frac{1}{1 + 2\|K\|^2 + \sigma_u^2}$.

Point 4: Using the fact that for $vv^{\top} \leq ||v||^2 I$, we find

$$\begin{split} &\frac{1}{t} \sum_{s=0}^{t-1} \begin{bmatrix} I \\ K \end{bmatrix} A_K^s x_1 x_1^\top (A_K^s)^\top \begin{bmatrix} I \\ K \end{bmatrix}^\top \\ &\preceq \|x_1\|^2 \frac{1}{t} \sum_{s=0}^{t-1} \begin{bmatrix} I \\ K \end{bmatrix} A_K^s (A_K^s)^\top \begin{bmatrix} I \\ K \end{bmatrix}^\top \\ &\preceq \|x_1\|^2 \left\| \sum_{s=0}^{t-1} A_K^s (A_K^s)^\top \right\| \frac{1}{t} \begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^\top \\ &\preceq \frac{\|x_1^2\|}{t-1} \|\text{dlyap}[A_K]\| \frac{t-1}{t} \begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^\top \\ &\preceq \frac{\|x_1^2\|}{t-1} \|P_K\| \bar{\Sigma}^t (K, \sigma_u, x_1). \end{split}$$

Point 5: By the fact that $\sigma_u^2 \leq 1$ we have from the triangle inequality and submultiplicativity that

$$\begin{split} \left\| \bar{\Sigma}^t(K, \sigma_u, x_1) \right\| &= \left\| \frac{1}{t-1} \sum_{s=0}^{t-2} \sum_{j=0}^{s} \begin{bmatrix} I \\ K \end{bmatrix} A_K^j (\sigma_u^2 B^\star (B^\star)^\top + I) \left(A_K^j \right)^\top \begin{bmatrix} I \\ K \end{bmatrix}^\top + \begin{bmatrix} 0 & 0 \\ 0 & \sigma_u^2 I_{d_0} \end{bmatrix} \right\| \\ &\leq 1 + \left(1 + \|K\|^2 \right) \left(\|B^\star\|^2 + 1 \right) \left\| \frac{1}{t} \sum_{t=0}^{t-2} \sum_{j=0}^{t} A_K^j \left(A_K^j \right)^\top \right\| \\ &\leq 1 + \left(1 + \|K\|^2 \right) \left(\|B^\star\|^2 + 1 \right) \left\| \sum_{j=0}^{\infty} A_K^j \left(A_K^j \right)^\top \right\| \\ &= 1 + \left(1 + \|K\|^2 \right) \left(\|B^\star\|^2 + 1 \right) \|\text{dlyap}[A_K]\| \\ &\leq 1 + \left(1 + \|K\|^2 \right) \left(\|B^\star\|^2 + 1 \right) \|P_K\| \\ &\leq 5 \|P_K\|^2 \Psi_{B^\star}^2, \end{split}$$

where the final point follows from the fact that $||K||^2 \le ||Q + K^\top RK|| \le ||P_K||$, $||P_K|| \ge 1$, and the definition of Ψ_{B^*} .

To analyze the estimate $\hat{\theta}$, we first verify that it solves the least squares problem of interst.

Lemma 3 Consider applying Algorithm 2 to an estimated model structure $\hat{\Phi}$, state data $x_{1:t+1}$ and input data $u_{1:t}$: $\hat{\theta}$, $\Lambda = LS(\hat{\Phi}, x_{1:t+1}, u_{1:t})$. As long as $\Lambda \succ 0$, then $\hat{\theta}$ is the unique solution to

$$\underset{\theta}{\operatorname{argmin}} \sum_{s=1}^{t} \left\| x_{s+1} - \operatorname{vec}^{-1}(\hat{\Phi}\theta) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\|^{2}. \tag{11}$$

Proof By the vectorization identity $vec(XYZ) = (Z^{\top} \otimes X) vec(Y)$, we may write

$$\operatorname{vec}^{-1}(\hat{\Phi} heta)egin{bmatrix} x_s \ u_s \end{bmatrix} = \left(egin{bmatrix} x_s \ u_s \end{bmatrix}^ op \otimes I_{d\mathsf{X}} \right) \hat{\Phi} heta.$$

Minimizing
$$\sum_{s=1}^{t} \left\| x_{s+1} - \left(\begin{bmatrix} x_s \\ u_s \end{bmatrix}^{\top} \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \theta \right\|^2$$
 over θ yields $\hat{\theta}$.

We now split the estimation error into a part arising from the variance and a part arising from the bias. The variance decays as t grows sufficiently large. The bias is due to the misspecificiation between the model structure estimate $\hat{\Phi}$ and the true model structure Φ^* .

Lemma 4 Consider applying Algorithm 2 to an estimated model structure $\hat{\Phi}$, state data $x_{1:t+1}$ and input data $u_{1:t}$: $\hat{\theta}$, $\Lambda = LS(\hat{\Phi}, x_{1:t+1}, u_{1:t})$. Suppose that $\Lambda > 0$. Let

$$\bar{\theta} = \underset{\theta}{\operatorname{argmin}} (\hat{\Phi}\theta - \Phi^{\star}\theta^{\star})^{\top} (\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}}) (\hat{\Phi}\theta - \Phi^{\star}\theta^{\star}). \tag{12}$$

We have that

$$\left\|\hat{\Phi}\hat{\theta} - \Phi^{\star}\theta^{\star}\right\|^{2} \leq \underbrace{2\left\|\hat{\Phi}\hat{\theta} - \hat{\Phi}\bar{\theta}\right\|^{2}}_{variance} + \underbrace{2\left\|\hat{\Phi}\bar{\theta} - \Phi^{\star}\theta^{\star}\right\|^{2}}_{bias}.$$
 (13)

Proof The lemma follows by application of the triangle inequality.

The variance term in the above lemma is bounded in Lemma 10, while the bias term is bounded in Lemma 11. Before presenting these lemmas, we present several covariance concentration guarantees that will be useful in obtaining presenting the variance bound.

B.1. Covariance Concentration

The following ε -net argument is standard. A proof may be found in Chapter 4 of Vershynin (2020).

Lemma 5 Let W be and $d \times d$ random matrix, and $\varepsilon \in [0, 1/2)$. Furthermore, let \mathcal{N} be an ε -net of \mathcal{S}^{d-1} with minimal cardinality. Then for all $\rho > 0$,

$$\mathbb{P}[\|W\| > \rho] \leq \left(\frac{2}{\varepsilon} + 1\right)^d \max_{x \in \mathcal{N}} \mathbb{P}\Big[\Big| x^\top W x \Big| > (1 - 2\epsilon)\rho \Big].$$

The following lemma helps to bound system constants in term of a few key quantities.

Lemma 6 (Lemma B.11 of Simchowitz and Foster (2020)) For a stabilizing controller K, we have that for any t, $||A_K^t|| \le \sqrt{\left(1 - \frac{1}{\|P_K\|}\right)^t \|P_K\|}$ and $\sum_{t=0}^{\infty} ||A_K^t|| \le 2 \|P_K\|^{3/2}$. As a consequence, we also have $||A_K||_{\mathcal{H}_{\infty}} \le 2 ||P_K||^{3/2}$.

Proof For the first point, observe that

$$||A_K^t|| = \sqrt{||(A_K^t)^\top A_K^t||} \le \sqrt{||(A_K^t)^\top P_K A_K^t||} \le \sqrt{\left(1 - \frac{1}{||P_K||}\right)^t ||P_K||}.$$

For we may use the first point to show that

$$= ||P_K||^{1/2} \frac{1 + \sqrt{1 - \frac{1}{||P_K||}}}{1/||P_K||}$$

$$\le 2 ||P_K||^{3/2}.$$

The result on the \mathcal{H}_{∞} norm of A_K follows from the previous point by noting that $\|A_K\|_{\mathcal{H}_{\infty}} \leq \sum_{t=0}^{\infty} \|A_K^t\|$.

We now present a result about the concentration of the empirical covariance to the true covariance. The result is adapted from Lemma 2 of Jedra and Proutiere (2020) and Lemma A.2 of Zhang et al. (2023a), which generalized the approximate isometries argument in Jedra and Proutiere (2020) to account for projecting the covariance onto a lower dimensional space by hitting it on either side with a low rank orthonormal matrix. The primary difference of the below result from that in Zhang et al. (2023a) is the inclusion of a nonzero initial state, resulting in an additional sub-gaussian concentration step.

Lemma 7 (Approximate Isometries) Let data $x_{1:t}$, $u_{1:t}$ be generated by (8). Let $G \in \mathbb{R}^{d_{\mathsf{c}}(d_{\mathsf{X}}+d_{\mathsf{U}})\times d_{G}}$ be a matrix with orthonormal columns. Define

$$M \triangleq \left(G^{\top} \left(\Sigma^t(K, \sigma_u, x_1) \otimes I_{d_c} \right) G \right)^{-1/2}.$$

Then for some positive universal constant C, and for any $\rho < 1$, the inequality

$$\left\| MG^{\top} \left(\frac{1}{\tau_{k-1}} \sum_{t=\tau_{k-1}}^{\tau_{k}-1} \begin{bmatrix} x_{t} \\ u_{t} \end{bmatrix} \begin{bmatrix} x_{t} \\ u_{t} \end{bmatrix}^{\top} \otimes I_{d_{c}} \right) GM - I \right\| > \rho$$

holds with probability at most

$$4 \times 9^{d_G} \exp \left(-C \frac{\min\{\rho, \rho^2\}t}{\sigma^4 \|P_K\|^3 \Psi_{B^*}^2} \right),$$

Proof Define the shorthand

$$X \triangleq \frac{1}{\sqrt{t}} \begin{bmatrix} x_1^\top & u_1^\top \\ \vdots & \vdots \\ x_t^\top & u_t^\top \end{bmatrix} \otimes I_{d_{\mathsf{c}}}$$

such that

$$\left(\frac{1}{t}\sum_{s=1}^{t} \begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^{\top} \otimes I_{d_c}\right) = X^{\top}X.$$

First note that $\mathbf{E}[G^{\top}X^{\top}XG|x_1] = M^{-2}$. Then

$$\|MG^{\top}X^{\top}XGM - I\| = \sup_{v \in \mathcal{S}^{d_G}} \left| v^{\top} \left(MG^{\top}X^{\top}XGM - I \right) v \right|$$

$$= \sup_{v \in \mathcal{S}^{d_G}} \left| v^{\top}MG^{\top}X^{\top}XGMv - \mathbf{E} \left[v^{\top}MG^{\top}X^{\top}XGMv | x_1 \right] \right|$$

$$= \sup_{v \in \mathcal{S}^{d_G}} \left| \|XGMv\|^2 - \mathbf{E} \left[\|XGMv\|^2 | x_1 \right] \right|.$$
(14)

Using the identity $\text{vec}(WYZ) = (Z^{\top} \otimes W) \text{vec}(Y)$, we may write

$$\operatorname{vec}\left(v^{\top}M^{\top}G^{\top}X^{\top}\right) = (I_{t \times d_{\mathsf{X}}} \otimes (GMv)^{\top})\operatorname{vec}(X^{\top}) \triangleq \sigma_{GMv}\operatorname{vec}(X^{\top}). \tag{15}$$

Next, we construct matrices $\Gamma_1^t(K, \sigma_u)$ and $\Gamma_2^t(K, \sigma_u)$ such that $\text{vec}(X^\top) = \Gamma_1^t(K, \sigma_u)x_1 + \Gamma_2^t(K, \sigma_u)\eta_t$. To construct these matrices, first recall the definition of $\Xi_1^t(K, \sigma_u)$ and $\Xi_2^t(K, \sigma_u)$ given in (10) and of $F_1^t(K, \sigma_u)$ and $F_2^t(K, \sigma_u)$ given in (9). To reach $\text{vec}(X^\top)$ from the vector of stacked states and inputs, we can apply the following transformation:

$$\operatorname{vec}(X^{\top}) = \frac{1}{\sqrt{t}} \left(I_t \otimes \begin{bmatrix} I_{d_{\mathsf{X}} + d_{\mathsf{U}}} \otimes e_1 \\ \vdots \\ I_{d_{\mathsf{X}} + d_{\mathsf{U}}} \otimes e_{d_{\mathsf{c}}} \end{bmatrix} \right) \begin{bmatrix} x_1 \\ u_1 \\ \vdots \\ x_t \\ u_t \end{bmatrix} \triangleq \frac{1}{\sqrt{t}} H \begin{bmatrix} x_1 \\ u_1 \\ \vdots \\ x_t \\ u_t \end{bmatrix}.$$

Combining the above sequence of transformation implies that by defining $\Gamma_1^t(K, \sigma_u) \triangleq \frac{1}{t}H\Xi_1^t(K, \sigma_u)$ and $\Gamma_2^t(K, \sigma_u) \triangleq \frac{1}{t}H\Xi_2^t(K, \sigma_u)$, we have $\text{vec}(X^\top) = \Gamma_1 x_1 + \Gamma_2^t(K, \sigma_u)\eta_t$. Using the above expression, our quantity of interest in (14) may be expressed as

$$\begin{split} &\left\|MG^{\top}X^{\top}XGM - I\right\| \\ &= \sup_{v \in \mathcal{S}^{d_{G}}} \left\|\left\|\sigma_{GMv}\left(\Gamma_{1}^{t}(K,\sigma_{u})x_{1} + \Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right)\right\|^{2} - \mathbf{E}\left[\left\|\sigma_{GMv}\left(\Gamma_{1}^{t}(K,\sigma_{u})x_{1} + \Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right)\right\|^{2} |x_{1}\right]\right| \\ &= \sup_{v \in \mathcal{S}^{d_{G}}} \left\|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} + \left\|\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1}\right\|^{2} + 2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle \\ &- \mathbf{E}\left[\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} + \left\|\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1}\right\|^{2} + 2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle |x_{1}\right] \\ &\stackrel{(i)}{=} \sup_{v \in \mathcal{S}^{d_{G}}} \left\|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} + 2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle - \mathbf{E}\left[\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2}\right] \right| \\ &\stackrel{(ii)}{=} \sup_{v \in \mathcal{S}^{d_{G}}} \left\|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} + 2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} \right| \\ &\leq \sup_{v \in \mathcal{S}^{d_{G}}} \left\|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2} + \frac{2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} \\ &\leq \sup_{v \in \mathcal{S}^{d_{G}}} \left\|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2} + \frac{2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2} + \frac{2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle}{\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2}} \right\}$$

where (i) follows from linearity of expectation and the substition rule of conditional expectation, combined with the fact that η has mean zero and is independent of x_1 . Equality (ii) follows from the fact that η_t is mean zero with identity covariance.

To bound the concentration of the quadratic form, we invoke Theorem 6.3.2 of Vershynin (2020). In particular, there exists a universal constant C > 0 such that

$$\Pr\left[\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2} - \left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2}\right] \leq 2\exp\left(-C\frac{\min\left\{\rho^{2}/\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2},\rho\right\}}{\sigma^{4}\left\|\sigma_{GM_{k}v}\Gamma_{2}^{t}(K,\sigma_{u})\right\|^{2}}\right).$$
(16)

For the cross term, we invoke a standard sub-Gaussian tail bound (Vershynin, 2020) to show that for any fixed $v \in S^{d_G}$,

$$\Pr\left[\left|2\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\rangle\right| > \frac{\rho}{2}\right] \\
\leq 2\exp\left(-\frac{1}{16}\rho^{2}\frac{1}{\sigma^{2}\left\|\Gamma_{2}^{t}(K,\sigma_{u})^{\top}\sigma_{GMv}^{\top}\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1}\right\|^{2}}\right). \tag{17}$$

We now seek to simplify the denominators appearing in the exponents for each of the probability bounds above. First, note that we have

$$\begin{split} & \left\| \sigma_{GMv} \Gamma_1^t(K, \sigma_u) x_1 \right\|^2 + \left\| \sigma_{GMv} \Gamma_2^t(K, \sigma_u) \right\|_F^2 \\ & = \operatorname{tr} \left(\sigma_{GMv} \Gamma_1^t(K, \sigma_u) x_1 x_1^\top \Gamma_1^t(K, \sigma_u)^\top \sigma_{GMv}^\top \right) + \operatorname{tr} \left(\sigma_{GMv} \Gamma_2^t(K, \sigma_u) \Gamma_2^t(K, \sigma_u)^\top \sigma_{GMv}^\top \right) \\ & = \operatorname{tr} \left(\sigma_{GMv} \left(\Gamma_1^t(K, \sigma_u) x_1 x_1^\top \Gamma_1^t(K, \sigma_u)^\top + \Gamma_2^t(K, \sigma_u) \Gamma_2^t(K, \sigma_u)^\top \right) \sigma_{GMv}^\top \right) \\ & = \mathbf{E} \left[\operatorname{tr} \left(\sigma_{GMv} \operatorname{vec}(X^\top) \operatorname{vec}(X^\top)^\top \sigma_{GMv}^\top \right) | x_1 \right], \end{split}$$

where the final equality follows from the fact that η_t is mean zero with identity covariance and independent form x_1 combined with the construction of $\Gamma_1^t(K, \sigma_u)$ and $\Gamma_2^t(K, \sigma_u)$. Employing the identity in (15), we find

$$\mathbf{E}\Big[\mathrm{tr}\Big(\sigma_{GMv}\operatorname{vec}(X^\top)\operatorname{vec}(X^\top)^\top\sigma_{GMv}^\top\Big)|x_1\Big] = \mathbf{E}\Big[v^\top MG^\top X^\top XGMv|x_1\Big] = 1,$$

where the final equality follows by the definition of M and the fact that $\|v\|^2=1$. The above computations provide identity $\|\sigma_{GMv}\Gamma_1^t(K,\sigma_u)x_1\|^2+\|\sigma_{GMv}\Gamma_2^t(K,\sigma_u)\|_F^2=1$. We therefore have $\|\sigma_{GMv}\Gamma_2^t(K,\sigma_u)\|_F^2\leq 1$ and $\|\sigma_{GMv}\Gamma_1^t(K,\sigma_u)x_1\|^2\leq 1$. As a result, the quantity in the denominator of the exponential in (17) is bounded as

$$\left\| \Gamma_2^t(K, \sigma_u)^\top \sigma_{GMv}^\top \sigma_{GMv} \Gamma_1^t(K, \sigma_u) x_1 \right\| \leq \left\| \sigma_{GMv} \Gamma_2^t(K, \sigma_u) \right\| \left\| \sigma_{GMv} \Gamma_1^t(K, \sigma_u) x_1 \right\| \leq \left\| \sigma_{GMv} \Gamma_2^t(K, \sigma_u) \right\|.$$

Therefore, the probability bounds in (16) and (17) may be modified to read

$$\Pr\left[\left|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2}-\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2}\right| \geq \frac{\rho}{2}\right] \leq 2\exp\left(-C\frac{\min\left\{\rho,\rho^{2}\right\}}{\sigma^{4}\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|^{2}}\right)$$

$$\Pr\left[\left|2\left\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\rangle\right| > \frac{\rho}{2}\right] \leq 2\exp\left(-\frac{1}{16}\rho^{2}\frac{1}{\sigma^{2}\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|^{2}}\right).$$

Union bounding over the above two events, and using the assumption that $\sigma^2 \geq 1$ implies that for some universal constant C > 0,

$$\Pr\left[\left|\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\|^{2}-\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|_{F}^{2}\right|+\left|2\left\langle\sigma_{GMv}\Gamma_{1}^{t}(K,\sigma_{u})x_{1},\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\eta_{t}\right\rangle\right|>\rho\right]$$

$$\leq 4\exp\left(-C\frac{\min\{\rho,\rho^{2}\}}{\sigma^{4}\left\|\sigma_{GMv}\Gamma_{2}^{t}(K,\sigma_{u})\right\|^{2}}\right).$$

We may now invoke the covering argument in Lemma 5 with $\varepsilon = \frac{1}{4}$ to show that there exists a universal positive constant C such that

$$\Pr\left[\left\|MG^{\top}X^{\top}XGM - I\right\| > \rho\right] \le 4 \times 9^{d_G} \exp\left(-C\frac{\min\{\rho, \rho^2\}}{\sigma^4 \left\|\sigma_{GMv}\Gamma_2^t(K, \sigma_u)\right\|^2}\right). \tag{18}$$

To conclude, we must bound the term $\|\sigma_{GMv}\Gamma_2^t(K,\sigma_u)\|$. To do so, we write

$$\begin{split} \left\| \sigma_{GMv} \Gamma_2^t(K, \sigma_u) \right\| &= \frac{1}{t} \left\| \sigma_{GMv} H \Xi_2^t(K, \sigma_u) \right\| \\ &= \frac{1}{\sqrt{t}} \left\| \sigma_{GMv} H \left(\left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix} \right) F_2^t(K, \sigma_u) + \left(I_t \otimes \begin{bmatrix} 0 & 0 \\ 0 & \sigma_u I_{d_0} \end{bmatrix} \right) \right) \right\| \\ &\leq \frac{1}{\sqrt{t}} \left(\underbrace{ \left\| \sigma_{GMv} H \left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix} \right) F_2^t(K, \sigma_u) \right\|}_{\text{state term}} + \underbrace{ \left\| \sigma_{GMv} H \left(I_t \otimes \begin{bmatrix} 0 & 0 \\ 0 & \sigma_u I_{d_0} \end{bmatrix} \right) \right\|}_{\text{input noise term}} \right). \end{split}$$

For the state term, we have

$$\left\| \sigma_{GMv} H\left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix}\right) \Psi_1 \right\| \leq \left\| \sigma_{GMv} H\left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix}\right) \right\| \left\| F_2^t(K, \sigma_u) \right\|.$$

The second term quantifies the system's amplification of an exogenous input, and is bounded by the \mathcal{H}_{∞} norm of the system $\|\begin{bmatrix} A_K \mid \begin{bmatrix} I & \sigma_u B^* \end{bmatrix} \end{bmatrix}\|_{\mathcal{H}_{\infty}}$ (Tilli, 1998, Corollary 4.2). This, in turn, is bounded by the \mathcal{H}_{∞} norm of the matrix A_K multiplied by the spectral norm of the input matrix, yielding

$$\left\| F_2^t(K, \sigma_u) \right\| \le \left\| A_K \right\|_{\mathcal{H}_{\infty}} (\left\| B^{\star} \right\| + 1)$$

We may bound the first quantity as

$$\begin{split} & \left\| \sigma_{GMv} H \bigg(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix} \bigg) \right\| \\ & = \left\| (I_{t \times d_c} \otimes (GMv)^\top) \left(I_t \otimes \begin{bmatrix} I_{d_X + d_U} \otimes e_1 \\ \vdots \\ I_{d_X + d_U} \otimes e_{d_c} \end{bmatrix} \right) \left(I_t \otimes \begin{bmatrix} I \\ K \end{bmatrix} \right) \right\| \\ & \stackrel{(i)}{=} \left\| (I_{d_c} \otimes (GMv)^\top) \begin{bmatrix} I_{d_X + d_U} \otimes e_1 \\ \vdots \\ I_{d_X + d_U} \otimes e_{d_c} \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix} \right\| \\ & \stackrel{(ii)}{=} \sup_{w \in \mathcal{S}^{d_X}} \left\| (I_{d_c} \otimes (GMv)^\top) \begin{bmatrix} I_{d_X + d_U} \otimes e_1 \\ \vdots \\ I_{d_X + d_U} \otimes e_{d_c} \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix} w \right\| \\ & \stackrel{(iii)}{=} \sup_{w \in \mathcal{S}^{d_X}} \left\| \operatorname{vec} v^\top M G^\top \operatorname{vec}^{-1} \left(\begin{bmatrix} I_{d_X + d_U} \otimes e_1 \\ \vdots \\ I_{d_X + d_U} \otimes e_{d_c} \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix} w \right) \right\| \\ & \stackrel{(iv)}{=} \sup_{w \in \mathcal{S}^{d_X}} \left\| \operatorname{vec} v^\top M G^\top \left(\left(\begin{bmatrix} I \\ K \end{bmatrix} w \right) \otimes I_{d_c} \right) \right\| \end{split}$$

where (i) follows by the following kronecker product identities: $I_{a+b} \otimes W = I_a \otimes (I_b \otimes W)$, $(A \otimes B)(C \otimes D) = AC \otimes BD$, and $\|I \otimes W\| = \|W\|$. Equality (ii) follows by definition of the operator norm, and equality (iii) follows by the vectorization identity $\text{vec}(WYZ) = (Z^{\top} \otimes W) \text{vec}(Y)$. Equality (iv) follows by the definition of the inverse vectorization operation. The quantity in the norm above may now be written as the inner product of a vector with itself. In particular, we have

$$\begin{split} \sup_{w \in \mathcal{S}^{d_{\mathsf{X}}}} \left\| \mathsf{vec} \, v^{\top} M G^{\top} \left(\left(\begin{bmatrix} I \\ K \end{bmatrix} w \right) \otimes I_{d_{\mathsf{c}}} \right) \right\| \\ &= \sup_{w \in \mathcal{S}^{d_{\mathsf{X}}}} \sqrt{v^{\top} M G^{\top} \left(\left(\begin{bmatrix} I \\ K \end{bmatrix} w w^{\top} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} \right) \otimes I_{d_{\mathsf{c}}} \right) G M v} \\ &\stackrel{(i)}{\leq} \sup_{w \in \mathcal{S}^{d_{\mathsf{X}}}} \sqrt{v^{\top} M G^{\top} \left(\left(\begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} \right) \otimes I_{d_{\mathsf{c}}} \right) G M v} \\ &\stackrel{(ii)}{\leq} 2 \sup_{w \in \mathcal{S}^{d_{\mathsf{X}}}} \sqrt{v^{\top} M G^{\top} \left(\Sigma^{t} (K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{c}}} \right) G M v} \leq 2, \end{split}$$

where inequality (i) follows by the fact that $ww^{\top} \leq I$, and inequality (ii) follows from the fact that $\begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} \leq 2\Sigma^t(K, \sigma_u, x_1)$, as may be verified by examining the expression for $\bar{\Sigma}^t(K, \sigma_u, x_1)$

in Lemma 2. We may similarly show that the input term is bounded by one:

$$\left\| \sigma_{GMv} H \left(I_t \otimes \begin{bmatrix} 0 & 0 \\ 0 & \sigma_u I_{d_U} \end{bmatrix} \right) \right\| \leq 1.$$

Combining results we have the bound $\|\sigma_{GMv}\Gamma_2^t(K,\sigma_u)\| \leq \frac{1}{\sqrt{t}}(1+2\|F_2^t(K,\sigma_u)\|) \leq \frac{5}{\sqrt{t}}\|P_K\|^{3/2}\Psi_{B^\star,\sigma_w}$, where we used the result of Lemma 6 to bound $\|A_K\|_{\mathcal{H}_\infty}$ in terms of $\|P_K\|$. Substituting this result into the bound in (18), we find that for some universal constant C,

$$\Pr\left[\left\|MG^{\top}X^{\top}XGM - I\right\| > \rho\right] \le 4 \times 9^{d_G} \exp\left(-C\frac{d\min\{\rho, \rho^2\}t}{\sigma^4 \|P_K\|^3 \Psi_{B^{\star}}^2}\right),$$

which concludes our proof.

Lemma 8 (Covariance Concentration) For a sufficiently large universal positive constant c, we have that as long as $t \ge c\sigma^4 \|P_K\|^3 \Psi_{B^*}^2 \left(d_\theta + \log \frac{1}{\delta}\right)$, the event

$$\mathcal{E}_{\mathsf{conc}} = \left\{ \frac{1}{2} \hat{\Phi}^\top \big(\Sigma^t(K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \big) \hat{\Phi} \preceq \frac{1}{t} \sum_{s=1}^t \hat{\Phi}^\top \bigg(\begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top \otimes I_{d_{\mathsf{X}}} \bigg) \hat{\Phi} \preceq 2 \hat{\Phi}^\top \big(\Sigma^t(K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \big) \hat{\Phi} \right\}$$

holds with probability at least $1 - \frac{\delta}{2}$.

Proof The result follows by invoking Lemma 7 with $G \leftarrow \hat{\Phi}$ and $\rho \leftarrow \frac{1}{2}$. We invert the probability bound by setting $\frac{\delta}{2} = 4 \times 9^{d_{\theta}} \exp\left(-C \frac{t}{\sigma^4 \|P_K\|^3 \Psi_{B^{\star}}^2}\right)$. As long as $t \geq c\sigma^4 \|P_K\|^3 \Psi_{B^{\star}}^2 \left(d_{\theta} + \log \frac{1}{\delta}\right)$ for a sufficiently large universal constant c > 0, the event holds with probability at least $1 - \frac{\delta}{2}$.

B.2. Self-Normalized Martingales

To present the self-normalized martingale bound we first recall the definitions of a filtration and an adapted process.

Definition 6 (Filtration and Adapted Process) A sequence of sub- σ -algebras $\{\mathcal{F}_s\}_{s=1}^t$ is said to be a filtration if $\mathcal{F}_s \subseteq \mathcal{F}_k$ for $s \leq k$. A stochastic process $\{w_s\}_{s=1}^t$ is said to be adapted to the filtration $\{\mathcal{F}_s\}_{s=1}^t$ if for all $s \geq 1$, w_s is \mathcal{F}_s -measurable.

The following theorem is a modification of Theorem 3.4 in Abbasi-Yadkori and Szepesvári (2011) and is a consequence of Lemma 14.7 in Peña et al. (2009).

Theorem 7 Let $\{\mathcal{F}_s\}_{s=0}^t$ be a filtration and let $\{z_s\}_{s=1}^t$ be a matrix valued stochastic process assuming values in $\mathbb{R}^{d_{\times} \times d_{\theta}}$ which is adapted to $\{\mathcal{F}_{s-1}\}_{s=1}^t$ and $\{w_s\}_{s=1}^t$ a vector valued stochastic process assuming values in $\mathbb{R}^{d_{\times}}$ which is adapted to $\{\mathcal{F}_s\}_{s=1}^t$. Additionally suppose that for all $1 \leq s \leq t$, w_t is σ^2 -conditionally sub-Gaussian with respect to \mathcal{F}_s . Let Σ be a positive definite matrix in $\mathbb{R}^{d_{\theta} \times d_{\theta}}$. Then for $\delta \in (0,1)$, the following inequality holds with probability at least $1-\delta$:

$$\left\| \left(\Sigma + \sum_{s=1}^t z_s^\top z_s \right)^{-1/2} \sum_{s=1}^t z_s^\top w_s \right\|^2 \le \sigma^2 \log \left(\frac{\det \left(\Sigma + \sum_{s=1}^t z_s^\top z_s \right)}{\det(\Sigma)} \right) + 2\sigma^2 \log \frac{1}{\delta}.$$

Proof The proof follows by applying Lemma 4.1 from Ziemann et al. (2023) with $P \leftarrow \sum_{s=1}^t \frac{z_s^\top w_s}{\sigma}$ and $Q \leftarrow \sum_{s=1}^t z_s^\top z_s$. To verify the conditions for this lemma to hold, we must verify that $\max_{\lambda \in \mathbb{R}^{d_\theta}} \mathbf{E} \exp\left(\lambda^\top P - \frac{1}{2}\lambda^\top Q\lambda\right) \leq 1$. To verify this condition, we define the quantity

$$M_s(\lambda) \triangleq \exp\left(\sum_{k=1}^s \left[\frac{\lambda^\top z_k^\top w_k}{\sigma} - \frac{1}{2}\lambda^\top z_k^\top z_k \lambda\right]\right).$$

Observe that for any $\lambda \in \mathbb{R}^{d_{\theta}}$, $M_0(\lambda) = 1$. For any $0 < s \le t$,

$$\mathbf{E} M_s(\lambda) = \mathbf{E} \mathbf{E} (M_s(\lambda | \mathcal{F}_s)) = \mathbf{E} \left(M_{s-1}(\lambda) \mathbf{E} \left(\exp \left(\frac{\lambda \top z_s^\top w_s}{\sigma} - \frac{1}{2} \lambda^\top z_s^\top z_s \lambda \right) | \mathcal{F}_s \right) \right).$$

Note that by the fact that w_s is σ^2 -conditionally sub-Gaussian with respect to \mathcal{F}_s ,

$$\begin{split} \mathbf{E} \bigg(\exp \bigg(\frac{\boldsymbol{\lambda}^{\top} \boldsymbol{z}_s^{\top} \boldsymbol{w}_s}{\sigma} - \frac{1}{2} \boldsymbol{\lambda}^{\top} \boldsymbol{z}_s^{\top} \boldsymbol{z}_s \boldsymbol{\lambda} \bigg) | \mathcal{F}_t \bigg) &= \mathbf{E} \bigg(\exp \bigg(\frac{\boldsymbol{\lambda}^{\top} \boldsymbol{z}_s^{\top} \boldsymbol{w}_s}{\sigma} | \mathcal{F}_s \bigg) \bigg) \exp \bigg(-\frac{1}{2} \boldsymbol{\lambda}^{\top} \boldsymbol{z}_s^{\top} \boldsymbol{z}_s \boldsymbol{\lambda} \bigg) \\ &\leq \exp \bigg(\boldsymbol{\lambda}^{\top} \boldsymbol{z}_s^{\top} \boldsymbol{z}_s \boldsymbol{\lambda} \bigg) \exp \bigg(-\frac{1}{2} \boldsymbol{\lambda}^{\top} \boldsymbol{z}_s^{\top} \boldsymbol{z}_s \boldsymbol{\lambda} \bigg) = 1. \end{split}$$

Therefore $\mathbf{E} M_t \leq \mathbf{E} M_{t-1}(\lambda) \leq \cdots \leq \mathbf{E} M_1(\lambda) \leq \mathbf{E} M_0(\lambda) = 1$, which verifies the requisite condition.

B.3. Variance Bound

Lemma 9 Let $\Sigma \in \mathbb{R}^{d_{\theta} \times d_{\theta}}$ be positive definite. Suppose data $x_{1:t+1}, u_{1:t}$ is generated by (8). Consider generating the least squares estimate $\hat{\theta}, \Lambda = LS(\hat{\Phi}, x_{1:t+1}, u_{1:t})$. Suppose that $\Lambda \succeq \Sigma$. There exists an event \mathcal{E}_{var} that holds with probability at least $1 - \delta/2$ under which the variance satisfies

$$\left\| \hat{\Phi} \hat{\theta} - \hat{\Phi} \bar{\theta} \right\|^2 \lesssim \frac{\sigma^2}{\lambda_{\min}(\Sigma)} \log \left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma) \delta^2} \right) + \frac{\operatorname{Conc}_{\mathsf{cov}}(\delta)^2}{\lambda_{\min}(\Sigma)^2} \left\| \Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \right\|^2,$$

where

$$\operatorname{Conc}_{\mathsf{cov}}(\delta) = \left\| \Sigma^{t}(K, \sigma_{u}, x_{1}) \right\| \max \left\{ \sqrt{t} \sigma^{2} \left\| P_{K} \right\|^{3/2} \Psi_{B^{\star}} \sqrt{d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta}}, \sigma^{4} \left\| P_{K} \right\|^{3} \Psi_{B^{\star}}^{2} \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \right) \right\}.$$

Proof By Lemma 3, $\hat{\theta}$ solves (11). Therefore,

$$\sum_{s=1}^t \left\| x_{s+1} - \mathsf{vec}^{-1}(\hat{\Phi}\hat{\theta}) \begin{bmatrix} x_s \\ u_s \end{bmatrix} \right\|^2 \le \sum_{s=1}^t \left\| x_{s+1} - \mathsf{vec}^{-1}(\hat{\Phi}\bar{\theta}) \begin{bmatrix} x_s \\ u_s \end{bmatrix} \right\|^2.$$

Inserting $x_{s+1} = \text{vec}^{-1}(\Phi^*\theta^*)\begin{bmatrix} x_s \\ u_s \end{bmatrix} + w_s$, we may rearrange the above inequality to read

$$\begin{split} &\sum_{s=1}^{t} \left\| \operatorname{vec}^{-1} \left(\hat{\Phi} \bar{\theta} - \hat{\Phi} \hat{\theta} \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\|^{2} \leq \\ &2 \sum_{s=1}^{t} \left\langle \operatorname{vec}^{-1} \left(\hat{\Phi} \left(\hat{\theta} - \bar{\theta} \right) \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix}, \operatorname{vec}^{-1} \left(\Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\rangle \\ &+ 2 \sum_{s=1}^{t} \left\langle \operatorname{vec}^{-1} \left(\hat{\Phi} \left(\hat{\theta} - \bar{\theta} \right) \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix}, w_{s} \right\rangle. \end{split}$$

Multiplying the above inequality by two, and bringing one of the sums from the right side to the left leaves us with

$$\sum_{s=1}^{t} \left\| \operatorname{vec}^{-1} \left(\hat{\Phi} \bar{\theta} - \hat{\Phi} \hat{\theta} \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\|^{2} \leq 4 \sum_{s=1}^{t} \left\langle \operatorname{vec}^{-1} \left(\hat{\Phi} \left(\hat{\theta} - \bar{\theta} \right) \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix}, \operatorname{vec}^{-1} \left(\Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\rangle \\
\text{variance from misspecification} \\
+ 4 \sum_{s=1}^{t} \left\langle \operatorname{vec}^{-1} \left(\hat{\Phi} \left(\hat{\theta} - \bar{\theta} \right) \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix}, w_{s} \right\rangle - \sum_{s=1}^{t} \left\| \operatorname{vec}^{-1} \left(\hat{\Phi} \left(\bar{\theta} - \hat{\theta} \right) \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\|^{2}. \\
\text{self-normalized process} \tag{19}$$

Bound on Self-normalized Process: We first bound the self-normalized process above. To simplify notation, we denote $z_s = \begin{pmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top \otimes I_{d_{\mathsf{X}}} \end{pmatrix} \hat{\Phi}$. By using the identity $\operatorname{vec}(XYZ) = (X^\top \otimes Z) \operatorname{vec}(Y)$, we may therefore write the self-normalized process term above as

$$4\sum_{s=1}^{t} \left\langle z_{t}(\hat{\theta} - \bar{\theta}), w_{s} \right\rangle - \sum_{s=1}^{t} \left\| z_{s}(\bar{\theta} - \hat{\theta}) \right\|^{2} \leq \sup_{\theta} \left\{ 4\sum_{s=1}^{t} \left\langle z_{s}\theta, w_{s} \right\rangle - \sum_{s=1}^{t} \|z_{s}\theta\|^{2} \right\} = 4 \left\| \Lambda^{-1/2} \sum_{s=1}^{t} z_{s}^{\top} w_{s} \right\|^{2}.$$

Using the lower bound $\Lambda \succeq \Sigma$, we have

$$4 \left\| \Lambda^{-1/2} \sum_{s=1}^t z_t^\top w_s \right\|^2 \le 8 \left\| (\Lambda + \Sigma)^{-1/2} \sum_{s=1}^t z_s^\top w_s \right\|^2.$$

Invoking the self-normalized martingale bound in Theorem 7 we find that there exists an event $\mathcal{E}_{\text{noise}}$ that holds with probability at least $1 - \delta/4$ such that under the event $\mathcal{E}_{\text{noise}}$,

$$\left\| (\Lambda + \Sigma)^{-1/2} \sum_{s=1}^t z_s^\top w_s \right\|^2 \le \sigma^2 \log \left(\frac{16 \det(\Sigma + \Lambda)}{\det(\Sigma) \delta^2} \right).$$

Bound on Variance from misspecification: We now proceed to bound the term in (19) arising due to variance from the model mispecification. To do so, note that

$$\begin{split} &\sum_{s=1}^t \bigg\langle \operatorname{vec}^{-1} \Big(\hat{\Phi} \Big(\hat{\theta} - \bar{\theta} \Big) \Big) \begin{bmatrix} x_s \\ u_s \end{bmatrix}, \operatorname{vec}^{-1} \Big(\Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \Big) \begin{bmatrix} x_s \\ u_s \end{bmatrix} \bigg\rangle \\ &= \Big(\Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \Big)^\top \bigg(\sum_{s=1}^t \bigg(\begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top \otimes I_{d_{\mathsf{X}}} \bigg) \bigg) \Big(\hat{\Phi} (\hat{\theta} - \bar{\theta}) \Big) \\ &= t \Big(\Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \Big)^\top \Big(\sum_{s=1}^t \begin{bmatrix} x_t \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top - t \sum_{s=1}^t (K, \sigma_u, x_1) \bigg) \otimes I_{d_{\mathsf{X}}} \bigg) \Big(\hat{\Phi} (\hat{\theta} - \bar{\theta}) \Big) \\ &+ \Big(\Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \Big)^\top \bigg(\sum_{s=1}^t \begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top - t \sum_{s=1}^t (K, \sigma_u, x_1) \bigg) \otimes I_{d_{\mathsf{X}}} \bigg) \Big(\hat{\Phi} (\hat{\theta} - \bar{\theta}) \Big). \end{split}$$

By the optimality of $\bar{\theta}$ in (12).

$$\left(\Phi^{\star}\theta^{\star} - \hat{\Phi}\bar{\theta}\right)^{\top} \left(\sum_{s=1}^{t} \left(\Sigma^{t}(K, \sigma_{u}) \otimes I_{d_{\mathsf{X}}}\right)\right) \left(\hat{\Phi}(\hat{\theta} - \bar{\theta})\right) = 0.$$

Therefore, we are left with

$$\begin{split} &\sum_{s=1}^t \left\langle \, \mathsf{vec}^{-1} \Big(\hat{\Phi} \Big(\hat{\theta} - \bar{\theta} \Big) \Big) \, \begin{bmatrix} x_s \\ u_s \end{bmatrix}, \mathsf{vec}^{-1} \Big(\Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \Big) \, \begin{bmatrix} x_s \\ u_s \end{bmatrix} \right\rangle \\ &= \Big(\Phi^\star \theta^\star - \hat{\Phi} \bar{\theta}_k \Big)^\top \Bigg(\Bigg(\sum_{s=1}^t \begin{bmatrix} x_s \\ u_s \end{bmatrix} \, \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top - t \Sigma^t (K, \sigma_u, x_1) \Bigg) \otimes I_{d_\mathsf{X}} \Bigg) \Big(\hat{\Phi} (\hat{\theta} - \bar{\theta}) \Big) \\ &\leq \left\| \Phi^\star \theta^\star - \hat{\Phi} \bar{\theta} \right\| \, \left\| \hat{\Phi} (\hat{\theta} - \bar{\theta}) \right\| \, \left\| \sum_{s=1}^t \begin{bmatrix} x_s \\ u_s \end{bmatrix} \, \begin{bmatrix} x_s \\ u_s \end{bmatrix}^\top - t \Sigma^t (K, \sigma_u, x_1) \right\| \, . \end{split}$$

Invoking Lemma 7 with $G = I_{d_X + d_U}$, we find that there exists an event \mathcal{E}_{cov} that holds with probability at least $1 - \delta/4$ such that under \mathcal{E}_{cov} ,

$$\left\| \sum_{s=1}^{t} \begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^{\top} - t\Sigma^t(K, \sigma_u, x_1) \right\| \lesssim \operatorname{Conc}_{\mathsf{cov}}(\delta).$$

Combining bounds: In light of the bounds on the self-normalized process and the variance from misspecification above, we define the event $\mathcal{E}_{\text{var}} = \mathcal{E}_{\text{noise}} \cap \mathcal{E}_{\text{cov}}$. This event holds with probability at least $1 - \delta/2$ by a union bound. We may substitute the bounds arising under these events into into (19), we find

$$\sum_{s=1}^{t} \left\| \mathsf{vec}^{-1} \left(\hat{\Phi} \bar{\theta} - \hat{\Phi} \hat{\theta} \right) \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \right\|^{2} \lesssim \sigma^{2} \log \left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma) \delta^{2}} \right) + \operatorname{Conc}_{\mathsf{cov}}(\delta) \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\| \left\| \hat{\Phi} (\hat{\theta} - \bar{\theta}) \right\|,$$

where we absorbed the 16 from the log in the first term into a universal constant. The left side of the above inequality may be lower bounded by $\lambda_{\min}(\Sigma) \left\| \bar{\theta} - \hat{\theta} \right\|^2$. which may in turn be lower

bounded by $\lambda_{\min}(\Sigma) \left\| \hat{\Phi} \bar{\theta} - \hat{\Phi} \hat{\theta} \right\|^2$, by the fact that $\hat{\Phi}$ has orthonormal columns. We therefore obtain the following bound:

$$\left\|\hat{\Phi}\bar{\theta} - \hat{\Phi}\hat{\theta}\right\|^2 \lesssim \frac{\sigma^2}{\lambda_{\min}(\Sigma)}\log\left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma)\delta^2}\right) + \frac{\operatorname{Conc}_{\mathsf{cov}}(\delta)}{\lambda_{\min}(\Sigma)}\left\|\Phi^{\star}\theta^{\star} - \hat{\Phi}\bar{\theta}\right\|\left\|\hat{\Phi}(\hat{\theta} - \bar{\theta})\right\|.$$

Now, if we define

$$a \triangleq \frac{\operatorname{Conc}_{\mathsf{cov}}(\delta)}{\lambda_{\min}(\Sigma)} \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\|, \quad b \triangleq \frac{\sigma^{2}}{\lambda_{\min}(\Sigma)} \log \left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma) \delta^{2}} \right), \quad x \triangleq \left\| \hat{\Phi} \hat{\theta} - \hat{\Phi} \bar{\theta} \right\|,$$

then the above inequalities may be combined to read $x^2 \le ax + b$, from which we can conclude $x \le \frac{1}{2} \left(a + \sqrt{a^2 + 4b} \right)$, or equivalently,

$$x^{2} \leq \frac{1}{4} \left(2a^{2} + 4b + 2\sqrt{a^{4} + 4a^{2}b} \right) \leq \frac{1}{4} \left(2a^{2} + 4b + 2a^{2} + 4a^{2} + 4b \right) = 2a^{2} + 2b.$$

Subtituting in the original quantities of interest and absorbing the factor of two into the universal constant concludes the proof.

Lemma 10 (Variance Bound) Suppose $t \ge c\tau_{ls}$ for c and τ_{ls} defined in Theorem 5. Then there exists an event \mathcal{E}_{ls} that holds with probability at least $1 - \delta$ under which

$$\begin{split} & \left\| \hat{\Phi} \hat{\theta} - \hat{\Phi} \bar{\theta} \right\|^2 \lesssim \frac{d_{\theta} \sigma^2}{t \lambda_{\min} \left(\hat{\Phi}^{\top} \left(\bar{\Sigma}^t (K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)} \log \left(\frac{1}{\delta} \right) \\ & + \frac{\sigma^4 \left\| \Sigma^t (K, \sigma_u, x_1) \right\|^2 \left\| P_K \right\|^3 \Psi_{B^{\star}}^2}{t \lambda_{\min} \left(\hat{\Phi}^{\top} \left(\bar{\Sigma}^t (K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)^2} \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \right) \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\|^2. \end{split}$$

Proof By the lower bound on t, the event $\mathcal{E}_{\mathsf{conc}}$ defined in Lemma 8 holds with probability at least $1 - \delta/2$. Denoting $\Sigma \leftarrow t \frac{1}{2} \hat{\Phi}^{\top} (\bar{\Sigma}^t(K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}}) \hat{\Phi}$, we may invoke Lemma 9 to show that there exists an event $\mathcal{E}_{\mathsf{var}}$ that holds with probability at least $1 - \delta/2$ such that conditioned on $\mathcal{E}_{ls} = \mathcal{E}_{\mathsf{conc}} \cap \mathcal{E}_{\mathsf{var}}$,

$$\left\|\hat{\Phi}\hat{\theta} - \hat{\Phi}\bar{\theta}\right\|^2 \lesssim \frac{\sigma^2}{\lambda_{\min}(\Sigma)} \log \left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma)\delta^2}\right) + \frac{\operatorname{Conc}_{\mathsf{cov}}(\delta)^2}{\lambda_{\min}(\Sigma)^2} \left\|\Phi^{\star}\theta^{\star} - \hat{\Phi}\bar{\theta}\right\|^2.$$

By a union bound, \mathcal{E}_{ls} holds with probability at least $1 - \delta$. Substituting the definition of $\operatorname{Conc}_{cov}$ from Lemma 9, we may simplify the above bound to find

$$\begin{split} \left\| \hat{\Phi} \hat{\theta} - \hat{\Phi} \bar{\theta} \right\|^2 &\lesssim \frac{\sigma^2}{\lambda_{\min}(\Sigma)} \log \left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma) \delta^2} \right) \\ &+ \frac{\sigma^4 \left\| \Sigma^t(K, \sigma_u, x_1) \right\|^2 \|P_K\|^3 \Psi_{B^{\star}}^2 t}{\lambda_{\min}(\Sigma)^2} \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{4}{\delta} \right) \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\|^2, \end{split}$$

where we have used the fact that

$$t \ge c\tau_{\mathsf{ls}} \ge \sigma^4 \|P_K\|^3 \Psi_{B^*}^2 \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \right),$$

to show that $Conc_{cov}$ assumes the quantity that grows with t.

The upper bound from the event \mathcal{E}_{conc} provides

$$\Lambda \leq 2t\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \leq 2t(1 + \|P_{K}\| \frac{\|x_{1}\|^{2}}{t - 1}) \hat{\Phi}^{\top} \left(\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi},$$

where the final inequality follows from Lemma 2 point 4. The log term may then be bounded as

$$\log\left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma)\delta^2}\right) \le d_{\theta}\log\left(4\frac{1 + \|P_K\| \frac{\|x_1\|^2}{t-1}}{\delta^2}\right)$$

By the fact that $t \ge c\tau_{ls} \ge \|x_1\|^2 \|P_K\| + 1$, we have $\frac{\|P_K\|\|x_1\|^2}{t-1} \le 1$. Therefore, the above quantity is bounded by $d_\theta \log \frac{8}{\delta^2} \lesssim d_\theta \log \frac{1}{\delta}$.

Substituting the expression for Σ tells us that

$$\lambda_{\min}(\Sigma) = \frac{t}{2} \lambda_{\min} \Big(\hat{\Phi}^{\top} \big(\bar{\Sigma}^t(K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \big) \hat{\Phi} \Big).$$

Substituing this into the bound on $\left\|\hat{\Phi}\hat{\theta} - \hat{\Phi}\bar{\theta}\right\|^2$ along with the upper bound on $\log\left(\frac{\det(\Sigma + \Lambda)}{\det(\Sigma)\delta^2}\right)$ completes the proof.

B.4. Bias Bound

Lemma 11 The bias of the estimate arising in Lemma 4 is bounded as

$$\left\|\hat{\Phi}\bar{\theta} - \Phi^{\star}\theta^{\star}\right\|^{2} \leq 4 \frac{\left\|\Sigma^{t}(K,\sigma_{u},x_{1})\right\|}{\lambda_{\min}(\hat{\Phi}^{\top}(\bar{\Sigma}^{t}(K,\sigma_{u},x_{1})\otimes I_{d_{X}})\hat{\Phi})} d(\hat{\Phi},\Phi^{\star})^{2} \left\|\theta^{\star}\right\|^{2}.$$

Proof

We first left multiply the quantity in the norm by the identity defined in terms of the matrix $\hat{\Phi}\hat{\Phi}^{\top}(\Sigma^t(K,\sigma_u,x_1)\otimes I_{d_{\mathsf{X}}})\hat{\Phi}\hat{\Phi}^{\top}+\hat{\Phi}_{\perp}\hat{\Phi}_{\perp}^{\top}$ left multiplied by its inverse:

$$\begin{split} \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\|^{2} &= \left\| (\hat{\Phi} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \\ &\times \left(\hat{\Phi} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right) \left(\Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right) \right\|^{2}. \end{split}$$

To simplify the above quantity, firstly observe that the term

$$\hat{\Phi}_{\perp}\hat{\Phi}_{\perp}^{\top} \left(\Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right) = \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \Phi^{\star} \theta^{\star} \tag{20}$$

by the fact that $\hat{\Phi}_{\perp}^{\top}\hat{\Phi}=0$. Second, note that the term

$$\hat{\Phi}\hat{\Phi}^{\top} (\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}}) \hat{\Phi}\hat{\Phi}^{\top} (\Phi^{\star}\theta^{\star} - \hat{\Phi}\bar{\theta})$$

$$= \hat{\Phi}\hat{\Phi}^{\top} (\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}}) \hat{\Phi}\hat{\Phi}^{\top} \Phi^{\star}\theta^{\star} - \hat{\Phi}\hat{\Phi}^{\top} (\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}}) \hat{\Phi}\bar{\theta}$$

by the fact that the columns of $\hat{\Phi}$ are orthonormal. We now substitute the optimal projection

$$\bar{\theta} = \left(\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)^{-1} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \Phi^{\star} \theta^{\star}$$

into the above to find that

$$\begin{split} \hat{\Phi}\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) & \hat{\Phi}\hat{\Phi}^\top \left(\Phi^\star \theta^\star - \hat{\Phi}\bar{\theta} \right) \\ &= \hat{\Phi}\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \hat{\Phi}\hat{\Phi}^\top \Phi^\star \theta^\star \\ &- \hat{\Phi}\hat{\Phi}^\top \left(\Sigma_k \otimes I_{d_\mathsf{X}} \right) \hat{\Phi} \left(\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \hat{\Phi} \right)^{-1} \hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \Phi^\star \theta^\star \\ &= \hat{\Phi}\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \hat{\Phi}\hat{\Phi}^\top \Phi^\star \theta^\star - \hat{\Phi}\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \Phi^\star \theta^\star \\ &= \hat{\Phi}\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \left(\hat{\Phi}\hat{\Phi}^\top - I_{d_\mathsf{X}} \right) \Phi^\star \theta^\star \\ &= -\hat{\Phi}\hat{\Phi}^\top \left(\Sigma^t(K,\sigma_u,x_1) \otimes I_{d_\mathsf{X}} \right) \hat{\Phi}_\perp \hat{\Phi}^\top_\perp \Phi^\star \theta^\star. \end{split}$$

$$\begin{split} & \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\|^{2} \\ &= \left\| (\hat{\Phi} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \left(I - \hat{\Phi} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \right) \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \Phi^{\star} \theta^{\star} \right\|^{2} \\ &\leq \left\| (\hat{\Phi} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \left(I - \hat{\Phi} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \right) \hat{\Phi}_{\perp} \right\|^{2} \left\| \hat{\Phi}_{\perp}^{\top} \Phi^{\star} \right\|^{2} \| \theta^{\star} \|^{2} \,. \end{split}$$

Application of the triangle inequality and Cauchy-Schwarz yields

$$\begin{split}
& \left\| (\hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}\hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \left(I - \hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \right) \hat{\Phi}_{\perp} \right\|^{2} \\
& \leq 2 \left\| (\hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}\hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \hat{\Phi}_{\perp} \right\|^{2} \\
& + 2 \left\| (\hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}\hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}_{\perp} \right\|^{2}.
\end{split}$$
(22)

The first term may be simplified as follows:

$$\begin{split} & \left\| (\hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}\hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \hat{\Phi}_{\perp} \right\|^{2} \\ &= \left\| \left(\begin{bmatrix} \hat{\Phi} & \hat{\Phi}_{\perp} \end{bmatrix} \begin{bmatrix} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} & I \end{bmatrix} \begin{bmatrix} \hat{\Phi} & \hat{\Phi}_{\perp} \end{bmatrix}^{\top} \right)^{-1} \hat{\Phi}_{\perp} \right\|^{2} \\ &= \left\| \begin{bmatrix} \hat{\Phi} & \hat{\Phi}_{\perp} \end{bmatrix} \begin{bmatrix} \hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} & I \end{bmatrix}^{-1} \begin{bmatrix} \hat{\Phi} & \hat{\Phi}_{\perp} \end{bmatrix}^{\top} \hat{\Phi}_{\perp} \right\|^{2} \\ &= 1. \end{split} \tag{23}$$

For the second term, we may similarly show that

$$\begin{split} & \left\| (\hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}\hat{\Phi}^{\top} + \hat{\Phi}_{\perp} \hat{\Phi}_{\perp}^{\top} \right)^{-1} \hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I \right) \hat{\Phi}_{\perp} \right\|^{2} \\ & = \left\| (\hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}\hat{\Phi}^{\top} \right)^{\dagger} \hat{\Phi}\hat{\Phi}^{\top} \left(\Sigma^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}_{\perp} \right\|^{2} \\ & \leq \frac{\left\| \Sigma^{t}(K, \sigma_{u}, x_{1}) \right\|}{\lambda_{\min} (\hat{\Phi}^{\top} (\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}}) \hat{\Phi})}, \end{split}$$

where the final inequality follows from submultiplicativity, the fact that $\hat{\Phi}$ has orthonormal columns and the fact that $\Sigma^t(K, \sigma_u, x_1) \leq \bar{\Sigma}^t(K, \sigma_u, x_1)$.

The lemma follows by substituting the above inequality along with (23) into (22). The result is then substituted into (21), where we recall the definition Theorem 1.

Proof Combining the results of Lemma 4 with Lemma 10, we find that under the event \mathcal{E}_{ls} of Lemma 10,

$$\begin{split} & \left\| \hat{\Phi} \hat{\theta} - \hat{\Phi} \bar{\theta} \right\|^2 \lesssim \frac{d_{\theta} \sigma^2}{t \lambda_{\min} \Big(\hat{\Phi}^{\top} \big(\bar{\Sigma}^t(K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \big) \hat{\Phi} \big)} \log \left(\frac{1}{\delta} \right) \\ & + \left(1 + \frac{\sigma^4 \left\| \Sigma^t(K, \sigma_u, x_1) \right\|^2 \left\| P_K \right\|^3 \Psi_{B^{\star}}^2}{t \lambda_{\min} \Big(\hat{\Phi}^{\top} \big(\bar{\Sigma}^t(K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \big) \hat{\Phi} \big)^2} \Big(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \Big) \right) \left\| \Phi^{\star} \theta^{\star} - \hat{\Phi} \bar{\theta} \right\|^2. \end{split}$$

Using Lemma 11, the above may be bounded as

$$\begin{split} & \left\| \hat{\Phi} \hat{\theta} - \hat{\Phi} \bar{\theta} \right\|^2 \lesssim \frac{d_{\theta} \sigma^2}{t \lambda_{\min} \left(\hat{\Phi}^{\top} \left(\bar{\Sigma}^t (K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right) \log \left(\frac{1}{\delta} \right)} \\ & + \left(1 + \frac{\sigma^4 \left\| \Sigma^t (K, \sigma_u, x_1) \right\|^2 \left\| P_K \right\|^3 \Psi_{B^{\star}}^2}{t \lambda_{\min} \left(\hat{\Phi}^{\top} \left(\bar{\Sigma}^t (K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)^2} \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \right) \right) \\ & \times \frac{\left\| \Sigma^t (K, \sigma_u, x_1) \right\|}{\lambda_{\min} \left(\hat{\Phi}^{\top} \left(\bar{\Sigma}^t (K, \sigma_u, x_1) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)} d(\hat{\Phi}, \Phi^{\star})^2 \left\| \theta^{\star} \right\|^2. \end{split}$$

To conclude, we use the upper bounds on $\|\Sigma^t(K, \sigma_u, x_1)\|$ from Lemma 2:

$$\left\| \Sigma^{t}(K, \sigma_{u}, x_{1}) \right\| \leq \left(1 + \|P_{K}\| \frac{\|x_{1}^{2}\|}{t - 1} \right) \left\| \bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \right\| \leq 5 \left(1 + \|P_{K}\| \frac{\|x_{1}^{2}\|}{t - 1} \right) \|P_{K}\|^{2} \Psi_{B^{*}}^{2}.$$

By the fact that $t \geq c\tau_{ls}$, the above quantity is bounded as $\|\Sigma^t(K, \sigma_u, x_1)\| \leq 10 \|P_K\|^2 \Psi_{B^*}^2$. Therefore we find that

$$\begin{split} \left\| \hat{\Phi} \hat{\theta} - \Phi^{\star} \theta^{\star} \right\|^{2} &\lesssim \frac{d_{\theta} \sigma^{2}}{t \lambda_{\min} \left(\hat{\Phi}^{\top} \left(\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right) \log \left(\frac{1}{\delta} \right)} \\ &+ \left(1 + \frac{\sigma^{4} \left\| P_{K} \right\|^{7} \Psi_{B^{\star}}^{6} \left(d_{\mathsf{X}} + d_{\mathsf{U}} + \log \frac{1}{\delta} \right)}{t \lambda_{\min} (\hat{\Phi}^{\top} \left(\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)^{2}} \right) \frac{\left\| P_{K} \right\|^{2} \Psi_{B^{\star}}^{2} d(\hat{\Phi}, \Phi^{\star})^{2} \left\| \theta^{\star} \right\|^{2}}{\lambda_{\min} (\hat{\Phi}^{\top} \left(\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi} \right)^{2}} \end{split}$$

Appendix C. High Probability Bounds on the Success Events

We first state a more complete counterpart of Lemma 1 that also characterize the error in the learned controller gain and the Lyapunov equation solution $P_{\hat{K}}$ under this controller.

Lemma 12 (Theorem 3 of Simchowitz and Foster (2020)) Define $\varepsilon \triangleq \frac{1}{2916\|P^{\star}(A^{\star},B^{\star})\|^{10}}$. As long as $\| \begin{bmatrix} \hat{A} & \hat{B} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \|_F^2 \leq \varepsilon$, we have that $P_{\hat{K}} \preceq \frac{21}{20}P^{\star}$, $\| \hat{K} - K^{\star} \| \leq \frac{1}{6\|P^{\star}\|^{3/2}}$, and

$$\mathcal{J}(\hat{K}) - \mathcal{J}(K^{\star}) \le 142 \|P^{\star}\|^{8} \| \begin{bmatrix} \hat{A} & \hat{B} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \|_{F}^{2}.$$

Lemma 13 Let $\delta \in (0,1)$. With probability at least $1-\delta$

$$\max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\| \le 4\sigma \sqrt{(d_{\mathsf{X}} + d_{\mathsf{U}}) \log \frac{T}{\delta}}.$$

Proof The vectors w_t and g_t have σ^2 -sub-Gaussian components. Therefore, a sub-Gaussian tail bound tells us that for any unit vector $v \in \mathbb{R}^{d_X + d_U}$

$$\mathbb{P}\bigg[v^{\top}\begin{bmatrix}w_t\\g_t\end{bmatrix} \ge \rho\bigg] \le \exp\bigg(-\frac{\rho^2}{2\sigma^2}\bigg).$$

By a covering argument, we therfore conclude

$$\mathbb{P}\left[\left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\| \ge \rho \right] \le 5^{d_{\mathsf{X}} + d_{\mathsf{U}}} \exp\left(-\frac{\rho^2}{8\sigma^2}\right).$$

Union bounding over the T timesteps yields

$$\mathbb{P}\left[\max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\| \geq \rho \right] \leq T5^{d_{\mathsf{X}} + d_{\mathsf{U}}} \exp\left(-\frac{\rho^2}{8\sigma^2}\right).$$

Setting $\rho = 4\sigma \sqrt{(d_{\mathsf{X}} + d_{\mathsf{U}}) \log \frac{T}{\delta}}$, the above probability becomes

$$T5^{d_{\mathsf{X}}+d_{\mathsf{U}}} \exp \left(-2(d_{\mathsf{X}}+d_{\mathsf{U}})\log \frac{T}{\delta}\right) \le T5^{d_{\mathsf{X}}+d_{\mathsf{U}}} \exp \left(-2(d_{\mathsf{X}}+d_{\mathsf{U}})-\log \frac{T}{\delta}\right)$$

$$\le \delta 5^{d_{\mathsf{X}}+d_{\mathsf{U}}} \exp (-2)^{d_{\mathsf{X}}+d_{\mathsf{U}}} \le \delta.$$

Lemma 14 Consider rolling out the system $x_{s+1} = A^*x_s + B^*u_s + w_s$ from initial state x_1 for t timesteps under the control action $u_s = Kx_s + \sigma_u g_s$ where K is stabilizing and $\sigma_u \leq 1$. Then the following bound holds:

$$||x_t|| \le \sqrt{\left(1 - \frac{1}{\|P_K\|}\right)^t \|P_K\| \|x_1\| + 2 \|P_K\|^{3/2} \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|}$$

Proof The states may be expressed as $x_t = A_K^{t-1} x_1 + \sum_{k=0}^{t-1} A_K^{t-1-k} \begin{bmatrix} I & \sigma_u B^* \end{bmatrix} \begin{bmatrix} w_k \\ g_k \end{bmatrix}$. Therefore, by Lemma 6,

Lemma 15 Consider rolling out the system $x_{s+1} = A^*x_s + B^*u_s + w_s$ from initial state x_1 for t timesteps under the control action $u_s = Kx_s + \sigma_u g_s$ where K is stabilizing and $\sigma_u \leq 1$. Suppose

$$||x_1|| \le 16 ||P_{K_0}||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|$$

• $||P_K|| \le 2 ||P_{K_0}||$

•
$$t \ge \log_{\left(1 - \frac{1}{\|P_K\|}\right)} \left(\frac{1}{4\|P_K\|}\right) + 1.$$

Then for $s = 1, \ldots, t$

$$||x_s|| \le 40 ||P_{K_0}||^2 \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|.$$

Furthermore,

$$||x_t|| \le 16 ||P_{K_0}||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|.$$

Proof By Lemma 14,

$$||x_s|| \le ||P_K||^{1/2} ||x_1|| + 2 ||P_K||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|$$

$$\le 2 ||P_{K_0}||^{1/2} ||x_1|| + 8 ||P_{K_0}||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|$$

The bound in the first point then follows by substituting in the bound for $||x_1||$. For the second point, note that by Lemma 14, and the fact that $t \ge \log_{\left(1 - \frac{1}{||P_K||}\right)} \left(\frac{1}{4||P_K||}\right) + 1$,

$$||x_{t}|| \leq \frac{1}{2} ||x_{1}|| + 2 ||P_{K}||^{3/2} \Psi_{B^{*}} \max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_{t} \\ g_{t} \end{bmatrix} \right\|$$

$$\leq \frac{1}{2} ||x_{1}|| + 8 ||P_{K_{0}}||^{3/2} \Psi_{B^{*}} \max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_{t} \\ g_{t} \end{bmatrix} \right\|$$

$$\leq 16 ||P_{K_{0}}||^{3/2} \Psi_{B^{*}} \max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_{t} \\ g_{t} \end{bmatrix} \right\|.$$

Lemma 16 Running Algorithm 1 with the arguments defined in Theorem 2, the event $\mathcal{E}_{\text{success},1}$ holds with probability at least $1-T^{-2}$.

Proof By Lemma 13, we have that with probability at least $1 - \frac{1}{2}T^{-2}$,

$$\max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\| \leq 4\sigma \sqrt{3(d_{\mathsf{X}} + d_{\mathsf{U}}) \log 2T}.$$

Denote the event that the above inequality holds by $\mathcal{E}_{w \, bound}$. We show by induction that the requisite conditions of $\mathcal{E}_{success,1}$ hold for all epochs. A key step in this argument is instantiating the result of Theorem 5 for every epoch. The rate of decay in this bound is the determined by minimum eigenvalue of the state and input covariance, $\lambda_{\min}(\hat{\Phi}^{\top}(\bar{\Sigma}^t(K,\sigma_u,x_1)\otimes I_{d_X})\hat{\Phi})$. We control this quantity by invoking point 3 of Lemma 2 along with the facts that 1) $\hat{\Phi}$ has orthonormal columns and 2) $\sigma_u = \sigma_k \leq 1$ for all epochs due to the lower bound on τ_1 . In particular, we may show that

$$\lambda_{\min}(\hat{\Phi}^{\top}(\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{X}})\hat{\Phi}) \geq \frac{\sigma_{u}^{2}}{2(2 + 2\|K\|^{2})} \geq \frac{\sigma_{u}^{2}}{8\|P_{K}\|},$$
(24)

where the final inequality follows by noting that $2 + 2 \|K\|^2 \le 2 + 2 \|P_K\| \le 4 \|P_K\|$ by the fact that $\|P_K\| \ge 1$.

Base Case: For the first epoch, observe that our lower bound on τ_1 ensures that $\tau_1 \geq c\tau_{ls}(K_0,0,\frac{1}{2}T^{-3})$ for a sufficiently large constant c. Therefore applying Theorem 5 along with (24) implies that there exists an event $\mathcal{E}_{ls,1}$ which holds with probability at least $\frac{1}{2}T^{-3}$ such that under $\mathcal{E}_{ls,1}$,

$$\begin{split} & \left\| \begin{bmatrix} \hat{A}_1 & \hat{B}_1 \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \right\|_F^2 \lesssim \frac{d_\theta \sigma^2 \left\| P_{K_0} \right\|}{\tau_1 \sigma_1^2} \log(T) \\ & + \left(1 + \frac{\sigma^4 \left\| P_{K_0} \right\|^9 \Psi_{B^\star}^6 (d_\mathsf{X} + d_\mathsf{U} + \log(T))}{\tau_1 \sigma_1^4} \right) \frac{\left\| P_{K_0} \right\|^3 \Psi_{B^\star}^2 d(\hat{\Phi}, \Phi^\star)^2 \left\| \theta^\star \right\|^2}{\sigma_1^2}. \end{split}$$

Using the fact that $\sigma_1^2 \geq \frac{\sqrt{d_\theta/d_U}}{\sqrt{\tau_1}}$ to simplify the first appearance of σ_1 , and $\sigma_1^2 \geq d(\hat{\Phi}, \Phi^*)^{1/2}$ for the last two appearances, the above bound simplifies to

$$\begin{aligned} \| \begin{bmatrix} \hat{A}_{1} & \hat{B}_{1} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \|_{F}^{2} & \lesssim \frac{\sqrt{d_{\theta}d_{\mathsf{U}}}\sigma^{2} \|P_{K_{0}}\|}{\sqrt{\tau_{1}}} \log(T) \\ + \sigma^{4} \frac{d_{\theta}}{d_{\mathsf{U}}} \|P_{K_{0}}\|^{12} \Psi_{B^{\star}}^{8} (d_{\mathsf{X}} + d_{\mathsf{U}}) d(\hat{\Phi}, \Phi^{\star})^{1/2} \|\theta^{\star}\|^{2}, \end{aligned}$$

where we have used the fact that $d_X + d_U + \log T \le (d_X + d_U) \log T$ and that $\tau_1 \ge \log T$ to remove the $\log T$ term from the numerator. By recalling the definition of β_1 from Assumption 2, the above bound can be simplified to

$$\left\| \begin{bmatrix} \hat{A}_1 & \hat{B}_1 \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \right\|_F^2 \le C_{\mathsf{est},1} \sigma^2 \frac{\sqrt{d_{\theta} d_{\mathsf{U}}} \, \|P_{K_0}\|}{\sqrt{\tau_1}} \log(T) + \beta_1 d(\hat{\Phi}, \Phi^{\star})^{1/2}.$$

Meanwhile, Lemma 15 tells us that under the event $\mathcal{E}_{\text{w bound}}$, $\|x_t\|^2 \leq x_b^2 \log T$ for $t = 1, \dots, \tau_1$, and that $\|x_{\tau_1}\| \leq 16 \|P_{K_0}\|^{3/2} \Psi_{B^*} \max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|$. Finally, we have $\|K_0\| \leq K_b$.

Induction step: Suppose

$$||x_{\tau_k}|| \le 16 ||P_{K_0}||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} || \begin{bmatrix} w_t \\ g_t \end{bmatrix} ||$$

and

$$\left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \right\|_F^2 \leq C_{\mathsf{est},1} \sigma^2 \frac{\sqrt{d_\theta d_\mathsf{U}} \left\| P_{K_0} \right\|}{\sqrt{\tau_1 2^{k-1}}} \log(T) + \beta_1 \sqrt{d(\hat{\Phi}, \Phi^\star)}.$$

By the assumptions that $\tau_1 \geq c \left(\frac{\sigma^2 \sqrt{d_\theta d_0} \|P_{K_0}\|}{2\varepsilon} \log T\right)^2$ for a sufficiently large constant c and that $d(\hat{\Phi}, \Phi^\star) \leq \frac{\varepsilon^2}{4\beta_1^2}$, we have that $\left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \right\|_F^2 \leq \varepsilon$. Then the conditions of Lemma 12 are satisfied, and consequently, $\left\| P_{\hat{K}_{k+1}} \right\| \leq 1.05 \, \|P^\star\|$. Therefore

$$\tau_{\mathsf{ls}}(\hat{K}_{k+1}, x_b^2 \log T, \frac{1}{2} T^{-3}) \leq 2\tau_{\mathsf{ls}}(K^\star, x_b^2 \log T, \frac{1}{2} T^{-3}) \quad \text{ and } \quad \left\| P_{\hat{K}_{k+1}} \right\| \leq 1.05 \left\| P_{K_0} \right\| \leq 2 \left\| P_{K_0} \right\|.$$

We may use our lower bound on τ_1 to conclude that $\tau_1 \geq c\tau_{\rm ls}(K^\star, x_b^2 \log T, \frac{1}{2}T^{-3})$ for a sufficiently large universal constant c. This guarantees that the conditions of Theorem 5 are satisfied. As a result, there exists an event $\mathcal{E}_{{\rm ls},k+1}$ that holds with probability at least $1-\frac{1}{2}T^{-3}$ under which

$$\begin{split} & \left\| \left[\hat{A}_{k+1} \quad \hat{B}_{k+1} \right] - \left[A^{\star} \quad B^{\star} \right] \right\|_{F}^{2} \lesssim \frac{d_{\theta} \sigma^{2} \left\| P_{\hat{K}_{k+1}} \right\|}{(\tau_{k+1} - \tau_{k}) \sigma_{k+1}^{2}} \log(T) \\ & + \left(1 + \frac{\sigma^{4} \left\| P_{\hat{K}_{k+1}} \right\|^{9} \Psi_{B^{\star}}^{6} (d_{\mathsf{X}} + d_{\mathsf{U}} + \log(T))}{(\tau_{k+1} - \tau_{k}) \sigma_{k+1}^{4}} \right) \frac{\left\| P_{\hat{K}_{k+1}} \right\|^{3} \Psi_{B^{\star}}^{2} d(\hat{\Phi}, \Phi^{\star})^{2} \left\| \theta^{\star} \right\|^{2}}{\sigma_{k+1}^{2}}, \end{split}$$

where we have again used (24) to simplify the bound. Observing that $\tau_{k+1} - \tau_k = \frac{1}{2}\tau_{k+1}$, and using the lower bounds $\sigma_{k+1}^2 \geq \frac{\sqrt{d_\theta/d_0}}{\sqrt{\tau_{1}2^k}} = \frac{\sqrt{d_\theta/d_0}}{\sqrt{\tau_{k+1}}}$ and $\sigma_{k+1}^2 \geq \gamma d(\hat{\Phi}, \Phi^\star)^{1/2} \geq d(\hat{\Phi}, \Phi^\star)^{1/2}$, the above bound simplifies to

$$\begin{aligned} & \left\| \begin{bmatrix} \hat{A}_{k+1} & \hat{B}_{k+1} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \right\|_{F}^{2} \lesssim \frac{\sqrt{d_{\theta}d_{\mathsf{U}}}\sigma^{2} \left\| P_{\hat{K}_{k+1}} \right\|}{\sqrt{\tau_{k+1}}} \log(T) \\ & + \sqrt{d_{\theta}/d_{\mathsf{U}}}\sigma^{4} \left\| P_{\hat{K}_{k+1}} \right\|^{12} \Psi_{B^{\star}}^{8}(d_{\mathsf{X}} + d_{\mathsf{U}}) d(\hat{\Phi}, \Phi^{\star})^{1/2} \left\| \theta^{\star} \right\|^{2}. \end{aligned}$$

Using the fact that $\left\|P_{\hat{K}_{k+1}}\right\| \leq 1.05 \left\|P^{\star}\right\| \leq 1.05 \left\|P_{K_0}\right\|$, the above bound may be simplified to

$$\| \begin{bmatrix} \hat{A}_{k+1} & \hat{B}_{k+1} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \|_F^2 \le C_{\mathsf{est},1} \sigma^2 \frac{\sqrt{d_{\theta} d_{\mathsf{U}}} \| P_{K_0} \|}{\sqrt{\tau_{k+1}}} \log(T) + \beta_1 d(\hat{\Phi}, \Phi^{\star})^{1/2},$$

where the powers of 1.05 are absorbed into the universal constants, and β_1 is as defined in Assumption 2.

Furthermore, Lemma 15 (which applies due to the inductive hypothesis, the lower bound on τ_1 , and the fact that $\|P_{\hat{K}_{k+1}}\| \le 2 \|P_{K_0}\|$) informs us that under the event $\mathcal{E}_{\mathsf{w}\,\mathsf{bound}}$,

$$||x_t||^2 \le x_b^2 \log T \quad \forall t = \tau_k + 1, \dots, \tau_{k+1}, \text{ and } ||x_{\tau_{k+1}}|| \le 16 ||P_{K_0}||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} || \begin{bmatrix} w_t \\ g_t \end{bmatrix} ||.$$

Also observe that $\left\|\hat{K}_{k+1}\right\|^2 \leq \left\|P_{\hat{K}_{k+1}}\right\| \leq 2 \left\|P_{K_0}\right\|$, which ensures that $\left\|\hat{K}_{k+1}\right\| \leq 2 \left\|K^\star\right\| \leq K_b$. In particular, we have verified that the algorithm does not abort on this epoch, and we have verified that the inductive hypothesis holds to start the next epoch.

Union bounding over the events The bounds on the norm of the state and the controller gain ensure that the algorithm does not abort. The estimation error bounds ensure that

$$\left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \right\|_F^2 \leq C_{\mathsf{est},1} \sigma^2 \frac{\sqrt{d_\theta d_\mathsf{U}} \left\| P_{K_0} \right\|}{\sqrt{\tau_1}} \log(T) + \beta_1 d(\hat{\Phi}, \Phi^\star)^{1/2} \quad \forall k \geq 1.$$

Therefore, $\mathcal{E}_{\text{success},1} \subseteq \mathcal{E}_{\text{w bound}} \cap \mathcal{E}_{\text{ls},1} \cap \cdots \cap \mathcal{E}_{\text{ls},k_{\text{fin}}}$. Union bounding over the good events $\mathcal{E}_{\text{w bound}}, \mathcal{E}_{\text{ls},1}, \ldots, \mathcal{E}_{\text{ls},k_{\text{fin}}}$, we find that $\mathcal{E}_{\text{success},1}$ holds with probability at least $1-T^{-2}$.

Lemma 17 Running Algorithm 1 with the arguments defined in Theorem 3, the event $\mathcal{E}_{success,2}$ holds with probability at least $1-T^{-2}$.

Proof By Lemma 13, we have that with probability at least $1 - \frac{1}{2}T^{-2}$,

$$\max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\| \le 4\sigma \sqrt{3(d_{\mathsf{X}} + d_{\mathsf{U}}) \log 2T}.$$

Denote the event that the above inequality holds by $\mathcal{E}_{w \, bound}$. We show by induction that the requisite conditions of $\mathcal{E}_{success,2}$ hold for all epochs. A key step in this argument is instantiating the result of Theorem 5 for every epoch. The rate of decay in this bound is the determined by minimum eigenvalue of the state and input covariance, $\lambda_{\min}(\hat{\Phi}^{\top}(\bar{\Sigma}^t(K,\sigma_u,x_1)\otimes I_{d_{\mathsf{X}}})\hat{\Phi})$. We control this quantity by observing that for any unit vector v

$$v^{\top} \hat{\Phi}^{\top} \left(\bar{\Sigma}^{t}(K, \sigma_{u}, x_{1}) \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}v \geq \frac{1}{2} v \hat{\Phi}^{\top} \left(\begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} \otimes I_{d_{\mathsf{X}}} \right) \hat{\Phi}v. \tag{25}$$

We use this result along with Assumption 3 to show a lower bound $\lambda_{\min}(\hat{\Phi}^{\top}(\bar{\Sigma}^t(K,\sigma_u,x_1)\otimes I_{d_{\mathsf{X}}})\hat{\Phi})\geq \frac{\alpha^2}{8}$, and in turn show that the event $\mathcal{E}_{\mathsf{success},2}$ holds with high probability. This result will proceed by induction.

Base Case: For the first epoch, observe that our lower bound on τ_1 guarantees that $\tau_1 \geq c\tau_{ls}(K_0,0,\frac{1}{2}T^{-3})$ for a sufficiently large universal constant c. Therefore applying Theorem 5 along with (25) and Assumption 3 implies that there exists an event $\mathcal{E}_{ls,1}$ which holds with probability at least $\frac{1}{2}T^{-3}$ such that under $\mathcal{E}_{ls,1}$,

$$\begin{split} & \left\| \left[\hat{A}_{1} \quad \hat{B}_{1} \right] - \left[A^{\star} \quad B^{\star} \right] \right\|_{F}^{2} \lesssim \frac{d_{\theta} \sigma^{2}}{\tau_{1} \alpha^{2}} \log T \\ & + \left(1 + \frac{\sigma^{4} \left\| P_{K_{0}} \right\|^{7} \Psi_{B^{\star}}^{6} (d_{\mathsf{X}} + d_{\mathsf{U}} + \log T)}{\tau_{1} \alpha^{4}} \right) \frac{\left\| P_{K_{0}} \right\|^{2} \Psi_{B^{\star}}^{2} d(\hat{\Phi}, \Phi^{\star})^{2} \left\| \theta^{\star} \right\|^{2}}{\alpha^{2}}. \end{split}$$

Using the fact that $\tau_1 = \tau_{\text{warm up}} \log T$, we can cancel the $\log T$ in the numerator in the second term. We can further use the fact that $\tau_{\text{warm up}} \geq c \frac{\sigma^4 d_\theta}{\epsilon \alpha^2}$ for some universal positive constant c to simplify the second term to $\beta_2 d(\hat{\Phi}, \Phi^\star)^2$, where β_2 is as in Assumption 4. Then the above bound may be simplified to

$$\left\| \begin{bmatrix} \hat{A}_1 & \hat{B}_1 \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \right\|_F^2 \le C_{\mathsf{est},2} \frac{\sigma^2 d_{\theta} \log T}{\tau_1 \alpha^2} + \beta_2 d(\hat{\Phi}, \Phi^{\star})^2.$$

where $C_{\text{est},2}$ is a sufficiently large universal constant. Meanwhile, Lemma 15 tells us that under the event $\mathcal{E}_{\text{w bound}}$, $\|x_t\|^2 \leq x_b^2 \log T$ for $t=1,\ldots,\tau_1$, and that $\|x_{\tau_1}\| \leq 16 \|P_{K_0}\|^{3/2} \Psi_{B^\star} \max_{1 \leq t \leq T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|$. Finally, we have $\|K_0\| \leq K_b$.

Induction step: Suppose

$$||x_{\tau_k}|| \le 16 ||P_{K_0}||^{3/2} \Psi_{B^*} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|$$

and

$$\left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^* & B^* \end{bmatrix} \right\|_F^2 \le C_{\mathsf{est},2} \frac{\sigma^2 d_\theta \log T}{\tau_1 \alpha^2} + \beta_2 d(\hat{\Phi}, \Phi^*)^2.$$

By the lower bound on τ_1 , we have that $\tau_1 \geq c \frac{\sigma^2 d_\theta \log T}{2\varepsilon \alpha^2}$ for a sufficiently large universal constant c. Combining this with the condition in assumption Assumption 4, which says $d(\hat{\Phi}, \Phi^\star) \leq \sqrt{\frac{\varepsilon}{2\beta_2}}$, we find $\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \|_F^2 \leq \varepsilon$. Then the conditions of Lemma 12 are satisfied, and consequently, $\| P_{\hat{K}_{k+1}} \| \leq 1.05 \, \| P^\star \|$. Therefore

$$\tau_{\mathsf{ls}}(\hat{K}_{k+1}, x_b^2 \log T, \frac{1}{2} T^{-3}) \leq 2\tau_{\mathsf{ls}}(K^\star, x_b^2 \log T, \frac{1}{2} T^{-3}) \quad \text{ and } \quad \left\| P_{\hat{K}_{k+1}} \right\| \leq 1.05 \, \|P_{K_0}\| \leq 2 \, \|P_{K_0}\| \, .$$

We may guarantee from our lower bound on τ_1 that $\tau_1 \geq c\tau_{\rm ls}(K^\star, x_b^2 \log T, \frac{1}{2}T^{-3})$ for a sufficiently large universal constant c, which ensures that the conditions of Theorem 5 are satisfied. As a result, there exists an event $\mathcal{E}_{{\rm ls},k+1}$ that holds with probability at least $1-\frac{1}{2}T^{-3}$ under which

$$\begin{split} & \left\| \left[\hat{A}_{k+1} \quad \hat{B}_{k+1} \right] - \left[A^{\star} \quad B^{\star} \right] \right\|_{F}^{2} \lesssim \frac{d_{\theta} \sigma^{2}}{(\tau_{k+1} - \tau_{k}) \alpha^{2}} \log T \\ & + \left(1 + \frac{\sigma^{4} \left\| P_{\hat{K}_{k+1}} \right\|^{7} \Psi_{B^{\star}}^{6} (d_{\mathsf{X}} + d_{\mathsf{U}} + \log T)}{(\tau_{k+1} - \tau_{k}) \alpha^{4}} \right) \frac{\left\| P_{\hat{K}_{k+1}} \right\|^{2} \Psi_{B^{\star}}^{2} d(\hat{\Phi}, \Phi^{\star})^{2} \left\| \theta^{\star} \right\|^{2}}{\alpha^{2}}, \end{split}$$

where we lower bounded $\lambda_{\min}(\hat{\Phi}^{\top}(\bar{\Sigma}^{\tau_{k+1}-\tau_k}(\hat{K}_{k+1},)\otimes I_{d_X})\hat{\Phi})$ using (25) by noting that for any matrix $K \in \mathbb{R}^{d_U \times d_X}$ and unit vector $v \in \mathbb{R}^{d_\theta}$,

$$\begin{split} v\hat{\Phi}^{\top} \bigg(\begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} \otimes I_{d_{\mathsf{X}}} \bigg) \hat{\Phi} v &= \left(\sum_{i=1}^{d_{\theta}} v_{i} \hat{\Phi}_{i} \right)^{\top} \bigg(\begin{bmatrix} I \\ K \end{bmatrix} \begin{bmatrix} I \\ K \end{bmatrix}^{\top} \otimes I_{d_{\mathsf{X}}} \bigg) \bigg(\sum_{i=1}^{d_{\theta}} v_{i} \hat{\Phi}_{i} \bigg) \\ &= \left\| \sum_{i=1}^{d_{\theta}} v_{i} \operatorname{vec}^{-1} \Big(\hat{\Phi}_{i} \Big) \begin{bmatrix} I \\ K \end{bmatrix} \right\|_{F}^{2} \\ &= \left\| \sum_{i=1}^{d_{\theta}} v_{i} \left[\hat{\Phi}_{i}^{A} + \hat{\Phi}_{i}^{B} K \right] \right\|_{F}^{2}. \end{split}$$

Then the reverse triangle inequality implies that:

$$v^{\top}\hat{\Phi}^{\top}\left(\bar{\Sigma}^{\tau_{k+1}-\tau_{k}}(\hat{K}_{k+1},)\otimes I_{d_{\mathsf{X}}}\right)\hat{\Phi}v \geq \left\|\sum_{i=1}^{d_{\theta}}v_{i}\left[\hat{\Phi}_{i}^{A}+\hat{\Phi}_{i}^{B}\hat{K}_{k+1}\right]\right\|_{F}^{2}$$

$$=\left\|\sum_{i=1}^{d_{\theta}}v_{i}\left(\hat{\Phi}_{i}^{A}+\hat{\Phi}_{i}^{B}K^{\star}\right)+\sum_{i=1}^{d_{\theta}}v_{i}\hat{\Phi}_{i}^{B}(\hat{K}_{k+1}-K^{\star})\right\|_{F}\geq \left\|\sum_{i=1}^{d_{\theta}}v_{i}\left(\hat{\Phi}_{i}^{A}+\hat{\Phi}_{i}^{B}K^{\star}\right)\right\|-\left\|\hat{K}_{k+1}-K^{\star}\right\|$$

$$\geq\sqrt{v\hat{\Phi}^{\top}\left(\left[I\atopK\right]\left[I\atopK\right]^{\top}\otimes I_{d_{\mathsf{X}}}\right)\hat{\Phi}v}-\frac{1}{6\left\|P^{\star}\right\|^{3/2}}\quad\text{(By Lemma 12)}$$

$$\geq\alpha-\frac{\alpha}{2}\quad\text{(by Assumption 3)}.$$

Observing that $\tau_{k+1} - \tau_k = \frac{1}{2}\tau_{k+1}$, and again using the fact that $\hat{K}_{k+1} = K^\star(\hat{A}_k, \hat{B}_k)$ where $\| [\hat{A}_k \ \hat{B}_k] - [A^\star \ B^\star] \|_F^2 \le \varepsilon$, we have that $\| P_{\hat{K}_{k+1}} \| \le 1.05 \| P^\star \|$. Therefore by absorbing powers of 1.05 into the universal constants, and following the same simplifications taken in the base case, the estimation error bound may be simplified to

$$\left\| \begin{bmatrix} \hat{A}_{k+1} & \hat{B}_{k+1} \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \right\|_F^2 \le C_{\text{est},2} \frac{\sigma^2 d_{\theta} \log T}{\tau_{k+1} \alpha^2} + \beta_2 d(\hat{\Phi}, \Phi^{\star})^2.$$

Furthermore, Lemma 15 (which applies due to the inductive hypothesis, the lower bound on τ_1 , and the fact that $\left\|P_{\hat{K}_{k+1}}\right\| \leq 2 \left\|P_{K_0}\right\|$) informs us that under the event $\mathcal{E}_{\text{w bound}}$,

$$\|x_t\|^2 \le x_b^2 \log T \quad \forall t = \tau_k + 1, \dots, \tau_{k+1}, \text{ and } \|x_{\tau_{k+1}}\| \le 16 \|P_{K_0}\|^{3/2} \Psi_{B^\star} \max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|.$$

Also observe that $\left\|\hat{K}_{k+1}\right\|^2 \leq \left\|P_{\hat{K}_{k+1}}\right\| \leq 2\left\|P_{K_0}\right\|$, which ensures that $\left\|\hat{K}_{k+1}\right\| \leq 2\left\|K^\star\right\| \leq K_b$. In particular, we have verified that the algorithm does not abort on this epoch, and we have verified that the inductive hypothesis holds to start the next epoch.

Union bounding over the events The bounds on the norm of the state and the controller gain ensure that the algorithm does not abort. The estimation error bounds ensure that

$$\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^* & B^* \end{bmatrix} \|_F^2 \le C_{\mathsf{est},2} \frac{\sigma^2 d_\theta \log T}{\tau_{k+1} \alpha^2} + \beta_2 d(\hat{\Phi}, \Phi^*)^2 \quad \forall k \ge 1.$$

Therefore, $\mathcal{E}_{\text{success},1} \subseteq \mathcal{E}_{\text{w bound}} \cap \mathcal{E}_{\text{ls},1} \cap \cdots \cap \mathcal{E}_{\text{ls},k_{\text{fin}}}$. Union bounding over the good events $\mathcal{E}_{\text{w bound}}, \mathcal{E}_{\text{ls},1}, \ldots, \mathcal{E}_{\text{ls},k_{\text{fin}}}$, we find that $\mathcal{E}_{\text{success},1}$ holds with probability at least $1-T^{-2}$.

$$= t\sigma_{u}^{2} + \sum_{s=1}^{t} \operatorname{tr}\left((Q + K^{T}RK)\mathbf{E}\left[x_{t}x_{t}^{T}|x_{1}\right]\right).$$

We have that

$$\begin{split} \mathbf{E} \Big[x_{t} x_{t}^{\intercal} | x_{1} \Big] &= \mathbf{E} \Big[(A^{\star} + B^{\star} K) x_{t-1} x_{t-1}^{\intercal} (A^{\star} + B^{\star} K) + \sigma_{u}^{2} B^{\star} (B^{\star})^{\intercal} + I | x_{1} \Big] \\ &= (A^{\star} + B^{\star} K)^{t-1} x_{1} x_{1}^{\intercal} \big((A^{\star} + B^{\star} K)^{t-1} \big)^{\intercal} \\ &\quad + \sum_{k=1}^{t-1} (A^{\star} + B^{\star} K)^{k} \Big(\sigma_{u}^{2} B^{\star} (B^{\star})^{\intercal} + I \Big) \Big((A^{\star} + B^{\star} K)^{k} \Big)^{\intercal} \\ &\preceq (A^{\star} + B^{\star} K)^{t-1} x_{1} x_{1}^{\intercal} \big((A^{\star} + B^{\star} K)^{t-1} \big)^{\intercal} + \mathrm{dlyap} (A^{\star} + B^{\star} K, \sigma_{u}^{2} B^{\star} (B^{\star})^{\intercal} + I). \end{split}$$

Substituting this above, we find,

$$\begin{split} \mathbf{E} \left[\sum_{s=1}^{t} \|x_t\|_Q^2 + \|u_t\|_R^2 |x_1| \right] &\leq t \sigma_u^2 + t \operatorname{tr} \Big((Q + K^\top R K) \operatorname{dlyap} (A^\star + B^\star K, \sigma_u^2 B^\star (B^\star)^\top + I) \Big) \\ &+ \sum_{s=1}^{t} \operatorname{tr} \Big((Q + K^\top R K) (A^\star + B^\star K)^{s-1} x_1 x_1^\top \big((A^\star + B^\star K)^{s-1} \big)^\top \Big) \\ &\leq t J(K) + t \sigma_u^2 (1 + d_{\mathsf{U}} \Psi_{B^\star}^2 \|P_K\|) + \|x_1\|^2 \|P_K\| \,. \end{split}$$

Lemma 19 In the settings of both Theorem 2 and Theorem 3,

$$R_3 = E\left[\sum_{t=1}^{\tau_1} \|x_t\|_Q^2 + \|u_t\|_R^2\right] \le 3\tau_1 \max\{d_{\mathsf{X}}, d_{\mathsf{U}}\} \|P_{K_0}\| \Psi_{B^{\star}}^2.$$

Proof This result follows from Lemma 18 by noting that $x_1 = 0$, and therefore

$$\begin{split} R_2 &= \boldsymbol{E} \left[\mathbf{1}(\mathcal{E}_{\text{success}}^c) \sum_{t=\tau_1+1}^T \|x_t\|_Q^2 + \|u_t\|_R^2 \right] \\ &\leq T^{-1} \big(\|Q\| + 2K_b^2 \big) x_b^2 \log T + T^{-1} J(K_0) + 24 \|P_{K_0}\| \, \Psi_{B^\star}^2 (d_{\mathsf{X}} + d_{\mathsf{U}}) \sigma^2 T^{-2} \log 3T \\ &+ 2T^{-2} \, \|P_{K_0}\| \, \|\theta_\star\|_F^2 \, K_b^2 x_b^2 \log T + \sum_{k=1}^{k_{\mathsf{fin}}} 2(\tau_k - \tau_{k-1}) d_{\mathsf{U}} \sigma_k^2. \end{split}$$

In the setting of Theorem 2, this reduces to

In the setting of Theorem 3, this reduces to

Proof Let t_{abort} be the first time instance where $||x_t||^2 \ge x_b^2 \log T$ or $||\hat{K}_k|| \ge K_b$.

$$\begin{split} &\mathbf{E} \Bigg[\mathbf{1}(t_{\mathsf{abort}} \leq T) \sum_{t=1}^{t_{\mathsf{abort}}-1} \|x_t\|_Q^2 + \|u_t\|_R^2 \Bigg] \\ &\leq \mathbf{E} \Bigg[\mathbf{1}(t_{\mathsf{abort}} \leq T) \sum_{t=1}^{t_{\mathsf{abort}}-1} x_b^2 \big(\|Q\| + 2K_b^2 \big) \log T + 2 \sum_{k=1}^{k_{\mathsf{fin}}} \sum_{t=\tau_{k-1}+1}^{\tau_k} 2\sigma_k^2 \|g_t\|^2 \Bigg] \\ &\leq \mathbf{E} \Bigg[\mathbf{1}(t_{\mathsf{abort}} \leq T) \sum_{t=1}^{t_{\mathsf{abort}}-1} x_b^2 \big(\|Q\| + 2K_b^2 \big) \log T \Bigg] + \mathbf{E} \Bigg[\mathbf{1}(t_{\mathsf{abort}} \leq T) \sum_{k=1}^{k_{\mathsf{fin}}} \sum_{t=\tau_{k-1}+1}^{\tau_k} 2\sigma_k^2 \|g_t\|^2 \Bigg] \\ &\leq \mathbf{E} \Big[\mathbf{1}(t_{\mathsf{abort}} \leq T) T x_b^2 \big(\|Q\| + 2K_b^2 \big) \log T \Big] + \mathbf{E} \Bigg[\sum_{k=1}^{k_{\mathsf{fin}}} \sum_{t=\tau_{k-1}+1}^{\tau_k} 2\sigma_k^2 \|g_t\|^2 \Bigg] \\ &= \mathbf{P}(t_{\mathsf{abort}} \leq T) T x_b^2 \big(\|Q\| + 2K_b^2 \big) \log T + \sum_{k=1}^{k_{\mathsf{fin}}} \sum_{t=\tau_{k-1}+1}^{\tau_k} 2d_{\mathsf{U}} \sigma_k^2 \\ &\leq T^{-1} x_b^2 \big(\|Q\| + 2K_b^2 \big) \log T + \sum_{k=1}^{k_{\mathsf{fin}}} 2(\tau_k - \tau_{k-1}) d_{\mathsf{U}} \sigma_k^2. \end{split}$$

We have that $x_{t_{\mathsf{abort}}} = (A^\star + B^\star K) x_{t_{\mathsf{abort}}-1} + \begin{bmatrix} I & \sigma_u B^\star \end{bmatrix} \begin{bmatrix} w_t \\ g_t \end{bmatrix}$ for some K satisfying $\|K\| \leq K_b$ and $\sigma_u \leq 1$. Then we may write

$$\begin{split} \mathbf{E} \bigg[\sum_{t = t_{\mathsf{abort}}}^{T} \|x_{t}\|_{Q}^{2} + \|u_{t}\|_{R}^{2} \bigg] &\leq \mathbf{P}(t_{\mathsf{abort}} \leq T) (TJ(K_{0}) + 2 \|P_{K_{0}}\| \|\theta_{\star}\|_{F}^{2} K_{b}^{2} x_{b}^{2} \log T) \\ &+ 2 \|P_{K_{0}}\| \Psi_{B^{\star}}^{2} \mathbf{E} \bigg[\mathbf{1}(t_{\mathsf{abort}} \leq T) \max_{1 \leq t \leq T} \bigg\| \begin{bmatrix} w_{t} \\ g_{t} \end{bmatrix} \bigg\|^{2} \bigg]. \end{split}$$

We have that $\mathbf{P}(t_{\mathsf{abort}} \leq T)(TJ(K_0) + 2 \|P_{K_0}\| \|\theta_\star\|_F^2 K_b^2 x_b^2 \log T) \leq T^{-1}J(K_0) + 2T^{-2} \|P_{K_0}\| \|\theta_\star\|_F^2 K_b^2 x_b^2 \log T$. Furthermore, by Lemma 21,

$$\leq \int_0^{4(d_X + d_U)\sigma^2 \log \frac{T}{\delta}} \mathbf{P}(E) dx + \int_{4(d_X + d_U)\sigma^2 \log \frac{T}{\delta}}^\infty \mathbf{P}\left[\max_{1 \le t \le T} \left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|^2 > x \right] dx$$

$$\leq 4(d_X + d_U)\sigma^2 \delta \log \frac{T}{\delta} + \int_{4(d_X + d_U)\sigma^2 \log \frac{T}{\delta}}^\infty 2T \exp\left(-\frac{x}{4(d_X + d_U)\sigma^2}\right) dx$$

$$= 4(d_X + d_U)\sigma^2 \delta \log \frac{T}{\delta} + 8(d_X + d_U)\sigma^2 \delta$$

$$= 4(d_X + d_U)\sigma^2 \delta \log \frac{T}{\delta} + \log 9$$

$$= 4(d_X + d_U)\sigma^2 \delta \log \frac{9T}{\delta},$$

where the probability bound in the final inequality follows from the fact that $\left\| \begin{bmatrix} w_t \\ g_t \end{bmatrix} \right\|^2$ is sub-exponential with parameter $4(d_X + d_U)\sigma^2$ (see Section 2.8 of Vershynin (2020)).

$$\begin{split} R_1 &= \pmb{E} \left[\pmb{1}(\mathcal{E}_{\text{success}}) \sum_{t=\tau_1+1}^T \|x_t\|_Q^2 + \|u_t\|_R^2 \right] \\ &\leq \sum_{k=2}^{k_{\text{fin}}} \left(\pmb{E} \Big[\pmb{1}(E_{k-1}) 142(\tau_k - \tau_{k-1}) \, \|P^\star\|^8 \, \big\| \big[\hat{A}_{k-1} \quad \hat{B}_{k-1} \big] - \big[A^\star \quad B^\star \big] \big\|_F^2 \right] \\ &+ (\tau_k - \tau_{k-1}) \mathcal{J}(K^\star) + 4(\tau_k - \tau_{k-1}) d_{\mathsf{U}} \, \|P_{K^\star}\| \, \sigma_k^2 \Psi_{B^\star}^2 + 2 x_b^2 \log T \, \|P_{K^\star}\| \, \bigg), \end{split}$$

where

$$E_k = \left\{ \left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^{\star} & B^{\star} \end{bmatrix} \right\|_F^2 \le C_{\mathsf{est},1} \frac{\sigma^2 \sqrt{d_\theta d_\mathsf{U}} \left\| P_{K_0} \right\| \log T}{\sqrt{\tau_k}} + \beta_1 \sqrt{d(\hat{\Phi}, \Phi^{\star})} \right\} \tag{26}$$

for $k = 1, ..., k_{fin} - 1$ in the setting of Theorem 2 and

$$E_k = \left\{ \left\| \begin{bmatrix} \hat{A}_k & \hat{B}_k \end{bmatrix} - \begin{bmatrix} A^\star & B^\star \end{bmatrix} \right\|_F^2 \le C_{\mathsf{est},2} \frac{\sigma^2 d_\theta \log T}{\tau_k \alpha^2} + \beta_2 d(\hat{\Phi}, \Phi^\star)^2 \right\} \tag{27}$$

for $k = 1, ..., k_{fin} - 1$ in the setting of Theorem 3.

Proof We have that

$$\mathbf{E}\left[\mathbf{1}(\mathcal{E}_{\text{success}})\sum_{t=\tau_{1}}^{T}\|x_{t}\|_{Q}^{2}+\|u_{t}\|_{R}^{2}\right]=\sum_{k=2}^{k_{\text{fin}}}\mathbf{E}\left[\mathbf{1}(\mathcal{E}_{\text{success}})\sum_{t=\tau_{k-1}+1}^{\tau_{k}}\|x_{t}\|_{Q}^{2}+\|u_{t}\|_{R}^{2}\right].$$

Let $S_k = \{\|x_{\tau_k+1}\|^2 \le x_b^2 \log T\}$. We have that for any $k = 1, \ldots, k_{\text{fin}}$, $\mathcal{E}_{\text{success}} \subseteq E_k \cap S_k$, and therefore $\mathbf{1}(\mathcal{E}_{\text{success}}) \le \mathbf{1}(E_k \cap S_k)$. By the tower property, we may write that for any $k = 2, \ldots, k_{\text{fin}}$,

$$\mathbf{E}\left[\mathbf{1}(\mathcal{E}_{\text{success}}) \sum_{t=\tau_{k-1}+1}^{\tau_k} \|x_t\|_Q^2 + \|u_t\|_R^2\right]$$

$$\leq \mathbf{E}\left[\mathbf{1}(E_{k-1} \cap S_{k-1}) \mathbf{E}\left[\sum_{t=\tau_{k-1}+1}^{\tau_k} \|x_t\|_Q^2 + \|u_t\|_R^2 |x_{\tau_{k-1}+1}, \hat{K}_k\right]\right].$$

As \hat{K}_k is stabilizing under \mathcal{E}_k , we may invoke Lemma 18 to bound

$$\begin{aligned} \mathbf{1}(E_{k-1} \cap S_{k-1}) \, \mathbf{E} \left[\sum_{t=\tau_{k-1}+1}^{\tau_k} \|x_t\|_Q^2 + \|u_t\|_R^2 |x_{\tau_{k-1}+1}, \hat{K}_k] \right] \\ &\leq \mathbf{1}(E_{k-1} \cap S_{k-1}) \Big((\tau_k - \tau_{k-1}) \mathcal{J}(\hat{K}_k) + 2(\tau_k - \tau_{k-1}) d_{\mathsf{U}} \, \Big\| P_{\hat{K}_k} \Big\| \, \sigma_k^2 \Psi_{B^\star}^2 + \|x_{\tau_{k-1}+1}\|^2 \, \Big\| P_{\hat{K}_k} \Big\| \Big) \\ &\stackrel{(i)}{\leq} \mathbf{1}(E_{k-1}) \Big((\tau_k - \tau_{k-1}) \mathcal{J}(\hat{K}_k) + 4(\tau_k - \tau_{k-1}) d_{\mathsf{U}} \, \|P^\star\| \, \sigma_k^2 \Psi_{B^\star}^2 + 2x_b^2 \log T \, \|P_{K^\star}\| \Big) \\ &\stackrel{(ii)}{\leq} \mathbf{1}(E_{k-1}) \Big(142(\tau_k - \tau_{k-1}) \, \|P^\star\|^8 \, \| [\hat{A}_{k-1} \, \hat{B}_{k-1}] - [A^\star \, B^\star] \|_F^2 \Big) + (\tau_k - \tau_{k-1}) \mathcal{J}(K^\star) \\ &+ 4(\tau_k - \tau_{k-1}) d_{\mathsf{U}} \, \|P_{K^\star}\| \, \sigma_k^2 \Psi_{B^\star}^2 + 2x_b^2 \log T \, \|P^\star\| \end{aligned}$$

where inequality (i) follows by using the bound from S_{k-1} along with the fact that under the event E_{k-1} , the burn in time and assumptions on $d(\hat{\Phi}, \Phi^\star)$ ensure that $\left\|P_{\hat{K}_k}\right\| \leq 2 \, \|P^\star\|$. Inequality (ii) follows from the fact that under the burn-in time assumptions along with the event E_{k-1} , the condition of Lemma 12 is satisfies, and $\mathcal{J}(\hat{K}) - \mathcal{J}(K^\star)l \leq 142 \, \|P^\star\|^8 \, \|\left[\hat{A}_{k-1} \quad \hat{B}_{k-1}\right] - \begin{bmatrix}A^\star \quad B^\star\end{bmatrix}\right\|_F^2$. Taking the expectation and summing over $k=2,\ldots,k_{\mathrm{fin}}$ proves the claim.

Lemma 23 In the setting of Theorem 2,

$$\begin{split} R_1 - T\mathcal{J}(K^\star) &\leq 832\sigma^2 \sqrt{d_\theta d_\mathsf{U}} \, \|P^\star\|^8 \, C_{\mathsf{est},1} \, \|P_{K_0}\| \, \Psi_{B^\star}^2 \sqrt{T} \log T \\ &+ \left(4d_\mathsf{U} \, \|P^\star\| \, \Psi_{B^\star}^2 \gamma \sqrt{d(\hat{\Phi}, \Phi^\star)} + 142 \, \|P^\star\|^8 \, \beta_1 \sqrt{d(\hat{\Phi}, \Phi^\star)} \right) T + 2x_b^2 \, \|P_{K^\star}\| \log^2 T, \end{split}$$

Proof By substituting the estimation error bound under the events E_k in (26), and the bound on the exploration noise magnitude $\sigma_k^2 \leq \frac{\sqrt{d_\theta}}{\sqrt{d_U}\sqrt{\tau_1 2^{k-1}}} + \gamma \sqrt{d(\hat{\Phi}, \Phi^\star)}$, Lemma 22 provides

$$\begin{split} R_1 - T\mathcal{J}(K^\star) &\leq 832\sigma^2 \sqrt{d_\theta d_\mathsf{U}} \, \|P^\star\|^8 \, C_{\mathsf{est},1} \, \|P_{K_0}\| \, \Psi_{B^\star}^2 \sqrt{T} \log T \\ &+ \left(4d_\mathsf{U} \, \|P^\star\| \, \Psi_{B^\star}^2 \gamma \sqrt{d(\hat{\Phi}, \Phi^\star)} + 142 \, \|P^\star\|^8 \, \beta_1 \sqrt{d(\hat{\Phi}, \Phi^\star)} \right) T + 2k_{\mathsf{fin}} x_b^2 \, \|P_{K^\star}\| \log T, \end{split}$$

We have that $k_{\text{fin}} = \log_2 T/\tau_1 \le \log T$, providing the result in the lemma statement.

Lemma 24 In the setting of Theorem 3,

$$R_1 - T\mathcal{J}(K^*) \le \left(C_{\mathsf{est},2} 142 \, \|P^*\|^8 \, \frac{\sigma^2 d_\theta}{\alpha^2} + x_b^2 \, \|P_{K^*}\| \right) \log^2 T + 142 \, \|P^*\|^8 \, \beta_2 d(\hat{\Phi}, \Phi^*)^2 T.$$

Proof By substituting the estimation error bound under the events E_k from (27), and the exploration noise magnitude $\sigma_k^2 = 0$, Lemma 22 provides

$$R_1 - T\mathcal{J}(K^{\star}) \leq k_{\mathsf{fin}} \left(C_{\mathsf{est},2} 142 \, \|P^{\star}\|^8 \, \frac{\sigma^2 d_{\theta}}{\alpha^2} + x_b^2 \, \|P_{K^{\star}}\| \right) \log T + 142 \, \|P^{\star}\|^8 \, \beta_2 d(\hat{\Phi}, \Phi^{\star})^2 T,$$

We have that $k_{\text{fin}} = \log_2 T / \tau_1 \le \log T$, providing the result in the lemma statement.

D.1. Proof of Theorem 2

We consider the decomposition of the regret as

$$\mathbf{E}[\mathbf{R}_T] = R_1 + R_2 + R_3 - T\mathcal{J}(K^*),$$

with R_1 , R_2 , and R_3 as in (6). Combining the bounds on $R_1 - T\mathcal{J}(K^*)$ from Lemma 23, on R_2 from Lemma 20, and on R_3 from Lemma 19, we find

$$\begin{split} \mathbf{E}[\mathbf{R}_{T}] &\lesssim \tau_{1} \max\{d_{\mathsf{X}}, d_{\mathsf{U}}\} \, \|P_{K_{0}}\| \, \Psi_{B^{\star}}^{2} \\ &+ T^{-1} \Big(\big(\|Q\| + K_{b}^{2} \big) x_{b}^{2} \log T + J(K_{0}) + \|P_{K_{0}}\| \, \Psi_{B^{\star}}^{2} (d_{\mathsf{X}} + d_{\mathsf{U}}) \sigma^{2} \log T + \|P_{K_{0}}\| \, \|\theta_{\star}\|^{2} \, K_{b}^{2} x_{b}^{2} \log T \Big) \\ &+ \sigma^{2} \sqrt{d_{\theta} d_{\mathsf{U}}} \, \|P^{\star}\|^{8} \, \|P_{K_{0}}\| \, \Psi_{B^{\star}}^{2} \sqrt{T} \log T \\ &+ \Big(d_{\mathsf{U}} \, \|P^{\star}\| \, \Psi_{B^{\star}}^{2} \gamma \sqrt{d(\hat{\Phi}, \Phi^{\star})} + \|P^{\star}\|^{8} \, \beta_{1} \sqrt{d(\hat{\Phi}, \Phi^{\star})} \Big) T + x_{b}^{2} \, \|P_{K^{\star}}\| \log^{2} T \end{split}$$

The first term may be modified by recalling that $\tau_1 = \tau_{\text{warm up}} \log^2 T$. For the second term, note that by the fact that $T^{-1} \leq \tau_1^{-1}$, the following bound holds,

$$T^{-1}\Big(\left(\|Q\| + K_b^2 \right) x_b^2 \log T + J(K_0) + \|P_{K_0}\| \Psi_{B^*}^2 (d_{\mathsf{X}} + d_{\mathsf{U}}) \sigma^2 \log T + \|P_{K_0}\| \|\theta_{\star}\|^2 K_b^2 x_b^2 \log T \Big)$$

$$\lesssim \Big(\|Q\| + K_b^2 \Big(1 + \|P_{K_0}\| \|\theta^{\star}\|^2 \Big) \Big).$$

Combining terms and substituting the definition of β_1 from Assumption 2 leads to the theorem statement.

D.2. Proof of Theorem 3

We consider the decomposition of the regret as

$$\mathbf{E}[\mathbf{R}_T] = R_1 + R_2 + R_3 - T \mathcal{J}(K^*),$$

with R_1 , R_2 , and R_3 as in (6). Combining the bounds on $R_1 - T\mathcal{J}(K^*)$ from Lemma 24, on R_2 from Lemma 20, and on R_3 from Lemma 19, we find

$$\begin{split} \mathbf{E}[\mathbf{R}_{T}] &\lesssim \tau_{1} \max\{d_{\mathsf{X}}, d_{\mathsf{U}}\} \, \|P_{K_{0}}\| \, \Psi_{B^{\star}}^{2} \\ &+ T^{-1} \Big(J(K_{0}) + \Big(\|Q\| + K_{b}^{2} + \|P_{K_{0}}\| \, \|\theta_{\star}\|^{2} \, K_{b}^{2} \Big) x_{b}^{2} \log T + \|P_{K_{0}}\| \, \Psi_{B^{\star}}(d_{\mathsf{X}} + d_{\mathsf{U}}) \sigma^{2} \log T \Big) \\ &+ \|P^{\star}\|^{8} \, \frac{\sigma^{2} d_{\theta} \log^{2} T}{\sigma^{2}} + \|P^{\star}\|^{8} \, \beta_{2} d(\hat{\Phi}, \Phi^{\star})^{2} T + x_{b}^{2} \, \|P_{K^{\star}}\| \log^{2} T. \end{split}$$

Substituting $\tau_1 = \tau_{\text{warm up}} \log T \le \tau_{\text{warm up}} \log^2 T$ for τ_1 , and grouping terms, we find that

$$\begin{split} \mathbf{E}[\mathbf{R}_{T}] &\leq \left(\tau_{\mathsf{warm \, up}} \max\{d_{\mathsf{X}}, d_{\mathsf{U}}\} \, \|P_{K_{0}}\| \, \Psi_{B^{\star}}^{2} + \|P^{\star}\|^{8} \, \frac{\sigma^{2} d_{\theta}}{\alpha^{2}} + x_{b}^{2} \, \|P_{K^{\star}}\| \right) \log^{2} T \\ &+ T^{-1} \Big(J(K_{0}) + \Big(\|Q\| + K_{b}^{2} + \|P_{K_{0}}\| \, \|\theta_{\star}\|^{2} \, K_{b}^{2} \Big) x_{b}^{2} \log T + \|P_{K_{0}}\| \, \Psi_{B^{\star}}(d_{\mathsf{X}} + d_{\mathsf{U}}) \sigma^{2} \log T \Big) \\ &+ \|P^{\star}\|^{8} \, \beta_{2} d(\hat{\Phi}, \Phi^{\star})^{2} T. \end{split}$$

Using the fact that $T^{-1} \le \tau_1^{-1}$ we have the following bound:

$$T^{-1} \Big(\mathcal{J}(K_0) + \Big(\|Q\| + K_b^2 + 2 \|P_{K_0}\| \|\theta_\star\|^2 K_b^2 \Big) x_b^2 \log T + \|P_{K_0}\| \Psi_{B^\star} (d_{\mathsf{X}} + d_{\mathsf{U}}) \sigma^2 \log T \Big)$$

$$\lesssim \Big(\|Q\| + K_b^2 \Big(1 + \|P_{K_0}\| \|\theta^\star\|^2 \Big) \Big).$$

Combining terms and substituting the definition of β_2 from Assumption 4 as well as the definition of ε in Lemma 12 provides the result in the theorem statement.

Appendix E. Generalizations

E.1. Logarithmic Regret with Known A^* or B^*

Cassel et al. (2020) and Jedra and Proutiere (2022) show that it is possible to attain logaritmic regret if either the A^* is known to the learner and $K^*(K^*)^{\top} \succ 0$, or the B^* is known to the learner. These settings cannot immediately be embedded into the formulation of (1), because (1) requires that $\begin{bmatrix} A^* & B^* \end{bmatrix}$ is a linear function of the unknown parameters. It can therefore only embed the settings where A^* and B^* are known up to scale. However, the model can easily be extended to

$$x_{t+1} = \begin{pmatrix} \begin{bmatrix} \bar{A} & \bar{B} \end{bmatrix} + \text{vec}^{-1}(\Phi^{\star}\theta^{\star}) \end{pmatrix} \begin{bmatrix} x_t \\ u_t \end{bmatrix} + w_t.$$

- 1: **Input:** Model structure estimate $\hat{\Phi}$, state data $x_{1:t+1}$, input data $u_{1:t}$
- 2: **Return:** $\hat{\theta}$, Λ , where

$$\hat{\theta} = \Lambda^{\dagger} \Biggl(\sum_{s=1}^{t} \hat{\Phi}^{\top} \Biggl(\begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \otimes I_{d\mathsf{X}} \Biggr) \Biggl(x_{s+1} - \begin{bmatrix} \bar{A} & \bar{B} \end{bmatrix} \begin{bmatrix} x_{t} \\ u_{t} \end{bmatrix} \Biggr) \Biggr), \text{ and } \Lambda = \sum_{s=1}^{t} \hat{\Phi}^{\top} \Biggl(\begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix} \begin{bmatrix} x_{s} \\ u_{s} \end{bmatrix}^{\top} \otimes I_{d\mathsf{X}} \Biggr) \hat{\Phi}$$

If the learner has access to \bar{A} , \bar{B} , and an estimate $\hat{\Phi}$ for Φ^* , then the results of Theorem 2 and Theorem 3 are unchanged by this generalization. In particular, the least squares algorithm may be modified to subtract out the known dynamics \bar{A} and \bar{B} . This modified algorithm is shown in Appendix E.1. Propagating this change through the analysis does not change the results.

Using the above generalization, we may recover logarithmic regret in the settings considered by Cassel et al. (2020); Jedra and Proutiere (2022).

• B^{\star} known: We may set $\begin{bmatrix} \bar{A} & \bar{B} \end{bmatrix} = \begin{bmatrix} 0 & B^{\star} \end{bmatrix}$ and $\theta^{\star} = \text{vec } A^{\star}$. We then set Φ^{\star} as the matrix with columns having a single element that is one, and the rest zero, such that $\text{vec}^{-1}(\Phi^{\star}\theta^{\star}) = \begin{bmatrix} A^{\star} & 0 \end{bmatrix}$. As we assume the learner knows B^{\star} exactly, and Φ^{\star} forms a complete basis for A^{\star} we may simply choose $\hat{\Phi} = \Phi^{\star}$, and have $d(\hat{\Phi}, \Phi^{\star}) = 0$. To verify that we may achieve logarithmic regret in this setting using Theorem 3, we must simply show that Assumption 3 is satisfied. To do so, note that for all $i = 1, \ldots, d_{\theta}$, Φ^{B}_{i} are zero, and $\hat{\Phi}^{A}_{i}$ are matrices each with a distinct unity element. Therefore, for any K, and any unit vector $v \in \mathbb{R}^{d_{\theta}}$,

$$\left\| \sum_{i=1} v_i \hat{\Phi}_i^A + \hat{\Phi}_i^B K \right\|_F^2 = \left\| \sum_{i=1} v_i \hat{\Phi}_i^A \right\|_F^2 = \sum_{i=1}^{d_\theta} v_i^2 = \|v\|^2 = 1 \ge \frac{1}{3 \|P^\star\|^{3/2}},$$

where the last inequality follows by the fact that $||P^*|| \ge 1$. This verifies that Assumption 3 holds in this setting.

• A^* known, $K^*(K^*)^{\top} \succeq \mu I$ and $K_0 K_0^{\top} \succeq \mu I$ for $\mu \geq \frac{1}{3\|P^*\|^{3/2}}$ 12: We may set $[\bar{A} \quad \bar{B}] = [A^* \quad 0]$ and $\theta^* = \text{vec } A^*$. We then set Φ^* as the matrix with columns having a single

^{12.} The assumption $K_0K_0^{\top} \succeq \mu I$, and the lower bound on μ is not included in Cassel et al. (2020); Jedra and Proutiere (2022), but are needed here to verify Assumption 3. The lower bound on α in Assumption 3 is used to find the probability bound on the success event $\mathcal{E}_{\text{success},2}$. It may be possible to remove this lower bound, but we leave that for future work.

element that is one, and the rest zero, such that $\operatorname{vec}^{-1}(\Phi^\star\theta^\star)=\begin{bmatrix}0&B^\star\end{bmatrix}$. As we assume the learner knows A^\star exactly, and Φ^\star forms a complete basis for A^\star we may simply choose $\hat{\Phi}=\Phi^\star$, and have $d(\hat{\Phi},\Phi^\star)=0$. To verify that we achieve logarithmic regret in this setting using Theorem 3, we again show that Assumption 3 is satisfied. To do so, note that for all $i=1,\ldots,d_\theta$, Φ^A_i are zero, and $\hat{\Phi}^B_i$ are matrices each with a distinct unity element. Therefore, for any K, and any unit vector $v\in\mathbb{R}^{d_\theta}$,

$$\left\| \sum_{i=1} v_{i} \hat{\Phi}_{i}^{A} + \hat{\Phi}_{i}^{B} K \right\|_{F}^{2} = \left\| \sum_{i=1} v_{i} \hat{\Phi}_{i}^{B} K \right\|_{F}^{2}$$

$$= \operatorname{tr} \left(\left(\sum_{i=1}^{d_{\theta}} v_{i} \hat{\Phi}_{i}^{B} \right) K K^{\top} \left(\sum_{i=1}^{d_{\theta}} v_{i} \hat{\Phi}_{i}^{B} \right)^{\top} \right)$$

$$\geq \mu \left\| \sum_{i=1}^{d_{\theta}} v_{i} \hat{\Phi}_{i}^{B} \right\|_{F}^{2}$$

$$= \mu \geq \frac{1}{3 \|P^{\star}\|^{3/2}}.$$

With a different definition of regret measuring the distance between the incurred cost and the optimal cost of a set of controllers in hindsight, Lale et al. (2020) also show logarithmic regret in a partially observed setting. However, they operate under the assumption that the class of controllers is persistently exciting. Such a condition is not satisfied by the optimal state feedback LQR controller in general. In particular, the covariates under the policy $u_t = K^*x_t$ are given by

$$\sum_{s=1}^{t} \begin{bmatrix} x_s \\ u_s \end{bmatrix} \begin{bmatrix} x_s \\ u_s \end{bmatrix}^{\top} = \begin{bmatrix} I \\ K^{\star} \end{bmatrix} \sum_{s=1}^{t} x_s x_s^{\top} \begin{bmatrix} I \\ K^{\star} \end{bmatrix}^{\top},$$

which is degenerate. For this reason, the structure through which the unknown parameters enter the dynamics become important. This is why we only can get $\log T$ regret in the setting of Section 3.2. Future work could extend the analysis of this work to the partially observed setting to examine under which conditions on system structure it is possible to satisfy the persistency of excitation condition assumed by Lale et al. (2020). See Tsiamis et al. (2023) for further discussion.
