HODGE THEORY OF ABELIAN COVERS

ABSTRACT. Motivated by classical Alexander invariants of affine hypersurface complements, we endow certain finite dimensional quotients of the homology of abelian covers of complex algebraic varieties with a canonical and functorial mixed Hodge structure (MHS). More precisely, we focus on covers which arise algebraically in the following way: if U is a smooth connected complex algebraic variety and G is a complex semiabelian variety, the pullback of the exponential map by an algebraic morphism $f: U \to G$ yields a covering space $\pi: U^f \to U$ whose group of deck transformations is $\pi_1(G)$. The new MHS are compatible with Deligne's MHS on the homology of U through the covering map π and satisfy a direct sum decomposition as MHS into generalized eigenspaces by the action of deck transformations. This provides a vast generalization of the previous results regarding univariable Alexander modules of the authors, Geske, Maxim and Wang. Lastly, we reduce the problem of whether the first Betti number of the Milnor fiber of a central hyperplane arrangement complement is combinatorial to a question about the Hodge filtration of certain MHS defined in this paper, providing evidence that the new structures contain interesting information.

1. INTRODUCTION

The goal of this note is to develop a Hodge theory for certain (infinite-sheeted) covers of smooth complex algebraic varieties. Let us start by precisely defining our setting: Let U be a complex smooth connected algebraic variety. Let G be a semiabelian variety and let $e \in G$ be its identity. Let TGdenote the tangent space of G at e, and let $\exp: TG \to G$ be the exponential map of complex Lie groups, which, since G is a commutative algebraic group, is the universal cover of G.

Let $f: U \to G$ be an algebraic morphism. The map f determines an abelian cover $\pi: U^f \to U$. Indeed, $\pi: U^f \to U$ is the pullback of exp by f, as shown in the following diagram:

(1.1)
$$U^{f} \subset U \times TG \xrightarrow{f} TG$$
$$\downarrow^{\pi} \qquad \qquad \downarrow^{\exp} U \xrightarrow{f} G,$$

Note that the deck transformation group of $\pi: U^f \to U$ coincides with the deck group of exp: $TG \to G$, and is thus isomorphic to $\pi_1(G)$, a free abelian group. Thus, the homology groups $H_j(U^f, k)$ have an action by $R := k[\pi_1(G)]$ by deck transformations for any field k, which in this note will be \mathbb{Q}, \mathbb{R} or \mathbb{C} . Also note that, if g is the rank of $\pi_1(G)$, then R is (non-canonically) isomorphic to the Laurent polynomial ring on g variables over k.

By Deligne's theory of 1-motives [10], there are plenty such morphisms f (out of the ones that give rise to connected covers, there is one for each mixed Hodge structure quotient of $H_1(U,\mathbb{Q})$). Hence, in order to develop a Hodge theory for covering spaces of algebraic varieties, this seems like a very general and natural setting in which covers arise from algebraic data that is related to the Hodge theory of U. One such morphism f is the generalized Albanese morphism due to Iitaka ([23], [24]), which yields the torsion-free universal abelian cover of U (that is, the covering space of U associated to the kernel of the projection of $\pi_1(U)$ into its maximal torsion-free abelian quotient).

A particularly interesting example is that of affine hypersurface complements. Let $U = \mathbb{C}^n \setminus \bigcup_{i=1}^m V(f_i)$, where $f_i \in \mathbb{C}[x_1, \ldots, x_n]$ are pairwise coprime irreducible polynomials, and let U^f be the cover induced by $f = (f_1, \ldots, f_n) : U \to (\mathbb{C}^*)^n$. In this case $H_j(U^f, k)$ are classical Alexander invariants of the hypersurface $H = \bigcup_{i=1}^m V(f_i)$ (see Example 2.36). These kinds of multivariable Alexander invariants are typically studied through their support loci, cf. [13], [27], [30], [41]. Moreover, since the abelianization of $\pi_1(U)$ is a free abelian group with a basis that consists of a meridian around each irreducible component of H, each morphism $\pi_1(U) \to \mathbb{Z}^l$ is the morphism induced at the level of fundamental groups of an algebraic morphism $f : U \to (\mathbb{C}^*)^l$ such as the ones considered in this paper.

Let us note that, unless G is a point, $\pi: U^f \to U$ is an infinite-sheeted cover, and U^f is a complex analytic manifold which in general is not an algebraic variety (nor has the homotopy type of a finite CW complex). Moreover, the homology groups $H_j(U^f, k)$ are finitely generated R-modules, so their dimension as k-vector spaces is countable, but it will not be finite in general. If $\dim_k H_j(U, k) = \infty$, the dimension of its k-dual $H^j(U^f, k)$ will not be countable, and thus $H^j(U^f, k)$ will not be a finitely generated R-module. For this reason, and even if Deligne's mixed Hodge theory of algebraic varieties arises in cohomology rather than homology, we will focus on the homology groups of U^f throughout this note.

Even though they are finitely generated over R, the homology groups of U^f can be infinite dimensional, so in order to develop a Hodge theory for them, we need to extract finite dimensional spaces from them. Since the R-action is by deck transformations and we want our theory to reflect the fact that $\pi: U^f \to U$ is a covering space, we will also want these finite dimensional spaces to have a natural R-module structure. There are two ways to do this:

- (1) Focus on finite dimensional *R*-submodules of $H_i(U^f, k)$:
 - If $G = \mathbb{C}^*$, then $R \cong k[t^{\pm 1}]$, so R is a principal ideal domain. Hence, the R-module $H_j(U^f, k)$ has a canonical direct sum decomposition into its free part and its torsion part. In particular, $\operatorname{Tors}_R H_j(U^f, k)$ is the maximal R-submodule of $H_j(U^f, k)$ which is a finite dimensional k-vector space. Thus, it makes sense to develop a Hodge theory for $\operatorname{Tors}_R H_j(U^f, k)$ for all $j \geq 0$. This was achieved in this generality in [15] (see also [16] for a survey of the main results therein), although there had been prior constructions by other authors in some special situations [12, 21, 29, 26, 28] (see the introduction of [15] for a description of the particular cases).
 - If G is not isomorphic to \mathbb{C}^* , then R is not a principal ideal domain, and $H_j(U^f, k)$ no longer decomposes into its free part and its torsion part. However, by analogy with the $G = \mathbb{C}^*$ case, one could still focus on the maximal Artinian submodule of $H_j(U^f, k)$, which is the maximal submodule of $H_j(U^f, k)$ which is a finite dimensional k-vector space. If $G \cong (\mathbb{C}^*)^n$ for some $n \ge 1$, this was the approach that was taken in [19], although not for $H_j(U^f, k)$ but for the cohomological Alexander modules defined therein.
- (2) Focus on finite dimensional *R*-module quotients of $H_j(U^f, k)$: This is the approach we take in this paper. More concretely, for every finite index subgroup $H \leq \pi_1(G)$, let $\mathfrak{m}_H :=$ $(\gamma - 1 \mid \gamma \in H) \subset k[H]$ be the augmentation ideal of $k[H] \subset R$, and let $(\mathfrak{m}_H)^m H_j(U^f, k)$ be the *R*-submodule of $H_j(U^f, k)$ generated by $(\mathfrak{m}_H)^m$. Then, the quotient $\frac{H_j(U^f, k)}{(\mathfrak{m}_H)^m H_j(U^f, k)}$ is finite dimensional for all $m \geq 1$ and all $j \geq 0$. The goal of this paper is to endow these quotients with canonical mixed Hodge structures (MHS).

These kinds of quotients have interesting applications. For example, they were used in [1] by Artal Bartolo, Carmona Ruber, Cogolludo Agustín and Marco Buzunáriz to give a proof of the fact that Rybnikov's pair of combinatorially equivalent projective line arrangements from [38] have non-isomorphic fundamental groups. In their proof, they use objects such as $\frac{H_1(U^f,k)}{\mathfrak{m}^2 H_1(U^f,k)}$ (but with \mathbb{Z} coefficients), where U^f is the universal abelian cover of a line arrangement complement and \mathfrak{m} is the augmentation ideal of R.

Remark 1.2. Let us further justify our choice of quotients to do Hodge theory on. For these quotients to be finite dimensional, they need to be supported in a finite number of points of Spec $R \cong (\mathbb{C}^*)^g$, where Spec denotes the maximal spectrum. By [35, Theorem 2.5], we know that, for all $q \ge 0$,

(1.3)
$$\bigcup_{j \le q} \operatorname{supp} H_j(U^f, \mathbb{C}) = \bigcup_{j \le q} (f^*)^{-1} (\mathcal{V}_j(U))$$

where $f^* : \operatorname{Spec} R \cong \operatorname{Hom}(\pi_1(G), \mathbb{C}^*) \to \operatorname{Hom}(\pi_1(U), \mathbb{C}^*)$ is the map induced by f, and

 $\mathcal{V}_j(U) = \{ \text{rank 1 } \mathbb{C} \text{-local systems } L \text{ on } U \mid H_j(U, L) \neq 0 \}$

is the *j*-th homology jump loci. Using the structure theorem of (co)homology jump loci [4, Theorem 1.4.1] one can show that the right hand side of (1.3) is a finite union of torsion translated subtori in Spec *R*. Hence, if we need to decide which finite dimensional quotients of $H_j(U^f, \mathbb{C})$ to study, a natural choice is to force them to be supported at the interesting torsion points, that is, those corresponding to the torsion-translated irreducible components of $\bigcup_{j\geq 0} \operatorname{supp} H_j(U^f, \mathbb{C})$. This is precisely what we are able to achieve by looking at $\frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)}$ for an appropriate choice of $H \leq \pi_1(G)$. Furthermore, by making *m* grow, we get larger and larger quotients which are supported in the same finite set of

points. This corresponds to looking at an infinitesimal neighborhood of these finite number of torsion points in supp $H_j(U^f, k)$.

In principle, approaches (1) and (2) might seem unrelated. However, in the case when $G = \mathbb{C}^*$, approach (2) generalizes approach (1) as follows.

Remark 1.4 (Generalization of [15]). Suppose that $G = \mathbb{C}^*$, and identify R with $k[t^{\pm 1}]$. By [15, Proposition 2.24] (based on [2, Proposition 4.1]), there exists $N \in \mathbb{N}$ such that $\operatorname{Tors}_R H_j(U^f, k)$ is annihilated by a big enough power of $t^N - 1$ for all $j \geq 0$. Hence, for $m \gg 1$, there are canonical inclusions

(1.5)
$$\operatorname{Tors}_{R} H_{j}(U^{f}, k) \hookrightarrow \frac{H_{j}(U^{f}, k)}{(t^{N} - 1)^{m} H_{j}(U^{f}, k)}$$

for all $j \ge 0$. In [15], $\operatorname{Tors}_R H_j(U^f, k)$ is endowed with a canonical and functorial MHS, but this shows that the MHS on $\frac{H_j(U^f, k)}{(t^N - 1)^m H_j(U^f, k)}$ defined in this paper corresponding to the subgroup $H = \langle N \rangle \subset \mathbb{Z} = \pi_1 ((\mathbb{C}^*)^n)$ sees more than just the *R*-torsion, it also sees more and more of the free part as we increase the values of N and m.

In fact, we show in [18] that the morphism (1.5) is a morphism of MHS, so the theory developed in this paper extends the theory developed in [15].

Remark 1.6 (Comparison with [19]). Definition 6.17 endows certain quotients of the cohomology Alexander modules considered in [19] with a canonical MHS. However, we will not try to address how the MHS on the maximal Artinian submodules of the cohomology Alexander modules from [19] relates to the MHS defined in this note, as the techniques used to define them are very different from one another. The reader may consult [19, Section 1.4] for an explanation of the main differences between [15] and [19] regarding the scope and the methods used.

Let us note that the MHS found in earlier work [15, 19] following approach (1) have applications that go beyond Hodge theory. For example, the existence and properties of the MHS on $\operatorname{Tors}_R H_j(U^f, k)$ gives a bound on the size of the Jordan blocks of $\operatorname{Tors}_R H_j(U^f, k)$ for the *t*-action (see [15, Corollary 7.20]), which in particular implies that $\operatorname{Tors}_R H_1(U^f, k)$ is always a semisimple *R*-module. This was unknown in this sort of generality before, see [12, Corollary 1.7] for the case of affine curve complements. We also obtain a similar bound for the Jordan blocks of the action of any element of $\pi_1((\mathbb{C}^*)^n)$ on the maximal Artinian submodules of the cohomological Alexander modules considered in [19] (see [19, Corollary 1.7(c)]).

This note is devoted to developing a Hodge theory following approach (2) which generalizes the theory developed in [15] (approach (1)). The focus is on providing structural results rather than investigating possible applications outside of Hodge theory, which, given the success of the previous approaches, remains a topic for further research.

1.1. Summary of the main results. In this paper we prove the following statement, which provides a generalization of [15, Theorem 1.0.2]:

Theorem 1.7. Let U be a smooth connected algebraic variety, let G be a semiabelian variety whose tangent space at the identity is denoted by TG and let $f: U \to G$ be an algebraic morphism. Denote by

$$\pi \colon U^f \coloneqq \{(u, z) \in U \times TG \mid f(u) = \exp(z)\} \subset U \times TG \longrightarrow U$$
$$(u, z) \longmapsto u$$

the corresponding cover of U, with deck group isomorphic to $\pi_1(G)$, which is a finitely generated free abelian group. Let $R = k[\pi_1(G)]$, for $k = \mathbb{Q}$ or \mathbb{R} . Let $H \leq G$ be a finite index subgroup, and let \mathfrak{m} be the augmentation ideal of R. Let $j \geq 0$ and $m \geq 1$. The following statements hold:

(1) If $k = \mathbb{R}$, $\frac{H_j(U^f,k)}{\mathfrak{m}^m H_j(U^f,k)}$ carries a canonical k-MHS (see Definition 6.17). If $G \cong (\mathbb{C}^*)^n$ for some $n \ge 1$, then this holds for $k = \mathbb{Q}$ too (see Corollary 10.11).

(2) Let k be as in part (1), and let $m' \ge m$. Then, the projection morphism

$$\frac{H_j(U^f,k)}{\mathfrak{m}^{m'}H_j(U^f,k)} \twoheadrightarrow \frac{H_j(U^f,k)}{\mathfrak{m}^m H_j(U^f,k)}$$

is a MHS morphism (see Remark 6.18).

(3) Let k be as in part (1). For all $\gamma \in \pi_1(G)$, let $\log \gamma \in H_1(G, \mathbb{Z})$ be the element corresponding to γ via the abelianization map. Consider the multiplication map, defined as the only k-linear map satisfying

$$\begin{aligned} H_1(G,k) \otimes_k \frac{H_j(U^f,k)}{\mathfrak{m}^m H_j(U^f,k)} &\longrightarrow & \frac{H_j(U^f,k)}{\mathfrak{m}^m H_j(U^f,k)} \\ \log \gamma \otimes v &\longmapsto & \log(\gamma) \cdot v \coloneqq \sum_{i=1}^{m-1} \frac{(1-\gamma)^i \cdot v}{i} \end{aligned}$$

for all $\gamma \in \pi_1(G)$ and all $v \in \frac{H_j(U^f,k)}{\mathfrak{m}^m H_j(U^f,k)}$ is a MHS morphism. (4) Let H be a finite index subgroup of $\pi_1(G)$, and let

$$\mathfrak{m}_H \coloneqq (\gamma - 1 \mid \gamma \in H)$$

be the augmentation ideal of $k[H] \subset R$. Note that $\mathfrak{m}_G = \mathfrak{m}$. Then, the results in parts (1)–(3) hold if we substitute $\mathfrak{m}^m H_j(U^f, k)$ by $(\mathfrak{m}_H)^m H_j(U^f, k)$, and $H_1(G, k)$ by $H_1(G_H, k)$, where $G_H \to G$ is the covering space associated to $H \leq \pi_1(G)$ (see Proposition 8.3).

(5) Let $K_2 \leq K_1 \leq G$ be a sequence of finite index subgroups. Then, the natural projection

$$\frac{H_j(U^J,k)}{(\mathfrak{m}_{K_2})^m H_j(U^f,k)} \twoheadrightarrow \frac{H_j(U^J,k)}{(\mathfrak{m}_{K_1})^m H_j(U^f,k)}$$

is a MHS morphism (see Proposition 8.4).

Moreover, the MHS from Theorem 1.7 is functorial in this very general sense, both in the domain and the target of $f: U \to G$ (see Theorem 7.1 combined with Corollary 10.11).

Theorem 1.8 (Functoriality). Let U_1, U_2 be smooth varieties, and let G_1, G_2 be semiabelian varieties. Consider a commutative diagram of algebraic morphisms (below, on the left hand side), where ρ is a group homomorphism.

(1.9)
$$\begin{array}{cccc} U_1 \xrightarrow{g} U_2 & U_1^{f_1} \xrightarrow{\widetilde{g}} U_2^{f_2} \\ \downarrow^{f_1} & \downarrow^{f_2} & \downarrow^{\widetilde{f}_1} & \downarrow^{\widetilde{f}_2} \\ G_1 \xrightarrow{\rho} G_2 & TG_1 \xrightarrow{\widetilde{\rho}} TG_2 \end{array}$$

On the right hand side, consider a commutative diagram which is the unique lift satisfying that $\tilde{\rho}$ is an additive group homomorphism.

Let $k = \mathbb{R}$ unless both G_1 and G_2 are affine tori, in which case we take $k = \mathbb{Q}$. For i = 1, 2 and for all $K_i \leq G_i$, let \mathfrak{m}_{K_i} be the augmentation ideal of $k[K_i] \subset k[\pi_1(G_i)]$.

Under these assumptions, the map $\widetilde{g}: U_1^{f_1} \to U_1^{f_2}$ induces MHS morphisms

$$\widetilde{g}_{*,m}: \frac{H_j(U_1^{f_1}, k)}{(\mathfrak{m}_{K_1})^m H_j(U_1^{f_1}, k)} \to \frac{H_j(U_1^{f_1}, k)}{(\mathfrak{m}_{K_2})^m H_j(U_1^{f_1}, k)}$$

for all $j \ge 0$, $m \ge 1$ and all $K_1 \le \pi_1(G_1)$ and $K_2 \le \pi_1(G_2)$ such that $\rho_*(K_1) \le K_2$.

Note that this is a more general version of the functoriality found in [15, Theorem 5.4.9], which corresponds to the diagram (1.9) in the case where $G_1 = G_2 = \mathbb{C}^*$ and $\rho = \text{Id}$. In other words, while in this paper our MHS behaves functorially in both the domain and the target of $f: U \to G$, the MHS in [15] is only functorial in the domain. Because of this more general functoriality, we obtain the following compatibility with Deligne's MHS as a Corollary of Theorem 1.8, by making G_2 be a point (see Corollary 7.18 combined with Corollary 10.11). This is a generalization of [15, Theorem 1.0.3], but the proof here is much simpler due to the extra functoriality features in this paper. **Corollary 1.10** (Compatibility with Deligne's MHS). Let U be a smooth connected algebraic variety, let G be a semiabelian variety, and let $f: U \to G$ be an algebraic morphism. Let $k = \mathbb{R}$ unless G is isomorphic to an affine torus, in which case $k = \mathbb{Q}$. Let H be a finite index subgroup of $\pi_1(G)$, and let \mathfrak{m}_H be the augmentation ideal of $k[H] \subset k[\pi_1(G)]$.

Then, the covering space map $\pi: U^f \to U$ induces the MHS morphism

$$\frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)} \to H_j(U,k)$$

for all $j \ge 0$ and all $m \ge 1$, where $H_i(U, k)$ is endowed with Deligne's MHS.

By Theorem 1.7 part (3), the logarithm of deck transformations behaves well with respect to the MHS. Let $\gamma \in \pi_1(G)$, which we interpret as a deck transformation of $\pi : U^f \to U$. It turns out that γ does not preserve the MHS in general, but its semisimple part does, as exemplified in the following result (see Theorem 9.1 combined with Corollary 10.11), which provides a generalization of Theorem [17, Theorem 1.3].

Theorem 1.11. Let $k = \mathbb{R}$ unless G is isomorphic to an affine torus, in which case $k = \mathbb{Q}$. Let H be a finite index subgroup of $\pi_1(G)$, and let \mathfrak{m}_H be the augmentation ideal of k[H]. Let $\gamma = \gamma_{ss}\gamma_u$ be the Jordan-Chevalley decomposition of γ acting on $\frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)}$ as the product of a semisimple and a unipotent operator that commute with each other. Then,

$$\gamma_{ss} \colon \frac{H_j(U^f, k)}{(\mathfrak{m}_H)^m H_j(U^f, k)} \to \frac{H_j(U^f, k)}{(\mathfrak{m}_H)^m H_j(U^f, k)}$$

is a MHS isomorphism for all $j \ge 0$ and all $m \ge 1$.

As a consequence of the theorem above, we obtain that the direct sum decomposition of the quotient $\frac{H_j(U^f,\mathbb{C})}{(\mathfrak{m}_H)^m H_j(U^f,\mathbb{C})}$ into its generalized eigenspaces by the action of γ is a MHS decomposition, see Corollary 9.2, which also contains a version for \mathbb{R} -coefficients that is extended to \mathbb{Q} -coefficients by Corollary 10.11.

1.2. Outline of the paper. This paper provides a vast generalization of the main results in [15] and in [17]. More precisely, sections 3 to 8 and Section 10 generalize the results in [15, Chapters 3–6], which are precisely the chapters which have clear analogies in this general setting (and do not depend on G being \mathbb{C}^*), and Section 9 generalizes [17].

In Section 2 we recall the relevant background and set notations for the rest of the paper. We review results regarding semiabelian varieties and Albanese morphisms, homology of abelian covers, local systems and how to interpret the homology groups of U^f as the homology groups of a local system \mathcal{L} on U, the compactifications of algebraic varieties that will be used throughout this paper, differential graded algebras (both cdga's and dgla's), and mixed Hodge complexes of sheaves, including the analytic logarithmic Dolbeault mixed Hodge complex of sheaves from Navarro Aznar [34], which endows the cohomology of smooth algebraic varieties with the same MHS as Deligne (which he obtained using holomorphic logarithmic forms).

In Section 3 we describe a general procedure to obtain mixed Hodge complexes of sheaves as "thickenings", i.e. infinitesimal deformations of other known mixed Hodge complexes of sheaves. Very roughly speaking, the construction amounts to tensoring the complexes of sheaves by a mixed Hodge structure and twisting the differentials. In Section 4, we give an explicit description of how to perform suitable thickenings of the analytic logarithmic Dolbeault mixed Hodge complex of sheaves. In Section 5 we show that these thickenings realize certain truncated local systems obtained from \mathcal{L} .

Sections 3–5 provide the theoretical framework needed to develop a Hodge theory for U^f . In Section 6 we start by endowing the cohomology of the aforementioned truncated local systems with MHS (see Definition 6.1), show that those MHS are independent of the choices used in their construction via mixed Hodge complexes of sheaves, and finally arrive at the first three parts of Theorem 1.7 for $k = \mathbb{R}$ in Section 6.3. We also endow other related (co)homology groups with canonical MHS in Section 6.3.

Section 7 is devoted to proving the version of the functoriality Theorem 1.8 for $k = \mathbb{R}$, $K_1 = \pi_1(G_1)$ and $K_2 = \pi_1(G_2)$, that is, where \mathfrak{m}_{K_i} is the augmentation ideal of $\mathbb{R}[K_i] \subset \mathbb{R}[\pi_1(G_i)]$ (Theorem 7.1), as well as the corresponding version of Corollary 1.10 (Corollary 7.18). We also study how the statement of Theorem 1.8 changes if ρ in diagram (1.9) is not a group homomorphism, but just a morphism of algebraic varieties (see Theorem 7.16). This has the following interesting consequence: if f is the generalized Albanese morphism, then the MHS obtained in this paper are invariants of the topology and the algebraic structure of U, but not of f (which is defined up to translation and isomorphism of semiabelian varieties), see Example 7.17.

In Section 8 we prove parts (4) and (5) of Theorem 1.7 in the case where $k = \mathbb{R}$. The results in this section can be used to immediately generalize the main results in Section 7 to the form they have in Section 1.1 (namely Theorem 1.8 and Corollary 1.10) (for $k = \mathbb{R}$).

Theorem 1.11 is proved in Section 9 in the case where $k = \mathbb{R}$. The consequent eigenspace decomposition appears in full detail in Corollary 9.2.

In Section 10 we show that the different MHS defined in Section 6 are in fact defined over \mathbb{Q} if $G \cong (\mathbb{C}^*)^n$ for some $n \ge 1$ (Corollary 10.11). The reason for this distinction is that we perform a thickening of a particular \mathbb{Q} -mixed Hodge complex of sheaves and show that it computes the cohomology of the local systems used in this paper, but this specific construction cannot be carried out if G is not an affine torus. We expect the result to be true in general, but were unable so far to find an explicit description of a multiplicative \mathbb{Q} -mixed Hodge complex of sheaves that we could use to perform the needed thickenings, which includes fixing a particular morphism relating the appropriate local systems to the corresponding thickened complexes in a compatible way with the construction over \mathbb{R} .

Lastly, in Section 11 we use the celebrated result of Budur and Saito [3] on the combinatorial nature of the spectrum of a hyperplane arrangement to reduce the open problem of whether the first Betti number of the Milnor fiber of a central hyperplane arrangement complement in \mathbb{C}^n is combinatorial to a question about the MHS defined in this paper. Specifically, it is reduced to a question about the combinatorial nature of the Hodge filtration of $\frac{H_2(U^f,\mathbb{C})}{\mathfrak{m}_H H_2(U^f,\mathbb{C})}$, where U is an essential line arrangement complement in \mathbb{C}^2 , $f: U \to \mathbb{C}^*$ is the defining (reduced) polynomial of the arrangement, and H is a subgroup of $\pi_1(\mathbb{C}^*)$ which is determined by the combinatorial data of the arrangement (see Theorem 11.7 and Lemma 11.9). We highlight a couple of aspects of this reduction:

- In this case, $H_2(U^f, \mathbb{C})$ is a free $R = \mathbb{C}[t^{\pm 1}]$ -module. Hence, even if $G = \mathbb{C}^*$, the MHS of $\frac{H_2(U^f, \mathbb{C})}{\mathfrak{m}_H H_2(U^f, \mathbb{C})}$ is completely new from this paper, as [15] only dealt with the torsion part of the homology of U^f .
- The rank of $H_2(U^f, \mathbb{C})$ as a free $R = \mathbb{C}[t^{\pm 1}]$ -module is determined by the combinatorics of the essential line arrangement, which we denote by \mathcal{H} . Hence, the dimension of $\frac{H_2(U^f,\mathbb{C})}{\mathfrak{m}_H H_2(U^f,\mathbb{C})}$ is also determined by combinatorial data. The work in Section 11 shows that, even if $\frac{H_2(U^f,\mathbb{C})}{\mathfrak{m}_H H_2(U^f,\mathbb{C})}$ is well understood, its MHS contains interesting information.
- well understood, its MHS contains interesting information. • The MHS on $\frac{H_2(U^f,\mathbb{C})}{\mathfrak{m}_H H_2(U^f,\mathbb{C})}$ only has three non-trivial graded pieces by the Hodge filtration, and we show that the dimension of the middle piece is also determined by the combinatorics of \mathcal{H} . Specifically, Theorem 11.7 reduces the problem of whether the first Betti number of the Milnor fiber of a central hyperplane arrangement complement is combinatorial to the question of whether dim $_{\mathbb{C}} F^0 \frac{H_2(U^f,\mathbb{C})}{\mathfrak{m}_H H_2(U^f,\mathbb{C})}$ is determined by the combinatorics of \mathcal{H} .

The last point motivates further work regarding the development of techniques that allow the computation of examples of the MHS defined in this paper (or at the very least of its Hodge filtration). This note is devoted to proving structural results and developing a new theory, not the computation of examples. However, using Remark 1.4, note that the examples from [15, Chapter 10] regarding affine hyperplane arrangement complements are also examples of the MHS $\frac{H_j(U^f,\mathbb{Q})}{\mathfrak{m}_H H_j(U^f,\mathbb{Q})}$ from this paper for suitable H, since in those cases $H_j(U^f,\mathbb{Q})$ was a torsion module for the chosen j. Similarly, the results from [17, Sections 5 and 6] (the ones which help with the computation of the MHS in [15] in cases such as when U is formal or the affine complement of a hypersurface which is transversal at infinity) also apply to the MHS $\frac{H_j(U^f,\mathbb{Q})}{\mathfrak{m}_H H_j(U^f,\mathbb{Q})}$ for suitable H, since $H_j(U^f,\mathbb{Q})$ is torsion for all but one j.

1.3. Summary of the techniques and new insights. Roughly speaking, the strategy in both [15] and this paper is as follows. First, we interpret $H_j(U^f, k)$ as the *j*-th homology group of a rank 1 local system of free *R*-modules \mathcal{L} on U. We also consider the *R*-dual local system $\overline{\mathcal{L}}$ of \mathcal{L} . The local system $\overline{\mathcal{L}}$ has infinite dimensional stalks, so we truncate it by quotienting by powers of the augmentation ideal. Then, we create a mixed Hodge complex of sheaves which endows the cohomology groups of these truncated local systems with canonical mixed Hodge structures. These MHS are used to endow the desired objects ($\operatorname{Tors}_R H_j(U^f, k)$ in [15], where $G = (\mathbb{C}^*)^n$, or the aforementioned quotients of $H_j(U^f, k)$ in this paper) with canonical MHS in different ways. In both cases, the mixed Hodge complexes of sheaves that we use are obtained by thickening known mixed Hodge complexes of sheaves which endow the cohomology of U (or of a finite cover of U) with Deligne's MHS. This thickening process consists on tensoring the complexes of sheaves by a finite dimensional vector space V (endowed with a MHS) and by twisting the differentials.

However, although in principle the techniques seem similar in both papers, there are several new key technical insights in this note that make the generalization possible:

- In [15] V was chosen to be $k[t^{\pm 1}]/(t-1)^m$ and the weight and Hodge filtrations were defined by hand. This was possible because we picked coordinates in $G = \mathbb{C}^*$. However, in this paper G can be any semiabelian variety, and we go further than in [15] and also explore connections between these different mixed Hodge structures that arise from morphisms between the corresponding semiabelian varieties (see Theorem 1.8). Hence, we needed to use a coordinate-free V (see Remark 2.54 for the definition of the MHS R_m and R_{-m} used in place of V in this paper) and construct the thickened complexes without fixed coordinates (see Sections 4 and 5). As a result of this generality, the new coordinate-free construction is more involved than the construction in [15], see Definition-Proposition 4.6 to illustrate this. However, we can also make the choice of the maps used to construct the thickenings very explicit by picking coordinates in the case when G is an affine torus (see Section 10).
- Deligne's mixed Hodge complex of sheaves considered in [15], which consists on logarithmic holomorphic forms on a compactification of U, could not be used in the new construction, as it does not contain enough forms to construct a thickening representing the truncations of $\overline{\mathcal{L}}$ if G is a semiabelian variety in general (not isomorphic to $(\mathbb{C}^*)^n$). For this reason, we need to consider a mixed Hodge complex of sheaves due to Navarro Aznar consisting on logarithmic analytic forms on a compactification of U instead.
- R is a principal ideal domain in the case when $G = \mathbb{C}^*$, so the Universal Coefficient Theorem is available. We use it in [15, Proposition 2.14] to obtain that $\operatorname{Tors}_R H^{j+1}(U, \overline{\mathcal{L}})$ (the torsion part of the (j + 1)-th cohomology Alexander module) is canonically isomorphic to the k-dual of $\operatorname{Tors}_R H_j(U^f, k)$ (the torsion part of the j-th homology Alexander module). The MHS on $\operatorname{Tors}_R H_j(U^f, k)$ is endowed through this isomorphism by a MHS on $\operatorname{Tors}_R H^{j+1}(U, \overline{\mathcal{L}})$ obtained using the aforementioned methods. However, there is no analogous duality between the objects we consider in this paper in homology and cohomology, namely, quotients of $H_*(U^f, k)$ and $H^*(U, \overline{\mathcal{L}})$ by powers of the augmentation ideal. To overcome this, we need to define different mixed Hodge complexes of sheaves to study quotients of $H_*(U^f, k)$ and of $H^*(U, \overline{\mathcal{L}})$ respectively: the mixed Hodge complex of sheaves that we use for homology and cohomology are thickenings of the same mixed Hodge complex of sheaves, but the MHS R_{-m} and R_m that we tensor by are different and dual to one another.

The lack of duality in this paper mentioned in the last point turns out to be a blessing in disguise: In [15], the statements regarding the behavior of the MHS with respect to morphisms which had a natural geometric interpretation for homology Alexander modules but not for cohomology Alexander modules were very difficult to prove because the MHS had a natural interpretation in cohomology but not in homology, and the duality map used to define the MHS in homology was explicit but not easy to work with. Examples of these kinds of results are the compatibility with Deligne's MHS on U [15, Theorem 6.1] or the independence of the MHS of the choice of finite cover of U used in the construction [15, Theorem 5.22]. However, the analogous results in this paper (namely Corollary 7.18 and Proposition 8.4) have much simpler proofs due to the fact that the mixed Hodge complex of sheaves constructed in this paper was designed for homology. As a result, and although the construction of

the MHS in this note is longer, this paper is shorter in length than [15] despite providing a vast generalization of the main results of loc. cit. (Sections 3 to 8 in this paper) and also of the main result of [17] (Section 9).

Lastly, we want to address a possible connection with the works of Hain and Zucker [22, 21], which is also related to the work of Sullivan [42] and Morgan [33] (see [37, Remark 9.25] for the relation). The tautological variations of mixed Hodge structures (VMHS) of [22] (whose stalks are MHS defined in [21]) for a semiabelian variety G have $R/\mathfrak{m}^m \otimes_R \mathcal{L}_G$ as underlying local systems, where $m \geq 1$, \mathfrak{m} is the augmentation ideal of R and $\mathcal{L}_G = \exp_! \underline{k}_{TG}$. In this paper, the truncated local systems that we consider in order to endow quotients of $H_j(U^f, k)$ by powers of \mathfrak{m} with canonical MHS are $R_{-m} \otimes_R \overline{\mathcal{L}}$, which, by Remarks 2.23 and 2.26, are the k-dual local systems to $f^{-1}(R/\mathfrak{m}^m \otimes_R \mathcal{L}_G)$ for each $m \geq 1$. The following questions remain open:

- Can the mixed Hodge complexes of sheaves defined in this paper be used to endow $R_{-m} \otimes_R \overline{\mathcal{L}}$ with the structure of an admissible VMHS on U? If so, since the cohomology of an admissible VMHS is endowed with a MHS, does this MHS coincide with the MHS on $H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}})$ from Definition 6.1? We note that these MHS on $H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}})$ are the ingredients needed to endow the quotients of $H_*(U^f, k)$ by powers of the augmentation ideal with canonical MHS (see Definition 6.17).
- Is the MHS on $H^*(U, f^{-1}(R/\mathfrak{m}^m \otimes_R \mathcal{L}_G))$ endowed through Hain and Zucker's work related to the MHS from Definition 6.1? If so, how?

2. Preliminaries

2.1. Semiabelian varieties. We begin this section recalling the Chevalley decomposition of complex connected algebraic groups (cf. [7, Theorem 1.1]).

Theorem 2.1 (Chevalley decomposition). Let G be a complex connected algebraic group. Then there exists a unique normal affine algebraic closed subgroup H of G for which G/H is an abelian variety A. That is, there is a unique short exact sequence of algebraic groups

$$1 \to H \to G \to A \to 1$$

Definition 2.2 (Semiabelian variety). Let G be a complex connected algebraic group, and let H be as in Theorem 2.1. We say that G is a semiabelian variety if $H \cong (\mathbb{C}^*)^n$ for some $n \ge 0$.

Remark 2.3. Semiabelian varieties are commutative groups (see [24, Lemma 4]), so we will denote their Chevalley decompositions with additive notation (0 instead of 1).

The following is well known.

Proposition 2.4 (Functoriality of the Chevalley decomposition). Let $f : G_1 \to G_2$ be a morphism of algebraic groups between two semiabelian varieties. Let $0 \to (G_i)_T \xrightarrow{t_i} G_i \xrightarrow{(p_A)_i} (G_i)_A \to 0$ be the Chevalley decomposition of G_i for i = 1, 2. Then, $f((G_1)_T) \subset (G_2)_T$.

Proof. $(p_A)_2 \circ f \circ t_1$ is an algebraic morphism between an affine algebraic group and an abelian variety. Since it is a group homomorphism, it sends the identity in $(G_1)_T$ to the identity in $(G_2)_A$. By [7, Lemma 2.3], $(p_A)_2 \circ f \circ t_1$ is the constant morphism to the identity in $(G_2)_A$. Hence, $f((G_1)_T) \subset \ker(p_A)_2 = (G_2)_T$.

Proposition 2.5. Let G be a semiabelian variety. Its Chevalley decomposition

$$0 \to G_T \to G \to G_A \to 0$$

gives G the structure of a G_T -torsor over G_A . This torsor is Zariski-locally trivial, i.e. there is a Zariski open covering of G_A over which $G \cong G_T \times G_A$.

Proof. This follows from the results in [32, III.4.], concretely, Propositions 4.6 and 4.9.

Proposition 2.6. If G is a semiabelian variety, the only holomorphic group homomorphism $G \to \mathbb{C}$ is trivial.

Proof. Consider a group homomorphism $\rho: G \to \mathbb{C}$, and G's Chevalley decomposition as in Proposition 2.5. Then, $\rho|_{G_T}: G_T \to \mathbb{C}$ is a holomorphic group homomorphism, so it is trivial. Therefore, ρ descends to a holomorphic map $\overline{\rho}: G_A \to \mathbb{C}$, which must be constant, since G_A is compact. \Box

Remark 2.7 (Universal cover of a semiabelian variety). As complex manifolds, every semiabelian variety G is isomorphic to $\mathbb{C}^g/\mathbb{Z}^r$ for $g = \dim G$ and some $r \in \mathbb{Z}_{\geq 0}$, where \mathbb{Z}^r is embedded into \mathbb{C}^g as a discrete subgroup. In particular, $r \leq 2g$. Also, \mathbb{Z}^r must generate \mathbb{C}^g as a \mathbb{C} -vector space: otherwise, Gwould have a nontrivial homomorphism to \mathbb{C} , contradicting Proposition 2.6. In particular, $g \leq r$. The universal cover of G is given by the exponential map of Lie groups $\exp : TG \to G$, where $TG := T_eG$ is the tangent space of G at the identity $e \in G$. Note that, since G is an abelian group, \exp is a group homomorphism, where TG is seen as a group under addition. Note that $TG \cong \mathbb{C}^g$, and $\exp^{-1}(e)$ is identified with the lattice \mathbb{Z}^r through this identification, so $r = \operatorname{rank} \pi_1(G)$.

Remark 2.8. Let $f: G_1 \to G_2$ be an algebraic morphism between two semiabelian varieties. Up to translation, f is also a group homomorphism. Indeed, up to translation in G_2 , we can assume that f takes the identity to the identity. Such f induces a linear map (the differential of f at the identity) between the universal covers given by the exponential map, which implies that f is also a group homomorphism.

2.2. Alexander modules. Let U be a smooth connected complex algebraic variety. Let G be a complex semiabelian variety and let $e \in G$ be its identity. Let $f: U \to G$ be an algebraic map. Let U^f be the complex manifold defined as the pullback of the universal cover of G as in the commutative diagram (1.1).

Since $\pi_1(G, e)$ is abelian, $\pi_1(G, x)$ is canonically identified with $\pi_1(G, e)$ for all $g \in G$. Therefore, we will not specify the choice of base points, and will denote the fundamental group of G by $\pi_1(G)$. The fundamental group $\pi_1(G)$ acts on TG by deck transformations. By the universal property of fiber products, $U^f \to U$ is also a covering map whose deck action comes from the lift of the deck action of $\pi_1(G)$, and its deck transformation group is $\pi_1(G)$.

Let k be a field (which for us will be \mathbb{Q} , \mathbb{R} or \mathbb{C}) and let $R = k[\pi_1(G)]$. Since $\pi_1(G) \cong \mathbb{Z}^r$, R is non-canonically isomorphic to the ring of Laurent polynomials $k[t_1^{\pm 1}, \ldots, t_r^{\pm 1}]$.

Definition 2.9. Let k be a field. The *i*-th (multivariable) homology Alexander module associated to (U, f) is $H_i(U^f, k)$. It is a $R = k[\pi_1(G)]$ -module, via the deck action of $\pi_1(G)$ on U^f .

Remark 2.10. Since U has the homotopy type of a finite CW complex, $H_i(U^f, k)$ is a finitely generated *R*-module.

For our purposes, it will be useful to realize the Alexander modules as homology groups of certain local systems on U.

Definition 2.11. Let $k = \mathbb{Q}, \mathbb{R}$ or \mathbb{C} . In the notation of (1.1), we define $\mathcal{L}_G := \exp_{\underline{k}} \underline{k}_{TG}$.

The action of $\pi_1(G)$ on TG by deck transformation induces an automorphism of \mathcal{L}_G , making \mathcal{L}_G into a local system of rank 1 free *R*-modules. For any $z \in G$, the stalks are given by $(\mathcal{L}_G)_z = \bigoplus_{z' \in \exp^{-1}(z)} k$.

The monodromy action of a loop $\gamma \in \pi_1(G)$ on $(\mathcal{L}_G)_z$ interchanges the summands according to the monodromy action of γ in $\exp^{-1}(z)$.

Definition 2.12. Let $k = \mathbb{Q}, \mathbb{R}$ or \mathbb{C} . In the notation of (1.1), we define $\mathcal{L} := f^{-1} \exp_{\underline{k}} \underline{k}_{TG}$, which is a rank 1 local system of free *R*-modules. Similarly, we let $\overline{\mathcal{L}} = R \otimes_{\gamma \mapsto \gamma^{-1}} \mathcal{L}$ denote the same local system, with a new *R*-module structure where $\gamma \in \pi_1(G)$ acts in the way that γ^{-1} acts on \mathcal{L} .

Remark 2.13. In the notation of (1.1), there is a natural *R*-module isomorphism $H_i(U^f, k) \cong H^i(U, \mathcal{L})$. This follows from the definition of the right hand side, since the chain complex that computes it is the same chain complex that computes the homology of U^f (see [11, Section 2.5]).

Remark 2.14. If $V \subset U$ is a simply connected open set, $\pi^{-1}(V) \cong \pi_1(G) \times V$. For any $\gamma \in \pi_1(U)$, the action of γ on the stalk \mathcal{L}_x is given by multiplication by $f_*(\gamma) \in \pi_1(G)$.

Remark 2.15. Let S be the sheaf (of sets) of lifts of f to TG, i.e. $\Gamma(S, V) = \{\iota : V \to TG \mid \exp \circ \iota = f\}$ for any open set $V \subseteq U$. For every $x \in U$, the stalk S_x is canonically isomorphic to $\exp^{-1}(f(x))$, and it carries a $\pi_1(G)$ -action coming from the action on TG.

On the other hand, a basis of the stalk of \mathcal{L}_G at f(x) is given by $\exp^{-1}(f(x))$, where each point z' on the fiber corresponds to the locally constant function that is 1 around z' and 0 elsewhere on the fiber, and this bijection is also compatible with the $\pi_1(G)$ action. The same can be said of the stalk of \mathcal{L} at x, since f^{-1} preserves stalks.

This provides us with a map of sheaves $S \to \mathcal{L}$ that sends S to a basis of \mathcal{L} on each open set, and it is compatible with the action of $\pi_1(G)$. Thus, a (locally defined) function $\iota: U \to TG$ such that $\exp \circ \iota = f$ can be seen as a (local) section of \mathcal{L} , and these locally form a k-basis. For $\gamma \in \pi_1(G)$, we will denote $\gamma \cdot \iota \coloneqq \gamma \circ \iota$.

Notation 2.16. We will denote the (identity) *R*-antilinear isomorphism $\mathcal{L} \to \overline{\mathcal{L}}$ by $\iota \mapsto \overline{\iota}$, that is, $\overline{\iota}$ is the notation that we will use to refer to ι when seen in $\overline{\mathcal{L}}$. This way, for $\iota \in \mathcal{L}$ and $\gamma \in \pi_1(G)$, we have $\gamma \cdot \overline{\iota} = \overline{\gamma^{-1} \circ \iota}$.

Remark 2.17. There is a canonical isomorphism $\mathcal{H}om_R(\mathcal{L}, R) \cong \overline{\mathcal{L}}$. On our local k-bases of \mathcal{L} and $\overline{\mathcal{L}}$, it is given by the pairing:

$$\overline{\mathcal{L}} \times \mathcal{L} \longrightarrow \underline{R}_U$$

defined by $\langle \gamma_1 \cdot \overline{\iota}, \gamma_2 \cdot \iota \rangle = \gamma_1 \gamma_2 \in \pi_1(G) \subseteq R$ for every $\iota, \gamma_1, \gamma_2$. One readily verifies that this is well-defined. Extending it in a k-bilinear way makes it automatically *R*-bilinear and it induces the above isomorphism.

Remark 2.18. The observation from Remark 2.17 also holds if we replace R by k[H], where H is a finite index subgroup of $\pi_1(G)$. Indeed, let $H\gamma_1, \ldots, H\gamma_n$ the distinct elements of $\pi_1(G)/H$, seen as right cosets. Then, $\{\gamma_1 \cdot \iota, \ldots, \gamma_n \cdot \iota\}$ is a local k[H]-basis of \mathcal{L} , and \mathcal{L} is a rank n free k[H]module. Similarly, since $\pi_1(G)$ is abelian, $\{\gamma_1^{-1} \cdot \overline{\iota}, \ldots, \gamma_n^{-1} \cdot \overline{\iota}\}$ is a local k[H]-basis of $\overline{\mathcal{L}}$. We define the k[H]-bilinear pairing $\overline{\mathcal{L}} \times \mathcal{L} \to k[H]_U$ by the k-bilinear extension of the pairing given by

$$\langle \delta_1 \gamma_i^{-1} \cdot \overline{\iota}, \delta_2 \gamma_j \cdot \iota \rangle = \begin{cases} 0 & \text{if } i \neq j, \\ \delta_1 \delta_2 & \text{if } i = j \end{cases}$$

for all $\delta_1, \delta_2 \in H$, $i, j \in \{1, ..., n\}$. One readily verifies that this is well-defined and induces the isomorphism of sheaves of k[H]-modules

$$\mathcal{H}om_{k[H]}(\mathcal{L}, k[H]) \cong \overline{\mathcal{L}},$$

which is also an isomorphism of sheaves of R-modules.

Remarks 2.13 and 2.17 motivate the following definition. Indeed, since the stalks of \mathcal{L} are infinite dimensional vector spaces but rank 1 free *R*-modules, it seems more reasonable to dualize over *R* rather than over *k* to define the cohomological version of Alexander modules.

Definition 2.19. Let k be a field. The *i*-th (multivariable) cohomology Alexander module associated to (U, f) is the *R*-module $H^i(U, \overline{\mathcal{L}})$, where $R = k[\pi_1(G)]$.

2.3. Truncated local systems. For the purposes of doing Hodge theory on Alexander modules, we will have to work with truncated versions of the local systems \mathcal{L} and $\overline{\mathcal{L}}$.

Definition 2.20. Let $m \in \mathbb{Z}_{>0}$, and let $k = \mathbb{Q}, \mathbb{R}, \mathbb{C}$. We define the rings R_{∞} and R_m by

$$R_{\infty} \coloneqq \prod_{j=0}^{\infty} \operatorname{Sym}^{j} H_{1}(G,k); \quad R_{m} \coloneqq \frac{R_{\infty}}{\prod_{j=m}^{\infty} \operatorname{Sym}^{j} H_{1}(G,k)},$$

and the R_m -module R_{-m} by

$$R_{-m} \coloneqq \operatorname{Hom}_k(R_m, k).$$

Note that for all m > 0, R_m and R_{-m} have natural R_{∞} -module structures. Also note that the field k does not appear in the notation for R_{∞} , R_m and R_{-m} (like it did not appear in R), but whenever we use this notation, the base field will either be explicitly specified or clear from context.

Notation 2.21. For all $\gamma \in \pi_1(G)$ we denote its corresponding element in $H_1(G,\mathbb{Z}) \subset H_1(G,k)$ by $\log \gamma$.

Even if $\pi_1(G)$ is abelian and thus isomorphic to $H_1(G,\mathbb{Z})$, this notation is useful because $\pi_1(G)$ will be thought of as having multiplication as its group operation, but $H_1(G,\mathbb{Z})$ has the sum as its group operation.

Definition 2.22 (The *R*-module structure of R_{∞} , R_m and R_{-m}). Let m > 0. The *k*-linear ring monomorphism

$$\begin{array}{ccc} R = k[\pi_1(G)] & \longrightarrow & R_\infty \\ \gamma & \longmapsto & e^{\log \gamma} \end{array}$$

endows R_{∞} , R_m and R_{-m} with *R*-module structures.

Remark 2.23 $(R_m \text{ and } R/\mathfrak{m}^m \text{ are isomorphic } R\text{-modules})$. Let $\mathfrak{m} := (\gamma - 1 | \gamma \in \pi_1(G))$ be the augmentation ideal of R, and let $m \geq 1$. The image of \mathfrak{m} by the k-linear ring monomorphism described in Definition 2.22 lies in $\prod_{j=1}^{\infty} \operatorname{Sym}^j H_1(G,k)$, so one gets an induced ring homomorphism $R/\mathfrak{m}^m \to R_m$, which is also an R-module homomorphism. In fact, it is an R-module isomorphism. To see this, it suffices to see that $R/\mathfrak{m}^m \to R_m$ is an isomorphism of k-vector spaces. Let $\gamma_1, \ldots, \gamma_r$ be a basis of generators of $\pi_1(G)$, and let us consider the bases

$$\bigcup_{j=0}^{m-1} \{ (\gamma_1 - 1)^{i_1} \cdots (\gamma_r - 1)^{i_r} \mid i_l \ge 0 \text{ for all } l = 1, \dots, r, \quad i_1 + \dots + i_r = j \}, \\ \bigcup_{j=0}^{m-1} \{ (\log \gamma_1)^{i_1} \cdots (\log \gamma_r)^{i_r} \mid i_l \ge 0 \text{ for all } l = 1, \dots, r, \quad i_1 + \dots + i_r = j \}$$

of R/\mathfrak{m}^m and R_m respectively, where both are ordered in the same way by increasing order of j, and amongst the ones with the same j, by lexicographical order. The square matrix representing the Rmodule homomorphism between R/\mathfrak{m}^m and R_m (seen as a k-linear homomorphism) in these bases is triangular with ones along the diagonal.

Remark 2.24. Let $\mathfrak{m} \subset R$ be as in the previous remark. Taking inverse limits in the isomorphism between $\frac{R}{\mathfrak{m}^m}$ and R_m from the previous remark, one obtains an *R*-module isomorphism

$$\lim_{\stackrel{\longleftarrow}{\longleftarrow}} \frac{R}{\mathfrak{m}^m} \cong R_\infty.$$

In light of the Definition 2.22, we can think about the local systems $R_{\infty} \otimes_R \mathcal{L}$, $R_m \otimes_R \mathcal{L}$ and $R_{-m} \otimes_R \mathcal{L}$, and similarly with $\overline{\mathcal{L}}$. Note that, by tensoring \mathcal{L} or $\overline{\mathcal{L}}$ with R_m (resp. R_{-m}) over R, we obtain finite dimensional k-local systems whose stalk is isomorphic to R_m (resp. R_{-m}). These will be the truncated local systems that we consider.

Let us understand the relationship between the homology and the cohomology of these truncated local systems. We begin by recalling a well-known duality result for finite dimensional k-local systems.

Proposition 2.25 (cf. [11] section 2.5). Let L be a finite dimensional local system over a field k on a connected algebraic variety X. Then, for all $i \ge 0$, there is a natural isomorphism

$$\operatorname{Hom}_k(H_i(X,L),k) \cong H^i(X,\operatorname{Hom}_k(L,k))$$

Remark 2.26 (Relationship between homology and cohomology). For all $m \neq 0$, we have a chain of natural isomorphisms

$$\mathcal{H}om_{k}(R_{m} \otimes_{R} \mathcal{L}, k) \cong \mathcal{H}om_{R}(\mathcal{L}, \operatorname{Hom}_{k}(R_{m}, k))$$
(Tensor-hom adjunction)
$$= \mathcal{H}om_{R}(\mathcal{L}, R_{-m})$$
$$\cong \mathcal{H}om_{R}(\mathcal{L}, R) \otimes_{R} R_{-m}$$
(Because \mathcal{L} is locally free over R)
$$\cong \overline{\mathcal{L}} \otimes_{R} R_{-m}.$$
 Remark 2.17

Since R is commutative, one can identify $\overline{\mathcal{L}} \otimes_R R_{-m}$ with $R_{-m} \otimes_R \overline{\mathcal{L}}$. We apply Proposition 2.25 to $L = R_m \otimes_R \mathcal{L}$, and the above to get R and R_∞ -module isomorphisms for all $i \ge 0$ and $m \ne 0$:

$$\operatorname{Hom}_{k}(H_{i}(U, R_{m} \otimes_{R} \mathcal{L}), k) \cong H^{i}(U, \mathcal{H}om_{k}(R_{m} \otimes_{R} \mathcal{L}, k)).$$
Proposition 2.25
$$\cong H^{i}(U, R_{-m} \otimes_{R} \overline{\mathcal{L}}).$$

Remark 2.27. Let H be a finite index subgroup of $\pi_1(G)$, and let $\pi_H : G_H \to G$ be the corresponding finite cover. G_H is the quotient of TG by H, where $H \leq \pi_1(G)$ acts by deck transformations. In particular, G_H is a commutative algebraic group, which is in fact a semiabelian variety (see [8, Section 3], for example), and π_H is a morphism of algebraic groups. In that case, we may define $R^H := k[H] = k[\pi_1(G_H)]$, and R^H_{∞} , R^H_m and R^H_{-m} analogously as in Definition 2.20 using $H_1(G_H, k)$ instead of $H_1(G, k)$. Note that \mathcal{L} is locally free of finite rank as a sheaf of R^H -modules. Hence, using Remark 2.17, the argument in Remark 2.26 can be replicated to obtain R^H and R^H_{∞} -module isomorphisms

$$\operatorname{Hom}_{k}(H_{i}(U, R_{m}^{H} \otimes_{R^{H}} \mathcal{L}), k) \cong H^{i}(U, R_{-m}^{H} \otimes_{R^{H}} \overline{\mathcal{L}})$$

for all $m \neq 0$ and all $i \geq 0$.

The rest of Section 2.3 will be devoted to establishing the relationship between the (co)homology of these truncated local systems and the homological and cohomological Alexander modules of Definitions 2.9 and 2.19. For this, we will need the following technical result.

Proposition 2.28. Let (S, \mathfrak{a}) be a complete Noetherian local ring. Let C^{\bullet} be a complex of finitely generated free S-modules. For $m \geq 0$, let $S_m \coloneqq S/\mathfrak{a}^m$. Then, the natural maps $\Xi_{\infty,m} \colon H^i(C^{\bullet}) \to H^i(S_m \otimes_S C^{\bullet})$ induce an isomorphism of S-modules:

$$\Xi \colon H^i(C^{\bullet}) \xrightarrow{\cong} \varprojlim_m H^i(S_m \otimes_S C^{\bullet})$$

Proof. First, we show that the map is injective. Let $M = \frac{C^i}{dC^{i-1}}$, and let $N = H^i(C^{\bullet}) \subseteq M$. Following the definitions, we have that

$$\ker \Xi = \bigcap_m \ker \Xi_{\infty,m} = \bigcap_m (\mathfrak{a}^m M \cap N) \subseteq \bigcap_m \mathfrak{a}^m M = 0,$$

where the last equality follows from Krull's Intersection Theorem.

Let us now prove that Ξ is surjective. It suffices to prove that for every m there exists an $m' \gg m$ such that

$$\operatorname{im} \Xi_{m',m} \subseteq \operatorname{im} \Xi_{\infty,m},$$

where $\Xi_{m',m}$ is the natural map $H^i(S_{m'} \otimes C^{\bullet}) \to H^i(S_m \otimes C^{\bullet})$. Consider the map of short exact sequences:

Taking cohomology, it induces the following map of exact sequences for every i:

$$\begin{array}{cccc} H^{i}(C^{\bullet}) & \xrightarrow{\Xi_{\infty,m'}} & H^{i}(S_{m'} \otimes C^{\bullet}) & \longrightarrow & \ker(H^{i+1}(\mathfrak{a}^{m'}C^{\bullet}) \to H^{i+1}(C^{\bullet})) & \longrightarrow & 0 \\ \downarrow = & & \downarrow \Xi_{m',m} & & \downarrow \star \\ H^{i}(C^{\bullet}) & \xrightarrow{\Xi_{\infty,m}} & H^{i}(S_{m} \otimes C^{\bullet}) & \longrightarrow & \ker(H^{i+1}(\mathfrak{a}^{m}C^{\bullet}) \to H^{i+1}(C^{\bullet})) & \longrightarrow & 0. \end{array}$$

By the exactness of the rows, it is enough to show that for $m' \gg m, \star = 0$. By definition,

$$\ker(H^{i+1}(\mathfrak{a}^{m'}C^{\bullet}) \to H^{i+1}(C^{\bullet})) = \frac{\mathfrak{a}^{m'}C^{i+1} \cap d^{-1}(0) \cap dC^{i}}{d(\mathfrak{a}^{m'}C^{i})} \subseteq \frac{\mathfrak{a}^{m'}C^{i+1} \cap dC^{i}}{d(\mathfrak{a}^{m'}C^{i})}$$

We apply the Artin-Rees Lemma to the module C^{i+1} and its submodule dC^i , to conclude that there exists an $m_0 \gg 0$ such that for all $m \ge 0$,

$$\mathfrak{a}^{m+m_0}C^{i+1} \cap dC^i = \mathfrak{a}^m(\mathfrak{a}^{m_0}C^{i+1} \cap dC^i) \subseteq \mathfrak{a}^m(dC^i) = d(\mathfrak{a}^mC^i).$$

So, if $m' \ge m_0 + m$, the starred map indeed vanishes, as desired.

Corollary 2.29. Let R_{∞} and R_m be as in Definition 2.20, for $m \ge 1$. The natural maps induce an isomorphism of R_{∞} -modules

$$R_{\infty} \otimes_{R} H^{i}(U, \overline{\mathcal{L}}) = \left(\varprojlim_{m} R_{m} \right) \otimes_{R} H^{i}(U, \overline{\mathcal{L}}) \xrightarrow{\cong} \varprojlim_{m} H^{i}\left(U, R_{m} \otimes_{R} \overline{\mathcal{L}}\right).$$

Proof. Recall that U has the homotopy type of a finite CW-complex, so $H^{\bullet}(U, \overline{\mathcal{L}})$ is represented by a bounded complex of finitely generated free R-modules C^{\bullet} as in [11, Section 2.5]. Now, by Remark 2.24, $R_{\infty} \cong \left(\varprojlim_{m} \frac{R}{\mathfrak{m}^{m}} \right)$, so the ring R_{∞} is flat over R. In particular, the cohomology of $R_{\infty} \otimes_{R} C^{\bullet}$ is naturally $R_{\infty} \otimes_{R} H^{i}(U, \overline{\mathcal{L}})$.

Let $(S, \mathfrak{a}) = (R_{\infty}, \prod_{j=1}^{\infty} \operatorname{Sym}^{j} H_{1}(G, k))$ in Proposition 2.28 (so $S_{m} = R_{m}$) and apply it to the complex of free R_{∞} -modules $R_{\infty} \otimes_{R} C^{\bullet}$ to obtain an isomorphism:

$$\left(\varprojlim_{m} R_{m}\right) \otimes_{R} H^{i}(U, \overline{\mathcal{L}}) \xrightarrow{\sim} \varprojlim_{m} H^{i}(R_{m} \otimes_{R_{\infty}} R_{\infty} \otimes_{R} C^{\bullet}) = \varprojlim_{m} H^{i}(R_{m} \otimes_{R} C^{\bullet}).$$

Finally, notice that $H^i(R_m \otimes_R C^{\bullet}) = H^i(U, R_m \otimes_R \overline{\mathcal{L}}).$

Corollary 2.30. Let $m \ge 1$, and R_{∞} , R_m and R_{-m} as in Definition 2.20. There is a natural isomorphism

$$R_{\infty} \otimes_R H_i(U, \mathcal{L}) \xrightarrow{\sim} \varprojlim_m \operatorname{Hom}_k \left(H^i(U, R_{-m} \otimes_R \overline{\mathcal{L}}), k \right)$$

Proof. By the analogous reasoning to the proof of Corollary 2.29, we have that the natural maps induce an isomorphism:

$$\left(\varprojlim_{m} R_{m}\right) \otimes_{R} H_{i}(U, \mathcal{L}) \xrightarrow{\sim} \varprojlim_{m} H_{i}(U, R_{m} \otimes_{R} \mathcal{L}).$$

Taking duals in Remark 2.26, one obtains

$$H_i(U, R_m \otimes_R \mathcal{L}) \cong \operatorname{Hom}_k \left(H^i(U, R_{-m} \otimes_R \overline{\mathcal{L}}), k \right).$$

2.4. Generalized Albanese varieties. Iitaka ([23], [24]) generalized the Albanese morphism of smooth complete complex algebraic varieties to smooth varieties as follows. For a detailed description, see [20].

Definition 2.31 (Iitaka's generalized Albanese maps). Let U be a smooth connected complex algebraic variety. The *Albanese map* $\alpha_U : U \to G_U$ is a morphism to a semiabelian variety G_U satisfying the following universal property: for any other morphism $\beta : U \to G'$ to a semiabelian variety G', there exists a unique algebraic morphism $f : G_U \to G'$ such that $\beta = f \circ \alpha_U$. Such G_U is usually called the *Albanese* variety of U.

Remark 2.32 (Existence of the Albanese map). The Albanese map α_U exists for any smooth connected complex algebraic variety (see [20]), and hence the Albanese variety G_U is well defined up to algebraic isomorphism, which, up to translation, will be a group homomorphism as well by Remark 2.8. Once G_U is fixed, α_U is uniquely defined defined up to translation in G_U and isomorphism of algebraic groups from G_U to itself.

Remark 2.33. If U is a smooth connected complex projective variety, G_U in Definition 2.31 is an abelian variety, and α_U is the usual Albanese map.

Lemma 2.34 ([20], Lemma 3.11). Let U be a smooth connected complex algebraic variety, and let $\alpha_U: U \to G_U$ be its Albanese map. Then,

$$(\alpha_U)_* : H_1(U, \mathbb{Z}) \to H_1(G_U, \mathbb{Z})$$

is surjective. Moreover, the kernel of $(\alpha_U)_*$ coincides with the torsion part of $H_1(U,\mathbb{Z})$.

$$\Box$$

Remark 2.35. Consider the pullback of (1.1) for the map α_U . If $H_1(U,\mathbb{Z})$ is torsion free, U^{α_U} is the universal abelian cover of U.

Example 2.36 (Affine hypersurface complements). Suppose that $U = \mathbb{C}^n \setminus H$ is an affine hypersurface complement, where $H = V(f_1 \cdots f_m)$, and f_i are non-constant irreducible polynomials in $\mathbb{C}[x_1, \ldots, x_n]$ such that f_i and f_j do not have any non-constant common factors for all $i \neq j \in \{1, \ldots, m\}$. Then, $H_1(U,\mathbb{Z}) \cong \mathbb{Z}^m$ is generated by a choice of a positively oriented meridians around each of the m irreducible components of H, the map

$$f = (f_1, \dots, f_m) \colon U \longrightarrow (\mathbb{C}^*)^m$$
$$x \longmapsto (f_1(x), \dots, f_n(x))$$

induces an isomorphism on first (integral) homology groups, and hence U^f is the universal abelian cover of U. In this case, $H_1(U^f, \mathbb{Q})$ is generally called the Alexander invariant (with \mathbb{Q} -coefficients) of the hypersurface H.

Let us see that the map $f = (f_1, \ldots, f_m)$ coincides with the Albanese map of U. Since both α_U and f induce isomorphisms in first homology with \mathbb{Q} -coefficients, the mixed Hodge structure on $H^1(G_U, \mathbb{Q})$ is pure of type (1,1). The Chevalley decomposition of G_U induces a short exact sequence between (abelian) fundamental groups, so if A is the abelian variety in the Chevalley decomposition of G_U , $H^1(A, \mathbb{Q}) \xrightarrow{(p_A)^*} H^1(G_U, \mathbb{Q})$ is an injective morphism between pure Hodge structures of weights 1 and 2 respectively. Thus $H^1(A, \mathbb{Q}) = 0$ and A is a point, so G_U is a torus which, looking at the rank of $H_1(G_U, \mathbb{Q})$, must be isomorphic to $(\mathbb{C}^*)^m$. By the universal property of the Albanese, there exists a unique algebraic morphism $h: G_U \cong (\mathbb{C}^*)^m \to (\mathbb{C}^*)^m$ such that $f = h \circ \alpha_U$ and which, up to translation in the target, is an algebraic group homomorphism between $(\mathbb{C}^*)^m$ and itself which induces an isomorphism between fundamental groups. This implies that h is an isomorphism of algebraic varieties, so f is the Albanese map of U.

2.5. Compactifications. Let U be a smooth connected complex algebraic variety, let G be a complex semiabelian variety and let $f: U \to G$ be an algebraic morphism. For the construction of the mixed Hodge structures in this paper, we will need to compactify f in appropriate ways. First of all, the compactifications of U and G that will appear in this paper will always be *good compactifications*, as defined below.

Definition 2.37 (Good compactification). Let U be a smooth connected complex algebraic variety, and let X be a smooth compactification of U. X is a good compactification of U if $D := X \setminus U$ is a simple normal crossings divisor.

Let us now explain which compactifications of G will appear in this paper.

Corollary 2.38 (Of Proposition 2.5). Let G be a semiabelian variety and let $0 \to G_T \to G \to G_A \to 0$ be its Chevalley decomposition. Then, G has a good compactification \overline{G} which has the structure of a fibration as follows:

$$\overline{G_T} \hookrightarrow \overline{G} \twoheadrightarrow G_A,$$

where $\overline{G_T}$ is the compactification of G_T by a product of \mathbb{P}^1 's.

Proof. Over an open covering of G_A this is the compactification of $(\mathbb{C}^*)^j \times G_A$ by $(\mathbb{P}^1)^j \times G_A$. These compactifications can be glued: by Proposition 2.5 the transition functions are multiplication in G_T by locally defined functions $G_A \to G_T$, which fix the divisors at infinity of $\overline{G_T}$. Finally, the divisor at infinity of \overline{G} has normal crossings, since this can be checked on an open cover.

Definition 2.39 (Allowed compactifications of G). Let Y be a good compactification of G. We say that Y is an allowed compactification of G if there exists an algebraic map $p: Y \to \overline{G}$ satisfying that $j_{\overline{G}} = p \circ j_Y$, where \overline{G} is a compactification of G such as the one described in Corollary 2.38, and $j_{\overline{G}}$ and j_Y are the inclusions of G into its compactifications \overline{G} and Y.

Definition 2.40 (Compatible compactifications w.r.t. f). Let X be a good compactification of U and let Y be an allowed compactification of G. We say that X and Y are compatible compactifications with respect to $f: U \to G$ if f extends to an algebraic morphism $\overline{f}: X \to Y$.

More generally, we have the following definition.

Definition 2.41 (Compatible compactification w.r.t. a commutative diagram). Suppose that U_1 and U_2 are smooth connected complex algebraic varieties, G_1 and G_2 are complex semiabelian varieties, and that we have the following commutative diagram of algebraic maps

$$U_1 \xrightarrow{f_1} G_1$$
$$\downarrow h \qquad \qquad \downarrow g$$
$$U_2 \xrightarrow{f_2} G_2.$$

Let X_i be a good compactification of U_i and let Y_i be an allowed compactification of G_i for i = 1, 2. We say that X_1, X_2, Y_1 and Y_2 are compatible compactifications with respect to the commutative diagram $g \circ f_1 = f_2 \circ h$ if the morphisms in the commutative diagram extend to algebraic morphisms which fit into the following commutative diagram:

$$\begin{array}{ccc} X_1 & \xrightarrow{f_1} & Y_1 \\ & & & \downarrow^{\overline{h}} & & \downarrow^{\overline{g}} \\ X_2 & \xrightarrow{\overline{f_2}} & Y_2. \end{array}$$

The next result follows from a standard argument.

Lemma 2.42 (Existence of compatible compactifications). Let U_1 and U_2 be smooth connected complex algebraic varieties, let G_1 and G_2 be complex semiabelian varieties, and suppose that we have the following commutative diagram of algebraic maps

$$U_1 \xrightarrow{f_1} G_1$$
$$\downarrow_h \qquad \qquad \downarrow^g$$
$$U_2 \xrightarrow{f_2} G_2.$$

Then, there exist compatible compactifications of with respect to the commutative diagram $g \circ f_1 = f_2 \circ h$.

In particular, if $f: U \to G$ is an algebraic morphism from a smooth connected complex algebraic variety to a complex semiabelian variety, there exist compatible compactifications with respect to f.

Proof. Let Z_2 be a good compactification of U_2 , and let $\overline{G_2}$ be a compactification of G_2 as in Corollary 2.38. Let X_2 be a resolution of singularities of the closure of the graph of f inside of $Z_2 \times \overline{G_2}$, such that X_2 is a good compactification of U_2 . By construction, f_2 extends to an algebraic map $\overline{f_2}: X_2 \to \overline{G_2}$.

Now, fix $\overline{G_1}$ a compactification of G_1 as in Corollary 2.38. By looking at the closure of the graph of h inside of $\overline{G_1} \times \overline{G_2}$ and resolving singularities as in the previous paragraph, we find an allowed compactification Y_1 of G_1 .

Following this argument, we can find good compactifications X'_1 and X''_1 of U_1 such that f_1 and h extend to algebraic morphisms $\overline{f_1}': X'_1 \to Y_1$ and $\overline{h}'': X''_1 \to X_2$. Let X_1 be a resolution of singularities of the closure of the graph of the identity map inside of $X'_1 \times X''_1$, such that X_1 is a good compactification of U. By construction, there exist algebraic maps $p_1: X_1 \to X'_1$ and $p_2: X_1 \to X''_1$ which extend the identity from U_1 to itself. Let $\overline{f_1} = \overline{f_1}' \circ p_1$, and $\overline{h} = \overline{h}'' \circ p_2$.

We claim that X_1 , X_2 , Y_1 and $\overline{G_2}$ are compatible compactifications with respect to $g \circ f_1 = f_2 \circ h$. This follows from the fact that $\overline{g} \circ \overline{f_1}$ and $\overline{f_2} \circ \overline{h}$ both agree on U_1 , and there exists a unique way of extending them continuously to X_1 .

2.6. Commutative Differential Graded Algebras.

Definition 2.43 (Commutative differential graded algebra (cdga)). A commutative differential graded k-algebra (cdga) is a triple

$$(A, d, \wedge)$$

such that:

- (A, \wedge) is a non-negatively graded unitary associative k-algebra.
- $a \wedge b = (-1)^{\deg(a) \deg(b)} b \wedge a$ for homogeneous $a, b \in A$.
- (A, d) is a cochain complex.
- $d(a \wedge b) = da \wedge b + (-1)^{\deg(a)}a \wedge db$ for homogeneous $a, b \in A$.

Notice that when we write a cdga, the field k is implicit. We often will write A instead of (A, d, \wedge) when the differential and multiplication are understood.

When we discuss Hodge complexes in Section 2.8, we will often work with filtered cdgas whose filtrations are compatible with the differential and the multiplication.

Definition 2.44 (cdga filtrations). Suppose (A, d, \wedge) is a cdga. An *increasing cdga filtration* on (A, d, \wedge) is an increasing filtration W on A such that

$$W_i A \wedge W_i A \subset W_{i+i} A$$
 and $d(W_i A) \subset W_i A$

for all integers i and j. By a *decreasing cdga filtration* on (A, d, \wedge) we mean a decreasing filtration F^{\cdot} on A such that

$$F^i A \wedge F^j A \subset F^{i+j} A$$
 and $d(F^i A) \subset F^i A$

for all integers i and j.

One defines *cdga filtrations on a sheaf of cdgas* analogously, by looking at the cdgas of sections over arbitrary open subsets.

2.7. Differential graded Lie algebras and deformation theory. Differential graded Lie algebras (dglas) provide a compact way to package the deformation theory of an object, in our case, a chain complex. We will review the definitions for the purpose of fixing notation. We will work over a (commutative, unital) ring A, which we will later assume to be Artinian local.

Definition 2.45. A dgla over A is a graded A-module $M = \bigoplus_{j \in \mathbb{Z}} M^j$ together with two A-(bi)linear operations:

- a differential $d: M \to M$ which has degree 1, i.e. $dM^j \subseteq M^{j+1}$, and
- a bracket $[\cdot, \cdot]: M \otimes_A M \to M$ of degree 0, i.e. $[M^j, M^{j'}] \subseteq M^{j+j'}$

subject to the following restrictions: throughout, suppose $a, b, c \in M$ are homogeneous elements of degrees |a|, |b|, |c|, respectively.

- (M, d) is a complex, i.e. $d^2 = 0$.
- The bracket is graded-anticommutative:

$$[a,b] = -(-1)^{|a||b|}[b,a].$$

• The bracket satisfies the graded Jacobi identity:

$$[a, [b, c]] = [[a, b], c] + (-1)^{|a||b|} [b, [a, c]].$$

• The differential is a graded derivation for the bracket:

$$d[a,b] = [da,b] + (-1)^{|a|}[a,db]$$

Remark 2.46. Our main example of a dgla is the following: suppose (M^{\bullet}, d, \cdot) is a differential graded associative algebra, i.e. (M^{\bullet}, d) is a complex, and \cdot is an associative product for which $d(a \cdot b) = (da) \cdot b + (-1)^{|a|} a \cdot (db)$. Then, automatically $(M^{\bullet}, d, [,])$ is a dgla with the bracket given by

$$[a, b] = a \cdot b - (-1)^{|a||b|} b \cdot a$$

Definition 2.47. Let (A, \mathfrak{m}) be an Artinian local k-algebra with a fixed map $A \twoheadrightarrow k$, and let (C^{\bullet}, d) be a bounded complex of k-vector spaces. A deformation of (C^{\bullet}, d) over A is a complex $(\tilde{C}^{\bullet}, \tilde{D})$ of free A-modules, together with an isomorphism of complexes $k \otimes_A \tilde{C}^{\bullet} \cong C^{\bullet}$.

We will be interested in how endomorphisms of C give rise to deformations.

Remark 2.48. Let C^{\bullet} be a bounded complex of k-vector spaces. Then the vector space of k-linear endomorphisms $\operatorname{End}_{k}^{\bullet}(C^{\bullet})$ is a differential graded associative algebra, where the homogeneous elements of degree k are linear maps ϕ such that $\phi(C^{j}) \subseteq C^{j+k}$. The product is composition, and the differential is the graded commutator with d, i.e. if ϕ has degree $|\phi|$,

$$d \cdot \phi \coloneqq d \circ \phi - (-1)^{|\phi|} \phi \circ d.$$

Note that with this differential, $H^j(\operatorname{End}_k^{\bullet}(C^{\bullet}))$ is the group of homotopy classes of complex morphisms $C^{\bullet} \to C^{\bullet}[j]$ (recall that by convention the differential on $C^{\bullet}[j]$ is $(-1)^j d$). By Remark 2.46, $\operatorname{End}_k^{\bullet}(C^{\bullet})$ is a dgla with the bracket given by the commutator.

Remark 2.49. Let $S_1 \to S_2$ be a ring map. If L^{\bullet} is a S_1 -dgla, $S_2 \otimes_{S_1} L^{\bullet}$ becomes a dgla with the bracket $[a_1 \otimes m_1, a_2 \otimes m_2] \coloneqq a_1 a_2 \otimes [m_1, m_2]$. We are interested in the ring map $k \to A$ and the k-dgla $L^{\bullet} = \operatorname{End}_k^{\bullet}(C^{\bullet})$. In this case, $A \otimes_k L^{\bullet} = \operatorname{End}_A^{\bullet}(A \otimes_k C^{\bullet})$, and the Lie bracket extended from k coincides with the commutator of endomorphisms. Furthermore, $\mathfrak{m} \operatorname{End}^{\bullet}(C^{\bullet}) \coloneqq \mathfrak{m} \otimes_k \operatorname{End}_k^{\bullet}(C^{\bullet}) = \operatorname{Hom}_k^{\bullet}(C^{\bullet}, \mathfrak{m} \otimes_k C^{\bullet}, \mathfrak{m} \otimes_k C^{\bullet})$ is a sub-dgla.

Lemma 2.50. Let $k = \mathbb{Q}, \mathbb{R}$ or \mathbb{C} , and let (A, \mathfrak{m}) be a local Artinian k-algebra with residue field k. Let (C^{\bullet}, d) be a bounded complex of A-modules. Suppose $\phi \in \mathfrak{m} \operatorname{End}^{1}(C^{\bullet})$ satisfies the Maurer-Cartan equation, *i.e.*:

$$d \cdot \phi + \frac{1}{2}[\phi, \phi] = 0$$

Then, $(C^{\bullet}, d + \phi)$ is a complex of A-modules. Furthermore, for any $\rho \in \mathfrak{m} \operatorname{End}^{0}(C^{\bullet})$, one obtains an isomorphism $e^{\rho} \coloneqq \sum_{k=0}^{\infty} \frac{1}{k!} \rho^{k}$:

$$e^{\rho} \colon (C^{\bullet}, d+\phi) \xrightarrow{\sim} (C^{\bullet}, d+\phi+[e^{\rho}, d+\phi]e^{-\rho})$$

If $[\rho, [\rho, d + \phi]] = 0$, then e^{ρ} is an isomorphism:

$$e^{\rho} \colon (C^{\bullet}, d+\phi) \xrightarrow{\sim} (C^{\bullet}, d+\phi-d\cdot\rho+[\rho,\phi]).$$

The same result holds if M is a left A-module and we substitute (C^{\bullet}, d) for a bounded complex of sheaves of A-modules $(M \otimes_k \mathcal{K}^{\bullet}, \mathrm{Id}_M \otimes_k d)$ (where $(\mathcal{K}^{\bullet}, d)$ is a bounded complex of sheaves of k-vector spaces), $\phi \in \mathcal{H}om_A^1(M \otimes_k \mathcal{K}^{\bullet}, \mathfrak{m}M \otimes_k \mathcal{K}^{\bullet})$ and $\rho \in \mathcal{H}om_A^0(M \otimes_k \mathcal{K}^{\bullet}, \mathfrak{m}M \otimes_k \mathcal{K}^{\bullet})$.

Proof. This is all direct computation. Note that A is Artinian local, so \mathfrak{m} is nilpotent, which ensures that e^{ρ} is well-defined.

Remark 2.51. Let k be a field, and let A be a local Artinian k-algebra with maximal ideal \mathfrak{m} . Let (C^{\bullet}, d, \cdot) be an A-cdga and let (M^{\bullet}, d) be a C^{\bullet} -differential graded (left) module. In other words, multiplication induces an A-dga homomorphism $C^{\bullet} \to \operatorname{End}_A(M^{\bullet})$. Let us abuse notation and use the same letter for elements of C^{\bullet} and their multiplication endomorphism.

- (1) For any $\phi \in \mathfrak{m}C^1$, $[\phi, \phi] = 0$, so the Maurer-Cartan equation is equivalent to $[d, \phi] = 0 \in \operatorname{End}_A(M^{\bullet})$, and therefore the condition that ϕ is closed in C^{\bullet} is sufficient for the Maurer-Cartan equation to hold.
- (2) For any $\phi \in \mathfrak{m}C^1$ and $\rho \in \mathfrak{m}C^0$, $[\rho, d + \phi] = -d\rho$. Therefore, $[\rho, [\rho, d + \phi]] = 0$. Applying Lemma 2.50, e^{ρ} is an isomorphism between $(M^{\bullet}, d + \phi)$ and $(M^{\bullet}, d + \phi d\rho)$.

The same result also holds in the case of sheaves, as in Lemma 2.50.

2.8. Mixed Hodge structures and complexes. The purpose of this section is to compile relevant definitions and to set notations related to mixed Hodge structures (MHS) and mixed Hodge complexes of sheaves. Throughout this section, k will be a subfield of \mathbb{R} and X will be a topological space. We start by recalling how to multi-linear algebra constructions behave with respect to MHS.

Definition-Proposition 2.52 (MHS on the dual, tensor product and symmetric product, cf. Examples 3.2 in [37]). Let (V, W, F^{\cdot}) and (V', W, F^{\cdot}) be k-vector spaces endowed with a MHS, where W are the decreasing weight filtrations and F^{\cdot} are the increasing Hodge filtrations in V and V'. Let $V_{\mathbb{C}}$ (resp. $V'_{\mathbb{C}}$) be $V \otimes_k \mathbb{C}$ (resp. $V' \otimes_k \mathbb{C}$).

• $(\operatorname{Hom}_k(V,k), W, F)$ is a MHS, where

$$W_{-n} \operatorname{Hom}_{k}(V, k) = \{f : V \to k \mid W_{n-1}V \subset \ker f\} \text{ for all } n, \text{ and}$$
$$F^{-p} (\operatorname{Hom}_{k}(V, k)_{\mathbb{C}}) = F_{-p} \operatorname{Hom}_{\mathbb{C}}(V_{\mathbb{C}}, \mathbb{C})$$
$$= \{f : V_{\mathbb{C}} \to \mathbb{C} \mid F^{p+1}(V_{\mathbb{C}}) \subset \ker f\} \text{ for all } p.$$

• $(V \otimes_k V', W, F)$ is a MHS, where

$$W_n(V \otimes_k V') = \sum_m W_m V \otimes_k W_{n-m} V' \quad \text{for all } n, \text{ and}$$
$$F^p(V_{\mathbb{C}} \otimes_{\mathbb{C}} V'_{\mathbb{C}}) = \sum_m F^m V_{\mathbb{C}} \otimes_{\mathbb{C}} F^{p-m} V'_{\mathbb{C}} \quad \text{for all } p.$$

• Let $j \ge 1$. The projection $\underbrace{V \otimes_k V \otimes_k \cdots \otimes_k V}_{j} \to \operatorname{Sym}^j V$ induces a MHS on $\operatorname{Sym}^j V$ given by the image of the filtrations W_{\cdot} and F^{\cdot} in $\underbrace{V \otimes_k V \otimes_k \cdots \otimes_k V}_{j}$. By convention, $\operatorname{Sym}^0 V = k$ is

a pure Hodge structure of type (0, 0).

• The multiplication map $V \otimes_k \operatorname{Sym}^j V \to \operatorname{Sym}^{j+1} V$ is a MHS morphism.

Remark 2.53 (MHS in homology). Let X be a complex algebraic variety. By work of Deligne [9, 10], $H^i(X,k)$ carries a canonical and functorial MHS for all $i \ge 0$. Since $H^i(X,k)$ is finite dimensional, its dual is canonically isomorphic to $H_i(X,k)$. By Definition-Proposition 2.52, $H_i(X,k)$ also carries a canonical and functorial MHS.

Remark 2.54 (MHS on R_m and R_{-m}). Let m > 0, and let R_m and R_{-m} as in Definition 2.20. Since

$$R_m \cong \prod_{j=0}^{m-1} \operatorname{Sym}^j H_1(G,k) = \bigoplus_{j=0}^{m-1} \operatorname{Sym}^j H_1(G,k)$$

and the direct sum of MHS is a MHS, the MHS on $H_1(G, k)$ endows both R_m and R_{-m} (its k-dual) with a MHS by Definition-Proposition 2.52.

In this paper, we will obtain infinite sequences of MHS of the form

$$\cdots \twoheadrightarrow V_{m+1} \twoheadrightarrow V_m \twoheadrightarrow V_{m-1} \twoheadrightarrow \cdots$$

The inverse limit of such a sequence can be regarded as a pro-MHS. We will not use the definition in this paper. as we will simply construct some pro-MHS and morphisms between them naively. Simply, recall that the Yoneda embedding guarantees the existence of such a thing as the category of pro-MHS.

Remark 2.55 (Pro-MHS). Let $V = \varprojlim_m V_m$, where each V_m is a k-MHS for all $m \ge 1$, and all the morphisms involved are MHS morphisms. This data can be regarded as a *pro-MHS*.

Suppose we are given two *pro-MHS* constructed in this way, $V = \varprojlim_m V_m$ and $W = \varprojlim_m W_m$, and given morphisms of MHS $V_m \to W_m$ for all $m \ge 1$ commuting with the linear maps $V_{m'} \to V_m$ and $W_{m'} \to W_m$ for all $m' \ge m \ge 1$. This data determines a *morphism of pro-MHS* $V \to W$.

Remark 2.56. Inverse limits are left exact, and in the context of inverse limits of finite dimensional vector spaces, they are also right exact, since these inverse limits always satisfy the Mittag-Leffler condition. Hence, the category of pro-MHS has kernels, images and cokernels, and they coincide with the kernels, images and cokernels of the underlying vector spaces V.

Definition 2.57 ([37, Definition 3.13]). A k-mixed Hodge complex of sheaves on a topological space X is a triple

$$\mathcal{K}^{\bullet} = ((\mathcal{K}_{k}^{\bullet}, W_{\bullet}), (\mathcal{K}_{\mathbb{C}}^{\bullet}, W_{\bullet}, F^{\bullet}), \alpha)$$

where:

- \mathcal{K}_k^{\bullet} is a bounded below cochain complex of sheaves of k-vector spaces on X such that $\mathbb{H}^*(X, \mathcal{K}_k^{\bullet})$ are finite-dimensional, and W_{\bullet} is an increasing (weight) filtration on \mathcal{K}_k^{\bullet} .
- $\mathcal{K}^{\bullet}_{\mathbb{C}}$ is a bounded below cochain complex of sheaves of \mathbb{C} -vector spaces on X; W_{\bullet} is an increasing (weight) filtration and F^{\bullet} a decreasing (Hodge) filtration on $\mathcal{K}^{\bullet}_{\mathbb{C}}$.
- $\alpha: (\mathcal{K}_k^{\bullet}, W_{\cdot}) \dashrightarrow (\mathcal{K}_{\mathbb{C}}^{\bullet}, W_{\cdot})$ is a pseudo-morphism of filtered complexes of sheaves of k-vector spaces on X (i.e. a chain of morphisms of bounded-below complexes of sheaves as in [37, Definition 2.31] except that each complex in the chain is filtered, as are all the morphisms) that induces a filtered pseudo-isomorphism

$$\alpha \otimes 1 \colon (\mathcal{K}_k^{\bullet} \otimes \mathbb{C}, W_{\bullet} \otimes \mathbb{C}) \dashrightarrow (\mathcal{K}_{\mathbb{C}}^{\bullet}, W_{\bullet})$$

- that is, a pseudo-isomorphism on each graded component.
- for $m \in \mathbb{Z}$, the *m*-th *W*-graded component

$$\operatorname{Gr}_m^W \mathcal{K}^{\bullet} = \left(\operatorname{Gr}_m^W \mathcal{K}_k^{\bullet}, \left(\operatorname{Gr}_m^W \mathcal{K}_{\mathbb{C}}^{\bullet}, F^{\bullet}\right), \operatorname{Gr}_m^W \alpha\right)$$

is a k-Hodge complex of sheaves [37, Definition 2.32] on X of weight m, where F^{\cdot} denotes the induced filtration.

We have not explicitly defined the concept of a k-Hodge complex of sheaves, but we will only use it in the proof of Lemma 3.6, where we will enumerate the conditions that need to be verified. The strategy that we will follow to prove that the rest of our constructions yield new mixed Hodge complexes of sheaves will consist on proving that its W-graded components coincide with complexes that are known to be Hodge complexes of sheaves by Lemma 3.6.

We will sometimes introduce a k-mixed Hodge complex of sheaves on X simply as \mathcal{K}^{\bullet} and implicitly assume the components of the triple to be notationally the same as in the above definition.

Definition 2.58. A multiplicative k-mixed Hodge complex of sheaves on X is a k-mixed Hodge complex of sheaves \mathcal{K}^{\bullet} on X such that the pseudo-morphism α has a distinguished representative given by a chain of morphisms of sheaves of cdgas on X (with all but \mathcal{K}^{\bullet}_k being a sheaf of \mathbb{C} -cdgas), and such that all filtrations (including those in the chain) are cdga-filtrations (over \mathbb{C} except for the weight filtration on \mathcal{K}^{\bullet}_k).

From a given mixed Hodge complex of sheaves, one can construct others (translation, Tate twists) as follows: We can also obtain new MHS from a given MHS by shifting the filtrations appropriately.

Definition 2.59 (Tate twist). • Suppose \mathcal{K}^{\bullet} is a *k*-mixed Hodge complex of sheaves on *X*. The *j*-th Tate twist of \mathcal{K}^{\bullet} is the triple

$$\mathcal{K}^{\bullet}(j) = \left(\left(\mathcal{K}_{k}^{\bullet}, W[2j]_{\centerdot} \right), \left(\mathcal{K}_{\mathbb{C}}^{\bullet}, W[2j]_{\centerdot}, F[j]^{\centerdot} \right), \alpha \right)$$

where $W[2j]_i = W_{2j+i}$ and $F[j]^i = F^{j+i}$ are shifted filtrations. $\mathcal{K}^{\bullet}(j)$ is again a k-mixed Hodge complex of sheaves on X. For details see [37, Definition 3.14].

• The *j*-th Tate twist of a k-mixed Hodge structure is defined by shifting the weight and Hodge filtrations with the same formula we used for mixed Hodge complexes above. See [37, Example 3.2(3)] for an explicit definition.

Notice that we have changed the convention of [37, Examples 3.2 (3)] in all of these definitions of Tate twists by selecting not to multiply by $(2\pi i)^{2j}$.

Remark 2.60. The two definitions of Tate twist above are compatible in the following sense. Let $\mathbb{H}^i(X, \mathcal{K}^{\bullet}_k(j))$ (resp. $\mathbb{H}^i(X, \mathcal{K}^{\bullet}_k)$) be the *k*-MHS induced in hypercohomology by the *k*-mixed Hodge complex of sheaves $\mathcal{K}^{\bullet}(j)$ (resp. \mathcal{K}^{\bullet}). By [37, Theorem 3.18], $\mathbb{H}^i(X, \mathcal{K}^{\bullet}_k(j)) = \mathbb{H}^i(X, \mathcal{K}^{\bullet}_k)(j)$.

Example 2.61. Suppose that $G = \mathbb{C}^*$ in Remark 2.54, and let $m \ge 1$. We have that $H_1(G, k)$ is a pure Hodge structure of type (-1, -1). Let s be a generator of $H_1(G, \mathbb{Z})$ (seen inside of $H_1(G, k)$). We have that $\{1 = s^0, s, s^2, \ldots, s^{m-1}\}$ is a k basis of R_m , and let $\{1^{\vee} = (s^0)^{\vee}, s^{\vee}, (s^2)^{\vee}, \ldots, (s^{m-1})^{\vee}\}$ be its dual basis. The following k-linear isomorphism defined on a basis as

$$\begin{array}{rcccc} A_m: & R_m & \longrightarrow & R_{-m} \\ & s^j & \longmapsto & (s^{m-1-j})^{\vee} & \text{ for all } j=0,\ldots,m-1 \end{array}$$

is also an R_{∞} -linear isomorphism which induces a MHS isomorphism $R_m(1-m) \to R_{-m}$, where (1-m) denotes the m-1-th Tate twist.

Definition 2.62 (Translation of a Mixed Hodge complex of sheaves).

- If \mathcal{F}^{\bullet} is a complex of sheaves on X, then its *translation* by $r \in \mathbb{Z}$ is the complex $\mathcal{F}^{\bullet}[r] = \mathcal{F}^{\bullet+r}$ with differential $d^{\bullet}[r] = -(1)^r d^{\bullet+r}$.
- Suppose \mathcal{K}^{\bullet} is a k-mixed Hodge complex of sheaves on X. The translation of \mathcal{K}^{\bullet} by $r \in \mathbb{Z}$ is the triple

$$\mathcal{K}^{\bullet}[r] = ((\mathcal{K}_{k}^{\bullet}[r], W[r]_{\centerdot}), (\mathcal{K}_{\mathbb{C}}^{\bullet}[r], W[r]_{\centerdot}, F[r]^{\centerdot}), \alpha[r])$$

where the filtrations are described by:

$$(W[r])_i \left(\mathcal{K}^{\bullet}_k[r] \right) = (W_{i+r} \mathcal{K}^{\bullet}_k) [r], \ (W[r])_i \left(\mathcal{K}^{\bullet}_{\mathbb{C}}[r] \right) = (W_{i+r} \mathcal{K}^{\bullet}_{\mathbb{C}}) [r], \ i \in \mathbb{Z}$$
$$(F[r])^p \left(\mathcal{K}^{\bullet}_{\mathbb{C}}[r] \right) = \left(F^{p+r} \mathcal{K}^{\bullet}_{\mathbb{C}} \right) [r], \ p \in \mathbb{Z}.$$

This is again a k-mixed Hodge complex of sheaves on X.

Note that this agrees with the translation of a pure Hodge complex as defined in [37, Lemma-Definition 2.35] for pure Hodge complexes, but not with the translation of mixed Hodge complexes implicit in loc. cit. Theorem 3.22.

Remark 2.63. Suppose \mathcal{K}^{\bullet} is a k-mixed Hodge complex of sheaves on X. By [37, Theorem 3.18II] the hypercohomology vector spaces $\mathbb{H}^*(X, \mathcal{K}^{\bullet}_k)$ inherit k-mixed Hodge structures. There is a relation between Tate twists and the translation of a k-mixed Hodge complex \mathcal{K}^{\bullet} of sheaves on X. Namely it can be shown that:

$$\mathbb{H}^*(X, \mathcal{K}^{\bullet}_k[r]) \cong \mathbb{H}^{*+r}(X, \mathcal{K}^{\bullet}_k)(r)$$

where a Tate twist has been taken on the right-hand side, and the k-mixed Hodge structure on the left-hand side has been induced by the translated k-mixed Hodge complex $\mathcal{K}^{\bullet}[r]$.

Definition 2.64 (Derived direct image of a mixed Hodge complex of sheaves.). Let \mathcal{K}^{\bullet} be a k-mixed Hodge complex of sheaves on X where the filtrations W and F^{\bullet} are biregular (i.e. for all m, the filtrations induced on \mathcal{K}^m are finite). Suppose that $g: X \to Y$ is a continuous map between two topological spaces. The derived direct image of \mathcal{K}^{\bullet} via g is again a mixed Hodge complex of sheaves, and it is defined as follows ([37, B.2.5]).

Let $\operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}\mathcal{F}^{\bullet}]$ be the Godement resolution of a complex of sheaves \mathcal{F}^{\bullet} as defined in [37, B.2.1], which is a flabby resolution. Here, $\operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}\mathcal{F}^{\bullet}]$ denotes the simple complex associated to the double complex $\mathcal{C}^{\bullet}_{\operatorname{Gdm}}\mathcal{F}^{\bullet}$. We define $Rg_*\mathcal{K}^{\bullet}$ to be the triple

 $\left(\left(g_* \operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}\mathcal{K}^{\bullet}_k], g_* \operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}W_{\cdot}]\right), \left(g_* \operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}\mathcal{K}^{\bullet}_{\mathbb{C}}], g_* \operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}W_{\cdot}], g_* \operatorname{Tot}[\mathcal{C}^{\bullet}_{\operatorname{Gdm}}F_{\cdot}]\right), g_*\alpha\right)$

where $g_*\alpha$ is the pseudo-morphism of filtered complexes of sheaves of k-vector spaces induced by α and the functoriality of both g_* and the Godement resolution.

2.9. The analytic logarithmic Dolbeault complex. Let U be a smooth algebraic variety, let X be a good compactification of U and let $D := X \setminus U$. Deligne defined a mixed Hodge complex of sheaves on X whose hypercohomology computes $H^*(U, \mathbb{R})$, endowing it with a canonical and functorial mixed Hodge structure. If $j: U \hookrightarrow X$ is the inclusion, Deligne considered:

$$(j_*\mathcal{E}^{\bullet}_{U,\mathbb{R}},\tau_{\leq \bullet}) \to (j_*\mathcal{E}^{\bullet}_{U,\mathbb{C}},\tau_{\leq \bullet}) \stackrel{\sim}{\longleftrightarrow} (\Omega^{\bullet}_X(\log D),\tau_{\leq \bullet}) \stackrel{\sim}{\hookrightarrow} (\Omega^{\bullet}_X(\log D),W_{\bullet},F^{\bullet}),$$

where $\mathcal{E}_{U,\mathbb{R}}^{\bullet}$ is the real (C^{∞}) de Rham complex on U, $\mathcal{E}_{U,\mathbb{C}}^{\bullet} := \mathcal{E}_{U,\mathbb{R}}^{\bullet} \otimes_{\mathbb{R}} \mathbb{C}$, Ω_U^{\bullet} is the holomorphic de Rham complex on U, and $\Omega_X^{\bullet}(\log D)$ is the subcomplex of $j_*\Omega_U^{\bullet}$ formed by the forms ω with logarithmic poles along D (both ω and $d\omega$ have at most a pole of order 1 along D). τ_{\leq} is the increasing canonical filtration, F^{\bullet} is the decreasing trivial filtration, and W_{\bullet} is given by the order of the poles (see [37, Theorem 4.2] for the precise definition).

Let us introduce different de Rham complexes from the ones in Deligne's mixed Hodge complex of sheaves.

Definition 2.65 (Real analytic de Rham complex of sheaves). For every smooth complex algebraic variety Y,

- $(\mathcal{A}^{\bullet}_{Y\mathbb{R}}, d)$ denotes the real analytic de Rham complex of sheaves on Y,
- $(\mathcal{A}_{Y,\mathbb{C}}^{\bullet}, d)$ denotes the real analytic de Rham complex of sheaves on Y with values over \mathbb{C} , i.e. $\mathcal{A}_{Y,\mathbb{C}}^{\bullet} \coloneqq \mathcal{A}_{Y,\mathbb{R}}^{\bullet} \otimes_{\mathbb{R}} \mathbb{C}.$
- $\mathcal{A}_{Y,\mathbb{C}}^{\bullet}$ has a bigrading induced by the complex structure on Y, which we denote by $\mathcal{A}_{Y,\mathbb{C}}^{\bullet\bullet}$, as follows: if z_1, \ldots, z_n are local holomorphic coordinates of Y, the forms in $\mathcal{A}_{Y\mathbb{C}}^{p,q}$ are locally generated over $\mathcal{A}_{Y,\mathbb{C}}^0$ by $dz_{i_1} \wedge \ldots \wedge dz_{i_p} \wedge d\overline{z_{j_i}} \wedge \ldots \wedge d\overline{z_{j_q}}$ for $i_1, \ldots, i_p, j_i, \ldots, j_q \in \{1, \ldots, n\}$.

Remark 2.66. $\mathcal{A}_{U,\mathbb{C}}^{\bullet}$ (and thus also $\mathcal{A}_{U,\mathbb{R}}^{\bullet}$) is a complex of j_* -acyclic and Γ -acyclic sheaves. The Γ -acyclicity is well known (see [25, p. 127], for example). For the j_* -acyclicity, it suffices to show that $\mathbb{H}^{i}(V_{x} \cap U, \mathcal{A}_{U,\mathbb{C}}^{k}) = 0$ for all $i > 0, k \ge 0, x \in X$ and certain V_{x} neighborhoods of x in X forming a basis. Let $Y = V_x \cap U$, which is a complex (and thus real) analytic manifold. As a real analytic manifold, Y can be embedded into $Y \times \overline{Y}$ as the diagonal, where \overline{Y} is the complex conjugate of Y, and the restriction of $\mathcal{O}_{Y \times \overline{Y}}$ (the sheaf of complex analytic functions on $Y \times \overline{Y}$) to Y is $\mathcal{A}_{U,\mathbb{C}}^0$. By [6, Proposition 5.42], Y possesses arbitrarily small neighborhoods in $Y \times \overline{Y}$ which are Stein. Let W be one such Stein neighborhood. By Oka's coherence theorem and Cartan's theorem B, one gets $\mathbb{H}^i(W, \mathcal{O}_{Y \times \overline{Y}}) = 0$ for all i > 0, so $R\Gamma(W, \mathcal{O}_{Y \times \overline{Y}}) \cong \Gamma(W, \mathcal{O}_{Y \times \overline{Y}})$. Since Y is closed in the paracompact space W, taking direct limits on W approaching Y yields $R\Gamma(Y, \mathcal{A}^0_{U,\mathbb{C}}) = \varinjlim_W \Gamma(W, \mathcal{O}_{Y \times \overline{Y}}) = \Gamma(Y, \mathcal{A}^0_{U,\mathbb{C}})$, obtaining the

 j_* -acyclicity of $\mathcal{A}^0_{U,\mathbb{C}}$. For $k \geq 1$ we follow the same argument, replacing $\mathcal{O}_{Y \times \overline{Y}}$ by $\Omega^k_{Y \times \overline{Y}}$, which is locally free as an $\mathcal{O}_{Y \times \overline{Y}}$ -modules and thus it is also coherent.

In [34] (see also [5] for a similar complex using C^{∞} functions), Navarro Aznar defined a different mixed Hodge complex of sheaves. The complexes of sheaves involved in its construction are the real and complex-valued logarithmic Dolbeault complexes, defined as follows.

Definition 2.67 (Logarithmic Dolbeault Complex). Let U be a smooth connected complex algebraic variety, let X be a good compactification of U, let $D = X \setminus U$, and let $j : U \hookrightarrow X$ be the inclusion. Let us write local holomorphic coordinates (z_i) on X such that D has equation $z_1 \cdots z_r = 0$. The real logarithmic Dolbeault complex $\mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D)$ is the sub- $\mathcal{A}_{X,\mathbb{R}}^{0}$ -algebra of $j_*\mathcal{A}_{U,\mathbb{R}}^{\bullet}$ generated by the local sections

$$\log(z_i\overline{z_i}), \Re\frac{dz_i}{z_i}, \Im\frac{dz_i}{z_i} \quad \text{for } 1 \le i \le r, \quad \Re dz_i, \Im dz_i \quad \text{for } i > r.$$

Similarly, the complex logarithmic Dolbeault complex is defined by $\mathcal{A}_{X,\mathbb{C}}^{\bullet}(\log D) \coloneqq \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D) \otimes_{\mathbb{R}} \mathbb{C}$. Moreover, we define a bigrading on $\mathcal{A}^{\bullet}_X(\log D)$ induced by the bigrading on \mathcal{A}^{\bullet}_U as follows:

 $\mathcal{A}^{p,q}_{X\mathbb{C}}(\log D) \coloneqq \mathcal{A}^{p+q}_{X\mathbb{C}}(\log D) \cap j_*\mathcal{A}^{p,q}_{U\mathbb{C}}.$

Definition 2.68 (Navarro Aznar's mixed Hodge complex of sheaves). Let $U, X, D, j, (z_i)$ as in Definition 2.67. The following data describes a mixed Hodge complex of sheaves $\mathcal{N}_{X,D}^{\bullet}$:

$$\widetilde{\mathcal{N}_{X,D}^{\bullet}} \coloneqq \left((\mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), \widetilde{W}_{\bullet}), (\mathcal{A}_{X,\mathbb{C}}^{\bullet}(\log D), \widetilde{W}_{\bullet}, F^{\bullet}), \alpha \right),$$

where

- the weight filtration \widetilde{W} on $\mathcal{A}^{\bullet}_{X,\mathbb{R}}(\log D)$ (resp. on $\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D)$) is the multiplicative increasing filtration obtained by assigning weight 0 to the sections of $\mathcal{A}_{X,\mathbb{R}}^{\bullet}$ and weight 1 to the sections defined locally by $\log(z_i\overline{z_i}), \Re \frac{dz_i}{z_i}, \Im \frac{dz_i}{z_i}$ for $1 \le i \le r$, • the Hodge filtration F^{\bullet} on $\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D)$ is defined by

$$F^{p}\mathcal{A}_{X,\mathbb{C}}^{\bullet}(\log D) \coloneqq \bigoplus_{p' \ge p} \mathcal{A}_{X,\mathbb{C}}^{p',\bullet}(\log D), \text{ and}$$

• $\alpha \otimes 1 : (\mathcal{A}^{\bullet}_{X\mathbb{R}}(\log D), \widetilde{W}) \otimes_{\mathbb{R}} \mathbb{C} \to (\mathcal{A}^{\bullet}_{X\mathbb{C}}(\log D), \widetilde{W}, F)$ is the identity.

We recall here some important properties of $\mathcal{N}_{X,D}^{\bullet}$.

Theorem 2.69 ([34], Theorem 8.8). The inclusion $(\Omega^{\bullet}_X(\log D), W_{\bullet}, F^{\bullet}) \to (\mathcal{A}^{\bullet}_{X \mathbb{C}}(\log D), \widetilde{W}_{\bullet}, F^{\bullet})$ is a bi-filtered quasi-isomorphism. The (weight and Hodge) filtrations on $\Omega^{\bullet}_X(\log D)$, which were described at the beginning of the section, coincide with the ones induced by the filtrations on $\mathcal{A}^{\bullet}_{X\mathbb{C}}(\log D)$.

Proposition 2.70 (Proposition 8.4, [34]). The identity

$$\left(\mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), \tau_{\leq \cdot}\right) \to \left(\mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), \widetilde{W}_{\cdot}\right)$$

and the inclusion

 $(\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), \tau_{<}) \hookrightarrow (j_*\mathcal{A}^{\bullet}_{U,\mathbb{C}}, \tau_{<})$

are both filtered quasi-isomorphisms. Moreover, the second map coincides with the adjunction $Id \rightarrow Id$ Rj_*j^{-1} applied to $\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D)$ when seen as a morphism in the derived category.

Corollary 2.71. The following is a diagram of filtered quasi-isomorphisms (the last one is bi-filtered), where the maps are either the identity or the natural inclusions.

$$\left(\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), \widetilde{W}_{\bullet} \right) \xleftarrow{\operatorname{Id}} \left(\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), \tau_{\leq \bullet} \right) \hookrightarrow \left(j_* \mathcal{E}^{\bullet}_{U,\mathbb{C}}, \tau_{\leq \bullet} \right) \xleftarrow{} \left(\Omega^{\bullet}_X(\log D), \tau_{\leq \bullet} \right) \xrightarrow{\operatorname{Id}} \left(\Omega^{\bullet}_X(\log D), W_{\bullet}, F^{\bullet} \right) \xleftarrow{} \left(\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), \widetilde{W}_{\bullet}, F^{\bullet} \right) \xrightarrow{} \left(\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), \widetilde{W}_{\bullet} \right) \xrightarrow{} \left(\mathcal{A}^{$$

The composition of all of these maps is the identity in the derived category.

Proof. The (de Rham) resolution $\underline{\mathbb{R}}_U \to \mathcal{E}_{U,\mathbb{R}}^{\bullet}$ factors through $\mathcal{A}_{U,\mathbb{R}}^{\bullet}$, which is quasi-isomorphic (through the inclusion map) to the bigger sheaf complex $\mathcal{E}_{U,\mathbb{R}}^{\bullet}$, because both resolve the trivial local system $\underline{\mathbb{R}}_U$ (see [25, p. 127], for example). Since $\mathcal{E}_{U,\mathbb{R}}^{\bullet}$ is a complex of soft sheaves, this gives rise to an isomorphism $Rj_*\mathbb{R}_U \to j_*\mathcal{E}_{U\mathbb{R}}^{\bullet}$ in the derived category, and Proposition 2.70 shows that the second map in the chain of maps in the statement of this Corollary is a (trivially filtered) quasi-isomorphism. The rest of the maps involved are (bi-)filtered quasi-isomorphisms by Theorem 2.69 and Proposition 2.70.

The statement about the composition of all of those maps in the derived category follows from the fact that the inclusion $\Omega^{\bullet}_X(\log D) \to j_* \mathcal{E}^{\bullet}_{U,\mathbb{C}}$ factors through $\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D)$.

Note that the filtration \widetilde{W}_{i} on the logarithmic Dolbeault complex is not biregular, a hypothesis which is needed for Definition 2.64, for example. However, we may tweak it a little to get a mixed Hodge complex of sheaves similar to the one from Definition 2.68 with biregular filtrations as follows.

Definition-Proposition 2.72 (Modified mixed Hodge complex of sheaves of Navarro Aznar). Let U, X, D, j, (z_i) as in Definition 2.67, and let W, F and α as in Definition 2.68. Let $n \geq 1$ $\max\{2, \dim_{\mathbb{R}} U\}, \text{ and let } W^n$ be the increasing cdga filtration on $\mathcal{A}^{\bullet}_{X,\mathbb{R}}$ given by

$$W_i^n \mathcal{A}_{X,\mathbb{R}}^j \coloneqq \left\{ egin{array}{cc} \widetilde{W_i} \mathcal{A}_{X,\mathbb{R}}^ullet & if \ i \leq n, \ \mathcal{A}_{X,\mathbb{R}}^ullet & if \ i > n, \end{array}
ight.$$

and let $(\mathcal{A}^{j}_{X,\mathbb{C}}, W^{n}_{\cdot}) \coloneqq (\mathcal{A}^{j}_{X,\mathbb{R}} \otimes_{\mathbb{R}} \mathbb{C}, W^{n}_{\cdot} \otimes_{\mathbb{R}} \mathbb{C}).$ Then, the following data describes a mixed Hodge complex of sheaves $\mathcal{N}^{\bullet}_{X,D,n}$:

$$\mathcal{N}_{X,D,n}^{\bullet} \coloneqq \left((\mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), W_{\cdot}^{n}), (\mathcal{A}_{X,\mathbb{C}}^{\bullet}(\log D), W_{\cdot}^{n}, F^{\cdot}), \alpha \right),$$

in which all the filtrations are biregular, and such that the identity morphism

$$\widetilde{\mathcal{N}_{X,D}^{\bullet}} \to \mathcal{N}_{X,D,m}^{\bullet}$$

induces (bi-)filtered quasi-isomorphisms in its real and complex parts.

Proof. The identity morphism $\widetilde{\mathcal{N}_{X,D}^{\bullet}} \to \mathcal{N}_{X,D,n}^{\bullet}$ induces filtered morphisms in its real and complex parts. By Proposition 2.70, if $m > n \ge \dim_{\mathbb{R}} U$, $\operatorname{Gr}_{m}^{W} \mathcal{A}_{X,\mathbb{R}}^{\bullet}$ is quasi-isomorphic to 0, so it is exact. By induction, one can show that $\widetilde{W}_m \mathcal{A}_{X,\mathbb{R}}^{\bullet}/\widetilde{W}_n \mathcal{A}_{X,\mathbb{R}}^{\bullet}$ is an exact complex of sheaves for all m > n, which implies that $\mathcal{A}^{\bullet}_{X,\mathbb{R}}/\widetilde{W}_n\mathcal{A}^{\bullet}_{X,\mathbb{R}}$ is an exact complex of sheaves, that is, quasi-isomorphic to 0. This shows that the identity morphism induces quasi-isomorphisms between $\operatorname{Gr}_m^{\widetilde{W}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}$ and $\operatorname{Gr}_m^{W^n} \mathcal{A}_{X,\mathbb{R}}^{\bullet}$ for all m. These quasi-isomorphisms are the identity if $m \leq n$. The same holds for $\mathcal{A}_{X,\mathbb{C}}^{\bullet}$, which concludes our proof.

Remark 2.73. The isomorphism $Rj_*\underline{\mathbb{R}}_U \to j_*\mathcal{E}_{U,\mathbb{R}}^{\bullet}$ described in the proof of Corollary 2.71 is the one used to endow $H^*(U,\mathbb{R})$ with Deligne's canonical mixed Hodge structure, using Deligne's mixed Hodge complex of sheaves described at the beginning of this section.

The mixed Hodge complex of Navarro Aznar (Definition 2.68) also induces a mixed Hodge structure on $H^*(U,\mathbb{R})$ via the composition of $Rj_*\mathbb{R}_U \to j_*\mathcal{E}_{U,\mathbb{R}}^{\bullet}$ above with $\mathcal{A}_{X,\mathbb{C}}^{\bullet}(\log D) \hookrightarrow j_*\mathcal{E}_{U,\mathbb{C}}^{\bullet}$. By Corollary 2.71, both of these mixed Hodge structures on $H^*(U,\mathbb{R})$ coincide. Consequently, this MHS coincides with the one induced by the modified complex $\mathcal{N}_{X,D,n}^{\bullet}$ from Definition-Proposition 2.72 for all $n \ge \max\{2, \dim_{\mathbb{R}} U\}$.

3. THICKENING OF A MIXED HODGE COMPLEX OF SHEAVES

Let $k = \mathbb{Q}$ or \mathbb{R} . We will show how to construct a thickened mixed Hodge complex of sheaves for any multiplicative mixed Hodge complex of sheaves \mathcal{K}^{\bullet} .

3.1. The definition of the thickening. The data required for the thickening should be understood as a MHS V and a morphism $V[-1] \to \mathcal{K}^{\bullet}$. Precisely, we require the following data.

Assumption 3.1. We consider the following objects.

(1) A multiplicative mixed Hodge complex $\mathcal{K}^{\bullet} = ((\mathcal{K}^{\bullet}_k, W_{\bullet}), (\mathcal{K}^{\bullet}_{\mathbb{C}}, W_{\bullet}, F^{\bullet}), \alpha)$ on a topological space X. α is a filtered pseudo-morphism, which induces the filtered pseudo-isomorphism $\alpha \otimes 1$ after tensoring by \mathbb{C} over k:

$$(\mathcal{K}^{\bullet}_{k} \otimes_{k} \mathbb{C}, W_{\bullet}) = (\mathcal{K}^{\bullet}_{0}, W_{\bullet}) \xrightarrow{\alpha_{1}} (\mathcal{K}^{\bullet}_{1}, W_{\bullet}) \xleftarrow{\alpha_{2}}{\cdots} \xrightarrow{\alpha_{2M-1}} (\mathcal{K}^{\bullet}_{2M-1}, W_{\bullet}) \xleftarrow{\alpha_{2M}} (\mathcal{K}^{\bullet}_{2M}, W_{\bullet}) = (\mathcal{K}^{\bullet}_{\mathbb{C}}, W_{\bullet}).$$

In addition, all the weight filtrations W_i are biregular (i.e. for all m and for all $0 \le i \le 2M$, the weight filtration induced on \mathcal{K}_i^m are finite), and all the complexes of sheaves are bounded.

- (2) A k-MHS (V, W, F). $V_{\mathbb{C}}$ will denote the vector space $V \otimes_k \mathbb{C}$.
- (3) For every $i = 0, \ldots, M$, a morphism

$$\Phi_{2i} \colon (V_{\mathbb{C}}, W_{\bullet}[1]) \to \Gamma\left(X, (\mathcal{K}_{2i}^{1, \mathrm{cl}}, W_{\bullet})\right)$$

Where $\mathcal{K}^{1,\mathrm{cl}} = \ker d \subseteq \mathcal{K}^1$. Additionally, Φ_{2M} is required to preserve F^{\bullet} and Φ_0 must be defined over k.

(4) For every $i = 1, \ldots, M$, a morphism

$$\Psi_{2i-1} \colon (V_{\mathbb{C}}, W_{\cdot}[1]) \to \Gamma\left(X, (\mathcal{K}_{2i-1}^0, W_{\cdot})\right)$$

such that

$$d \circ \Psi_{2i-1} = \alpha_{2i-1} \circ \Phi_{2i-2} - \alpha_{2i} \circ \Phi_{2i}.$$

In other words, the maps Φ_{2i} are only required to be compatible with α up to homotopy, and the homotopies are part of the data.

Our thickening, when seen as a deformation, will be parametrized by the formal neighborhood of the origin in V, i.e. if V^{\vee} is the dual vector space, the base ring will be the completion of Sym[•] V^{\vee} at its maximal ideal. Concretely, the base ring will be the following: Let V^{\vee} be the dual MHS. For the rest of this section, and for all $0 \leq m$, let us generalize Definition 2.20 (which assumes $V = H^1(G, k)$):

$$R_{\infty} \coloneqq \prod_{j=0}^{\infty} \operatorname{Sym}^{j} V^{\vee}; \quad R_{m} \coloneqq \frac{R_{\infty}}{\prod_{j=m}^{\infty} \operatorname{Sym}^{j} V^{\vee}} \cong \bigoplus_{j=0}^{m-1} \operatorname{Sym}^{j} V^{\vee}$$

We reuse the notation from Definition 2.20 because we will only construct explicit thickened complexes when $V = H^1(G, k)$, but the theory will be carried out with more generality in this section.

 R_{∞} is a ring, whose multiplication is the usual multiplication in the symmetric tensor algebra, and $\prod_{i=m}^{\infty} \operatorname{Sym}^{j} V^{\vee}$ is an ideal for every $m \geq 1$. In fact, if we let

$$\mathfrak{a} \coloneqq \prod_{j=1}^{\infty} \operatorname{Sym}^{j} V^{\vee},$$

then the ideal $\prod_{j=m}^{\infty} \operatorname{Sym}^{j} V^{\vee}$ equals \mathfrak{a}^{m} for all $m \geq 1$. Given a basis s_{1}, \ldots, s_{r} of V^{\vee} , we obtain an isomorphism $R_{\infty} \cong k[[s_{1}, \ldots, s_{r}]]$, and $R_{m} \cong k[[s_{1}, \ldots, s_{r}]]/(s_{1}, \ldots, s_{r})^{m}$.

In order to work in both homology and cohomology, we will consider the k-dual of a deformed complex. This will require us to work over the k-dual modules of R_m . Let us from now on use m to denote a nonnegative integer, and let:

$$R_{-m} \coloneqq \operatorname{Hom}_k(R_m, k).$$

The R_{∞} -module structure of R_m induces a module structure on R_{-m} . We will abuse notation and denote by R_{∞} , R_m and R_{-m} the same constructions but using $V_{\mathbb{C}}$ instead of V and \mathbb{C} instead of k. This abuse of notation will be clarified as follows: The expression $R_{\infty} \otimes_k -$ will assume that R_{∞} is constructed using V, whereas $R_{\infty} \otimes_{\mathbb{C}} -$ will assume that R_{∞} is constructed using $V_{\mathbb{C}}$.

For $m \ge 0$, R_m has a MHS, namely the direct sum of the MHS's on $\operatorname{Sym}^j V^{\vee}$. Furthermore, R_{-m} has the dual MHS. In fact, using Definition-Proposition 2.52, one can see that the multiplication morphisms

(3.2)
$$V^{\vee} \otimes_k R_m \to R_m, \text{ and } V^{\vee} \otimes_k R_{-m} \to R_{-m}$$

are MHS morphisms.

Definition 3.3. Let V as in Assumption 3.1. We denote by ε_k the canonical element of $V^{\vee} \otimes_k V$, namely

$$\varepsilon_k = \sum_{i=1}^r s_i \otimes s_i^{\vee},$$

where $\{s_1, \ldots, s_r\}$ is a basis of V^{\vee} and $\{s_1^{\vee}, \ldots, s_r^{\vee}\}$ is its dual basis. Similarly, $\varepsilon_{\mathbb{C}}$ will denote the canonical element of $(V_{\mathbb{C}})^{\vee} \otimes_{\mathbb{C}} V_{\mathbb{C}}$.

Definition 3.4. Consider the setup in Assumption 3.1.

• We will denote by $\Phi_{2i}(\varepsilon_{\mathbb{C}}) \in \Gamma(X, R_{\infty} \otimes_{\mathbb{C}} \mathcal{K}^{1}_{2i})$ the image of $\varepsilon_{\mathbb{C}}$ by $\mathrm{Id}_{V_{\mathbb{C}}^{\vee}} \otimes_{\mathbb{C}} \Phi_{2i}$ for all $i = 0, \ldots, M$.

Similarly,

- If i = 0, we will denote by $\Phi_0(\varepsilon_k) := \operatorname{Id}_{V^{\vee}} \otimes_k \Phi_0(\varepsilon_k) \in \Gamma(X, R_{\infty} \otimes_k \mathcal{K}^1_k)$ (recall that Φ_0 is defined over k).
- $\Psi_{2i-1}(\varepsilon_{\mathbb{C}}) \coloneqq \operatorname{Id}_{V_{\mathbb{C}}^{\vee}} \otimes_{\mathbb{C}} \Psi_{2i-1}(\varepsilon_{\mathbb{C}}) \in \Gamma(X, R_{\infty} \otimes_{\mathbb{C}} \mathcal{K}_{2i-1}^{0}) \text{ for all } i = 1, \ldots, M.$
- $\alpha_{2i-1}\Phi_{2i-2}(\varepsilon_{\mathbb{C}}) \stackrel{\sim}{\coloneqq} \operatorname{Id}_{V^{\vee}} \otimes_k \alpha_{2i-1} \circ \Phi_{2i-2}(\varepsilon_k) \in \Gamma(X, R_{\infty} \otimes_{\mathbb{C}} \mathcal{K}^1_{2i-1}) \text{ for all } i = 1, \dots, M.$
- $\alpha_{2i}\Phi_{2i}(\varepsilon_{\mathbb{C}}) := \mathrm{Id}_{V^{\vee}} \otimes_k \alpha_{2i} \circ \Phi_{2i}(\varepsilon_k) \in \Gamma(X, R_{\infty} \otimes_{\mathbb{C}} \mathcal{K}^1_{2i-1}) \text{ for all } i = 1, \ldots, M.$

Remark 3.5. Let $m \ge 1$. Left multiplication by $\Phi_{2i}(\varepsilon_{\mathbb{C}})$ defines an element of

$$\operatorname{Hom}_{R_m}^1(R_{\pm m} \otimes_{\mathbb{C}} \mathcal{K}_{2i}^{\bullet}, \mathfrak{a} R_{\pm m} \otimes_{\mathbb{C}} \mathcal{K}_{2i}^{\bullet})$$

for all $i = 0, \ldots, M$. Here R_{-m} is seen as an R_m -module, and R_m is a local Artinian \mathbb{C} -algebra with maximal ideal \mathfrak{a} (where we are abusing notation and denoting by \mathfrak{a} the image of the ideal \mathfrak{a} of R_{∞} through the ring epimorphism $R_{\infty} \twoheadrightarrow R_m$). Similarly, left multiplication by the rest of the elements from Definition 3.4 defines an element of

$$\operatorname{Hom}_{R_m}^1(R_{\pm m}\otimes_{\mathbb{C}}\mathcal{K}_j^{\bullet},\mathfrak{a}R_{\pm m}\otimes_{\mathbb{C}}\mathcal{K}_j^{\bullet})$$

for the appropriate j, except for $\Psi_{2i-1}(\varepsilon_{\mathbb{C}})$, which defines an element of

$$\operatorname{Hom}_{R_m}^0(R_{\pm m}\otimes_{\mathbb{C}}\mathcal{K}_{2i-1}^{\bullet},\mathfrak{a}R_{\pm m}\otimes_{\mathbb{C}}\mathcal{K}_{2i-1}^{\bullet})$$

for all i = 1, ..., M. In particular, since \mathfrak{a} is a nilpotent ideal in R_m ,

$$e^{\Psi_{2i-1}(\varepsilon_{\mathbb{C}})} \coloneqq \sum_{j=0}^{\infty} \frac{1}{j!} (\Psi_{2i-1}(\varepsilon_{\mathbb{C}}))^j = \sum_{j=0}^{m-1} \frac{1}{j!} (\Psi_{2i-1}(\varepsilon_{\mathbb{C}}))^j \in \operatorname{Hom}_{R_m}^0(R_{\pm m} \otimes_{\mathbb{C}} \mathcal{K}_{2i-1}^{\bullet}, R_{\pm m} \otimes_{\mathbb{C}} \mathcal{K}_{2i-1}^{\bullet})$$

is a globally (and well) defined endomorphism for all i = 1, ..., M.

Lemma 3.6. Let $\mathcal{K}^{\bullet} = ((\mathcal{K}^{\bullet}_k, W_{\bullet}), (\mathcal{K}^{\bullet}_{\mathbb{C}}, W_{\bullet}, F^{\bullet}), \alpha)$ be a mixed Hodge complex of sheaves on a topological space X, and let H be a k-MHS. Then

$$H \otimes \mathcal{K}^{\bullet} \coloneqq ((H \otimes_k \mathcal{K}_k^{\bullet}, W_{\bullet}), (H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}_{\mathbb{C}}^{\bullet}, W_{\bullet}, F^{\bullet}), \mathrm{Id}_H \otimes \alpha),$$

with the natural (tensor) filtrations from Definition-Proposition 2.52, differential, pseudo-morphism and k-structure, is also a mixed Hodge complex of sheaves.

Proof. Let us start by noting that, since the complex of sheaves \mathcal{K}_k^{\bullet} is a complex of sheaves of k-vector spaces, the identity induces an isomorphism for all j:

(3.7)
$$\operatorname{Gr}_{j}^{W}(H \otimes_{k} \mathcal{K}_{k}^{\bullet}) \cong \bigoplus_{a+b=j} \operatorname{Gr}_{a}^{W} H \otimes_{k} \operatorname{Gr}_{b}^{W} \mathcal{K}_{k}^{\bullet},$$

and similarly for $H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}_i^{\bullet}$ for every complex of sheaves of \mathbb{C} -vector spaces \mathcal{K}_i^{\bullet} appearing in the pseudo-isomorphism $\alpha \otimes 1$.

In order for $H \otimes \mathcal{K}^{\bullet}$ to be a mixed Hodge complex of sheaves, it must satisfy the following requirements. We will begin with the more straightforward properties.

- The vector spaces $\mathbb{H}^*(X, H \otimes_k \mathcal{K}^{\bullet})$ are finite-dimensional: this follows from the fact that k is a field and therefore H is flat, so these are isomorphic to $H \otimes_k \mathbb{H}^*(X, \mathcal{K}^{\bullet})$.
- The differentials preserve the weight and Hodge filtrations: this is a direct consequence of the definition of the differential on the tensor product as $\mathrm{Id}_H \otimes d$, where d denotes the differential in \mathcal{K}^{\bullet} .
- The maps $\operatorname{Id}_H \otimes \alpha$ form a pseudo-morphism which becomes a filtered pseudoisomorphism after tensoring by \mathbb{C} over k: this also follows also from the flatness of $H_{\mathbb{C}}$ over \mathbb{C} and its graded pieces, together with the direct sum decomposition (3.7).

Finally, we must show that the associated graded for the weight filtration is a pure Hodge complex of sheaves, as defined in [37, Definition 2.32]. Applying the decomposition (3.7), it suffices to show this for any summand of the form $\operatorname{Gr}_a^W H \otimes \operatorname{Gr}_b^W \mathcal{K}^{\bullet}$. In other words, the problem is reduced to the case where H is a pure Hodge structure of weight a and \mathcal{K}^{\bullet} is a pure Hodge complex of weight b, and we need to show that $H \otimes \mathcal{K}^{\bullet}$ is a pure Hodge complex of weight a + b. This amounts to showing the following properties:

- The vector spaces $\mathbb{H}^*(X, H_k \otimes_k \mathcal{K}^{\bullet})$ are finite-dimensional: this is the same as above.
- The maps $\operatorname{Id}_H \otimes \alpha$ form a pseudo-morphism which becomes a pseudo-isomorphism after tensoring by \mathbb{C} over k: this is the same as above.
- The filtration induced by F endows $\mathbb{H}^{j}(X, H_{k} \otimes_{k} \mathcal{K}_{k}^{\bullet})$ with a Hodge structure of weight a + b + j: $F^{p}\mathbb{H}^{j}(X, H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}_{\mathbb{C}}^{\bullet})$ is, by definition, the image of the morphism induced by the inclusion of sheaves

$$\mathbb{H}^{j}(X, F^{p}(H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}})) \to \mathbb{H}^{j}(X, H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}}),$$

Let us use the Hodge decomposition of H, namely $F^{p_1}H_{\mathbb{C}} = \bigoplus_{i > p_1} (H_{\mathbb{C}})^{i,a-i}$, to get

$$F^{p}(H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}}) = \sum_{p_{1}+p_{2}=p} F^{p_{1}}H_{\mathbb{C}} \otimes_{\mathbb{C}} F^{p_{2}}\mathcal{K}^{\bullet}_{\mathbb{C}} = \bigoplus_{p_{1}+p_{2}=p} (H_{\mathbb{C}})^{p_{1},a-p_{1}} \otimes_{\mathbb{C}} F^{p_{2}}\mathcal{K}^{\bullet}_{\mathbb{C}}.$$

Therefore, $F^p \mathbb{H}^j(X, H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}})$ is the direct sum for all p_1, p_2 such that $p_1 + p_2 = p$ of all the images of the morphisms

$$\mathbb{H}^{j}\left(X,(H_{\mathbb{C}})^{p_{1},a-p_{1}}\otimes_{\mathbb{C}}F^{p_{2}}\mathcal{K}_{\mathbb{C}}^{\bullet}\right)\to\mathbb{H}^{j}(X,H_{\mathbb{C}}\otimes_{\mathbb{C}}\mathcal{K}_{\mathbb{C}}^{\bullet}),$$

that is, the direct sum of the images of

$$(H_{\mathbb{C}})^{p_1, a-p_1} \otimes_{\mathbb{C}} \mathbb{H}^j(X, F^{p_2} \mathcal{K}^{\bullet}_{\mathbb{C}}) \to H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathbb{H}^j(X, \mathcal{K}^{\bullet}_{\mathbb{C}}),$$

which coincide with $(H_{\mathbb{C}})^{p_1,a-p_1} \otimes_{\mathbb{C}} F^{p_2} \mathbb{H}^j(X, \mathcal{K}^{\bullet}_{\mathbb{C}})$ for all $p_1 + p_2 = p$. Therefore,

$$F^{p}\mathbb{H}^{j}(X, H_{\mathbb{C}}\otimes_{\mathbb{C}}\mathcal{K}^{\bullet}_{\mathbb{C}}) = \bigoplus_{p_{1}+p_{2}=p} (H_{\mathbb{C}})^{p_{1}, a-p_{1}} \otimes_{\mathbb{C}} F^{p_{2}}\mathbb{H}^{j}(X, \mathcal{K}^{\bullet}_{\mathbb{C}}) = \sum_{p_{1}+p_{2}=p} F^{p_{1}}H_{\mathbb{C}}\otimes F^{p_{2}}\mathbb{H}^{j}(X, \mathcal{K}^{\bullet}_{\mathbb{C}}).$$

That is, the filtration F^{\bullet} on $\mathbb{H}^{j}(X, H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}})$ is the tensor filtration on $H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathbb{H}^{j}(X, \mathcal{K}^{\bullet}_{\mathbb{C}})$. The rest follows from the fact that $H_{\mathbb{C}}$ is a Hodge structure of weight a and, since $\mathcal{K}^{\bullet}_{\mathbb{C}}$ is a Hodge complex of sheaves, $\mathbb{H}^{j}(X, \mathcal{K}_{\mathbb{C}}^{\bullet})$ is a Hodge structure of weight b + j.

• The spectral sequence $\mathbb{H}^{p+q}(X, \operatorname{Gr}^p_F(H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}})) \Rightarrow \mathbb{H}^{p+q}(X, H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}})$ degenerates at E_1 : Again, we use the Hodge decomposition of H to decompose $H_{\mathbb{C}} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}}$ into a direct sum of complexes of the form $(H_{\mathbb{C}})^{p,a-p} \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}}$. Since $\mathcal{K}^{\bullet}_{\mathbb{C}}$ is a Hodge complex of sheaves, the spectral sequence for the direct summands converges at E_1 , since it only differs from the one for $\mathcal{K}^{\bullet}_{\mathbb{C}}$ by a tensor with a vector space and a shift in the filtration.

Definition-Proposition 3.8. Consider the objects in Assumption 3.1, and let $\Phi \coloneqq (\Phi_0, \ldots, \Phi_{2M})$ and $\Psi \coloneqq (\Psi_1, \ldots, \Psi_{2M-1})$. Let $\varepsilon_{\mathbb{C}}$ and ε_k as in Definition 3.3. Let $m \in \mathbb{Z}$ where $m \neq 0$, and let (R_m, W, F) be the MHS on R_m as in this section.

Then,

$$\mathcal{K}^{\bullet}(m, V, \mathbf{\Phi}, \mathbf{\Psi}) \coloneqq \left(\left(\left(R_m \otimes_k \mathcal{K}_k^{\bullet}, d + \Phi_0(\varepsilon_k) \right), W_{\bullet} \right), \left(\left(R_m \otimes_{\mathbb{C}} \mathcal{K}_{\mathbb{C}}^{\bullet}, d + \Phi_{2M}(\varepsilon_{\mathbb{C}}) \right), W_{\bullet}, F^{\bullet} \right), \widetilde{\alpha} \right)$$

is a multiplicative k-mixed Hodge complex of sheaves on X, where

- The filtrations W_{\bullet} , F^{\bullet} of $R_m \otimes_k \mathcal{K}^{\bullet}_k$ and/or $R_m \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_j$ for all $j = 0, \ldots, 2M$ that appear are the tensor filtrations defined as in Definition-Proposition 2.52 from (R_m, W, F) and the filtrations in \mathcal{K}^{\bullet} .
- everywhere, we write d + a to denote the sum of the differential $\mathrm{Id}_{R_m} \otimes d$, where d is the differential in \mathcal{K}^{\bullet} , and left multiplication by a.
- $\tilde{\alpha}$ is the filtered pseudo-isomorphism given by

(3.

$$((R_m \otimes_{\mathbb{C}} \mathcal{K}_0^{\bullet}, d + \Phi_0(\varepsilon_{\mathbb{C}})), W_{\bullet}) \qquad \qquad ((R_m \otimes_{\mathbb{C}} \mathcal{K}_2^{\bullet}, d + \Phi_2(\varepsilon_{\mathbb{C}})), W_{\bullet}) \xrightarrow{\operatorname{Id} \otimes \alpha_3} \cdots \\ \downarrow_{\operatorname{Id} \otimes \alpha_1} \qquad \qquad \downarrow_{\operatorname{Id} \otimes \alpha_2} \\ ((R_m \otimes_{\mathbb{C}} \mathcal{K}_1^{\bullet}, d + \alpha_1 \Phi_0(\varepsilon)), W_{\bullet}) \xrightarrow{e^{\Psi_1(\varepsilon_{\mathbb{C}})}} \cdots ((R_m \otimes_{\mathbb{C}} \mathcal{K}_1^{\bullet}, d + \alpha_2 \Phi_2(\varepsilon_{\mathbb{C}})), W_{\bullet})$$

Proof. First note that all of the complexes of sheaves involved in this definition are indeed complexes of sheaves by Lemma 2.50, and they are bounded because the complexes in \mathcal{K}^{\bullet} are. All the W filtrations that appear in the complexes appearing in $\mathcal{K}^{\bullet}(m, V, \Phi, \Psi)$ are increasing, as they are tensor filtrations of increasing filtrations. Similarly, the F^{\bullet} filtration of $(R_m \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}_{\mathbb{C}}, d + \Phi_{2M}(\varepsilon_{\mathbb{C}}))$ is a decreasing filtration.

We have to verify the following claims:

• The vector spaces $\mathbb{H}^*(X, (R_m \otimes_k \mathcal{K}_k^{\bullet}, d + \Phi_0(\varepsilon_k)))$ are finite-dimensional. If m = 1, these hypercohomology groups coincide with $\mathbb{H}^*(X, \mathcal{K}^{\flat}_k)$, which are finite dimensional by the hypothesis that \mathcal{K}^{\bullet} is a mixed Hodge complex of sheaves. For m > 1, we have a short exact sequence

10)
$$0 \to \operatorname{Sym}^{m-1} V^{\vee} \to R_m \to R_{m-1} \to 0$$

which induces a short exact sequence of complexes of sheaves

$$0 \to (\operatorname{Sym}^{m-1} V^{\vee} \otimes_k \mathcal{K}_k^{\bullet}, d) \to (R_m \otimes_k \mathcal{K}_k^{\bullet}, d + \Phi(\varepsilon_k)) \to (R_{m-1} \otimes_k \mathcal{K}_k^{\bullet}, d + \Phi(\varepsilon_k)) \to 0$$

We have that $\mathbb{H}^*(X, \operatorname{Sym}^{m-1} V^{\vee} \otimes_k \mathcal{K}^{\bullet}_k) \cong \operatorname{Sym}^{m-1} V^{\vee} \otimes \mathbb{H}^*(X, \mathcal{K}^{\bullet}_k)$, so they are finite dimensional vector spaces. The short exact sequence of complexes of sheaves induces a long exact sequence in cohomology groups, so the result for all m > 1 follows by induction from these long exact sequences.

For m < 0 the result follows by dualizing (3.10) over k and following the same inductive argument.

• The differentials preserve the weight and Hodge filtrations, that is, the weight and Hodge filtrations are filtrations by subcomplexes of sheaves. We start by showing that $\varepsilon_{\mathbb{C}} \in$ $(W_0 \cap F^0)(V_{\mathbb{C}}^{\vee} \otimes_{\mathbb{C}} V_{\mathbb{C}})$. Recall how the filtrations are defined on duals and tensor products in Definition-Proposition 2.52. If $s_i^{\vee} \in W_m V \setminus W_{m-1} V$ (resp. $s_i^{\vee} \in F^p V_{\mathbb{C}} \setminus F_{p+1} V_{\mathbb{C}}$), then s_i (seen as a morphism from V to k) takes $W_{m-1}V$ (resp. $F_{p+1}V_{\mathbb{C}}$) to 0, so $s_i \in W_{-m}V^{\vee}$ (resp.

 $s_i \in F^{-p}V_{\mathbb{C}}^{\vee}$). In particular, $s_i \otimes s_i^{\vee} \in W_0(V^{\vee} \otimes_k V)$ (resp. $s_i \otimes s_i^{\vee} \in F^0(V_{\mathbb{C}}^{\vee} \otimes_{\mathbb{C}} V_{\mathbb{C}})$), so $\varepsilon_{\mathbb{C}} \in (W_0 \cap F^0)(V_{\mathbb{C}}^{\vee} \otimes_{\mathbb{C}} V_{\mathbb{C}})$.

Now, recall that $\Phi_{2i}(\varepsilon_{\mathbb{C}}) := (\mathrm{Id} \otimes \Phi_{2i})(\varepsilon_{\mathbb{C}})$ for all $i = 0, \ldots, M$. By Assumption 3.1, Φ_{2i} decreases the weight by 1, so

$$\Phi_{2i}(\varepsilon_{\mathbb{C}}) \in \Gamma\left(X, W_{-1}\left(V_{\mathbb{C}}^{\vee} \otimes_{\mathbb{C}} \mathcal{K}_{2i}^{1}\right)\right).$$

Since \mathcal{K}^{\bullet} is a mixed Hodge complex of sheaves, d preserves the weight. Since \mathcal{K}^{\bullet} is a multiplicative mixed Hodge complex of sheaves and the fact that the multiplication morphisms in (3.2) are MHS morphisms, multiplication by $\Phi_{2i}(\varepsilon_{\mathbb{C}})$ decreases the weight by 1. Hence, applying $d + \Phi_{2i}(\varepsilon_{\mathbb{C}})$ preserves the weight, since d does. Since α_{2i} also preserves the weight for all i, multiplication by $\alpha_{2i-1}\Phi_{2i-2}(\varepsilon_{\mathbb{C}})$ and $\alpha_{2i}\Phi_{2i}(\varepsilon_{\mathbb{C}})$ decreases the weight by 1, so applying $d + \alpha_{2i-1}\Phi_{2i-2}(\varepsilon_{\mathbb{C}})$ or $d + \alpha_{2i}\Phi_{2i}(\varepsilon_{\mathbb{C}})$ preserves the weight. Similarly, multiplication by $\Phi_{2M}(\varepsilon_{\mathbb{C}})$ and the differential $d + \Phi_{2M}(\varepsilon_{\mathbb{C}})$ both preserve the Hodge filtration.

• The associated graded for the weight filtration is a Hodge complex of sheaves. First, note that, by a similar argument as above, $\Psi_{2i-1}(\varepsilon_{\mathbb{C}})$ decreases the weight by 1, since Ψ_{2i-1} also does that. Since $\Phi_{2i}(\varepsilon_{\mathbb{C}})$ also decreases the weight by 1 for all $i = 0, \ldots, M$, applying $\operatorname{Gr}_{W}^{W}$ to (3.9) yields:

Hence, $\operatorname{Gr}_{j}^{W}$ applied to (3.9) yields (up to some extra identity maps between the sheaf complexes) the same diagram as $\operatorname{Gr}_{j}^{W}$ applied to $R_m \otimes \mathcal{K}^{\bullet}$ (without twisting the differential). The rest follows from Lemma 3.6

 The maps α̃ form a filtered pseudo-morphism, which becomes a filtered pseudoisomorphism after tensoring with C over k: First, the maps Id ⊗α_i are clearly morphisms of complexes (they preserve the differential). By Remark 2.51, e^{Ψ_{2i+1}(ε)} is an isomorphism of complexes. When passing to Gr.^W, we obtain (3.11), which we already showed is a pseudoisomorphism. Since the filtrations W_i are biregular, the result now follows by increasing induction and the five lemma.

3.2. Properties of the thickening.

Proposition 3.12. Suppose we have $(\mathcal{K}^{\bullet}, V, \Phi, \Psi)$ as in Assumption 3.1. Via the embedding $V^{\vee} \subset \mathbb{R}_{\infty}$, multiplication induces a morphism of mixed Hodge complexes of sheaves for every $m \in \mathbb{Z} \setminus \{0\}$:

$$V^{\vee} \otimes \mathcal{K}^{\bullet}(m, V, \Phi, \Psi) \to \mathcal{K}^{\bullet}(m, V, \Phi, \Psi),$$

where

$$V^{\vee} \otimes \mathcal{K}^{\bullet}(m, V, \Phi, \Psi) \coloneqq \\ \left(\left(\left(V^{\vee} \otimes_{k} \otimes R_{m} \otimes_{k} \mathcal{K}_{k}^{\bullet}, d + \Phi_{0}(\varepsilon_{k}) \right), W_{\bullet} \right), \left(\left(V_{\mathbb{C}}^{\vee} \otimes_{\mathbb{C}} \otimes R_{m} \otimes_{\mathbb{C}} \mathcal{K}_{\mathbb{C}}^{\bullet}, d + \Phi_{2M}(\varepsilon_{\mathbb{C}}) \right), W_{\bullet} \right), \operatorname{Id}_{V^{\vee}} \otimes \widetilde{\alpha} \right),$$

and the filtrations are tensor filtrations of V^{\vee} and $\mathcal{K}^{\bullet}(m, V, \Phi, \Psi)$ as in Definition-Proposition 2.52.

Proof. Note that V^{\vee} and $\mathcal{K}^{\bullet}(m, V, \Phi, \Psi)$ is a mixed Hodge complex of sheaves by Lemma 3.6. By (3.2), multiplication induces a mixed Hodge structure morphism $V^{\vee} \otimes R_m \to R_m$, so the multiplication morphism $V^{\vee} \otimes \mathcal{K}^{\bullet}(m, V, \Phi, \Psi) \to \mathcal{K}^{\bullet}(m, V, \Phi, \Psi)$ preserves the filtrations. To see that it is a morphism of mixed Hodge complexes of sheaves, we also need to see that it commutes with the pseudo-morphisms of both mixed Hodge complexes of sheaves. That is, it suffices to see that it commutes with $\mathrm{Id} \otimes \alpha_i$, which is clear since it acts on the other factor, and with $e^{\Psi_{2i-1}(\varepsilon)}$, which follows from the commutativity of R_{∞} .

Proposition 3.13. Suppose we have $(\mathcal{K}^{\bullet}, V, \Phi, \Psi)$ as in Assumption 3.1. Let $m', m \in \mathbb{Z}$ with m' > m > 0. The projection morphism $R_{m'} \twoheadrightarrow R_m$ induces a morphism of mixed Hodge complexes of sheaves:

$$\mathcal{K}^{\bullet}(m', V, \Phi, \Psi) \to \mathcal{K}^{\bullet}(m, V, \Phi, \Psi).$$

and the dual $R_{-m} \hookrightarrow R_{-m'}$ of the projection morphism induces a morphism of mixed Hodge complexes of sheaves:

$$\mathcal{K}^{\bullet}(-m, V, \Phi, \Psi) \to \mathcal{K}^{\bullet}(-m', V, \Phi, \Psi).$$

Proof. The proof follows the same steps as the proof of Proposition 3.12, this time using that the projection $R_{m'} \rightarrow R_m$ is a MHS morphism, so we omit it.

Proposition 3.14. Suppose we have two pieces of data as in Assumption 3.1 with a morphism connecting them:

$$(\mathcal{K}^{\bullet}, V, \Phi, \Psi) \longrightarrow (\mathcal{K}^{\bullet}, \widetilde{V}, \widetilde{\Phi}, \widetilde{\Psi}),$$

in other words, there is a MHS morphism $\mu: V \to \widetilde{V}$, such that the maps Φ 's and Ψ 's commute with these. Then, the morphisms between complexes of sheaves induced by μ and the identity in \mathcal{K}^{\bullet}

$$\mathcal{K}^{\bullet}(m, \tilde{V}, \Phi, \Psi) \to \mathcal{K}^{\bullet}(m, V, \Phi, \Psi), \quad \mathcal{K}^{\bullet}(-m, V, \Phi, \Psi) \to \mathcal{K}^{\bullet}(-m, \tilde{V}, \Phi, \Psi).$$

are morphisms of mixed Hodge complexes of sheaves for all $m \in \mathbb{Z}_{\geq 1}$

Proof. Let R_m and \widetilde{R}_m be constructed as in this section for the spaces V and \widetilde{V} , respectively. The morphism $\mu: V \to \widetilde{V}$ induces MHS morphisms $\mu^{\vee}: \widetilde{V}^{\vee} \to V^{\vee}$ and $(\mu^{\vee})^{\otimes j}: \operatorname{Sym}^j \widetilde{V}^{\vee} \to \operatorname{Sym}^j V^{\vee}$. Together they define a ring morphism $\mu_{\infty}^{\vee}: \widetilde{R}_{\infty} \to R_{\infty}, \widetilde{R}_{\infty}$ -module morphisms $\mu_m^{\vee}: \widetilde{R}_m \to R_m$ and their duals $\mu_m: R_{-m} \to \widetilde{R}_m$ for all $m \ge 1$. The maps μ_m^{\vee} and μ_m are MHS morphisms for all $m \ge 1$.

Tensoring with the identity morphism of \mathcal{K}^{\bullet} , we obtain morphisms between the complexes, which automatically preserve all filtrations since μ_m^{\vee} do as well.

Let us show that these morphisms commute with the differentials (that is, they are morphisms of complexes of sheaves). We start by showing that $(\mu_m^{\vee} \otimes_{\mathbb{C}} \operatorname{Id}_{\mathcal{K}_i^{\bullet}}) \circ (d + \widetilde{\Phi}_i(\widetilde{\varepsilon}_{\mathbb{C}})) = (d + \Phi_i(\varepsilon_{\mathbb{C}})) \circ$ $(\mu_m^{\vee} \otimes_{\mathbb{C}} \operatorname{Id}_{\mathcal{K}_i^{\bullet}})$, where $\varepsilon_{\mathbb{C}}$ and $\widetilde{\varepsilon}_{\mathbb{C}}$ are constructed from V and \widetilde{V} as in Definition 3.3, and the subindex \mathbb{C} is changed for k if the degree i is 0 (in which case \mathcal{K}_0^{\bullet} is changed for \mathcal{K}_k^{\bullet}). Since d acts as the identity on the factor R_m , it is clear that it commutes with μ_m^{\vee} . Therefore, it suffices to show that $\Phi_i(\varepsilon_{\mathbb{C}}) \circ \mu_m^{\vee} = \mu_m^{\vee} \circ \widetilde{\Phi}_i(\widetilde{\varepsilon}_{\mathbb{C}}) \colon \widetilde{R}_m \otimes_{\mathbb{C}} \mathcal{K}^{\bullet} \to R_m \otimes_{\mathbb{C}} \mathcal{K}^{\bullet}$. Suppose we have a simple tensor $a \otimes c \in \widetilde{R}_m \otimes_{\mathbb{C}} \mathcal{K}_i^j$. Let $\{\widetilde{s}_r^{\vee}\}$ be a basis of \widetilde{V} , and let $\{\widetilde{s}_r\}$ be its dual basis. Then,

$$\mu_m^{\vee}(\widetilde{\Phi}_i(\varepsilon_{\mathbb{C}}) \cdot (a \otimes c)) = \mu_m^{\vee} \left(\sum_r \widetilde{s}_r a \otimes \widetilde{\Phi}_i(\widetilde{s}_r^{\vee}) \wedge c \right)$$
$$= \sum_r \mu_m^{\vee}(\widetilde{s}_r a) \otimes \widetilde{\Phi}_i(\widetilde{s}_r^{\vee}) \wedge c$$
$$= \sum_r \mu^{\vee}(\widetilde{s}_r) \mu_m^{\vee}(a) \otimes \widetilde{\Phi}_i(\widetilde{s}_r^{\vee}) \wedge c$$
$$= \left(\sum_r \mu^{\vee}(\widetilde{s}_r) \otimes \widetilde{\Phi}_i(\widetilde{s}_r^{\vee}) \right) \wedge (\mu_m^{\vee}(a) \otimes c).$$

Note that if $\{s_l^{\vee}\}$ (resp. $\{\tilde{s}_r^{\vee}\}$) is a basis of V (resp. V), then

$$\sum_{r} \mu^{\vee}(\widetilde{s}_{r}) \otimes \widetilde{\Phi}_{i}(\widetilde{s}_{r}^{\vee}) = \sum_{l} s_{l} \otimes \widetilde{\Phi}_{i}(\mu(s_{l}^{\vee}))$$

which equals $\sum_{l} s_l \otimes \Phi_i(s_l^{\vee})$ by hypothesis. Applying this to the previous string of equalities yields

$$\mu_m^{\vee}(\widetilde{\Phi}_i(\varepsilon_{\mathbb{C}}) \cdot (a \otimes c)) = \left(\sum_l s_l \otimes \Phi(s_l^{\vee})\right) \wedge (\mu_m^{\vee}(a) \otimes c)$$
$$= \Phi_i(\varepsilon_{\mathbb{C}}) \cdot (\mu_m^{\vee}(a) \otimes c).$$

This shows that $\mu_m^{\vee} \otimes_{\mathbb{C}} \operatorname{Id}_{\mathcal{K}_i^{\bullet}}$ commutes with the differentials of the form $d + \Phi_i(\varepsilon_{\mathbb{C}})$ and $d + \widetilde{\Phi}_i(\widetilde{\varepsilon}_{\mathbb{C}})$. The proof follows the same steps for the other differentials appearing in the corresponding thickened mixed Hodge complexes of sheaves, namely those of the form $d + \alpha_j \Phi_i(\varepsilon_{\mathbb{C}})$. Hence, $\mu_m^{\vee} \otimes_{\mathbb{C}} \operatorname{Id}_{\mathcal{K}_i^{\bullet}}$ commutes with the differentials for all $m \geq 1$.

The proof of the fact that $\Phi_i(\widetilde{\varepsilon}_{\mathbb{C}}) \circ \mu_m = \mu_m \circ \Phi_i(\varepsilon_{\mathbb{C}})$ follows the same steps, this time using that for all $a^{\vee} \in R_{-m}$, $\widetilde{s}_r \cdot \mu_m(a^{\vee}) = \mu_m(\mu^{\vee}(\widetilde{f}cs_r) \cdot a)$, so we omit it. This shows that $\mu_m \otimes_{\mathbb{C}} \operatorname{Id}_{\mathcal{K}_i^{\bullet}}$ commutes with the differentials of the form $d + \Phi_i(\varepsilon_{\mathbb{C}})$ and $d + \widetilde{\Phi}_i(\widetilde{\varepsilon}_{\mathbb{C}})$. As in the previous case for μ_m^{\vee} , the proof follows the same steps for the other differentials appearing in the corresponding thickened mixed Hodge complexes of sheaves, so $\mu_m \otimes_{\mathbb{C}} \operatorname{Id}_{\mathcal{K}_i^{\bullet}}$ commutes with the differentials for all $m \geq 1$.

It remains to show that these morphisms between the complexes of sheaves commute with the pseudo-morphisms at every degree. It is clear that they commute with the morphisms of the form $\mathrm{Id} \otimes \alpha_i$, since these are the identity on the first factor. The commutation with the morphisms of the form $e^{\Psi_i(\varepsilon_{\mathbb{C}})}$ and $e^{\widetilde{\Psi}_i(\widetilde{\varepsilon}_{\mathbb{C}})}$ follows similar steps as the ones done for checking that these morphisms induced by μ between the complexes of sheaves commute with the differentials, so we omit them. \Box

Proposition 3.15. Let $m \in \mathbb{Z} \setminus \{0\}$. Let V be a k-vector space, where $k = \mathbb{Q}, \mathbb{R}, \mathbb{C}$. Let $M : (\mathcal{K}^{\bullet}, d) \to (\mathcal{G}^{\bullet}, d)$ be a quasi-isomorphism of complexes of sheaves over k on a smooth variety X. Let $\Phi : V \to \Gamma(X, \mathcal{K}^{1, cl})$. Then,

$$M_{\#} \coloneqq \mathrm{Id}_{R_m} \otimes_k M : (R_m \otimes_k \mathcal{K}^{\bullet}, d + \Phi(\varepsilon_k)) \to (R_m \otimes_k \mathcal{G}^{\bullet}, d + (M \circ \Phi)(\varepsilon_k))$$

is a quasi-isomorphism.

Proof. Note that $M_{\#}$ is a morphism of complexes (it commutes with the differentials)

Suppose that m > 0. Consider the decreasing filtration G^{\bullet} by subcomplexes of $(R_m \otimes_k \mathcal{K}^{\bullet}, d + \Phi(\varepsilon_k))$ given by

$$G^p R_m \otimes_k \mathcal{K}^{\bullet} = \left(\bigoplus_{p < j < m-1} \operatorname{Sym}^j V^{\vee} \right) \otimes_k \mathcal{K}^{\bullet}.$$

Note that $G^0 R_m \otimes_k \mathcal{K}^{\bullet} = R_m \otimes_k \mathcal{K}^{\bullet}$ and $G^m R_m \otimes_k \mathcal{K}^{\bullet} = 0$. Similarly, we define the decreasing filtration G^{\bullet} of $R_m \otimes_k \mathcal{G}^{\bullet}$, $d + (M \circ \Phi(\varepsilon_k))$. Note that $M_{\#}$ preserves the filtration G^{\bullet} , and multiplication by $\Phi(\varepsilon_k)$ or $(M \circ \Phi)(\varepsilon_k)$ increases the filtration by 1. In particular, for $p \ge 0$ we have the following commutative diagrams of short exact sequences:

$$\begin{array}{cccc} G^{p+1}(R_m \otimes_k \mathcal{K}^{\bullet}, d + \Phi(\varepsilon_k)) & \longrightarrow & G^p(R_m \otimes_k \mathcal{K}^{\bullet}, d + \Phi(\varepsilon_k)) & \longrightarrow & \operatorname{Gr}_G^p(R_m \otimes_k \mathcal{K}^{\bullet}, d) \\ & & \downarrow^{M_{\#}} & & \downarrow^{M_{\#}} \\ G^{p+1}(R_m \otimes_k \mathcal{G}^{\bullet}, d + (M \circ \Phi)(\varepsilon_k)) & \longmapsto & G^p(R_m \otimes_k \mathcal{G}^{\bullet}, d + (M \circ \Phi)(\varepsilon_k)) & \longrightarrow & \operatorname{Gr}_G^p(R_m \otimes_k \mathcal{G}^{\bullet}, d) \end{array}$$

If p = m - 1, the vertical arrow on the left is a morphism between two 0 complexes, and the vertical arrow on the left is a quasi-isomorphism, so the central vertical arrow must also be a quasi-isomorphism. The rest of the proof now follows from decreasing induction and the five lemma, ending at p = 0, where one can show that the central vertical arrow is a quasi-isomorphism.

The result for m < 0 follows similarly by defining a decreasing filtration on $R_m \otimes_k \mathcal{K}^{\bullet}$ from the dual decreasing filtration on R_m defined as in Definition-Proposition 2.52 from the one in R_{-m} , namely $G^p R_{-m} \coloneqq \{h : R_m \to \mathbb{C} \mid \bigoplus_{-p+1 \le j \le m-1} \operatorname{Sym}^j V^{\vee} \subset \ker h\}.$

Proposition 3.16. Suppose we have two pieces of data as in Assumption 3.1:

$$(\mathcal{K}^{\bullet}, V, \Phi, \Psi), (\mathcal{K}^{\bullet}, V, \Phi, \Psi)$$

Furthermore, suppose that they are connected by a morphism of multiplicative mixed Hodge complexes of sheaves $M: \mathcal{K}^{\bullet} \to \widetilde{\mathcal{K}}^{\bullet}$, that is compatible with the remaining data, in the sense that for every *i*,

$$\Phi_{2i} = M_{2i} \circ \Phi_{2i};$$
$$\widetilde{\Psi}_{2i-1} = M_{2i-1} \circ \Psi_{2i-1}.$$

Then, $\operatorname{Id}_{R_m} \otimes M$ is a morphism of mixed Hodge complexes of sheaves between the two thickenings $\mathcal{K}^{\bullet}(m, V, \Phi, \Psi)$ and $\widetilde{\mathcal{K}}^{\bullet}(m, V, \widetilde{\Phi}, \widetilde{\Psi})$. Moreover,

- 31
- if M is a weak equivalence in the sense of [37, Lemma-Definition 3.19] (that is, a collection of quasi-isomorphisms), so is $Id_{R_m} \otimes M$, and
- if M is a filtered quasi-isomorphism between the respective components of the mixed Hodge complexes of sheaves \mathcal{K}^{\bullet} and $\widetilde{\mathcal{K}}^{\bullet}$ (and bi-filtered in the last), so is $\mathrm{Id}_{R_m} \otimes M$.

Proof. Let α and β denote the pseudo-morphisms in \mathcal{K}^{\bullet} and $\widetilde{\mathcal{K}}^{\bullet}$ respectively.

First of all, $\operatorname{Id}_{R_m} \otimes_{\mathbb{C}} M_{2i}$ commutes with the differentials $d + \Phi_{2i}(\varepsilon_{\mathbb{C}})$ and $d + \Phi_{2i}(\varepsilon_{\mathbb{C}})$ because M commutes with all Φ 's, and it commutes with differentials of the form $d + \alpha_j \circ \Phi_{2i}$ and $d + \beta_j \tilde{\Phi}_{2i}(\varepsilon_{\mathbb{C}})$ because M commutes with the α 's as well. Next, $\operatorname{Id}_{R_m} \otimes M$ commutes with all the maps in the pseudomorphisms (3.9) (the α 's and the β 's): It commutes with maps of the form $\operatorname{Id}_{R_m} \otimes \alpha_i$ and $\operatorname{Id}_{R_m} \otimes \beta_i$ because M, being a mixed Hodge complex morphism, must commute with the α_i 's and β_i 's, and it commutes with maps of the form $e^{\Psi_i(\varepsilon)}$ because M is required to preserve the multiplicative structure and commute with the Ψ 's. Lastly, $\operatorname{Id}_{R_m} \otimes M$ preserves all the filtrations because both Id_{R_m} and M do. This concludes the proof of the fact that $\operatorname{Id}_{R_m} \otimes M$ is a morphism of mixed Hodge complexes of sheaves.

The first point in the "moreover" part of the statement follows from Proposition 3.15.

Lastly, the proof of the second point for the weight filtration in the "moreover" part of the statement follows from the fact that after passing to the graded pieces the differentials become untwisted, and from the direct sum decomposition of the graded pieces in terms of graded pieces of the tensor appearing in the proof of Lemma 3.6. For the Hodge filtration in the last component of both mixed Hodge complexes of sheaves, one can use again use the the direct sum decomposition of the graded pieces in terms of graded pieces of the tensor, and use an inductive argument similar to the one in the proof of Proposition 3.15, defining the filtration that G induces on these graded pieces.

4. The thickening of the logarithmic Dolbeault complex

In the previous section, we showed how to construct a thickened mixed Hodge complex of sheaves from a multiplicative mixed Hodge complex of sheaves and the extra data (V, Φ, Ψ) of Assumption 3.1. In this section, we apply this construction in the case where the multiplicative mixed Hodge complex of sheaves is the modified logarithmic Dolbeault mixed Hodge complex of sheaves from Definition-Proposition 2.72 (based on Navarro Aznar's mixed Hodge complex of sheaves from Definition 2.68) and V is the first cohomology of a semiabelian variety G. The following result clarifies which ingredients we will use in order to construct a thickening of the logarithmic Dolbeault complex. In it, note that the mixed Hodge complex of Definition-Proposition 2.72 is extended by an extra term (using the identity morphism) to fit Assumption 3.1.

Lemma 4.1. Let $U \xrightarrow{f} G$ be an algebraic morphism from a smooth variety to a semiabelian variety. Let

$$0 \to G_T \xrightarrow{t} G \xrightarrow{p_A} G_A \to 0.$$

be the Chevalley decomposition of G.

Suppose that we have the ingredients $(X, Y, \Phi_{\mathbb{R}}^{Y}, \Phi_{\mathbb{C}}^{Y}, \Psi^{Y})$, satisfying the following properties:

(1) X is a good compactification of U and Y is an allowed compactification of G (Definition 2.39) such that X and Y are compatible with respect to f (Definition 2.40), i.e. f extends to $\overline{f}: X \to Y$.

(2) Let $E \coloneqq Y \setminus G$ and let $D \coloneqq X \setminus U$.

(3) Let $n \ge \max\{2, \dim_{\mathbb{R}} U\}$, and let $\mathcal{N}^{\bullet}_{X,D,n}$ be the (multiplicative) mixed Hodge complex from [34] (see Definition-Proposition 2.72):

$$\mathcal{N}^{\bullet}_{X,D,n} \coloneqq \left((\mathcal{A}^{\bullet}_{X,\mathbb{R}}(\log D), W^n_{\bullet}), (\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), W^n_{\bullet}, F^{\bullet}), \alpha \right)$$

where α is the filtered pseudo-morphism such that $\alpha \otimes 1$ is the filtered pseudo-isomorphism

$$(\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), W^n_{\cdot}) = (\mathcal{A}^{\bullet}_{X,\mathbb{R}}(\log D) \otimes_{\mathbb{R}} \mathbb{C}, W^n_{\cdot}) \xrightarrow{\mathrm{Id}} (\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), W^n_{\cdot}) \xleftarrow{\mathrm{Id}} (\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), W^n_{\cdot}).$$

(4) Let $H = H^1(G; \mathbb{R})$, together with its mixed Hodge structure.

(5) $\Phi_{\mathbb{R}}^{Y}, \Phi_{\mathbb{C}}^{Y}$ are linear maps which are a section of the cohomology map, with the following domain and target:

$$\Phi_{\mathbb{R}}^{Y} \colon H \to \Gamma(Y, \mathcal{A}_{Y,\mathbb{R}}^{1,\mathrm{cl}}(\log E)),$$
$$\Phi_{\mathbb{C}}^{Y} \colon H_{\mathbb{C}} \coloneqq H \otimes_{\mathbb{R}} \mathbb{C} \to \Gamma(Y, \mathcal{A}_{Y,\mathbb{C}}^{1,\mathrm{cl}}(\log E)).$$

Here, $\mathcal{A}_{Y,k}^{1,\mathrm{cl}}(\log E)$ denotes the closed k-valued forms in $\mathcal{A}_{Y,k}^1(\log E)$. These maps satisfy the following three conditions:

- For $k = \mathbb{R}, \mathbb{C}$, the image of Φ_k^Y is contained in $\Gamma(Y, \widetilde{W}_1 \mathcal{A}_{Y,k}^{1,\mathrm{cl}}(\log E))$, where \widetilde{W} is as in Definition 2.68.
- Both $\Phi_{\mathbb{R}}^{Y}$ and $\Phi_{\mathbb{C}}^{Y}$ send classes that are pulled back from G_{A} to forms whose restriction to G is in the image of $p_{A}^{*}: \Gamma(G_{A}, \mathcal{A}_{G_{A},k}^{1}) \to \Gamma(G, \mathcal{A}_{G,k}^{1})$ for $k = \mathbb{R}, \mathbb{C}$ respectively.
- $\Phi^Y_{\mathbb{C}}$ sends classes that are represented by holomorphic forms on G to (1,0)-forms.

(6) Ψ^Y is a linear map (a homotopy)

$$\Psi^Y \colon H_{\mathbb{C}} \to \Gamma(Y, \mathcal{A}^0_{Y, \mathbb{C}}(\log E))$$

such that

$$d \circ \Psi^Y = \mathbb{C} \otimes \Phi^Y_{\mathbb{R}} - \Phi^Y_{\mathbb{C}}.$$

 $Then, \ (\mathcal{K}^{\bullet}, V, \Phi_0, \Phi_2, \Psi_1) \coloneqq (\mathcal{N}_{X,D,n}^{\bullet}, H, \overline{f}^* \circ \Phi_{\mathbb{R}}^Y, \overline{f}^* \circ \Phi_{\mathbb{C}}^Y, \overline{f}^* \circ \Psi^Y) \ satisfy \ Assumption \ 3.1.$

Proof. We need to show that Φ_0, Φ_2, Ψ_1 satisfy the conditions of Assumption 3.1. We do this in several steps. Note that, since $n \ge 2$, the filtrations of the logarithmic Dolbeault complex W_j^n and \widetilde{W}_j coincide for j = 0, 1, 2, so we can use \widetilde{W}_j in our arguments.

(1) Let us see that $\Phi_{\mathbb{R}}^{Y}$ respects the weight filtration as follows:

$$\Phi_{\mathbb{R}}^{Y}: (H, W_{\bullet}[1]) \to \Gamma\left(Y, \left(\mathcal{A}_{Y, \mathbb{R}}^{1, \mathrm{cl}}(\log E), W_{\bullet}^{n}\right)\right).$$

Since G is smooth, $\operatorname{Gr}_i^W H = 0$ when *i* is not contained in $\{1, 2\}$. Therefore, after the shift, the non trivial graded pieces correspond to indices contained in $\{0, 1\}$. The weight 1 is preserved by hypothesis.

For weight 0, note that

$$W_0(H^1(G,\mathbb{R})[1]) = W_1H^1(G,\mathbb{R}) = H^1(G_A,\mathbb{R}), \quad \text{and} \quad \widetilde{W}_0\mathcal{A}^1_{Y,\mathbb{R}}(\log E) = \mathcal{A}^1_{Y,\mathbb{R}}$$

Since Y is an allowed compactification of G, there exists a compactification \overline{G} as in Corollary 2.38 and an algebraic map $p: Y \to \overline{G}$ such that $p \circ j_Y = j_{\overline{G}}$, where $j_Z: G \hookrightarrow Z$ is the inclusion for $Z = Y, \overline{G}$. In particular, p_A extends to a fibration $\overline{p_A}: \overline{G} \to G_A$. Let $a \in H^1(G_A, \mathbb{R})$. By hypothesis, $\Phi_{\mathbb{R}}^Y(a)_{|G} = p_A^* \omega$ for some $\omega \in \Gamma(G_A, \mathcal{A}_{G_A,\mathbb{R}}^1)$. Note that $\Phi_{\mathbb{R}}^Y(a)$ and $p^*(\overline{p_A}^*\omega)$ have the same restriction to G, and since G is dense, they must coincide. In particular, $\Phi_{\mathbb{R}}^Y(a) \in \Gamma(Y, \mathcal{A}_{Y,\mathbb{R}}^1) = \Gamma(Y, \widetilde{W}_0 \mathcal{A}_{Y,\mathbb{R}}^1(\log E))$.

- (2) $\Phi_{\mathbb{C}}^{Y}: (H_{\mathbb{C}}, W_{\cdot}[1]) \to \Gamma\left(Y, \left(\mathcal{A}_{Y,\mathbb{C}}^{1,\mathrm{cl}}(\log E), \widetilde{W}_{\cdot}\right)\right)$ also respects the weight filtration by the analogous argument over \mathbb{C} .
- (3) $\Psi^{Y} : (H_{\mathbb{C}}, W_{\cdot}[1]) \to \Gamma\left(Y, \left(\mathcal{A}^{0}_{Y,\mathbb{C}}(\log E), \widetilde{W}_{\cdot}\right)\right)$ respects the weight filtration: Since $\Phi^{Y}_{\mathbb{R}}$ and $\Phi^{Y}_{\mathbb{C}}$ respect the filtrations (up to a shift), the relationship between $\Psi^{Y}, \Phi^{Y}_{\mathbb{R}}$ and $\Phi^{Y}_{\mathbb{C}}$ implies that it suffices to show that, for $d : \mathcal{A}^{0}_{Y,\mathbb{C}}(\log E) \to \mathcal{A}^{1}_{Y,\mathbb{C}}(\log E), \ d^{-1}\left(\widetilde{W}_{j}\mathcal{A}^{1}_{Y,\mathbb{C}}(\log E)\right) = \widetilde{W}_{j}\mathcal{A}^{0}_{Y,\mathbb{C}}(\log E)$ for all $j \ge 0$ (we only need to apply this fact for $j \in \{0,1\}$).

To do this, we will show that for all $j \geq 1$, $d^{-1}\left(\widetilde{W}_{j-1}\mathcal{A}^{1}_{Y,\mathbb{C}}(\log E)\right) \cap \widetilde{W}_{j}\mathcal{A}^{0}_{Y,\mathbb{C}}(\log E) = \widetilde{W}_{j-1}\mathcal{A}^{0}_{Y,\mathbb{C}}(\log E)$. We apply Proposition 2.70, which ensures that

$$\mathcal{H}^0\left(\operatorname{gr}_j^{\widetilde{W}}\mathcal{A}_{Y,\mathbb{C}}^{\bullet}(\log E)\right) \cong \mathcal{H}^0\left(\operatorname{gr}_j^{\tau}\mathcal{A}_{Y,\mathbb{C}}^{\bullet}(\log E)\right) \stackrel{j>0}{=} 0.$$

Spelling out the definition of \mathcal{H}^0 , this means that if $\alpha \in \widetilde{W}_i \mathcal{A}^0_{Y,\mathbb{C}}(\log E)$ is such that $d\alpha \in$ $\widetilde{W}_{j-1}\mathcal{A}^1_{Y,\mathbb{C}}(\log E)$, then $\alpha \in \widetilde{W}_{j-1}\mathcal{A}^0_{Y,\mathbb{C}}(\log E)$, as desired. By induction on j, we have that for any $j > j' \ge 0$, if $\alpha \in \widetilde{W}_j \mathcal{A}^0_{Y,\mathbb{C}}(\log E)$ is such that $d\alpha \in \widetilde{W}_{j'} \mathcal{A}^1_{Y,\mathbb{C}}(\log E)$, then $\alpha \in \mathcal{W}_{j'} \mathcal{A}^1_{Y,\mathbb{C}}(\log E)$ $W_{j'}\mathcal{A}^0_{Y\mathbb{C}}(\log E).$

- (4) $\Phi^Y_{\mathbb{C}}$ respects the Hodge filtration (without any shifts): The relevant pieces are $F^0 = H^1(G, \mathbb{C})$ and F^1 . For F^0 , we have that $H^1(G, \mathbb{C}) = F^0 H^1(G, \mathbb{C})$. Automatically, its image lands in $F^0\mathcal{A}^1_{Y,\mathbb{R}}(\log E) = \mathcal{A}^1_{Y,\mathbb{R}}(\log E)$. Next, by Deligne's theory of MHS, $F^1H^1(G,\mathbb{C})$ is composed of the classes of holomorphic forms, and $\Phi_{\mathbb{C}}$ maps these to (1,0) forms by hypothesis, that is, to $F^1\mathcal{A}^1_{Y,\mathbb{R}}(\log E).$
- (5) \overline{f}^* takes logarithmic forms to logarithmic forms and respects the filtrations W and F, so in particular it also respects W_0^n and W_1^n . Also, \overline{f}^* commutes with the differential d. Hence, Φ_0, Φ_2, Ψ_1 satisfy the conditions of Assumption 3.1.

In order to be able to apply Lemma 4.1, we need to make sure that such $\Phi_{\mathbb{R}}^{Y}, \Phi_{\mathbb{C}}^{Y}$ and Ψ^{Y} satisfying the assumptions therein exist, which we achieve in Definition-Proposition 4.8 and in Corollary 4.9. Before that, we start by recalling some general facts about abelian Lie groups in order to fix notation (Lemma 4.2). Then, we prove an auxiliary lemma (Lemma 4.2), which makes the definitions in Definition-Proposition 4.6 easier to state. These definitions are a first approximation to $\Phi_{\mathbb{R}}^{Y}, \Phi_{\mathbb{C}}^{Y}$ and Ψ^{Y} , and the images of the maps defined therein $(\Phi_{\mathbb{R}}^{G}, \Phi_{\mathbb{C}}^{G} \text{ and } \Psi^{G})$ consist of analytic forms on G. We later extend these to $\Phi_{\mathbb{R}}^{Y}, \Phi_{\mathbb{C}}^{Y}$ and Ψ^{Y} in Definition-Proposition 4.8.

Lemma 4.2. Let G be a complex semiabelian variety. Let Λ be the kernel of the exponential map $TG \rightarrow G$. Let the Chevalley decomposition of G be given by

(4.3)
$$0 \to G_T \xrightarrow{t} G \xrightarrow{p_A} G_A \to 0.$$

Let Ω^{\bullet}_X denote the holomorphic de Rham complex of sheaves on X for every smooth complex algebraic variety X, and if X is a complex Lie group, let $\Omega^{1,\text{inv}}_X$ (resp. $\mathcal{A}^{1,\text{inv}}_{X,k}$ for $k = \mathbb{R}, \mathbb{C}$) denote the sheaf of holomorphic (resp. analytic) invariant 1-forms on X. Then,

- (1) For $k = \mathbb{R}, \mathbb{C}$, there are natural isomorphisms $\Gamma(G, \mathcal{A}_{G,k}^{1, \text{inv}}) \cong \operatorname{Hom}_{\mathbb{R}}(TG, k)$ and $H^1(G, k) \cong$ $\operatorname{Hom}_{\mathbb{Z}}(\Lambda, k)$. The map that sends a form to its cohomology class corresponds to the restriction to Λ .
- (2) There is a natural isomorphism $\Gamma(G, \Omega_G^{1, \text{inv}}) \cong \operatorname{Hom}_{\mathbb{C}}(TG, \mathbb{C}).$ (3) The restriction $\Gamma(G, \Omega_G^{1, \text{inv}}) \to \Gamma(G_T, \Omega_{G_T}^{1, \text{inv}})$ is surjective.
- (4) The projection of invariant forms onto their cohomology classes $\Gamma(G, \mathcal{A}_{G,\mathbb{R}}^{1,\mathrm{inv}}) \to H^1(G,\mathbb{R})$ is a surjection, and the same holds for G_A and G_T . The statement is also true for \mathbb{C} -coefficients. Furthermore, in the case of G_A this projection is an isomorphism (both with \mathbb{R} and \mathbb{C} coefficients).
- (5) $\Gamma(G, \Omega_G^{1, \text{inv}})$ can be seen as a subspace of $H^1(G, \mathbb{C})$ through the projection of forms onto their cohomology classes, which is an injective map. The same holds for G_A and G_T . Furthermore, in the case of G_T this injection is an isomorphism.
- (6) The cohomology class of every closed holomorphic 1-form is represented by an invariant holomorphic form.
- (7) $H^1(G_A, \mathbb{C})$ can be seen as a subspace of $H^1(G, \mathbb{C})$ via $(p_A)^* : H^1(G_A, \mathbb{C}) \to H^1(G, \mathbb{C})$, which is injective.
- (8) $\Gamma(G, \Omega_G^{1, \text{inv}})$ and $H^1(G_A, \mathbb{C})$ generate $H^1(G, \mathbb{C})$ as a complex vector space.

Proof. Note that all invariant forms appearing in the statement of this lemma are closed, since they pull back to constant forms on the corresponding universal cover (a complex vector space), and the differential commutes with the pullback. Hence, the statements in parts (1), (4), (5) and (8) make sense.

Since G_A and G_T are semiabelian varieties, every statement that is proved for G applies to them as well.

- (1) The isomorphism $\Gamma(G, \mathcal{A}_{G,k}^{1,\text{inv}}) \cong \text{Hom}_{\mathbb{R}}(TG, k)$ comes from the fact that constant forms on a vector space are identified with its dual. For the second isomorphism, note that TG is the universal cover of G, and therefore Λ is canonically $\pi_1(G)$ and also $H_1(G,\mathbb{Z})$. Furthermore, since TG is a vector space, the pairing between a constant form seen as an element of $\operatorname{Hom}_{\mathbb{R}}(TG,k)$ and $x \in TG$ is the same as the integral of the form on a path from 0 to x. If $x \in \Lambda$, this path is the pullback of a loop in $\pi_1(G)$, and the statement follows from de Rham's theorem.
- (2) The isomorphism $\Gamma(G, \Omega_G^{1, \text{inv}}) \cong \text{Hom}_{\mathbb{C}}(TG, \mathbb{C})$ is analogous to the real analytic setting. (3) The morphism p_A in (4.3) is a fibration with fiber G_T , so it induces a short exact sequence between tangent spaces at the identity, and hence the restriction $\operatorname{Hom}_{\mathbb{C}}(TG,\mathbb{C}) \to$ $\operatorname{Hom}_{\mathbb{C}}(TG_T,\mathbb{C})$ is a surjection. Now, use part (2).
- (4) Since $G = TG/\Lambda$, Λ is discrete, and in particular any \mathbb{Z} -basis is \mathbb{R} -linearly independent. The statement for G follows from part (1). In the case of G_A , the fact that the projection is an isomorphism now follows from the fact that both spaces have the same real dimension, namely $2 \dim_{\mathbb{C}} G_A.$
- (5) From above, we have a natural isomorphism $\Gamma(G, \Omega_G^{1, \text{inv}}) \cong \text{Hom}_{\mathbb{C}}(TG, \mathbb{C})$, and $H^1(G, \mathbb{C})$ is naturally identified with $\text{Hom}_{\mathbb{Z}}(\Lambda, \mathbb{C})$. Since Λ generates TG as a \mathbb{C} -vector space, this restriction is injective. In the case of G_T , Λ is a \mathbb{C} -basis of TG_T , and the injection is an isomorphism.
- (6) Let us consider first the cases where G is an algebraic torus and an abelian variety. If G is a torus, then every cohomology class is represented by an invariant holomorphic form. If G is an abelian variety, the Hodge decomposition tells us that the space of classes of holomorphic forms has complex dimension equal to $\dim G$, so it suffices to compare dimensions.

For a general G, consider a closed form $\alpha \in \Gamma(G, \Omega_G^1)$. By the torus case, its restriction to G_T is represented by an invariant holomorphic form $\tilde{\alpha}_T$ on G_T which, by (3), is the restriction of some $\alpha_T \in \Gamma(G, \Omega_G^{1, \text{inv}})$. Then, $\alpha - \alpha_T$ is a holomorphic form that vanishes on G_T . By the short exact sequence (4.4), its cohomology class comes from G_A , and by the abelian variety case, it is represented by an invariant holomorphic form α_A . Then, in cohomology, $\alpha = \alpha_T + (p_A)^* \alpha_A$, which is the class of an invariant holomorphic form, as desired.

(7) Consider the long exact sequence of the fibration p_A on homotopy groups. Since the universal covers of all the spaces involved are contractible and their fundamental groups are all abelian, we get a short exact sequence in homology

$$0 \to H_1(G_T, \mathbb{Z}) \xrightarrow{t_*} H_1(G, \mathbb{Z}) \xrightarrow{(p_A)_*} H_1(G_A, \mathbb{Z}) \to 0,$$

and in particular, a short exact sequence in cohomology

(4.4)
$$0 \to H_1(A, \mathbb{C}) \xrightarrow{(p_A)^*} H^1(G, \mathbb{C}) \xrightarrow{t^*} H^1(G_T, \mathbb{C}) \to 0$$

(8) Using the short exact sequence (4.4), $H^1(G_A, \mathbb{C})$ together with the image of any section of t^* generate $H^1(G, \mathbb{C})$. Combining parts (5) and (3), such a section can be constructed from a section of $\Gamma(G, \Omega_G^{1, \text{inv}}) \to \Gamma(G_T, \Omega_{G_T}^{1, \text{inv}})$.

Remark 4.5. Consider the Chevalley decomposition (4.3) and Λ as in Lemma 4.2. Since G_T is an algebraic torus, $\Lambda \cap TG_T \cong \pi_1(G_T)$ is freely generated by a \mathbb{C} -basis of TG_T , and since G_A is an abelian variety, the image of Λ in TG_A is a full rank lattice in G_A .

We can choose a way of extending Λ to a full rank lattice in G. Let $\Lambda' := i \cdot (\Lambda \cap TG_T)$. Then, $\Lambda' \oplus (\Lambda \cap TG_T)$ is a full rank lattice in TG_T , and $\Lambda \oplus \Lambda'$ is a full rank lattice in TG.

Definition-Proposition 4.6 (Definition of $\Phi_{\mathbb{R}}^G$, $\Phi_{\mathbb{C}}^G$ and Ψ^G). Let Y be an allowed compactification of a complex semiabelian variety G, let $j_Y: G \to Y$ be the inclusion and let $E \coloneqq Y \setminus G$. Let

$$0 \to G_T \xrightarrow{t} G \xrightarrow{p_A} G_A \to 0$$

be the Chevalley decomposition of G.

We define Φ^G_C as the unique C-linear map whose restrictions to H¹(G_A, C) and the cohomology classes of Γ(G, Ω^{1,inv}_G) are as follows:
 (1)

$$(\Phi^G_{\mathbb{C}})|_{H^1(G_A,\mathbb{C})} : H^1(G_A,\mathbb{C}) \to \Gamma(G,\mathcal{A}^{1,\mathrm{inv}}_{G,\mathbb{C}})$$

is given by the composition of the isomorphism found in Lemma 4.2(4) $H^1(G_A; \mathbb{C}) \cong \Gamma(G_A, \mathcal{A}_{G_A, \mathbb{C}}^{1, \text{inv}})$ and the pullback by p_A .

(2)

$$(\Phi^G_{\mathbb{C}})|_{\Gamma(G,\Omega^{1,\mathrm{inv}}_G)}: \Gamma(G,\Omega^{1,\mathrm{inv}}_G) \to \Gamma(G,\mathcal{A}^{1,\mathrm{inv}}_{G,\mathbb{C}})$$

- is the map given by the inclusion of sheaves.
- We define $\Phi^G_{\mathbb{R}}$ as the composition

$$H^1(G,\mathbb{R}) \hookrightarrow H^1(G,\mathbb{C}) \xrightarrow{\Phi^G_{\mathbb{C}}} \Gamma(G,\mathcal{A}^1_{G,\mathbb{C}}) \xrightarrow{\Re} \Gamma(G,\mathcal{A}^1_{G,\mathbb{R}}).$$

where \Re is the real part.

• We define $\Psi^G : H^1(G, \mathbb{C}) \to \Gamma(G, \mathcal{A}^0_{G, \mathbb{C}})$ as the unique linear map satisfying that $d\Psi^G = \mathbb{C} \otimes \Phi^G_{\mathbb{R}} - \Phi^G_{\mathbb{C}}$ whose image lies in $\operatorname{Hom}_{\mathbb{R}\text{-} Lie \ groups}(G, \mathbb{C}).$

Proof. To see that $\Phi^G_{\mathbb{C}}$ is well defined, we need to see that $(\Phi^G_{\mathbb{C}})_{|\Gamma(G,\Omega^{1,\mathrm{inv}}_G)}$ and $(\Phi^G_{\mathbb{C}})_{|H^1(G_A,\mathbb{C})}$ agree on $\Gamma(G,\Omega^{1,\mathrm{inv}}_G) \cap H^1(G_A,\mathbb{C})$. We are going to use the notation for Λ and Λ' from Remark 4.5. We will give a global definition of $\Phi^G_{\mathbb{C}}$ and we will check that it agrees with the definition that we gave on each of the subspaces.

Consider the natural isomorphism

$$\operatorname{Hom}_{\mathbb{Z}}(\Lambda, \mathbb{C}) \oplus \operatorname{Hom}_{\mathbb{Z}}(\Lambda', \mathbb{C}) \cong \operatorname{Hom}_{\mathbb{R}}(TG, \mathbb{C}) \cong \Gamma(G, \mathcal{A}_{G, \mathbb{C}}^{1, \operatorname{inv}}),$$

and let $(\alpha, \alpha') \in \operatorname{Hom}_{\mathbb{Z}}(\Lambda, \mathbb{C}) \oplus \operatorname{Hom}_{\mathbb{Z}}(\Lambda', \mathbb{C})$. Seeing this inside of $\Gamma(G, \mathcal{A}_{G,\mathbb{C}}^{1,\operatorname{inv}})$, we have that $t^*(\alpha, \alpha')$ is the restriction to $\operatorname{Hom}_{\mathbb{Z}}(\Lambda \cap TG_T, \mathbb{C}) \oplus \operatorname{Hom}_{\mathbb{Z}}(\Lambda', \mathbb{C}) \cong \Gamma(G_T, \mathcal{A}_{G_T,\mathbb{C}}^{1,\operatorname{inv}})$. The elements of $\operatorname{Hom}_{\mathbb{Z}}(\Lambda \cap TG_T, \mathbb{C}) \oplus \operatorname{Hom}_{\mathbb{Z}}(\Lambda', \mathbb{C})$ which correspond to elements of $\Gamma(G_T, \Omega_{G_T}^{1,\operatorname{inv}}) \cong \operatorname{Hom}_{\mathbb{Z}}(\Lambda \cap TG_T, \mathbb{C}) \cong \operatorname{Hom}_{\mathbb{C}}(TG_T, \mathbb{C})$ are the ones satisfying that $\alpha' = -i \circ \alpha|_{\Lambda \cap TG_T} \circ i$. Consider the following chain of isomorphisms:

$$H^{1}(G,\mathbb{C}) \cong \operatorname{Hom}_{\mathbb{Z}}(\Lambda,\mathbb{C}) \cong \left\{ \begin{array}{c} (\alpha,\alpha') \in \operatorname{Hom}_{\mathbb{Z}}(\Lambda,\mathbb{C}) \oplus \operatorname{Hom}_{\mathbb{Z}}(\Lambda',\mathbb{C}) \cong \operatorname{Hom}_{\mathbb{R}}(TG,\mathbb{C}) \cong \Gamma(G,\mathcal{A}_{G,\mathbb{C}}^{1,\operatorname{inv}}) \\ & \text{where } \alpha' = -i \circ \alpha|_{\Lambda \cap TG_{T}} \circ i \end{array} \right\}$$

$$\cong \{ (\alpha, \alpha') \in \Gamma(G, \mathcal{A}_{G, \mathbb{C}}^{1, \text{inv}}) \mid t^*(\alpha, \alpha') \in \Gamma(G_T, \Omega_{G_T}^{1, \text{inv}}) \} \subset \Gamma(G, \mathcal{A}_{G, \mathbb{C}}^{1, \text{inv}})$$

We claim that the composition above coincides with the definition that we have given of $\Phi_{\mathbb{G}}^G$: We start by showing that both definitions agree on $H^1(G_A, \mathbb{C})$. Let $\beta \in H^1(G_A, \mathbb{C}) \cong \Gamma(G_A, \mathcal{A}_{G_A,\mathbb{C}}^{1,\text{inv}}) \cong$ Hom_{\mathbb{R}} $(TG_A, \mathbb{C}) \cong$ Hom_{\mathbb{Z}} $(\Lambda/(\Lambda \cap TG_T), \mathbb{C})$, where the first of these isomorphisms is the one in part (4) of Lemma 4.2. Let q be the quotient $q: TG \to TG_A$. By our definition, $(\Phi_{\mathbb{C}}^G)|_{H^1(G_A,\mathbb{C})}(\beta) = \beta \circ q \in$ Hom_{\mathbb{R}} $(TG, \mathbb{C}) \cong \Gamma(G, \mathcal{A}_{G,\mathbb{C}}^{1,\text{inv}})$ for all $\beta \in$ Hom_{\mathbb{R}} (TG_A, \mathbb{C}) . Note that $\beta \circ q \circ \iota_\Lambda$ is just $\beta \in H^1(G_A, \mathbb{C})$ seen inside of $H^1(G, \mathbb{C}) \cong$ Hom_{\mathbb{Z}} (Λ, \mathbb{C}) , where $\iota_\Lambda : \Lambda \to TG$ is the inclusion. The chain of isomorphisms in (4.7) sends $\beta \circ q \circ \iota_\Lambda$ to $(\beta \circ q \circ \iota_\Lambda, 0)$, which corresponds to $\beta \circ q$ under the isomorphism Hom_{\mathbb{R}} $(TG, \mathbb{C}) \cong$ Hom_{\mathbb{Z}} (Λ, \mathbb{C}) .

Let us now see that both definitions agree on $\Gamma(G, \Omega_G^{1, \text{inv}}) \cong \text{Hom}_{\mathbb{C}}(TG, \mathbb{C})$. Let $\beta \in \text{Hom}_{\mathbb{C}}(TG, \mathbb{C})$. By our definition, $(\Phi_{\mathbb{C}}^G)|_{\Gamma(G, \Omega_G^{1, \text{inv}})}(\beta)$ equals β itself, but seen inside of $\text{Hom}_{\mathbb{R}}(TG, \mathbb{C})$. In Lemma 4.2 (4), we see β in $H^1(G, \mathbb{C}) \cong \text{Hom}_{\mathbb{Z}}(\Lambda, \mathbb{C})$ as $\beta \circ \iota_{\Lambda}$. The chain of isomorphisms (4.7) sends $\beta \circ \iota_{\Lambda}$ to $(\beta \circ \iota_{\Lambda}, \beta \circ \iota_{\Lambda'})$, where $\iota_{\Lambda'} : \Lambda' \hookrightarrow TG$ is the inclusion. This equals β itself. Hence, we have seen that $\Phi_{\mathbb{C}}^Y$ is well defined.

Let us now construct Ψ^G . Suppose $\alpha \in H^1(G, \mathbb{C}) \cong \operatorname{Hom}_{\mathbb{Z}}(\Lambda, \mathbb{C})$. We will see α as an element of $\operatorname{Hom}_{\mathbb{Z}}(\Lambda, \mathbb{C})$. Then, by our construction, $(\mathbb{C} \otimes \Phi_{\mathbb{R}})(\alpha)$ vanishes on Λ' , while $\Phi_{\mathbb{C}}(\alpha)|_{\Lambda'} = -i \circ \alpha|_{\Lambda \cap TG_{\mathcal{T}}} \circ i$. They both agree on Λ , so their difference is the element $\beta \in \operatorname{Hom}_{\mathbb{Z}}(\Lambda \oplus \Lambda', \mathbb{C})$ that vanishes on Λ and agrees with $i \circ \alpha|_{\Lambda \cap TG_T} \circ i$ on Λ' . Going back through the isomorphism $\operatorname{Hom}_{\mathbb{Z}}(\Lambda \oplus \Lambda', \mathbb{C}) \cong$ $\operatorname{Hom}_{\mathbb{R}}(TG,\mathbb{C}),\ \beta$ corresponds to a linear map vanishing on the \mathbb{R} -span of Λ . The pullback of an invariant form to the universal cover TG yields a constant 1-form. Let us pull back the form $\beta =$ $(\mathbb{C} \otimes \Phi_{\mathbb{R}} - \Phi_{\mathbb{C}})(\alpha)$ to a form in TG. Note that this pulled back 1-form on TG is exact: a linear function on a vector space seen as an invariant 1-form is the differential of itself, seen as a function (in coordinates, $\sum a_i dz_i$ is the differential of $\sum a_i z_i$). In other words, it is the differential of the linear function h vanishing on the span of Λ and agreeing with $i \circ \alpha|_{\Lambda \cap TG_T} \circ i$ on Λ' (i.e. β seen as a function). Lastly, note that $h: TG \to \mathbb{C}$ descends to G, since it is A-invariant (it vanishes on A and it is \mathbb{R} -linear). This function can be defined to be $\Psi^{G}(\alpha)$ (it is uniquely defined up to constants amongst the functions $\Psi^{G}(\alpha)$ that satisfy that $d\Psi^{G}(\alpha) = \mathbb{C} \otimes \Phi^{G}_{\mathbb{R}}(\alpha) - \Phi^{\check{G}}_{\mathbb{C}}(\alpha)$. Note that we have defined Ψ^G as a linear map, and furthermore, it is a homomorphism $H^1(\check{G}, \mathbb{C}) \to \operatorname{Hom}_{\mathbb{R}-\operatorname{Lie groups}}(G, \mathbb{C})$. In fact, since $\Psi^{G}(\alpha)$ is uniquely defined up to adding a constant function, our choice of Ψ^{G} such that its image is in $\operatorname{Hom}_{\mathbb{R}-\operatorname{Lie groups}}(G,\mathbb{C})$ is unique.

Definition-Proposition 4.8 (Definition of $\Phi_{\mathbb{C}}^Y$, $\Phi_{\mathbb{R}}^Y$ and Ψ^Y). Let Y be an allowed compactification of a complex semiabelian variety G, let $j_Y : G \to Y$ be the inclusion and let $E := Y \setminus G$.

The images of the maps $\Phi^G_{\mathbb{C}}$, $\Phi^G_{\mathbb{R}}$ and Ψ^G consist of logarithmic forms in $\Gamma(Y, \mathcal{A}^{1,cl}_{Y,\mathbb{C}}(\log E))$, $\Gamma(Y, \mathcal{A}^{1,cl}_{Y,\mathbb{R}}(\log E))$ and $\Gamma(Y, \mathcal{A}^0_{Y,\mathbb{R}}(\log E))$ respectively, where $\Gamma(Y, \mathcal{A}^l_{Y,k}(\log E))$ is seen as a subspace of $\Gamma(G, \mathcal{A}^l_{Y,k})$ through

$$\Gamma(Y, \mathcal{A}_{Y,k}^{l}(\log E)) \subset \Gamma(Y, (j_{Y})_{*}\mathcal{A}_{G,k}^{l}) \cong \Gamma(G, \mathcal{A}_{G,k}^{l}),$$

for $k = \mathbb{R}, \mathbb{C}$ and l = 0, 1. Hence we can define

$$\Phi_{\mathbb{C}}^{Y} : H^{1}(G, \mathbb{C}) \to \Gamma(Y, \widetilde{W}_{1}\mathcal{A}_{Y,\mathbb{C}}^{1, \text{cl}}(\log E)) \subseteq \Gamma(Y, \mathcal{A}_{Y,\mathbb{C}}^{1, \text{cl}}(\log E)),
\Phi_{\mathbb{R}}^{Y} : H^{1}(G, \mathbb{R}) \to \Gamma(Y, \widetilde{W}_{1}\mathcal{A}_{Y,\mathbb{R}}^{1, \text{cl}}(\log E)) \subseteq \Gamma(Y, \mathcal{A}_{Y,\mathbb{R}}^{1, \text{cl}}(\log E)), and
\Psi^{Y} : H^{1}(G, \mathbb{C}) \to \Gamma(Y, \mathcal{A}_{Y,\mathbb{R}}^{0}(\log E))$$

as the maps $\Phi^G_{\mathbb{C}}$, $\Phi^G_{\mathbb{R}}$ and Ψ^G of Definition-Proposition 4.6 respectively.

Proof. Since the images of $\Phi_{\mathbb{C}}^G$, $\Phi_{\mathbb{R}}^G$ and Ψ^G consist of invariant forms and those are closed, any logarithmic form on Y that extends them must also be closed.

Let us check that the image of $\Phi_{\mathbb{C}}^G : H^1(G, \mathbb{C}) \to \Gamma(G, \mathcal{A}_{G,\mathbb{C}}^{1,\mathrm{inv}}) \subset \Gamma(G, \mathcal{A}_{G,\mathbb{C}}^{1})$ lies in the space $\Gamma(Y, \widetilde{W}_1 \mathcal{A}_{Y,\mathbb{C}}^{1,\mathrm{cl}}(\log E))$. Since Y is an allowed compactification of G, there exists a compactification \overline{G} of G as in Corollary 2.38 and an algebraic map $p: Y \to \overline{G}$ such that $p \circ j_Y = j_{\overline{G}}$, where $j_{\overline{G}}: G \to \overline{G}$ is the inclusion. Let $E' = \overline{G} \setminus G$. First of all, the image of $\Phi_{\mathbb{C}}^G$ is contained in $\Gamma(\overline{G}, \widetilde{W}_1 \mathcal{A}_{\overline{G},\mathbb{C}}(\log E')^{1,\mathrm{cl}})$, in fact, all invariant forms are logarithmic of weight \widetilde{W} equal to 1 (recall that we already know that invariant forms are closed). This can be verified over an open cover of G_A : over a small enough open set U_A of G_A , \overline{G} is isomorphic to $(\mathbb{P}^1)^m \times U_A$, and an explicit basis of the space of invariant forms can be written down using local coordinates. By pulling back through p, we see that the elements in the image of $\Phi_{\mathbb{C}}^G$ all extend (necessarily uniquely) to elements of $\Gamma(Y, \widetilde{W}_1 \mathcal{A}_{Y,\mathbb{C}}^{1,\mathrm{cl}}(\log E))$.

The fact that the image of $\Phi^G_{\mathbb{R}} : H^1(G, \mathbb{R}) \to \Gamma(G, \mathcal{A}^{1, \text{inv}}_{G, \mathbb{R}}) \subset \Gamma(G, \widetilde{W}_1 \mathcal{A}^1_{G, \mathbb{R}})$ lies in $\Gamma(Y, \mathcal{A}^{1, \text{cl}}_{Y, \mathbb{R}}(\log E))$ follows from the definition of $\Phi^G_{\mathbb{R}}$ as the real part of $\Phi^G_{\mathbb{C}}$ and from the previous paragraph.

Let us show that the elements in the image of Ψ^G extend to globally defined elements in the space $\Gamma(Y, \mathcal{A}^0_{Y,\mathbb{C}}(\log E))$. It suffices to see that they extend to globally defined elements in $\Gamma(\overline{G}, \mathcal{A}^0_{\overline{G},\mathbb{C}}(\log E'))$, and then pull those back through $p: Y \to \overline{G}$. This can be verified over an open cover of G_A as before: over a small enough open set U_A of G_A , G is isomorphic to $(\mathbb{C}^*)^n \times U_A$, and \overline{G} is isomorphic to $(\mathbb{P}^1)^m \times U_A$. Let (z_1, \ldots, z_n) be (complex) coordinates of the $(\mathbb{C}^*)^n$ factor. One can check that the elements in the image of Ψ^G (as defined explicitly in the proof of Definition-Proposition 4.6) are the functions $(\mathbb{C}^*)^n \times U_A \to \mathbb{C}$ of the form $\sum_{i=1}^n a_i \log(|z_i|)$ for $a_1, \ldots, a_n \in \mathbb{C}$. Hence, these all lie in $\Gamma(\overline{G}, \mathcal{A}^0_{\overline{G}, \mathbb{C}}(\log E'))$.

Corollary 4.9. Let Y be an allowed compactification of a complex semiabelian variety G, let $j_Y : G \to Y$ be the inclusion and let $E := Y \setminus G$. Then, the maps $\Phi_{\mathbb{C}}^Y$ and $\Phi_{\mathbb{R}}^Y$ satisfy the assumptions of part (5) in Lemma 4.1.

Proof. Let $0 \to G_T \xrightarrow{t} G \xrightarrow{p_A} G_A \to 0$ be the Chevalley decomposition of G. Let $k = \mathbb{R}, \mathbb{C}$. The first condition (the image of Φ_k^Y is contained in weight 1) is part of Definition-Proposition 4.8. The fact that $\Phi_{\mathbb{C}}^Y$ and $\Phi_{\mathbb{R}}^Y$ are sections of the cohomology map follows immediately from the definition of Φ_k^G (Definition-Proposition 4.6).

The fact that Φ_k^Y maps forms which are pulled back from $H^1(G_A, \mathbb{C})$ to forms whose restriction to G is in the image of $p_A^* : \Gamma(G_A, \mathcal{A}_{G_A,k}^1) \to \Gamma(G, \mathcal{A}_{G,k}^1)$ also follows by Definition-Proposition 4.6.

Lastly, by Lemma 4.2 (6), classes of holomorphic forms are represented by invariant holomorphic forms. By definition, $\Phi_{\mathbb{C}}^{Y}$ maps these to holomorphic forms, which in particular are (1,0)-forms. \Box

Applying Lemma 3.8 to the objects $(\mathcal{N}_{X,D,n}^{\bullet}, H^1(G, \mathbb{R}), \overline{f}^* \circ \Phi_{\mathbb{R}}^Y, \overline{f}^* \circ \Phi_{\mathbb{C}}^Y, \overline{f}^* \circ \Psi^Y)$, which satisfy the assumptions of Lemma 4.1 by Corollary 4.9, we get a thickened mixed Hodge complex of sheaves. We describe this mixed Hodge complex of sheaves explicitly in the following definition.

Definition 4.10 (The thickened logarithmic Dolbeault mixed Hodge complex of sheaves). Let U be a smooth connected complex algebraic variety, let G be a complex semiabelian variety, and let $f: U \to G$ be an algebraic morphism, which extends to $\overline{f}: X \to Y$, where X, Y are compatible compactifications of U, G with respect to f as in Definition 2.40. Let $R_m := \frac{\prod_{j=0}^{\infty} \operatorname{Sym}^j H_1(G,k)}{\prod_{j=m}^{\infty} \operatorname{Sym}^j H_1(G,k)}$ and let $R_{-m} := \operatorname{Hom}_k(R_m, k)$ for all $m \geq 1$, and $k = \mathbb{R}, \mathbb{C}$.

Let $m \in \mathbb{Z} \setminus \{0\}$, and let $n \geq \max\{2, \dim_{\mathbb{R}} U\}$. We denote by $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$ the thickened mixed Hodge complex with real part

$$\left(\left(R_m\otimes_{\mathbb{R}}\mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D),d+\overline{f}^*\circ\Phi_{\mathbb{R}}^Y(\varepsilon_{\mathbb{R}})\right),W^n_{\cdot}\right),$$

complex part $\left(\left(R_m \otimes_{\mathbb{C}} \mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), d + \overline{f}^* \circ \Phi^Y_{\mathbb{C}}(\varepsilon_{\mathbb{C}})\right), W^n_{\bullet}, F^{\bullet}\right)$, and a filtered isomorphism

$$\alpha = e^{\overline{f}^* \circ \Psi^Y(\varepsilon_{\mathbb{C}})} : \left(\left(R_m \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d + \overline{f}^* \circ \Phi_{\mathbb{R}}^Y(\varepsilon_{\mathbb{R}}) \right) \otimes_{\mathbb{R}} \mathbb{C}, W^n_{\cdot} \right) \xrightarrow{\sim} \left(\left(\left(R_m \otimes_{\mathbb{C}} \mathcal{A}_{X,\mathbb{C}}^{\bullet}(\log D), d + \overline{f}^* \circ \Phi_{\mathbb{C}}^Y(\varepsilon_{\mathbb{C}}) \right), W^n_{\cdot} \right).$$

Here, W^n_{\cdot} denotes the tensor filtration of the weight filtration in R_m and the filtration W^n_{\cdot} of $\mathcal{A}^{\bullet}_{X,k}(\log D)$ from Definition-Proposition 2.72, and F^{\bullet} denotes the tensor filtration of the Hodge filtration in R_m and the filtration F^{\bullet} from Definition-Proposition 2.72.

Remark 4.11. Note that technically, applying Definition-Proposition 3.8 to the objects

$$(\mathcal{N}^{\bullet}_{X,D,n}, H^1(G, \mathbb{R}), \overline{f}^* \circ \Phi^Y_{\mathbb{R}}, \overline{f}^* \circ \Phi^Y_{\mathbb{C}}, \overline{f}^* \circ \Psi^Y)$$

yields a thickened mixed Hodge complex with four terms $(\mathcal{K}_0^{\bullet}, \mathcal{K}_1^{\bullet}, \mathcal{K}_2^{\bullet}, \mathcal{K}_3^{\bullet})$, but since two of the maps between them are the identity $(\mathcal{K}_0^{\bullet} = \mathcal{K}_1^{\bullet}, \mathcal{K}_2^{\bullet} = \mathcal{K}_3^{\bullet})$, we have simplified the notation in the definition above.

The maps defined in Definition-Proposition 4.8 satisfy the following functoriality.

Corollary 4.12. Suppose that we have a map of semiabelian varieties $g: G_1 \to G_2$. Let Y_2 be an allowed compactification of G_2 . Then, there exists an allowed compactification Y_1 of G_1 such that g extends to $\overline{g}: Y_1 \to Y_2$. Moreover, for every such allowed compactification Y_1 , the maps $(\Phi_{\mathbb{R}}^{Y_1}, \Phi_{\mathbb{C}}^{Y_1}, \Psi^{Y_1})$ and $(\Phi_{\mathbb{R}}^{Y_2}, \Phi_{\mathbb{C}}^{Y_2}, \Psi^{Y_2})$ are compatible in the sense that $\overline{g}^* \circ \Phi_{\mathbb{R}}^{Y_1} = \Phi_{\mathbb{R}}^{Y_2} \circ g^*$, $\overline{g}^* \circ \Phi_{\mathbb{C}}^{Y_1} = \Phi_{\mathbb{C}}^{Y_2} \circ g^*$ and $\overline{g}^* \circ \Psi^{Y_1} = \Psi^{Y_2} \circ g^*$.

Proof. Let $\overline{G_1}$ be a compactification of G_1 as in Corollary 2.38. We can obtain Y_1 as a resolution of singularities of the closure of the graph of g inside of $\overline{G_1} \times Y_2$.

Recall that by Proposition 2.4, g must preserve the Chevalley decomposition. By Lemma 4.2, $\Phi_{\mathbb{C}}^{Y_i}$ is completely determined by its restriction to $\Gamma(G_i, \Omega_{G_i}^{1, \text{inv}})$ and $H^1((G_i)_A, \mathbb{C})$, both seen as subspaces of $H^1(G_i, \mathbb{C})$. With the definition of $\Phi_{\mathbb{C}}^{G_i}$ from Definition-Proposition 4.6, it is straightforward to see that $g^* \circ \Phi_{\mathbb{C}}^{G_1} = \Phi_{\mathbb{C}}^{G_2} \circ g^*$. Hence, $\overline{g}^* \circ \Phi_{\mathbb{C}}^{Y_1} = \Phi_{\mathbb{C}}^{Y_2} \circ g^*$. In Definition-Proposition 4.8, $\Phi_{\mathbb{R}}^{Y_i}$ is defined as the real part of $\Phi_{\mathbb{C}}^{Y_i}$, so these are compatible as well. Finally, Ψ^{Y_i} is determined up to constants by the condition that it is a homotopy between $\Phi_{\mathbb{R}}^{Y_i}$ and $\Phi_{\mathbb{C}}^{Y_i}$, so it is uniquely determined if one requires that its image is composed of homomorphisms of \mathbb{R} -Lie groups $G_i \to \mathbb{C}$, and compatible with g. \Box

Example 4.13 (The case $G = \mathbb{C}^*$). Let $m \ge 1$, and let $n \ge \max\{2, \dim_{\mathbb{R}} U\}$. If $G = \mathbb{C}^*$, the R_{∞} -linear isomorphism of MHS $A_m : R_m(1-m) \to R_{-m}$ from Example 2.61 lifts to an isomorphism of mixed Hodge complexes of sheaves:

$$A_m \otimes \mathrm{Id} : (R_m \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))(1-m) \longrightarrow (R_{-m} \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)),$$

where (1-m) denotes a Tate twist. Indeed, the commutativity with the differentials is immediate: d leaves the first factor of the tensor product unchanged, and $\overline{f}^* \circ \Phi^Y(\varepsilon)$ acts on the first factor of the tensor product by multiplication by elements of R_{∞} , which commutes with A_m . The commutativity with the pseudo-morphism is also immediate because it leaves the first factor of the tensor product unchanged.

5. THICKENED LOGARITHMIC DOLBEAULT COMPLEXES AND LOCAL SYSTEMS

Let $f: U \to G$ be an algebraic morphism from a smooth variety to a semiabelian variety. Let $\Phi_{\mathbb{R}}^G$ be as in Definition-Proposition 4.6, let $m \in \mathbb{Z} \setminus \{0\}$ and let R_m as in Definition 2.20 (with \mathbb{R} coefficients throughout this section). Recall the definition of the twisted differential from DefinitionProposition 3.8. This section is devoted to showing that $(R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{\bullet}, d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}))$ is a resolution
of $R_m \otimes_R \overline{\mathcal{L}}$ (see Lemmas 5.8 and 5.9), explicitly defining the morphism that makes the former a
resolution of the latter (namely the one defined in Construction 5.4 below).

Construction 5.1 (Definition of $(\Phi_{\mathbb{R}}^G)^{\vee}$). Recall that $\Phi_{\mathbb{R}}^G$ is a map from $H^1(G, \mathbb{R})$ to $\Gamma(G, \mathcal{A}_{G,\mathbb{R}}^{1,\text{inv}})$ (extended in a unique way by $\Phi_{\mathbb{R}}^Y$ to logarithmic forms on Y), and recall that $\Gamma(G, \mathcal{A}_{G,\mathbb{R}}^{1,\text{inv}}) \cong \text{Hom}_{\mathbb{R}}(TG, \mathbb{R})$ by Lemma 4.2(1). Under this identification, we can consider its dual $(\Phi_{\mathbb{R}}^G)^{\vee}$ as a morphism

(5.2)
$$(\Phi^G_{\mathbb{R}})^{\vee} \colon TG \to H_1(G, \mathbb{R}).$$

Note that since $\Phi_{\mathbb{R}}^G$ is a section of the cohomology map, $(\Phi_{\mathbb{R}}^G)^{\vee}$ fixes $H_1(G,\mathbb{R}) \subset TG$. Furthermore, we will also use the notation $(\Phi_{\mathbb{R}}^G)^{\vee}$ to denote the map

(5.3)
$$(\Phi_{\mathbb{R}}^G)^{\vee} \colon TG \otimes_{\mathbb{R}} \mathcal{A}^0_{U,\mathbb{R}} \to H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} \mathcal{A}^0_{U,\mathbb{R}}$$

induced by $(\Phi_{\mathbb{R}}^G)^{\vee}$ in (5.2).

Recall from Remark 2.15 that a local \mathbb{R} -basis of \mathcal{L} at any point of U is given by lifts ι of f to TG, i.e. maps $\iota: U \to TG$ such that $\exp \circ \iota = f$. The sheaf $\overline{\mathcal{L}}$ is a local system of rank 1 free $\mathbb{R}[\pi_1(G)]$ -modules. Recall from Notation 2.16 that \mathcal{L} and $\overline{\mathcal{L}}$ are identified through the identity map $\mathcal{L} \to \overline{\mathcal{L}}$ that maps ι to $\overline{\iota}$, which is an R-antilinear isomorphism.

Recall that $R_{\infty} = \prod_{j=0}^{\infty} \operatorname{Sym}^{j} H_{1}(G, \mathbb{R})$ and $R := \mathbb{R}[\pi_{1}(G)]$. Moreover, recall Notation 2.21 and Definition 2.22.

Construction 5.4 (Definition of $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$). Let $m \in \mathbb{Z} \setminus \{0\}$. Let $\{\gamma_i\}$ be a basis of $\pi_1(G)$, so that $\{\log \gamma_i\}$ is a \mathbb{Z} -basis of $\Lambda = H_1(G, \mathbb{Z}) \subset TG$, and let $\{e_j\}$ be chosen so that $\{\log \gamma_i, e_j\}$ form an \mathbb{R} -basis of $TG \supset H_1(G, \mathbb{Z})$. Since they form a basis, any lift $\iota: U \to TG$ may be written as $\iota = \sum \log \gamma_i \otimes g_i + e_j \otimes h_j$ for some $g_i, h_j \in \mathcal{A}_{U,\mathbb{R}}^0$, so

$$\overline{\iota} = \sum \log \gamma_i \otimes g_i + e_j \otimes h_j.$$

Hence, we can see $\overline{\mathcal{L}}$ as a subsheaf of $TG \otimes_{\mathbb{R}} \mathcal{A}^0_{U,\mathbb{R}}$, and restrict $(\Phi^G_{\mathbb{R}})^{\vee}$ as in (5.3) to $\overline{\mathcal{L}}$.

Up to a sign, we postcompose $(\Phi_{\mathbb{R}}^G)^{\vee}$ as in (5.3) with the exponential map, to obtain the following:

$$e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}} \colon R_{m} \otimes_{R} \overline{\mathcal{L}} \subset R_{m} \otimes_{R} (TG \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{0}) \longrightarrow R_{m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{0} = R_{m} \otimes_{R_{\infty}} (R_{\infty} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{0})$$
$$\alpha \otimes \overline{\iota} = \alpha \left(\sum \log \gamma_{i} \otimes g_{i} + e_{j} \otimes h_{j} \right) \longmapsto \alpha e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}(\overline{\iota})}$$
$$= \alpha \sum_{k=0}^{\infty} \frac{1}{k!} \left(-\sum_{i} \log \gamma_{i} \otimes g_{i} - \sum_{j} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{j}) \otimes h_{j} \right)^{k}$$

Note that the product of k many elements in $H_1(G, \mathbb{R}) \otimes \mathcal{A}_{U,\mathbb{R}}^0$ is an element of $\operatorname{Sym}^k H_1(G, \mathbb{R}) \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0 \subset R_{\infty} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$, so, since R_m is an R_{∞} -module, it makes sense to multiply $\alpha \in R_m$ by the elements in the first factor of the tensor product of $\frac{1}{k!} \left(-\sum_i \log \gamma_i \otimes g_i - \sum_j (\Phi_{\mathbb{R}}^G)^{\vee}(e_j) \otimes h_j \right)^k$ for all k.

Proposition 5.5. The map $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ defined in Construction 5.4 is well-defined on the tensor product (over R), and is R-linear.

Proof. Let us show that the above formula is well-defined on the tensor product (over R). The same reasoning will show us that $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is R-linear.

Recall that R acts on $\overline{\mathcal{L}}$ by letting $\gamma_0 \in \pi_1(G)$ act by translation by γ_0^{-1} , that is, $\gamma_0 \cdot \overline{\iota} = \overline{\gamma_0^{-1} \cdot \iota}$, which corresponds with postcomposing $\overline{\iota}$ with translation by $-\log \gamma_0 = \log \gamma_0^{-1}$ (namely the element in $H_1(G, \mathbb{Z}) \subset TG$ corresponding to $\gamma_0 \in \pi_1(G)$). Furthermore, R is embedded in R_∞ by the ring $\gamma \mapsto e^{\log \gamma}$ of Definition 2.22. Hence, we need to show that for any $\gamma \in R$, the image of $e^{\log \gamma} \alpha \otimes \overline{\iota}$ equals the image of $\alpha \otimes \gamma \cdot \overline{\iota}$. It is enough to check this for $\gamma_0 \in \pi_1(G)$, since R is generated by $\pi_1(G)$. With the above notations:

(5.6)

$$\alpha e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}(\gamma_{0},\overline{\iota})} = \alpha e^{-(\Phi_{\mathbb{R}}^{G})^{\vee} \left(-\log\gamma_{0}\otimes 1 + \sum\log\gamma_{i}\otimes g_{i} + e_{j}\otimes h_{j}\right)}$$

$$= \alpha \exp\left(\log\gamma_{0}\otimes 1 - \sum_{i}\log\gamma_{i}\otimes g_{i} - \sum_{j}(\Phi_{\mathbb{R}}^{G})^{\vee}(e_{j})\otimes h_{j}\right)$$

$$= \alpha e^{\log\gamma_{0}}e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}\overline{\iota}}.$$

Proposition 5.7. Let $\{\log \gamma_i, e_j\}$ be an \mathbb{R} -basis of TG, where $\{\log \gamma_i\}$ is the \mathbb{Z} -basis of $H_1(G, \mathbb{Z})$ corresponding to a basis $\{\gamma_i\}$ of $\pi_1(G)$. Let $\{\log \gamma_i^{\vee}, e_j^{\vee}\}$ be its dual basis. Suppose a locally defined $\overline{\iota} \in \overline{\mathcal{L}}$ is given by $\overline{\iota} = \sum_i \log \gamma_i \otimes g_i + \sum_j e_j \otimes h_j \in TG \otimes_{\mathbb{R}} \mathcal{A}^0_{U,\mathbb{R}}$. Then,

• All the 1-forms dg_i and dh_j are the pullback of invariant 1-forms on G, namely:

$$dg_i = f^* \log \gamma_i^{\vee}, \quad dh_j = f^* e_j^{\vee}$$

where $\log \gamma_i^{\vee}, e_j^{\vee} : TG \to \mathbb{R}$ are seen in $\Gamma(G, \mathcal{A}_{G,\mathbb{R}}^{1,\mathrm{inv}})$ through the isomorphism described in Lemma 4.2(1).

• For every j, the function h_j is the composition of f with the (globally defined) unique differentiable homomorphism $G \to \mathbb{R}$ mapping $\exp(e_j)$ to 1 and the rest of the elements of $\{\exp(e_l)\}$ to 0.

Proof. Let us start with the first statement. Let V be the open set in U such that $\overline{\iota}$ is a map from V to TG. By definition of the dual basis, for all $x \in V$ we have that

$$g_i(x) = \langle (\log \gamma_i)^{\vee}, \overline{\iota}(x) \rangle; \quad h_j(x) = \langle (e_j)^{\vee}, \overline{\iota}(x) \rangle$$

In any small neighborhood of $\exp(\overline{\iota}(x))$ in G, we can define $a_i, b_j : G \to \mathbb{R}$ such that $a_i \circ \exp = (\log \gamma_i)^{\vee}$ and $b_j \circ \exp = e_j^{\vee}$. Hence, locally we have that $g_i = f^*(a_i)$, and $h_j = f^*(b_j)$ in a neighborhood of x. Thus, $dg_i = f^*(da_i)$, and $dh_j = f^*(db_j)$. Note that $\exp^* da_i = d((\log \gamma_i)^{\vee})$ is a constant 1-form on

TG. The identification $\operatorname{Hom}_{\mathbb{R}}(TG,\mathbb{R}) \cong \mathcal{A}_{G,\mathbb{R}}^{1,\operatorname{inv}}$ from Lemma 4.2(1) implies that $da_i = (\log \gamma_i)^{\vee}$ (seen as an element of $\mathcal{A}_{G,\mathbb{R}}^{1,\operatorname{inv}}$) and similarly, $db_j = e_j^{\vee}$. This concludes the proof of the first statement.

For the second statement, we just need to see that b_j is defined globally, and that it coincides with the homomorphism $G \to \mathbb{R}$ described. Note b_j is defined globally because e_j^{\vee} is invariant by the action of $\log \gamma_i$. Since $b_j \circ \exp = e_j^{\vee}$ and \exp is a surjective homomorphism, b_j is a group homomorphism which takes $\exp(e_j)$ to 1 and the image of \exp of the rest of the elements of the basis $\{\log \gamma_i, e_l\}$ to 0.

Lemma 5.8. For any $m \in \mathbb{Z} \setminus \{0\}$, the complex $(R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{\bullet}, d+f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}))$ has non-zero cohomology only in degree 0. The kernel of the differential in degree 0 a local system of R_{∞} -modules whose stalks are isomorphic to R_m .

Proof. We will show that locally there is an isomorphism between $(R_m \otimes_{\mathbb{R}} \mathcal{A}^{\bullet}_{U,\mathbb{R}}, d + f^* \circ \Phi^G_{\mathbb{R}}(\varepsilon_{\mathbb{R}}))$ and $(R_m \otimes_{\mathbb{R}} \mathcal{A}^{\bullet}_{U,\mathbb{R}}, d)$. Let us consider a simply connected open set V of U. Over such an open set, all closed forms are exact, and in particular the restriction to V of the image of $f^* \circ \Phi^G_{\mathbb{R}} \colon H^1(G, \mathbb{R}) \to \Gamma(U, \mathcal{A}^1_{U,\mathbb{R}})$ consists of exact forms. Let $h \colon H^1(G, \mathbb{R}) \to \Gamma(V, \mathcal{A}^0_{V,\mathbb{R}})$ be a linear map such that $d \circ h = (f^* \circ \Phi^G_{\mathbb{R}})|_V$. Applying Lemma 2.50, multiplication by $e^{h(\varepsilon_{\mathbb{R}})}$ is an isomorphism:

$$(R_m \otimes_{\mathbb{R}} \mathcal{A}_{V,\mathbb{R}}^{\bullet}, d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})) \cong (R_m \otimes_{\mathbb{R}} \mathcal{A}_{V,\mathbb{R}}^{\bullet}, d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}) - (d \circ h)(\varepsilon_{\mathbb{R}}) + [h(\varepsilon_{\mathbb{R}}), f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})]).$$

Note that $h(\varepsilon_{\mathbb{R}})$ and $f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})$ commute because they are elements of a cdga, so the differential on the right hand side above is simply d. Note that $(\mathcal{A}_{V,\mathbb{R}}^{\bullet}, d)$ is a complex of acyclic sheaves (with respect to the global sections functor) which resolves the trivial local system \mathbb{R}_V (see [25, p. 127], for example). This shows that $(R_m \otimes_{\mathbb{R}} \mathcal{A}_{V,\mathbb{R}}^{\bullet}, d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}))$ is isomorphic to the resolution of a trivial local system with stalk R_m , which is exact in all places except for degree 0, as desired.

Lemma 5.9. The morphism $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ defined as in Construction 5.4 is an isomorphism onto the kernel of

$$d + f^* \circ \Phi^G_{\mathbb{R}}(\varepsilon_{\mathbb{R}}) : R_m \otimes_{\mathbb{R}} \mathcal{A}^0_{U,\mathbb{R}} \to R_m \otimes_{\mathbb{R}} \mathcal{A}^1_{U,\mathbb{R}}$$

Proof. Let us start by proving that $d \circ e^{-(\Phi_{\mathbb{R}}^G)^{\vee}} = -(f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})) \circ e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$, which will show that the image of $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is contained in the kernel of $d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})$. Let $\{e_i\}$ be an \mathbb{R} -basis of TG and let $\{e_i^{\vee}\}$ be its dual basis. Let $\overline{\iota} = \sum e_i \otimes h_i$ be a local generator of $\overline{\mathcal{L}}$. We must compute $d(e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}(\overline{\iota}))$, i.e.

$$d(e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}}(\overline{\iota})) = d\left(e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}(\overline{\iota})}\right)$$
$$= d\left(\sum_{k=0}^{\infty} \frac{1}{k!} \left(-\sum_{i} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{i}) \otimes h_{i}\right)^{k}\right)$$
$$= \sum_{k=1}^{\infty} \frac{1}{(k-1)!} \left(-\sum_{i} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{i}) \otimes h_{i}\right)^{k-1} \left(-\sum_{i} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{i}) \otimes dh_{i}\right)$$
$$= \left(-\sum_{i} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{i}) \otimes dh_{i}\right) \cdot e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}}(\overline{\iota})$$

Using Proposition 5.7, $dh_i = f^*(e_i^{\vee})$. Finally, note that if $\{s_j\}$ is an \mathbb{R} -basis of $H_1(G, \mathbb{R})$, and $\{s_j^{\vee}\}$ is its dual basis, then

$$-\sum_{i} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{i}) \otimes f^{*}(e_{i}^{\vee}) = -\operatorname{Id} \otimes f^{*} \left(\sum_{i} (\Phi_{\mathbb{R}}^{G})^{\vee}(e_{i}) \otimes e_{i}^{\vee} \right)$$
$$= -\operatorname{Id} \otimes f^{*} \left(\sum_{j} s_{j} \otimes \Phi_{\mathbb{R}}^{G}(s_{j}^{\vee}) \right) = -f^{*} \circ \Phi_{\mathbb{R}}^{G}(\varepsilon_{\mathbb{R}}).$$

So indeed the image of $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is contained in the desired kernel.

Using Lemma 5.8, we know that the kernel of d is a local system, of the same real dimension as R_m . To show $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is an isomorphism onto the kernel, we only need to prove that $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is either injective or surjective on stalks, since we know the dimensions agree.

The stalks of ker $d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}) \subset R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$ are finitely generated $R_{|m|}$ -modules. If m > 0, Nakayama's Lemma implies that one can show that $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is surjective on stalks by taking the quotient by the maximal ideal of R_m , reducing to the case m = 1 (which is clear, the complex is just $(\mathcal{A}_{U,\mathbb{R}}^{\bullet}, d)$). If m < 0, we can show that $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is injective by noting that $R_{-1} \subset R_m$ is contained in every non-zero sub R_{-m} -module of R_m . Therefore, to show that $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ is injective, it is enough to show that, identifying the stalk with R_m , the kernel of $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ intersects R_{-1} trivially, which is again clear.

Remark 5.10. Let $m \ge 1$ and suppose that $G = \mathbb{C}^*$. The isomorphism $A_m : R_m \to R_{-m}$ from Example 2.61 extends to an R_{∞} -linear isomorphism

$$A_m \otimes_{\mathbb{R}} \operatorname{Id}_{\overline{\mathcal{L}}} : R_m \otimes_R \overline{\mathcal{L}} \to R_{-m} \otimes_R \overline{\mathcal{L}}.$$

Moreover, it is immediate from the definition of $e^{-(\Phi_{\mathbb{R}}^{\mathbb{C}^*})^{\vee}}$ that

$$\left(A_m \otimes_{\mathbb{R}} \operatorname{Id}_{\mathcal{A}_{U,\mathbb{R}}^0}\right) \circ e^{-(\Phi_{\mathbb{R}}^{\mathbb{C}^*})^{\vee}} : R_m \otimes_R \overline{\mathcal{L}} \to R_{-m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$$

coincides with

$$e^{-(\Phi_{\mathbb{R}}^{\mathbb{C}^*})^{\vee}} \circ \left(A_m \otimes_{\mathbb{R}} \mathrm{Id}_{\overline{\mathcal{L}}}\right)$$

6. Mixed Hodge structures

6.1. The MHS on $H^j(U, R_m \otimes_R \overline{\mathcal{L}})$. Let $f : U \to G$ be an algebraic morphism between a smooth complex connected algebraic variety U and a semiabelian variety G. Let X and Y be compatible compactifications of U and G with respect to f as in Definition 2.40, let $j : U \to X$ be the inclusion, and let $D := X \setminus U$. Note that

$$(R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{\bullet}, d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})) = j^{-1} \left(R_m \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d + \overline{f}^* \circ \Phi_{\mathbb{R}}^Y(\varepsilon_{\mathbb{R}}) \right),$$

where $\overline{f}: X \to Y$ extends f and $\Phi_{\mathbb{R}}^{Y}$ is as in Definition-Proposition 4.8. Hence,

$$Rj_*(R_m \otimes_R \overline{\mathcal{L}}) \cong Rj_*j^{-1}\left(R_m \otimes_{\mathbb{R}} \mathcal{A}^{\bullet}_{X,\mathbb{R}}(\log D), d + \overline{f}^* \circ \Phi^Y_{\mathbb{R}}(\varepsilon_{\mathbb{R}})\right).$$

In this case, the adjunction $\mathrm{Id} \to Rj_*j^{-1}$ applied to the complex of sheaves

$$\left(R_m \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d + \overline{f}^* \circ \Phi_{\mathbb{R}}(\varepsilon_{\mathbb{R}})\right),$$

which is the real part of the thickened logarithmic Dolbeault mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$ from Definition 4.10, is an isomorphism in the derived category by Proposition 2.70 and Proposition 3.15 (see Remark 2.66).

In Section 5 we saw that the morphism

$$e^{-(\Phi_{\mathbb{R}}^G)^{\vee}} \colon R_m \otimes_R \overline{\mathcal{L}} \to \left(R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{\bullet}, d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}) \right)$$

is a quasi-isomorphism. The first goal of this section is to show that the mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$ endows $H^i(U, R_m \otimes_R \overline{\mathcal{L}})$ with an \mathbb{R} -MHS for all i, and to describe the map via which these MHS are induced.

Definition 6.1 (MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$). Let $f : U \to G$ be an algebraic morphism between a smooth complex connected algebraic variety U and a semiabelian variety G. Let Y be an allowed compactification of G, and let X be a good compactification of U such that f extends to $\overline{f} : X \to Y$. Let $D = X \setminus U$, let m > 0 and let $n \ge \max\{2, \dim_{\mathbb{R}} U\}$.

• Suppose that m < 0. The thickened logarithmic Dolbeault mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$ from Definition 4.10 endows $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ with a mixed Hodge structure via this sequence of isomorphisms in the derived category.

$$Rj_{*}(R_{m} \otimes_{R} \overline{\mathcal{L}}) \xrightarrow{Rj_{*}e^{-(\Phi_{\mathbb{R}}^{G})^{\vee}}} Rj_{*}(R_{m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{\bullet}, d+f^{*} \circ \Phi_{\mathbb{R}}^{G}(\varepsilon_{\mathbb{R}}))$$

$$\|$$

$$(R_{m} \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d+\overline{f}^{*} \circ \Phi_{\mathbb{R}}^{Y}(\varepsilon_{\mathbb{R}})) \xrightarrow{\text{adjunction}} Rj_{*}j^{-1}(R_{m} \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d+\overline{f}^{*} \circ \Phi_{\mathbb{R}}^{Y}(\varepsilon_{\mathbb{R}}))$$

• Suppose that m > 0. Let $e = \dim_{\mathbb{C}} H_1(G, \mathbb{C})$. The translated (as in Definition 2.62) thickened logarithmic Dolbeault mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))[e]$ endows $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ with a mixed Hodge structure via the same sequence of isomorphisms as in (3.11), but where every sheaf complex is shifted by e, namely

$$\begin{split} Rj_*(R_m \otimes_R \overline{\mathcal{L}})[e] \xrightarrow{Rj_*e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}} Rj_*(R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^{\bullet}, d+f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}}))[e] \\ \| \\ (R_m \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d+\overline{f}^* \circ \Phi_{\mathbb{R}}^Y(\varepsilon_{\mathbb{R}}))[e] \xrightarrow{\text{adjunction}} Rj_*j^{-1}(R_m \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^{\bullet}(\log D), d+\overline{f}^* \circ \Phi_{\mathbb{R}}^Y(\varepsilon_{\mathbb{R}}))[e] \end{split}$$

Remark 6.3. The shift when m is positive but not when m is negative might seem arbitrary in the previous definition, but it is not. Indeed, the case m negative will be used to endow quotients of the homology Alexander modules with MHS, and that MHS will be functorial (see Section 7) without the need for any shifts. However, the case when m is positive is related to the MHS on the torsion part of the cohomology Alexander modules defined in [15] in the case when $G = \mathbb{C}^*$ (see Remark 10.12 below), where the shift was needed to enjoy good functoriality properties (see[15, Theorem 6.1]). In any case, the focus of this paper is when m is negative.

Example 6.4 (The case $G = \mathbb{C}^*$). If $G = \mathbb{C}^*$, and $m \ge 1$, the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ and $H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}})$ from Definition 6.1 are related as follows: Let $A_m : R_m \to R_{-m}$ be the R_{∞} -linear identification from Example 2.61. The isomorphism $A_m \otimes \operatorname{Id}_{\overline{\mathcal{L}}} : R_m \otimes_R \overline{\mathcal{L}} \to R_{-m} \otimes_R \overline{\mathcal{L}}$ from Remark 5.10 lifts (by the commutativity with $e^{-(\Phi_{\mathbb{R}}^{\mathbb{C}^*})^{\vee}}$ explained therein) to the isomorphism of mixed Hodge complexes of sheaves $A_m \otimes \operatorname{Id} : (R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))(1-m) \longrightarrow (R_{-m} \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$ from Example 4.13. By Remarks 2.60 and 2.63, A_m induces the following isomorphism of MHS

$$H^{j}(A_{m} \otimes \operatorname{Id}_{\overline{\mathcal{L}}}) : H^{j}(U, R_{m} \otimes_{R} \overline{\mathcal{L}})(2-m) \to H^{j}(U, R_{-m} \otimes_{R} \overline{\mathcal{L}}),$$

where (2-m) denotes the 2-m-th Tate twist.

In Section 6.2 we will see that the previous definition is independent of the choice of n and compactifications. Before that, let us show some properties of the MHS from Definition 6.1 while assuming the independence of those choices.

Remark 6.5 (The pro-MHS on $H^*(U, R_{\infty} \otimes_R \overline{\mathcal{L}})$). Let m' > m > 0. In that case, the projection morphism $p_{m',m} \colon R_{m'} \to R_m$ is a mixed Hodge structure morphism which is R_{∞} -linear, which induces a projection $p_{m',m} \otimes \text{Id} \colon R_{m'} \otimes_R \overline{\mathcal{L}} \to R_m \otimes_R \overline{\mathcal{L}}$. This morphism extends via $e^{-(\Phi_R^G)^{\vee}}$ and the morphisms in Definition 6.1 to a morphism of mixed Hodge complexes of sheaves (that is, a morphism between the corresponding complexes of sheaves respecting the filtrations and the pseudo-morphism):

$$p_{m',m} \otimes \mathrm{Id} \colon (R_{m'} \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)) \to (R_m \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)).$$

In particular, $p_{m',m}$ induces a MHS morphism

$$H^*(U, R_{m'} \otimes_R \overline{\mathcal{L}}) \to H^*(U, R_m \otimes_R \overline{\mathcal{L}}).$$

By Proposition 2.28, taking the inverse limit for m > 0, one obtains a pro-MHS on $H^*(U, R_\infty \otimes_R \overline{\mathcal{L}})$.

(6.2)

Remark 6.6 (The pro-MHS on $R_{\infty} \otimes_R H_*(U, \mathcal{L})$). Let m' > m > 0. In that case, the dual $p_{m',m}^{\vee} \colon R_{-m} \hookrightarrow R_{-m'}$ of projection morphism $p_{m',m}$ from Remark 6.5 is also mixed Hodge structure morphism which is R_{∞} -linear, which induces an inclusion $p_{m',m}^{\vee} \otimes \operatorname{Id} \colon R_{-m} \otimes_R \overline{\mathcal{L}} \to R_{-m'} \otimes_R \overline{\mathcal{L}}$. Note that, by Remark 2.26, dualizing this inclusion (over \mathbb{R}) yields the projection

$$p_{m',m} \otimes \mathrm{Id} \colon R_{m'} \otimes_R \mathcal{L} \to R_m \otimes_R \mathcal{L}.$$

The morphism $p_{m',m}^{\vee} \otimes \text{Id}$ extends via $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ and the morphisms in Definition 6.1 to a morphism of mixed Hodge complexes of sheaves:

$$p_{m',m}^{\vee} \otimes \operatorname{Id} \colon (R_{-m} \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)) \to (R_{-m'} \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)).$$

In particular, $p_{m',m}^{\vee}$ induces a MHS morphism

$$H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}}) \to H^*(U, R_{-m'} \otimes_R \overline{\mathcal{L}}).$$

If $\operatorname{Hom}_{\mathbb{R}}(H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}}, \mathbb{R}))$ is endowed with the dual MHS, these morphisms endow their limit $\varprojlim_m \operatorname{Hom}_{\mathbb{R}}(H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}}, \mathbb{R}))$ with a pro-MHS. By Corollary 2.30, this endows $R_{\infty} \otimes_R H_*(U, \mathcal{L})$ with a pro-MHS. In fact, using and using the isomorphism $\operatorname{Hom}_{\mathbb{R}}(H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}}), \mathbb{R}) \cong H_*(U, R_m \otimes_R \mathcal{L})$ from Remark 2.26, we see that the dual of the MHS morphism induced by $p_{m',m}^{\vee}$ in cohomology is the morphism induced in homology by $p_{m',m} \otimes \operatorname{Id} : R_{m'} \otimes_R \mathcal{L} \to R_m \otimes_R \mathcal{L}$. With this interpretation, the pro-MHS on $R_{\infty} \otimes_R H_*(U, \mathcal{L})$ is given by the isomorphism $R_{\infty} \otimes_R H_*(U, \mathcal{L}) \cong \varprojlim_m H_*(U, R_m \otimes_R \mathcal{L})$ and the morphisms induced in homology by the projections $p_{m',m} \otimes \operatorname{Id} : R_{m'} \otimes_R \mathcal{L} \to R_m \otimes_R \mathcal{L}$.

Remark 6.7. Let $m \in \mathbb{Z} \setminus \{0\}$. The action of $H_1(G, \mathbb{R}) \subset R_{\infty}$ on R_m induces a multiplication morphism

(6.8)
$$H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} (R_m \otimes_R \overline{\mathcal{L}}) \to R_m \otimes_R \overline{\mathcal{L}}.$$

Since the morphism $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}} : R_m \otimes_R \overline{\mathcal{L}} \to \ker(d + f^* \circ \Phi_{\mathbb{R}}^G(\varepsilon_{\mathbb{R}})) \subset R_m \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$ from Construction 5.4 is R_{∞} -linear, the multiplication morphism from (6.8) extends to a morphism of mixed Hodge complexes of sheaves

$$H_1(G,\mathbb{R}) \otimes (R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)) \to (R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$$

for any $n \ge \max\{2, \dim_{\mathbb{R}} U\}$ by Proposition 3.12. Therefore, the multiplication morphism (6.8) induces a MHS morphism for every $m \in \mathbb{Z} \setminus \{0\}$:

$$H_1(G,\mathbb{R})\otimes H^*(U,R_m\otimes_R\overline{\mathcal{L}})\to H^*(U,R_m\otimes_R\overline{\mathcal{L}}).$$

By Proposition 2.28 and Remark 6.5, taking the inverse limit for m > 0, one obtains a pro-MHS morphism replacing m by ∞ .

Remark 6.9. Let m > 0. Since the \mathbb{R} -dual of multiplication by elements of $H_1(G, \mathbb{R})$ in an R_{∞} -module is multiplication by elements of $H_1(G, \mathbb{R})$, the fact that the multiplication map

$$H_1(G,\mathbb{R})\otimes_{\mathbb{R}} H^*(U,R_{-m}\otimes_R \overline{\mathcal{L}}) \to H^*(U,R_{-m}\otimes_R \overline{\mathcal{L}})$$

from Remark 6.7 is a MHS morphism implies that the multiplication map

$$H_1(G,\mathbb{R})\otimes_{\mathbb{R}} \operatorname{Hom}_{\mathbb{R}}(H^*(U,R_{-m}\otimes_R \overline{\mathcal{L}}),\mathbb{R}) \to \operatorname{Hom}_{\mathbb{R}}(H^*(U,R_{-m}\otimes_R \overline{\mathcal{L}}),\mathbb{R})$$

is also a MHS morphism, where $\operatorname{Hom}_{\mathbb{R}}(H^*(U, R_{-m} \otimes_R \overline{\mathcal{L}}), \mathbb{R})$ is endowed with the dual MHS. This can be easily checked using the definition of the tensor and dual MHS from Definition-Proposition 2.52. By Remark 6.6, taking the inverse limit for m > 0 one obtains a pro-MHS morphism

$$H_1(G,\mathbb{R})\otimes_{\mathbb{R}} (R_\infty\otimes_R H_*(U,\mathcal{L})) \to R_\infty\otimes_R H_*(U,\mathcal{L}).$$

Remark 6.10 (Multiplication by elements of $H_1(G, \mathbb{R})$ if $G \cong (\mathbb{C}^*)^n$). Suppose that $G \cong (\mathbb{C}^*)^n$, in which case $H_1(G, \mathbb{R})$ is pure of type (-1, -1). Let $a \in H_1(G, \mathbb{R})$ be a non-zero element. Since the span of a is a sub-MHS of $H_1(G, \mathbb{R})$, Remark 6.7 implies that multiplication by a is a MHS morphism

$$a: H^*(U, R_m \otimes_R \overline{\mathcal{L}}) \to H^*(U, R_m \otimes_R \overline{\mathcal{L}})(-1)$$

for every $m \in \mathbb{Z} \setminus \{0\}$, where (-1) denotes the Tate twist. By Proposition 2.28 and Remark 6.5, taking the inverse limit for m > 0, one obtains a pro-MHS morphism replacing m by ∞ . Similarly, Remarks 6.6 and 6.9 imply that

$$a: R_{\infty} \otimes_R H^*(U, \mathcal{L}) \to R_{\infty} \otimes_R H^*(U, \mathcal{L})(-1)$$

is a pro-MHS morphism.

6.2. Independence of the choices. Note that there are some choices involved in Definition 6.1, namely the choice of compactifications, the number $n \ge \max\{2, \dim_{\mathbb{R}} U\}$ and the choice of the maps $\Phi_{\mathbb{R}}^G$, $\Phi_{\mathbb{C}}^G$ and Ψ^G . Note that the choice of the maps $\Phi_{\mathbb{R}}^G$, $\Phi_{\mathbb{C}}^G$ and Ψ^G was canonical, so we will not attempt to modify those. However, it is important that the MHS in Definition 6.1 does not depend on compactifications or on n. This section shows this.

Lemma 6.11 (Independence of *n*). Under the same notation as in Definition 6.1, the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ endowed by the mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$ does not depend on the choice of $n \geq \max\{2, \dim_{\mathbb{R}} U\}$.

Proof. Let $n' \ge n \ge \max\{2, \dim_{\mathbb{R}} U\}$. The identity map induces a morphism of complexes of sheaves (as in [37, Definition 3.16])

$$(R_m \otimes \mathcal{N}^{\bullet}_{X,D}(n'), d + \overline{f}^* \circ \Phi^Y(\varepsilon)) \to (R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon)).$$

Since the identity is a quasi-isomorphism, this is what is called a weak equivalence, which induces isomorphisms of MHS in hypercohomology (see [37, Lemma-Definition 3.19]).

Lemma 6.12 (Independence of the compactification of U, fixing the compactification of G). Let Y be an allowed compactification of G. Let X_1 and X_2 be two good compactifications of U such that $f: U \to G$ extends to algebraic maps $\overline{f}_1: X_1 \to Y$ and $\overline{f}_2: X_2 \to Y$. Let D_i be the simple normal crossings divisor $X_i \setminus U$ for i = 1, 2. Then, the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ induced by $(R_m \otimes \mathcal{N}^{\bullet}_{X_1, D_1, n}, d + (\overline{f}_1)^* \circ \Phi^Y(\varepsilon))$ coincides with the MHS induced by $(R_m \otimes \mathcal{N}^{\bullet}_{X_2, D_2, n}, d + (\overline{f}_2)^* \circ \Phi^Y(\varepsilon))$ for all $m \in \mathbb{Z} \setminus \{0\}$.

Proof. Let Z be a good compactification of U obtained as a resolution of singularities of the closure of the diagonal $U \to U \times U$ in $X_1 \times X_2$. Then, there exist algebraic maps $\pi^i : Z \to X_i$ for i = 1, 2. Let $D = Z \setminus U$. It is enough to show that the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ induced by $(R_m \otimes \mathcal{N}^{\bullet}_{X_1, D_1, n}, d + (\overline{f_1})^* \circ \Phi^Y(\varepsilon))$ coincides with the MHS induced by $(R_m \otimes \mathcal{N}^{\bullet}_{Z, D, n}, d + (\overline{f_1} \circ \pi^1)^* \circ \Phi^Y(\varepsilon))$.

The proof follows the same steps as [15, Theorem 5.21], so we omit some details. The pullback of forms through π^1 induces a morphism

$$\mathcal{N}^{\bullet}_{X_1,D_1,n} \to (\pi^1)_* \mathcal{N}^{\bullet}_{Z,D,n}$$

which respects the filtrations). Although $(\pi^1)_* \mathcal{N}_{Z,D,n}^{\bullet}$ is not a mixed Hodge complex of sheaves, the proof of Proposition 3.16 implies that the morphism $\mathcal{N}_{X_1,D_1,n}^{\bullet} \to (\pi^1)_* \mathcal{N}_{Z,D,n}^{\bullet}$ extends to the thickenings by $(\overline{f}_1)^* \circ \Phi^Y(\varepsilon)$ and $(\overline{f}_1 \circ \pi^1)^* \circ \Phi^Y(\varepsilon)$, respecting the filtrations. Composing with $(\pi^1)_*$ of the canonical map from the mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}_{Z,D,n}^{\bullet}, d + (\overline{f}_1 \circ \pi^1)^* \circ \Phi(\varepsilon))$ into its Godement resolution, we obtain a morphism of mixed Hodge complexes of sheaves

$$(R_m \otimes \mathcal{N}^{\bullet}_{X_1, D_1, n}, d + (\overline{f}_1)^* \circ \Phi(\varepsilon)) \to R(\pi^1)_*(R_m \otimes \mathcal{N}^{\bullet}_{Z, D, n}, d + (\overline{f}_1 \circ \pi^1)^* \circ \Phi(\varepsilon)),$$

where the latter is a mixed Hodge complex of sheaves. If we restrict to U, the map between these mixed Hodge complexes of sheaves is just the map from the analytic forms on U (real or complex) to its Godement resolution. Hence, this map induces the identity between the cohomology of $R_m \otimes_R \overline{\mathcal{L}}$ itself, which concludes the proof.

Lemma 6.13 (Independence of the compactification of G, fixing the compactification of U). Let Y_i be an allowed compactification of G for i = 1, 2. Suppose that X is a good compactifications of U such that $f: U \to G$ extends to algebraic maps $\overline{f}_1: X \to Y_1$ and $\overline{f}_2: X \to Y_2$. Let D be the simple normal crossings divisor $X \setminus U$. Then, the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ induced by $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d+(\overline{f}_1)^* \circ \Phi^{Y_1}(\varepsilon))$ coincides with the MHS induced by $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d+(\overline{f}_2)^* \circ \Phi^{Y_2}(\varepsilon))$.

Proof. First, we find an allowed compactification Y of G such that there exist algebraic maps $\pi^i : Y \to Y_1$, as in the first sentence of the proof of Lemma 6.12. Now, take Z a good compactification of U obtained by doing a resolution of singularities of the closure of the graph of $f: U \to G$ inside of $X \times Y$. Let $\widehat{D} := Z \setminus U$. We get an algebraic map $p: Z \to X$, and f extends to $\overline{f}: Z \to Y$. Hence, it suffices to show that the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ induced by $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + (\overline{f_1})^* \circ \Phi^{Y_1}(\varepsilon))$ coincides with the MHS induced by $(R_m \otimes \mathcal{N}^{\bullet}_{Z,\widehat{D},n}, d + \overline{f}^* \circ \Phi^Y(\varepsilon))$.

Note that $(\pi^1 \circ \overline{f})^* \circ \Phi_k^{Y_1} = (\overline{f})^* \circ \Phi_k^Y$ for $k = \mathbb{R}, \mathbb{C}$ (both are extensions of $f^* \circ \Phi_k^G$). By Lemma 6.12, the mixed Hodge complex of sheaves $(R_m \otimes \mathcal{N}_{Z,\widehat{D},n}^{\bullet}, d + (\pi^1 \circ \overline{f})^* \circ \Phi^{Y_1}(\varepsilon))$ induces the same MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ as $(R_m \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + (\overline{f}_1)^* \circ \Phi^{Y_1}(\varepsilon))$.

Theorem 6.14 (Independence of the compactifications of G and U). Let Y_i be an allowed compactification of G, and let X_i be a good compactification of U such that f extends to $\overline{f_i} : X_i \to Y_i$, for i = 1, 2. Let $D_i = X_i \setminus U$. Then, the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ endowed by $(R_m \otimes \mathcal{N}^{\bullet}_{X,D,n}, d + (\overline{f_i})^* \circ \Phi^{Y_i}(\varepsilon))$ is the same for i = 1, 2.

Proof. This follows from Lemmas 6.12 and 6.13 by finding suitable compactifications lying above the ones given, using the same methods for doing so as in the proof of these two lemmas (resolution of singularities of the closure of the diagonal of U or of G).

6.3. The MHS on quotients of Alexander modules. In this section, we obtain other MHS from the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ given Definition 6.1.

Corollary 6.15. Let \mathfrak{a} be the maximal ideal of R_{∞} . For every $m \in \mathbb{Z} \setminus \{0\}$ and every $m' \in \mathbb{Z} \ge 0$, $\mathfrak{a}^{m'}H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ is a sub-MHS of $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$, and similarly replacing m by ∞ . Therefore, the quotients by

$$\frac{H^*(U, R_m \otimes_R \mathcal{L})}{\mathfrak{a}^{m'} H^*(U, R_m \otimes_R \overline{\mathcal{L}})}$$

are quotient MHS's as well.

Proof. Note that $\mathfrak{a}^{m'}H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ is the image of the map in Remark 6.7 composed with itself m' times:

$$(H_1(G,\mathbb{R}))^{\otimes m'} \otimes H^*(U,R_m \otimes_R \overline{\mathcal{L}}) \to (H_1(G,\mathbb{R}))^{\otimes (m'-1)} \otimes H^*(U,R_m \otimes_R \overline{\mathcal{L}}) \to \cdots$$

The proof for $m = \infty$ follows from Remark 6.7 and Remark 2.56.

Corollary 6.16. The MHS in Definition 6.1 induces the following two sequences of MHS for $m \in \mathbb{Z}_{\geq 0}$:

 $R_m \otimes_R H^i(U, \overline{\mathcal{L}}); \quad R_m \otimes_R H_i(U, \mathcal{L}).$

The latter MHS induces through the R-module isomorphism $H_i(U^f, \mathbb{R}) \cong H_i(U, \mathcal{L})$ from Remark 2.13 a MHS on $R_m \otimes_R H_i(U^f, \mathbb{R})$.

Moreover, the quotient maps induced by $R_{m'} \rightarrow R_m$ for all $m' \geq m$ between these are MHS morphisms.

Proof. By Remarks 2.23, 2.24 and 2.26, and Corollaries 2.29 and 2.30, we have the following R_{∞} -module isomorphisms:

$$R_{\infty} \otimes_{R} H^{i}(U, \overline{\mathcal{L}}) \cong \varprojlim_{m} H^{i}(U, R_{m} \otimes_{R} \overline{\mathcal{L}});$$

$$R_{\infty} \otimes_{R} H_{i}(U, \mathcal{L}) \cong \varprojlim_{m} H_{i}(U, R_{m} \otimes_{R} \mathcal{L}) \cong \varprojlim_{m} \operatorname{Hom}_{\mathbb{R}}(H^{i}(U, R_{-m} \otimes_{R} \overline{\mathcal{L}}), \mathbb{R}).$$

These isomorphisms endow the right hand side spaces with pro-MHS by Remarks 6.5 and 6.6. Furthermore, by Remarks 6.7 and 6.9, the multiplication maps

$$H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} (R_\infty \otimes_R H^i(U,\overline{\mathcal{L}})) \to R_\infty \otimes_R H^i(U,\overline{\mathcal{L}}) H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} (R_\infty \otimes_R H_i(U,\mathcal{L})) \to R_\infty \otimes_R H_i(U,\mathcal{L})$$

are pro-MHS morphisms. By Remark 2.56, the images and cokernels of the composition of pro-MHS morphisms are pro-mixed Hodge structures as well. In particular, $R_m \otimes_R H^i(U, \overline{\mathcal{L}})$ and $R_m \otimes_R H_i(U, \mathcal{L})$ are pro-MHS, but they are also finite dimensional vector spaces, so they must be MHS.

For the "moreover" part of the statement, note that the quotient maps

$$R_{m'} \otimes_R H^i(U, \mathcal{L}) \to R_m \otimes_R H^i(U, \mathcal{L})$$
$$R_{m'} \otimes_R H_i(U, \mathcal{L}) \to R_m \otimes_R H_i(U, \mathcal{L})$$

induced by $R_{m'} \twoheadrightarrow R_m$ for all $m' \ge m$ are induced in the quotients by the identity morphisms in $R_{\infty} \otimes_R H^i(U, \overline{\mathcal{L}})$ and $R_{\infty} \otimes_R H_i(U, \mathcal{L})$ respectively, so they are MHS morphisms.

Definition 6.17 (MHS on quotients of the Alexander modules by powers of the augmentation ideal). Let $m \ge 1$, and let \mathfrak{m} be the augmentation ideal of $R = k[\pi_1(G)]$.

• The *R*-module isomorphism $R/\mathfrak{m}^m \cong R_m$ from Remark 2.23 induces isomorphisms

$$\frac{H^{i}(U,\overline{\mathcal{L}})}{\mathfrak{m}^{m}H^{i}(U,\overline{\mathcal{L}})} \cong R/\mathfrak{m}^{m} \otimes_{R} H^{i}(U,\overline{\mathcal{L}}) \cong R_{m} \otimes_{R} H_{i}(U,\mathcal{L}),$$
$$\frac{H_{i}(U,\mathcal{L})}{\mathfrak{m}^{m}H_{i}(U,\mathcal{L})} \cong R/\mathfrak{m}^{m} \otimes_{R} H_{i}(U,\mathcal{L}) \cong R_{m} \otimes_{R} H_{i}(U,\mathcal{L}),$$

The right hand sides of these isomorphisms are MHS by Corollary 6.16, which we use to define MHS on $\frac{H^i(U,\overline{\mathcal{L}})}{\mathfrak{m}^m H^i(U,\overline{\mathcal{L}})}$ and $\frac{H_i(U,\mathcal{L})}{\mathfrak{m}^m H_i(U,\mathcal{L})}$ for all $i \geq 0$ and for all $m \geq 1$.

• The *R*-module isomorphism $H_i(U^f, \mathbb{R}) \cong H_i(U, \mathcal{L})$ from Remark 2.13 (where *R* acts on $H_i(U^f, \mathbb{R})$ by deck transformations) endows $\frac{H_i(U^f, \mathbb{R})}{\mathfrak{m}^m H_i(U^f, \mathbb{R})}$ with a MHS.

Remark 6.18. Since the isomorphisms $R/\mathfrak{m}^{m'} \cong R_{m'}$ and $R/\mathfrak{m}^m \cong R_m$ from Remark 2.23 form a commutative diagram with the projections $R/\mathfrak{m}^{m'} \twoheadrightarrow R/\mathfrak{m}^m$ and $R_{m'} \twoheadrightarrow R_m$ for all $m' \ge m \ge 1$, the projection morphisms

$$\frac{H^{i}(U,\overline{\mathcal{L}})}{\mathfrak{m}^{m'}H^{i}(U,\overline{\mathcal{L}})} \to \frac{H^{i}(U,\overline{\mathcal{L}})}{\mathfrak{m}^{m}H^{i}(U,\overline{\mathcal{L}})}, \quad \frac{H_{i}(U,\mathcal{L})}{\mathfrak{m}^{m'}H_{i}(U,\mathcal{L})} \to \frac{H_{i}(U,\mathcal{L})}{\mathfrak{m}^{m}H_{i}(U,\mathcal{L})}$$

are MHS morphisms.

Recall that $\pi_1(G)$ acts on $H_i(U, \mathcal{L})) \cong H_i(U^f, \mathbb{R})$ by deck transformations. The following result states that log of deck transformation respects the MHS on quotients of Alexander modules.

Corollary 6.19. For all $\gamma \in \pi_1(G)$, let $\log \gamma \in H_1(G, \mathbb{Z})$ be the element corresponding to γ via the abelianization map. Let \mathfrak{m} be the augmentation ideal of $R := \mathbb{R}[\pi_1(G)]$, and let $m \ge 1$.

Then, the multiplication map defined as the only \mathbb{R} -linear map satisfying that

$$\begin{array}{cccc} H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} \frac{H^i(U,\overline{\mathcal{L}})}{\mathfrak{m}^m H^i(U,\overline{\mathcal{L}})} & \longrightarrow & \frac{H^i(U,\overline{\mathcal{L}})}{\mathfrak{m}^m H^i(U,\overline{\mathcal{L}})}\\ \log \gamma \otimes v & \longmapsto & \log(\gamma) \cdot v \end{array}$$

for all $\gamma \in \pi_1(G)$ and all $v \in \frac{H^i(U,\overline{\mathcal{L}})}{\mathfrak{m}^m H^i(U,\overline{\mathcal{L}})}$ is a MHS morphism, where $\log(\gamma) \cdot v$ denotes the multiplication by $\log(\gamma) := \log(1 + (\gamma - 1))$, seen as a power series in $\gamma - 1 \in \mathfrak{m}$.

Moreover, if $G \cong (\mathbb{C}^*)^n$ for some $n \ge 1$, then for all $\gamma \in \pi_1(G)$, multiplication by $\log(\gamma)$ is a MHS morphism from $\frac{H^i(U,\overline{\mathcal{L}})}{\mathfrak{m}^m H^i(U,\overline{\mathcal{L}})}$ to its -1-st Tate twist.

Furthermore, the same results hold if we replace $H^i(U, \overline{\mathcal{L}})$ by $H_i(U, \mathcal{L})$ or $H_i(U^f, \mathbb{R})$ everywhere.

Proof. Note that the multiplication morphisms

 $H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} (R_m \otimes_R H^i(U,\overline{\mathcal{L}})) \to H^i(U,\overline{\mathcal{L}}), \quad H_1(G,\mathbb{R}) \otimes_{\mathbb{R}} (R_m \otimes_R H_i(U,\mathcal{L})) \to H_i(U,\mathcal{L})$

are MHS morphisms because they are induced by the multiplication morphisms on $R_{\infty} \otimes_R H^i(U, \overline{\mathcal{L}})$ and $R_{\infty} \otimes_R H_i(U, \overline{\mathcal{L}})$ respectively, which are pro-MHS morphism by the proof of Corollary 6.16. Also note that the isomorphism $R/\mathfrak{m}^m \cong R_m$ from Remark 2.23 takes $\log(\gamma) \in R/\mathfrak{m}^m$ to $\log \gamma \in R_m$. The result now follows from Remarks 6.7 and 6.10, and from the way the MHS of Definition 6.17 are constructed. Note that the dual MHS of a *j*-th Tate twist corresponds to the -j-th Tate twist of the dual MHS.

7. FUNCTORIALITY

In this section we prove the following theorem, which is stated in terms of the homology of covers instead of homology of local systems (recall Remark 2.13) due to the geometric meaning of the morphisms to which it applies.

Theorem 7.1 (Functoriality). Let U_1, U_2 be smooth varieties, and let G_1, G_2 be semiabelian varieties. Consider a commutative diagram of algebraic morphisms

(7.2)
$$\begin{array}{c} U_1 \xrightarrow{g} U_2 \\ \downarrow_{f_1} & \downarrow_{f_2} \\ G_1 \xrightarrow{\rho} G_2 \end{array}$$

where ρ is a group homomorphism. Let

(7.3)
$$\begin{array}{c} U_1^{f_1} \xrightarrow{g} U_2^{f_2} \\ \downarrow_{\tilde{f}_1} & \downarrow_{\tilde{f}_2} \\ TG_1 \xrightarrow{\tilde{\rho}} TG_2 \end{array}$$

be a commutative diagram which is the unique lift of (7.2) satisfying that $\tilde{\rho}$ is an additive group homomorphism.

For i = 1, 2, let $R^i = \mathbb{R}[\pi_1(G_i)]$ and let \mathfrak{m}_i be the augmentation ideal of R^i . For $m \in \mathbb{Z}_{\geq 1}$, let $R^i_m = \frac{\prod_{j=0}^{\infty} \operatorname{Sym}^j H_1(G_i,\mathbb{R})}{\prod_{j=m}^{\infty} \operatorname{Sym}^j H_1(G_i,\mathbb{R})}$. Then, the following statements hold for the morphisms induced in homology by $\tilde{g}: U_1^{f_1} \to U_1^{f_2}$:

(7.4)

$$\widetilde{g}_{*,m} \colon R_m^1 \otimes_{R^1} H_j(U_1^{f_1}, \mathbb{R}) \to R_m^2 \otimes_{R^2} H_j(U_2^{f_2}, \mathbb{R})$$

is a MHS morphism for all $j \ge 0$ and for all $m \ge 1$, where the domain and the target have the MHS from Corollary 6.16.

(2) Equivalently,

$$\widetilde{g}_{*,m} \colon \frac{H_j(U_1^{f_1}, \mathbb{R})}{\mathfrak{m}_1^m H_j(U_1^{f_1}, \mathbb{R})} \to \frac{H_j(U_2^{f_2}, \mathbb{R})}{\mathfrak{m}_2^m H_j(U_2^{f_2}, \mathbb{R})}$$

is a MHS morphism for all $j \ge 0$ and for all $m \ge 1$, where the domain and the target have the MHS from Definition 6.17.

Before we prove Theorem 7.1, let us interpret its statement in more detail: the commutative diagram (7.2) induces a commutative cube



as follows: the left and right sides of the cube are pullback diagrams, $\tilde{\rho}$ is the unique lift of ρ to the universal covers that is a group homomorphism, and \tilde{g} is determined uniquely by g and $\tilde{\rho}$. The top of this cube is the commutative diagram (7.3).

Also note that the morphism

$$\widetilde{g}_*: H_j(U_1^{f_1}, \mathbb{R}) \to H_j(U_2^{f_2}, \mathbb{R})$$

induced in homology by \tilde{g} for all $j \ge 0$ satisfies that $\tilde{g}_*(\gamma \cdot -) = \rho_*(\gamma) \cdot \tilde{g}_*(-)$ for all $\gamma \in \pi_1(G_1)$, which justifies that the maps $\tilde{g}_{*,m}$ are well defined for all $j \ge 0$ and all $m \ge 1$.

7.1. Proof of Theorem 7.1.

Remark 7.5. In the setting of Theorem 7.1, the commutative diagram (7.2) factors as

(7.6)
$$\begin{array}{c} U_1 \xrightarrow{\mathrm{Id}} U_1 \xrightarrow{g} U_2 \\ \downarrow_{f_1} \qquad \downarrow_{\rho \circ f_1} \qquad \downarrow_{f_2} \\ G_1 \xrightarrow{\rho} G_2 \xrightarrow{\mathrm{Id}} G_2, \end{array}$$

so the map $U_1^{f_1} \to U_2^{f_2}$ factors through $U_1^{\rho \circ f_1}$. Therefore, it is enough to consider the cases where $\rho = \text{Id}$ and g = Id, which we will do in Theorems 7.14 and 7.15 respectively.

Let $\mathcal{L}_1 := f_1^{-1} \exp_! \mathbb{R}_{TG_1}$, and let $\mathcal{L}_2 := f_2^{-1} \exp_! \mathbb{R}_{TG_2}$. Let $\overline{\mathcal{L}_1}$ (resp. $\overline{\mathcal{L}_2}$) be \mathcal{L}_1 (resp. \mathcal{L}_2) with the conjugate R^1 (resp. R_2)-module structure. Before we prove Theorem 7.1, we need to recall how the MHS on $R_m^i \otimes_{R^i} H_j(U_i^{f_i}, \mathbb{R})$ was defined (Definition 6.17) using mixed Hodge complexes of sheaves, since the proof will need to realize the morphism \tilde{g}_* as a morphism at the level of the corresponding complexes of sheaves. The MHS on $R_m^i \otimes_{R^i} H_j(U_i^{f_i}, \mathbb{R})$ is induced from the MHS on $H^j(U_i, R_{-m'}^i \otimes_{R^i} \overline{\mathcal{L}_i})$ for all $m' \geq 1$ (from Definition 6.1) as follows:

- (1) The isomorphism $H_j(U_i, R^i_{m'} \otimes_{R^i} \mathcal{L}_i) \cong \operatorname{Hom}_{\mathbb{R}}(H^j(U_i, R^i_{-m'} \otimes_{R^i} \overline{\mathcal{L}_i}), \mathbb{R})$ from Remark 2.26 endows $H_j(U_i, R^i_{m'} \otimes_{R^i} \mathcal{L}_i)$ with the dual MHS of $H^j(U_i, R^i_{-m'} \otimes_{R^i} \overline{\mathcal{L}_i})$ for all $m' \ge 1$.
- (2) The isomorphism $R^i_{\infty} \otimes_{R^i} H_j(U_i, \mathcal{L}_i) \cong \varprojlim_{m'} H_j(U_i, R^i_{m'} \otimes_{R^i} \mathcal{L}_i)$ from Corollary 2.30 endows $R^i_{\infty} \otimes_{R^i} H_j(U_i, \mathcal{L}_i)$ with a pro-MHS, where the morphisms in the inverse limits are the ones induced by the projections $R^i_{m''} \twoheadrightarrow R^i_{m'}$ for all m'' > m' (Remark 6.6).
- (3) $R_m^i \otimes_{R^i} H_j(U_i, \mathcal{L}_i)$ is endowed with a MHS in Corollary 6.16 as the cokernels of the multiplication map

$$\underbrace{H_1(G_1,\mathbb{R})\otimes_{\mathbb{R}}\ldots\otimes_{\mathbb{R}}H_1(G_1,\mathbb{R})}_{m}\otimes_{\mathbb{R}}\left(R^i_{\infty}\otimes_{R^i}H_j(U_i,\mathcal{L}_i)\right)\to\left(R^i_{\infty}\otimes_{R^i}H_j(U_i,\mathcal{L}_i)\right),$$

which is a morphism of pro-MHS (Remark 6.9).

(4) $R_m^i \otimes_{R^i} H_j(U_i^{f_i}, \mathbb{R})$ is endowed with the MHS from $R_m^i \otimes_{R^i} H_j(U_i, \mathcal{L}_i)$ through the natural isomorphism $H_j(U_i^{f_i}, \mathbb{R}) \cong H_j(U_i, \mathcal{L}_i)$ from Remark 2.13, which comes from an isomorphism at the level of chain complexes (Corollary 6.16).

The following two lemmas address the question of how to realize the morphism \tilde{g}_* as a morphism between complexes of sheaves.

Lemma 7.7. Suppose that $\rho = \operatorname{Id}$ in the setting from Theorem 7.1. Let us denote $G \coloneqq G_1 = G_2$, $R = \mathbb{R}[\pi_1(G)]$ and $R_m \coloneqq R_m^1 = R_m^2$ for all $m \ge 1$. Then, $\overline{\mathcal{L}}_1 = g^{-1}\overline{\mathcal{L}}_2$, and the map $\widetilde{g}_* : H_j(U_1^{f_1}, \mathbb{R}) \to H_j(U_2^{f_2}, \mathbb{R})$ is induced through steps (1)–(4) above for all $j \ge 0$ by the adjunction $\operatorname{Id} \to Rg_*g^{-1}$ applied to the sheaves $R_{-m'} \otimes \overline{\mathcal{L}}_2$ for all m' > 1.

Proof. Following [31, p.60], let

$$S_{j}(U_{i},\mathcal{L}_{i}) \coloneqq \left\{ \sum_{\sigma} l_{\sigma}\sigma \text{ (finite linear combination)} \middle| \begin{array}{c} \sigma: \Delta^{j} \to U_{i} \text{ is a singular } j \text{-simplex, and} \\ l_{\sigma} \in \Gamma(\Delta^{j}, \sigma^{-1}\mathcal{L}_{i}) \end{array} \right\}.$$

Through the usual differential of singular homology and restrictions of l_{σ} to the faces of σ , we obtain $S_{\bullet}(U_i, \mathcal{L}_i)$, the singular chain complex that computes $H_j(U_i, \mathcal{L}_i)$ for all j. The morphism in homology

induced by \tilde{g}_* through the isomorphism in Step (4) above comes from the following map of chain complexes.

$$\begin{array}{cccc} \widehat{g} \colon S_j(U_1, \mathcal{L}_1) & \longrightarrow & S_j(U_2, \mathcal{L}_2) \\ & \sum_{\sigma} l_{\sigma} \sigma & \longmapsto & \sum_{\sigma} l_{\sigma} g \circ \sigma \end{array}$$

Since $\mathcal{L}_1 = g^{-1}\mathcal{L}_2$, we have that $\Gamma(\Delta^j, \sigma^{-1}\mathcal{L}_1) = \Gamma(\Delta^j, (g \circ \sigma)^{-1}\mathcal{L}_2)$, so this definition makes sense. A similar definition can be given for a map between the chain complexes corresponding to truncated local systems, namely

$$\begin{array}{rcl} \widehat{g}_{m'} \colon S_j(U_1, R_{m'} \otimes_R \mathcal{L}_1) & \longrightarrow & S_j(U_2, R_{m'} \otimes_R \mathcal{L}_2) \\ & \sum_{\sigma} (a \otimes l_{\sigma}) \sigma & \longmapsto & \sum_{\sigma} (a \otimes l_{\sigma}) g \circ \sigma \end{array}$$

where $a \in R_{m'}$ and $l_{\sigma} \in \Gamma(\Delta^j, \sigma^{-1}\mathcal{L}_1)$. Note that $\Gamma(\Delta^j, \sigma^{-1}R_{m'} \otimes_R \mathcal{L}_1) = R_{m'} \otimes_R \Gamma(\Delta^j, \sigma^{-1}\mathcal{L}_1)$, so this is well defined. Analogously, we may define \widehat{g}_{∞} . If we pass to the inverse limit, these morphisms $S_{\bullet}(U_1, R_{m'} \otimes_R \mathcal{L}_1) \to S_{\bullet}(U_2, R_{m'} \otimes_R \mathcal{L}_2)$ for all m' induce through the isomorphism in Step (2) the same morphism in homology as \widehat{g}_{∞} (note that R_{∞} is a flat *R*-module). The multiplication map in Step (3) above can be lifted to a morphism of chain complexes

$$\underbrace{H_1(G_1,\mathbb{R})\otimes_{\mathbb{R}}\ldots\otimes_{\mathbb{R}}H_1(G_1,\mathbb{R})}_m\otimes_{\mathbb{R}}(S_{\bullet}(U_1,R_{\infty}\otimes_R\mathcal{L}_1))\to S_{\bullet}(U_1,R_{\infty}\otimes_R\mathcal{L}_1).$$

and in this way we see that the morphism that \widehat{g}_{∞} induces in the cokernel of the morphisms induced in the *j*-th homology by this multiplication map coincides with $R_m \otimes H_j(\widetilde{g})$. All that is left to see is that the morphisms induced by $\widehat{g}_{m'}$ in homology agree with the dual of the morphisms induced in cohomology by adjunction $\mathrm{Id} \to Rg_*g^{-1}$ applied to the sheaf $R_{-m} \otimes_R \overline{\mathcal{L}}_2$ through the isomorphism in Step (1) above.

The isomorphism in Step (1) can be realized at the level of chains as follows: Let $S^{\bullet}(U_i, R_{-m'} \otimes_R \overline{\mathcal{L}}_i)$ the complex obtained by taking the \mathbb{R} -dual of $S_{\bullet}(U_i, R_{m'} \otimes_R \mathcal{L}_i)$. The dual of $\widehat{g}_{m'}$ is

$$(\widehat{g}_{m'})^{\vee} \colon S^{j}(U_{2}, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{2}}) \longrightarrow S^{j}(U_{1}, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{1}}) H \longmapsto H \circ \widehat{g}_{m'}$$

Note that $S^{j}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}})$ is a presheaf. Let $\widetilde{S}^{j}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}})$ be its sheafification. We will use facts stated in [39, p.360, section F]. $S^{\bullet}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}})$ is a complex of fine presheaves which is resolution (in the category of presheaves on U_{i}) of $R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}}$, where the resolution map $R_{-m} \otimes_{R} \overline{\mathcal{L}_{i}} \to S^{0}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}})$ is given by locally on $V_{i} \subset U_{i}$ by

$$b \mapsto \left(\begin{array}{ccc} S_0(V_i, R_m \otimes_R \mathcal{L}_i) & \longrightarrow & \mathbb{R} \\ \sum_{x \in V_i} l_{\sigma_x} \sigma_x & \longmapsto & \sum_{\sigma} b_x(l_{\sigma_x}), \end{array}\right)$$

where σ_x is the map from Δ^0 to $x \in V_i$, l_{σ_x} is in the stalk of $R_m \otimes_R \mathcal{L}_i$ at the point x, and we are using that $R_m \otimes_R \mathcal{L}_i$ and $R_{-m} \otimes_R \overline{\mathcal{L}}_i$ are \mathbb{R} -dual local systems. Hence, $\widetilde{S}^{\bullet}(-, R_{-m'} \otimes_R \overline{\mathcal{L}}_i)$ is a resolution of $R_{-m'} \otimes_R \overline{\mathcal{L}}_i$ (in the category of sheaves on U_i) of fine sheaves. In particular $\widetilde{S}^{\bullet}(-, R_{-m'} \otimes_R \overline{\mathcal{L}}_i)$ is a complex of acyclic sheaves with respect to pushforwards, so it can be used to compute $H^j(U_i, R_{-m'} \otimes_R \overline{\mathcal{L}}_i)$. Moreover, the sheafification morphism induces an isomorphism

$$H^{j}(S^{j}(U_{i}, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}})) \xrightarrow{\cong} H^{j}(U_{i}, R_{-m'} \otimes_{R} \overline{\mathcal{L}_{i}})$$

for all j. It suffices to show that the morphism induced by $(\widehat{g}_{m'})^{\vee}$ in cohomology coincides through this isomorphism with the map $R_{-m'} \otimes_R \overline{\mathcal{L}_2} \to Rg_*(R_{-m'} \otimes_R \overline{\mathcal{L}_1})$ induced by the adjunction $\mathrm{Id} \to Rg_*g^{-1}$ in sheaf cohomology. Consider the morphism

$$\begin{array}{cccc} a_{m'} \colon R_{-m} \otimes_R \overline{\mathcal{L}_2} & \longrightarrow & g_*(R_{-m} \otimes_R \overline{\mathcal{L}_1}) \\ & \alpha \otimes \iota & \longmapsto & \alpha \otimes \iota \circ g \end{array}$$

where $\iota: V \to TG$ satisfies that $\exp \circ \iota = f_2$. Note that $(\widehat{g}_{m'})^{\vee}$ can be easily extended to a morphism of complexes of pre-sheaves $(\widehat{g}_{m'})^{\vee}: S^{\bullet}(-, R_{-m} \otimes_R \overline{\mathcal{L}}_2) \to g_*S^{\bullet}(-, R_{-m} \otimes_R \overline{\mathcal{L}}_2)$. The result follows from the commutativity of this diagram and the fact that the complexes of (pre)sheaves that appear are fine.

$$\begin{array}{c} R_{-m'} \otimes_{R} \overline{\mathcal{L}}_{2} \\ \downarrow^{a_{m'}} \\ g_{*} \left(R_{-m'} \otimes_{R} \overline{\mathcal{L}}_{1} \right) \\ \downarrow^{g_{*} \text{ of resolution}} \\ S^{\bullet}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}}_{2}) \xrightarrow{(\widehat{g}_{m'})^{\vee}} g_{*} S^{\bullet}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}}_{1}) \\ \downarrow^{\text{sheafification}} \\ \widetilde{S}^{\bullet}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}}_{2}) \qquad g_{*} \widetilde{S}^{\bullet}(-, R_{-m'} \otimes_{R} \overline{\mathcal{L}}_{1}) \\ \downarrow^{\text{sheafification}} \\ \end{array}$$

Lemma 7.8. Suppose that g = Id in the setting of Theorem 7.1, and let $U := U_1 = U_2$. Let ρ_* denote the induced map in homology, which generates a map $R_{m'}^1 \to R_{m'}^2$ for all $m' \ge 1$. After applying the isomorphisms in Steps (1)–(4) above, the map $\tilde{g}_{*,m}$ in Theorem 7.1 is induced by the following maps of sheaves for all $m' \ge 1$:

$$\begin{array}{rccc} R^2_{-m'} \otimes_{R^2} \overline{\mathcal{L}_2} & \longrightarrow & R^1_{-m'} \otimes_{R^1} \overline{\mathcal{L}_1} \\ \phi \otimes \overline{\widetilde{\rho}} \circ \iota_0 & \mapsto & \phi \circ \rho_* \otimes \overline{\iota_0}. \end{array}$$

Here ϕ is any element of $R^2_{-m'} = \operatorname{Hom}_{\mathbb{R}}(R^2_{m'}, \mathbb{R})$ and ι_0 is a local generator of \mathcal{L}_1 , i.e. a local lift $U \to TG_1$ satisfying that $\exp \circ \iota_0 = f_1$.

Proof. Seeing U^{f_i} as subsets of $U \times TG_i$, we have that $\tilde{g}(u, z) = (u, \tilde{\rho}(z))$, so the map $\tilde{g}_* : H_j(U^{f_1}, \mathbb{R}) \to H_j(U^{f_2}, \mathbb{R})$ coincides through the identifications in Step (4) with the map that the morphism

(7.9)
$$\begin{array}{cccc} \mathcal{L}_1 & \longrightarrow & \mathcal{L}_2 \\ \iota & \longmapsto & \rho \circ \iota \end{array}$$

induces in homology, where the morphism above is described in terms of local sections (local lifts of f_i to $U \to TG_i$). Notice that the morphism (7.9) descends to the truncated local systems as

(7.10)
$$\begin{array}{cccc} R_{m'}^1 \otimes_{R^1} \mathcal{L}_1 & \longrightarrow & R_{m'}^2 \otimes_{R^2} \mathcal{L}_2 \\ a \otimes \iota_0 & \longmapsto & \rho_*(a) \otimes \widetilde{\rho} \circ \iota_0 \end{array}$$

for all $m' \ge 0$. By Step (2), the inverse limit of the maps in homology induced by these morphisms coincides with the map in homology induced by

(7.11)
$$\begin{array}{cccc} R_{\infty}^{1} \otimes_{R^{1}} \mathcal{L}_{1} & \longrightarrow & R_{\infty}^{2} \otimes_{R^{2}} \mathcal{L}_{2} \\ a \otimes \iota_{0} & \longmapsto & \rho_{*}(a) \otimes \widetilde{\rho} \circ \iota_{0} \end{array}$$

which makes the following diagram commute, where the horizontal arrows are multiplication.

$$H_{1}(G_{1},\mathbb{R}) \otimes_{\mathbb{R}} (R_{\infty} \otimes H_{j}(U,\mathcal{L}_{1})) \longrightarrow R_{\infty} \otimes H_{j}(U,\mathcal{L}_{1})$$

$$\downarrow^{\rho_{*} \otimes (\rho_{*} \otimes H_{j}((7.9)))} \qquad \qquad \downarrow^{\rho_{*} \otimes H_{j}((7.9)) = H_{j}((7.11)) = \varprojlim_{m'} H_{j}((7.10))}$$

$$H_{1}(G_{2},\mathbb{R}) \otimes_{\mathbb{R}} (R_{\infty} \otimes H_{j}(U,\mathcal{L}_{2})) \longrightarrow R_{\infty} \otimes H_{j}(U,\mathcal{L}_{2}).$$

The equality $\rho_* \otimes H_j((7.9)) = H_j((7.11))$ follows because R^i_{∞} is a flat R^i -module. In light of Step (3), the commutativity of the diagram above tells us that we just need to identify what the morphism $R^2_{-m'} \otimes_{R^2} \overline{\mathcal{L}_2} \to R^1_{-m'} \otimes_{R^1} \overline{\mathcal{L}_1}$ corresponding to (7.10) is through the chain of isomorphisms at the level of sheaves from Remark 2.8 (see Step (1)), and check that it agrees with the one described in the statement of this Lemma.

Let $m' \geq 1$, let $\phi \in R^2_{-m'} = \operatorname{Hom}_{\mathbb{R}}(R^2_{m'}, \mathbb{R})$, and let ι_0 be a local section of \mathcal{L}_1 . Note that $\widetilde{\rho} \circ \iota_0$ generates \mathcal{L}_2 locally over \mathbb{R}^2 , so any element of $\mathbb{R}^2_{-m'} \otimes_{\mathbb{R}^2} \overline{\mathcal{L}}_2$ can be written as $\phi \otimes \overline{\rho} \circ \iota_0$ for some $\phi \in R^2_{-m'}$. For two lifts $\iota, \iota' \colon U \to G_i$, let us use $\langle \overline{\iota'}, \overline{\iota} \rangle \in \pi_1(G_i) \subset R^i$ the pairing between $\overline{\mathcal{L}_i}$ and \mathcal{L}_i from Remark 2.17, which is defined by $\langle \overline{\iota}, \iota \rangle = 1$. We have the following chain of isomorphisms from Remark 2.26:

$$\begin{array}{rcl} R^2_{-m'} \otimes_{R^2} \overline{\mathcal{L}}_2 &\cong& R^2_{-m'} \otimes \mathcal{H}\mathrm{om}_{R^2}(\mathcal{L}_2, R^2) &\cong& \mathcal{H}\mathrm{om}_{R^2}(\mathcal{L}_2, \mathcal{H}\mathrm{om}_{\mathbb{R}}(R^2_{m'}, \mathbb{R})) \\ \phi \otimes \overline{\widetilde{\rho} \circ \iota_0} &\leftrightarrow& \phi \otimes (\iota \mapsto \langle \overline{\widetilde{\rho} \circ \iota_0}, \iota \rangle) &\leftrightarrow& \iota \mapsto (b \mapsto \phi(\langle \overline{\widetilde{\rho} \circ \iota_0}, \iota \rangle \cdot b)) \\ &\cong& \mathcal{H}\mathrm{om}_{\mathbb{R}}(R^2_{m'} \otimes_{R^2} \mathcal{L}_2, \mathbb{R}) \\ &\leftrightarrow& (b \otimes \iota) \mapsto \phi(\langle \overline{\widetilde{\rho} \circ \iota_0}, \iota \rangle \cdot b). \end{array}$$

Now, we have the following morphism

(7.12)
$$\mathcal{H}om_{\mathbb{R}}(R^{2}_{m'} \otimes_{R^{2}} \mathcal{L}_{2}, \mathbb{R}) \longrightarrow \mathcal{H}om_{\mathbb{R}}(R^{1}_{m'} \otimes_{R^{1}} \mathcal{L}_{1}, \mathbb{R}) H \longmapsto (a \otimes \iota_{0} \to H(\rho_{*}(a) \otimes \widetilde{\rho} \circ \iota_{0})),$$

which is the \mathbb{R} -dual of (7.10). Hence, the composition of the chain of isomorphisms above with (7.12) takes $\phi \otimes \overline{\rho} \circ \iota_0$ to $(a \otimes \iota_0 \mapsto \phi(\rho_*(a)))$. Going backwards through the chain of isomorphisms of Remark 2.26, we have:

$$\mathcal{H}om_{\mathbb{R}}(R^{1}_{m'} \otimes_{R^{1}} \mathcal{L}_{1}, \mathbb{R}) \cong \mathcal{H}om_{R^{1}}(\mathcal{L}_{1}, \mathcal{H}om_{\mathbb{R}}(R^{1}_{m'}, \mathbb{R})) \cong R^{1}_{-m'} \otimes \mathcal{H}om_{R^{1}}(\mathcal{L}_{1}, R^{1})$$

$$(a \otimes \iota_{0}) \mapsto \phi(\rho_{*}(a)) \iff \iota_{0} \mapsto \phi \circ \rho_{*} \iff \phi \circ \rho_{*} \otimes (\iota_{0} \mapsto \langle \overline{\iota}_{0}, \iota_{0} \rangle)$$

$$\cong R^{1}_{-m'} \otimes \overline{\mathcal{L}}_{1}$$

$$\Leftrightarrow \phi \circ \rho_{*} \otimes \overline{\iota_{0}}$$

$$conclusion, the map of sheaves is the one we claimed.$$

Remark 7.13. Suppose that ρ is an algebraic morphism, but not a group homomorphism. In that case, one cannot pick a canonical lift $\tilde{\rho}$ to the universal covers, so there are many choices of $\tilde{\rho}$ (each of which determines a choice of \tilde{q}) that make the cube (7.4) commutative. However, notice that the hypothesis that ρ is a group homomorphism was not used in the proof of Lemma 7.8. Hence, if q = Id, the map

$$\widetilde{g}_{*,m}: R^1_m \otimes_{R^1} H_j(U^{f_1}, \mathbb{R}) \to R^2_m \otimes_{R^2} H_j(U^{f_2}, \mathbb{R})$$

induced by the choice of \tilde{g} determined by the choice of $\tilde{\rho}$ is induced by the morphisms $R^2_{-m'} \otimes_{R^2} \overline{\mathcal{L}_2} \to \mathcal{L}_2$ $R^1_{-m'} \otimes_{R^1} \overline{\mathcal{L}_1}$ through Steps (1)–(4). Note that if ρ is a homeomorphism (for example, a translation in a semiabelian variety G) and g = Id, then $\tilde{g}_{*,m}$ is an isomorphism.

Theorem 7.14 (Functoriality, $\rho = \text{Id}$). Theorem 7.1 holds if $\rho = \text{Id}$.

Proof. Let us denote $G := G_1 = G_2$, $R = \mathbb{R}[\pi_1(G)]$ and $R_m := R_m^1 = R_m^2$ for all $m \ge 1$. By Lemma 7.7 it suffices to show that the adjunction morphism $\mathrm{Id} \to Rg_*g^{-1}$ applied to the sheaves $R_{-m'} \otimes \overline{\mathcal{L}_2}$ induces MHS isomorphisms in cohomology for all $m' \geq 1$.

Let Y_1, Y_2 be compactifications of G and X_1, X_2 be compactifications of U_1 and U_2 such that

$$\begin{array}{ccc} X_1 & \stackrel{\overline{g}}{\longrightarrow} & X_2 \\ & & \downarrow_{\overline{f_1}} & & \downarrow_{\overline{f_2}} \\ & Y_1 & \stackrel{\overline{\mathrm{Id}}}{\longrightarrow} & Y_2 \end{array}$$

forms a compatible compactification with respect to the commutative diagram (7.2), where $\rho = \text{Id.}$ Let $j_i: U_i \to X_i$ be the inclusion for i = 1, 2. We have that $R(j_2)_*$ of the adjunction morphism yields $R(j_2)_*(R_{-m'}\otimes_R\overline{\mathcal{L}_2}) \to R(\overline{g})^*R(j_1)_*(R_{-m'}\otimes_R\overline{\mathcal{L}_1})$. At the level of the thickened logarithmic Dolbeault complexes which are quasi-isomorphic to $R(j_i)_*(R_{-m'}\otimes_R \overline{\mathcal{L}_i})$ for i = 1, 2, this is the composition of

$$\left(R_{-m'}\otimes_{\mathbb{R}}\mathcal{A}_{X_{2},\mathbb{R}}^{\bullet}(\log D_{2}),d+(\overline{f_{2}})^{*}\circ\Phi_{\mathbb{R}}^{Y_{2}}(\varepsilon_{\mathbb{R}})\right)\to(\overline{g})_{*}\left(R_{-m'}\otimes_{\mathbb{R}}\mathcal{A}_{X_{1},\mathbb{R}}^{\bullet}(\log D_{1}),d+(\overline{f_{1}})^{*}\circ\Phi_{\mathbb{R}}^{Y_{1}}(\varepsilon_{\mathbb{R}})\right),$$

given by the pullback of forms through \overline{g} (which is a morphism of complexes of sheaves by the proof of Proposition 3.16 and the fact that $\Phi_{\mathbb{R}}^{Y_1} = \overline{\mathrm{Id}}^* \circ \Phi_{\mathbb{R}}^{Y_2}$) with $(\overline{g})_*$ of the inclusion of

$$\left(R_{-m'}\otimes_{\mathbb{R}}\mathcal{A}^{\bullet}_{X_1,\mathbb{R}}(\log D_1), d+(\overline{f_1})^*\circ\Phi^{Y_1}_{\mathbb{R}}(\varepsilon_{\mathbb{R}})\right)$$

into its Godement resolution. Since \overline{g} is algebraic, the first of these morphisms respects the weight filtrations \widetilde{W} . Hence, picking $n \ge \max\{2, \dim_{\mathbb{R}} U_1, \dim_{\mathbb{R}} U_2\}$, both of these morphisms will respect the weight filtrations W^n , which are biregular. Recall the definition of the derived direct image of a mixed Hodge complex of sheaves (Definition 2.64). Using Proposition 3.16, we see that composition above extends to a morphism of mixed Hodge complexes of sheaves

$$\left(R_{-m'}\otimes\mathcal{N}_{X_2,D_2,n}^{\bullet},d+\overline{f_2}^*\circ\Phi^{Y_2}(\varepsilon)\right)\to R(\overline{g})_*\left(R_{-m'}\otimes\mathcal{N}_{X_1,D_1,n}^{\bullet},d+\overline{f_1}^*\circ\Phi^{Y_1}(\varepsilon)\right),$$

where the morphism between the complex part is also given by the pullback by \overline{g} . Indeed, pullback by \overline{g} respects both the weight and Hodge filtrations there, and it is straightforward to check that $R(\overline{g})_*\left(e^{\overline{f_1}^*\circ\Psi^{Y_1}(\varepsilon_{\mathbb{C}})}\right)$ composed with the real part of the morphism (tensored by $\otimes_{\mathbb{R}}\mathbb{C}$) coincides with the composition of the complex part of this morphism and $e^{\overline{f_2}^*\circ\Psi^{Y_2}(\varepsilon_{\mathbb{C}})}$. This proves that the morphism induced by adjunction Id $\to Rg_*g^{-1}$ applied to $R_{-m}\otimes_R\overline{\mathcal{L}^2}$ yields MHS morphisms in cohomology

$$H^{j}(U_{2}, R_{-m'} \otimes_{R} \overline{\mathcal{L}^{2}}) \to H^{j}(U_{1}, R_{-m'} \otimes_{R} \overline{\mathcal{L}^{1}})$$

for all $m' \ge 1$ and for all $j \ge 1$.

Theorem 7.15 (Functoriality, g = Id). Theorem 7.1 holds if g = Id.

Proof. Let us denote $U := U_1 = U_2$. By Lemma 7.8 it suffices to show that the maps of sheaves $R^2_{-m'} \otimes_{R^2} \overline{\mathcal{L}_2} \to R^1_{-m'} \otimes_{R^1} \overline{\mathcal{L}_1}$ given by $\phi \otimes \overline{\rho} \circ \iota_0 \mapsto \phi \circ \rho_* \otimes \overline{\iota_0}$ induces MHS isomorphisms in cohomology for all $m' \geq 1$, where $\phi \in R^2_{-m'}$ and ι_0 is a local generator of \mathcal{L}_1 .

Let Y_1, Y_2 be compactifications of G_1 and G_2 , and let X be a compactification of U such that

$$\begin{array}{ccc} X & \stackrel{\mathrm{Id}}{\longrightarrow} & X \\ & & \downarrow_{\overline{f_1}} & & \downarrow_{\overline{f_2}} \\ & Y_1 & \stackrel{\overline{\rho}}{\longrightarrow} & Y_2 \end{array}$$

forms a compatible compactification with respect to the commutative diagram (7.2), where g = Id.Let $j: U \to X$ be the inclusion, and let $D = X \setminus U$. Now, we consider the thickened complexes from Definition 4.10.

$$\left(R^{i}_{-m}\otimes\mathcal{N}^{\bullet}_{X,D,n},d+\overline{f}^{*}_{i}\circ\Phi^{Y_{i}}(\varepsilon)\right),$$

where $n \ge \max\{2, \dim_{\mathbb{R}} U\}$.

Let $\rho_m : R^2_{-m} \to R^1_{-m}$ be the dual of the morphism $R^1_m \to R^2_m$ induced by $\rho_* : H_1(G_1, \mathbb{R}) \to H_1(G_2, \mathbb{R})$. By Proposition 3.14, since $\rho^* : H^1(G_2, \mathbb{R}) \to H^1(G_1, \mathbb{R})$ is a MHS morphism, $\rho_m \otimes \mathrm{Id}$ induces a morphism of mixed Hodge complexes (taking into account Corollary 4.12, which ensures that the Φ 's and Ψ 's we have defined commute with ρ^*).

The resulting mixed Hodge complex morphism induces a morphism of MHS's, as desired. It remains to show that it agrees with the one in Lemma 7.8. First, note that it results, up to natural quasiisomorphism (see Definition 6.1) from applying R_{j_*} to

$$R^2_{-m} \otimes_{\mathbb{R}} \mathcal{A}^{\bullet}_{U,\mathbb{R}} \xrightarrow{\rho_m \otimes \mathrm{Id}} R^1_{-m} \otimes_{\mathbb{R}} \mathcal{A}^{\bullet}_{U,\mathbb{R}}$$

so we just need to show that the following diagram commutes:

The proof is done via direct computation. A generator of $\overline{\mathcal{L}}_2$ can be given as $\overline{\rho} \circ \iota$, where ι is a generator of \mathcal{L}_1 . Let us write $\iota = \sum_j e_j \otimes h_j$, where h_j are analytic functions on U and $\{e_j\}$ is an \mathbb{R} -basis of TG_1 . Applying ρ results in the element $\rho \circ \iota = \sum_j \rho(e_j) \otimes h_j$. If $\alpha \in \mathbb{R}^2_{-m}$, then

$$\begin{aligned} &(\rho_m \otimes \mathrm{Id})(e^{-(\Phi_{\mathbb{R}}^{G_2})^{\vee}})\left(\alpha \otimes \overline{\rho} \circ \iota\right) \\ &= (\rho_m \otimes \mathrm{Id})\left(\alpha \cdot \exp\left(-\sum_j (\Phi_{\mathbb{R}}^{G_2})^{\vee}(\widetilde{\rho}(e_j)) \otimes h_j\right)\right) \\ &= (\rho_m \otimes \mathrm{Id})\left(\alpha \cdot \exp\left(-\sum_j \rho_*(\Phi_{\mathbb{R}}^{G_1})^{\vee}(e_j) \otimes h_j\right)\right) \qquad \left(\begin{array}{c} \mathrm{Corollary} \ 4.12, \ \mathrm{taking} \ \mathrm{duals}, \ \mathrm{using} \\ \mathrm{that} \ \rho \ \mathrm{is} \ \mathrm{a} \ \mathrm{homomorphism}\end{array}\right) \end{aligned}$$

Going through the other path, the generator $\alpha \otimes \sum_{j} \tilde{\rho}(e_{j}) \otimes h_{j}$ is mapped to $\alpha \circ \rho_{*} \otimes \sum_{j} e_{j} \otimes h_{j}$ through the vertical arrow. Therefore, we have:

$$e^{-(\Phi_{\mathbb{R}}^{G_1})^{\vee}}\left(\alpha \circ \rho_* \otimes \sum_j e_j \otimes h_j\right) = \rho_m(\alpha) \cdot \exp\left(-\sum_j (\Phi_{\mathbb{R}}^{G_1})^{\vee}(e_j) \otimes h_j\right).$$

To show that the above two expressions coincide, we just need to show that for any $\beta \in H_1(G_1, \mathbb{R})$ and any $\alpha \in \text{Hom}(\text{Sym}^j H_1(G_2, \mathbb{R}), \mathbb{R})$,

$$(\rho_*\beta \cdot \alpha) \circ \rho_* = \beta \cdot (\alpha \circ \rho_*).$$

The proof is a computation: we use the fact that the product

$$H_1(G_i, \mathbb{R}) \otimes (\operatorname{Sym}^j H_1(G_i, \mathbb{R}))^{\vee} \to (\operatorname{Sym}^{j-1} H_1(G_i, \mathbb{R}))^{\vee}$$

is the dual of $H^1(G_i, \mathbb{R}) \otimes \operatorname{Sym}^{j-1} H_1(G_i, \mathbb{R}) \to \operatorname{Sym}^j H_1(G_i, \mathbb{R})$. For any $\gamma \in \operatorname{Sym}^{j-1} H_1(G_1, \mathbb{R})$,

$$\langle (\rho_*\beta \cdot \alpha) \circ \rho_*, \gamma \rangle = \langle \rho_*\beta \cdot \alpha, \rho_*\gamma \rangle = \langle \alpha, \rho_*\beta \cdot \rho_*\gamma \rangle = \langle \alpha, \rho_*(\beta \cdot \gamma) \rangle = \langle \alpha \circ \rho_*, \beta \cdot \gamma \rangle = \langle \beta \cdot \alpha \circ \rho_*, \gamma \rangle.$$

7.2. A more general statement. Suppose that $\rho: G_1 \to G_2$ in the statement of Theorem 7.1 is an algebraic morphism but not a group homomorphism. In that case, Remark 2.8 says that there exists a group homomorphism $\rho_1: G_1 \to G_2$ and a translation $\rho_2: G_2 \to G_2$ such that $\rho = \rho_2 \circ \rho_1$, and the commutative diagram (7.2) can be decomposed as

$$U_1 \xrightarrow{g} U_2 \xrightarrow{\mathrm{Id}} U_2$$
$$\downarrow f_1 \qquad \qquad \downarrow \rho_2^{-1} \circ f_2 \qquad \qquad \downarrow f_2$$
$$G_1 \xrightarrow{\rho_1} G_2 \xrightarrow{\rho_2} G_2.$$

Theorem 7.1 says that the commutative square on the left induces a MHS homomorphism between the quotients of Alexander modules of (U_1, f_1) and $(U_2, \rho_2^{-1} \circ f_2)$ by powers of the respective augmentation ideals. Hence, in this more general setting, it suffices to understand what happens for the commutative square on the right. This is done in the following result. The main issue is that group homomorphism between semiabelian varieties lift to a unique group homomorphism between its universal covers, but algebraic morphisms between semiabelian varieties don't have a canonical lift to their universal covers in general, so we compose them with another map in (co)homology in a way that the composition does not depend on the choice of base points used to construct the lift.

Theorem 7.16. Consider the commutative diagram

$$U \xrightarrow{\mathrm{Id}} U$$
$$\downarrow^{f} \qquad \downarrow^{\rho \circ f}$$
$$G \xrightarrow{\rho} G$$

where $\rho: G \to G$ is a translation, that is, multiplication by an element $x \in G$. Let $y \in TG$ such that $\exp(y) = x$. Let $\mathcal{L}_1 := f^{-1} \exp_! \underline{\mathbb{R}}_{TG}$ and $\mathcal{L}_2 := (\rho \circ f)^{-1} \exp_! \underline{\mathbb{R}}_{TG}$. Then, the following hold:

- If $\tilde{\rho}: TG \to TG$ is addition by y, then $\exp \circ \tilde{\rho} = \rho \circ \exp$.
- Let $\zeta_m^y : R_{-m} \otimes_R \overline{\mathcal{L}_2} \to R_{-m} \otimes_R \overline{\mathcal{L}_1}$ be the morphism from Remark 7.13 given by $\phi \otimes \overline{\rho} \circ \iota \mapsto \phi \circ \rho_* \otimes \overline{\iota}$. The composition $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ \zeta_m^y$ induces through Steps (1)–(4) the morphism

$$e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ \widetilde{\mathrm{Id}}_{*,m} : R_m \otimes_R H_j(U^f, \mathbb{R}) \to R_m \otimes_R H_j(U^{\rho \circ f}, \mathbb{R}),$$

where $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)}$ denotes the multiplication by $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \in R_{\infty}$, and $\widetilde{\mathrm{Id}}_{*,m}$ is the map induced by the lift $\widetilde{\mathrm{Id}}: U^f \to U^{\rho \circ f}$ of Id which is determined by $\widetilde{\rho}$ as in Theorem 7.1.

- The morphism $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ \zeta_m^y$ is independent of the choice of $y \in TG$ such that $\exp(y) = x$.
- $e^{-(\Phi^G_{\mathbb{R}})^{\vee}(y)} \circ \widetilde{\mathrm{Id}}_{*,m}$ is an isomorphism of MHS.

In particular, $\frac{H_j(U^f,\mathbb{R})}{\mathfrak{m}^m H_j(U^f,\mathbb{R})}$ and $\frac{H_j(U^{\rho\circ f},\mathbb{R})}{\mathfrak{m}^m H_j(U^{\rho\circ f},\mathbb{R})}$ are canonically isomorphic, although not through the map $\widetilde{\mathrm{Id}}$ in general.

Proof. The proof of the first point is immediate. The second point is a consequence of Remark 7.13 and the fact that the \mathbb{R} -dual of multiplication by an element of R_{∞} is also multiplication by an element of R_{∞} .

For the third point, notice that, since G is path connected, ρ is homotopic to the identity in G. In particular, $\zeta_m^y(-\phi \otimes \overline{\rho} \circ \iota) = \phi \otimes \overline{\iota}$. Notice also that for all $y, y' \in TG$ such that $\exp(y) = \exp(y')$ one has that $y - y' \in H_1(G, \mathbb{Z}) \subset TG$. In particular, y - y' is fixed by $(\Phi_{\mathbb{R}}^G)^{\vee}$, so

$$(\Phi_{\mathbb{R}}^G)^{\vee}(y) - (\Phi_{\mathbb{R}}^G)^{\vee}(y') = (\Phi_{\mathbb{R}}^G)^{\vee}(y-y') = y - y' \in H_1(G,\mathbb{Z}).$$

Hence,

$$e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ \zeta_m^y(\phi \otimes \overline{\iota + y}) = e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ (\phi \otimes \overline{\iota}) = \left(e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \cdot \phi\right) \otimes \overline{\iota},$$

and, if we let $\gamma \in \pi_1(G)$ be the element corresponding to $y - y' \in H_1(G, \mathbb{Z})$ (i.e. $\log \gamma = y - y'$ using the notation of Remark 2.23), then

$$e^{-(\Phi_{\mathbb{R}}^G)^{\vee}} \circ \zeta_m^{y'}(\phi \otimes \overline{\iota + y}) = e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y')} \circ (\phi \otimes \overline{\iota + y - y'}) = (e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y')} \cdot \phi) \otimes \gamma^{-1}\overline{\iota}$$
$$= e^{-(y-y')}(e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y')} \cdot \phi) \otimes \overline{\iota} = (e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \cdot \phi) \otimes \overline{\iota},$$

which concludes the proof of the third point.

For the fourth point a similar computation to that of (5.6) yields that the morphism $\zeta_m^y : R_{-m} \otimes_R \overline{\mathcal{L}_2} \to R_{-m} \otimes_R \overline{\mathcal{L}_1}$ lifts through the morphisms $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ from Construction 5.4 to a morphism $R_{-m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0 \to R_{-m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$ given by multiplication by $e^{(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \in R_{\infty}$ in the first factor. This is done using that $\rho_* : R_m \to R_m$ is the identity. Hence, $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ \zeta_m^y$ lifts through the morphisms $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}}$ from Construction 5.4 to the identity morphism in $R_{-m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$, which in turn lifts to the identity morphism in $R_{-m} \otimes_{\mathbb{R}} \mathcal{A}_{U,\mathbb{R}}^0$, which in turn lifts to the identity morphism of this lemma, it is clear that the identity morphism can be realized at the level of mixed Hodge complexes of sheaves from Definition-Proposition 2.72, and hence it induces a morphism of MHS in hypercohomology. In particular, $e^{-(\Phi_{\mathbb{R}}^G)^{\vee}(y)} \circ \widetilde{\mathrm{Id}}_{*,m}$ is a morphism of MHS which is an isomorphism of vector spaces, so it is an isomorphism of MHS.

The following example conveys that the MHS defined in this paper have the potential of distinguishing (up to algebraic isomorphism) algebraic varieties whose cohomology groups have isomorphic MHS. This could be interesting in the case of affine hypersurface complements (Example 2.36).

Example 7.17. Let U be a smooth algebraic variety. By Remark 2.32, its Albanese map $\alpha_U : U \to G$ is completely determined up to translation in the target. By Remark 2.35, U^{α_U} is the (torsion-free) universal abelian cover of U, which is a topological invariant (i.e. it does not depend on α_U , just on U). Let \mathfrak{m} be the augmentation ideal of $\mathbb{R}[\pi_1(G)]$. By Theorem 7.16, the isomorphism class of the mixed Hodge structure on $\frac{H_j(U^{\alpha_U},\mathbb{R})}{\mathfrak{m}^m H_j(U^{\alpha_U},\mathbb{R})}$ is an algebraic invariant of (U, m), that is, it depends on the algebraic structure of U and on the value of $m \geq 1$, but not on the choice of Albanese map α_U .

7.3. Compatibility with Deligne's MHS. We end this section by showing the compatibility of the MHS defined in this paper with Deligne's MHS, as a consequence of functoriality.

Corollary 7.18. Let U be a smooth connected algebraic variety, let G be a semiabelian variety, and let $f: U \to G$ be an algebraic morphism. Let $\pi: U^f \to U$ be the pullback of $\exp: TG \to G$ by f. Let $R = \mathbb{R}[\pi_1(G)]$, and let \mathfrak{m} be its augmentation ideal. Then, the map that π induces in homology factors through the MHS morphism

$$\frac{H_j(U^f,\mathbb{R})}{\mathfrak{m}^m H_j(U^f,\mathbb{R})} \to H_j(U,\mathbb{R})$$

for all $j \geq 0$ and all $m \geq 1$, where $H_j(U, \mathbb{R})$ is endowed with Deligne's MHS.

Proof. The statement follows from applying Theorem 7.1 in the case where $U_1 = U_2 = U$, $G_1 = G$, G_2 is a point, $f_1 = f$ and g is the identity. Indeed, in this case $R^2 = \mathbb{R} = R_m^2$, $U^{f_2} = U$ and $\tilde{g} = \pi$, so in particular the augmentation ideal \mathfrak{m}_2 of R^2 is (0). The thickened logarithmic Dolbeault mixed Hodge complex of sheaves $(R_m^2 \otimes \mathcal{N}_{X,D,n}^{\bullet}, d + \overline{f_2}^* \circ \Phi^Y)$ from Definition 4.10 constructed form (U, f_2, m) coincides with the mixed Hodge complex of sheaves $(\mathcal{N}_{X,D,n}^{\bullet}, d)$ from Definition-Proposition 2.72, so by Remark 2.73, the pro-MHS on $R_\infty^2 \otimes_{R^2} H_j(U^{f_2}, \mathbb{R}) = H_j(U^{f_2}, \mathbb{R})$ from Corollary 6.16 coincides with Deligne's MHS on $H_j(U, \mathbb{R})$. Hence, the MHS on $H_j(U^{f_2}, \mathbb{R}) \cong \frac{H_j(U^{f_2}, \mathbb{R})}{\mathfrak{m}_2^m H_j(U^{f_2}, \mathbb{R})}$ from Definition 6.17 coincides with Deligne's MHS on $H_j(U, \mathbb{R})$.

8. Completion with respect to other ideals

Let U be a smooth connected complex algebraic variety, let G be a complex semiabelian variety and let $f: U \to G$ be an algebraic map. Let H be a finite index subgroup of $\pi_1(G)$, and let \mathfrak{m}_H be the augmentation ideal of $\mathbb{R}^H := \mathbb{R}[H] \subset \mathbb{R}[\pi_1(G)] = \mathbb{R}$. Note that $\mathfrak{m}_H \mathbb{R}$ is the ideal of R given by

$$\mathfrak{m}_H R = (\gamma - 1 \mid \gamma \in H).$$

The goal of this section is to endow $\frac{H_i(U^f,k)}{(\mathfrak{m}_H)^m H_i(U^f,k)}$ with a canonical MHS for all $i \geq 0$ and for all $m \geq 1$. Here, $(\mathfrak{m}_H)^m H_i(U^f,k)$, which in principle is a R^H -submodule of $H_i(U^f,k)$, can also be seen as an R-submodule by identifying it with $(\mathfrak{m}_H R)^m H_i(U^f,k)$.

For this, we start by passing to the finite cover induced by H as follows: let $p_H : G_H \to G$ be the covering space corresponding to H, where G_H is a semiabelian variety and p_H is morphism of algebraic groups (see Remark 2.27). Note that $p_H : G_H \to G$ is only determined up to isomorphism of semiabelian varieties on the domain.

The pair (f, p_H) determines the following pullback diagram:

Note that $\pi_H : U_H \to U$ is a finite cover of U, with deck transformation group H (the same as $p_H : G_H \to G$). Note also that p_H induces a unique isomorphism of vector spaces $\widetilde{p}_H : TG_H \to TG$ such that $\exp \circ \widetilde{p}_H = p_H \circ \exp$.

We define the following map, which is easily seen to be an isomorphism of complex analytic varieties, where $U_H^{f_H}$ is constructed from the pullback diagram of (f_H, \exp) as U^f is constructed from the pullback diagram of (f, \exp) :

$$\begin{array}{rccc} \theta_H \colon U^f & \longrightarrow & U_H^{f_H} \\ (u,z) & \longmapsto & \left(\left(u, \exp(\widetilde{p_H}^{-1}(z)) \right), \widetilde{p_H}^{-1}(z) \right) \end{array}$$

It fits into the following commutative cube:



Here, the bottom face of the cube is the pullback diagram above, and the left and right faces are also pullback diagrams.

A straightforward computation shows that $\pi_H \circ \pi' \circ \theta_H = \pi$, so $\pi' \circ \theta_H : U^f \to U_H$ is a covering space and θ_H is an isomorphism of covering spaces over U_H . Hence, θ_H induces an isomorphism $(\theta_H)^* : H_j(U^f, k) \to H_j(U_H^{f_H}, k)$ of $\mathbb{R}[H]$ -modules for all $j \ge 0$. Note that $\gamma \in H \le \pi_1(G)$ acts on $H_j(U^f, k)$ by $(p_H)_*(\gamma)$, where the latter is seen as a deck transformation of $\pi : U^f \to U$. In particular, θ_H induces isomorphisms of $\mathbb{R}[H] = \mathbb{R}[\pi_1(G_H)]$ -modules

$$\frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)} \cong \frac{H_j(U_H^{fH},k)}{(\mathfrak{m}_H)^m H_j(U_H^{fH},k)}$$

Proposition 8.3. Let H be a finite index subgroup of $\pi_1(G)$. Let \mathfrak{m} be the augmentation ideal of $R = \mathbb{R}[\pi_1(G)]$, and let \mathfrak{m}_H be the augmentation ideal of $R^H = \mathbb{R}[H] \subset R$. Let $f : U \to G$ be an algebraic map, where U is a smooth connected algebraic variety, and let $\pi : U^f \to G$ be the corresponding abelian cover corresponding to f as in (1.1). Then,

$$\frac{H_j(U^f,\mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f,\mathbb{R})}$$

has a canonical MHS for all $j \ge 0$ and for all $m \ge 1$ such that the natural projection morphism

$$\frac{H_j(U^f,\mathbb{R})}{(\mathfrak{m}_H)^m H_i(U^f,\mathbb{R})} \twoheadrightarrow \frac{H_j(U^f,\mathbb{R})}{\mathfrak{m}^m H_i(U^f,\mathbb{R})}$$

is a morphism of mixed Hodge structures.

Proof. Using the notation in the discussion above, the isomorphism induced by θ_H can be used to endow $\frac{H_j(U^f,\mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f,\mathbb{R})}$ with a MHS from the canonical MHS of $\frac{H_j(U_H^{f_H},\mathbb{R})}{(\mathfrak{m}_H)^m H_j(U_H^{f_H},\mathbb{R})}$ from Definition 6.17. For this MHS on $\frac{H_j(U^f,\mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f,\mathbb{R})}$ to be canonical it must not depend on the choice of G_H , which is determined up to isomorphism of semiabelian varieties, but this follows from functoriality (Theorem 7.1). The statement about the projection map follows from functoriality (Theorem 7.1) applied to the commutative diagram (8.1).

Proposition 8.4. Let $\pi_1(G) = K_0 \ge K_1 \ge K_2 \dots$ a sequence such that K_i is a finite index subgroup of K_{i-1} for all $i \ge 1$. Then, the following is a diagram of MHS morphisms, where all the maps involved

are the natural projections and the MHS are the ones from Proposition 8.3.



Proof. Construct a chain of covering spaces

$$\ldots \to G_{K_2} \to G_{K_1} \to G$$

and use those semiabelian varieties to endow the different modules in the diagram with canonical MHS as in the proof of Proposition 8.3. The vertical projections are morphisms of MHS by Proposition 8.3. The horizontal projections are morphism of MHS by Remark 6.18. $\hfill \Box$

Example 8.6. Suppose that $G = \mathbb{C}^*$. In this case, $R = \mathbb{R}[\pi_1(G)]$ is isomorphic to $\mathbb{R}[t^{\pm 1}]$, where t is a generator of $\pi_1(G)$. The map $p : \mathbb{C}^* \to \mathbb{C}^*$ that sends z to z^N is a finite cover. In this setting, Proposition 8.4 applied to the chain of subgroups $\pi_1(G) = \langle t \rangle \geq \langle t^N \rangle \geq \langle t^{2N} \rangle \geq \langle t^{4N} \rangle$ yields the commutative diagram (8.5), where $(\mathfrak{m}_{K_l})^m = (t^{2^{l-1}N} - 1)^m$ for all $l \geq 1$ and all $m \geq 1$, and $(\mathfrak{m})^m = (t-1)^m$.

9. EIGENSPACE DECOMPOSITION

In this section, $U, G, f, G_H, p_H, U_H, f_H, \pi, \pi_H, \pi', \theta_H$, and the augmentation ideals $\mathfrak{m} \subset R = \mathbb{R}[\pi_1(G)]$, and $\mathfrak{m}_H \subset R^H = \mathbb{R}[H]$ will be as in Section 8. Let \mathcal{L} (resp. \mathcal{L}_H) be the local system of $\mathbb{R}[\pi_1(G)]$ -modules given by $(f)^{-1} \exp_! \underline{k}_{TG}$ (resp. $(f_H)^{-1} \exp_! \underline{k}_{TG_H}$), and let $\overline{\mathcal{L}}$ (resp. $\overline{\mathcal{L}}_H$) be the corresponding local system endowed with its conjugate $\mathbb{R}[\pi_1(G)]$ -module (resp. $\mathbb{R}[H]$ -module) structure.

The rings R_{∞}^{H} and R_{m}^{H} for m > 0 will be defined from G_{H} , that is, $R_{\infty}^{H} \coloneqq \prod_{j=0}^{\infty} \operatorname{Sym}^{j} H_{1}(G_{H}, \mathbb{R})$, $R_{m}^{H} \coloneqq \frac{R_{\infty}^{H}}{\prod_{j=m}^{\infty} \operatorname{Sym}^{j} H_{1}(G_{H}, \mathbb{R})}$. Similarly, for all m > 0, $R_{-m}^{H} \coloneqq \operatorname{Hom}_{\mathbb{R}}(R_{m}^{H}, \mathbb{R})$. The same construction can be carried out for \mathbb{C} coefficients, and will be denoted equally as in Section 3.

The goal of this section is to prove the following theorem, which provides a generalization of Theorem [17, Theorem 1.3].

Theorem 9.1. Let $\gamma \in \pi_1(G)$, which acts on $H_j(U^f, \mathbb{R})$ by a deck transformation of $\pi : U^f \to U$. Let H be a finite index subgroup of $\pi_1(G)$, and let \mathfrak{m}_H be the augmentation ideal of $\mathbb{R}[H]$. Let $\gamma = \gamma_{ss}\gamma_u$ be the Jordan-Chevalley decomposition of γ acting on $\frac{H_j(U^f,\mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f,\mathbb{R})}$ as the product of a semisimple (i.e. diagonalizable) operator and a unipotent (i.e. γ_u – Id is nilpotent) operator that commute with each other. Then,

$$\gamma_{ss} \colon \frac{H_j(U^f, \mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f, \mathbb{R})} \to \frac{H_j(U^f, \mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f, \mathbb{R})}$$

is a MHS isomorphism for all $j \ge 0$ and all $m \ge 1$.

Since γ acts quasi-unipotently on $\frac{H_j(U^f,\mathbb{R})}{(\mathfrak{m}_H)^m H_j(U^f,\mathbb{R})}$ (γ^N – Id is a nilpotent operator, where N is the order of the class of γ in $\pi_1(G)/H$) and $\pi_1(G)$ is an abelian group, Theorem 9.1 immediately implies the following result. It uses the terminology of the lesser known \mathbb{C} -MHS, see cf. [17, Definition 2.1] for a definition.

Corollary 9.2 (Eigenspace decomposition). Let $\gamma \in \pi_1(G)$, let N be the order of the class of γ in the quotient $\pi_1(G)/H$ and let $k = \mathbb{R}, \mathbb{C}$. Let $g(x) \in k[x]$ be a monic irreducible factor of $x^N - 1$, and let E_g^{γ} be the kernel of $g(\gamma_{ss}) : \frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)} \to \frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)}$ for $m \gg 0$, so in particular, if $g(x) = x - \lambda$ for some N-th root of unity $\lambda \in k$, E_g^{γ} is the generalized eigenspace of eigenvalue λ . Then, the inclusion $E_g^{\gamma} \hookrightarrow \frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)}$ endows E_g^{γ} with a k-MHS, and the direct sum decomposition

tion

$$\frac{H_j(U^J,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)} = \bigoplus_g E_g^{\gamma}$$

is a MHS decomposition, that is, the MHS on the right hand side is a direct sum of MHS as in the left hand side.

Moreover, let n be the rank of $\pi_1(G)$, and let $\{\gamma_1, \ldots, \gamma_n\}$ be a basis of $\pi_1(G)$ as a \mathbb{Z} -module. Consider all the n-tuples $\overline{g} = (g_1, \ldots, g_n)$ such that $g_i(x) \in k[x]$ is a monic irreducible factor of $x^{N_i}-1$, where N_i is the order of the class of γ_i in the quotient $\pi_1(G)/H$. Denote $E_{\overline{g}} \coloneqq \bigcap_{i=1}^n E_{g_i}^{\gamma_i}$. Then,

$$\frac{H_j(U^f,k)}{(\mathfrak{m}_H)^m H_j(U^f,k)} = \bigoplus_{\overline{g}} E_{\overline{g}}$$

is a finer k-MHS decomposition.

Theorem 9.1 will be proved by passing to the finite cover U_H of U, so first, we need to specify certain identifications between local systems on U and U_H . Let $\mathcal{L}_H := f_H^{-1} \exp_! \mathbb{R}_{TG}$ and $\mathcal{L} := f^{-1} \exp_! \mathbb{R}_{TG}$. From the commutative cube (8.2), we deduce the following chain of canonical identifications:

$$(\pi_{H})_{*}\mathcal{L}_{H} = (\pi_{H})_{*}(f_{H})^{-1} \exp_{!} \underline{\mathbb{R}}_{TG_{H}} = (\pi_{H})_{!}(f_{H})^{-1} \exp_{!} \underline{\mathbb{R}}_{TG_{H}} = (\pi_{H})_{!}(\pi')_{!}(f_{H})^{-1} \underline{k}_{TG_{H}} = \pi_{!}(\theta_{H})^{-1}(\widetilde{f_{H}})^{-1} \underline{\mathbb{R}}_{TG_{H}} = \pi_{!}(\widetilde{f})^{-1}(\widetilde{p_{H}}^{-1})^{-1} \underline{\mathbb{R}}_{TG} = \pi_{!}(\widetilde{f})^{-1} \underline{\mathbb{R}}_{TG} = \mathcal{L}.$$

Here, the exponent -1 is used to describe the inverse image functor when the function is in parentheses, and the inverse of a bijective map when there are no parentheses, we hope that the use is clear from the context. Recall that the $\mathbb{R}[H]$ -module structure on \mathcal{L}_H side is by deck transformations of π' : $U_H^{f_H} \to U_H$, and the $\mathbb{R}[H]$ -module structure on \mathcal{L} is by seeing H inside of $\pi_1(G)$ and thus considering the elements of H as deck transformations of $\pi: U^f \to U$. Hence, the chain of identifications above induces an isomorphism of $\mathbb{R}[H]$ -modules between the (conjugate) local systems

$$\theta_{\overline{\mathcal{L}}_H}: (\pi_H)_* \overline{\mathcal{L}}_H \to \overline{\mathcal{L}}.$$

Let $\gamma \in \pi_1(G)$, and let $\mathcal{T}_{\gamma} : U^f \to U^f$ be the corresponding deck transformation of π . By definition, $\gamma \in \mathbb{R}[\pi_1(G)]$ has an action on \mathcal{L} induced by \mathcal{T}_{γ} , i.e. if ι is a local section of \mathcal{L} seen as a map $\iota: U \to TG$ such that $\exp \circ \iota = f$, $\gamma \cdot \iota = \iota + \log \gamma$. The action of \mathcal{T}_{γ} descends to the deck transformation of π_H , which we will also denote $\mathcal{T}_{\gamma} \colon U_H \to U_H$.

Now, note that for all $(u, z) \in U^f \subset U \times TG$, $\gamma \cdot (u, z) = (u, z + \log \gamma)$, where $\log \gamma$ is the element of $H_1(G,\mathbb{Z})$ corresponding to γ through the abelianization. In that sense, we can think of $\gamma \in \pi_1(G)$ as acting on $U_H^{f_H}$ through the isomorphism θ_H as follows: for every $((u, s), w) \in U_H^{f_H} \subset U_H \times TG_H \subset U_H$ $U \times G_H \times TG_H$,

$$\gamma \cdot ((u,s),w) \coloneqq \theta_H \circ (\gamma \cdot) \circ \theta_H^{-1}((u,s),w) = \left(\left(u, s \cdot \exp(\widetilde{p_H}^{-1}(\log \gamma)) \right), w + \widetilde{p_H}^{-1}(\log \gamma) \right).$$

The following result below is a generalization of [17, Lemma 3.1] (where $G = \mathbb{C}^*$). The proof is a straightforward verification on local sections which follows the same steps as in [17, Lemma 3.1], so we omit it. In it, we describe the γ -action on \mathcal{L}_H , similarly as to how we have described the γ -action on $U_{H}^{f_{H}}$.

Lemma 9.3. Let $\gamma \in \pi_1(G)$. There is a morphism of sheaves $\mathcal{M}_{\gamma} \colon \overline{\mathcal{L}}_H \to (\mathcal{T}_{\gamma})_* \overline{\mathcal{L}}_H$ such that after taking $(\pi_H)_*$ it becomes multiplication by γ , i.e. the following composition is multiplication by γ :

$$\overline{\mathcal{L}} \xrightarrow[\sim]{\stackrel{\theta \overline{\mathcal{L}}_H}{\longrightarrow}} (\pi_H)_* \overline{\mathcal{L}}_H \xrightarrow[\sim]{(\pi_H)_* \mathcal{M}_{\gamma}} (\pi_H)_* (\mathcal{T}_{\gamma})_* \overline{\mathcal{L}}_H = (\pi_H \circ \mathcal{T}_{\gamma})_* \overline{\mathcal{L}}_H = (\pi_H)_* \overline{\mathcal{L}}_H \xrightarrow[\sim]{\stackrel{\theta \overline{\mathcal{L}}_H}{\longrightarrow}} \overline{\mathcal{L}}.$$

Furthermore, for every local section $\overline{\iota}$ of $\overline{\mathcal{L}_H}$ (seen as a map $\iota : U_H \to TG_H$ such that $\exp \circ \iota = f_H$), \mathcal{M}_{γ} is given by

$$\mathcal{M}_{\gamma}(\overline{\iota}) = (\widetilde{p_H}^{-1} \circ (-\log \gamma) \circ \widetilde{p_H}) \circ \overline{\iota} \circ \mathcal{T}_{\gamma} = (\overline{\iota} - \widetilde{p_H}^{-1} \log \gamma) \circ \mathcal{T}_{\gamma},$$

where $(-\log \gamma) : TG \to TG$ is defined by $z \to z - \log \gamma$.

Remark 9.4. From now on, we are going to be working on complexes of sheaves defined over U_H . We will look at the map that \mathcal{M}_{γ} induces between $R_m^H \otimes_{R^H} \overline{\mathcal{L}}_H$ and itself, namely $\mathrm{Id} \otimes \mathcal{M}_{\gamma}$. For simplicity in the notation, we will denote $\mathrm{Id} \otimes \mathcal{M}_{\gamma}$ also by \mathcal{M}_{γ} from now on. Note

The following is a higher dimensional generalization of [17, Lemma 3.3].

Lemma 9.5. Let $m \in \mathbb{Z} \setminus \{0\}$. Under the quasi-isomorphism

$$e^{-(\Phi_{\mathbb{R}}^{G_H})^{\vee}} \colon R_m^H \otimes_R \overline{\mathcal{L}_H} \to \left(R_m^H \otimes_{\mathbb{R}} \mathcal{A}_{U_H,\mathbb{R}}^{\bullet}, d + (f_H)^* \circ \Phi_{\mathbb{R}}^{G_H}(\varepsilon_{\mathbb{R}}) \right)$$

from Construction 5.4, the map \mathcal{M}_{γ} (where \mathcal{M}_{γ} was defined in Lemma 9.3) becomes the following morphism of complexes of sheaves, defined R_{∞}^{H} -linearly as

$$\widetilde{\mathcal{M}}_{\gamma} \colon \left(R_{m}^{H} \otimes_{\mathbb{R}} \mathcal{A}_{U_{H},\mathbb{R}}^{\bullet}, d + (f_{H})^{*} \circ \Phi_{\mathbb{R}}^{G_{H}}(\varepsilon_{\mathbb{R}}) \right) \longrightarrow (\mathcal{T}_{\gamma})_{*} \left(R_{m}^{H} \otimes_{\mathbb{R}} \mathcal{A}_{U_{H},\mathbb{R}}^{\bullet}, d + (f_{H})^{*} \circ \Phi_{\mathbb{R}}^{G_{H}}(\varepsilon_{\mathbb{R}}) \right)$$

$$1 \otimes \omega \longmapsto e^{\widetilde{p_{H}}^{-1}(\log \gamma)} \otimes (\mathcal{T}_{\gamma})^{*} \omega.$$

In other words, the following diagram commutes:

Proof. Since $p_H^* : H^1(G, \mathbb{R}) \to H^1(G_H, \mathbb{R})$ is surjective, $\widetilde{\mathcal{M}}_{\gamma}$ is a morphism of complexes of sheaves. Moreover, since \mathcal{T}_{γ} is a deck transformation of $\pi_H : U_H \to U$,

$$\mathcal{T}_{\gamma}^{*} \circ f_{H}^{*} \circ \Phi_{\mathbb{R}}^{G_{H}} \circ p_{H}^{*} = \mathcal{T}_{\gamma}^{*} \circ f_{H}^{*} \circ p_{H}^{*} \circ \Phi_{\mathbb{R}}^{G} = \mathcal{T}_{\gamma}^{*} \circ \pi_{H}^{*} \circ f^{*} \circ \Phi_{\mathbb{R}}^{G} = \pi_{H}^{*} \circ f^{*} \Phi_{\mathbb{R}}^{G} = f_{H}^{*} \circ \Phi_{\mathbb{R}}^{G_{H}}.$$

The rest of the proof is a direct application of the definitions of the morphisms involved which can be checked on elements of the form $1 \otimes \overline{\iota}$, where $\overline{\iota}$ is a local section of $\overline{\mathcal{L}}_H$. It uses that $(\Phi_{\mathbb{R}}^{G_H})^{\vee}$ fixes $H_1(G_H, \mathbb{R})$, so in particular it fixes $\widetilde{p_H}^{-1} \log \gamma$.

Let $\widetilde{\mathcal{M}}_{\gamma}^{ss}$ be the following morphism of complexes of sheaves, defined R_{∞}^{H} -linearly as

$$\widetilde{\mathcal{M}}_{\gamma}^{ss} \colon \left(R_{m}^{H} \otimes_{\mathbb{R}} \mathcal{A}_{U_{H},\mathbb{R}}^{\bullet}, d + (f_{H})^{*} \circ \Phi_{\mathbb{R}}^{G_{H}}(\varepsilon_{\mathbb{R}}) \right) \longrightarrow (\mathcal{T}_{\gamma})_{*} \left(R_{m}^{H} \otimes_{\mathbb{R}} \mathcal{A}_{U_{H},\mathbb{R}}^{\bullet}, d + (f_{H})^{*} \circ \Phi_{\mathbb{R}}^{G_{H}}(\varepsilon_{\mathbb{R}}) \right)$$

$$1 \otimes \omega \longmapsto 1 \otimes (\mathcal{T}_{\gamma})^{*} \omega$$

Lemma 9.6. The morphism $\mathcal{M}^{ss}_{\gamma}$ induces an isomorphism of MHS in cohomology

$$h_{ss}: H^j(U_H, R_m^H \otimes_{R^H} \overline{\mathcal{L}_H}) \to H^j(U_H, R_m^H \otimes_{R^H} \overline{\mathcal{L}_H})$$

for all $j \geq 0$ and all $m \in \mathbb{Z} \setminus \{0\}$ through the quasi-isomorphism $e^{-(\Phi_{\mathbb{R}}^{G_H})^{\vee}}$.

Proof. We denote also by $\mathcal{T}_{\gamma} : G_H \to G_H$ be the deck transformation of $p_H : G_H \to G$ induced by $\gamma \in \pi_1(G)$. Let Y_1, Y_2 be compactifications of G_H and X_1, X_2 be compactifications of U_H such that the first commutative diagram in

$$\begin{array}{cccc} X_1 & \stackrel{\mathcal{T}_{\gamma}}{\longrightarrow} & X_2 & & U_H & \stackrel{\mathcal{T}_{\gamma}}{\longrightarrow} & U_H \\ & & & \downarrow_{\overline{f_H}} & & \downarrow_{\overline{f_H}} & & \downarrow_{f_H} & & \downarrow_{f_H} \\ Y_1 & \stackrel{\mathcal{T}_{\gamma}}{\longrightarrow} & Y_2 & & G_H & \stackrel{\mathcal{T}_{\gamma}}{\longrightarrow} & G_H \end{array}$$

forms a compatible compactification with respect to the second commutative diagram.

Let $D_i := X_i \setminus U_H$ for i = 1, 2. Note that $j_* \widetilde{\mathcal{M}}_{\gamma}^{ss}$ restricts to a morphism of sheaf complexes

$$\left(R_m^H \otimes_{\mathbb{R}} \mathcal{A}_{X_2,\mathbb{R}}^{\bullet}(\log D_2), d + (\overline{f_H})^* \circ \Phi_{\mathbb{R}}^{Y_2}(\varepsilon_{\mathbb{R}})\right) \to (\overline{\mathcal{T}_{\gamma}})_* \left(R_m^H \otimes_{\mathbb{R}} \mathcal{A}_{X_1,\mathbb{R}}^{\bullet}(\log D_1), d + (\overline{f_H})^* \circ \Phi_{\mathbb{R}}^{Y_1}(\varepsilon_{\mathbb{R}})\right),$$

where X, Y are compatible compactifications of U_H , G_H with respect to f_H , and $D = X \setminus U_H$, and this restriction is the pullback by $\overline{\mathcal{T}_{\gamma}}$.

Recall the definition of the derived direct image of a mixed Hodge complex of sheaves (Definition 2.64). Composing this restriction of $j_* \widetilde{\mathcal{M}}_{\gamma}^{ss}$ with $(\overline{\mathcal{T}_{\gamma}})_*$ of the inclusion of

$$\left(R_m^H \otimes_{\mathbb{R}} \mathcal{A}_{X_1,\mathbb{R}}^{\bullet}(\log D_1), d + (\overline{f_H})^* \circ \Phi_{\mathbb{R}}^{Y_1}(\varepsilon_{\mathbb{R}})\right)$$

into its Godement resolution, and using that the pullback by algebraic functions respects the weight filtration \widetilde{W} , we obtain a morphisms of filtered complexes

$$\left(R_m^H \otimes \mathcal{A}_{X_2,\mathbb{R}}^{\bullet}(\log D_2), d + (\overline{f_H})^* \circ \Phi_{\mathbb{R}}^{Y_2}(\varepsilon_{\mathbb{R}}), W_{\cdot}^n\right) \to R(\overline{\mathcal{T}_{\gamma}})_* \left(R_m^H \otimes \mathcal{A}_{X_1,\mathbb{R}}^{\bullet}(\log D_1), d + (\overline{f_H})^* \circ \Phi_{\mathbb{R}}^{Y_1}(\varepsilon_{\mathbb{R}}), W_{\cdot}^n\right)$$

given by the pullback by $\overline{\mathcal{T}_{\gamma}}$, for any $n \geq \max\{2, \dim_{\mathbb{R}} U_H\}$. The result follows from the fact that this extends to a morphism of mixed Hodge complexes of sheaves

$$\left(R_m^H \otimes \mathcal{N}_{X_2,D_2,n}^{\bullet}, d + \overline{f_H}^* \circ \Phi^{Y_2}(\varepsilon)\right) \to R(\overline{\mathcal{T}_{\gamma}})_* \left(R_m^H \otimes \mathcal{N}_{X_1,D_1,n}^{\bullet}, d + \overline{f_H}^* \circ \Phi^{Y_1}(\varepsilon)\right),$$

where the morphism between the complex part is also given by the pullback by $\overline{\mathcal{T}_{\gamma}}$. Indeed, pullback by $\overline{\mathcal{T}_{\gamma}}$ respects both the weight and Hodge filtrations there, and it is straightforward to check that $R(\overline{\mathcal{T}_{\gamma}})_*\left(e^{\overline{f_H}^*\circ\Psi^{Y_1}(\varepsilon_{\mathbb{C}})}\right)$ composed with the real part of the morphism (tensored by $\otimes_{\mathbb{R}}\mathbb{C}$) coincides with the composition of the complex part of this morphism and $e^{\overline{f_H}^*\circ\Psi^{Y_2}(\varepsilon_{\mathbb{C}})}$.

Lemma 9.7. Let N be the order of the class of γ in the quotient $\pi_1(G)/H$, and let $j \ge 0$, $m \in \mathbb{Z} \setminus \{0\}$. Let

$$h_{ss}: H^j(U_H, R_m^H \otimes_{R^H} \overline{\mathcal{L}_H}) \to H^j(U_H, R_m^H \otimes_{R^H} \overline{\mathcal{L}_H})$$

as in Lemma 9.6, and let

 $h: H^{j}(U_{H}, R_{m}^{H} \otimes_{R^{H}} \overline{\mathcal{L}_{H}}) \to H^{j}(U_{H}, R_{m}^{H} \otimes_{R^{H}} \overline{\mathcal{L}_{H}})$

be the map induced by \mathcal{M}_{γ} in cohomology. Then,

- $(h_{ss})^N = \text{Id.}$ • $(h \circ (h_{ss})^{-1} - \text{Id})^{|m|} = 0$
- h_{ss} and h commute.

In particular, h_{ss} is the semisimple part in the Jordan-Chevalley decomposition of h.

Proof. Note that h_{ss} and h are the maps induced in cohomology by $\widetilde{\mathcal{M}}_{\gamma}$ and $\widetilde{\mathcal{M}}_{\gamma}^{ss}$ through the quasiisomorphism $e^{-(\Phi_{\mathbb{R}}^{GH})^{\vee}}$. These statements can be easily checked by looking at $\widetilde{\mathcal{M}}_{\gamma}$ and $\widetilde{\mathcal{M}}_{\gamma}^{ss}$. The first statement is a consequence of the fact that $(\mathcal{T}_{\gamma})^{N}$ is the identity on U_{H} . The second is a consequence of the fact that $(e^{\widetilde{p}_{H}^{-1}(\log \gamma)} - 1)^{|m|} \in R_{\infty}^{H}$ acts as multiplication by 0 in R_{m}^{H} .

We are now ready to prove the main result in this section.

Proof of Theorem 9.1. Let m > 0. By Lemma 9.3, multiplication by $\gamma \in \pi_1(G) \subset \mathbb{R}[\pi_1(G)]$ in $\overline{\mathcal{L}}$ determines an isomorphism of sheaves from $\gamma : \mathbb{R}^H_{-m} \otimes_{\mathbb{R}^H} \overline{\mathcal{L}} \to \mathbb{R}^H_{-m} \otimes_{\mathbb{R}^H} \overline{\mathcal{L}}$ to itself, which, through the isomorphism $\theta_{\overline{\mathcal{L}}_H}$ determines an isomorphism

$$(\pi_H)_*\mathcal{M}_{\gamma}: (\pi_H)_*\left(R^H_{-m}\otimes_{R^H}\overline{\mathcal{L}}_H\right) \to (\pi_H)_*\left(R^H_{-m}\otimes_{R^H}\overline{\mathcal{L}}_H\right)$$

Let $\gamma_{ss}: H^j(U, R^H_{-m} \otimes_{R^H} \overline{\mathcal{L}}) \to H^j(U, R^H_{-m} \otimes_{R^H} \overline{\mathcal{L}})$ be the semisimple part of the isomorphism induced by γ in cohomology. Now, taking duals and applying Lemma 9.7, we obtain the commutative diagram

where the arrow on the right is a MHS morphism by Lemma 9.6.

We can apply Remark 2.26 to the right column of this diagram and Remark 2.27 to the left column to obtain

(9.8)
$$\begin{array}{c} H_{j}(U, R_{m}^{H} \otimes_{R^{H}} \mathcal{L}) \xrightarrow{\cong} H_{j}(U_{H}, R_{m}^{H} \otimes_{R^{H}} \mathcal{L}_{H}) \\ \downarrow^{\gamma_{ss}} & \text{MHS} \downarrow^{(h_{ss})^{\vee}} \\ H_{j}(U, R_{m}^{H} \otimes_{R^{H}} \mathcal{L}) \xrightarrow{\cong} H_{j}(U_{H}, R_{m}^{H} \otimes_{R^{H}} \mathcal{L}_{H}). \end{array}$$

Note that the arrow at the left has been labeled by γ_{ss} because the dual of multiplication by γ is multiplication by γ , and taking duals respects the Jordan-Chevalley decomposition. Now, these maps are defined for all m > 0 and commute with taking inverse limits, so by Corollary 2.30,

In the previous commutative diagram, the horizontal arrows were induced by $\theta_{\mathcal{L}_H}$ after tensoring by R^H_{-m} over R^H , taking the *j*-th cohomology, taking \mathbb{R} -duals and performing an inverse limit. However, notice that this is the map induced in homology by the identification $\theta_H : U^f \to U_H^{f_H}$ from (8.2), under the identification from Remark 2.13. Indeed, both of these maps come from the natural identifications arising from the commutative cube (8.2).

Let us see that the maps in (9.8) all commute with multiplication by any element of $H_1(G_H, \mathbb{R}) \subset \mathbb{R}^H_{\infty}$. By properties of the Jordan-Chevalley decomposition (and the fact that it commutes with taking duals), we have that $(h_{ss})^{\vee}$ is a polynomial in h^{\vee} with no constant terms, so in particular $(h_{ss})^{\vee}$ commutes with every linear operator that commutes with h^{\vee} . Since the action of γ on the left hand side of (9.8) commutes with multiplication by any element of $H_1(G_H, \mathbb{R})$, we obtain the desired result.

In Corollary 6.16 $R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H)$ is endowed with a MHS as the cokernel of a multiplication map

$$\underbrace{H_1(G_H,\mathbb{R})\otimes\ldots\otimes H_1(G_H,\mathbb{R})}_m\otimes \left(R^H_\infty\otimes_{R^H}H_j(U_H,\mathcal{L}_H)\right)\to R^H_\infty\otimes_{R^H}H_j(U_H,\mathcal{L}_H),$$

so, by (9.9),

 $(h_{ss})^{\vee}: R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H) \to R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H)$

is a mixed Hodge structure isomorphism. Note that there exists $m' \gg 1$ such that the natural map

$$H_j(U_H, R_{m'}^H \otimes_{R^H} \mathcal{L}_H) \to R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H)$$

is surjective and a MHS morphism. Since this surjection commutes with $(h_{ss})^{\vee}$, Lemma 9.6 implies that $((h_{ss})^{\vee})^N : R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H) \to R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H)$ is the identity, it commutes with h, and $h^{\vee} \circ ((h_{ss})^{\vee})^{-1}$ is unipotent. In other words, $(h_{ss})^{\vee} : R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H) \to R_m^H \otimes_{R^H} H_j(U_H, \mathcal{L}_H)$ is the semisimple part in the Jordan-Chevalley decomposition of h^{\vee} , and it is a MHS isomorphism.

Recall the definition of the MHS on $\frac{H_j(U^f,\mathbb{R})}{\mathfrak{m}_H H_j(U^f,\mathbb{R})}$ from Proposition 8.3, which uses the MHS from Definition 6.17. Under the isomorphism $H_j(U_H, \mathcal{L}_H) \cong H_j(U, \mathcal{L})$ coming from θ_H and the identification from Remark 2.13, $(h_{ss})^{\vee}$ corresponds to the semisimple part of the map induced by γ , so

$$\gamma_{ss}: \frac{H_j(U^f, \mathbb{R})}{\mathfrak{m}_H H_j(U^f, \mathbb{R})} \cong R_m^H \otimes_{R^H} H_j(U, \mathcal{L}) \to R_m^H \otimes_{R^H} H_j(U, \mathcal{L}) \cong \frac{H_j(U^f, \mathbb{R})}{\mathfrak{m}_H H_j(U^f, \mathbb{R})}$$

is a mixed Hodge structure isomorphism, concluding the proof.

10. The Q-MHS in the case $G = (\mathbb{C}^*)^n$

In 6.1, a canonical MHS was defined on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ for all $m \in \mathbb{Z} \setminus \{0\}$. All of the other MHS defined in this paper are induced from these ones through morphisms defined over \mathbb{Q} . The goal of this section is to prove that the MHS of this paper are actually defined over \mathbb{Q} if $G = (\mathbb{C}^*)^n$, although we expect the result to be true in general. Since the proofs of the results in Sections 6, 7, 8 and 9 only use morphisms defined over \mathbb{Q} , the results therein also hold for the MHS with \mathbb{Q} -coefficients.

Let U be a smooth connected complex algebraic variety, and let $f : U \to (\mathbb{C}^*)^n$ be an algebraic morphism, where $n \geq 1$. Let X and $(\mathbb{P}^1)^n$ be compactifications of U and $(\mathbb{C}^*)^n$ which are compatible with f, and let $\overline{f} : X \to (\mathbb{P}^1)^n$ be the extension of f to those compactifications. Let $D \coloneqq X \setminus U$ and let $n' \geq \max\{2, \dim_{\mathbb{R}} U\}$. Pick coordinates (z_1, z_2, \ldots, z_n) of $(\mathbb{C}^*)^n$, and note that $\left\{ \begin{bmatrix} \frac{1}{2\pi i} \frac{dz_j}{z_j} \\ \frac{1}{2\pi i} \end{bmatrix} \mid j = 1, \ldots, n \right\}$ form a basis of $H^1((\mathbb{C}^*)^n, \mathbb{Z})$. With that choice of coordinates, we have that $f = (f_1, \ldots, f_n)$, where $f_j : U \to \mathbb{C}^*$ for all $j = 1, \ldots, n$. Note that G_A in the Chevalley decomposition of $G = (\mathbb{C}^*)^n$ is a point, and $G = G_T$. Hence, by

Note that G_A in the Chevalley decomposition of $G = (\mathbb{C}^*)^n$ is a point, and $G = G_T$. Hence, by Definition-Proposition 4.6, $\Phi_{\mathbb{C}}^{(\mathbb{P}^1)^n}$ factors through $\Gamma\left((\mathbb{P}^1)^n, \Omega^1_{(\mathbb{P}^1)^n}(\log E)\right)$, where $E = (\mathbb{P}^1)^n \setminus (\mathbb{C}^*)^n$. It is straightforward to see that maps $\overline{f}^* \circ \Phi_{\mathbb{C}}^{(\mathbb{P}^1)^n}, \overline{f}^* \circ \Phi_{\mathbb{R}}^{(\mathbb{P}^1)^n}$, and $\overline{f}^* \circ \Psi^{(\mathbb{P}^1)^n}$ appearing in Definition 4.10 have the following form:

(10.1)

$$\begin{split} \overline{f}^* \circ \Phi_{\mathbb{C}}^{(\mathbb{P}^1)^n} \colon \left(H^1((\mathbb{C}^*)^n, \mathbb{C}), W_{\cdot}[1], F^{\bullet} \right) &\longrightarrow \left(\Gamma(X, \Omega_X^1(\log D)), W_{\cdot}, F^{\bullet} \right) \subset \left(\Gamma(X, \mathcal{A}_{X,\mathbb{C}}^1(\log D)), W_{\cdot}^{n'}, F^{\bullet} \right) \\ \left[\frac{1}{2\pi i} \frac{dz_j}{z_j} \right] &\longmapsto \frac{1}{2\pi i} \frac{df_j}{f_j}, \\ \overline{f}^* \circ \Phi_{\mathbb{R}}^{(\mathbb{P}^1)^n} \colon \left(H^1((\mathbb{C}^*)^n, \mathbb{R}), W_{\cdot}[1] \right) &\longrightarrow \left(\Gamma(X, \mathcal{A}_{X,\mathbb{R}}^1(\log D)), W_{\cdot}^{n'} \right) \\ \left[\frac{1}{2\pi i} \frac{dz_j}{z_j} \right] &\longmapsto \Re_{\frac{1}{2\pi i}} \frac{df_j}{f_j} = \frac{1}{2\pi} \Im_{\frac{df_j}{f_j}}, \\ \overline{f}^* \circ \Psi^{(\mathbb{P}^1)^n} \colon \left(H^1((\mathbb{C}^*)^n, \mathbb{C}), W_{\cdot}[1] \right) &\longrightarrow \left(\Gamma(X, \mathbb{C} \otimes_{\mathbb{R}} \mathcal{A}_{X,\mathbb{R}}^0(\log D)), W_{\cdot}^{n'} \right) \\ \left[\frac{1}{2\pi i} \frac{df_j}{f_j} \right] &\longmapsto -\frac{1}{2\pi i} \log(|f_j|). \end{split}$$

Recall the filtrations in the target of the first of these maps, which were defined in Section 2.9, and note that it respects the filtrations (recall that $H^1((\mathbb{C}^*)^n, \mathbb{R})$ is pure of type (1, 1)).

Let $j: U \to X$ be the inclusion. Consider the multiplicative Q-mixed Hodge complex of sheaves on X of [15, Theorem 2.37]

(10.2)
$$((\mathcal{K}^{\bullet}_{\infty}, \widetilde{W}_{\bullet}), (\Omega^{\bullet}_{X}(\log D), W_{\bullet}, F^{\bullet}), \varphi_{\infty}),$$

which coincides with the one from [37, Section 4.4] except for a slight modification in the weight filtration of the rational part so as to make it biregular.

For the purposes of this section, we just need to recall this much of the definition of this mixed Hodge complex of sheaves:

$$\mathcal{K}^{p}_{\infty} \coloneqq \lim_{m \to \infty} \left(\operatorname{Sym}^{m-p}_{\mathbb{Q}}(\mathcal{O}_{X}) \otimes \left(\bigwedge_{\mathbb{Q}}^{p} \mathcal{M}^{\operatorname{gp}}_{X,D} \otimes_{\mathbb{Z}}\right) \right), \quad \widetilde{W}_{m} \mathcal{K}^{\bullet}_{\infty} \coloneqq \left\{ \begin{array}{cc} \mathcal{K}^{\bullet}_{m} & \text{if } m \leq \dim_{\mathbb{C}} X, \\ \mathcal{K}^{\bullet}_{\infty} & \text{otherwise.} \end{array} \right. \\ \varphi_{\infty} \colon & \mathcal{K}^{p}_{\infty} & \longrightarrow & \Omega^{p}_{X}(\log D) \\ g_{1} \cdot \ldots \cdot g_{m-p} \otimes y_{1} \wedge \ldots \wedge y_{p} & \longmapsto & \frac{1}{(2\pi i)^{p}} g_{1} \cdot \ldots \cdot g_{m-p} \frac{dy_{1}}{y_{1}} \wedge \ldots \wedge \frac{dy_{p}}{y_{p}} \end{array}$$

where \mathcal{O}_X is the sheaf of holomorphic functions on X and $\mathcal{M}_{X,D}^{\mathrm{gp}}$ is the sheaf of abelian groups associated to $\mathcal{M}_{X,D} := \mathcal{O}_X \cap j_* \mathcal{O}_U^*$, where \mathcal{O}_U^* is the sheaf of holomorphic functions g on U such that $\frac{1}{q}$ is also holomorphic.

Remark 10.3. Note that $f_j \in \Gamma(X, j_*\mathcal{O}_U^*)$ for all j = 1, ..., n. These functions can be extended to X as the quotient of two holomorphic functions, and thus $f_j \in \Gamma(X, \mathcal{M}_{X,D}^{\mathrm{gp}})$ for all j = 1, ..., n.

Definition 10.4. We define the morphism $\Phi_{\mathbb{Q}}$ as

$$\Phi_{\mathbb{Q}} \colon \left(H^{1}((\mathbb{C}^{*})^{n}, \mathbb{Q}), W_{\cdot}[1] \right) \longrightarrow \Gamma\left(X, (\mathcal{K}_{\infty}^{1, cl}, \widetilde{W}_{\cdot}) \right)$$
$$\left[\frac{1}{2\pi i} \frac{dz_{i}}{z_{i}} \right] \longmapsto 1 \otimes f_{i}.$$

Clearly, $\Phi_{\mathbb{Q}}$ preserves the weights and, using (10.1), it is straightforward to see that $\varphi_{\infty} \circ \Phi_{\mathbb{Q}} = \overline{f}^* \circ \Phi_{\mathbb{C}}^{(\mathbb{P}^1)^n}$ in $H^1((\mathbb{C}^*)^n, \mathbb{Q})$. In particular, we may apply Definition-Proposition 3.8 to get the following mixed Hodge complex of sheaves.

Definition 10.5 (Thickened rational mixed Hodge complex of sheaves). Let $m \in \mathbb{Z} \setminus \{0\}$. The following is a Q-mixed Hodge complex of sheaves in X:

$$\left(\left((R_m \otimes_{\mathbb{Q}} \mathcal{K}^{\bullet}_{\infty}, d + \Phi_{\mathbb{Q}}(\varepsilon_{\mathbb{Q}})\right), W_{\bullet}\right), \left((R_m \otimes_{\mathbb{C}} \Omega^{\bullet}_X(\log D), d + \overline{f}^* \circ \Phi^{(\mathbb{P}^1)^n}_{\mathbb{C}}(\varepsilon_{\mathbb{C}})\right), W_{\bullet}, F^{\bullet}\right), \operatorname{Id} \otimes \varphi_{\infty}\right),$$

where the filtrations are the tensor filtrations corresponding to R_m and the mixed Hodge complex (10.2), and Id $\otimes \varphi_{\infty} : R_m \otimes_{\mathbb{Q}} \mathcal{K}^{\bullet}_{\infty} \to R_m \otimes_{\mathbb{C}} \Omega^{\bullet}_X(\log D)$ is a quasi-isomorphism after tensoring the domain with \mathbb{C} over \mathbb{Q} .

Remark 10.6. Let $m \in \mathbb{Z} \setminus \{0\}$, and let $n' \ge \max\{2, \dim_{\mathbb{R}} U\}$. Note that the mixed Hodge complex of sheaves from Definition 10.5 can be given an extra term so that its complex part coincides with the complex part in the mixed Hodge complex of sheaves $\left(R_m \otimes \mathcal{N}^{\bullet}_{X,D}(n'), d + \overline{f}^* \circ \Phi^{(\mathbb{P}^1)^n}(\varepsilon)\right)$ of Definition 4.10. Indeed, by Proposition 3.16, the composition of the bi-filtered quasi-isomorphisms from Theorem 2.69 and Definition-Proposition 2.72 $(\Omega^{\bullet}_X(\log D), W_{\bullet}, F^{\bullet}) \hookrightarrow (\mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), W_{\bullet}^{n'}, F^{\bullet})$ given by inclusion extends to a bi-filtered quasi-isomorphism between the complex parts of the thickened complexes of Definitions 10.5 and 4.10

$$\left((R_m \otimes_{\mathbb{C}} \Omega^{\bullet}_X(\log D), d + \overline{f}^* \circ \Phi^Y_{\mathbb{C}}(\varepsilon_{\mathbb{C}})), W_{\bullet}, F^{\bullet} \right) \hookrightarrow \left((R_m \otimes_{\mathbb{C}} \mathcal{A}^{\bullet}_{X,\mathbb{C}}(\log D), d + \overline{f}^* \circ \Phi^Y_{\mathbb{C}}(\varepsilon_{\mathbb{C}})), W^{n'}_{\bullet}, F^{\bullet} \right)$$

Notation 10.7. Let $\overline{\mathcal{L}}_{\mathbb{Q}}$ (resp. $\overline{\mathcal{L}}_{\mathbb{R}}$) be as $\overline{\mathcal{L}}$ in Definition 2.12 but with \mathbb{Q} (resp. \mathbb{R}) coefficients. For $m \in \mathbb{Z} \setminus \{0\}, R_m$ (resp. R) in the expression $R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}}$ will be as in Definition 2.20 for $k = \mathbb{Q}$ (resp. $\mathbb{Q} [\pi_1 ((\mathbb{C}^*)^n)])$, and similarly for \mathbb{R} -coefficients.

We now introduce some notation. Let $k = \mathbb{Q}$, \mathbb{R} or \mathbb{C} , depending on contest. Let $s_j^{\vee} \coloneqq \left\lfloor \frac{1}{2\pi i} \frac{dz_j}{z_j} \right\rfloor$, let $\{s_j \mid j = 1, \ldots, n\} \subset H_1((\mathbb{C}^*)^n, k)$ be the dual basis of $\{s_j^{\vee} \mid j = 1, \ldots, n\}$. Let γ_j be a loop around the origin in the *j*-th coordinate \mathbb{C}^* of $(\mathbb{C}^*)^n$ for all $j = 1, \ldots, n$. Identify $T(\mathbb{C}^*)^n$ with \mathbb{C}^n (with coordinates (w_1, \ldots, w_n)) in a way that $\exp(w_1, \ldots, w_n) = (e^{w_1}, \ldots, e^{w_n})$. With that identifications, $\log \gamma_j$ is seen in $T(\mathbb{C}^*)^n$ as $2\pi i e_j$, where e_j is the *j*-th element of the canonical basis of \mathbb{C}^n . Denote by x_j and y_j the real and imaginary parts of z_j . Note that $\{e_1, \ldots, e_n\} \cup \{\log \gamma_i, \ldots, \log \gamma_n\}$ form an \mathbb{R} -basis of $T(\mathbb{C}^*)^n$. Note that $\Phi_{\mathbb{R}}^{(\mathbb{C}^*)^n}\left(\left[\frac{1}{2\pi i} \frac{dz_j}{z_j}\right]\right) = \Re \frac{1}{2\pi i} \frac{dz_j}{z_j}$, which, at the identity element of $(\mathbb{C}^*)^n$ takes the value $\frac{1}{2\pi} dy_j$, which takes the value 1 in $\log \gamma_j$ and 0 in the rest of the elements of the fixed \mathbb{R} basis of $T(\mathbb{C}^*)^n$. Hence, under these identifications, $(\Phi_{\mathbb{R}}^{(\mathbb{C}^*)^n})^{\vee}$ (as introduced in Construction 5.4) takes the following form:

$$(\Phi_{\mathbb{R}}^{(\mathbb{C}^*)^n})^{\vee} : TG \longrightarrow H_1(G, \mathbb{R}) \log \gamma_j \longmapsto \log \gamma_j = s_j e_j \longmapsto 0$$

Let V be a small open set in U and let $\iota : V \to T(\mathbb{C}^*)^n$ be a holomorphic map such that $\exp \circ \iota = f$. Note that such ι form a Q-basis of $\overline{\mathcal{L}}_{\mathbb{Q}}$ in V. Under the identifications above, $\iota = (\iota_1, \ldots, \iota_n)$, where $\iota_j : V \to \mathbb{C}$ is holomorphic. Hence, it makes sense to talk about $\Re \iota_j$ and $\Im \iota_j$ for all $j = 1, \ldots, n$. Notice that $\exp(\iota_j) = f_j$, so $\exp(\Re \iota_j) = |f_j|$.

We now do the analogue of Construction 5.4 but for \mathbb{Q} -coefficients.

Construction 10.8. Let $m \in \mathbb{Z} \setminus \{0\}$. Then, we can define an $R = \mathbb{Q} [\pi_1 (\mathbb{C}^*)^n]$ -linear morphism of sheaves $\nu_{\mathbb{Q}} : R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}} \to j^{-1}(R_m \otimes_{\mathbb{Q}} \mathcal{K}_{\infty}^0)$ locally by

$$\nu_{\mathbb{Q}} \colon R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}} \longrightarrow j^{-1}(R_m \otimes_{\mathbb{Q}} \mathcal{K}^0_{\infty})$$
$$\alpha \otimes \iota \longmapsto \alpha \exp\left(-\frac{1}{2\pi i} \sum_{j=1}^n (s_j \otimes (\iota_j \otimes 1))\right).$$

The proof that $\nu_{\mathbb{Q}}$ is well-defined on the tensor product (over R) and that it is R-linear follows similar steps as its analogue for \mathbb{R} -coefficients (Proposition 5.5), so we omit it. This time, it needs to use that for all $a_1, \ldots, a_n \in \mathbb{Z}$, $(\prod_{i=1}^n \gamma_i^{a_i}) \cdot \iota = (\iota_1 - 2\pi i a_1, \ldots, \iota_n - 2\pi i a_n)$.

Proposition 10.9. Let $m \in \mathbb{Z} \setminus \{0\}$. Then, the restriction of the morphism $e^{f^* \circ \Psi^{(\mathbb{C}^*)^n}(\varepsilon_{\mathbb{C}})} \cdot e^{-(\Phi_{\mathbb{R}}^{(\mathbb{C}^*)^n})^{\vee}}$: $R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{R}} \to j^{-1} \left(R_m \otimes_{\mathbb{C}} \mathcal{A}^0_{X,\mathbb{C}}(\log D) \right)$ to $R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}}$ coincides with the composition $(\mathrm{Id} \otimes \varphi_{\infty}) \circ \nu_{\mathbb{Q}}$.

Proof. The proof is a direct computation:

$$e^{f^* \circ \Psi^{(\mathbb{C}^*)^n}(\varepsilon_{\mathbb{C}})} \cdot e^{-(\Phi_{\mathbb{R}}^{(\mathbb{C}^*)^n})^{\vee}} (\alpha \otimes \iota) = \alpha \cdot e^{f^* \circ \Psi^{(\mathbb{C}^*)^n}(\varepsilon_{\mathbb{C}})} \cdot e^{-(\Phi_{\mathbb{R}}^{(\mathbb{C}^*)^n})^{\vee} (\sum_{j=1}^n e_j \otimes \Re \iota_j + \frac{1}{2\pi} \sum_{j=1}^n \log \gamma_j \otimes \Im \iota_j)}$$
$$= \alpha \cdot \exp\left(-\frac{1}{2\pi i} \sum_{j=1}^n s_j \otimes \log(|f_j|)\right) \cdot \exp\left(-\frac{1}{2\pi} \sum_{j=1}^n s_j \otimes \Im \iota_j\right)$$
$$= \alpha \cdot \exp\left(-\frac{1}{2\pi i} \sum_{j=1}^n s_j \otimes \iota_j\right) = (\mathrm{Id} \otimes \varphi_{\infty}) \circ \nu_{\mathbb{Q}}(\alpha \otimes \iota)$$

Remark 10.10. Since $\operatorname{Id} \otimes \varphi_{\infty}$ (resp. $e^{f^* \circ \Psi^{(\mathbb{C}^*)^n}(\varepsilon_{\mathbb{C}})}$) is a quasi-isomorphism when the domain is tensored by \mathbb{C} over \mathbb{Q} (resp. over \mathbb{R}) and \mathbb{C} is faithfully flat over \mathbb{Q} (resp. over \mathbb{R}), we have that $j^{-1}((R_m \otimes_{\mathbb{Q}} \mathcal{K}^{\bullet}_{\infty}, d + \Phi_{\mathbb{Q}}(\varepsilon_{\mathbb{Q}})))$ resolves a free rank 1 *R*-local system. Using Proposition 10.9 and Lemma 5.9 we get that $\nu_{\mathbb{Q}}$ induces a quasi-isomorphism

$$\nu_{\mathbb{Q}}: R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}} \to j^{-1} \left(\left(R_m \otimes_{\mathbb{Q}} \mathcal{K}^{\bullet}_{\infty}, d + \Phi_{\mathbb{Q}}(\varepsilon_{\mathbb{Q}}) \right) \right).$$

In particular, the mixed Hodge complex of sheaves from Definition 10.5 endows $H^*(U, R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}})$ with a Q-MHS following the same steps as in Definition 6.1 (with the same shifts if m > 0), using the adjunction Id $\to Rj_*j^{-1}$.

Corollary 10.11. Let $m \in \mathbb{Z} \setminus \{0\}$, and suppose that $G = (\mathbb{C}^*)^n$ for some $n \ge 1$. The MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{R}})$ from Definition 6.1 is defined over \mathbb{Q} . In particular, all of the MHS defined in this paper are defined over \mathbb{Q} in this case, and the results in Sections 6, 7, 8 and 9 also hold for \mathbb{Q} -coefficients.

Proof. Proposition 10.9 implies that, after tensoring by \mathbb{R} over \mathbb{Q} , the MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}}_{\mathbb{Q}})$ induced by the mixed Hodge complex of sheaves from Definition 10.5 coincides with the MHS from Definition 6.1.

Remark 10.12 (The case $G = \mathbb{C}^*$). Suppose that m > 0 and that $G = \mathbb{C}^*$. Let s be a positive oriented loop around the origin in $H_1((\mathbb{C}^*)^n, \mathbb{Q})$, and use it to identify R_m with $\mathbb{Q}[s^{\pm 1}]/(s^m)$. Under the identifications and choice of coordinates explained in this section, the mixed Hodge complex of Definition 10.5 and $\nu_{\mathbb{Q}}$ coincide with those of [15] (see Remark 5.12 and Theorem 5.24 therein). Therefore, the \mathbb{Q} -MHS on $H^*(U, R_m \otimes_R \overline{\mathcal{L}})$ from both papers is the same. Note that, in [15], this MHS (with the same shift as in Definition 6.1) was used to endow $\operatorname{Tors}_R H^*(U, \overline{\mathcal{L}})$ with a canonical MHS.

HODGE THEORY OF ABELIAN COVERS

11. Relationship with the spectrum of a central hyperplane arrangement complement

Let $f_i \in \mathbb{C}[x_1, \ldots, x_n]$ be homogeneous polynomials of degree 1 for $i = 1, \ldots, m$ such that if $i \neq j$, f_i is not a product of f_j by a constant. Suppose that m > n. Let $f = \prod_{i=1}^m f_i^{d_i}$ for some $d_i \ge 1$, let $d = \sum_{i=1}^m d_i$, let $H_i = V(f_i) \subset \mathbb{C}^n$, and let $H = \bigcup_{i=1}^m H_i$. The f_i 's describe a central hyperplane arrangement in \mathbb{C}^n , but if we think of it as being determined by f, the arrangement is not necessarily reduced.

The Milnor fiber of f is $f^{-1}(1)$, and it is equipped with the monodromy action

$$\begin{array}{ccc} f^{-1}(1) & \longrightarrow & f^{-1}(1) \\ (x_1, \dots, x_n) & \longmapsto & (\xi x_1, \dots, \xi x_n), \end{array}$$

where $\xi = e^{\frac{2\pi i}{d}}$. Note that this induces a semisimple action on the reduced homology groups $\widetilde{H}^{j}(f^{-1}(1),\mathbb{C})$, and its possible eigenvalues are the *d*-th roots of unity.

Definition 11.1 (Spectrum of f). The spectrum of f is defined by $\operatorname{Sp}(f) = \sum_{\alpha \in \mathbb{O}} n_{f,\alpha} t^{\alpha}$, where

- $n_{f,\alpha} = \sum_{j} (-1)^{j-n+1} \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{p} \widetilde{H}^{j}(f^{-1}(1), \mathbb{C})_{\lambda},$
- $\widetilde{H}^{j}(f^{-1}(1),\mathbb{C})_{\lambda}$ is the eigenspace of eigenvalue λ by the monodromy action on the reduced cohomology groups $\widetilde{H}^{j}(f^{-1}(1),\mathbb{C})$,
- $\lambda = e^{-2\pi i \alpha}$ and
- $p = \lfloor n \alpha \rfloor$.

The spectrum of a hypersurface singularity was first defined by Steenbrink [40] as a local invariant of the Hodge filtration of the cohomology of the local Milnor fiber, but in the case of central hyperplane arrangements, the Milnor fibration corresponding to the singularity at the origin comes from a global fibration of the hyperplane complement over \mathbb{C}^* , and Definition 11.1 coincides with Steenbrink's.

Remark 11.2. Budur and Saito showed in [3], Sp(f) depends only on the combinatorial data of the (not necessarily reduced) arrangement defined by f.

Despite this positive result of Budur and Saito, one of the most central open problems of arrangement theory is whether the Betti numbers of the Milnor fiber associated to a (reduced) central hyperplane arrangement in \mathbb{C}^n are combinatorial or not. This has been solved if n = 3 and the projectivized arrangement in \mathbb{P}^2 only has double and triple points by Papadima and Suciu in [36]. In this section, we translate the problem of whether the first Betti number of a central hyperplane arrangement is combinatorial to a statement of whether the dimensions of the filtered pieces by the Hodge filtration of a MHS defined in this paper is combinatorially determined, motivating the future study of the objects introduced in this note.

Suppose that one wants to study whether the first Betti number of the Milnor fiber of a (reduced) central hyperplane arrangement is combinatorially determined or not. It is enough to consider the case when the arrangement is essential and the number of hyperplanes is greater than the dimension of the ambient space. Moreover, by a Lefschetz hyperplane argument, it suffices to determine whether the first Betti number of an essential line arrangement complement in \mathbb{C}^2 with 3 or more lines is combinatorially determined. From now on in this section, this will be our setting: $m \geq 3$, L_1, L_2, \ldots, L_m form an essential arrangement of m different lines in \mathbb{C}^2 , and $f_i \in \mathbb{C}[x, y]$ is a polynomial of degree 1 such that $L_i = V(f_i)$ for all $i = 1, \ldots, m$. Let $f = \prod_{i=1}^m f_i$, and let $U \coloneqq \mathbb{C}^2 \setminus (\bigcup_{i=1}^m L_i)$. The infinite cyclic cover $\pi : U^f \to U$ is constructed as the pullback of exp : $\mathbb{C} \to \mathbb{C}^*$ by $f : U \to \mathbb{C}^*$. Moreover, we identify $R = \mathbb{C}[\pi_1(\mathbb{C}^*)]$ with $\mathbb{C}[t^{\pm 1}]$ by taking a positively oriented loop around the origin to t.

Remark 11.3. By [15, Proposition 2.24, Corollary 7.21], there exists $N \in \mathbb{N}$ such that $t^N - 1$ annihilates $H_1(U^f, \mathbb{C})$. Moreover, by [14, Theorem 5], N can be taken to be the least common multiple of all the numbers ≥ 3 which appear as multiplicities of multiple points in the arrangement (so in particular, this choice of N is combinatorially determined).

Remark 11.4. Let N as in Remark 11.3 (given by the least common multiple of the multiplicities greater or equal than 3 of the multiple points in the arrangement), and suppose that $N < m = \deg f$. We may substitute N by $\min\{Nk \mid k \in \mathbb{N}, Nk > m\}$, which is again combinatorially determined.

Let N as in Remark 11.4 (a combinatorially determined number such that $N \ge m$ and $t^N - 1$ annihilates $H_1(U^f, \mathbb{C}))$, and let $\pi_N : U_N \to U$ be the covering space of U obtained via the pullback diagram

(11.5)
$$U_{N} \subset U \times \mathbb{C}^{*} \xrightarrow{f_{N}} \mathbb{C}^{*}$$
$$\downarrow^{\pi_{N}} \stackrel{\neg}{\qquad} \downarrow^{w \mapsto w^{N}}$$
$$U \xrightarrow{f} \mathbb{C}^{*},$$

Notice that if we see U as the affine variety $V(z \cdot f(x, y) - 1) \subset \mathbb{C}^3$, then

$$U_N = \{(x, y, z, w) \in \mathbb{C}^3 \times \mathbb{C}^* \mid zf(x, y) = 1, \quad f(x, y) = w^N\}$$
$$\cong \{(x, y, w) \in \mathbb{C}^2 \times \mathbb{C}^* \mid f(x, y) = w^N\},$$

Let $\widetilde{f}(x,y,z)$ be the homogenization of the polynomial f(x,y). The following is an isomorphism of algebraic varieties

(11.6)
$$V(z^{N-m}\widetilde{f}(x,y,z)=1) \subset \mathbb{C}^3 \quad \longleftrightarrow \quad U_N = \{(x,y,w) \in \mathbb{C}^2 \times \mathbb{C}^* \mid f(x,y)=w^N\} \subset \mathbb{C}^3 \quad (x,y,z) \quad \longmapsto \quad (\frac{x}{z},\frac{y}{z},\frac{1}{z})$$

and under this identification, π_N and f_N in the pullback diagram (11.5) become

$$\pi_N \colon U_N = V(z^{N-m}\widetilde{f}(x,y,z) = 1) \subset \mathbb{C}^3 \longrightarrow U = \mathbb{C}^2 \setminus V(f) \subset \mathbb{C}^2$$
$$(x,y,z) \longmapsto \left(\frac{x}{z}, \frac{y}{z}\right)$$

and

$$f_N \colon U_N = V(z^{N-m}\widetilde{f}(x,y,z) = 1) \subset \mathbb{C}^3 \longrightarrow \mathbb{C}^*$$
$$(x,y,z) \longmapsto \frac{1}{z}$$

respectively. Note that U_N is a (possibly non-reduced) Milnor fiber of an essential central hyperplane arrangement in \mathbb{C}^3 , so it makes sense to talk about $\operatorname{Sp}(z^{N-m}\widetilde{f}(x,y,z))$. Under the identification of R with $\mathbb{C}[t^{\pm 1}]$, the *t*-action on U_N given by Deck transformations of π_N is

$$t: U_N = V(z^{N-m}f(x, y, z) = 1) \subset \mathbb{C}^3 \longrightarrow U_N$$

(x, y, z) $\longmapsto e^{-\frac{2\pi i}{N}}(x, y, z) ,$

which is the inverse of the monodromy of the Milnor fiber.

Theorem 11.7. Let $\{L_1, \ldots, L_m\}$ be a (reduced) essential line arrangement in \mathbb{C}^2 , with $m \geq 3$. Let $f(x,y) \in \mathbb{C}[x,y]$ be a reduced defining polynomial of $\bigcup_{i=1}^{m} L_i$, and let $U = \mathbb{C}^2 \setminus V(f)$. Let $\mathcal{L} = \mathcal{L}$ $f^{-1} \exp_{\mathbb{C}} \mathbb{C}_{\mathbb{C}}$, and let N as Remark 11.4, which is determined by the combinatorics of $\{L_1, \ldots, L_m\}$. Then, the following hold.

- (1) $\dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-p} \frac{H_{2}(U^{f},\mathbb{R})}{(t^{N}-1)H_{2}(U^{f},\mathbb{R})} \neq 0 \Rightarrow p = 0, 1, 2.$ (2) $\dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \frac{H_{2}(U^{f},\mathbb{R})}{(t^{N}-1)H_{2}(U^{f},\mathbb{R})}$ is determined by the combinatorics of $\{L_{1},\ldots,L_{m}\}$.
- (3) $H_2(U^f,\mathbb{R})$ is a free $\mathbb{C}[t^{\pm 1}]$ -module of rank $\chi(U)$, so $\dim_{\mathbb{C}} \frac{H_2(U^f,\mathbb{R})}{(t^{N-1})H_2(U^f,\mathbb{R})} = N\chi(U)$, which is determined by the combinatorics of $\{L_1, \ldots, L_m\}$.
- (4) The following are equivalent:
 - dim_ℂ F⁻¹ H₂(U^f,ℂ)/(t^N-1)H₂(U^f,ℂ) is determined by the combinatorics of {L₁,..., L_m}.
 dim_ℂ F⁻⁰ H₂(U^f,ℂ)/(t^N-1)H₂(U^f,ℂ) is determined by the combinatorics of {L₁,..., L_m}.
 dim_ℂ Tors_R H₁(U^f,ℂ) is determined by the combinatorics of {L₁,..., L_m}.

Proof. The statement in (3) is true by [14, Theorem 4]. The covering $\pi: U^f \to U$ factors through U_N as $\pi_N \circ \pi'$, where $\pi' : U^f \to U_N$ is a covering space. The short exact sequence at the level of singular chains

$$0 \to C_{\bullet}(U^f) \xrightarrow{t^N - 1} C_{\bullet}(U^f) \xrightarrow{(\pi')_*} C_{\bullet}(U_N) \to 0$$

yields the Milnor long exact sequence in homology, which we claim gives rise to the following exact sequences of MHS, where (1) denotes a Tate twist.

$$0 \to \frac{H_2(U^f, \mathbb{C})}{(t^N - 1)H_2(U^f, \mathbb{C})} \to H_2(U_N, \mathbb{C}) \to \operatorname{Tors}_R H_1(U^f, \mathbb{C})(1) \to 0,$$

$$0 \to \operatorname{Tors}_R H_1(U^f, \mathbb{C}) = H_1(U^f, \mathbb{C}) \to H_1(U_N, \mathbb{C}) \to H_0(U^f, \mathbb{C}) = \operatorname{Tors}_R H_0(U^f, \mathbb{C})(1) \to 0,$$

$$0 \to H_0(U^f, \mathbb{C}) = \operatorname{Tors}_R H_0(U^f, \mathbb{C}) \to H_0(U_N, \mathbb{C}) \to 0,$$

Let us see that these are indeed short exact sequences of MHS, where $\operatorname{Tors}_R H_i(U^f, \mathbb{C})$ is endowed with the MHS from [15], $H_1(U_N, \mathbb{C})$ is endowed with Deligne's MHS, and $\frac{H_2(U^f, \mathbb{C})}{(t^N - 1)H_2(U^f, \mathbb{C})}$ is endowed with the MHS from Proposition 8.3. Indeed, $H_i(U^f, \mathbb{C}) = \operatorname{Tors}_R H_i(U^f, \mathbb{C})$ for i = 0, 1 by [14, Theorem 4]. We have that $\frac{H_2(U^f, \mathbb{C})}{(t^N - 1)H_2(U^f, \mathbb{C})} \to H_2(U_N, \mathbb{C})$ is a MHS morphism by Corollary 7.18 and Proposition 8.3, and the rest follows from [17, Corollary 5.9].

The statement in (1) holds by the first of these sequences, because since U_N is smooth, the analogous statement holds for $H_2(U_N, \mathbb{C})$.

The *t*-action is semisimple in all of the homology groups appearing in the three exact sequences above. In the case of U_N , it acts by deck transformations realized by an algebraic isomorphism, so it is a MHS isomorphism in homology. By Theorem 9.1 (and its counterpart for the torsion in [17, Theorem 1.3]) multiplication by *t* is a MHS isomorphism for the rest of those homology groups. The exact sequences above induce exact sequences of MHS in the corresponding eigenspaces, which in turn induce

$$0 \to \operatorname{Gr}_{F}^{-p} \left(\frac{H_{2}(U^{f}, \mathbb{C})}{(t^{N} - 1)H_{2}(U^{f}, \mathbb{C})} \right)_{\lambda} \to \operatorname{Gr}_{F}^{-p} H_{2}(U_{N}, \mathbb{C})_{\lambda} \to \operatorname{Gr}_{F}^{-p+1} \left(\operatorname{Tors}_{R} H_{1}(U^{f}, \mathbb{C}) \right)_{\lambda} \to 0,$$

$$0 \to \operatorname{Gr}_{F}^{-p} \left(\operatorname{Tors}_{R} H_{1}(U^{f}, \mathbb{C}) \right)_{\lambda} \to \operatorname{Gr}_{F}^{-p} H_{1}(U_{N}, \mathbb{C})_{\lambda} \to \operatorname{Gr}_{F}^{-p+1} \left(\operatorname{Tors}_{R} H_{0}(U^{f}, \mathbb{C}) \right)_{\lambda} \to 0,$$

$$\operatorname{Gr}_{F}^{-p} \left(\operatorname{Tors}_{R} H_{0}(U^{f}, \mathbb{C}) \right)_{\lambda} \cong \operatorname{Gr}_{F}^{-p} H_{0}(U_{N}, \mathbb{C})_{\lambda}.$$

By [15, Theorem 10.5], the following hold:

• Tors_R $H_1(U^f, \mathbb{C})_{\neq 1}$ is a pure Hodge structure of weight -1, where the subindex $\neq 1$ denotes the direct sum of all of the eigenspaces of eigenvalue other than 1. Hence,

$$\dim_{\mathbb{C}} \operatorname{Gr}_{F}^{0} \left(\operatorname{Tors}_{R} H_{0}(U^{f}, \mathbb{C}) \right)_{\neq 1} = \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \left(\operatorname{Tors}_{R} H_{0}(U^{f}, \mathbb{C}) \right)_{\neq 1}.$$

- $(\operatorname{Tors}_R H_1(U^f, \mathbb{C}))_1$ is a pure Hodge structure of type (-1, -1), so the only non-zero graded piece is $\operatorname{Gr}_F^{-1}(\operatorname{Tors}_R H_1(U^f, \mathbb{C}))_1$. Moreover, this graded piece has dimension m-1, which is combinatorially determined.
- Tors_R $H_0(U^f, \mathbb{C})$ is a Hodge structure of weight 0 and dimension 1. The only nontrivial eigenspace is the eigenspace of eigenvalue 1, which has dimension 1, and its only nontrivial graded piece is $\operatorname{Gr}_F^0(\operatorname{Tors}_R H_0(U^f, \mathbb{C}))_1$.

Recall from Remark 11.2 that, by Budur and Saito's result, $n_{\tilde{f},\alpha} := \sum_j (-1)^j \dim_{\mathbb{C}} \operatorname{Gr}_F^p \widetilde{H}^j(U_N, \mathbb{C})_{\lambda}$ is a combinatorial invariant, where $\tilde{f}(x, y, z) := z^{N-m} \overline{f}(x, y, z)$, $\lambda = e^{2\pi i \alpha}$, $\widetilde{H}^j(U_N, \mathbb{C})_{\lambda}$ is the eigenspace of eigenvalue λ for the *t*-action on the reduced cohomology groups $\widetilde{H}^j(U_N, \mathbb{C})$ (which is the inverse of the monodromy action), and $p = \lfloor 3 - \alpha \rfloor$. Let $\lambda_l := e^{2\pi i \frac{l}{N}}$ for $l = 1, \ldots, N$ be all the *N*-th roots of unity. We have that

(11.8)
$$n_{\widetilde{f},\frac{l}{N}+(2-p)} = \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-p} H_{2}(U_{N},\mathbb{C})_{\lambda_{l}} - \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-p} H_{1}(U_{N},\mathbb{C})_{\lambda_{l}}$$

is combinatorially determined for all p = 0, 1, 2 (the only possibly non-zero graded pieces). Now, using the exact sequences above, we get that, for all $l \neq N$,

$$\begin{split} n_{\widetilde{f},\frac{l}{N}+2} &= \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{0} \left(\frac{H_{2}(U^{f},\mathbb{C})}{(t^{N}-1)H_{2}(U^{f},\mathbb{C})} \right)_{\lambda_{l}} - \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{0} \left(\operatorname{Tors}_{R} H_{1}(U^{f},\mathbb{C}) \right)_{\lambda_{l}}, \\ n_{\widetilde{f},\frac{l}{N}+1} &= \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \left(\frac{H_{2}(U^{f},\mathbb{C})}{(t^{N}-1)H_{2}(U^{f},\mathbb{C})} \right)_{\lambda_{l}} + \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{0} \left(\operatorname{Tors}_{R} H_{1}(U^{f},\mathbb{C}) \right)_{\lambda_{l}} \\ &- \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \left(\operatorname{Tors}_{R} H_{1}(U^{f},\mathbb{C}) \right)_{\lambda_{l}}, \end{split}$$

and for l = N,

$$n_{\widetilde{f},\frac{l}{N}+2} = \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{0} \left(\frac{H_{2}(U^{f},\mathbb{C})}{(t^{N}-1)H_{2}(U^{f},\mathbb{C})} \right)_{\lambda_{l}},$$
$$n_{\widetilde{f},\frac{l}{N}+1} = \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \left(\frac{H_{2}(U^{f},\mathbb{C})}{(t^{N}-1)H_{2}(U^{f},\mathbb{C})} \right)_{\lambda_{l}} - m$$

Hence, $\dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \frac{H_{2}(U^{f},\mathbb{C})}{(t^{N}-1)H_{2}(U^{f},\mathbb{C})} = \left(\sum_{l=1}^{N} n_{\tilde{f},\frac{l}{N}+1}\right) + m$ is combinatorially determined, which concludes the proof of the statement in (2). For the statement in (4), just note that

$$\dim_{\mathbb{C}} \operatorname{Gr}_{F}^{-1} \frac{H_{2}(U^{f}, \mathbb{R})}{(t^{N} - 1)H_{2}(U^{f}, \mathbb{R})} = \dim_{\mathbb{C}} F^{-1} \frac{H_{2}(U^{f}, \mathbb{R})}{(t^{N} - 1)H_{2}(U^{f}, \mathbb{R})} - \dim_{\mathbb{C}} F^{0} \frac{H_{2}(U^{f}, \mathbb{R})}{(t^{N} - 1)H_{2}(U^{f}, \mathbb{R})}$$

and that

$$\dim_{\mathbb{C}} F^{0} \frac{H_{2}(U^{f}, \mathbb{C})}{(t^{N} - 1)H_{2}(U^{f}, \mathbb{C})} = \dim_{\mathbb{C}} \operatorname{Gr}_{F}^{0} \frac{H_{2}(U^{f}, \mathbb{C})}{(t^{N} - 1)H_{2}(U^{f}, \mathbb{C})}$$
$$= \left(\sum_{l=1}^{N} n_{\tilde{f}, \frac{l}{N} + 2}\right) - \frac{1}{2} \dim_{\mathbb{C}} \left(\operatorname{Tors}_{R} H_{1}(U^{f}, \mathbb{C})\right)_{\neq 1}$$
$$= \left(\sum_{l=1}^{N} n_{\tilde{f}, \frac{l}{N} + 2}\right) - \frac{1}{2} \left(\dim_{\mathbb{C}} \operatorname{Tors}_{R} H_{1}(U^{f}, \mathbb{C}) - (m - 1)\right).$$

The following lemma, when paired with Theorem 11.7, relates the problem of studying the combinatorial nature of the first Betti number of a central hyperplane arrangement to studying the combinatorial nature of the dimension of the filtered pieces of the Hodge filtration of $\frac{H_2(U^f,\mathbb{C})}{(t^N-1)H_2(U^f,\mathbb{C})}$. Note that, by Theorem 11.7, $\frac{H_2(U^f,\mathbb{C})}{(t^N-1)H_2(U^f,\mathbb{C})}$ is a space whose dimension is combinatorially determined and the dimension of one out of its three possible non-zero graded pieces by the Hodge filtration is also combinatorially determined. Both problems are equivalent for central arrangements of planes in \mathbb{C}^3 .

Lemma 11.9. Let $\{H_1, \ldots, H_m\}$ be a (reduced) central arrangement of m different hyperplanes in \mathbb{C}^n , where m > n, and let $\{L_1, \ldots, L_m\}$ a (reduced) line arrangement in \mathbb{C}^2 which is obtained from $\{H_1, \ldots, H_m\}$ after intersection with n-2 generic hyperplanes. Let $f(x, y) \in \mathbb{C}[x, y]$ be a reduced defining polynomial of $\bigcup_{i=1}^m L_i$, and let $U = \mathbb{C}^2 \setminus V(f)$. Let $U^f \to U$ be the pullback by f of $\exp : \mathbb{C} \to \mathbb{C}^*$.

If dim_C Tors_R $H_1(U^f, \mathbb{C})$ is determined by the combinatorics of $\{L_1, \ldots, L_m\}$, then the first Betti number of the Milnor fiber of $\{H_1, \ldots, H_m\}$ is determined by the combinatorics of $\{H_1, \ldots, H_m\}$. Moreover, the other implication holds if n = 3.

Proof. Note that the combinatorics of $\{H_1, \ldots, H_m\}$ determines the combinatorics of $\{L_1, \ldots, L_m\}$ and the other implication also holds if n = 3. By the Lefschetz hyperplane section theorem, $\mathbb{C}^n \setminus (\bigcup_{j=1} H_j)$ can be obtained (up to homotopy equivalence) by attaching cells of dimensions 3 and higher to U.

Consider the commutative diagram



(where f_2 is a reduced defining polynomial of the arrangement $\{H_1, \ldots, H_m\}$). Since f_2 is homogeneous of degree m, $(\mathbb{C}^n \setminus (\cup_{j=1}H_j))^{f_2} \cong (f_2)^{-1}(1) \times \mathbb{C}$. Hence, the inclusion in the commutative diagram above induces an isomorphism $\operatorname{Tors}_R H_1(U^f, \mathbb{C}) = H_1(U^f, \mathbb{C}) \to H_1((f_2)^{-1}(1), \mathbb{C})$. If the dimension of $\operatorname{Tors}_R H_1(U^f, \mathbb{C})$ is determined by the combinatorics of $\{L_1, \ldots, L_m\}$, then the dimension of the first Betti number of the Milnor fiber of the arrangement $\{H_1, \ldots, H_m\}$ is determined by the combinatorics of $\{H_1, \ldots, H_m\}$.
