# SCHWARTZ  $\kappa$ -DENSITIES FOR THE MODULI STACK OF RANK 2 BUNDLES ON A CURVE OVER A LOCAL FIELD

#### ALEXANDER BRAVERMAN, DAVID KAZHDAN, AND ALEXANDER POLISHCHUK

Abstract. Let Bun be the moduli stack of rank 2 bundles with fixed determinant on a smooth proper irreducible curve  $C$  over a local field  $F$ . We show how to associate with a Schwartz  $\kappa$ -density, for  $\text{Re}(\kappa) \geq 1/2$ , a smooth function on the corresponding coarse moduli space of very stable bundles. In the non-archimedean case we also prove that the stack Bun is  $\kappa$ -bounded in the sense of [\[4,](#page-30-0) Def. 2.10] for any  $\kappa \in \mathbb{C}$ .

#### 1. Introduction

Let C be a smooth (connected) proper curve over a local field  $F$  and let G be a reductive group.

The *analytic Langlands correspondence* (that is still only partially understood) is concerned with the study of certain Hecke operators on Schwartz vector spaces associated with the stack of G-bundles over C (see [\[10–](#page-30-1)[12\]](#page-30-2), [\[4\]](#page-30-0) and [\[5\]](#page-30-3)). Conjecturally, these (commuting) operators extend to compact operators on the corresponding Hilbert space with a discrete joint spectrum, which is expected to be related to some "Galois side" objects for the Langlands dual group G<sup>∨</sup>.

In this paper we study the Schwartz spaces  $\mathcal{S}(\text{Bun}_G, |\omega|^{\kappa})$  of  $\kappa$ -densities (where  $\kappa \in \mathbb{C}$ ) on the stack  $Bun_G$  over F. In the non-archimedean case the Schwartz spaces of algebraic stacks were introduced in [\[13\]](#page-30-4) (see also [\[4\]](#page-30-0) and [\[5\]](#page-30-3)). In the archimedean case similar spaces were introduced in [\[15\]](#page-30-5). These Schwartz spaces are defined as inductive limits of the spaces  $\mathcal{S}(X, |p^*\omega|^{\kappa})_{H(F)}$  of coinvariants, where  $[X/H] \to \text{Bun}_G$  is an open substack with X a smooth variety,  $p: X \to \text{Bun}_G$  is the corresponding map, and  $H \simeq \text{GL}_N$  (in the archimedean case taking coinvariants involves taking the closure of the subspace of elements of the form  $hv - v$ ).

Recall that a G-bundle P on C is called very stable if there are no nonzero nilpotent Higgs fields  $\phi \in H^0(C, P_{\mathfrak{g}})$  where  $P_{\mathfrak{g}}$  is the vector bundle corresponding to P and the adjoint representation of G. Let  $M_G^{vs} \subset \text{Bun}_G$  denote the coarse moduli space of very stable bundles. Then [\[4,](#page-30-0) Conjecture 3.5(1)] states in particular that for  $\text{Re}(\kappa) \geq 1/2$ , every Schwartz  $\kappa$ density in  $\mathcal{S}(\text{Bun}_G, |\omega|^{\kappa})$  defines in a natural way a smooth  $\kappa$ -density on  $M_G^{vs}(F)$ . The main result of the present paper is a proof of this Conjecture in the case when  $G = SL_2$  in both archimedean and non-archimedean cases.

Namely, for each line bundle  $L_0$  on C, we consider the stacks  $Bun_{L_0}$  of rank 2 bundles E with  $\det(E) \simeq L_0$  (for trivial  $L_0$  this is exactly  $Bun_{SL_2}$ ), and the open DM-substack of very stable bundles  $\mathcal{M}_{L_0}^{vs} \subset \text{Bun}_{L_0}$ , which is dense if C has genus  $g \geq 2$ . The stack  $\mathcal{M}_{L_0}^{vs}$  is a quotient of a smooth variety  $M_{L_0}^{vs}$  by the trivial action of  $\mu_2$  (so  $M_{L_0}^{vs}$  is also the coarse moduli space of  $\mathcal{M}_{L_0}^{vs}$ ). We prove that for  $\text{Re}(\kappa) \geq 1/2$ , for finite type substacks  $[X/G] \subset \text{Bun}_{L_0}$  (with  $G = GL_N$ ), the integrals of Schwartz  $\kappa$ -densities on  $X(F)$  over Fpoints of very stable G-orbits are absolutely convergent (away from a subset of orbits of measure zero) and define a map

$$
\pi_{\kappa}: \mathcal{S}(\mathrm{Bun}_{L_0},|\omega|^{\kappa}) \to C^{\infty}(M_{L_0}^{vs},|\omega|^{\kappa}),
$$

where in the non-archimedean case the class  $C^{\infty}$  consists of locally constant sections. More precisely, we consider push-forwards of Schwartz  $\kappa$ -densities on  $X(F)$  (restricted to the very stable locus) to  $M^{vs}_{L_0}$  in the sense of distributions, and prove that the obtained distributions are of class  $C^{\infty}$  (see Theorem [6.8\)](#page-28-0).

In addition, in the non-archimedean case we prove a certain boundedness result (an-nounced in [\[4\]](#page-30-0)), Theorem [6.9,](#page-29-0) stating that in the Schwartz spaces  $\mathcal{S}(\text{Bun}_{L_0}, |\omega|^{\kappa})$  one can replace  $\text{Bun}_{L_0}$  by a substack of finite type.

Note that in [\[10\]](#page-30-1) the authors consider in the archimedean case another Schwartz space of half-densities on Bun<sub>G</sub> defined using global (twisted) differential operators on Bun<sub>G</sub>. Conjecturally their space should coincide with the space  $\mathcal{S}(\text{Bun}_G, |\omega|^{1/2})$  used in our paper. This is related to the conjectural statement that the image of  $\pi_{1/2}$  is in  $L^2$  (an archimedean analog of  $[4, \text{Conj. } 3.5(3)]$ .

The paper is organized as follows. In Section [2,](#page-2-0) we gather necessary facts about Schwartz spaces. In the archimedean case we refer to results from [\[1\]](#page-30-6), [\[3\]](#page-30-7) and [\[2\]](#page-30-8). We extend some of these results to the case of Schwartz sections depending holomorphically on a complex parameter. In Section [3,](#page-6-0) we prove a slight extension of [\[7,](#page-30-9) Thm. 6.9], which gives a criterion for an element of the Schwartz coinvariants space to come from an invariant open subset. In Section [4](#page-15-0) we prove a similar surjectivity criterion in the archimedean case, Theorem [4.1,](#page-15-1) which is an extension of  $[2, Thm. B.0.2]$  and is proved in a similar way. In Section [5](#page-21-0) we apply the results of Sections [3](#page-6-0) and [4](#page-15-0) to study the push-forwards of Schwartz  $\kappa$ -densities on a G-variety X to  $U_0/G$ , where  $U_0 \subset X$  is an open subset such that G-acts freely on  $U_0$ and the geometric quotient  $U_0/G$  exists. The main results are Lemma [5.2](#page-22-0) and Lemma [5.4](#page-25-0) which compare properties of such push-forwards for Schwartz  $\kappa$ -densities on X and on a G-invariant open subset  $U \subset X$ . In Section [6,](#page-25-1) we apply these results to the stacks  $Bun_{L_0}$ and their natural filtration by substacks  $\text{Bun}_{L_0}^{\leq n}$  (see [6.1\)](#page-25-2). The main additional ingredient (which is hard to generalize to the case of higher rank) is finding an explicit form of possible specializations of very stable bundles (see Sec. [6.2\)](#page-27-0). The main results, Theorems [6.8](#page-28-0) and [6.9](#page-29-0) are proved in Sec. [6.3.](#page-28-1)

### 2. Schwartz spaces

<span id="page-2-2"></span><span id="page-2-0"></span>2.1. Schwartz spaces for varieties. Let F be a local field. We denote by  $|\cdot|: F^* \to \mathbb{C}^*$ the standard absolute value (so for  $F = \mathbb{C}$  we have  $|z| = z\overline{z}$ , and for a non-archimedean field,  $|a| = q^{-v(a)}$ , where q is the number of elements in the residue field).

For any smooth F-variety X, an (algebraic) line bundle  $L$  over  $X$ , and a continuous character  $\chi : F^* \to \mathbb{C}^*$  we have the corresponding complex line bundle  $L^{\chi}$  over  $X(F)$ . In particular, for  $\kappa \in \mathbb{C}$  we denote by  $|L|^{\kappa}$  the complex line bundle corresponding to the character  $\chi(a) = |a|^{\kappa}$ . Note that for a non-archimedean field F, the topological space  $X(F)$ is an *l*-space<sup>[1](#page-2-1)</sup>, and the transition functions of  $|L|^{\kappa}$  are locally constant.

For example, if  $\omega_X$  is the algebraic line bundle of top forms on X then  $|\omega_X|$  is the line bundle of complex densities on  $X(F)$ .

Assume first that  $F$  is non-archimedean. Then we can define Schwartz spaces of line bundles on  $X(F)$ . More generally, if X is an l-space and L is a complex line bundle on X (so the transition functions of L are are locally constant), we denote by  $C^{\infty}(X, L)$  the space of locally constant sections, and define the Schwartz subspace  $\mathcal{S}(X, L) \subset C^{\infty}(X, L)$ as sections with compact support. These definitions also make sense for arbitrary sheaves of C-vector spaces (see [\[6,](#page-30-10) Sec. 1.3] and Sec. [3.2](#page-7-0) below).

Now consider the archimedean case,  $F = \mathbb{C}$  or  $\mathbb{R}$ . Recall that for any smooth variety X over F, Aizenbud and Gourevitch define in [\[1\]](#page-30-6) the space  $\mathcal{S}(X)$  of Schwartz functions on  $X(F)$  (which agrees with the standard Schwartz space in the case  $X = \mathbb{A}^n$ ). They also define the space of tempered functions  $\mathcal{T}(X)$ , which are smooth functions f such that for any affine open  $U \subset X$  and a polynomial differential operator D on U, the function  $D(f|_U)$  grows at most polynomially. An important property of tempered functions is that for  $f \in \mathcal{T}(X)$ , one has  $f \cdot \mathcal{S}(X) \subset \mathcal{S}(X)$ . Note that for any open embedding  $U \to X$  there is a natural linear embedding  $\mathcal{S}(U) \to \mathcal{S}(X)$ .

Now let V be an algebraic vector bundle over  $X$ ,  $L_1$  and  $L_2$  are algebraic line bundles, and  $\kappa \in \mathbb{C}$ . We consider the corresponding complex vector bundle

$$
E_\kappa\coloneqq V\otimes_F|L_1|^\kappa\otimes |L_2|
$$

over  $X(F)$ . We denote by  $C^{\infty}(X, E_{\kappa})$  the space of smooth sections.

Similarly to [\[1\]](#page-30-6) we can define the Schwartz subspace  $\mathcal{S}(X, E_{\kappa}) \subset C^{\infty}(X, E_{\kappa})$ . Note that  $E_{\kappa}$  is not a Nash bundle, so the definitions of [\[1\]](#page-30-6) do not directly apply. However, we can still mimic the definition of [\[1\]](#page-30-6) by choosing a finite open covering  $(U_i)$  such that  $V|_{U_i}$ ,  $L_1|_{U_i}$  and  $L_2|_{U_i}$  are trivial and considering the linear span of the spaces of  $C^{\infty}$ -sections of  $E_{\kappa}$  coming from the Schwartz sections of the trivial bundles  $E_{\kappa}|_{U_i}$  over  $U_i$  (see Definition [2.2](#page-3-0) below for a similar definition with holomorphic dependence on  $\kappa$ ). One can show that the usual properties still hold for the obtained Schwartz spaces  $\mathcal{S}(X, E_{\kappa})$  using tempered partitions of unity (see [\[1,](#page-30-6) Thm. 5.2.1]) and the fact that the transition functions of  $E_{\kappa}$  are tempered.

<span id="page-2-1"></span><sup>1</sup>This means that it is locally compact, Hausdorff, and every point has a basis of compact open neighborhoods.

2.2. Schwartz sections with holomorphic dependence on a parameter. Let  $X$  be a smooth variety over  $F$ . We can define Schwartz functions on  $X$  depending holomorphically on  $\kappa \in \mathbb{C}$ . Let  $D \subset \mathbb{C}$  be an open region.

**Definition 2.1.** We define  $S^{hol}(X \times D)$  as the space of holomorphic functions on D with values in  $\mathcal{S}(X)$ . By definition, these are functions  $f: D \to \mathcal{S}(X)$ , such that for every continuous linear functional (any functional if F is non-archimedean)  $\varphi : \mathcal{S}(X) \to \mathbb{C}$  the function  $\varphi \circ f$  is holomorphic.

Note that if f is a tempered function on  $X(F)$  (locally constant in the non-archimedean case), then we have a well defined continuous operator on  $S^{hol}(X \times D)$  given by  $\varphi(x,\kappa) \mapsto$  $f(x) \cdot \varphi(x,\kappa)$ .

We can also talk about Schwartz sections of the trivial bundle over  $X$ , depending holomorphically on a parameter  $\kappa \in D$  (and this notion does not change under a tempered change of trivializations).

It is known that in the archimedean case,

$$
\mathcal{S}^{hol}(X \times D) \simeq \mathcal{S}(X) \hat{\otimes} \mathcal{H}(D),\tag{2.1}
$$

where  $\mathcal{H}(D)$  is the space of holomorphic functions on D, and ⊗ is the topological tensor product of nuclear spaces (see [\[14,](#page-30-11) ch.II,§3, n.3, Ex.2,3]).

In the non-archimedean case we have instead

$$
\mathcal{S}^{hol}(X \times D) \simeq \mathcal{S}(X) \otimes \mathcal{H}(D).
$$

Next, we want to consider Schwartz sections of nontrivial vector bundles. Assume first that  $F = \mathbb{R}$  or  $\mathbb{C}$ . As before, let V be an algebraic vector bundle over X,  $L_1$  and  $L_2$  are algebraic line bundles, and

$$
E_\kappa\coloneqq V\otimes_F|L_1|^\kappa\otimes |L_2|,
$$

where  $\kappa \in \mathbb{C}$ .

<span id="page-3-0"></span>Then we can define Schwartz sections of  $E_{\kappa}$ . depending holomorphically on  $\kappa \in D$ .

**Definition 2.2.** We define  $S^{hol}(X \times D, E_{\kappa})$  as the space of smooth sections of  $E_{\kappa}$  over  $X \times D$ , lying in the image of

$$
\bigoplus_i \mathcal{S}^{hol}(U_i \times D, E_{\kappa}|_{U_i}) \to C^{\infty}(X \times D, E_{\kappa})
$$

for some open covering  $(U_i)$  of X such that  $V|_{U_i}$  and  $L_1|_{U_i}$ ,  $L_2|_{U_i}$  are trivial.

The existence of tempered partition of unity shows that this definition does not depend on a choice of an open covering.

If  $F$  is non-archimedean, we can give an analogous definition for the Schwartz space  $\mathcal{S}^{hol}(X \times D, |L_1| \times \otimes |L_2|)$  (i.e., for trivial V).

Note that if  $U \subset X$  is Zariski open then we have a natural embedding (extension by zero),

 $\mathcal{S}^{hol}(U \times D, E_{\kappa}) \to \mathcal{S}^{hol}(X \times D, E_{\kappa}).$ 

Also, for every  $\kappa \in D$  we have a continuous map

$$
\mathcal{S}^{hol}(X \times D, E_{\kappa}) \to \mathcal{S}^{hol}(X, E_{\kappa})
$$

<span id="page-4-1"></span>given by the evaluation at  $\kappa$ .

**Lemma 2.3.** Let  $f: Y \rightarrow X$  be a smooth morphism of algebraic varieties, surjective on F-points, and let  $E'_{\kappa} = f^* E_{\kappa} \otimes |\omega_f|$  (in the nonarchimedean case we assume V to be trivial). Then for each D, the integration map

$$
f_*: \mathcal{S}^{hol}(Y \times D, E'_{\kappa}) \to \mathcal{S}^{hol}(X \times D, E_{\kappa})
$$

is surjective.

*Proof.* Let us give a proof for archimedean  $F$ . The non-archimedean case is analogous but simpler. By the partition of unity, the assertion is local in X, so we can assume that  $E_{\kappa}$  is trivial, and we just need to prove the surjectivity of the map

$$
f_*: \mathcal{S}^{hol}(Y \times D) \to \mathcal{S}^{hol}(X \times D).
$$

But this follows from the surjectivity of  $f_* : \mathcal{S}(Y) \to \mathcal{S}(X)$  (see [\[3,](#page-30-7) Thm. B.2.4]) and from isomorphisms [\(2.1\)](#page-3-1) (using the fact that all the spaces involved are nuclear Frechet spaces).  $\square$ 

<span id="page-4-0"></span>2.3. Schwartz spaces for stacks and coinvariants. We consider admissible smooth algebraic stacks over  $F$  (see [\[5,](#page-30-3) Sec. 2.2]). Recall that they are increasing unions of open substacks of the form  $[X/G]$  where G is a linear algebraic group over F acting on a smooth  $F$ -variety X. The Schwartz spaces can still be defined for line bundles over such stacks. In the non-archimedean case this is done in  $[13]$  (see also  $[5, \text{Sec. } 2.2]$ ). In the archimedean case this is due to Sakellaridis (see [\[15\]](#page-30-5)).

In the case of a quotient stack  $[X/G]$ , where  $G = GL_N$ , the Schwartz spaces  $\mathcal{S}([X/G], |{\mathcal{L}}|^\kappa)$ can be computed as (algebraic) coinvariants of  $\mathcal{S}(X, |L|^{\kappa} \otimes |\Lambda^{top}(\mathfrak{g})|^{-1})$  with respect to the  $G(F)$ -action, where L is the pull-back of L to X. In the archimedean case, the definition of coinvariants  $\mathcal{S}(X, |L|^{\kappa} \otimes |\Lambda^{top}(\mathfrak{g})|^{-1})_{G(F)}$  is slightly different: one has to take the quotient by the closure of the span of elements of the form  $gv - v$ . Note that we can pull out the factor  $|\Lambda^{top}(\mathfrak{g})|^{-1}$  when taking coinvariants since  $G = GL_N$  acts trivially on it.

Similarly, for an open domain  $D \subset \mathbb{C}$ , we define  $S^{hol}([X/G] \times D, |\mathcal{L}|^k)$  as appropriate coinvariants of  $S(X \times D, |L| \sim \otimes |\Lambda^{top}(\mathfrak{g})|^{-1}).$ 

<span id="page-4-2"></span>**Lemma 2.4.** Assume  $G = GL_N$  and F is archimedean. Then there are natural surjective maps

$$
\mathcal{S}(X, |L|^\kappa)_{\mathfrak{g}} \to \mathcal{S}(X, |L|^\kappa)_{G(F)},
$$
  

$$
\mathcal{S}^{hol}(X \times D, |L|^\kappa)_{\mathfrak{g}} \to \mathcal{S}^{hol}(X \times D, |L|^\kappa)_{G(F)},
$$

where we use the usual algebraic coinvariants with respect to the Lie algebra  $\mathfrak{g}$ .

*Proof.* This follows from the fact that  $\mathfrak g$  acts trivially on  $\mathcal S(X,|L|^\kappa)_{G(F)}$  (resp.,  $\mathcal S^{hol}(X\times$  $D, |L|^\kappa)_{G(F)}$ ).  $(\kappa)_{G(F)}$ ). 2.4. Borel's theorem with a holomorphic parameter. Here we assume that  $F = \mathbb{R}$ or C. Let X be a smooth F-variety,  $Z \subset X$  a smooth closed subvariety, and let  $N_Z$ be the normal bundle to Z in X. Let us consider the decreasing filtration on  $S^{hol}(X \times$  $(D, E_{\kappa})$  defined as follows:  $F_Z^i \mathcal{S}^{hol}(X \times D, E_{\kappa})$  consists of  $f(x, \kappa)$  such that for any algebraic differential operator D of order  $\leq i-1$  defined on an open  $U \subset X$ , one has  $Df|_{U \cap Z} = 0$ .

## <span id="page-5-2"></span>Lemma 2.5. One has

$$
F_Z^i \mathcal{S}^{hol}(X \times D, E_{\kappa})/F_Z^{i+1} \mathcal{S}^{hol}(X \times D, E_{\kappa}) \simeq \mathcal{S}^{hol}(Z \times D, S^i N_Z^{\vee} \otimes E|_Z).
$$

Proof. It is clear that the natural map from the left-hand side to the right-hand side is injective. Thus, we need to prove surjectivity. Using partition of unity and local étale coordinates, we can reduce to the case of a trivial bundle E and of an embedding  $Z = \mathbb{A}^k$  $\mathbb{A}^n \times \mathbb{A}^k = X$ . Let us partition coordinates on X as  $(y, z)$  where z are coordinates on Z. Then we can identify  $S^{hol}(Z \times D, S^i N_Z^{\vee})$  with functions  $f(y, z, \kappa)$  which are homogeneous polynomial of degree i in y, with coefficients that are in  $S^{hol}(Z \times D)$ . But we can view such f as elements of  $F_Z^i \mathcal{S}^{hol}(X \times D, E_\kappa)$ .

<span id="page-5-1"></span>We need the following analog of Borel's theorem.

**Proposition 2.6.** For each open subset  $D \subset \mathbb{C}$  let us consider the map

$$
\tau_D: \mathcal{S}^{hol}(X \times D, E_{\kappa})/\mathcal{S}^{hol}((X - Z) \times D, E_{\kappa}) \to \varprojlim \mathcal{S}^{hol}(X \times D, E_{\kappa})/F_Z^i \mathcal{S}^{hol}(X \times D, E_{\kappa}).
$$

Then it is injective, and for any open D' such that  $\overline{D'}$  is compact and is contained in D, the natural restriction map

$$
\lim_{\leftarrow} \mathcal{S}^{hol}(X \times D, E_{\kappa})/F_Z^i \mathcal{S}^{hol}(X \times D, E_{\kappa}) \to \lim_{\leftarrow} \mathcal{S}^{hol}(X \times D', E_{\kappa})/F_Z^i \mathcal{S}^{hol}(X \times D', E_{\kappa})
$$
(2.2)

factors through the image of  $\tau_{D'}$ .

*Proof.* First, we claim that  $S^{hol}((X - Z) \times D, E_{\kappa})$  is exactly the kernel of the map

$$
\widetilde{\tau}_D : \mathcal{S}^{hol}(X \times D, E_{\kappa}) \to \varprojlim \mathcal{S}^{hol}(X \times D, E_{\kappa})/F_Z^i \mathcal{S}^{hol}(X \times D, E_{\kappa}).
$$

Indeed, this immediately follows from the similar statement for a fixed  $\kappa$ .

Thus, it remains to check that the map [\(2.2\)](#page-5-0) factors through the image of  $\tilde{\tau}_{D'}$ . Using partition of unity and local étale coordinates, we reduce to the case of trivial  $E$  and of an embedding  $Z = \mathbb{A}^k \subset \mathbb{A}^n \times \mathbb{A}^k = X$ . Then the element of  $\varprojlim \mathcal{S}^{hol}(X \times D, E_{\kappa})/F_Z^i \mathcal{S}^{hol}(X \times D, E_{\kappa})$  $D, E_{\kappa}$ ) can be viewed as a formal series

$$
f(y,z,\kappa)=\sum_{i\geq 0}f_i(y,z,\kappa),
$$

where  $f_i(y, z, \kappa)$  is a homogeneous polynomial of degree i in y, with coefficients that are in  $S^{hol}(Z \times D)$ . We claim that there exists then  $F(y, z, \kappa) \in S^{hol}(X \times D')$ , such that the formal expansion of F in y is equal to  $f|_{D'}$ . Indeed, this follows from the standard proof of Borel's theorem.

#### 3. Coinvariants for Schwartz sections: non-archimedean case

<span id="page-6-0"></span>3.1. Homology for smooth representations of  $l$ -groups. We use the setup of  $l$ -spaces and l-groups from [\[7\]](#page-30-9) (see also [\[6\]](#page-30-10)).

Let G be an *l*-group,  $\mathcal{H}(G)$  the Hecke algebra of locally constant compactly supported distributions on  $G, \mathcal{M}(G)$  the category of smooth representations of G. Recall that it is equivalent to the category  $\mathcal{M}(\mathcal{H}(G))$  of nondegenerate left  $\mathcal{H}(G)$ -modules (see [\[6,](#page-30-10) Sec. 2.1]). It is known that this category has enough projectives (see [\[6,](#page-30-10) Sec. 2.2]).

<span id="page-6-2"></span>**Lemma 3.1.**  $\mathcal{H}(G)$  is projective as a left  $\mathcal{H}(G)$ -module.

*Proof.*  $\mathcal{H}(G)$  is the direct limit of the projective modules  $\mathcal{H}(G)e_K$ , where  $e_K$  is the idempotent corresponding to a compact open subgroup  $K \subset G$ . Hence, for any  $M \in \mathcal{M}(G)$  we have

$$
\operatorname{Hom}_{\mathcal{H}(G)}(\mathcal{H}(G),M)\simeq \varprojlim_{K}\operatorname{Hom}(\mathcal{H}(G)e_{K},M)=\varprojlim_{K}e_{K}M,
$$

where the maps  $e_K M \to e_{K'} M$  for  $K \subset K'$  are given by the multiplication with  $e_{K'}$ . But these maps are surjective (since  $e_{K'} = e_{K'}e_K$ ), so for an exact sequence  $0 \to M_1 \to M_2 \to$  $M_3 \rightarrow 0$  we get an exact sequence of inverse systems satisfying the Mittag-Leffler condition, which implies that the functor  $\text{Hom}_{\mathcal{H}(G)}(\mathcal{H}(G), \cdot)$  is exact.

For a smooth G-representation M, we denote by  $M<sub>G</sub>$  the space of G-coinvariants. The integration defines a homomorphism  $\mathcal{H}(G) \to \mathbb{C}$ , and we view  $\mathbb{C}$  as a right  $\mathcal{H}(G)$ -module via this homomorphism. It is easy to see that for  $M \in \mathcal{M}(G)$  there is a natural isomorphism

<span id="page-6-1"></span>
$$
M_G \simeq \mathbb{C} \otimes_{\mathcal{H}(G)} M. \tag{3.1}
$$

**Definition 3.2.** We define smooth homology  $H_i^{sm}(G, M)$  of G with coefficients in  $M \in$  $\mathcal{M}(G)$  as the left derived functors of the functor of coinvariants  $M \mapsto M_G$  on the category  $\mathcal{M}(G)$ .

It follows from [\(3.1\)](#page-6-1) that

$$
H_i^{sm}(G,M) \simeq \mathrm{Tor}_i^{\mathcal{H}(G)}(\mathbb{C},M).
$$

**Example 3.3.** If G is a union of compact subgroups then the functor  $M \mapsto M_G$  is exact, so  $H^{sm}_{>0}(G, M) = 0$ .

<span id="page-6-3"></span>**Lemma 3.4.** Let F be a local non-archimedean field,  $G = F^* \times F^n$ , where  $F^*$  acts linearly on  $F^n$ . Let  $\chi : F^* \to \mathbb{C}^*$  be a character, trivial on some open subgroup of  $F^*$ . We denote by  $\mathbb{C}_{\chi}$  the smooth 1-dimensional representation of G, where  $\chi$  extends to G via the projection  $G \rightarrow F^*$ . Assume  $\chi \neq 1$ . Then

$$
H_*^{sm}(G,\mathbb{C}_\chi)=0.
$$

*Proof.* Since  $F^n$  is a union of compact subgroups, this reduces to the case  $G = F^*$ . Moreover, we can replace G by its quotient  $G_0$  by an open compact subgroup. Note that  $G_0$  is an extension of  $\mathbb Z$  by a finite commutative group  $K$ , and we just need to compute the usual homology  $H_*(G_0, \mathbb{C}_\chi)$ . If  $\chi|_K \neq 1$ , the assertion follows from the spectral sequence. In the case  $\chi|_{K} = 1$ , we reduce to the case  $G_0 = \mathbb{Z}$ . Then we immediately compute the homology using the resolution

$$
0 \to \mathbb{C}[t, t^{-1}] \xrightarrow{t-1} \mathbb{C}[t, t^{-1}] \to \mathbb{C} \to 0
$$
  
\n
$$
\mathbb{C}[\mathbb{Z}] = \mathbb{C}[t, t^{-1}].
$$

of the trivial module over  $\mathbb{C}[\mathbb{Z}] = \mathbb{C}[t, t^{-1}].$ 

Now let  $H \subset G$  be a closed subgroup. We denote by

$$
\mathrm{ind}_H^G:\mathcal M(H)\to\mathcal M(G)
$$

the functor of compact induction. It is known that it is an exact functor.

Note that  $\mathcal{H}(G)$  has a natural  $\mathcal{H}(G)$ -bimodule structure, hence, we can view it as an  $\mathcal{H}(G)$  –  $\mathcal{H}(H)$ -bimodule.

For a locally compact group H we denote by  $\Delta_H$  the modular character  $H \to \mathbb{R}^*_{>0}$  (see [\[8,](#page-30-12) 0.5]), [\[7,](#page-30-9) Sec. 1.19]). In the case when  $H = H(F)$ , where F is a local field, and H is a linear algebraic group over F, we have an *algebraic modular character*  $\Delta_H^{alg}$  $_{H}^{alg}: H \rightarrow \mathbb{G}_{m}$ given by the adoint action of H on  $\wedge^{top}$  Lie $(H)^*$ . Then  $\Delta_H$  is the composition of the  $\Delta_H^{alg}$  $_{H}^{alg}(F):H(F)\rightarrow F^*$  with  $|\cdot|:F^*\rightarrow \mathbb{R}_{>0}^*$ .

<span id="page-7-1"></span>**Lemma 3.5.** ( [\[8,](#page-30-12) Thm. 1.4]) For a closed subgroup  $H \subset G$  and  $M \in \mathcal{M}(H)$ , one has a natural isomorphism

$$
\mathrm{ind}_{H}^{G}(M) \simeq \mathcal{H}(G) \otimes_{\mathcal{H}(H)} (M \cdot (\Delta_{H}/\Delta_{G}|_{H})),
$$

<span id="page-7-2"></span>**Lemma 3.6.** The functor  $\text{ind}_{H}^{G}$  takes projectives to projectives.

*Proof.* The right adjoint functor to  $\text{ind}_{H}^{G}$  is given by  $N \to \text{Hom}_{H(G)}(\mathcal{H}(G), N)$ , where the  $\mathcal{H}(H)$ -structure is induced by the right action of  $\mathcal{H}(H)$  on  $\mathcal{H}(G)$ . The assertion follows from the fact that the latter functor is exact since  $\mathcal{H}(G)$  is projective as an object of  $\mathcal{M}(G)$ by Lemma [3.1.](#page-6-2)  $\Box$ 

<span id="page-7-3"></span>**Lemma 3.7.** For  $M \in \mathcal{M}(H)$ , one has a natural isomorphism

$$
H_i^{sm}(G,\mathrm{ind}_H^G M) \simeq H_i^{sm}(H,M\cdot(\Delta_H/\Delta_G|_H)).
$$

*Proof.* For  $i = 0$ , this follows from [\[7,](#page-30-9) Prop. 2.29], or can be deduced from Lemma [3.5](#page-7-1) together with  $(3.1)$ . The general case follows from Lemma [3.6.](#page-7-2)

<span id="page-7-0"></span>3.2. Equivariant sheaves on *l*-spaces. Let G be an *l*-group acting on an *l*-space X. Let  $\mathcal{M}(G, X)$  denote the category of G-equivariant sheaves on X (see [\[6,](#page-30-10) Sec. 1.3]). Recall that a G-equivariant sheaf F on X is equipped with an isomorphism of sheaves on  $G \times X$ ,

$$
\alpha : p^*F \to a^*F,
$$

where  $p: G \times X \to X$  is the projection and  $a: G \times X \to X$  is the action map, satisfying the natural cocycle condition on  $G \times G \times X$ .

If X is a point then  $\mathcal{M}(G, pt)$  is naturally equivalent to  $\mathcal{M}(G)$ , the category of smooth representations of  $G$  (see [\[6,](#page-30-10) Sec. 1.3]).

If  $\pi: X \to Y$  is a continuous map of l-spaces, compatible with actions of G on X and Y, then we have an exact functor

$$
\pi_!:\mathcal{M}(G,X)\to\mathcal{M}(G,Y).
$$

Furthermore, a G-equivariant version of the base change holds, similar to [\[6,](#page-30-10) Sec. 1.3, Prop. 3].

In the case of the projection to the point  $\pi : X \to pt$ , we have  $\pi_1(F) = \mathcal{S}(X, F)$ , the Schwartz space of compactly supported sections of  $F$ , with the natural (smooth) action of G.

If Y has a trivial G-action, then by the base change, for any point  $y \in Y$  and a Gequivariant sheaf F on X, we have an isomorphism in  $\mathcal{M}(G)$ ,

<span id="page-8-0"></span>
$$
(\pi_! F)_y \simeq \mathcal{S}(\pi^{-1}(y), F|_{\pi^{-1}(y)}).
$$
\n(3.2)

If  $H \subset G$  is a closed subgroup, then for  $M \in \mathcal{M}(H)$ , the compactly induced representation  $\operatorname{ind}_{H}^{G} M$  can be identified with the Schwartz space of the corresponding G-equivariant sheaf on  $G/H$ . Hence, we get the following Corollary from Lemma [3.7.](#page-7-3)

<span id="page-8-2"></span>**Corollary 3.8.** Let  $H \subset G$  is a closed subgroup, and let L be a G-equivariant complex line bundle on G/H. Then

$$
H_i^{sm}(G, \mathcal{S}(G/H, L)) \simeq H_i^{sm}(H, \chi_L \cdot (\Delta_H/\Delta_G|_H)),
$$

where  $\chi_L: H \to \mathbb{C}^*$  is the character given by the action of H on the fiber of L at the point with the stabilizer H.

If  $U \subset X$  is an open subset,  $Z = X \setminus U$  the complementary closed subset, then for any sheaf  $F$  on  $X$  we have an exact sequence

$$
0 \to \mathcal{S}(U, F) \to \mathcal{S}(X, F) \to \mathcal{S}(Z, F|_Z) \to 0
$$

(see [\[6,](#page-30-10) Sec. 1.3, Prop. 4]). We also have the following co-Cech complexes associated with open coverings.

<span id="page-8-1"></span>**Lemma 3.9.** For any open covering  $(U_i)$  of X and any G-equivariant sheaf F on X, where each  $U_i$  is  $G$ -invariant, we have an exact sequence of smooth  $G$ -representations

$$
\dots \bigoplus_{i,j} \mathcal{S}(U_{ij}, F) \to \bigoplus_i \mathcal{S}(U_i, F) \to \mathcal{S}(X, F) \to 0,
$$

in which the differentials are defined in a dual way to the Cech complex (see  $(16, Sec.$  $21.8$ .

*Proof.* This follows from the exactness of the functor  $\mathcal{S}(X, \cdot)$  and the exactness of the corresponding sheafified complex, where we use the direct sums of sheaves of the form  $j_1F|_U$ , for  $j: U \hookrightarrow X$  with  $U = U_{i_1...i_k}$ . .

It is well known that sheaves of  $\mathbb{C}\text{-vector spaces on an }l\text{-space }Y$  correspond to nondegenerate  $\mathcal{S}(Y)$ -modules (see [\[6,](#page-30-10) Sec. 1.3]), while smooth G-representations correspond to nondegenerate  $\mathcal{H}(G)$ -modules, where  $\mathcal{H}(G)$  is the Hecke algebra. We can get a similar description for the category of  $G$ -equivariant sheaves on Y, where  $G$  acts trivially on Y.

**Definition 3.10.** We say that an  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ -module M is *strongly nondegenerate* if  $\mathcal{H}(G)M = M$  and  $\mathcal{S}(Y)M = M$ .

**Lemma 3.11.** If Y has a trivial G-action then the functor  $F \mapsto \mathcal{S}(Y, F)$  gives an equivalence of  $\mathcal{M}(G, Y)$  with the category of strongly nondegenerate  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ -modules M. Under this equivalence the functor of push-forward to the point  $F \mapsto \mathcal{S}(Y, F) \in \mathcal{M}(G)$  corresponds to restricting the module structure to  $\mathcal{H}(G)$ . Also, for each point  $y \in Y$ , the stalk functor  $F \mapsto F_y \in \mathcal{M}(G)$  corresponds to the functor  $M \mapsto M \otimes_{\mathcal{S}(Y)} \mathbb{C}_y$ , where  $\mathbb{C}_y$  is the  $S(Y)$ -module corresponding to the homomorphism  $ev_y : S(Y) \to \mathbb{C}$  of evaluation at y.

*Proof.* Let us denote by  $\mathcal{M}(\mathcal{H}(G) \otimes \mathcal{S}(Y))$  the category of nondegenerate  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ modules. First, we observe that the functor  $F \mapsto \mathcal{S}(Y, F)$  can be enriched to a functor

$$
\mathcal{M}(G,Y)\to \mathcal{M}'(\mathcal{H}(G)\otimes \mathcal{S}(Y)).
$$

Indeed, the nondegenerate  $\mathcal{S}(Y)$ -module  $\mathcal{S}(Y, F)$  has a G-action commuting with the  $\mathcal{S}(Y)$ -module structure, and  $\mathcal{S}(Y, F)$  is a smooth G-representation. Hence,  $\mathcal{S}(Y, F)$  has a nondegenerate  $\mathcal{H}(G)$ -module structure commuting with the  $\mathcal{S}(Y)$ -module structure, i.e., it becomes a strongly nondegenerate  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ -module.

Conversely, starting with  $M \in \mathcal{M}'(\mathcal{H}(G) \otimes \mathcal{S}(Y))$ , we get a sheaf F on Y with  $\mathcal{S}(Y, F)$  = M, and we can use the smooth G-action on M to get a G-equivariant structure on  $F$ . Namely, we know that M corresponds to a G-equivariant sheaf on a point, which is given by a map of  $\mathcal{S}(G)$ -modules,

$$
\alpha : \mathcal{S}(G) \otimes M \to \mathcal{S}(G) \otimes M
$$

satisfying a certain cocycle condition. But the map  $\alpha$  commutes with the  $\mathcal{S}(Y)$ -module structures, hence, it corresponds to a map  $p^*F \to p^*F$  of sheaves on  $G \times X$ , so it gives a G-equivariant structure on F.

Assume Y has a trivial G-action. For each open compact subgroup  $K \subset G$  and each open compact  $L \subset Y$ , let  $P_{K,L}$  denote the object of  $\mathcal{M}(G, Y)$  corresponding to the strongly nondegenerate  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ -module  $\mathcal{H}(G)e_K \otimes \mathcal{S}(Y)e_L$ , where  $e_K \in \mathcal{H}(G)$  (resp.,  $e_L \in$  $\mathcal{S}(Y)$ ) is the idempotent corresponding to K (resp., L).

<span id="page-9-0"></span>**Lemma 3.12.** The objects  $P_{K,L} \in \mathcal{M}(G,Y)$  are projective. For every object F of  $\mathcal{M}(G,Y)$ there is a surjective from a direct sum of some  $P_{K,L}$  to F. For every point  $y \in Y$ , the stalk  $(P_{K,L})$ <sub>y</sub> is a projective  $\mathcal{H}(G)$ -module. Also,  $\mathcal{S}(Y, P_{K,L})$  is a projective  $\mathcal{H}(G)$ -module.

*Proof.* It is clear that the  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ -module  $\mathcal{H}(G)e_K \otimes \mathcal{S}(Y)e_L$  is projective since  $Hom(\mathcal{H}(G)e_K \otimes \mathcal{S}(Y)e_L, M) = (e_K \otimes e_L)M$ . Furthermore, since for a strongly nondegenerate  $\mathcal{H}(G) \otimes \mathcal{S}(Y)$ -module M, every  $x \in M$  is contained in  $(e_K \otimes e_L)M$  for some  $(K, L)$ , there is a surjection from a direct sum of some  $\mathcal{H}(G)e_K \otimes \mathcal{S}(Y)e_L$  to M.

The stalks of  $P_{K,L}$  are given by

$$
(P_{K,L})_y \simeq (\mathcal{H}(G)e_K) \otimes (\mathcal{S}(Y)e_L) \otimes_{\mathcal{S}(M)} \mathbb{C}_y) \simeq \begin{cases} \mathcal{H}(G)e_K, & y \in L \\ 0, & y \notin L, \end{cases}
$$

so they are projective  $\mathcal{H}(G)$ -modules.

Finally, viewed as an  $\mathcal{H}(G)$ -module,  $\mathcal{H}(G)e_K \otimes \mathcal{S}(Y)e_L$  is a direct sum of copies of  $\mathcal{H}(G)e_K$ , hence it is projective.

Still assuming that Y has a trivial  $G$ -action let us consider the functor of  $G$ -coinvariants

$$
\mathcal{M}(G,Y)\to \mathcal{M}(Y):F\mapsto F_G,
$$

which corresponds to the functor  $M \mapsto \mathbb{C} \otimes_{\mathcal{H}(G)} M$  on strongly nondegenerate  $\mathcal{H}(G) \otimes \mathcal{S}(M)$ modules. Thus, by definition  $\mathcal{S}(Y, F_G) = \mathcal{S}(Y, F)_G$ . We denote by  $F \mapsto H_i(G, F)$  the left derived functors  $\mathcal{M}(G, Y) \to \mathcal{M}(Y)$ .

<span id="page-10-0"></span>**Lemma 3.13.** Assume Y has a trivial G-action. Then for  $F \in \mathcal{M}(G, Y)$  and  $y \in Y$ , we have natural isomorphisms

$$
H_i(G, F)_y \simeq H_i(G, F_y),
$$
  

$$
\mathcal{S}(Y, H_i(G, F)) \simeq H_i(G, \mathcal{S}(Y, F)).
$$

*Proof.* For  $i = 0$  the first isomorphism is [\[7,](#page-30-9) Prop. 2.36] and the second holds by definition. The general case follows from Lemma [3.12](#page-9-0) by considering projective resolutions consisting of direct sums of objects  $P_{K,L}$ .

Now assume we have an *l*-space X with an action of an *l*-group  $G$  and a continuous map of l-spaces  $\pi : X \to Y$ , such that  $\pi(gx) = \pi(x)$  (so it is G-equivariant, where G acts trivially on  $Y$ ).

<span id="page-10-1"></span>**Lemma 3.14.** For a G-equivariant sheaf F on X and a point  $y \in Y$ , we have natural isomorphisms

$$
H_i(G, \pi_! F)_y \simeq H_i(G, \mathcal{S}(\pi^{-1}(Y), F|_{\pi^{-1}(y)})).
$$

*Proof.* Set  $F' \coloneqq \pi_! F \in \mathcal{M}(G, Y)$ . By Lemma [3.13,](#page-10-0) we have

$$
H_i(G, F')_y \simeq H_i(G, F'_y).
$$

It remains to apply the isomorphism  $(3.2)$ .

Recall that the graph of a G-action on X is the image of the map  $G \times X \to X \times X$ :  $(g, x) \mapsto (x, gx).$ 

<span id="page-10-3"></span>**Definition 3.15.** An action of an *l*-group G on an *l*-space X is called *locally separated* (resp., separated) if the graph of the action in  $X \times X$  is locally closed (resp., closed). By [\[7,](#page-30-9) Lem. 6.2], this is equivalent to requiring that the diagonal in  $(X/G) \times (X/G)$  is locally closed (resp., closed).

Note that in [\[7\]](#page-30-9) separated group actions are called regular. By [\[7,](#page-30-9) Lem. 6.4], if the action of G on X is separated then the quotient  $X/G$  is an l-space.

<span id="page-10-2"></span>**Proposition 3.16.** Assume that the action of G on X is locally separated, and let F be a G-equivariant sheaf on X. Fix  $i_0 \geq 0$ . Assume that for every G-orbit  $\Omega \subset X$ , one has  $H_i(G, \mathcal{S}(\Omega, F|_{\Omega})) = 0$  for  $i \leq i_0$ . Then  $H_i(G, \mathcal{S}(X, F)) = 0$  for  $i \leq i_0$ .

*Proof.* Assume first that the action of G on X is separated, set  $Y = X/G$ , and let  $\pi : X \to Y$ be the natural projection, so that the fibers of  $\pi$  are exactly G-orbits.

Set  $F' \coloneqq \pi_! F \in \mathcal{M}(G, Y)$ . By Lemma [3.14,](#page-10-1) our assumption implies that the sheaf  $H_i(G, F')$  has zero stalks, hence it is zero. Now using Lemma [3.13,](#page-10-0) we get

$$
H_i(G, \mathcal{S}(X, F)) \simeq H_i(G, \mathcal{S}(Y, F')) \simeq \mathcal{S}(Y, H_i(G, F')) = 0.
$$

Now consider the general case when the action of  $G$  on  $X$  is locally separated. Then the diagonal in  $(X/G) \times (X/G)$  is closed in a neighborhood of every point  $(\overline{x}, \overline{x})$ . Hence, there exists an open neighborhood  $\overline{U}$  of  $\overline{x}$  in  $X/G$ , such that the diagonal is closed in  $\overline{U} \times \overline{U}$ . The preimage  $U \subset X$  of  $\overline{U}$  is a G-equivariant open subset such that the action of G on U is separated. Hence, there exists an open covering  $(U_i)$  of X such that  $U_i$  are G-invariant and the action of G on each  $U_i$  is separated. It follows that the action of G on each  $U_{i_1...i_k} = U_{i_1} \cap ... U_{i_k}$  is separated, and so by the first part of the argument,

$$
H_i(G, \mathcal{S}(U_{i_1...i_k}, F)) = 0
$$

for  $i \leq i_0$ . Now the similar vanishing for  $H_i(G, \mathcal{S}(X, F))$  follows from the long exact sequence of smooth G-representations

$$
\dots \bigoplus_{i,j} \mathcal{S}(U_{ij}, F) \to \bigoplus_i \mathcal{S}(U_i, F) \to \mathcal{S}(X, F) \to 0
$$

<span id="page-11-0"></span>(see Lemma [3.9\)](#page-8-1).

3.3. Adding a coefficient ring. Let X be an *l*-space,  $G$  an *l*-group. Instead of considering G-equivariant sheaves of  $\mathbb C$ -vector spaces on X as before, we can consider the category  $\mathcal{M}(G, X; R)$  of G-equivariant sheaves of R-modules on X, where R is a commutative Calgebra.

All the results of Section [3.2](#page-7-0) extend naturally to this setup. For example, in the case when G acts trivially on X, the category  $\mathcal{M}(G, X; R)$  is equivalent to the category of strongly nondegenerate  $R \otimes \mathcal{H}(G) \otimes \mathcal{S}(X)$ -modules.

**Definition 3.17.** An R-line bundle over X is a sheaf  $\mathcal L$  of R-modules such that for some open covering  $(U_i)$  we have an isomorphism of  $\mathcal{L}|_{U_i}$  with the sheaf of R-valued locally constant functions. Thus, such  $\mathcal L$  is given by the transition functions  $f_{ij}$  which are locally constant R<sup>\*</sup>-valued functions on  $U_i \cap U_j$ . For an extension of rings  $R \to R'$  and an R-line bundle  $\mathcal{L}$ , we have a natural R'-line bundle  $\mathcal{L} \otimes_R R'$ , given by the same transition functions via the embedding  $R \hookrightarrow R'$ .

Let us describe the main example of an R-line bundle we are interested in (for the coefficent ring  $R = \mathbb{C}[t, t^{-1}]$ . Consider the homomorphism

$$
F^* \to \mathbb{C}[t, t^{-1}]^* : x \mapsto |x|_t := t^{-v(x)},
$$

where  $|x| = q^{-v(x)}$ . Suppose  $X = \underline{X}(F)$ , where  $\underline{X}$  is an F-variety, and L is an algebraic line bundle on <u>X</u>. Then we can construct an  $\mathbb{C}[t,t^{-1}]$ -line bundle  $|L|_t$  on X as follows. Let  $(\underline{U_i})$ be an open covering such that L is glued from trivial line bundles on  $U_i$  using transition

functions  $f_{ij} \in \mathcal{O}^*(\underline{U_i})$ . Then we glue  $|L|_t$  out of sheaves of locally constant  $\mathbb{C}[t, t^{-1}]$ -valued functions on  $U_i = \overline{U_i}(F)$  using  $|f_{ij}|_t$  as  $\mathbb{C}[t, t^{-1}]^*$ -valued transition functions.

For any open region  $D \subset \mathbb{C}$ , we have a natural embedding of  $\mathbb{C}$ -algebras,

$$
\mathbb{C}[t,t^{-1}] \hookrightarrow \mathcal{H}(D): t \mapsto q^{\kappa},
$$

and the corresponding embedding

$$
\mathcal{S}(X, |L|_t) \hookrightarrow \mathcal{S}(X, |L|_t \otimes \mathcal{H}(D)) \simeq \mathcal{S}^{hol}(X \times D, |L|^\kappa).
$$

For  $c \in \mathbb{C}^*$ , we can consider the localization

$$
R_c \coloneqq \mathbb{C}[t, t^{-1}][\frac{1}{t-c}].
$$

Then if  $q^k \neq c$  on the region  $D \subset \mathbb{C}$ , the above embeddings extend to

$$
R_c \hookrightarrow \mathcal{H}(D), \quad \mathcal{S}(X, |L|_t \otimes_{\mathbb{C}[t,t^{-1}]} R_c) \hookrightarrow \mathcal{S}^{hol}(X \times D, |L|^\kappa).
$$

<span id="page-12-2"></span>We have the following analog of Lemma [3.4.](#page-6-3)

**Lemma 3.18.** Let  $\chi : G \to \mathbb{C}[t, t^{-1}]^*$  be a locally constant homomorphism. Assume that there exists a closed embedding  $F^* \hookrightarrow G$ , such that

$$
\chi|_{F^*}(x) = t^{-v(x)} \cdot c^{v(x)},
$$

for some  $c \in \mathbb{C}^*$ . Let R be an  $R_c$ -algebra. Then viewing  $\chi$  as a homomorphism  $G \to R^*$ , we have

$$
H_0^{sm}(G,R_\chi)=0,
$$

where  $R_{\chi}$  is R with the G-action given by  $\chi$ . Assume in addition that  $G = F^* \times F^n$ , and  $\chi$ is trivial on  $F^n$ . Then  $H_*^{sm}(G, R_\chi) = 0$ .

Proof. The proof is completely parallel to that of Lemma [3.4.](#page-6-3) We just have to use the fact that  $t/c - 1$  is invertible in  $R_c$ .  $\Box$ 

We also have the following versions of Corollary [3.8](#page-8-2) and Proposition [3.16.](#page-10-2) The proofs are similar, so we omit them.

<span id="page-12-1"></span>**Corollary 3.19.** Let R be a commutative C-algebra. For a closed subgroup  $H \subset G$  a  $G$ -equivariant R-line bundle L on  $G/H$ , one has

$$
H_i^{sm}(G, \mathcal{S}(G/H, L)) \simeq H_i^{sm}(H, \chi_L \cdot (\Delta_H/\Delta_G|_H)),
$$

where  $\chi_L: H \to R^*$  is the character given by the action of H on the fiber of L at the point with the stabilizer H (and we view  $\Delta_H/\Delta_G|_H$  as taking values in  $\mathbb{C}^* \subset R^*$ ).

<span id="page-12-0"></span>**Proposition 3.20.** Assume that the action of G on X is locally separated, and let F be a G-equivariant sheaf of R-modules on X (where R is a commutative ring). Fix  $i_0 \geq 0$ . Assume that for every G-orbit  $\Omega \subset X$ , one has  $H_i(G, \mathcal{S}(\Omega, F|_{\Omega})) = 0$  for  $i \leq i_0$ . Then  $H_i(G, \mathcal{S}(X, F)) = 0$  for  $i \leq i_0$ .

3.4. An extension result for coinvariants of Schwartz sections. We formulate a general result in the framework of l-spaces and l-groups, which extends the classical [\[7,](#page-30-9) Thm. 6.9] on invariant distributions.

<span id="page-13-0"></span>**Theorem 3.21.** Let X be an l-space equipped with action of an l-group  $G$ ,  $Z \subset X$  be a  $G$ invariant closed subset. Assume that the action of  $G$  on  $Z$  is constructible (i.e., the graph of the action in  $Z \times Z$  is constructible). Let R be a commutative ring, L a G-equivariant R-line bundle on X. Assume that for every  $z \in Z$ , one has

<span id="page-13-2"></span>
$$
H_i^{sm}(G_z, \chi_{L,z} \cdot \Delta_{G_z}/\Delta_G|_{G_z}) = 0 \tag{3.3}
$$

for  $i = 0, 1$  (resp., for  $i = 0$ ), where  $G_z$  is the stabilizer of  $z \in Z$ . Then the natural map

$$
\mathcal{S}(X - Z, L)_{G} \to \mathcal{S}(X, L)_{G}
$$
\n
$$
(3.4)
$$

is an isomorphism (resp., surjective).

Note that by [\[7,](#page-30-9) Sec. 6.15], the condition of constructibility of action is satisfied if  $G = G(F)$ ,  $X = X(F)$ , where X is a variety over a local field F, G is a linear algebraic group over  $F$  acting algebraically on  $\underline{X}$ .

<span id="page-13-1"></span>**Lemma 3.22.** Assume that the action of  $G$  on  $Z$  is constructible. Then there exists a filtration  $Z = Z^0 \supset Z^1 \supset \ldots \supset Z^k = \emptyset$  by closed G-invariant subsetss, such that the action of G on  $Z^i \setminus Z^{i+1}$  is locally separated (see Def. [3.15\)](#page-10-3).

*Proof.* Set  $\overline{Z} = Z/G$  and let us consider the diagonal  $\Delta \subset \overline{Z} \times \overline{Z}$ . As in [\[7,](#page-30-9) Sec. 6.7], let us consider the finite filtration  $\Delta \supset \Delta^1 \supset \ldots \supset \Delta^k = \emptyset$  by closed subsets, defined recursively as follows:  $\Delta^{i+1}$  is the set of points  $(\overline{z}, \overline{z}) \in \Delta^i$  such that  $\Delta^i$  is not closed in any neighborhood of  $(\overline{z}, \overline{z})$  (in  $\overline{Z} \times \overline{Z}$ ). By the identification  $\Delta \simeq \overline{Z}$  we get a filtration  $\overline{Z} \supset \overline{Z}^1 \supset \dots$  of  $\overline{Z}$ . We claim that the corresponding filtration of  $Z$  by  $G$ -invariant closed subspaces satisfies our requirement. Indeed, by definition,  $\Delta^i \setminus \Delta^{i+1}$  is locally closed in  $\overline{Z} \times \overline{Z}$ , hence, in  $(Z^i \setminus Z^{i+1}) \times (Z^i \setminus Z^{i+1})$ . Therefore, the diagonal is locally closed in  $(Z^i \setminus Z^{i+1}) \times (Z^i \setminus Z^{i+1})$ , and so the action of  $G$  on  $Z^i \setminus Z^{i+1}$  is locally separated. and so the action of  $G$  on  $Z^i \setminus Z^{i+1}$  is locally separated.

Proof of Theorem [3.21.](#page-13-0) The exact sequence of smooth G-representations

$$
0 \to \mathcal{S}(X - Z, L) \to \mathcal{S}(X, L) \to \mathcal{S}(Z, L|_Z) \to 0
$$

and the long exact sequence of smooth G-homology show that it is enough to prove the vanishing

$$
H_i^{sm}\bigl(G,\mathcal S\bigl(Z,L|_Z\bigr)\bigr)=0
$$

for  $i = 0, 1$  (resp.,  $i = 0$ ).

Using Lemma [3.22](#page-13-1) we reduce to the case when the action of  $G$  on  $Z$  is locally separated. Now applying Proposition [3.20,](#page-12-0) we are reduced to showing that for each G-orbit  $\Omega \subset Z$ , one has

$$
H^{sm}_i\bigl(G,\mathcal S\bigl(\Omega,L|_{\Omega}\bigr)\bigr)=0
$$

for  $i = 0, 1$  (resp.,  $i = 0$ ). It remains to apply Corollary [3.19](#page-12-1) and the vanishing [\(3.3\)](#page-13-2) for  $i = 0, 1$  (resp.,  $i = 0$ ). 3.5. Corollary for admissible stacks. Let  $\mathcal{X} = [X/G]$  be an admissible stack of finite type over F (where F is a nonarchimedean local field,  $G = GL_N$ ),  $\mathcal L$  a line bundle on  $\mathcal X, L$ the corresponding  $G$ -equivariant line bundle on  $X$ .

We can associate with L and with a number  $\kappa \in \mathbb{C}$ , a  $G(F)$ -equivariant C-line bundle  $|L|^{\kappa}$  on  $X(F)$ , and by passing to  $G(F)$ -coinvariants, the Schwartz space  $\mathcal{S}(\mathcal{X},|\mathcal{L}|^{\kappa})$  (see Sec. [2.3\)](#page-4-0). On the other hand, we can define a  $G(F)$ -equivariant  $\mathbb{C}[t,t^{-1}]$ -line bundle  $|L|_t$ on  $X(F)$  and a  $\mathbb{C}[t,t^{-1}]$ -module  $\mathcal{S}(\mathcal{X},|\mathcal{L}|_t)$  defined as  $G(F)$ -coinvariants of  $\mathcal{S}(X(F),|L|_t)$ (see Sec. [3.3\)](#page-11-0).

For an open substack  $\mathcal{U} \subset \mathcal{X}$  and  $\kappa \in \mathbb{C}$ , there is a natural map

$$
j_{\mathcal{U}\rightarrow\mathcal{X},\mathcal{L},\kappa}:\mathcal{S}(\mathcal{U},|\mathcal{L}|^{\kappa})\rightarrow\mathcal{S}(\mathcal{X},|\mathcal{L}|^{\kappa}).
$$

Also, for every commutative  $\mathbb{C}[t, t^{-1}]$ -algebra R, we can consider a natural map

$$
j_{\mathcal{U}\rightarrow\mathcal{X},\mathcal{L}}^R:\mathcal{S}(\mathcal{U},|\mathcal{L}|_t\otimes R)\rightarrow\mathcal{S}(\mathcal{X},|\mathcal{L}|_t\otimes R).
$$

For every point  $x \in \mathcal{X}$ , the action of the group Aut $(x)$  on the line bundle  $\mathcal{L}$  gives a character

$$
\chi_{\mathcal{L},x} : \mathrm{Aut}(x) \to \mathbb{G}_m.
$$

On the other hand, we have the algebraic modular character  $\Delta_{\text{Aut}(x)}^{alg}$ : Aut $(x) \to \mathbb{G}_m$ .

For a character  $\chi: \text{Aut}(x) \to \mathbb{G}_m$  and a cocharacter  $\lambda^{\vee}: \mathbb{G}_m \to \text{Aut}(x)$ , we define an integer  $m = \langle \chi, \lambda^{\vee} \rangle$  so that

$$
\chi(\lambda^{\vee}(a)) = a^m.
$$

<span id="page-14-0"></span>**Lemma 3.23.** (i) Fix  $\kappa \in \mathbb{C}$ . Assume that for every point  $x \in \mathcal{X}(F) \setminus \mathcal{U}(F)$ , there exists an algebraic homomorphism  $\lambda^{\vee}$ :  $\mathbb{G}_m \to \text{Aut}(x)$  (defined over F), such that

$$
q^{\kappa\cdot\left(\chi_{\mathcal{L},x},\lambda^\vee\right)}\neq q^{-\left\langle\Delta_{\mathrm{Aut}(x)}^{alg},\lambda^\vee\right\rangle},
$$

where q is the number of elements in the residue field. Then  $j_{\mathcal{U}\to\mathcal{X},\mathcal{L},\kappa}$  is surjective. Assume in addition that for each  $x \in \mathcal{X}(F) \setminus \mathcal{U}(F)$ , we have  $\text{Aut}(x) \simeq \mathbb{G}_m \ltimes \mathbb{G}_a^n$ , where  $\lambda^{\vee} : \mathbb{G}_m \to$ Aut(x) given by the natural embedding. Then  $j_{\mathcal{U}\rightarrow\mathcal{X},\mathcal{L},\kappa}$  is an isomorphism.

(ii) Let R be a commutative  $\mathbb{C}[t,t^{-1}]$ -algebra. Assume that for every point  $x \in \mathcal{X}(F) \setminus \mathcal{U}(F)$ , there exists an algebraic homomorphism  $\lambda^{\vee}$ :  $\mathbb{G}_m \to \text{Aut}(x)$ , such that

$$
t^{\langle \chi_{\mathcal{L},x},\lambda^\vee\rangle}-q^{-\langle \Delta_{\mathrm{Aut}(x)}^{\mathrm{alg}},\lambda^\vee\rangle}\in R^*.
$$

Then the map  $j_{\mathcal{U}\to\mathcal{X},\mathcal{L}}^R$  is surjective. If in addition  $\text{Aut}(x) \simeq \mathbb{G}_m \ltimes \mathbb{G}_a^n$  and  $\lambda^{\vee} : \mathbb{G}_m \to \text{Aut}(x)$ is given by the natural embedding, then  $j_{\mathcal{U}\rightarrow\mathcal{X},\mathcal{L}}^R$  is an isomorphism.

(iii) Let  $D \subset \mathbb{C}$  be an open region. Assume that for every point  $x \in \mathcal{X}(F) \setminus \mathcal{U}(F)$ , there exists an algebraic homomorphism  $\lambda^{\vee} : \mathbb{G}_m \to \text{Aut}(x)$ , such that

$$
\operatorname{Re}(\kappa) \cdot (\chi_{\mathcal{L},x}, \lambda^{\vee}) \neq (-\Delta_{\operatorname{Aut}(x)}^{alg}, \lambda^{\vee})
$$

for every  $\kappa \in D$ . Then the map

$$
j_{\mathcal{U}\to\mathcal{X},\mathcal{L}}^{hol}(\mathcal{U}\times D,|\mathcal{L}|^{\kappa})\to\mathcal{S}^{hol}(\mathcal{X}\times D,|\mathcal{L}|^{\kappa})
$$

is surjective.

*Proof.* (i) Let  $U \subset X$  be the G-invariant open subset corresponding to  $\mathcal{U} \subset \mathcal{X}$ . For  $x \in X(F)$ , we have  $\text{Aut}_\mathcal{X}(x) = G_x \subset G$ , the stabilizer of x. Since  $\Delta_{G(F)} = 1$ , by Theorem [3.21,](#page-13-0) to check that  $j_{\mathcal{U}\to\mathcal{X},\mathcal{L},\kappa}$  surjective (resp., an isomorphism), we need to know that

$$
H_i^{sm}(G_x(F), |\chi_{\mathcal{L},x}|^{\kappa} \cdot |\Delta_{G_x}^{alg}|) = 0
$$

for  $x \notin U(F)$  and  $i = 0$  (resp.,  $i \leq 1$ ). For  $i = 0$  we are just computing the coinvariants, and the assumption implies that the corresponding character  $G_x(F) \to \mathbb{C}^*$  is nontrivial. To compute higher homology we use the extra assumption on the structure of  $\text{Aut}(x)$  and apply Lemma [3.4.](#page-6-3)

(ii) This is parallel to (i) using Lemma [3.18.](#page-12-2)

<span id="page-15-0"></span>(iii) This follows from (ii) with  $R = \mathcal{H}(D)$ , viewed as a  $\mathbb{C}[t, t^{-1}]$ -algebra via  $t \mapsto q$ <sup>κ</sup>.

## 4. Coinvariants for Schwartz sections: archimedean case

4.1. Formulation of the extension result and the first reduction. Now we assume that  $F = \mathbb{R}$  or  $\mathbb{C}$ . We want to prove the following version of [\[2,](#page-30-8) Thm. B.0.[2](#page-15-2)]<sup>2</sup>.

<span id="page-15-1"></span>**Theorem 4.1.** Let X be the set of F-points of a smooth algebraic F-variety equipped with an algebraic action of a connected linear algebraic group  $G$  (over  $F$ ) with the Lie algebra g, and let  $Z \subset X$  be a G-invariant closed subvariety. Let V (resp.,  $L_1, L_2$ ) be an algebraic G-equivariant vector bundle (resp., line bundles) over X. As in Sec. [2.1,](#page-2-2) consider  $E_{\kappa} = V \otimes |L_1|^{\kappa} \otimes |L_2|$ , where  $\kappa \in \mathbb{C}$ . For  $z \in Z$  we denote by  $G_z \subset G$  the stabilizer subgroup, and by  $\mathfrak{g}_z$  its Lie algebra. Let  $\chi_{L_i,z}: G_z \to \mathbb{G}_m$  denote the character of action on  $L|_z$ . Let D be either an open region in  $\mathbb C$  or a single point  $D = {\kappa_0}$ . Assume that for any  $z \in Z$ ,  $\kappa \in D$  and  $m \geq 0$  we have

$$
\big[ \big| \chi_{L_1,z} \big|^\kappa \otimes \big| \chi_{L_2,z} \big| \otimes V \big|_z \otimes S^m \big( N_{Gz}^\vee \big) \big|_z \otimes \Delta_{G_z} \big/ \Delta_G \big|_{G_z} \big]_{\mathfrak{g}_{z,r}} = 0
$$

for some reductive subalgebra  $\mathfrak{g}_{z,r} \subset \mathfrak{g}_z$ , where  $N_{Gz}^{\vee}$  is the conormal bundle to  $Gz$  Then for any open  $D' \subset D$  such that  $\overline{D'}$  is compact and is contained in D, the map on coinvariants

$$
[\mathcal{S}^{hol}(X \times D, E_{\kappa})/\mathcal{S}^{hol}((X - Z) \times D, E_{\kappa})]_{\mathfrak{g}} \to [\mathcal{S}^{hol}(X \times D', E_{\kappa})/\mathcal{S}^{hol}((X - Z) \times D', E_{\kappa})]_{\mathfrak{g}}
$$

is zero. In the case  $D = {\kappa_0},$  the conclusion is

$$
[\mathcal{S}(X, E_{\kappa_0})/\mathcal{S}(X - Z, E_{\kappa})]_{\mathfrak{g}} = 0
$$

We follow the same steps as in [\[2\]](#page-30-8).

First, we observe that if we have a filtration  $Z_1 \subset Z_2 \subset \ldots Z_r = Z$  by G-invariant closed subvarieties then it is enough to prove the result for each pair  $(X - Z_{i-1}, Z_i - Z_{i-1})$ .

**Definition 4.2.** An action of an algebraic group  $G$  on an algebraic variety  $Z$  is called *factorizable* if Z is smooth, the schematic image Y of the map  $G \times X \to X \times X : (g, x) \mapsto$  $(x, gx)$  is a smooth variety, and the map  $G \times Z \rightarrow Y$  is smooth.

There exists a filtration  $Z_1 \subset \ldots \subset Z_r = Z$  be G-invariant closed subvarieties, such that the action of G on  $Z_i - Z_{i-1}$  is factorizable (see [\[2,](#page-30-8) Thm. B.0.11]). Thus, we can assume that  $Z$  is smooth and the action of  $G$  on  $Z$  is *factorizable*.

By an analog of Borel's theorem (see Prop. [2.6\)](#page-5-1) together with Lemma [2.5,](#page-5-2) Theorem [4.1](#page-15-1) now reduces to the following result (which is an analog of [\[2,](#page-30-8) Thm. B.0.12]), which has to be applied to  $X = Z$  and the bundle  $S^m(N_Z^{\vee}) \otimes (V \otimes |L_1|^{\kappa} \otimes |L_2|)|_Z$ . Note that to deduce Theorem [4.1](#page-15-1) from Theorem [4.3](#page-16-0) we use reductivity of  $\mathfrak{g}_{z,r}$ , as we have to pass from the space  $N_{Gz}^{\vee}|_z$  to its subspace  $N_Z^{\vee}|_z$ .<sup>[3](#page-16-1)</sup>

<span id="page-16-0"></span>**Theorem 4.3.** Let  $(X, G, V, L_1, L_2, D)$  be as in Theorem and assume in addition that the action of G on Z is factorizable. Assume that for any  $z \in Z$  and  $\kappa \in D$  we have

$$
\left[ \left| \chi_{L_1,z} \right|^\kappa \otimes \left| \chi_{L_2,z} \right| \otimes V \right|_z \otimes \Delta_{G_z} / \Delta_G \vert_{G_z} \left]_{\mathfrak{g}_z} = 0,
$$

where  $\mathfrak{g}_z$  is the Lie algebra of  $G_z$ . Then

$$
\mathcal{S}^{hol}(X \times D, E_{\kappa})_{\mathfrak{g}} = 0.
$$

In the case  $D = {\kappa_0}$ , the conclusion is

$$
\mathcal{S}^{hol}(X, E_{\kappa_0})_{\mathfrak{g}} = 0.
$$

# <span id="page-16-2"></span>4.2. Description of coinvariants.

**Lemma 4.4.** Let  $\mathfrak g$  be a finite dimensional Lie algebra (over  $\mathbb R$  or  $\mathbb C$ ), and let V be a nuclear Frechet space with a continuous  $\mathfrak{g}\text{-}action$ , such that  $\mathfrak{g}\cdot V$  is closed in V. Then for a nuclear Frechet space W (with the trivial g-action), we have

$$
\mathfrak{g}\cdot(V\hat{\otimes}W)=(\mathfrak{g}\cdot V)\hat{\otimes}W.
$$

*Proof.* By definition  $\mathfrak{g} \cdot (V \hat{\otimes} W)$  is the image of the action map

$$
\mathfrak{g} \otimes (V \hat{\otimes} W) \to V \hat{\otimes} W,
$$

which can be identified with the map  $(\mathfrak{g} \otimes V) \hat{\otimes} W \to V \hat{\otimes} W$  induced by the action map  $\mathfrak{g} \otimes V \to V$ . By assumption, the latter map factors as the composition of the surjection  $\mathfrak{g} \otimes V \to V_0 := \mathfrak{g} \cdot V$  and a closed embedding  $V_0 \to V$ . Now the assertion follows from the fact that the induced maps  $(g \otimes V) \hat{\otimes} W \to V_0 \hat{\otimes} W$  and  $V_0 \hat{\otimes} W \to V \hat{\otimes} W$  are still surjective and injective, respectively.

Let  $a: G \times X \to X$  be the action map  $(q, x) \mapsto qx, p: G \times X \to X$  the projection. The G-equivariant structure on  $E_{\kappa}$  gives a (tempered) map of bundles on  $G \times X$ ,  $p^*(E_\kappa) \longrightarrow a^*(E_\kappa)$ , and hence a map

$$
\alpha : p^!(E_\kappa) \xrightarrow{\sim} a^!(E_\kappa),
$$

where for a smooth morphism f we set  $f'(F) = f^*(F) \otimes |\omega_f|$  (here we use the identifications  $\omega_p \simeq \omega_a \simeq p_G^* \omega_G$ .

Similar to [\[2\]](#page-30-8), we consider the kernel of the integration map,

$$
\mathcal{S}^{hol}(G\times X\times D,p^!E_\kappa)_{0,X}\coloneqq\ker(p_*:\mathcal{S}^{hol}(G\times X\times D,p^!E_\kappa)\to\mathcal{S}^{hol}(X\times D,E_\kappa)).
$$

and then we consider the image of this subspace under the above map  $\alpha$ ,

$$
\mathcal{S}^{hol}(G \times X \times D, a^! E_{\kappa})_{0,X,a} \coloneqq \alpha(\mathcal{S}^{hol}(G \times X \times D, p^! E_{\kappa})_{0,X}).
$$

<span id="page-17-1"></span>Proposition 4.5. We have

$$
\mathfrak{g} \cdot \mathcal{S}^{hol}(X \times D, E_{\kappa}) = a_{*}(\mathcal{S}^{hol}(G \times X \times D, a^{*}E_{\kappa} \otimes |\omega_{a}|)_{0,X,a}).
$$

Proof. The integration map

$$
a_*: \mathcal{S}^{hol}(G \times X \times D, a^*E_\kappa \otimes |\omega_a|) \to \mathcal{S}^{hol}(X \times D, E_\kappa)
$$

is surjective (see Lemma [2.3\)](#page-4-1) and is compatible with  $G$ -actions, where  $G$  acts on the  $G$ coordinate in  $G \times X$ . It follows that  $\mathfrak{g} \cdot \mathcal{S}^{hol}(X \times D, E_{\kappa})$  is the image of  $\mathfrak{g} \cdot \mathcal{S}^{hol}(G \times X \times E_{\kappa})$  $D, a^*E_\kappa \otimes |\omega_a|$ . Furthermore, the isomorphism

$$
p^* E_\kappa \otimes |\omega_p| \simeq p^* E_\kappa \otimes |p_G^* \omega_G| \simeq a^* E_\kappa \otimes |\omega_a|
$$

is compatible with G-actions, where  $p^*E_{\kappa}$  has a trivial G-action. Now we have an isomorphism of g-representations,

$$
\mathcal{S}^{hol}(G \times X \times D, p^*E_\kappa \otimes |p_G^*\omega_G|) \simeq \mathcal{S}(G, |\omega_G|) \hat{\otimes} \mathcal{S}^{hol}(X, E_\kappa).
$$

Recall that  $\mathfrak{g} \cdot \mathcal{S}(G, |\omega_G|)$  coincides with the (closed) subspace  $\mathcal{S}(G, |\omega_G|)_0$  of f with  $\int_G f = 0$ (see [\[2\]](#page-30-8)). This gives an identification

$$
\mathfrak{g} \cdot \mathcal{S}^{hol}(G \times X \times D, p^* E_\kappa \otimes |p_G^* \omega_G|) \simeq \mathcal{S}(G, |\omega_G|)_0 \hat{\otimes} \mathcal{S}^{hol}(X, E_\kappa)
$$

(see Lemma [4.4\)](#page-16-2). It remains to observe that the completed tensored product of the exact sequence

$$
0 \to \mathcal{S}(G, |\omega_G|)_0 \to \mathcal{S}(G, |\omega_G|) \xrightarrow{J_G} \mathbb{C} \to 0
$$

with  $S^{hol}(X, E_{\kappa})$  gives the exact sequence

$$
0 \to \mathcal{S}^{hol}(G \times X \times D, p^* E_{\kappa} \otimes |p_G^* \omega_G|)_{0,X} \to \mathcal{S}^{hol}(G \times X \times D, p^* E_{\kappa} \otimes |p_G^* \omega_G|) \xrightarrow{p_*} \mathcal{S}^{hol}(X \times D, E_{\kappa}) \to 0.
$$

<span id="page-17-0"></span>Next, we will consider the case of a smooth group scheme over  $X$ .

**Proposition 4.6.** Let  $\pi : H \to X$  be a smooth group scheme over X,  $V_{\kappa}$  a family of  $H(F)$ equivariant vector bundles over  $X(F)$  of the form  $P \otimes |L_1|^\kappa \otimes |L_2|$ , where  $\kappa \in D_0$ . Assume that for every  $x \in X$  and  $\kappa \in D \subset D_0$ , one has  $(V_{\kappa}|_x)_{\mathfrak{h}|_x} = 0$ . Then the composition

$$
\mathcal{S}^{hol}(H \times D, \pi^* V_{\kappa} \otimes |\omega_{\pi}|)_{0,X} \xrightarrow{\alpha} \mathcal{S}^{hol}(H \times D, \pi^* V_{\kappa} \otimes |\omega_{\pi}|) \xrightarrow{\pi_*} \mathcal{S}^{hol}(X \times D, V_{\kappa}),
$$

induced by the H-action map  $\alpha : \pi^* V_\kappa \to \pi^* V_\kappa$  followed by the integration along  $\pi : H \to X$ , is surjective.

*Proof.* **Step 1**. The surjective composed map

$$
\mathcal{S}^{hol}(H \times D, \pi^*V_{\kappa} \otimes |\omega_{\pi}|) \xrightarrow{\alpha} \mathcal{S}^{hol}(H \times D, \pi^*V_{\kappa} \otimes |\omega_{\pi}|) \xrightarrow{\pi_*} \mathcal{S}^{hol}(X \times D, V_{\kappa}),
$$

is a map of  $\mathcal{S}(X, \mathfrak{h})$ -representations, where the action on the source considers  $V_{\kappa}$  with the trivial *H*-action (cf. the proof of  $[2, Cor. 9.17]$ ).

Step 2. The image of the map  $S(X, \mathfrak{h}) \otimes S^{hol}(H \times D, \pi^*V_{\kappa} \otimes |\omega_{\pi}|) \to S^{hol}(H \times D, \pi^*V_{\kappa} \otimes |\omega_{\pi}|)$ associated with the trivial H-action on  $V_{\kappa}$  is contained in  $\mathcal{S}^{hol}(H \times D, \pi^*V_{\kappa} \otimes |\omega_{\pi}|)_{0,X}$ .

Indeed, by partition of unity, we can assume that  $V_{\kappa}$  is trivial. We have the following identifications:

$$
\mathcal{S}^{hol}(H \times D, |\omega_{\pi}|) \simeq \mathcal{S}(H, |\omega_{\pi}|) \hat{\otimes} \mathcal{S}^{hol}(D), \quad \mathcal{S}^{hol}(X \times D) \simeq \mathcal{S}(X) \hat{\otimes} \mathcal{S}^{hol}(D),
$$
  

$$
\mathcal{S}^{hol}(H \times D, |\omega_{\pi}|)_{0,X} \simeq \mathcal{S}(H, |\omega_{\pi}|)_{0,X} \hat{\otimes} \mathcal{S}^{hol}(D),
$$

where the latter identification is obtained by looking at the completed tensor product with  $S^{hol}(D)$  of the sequence

$$
0 \to \mathcal{S}(H, |\omega_{\pi}|)_{0,X} \to \mathcal{S}(H, |\omega_{\pi}|) \xrightarrow{\pi_{*}} \mathcal{S}(X) \to 0.
$$

By [\[2,](#page-30-8) Lem. B.1.14], we have an inclusion

$$
\operatorname{im}(\mathcal{S}(X,\mathfrak{h})\otimes\mathcal{S}(H,|\omega_{\pi}|)\to\mathcal{S}(H,|\omega_{\pi}|))\subset\mathcal{S}(H,|\omega_{\pi}|)_{0,X}.
$$

This implies that the composition

$$
\mathcal{S}(X,\mathfrak{h})\hat{\otimes}\mathcal{S}(H,|\omega_{\pi}|)\rightarrow\mathcal{S}(H,|\omega_{\pi}|)\xrightarrow{\pi_{*}}\mathcal{S}(X)
$$

is zero. Tensoring with  $S^{hol}(D)$ , we deduce that the composition

$$
\mathcal{S}(X,\mathfrak{h})\hat{\otimes}\mathcal{S}(H,|\omega_{\pi}|)\hat{\otimes}\mathcal{S}^{hol}(D)\rightarrow\mathcal{S}(H,|\omega_{\pi}|)\hat{\otimes}\mathcal{S}^{hol}(D)\xrightarrow{\pi_{*}\otimes id}\mathcal{S}(X)\hat{\otimes}\mathcal{S}^{hol}(D),
$$

is zero, which gives the assertion in view of the above identifications.

**Step 3.** The map  $\mathcal{S}(X, \mathfrak{h}) \otimes \mathcal{S}^{hol}(X \times D, V_{\kappa}) \to \mathcal{S}^{hol}(X \times D, V_{\kappa})$  (induced by the *H*-action on  $V_{\kappa}$ ) is surjective. The action of h on  $V_{\kappa}$  gives a morphism of vector bundles

$$
\alpha_{\mathfrak{h}} : \mathfrak{h} \otimes V_{\kappa} \to V_{\kappa}
$$

over  $X \times D$ , and our assumption implies that it is surjective. By the partition of unity, we can assume that X is affine, and can trivialize  $P$ ,  $L_1$  and  $L_2$ . and  $\mathfrak h$  as a vector bundle. Let us write  $\mathfrak{h} = \mathfrak{h}_0 \otimes \mathcal{O}, V_{\kappa} = V_0 \otimes \mathcal{O}, \text{ where } \mathfrak{h}_0 \text{ and } V_0 \text{ are finite-dimensional vector spaces.}$ Then  $\alpha_{\mathfrak{h}}$  can be viewed as a surjective algebraic morphism

$$
\mathfrak{h}_0 \otimes V_0 \otimes \mathcal{O}_{X \times D} \to V_0 \otimes \mathcal{O}_{X \times D}
$$

over  $X \times D$  (the dependence on  $\kappa$  will be linear).

We have identifications

$$
\mathcal{S}(X,\mathfrak{h})\simeq \mathfrak{h}_0\otimes \mathcal{S}(X),\quad \mathcal{S}^{hol}(X\times D,V_\kappa)\simeq V_0\otimes \mathcal{S}^{hol}(X\times D),
$$

so the map we are interested in is obtained as the composition

$$
\mathfrak{h}_0 \otimes \mathcal{S}(X) \otimes V_0 \otimes \mathcal{S}^{hol}(X \times D) \to \mathfrak{h}_0 \otimes V_0 \otimes \mathcal{S}^{hol}(X \times D) \xrightarrow{\alpha_{\mathfrak{h}}} V_0 \otimes \mathcal{S}^{hol}(X \times D),
$$

where the first arrow is induced by the natural surjective map  $S(X) \otimes S^{hol}(X \times D) \rightarrow$  $S<sup>hol</sup>(X \times D)$ . Thus, it suffices to prove surjectivity of the map

<span id="page-18-0"></span>
$$
\mathfrak{h}_0 \otimes V_0 \otimes \mathcal{S}^{hol}(X \times D) \xrightarrow{\alpha_{\mathfrak{h}}} V_0 \otimes \mathcal{S}^{hol}(X \times D). \tag{4.1}
$$

To this end we can choose a section

$$
s: V_0 \otimes \mathcal{O}_{X \times D} \to \mathfrak{h}_0 \otimes V_0 \otimes \mathcal{O}_{X \times D}
$$

of  $\alpha_{fh}$ . Then s gives rise to a map

$$
V_0 \otimes \mathcal{S}^{hol}(X \times D) \to \mathfrak{h}_0 \otimes V_0 \otimes \mathcal{S}^{hol}(X \times D),
$$

which is a section of  $(4.1)$ , proving its surjectivity.

**Step 4.** Now the assertion follows formally from Steps 1, 2 and 3.

4.3. Representation of torsors. We use the terminology of [\[2,](#page-30-8) Sec. B.1.4] concerning (families of) torsors.

We consider a smooth morphism of F-varieties,  $\pi : T \to Y$  with the torsor structure over Y. This means that we are given a map  $m: T \times_Y T \times_Y T \to T$  which is locally of the form  $m(x, y, z) = z(z^{-1}x)(z^{-1}y)$  for some group structure. For every  $t \in T$  we denote by  $H_t$  the fiber  $\pi^{-1}(\pi(t))$  with the unique group structure such that t is the neutral element. In the archimedean case we denote by  $\mathfrak{h}_t$  the Lie algebra of  $H_t$ . An (algebraic) representation of T is a pair of (algebraic) vector bundles  $V_1$ ,  $V_2$  on Y, together with a morphism  $\alpha : \pi^* V_1 \rightarrow$  $\pi^* V_2$  such that for every  $t_0 \in T$ , the map  $t \mapsto \alpha_t \alpha_{t_0}^{-1} : V_2|_{\pi(t_0)} \to V_2|_{\pi(t_0)}$  gives an action of  $H_{t_0}$  on  $V_2|_{\pi(t_0)}$ . There is a natural operation of tensor product of representations of T.

<span id="page-19-0"></span>We have the following Corollary from Proposition [4.6](#page-17-0) (an analog of [\[2,](#page-30-8) Cor. B.1.27]).

**Corollary 4.7.** Let  $\pi : T \to Y$  be an algebraic torsor over F,  $(V_{1,\kappa}, V_{2,\kappa}, \alpha)$  a family of representations of  $T(F)$ , obtained as the tensor product of an algebraic representation  $(P_1, P_2)$ , with 1-dimensional representations of the form  $(|L_1|\kappa, |L_2|\kappa)$  and  $(|M_1|, |M_2|)$ (where  $(L_1, L_2)$  and  $(M_1, M_2)$  are algebraic representations of T). Assume that for every  $t \in T$  and  $\kappa \in D$ , one has  $(V_{2,\kappa}|_{p(t)})_{\mathfrak{h}_t} = 0$ . Then the composition

<span id="page-19-1"></span>
$$
\mathcal{S}^{hol}(T \times D, \pi^* V_{1,\kappa} \otimes |\omega_{\pi}|)_{0,Y} \xrightarrow{\alpha} \mathcal{S}^{hol}(T \times D, \pi^* V_{2,\kappa} \otimes |\omega_{\pi}|) \xrightarrow{\pi_*} \mathcal{S}^{hol}(Y \times D, V_{\kappa}), \quad (4.2)
$$

is surjective.

*Proof.* If there is a section  $\sigma: Y \to T$  then T becomes a family of smooth groups and the assertion follows from Proposition [4.6.](#page-17-0) The general case follows from this by choosing local sections and a partition of unity.

*Proof of Theorem [4.3.](#page-16-0)* Let  $Y \subset X \times X$  denote the image of the map  $(p, a) : G \times X \to X \times X$ :  $(g, x) \mapsto (x, gx)$ . In other words, Y is the variety of pairs  $(x_1, x_2)$  such that  $x_1$  and  $x_2$  are in the same  $G$ -orbit. By assumption, Y is smooth and the map

$$
b: G \times X \to Y : (g, x) \mapsto (x, gx)
$$

is smooth. Hence, the projections  $p_1, p_2 : Y \to X$  are also smooth.

Via the map b, we can view  $G \times X$  as a torsor over Y. Note that  $b^{-1}(x_1, x_2)$  is identified with  ${g \in G \mid gx_1 = x_2}$ . For each  $(g, x) \in G \times X$ , the corresponding group  $H_{g,x}$  is canonically identified with  $H_x \simeq H_{gx}$ .

The pair of bundles on  $Y$ ,

$$
V_{i,\kappa} = p_i^* E_{\kappa} \otimes |\omega_{p_i}|, \ i = 1, 2,
$$

has a natural structure of a representation over the torsor  $G \times X$ . Namely, for  $(x_1, x_2) \in Y$ , and an element  $g \in G$  such that  $gx_1 = x_2$ , we use the map

$$
V_{1,\kappa}|_{(x_1,x_2)} \simeq E_{\kappa}|_{x_1} \otimes |\omega_{\Omega}||_{x_2} \xrightarrow{\alpha_g \otimes \alpha_{g^{-1}}} E_{\kappa}|_{x_2} \otimes |\omega_{\Omega}||_{x_1},
$$

induced by the action of g on  $E_{\kappa}$  and by the action of  $g^{-1}$  on  $\omega_{\Omega}$ , where  $\Omega$  is the G-orbit containing  $x_1$  and  $x_2$ . The corresponding representation of  $H_x$  on  $V_{2,\kappa}|_x$  can be identified with  $E_{\kappa} \otimes \Delta_{H_x} \otimes \Delta_G^{-1}|_{H_x}$ . Thus our assumption implies that for every  $x \in X$ , one has  $(V_{2,\kappa}|_x)_{\mathfrak{h}_x} = 0.$ 

Applying Corollary [4.7](#page-19-0) we deduce surjectivity of the composition [\(4.2\)](#page-19-1). On the other hand, by Proposition [4.5,](#page-17-1) we need to prove surjectivity of the composition

$$
\mathcal{S}^{hol}(G\times X\times D,p^!E_{\kappa})_{0,X}\hookrightarrow \mathcal{S}^{hol}(G\times X\times D,p^!E_{\kappa})\xrightarrow{\alpha} \mathcal{S}^{hol}(G\times X\times D,a^!E_{\kappa})\xrightarrow{a_*}\mathcal{S}^{hol}(X\times D,E_{\kappa}).
$$

Since  $a = p_2 \circ b$ , and the map  $p_2 : Y \to X$  is smooth and surjective on F-points, by Lemma [2.3,](#page-4-1) it is enough to prove surjectivity of the similar composition with  $a<sub>*</sub>$  replaced by the map

$$
b_*: \mathcal{S}^{hol}(G \times X \times D, a^! E_{\kappa}) \to \mathcal{S}^{hol}(Y \times D, p_2^! E_{\kappa}).
$$

Finally, we observe that we have an inclusion

$$
\mathcal{S}^{hol}(G \times X \times D, b^*V_{1,\kappa} \otimes |\omega_b|)_{0,Y} \subset \mathcal{S}^{hol}(G \times X \times D, p^!E_{\kappa})_{0,X}
$$

(the first space is the kernel of  $b_*,$  while the second is the kernel of  $p_*$ ), and a commutative diagram

$$
\mathcal{S}^{hol}(G \times X \times D, p^! E_{\kappa}) \xrightarrow{\alpha} \mathcal{S}^{hol}(G \times X \times D, a^! E_{\kappa})
$$
  
\n
$$
\sim \left\downarrow \left\downarrow \left\downarrow \right\downarrow
$$
  
\n
$$
\mathcal{S}^{hol}(G \times X \times D, b^! V_{1,\kappa}) \xrightarrow{\alpha} \mathcal{S}^{hol}(G \times X \times D, b^! V_{2,\kappa}).
$$

Hence, the assertion follows from surjectivity of  $(4.2)$ .

4.4. Corollary for admissible stacks. Let  $\mathcal X$  be an admissible stack of finite type over  $F, \mathcal{L}$  a line bundle on  $\mathcal{X}$ .

Let  $\mathcal{U} \subset \mathcal{X}$  an open substack. For every  $\kappa \in \mathbb{C}$ , there is a natural map

$$
j_{\mathcal{U}\rightarrow\mathcal{X},\mathcal{L},\kappa}: \mathcal{S}(\mathcal{U},|\mathcal{L}|^{\kappa})\rightarrow \mathcal{S}(\mathcal{X},|\mathcal{L}|^{\kappa})
$$

and for an open region  $D \subset \mathbb{C}$ , a map

$$
j_{\mathcal{U}\to\mathcal{X},\mathcal{L},D}^{hol}: \mathcal{S}^{hol}(\mathcal{U}\times D,|\mathcal{L}|^{\kappa})\to\mathcal{S}^{hol}(\mathcal{X}\times D,|\mathcal{L}|^{\kappa})
$$

As before, for every point  $x \in \mathcal{X}$ , we consider the character

$$
\chi_{\mathcal{L},x} : \mathrm{Aut}(x) \to \mathbb{G}_m.
$$

and the algebraic modular character  $\Delta_{\text{Aut}(x)}^{alg}$  of  $\text{Aut}(x)(F)$ .

<span id="page-21-2"></span>**Lemma 4.8.** Let D be either an open region in  $\mathbb{C}$  or  $D = \{\kappa_0\}$ . Assume that for every point  $x \in \mathcal{X} \setminus \mathcal{U}$  and  $\kappa \in D$ , there exists an algebraic homomorphism  $\lambda^{\vee} : \mathbb{G}_m \to \text{Aut}(x)$ , such that for any character  $a \mapsto a^m$  of  $\mathbb{G}_m$  appearing in the action on  $S^{\bullet}H^0T^*_{\mathcal{X}}|_x$  one has

$$
\kappa \cdot \langle \chi_{\mathcal{L},x}, \lambda^{\vee} \rangle + m \neq - \langle \Delta_{\mathrm{Aut}(x)}^{alg}, \lambda^{\vee} \rangle.
$$

Then for any open  $D' \subset D$  such that  $\overline{D'}$  is compact and is contained in D, the image of the restriction map

$$
\mathcal{S}^{hol}(\mathcal{X} \times D, |\mathcal{L}|^{\kappa}) \to \mathcal{S}^{hol}(\mathcal{X} \times D', |\mathcal{L}|^{\kappa})
$$

is contained in the image of  $j_{U\to X,\mathcal{L},D'}^{hol}$ . In the case  $D = {\kappa_0}$ , the conclusion is that  $j_{U\to X,\mathcal{L},\kappa_0}$ is surjective.

*Proof.* We can assume that  $\mathcal{X} = [X/G]$ , where  $G = GL_N$ , and  $\mathcal{U} = [U/G]$ , where  $U \subset X$  is open. Let L denote the pull-back of L to X. We have  $\text{Aut}_{\mathcal{X}}(x) = G_x \subset G$ , the stabilizer subgroup of  $x \in X$ . Theorem [4.1](#page-15-1) implies that the top horizontal arrow in the diagram

$$
S^{hol}(X \times D, |L|^\kappa)_{\mathfrak{g}} / \operatorname{im} S^{hol}(U \times D, |L|^\kappa)_{\mathfrak{g}} \longrightarrow S^{hol}(X \times D', |L|^\kappa)_{\mathfrak{g}} / \operatorname{im} S^{hol}(U \times D', |L|^\kappa)_{\mathfrak{g}}
$$
  

$$
\downarrow
$$
  

$$
S^{hol}(X \times D, |\mathcal{L}|^\kappa) / \operatorname{im} S^{hol}(U \times D, |\mathcal{L}|^\kappa) \longrightarrow S^{hol}(X \times D', |\mathcal{L}|^\kappa) / \operatorname{im} S^{hol}(U \times D', |\mathcal{L}|^\kappa)
$$

<span id="page-21-0"></span>is zero. Now we observe that the vertical arrows in this diagram are surjective by Lemma [2.4.](#page-4-2) Hence, the bottom horizontal arrow is also zero.  $\Box$ 

## 5. Integration over orbits

<span id="page-21-3"></span>5.1. Setup and two extension results. In this section  $F$  is either archimedean or nonarchimedean.

Let X be a smooth G-scheme over F (where  $G = GL_N$ ), L a G-equivariant line bundle on X representing a line bundle L on the stack  $[X/G]$ , and let  $U_0 \subset X$  be an open G-invariant subscheme such that G acts freely on  $U_0$  and the quotient  $U_0/G$  exists. Let us choose a trivialization  $\mathrm{vol}_{\mathfrak{g}} \in |\Lambda^{top}(\mathfrak{g})^{-1}|.$ 

First, we observe that for each  $\kappa \in \mathbb{C}$ , there is a well defined map

$$
\pi_{U_0,\kappa}: \mathcal{S}(U_0(F),|L|^\kappa)_{G(F)} \to \mathcal{S}((U_0/G)(F),|L_0|^\kappa),
$$

where  $L_0$  is the descent of L to  $U_0/G$ , given by absolutely convergent integrals

<span id="page-21-1"></span>
$$
\pi_{U_0,\kappa}(\varphi)(x) = \int_{\Omega_x(F)} \varphi \cdot \text{vol}_{\mathfrak{g}},\tag{5.1}
$$

where  $\Omega_x \subset X$  is the G-orbit of  $x \in U_0$  (which is closed in  $U_0$ ).

We are interested in finding conditions under which the above map extends to a map

<span id="page-21-4"></span>
$$
\pi_{X,U_0,\kappa}: \mathcal{S}(X(F), |L|^\kappa)_{G(F)} \to C^\infty((U_0/G)(F), |L_0|^\kappa),\tag{5.2}
$$

given by the same formula [\(5.1\)](#page-21-1) (where in the nonarchimedean case  $C^{\infty}$  refers to locally constant functions). For technical reasons we will define  $\pi_{U_0,\kappa}(\varphi)$  as distributions on  $(U_0/G)(F)$ , so actually we will be able to control the integrals [\(5.1\)](#page-21-1) only away from a set of orbits of measure zero.

We will consider the space of distributions  $\mathcal{D}((U_0/G)(F), |L_0|^{\kappa})$  acting on sections of  $|L_0|^{-\kappa} \otimes |\omega|$ , so that we have an inclusion

$$
C^{\infty}((U_0/G)(F), |L_0|^{\kappa}) \subset \mathcal{D}((U_0/G)(F), |L_0|^{\kappa}).
$$

**Definition 5.1.** We say that the pair  $(U_0, X)$  is  $|L|^\kappa$ -nice if for every  $\varphi \in \mathcal{S}(X(F), |L|^\kappa)$ , and every  $\psi \in \mathcal{S}((U_0/G)(F), |L_0|^{-\kappa} \otimes |\omega|)$ , the integral

<span id="page-22-1"></span>
$$
\pi_{X,U_0,\kappa}(\varphi)(\psi) \coloneqq \int_{U_0(F)} \psi \cdot \varphi|_{U_0(F)} \cdot \text{vol}_{\mathfrak{g}} \tag{5.3}
$$

is absolutely convergent, and the corresponding distribution  $\pi_{X,U_0,\kappa}(\varphi) \in \mathcal{D}((U_0/G)(F), |L_0|^{\kappa})$ belongs to the subspace  $C^{\infty}((U_0/G)(F), |L_0|^{\kappa})$ .

It is easy to see using Fubini's theorem that in the situation of the above definition the integrals [\(5.1\)](#page-21-1) are absolutely convergent away from a set of orbits of measure zero. It is plausible that if  $(U_0, X)$  is  $|L|$ <sup>k</sup>-nice then in fact the values of the obtained  $C^{\infty}$ -sections  $\pi_{X,U_0,\kappa}(\varphi)$  are given by absolutely convergent integrals [\(5.1\)](#page-21-1) but we do not know how to prove this (and this is not essential for us).

From now on we specialize to the case  $\mathcal{L} = \omega_{\mathcal{X}}$ , so  $L = \omega_X \otimes \Lambda^{top}(\mathfrak{g})$ . Note that since the action of G on  $\wedge^{top}(\mathfrak{g})$  is trivial, we can (and will) identify L with  $\omega_X$  as a G-equivariant bundle.

Assume we have some open G-invariant subschemes  $U_0 \subset U \subset X$  such that G acts freely on  $U_0$  and the quotient  $U_0/G$  exists.

As before, for  $x \in X(F)$ ,  $G_x = \text{Aut}_{[X/G]}(x)$  is the stabilizer of x, and  $\chi_{\omega,x} : G_x \to \mathbb{G}_m$  is the character given by the action on  $\omega_X|x$ .

<span id="page-22-0"></span>**Lemma 5.2.** Fix some real numbers  $a < 1$ ,  $b > 1$ . Assume that for any real number k in the interval  $(a, b) \in \mathbb{R}$ , the pair  $(U_0, U)$  is  $|\omega|^k$ -nice. Assume in addition that

• either F is non-archimedean, and for any  $x \in (X \setminus U)(F)$  there exists a cocharacter  $\lambda^{\vee} : \mathbb{G}_m \to G_x$  such that

$$
k \cdot \langle \chi_{\omega,x}, \lambda^{\vee} \rangle \neq - \langle \Delta_{G_x}^{alg}, \lambda^{\vee} \rangle
$$

for any  $k \in (a, b)$ ;

• or F is archimedean, and for any  $x \in (X \setminus U)(F)$  there exists a cocharacter  $\lambda^{\vee}$ :  $\mathbb{G}_m \to G_x$ , such that for any character  $a \mapsto a^{m}$  of  $\mathbb{G}_m$  appearing in  $S^{\bullet}H^0T^*_{\square}$  $\frac{1}{[X/G]}|_x,$ 

$$
k \cdot \langle \chi_{\omega,x}, \lambda^{\vee} \rangle + m \neq - \langle \Delta_{G_x}^{alg}, \lambda^{\vee} \rangle
$$

for any  $k \in (a, b)$ .

Then the pair  $(U_0, X)$  is  $|\omega|^{\kappa}$ -nice for any  $\kappa$  in the strip  $a < \text{Re}(\kappa) < b$ .

*Proof.* By shrinking  $U_0/G$  we can assume that there exists a nowhere vanishing G-invariant top form  $\eta_0$  on  $U_0/G$ . On the other hand, we can cover X with open subsets  $U_i$  such that there exist nowhere vanishing top forms  $\eta_i$  on  $U_i$ , so that  $\eta_i \cdot \text{vol}_{\mathfrak{g}}^{-1}$  are trivializations of  $\omega_X|_{U_i} \otimes \bigwedge^{top}(\mathfrak{g}).$ 

It is enough to consider sections of  $\mathcal{S}(X(F), |L|<sup>\kappa</sup>)$  supported on some  $U_i$ . Using the trivializations of  $L|_{U_i}$ , we can write these sections as

$$
\varphi_{\kappa} \coloneqq \varphi \cdot |\eta_i \cdot \mathrm{vol}_{\mathfrak{g}}^{-1}|^{\kappa},
$$

where  $\varphi \in \mathcal{S}(U_i(F))$ , so the corresponding integrals can be written as

<span id="page-23-0"></span>
$$
\pi_{X,U_0,\kappa}(\varphi_\kappa)(\psi|\eta_0|^{1-\kappa}) = \int_{U_0(F)\cap U_i(F)} \psi \cdot \varphi \cdot |\frac{\eta_i}{\mathrm{vol}_{\mathfrak{g}}\eta_0}|^\kappa \cdot |\eta_0| \cdot \mathrm{vol}_{\mathfrak{g}},\tag{5.4}
$$

where  $\psi \in \mathcal{S}((U_0/G)(F))$ . Note that here  $\eta_i/(\text{vol}_{\mathfrak{g}} \eta_0)$  is a non-vanishing function on  $(U_i \cap$  $U_0$  $(F)$ .

Furthermore, it is enough to consider the Schwartz sections as above with  $\varphi$  non-negative (since any  $\varphi$  can be expressed as a difference of non-negative Schwartz functions). From now one, we fix such  $\varphi \in \mathcal{S}(U_i(F))$ .

**Step 1.** We observe that for  $\text{Re}(\kappa) = 1$ , the integral [\(5.4\)](#page-23-0) absolutely converges, since the measure  $\varphi \cdot |\eta_i|$  has finite volume. Hence, [\(5.4\)](#page-23-0) defines a well defined distribution  $\pi_{X,U_0,\kappa}(\varphi_\kappa)\in \mathcal{D}((U_0/G)(F),|\omega|^\kappa).$ 

**Step 2.** It is enough to prove the relevant absolute convergence for  $\kappa$  in any slightly smaller strip  $a' < \text{Re}(\kappa) < b'$ , where  $a' = a + \epsilon$ ,  $b' = b - \epsilon$ . Let us pick a bounded open domain D' contained in this strip such that  $D' \cap \mathbb{R} = (a', b')$ . By Lemma [4.8](#page-21-2) in the archimedean case or by Lemma [3.23\(](#page-14-0)iii) in the non-archimedean case, there exists an element

$$
\widetilde{\varphi}_{\kappa} \in \mathcal{S}(U(F) \times D', |\omega|^{\kappa})_{G(F)}
$$

lifting  $\varphi_{\kappa}$ . Note that

$$
\pi_{U,U_0,\kappa}(\widetilde{\varphi}_\kappa)\in C^\infty((U_0/G)(F),|\omega|^\kappa)\subset \mathcal{D}((U_0/G)(F),|\omega|^\kappa)
$$

depends holomorphically on  $\kappa \in D'$ .

**Step 3.** We know that for  $\text{Re}(\kappa) = 1$ , the integrals defining the distribution  $\pi_{X,U_0,\kappa}(\varphi_\kappa)$ are absolutely convergent and we have an equality of twisted distributions on  $(U_0/G)(F)$ .

$$
\pi_{U,U_0,\kappa}(\widetilde{\varphi}_\kappa)=\pi_{U,U_0,\kappa}(\varphi_\kappa)=\pi_{X,U_0,\kappa}(\varphi_\kappa).
$$

In particular, for Re( $\kappa$ ) = 1, the image of  $\pi_{X,U_0,\kappa}$  is contained in  $C^{\infty}((U_0/G)(F), |\omega|^{\kappa})$ .

Step 4. Now we arrive at the following situation: we have a holomorphic map

$$
\{\kappa \in \mathbb{C} \mid a' < \text{Re}(\kappa) < b'\} \to C^{\infty}((U_0/G)(F)) \subset \mathcal{D}((U_0/G)(F)) : \kappa \mapsto \pi_{U,U_0,\kappa}(\widetilde{\varphi}_{\kappa}),
$$

such that for Re( $\kappa$ ) = 1 it is given by absolutely converging integrals  $\pi_{X,U_0,\kappa}(\varphi_\kappa)(\psi|\eta_0|^{1-\kappa})$ .

Now by Lemma [5.3](#page-24-0) below, we conclude that for any non-negative  $\psi$  the integral [\(5.4\)](#page-23-0) converges absolutely for all  $\kappa$  in the strip  $a' < \text{Re}(\kappa) < b'$ , and agrees with  $\pi_{U,U_0,\kappa}(\widetilde{\varphi}_{\kappa})(\psi|\eta_0|^{1-\kappa})$ . In particular, the distribution it defines belongs to  $C^{\infty}((U_0/G)(F))$ .

The proof of the following Lemma is due to Pavel Etingof.

<span id="page-24-0"></span>**Lemma 5.3.** Let Y be a smooth variety over a local field  $F$ ,  $f$  an invertible function on Y,  $\mu$  a positive measure on  $Y(F)$ . Consider the integrals depending on  $s \in C$ ,

$$
I(s) = \int_{Y(F)} |f|^s \mu.
$$

Assume that  $I(s_0) < \infty$  for some  $s_0 \in \mathbb{R}$ , so that  $I(s)$  is well defined for  $\text{Re}(s) = s_0$ , and there exists an analytic continuation of  $I(s)$  into an open neighborhood  $U \subset \mathbb{C}$  of  $s_0$ . Suppose  $s_0 \subset (a, b) \subset U \cap \mathbb{R}$ . Then  $I(s) < \infty$  for  $a < \text{Re}(s) < b$ .

*Proof.* Without loss of generality we can assume that  $s_0 = 0$ . Let us write  $I(s) = I_+(s)$  +  $I_-(s)$ , where

$$
I_+(s) = \int_{|f| \ge 1} |f|^s \cdot \mu, \quad I_-(s) = \int_{|f| < 1} |f|^s \mu.
$$

Since  $I(0) < \infty$ , the integral  $I_+(s)$  (resp.,  $I_-(s)$ ) converges absolutely for  $\text{Re}(s) \leq 0$  (resp.,  $\text{Re}(s) \geq 0$ ).

It is enough to prove that  $I_+(b) < \infty$  and  $I_-(a) < \infty$ . Let us prove the convergence of  $I_{-}(a)$  (the proof for  $I_{+}(b)$ ) is analogous). The existence of an analytic continuation of  $I(s)$ into  $a < \text{Re}(s) < \epsilon$  (where  $\epsilon > 0$ ) implies that  $I_{-}(s)$  extends to a function on  $a < \text{Re}(s) \leq 0$ , analytic on  $a < \text{Re}(s) < 0$  and continuous on  $a < \text{Re}(s) \leq 0$  (note for  $I_+(s)$ ) this follows from the absolute convergence in  $a < \text{Re}(s) \leq 0$ . It follows that  $I_-(s)$  has an analytic continuation to the region  $a < \text{Re}(s)$ .

Set

$$
a_0 \coloneqq \inf\{s \in \mathbb{R} \mid I_{-}(s) < \infty\}.
$$

Note that  $a_0 \leq 0$ . We want to prove that  $a_0 \leq a$ . Assume that  $a_0 > a$ . Consider the positive measure

$$
\nu \coloneqq |f|^{a_0} \cdot \delta_{|f|<1} \cdot \mu.
$$

Then the integral

$$
J(s)\coloneqq \int_{Y(F)}|f|^s\cdot \nu
$$

has the following properties:

- $J(s) < \infty$  for every  $s > 0$ ;
- $J(s)$  has an analytic continuation to  $a a_0 < \text{Re}(s)$ .

The analyticity of  $J(s)$  near  $s = 0$  implies that s near 0 one has

$$
J^{(n)}(s) = \int_{Y(F)} (\ln |f|)^n \cdot |f|^s \cdot \nu,
$$

for each  $n \geq 0$ . Since  $J(s)$  is analytic at  $s = 0$ , there exists some  $R > 0$  and a constant  $C > 0$ , such that

$$
|J^{(n)}(0)| = \int_{Y(F)} (-\ln|f|)^n \nu \le C \cdot n! \cdot R^n.
$$

But this implies that for  $0 \le t < R^{-1}$ , one has

$$
J(-t) = \int |f|^{-t} \nu = \int \sum_{n=0}^{\infty} \frac{t^n}{n!} (-\ln|f|)^n \nu \leq \sum_{n=0}^{\infty} C(tR)^n < \infty.
$$

Hence,  $I_-(a_0-t) < \infty$  for  $0 \le t < R^{-1}$ , contradicting the definition of  $a_0$ .

<span id="page-25-0"></span>We also need another type of extension of  $\pi_{U,U_0,\kappa}$ .

**Lemma 5.4.** Assume that the pair  $(U_0, U)$  is  $|\omega|^{\kappa}$ -nice. Assume also that for every point  $y \in (U_0/G)(F)$ , there exists a neighborhood  $V_y \subset (U_0/G)(F)$  of y and a closed subset  $Z_y \subset X(F)$ , such that  $Z_y \subset U(F)$ , and for every  $x \in U_0(F)$  mapping to  $V_y$ , one has  $G(F)x \subset Z_y$ . Then the pair  $(U_0, X)$  is  $|\omega|^{\kappa}$ -nice.

*Proof.* It is enough to prove the assertion about distributions  $\pi_{X,U_0,\kappa}(\varphi)$  restricted to  $V_y$ , i.e., when  $\psi$  is supported on  $V_y$ . Set  $W_y = X(F) \setminus Z_y$ . Consider the open covering  $X(F) = U(F) \cup W_y$ . For every  $\varphi \in \mathcal{S}(X(F), |\omega|^{\kappa})$ , we can write

$$
\varphi = \varphi_U + \varphi_{W_y},
$$

where  $\varphi_U \in \mathcal{S}(U(F), |\omega|^{\kappa})$  and  $\varphi_{W_y} \in \mathcal{S}(W_y, |\omega|^{\kappa})$ . Now by our assumptions, the distribution

$$
\pi_{X,U_0,\kappa}(\varphi_U)=\pi_{U,U_0,\kappa}(\varphi_U)
$$

is well defined and of class  $C^{\infty}$ , while  $\pi_{X,U_0,\kappa}(\varphi_{W_y})|_{V_y} \equiv 0$ . This immediately implies the assertion.  $\Box$ 

5.2. A version with smooth coarse moduli. Let  $X$  be a smooth  $G$ -scheme over  $F$ (where  $G = GL_N$ ), L a G-equivariant bundle on X, and  $U_0 \subset X$  an open G-invariant subset such that there exists a smooth coarse moduli space  $U_0/G$  of  $[U_0/G]$ . In other words,  $U_0/G$ is a geometric quotient for the action of  $G$  on  $U_0$ , but we do not require the action of  $G$  on  $U_0$  to be free. Then the natural projection  $U_0 \rightarrow U_0/G$  is smooth and its fibers are exactly G-orbits. Assume also that L descends to a line bundle  $\overline{L}$  on  $U_0/G$ . We have natural integration maps

$$
\pi_{U_0,\kappa}: \mathcal{S}(U_0(F),|L|^\kappa)_{G(F)} \to \mathcal{S}((U_0/G)(F),|\overline{L}|^\kappa),
$$

<span id="page-25-1"></span>and the results of Section [5.1](#page-21-3) about extensions of these maps to maps  $\pi_{X,U_0,\kappa}$  of the form [\(5.2\)](#page-21-4) are still valid.

# 6. APPLICATION TO  $Bun_G$

<span id="page-25-2"></span>6.1. Filtration of the stack of rank 2 bundles. Let C be a curve of genus  $q \geq 2$ . Let Bun<sub>L<sub>0</sub></sub> denote the stack of rank 2 bundles E on C, equipped with an isomorphism  $\det(E) \simeq L_0$ , where  $L_0$  is a fixed line bundle. Morphisms in this stack are isomorphisms compatible with the identifications of the determinant bundles. In particular, for  $L_0 = \mathcal{O}$ , Bun<sub>O</sub> is the stack of  $SL_2$ -bundles on C.

It is well known that each stack  $\text{Bun}_{L_0}$  is admissible (but not of finite type). We denote by  $Bun_{L_0}^{ss} \subset Bun_{L_0}$  the substack of semistable bundles.

**Definition 6.1.** For each *n*, we define an open substack  $\text{Bun}_{L_0}^{\leq n} \subset \text{Bun}_{L_0}$  consisting of bundles E such that any line subbundle  $A \subset E$  has  $deg(A) \leq n$ .

The filtration (Bun<sup> $\leq n$ </sup>) plays an important role in the proof that the stack Bun<sub>SL<sub>2</sub></sub> is truncatable in [\[9,](#page-30-14) Sec. 6]. Note that  $\text{Bun}_{L_0}^{\leq |\text{deg}(L_0)/2|}$  is exactly the substack of semistable bundles  $\text{Bun}_{L_0}^{ss}$ .

**Definition 6.2.** For any n, we define  $(\text{Bun}_{L_0}^{\leq n})^0 \subset \text{Bun}_{L_0}^{\leq n}$  to be the substack consisting of E such that for any degree n line subbundle  $A \subset E$  one has  $H^1(A^2 L_0^{-1}) = 0$ .

<span id="page-26-0"></span>**Lemma 6.3.** (i) For  $E \in \text{Bun}_{L_0}^{\leq n}$ , we have  $E \in (\text{Bun}_{L_0}^{\leq n})^0$  if and only if for any degree n line bundle A with  $H^1(A^2L_0^{-1}) \neq 0$  one has  $Hom(A, E) = 0$ . (ii)  $(\text{Bun}_{L_0}^{\leq n})^0$  is an open substack of  $\text{Bun}_{L_0}^{\leq n}$ . (iii) Every  $E \in (\text{Bun}_{L_0}^{\leq n})^0 \setminus \text{Bun}_{L_0}^{\leq n-1}$  has form  $E = A \oplus A^{-1}L_0$ , where  $\deg(A) = n$  and  $H^1(A^2L_0^{-1})=0.$ (iv)  $(\text{Bun}_{L_0}^{≤n})^0 = \text{Bun}_{L_0}^{≤n-1}$  unless  $n \ge (g-1+\text{deg}(L_0))/2$ . (v)  $(\text{Bun}_{L_0}^{\leq n})^0 = \text{Bun}_{L_0}^{\leq n}$  for  $n > g - 1 + \text{deg}(L_0)/2$ .

*Proof.* (i) We just have to note that if  $A \rightarrow E$  is a nonzero morphism from a line bundle A of degree n then A is necessarily is a subbundle of  $E$  (otherwise, there would be a subbundle in E of degree  $> n$ ).

(ii) The subvariety  $Z \subset Pic^{n}(C)$  of A with  $H^{1}(A^{2}L_{0}^{-1}) \neq 0$  is closed in Pic<sup>n</sup>(C), hence proper. Therefore, the locus of E such that  $Hom(A, E) \neq 0$  for some  $A \in Z$  is closed, and so its complement is open.

(iii) For such E there exists a line subbundle  $A \subset E$  such that  $\text{Ext}^1(A^{-1}L_0, A) \simeq H^1(A^2L_0^{-1}) =$ 0, so the extension  $0 \to A \to E \to E/A \to 0$ , where  $E/A \simeq A^{-1}L_0$ , splits.

(iv) If  $H^1(A^2L_0^{-1}) = 0$  then  $\deg(A^2L_0^{-1}) = 2n - \deg(L_0) \ge g - 1$ . Hence, E cannot have a line subbundle A of degree n with  $H^1(A^2L_0^{-1}) = 0$  unless  $n \ge (g - 1 + \deg(L_0))/2$ .

(v) This follows from the fact that if  $\deg(A^2 L_0^{-1}) = 2n - \deg(L_0) > 2g - 2$  then  $H^1(A^2 L_0^{-1}) =$  $\overline{0}$ .

<span id="page-26-1"></span>**Lemma 6.4.** Assume  $n \ge (g - 1 + \deg(L_0))/2$ , and

$$
\operatorname{Re}(\kappa)\cdot 2(2n-\deg(L_0))-(2n-\deg(L_0)-g+1)\notin \mathbb{Z}_{\leq 0}
$$

(resp.,

$$
\operatorname{Re}(\kappa) \neq \frac{2n - \deg(L_0) - g + 1}{2(2n - \deg(L_0))}
$$

in the non-archimedean case). Then for every point  $x \in ((Bun_{L_0}^{\leq n})^0 \setminus Bun_{L_0}^{\leq n-1})(F)$ , there exists a cocharacter  $\lambda^{\vee}$ :  $\mathbb{G}_m \to \text{Aut}(x)$  such that in the archimedean case, for any character  $a \mapsto a^m$  of  $\mathbb{G}_m$  appearing in  $S^{\bullet}H^0T^*_{\mathrm{Bun}_{L_0}}|_x$ , one has

Re(
$$
\kappa
$$
)  $\cdot \langle \chi_{\mathcal{L},x}, \lambda^{\vee} \rangle + m \neq - \langle \Delta_{\text{Aut}(x)}^{alg}, \lambda^{\vee} \rangle;$ 

while in the non-archimedean case,

Re(
$$
\kappa
$$
)  $\cdot \langle \chi_{\omega,x}, \lambda^{\vee} \rangle \neq - \langle \Delta_{\text{Aut}(x)}^{alg}, \lambda^{\vee} \rangle$ .

*Proof.* By Lemma [6.3\(](#page-26-0)iii), every E in  $(\text{Bun}_{L_0}^{\leq n})^0 \setminus \text{Bun}_{L_0}^{\leq n-1}$  has form  $E = A \oplus A^{-1}L_0$ , with deg(A) = n and  $H^1(A^2L_0^{-1}) = 0$ . Note that this implies that  $\deg(A^2L_0^{-1}) \ge g - 1 > 0$ , hence  $H^0(A^{-2}L_0) = 0.$ 

One has

$$
\underline{\operatorname{End}}_0(E) \simeq \mathcal{O} \oplus A^2 L_0^{-1} \oplus A^{-2} L_0.
$$

Hence, the Lie algebra of automorphisms of E (with trivial determinant) is  $H^0(\mathcal{O})\oplus$  $H^0(A^2L_0^{-1})$ , and the fiber of the canonical line bundle of  $\text{Bun}_{L_0}$  at E is identified with

$$
\omega_{\mathrm{Bun}_{L_0}}|_E \simeq \det(H^1(\mathcal{O})^*) \otimes \det(H^1(A^{-2}L_0)^*) \otimes \det(H^0(A^2L_0)).
$$

Let us consider the subgroup  $\lambda^{\vee}$ :  $\mathbb{G}_m \hookrightarrow \text{Aut}(E)$  acting by  $(a, a^{-1})$  on  $A \oplus A^{-1}L_0$ . Since the induced action of  $\mathbb{G}_m$  on  $A^2 L_0^{-1}$  (resp.,  $A^{-2} L_0$ ) has weight 2 (resp., -2), we have

$$
\langle \chi_{\omega}, \lambda^{\vee} \rangle = 2(\chi(C, A^2 L_0^{-1}) - \chi(C, A^{-2} L_0)) = 4(2n - \deg(L_0)),
$$
  

$$
-\langle \Delta_{\text{Aut}(E)}^{alg}, \lambda^{\vee} \rangle = 2\chi(C, A^2 L_0^{-1}) = 2(2n - \deg(L_0) - g + 1)
$$

(here we use the vanishing of  $h^1(A^2L_0^{-1})$ ).

Also, the  $\mathbb{G}_m$ -weights of  $H^0T^*_{\text{Bun}_{L_0},E} \cong H^1(A^{-2}L_0)^* \oplus H^1(\mathcal{O})^*$  are 0 and 2. Hence, the weights on the symmetric algebra of  $H^0T^*_{\text{Bun}_{L_0},E}$  are non-negative even integers. Now the assertion follows from our assumption on  $\kappa$ .

<span id="page-27-0"></span>6.2. Limits of very stable bundles. Recall that a rank 2 bundle E on C is very stable if any nilpotent Higgs field  $\phi : E \to E \otimes \omega_C$  is zero. It is known that a very stable bundle is stable.

We need some information on bundles which can appear as specializations of very stable bundles. Recall that a bundle  $E_0$  is a specialization of E if there exists a family of bundles on C,  $(E_s)$ , parametrized by an irreducible base S and a point  $s_0 \in S$  such that  $E_s \simeq E$  for  $s \neq s_0$  and  $E_{s_0} \simeq E_0$ .

<span id="page-27-1"></span>**Lemma 6.5.** Let E be a very stable bundle with  $\det(E) \simeq L_0$ . Assume  $E_0 \in \text{Bun}_{L_0}^{\leq n}$ , where  $n \geq \deg(L_0)/2$ , is such that  $\text{Hom}(E, E_0) \neq 0$ . Then  $E_0 \in (\text{Bun}_{L_0}^{\leq n})^0$ . In particular, E does not specialize to any bundle in  $\text{Bun}_{L_0}^{\leq n} \setminus (\text{Bun}_{L_0}^{\leq n})^0$ , where  $n \geq \text{deg}(L_0)/2$ .

*Proof.* Assume that  $Hom(E, E_0) \neq 0$  and  $E_0 \in Bun_{L_0}^{\leq n} \setminus (Bun_{L_0}^{\leq n})^0$ . Then there exists an exact sequence

$$
0 \to A \to E_0 \to A^{-1}L_0 \to 0
$$

with  $\deg(A) = n$ , where  $H^1(A^2 L_0^{-1}) \neq 0$ . Since  $n \geq \deg(L_0)/2$ , we have  $\deg(A^{-1}L_0) \leq$  $\mu(E) = \deg(L_0)/2$ , hence Hom $(E, A^{-1}L_0) = 0$  by the stability of E.

Since  $Hom(E, E_0) \neq 0$ , the exact sequence

$$
0 \to \text{Hom}(E, A) \to \text{Hom}(E, E_0) \to \text{Hom}(E, A^{-1}L_0) = 0
$$

shows that  $Hom(E, A) \neq 0$ . Let  $E \rightarrow A$  be a nonzero map. Such a map factors through a surjection  $E \to A(-D)$ , where D is an effective divisor. Therefore, E fits into an extension

$$
0 \to A^{-1}L_0(D) \to E \to A(-D) \to 0
$$

Next, we observe that

$$
\text{Hom}(A, \omega_C A^{-1} L_0) \simeq H^0(\omega_C A^{-2} L_0) \simeq H^1(A^2 L_0^{-1})^* \neq 0,
$$

Hence, the composition

$$
E \to A(-D) \to A \to \omega_C A^{-1} L_0 \to \omega_C A^{-1} L_0(D) \to KE
$$

gives a nonzero nilpotent Higgs field on E, so E cannot be very stable.

<span id="page-28-2"></span>**Corollary 6.6.** For  $n < (g-1+\deg(L_0))/2$ , a very stable bundle E with determinant  $L_0$ never specializes to a bundle in  $\text{Bun}_{L_0}^{\leq n}$  which is not isomorphic to E.

*Proof.* Assume E specializes to  $E_0 \in \text{Bun}_{L_0}^{\leq n}$ , where  $E_0 \neq E$ . Applying Lemma [6.5](#page-27-1) iteratively, and taking into account Lemma  $6.3(iv)$ , we see that  $E_0$  is semistable. But then the condition  $Hom(E, E_0) \neq 0$  gives a contradiction, since E and  $E_0$  have the same slope and E is stable.

The following result on possible specializations of very stable bundles is not needed for our argument but it clarifies the picture.

**Proposition 6.7.** Let E be a rank 2 very stable bundle, and let  $E_0$  be a specialization of E such that  $E_0 \neq E$ . Then  $E \simeq A \oplus B$ , where A and B are line bundles such that  $Ext<sup>1</sup>(B, A) = 0.$ 

*Proof.* Let  $L_0 := \det(E)$ . By Corollary [6.6,](#page-28-2)  $E_0 \in \text{Bun}_{L_0}^{\leq n} \setminus \text{Bun}_{L_0}^{\leq n-1}$  for some  $n \geq (g-1 +$  $deg(L_0)/2$ . Hence, by Lemma [6.5,](#page-27-1)  $E \in (\text{Bun}_{L_0}^{\leq n})^0 \setminus \text{Bun}_{L_0}^{\leq n-1}$ , and the assertion follows from Lemma [6.3\(](#page-26-0)iii).

<span id="page-28-1"></span>6.3. Main theorems. Consider the open substack  $\mathcal{M}_{L_0}^{vs} \subset \text{Bun}_{L_0}$  of very stable bundles, and let  $M^{vs}_{L_0}$  be its coarse moduli space. The variety  $M^{vs}_{L_0}$  is smooth and the line bundle  $\omega$ on  $\mathcal{M}_{L_0}^{vs}$  descends to  $\omega$  on  $M_{L_0}^{vs}$ .

<span id="page-28-0"></span>**Theorem 6.8.** Assume that  $q \geq 2$ . For every open substack of the form  $[X/\operatorname{GL}_N]$  in Bun<sub>L<sub>0</sub></sub>, let  $X^{vs} \subset X$  denote the open subset corresponding to very stable bundles. Then for  $\text{Re}(\kappa) \geq 1/2$ , the pair  $(X^{vs}, X)$  is  $|\omega|^{\kappa}$ -nice, so there is a well defined map

$$
\pi_{\kappa} : \mathcal{S}(\mathrm{Bun}_{L_0}, |\omega|^{\kappa}) \to C^{\infty}(M_{L_0}^{vs}, |\omega|^{\kappa}),
$$

where  $\pi_{\kappa}(\varphi)$ , viewed as a distribution, is given by absolutely convergent integrals [\(5.3\)](#page-22-1).

*Proof.* First, let  $X^s \subset X$  be the G-invariant open subset corresponding to stable bundles (where  $G = GL_N$ ). Then we have a smooth geometric quotient  $X<sup>s</sup>/G$  of the action of G on  $X^s$ , which implies that the pair  $(X^{vs}, X^s)$  is  $|\omega|^{\kappa}$ -nice for any  $\kappa \in \mathbb{C}$ .

Next, let us show that for  $n < (g-1 + \deg(L_0))/2$ , the pair  $(X^{vs}, X^{\leq n})$  is  $|\omega|^{\kappa}$ -nice for any  $\kappa \in \mathbb{C}$ , where  $X^{\leq n} \subset X$  is the G-invariant open subset corresponding to Bun<sup> $\leq n$ </sup>. Indeed, since  $(\text{Bun}_{L_0}^{\leq n})^0 = \text{Bun}_{L_0}^{\leq n-1}$  for  $n < (g-1 + \text{deg}(L_0))/2$  (see Lemma [6.3\(](#page-26-0)iv)), by Lemma [6.5,](#page-27-1) for such *n* the G-orbits of points in  $X^{vs}$  are contained in  $X^{s}$ . Hence, the assertion follows from Lemma [5.4](#page-25-0) applied to the embedding  $X^s \to X^{\leq n}$ . In more detail, given a compact set K of G-orbits in  $X^{vs}/G$ , we have a closed subset  $Z_K \subset X(F)$  consisting of points corresponding to bundles  $E_0$  such that  $\text{Hom}(E, E_0) \neq 0$  for some  $E \in K$ . By Lemma [6.5,](#page-27-1) we have  $Z_K \subset X^s(F)$ . On the other hand, by semicontinuity of dim Hom $(E, E_0)$ , the closures of G-orbits in K are contained in  $Z_K$ . Hence, we can apply Lemma [6.5](#page-27-1) to deduce that the pair  $(X^{vs}, X^{\leq n})$  is  $|\omega|^{\kappa}$ -nice.

Next, we will use induction on n to prove that for every n, the pair  $(X^{vs}, X^{\leq n})$  is  $|\omega|^{\kappa}$ -nice for Re( $\kappa$ ) ≥ 1/2. For some  $n \ge (g-1+\deg(L_0))/2$ , let

$$
X^{\leq n-1} \subset (X^{\leq n})^0 \subset X
$$

denote the open subsets corresponding to the substacks  $\text{Bun}_{L_0}^{\leq n-1} \subset (\text{Bun}_{L_0}^{\leq n})^0$ . By the induction assumption (or the case  $n < (g - 1 + \deg(L_0))/2$ ), we can assume that the claim holds for  $X^{\leq n-1}$ , i.e, the pair  $(X^{vs}, X^{\leq n-1})$  is  $|\omega|^{\kappa}$ -nice.

Note that we have

Re(
$$
\kappa
$$
)  $\geq \frac{1}{2} > \frac{2n - \deg(L_0) - g + 1}{2(2n - \deg(L_0))}$ .

Hence, by Lemma [6.4,](#page-26-1) we can apply by Lemma [5.2](#page-22-0) to the inclusion  $[X^{\leq n-1}/G] \subset [(X^{\leq n})^0/G]$ and to the interval

$$
(a,b) = \left(\frac{2n - \deg(L_0) - g + 1}{2(2n - \deg(L_0))}, b\right)
$$

with b sufficiently large, and deduce that the pair  $(X^{vs}, (X^{\leq n})^0)$  is  $|\omega|^{\kappa}$ -nice.

Finally, we would like to apply Lemma [5.4](#page-25-0) to the embedding  $(X^{\leq n})^0 \subset X^{\leq n}$ . We need to check that the assumptions of this lemma are satisfied. Given a compact set  $K$  of  $G$ -orbits in  $X^{vs}/G$ , we have a closed subset  $Z_K \subset X(F)$  consisting of points corresponding to bundles E<sub>0</sub> such that Hom $(E, E_0) \neq 0$  for some  $E \in K$ . By Lemma [6.5,](#page-27-1) we have  $Z_K \subset (X^{\leq n})^0(F)$ . On the other hand, by semicontinuity of dim  $Hom(E, E_0)$ , the closures of G-orbits in K are contained in  $Z_K$ . Hence, by Lemma [5.4,](#page-25-0) the pair  $(X^{vs}, X^{\leq n})$  is  $|\omega|^{\kappa}$ -nice.

Since  $X^{\leq n} = X$  for sufficiently large n, the assertion follows.

In the non-archimedean case we can also prove the following boundedness result, which implies that the stack  $\mathcal{S}(\text{Bun}_{L_0})$  is  $\kappa$ -bounded for each  $\kappa \in \mathbb{C}$  in the terminology of [\[4,](#page-30-0) Def. 2.10].

<span id="page-29-0"></span>**Theorem 6.9.** Assume F is non-archimedean and  $q \geq 2$ . (i) For  $n > g - 2 + \deg(L_0)/2$  and  $\text{Re}(\kappa) \geq 1/2$ , the natural map

 $\mathcal{S}(\text{Bun}_{L_0}^{\leq n},|\omega|^{\kappa}) \to \mathcal{S}(\text{Bun}_{L_0},|\omega|^{\kappa})$ 

is an isomorphism. (*ii*) For any  $\kappa \in \mathbb{C}$ , the map

 $\mathcal{S}(\text{Bun}_{L_0}^{\leq n}, |\omega|^{\kappa}) \to \mathcal{S}(\text{Bun}_{L_0}, |\omega|^{\kappa})$ 

is an isomorphism for large enough n.

*Proof.* (i) It suffices to prove that under these assumptions the map

$$
\mathcal{S}(\text{Bun}_{L_0}^{\leq n}, |\omega|^{\kappa}) \to \mathcal{S}(\text{Bun}_{L_0}^{\leq n+1}, |\omega|^{\kappa}) \tag{6.1}
$$

is an isomorphism. We are going to apply Lemma [3.23\(](#page-14-0)i) to the inclusion  $\text{Bun}_{L_0}^{\leq n} \to \text{Bun}_{L_0}^{\leq n+1}$ .

First of all, we observe that by Lemma [6.3\(](#page-26-0)v), we have  $Bun_{L_0}^{\leq n+1} = (\text{Bun}_{L_0}^{\leq n+1})^0$ , so by Lemma [6.3\(](#page-26-0)iii), every  $E \in \text{Bun}_{L_0}^{\leq n+1} \setminus \text{Bun}_{L_0}^{\leq n}$  has form  $E = A \oplus A^{-1}L_0$ , where  $H^1(A^2L_0^{-1}) = 0$ . In this case  $deg(A^2L_0^{-1}) > 0$ , so  $H^0(A^{-2}L_0) = 0$ . It follows that the group  $Aut(E)$  is the semidirect product of  $\mathbb{G}_m$  acting by  $(a, a^{-1})$  on  $A \oplus A^{-1}L_0$  with the additive group  $\text{Hom}(A^{-1}L_0, A) = H^0(A^2L_0^{-1})$ . Together with Lemma [6.4](#page-26-1) this implies that the assumptions of Lemma [3.23\(](#page-14-0)i) are satisfied and we deduce that the map [\(6.1\)](#page-29-1) is an isomorphism. (ii) Pick N such that  $N > g - 2 + \deg(L_0)/2$  and  $\text{Re}(\kappa) \neq \frac{2n - \deg(L_0) - g + 1}{2(2n - \deg(L_0))}$  for  $n > N$ . Then the same argument as in (i) shows that [\(6.1\)](#page-29-1) is an isomorphism for  $n \geq N$ .

Note that Theorems [6.8](#page-28-0) and [6.9](#page-29-0) imply [\[4,](#page-30-0) Conj. 3.5(1)] for  $G = SL_2$ .
